# REPRESENTING KERNELS OF PERTURBATIONS OF TOEPLITZ OPERATORS BY BACKWARD SHIFT-INVARIANT SUBSPACES 

YUXIA LIANG AND JONATHAN R. PARTINGTON


#### Abstract

It is well known the kernel of a Toeplitz operator is nearly invariant under the backward shift $S^{*}$. This paper shows that kernels of finite rank perturbations of Toeplitz operators are nearly $S^{*}$-invariant with finite defect. This enables us to apply a recent theorem by Chalendar-Gallardo-Partington to represent the kernel in terms of backward shift-invariant subspaces, which we identify in several important cases.


## 1. Introduction

Let $H(\mathbb{D})$ be the space of all analytic functions on the open unit disc $\mathbb{D}$. The Hardy space $H^{2}:=H^{2}(\mathbb{D})$ is defined by

$$
H^{2}=\left\{f \in H(\mathbb{D}): f(z)=\sum_{n=0}^{\infty} a_{n} z^{n} \text { with }\|f\|^{2}:=\sum_{n=0}^{\infty}\left|a_{n}\right|^{2}<+\infty\right\}
$$

The limit $\lim _{r \rightarrow 1^{-}} f\left(r e^{i t}\right)$ exists almost everywhere, which gives the values of $f$ on the unit circle $\mathbb{T}$. Since the $H^{2}$ norm of $f$ and the $L^{2}(\mathbb{T})$ norm of its boundary function coincide, $H^{2}$ embeds isometrically as a closed subspace of $L^{2}(\mathbb{T})$ via

$$
\sum_{n=0}^{\infty} a_{n} z^{n} \mapsto \sum_{n=0}^{\infty} a_{n} e^{i n t}
$$

This indicates a natural orthogonal decomposition $L^{2}(\mathbb{T})=H^{2} \oplus \overline{H_{0}^{2}}$, where $H^{2}$ is identified with the subspace spanned by $\left\{e^{i n t}: n \geq 0\right\}$ and $\overline{H_{0}^{2}}$ is the subspace spanned by $\left\{e^{i n t}: n<0\right\}$, respectively.

Let $L^{\infty}:=L^{\infty}(\mathbb{T})$ be the space containing all essentially bounded functions on $\mathbb{T}$. And $H^{\infty}:=H^{\infty}(\mathbb{D})$ is the Banach algebra of bounded

[^0]analytic functions on $\mathbb{D}$ with the norm defined
$$
\|f\|_{\infty}=\sup _{z \in \mathbb{D}}|f(z)|
$$

Similarly, the radial boundary function of an $H^{\infty}$ function belongs to $L^{\infty}$, and then $H^{\infty}$ can be viewed as a Banach subalgebra of $L^{\infty}$.

We recall an inner function is an $H^{\infty}$ function that has unit modulus almost everywhere on $\mathbb{T}$. An outer function is a function $f \in H^{1}$ which can be written in the form

$$
f\left(r e^{i \eta}\right)=\alpha \exp \left(\frac{1}{2 \pi} \int_{0}^{2 \pi} \frac{e^{i t}+r e^{i \eta}}{e^{i t}-r e^{i \eta}} k\left(e^{i t}\right) d t\right)
$$

for $r e^{i \eta} \in \mathbb{D}$, where $k$ is a real-valued integrable function and $|\alpha|=1$. It is known that each $f \in H^{1} \backslash\{0\}$ has a factorization $f=\theta \cdot u$, where $\theta$ is inner and $u$ is outer. This factorization is unique up to a constant of modulus 1 (cf. [9]).

Let $P: L^{2}(\mathbb{T}) \rightarrow H^{2}$ be the orthogonal projection on $H^{2}$ defined by a Cauchy integral

$$
(P f)(z)=\int \frac{f(\zeta)}{1-\bar{\zeta} z} d m(\zeta),|z|<1 .
$$

Given $g \in L^{\infty}$, the Toeplitz operator $T_{g}: H^{2} \rightarrow H^{2}$ is defined by

$$
T_{g} f=P(g f)
$$

for any $f \in H^{2}$. If $\theta$ is an inner function, then $\operatorname{Ker} T_{\bar{\theta}}$ is the model space $K_{\theta}=H^{2} \ominus \theta H^{2}=H^{2} \cap \theta \overline{H_{0}^{2}}$ (cf. [10, 11]). It has also been proved that $\left\|T_{g}\right\|=\|g\|_{\infty}$ and $T_{g}^{*}=T_{\bar{g}}$ (cf. [3]). For more investigations into Toeplitz operators, the reader can refer to [7, 4, 14] and so on.

Beurling's theorem states that the subspaces $\theta H^{2}$ with inner function $\theta$ constitute the nontrivial invariant subspaces for the unilateral shift $S: H^{2} \rightarrow H^{2}$ defined by $[S f](z)=z f(z)$. Also the model space $K_{\theta}$ is invariant under the backward shift $S^{*}: H^{2} \rightarrow H^{2}$ (cf. [10, Proposition 5.2]) defined by

$$
S^{*} f(z)=\frac{f(z)-f(0)}{z}\left(f \in H^{2}, z \in \mathbb{D}\right) .
$$

The invariant subspace problem is still an unresolved problem in operator theory and there are various related investigations (cf. [6, 5]). Moreover, the study of nearly $S^{*}$-invariant subspaces has attracted a lot of attention (cf. [12, 13, 5]).

Definition 1.1. A subspace $M \subset H^{2}$ is called nearly $S^{*}$-invariant if $S^{*} f \in M$ whenever $f \in M$ and $f(0)=0$. Furthermore, a subspace $M \subset H^{2}$ is said to be nearly $S^{*}$-invariant with defect $m$ if there is an
$m$-dimensional subspace $F$ such that $S^{*} f \in M+F$ whenever $f \in M$ with $f(0)=0$; we call $F$ the defect space.

If $f \in \operatorname{Ker} T_{g}$ with $f(0)=0$, so $g f \in \overline{H_{0}^{2}}$ and then $g(\bar{z} f) \in \overline{H_{0}^{2}}$. Since $\bar{z} f \in H^{2}$, this implies $S^{*} f=\bar{z} f \in \operatorname{Ker} T_{g}$, which shows the kernel of a Toeplitz operator is nearly $S^{*}$-invariant. Motivated by this well-known result, we continue to examine a question which has a close link with the invariant subspace problem:

Given a Toeplitz operator $T_{g}$ acting on Hardy space $H^{2}$, is the kernel of a rank $n$ perturbation of $T_{g}$ nearly $S^{*}$-invariant with finite defect?

We recall that an operator $T: \mathcal{H} \rightarrow \mathcal{H}$ of rank $n$ on a Hilbert space $\mathcal{H}$ takes the form

$$
T h=\sum_{i=1}^{n}\left\langle h, u_{i}\right\rangle v_{i} \text { for all } h \in \mathcal{H}
$$

where $\left\{u_{i}\right\}$ and $\left\{v_{i}\right\}$ are orthogonal sets in $\mathcal{H}$ (we may also suppose that $\left\{u_{i}\right\}$ is orthonormal). For simplicity, write $A_{n}:=\{1,2, \cdots, n\}$ and let $|\Lambda|$ stand for the number of integers in a set $\Lambda$.

A rank $n$ perturbation of the Toeplitz operator $T_{g}: H^{2} \rightarrow H^{2}$ denoted by $R_{n}: H^{2} \rightarrow H^{2}$ is defined by

$$
\begin{equation*}
R_{n}(h)=T_{g} h+T h=T_{g} h+\sum_{i=1}^{n}\left\langle h, u_{i}\right\rangle v_{i} \tag{1.1}
\end{equation*}
$$

with orthonormal set $\left\{u_{i}\right\}$ and orthogonal set $\left\{v_{i}\right\}$ in $H^{2}$.
The rest of the paper is organized as follows. In Section 2, we discuss the nearly $S^{*}$-invariant subspace Ker $R_{n}$ with finite defect for several important classes of symbols and present the corresponding defect space in each case. Then we apply a recent theorem by Chalendar-Gallardo-Partington to represent the kernel of the operator $R_{1}$ in terms of backward shift-invariant subspaces in Section 3. The challenging task here is to identify the subspaces in question, which we do in various important cases. Note that even in the nearly $S^{*}$-invariant (defect 0 ) case, this is known to be a difficult question in general.

## 2. nearly $S^{*}$-Invariant $\operatorname{Ker} R_{n}$ with finite defect

In this section, we prove that the kernel of the operator $R_{n}$ in (1.1) is nearly $S^{*}$-invariant with finite defect for various important cases, especially identify the finite-dimensional defect spaces. First of all, we recall a useful theorem for later use.

Theorem 2.1. [10, Theorem 4.22] For $\psi, \varphi \in L^{\infty}$, the operator $T_{\psi} T_{\varphi}$ is a Toeplitz operator if and only if either $\bar{\psi} \in H^{\infty}$ or $\varphi \in H^{\infty}$. In both cases, $T_{\psi} T_{\varphi}=T_{\psi \varphi}$.

So for all $g \in L^{\infty}$, it holds that

$$
\begin{equation*}
T_{\bar{z}} T_{g}=T_{\bar{z} g}=T_{g \bar{z}} \tag{2.1}
\end{equation*}
$$

For every $h \in \operatorname{Ker} R_{n}$, it follows that

$$
\begin{equation*}
T_{g} h+\sum_{i=1}^{n}\left\langle h, u_{i}\right\rangle v_{i}=0 . \tag{2.2}
\end{equation*}
$$

Letting $S^{*}=T_{\bar{z}}$ act on both sides of (2.2) and using (2.1), we have

$$
T_{g \bar{z}} h+\sum_{i=1}^{n}\left\langle h, u_{i}\right\rangle S^{*} v_{i}=0 .
$$

Now let $h \in \operatorname{Ker} R_{n}$ satisfy $h(0)=0$, and then the above equation implies the following equivalent expressions.

$$
\begin{align*}
& T_{g}\left(\frac{h}{z}\right)+\sum_{i=1}^{n}\left\langle h, u_{i}\right\rangle S^{*} v_{i}=0  \tag{2.3}\\
\Leftrightarrow & g \frac{h}{z}+\sum_{i=1}^{n}\left\langle h, u_{i}\right\rangle S^{*} v_{i} \in \overline{H_{0}^{2}} . \tag{2.4}
\end{align*}
$$

So the question of nearly $S^{*}$-invariant $\operatorname{Ker} R_{n}$ with finite defect is that: for each $h \in \operatorname{Ker} R_{n}$ with $h(0)=0$, find a vector $w$ in some suitable finite-dimensional space $F$ such that

$$
S^{*} h+w=\frac{h}{z}+w \in \operatorname{Ker} R_{n},
$$

which is equivalent to the following equations.

$$
\begin{align*}
& T_{g}\left(\frac{h}{z}+w\right)+\sum_{i=1}^{n}\left\langle\frac{h}{z}+w, u_{i}\right\rangle v_{i}=0  \tag{2.5}\\
\Leftrightarrow & g\left(\frac{h}{z}+w\right)+\sum_{i=1}^{n}\left\langle\frac{h}{z}+w, u_{i}\right\rangle v_{i} \in \overline{H_{0}^{2}} . \tag{2.6}
\end{align*}
$$

Next we will construct the defect space $F$ in several important cases.
2.1. $g=0$ a.e. on $\mathbb{T}$. In this case, $R_{n}$ is a rank- $n$ operator and equation (2.5) with $g=0$ implies

$$
\operatorname{Ker} R_{n}=\bigcap_{i=1}^{n}\left(\bigvee\left\{u_{i}\right\}\right)^{\perp}=H^{2} \ominus\left(\bigvee\left\{u_{i}, i \in A_{n}\right\}\right)
$$

where $\bigvee$ denotes the closed linear span in $H^{2}$.
For any $h \in \operatorname{Ker} R_{n}$ with $h(0)=0$, it always holds that

$$
S^{*} h \in \operatorname{Ker} R_{n} \oplus\left(\bigvee\left\{u_{i}, i \in A_{n}\right\}\right)=H^{2}
$$

which gives the following elementary observation on the nearly $S^{*}$ invariant subspace $\operatorname{Ker} R_{n}$ with finite defect.

Proposition 2.2. Suppose $g=0$ almost everywhere on $\mathbb{T}$. Then the subspace Ker $R_{n}$ is nearly $S^{*}$-invariant with defect $n$ and defect space

$$
F=\bigvee\left\{u_{i}, i \in A_{n}\right\}
$$

2.2. $g=\theta$ an inner function. In this case $T_{\theta} f=\theta f$ is an isometric multiplication operator on $H^{2}$. For each $h \in \operatorname{Ker} R_{n}$ with $h(0)=0$, the relation (2.4) becomes

$$
\begin{equation*}
\theta \frac{h}{z}+\sum_{i=1}^{n}\left\langle h, u_{i}\right\rangle S^{*} v_{i}=0 \tag{2.7}
\end{equation*}
$$

The required relation (2.6) turns into

$$
\theta\left(\frac{h}{z}+w\right)+\sum_{i=1}^{n}\left\langle\frac{h}{z}+w, u_{i}\right\rangle v_{i}=0
$$

Combining it with (2.7), the above equation is equivalent to

$$
\begin{equation*}
\left(\theta w-\sum_{k=1}^{n}\left\langle h, u_{k}\right\rangle S^{*} v_{k}\right)+\sum_{i=1}^{n}\left\langle\left(\theta w-\sum_{k=1}^{n}\left\langle h, u_{k}\right\rangle S^{*} v_{k}\right), \theta u_{i}\right\rangle v_{i}=0 \tag{2.8}
\end{equation*}
$$

Now choosing

$$
w=\bar{\theta}\left(\sum_{k=1}^{n}\left\langle h, u_{k}\right\rangle S^{*} v_{k}\right)=\sum_{k=1}^{n}\left\langle h, u_{k}\right\rangle T_{\bar{\theta}}\left(S^{*} v_{k}\right) \in H^{2}
$$

the required equation (2.8) holds. So we can obtain a theorem on the nearly $S^{*}$-invariant Ker $R_{n}$ with finite defect.

Theorem 2.3. Suppose $g=\theta$ an inner function. Then the subspace Ker $R_{n}$ is nearly $S^{*}$-invariant with defect at most $n$ and defect space

$$
F=\bigvee\left\{T_{\bar{\theta}}\left(S^{*} v_{i}\right), i \in A_{n}\right\}
$$

Example 2.4. For $g(z)=z^{m}(m \in \mathbb{N})$, $\operatorname{Ker} R_{n}$ is nearly $S^{*}$-invariant with defect at most $n$ and defect space $F=\bigvee\left\{\left(S^{*}\right)^{m+1}\left(v_{i}\right), i \in A_{n}\right\}$.
2.3. $g=f_{1} \overline{f_{2}}$ with $f_{j} \in \mathcal{G} H^{\infty}$ for $j=1,2$. Here $\mathcal{G} H^{\infty}$ denotes the set of all invertible elements in $H^{\infty}$. In [2], Bourgain proved: If $g$ is a bounded measurable function on $\mathbb{T}$, then the condition $\int_{\pi} \log |g| d m>$ $-\infty(m$ is the normalized invariant measure on $\mathbb{T})$ is the necessary and sufficient condition for $g \neq 0$ to be of the form $g=f_{1} \cdot \overline{f_{2}}$ where $f_{1}, f_{2} \in H^{\infty}$. The interested reader can also refer to [1, Theorem 4.1] for a matricial version with norm estimates. In this subsection, we suppose $f_{j} \in \mathcal{G} H^{\infty}$ for $j=1,2$, and then Theorem 2.1 ensures that $T_{f_{1} \overline{f_{2}}}=T_{\overline{f_{2}}} T_{f_{1}}$.

For each $h \in \operatorname{Ker} R_{n}$ with $h(0)=0$, (2.3) can be rewritten as

$$
\begin{equation*}
T_{\overline{f_{2}}} T_{f_{1}}\left(\frac{h}{z}\right)+\sum_{i=1}^{n}\left\langle h, u_{i}\right\rangle S^{*} v_{i}=0 \tag{2.9}
\end{equation*}
$$

which together with Theorem 2.1 imply

$$
\begin{equation*}
\frac{h}{z}+\sum_{i=1}^{n}\left\langle h, u_{i}\right\rangle T_{f_{1}^{-1}} T_{\overline{f_{2}}-1}\left(S^{*} v_{i}\right)=0 \tag{2.10}
\end{equation*}
$$

The required equation (2.5) is changed into

$$
T_{\overline{f_{2}}} T_{f_{1}}\left(\frac{h}{z}+w\right)+\sum_{i=1}^{n}\left\langle\frac{h}{z}+w, u_{i}\right\rangle v_{i}=0
$$

which, by (2.9), is equivalent to

$$
T_{\overline{f_{2}}} T_{f_{1}} w-\sum_{k=1}^{n}\left\langle h, u_{k}\right\rangle S^{*} v_{k}+\sum_{i=1}^{n}\left\langle\frac{h}{z}+w, u_{i}\right\rangle v_{i}=0 .
$$

Now choosing

$$
w=\sum_{k=1}^{n}\left\langle h, u_{k}\right\rangle T_{f_{1}^{-1}} T_{\overline{f_{2}}}\left(S^{*} v_{k}\right)
$$

and using (2.10), the result follows. Hence we can present a theorem on the nearly $S^{*}$-invariant $\operatorname{Ker} R_{n}$ with finite defect.

Theorem 2.5. Suppose $g=f_{1} \overline{f_{2}}$ with $f_{j} \in \mathcal{G} H^{\infty}$ for $j=1,2$. Then the subspace Ker $R_{n}$ is nearly $S^{*}$-invariant with defect at most $n$ and defect space

$$
F=\bigvee\left\{T_{f_{1}^{-1}} T_{\overline{f_{2}}}-1\left(S^{*} v_{i}\right), i \in A_{n}\right\}
$$

The following is a remark on two special cases of Theorem 2.5.

Remark 2.6. (i) For the operator $R_{n}$ in (1.1) with $\bar{g} \in \mathcal{G} H^{\infty}$, $\operatorname{Ker} R_{n}$ is nearly $S^{*}$-invariant with defect at most $n$ and defect space

$$
F=\bigvee\left\{T_{g^{-1}}\left(S^{*} v_{i}\right), i \in A_{n}\right\}
$$

(ii) For the operator $R_{n}$ in (1.1) with $g \in \mathcal{G} H^{\infty}$, $\operatorname{Ker} R_{n}$ is nearly $S^{*}$ invariant with defect at most $n$ and defect space

$$
F=\bigvee\left\{T_{g^{-1}}\left(S^{*} v_{i}\right), i \in A_{n}\right\}
$$

2.4. $g(z)=\overline{\theta(z)}$ with $\theta$ a nonconstant inner function. In this case, $T_{\bar{\theta}}$ is a special conjugate analytic Toeplitz operator with kernel $K_{\theta}$. And then the relation (2.4) becomes

$$
\psi:=\bar{\theta} \frac{h}{z}+\sum_{k=1}^{n}\left\langle h, u_{k}\right\rangle S^{*} v_{k} \in \overline{H_{0}^{2}}
$$

with

$$
\begin{equation*}
\theta \psi=\frac{h}{z}+\sum_{k=1}^{n}\left\langle h, u_{k}\right\rangle \theta S^{*} v_{k} \in H^{2} . \tag{2.11}
\end{equation*}
$$

The desired relation (2.6) now takes the form

$$
\begin{equation*}
\bar{\theta}\left(\frac{h}{z}+w\right)+\sum_{i=1}^{n}\left\langle\frac{h}{z}+w, u_{i}\right\rangle v_{i} \in \overline{H_{0}^{2}} \tag{2.12}
\end{equation*}
$$

which, by (2.11), is equivalent to

$$
\begin{align*}
\psi & -\sum_{k=1}^{n}\left\langle h, u_{k}\right\rangle S^{*} v_{k}+\bar{\theta} w \\
& +\sum_{i=1}^{n}\left\langle\psi-\sum_{k=1}^{n}\left\langle h, u_{k}\right\rangle S^{*} v_{k}+\bar{\theta} w, \bar{\theta} u_{i}\right\rangle v_{i} \in \overline{H_{0}^{2}} \tag{2.13}
\end{align*}
$$

We denote the decompositions of $u_{i}$ and $\psi$ as below: $u_{i}=u_{i 1}+\theta u_{i 2}$ with $u_{i 1}=P_{K_{\theta}} u_{i} \in K_{\theta}, u_{i 2} \in H^{2}$, and $\psi=\psi_{1}+\psi_{2}$ with $\psi_{1} \in B:=$ $\bigvee\left\{\bar{\theta} u_{i 1}, i \in A_{n}\right\} \subset \overline{H_{0}^{2}}$ and $\psi_{2} \in \overline{H_{0}^{2}} \ominus B$. So it is clear that

$$
\left\langle\psi_{2}, \bar{\theta} u_{i}\right\rangle=0 \text { and }\left\langle\psi_{2}, u_{i 2}\right\rangle=0 \text { for all } i \in A_{n} .
$$

The above indicates that (2.13) is equivalent to

$$
\begin{aligned}
& \left(\psi_{1}-\sum_{k=1}^{n}\left\langle h, u_{k}\right\rangle S^{*} v_{k}+\bar{\theta} w\right) \\
& \quad+\sum_{i=1}^{n}\left\langle\left(\psi_{1}-\sum_{k=1}^{n}\left\langle h, u_{k}\right\rangle S^{*} v_{k}+\bar{\theta} w\right), \bar{\theta} u_{i 1}+u_{i 2}\right\rangle v_{i} \in \overline{H_{0}^{2}}
\end{aligned}
$$

Choosing

$$
w=\sum_{k=1}^{n}\left\langle h, u_{k}\right\rangle \theta S^{*} v_{k}-\theta \psi_{1},
$$

the above desired relation is true and the defect space $F$ is

$$
F=\bigvee\left\{\theta S^{*} v_{i}, P_{K_{\theta}} u_{i}, i \in A_{n}\right\}=\bigvee\left\{\theta S^{*} v_{i}, P_{K_{\theta}} u_{k}, i \in A_{n}, k \in \Lambda\right\}
$$

where $\Lambda$ denotes the subset of $A_{n}$ consisting of all $k \in A_{n}$ such that $P_{K_{\theta}} u_{k} \neq 0$, i.e. $\theta \nmid u_{k}$. So in conclusion we have the following theorem.

Theorem 2.7. Suppose $g(z)=\overline{\theta(z)}$ with $\theta$ an inner function. Then the subspace Ker $R_{n}$ is nearly $S^{*}$-invariant with defect at most $n+|\Lambda|$ and defect space

$$
F=\bigvee\left\{\theta S^{*} v_{i}, P_{K_{\theta}} u_{k}, i \in A_{n}, k \in \Lambda\right\},
$$

with $\Lambda \subset A_{n}$ consisting of all $k \in A_{n}$ such that $\theta \nmid u_{k}$.

## 3. The application of the C-G-P theorem

In this section, we apply a recent theorem (for short the C-G-P Theorem) by Chalendar-Gallardo-Partington to represent the kernels of rank one perturbations of Toeplitz operators in terms of backward shift-invariant subspaces. We shall take $n=1$ and denote the operator

$$
R_{1} f=T_{g} f+\langle f, u\rangle v
$$

with $\|u\|=1$ and $S^{*} v \neq 0$. First we cite the C-G-P Theorem on nearly $S^{*}$-invariant subspaces with defect $m$ from [8].

Theorem 3.1. [8, Theorem 3.2] Let $M$ be a closed subspace that is nearly $S^{*}$-invariant with defect $m$. Then
(1) in the case where there are functions in $M$ that do not vanish at 0 , then

$$
M=\left\{f: f(z)=k_{0}(z) f_{0}(z)+z \sum_{j=1}^{m} k_{j}(z) e_{j}(z):\left(k_{0}, \cdots, k_{m}\right) \in K\right\}
$$

where $f_{0}$ is the normalized reproducing kernel for $M$ at $0,\left\{e_{1}, \cdots, e_{m}\right\}$ is any orthonormal basis for the defect space $F$, and $K$ is a closed $S^{*} \oplus$ $\cdots \oplus S^{*}$-invariant subspace of the vector-valued Hardy space $H^{2}\left(\mathbb{D}, \mathbb{C}^{m+1}\right)$, and $\|f\|^{2}=\sum_{j=0}^{m}\left\|k_{j}\right\|^{2}$.
(2) in the case where all functions in $M$ vanish at 0 , then

$$
M=\left\{f: f(z)=z \sum_{j=1}^{m} k_{j}(z) e_{j}(z):\left(k_{1}, \cdots, k_{m}\right) \in K\right\}
$$

with the same notation as in (1), except that $K$ is now a closed $S^{*} \oplus$ $\cdots \oplus S^{*}$-invariant subspace of the vector-valued Hardy space $H^{2}\left(\mathbb{D}, \mathbb{C}^{m}\right)$, and $\|f\|^{2}=\sum_{j=1}^{m}\left\|k_{j}\right\|^{2}$.

The following proposition asserts that the kernels of some Toeplitz operators with special symbols are model spaces.

Proposition 3.2. [10, Proposition 5.8] Let $\varphi \in H^{\infty} \backslash\{0\}$ and let $\eta$ be the inner factor of $\varphi$, then

$$
\operatorname{Ker} T_{\bar{\varphi}}=K_{\eta}
$$

Now we apply the C-G-P Theorem to represent $\operatorname{Ker} R_{1}$ by backward shift-invariant subspaces in several important cases. Note that we can find $K$ as the largest $S^{*}$-invariant subspace such that

$$
S^{* n} k_{0} f_{0}+z \sum_{j=1}^{m} S^{* n} k_{j} e_{j} \in M \quad \text { or } \quad z \sum_{j=1}^{m} S^{* n} k_{j} e_{j} \in M
$$

for all $n \in \mathbb{N}$.
3.1. $g=0$ a.e. on $\mathbb{T}$. In this case $M=\operatorname{Ker} R_{1}=H^{2} \ominus \bigvee\{u\}$, which is a vector hyperplane. It is clear that such a hyperplane is the solution of a single linear equation. Also Proposition 2.2 showed that $\operatorname{Ker} R_{1}$ is nearly $S^{*}$-invariant with a 1-dimensional defect space $F=\bigvee\{u\}$. Using Theorem 3.1, we deduce a corollary on the representations of Ker $R_{1}$.

Corollary 3.3. Given a nearly $S^{*}$-invariant subspace $M=H^{2} \ominus \bigvee\{u\}$ with defect 1, let $f_{0}=P_{M} 1=1-\overline{u(0)} u$, $v_{0}=P\left(u-u(0)|u|^{2}\right)$ and $v_{1}=P\left(\bar{z}|u|^{2}\right)$. Then
(1) in the case $P_{M} 1 \neq 0$, we have

$$
M=\left\{f: f=k_{0} f_{0}+k_{1} z u:\left(k_{0}, k_{1}\right) \in K\right\}
$$

with an $S^{*} \oplus S^{*}$-invariant subspace $K=\left\{\left(k_{0}, k_{1}\right):\left\langle k_{0}, z^{n} v_{0}\right\rangle+\left\langle k_{1}, z^{n} v_{1}\right\rangle=\right.$ 0 for $n \in \mathbb{N}\}$.
(2) in the case $P_{M} 1=0$, we have

$$
M=\left\{f: f=k_{1} z u: k_{1} \in K\right\}
$$

with an $S^{*}$-invariant subspace $K=\left\{k_{1}:\left\langle k_{1}, z^{n} v_{1}\right\rangle=0\right.$ for $\left.n \in \mathbb{N}\right\}$.
Here we show some examples illustrating the variety of subspaces $K$ that can occur.
Example 3.4. (i) Suppose $u=1$, then $M=z H^{2}, f_{0}=0$ and $v_{0}=$ $v_{1}=0$. So Corollary 3.3 (2) implies $M$ has the representation

$$
M=\left\{f: f=z k_{1}: k_{1} \in K\right\}
$$

with $K=H^{2}$ a trivial $S^{*}$-invariant subspace.
(ii) Suppose $u$ is a nonconstant inner function, then $M=K_{u} \oplus z u H^{2}$, $f_{0}=1-\overline{u(0)} u \neq 0$ and $v_{0}=u-u(0), v_{1}=0$. So Corollary 3.3 (1) implies $M$ has the representation

$$
M=\left\{f: f=k_{0}(1-\overline{u(0)} u)+k_{1} z u:\left(k_{0}, k_{1}\right) \in K\right\}
$$

with an $S^{*} \oplus S^{*}$-invariant subspace $K=K_{\eta} \times H^{2}$, where $\eta$ is the inner factor of $v_{0}$. Besides, Proposition 3.2 is used to show that $K$ is backward shift-invariant.
(iii) Suppose $u$ is a normalized reproducing kernel of $H^{2}$, that is $u(z)=\sqrt{1-|\alpha|^{2}}(1-\bar{\alpha} z)^{-1}, \quad \alpha \in \mathbb{D} \backslash\{0\}$, then $M=\{f: f(\alpha)=0\}$, $f_{0}=\bar{\alpha}(\alpha-z)(1-\bar{\alpha} z)^{-1} \neq 0$ and $v_{0}=0, v_{1}=\bar{\alpha}(1-\bar{\alpha} z)^{-1}$. So Corollary 3.3 (1) implies $M$ has the representation

M=\left\{f: f=\bar{\alpha} k_{0} \frac{\alpha-z}{1-\bar{\alpha} z}+z k_{1} \frac{\sqrt{1-|\alpha|^{2}}}{1-\bar{\alpha} z}:\left(k_{0}, k_{1}\right) \in K\right\},
$$

with an $S^{*} \oplus S^{*}$-invariant subspace $K=H^{2} \times\{0\}$.
(iv) Suppose $u(z)=\left(1+z^{k}\right) / \sqrt{2}$ with $k \geq 1$, then $M=\bigvee\{1-$ $\left.z^{k}, z, \cdots, z^{k-1}, z^{k+1}, z^{k+2}, \cdots\right\}, f_{0}=2^{-1}\left(1-z^{k}\right) \neq 0$ and $v_{0}=z^{k} /(2 \sqrt{2})$, $v_{1}=2^{-1} z^{k-1}$. So Corollary 3.3 (1) implies $M$ has the representation

$$
M=\left\{f: f=k_{0} \frac{1-z^{k}}{2}+z k_{1} \frac{1+z^{k}}{\sqrt{2}}:\left(k_{0}, k_{1}\right) \in K\right\}
$$

with an $S^{*} \oplus S^{*}$-invariant subspace $K=\left\{\left(k_{0}, k_{1}\right): \sqrt{2}\left(S^{*}\right)^{k-1} k_{1}=\right.$ $\left.-\left(S^{*}\right)^{k} k_{0}, k_{0} \in H^{2}\right\}$.
3.2. $g=\theta$ an inner function. In this case, $M=\operatorname{Ker} R_{1} \subset \bigvee\{\bar{\theta} v\}$. Take any vector $f=\lambda \bar{\theta} v \in M$ satisfying $R_{1} f=0$, which is equivalent to $\lambda(1+\langle\bar{\theta} v, u\rangle)=0$. If $1+\langle\bar{\theta} v, u\rangle \neq 0$, then $\lambda=0$, meaning $M=\{0\}$ a trivial $S^{*}$-invariant subspace. So suppose $1+\langle\bar{\theta} v, u\rangle=0$, and then $M=\bigvee\{\bar{\theta} v\}$, which is nearly $S^{*}$-invariant with a 1-dimensional defect space $F=\bigvee\left\{S^{*}(\bar{\theta} v)\right\}$ from Theorem [2.3, So Theorem 3.1 implies a corollary on the representations of Ker $R_{1}$.

Corollary 3.5. Given a nearly $S^{*}$-invariant subspace $M=\bigvee\{\bar{\theta} v\}$ with defect 1, then
(1) in the case $a_{0}:=\langle\bar{\theta} v, 1\rangle \neq 0$, let $f_{0}=P_{M} 1=\overline{a_{0}}\|v\|^{-2} \bar{\theta} v$, we have

$$
M=\left\{f: f=k_{0} f_{0}:\left(k_{0}, 0\right) \in K\right\}
$$

with an $S^{*} \oplus S^{*}$-invariant subspace $K=\mathbb{C} \times\{0\}$.
(2) in the case $a_{0}:=\langle\bar{\theta} v, 1\rangle=0$, we have

$$
M=\left\{f: f=\left\|S^{*}(\bar{\theta} v)\right\|^{-1} k_{1} \bar{\theta} v: k_{1} \in K\right\},
$$

with an $S^{*}$-invariant subspace $K=\mathbb{C}$.
Proof. (1) in this case, using Theorem 3.1 (1), we represent $M$ by

$$
\begin{aligned}
M & =\left\{f: f=k_{0} f_{0}+z k_{1} \frac{S^{*}(\bar{\theta} v)}{\left\|S^{*}(\bar{\theta} v)\right\|}:\left(k_{0}, k_{1}\right) \in K\right\} \\
& =\left\{f: f=\frac{\overline{a_{0}}}{\|v\|^{2}} k_{0} \bar{\theta} v+\left\|S^{*}(\bar{\theta} v)\right\|^{-1} k_{1}\left(\bar{\theta} v-a_{0}\right):\left(k_{0}, k_{1}\right) \in K\right\}
\end{aligned}
$$

Since $M=\bigvee\{\bar{\theta} v\}$, it yields

$$
k_{0} \in \mathbb{C} \text { and }\left\|S^{*}(\bar{\theta} v)\right\|^{-1} k_{1}\left(\bar{\theta} v-a_{0}\right)=\mu \bar{\theta} v \text { with } \mu \in \mathbb{C},
$$

which is equivalent to $k_{0} \in \mathbb{C}$ and $k_{1}=0$ due to $a_{0} \neq 0$. So the statement (1) is true. The statement (2) can be similarly shown by Theorem 3.1 (2).
3.3. $g=f_{1} \overline{f_{2}}$ with $f_{j} \in \mathcal{G} H^{\infty}$ for $j=1$, 2 . In this case, $M=\operatorname{Ker} R_{1} \subset$ $\bigvee\left\{f_{1}^{-1}\left(T_{\overline{f_{2}}-1} v\right)\right\}$. Take any vector $f=\lambda f_{1}^{-1}\left(T_{\overline{f_{2}}-1} v\right) \in M$ such that
 $M=\{0\}$ is a trivial $S^{*}$-invariant subspace for $1+\left\langle f_{1}^{-1} T_{\overline{f_{2}}}-1 v, u\right\rangle \neq 0$. Now we always assume $1+\left\langle f_{1}^{-1}\left(T_{\bar{f}_{2}}-1 v\right), u\right\rangle=0$, and obtain $M=$ $\bigvee\left\{f_{1}^{-1}\left(T_{\left.\overline{f_{2}}-1 v\right)}\right\}\right.$, which is nearly $S^{*}$-invariant with a 1-dimensional defect space $F=\bigvee\left\{f_{1}^{-1} T_{\overline{f_{2}}-1}\left(S^{*} v\right)\right\}$ from Theorem [2.5. Denote the Taylor coefficients of $T_{\overline{f_{2}}-1 v}$ and $f_{1}^{-1}$ by $\left\{a_{k}\right\}_{k \in \mathbb{N}}$ and $\left\{b_{k}\right\}_{k \in \mathbb{N}}$, respectively. So $\left\langle f_{1}^{-1} T_{\overline{f_{2}}-1} v, 1\right\rangle=a_{0} b_{0}$, and using Theorem 3.1, we deduce a corollary on the representations of Ker $R_{1}$.

Corollary 3.6. Given a nearly $S^{*}$-invariant subspace $M=\bigvee\left\{f_{1}^{-1}\left(T_{\overline{f_{2}}}-v\right)\right\}$ with defect 1 , then
(1) in the case $a_{0} b_{0} \neq 0$, let $f_{0}=P_{M} 1=\overline{a_{0} b_{0}}\left\|f_{1}^{-1} T_{\overline{f_{2}}-v} v\right\|^{-2} f_{1}^{-1} T_{\bar{f}_{2}}-1 v$; then we have

$$
M=\left\{f: f=k_{0} f_{0}:\left(k_{0}, 0\right) \in K\right\}
$$

with an $S^{*} \oplus S^{*}$-invariant subspace $K=\mathbb{C} \times\{0\}$.
(2) in the case $a_{0} b_{0}=0$, we have

$$
M=\left\{f: f=k_{1} \frac{f_{1}^{-1} T_{\overline{f_{2}}-1 v}}{\left\|f_{1}^{-1} T_{\overline{f_{2}}}-1\left(S^{*} v\right)\right\|}: k_{1} \in K\right\}
$$

with $K=\mathbb{C}$ an $S^{*}$-invariant subspace.

Proof. (1) in this case, Theorem 3.1 (1) gives
due to $\left.z f_{1}^{-1} T_{\overline{f_{2}}}-1\left(S^{*} v\right)\right]=f_{1}^{-1} z\left[S^{*}\left(T_{\overline{f_{2}}-1} v\right)\right]=f_{1}^{-1}\left(T_{\overline{f_{2}}}-1 v-a_{0}\right)$. Further by $M=\bigvee\left\{f_{1}^{-1}\left(T_{\overline{f_{2}}}-v\right)\right\}$, it follows that

$$
k_{0} \in \mathbb{C} \text { and } k_{1} \frac{f_{1}^{-1}\left(T_{\overline{f_{2}}-1 v}-a_{0}\right)}{\left\|f_{1}^{-1} T_{\overline{f_{2}}}-1\left(S^{*} v\right)\right\|}=\mu f_{1}^{-1}\left(T_{\overline{f_{2}}}-1 v\right) \text { with } \mu \in \mathbb{C},
$$

which is equivalent to $k_{0} \in \mathbb{C}$ and $k_{1}=0$ by $a_{0} \neq 0$.
(2) in this case, it follows either $a_{0}=0$ or $b_{0}=0$ and $f_{0}=P_{M} 1=0$. If $b_{0}=0$, Theorem 3.1 (2) implies that

$$
M=\left\{f: f=k_{1} \frac{f_{1}^{-1}\left(T_{\overline{f_{2}}-1} v-a_{0}\right)}{\left\|f_{1}^{-1} T_{\overline{f_{2}}-1}\left(S^{*} v\right)\right\|}: k_{1} \in K\right\}
$$

which is valid if and only if $a_{0}=0$ and $k_{1} \in \mathbb{C}$.
3.4. $g=\bar{\theta}$ with $\theta$ nonconstant inner function. Because of its link with model spaces, this case is of particular interest. For every $h \in$ Ker $R_{1}$, the equation (2.2) is equivalent to $h+\langle h, u\rangle \theta v \in \theta \overline{H_{0}^{2}}$. So

M=\operatorname{Ker} R_{1} \subset\left(H^{2} \cap \theta \overline{H_{0}^{2}}\right) \oplus \bigvee\{\theta v\}=K_{\theta} \oplus \bigvee\{\theta v\}
$$

Take any vector $h=h_{1}+\lambda \theta v \in M$ with $h_{1} \in K_{\theta}$ and $\lambda \in \mathbb{C}$, such that $R_{1} h=0$, which is equivalent to

$$
\begin{equation*}
\lambda(1+\langle\theta v, u\rangle)=-\left\langle h_{1}, u\right\rangle . \tag{3.1}
\end{equation*}
$$

Now we divide this into two subsections to represent $M=\operatorname{Ker} R_{1}$ in terms of backward shift-invariant subspaces.
3.4.1. $\theta \mid u$. In this case, the equation (3.1) now is changed into $\lambda(1+$ $\langle\theta v, u\rangle)=0$. If $1+\langle\theta v, u\rangle \neq 0$, then $\lambda=0$ and $M=K_{\theta}$ a nearly $S^{*}$-invariant subspace. So we suppose $1+\langle\theta v, u\rangle=0$, and then $M=$ $K_{\theta} \oplus \bigvee\{\theta v\}$ is nearly $S^{*}$-invariant with a 1-dimensional defect space $F=\bigvee\left\{\theta S^{*} v\right\}$ from Theorem [2.7, Using Theorem 3.1, we obtain a corollary on the representation of $\operatorname{Ker} R_{1}$.

Corollary 3.7. Given a nearly $S^{*}$-invariant subspace $M=K_{\theta} \oplus \bigvee\{\theta v\}$ with defect 1 , and let $f_{0}=P_{M} 1=1-\overline{\theta(0)} \theta+\overline{\theta(0) v(0)}\|v\|^{-2} \theta v$, we have

$$
\begin{align*}
M=\{f: f= & k_{0}-\left(k_{0} \overline{\theta(0)}+k_{1} \frac{v(0)}{\left\|S^{*} v\right\|}\right) \theta+\left(k_{0} \frac{\overline{\theta(0) v(0)}}{\|v\|^{2}}\right. \\
& \left.\left.+\left\|S^{*} v\right\|^{-1} k_{1}\right) \theta v:\left(k_{0}, k_{1}\right) \in K\right\}, \tag{3.2}
\end{align*}
$$

with an $S^{*} \oplus S^{*}$-invariant subspace $K=\left\{\left(k_{0}, k_{1}\right)\right.$ : $k_{i}$ satisfies (3.3) for $i=$ $0,1\}$, where
$k_{0}-\left(k_{0} \overline{\theta(0)}+k_{1} \frac{v(0)}{\left\|S^{*} v\right\|}\right) \theta \in K_{\theta} \quad$ and $k_{0} \frac{\overline{\theta(0) v(0)}}{\|v\|^{2}}+\left\|S^{*} v\right\|^{-1} k_{1} \in \mathbb{C}$.
Proof. By Theorem 3.1 (1), we obtain

$$
M=\left\{f: f=k_{0} f_{0}+k_{1} \frac{\theta(v-v(0))}{\left\|S^{*} v\right\|}:\left(k_{0}, k_{1}\right) \in K\right\},
$$

which equals $K_{\theta} \oplus \bigvee\{\theta v\}$ implying the desired representation in (3.2). It is clear the second relation in (3.3) holds for $S^{*} k_{i}, i=1,2$. At the same time, the first relation in (3.3) together with the fact $K_{\theta}$ is an $S^{*}$-invariant subspace verify that

Y_{\theta}:=S^{*} k_{0}-S^{*}\left(k_{0} \overline{\theta(0)} \theta+\frac{v(0) k_{1}}{\left\|S^{*} v\right\|} \theta\right) \in K_{\theta} .
$$

Then it turns out that

\begin{aligned}
& S^{*} k_{0}-\left(S^{*} k_{0} \overline{\theta(0)}+\frac{v(0)}{\left\|S^{*} v\right\|} S^{*} k_{1}\right) \theta \\
= & Y_{\theta}+\overline{\theta(0)} k_{0}(0) \frac{\theta-\theta(0)}{z}+\frac{v(0) k_{1}(0)}{\left\|S^{*} v\right\|} \frac{\theta-\theta(0)}{z} \\
= & Y_{\theta}+\left(\overline{\theta(0)} k_{0}(0)+\frac{v(0) k_{1}(0)}{\left\|S^{*} v\right\|}\right) T_{\bar{z}} \theta \in K_{\theta},
\end{aligned}
$$

since $\left\langle T_{\bar{z}} \theta, \theta\right\rangle=\langle 1, z\rangle=0$ holds. This means the first relation in (3.3) also holds for $S^{*} k_{i}, i=1,2$. So $K$ is an $S^{*} \oplus S^{*}$-invariant subspace.
3.4.2. $\theta \nmid u$. In this case, we decompose $u$ into $u=u_{1}+u_{\theta}$ with nonzero $u_{1} \in K_{\theta}$ and $u_{\theta} \in \theta H^{2}$. Then the identity (3.1) becomes

$$
\begin{equation*}
\lambda\left(1+\left\langle\theta v, u_{\theta}\right\rangle\right)=-\left\langle h_{1}, u_{1}\right\rangle . \tag{3.4}
\end{equation*}
$$

Especially Theorem 2.7 implies $\operatorname{Ker} R_{1}$ is nearly $S^{*}$-invariant with a 2-dimensional defect space $F=\bigvee\left\{\theta S^{*} v, u_{1}\right\}$. For later use we present a remark concerning the projection $P_{M} 1$.

Remark 3.8. Let $M=\operatorname{Ker} R_{1} \subset N:=K_{\theta} \oplus \bigvee\{\theta v\}$, and denote $N=$ $M \oplus \bigvee\{G\}$ with $G=g+\mu \theta v$, where $g \in K_{\theta}$ and $\mu \in \mathbb{C}$. Then

$$
\begin{align*}
P_{M} 1= & 1-\overline{\theta(0)} \theta+\frac{\overline{\theta(0) v(0)}}{\|v\|^{2}} \theta v \\
& -\frac{\langle 1-\overline{\theta(0) \theta} \theta, g\rangle+\overline{\theta(0) v(0) \mu}}{\|g\|^{2}+|\mu|^{2}\|v\|^{2}}(g+\mu \theta v) . \tag{3.5}
\end{align*}
$$

For simplicity, we denote $w_{\theta}:=1+\left\langle\theta v, u_{\theta}\right\rangle$ and

\rho_{\theta}:=\frac{\overline{u_{1}(0)}+\overline{\theta(0) v(0)} w_{\theta}}{\left\|u_{1}\right\|^{2}+\left|w_{\theta}\right|^{2}\|v\|^{2}} .
$$

Applying Theorem 3.1, we present a corollary on $\operatorname{Ker} R_{1}$.
Corollary 3.9. (1) In the case $w_{\theta} \neq 0, M=N \ominus \bigvee\left\{u_{1}+\overline{w_{\theta}} \theta v\right\}$ is nearly $S^{*}$-invariant with defect 2 , and letting

\begin{aligned}
& f_{0}=P_{M} 1=1-\overline{\theta(0)} \theta+\overline{\theta(0) v(0)}\|v\|^{-2} \theta v-\rho_{\theta}\left(u_{1}+\overline{w_{\theta}} \theta v\right), \\
& v_{0}=P\left(u_{1}+\overline{w_{\theta}} \theta v-\theta(0) \overline{w_{\theta}} v+\theta(0) v(0)\|v\|^{-2} \overline{w_{\theta}}|v|^{2}-\overline{\rho_{\theta}}\left|u_{1}+\overline{w_{\theta}} \theta v\right|^{2}\right), \\
& v_{1}=\left\|S^{*} v\right\|^{-1} P\left(\overline{w_{\theta}} v(\overline{v-v(0)})\right) \text { and } v_{2}=\left\|u_{1}\right\|^{-1} P\left(\bar{z}\left|u_{1}\right|^{2}\right),
\end{aligned}
$$

we have

$$
\begin{align*}
M=\{f & : f=k_{0}-\left(k_{0} \overline{\theta(0)}+k_{1} \frac{v(0)}{\left\|S^{*} v\right\|}\right) \theta+\left(k_{0} \frac{\overline{\theta(0) v(0)}}{\|v\|^{2}}+\frac{k_{1}}{\left\|S^{*} v\right\|}-k_{2} \frac{z \overline{w_{\theta}}}{\left\|u_{1}\right\|}\right) \theta v \\
& \left.+\left(-k_{0} \rho_{\theta}+k_{2} \frac{z}{\left\|u_{1}\right\|}\right)\left(u_{1}+\overline{w_{\theta}} \theta v\right):\left(k_{0}, k_{1}, k_{2}\right) \in K\right\}, \tag{3.7}
\end{align*}
$$

with an $S^{*} \oplus S^{*} \oplus S^{*}$-invariant subspace $K=\left\{\left(k_{0}, k_{1}, k_{2}\right): k_{i}\right.$ satisfies (3.8) for $i=0,1,2\}$, where

$$
\left\{\begin{array}{l}
k_{0}-\left(k_{0} \overline{\theta(0)}+k_{1} \frac{v(0)}{\left\|S^{*} v\right\|}\right) \theta \in K_{\theta},  \tag{3.8}\\
k_{0} \frac{\overline{\theta(0) v(0)}}{\|v\|^{2}}+\frac{k_{1}}{\left\|S^{*} v\right\|}-k_{2} \frac{z \overline{w_{\theta}}}{\left\|u_{1}\right\|} \in \mathbb{C}, \\
\left\langle k_{0}, z^{n} v_{0}\right\rangle+\left\langle k_{1}, z^{n} v_{1}\right\rangle+\left\langle k_{2}, z^{n} v_{2}\right\rangle=0 \text { for all } n \in \mathbb{N} .
\end{array}\right.
$$

(2) In the case $w_{\theta}=0, M=N \ominus \bigvee\left\{u_{1}\right\}$ is nearly $S^{*}$-invariant with defect 2, and letting

\begin{aligned}
& f_{0}=P_{M} 1=1-\overline{\theta(0)} \theta-\overline{u_{1}(0)}\left\|u_{1}\right\|^{-2} u_{1}+\overline{\theta(0) v(0)}\|v\|^{-2} \theta v, \\
& v_{0}=P\left(u_{1}-u_{1}(0)\left\|u_{1}\right\|^{-2}\left|u_{1}\right|^{2}\right) \quad \text { and } \quad v_{2}=P\left(\left\|u_{1}\right\|^{-1} \bar{z}\left|u_{1}\right|^{2}\right),
\end{aligned}
$$

we have

\begin{aligned}
M=\{f: f & =k_{0}-\left(k_{0} \overline{\theta(0)}+k_{1} \frac{v(0)}{\left\|S^{*} v\right\|}\right) \theta+\left(k_{0} \frac{\overline{\theta(0) v(0)}}{\|v\|^{2}}+\frac{k_{1}}{\left\|S^{*} v\right\|}\right) \theta v \\
& \left.+\left(-k_{0} \frac{\overline{u_{1}(0)}}{\left\|u_{1}\right\|^{2}}+k_{2} \frac{z}{\left\|u_{1}\right\|}\right) u_{1}:\left(k_{0}, k_{1}, k_{2}\right) \in K\right\},
\end{aligned}
$$

with an $S^{*} \oplus S^{*} \oplus S^{*}$-invariant subspace $K=\left\{\left(k_{0}, k_{1}, k_{2}\right): k_{i}\right.$ satisfies (3.9) for $i=0,1,2\}$, where

$$
\left\{\begin{array}{l}
k_{0}-\left(k_{0} \overline{\theta(0)}+k_{1} \frac{v(0)}{\left\|S^{*} v\right\|}\right) \theta \in K_{\theta},  \tag{3.9}\\
k_{0} \frac{\overline{\theta(0) v(0)}}{\|v\|^{2}}+\left\|S^{*} v\right\|^{-1} k_{1} \in \mathbb{C}, \\
\left\langle k_{0}, z^{n} v_{0}\right\rangle+\left\langle k_{2}, z^{n} v_{2}\right\rangle=0 \text { for } n \in \mathbb{N}
\end{array}\right.
$$

Proof. For the case $w_{\theta} \neq 0$, the equation (3.4) implies $\lambda=-w_{\theta}^{-1}\left\langle h_{1}, u_{1}\right\rangle$ and then $M=\operatorname{Ker} R_{1}=\left\{f: f=k-w_{\theta}^{-1}\left\langle k, u_{1}\right\rangle \theta v, k \in K_{\theta}\right\}$. By some calculations, it follows

$$
\begin{equation*}
M=N \ominus \bigvee\left\{u_{1}+\overline{w_{\theta}} \theta v\right\} \tag{3.10}
\end{equation*}
$$

Letting $g=u_{1}$ and $\mu=\overline{w_{\theta}}$ in (3.5), we obtain $f_{0}$ in (3.6). By Theorem 3.1 (1), it follows

$$
M=\left\{f: f=k_{0} f_{0}+k_{1} \frac{\theta(v-v(0))}{\left\|S^{*} v\right\|}+k_{2} \frac{z u_{1}}{\left\|u_{1}\right\|}:\left(k_{0}, k_{1}, k_{2}\right) \in K\right\}
$$

which together with (3.10) imply the representation of $M$ in (3.7). Note the third formula in (3.8) holds for $S^{*} k_{i}, i=0,1,2$. Following the similar lines for proving (3.3) is $S^{*}$-invariant, it is easy to check the first two relations of (3.8) are valid for $S^{*} k_{i}, i=0,1,2$. So $K$ is an $S^{*} \oplus S^{*} \oplus S^{*}$-invariant subspace. In particular, if $w_{\theta}=0$, the equation (3.4) implies

$$
M=N \ominus \bigvee\left\{u_{1}\right\}
$$

which is a special case of (3.10) with $w_{\theta}=0$. Hence we can prove the statement (2) from the similar proof of statement (1) with $w_{\theta}=0$.

In order to help understand the case $g=\bar{\theta}$ with $\theta$ an inner function, we present an example for Corollary 3.9 ,

Example 3.10. Let $\theta=z^{m}(m \geq 1)$ and $u=u_{1}+u_{2}$ with $u_{1}=z^{m-1} / 4$ and $u_{2} \in z^{m} H^{2}$. It easy to check the kernel of $R_{1}$ is

$$
M=\bigvee\left\{1, z, \cdots, z^{m-1}\right\rangle \oplus \bigvee\left\{z^{m} v\right\} \ominus \bigvee\left\{z^{m-1} / 4+\overline{w_{\theta}} z^{m} v\right\}
$$

which is nearly $S^{*}$-invariant with 2 -dimensional defect space
$F=\bigvee\left\{z^{m} S^{*} v, z^{m-1}\right\}$ from Theorem 2.7. If $w_{\theta}=1+\left\langle z^{m} v, u_{\theta}\right\rangle \neq 0$, then Corollary 3.9 (2) indicates the following representation for $M$ :

$$
\begin{aligned}
M= & \left\{f: f=k_{0}-k_{1} \frac{v(0)}{\left\|S^{*} v\right\|} z^{m}+\left(k_{1}\left\|S^{*} v\right\|^{-1}-4 k_{2} z \overline{w_{\theta}}\right) z^{m} v\right. \\
& \left.+k_{2} z\left(z^{m-1}+4 \overline{w_{\theta}} z^{m} v\right):\left(k_{0}, k_{1}, k_{2}\right) \in K\right\}
\end{aligned}
$$

with an $S^{*} \oplus S^{*} \oplus S^{*}$-invariant subspace $K=\left\{\left(k_{0}, k_{1}, k_{2}\right): k_{i}\right.$ satisfies (3.11) for $i=0,1,2\}$ where

$$
\left\{\begin{array}{l}
k_{0}-k_{1} \frac{v(0)}{\left\|S^{*} v\right\|} z^{m} \in K_{z^{m}}  \tag{3.11}\\
k_{1}\left\|S^{*} v\right\|^{-1}-4 k_{2} z \overline{w_{\theta}} \in \mathbb{C} \\
\left\langle k_{0}, z^{n} v_{0}\right\rangle+\left\langle k_{1}, z^{n} v_{1}\right\rangle=0 \text { for } n \in \mathbb{N}
\end{array}\right.
$$

with

$$
v_{0}=4^{-1} z^{m-1}+\overline{w_{\theta}} z^{m} v, \quad v_{1}=\left\|S^{*} v\right\|^{-1} P\left(\overline{w_{\theta}} v(\overline{v-v(0)})\right) .
$$
