# A NOTE ON PRESENTATIONS OF SUPERSINGULAR REPRESENTATIONS OF GL ${ }_{2}(F)$

#### Abstract

We prove that any smooth irreducible supersingular representation with central character of $\mathrm{GL}_{2}(F)$ is never of finite presentation when $F$ is a finite field extension of $\mathbb{Q}_{p}$ such that $F \neq \mathbb{Q}_{p}$, extending a result of Schraen in [16] for quadratic extensions.


## 1. Introduction

Let $p$ be a prime number. Let $F$ be a finite extension of $\mathbb{Q}_{p}$ with ring of integers $\mathcal{O}$. Let $n \geq 2$ be an integer. Recent years, several progresses have been made on the study of representations of $p$-adic Lie groups on vector spaces over fields of characteristic $p$, motivated by the $p$-adic and mod- $p$ Langlands programs. The classifications of mod- $p$ irreducible admissible smooth representations of $\mathrm{GL}_{n}(F)$ in terms of supersingular representations was proved by Barthel-Livné for $\mathrm{GL}_{2}$ ([3]) and by Herzig for general $\mathrm{GL}_{n}([\overline{10}])$, which are now known for general reductive groups ([2] ). Supersingular representations of $\mathrm{GL}_{2}\left(\mathbb{Q}_{p}\right)$ was classified by Breuil and some mod- $p$ Langlands correspondences appeared ( $[4]$ ). Up to now, except $\mathrm{GL}_{2}\left(\mathbb{Q}_{p}\right)$ and some related groups such as $\mathrm{SL}_{2}\left(\mathbb{Q}_{p}\right)([1],[6],[12])$, supersingular representations for general groups (e.g. $\mathrm{GL}_{3}\left(\mathbb{Q}_{p}\right)$ or $\mathrm{GL}_{2}(F)$ when $F \neq \mathbb{Q}_{p}$ ) remain mysterious. Some complexity of classifications of supersingular representations of $\mathrm{GL}_{2}(F)$ when $F \neq \mathbb{Q}_{p}$ was shown by Breuil-Paškūnas's construction of supersingular representations ([5]). Daniel Le also constructed some non-admissible irreducible smooth mod- $p$ representations for certain $\mathrm{GL}_{2}(F)$ ([13]).

Let $G=\mathrm{GL}_{2}(F), K=\mathrm{GL}_{2}(\mathcal{O})$ and $Z$ be the center of $G$. Let $\pi$ be an irreducible smooth representation of $G$ over an algebraically closed characteristic $p$ field $k$ with central character. Then $\pi$ contains a smooth irreducible sub-representation $\sigma$ of subgroup $K Z$ and there is a surjective morphism of $G$-representations $\operatorname{ind}_{K Z}^{G} \sigma \rightarrow \pi$ by the Frobenius reciprocity where $\operatorname{ind}_{K Z}^{G} \sigma$ denotes the compact induced representation. The representation $\pi$ is called of finite presentation if the kernel of the surjection $\operatorname{ind}_{K Z}^{G} \sigma \rightarrow \pi$ is finitely generated as a $k[G]$-module. Such kind of finite presentation of representations of $G$ when $G=\mathrm{GL}_{2}\left(\mathbb{Q}_{p}\right)$ are used by Colmez to construct a functor to get étale $(\varphi, \Gamma)$-modules from representations of $\mathrm{GL}_{2}\left(\mathbb{Q}_{p}\right)$, which plays a key role in mod- $p$ and $p$-adic Langlands correspondences for $\mathrm{GL}_{2}\left(\mathbb{Q}_{p}\right)([7])$. Vignéras constructed a generalized functor from representations of $\mathrm{GL}_{2}(F)$ of finite presentation to étale $(\varphi, \Gamma)$-modules of finite type ([17]). Unfortunately, Schraen proved in [16] that any smooth irreducible supersingular representation with central character of $\mathrm{GL}_{2}(F)$ is never of finite presentation when $F$ is a quadratic field extension of $\mathbb{Q}_{p}$. The proof relies on a kind of coherent rings found by Emerton ([8]) and a criterion of finite presentation for representations of $\mathrm{GL}_{2}$ by Hu (Theorem 1.3, [11]). In the note, we extend the result for any finite field extension $F$ of $\mathbb{Q}_{p}$ such that $F \neq \mathbb{Q}_{p}$.

Theorem 1.1 (3.8). If $\left[F: \mathbb{Q}_{p}\right] \geq 2$, a smooth supersingular representation of $G L_{2}(F)$ with central character is not of finite presentation.

The proof firstly follows and simplifies the original arguments in [16]. Let $\operatorname{ind}_{K Z}^{G} \sigma / T\left(\operatorname{ind}_{K Z}^{G} \sigma\right)$ be the universal supersingular representation of $G$ where $T$ is the distinguished Hecke operator (cf. [3]). Let $L(\sigma)$ be the subspace of $\operatorname{ind}_{K Z}^{G} \sigma / T\left(\operatorname{ind}_{K Z}^{G} \sigma\right)$ generated by $\sigma$ under the action of monoid $\left(\begin{array}{cc}\varpi^{2 \mathbb{N}} & \mathcal{O} \\ & 1\end{array}\right)$, where $\varpi$ is a uniformizer of $\mathcal{O}$. Let $U:=\left(\begin{array}{cc}1 & \mathcal{O} \\ & 1\end{array}\right)$ be the subgroup of unipotent uppertriangular matrices in $\mathrm{GL}_{2}(\mathcal{O})$. Using some arguments on modules over coherent rings (Lemma 3.1
and Lemma 3.2), we prove that $\pi$ is not of finite presentation if the sub-module $L(\sigma)$ is not admissible, which means that the space $L(\sigma)^{U}$ of the $U$-invariants in $L(\sigma)$ is infinite-dimensional over $k$. The non-admissibility of $L(\sigma)$ is proved by explicitly finding invariant elements which is similar to works in [4], [15], [14] and [9]. A key observation is that the module structure of $L(\sigma)$ over the coherent ring guarantees that $\operatorname{dim}_{k} L(\sigma)^{U}=\infty$ if $\operatorname{dim}_{k} L(\sigma)^{U} \geq 2$. As a corollary, following [8] and [16], our result gives a uniform proof for the following fact.
Corollary 1.2 (4.5). For any smooth irreducible representation $\sigma$ of $K Z$, the universal supersingular representation ind ${ }_{K Z}^{G} \sigma / T\left(\operatorname{ind}_{K Z}^{G} \sigma\right)$ of $G L_{2}(F)$ is not admissible if $F \neq \mathbb{Q}_{p}$.

Organization of the note. In $\S 2$, we recall basic facts on mod- $p$ representations of $\mathrm{GL}_{2}(F)$ and Emerton's coherent rings. We prove the main result in $\S 3$ with the proof for non-admissibility postponed to $\S 4$.

Notations. We fix a uniformizer $\varpi$ of $F$. Let $k_{F}$ be the residue field of $\mathcal{O}$. Let $d=\left[F: \mathbb{Q}_{p}\right]$, $f=\left[k_{F}: \mathbb{F}_{p}\right], e=d / f$ and $q=p^{f}$. Let $G=\mathrm{GL}_{2}(F), K=\mathrm{GL}_{2}(\mathcal{O})$ and $Z$ be the center of $G$. Let $K_{1}$ be the kernel of the reduction map $K \rightarrow \mathrm{GL}_{2}\left(k_{F}\right)$. Let $U=\left\{\left(\begin{array}{ll}1 & a \\ & 1\end{array}\right), a \in \mathcal{O}\right\}$ and $\alpha=\left(\begin{array}{ll}\varpi & \\ & 1\end{array}\right)$. Let $k$ be an algebraically closed field of characteristic $p$. We identify $k_{F}=\mathbb{F}_{q}$ and fix an embedding $k_{F} \hookrightarrow k$. All the representations in the note are on vector spaces over $k$.

## 2. PRELIMINARY ON REPRESENTATIONS AND COHERENT RINGS

Mod- $p$ representations of $\mathbf{G L}_{2}$. We recall some results and notations in [3] and [4]. Let $\pi$ be a smooth irreducible representation of $G$ with central character over $k$. Then $\pi$ contains an irreducible sub- $K Z$ representation $\sigma$ of $K Z$. Let $\operatorname{ind}_{K Z}^{G} \sigma$ be the compactly induced representation: the representation space consists of functions $f: G \rightarrow \sigma$ such that $f$ is compactly supported modulo $K Z$ and $f(k \cdot)=k . f(\cdot)$ for any $k \in K Z$ and the action of $G$ is given by right translations. There is a distinguished element $T \in \operatorname{End}_{G}\left(\operatorname{ind}_{K Z}^{G} \sigma\right)$ which generates the Hecke algebra. By the definition and the classification in [3], $\pi$ is supersingular if and only if there exists a surjection $\operatorname{ind}_{K Z}^{G} \sigma \rightarrow \pi$ induced by an inclusion $\left.\sigma \hookrightarrow \pi\right|_{K Z}$ and the Frobenius reciprocity such that the surjection factors through a map

for some or every such $\sigma$.
If $0 \leq r \leq p-1$ is an integer, let $\mathrm{Sym}^{r}$ be the $r$-th symmetric power of the standard representation of $\mathrm{GL}_{2}\left(\mathbb{F}_{q}\right)$ on two-dimensional space $k^{2}$ via the embedding $\mathbb{F}_{q} \hookrightarrow k$. If $\vec{r}=\left(r_{0}, \cdots, r_{f-1}\right) \in \mathbb{Z}^{f}$ with $0 \leq r_{j} \leq p-1$ for any $0 \leq j \leq f-1$, we get a representation $\operatorname{Sym}^{\vec{r}}:=\otimes_{j=0}^{f-1} \operatorname{Sym}^{r_{j}} \circ \mathrm{Fr}^{j}$, where Fr denotes the automorphism of $\mathrm{GL}_{2}\left(\mathbb{F}_{q}\right)$ induced by the Frobenius automorphism of $\mathbb{F}_{q}$. If $\vec{a}, \vec{b} \in \mathbb{Z}^{f}$, we say $\vec{a} \leq \vec{b}$ if $a_{j} \leq b_{j}$ for any $j=0, \cdots, f-1$. The representation $\operatorname{Sym}^{\vec{r}}$ has a model consisting of homogeneous polynomials spanned by a basis $\left\{\otimes_{j=0}^{f-1} x_{j}^{r_{j}-i_{j}} y_{j}^{i_{j}}\right\}_{0 \leq \vec{i} \leq \vec{r}}$. The group action is given by

for any $0 \leq \vec{i} \leq \vec{r},\left(\begin{array}{ll}a & b \\ c & d\end{array}\right) \in \mathrm{GL}_{2}\left(\mathbb{F}_{q}\right)$. We abbreviate $x^{\vec{r}-\vec{i}} y^{\vec{i}}:=\otimes_{j=0}^{f-1} x_{j}^{r_{j}-i_{j}} y_{j}^{i_{j}}$. If $\chi: \mathbb{F}_{q}^{\times} \rightarrow k^{\times}$ is a character of $\mathbb{F}_{q}^{\times}, \chi \circ$ det is a character of $\mathrm{GL}_{2}\left(\mathbb{F}_{q}\right)$. We can naturally inflate the representation
$(\chi \circ \operatorname{det}) \otimes \operatorname{Sym}^{\vec{r}}$ of $\mathrm{GL}_{2}\left(\mathbb{F}_{q}\right)$ to a representation of $K$ by letting $K_{1}$ act trivially. Then the smooth irreducible $K Z$-representation $\sigma$ is isomorphic to $(\chi \circ \operatorname{det}) \otimes \operatorname{Sym}^{\vec{r}}$ when restricted to $K$ for a unique $\chi: \mathbb{F}_{q}^{\times} \rightarrow k^{\times}$and $\vec{r}$ as above and the action of $\left(\begin{array}{ll}\varpi & \\ & \varpi\end{array}\right) \in Z$ on $\sigma$ is given by a scalar $\nu \in k^{\times}$.

If $g \in G, w \in \sigma$, let $[g, w] \in \operatorname{ind}_{K Z}^{G} \sigma$ be the element given by

Then $g^{\prime} .[g, w]=\left[g^{\prime} g, w\right], \forall g^{\prime}, g \in G, w \in \sigma$. If $S \subset G$ is a subset, let $[S, \sigma]$ be the subspace of $\operatorname{ind}_{K Z}^{G} \sigma$ spanned by $[g, w], w \in \sigma, g \in S$.

If $\lambda \in \mathbb{F}_{q}$, we let $[\lambda]$ be the Teichmüller lift of $\lambda$ in $F$. For any integer $n \geq 1$, the set $I_{n}:=$ $\left\{\left[\lambda_{0}\right]+\varpi\left[\lambda_{1}\right]+\cdots+\varpi^{n-1}\left[\lambda_{n-1}\right], \lambda_{i} \in \mathbb{F}_{q}\right\}$ is a complete set of representatives of $\mathcal{O} / \varpi^{n} \mathcal{O}$. We define $I_{0}=\{0\}$. If $\lambda=\left[\lambda_{0}\right]+\varpi\left[\lambda_{1}\right]+\cdots+\varpi^{n-1}\left[\lambda_{n-1}\right] \in I_{n}$, let $[\lambda]_{n-1}:=\lambda-\varpi^{n-1}\left[\lambda_{n-1}\right] \in I_{n-1}$. If $\vec{i} \in$ $\mathbb{Z}^{f}, \lambda \in \mathbb{F}_{q}$, we use the notation $\lambda^{\vec{i}}:=\lambda^{\sum_{0 \leq j \leq f-1} p^{j} i_{j}}$. The element $\left[\left(\begin{array}{cc}\varpi^{n} & \lambda \\ & 1\end{array}\right), \sum_{\overrightarrow{0} \leq \vec{i} \leq \vec{r}} u_{\vec{i}} x^{\vec{r}-\vec{i}} y^{\vec{i}}\right] \in$ $\operatorname{ind}_{K Z}^{G} \sigma$ where $u_{\vec{i}} \in k$ for any $\vec{i}, n \in \mathbb{N}, \lambda \in I_{n}$. The action of the operator $T$ on the element is calculated as in [4] (or see Proposition 2.1, [9]). If $n \geq 1, \mu \in I_{n}$,

A class of coherent rings. We now recall some results in [8] and [16] on a type of coherent rings and their applications on representations of $\mathrm{GL}_{2}$. Assume $A$ is a complete regular local ring of dimension $d$ with residue field $k$ and maximal ideal $\mathfrak{m}$. Assume $\phi: A \rightarrow A$ is a local flat ring endomorphism of $A$ and assume $\phi$ is equal to the identity map on $k$ after reduction modulo $\mathfrak{m}$. We let $A[X]_{\phi}$ be the ring of polynomials in variable $X$ with commutative relation $X a=\phi(a) X, \forall a \in A$. By Proposition 1.3 in [8], $A[X]_{\phi}$ is a coherent ring which means that any finitely generated submodule of a finitely presented left $A[X]_{\phi}$-module is finitely presented.

Modulo $\mathfrak{m}$, we get a ring morphism $A[X]_{\phi} \rightarrow k[X]$. If $M$ is a left $A[X]_{\phi}$-module, there are natural isomorphisms $\operatorname{Tor}_{i}^{A[X]_{\phi}}(k[X], M) \simeq \operatorname{Tor}_{i}^{A}(k, M)$ for all $i \geq 0$ (Lemma 2.1, [8]). The isomorphisms equip the $k$-spaces $\operatorname{Tor}_{i}^{A}(k, M) k[X]$-module structures. If $M$ is a finitely presented $A[X]_{\phi}$-module, then for any $i \geq 0, \operatorname{Tor}_{i}^{A}(k, M)$ is a finitely generated $k[X]$-module (Proposition 2.2, [8]).

An $A$-module is called smooth if any finitely generated submodule is Artinian. An $A[X]_{\phi}$-module is called smooth if the underlying $A$-module is smooth. If $M$ is an $A$-module, we let $M[\mathfrak{m}]=\{x \in M \mid$ $m x=0, \forall m \in \mathfrak{m}\}$. There is a non-canonical isomorphism between functor $M \mapsto M[\mathfrak{m}]$ and functor $M \mapsto \operatorname{Tor}_{d}^{A}(k, M)$. An $A$-module $M$ is called admissible if it is smooth and $M[\mathfrak{m}] \simeq \operatorname{Tor}_{d}^{A}(k, M)$ is finite-dimensional over $k$. An $A[X]_{\phi}$-module is called admissible if the underlying $A$-module is admissible.

From now on, we let $A:=k[[U]]=\lim k[U / N]$, where $N$ ranges over all open normal subgroups of $U$, be the Iwasawa algebra of $U$. Then $A \simeq k\left[\left[X_{1}, \cdots, X_{d}\right]\right]$ the ring of formal power series in $d$ variables with maximal ideal $\mathfrak{m}=\left(X_{1}, \cdots, X_{d}\right)$. The action of $\alpha=\left(\begin{array}{ll}\varpi & \\ & 1\end{array}\right)$ on $U: u \mapsto \alpha u \alpha^{-1}$ induces a flat local morphism $\phi: A \rightarrow A$. If $\Pi$ is a smooth representation of $U, \Pi$ is naturally a smooth $A$-module and $\Pi^{U}=\Pi[\mathfrak{m}]$. Thus the representation $\Pi$ is an admissible $A$-module if and only if $\Pi$ is an admissible $U$-representation. Any representation $\Pi$ of monoid $\left(\begin{array}{cc}\varpi^{\mathbb{N}} & \mathcal{O} \\ & 1\end{array}\right)$ is now naturally an $A[X]_{\phi}$-module where $X$ acts by the action of $\alpha$ on $\Pi$.

Let $\sigma$ be an irreducible smooth representation of $K Z$. For any $n \geq 0$, let $R_{n}(\sigma):=\left[\left(\begin{array}{ll}\varpi^{n} & \mathcal{O} \\ & 1\end{array}\right), \sigma\right]$ which is a sub- $A$-module of $\operatorname{ind}_{K Z}^{G} \sigma$. For any $k \in \mathbb{N}$, we let

I_{\geq k}(\sigma):=\bigoplus_{n \geq k} R_{n}(\sigma), \quad I_{\geq k}^{e}(\sigma):=\bigoplus_{n \geq k, 2 \mid n} R_{n}(\sigma), \quad I_{\geq k}^{o}(\sigma):=\bigoplus_{n \geq k, 2 \nmid n} R_{n}(\sigma),

be subspaces of $\operatorname{ind}_{K Z}^{G} \sigma$. We let $\phi_{2}:=\phi^{2}: A \rightarrow A$. We have (Lemma 2.11, [16])

I_{\geq 0}^{e}(\sigma) \simeq A[X]_{\phi_{2}} \otimes_{A} \sigma, \quad I_{\geq 1}^{o}(\sigma) \simeq A[X]_{\phi_{2}} \otimes_{A} R_{1}(\sigma)
$$

as $A[X]_{\phi_{2}}$-modules.
By the formula of the operator $T$ (2.1), we have $T\left(R_{n}(\sigma)\right) \subset R_{n+1}(\sigma) \oplus R_{n-1}(\sigma)$ if $n \geq 1$. Hence $T\left(I_{\geq 1}(\sigma)\right) \subset I_{\geq 0}(\sigma)$ and $T\left(I_{\geq 1}^{o}(\sigma)\right) \subset I_{\geq 0}^{e}(\sigma)$, etc. We decompose $\left.T\right|_{I_{\geq 1}(\sigma)}=T_{+}+T_{-}$by the decomposition $\left.T\right|_{R_{n}(\sigma)}=\left.T_{+}\right|_{R_{n}(\sigma)}+\left.T_{-}\right|_{R_{n}(\sigma)}$, where $\left.T_{+}\right|_{R_{n}(\sigma)}: R_{n}(\sigma) \rightarrow R_{n+1}(\sigma)$ and $\left.T_{-}\right|_{R_{n}(\sigma)}:$ $R_{n}(\sigma) \rightarrow R_{n-1}(\sigma)$ are compositions of the projections to the direct sum factors of $R_{n+1}(\sigma) \oplus R_{n-1}(\sigma)$ and $\left.T\right|_{R_{n}(\sigma)}$, for all $n \geq 1$.

Let $L(\sigma):=I_{\geq 0}^{e}(\sigma) / T\left(I_{\geq 1}^{o}(\sigma)\right)$. Then $L(\sigma)$ is an $A[X]_{\phi_{2}}$-module. The following proposition is essentially Proposition 2.23 in [16] which we recall the proof.

Proposition 2.1. $\operatorname{Tor}_{0}^{A}(k, L(\sigma))=0$. The $k[X]$-torsion part of $\operatorname{Tor}_{d}^{A}(k, L(\sigma))$ is isomorphic to $k=$ $k[X] /(X)$ and coincides with the image of $\operatorname{Tor}_{d}^{A}(k, \sigma)$ via the morphism $\sigma \hookrightarrow I_{\geq 0}^{e}(\sigma) \rightarrow L(\sigma)$.
Proof We have an exact sequence

\end{array}\right) \operatorname{Tor}_{0}^{A}\left(k, I_{\geq 1}^{o}(\sigma)\right) \xrightarrow{\operatorname{Tor}_{0}^{A}(T)} \operatorname{Tor}_{0}^{A}\left(k, I_{\geq 0}^{e}(\sigma)\right) \rightarrow \operatorname{Tor}_{0}^{A}(k, L(\sigma)) \rightarrow 0 .

And $\operatorname{Tor}_{i}^{A}\left(k, I_{\geq 0}^{e}(\sigma)\right) \simeq \oplus_{k \geq 0} \operatorname{Tor}_{i}^{A}\left(k, R_{2 k}(\sigma)\right), \operatorname{Tor}_{i}^{A}\left(k, I_{\geq 1}^{o}(\sigma)\right) \simeq \oplus_{k \geq 0} \operatorname{Tor}_{i}^{A}\left(k, R_{2 k+1}(\sigma)\right)$ for $i \in$ $\mathbb{N}$.

By Lemma 2.12 in [16], $\operatorname{Tor}_{0}^{A}\left(T_{+}\right)=0, \operatorname{Tor}_{0}^{A}\left(T_{-}\right)=\operatorname{Tor}_{0}^{A}(T)$ and $\operatorname{Tor}_{0}^{A}\left(T_{-}\right)$sends each $\operatorname{Tor}_{0}^{A}\left(k, R_{2 k+1}(\sigma)\right)$ onto $\operatorname{Tor}_{0}^{A}\left(k, R_{2 k}(\sigma)\right)$. Hence $\operatorname{Tor}_{0}^{A}(T)$ in the above diagram is a surjection and $\operatorname{Tor}_{0}^{A}(k, L(\sigma))=0$. Since $\operatorname{Tor}_{d-1}^{A}\left(k, I_{\geq 1}^{o}(\sigma)\right) \simeq \operatorname{Tor}_{d-1}^{A}\left(k, A[X]_{\phi_{2}} \otimes_{A}\left(A \otimes_{\phi, A} \sigma\right)\right) \simeq k[X] \otimes_{k} \operatorname{Tor}_{d-1}^{A}\left(k, A \otimes_{\phi, A} \sigma\right)$ by Proposition 1.4 in [16], the $k[X]$-module $\operatorname{Tor}_{d-1}^{A}\left(k, I_{\geq 1}^{o}(\sigma)\right)$ is torsion free. Hence $\operatorname{Tor}_{d}^{A}(k, L(\sigma))_{\text {tors }}=$ $\operatorname{coker}\left(\operatorname{Tor}_{d}^{A}(T)\right)_{\text {tors }}$. By Lemma 2.12 in [16] again, $\operatorname{Tor}_{d}^{A}\left(T_{-}\right)=0$ and $\operatorname{Tor}_{d}^{A}\left(T_{+}\right)$sending $\operatorname{Tor}_{d}^{A}\left(k, R_{2 k+1}(\sigma)\right)$ to $\operatorname{Tor}_{d}^{A}\left(k, R_{2 k+2}(\sigma)\right)$ is an isomorphism. Thus the image of $\operatorname{Tor}_{d}^{A}(T)$ in $\operatorname{Tor}_{d}^{A}\left(k, I_{\geq 0}^{e}(\sigma)\right)$ is $\oplus_{k \geq 1} \operatorname{Tor}_{d}^{A}\left(k, R_{2 k}(\sigma)\right)$. Since $R_{0}(\sigma)=\sigma, \operatorname{Tor}_{d}^{A}(k, L(\sigma))_{\text {tors }}$ coincides with the image of $\operatorname{Tor}_{d}^{A}(k, \sigma)$ via the map $\sigma \hookrightarrow$ $I_{\geq 0}^{e}(\sigma) \rightarrow L(\sigma)$ in $L(\sigma)$. Finally, $\operatorname{Tor}_{d}^{A}(k, \sigma) \simeq \sigma^{U}$ is one-dimensional over $k$ by Lemma 2 in [3].

We recall the following key lemma on smooth finitely presented $A[X]_{\phi}$-modules in [16].

Lemma 2.2 ([16], Lemma 1.13). Let $M$ be a smooth finitely presented $A[X]_{\phi}$-module. Then there exists an increasing sequence of sub- $A[X]_{\phi}$-modules $\left(M_{i}\right)_{i \geq 0}$, a sequence of finite-dimensional $k$ vector spaces $\left(V_{i}\right)_{i \geq 0}$ such that there exist isomorphisms $M_{i+1} / M_{i} \simeq A[X]_{\phi} \otimes_{A} V_{i}$ as $A[X]_{\phi}$-modules, and if we let $\widetilde{M}=\cup_{i} M_{i}$, then $\operatorname{Tor}_{d}^{A}(k, M)_{\text {tors }} \simeq \operatorname{Tor}_{d}^{A}(k, M / \widetilde{M})$. In particular, $M / \widetilde{M}$ is admissible and each $M_{i}$ is of finite presentation.

## 3. Presentations of supersingular representations

We prove some lemmas on $A[X]_{\phi}$-modules.
Lemma 3.1. Let $M$ be a non-zero, smooth, finitely presented $A[X]_{\phi}$-module. Assume that $\operatorname{Tor}_{d}^{A}(k, M)$ is a torsion free $k[X]$-module. Then $\operatorname{Tor}_{0}^{A}(k, M)$ is infinite-dimensional over $k$.
Proof By Lemma [2.2, we can find an increasing sequence of sub- $A[X]_{\phi}$-modules $\left(M_{i}\right)_{i \geq 0}$, a sequence of finite-dimensional $k$-vector spaces $\left(V_{i}\right)_{i \geq 0}$ such that there exist isomorphisms $M_{i+1} / M_{i} \simeq$ $A[X]_{\phi} \otimes_{A} V_{i}$ of $A[X]_{\phi}$-modules with $M_{0}=0$, and if we let $\widetilde{M}=\cup_{i} M_{i}$, then $\operatorname{Tor}_{d}^{A}(k, M)_{\text {tors }} \simeq$ $\operatorname{Tor}_{d}^{A}(k, M / \widetilde{M})$. Thus $\operatorname{Tor}_{d}^{A}(k, M / \widetilde{M})=0$ by assumptions. Hence $M=\widetilde{M}$ by Lemma 1.8 in [16]. Since $M$ is finitely generated, there exists a minimal $n \in \mathbb{N}$ such that $M=M_{n}$. Since $M$ is non-zero, we have $n \geq 1$ and $M_{n} \neq M_{n-1}$. We have a surjection

$$
M \rightarrow M / M_{n-1} \simeq A[X]_{\phi} \otimes_{A} V_{n-1} .
$$

Thus we have a surjection

$$
\operatorname{Tor}_{0}^{A}(k, M) \rightarrow \operatorname{Tor}_{0}^{A}\left(k, A[X]_{\phi} \otimes_{A} V_{n-1}\right)
$$

But by Proposition 1.4 and Example 1.6 in [16], $\operatorname{Tor}_{0}^{A}\left(k, A[X]_{\phi} \otimes_{A} V_{n-1}\right) \simeq k[X] \otimes \operatorname{Tor}_{0}^{A}\left(k, V_{n-1}\right)$ is a free $k[X]$-module of $\operatorname{rank} \operatorname{dim}_{k} V_{n-1}$. Assume that $\operatorname{Tor}_{0}^{A}(k, M)$ is finite-dimensional over $k$. Then $V_{n-1}$ is zero by the surjection above. This contradicts that $M_{n} \neq M_{n-1}$. Hence $\operatorname{Tor}_{0}^{A}(k, M)$ is infinitedimensional over $k$.
Lemma 3.2. Let $M$ be a smooth, finitely presented $A[X]_{\phi^{-}}$module and $N$ be a non-zero sub- $A[X]_{\phi^{-}}$ module of $M$. Assume that $M / N$ is finitely presented and admissible, and $\operatorname{Tor}_{d}^{A}(k, N)$ is torsion free. Then $\operatorname{Tor}_{0}^{A}(k, M)$ is infinite-dimensional over $k$.
Proof Since $M / N$ and $M$ are finitely presented, by the coherence of $A[X]_{\phi}$ (Proposition 1.3, [8]), $N$ is of finite presentation. Thus by Lemma 3.1, $\operatorname{Tor}_{0}^{A}(k, N)$ is infinite-dimensional over $k$. Consider the long exact sequence

$$
\cdots \rightarrow \operatorname{Tor}_{1}^{A}(k, M / N) \rightarrow \operatorname{Tor}_{0}^{A}(k, N) \rightarrow \operatorname{Tor}_{0}^{A}(k, M) \rightarrow \operatorname{Tor}_{0}^{A}(k, M / N) \rightarrow 0
$$

Since $M / N$ is admissible, by Corollary 1.12 in [16], $\operatorname{Tor}_{1}^{A}(k, M / N)$ and $\operatorname{Tor}_{0}^{A}(k, M / N)$ are finitedimensional over $k$. Since $\operatorname{Tor}_{0}^{A}(k, N)$ is infinite-dimensional over $k$, so is $\operatorname{Tor}_{0}^{A}(k, M)$.

Definition 3.3. A smooth representation $\pi$ of $G$ is called of finite presentation if there exists an irreducible smooth representation $\sigma$ of $K Z$ and a surjection

$$
i n d_{K Z}^{G} \sigma \rightarrow \pi
$$

such that the kernel is finitely generated as a $k[G]$-module.
Remark 3.4. By Proposition 4.4 in [11], if $\pi$ is of finite presentation, then for all smooth finitedimensional sub-KZ-representation $\sigma$ of $\pi$ which generates the $G$-representation $\pi$, the kernel of the surjection ind ${ }_{K Z}^{G} \sigma \rightarrow \pi$ is finitely generated as a $k[G]$-module.
Remark 3.5. If $F=\mathbb{Q}_{p}$, then by the classifications in [3] and [4], any irreducible representation of $G L_{2}\left(\mathbb{Q}_{p}\right)$ with central character is of finite presentation.

Assume $\pi$ is a smooth irreducible representation of $G$ with central character, and $\sigma \subset \pi$ is an irreducible smooth sub- $K Z$-representation. Let $I^{+}(\pi, \sigma):=\left(\begin{array}{cc}\varpi^{\mathbb{N}} & \mathcal{O} \\ & 1\end{array}\right) \sigma \subset \pi$ be the $A[X]_{\phi}$-submodule of $\pi$ generated by $\sigma$. Then $I^{+}(\pi, \sigma)$ is the image of $I_{\geq 0}(\sigma)$ in $\pi$ via the map ind ${ }_{K Z}^{G} \sigma \rightarrow \pi$. We recall the following result of Yongquan Hu.

Theorem 3.6 ([11], Theorem 1.3). If $\pi$ is of finite presentation, then $I^{+}(\pi, \sigma)^{U}$ is a finite-dimensional $k$-vector space.

We will prove the following theorem in $\S 4$
Theorem 3.7. The $A$-module $L(\sigma)$ is not admissible if $\left[F: \mathbb{Q}_{p}\right] \geq 2$. In particular, the $k[X]$-module $\operatorname{Tor}_{d}^{A}(k, L(\sigma))$ is not torsion.

Now assuming Theorem 3.7 we prove the main theorem.
Theorem 3.8. If $\pi$ is a smooth supersingular representation of $G L_{2}(F)$ with central character, then $\pi$ is not of finite presentation when $\left[F: \mathbb{Q}_{p}\right] \geq 2$.

Proof We can find a surjection $\operatorname{ind}_{K Z}^{G}(\sigma) /(T) \rightarrow \pi$ for some irreducible smooth sub- $K Z$-representation $\sigma$ of $\pi$ by the definition of supersingular representations. Let $I^{+}(\pi, \sigma)$ be the $A[X]_{\phi}$-submodule of $\pi$ generated by $\sigma$ and let $M(\pi, \sigma)$ be the $A[X]_{\phi_{2}}$-submodule of $\pi$ generated by $\sigma$. Then $M(\pi, \sigma) \subset$ $I^{+}(\pi, \sigma)$. The map of $A[X]_{\phi_{2}}$-modules $I_{\geq 0}^{e}(\sigma) \hookrightarrow \operatorname{ind}_{K Z}^{G} \sigma \rightarrow \pi$ factors through $L(\sigma) \rightarrow \pi$ with image $M(\pi, \sigma)$. Let $N(\pi, \sigma)$ be the kernel of the morphism $L(\sigma) \rightarrow M(\pi, \sigma)$ of $A[X]_{\phi_{2}}$-modules. We have an exact sequence

$$
0 \rightarrow \operatorname{Tor}_{d}^{A}(k, N(\pi, \sigma)) \rightarrow \operatorname{Tor}_{d}^{A}(k, L(\sigma)) \rightarrow \operatorname{Tor}_{d}^{A}(k, M(\pi, \sigma)) .
$$

By Proposition 2.1, $\operatorname{Tor}_{d}^{A}(k, L(\sigma))_{\text {tors }}$ is generated by the image of $\sigma^{U} \simeq \operatorname{Tor}_{d}^{A}(k, \sigma)$ via the map $\sigma \rightarrow I_{\geq 0}^{e}(\sigma) \rightarrow L(\sigma)$. The non-zero composition map $\sigma \rightarrow L(\sigma) \rightarrow M(\pi, \sigma)$ induces morphisms $\operatorname{Tor}_{d}^{A}(k, \sigma) \xrightarrow{\sim} \operatorname{Tor}_{d}^{A}(k, L(\sigma))_{\text {tors }} \rightarrow \operatorname{Tor}_{d}^{A}(k, M(\pi, \sigma))$. The composition $\sigma \rightarrow M(\pi, \sigma)$ is injective since $\sigma$ is irreducible. Since $\operatorname{Tor}_{d}^{A}(k,-)$ is left exact, we get an injection $\operatorname{Tor}_{d}^{A}(k, L(\sigma))_{\text {tors }} \hookrightarrow$ $\operatorname{Tor}_{d}^{A}(k, M(\pi, \sigma))$. Then $\operatorname{Tor}_{d}^{A}(k, N(\pi, \sigma))$ must be a torsion free $k[X]$-module.

Now if $\pi$ is finitely presented, $M(\pi, \sigma) \subset I^{+}(\pi, \sigma)$ is admissible by Hu's result (Theorem 3.6). Since $M(\pi, \sigma)$ is generated by $\sigma$, it is a finitely generated $A[X]_{\phi_{2}}$-module. Moreover, the proof of Theorem 2.24 in [16] shows that $M(\pi, \sigma)$ is of finite presentation $(M(\pi, \sigma)$ is stable under the action of $H=\left(\begin{array}{cc}\mathcal{O}^{\times} & \\ & 1\end{array}\right)$, then use Lemma 2.6 in [16]). If $N(\pi, \sigma) \neq 0$, then all the assumptions in Lemma 3.2 are satisfied if we take $M=L(\sigma)$ and $N=N(\pi, \sigma)$. Remark that here $L(\sigma), N(\pi, \sigma)$ are modules over the coherent ring $A[X]_{\phi_{2}}$ rather than $A[X]_{\phi}$, but Lemma 3.2 holds true for $A[X]_{\phi_{2}}$. Thus by Lemma 3.2, $\operatorname{Tor}_{0}^{A}(k, L(\sigma))$ has infinite dimension over $k$, which contradicts that $\operatorname{Tor}_{0}^{A}(k, L(\sigma))=0$ (Proposition 2.1)! Hence $N(\pi, \sigma)=0$. Then $L(\sigma) \simeq M(\pi, \sigma)$ is admissible. This contradicts Theorem 3.7! Hence $\pi$ is not of finite presentation.

## 4. NON-ADMISSIBILITY

Assume $\sigma=\operatorname{Sym}^{\vec{r}} \otimes(\chi \circ \operatorname{det})$, where $\vec{r}=\left(r_{0}, \cdots, r_{f-1}\right)$ such that $0 \leq r_{0}, \cdots, r_{f-1} \leq p-1$, is an irreducible representation of $K Z$ with $\varpi \in Z$ acting on $\sigma$ as a scalar $\nu \in k^{\times}$. Recall that

$$
R_{1}(\sigma)=\bigoplus_{\mu \in \mathbb{F}_{q}}\left[\left(\begin{array}{cc}
\varpi & {[\mu]} \\
& 1
\end{array}\right), \sigma\right], \quad R_{2}(\sigma)=\bigoplus_{\mu, \lambda \in \mathbb{F}_{q}}\left[\left(\begin{array}{cc}
\varpi^{2} & {[\mu]+\varpi[\lambda]} \\
1
\end{array}\right), \sigma\right] .
$$

For any $\mu \in \mathbb{F}_{q}, u_{\vec{i}} \in k, \vec{i} \in \mathbb{Z}^{f}, \overrightarrow{0} \leq \vec{i} \leq \vec{r}$, the operators $T_{ \pm}$act on $\left[\left(\begin{array}{cc}\varpi & {[\mu]} \\ & 1\end{array}\right), \sum_{0 \leq \vec{i} \leq \vec{r}} u_{\vec{i}} x^{\vec{r}-\vec{i}} y^{\vec{i}}\right] \in$ $R_{1}(\sigma)$ by the formulas (see (2.1)):

\varpi^{2} & {[\mu]+\varpi[\lambda]} \\
1
\end{array}\right),\left(\sum_{0 \leq \vec{i} \leq \vec{r}} u_{\vec{i}}(-\lambda)^{\vec{i}}\right) x^{\vec{r}}\right]  \tag{4.1}\\
& T_{-}\left(\left[\left(\begin{array}{cc}
\varpi & {[\mu]} \\
& 1
\end{array}\right), \sum_{0 \leq \vec{i} \leq \vec{r}} u_{\vec{i}} x^{\vec{r}-\vec{i}} y^{\vec{i}}\right]\right)=\nu\left[\left(\begin{array}{cc}
1 & \\
& 1
\end{array}\right), u_{\vec{r}} \otimes_{j=0}^{f-1}\left(\mu^{p^{j}} x_{j}+y_{j}\right)^{r_{j}}\right] . \tag{4.2}
\end{align*}

Proof of Theorem 3.7 We need to prove that $L(\sigma)^{U}$ is infinite-dimensional over $k$. By Proposition 2.1 , the torsion part of the $k[X]$-module $\operatorname{Tor}_{d}^{A}(k, L(\sigma)) \simeq L(\sigma)^{U}$ has only dimension 1. If $\operatorname{dim}_{k} L(\sigma)^{U} \geq 2$, the free part of the $k[X]$-module $\operatorname{Tor}_{d}^{A}(k, L(\sigma))$ can not be zero and then $\operatorname{Tor}_{d}^{A}(k, L(\sigma))$ is infinitedimensional over $k$ since a non-zero free $k[X]$-module is infinite-dimensional over $k$. So we only need to prove that $\operatorname{dim}_{k} L(\sigma)^{U} \geq 2$ to show that $L(\sigma)$ is not an admissible $A$-module. We will prove
Lemma 4.1. If $\left[F: \mathbb{Q}_{p}\right] \geq 2$, there exists an element $g \in R_{2}(\sigma)$ such that $g \notin T_{+} R_{1}(\sigma)$ and $u g-g \in T R_{1}^{\prime}(\sigma)$ for any $u \in U$, where $R_{1}^{\prime}(\sigma)$ is the kernel of $\left.T_{-}\right|_{R_{1}(\sigma)}$.

Now assume there exists an element $g$ as in Lemma 4.1. Then the image of $g$ in $L(\sigma)$ lies in $L(\sigma)^{U}$ since $u g-g \in T R_{1}^{\prime}(\sigma) \subset T I_{\geq 1}^{o}(\sigma)$ which is zero in $L(\sigma)=I_{\geq 0}^{e}(\sigma) / T I_{\geq 1}^{o}(\sigma)$ for any $u \in U$. We claim that the image of $g$ doesn't lie in the image of $R_{0}(\sigma)$ in $L(\sigma)$. Otherwise there exist $a \in R_{0}(\sigma), x \in I_{\geq 1}^{o}(\sigma)$ such that $g-a=T x$. Assume $x=\sum_{k \in \mathbb{N}} x_{2 k+1}$, where each $x_{2 k+1} \in$ $R_{2 k+1}(\sigma)$ and there are only finitely many $k$ such that $x_{2 k+1} \neq 0$. Since $g \notin T_{+} R_{1}(\sigma), g \neq 0$ and we may assume $x \neq 0$. Let $k_{0}$ be the maximal integer such that $x_{2 k_{0}+1} \neq 0$. Then $T x=T_{-}\left(x_{1}\right)+$ $\sum_{k=0}^{k_{0}}\left(T_{+}\left(x_{2 k+1}\right)+T_{-}\left(x_{2 k+3}\right)\right) \in R_{0}(\sigma) \oplus\left(\oplus_{k=0}^{k_{0}} R_{2 k+2}(\sigma)\right)$. Since $T x=g-a \in R_{0}(\sigma) \oplus R_{2}(\sigma)$, if $k_{0} \neq 0, T_{+}\left(x_{2 k_{0}+1}\right)=0 \in R_{2 k_{0}+2}(\sigma)$. This contradicts that $T_{+}$is injective (Lemma 2.12 in [16]) and $x_{2 k_{0}+1}$ is not 0 . If $k_{0}=0$, then $g=T_{+}\left(x_{1}\right) \in T_{+} R_{1}(\sigma)$, which contradicts our choice of $g$ in the Lemma 4.1. Hence the image of $g$ in $L(\sigma)$ doesn't lie in the image of $R_{0}(\sigma)$ in $L(\sigma)$. Thus the image of $\sigma^{U}$ and $g$ in $L(\sigma)$ span a two-dimensional subspace of $L(\sigma)^{U}$. This proves that $\operatorname{dim}_{k}(L(\sigma)) \geq 2$ and $L(\sigma)$ is not admissible.

Before the proof of Lemma 4.1 , we remark the following simple facts.
Lemma 4.2. Let $F=\sum_{i} a_{i} X^{i} \in k[X]$ be a polynomial of degree no more than $q-1$, then $\sum_{t \in \mathbb{F}_{q}} F(t)=$ $-a_{q-1}$.
Lemma 4.3 ([15], Lemma 2.2). For any $a, b \in \mathbb{F}_{q},[a]+[b] \equiv[a+b]+\varpi^{e}[P(a, b)] \bmod \varpi^{e+1}$, where $P(a, b)=\frac{a^{q^{e}}+b^{q^{e}}-(a+b)^{q^{e}}}{\omega^{e}}$.
Proof of Lemma 4.1 Our method is to find a concrete required element $g$ in all possible cases. We remark firstly that by (4.1), $T_{+} R_{1}(\sigma)$ is spanned (over $k$ ) by elements

where $\overrightarrow{0} \leq \vec{i} \leq \vec{r}$ and $\mu \in \mathbb{F}_{q}$. Moreover $\sum_{\lambda \in \mathbb{F}_{q}}\left[\left(\begin{array}{cc}\varpi^{2} & {[\mu]+\varpi[\lambda]} \\ 1\end{array}\right), \lambda^{\vec{i}} x^{\vec{r}}\right]$ lies in $T_{+} R_{1}^{\prime}(\sigma)$ if $\vec{i}<\vec{r}$ by (4.1) and (4.2), here $\vec{i}<\vec{r}$ means $\vec{i} \leq \vec{r}$ and $\vec{i} \neq \vec{r}$. Since $T_{ \pm}$are $U$-equivariant, $R_{1}^{\prime}(\sigma)$ and $T_{+} R_{1}^{\prime}(\sigma)$ are stable under the action of $U$. Moreover, $\alpha^{3} U \alpha^{-3}=\left(\begin{array}{cc}1 & \varpi^{3} \mathcal{O} \\ & 1\end{array}\right)$ acts trivially on $R_{2}(\sigma)$.

1) Assume $F$ is ramified over $\mathbb{Q}_{p}$ with $e \geq 2$. We have

by Lemma 4.3
If $\operatorname{dim}_{k}(\sigma)>1$, there exists $j_{0}$ such that $r_{j_{0}} \geq 1$. Let $\overrightarrow{i^{\prime}}=\left(i_{0}^{\prime}, \cdots, i_{f-1}^{\prime}\right) \in \mathbb{Z}^{f}$ where $i_{j}^{\prime}=0$ if $j \neq j_{0}$ and $i_{j_{0}}^{\prime}=1$. Then $\overrightarrow{i^{\prime}} \leq \vec{r}$. We take

g=\sum_{\mu, \lambda \in \mathbb{F}_{q}}\left[\left(\begin{array}{cc}
\varpi^{2} & {[\mu]+\varpi[\lambda]} \\
& 1
\end{array}\right), x^{\vec{r}-\vec{i}^{\prime}} y^{i^{\prime}}\right] .
$$

Then $g \notin T_{+} R_{1}(\sigma)$. For $a \in \mathbb{F}_{q}$, we calculate that

Since $\left(\begin{array}{cc}1 & \varpi[a] \\ & 1\end{array}\right),\left(\begin{array}{cc}1 & {[a]+\varpi^{2}[b]} \\ 1\end{array}\right), a, b \in \mathbb{F}_{q}$ generate $U / \alpha^{3} U \alpha^{-3}$, we see that $g \in\left(R_{2}(\sigma) / T_{+} R_{1}^{\prime}(\sigma)\right)^{U}$ and $g \notin T_{+} R_{1}(\sigma)$.

If $\operatorname{dim}_{k}(\sigma)=1, \vec{r}=\overrightarrow{0}$. We take $g=\sum_{\mu, \lambda \in \mathbb{F}_{q}}\left[\left(\begin{array}{cc}\varpi^{2} & {[\mu]+\varpi[\lambda]} \\ 1\end{array}\right), \lambda\right]$. Then $g \notin T_{+} R_{1}(\sigma)$ as $T_{+} R_{1}(\sigma)$ is spanned by $\sum_{\lambda \in \mathbb{F}_{q}}\left[\left(\begin{array}{cc}\varpi^{2} & {[\mu]+\varpi[\lambda]} \\ 1\end{array}\right), 1\right]$ by (4.1). Then for any $a, b, c \in \mathbb{F}_{q}$,

2) Assume $F$ is unramified. Then $f>1, \varpi=p$. By the theory of Witt vectors, there exist polynomials $P_{1}, P_{2} \in \mathbb{Z}[x, y]$ such that for any $a, b \in \mathbb{F}_{q},[a]+[b] \equiv[a+b]+p\left[P_{1}(a, b)\right]+p^{2}\left[P_{2}(a, b)\right]$ $\bmod p^{3}$. Since $P_{1}(a, b)=F\left(a^{1 / p}, b^{1 / p}\right)=F\left(a^{p^{f-1}}, b^{p^{f-1}}\right)$ where $F(x, y)=\frac{x^{p}+y^{p}-(x+y)^{p}}{p}$, we can assume $P_{1}$ is a polynomial of degree no more than $p^{f-1}(p-1)$ in each variable (or see Lemma4.3).

If there exists $j_{0} \in\{0, \cdots, f-1\}$ such that $r_{j_{0}}+1 \leq p-1$ (i.e. $\vec{r} \neq(p-1, \cdots, p-1)$ ), we take

Then $\lambda^{p^{j_{0}}\left(r_{j_{0}}+1\right)}=\sum_{\vec{i} \leq \vec{r}} u_{\vec{i}}(-1)^{\vec{i}} \lambda^{\vec{i}}$ for every $\lambda \in \mathbb{F}_{q}$. This is impossible since the polynomial $X^{p^{j}\left(r_{j_{0}}+1\right)}-\sum_{0 \leq \vec{i} \leq \vec{r}} u_{\vec{i}}(-1)^{\vec{i}} X^{\sum_{0 \leq j \leq f-1} p^{j} i_{j}} \in k[X]$ is not zero and has degree no more than $q-2$ (by $f>1$ and $\vec{r} \neq(p-1, \cdots, p-1)$ ). For any $a, b, c \in \mathbb{F}_{q}$, we calculate that (using $x^{\vec{r}} \in \sigma^{U}$ and
$\left.[a]+[b] \equiv[a+b]+p\left[P_{1}(a, b)\right] \bmod p^{2}\right)$

Write $\left(\lambda-b-P_{1}(a, \mu-a)\right)^{p^{j_{0}}\left(r_{j_{0}}+1\right)}-\lambda^{p^{j_{0}}\left(r_{j_{0}}+1\right)}=\sum_{0 \leq i \leq r_{j_{0}}} g_{i}(\mu)(-\lambda)^{p^{j_{0} i}}$, where $g_{i}(\mu)$ are polynomials in $\mu$ (depending also on $a, b$ ).

First assume $p^{j_{0}} r_{j_{0}} \neq r=\sum_{j=0}^{f-1} r_{j} p^{j}$. For any $0 \leq i \leq r_{j_{0}}$, let $\vec{i}_{j_{0}}=\left(i_{1}, \cdots, i_{f-1}\right) \in \mathbb{Z}^{f-1}$ such that $i_{j}=0$ if $j \neq j_{0}$ and $i_{j_{0}}=i$. Then $\vec{i}_{j_{0}}<\vec{r}$ for any $i \leq r_{j_{0}}$. Hence the last term in (4.3)

Otherwise $r=p^{j^{\prime}} r_{j^{\prime}}$ for some $j^{\prime}$. If $\vec{r} \neq 0$, we can choose in the beginning $j_{0} \neq j^{\prime}$ with $r_{j_{0}}=0$ since $f \geq 2$ and $r_{j_{0}}+1=1 \leq p-1$. Then $0=p^{j_{0}} r_{j_{0}} \neq r$, we return to the previous case and we can find a required $g$. If $\vec{r}=0$, we can let $j_{0}=0$, then $r_{j_{0}}=0$. Then the last term in (4.3) is $\sum_{\mu, \lambda \in \mathbb{F}_{q}}\left[\left(\begin{array}{cc}p^{2} & {[\mu]+p[\lambda]} \\ 1\end{array}\right), g_{0}(\mu)\right]=T_{+}\left(\sum_{\mu \in \mathbb{F}_{q}}\left[\left(\begin{array}{cc}p & {[\mu]} \\ & 1\end{array}\right), g_{0}(\mu)\right]\right)$. We have

(3) Now we remain the case when $F$ is unramified over $\mathbb{Q}_{p}, f \geq 2$ and $\vec{r}=(p-1, \cdots, p-1)$. Let $\overrightarrow{i^{\prime}}=\left(i_{0}^{\prime}, \cdots, i_{f-1}^{\prime}\right)$ where $i_{j}^{\prime}=0$ if $j \neq 0$ and $i_{0}^{\prime}=1$. Take

For any $a, b \in \mathbb{F}_{q}$, we calculate that (using $\left(\begin{array}{ll}1 & a \\ & 1\end{array}\right) x^{\vec{r}-\vec{i}^{\prime}} y^{\overrightarrow{i^{\prime}}}=a x^{\vec{r}}+$ $\left.x^{\vec{r}-\vec{i}^{\prime}} y^{i^{\prime}}\right)$

$P_{1}(a, \lambda-a)+b$ is a polynomial of $\lambda$ with degree no more than $p^{f-1}(p-1)<q-1$, the last term lies in $T_{+} R_{1}^{\prime}$ by the remark at the beginning $\left(\sum_{\lambda \in \mathbb{F}_{q}}\left[\left(\begin{array}{cc}p^{2} & {[\mu]+\varpi[\lambda]} \\ 1\end{array}\right), \lambda^{\vec{i}} x^{\vec{r}}\right]\right.$ lies in $T_{+} R_{1}^{\prime}(\sigma)$ if $\left.\vec{i}<\vec{r}\right)$. For any $a \in \mathbb{F}_{q}$,

$\left(P_{2}(a, \mu-a)+P_{1}\left(\lambda-P_{1}(a, \mu-a), P_{1}(a, \mu-a)\right)\right)$ is a polynomial of $\lambda$ of degree no more than $p^{f-1}(p-1)<q-1$. By the remark at the beginning, the last term lies in $T_{+} R_{1}^{\prime}(\sigma)$.

Since $\left(\begin{array}{cc}1 & {[a]} \\ & 1\end{array}\right),\left(\begin{array}{cc}1 & p[b]+p^{2}[c] \\ 1\end{array}\right), a, b, c \in \mathbb{F}_{q}$ generate $U / \alpha^{3} U \alpha^{-3}, g \in\left(R_{2}(\sigma) / T_{+} R_{1}^{\prime}(\sigma)\right)^{U}$.
Thus we have found a required $g$.
Remark 4.4. Those $g$ in Lemma 4.1] have been found for many cases in [4], [15], [14] and [9].
Corollary 4.5. For any smooth irreducible representation $\sigma$ of $K Z$, the universal supersingular representation of $G$ ind ${ }_{K Z}^{G} \sigma / T\left(\right.$ ind $\left._{K Z}^{G} \sigma\right)$ is not admissible if $F \neq \mathbb{Q}_{p}$.

Proof Same as Corollary 2.21 in [16], using Proposition 4.5 in [8].
