METASTABILITY PHENOMENA IN TWO-DIMENSIONAL RECTANGULAR LATTICES WITH NEAREST-NEIGHBOUR INTERACTION

Abstract. We study analytically the dynamics of two-dimensional rectangular lattices with periodic boundary conditions. We consider anisotropic initial data supported on one low-frequency Fourier mode. We show that, in the continuous approximation, the resonant normal form of the system is given by integrable PDEs. We exploit the normal form in order to prove the existence of metastability phenomena for the lattices. More precisely, we show that the energy spectrum of the normal modes attains a distribution in which the energy is shared among a packet of low-frequencies modes; such distribution remains unchanged up to the time-scale of validity of the continuous ap-

1. Introduction

In this paper we present an analytical study of the dynamics of two-dimensional rectangular lattices with nearest-neighbour interaction and periodic boundary conditions, for initial data with only one lowfrequency Fourier mode initially excited. We give some rigorous results concerning the relaxation to a

metastable state, in which energy sharing takes place among low-frequency modes only.

The study of metastability phenomena for lattices started with the numerical result by Fermi, Pasta and Ulam (FPU) [FPU95], who investigated the dynamics of a one-dimensional chain of particles with nearest neighbour interaction. In the original simulations all the energy was initially given to a single low-frequency Fourier mode with the aim of measuring the time of relaxation of the system to the 'thermal equilibrium' by looking at the evolution of the Fourier spectrum. Classical statistical mechanics prescribes that the energy spectrum corresponding to the thermal equilibrium is a plateau (the so-called theorem of equipartition of energy). Despite the authors believed that the approach to such an equilibrium would have occurred in a short time-scale, the outcoming Fourier spectrum was far from being flat and they observed two features of the dynamics that were in contrast with their expectations: the lack of thermalization displayed by the energy spectrum and the recurrent behaviour of the dynamics.

Both from a physical and a mathematical point of view, the studies on FPU-like systems have a long and active history: a concise survey of this vast literature is discussed in the monograph [Gal07]. For a more recent account on analytic results on the 'FPU paradox' we refer to [BCMM15].

In particular, we mention the papers [BP06] and [Bam08], in which the authors used the techniques of canonical perturbation theory for PDEs in order to show that the FPU α model (respectively, β model) can be rigorously described by a system of two uncoupled KdV (resp. mKdV) equations, which are obtained as a resonant normal form of the continuous approximation of the FPU model; moreover, this result allowed to deduce a rigorous result about the energy sharing among the Fourier modes, up to the time-scales of validity of the approximation. If we denote by N the number of degrees of freedom for the lattice and by $\mu \sim \frac{1}{N} \ll 1$ the wave-number of the initially excited mode, if we assume that the specific energy $\epsilon \sim \mu^4$ (resp. $\epsilon \sim \mu^2$ for the FPU β model), then the dynamics of the KdV (resp. mKdV) equations approximates the solutions of the FPU model up to a time of order $\mathcal{O}(\mu^{-3})$. However, the relation between the specific energy and the number of degrees of freedom implies that the result does not hold in the thermodynamic limit regime, namely for large N and for fixed specific energy ϵ (such a regime is the one which is relevant for statistical mechanics).

Unlike the extensive research concerning one-dimensional systems, it seems to the authors that the behaviour of the dynamics of two-dimensional lattices is far less clear; it is expected that the interplay between the geometry of the lattice and the specific energy regime could lead to different results.

Benettin and collaborators [BVT80] [Ben05] [BG08] studied numerically a two-dimensional FPU lattice with triangular cells and different boundary conditions in order to estimate the equipartition time-scale. They found out that in the thermodynamic limit regime the equipartition is reached faster than in the one-dimensional case. The authors decided not to consider model with square cells in order to have a spectrum of linear frequencies which is different with respect to the one of the one-dimensional model; they also added (see [BG08], Section B.(iii))

There is a good chance, however, that models with square lattice, and perhaps a different potential so as to avoid instability, behave differently from models with triangular lattice, and are instead more similar to one-dimensional models. This would correspond to an even stronger lack of universality in the two-dimensional FPU problem.

Up to the authors' knowledge, the only analytical results on the dynamics of two-dimensional lattices in this framework concern the existence of breathers [Wat94] [BW06] [BW07] [YWSC09] [BPP10].

In this paper we study two-dimensional rectangular lattices with $(2N_1+1)\times(2N_2+1)$ sites, square cell, nearest-neighbour interaction and periodic boundary conditions, and we show the existence of metastability phenomena as in [BP06]. More precisely, if we denote by $\mu\ll 1$ the wave-number of the Fourier mode initially excited and by σ the ratio between the sides of the lattice, we obtain for a 2D Electrical Transmission lattice (ETL) either a system of two uncoupled KP-II equations for $\mu\ll 1$ and $\sigma=2$, or a system of two uncoupled KdV equations for $\mu\ll 1$ and $2<\sigma<7$ as a resonant normal form for the continuous approximation of the lattice, while for the 2D Klein-Gordon lattice with

quartic defocusing nonlinearity we obtain a one-dimensional cubic defocusing NLS equation for $\mu \ll 1$ and $1 < \sigma < 7$. Since all the above PDEs are integrable, we can exploit integrability to deduce a mathematically rigorous result on the formation of the metastable packet.

Up to the authors' knowledge, this is the first analytical result about metastable phenomena in two-dimensional Hamiltonian lattices with periodic boundary conditions; in particular, this is the first rigorous result for two-dimensional lattices in which the dynamics of the lattice in a two-dimensional regime is described by a system of two-dimensional integrable PDEs.

Some comments are in order:

- i. the time-scale of validity of our result is of order $\mathcal{O}(\mu^{-3})$ for the 2D ETL lattice, and of order $\mathcal{O}(\mu^{-2})$ for the 2D Klein-Gordon lattice;
- ii. the ansatz about the small amplitude solutions gives a relation between the specific energy of the system ϵ and the wave-number $\mu \sim \frac{1}{N_1}$ of the Fourier mode initially excited. More precisely, we obtain $\epsilon \sim \mu^4$ for the 2D ETL lattice as in [BP06], and $\epsilon \sim \mu^2$ for the 2D Klein-Gordon lattice. This implies that the result does not hold in the thermodynamic limit regime;
- iii. our result can be easily generalized to higher-dimensional lattices, such as the physical case of three-dimensional rectangular lattices with cubic cells;
- iv. depending on the geometry of the lattice which is encoded in the parameter σ , the effective dynamics is described by one-dimensional PDEs for highly anisotropic lattices and by two-dimensional PDEs for low values of σ . The normal form equation of the ETL lattices are not integrable for $1 \le \sigma < 2$ and they are integrable if $\sigma > 2$. The edge case $\sigma = 2$ is very sensitive to the potential: if the cubic term of the potential is present, then the normal form equation it is the integrable two-dimensional KP-II equation, otherwise it is a non-integrable modification of the mKdV equation. On the other hand, the normal form equation for KG lattices is integrable for $\sigma > 1$, thus also for less anisotropic lattices;
- v. the upper bounds for σ in the KdV regime and in the NLS regime come from a technical assumption in the approximation results (see Proposition 6.5, Proposition 6.2 and Proposition 6.9). The approximation of solutions for the lattice with solutions of integrable PDEs in one-dimensional lattices was obtained through a detailed analysis in order to bound the error, and this is also the case for two-dimensional lattices, (see Proposition 6.5, Proposition 6.9, Appendix C and Appendix E), where one has to do very careful estimates in order to bound the different contributions to the error.

To prove our results we follow the strategy of [BP06]. The first step consists in the approximation of the dynamics of the lattice with the dynamics of a continuous system. This step gives also a natural perturbative order and, since $\sigma > 1$, the leading term is given by a PDE in only one space variable. The effect of the second dimension is of order μ^{σ} , and thus it appears at the second perturbative order for low values of σ and at higher perturbative orders for higher values. In this sense one expects that for higher values of σ the normal form equations are one-dimensional, but it is not trivial that the effect of the second dimension do not destroy integrability. For this reason, as a second step we perform a normal form canonical transformation and we obtain that the effective dynamics is given by a system of integrable PDEs (KdV, KP-II, NLS depending on the lattice and the relation between N_1 and N_2). Next, we exploit the dynamics of these integrable PDEs in order to construct approximate solutions of the original discrete lattices, and we estimate the error with repect to a true solution with the corresponding initial datum. Finally, we use the known results about the dynamics of the above mentioned integrable PDEs in order to estimate the specific energies for the approximate solutions of the original lattices.

The novelties of this work are: on the one side, a mathematically rigorous proof of the approximation of the dynamics of the 2D ETL lattice by the dynamics of certain integrable PDEs (among these integrable PDEs, there is one which is *genuinely* two-dimensional, the KP-II equation) and of the dynamics of the 2D KG lattice by the dynamics of the one-dimensional nonlinear Schrödinger equation; on the other side, there are two technical differences with respect to previous works, namely the normal form theorem (which is a variant of the technique used in [BCP02] [Bam05] [Pas19]) and the estimates for bounding the error between the approximate solution and the true solution of the lattice (which need a

more careful study than the ones appearing in [SW00] [BP06] for the one-dimensional case).

The paper is organized as follows: in Section 2 we introduce the mathematical setting of the models and we state our main results, Theorem 2.1, Theorem 2.5 and Theorem 2.7. In Section 3 we state an abstract Averaging Theorem, which we prove in Section 3.2. In Section 4 we apply the averaging Theorem to the two-dimensional lattices, deriving the integrable approximating PDEs in the different regimes. In Section 5 we review some results about the dynamics of the normal form equation. In Section 6 we use the normal form equations in order to construct approximate solutions (see Proposition 6.5, Proposition 6.2 and Proposition 6.9), and we estimate the difference with respect to the true solutions with corresponding initial data in Proposition 6.6, Proposition 6.3 and Proposition 6.10. In Appendix A we prove the technical Lemma 3.6; in Appendix B we prove Propositions 6.2 and 6.5; in Appendix C we prove Propositions 6.6 and 6.3; in Appendix D we prove Proposition 6.9; in Appendix E we prove Proposition 6.10.

Relevant notations. For the sake of clarity we provide a short explanation of some of the symbols we use in the paper. With $\mathbb{Z}^2_{N_1,N_2}$ we denote $\frac{\mathbb{Z}}{2N_1+1} \times \frac{\mathbb{Z}}{2N_2+1} = \{(j_1,j_2) \in \mathbb{Z}^2 : |j_1| \leq N_1, |j_2| \leq N_2\}$. We will denote by $k = (k_1,k_2) \in \mathbb{Z}^2$ the index of the wave-vector; we denote by $\kappa = (\kappa_1,\kappa_2)$ the specific wave vector defined in (9). In Section 6 and in the appendices we will denote by $K = (K_1, K_2)$ the index of the wave-vector with $|K_1| \leq N_1$ and $|K_2| \leq N_2$. With N_r (r=1,2) we denote the half-length of the rectangular lattice and with $N := (2N_1 + 1)(2N_2 + 1)$ we denote the total number of sites.

Space variables are denoted by x_r (with r=1,2) with $x_r \in [-N_r, N_r]$ and the rescaled space variables are denoted by y_r with $y_r \in [-1, 1]$.

The Hilbert space $\ell_{\rho,s}^2$ is defined in Definition 3.1 and $B_{\rho,s}(R)$ denotes the open ball of radius R centred in 0, $B_{\rho,s}(R) \subset \ell_{\rho,s}^2$. We also use $\mathcal{H}^{\rho,s} := \ell_{\rho,s}^2 \times \ell_{\rho,s}^2$ and $\mathcal{B}_{\rho,s}(R) := B_{\rho,s}(R) \times B_{\rho,s}(R) \subset \mathcal{H}^{\rho,s}$. We also denote with $|(a,b)| := \sqrt{a^2 + b^2}$ the Euclidean norm of the vector (a,b). We denote with

 $[f] := \int_0^T f \circ \Phi_h^t(y) \frac{dt}{T}$ the time-average of f with respect to Φ_h^t .

In Section 4 we introduce interpolating functions and we denote with Q(t,x) the interpolating function for the lattice variable $Q_j(t)$ and with P(t,x) the interpolating function for the lattice variable $P_j(t)$. We use this little abuse of notation because the former is actually an extension of the latter in the sense that $P_j(t) = P(t, j)$ for every t and j.

The component k of the Fourier transform of the continuous approximation at time t will be denoted by $\hat{Q}(t,k)$ to distinguish it from the k-th component of the Fourier transform of the reticular variable $\hat{Q}_k(t)$. Since for the rescaled functions such as q and p this ambiguity do not hold, we prefer the short notation $\hat{q}_k(\tau)$ and $\hat{p}_k(\tau)$ for their Fourier transform.

In Section 6 we make use of the following abuse of notation: $Q(t) = \xi(\tau)$. This is to avoid the long-writing $Q(t) = \xi(\tau(t))$.

2. Main Results

We consider a periodic two-dimensional rectangular lattice, called ETL lattice, which in the nonperiodic setting has been studied in [BW06], and which can be regarded as a simpler version of a 2D rectangular FPU model. We denote

(1)
$$\mathbb{Z}_{N_1,N_2}^2 := \{ (j_1,j_2) : j_1, j_2 \in \mathbb{Z}, |j_1| \le N_1, |j_2| \le N_2 \};$$

we also write $e_1 := (1,0), e_2 := (0,1)$ and we denote by $N := (2N_1 + 1)(2N_2 + 2)$ the total number of sites of the lattice.

The Hamiltonian describing the ETL lattice is given by

(2)
$$H_{\text{ETL}}(Q, P) = \sum_{j \in \mathbb{Z}_{N_1, N_2}^2} -\frac{1}{2} P_j (\Delta_1 P)_j + (V(Q))_j,$$

(3)
$$(\Delta_1 P)_j := (P_{j+e_1} - 2P_j + P_{j-e_1}) + (P_{j+e_2} - 2P_j + P_{j-e_2}),$$

(4)
$$(V(Q))_j = \frac{Q_j^2}{2} + \alpha \frac{Q_j^3}{3} + \beta \frac{Q_j^4}{4}.$$




FIGURE 1. The dispersion relation for the ETL lattice (2), namely $\pm \omega_k$, $k = (k_1, k_2)$, vs the integer coordinates, for $N_1 = 10$ and $N_2 = 100$.

We refer to (2) as $\alpha + \beta$ model (respectively, β model) if $\alpha \neq 0$ (respectively $\alpha = 0$). With the above Hamiltonian formulation the equations of motion associated to (2) are given by

$$\begin{cases} \dot{Q}_j = -(\Delta_1 P)_j \\ \dot{P}_j = -(V'(Q))_j \end{cases};$$

(5)
$$\ddot{Q}_j = (\Delta_1 V'(Q))_j.$$

We also introduce the Fourier coefficients of Q via the following standard relation,

(6)
$$Q_j(t) := \frac{1}{\sqrt{N}} \sum_{k \in \mathbb{Z}_{N_1, N_2}^2} \hat{Q}_k(t) e^{2\pi i \frac{j \cdot k}{N}}, \qquad j \in \mathbb{Z}_{N_1, N_2}^2,$$

and similarly for P_j . We denote by

(7)
$$E_k := \frac{\omega_k^2 |\hat{P}_k|^2 + |\hat{Q}_k|^2}{2},$$

(8)
$$\omega_k^2 := 4\sin^2\left(\frac{k_1\pi}{2N_1+1}\right) + 4\sin^2\left(\frac{k_2\pi}{2N_2+1}\right),$$

the energy and the square of the frequency of the mode at site $k=(k_1,k_2)\in\mathbb{Z}^2_{N_1,N_2}$ (see Figure 1). For states described by real functions, one has $E_{(k_1,k_2)}=E_{(-k_1,k_2)}$ and $E_{(k_1,k_2)}=E_{(k_1,-k_2)}$ for all $k=(k_1,k_2)$, so we will consider only indexes in

$$\mathbb{Z}^2_{N_1,N_2,+} := \{ (k_1,k_2) \in \mathbb{Z}^2_{N_1,N_2} : k_1,k_2 \ge 0 \}.$$

As is customary in lattices with a large number of degrees of freedom, especially in relation with statistical mechanics, we introduce the *specific wave vector* κ as

(9)
$$\kappa := \kappa(k) = \left(\frac{k_1}{N_1 + \frac{1}{2}}, \frac{k_2}{N_2 + \frac{1}{2}}\right),$$

and the specific energy of the specific normal mode $\kappa = \kappa(k)$ as

(10)
$$\mathcal{E}_{\kappa} := \frac{E_k}{\left(N_1 + \frac{1}{2}\right)\left(N_2 + \frac{1}{2}\right)}.$$

We want to study the behaviour of small amplitude solutions of (5), with initial data in which only one low-frequency Fourier mode is excited.

We assume $N_1 \leq N_2$, and we introduce the quantities

(11)
$$\mu := \frac{2}{2N_1 + 1},$$

(12)
$$\sigma := \log_{N_1 + \frac{1}{2}} \left(N_2 + \frac{1}{2} \right),$$

which play the role of parameters in our construction: we will use them in the asymptotic expansion of the dispersion relation of the continuous approximation of the lattice (see (88)-(89), and (105)-(106)) in order to derive the integrable approximating PDEs in the regimes we are considering.

We study the $\alpha + \beta$ model of (5) in the following regime:

(KP) the weakly transverse regime, where the effective dynamics is described by a system of two uncoupled Kadomtsev-Petviashvili (KP) equation. This corresponds to taking $\mu \ll 1$ and $\sigma = 2$.

From now on, we denote by $\kappa_0 := \left(\frac{1}{N_1 + \frac{1}{2}}, \frac{1}{(N_1 + \frac{1}{2})^{\sigma}}\right) = (\mu, \mu^{\sigma})$. Our main result is the following:

Theorem 2.1. Consider (5) with $\alpha \neq 0$, $\sigma = 2$.

Fix $0 < \gamma < \frac{1}{2}$ and two positive constants C_0 and T_0 , then there exist positive constants μ_0 , C_1 and C_2 (depending only on γ , C_0 and on T_0) such that the following holds. Consider an initial datum with

(13)
$$\mathcal{E}_{\kappa_0}(0) = C_0 \mu^4, \qquad \mathcal{E}_{\kappa}(0) = 0 \qquad \forall \kappa = (\kappa_1, \kappa_2) \neq \kappa_0,$$

and assume that $\mu < \mu_0$. Then there exists $\rho > 0$ such that along the corresponding solution one has

(14)
$$\mathcal{E}_{\kappa}(t) \leq C_1 \,\mu^4 e^{-\rho|(\kappa_1/\mu,\kappa_2/\mu^{\sigma})|} + C_2 \,\mu^{4+\gamma}, \qquad \forall |t| \leq \frac{T_0}{\mu^3}$$

for all κ .

Remark 2.2. Theorem 2.1 is the first rigorous result for two-dimensional lattices in which the dynamics of the lattice in a genuinely two-dimensional regime is described by a system of two-dimensional integrable PDEs. Moreover, in Theorem 2.1 we do not mention the existence of a sequence of almost-periodic functions approximating the specific energies of the modes, and this is a difference with respect to Theorem 5.3 in [BP06]. This is related to the construction of action-angle/Birkhoff coordinates for the KP equation, which is an open problem in the theory of integrable PDEs.

Remark 2.3. For the sake of simplicity, we have proved Theorem 2.1 for initial data in which only one low-frequency Fourier mode is excited. One can also prove that a variant of Theorem 2.1 holds also in the case the higher harmonics of a low-frequency Fourier mode are excited, provided that the energy decreases exponentially with respect to $|(\kappa_1/\mu, \kappa_2/\mu^{\sigma})|$, and also for initial data in which the symmetrical modes of a given low-frequency Fourier mode are excited. To summarize, we are only able to prove stability of the solutions we constructed for initial data with vanishing specific energy for a time-scale $\mathcal{O}(\mu^{-3})$.

Remark 2.4. Here and in the following theorems we decided to write the bound on the specific energy with respect to the intensive variables $\kappa = (\kappa_1, \kappa_2)$. This writing has the advantage to be consistent with the previous literature (e.g. compare (13) above with (3.8) in [BP06]). Anyway, let us emphasize that, using the definition of κ , (13) can be written equivalently as

(15)
$$\mathcal{E}_{\kappa}(t) \le C_1 \mu^4 e^{-\rho |(k_1, k_2)|} + C_2 \mu^{4+\gamma}, \qquad \forall t \le \frac{T_0}{\mu^3}.$$

This implies that, as the number of sites increase, the Fourier spectrum is exponentially localised (and remains so, as $\mu \to 0$) around $\kappa = 0$, apart from an error of order $\mu^{4+\gamma}$.

We also point out that there are also other regimes in which the dynamics of a two-dimensional lattice can be approximated by integrable PDEs. For example, we can consider $\alpha + \beta$ model of (5) in the following regime:

(KdV) the very weakly transverse regime, where the effective dynamics is described by a system of two uncoupled Korteweg-de Vries (KdV) equations. This corresponds to taking $\mu \ll 1$ and $2 < \sigma < 7$.

The corresponding result one can prove in such a regime is the following.

Theorem 2.5. Consider (5) with $\alpha \neq 0$, $2 < \sigma < 7$. Define $\gamma_0(\sigma) := \frac{3}{2} \left(\sigma - \frac{5}{3} \right)$ for $2 < \sigma < 3$, and $\gamma_0(\sigma) := \frac{1}{2} (7 - \sigma)$ for $3 \leq \sigma < 7$.

Fix $0 < \gamma < \gamma_0(\sigma)$ and two positive constants C_0 and T_0 , then there exist positive constants μ_0 , C_1 and C_2 (depending only on γ , C_0 , σ and on T_0) such that the following holds. Consider an initial datum with

(16)
$$\mathcal{E}_{\kappa_0}(0) = C_0 \mu^4, \qquad \mathcal{E}_{\kappa}(0) = 0, \qquad \forall \kappa = (\kappa_1, \kappa_2) \neq \kappa_0,$$




FIGURE 2. The dispersion relation for the KG lattice (20), namely $\pm \omega_k$, $k = (k_1, k_2)$, vs the integer coordinates, for $N_1 = 10$ and $N_2 = 100$.

and assume that $\mu < \mu_0$. Then there exists $\rho > 0$ such that along the corresponding solution one has

(17)
$$\mathcal{E}_{\kappa}(t) \leq C_1 \,\mu^4 e^{-\rho|(\kappa_1/\mu,\kappa_2/\mu^{\sigma})|} + C_2 \,\mu^{4+\gamma}, \qquad \forall |t| \leq \frac{T_0}{\mu^3}$$

for all κ . Moreover, for any n_2 with $0 \le n_2 \le N_2$ there exists a sequence of almost-periodic functions $(F_n)_{n=(n_1,n_2)\in\mathbb{Z}^2_{N_1,N_2,+}}$ such that, if we define

(18)
$$\mathcal{F}_{\kappa_0} = \mu^4 F_n, \qquad \mathcal{F}_{\kappa} = 0 \qquad \forall \kappa \neq n \kappa_0$$

then one has, for the specific energy distribution $\mathcal{E}_{\kappa}(t)$,

(19)
$$|\mathcal{E}_{\kappa}(t) - \mathcal{F}_{\kappa}(t)| \le C_2 \,\mu^{4+\gamma}, \qquad \forall \, |t| \le \frac{T_0}{\mu^3}.$$

Remark 2.6. We point out that in the statement of Theorem 2.5 the assumption $\sigma > 2$ comes from an asymptotic expansion of the dispersion relation of the continuous approximation of the lattice (see (88)-(89)), while the assumption $\sigma < 7$ comes from a technical assumption under which we can approximate the dynamics of the lattice with the dynamics of the system of uncoupled KdV equations (see the statement of Theorem 6.6).

We can also consider two-dimensional KG lattices, which combine the nearest-neighbour potential with an on-site one: the scalar model is described by

(20)
$$H_{KG}(Q, P) = \sum_{j \in \mathbb{Z}_{N_1, N_2}^2} \frac{P_j^2}{2} + \frac{1}{2} \sum_{j \in \mathbb{Z}_{N_1, N_2}^2} Q_j (-\Delta_1 Q)_j + \sum_{j \in \mathbb{Z}_{N_1, N_2}^2} U(Q_j),$$

(21)
$$U(x) = m^2 \frac{x^2}{2} + \beta \frac{x^{2p+2}}{2p+2}, \qquad m > 0, \qquad \beta > 0, \ p \ge 1,$$

(see [Ros03] for a physical interpration of the model). The associated equations of motion are

(22)
$$\ddot{Q}_j = (\Delta_1 Q)_j - m^2 Q_j - \beta Q_j^{2p+1}, \qquad j \in \mathbb{Z}^2_{N_1, N_2}.$$

If we take p=1, we obtain a generalization of the one-dimensional ϕ^4 model.

We now introduce the Fourier coefficients of Q as in (6), and similarly for P, and denote by

(23)
$$E_k := \frac{|\hat{P}_k|^2 + \omega_k^2 |\hat{Q}_k|^2}{2}.$$

(24)
$$\omega_k^2 := m^2 + 4\sin^2\left(\frac{k_1\pi}{2N_1+1}\right) + 4\sin^2\left(\frac{k_2\pi}{2N_2+1}\right),$$

the energy and the square of the frequency of the mode at site $k = (k_1, k_2) \in \mathbb{Z}^2_{N_1, N_2}$ (see Figure 2). In the rest of the paper we will assume that m = 1.

We consider the two-dimensional KG lattice (20) in the following regime:

(1D NLS) the very weakly transverse regime, where the effective dynamics is described by a cubic onedimensional nonlinear Schrödinger (NLS) equation. This corresponds to taking $\mu \ll 1$ and

Theorem 2.7. Consider (20) with $\beta > 0$, $1 < \sigma < 7$. Define $\gamma_1(\sigma) := \frac{3}{2} \left(\sigma - \frac{1}{3}\right)$ for $1 < \sigma < 2$, and $\gamma_1(\sigma) := \frac{1}{2}(7-\sigma) \text{ for } 2 \leq \sigma < 7.$

Fix $0 < \gamma \le \gamma_1(\sigma)$ and two positive constants C_0 and T_0 , then there exist positive constants μ_0 , C_1 and C_2 (depending only on γ , C_0 , σ and on T_0) such that the following holds. Consider an initial datum

(25)
$$\mathcal{E}_{\kappa_0}(0) = C_0 \mu^2, \qquad \mathcal{E}_{\kappa}(0) = 0, \ \forall \kappa = (\kappa_1, \kappa_2) \neq \kappa_0,$$

and assume that $\mu < \mu_0$. Then there exists $\rho > 0$ such that along the corresponding solution one has

(26)
$$\mathcal{E}_{\kappa}(t) \leq C_1 \,\mu^2 e^{-\rho|(\kappa_1/\mu, \kappa_2/\mu^{\sigma})|} + C_2 \,\mu^{2+\gamma}, \qquad |t| \leq \frac{T_0}{\mu^2}$$

for all κ . Moreover, for any n_2 with $0 \le n_2 \le N_2$ there exists a sequence of almost-periodic functions $(F_n)_{n=(n_1,n_2)\in\mathbb{Z}^2_{N_1,N_2,+}}$ such that, if we denote

(27)
$$\mathcal{F}_{\kappa_0} = \mu^2 F_n, \qquad \mathcal{F}_{\kappa} = 0 \qquad \forall \kappa \neq n \kappa_0$$

then we have for the specific energy distribution

(28)
$$|\mathcal{E}_{\kappa}(t) - \mathcal{F}_{\kappa}(t)| \le C_2 \,\mu^{2+\gamma}, \qquad |t| \le \frac{T_0}{\mu^2}.$$

Remark 2.8. In Theorem 2.7 we are able to prove stability of the solutions we constructed for initial data with vanishing specific energy for a time-scale $\mathcal{O}(\mu^{-2})$.

Remark 2.9. As for Theorem 2.5, in the statement of Theorem 2.7 the assumption $\sigma > 1$ comes from an asymptotic expansion of the dispersion relation of the continuous approximation of the lattice (see (105)-(106)), while the assumption $\sigma < 7$ comes from a technical assumption under which we can approximate the dynamics of the lattice with the dynamics of the system of uncoupled NLS equations (see the statement of Theorem 6.10).

2.1. Further remarks.

Remark 2.10. The specific choice of the direction of longitudinal propagation in the regimes that we have considered is not relevant.

Remark 2.11. We point out that the time of validity of Theorem 2.7 for the KG lattice is of order $\mathcal{O}(\mu^{-2})$, which is different from the time of validity of Theorem 2.5 and Theorem 2.1 for the FPU lattice. In the one-dimensional case it has been observed that, for a fixed value of specific energy ϵ and for long-wavelength modes initially excited, the ϕ^4 model reached equipartition faster than the FPU β model (see [LLPR07], sec. 2.1.8).

Remark 2.12. Theorem 2.1, Theorem 2.5 and Theorem 2.7 can be generalized to higher dimensional lattices. Indeed, let $d \geq 2$, define

(29)
$$\mathbb{Z}_{N_1,\ldots,N_d}^d := \{ (j_1,\ldots,j_d) : j_1,\ldots,j_d \in \mathbb{Z}, |j_1| \le N_1,\ldots,|j_d| \le N_d \},$$

and consider the d-dimensional ETL

$$H_{\text{ETL}}^{(d)}(Q, P) = \sum_{j \in \mathbb{Z}_{N_1, \dots, N_d}^d} \left(-\frac{1}{2} P_j \left(\Delta_1 P \right)_j + (V(Q))_j \right), \quad (V(Q))_j = \frac{Q_j^2}{2} + \alpha \frac{Q_j^3}{3} + \beta \frac{Q_j^4}{4}, \quad j \in \mathbb{Z}_{N_1, \dots, N_d}^d,$$

and the d-dimensional NLKG lattice

$$H_{\mathrm{KG}}^{(d)}(Q,P) = \sum_{\substack{j \in \mathbb{Z}_{N_1,\ldots,N_d}^d \\ |j-k|=1}} \frac{P_j^2}{2} + \frac{1}{2} \sum_{\substack{j,k \in \mathbb{Z}_{N_1,\ldots,N_d}^d \\ |j-k|=1}} \frac{(Q_j - Q_k)^2}{2} + \sum_{\substack{j \in \mathbb{Z}_{N_1,\ldots,N_d}^d \\ |j-k|=1}} U(Q_j), \quad U(x) = \frac{x^2}{2} + \beta \frac{x^4}{4}, \quad \beta > 0.$$

We assume $N_1 \leq N_2, \ldots, N_d$, and we introduce the quantities

(32)
$$\mu := \frac{2}{2N_1 + 1}, \quad \sigma_i := \log_{N_1 + \frac{1}{2}} \left(N_{i+1} + \frac{1}{2} \right), \qquad i = 1, \dots, d - 1.$$

Then we can describe the following regimes:

- (KdV-d) the model (30) for $d \le 4$, in the very weakly transverse regime with $\mu \ll 1$ and $2 < \sigma_1, \ldots, \sigma_{d-1} < \tau$;
- (KP-d) the model (30) for $d \leq 4$, in the weakly transverse regime with $\mu \ll 1$ and $\sigma_1 = 2, 2 < \sigma_2, \ldots, \sigma_{d-1} < 7$:
- (1DNLS-d) the model (31) for $d \le 6$, in the very weakly transverse regime, with $\mu \ll 1, 1 < \sigma_1, \ldots, \sigma_{d-1} < 7$.

Remark 2.13. There are other interesting regimes for (5) and (22) especially for their relation with the modified KdV equation and two-dimensional Non-Linear Schrödinger equation respectively. These will be discussed in Remark 4.6 and Remark 4.9 respectively.

3. Galerkin Averaging

In the next Section we will show that for large N the dynamics of both ETL and KG lattices can be approximated by an infinite dimensional Hamiltonian, which can be written as the sum of an integrable part and a non-integrable perturbation. For this kind of systems it is often possible to analyse the dynamics taking into account only the leading terms of the integrable part and the 'average effect' of the perturbation, which describe the relevant qualitative behaviour of the system for a sufficiently long time-scale.

In this Section we prove an abstract averaging theorem whose assumptions are satisfied by the systems we have introduced in Section 2. This is the crucial technical result that allows to rigorously approximate the infinite dimensional Hamiltonian system with the leading terms of the integrable part and the average of the perturbation, up to the time-scales we are interested in. Since the average has to be computed along the solutions of the unperturbed system (see (47) below), the vector field of the averaged perturbation commutes with the vector field of the unperturbed system, thus resulting in a system in normal form.

The idea of its proof (following [Bam05], [BP06] and [Pas19]) is to make a Galerkin cutoff, namely to approximate the original infinite dimensional system by a finite dimensional one, to put in normal form the cutoffed system, and then to choose the dimension of the cutoffed system in such a way that the error due to the Galerkin cutoff and the error due to the truncation in the normalization procedure are of the same order of magnitude. The system one gets is composed by a part which is in normal form, and by a remainder which is a smaller singular perturbation.

If we neglect the remainder, we obtain a system whose solutions are approximate solutions of the original system. In Sec. 6 we will show how to control the error with respect to a true solution of the original system.

This Section is divided in two parts. In the first part we introduce the analytic setting we are working with. This includes the definition functional setting of the problem and the average Theorem 3.3. In the second part we give a concise proof of the average Theorem, deferring the proof of the technical Lemma 3.6 to Appendix A.

3.1. **An Averaging Theorem.** To define the function spaces we are working with, we introduce a topology in the phase space. This is conveniently done in terms of Fourier coefficients.

Definition 3.1. Fix two constants $\rho \geq 0$ and $s \geq 0$. We will denote by $\ell_{\rho,s}^2$ the Hilbert space of complex sequences $v = (v_n)_{n \in \mathbb{Z}^2 \setminus \{0\}}$ with obvious vector space structure and with scalar product

(33)
$$\langle v, w \rangle_{\rho, s} := \sum_{n \in \mathbb{Z}^2 \setminus \{0\}} \overline{v_n} w_n e^{2\rho|n|} |n|^{2s}.$$

and such that

(34)
$$||v||_{\rho,s}^2 := \langle v, v \rangle_{\rho,s} = \sum_{n \in \mathbb{Z}^2 \setminus \{0\}} |v_n|^2 e^{2\rho|n|} |n|^{2s}$$

is finite. We will denote by ℓ^2 the space $\ell^2_{0,0}$.

We will identify a 2-periodic function f with the sequence of its Fourier coefficients $(\hat{f}_n)_{n\in\mathbb{Z}^2\setminus\{0\}}$,

$$f(y) = \frac{1}{2} \sum_{n \in \mathbb{Z}^2} \hat{f}_n e^{i\pi \, n \cdot y},$$

and, with a small abuse of notation, we will say that $f \in \ell^2_{\rho,s}$ if the sequence of its Fourier coefficients belong to $\ell^2_{\rho,s}$.

Now fix $\rho \geq 0$ and $s \geq 1$, and consider the scale of Hilbert spaces $\mathcal{H}^{\rho,s} := \ell_{\rho,s}^2 \times \ell_{\rho,s}^2 \ni \zeta = (\xi, \eta)$, endowed with one of the following symplectic forms:

(35)
$$\Omega_1 := \begin{pmatrix} 0 & i \\ -i & 0 \end{pmatrix}, \qquad \Omega_2 := \begin{pmatrix} -\partial_{y_1}^{-1} & 0 \\ 0 & \partial_{y_1}^{-1} \end{pmatrix}.$$

Observe that $\Omega_{\Gamma}: \mathcal{H}^{\rho,s} \to \mathcal{H}^{\rho,s+\Gamma-1}$ ($\Gamma=1,2$) is a well-defined operator. Moreover, Ω_2 is well-defined on the space of functions with zero-average with respect to the y_1 -variable, i.e. on those functions $\zeta(y_1,y_2)$ such that for every y_2 we have $\int_{-1}^1 \zeta(y_1,y_2) \, \mathrm{d}y_1 = 0$.

If we fix $\Gamma \in \{1,2\}$, s and $U_s \subset \ell_{\rho,s}^2$ open, we define the gradient of $K \in C^{\infty}(U_s,\mathbb{R})$ with respect to $\xi \in \ell_{\rho,s}^2$ as the unique function s.t.

$$\langle \nabla_{\xi} \mathsf{K}, h \rangle = \mathrm{d}_{\xi} \mathsf{K}(h), \qquad \forall h \in \ell_{\rho,s}^2.$$

Similarly, for an open set $\mathcal{U}_s \subset \mathcal{H}^{\rho,s}$ the Hamiltonian vector field of the Hamiltonian function $\mathsf{H} \in C^{\infty}(\mathcal{U}_s, \mathbb{R})$ is given by

$$X_{\mathsf{H}}(\zeta) = \Omega_{\Gamma}^{-1} \nabla_{\zeta} \mathsf{H}(\zeta).$$

The open ball of radius R and center 0 in $\ell_{\rho,s}^2$ will be denoted by $B_{\rho,s}(R)$; we write $\mathcal{B}_{\rho,s}(R) := B_{\rho,s}(R) \times B_{\rho,s}(R) \subset \mathcal{H}^{\rho,s}$.

Now, we introduce the Fourier projection operators $\hat{\pi}_j: \ell^2_{\rho,s} \to \ell^2_{\rho,s}$

(36)
$$\hat{\pi}_{j}((v_{n})_{n \in \mathbb{Z}^{2} \setminus \{0\}}) := \begin{cases} v_{n} & \text{if } j-1 \leq |n| < j \\ 0 & \text{otherwise} \end{cases}, \quad j \geq 1,$$

the operators $\pi_j: \mathcal{H}^{\rho,s} \to \mathcal{H}^{\rho,s}$

(37)
$$\pi_j((\zeta_n)_{n \in \mathbb{Z}^2 \setminus \{0\}}) := \begin{cases} \zeta_n & \text{if } j-1 \le |n| < j \\ 0 & \text{otherwise} \end{cases}, \quad j \ge 1,$$

and the operators $\Pi_M: \mathcal{H}^{\rho,s} \to \mathcal{H}^{\rho,s}$

(38)
$$\Pi_M((\zeta_n)_{n\in\mathbb{Z}^2\setminus\{0\}}) := \begin{cases} \zeta_n & \text{if } |n| \le M \\ 0 & \text{otherwise} \end{cases}, \qquad M \ge 0.$$

Last, we define the operator $\overline{\pi_j} := \mathrm{id} - \pi_j$ that will be used in Appendix C and E.

Lemma 3.2. The projection operators defined in (37) and (38) satisfy the following properties for any $\zeta \in \mathcal{H}^{\rho,s}$:

i. for any $j \geq 0$

$$\zeta = \sum_{j>0} \pi_j \zeta;$$

ii. for any $j \geq 0$

$$\|\Pi_M \zeta\|_{\mathcal{H}^{\rho,s}} \le \|\zeta\|_{\mathcal{H}^{\rho,s}};$$

iii. the following equality holds

(39)
$$\|\zeta\|_{\mathcal{H}^{\rho,s}} = \left\| \left[\sum_{j \in \mathbb{N}} j^{2s} |\pi_j \zeta|^2 \right]^{1/2} \right\|_{\mathcal{H}^{\rho,0}}$$

where $|\zeta|$, for $\zeta \in \mathcal{H}^{\rho,s}$ is the element $|\zeta| \in \mathcal{H}^{\rho,s}$ whose n-th element is

$$|\zeta|_n := (|\xi_n|, |\eta_n|)$$

and
$$(\zeta^{\alpha})_n := (\xi_n^{\alpha}, \eta_n^{\alpha}).$$

Now we consider a Hamiltonian system of the form

$$\mathsf{H} = \mathsf{h}_0 + \delta \mathsf{F},$$

where we assume that

(PER) h_0 generates a linear periodic flow $\Phi_{h_0}^{\tau}$ with period T,

$$\Phi_{\mathsf{h}_0}^{\tau+T} = \Phi_{\mathsf{h}_0}^{\tau} \qquad \forall \tau,$$

which is analytic as a map from $\mathcal{H}^{\rho,s}$ into itself for any $s \geq 1$. Furthermore, the flow is an isometry for any $s \geq 1$.

(INV) for any $s \ge 1$, $\Phi_{h_0}^{\tau}$ leaves invariant the space $\Pi_j \mathcal{H}^{\rho,s}$ for any $j \ge 0$. Furthermore, for any $j \ge 0$

$$\pi_j \circ \Phi_{\mathsf{h}_0}^{\tau} = \Phi_{\mathsf{h}_0}^{\tau} \circ \pi_j.$$

Next, we assume that there exists $\nu \in]0,1]$ such that the vector field of F admits an asymptotic expansion in δ of the form

(41)
$$\mathsf{F} \sim \sum_{i > 1} \delta^{\nu(j-1)} \mathsf{F}_j,$$

(41)
$$\mathsf{F} \sim \sum_{j \geq 1} \delta^{\nu(j-1)} \mathsf{F}_{j},$$

$$(42) X_{\mathsf{F}} \sim \sum_{j \geq 1} \delta^{\nu(j-1)} X_{\mathsf{F}_{j}},$$

and that the following property is satisfied

(HVF) There exists $R^* > 0$ such that for any $j \ge 1$

· X_{F_j} is analytic from $\mathcal{B}_{\rho,s+2j+\Gamma}(R^*)$ to $\mathcal{H}^{\rho,s}$.

Moreover, for any $r \geq 1$ we have that

$$\cdot X_{\mathsf{F}-\sum_{j=1}^r \delta^{\nu(j-1)}\mathsf{F}_j}$$
 is analytic from $\mathcal{B}_{\rho,s+2(r+1)+\Gamma}(R^*)$ to $\mathcal{H}^{\rho,s}$.

The main result of this Section is the following theorem.

Theorem 3.3. Fix R > 0, $s_1 \gg 1$. Consider (40), and assume (PER), (INV) and (HVF). Then \exists $s_0 > 0$ with the following properties: for any $s \geq s_1$ there exists $\delta_s \ll 1$ such that for any $\delta < \delta_s$ there exists $\mathcal{T}_{\delta}: \mathcal{B}_{\rho,s}(R/2) \to \mathcal{B}_{\rho,s}(R)$ analytic canonical transformation such that

(43)
$$\mathsf{H}_1 := \mathsf{H} \circ \mathcal{T}_{\delta} = \mathsf{h}_0 + \delta \mathcal{Z}_1 + \delta^{1+\nu} \, \mathcal{R}^{(1)},$$

where \mathcal{Z}_1 is in normal form, namely

$$\{\mathcal{Z}_1, \mathsf{h}_0\} = 0,$$

and there exists a positive constant C'_s (that depends on s) such that

$$\sup_{\mathcal{B}_{\rho,s+s_0}(R/2)} \|X_{\mathcal{Z}_1}\|_{\mathcal{H}^{\rho,s}} \le C_s',$$

(45)
$$\sup_{\mathcal{B}_{\rho,s+s_0}(R/2)} \|X_{\mathcal{R}^{(1)}}\|_{\mathcal{H}^{\rho,s}} \le C_s',$$

(46)
$$\sup_{\mathcal{B}_{\rho,s}(R/2)} \|\mathcal{T}_{\delta} - \mathrm{id}\|_{\mathcal{H}^{\rho,s}} \le C'_s \,\delta.$$

In particular,

(47)
$$\mathcal{Z}_1(\zeta) = \langle \mathsf{F}_1 \rangle (\zeta),$$

where $\langle \mathsf{F}_1 \rangle (\zeta) := \int_0^T \mathsf{F}_1 \circ \Phi_{\mathsf{ho}}^{\tau}(\zeta) \frac{\mathrm{d}\tau}{T}$.

3.2. **Proof of the Averaging Theorem.** The proof of Theorem 3.3 is actually an application of the techniques used in [Pas19] and [BP06]).

First notice that by assumption (INV) the Hamiltonian vector field of h_0 generates a continuous flow $\Phi_{h_0}^{\tau}$ which leaves $\Pi_M \mathcal{H}^{\rho,s}$ invariant.

Now we set $H = H_{1,M} + \mathcal{R}_{1,M} + \mathcal{R}_1$, where

(48)
$$\mathsf{H}_{1,M} := \mathsf{h}_0 + \delta \, \mathsf{F}_{1,M},$$

$$\mathsf{F}_{1,M} := \mathsf{F}_1 \circ \Pi_M,$$

and

(50)
$$\mathcal{R}_{1,M} := \mathsf{h}_0 + \delta \mathsf{F}_1 - \mathsf{H}_{1,M},$$

(51)
$$\mathcal{R}_1 := \delta \left(\mathsf{F} - \mathsf{F}_1 \right).$$

The system described by the Hamiltonian (48) is the one that we will put in normal form. In the following we will use the notation $a \leq b$ to mean: there exists a positive constant K independent of M and R (but eventually on s), such that $a \leq Kb$. We exploit the following intermediate results:

Lemma 3.4. For any $s \ge s_1$ there exists R > 0 such that $\forall \sigma > 0$, M > 0

(52)
$$\sup_{\zeta \in \mathcal{B}_{\rho,s+\Gamma+\sigma+2}(R)} \|X_{\mathcal{R}_{1,M}}(\zeta)\|_{\mathcal{H}^{\rho,s}} \lesssim \frac{\delta}{(M+1)^{\sigma}},$$

(53)
$$\sup_{\zeta \in \mathcal{B}_{\rho,s+\Gamma+4}(R)} \|X_{\mathcal{R}_1}(\zeta)\|_{\mathcal{H}^{\rho,s}} \lesssim \delta^{1+\nu}.$$

Proof. We recall that $\mathcal{R}_{1,M} = \mathsf{h}_0 + \delta \mathsf{F}_1 - \mathsf{H}_{1,M} = \delta(F_1 - F_{1,M})$. We first notice that $\|\mathrm{id} - \Pi_M\|_{\mathcal{H}^{\rho,s+\sigma} \to \mathcal{H}^{\rho,s}} = (M+1)^{-\sigma}$: indeed, using (39) we obtain

$$\left\| \sum_{j \ge M+1} \pi_j f \right\|_{\mathcal{H}^{\rho,s}} = \left\| \left[\sum_{j \ge M+1} |j^s \pi_j f|^2 \right]^{1/2} \right\|_{\mathcal{H}^{\rho,0}} \le (M+1)^{-\sigma} \left\| \left[\sum_{j \ge M+1} |j^{s+\sigma} \pi_j f|^2 \right]^{1/2} \right\|_{\mathcal{H}^{\rho,0}} \le (M+1)^{-\sigma} \|f\|_{\mathcal{H}^{\rho,s+\sigma}},$$

whereas the inequality $\|\mathrm{id} - \Pi_M\|_{\mathcal{H}^{\rho,s+\sigma} \to \mathcal{H}^{\rho,\sigma}} \leq (M+1)^{-\sigma}$ is obtained with a function which has non zero components only for |j| = M+1, i.e. $f = \pi_{M+1}f$.

Inequality (52) follows from

$$\sup_{\zeta \in \mathcal{B}_{\rho,s+\Gamma+2+\sigma}(R)} \|X_{\mathcal{R}_{1,M}}(\zeta)\|_{\mathcal{H}^{\rho,s}} \lesssim \|dX_{\delta\mathsf{F}_1}\|_{L^{\infty}(\mathcal{B}_{\rho,s+2+\Gamma}(R),\mathcal{H}^{\rho,s})} \|id - \Pi_M\|_{L^{\infty}(\mathcal{B}_{\rho,s+2+\Gamma+\sigma}(R),\mathcal{B}_{\rho,s+2+\Gamma}(R))}$$

$$\lesssim \delta (M+1)^{-\sigma},$$

while estimate (53) is an immediate consequence of (HVF).

Lemma 3.5. For any $s \geq s_1$

$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R^*)} \|X_{\mathsf{F}_{1,M}}(\zeta)\|_{\mathcal{H}^{\rho,s}} \le K_{1,s}^{(\mathsf{F})} M^{2+\Gamma},$$

where

$$K_{1,s}^{(\mathsf{F})} := \sup_{\zeta \in \mathcal{B}_{\rho,s}(R^*)} \|X_{\mathsf{F}_1}(\zeta)\|_{\mathcal{H}^{\rho,s-2-\Gamma}} < +\infty.$$

Proof. Using (39) we have

(54)
$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \left\| \sum_{h \le M} \pi_h X_{\mathsf{F}_{1,M}}(\zeta) \right\|_{\mathcal{H}^{\rho,s}} = \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \left\| \left[\sum_{h \le M} \left| h^s \pi_h X_{\mathsf{F}_{1,M}}(\zeta) \right|^2 \right]^{1/2} \right\|_{\mathcal{H}^{\rho,0}}$$

(55)
$$\leq M^{2+\Gamma} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \left\| \left[\sum_{h \leq M} |h^{s-2-\Gamma} \pi_h X_{\mathsf{F}_{1,M}}(\zeta)|^2 \right]^{1/2} \right\|_{\mathcal{H}^{\rho,0}}$$

(56)
$$\leq M^{2+\Gamma} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\mathsf{F}_{1,M}}(\zeta)\|_{\mathcal{H}^{\rho,s-2-\Gamma}} = K_{1,s}^{(\mathsf{F})} M^{2+\Gamma},$$

where the last quantity is finite for $R \leq R^*$ by property (HVF).

To normalize (48) we need to prove a reformulation of Theorem 4.4 in [Bam99]. Here we report a statement of the result adapted to our context which is proved in Appendix A.

Lemma 3.6. Let $s \ge s_1 + 2 + \Gamma$, R > 0, and consider the system (48). Assume that $\delta < \frac{1}{30^{1/\nu}}$, and that

(57)
$$12TK_{1,s}^{(\mathsf{F})}M^{2+\Gamma}\delta < R$$

where

$$K_{1,s}^{(\mathsf{F})} := \sup_{\zeta \in \mathcal{B}_{
ho,s}(R)} \|X_{\mathsf{F}_1}(\zeta)\|_{\mathcal{H}^{
ho,s-2-\Gamma}}.$$

Then there exists an analytic canonical transformation $\mathcal{T}_{\delta,M}^{(0)}:\mathcal{B}_{\rho,s}(R/2)\to\mathcal{B}_{\rho,s}(R)$ such that

(58)
$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R/2)} \|\mathcal{T}_{\delta,M}^{(0)}(\zeta) - \zeta\|_{\mathcal{H}^{\rho,s}} \le 2T K_{1,s}^{(F)} M^{2+\Gamma} \delta,$$

and that puts (48) in normal form up to a small remainder,

(59)
$$\mathsf{H}_{1,M} \circ \mathcal{T}_{\delta,M}^{(0)} = \mathsf{h}_0 + \delta \mathsf{Z}_M^{(1)} + \delta^{1+\nu} \mathcal{R}_M^{(1)},$$

with $Z_M^{(1)}$ in normal form, namely $\{h_{0,M},Z_M^{(1)}\}=0$, and

(60)
$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R/2)} \|X_{\mathsf{Z}_{M}^{(1)}}(\zeta)\|_{\mathcal{H}^{\rho,s}} \le K_{1,s}^{(\mathsf{F})} M^{2+\Gamma}$$

(61)
$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R/2)} \|X_{\mathcal{R}_{M}^{(1)}}(\zeta)\|_{\mathcal{H}^{\rho,s}} \le 15K_{1,s}^{(\mathsf{F})}M^{2+\Gamma}$$

Now we conclude with the proof of Theorem 3.3.

Proof. If we define $\delta_s := \min\{\frac{1}{30^{1/\nu}}, \frac{R}{12 T K_1^{(\Gamma)} M^{2+\Gamma}}\}$ and we choose

$$s_0 = \sigma + 2 + \Gamma,$$

$$\sigma > 2,$$

then the transformation $\mathcal{T}_{\delta} := \mathcal{T}_{\delta,M}^{(0)}$ defined by Lemma 3.6 satisfies (43) because of (59). Next, Eq. (44) follows from Lemma 3.6, Eq. (45) follows from (60) and (61), while (46) is precisely (58). Finally, (47) can be deduced by applying Lemma A.6 to $\mathsf{G}=\mathsf{F}_1$.

4. Applications to two-dimensional lattices

4.1. The KP regime for the ETL lattice. We want to study the behaviour of small amplitude solutions of (5) with initial data in which only one low-frequency Fourier mode is excited.

As a first step, we introduce an interpolating function Q = Q(t, x) such that

- (A1) $Q(t,j)=Q_j(t)$, for all $j\in\mathbb{Z}^2_{N_1,N_2}$; (A2) Q is periodic with period $2N_1+1$ in the x_1 -variable, and periodic with period $2N_2+1$ in the x_2 -variable;

(A3) Q has zero average, $\int_{\left[-\left(N_1+\frac{1}{2}\right),N_1+\frac{1}{2}\right]\times\left[-\left(N_2+\frac{1}{2}\right),N_2+\frac{1}{2}\right]}Q(t,x)\,\mathrm{d}x=0\,\,\forall t;$

$$(A4)$$
 Q fulfills

(62)
$$\ddot{Q} = \Delta_1 (Q + \alpha Q^2 + \beta Q^3),$$

(63)
$$\Delta_1 := 4\sinh^2\left(\frac{\partial_{x_1}}{2}\right) + 4\sinh^2\left(\frac{\partial_{x_2}}{2}\right).$$

One can check that the operator (63) is equivalent to (3) by using functional calculus.

It is easy to verify that (62) is Hamiltonian with Hamiltonian function

(64)
$$\mathsf{H}_{\mathrm{ETL}}(Q,P) = \int_{\left[-\frac{1}{\mu},\frac{1}{\mu}\right] \times \left[-\frac{1}{\mu^2},\frac{1}{\mu^2}\right]} \left(\frac{-P\,\Delta_1 P + Q^2}{2} + \alpha \frac{Q^3}{3} + \beta \frac{Q^4}{4}\right) \,\mathrm{d}x,$$

where P is a periodic function which has zero average and is canonically conjugated to Q.

The existence of such an interpolating function is obvious, indeed such function can be taken to be a Fourier polynomial with N terms. However, by construction, items (A1)-(A4) do not provide a unique interpolating function. Among all possible choices of interpolating functions it is convenient to choose the Fourier polynomial supported on $k \in [-N_1, N_1] \times [-N_2, N_2]$ (i.e. the analytic function supported in the lowest possible number of Fourier modes). Also let us emphasize that (A4) ensures that if (A1) is valid for the intial time t = 0, then is valid for all $t \in \mathbb{R}$.

We consider (62), with $\alpha \neq 0$, and we look for small amplitude solutions of the form

(65)
$$Q(t,x) = \mu^2 q(\mu t, \mu x_1, \mu^2 x_2),$$

with μ as in (11). We introduce the rescaled time $\tau = \mu t$ and the rescaled space variables $y_1 = \mu x_1$, $y_2 = \mu^2 x_2$.

Plugging (65) into (62), leads to

(66)
$$q_{\tau\tau} = \frac{\Delta_{\mu,y_1}}{\mu^2} \left(q + \mu^2 \alpha q^2 + \mu^4 \beta q^3 \right),$$

(67)
$$\Delta_{\mu,y_1} := 4 \sinh^2 \left(\frac{\mu \partial_{y_1}}{2} \right) + 4 \sinh^2 \left(\mu^2 \frac{\partial_{y_2}}{2} \right),$$

which is a Hamiltonian PDE corresponding to the Hamiltonian functional,

(68)
$$\mathsf{K}_{1}(q,p) = \int_{I} \left(\frac{-p \,\Delta_{\mu,y_{1}} p}{2\mu^{2}} + \frac{q^{2}}{2} + \alpha \mu^{2} \frac{q^{3}}{3} + \beta \mu^{4} \frac{q^{4}}{4} \right) \mathrm{d}y,$$

where

$$(69) I := [-1, 1]^2,$$

and p is the variable canonically conjugated to q.

Now, observe that the operator Δ_{μ,y_1} admits the following asymptotic expansion up to terms of order $\mathcal{O}(\mu^4)$,

(70)
$$\frac{\Delta_{\mu,y_1}}{\mu^2} \sim \partial_{y_1}^2 + \mu^2 \partial_{y_2}^2 + \frac{\mu^2}{12} \partial_{y_1}^4 + \mathcal{O}(\mu^4),$$

therefore the Hamiltonian (68) admits the following asymptotic expansion

(71)
$$\mathsf{K}_{1}(q,p) \sim \hat{\mathsf{h}}_{0}(q,p) + \mu^{2} \hat{\mathsf{F}}_{1}(q,p) + \mu^{4} \hat{\mathcal{R}}(q,p),$$

(72)
$$\hat{\mathsf{h}}_0(q,p) = \int_I \left[\frac{p(-\partial_{y_1}^2 p) + q^2}{2} \right] \, \mathrm{d}y,$$

(73)
$$\hat{\mathsf{F}}_{1}(q,p) = \int_{I} \left(-\frac{p \, \partial_{y_{1}}^{4} p}{24} - \frac{p \, \partial_{y_{2}}^{2} p}{2} + \alpha \frac{q^{3}}{3} \right) \, \mathrm{d}y.$$

Following the approach of [BP06], we can introduce the following non-canonical change of coordinates

(74)
$$\xi := \frac{1}{\sqrt{2}} (q + \partial_{y_1} p), \quad \eta := \frac{1}{\sqrt{2}} (q - \partial_{y_1} p).$$

which transforms the Poisson tensor into

$$J = \partial_{y_1} \begin{pmatrix} -1 & 0 \\ 0 & 1 \end{pmatrix},$$

and Hamilton equations associated to a Hamiltonian K are

$$\partial_{ au}\xi = -\partial_{y_1} rac{\delta \mathsf{K}}{\delta \xi},$$
 $\partial_{ au}\eta = \partial_{y_1} rac{\delta \mathsf{K}}{\delta \eta}.$

Remark 4.1. By the explicit expression of the Poisson tensor (75) we can compute straightforwardly Casimir invariants associated to J, which are

(76)
$$C(\xi,\eta) = A(y_2) + B(y_2) \int_{-1}^{1} \xi(\tau, y_1, y_2) \, \mathrm{d}y_1 + C(y_2) \int_{-1}^{1} \eta(\tau, y_1, y_2) \, \mathrm{d}y_1,$$

where A, B and C are arbitrary functions of y_2 .

Since Casimir invariants are constants of motion, we can restrict our analysis on the subspace defined by

(77)
$$\int_{-1}^{1} \left[\xi(\tau, y_1, y_2) - \eta(\tau, y_1, y_2) \right] dy_1 = 0, \quad \forall \tau \in \mathbb{R}, \ |y_2| \le 1.$$

However, by recalling (74) one sees that (77) is equivalent to

(78)
$$\int_{-1}^{1} \partial_{y_1} p(\tau, y_1, y_2) \, \mathrm{d}y_1 = 0, \qquad \forall \tau \in \mathbb{R}, \ |y_2| \le 1,$$

which is trivially true due to periodic boundary conditions.

In the new coordinates the Hamiltonian takes the form

(79)
$$\mathsf{K}_{1}(\xi,\eta) \sim \mathsf{h}_{0}(\xi,\eta) + \mu^{2}\mathsf{F}_{1}(\xi,\eta) + \mu^{4}\mathcal{R}(\xi,\eta),$$

(80)
$$h_0(\xi, \eta) = \int_I \frac{\xi^2 + \eta^2}{2} dy,$$

(81)
$$\mathsf{F}_{1}(\xi,\eta) = \int_{I} \left(-\frac{\left[\partial_{y_{1}}(\xi - \eta)\right]^{2}}{48} + \frac{\left[\partial_{y_{2}}\partial_{y_{1}}^{-1}(\xi - \eta)\right]^{2}}{4} + \alpha \frac{(\xi + \eta)^{3}}{3 \cdot 2^{3/2}} \right) \, \mathrm{d}y,$$

where (81) is well defined because of (92).

Now we apply the averaging Theorem 3.3 to the Hamiltonian (79), with $\delta = \mu^2$, $\nu = 1$. Observe that the equations of motion of h_0 have the following simple form:

(82)
$$\begin{cases} \xi_{\tau} = -\partial_{y_1} \xi \\ \eta_{\tau} = \partial_{y_1} \eta \end{cases}; \qquad \begin{cases} \xi(\tau, y) = \xi_0(y_1 - \tau, y_2) \\ \eta(\tau, y) = \eta_0(y_1 + \tau, y_2) \end{cases}$$

Proposition 4.2. The average of F_1 in (79) with respect to the flow of h_0 in (79) is given by

$$(83) \qquad \left\langle \mathsf{F}_{1} \right\rangle (\xi, \eta) = \int_{I} \left(-\frac{(\partial_{y_{1}} \xi)^{2} + (\partial_{y_{1}} \eta)^{2}}{48} + \frac{(\partial_{y_{2}} \partial_{y_{1}}^{-1} \xi)^{2} + (\partial_{y_{2}} \partial_{y_{1}}^{-1} \eta)^{2}}{4} \right) \, \mathrm{d}y + \frac{\alpha}{3 \cdot 2^{3/2}} ([\xi^{3}] + [\eta^{3}])$$

where we denote by $[f^j]$ the average $\int_I f^j(y) \frac{dy}{4}$.

Proof. For the computation of $\langle \mathsf{F}_1 \rangle (\xi, \eta)$ one can exchange the order of the integrations in y and s. To compute averages we use the following elementary facts:

i. let $u, v \in L^2([-1, 1])$, then

$$\int_{-1}^{1} dy \int_{-1}^{1} ds \, u(y \pm s) \, v(y \mp s) = \int_{-1}^{1} u(y) \, dy \int_{-1}^{1} v(y) \, dy;$$

ii. let $u \in L^1([-1, 1])$, then

$$\frac{1}{2} \int_{-1}^{1} \mathrm{d}s \int_{-1}^{1} \mathrm{d}y \ u(y \pm s) = \int_{-1}^{1} u(x) \, \mathrm{d}x.$$

Since we assume our functions to be periodic, then also $\int_I \partial_{y_r} u(y) \, dy = 0$, r = 1, 2, and hence only terms with only ξ or η are not cancelled by the average procedure.

Corollary 4.3. The equations of motion associated to $h_0(\xi,\eta) + \mu^2 \langle \mathsf{F}_1 \rangle (\xi,\eta)$ are given by

(84)
$$\begin{cases} \xi_{\tau} = -\partial_{y_1} \xi - \frac{\mu^2}{24} \partial_{y_1}^3 \xi - \frac{\mu^2}{2} \partial_{y_1}^{-1} \partial_{y_2}^2 \xi - \frac{\alpha \mu^2}{2\sqrt{2}} \partial_{y_1}(\xi^2) \\ \eta_{\tau} = \partial_{y_1} \eta + \frac{\mu^2}{2} \partial_{y_1}^{-1} \partial_{y_2}^2 \eta + \frac{\mu^2}{24} \partial_{y_1}^3 \eta + \frac{\alpha \mu^2}{2\sqrt{2}} \partial_{y_1}(\eta^2) \end{cases}.$$

More explicitly, we observe that (84) is a system of two uncoupled KP equations on a two-dimensional torus in translating frames.

4.2. The KdV regime for the ETL lattice. For this regime we consider (62), with $\alpha \neq 0$, and we look for small amplitude solutions of the form

(85)
$$Q(t,x) = \mu^2 q(\mu t, \mu x_1, \mu^{\sigma} x_2),$$

where $q: \mathbb{R} \times \mathbb{T}^2 \to \mathbb{R}$ is a periodic function and μ , $\sigma > 2$ are defined in (11)-(12). We introduce the rescaled variables $\tau = \mu t$, $y_1 = \mu x_1$, $y_2 = \mu^{\sigma} x_2$, and we denote I is as in (69). Plugging (85) into (62), we get

$$(86) q_{\tau\tau} = \frac{\Delta_{\mu,y_1,\sigma}}{\mu^2} \left(q + \mu^2 \alpha q^2 + \mu^4 \beta q^3 \right), \quad \Delta_{\mu,y_1,\sigma} := 4 \sinh^2 \left(\frac{\mu \partial_{y_1}}{2} \right) + 4 \sinh^2 \left(\mu^\sigma \frac{\partial_{y_2}}{2} \right),$$

which is a Hamiltonian PDE corresponding to the Hamiltonian functional

(87)
$$\mathsf{K}_{2}(q,p) = \int_{I} \left(\frac{-p \,\Delta_{\mu,y_{1},\sigma} p}{2\mu^{2}} + \frac{q^{2}}{2} + \alpha \mu^{2} \frac{q^{3}}{3} + \beta \mu^{4} \frac{q^{4}}{4} \right) \,\mathrm{d}y,$$

and p is the variable canonically conjugated to q.

Now, observe that the operator $\Delta_{\mu,y_1,\sigma}$ admits the following asymptotic expansion,

(88)

$$\frac{\Delta_{\mu,y_1,\sigma}}{\mu^2} \sim \partial_{y_1}^2 + \frac{\mu^2}{12} \partial_{y_1}^4 + \mu^{2(\sigma-1)} \partial_{y_2}^2 + \frac{\mu^{2(2\sigma-1)}}{12} \partial_{y_2}^4 + \sum_{m \ge 2} c_m \left(\mu^{2m} \partial_{y_1}^{2(m+1)} + \mu^{2[(m+1)\sigma-1]} \partial_{y_2}^{2(m+1)} \right),$$

$$c_m := \frac{2}{(2m+2)!},$$

and by recalling that $\sigma > 2$ we have

(89)
$$\frac{\Delta_{\mu,y_1,\sigma}}{\mu^2} \sim \partial_{y_1}^2 + \frac{\mu^2}{12} \partial_{y_1}^4 + \mathcal{O}(\mu^{\min(2\sigma-2,4)}).$$

Therefore the Hamiltonian (87) admits the following asymptotic expansion

(90)
$$\mathsf{K}_{2}(q,p) \sim \hat{\mathsf{h}}_{0}(q,p) + \mu^{2}\hat{\mathsf{F}}_{2}(q,p) + \mu^{\min(2\sigma-2,4)}\hat{\mathcal{R}}(q,p),$$

(91)
$$\hat{\mathsf{h}}_{0}(q,p) = \int_{I} \frac{-p \left(\partial_{y_{1}}^{2} p\right) + q^{2}}{2} \mathrm{d}y, \quad \hat{\mathsf{F}}_{2}(q,p) = \int_{I} \left(-\frac{p \, \partial_{y_{1}}^{4} p}{24} + \alpha \frac{q^{3}}{3}\right) \, \mathrm{d}y.$$

Note that the nonlinearity of degree 4 does not affect the Hamiltonian up to order $\mathcal{O}(\mu^4)$.

By exploiting again the non-canonical change of coordinates $(q, p) \mapsto (\xi, \eta)$ introduced in (74) and the Poisson tensor (75), and

(92)
$$\int_{-1}^{1} \left[\xi(\tau, y_1, y_2) - \eta(\tau, y_1, y_2) \right] dy_1 = 0, \quad \forall \tau \in \mathbb{R}, \ |y_2| \le 1,$$

we obtain

(93)
$$\mathsf{K}_{2}(\xi,\eta) \sim \mathsf{h}_{0}(\xi,\eta) + \mu^{2} \mathsf{F}_{2}(\xi,\eta) + \mu^{\min(2\sigma-2,4)} \mathcal{R}(\xi,\eta),$$

(94)
$$\mathsf{h}_0(\xi,\eta) = \int_I \frac{\xi^2 + \eta^2}{2} \mathrm{d}y, \quad \mathsf{F}_2(\xi,\eta) = \int_I \left(-\frac{[\partial_{y_1}(\xi - \eta)]^2}{48} + \alpha \frac{(\xi + \eta)^3}{3 \cdot 2^{3/2}} \right) \mathrm{d}y.$$

Now we apply the averaging Theorem 3.3 to the Hamiltonian (93), with $\delta = \mu^2$, $\nu = \min(\sigma - 2, 1)$.

Proposition 4.4. The average of F_2 in (93) with respect to the flow of h_0 in (94) is given by

(95)
$$\langle \mathsf{F}_2 \rangle (\xi, \eta) = -\int_I \frac{(\partial_{y_1} \xi)^2 + (\partial_{y_1} \eta)^2}{48} \mathrm{d}y + \frac{\alpha}{3 \cdot 2^{3/2}} ([\xi^3] + [\eta^3]),$$

where we denote by $[f^j]$ the average $\int_I f^j(y) \frac{dy}{4}$.

Corollary 4.5. The equations of motion associated to $h_0(\xi, \eta) + \mu^2 \langle \mathsf{F}_1 \rangle (\xi, \eta)$ are given by

(96)
$$\begin{cases} \xi_{\tau} = -\partial_{y_1} \xi - \frac{\mu^2}{24} \partial_{y_1}^3 \xi - \frac{\mu^2 \alpha}{2\sqrt{2}} \partial_{y_1} (\xi^2) \\ \eta_{\tau} = \partial_{y_1} \eta + \frac{\mu^2}{24} \partial_{y_1}^3 \eta + \frac{\mu^2 \alpha}{2\sqrt{2}} \partial_{y_1} (\eta^2) \end{cases}$$

The latter is a system of two uncoupled KdV equations in translating frames with respect to the y_1 -direction, for each fixed value of the coordinate y_2 .

Remark 4.6. One can also study the β model (namely, (62) with $\alpha = 0$, $\beta \neq 0$) in the following regime, (mKdV) the β model in the very weakly transverse regime, $Q(t,x) = \mu q(\mu t, \mu x_1, \mu^{\sigma} x_2)$, where $\mu \ll 1$, $\sigma > 2$.

Let us introduce again the rescaled variables $\tau = \mu t$, $y_1 = \mu x_1$, $y_2 = \mu^{\sigma} x_2$, and the domain I as in (69); plugging the ansatz for Q into (62), we get

(97)
$$q_{\tau\tau} = \frac{\Delta_{\mu,y_1,\sigma}}{\mu^2} \left(q + \mu^2 \beta q^3 \right),$$

where $\Delta_{\mu,y_1,\sigma}$ is the operator introduced in (86). Eq. (97) is a Hamiltonian PDE with the following corresponding Hamiltonian,

(98)
$$\mathsf{K}_{3}(q,p) = \int_{I} \left(\frac{-p \,\Delta_{\mu,y_{1},\sigma} p}{2\mu^{2}} + \frac{q^{2}}{2} + \beta \mu^{2} \frac{q^{4}}{4} \right) \,\mathrm{d}y,$$

where p is the variable canonically conjugated to q. Recalling that (77) holds true, we exploit again the non-canonical change of coordinates (74) and the Poisson tensor (75), obtaining that

(99)
$$\mathsf{K}_{3}(\xi,\eta) \sim \mathsf{h}_{0}(\xi,\eta) + \mu^{2} \mathsf{F}_{3}(\xi,\eta) + \mu^{\min(2\sigma-2,4)} \mathcal{R}(\xi,\eta),$$

where h_0 is the same as in (94), while

(100)
$$\mathsf{F}_{3}(\xi,\eta) = \int_{\mathsf{L}} \left(-\frac{[\partial_{y_{1}}(\xi-\eta)]^{2}}{48} + \beta \frac{(\xi+\eta)^{4}}{2^{4}} \right) \, \mathrm{d}y.$$

Applying Theorem 3.3 to the Hamiltonian (99) with $\delta = \mu^2$ and $\nu = \min(\sigma - 2, 1)$, we get that the equations of motion associated to $h_0(\xi, \eta) + \mu^2 \langle F_3 \rangle(\xi, \eta)$ are given by

(101)
$$\begin{cases} \xi_{\tau} = -\left(1 + \frac{3}{4}[\eta^{2}]\right) \partial_{y_{1}}\xi - \frac{\mu^{2}}{24} \partial_{y_{1}}^{3}\xi - \frac{\mu^{2}\beta}{4} \partial_{y_{1}}(\xi^{3}) \\ \eta_{\tau} = \left(1 + \frac{3}{4}[\xi^{2}]\right) \partial_{y_{1}}\eta + \frac{\mu^{2}}{24} \partial_{y_{1}}^{3}\eta + \frac{\mu^{2}\beta}{4} \partial_{y_{1}}(\eta^{3}) \end{cases}$$

which is a system of two uncoupled mKdV equations in translating frames with respect to the y_1 -direction. The integrability properties of the mKdV equation and the existence of Birkhoff coordinates for this model have been proved in [KST08].

4.3. The one-dimensional NLS regime for the KG Lattice. We want to study small amplitude solutions of (22), with initial data in which only one low-frequency Fourier mode is excited.

Analogously to the procedure of the previous Sections, the first step is to introduce an interpolating function Q = Q(t, x) such that

- (B1) $Q(t,j) = Q_j(t)$, for all $j \in \mathbb{Z}^2_{N_1,N_2}$;
- (B2) Q is periodic with period $2N_1 + 1$ in the x_1 -variable, and periodic with period $2N_2 + 1$ in the x_2 -variable;
- (B3) Q fulfills

$$\ddot{Q} = \Delta_1 Q - Q - \beta Q^{2p+1},$$

where Δ_1 is the operator defined in (63) (recall that we also assumed m=1 in (21)).

It is easy to verify that (102) is Hamiltonian with Hamiltonian function

(103)
$$\mathsf{H}_{\mathrm{KG}}(Q,P) = \int_{\left[-\frac{1}{\mu},\frac{1}{\mu}\right]\times\left[-\frac{1}{\mu^{\sigma}},\frac{1}{\mu^{\sigma}}\right]} \left(\frac{P^{2}}{2} + \frac{Q^{2}}{2} - \frac{Q\Delta_{1}Q}{2} + \beta\frac{Q^{2p+2}}{2p+2}\right) \,\mathrm{d}x,$$

where P is a periodic function and is canonically conjugated to Q.

Starting from the Hamiltonian (20), where p = 1, we look for small amplitude solutions of the form

(104)
$$Q(t,x) = \mu q(\mu^2 t, \mu x_1, \mu^{\sigma} x_2).$$

where $q: \mathbb{R} \times \mathbb{T}^2 \to \mathbb{R}$ is a periodic function and σ, μ are defined respectively in (12)-(11).

We introduce the rescaled variables $\tau = \mu^2 t$, $y_1 = \mu x_1$ and $y_2 = \mu^{\sigma} x_2$, and we define I as in (69). The Hamiltonian (20) in the rescaled variables is given by

(105)
$$\mathsf{K}_4(q,p) = \int_I \left(\frac{p^2}{2} + \frac{q^2}{2} - \frac{q \, \Delta_{\mu,y_1,\sigma} q}{2} + \beta \mu^2 \frac{q^4}{4} \right) \, \mathrm{d}y,$$

with the operator $\Delta_{\mu,y_1,\sigma}$ as in (86), and p is the variable canonically conjugated to q. The corresponding equation of motion is given by

(106)
$$q_{\tau\tau} = -q + \Delta_{\mu, y_1, \sigma} q - \beta \mu^2 q^3.$$

Recalling (89), we have that the Hamiltonian (105) admits the following asymptotic expansion

(107)
$$\mathsf{K}_{4}(q,p) \sim \hat{\mathsf{h}}_{4}(q,p) + \mu^{2}\hat{\mathsf{F}}_{4}(q,p) + \mu^{\min(2\sigma,4)}\hat{\mathcal{R}}(q,p),$$

(108)
$$\hat{\mathsf{h}}_4(q,p) = \int_I \frac{p^2 + q^2}{2} \, \mathrm{d}y, \quad \hat{\mathsf{F}}_4(q,p) = \int_I \left(-\frac{q \, \partial_{y_1}^2 q}{2} + \beta \frac{q^4}{4} \right) \, \mathrm{d}y,$$

and the equation of motion associated to $\hat{h}_4 + \mu^2 \hat{F}_4$ is given by the following cubic one-dimensional nonlinear Klein-Gordon (NLKG) equation,

(109)
$$q_{\tau\tau} = -(q - \mu^2 \partial_{y_1}^2 q) - \mu^2 \beta q^3.$$

We now exploit the change of coordinates $(q,p)\mapsto (\psi,\bar{\psi})$ given by

(110)
$$\psi = \frac{1}{\sqrt{2}}(q - ip),$$

therefore the inverse change of coordinates is given by

(111)
$$q = \frac{1}{\sqrt{2}}(\psi + \bar{\psi}), \quad p = \frac{i}{\sqrt{2}}(\psi - \bar{\psi}),$$

while the symplectic form is given by $-i d\psi \wedge d\bar{\psi}$. With this change of variables the Hamiltonian takes the form

(112)
$$\mathsf{K}_{4}(\psi, \bar{\psi}) \sim \mathsf{h}_{4}(\psi, \bar{\psi}) + \mu^{2} \mathsf{F}_{4}(\psi, \bar{\psi}) + \mu^{\min(2\sigma, 4)} \mathcal{R}(\psi, \bar{\psi}),$$

(113)
$$\mathsf{h}_4(\psi,\bar{\psi}) = \int_I \psi \,\bar{\psi} \,\mathrm{d}y, \quad \mathsf{F}_4(\psi,\bar{\psi}) = \int_I \left(-\frac{(\psi+\bar{\psi})\left[-\partial_{y_1}^2(\psi+\bar{\psi})\right]}{4} + \beta \frac{(\psi+\bar{\psi})^4}{16} \right) \,\mathrm{d}y.$$

Now we apply the averaging Theorem 3.3 to the Hamiltonian (112), with $\delta = \mu^2$, $\nu = \min(\sigma - 1, 1)$. Observe that h_4 generates a periodic flow,

(114)
$$-i\partial_{\tau}\psi = \psi; \quad \psi(\tau, y) = e^{i\tau}\psi_0(y).$$

Proposition 4.7. The average of F_4 in (112) with respect to the flow of h_4 (108) is given by

(115)
$$\left\langle \mathsf{F}_{4}\right\rangle (\psi,\bar{\psi}) = \int_{I} \frac{\bar{\psi}\left(-\partial_{y_{1}}^{2}\psi\right)}{2} \mathrm{d}y + \frac{3\beta}{8} \int_{I} \left|\psi\right|^{4} \mathrm{d}y.$$

Corollary 4.8. The equations of motion associated to $h_4(\psi, \bar{\psi}) + \mu^2 \langle F_4 \rangle (\psi, \bar{\psi})$ are given by a cubic one-dimensional nonlinear Schrödinger equation for each fixed value of y_2 ,

(116)
$$-i\psi_{\tau} = \psi - \mu^2 \, \partial_{y_1}^2 \psi + \mu^2 \frac{3\beta}{4} \, |\psi|^2 \psi.$$

Remark 4.9. If we apply the above argument to the Hamiltonian (20) in the regime

(2-D NLS) the scalar model (20) with m=1, p=1 and $Q(t,x)=\mu\,q(\mu^2t,\mu x)$, where $\mu\ll 1$ and $\sigma=1$, we can obtain as a normal form equation the cubic nonlinear Schrödinger (NLS) equation

(117)
$$-i\psi_{\tau} = \psi - \mu^2 \Delta \psi + \mu^2 \frac{3\beta}{4} |\psi|^2 \psi.$$

5. Dynamics of the normal form equation

5.1. **The KP equation.** In this Section we recall some known facts on the dynamics of the KP equation on the two-dimensional torus

(118)
$$\xi_{\tau} = -\frac{1}{24} \partial_{y_1}^3 \xi - \frac{1}{2} \partial_{y_1}^{-1} \partial_{y_2}^2 \xi - \frac{\alpha}{2\sqrt{2}} \partial_{y_1}(\xi^2), \ \alpha = \pm 1, \ y \in \mathbb{T}^2 := \mathbb{R}^2 / (2\pi \mathbb{Z})^2.$$

The KP equation has been introduced in order to describe weakly-transverse solutions of the water waves equations; it has been considered as a two-dimensional analogue of the KdV equation, since also the KP equation admits an infinite number of constants of motions [LC82] [CLL83] [CL87]. It is customary to refer to (118) as KP-I equation when $\alpha = -1$, and as KP-II equation when $\alpha = 1$.

The global-well posedness for the KP-II equation on the two-dimensional torus has been discussed by Bourgain in [Bou93]. The main point of the result by Bourgain consists in extending the local well-posedness result to a global one, even though the L^2 -norm is the only constant of motion for the KP-II equation that allows an a-priori bound for the solution (see Theorem 8.10 and Theorem 8.12 in [Bou93]).

Theorem 5.1. Consider (118) with $\alpha = 1$.

Let $\rho \geq 0$ and $s \geq 0$, and assume that the initial datum $\xi(0,\cdot,\cdot) = \xi_0 \in \ell^2_{\rho,s}$. Then (118) is globally well-posed in $\ell^2_{\rho,s}$. Moreover, the ℓ^2 -norm of the solution is conserved,

(119)
$$\|\xi(t)\|_{\ell^2} = \|\xi_0\|_{\ell^2},$$

while

(120)
$$\|\xi(t)\|_{\ell^2_0} \le e^{C|t|} \|\xi_0\|_{\ell^2_0},$$

where C depends on s.

Remark 5.2. As pointed out by Bourgain in Sec. 10.2 of [Bou93], a global well-posedness result for sufficiently smooth solution of the KP-I equation (namely, (118) with $\alpha = -1$) on the two-dimensional torus can be obtained by generalizing the argument in [SJ87] for small data and by using the a-priori bounds given by the constants of motion for the KP-I equation.

Last, we mention that for the KP equation the construction of action-angle/Birkhoff coordinates is still an open problem.

5.2. **The KdV equation.** In this Section we recall some known facts on the dynamics of the KdV equation with periodic boundary conditions. The interested reader can find more detailed explanations and proofs in [KP03].

Consider the KdV equation

(121)
$$\xi_{\tau} = -\frac{1}{24} \partial_{y_1}^3 \xi - \frac{\alpha}{2\sqrt{2}} \partial_{y_1}(\xi^2), \qquad y_1 \in [0, 2].$$

Through the Lax pair formulation of the evolution problem (121) one get that the periodic eigenvalues $(\lambda_n)_{n\in\mathbb{N}}$ of the Sturm-Liouville operator

(122)
$$L_{\xi} := -\partial_{y_1}^2 + 6\sqrt{2}\xi(\tau, y_1)$$

are conserved quantities under the evolution of the KdV equation (121). Moreover, if we define the gaps of the spectrum $\gamma_m := \lambda_{2m} - \lambda_{2m-1}$ $(m \ge 1)$, it is well known that the squared spectral gaps $(\gamma_m^2)_{m \ge 1}$ form a complete set of constants of motion for (121).

The following relation between the sequence of the spectral gaps and the regularity of the corresponding solution to the KdV equation holds (see Theorem 9, Theorem 10 and Theorem 11 in [KP08]; see also [Pös11])

Theorem 5.3. Assume that $\xi \in L^2$, then $\xi \in \ell^2_{0,s}$ if and only if its spectral gaps satisfy

$$\sum_{m\geq 1} m^{2s} |\gamma_m|^2 < +\infty.$$

Moreover if $\xi \in \ell^2_{\rho,s}$, then

(123)
$$\sum_{m>1} m^{2s} e^{2\rho m} |\gamma_m|^2 < +\infty;$$

conversely, if (123) holds, then $\xi \in \ell^2_{\rho',0}$ for some $\rho' > 0$.

Kappeler and Pöschel constructed the following global Birkhoff coordinates (see Theorem 1.1 in [KP03])

Theorem 5.4. There exists a diffeomorphism $\Omega: L^2 \to \ell^2_{0,1/2} \times \ell^2_{0,1/2}$ such that:

- Ω is bijective, bianalytic and canonical;
- for each $s \geq 0$, the restriction of Ω to $\ell_{0,s}^2$, namely the map

$$\Omega: \ell_{0,s}^2 \to \ell_{0,s+1/2}^2 \times \ell_{0,s+1/2}^2$$

is bijective, bianalytic and canonical;

• the coordinates $(x,y) \in \ell_{0,3/2}^2 \times \ell_{0,3/2}^2$ are Birkhoff coordinates for the KdV equation, namely they form a set of canonically conjugated coordinates in which the Hamiltonian of the KdV equation (121) depends only on the action $I_m := \frac{x_m^2 + y_m^2}{2}$ $(m \ge 1)$.

The dynamics of the KdV equation (121) in terms of the variables (x, y) is trivial: it can be immediately seen that any solution is periodic, quasiperiodic or almost periodic, depending on the number of spectral gaps (equivalently, depending on the number of actions) initially different from zero.

5.3. The one-dimensional cubic NLS equation. In this Section we recall some known facts on the dynamics of the one-dimensional cubic defocusing NLS equation with periodic boundary conditions. The interested reader can find more detailed explanations and proofs in [GKK14] [Mol14].

Consider the cubic defocusing NLS equation

(124)
$$i\psi_{\tau} = -\partial_{y_1}^2 \psi + 2|\psi|^2 \psi, \qquad y_1 \in \mathbb{T} := \mathbb{R}/(2\pi\mathbb{Z}).$$

Eq. (124) is a PDE admitting a Hamiltonian structure: indeed, we can set $\mathcal{H}^{\rho,s} = \ell_{\rho,s}^2 \times \ell_{\rho,s}^2$ as the phase space with elements denoted by $\phi = (\phi_1, \phi_2)$, while the associated Poisson bracket and the Hamiltonian are given by

(125)
$$\{\mathsf{F},\mathsf{G}\} := -\mathrm{i} \int_{\pi} (\partial_{\phi_1} \mathsf{F} \, \partial_{\phi_2} \mathsf{G} - \partial_{\phi_1} \mathsf{G} \, \partial_{\phi_2} \mathsf{F}) \, \mathrm{d}y_1,$$

(126)
$$\mathsf{H}_{\mathrm{NLS}}(\phi_1, \phi_2) := \int_{\mathbb{T}} \left(\partial_{y_1} \phi_1 \, \partial_{y_1} \phi_2 + \phi_1^2 \phi_2^2 \right) \, \mathrm{d}y_1.$$

The defocusing NLS equation (124) is obtained by restricting (126) to the invariant subspace of states of real type,

(127)
$$\mathcal{H}_r^{\rho,s} := \{ \phi \in \mathcal{H}^{\rho,s} : \phi_2 = \bar{\phi}_1 \}.$$

The above Hamiltonian (126) is well-defined on $\mathcal{H}^{\rho,s}$ with $s \geq 1$ and $\rho \geq 0$, while the initial value problem for the NLS equation (124) is well-posed on $\mathcal{H}^{0,0} = \ell^2 \times \ell^2$.

It is well known from the work by Zakharov and Shabat that the NLS equation (124) has a Lax pair, and that it admits infinitely many constants of motion in involution. More precisely, for any $\phi \in \mathcal{H}^{0,0}$ consider the Zakharov-Shabat operator

(128)
$$L(\phi) = \begin{pmatrix} i & 0 \\ 0 & -i \end{pmatrix} \partial_{y_1} + \begin{pmatrix} 0 & \phi_1 \\ \phi_2 & 0 \end{pmatrix},$$

where we call ϕ the potential of the operator $L(\phi)$. The spectrum of $L(\phi)$ on the interval [0, 2] with periodic boundary conditions is pure point, and it consists of the following sequence of periodic eigenvalues

(129)
$$\cdots < \lambda_{-1}^{-} \le \lambda_{-1}^{+} < \lambda_{0}^{-} \le \lambda_{0}^{+} < \lambda_{1}^{-} \le \lambda_{1}^{+} < \cdots,$$

where the quantities $\gamma_m := \lambda_m^+ - \lambda_m^ (m \in \mathbb{Z})$ are called gap lengths. It has been proved that the squared spectral lengths $(\gamma_m^2)_{m \in \mathbb{Z}}$ form a complete set of analytic constants of motion for (124).

Grébert, Kappeler and Mityagin proved the following relation between the sequence of the squared spectral gaps and the regularity of the corresponding potential (see Theorem in [GKM98]).

Theorem 5.5. Let $\rho \geq 0$ and s > 0, then for any bounded subset $\mathcal{B} \subset \ell_{\rho,s}^2 \times \ell_{\rho,s}^2$ there exists $n_0 \geq 1$ and $M \geq 1$ such that for any $|k| \geq n_0$ and any $(\phi_1, \phi_2) \in \mathcal{B}$, the following estimate holds

(130)
$$\sum_{|k| \ge n_0} (1+|k|)^{2s} e^{2\rho|k|} |\gamma_m|^2 \le M.$$

Moreover, Grébert and Kappeler constructed the following global Birkhoff coordinates (see Theorem 20.1 - Theorem 20.3 in [GKK14])

Theorem 5.6. There exists a diffeomorphism $\Omega: L_r^2 \to \mathcal{H}_r^{0,0}$ such that:

- Ω is bianalytic and canonical;
- for each $s \geq 0$, the restriction of Ω to $\mathcal{H}_r^{0,s}$, namely the map

$$\Omega: \mathcal{H}_r^{0,s} \to \mathcal{H}_r^{0,s}$$

is again bianalytic and canonical;

• the coordinates $(x,y) \in \mathcal{H}_r^{0,1}$ are Birkhoff coordinates for the NLS equation, namely they form a set of canonically conjugated coordinates in which the Hamiltonian of the NLS equation (124) depends only on the action $I_m := \frac{x_m^2 + y_m^2}{2}$ $(m \in \mathbb{Z})$.

The dynamics of the NLS equation (124) in terms of the variables (x, y) is trivial: it can be immediately seen that any solution is periodic, quasiperiodic or almost periodic, depending on the number of spectral gaps (equivalently, depending on the number of actions) initially different from zero.

6. Approximation results

In this Section we show how to use the normal form equations in order to construct approximate solutions of (5) and (22), and we estimate the difference with respect to the true solutions with corresponding initial data

The approach is the same for all regimes (65), (85) and (104). First, we point out a relation between the specific energy of normal mode $\mathcal{E}_{\kappa} = 2E_k/N$ (where the energy of normal mode E_k is defined in (7) for (5), and in (23) for (22)), $k \in \mathbb{Z}^2_{N_1,N_2}$, and the Fourier coefficients of the solutions of the normal form equations. This procedure has to be done carefully, since all wavevectors $k + (N_1L_1, N_2L_2)$ contributes to the specific energy \mathcal{E}_{κ} of the discrete system. Then we have to prove that the approximate solutions approximate the specific energy of the true normal mode \mathcal{E}_{κ} up to the time-scale for which the continuous approximation is valid, and finally we can deduce the result about the dynamics of the lattice. For simplicity we present in this Section only the main part of the argument, and we defer the proof of technical results to Appendices B-E.

6.1. The KP regime. Let $I = [-1, 1]^2$ be as in (69) and let $k = (k_1, k_2) \in \mathbb{Z}^2$. We define the Fourier coefficients of the function $q: I \to \mathbb{R}$ by

(131)
$$\hat{q}_k := \frac{1}{2} \int_I q(y_1, y_2) e^{-i\pi(k_1 y_1 + k_2 y_2)} dy_1 dy_2,$$

and similarly for the Fourier coefficients of the function p. Note that in this definition we omitted an eventual time dependence because we are interested in relations among quantities for points in the phase space, i.e. pairs of functions $(q, p): I \to \mathbb{R}$. These relations extend automatically to trajectories and, in fact, this will be the subject of the last result of each subsection.

Lemma 6.1. Consider the lattice (2) in the regime (KP) and with interpolating function (65). Then for a state corresponding to (q, p) one has

(132)
$$\mathcal{E}_{\kappa} = \frac{\mu^4}{2} \sum_{L=(L_1,L_2) \in \mathbb{Z}^2: \mu L_1, \mu^2 L_2 \in 2\mathbb{Z}} \left(|\hat{q}_{K+L}|^2 + \omega_k^2 \left| \frac{\hat{p}_{K+L}}{\mu} \right|^2 \right), \quad \forall k : \kappa(k) = (\mu K_1, \mu^2 K_2)$$

(where the ω_k are defined as in (8)), and $\mathcal{E}_{\kappa} = 0$ otherwise.

Proof. Take a smooth $(2N_1 + 1, 2N_2 + 1)$ -periodic interpolating function Q for Q_j , and similarly for P_j . We denote by

(133)
$$\hat{Q}(k) := \frac{1}{\sqrt{N}} \int_{\left[-\left(N_1 + \frac{1}{2}\right), \left(N_1 + \frac{1}{2}\right)\right] \times \left[-\left(N_2 + \frac{1}{2}\right), \left(N_2 + \frac{1}{2}\right)\right]} Q(x) e^{-2\pi i \frac{k \cdot x}{N}} dx,$$

so that by the interpolation property we obtain

$$\begin{split} Q_j &= Q(j) \, = \, \frac{1}{\sqrt{N}} \sum_{k \in \mathbb{Z}^2} \hat{Q}(k) e^{2\pi \mathrm{i} \frac{j \cdot k}{N}} \\ &= \frac{1}{\sqrt{N}} \sum_{k = (k_1, k_2) \in \mathbb{Z}^2_{2N_1 + 1, 2N_2 + 1}} \left[\sum_{h = (h_1, h_2) \in \mathbb{Z}^2} \hat{Q}(k_1 + (2N_1 + 1)h_1, k_2 + (2N_2 + 1)h_2) \right] \, e^{2\pi \mathrm{i} \frac{j \cdot k}{N}}, \end{split}$$

hence

(134)
$$\hat{Q}_K = \sum_{h \in \mathbb{Z}^2} \hat{Q}(K_1 + (2N_1 + 1)h_1, K_2 + (2N_2 + 1)h_2).$$

The relation between $\hat{Q}(k)$ and \hat{q}_k can be deduced from (65) and from the rescalings $\tau = \mu t$, $y_1 = \mu x_1$, $y_2 = \mu^2 x_2$,

$$Q(j) = \mu^{2} q(\mu j_{1}, \mu^{2} j_{2});$$

$$\hat{Q}(k) = \frac{1}{2} \mu^{3/2} \int_{\left[-\frac{1}{\mu}, \frac{1}{\mu}\right] \times \left[-\frac{1}{\mu^{2}}, \frac{1}{\mu^{2}}\right]} Q(x_{1}, x_{2}) e^{-i\pi(k_{1}x_{1}\mu + k_{2}x_{2}\mu^{2})} dx_{1} dx_{2}$$

$$= \frac{1}{2} \mu^{3/2} \int_{\left[-\frac{1}{\mu}, \frac{1}{\mu}\right] \times \left[-\frac{1}{\mu^{2}}, \frac{1}{\mu^{2}}\right]} \mu^{2} q(\mu x_{1}, \mu^{2} x_{2}) e^{-i\pi(k_{1}x_{1}\mu + k_{2}x_{2}\mu^{2})} dx_{1} dx_{2}$$

$$\stackrel{(85)}{=} \frac{1}{2} \mu^{1/2} \int_{I} q(y) e^{-i\pi(k_{1}y_{1} + k_{2}y_{2})} dy = \mu^{1/2} \hat{q}_{k},$$

$$(135)$$

and similarly

$$\hat{P}(k) = \mu^{-1/2} \hat{p}_k$$

By using (7), (10) and (134)-(136) we have

$$\begin{split} \mathcal{E}_{\kappa} &\overset{(10)}{=} \mu^3 \, \frac{1}{2} \sum_{L = (L_1, L_2) \in \mathbb{Z}^2 : \mu L_1, \mu^2 L_2 \in 2\mathbb{Z}} \left(|\hat{Q}(K+L)|^2 + \omega_k^2 |\hat{P}(K+L)|^2 \right) \\ &\overset{(135)}{=} \mu^4 \frac{1}{2} \sum_{L = (L_1, L_2) \in \mathbb{Z}^2 : \mu L_1, \mu^2 L_2 \in 2\mathbb{Z}} \left(|\hat{q}_{K+L}|^2 + \omega_k^2 \left| \frac{\hat{p}_{K+L}}{\mu} \right|^2 \right) \end{split}$$

for all k such that $\kappa(k) = (\mu K_1, \mu^2 K_2)$, and this leads to (132).

Proposition 6.2. Fix $\rho > 0$ and $0 < \delta \ll 1$. Consider the normal form system (84), and define the Fourier coefficients of (ξ, η) through the following formula

(137)
$$\xi(y) = \frac{1}{2} \sum_{h \in \mathbb{Z}^2} \hat{\xi}_h \, e^{i\pi h \cdot y},$$

(138)
$$\eta(y) = \frac{1}{2} \sum_{h \in \mathbb{Z}^2} \hat{\eta}_h e^{i\pi h \cdot y},.$$

Suppose that $(\xi, \eta) \in \mathcal{H}^{\rho,0}$, and denote by \mathcal{E}_{κ} the specific energy of the normal mode with index κ as defined in (9)-(10). Then for any positive μ sufficiently small

(139)
$$\left| \mathcal{E}_{\kappa} - \mu^{4} \frac{|\hat{\xi}_{K}|^{2} + |\hat{\eta}_{K}|^{2}}{2} \right| \leq C \mu^{4+3/2} \|(\xi, \eta)\|_{\mathcal{H}^{\rho, 0}}^{2}$$

for all k such that $\kappa(k) = (\mu K_1, \mu^2 K_2)$ and $|K_1| + |K_2| \leq \frac{(2+\delta)|\log \mu|}{\rho}$. Moreover,

$$|\mathcal{E}_{\kappa}| \le C \,\mu^8 \|(\xi, \eta)\|_{\mathcal{H}^{\rho, 0}}^2$$

for all k such that $\kappa(k) = (\mu K_1, \mu^2 K_2)$ and $|K_1^2 + K_2^2|^{1/2} > \frac{(2+\delta)|\log \mu|}{\rho}$, and $\mathcal{E}_{\kappa} = 0$ otherwise.

The proof of the above Proposition is deferred to Appendix B.

Now, consider the following system of uncoupled KP equations

(141)
$$\xi_{\tau} = -\frac{1}{24} \partial_{y_1}^3 \xi - \frac{1}{2} \partial_{y_1}^{-1} \partial_{y_2}^2 \xi - \frac{\alpha}{2\sqrt{2}} \partial_{y_1}(\xi^2),$$

(142)
$$\eta_{\tau} = \frac{1}{2} \partial_{y_1}^{-1} \partial_{y_2}^2 \eta + \frac{1}{24} \partial_{y_1}^3 \eta + \frac{\alpha}{2\sqrt{2}} \partial_{y_1} (\eta^2).$$

and consider a solution $(\tau, y) \mapsto (\widetilde{\xi}_a(\tau, y), \widetilde{\eta}_a(\tau, y))$ such that it belongs to $\mathcal{H}^{\rho, n}$, for some $n \geq 1$. We consider the approximate solutions (Q_a, P_a) of the ETL model (62)

(143)
$$Q_a(t,y) := \frac{\mu^2}{\sqrt{2}} \left[\widetilde{\xi}_a(\mu^2 \tau, y_1 - \tau, y_2) + \widetilde{\eta}_a(\mu^2 \tau, y_1 + \tau, y_2) \right]$$

(144)
$$\partial_{y_1} P_a(t, y) := \frac{\mu}{\sqrt{2}} \left[\tilde{\xi}_a(\mu^2 \tau, y_1 - \tau, y_2) - \tilde{\eta}_a(\mu^2 \tau, y_1 + \tau, y_2) \right],$$

where we made a little abuse of notation since the left-hand side depends on t and right-hand side on τ that are related as $\tau = \mu t$.

We need to compare the difference between the approximate solution (143)-(144) and the true solution of (5). Let us consider (5), and take an initial datum (Q_0, P_0) with corresponding Fourier coefficients $(\hat{Q}_{0,k}, \hat{P}_{0,k})$ given by (6). Observe that

(145)
$$\hat{Q}_{0,k} \neq 0$$
 only if $\kappa(k) = (\mu K_1, \mu^2 K_2)$.

and that, as a consequence of the analiticity of Q_0 and P_0 , there exist C, $\rho > 0$ such that

(146)
$$\frac{|\hat{Q}_{0,k}|^2 + \omega_k^2 |\hat{P}_{0,k}|^2}{N} \le Ce^{-2\rho|(\kappa_1(k)/\mu, \kappa_2(k)/\mu^2)|}.$$

Moreover, we define an interpolating function for the initial datum (Q_0, P_0) by

$$Q_0(y) = \frac{1}{\sqrt{N}} \sum_{K: (\mu^2 |K_1|^2 + \mu^4 |K_2|^2)^{1/2} = |\kappa(k)| \le 1} \hat{Q}_{0,k} e^{i\pi(\mu K_1 y_1 + \mu^2 K_2 y_2)},$$

and similarly for $y \mapsto P_0(y)$.

Next we show that we can exploit the analiticity of the solution of the approximating integrable PDEs to prove the vicinity between the approximate solution and the true solution.

Proposition 6.3. Consider (5) with $\sigma = 2$, and fix $0 < \gamma < \frac{1}{2}$. Let us assume that the initial datum for (5) satisfies (145)-(146), and denote by $(Q_j(t), P_j(t))_{j \in \mathbb{Z}^2_{N_1, N_2}}$ the corresponding solution. Consider the approximate solution $(\widetilde{\xi_a}, \widetilde{\eta_a})$ with the corresponding initial datum. Assume that $(\widetilde{\xi_a}, \widetilde{\eta_a}) \in \mathcal{H}^{\rho, n}$ for some $\rho > 0$ and for some $n \geq 1$ for all times, and fix $T_0 > 0$ and $0 < \delta \ll 1$.

Then there exists $\mu_0 = \mu_0(T_0, \|(\xi_a(0), \widetilde{\eta_a}(0))\|_{\mathcal{H}^{\rho,n}})$ such that, if $\mu < \mu_0$, we have that there exists C > 0 such that

(147)
$$\sup_{j} |Q_{j}(t) - Q_{a}(t,j)| + |P_{j}(t) - P_{a}(t,j)| \le C\mu^{\gamma}, \qquad \forall |t| \le \frac{T_{0}}{\mu^{3}},$$

where (Q_a, P_a) are given by (143)-(144). Moreover,

(148)
$$\left| \mathcal{E}_{\kappa}(t) - \mu^4 \frac{|\hat{\xi}_K(\tau)|^2 + |\hat{\eta}_K(\tau)|^2}{2} \right| \le C\mu^{4+\gamma} \qquad \forall |t| \le \frac{T_0}{\mu^3}$$

for all k such that $\kappa(k) = (\mu K_1, \mu^2 K_2)$ and $|K_1| + |K_2| \leq \frac{(2+\delta)|\log \mu|}{\rho}$. Moreover,

(149)
$$|\mathcal{E}_{\kappa}(\tau)| \le \mu^{4+\gamma} \qquad \forall |t| \le \frac{T_0}{\mu^3}$$

for all k such that $\kappa(k) = (\mu K_1, \mu^2 K_2)$ and $|K_1| + |K_2| > \frac{(2+\delta)|\log \mu|}{\rho}$, and $\mathcal{E}_{\kappa} = 0$ otherwise.

The proof of the above Proposition is deferred to Appendix C.

Proof of Theorem 2.1. First we prove (14).

We consider an initial datum as in (13); when passing to the continuous approximation (62), this initial datum corresponds to an initial data $(\xi_0, \eta_0) \in \mathcal{H}^{\rho_0, n}$ for some $\rho_0 > 0$ and $n \ge 1$. By Theorem 5.1 the corresponding solution $(\xi(\tau), \eta(\tau))$ is analytic in a complex strip of width $\rho(t)$. Taking the minimum of such quantities one gets the coefficient ρ appearing in the statement of Theorem (2.1). Applying Proposition 6.3, we can deduce the corresponding result for the discrete model (5) and the specific quantities (10).

6.2. The KdV regime. Similarly to Lemma 6.1, Proposition 6.2 we can prove the following results

Lemma 6.4. Consider the lattice (2) in the regime (KdV) and with interpolating function (85). Then for a state corresponding to (q, p) one has

$$\mathcal{E}_{\kappa} = \frac{\mu^4}{2} \sum_{L=(L_1, L_2) \in \mathbb{Z}^2: \mu L_1, \mu^{\sigma} L_2 \in 2\mathbb{Z}} \left(|\hat{q}_{K+L}|^2 + \omega_k^2 \left| \frac{\hat{p}_{K+L}}{\mu} \right|^2 \right), \quad \forall k : \kappa(k) = (\mu K_1, \mu^{\sigma} K_2)$$

(where the ω_k are defined as in (8) and the \mathcal{E}_{κ} in (10)), and $\mathcal{E}_{\kappa} = 0$ otherwise.

Proof. As in Lemma 6.4 we introduce a $(2N_1 + 1, 2N_2 + 1)$ -periodic interpolating function for Q_j and P_j . We denote $\hat{Q}(t,k)$ and $\hat{Q}_K(t)$ as in (133) and (134).

The relation between $\hat{Q}(k)$ and \hat{q}_k can be deduced from (85) and from the rescalings $y_1 = \mu x_1$, $y_2 = \mu^{\sigma} x_2$,

$$Q(j) = \mu^{2} q(\mu j_{1}, \mu^{\sigma} j_{2});$$

$$\hat{Q}(k) = \frac{1}{2} \mu^{(\sigma+1)/2} \int_{\left[-\frac{1}{\mu}, \frac{1}{\mu}\right] \times \left[-\frac{1}{\mu^{\sigma}}, \frac{1}{\mu^{\sigma}}\right]} Q(x_{1}, x_{2}) e^{-i\pi(k_{1}x_{1}\mu + k_{2}x_{2}\mu^{\sigma})} dx_{1} dx_{2}$$

$$= \frac{1}{2} \mu^{(\sigma+1)/2} \int_{\left[-\frac{1}{\mu}, \frac{1}{\mu}\right] \times \left[-\frac{1}{\mu^{\sigma}}, \frac{1}{\mu^{\sigma}}\right]} \mu^{2} q(\mu x_{1}, \mu^{\sigma} x_{2}) e^{-i\pi(k_{1}x_{1}\mu + k_{2}x_{2}\mu^{\sigma})} dx_{1} dx_{2}$$

$$(151) \qquad \stackrel{(85)}{=} \frac{1}{2} \mu^{(3-\sigma)/2} \int_{I} q(y) e^{-i\pi(k_{1}y_{1} + k_{2}y_{2})} dy = \mu^{(3-\sigma)/2} \hat{q}_{k},$$

and similarly

(152)
$$\hat{P}(k) = \mu^{(1-\sigma)/2} \hat{p}_k.$$

By using (7), (10) and (151)-(152) we have

$$\mathcal{E}_{\kappa} \stackrel{(10)}{=} \mu^{\sigma+1} \frac{1}{2} \sum_{L=(L_{1},L_{2}) \in \mathbb{Z}^{2}: \mu L_{1}, \mu^{\sigma} L_{2} \in 2\mathbb{Z}} \left(|\hat{Q}(K+L)|^{2} + \omega_{k}^{2} |\hat{P}(K+L)|^{2} \right)$$

$$\stackrel{(151),(151)}{=} \mu^{\sigma+1} \mu^{3-\sigma} \frac{1}{2} \sum_{L=(L_{1},L_{2}) \in \mathbb{Z}^{2}: \mu L_{1}, \mu^{\sigma} L_{2} \in 2\mathbb{Z}} \left(|\hat{q}_{K+L}|^{2} + \omega_{k}^{2} \left| \frac{\hat{p}_{K+L}}{\mu} \right|^{2} \right)$$

for all k such that $\kappa(k) = (\mu K_1, \mu^{\sigma} K_2)$, and this leads to (150).

Proposition 6.5. Fix $\rho > 0$ and $0 < \delta \ll 1$. Consider the normal form system (96), and define the Fourier coefficients of (ξ, η) through the following formula

(153)
$$\xi(y) = \frac{1}{2} \sum_{h \in \mathbb{Z}^2} \hat{\xi}_h e^{i\pi h \cdot y},$$

(154)
$$\eta(y) = \frac{1}{2} \sum_{b \in \mathbb{Z}^2} \hat{\eta}_b e^{i\pi h \cdot y},.$$

Suppose that $(\xi, \eta) \in \mathcal{H}^{\rho,0}$, and denote by \mathcal{E}_{κ} the specific energy of the normal mode with index κ as defined in (9)-(10). Then for any positive μ sufficiently small

(155)
$$\left| \mathcal{E}_{\kappa} - \mu^4 \frac{|\hat{\xi}_K|^2 + |\hat{\eta}_K|^2}{2} \right| \le C\mu^{4+3/2} \|(\xi, \eta)\|_{\mathcal{H}^{\rho, 0}}^2$$

for all k such that $\kappa(k) = (\mu K_1, \mu^{\sigma} K_2)$ and $|K_1| + |K_2| \leq \frac{(2+\delta)|\log \mu|}{\rho}$. Moreover,

$$|\mathcal{E}_{\kappa}| \le C \,\mu^8 \|(\xi, \eta)\|_{\mathcal{H}^{\rho, 0}}^2$$

for all k such that $\kappa(k)=(\mu K_1,\mu^{\sigma}K_2)$ and $|K_1|+|K_2|>\frac{(2+\delta)|\log\mu|}{\rho}$, and $\mathcal{E}_{\kappa}=0$ otherwise.

We defer the proof of the above Proposition to Appendix B.

Now, consider the following system of uncoupled KdV equations

(157)
$$\xi_{\tau} = -\frac{1}{24} \partial_{y_1}^3 \xi - \frac{\alpha}{2\sqrt{2}} \partial_{y_1}(\xi^2),$$

(158)
$$\eta_{\tau} = \frac{1}{24} \partial_{y_1}^3 \eta + \frac{\alpha}{2\sqrt{2}} \partial_{y_1}(\eta^2),$$

and consider a solution $(\tau, y) \mapsto (\widetilde{\xi}_a(\tau, y), \widetilde{\eta}_a(\tau, y))$ such that it belongs to $\mathcal{H}^{\rho, n}$, for some $n \geq 1$.

We consider the approximate solutions (Q_a, P_a) of the FPU model (62) defined by formulas (143)-(144).

We need to compare the difference between the approximate solution (143)-(144) and the true solution of (5). Let us consider (5), and take an initial datum (Q_0, P_0) with corresponding Fourier coefficients $(\hat{Q}_{0,k}, \hat{P}_{0,k})$ given by (6); observe that

(159)
$$Q_{0,k} \neq 0 \text{ only if } \kappa(k) = (\mu K_1, \mu^{\sigma} K_2).$$

Since Q_0 and P_0 are analytic functions, there exist C, $\rho > 0$ such that

(160)
$$\frac{|\hat{Q}_{0,k}|^2 + \omega_k^2 |\hat{P}_{0,k}|^2}{(2N_1 + 1)(2N_2 + 1)} \le Ce^{-2\rho|(\kappa_1(k)/\mu, \kappa_2(k)/\mu^{\sigma})|}.$$

Moreover, we define an interpolating function for the initial datum (Q_0, P_0) by

$$Q_0(y,t) = \frac{1}{\sqrt{N}} \sum_{K: (\mu^2 |K_1|^2 + \mu^{2\sigma} |K_2|^2)^{1/2} = |\kappa(k)| < 1} \hat{Q}_{0,k}(t) e^{i\pi(\mu K_1 y_1 + \mu^{\sigma} K_2 y_2)},$$

and similarly for $y \mapsto P_0(y)$.

Proposition 6.6. Consider (5) with $\sigma > 2$ and $\gamma \ge 1$ such that $\sigma + 2\gamma < \min(4\sigma - 5, 7)$. Let us assume that the initial datum satisfies (159)-(160), and denote by (Q(t), P(t)) the corresponding solution. Consider the approximate solution $(\widetilde{\xi}_a(t,x), \widetilde{\eta}_a(t,x))$ with the corresponding initial datum. Assume that $(\widetilde{\xi}_a, \widetilde{\eta}_a) \in \mathcal{H}^{\rho,n}$ for some $\rho > 0$ and for some $n \ge 1$ for all times, and fix $T_0 > 0$ and $0 < \delta \ll 1$.

Then there exists $\mu_0 = \mu_0(T_0, \sigma, \|(\widetilde{\xi}_a(0), \widetilde{\eta}_a(0))\|_{\mathcal{H}^{\rho,n}})$ such that, if $\mu < \mu_0$, we have that there exists C > 0 such that

(161)
$$\sup_{j} |Q_{j}(t) - Q_{a}(t,j)| + |P_{j}(t) - P_{a}(t,j)| \le C\mu^{\gamma}, \qquad \forall |t| \le \frac{T_{0}}{\mu^{3}},$$

where (Q_a, P_a) are given by (143)-(144). Moreover,

(162)
$$\left| \mathcal{E}_{\kappa}(t) - \mu^4 \frac{|\hat{\xi}_K(\tau)|^2 + |\hat{\eta}_K(\tau)|^2}{2} \right| \le C \mu^{4+\gamma}, \qquad \forall |t| \le \frac{T_0}{\mu^3}$$

for all k such that $\kappa(k) = (\mu K_1, \mu^{\sigma} K_2)$ and $|K_1| + |K_2| \leq \frac{(2+\delta)|\log \mu|}{\rho}$. Moreover,

(163)
$$|\mathcal{E}_{\kappa}(t)| \le \mu^{4+\gamma}, \qquad \forall |t| \le \frac{T_0}{\mu^3}$$

for all k such that $\kappa(k) = (\mu K_1, \mu^{\sigma} K_2)$ and $|K_1| + |K_2| > \frac{(2+\delta)|\log \mu|}{\rho}$, and $\mathcal{E}_{\kappa} = 0$ otherwise.

We defer the proof to Appendix C.

Remark 6.7. The conditions $\sigma + 2\gamma < \min(4\sigma - 5, 7)$, which, together with $\gamma > 0$, implies the upper bound $\sigma < 7$ found in the statement of Theorem (2.5), is the consequence of a technical condition which allows to estimate the error in the proof of Proposition 6.6 (see Claim 2, together with (238)-(239)).

Proof of Theorem 2.5. First we prove (17).

We consider an initial datum as in (16); when passing to the continuous approximation (62), this initial datum corresponds to an initial data $(\xi_0, \eta_0) \in \mathcal{H}^{\rho_0, n}$ for some $\rho_0 > 0$ and $n \ge 1$. By Theorem 5.3 the corresponding sequence of gaps belongs to $\mathcal{H}^{\rho_0, n}$, and that the solution $(\xi(\tau), \eta(\tau))$ is analytic in a complex strip of width $\rho(t)$. Taking the minimum of such quantities one gets the coefficient ρ appearing in the statement of Theorem (2.5). Applying Proposition 6.6, we can deduce the corresponding result for the discrete model (5) and the specific quantities (10).

Next, we prove (19). In order to do so, we exploit the Birkhoff coordinates (x, y) introduced in Theorem 5.4; indeed, by rewriting the normal form system (96) in Birkhoff coordinates we get that every solution is almost-periodic in time. Now, let us introduce the quantities

$$E_K^{(1)} := \left| \hat{\xi}_K \right|^2,$$

 $E_K^{(2)} := \left| \hat{\eta}_K \right|^2,$

then $\tau \mapsto E_K^{(1)}(x(\tau), y(\tau))$ and $\tau \mapsto E_K^{(2)}(x(\tau), y(\tau))$ are almost-periodic. If we set $E_K := \frac{1}{2} \left(E_K^{(1)} + E_K^{(2)} \right)$, we can exploit (162) of Proposition 6.6 to translate the results in terms of the specific quantities \mathcal{E}_{κ} , and we get the thesis.

6.3. The one-dimensional NLS regime. Let $\beta > 0$ and let I be as in (69), we define the Fourier coefficients of the function $q: I \to \mathbb{R}$ by

(164)
$$\hat{q}_k := \frac{1}{2} \int_{\Gamma} q(y_1, y_2) e^{-i\pi(k_1 y_1 + k_2 y_2)} dy_1 dy_2,$$

and similarly for the Fourier coefficients of the function p.

Lemma 6.8. Consider the lattice (20) in the regime (1D NLS) and with interpolating function (104). Then for a state corresponding to (q, p) one has

(165)
$$\mathcal{E}_{\kappa} = \frac{\mu^{2}}{2} \sum_{L=(L_{1},L_{2})\in\mathbb{Z}^{2}:\mu L_{1},\mu^{\sigma}L_{2}\in2\mathbb{Z}} \left(|\hat{p}_{K+L}|^{2} + \omega_{k}^{2} |\hat{q}_{K+L}|^{2} \right), \qquad \forall k: \kappa(k) = (\mu K_{1},\mu^{\sigma}K_{2})$$

(where the ω_k are defined as in (24)), and $\mathcal{E}_{\kappa} = 0$ otherwise.

Proof. We introduce a $(2N_1 + 1, 2N_2 + 1)$ -periodic interpolating function for Q_j and P_j . We denote $\hat{Q}(t,k)$ and $\hat{Q}_k(t)$ as in (133) and (134). By the interpolation property we obtain (134).

The relation between $\hat{Q}(t, k)$ and $\hat{q}_k(t)$ can be deduced from (104) and from the rescalings $\tau = \mu t$, $y_1 = \mu x_1, y_2 = \mu^{\sigma} x_2$,

$$Q(j) = \mu q(\mu j_{1}, \mu^{\sigma} j_{2});$$

$$\hat{Q}(k) = \frac{1}{2} \mu^{(\sigma+1)/2} \int_{\left[-\frac{1}{\mu}, \frac{1}{\mu}\right] \times \left[-\frac{1}{\mu^{\sigma}}, \frac{1}{\mu^{\sigma}}\right]} Q(x_{1}, x_{2}) e^{-i\pi(k_{1}x_{1}\mu + k_{2}x_{2}\mu^{\sigma})} dx_{1} dx_{2}$$

$$\stackrel{(104)}{=} \frac{1}{2} \mu^{(\sigma+1)/2} \int_{\left[-\frac{1}{\mu}, \frac{1}{\mu}\right] \times \left[-\frac{1}{\mu^{\sigma}}, \frac{1}{\mu^{\sigma}}\right]} \mu q(\mu x_{1}, \mu^{\sigma} x_{2}) e^{-i\pi(k_{1}x_{1}\mu + k_{2}x_{2}\mu^{\sigma})} dx_{1} dx_{2}$$

$$= \frac{1}{2} \mu^{(1-\sigma)/2} \int_{I} q(y) e^{-i\pi(k_{1}y_{1} + k_{2}y_{2})} dy = \mu^{(1-\sigma)/2} \hat{q}_{k},$$

$$(166)$$

and similarly

(167)
$$\hat{P}(k) = \mu^{(1-\sigma)/2} \hat{p}_k.$$

By using (23), (10), (134) and (167) we have

$$\mathcal{E}_{\kappa} \stackrel{(10)}{=} \mu^{\sigma+1} \frac{1}{2} \sum_{L=(L_{1},L_{2}) \in \mathbb{Z}^{2}: \mu L_{1}, \mu^{\sigma} L_{2} \in 2\mathbb{Z}} \left(|\hat{P}(K+L)|^{2} + \omega_{k}^{2} |\hat{Q}(K+L)|^{2} \right)$$

$$\stackrel{(166)}{=} \mu^{\sigma+1} \mu^{1-\sigma} \frac{1}{2} \sum_{L=(L_{1},L_{2}) \in \mathbb{Z}^{2}: \mu L_{1}, \mu^{\sigma} L_{2} \in 2\mathbb{Z}} \left(|\hat{p}_{K+L}|^{2} + \omega_{k}^{2} |\hat{q}_{K+L}|^{2} \right)$$

for all k such that $\kappa(k) = (\mu K_1, \mu^{\sigma} K_2)$, and this leads to (165).

Proposition 6.9. Fix $\rho > 0$ and $0 < \delta \ll 1$. Consider the normal form equation (116), and define the Fourier coefficients of $(\psi, \bar{\psi})$ through the following formula

(168)
$$\psi(y) = \frac{1}{2} \sum_{h \in \mathbb{Z}^2} \hat{\psi}_h e^{i\pi h \cdot y},$$

Suppose that $(\psi, \bar{\psi}) \in \mathcal{H}^{\rho,0}$, and denote by \mathcal{E}_{κ} the specific energy of the normal mode with index κ as defined in (9)-(10). Then for any positive μ sufficiently small

(169)
$$\left| \mathcal{E}_{\kappa} - \mu^2 \frac{|\hat{\psi}_K|^2}{2} \right| \le C \mu^{2+3/2} \|(\psi, \bar{\psi})\|_{\mathcal{H}^{\rho,0}}^2$$

for all k such that $\kappa(k) = (\mu K_1, \mu^{\sigma} K_2)$ and $|K_1| + |K_2| \leq \frac{(2+\delta)|\log \mu|}{\rho}$. Moreover,

(170)
$$|\mathcal{E}_{\kappa}| \leq C \,\mu^{6} \|(\psi, \bar{\psi})\|_{\mathcal{H}^{\rho, 1}}^{2}$$

for all k such that $\kappa(k)=(\mu K_1,\mu^{\sigma}K_2)$ and $|K_1|+|K_2|>\frac{(2+\delta)|\log\mu|}{\rho},$ and $\mathcal{E}_{\kappa}=0$ otherwise.

We defer the proof of the above Proposition to Appendix D.

Now, consider the normal form equation, namely the following cubic defocusing one-dimensional NLS

(171)
$$-i\psi_{\tau} = -\partial_{y_1}^2 \psi + \frac{3\beta}{4} |\psi|^2 \psi.$$

and consider a solution $(\widetilde{\psi_a}, \overline{\widetilde{\psi_a}})$ such that it belongs to $\mathcal{H}^{\rho,n}$, for some n > 0.

We consider the approximate solutions (Q_a, P_a) of the KG lattice (20) (in the following $\tau = \mu^2 t$)

(172)
$$Q_{a}(t,y) := \frac{\mu}{\sqrt{2}} \left[e^{i\tau} \widetilde{\psi}_{a}(\tau, y_{1}, y_{2}) + e^{-i\tau} \overline{\widetilde{\psi}}_{a}(\tau, y_{1}, y_{2}) \right],$$

(173)
$$P_a(t,y) := \frac{\mu}{\sqrt{2i}} \left[e^{i\tau} \widetilde{\psi_a}(\tau, y_1, y_2) + e^{-i\tau} \overline{\widetilde{\psi_a}}(\tau, y_1, y_2) \right].$$

We need to compare the difference between the approximate solution (172)-(173) and the true solution of (20). Let us consider (20), and take an initial datum (Q_0, P_0) with corresponding Fourier coefficients $(\hat{Q}_{0,k}, \hat{P}_{0,k})$ given by (6); observe that

(174)
$$\hat{Q}_{0,k} \neq 0 \text{ only if } \kappa(k) = (\mu K_1, \mu^{\sigma} K_2).$$

Since P_0 and Q_0 are analytic functions, there exist C, $\rho > 0$ such that

(175)
$$\frac{|\hat{P}_{0,k}|^2 + \omega_k^2 |\hat{Q}_{0,k}|^2}{N} \le Ce^{-2\rho|(\kappa_1(k)/\mu, \kappa_2(k)/\mu^{\sigma})|}.$$

Moreover, we define an interpolating function for the initial datum (Q_0, P_0) by

$$Q_0(t,y) = \frac{1}{\sqrt{N}} \sum_{K: (\mu^2 |K_1|^2 + \mu^{2\sigma} |K_2|^2)^{1/2} = |\kappa(k)| \le 1} \hat{Q}_{0,K}(t) e^{i\pi(\mu K_1 y_1 + \mu^{\sigma} K_2 y_2)},$$

and similarly for $y \mapsto P_0(y)$.

Proposition 6.10. Consider (20) with $\sigma > 1$ and $\gamma > 0$ such that $\sigma + 2\gamma < \min(4\sigma - 1, 7)$. Let us assume that the initial datum satisfies (174)-(175), and denote by $(Q_j(t), P_j(t))_{j \in \mathbb{Z}_{N_1, N_2}}$ the corresponding solution. Consider the approximate solution $(\widetilde{\psi_a}(t, x), \widetilde{\psi_a}(t, x))$ with the corresponding initial datum. Assume that $(\widetilde{\psi_a}, \widetilde{\psi_a}) \in \mathcal{H}^{\rho, n}$ for some $\rho > 0$ and for some $n \geq 0$ for all times, and fix $T_0 > 0$ and $0 < \delta \ll 1$.

Then there exists $\mu_0 = \mu_0(T_0, \sigma, \|(\widetilde{\psi}_a(0), \widetilde{\psi}_a(0))\|_{\mathcal{H}^{\rho,n}})$ such that, if $\mu < \mu_0$, we have that there exists C > 0 such that

(176)
$$\sup_{j} |Q_{j}(t) - Q_{a}(t,j)| + |P_{j}(t) - P_{a}(t,j)| \le C\mu^{\gamma}, \qquad \forall |t| \le \frac{T_{0}}{\mu^{2}},$$

where (Q_a, P_a) are given by (172)-(173). Moreover,

(177)
$$\left| \mathcal{E}_{\kappa}(t) - \mu^2 \frac{|\hat{\psi}_K(\tau)|^2}{2} \right| \le C \,\mu^{2+\gamma} \,, \qquad |t| \le \frac{T_0}{\mu^2}$$

for all k such that $\kappa(k) = (\mu K_1, \mu^{\sigma} K_2)$ and $|K_1| + |K_2| \leq \frac{(2+\delta)|\log \mu|}{\rho}$. Moreover,

(178)
$$|\mathcal{E}_{\kappa}(t)| \le \mu^{2+\gamma}, \qquad |t| \le \frac{T_0}{\mu^2}$$

for all k such that $\kappa(k) = (\mu K_1, \mu^{\sigma} K_2)$ and $|K_1| + |K_2| > \frac{(2+\delta)|\log \mu|}{\rho}$, and $\mathcal{E}_{\kappa} = 0$ otherwise.

We defer the proof to Appendix E.

Remark 6.11. The condition $\sigma + 2\gamma < \min(4\sigma - 1, 7)$, which, together with $\gamma > 0$, implies the upper bound $\sigma < 7$ found in the statement of Theorem (2.7), is the consequence of a technical condition which allows to estimate the error in the proof of Proposition 6.10 (see Claim 2, together with (268)-(270)).

Proof of Theorem 2.7. First we prove (26).

We consider an initial datum as in (25); when passing to the continuous approximation (103), this initial datum corresponds to an initial data $(\xi_0, \eta_0) \in \mathcal{H}^{\rho_0, n}$. By Theorem 5.5 the corresponding sequence of gaps belongs to $\mathcal{H}^{\rho_0, n}$, and that the solution $(\xi(\tau), \eta(\tau))$ is analytic in a complex strip of width $\rho(t)$. Taking the minimum of such quantities one gets the coefficient ρ appearing in the statement of Theorem (2.7). Applying Proposition 6.10, we can deduce the corresponding result for the discrete model (22) and the specific quantities (10).

Next, we prove (28). In order to do so, we exploit the Birkhoff coordinates (x, y) introduced in Theorem 5.6; indeed, by rewriting the normal form system (116) in Birkhoff coordinates we get that every solution is almost-periodic in time. Now, let us introduce the quantity

$$E_K := \frac{1}{2} \left| \hat{\psi}_K \right|^2,$$

then $\tau \mapsto E_K(x(\tau), y(\tau))$ is almost-periodic. Hence we can exploit (177) of Proposition 6.10 to translate the results in terms of the specific quantities \mathcal{E}_{κ} , and we get the thesis.

Appendix A. Proof of Lemma 3.6

This appendix is devoted to the proof of the Lemma 3.6, which is a key step to normalize the system (48). Its proof is an adaptation of Theorem 4.4 in [Bam99] and it is based on the method of Lie transform, briefly recalled in the following. Throughout this Section, we consider $s \geq s_1$ and $\rho \geq 0$ to be fixed quantities.

Given an auxiliary function χ analytic on $\mathcal{H}^{\rho,s}$, we consider the auxiliary differential equation

$$\dot{\zeta} = X_{\chi}(\zeta)$$

and denote by Φ_{χ}^{t} its flow at time t.

Lemma A.1. Let χ and its vector field be analytic in $\mathcal{B}_{\rho,s}(R)$. Fix d < R, and assume that

$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\chi}(\zeta)\|_{\mathcal{H}^{\rho,s}} \le d.$$

Then, if we consider the time-t flow Φ_{χ}^t of X_{χ} we have that for $|t| \leq 1$

$$\sup_{\zeta\in\mathcal{B}_{\rho,s}(R-d)}\|\Phi_\chi^t(\zeta)-\zeta\|_{\mathcal{H}^{\rho,s}}\leq \sup_{\zeta\in\mathcal{B}_{\rho,s}(R)}\|X_\chi(\zeta)\|_{\mathcal{H}^{\rho,s}}.$$

Definition A.2. The map $\Phi_{\chi} := \Phi_{\chi}^1$ is called the Lie transform generated by χ .

Given G analytic on $\mathcal{H}^{\rho,s}$, let us consider the differential equation

$$\dot{\zeta} = X_{\mathsf{G}}(\zeta),$$

where by X_{G} we denote the vector field of G . Now define

$$\Phi_{\gamma}^* \mathsf{G}(\tilde{\zeta}) := \mathsf{G} \circ \Phi_{\gamma}(\tilde{\zeta}).$$

By exploiting the fact that Φ_{χ} is a canonical transformation, we have that in the new variable $\tilde{\zeta}$ defined by $\zeta = \Phi_{\chi}(\tilde{\zeta})$ equation (180) is equivalent to

(181)
$$\dot{\tilde{\zeta}} = X_{\Phi_{\nu}^* \mathsf{G}}(\tilde{\zeta}).$$

Using the relation

(182)
$$\frac{\mathrm{d}}{\mathrm{d}t}\Phi_{\chi}^{*}\mathsf{G} = \Phi_{\chi}^{*}\{\chi,\mathsf{G}\},$$

and the Poisson bracket formalism $\{\mathsf{G}_1,\mathsf{G}_2\}(\zeta):=\mathrm{d}\mathsf{G}_1(\zeta)[X_{\mathsf{G}_2}(\zeta)]$ we formally get

(183)
$$\begin{split} \Phi_{\chi}^{*}\mathsf{G} &= \sum_{\ell=0}^{\infty} \mathsf{G}_{\ell}, \\ \mathsf{G}_{0} &:= \mathsf{G}, \\ \mathsf{G}_{\ell} &:= \frac{1}{\ell} \{ \chi, \mathsf{G}_{\ell-1} \}, \ \ell \geq 1. \end{split}$$

In order to estimate the vector field of the terms appearing in (183), we exploit the following results

Lemma A.3. Let R > 0, and assume that χ , G are analytic on $\mathcal{B}_{\rho,s}(R)$ as well as their vector fields. Then, for any $d \in (0,R)$ we have that $\{\chi,G\}$ is analytic on $\mathcal{B}_{\rho,s}(R-d)$, and

(184)
$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \|X_{\{\chi,\mathsf{G}\}}(\zeta)\|_{\mathcal{H}^{\rho,s}} \leq \frac{2}{d} \left(\sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\chi}(\zeta)\|_{\mathcal{H}^{\rho,s}} \right) \left(\sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\mathsf{G}}(\zeta)\|_{\mathcal{H}^{\rho,s}} \right).$$

Proof. Observe that

$$\begin{aligned} \|X_{\{\chi,\mathsf{G}\}}(\zeta)\|_{\mathcal{H}^{\rho,s}} &= \|\mathrm{d}X_{\chi}(\zeta) \ X_{\mathsf{G}}(\zeta) - \mathrm{d}X_{\mathsf{G}}(\zeta) \ X_{\chi}(\zeta)\|_{\mathcal{H}^{\rho,s}} \\ &\leq \|\mathrm{d}X_{\chi}(\zeta) \ X_{\mathsf{G}}(\zeta)\|_{\mathcal{H}^{\rho,s}} + \|\mathrm{d}X_{\mathsf{G}}(\zeta) \ X_{\chi}(\zeta)\|_{\mathcal{H}^{\rho,s}}, \end{aligned}$$

and since for any $d \in (0, R)$ Cauchy inequality gives

$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \| \mathrm{d} X_{\chi}(\zeta) \|_{\mathcal{H}^{\rho,s} \to \mathcal{H}^{\rho,s}} \le \frac{1}{d} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \| X_{\chi}(\zeta) \|_{\mathcal{H}^{\rho,s}},$$

we finally get

$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \| \mathrm{d} X_{\chi}(\zeta) \ X_{\mathsf{G}}(\zeta) \|_{\mathcal{H}^{\rho,s}} \leq \frac{1}{d} \left(\sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \| X_{\chi}(\zeta) \|_{\mathcal{H}^{\rho,s}} \right) \left(\sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \| X_{\mathsf{G}}(\zeta) \|_{\mathcal{H}^{\rho,s}} \right).$$

With a similar estimate for the other term we obtain the thesis.

Lemma A.4. Let R > 0, and assume that χ , G are analytic on $\mathcal{B}_{\rho,s}(R)$ as well as their vector fields. Let $\ell \geq 1$, and consider G_{ℓ} as defined in (183); for any $d \in (0,R)$, G_{ℓ} is analytic on $\mathcal{B}_{\rho,s}(R-d)$ as well as it vector field, and

(185)
$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \|X_{\mathsf{G}_{\ell}}(\zeta)\|_{\mathcal{H}^{\rho,s}} \leq \left(\frac{2e}{d} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\chi}(\zeta)\|_{\mathcal{H}^{\rho,s}}\right)^{\ell} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\mathsf{G}}(\zeta)\|_{\mathcal{H}^{\rho,s}}.$$

Proof. Fix $\ell \geq 1$. We look for a sequence $C_m^{(\ell)}$ such that

$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R-m \ d/\ell)} \|X_{\mathsf{G}_m}(\zeta)\|_{\mathcal{H}^{\rho,s}} \le C_m^{(\ell)}, \ \forall m \le \ell.$$

Lemma A.3 ensures that the following sequence satisfies this property.

$$\begin{split} C_0^{(\ell)} &:= \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\mathsf{G}}(\zeta)\|_{\mathcal{H}^{\rho,s}}, \\ C_m^{(\ell)} &= \frac{2\ell}{dm} C_{m-1}^{(\ell)} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\chi}(\zeta)\|_{\mathcal{H}^{\rho,s}}. \end{split}$$

One has

$$C_{\ell}^{(\ell)} = \frac{1}{\ell!} \left(\frac{2\ell}{d} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\chi}(\zeta)\|_{\mathcal{H}^{\rho,s}} \right)^{\ell} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\mathsf{G}}(\zeta)\|_{\mathcal{H}^{\rho,s}},$$

and by using the inequality $\ell^{\ell} < \ell! e^{\ell}$ one obtains the estimate (185).

Before stating the next Lemma, we point out that the Poisson tensor Ω_2^{-1} , obtained by inversion from the associated symplectic form Ω_2 in (35), is not a bounded operator on $\mathcal{H}^{\rho,s}$. We thus have to weaken the hypothesis of Theorem 4.4 in [Bam99]; indeed, we just assume that

$$\|\Omega^{-1}f\|_{\mathcal{H}^{\rho,s}} \leq \|f\|_{\mathcal{H}^{\rho,s+1}}$$
.

This property is satisfied by both Ω_1^{-1} and Ω_2^{-1} .

Lemma A.5. Let χ and F be analytic on $\mathcal{B}_{\rho,s}(R)$ as well as their vector fields. Fix $d \in (0,R)$, and assume also that

$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\chi}(\zeta)\|_{\mathcal{H}^{\rho,s}} \le d/3.$$

Then for $|t| \leq 1$

(186)
$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \|X_{(\Phi_{\chi}^{t})^{*}\mathsf{F}-\mathsf{F}}(\zeta)\|_{\mathcal{H}^{\rho,s}} \leq \frac{9}{d} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\chi}(\zeta)\|_{\mathcal{H}^{\rho,s}} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\mathsf{F}}(\zeta)\|_{\mathcal{H}^{\rho,s}}.$$

Proof. Since the bound on the norm of X_{χ} implies that $\Phi_{\chi}^{t}(\zeta) \in \mathcal{B}_{\rho,s}(R)$ when $\zeta \in \mathcal{B}_{\rho,s}(R-d/3)$, using Cauchy inequality and Lemma A.1

$$\begin{split} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \|\mathrm{d}\Phi_{\chi}^{-t}(\Phi_{\chi}^{t}(\zeta)) - \mathrm{id}\|_{\mathcal{H}^{\rho,s} \to \mathcal{H}^{\rho,s}} &\leq \sup_{\zeta \in \mathcal{B}_{\rho,s}(R-2d/3)} \|\mathrm{d}\Phi_{\chi}^{-t}(\zeta) - \mathrm{id}\|_{\mathcal{H}^{\rho,s} \to \mathcal{H}^{\rho,s}} \\ &\leq \frac{3}{d} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d/3)} \|\Phi_{\chi}^{-t}(\zeta) - \zeta\|_{\mathcal{H}^{\rho,s}} \\ &\leq \frac{3}{d} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\chi}(\zeta)\|_{\mathcal{H}^{\rho,s}} \end{split}$$

Since $\Phi_{\mathcal{X}}^t$ is a canonical transformation, a direct computation shows

$$\Omega^{-1}\mathrm{d}(\mathsf{F}\circ\Phi_\chi^t)(\zeta)=(\mathrm{d}\Phi_\chi^{-t}(\Phi_\chi^t(\zeta))-\mathrm{id})\Omega^{-1}\mathrm{d}\mathsf{F}(\Phi_\chi^t)+\Omega^{-1}\mathrm{d}\mathsf{F}(\Phi_\chi^t(\zeta))$$

whence

$$\begin{split} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \| X_{(\Phi_{\chi}^{t})^{*}\mathsf{F}-\mathsf{F}}(\zeta) \|_{\mathcal{H}^{\rho,s}} &= \sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \| \Omega^{-1} \mathrm{d}(\mathsf{F}(\Phi_{\chi}^{t}(\zeta)) - \mathsf{F}(\zeta)) \|_{\mathcal{H}^{\rho,s}} \\ &\leq \sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \| (\mathrm{d}\Phi_{\chi}^{-t}(\Phi_{\chi}^{t}(\zeta)) - \mathrm{id}) \Omega^{-1} \mathrm{d}\mathsf{F}(\Phi_{\chi}^{t}) + \Omega^{-1} \mathrm{d}(\mathsf{F}(\Phi_{\chi}^{t}(\zeta)) - \mathsf{F}(\zeta)) \|_{\mathcal{H}^{\rho,s}} \\ &\leq \sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \| \mathrm{d}\Phi_{\chi}^{-t}(\Phi_{\chi}^{t}(\zeta)) - \mathrm{id} \|_{\mathcal{H}^{\rho,s} \to \mathcal{H}^{\rho,s}} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \| X_{\mathsf{F}}(\Phi_{\chi}^{t}(\zeta)) \|_{\mathcal{H}^{\rho,s}} \\ &+ \sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \| X_{\mathsf{F}}(\Phi_{\chi}^{t}(\zeta)) - X_{\mathsf{F}}(\zeta) \|_{\mathcal{H}^{\rho,s}} \\ &\leq \frac{3}{d} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \| X_{\chi}(\zeta) \|_{\mathcal{H}^{\rho,s}} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \| X_{\mathsf{F}}(\zeta) \|_{\mathcal{H}^{\rho,s}} \\ &+ \sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \left\| \int_{0}^{t} [X_{\chi}, X_{\mathsf{F}}](\Phi_{\chi}^{s}(\zeta)) \mathrm{d}s \right\|_{\mathcal{H}^{\rho,s}}. \end{split}$$

To estimate the last term we use Cauchy inequality

$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \left\| \int_{0}^{t} [X_{\chi}, X_{\mathsf{F}}] (\Phi_{\chi}^{s}(\zeta)) \, \mathrm{d}s \right\|_{\mathcal{H}^{\rho,s}} \leq 2 \sup_{\zeta \in \mathcal{B}_{\rho,s}(R-2d/3)} \|[X_{\chi}, X_{\mathsf{F}}](\zeta)\|_{\mathcal{H}^{\rho,s}} \\
\leq \frac{6}{d} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\chi}(\zeta)\|_{\mathcal{H}^{\rho,s}} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\mathsf{F}}(\zeta)\|_{\mathcal{H}^{\rho,s}} .$$

Then the thesis follows.

Lemma A.6. Assume that G is analytic on $\mathcal{B}_{\rho,s}(R)$ as well as its vector field, and that h_0 satisfies (PER). Then there exists χ analytic on $\mathcal{B}_{\rho,s}(R)$ and Z analytic on $\mathcal{B}_{\rho,s}(R)$ with Z in normal form, namely $\{h_0, Z\} = 0$, such that

(187)
$$\{\chi, h_0\} + G = Z.$$

Such Z and χ are given explicitly by

(188)
$$\mathsf{Z}(\zeta) = \frac{1}{T} \int_0^T \mathsf{G}(\Phi_{\mathsf{h}_0}^t(\zeta)) \,\mathrm{d}t,$$

(189)
$$\chi(\zeta) = \frac{1}{T} \int_0^T t \left[\mathsf{Z}(\Phi_{\mathsf{h}_0}^t(\zeta)) - \mathsf{G}(\Phi_{\mathsf{h}_0}^t(\zeta)) \right] \, \mathrm{d}t.$$

Furthermore, we have that the vector fields of χ and Z are analytic on $\mathcal{B}_{\rho,s}(R)$, and satisfy

(190)
$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\mathsf{Z}}(\zeta)\|_{\mathcal{H}^{\rho,s}} \leq \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\mathsf{G}}(\zeta)\|_{\mathcal{H}^{\rho,s}},$$
$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\mathsf{X}}(\zeta)\|_{\mathcal{H}^{\rho,s}} \leq 2T \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\mathsf{G}}(\zeta)\|_{\mathcal{H}^{\rho,s}}.$$

Proof. We check directly that the solution of (187) is (189). Indeed,

$$\begin{split} \{\chi, \mathsf{h}_0\}(\zeta) &= \frac{\mathrm{d}}{\mathrm{d}s} \Big|_{s=0} \chi(\Phi^s_{\mathsf{h}_0}(\zeta)) \\ &= \frac{1}{T} \int_0^T t \frac{\mathrm{d}}{\mathrm{d}s} \Big|_{s=0} \left[\mathsf{Z}(\Phi^{t+s}_{\mathsf{h}_0}(\zeta)) - \mathsf{G}(\Phi^{t+s}_{\mathsf{h}_0}(\zeta)) \right] \mathrm{d}t \\ &= \frac{1}{T} \int_0^T t \frac{\mathrm{d}}{\mathrm{d}t} \left[\mathsf{Z}(\Phi^t_{\mathsf{h}_0}(\zeta)) - \mathsf{G}(\Phi^t_{\mathsf{h}_0}(\zeta)) \right] \mathrm{d}t \\ &= \frac{1}{T} \left[t \mathsf{Z}(\Phi^t_{\mathsf{h}_0}(\zeta)) - t \mathsf{G}(\Phi^t_{\mathsf{h}_0}(\zeta)) \right]_{t=0}^T - \frac{1}{T} \int_0^T \left[\mathsf{Z}(\Phi^t_{\mathsf{h}_0}(\zeta)) - \mathsf{G}(\Phi^t_{\mathsf{h}_0}(\zeta)) \right] \mathrm{d}t \\ &= \mathsf{Z}(\zeta) - \mathsf{G}(\zeta). \end{split}$$

In the last step we used the explicit expression of Z provided in (188). Finally, the first estimate in (190) follows from the explicit expression of Z in (188) while for the second estimate we write explicitly the vector field X_Y :

$$X_{\chi}(\zeta) = \frac{1}{T} \int_0^T t \, D\Phi_{\mathsf{h}_0}^{-t}(\Phi_{\mathsf{h}_0}^t(\zeta)) \circ X_{\mathsf{Z}-\mathsf{G}}(\Phi_{\mathsf{h}_0}^t(\zeta)) \, \mathrm{d}t \, .$$

Hypothesis (PER) guarantees that $\Phi_{h_0}^t$ as well as its derivatives and the inverses are uniformly bounded as operators from $\mathcal{H}^{\rho,s}$ into itself. Moreover, for any $t \in \mathbb{R}$, the map $\zeta \mapsto \Phi_{h_0}^t(\zeta)$ is a diffeomorphism of $\mathcal{B}_{\rho,s}(R)$ into itself. Using the fact that $\Phi_{h_0}^t$ is an isometry, we have

$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_\chi(\zeta)\|_{\mathcal{H}^{\rho,s}} \leq T \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} (\|X_\mathsf{Z}(\zeta)\|_{\mathcal{H}^{\rho,s}} + \|X_\mathsf{G}(\zeta)\|_{\mathcal{H}^{\rho,s}}) \leq 2T \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_\mathsf{G}(\zeta)\|_{\mathcal{H}^{\rho,s}}$$

where in the last step we used the first inequality in (190).

Lemma A.7. Assume that G and its vector fields are analytic on $\mathcal{B}_{\rho,s}(R)$, and that h_0 satisfies (PER). Let χ and its vector field be analytic on $\mathcal{B}_{\rho,s}(R)$, and assume that χ solves (187). For any $\ell \geq 1$ denote by $h_{0,\ell}$ the functions defined recursively as in (183) from h_0 . Then for any $d \in (0,R)$ one has that $h_{0,\ell}$ and its vector field are analytic on $\mathcal{B}_{\rho,s}(R-d)$, and

(191)
$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \|X_{\mathsf{h}_{0,\ell}}(\zeta)\|_{\mathcal{H}^{\rho,s}} \leq 2 \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\mathsf{G}}(\zeta)\|_{\mathcal{H}^{\rho,s}} \left(\frac{9}{d} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\chi}(\zeta)\|_{\mathcal{H}^{\rho,s}} \right)^{\ell}.$$

Proof. By using (187) one gets that $h_{0,1} = \mathsf{Z} - \mathsf{G}$ is analytic on $\mathcal{B}_{\rho,s}(R)$. Then by exploiting (186) one gets the result.

Lemma A.8. Assume that G and its vector field are analytic on $\mathcal{B}_{\rho,s}(R)$, and that h_0 satisfies PER. Let χ be the solution of (187), denote by Φ_{χ}^t the flow of the Hamiltonian vector field associated to χ and by Φ_{χ} the corresponding time-one map. Moreover, denote by

$$\mathcal{F}(\zeta) := h_0(\Phi_{\chi}(\zeta)) - h_0(\zeta) - \{\chi, h_0\}(\zeta).$$

Let d < R, and assume that

$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\chi}(\zeta)\|_{\mathcal{H}^{\rho,s}} \le d/3.$$

Then we have that \mathcal{F} and its vector field are analytic on $\mathcal{B}_{\rho,s}(R-d)$, and

(192)
$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \|X_{\mathcal{F}}(\zeta)\|_{\mathcal{H}^{\rho,s}} \leq \frac{18}{d} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\chi}(\zeta)\|_{\mathcal{H}^{\rho,s}} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\mathsf{G}}(\zeta)\|_{\mathcal{H}^{\rho,s}}.$$

Proof. Since

$$\mathsf{h}_0(\Phi_\chi(\zeta)) - \mathsf{h}_0(\zeta) = \int_0^1 \left\{\chi, \mathsf{h}_0\right\} \circ \Phi_\chi^t(\zeta) \; \mathrm{d}t \stackrel{(187)}{=} \int_0^1 \; \mathsf{Z}(\Phi_\chi^t(\zeta)) - \mathsf{G}(\Phi_\chi^t(\zeta)) \; \mathrm{d}t,$$

if we define $F(\zeta) := Z(\zeta) - G(\zeta)$, we get

$$\mathcal{F}(\zeta) = \int_0^1 \left(\mathsf{F}(\Phi_{\chi}^t(\zeta)) - \mathsf{F}(\zeta) \right) \, \mathrm{d}t.$$

Now, we have

$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \|X_{\mathcal{F}}(\zeta)\|_{\mathcal{H}^{\rho,s}}
= \sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \left\| \Omega^{-1} d \left[\int_{0}^{1} \left(\mathsf{F}(\Phi_{\chi}^{t}(\zeta)) - \mathsf{F}(\zeta) \right) dt \right] \right\|_{\mathcal{H}^{\rho,s}}
\leq \sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \left\| \int_{0}^{1} \left[(d\Phi_{\chi}^{-t}(\Phi_{\chi}^{t}(\zeta)) - id)\Omega^{-1} d\mathsf{F}(\Phi_{\chi}^{t}) + \Omega^{-1} d(\mathsf{F}(\Phi_{\chi}^{t}(\zeta)) - \mathsf{F}(\zeta)) \right] dt \right\|_{\mathcal{H}^{\rho,s}}
\leq \sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \left\| \int_{0}^{1} \left(d\Phi_{\chi}^{-t}(\Phi_{\chi}^{t}(\zeta)) - id \right) \Omega^{-1} d\mathsf{F}(\Phi_{\chi}^{t}) dt \right\|_{\mathcal{H}^{\rho,s}}
+ \sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \left\| \int_{0}^{1} \left(X_{\mathsf{F}}(\Phi_{\chi}^{t}(\zeta)) - X_{\mathsf{F}}(\zeta) \right) dt \right\|_{\mathcal{H}^{\rho,s}}$$

and by dominated convergence we can bound the last quantity by

$$\begin{split} &\sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \sup_{t \in [0,1]} \| \mathrm{d}\Phi_{\chi}^{-t}(\Phi_{\chi}^{t}(\zeta)) - \mathrm{id}\|_{\mathcal{H}^{\rho,s} \to \mathcal{H}^{\rho,s}} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \|X_{\mathsf{F}}(\Phi_{\chi}^{t}(\zeta))\|_{\mathcal{H}^{\rho,s}} \\ &+ \sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \sup_{t \in [0,1]} \|X_{\mathsf{F}}(\Phi_{\chi}^{t}(\zeta)) - X_{\mathsf{F}}(\zeta)\|_{\mathcal{H}^{\rho,s}} \\ &\leq \sup_{t \in [0,1]} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \| \mathrm{d}\Phi_{\chi}^{-t}(\Phi_{\chi}^{t}(\zeta)) - \mathrm{id}\|_{\mathcal{H}^{\rho,s} \to \mathcal{H}^{\rho,s}} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \|X_{\mathsf{F}}(\Phi_{\chi}^{t}(\zeta))\|_{\mathcal{H}^{\rho,s}} \\ &+ \sup_{t \in [0,1]} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \|X_{\mathsf{F}}(\Phi_{\chi}^{t}(\zeta)) - X_{\mathsf{F}}(\zeta)\|_{\mathcal{H}^{\rho,s}} \\ &\leq \frac{3}{d} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\chi}(\zeta)\|_{\mathcal{H}^{\rho,s}} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\mathsf{F}}(\zeta)\|_{\mathcal{H}^{\rho,s}} + \sup_{t \in [0,1]} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \left\|\int_{0}^{t} [X_{\chi}, X_{\mathsf{F}}](\Phi_{\chi}^{s}(\zeta)) \mathrm{d}s \right\|_{\mathcal{H}^{\rho,s}}, \end{split}$$

where we can estimate the last term by Cauchy inequality

$$\begin{split} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \left\| \int_0^t [X_\chi, X_\mathsf{F}] (\Phi_\chi^s(\zeta)) \mathrm{d}s \right\|_{\mathcal{H}^{\rho,s}} &\leq 2 \sup_{\zeta \in \mathcal{B}_{\rho,s}(R-2d/3)} \|[X_\chi, X_\mathsf{F}] (\zeta)\|_{\mathcal{H}^{\rho,s}} \\ &\leq \frac{6}{d} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_\chi(\zeta)\|_{\mathcal{H}^{\rho,s}} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_\mathsf{F} (\zeta)\|_{\mathcal{H}^{\rho,s}} \,. \end{split}$$

By the above computations and (190) we obtain

$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R-d)} \|X_{\mathcal{F}}(\zeta)\|_{\mathcal{H}^{\rho,s}} \leq \frac{9}{d} \sup_{\mathcal{B}_{\rho,s}(R)} \|X_{\chi}(\zeta)\|_{\mathcal{H}^{\rho,s}} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\mathsf{F}}(\zeta)\|_{\mathcal{H}^{\rho,s}}
\leq \frac{18}{d} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\chi}(\zeta)\|_{\mathcal{H}^{\rho,s}} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{G}(\zeta)\|_{\mathcal{H}^{\rho,s}}.$$

Lemma A.9. Let $s \ge s_1 \gg 1$, R > 0, $m \ge 0$, $0 < \nu \le 1$, and consider the Hamiltonian

(193)
$$H^{(m)}(\zeta) = \mathsf{h}_0(\zeta) + \delta \mathsf{Z}^{(m)}(\zeta) + \delta^{\nu m+1} \mathsf{F}^{(m)}(\zeta).$$

Assume that h₀ satisfies (PER) and (INV), and that

$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R)} \|X_{\mathsf{F}^{(0)}}(\zeta)\|_{\mathcal{H}^{\rho,s}} \le F.$$

Fix $d < \frac{R}{m+1}$, and set $R_m := R - md$ $(m \ge 1)$.

Assume also that $\mathsf{Z}^{(m)}$ is analytic on $\mathcal{B}_{\rho,s}(R_m)$, and that

$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R_m)} \|X_{\mathsf{Z}^{(0)}}(\zeta)\|_{\mathcal{H}^{\rho,s}} = 0,$$

(194)
$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R_m)} \|X_{\mathsf{Z}^{(m)}}(\zeta)\|_{\mathcal{H}^{\rho,s}} \le F \sum_{i=0}^{m-1} \delta^{\nu i} K_0^i, \quad m \ge 1,$$

(195)
$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R_m)} \|X_{\mathsf{F}^{(m)}}(\zeta)\|_{\mathcal{H}^{\rho,s}} \le F K_0^m, \ m \ge 1,$$

with $K_0 \geq 15$ and $d > 3T\delta F$.

Then, if $\delta^{\nu} K_0 < 1/2$ there exists a canonical transformation $\mathcal{T}_{\delta}^{(m)}$ analytic on $\mathcal{B}_{\rho,s}(R_{m+1})$ such that

(196)
$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R_{m+1})} \|\mathcal{T}_{\delta}^{(m)}(\zeta) - \zeta\|_{\mathcal{H}^{\rho,s}} \le 2T\delta^{\nu m+1} K_0^m F,$$

 $\mathsf{H}^{(m+1)} := \mathsf{H}^{(m)} \circ \mathcal{T}^{(m)}$ has the form (193) and satisfies (195) with m replaced by m+1.

Proof. The key point of the proof is to look for $\mathcal{T}_{\delta}^{(m)}$ as the time-one map of the Hamiltonian vector field of an analytic function $\delta^{\nu m+1}\chi_m$. Hence, consider the differential equation

(197)
$$\dot{\zeta} = X_{\delta^{\nu m + 1} \gamma_m}(\zeta).$$

By standard theory we have that, if $\|X_{\delta^{\nu m+1}\chi_m}\|_{\mathcal{B}_{\rho,s}(R_m)}$ is small enough (e.g. $\|X_{\delta^{\nu m+1}\chi_m}\|_{\mathcal{B}_{\rho,s}(R_m)} \le \frac{md}{m+1}$) and $\zeta_0 \in \mathcal{B}_{\rho,s}(R_{m+1})$, then the solution of (197) exists for $|t| \le 1$.

Therefore we can define $\mathcal{T}_{m,\delta}^t: \mathcal{B}_{\rho,s}(R_{m+1}) \to \mathcal{B}_{\rho,s}(R_m)$, and in particular the corresponding time-one map $\mathcal{T}_{\delta}^{(m)}:=\mathcal{T}_{m,\delta}^1$, which is an analytic canonical transformation, $\delta^{\nu m+1}$ -close to the identity. We have

$$(\mathcal{T}_{\delta}^{(m)})^{*} \left(\mathsf{h}_{0} + \delta \mathsf{Z}^{(m)} + \delta^{m+1} \mathsf{F}^{(m)}\right) = \mathsf{h}_{0} + \delta \mathsf{Z}^{(m)} + \delta^{\nu m+1} \left[\left\{ \chi_{m}, \mathsf{h}_{0} \right\} + \mathsf{F}^{(m)} \right] + \\ \left(\mathsf{198} \right) + \left(\mathsf{h}_{0} \circ \mathcal{T}_{\delta}^{(m)} - \mathsf{h}_{0} - \delta^{\nu m+1} \left\{ \chi_{m}, \mathsf{h}_{0} \right\} \right) + \delta \left(\mathsf{Z}^{(m)} \circ \mathcal{T}_{\delta}^{(m)} - \mathsf{Z}^{(m)} \right) \\ + \delta^{\nu m+1} \left(\mathsf{F}^{(m)} \circ \mathcal{T}_{\delta}^{(m)} - \mathsf{F}^{(m)} \right).$$

It is easy to see that the first two terms on the right-hand side are already normalized, that the third term is the non-normalized part of order m+1 that can be normalized through the choice of a suitable χ_m , and that (198)-(199) contain all the terms of order higher than m+1.

In order to normalize the third term on the right-hand side we solve the homological equation

$$\{\chi_m, \mathsf{h}_0\} + \mathsf{F}^{(m)} = \mathsf{Z}_{m+1},$$

with Z_{m+1} in normal form. Lemma A.6 ensures the existence of χ_m and Z_{m+1} as well as their explicit expressions:

$$Z_{m+1}(\zeta) = \frac{1}{T} \int_0^T \mathsf{F}^{(m)}(\Phi_{\mathsf{h}_0}^t(\zeta)) \, \mathrm{d}t \,,$$
$$\chi_m(\zeta) = \frac{1}{T} \int_0^T t \left[\mathsf{F}^{(m)}(\Phi_{\mathsf{h}_0}^t(\zeta)) - \mathsf{Z}_{m+1}(\Phi_{\mathsf{h}_0}^t(\zeta)) \right] \, \mathrm{d}t \,.$$

The explicit expression of X_{χ_m} can be computed following the argument of Lemma A.6. Using this explicit expression, the analyticity of the flow $\Phi_{h_0}^t$ ensured by (PER) and (190) one has

$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R_m)} \|X_{\chi_m}(\zeta)\|_{\mathcal{H}^{\rho,\sigma}} \le 2T \sup_{\zeta \in \mathcal{B}_{\rho,s}(R_m)} \|X_{\mathsf{F}^{(m)}}\|_{\mathcal{H}^{\rho,\sigma}} \le 2T K_0^m F.$$

Straightforwardly, from the explicit expression of $Z_{m+1}(\zeta)$ and (195) one has

$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R_m)} \|X_{Z_{m+1}}\|_{\mathcal{H}^{\rho,s}} \le K_0^m F.$$

Now define $Z^{(m+1)} := Z^{(m)} + \delta^{\nu m} Z_{m+1}$ and notice that as a consequence of the latter estimate and (194) we have

$$\begin{split} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R_{m+1})} \|X_{\mathsf{Z}^{(m+1)}}(\zeta)\| & \leq \sup_{\zeta \in \mathcal{B}_{\rho,s}(R_{m+1})} \|X_{\mathsf{Z}^{(m)}}(\zeta)\|_{\mathcal{H}^{\rho,s}} + \sup_{\zeta \in \mathcal{B}_{\rho,s}(R_{m+1})} \|X_{\delta^{\nu m}\mathsf{Z}_{m+1}}(\zeta)\|_{\mathcal{H}^{\rho,s}} \\ & \leq F\left(\sum_{j=0}^{m-1} \delta^{\nu j} K_0^j + \delta^{\nu m} K_0^m\right). \end{split}$$

Defining now $\mathcal{T}_{\delta}^{(m)}(\zeta) := \Phi^1_{\delta^{\nu m+1}\chi_m}(\zeta)$ we can apply Lemma A.1 and (*) to obtain

$$\sup_{\zeta \in \mathcal{B}_{\rho,s}(R_{m+1})} \| \mathcal{T}_{\delta}^{(m)}(\zeta) - \zeta \|_{\mathcal{H}^{\rho,s}} = \sup_{\zeta \in \mathcal{B}_{\rho,s}(R_{m+1})} \| \Phi_{\delta^{\nu_{m+1}}\chi_{m}}^{1}(\zeta) - \zeta \|_{\mathcal{H}^{\rho,s}} \\
\leq \sup_{\zeta \in \mathcal{B}_{\rho,s}(R_{m})} \| X_{\delta^{\nu_{m+1}}\chi_{m}} \|_{\mathcal{H}^{\rho,s}} \leq 2T \delta^{\nu_{m+1}} K_{0}^{m} F$$

Let us set now $\delta^{\nu(m+1)+1}\mathsf{F}^{(m+1)}:=(198)+(199)$. Using Lemma A.5 one can estimate separately the three pieces. We notice that $\sup_{\mathcal{B}_{\rho,s}(R_m)}\|X_{\delta^{\nu m+1}\chi_m}\|_{\mathcal{H}^{\rho,s}}\leq 2T\delta^{\nu m+1}K_0^mF$ and since $\delta^{\nu}K_0<\frac{1}{2}$ we have $\sup_{\mathcal{B}_{\rho,s}(R_m)}\|X_{\delta^{\nu m+1}\chi_m}\|_{\mathcal{H}^{\rho,s}}< T\delta F<\frac{d}{3}\leq \frac{(m+1)d}{3}$. We can thus apply Lemma A.5 and Lemma A.8 to get

$$\begin{split} \sup_{\zeta \in \mathcal{B}(R_{m+1})} \| X_{\mathsf{Z}^{(m)} \circ \mathcal{T}_{\delta}^{(m)} - \mathsf{Z}^{(m)}}(\zeta) \|_{\mathcal{H}^{\rho,s}} &\leq \frac{27 \; \delta^{\nu m + 1}}{(m+1)d} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R_m)} \| X_{\chi_m}(\zeta) \|_{\mathcal{H}^{\rho,s}} \; \sup_{\zeta \in \mathcal{B}_{\rho,s}(R_m)} \| X_{\mathsf{Z}^{(m)}} \|_{\mathcal{H}^{\rho,s}}, \\ \sup_{\zeta \in \mathcal{B}(R_{m+1})} \| X_{\mathsf{F}^{(m)} \circ \mathcal{T}_{\delta}^{(m)} - \mathsf{F}^{(m)}}(\zeta) \|_{\mathcal{H}^{\rho,s}} &\leq \frac{27 \; \delta^{\nu m + 1}}{(m+1)d} \sup_{\zeta \in \mathcal{B}_{\rho,s}(R_m)} \| X_{\chi_m}(\zeta) \|_{\mathcal{H}^{\rho,s}} \; \sup_{\zeta \in \mathcal{B}_{\rho,s}(R_m)} \| X_{\mathsf{F}^{(m)}} \|_{\mathcal{H}^{\rho,s}}, \\ \sup_{\zeta \in \mathcal{B}(R_{m+1})} \| X_{\mathsf{h}_0 \circ \mathcal{T}_{\delta}^{(m)} - \mathsf{h}_0 - \delta^{\nu m + 1} \{\chi_m, \mathsf{h}_0\}} \|_{\mathcal{H}^{\rho,s}} &\leq \frac{18 \; \delta^{2m\nu + 2}}{(m+1)d} \; \sup_{\zeta \in \mathcal{B}_{\rho,s}(R_m)} \| X_{\chi_m}(\zeta) \|_{\mathcal{H}^{\rho,s}} \; \sup_{\zeta \in \mathcal{B}_{\rho,s}(R_m)} \| X_{\mathsf{F}^{(m)}}(\zeta) \|_{\mathcal{H}^{\rho,s}}. \end{split}$$

By means of these inequalities and by exploiting $\|X_{\delta^{\nu m+1}\chi_m}\|_{\mathcal{H}^{\rho,s}} \leq \frac{(m+1)d}{3}$ together with assumptions (194) and (195), we can estimate

$$= \frac{\pi^{2}}{2} \|(\xi,\eta)\|_{\mathcal{H}^{\rho,0}}^{2} \times$$

Proof of Proposition 6.2. Proposition 6.2 is obtained as a Corollary of Proposition 6.5 by setting $\sigma = 0$

Appendix C. Proof of Proposition 6.6 and Proposition 6.3

Proof of Proposition 6.6. The argument follows along the lines of Appendix C in [BP06]. Exploiting the canonical transformation found in Theorem 3.3, we also define

where $\psi_a(\tilde{\zeta}_a) := (\psi_{\xi}(\tilde{\zeta}_a), \psi_{\eta}(\tilde{\zeta}_a));$ by (46) we have

$$\sup_{\zeta \in \mathcal{B}_{\rho,n}(R)} \|\psi_a(\zeta)\|_{\mathcal{H}^{\rho,n}} \le C'_n \mu^2 R.$$

For convenience we define

(223)
$$q_a(\tau, y) := \frac{1}{\sqrt{2}} \left[\xi_a(\mu^2 \tau, y_1 - \tau, y_2) + \eta_a(\mu^2 \tau, y_1 + \tau, y_2) \right]$$

(224)
$$\partial_{y_1} p_a(\tau, y) := \frac{1}{\sqrt{2}} \left[\xi_a(\mu^2 \tau, y_1 - \tau, y_2) - \eta_a(\mu^2 \tau, y_1 + \tau, y_2) \right],$$

We observe that the pair (q_a, p_a) satisfies

$$\mu^{2}(q_{a})_{t} = -\Delta_{1} \mu p_{a} + \mu^{\min(2\sigma,6)} \mathcal{R}_{q}, \quad \mu(p_{a})_{t} = -\mu^{2} q_{a} - \mu^{4} \alpha \overline{\pi_{0}} q_{a}^{2} + \mu^{\min(2\sigma-1,5)} \mathcal{R}_{p},$$

where the operator Δ_1 acts on the variable x, $\overline{\pi_0}$ is the projector on the space of the functions with zero average (defined in Section 3), and the remainders are functions of the rescaled variables τ and y which satisfy

$$\sup_{\mathcal{B}_{\rho,n}(R)} \|\mathcal{R}_q\|_{\ell^2_{\rho,0}} \le C, \quad \sup_{\mathcal{B}_{\rho,n}(R)} \|\mathcal{R}_p\|_{\ell^2_{\rho,1}} \le C.$$

We now restrict the space variables to integer values; keeping in mind that q_a and p_a are periodic, we assume that $j \in \mathbb{Z}^2_{N_1,N_1^\sigma}$.

We now define the operator ∂_i , i = 1, 2, by $(\partial_i f)_j := f_j - f_{j-e_i}$ for each $f \in \ell^2_{N_1, N_1^{\sigma}}$.

$$F_{0} = \mu \frac{\partial_{y_{1}}^{-1} [\xi_{a} - \eta_{a} - (\widetilde{\xi}_{a} - \widetilde{\eta}_{a})]}{\sqrt{2}\mu^{2+\gamma}} = \mu^{-1-\gamma} \frac{\partial_{y_{1}}^{-1} (\psi_{\xi} - \psi_{\eta})}{\sqrt{2}},$$

from which we can deduce

$$\begin{split} \|E_0\|_{\ell^2_{N_1,N_1^{\sigma}}}^2 &\leq \sum_{j \in \mathbb{Z}_{N_1,N_1^{\sigma}}} |E_{0,j}|^2 \leq C \, 4N_1^{\sigma+1} \, (\mu^{2-\gamma})^2 = C \, \mu^{3-2\gamma-\sigma} \,, \\ \|\partial_1 F_0\|_{\ell^2_{N_1,N_1^{\sigma}}}^2 &\leq \sum_{j \in \mathbb{Z}_{N_1,N_1^{\sigma}}} |\partial_1 F_{0,j}|^2 \leq C \, 4N_1^{\sigma+1} \, (\mu^{2-\gamma})^2 \leq C \, \mu^{3-2\gamma-\sigma} \,, \\ \|\partial_2 F_0\|_{\ell^2_{N_1,N_1^{\sigma}}}^2 &\leq \sum_{j \in \mathbb{Z}_{N_1,N_1^{\sigma}}} |\partial_2 F_{0,j}|^2 \leq C \, 4N_1^{\sigma+1} \, (\mu^{1+\sigma-\gamma})^2 = C \, \mu^{1-2\gamma+\sigma} \end{split}$$

and this leads to the thesis.

• Claim 2: Fix $n \ge 0$, $T_0 > 0$ and $K_* > 0$, then for any $\mu < \mu_s$ and for any $\sigma > 2$ and $\gamma > 0$ such that $\sigma + 2\gamma < \min(4\sigma - 5, 7)$ we have

Now we compute the time derivative of \mathcal{G} . Exploiting (228)-(229)

$$+ \sum_{j} (-\Delta_1 F)_j \left[-E_j - \alpha (\mu^2 2q_{a,j} E_j + \mu^{2+\gamma} E_j^2) - \mu^{\min(2\sigma - 3, 3) - \gamma} (\mathcal{R}_p)_j \right]$$

(234)
$$+ \sum_{j} 2\mu^{2} \alpha q_{a,j} E_{j} \left[-(\Delta_{1} F)_{j} - \mu^{\min(2\sigma - 2, 4) - \gamma} (\mathcal{R}_{q})_{j} \right]$$

$$(235) + \sum_{i} \mu^{2} \alpha E_{j}^{2} \mu \frac{\partial q_{a,j}}{\partial \tau}$$

$$(236) \qquad = \sum_{j} -E_{j} \,\mu^{\min(2\sigma-2,4)-\gamma}(\mathcal{R}_{q})_{j} + \sum_{j} (-\Delta_{1}F)_{j} \left[-\alpha \,\mu^{2+\gamma}E_{j}^{2} - \mu^{\min(2\sigma-3,3)-\gamma}(\mathcal{R}_{p})_{j} \right]$$

$$(237) \qquad -\sum_{j} 2\mu^{2} \alpha q_{a,j} E_{j} \mu^{\min(2\sigma-2,4)-\gamma} (\mathcal{R}_{q})_{j} + \sum_{j} \mu^{2} \alpha E_{j}^{2} \mu \frac{\partial q_{a,j}}{\partial \tau}$$

In order to estimate (236)-(237), we notice that

$$\sup_{j} |(\Delta_{1}F)_{j}| \leq 2 \sup_{j} |(\partial_{1}F)_{j}| + |(\partial_{2}F)_{j}| \leq 4\sqrt{\mathcal{G}},$$

$$\|\mathcal{R}_{q}\|_{\ell^{2}_{N_{1},N_{1}^{\sigma}}}^{2} \leq \sum_{j} |(\mathcal{R}_{q})_{j}|^{2} \leq 4N_{1}^{\sigma+1} \sup_{y} |\mathcal{R}_{q}(y)|^{2} \leq C\mu^{-1-\sigma},$$

and that $|(\partial_i \mathcal{R}_p)_j| \le \mu \sup_y \left| \frac{\partial \mathcal{R}_p}{\partial y}(y) \right|$, which implies

and by applying Gronwall's lemma we get

$$(240) \quad \mathcal{G}(t) \leq \mathcal{G}(0) e^{C \, 2\sqrt{2} \, K_*^{1/2} \, \mu^3 t} + e^{C \, 2\sqrt{2} \, K_*^{1/2} \, \mu^3 t} \, \, C \, 2\sqrt{2} \, K_*^{1/2} \, \mu^3 t \, \, C \, 3\mu^{(\min(4\sigma-5,7)-2\gamma-\sigma)/2} \, \sqrt{2} \, K_*^{1/2},$$

$$\frac{|\hat{p}_{K}|^{2} + \pi^{2}(1 + \mu^{2}K_{1}^{2} + \mu^{2\sigma}K_{2}^{2})|\hat{q}_{K}|^{2}}{2} \leq \pi^{2} e^{-2\rho|K|} \frac{|\hat{p}_{K}|^{2} + (1 + \mu^{2}K_{1}^{2} + \mu^{2\sigma}K_{2}^{2})|\hat{q}_{K}|^{2}}{2} e^{2\rho|K|}$$

$$\leq \pi^{2} e^{-2\rho|K|} \left(1 + \mu^{2}K_{1}^{2} + \mu^{2\sigma}K_{2}^{2}\right) \|(\psi, \bar{\psi})\|_{\mathcal{H}^{0,0}}^{2}.$$
(242)

Hence, analogously to Appendix B, it is convenient to define $\mathscr{L}_{\mu,\delta,\rho}$ as in (209) and by (165) we obtain that for all k such that $\kappa(k) = (\mu K_1, \mu^{\sigma} K_2)$ and $|K_1| + |K_2| > \frac{(2+\delta)|\log \mu|}{\rho}$

$$\frac{\mathcal{E}_{\kappa}}{\mu^{2}} \leq \sum_{L \in \mathcal{L}_{\mu,\delta,\rho}} \left(\left| \hat{p}_{K+L} \right|^{2} + \omega_{k}^{2} \left| \hat{q}_{K+L} \right|^{2} \right)$$

$$(243) \stackrel{(241),(242)}{\leq} \pi^{2} \|(\psi,\bar{\psi})\|_{\mathcal{H}^{\rho,0}}^{2} 2 \sum_{L \in \mathcal{L}_{\mu,\delta,\rho}} e^{-2\rho|K+L|} \left[1 + \mu^{2} \left(K_{1} + L_{1} \right)^{2} + \mu^{2\sigma} \left(K_{2} + L_{2} \right)^{2} \right],$$

$$(244) \qquad = \sum_{L \in \mathscr{L}_{\mu,\delta,\rho}} e^{-2\rho|K+L|} + \mu^2 \sum_{L \in \mathscr{L}_{\mu,\delta,\rho}} e^{-2\rho|K+L|} (K_1 + L_1)^2 + \mu^{2\sigma} \sum_{L \in \mathscr{L}_{\mu,\delta,\rho}} e^{-2\rho|K+L|} (K_2 + L_2)^2.$$

Now,

\stackrel{(241)}{\leq} \left(\mu^{2}\pi^{2}K_{1}^{2} + \pi^{2}\mu^{2\sigma}K_{2}^{2}\right) \left|\hat{p}_{K}\right|^{2}
+ \frac{1}{2} \sum_{\substack{L=(L_{1},L_{2})\in\mathbb{Z}^{2}\backslash\{0\}\\\mu L_{1},\mu^{\sigma}L_{2}\in2\mathbb{Z}}} \left(\left|\hat{p}_{K+L}\right|^{2} + \left|\hat{q}_{K+L}\right|^{2} + \pi^{2} \left[\mu^{2}(K_{1} + L_{1})^{2} + \mu^{2\sigma}(K_{2} + L_{2})^{2}\right] \left|\hat{q}_{K+L}\right|^{2}\right),
\leq \left(\pi^{2}\mu^{2}K_{1}^{2} + \pi^{2}\mu^{2\sigma}K_{2}^{2}\right) \left|\hat{p}_{K}\right|^{2}
+ \left\|(\psi,\bar{\psi})\right\|_{\mathcal{H}^{2},0}^{2} \sum_{\substack{L=(L_{1},L_{2})\in\mathbb{Z}^{2}\backslash\{0\}\\\mu L_{1},\mu^{\sigma}L_{2}\in2\mathbb{Z}}} e^{-2\rho|K+L|} \left[1 + \pi^{2}\mu^{2}(K_{1} + L_{1})^{2} + \pi^{2}\mu^{2\sigma}(K_{2} + L_{2})^{2}\right]
(252) \qquad \leq \pi^{2}\mu^{2}\left(1 + \mu^{2(\sigma-1)}\right) \frac{9|\log\mu|^{2}}{\rho^{2}} \left\|(\psi,\bar{\psi})\right\|_{\mathcal{H}^{\rho,0}}^{2}
(253) \qquad + \left\|(\psi,\bar{\psi})\right\|_{\mathcal{H}^{\rho,0}}^{2} \sum_{\substack{L=(L_{1},L_{2})\in\mathbb{Z}^{2}\backslash\{0\}\\\mu L_{1},\mu^{\sigma}L_{2}\in2\mathbb{Z}}} e^{-2\rho|K+L|} (K_{1} + L_{1})^{2}
(254) \qquad + \pi^{2}\mu^{2}\left\|(\psi,\bar{\psi})\right\|_{\mathcal{H}^{\rho,0}}^{2} \sum_{\substack{L=(L_{1},L_{2})\in\mathbb{Z}^{2}\backslash\{0\}\\\mu L_{1},\mu^{\sigma}L_{2}\in2\mathbb{Z}}} e^{-2\rho|K+L|} (K_{2} + L_{2})^{2}}
(255) \qquad + \pi^{2}\mu^{2\sigma}\left\|(\psi,\bar{\psi})\right\|_{\mathcal{H}^{\rho,0}}^{2} \sum_{\substack{L=(L_{1},L_{2})\in\mathbb{Z}^{2}\backslash\{0\}\\\mu L_{1},\mu^{\sigma}L_{2}\in2\mathbb{Z}}} e^{-2\rho|K+L|} (K_{2} + L_{2})^{2}}$$

and we can conclude by estimating (252) by exploiting the fact that $|\log \mu| \le \mu^{-1/4}$, while we can bound (253)-(254) by

$$\frac{\pi^{2}}{2} \| (\psi, \bar{\psi}) \|_{\mathcal{H}^{\rho,0}}^{2} \sum_{\substack{L = (L_{1}, L_{2}) \in \mathbb{Z}^{2} \setminus \{0\} \\ \mu L_{1}, \mu^{\sigma} L_{2} \in 2\mathbb{Z}}} [1 + \mu^{2} (K_{1} + L_{1})^{2}] e^{-2\rho|K + L|}$$

$$\leq \frac{\pi^{2}}{2} \| (\psi, \bar{\psi}) \|_{\mathcal{H}^{\rho,0}}^{2} \sum_{\substack{L = (L_{1}, L_{2}) \in \mathbb{Z}^{2} \setminus \{0\} \\ \mu L_{1}, \mu^{\sigma} L_{2} \in 2\mathbb{Z}}} (1 + 2 \mu^{2} K_{1}^{2} + 2 \mu^{2} L_{1}^{2}) e^{-2\rho|K + L|}$$

$$\leq \frac{\pi^{2}}{2} \| (\psi, \bar{\psi}) \|_{\mathcal{H}^{\rho,0}}^{2} \left[(1 + 2 \mu^{2} K_{1}^{2}) 2\pi \int_{2/\mu}^{+\infty} e^{-2\rho\ell} \ell \, d\ell + 4\pi \mu^{2} \int_{2/\mu}^{+\infty} e^{-2\rho\ell} \ell^{3} \, d\ell \right]$$

$$= \frac{\pi^{2}}{2} \| (\psi, \bar{\psi}) \|_{\mathcal{H}^{\rho,0}}^{2} \times$$

$$\left[2\pi \left(1 + 2\mu^{2} \frac{9|\log \mu|^{2}}{\rho^{2}} \right) e^{-4\rho/\mu} \frac{\mu + 4\rho}{4\mu\rho^{2}} + 4\pi \mu^{2} e^{-4\rho/\mu} \frac{3\mu^{3} + 12\rho\mu^{2} + 24\rho^{2}\mu + 32\rho^{3}}{8\mu^{3}\rho^{4}} \right],$$
(256)

and we can estimate (255) by

$$\frac{\pi^{2}}{2} \| (\psi, \bar{\psi}) \|_{\mathcal{H}^{\rho,0}}^{2} \mu^{2(\sigma-1)} \sum_{\substack{L = (L_{1}, L_{2}) \in \mathbb{Z}^{2} \setminus \{0\} \\ \mu L_{1}, \mu^{\sigma} L_{2} \in 2\mathbb{Z}}} (K_{2} + L_{2})^{2} e^{-2\rho|K+L|}$$

$$\leq \frac{\pi^{2}}{2} \| (\psi, \bar{\psi}) \|_{\mathcal{H}^{\rho,0}}^{2} \mu^{2(\sigma-1)} \sum_{\substack{L = (L_{1}, L_{2}) \in \mathbb{Z}^{2} \setminus \{0\} \\ \mu L_{1}, \mu^{\sigma} L_{2} \in 2\mathbb{Z}}} (2K_{2}^{2} + 2L_{2}^{2}) e^{-2\rho|K+L|}$$

$$\leq \frac{\pi^{2}}{2} \| (\psi, \bar{\psi}) \|_{\mathcal{H}^{\rho,0}}^{2} \mu^{2(\sigma-1)} \left[2K_{1}^{2} 2\pi \int_{2/\mu^{\sigma}}^{+\infty} e^{-2\rho\ell} \ell d\ell + 4\pi \int_{2/\mu^{\sigma}}^{+\infty} e^{-2\rho\ell} \ell^{3} d\ell \right]$$

$$= \frac{\pi^{2}}{2} \| (\psi, \bar{\psi}) \|_{\mathcal{H}^{\rho,0}}^{2} \mu^{2(\sigma-1)} \times$$

$$\left[4\pi \frac{9 |\log \mu|^{2}}{\rho^{2}} e^{-4\rho/\mu^{\sigma}} \frac{\mu^{\sigma} + 4\rho}{4\mu^{\sigma}\rho^{2}} + 4\pi e^{-4\rho/\mu^{\sigma}} \frac{3\mu^{3\sigma} + 12\rho\mu^{2\sigma} + 24\rho^{2}\mu^{\sigma} + 32\rho^{3}}{8\mu^{3\sigma}\rho^{4}} \right].$$
(257)

Appendix E. Proof of Proposition 6.10

The argument follows along the lines of Appendix C in [BP06].

Exploiting the canonical transformation found in Theorem 3.3, we also define

(258)
$$\zeta_a := (\psi_a, \bar{\psi}_a) = \mathcal{T}_{\mu^2}(\widetilde{\psi}_a, \overline{\widetilde{\psi}}_a) = \tilde{\zeta}_a + \phi_a(\tilde{\zeta}_a),$$

where $\phi_a(\tilde{\zeta}_a) := (\phi_{\xi}(\tilde{\zeta}_a), \phi_{\eta}(\tilde{\zeta}_a))$; by (46) we have

(259)
$$\sup_{\zeta \in \mathcal{B}_{\rho,n}(R)} \|\phi_a(\zeta)\|_{\mathcal{H}^{\rho,n}} \le C'_n \mu^2 R.$$

For convenience we define

(260)
$$q_a(\tau, y) := \frac{1}{\sqrt{2}} \left[e^{i\tau} \widetilde{\psi}_a(\tau, y_1, y_2) + e^{-i\tau} \widetilde{\psi}_a(\tau, y_1, y_2) \right]$$

(261)
$$p_a(\tau, y) := \frac{1}{\sqrt{2}i} \left[e^{i\tau} \widetilde{\psi}_a(\tau, y_1, y_2) - e^{-i\tau} \overline{\widetilde{\psi}_a}(\tau, y_1, y_2) \right],$$

We observe that the pair (q_a, p_a) satisfies

$$\mu(q_a)_t = \mu p_a + \mu^{\min(2\sigma+1,5)} \mathcal{R}_q, \quad \mu(p_a)_t = -\mu q_a + \mu \Delta_1 q_a - \mu^3 \beta \, \overline{\pi_0} q_a^3 + \mu^{\min(2\sigma+1,5)} \mathcal{R}_p,$$

where the operator Δ_1 acts on the variable $x, \overline{\pi_0}$ is the projector on the space of the functions with zero average, and the remainders are functions of the rescaled variables τ and y which satisfy

$$\sup_{\mathcal{B}_{\rho,n}(R)} \|\mathcal{R}_q\|_{\ell^2_{\rho,0}} \le C, \quad \sup_{\mathcal{B}_{\rho,n}(R)} \|\mathcal{R}_p\|_{\ell^2_{\rho,1}} \le C.$$

We now restrict the space variables to integer values; keeping in mind that q_a and p_a are periodic, we assume that $j \in \mathbb{Z}^2_{N_1,N_1^{\sigma}}$.

For a finite sequence $Q = (Q_j)_{j \in \mathbb{Z}^2_{N_1, N_1^{\sigma}}}$ we use the norm $\|Q\|^2_{\ell^2_{N_1, N_1^{\sigma}}}$ defined in (225).

Now we consider the discrete model (5): we rewrite in the following form,

$$\dot{Q}_j = P_j$$

(263)
$$\dot{P}_j = -Q_j + (\Delta_1 Q)_j - \beta \,\overline{\pi_0} Q_j^3$$

and we want to show that there exist two sequences $E=(E_j)_{j\in\mathbb{Z}^2_{N_1,N_i^q}}$ and $F=(F_j)_{j\in\mathbb{Z}^2_{N_1,N_i^q}}$ such that

$$Q = \mu q_a + \mu^{1+\gamma} E, \ P = \mu p_a + \mu^{1+\gamma} F$$

fulfills (262)-(263), where $\gamma > 0$ is a parameter we will fix later in the proof. Therefore, we have that

(264)
$$\dot{E} = F - \mu^{\min(2\sigma + 1, 5) - 1 - \gamma} \mathcal{R}_q$$

(265)
$$\dot{F} = -E + \Delta_1 E - \beta \overline{\pi_0} \left(3\mu^2 q_a^2 E + 3\mu^{2+\gamma} q_a E^2 + \mu^{2+2\gamma} E^3 \right) - \mu^{\min(2\sigma+1,5)-1-\gamma} \mathcal{R}_{p,p}$$

where we impose initial conditions on (E, F) such that (\tilde{q}, \tilde{p}) has initial conditions corresponding to the ones of the true initial datum,

$$\mu q_a(0, \mu j_1, \mu^{\sigma} j_2) + \mu^{1+\gamma} E_{0,j} = Q_{0,j},$$

$$\mu p_a(0, \mu j_1, \mu^{\sigma} j_2) + \mu^{1+\gamma} F_{0,j} = P_{0,j}.$$

We now define the operator ∂_i , i = 1, 2, by $(\partial_i f)_j := f_j - f_{j-e_i}$ for each $f \in \ell^2_{N_1, N_1^\sigma}$.

• Claim 1: Let $\sigma > 1$ and $\gamma > 0$, we have

$$\begin{split} \|E_0\|_{\ell^2_{N_1,N_1^{\sigma}}} &\leq C' \mu^{(3-2\gamma-\sigma)/2}, \ \|F_0\|_{\ell^2_{N_1,N_1^{\sigma}}} \leq C' \mu^{(3-2\gamma-\sigma)/2}, \ \|\partial_1 E_0\|_{\ell^2_{N_1,N_1^{\sigma}}} \leq C' \mu^{(5-2\gamma-\sigma)/2}, \\ \|\partial_2 E_0\|_{\ell^2_{N_1,N_1^{\sigma}}} &\leq C' \mu^{(3-2\gamma+\sigma)/2}, \ \|\partial_1 F_0\|_{\ell^2_{N_1,N_1^{\sigma}}} \leq C' \mu^{(5-2\gamma-\sigma)/2}, \ \|\partial_2 F_0\|_{\ell^2_{N_1,N_1^{\sigma}}} \leq C' \mu^{(3-2\gamma+\sigma)/2}. \end{split}$$

To prove Claim 1 we observe that

$$E_0 = \mu \frac{\psi_a + \bar{\psi}_a - (\widetilde{\psi}_a + \overline{\widetilde{\psi}}_a)}{\sqrt{2}\mu^{1+\gamma}} = \mu^{-\gamma} \frac{\phi_{\xi} + \phi_{\eta}}{\sqrt{2}},$$

$$F_0 = \mu \frac{\psi_a - \bar{\psi}_a - (\widetilde{\psi}_a - \overline{\widetilde{\psi}}_a)]}{\sqrt{2}i \,\mu^{1+\gamma}} = \mu^{-\gamma} \frac{\phi_{\xi} - \phi_{\eta}}{\sqrt{2}i},$$

from which we can deduce

$$\begin{split} \|E_0\|_{\ell^2_{N_1,N_1^{\sigma}}}^2 &\leq \sum_{j \in \mathbb{Z}^2_{N_1,N_1^{\sigma}}} |E_{0,j}|^2 \leq C \, 4N_1^{\sigma+1} \, (\mu^{2-\gamma})^2 = C \, \mu^{3-2\gamma-\sigma}, \\ \|F_0\|_{\ell^2_{N_1,N_1^{\sigma}}}^2 &\leq \sum_{j \in \mathbb{Z}^2_{N_1,N_1^{\sigma}}} |F_{0,j}|^2 \leq C \, 4N_1^{\sigma+1} \, (\mu^{2-\gamma})^2 = C \, \mu^{3-2\gamma-\sigma}, \\ \|\partial_1 E_0\|_{\ell^2_{N_1,N_1^{\sigma}}}^2 &\leq \sum_{j \in \mathbb{Z}^2_{N_1,N_1^{\sigma}}} |\partial_1 E_{0,j}|^2 \leq C \, 4N_1^{\sigma+1} \, (\mu^{2+1-\gamma})^2 \leq C \, \mu^{5-2\gamma-\sigma}, \\ \|\partial_2 E_0\|_{\ell^2_{N_1,N_1^{\sigma}}}^2 &\leq \sum_{j \in \mathbb{Z}^2_{N_1,N_1^{\sigma}}} |\partial_2 E_{0,j}|^2 \leq C \, 4N_1^{\sigma+1} \, (\mu^{2+\sigma-\gamma})^2 = C \, \mu^{3-2\gamma+\sigma}, \\ \|\partial_1 F_0\|_{\ell^2_{N_1,N_1^{\sigma}}}^2 &\leq \sum_{j \in \mathbb{Z}^2_{N_1,N_1^{\sigma}}} |\partial_1 F_{0,j}|^2 \leq C \, 4N_1^{\sigma+1} \, (\mu^{2+1-\gamma})^2 \leq C \, \mu^{5-2\gamma-\sigma}, \\ \|\partial_2 F_0\|_{\ell^2_{N_1,N_1^{\sigma}}}^2 &\leq \sum_{j \in \mathbb{Z}^2_{N_1,N_1^{\sigma}}} |\partial_2 F_{0,j}|^2 \leq C \, 4N_1^{\sigma+1} \, (\mu^{2+\sigma-\gamma})^2 = C \, \mu^{3-2\gamma+\sigma}, \end{split}$$

and this leads to the thesis.

• Claim 2: Fix $n \ge 0$, $T_0 > 0$ and $K_* > 0$, then for any $\mu < \mu_s$ and for any $\sigma > 1$ and $\gamma > 0$ such that $\sigma + 2\gamma < \min(4\sigma - 1, 7)$ we have

To prove the claim, we define

(267)
$$\mathcal{G}(E,F) := \sum_{j \in \mathbb{Z}_{N_1,N_j}^2} \left(\frac{F_j^2 + E_j^2 + E_j(-\Delta_1 E)_j}{2} + \frac{3\mu^2 \beta q_a^2 E_j^2 + 3\mu^{2+\gamma} \beta q_a E_j^3}{2} \right),$$

and we remark that

$$\frac{1}{2}\mathcal{G}(E,F) \leq \|E\|_{\ell^2_{N_1,N_1^{\sigma}}}^2 + \|\partial_1 F_0\|_{\ell^2_{N_1,N_1^{\sigma}}}^2 + \|\partial_2 F_0\|_{\ell^2_{N_1,N_1^{\sigma}}}^2 \leq 2\mathcal{G}(E,F).$$

Now we compute the time derivative of G. Exploiting (228)-(229) and using a procedure analogous to Appendix C, we finally obtain as long as $\mathcal{G} < 2K_*$

$$\left|\dot{\mathcal{G}}\right| \leq C \left[\mu^{2+\gamma} K_*^{1/2} + \mu^{2+2\gamma} K_* + \mu^3 + \mu^{2+\gamma} K_*^{1/2} + \mu^{\min(2\sigma+2,6)-(1+\sigma)/2} + \mu^{2+\gamma} K_*^{1/2}\right] \mathcal{G}$$

(269)
$$+ C \left[2\mu^{\min(2\sigma,4)-\gamma-(1+\sigma)/2} + \mu^{\min(2\sigma,4)-\gamma+(1-\sigma)/2} + \mu^{\min(2\sigma+2,6)-\gamma-(1+\sigma)/2} \right] K_*^{1/2}$$

(270)
$$\leq^{\sigma + 2\gamma < \min(4\sigma - 1, 7)} C \mu^{2} (1 + K_{*}^{1/2}) \mathcal{G} + C \mu^{(\min(4\sigma - 1, 7) - 2\gamma - \sigma)/2} K_{*}^{1/2}$$

and by applying Gronwall's lemma we get

(271)
$$\mathcal{G}(t) \leq \mathcal{G}(0)e^{C(1+K_*^{1/2})\mu^2t} + e^{C(1+K_*^{1/2})\mu^2t} C(1+K_*^{1/2})\mu^2t C\mu^{(\min(4\sigma-1,7)-2\gamma-\sigma)/2} K_*^{1/2},$$

from which we can deduce the thesis.
