# Numerical Schemes for Backward Stochastic Differential Equations Driven by $G$-Brownian motion

#### Abstract

We design a class of numerical schemes for backward stochastic differential equation driven by $G$-Brownian motion ( $G$-BSDE), which is related to a fully nonlinear PDE. Based on Peng's central limit theorem, we employ the CLT method to approximate $G$-distributed. Rigorous stability and convergence analysis are also carried out. It is shown that the $\theta$-scheme admits a half order convergence rate in the general case. In particular, for the case of $\theta_{1} \in[0,1]$ and $\theta_{2}=0$, the scheme can reach first-order in the deterministic case. Several numerical tests are given to support our theoretical results.


Keywords. backward stochastic differential equation driven by $G$-Brownian motion, $\theta$-scheme, error estimates, CLT method

## 1 Introduction

In 1990, Pardoux and Peng in [19] proved the existence and uniqueness of the solution for nonlinear backward stochastic differential equations (BSDEs). Since then, the theory of BSDEs has grown into a indispensable tool in many areas. In particular, it is used to measure financial risk under uncertainty of probabilities. But this type of BSDE is difficult to price path-dependent contingent claims in the uncertain volatility model (UVM). To overcome this obstacle, Peng systemically established a time-consistent fully nonlinear expectation theory and introduced $G$-expectation [20-22]. Under $G$-expectation framework, a new type of Brownian motion called $G$-Brownian motion was constructed and the corresponding stochastic calculus of Itô's type was established. Hu et al. [13] obtained the existence and uniqueness of solution for the following fully nonlinear BSDE driven by $G$-Brownian motion ( $G$-BSDE for short, in this paper we always use Einstein convention):

where $B_{t}=\left(B_{t}^{1}, \ldots, B_{t}^{d}\right)^{\top}$ is a $d$-dimensional $G$-Brownian motion, $f, g_{i j}:[0, T] \times \Omega_{T} \times \mathbb{R} \times \mathbb{R}^{d} \rightarrow \mathbb{R}$, $i, j=1, \ldots, d$ are stochastic processes in $M_{G}^{\beta}(0, T)$ for some $\beta>1$. Under some regularity conditions on $f$,

[^0]$g_{i j}$ and $\xi$, the equation 1.1 has a unique solution $(Y, Z, K), K$ is a decreasing $G$-martingale. Furthermore, Hu et al. [14] studied nonlinear Feynman-Kac formula under the framework of $G$-expectation (see Theorem 2.3 , which built the relationship between $G$-BSDEs and the fully nonlinear PDEs.
$G$-expectation theory and its applications have been developed in recent research [4, 6, 7, 12, 25, 26. Depending on the underlying volatility, it is well known that the Black-Sholes price can be presented by the solution of BSDEs. Hu and Ji [12] studied the pricing of contingent claims under $G$-expectation. They found that the superhedging and subhedging prices of the given contingent claim $\xi$ are related to $Y_{t}$, which is the solution of the following $G$ - BSDE

where $\left(r_{s}\right)_{s \in[0, T]}$ is the return on the riskless asset, $\left(a_{s}\right)_{s \in[0, T]}$ and $\left(b_{s}^{i j}\right)_{s \in[0, T]}$ are bounded processes in $M_{G}^{2}\left(0, T ; \mathbb{R}^{1 \times d}\right)$. Indeed, in the Markovian case, the superhedging and subhedging prices are the BlackScholes prices with volatilities $\underline{\sigma}^{2}$ and $\bar{\sigma}^{2}$ respectively. Therefore, proposing an efficient numerical approach to approximate the process $Y_{t}$ has important practical significance.

Based on contingent claim pricing models, we devote to designing a numerical scheme for the following type of $G$-BSDE

where $B_{t}=\left(B_{t}^{1}, \ldots, B_{t}^{d}\right)^{\top}$ is a $d$-dimensional $G$-Brownian motion defined in the $G$-expectation space $\left(\Omega_{T}, L_{G}^{1}\left(\Omega_{T}\right), \hat{\mathbb{E}}\right),\left(a_{s}\right)_{s \in[0, T]}$ and $\left(b_{s}^{i j}\right)_{s \in[0, T]}$ are bounded processes in $M_{G}^{\beta}\left(0, T ; \mathbb{R}^{1 \times d}\right)$, and $f, g_{i j}:[0, T] \times$ $\Omega_{T} \times \mathbb{R} \rightarrow \mathbb{R}, i, j=1, \ldots, d$ satisfy the following properties:
(H1) There exists a constant $\beta>2$ such that $f(\cdot, y), g_{i j}(\cdot, y) \in M_{G}^{\beta}(0, T)$ for any $y$;
(H2) There exists a constant $L>0$ such that

Tremendous efforts have been made on the numerical computing of BSDEs (see, e.g., [1-3, 5, 9, 10, [17, 18, 27-31 and references therein), but little attention has been paid to $G$-BSDEs. There are some technical obstacles in developing numerical schemes for $G$-BSDEs. On the one hand, owing to the sublinear nature of $G$-expectation, many conclusions under linear expectation can not be extended to $G$-expectation, which increases the difficulty of theoretical analysis. On the other hand, there is no integral representation for $G$-normal distributed, traditional numerical integration methods of normal distribution are no longer applicable.

Zhao [29] proposed a $\theta$-scheme to solve BSDEs directly, which is highly efficient and accurate. Unlike classical BSDEs, it is difficult to present a numerical scheme for $G$-BSDEs directly. To overcome it, we construct an auxiliary extended $\widetilde{G}$-expectation space and design a new $\theta$-scheme for solving $Y_{t}$ of the $G$ BSDE $\sqrt{1.2}$ in this space. Furthermore, on the basis of Peng's central limit theorem [23], we use the CLT
method to approximate $G$-distributed. Full stability and convergence analysis are also derived. It is shown that our $\theta$-scheme admits a half order rate of convergence in the general case. In particular, for the case of $\theta_{1} \in[0,1]$ and $\theta_{2}=0$, our schemes can reach first-order convergence in the deterministic case. To the best of our knowledge, this is the first attempt to design numerical schemes for $G$-BSDEs.

For simple representations, we introduce some notations that will be used extensively throughout the paper:

- $|\cdot|$ : the standard Euclidean norm in $\mathbb{R}$ and $\mathbb{R}^{d}$.
- $C^{\frac{1}{2}, 1}$ : continuous functions $\phi:[0, T] \times \mathbb{R}\left(\mathbb{R}^{d}\right) \rightarrow \mathbb{R}$ such that $|\phi(t, x)-\phi(s, y)| \leq C\left(|t-s|^{\frac{1}{2}}+|x-y|\right)$, $C>0, \forall t, s \in[0, T], \forall x, y \in \mathbb{R}\left(\mathbb{R}^{d}\right)$. (Note: $\phi(x) \in C^{\frac{1}{2}, 1}$ means that $\phi$ is a Lipschitz continuous function).
- $C_{b}^{l, k}$ : continuously differentiable functions $\phi:[0, T] \times \mathbb{R}\left(\mathbb{R}^{d}\right) \rightarrow \mathbb{R}$ with uniformly bounded partial derivatives $\partial_{t}^{l_{1}} \phi$ and $\partial_{x}^{k_{1}} \phi$ for $l_{1} \leq l$ and $k_{1} \leq k$.
- $\hat{\mathbb{E}}_{t_{n}}^{x}[X]$ : the conditional $\tilde{G}$-expectation of $X$, under the $\sigma$-field $\sigma\left\{B_{t}=x\right\}$, i.e. $\hat{\mathbb{E}}\left[X \mid B_{t_{n}}=x\right]$.

The paper is organized as follow. In Section 2, we recall some basic notations and results for stochastic calculus under $G$-framework. In Section 3, we propose a class of $\theta$-schemes for $G$-BSDEs by choosing different parameters $\theta_{i}(i=1,2)$. The analysis of stability and convergence is separately discussed in Section 4 and 5 . In Section 6, we employ the CLT method for $G$-distributed simulation and conclude the paper in Section 7 with numerical examples that illustrate the performance of our schemes.

## 2 Preliminaries

The main purpose of this section is to recall some basic notions and results of $G$-Expectation, $G$-Brownian motion and $G$-BSDEs, which are needed in the sequel. More details can refer to 20 22] and references therein.

### 2.1 G-Brownian motion

Definition 2.1 Let $\Omega$ be a given set and let $\mathcal{H}$ be a linear space of real valued functions defined on $\Omega$, satisfies $c \in \mathcal{H}$ for each constant $c$ and $|X| \in \mathcal{H}$ if $X \in \mathcal{H} . \mathcal{H}$ is considered as the space of random variables. A sublinear expectation $\hat{\mathbb{E}}$ on $\mathcal{H}$ is a functional $\hat{\mathbb{E}}: \mathcal{H} \rightarrow \mathbb{R}$ satisfying the following properties: for all $X, Y$ $\in \mathcal{H}$, we have
(a) Monotonicity: If $X \geq Y$ then $\hat{\mathbb{E}}[X] \geq \hat{\mathbb{E}}[Y]$;
(b) Constant preservation: $\hat{\mathbb{E}}[c]=c$;
(c) Sub-additivity: $\hat{\mathbb{E}}[X+Y] \leq \hat{\mathbb{E}}[X]+\hat{\mathbb{E}}[Y]$;
(d) Positive homogeneity: $\hat{\mathbb{E}}[\lambda X]=\lambda \hat{\mathbb{E}}[X]$ for each $\lambda>0$.
$(\Omega, \mathcal{H}, \hat{\mathbb{E}})$ is called a sublinear expectation space. From the definition of the sublinear expectation $\hat{\mathbb{E}}$, the following results can be easily obtained.

Proposition 2.2 For $X, Y \in \mathcal{H}$, we have
(i) $\hat{\mathbb{E}}[\lambda X]=\lambda^{+} \hat{\mathbb{E}}[X]+\lambda^{-} \hat{\mathbb{E}}[-X]$, for each $\lambda \in \mathbb{R}$;
(ii) If $\hat{\mathbb{E}}[X]=-\hat{\mathbb{E}}[-X]$, then $\hat{\mathbb{E}}[X+Y]=\hat{\mathbb{E}}[X]+\hat{\mathbb{E}}[Y]$;
(iii) $|\hat{\mathbb{E}}[X]-\hat{\mathbb{E}}[Y]| \leq \hat{\mathbb{E}}[|X-Y|]$, i.e. $|\hat{\mathbb{E}}[X]-\hat{\mathbb{E}}[Y]| \leq \hat{\mathbb{E}}[X-Y] \vee \hat{\mathbb{E}}[Y-X]$;
(iv) $\hat{\mathbb{E}}[|X Y|] \leq\left(\hat{\mathbb{E}}\left[|X|^{p}\right]\right)^{1 / p} \cdot\left(\hat{\mathbb{E}}\left[|Y|^{q}\right]\right)^{1 / q}$, for $1 \leq p, q<\infty$ with $\frac{1}{p}+\frac{1}{q}=1$.

Definition 2.3 Let $X_{1}$ and $X_{2}$ be two $n$-dimensional random vectors defined respectively in sublinear expectation spaces $\left(\Omega_{1}, \mathcal{H}_{1}, \hat{\mathbb{E}}_{1}\right)$ and $\left(\Omega_{2}, \mathcal{H}_{2}, \hat{\mathbb{E}}_{2}\right)$. They are called identically distributed, denoted by $X_{1} \stackrel{d}{=} X_{2}$, if $\hat{\mathbb{E}}_{1}\left[\varphi\left(X_{1}\right)\right]=\hat{\mathbb{E}}_{2}\left[\varphi\left(X_{2}\right)\right]$, for all $\varphi \in C_{b, \text { Lip }}\left(\mathbb{R}^{n}\right)$, the space of bounded Lipschitz continuous functions on $\mathbb{R}^{n}$.

Definition 2.4 In a sublinear expectation space $(\Omega, \mathcal{H}, \hat{\mathbb{E}})$, a random vector $Y=\left(Y_{1, \ldots}, Y_{n}\right)$, $Y_{i} \in \mathcal{H}$, is said to be independent from another random vector $X=\left(X_{1, \ldots}, X_{m}\right), X_{i} \in \mathcal{H}$ under $\hat{\mathbb{E}}[\cdot]$, denoted by $Y \perp X$, if for every test function $\varphi \in C_{b, \text { Lip }}\left(\mathbb{R}^{m} \times \mathbb{R}^{n}\right)$ we have $\hat{\mathbb{E}}[\varphi(X, Y)]=\hat{\mathbb{E}}\left[\hat{\mathbb{E}}[\varphi(x, Y)]_{x=X}\right]$.

Definition 2.5 A d-dimensional random vector $X=\left(X_{1, \ldots,}, X_{d}\right)$ in a sublinear expectation space $(\Omega, \mathcal{H}, \hat{\mathbb{E}})$ is called $G$-normally distributed if for each $a, b \geq 0$ we have

a X+b \bar{X}=\sqrt{a^{2}+b^{2}} X
$$

where $\bar{X}$ is an independent copy of $X, G: \mathbb{S}(d) \rightarrow \mathbb{R}$ denotes the function

G(A):=\frac{1}{2} \hat{\mathbb{E}}[\langle A X, X\rangle], \quad A \in \mathbb{S}(d)
$$

where $\mathbb{S}(d)$ denotes the collection of $d \times d$ symmetric matrices. We assume that $G$ is non-degenerate, i.e., there exist some constants $0<\underline{\sigma}^{2} \leq \bar{\sigma}^{2}<\infty$ such that $\frac{1}{2} \underline{\sigma}^{2} \operatorname{tr}[A-B] \leq G(A)-G(B) \leq \frac{1}{2} \bar{\sigma}^{2} \operatorname{tr}[A-B]$ for $A \geq B$. Then there exists a bounded and closed subset $\Gamma \subset \mathbb{S}^{+}(d)$ such that

where $\mathbb{S}^{+}(d)$ denotes the collection of nonnegative elements in $\mathbb{S}(d)$. In this paper, we also assume $\sigma^{2}=\underline{\sigma}^{2} \leq$ $\bar{\sigma}^{2}=1$.

Now we give definitions of $G$-Brownian motion, $G$-expectation and conditional $G$-expectation.
Definition 2.6 Let $\Omega_{T}=C_{0}\left([0, T] ; \mathbb{R}^{d}\right)$, the space of real valued continuous functions on $[0, T]$ with $\omega_{0}=0$, be endowed with the supremum norm. Set

\operatorname{Lip}\left(\Omega_{T}\right)=\left\{\varphi\left(B_{t_{1}}, \ldots, B_{t_{n}}\right): n \geq 1, t_{1}, \ldots, t_{n} \in[0, T], \varphi \in C_{b, L i p}\left(\mathbb{R}^{d \times n}\right)\right\}
$$

$G$-expectation on $\left(\Omega_{T}, \operatorname{Lip}\left(\Omega_{T}\right)\right)$ is a sublinear expectation defined by

\hat{\mathbb{E}}[X]=\tilde{\mathbb{E}}\left[\varphi\left(\sqrt{t_{1}-t_{0}} \xi_{1}, \ldots, \sqrt{t_{m}-t_{m-1}} \xi_{m}\right)\right]
$$

for all $X=\varphi\left(B_{t_{1}}-B_{t_{0}}, \ldots, B_{t_{m}}-B_{t_{m-1}}\right), B_{t}(\omega)=\omega_{t}$, where $\xi_{1}, \ldots, \xi_{m}$ are identically distributed ddimensional $G$-normally distributed random vectors in a sublinear expectation space $(\tilde{\Omega}, \tilde{\mathcal{H}}, \tilde{\mathbb{E}})$ such that $\xi_{i+1}$ is independent from $\left(\xi_{1}, \ldots, \xi_{i}\right), i=1, \ldots, m-1$. The corresponding canonical process $B_{t}=\left(B_{t}^{i}\right)_{i=1}^{d}$ is called a G-Brownian motion and $\left(\Omega_{T}, \operatorname{Lip}\left(\Omega_{T}\right), \hat{\mathbb{E}}\right)$ is called a $G$-expectation space.

Definition 2.7 We assume that $\xi \in \operatorname{Lip}\left(\Omega_{T}\right)$ has the representation $\xi=\varphi\left(B_{t_{1}}-B_{t_{0}}, \ldots, B_{t_{m}}-B_{t_{m-1}}\right)$, define the conditional $G$-expectation $\hat{\mathbb{E}}_{t_{i}}$ of $\xi$, for some $1 \leq i \leq m$

\hat{\mathbb{E}}_{t_{i}}\left[\varphi\left(B_{t_{1}}-B_{t_{0}}, \ldots, B_{t_{m}}-B_{t_{m-1}}\right)\right]=\tilde{\varphi}\left(B_{t_{1}}-B_{t_{0}}, \ldots, B_{t_{i}}-B_{t_{i-1}}\right),
$$

where

\tilde{\varphi}\left(x_{1}, \ldots, x_{i}\right)=\hat{\mathbb{E}}_{t_{i}}\left[\varphi\left(x_{1}, \ldots, x_{i}, B_{t_{i+1}}-B_{t_{i}}, \ldots, B_{t_{m}}-B_{t_{m-1}}\right)\right] .

Define $\|\xi\|_{p, G}=\left(\hat{\mathbb{E}}\left[|\xi|^{p}\right]\right)^{1 / p}$, for $\xi \in \operatorname{Lip}\left(\Omega_{T}\right)$ and $p \geq 1$. Then $\hat{\mathbb{E}}_{t}[\cdot]$ can be extended continuously to the completion $L_{G}^{1}\left(\Omega_{T}\right)$ of $\operatorname{Lip}\left(\Omega_{T}\right)$ under the norm $\|\cdot\|_{1, G}$.

Proposition 2.8 For $X \in \operatorname{Lip}\left(\Omega_{T}\right)$, we have
(I) $\hat{\mathbb{E}}_{t}[\xi]=\xi$, for $\xi \in \operatorname{Lip}\left(\Omega_{t}\right)$;
(II) $\hat{\mathbb{E}}_{t}[\xi X]=\xi^{+} \hat{\mathbb{E}}_{t}[X]+\xi^{-} \hat{\mathbb{E}}_{t}[-X]$, for $\xi \in \operatorname{Lip}\left(\Omega_{t}\right)$;
(III) $\hat{\mathbb{E}}_{s}\left[\hat{\mathbb{E}}_{t}[X]\right]=\hat{\mathbb{E}}_{s}[X]$, for $s \leq t$;
(IV) $\hat{\mathbb{E}}\left[\hat{\mathbb{E}}_{t}[X]\right]=\hat{\mathbb{E}}[X]$.

## 2.2 $G$-Itô's formula and Feynman-Kac formula

Set

M_{G}^{0}(0, T)=\left\{\sum_{j=0}^{N-1} \xi_{j}(\omega) I_{\left[t_{j}, t_{j+1}\right)}(t): 0=t_{0}<\cdots<t_{N}=T, \xi_{j} \in \operatorname{Lip}\left(\Omega_{t_{j}}\right)\right\}
$$

For $p \geq 1$ and $\eta \in M_{G}^{0}(0, T)$, let $\|\eta\|_{M_{G}^{p}}=\left(\hat{\mathbb{E}}\left[\int_{0}^{T}\left|\eta_{s}\right|^{p} \mathrm{~d} s\right]\right)^{1 / p}$ and denote by $M_{G}^{p}(0, T)$ the completion of $M_{G}^{0}(0, T)$ under $\|\cdot\|_{M_{G}^{p}}$.

For each $1 \leq i, j \leq d$, we denote by $\left\langle B^{i}, B^{j}\right\rangle$ the mutual variation process. We can define Itô's integrals $\int_{0}^{T} \eta_{s} B_{s}^{i}$ and $\int_{0}^{T} \xi_{s}\left\langle B^{i}, B^{j}\right\rangle_{s}$, for two processes $\eta \in M_{G}^{2}(0, T)$ and $\xi \in M_{G}^{1}(0, T)$ (see [20 22]).

Consider the following $n$-dimensional process:

where $v=1, \ldots, n, i, j=1, \ldots, d$. Now we give the following $G$-Itô's formula.

Theorem 2.9 ([22]) Let $\Phi$ be a $C^{2}$-function on $\mathbb{R}^{n}$ such that $\partial_{x^{\mu} x^{v}}^{2} \Phi$ satisfy polynomial growth condition for $\mu, v=1, \ldots, n$. Let $\alpha^{v}, \beta^{v j}$ and $\eta^{v i j}, v=1, \ldots, n, i, j=1, \ldots, d$ be bounded processes in $M_{G}^{2}(0, T)$. Then for each $t \geq 0$ we have

Theorem 2.10 ([14]) Let the functions $f, g_{i j}$ be continuous with respect to $t$ and Lipschitz continuous with respect to $y, \varphi$ be an Lipschitz continuous function. Then the unique solution of $G$-BSDEs 1.2 can be represented as $Y_{t}=u\left(t, B_{t}\right)$, where $u(t, x) \in C^{\frac{1}{2}, 1}$ is the unique viscosity solution of the following PDE:

## 3 Numerical schemes for $G$-BSDEs

### 3.1 Explicit expression of $Y_{t}$

Without loss of generality, we only consider the case of $d=1$. The results still hold for the case $d>1$. Let $\Omega_{T}=C_{0}([0, T] ; \mathbb{R})$, the space of $\mathbb{R}$-valued continuous functions on $[0, T]$ with $\omega_{0}=0$. we consider the following type of $G$-BSDE defined in the $G$-expectation space $\left(\Omega_{T}, L_{G}^{1}\left(\Omega_{T}\right), \hat{\mathbb{E}}\right)$

$$
\begin{align*}
Y_{t}=\xi & +\int_{t}^{T}\left(f\left(s, Y_{s}\right)+a_{s} Z_{s}\right) d s+\int_{t}^{T}\left(g\left(s, Y_{s}\right)+b_{s} Z_{s}\right) d\langle B\rangle_{s} \\
& -\int_{t}^{T} Z_{s} d B_{s}-\left(K_{T}-K_{t}\right), \tag{3.1}
\end{align*}
$$

where $\xi \in L_{G}^{\beta}\left(\Omega_{T}\right), \beta>1, f, g:[0, T] \times \Omega_{T} \times \mathbb{R} \rightarrow \mathbb{R}$ satisfy $(\mathrm{H} 1)-(\mathrm{H} 2),\left(a_{s}\right)_{s \in[0, T]}$ and $\left(b_{s}\right)_{s \in[0, T]}$ are bounded processes in $M_{G}^{\beta}(0, T ; \mathbb{R})$.

To get the explicit expression of $Y_{t}$ excluding $Z_{t}$, we construct an auxiliary extended $\tilde{G}$-expectation space $\left(\tilde{\Omega}_{T}, L_{\tilde{G}}^{1}\left(\tilde{\Omega}_{T}\right), \hat{\mathbb{E}}^{\tilde{G}}\right)$ with $\tilde{\Omega}_{T}=C_{0}\left([0, \infty), \mathbb{R}^{2}\right)$ and

\tilde{G}(A)=\frac{1}{2} \sup _{\sigma^{2} \leq v \leq 1} \operatorname{tr}\left[A\left[\begin{array}{rr}
v & 1 \\
1 & v^{-1}
\end{array}\right]\right], \quad A \in \mathbb{S}(2)
$$

To simplify presentation, we still denote by $\hat{\mathbb{E}}$ the extended $\tilde{G}$-expectation in the sequel. Let $\left(B_{t}, \tilde{B}_{t}\right)_{t \geq 0}$ be the canonical process in the extended space, it is easy to check that $\langle B, \tilde{B}\rangle_{t}=t$.

Now, introducing the following linear $\tilde{G}$-SDE:

it is easy to verify that

X_{t}=\exp \left(\int_{0}^{t}-a_{s} b_{s} d s\right) \exp \left(\int_{0}^{t} b_{s} d B_{s}-\frac{1}{2} \int_{0}^{t} b_{s}{ }^{2} d\langle B\rangle_{s}\right) \exp \left(\int_{0}^{t} a_{s} d \tilde{B}_{s}-\frac{1}{2} \int_{0}^{t} a_{s}{ }^{2} d\langle\tilde{B}\rangle_{s}\right) . \tag{3.3}
\end{equation*}
$$

Applying Itô's formula to $X_{t} Y_{t}$, we obtain

X_{t} Y_{t}= & X_{T} \xi+\int_{t}^{T} X_{s} f\left(s, Y_{s}\right) d s+\int_{t}^{T} X_{s} g\left(s, Y_{s}\right) d\langle B\rangle_{s}-\int_{t}^{T} a_{s} X_{s} Y_{s} d \tilde{B}_{s} \\
& -\int_{t}^{T}\left(X_{s} Z_{s}+b_{s} X_{s} Y_{s}\right) d B_{s}-\int_{t}^{T} X_{s} d K_{s}
\end{aligned}
$$

By Lemma 3.4 in [13], $\left\{\int_{0}^{t} X_{s} d K_{s}\right\}_{0 \leq t \leq T}$ is a $\tilde{G}$-martingale. Thus we get the explicit expression of $Y_{t}$ excluding $Z_{t}$

Y_{t}=\hat{\mathbb{E}}_{t}\left[X_{T}^{t} \xi+\int_{t}^{T} X_{s}^{t} f\left(s, Y_{s}\right) d s+\int_{t}^{T} X_{s}^{t} g\left(s, Y_{s}\right) d\langle B\rangle_{s}\right], \tag{3.4}
\end{equation*}
$$

where $X_{s}^{t}=X_{s} / X_{t}$.

### 3.2 The semi-discrete scheme

For the time interval $[0, T]$, we introduce the following partition:

with $\Delta t_{n}=t_{n+1}-t_{n}$ and $\Delta t=\max _{0 \leq n \leq N-1} \Delta t_{n}$. We denote $\Delta B_{n, s}=B_{s}-B_{t_{n}} \sim N\left(\{0\} \times\left(s-t_{n}\right) \Sigma\right)$ and $\Delta \tilde{B}_{n, s}=\tilde{B}_{s}-\tilde{B}_{t_{n}} \sim N\left(\{0\} \times\left(s-t_{n}\right) \tilde{\Sigma}\right)$ with $\Sigma=\left[\sigma^{2}, 1\right]$ and $\tilde{\Sigma}=\left[1, \frac{1}{\sigma^{2}}\right]$, respectively, for $t_{n} \leq s \leq t_{n+1}$. We also denote quadratic variation processes $\Delta\langle B\rangle_{n, s}=\langle B\rangle_{s}-\langle B\rangle_{t_{n}}$ and $\Delta\langle\tilde{B}\rangle_{n, s}=\langle\tilde{B}\rangle_{s}-\langle\tilde{B}\rangle_{t_{n}}$, for $t_{n} \leq s \leq t_{n+1}$.

Let $f_{s}=f\left(s, Y_{s}\right)$ and $g_{s}=g\left(s, Y_{s}\right)$. From (3.4) we can obtain

X_{t}^{t_{n}}=\exp \left(\int_{t_{n}}^{t}-a_{s} b_{s} d s\right) \exp \left(\int_{t_{n}}^{t} b_{s} d B_{s}-\frac{1}{2} \int_{t_{n}}^{t} b_{s}^{2} d\langle B\rangle_{s}\right) \exp \left(\int_{t_{n}}^{t} a_{s} d \tilde{B}_{s}-\frac{1}{2} \int_{t_{n}}^{t} a_{s}^{2} d\langle\tilde{B}\rangle_{s}\right) . \tag{3.7}
\end{equation*}

It is easy to verify that $X_{t}^{t_{n}}$ satisfies the following $\tilde{G}$-SDE

X_{t}^{t_{n}}=1+\int_{t_{n}}^{t} a_{s} X_{s}^{t_{n}} d \tilde{B}_{s}+\int_{t_{n}}^{t} b_{s} X_{s}^{t_{n}} d B_{s}, \quad t \in\left[t_{n}, t_{n+1}\right] \tag{3.8}
\end{equation*}

Similar to numerical integration methods, using the $\theta$-scheme to approximate the stochastic integrals in (3.6), we have

& \left.+\left(\theta_{2} g_{t_{n}}+\left(1-\theta_{2}\right) X_{t_{n+1}}^{t_{n}} g_{t_{n+1}}\right) \Delta\langle B\rangle_{n, t_{n+1}}\right]+R_{y}^{n}, \tag{3.9}
\end{align*}

where $R_{y}^{n}=R_{y_{1}}^{n}+R_{y_{2}}^{n}$, with

R_{y_{1}}^{n}= & \hat{\mathbb{E}}_{t_{n}}^{x}\left[X_{t_{n+1}}^{t_{n}} Y_{t_{n+1}}+\int_{t_{n}}^{t_{n+1}} X_{s}^{t_{n}} f_{s} d s+\int_{t_{n}}^{t_{n+1}} X_{s}^{t_{n}} g_{s} d\langle B\rangle_{s}\right]  \tag{3.10}\\
& -\hat{\mathbb{E}}_{t_{n}}^{x}\left[X_{t_{n+1}}^{t_{n}} Y_{t_{n+1}}+\left(\theta_{1} f_{t_{n}}+\left(1-\theta_{1}\right) X_{t_{n+1}}^{t_{n}} f_{t_{n+1}}\right) \Delta t_{n}+\int_{t_{n}}^{t_{n+1}} X_{s}^{t_{n}} g_{s} d\langle B\rangle_{s}\right]
\end{align*}
$$

and

\begin{align*}
R_{y_{2}}^{n}= & \hat{\mathbb{E}}_{t_{n}}^{x}\left[X_{t_{n+1}}^{t_{n}} Y_{t_{n+1}}+\left(\theta_{1} f_{t_{n}}+\left(1-\theta_{1}\right) X_{t_{n+1}}^{t_{n}} f_{t_{n+1}}\right) \Delta t_{n}+\int_{t_{n}}^{t_{n+1}} X_{s}^{t_{n}} g_{s} d\langle B\rangle_{s}\right] \\
& -\hat{\mathbb{E}}_{t_{n}}^{x}\left[X_{t_{n+1}}^{t_{n}} Y_{t_{n+1}}+\left(\theta_{1} f_{t_{n}}+\left(1-\theta_{1}\right) X_{t_{n+1}}^{t_{n}} f_{t_{n+1}}\right) \Delta t_{n}\right.  \tag{3.11}\\
& \left.+\left(\theta_{2} g_{t_{n}}+\left(1-\theta_{2}\right) X_{t_{n+1}}^{t_{n}} g_{t_{n+1}}\right) \Delta\langle B\rangle_{n, t_{n+1}}\right] .
\end{align*}

In the meanwhile, we employ Euler's method to approximate the stochastic integrals in $X_{t_{n+1}}^{t_{n}}$, denoted by $\tilde{X}_{t_{n+1}}^{t_{n}}$, then

\tilde{X}_{t_{n+1}}^{t_{n}}= & \exp \left(-\int_{t_{n}}^{t_{n+1}} a_{t_{n}} b_{t_{n}} d s\right) \exp \left(\int_{t_{n}}^{t_{n+1}} b_{t_{n}} d B_{s}-\frac{1}{2} \int_{t_{n}}^{t_{n+1}} b_{t_{n}}^{2} d\langle B\rangle_{s}\right)  \tag{3.12}\\
& \exp \left(\int_{t_{n}}^{t_{n+1}} a_{t_{n}} d \tilde{B}_{s}-\frac{1}{2} \int_{t_{n}}^{t_{n+1}} a_{t_{n}}^{2} d\langle\tilde{B}\rangle_{s}\right)
\end{align*}
$$

Replacing $X_{t_{n+1}}^{t_{n}}$ with $\tilde{X}_{t_{n+1}}^{t_{n}}$ in 3.9 , we get the following reference equation

& \left.+\left(\theta_{2} g_{t_{n}}+\left(1-\theta_{2}\right) \tilde{X}_{t_{n+1}}^{t_{n}} g_{t_{n+1}}\right) \Delta\langle B\rangle_{n, t_{n+1}}\right]+R_{x}^{n}+R_{y}^{n} \tag{3.13}
\end{align*}
$$

where

\begin{align*}
R_{x}^{n}= & \hat{\mathbb{E}}_{t_{n}}^{x}\left[X_{t_{n+1}}^{t_{n}} Y_{t_{n+1}}+\left(\theta_{1} f_{t_{n}}+\left(1-\theta_{1}\right) X_{t_{n+1}}^{t_{n}} f_{t_{n+1}}\right) \Delta t_{n}\right. \\
& \left.+\left(\theta_{2} g_{t_{n}}+\left(1-\theta_{2}\right) X_{t_{n+1}}^{t_{n}} g_{t_{n+1}}\right) \Delta\langle B\rangle_{n, t_{n+1}}\right]  \tag{3.14}\\
& -\hat{\mathbb{E}}_{t_{n}}^{x}\left[\tilde{X}_{t_{n+1}}^{t_{n}} Y_{t_{n+1}}+\left(\theta_{1} f_{t_{n}}+\left(1-\theta_{1}\right) \tilde{X}_{t_{n+1}}^{t_{n}} f_{t_{n+1}}\right) \Delta t_{n}\right. \\
& \left.+\left(\theta_{2} g_{t_{n}}+\left(1-\theta_{2}\right) \tilde{X}_{t_{n+1}}^{t_{n}} g_{t_{n+1}}\right) \Delta\langle B\rangle_{n, t_{n+1}}\right] .
\end{align*}

Let $Y^{n}$ denote the numerical approximation to the analytic solution $Y_{t}$ at time level $t=t_{n} \quad(n=$ $0,1, \ldots, N-1)$. To maintain the consistency of representation, we use $X^{n}$ to denote $\tilde{X}_{t_{n}}^{t_{n-1}}(n=1, \ldots, N)$. Based on (3.13), we propose the following semi-discrete $\theta$-scheme for solving $Y_{t}$ of the $G$-BSDE (3.1).

Scheme 1 Given random variables $Y^{N}$, solve random variables $Y^{n}$, $n=N-1, \ldots, 0$ from

\left\{\begin{align*}
Y^{n}= & \hat{\mathbb{E}}_{t_{n}}^{x}\left[X^{n+1} Y^{n+1}+\left(\theta_{1} f\left(t_{n}, Y^{n}\right)+\left(1-\theta_{1}\right) X^{n+1} f\left(t_{n+1}, Y^{n+1}\right)\right) \Delta t_{n}\right.  \tag{3.15}\\
& \left.+\left(\theta_{2} g\left(t_{n}, Y^{n}\right)+\left(1-\theta_{2}\right) X^{n+1} g\left(t_{n+1}, Y^{n+1}\right)\right) \Delta\langle B\rangle_{n, t_{n+1}}\right] \\
X^{n+1}= & \exp \left(-a_{t_{n}} b_{t_{n}} \Delta t_{n}\right) \exp \left(b_{t_{n}} \Delta B_{n, t_{n+1}}-\frac{1}{2} b_{t_{n}}^{2} \Delta\langle B\rangle_{n, t_{n+1}}\right) \\
& \exp \left(a_{t_{n}} \Delta \tilde{B}_{n, t_{n+1}}-\frac{1}{2} a_{t_{n}}^{2} \Delta\langle\tilde{B}\rangle_{n, t_{n+1}}\right)
\end{align*}\right.
$$

with the deterministic parameters $\theta_{i} \in[0,1](i=1,2)$.

Remark 3.1 Usually, we pay more attention to the solution $Y_{t}$ of the $G$-BSDE (3.1), which reflects the hedging price of a given contingent claim. By introducing the $\tilde{G}$-SDE, we obtained the scheme 1 for solving $Y_{t}$, which $Z_{t}$ can be excluded completely.

Remark 3.2 By choosing different $\theta_{i}(i=1,2) \in[0,1]$, we can obtain a class of different $\theta$-schemes for solving the solution $Y_{t}$ of the $G$-BSDE. Our $\theta$-schemes can admit a first order rate of convergence when $\theta_{1} \in[0,1]$ and $\theta_{2}=0$ in the deterministic case, which will be confirmed in later numerical experiments.

## 4 Stability analysis

In this section, we focus on the stability analysis of the numerical scheme. In what follows, $C$ represents a generic constant, which may be different from line to line.

Lemma 4.1 Let $a_{s}, b_{s} \in M_{G}^{2}(0, T)$ be bounded processes. Then for all $t \in\left[t_{n}, t_{n+1}\right], n=0,1, \ldots, N-1$,

1. $\hat{\mathbb{E}}_{t_{n}}^{x}\left[\tilde{X}_{t}^{t_{n}}\right]=1$ and $\hat{\mathbb{E}}_{t_{n}}^{x}\left[\left(\tilde{X}_{t}^{t_{n}}\right)^{2}\right] \leq 1+C \Delta t$;
2. $\hat{\mathbb{E}}_{t_{n}}^{x}\left[X_{t}^{t_{n}}\right]=1$ and $\hat{\mathbb{E}}_{t_{n}}^{x}\left[\left(X_{t}^{t_{n}}\right)^{2}\right] \leq 1+C \Delta t$,
where $C>0$ is a constant independent of $n, X^{t_{n}}$ and $\tilde{X}^{t_{n}}$ are defined in 3.7) and (3.12), respectively.
Proof. 1. For all $t \in\left[t_{n}, t_{n+1}\right]$, from (3.12) we know

\begin{align*}
\tilde{X}_{t}^{t_{n}}= & \exp \left(-\int_{t_{n}}^{t} a_{t_{n}} b_{t_{n}} d s\right) \exp \left(\int_{t_{n}}^{t} b_{t_{n}} d B_{s}-\frac{1}{2} \int_{t_{n}}^{t} b_{t_{n}}^{2} d\langle B\rangle_{s}\right) \\
& \exp \left(\int_{t_{n}}^{t} a_{t_{n}} d \tilde{B}_{s}-\frac{1}{2} \int_{t_{n}}^{t} a_{t_{n}}^{2} d\langle\tilde{B}\rangle_{s}\right), \tag{4.1}
\end{align*}
$$

Notice that $\langle B, \tilde{B}\rangle_{t}=t$, applying $G$-Itô's formula to $\tilde{X}_{t}^{t_{n}}$, we get

\end{equation*}
$$

From the proposition 2.2, we have $\hat{\mathbb{E}}_{t_{n}}^{x}\left[\tilde{X}_{t}^{t_{n}}\right]=1$. Through the properties of quadratic variation $\langle B\rangle_{s}-\langle B\rangle_{r}$ $\leq(s-r)$ and $\langle\tilde{B}\rangle_{s}-\langle\tilde{B}\rangle_{r} \leq \frac{1}{\sigma^{2}}(s-r), \forall r \leq s$, we have

\left(\tilde{X}_{t}^{t_{n}}\right)^{2}= & \exp \left(-2 \int_{t_{n}}^{t} a_{t_{n}} b_{t_{n}} d s\right) \exp \left(2 \int_{t_{n}}^{t} a_{t_{n}} d \tilde{B}_{s}-\int_{t_{n}}^{t} a_{t_{n}}^{2} d\langle\tilde{B}\rangle_{s}\right) \\
& \exp \left(2 \int_{t_{n}}^{t} b_{t_{n}} d B_{s}-\int_{t_{n}}^{t} b_{t_{n}}^{2}\langle B\rangle_{s}\right) \\
\leq & \exp \left(\frac{1}{\sigma^{2}}\left(a_{t_{n}}+b_{t_{n}}\right)^{2} \Delta t\right) \exp \left(-4 \int_{t_{n}}^{t} a_{t_{n}} b_{t_{n}} d s\right) \\
& \exp \left(2 \int_{t_{n}}^{t} a_{t_{n}} d \tilde{B}_{s}-2 \int_{t_{n}}^{t} a_{t_{n}}^{2} d\langle\tilde{B}\rangle_{s}\right)\left(2 \int_{t_{n}}^{t} b_{t_{n}} d B_{s}-2 \int_{t_{n}}^{t} b_{t_{n}}^{2} d\langle B\rangle_{s}\right),
\end{aligned}
$$

Similar to the above process, we can deduce

\hat{\mathbb{E}}_{t_{n}}^{x}\left[\left(\tilde{X}_{t}^{t_{n}}\right)^{2}\right] \leq e^{\frac{1}{\sigma^{2}}\left(a_{t_{n}}+b_{t_{n}}\right)^{2} \Delta t} \tag{4.3}
\end{equation*}
$$

It is easy to verify that $e^{x} \leq 1+e x, \forall 0 \leq x \leq 1$. Therefore, for bounded processes $a_{s}, b_{s}$ and sufficiently small $\Delta t$, we draw the conclusion 1. Similarly, we can prove 2.

Theorem 4.2 Let $\left(Y_{t}\right)_{0 \leq t \leq T}$ be the solution of the $G$-BSDE 3.1) and $Y^{n}(n=0, \ldots, N)$ defined in the Scheme 1, $R_{x}^{n}$ and $R_{y}^{n}$ are defined in (3.14) and 3.10 - 3.11, respectively. Assume that $f$ and $g$ satisfy (H1)-(H2) with Lipschitz constant L. Then for sufficiently small time step $\Delta t$, we have

\hat{\mathbb{E}}\left[\left|e_{y}^{n}\right|^{2}\right] \leq C\left(\hat{\mathbb{E}}\left[\left|e_{y}^{N}\right|^{2}\right]+\sum_{i=0}^{N-1} \frac{\hat{\mathbb{E}}\left[\left|R_{x}^{i}\right|^{2}\right]+\hat{\mathbb{E}}\left[\left|R_{y}^{i}\right|^{2}\right]}{\Delta t}\right) \tag{4.4}
\end{equation*}
$$

for $n=N-1, \ldots, 0, C>0$ is a constant just depending on $T, L$ and upper bounds of $a$ and $b$.
Proof. Let $e_{y}^{n}=Y_{t_{n}}-Y^{n}, e_{f}^{n}=f\left(t_{n}, Y_{t_{n}}\right)-f\left(t_{n}, Y^{n}\right)$ and $e_{g}^{n}=g\left(t_{n}, Y_{t_{n}}\right)-g\left(t_{n}, Y^{n}\right)$, for $n=0,1, \ldots, N$. Subtract 3.15 from 3.13, by Proposition 2.2 (iii), we get

\left|e_{y}^{n}\right| \leq & \hat{\mathbb{E}}_{t_{n}}^{x}\left[\tilde{X}_{t_{n+1}}^{t_{n}}\left|e_{y}^{n+1}\right|+\left(\theta_{1}\left|e_{f}^{n}\right|+\left(1-\theta_{1}\right) \tilde{X}_{t_{n+1}}^{t_{n}}\left|e_{f}^{n+1}\right|\right) \Delta t_{n}\right. \\
& \left.+\left(\theta_{2}\left|e_{g}^{n}\right|+\left(1-\theta_{2}\right) \tilde{X}_{t_{n+1}}^{t_{n}}\left|e_{g}^{n+1}\right|\right) \Delta\langle B\rangle_{n, t_{n+1}}\right]+\left|R_{x}^{n}\right|+\left|R_{y}^{n}\right| . \tag{4.5}
\end{align*}
$$

Using $\langle B\rangle_{t_{n+1}}-\langle B\rangle_{t_{n}} \leq \Delta t_{n}, 4.5$ implies

\left|e_{y}^{n}\right| \leq\left(1+2 L \Delta t_{n}\right) \hat{\mathbb{E}}_{t_{n}}^{x}\left[\tilde{X}_{t_{n+1}}^{t_{n}}\left|e_{y}^{n+1}\right|\right]+2 L \Delta t_{n}\left|e_{y}^{n}\right|+\left|R_{x}^{n}\right|+\left|R_{y}^{n}\right| \tag{4.6}
\end{equation*}

where $L>0$ is the Lipschitz constant. From the inequality 4.6), we obtain

The proof is complete.
Remark 4.3 Theorem 4.2 implies that Scheme 1 is stable.

## 5 Error estimates

In this section, we will discuss the error estimates of Scheme 1 for the $G$-BSDE (3.1) with $\xi=\varphi\left(B_{T}\right)$. Under some regularity conditions on $f, g$ and $\varphi$, we first give the estimates of truncation errors $R_{x}^{n}$ and $R_{y}^{n}$ defined in (3.14) and (3.10)-3.11). Then we come to the conclusion based on Theorem 4.2.

Lemma 5.1 Let $R_{x}^{n}$ be the local truncation error derived from (3.14). Then for sufficiently small time step $\Delta t$ and $\theta_{i}(i=1,2) \in[0,1]$, we have the following conclusions:

1. If $a_{s}=a\left(s, B_{s}\right), b_{s}=b\left(s, B_{s}\right) \in C^{\frac{1}{2}, 1}$ are bounded stochastic processes on $[0, T]$ and $f, g, \varphi \in C^{\frac{1}{2}, 1}$, we have

According to (3.8, 4.2) and Proposition 2.8 (II), it is worth noting that

1. For $\theta_{i} \in[0,1](i=1,2)$, if $f, g, \varphi \in C^{\frac{1}{2}, 1}, a_{s}=a\left(s, B_{s}\right)$ and $b_{s}=b\left(s, B_{s}\right)$ are bounded stochastic processes in $C^{\frac{1}{2}, 1}$, we have

$$
\begin{equation*}
\left|R_{x}^{n}\right| \leq C(\Delta t)^{\frac{3}{2}}, \quad\left|R_{y}^{n}\right| \leq C(\Delta t)^{\frac{3}{2}} \tag{5.33}
\end{equation*}
$$

2. In particular, for $\theta_{1} \in[0,1]$ and $\theta_{2}=0$, if $f, g, u \in C_{b}^{1,2}, a_{s}=a(s)$ and $b_{s}=b(s)$ are Lipschitz continuous functions on $[0, T]$, we have

$$
\begin{equation*}
\left|R_{x}^{n}\right| \leq C(\Delta t)^{2}, \quad\left|R_{y}^{n}\right| \leq C(\Delta t)^{2} . \tag{5.34}
\end{equation*}
$$

Using Theorem 4.2, the conclusion can be directly obtained.
Remark 5.6 Theorem 5.5 shows that if $a_{s}$ and $b_{s}$ are general stochastic processes, the convergence rate of Scheme 1 is 0.5. In particular, if $a_{s}$ and $b_{s}$ are deterministic functions, $f, g, \varphi, u$ are smooth enough, Scheme 1 admits a first order rate of convergence.

## $6 \quad G$-distributed simulation

In this section, we first present the CLT method to approximate the $G$-distributed. Then we propose a fully discrete $\theta$-scheme for solving $Y_{t}$ of the $G$-BSDE (3.1).

### 6.1 CLT method for $G$-distributed

Before giving the CLT method, we first recall the definition of $G$-distributed and Peng's central limit theorem.

Definition 6.1 The pair d-dimensional random vectors $(X, \eta)$ in a sublinear expectation space $(\Omega, \mathcal{H}, \hat{\mathbb{E}})$ is called $G$-distributed if for each $a, b \geq 0$ we have

$$
\left(a X+b \bar{X}, a^{2} \eta+b^{2} \bar{\eta}\right) \stackrel{d}{=}\left(\sqrt{a^{2}+b^{2}} X,\left(a^{2}+b^{2}\right) \eta\right),
$$

where $(\bar{X}, \bar{\eta})$ is an independent copy of $(X, \eta), G: \mathbb{R}^{d} \times \mathbb{S}(d) \rightarrow \mathbb{R}$ denotes the binary function

$$
G(p, A):=\hat{\mathbb{E}}\left[\frac{1}{2}\langle A X, X\rangle+\langle p, \eta\rangle\right], \quad(p, A) \in \mathbb{R}^{d} \times \mathbb{S}(d)
$$

From the definition above, it is easy to check that $\left(B_{1},\langle B\rangle_{1}\right)$ is a $G$-distributed.
Theorem $6.2\left([\mathbf{2 2},[\mathbf{2 3}])\right.$ Let $\left\{\left(X_{i}, Y_{i}\right)\right\}_{i=1}^{\infty}$ be a sequence of $\mathbb{R}^{d} \times \mathbb{R}^{d}$-valued random variables on a sublinear expectation space $(\Omega, \mathcal{H}, \hat{\mathbb{E}})$. We assume that $\left(X_{i+1}, Y_{i+1}\right) \stackrel{d}{=}\left(X_{i}, Y_{i}\right)$ and $\left(X_{i+1}, Y_{i+1}\right)$ is independent from $\left\{\left(X_{1}, Y_{1}\right), \ldots,\left(X_{i}, Y_{i}\right)\right\}$ for each $i=1,2, \cdots$. We further assume that $\hat{\mathbb{E}}\left[X_{1}\right]=\hat{\mathbb{E}}\left[-X_{1}\right]=0$. Then for each function $\varphi \in C\left(\mathbb{R}^{d} \times \mathbb{R}^{d}\right)$ satisfying linear growth condition, we have

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \hat{\mathbb{E}}\left[\varphi\left(\sum_{i=1}^{n} \frac{X_{i}}{\sqrt{n}}, \sum_{i=1}^{n} \frac{Y_{i}}{n}\right)\right]=\hat{\mathbb{E}}[\varphi(X, \eta)] \tag{6.1}
\end{equation*}
$$

where the pair $(X, \eta)$ is $G$-distributed. The corresponding sublinear function $G: \mathbb{R}^{d} \times \mathbb{S}(d) \rightarrow \mathbb{R}$ is defined by

$$
G(p, A):=\hat{\mathbb{E}}\left[\frac{1}{2}\left\langle A X_{1}, X_{1}\right\rangle+\left\langle p, Y_{1}\right\rangle\right],(p, A) \in \mathbb{R}^{d} \times \mathbb{S}(d)
$$

Since Peng's central limit theorem, a great deal of work has been done to prove the following rate of convergence (see [8, 15, 16, 25, 26])

$$
\begin{equation*}
\left|\hat{\mathbb{E}}\left[\varphi\left(\sum_{i=1}^{n} \frac{X_{i}}{\sqrt{n}}, \sum_{i=1}^{n} \frac{Y_{i}}{n}\right)\right]-\hat{\mathbb{E}}[\varphi(X, \eta)]\right| \leq C n^{-\frac{1}{6}}, \tag{6.2}
\end{equation*}
$$

where $C$ is a constant depending on $\varphi, X_{i}$ and $Y_{i}$.
CLT method. Assume $M$ is a positive integer. Using the property of independence, we have

$$
\begin{align*}
& \hat{\mathbb{E}}\left[\varphi\left(\sum_{i=1}^{M} \frac{X_{i}}{\sqrt{M}}, \sum_{i=1}^{M} \frac{Y_{i}}{M}\right)\right] \\
& =\hat{\mathbb{E}}\left[\hat{\mathbb{E}}\left[\varphi\left(\sum_{i=2}^{M} \frac{X_{i}+x_{1}}{\sqrt{M}}, \sum_{i=2}^{M} \frac{Y_{i}+y_{1}}{M}\right)\right]_{\left(x_{1}, y_{1}\right)=\left(X_{1}, Y_{1}\right)}\right]  \tag{6.3}\\
& =\hat{\mathbb{E}}\left[\hat{\mathbb{E}}\left[\cdots \hat{\mathbb{E}}\left[\varphi\left(\sum_{i=1}^{M-1} \frac{X_{M}+x_{i}}{\sqrt{M}}, \sum_{i=1}^{M-1} \frac{Y_{M}+y_{i}}{M}\right)\right]_{\substack{\left(x_{M-1}, y_{M-1}\right) \\
=\left(X_{M-1}, Y_{M-1}\right)}} \cdots\right]_{\left(x_{1}, y_{1}\right)=\left(X_{1}, Y_{1}\right)}\right] .
\end{align*}
$$

Denote $\hat{\mathbb{E}}^{M}[\varphi(X, \eta)]=\hat{\mathbb{E}}\left[\varphi\left(\sum_{i=1}^{M} \frac{X_{i}}{\sqrt{M}}, \sum_{i=1}^{M} \frac{Y_{i}}{M}\right)\right]$ as the approximation of $\hat{\mathbb{E}}[\varphi(X, \eta)]$. By choosing appropriate random variables $\left\{\left(X_{i}, Y_{i}\right)\right\}_{i=1}^{M}$, the numerical approximation of $\hat{\mathbb{E}}[\varphi(X, \eta)]$ can be obtained, we call it the CLT method for $G$-distributed. The following error estimate is straightforward

$$
\begin{equation*}
\hat{\mathbb{E}}[\varphi(X, \eta)]=\hat{\mathbb{E}}^{M}[\varphi(X, \eta)]+\operatorname{Err}_{\hat{\mathbb{E}}, M} \tag{6.4}
\end{equation*}
$$

with $\operatorname{Err}_{\hat{\mathbb{E}}, M}$ converge to 0 with the convergence rate $M^{-\frac{1}{6}}$, as $M \rightarrow \infty$. So we can select a proper $M$ in the CLT method to approximate the $G$-expectation with the required accuracy.

### 6.2 The fully-discrete scheme

To propose a fully-discrete scheme, we introduce the following space partition $D_{h}$ :

$$
\begin{equation*}
D_{h}=\left\{x_{i} \mid x_{i} \in \mathbb{R}, i \in \mathbb{Z}, x_{i}<x_{i+1}\right\}, \tag{6.5}
\end{equation*}
$$

with the space step $\Delta x_{i}=x_{i+1}-x_{i}$ and the maximum space step $\Delta x=\max _{i \in \mathbb{Z}} \Delta x_{i}$.
Now by (3.13), we solve $Y_{t}$ at the time-space point $\left(t_{n}, x_{i}\right)$ in the following form:

$$
\begin{align*}
Y_{t_{n}}^{x_{i}}= & \hat{\mathbb{E}}_{t_{n}}^{x_{i}, M}\left[\tilde{X}_{t_{n+1}}^{t_{n}} \hat{Y}_{t_{n+1}}+\left(\theta_{1} f\left(t_{n}, Y_{t_{n}}^{x_{i}}\right)+\left(1-\theta_{1}\right) \tilde{X}_{t_{n+1}}^{t_{n}} f\left(t_{n+1}, \hat{Y}_{t_{n+1}}\right)\right) \Delta t_{n}\right. \\
& \left.+\left(\theta_{2} g\left(t_{n}, Y_{t_{n}}^{x_{i}}\right)+\left(1-\theta_{2}\right) \tilde{X}_{t_{n+1}}^{t_{n}} g\left(t_{n+1}, \hat{Y}_{t_{n+1}}\right)\right) \Delta\langle B\rangle_{n, t_{n+1}}\right]+R_{x}^{n}+R_{y}^{n}+R_{\hat{\mathbb{E}}}^{n} \tag{6.6}
\end{align*}
$$

where $R_{x}^{n}$ and $R_{y}^{n}$ are truncation errors defined in (3.10)-3.11) and 3.14,

$$
\begin{aligned}
R_{\widehat{\mathbb{E}}}^{n}= & \hat{\mathbb{E}}_{t_{n}}^{x_{i}}\left[\tilde{X}_{t_{n+1}}^{t_{n}} Y_{t_{n+1}}+\left(\theta_{1} f\left(t_{n}, Y_{t_{n}}^{x_{i}}\right)+\left(1-\theta_{1}\right) \tilde{X}_{t_{n+1}}^{t_{n}} f\left(t_{n+1}, Y_{t_{n+1}}\right)\right) \Delta t_{n}\right. \\
& \left.+\left(\theta_{2} g\left(t_{n}, Y_{t_{n}}^{x_{i}}\right)+\left(1-\theta_{2}\right) \tilde{X}_{t_{n+1}}^{t_{n}} g\left(t_{n+1}, Y_{t_{n+1}}\right)\right) \Delta\langle B\rangle_{n, t_{n+1}}\right] \\
& -\hat{\mathbb{E}}_{t_{n}}^{x_{i}, M}\left[\tilde{X}_{t_{n+1}}^{t_{n}} \hat{Y}_{t_{n+1}}+\left(\theta_{1} f\left(t_{n}, Y_{t_{n}}^{x_{i}}\right)+\left(1-\theta_{1}\right) \tilde{X}_{t_{n+1}}^{t_{n}} f\left(t_{n+1}, \hat{Y}_{t_{n+1}}\right)\right) \Delta t_{n}\right. \\
& \left.+\left(\theta_{2} g\left(t_{n}, Y_{t_{n}}^{x_{i}}\right)+\left(1-\theta_{2}\right) \tilde{X}_{n+1}^{t_{n}} g\left(t_{n+1}, \hat{Y}_{t_{n+1}}\right)\right) \Delta\langle B\rangle_{n, t_{n+1}}\right] .
\end{aligned}
$$

Here $\hat{Y}_{t_{n+1}}$ is the interpolation value at the point $x_{i}+\Delta B_{n, t_{n+1}}(i \in \mathbb{Z}) . \hat{\mathbb{E}}_{t_{n}}^{x_{i}, M}[\cdot]$ is an approximation of $\hat{\mathbb{E}}_{t_{n}}^{x_{i}}[\cdot]$ by using the CLT method, and corresponding approximation error $R_{\widehat{\mathbb{E}}}^{n}$ converge to 0 as $M \rightarrow \infty$.

Based on 6.6, by omitting numerical errors $R_{x}^{n}, R_{y}^{n}$ and $R_{\hat{\mathbb{E}}}^{n}$, we propose the following fully-discrete $\theta$-scheme for solving $Y_{t}$ of the $G$-BSDE (3.1):

Scheme 2 Denote $Y_{i}^{n}(n=N, N-1, \ldots, 0, i \in \mathbb{Z})$ as a numerical solution to the analytic solution $Y_{t}$ of the $G$-BSDE (3.1) at the time-space point $\left(t_{n}, x_{i}\right)$. Given the random variable $Y_{i}^{N}, i \in \mathbb{Z}$, solve $Y_{i}^{n}$ by

$$
\left\{\begin{align*}
Y_{i}^{n}= & \hat{\mathbb{E}}_{t_{n}}^{x_{n}, M}\left[X_{i}^{n+1} \hat{Y}^{n+1}+\left(\theta_{1} f\left(t_{n}, Y_{i}^{n}\right)+\left(1-\theta_{1}\right) X_{i}^{n+1} f\left(t_{n+1}, \hat{Y}^{n+1}\right)\right) \Delta t_{n}\right.  \tag{6.7}\\
& \left.+\left(\theta_{2} g\left(t_{n}, Y_{i}^{n}\right)+\left(1-\theta_{2}\right) X_{i}^{n+1} g\left(t_{n+1}, \hat{Y}^{n+1}\right)\right) \Delta\langle B\rangle_{n, t_{n+1}}\right] \\
X_{i}^{n+1}= & \exp \left(-a_{i}^{n} b_{i}^{n} \Delta t_{n}\right) \exp \left(b_{i}^{n} \Delta B_{n, t_{n+1}}-\frac{1}{2}\left(b_{i}^{n}\right)^{2} \Delta\langle B\rangle_{n, t_{n+1}}\right) \\
& \exp \left(a_{i}^{n} \Delta \tilde{B}_{n, t_{n+1}}-\frac{1}{2}\left(a_{i}^{n}\right)^{2} \Delta\langle\tilde{B}\rangle_{n, t_{n+1}}\right)
\end{align*}\right.
$$

with the deterministic parameters $\theta_{i} \in[0,1](i=1,2)$.
Here $\hat{Y}^{n+1}$ is the interpolation value of $Y^{n+1}$ at the point $x_{i}+\Delta B_{t_{n+1}}(i \in \mathbb{Z}) . X_{i}^{n+1}$ is grid discrete approximation of the $X^{n+1}$ with $a_{i}^{n}=a\left(t_{n}, x_{i}\right)$ and $b_{i}^{n}=b\left(t_{n}, x_{i}\right) . \hat{\mathbb{E}}_{t_{n}}^{x_{i}, M}[\cdot]$ is the approximation of the conditional $G$-expectation $\hat{\mathbb{E}}_{t_{n}}^{x_{i}}[\cdot]$ by using the CLT method. More precisely, we take the special case as an example:

$$
\hat{\mathbb{E}}_{t_{n}}^{x_{i}, M}\left[\hat{Y}^{n+1}\left(B_{t_{n+1}}\right) \Delta\langle B\rangle_{n, t_{n+1}}\right]=\hat{\mathbb{E}}\left[\hat{Y}^{n+1}\left(x_{i}+\sqrt{\Delta t_{n}} \sum_{i=1}^{M} \frac{X_{i}}{\sqrt{M}}\right) \Delta t_{n} \sum_{i=1}^{M} \frac{Y_{i}}{M}\right]
$$

where $\hat{Y}^{n+1}\left(x_{i}+\sqrt{\Delta t_{n}} \sum_{i=1}^{M} \frac{X_{i}}{\sqrt{M}}\right)$ is the interpolation approximation of $Y^{n+1}$ at spacial non-grid point $x_{i}+\sqrt{\Delta t_{n}} \sum_{i=1}^{M} \frac{X_{i}}{\sqrt{M}}, M$ is a positive integer. In our numerical experiments, we choose the sequence of
discrete random variables

$$
\left(X_{i}, Y_{i}\right)=\left\{\begin{array}{cc}
(1,1) & q / 2  \tag{6.8}\\
(0,0) & 1-q \\
(-1,1) & q / 2
\end{array} \quad i=1, \ldots, M\right.
$$

with uncertainty $q \in\left\{\sigma^{2}, 1\right\}, \sigma^{2} \in(0,1]$, and $G(p, a)=\hat{\mathbb{E}}\left[\frac{1}{2} a X_{1}^{2}+p Y_{1}\right]=\hat{\mathbb{E}}\left[\frac{1}{2} a B_{1}^{2}+p\langle B\rangle_{1}\right]$, for all $(p, a) \in$ $\mathbb{R} \times \mathbb{R}$. In the same way, the conditional $G$-expectation in Scheme 2 can be defined.

Remark 6.3 Notice that the spacial mesh $D_{h}$ is essentially unbounded. However, in real computations, we are interested in acquiring certain values of $Y_{t}$ at $\left(t_{n}, x\right)$ with $x$ belonging to a bounded domain. In fact, $\hat{\mathbb{E}}_{t_{n}}^{x}\left[\varphi\left(B_{t_{n+1}}\right)\right]=\hat{\mathbb{E}}_{t_{n}}^{x}\left[\varphi\left(x+\sqrt{\Delta t_{n}} B_{1}\right) I_{\left|B_{1}\right| \leq D}\right]+\operatorname{Err}_{\varphi, D}$, where $\operatorname{Err}_{\varphi, D}$ is the truncation error. If $\varphi$ is a bounded function, the truncation error $\left|E r r_{\varphi, D}\right| \leq C\left(\hat{\mathbb{E}}\left[I_{B_{1} \leq-D}\right]+\hat{\mathbb{E}}\left[I_{B_{1} \geq D}\right]\right)$ is negligible when $D \geq 3$ (see Section 4.2 in 24 for more details).

## 7 Numerical experiments

In this section, some numerical calculations have been carried out to illustrate the high accuracy of our numerical schemes. In our numerical experiments, we let $D=3$ and select a appropriate $M$ in the CLT method. We also apply cubic spline interpolation to compute spatial non-grid points. Set $x_{0}=0$, the initial time $t_{0}=0$ and terminal time $T=1$. In the following tables, $\left|Y_{0}-Y^{0}\right|$ denotes the absolute error between the exact and numerical solution for $Y_{t}$ at $\left(t_{0}, x_{0}\right)$. We shall denote by " CR " the convergence rate.

Example 7.1 Consider the following linear G-BSDE

$$
\left\{\begin{array}{l}
-d Y_{t}=-Y_{t} d t+\frac{1}{2} Y_{t} d\langle B\rangle_{t}-Z_{t} d B_{t}-d K_{t}, 0 \leq t \leq T  \tag{7.1}\\
Y_{T}=\exp (T) \sin \left(B_{T}\right)
\end{array}\right.
$$

The analytic solution of (7.1) is

$$
\left\{\begin{array}{l}
Y_{t}=\exp (t) \sin \left(B_{t}\right)  \tag{7.2}\\
Z_{t}=\exp (t) \cos \left(B_{t}\right) \\
K_{t}=0
\end{array}\right.
$$

The solution $Y_{t}$ at initial time $t_{0}=0$ is $Y_{0}=0$. Errors and convergence rates for different time partitions and different $\sigma^{2}$ are listed in Table 1. Figure 1 shows the convergence rates of the $\theta$-scheme for time step varying from $2^{3}$ to $2^{7}$ with different parameters $\theta_{i}(i=1,2)$. By contrast, we can clearly see that the convergence rate of the $\theta$-scheme is highly correlated with $\theta_{2}$. For $\theta_{1} \in[0,1]$, the scheme is half-order convergence with $\theta_{2} \neq 0$. When $\theta_{2}=0$, the scheme can achieve first order, which is consistent with our theoretical analysis.

Example 7.2 Consider the following nonlinear $G$-BSDE

$$
\left\{\begin{array}{l}
-d Y_{t}=\left(f\left(t, Y_{t}\right)-Y_{t}\right) d t+\left(g\left(t, Y_{t}\right)+Z_{t}\right) d\langle B\rangle_{t}-Z_{t} d B_{t}-d K_{t}, 0 \leq t \leq T  \tag{7.3}\\
Y_{T}=\frac{\exp \left(T+B_{T}\right)}{1+\exp \left(T+B_{T}\right)}
\end{array}\right.
$$

where $f(t, y)=J_{\varepsilon} * y^{2}, g(t, y)=J_{\varepsilon} *\left(-y^{3}+2.5 y^{2}-1.5 y\right) \in C^{\infty}(\mathbb{R})$ with the mollifier $J_{\varepsilon}$ and the convolution

$$
J_{\varepsilon} * u(x)=\int_{\mathbb{R}} J_{\varepsilon}(x-y) u(y) d y
$$

The analytic solution of (7.3) is $\left(Y_{t}, Z_{t}, K_{t}\right)=\left(\frac{\exp \left(t+B_{t}\right)}{1+\exp \left(t+B_{t}\right)}, \frac{\exp \left(t+B_{t}\right)}{\left(1+\exp \left(t+B_{t}\right)\right)^{2}}, 0\right)$. Then $Y_{t}$ at initial time $t_{0}=0$ is $Y_{0}=0.5$.

Errors and convergence rates for different time partitions of the $\theta$-scheme with different parameters $\theta_{i}(i=1,2)$ are listed in Table 2. Figure 2 presents convergence rates of the $\theta$-scheme under different uncertainty $\sigma^{2}$. When $\sigma^{2}=1, G$-Brownian motion is reduced to a standard Brownian motion, the $\theta$-scheme can reach first order for $\theta_{i} \in[0,1](i=1,2)$, which coincides with Zhao [29].

## 8 Conclusions

In this paper, we design a new kind of $\theta$-scheme to approximate the solution $Y_{t}$ of the $G$-BSDE (3.1). By choosing different $\theta_{i}(i=1,2)$, a class of numerical schemes have been obtained which provide useful tools for dealing with the pricing of contingent claims. We also analyze the stability of our numerical schemes and strictly prove the error estimates. As discussed in section 5 , the $\theta$-scheme admits a half order convergence rate in the general, and when $\theta_{2}=0$, the scheme can reach first-order in the deterministic case. In addition, based on Peng's central limit theorem, we employ the CLT method to approximate $G$-distributed for the first time. Several numerical examples are presented to show the effectiveness of our numerical schemes.
