# PROJECTIVE STRUCTURES ON RIEMANN SURFACE AND NATURAL DIFFERENTIAL OPERATORS

#### Abstract

We investigate the holomorphic differential operators on a Riemann surface $M$. This is done by endowing $M$ with a projective structure. Let $\mathcal{L}$ be a theta characteristic on $M$. We explicitly describe the jet bundle $J^{k}\left(E \otimes \mathcal{L}^{\otimes n}\right)$, where $E$ is a holomorphic vector bundle over $M$ equipped with a holomorphic connection, for all $k$ and $n$. This provides a description of global holomorphic differential operators from $E \otimes \mathcal{L}^{\otimes n}$ to another holomorphic vector bundle $F$ using the natural isomorphism $\operatorname{Diff}^{k}\left(E \otimes \mathcal{L}^{\otimes n}, F\right)=F \otimes\left(J^{k}\left(E \otimes \mathcal{L}^{\otimes n}\right)\right)^{*}$.


## 1. Introduction

The study of natural differential operators between natural vector bundles is a major topic in global analysis on manifolds (see, for instance, Ni , Te and [KMS]).

Our aim here is to study holomorphic differential operators between natural holomorphic vector bundles on a Riemann surface $M$. To be able to formulate their description, we make use of the existence of compatible projective structures on the Riemann surface $M$ (see [Gu] for projective structure on Riemann surfaces).

We recall that a projective structure on $M$ is given by a holomorphic coordinate atlas such that all the transition functions are restrictions of Möbius transformations of the projective line $\mathbb{C P}{ }^{1}$. The above mentioned approach to holomorphic differential operators on $M$ entails a detailed understanding of the action of $\operatorname{SL}(2, \mathbb{C})$ on the jet bundles on $\mathbb{C P}^{1}$.

Let $\mathbb{V}$ be a complex vector space of dimension two. For notational convenience, denote by $X$ the space $\mathbb{P}(\mathbb{V})$ of complex lines in $\mathbb{V}$. Let $L$ be the tautological holomorphic line bundle of degree one on $X$. The rank two trivial holomorphic vector bundle $X \times \mathbb{V}$ on $X$ with fiber $\mathbb{V}$ will be denoted by $\mathbb{V}_{1}$, while the $j$-fold symmetric product $\operatorname{Sym}^{j}\left(\mathbb{V}_{1}\right)$ of $\mathbb{V}_{1}$ will be denoted by $\mathbb{V}_{j}$. The holomorphically trivial line bundle $X \times \mathbb{C}$ on $X$ will be denoted by $\mathbb{V}_{0}$.

We prove the following (see Theorem 3.5):
Theorem 1.1. If $n<0$ or $n \geq k$, then

$$
J^{k}\left(L^{n}\right)=L^{n-k} \otimes \mathbb{V}_{k}
$$

If $k>n \geq 0$, then

$$
J^{k}\left(L^{n}\right)=\mathbb{V}_{n} \oplus\left(L^{-(k+1)} \otimes \mathbb{V}_{k-n-1}\right)
$$

Both the isomorphisms are $\mathrm{SL}(\mathbb{V})$-equivariant.

[^0]The natural forgetful homomorphism $J^{k}\left(L^{n}\right) \longrightarrow J^{k-1}\left(L^{n}\right)$ of holomorphic vector bundles equipped with action of $\operatorname{SL}(\mathbb{V})$ is described in Proposition 3.1, Proposition 3.2 and Proposition 3.4.

Since all the above mentioned isomorphisms and homomorphisms are $\mathrm{SL}(\mathbb{V})$-equivariant, we are able to translate them into the set-up of a Riemann surface equipped with a projective structure. We recall that any projective structure on a Riemann surface $M$ has an underlying holomorphic atlas on $M$ for which the transition maps are restrictions of elements in $\operatorname{SL}(\mathbb{V})$ (see Section (4).

Let $M$ be a compact Riemann surface equipped with a projective structure $P$. Using $P$, the above mentioned tautological line bundle $L$ on $X$ produces a holomorphic line bundle $\mathbf{L}$ on $M$ with the property that $\mathbf{L}^{\otimes 2}=T M$. Moreover, using $P$, the trivial vector bundle $\mathbb{V}_{1}$ produces a holomorphic vector bundle $\mathcal{V}_{1}$ of rank two over $M$ that fits in the following short exact sequence of holomorphic vector bundles on $M$ :

$$
0 \longrightarrow \mathbf{L}^{*} \longrightarrow \mathcal{V}_{1} \longrightarrow \mathbf{L} \longrightarrow 0
$$

This involves fixing a nonzero element of $\bigwedge^{2} \mathbb{V}$. The vector bundle $\mathcal{V}_{1}$ also has a holomorphic connection given by $P$.

The symmetric power $\operatorname{Sym}^{j}\left(\mathcal{V}_{1}\right)$ will be denoted by $\mathcal{V}_{j}$, while the trivial line bundle $\mathcal{O}_{M}$ will be denoted by $\mathcal{V}_{0}$.

Let us now describe our results about natural differential holomorphic operators on a Riemann surface endowed with a projective structure.

The following is deduced using Theorem 1.1 (see Corollary 4.2):
Corollary 1.2. Let $M$ be a compact connected Riemann surface endowed with a projective structure $P$. If $n<0$ or $n \geq k$, then there is a canonical isomorphism

$$
J^{k}\left(\mathbf{L}^{n}\right)=\mathbf{L}^{n-k} \otimes \mathcal{V}_{k}
$$

where $\mathcal{V}_{k}$ is defined above.
If $k>n \geq 0$, then there is a canonical isomorphism

$$
J^{k}\left(\mathbf{L}^{n}\right)=\mathcal{V}_{n} \oplus\left(\mathbf{L}^{-(k+1)} \otimes \mathcal{V}_{k-n-1}\right)
$$

This enables us to deduce the following result (see Lemma 4.4):
Lemma 1.3. Let $M$ be a compact connected Riemann surface endowed with a projective structure $P$. Consider $E$ a holomorphic vector bundle on $M$ equipped with a holomorphic connection.

If $n<0$ or $n \geq k$, then there is a canonical isomorphism

$$
J^{k}\left(E \otimes \mathbf{L}^{n}\right)=E \otimes \mathbf{L}^{n-k} \otimes \mathcal{V}_{k}
$$

If $k>n \geq 0$, then there is a canonical isomorphism

$$
J^{k}\left(E \otimes \mathbf{L}^{n}\right)=E \otimes\left(\mathcal{V}_{n} \oplus\left(\mathbf{L}^{-(k+1)} \otimes \mathcal{V}_{k-n-1}\right)\right)
$$

Let $E$ be a holomorphic vector bundle on $M$ equipped with a holomorphic connection, as in Lemma 1.3. Given a holomorphic vector bundle $F$ on $M$, denote by $\operatorname{Diff}_{M}^{k}\left(E \otimes \mathbf{L}^{n}, F\right)$ the sheaf of holomorphic differential operators of order $k$ from $E \otimes \mathbf{L}^{n}$ to $F$.

The associated symbol homomorphism

$$
\operatorname{Diff}_{M}^{k}\left(E \otimes \mathbf{L}^{n}, F\right) \longrightarrow \operatorname{Hom}\left(E \otimes \mathbf{L}^{n}, F\right) \otimes(T M)^{\otimes k}
$$

is described in Corollary 4.7 and Corollary 4.11.
Fix integers $k, n$ and $l$ such that at least one of the following two conditions is valid:
(1) $n<0$, or
(2) $n, l \geq k$.

Also fix a section

$$
\begin{equation*}
\theta_{0} \in H^{0}\left(M, \operatorname{End}(E) \otimes \mathbf{L}^{l}\right) \tag{1.1}
\end{equation*}
$$

Using $\theta_{0}$, and a projective structure $P$ on $M$, we construct a holomorphic differential operator

$$
\mathcal{T}_{\theta} \in H^{0}\left(M, \operatorname{Diff}^{k}\left(E \otimes \mathbf{L}^{n}, E \otimes \mathbf{L}^{l+n-2 k}\right)\right)
$$

The following theorem shows that $\mathcal{T}_{\theta}$ is a lift of the symbol $\theta_{0}$ to a holomorphic differential operator (see Theorem 5.1):
Theorem 1.4. The symbol of the above holomorphic differential operator $\mathcal{T}_{\theta}$ is the section $\theta_{0}$ in (1.1).

## 2. Preliminaries

2.1. Jet bundles and differential operators. Let $X$ be a connected Riemann surface. The holomorphic cotangent bundle of $X$ will be denoted by $K_{X}$. Consider the Cartesian product $X \times X$. For $i=1,2$, let

p_{i}: X \times X \longrightarrow X
$$

be the natural projection to the $i$-th factor. Let

$$
\begin{equation*}
\Delta:=\{(x, x) \mid x \in X\} \subset X \times X \tag{2.1}
\end{equation*}
$$

be the diagonal divisor. At times we shall identify $\Delta$ with $X$ using the mapping $x \longmapsto$ $(x, x)$, where $x \in X$. For any nonnegative integer $k$, consider the natural short exact sequence of coherent analytic sheaves on $X \times X$

$$
\begin{align*}
& 0 \longrightarrow \mathcal{O}_{X \times X}(-(k+1) \Delta) \longrightarrow \mathcal{O}_{X \times X}(-k \Delta)  \tag{2.2}\\
& \longrightarrow \mathcal{O}_{X \times X}(-k \Delta) / \mathcal{O}_{X \times X}(-(k+1) \Delta) \longrightarrow 0
\end{align*}
$$

Using the Poincaré adjunction formula, we have

$$
\begin{equation*}
\mathcal{O}_{X \times X}(-k \Delta) / \mathcal{O}_{X \times X}(-(k+1) \Delta)=K_{X}^{\otimes k} \tag{2.3}
\end{equation*}
$$

here $X$ is identified with $\Delta$ as explained above. Let $z$ be a holomorphic coordinate function on an open subset $U \subset X$. The isomorphism in (2.3) over $(U \times U) \cap \Delta$ sends the section $\left(z \circ p_{2}-z \circ p_{1}\right)^{k}$ of $\mathcal{O}_{X \times X}(-k \Delta) / \mathcal{O}_{X \times X}(-(k+1) \Delta)$ over $(U \times U) \cap \Delta$ to the section $(d z)^{\otimes k}$ of $\left.K_{X}^{\otimes k}\right|_{U}$ (after identifying $U$ with $(U \times U) \bigcap \Delta$ in the above fashion).

Let $W$ be a holomorphic vector bundle on $X$ of rank $r_{W}$. For any nonnegative integer $k$, consider the coherent analytic subsheaf

$$
\left(p_{2}^{*} W\right) \otimes \mathcal{O}_{X \times X}(-(k+1) \Delta) \subset p_{2}^{*} W
$$

The $k$-th order jet bundle $J^{k}(W)$ is defined to be the direct image

$$
\begin{equation*}
J^{k}(W):=p_{1 *}\left(\left(p_{2}^{*} W\right) /\left(\left(p_{2}^{*} W\right) \otimes \mathcal{O}_{X \times X}(-(k+1) \Delta)\right)\right) \longrightarrow X \tag{2.4}
\end{equation*}
$$

which is a holomorphic vector bundle on $X$ of rank $(k+1) r_{W}$.
For any $k \geq 1$, using the natural inclusions of coherent analytic sheaves on $X \times X$

$$
\left(p_{2}^{*} W\right) \otimes \mathcal{O}_{X \times X}(-(k+1) \Delta) \subset\left(p_{2}^{*} W\right) \otimes \mathcal{O}_{X \times X}(-k \Delta) \subset p_{2}^{*} W
$$

together with the isomorphism in (2.3), we obtain a short exact sequence of holomorphic vector bundles on $X$

$$
\begin{equation*}
0 \longrightarrow W \otimes K_{X}^{\otimes k} \xrightarrow{\iota} J^{k}(W) \xrightarrow{\phi_{k}} J^{k-1}(W) \longrightarrow 0 . \tag{2.5}
\end{equation*}
$$

Let $V$ be a holomorphic vector bundle on $X$. Let $\operatorname{Diff}^{k}(W, V)$ denote the sheaf of holomorphic differential operators of order $k$ from $W$ to $V$. It is the sheaf of holomorphic sections of

$$
\begin{equation*}
\operatorname{Diff}^{k}(W, V):=\operatorname{Hom}\left(J^{k}(W), V\right)=V \otimes J^{k}(W)^{*} \tag{2.6}
\end{equation*}
$$

Consider the homomorphism

$$
\begin{equation*}
\operatorname{Diff}^{k}(W, V)=V \otimes J^{k}(W)^{*} \xrightarrow{\mathrm{Id}_{V} \otimes \iota^{*}} V \otimes\left(W \otimes K_{X}^{\otimes k}\right)^{*}=(T X)^{\otimes k} \otimes \operatorname{Hom}(W, V), \tag{2.7}
\end{equation*}
$$

where $\iota^{*}$ is the dual of the homomorphism $\iota$ in (2.5). This homomorphism $\operatorname{Id}_{V} \otimes \iota^{*}$ in (2.7) is known as the symbol mapon differential operators.
2.2. Line bundles on the projective line. Let $\mathbb{V}$ be a complex vector space of dimension two. Now set

$$
X:=\mathbb{P}(\mathbb{V})
$$

to be the compact Riemann surface of genus zero parametrizing all the complex lines in $\mathbb{V}$. Let

$$
\begin{equation*}
L:=\mathcal{O}_{X}(1)=\mathcal{O}_{\mathbb{P}(\mathbb{V})}(1) \longrightarrow X \tag{2.8}
\end{equation*}
$$

be the tautological holomorphic line bundle of degree one whose fiber over the point of $\mathbb{P}(\mathbb{V})$ corresponding to a line $\xi \subset \mathbb{V}$ is the quotient line $\mathbb{V} / \xi$. For any integer $n$, by $L^{n}$ we shall denote the holomorphic line bundle

- $L^{\otimes n}$, if $n>0$,
- $\left(L^{\otimes-n}\right)^{*}$, if $n<0$, and
- $\mathcal{O}_{X}$ (the trivial holomorphic line bundle), if $n=0$.

A theorem of Grothendieck asserts that any holomorphic vector bundle $F$ on $X$ of rank $r$ is of the form

$$
F=\bigoplus_{i=1}^{r} L^{a_{i}}
$$

where $a_{i} \in \mathbb{Z}$ [Gr, p. 122, Théorème 1.1]; moreover, the above integers $\left\{a_{i}\right\}$ are uniquely determined, up to a permutation, by $F$ [Gr, p. 122, Théorème 1.1], [At1, p. 315, Theorem 2]. Recall that the holomorphic cotangent bundle $K_{X}$ is holomorphically isomorphic to $L^{-2}$.

Let

$$
\begin{equation*}
\mathbb{L} \longrightarrow X \tag{2.9}
\end{equation*}
$$

be the tautological holomorphic line bundle of degree -1 whose fiber over the point of $\mathbb{P}(\mathbb{V})$ corresponding to a line $\xi \subset \mathbb{V}$ is $\xi$ itself. This $\mathbb{L}$ is holomorphically isomorphic to $L^{-1}$. We note that there is no natural isomorphism between $L^{-1}$ and $\mathbb{L}$.

Let $\operatorname{SL}(\mathbb{V})$ be the complex Lie group of dimension three consisting of all linear automorphisms of $\mathbb{V}$ that act trivially on the determinant line $\bigwedge^{2} \mathbb{V}$. This group $\operatorname{SL}(\mathbb{V})$ acts on $\mathbb{P}(\mathbb{V})$ as follows: the action of any $A \in \mathrm{SL}(\mathbb{V})$ sends a line $\xi \subset \mathbb{V}$ to the line $A(\xi)$. The corresponding action homomorphism

$$
\mathrm{SL}(\mathbb{V}) \longrightarrow \operatorname{Aut}(X)
$$

is holomorphic, and its kernel is $\pm \mathrm{Id}_{\mathbb{V}}$. The action of $\mathrm{SL}(\mathbb{V})$ on $X$ has a tautological lift to an action of $\operatorname{SL}(\mathbb{V})$ on $K_{X}^{\otimes m}$ for every integer $m$.

The above action of $\mathrm{SL}(\mathbb{V})$ on $\mathbb{P}(\mathbb{V})$ clearly lifts to the line bundle $L$. Indeed, the action of any $A \in \mathrm{SL}(\mathbb{V})$ on $\mathbb{V}$ produces an isomorphism

$$
\mathbb{V} / \xi \xrightarrow{\sim} \mathbb{V} / A(\xi)
$$

for every line $\xi \subset \mathbb{V}$. The resulting action of $\mathrm{SL}(\mathbb{V})$ on $L$ produces an action of $\mathrm{SL}(\mathbb{V})$ on the tensor product $L^{n}$ for every $n$.

The diagonal action of $\operatorname{SL}(\mathbb{V})$ on $X \times X$ preserves the divisor $\Delta$ defined in (2.1). This action of $\mathrm{SL}(\mathbb{V})$ on $X \times X$, and the action of $\operatorname{SL}(\mathbb{V})$ on $L^{n}$, together produce an action of $\mathrm{SL}(\mathbb{V})$ on the jet bundle $J^{k}\left(L^{n}\right)$ defined in (2.4). The homomorphism $\phi_{k}$ in (2.5) is in fact $\operatorname{SL}(\mathbb{V})$-equivariant.

## 3. Description of jet bundles on the projective line

Consider the short exact sequence of coherent analytic sheaves on $X \times X=\mathbb{P}(\mathbb{V}) \times \mathbb{P}(\mathbb{V})$

$$
\begin{equation*}
\left.0 \longrightarrow\left(p_{2}^{*} L^{n}\right) \otimes \mathcal{O}_{X \times X}(-(k+1) \Delta) \longrightarrow p_{2}^{*} L^{n} \longrightarrow\left(p_{2}^{*} L^{n}\right)\right|_{(k+1) \Delta} \longrightarrow 0, \tag{3.1}
\end{equation*}
$$

where $L$ is defined in (2.8), and $p_{i}$ as before is the projection $X \times X \longrightarrow X$ to the $i$-th factor. From (2.4) we know that the jet bundle $J^{k}\left(L^{n}\right)$ is the direct image of $\left.\left(p_{2}^{*} L^{n}\right)\right|_{(k+1) \Delta}$ to $X$ under the projection $p_{1}$. We shall investigate $J^{k}\left(L^{n}\right)$ using the long exact sequence of direct images for the short exact sequence of sheaves in (3.1).

Let

$$
\begin{align*}
0 & \longrightarrow R^{0} p_{1 *}\left(\left(p_{2}^{*} L^{n}\right) \otimes \mathcal{O}_{X \times X}(-(k+1) \Delta)\right) \longrightarrow R^{0} p_{1 *} p_{2}^{*} L^{n} \longrightarrow R^{0} p_{1 *}\left(\left.\left(p_{2}^{*} L^{n}\right)\right|_{(k+1) \Delta}\right) \\
& =: J^{k}\left(L^{n}\right) \longrightarrow R^{1} p_{1 *}\left(\left(p_{2}^{*} L^{n}\right) \otimes \mathcal{O}_{X \times X}(-(k+1) \Delta)\right) \longrightarrow R^{1} p_{1 *} p_{2}^{*} L^{n} \longrightarrow 0 \tag{3.2}
\end{align*}
$$

be the long exact sequence of direct images, under $p_{1}$, associated to the short exact sequence in (3.1). Note that

$$
R^{1} p_{1 *}\left(\left.\left(p_{2}^{*} L^{n}\right)\right|_{(k+1) \Delta}\right)=0
$$

because the support of $\left.\left(p_{2}^{*} L^{n}\right)\right|_{(k+1) \Delta}$ is finite over $X$ (for the projection $p_{1}$ ).
Since the diagonal action of $\operatorname{SL}(\mathbb{V})$ on $X \times X$ preserves the divisor $\Delta$, each sheaf in (3.2) is equipped with an action of $\mathrm{SL}(\mathbb{V})$ that lifts the action of $\mathrm{SL}(\mathbb{V})$ on $X$. Moreover, all the homomorphisms in the exact sequence (3.2) are in fact $\mathrm{SL}(\mathbb{V})$-equivariant.

The direct image $R^{i} p_{1 *} p_{2}^{*} L^{n}$ in (3.2) is evidently the trivial holomorphic vector bundle

$$
\begin{equation*}
R^{i} p_{1 *} p_{2}^{*} L^{n}=X \times H^{i}\left(X, L^{n}\right) \tag{3.3}
\end{equation*}
$$

over $X$ with fiber $H^{i}\left(X, L^{n}\right)$ for $i=0,1$.
Next, to understand $R^{i} p_{1 *}\left(\left(p_{2}^{*} L^{n}\right) \otimes \mathcal{O}_{X \times X}(-(k+1) \Delta)\right)$ in (3.2), we first note that the holomorphic line bundle $\mathcal{O}_{X \times X}(\Delta)$ is holomorphically isomorphic to $\left(p_{1}^{*} L\right) \otimes\left(p_{2}^{*} L\right)$. To
construct an explicit isomorphism between $\mathcal{O}_{X \times X}(\Delta)$ and $\left(p_{1}^{*} L\right) \otimes\left(p_{2}^{*} L\right)$, fix a nonzero element

$$
\begin{equation*}
0 \neq \omega \in \bigwedge^{2} \mathbb{V} \tag{3.4}
\end{equation*}
$$

We have $H^{0}(X, L)=\mathbb{V}$. So

$$
H^{0}\left(X \times X,\left(p_{1}^{*} L\right) \otimes\left(p_{2}^{*} L\right)\right)=H^{0}(X, L) \otimes H^{0}(X, L)=\mathbb{V} \otimes \mathbb{V}
$$

and hence $\omega \in \bigwedge^{2} \mathbb{V} \subset \mathbb{V} \otimes \mathbb{V}$ in (3.4) defines a holomorphic section

$$
\begin{equation*}
\widehat{\omega} \in H^{0}\left(X \times X,\left(p_{1}^{*} L\right) \otimes\left(p_{2}^{*} L\right)\right) . \tag{3.5}
\end{equation*}
$$

This section $\widehat{\omega}$ vanishes exactly on the diagonal $\Delta \subset X \times X$; this is because $\omega \in \Lambda^{2} \mathbb{V}$. Consequently, there is a unique holomorphic isomorphism

$$
\begin{equation*}
\Phi:\left(p_{1}^{*} L\right) \otimes\left(p_{2}^{*} L\right) \xrightarrow{\sim} \mathcal{O}_{X \times X}(\Delta) \tag{3.6}
\end{equation*}
$$

such that the section $\Phi(\widehat{\omega})$, where $\widehat{\omega}$ is constructed in (3.5), coincides with the holomorphic section of $\mathcal{O}_{X \times X}(\Delta)$ given by the constant function 1 on $X \times X$.

The isomorphism $\Phi$ in (3.6) depends on $\omega$. It should be mentioned that there is no natural isomorphism between $\mathcal{O}_{X \times X}(\Delta)$ and $\left(p_{1}^{*} L\right) \otimes\left(p_{2}^{*} L\right)$.

Observe that $\omega$ in (3.4) defines a symplectic structure on $\mathbb{V}$, in particular, $\omega$ produces an isomorphism

$$
\begin{equation*}
\mathbb{V}^{*} \xrightarrow{\sim} \mathbb{V} . \tag{3.7}
\end{equation*}
$$

The action of $\operatorname{SL}(\mathbb{V})$ on $\bigwedge^{2} \mathbb{V}$, given by the action of $\operatorname{SL}(\mathbb{V})$ on $\mathbb{V}$, is the trivial action, and hence this action fixes the element $\omega$ in (3.4). We observe that $\omega$ produces a holomorphic isomorphism

$$
\begin{equation*}
\Psi: L^{-1} \longrightarrow \mathbb{L} \tag{3.8}
\end{equation*}
$$

where $\mathbb{L}$ was constructed in (2.9). Indeed, from the short exact sequence of holomorphic vector bundles

$$
\begin{equation*}
0 \longrightarrow \mathbb{L} \longrightarrow X \times \mathbb{V} \longrightarrow L \longrightarrow 0 \tag{3.9}
\end{equation*}
$$

we conclude that $\mathbb{L} \otimes L=X \times \bigwedge^{2} \mathbb{V}$. Therefore, the element $\omega \in \Lambda^{2} \mathbb{V}$ gives a nowhere vanishing holomorphic section of $\mathbb{L} \otimes L$. This section produces the isomorphism $\Psi$ in (3.8). Observe that the diagonal action of $\mathrm{SL}(\mathbb{V})$ on $X \times \mathbb{V}$ preserves the subbundle $\mathbb{L}$ in (3.9); more precisely, the homomorphisms in the exact sequence (3.9) are $\mathrm{SL}(\mathbb{V})$-equivariant. The isomorphism $\Psi$ in (3.8) is evidently $\mathrm{SL}(\mathbb{V})$-equivariant. It should be mentioned that $\Psi$ depends on $\omega$.

Combining $\Phi$ in (3.6) with $\Psi$ in (3.8), we have

$$
\begin{equation*}
\left(p_{1}^{*} \mathbb{L}\right) \otimes\left(p_{2}^{*} \mathbb{L}\right)=\left(p_{1}^{*} L^{-1}\right) \otimes\left(p_{2}^{*} L^{-1}\right)=\left(p_{1}^{*} \mathbb{L}\right) \otimes\left(p_{2}^{*} L^{-1}\right)=\mathcal{O}_{X \times X}(-\Delta) \tag{3.10}
\end{equation*}
$$

Using the identification of $X$ with $\Delta$, the Poincaré adjunction formula gives that $\left.\mathcal{O}_{X \times X}(\Delta)\right|_{\Delta}=T X$, where $T X$ is the holomorphic tangent bundle of $X$; this isomorphism $\left.\mathcal{O}_{X \times X}(\Delta)\right|_{\Delta}=T X$ is the dual of the isomorphism in (2.3) for $k=1$. Therefore, restricting the isomorphisms in (3.10) to $\Delta \subset X \times X$, we have a holomorphic isomorphism

\Phi_{0}: L^{2}=\left(\mathbb{L}^{*}\right)^{\otimes 2} \xrightarrow{\sim} T X \tag{3.11}
\end{equation*}
$$

Using the isomorphisms in (3.10), we have

$$
\left(p_{2}^{*} L^{n}\right) \otimes \mathcal{O}_{X \times X}(-(k+1) \Delta)=\left(p_{1}^{*} L^{-k-1}\right) \otimes\left(p_{2}^{*} L^{n-k-1}\right)=\left(p_{1}^{*} \mathbb{L}^{k+1}\right) \otimes\left(p_{2}^{*} L^{n-k-1}\right)
$$

Hence by the projection formula, [Ha, p. 426, A4],

$$
\begin{gather*}
R^{i} p_{1 *}\left(\left(p_{2}^{*} L^{n}\right) \otimes \mathcal{O}_{X \times X}(-(k+1) \Delta)\right)=R^{i} p_{1 *}\left(\left(p_{1}^{*} \mathbb{L}^{k+1}\right) \otimes\left(p_{2}^{*} L^{n-k-1}\right)\right)  \tag{3.12}\\
=\mathbb{L}^{k+1} \otimes R^{i} p_{1 *}\left(p_{2}^{*} L^{n-k-1}\right)
\end{gather*}
$$

for $i=0,1$.
We shall break all possible $(n, k)$ into three cases.
3.1. The case of $n<0$. In (3.2), we have $R^{0} p_{1 *} p_{2}^{*} L^{n}=0$, because $n<0$. Consequently, the short exact sequence in (3.2) becomes

0 \longrightarrow J^{k}\left(L^{n}\right) \longrightarrow R^{1} p_{1 *}\left(\left(p_{2}^{*} L^{n}\right) \otimes \mathcal{O}_{X \times X}(-(k+1) \Delta)\right) \longrightarrow R^{1} p_{1 *} p_{2}^{*} L^{n} \longrightarrow 0 \tag{3.13}
\end{equation*}
$$

Now using (3.12), the exact sequence in (3.13) becomes the short exact sequence

$$
\begin{equation*}
0 \longrightarrow J^{k}\left(L^{n}\right) \longrightarrow \mathbb{L}^{k+1} \otimes R^{1} p_{1 *}\left(p_{2}^{*} L^{n-k-1}\right) \xrightarrow{\gamma_{1}} R^{1} p_{1 *} p_{2}^{*} L^{n} \longrightarrow 0 . \tag{3.14}
\end{equation*}
$$

Invoking Serre duality and using the isomorphism $\Phi_{0}$ in (3.11),

$$
H^{1}\left(X, L^{n}\right)=H^{0}\left(X, L^{-n-2}\right)^{*}=\operatorname{Sym}^{-n-2}(\mathbb{V})^{*},
$$

where $\operatorname{Sym}^{-n-2}(\mathbb{V})$ denotes:

- the $(-n-2)$-th symmetric power of $\mathbb{V}$, if $-n-2>0$,
- $\mathbb{C}$, if $-n=2$, and
- 0 , if $-n=1$.

Therefore, $R^{1} p_{1 *} p_{2}^{*} L^{n}$ in (3.14) is the trivial holomorphic vector bundle

$$
X \times \operatorname{Sym}^{-n-2}(\mathbb{V})^{*} \longrightarrow X
$$

(see (3.3)).
For notational convenience, the trivial holomorphic vector bundle $X \times \operatorname{Sym}^{j}(\mathbb{V})$ over $X$ with fiber $\operatorname{Sym}^{j}(\mathbb{V})$ will be denoted by $\mathbb{V}_{j}$. The trivial line bundle $\mathcal{O}_{X}$ will be denoted by $\mathbb{V}_{0}$. So we have

$$
\begin{equation*}
R^{1} p_{1 *} p_{2}^{*} L^{n}=\left(\mathbb{V}_{-n-2}\right)^{*}=\mathbb{V}_{-n-2}^{*} \tag{3.15}
\end{equation*}
$$

Similarly, we have

$$
\begin{equation*}
R^{1} p_{1 *}\left(p_{2}^{*} L^{n-k-1}\right)=X \times \operatorname{Sym}^{k-n-1}(\mathbb{V})^{*}=\mathbb{V}_{k-n-1}^{*} \longrightarrow X \tag{3.16}
\end{equation*}
$$

Hence $\mathbb{L}^{k+1} \otimes R^{1} p_{1 *}\left(p_{2}^{*} L^{n-k-1}\right)$ in (3.14) has the following description:

\begin{equation*}
\mathbb{L}^{k+1} \otimes R^{1} p_{1 *}\left(p_{2}^{*} L^{n-k-1}\right)=\mathbb{L}^{k+1} \otimes \mathbb{V}_{k-n-1}^{*} \tag{3.17}
\end{equation*}
$$

Using (3.15) and (3.17), the homomorphism $\gamma_{1}$ in (3.14) is a homomorphism

$$
\begin{equation*}
\gamma_{1}: \mathbb{L}^{k+1} \otimes \mathbb{V}_{k-n-1}^{*} \longrightarrow \mathbb{V}_{-n-2}^{*} \tag{3.18}
\end{equation*}
$$

The homomorphism $\gamma_{1}$ in (3.18) is simply the contraction of elements of $\mathbb{V}$ by $\mathbb{V}^{*}$ (recall that $\mathbb{L} \subset X \times \mathbb{V})$. More precisely, consider the contraction homomorphism

\mathbb{V} \otimes\left(\mathbb{V}^{*}\right)^{\otimes j} \longrightarrow\left(\mathbb{V}^{*}\right)^{\otimes(j-1)}
$$

Since $\mathbb{L} \subset \mathbb{V}_{1}($ see (3.9) $)$, this contraction produces a holomorphic homomorphism of vector bundles

\mathbb{L} \otimes \mathbb{V}_{j}^{*} \longrightarrow \mathbb{V}_{j-1}^{*}
$$

The homomorphism $\gamma_{1}$ in (3.18) is $(k+1)$-times iteration of this homomorphism starting with $j=k-n-1$.

We shall compute the kernel of the homomorphism $\gamma_{1}$ in (3.18).
Taking the dual of the short exact sequence in (3.9), we have

L^{*} \subset X \times \mathbb{V}^{*}=\mathbb{V}_{1}^{*}
$$

Hence, using the isomorphism $\Psi$ in (3.8), we have

$$
\begin{equation*}
\mathbb{L}=L^{*} \subset \mathbb{V}_{1}^{*} \tag{3.19}
\end{equation*}
$$

For the natural duality paring $\mathbb{V}_{1} \otimes \mathbb{V}_{1}^{*} \longrightarrow \mathcal{O}_{X}$, the annihilator of the subbundle $\mathbb{L} \subset \mathbb{V}_{1}$ in (3.9) is the subbundle $\mathbb{L} \subset \mathbb{V}_{1}^{*}$ in (3.19). Therefore, from the above description of the homomorphism $\gamma_{1}$ in (3.18) we conclude that the subbundle

$$
\mathbb{L}^{k+1} \otimes\left(\mathbb{V}_{k-n-1}^{*}\right) \supset \mathbb{L}^{k+1} \otimes\left(\mathbb{L}^{-n-1} \otimes \mathbb{V}_{k}^{*}\right)=\mathbb{L}^{k-n} \otimes \mathbb{V}_{k}^{*}
$$

is contained in the kernel of the surjective homomorphism $\gamma_{1}$; note that $\mathbb{L}^{-n-1} \otimes \mathbb{V}_{k}^{*}$ is realized as a subbundle of $\mathbb{V}_{k-n-1}^{*}$ using the inclusion $\mathbb{L} \subset \mathbb{V}_{1}^{*}$ in (3.19). From (3.14) we know that $\gamma_{1}$ is surjective. Since
$\operatorname{rank}\left(\mathbb{L}^{k-n} \otimes \mathbb{V}_{k}^{*}\right)=k+1=(k-n)-(-n-1)=\operatorname{rank}\left(\mathbb{L}^{k+1} \otimes \mathbb{V}_{k-n-1}^{*}\right)-\operatorname{rank}\left(\mathbb{V}_{-n-2}^{*}\right)$, we now conclude that

\mathbb{L}^{k-n} \otimes \mathbb{V}_{k}^{*}=\operatorname{kernel}\left(\gamma_{1}\right)
$$

Therefore, from (3.14) it follows that

J^{k}\left(L^{n}\right)=\operatorname{kernel}\left(\gamma_{1}\right)=\mathbb{L}^{k-n} \otimes \mathbb{V}_{k}^{*} \tag{3.20}
\end{equation*}
$$

Now using the isomorphism between $\mathbb{V}_{k}$ and $\mathbb{V}_{k}^{*}$ given by the isomorphism in (3.7), from (3.20) we deduce that

J^{k}\left(L^{n}\right)=\mathbb{L}^{k-n} \otimes \mathbb{V}_{k}
$$

Moreover, using the isomorphism $\Psi$ in (3.8) we have

$$
\begin{equation*}
J^{k}\left(L^{n}\right)=L^{n-k} \otimes \mathbb{V}_{k} \tag{3.21}
\end{equation*}
$$

Recall that all the homomorphisms in (3.2) are $\mathrm{SL}(\mathbb{V})$-equivariant. From the construction of the isomorphism in (3.20) between $J^{k}\left(L^{n}\right)$ and $\mathbb{L}^{k-n} \otimes \mathbb{V}_{k}^{*}$ it is evident that it is $\mathrm{SL}(\mathbb{V})$-equivariant. Therefore, the isomorphism in (3.21) is $\mathrm{SL}(\mathbb{V})$-equivariant.

Fix $k \geq 1$ an integer. Using (3.21), the homomorphism $\phi_{k}$ in (2.5) is a projection

$$
\begin{equation*}
\phi_{k}: L^{n-k} \otimes \mathbb{V}_{k}=J^{k}\left(L^{n}\right) \longrightarrow J^{k-1}\left(L^{n}\right)=L^{n-k+1} \otimes \mathbb{V}_{k-1} \tag{3.22}
\end{equation*}
$$

We shall describe the homomorphism in (3.22).
Recall that $\mathbb{V}_{j}=\operatorname{Sym}^{j}\left(\mathbb{V}_{1}\right)=\operatorname{Sym}^{j}(X \times \mathbb{V})$, and the line bundle $L$ is a quotient of $\mathbb{V}_{1}$ (see (3.9)). Therefore, we have a natural projection

\begin{equation*}
\varpi_{k}^{0}: \mathbb{V}_{k} \longrightarrow L \otimes \mathbb{V}_{k-1} \tag{3.23}
\end{equation*}
$$

To describe this $\varpi_{k}^{0}$ explicitly, let $q_{L}: \mathbb{V}_{1} \longrightarrow L$ be the quotient map in (3.9). Consider the homomorphism

q_{L} \otimes \operatorname{Id}_{\mathbb{V}_{1}^{\otimes(k-1)}}: \mathbb{V}_{1}^{\otimes k} \longrightarrow L \otimes \mathbb{V}_{1}^{\otimes(k-1)}
$$

Note that $q_{L} \otimes \mathrm{Id}_{\mathbb{V}_{1}^{\otimes(k-1)}}$ sends the subbundle

\operatorname{Sym}^{k}\left(\mathbb{V}_{1}\right) \subset \mathbb{V}_{1}^{\otimes k}
$$

to the subbundle $L \otimes \mathbb{V}_{k-1} \subset L \otimes \mathbb{V}_{1}^{\otimes(k-1)}$. The homomorphism $\varpi_{k}^{0}$ in (3.23) is this restriction of $q_{L} \otimes \operatorname{Id}_{\mathbb{V}_{1}^{\otimes(k-1)}}$.

Proposition 3.1. The homomorphism $\phi_{k}$ in (3.22) coincides with $\operatorname{Id}_{L^{n-k}} \otimes \varpi_{k}^{0}$, where $\varpi_{k}^{0}$ is the homomorphism in (3.23).

Proof. Consider the short exact sequence in (3.13). We have the commutative diagram of homomorphisms

where the bottom exact sequence is the one in (3.13) with $k$ substituted by $k-1$, the top exact sequence is the one in (3.13), the left-vertical exact sequence is the one in (2.5) for $W=L^{n}$, and the other vertical exact sequence is the long exact sequence of direct images, under $p_{1}$, for the short exact sequence
$\left.0 \longrightarrow\left(p_{2}^{*} L^{n}\right) \otimes \mathcal{O}_{X \times X}(-(k+1) \Delta) \longrightarrow\left(p_{2}^{*} L^{n}\right) \otimes \mathcal{O}_{X \times X}(-k \Delta) \longrightarrow\left(L^{n} \otimes K_{X}^{\otimes k}\right)\right|_{\Delta} \longrightarrow 0$ of sheaves on $X \times X$ obtained by tensoring with $p_{2}^{*} L^{n}$ the short exact sequence given by (2.2).

Using (3.12) and (3.17) we have

R^{1} p_{1 *}\left(\left(p_{2}^{*} L^{n}\right) \otimes \mathcal{O}_{X \times X}(-(k+1) \Delta)\right)=\mathbb{L}^{k+1} \otimes \mathbb{V}_{k-n-1}^{*}
$$

Replacing $k$ by $k-1$, we have

$$
R^{1} p_{1 *}\left(\left(p_{2}^{*} L^{n}\right) \otimes \mathcal{O}_{X \times X}(-k \Delta)\right)=\mathbb{L}^{k} \otimes \mathbb{V}_{k-n-2}^{*}
$$

So the homomorphism $\mu$ in (3.24) becomes a homomorphism

$$
\mu: \mathbb{L}^{k+1} \otimes \mathbb{V}_{k-n-1}^{*} \longrightarrow \mathbb{L}^{k} \otimes \mathbb{V}_{k-n-2}^{*}
$$

This homomorphism is simply the contraction of elements of $\mathbb{V}^{*}$ by elements of $\mathbb{L} \subset \mathbb{V}$. The proposition follows from this and the commutative diagram in (3.24).
3.2. The case of $n \geq k$. Note that $n \geq 0$, because $n \geq k$. Since now we have $n-k-1 \geq-1$, it follows that

H^{1}\left(X, L^{n-k-1}\right)=0
$$

and hence using (3.12) and (3.3) it is deduced that

R^{1} p_{1 *}\left(\left(p_{2}^{*} L^{n}\right) \otimes \mathcal{O}_{X \times X}(-(k+1) \Delta)\right)=0
$$

Consequently, the exact sequence in (3.2) becomes the short exact sequence

$$
\begin{equation*}
0 \longrightarrow R^{0} p_{1 *}\left(\left(p_{2}^{*} L^{n}\right) \otimes \mathcal{O}_{X \times X}(-(k+1) \Delta)\right) \longrightarrow R^{0} p_{1 *} p_{2}^{*} L^{n} \longrightarrow J^{k}\left(L^{n}\right) \longrightarrow 0 \tag{3.25}
\end{equation*}
$$

Therefore, using (3.12) and (3.3), the exact sequence in (3.25) becomes the short exact sequence

$$
\begin{gather*}
0 \longrightarrow \mathbb{L}^{k+1} \otimes R^{0} p_{1 *}\left(p_{2}^{*} L^{n-k-1}\right)=\mathbb{L}^{k+1} \otimes \mathbb{V}_{n-k-1}  \tag{3.26}\\
\xrightarrow{\gamma_{2}} X \times \operatorname{Sym}^{n}(\mathbb{V})=: \mathbb{V}_{n} \longrightarrow J^{k}\left(L^{n}\right) \longrightarrow 0
\end{gather*}
$$

Consider the homomorphism given by the composition of the natural homomorphisms

$$
\mathbb{V} \otimes \mathbb{V}_{j} \longrightarrow X \times \mathbb{V}^{\otimes(j+1)} \longrightarrow X \times \operatorname{Sym}^{j+1}(\mathbb{V})=\mathbb{V}_{j+1}
$$

Since $\mathbb{L} \subset \mathbb{V}($ see (3.9) $)$, this restricts to a homomorphism

$$
\mathbb{L} \otimes \mathbb{V}_{j} \longrightarrow \mathbb{V}_{j+1}
$$

The homomorphism $\gamma_{2}$ in (3.26) is $(k+1)$-fold iteration of this homomorphism starting with $j=n-k-1$.

To compute the cokernel of this homomorphism $\gamma_{2}$, consider the surjective homomorphism $\mathbb{V}_{1} \longrightarrow L$ in (3.9). It produces a surjective homomorphism

$$
\theta_{2}: \mathbb{V}_{n} \longrightarrow L^{n-k} \otimes \mathbb{V}_{k}
$$

It is straight-forward to check that $\theta_{2} \circ \gamma_{2}=0$. Consequently, $\theta_{2}$ produces a surjective homomorphism from $\operatorname{cokernel}\left(\gamma_{2}\right)$ to $L^{n-k} \otimes \mathbb{V}_{k}$. On the other hand,

$$
\operatorname{rank}\left(\mathbb{V}_{n}\right)-\operatorname{rank}\left(\mathbb{L}^{k+1} \otimes \mathbb{V}_{n-k-1}\right)=k+1=\operatorname{rank}\left(L^{n-k} \otimes \mathbb{V}_{k}\right)
$$

Hence we conclude that the above surjection from $\operatorname{cokernel}\left(\gamma_{2}\right)$ to $L^{n-k} \otimes \mathbb{V}_{k}$ is also injective.

Therefore, from (3.26) it follows that

J^{k}\left(L^{n}\right)=L^{n-k} \otimes \mathbb{V}_{k} \tag{3.27}
\end{equation*}
$$

From the construction of the isomorphism in (3.27) it is evident that this isomorphism is in fact $\operatorname{SL}(\mathbb{V})$-equivariant.

Consider $k \geq 1$ an integer. Using (3.27), the homomorphism $\phi_{k}$ in (2.5) is a projection

$$
\begin{equation*}
\phi_{k}: L^{n-k} \otimes \mathbb{V}_{k}=J^{k}\left(L^{n}\right) \longrightarrow J^{k-1}\left(L^{n}\right)=L^{n-k+1} \otimes \mathbb{V}_{k-1} \tag{3.28}
\end{equation*}
$$

Proposition 3.2. The homomorphism $\phi_{k}$ in (3.28) coincides with $\operatorname{Id}_{L^{n-k}} \otimes \varpi_{k}^{0}$, where $\varpi_{k}^{0}$ is the homomorphism in (3.23).

Proof. Consider the short exact sequence of sheaves in (3.25). We have the commutative diagram of homomorphism

where the bottom exact row is (3.25) with $k-1$ substituted in place of $k$, the top exact row is the one in (3.25), the right vertical exact sequence is the one in (2.5) and the left vertical exact sequence is a part of the long exact sequence of direct images, under $p_{1}$, for the short exact sequence
$\left.0 \longrightarrow\left(p_{2}^{*} L^{n}\right) \otimes \mathcal{O}_{X \times X}(-(k+1) \Delta) \longrightarrow\left(p_{2}^{*} L^{n}\right) \otimes \mathcal{O}_{X \times X}(-k \Delta) \longrightarrow\left(L^{n} \otimes K_{X}^{\otimes k}\right)\right|_{\Delta} \longrightarrow 0$ of sheaves on $X \times X$ obtained by tensoring (2.3) with $p_{2}^{*} L^{n}$. Using (3.12), in (3.26) we saw that

R^{0} p_{1 *}\left(\left(p_{2}^{*} L^{n}\right) \otimes \mathcal{O}_{X \times X}(-(k+1) \Delta)\right)=\mathbb{L}^{k+1} \otimes \mathbb{V}_{n-k-1}
$$

So replacing $k$ by $k-1$, we have

R^{0} p_{1 *}\left(\left(p_{2}^{*} L^{n}\right) \otimes \mathcal{O}_{X \times X}(-k \Delta)\right)=\mathbb{L}^{k} \otimes \mathbb{V}_{n-k}
$$

Using these isomorphisms, the injective homomorphism

$$
\mu: \mathbb{L}^{k+1} \otimes \mathbb{V}_{n-k-1}=\mathbb{L}^{k+1} \otimes \operatorname{Sym}^{n-k-1}\left(\mathbb{V}_{1}\right) \longrightarrow \mathbb{L}^{k} \otimes \operatorname{Sym}^{n-k}\left(\mathbb{V}_{1}\right)
$$

in (3.29) is the natural homomorphism induced by the inclusion of $\mathbb{L}$ in $\mathbb{V}_{1}$. Now the proposition follows from (3.29).

The remaining case will now be considered.
3.3. The case of $k>n \geq 0$. Since $n \geq 0$, it follows that $H^{1}\left(X, L^{n}\right)=0$. Hence in (3.2) we have

R^{1} p_{1 *} p_{2}^{*} L^{n}=0 ;
$$

see (3.3). Since $n-k-1<0$, we have $H^{0}\left(X, L^{n-k-1}\right)=0$. Therefore, from (3.12) and (3.3) we conclude that

$$
R^{0} p_{1 *}\left(\left(p_{2}^{*} L^{n}\right) \otimes \mathcal{O}_{X \times X}(-(k+1) \Delta)\right)=0
$$

Consequently, the exact sequence in (3.2) becomes the short exact sequence

$$
\begin{equation*}
0 \longrightarrow R^{0} p_{1 *} p_{2}^{*} L^{n} \longrightarrow J^{k}\left(L^{n}\right) \longrightarrow R^{1} p_{1 *}\left(\left(p_{2}^{*} L^{n}\right) \otimes \mathcal{O}_{X \times X}(-(k+1) \Delta)\right) \longrightarrow 0 \tag{3.30}
\end{equation*}
$$

Now using (3.12) and (3.3) together with the projection formula, the exact sequence in (3.30) becomes the exact sequence

$$
\begin{equation*}
0 \longrightarrow \mathbb{V}_{n} \xrightarrow{\gamma_{3}} J^{k}\left(L^{n}\right) \xrightarrow{\theta_{3}} \mathbb{L}^{k+1} \otimes R^{1} p_{1 *}\left(p_{2}^{*} L^{n-k-1}\right) \longrightarrow 0 . \tag{3.31}
\end{equation*}
$$

The homomorphisms $\gamma_{3}$ and and $\theta_{3}$ in (3.31) are clearly $\operatorname{SL}(\mathbb{V})$-equivariant.
Lemma 3.3. The short exact sequence in (3.31) has a canonical SL(V)-equivariant holomorphic splitting.

Proof. Since $k>n$, there is a natural projection

J^{k}\left(L^{n}\right) \longrightarrow J^{n}\left(L^{n}\right)
$$

$\left(\right.$ see (2.5)). Now $J^{n}\left(L^{n}\right)=\mathbb{V}_{n}$ by (3.27), so this projection defines a projection

\begin{equation*}
\beta: J^{k}\left(L^{n}\right) \longrightarrow \mathbb{V}_{n} \tag{3.32}
\end{equation*}
$$

It is straight-forward to check that $\beta \circ \gamma_{3}=\operatorname{Id}_{\mathbb{V}_{n}}$, where $\gamma_{3}$ and $\beta$ are constructed in (3.31) and (3.32) respectively. This produces an $\operatorname{SL}(\mathbb{V})$-equivariant holomorphic splitting

J^{k}\left(L^{n}\right)=\operatorname{image}\left(\gamma_{3}\right) \oplus \operatorname{kernel}(\beta)
$$

of the short exact sequence in (3.31).
Lemma 3.3 gives a holomorphic decomposition

$$
\begin{equation*}
J^{k}\left(L^{n}\right)=\mathbb{V}_{n} \oplus\left(\mathbb{L}^{k+1} \otimes R^{1} p_{1 *}\left(p_{2}^{*} L^{n-k-1}\right)\right. \tag{3.33}
\end{equation*}
$$

which is compatible with the actions of $\operatorname{SL}(\mathbb{V})$. Now, $R^{1} p_{1 *}\left(p_{2}^{*} L^{n-k-1}\right)=\mathbb{V}_{k-n-1}^{*}$ (see (3.16)), and $\mathbb{V}_{k-n-1}^{*}=\mathbb{V}_{k-n-1}$ which is constructed using the isomorphism in (3.7). Therefore, the decomposition in (3.33) can be reformulated as

$$
\begin{equation*}
J^{k}\left(L^{n}\right)=\mathbb{V}_{n} \oplus\left(\mathbb{L}^{k+1} \otimes \mathbb{V}_{k-n-1}\right)=\mathbb{V}_{n} \oplus\left(L^{-(k+1)} \otimes \mathbb{V}_{k-n-1}\right) \tag{3.34}
\end{equation*}
$$

using $\Psi$ in (3.8). As before, the isomorphisms in (3.34) are compatible with the actions of $\operatorname{SL}(\mathbb{V})$.

If $k-1>n \geq 0$, then from (3.34) we know that

$$
J^{k-1}\left(L^{n}\right)=\mathbb{V}_{n} \oplus\left(\mathbb{L}^{k} \otimes \mathbb{V}_{k-n-2}\right)=\mathbb{V}_{n} \oplus\left(L^{-k} \otimes \mathbb{V}_{k-n-2}\right)
$$

and if $k-1=n \geq 0$, then from (3.27) we have

$$
J^{k-1}\left(L^{n}\right)=\mathbb{V}_{k-1}
$$

The proof of the following proposition is similar to the proofs of Proposition 3.1 and Proposition 3.2,

Proposition 3.4. If $k-1>n \geq 0$, then the projection $J^{k}\left(L^{n}\right) \longrightarrow J^{k-1}\left(L^{n}\right)$ in (2.5) is the homomorphism

$$
\mathbb{V}_{n} \oplus\left(L^{-(k+1)} \otimes \mathbb{V}_{k-n-1}\right) \longrightarrow \mathbb{V}_{n} \oplus\left(L^{-k} \otimes \mathbb{V}_{k-n-2}\right)
$$

which is the direct sum of the identity map of $\mathbb{V}_{n}$ and the natural contraction map $L^{-(k+1)} \otimes$ $\mathbb{V}_{k-n-1} \longrightarrow L^{-k} \otimes \mathbb{V}_{k-n-2}$.

If $k-1=n \geq 0$, then the projection $J^{k}\left(L^{n}\right) \longrightarrow J^{k-1}\left(L^{n}\right)$ in (2.5) is the homomorphism

$$
\mathbb{V}_{n} \oplus\left(L^{-(k+1)} \otimes \mathbb{V}_{k-n-1}\right) \longrightarrow \mathbb{V}_{n}
$$

which is the direct sum of the identity map of $\mathbb{V}_{n}$ and the zero homomorphism of $L^{-(k+1)} \otimes$ $\mathbb{V}_{k-n-1}=L^{-(k+1)}\left(\right.$ recall that $\left.\mathbb{V}_{0}=\mathcal{O}_{X}\right)$.

### 3.4. The jet bundle. Combining (3.21), (3.27) and (3.34), we have the following:

Theorem 3.5. If $n<0$ or $n \geq k$, then

$$
J^{k}\left(L^{n}\right)=L^{n-k} \otimes \mathbb{V}_{k}
$$

If $k>n \geq 0$, then

$$
J^{k}\left(L^{n}\right)=\mathbb{V}_{n} \oplus\left(L^{-(k+1)} \otimes \mathbb{V}_{k-n-1}\right)
$$

Both the isomorphisms are $\mathrm{SL}(\mathbb{V})$-equivariant.

## 4. Holomorphic connections on vector bundles

In this section we construct and study natural differential holomorphic operators between natural holomorphic vector bundles on a Riemann surface equipped with a projective structure.
4.1. Jets of Riemann surfaces with a projective structure. Let $M$ be a compact connected Riemann surface of genus $g$. A holomorphic coordinate chart on $M$ is a pair of the form $(U, \varphi)$, where $U \subset M$ is an open subset and $\varphi: U \longrightarrow \mathbb{P}(\mathbb{V})=X$ is a holomorphic embedding. A holomorphic coordinate atlas on $M$ is a collection of coordinate charts $\left\{\left(U_{i}, \varphi_{i}\right)\right\}_{i \in I}$ such that $M=\bigcup_{i \in I} U_{i}$. A projective structure on $M$ is given by a holomorphic coordinate atlas $\left\{\left(U_{i}, \varphi_{i}\right)\right\}_{i \in I}$ such that for all pairs $(i, j) \in I \times I$ for which $U_{i} \bigcap U_{j} \neq \emptyset$, there exists an element $\tau_{j, i} \in \operatorname{Aut}(\mathbb{P}(\mathbb{V}))=\operatorname{PGL}(\mathbb{V})$ such that $\varphi_{j} \circ \varphi_{i}^{-1}$ is the restriction of $\tau_{j, i}$ to $\varphi_{i}\left(U_{i} \bigcap U_{j}\right)$. A holomorphic coordinate atlas satisfying this condition is called a projective atlas. Two such projective atlases $\left\{\left(U_{i}, \varphi_{i}\right)\right\}_{i \in I}$ and $\left\{\left(U_{i}, \varphi_{i}\right)\right\}_{i \in J}$ are called equivalent if their union $\left\{\left(U_{i}, \varphi_{i}\right)\right\}_{i \in I \cup J}$ is again a projective atlas. A projective structure on $M$ is an equivalence class of projective atlases (see [Gu]).

Giving a projective structure on $M$ is equivalent to giving a holomorphic Cartan geometry on $M$ for the pair of groups $(\operatorname{PSL}(2, \mathbb{C}), B)$, where $B \subset \operatorname{PSL}(2, \mathbb{C})$ is the Borel subgroup

$$
B:=\left\{\left.\left(\begin{array}{ll}
a & b \\
c & d
\end{array}\right) \in \operatorname{PSL}(2, \mathbb{C}) \right\rvert\, d=0\right\} ;
$$

see Sh for Cartan geometry.
Note that the collection $\left\{\tau_{j, i}\right\}$ in the definition of a projective atlas forms a 1-cocycle with values in $\operatorname{PGL}(\mathbb{V})$. The corresponding cohomology class in $H^{1}(M, \operatorname{PGL}(\mathbb{V}))$ depends only on the projective structure and can be lifted to $H^{1}(M, \mathrm{SL}(\mathbb{V}))$. Moreover the space of such lifts is in bijection with the theta characteristics of $M$ (see [Gu]). We recall that the theta characteristic on $M$ is a holomorphic line bundle $K_{M}^{1 / 2}$ on $M$ together with a holomorphic isomorphism of $K_{M}^{1 / 2} \otimes K_{M}^{1 / 2}$ with the holomorphic cotangent bundle $K_{M}$.

We fix a theta characteristic on $M$. So a projective structure on $M$ is given by a coordinate atlas $\left\{\left(U_{i}, \varphi_{i}\right)\right\}_{i \in I}$ together with an element

$$
\tau_{j, i} \in \mathrm{SL}(\mathbb{V})
$$

for every ordered pair $(i, j) \in I \times I$ such that $U_{i} \bigcap U_{j} \neq \emptyset$ such that the following four conditions hold:
(1) $\varphi_{j} \circ \varphi_{i}^{-1}$ is the restriction to $\varphi_{i}\left(U_{i} \bigcap U_{j}\right)$ of the automorphism of $X$ given by $\tau_{j, i}$,
(2) $\tau_{i, k} \tau_{k, j} \tau_{j, i}=\operatorname{Id}_{\mathbb{V}}$ for all $i, j, k \in I$ such that $U_{i} \bigcap U_{j} \bigcap U_{k} \neq \emptyset$,
(3) $\tau_{i, i}=\operatorname{Id}_{\mathbb{V}}$ for all $i \in I$, and
(4) the theta characteristic corresponding to the data is the given one.

Two such collections of triples $\left\{\left\{\left(U_{i}, \varphi_{i}\right)\right\}_{i \in I},\left\{\tau_{i, j}\right\}\right\}$ and $\left\{\left\{\left(U_{i}, \varphi_{i}\right)\right\}_{i \in J},\left\{\tau_{i, j}\right\}\right\}$ are called equivalent if their union $\left\{\left\{\left(U_{i}, \varphi_{i}\right)\right\}_{i \in I \cup J},\left\{\tau_{i, j}\right\}\right\}$ is again a part of a collection of triples satisfying the above conditions. A SL( $\mathbb{V}$ )-projective structure on $M$ is an equivalence class of collection of triples satisfying the above conditions.

Giving a $\mathrm{SL}(\mathbb{V})$-projective structure on $M$ is equivalent to giving a holomorphic Cartan geometry on $M$ for the pair of groups ( $\left.\mathrm{SL}(2, \mathbb{C}), B_{0}\right)$, where $B_{0} \subset \mathrm{SL}(2, \mathbb{C})$ is the Borel subgroup

$$
B_{0}:=\left\{\left.\left(\begin{array}{ll}
a & b \\
c & d
\end{array}\right) \in \mathrm{SL}(2, \mathbb{C}) \right\rvert\, d=0\right\} .
$$

Let $P=\left\{\left\{\left(U_{i}, \varphi_{i}\right)\right\}_{i \in I},\left\{\tau_{i, j}\right\}\right\}$ be a $\mathrm{SL}(\mathbb{V})$-projective structure on $M$. Recall that the collection $\left\{\tau_{i, j}\right\}$ forms a 1 -cocycle on $M$ with values in the group $\operatorname{SL}(\mathbb{V})$. Hence $\left\{\tau_{i, j}\right\}$ produce a holomorphic rank two bundle $\mathcal{V}$ on $M$ equipped with a holomorphic connection

$$
\begin{equation*}
D: \mathcal{V} \longrightarrow \mathcal{V} \otimes K_{M} \tag{4.1}
\end{equation*}
$$

where $K_{M}$ is the holomorphic cotangent bundle of $M$ (see At2] for holomorphic connections). To construct the pair $(\mathcal{V}, D)$ explicitly, for each $i \in I$, consider the trivial holomorphic vector bundle $U_{i} \times \mathbb{V} \longrightarrow U_{i}$ equipped with the trivial connection. For any ordered pair $(i, j) \in I \times I$ with $U_{i} \bigcap U_{j} \neq \emptyset$, glue $U_{i} \times \mathbb{V}$ and $U_{j} \times \mathbb{V}$ over $U_{i} \bigcap U_{j}$ using the automorphism of $\left(U_{i} \bigcap U_{j}\right) \times \mathbb{V}$ that sends any

$$
(y, v) \in\left(U_{i} \bigcap U_{j}\right) \times \mathbb{V} \subset U_{j} \times \mathbb{V}
$$

to $\left(y, \tau_{i, j}(v)\right) \in\left(U_{i} \bigcap U_{j}\right) \times \mathbb{V} \subset U_{i} \times \mathbb{V}$. This automorphism of $\left(U_{i} \bigcap U_{j}\right) \times \mathbb{V}$ is holomorphic, and it evidently preserves the trivial connection. Therefore, this gluing operation produces a holomorphic vector bundle on $M$, which we shall denote by $\mathcal{V}$, and a holomorphic connection on $\mathcal{V}$, which we shall denote by $D$.

The diagonal action of $\mathrm{SL}(\mathbb{V})$ on $X \times \mathbb{V}$ preserves the subbundle $\mathbb{L}$ in (3.9). Therefore, the subbundles $\varphi_{i}\left(U_{i}\right) \times \mathbb{L} \subset \varphi\left(U_{i}\right) \times \mathbb{V}$ patch together compatibly to produce a holomorphic line subbundle of the vector bundle $\mathcal{V}$ on $M$ constructed above. This line subbundle of $\mathcal{V}$ will be denoted by $\mathcal{L}$. Let

$$
\begin{equation*}
\mathrm{L}:=\mathcal{V} / \mathcal{L} \tag{4.2}
\end{equation*}
$$

be the quotient bundle.
Recall that the isomorphism $\Psi$ in (3.8) and the isomorphism $\Phi_{0}$ in (3.11) are both $\operatorname{SL}(\mathbb{V})$-equivariant. However, it should be clarified that a nonzero element $\omega \in \bigwedge^{2} \mathbb{V}$ (see (3.4)) was used in their construction. Since $\Psi$ and $\Phi_{0}$ are $\operatorname{SL}(\mathbb{V})$-equivariant, they produce isomorphisms

$$
\begin{equation*}
\mathbf{L}=\mathcal{L}^{*} \quad \text { and } \mathbf{L}^{\otimes 2}=\left(\mathcal{L}^{*}\right)^{\otimes 2}=T M \tag{4.3}
\end{equation*}
$$

respectively. Recall that we fixed a theta characteristic on $M$. The fourth condition in the definition of a projective structure says that the theta characteristic $\mathcal{L}$ coincides with the chosen one.

For any $j \geq 1$, the vector bundle $\operatorname{Sym}^{j}(\mathcal{V})$ will be denoted by $\mathcal{V}_{j}$. Also, $\mathcal{V}_{0}$ will denote the trivial line bundle $\mathcal{O}_{M}$. The holomorphic connection $D$ on $\mathcal{V}$ constructed in (4.1) induces a holomorphic connection on $\mathcal{V}_{j}$ for every $j \geq 1$; let

$$
\begin{equation*}
D_{j}: \mathcal{V}_{j} \longrightarrow \mathcal{V}_{j} \otimes K_{M} \tag{4.4}
\end{equation*}
$$

be this connection given by $D$. The trivial connection on $\mathcal{V}_{0}=\mathcal{O}_{M}$ will be denoted by $D_{0}$. The connections $D_{m}$ and $D_{n}$ on $\mathcal{V}_{m}$ and $\mathcal{V}_{n}$ respectively together produce a holomorphic connection on $\mathcal{V}_{m} \otimes \mathcal{V}_{n}$.
Proposition 4.1. Let $M$ be a compact connected Riemann surface equipped with a projective structure $P$. Take integers $m>n \geq 0$. Then $\mathcal{V}_{m} \otimes \mathcal{V}_{n}$ has a canonical decomposition

$$
\mathcal{V}_{m} \otimes \mathcal{V}_{n}=\bigoplus_{i=0}^{n} \mathcal{V}_{m+n-2 i}
$$

The above isomorphism takes the connection on $\mathcal{V}_{m} \otimes \mathcal{V}_{n}$ induced by $D_{m}$ and $D_{n}$ to the connection $\bigoplus_{i=0}^{n} D_{m+n-2 i}$ on $\bigoplus_{i=0}^{n} \mathcal{V}_{m+n-2 i}$.

Proof. First consider the case of $X=\mathbb{P}(\mathbb{V})$ investigated in Section 2. The $\operatorname{SL}(\mathbb{V})$-module $\operatorname{Sym}^{j}(\mathbb{V})$ is irreducible for every $j \geq 0$ [FH, p. 150], and furthermore, for $m>n \geq 0$, the $\operatorname{SL}(\mathbb{V})$-module $\operatorname{Sym}^{m}(\mathbb{V}) \otimes \operatorname{Sym}^{n}(\mathbb{V})$ decomposes as

$$
\begin{equation*}
\operatorname{Sym}^{m}(\mathbb{V}) \otimes \operatorname{Sym}^{n}(\mathbb{V})=\bigoplus_{i=0}^{n} \operatorname{Sym}^{m+n-2 i}(\mathbb{V}) \tag{4.5}
\end{equation*}
$$

[FH, p. 151, Ex. 11.11].
Take a theta characteristic on $M$. Choose data $\left\{\left\{\left(U_{i}, \varphi_{i}\right)\right\}_{i \in I},\left\{\tau_{i, j}\right\}\right\}$ representing a $\mathrm{SL}(\mathbb{V})$-projective structure associated to $P$. On each $U_{i}$ we have the holomorphic vector bundles $\varphi_{i}^{*} \mathbb{V}_{j}=U_{i} \times \operatorname{Sym}^{j}(\mathbb{V})$ equipped with the trivial connection. Patching these together using $\left\{\tau_{i, j}\right\}$ as the transition functions we construct a holomorphic connection $D_{j}$ on the holomorphic vector bundle $\mathcal{V}_{j}$ for every $j \geq 0$. This connection $D_{j}$ on $\mathcal{V}_{j}$ coincides with the connection constructed in (4.4).

Now it can be shown that the isomorphism in (4.5) over each $U_{i}$ patch together compatibly to give a global holomorphic isomorphism

$$
\mathcal{V}_{m} \otimes \mathcal{V}_{n} \xrightarrow{\sim} \bigoplus_{i=0}^{n} \mathcal{V}_{m+n-2 i}
$$

over $M$. Indeed, this is an immediate consequence of the fact that the isomorphism in (4.5) intertwines the actions of $\mathrm{SL}(\mathbb{V})$. This isomorphism evidently takes the connection on $\mathcal{V}_{m} \otimes \mathcal{V}_{n}$ induced by $D_{m}$ and $D_{n}$ to the connection $\bigoplus_{i=0}^{n} D_{m+n-2 i}$ on $\bigoplus_{i=0}^{n} \mathcal{V}_{m+n-2 i}$. This completes the proof.

Henceforth, we shall assume that $\operatorname{genus}(M)=g \geq 1$. Since all the isomorphisms in Theorem 3.5 are $\operatorname{SL}(\mathbb{V})$-equivariant, the following corollary is deduced from Theorem 3.5 in a straight-forward manner.

Corollary 4.2. Let $M$ be a connected Riemann surface equipped with a projective structure $P$. If $n<0$ or $n \geq k$, then there is a canonical isomorphism

$$
J^{k}\left(\mathbf{L}^{n}\right)=\mathbf{L}^{n-k} \otimes \mathcal{V}_{k}
$$

If $k>n \geq 0$, then there is a canonical isomorphism

$$
J^{k}\left(\mathbf{L}^{n}\right)=\mathcal{V}_{n} \oplus\left(\mathbf{L}^{-(k+1)} \otimes \mathcal{V}_{k-n-1}\right)
$$

Remark 4.3. Note that Proposition 4.1, Corollary 4.2 and (4.3) together give a description of any jet bundles of the form $J^{k}\left(\mathbf{L}^{a}\right) \otimes J^{\ell}\left(\mathbf{L}^{b}\right)$ as a direct sum of vector bundles of the form $\mathcal{V}^{p} \otimes \mathbf{L}^{q}$.
4.2. Jets of vector bundles with a holomorphic connection. Let $M$ be a compact connected Riemann surface. Let $E$ be a holomorphic vector bundle on $M$ equipped with a holomorphic connection $D_{E}$. Take a holomorphic vector bundle $W$ on $M$. We will construct a holomorphic homomorphism from $J^{k}(E \otimes W)$ to $E \otimes J^{k}(W)$ for all $k \geq 0$. To construct this homomorphism, let $f_{1}, f_{2}: M \times M \longrightarrow M$ be the projections to the first and second factors respectively. The diagonal divisor

$$
\{(x, x) \mid x \in M\} \subset M \times M
$$

will be denoted by $\Delta_{M}$. Recall from (2.4) that

$$
\begin{align*}
& J^{k}(E \otimes W):=f_{1 *}\left(\left(f_{2}^{*}(E \otimes W)\right) /\left(\left(f_{2}^{*}(E \otimes W)\right) \otimes \mathcal{O}_{M \times M}\left(-(k+1) \Delta_{M}\right)\right)\right)  \tag{4.6}\\
& =f_{1 *}\left(\left(\left(f_{2}^{*} E\right) \otimes\left(f_{2}^{*} W\right)\right) /\left(\left(f_{2}^{*} E\right) \otimes\left(f_{2}^{*} W\right) \otimes \mathcal{O}_{M \times M}\left(-(k+1) \Delta_{M}\right)\right)\right) \longrightarrow M .
\end{align*}
$$

Consider the pulled back connection $f_{2}^{*} D_{E}$ on $f_{2}^{*} E$. Since the sheaf of holomorphic twoforms on $M$ is the zero sheaf, the connection $D_{E}$ is flat (the curvature vanishes identically). Hence the connection $f_{2}^{*} D_{E}$ is also flat. Therefore, on any analytic neighborhood $U$ of $\Delta_{M} \subset M \times M$ that admits a deformation retraction to $\Delta_{M}$, the two vector bundles $\left.\left(p_{1}^{*} E\right)\right|_{U}$ and $\left.\left(p_{2}^{*} E\right)\right|_{U}$ are identified using parallel translation. Invoking this isomorphism between $\left.\left(p_{1}^{*} E\right)\right|_{U}$ and $\left.\left(p_{2}^{*} E\right)\right|_{U}$, from (4.6) we have

$$
J^{k}(E \otimes W)=f_{1 *}\left(\left(\left(f_{1}^{*} E\right) \otimes\left(f_{2}^{*} W\right)\right) /\left(\left(f_{1}^{*} E\right) \otimes\left(f_{2}^{*} W\right) \otimes \mathcal{O}_{M \times M}\left(-(k+1) \Delta_{M}\right)\right)\right)
$$

Hence the projection formula gives that

$$
\begin{equation*}
J^{k}(E \otimes W)=E \otimes f_{1 *}\left(\left(f_{2}^{*} W\right) /\left(\left(f_{2}^{*} W\right) \otimes \mathcal{O}_{M \times M}\left(-(k+1) \Delta_{M}\right)\right)\right)=E \otimes J^{k}(W) \tag{4.7}
\end{equation*}
$$

Lemma 4.4. Let $M$ be a connected Riemann surface equipped with a projective structure $P$. Let $E$ be a holomorphic vector bundle on $M$ equipped with a holomorphic connection $D_{E}$. If $n<0$ or $n \geq k$, then there is a canonical isomorphism

$$
J^{k}\left(E \otimes \mathbf{L}^{n}\right)=E \otimes \mathbf{L}^{n-k} \otimes \mathcal{V}_{k}
$$

If $k>n \geq 0$, then there is a canonical isomorphism

$$
J^{k}\left(E \otimes \mathbf{L}^{n}\right)=E \otimes\left(\mathcal{V}_{n} \oplus\left(\mathbf{L}^{-(k+1)} \otimes \mathcal{V}_{k-n-1}\right)\right)
$$

Proof. This follows from (4.7) and Corollary 4.2. We omit the details.
4.3. The symbol map. As before, $M$ is a compact connected Riemann surface equipped with a projective structure $P$, and $E$ is a holomorphic vector bundle over $M$ equipped with a holomorphic connection $D_{E}$. Consider the projection

$$
\begin{equation*}
\phi_{k}: J^{k}\left(E \otimes \mathbf{L}^{n}\right) \longrightarrow J^{k-1}\left(E \otimes \mathbf{L}^{n}\right) \tag{4.8}
\end{equation*}
$$

in (2.5). We will describe $\phi_{k}$ in terms of the isomorphisms in Lemma 4.4,
4.3.1. Case where either $n<0$ or $n \geq k$. Assume that at least one of the following two conditions is valid:
(1) $n<0$, or
(2) $n \geq k$.

In view of Lemma 4.4, this implies that

$$
\begin{equation*}
J^{k}\left(E \otimes \mathbf{L}^{n}\right)=E \otimes \mathbf{L}^{n-k} \otimes \mathcal{V}_{k} \quad \text { and } \quad J^{k-1}\left(E \otimes \mathbf{L}^{n}\right)=E \otimes \mathbf{L}^{n-k+1} \otimes \mathcal{V}_{k-1} \tag{4.9}
\end{equation*}
$$

when $k \geq 1$ (note that in (4.8) we have $k \geq 1$ ). Using (4.9), the projection $\phi_{k}$ in (4.8) is a surjective homomorphism

$$
\begin{equation*}
\phi_{k}: E \otimes \mathbf{L}^{n-k} \otimes \mathcal{V}_{k} \longrightarrow E \otimes \mathbf{L}^{n-k+1} \otimes \mathcal{V}_{k-1} \tag{4.10}
\end{equation*}
$$

Recall that $\mathcal{V}_{j}=\operatorname{Sym}^{j}(\mathcal{V})$, and the line bundle $\mathbf{L}$ is a quotient of $\mathcal{V}$ (see (4.2)). Therefore, we have a natural projection

$$
\begin{equation*}
\varpi_{k}: \mathcal{V}_{k} \longrightarrow \mathbf{L} \otimes \mathcal{V}_{k-1} \tag{4.11}
\end{equation*}
$$

To describe $\varpi_{k}$ explicitly, let $q_{\mathbf{L}}: \mathcal{V} \longrightarrow \mathbf{L}$ be the quotient map. Consider the homomorphism

$$
q_{\mathbf{L}} \otimes \operatorname{Id}_{\mathcal{V} \otimes(k-1)}: \mathcal{V}^{\otimes k} \longrightarrow \mathbf{L} \otimes \mathcal{V}^{\otimes(k-1)}
$$

Note that $q_{\mathbf{L}} \otimes \operatorname{Id}_{\mathcal{V} \otimes(k-1)}$ sends the subbundle $\operatorname{Sym}^{k}(\mathcal{V}) \subset \mathcal{V}^{\otimes k}$ to the subbundle $\mathbf{L} \otimes \mathcal{V}_{k-1} \subset$ $\mathbf{L} \otimes \mathcal{V}^{\otimes(k-1)}$. The homomorphism $\varpi_{k}$ in (4.11) is this restriction of the homomorphism $q_{\mathbf{L}} \otimes \operatorname{Id}_{\mathcal{V} \otimes(k-1)}$.
Proposition 4.5. The homomorphism $\phi_{k}$ in (4.10) coincides with $\operatorname{Id} \otimes \varpi_{k}$, where Id denotes the identity map of $E \otimes \mathbf{L}^{n-k}$, and $\varpi_{k}$ is the homomorphism in (4.11).

Proof. This follows from Proposition 3.1 and Proposition 3.2.
Consider the inclusion homomorphism $\iota_{\mathcal{L}}: \mathcal{L} \hookrightarrow \mathcal{V}$ (see (4.2)). We have the subbundle

$$
\iota^{\prime}:=\operatorname{Id}_{E} \otimes \iota_{\mathcal{L}}^{\otimes k}: E \otimes \mathcal{L}^{\otimes k} \hookrightarrow E \otimes \operatorname{Sym}^{k}(\mathcal{V})=E \otimes \mathcal{V}_{k}
$$

Using the isomorphism $\mathbf{L}=\mathcal{L}^{*}$ in (4.3), the above homomorphism $\iota^{\prime}$ produces a homomorphism

$$
\begin{equation*}
\tau:=\iota^{\prime} \otimes \operatorname{Id}_{\mathbf{L}^{n-k}}: E \otimes \mathbf{L}^{n-2 k}=E \otimes \mathcal{L}^{\otimes k} \otimes \mathbf{L}^{n-k} \hookrightarrow E \otimes \mathcal{V}_{k} \otimes \mathbf{L}^{n-k} \tag{4.12}
\end{equation*}
$$

The following is an immediate consequence of Proposition 4.5.
Corollary 4.6. The kernel of the surjective homomorphism $\phi_{k}$ in (4.10) coincides with the subbundle $E \otimes \mathbf{L}^{n-2 k} \hookrightarrow E \otimes \mathcal{V}_{k} \otimes \mathbf{L}^{n-k}$ given by the image of the homomorphism $\widetilde{\iota}$ in (4.12).

Let $F$ be any holomorphic vector bundle on $M$. Using (2.6) and (4.9), we have

$$
\begin{equation*}
\operatorname{Diff}_{M}^{k}\left(E \otimes \mathbf{L}^{n}, F\right)=F \otimes\left(E \otimes \mathbf{L}^{n-k} \otimes \mathcal{V}_{k}\right)^{*}=F \otimes \mathbf{L}^{k-n} \otimes\left(E \otimes \mathcal{V}_{k}\right)^{*} \tag{4.13}
\end{equation*}
$$

Using the homomorphism $\tau$ in (4.12) construct the homomorphism

$$
\begin{equation*}
\operatorname{Id}_{F} \otimes \widetilde{\imath}^{*}: F \otimes\left(E \otimes \mathcal{V}_{k} \otimes \mathbf{L}^{n-k}\right)^{*} \longrightarrow F \otimes\left(E \otimes \mathbf{L}^{n-2 k}\right)^{*}=\operatorname{Hom}(E, F) \otimes \mathbf{L}^{2 k-n} \tag{4.14}
\end{equation*}
$$

Combining (4.13) and (4.14), we have a surjective homomorphism

$$
\sigma_{k}: \operatorname{Diff}_{M}^{k}\left(E \otimes \mathbf{L}^{n}, F\right) \longrightarrow \operatorname{Hom}(E, F) \otimes \mathbf{L}^{2 k-n}
$$

The following is an immediate consequence of Corollary 4.6.
Corollary 4.7. The symbol homomorphism

$$
\operatorname{Diff}_{M}^{k}\left(E \otimes \mathbf{L}^{n}, F\right) \longrightarrow \operatorname{Hom}\left(E \otimes \mathbf{L}^{n}, F\right) \otimes(T M)^{\otimes k}
$$

in (2.7) coincides with the above homomorphism $\sigma_{k}$ after $T M$ is identified with $\mathbf{L}^{\otimes 2}$ as in (4.3).
4.3.2. Case where $k>n \geq 0$. We first assume that $k-1>n \geq 0$. Therefore, from Lemma 4.4 we have $J^{k}\left(E \otimes \mathbf{L}^{n}\right)=E \otimes\left(\mathcal{V}_{n} \oplus\left(\mathbf{L}^{-(k+1)} \otimes \mathcal{V}_{k-n-1}\right)\right)$ and

$$
J^{k-1}\left(E \otimes \mathbf{L}^{n}\right)=E \otimes\left(\mathcal{V}_{n} \oplus\left(\mathbf{L}^{-k} \otimes \mathcal{V}_{k-n-2}\right)\right)
$$

Let

$$
\begin{gather*}
\phi_{k}: E \otimes\left(\mathcal{V}_{n} \oplus\left(\mathbf{L}^{-(k+1)} \otimes \mathcal{V}_{k-n-1}\right)\right)=J^{k}\left(E \otimes \mathbf{L}^{n}\right)  \tag{4.15}\\
\longrightarrow J^{k-1}\left(E \otimes \mathbf{L}^{n}\right)=E \otimes\left(\mathcal{V}_{n} \oplus\left(\mathbf{L}^{-k} \otimes \mathcal{V}_{k-n-2}\right)\right)
\end{gather*}
$$

be the projection in (2.5). Just as the homomorphism $\operatorname{Id} \otimes \varpi_{k}$ in Proposition 4.5, we have a homomorphism

$$
\widehat{\varpi}_{k}: E \otimes \mathbf{L}^{-(k+1)} \otimes \mathcal{V}_{k-n-1} \longrightarrow E \otimes \mathbf{L}^{-k} \otimes \mathcal{V}_{k-n-2}
$$

Lemma 4.8. The homomorphism $\phi_{k}$ in (4.15) coincides with the homomorphism

$$
\operatorname{Id}_{E \otimes \mathcal{V}_{n}} \oplus \widehat{\varpi}_{k}: E \otimes\left(\mathcal{V}_{n} \oplus\left(\mathbf{L}^{-(k+1)} \otimes \mathcal{V}_{k-n-1}\right)\right) \longrightarrow E \otimes\left(\mathcal{V}_{n} \oplus\left(\mathbf{L}^{-k} \otimes \mathcal{V}_{k-n-2}\right)\right)
$$

Proof. This follows from Proposition 3.4.
Note that using (4.3),

$$
\operatorname{kernel}\left(\widehat{\varpi}_{k}\right)=E \otimes \mathbf{L}^{-(k+1)} \otimes \mathcal{L}^{\otimes(k-n-1)}=E \otimes K_{M}^{\otimes k} \mathbf{L}^{n}
$$

The following is an immediate consequence of Lemma 4.8.
Corollary 4.9. Let $F$ be any holomorphic vector bundle on $M$. The symbol homomorphism

$$
\operatorname{Diff}_{M}^{k}\left(E \otimes \mathbf{L}^{n}, F\right) \longrightarrow \operatorname{Hom}\left(E \otimes \mathbf{L}^{n}, F\right) \otimes(T M)^{\otimes k}
$$

coincides with $\operatorname{Id}_{F} \otimes \iota^{*}$, where $\iota: \operatorname{kernel}\left(\widehat{\varpi}_{k}\right) \hookrightarrow E \otimes \mathbf{L}^{-(k+1)} \otimes \mathcal{V}_{k-n-1}$ is the inclusion map.

We now assume that $k-1=n \geq 0$.
Under this assumption, from Lemma 4.4 we have

$$
J^{k}\left(E \otimes \mathbf{L}^{n}\right)=E \otimes\left(\mathcal{V}_{n} \oplus \mathbf{L}^{-(k+1)}\right) \quad \text { and } \quad J^{k-1}\left(E \otimes \mathbf{L}^{n}\right)=E \otimes \mathcal{V}_{n}
$$

Let

$$
\begin{equation*}
\phi_{k}: E \otimes\left(\mathcal{V}_{n} \oplus \mathbf{L}^{-(k+1)}\right)=J^{k}\left(E \otimes \mathbf{L}^{n}\right) \longrightarrow J^{k-1}\left(E \otimes \mathbf{L}^{n}\right)=E \otimes \mathcal{V}_{n} \tag{4.16}
\end{equation*}
$$

be the projection in (2.5).
Lemma 4.10. The homomorphism $\phi_{k}$ in (4.16) coincides with the projection

$$
E \otimes\left(\mathcal{V}_{n} \oplus \mathbf{L}^{-(k+1)}\right) \longrightarrow E \otimes \mathcal{V}_{n}
$$

to the first factor.
Proof. This follows from Proposition 3.4.

The following is an immediate consequence of Lemma 4.10.
Corollary 4.11. Let $F$ be any holomorphic vector bundle on $M$. The symbol homomorphism

$$
\operatorname{Diff}_{M}^{k}\left(E \otimes \mathbf{L}^{n}, F\right) \longrightarrow \operatorname{Hom}\left(E \otimes \mathbf{L}^{n}, F\right) \otimes(T M)^{\otimes k}
$$

coincides with $\operatorname{Id}_{F} \otimes p^{\prime}$, where

$$
p^{\prime}: E^{*} \otimes\left(\mathcal{V}_{n} \oplus \mathbf{L}^{-(k+1)}\right)^{*} \longrightarrow E^{*} \otimes\left(\mathbf{L}^{-(k+1)}\right)^{*}
$$

is the natural projection.

## 5. Lifting of Symbol

As before, $M$ is a connected Riemann surface equipped with a projective structure $P$, and $E$ is a holomorphic vector bundle on $M$ equipped with a holomorphic connection $D_{E}$. The connection $D_{E}$ on $E$ induces a holomorphic connection on $\operatorname{End}(E)$. This induced connection on $\operatorname{End}(E)$ will be denoted by $\mathcal{D}_{E}$.

Take integers $k, n$ and $l$ such that at least one of the following two conditions is valid:
(1) $n<0$, or
(2) $n, l \geq k$.

Let

$$
\begin{equation*}
\theta_{0} \in H^{0}\left(M, \operatorname{End}(E) \otimes \mathbf{L}^{l}\right) \tag{5.1}
\end{equation*}
$$

be a holomorphic section. Note that $\theta_{0}$ defines a section

$$
\theta \in H^{0}\left(M, J^{k}\left(\operatorname{End}(E) \otimes \mathbf{L}^{l}\right)\right)
$$

Recall that $D_{E}$ induces a holomorphic connection $\mathcal{D}_{E}$ on $\operatorname{End}(E)$. In view of this connection, Lemma 4.4 says that $J^{k}\left(\operatorname{End}(E) \otimes \mathbf{L}^{l}\right)=\operatorname{End}(E) \otimes \mathbf{L}^{l-k} \otimes \mathcal{V}_{k}$. So, we have

$$
\begin{equation*}
\theta \in H^{0}\left(M, \operatorname{End}(E) \otimes \mathbf{L}^{l-k} \otimes \mathcal{V}_{k}\right) \tag{5.2}
\end{equation*}
$$

Recall from Lemma 4.4 that $J^{k}\left(E \otimes \mathbf{L}^{n}\right)=E \otimes \mathbf{L}^{n-k} \otimes \mathcal{V}_{k}$. Let

$$
\mathcal{T}_{\theta}^{0}: J^{k}\left(E \otimes \mathbf{L}^{n}\right)=E \otimes \mathbf{L}^{n-k} \otimes \mathcal{V}_{k} \longrightarrow E \otimes \mathbf{L}^{l+n-2 k} \otimes \mathcal{V}_{k} \otimes \mathcal{V}_{k}
$$

be the homomorphism defined by $a \otimes b \longmapsto \sum_{i}\left(a_{i}^{\prime}(a) \otimes b \otimes b_{i}^{\prime}\right)$, where $a$ and $b$ are local sections of $E$ and $\mathbf{L}^{n-k} \otimes \mathcal{V}_{k}$ respectively, while $\theta$ in (5.2) is locally expressed as $\sum_{i} a_{i}^{\prime} \otimes b_{i}^{\prime}$ with $a_{i}^{\prime}$ and $b_{i}^{\prime}$ being local sections of $\operatorname{End}(E)$ and $\mathbf{L}^{l-k} \otimes \mathcal{V}_{k}$ respectively. Let

$$
p_{0}: \mathcal{V}_{k} \otimes \mathcal{V}_{k} \longrightarrow, \mathcal{V}_{0}=\mathcal{O}_{M}
$$

be the projection constructed using the decomposition in Proposition 4.1. Now define the homomorphism

$$
\begin{equation*}
\mathcal{T}_{\theta}:=\left(\operatorname{Id} \otimes p_{0}\right) \circ \mathcal{T}_{\theta}^{0}: J^{k}\left(E \otimes \mathbf{L}^{n}\right)=E \otimes \mathbf{L}^{n-k} \otimes \mathcal{V}_{k} \longrightarrow E \otimes \mathbf{L}^{l+n-2 k} \tag{5.3}
\end{equation*}
$$

where Id denotes the identity map of $E \otimes \mathbf{L}^{l+n-2 k}$. Therefore, we have

$$
\begin{equation*}
\mathcal{T}_{\theta} \in H^{0}\left(M, \operatorname{Diff}^{k}\left(E \otimes \mathbf{L}^{n}, E \otimes \mathbf{L}^{l+n-2 k}\right)\right) \tag{5.4}
\end{equation*}
$$

(see (2.6)). Let

$$
\widehat{\sigma}: \operatorname{Diff}^{k}\left(E \otimes \mathbf{L}^{n}, E \otimes \mathbf{L}^{l+n-2 k}\right) \longrightarrow \operatorname{End}(E) \otimes \mathbf{L}^{l-2 k} \otimes(T M)^{\otimes k}=\operatorname{End}(E) \otimes \mathbf{L}^{l}
$$ be the symbol homomorphism in (2.7); in (4.3) it was shown that $T M=\mathbf{L}^{\otimes 2}$.

Theorem 5.1. The symbol $\widehat{\sigma}\left(\mathcal{T}_{\theta}\right)$ of the differential operator $\mathcal{T}_{\theta}$ in (5.4) is the section $\theta_{0}$ in (5.1).

Proof. This theorem can be derived from Corollary 4.7) that describes the symbol. The following is needed to derive the theorem from Corollary 4.7 ,

Consider the decomposition of the $\mathrm{SL}(\mathbb{V})$-module

$$
\operatorname{Sym}^{m}(\mathbb{V}) \otimes \operatorname{Sym}^{m}(\mathbb{V})=\bigoplus_{i=0}^{m} \operatorname{Sym}^{2(m-i)}(\mathbb{V})
$$

in (4.5). Let

$$
f: \operatorname{Sym}^{m}(\mathbb{V}) \otimes \operatorname{Sym}^{m}(\mathbb{V}) \longrightarrow \operatorname{Sym}^{0}(\mathbb{V})=\mathbb{C}
$$

be the projection constructed using this decomposition (by setting $i=m$ in the decomposition). Then for any line $L_{0} \subset \mathbb{V}$, we have

$$
f\left(\left(L_{0}^{\otimes m}\right) \otimes\left(L_{0} \otimes \operatorname{Sym}^{m-1}(\mathbb{V})\right)\right)=0
$$

so $f$ produces a homomorphism

$$
\widehat{f}:\left(L_{0}^{\otimes m}\right) \otimes\left(\left(\operatorname{Sym}^{m}(\mathbb{V})\right) /\left(L_{0} \otimes \operatorname{Sym}^{m-1}(\mathbb{V})\right)\right)=\left(L_{0}^{\otimes m}\right) \otimes\left(\mathbb{V} / L_{0}\right)^{\otimes m} \longrightarrow \mathbb{C} .
$$

This homomorphism $\widehat{f}$ sends $v^{\otimes m} \otimes u^{\otimes m}$, where $v \in L_{0}$ and $u \in \mathbb{V} / L_{0}$, to $\lambda^{m} \in \mathbb{C}$ that satisfies the equation

$$
v \wedge u=\lambda \cdot \omega,
$$

where $\omega$ is the fixed element in (3.4); note that $v \wedge u$ is a well-defined element of $\bigwedge^{2} \mathbb{V}$. The theorem follows from this observation and Corollary 4.7.

Remark 5.2. It may be mentioned that symbols do not always lift to a holomorphic differential operator. For such an example, set the symbol to be the constant function 1. It does not lift to a first order holomorphic differential operator from $\mathcal{L}^{n}$ to $\mathcal{L}^{n} \otimes K_{M}$ if $g \geq 2$ and $n \neq 0$. Indeed, a first order holomorphic differential operator from $\mathcal{L}^{n}$ to $\mathcal{L}^{n} \otimes K_{M}$ with symbol 1 is a holomorphic connection on $\mathcal{L}^{n}$. But $\mathcal{L}^{n}$ does not admit a holomorphic connection because its degree is nonzero.
