# ON THE DIAMETERS OF MCKAY GRAPHS FOR FINITE SIMPLE GROUPS

#### Abstract

Let $G$ be a finite group, and $\alpha$ a nontrivial character of $G$. The McKay graph $\mathcal{M}(G, \alpha)$ has the irreducible characters of $G$ as vertices, with an edge from $\chi_{1}$ to $\chi_{2}$ if $\chi_{2}$ is a constituent of $\alpha \chi_{1}$. We study the diameters of McKay graphs for simple groups $G$. For $G$ a group of Lie type, we show that for any $\alpha$, the diameter is bounded by a quadratic function of the rank, and obtain much stronger bounds for $G=\operatorname{PSL}_{n}(q)$ or $\operatorname{PSU}_{n}(q)$. We also bound the diameter for symmetric and alternating groups.


## 1. Introduction

For a finite group $G$, and a (complex) character $\alpha$ of $G$, the McKay graph $\mathcal{M}(G, \alpha)$ is defined to be the directed graph with vertex set $\operatorname{Irr}(G)$, there being an edge from $\chi_{1}$ to $\chi_{2}$ if and only if $\chi_{2}$ is a constituent of $\alpha \chi_{1}$. The famous McKay correspondence [10] shows that if $G$ is a finite subgroup of $\mathrm{SU}_{2}(\mathbb{C})$ and $\alpha$ is the corresponding 2-dimensional character of $G$, then $\mathcal{M}(G, \alpha)$ is an affine Dynkin diagram of type $A, D$ or $E$. The purpose of this paper is to initiate the study of McKay graphs for simple groups, focussing particularly on their diameters.

By a classical result of Burnside and Brauer [2], $\mathcal{M}(G, \alpha)$ is connected if and only if $\alpha$ is faithful, and moreover in this case an upper bound for the diameter $\operatorname{diam} \mathcal{M}(G, \alpha)$ is given by $N-1$, where $N$ is the number of distinct values of $\alpha$. (Indeed, in this case $\sum_{j=0}^{N-1} \alpha^{j}$ contains every irreducible character of $G$. Taking $\beta$ to be an irreducible constituent of $\bar{\chi}_{1} \chi_{2}$, we can find $0 \leq j \leq N-1$ such that

$$
0<\left[\alpha^{j}, \beta\right]_{G} \leq\left[\alpha^{j}, \bar{\chi}_{1} \chi_{2}\right]_{G}=\left[\alpha^{j} \chi_{1}, \chi_{2}\right]_{G},
$$

i.e. a directed path of length $j$ connects $\chi_{1}$ to $\chi_{2}$.)

An obvious lower bound for $\operatorname{diam} \mathcal{M}(G, \alpha)($ when $\alpha(1)>1)$ is given by $\frac{\log \mathrm{b}(G)}{\log \alpha(1)}$, where $\mathrm{b}(G)$ is the largest degree of an irreducible character of $G$. One can do slightly better, by observing that if $d:=\operatorname{diam}(M, \alpha)$, then

$$
2 \alpha(1)^{d}>\sum_{i=0}^{d} \alpha(1)^{i} \geq \sum_{\chi \in \operatorname{Irr}(G)} \chi(1)>\left(\sum_{\chi \in \operatorname{Irr}(G)} \chi(1)^{2}\right)^{1 / 2}=|G|^{1 / 2} .
$$

It follows that

$$
\operatorname{diam} \mathcal{M}(G, \alpha) \geq \frac{1}{2} \frac{\log (|G| / 4)}{\log \alpha(1)}
$$

This bound is far from tight for many groups $G$. However, for finite simple groups we make the following conjecture.

[^0]Conjecture 1. There is an absolute constant $C$ such that for any finite non-abelian simple group $G$, and any nontrivial irreducible character $\alpha$ of $G$,

$$
\operatorname{diam} \mathcal{M}(G, \alpha) \leq C \frac{\log |G|}{\log \alpha(1)}
$$

Note that [8] gives the analogous bound for conjugacy classes: namely, for a nontrivial conjugacy class $S$ of a finite (non-abelian) simple group $G$, we have $\operatorname{diam} \Gamma(G, S) \leq C \frac{\log |G|}{\log |S|}$, where $\Gamma(G, S)$ is the Cayley graph of $G$ with respect to $S$.

In general, Conjecture 1 cannot hold for arbitrary faithful character of $G$. However, once it holds for faithful irreducible characters, then it also holds for all faithful multiplicity-free characters, albeit with a different constant $C$. To see this, note that Theorem 1.1 of [9] implies that the number $r_{m}(G)$ of irreducible characters of degree $m$ of a non-abelian finite simple group $G$ satisfies $r_{m}(G)=o\left(m^{1+\epsilon}\right)$ for any fixed $\epsilon>0$. This implies that $G$ has at most $m^{c}$ irreducible characters of degree at most $m$, where $c$ is an absolute constant. Now let $\beta$ be a faithful multiplicity-free character of $G$, and let $\alpha$ be an irreducible constituent of $\beta$ of maximal degree. Then $\beta(1) \leq \alpha(1)^{c+1}$, so assuming Conjecture 1 we obtain

$$
\operatorname{diam} \mathcal{M}(G, \beta) \leq \operatorname{diam} \mathcal{M}(G, \alpha) \leq C \frac{\log |G|}{\log \alpha(1)} \leq C(c+1) \frac{\log |G|}{\log \beta(1)}
$$

In this paper we prove Conjecture 1 for many families of simple groups of Lie type.
Theorem 2. There is an absolute constant $C$ such that $\operatorname{diam} \mathcal{M}(G, \alpha) \leq C r^{2}$ for any finite simple group $G$ of Lie type of rank $r$ and any nontrivial irreducible character $\alpha$ of G. Hence Conjecture 1 holds for simple groups of Lie type of bounded rank.

Our proof of Theorem 2 shows that in fact one can take $C=489$.
For classical groups of unbounded rank, we are able to handle the projective special linear and unitary groups $\mathrm{PSL}_{n}^{\epsilon}(q)$ (with $\mathrm{PSL}^{+}=\mathrm{PSL}$ and $\mathrm{PSL}^{-}=\mathrm{PSU}$ ), where $q$ is large compared to $n$. The proof uses major new advances in the theory of character ratios, taken from [1, 11].

Theorem 3. There exist an absolute constant $C$ and a function $g: \mathbb{N} \rightarrow \mathbb{N}$ such that the following holds. If $G=\operatorname{PSL}_{n}^{\epsilon}(q)$ with $n \geq 2, \epsilon= \pm$, and $q>g(n)$, then

$$
\operatorname{diam} \mathcal{M}(G, \alpha)<C \frac{\log |G|}{\log \alpha(1)}
$$

for all nontrivial irreducible characters $\alpha$ of $G$.
As one can see from our proof, $C$ can be taken to be 15 , and $g$ can also be made explicit. Theorem 3 gives rise to the following extension.

Corollary 4. With the function $g(n)$ and $C$ as in Theorem 3, we have

$$
\operatorname{diam} \mathcal{M}(G, \alpha)<2.5 C \frac{\log |G|}{\log \alpha(1)}
$$

for any simple group $G=\operatorname{PSL}_{n}^{\epsilon}(q)$ with $n \geq 2, \epsilon= \pm, q>\max \{g(n), 11\}$, and for any faithful multiplicity-free character $\alpha$ of $G$.

For other types of classical groups of unbounded ranks, we have not yet been able to prove the conjecture, but we do have results bounding the diameter by a linear function of the rank; these will appear in a forthcoming paper.

For alternating (and symmetric) groups, the conjecture is wide open. However we are able to establish the following bound.

Theorem 5. Let $n \geq 5$ and let $G=\mathrm{A}_{n}$ or $\mathrm{S}_{n}$. Then for any faithful irreducible character $\alpha$ of $G$, we have $\operatorname{diam} \mathcal{M}(G, \alpha) \leq 4 n-4$.

This bound is essentially best possible (up to the multiplicative constant); it confirms Conjecture 1 for faithful irreducible characters $\alpha$ of $G=\mathrm{A}_{n}, \mathrm{~S}_{n}$ of polynomial degree, namely $\alpha(1)=O\left(n^{O(1)}\right)$. It also follows immediately that Theorems 2 and 5 extend to all faithful multiplicity-free characters $\alpha$ of $G$.

This paper is organized as follows. In Section 2 we prove Theorem 2. Section 3 is devoted to the proof of Theorem 3 and Corollary 4, using new developments in character bounds (see [1, 11]). Theorem 5 is proved in Section 4, and in Section 5 we briefly discuss the diameter of McKay graphs for quasi-simple groups.

## 2. Preliminaries and groups of bounded rank

Our proof uses the following results, taken from [6] and [5].
Proposition 2.1. Let $G$ be a finite simple group of Lie type, and let St denote the Steinberg character of $G$. Then provided $G$ is not a unitary group in odd dimension, $\mathrm{St}^{2}$ contains every irreducible character of $G$ as a constituent. In all cases, $\mathrm{St}^{3}$ contains every irreducible character.

Proof. The first statement is [6, Theorem 1.2]. Consider the exceptional case $G=$ $\operatorname{PSU}_{n}(q)$ with $2 \nmid n \geq 3$. Then, again by [6, Theorem 1.2], $\mathrm{St}^{2}$ contains all $\chi \in \operatorname{Irr}(G)$ but the unique unipotent character $\alpha$ of degree $\left(q^{n}-q\right) /(q+1)$. Let $\chi \in \operatorname{Irr}(G)$ and suppose that $\mathrm{St} \cdot \bar{\chi}$ is a multiple of $\alpha$ :

$$
\text { St } \cdot \bar{\chi}=k \alpha
$$

for some $k \in \mathbb{Z}$. Then $k=\operatorname{St}(1) \chi(1) / \alpha(1) \neq 0$, and so $\alpha(t)=\operatorname{St}(t) \cdot \bar{\chi}(t) / k=0$ for any transvection $t \in G$. However, $\alpha(t)=-\left(q^{n}-q(-1)^{n}\right) /(q+1) \neq 0$ by [13, Lemma 4.1], a contradiction. Hence $\mathrm{St} \cdot \bar{\chi}$ contains some character $\beta \in \operatorname{Irr}(G) \backslash\{\alpha\}$. It follows that

$$
0<[\mathrm{St} \cdot \bar{\chi}, \beta]_{G} \leq\left[\mathrm{St} \cdot \bar{\chi}, \mathrm{St}^{2}\right]_{G}=\left[\mathrm{St}^{3}, \chi\right]_{G}
$$

i.e. $\chi$ is an irreducible constituent of $\mathrm{St}^{3}$.

A similar argument as above shows that $\mathrm{St}^{3}$ contains all irreducible characters of $G$, for any simple group $G$ of Lie type.

Proposition 2.2. [5] Let $G$ be a finite simple group of Lie type over $\mathbb{F}_{q}$, and let $1 \neq g \in G$. Then for any $\chi \in \operatorname{Irr}(G)$,

$$
\frac{|\chi(g)|}{\chi(1)} \leq \min \left(\frac{3}{\sqrt{q}}, \frac{19}{20}\right)
$$

We can now prove Theorem 2. Let $G$ be a simple group of Lie type over a field $\mathbb{F}_{q}$ (of characteristic $p$ ) of rank $r$, and let $G_{\mathrm{SS}}$ denote the set of semisimple elements of $G$. Recall (see $[3,6.4 .7]$ ) that the values of the Steinberg character St are

$$
\operatorname{St}(g)=\left\{\begin{array}{l}
\epsilon_{g}\left|\mathbf{C}_{G}(g)\right|_{p}, \text { if } g \in G_{\mathrm{SS}},  \tag{2.1}\\
0, \text { if } g \notin G_{\mathrm{sS}},
\end{array}\right.
$$

where $\epsilon_{g}= \pm 1$.
Lemma 2.3. There is an absolute constant $D$ such that for any $l \geq D r^{2}$ and any $\chi \in$ $\operatorname{Irr}(G)$, we have $\left[\chi^{l}, \mathrm{St}\right]_{G} \neq 0$. Indeed, $D=163$ suffices.

Proof. By (2.1),

$$
\begin{align*}
{\left[\chi^{l}, \mathrm{St}\right]_{G} } & =\frac{1}{|G|} \sum_{g \in G_{\mathrm{ss}}} \epsilon_{g} \chi^{l}(g)\left|\mathbf{C}_{G}(g)\right|_{p} \\
& =\frac{\chi^{l}(1)}{|G|}\left(|G|_{p}+\sum_{l \neq g \in G_{\mathrm{ss}}} \epsilon_{g}\left(\frac{\chi(g)}{\chi(1)}\right)^{l}\left|\mathbf{C}_{G}(g)\right|_{p}\right) . \tag{2.2}
\end{align*}
$$

Hence $\left[\chi^{l}, \mathrm{St}\right]_{G} \neq 0$ provided $\Sigma_{l}<|G|_{p}$, where

$$
\Sigma_{l}:=\sum_{1 \neq g \in G_{\mathrm{ss}}}\left|\frac{\chi(g)}{\chi(1)}\right|^{l}\left|\mathbf{C}_{G}(g)\right|_{p}
$$

Note that $|G|<q^{4 r^{2}}$. Assume first that $q>9$. Then Proposition 2.2 implies that $\Sigma_{l}<|G|_{p}$ provided $q^{4 r^{2}} \cdot\left(3 / q^{1 / 2}\right)^{l}<1$, which holds if $l \geq 96 r^{2}$. For $q \leq 9$ we need $q^{4 r^{2}} \cdot(19 / 20)^{l}<1$, and this holds when $l \geq 163 r^{2}$.

Now let $1 \neq \alpha \in \operatorname{Irr}(G)$. It follows from Lemma 2.3 and Proposition 2.1 that $\alpha^{3 D r^{2}}$ contains all irreducible characters of $G$. Hence, given any two $\chi_{1}, \chi_{2} \in \operatorname{Irr}(G)$,

$$
0 \neq\left[\alpha^{3 D r^{2}}, \bar{\chi}_{1} \chi_{2}\right]_{G}=\left[\alpha^{3 D r^{2}} \chi_{1}, \chi_{2}\right]_{G}
$$

i.e. a directed path of length $\leq 3 D r^{2}$ connects $\chi_{1}$ to $\chi_{2}$ in $\mathcal{M}(G, \alpha)$. We conclude that $\operatorname{diam} \mathcal{M}(G, \alpha) \leq 3 D r^{2}$, completing the proof of Theorem 2 .

## 3. Projective special Linear and unitary groups

Throughout this section, which is devoted to prove Theorem 3, let $G=\operatorname{PSL}_{n}^{\epsilon}(q)$ with $\epsilon= \pm$. For a semisimple element $g \in G_{\mathrm{sS}}$, let $\hat{g}$ be a preimage of $g$ in $\mathrm{SL}_{n}^{\epsilon}(q)$, and define $\nu(g)=\operatorname{supp}(\hat{g})$, the codimension of the largest eigenspace of $\hat{g}$ over $\overline{\mathbb{F}}_{q}$.

We shall need the following bound for character ratios of semisimple elements, which follows from the deep results in $[1,11]$.

Theorem 3.1. There is a function $f: \mathbb{N} \rightarrow \mathbb{N}$ such that for any $g \in G_{\text {ss }}$ with $s=\nu(g)$, and any $\chi \in \operatorname{Irr}(G)$, we have

$$
|\chi(g)|<f(n) \chi(1)^{1-\frac{s}{n}}
$$

Proof. Let $\mathcal{G}=\mathrm{SL}_{n}(K), K=\overline{\mathbb{F}}_{q}$ be the ambient algebraic group with $G=\mathcal{G}^{F} / \mathbf{Z}\left(\mathcal{G}^{F}\right)$, where $F$ is a Frobenius endomorphism. Then $\mathbf{C}_{\mathcal{G}}(\hat{g})=\mathcal{L}:=\tilde{\mathcal{L}} \cap \mathcal{G}$, where $\tilde{\mathcal{L}}=\prod_{i=1}^{m} \mathrm{GL}_{n_{i}}(K)$, $1 \leq n_{1} \leq \cdots \leq n_{m}$, and $\sum_{i=1}^{m} n_{i}=n$. Note that $\nu(g)=s=n-n_{m}$; and that $\mathcal{L}$ is $F$-stable (but not necessarily split).

We now apply [11, Cor. 1.11(c)] (which is an extension of [1, Thm. 1.1]). That gives a function $f: \mathbb{N} \rightarrow \mathbb{N}$ such that for any $\chi \in \operatorname{Irr}(G)$,

$$
|\chi(g)|<f(n) \chi(1)^{\alpha(\mathcal{L})}
$$

where $\alpha(\mathcal{L})$ is the maximum value of $\frac{\operatorname{dim} u^{\mathcal{L}}}{\operatorname{dim} u^{\mathcal{G}}}$ over nontrivial unipotent elements $u \in \mathcal{L}$ (and $\alpha(\mathcal{L})=0$ if $\mathcal{L}$ is a torus). Note that the function $f(n)$ can be chosen to be explicit; an explicit choice for $f(n)$ is given in $[11,1.28]$ with the main term of $(n!)^{5 / 2}$. Although this choice may seem to be inflated, it is noted in [1, Remark 1.2 (iii)] that any choice of $f(n)$ should be at least $\mathrm{b}\left(\mathrm{S}_{n}\right)>e^{-1.3 \sqrt{n}} \sqrt{n!}$.

Let $\tilde{\mathcal{G}}=\operatorname{GL}_{n}(K)$ and let $\alpha(\tilde{\mathcal{L}})$ be the maximum value of $\frac{\operatorname{dim} u^{\tilde{\mathcal{L}}}}{\operatorname{dim} u^{\tilde{\mathcal{G}}}}$ over nontrivial unipotent elements $u \in \tilde{\mathcal{L}}(\tilde{\mathcal{L}}$ and $\alpha(\tilde{\mathcal{L}})=0$ if $\tilde{\mathcal{L}}$ is a torus). It is easy to see that $\alpha(\mathcal{L})=\alpha(\tilde{\mathcal{L}})$. Furthermore, $\alpha(\tilde{\mathcal{L}}) \leq \frac{n_{m}}{n}$ by [1, Thm. 1.10]. (Note that this bound is only stated for $\mathrm{GL}_{n}(q)$ in [1, Theorem 1.10], but its proof applies to bound $\alpha(\tilde{\mathcal{L}})$ for any proper Levi subgroup $\tilde{\mathcal{L}}$ of the algebraic group $\tilde{\mathcal{G}}$.) Hence $\alpha(L) \leq \frac{n-s}{n}$, and the conclusion follows.

The next lemma gives some properties of elements of $G$ of support $s$.
Lemma 3.2. For $1 \leq s<n$, define $N_{s}(G)=\left\{g \in G_{\mathrm{ss}}: \nu(g)=s\right\}$ and let $n_{s}(G):=$ $\left|N_{s}(G)\right|$.
(i) If $g \in N_{s}(g)$ and $s<\frac{n}{2}$ then $\left|\mathbf{C}_{G}(g)\right|_{p}<q^{\frac{1}{2} n^{2}+s^{2}-n s}$.
(ii) If $g \in N_{s}(g)$ and $s \geq \frac{n}{2}$ then $\left|\mathbf{C}_{G}(g)\right|_{p}<q^{\frac{1}{2}\left(n^{2}-n s\right)}$.
(iii) $\sum_{n-1 \geq s \geq n / 2} n_{s}(G)<|G|<q^{n^{2}-1}$.
(iv) If $s<n / 2$, then $n_{s}(G)<c q^{s(2 n-s)+n-1}$, where $c$ is an absolute constant that can be taken to be 44.1.

Proof. (i) Let $g \in N_{s}(G)$ with $s<\frac{n}{2}$. Then $\hat{g}=\operatorname{diag}\left(\lambda I_{n-s}, X\right)$ for some $\lambda \in \mathbb{F}_{q^{u}}^{*}$ (where $u=1$ if $\epsilon=+$ and $u=2$ if $\epsilon=-$ ) and a suitable $s \times s$-matrix $X$, and one can see that

$$
\begin{equation*}
\operatorname{GL}_{n-s}^{\epsilon}(q) \leq \mathbf{C}_{\mathrm{GL}_{n}(q)}(\hat{g}) \leq \mathrm{GL}_{n-s}^{\epsilon}(q) \times \mathrm{GL}_{s}^{\epsilon}(q) . \tag{3.1}
\end{equation*}
$$

Now the statement follows, since $\left|\mathbf{C}_{G}(g)\right|_{p} \leq\left|\mathbf{C}_{\mathrm{GL}_{n}^{\epsilon}(q)}(\hat{g})\right|_{p}$.
(ii) Let $g \in N_{s}(G)$ with $s \geq \frac{n}{2}$. Then

$$
\mathbf{C}_{\mathrm{GL}_{n}^{\epsilon}(q)}(\hat{g})=\prod_{i=1}^{t} \mathrm{GL}_{d_{i}}^{\epsilon_{i}}\left(q^{k_{i}}\right),
$$

where $n-s=d_{1} \geq d_{2} \geq \ldots \geq d_{t} \geq 1$ and $\sum_{i=1}^{t} d_{i} k_{i}=n$. Hence, $\left|\mathbf{C}_{\mathrm{GL}_{n}^{\epsilon}(q)}(\hat{g})\right|_{p}=q^{D}$, where

$$
D:=\sum_{i=1}^{t} k_{i} d_{i}\left(d_{i}-1\right) / 2=\left(\sum_{i=1}^{t} k_{i} d_{i}^{2}-n\right) / 2 .
$$

Using the obvious inequality $x^{2}+y^{2}<(x+1)^{2}+(y-1)^{2}$ when $x \geq y$, we observe that, over all $m$-tuples ( $x_{1} \geq x_{2} \geq \ldots \geq x_{m}$ ) of integers $0 \leq x_{i} \leq d_{1}$ and with fixed $\sum_{i=1}^{m} x_{i}$, $\sum_{i=1}^{m} x_{i}^{2}$ is maximized when $\left(x_{1}, x_{2}, \ldots, x_{m}\right)$ is $\left(d_{1}, d_{1}, \ldots, d_{1}, e, 0, \ldots, 0\right)$ with $0 \leq e<d_{1}$. Applying this observation to

$$
\left(x_{1}, x_{2}, \ldots, x_{m}\right)=(\underbrace{d_{1}, \ldots, d_{1}}_{k_{1} \text { times }}, \underbrace{d_{2}, \ldots, d_{2}}_{k_{2} \text { times }}, \ldots, \underbrace{d_{t}, \ldots, d_{t}}_{k_{t} \text { times }})
$$

(and $m=\sum_{i=1}^{t} k_{i}$ ), we see that

$$
\sum_{i=1}^{t} k_{i} d_{i}^{2} \leq a d_{1}^{2}+b,
$$

where $n=a d_{1}+b$ with $0 \leq b<d-1$. It follows that

$$
2 D \leq a d_{1}\left(d_{1}-1\right)<a d_{1}^{2} \leq n d_{1}=n(n-s),
$$

and we are done as in (i).
(iii) This is obvious, since $|G| \leq\left|\operatorname{SL}_{n}^{\epsilon}(q)\right|<q^{n^{2}-1}$.
(iv) By [7, Lemma 4.1],

$$
\frac{9}{32} q^{n^{2}}<\left|\mathrm{GL}_{n}(q)\right|<\left|\mathrm{GU}_{n}(q)\right| \leq \frac{3}{2} q^{n^{2}} .
$$

It now follows from (3.1) that

$$
\begin{aligned}
\left|g^{G}\right| & \leq\left|\hat{g}^{\mathrm{GL}_{n}^{\epsilon}(q)}\right|=\left[\mathrm{GL}_{n}^{\epsilon}(q): \mathbf{C}_{\mathrm{GL}_{n}^{\epsilon}(q)}(\hat{g})\right] \\
& \leq\left[\mathrm{GL}_{n}^{\epsilon}(q): \mathrm{GL}_{n-s}^{ \pm}(q)\right]<\frac{(3 / 2) q^{n^{2}}}{(9 / 32) q^{(n-s)^{2}}}=\frac{16}{3} q^{s(2 n-s)}
\end{aligned}
$$

for any $g \in N_{s}(G)$. Since the total number of conjugacy classes in $G$ is at most $8.26 q^{n-1}$ by Propositions 3.6 and 3.10 of [4], the statement follows.

Lemma 3.3. Let $1 \neq \chi \in \operatorname{Irr}(G)$, and for $1 \leq s<n$, let $g_{s} \in N_{s}(G)$ be such that $\left|\chi\left(g_{s}\right)\right|$ is maximal. For $l \geq 1$, define

$$
\Delta_{l}:=\sum_{1 \leq s<n / 2} c q^{n s+\frac{3 n}{2}-1}\left|\frac{\chi\left(g_{s}\right)}{\chi(1)}\right|^{l}+\sum_{n / 2 \leq s<n}^{n-1} q^{n^{2}-\frac{1}{2} n(s-1)-1}\left|\frac{\chi\left(g_{s}\right)}{\chi(1)}\right|^{l}
$$

with $c$ as in Lemma 3.2. If $\Delta_{l}<1$, then $\left[\chi^{l}, \mathrm{St}\right]_{G} \neq 0$.
Proof. As in the proof of Lemma 2.3, we have $\left[\chi^{l}, \mathrm{St}\right]_{G} \neq 0$ as long as $\Sigma_{l}<|G|_{p}$, where

$$
\Sigma_{l}:=\sum_{1 \neq g \in G_{\mathrm{ss}}}\left|\frac{\chi(g)}{\chi(1)}\right|^{l}\left|\mathbf{C}_{G}(g)\right|_{p} .
$$

Using Lemma 3.2, we have

$$
\begin{aligned}
\Sigma_{l} & \leq \sum_{s=1}^{n-1} n_{s}(G)\left|\frac{\chi\left(g_{s}\right)}{\chi(1)}\right|^{l}\left|\mathbf{C}_{G}(g)\right|_{p} \\
& \leq \sum_{1 \leq s<\frac{n}{2}} c q^{s(2 n-s)+n-1}\left|\frac{\chi\left(g_{s}\right)}{\chi(1)}\right|^{l} q^{\frac{1}{2} n^{2}+s^{2}-n s}+\sum_{n / 2 \leq s<n} q^{n^{2}-1}\left|\frac{\chi\left(g_{s}\right)}{\chi(1)}\right|^{l} q^{\frac{1}{2}\left(n^{2}-n s\right)} \\
& =|G|_{p} \Delta_{l},
\end{aligned}
$$

where $\Delta_{l}$ is as in the statement of the lemma. The conclusion follows.

## Proof of Theorem 3

Adopt the notation of Lemma 3.3. By Theorem 3.1, for any $\chi \in \operatorname{Irr}(G)$,

$$
\left|\chi\left(g_{s}\right)\right|<f(n) \chi(1)^{1-\frac{s}{n}} .
$$

Hence for $l \geq 1$,

$$
\begin{equation*}
\Delta_{l}<f(n)^{l}\left(\sum_{1 \leq s<n / 2} c q^{n s+\frac{3 n}{2}-1} \chi(1)^{-s l / n}+\sum_{n / 2 \leq s<n} q^{n^{2}-\frac{1}{2} n(s-1)-1} \chi(1)^{-s l / n}\right) \tag{3.2}
\end{equation*}
$$

Now we choose

$$
l=5 \frac{\log |G|}{\log \chi(1)}=5 \frac{\log _{q}|G|}{\log _{q} \chi(1)}
$$

We claim that

$$
\begin{equation*}
8(n+2) \geq l>\frac{3 n^{2}}{\log _{q} \chi(1)} \tag{3.3}
\end{equation*}
$$

This is obvious if $G=\operatorname{PSL}_{2}(q)$ is simple. If $G=\operatorname{PSL}_{n}(q)$ with $n \geq 3$, then by [12, Theorem 1.1],

$$
\chi(1)>q^{n-1}, \text { on the other hand, } q^{n^{2}-1}>|G|>q^{n^{2}-2}
$$

(where the last inequality follows from [7, Lemma 4.1(ii)]), and so (3.3) holds. If $G=$ $\operatorname{PSU}_{n}(q)$ with $n \geq 3$, then again by [12, Theorem 1.1],

$$
\chi(1)>q^{n-2}, \text { on the other hand, } q^{n^{2}-1}>|G|>q^{n^{2}-3},
$$

(where the last two inequalities can be checked using the proof of [7, Lemma 4.1(iv)]), and so (3.3) holds.

Now (3.3) implies that $\chi(1)^{-s l / n}<q^{-3 n s}$. Hence the first summand inside the parenthesized part of (3.2) is at most

$$
c \sum_{1 \leq s<n / 2} q^{3 n / 2-1-2 n s}<c q^{-n / 2-1} \sum_{j=0}^{\infty} \frac{1}{q^{2 n j}}<\frac{16 c}{15} q^{-n / 2-1} .
$$

The second summand inside the parenthesized part of (3.2) is at most

$$
\sum_{n / 2 \leq s<n} q^{n^{2}-7 n s / 2+n / 2-1}<\frac{n}{2} q^{-3 n^{2} / 4+n / 2-1} \leq \frac{n}{2} q^{-n-1}<q^{-n / 2-1}
$$

Since $c \leq 44.1$, it follows that

$$
\Delta_{l}<f(n)^{l}\left(\frac{16 c}{15}+1\right) q^{-n / 2-1}<f(n)^{l}\left(\frac{49}{q}\right)^{n / 2+1}
$$

Taking

$$
q \geq(49 f(n))^{16}
$$

we obtain by (3.3) that $\Delta_{l}<1$. Hence $\left[\chi^{l}, \mathrm{St}\right]_{G} \neq 0$ by Lemma 3.3.
Now Theorem 3 follows, using exactly the same argument as in the last paragraph of Section 2.

## Proof of Corollary 4

Write $\alpha=\alpha_{1}+\ldots+\alpha_{k}$, with $\alpha_{i} \in \operatorname{Irr}(G)$ and $\alpha_{1}(1) \leq \alpha_{2}(1) \ldots \leq \alpha_{k}(1)$. Since $\alpha$ is faithful, $\alpha_{k}(1) \geq \mathrm{d}(G)>1$, where $\mathrm{d}(G)$ is the smallest degree of nontrivial irreducible characters of $G$; furthermore, $k \leq k(G):=|\operatorname{Irr}(G)|$ as $\alpha$ is multiplicity-free. It is easy to check that $\mathrm{d}(G)^{1.5}>k(G)$ for $G=\operatorname{PSL}_{2}(q)$ with $q \geq 11$. For $n \geq 3$ and $G=\operatorname{PSL}_{n}^{\epsilon}(q)$, it follows from [12, Theorem 1.1] and [4, Propositions 3.6, 3.10] that

$$
\mathrm{d}(G)^{3 / 2} \geq\left(\frac{q^{n}-q}{q+1}\right)^{3 / 2} \geq\left(\frac{5}{6} q^{n-1}\right)^{3 / 2}>8.3 q^{n-1}>k(G)
$$

It follows that $\alpha_{k}(1)^{5 / 2}>k(G) \alpha_{k}(1) \geq k \alpha_{k}(1) \geq \alpha(1)$. By Theorem 3, for some

$$
N \leq C \frac{\log |G|}{\log \alpha_{k}(1)}<2.5 C \frac{\log |G|}{\log \alpha(1)}
$$

we have $\sum_{i=0}^{N} \alpha_{k}^{i}$ contains all irreducible characters of $G$, whence $\sum_{i=0}^{N} \alpha^{i}$ also contains all irreducible characters of $G$, i.e. $\operatorname{diam} \mathcal{M}(G, a) \leq N$.

## 4. Symmetric and alternating groups

This section is devoted to prove Theorem 5.
As explained in the Introduction, $\operatorname{diam} \mathcal{M}(G, \alpha)$ is at most $N=N(\alpha)$, if $N$ is the smallest positive integer such that $\sum_{i=0}^{N} \alpha^{i}$ contains $\operatorname{Irr}(G)$. Let $G:=\mathrm{S}_{n}, S:=\mathrm{A}_{n}$, and let $H:=\mathrm{S}_{n-1}, K:=\mathrm{S}_{n-2} \times \mathrm{S}_{2}, K^{\prime}=\mathrm{S}_{n-2}<K$, and $L:=\mathrm{S}_{n-3} \times \mathrm{S}_{3}$ be Young subgroups of $G$. If $\lambda \vdash n$ is a partition of $n$, let $\chi^{\lambda}$ denote the irreducible character of $\mathrm{S}_{n}$ labeled by $\lambda$.

Given a faithful irreducible character $\alpha$ of $G$ or $H$, we will now bound $N(\alpha)$ in a sequence of steps.

STEP 1. If $\alpha \in \operatorname{Irr}(G)$ and $\alpha=\chi^{(n-1,1)}$, then $N(\alpha) \leq n-1$.
Indeed, $\alpha$ takes $n$ distinct values $-1,0,1, \ldots, n-3, n-1$, hence $N(\alpha) \leq n-1$ by [2].
STEP 2. If $\alpha \in \operatorname{Irr}(G)$ and $\left.\alpha\right|_{H}$ is reducible, then $N(\alpha) \leq 2 n-2$. In particular, $N\left(\chi^{(n-2,2)}\right) \leq 2 n-2$. Likewise, if $n \geq 7$ and $\mu=\left(m u_{1} \geq \mu_{2} \geq \ldots \geq \mu_{s} \geq 1\right) \vdash n$ and $n-1 \geq \mu_{1} \geq n-3$, then $N\left(\chi^{\mu}\right) \leq 2 n-2$.

Indeed, by assumption we have that

$$
2 \leq\left[\left.\alpha\right|_{H},\left.\alpha\right|_{H}\right]_{H}=\left[\left.\alpha^{2}\right|_{H}, 1_{H}\right]_{H}=\left[\alpha^{2}, \operatorname{Ind}_{H}^{G}\left(1_{H}\right)\right]_{G}
$$

Recall that $\operatorname{Ind}_{H}^{G}\left(1_{H}\right)=1_{G}+\chi^{(n-1,1)}$ and $\left[\alpha^{2}, 1_{G}\right]_{G}=1$. It follows that $\alpha^{2}$ contains $\chi^{(n-1,1)}$, and so $N(\alpha) \leq 2 n-2$ by Step 1 .

The branching rule for complex representations of $S_{n}$ implies that

$$
\left.\chi^{(n-2,2)}\right|_{H}=\chi^{(n-2,1)}+\chi^{(n-3,2)}
$$

i.e. $\chi^{(n-2,2)}$ is reducible over $H$. Similarly, $\left.\chi^{\mu}\right|_{H}$ is reducible for the $\mu$ listed above when $n \geq 7$, whence we are done.

Step 3. If $\alpha \in \operatorname{Irr}(G)$, then $N(\alpha) \leq 4 n-4$.
Consider $K=\mathrm{S}_{n-2} \times \mathrm{S}_{2}$, where $\mathrm{S}_{2}=\langle s\rangle$ is generated by a transposition $s$. If $\left.\alpha\right|_{K}$ is irreducible, then by Schur's Lemma $s$ acts as a scalar, and so $\alpha=1_{G}$ or the sign character, contradicting the faithfulness of $\alpha$. Thus $\left.\alpha\right|_{K}$ is reducible, and so

$$
2 \leq\left[\left.\alpha\right|_{K},\left.\alpha\right|_{K}\right]_{K}=\left[\left.\alpha^{2}\right|_{K}, 1_{K}\right]_{K}=\left[\alpha^{2}, \operatorname{Ind}_{K}^{G}\left(1_{K}\right)\right]_{G}
$$

Recall that $\operatorname{Ind}_{K}^{G}\left(1_{K}\right)=1_{G}+\chi^{(n-1,1)}+\chi^{(n-2,2)}$ and $\left[\alpha^{2}, 1_{G}\right]_{G}=1$. If $\alpha^{2}$ contains $\chi^{(n-1,1)}$, then $N(\alpha) \leq 2 n-2$ by Step 1. Otherwise we must have that $\alpha^{2}$ contains $\chi^{(n-2,2)}$, and so $N(\alpha) \leq 4 n-4$ by Step 2 .

From now on we will assume that $\alpha \in \operatorname{Irr}(S)$ and that $\alpha$ is an irreducible constituent of the restriction of $\chi=\chi^{\lambda} \in \operatorname{Irr}(G)$ to $S$.

STEP 4. If $\alpha$ extends to $G$, then $N(\alpha) \leq 4 n-4$.
Indeed, in this case $\alpha=\left.\chi\right|_{S}$. By Step $3, \sum_{i=0}^{4 n-4} \chi^{i}$ contains $\chi^{\mu}$ for all $\mu \vdash n$. It follows that $\sum_{i=0}^{4 n-4} \alpha^{i}=\left.\left(\sum_{i=0}^{4 n-4} \chi^{i}\right)\right|_{S}$ contains $\left.\chi^{\mu}\right|_{S}$ for all $\mu \vdash n$, whence it contains all $\operatorname{Irr}(S)$.

From now on, we will assume that $\alpha$ does not extend to $G$; equivalently, $\lambda$ is selfassociated: $\lambda=\lambda^{*}$. For $n=5,6$, the character $\alpha$ takes at most 5 different values on $S$, and so $N(\alpha) \leq 4$ by [2]. We will therefore assume $n \geq 7$.

Step 5. If $\alpha$ is real-valued then $N(\alpha) \leq 4 n-4$.
The assumption implies that $\left[\left.\alpha^{2}\right|_{S}, 1_{S}\right]=1$. Next, by inspecting the character table of $A_{5}$, we see that any nontrivial complex irreducible representation $\Phi$ of $A_{5}$ affords all three distinct eigenvalues $1, \omega, \omega^{2}$ for the 3 -cycle $t=(1,2,3)(\omega \neq 1$ being a cubic root of unity in $\mathbb{C}$ ). We prove by induction that the same statement holds for any $n \geq 5$. For the induction step $n \geq 6$, suppose $\Phi(t)$ affords at most two distinct eigenvalues. By induction hypothesis, all composition factors of $\left.\Phi\right|_{A_{n-1}}$ are trivial. By Frobenius' reciprocity, the character $\varphi$ of $\Phi$ is a constituent of

$$
\operatorname{Ind}_{S \cap H}^{S}\left(1_{S \cap H}\right)=\left.\left(\operatorname{Ind}_{H}^{G}\left(1_{H}\right)\right)\right|_{S}=\left.\left(\chi^{n}+\chi^{(n-1,1)}\right)\right|_{H}
$$

and so $\varphi=\left.\chi^{(n-1,1)}\right|_{S}$. But clearly in this case $\Phi(t)$ affords all three eigenvalues $1, \omega, \omega^{2}$, a contradiction.

Applying the established assertion to a complex representation $\Phi$ affording $\alpha$, we see that $\Phi(t)$ affords all three eigenvalues $1, \omega, \omega^{2}$. We can choose the Young subgroup $L=\mathrm{S}_{n-3} \times \mathrm{S}_{3}$ such that $t \in \mathrm{~S}_{3} \cap L$, in which case $\langle t\rangle \triangleleft L \cap S$. It follows that $\left.\alpha\right|_{L \cap S}$ is reducible, and so

$$
2 \leq\left[\left.\alpha\right|_{S \cap L},\left.\alpha\right|_{S \cap L}\right]_{S \cap L}=\left[\left.\alpha^{2}\right|_{S \cap L}, 1_{S \cap L}\right]_{S \cap L}=\left[\alpha^{2}, \operatorname{Ind}_{S \cap L}^{S}\left(1_{S \cap L}\right)\right]_{S}
$$

Observe that

$$
\operatorname{Ind}_{S \cap L}^{S}\left(1_{S \cap L}\right)=\left.\left(\operatorname{Ind}_{L}^{G}\left(1_{L}\right)\right)\right|_{S}=1_{S}+\left.\sum_{i=1}^{3} \chi^{(n-i, i)}\right|_{S}
$$

and $\left.\chi^{(n-i, i)}\right|_{S}$ is irreducible for $i \leq 3$. It follows that $\alpha^{2}$ contains $\left.\chi^{(n-j, j)}\right|_{S}$ for some $1 \leq j \leq 3$. As $\left.N\left(\chi^{(n-j, j}\right)\right) \leq 2 n-2$ by Step 2 , we have that $N(\alpha) \leq 4 n-4$.

Step 6. If $\alpha \neq \bar{\alpha}$ and $\lambda \neq\left(a^{a}\right)$ with $a \in \mathbb{Z}_{\geq 1}$, then $N(\alpha) \leq 2 n-2$.
Since we are assuming that $\alpha$ does not extend to $G$ and $\chi^{\lambda}$ is real-valued, we have that $\left.\chi^{\lambda}\right|_{S}=\alpha+\bar{\alpha}$ and that $\lambda=\lambda^{*}$. Let $\mu$ be obtained from $\lambda$ by removing the last node of the shortest row of (the Young diagram of) $\lambda$. As $\lambda \neq\left(a^{a}\right)$, observe that $\mu \neq \mu^{*}$. But $\lambda=\lambda^{*}$, so by symmetry we see that $\left.\chi^{\langle }\right|_{H}$ contains $\chi^{\mu}+\chi^{\mu^{*}}$. The condition $\mu \neq \mu^{*}$ also implies that $\beta:=\left.\chi^{\mu}\right|_{\mathrm{A}_{n-1}}=\left.\chi^{\mu^{*}}\right|_{\mathrm{A}_{n-1}}$ is irreducible. It follows that $\left.\alpha\right|_{S \cap H}$ contains the real-valued irreducible character $\beta$, and so $\left.\alpha^{2}\right|_{S \cap H}$ contains $\beta^{2}$, which in turns contains $1_{S \cap H}$. Thus we have

$$
1 \leq\left[\left.\alpha^{2}\right|_{S \cap H}, 1_{S \cap H}\right]_{S \cap H}=\left[\alpha^{2}, \operatorname{Ind}_{S \cap H}^{S}\left(1_{S \cap H}\right)\right]_{S}
$$

Now

$$
\operatorname{Ind}_{S \cap H}^{S}\left(1_{S \cap H}\right)=\left.\left(\operatorname{Ind}_{H}^{G}\left(1_{H}\right)\right)\right|_{S}=1_{S}+\left.\chi^{(n-1,1)}\right|_{S}
$$

and $\left[\alpha^{2}, 1_{S}\right]_{S}=0$ since $\alpha \neq \bar{\alpha}$. Hence $\alpha^{2}$ contains $\left.\chi^{(n-1,1)}\right|_{S}$, and so $N(\alpha) \leq 2 n-2$ by Step 1.

Final Step. If $\alpha \neq \bar{\alpha}$ and $\lambda=\left(a^{a}\right)$ with $a \in \mathbb{Z}_{\geq 3}$, then $N(\alpha) \leq 4 n-4$.
As in Step 6, since we are assuming that $\alpha$ does not extend to $G$ and $\chi^{\lambda}$ is real-valued, we have that $\left.\chi^{\lambda}\right|_{S}=\alpha+\bar{\alpha}$. Let $\nu$ be obtained from $\lambda$ by removing the last two nodes of the last row of (the Young diagram of) $\lambda$, so that $\nu \neq \nu^{*}$. But $\lambda=\lambda^{*}$, so by symmetry we see that $\left.\chi^{\lambda}\right|_{K}$ contains $\chi^{\nu}+\chi^{\nu^{*}}$. The condition $\nu \neq \nu^{*}$ also implies that $\gamma:=\left.\chi^{\nu}\right|_{\mathrm{A}_{n-2}}=\left.\chi^{\nu^{*}}\right|_{\mathrm{A}_{n-2}}$ is irreducible. It follows that $\left.\alpha\right|_{S \cap K^{\prime}}$ contains the real-valued irreducible character $\gamma$, and so $\left.\alpha^{2}\right|_{S \cap K^{\prime}}$ contains $\gamma^{2}$, which in turns contains $1_{S \cap K^{\prime}}$. Thus we have

$$
1 \leq\left[\left.\alpha^{2}\right|_{S \cap K^{\prime}}, 1_{S \cap K^{\prime}}\right]_{S \cap K^{\prime}}=\left[\alpha^{2}, \operatorname{Ind}_{S \cap K^{\prime}}^{S}\left(1_{S \cap K^{\prime}}\right)\right]_{S}
$$

Now

$$
\operatorname{Ind}_{S \cap K^{\prime}}^{S}\left(1_{S \cap K^{\prime}}\right)=\left.\left(\operatorname{Ind}_{K^{\prime}}^{G}\left(1_{K^{\prime}}\right)\right)\right|_{S}=1_{S}+\left.\chi^{(n-1,1)}\right|_{S}+\left.\chi^{(n-2,2)}\right|_{S}+\left.\chi^{\left(n-2,1^{2}\right)}\right|_{S},
$$

and $\left[\alpha^{2}, 1_{S}\right]_{S}=0$ since $\alpha \neq \bar{\alpha}$. Hence $\alpha^{2}$ contains at least one of (irreducible characters) $\left.\chi^{(n-1,1)}\right|_{S},\left.\chi^{(n-2,2)}\right|_{S},\left.\chi^{\left(n-2,1^{2}\right)}\right|_{S}$, and we conclude that $N(\alpha) \leq 4 n-4$ by Step 2.

## 5. McKay graphs for quasi-Simple groups

McKay graphs $\mathcal{M}(G, \alpha)$ are usually considered for any finite group $G$ possessing a faithful character $\alpha$ (to guarantee connectedness). In this section, we show that the diameters of McKay graphs for faithful irreducible characters of quasi-simple groups (with cyclic center) can be bounded by the diameters of McKay graphs for simple groups.

Theorem 5.1. Let $G$ be a finite quasi-simple group with cyclic center $\mathbf{Z}(G)$, and let $\chi$ be a faithful irreducible character of $G$. Then there is a nontrivial irreducible character $\beta$ of the simple group $S:=G / \mathbf{Z}(G)$ such that

$$
\operatorname{diam} \mathcal{M}(G, \chi) \leq|\mathbf{Z}(G)| \cdot \operatorname{diam} \mathcal{M}(S, \beta)+|\mathbf{Z}(G)|-1
$$

In particular

$$
\max _{\alpha \in \operatorname{Irr}(G), \alpha \text { faithful }} \operatorname{diam} \mathcal{M}(G, \alpha) \leq|\mathbf{Z}(G)| \cdot\left(\max _{1_{S} \neq \gamma \in \operatorname{Irr}(S)} \operatorname{diam} \mathcal{M}(S, \gamma)+1\right)-1
$$

Proof. Let $e:=|\mathbf{Z}(G)|$. Since $\operatorname{Ker}\left(\chi^{e}\right)$ contains $\mathbf{Z}(G)$ but not $G$, we can find a nontrivial $\beta \in \operatorname{Irr}(S)$ such that $\beta$ inflated to $G$ is an irreducible constituent of $\chi^{e}$. Now consider arbitrary $\varphi, \psi \in \operatorname{Irr}(G)$. Then there is $0 \leq i \leq e-1$ such that the nontrivial character $\varphi \chi^{i} \bar{\psi}$ is trivial at $\mathbf{Z}(G)$ and so contains a nontrivial $\delta \in \operatorname{Irr}(S)$. Thus

$$
\left[\varphi \chi^{i} \bar{\delta}, \psi\right]_{G}=\left[\varphi \chi^{i} \bar{\psi}, \delta\right]_{G}>0
$$

Next, we can find some $d \leq \operatorname{diam} \mathcal{M}(S, \beta)$ such that $\beta^{d}$ contains $\bar{\delta}$. It follows that

$$
\left[\varphi \chi^{i+d e}, \psi\right]_{G} \geq\left[\varphi \chi^{i} \beta^{d}, \psi\right]_{G} \geq\left[\varphi \chi^{i} \bar{\delta}, \psi\right]_{G}>0
$$

i.e. a directed path of length $i+d e$ connects $\varphi$ to $\psi$ in $\mathcal{M}(G, \alpha)$.

As a final remark, we note that one cannot remove the term $|\mathbf{Z}(G)|$ from the upper bound in Theorem 5.1. Indeed, any directed path connecting $1_{G}$ to any other $1_{S} \neq \psi \in \operatorname{Irr}(S)$ in $\mathcal{M}(G, \alpha)$ must have length divisible by $|\mathbf{Z}(G)|$.
