# $\mathbb{Z}_{2 k}$-CODE VERTEX OPERATOR ALGEBRAS

#### Abstract

We study a simple, self-dual, rational, and $C_{2}$-cofinite vertex operator algebra of CFT-type whose simple current modules are graded by $\mathbb{Z}_{2 k}$. Based on those simple current modules, a vertex operator algebra associated with a $\mathbb{Z}_{2 k}$-code is constructed. The classification of irreducible modules for such a vertex operator algebra is established. Furthermore, all the irreducible modules are realized in a module for a certain lattice vertex operator algebra.


## 1. Introduction

Let $V$ be a simple, self-dual, rational, and $C_{2}$-cofinite vertex operator algebra of CFTtype. Then the set $\operatorname{Irr}(V)_{\mathrm{sc}}$ of equivalence classes of simple current $V$-modules is closed under the fusion product $\boxtimes_{V}$, and it is graded by a finite abelian group, say $C$. That is, $\operatorname{Irr}(V)_{\mathrm{sc}}=\left\{A^{\alpha} \mid \alpha \in C\right\}$ with $A^{\alpha}, \alpha \in C$, being inequivalent to each other, $A^{0}=V$, and $A^{\alpha} \boxtimes_{V} A^{\beta}=A^{\alpha+\beta}$ for $\alpha, \beta \in C$. If $D$ is a subgroup of $C$ such that the conformal weight $h\left(A^{\alpha}\right)$ of $A^{\alpha}$ is an integer for $\alpha \in D$, then the direct sum $\bigoplus_{\alpha \in D} A^{\alpha}$ has either a simple vertex operator algebra structure or a simple vertex operator superalgebra structure, which extends the $V$-module structure [7, Theorem 3.12]. In such a case $\bigoplus_{\alpha \in D} A^{\alpha}$ is called a simple current extension of $V$.

The theory of simple current extensions of vertex operator algebras has been developed extensively, see for example [6, 7, 8, 12, 15, 17, 18, 20]. Nowadays it is not hard to construct new vertex operator (super)algebras as simple current extensions of known ones. One of the examples is the $\mathbb{Z}_{k}$-code vertex operator algebra [5], which is a $D$-graded simple current extension of the tensor product $K\left(\mathfrak{s l}_{2}, k\right)^{\otimes \ell}$ of $\ell$ copies of the parafermion vertex operator algebra $K\left(\mathfrak{s l}_{2}, k\right)$ associated with $\mathfrak{s l}_{2}$ and an integer $k \geq 2$, and $D$ is an additive subgroup of $\left(\mathbb{Z}_{k}\right)^{\ell}$ satisfying a certain condition.

In this paper, we study a $D$-graded simple current extension $U_{D}$ of the tensor product $\left(U^{0}\right)^{\otimes \ell}$ of $\ell$ copies of a vertex operator algebra $U^{0}$ such that $\operatorname{Irr}\left(U^{0}\right)_{\mathrm{sc}}$ is graded by $\mathbb{Z}_{2 k}$ for an integer $k \geq 2$. Here $D$ is an additive subgroup of $\left(\mathbb{Z}_{2 k}\right)^{\ell}$.

Let $N=\sqrt{2} A_{k-1}$ be $\sqrt{2}$ times an $A_{k-1}$ root lattice. Then a vertex operator algebra $V_{N}$ associated with the lattice $N$ contains a subalgebra isomorphic to

L\left(c_{1}, 0\right) \otimes \cdots \otimes L\left(c_{k-1}, 0\right) \otimes K\left(\mathfrak{s l}_{2}, k\right)
$$

where $L\left(c_{m}, 0\right), 1 \leq m \leq k-1$, are the Virasoro vertex operator algebras of discrete series. The vertex operator algebra $U^{0}$ is defined to be the commutant of $S=L\left(c_{1}, 0\right) \otimes \cdots \otimes$ $L\left(c_{k-2}, 0\right)$ in $V_{N}$. The vertex operator algebra $U^{0}$ was previously known [2, 8]. There are two descriptions of $U^{0}$, one is a $\mathbb{Z}_{k-1}$-graded simple current extension of $K\left(\mathfrak{s l}_{2}, k-1\right) \otimes V_{\mathbb{Z} d}$ with $\langle d, d\rangle=2(k-1) k$, and the other is a non-simple current extension of $L\left(c_{k-1}, 0\right) \otimes$

[^0]$K\left(\mathfrak{s l}_{2}, k\right)$ (Theorem 3.2). We review the irreducible $U^{0}$-modules (Theorem 3.6) and fusion rules (Theorem 4.1) in our notation. Moreover, we show how the irreducible $U^{0}$-modules appear in $V_{N^{\circ}}$ (Lemma 5.1).

The $\mathbb{Z}_{2 k}$-grading of the set $\operatorname{Irr}\left(U^{0}\right)_{\mathrm{sc}}=\left\{U^{l} \mid 0 \leq l<2 k\right\}$ of equivalence classes of simple current $U^{0}$-modules corresponds to the $\mathbb{Z}_{2 k}$-part of the discriminant group $N^{\circ} / N \cong\left(\mathbb{Z}_{2}\right)^{k-2} \times \mathbb{Z}_{2 k}$ of the lattice $N$ (Eq. (5.2)). We also recall that the $\mathbb{Z}_{k}$-grading of $\operatorname{Irr}\left(K\left(\mathfrak{s l}_{2}, k\right)\right)_{\text {sc }}$ used in [5] for $\mathbb{Z}_{k}$-code vertex operator algebras corresponds to the $\mathbb{Z}_{k}$-part of $\left(\mathbb{Z}_{2}\right)^{k-2} \times \mathbb{Z}_{2 k}$.

Once the necessary properties of the vertex operator algebra $U^{0}$ are obtained, the construction of the vertex operator algebra $U_{D}$ is straightforward. In fact, $U_{D}$ is defined to be the commutant of $S^{\otimes \ell}$ in a vertex operator algebra $V_{\Gamma_{D}}$ associated with a certain positive definite integral lattice $\Gamma_{D}$ (Theorem 5.7). It turns out that $U_{D}$ is a direct sum of a $D$-graded set of simple current $\left(U^{0}\right)^{\otimes \ell}$-modules $U_{\xi}=U^{\xi_{1}} \otimes \cdots \otimes U^{\xi_{\ell}}, \xi=\left(\xi_{1}, \ldots, \xi_{\ell}\right) \in D$. We construct all the irreducible $\chi$-twisted $U_{D}$-modules for $\chi \in \operatorname{Hom}\left(D, \mathbb{C}^{\times}\right)$in $V_{\left(N^{\circ}\right)^{\ell}}$, and classify them (Theorems 6.4 and 6.6). The arguments concerning $U_{D}$ and its irreducible $\chi$-twisted modules are similar to those in Sections 8 and 9 of (5].

If $k=2$, then $U^{0}$ is isomorphic to a rank one lattice vertex operator algebra $V_{2 \mathbb{Z}}$. In the case $k=4$, the $\mathbb{Z}_{8}$-code vertex operator algebra $U_{D}$ was studied in [21. Our result is a generalization of [21] to an arbitrary $k \geq 2$.

This paper is organized as follows. In Section 2, we recall basic properties of the Virasoro vertex operator algebra of discrete series and the parafermion vertex operator algebra associated with $\mathfrak{s l}_{2}$ and a positive integer $k$. In Section 3, we define the vertex operator algebra $U^{0}$ and describe it in two ways. We classify irreducible $U^{0}$-modules as well. Fusion rules for irreducible $U^{0}$-modules are discussed in Section (1) In Section 5 , we introduce the positive definite integral lattice $\Gamma_{D}$ and the vertex operator algebra or a vertex operator superalgebra $U_{D}$ for a $\mathbb{Z}_{2 k}$-code $D$. Finally, in Section 6, we classify the irreducible $U_{D}$-modules. The weight and the dimension of the top level of the simple current $U^{0}$-module $U^{l}, 0 \leq l<2 k$, are calculated in Appendix A.

We use the symbol $\boxtimes_{V}$ to denote the fusion product over a vertex operator algebra $V$. We also use the symbol $\otimes$ to denote the tensor product of vertex operator algebras and their modules as in [16].

## 2. Preliminaries

In this section, we recall the vertex operator algebra associated with the discrete series of Virasoro algebra and the parafermion vertex operator algebra associated with $\mathfrak{s l}_{2}$ and a positive integer $k$.
2.1. Virasoro vertex operator algebra $L\left(c_{m}, 0\right)$. Let $L(c, 0)$ be the simple Virasoro vertex operator algebra of central charge $c$, and let $L(c, h)$ be its irreducible highest weight module with highest weight $h$. Let

c_{m}=1-\frac{6}{(m+2)(m+3)}
$$

for $m=1,2, \ldots$, and

$$
h_{r, s}^{(m)}=\frac{(r(m+3)-s(m+2))^{2}-1}{4(m+2)(m+3)}
$$

for $1 \leq r \leq m+1,1 \leq s \leq m+2$. The vertex operator algebra $L\left(c_{m}, 0\right)$ is self-dual, rational, $C_{2}$-cofinite, and of CFT-type with $L\left(c_{m}, h_{r, s}^{(m)}\right), 1 \leq s \leq r \leq m+1$, a complete set of representatives of equivalence classes of irreducible $L\left(c_{m}, 0\right)$-modules 25, Theorem 4.2]. The fusion product of irreducible $L\left(c_{m}, 0\right)$-modules is as follows [25, Theorem 4.3].

L\left(c_{m}, h_{r_{1}, s_{1}}^{(m)}\right) \boxtimes_{L\left(c_{m}, 0\right)} L\left(c_{m}, h_{r_{2}, s_{2}}^{(m)}\right)=\sum_{i, j} L\left(c_{m}, h_{\left|r_{1}-r_{2}\right|+2 i-1,\left|s_{1}-s_{2}\right|+2 j-1}^{(m)}\right), \tag{2.1}
\end{equation*}
$$

where the summation is taken over the integers $i$ and $j$ satisfying

$$
\begin{aligned}
& 1 \leq i \leq \min \left\{r_{1}, r_{2}, m+2-r_{1}, m+2-r_{2}\right\} \\
& 1 \leq j \leq \min \left\{s_{1}, s_{2}, m+3-s_{1}, m+3-s_{2}\right\} .
\end{aligned}
$$

2.2. Parafermion vertex operator algebra $K\left(\mathfrak{s l}_{2}, k\right)$. We fix the notation for the parafermion vertex operator algebra $K\left(\mathfrak{s l}_{2}, k\right)$ associated with $\mathfrak{s l}_{2}$ and a positive integer $k$. Details about $K\left(\mathfrak{s l}_{2}, k\right)$ can be found in [3, ©, 9, 10, 14]. If $k=1$, then $K\left(\mathfrak{s l}_{2}, k\right)$ reduces to the trivial vertex operator algebra $\mathbb{C} 1$. So we assume that $k \geq 2$. Let

\begin{equation*}
L^{(k)}=\mathbb{Z} \alpha_{1}+\cdots+\mathbb{Z} \alpha_{k} \tag{2.2}
\end{equation*}
$$

with $\left\langle\alpha_{i}, \alpha_{j}\right\rangle=2 \delta_{i, j}$, and set $\gamma_{k}=\alpha_{1}+\cdots+\alpha_{k}$.
The vertex operator algebra $V_{L^{(k)}}$ contains a subalgebra isomorphic to the simple affine vertex operator algebra $L_{\widehat{\mathfrak{s}}_{2}}(k, 0)$ associated with the affine Kac-Moody algebra $\widehat{\mathfrak{s l}}{ }_{2}$ at level $k$, and $K\left(\mathfrak{s l}_{2}, k\right)$ is realized as the commutant of the vertex operator algebra $V_{\mathbb{Z} \gamma_{k}}$ in $L_{{\widehat{\mathfrak{s}} l_{2}}(k, 0) \text {. Let }}$

$$
M_{(k)}^{j}=\left\{v \in L_{\widehat{\mathfrak{s}}_{2}}(k, 0) \mid \gamma_{k}(n) v=-2 j \delta_{n, 0} v \text { for } n \geq 0\right\}
$$

for $0 \leq j<k$. Then $M_{(k)}^{0}=K\left(\mathfrak{s l}_{2}, k\right)$, and

$$
\begin{equation*}
L_{\widehat{\mathfrak{s}}_{2}}(k, 0)=\bigoplus_{j=0}^{k-1} M_{(k)}^{j} \otimes V_{\mathbb{Z} \gamma_{k}-j \gamma_{k} / k} \tag{2.3}
\end{equation*}
$$

An irreducible $L_{\widehat{\mathfrak{s}}_{2}}(k, 0)$-module $L_{\widehat{\mathfrak{s l}}_{2}}(k, i)$ with $i+1$ dimensional top level can be constructed in the $V_{L^{(k)}}$-module $V_{\left(L^{(k)}\right)^{\circ}}$ for $0 \leq i \leq k$, where $\left(L^{(k)}\right)^{\circ}=\frac{1}{2} L^{(k)}$ is the dual lattice of $L^{(k)}$. Let

$$
M_{(k)}^{i, j}=\left\{v \in L_{\widehat{\mathfrak{s k}_{2}}}(k, i) \mid \gamma_{k}(n) v=(i-2 j) \delta_{n, 0} v \text { for } n \geq 0\right\}
$$

for $0 \leq j<k$. Then $M_{(k)}^{0, j}=M_{(k)}^{j}$, and

$$
\begin{equation*}
L_{\widehat{\mathfrak{s}}_{2}}(k, i)=\bigoplus_{j=0}^{k-1} M_{(k)}^{i, j} \otimes V_{\mathbb{Z} \gamma_{k}+(i-2 j) \gamma_{k} / 2 k} \tag{2.4}
\end{equation*}
$$

The index $j$ of $M_{(k)}^{j}$ and $M_{(k)}^{i, j}$ can be considered to be modulo $k$. We will use the following properties of $M_{(k)}^{0}$ and $M_{(k)}^{i, j}$.
(1) $M_{(k)}^{0}=K\left(\mathfrak{s l}_{2}, k\right)$ is a simple, self-dual, rational, and $C_{2}$-cofinite vertex operator algebra of CFT-type with central charge $2(k-1) /(k+2)$.
(2) $M_{(k)}^{i, j}, 0 \leq i \leq k, 0 \leq j<k$, are irreducible $M_{(k)}^{0}$-modules with

$$
\begin{equation*}
M_{(k)}^{i, j} \cong M_{(k)}^{k-i, j-i} \tag{2.5}
\end{equation*}
$$

and $M_{(k)}^{i, j}, 0 \leq j<i \leq k$, form a complete set of representatives of equivalence classes of irreducible $M_{(k)}^{0}$-modules.
(3) The top level of $M_{(k)}^{i, j}$ is one dimensional and its conformal weight is

\begin{equation*}
h\left(M_{(k)}^{i, j}\right)=\frac{1}{2 k(k+2)}\left(k(i-2 j)-(i-2 j)^{2}+2 k(i-j+1) j\right) \tag{2.6}
\end{equation*}
$$

for $0 \leq j \leq i \leq k$. Eq. (2.6) is valid even in the case $j=i$.
(4) The fusion product of irreducible $M_{(k)}^{0}$-modules is

M_{(k)}^{i_{1}, j_{1}} \boxtimes_{M_{(k)}^{0}} M_{(k)}^{i_{2}, j_{2}}=\sum_{r \in R\left(i_{1}, i_{2}\right)} M_{(k)}^{r,\left(2 j_{1}-i_{1}+2 j_{2}-i_{2}+r\right) / 2} \tag{2.7}
\end{equation*}
$$

where $R\left(i_{1}, i_{2}\right)$ is the set of integers $r$ satisfying

$$
\left|i_{1}-i_{2}\right| \leq r \leq \min \left\{i_{1}+i_{2}, 2 k-i_{1}-i_{2}\right\}, \quad i_{1}+i_{2}+r \in 2 \mathbb{Z}
$$

In particular, $M_{(k)}^{j}, 0 \leq j<k$, are the simple currents, and

$$
M_{(k)}^{p} \boxtimes_{M_{(k)}^{0}} M_{(k)}^{i, j}=M_{(k)}^{i, j+p}
$$

(5) If $k \geq 3$, then the automorphism group Aut $M_{(k)}^{0}$ of $M_{(k)}^{0}$ is generated by an involution $\theta$, and $M_{(k)}^{i, j} \circ \theta \cong M_{(k)}^{i, i-j}$. The automorphism $\theta$ is induced from the -1 -isometry $\alpha \mapsto-\alpha$ of the lattice $L^{(k)}$.

## 3. Vertex operator algebra $U^{0}$

In this section, we discuss a vertex operator algebra $U^{0}$. The vertex operator algebra $U^{0}$ and its irreducible modules have already been studied [2, [8, Section 4.4.2], see also [26, Section 3.1]. We describe $U^{0}$ and all the irreducible $U^{0}$-modules in a lattice vertex operator algebra and in its module for later use.

We fix an integer $k \geq 2$. Let $\alpha_{i}, 1 \leq i \leq k$, and $L^{(k)}$ be as in Section 2.2. Thus $\left\langle\alpha_{i}, \alpha_{j}\right\rangle=2 \delta_{i, j}$ and $L^{(k)}=\mathbb{Z} \alpha_{1}+\cdots+\mathbb{Z} \alpha_{k}$. Let

\begin{equation*}
\gamma_{k-1}=\alpha_{1}+\cdots+\alpha_{k-1}, \quad \gamma_{k}=\alpha_{1}+\cdots+\alpha_{k}, \quad d=\gamma_{k-1}-(k-1) \alpha_{k} . \tag{3.1}
\end{equation*}
$$

Then $d=\gamma_{k}-k \alpha_{k},\left\langle\gamma_{k}, \gamma_{k}\right\rangle=2 k,\langle d, d\rangle=2(k-1) k$, and $\left\langle\gamma_{k}, d\right\rangle=0$.
For $\boldsymbol{a}=\boldsymbol{a}(k)=\left(a_{1}, \ldots, a_{k}\right) \in\{0,1\}^{k}$, let $\delta_{\boldsymbol{a}(k)}=\frac{1}{2} \sum_{p=1}^{k} a_{p} \alpha_{p}$. The vertex operator algebra $V_{L^{(k)}}$ associated with the lattice $L^{(k)}$ contains a subalgebra isomorphic to

L\left(c_{1}, 0\right) \otimes \cdots \otimes L\left(c_{k-1}, 0\right) \otimes L_{\widehat{\mathfrak{s}}_{2}}(k, 0)
$$

and

$$
\begin{equation*}
V_{L^{(k)}+\delta_{a(k)}}=\bigoplus_{\substack{0 \leq i_{s} \leq s \\ i_{s} \equiv \equiv_{s} \\ 1 \leq m \leq k \\ 1 \leq s \leq k}} L\left(c_{1}, h_{i_{1}+1, i_{2}+1}^{(1)}\right) \otimes \cdots \otimes L\left(c_{k-1}, h_{i_{k-1}+1, i_{k}+1}^{(k-1)}\right) \otimes L_{\widehat{s t}_{2}}\left(k, i_{k}\right) \tag{3.2}
\end{equation*}
$$

as an $L\left(c_{1}, 0\right) \otimes \cdots \otimes L\left(c_{k-1}, 0\right) \otimes L_{\widehat{\mathfrak{s}}_{2}}(k, 0)$-module, where $b_{s}=\sum_{p=1}^{s} a_{p}$ [19, 22, 24, see also [55, Section 5]. Since $L^{(k-1)} \oplus \mathbb{Z} \alpha_{k}=L^{(k)}$, it follows that

\begin{equation*}
V_{L^{(k-1)}+\delta_{\boldsymbol{a}(k-1)}} \otimes V_{\mathbb{Z} \alpha_{k}+a_{k} \alpha_{k} / 2}=V_{L^{(k)}+\delta_{\boldsymbol{a}(k)}} . \tag{3.3}
\end{equation*}
$$

Let $\omega^{s}$ be the conformal vector of the Virasoro vertex operator algebra $L\left(c_{s}, 0\right), 1 \leq$ $s \leq k-1$. We apply (3.2) to $V_{L^{(k-1)}+\delta_{a(k-1)}}$ for $k-1$ in place of $k$. Then

\begin{aligned}
\{v \in & \left.V_{L^{(k-1)}+\delta_{a(k-1)}} \otimes V_{\mathbb{Z} \alpha_{k}+a_{k} \alpha_{k} / 2} \mid \omega_{(1)}^{s} v=h_{i_{s}+1, i_{s+1}+1}^{(s)} v, 1 \leq s \leq k-2\right\} \\
& =L_{\mathfrak{s l}_{2}}\left(k-1, i_{k-1}\right) \otimes V_{\mathbb{Z} \alpha_{k}+a_{k} \alpha_{k} / 2}
\end{aligned}
$$

We also have

$$
\begin{align*}
\{v \in & \left.V_{L^{(k)}+\delta_{a(k)}} \mid \omega_{(1)}^{s} v=h_{i_{s}+1, i_{s+1}+1}^{(s)} v, 1 \leq s \leq k-2\right\} \\
& =\bigoplus_{\substack{0 \leq i_{k} \leq k \\
i_{k} \equiv b_{k}(\bmod 2)}} L\left(c_{k-1}, h_{i_{k-1}+1, i_{k}+1}^{(k-1)}\right) \otimes L_{\mathfrak{s l}_{2}}\left(k, i_{k}\right) \tag{3.4}
\end{align*}
$$

by (3.2). Hence (3.3) implies that

L_{\mathfrak{s l}_{2}}\left(k-1, i_{k-1}\right) \otimes V_{\mathbb{Z} \alpha_{k}+a_{k} \alpha_{k} / 2}=\bigoplus_{\substack{0 \leq i_{k} \leq k \\ i_{k} \equiv b_{k}(\bmod 2)}} L\left(c_{k-1}, h_{i_{k-1}+1, i_{k}+1}^{(k-1)}\right) \otimes L_{\widehat{\mathfrak{s}}_{2}}\left(k, i_{k}\right) \tag{3.5}
\end{equation*}
$$

for $0 \leq i_{k-1} \leq k-1$ with $i_{k-1} \equiv b_{k-1}(\bmod 2)$.
We set $i=i_{k-1}$ for simplicity of notation. Since $\left\langle\gamma_{k-1}, \alpha_{k}\right\rangle=0$, the left hand side of (3.5) is

\bigoplus_{j=0}^{k-2} M_{(k-1)}^{i, j} \otimes V_{\mathbb{Z} \gamma_{k-1}+(i-2 j) \gamma_{k-1} / 2(k-1)+\mathbb{Z} \alpha_{k}+a_{k} \alpha_{k} / 2} \tag{3.6}
\end{equation*}
$$

by (2.4) for $k-1$ in place of $k$. Since $\gamma_{k-1}=\gamma_{k}-\alpha_{k}$, and since $\alpha_{k}=\left(\gamma_{k}-d\right) / k$, we have a coset decomposition

with $\left[\mathbb{Z} \gamma_{k-1}+\mathbb{Z} \alpha_{k}: \mathbb{Z} d+\mathbb{Z} \gamma_{k}\right]=k$, and

& \mathbb{Z} \gamma_{k-1}+\frac{i-2 j}{2(k-1)} \gamma_{k-1}+\mathbb{Z} \alpha_{k}+\frac{1}{2} a_{k} \alpha_{k} \\
& =\bigcup_{p=0}^{k-1}\left(\left(\mathbb{Z} d+\frac{1}{2(k-1) k}\left(-(k-1)\left(a_{k}+2 p\right)+i-2 j\right) d\right)\right.  \tag{3.8}\\
& \left.\quad+\left(\mathbb{Z} \gamma_{k}+\frac{1}{2 k}\left(a_{k}+2 p+i-2 j\right) \gamma_{k}\right)\right)
\end{align*}
$$

for $0 \leq j<k-1$. The left hand side of (3.8) is a coset of $\mathbb{Z} \gamma_{k-1}+\mathbb{Z} \alpha_{k}$, and it is determined by $j$ modulo $k-1$, whereas the right hand side is a union of cosets of $\mathbb{Z} d+\mathbb{Z} \gamma_{k}$, and $j$ can not be considered to be modulo $k-1$ for these cosets.

For $0 \leq p<k$, define $0 \leq l<2 k$ by

l \equiv i+a_{k}+2(p-j) \quad(\bmod 2 k) \tag{3.9}
\end{equation*}
$$

Then (3.8) can be written as

$$
\begin{align*}
\mathbb{Z} \gamma_{k-1} & +\frac{i-2 j}{2(k-1)} \gamma_{k-1}+\mathbb{Z} \alpha_{k}+\frac{1}{2} a_{k} \alpha_{k} \\
& =\bigcup_{\substack{0 \leq l<2 k \\
l \equiv i+a_{k}(\bmod 2)}}\left(\left(\mathbb{Z} d-\frac{l}{2 k} d+\frac{i-2 j}{2(k-1)} d\right)+\left(\mathbb{Z} \gamma_{k}+\frac{l}{2 k} \gamma_{k}\right)\right) . \tag{3.10}
\end{align*}
$$

Since $\left\langle d, \gamma_{k}\right\rangle=0$, it follows from (3.6) and (3.10) that

$$
\begin{align*}
& L_{\widehat{\mathfrak{s l}}_{2}}(k-1, i) \otimes V_{\mathbb{Z} \alpha_{k}+a_{k} \alpha_{k} / 2} \\
& \quad=\bigoplus_{j=0}^{k-2} \bigoplus_{\substack{0 \leq l<2 k \\
l \equiv i+a_{k} \\
(\bmod 2)}} M_{(k-1)}^{i, j} \otimes V_{\mathbb{Z} d-l d / 2 k+(i-2 j) d / 2(k-1)} \otimes V_{\mathbb{Z} \gamma_{k}+l \gamma_{k} / 2 k} \tag{3.11}
\end{align*}
$$

Let

$$
U^{i, l}=\left\{v \in L_{\widehat{s l}_{2}}(k-1, i) \otimes V_{\mathbb{Z} \alpha_{k}+a_{k} \alpha_{k} / 2} \mid \gamma_{k}(n) v=l \delta_{n, 0} v \text { for } n \geq 0\right\}
$$

for $0 \leq i \leq k-1,0 \leq l<2 k$, which is the multiplicity of $V_{\mathbb{Z} \gamma_{k}+l \gamma_{k} / 2 k}$ in (3.11). Then

$$
U^{i, l}=\bigoplus_{j=0}^{k-2} M_{(k-1)}^{i, j} \otimes V_{\mathbb{Z} d-l d / 2 k+(i-2 j) d / 2(k-1)}
$$

The index $l$ of $U^{i, l}$ can be considered to be modulo $2 k$.
The right hand side of (3.5) is

$$
\begin{equation*}
\bigoplus_{\substack{0 \leq i_{k} \leq k \\ i_{k} \equiv b_{k}(\bmod 2)}} \bigoplus_{p=0}^{k-1} L\left(c_{k-1}, h_{i_{k-1}+1, i_{k}+1}^{(k-1)}\right) \otimes M_{(k)}^{i_{k, p}} \otimes V_{\mathbb{Z} \gamma_{k}+\left(i_{k}-2 p\right) \gamma_{k} / 2 k} \tag{3.12}
\end{equation*}
$$

by (2.4). Recall that $l$ is defined in (3.9) and that $i=i_{k-1}$ satisfies the condition $i \equiv b_{k-1}$ $(\bmod 2)$. Since $b_{k}=b_{k-1}+a_{k}$, we have $i_{k}-l \in 2 \mathbb{Z}$ for $i_{k}$ such that $i_{k} \equiv b_{k}(\bmod 2)$. Then $V_{\mathbb{Z} \gamma_{k}+\left(i_{k}-2 p\right) \gamma_{k} / 2 k}$ agrees with $V_{\mathbb{Z} \gamma_{k}+l \gamma_{k} / 2 k}$ if and only if $p \equiv\left(i_{k}-l\right) / 2(\bmod k)$. Hence the multiplicity of $V_{\mathbb{Z} \gamma_{k}+l \gamma_{k} / 2 k}$ in (3.12) is

$$
\begin{align*}
\{v \in & \left.\bigoplus_{\substack{0 \leq i_{k} \leq k \\
i_{k} \equiv b_{k}(\bmod 2)}} L\left(c_{k-1}, h_{i+1, i_{k}+1}^{(k-1)}\right) \otimes L_{\widehat{\mathfrak{s} \mathfrak{l}_{2}}}\left(k, i_{k}\right) \mid \gamma_{k}(n) v=l \delta_{n, 0} v \text { for } n \geq 0\right\}  \tag{3.13}\\
& =\bigoplus_{\substack{0 \leq i_{k} \leq k \\
i_{k} \equiv b_{k}(\bmod 2)}} L\left(c_{k-1}, h_{i+1, i_{k}+1}^{(k-1)}\right) \otimes M_{(k)}^{i_{k},\left(i_{k}-l\right) / 2}
\end{align*}
$$

Therefore, the following theorem is proved.

Theorem 3.1. The multiplicity $U^{i, l}$ of $V_{\mathbb{Z} \gamma_{k}+l \gamma_{k} / 2 k}$ on both sides of (3.5) is described in two ways, namely,

$$
\begin{aligned}
U^{i, l} & =\bigoplus_{j=0}^{k-2} M_{(k-1)}^{i, j} \otimes V_{\mathbb{Z} d-l d / 2 k+(i-2 j) d / 2(k-1)} \\
& =\bigoplus_{\substack{0 \leq i_{k} \leq k \\
i_{k} \equiv b_{k}(\bmod 2)}} L\left(c_{k-1}, h_{i+1, i_{k}+1}^{(k-1)}\right) \otimes M_{(k)}^{i_{k},\left(i_{k}-l\right) / 2},
\end{aligned}
$$

for $0 \leq i \leq k-1$ with $i \equiv b_{k-1}(\bmod 2)$, and $0 \leq l<2 k$ with $l \equiv b_{k}(\bmod 2)$. The first one is a direct sum of irreducible $M_{(k-1)}^{0} \otimes V_{\mathbb{Z} d}$-modules, and the second one is a direct sum of irreducible $L\left(c_{k-1}, 0\right) \otimes M_{(k)}^{0}$-modules.

In the case $\boldsymbol{a}(k)=(0, \ldots, 0)$, take the commutant of $S=L\left(c_{1}, 0\right) \otimes \cdots \otimes L\left(c_{k-2}, 0\right)$ in $V_{L^{(k-1)}} \otimes V_{\mathbb{Z} \alpha_{k}}=V_{L^{(k)}}$. Then we have

$$
\begin{equation*}
L_{\widehat{\mathfrak{s}}_{2}}(k-1,0) \otimes V_{\mathbb{Z} \alpha_{k}}=\bigoplus_{j=0}^{\lfloor k / 2\rfloor} L\left(c_{k-1}, h_{1,2 j+1}^{(k-1)}\right) \otimes L_{\widehat{\mathfrak{s}}_{2}}(k, 2 j), \tag{3.14}
\end{equation*}
$$

where $\lfloor k / 2\rfloor$ is the largest integer which does not exceed $k / 2$.
Let $U^{0}$ be the commutant of $V_{\mathbb{Z} \gamma_{k}}$ in (3.14). Then $U^{0}=U^{0,0}$ in the notation of Theorem 3.1. In particular,

$$
\begin{equation*}
U^{0}=\bigoplus_{j=0}^{k-2} M_{(k-1)}^{j} \otimes V_{\mathbb{Z} d-j d /(k-1)} \tag{3.15}
\end{equation*}
$$

which is a $\mathbb{Z}_{k-1}$-graded simple current extension of $M_{(k-1)}^{0} \otimes V_{\mathbb{Z} d}$. Hence the following theorem holds by [27, Theorem 2.14], see also [2], [8, Section 4.4.2].

Theorem 3.2. (1) $U^{0}$ is a simple, self-dual, rational, and $C_{2}$-cofinite vertex operator algebra of CFT-type with central charge $3(k-1) /(k+1)$.
(2) $U^{0}$ is described in two ways, namely,

$$
\begin{aligned}
U^{0} & =\bigoplus_{j=0}^{k-2} M_{(k-1)}^{j} \otimes V_{\mathbb{Z} d-j d /(k-1)} \\
& =\bigoplus_{j=0}^{\lfloor k / 2\rfloor} L\left(c_{k-1}, h_{1,2 j+1}^{(k-1)}\right) \otimes M_{(k)}^{2 j, j} .
\end{aligned}
$$

The first one is a $\mathbb{Z}_{k-1}$-graded simple current extension of $M_{(k-1)}^{0} \otimes V_{\mathbb{Z} d}$, and the second one is a non-simple current extension of $L\left(c_{k-1}, 0\right) \otimes M_{(k)}^{0}$.

The fusion product of irreducible $M_{(k-1)}^{0}$-modules $M_{(k-1)}^{j}$ agrees with the fusion product of irreducible $V_{\mathbb{Z} d}$-modules $V_{\mathbb{Z} d-j d /(k-1)}$ under the correspondence

$$
M_{(k-1)}^{j} \longleftrightarrow V_{\mathbb{Z} d-j d /(k-1)}, \quad 0 \leq j<k-1
$$

Similarly, the fusion product of irreducible $L\left(c_{k-1}, 0\right)$-modules $L\left(c_{k-1}, h_{1,2 j+1}^{(k-1)}\right)$ agrees with the fusion product of irreducible $M_{(k)}^{0}$-modules $M_{(k)}^{2 j, j}$ under the correspondence

$$
L\left(c_{k-1}, h_{1,2 j+1}^{(k-1)}\right) \longleftrightarrow M_{(k)}^{2 j, j}, \quad 0 \leq j \leq\lfloor k / 2\rfloor
$$

In fact, for $0 \leq p \leq q \leq\lfloor k / 2\rfloor$, we have

$$
L\left(c_{k-1}, h_{1,2 p+1}^{(k-1)}\right) \boxtimes_{L\left(c_{k-1}, 0\right)} L\left(c_{k-1}, h_{1,2 q+1}^{(k-1)}\right)=\sum_{j=0}^{\min \{2 p, k-2 q\}} L\left(c_{k-1}, h_{1,2(q-p+j)+1}^{(k-1)}\right)
$$

by (2.1), and

$$
M_{(k)}^{2 p, p} \boxtimes_{M_{(k)}^{0}} M_{(k)}^{2 q, q}=\sum_{j=0}^{\min \{2 p, k-2 q\}} M_{(k)}^{2(q-p+j), q-p+j}
$$

by (2.7).
Since the left hand side of (3.11) is an $L_{\mathfrak{s}_{2}}(k-1,0) \otimes V_{\mathbb{Z} \alpha_{k}}$-module, and since $U^{0}$ is the commutant of $V_{\mathbb{Z} \gamma_{k}}$ in $L_{\widehat{s l}_{2}}(k-1,0) \otimes V_{\mathbb{Z} \alpha_{k}}$, it follows that $U^{i, l}$ is a $U^{0}$-module.

For simplicity of notation, set

$$
\begin{gathered}
A^{j}=M_{(k-1)}^{j} \otimes V_{\mathbb{Z} d-j d /(k-1)} \\
X(i, j, l)=M_{(k-1)}^{i, j} \otimes V_{\mathbb{Z} d-l d / 2 k+(i-2 j) d / 2(k-1)}
\end{gathered}
$$

for $0 \leq i \leq k-1,0 \leq j<k-1$, and $0 \leq l<2 k$. Then $U^{0}=\bigoplus_{j=0}^{k-2} A^{j}$ and $U^{i, l}=\bigoplus_{j=0}^{k-2} X(i, j, l)$ as $A^{0}$-modules. For fixed $i$ and $l, X(i, j, l), 0 \leq j<k-1$, are inequivalent irreducible $A^{0}$-modules. Thus the $U^{0}$-module $U^{i, l}$ is irreducible. In fact, the $U^{0}$-module structure on the direct sum $\bigoplus_{j=0}^{k-2} X(i, j, l)$ which extends the $A^{0}$-module structure is unique [23, Proposition 3.8]. Since

$$
\begin{equation*}
A^{j} \boxtimes_{A^{0}} X(i, 0, l)=X(i, j, l) \tag{3.16}
\end{equation*}
$$

we have

$$
\begin{equation*}
U^{i, l}=U^{0} \boxtimes_{A^{0}} X(i, 0, l) \tag{3.17}
\end{equation*}
$$

The following lemma is a consequence of the isomorphism $M_{(k-1)}^{i, j} \cong M_{(k-1)}^{k-1-i, j-i}$ of $M_{(k-1)}^{0}$-modules in (2.5) for $k-1$ in place of $k$.
Lemma 3.3. (1) Let $0 \leq i, i^{\prime} \leq k-1,0 \leq j, j^{\prime}<k-1$, and $0 \leq l, l^{\prime}<2 k$. Then $X(i, j, l) \cong X\left(i^{\prime}, j^{\prime}, l^{\prime}\right)$ as $A^{0}$-modules if and only if one of the following conditions holds.
(i) $i=i^{\prime}, j=j^{\prime}$, and $l=l^{\prime}$.
(ii) $i^{\prime}=k-1-i, j^{\prime} \equiv j-i(\bmod k-1)$, and $l^{\prime} \equiv k+l(\bmod 2 k)$.
(2) $X(i, j, l), 0 \leq j<i \leq k-1,0 \leq l<2 k$, are inequivalent to each other.

The above lemma implies the next lemma.
Lemma 3.4. Let $0 \leq i, i^{\prime} \leq k-1$ and $0 \leq l, l^{\prime}<2 k$. Then $U^{i, l} \cong U^{i^{\prime}, l^{\prime}}$ as $U^{0}$-modules if and only if one of the following conditions holds.
(i) $i=i^{\prime}$ and $l=l^{\prime}$.
(ii) $i^{\prime}=k-1-i$ and $l^{\prime} \equiv k+l(\bmod 2 k)$.

Next, we calculate the difference of the conformal weight of two irreducible $A^{0}$-modules.

Lemma 3.5. Let $0 \leq i \leq k-1,0 \leq j<k-1$, and $0 \leq s<2(k-1) k$. Then the difference of the conformal weight of $M_{(k-1)}^{i, p} \otimes V_{\mathbb{Z} d+s d / 2(k-1) k-p d /(k-1)}$ for $p=0, j$ is as follows.

$$
\begin{align*}
& h\left(M_{(k-1)}^{i, j} \otimes V_{\mathbb{Z} d+s d / 2(k-1) k-j d /(k-1)}\right)-h\left(M_{(k-1)}^{i, 0} \otimes V_{\mathbb{Z} d+s d / 2(k-1) k}\right) \\
& \quad \equiv \frac{j(i-s)}{k-1} \quad(\bmod \mathbb{Z}) \tag{3.18}
\end{align*}
$$

Indeed, we have $h\left(M_{(k-1)}^{i, j}\right)$ for $0 \leq j \leq i \leq k-1$ by (2.6) for $k-1$ in place of $k$, and $h\left(M_{(k-1)}^{i, j}\right)$ for $0 \leq i \leq j \leq k-1$ is obtained by using (2.5) for $k-1$ in place of $k$. In fact,

$$
h\left(M_{(k-1)}^{i, j}\right)-h\left(M_{(k-1)}^{i, 0}\right) \equiv \frac{j(i-j)}{k-1} \quad(\bmod \mathbb{Z})
$$

Since

$$
h\left(V_{\mathbb{Z} d+s d / 2(k-1) k-j d /(k-1)}\right)-h\left(V_{\mathbb{Z} d+s d / 2(k-1) k}\right) \equiv \frac{j(j-s)}{k-1} \quad(\bmod \mathbb{Z}),
$$

Eq. (3.18) holds.
The following theorem holds, see [2], [ 8, Section 4.4.2], [26, Section 3.1].
Theorem 3.6. (1) Any irreducible $U^{0}$-module is isomorphic to $U^{i, l}$ for some $0 \leq i \leq k-1$, $0 \leq l<2 k$.
(2) The irreducible $U^{0}$-modules $U^{i, l}, 0 \leq i \leq k-1,0 \leq l<2 k$, are inequivalent to each other except for the isomorphism

$$
\begin{equation*}
U^{i, l} \cong U^{k-1-i, k+l} . \tag{3.19}
\end{equation*}
$$

(3) There are exactly $k^{2}$ inequivalent irreducible $U^{0}$-modules.
(4) The conformal weight of any irreducible $U^{0}$-module except for $U^{0}$ is positive.

Proof. Let $W$ be an irreducible $U^{0}$-module. Then $W$ is a direct sum of irreducible $A^{0}$ modules. Let $X$ be an irreducible $A^{0}$-submodule of $W$. We may assume that $X=$ $M_{(k-1)}^{i, 0} \otimes V_{\mathbb{Z} d+s d / 2(k-1) k}$ for some $0 \leq i \leq k-1$ and $0 \leq s<2(k-1) k$ by (3.16). Then

$$
A^{1} \boxtimes_{A^{0}} X=M_{(k-1)}^{i, 1} \otimes V_{\mathbb{Z} d+s d / 2(k-1) k-d /(k-1)}
$$

is contained in $W$, so $h\left(A^{1} \boxtimes_{A^{0}} X\right)-h(X)$ is an integer. Thus $s \equiv i(\bmod k-1)$ by Lemma 3.5. Then $s \equiv i-m(k-1)(\bmod 2(k-1) k)$ for some $0 \leq m<2 k$. Take $0 \leq l<2 k$ such that $l \equiv i+m(\bmod 2 k)$. Then $s \equiv i k-l(k-1)(\bmod 2(k-1) k)$, and $W=U^{i, l}$ by (3.17). Thus the assertion (1) holds.

Lemma 3.4 implies the assertion (2). The assertion (3) is clear from (1) and (2). The conformal weight of any irreducible $M_{(k-1)}^{0}$-module except for $M_{(k-1)}^{0}$ is positive. Thus the assertion (4) holds.

There are $(k-1)^{2} k^{2}$ inequivalent irreducible $A^{0}$-modules, namely,

$$
\operatorname{Irr}\left(A^{0}\right)=\left\{M_{(k-1)}^{i, j} \otimes V_{\mathbb{Z} d+s d / 2(k-1) k} \mid 0 \leq j<i \leq k-1,0 \leq s<2(k-1) k\right\}
$$

Only $(k-1) k^{2}$ of them can be direct summands of an irreducible $U^{0}$-module. In fact, let

$$
\operatorname{Irr}^{0}\left(A^{0}\right)=\{X(i, j, l) \mid 0 \leq j<i \leq k-1,0 \leq l<2 k\} .
$$

Then each irreducible $U^{0}$-module is a direct sum of $k-1$ inequivalent irreducible $A^{0}$ modules in $\operatorname{Irr}^{0}\left(A^{0}\right)$.

Recall the automorphism $\theta$ of $M_{(k)}^{0}$, which is induced from the -1 -isometry $\alpha \mapsto-\alpha$ of the lattice $L^{(k)}$. The isometry induces an automorphism of $U^{0}$ of order two as well. We denote the automorphism by the same symbol $\theta$. Then

$$
\begin{equation*}
U^{i, l} \circ \theta \cong U^{i,-l} \tag{3.20}
\end{equation*}
$$

## 4. Fusion rule of irreducible $U^{0}$-modules

The fusion rule of the irreducible $U^{0}$-modules was previously known [8, Section 4.4.2], see also [26, Section 3.2]. The fusion rule in our notation for the irreducible $U^{0}$-modules is as follows.

Theorem 4.1. Let $0 \leq i_{1}, i_{2} \leq k-1$ and $0 \leq l_{1}, l_{2}<2 k$. Then

$$
\begin{equation*}
U^{i_{1}, l_{1}} \boxtimes_{U^{0}} U^{i_{2}, l_{2}}=\sum_{r \in R\left(i_{1}, i_{2}\right)} U^{r, l_{1}+l_{2}} \tag{4.1}
\end{equation*}
$$

where $R\left(i_{1}, i_{2}\right)$ is the set of integers $r$ satisfying

$$
\left|i_{1}-i_{2}\right| \leq r \leq \min \left\{i_{1}+i_{2}, 2(k-1)-i_{1}-i_{2}\right\}, \quad i_{1}+i_{2}+r \in 2 \mathbb{Z}
$$

and $l_{1}+l_{2}$ is considered to be modulo $2 k$. The irreducible $U^{0}$-modules $U^{r, l_{1}+l_{2}}, r \in R\left(i_{1}, i_{2}\right)$, on the right hand side of (4.1) are inequivalent to each other.

Proof. Let $\mathcal{C}_{A^{0}}$ be the category of $A^{0}$-modules, and let $\mathcal{C}_{A^{0}}^{0}$ be the full subcategory of $\mathcal{C}_{A^{0}}$ consisting of the objects $X$ of $\mathcal{C}_{A^{0}}$ such that $U^{0} \boxtimes_{A^{0}} X$ is a $U^{0}$-module [ 8 , Definition 2.66]. Then $\operatorname{Irr}^{0}\left(A^{0}\right)$ constitutes the simple objects of $\mathcal{C}_{A^{0}}^{0}$ [8, Proposition 2.65]. The category $\mathcal{C}_{A^{0}}^{0}$ is a $\mathbb{C}$-linear additive braided monoidal category with structures induced from $\mathcal{C}_{A^{0}}$, and the functor $F: \mathcal{C}_{A^{0}}^{0} \rightarrow \mathcal{C}_{U^{0}} ; X \mapsto U^{0} \boxtimes_{A^{0}} X$ is a braided tensor functor [8, Theorem 2.67], where $\mathcal{C}_{U^{0}}$ is the category of $U^{0}$-modules.

We fix $0 \leq i_{1}, i_{2} \leq k-1$ and $0 \leq l_{1}, l_{2}<2 k$. Since the category $\mathcal{C}_{A^{0}}^{0}$ is closed under the fusion product, we have

$$
\begin{equation*}
X\left(i_{1}, 0, l_{1}\right) \boxtimes_{A^{0}} X\left(i_{2}, 0, l_{2}\right)=\sum_{X\left(i_{3}, j_{3}, l_{3}\right) \in \operatorname{Ir}^{0}\left(A^{0}\right)} n\left(i_{3}, j_{3}, l_{3}\right) X\left(i_{3}, j_{3}, l_{3}\right), \tag{4.2}
\end{equation*}
$$

where

$$
n\left(i_{3}, j_{3}, l_{3}\right)=\operatorname{dim} I_{A^{0}}\left(\begin{array}{c}
X\left(i_{3}, j_{3}, l_{3}\right) \\
X\left(i_{1}, 0, l_{1}\right)
\end{array} \quad X\left(i_{2}, 0, l_{2}\right)\right)
$$

is the fusion rule, that is, the dimension of the space of intertwining operators of type $\left(\underset{X\left(i_{1}, 0, l_{1}\right)}{X\left(i_{3}, j_{3}, l_{3}\right)} \underset{X\left(i_{2}, 0, l_{2}\right)}{ }\right)$. Let

$$
n\left(i_{3}, l_{3}\right)=\operatorname{dim} I_{U^{0}}\left(\begin{array}{c}
U^{i_{3}, l_{3}} \\
U^{i_{1}, l_{1}}
\end{array} U^{i_{2}, l_{2}}\right)
$$

be the fusion rule of the irreducible $U^{0}$-modules $U^{i_{p}, l_{p}}, p=1,2,3$. Then

$$
\begin{equation*}
U^{i_{1}, l_{1}} \boxtimes_{U^{0}} U^{i_{2}, l_{2}}=\sum_{U^{i}, l_{3} \in \operatorname{Irr}\left(U^{0}\right)} n\left(i_{3}, l_{3}\right) U^{i_{3}, l_{3}} \tag{4.3}
\end{equation*}
$$

Since $U^{i, l}=U^{0} \boxtimes_{A^{0}} X(i, j, l)$ for any $0 \leq j<k-1$, and since the functor $F: \mathcal{C}_{A^{0}}^{0} \rightarrow \mathcal{C}_{U^{0}}$; $X \mapsto U^{0} \boxtimes_{A^{0}} X$ is a braided tensor functor, it follows from (4.2) that

$$
U^{i_{1}, l_{1}} \boxtimes_{U^{0}} U^{i_{2}, l_{2}}=\sum_{X\left(i_{3}, j_{3}, l_{3}\right) \in \operatorname{Trr}^{0}\left(A^{0}\right)} n\left(i_{3}, j_{3}, l_{3}\right) U^{i_{3}, l_{3}} .
$$

Thus $n\left(i_{3}, l_{3}\right)=\sum_{j_{3}=0}^{k-2} n\left(i_{3}, j_{3}, l_{3}\right)$ by (4.3).
Now,

$$
\left.\begin{array}{rl}
n\left(i_{3}, j_{3}, l_{3}\right)= & \operatorname{dim} I_{M_{(k-1)}^{0}}\left(\begin{array}{c}
M_{(k-1)}^{i_{3}, j_{3}} \\
M_{(k-1)}^{i_{1}, 0}
\end{array} M_{(k-1)}^{i_{2}, 0}\right.
\end{array}\right)
$$

by [⿴囗 1 , and it is 1 if and only if $i_{3} \in R\left(i_{1}, i_{2}\right)$ and $i_{3}-2 j_{3} \equiv i_{1}+i_{2}(\bmod 2(k-1))$ by (2.7) for $k-1$ in place of $k$. The second term of the right hand side is 0 or 1 , and it is 1 if and only if

$$
\begin{equation*}
-\left(l_{1}+l_{2}\right)(k-1)+\left(i_{1}+i_{2}\right) k \equiv-l_{3}(k-1)+\left(i_{3}-2 j_{3}\right) k \quad(\bmod 2(k-1) k) \tag{4.4}
\end{equation*}
$$

by the fusion rule for $V_{\mathbb{Z} d}$ [11, Chapter 12]. Hence $n\left(i_{3}, j_{3}, l_{3}\right)$ is 0 or 1 , and it is 1 if and only if $i_{3} \in R\left(i_{1}, i_{2}\right), i_{3}-2 j_{3} \equiv i_{1}+i_{2}(\bmod 2(k-1))$, and the condition (4.4) is satisfied.

If $i_{3} \in R\left(i_{1}, i_{2}\right)$, then there is a unique $0 \leq j_{3}<k-1$ such that $i_{3}-2 j_{3} \equiv i_{1}+i_{2}$ $(\bmod 2(k-1))$. Moreover, if $i_{3}-2 j_{3} \equiv i_{1}+i_{2}(\bmod 2(k-1))$, then the condition (4.4) is equivalent to the condition that $l_{1}+l_{2} \equiv l_{3}(\bmod 2 k)$. Therefore, (4.1) holds.

We have the following two corollaries.
Corollary 4.2. Let $\zeta=\exp (2 \pi \sqrt{-1} / k)$. Then the $\operatorname{map} \varphi: U^{i, l} \mapsto \zeta^{l} U^{i, l}$ for $0 \leq i \leq k-1$ and $0 \leq l<2 k$ defines an automorphism of the fusion algebra of $U^{0}$ of order $k$ which is compatible with the isomorphism (3.19).

Corollary 4.3. There are exactly $2 k$ inequivalent simple current $U^{0}$-modules, which are represented by $U^{0, l}, 0 \leq l<2 k$.

Let $U^{l}=U^{0, l}$. Then

$$
\begin{align*}
U^{l} & =\bigoplus_{j=0}^{k-2} M_{(k-1)}^{j} \otimes V_{\mathbb{Z} d-l d / 2 k-j d /(k-1)}  \tag{4.5}\\
& =U^{0} \boxtimes_{A^{0}} X(0,0, l),
\end{align*}
$$

and the set of equivalence classes of simple current $U^{0}$-modules is

$$
\begin{equation*}
\operatorname{Irr}\left(U^{0}\right)_{\mathrm{sc}}=\left\{U^{l} \mid 0 \leq l<2 k\right\} \quad \text { with } \quad U^{l} \boxtimes_{U^{0}} U^{l^{\prime}}=U^{l+l^{\prime}} \tag{4.6}
\end{equation*}
$$

The conformal weight of $U^{l}$ satisfies $h\left(U^{l}\right) \equiv h(X(0,0, l))(\bmod \mathbb{Z})$ by (4.5). Hence we have

$$
\begin{equation*}
h\left(U^{l}\right) \equiv \frac{(k-1) l^{2}}{4 k} \quad(\bmod \mathbb{Z}) \tag{4.7}
\end{equation*}
$$

Since

$$
\begin{equation*}
U^{p} \boxtimes_{U^{0}} U^{i, l}=U^{i, l+p} \tag{4.8}
\end{equation*}
$$

by (4.1), the isomorphism (3.19) implies the next lemma.
Lemma 4.4. Let $0 \leq i \leq k-1$ and $0 \leq p, l<2 k$. Then $U^{p} \boxtimes_{U^{0}} U^{i, l}=U^{i, l}$ if and only if one of the following conditions holds.
(i) $p=0$.
(ii) $k$ is odd, $i=(k-1) / 2$, and $p=k$.

The fusion rules of $M_{(k-1)}^{0}$-modules are illustrated as follows. We set $M^{0}=M_{(k-1)}^{0}$ and $M^{i, j}=M_{(k-1)}^{i, j}$ for simplicity of notation. The irreducible $M^{0}$-modules are denoted as $M^{i, j}$ by using $0 \leq i \leq k-1$ and $0 \leq j<k-1$. There is another description of the irreducible $M^{0}$-modules. Take $0 \leq q<2(k-1)$ such that $q \equiv i-2 j(\bmod 2(k-1))$. Let $\widetilde{M}^{i, q}=M^{i, j}$, which is the multiplicity of $V_{\mathbb{Z} \gamma_{k-1}+q \gamma_{k-1} / 2(k-1)}$ in the decomposition (2.4) of $L_{\widehat{\mathfrak{s l}}_{2}}(k-1, i)$. Then the fusion product (2.7) for $k-1$ in place of $k$ can be written as

$$
\begin{equation*}
\widetilde{M}^{i_{1}, q_{1}} \boxtimes_{M^{0}} \widetilde{M}^{i_{2}, q_{2}}=\sum_{r \in R\left(i_{1}, i_{2}\right)} \widetilde{M}^{r, q_{1}+q_{2}} . \tag{4.9}
\end{equation*}
$$

The relationship between (4.1) and (4.9) is clear. Moreover, the isomorphisms $M^{i, j} \cong$ $M^{k-1-i, j-i}$ and $M^{i, j} \circ \theta \cong M^{i, i-j}$ can be written as

$$
\widetilde{M}^{i, q} \cong \widetilde{M}^{k-1-i, k-1+q}, \quad \widetilde{M}^{i, q} \circ \theta \cong \widetilde{M}^{i,-q} .
$$

It is known that a map defined by $\widetilde{M}^{i, q} \mapsto \eta^{q} \widetilde{M}^{i, q}$ with $\eta=\exp (2 \pi \sqrt{-1} /(k-1))$ is compatible with the isomorphism $\widetilde{M}^{i, q} \cong \widetilde{M}^{k-1-i, k-1+q}$, and it induces an automorphism of the fusion algebra of $M^{0}$ of order $k-1$.

## 5. Vertex operator (Super)algebra $U_{D}$

In this section, we introduce a positive definite integral lattice $\Gamma_{D}$ and a vertex operator algebra or a vertex operator superalgebra $U_{D}$ for a $\mathbb{Z}_{2 k}$-code $D$.
5.1. Irreducible $U^{0}$-modules in $V_{N^{\circ}}$. Let $L^{(k)}$ be the lattice as in (2.2). We set

$$
N=\left\{\alpha \in L^{(k)} \mid\left\langle\alpha, \gamma_{k}\right\rangle=0\right\}
$$

where $\gamma_{k} \in L^{(k)}$ is as in (3.1). We denote the dual lattice of $N$ by $N^{\circ}$. The lattice $N$ is also considered in Section 4 of [5], where $L^{(k)}$ and $\gamma_{k}$ are denoted by $L$ and $\gamma$, respectively. We show how the irreducible $U^{0}$-modules $U^{i, l}$ appear in the $V_{N}$-module $V_{N^{\circ}}$.

For $0 \leq j<k$ and $\boldsymbol{a}=\boldsymbol{a}(k)=\left(a_{1}, \ldots, a_{k}\right) \in\{0,1\}^{k}$, let

$$
N(j, \boldsymbol{a}(k))=N+\delta_{\boldsymbol{a}(k)}-j \alpha_{k}+\frac{2 j-b_{k}}{2 k} \gamma_{k}
$$

be a coset of $N$ in $N^{\circ}$, which is identical with $N(j, \boldsymbol{a})$ of (4.4) in [0] as $\delta_{\boldsymbol{a}(k)}=\frac{1}{2} \sum_{p=1}^{k} a_{p} \alpha_{p}$ and $\operatorname{wt}(\boldsymbol{a}(k))=b_{k}$. We have

$$
V_{L^{(k)}+\delta_{\boldsymbol{a}(k)}}=\bigoplus_{j=0}^{k-1} V_{N(j, \boldsymbol{a}(k))} \otimes V_{\mathbb{Z} \gamma_{k}+\left(b_{k}-2 j\right) \gamma_{k} / 2 k}
$$

by (5.2) of [5]. Let $0 \leq l<2 k$ be such that $l \equiv b_{k}-2 j(\bmod 2 k)$. Then $j \equiv\left(b_{k}-l\right) / 2$ $(\bmod k)$, and the multiplicity of $V_{\mathbb{Z} \gamma_{k}+l \gamma_{k} / 2 k}$ in $V_{L^{(k)}+\delta_{\boldsymbol{a}(k)}}$ is $V_{N\left(\left(b_{k}-l\right) / 2, \boldsymbol{a}(k)\right)}$. Therefore,

$$
U^{i, l}=\left\{v \in V_{N\left(\left(b_{k}-l\right) / 2, a(k)\right)} \mid \omega_{(1)}^{s} v=h_{i_{s}+1, i_{s+1}+1}^{(s)} v, 1 \leq s \leq k-2\right\}
$$

with $i=i_{k-1}$ by (3.4) and (3.13). In the case where $a_{1}=\cdots=a_{k-2}=0$, we have $b_{k-1}=a_{k-1}$ and $b_{k}=a_{k-1}+a_{k}$. Thus the following lemma holds.

Lemma 5.1. Let $0 \leq i \leq k-1$ and $0 \leq l<2 k$.
(1) Define $a_{k-1}, a_{k} \in\{0,1\}$, and $0 \leq j<k$ by the conditions

$$
\begin{equation*}
i \equiv a_{k-1}, l \equiv a_{k-1}+a_{k} \quad(\bmod 2), \quad j \equiv\left(a_{k-1}+a_{k}-l\right) / 2 \quad(\bmod k) \tag{5.1}
\end{equation*}
$$

Then

$$
U^{i, l}=\left\{v \in V_{N\left(j,\left(0, \ldots, 0, a_{k-1}, a_{k}\right)\right)} \mid \omega_{(1)}^{s} v=0,1 \leq s \leq k-3, \omega_{(1)}^{k-2} v=h_{1, i+1}^{(k-2)} v\right\} .
$$

(2) In the case $i=0$, we have $a_{k-1}=0, l \equiv a_{k}(\bmod 2)$, and $j \equiv\left(a_{k}-l\right) / 2(\bmod k)$. In particular,

$$
U^{l}=\left\{v \in V_{N\left(j,\left(0, \ldots, 0, a_{k}\right)\right)} \mid \omega_{(1)}^{s} v=0,1 \leq s \leq k-2\right\}
$$

In the assertion (2) of the above lemma, we have $N\left(j,\left(0, \ldots, 0, a_{k}\right)\right)=N-l d / 2 k$, as $d=\gamma_{k}-k \alpha_{k}$. Thus

$$
\begin{equation*}
U^{l}=\left\{v \in V_{N-l d / 2 k} \mid \omega_{(1)}^{s} v=0,1 \leq s \leq k-2\right\} . \tag{5.2}
\end{equation*}
$$

5.2. $\Gamma_{D}$ and $U_{D}$. The arguments in this subsection are parallel to those in Section 7 of [5]. For simplicity of notation, set

$$
\tilde{N}^{(l)}=N-l d / 2 k, \quad 0 \leq l<2 k .
$$

We can regard the index $l$ of $\tilde{N}^{(l)}$ as $l \in \mathbb{Z}_{2 k}$. Since $\langle x, y\rangle \in 2 \mathbb{Z}$ and $\langle x, d / 2 k\rangle \in \mathbb{Z}$ for $x, y \in N$, and since $\langle d, d\rangle=2(k-1) k$, the following lemma holds.
Lemma 5.2. Let $0 \leq p, q<2 k$.
(1) $\langle\alpha, \beta\rangle \in \frac{k-1}{2 k} p q+\mathbb{Z}$ for $\alpha \in \tilde{N}^{(p)}$ and $\beta \in \widetilde{N}^{(q)}$.
(2) $\langle\alpha, \alpha\rangle \in \frac{k-1}{2 k} p^{2}+2 \mathbb{Z}$ for $\alpha \in \widetilde{N}^{(p)}$.

We fix a positive integer $\ell$. Define a $\operatorname{coset} \widetilde{N}(\xi)$ of $N^{\ell}$ in $\left(N^{\circ}\right)^{\ell}$ by

$$
\widetilde{N}(\xi)=\left\{\left(x_{1}, \ldots, x_{\ell}\right) \mid x_{r} \in \tilde{N}^{\left(\xi_{r}\right)}, 1 \leq r \leq \ell\right\}
$$

for $\xi=\left(\xi_{1}, \ldots, \xi_{\ell}\right) \in\left(\mathbb{Z}_{2 k}\right)^{\ell}$. Then $\tilde{N}(\xi)+\widetilde{N}(\eta)=\tilde{N}(\xi+\eta)$ for $\xi, \eta \in\left(\mathbb{Z}_{2 k}\right)^{\ell}$.
For $\xi=\left(\xi_{1}, \ldots, \xi_{\ell}\right), \eta=\left(\eta_{1}, \ldots, \eta_{\ell}\right) \in \mathbb{Z}^{\ell}$, define an integer $\xi \cdot \eta$ by

$$
\xi \cdot \eta=\xi_{1} \eta_{1}+\cdots+\xi_{\ell} \eta_{\ell}
$$

and consider a $\mathbb{Z}$-bilinear map

$$
\mathbb{Z}^{\ell} \times \mathbb{Z}^{\ell} \rightarrow \mathbb{Q} / \mathbb{Z} ; \quad(\xi, \eta) \mapsto \frac{k-1}{2 k} \xi \cdot \eta+\mathbb{Z}
$$

Since $\frac{k-1}{2 k} \xi_{r} \eta_{r}+\mathbb{Z}$ depends only on $\xi_{r}$ and $\eta_{r}$ modulo $2 k$, the above $\mathbb{Z}$-bilinear map induces a $\mathbb{Z}$-bilinear map

$$
\left(\mathbb{Z}_{2 k}\right)^{\ell} \times\left(\mathbb{Z}_{2 k}\right)^{\ell} \rightarrow \mathbb{Q} / \mathbb{Z} ; \quad(\xi, \eta) \mapsto \frac{k-1}{2 k} \xi \cdot \eta+\mathbb{Z}
$$

where $\xi \cdot \eta=\xi_{1} \eta_{1}+\cdots+\xi_{\ell} \eta_{\ell}$ is considered for integers $\xi_{r}, \eta_{r}$ such that $0 \leq \xi_{r}, \eta_{r}<2 k$, $1 \leq r \leq \ell$. The $\mathbb{Z}$-bilinear map is non-degenerate if $k$ is even, whereas it is degenerate with radical $\{0, k\}^{\ell}$ if $k$ is odd. The following lemma holds by Lemma 5.2.

Lemma 5.3. Let $\xi, \eta \in\left(\mathbb{Z}_{2 k}\right)^{\ell}$.
(1) $\langle\alpha, \beta\rangle \in \frac{k-1}{2 k} \xi \cdot \eta+\mathbb{Z}$ for $\alpha \in \widetilde{N}(\xi)$ and $\beta \in \widetilde{N}(\eta)$.
(2) $\langle\alpha, \alpha\rangle \in \frac{k-1}{2 k} \xi \cdot \xi+2 \mathbb{Z}$ for $\alpha \in \widetilde{N}(\xi)$.

Let $(\xi \mid \eta)=\xi_{1} \eta_{1}+\cdots+\xi_{\ell} \eta_{\ell} \in \mathbb{Z}_{2 k}$ be the standard inner product of $\xi=\left(\xi_{1}, \ldots, \xi_{\ell}\right)$ and $\eta=\left(\eta_{1}, \ldots, \eta_{\ell}\right) \in\left(\mathbb{Z}_{2 k}\right)^{\ell}$. Then $\frac{1}{2 k}(\xi \mid \eta)+\mathbb{Z}$ makes sense, and

$$
\frac{1}{2 k}(\xi \mid \eta)+\mathbb{Z}=\frac{1}{2 k} \xi \cdot \eta+\mathbb{Z}
$$

The inner product $(\xi \mid \eta)$ will be used in Section 6 .
Remark 5.4. The Euclidean weight $\operatorname{wt}_{\mathrm{E}}(\xi)$ of $\xi=\left(\xi_{1}, \ldots, \xi_{\ell}\right) \in\left(\mathbb{Z}_{2 k}\right)^{\ell}$ is defined as

$$
\mathrm{wt}_{\mathrm{E}}(\xi)=\sum_{r=1}^{\ell} \min \left\{\xi_{r}^{2},\left(2 k-\xi_{r}\right)^{2}\right\} \in \mathbb{Z}
$$

where $\xi_{r}$ are considered to be integers such that $0 \leq \xi_{r}<2 k, 1 \leq r \leq \ell$. Note that $\frac{1}{2 k} \mathrm{wt}_{\mathrm{E}}(\xi)+2 \mathbb{Z}=\frac{1}{2 k} \xi \cdot \xi+2 \mathbb{Z}$. The Euclidean weight was used in 21.

Let $D$ be a $\mathbb{Z}_{2 k}$-code of length $\ell$, that is, $D$ is an additive subgroup of $\left(\mathbb{Z}_{2 k}\right)^{\ell}$. Set

$$
\Gamma_{D}=\bigcup_{\xi \in D} \tilde{N}(\xi)
$$

which is a sublattice of $\left(N^{\circ}\right)^{\ell}$. We consider two cases, namely,
Case A. $\frac{k-1}{2 k} \xi \cdot \xi \in 2 \mathbb{Z}$ for all $\xi \in D$.
Case B. $\frac{k-1}{2 k} \xi \cdot \eta \in \mathbb{Z}$ for all $\xi, \eta \in D$, and $\frac{k-1}{2 k} \xi \cdot \xi \in 2 \mathbb{Z}+1$ for some $\xi \in D$.
Lemma 5.3 implies the following lemma.
Lemma 5.5. (1) $\Gamma_{D}$ is a positive definite even lattice if and only if $D$ is in Case $A$.
(2) $\Gamma_{D}$ is a positive definite odd lattice if and only if $D$ is in Case $B$.

In Case $\mathrm{A}, V_{\Gamma_{D}}$ is a vertex operator algebra. In Case B, set

$$
D^{0}=\left\{\xi \in D \left\lvert\, \frac{k-1}{2 k} \xi \cdot \xi \in 2 \mathbb{Z}\right.\right\}, \quad D^{1}=\left\{\xi \in D \left\lvert\, \frac{k-1}{2 k} \xi \cdot \xi \in 2 \mathbb{Z}+1\right.\right\}
$$

Then $D^{0}$ is a subgroup of $D$, and $D=D^{0} \cup D^{1}$ is the coset decomposition of $D$ by $D^{0}$. Let $\Gamma_{D^{p}}=\bigcup_{\xi \in D^{p}} \widetilde{N}(\xi), p=0,1$. Then $V_{\Gamma_{D}}=V_{\Gamma_{D^{0}}} \oplus V_{\Gamma_{D^{1}}}$ is a vertex operator superalgebra.

We have $V_{\widetilde{N}(\xi)}=V_{\widetilde{N}\left(\xi_{1}\right)} \otimes \cdots \otimes V_{\widetilde{N}\left(\xi_{\ell}\right)} \subset\left(V_{N^{\circ}}\right)^{\otimes \ell}$, and $V_{\Gamma_{D}}=\bigoplus_{\xi \in D} V_{\widetilde{N}(\xi)}$. Let

$$
U_{\xi}=\left\{v \in V_{\widetilde{N}(\xi)} \mid\left(\omega_{S^{\otimes \ell}}\right)_{(1)} v=0\right\}
$$

where $\omega_{S \otimes \ell}$ is the conformal vector of the vertex operator subalgebra $S^{\otimes \ell}$ of $\left(V_{N}\right)^{\otimes \ell}$ with $S=L\left(c_{1}, 0\right) \otimes \cdots \otimes L\left(c_{k-2}, 0\right)$. Then $U_{\xi}=U^{\xi_{1}} \otimes \cdots \otimes U^{\xi_{\ell}}$ by (5.2). In particular, $U_{\mathbf{0}}=\left(U^{0}\right)^{\otimes \ell}$ for the zero codeword $\mathbf{0}=(0, \ldots, 0)$. We see from (4.6) that the set of equivalence classes of simple current $U_{0}$-modules is

$$
\operatorname{Irr}\left(U_{\mathbf{0}}\right)_{\mathrm{sc}}=\left\{U_{\xi} \mid \xi \in\left(\mathbb{Z}_{2 k}\right)^{\ell}\right\} \quad \text { with } \quad U_{\xi} \boxtimes_{U_{0}} U_{\xi^{\prime}}=U_{\xi+\xi^{\prime}}
$$

The conformal weight $h\left(U_{\xi}\right)$ of $U_{\xi}$ is

$$
h\left(U_{\xi}\right) \equiv \frac{k-1}{4 k} \xi \cdot \xi \quad(\bmod \mathbb{Z})
$$

by (4.7). Hence $h\left(U_{\xi}\right) \in \mathbb{Z}$ for $\xi \in D$ if $D$ is in Case A .
The next proposition follows from Theorems 3.2 and 3.6.
Proposition 5.6. $U_{0}=\left(U^{0}\right)^{\otimes \ell}$ is a simple, self-dual, rational, and $C_{2}$-cofinite vertex operator algebra of CFT-type with central charge $3 \ell(k-1) /(k+1)$. Any irreducible $U_{0}$ module except for $U_{\mathbf{0}}$ itself has positive conformal weight.

Let $U_{D}$ be the commutant of $S^{\otimes \ell}$ in $V_{\Gamma_{D}}$. Then

$$
U_{D}=\left\{v \in V_{\Gamma_{D}} \mid\left(\omega_{S \otimes \ell}\right)_{(1)} v=0\right\}=\bigoplus_{\xi \in D} U_{\xi}
$$

so $U_{D}$ is a $D$-graded simple current extension of $U_{\mathbf{0}}$. We have the next theorem.
Theorem 5.7. (1) If $D$ is in Case $A$, then $U_{D}$ is a simple, self-dual, rational, and $C_{2}{ }^{-}$ cofinite vertex operator algebra of CFT-type with central charge $3 \ell(k-1) /(k+1)$.
(2) If $D$ is in Case $B$, then $U_{D}=U_{D^{0}} \oplus U_{D^{1}}$ is a simple vertex operator superalgebra. The even part $U_{D^{0}}$ and the odd part $U_{D^{1}}$ are given by $U_{D^{p}}=\bigoplus_{\xi \in D^{p}} U_{\xi}, p=0,1$, and $h\left(M_{D^{1}}\right) \in \mathbb{Z}+1 / 2$.

## 6. Representations of $U_{D}$

In this section, we construct all the irreducible $\chi$-twisted $U_{D}$-modules for $\chi \in D^{*}$ in $V_{\left(N^{\circ}\right)^{\ell}}$, and classify them, where $D^{*}=\operatorname{Hom}\left(D, \mathbb{C}^{\times}\right)$. We argue as in Sections 8 and 9 of [5].
6.1. Irreducible $U_{D}$-modules: Case $\mathbf{A}$. Let $D$ be a $\mathbb{Z}_{2 k}$-code of length $\ell$ in Case A of Section 5.2. Let $b_{U^{0}}: \operatorname{Irr}\left(U^{0}\right)_{\mathrm{sc}} \times \operatorname{Irr}\left(U^{0}\right) \rightarrow \mathbb{Q} / \mathbb{Z}$ be a map defined by

$$
b_{U^{0}}\left(U^{p}, U^{i, l}\right)=h\left(U^{p} \boxtimes_{U^{0}} U^{i, l}\right)-h\left(U^{p}\right)-h\left(U^{i, l}\right)+\mathbb{Z}
$$

for $0 \leq i \leq k-1$ and $0 \leq p, l<2 k$. Since $h\left(U^{i, l}\right) \equiv h(X(i, 0, l))(\bmod \mathbb{Z})$ by (3.17), we obtain by using (4.7) and (4.8) that

$$
\begin{equation*}
b_{U^{0}}\left(U^{p}, U^{i, l}\right)=p((k-1) l-k i) / 2 k+\mathbb{Z} \tag{6.1}
\end{equation*}
$$

Any irreducible $U_{0}$ module is of the form

$$
U_{\mu, \nu}=U^{\mu_{1}, \nu_{1}} \otimes \cdots \otimes U^{\mu_{\ell}, \nu_{\ell}}
$$

for some $\mu=\left(\mu_{1}, \ldots, \mu_{\ell}\right)$ with $0 \leq \mu_{r} \leq k-1,1 \leq r \leq \ell$, and $\nu=\left(\nu_{1}, \ldots, \nu_{\ell}\right) \in\left(\mathbb{Z}_{2 k}\right)^{\ell}$. We have $U_{\mathbf{0}, \xi}=U_{\xi}$, and

$$
U_{\xi} \boxtimes_{U_{\mathbf{0}}} U_{\mu, \nu}=U_{\mu, \nu+\xi}
$$

by (4.8). Define a map $b_{U_{0}}: \operatorname{Irr}\left(U_{\mathbf{0}}\right)_{\mathrm{sc}} \times \operatorname{Irr}\left(U_{\mathbf{0}}\right) \rightarrow \mathbb{Q} / \mathbb{Z}$ by

$$
b_{U_{0}}\left(U_{\xi}, U_{\mu, \nu}\right)=h\left(U_{\xi} \boxtimes_{U_{0}} U_{\mu, \nu}\right)-h\left(U_{\xi}\right)-h\left(U_{\mu, \nu}\right)+\mathbb{Z}
$$

Then it follows from (6.1) that

$$
\begin{equation*}
b_{U_{\mathbf{0}}}\left(U_{\xi}, U_{\mu, \nu}\right)=\frac{1}{2 k}(\xi \mid(k-1) \nu-k \mu)+\mathbb{Z} \tag{6.2}
\end{equation*}
$$

where $(\cdot \mid \cdot)$ is the standard inner product on $\left(\mathbb{Z}_{2 k}\right)^{\ell}$. Although each entry $\mu_{r}$ of $\mu$ is an integer such that $0 \leq \mu_{r} \leq k-1$, we can treat it as an element of $\mathbb{Z}_{2 k}$ on the right hand side of (6.2). Since $U_{\eta}=U_{\mathbf{0}, \eta}$ for $\eta \in\left(\mathbb{Z}_{2 k}\right)^{\ell}$, this in particular implies that

$$
b_{U_{\mathbf{0}}}\left(U_{\xi}, U_{\eta}\right)=\frac{k-1}{2 k}(\xi \mid \eta)+\mathbb{Z} .
$$

Let $D^{\perp}=\left\{\eta \in\left(\mathbb{Z}_{2 k}\right)^{\ell} \mid(D \mid \eta)=0\right\}$. Then $|D|\left|D^{\perp}\right|=\left|\left(\mathbb{Z}_{2 k}\right)^{\ell}\right|$, as $(\cdot \mid \cdot)$ is a nondegenerate bilinear form on $\left(\mathbb{Z}_{2 k}\right)^{\ell}$. Consider a map

$$
\chi_{U_{\mu, \nu}}: D \rightarrow \mathbb{C}^{\times} ; \quad \xi \mapsto \exp \left(2 \pi \sqrt{-1} b_{U_{\mathbf{0}}}\left(U_{\xi}, U_{\mu, \nu}\right)\right)
$$

We have

$$
\begin{equation*}
\chi_{U_{\mu, \nu}}(\xi)=\exp (2 \pi \sqrt{-1}(\xi \mid(k-1) \nu-k \mu) / 2 k) \tag{6.3}
\end{equation*}
$$

by (6.2). Hence $\chi_{U_{\mu, \nu}} \in D^{*}$.
Lemma 6.1. (1) $\chi_{U_{\mu, \nu}}=1$; the principal character of $D$ if and only if $(k-1) \nu-k \mu \in D^{\perp}$.
(2) For any $\chi \in D^{*}$, there exists $U_{\mu, \nu} \in \operatorname{Irr}\left(U_{\mathbf{0}}\right)$ such that $\chi=\chi_{U_{\mu, \nu}}$.

Proof. The assertion (1) is a consequence of (6.3) and the definition of $D^{\perp}$. For any $0 \leq p<2 k$, we have $p \equiv(k-1) l-k i(\bmod 2 k)$ for some $0 \leq i \leq k-1$ and $0 \leq l<2 k$. Hence for any $\eta \in\left(\mathbb{Z}_{2 k}\right)^{\ell}$, there are $\mu=\left(\mu_{1}, \ldots, \mu_{\ell}\right)$ with $0 \leq \mu_{r} \leq k-1,1 \leq r \leq \ell$, and $\nu \in\left(\mathbb{Z}_{2 k}\right)^{\ell}$ such that $\eta=(k-1) \nu-k \mu$. Since $(\cdot \mid \cdot)$ is non-degenerate on $\left(\mathbb{Z}_{2 k}\right)^{\ell}$, the assertion (2) holds.

We consider a coset

$$
N\left(\eta, \delta^{(1)}, \delta^{(2)}\right)=\left\{\left(x_{1}, \ldots, x_{\ell}\right) \mid x_{r} \in N\left(\eta_{r},\left(0, \ldots, 0, d_{r}^{(1)}, d_{r}^{(2)}\right)\right), 1 \leq r \leq \ell\right\}
$$

of $N^{\ell}$ in $\left(N^{\circ}\right)^{\ell}$ for $\eta=\left(\eta_{1}, \ldots, \eta_{\ell}\right) \in\left(\mathbb{Z}_{k}\right)^{\ell}$ and $\delta^{(s)}=\left(d_{1}^{(s)}, \ldots, d_{\ell}^{(s)}\right) \in\{0,1\}^{\ell}, s=1,2$. The next proposition holds by Lemma 5.1.
Proposition 6.2. Let $\mu=\left(\mu_{1}, \ldots, \mu_{\ell}\right)$ with $0 \leq \mu_{r} \leq k-1,1 \leq r \leq \ell$, and let $\nu=\left(\nu_{1}, \ldots, \nu_{\ell}\right) \in\left(\mathbb{Z}_{2 k}\right)^{\ell}$. Define $d_{r}^{(1)}, d_{r}^{(2)} \in\{0,1\}$, and $0 \leq \eta_{r}<k$ by the conditions

$$
\mu_{r} \equiv d_{r}^{(1)}, \nu_{r} \equiv d_{r}^{(1)}+d_{r}^{(2)} \quad(\bmod 2), \quad \eta_{r} \equiv\left(d_{r}^{(1)}+d_{r}^{(2)}-\nu_{r}\right) / 2 \quad(\bmod k)
$$

for $1 \leq r \leq \ell$. Then $V_{N\left(\eta, \delta^{(1)}, \delta^{(2)}\right)}$ contains the irreducible $U_{0}$-module $U_{\mu, \nu}$.
Let $0 \leq i \leq k-1$ and $0 \leq p, l<2 k$. Define $a_{k-1}, a_{k} \in\{0,1\}$, and $0 \leq j<k$ by the conditions (5.1). Then

$$
\langle\alpha, \beta\rangle \in p((k-1) l-k i) / 2 k+\mathbb{Z}
$$

for $\alpha \in \tilde{N}^{(p)}$ and $\beta \in N\left(j,\left(0, \ldots, 0, a_{k-1}, a_{k}\right)\right)$. Thus the the following lemma holds by (6.2).

Lemma 6.3. Let $\mu, \nu, \eta, \delta^{(1)}$, and $\delta^{(2)}$ be as in Proposition 6.8, and let $\xi \in\left(\mathbb{Z}_{2 k}\right)^{\ell}$. Then $\langle x, y\rangle \in b_{U_{\mathbf{0}}}\left(U_{\xi}, U_{\mu, \nu}\right)$ for $x \in \widetilde{N}(\xi)$ and $y \in N\left(\eta, \delta^{(1)}, \delta^{(2)}\right)$.

Let $X \in \operatorname{Irr}\left(U_{\mathbf{0}}\right)$. Then $X=U_{\mu, \nu}$ for some $\mu$ and $\nu$. Let $\eta, \delta^{(1)}$, and $\delta^{(2)}$ be as in Proposition 6.2. Then $X$ is contained in $V_{N\left(\eta, \delta^{(1)}, \delta^{(2)}\right)}$. Since $U_{\xi}$ is contained in $V_{\widetilde{N}(\xi)}$, and since the cosets $\widetilde{N}(\xi)+N\left(\eta, \delta^{(1)}, \delta^{(2)}\right)$ of $N^{\ell}$ in $\left(N^{\circ}\right)^{\ell}$ are distinct for all $\xi \in D$, the $\chi_{X}$-twisted $U_{D}$-submodule $U_{D} \cdot X$ of $V_{\left(N^{\circ}\right)^{\ell}}$ generated by $X$ is isomorphic to $U_{D} \boxtimes_{U_{0}} X=$ $\bigoplus_{\xi \in D} U_{\xi} \boxtimes_{U_{0}} X$. If $\chi_{X}(\xi)=1$ for all $\xi \in D$, then $N\left(\eta, \delta^{(1)}, \delta^{(2)}\right) \subset\left(\Gamma_{D}\right)^{\circ}$ by Lemma 6.3, and we have $U_{D} \cdot X \subset V_{\left(\Gamma_{D}\right)^{\circ}}$. Thus the following theorem holds.

Theorem 6.4. (1) Any irreducible $\chi$-twisted $U_{D}$-module, $\chi \in D^{*}$, is contained in $V_{\left(N^{\circ}\right)^{\ell}}$. (2) Any irreducible untwisted $U_{D}$-module is contained in $V_{\left(\Gamma_{D}\right)^{\circ}}$.

Define an action of $D$ on $\operatorname{Irr}\left(U_{\mathbf{0}}\right)$ by $X \mapsto U_{\xi} \boxtimes_{U_{0}} X$ for $\xi \in D$ and $X \in \operatorname{Irr}\left(U_{\mathbf{0}}\right)$. Let $\operatorname{Irr}\left(U_{\mathbf{0}}\right)=\bigcup_{i \in I} \mathscr{O}_{i}$ be the $D$-orbit decomposition, and let $D_{X}=\left\{\xi \in D \mid U_{\xi} \boxtimes_{U_{0}} X=X\right\}$ be the stabilizer of $X$. The next lemma holds by Lemma 4.4.

Lemma 6.5. $U_{\xi} \boxtimes_{U_{0}} U_{\mu, \nu}=U_{\mu, \nu}$ for some $\xi \neq \mathbf{0}$ if and only if $k$ is odd, $\xi=\left(\xi_{1}, \ldots, \xi_{\ell}\right) \in$ $\{0, k\}^{\ell}$, and $\mu_{r}=(k-1) / 2$ for $1 \leq r \leq \ell$ such that $\xi_{r}=k$.

We study the structure of $U_{D} \boxtimes_{U_{0}} X$ for $X \in \operatorname{Irr}\left(U_{\mathbf{0}}\right)$. If $D_{X}=0$, then $U_{D} \boxtimes_{U_{\mathbf{0}}} X$ is an irreducible $\chi_{X}$-twisted $U_{D}$-module.

Suppose $D_{X} \neq 0$. Then $k$ is odd, and $D_{X} \subset\{0, k\}^{\ell}$ by Lemma 6.5. Let $C=\{(0),(k)\}$ be a $\mathbb{Z}_{2 k}$-code of length one consisting of two codewords ( 0 ) and ( $k$ ). The code $C$ is in Case A or in Case B according as $k \equiv 1$ or $k \equiv 3(\bmod 4)$. Hence the $\mathbb{Z}_{2}$-graded simple current extension $U_{C}=U^{0} \oplus U^{k}$ of $U^{0}$ is a simple vertex operator algebra with $h\left(U^{k}\right) \in \mathbb{Z}$ or a simple vertex operator superalgebra with $h\left(U^{k}\right) \in \mathbb{Z}+1 / 2$ according as $k \equiv 1$ or $k \equiv 3(\bmod 4)$. We can regard any additive subgroup of $\{0, k\}^{\ell} \subset\left(\mathbb{Z}_{2 k}\right)^{\ell}$ as an additive subgroup of $\left(\mathbb{Z}_{2}\right)^{\ell}$ under the correspondence $0 \mapsto 0$ and $k \mapsto 1$. Since $k$ is odd, the correspondence is the reduction modulo 2 , and it gives an isometry from $\left(\{0, k\}^{\ell},(\cdot \mid \cdot)\right)$ to $\left(\left(\mathbb{Z}_{2}\right)^{\ell},(\cdot \mid \cdot)\right)$, where $(\cdot \mid \cdot)$ is the standard inner product on either $\left(\mathbb{Z}_{2 k}\right)^{\ell}$ or $\left(\mathbb{Z}_{2}\right)^{\ell}$. In particular, $D_{X} \cap D_{X}^{\perp}$ in $\left(\mathbb{Z}_{2 k}\right)^{\ell}$ corresponds to $D_{X} \cap D_{X}^{\perp}$ in $\left(\mathbb{Z}_{2}\right)^{\ell}$. Thus the following theorem holds by Propositions 2.3, 2.5, and 2.6 of [5].

Theorem 6.6. Let $X \in \operatorname{Irr}\left(U_{0}\right)$.
(1) If $D_{X}=0$, then $U_{D} \boxtimes_{U_{0}} X$ is an irreducible $\chi_{X}$-twisted $U_{D}$-module.
(2) Suppose $k$ is odd and $D_{X} \neq 0$.

If $k \equiv 1(\bmod 4)$, then $U_{D} \boxtimes_{U_{0}} X=\bigoplus_{j=1}^{\left|D_{X}\right|} V^{j}$, where $V^{j}, 1 \leq j \leq\left|D_{X}\right|$, are inequivalent irreducible $\chi_{X}$-twisted $U_{D}$-modules. Furthermore, $V^{j} \cong \bigoplus_{W \in \mathcal{O}_{i}} W$ as $U_{0}$-modules, where $\mathscr{O}_{i}$ is the $D$-orbit in $\operatorname{Irr}\left(U_{\mathbf{0}}\right)$ containing $X$.

If $k \equiv 3(\bmod 4)$, then $U_{D} \boxtimes_{U_{0}} X=\bigoplus_{j=1}^{\left|D_{X} \cap D_{\bar{X}}\right|}\left(V^{j}\right)^{\oplus m}$, where $m=\left[D_{X}: D_{X} \cap D_{X}^{\frac{1}{X}}\right]^{1 / 2}$, and $V^{j}, 1 \leq j \leq\left|D_{X} \cap D_{X}^{\perp}\right|$, are inequivalent irreducible $\chi_{X}$-twisted $U_{D}$-modules. Furthermore, $V^{j} \cong \bigoplus_{W \in \mathscr{O}_{i}} W^{\oplus m}$ as $U_{\mathbf{0}}$-modules, where $\mathscr{O}_{i}$ is the $D$-orbit in $\operatorname{Irr}\left(U_{\mathbf{0}}\right)$ containing $X$.

Any irreducible $\chi$-twisted $U_{D}$-module, $\chi \in D^{*}$, is isomorphic to a direct summand of $U_{D} \boxtimes_{U_{0}} X$ with $\chi=\chi_{X}$ for some $X \in \operatorname{Irr}\left(U_{\mathbf{0}}\right)$. Thus the classification of irreducible $\chi$-twisted $U_{D}$-modules for any $\chi \in D^{*}$ is obtained by Theorem 6.6.

We can write $\chi_{i}$ for $\chi_{X}$, and $D_{i}$ for $D_{X}$ if $X$ belongs to a $D$-orbit $\mathscr{O}_{i}$ in $\operatorname{Irr}\left(U_{\mathbf{0}}\right)$, as $\chi_{X}$ and $D_{X}$ are independent of the choice of $X \in \mathscr{O}_{i}$. Let $I(\chi)=\left\{i \in I \mid \chi_{i}=\chi\right\}$, which is non-empty by Lemma 6.1.

By the above arguments, we obtain the next theorem.

Theorem 6.7. The number of inequivalent irreducible $\chi$-twisted $U_{D}$-modules for $\chi \in D^{*}$ is as follows.

$$
\begin{array}{ll}
|I(\chi)| & \text { if } k \text { is even, } \\
\left|I(\chi)_{0}\right|+\sum_{i \in I(\chi)_{1}}\left|D_{i}\right| & \text { if } k \equiv 1 \quad(\bmod 4) \\
\left|I(\chi)_{0}\right|+\sum_{i \in I(\chi)_{1}}\left|D_{i} \cap D_{i}^{\perp}\right| & \text { if } k \equiv 3 \quad(\bmod 4)
\end{array}
$$

where $I(\chi)_{0}=\left\{i \in I(\chi) \mid D_{i}=0\right\}$ and $I(\chi)_{1}=I(\chi) \backslash I(\chi)_{0}$.
6.2. Irreducible $U_{D}$-modules: Case B. Let $D$ be a $\mathbb{Z}_{2 k}$-code of length $\ell$ in Case B of Section 5.2, and let $D^{0}$ and $D^{1}$ be as in Section 5.2. Since $D^{0}$ is a $\mathbb{Z}_{2 k}$-code of length $\ell$ in Case A, we see from Section 6.1 that any irreducible $U_{D^{0}}$-module $P$ is isomorphic to a direct summand of $U_{D^{0}} \boxtimes_{U_{0}} X$ for some $X \in \operatorname{Irr}\left(U_{0}\right)$, and that $X$ is contained in $V_{N\left(\eta, \delta^{(1)}, \delta^{(2)}\right)}$ for some coset $N\left(\eta, \delta^{(1)}, \delta^{(2)}\right)$ of $N^{\ell}$ in $\left(\Gamma_{D^{0}}\right)^{\circ}$. Since $U_{D}=U_{D^{0}} \oplus U_{D^{1}}$, the $U_{D^{-}}$submodule $U_{D} \cdot P$ of $V_{\left(\Gamma_{D^{0}}\right)^{\circ}}$ generated by $P$ is isomorphic to $U_{D} \boxtimes_{U_{D^{0}}} P$. Moreover, $U_{D} \boxtimes_{U_{D^{0}}} P$ is either an irreducible $U_{D^{-}}$module or a direct sum of two irreducible $U_{D^{-}}$ modules. Since any irreducible $U_{D}$-module is obtained in this way, the following theorem holds.

Theorem 6.8. Any irreducible $U_{D-m o d u l e}$ is contained in $V_{\left(\Gamma_{D^{0}}\right)^{\circ}}$.
Appendix A. Top level of $U^{l}, 0 \leq l<2 k$
In this appendix, we prove the following theorem on the top level of $U^{l}, 0 \leq l<2 k$, defined in (4.5).
Theorem A.1. The weight and the dimension of the top level of the simple current $U^{0}$ module $U^{l}, 0 \leq l<2 k$, are as follows.
(1) If $l=0$, then the weight is 0 and the dimension is 1 .
(2) If $l$ is odd, then the weight is $l(2 k-l) / 4 k-1 / 4$ and the dimension is 1.
(3) If $l \neq 0$ is even, then the weight is $l(2 k-l) / 4 k$ and the dimension is 2 .

Proof. Since $U^{l} \circ \theta \cong U^{-l}=U^{2 k-l}$ by (3.20), it is enough to consider the case $0 \leq l \leq k$. The top level of $U^{0}$ is $\mathbb{C} 1$, and the assertion (1) holds. Thus we assume that $1 \leq l \leq k$. If $k=2$, then $U^{l}=V_{\mathbb{Z} d-l d / 4}$ with $\langle d, d\rangle=4$, as $M_{(1)}^{0}=\mathbb{C} 1$. Hence the theorem holds for $k=2$. So we assume that $k \geq 3$.

Recall the notation $X(i, j, l)$ in Section 3 . For a fixed $l$, let $P(j)$ be the conformal weight of $X(0, j, l)$. Since $U^{l}=\bigoplus_{j=0}^{k-2} X(0, j, l)$, we need to calculate the minimum value of $P(j)$ for integers $j$ in the range $0 \leq j<k-1$. We have

$$
\begin{align*}
P(j) & =\frac{j(k-1-j)}{k-1}+\frac{((k-1) l+2 k j)^{2}}{4(k-1) k}  \tag{A.1}\\
& =\left(j+\frac{l+1}{2}\right)^{2}-\frac{(l+1)^{2}}{4}+\frac{(k-1) l^{2}}{4 k}
\end{align*}
$$

for $j$ in the range

$$
\begin{equation*}
0 \leq j \leq(k-1)(k-l) / 2 k \tag{A.2}
\end{equation*}
$$

and

$$
\begin{align*}
P(j) & =\frac{j(k-1-j)}{k-1}+\frac{((k-1) l+2 k j-2(k-1) k)^{2}}{4(k-1) k}  \tag{A.3}\\
& =\left(j-\left(k-\frac{l+1}{2}\right)\right)^{2}+\frac{l(2 k-l)}{4 k}-\frac{1}{4}
\end{align*}
$$

for $j$ in the range

$$
\begin{equation*}
(k-1)(k-l) / 2 k \leq j<k-1 \tag{A.4}
\end{equation*}
$$

The dimension of the top level of $V_{\mathbb{Z} d-l d / 2 k-j d /(k-1)}$ is 2 if $(k-1) l+2 k j=(k-1) k$, otherwise it is 1 . Since the dimension of the top level of $M_{(k-1)}^{j}$ is 1 , the dimension of the top level of $X(0, j, l)$ is 2 if $l=k$ and $j=0$, otherwise it is 1 , as $1 \leq l \leq k$.

The minimum value of the quadratic polynomial $P(j)$ for integers $j$ in the range (A.2) is $(k-1) l^{2} / 4 k$ at $j=0$ by (A.1). As for the minimum value of $P(j)$ for integers $j$ in the range (A.4), note that

$$
(k-1)(k-l) / 2 k \leq k-1-(l+1) / 2<k-1,
$$

as $k \geq 3$ and $1 \leq l \leq k$. We argue the cases $l=1,2$, and $l \geq 3$ separately.
First, assume that $l=1$. Then $k-(l+1) / 2=k-1$ is not in the range (A.4). So the minimum value of $P(j)$ for integers $j$ in the range (A.4) is $5 / 4-1 / 4 k$ at $j=k-2$ by (A.3). Since $P(0)<P(k-2)$, the assertion (2) holds for $l=1$.

Next, assume that $l=2$. Then $k-(l+1) / 2=k-3 / 2$, so the minimum value of $P(j)$ for integers $j$ in the range (A.4) is $(k-1) / k$ at $j=k-2$ by (A.3). Since $P(0)=P(k-2)$, the assertion (3) holds for $l=2$.

Now, assume that $3 \leq l \leq k$. Suppose $l$ is odd. Then the minimum value of $P(j)$ for integers $j$ in the range (A.4) is $l(2 k-l) / 4 k-1 / 4$ at $j=k-(l+1) / 2$ by (A.3). The minimum value is smaller than $P(0)$. Thus the assertion (2) holds.

Finally, suppose $4 \leq l \leq k$ and $l$ is even. Then the minimum value of $P(j)$ for integers $j$ in the range (A.4) is $l(2 k-l) / 4 k$ at $j=k-1-l / 2$ and $k-l / 2$ by (A.3). The minimum value is smaller than $P(0)$. Thus the assertion (3) holds. The proof is complete.
