# THE GROWTH RATE OF HARMONIC FUNCTIONS

#### Abstract

We study the growth rate of harmonic functions in two aspects: gradient estimate and frequency. We obtain the sharp gradient estimate of positive harmonic function in geodesic ball of complete surface with non-negative curvature. On complete Riemannian manifolds with non-negative Ricci curvature and maximal volume growth, further assume the dimension of the manifold is not less than three, we prove that quantitative strong unique continuation yields the existence of non-constant polynomial growth harmonic functions. Also the uniform bound of frequency for linear growth harmonic functions on such manifolds is obtained, and this confirms a special case of Colding-Minicozzi's conjecture on frequency.

## 1. Introduction

This paper studies the harmonic function's growth rate on manifolds and its related application. Unless otherwise mentioned, all manifolds in this paper have non-negative Ricci curvature. By Yau's Liouville theorem, any positive harmonic functions on complete manifolds with non-negative Ricci curvature is constant

[^0]function. We firstly study the positive harmonic functions defined on a unit geodesic ball. Note if we do scaling on manifolds with non-negative Ricci curvature, the unit geodesic ball case can be extended to general geodesic ball case. We get the following results characterizing the 'largest' positive harmonic functions in the geodesic ball. Define $\mathcal{H}^{+}$as the set of positive harmonic functions $u$ defined on $B_{1}(p)$ with $u(p)=1$, where $B_{1}(p) \subseteq M^{n}$ is the geodesic ball centered at $p$ with radius $=1$.

Theorem 1.1. For any $s \in[0,1)$, there exists $u_{s} \in \mathcal{H}^{+}$such that

$$
\sup _{y \in \partial B_{s}(p)} u_{s}(y)=\max _{u \in \mathcal{H}^{+}} \sup _{y \in \partial B_{s}(p)} u(y) .
$$

Furthermore there exists $x_{s} \in \partial B_{1}(p)$ (possibly not unique) such that $u_{s}(y)=$ $\frac{P\left(x_{s}, y\right)}{P\left(x_{s}, p\right)}$.

Motivated by the gradient estimate of Cheng and Yau [CY75], we study the largest growth rate of positive harmonic functions in a unit geodesic ball. So far we can only prove the sharp gradient estimate on surfaces.
Theorem 1.2. Assume $u: B_{1}(p) \rightarrow \mathbb{R}^{+}$is a harmonic function, where $M^{2}$ is a Riemannian manifold with $R c \geq 0$ and $B_{1}(p) \subseteq M^{2}$ is a geodesic ball centered at $p$ with radius $=1$, then $\sup _{x \in B_{s}(p)} \frac{|\nabla u|}{u} \leq \frac{1}{1-s}+\frac{1}{1+s}$ for any $s \in[0,1)$.

The model of the above theorem is the sharp gradient estimate obtained on $\mathbb{R}^{n}$, which is exactly the gradient estimate of the corresponding Poisson kernel on the unit ball. The sharp gradient estimate we are looking for, is one step to reveal the largest growth rate of positive harmonic function on the geodesic balls of complete manifolds with $R c \geq 0$, which is motivated by the study of polynomial growth harmonic function's frequency. For higher dimensional manifolds (the dimension is greater than 2), this type sharp gradient estimate is unknown so far.

It is well known that on any complete noncompact manifold, there always exist nonconstant harmonic functions (see [GW75]). The proof of such existence result is based on the classical unique continuation for harmonic functions. The frequency for harmonic function was firstly introduced by Almgren [Alm79]. Later Garofalo and Lin [GL86] used the bound on frequency to prove the unique continuation, which partly revealed the deep connection between the existence problem and the bound on frequency.

The polynomial growth harmonic functions are important harmonic functions. Yau Yau87] conjectured: on a complete manifold with $R c \geq 0$, the space of harmonic functions with polynomial growth is finite dimensional. In 1997, this conjecture was completely proved by Colding and Minicozzi [CM97b] (also see [Li97], [CM98a], [CM98b] for further developments).

Sormani [Sor00] proved that the existence of any nonconstant harmonic functions with polynomial growth on linear volume growth manifolds with $R c \geq 0$ leads to the splitting of the manifolds. This can be used to construct the manifolds with $R c \geq 0$, which does not admit any nonconstant harmonic functions with polynomial growth.

For a complete Riemannian manifold $M^{n}$ with $R c \geq 0$, define $\mathrm{V}_{M}=\lim _{r \rightarrow \infty} \frac{\operatorname{Vol}\left(B_{r}(p)\right)}{\omega_{n} r^{n}}$; if $V_{M}>0$, we say that $M^{n}$ has maximal volume growth. Although Yau's conjecture was confirmed, we do not know whether there always exists a non-constant polynomial growth harmonic function on $M^{n}$ with maximal volume growth. In the rest of the introduction, we assume $M^{n}$ has maximal volume growth and $n \geq 3$.

Colding and Minicozzi [CM97a] introduced a slightly different frequency function $\mathscr{F}_{u}(r)$ for harmonic function $u$ on $M^{n}$, and obtained some local estimates of $\mathscr{F}_{u}(r)$. Furthermore, they [CM97c] made the following conjectures about frequency of harmonic functions.

Conjecture 1.3. (a) If $u$ is a non-constant polynomial growth harmonic function on $M^{n}$, then $\mathscr{F}_{u}(r)$ is uniformly bounded.
(b) (Quantitative strong unique continuation). Suppose $B_{2 r}(p) \subseteq M^{n}$ for some $p \in M^{n}$, and $u$ is a harmonic function on $B_{2 r}(p)$ with $\sup _{\mathscr{F}_{u}}(s) \leq d$, $s \in[r, 2 r]$
where $d>0$ is some constant; then there exists $C=C\left(n, d, \mathrm{~V}_{M}\right)$ such that $\sup _{s \in[0, r]} \mathscr{F}_{u}(s) \leq C$.

In this paper, we prove the following theorem revealing the relation between the existence of polynomial growth harmonic function and quantitative strong unique continuation conjecture.

Theorem 1.4. If the quantitative unique continuation holds on $M^{n}$, then there exists a non-constant polynomial growth harmonic function.

And we also confirm part $(a)$ of Conjecture 1.3 for linear growth harmonic function in the following theorem.

Theorem 1.5. If $u$ is a linear growth harmonic function on $M^{n}$, then $\sup _{r \geq 0} \mathscr{F}_{u}(r) \leq$ $C\left(M^{n}, p\right)$.

The organization of this paper is as the following. In part I, we study the harmonic functions defined in a geodesic ball with non-negative Ricci curvature. Especially, we give the sharp gradient estimate of positive harmonic functions, by detailed study of Poisson kernel in the geodesic ball.

In part II, we study the sufficient condition guaranteeing the existence of polynomial growth harmonic functions on the whole complete Riemannian manifold in section 4. Then we prove any linear growth harmonic functions has bounded frequency in section 5 . The key of the proof is the asymptotic mean value equality proved by Li [Li86], which provides us the uniform control of $u$ near the infinity of the manifolds. Finally, we show the existence of non-constant polynomial growth harmonic functions on Perelman's example manifolds, which has maximal volume growth and non-unique tangent cones at infinity.

## Part I. Positive harmonic functions in a geodesic ball

In this part, let $G(x, y)$ be the positive Dirichlet Green's function of $B_{1}(p)$ and $\vec{n}_{x}$ is the inward unit normal vector of $\partial B_{1}(p)$ at $x$. Then for $n \geq 2$, we have

$$
P(x, y)=\frac{\partial G(x, y)}{\partial \vec{n}_{x}}, \quad \forall x \in \partial B_{1}(p), y \in B_{1}(p),
$$

where $P(x, y)$ is the Poisson kernel of $B_{1}(p)$.

## 2. Positive harmonic function and Poisson kernel

Let $\alpha=n(n-2) \omega_{n}$, where $\omega_{n}$ is the volume of the unit ball $B_{1}(0) \subseteq \mathbb{R}^{n}$.
Proof: [of Theorem 1.1] From Cheng-Yau's gradient estimate, we know that

$$
\sup _{B_{s}(p)} \frac{|\nabla u|}{u} \leq \frac{C(n)}{1-s}, \quad s \in[0,1) .
$$

Hence there exists $h(s):=\sup _{\substack{u \in \mathcal{H}+\\ x \in B_{s}(p)}} u(x)<\infty$. From the compactness theorem of bounded harmonic functions, there exists $u_{s} \in \mathcal{H}^{+}$such that

$$
\sup _{x \in B_{s}(p)} u_{s}(x)=h(s), \quad s \in[0,1) .
$$

Similar to [ABR01, Corollary 6.15], there exists a measure $d \mu_{s}$ on $\partial B_{1}(p)$ such that $u_{s}(y)=\int_{\partial B_{1}(p)} P(x, y) d \mu_{s}(x)$, where $P(x, y)$ is the Poisson kernel of $B_{1}(p)$. From $u_{s}(p)=1$, we obtain $\int_{\partial B_{1}(p)} P(x, p) d \mu_{s}(x)=1$. Then

$$
\begin{aligned}
u_{s}(y) & =\int_{\partial B_{1}(p)} P(x, y) d \mu_{s}(x) \leq \sup _{x \in \partial B_{1}(p)} \frac{P(x, y)}{P(x, p)} \cdot \int_{\partial B_{1}(p)} P(x, p) d \mu_{s}(x) \\
& =\sup _{x \in \partial B_{1}(p)} \frac{P(x, y)}{P(x, p)} .
\end{aligned}
$$

Furthermore, the equality holds if and only if $d \mu_{s}(x)=\frac{1}{P(x, p)} \mathscr{P}_{E(y)}(x)$, where $\mathscr{P}_{E(y)}(x)$ is a probability measure on $E(y)=\left\{\tilde{x} \in \partial B_{1}(p): \frac{P(\tilde{x}, y)}{P(\tilde{x}, p)}=\sup _{x \in \partial B_{1}(p)} \frac{P(x, y)}{P(x, p)}\right\}$. And we define $\psi(y) \in \partial B_{1}(p)$ such that $\frac{P(\psi(y), y)}{P(\psi(y), p)}=\sup _{x \in \partial B_{1}(p)} \frac{P(x, y)}{P(x, p)}$. Note that $\psi(y)$ possibly is not unique.

There exists $y_{s} \in \partial B_{s}(p)$ such that $u_{s}\left(y_{s}\right)=\sup _{y \in B_{s}(p)} u_{s}(y)$. Also there exists $x_{s} \in$ $\partial B_{1}(p)$ such that $\frac{P\left(x_{s}, y_{s}\right)}{P\left(x_{s}, p\right)}=\sup _{x \in \partial B_{1}(p)} \frac{P\left(x, y_{s}\right)}{P(x, p)}$. Define $v_{s}(y)=\frac{P\left(x_{s}, y\right)}{P\left(x_{s}, p\right)}: B_{1}(p) \rightarrow$ $\mathbb{R}^{+}$, then $v_{s} \in \mathcal{H}^{+}$and

$$
h(s) \geq \sup _{y \in B_{s}(p)} v_{s}(y) \geq \sup _{y \in B_{s}(p)} u_{s}(y)=h(s) .
$$

Especially, one gets $\sup _{x \in \partial B_{1}(p)} \frac{P\left(x, y_{s}\right)}{P(x, p)}=u_{s}\left(y_{s}\right)=h(s)$.
From the above, we get $d \mu_{s}(x)=\frac{1}{P(x, p)} \mathscr{P}_{E\left(y_{s}\right)}(x)$, which implies

$$
u_{s}(y)=\int_{\partial B_{1}(p)} P(x, y) d \mu_{s}(x)=\frac{P\left(\psi\left(y_{s}\right), y\right)}{P\left(\psi\left(y_{s}\right), p\right)}
$$

Lemma 2.1. On $M^{n}$ with $n \geq 2$, assume $u$ is a positive harmonic function on $B_{1}(p) \subseteq M^{n}$, then for any $s \in[0,1)$,

$$
\sup _{y \in B_{s}(p)}|\nabla \ln u|(y) \leq \sup _{x \in \partial B_{1}(p)} \sup _{y \in B_{s}(p)}\left|\nabla_{y} \ln P(x, y)\right| .
$$

Proof: For any $\epsilon>0$, let $G^{\epsilon}(x, y)$ be the Dirichlet Green's function of $B_{1-\epsilon}(p)$, then for any $y \in \partial B_{s}$, we have $u(y)=\int_{\partial B_{1-\epsilon}} u(x) P^{\epsilon}(x, y) d x$, where $P^{\epsilon}(x, y)=$ $\frac{\partial G^{\epsilon}(x, y)}{\partial \vec{n}_{x}}$. We get

$$
\frac{|\nabla u(y)|}{u(y)}=\frac{\left|\int_{\partial B_{1-\epsilon}} u(x) \nabla_{y} P^{\epsilon}(x, y) d x\right|}{\int_{\partial B_{1-\epsilon}} u(x) P^{\epsilon}(x, y) d x} \leq \sup _{x \in \partial B_{1-\epsilon}} \frac{\left|\nabla_{y} P^{\epsilon}(x, y)\right|}{P^{\epsilon}(x, y)}
$$

Letting $\epsilon \rightarrow 0$ in the above, we have

$$
\begin{equation*}
\frac{|\nabla u(y)|}{u(y)} \leq \sup _{x \in \partial B_{1}} \frac{\left|\nabla_{y} P(x, y)\right|}{P(x, y)} \tag{2.1}
\end{equation*}
$$

The conclusion follows from the above.
Now, we have the sharp gradient estimate on $\mathbb{R}^{n}$.
Corollary 2.2. On $\mathbb{R}^{n}$ with $n \geq 2$, assume $u$ is a positive harmonic function on $B_{1}$, then $\sup _{y \in B_{s}} \frac{|\nabla u|}{u}(y) \leq \frac{n-1}{1-s}+\frac{1}{1+s}$ for any $0 \leq s<1$. Furthermore, the equality holds if and only if $u(y)=\frac{1-|y|^{2}}{n \omega_{n}\left|x_{0}-y\right|^{n}}$ for some $x_{0} \in \partial B_{1}(0)$.

Proof: Step (1). Recall we have the Poisson kernel $P(x, y)$ of $B_{1}(0)$ has the following expression:

$$
P(x, y)=\frac{\partial G(x, y)}{\partial \vec{n}_{x}}=\frac{1-|y|^{2}}{n \omega_{n}|x-y|^{n}}, \quad \forall x \in \partial B_{1}(0), y \in B_{1}(0)
$$

It is straightforward to get

$$
\left|\nabla_{y} \ln P(x, y)\right|^{2}=\frac{2 n-2(n-2) s^{2}}{\left(1-s^{2}\right)^{2}}+\frac{n(n-2)}{1+s^{2}-2 x y}, \quad \forall x \in \partial B_{1}, y \in \partial B_{s}
$$

Hence

$$
\begin{aligned}
\sup _{\substack{x \in \partial B_{1} \\
y \in \partial B_{s}}} \frac{\left|\nabla_{y} P(x, y)\right|}{P(x, y)} & =\sup _{\substack{x \in \partial B_{1} \\
y \in \partial B_{s}}} \sqrt{\frac{2 n-2(n-2) s^{2}}{\left(1-s^{2}\right)^{2}}+\frac{n(n-2)}{1+s^{2}-2 x y}} \\
& =\sqrt{\frac{2 n-2(n-2) s^{2}}{\left(1-s^{2}\right)^{2}}+\frac{n(n-2)}{1+s^{2}-2 s}}=\frac{n-1}{1-s}+\frac{1}{1+s}
\end{aligned}
$$

We conclude $\sup _{\substack{x \in \partial B_{1} \\ y \in B_{s}}} \frac{\left|\nabla_{y} P(x, y)\right|}{P(x, y)}=\frac{n-1}{1-s}+\frac{1}{1+s}$ by the fact that $\frac{n-1}{1-s}+\frac{1}{1+s}$ is increasing in $s$. Combining the above with Lemma 2.1, the first conclusion follows.

Step (2). If the equality holds for some $u$, then we can assume that $\left|\nabla \ln u\left(y_{0}\right)\right|=$ $\frac{n-1}{1-s}+\frac{1}{1+s}$ for some $y_{0} \in \partial B_{s}$. From (2.1), we have

$$
\begin{equation*}
\frac{n-1}{1-s}+\frac{1}{1+s}=\left|\nabla \ln u\left(y_{0}\right)\right| \leq \sup _{x \in \partial B_{1}}\left|\nabla_{y} \ln P\left(x, y_{0}\right)\right|=\frac{n-1}{1-s}+\frac{1}{1+s} \tag{2.2}
\end{equation*}
$$

Assume $\left|\nabla_{y} \ln P\left(x_{0}, y_{0}\right)\right|=\frac{n-1}{1-s}+\frac{1}{1+s}$ for some $x_{0} \in \partial B_{1}$, then it is easy to see that $\left|\nabla_{y} \ln P\left(x_{1}, y_{0}\right)\right|<\left|\nabla_{y} \ln P\left(x_{0}, y_{0}\right)\right|$ for any $x_{1} \neq x_{0}$. Combining this inequality with (2.2), we get $\left.u\right|_{\partial B_{1}}(y)=\delta_{x_{0}}(y)$. From the Poisson formula, we have $u(y)=P\left(x_{0}, y\right)$.

## 3. Gradient estimate in geodesic balls

The following lemma is well-known. We include its proof here for completeness.

Lemma 3.1. Assume $u: \Omega \rightarrow \mathbb{R}^{+}$is a harmonic function, where $\Omega \subset M^{n}$ with $R c \geq 0$, then for $Q=|\nabla \ln u|^{2}$, we have

$$
\Delta Q \geq \frac{2}{n-1} Q^{2}+\frac{4-2 n}{n-1}\langle\nabla Q, \nabla v\rangle+\frac{n}{2(n-1)}|\nabla Q|^{2} \cdot Q^{-1}
$$

Proof: One can set $v=\ln u, Q=|\nabla v|^{2}$. Using the Bochner formula, we compute

$$
\begin{equation*}
\Delta Q=2 v_{i j}^{2}+2 R c(\nabla v, \nabla v)+2\langle\nabla v, \nabla \Delta v\rangle \geq 2 v_{i j}^{2}-2\langle\nabla v, \nabla Q\rangle \tag{3.1}
\end{equation*}
$$

where we use the fact $\Delta v=\nabla\left(\frac{\nabla u}{u}\right)=-|\nabla v|^{2}=-Q$.
Firstly observed by Yau Yau75], there is the following estimate for $\sum_{i j} v_{i j}^{2}$,

$$
\begin{align*}
v_{i j}^{2} & \geq v_{11}^{2}+2 \sum_{\alpha=2}^{n} v_{1 \alpha}^{2}+\sum_{\alpha=2}^{n} v_{\alpha \alpha}^{2} \geq v_{11}^{2}+2 \sum_{\alpha=2}^{n} v_{1 \alpha}^{2}+\frac{\left(\sum_{\alpha=2}^{n} v_{\alpha \alpha}\right)^{2}}{n-1} \\
& =v_{11}^{2}+2 \sum_{\alpha=2}^{n} v_{1 \alpha}^{2}+\frac{\left(\Delta v-v_{11}\right)^{2}}{n-1}=v_{11}^{2}+2 \sum_{\alpha=2}^{n} v_{1 \alpha}^{2}+\frac{\left(Q+v_{11}\right)^{2}}{n-1} \\
& \geq \frac{n}{n-1} \sum_{j=1}^{n} v_{1 j}^{2}+\frac{1}{n-1} Q^{2}+\frac{2}{n-1} Q \cdot v_{11} \tag{3.2}
\end{align*}
$$

Choosing an orthonormal frame $\left\{e_{1}, \cdots, e_{n}\right\}$ at a point such that $e_{1}=\frac{\nabla v}{|\nabla v|}$,

$$
|\nabla Q|^{2}=\left.\left.|\nabla| \nabla v\right|^{2}\right|^{2}=4 \sum_{j=1}^{n}\left(\sum_{i=1}^{n} v_{i} v_{i j}\right)^{2}=4 v_{1}^{2} \sum_{j=1}^{n} v_{1 j}^{2}=4|\nabla v|^{2} \sum_{j=1}^{n} v_{1 j}^{2}=4 Q \cdot \sum_{j=1}^{n} v_{1 j}^{2}
$$

which implies

$$
\begin{equation*}
\sum_{j=1}^{n} v_{1 j}^{2}=\frac{|\nabla Q|^{2}}{4 Q} \tag{3.3}
\end{equation*}
$$

Combining the identity $\left.\left.\langle\nabla| \nabla v\right|^{2}, \frac{\nabla v}{|\nabla v|}\right\rangle=\nabla_{e_{1}}|\nabla v|^{2}=2 v_{1} v_{11}$ with $v_{1}=|\nabla v|$, we get

$$
\begin{equation*}
\left.v_{11}=\left.\frac{1}{2 v_{1}|\nabla v|}\langle\nabla| \nabla v\right|^{2}, \nabla v\right\rangle=\frac{1}{2 Q}\langle\nabla Q, \nabla v\rangle \tag{3.4}
\end{equation*}
$$

From (3.2), (3.3) and (3.4),

$$
v_{i j}^{2} \geq \frac{n}{4(n-1)}|\nabla Q|^{2} \cdot Q^{-1}+\frac{1}{n-1} Q^{2}+\frac{1}{n-1}\langle\nabla Q, \nabla v\rangle
$$

combining the above estimate with (3.1), we obtain

$$
\Delta Q \geq \frac{2}{n-1} Q^{2}+\frac{4-2 n}{n-1}\langle\nabla Q, \nabla v\rangle+\frac{n}{2(n-1)}|\nabla Q|^{2} \cdot Q^{-1}
$$

From the above lemma and the maximum principle, we get the following corollary.

Corollary 3.2. For a positive harmonic function $u$ on $B_{1}(p)$ with $R c \geq 0$, we have

$$
\sup _{B_{t}(0)} \frac{|\nabla u|}{u}=\sup _{\partial B_{t}(0)} \frac{|\nabla u|}{u}, \quad \forall t \in(0,1)
$$

Lemma 3.3. For $B_{1}(p) \subseteq M^{n}$ with $R c \geq 0$, assume $u: B_{1}(p) \rightarrow \mathbb{R}^{+}$is a positive harmonic function, then for any positive function $h \in C^{\infty}\left(B_{1-\epsilon}(p)\right)$ satisfying $\lim _{r \rightarrow 1-\epsilon} \inf _{x \in \partial B_{r}(p)} h(x)=\infty$, where $\epsilon>0$ is a constant, we have

$$
\sup _{B_{s}(p)} \frac{|\nabla u|}{u} \leq \sup _{\partial B_{s}(p)} \sqrt{h} \cdot \sup _{y \in B_{1-\epsilon}(p)} T(h)(y), \quad \forall s<1-\epsilon
$$

where $T(h)=\frac{n-2}{2} \frac{|\nabla h|}{h^{\frac{3}{2}}}+\frac{1}{2} \sqrt{\left\{\left(n^{2}-5 n+4\right) \frac{|\nabla h|^{2}}{h^{3}}+2(n-1) \frac{\Delta h}{h^{2}}\right\}^{+}}$.

Proof: Let $\phi=\frac{1}{h}$ on $B_{1-\epsilon}(p)$ and $\phi=0$ on $M^{n}-B_{1-\epsilon}(p)$, then $\phi$ is a positive cut-off function on $M^{n}$. Define $P=\phi Q=\phi|\nabla \ln u|^{2}$, from Lemma3.1,

$$
\begin{aligned}
& \Delta P=Q \Delta \phi+2\langle\nabla \phi, \nabla Q\rangle+\phi \Delta Q \\
\geq & \frac{\Delta \phi}{\phi} P+2 \phi^{-1}\langle\nabla \phi, \nabla P\rangle-2 \phi^{-2}|\nabla \phi|^{2} \cdot P+\frac{n}{2(n-1)}|\nabla P|^{2} \cdot P^{-1} \\
+ & \frac{n}{2(n-1)}|\nabla \phi|^{2} \phi^{-2} \cdot P-\frac{n}{n-1} \phi^{-1}\langle\nabla \phi, \nabla P\rangle-\frac{2(n-2)}{n-1}\langle\nabla v, \nabla P\rangle \\
+ & \frac{2(n-2)}{n-1}\langle\nabla v, \nabla \phi\rangle Q+\frac{2}{n-1} \phi^{-1} P^{2}
\end{aligned}
$$

Using the inequality $|\langle\nabla v, \nabla \phi\rangle| \leq|\nabla \phi| \cdot|\nabla v|=|\nabla \phi| \cdot \phi^{-\frac{1}{2}} P^{\frac{1}{2}}$, we get

$$
\begin{align*}
& \Delta P \geq \frac{\Delta \phi}{\phi} P+\frac{n-2}{n-1} \phi^{-1}\langle\nabla \phi, \nabla P\rangle+\frac{4-3 n}{2(n-1)} \phi^{-2}|\nabla \phi|^{2} \cdot P+\frac{n}{2(n-1)}|\nabla P|^{2} \cdot P^{-1} \\
& .5) \quad-\frac{2(n-2)}{n-1}\langle\nabla v, \nabla P\rangle-\frac{2(n-2)}{n-1}|\nabla \phi| \phi^{-\frac{3}{2}} P^{\frac{3}{2}}+\frac{2}{n-1} \phi^{-1} P^{2} \tag{3.5}
\end{align*}
$$

Let $\mathcal{L}_{1}(P):=\Delta P+\frac{2(n-2)}{n-1}\langle\nabla v, \nabla P\rangle-\frac{n-2}{n-1} \phi^{-1}\langle\nabla \phi, \nabla P\rangle-\frac{n}{2(n-1)}|\nabla P|^{2} \cdot P^{-1}$, then (3.5) is equivalent to

$$
\begin{aligned}
\mathcal{L}_{1}(P) & \geq\left(\frac{\Delta \phi}{\phi}+\frac{4-3 n}{2(n-1)} \phi^{-2}|\nabla \phi|^{2}\right) \cdot P-\frac{2(n-2)}{n-1}|\nabla \phi| \phi^{-\frac{3}{2}} P^{\frac{3}{2}}+\frac{2}{n-1} \phi^{-1} P^{2} \\
& \geq \frac{1}{(n-1) \phi}\left\{(n-1) P \Delta \phi+\frac{4-3 n}{2} \phi^{-1}|\nabla \phi|^{2} \cdot P-2(n-2)|\nabla \phi| \phi^{-\frac{1}{2}} P^{\frac{3}{2}}+2 P^{2}\right\}
\end{aligned}
$$

Assume $P\left(x_{0}\right)=\max _{B_{1}(p)} P(x)$, then $x_{0} \in B_{1-\epsilon}(p)$ and $\mathcal{L}_{1}(P)\left(x_{0}\right) \leq 0$, we get

$$
0 \geq 2 P\left(x_{0}\right)-2(n-2) \frac{|\nabla \phi|}{\sqrt{\phi}} P^{\frac{1}{2}}\left(x_{0}\right)+\left((n-1) \Delta \phi+\frac{4-3 n}{2} \phi^{-1}|\nabla \phi|^{2}\right)\left(x_{0}\right)
$$

which implies

$$
P\left(x_{0}\right)^{\frac{1}{2}} \leq \frac{n-2}{2} \frac{|\nabla \phi|}{\sqrt{\phi}}\left(x_{0}\right)+\frac{1}{2} \sqrt{\left(n^{2}-n\right) \frac{|\nabla \phi|^{2}}{\phi}-2(n-1) \Delta \phi\left(x_{0}\right)}
$$

Putting $\phi=h^{-1}$ into the above, we have

$$
P\left(x_{0}\right)^{\frac{1}{2}} \leq \frac{n-2}{2} \frac{|\nabla h|}{h^{\frac{3}{2}}}\left(x_{0}\right)+\frac{1}{2} \sqrt{\left(n^{2}-5 n+4\right) \frac{|\nabla h|^{2}}{h^{3}}+2(n-1) \frac{\Delta h}{h^{2}}}\left(x_{0}\right)=T(h)\left(x_{0}\right)
$$

Then we get

$$
\sup _{B_{1-\epsilon}(p)} h(x)^{-\frac{1}{2}} \frac{|\nabla u|}{u}(x)=P\left(x_{0}\right)^{\frac{1}{2}} \leq T(h)\left(x_{0}\right) \leq \sup _{x \in B_{1-\epsilon}(p)} T(h)(x)
$$

which implies $\frac{|\nabla u|}{u}(x) \leq \sqrt{h(x)} \sup _{y \in B_{1-\epsilon}(p)} T(h)(y)$ for any $x \in B_{1-\epsilon}(p)$. Taking the supermum of $x$ on $\partial B_{s}(p)$, we get

$$
\sup _{\partial B_{s}(p)} \frac{|\nabla u|}{u}(x) \leq \sup _{\partial B_{s}(p)} \sqrt{h(x)} \cdot \sup _{y \in B_{1-\epsilon}(p)} T(h)(y), \quad \forall s<1-\epsilon
$$

The conclusion follows from the above and Corollary 3.2,
Theorem 3.4. Assume $u: B_{1}(p) \rightarrow \mathbb{R}^{+}$is a harmonic function, where $M^{2}$ is a Riemannian manifold with $R c \geq 0$, then $\sup _{x \in B_{s}(p)} \frac{|\nabla u|}{u} \leq \frac{1}{1-s}+\frac{1}{1+s}$ for any $s \in[0,1)$.

Proof: When $n=2$, choosing $h(x)=\frac{4}{\left(1-\epsilon-\rho(x)^{2}\right)^{2}}$ in Lemma 3.3, we get

$$
\sup _{B_{s}(p)} \frac{|\nabla u|}{u} \leq \frac{1}{2} \sup _{\partial B_{s}(p)} \sqrt{h} \cdot \sup _{y \in B_{1-\epsilon}(p)} \sqrt{2 \frac{\Delta h}{h^{2}}-2 \frac{|\nabla h|^{2}}{h^{3}}}, \quad \forall s<1-\epsilon
$$

By the Laplace comparison theorem, we have $\Delta \rho \leq \frac{1}{\rho}$, which yields $\sqrt{2 \frac{\Delta h}{h^{2}}-2 \frac{|\nabla h|^{2}}{h^{3}}} \leq$ 2. Hence we get

$$
\sup _{B_{s}(p)} \frac{|\nabla u|}{u} \leq \sup _{\partial B_{s}(p)} \sqrt{h}=\frac{2}{\left(1-\epsilon-s^{2}\right)}, \quad \forall s<1-\epsilon
$$

Letting $\epsilon \rightarrow 0$ in the above, the conclusion follows.
The following corollary follows from the above theorem directly.
Corollary 3.5. Assume $u: B_{1}(p) \rightarrow \mathbb{R}^{+}$is a harmonic function, where $M^{2}$ is a Riemannian manifold with $R c \geq 0$, then $u(x) \leq \frac{1+d(p, x)}{1-d(p, x)} u(p)$.

Remark 3.6. We do not know the rigidity part of the above Theorem. In other words, if $\sup _{x \in B_{s}(p)} \frac{|\nabla u|}{u}=\frac{1}{1-s}+\frac{1}{1+s}$ for some $s \in[0,1)$, is $B_{1}(p)$ isometric to $B_{1}(0)$ ?

Question 3.7. Assume $u: B_{1}(p) \rightarrow \mathbb{R}^{+}$is a positive harmonic function, where $B_{1}(p) \subseteq M^{n}$ with $R c \geq 0$ and $n \geq 3$, for any $s \in[0,1)$, do we have

$$
\sup _{B_{s}(p)} \frac{|\nabla u|}{u} \leq \frac{n-1}{1-s}+\frac{1}{1+s} ?
$$

## Part II. Polynomial growth harmonic functions on manifolds

In part II of this paper, we always assume that $M^{n}$ is a complete non-compact Riemannian manifold with $R c \geq 0$ and maximal volume growth, where $n \geq 3$, unless otherwise mentioned.

## 4. Frequency and existence of harmonic function

From [Var81], there exists a unique, minimal, positive Green function on $M^{n}$, denoted as $G(p, x)$ where $p$ is a fixed point on manifold. We define $b(x)=[n(n-$ 2) $\left.\omega_{n} \cdot G(p, x)\right]^{\frac{1}{2-n}}$ and use $\rho(x)=d(p, x)$ unless otherwise mentioned. From the behavior of Green function $G(p, x)$ near singular point $p$, we get

$$
\begin{equation*}
\lim _{\rho(x) \rightarrow 0} \frac{b(x)}{\rho(x)}=1 \quad \text { and } \quad \lim _{\rho(x) \rightarrow 0}|\nabla b|=1 \tag{4.1}
\end{equation*}
$$

The following definition of frequency function was firstly introduced in [CM97a]. Assume $u(x)$ is a harmonic function defined on $\{b(x) \leq r\}$, define:

$$
\begin{equation*}
I_{u}(r)=r^{1-n} \int_{b(x)=r} u^{2}|\nabla b| d x \quad \text { and } \quad D_{u}(r)=r^{2-n} \int_{b(x) \leq r}|\nabla u|^{2} d x \tag{4.2}
\end{equation*}
$$

The frequency function of harmonic function $u$ is defined by $\mathscr{F}_{u}(r)=\frac{D_{u}(r)}{I_{u}(r)}$.
In this paper, $I(r), D(r)$ and $\mathscr{F}(r)$ are defined as in above with respect to harmonic function $u$ (which may be defined locally on suitable regions of $M^{n}$ ). From the definition of $\mathscr{F}_{u}(r)$, we can get that $\mathscr{F}_{u}(0)=0$ if $u(p) \neq 0$.

The following lemma is a generalized version of the Rellich-Necas identity, which was originally discovered by Payne and Weinberger [PW58] (also see [CM97a]).

Lemma 4.1. For harmonic function $u$ on $B=\{x: b(x) \leq r\} \subseteq M^{n}$, we have

$$
r \int_{b=r}|\nabla u|^{2} \cdot|\nabla b|=2 r \int_{b=r}\left|\frac{\partial u}{\partial \vec{n}}\right|^{2} \cdot|\nabla b|+\int_{b \leq r} \frac{1}{2} \Delta\left(b^{2}\right) \cdot|\nabla u|^{2}-\nabla^{2}\left(b^{2}\right)(\nabla u, \nabla u)
$$

where $\vec{n}$ is the unit normal of $\partial B$ pointing inward of $B$.

Lemma 4.2. When $I(r) \neq 0$, we have

$$
(\ln \mathscr{F}(r))^{\prime} \geq-\frac{\int_{b \leq r}\left\{n\left(1-|\nabla b|^{2}\right)+\left|2 g-\nabla^{2}\left(b^{2}\right)\right|\right\} \cdot|\nabla u|^{2}}{r \int_{b \leq r}|\nabla u|^{2}}-2 \frac{\int_{b=r}\left|\frac{\partial u}{\partial \vec{n}}\right|^{2}| | \nabla b\left|-|\nabla b|^{-1}\right|}{\int_{b \leq r}|\nabla u|^{2}} .
$$

Proof: From the definition of $\mathscr{F}$, we have

$$
\mathscr{F}^{\prime}(r)=\frac{D^{\prime}(r)}{I(r)}-\frac{D(r)}{I^{2}(r)} I^{\prime}(r)=\mathscr{F}(r)\left\{\frac{D^{\prime}(r)}{D(r)}-\frac{I^{\prime}(r)}{I(r)}\right\} .
$$

From Lemma 5.1 and Cauchy-Schwartz inequality, noting that $\int_{b \leq r}|\nabla u|^{2}=$ $\int_{b=r} u \frac{\partial u}{\partial \vec{n}}$, we have

$$
\begin{aligned}
& \frac{D^{\prime}(r)}{D(r)}-\frac{I^{\prime}(r)}{I(r)}=\frac{2-n}{r}+\frac{\int_{b=r}|\nabla u|^{2}|\nabla b|^{-1}}{\int_{b \leq r}|\nabla u|^{2}}-2 \frac{\int_{b \leq r}|\nabla u|^{2}}{\int_{b=r} u^{2}|\nabla b|} \\
\geq & \frac{2-n}{r}+\frac{\int_{b=r}|\nabla u|^{2}|\nabla b|^{-1}}{\int_{b \leq r}|\nabla u|^{2}}-2 \frac{\int_{b=r}\left|\frac{\partial u}{\partial \vec{n}}\right|^{2}|\nabla b|^{-1}}{\int_{b \leq r}|\nabla u|^{2}} \\
= & \frac{2-n}{r}+\frac{\int_{b=r}|\nabla u|^{2}|\nabla b|^{-1}-2\left|\frac{\partial u}{\partial \vec{n}}\right|^{2}|\nabla b|}{\int_{b \leq r}|\nabla u|^{2}}+2\left\{\frac{\int_{b=r}\left|\frac{\partial u}{\partial \vec{n}}\right|^{2}|\nabla b|}{\int_{b \leq r}|\nabla u|^{2}}-\frac{\int_{b=r}\left|\frac{\partial u}{\partial \vec{n}}\right|^{2}|\nabla b|^{-1}}{\int_{b \leq r}|\nabla u|^{2}}\right\} .
\end{aligned}
$$

Note $|\nabla b| \leq 1$ and Lemma4.1, we have

$$
\begin{aligned}
& \frac{D^{\prime}(r)}{D(r)}-\frac{I^{\prime}(r)}{I(r)} \geq \frac{2-n}{r}+\frac{\left.\int_{b=r}|\nabla u|^{2}|\nabla b|-2\left|\frac{\partial u}{\partial \vec{n}}{ }^{2}\right| \nabla b \right\rvert\,}{\int_{b \leq r}|\nabla u|^{2}}+2 \frac{\int_{b=r} \left\lvert\, \frac{\partial u}{\partial \vec{n}}{ }^{2}\left(|\nabla b|-|\nabla b|^{-1}\right)\right.}{\int_{b \leq r}|\nabla u|^{2}} \\
= & \frac{2-n}{r}+\frac{1}{r} \cdot \frac{\int_{b \leq r}\left[\frac{1}{2} \Delta\left(b^{2}\right) \cdot|\nabla u|^{2}-\nabla^{2}\left(b^{2}\right)(\nabla u, \nabla u)\right]}{\int_{b \leq r}|\nabla u|^{2}}+2 \frac{\int_{b=r}\left|\frac{\partial u}{\partial \vec{n}}\right|^{2}\left(|\nabla b|-|\nabla b|^{-1}\right)}{\int_{b \leq r}|\nabla u|^{2}} \\
= & \frac{\int_{b \leq r} n\left[|\nabla b|^{2}-1\right]|\nabla u|^{2}+\left[\left(2 g-\nabla^{2}\left(b^{2}\right)\right)(\nabla u, \nabla u)\right]}{r \int_{b \leq \leq r}|\nabla u|^{2}}+2 \frac{\int_{b=r} \frac{\left|\frac{\partial u}{\partial \vec{n}}\right|^{2}\left(|\nabla b|-|\nabla b|^{-1}\right)}{\int_{b \leq r}|\nabla u|^{2}}}{r} \\
\geq & -\frac{\int_{b \leq r}\left\{n\left(1-|\nabla b|^{2}\right)+\left|2 g-\nabla^{2}\left(b^{2}\right)\right|\right\} \cdot|\nabla u|^{2}}{r \int_{b \leq r}|\nabla u|^{2}}-2 \frac{\int_{b=r} \frac{\left|\frac{\partial u}{\partial \vec{n}}\right|^{2}| | \nabla b\left|-|\nabla b|^{-1}\right|}{\int_{b \leq r}|\nabla u|^{2}},}{}
\end{aligned}
$$

in the last equation above we use $\Delta\left(b^{2}\right)=2 n|\nabla b|^{2}$.
Lemma 4.3. For any $\epsilon_{0} \in(0,1)$, there is $r_{0}>0$ such that if $r \geq V^{\frac{1}{n-2}}\left(1-\epsilon_{0}\right)^{\frac{1}{2-n}} r_{0}$, then

$$
\left\{x: \rho(x) \leq \mathrm{V}_{M}^{\frac{1}{2-n}}\left(1-\epsilon_{0}\right)^{\frac{1}{2-n}} r\right\} \subseteq\{x: b(x) \leq r\} \subseteq\left\{x: \rho(x) \leq \mathrm{V}_{M}^{\frac{1}{2-n}}\left(1+\epsilon_{0}\right)^{\frac{1}{n-2}} r\right\} .
$$

Proof: From the proof of [LTW97, Theorem 1.1] (also see [CM97c]), for any $\delta \in\left(0, \frac{1}{2}\right]$, we have

$$
\left(\mathrm{V}_{M}\right)^{\frac{1}{n-2}}(1+\tau(n, \delta))^{\frac{1}{2-n}} \rho(x) \leq b(x) \leq\left(\mathrm{V}_{M}\right)^{\frac{1}{n-2}}(1-\tau(n, \delta))^{\frac{1}{2-n}} \rho(x),
$$

where $\tau(n, \delta)(x)=C(n)\left[\delta+\left(\theta_{p}(\delta \rho(x))-\theta\right)^{\frac{1}{n-}}\right]$, and

$$
\theta_{p}(r)=\frac{\operatorname{Vol}\left(\partial B_{r}(p)\right)}{r^{n-1}}, \quad \theta=\lim _{r \rightarrow \infty} \theta_{p}(r) .
$$

For any $\epsilon_{0} \in(0,1)$, we can firstly find $\delta=\frac{\epsilon_{0}}{2 C(n)}$, then

$$
\tau(n, \delta)=C(n) \delta+C(n)\left(\theta_{p}(\delta \rho(x))-\theta\right)^{\frac{1}{n-1}}=\frac{\epsilon_{0}}{2}+C(n)\left\{\theta_{p}\left(\frac{\epsilon_{0}}{2 C(n)} \rho(x)\right)-\theta\right\}^{\frac{1}{n-1}} .
$$

Now choose suitable $r_{0}>0$, then it yields $\tau(n, \delta)(x) \leq \epsilon_{0}$. If $\rho(x) \geq r_{0}$, we have

$$
\begin{equation*}
\left(\mathrm{V}_{M}\right)^{\frac{1}{n-2}}\left(1+\epsilon_{0}\right)^{\frac{1}{2-n}} \rho(x) \leq b(x) \leq\left(\mathrm{V}_{M}\right)^{\frac{1}{n-2}}\left(1-\epsilon_{0}\right)^{\frac{1}{2-n}} \rho(x) \tag{4.3}
\end{equation*}
$$

From [Col12], we know that $|\nabla b| \leq 1$. If $\rho(x) \leq r_{0}$, we get $b(x) \leq \rho(x) \leq r_{0} \leq r$. If $\rho(x) \in\left[r_{0}, V_{M}^{\frac{1}{2-n}}\left(1-\epsilon_{0}\right)^{\frac{1}{2-n}} r\right]$, then from (4.3),

$$
b(x) \leq \mathrm{V}_{M}^{\frac{1}{n-2}}\left(1-\epsilon_{0}\right)^{\frac{1}{2-n}} \rho(x) \leq r,
$$

the first inclusion is proved.
If $b(x) \leq r$, and $\rho(x)>\left(1+\epsilon_{0}\right)^{\frac{1}{n-2}} V_{M}^{\frac{1}{2-n}} r$, then $\rho(x)>r_{0}$. From (4.3),

$$
b(x) \geq \mathrm{V}_{M}^{\frac{1}{n-2}}\left(1+\epsilon_{0}\right)^{\frac{1}{2-n}} \rho(x)>r .
$$

This is the contradiction, and the second inclusion follows.

Lemma 4.4. There is $R=R\left(M^{n}, n\right)>0$, such that for any $\tau>1, r \geq R$, we have

$$
\sup _{b(x) \leq r}|\nabla u|^{2}(x) \leq \frac{C(n, \tau)}{\mathrm{V}_{M}^{\frac{2}{2-n}}} r^{-2} D(\tau r) \quad \text { and } \quad \sup _{b \leq r}|u|^{2} \leq \frac{C(n, \tau)}{\mathrm{V}_{M}^{\frac{2}{2-n}}} D(\tau r),
$$

where $u$ is harmonic with $u(p)=0$.
Proof: From Lemma 4.3, choose $\epsilon_{0}=\frac{1}{\sqrt{2}}$, there is $r_{0}>0$ such that if $r \geq$ $\mathrm{V}_{M}^{\frac{1}{n-2}}\left(1-\epsilon_{0}\right)^{\frac{1}{2-n}} r_{0}$, then

$$
\begin{equation*}
\left\{\rho \leq \mathrm{V}_{M}^{\frac{1}{2-n}}\left(1-\epsilon_{0}\right)^{\frac{1}{2-n}} r\right\} \subseteq\{b \leq r\} \subseteq\left\{\rho \leq \mathrm{V}_{M}^{\frac{1}{2-n}}\left(1+\epsilon_{0}\right)^{\frac{1}{n-2}} r\right\} \tag{4.4}
\end{equation*}
$$

From [LS84, Theorem 1.2] and (4.4), let $\tau_{1}=2^{\frac{1}{n-2}} \tau>0$,

$$
\begin{align*}
\sup _{b(x) \leq r}|\nabla u|^{2}(x) & \leq \sup _{B\left(\mathrm{~V}_{M}^{\frac{1}{2-n}}\left(1+\epsilon_{0}\right)^{\frac{1}{n-2}} r\right)}|\nabla u|^{2} \\
& \leq \frac{C\left(n, \tau_{1}\right)}{\operatorname{Vol}\left(B\left(\tau_{1} \mathrm{~V}_{M}^{\frac{1}{2-n}}\left(1+\epsilon_{0}\right)^{\frac{1}{n-2}} r\right)\right)} \int_{B\left(\tau_{1} \mathrm{~V}_{M}^{\frac{1}{2-n}}\left(1+\epsilon_{0}\right)^{\frac{1}{n-2}} r\right)}|\nabla u|^{2} \\
& \leq \frac{C(n, \tau)}{\mathrm{V}_{M} \cdot\left(\tau_{1} \mathrm{~V}_{M}^{\frac{1}{2-n}}\left(1+\epsilon_{0}\right)^{\frac{1}{n-2}} r\right)^{n}} \int_{b \leq \tau_{1}\left(1-\epsilon_{0}^{2}\right)^{\frac{1}{n-2}} r}|\nabla u|^{2} \\
& \leq \frac{C(n, \tau)}{\mathrm{V}_{M}^{\frac{2}{2-n}} r^{-2} D(\tau r) .} \tag{4.5}
\end{align*}
$$

Integrating (4.5) along geodesics starting at $p$ and using $u(p)=0$, we obtain $\sup _{b(x) \leq r}|u|^{2}(x) \leq \frac{C(n, \tau)}{\mathrm{V}_{M}^{\frac{2}{2-n}}} D(\tau r)$.

Lemma 4.5. If $u(x)$ is harmonic on $B_{2 r}(p) \subset M^{n}$ with $\max _{s \leq 2 r} \mathscr{F}_{u}(s) \leq d$ and $u(p)=0$, where $r \geq \max \left\{1, R\left(M^{n}, p, n\right)\right\}$, then $\sup _{b \leq r}|u| \leq C\left(n, \mathrm{~V}_{M}, d\right) r^{d} I_{u}(1)^{\frac{1}{2}}$.

Proof: From Lemma 4.4, we have

$$
\begin{equation*}
\sup _{b \leq r}|u|^{2} \leq \frac{C(n)}{\mathrm{V}_{M}^{\frac{2}{2-n}}} D(2 r), \quad \forall r \geq R\left(M^{n}, p, n\right) \tag{4.6}
\end{equation*}
$$

By Lemma 5.1, for any $s \in[1,2 r]$, we have

$$
\begin{equation*}
I(s)=\exp \left(2 \int_{1}^{s} \frac{\mathscr{F}(t)}{t} d t\right) I(1) \leq I(1) s^{2 d} \tag{4.7}
\end{equation*}
$$

From (4.7), we have

$$
\begin{equation*}
D(s)=I(s) \mathscr{F}(s) \leq I(1) d \cdot s^{2 d}, \quad \forall s \in[1,2 r] \tag{4.8}
\end{equation*}
$$

By (4.8) and (4.6), we obtain

$$
\sup _{b \leq r}|u|^{2} \leq \frac{C(n) D(2 r)}{\mathrm{V}_{M}^{\frac{2}{2-n}}} \leq C\left(n, \mathrm{~V}_{M}\right) I(1) d r^{2 d}=C\left(n, \mathrm{~V}_{M}, d\right) r^{2 d} I(1)
$$

Lemma 4.6. If there exists a sequence of non-zero harmonic functions $u_{i}(x)$ defined on $B_{r_{i}}(p) \subseteq M^{n}$, where $\lim _{i \rightarrow \infty} r_{i}=\infty$, satisfying $u_{i}(p)=0$ and $\max _{s \leq r_{i}} \mathscr{F}_{u_{i}}(s) \leq d$ for some $d>0$, then there exists a non-constant polynomial growth harmonic function $u$ with degree $\leq d$.

Proof: Consider $I_{u_{i}}(1)$, if $I_{u_{i}}(1)=0$, from the maximum principle, we know that $\left.u_{i}\right|_{B_{1}(p)}=0$. Applying unique continuation theorem on $u_{i}$, we get $\left.u_{i}\right|_{B_{r_{i}}(p)}=0$, which is the contradiction. Hence $I_{u_{i}}(1) \neq 0$, we can define $\tilde{u}_{i}(x)=\frac{u_{i}(x)}{I_{u_{i}}(1)^{\frac{1}{2}}}$.

From Lemma 5.1 we have $n \omega_{n} u_{i}(p)^{2}=\lim _{r \rightarrow 0} I_{u_{i}}(r) \leq I_{u_{i}}(1)$, which implies

\left|u_{i}(p)\right| \leq\left(\frac{I_{u_{i}}(1)}{n \omega_{n}}\right)^{\frac{1}{2}} \tag{4.9}
\end{equation*}
$$

From (4.9), we have

\left|\tilde{u}_{i}(p)\right| \leq\left(\frac{1}{n \omega_{n}}\right)^{\frac{1}{2}}, \quad \quad I_{\tilde{u}_{i}}(1)=1 \tag{4.10}
\end{equation*}

From Lemma 4.5 and the assumption on $u_{i}$, using (4.9), we know that

\sup _{B_{\frac{r_{i}^{2}}{2}}(p)}\left|u_{i}\right| \leq\left|u_{i}(p)\right|+C(n, d) r_{i}^{d} I_{u_{i}}(1)^{\frac{1}{2}} \leq C(n, d) r_{i}^{d} I_{u_{i}}(1)^{\frac{1}{2}},
$$

which implies sup $\left|\tilde{u}_{i}\right| \leq C(n, d) r_{i}^{d}$. From compactness theorem of harmonic func$B_{\frac{r_{i}}{2}}(p)$
tions and the above growth estimate for $u_{i}$, after taking suitable subsequence, $\tilde{u}_{i}$ converges to a polynomial growth harmonic function $u(x)$ with degree $\leq d$ on $M^{n}$. From (4.10), we know that $u$ satisfies $I_{u}(1)=1$, hence $u(x)$ is not constant by $u_{i}(p)=0$. The conclusion is proved.

Proposition 4.7. For $\gamma \geq 1$, there is $R_{2}=R_{2}\left(M^{n}, p, \delta, \gamma\right)$, such that for $R \geq R_{2}$ and harmonic function $u$ on $B_{R} \subseteq M^{n}$, if $I_{u}(r) \leq \gamma \cdot I_{u}\left(\frac{r}{2}\right)$ for any $r \in\left[2^{-1} R, 2 R\right]$, then $\sup _{s \in\left[\frac{1}{2} R, R\right]} \mathscr{F}(s) \leq 14 \ln \gamma$. $s \in\left[\frac{1}{2} R, R\right]$

Proof: Step (1).From Lemma4.4, we obtain $\sup _{b(x) \leq \frac{r}{2}}|u|^{2}(x) \leq \frac{C(n)}{\mathrm{V}_{M}^{\frac{2}{2}-n}} D\left(\frac{5}{8} r\right)$. Hence

& =\frac{C(n)}{\mathrm{V}_{M}^{\frac{2}{2-n}}} D\left(\frac{5}{8} r\right) I_{1}\left(\frac{r}{2}\right)=C(n) \mathrm{V}_{M}^{\frac{2}{n-2}} D\left(\frac{5}{8} r\right), \tag{4.11}
\end{align*}
$$

in the last equation we use Lemma 5.1. Also from Lemma 5.1

\int_{\frac{14}{15} r}^{r} \frac{2 D(s)}{s} d s=I(r)-I\left(\frac{14}{15} r\right) \leq I(r)
$$

which implies $2 \int_{\frac{14}{15} r}^{r} s^{n-2} D(s) d s \leq r^{n-1} I(r)$. Note $s^{n-2} D(s)$ is nondecreasing in $s$ from the definition of $D(r)$, we get $\frac{1}{7}\left(\frac{14}{15} r\right)^{n-1} D\left(\frac{14}{15} r\right) \leq r^{n-1} I(r)$. Combining (4.11), simplifying the above inequality yields

\sup _{b(x) \leq \frac{7}{8} r}|\nabla u|^{2}(x) & \leq C(n) \mathrm{V}_{M}^{\frac{2}{n-2}} r^{-2} D\left(\frac{14}{15} r\right) \leq C\left(n, \mathrm{~V}_{M}\right) r^{-2} \gamma D\left(\frac{5}{8} r\right) \\
& =C\left(n, \mathrm{~V}_{M}\right) \gamma r^{-n} \int_{b \leq \frac{5}{8} r}|\nabla u|^{2}
\end{aligned}
$$

hence we get

& \geq-C\left(n, \mathrm{~V}_{M}\right) \gamma \cdot\left\{\frac{\left.\int_{b \leq s}| | \nabla b\right|^{2}-1\left|+\left|2 g-\nabla^{2}\left(b^{2}\right)\right|\right.}{s^{n+1}}+\frac{\int_{b=s}| | \nabla b\left|-|\nabla b|^{-1}\right|}{s^{n}}\right\} \\
& \geq-C\left(n, \mathrm{~V}_{M}\right) \gamma \cdot\left\{\frac{\left.f_{b \leq s}| | \nabla b\right|^{2}-1\left|+\left|2 g-\nabla^{2}\left(b^{2}\right)\right|\right.}{s}+\frac{\int_{b=s}| | \nabla b\left|-|\nabla b|^{-1}\right|}{r^{n}}\right\} \\
& \geq-C\left(n, \mathrm{~V}_{M}\right) \gamma \cdot\left\{\frac{\delta}{s}+\frac{\int_{b=s}| | \nabla b\left|-|\nabla b|^{-1}\right|}{r^{n}}\right\} .
\end{aligned}
$$

Hence take the integral of the above inequality, we obtain

\int_{\frac{5}{8} r}^{\frac{7}{8} r}(\ln \mathscr{F}(s))^{\prime} d s & \left.\geq-C\left(n, \mathrm{~V}_{M}\right) \gamma \delta-C\left(n, \mathrm{~V}_{M}\right) \gamma r^{-n} \int_{\frac{5}{8} r \leq b \leq \frac{7}{8} r}|\nabla b|^{2}-1 \right\rvert\, \\
& \left.\geq-C\left(n, \mathrm{~V}_{M}\right) \gamma \delta-\left.C\left(n, \mathrm{~V}_{M}\right) \gamma f_{b \leq \frac{7}{8} r}| | \nabla b\right|^{2}-1 \right\rvert\, \\
& \geq-C\left(n, \mathrm{~V}_{M}\right) \gamma \delta,
\end{aligned}
$$

in the first inequality above we use the Co-area formula. Hence there exists $\delta_{0}=$ $\delta_{0}\left(n, \mathrm{~V}_{M}, \gamma\right)$, such that if $\delta \leq \delta_{0}$,

Hence there exists $s_{i} \in\left[\frac{3}{4} r, \frac{7}{8} r\right]$ such that $\mathscr{F}\left(s_{i}\right) \leq \frac{7}{2} \ln \gamma$. For this $s_{i}$, similar to the above argument, in fact we have $\int_{s}^{s_{i}}(\ln \mathscr{F})^{\prime}(t) d t \geq-1$ for any $s \in\left[\frac{5}{8} r, \frac{11}{16} r\right]$, which implies

\sup _{s \in\left[\frac{5}{8} r, \frac{11}{16} r\right]} \mathscr{F}(s) \leq e \mathscr{F}\left(s_{i}\right) \leq 14 \ln \gamma, \quad \forall r \in\left[2^{-1} R, 2 R\right]

then we get that $\sup \mathscr{F}(s) \leq e \mathscr{F}\left(s_{i}\right) \leq 14 \ln \gamma$.

s \in\left[\frac{1}{2} R, R\right]

Now we conclude this section with the proof of Theorem 1.4
Proof: [of Theorem 1.4] Step (1). From [CC96], we know any tangent cone at infinity of $M^{n}$ is a metric cone, choose one denoted as $C(X)$. Consider $\varphi_{1}(x)$ is the eigenfunction on $X$ with respect to eigenvalue $\lambda_{1}=\alpha_{1}\left(\alpha_{1}+n-2\right), \int_{X}\left|\varphi_{1}\right|^{2}=1$. Let $u_{\infty}=r^{\alpha_{1}} \varphi_{1}(x)$, then $u_{\infty}$ is harmonic on $C(X)$ and $u_{\infty}\left(p_{\infty}\right)=0$.

From [Xu16, Lemma 4.1], there exist $R_{i} \rightarrow \infty, B\left(R_{i}\right) \subset M^{n}$, such that

$$
\lim _{i \rightarrow \infty} d_{G H}\left(B_{i}(1), B_{\infty}(1)\right)=0,
$$

where $B_{i}(1) \subset\left(M^{n}, R_{i}^{-2} g\right), B_{\infty}(1) \subset C(X)$. And $u_{i}$ is harmonic on $B_{p}\left(R_{i}\right)=B_{i}(1)$ satisfying the following property:

where $\Psi_{\infty, i}: B_{\infty}(1) \rightarrow B_{i}(1)$ is an $\epsilon_{i}$-Gromov-Hausdorff approximation, and $\lim _{i \rightarrow \infty} \epsilon_{i}=0$. From Proposition 3.4 in Hon15], we have

Note $R_{i}^{-1} r_{i} \in\left[4^{-1}, 1\right]$, without loss of generality, we can assume that there exists a subsequence of $\{i\}$, for simplicity also denoted as $\{i\}$ such that

\end{equation*}

where $c_{0}$ is some constant. Taking the limit in (4.17), from (4.18) and 4.15), note $b_{\infty}=\rho_{\infty}$ on $C(X)$, we have

c_{0}^{1-n} \int_{\rho_{\infty}=c_{0}}\left|u_{\infty}\right|^{2} d v_{\infty} \geq 2^{2 d}\left(\frac{c_{0}}{2}\right)^{1-n} \int_{\rho_{\infty}=\frac{c_{0}}{2}}\left|u_{\infty}\right|^{2} d v_{\infty} \tag{4.19}
\end{equation*}
$$

From $u_{\infty}=r^{\alpha_{1}} \varphi_{1}(x)$ and $d>\alpha_{1}$, 4.19) implies $\int_{X}\left|\varphi_{1}(x)\right|^{2} d x=0$, which is contradiction.

From (4.16) and Proposition 4.7, we get that $\sup _{s \in\left[4^{-1} R_{i}, 2^{-1} R_{i}\right]} \mathscr{F}_{u_{i}}(s) \leq 28 d \ln 2$. From quantitative strong unique continuation, we have $\sup _{s \in\left[0,2^{-1} R_{i}\right]} \mathscr{F}_{u_{i}}(s) \leq C\left(n, d, \mathrm{~V}_{M}\right)$. Now applying Lemma ??, we obtain the existence of non-constant polynomial growth harmonic function on $M^{n}$.

## 5. The frequency of linear growth harmonic functions

Lemma 5.1. If $u$ is a harmonic function, we have $I_{u}^{\prime}(r)=2 \frac{D_{u}(r)}{r}$, and

$$
u(p)=\frac{1}{n \omega_{n} r^{n-1}} \int_{b=r} u|\nabla b|, \quad \forall r>0
$$

Remark 5.2. The formula $I_{u}^{\prime}(r)=2 \frac{D_{u}(r)}{r}$ firstly appeared in [CM97a], for reader's convenience we include its proof here.

Proof: Firstly, we note $\frac{\partial}{\partial r}=\frac{\nabla b}{|\nabla b|^{2}}$, assume the volume element of $b^{-1}(r)$ is $J\left(b^{-1}(r)\right)$, then we have

\begin{aligned}
I^{\prime}(r)= & (1-n) r^{-n} \int_{b=r} u^{2}|\nabla b|+r^{1-n} \int_{b=r} 2 u\left\langle\nabla u, \frac{\nabla b}{|\nabla b|}\right\rangle \\
& +r^{1-n} \int_{b=r} u^{2}\left(\frac{\nabla_{\nabla b}|\nabla b|}{|\nabla b|^{2}}+\frac{\nabla_{\nabla b} J\left(b^{-1}(r)\right)}{|\nabla b| J\left(b^{-1}(r)\right)}\right) d x \\
= & 2 \frac{D_{u}(r)}{r}+(1-n) r^{-n} \int_{b=r} u^{2}|\nabla b|+r^{1-n} \int_{b=r} \frac{u^{2}}{|\nabla b|} \Delta b
\end{aligned}
$$

where we use the Divergence Theorem, $u$ is harmonic and the fact $\left(\frac{\nabla_{\nabla b}|\nabla b|}{|\nabla b|}+\right.$ $\left.\frac{\nabla_{\nabla b} J\left(b^{-1}(r)\right)}{J\left(b^{-1}(r)\right)}\right)=\Delta b$. From $\Delta\left(b^{2-n}\right)=0$, we have $\Delta b=\frac{n-1}{b}|\nabla b|^{2}$, plug into the above equation, we get $I_{u}^{\prime}(r)=2 \frac{D_{u}(r)}{r}$.

Similarly, we have

$$
\begin{aligned}
& \frac{d}{d r}\left(r^{1-n} \int_{b=r} u|\nabla b|\right) \\
= & (1-n) r^{-n} \int_{b=r} u|\nabla b|+r^{1-n} \int_{b=r}\left\langle\nabla u, \frac{\nabla b}{|\nabla b|}\right\rangle \\
& +r^{1-n} \int_{b=r} u\left(\frac{\nabla_{\nabla b}|\nabla b|}{|\nabla b|^{2}}+\frac{\nabla_{\nabla b} J\left(b^{-1}(r)\right)}{|\nabla b| J\left(b^{-1}(r)\right)}\right) d x \\
= & r^{1-n} \int_{b \leq r} \Delta u+(1-n) r^{-n} \int_{b=r} u|\nabla b|+r^{1-n} \int_{b=r} \frac{u}{|\nabla b|} \Delta b \\
= & (1-n) r^{-n} \int_{b=r} u|\nabla b|+r^{1-n} \int_{b=r} \frac{u}{|\nabla b|} \Delta b=0 .
\end{aligned}
$$

Finally, we get

r^{1-n} \int_{b=r} u|\nabla b|=\lim _{r \rightarrow 0} r^{1-n} \int_{b=r} u|\nabla b|=u(p) \lim _{r \rightarrow 0} r^{1-n} \int_{b=r}|\nabla b|=u(p) n \omega_{n} .
$$

Lemma 5.3. If $u(p)=0$, then $\mathscr{F}_{u}(0)=\frac{1}{2} \min \left\{m \geq 0:\left.\frac{d^{m}}{d r^{m}} I_{u}(r)\right|_{r=0} \neq 0\right\} \in \mathbb{Z}^{+}$.
Proof: From Lemma 5.1 and by induction, it is straightforward to get

\frac{d^{m}}{d r^{m}} I(r)=r^{1-n} \int_{b=r}|\nabla b| \frac{\partial^{m}}{\partial r^{m}}\left(u^{2}\right), \quad \forall m \geq 0
$$

Let $u \equiv 1$ in Lemma5.1, we get $r^{1-n} \int_{b=r}|\nabla b|=n \omega_{n}$. Hence

$$
\lim _{r \rightarrow 0} \frac{d^{m}}{d r^{m}} I(r)=\left.n \omega_{n} \cdot \frac{\partial^{m}}{\partial r^{m}}\left(u^{2}\right)\right|_{r=0}, \quad \forall m \geq 0
$$

Let $j=\max \left\{s:\left.\frac{\partial^{t}}{\partial r^{t}} u\right|_{r=0}=0,0 \leq t \leq s\right\}$, then $\left.\frac{\partial^{t}}{\partial r^{t}}\left(u^{2}\right)\right|_{r=0}=0$ for all $0 \leq t \leq$ $(2 j+1)$, and $\left.\frac{\partial^{2 j+2}}{\partial r^{2 j+2}}\left(u^{2}\right)\right|_{r=0} \neq 0$. From Lemma5.1, we know that $D(r)=\frac{1}{2} r \cdot I^{\prime}(r)$, hence $\left.D^{(2 j+2)}(r)\right|_{r=0}=\left.\frac{2 j+2}{2} I^{(2 j+2)}(r)\right|_{r=0}$. By the L'Hospital rule, we have $\mathscr{F}(0)=$ $\frac{D^{(2 j+2)}(0)}{I^{(2 j+2)}(0)}=j+1$.
Corollary 5.4. For any non-constant harmonic function u defined on $B_{r}(p) \subseteq M^{n}$, there exists $C\left(p, r, M^{n}, u\right)<\infty$ such that $\sup _{s \in[0, r]} \mathscr{F}_{u}(s) \leq C\left(p, r, M^{n}, u\right)$.

Proof: Note if $\mathscr{F}_{u}(s)=\infty$ for any $s>0$, then $\left.u\right|_{b(x) \leq s}=0$. From the unique continuation property of harmonic functions, we know that $u \equiv 0$, it is the contradiction. Now the conclusion follows from Lemma[5.3] and the continuity of $\mathscr{F}_{u}(s)$ with respect to $s$.

The following lemma was proved in [Li86].
Lemma 5.5. Let $M^{n}$ be a complete manifold with $R c \geq 0$. Suppose $f$ is a bounded subharmonic function defined on $M^{n}$, then $\lim _{r \rightarrow \infty} f_{B_{r}(p)} f=\sup _{M^{n}} f$.

Lemma 5.6. For any $\epsilon_{0} \in(0,1)$, there exists $r_{0}>0$ such that for any $r \geq(1-$ $\left.\epsilon_{0}\right)^{\frac{1}{2-n}} \mathrm{~V}_{M}^{\frac{1}{n-2}} r_{0}$, and harmonic function $u$ on $M^{n}$,
$\left(1-\epsilon_{0}\right)^{\frac{n}{2-n}} \int_{\rho \leq\left(1-\epsilon_{0}\right)^{\frac{1}{2-n}} \mathrm{~V}_{M}^{\frac{1}{2-n}} r}|\nabla u|^{2} \leq \frac{D(r)}{\omega_{n} \mathrm{~V}_{M}^{\frac{2}{2-n}} r^{2}} \leq\left(1+\epsilon_{0}\right)^{\frac{n+1}{n-2}} \int_{\rho \leq\left(1+\epsilon_{0}\right)^{\frac{1}{n-2}} \frac{1}{M}_{\frac{1}{2-n} r}}|\nabla u|^{2}$.
Proof: From Lemma 4.3, for $\epsilon_{0}>0$, there is $r_{0}>0$ such that for any $r \geq$ $\left(1-\epsilon_{0}\right)^{\frac{1}{2-n}} \mathrm{~V}_{M}^{\frac{1}{n-2}} r_{0}$, we have

\begin{aligned}
D(r) & =r^{2-n} \int_{b \leq r}|\nabla u|^{2} \geq r^{2-n} \int_{\rho \leq\left(1-\epsilon_{0}\right)^{\frac{1}{2-n}} \mathrm{~V}_{M}^{\frac{1}{2-n}} r}|\nabla u|^{2} \\
& \geq \frac{\operatorname{Vol}\left(\rho \leq\left(1-\epsilon_{0}\right)^{\frac{1}{2-n}} \mathrm{~V}_{M}^{\frac{1}{2-n}} r\right)}{r^{n-2}} \int_{\rho \leq\left(1-\epsilon_{0}\right)^{\frac{1}{2-n}} \mathrm{~V}_{M}^{\frac{1}{2-n}} r}|\nabla u|^{2} \\
& \geq\left(1-\epsilon_{0}\right)^{\frac{n}{2-n}} \omega_{n} \mathrm{~V}_{M}^{\frac{2}{2-n}} r^{2} f_{\rho \leq\left(1-\epsilon_{0}\right)^{\frac{1}{2-n}} \mathrm{~V}_{M}^{\frac{1}{2-n} r} r}|\nabla u|^{2},
\end{aligned}
$$

and

$$
\begin{aligned}
D(r) & =r^{2-n} \int_{b \leq r}|\nabla u|^{2} \leq r^{2-n} \int_{\rho \leq\left(1+\epsilon_{0}\right)^{\frac{1}{n-2}} \mathrm{~V}_{M}^{\frac{1}{2-n} r}}|\nabla u|^{2} \\
& \leq \frac{\operatorname{Vol}\left(\rho \leq\left(1+\epsilon_{0}\right)^{\frac{1}{n-2}} \mathrm{~V}_{M}^{\frac{1}{2-n}} r\right)}{r^{n-2}} \int_{\rho \leq\left(1+\epsilon_{0}\right)^{\frac{1}{n-2}} \mathrm{~V}_{M}^{\frac{1}{2-n}} r}|\nabla u|^{2} \\
& \leq\left(1+\epsilon_{0}\right)^{\frac{n+1}{n-2}} \omega_{n} \mathrm{~V}_{M}^{\frac{2}{2-n}} r^{2} \int_{\rho \leq\left(1+\epsilon_{0}\right)^{\frac{1}{n-2}} \mathrm{~V}_{M}^{\frac{1}{2-n} r}}|\nabla u|^{2} .
\end{aligned}
$$

Proposition 5.7. For linear growth harmonic function $u$ on $M^{n}, \lim _{s \rightarrow \infty} \mathscr{F}_{u}(s)=1$.
Proof: Without loss of generality, we can assume $\sup _{M^{n}}|\nabla u|=1$. By Bochner formula and $u$ is harmonic, one gets that $|\nabla u|^{2}$ is a bounded subharmonic function. From Lemma 5.6 for any $\epsilon_{0} \in(0,1)$, there exists $r_{0}>0$ such that if $r \geq r_{0}$, we have

$$
\psi_{1}\left(\epsilon_{0}\right) \varphi\left(\psi_{2}\left(\epsilon_{0}\right) \mathrm{V}_{M}^{\frac{1}{2-n}} r\right) \leq \frac{D(r)}{\mathrm{V}_{M}^{\frac{2}{2-n}} r^{2}} \leq \psi_{3}\left(\epsilon_{0}\right) \varphi\left(\psi_{4}\left(\epsilon_{0}\right) \mathrm{V}_{M}^{\frac{1}{2-n}} r\right),
$$

where $\varphi(s)=f_{\rho \leq s}|\nabla u|^{2}$ and $\psi_{i}(\cdot)$ are functions satisfying $\lim _{t \rightarrow 0} \psi_{i}(t)=1, i=1,2, \cdots$.
The above inequality implies that for any $s \in\left[r_{0}, r\right]$,

$$
\psi_{5}\left(\epsilon_{0}\right) \frac{s^{2}}{r^{2}} \cdot \frac{\varphi\left(\psi_{2}\left(\epsilon_{0}\right) \mathrm{V}_{M}^{\frac{1}{2-n}} s\right)}{\varphi\left(\psi_{4}\left(\epsilon_{0}\right) \mathrm{V}_{M}^{\frac{1}{2-n}} r\right)} \leq \frac{D(s)}{D(r)} \leq \psi_{6}\left(\epsilon_{0}\right) \frac{s^{2}}{r^{2}} \cdot \frac{\varphi\left(\psi_{4}\left(\epsilon_{0}\right) \mathrm{V}_{M}^{\frac{1}{2-n}} s\right)}{\varphi\left(\psi_{2}\left(\epsilon_{0}\right) \mathrm{V}_{M}^{\frac{1}{2-n}} r\right)}
$$

Combining Lemma5.5, if $r_{0}$ is big enough, we have

$$
\psi_{5}\left(\epsilon_{0}\right) \frac{s^{2}}{r^{2}}\left(1-\epsilon_{0}\right) \leq \frac{D(s)}{D(r)} \leq \psi_{6}\left(\epsilon_{0}\right) \frac{s^{2}}{r^{2}} \cdot\left(1+\epsilon_{0}\right)
$$

which implies $\psi_{7}\left(\epsilon_{0}\right) \frac{s^{2}}{r^{2}} \leq \frac{D(s)}{D(r)} \leq \psi_{8}\left(\epsilon_{0}\right) \frac{s^{2}}{r^{2}}$. From Lemma 5.1,

$$
\mathscr{F}(r)=\frac{D(r)}{I\left(r_{0}\right)+\int_{r_{0}}^{r} I^{\prime}(s) d s}=\frac{D(r)}{I\left(r_{0}\right)+\int_{r_{0}}^{r} \frac{2 D(s)}{s} d s}=\frac{1}{\frac{I\left(r_{0}\right)}{D(r)}+2 \int_{r_{0}}^{r} \frac{1}{s} \frac{D(s)}{D(r)} d s} .
$$

Note $I\left(r_{0}\right) \geq 0$, if we assume $r \geq 2 r_{0}$, we get

$$
\mathscr{F}(r) \leq \frac{1}{2 \int_{r_{0}}^{r} \frac{1}{s} \frac{D(s)}{D(r)} d s} \leq \frac{1}{2 \psi_{7}\left(\epsilon_{0}\right) \int_{r_{0}}^{r} \frac{s}{r^{2}} d s}=\frac{\psi_{9}\left(\epsilon_{0}\right)}{1-\frac{r_{0}^{2}}{r^{2}}},
$$

which implies $\lim _{r \rightarrow \infty} \mathscr{F}(r) \leq \psi_{9}\left(\epsilon_{0}\right)$. Letting $\epsilon_{0} \rightarrow 0$, we get $\lim _{r \rightarrow \infty} \mathscr{F}(r) \leq 1$.
On the other hand, similar to the above, we get

$$
\mathscr{F}(r) \geq \frac{1}{\frac{I\left(r_{0}\right)}{D(r)}+2 \psi_{8}\left(\epsilon_{0}\right) \int_{r_{0}}^{r} \frac{s}{r^{2}} d s} \geq \frac{1}{\frac{I\left(r_{0}\right)}{\left.\left.\psi_{1}\left(\epsilon_{0}\right) \varphi\left(\psi_{2}\left(\epsilon_{0}\right)\right)_{M}^{\frac{1}{2-n}} r\right)\right)_{M}^{\frac{2}{2}-r^{2}} r^{2}}+\psi_{8}\left(\epsilon_{0}\right)\left[1-\frac{r_{0}^{2}}{r^{2}}\right]}
$$

which implies $\lim _{r \rightarrow \infty} \mathscr{F}(r) \geq 1$. The conclusion follows.
Recall S.-Y. Cheng [Che80] proved that any non-constant polynomial growth harmonic function is at least linear growth. From [CCM95, Theorem 1], we know that on $M^{n}$ with $R c \geq 0$, the existence of non-constant linear growth harmonic function implies, that any tangent cone at infinity of $M^{n}, M_{\infty}$, will split isometrically as $\mathbb{R} \times N$. The following rigidity result links the geometric structure of $M^{n}$ with the frequency upper bound of global harmonic functions.

Corollary 5.8. For harmonic function $u$ with $u(p)=0$, if $\sup _{s \geq 0} \mathscr{F}_{u}(s) \leq 1$, then $M^{n}$ is isometric to $\mathbb{R}^{n}$.

Proof: From Lemma 4.5 and $\mathscr{F}(s) \leq 1$, we know that $u$ is linear growth. Hence we can assume that $\sup _{M^{n}}|\nabla u|=1$ by rescaling. From Lemma 5.1, we have $\frac{I^{\prime}}{I}(r)=$ $\frac{2}{r} \mathscr{F}(r)$, which implies $I(r)=I(1) e^{\int_{1}^{r} \frac{2 \mathscr{F}(s)}{s} d s}$ and

$$
D(r)=I(r) \mathscr{F}(r)=I(1) \mathscr{F}(r) e^{\int_{1}^{r} \frac{2 \mathscr{F}(s)}{s} d s}
$$

By Lemma 4.3 and Proposition 5.7, for any $\epsilon_{0}>0$ the followings hold:

$$
\begin{aligned}
I(1) & =\lim _{r \rightarrow \infty} \frac{D(r)}{\mathscr{F}(r) e^{r} \int_{1}^{r \frac{2 \mathscr{F}(s)}{s} d s}}=\lim _{r \rightarrow \infty} \frac{r^{2-n} \int_{b \leq \leq}|\nabla u|^{2}}{\mathscr{F}(r) e^{\int_{1}^{r}} \frac{2 \mathscr{F}(s)}{s} d s} \\
& \geq \lim _{r \rightarrow \infty} \frac{r^{2}}{\mathscr{F}(r) e^{r} \int_{1}^{r \frac{2 \mathscr{F}(s)}{s}} d s} \cdot \frac{\int_{\rho \leq\left(1-\epsilon_{0}\right)} \frac{1}{2-n} r \mathrm{~V}_{M}^{\frac{1}{2-n}}|\nabla u|^{2}}{r^{n}} \\
& =\lim _{r \rightarrow \infty} \frac{r^{2}}{\mathscr{F}(r) e_{1}^{r} \frac{2 \mathscr{F}(s)}{s} d s} \cdot \lim _{r \rightarrow \infty} \frac{V\left(\rho \leq r V_{M}^{\frac{1}{2-n}}\left(1-\epsilon_{0}\right)^{\frac{1}{2-n}}\right)}{r^{n}} \sup _{M^{n}}|\nabla u|^{2} \\
& =\omega_{n} \mathrm{~V}_{M}^{\frac{2}{2-n}}\left(1-\epsilon_{0}\right)^{\frac{n}{2-n}} .
\end{aligned}
$$

On the other hand, by $u(p)=0$ and Lemma 5.3, we know $\lim _{r \rightarrow 0} \mathscr{F}(r) \geq 1$, hence $\mathscr{F}(0)=1$ and

$$
\begin{aligned}
I(1) & =\lim _{r \rightarrow 0} \frac{D(r)}{\mathscr{F}(r) e^{\int_{1}^{r} \frac{2 \mathscr{F}(s)}{s} d s}} \leq \lim _{r \rightarrow 0} \frac{D(r)}{r^{2}} \cdot \frac{r^{2}}{e^{\int_{1}^{r} \frac{\mathscr{F}(s)}{s} d s}} \\
& \leq \lim _{r \rightarrow 0} \frac{\int_{b \leq r}|\nabla u|^{2}}{r^{n}} \cdot \varlimsup_{r \rightarrow 0} \frac{r^{2}}{e_{1}^{r} \frac{2 \mathscr{F}(s)}{s} d s}=\omega_{n}|\nabla u|^{2}(p) .
\end{aligned}
$$

Combining the above, we get

$$
|\nabla u|^{2}(p) \geq\left(1-\epsilon_{0}\right)^{\frac{n}{2-n}} V_{M}^{\frac{2}{2-n}} \geq\left(1-\epsilon_{0}\right)^{\frac{n}{2-n}} .
$$

Letting $\epsilon_{0} \rightarrow 0$ in the above, we have $|\nabla u|^{2}(p) \geq 1$. From the strong maximum principle and $\Delta|\nabla u|^{2} \geq 0$, we get $|\nabla u|^{2} \equiv 1$. This implies $\mathrm{V}_{M}=1$, hence $M^{n}$ is isometric to $\mathbb{R}^{n}$.

Now we present the proof of Theorem 1.5 .
Proof: [of Theorem 1.5] From [LT89], $\operatorname{dim} \mathcal{H}_{1}\left(M^{n}\right)<\infty$, where $\mathcal{H}_{1}\left(M^{n}\right)$ is the space of linear growth harmonic functions on $M^{n}$. We can assume $\mathcal{H}^{\prime}(M)=\{f$ : $\left.f(p)=0, f \in \mathcal{H}_{1}(M)\right\}$, and define the inner product as

$$
\langle f, g\rangle=\lim _{r \rightarrow \infty} f_{B_{r}(p)} \nabla f \cdot \nabla g
$$

which is well-defined by Lemma 5.5
Assume $\left\{u_{i}\right\}_{i=1}^{m}$ be an orthonormal basis of $\mathcal{H}^{\prime}(M)$, to prove the conclusion, we only need to show that $\mathscr{F}_{u}(r) \leq C\left(M^{n}\right)$, where $u=\sum_{i=1}^{m} a_{i} u_{i}$ with $\sum_{i=1}^{m}\left|a_{i}\right|^{2}=1$.

For any $\epsilon_{0}>0$, there is $R_{0}>0$ such that if $t \geq R_{0}$, we have

$$
\begin{aligned}
& \left|f_{\psi_{k}\left(\epsilon_{0}\right) \mathrm{v}_{M}^{\frac{1}{2-n}}(p)} \nabla u_{i} \cdot \nabla u_{j}-\delta_{i j}\right| \leq \epsilon_{0}, \quad 1 \leq i, j \leq m, 1 \leq k \leq 4, \\
& \left.\left.\left|f_{\psi_{k}\left(\epsilon_{0}\right) \mathrm{v}_{M}^{\frac{1}{2-n}}(p)}\right| \nabla u\right|^{2}-1\left|\leq \sum_{i, j=1}^{m}\right| a_{i} a_{j}|\cdot| f_{\psi_{\psi_{k}\left(\epsilon_{0}\right) \mathrm{v}_{M}^{\frac{1}{2-n}} t}(p)} \nabla u_{i} \cdot \nabla u_{j}-\delta_{i j} \right\rvert\, \\
& \leq \epsilon_{0}\left(\sum_{i=1}^{m}\left|a_{i}\right|\right)^{2} \leq m \epsilon_{0} .
\end{aligned}
$$

Then from Lemma5.6, for $r \geq s \geq R_{0}$, we get

$$
\frac{D_{u}(s)}{D_{u}(r)} \geq \frac{\psi_{1}\left(\epsilon_{0}\right) s^{2}}{\psi_{3}\left(\epsilon_{0}\right) r^{2}} \frac{f_{B}}{f_{B} \psi_{\left.\left.\psi_{4}\left(\epsilon_{0}\right)\right)_{M}\right) v_{M}^{\frac{1}{2-n}}(p)}|\nabla u|^{2}}(p)|\nabla u|^{2} \quad \geq \frac{1-m \epsilon_{0}}{1+m \epsilon_{0}} \psi\left(\epsilon_{0}\right) \frac{s^{2}}{r^{2}}
$$

And if $r \geq 2 R_{0}$ we get

$$
\begin{aligned}
\mathscr{F}(r) & =\frac{1}{\frac{I\left(R_{0}\right)}{D(r)}+2 \int_{R_{0}}^{r} \frac{1}{s} \frac{D(s)}{D(r)} d s} \leq \frac{1}{2 \int_{R_{0}}^{r} \frac{1}{s} \frac{D(s)}{D(r)} d s} \leq \frac{1}{2 \psi\left(\epsilon_{0}\right) \int_{R_{0}}^{r} \frac{s}{r^{2}} d s}=\frac{\psi\left(\epsilon_{0}\right)}{1-\frac{\left(R_{0}\right)^{2}}{r^{2}}} \\
& \leq \frac{4}{3} \psi\left(\epsilon_{0}\right)
\end{aligned}
$$

For $r \leq 2 R_{0}$, we claim that there is some $C>0$ such that $\mathscr{F}_{u}(r) \leq C$ for any $u \in \mathcal{H}^{\prime}\left(M^{n}\right)$. By contradiction, if there is $v_{i} \in \mathcal{H}^{\prime}\left(M^{n}\right)$ and $s_{i} \leq 2 R_{0}$ such that $\lim _{i \rightarrow \infty} \mathscr{F}_{v_{i}}\left(s_{i}\right)=\infty$. Without loss of generality, we can rescale $v_{i}$ such that $\max _{x \in B_{2 R_{0}}(p)}\left|\nabla v_{i}(x)\right|=1$. From the compactness theorem for harmonic functions, we get $\lim _{i \rightarrow \infty} s_{i}=s_{\infty} \leq 2 R_{0}$ and $v_{i} \rightarrow v_{\infty} \in \mathcal{H}_{1}\left(M^{n}\right)$, also

$$
\mathscr{F}_{v_{\infty}}\left(s_{\infty}\right)=\lim _{i \rightarrow \infty} \mathscr{F}_{v_{i}}\left(s_{i}\right)=\infty, \quad v_{\infty}(p)=0, \quad \max _{x \in B_{2 R_{0}}(p)}\left|\nabla v_{\infty}(x)\right|=1,
$$

which is the contradiction to Corollary 5.4. The conclusion follows from the above argument.

## 6. Polynomial growth harmonic functions on Perelman's manifold

From [Din04] (also see [Xu16]), we know the existence of non-constant PGHF on maximal volume growth manifolds with unique tangent cone at infinity. In this section, applying the results of [Xu16], we show the existence of non-constant PGHF on some maximal volume growth manifolds with different tangent cones at infinity, which were constructed firstly by Perelman [Per97b].

A metric space $\left(M_{\infty}, p_{\infty}, \rho_{\infty}\right)$ is a tangent cone at infinity of $M^{n}$ if it is a Gromov-Hausdorff limit of a sequence of rescaled manifolds $\left(M^{n}, p, r_{j}^{-2} g\right.$ ), where $r_{j} \rightarrow \infty$. By Gromov's compactness theorem, [Gro99], any sequence $r_{j} \rightarrow \infty$, has a subsequence, also denoted as $r_{j} \rightarrow \infty$, such that the rescaled manifolds
( $M^{n}, p, r_{j}^{-2} g$ ) converge to some tangent cone at infinity $M_{\infty}$ in the Gromov-Hausdorff sense. From Cheeger-Colding's theory of Ricci limit spaces, there exists a selfadjoint Laplace operator $\Delta_{(C(X), v)}$ on $(C(X), v) \in \mathscr{M}(M)$, where $v$ is a measure. And $v$ induces a natural measure $v_{-1}$ on $X$, which yields the existence of a selfadjoint positive Laplace operator $\Delta_{\left(X, v_{-1}\right)}$ on $\left(X, v_{-1}\right)$.

On a metric cone $\left(C(X), d r^{2}+r^{2} d X\right)$, the measure $v$ is called conic measure of power $\kappa$, and $\kappa$ is a positive constant denoted as $\mathrm{p}(v)$, if for any $\Omega \subset \subset C(X)$,

$$
v(\Omega)=\int_{0}^{\infty} r^{K-1} d r \int_{X} \chi\left(\Omega_{r}\right) d v_{-1}
$$

where $\Omega_{r}=\{z \mid z \in \Omega, r(z)=r\}, \chi(\cdot)$ is the characteristic function on $C(X)$.
And we also define $\mathscr{S}(M)$ the spectrum at infinity of $\left(M^{n}, g\right)$ and $\mathscr{D}(M)$ the degree spectrum at infinity of $\left(M^{n}, g\right)$ :
$\mathscr{S}(M):=\left\{\lambda \mid \lambda=\lambda_{j}\left(X, v_{-1}\right)\right.$ for some positive interger $j$ and $\left.(C(X), v) \in \mathscr{M}(M)\right\}$
$\mathscr{D}(M):=\left\{\alpha \geq 0 \mid \alpha(\kappa+\alpha-2)=\lambda\right.$ for some $\lambda=\lambda_{j}\left(X, v_{-1}\right) \in \mathscr{S}(M)$ and $\left.\kappa=\mathrm{p}(v)\right\}$
Recall the following theorem [Xu16, Theorem 4.3].
Theorem 6.1. Let $\left(M^{n}, g\right)$ be a complete manifold with nonnegative Ricci curvature, assume that every tangent cone at infinity of $M^{n}$ with renormalized limit measure is a metric cone $C(X)$ with conic measure of power $\kappa \geq 2$, and $\mathcal{H}^{1}(X)>0$. If there exists $d \notin \mathscr{D}(M)$ and $d>\inf \{\alpha \mid \alpha \in \mathscr{D}(M), \alpha \neq 0\}$, then $\operatorname{dim}\left(\mathscr{H}_{d}(M)\right) \geq 2$.

The following lemma was implied by Perelman's work [Per97a] (also see [AMW16]).
Lemma 6.2. For any Riemannian manifold $\left(M^{4}, g\right)$ with $R c(g)>0$, and assume the boundary $\partial M^{4}$ is isometric to round sphere $\mathbb{S}^{3}$, whose sectional curvature is equal to $r_{1}^{2}>0$, furthermore its principal curvatures $\lambda\left(\partial M^{4}\right)$ satisfy $\sup \left[\lambda\left(\partial M^{4}\right)\right]^{2} \leq$ $c_{1}^{2} r_{1}^{2}$, where $c_{1} \in(0,1)$ is some constant. Then the differential manifold $M^{4} \cup_{\mathbb{S}^{3}}\left(\mathbb{S}^{4}-\right.$ $\mathcal{B}^{4}$ ) carries a Riemannian metric $\hat{g}$ with $\operatorname{Rc}(\hat{g})>0$, where $\mathcal{B}^{4}$ is diffeomorphic to a 4-dim Euclidean ball.

To show the existence of non-constant polynomial growth harmonic functions on Perelman's example manifolds, we recall the construction of Perelman's example [Per97b] for completeness. For these manifolds with $R c \geq 0$ has maximal volume growth, the tangent cones at infinity are not unique.

Consider the metric $d s^{2}=d t^{2}+\hat{g}_{\mathbb{S}^{3}}$ defined on $\mathbb{R}^{4}$, where $t \geq 0, \hat{g}_{\mathbb{S}^{3}}=A^{2}(t) d X^{2}+$ $B^{2}(t) d Y^{2}+C^{2}(t) d Z^{2}, X, Y, Z$ are vector fields on $\mathbb{S}^{3}, T=\frac{\partial}{\partial t}$, and $X, Y, Z, T$ satisfy

$$
[X, T]=[Y, T]=[Z, T]=0, \quad[X, Y]=2 Z, \quad[Y, Z]=2 X, \quad[Z, X]=2 Y
$$

Now we take

$$
\begin{array}{ll}
A(t)=\frac{t}{10}[1+\phi(t) \sin (\ln \ln t)], & B(t)=\frac{t}{10} \cdot \frac{1}{1+\phi(t) \sin (\ln \ln t)} \\
C(t)=\frac{t}{10}[1-\gamma(t)],
\end{array}
$$

where $\phi(t)$ is a smooth function such that

$$
\begin{aligned}
& \phi(t)=0, \quad \forall t \in\left[0, t_{0}\right], \\
& \phi(t)>0, \quad \forall t>t_{0}, \\
& 0 \leq \phi^{\prime}(t) \leq \frac{1}{t^{2}} \quad \text { and } \quad\left|\phi^{\prime \prime}(t)\right| \leq \frac{1}{t^{3}},
\end{aligned}
$$

and $\gamma(t)$ is a smooth function defined on $\left[\frac{t_{0}}{2}, \infty\right)$ such that

$$
\begin{aligned}
& \gamma\left(\frac{t_{0}}{2}\right)=0, \gamma^{\prime}(t)>0, \gamma^{\prime \prime}(t)>0, \quad \forall t \in\left(\frac{t_{0}}{2}, t_{0}\right), \\
& \gamma^{\prime}(t)=\frac{1}{t \ln ^{\frac{3}{2}} t}, \quad \forall t>t_{0}
\end{aligned}
$$

We consider the manifold $\left(N^{4}, d s^{2}\right)=\left(\mathbb{R}^{4}-B_{\frac{t_{0}}{2}}(0), d s^{2}\right)$, where $B_{\frac{t_{0}}{2}}(0)$ is the metric ball with respect to the metric $d s^{2}$. One can check that $R c\left(N^{4}, d s^{2}\right)>0$ from the above properties of $g$.

Note near $\partial N^{4}, A=B=C=\frac{t}{10}$, the principal curvature $\lambda\left(\partial N^{4}\right)$ is $-\frac{1}{t}$. Because $\partial N^{4}$ is round sphere, the intrinsic sectional curvatures $\widetilde{\operatorname{Rm}}\left(\partial N^{4}\right)$ of $\partial N^{4}$ are $\frac{10^{2}}{t^{2}}$.

Hence $\left[\lambda\left(\partial N^{4}\right)\right]^{2}=\frac{1}{100} \widetilde{R m}\left(\partial N^{4}\right)$. Using Lemma 6.2, one gets the differential manifold $M^{4}=N^{4} \cup_{\mathbb{S}^{3}}\left(\mathbb{S}^{4}-\mathcal{B}^{4}\right)$, which admits a Riemannian metric $g$ with $R c(g)>$ 0 , and $g=d s^{2}$ outside of a compact subset of $M^{4}$.

We can define $\phi_{\infty}=\lim _{t \rightarrow \infty} \phi(t)>0$ and $\gamma_{\infty}=\lim _{t \rightarrow \infty} \gamma(t)>0$. Then $\mathcal{M}_{\infty}$ is a family of $\left(C(X), d t^{2}+t^{2} d X\right)$, where $\left.X=\left(\mathbb{S}^{3}, g_{X}\right)\right\}$ with

$$
g_{X}=\left(\frac{1+\phi_{\infty} \delta}{10}\right)^{2} d X^{2}+\left(\frac{1}{10} \cdot \frac{1}{1+\phi_{\infty} \delta}\right)^{2} d Y^{2}+\left(\frac{1-\gamma_{\infty}}{10}\right)^{2} d Z^{2}, \quad \forall \delta \in[-1,1] .
$$

And the conic measure is of power 4 for each $\delta$.
If we choose $\phi_{\infty}, \gamma_{\infty}$ small enough, then $\mathscr{S}\left(M^{4}\right)$ is a set close to the spectrum of $\mathbb{S}^{3}$, which implies the existence of $d \notin \mathscr{D}\left(M^{4}\right)$ satisfying $d>\inf \mathscr{D}\left(M^{4}\right)$. From [Xu16, Theorem 4.3], one gets the existence of polynomial growth harmonic functions on Perelman's example manifolds.
