# LOWER AND UPPER BOUNDS FOR SOME GENERALIZED ARCS

#### Abstract

Let $\mathbb{F}_{q}$ be a field with $q$ elements. In this note, we study some generalized arcs, that is, sets of $\mathbb{F}_{q}$-points in the projective plane $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$ such that no six of them are on a conic. First, we consider the geometric configurations of such generalized arcs for small values of $q$ and then we give some upper and lower bounds for the cardinality of complete generalized arcs, i.e. generalized arcs which are not contained in a bigger one.


## Introduction

Let $\mathbb{F}_{q}$ be a field with $q$ elements, where $q=p^{r}$ for some prime $p$ and $r \in \mathbb{Z}_{\geq 1}$. Consider the finite projective plane $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$. A $k$-arc is a set $\mathcal{K}$ of $k \mathbb{F}_{q}$-points (or, simply, points) of $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$ such that no three of them lie on a $\mathbb{F}_{q}$-line (or, simply, line) of $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$. The literature on $k$-arcs is very vast and many generalizations inherent to this concept have been considered by various authors, even in higher dimensions. In particular, recalling that a $k$-arc is complete if it is not contained in a $(k+1)$-arc, many authors focused their attention to the study of complete $k$-arcs and on some upper and lower bounds of their cardinality, obtaining interesting algebraic and geometric results, also in connection with some linear codes of special type. For a survey about all these results we refer, for instance, to [9] and the references therein.

In this note, we extend the concept of a $k$-arc along another direction. More precisely, we consider principally a generalized $k$-arc, that is, a set of $k$ points of $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$ such that no six of them lie on a $\mathbb{F}_{q}$-conic (or, simply, conic) of $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$. Let us observe here that the conics we consider in this definition could be also reducible in two lines. In particular, a generalized $k$-arc which is also a $k$-arc is known simply as a Veronesian $k$-arc. In line with the classical results about $k$-arcs, we start to study here some geometric properties of generalized $k$-arcs for small values of $q$ (see, e.g., Table 1) and we give some upper and lower bounds about the cardinality of complete generalized and Veronesian $k$-arcs for sufficiently bigger values of $q$ (see, e.g., Theorems 1, 2, 3).

The paper is organized as follows. After some basic notions and remarks in Section 1, we study in Section 2 the cardinality and the geometry of maximal complete generalized $k$-arcs in $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$ for $q \leq 9$ (Table 1). Subsequently, for higher values of $q$, we show some upper bounds for generalized $k$-arcs, depending on the parity of $q$ (Theorem 1 and

[^0]Corollary 1). In Section 3, we prove another lower bound for complete $k$-arcs in $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$ (Proposition 6) and we give principally a lower bound for complete generalized $k$-arcs $\mathcal{K}_{g}$, depending on the fact that $\mathcal{K}_{g}$ is complete as a Veronesian $k$-arc, or not (Theorems 2 and 3). Finally, in the Appendix, we report the main Magma [3] programs used to build all the tables and the corresponding examples.

## 1. Basic definitions and background material

First of all, let us recall here some basic classical definitions. A $(k, m)_{n}$-arc is a set of $k$ points of $\mathbb{P}^{n}\left(\mathbb{F}_{q}\right)$ such that no $m+1$ of them lie on a hyperplane. A $(k, m)_{n}$-arc is complete if it is not properly contained in a $(h, m)_{n}$-arc, for some $h>k$. In particular, a $(k, 2)_{2}$-arc is simply a $k$-arc in $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$ (see, e.g., [13], [14], [6]). Moreover, the size of the largest complete $k$-arc in $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$ will be denoted by $m(2, q)$, the size of the second largest complete $k$-arc in $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$ by $m^{\prime}(2, q)$, and the size of the smallest one by $t(2, q)$.

Now, let us introduce here the two main definitions of this note.
Definition 1. A generalized $k$-arc (or, simply, a $k_{g}$-arc) is a set of $k$ points of $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$ such that not six of them are on a (possibly reducible) conic. A $k_{g}$-arc is said to be complete if it is not contained in a $(k+1)_{g}$-arc. Moreover, the size of the largest complete $k_{g}$-arc is denoted by $m_{g}(2, q)$, while the size of the smallest one will be denoted by $t_{g}(2, q)$. Finally, a generalized $k$-arc is said to be maximal if $k=m_{g}(2, q)$ and minimal if $k=t_{g}(2, q)$.
Definition 2. A Veronesian $k$-arc (or, simply, a $k_{v}$-arc) is a $k$-arc in $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$ such that not six of its points lie on a (necessarily irreducible) conic. A $k_{v}$-arc is said to be complete if it is not contained in a $(k+1)_{v}$-arc. Moreover, the size of the largest complete $k_{v}$-arc is denoted by $m_{v}(2, q)$, while the size of the smallest one will be denoted by $t_{v}(2, q)$. Finally, a generalized $k$-arc is said to be maximal if $k=m_{v}(2, q)$ and minimal if $k=t_{v}(2, q)$.

Remark 1. From Definitions 1 and 2, one can deduce that a $k_{g}$-arc is at most a $(k, 3)_{2}$-arc and that a Veronesian $k$-arc is a $k_{g}$-arc with the additional property of being a $(k, 2)_{2}$-arc. Moreover, since a Veronesian arc is a special case of a generalized arc, we have

$$
t_{v}(2, q) \leq t_{g}(2, q) \quad \text { and } \quad m_{v}(2, q) \leq m_{g}(2, q)
$$

Denote by $|W|$ the cardinality of a set $W \subseteq \mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$. The following simple technical result will be useful in the sequel.

Lemma 1. Let $\mathcal{K}_{g} \subseteq \mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$ be a generalized $k$-arc. If $l_{1}$ is a line in $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$ such that $\left|\mathcal{K}_{g} \cap l_{1}\right|=3$, then for every line $l$ in $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$ we have

$$
\left|\left(\mathcal{K}_{g} \backslash l_{1}\right) \cap l\right| \leq 2
$$

i.e. $\left(\mathcal{K}_{g} \backslash l_{1}\right)$ is a (Veronesian) $k$-arc in $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$. In particular, a generalized $k$-arc is at most the disjoint union of a (Veronesian) ( $k-3$ )-arc and 3 collinear points.

Proof. By Remark 1, we have $\left|\mathcal{K}_{g} \cap l\right| \leq 3$ for every line $l$ in $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$. By contradiction, suppose there exists a line $l_{2}$ in $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$ such that $\left|\left(\mathcal{K}_{g} \backslash l_{1}\right) \cap l_{2}\right|=3$. Then, we get $\left(l_{1} \cap \mathcal{K}_{g}\right) \cap\left(l_{2} \cap \mathcal{K}_{g}\right)=\varnothing$. Hence, the conic $\Gamma:=l_{1} \cup l_{2}$ is such that $\left|\mathcal{K}_{g} \cap \Gamma\right|=6$, but this is impossible because $\mathcal{K}_{g}$ is a generalized $k$-arc.

## 2. Some upper bounds for $m_{g}(2, q)$

Before to study the geometry of generalized $k$-arcs for small values of $q$ and some upper bounds for $m_{g}(2, q)$ when $q$ is sufficiently large, let us give here the following result.

Proposition 1. We have

$$
m_{g}(2, q) \leq m(5, q)
$$

for any $q \geq 2$, where $m(5, q)$ is the largest size of $a(k, 5)_{5}$-arc.
Proof. Consider the Veronese embedding

$$
\begin{align*}
\nu_{2}: \mathbb{P}^{2}\left(\mathbb{F}_{q}\right) & \longrightarrow \mathbb{P}^{5}\left(\mathbb{F}_{q}\right)  \tag{1}\\
{\left[x_{0}: x_{1}: x_{2}\right] } & \longmapsto\left[x_{0}^{2}: x_{0} x_{1}: x_{0} x_{2}: x_{1}^{2}: x_{1} x_{2}: x_{2}^{2}\right]
\end{align*}
$$

Define $S:=\nu_{2}\left(\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)\right) \subset \mathbb{P}^{5}\left(\mathbb{F}_{q}\right)$ and denote by $\left[z_{0}: z_{1}: z_{2}: z_{3}: z_{4}: z_{5}\right]$ the general point of $\mathbb{P}^{5}\left(\mathbb{F}_{q}\right)$. If $H$ is a hyperplane $\sum_{i=0}^{5} \alpha_{i} z_{i}=0$ in $\mathbb{P}^{5}\left(\mathbb{F}_{q}\right)$, with $\alpha_{i} \in \mathbb{F}_{q}$, then $\nu_{2}^{-1}(H \cap S)$ is a conic in $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$. If $\mathcal{K}_{g}$ is a generalized $k$-arc, then $\left|\nu_{2}\left(\mathcal{K}_{g}\right) \cap H\right| \leq 5$. Therefore, the set $\nu_{2}\left(\mathcal{K}_{g}\right)$ is a $(k, 5)_{5}$-arc and then $m_{g}(2, q) \leq m(5, q)$.

First of all, let us compute the exact values of $m_{g}(2, q)$ for small $q$ 's, that is, for $q=2,3,4,5,7$ and 8 .

Proposition 2. $m_{g}(2,2)=7(c f$. Table 1).
Proof. Note that any conic in $\mathbb{P}^{2}\left(\mathbb{F}_{2}\right)$ has at most 5 points. So, any subset of $\mathbb{P}^{2}\left(\mathbb{F}_{2}\right)$ is a generalized arc. Therefore, $m_{g}(2,2)=\left|\mathbb{P}^{2}\left(\mathbb{F}_{2}\right)\right|=7$.

Example 1. Let $q=3$ and let $\mathcal{K}=\left\{p_{1}, p_{2}, p_{3}, p_{4}\right\}$ be a complete 4 -arc in $\mathbb{P}^{2}\left(\mathbb{F}_{3}\right)$. Denote by $l_{i j}$ the line passing through the distinct points $p_{i}$ and $p_{j}$. Let $q_{1}$ be the intersection of $l_{12}$ and $l_{34}$, and let $q_{2}$ be the intersection of $l_{13}$ and $l_{24}$. Consider the point $q_{3}$ obtained by intersecting the line passing through $q_{1}$ and $q_{2}$ with $l_{14}$. So, by construction, the set $\mathcal{K}_{g}=\left\{p_{1}, p_{2}, p_{3}, p_{4}, q_{1}, q_{2}, q_{3}\right\}$ is a generalized 7 -arc. For instance, consider the set $\mathcal{K}_{g}$ given by the following seven points (see Figure 1):

- $[0: 1: 2]$
- $[1: 1: 2]$
- $[1: 2: 0]$
- $[0: 1: 0]$
- $[1: 1: 1]$
- $[1: 0: 1]$
- $[1: 1: 0]$


Figure 1. A maximal generalized 7 -arc in $\mathbb{P}^{2}\left(\mathbb{F}_{3}\right)$.

Proposition 3. $m_{g}(2,3)=7$ (see Figure 1; cf. Table 1).
Proof. Note that any irreducible conic in $\mathbb{P}^{2}\left(\mathbb{F}_{3}\right)$ has four points. Hence, by Lemma 1 we deduce that $m_{g}(2,3) \leq m(2,3)+3=7$ and we can conclude by Example 1 .

Consider now, from a combinatorial and geometric point of view, the more intricate cases $q=4,5$. For $q=4$, we have the following result.

Proposition 4. $m_{g}(2,4)=7(c f$. Table 1).
Proof. First of all, we prove a lower bound for $m_{g}(2,4)$.
Claim. $m_{g}(2,4) \geq 7$.
Since $q=4$, consider a complete 6 -arc $\mathcal{K} \subset \mathbb{P}^{2}\left(\mathbb{F}_{4}\right)$, i.e. a conic and its nucleus (that is, the unique intersection point of the $q+1$ tangent $\mathbb{F}_{q}$-lines to an irreducible conic in $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$ with $q$ even [6, p. 143]). Let $p \notin \mathcal{K}$ and write $\mathcal{K}_{g}:=\mathcal{K} \cup\{p\}$. Suppose that $\mathcal{K}_{g}$ is not a generalized 7 -arc. As any irreducible conic has five points, it follows that there exist two lines $l_{1}$ and $l_{2}$ such that $\left(l_{1} \cap \mathcal{K}_{g}\right) \cap\left(l_{2} \cap \mathcal{K}_{g}\right)=\varnothing$ and $\left|\mathcal{K}_{g} \cap l_{i}\right|=3$, for $i=1,2$. Since $|\mathcal{K}|=6$, after renaming, we can assume that $p \in l_{1} \backslash l_{2}$. Hence $\left|\mathcal{K} \cap l_{2}\right|=3$, but this is a contradiction because $\mathcal{K}$ is a 6 -arc. Thus, $\mathcal{K}_{g}$ is a generalized 7 -arc and $m_{g}(2,4) \geq 7$.
Q.E.D.

By the Claim, we know that there exists a generalized 7 -arc in $\mathbb{P}^{2}\left(\mathbb{F}_{4}\right)$. Now, assume that there exists a generalized 8 -arc $\mathcal{K}_{g} \subset \mathbb{P}^{2}\left(\mathbb{F}_{4}\right)$. Note that $\mathcal{K}_{g}$ cannot be a 8 -arc because otherwise we would have $\left|\mathcal{K}_{g}\right| \leq q+2=6$ (see e.g. [6, Chapter 8]). Thus, there is a line $l \subset \mathbb{P}^{2}\left(\mathbb{F}_{4}\right)$ such that $\left|\mathcal{K}_{g} \cap l\right|=3$. By Lemma 1 , we know that $\mathcal{K}_{g} \backslash l=$ : $\mathcal{K}$ is a 5 -arc in $\mathbb{P}^{2}\left(\mathbb{F}_{4}\right)$. Write $\mathcal{K}_{g}:=\left\{p_{1}, \ldots, p_{8}\right\}$ and, after renaming, suppose that $p_{1}, \ldots, p_{5} \in \mathcal{K}$ and $p_{6}, p_{7}, p_{8} \in l$. Let $p$ be the nucleus of the irreducible conic $\gamma$ containing $\mathcal{K}$. Since $|\gamma|=|\mathcal{K}|=q+1=5$, note that $|\mathcal{K} \cap l|=0$, otherwise $l$ would contain four distinct points of $\mathcal{K}_{g}$ and taking any other secant line $l^{\prime}$ of $\mathcal{K}_{g}$ such that $\left(l \cap \mathcal{K}_{g}\right) \cap\left(l^{\prime} \cap \mathcal{K}_{g}\right)=\varnothing$, the reducible conic $l \cup l^{\prime}$ would have 6 points in common with $\mathcal{K}_{g}$, a contradiction because $\mathcal{K}_{g}$ is a generalized 8-arc. In particular, this shows that $p \notin l$ by definition of the nucleus $p$. Let $q_{1}$ and $q_{2}$ be the other two points of $l$ distinct from $p_{6}, p_{7}$ and $p_{8}$. Considering the pencil of $\mathbb{F}_{4}$-lines through $p$, after renaming, we can assume that the line $l_{16}:=\left\langle p_{1}, p\right\rangle$ is such that $p_{6} \in l_{16}$. Furthermore, considering the pencil of $\mathbb{F}_{4}$-lines through $p_{1}$, after renaming, we can suppose that there exist three lines $l_{1 i}:=\left\langle p_{1}, p_{i}\right\rangle$ through $p_{1}$ and $p_{i}$ for $i=2,4,5$ such that $q_{2} \in l_{12}, p_{7} \in l_{15}$ and $p_{8} \in l_{14}$. Now, note that $p_{6} \notin l_{12}$ and that the tangent line $l^{\prime}$ to $\gamma$ at $p_{2}$ cannot contain the point $p_{6}$ because $p \in l^{\prime}$ and $l_{16}=\left\langle p, p_{6}\right\rangle$. So, consider the pencil of $\mathbb{F}_{4}$-lines through $p_{2}$. Write $l_{2 j}:=\left\langle p_{2}, p_{j}\right\rangle$ for $j=3,4,5$. Since $p_{6} \notin l^{\prime} \cup l_{12}$, we see that there exists $j \in\{3,4,5\}$ such that $p_{6} \in l_{2 j}$. Thus one of the following three cases can occur: (a) $j=3,\left\{p_{2}, p_{3}, p_{6}\right\} \subset l_{23}$, (b) $j=4,\left\{p_{2}, p_{4}, p_{6}\right\} \subset l_{24}$, (c) $j=5,\left\{p_{2}, p_{5}, p_{6}\right\} \subset l_{25}$. In all these cases, having in mind that $\left\{p_{1}, p_{4}, p_{8}\right\} \subset l_{14}$ and $\left\{p_{1}, p_{5}, p_{7}\right\} \subset l_{15}$, we get a contradiction by taking the reducible conics $l_{23} \cup l_{14}, l_{24} \cup l_{15}, l_{25} \cup l_{14}$, respectively. This shows that actually $m_{g}(2,4)=7$.

Example 2. Let $\mathbb{F}_{4}=\{0,1, a, a+1\}$ be a field with four elements, where $a^{2}+a+1=0$. Considering in $\mathbb{P}^{2}\left(\mathbb{F}_{4}\right)$ the conic $x_{0}^{2}+x_{1} x_{2}=0$, its nucleus and the point $[1: 0: 1]$, from the Claim of Proposition 4 it follows that the set

$$
\mathcal{K}_{g}:=\{[1: 1: 1],[a: a+1: 1],[a+1: a: 1],[0: 0: 1],[0: 1: 0],[1: 0: 0],[1: 0: 1]\}
$$

is a maximal generalized 7 -arc in $\mathbb{P}^{2}\left(\mathbb{F}_{4}\right)(c f$. Table 1$)$.
Now, consider the case $q=5$.
Example 3. In $\mathbb{P}^{2}\left(\mathbb{F}_{5}\right)$, consider the following set

$$
\mathcal{K}^{\prime}:=\{[1: 0: 0],[0: 1: 0],[0: 0: 1],[1: 1: 1],[1: 0: 1],[1: 1: 0],[0: 1: 1]\} .
$$

By the Veronese embedding $\nu_{2}: \mathbb{P}^{2}\left(\mathbb{F}_{5}\right) \rightarrow \mathbb{P}^{5}\left(\mathbb{F}_{5}\right)$, we have

$$
\begin{aligned}
\nu_{2}\left(\mathcal{K}^{\prime}\right) & =\{[1: 0: 0: 0: 0: 0],[0: 1: 0: 0: 0: 0],[0: 0: 1: 0: 0: 0] \\
& {[1: 1: 1: 1: 1: 1],[1: 0: 1: 0: 1: 0],[1: 1: 0: 1: 0: 0],[0: 1: 1: 0: 0: 1]\}, }
\end{aligned}
$$

and using the homography given by the matrix

$$
\left(\begin{array}{llllll}
1 & 0 & 0 & 4 & 4 & 1 \\
0 & 1 & 0 & 4 & 0 & 0 \\
0 & 0 & 1 & 0 & 4 & 0 \\
0 & 0 & 0 & 0 & 0 & 1 \\
0 & 0 & 0 & 0 & 4 & 1 \\
0 & 0 & 0 & 4 & 0 & 1
\end{array}\right),
$$

we see that $\nu_{2}\left(\mathcal{K}^{\prime}\right)$ is projectively equivalent to the $(7,5)_{5}$-arc

$$
\mathcal{K}:=\{[1: 0: \cdots: 0],[0: 1: 0: \cdots: 0], \ldots,[0: \cdots: 0: 1],[1: 1: \cdots: 1]\} .
$$

So, $\mathcal{K}^{\prime}$ is a generalized 7 -arc in $\mathbb{P}^{2}\left(\mathbb{F}_{5}\right)$ (cf. Table 1$)$.

Proposition 5. $m_{g}(2,5)=7(c f$. Table 1).
Proof. By Proposition 1, we have $m_{g}(2,5) \leq m(5,5)=7$. Thus, we can conclude by Example 3.

For $q=7,8$, from Proposition 1 and [7, Theorem 3.17 (iv) and (xiii)], it follows that $m_{g}(2, q) \leq m(5, q)=q+1$. Using Program 1, we can see that in fact $m_{g}(2,7)=8$ and $m_{g}(2,8)=9$ (see Table 1). In general, this program could theoretically find the exact values of $m_{g}(2, q)$, but already for $q \geq 9$ the geometry of a generalized $k$-arc becomes much more intricate and, for this reason, we will give only some upper bounds for $m_{g}(2, q)$. On the other hand, when $q=9$, some geometric considerations, up to projectivities, together with slight modifications of Program 1 allowed us to obtain $m_{g}(2,9)=8$ and an example of a complete generalized 8-arc is given in Table 1.

For sufficiently big values of $q$, we obtain the following upper bounds for $m_{g}(2, q)$.
Theorem 1. We have

$$
m_{g}(2, q) \leq \begin{cases}\min \left\{m(5, q), m^{\prime}(2, q)+3, q-\frac{\sqrt{q}}{4}+\frac{19}{4}\right\} & \text { if } q \geq 7 \text { is odd } \\ \min \left\{m(5, q), q-\frac{\sqrt{q}}{2}+\frac{17}{4}\right\} & \text { if } q \geq 16 \text { is even }\end{cases}
$$

where $m(5, q)$ is the largest size of $a(k, 5)_{5}$-arc and $m^{\prime}(2, q)$ is the second largest size of a complete $(k, 2)_{2}$-arc.

Proof. First, suppose that $q \geq 7$ is odd. From [11, Theorem I], we know that a complete $k$-arc with $m(2, q)$ points is a conic. Thus, if a $k$-arc $\mathcal{K}$ has more than $m^{\prime}(2, q)$ points, then $\mathcal{K}$ can be extended to a conic $\Gamma$, so $\mathcal{K}$ must lie on $\Gamma$. By Lemma 1 , we can assume that a generalized $k$-arc is contained in the disjoint union of a $k$-arc and 3 collinear points. Since $m^{\prime}(2, q) \geq 6$ for any odd integer $q \geq 7$, we conclude that $m_{g}(2, q) \leq m^{\prime}(2, q)+3$. Assume now that one of the following conditions is satisfied:
(1) $q \geq 7$ is odd and there is a generalized $k$-arc $\mathcal{K}_{g}$ with $k>q-\frac{\sqrt{q}}{4}+\frac{19}{4}$;

TABLE 1. Maximal generalized $k$-arcs in $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$ for $q \leq 9$, where $\mathbb{F}_{q}^{*}=\langle\alpha\rangle$.
(2) $q \geq 16$ is even and there exists a generalized $k$-arc $\mathcal{K}_{g}$ with $k>q-\frac{\sqrt{q}}{2}+\frac{17}{4}$.

Consider the Veronese embedding $\nu_{2}: \mathbb{P}^{2}\left(\mathbb{F}_{q}\right) \longrightarrow \mathbb{P}^{5}\left(\mathbb{F}_{q}\right)$ defined as in (1). Note that the set $\nu_{2}\left(\mathcal{K}_{g}\right)$ is a $(k, 5)_{5}$-arc. By $\left[9\right.$, Theorems 4.10 and 4.11], $\nu_{2}\left(\mathcal{K}_{g}\right)$ lies on a unique normal rational curve $\Gamma$ of degree 5 in $\mathbb{P}^{5}\left(\mathbb{F}_{q}\right)$. Moreover, $\nu_{2}\left(\mathcal{K}_{g}\right) \subseteq \nu_{2}\left(\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)\right)=: S$, where $S$ is the Veronese surface. Since $S$ is defined by quadrics (see [5, Example 2.7]), we see that $\Gamma \nsubseteq S$. Furthermore, there exists a quadric $\mathbb{Q}^{4} \subset \mathbb{P}^{5}\left(\mathbb{F}_{q}\right)$ such that $S \subset \mathbb{Q}^{4}$ and $\Gamma \not \subset \mathbb{Q}^{4}$. So, we get

$$
|\Gamma \cap S| \leq\left|\Gamma \cap \mathbb{Q}^{4}\right| \leq \operatorname{deg}(\Gamma) \cdot \operatorname{deg}\left(\mathbb{Q}^{4}\right)=10
$$

where the last inequality is due to the Bézout's Theorem [10, Theomem 25.1]. This implies that $k=\left|\nu_{2}\left(\mathcal{K}_{g}\right)\right|=\left|\nu_{2}\left(\mathcal{K}_{g}\right) \cap \Gamma \cap S\right| \leq|\Gamma \cap S| \leq 10$, but this gives a numerical contradiction in both cases (1) and (2). We conclude by Proposition 1.

Remark 2. For $q=2^{h}$ and $h \geq 4$, there exist irregular hyperovals, that is, $m(2, q)$-arcs in $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$ which are not the union of a conic and its nucleus. For this reason, in these cases we cannot use the same argument as in the first part of the proof of Theorem 1.

Remark 3. From [9, §4.5.2] we know that

$$
m^{\prime}(2, q) \leq\left\{\begin{array}{lll}
q-1 & q \geq 7 & \text { Segre 1955, Tallini 1957 [12] } \\
q-\frac{1}{4} \sqrt{q}+\frac{25}{16} & q \text { odd } & \text { Thas 1987[15] } \\
\frac{44}{45} q+\frac{8}{9} & q \text { prime } & \text { Voloch 1990[16] } \\
q-\frac{1}{2} \sqrt{q}+5 & q=p^{h}, p \geq 5 & \text { Hirschfeld-Korchmáros 1996[8] }
\end{array}\right.
$$

Remark 4. For $q \geq 8$ even we have $m(5, q)=q+1$, while for $q \geq 7$ odd we know that $m(5, q)=q+1$, except possibly for $23 \leq q \leq 83$, Hirschfeld 1997 [7].

The next result can be easily obtained by comparing directly Theorem 1 and the results recalled in Remarks 3 and 4.

Corollary 1. Let $q \geq 16$ even. Then

$$
m_{g}(2, q) \leq \begin{cases}q+1 & q=16,32 \\ \left\lfloor q-\frac{\sqrt{q}}{2}+\frac{17}{4}\right\rfloor & q \geq 64\end{cases}
$$

Let $q \geq 7$ odd. Then we have one of the following cases:

- for q prime,

$$
m_{g}(2, q) \leq \begin{cases}q+1 & 7 \leq q \leq 19 \\ q+2 & 23 \leq q \leq 83 \\ \left\lfloor\frac{44}{45} q+\frac{8}{9}\right\rfloor+3 & q \geq 89\end{cases}
$$

- for $q=p^{s}$, with $p$ prime greater than or equal to 5 and $s \geq 2$ :

$$
m_{g}(2, q) \leq \begin{cases}q+2 & q \in\{25,49\} \\ q+1 & q \in\{121,125\} \\ \left\lfloor q-\frac{\sqrt{q}}{2}+5\right\rfloor+3 & q \geq 169\end{cases}
$$

- for $q=3^{s}$ and $s \geq 2$ :

$$
m_{g}(2, q) \leq \begin{cases}10 & q=9 \\ q+2 & q \in\{27,81\} \\ \left\lfloor q-\frac{\sqrt{q}}{4}+\frac{25}{16}\right\rfloor+3 & q \geq 243\end{cases}
$$

## 3. SOME LOWER BOUNDS FOR $t(2, q), t_{v}(2, q)$ AND $t_{g}(2, q)$

Recall that the size of a smallest complete $k$-arc in $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$ is denoted by $t(2, q)$. In [1], S. Ball showed that

$$
t(2, q) \geq \begin{cases}\lfloor\sqrt{2 q}+2\rfloor & \text { for any } q  \tag{*}\\ \left\lceil\sqrt{3 q}+\frac{1}{2}\right\rceil & \text { for } q=p^{h}, p \text { prime, } h=1,2 .\end{cases}
$$

In [2], the authors realized a more detailed work on lower bounds when $q \leq 7559$ and they proved that $t(2, q) \leq\lfloor 3 \sqrt{q}\rfloor$ for $q \leq 89$.

First of all, let us give here a lower bound for $t(2, q)$ which slightly improves $\lfloor\sqrt{2 q}+2\rfloor$ only for some values of $q$ (see the below Remark 5).
Proposition 6. $t(2, q) \geq\left\lceil\sqrt{\left(2 q+\frac{1}{4}\right)}+\frac{3}{2}\right\rceil$ for any $q \geq 2$.
Proof. Assume that a set of $k$ points $\left\{p_{1}, p_{2}, \ldots, p_{k}\right\}$ is a complete $k$-arc. Denote by $l_{i j}$ the unique $\mathbb{F}_{q}$-line passing through $p_{i}$ and $p_{j}$, where $i \neq j$ and $i, j \in\{1, \ldots, k\}$. Write

$$
\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)=\bigcup_{1 \leq i<j \leq k} l_{i j}=\left(\bigcup_{h=1}^{k-1} l_{h k}\right) \cup\left(\bigcup_{1 \leq i<j \leq k-1} l_{i j} \backslash\left(\cup_{h=1}^{k-1} l_{h k}\right)\right) .
$$

Then we deduce that

$$
\begin{gathered}
q^{2}+q+1=\left|\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)\right| \leq\left|\cup_{h=1}^{k-1} l_{h k}\right|+\sum_{1 \leq i<j \leq k-1}\left|l_{i j} \backslash\left(\cup_{h=1}^{k-1} l_{h k}\right)\right|= \\
=[(k-1) q+1]+\sum_{1 \leq i<j \leq k-1}[q+1-(k-1)]=(k-1) q+1+\binom{k-1}{2}(q+2-k),
\end{gathered}
$$

i.e. $q^{2}+q+1-[(k-1) q+1]-\binom{k-1}{2}(q+2-k) \leq 0$. Hence we get

$$
(q+2-k) \cdot\left[q-\binom{k-1}{2}\right] \leq 0
$$

that is,

$$
[k-(q+2)] \cdot\left[k-\left(\frac{3}{2}-\sqrt{2 q+\frac{1}{4}}\right)\right] \cdot\left[k-\left(\frac{3}{2}+\sqrt{2 q+\frac{1}{4}}\right)\right] \leq 0 .
$$

This leads to the solution $\frac{3}{2}+\sqrt{2 q+\frac{1}{4}} \leq k \leq q+2$ which shows that the inequality of the statement holds for any $q \geq 2$.

In Tables 2 and 3, we make a comparison between $\left(^{*}\right)$ and the lower bound of Proposition 6 when $q \leq 31$. Furthermore, in Table 2 we give also some examples which reach the best known lower bound $t(2, q)$ for a $k$-arc when $q \leq 11$.
Remark 5. As shown in Table 2, the lower bound $\left\lceil\sqrt{\left(2 q+\frac{1}{4}\right)}+\frac{3}{2}\right\rceil$ is better than $\lfloor\sqrt{2 q}+2\rfloor$ for $q=4,7,11$ and it is sharp for $q=2,3,7,8,9,11$. More generally, we have

$$
\left\lceil\sqrt{\left(2 q+\frac{1}{4}\right)}+\frac{3}{2}\right\rceil=\lfloor\sqrt{2 q}+2\rfloor+1>\lfloor\sqrt{2 q}+2\rfloor
$$

for any $q$ such that $\frac{(h-2)(h-1)}{2}<q<\frac{(h-1)^{2}}{2}$ for some suitable integer $h \geq 4$. Moreover, the lower bound of Proposition 6 is also better than that obtained in [4, Lemma 2.5] for $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$.

Coming back to generalized $k$-arcs, let us note also that if $\mathcal{K}$ is a subset of $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$, then $(\diamond) \quad \mathcal{K}$ is a Veronesian $k$-arc $\Longleftrightarrow \mathcal{K}$ is a generalized $k$-arc such that all the conics passing through any 5 of its points are irreducible.

If $q=2$, then we have $t_{g}(2,2)=m_{g}(2,2)=7$ and $t_{v}(2,2)=t(2,2)=4$, because any conic has at most 5 points.

Let $q=3$. Using Programs 1 and 2 , we obtain that $t_{g}(2,3)=m_{g}(2,3)=7$ and $t_{v}(2,3)=t(2,3)=4$, where a minimal complete Veronesian 4 -arc is given by $\{[1: 1: 1],[0: 0: 1],[0: 1: 0],[1: 0: 0]\}$.

Now, let $q=4$ and consider a minimal generalized $k$-arc $\mathcal{K}_{g} \subset \mathbb{P}^{2}\left(\mathbb{F}_{4}\right)$. Since $\mathcal{K}_{g}$ is the smallest complete generalized $k$-arc and any irreducible conic in $\mathbb{P}^{2}\left(\mathbb{F}_{4}\right)$ has $q+1=5$ points, we deduce that $\mathcal{K}_{g}$ is not a $k$-arc. Therefore there are three collinear points in $\mathcal{K}_{g}$, say $p_{1}, p_{2}, p_{3}$. Let $L$ be the line through these three points. Since $\mathcal{K}_{g}$ is a complete generalized $k$-arc, we deduce that any point $p \notin \mathcal{K}_{g}$ is contained in a reducible conic of type $L \cup l$, where $l$ is a secant line of $\mathcal{K}_{g} \backslash\left\{p_{1}, p_{2}, p_{3}\right\}$. This implies that

$$
2+2\binom{k-3}{2}+k \geq q^{2}+q+1=21
$$

Hence $k \geq 7$ and since $k \leq m_{g}(2,4)=7$ by Proposition 4, we conclude that $t_{g}(2,4)=$ $m_{g}(2,4)=7$. By Program 1, we obtain that a minimal generalized 7 -arc is given by

$$
\left\{[1: 0: 0],[0: 1: 0],[0: 0: 1],[1: 1: 1],\left[\alpha: \alpha^{2}: 1\right],\left[\alpha^{2}: \alpha: 1\right],[1: 0: 1]\right\},
$$

where $\mathbb{F}_{4}^{*}=\langle\alpha\rangle$. Moreover, by Program 2, one can see that $t_{v}(2,4)=t(2,4)=6$ and a minimal complete Veronesian 6 -arc is given by

$$
\left\{[1: 1: 1],[0: 0: 1],[0: 1: 0],[1: 0: 0],\left[\alpha: \alpha^{2}: 1\right],\left[\alpha^{2}: \alpha: 1\right]\right\} .
$$

For $q \geq 5$, as to $t_{v}(2, q)$, we get the following lower bound.
Theorem 2. For $q \geq 5$, we have $t_{v}(2, q) \geq\left\lceil t_{0}\right\rceil$, where $t_{0}$ is the smallest real positive solution of the following inequality:

$$
\binom{t_{0}}{5}(q-4)+\binom{t_{0}}{2}(q-1)+t_{0} \geq q^{2}+q+1 .
$$

Proof. Let $\mathcal{K}_{v} \subseteq \mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$ be a complete Veronesian $k$-arc. Since any irreducible conic of $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$ has $q+1$ points, from $(\diamond)$ we deduce that the maximal number of points covered by conics passing through 5 of $k$ points of $\mathcal{K}_{v}$ is given by

$$
\binom{k}{5}(q+1-5)+k=\binom{k}{5}(q-4)+k .
$$

Moreover, the maximal number of points covered by lines passing through 2 of $k$ points of $\mathcal{K}_{v}$ is

$$
\binom{k}{2}(q+1-2)+k=\binom{k}{2}(q-1)+k .
$$

Since the $k$ points of $\mathcal{K}_{v}$ are common to all the above conics and lines, to cover the projective plane we get the following inequality

$$
\binom{k}{5}(q-4)+\binom{k}{2}(q-1)+k \geq q^{2}+q+1
$$

Remark 6. In Table 4, we compare the values of $t(2, q)$ for complete $k$-arcs with the values of $t_{v}(2, q)$ obtained by Program 2 and the lower bounds $\left\lceil t_{0}\right\rceil$ of Theorem 2 for complete Veronesian $k$-arcs. We would like to stress the fact that a Veronesian $k$-arc is a particular case of a generalized $k$-arc and that if a set is complete as a Veronesian $k$-arc, could be not complete as a generalized $k$-arc. Furthermore, by using Program 2, we found examples which show that the lower bound $\left\lceil t_{0}\right\rceil$ is sharp for $q=5,8,9,11$.

In a similar way as in the proof of Theorem 2, we get the following result.
Theorem 3. Let $\mathcal{K}_{g} \subseteq \mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$ be a generalized $k$-arc with $q \geq 5$. If $\mathcal{K}_{g}$ is complete as a generalized arc, then

$$
k \geq \begin{cases}\left\lceil t_{1}\right\rceil & \text { if } \mathcal{K}_{g} \text { is also a } k \text {-arc } \\ \left\lceil t_{2}\right\rceil & \text { if } \mathcal{K}_{g} \text { is not a } k \text {-arc }\end{cases}
$$

where $t_{1}$ and $t_{2}$ are the minimum real positive solutions of the following inequalities:

$$
\begin{gathered}
\binom{t_{1}}{5}(q-4)+t_{1} \geq q^{2}+q+1, \quad \text { and } \\
\binom{t_{2}-3}{5}(q-4)+\binom{t_{2}-2}{4}(6 q-12)+\binom{t_{2}-3}{2}(q-2)+t_{2} \geq q^{2}+3
\end{gathered}
$$

In particular, we have $t_{g}(2, q) \geq \min \left\{\left\lceil t_{1}\right\rceil,\left\lceil t_{2}\right\rceil\right\}$.
Proof. Let $\mathcal{K}_{g} \subseteq \mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$ be a complete generalized $k$-arc. If $\mathcal{K}_{g}$ is also a $k$-arc, then $\mathcal{K}_{g}$ is a Veronesian $k$-arc complete by (irreducible) conics. Thus, in this situation, by arguing in a similar way as in Theorem 2, we get $k \geq\left\lceil t_{1}\right\rceil$, where $\binom{t_{1}}{5}(q-4)+t_{1} \geq q^{2}+q+1$.

Suppose now that $\mathcal{K}_{g}$ is not a $k$-arc. From Lemma 1 it follows that we can write $\mathcal{K}_{g}=\mathcal{K} \cup \mathcal{P}$, where $\mathcal{K}$ is a (Veronesian) $(k-3)$-arc and $\mathcal{P}$ are 3 distinct collinear points. The conics $\gamma_{0}$ passing through any 5 distinct points of $\mathcal{K}$ are irreducible because $\mathcal{K}$ is a $(k-3)$-arc and they cover at most

$$
\begin{equation*}
\binom{3}{0}\binom{k-3}{5}(q+1-5)+k \tag{2}
\end{equation*}
$$

points of the projective plane. On the other hand, the conics $\gamma_{1}$ passing through any 4 distinct points of $\mathcal{K}$ and one point of $\mathcal{P}$, can be either reducible or irreducible. Since
the reducible conics cover $2 q+1>q+1$ points of the plane, we can assume that all the $\gamma_{1}$ 's are reducible. Thus they cover at most

$$
\begin{equation*}
\binom{3}{1}\binom{k-3}{4}(2 q+1-5)+k \tag{3}
\end{equation*}
$$

points of the plane. Similarly, the conics $\gamma_{2}$ passing through any 3 distinct points of $\mathcal{K}$ and 2 distinct points of $\mathcal{P}$, can be either reducible or irreducible. As in the previous case, we can assume that all the $\gamma_{2}$ 's are reducible conics. Therefore, they cover at most

$$
\begin{equation*}
\binom{3}{2}\binom{k-3}{3}(2 q+1-5)+k \tag{4}
\end{equation*}
$$

points of $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$. Finally, the conics $\gamma_{3}$ passing through any 2 distinct points of $\mathcal{K}$ and the 3 points of $\mathcal{P}$ are all reducible and they cover at most

$$
\begin{equation*}
\binom{3}{3}\binom{k-3}{2}(q+1-3)+(q+1-3)+k \tag{5}
\end{equation*}
$$

points of the projective plane. Since the $k$ points of $\mathcal{K}_{g}$ are common to all the above conics $\gamma_{i}$ for $i=0,1,2,3$, using the expressions from (2) to (5), we get

$$
S(k):=\binom{k-3}{5}(q-4)+\binom{k-2}{4}(6 q-12)+\left[\binom{k-3}{2}+1\right](q-2)+k
$$

which is greater than or equal to the number of points covered by the span of all the conics passing through any 5 distinct points of $\mathcal{K}_{g}$. So, if $t_{2}$ is the minimum real positive solution of $S\left(t_{2}\right) \geq q^{2}+q+1$, then we have $k \geq\left\lceil t_{2}\right\rceil$.

Remark 7. In Tables 5 and 6, we compare the two lower bounds of Theorem 3 for a generalized $k$-arc in $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$. Moreover, for $5 \leq q \leq 11$, in Table 5 we find the exact values of $t_{g}(2, q)$ by using Program 1, and we give their respective examples showing that the lower bound $\left\lceil t_{2}\right\rceil$ is sharp for $q=7,8,9,11$.

Finally, looking at the number of 3 -secant lines of a generalized $k$-arc, we can also obtain the following result.

Proposition 7. Let $\mathcal{K}_{g} \subseteq \mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$ be a complete generalized $k$-arc with $q \geq 5$. Let $T \in \mathbb{Z}_{\geq 0}$ be the number of distinct 3 -secant lines of $\mathcal{K}_{g}$. Then $k \geq\left\lceil t_{3}\right\rceil$, where $t_{3}$ is the minimum real positive solution of the following inequality

$$
\binom{t_{3}}{5}(q-4)+\frac{T}{2}\left[\left(t_{3}-3\right)\left(t_{3}-4\right)+1-T\right] q+t_{3} \geq q^{2}+q+1
$$

Proof. Write $\mathcal{K}_{g}:=\left\{p_{1}, \ldots, p_{k}\right\}$ and let $I:=\left\{(p, \gamma) \mid p \in \mathbb{P}^{2}\left(\mathbb{F}_{q}\right), \gamma \in \Gamma, p \in \gamma\right\}$, where $\Gamma$ is the set of all the conics in $\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)$ passing through any 5 distinct points of

$\mathcal{K}_{g}$. Since any reducible conic of $\Gamma$ contains at least a 3 -secant line, we deduce that the number of distinct reducible conics in $\Gamma$ is $\delta$ given by

$$
\delta:=\binom{T}{2}+T\left[\binom{k-3}{2}-(T-1)\right]
$$

while the number of distinct irreducible conics in $\Gamma$ is $\binom{k}{5}-\delta$, because $|\Gamma|=\binom{k}{5}$. So, the cardinality of $I$ is

$$
\left[\binom{k}{5}-\delta\right](q+1)+\delta(2 q+1)=\binom{k}{5}(q+1)+\delta q
$$

that is,

$$
|I|=\binom{k}{5}(q+1)+\left\{\binom{T}{2}+T\left[\binom{k-3}{2}-(T-1)\right]\right\} q .
$$

Now, observe that the number of distinct conics in $\Gamma$ passing through a fixed point $p_{j} \in \mathcal{K}_{g}$ is given by $\binom{k-1}{4}$. Note that $I$ can be written as a union $I_{1} \cup I_{2}$, where $I_{1}:=\left\{\left(p_{j}, \gamma\right) \in I \mid p_{j} \in \mathcal{K}_{g}\right\}$ and $I_{2}:=\left\{(q, \gamma) \in I \mid q \notin \mathcal{K}_{g}\right\}$. Since $\left|I_{1}\right|=k\binom{k-1}{4}$ and
$\left|\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)\right|-k \leq\left|I_{2}\right|$, we conclude that

$$
|I|-k\left[\binom{k-1}{4}-1\right] \geq\left|\mathbb{P}^{2}\left(\mathbb{F}_{q}\right)\right|
$$

i.e. $|I|-5\binom{k}{5}+k \geq q^{2}+q+1$, which leads to the inequality of the statement.
