# THE NEUMANN PROBLEM FOR PARABOLIC HESSIAN QUOTIENT EQUATIONS

#### Abstract

In this paper, we consider the Neumann problem for parabolic Hessian quotient equations. We show that the $k$-admissible solution of the parabolic Hessian quotient equation exists for all time and converges to the smooth solution of elliptic Hessian quotient equations. Also the solutions of the classical Neumann problem converge to a translating solution.


Key words: parabolic Hessian quotient equation, Neumann problem, translating solution. 2010 Mathematics Subject Classification: 35J60, 35B45.

## 1. Introduction

In this paper, we consider the Neumann problem for parabolic Hessian quotient equation, which is of the form

\begin{cases}u_{t}=\log \frac{\sigma_{k}\left(D^{2} u\right)}{\sigma_{l}\left(D^{2} u\right)}-\log f(x, u) & \text { in } \quad \Omega \times[0, T)  \tag{1.1}\\ u_{\nu}=\varphi(x, u) & \text { on } \partial \Omega \times[0, T) \\ u(x, 0)=u_{0} & \text { in } \Omega\end{cases}
$$

where $0 \leq l<k \leq n, \nu$ is outer unit normal vector of $\partial \Omega, T$ is the maximal time, and $\Omega \subset \mathbb{R}^{n}$, $n \geq 2$ is a strictly convex bounded domain with smooth boundary. For any $k=1, \cdots, n$,

\sigma_{k}\left(D^{2} u\right)=\sigma_{k}\left(\lambda\left(D^{2} u\right)\right)=\sum_{1 \leq i_{1}<i_{2}<\cdots<i_{k} \leq n} \lambda_{i_{1}} \lambda_{i_{2}} \cdots \lambda_{i_{k}}
$$

with $\lambda\left(D^{2} u\right)=\left(\lambda_{1}, \cdots, \lambda_{n}\right)$ being the eigenvalues of $D^{2} u=:\left\{\frac{\partial^{2} u}{\partial x_{i} \partial x_{j}}\right\}$. We also set $\sigma_{0}=1$ for convenience. And we recall that the Gårding's cone is defined as

\Gamma_{k}=\left\{\lambda \in \mathbb{R}^{n}: \sigma_{i}(\lambda)>0, \forall 1 \leq i \leq k\right\}
$$

For any $C^{2}$ function $u(x, t)$ (or $u(x)$ ), if $\lambda\left(D^{2} u\right) \in \Gamma_{k}$ holds for any $(x, t) \in \Omega \times(0, T)$ (or $x \in \Omega$ ), we say $u$ is a $k$-convex function. If the solution $u(x, t)$ of (1.1) is $k$-convex, then the equation (1.1) is parabolic and we say $u$ is a $k$-admissible solution of (1.1).

If $l=0$, (1.1) is known as the parabolic $k$-Hessian equation. In particular, (1.1) is the parabolic Laplace equation if $k=1, l=0$, and the parabolic Monge-Ampère equation if $k=n, l=0$. Hessian quotient equation is a more general form of Hessian type equations. It appears naturally in classical geometry, conformal geometry and Kähler geometry.

Firstly, we present a brief description for the Dirichlet problem of elliptic equations in $\mathbb{R}^{n}$. The Dirichlet problem for the Laplace equation is well studied in [10, 15]. For nonlinear elliptic

[^0]equations, the pioneering works have been done by Evans in 14, Krylov in [26, 27, 28, Caffarelli-Nirenberg-Spruck in [2, 3] and Ivochkina in [22]. In their papers, they solved the Dirichlet problem for Monge-Ampère equations and $k$-Hessian equations elegantly. Since then, many interesting fully nonlinear equations with different structure conditions have been researched, such as Hessian quotient equations, which were solved by Trudinger in 48. For more information, we refer the citations of [2], etc.

For the curvature equations in classical geometry, the existence of hypersurfaces with prescribed Weingarten curvature was studied by Pogorelov [40], Caffarelli-Nirenberg-Spruck [4, 5], GuanGuan [18], Guan-Ma [19] and the later work by Sheng-Trudinger-Wang 42. The Hessian equation on Riemannian manifolds was also studied by Y.Y. Li [29], Urbas 51 and Guan [17. Hessian type equations also appear in conformal geometry, which started from Viaclovsky [53], Chang-Gursky-Yang 6. In Kähler geometry, the Hessian equation was studied by Hou-Ma-Wu 20 and Dinew-Kolodziej 12 .

Meanwhile, the Neumann and oblique derivative problem of partial differential equations were widely studied. For a priori estimates and the existence theorem of Laplace equation with Neumann boundary condition, we refer to the book [15. Also, we recommend the recent book written by Lieberman 33 for the Neumann and the oblique derivative problems of linear and quasilinear elliptic equations. Especially for the mean curvature equation with prescribed contact angle boundary value problem, Ural'tseva [52], Simon-Spruck [43] and Gerhardt [16] got the boundary gradient estimates and the corresponding existence theorem. Recently in [39], the second author and J.J. Xu got the boundary gradient estimates and the corresponding existence theorem for the Neumann boundary value problem on mean curvature equation.

The Yamabe problem with boundary is an important motivation for the study of the Neumann problems. The Yamabe problem on manifolds with boundary was first studied by Escobar, who shows in [13] that (almost) every compact Riemannian manifold $(M, g)$ is conformally equivalent to one of constant scalar curvature, whose boundary is minimal. The problem reduces to solving the semilinear elliptic critical Sobolev exponent equation with the Neumann boundary condition. It is naturally, the Neumann boundary value problem for Hessian type equations also appears in the fully nonlinear Yamabe problem for manifolds with boundary, which is to find a conformal metric such that the $k$-th elementary symmetric function of eigenvalues of Schouten tensor is constant and with the constant mean curvature on the boundary of manifold. See Jin-Li-Li [25], Chen 9] and Li-Luc [31, but in all these papers they need to impose the manifold are umbilic or total geodesic boundary for $k \geq 2$, which are more like the condition in Trudinger 47 that the domain is ball.

In 1986, Lions-Trudinger-Urbas solved the Neumann problem of Monge-Ampère equations in the celebrated paper [35]. For related results on the Neumann or oblique derivative problem for some class of fully nonlinear elliptic equations can be found in Urbas 49. Recently, the second author and G.H. Qiu [36] solved the the Neumann problem of $k$-Hessian equations, and then ChenZhang [8] generalized the above result to the the Neumann problem of Hessian quotient equations. Meanwhile, Jiang-Trudinger [23, 24] studied the general oblique boundary value problems for augmented Hessian equations with some regular condition and concavity condition. Motivated by the optimal transport Caffarelli [1] and Urbas [50] proved the existence of the Monge-Ampere equation with second boundary value problem, for the general convex cost function this second boundary value problem studied by Ma-Trudinger-Wang 37.

If $k=n, l=0$, (1.1) is the well known parabolic Monge-Ampère equation, which relates to the Gauss curvature flow if $f=f(x, u, D u)$. O.C. Schnürer-K. Smoczyk proved the long time existence of this Gauss curvature flow and showed that the flow converges to a solution of the prescribed Gauss curvature equation in [45].

Naturally, we want to know how about the Neumann problem of parabolic Hessian quotient equations. In this paper, we obtain two results. One is the long time existence and convergence of solutions of the Neumann problem of parabolic Hessian quotient equation. The other is that the solutions of the classical Neumann problem of parabolic Hessian quotient equation converge to the translating solution.

To state our main results, we first introduce the structural conditions on $\varphi, f$ and $u_{0}$. Firstly, we assume

and

These two conditions are similar as the Monge-Ampère case in 46. Here $u_{0}$ is always a smooth, $k$-convex function. Moreover, we will always assume either

\frac{f_{u}}{f} \geq c_{f}>0 \tag{1.4}
\end{equation*}

or

$$
\begin{equation*}
\frac{\sigma_{k}\left(D^{2} u_{0}\right)}{\sigma_{l}\left(D^{2} u_{0}\right)} \geq f\left(x, u_{0}\right) \tag{1.5}
\end{equation*}
$$

We also assume the following compatibility conditions

$$
\begin{equation*}
\left.\left(\frac{\partial}{\partial t}\right)^{j}\right|_{t=0}\left(u_{\nu}-\varphi(x, u)\right)=0, \quad \text { for any } \quad j \geq 0, \quad \text { on } \quad \partial \Omega \tag{1.6}
\end{equation*}
$$

Our first main theorem is
Theorem 1.1. Assume that $\Omega$ is a strictly convex bounded domain in $\mathbb{R}^{n}, n \geq 2$, with smooth boundary. Let $f, \varphi: \bar{\Omega} \times \mathbb{R} \rightarrow \mathbb{R}$, be smooth functions which satisfy (1.2) and (1.3). Suppose there is a smooth, $k$-convex function $u_{0}$ satisfying the compatibility conditions (1.6). We further assume that either (1.4) or (1.5) holds. Then there exists a smooth solution $u(x, t)$ of equation (1.1) for all $t \geq 0$. Moreover, $u(x, t)$ converges smoothly to a smooth function $u^{\infty}$ which is a solution of the Neumann problem for Hessian quotient equation

$$
\begin{cases}\frac{\sigma_{k}\left(D^{2} u^{\infty}\right)}{\sigma_{l}\left(D^{2} u^{\infty}\right)}=f\left(x, u^{\infty}\right), & \text { in } \quad \Omega \subset \mathbb{R}^{n}  \tag{1.7}\\ u_{\nu}^{\infty}(x)=\varphi\left(x, u^{\infty}\right), & \text { on } \partial \Omega\end{cases}
$$

where $\nu$ is outer unit normal vector of $\partial \Omega$. The rate of convergence is exponential provided (1.4) holds.

Next we consider the related translating solution of the classical Neumann problem for parabolic Hessian quotient equations. The Monge-Ampère equation case was proven by [46, and the mean curvature equation by 38.

Let $u_{0}$ be a smooth $k$-convex function. Assume that $u_{0} \in C^{\infty}(\bar{\Omega})$ and satisfies

\frac{\partial u_{0}(x)}{\partial \nu}=\varphi(x) \quad \text { on } \quad \partial \Omega \tag{1.8}
\end{equation*}
$$

Theorem 1.2. Let $\Omega$ is a strictly convex bounded domain in $\mathbb{R}^{n}$ with smooth boundary. Assume that $u_{0}$ and $\varphi$ are smooth functions satisfying (1.8), and $f$ is a positive smooth function, $f \in$
$C^{\infty}(\bar{\Omega})$. Then there exists a smooth $k$-admissible solution $u(x, t)$ of the following equation for all $t \geq 0$.

$$
\begin{cases}u_{t}=\log \frac{\sigma_{k}\left(D^{2} u\right)}{\sigma_{l}\left(D^{2} u\right)}-\log f(x), & (x, t) \in \Omega \times(0, T)  \tag{1.9}\\ u_{\nu}(x, t)=\varphi(x), & x \in \partial \Omega, t \in[0, T) \\ u(x, 0)=u_{0}(x), & x \in \Omega,\end{cases}
$$

where $u(\cdot, t)$ approaches $u_{0}$ in $C^{2}(\bar{\Omega})$ as $t \rightarrow 0$. Moreover, $u(\cdot, t)$ converges smoothly to a translating solution, i.e. to a solution with constant time derivative.

The rest of the paper is organized as follows. In Section 2, we collect some properties and inequalities of elementary symmetric functions. And we prove the uniform estimate for $\left|u_{t}\right|$ in Section 3. Then we use the uniform estimate of $\left|u_{t}\right|$ to obtain $C^{0}$-estimate of $u$ in Section 4. The $C^{1}$-estimate and the $C^{2}$ estimate are derived in Section 5 and Section 6, respectively. And then we prove Theorem 1.1 in Section 7. At last, we prove Theorem 1.2 in Section 8.

## 2. PRELIMINARY

In this section, we collect some properties and inequalities of elementary symmetric functions.
2.1. Basic properties of elementary symmetric functions. Let $\lambda=\left(\lambda_{1}, \ldots, \lambda_{n}\right) \in \mathbb{R}^{n}$ and $1 \leq k \leq n$.

$$
\sigma_{k}(\lambda)=\sum_{1 \leq i_{1}<i_{2}<\cdots<i_{k} \leq n} \lambda_{i_{1}} \lambda_{i_{2}} \cdots \lambda_{i_{k}}
$$

We denote by $\sigma_{k}(\lambda \mid i)$ the symmetric function with $\lambda_{i}=0$ and $\sigma_{k}(\lambda \mid i j)$ the symmetric function with $\lambda_{i}=\lambda_{j}=0$. It is easy to know the following equalities hold

$$
\begin{aligned}
& \sigma_{k}(\lambda)=\sigma_{k}(\lambda \mid i)+\lambda_{i} \sigma_{k-1}(\lambda \mid i), \quad \forall 1 \leq i \leq n \\
& \sum_{i} \lambda_{i} \sigma_{k-1}(\lambda \mid i)=k \sigma_{k}(\lambda) \\
& \sum_{i} \sigma_{k}(\lambda \mid i)=(n-k) \sigma_{k}(\lambda)
\end{aligned}
$$

We also denote by $\sigma_{k}(W \mid i)$ the symmetric function with $W$ deleting the $i$-row and $i$-column and $\sigma_{k}(W \mid i j)$ the symmetric function with $W$ deleting the $i, j$-rows and $i, j$-columns. Then we have the following identities.

Proposition 2.1. Suppose $W=\left(W_{i j}\right)$ is diagonal, and $m$ is a positive integer, then

\frac{\partial \sigma_{m}(W)}{\partial W_{i j}}= \begin{cases}\sigma_{m-1}(W \mid i), & \text { if } i=j \\ 0, & \text { if } i \neq j\end{cases}
$$

Recall that the Gårding's cone is defined as

$$
\begin{equation*}
\Gamma_{k}=\left\{\lambda \in \mathbb{R}^{n}: \sigma_{i}(\lambda)>0, \forall 1 \leq i \leq k\right\} \tag{2.1}
\end{equation*}
$$

Proposition 2.2. Let $\lambda \in \Gamma_{k}$ and $k \in\{1,2, \cdots, n\}$. Suppose that

$$
\lambda_{1} \geq \cdots \geq \lambda_{k} \geq \cdots \geq \lambda_{n}
$$

then we have

$$
\begin{align*}
& \sigma_{k-1}(\lambda \mid n) \geq \sigma_{k-1}(\lambda \mid n-1) \geq \cdots \geq \sigma_{k-1}(\lambda \mid k) \geq \cdots \geq \sigma_{k-1}(\lambda \mid 1)>0  \tag{2.2}\\
& \lambda_{1} \geq \cdots \geq \lambda_{k}>0, \quad \sigma_{k}(\lambda) \leq C_{n}^{k} \lambda_{1} \cdots \lambda_{k}  \tag{2.3}\\
& \lambda_{1} \sigma_{k-1}(\lambda \mid 1) \geq \frac{k}{n} \sigma_{k}(\lambda) \tag{2.4}
\end{align*}
$$

where $C_{n}^{k}=\frac{n!}{k!(n-k)!}$.
Proof. All the properties are well known. For example, see 32 or [21 for a proof of (2.2), 30] for (2.3), and [11] or [20] for (2.4).

Proposition 2.3. (Newton-MacLaurin inequality) For $\lambda \in \Gamma_{k}$ and $k>l \geq 0, r>s \geq 0, k \geq r$, $l \geq s$, we have

\left[\frac{\sigma_{k}(\lambda) / C_{n}^{k}}{\sigma_{l}(\lambda) / C_{n}^{l}}\right]^{\frac{1}{k-l}} \leq\left[\frac{\sigma_{r}(\lambda) / C_{n}^{r}}{\sigma_{s}(\lambda) / C_{n}^{s}}\right]^{\frac{1}{r-s}} \tag{2.5}
\end{equation*}
$$

where $C_{n}^{k}=\frac{n!}{k!(n-k)!}$.
Proof. See 44.
2.2. Key Lemmas. The following inequalities of Hessian operators are very useful for us to establish a priori estimates. One can find the proofs in [7, 8].
Lemma 2.4. Suppose $\lambda=\left(\lambda_{1}, \lambda_{2}, \cdots, \lambda_{n}\right) \in \Gamma_{k}, k \geq 1$, and $\lambda_{1}<0$. Then we have

\begin{equation*}
\sigma_{m}(\lambda \mid 1) \geq \sigma_{m}(\lambda), \quad \forall \quad m=0,1, \cdots, k \tag{2.6}
\end{equation*}
$$

Moreover, we have

$$
\begin{equation*}
\frac{\partial\left[\frac{\sigma_{k}(\lambda)}{\sigma_{l}(\lambda)}\right]}{\partial \lambda_{1}} \geqslant \frac{n}{k} \frac{k-l}{n-l} \frac{1}{n-k+1} \sum_{i=1}^{n} \frac{\partial\left[\frac{\sigma_{k}(\lambda)}{\sigma_{l}(\lambda)}\right]}{\partial \lambda_{i}}, \quad \forall \quad 0 \leq l<k \tag{2.7}
\end{equation*}
$$

Lemma 2.5. Suppose $A=\left\{a_{i j}\right\}_{n \times n}$ satisfies

$$
\begin{equation*}
a_{11}<0, \quad\left\{a_{i j}\right\}_{2 \leq i, j \leq n} \quad \text { is diagonal, } \tag{2.8}
\end{equation*}
$$

and $\lambda(A) \in \Gamma_{k}(k \geq 1)$. Then we have

\begin{equation*}
\frac{\partial\left[\frac{\sigma_{k}(A)}{\sigma_{l}(A)}\right]}{\partial a_{11}} \geqslant \frac{n}{k} \frac{k-l}{n-l} \frac{1}{n-k+1} \sum_{i=1}^{n} \frac{\partial\left[\frac{\sigma_{k}(A)}{\sigma_{l}(A)}\right]}{\partial a_{i i}}, \quad \forall \quad 0 \leq l<k \tag{2.9}
\end{equation*}
$$

and

$$
\begin{equation*}
\sum_{i=1}^{n} \frac{\partial\left[\frac{\sigma_{k}(A)}{\sigma_{l}(A)}\right]}{\partial a_{i i}} \geq \frac{k-l}{k} \frac{1}{C_{n}^{l}}\left(-a_{11}\right)^{k-l-1}, \quad \forall \quad 0 \leq l<k \tag{2.10}
\end{equation*}
$$

where $C_{n}^{l}=\frac{n!}{l!(n-l)!}$.
Lemma 2.6. Suppose $\lambda=\left(\lambda_{1}, \lambda_{2}, \cdots, \lambda_{n}\right) \in \Gamma_{k}, k \geq 2$, and $\lambda_{2} \geq \cdots \geq \lambda_{n}$. If $\lambda_{1}>0, \lambda_{n}<0$, $\lambda_{1} \geq \delta \lambda_{2}$, and $-\lambda_{n} \geq \varepsilon \lambda_{1}$ for small positive constants $\delta$ and $\varepsilon$, then we have

$$
\begin{equation*}
\sigma_{m}(\lambda \mid 1) \geq c_{0} \sigma_{m}(\lambda), \quad \forall \quad m=0,1, \cdots, k-1 \tag{2.11}
\end{equation*}
$$

where $c_{0}=\min \left\{\frac{\varepsilon^{2} \delta^{2}}{2(n-2)(n-1)}, \frac{\varepsilon^{2} \delta}{4(n-1)}\right\}$. Moreover, we have

$$
\begin{equation*}
\frac{\partial\left[\frac{\sigma_{k}(\lambda)}{\sigma_{l}(\lambda)}\right]}{\partial \lambda_{1}} \geqslant c_{1} \sum_{i=1}^{n} \frac{\partial\left[\frac{\sigma_{k}(\lambda)}{\sigma_{l}(\lambda)}\right]}{\partial \lambda_{i}}, \quad \forall \quad 0 \leq l<k \tag{2.12}
\end{equation*}
$$

where $c_{1}=\frac{n}{k} \frac{k-l}{n-l} \frac{c_{0}^{2}}{n-k+1}$.
Remark 2.7. These lemmas play an important role in the establishment of a priori estimates. Precisely, Lemma 2.5 is the key of the gradient estimates in Section 5, including the interior gradient estimate and the near boundary gradient estimate. Lemmas 2.4 and Lemma 2.6 are the keys of the lower and upper estimates of double normal second order derivatives on the boundary in Section 6, respectively.

## 3. $u_{t}$-ESTIMATE

In this section, we follow the proof in Schnürer-Smoczyk [45] to obtain $u_{t}$-estimate.
Lemma 3.1. Suppose $\Omega \subset \mathbb{R}^{n}$ is a $C^{3}$ domain, and $u \in C^{3}(\bar{\Omega} \times[0, T))$ is a $k$-admissible solution of equation (1.1), satisfying (1.2) and (1.3). Then it holds

$$
\begin{equation*}
\min \left\{\min _{\bar{\Omega}} u_{t}(x, 0), 0\right\} \leq u_{t}(x, t) \leq \max \left\{\max _{\bar{\Omega}} u_{t}(x, 0), 0\right\}, \quad \forall(x, t) \in \Omega \times[0, T) \tag{3.1}
\end{equation*}
$$

Moreover,
(i) if (1.4) holds, then we have for any $0<\lambda<c_{f}$

$$
\begin{equation*}
\min \left\{\min _{\bar{\Omega}} u_{t}(x, 0), 0\right\} \leq u_{t}(x, t) e^{\lambda t} \leq \max \left\{\max _{\bar{\Omega}} u_{t}(x, 0), 0\right\}, \quad \forall(x, t) \in \Omega \times[0, T) \tag{3.2}
\end{equation*}
$$

(ii) if (1.5) holds, then we have $u_{t}(x, 0) \equiv 0$ or $u_{t}(x, t)>0$ for any $t>0$.

Proof. For any $\varepsilon>0$ sufficiently small, we consider the evolution equation of $u_{t}$ in $\Omega \times[0, T-\varepsilon]$. It is easy to see that $u_{t}$ satisfies

$$
\left(u_{t}\right)_{t}=F^{i j}\left(u_{t}\right)_{i j}-\frac{f_{u}}{f} u_{t}
$$

where $F^{i j}=\frac{\partial \log \left(\frac{\sigma_{k}}{\sigma_{j}}\right)}{\partial u_{i j}}$. Assume $u_{t}\left(x_{0}, t_{0}\right)=\max _{\bar{\Omega} \times[0, T-\varepsilon]} u_{t}(x, t)>0$, then the weak parabolic maximum principle implies that either $x_{0} \in \partial \Omega$ or $t_{0}=0$. If $x_{0} \in \partial \Omega$, we have at $\left(x_{0}, t_{0}\right)$

$$
0<\left(u_{t}\right)_{\nu}=\varphi_{u} u_{t} \leq-c_{\varphi} u_{t}
$$

which is a contradiction. Thus we have $t_{0}=0$, and the second inequality in (3.1) is proved. Similarly, we can prove the first inequality in (3.1).

The proof of (3.2) is similar as that in (45]. We produce it here for completeness. Let $v(x, t)=$ $e^{\lambda t} u_{t}(x, t)$ for $0<\lambda<c_{f}$, and then $v(x, t)$ satisfies

\begin{aligned}
v_{t} & =\lambda v+e^{\lambda t} u_{t t} \\
& =\lambda v+e^{\lambda t}\left(F^{i j} u_{t i j}-\frac{f_{u}}{f} u_{t}\right) \\
& =F^{i j} v_{i j}+\left(\lambda-\frac{f_{u}}{f}\right) v .
\end{aligned}
$$

Assume $v\left(x_{0}, t_{0}\right)=\max _{\bar{\Omega} \times[0, T-\varepsilon]} v(x, t)>0$. Therefore by maximum principle, we have either $x_{0} \in \partial \Omega$ or $t_{0}=0$. If $x_{0} \in \partial \Omega$, we have at $\left(x_{0}, t_{0}\right)$ by Neumman boundary condition,

$$
0<v_{\nu}=e^{\lambda t} u_{\nu t}=v \varphi_{u}<0,
$$

which is a contradiction. Hence, $t_{0}=0$, i.e. $\max _{\bar{\Omega} \times[0, T-\varepsilon])} v(x, t)=\max _{\bar{\Omega}} u_{t}(x, 0)$. Similarly, we can prove the first inequality in (3.2).

At last, if (1.5) holds, then we have $u_{t}(x, 0) \geq 0$. From (3.1), we know that $u_{t} \geq 0$ for any $t>0$. If $u_{t}(x, 0)$ is not identically to zero, then we let $u_{t}\left(x_{0}, t_{0}\right)=\min _{\bar{\Omega} \times[\varepsilon, T-\varepsilon]} u_{t}(x, t)$. If $u_{t}\left(x_{0}, t_{0}\right)=0$, then the strong maximum principle tells us that $u_{t}(x, t) \equiv u_{t}\left(x_{0}, t_{0}\right)=0$, for any $(x, t) \in \bar{\Omega} \times\left[0, t_{0}\right)$. Thus $u_{t}(x, 0) \equiv 0$, which contradicts the hypothesis that $u_{t}(x, 0)$ is not identically to zero.

## 4. $C^{0}$ estimate

Due to $u_{t}$-estimate in Lemma 3.1, we can derive the $C^{0}$-estimate of $u$ as follows.
Theorem 4.1. Suppose $\Omega \subset \mathbb{R}^{n}$ is a $C^{3}$ domain, and $u \in C^{3}(\bar{\Omega} \times[0, T))$ is a $k$-admissible solution of equation (1.1), satisfying (1.2) and (1.3). Moreover, if $f$ satisfies (1.4) or $u_{0}$ satisfies (1.5), then we have

$$
\begin{equation*}
|u(x, t)| \leq M_{0}, \quad(x, t) \in \Omega \times[0, T), \tag{4.1}
\end{equation*}
$$

where $M_{0}$ is a positive constant depending only on $c_{\varphi}, \max _{\bar{\Omega}}|\varphi(x, 0)|, \max _{\bar{\Omega}}\left|u_{0}\right|, c_{f}$ and $\max _{\bar{\Omega}}\left|u_{t}(x, 0)\right|$.
Proof. We first prove the upper bound of $u$. For any fixed $t, u(x, t)$ is a subharmonic function. If $u\left(x_{0}, t\right)=\max _{\bar{\Omega}} u(x, t)>0$, we must have $x_{0} \in \partial \Omega$. By the Neumann boundary condition, we have at this point

$$
0 \leq u_{\nu}=\varphi\left(x_{0}, u\right)=\varphi\left(x_{0}, 0\right)+\varphi_{u}\left(x_{0}, \theta\right) u \leq \varphi\left(x_{0}, 0\right)-c_{\varphi} u .
$$

Thus $u\left(x_{0}, t\right) \leq \frac{\max _{\Omega} \varphi(x, 0)}{c_{\varphi}}$.
Next we prove the lower bound of $u$. If (1.5) holds, by the equation $u_{t}(x, 0)=\log \left(\frac{\sigma_{k}\left(D^{2} u_{0}\right)}{\sigma_{l}\left(D^{2} u_{0}\right)}\right)-$ $\log f\left(x, u_{0}\right) \geq 0$. Thus by Lemma 3.1 we immediately have $u(x, t) \geq u(x, 0)=u_{0}(x)$.

If (1.4) holds, we have by Lemma 3.1

u(x, t) & \geq u(x, 0)+\int_{0}^{t} u_{t}(x, s) d s \\
& \geq u_{0}(x)+\min \left\{\min _{\bar{\Omega}} u_{t}(x, 0), 0\right\} \int_{0}^{t} e^{-\frac{c_{f}}{2} s} d s \\
& \geq u_{0}(x)+\frac{2 \min \left\{\min _{\bar{\Omega}} u_{t}(x, 0), 0\right\}}{c_{f}} .
\end{aligned}
$$

Hence (4.1) holds if we choose $M_{0}=\frac{\max _{\Omega} \varphi(x, 0)}{c_{\varphi}}+\max _{\Omega}\left|u_{0}(x)\right|+\frac{2 \max _{\Omega}\left|u_{t}(x, 0)\right|}{c_{f}}$.
Remark 4.2. Due to the $C^{0}$ estimate of $u$ and $u_{t}$, we now have

\frac{\sigma_{k}\left(D^{2} u\right)}{\sigma_{l}\left(D^{2} u\right)}=f(x, u) e^{u_{t}} \geq \min _{\Omega} f\left(x,-M_{0}\right) \cdot e^{-\max _{\Omega}\left|u_{t}(x, 0)\right|}=: c_{2}>0 . \tag{4.2}
\end{equation*}
$$

## 5. $C^{1}$ estimates

In this section, we prove the global gradient estimate as follows
Theorem 5.1. Suppose $\Omega \subset \mathbb{R}^{n}$ is a $C^{3}$ domain, and $u \in C^{3}(\bar{\Omega} \times[0, T))$ is a $k$-admissible solution of equation (1.1), satisfying (1.2) and (1.3). Then we have

$$
\begin{equation*}
\sup _{\Omega \times[0, T)}|D u| \leq M_{1} \tag{5.1}
\end{equation*}
$$

where $M_{1}$ depends on $n, k, l, \Omega,|u|_{C^{0}},\left|u_{t}\right|_{C^{0}},\left|D u_{0}\right|_{C^{0}},|\varphi|_{C^{3}}, \min f, \max f$ and $\left|D_{x} f\right|_{C^{0}}$.
To state our theorems, we denote $d(x)=\operatorname{dist}(x, \partial \Omega)$, and $\Omega_{\mu}=\{x \in \Omega \mid d(x)<\mu\}$ where $\mu$ is a small positive universal constant to be determined in Theorem 5.3. In Subsection 5.1, we give the interior gradient estimate in $\left(\Omega \backslash \Omega_{\mu}\right) \times[0, T)$, and in Subsection 5.2 we establish the near boundary gradient estimate in $\Omega_{\mu} \times[0, T)$, following the idea of Ma-Qiu 36].

### 5.1. Interior gradient estimate.

Theorem 5.2. Under the assumptions in Theorem 5.1, then we have

$$
\begin{equation*}
\sup _{\left(\Omega \backslash \Omega_{\mu}\right) \times[0, T)}|D u| \leq \widetilde{M_{1}} \tag{5.2}
\end{equation*}
$$

where $\widetilde{M_{1}}$ depends on $n, k, l, \mu, M_{0},\left|D u_{0}\right|_{C^{0}},\left|u_{t}\right|_{C^{0}}, \min f, \max f$ and $\left|D_{x} f\right|_{C^{0}}$.
Proof. For any fixed point $\left(x_{0}, t_{0}\right) \in\left(\Omega \backslash \Omega_{\mu}\right) \times(0, T)$, we prove that $|D u|\left(x_{0}, t_{0}\right) \leq \widetilde{M_{1}}$, where $\widetilde{M_{1}}>0$ depends on $n, k, l, \mu, M_{0},\left|D u_{0}\right|_{C^{0}},\left|u_{t}\right|_{C^{0}}, \min f, \max f$ and $\left|D_{x} f\right|_{C^{0}}$. It is easy to know that $B_{\mu}\left(x_{0}\right) \times\left[0, t_{0}\right] \subset \Omega \times\left[0, t_{0}\right]$, and we consider the auxiliary function

$$
\begin{equation*}
G(x, t)=|D u| \psi(u) \rho(x) \tag{5.3}
\end{equation*}
$$

in $B_{\mu}\left(x_{0}\right) \times\left[0, t_{0}\right]$, where $\rho=\mu^{2}-\left|x-x_{0}\right|^{2}$, and $\psi(u)=\left(3 M_{0}-u\right)^{-\frac{1}{2}}$. Then $G(x, t)$ attains maximum at some point $\left(x_{1}, t_{1}\right) \in B_{\mu}\left(x_{0}\right) \times\left[0, t_{0}\right]$. If $t_{1}=0$, then $\left|D u\left(x_{1}, t_{1}\right)\right|=\left|D u_{0}\left(x_{1}\right)\right|$. It is easy to obtain the estimate (5.2).

In the following, we assume $t_{1} \in\left(0, t_{0}\right]$. By rotating the coordinate $\left(x_{1}, \cdots, x_{n}\right)$, we can assume

u_{1}\left(x_{1}, t_{1}\right)=|D u|\left(x_{1}, t_{1}\right)>0, \quad\left\{u_{i j}\right\}_{2 \leq i, j \leq n} \text { is diagonal. } \tag{5.4}

\phi(x, t)=\log u_{1}(x, t)+\log \psi(u)+\log \rho \tag{5.5}
\end{equation*}
$$

attains local maximum at the point $\left(x_{1}, t_{1}\right) \in B_{\mu}\left(x_{0}\right) \times\left[0, t_{0}\right]$. Denote $\widetilde{\lambda}=\left(\tilde{\lambda}_{2}, \cdots, \widetilde{\lambda}_{n}\right)=$ $\left(u_{22}\left(x_{1}, t_{1}\right), \cdots, u_{n n}\left(x_{1}, t_{1}\right)\right)$, and all the calculations are at $\left(x_{1}, t_{1}\right)$. So we have at $\left(x_{1}, t_{1}\right)$,

\end{align*}

Hence

In the following, we always assume

\end{equation*}

Otherwise there is nothing to prove. Then we have

& \geq 2 \frac{\psi}{\psi^{\prime}}\left|\rho_{1}\right| \tag{5.10}
\end{align*}
$$

Denote $F^{i j}=\frac{\partial \log \left(\frac{\sigma_{k}\left(D^{2} u\right)}{\sigma_{l}\left(D^{2} u\right)}\right)}{\partial u_{i j}}$, and we have

= & \frac{1}{u_{1}} \frac{f_{1}+f_{u} u_{1}}{f}-F^{i j} \frac{u_{1 i} u_{1 j}}{u_{1}^{2}}+\left[\frac{\psi^{\prime \prime}}{\psi}-\frac{\psi^{\prime 2}}{\psi^{2}}\right] F^{i j} u_{i} u_{j}+\frac{\psi^{\prime}}{\psi}\left[(k-l)-u_{t}\right] \\
& +F^{i j} \frac{\rho_{i j}}{\rho}-F^{i j} \frac{\rho_{i} \rho_{j}}{\rho^{2}} \\
= & \frac{1}{u_{1}} \frac{f_{1}+f_{u} u_{1}}{f}+\left[\frac{\psi^{\prime \prime}}{\psi}-2 \frac{\psi^{\prime 2}}{\psi^{2}}\right] F^{11} u_{1}^{2}+\frac{\psi^{\prime}}{\psi}\left[(k-l)-u_{t}\right] \\
& -\sum_{i} F^{i i} \frac{2}{\rho}-F^{i j}\left[\frac{\psi_{i}}{\psi} \frac{\rho_{j}}{\rho}+\frac{\rho_{i}}{\rho} \frac{\psi_{j}}{\psi}\right]-2 F^{i j} \frac{\rho_{i} \rho_{j}}{\rho^{2}} \\
\geq & -\frac{\left|f_{1} / f\right|}{u_{1}}+\left[\frac{\psi^{\prime \prime}}{\psi}-2 \frac{\psi^{\prime 2}}{\psi^{2}}\right] F^{11} u_{1}^{2}+\frac{\psi^{\prime}}{\psi}\left[(k-l)-u_{t}\right] \\
& -\sum_{i} F^{i i} \frac{2}{\rho}-2 \sum_{i} F^{i i} \frac{\psi^{\prime}}{\psi} u_{1} \frac{|D \rho|}{\rho}-2 \sum_{i} F^{i i} \frac{|D \rho|^{2}}{\rho^{2}} \\
\geq & -\frac{\left|f_{1} / f\right|}{u_{1}}+\frac{1}{64 M_{0}^{2}} F^{11} u_{1}^{2}+\frac{\psi^{\prime}}{\psi}\left[(k-l)-u_{t}\right] \\
& -2 \sum_{i} F^{i i}\left[\frac{1}{\rho}+\frac{1}{4 M_{0}} u_{1} \frac{2 \mu}{\rho}+\frac{4 \mu^{2}}{\rho^{2}}\right] .
\end{aligned}
$$

From Lemma 2.5, we know

& \geq \frac{1}{f e^{u_{t}}} \frac{k-l}{k} \frac{1}{C_{n}^{l}}\left(-u_{11}\right)^{k-l-1} \\
& \geq c_{4} u_{1}^{2(k-l-1)} \tag{5.14}
\end{align*}
$$

Then we can get

& +\sum_{i} F^{i i}\left[\frac{1}{128 M_{0}^{2}} c_{3} u_{1}^{2}-2\left(\frac{1}{\rho}+\frac{1}{4 M_{0}} u_{1} \frac{2 \mu}{\rho}+\frac{4 \mu^{2}}{\rho^{2}}\right)\right] \tag{5.15}
\end{align*}
$$

This yields

\begin{equation*}
\rho\left(x_{1}\right) u_{1}\left(x_{1}, t_{1}\right) \leq C \tag{5.16}
\end{equation*}
$$

where $C$ depends on $n, k, l, \mu, M_{0},\left|u_{t}\right|_{C^{0}}, \min f, \max f$ and $\left|D_{x} f\right|_{C^{0}}$. Hence we can get

\left|D u\left(x_{0}, t_{0}\right)\right| \leq \frac{\psi(u)\left(x_{1}, t_{1}\right)}{\psi(u)\left(x_{0}, t_{0}\right)} \frac{1}{\rho\left(x_{0}\right)} \rho\left(x_{1}\right) u_{1}\left(x_{1}, t_{1}\right) \leq \widetilde{M}_{1} .
$$

From this, the proof is complete.

### 5.2. Near boundary gradient estimate.

Theorem 5.3. Under the assumptions in Theorem 5.1, then there exists a positive universal constant $\mu$ such that

$$
\begin{equation*}
\sup _{\Omega_{\mu} \times[0, T)}|D u| \leq \max \left\{\widetilde{M_{1}}, \widehat{M_{1}}\right\} \tag{5.17}
\end{equation*}
$$

where $\widetilde{M}_{1}$ is the constant in Theorem 5.2, and $\widehat{M}_{1}$ depends on $n, k, l, \mu, \Omega, M_{0},\left|D u_{0}\right|_{C^{0}},\left|u_{t}\right|_{C^{0}}$, $\min _{\Omega} f, \max f,\left|D_{x} f\right|_{C^{0}}$ and $|\varphi|_{C^{3}}$.

Proof. The proof follows the idea of Ma-Qiu [36].
Since $\Omega$ is a $C^{3}$ domain, it is well known that there exists a small positive universal constant $0<\mu<\frac{1}{10}$ such that $d(x) \in C^{3}\left(\overline{\Omega_{\mu}}\right)$. As in Simon-Spruck [43] or Lieberman [33] (in page 331), we can extend $\nu$ by $\nu=-D d$ in $\Omega_{\mu}$ and note that $\nu$ is a $C^{2}\left(\overline{\Omega_{\mu}}\right)$ vector field. As mentioned in the book [33, we also have the following formulas

where $C_{0}$ is depending only on $n$ and $\Omega$. As in [33], we define

and for a vector $\zeta \in \mathbb{R}^{n}$, we write $\zeta^{\prime}$ for the vector with $i$-th component $\sum_{j=1}^{n} c^{i j} \zeta^{j}$. Then we have

We consider the auxiliary function

with $\alpha_{0}>0$ to be determined later. Note that here $\varphi \in C^{3}(\bar{\Omega})$ is an extension with universal $C^{3}$ norms.

For any fixed $T_{0} \in(0, T)$, it is easy to know $G(x, t)$ is well-defined in $\overline{\Omega_{\mu}} \times\left[0, T_{0}\right]$. Then we assume that $G(x, t)$ attains its maximum at a point $\left(x_{0}, t_{0}\right) \in \overline{\Omega_{\mu}} \times\left[0, T_{0}\right]$. If $t_{0}=0$, then $\left|D u\left(x_{0}, t_{0}\right)\right|=\left|D u_{0}\left(x_{0}\right)\right|$. It is easy to obtain the estimate (5.17).

In the following, we assume $t_{0} \in\left(0, T_{0}\right]$ and $|D u|\left(x_{0}, t_{0}\right)>10 n\left[|\varphi|_{C^{1}}+|u|_{C^{0}}\right]$. Then we have

\frac{1}{2}\left|D u\left(x_{0}, t_{0}\right)\right|^{2} \leq\left|D w\left(x_{0}, t_{0}\right)\right|^{2} \leq 2\left|D u\left(x_{0}, t_{0}\right)\right|^{2} \tag{5.23}
\end{equation*}

since $w_{i}=u_{i}+D_{i} \varphi d+\varphi d_{i}$ and $d$ is sufficiently small. Now we divide into three cases to complete the proof of Theorem 5.3.
$\checkmark$ CASE I: $x_{0} \in \partial \Omega_{\mu} \cap \Omega$.
Then $x_{0} \in \Omega \backslash \Omega_{\mu}$, and we can get from the interior gradient estimate (i.e. Theorem 5.2),

- CASE II: $x_{0} \in \partial \Omega$.

At $\left(x_{0}, t_{0}\right)$, we have $d=0$. We may assume $x_{0}=0$. We choose the coordinate such that $\partial \Omega$ is locally represented by $\partial \Omega=\left(x^{\prime}, \rho\left(x^{\prime}\right)\right)$, where $\rho\left(x^{\prime}\right)$ is a $C^{3}$ function with $\rho_{i}(0)=0$ for $1 \leq i \leq n-1$. Thus $\nu\left(x_{0}\right)=(0, \cdots, 0,-1)$. Rotating the $x^{\prime}$-coordinate further, we can assume $w_{1}\left(x_{0}, t_{0}\right)=|D w|\left(x_{0}, t_{0}\right)$. Therefore we have

By Hopf lemma, we have

## 6. $C^{2}$-ESTIMATE

We come now to the a priori estimates of global second derivatives, and we obtain the following theorem

Theorem 6.1. Suppose $\Omega \subset \mathbb{R}^{n}$ is a $C^{4}$ strictly convex domain, and $u \in C^{4}(\bar{\Omega} \times[0, T))$ is a $k$-admissible solution of equation (1.1), satisfying (1.2) and (1.3). Moreover, if $f$ satisfies (1.4) or $u_{0}$ satisfies (1.5), then we have

where $M_{2}$ depends on $n, k, l, \Omega,\left|D^{2} u_{0}\right|_{C^{0}},|D u|_{C^{0}},\left|u_{t}\right|_{C^{0}}, \min _{\Omega} f,|f|_{C^{2}}$ and $|\varphi|_{C^{3}}$.
Following the idea of Lions-Trudinger-Urbas [35] (see also Ma-Qiu 36]), we divide the proof of Theorem 6.1 into three steps. In step one, we reduce global second derivatives to double normal second derivatives on boundary, then we prove the lower estimate of double normal second derivatives on boundary in step two, and at last we prove the upper estimate of double normal second derivatives on boundary.

### 6.1. Global $C^{2}$ estimates can be reduced to the double normal estimates.

Lemma 6.2. Under the assumptions in Theorem 6.1, then we have

We define $\widetilde{d} \in C^{4}(\bar{\Omega})$ such that $\widetilde{d}=d$ in $\overline{\Omega_{\mu}}$ and denote

## 7. Proof of Theorem 1.1

For the Neumann problem of parabolic Hessian quotient equations (1.1), we have established the $\left|u_{t}\right|, C^{0}, C^{1}$ and $C^{2}$ estimates in Section 3, Section 4, Section 5, Section 6, respectively. Then the equation (1.1) is uniformly parabolic in $\bar{\Omega} \times[0, T)$. Due to the concavity of operator $\log \left(\frac{\sigma_{k}(\lambda)}{\sigma_{l}(\lambda)}\right)$ in $\Gamma_{k}$, we can get the global Hölder estimates of second derivative following the discussions in 34, the uniform estimates of all higher derivatives of $u$ can be derived by differentiating the equation (1.1) and apply the Schauder theory for linear, uniformly parabolic equations. Applying the method of continuity (see [15], Theorem 17.28), we can get the existence of smooth $k$-admissible solution $u(x, t)$.

By the uniform estimates of $u$ and the uniform parabolicity of equation (1.1), the solution $u(x, t)$ exists for all time $t \geq 0$, that is $T=+\infty$.

Following the discussions in [45], we can obtain the smooth convergence of $u(x, t)$. That is,

## 8. Proof of Theorem 1.2

In this section, we prove Theorem [1.2, following the ideas of Schnürer-Schwetlick [46], Qiu-Xia 41 and Ma-Wang-Wei 38.
8.1. elliptic problem. Firstly, we solve the following elliptic problem, which is the key of proof of Theorem 1.2 .

Theorem 8.1. Let $\Omega$ is a strictly convex bounded domain in $\mathbb{R}^{n}$ with smooth boundary. Assume that $u_{0}$ is given as in Theorem 1.2 and $f$ is a positive smooth function, $f \in C^{\infty}(\bar{\Omega})$. Then there
exists a unique $s \in \mathbb{R}$ and a $k$-convex function $u \in C^{\infty}(\bar{\Omega})$ solving

Moreover, the solution $u$ is unique up to a constant.
Proof. To find a pair $(s, u)$ solving the above equation, we consider the following approximating equation

In the following, we will prove that for any $\varepsilon>0$, there exists a unique constant $s_{\varepsilon}$ which is uniformly bounded such that $\left|u_{\varepsilon, s_{\varepsilon}}\right|_{C^{k}(\bar{\Omega})}$ ( $k$ is any positive integer) is uniformly bounded. Thus by extracting subsequence, we have $s_{\varepsilon_{i}}$ converges to $s$ and $u_{\varepsilon, s_{\varepsilon}}$ converges to a solution $u$ of our problem (8.1).

Step 1: If we choose $M$ sufficiently large, we have that $u_{\varepsilon}^{+}=u_{0}+\frac{M}{\varepsilon}$ is a supersolution of $\left(*_{\varepsilon, 0}\right)$ and $u_{\varepsilon}^{-}=u_{0}-\frac{M}{\varepsilon}$ is a subsolution of $\left(*_{\varepsilon, 0}\right)$, i.e. $u_{\varepsilon}^{-} \leq u_{\varepsilon, 0} \leq u_{\varepsilon}^{+}$. Thus we have $u_{\varepsilon, M}<u_{0}<u_{\varepsilon,-M}$ in $\Omega$. By strictly decreasing property of $u_{\varepsilon, s}$, for any $\varepsilon \in(0,1)$, there exists a unique $s_{\varepsilon} \in(-M, M)$ such that $u_{\varepsilon, s_{\varepsilon}}\left(y_{0}\right)=u_{0}\left(y_{0}\right)$ for a fixed point $y_{0} \in \Omega$. We also have $\left|\varepsilon u_{\varepsilon, s_{\varepsilon}}\right|_{C^{0}(\bar{\Omega})} \leq 2 M+\varepsilon\left|u_{0}\right|_{C^{0}(\bar{\Omega})} \leq 3 M$.

Step 2: We prove that for $\varepsilon>0$ sufficiently small, $\left|D u_{\varepsilon, s_{\varepsilon}}\right| \leq C_{25}$, where $C_{25}$ is a positive constant independent of $\left|u_{\varepsilon, s_{\varepsilon}}\right|_{C^{0}(\bar{\Omega})}$.

We denote $\widetilde{F}^{i j}=: \frac{\partial\left(\frac{\sigma_{k}\left(D^{2} u\right)}{\sigma_{l}\left(D^{2} u\right)}\right)}{\partial u_{i j}}$. By the equation, we have

Rotating the $x^{\prime}$-axis, we can further assume that $w_{1}\left(x_{0}\right)=|D w|\left(x_{0}\right)$. Moreover we have $u_{1}\left(x_{0}\right)=w_{1}\left(x_{0}\right)$ and $u_{i}\left(x_{0}\right)=w_{i}\left(x_{0}\right)=0$ for $2 \leq i \leq n-1$.

0 \geq F^{i j} G^{i j}-G_{t} & =\frac{2 F^{i j} w_{1 i j}}{w_{1}}+\frac{2 F^{i j} w_{k i} w_{k j}}{w_{1}^{2}}-a^{2} F^{i j} h_{i} h_{j}+a F^{i j} h_{i j}-\frac{2 u_{1 t}}{w_{1}} \\
& \geq \frac{2 F^{i j} w_{1 i j}}{w_{1}}+\frac{2 F^{i j} w_{1 i} w_{1 j}}{w_{1}^{2}}-a^{2} F^{i j} h_{i} h_{j}+a F^{i j} h_{i j}-\frac{2 u_{1 t}}{w_{1}} \\
& =\frac{2 F^{i j} u_{i j 1}-2 F^{i j}(\varphi h)_{i j 1}}{w_{1}}-\frac{1}{2} a^{2} F^{i j} h_{i} h_{j}+a F^{i j} h_{i j}-\frac{2 u_{1 t}}{w_{1}} \\
& \geq \frac{2 f_{1} / f}{w_{1}}-\frac{C_{33}}{w_{1}} \sum_{i=1}^{n} F^{i i}-\frac{1}{2} a^{2} F^{i j} h_{i} h_{j}+a F^{i j} h_{i j} \\
& \geq-\frac{2\left|f_{1}\right| / f}{w_{1}}-C_{34} \frac{1}{w_{1}} \sum_{i=1}^{n} F^{i i}+a\left(a_{0}-\frac{a}{2}\right) \sum_{i=1}^{n} F^{i i}
\end{aligned}
$$

hence we can get $w_{1}\left(x_{0}, t_{0}\right)$ is bounded, and then (8.6) holds.
(3) $\left|D^{2} u\right|$ estimate.

Following the proof of Theorem 6.1, we can get

$$
\begin{equation*}
\left|D^{2} u\right| \leq C_{35}, \quad \forall(x, t) \in \Omega \times[0, T) \tag{8.8}
\end{equation*}
$$

where $C_{35}$ depends only on $n, k, l, \Omega,\left|u_{0}\right|_{C^{2}},|D u|_{C^{0}}, \min f,|f|_{C^{2}}$ and $|\varphi|_{C^{3}}$, but is independent of $|u|_{C^{0}}$.

### 8.3. Proof of Theorem 1.2, :

(1) We first get a bound for the solution $u$ of (1.9).

Now denote $u^{\infty}(x, t)=u_{\text {ell }}^{\infty}(x)+s^{\infty} t$, where $u_{\text {ell }}^{\infty}$ is the solution obtained in Theorem 8.1 then $u^{\infty}$ satisfies

$$
\begin{cases}u_{t}^{\infty}=\log \frac{\sigma_{k}\left(D^{2} u^{\infty}\right)}{\sigma_{l}\left(D^{2} u^{\infty}\right)}-\log f, & (x, t) \in \Omega \times(-\infty,+\infty)  \tag{8.9}\\ \frac{\partial u^{\infty}}{\partial \nu}=\varphi(x), & (x, t) \in \partial \Omega \times(-\infty,+\infty) \\ u^{\infty}(x, 0)=u_{\text {ell }}^{\infty}(x), & x \in \Omega\end{cases}
$$

Take $C_{36}=\max _{\bar{\Omega}}\left|u_{\text {ell }}^{\infty}\right|+\max _{\bar{\Omega}}\left|u_{0}\right|$, then

$$
u_{e l l}^{\infty}(x)-C_{36} \leq u(x, 0)=u_{0}(x) \leq u^{\infty}(x, 0)+C_{36}, \quad \forall x \in \Omega
$$

Thus by parabolic maximum principle we obtain

$$
u_{e l l}^{\infty}-C_{36} \leq u(x, t) \leq u_{e l l}^{\infty}+C_{36}, \quad(x, t) \in \Omega \times(0,+\infty)
$$

That is, we obtain the $C^{0}$ estimate of $u$

$$
\begin{equation*}
s^{\infty} t-C_{37} \leq u(x, t) \leq s^{\infty} t+C_{37}, \quad(x, t) \in \Omega \times(0,+\infty) \tag{8.10}
\end{equation*}
$$

where $C_{37}=C_{36}+\max _{\bar{\Omega}}\left|u_{\text {ell }}^{\infty}\right|$.
(2) We prove the solution $u$ of (1.9) is longtime existence and smooth.

The $C^{1}$ and $C^{2}$ estimates hold as in Subsection 8.2, and the $C^{0}$ estimate is established as above. Following the discussions in [45, we can obtain the existence of the smooth $k$-admissible solution $u(x, t)$, and all higher derivatives of $u$ have uniform bounds. By the uniform estimates of $u$ and the uniform parabolicity of equation (1.9), the solution $u(x, t)$ exists for all time, that is $T=+\infty$.
(3) Now we will show that $u$ converges to a translating solution as $t \rightarrow+\infty$.

To obtain the convergence, we just need to prove that there exists a constant $a$ such that

$$
\begin{equation*}
\lim _{t \rightarrow+\infty}\left|u(x, t)-u_{e l l}^{\infty}(x)-s^{\infty} t-a\right|_{C^{m}(\Omega)}=0 \tag{8.11}
\end{equation*}
$$

holds for any integer $m \geq 0$.
Obviously, $\left(u_{\text {ell }}^{\infty}, s^{\infty}\right)$ is a solution of (1.9), then $\left(u_{\text {ell }}^{\infty}+a, s^{\infty}\right)$ is also a solution of (1.9).
We denote $w(x, t):=u(x, t)-u^{\infty}(x, t)$, then it satisfies

$$
\begin{cases}w_{t}=a^{i j} w_{i j}, & (x, t) \in \Omega \times(0,+\infty),  \tag{8.12}\\ \frac{\partial w}{\partial \nu}=0, & x \in \partial \Omega\end{cases}
$$

where $a^{i j}$ is positive definite. If there exits some time $t_{0}$ such that $w$ is constant in $\Omega \times\left[t_{0}, \infty\right)$, i.e. $u=u^{\infty}$ in $\Omega \times\left[t_{0}, \infty\right)$. Thus $u$ is a translating solution. If for any $t>0, w$ is not constant in $\Omega \times[t, \infty)$. We claim that osc $w(\cdot, t)=\max _{\bar{\Omega}} w(x, t)-\min _{\bar{\Omega}} w(x, t)$ is strictly decreasing. In fact, for any $t_{1}<t_{2}$, there hold by the maximum principle and Hopf Lemma,

$$
\begin{equation*}
\max _{\bar{\Omega}} u\left(x, t_{1}\right)>\max _{\bar{\Omega}} u\left(x, t_{2}\right) \tag{8.13}
\end{equation*}
$$

and

$$
\begin{equation*}
\min _{\bar{\Omega}} u\left(x, t_{1}\right)<\min _{\bar{\Omega}} u\left(x, t_{2}\right) . \tag{8.14}
\end{equation*}
$$

Thus osc $w\left(\cdot, t_{1}\right)>\operatorname{osc} w\left(\cdot, t_{2}\right)$, i.e. osc $w(\cdot, t)$ is strictly decreasing. Hence we can get

$$
\lim _{t \rightarrow \infty} \operatorname{osc} w(\cdot, t)=\delta \geq 0
$$

In the following, we prove $\delta=0$. We define $u^{i}(x, t):=u\left(x, t+t_{i}\right)-s^{\infty} t_{i}$ for a sequence $\left\{t_{i}\right\}$ which converges to $\infty$. Since (8.10), we have $-C_{37}+t s^{\infty} \leq u^{i}(x, t) \leq C_{37}+t s^{\infty}$. And $\left|u^{i}\right|_{C^{k}} \leq C$, for any $k \geq 1$. Hence, there exists a subsequence (for convenience we also denote) $u^{i}$ such that $u^{i}$ converges locally uniformly in any $C^{k}$-norm to a $k$-convex function $u^{*}$. Moreover, $u^{*}$ exists for all time $t \in(-\infty,+\infty)$ and satisfies the following equation

$$
\begin{cases}u_{t}^{*}=\log \frac{\sigma_{k}\left(D^{2} u^{*}\right)}{\sigma_{l}\left(D^{2} u^{*}\right)}-\log f, & (x, t) \in \Omega \times(-\infty,+\infty)  \tag{8.15}\\ \frac{\partial u^{*}}{\partial \nu}=\varphi(x), & (x, t) \in \partial \Omega \times(-\infty,+\infty)\end{cases}
$$

So for any time $t \in(-\infty,+\infty)$, we have

$$
\begin{aligned}
\operatorname{osc}\left(u^{*}-u^{\infty}\right)(\cdot, t) & =\lim _{i \rightarrow \infty} \operatorname{osc}\left(\left(u\left(\cdot, t+t_{i}\right)-s^{\infty} t_{i}-u^{\infty}(\cdot, t)\right)\right. \\
& =\lim _{i \rightarrow \infty} \operatorname{osc}\left(\left(u\left(\cdot, t+t_{i}\right)-u^{\infty}\left(\cdot, t+t_{i}\right)\right)\right. \\
& =\lim _{i \rightarrow \infty} \operatorname{osc}\left(w\left(\cdot, t+t_{i}\right)\right) \\
& =\delta .
\end{aligned}
$$

Namely,

$$
\begin{equation*}
\max _{\bar{\Omega}}\left(u^{*}-u^{\infty}\right)-\min _{\bar{\Omega}}\left(u^{*}-u^{\infty}\right) \equiv \delta \tag{8.16}
\end{equation*}
$$

holds for any time $t \in(-\infty,+\infty)$. It is easy to know $u^{*}-u^{\infty}$ satisfies

$$
\begin{cases}\left(u^{*}-u^{\infty}\right)_{t}=a^{i j}\left(u^{*}-u^{\infty}\right)_{i j}, & (x, t) \in \Omega \times(-\infty,+\infty) \\ \frac{\partial\left(u^{*}-u^{\infty}\right)}{\partial \nu}=0, & (x, t) \in \partial \Omega \times(-\infty,+\infty)\end{cases}
$$

Then $\max _{\bar{\Omega}}\left(u^{*}-u^{\infty}\right)$ is decreasing with respect to $t$, and $\min _{\bar{\Omega}}\left(u^{*}-u^{\infty}\right)$ is increasing by the maximum principle. Hence from (8.16), $\max _{\bar{\Omega}}\left(u^{*}-u^{\infty}\right)$ and $\min _{\bar{\Omega}}\left(u^{*}-u^{\infty}\right)$ are constants for any time $t \in$ $(-\infty,+\infty)$. By the strong maximum principle and Hopf Lemma, $u^{*}-u^{\infty}$ is a constant, and this implies $\delta=0$.

Now, we have $\lim _{t \rightarrow \infty}$ osc $w(\cdot, t)=0$, then there exists a constant $a$ such that $\lim _{t \rightarrow \infty} \max _{\bar{\Omega}}\left(u-u^{\infty}\right)=$ $\lim _{t \rightarrow \infty} \min _{\bar{\Omega}}\left(u-u^{\infty}\right)=a$. Thus $\lim _{t \rightarrow \infty}\left|u(\cdot, t)-u^{\infty}(\cdot, t)-a\right|_{C^{0}(\bar{\Omega})}=0$. The $C^{1}$-norm convergence follows by the following interpolation inequality

$$
|D v|_{C^{0}(\bar{\Omega})}^{2} \leq c(\Omega)|v|_{C^{0}(\bar{\Omega})}\left(\left|D^{2} v\right|_{C^{0}(\bar{\Omega})}+|D v|_{C^{0}(\bar{\Omega})}\right)
$$

for $v=u-u^{\infty}-a$. The $C^{k}$-norm convergence is similar. Hence 8.11) holds, which means the solution $u(x, t)$ converges to a translating solution as $t \rightarrow+\infty$. The proof of Theorem 1.2 is finished.
