# ON DIGITS OF MERSENNE NUMBERS

#### Abstract

Motivated by recently developed interest to the distribution of $q$-ary digits of Mersenne numbers $M_{p}=2^{p}-1$, where $p$ is prime, we estimate rational exponential sums with $M_{p}, p \leqslant X$, modulo a large power of a fixed odd prime $q$. In turn this immediately implies the normality of strings of $q$-ary digits amongst about $(\log X)^{3 / 2+o(1)}$ rightmost digits of $M_{p}, p \leqslant X$. Previous results imply this only for about $(\log X)^{1+o(1)}$ rightmost digits.


## 1. Introduction

1.1. Overview. Recently, Cai, Faust, Hildebrand, Li and Zhang [5] have considered various questions on the patterns in leading $q$-ary digits of Mersenne numbers $M_{p}=2^{p}-1$, where $p$ is prime, see also [4,10] for some other related questions. In particular, one can find in [5] some numerical results which suggest the leftmost $q$-ary digits of Mersenne numbers obey the so-called Benford law. It has also been observed in [5, Remark 4.4 and Section 7] that the bounds of exponential sums with fractions $M_{p} / m$ for a large integer $m$ such as in $[1,2]$ can be used to extract some nontrivial information about the distribution of the rightmost digits of $M_{p}$. This conclusion in [5] is based on bounds of exponential sums with an arbitrary modulus $m$. However for the case $q$-ary digits only moduli of the form $m=q^{\gamma}$ with an integer $\gamma$ are of interest. Here we show that indeed for such moduli, using some ideas of Korobov [12] one can obtain much stronger results. To emphasise the ideas we consider the case when $q$ is prime, however there is no doubt that the method extends to any $q$ without too much loss in its power.

For example, our bounds of exponential sums immediately imply the following equidistribution results for $q$-ary digits of $M_{p}$. For any fixed real $\varepsilon>0$ and for any positive integers $s \leqslant r \leqslant(\log X)^{3 / 2-\varepsilon}$, on rightmost $q$-ary positions $r, \ldots, r-s+1$ of $M_{p}, p \leqslant X$, any block of $q$-ary digits of length $s$ appears asymptotically the same number

[^0]of times, that is $\left(q^{-s}+o(1)\right) \pi(X)$, where, as usual, $\pi(X)$ denotes the number of primes $p \leqslant X$, see Theorem 1.3.

The generic results of [1,2] imply this only for positions which are much closer to the right end, namely, only for $r \leqslant c \log X$ for some absolute constant $c>0$.

Let $m$ be an arbitrary natural number, and let $a$ and $g$ be integers that are coprime to $m$. In this paper, we study exponential sums of the form

\begin{equation*}
S_{m}(a ; X)=\sum_{n \leqslant X} \Lambda(n) \mathbf{e}_{m}\left(a g^{n}\right) \tag{1.1}
\end{equation*}
$$

where $\mathbf{e}_{m}$ is the additive character modulo $m$ defined by

$$
\mathbf{e}_{m}(t)=\exp (2 \pi i t / m) \quad(t \in \mathbb{R})
$$

and $\Lambda$ is the von Mangoldt function:

$$
\Lambda(n)= \begin{cases}\log p & \text { if } n \text { is a power of the prime } p \\ 0 & \text { otherwise }\end{cases}
$$

The sums (1.1) are introduced in Banks et al [1], where it is shown that

$$
\max _{(a, m)=1}\left|S_{m}(a ; X)\right| \leqslant\left(X \tau^{-11 / 32} m^{5 / 16}+X^{5 / 6} \tau^{5 / 48} m^{7 / 24}\right) X^{o(1)}
$$

as $X \rightarrow \infty$, where $\tau=\operatorname{ord}_{m} g$ denotes the multiplicative order of $g$ modulo $m$, that is, the smallest natural number $k$ such that $g^{k} \equiv$ $1 \bmod m$.

Using an idea of Garaev [9] to handle double sums over certain hyperbolic regions, the stronger bound

$$
\max _{(a, m)=1}\left|S_{m}(a ; X)\right| \leqslant\left(X \tau^{-11 / 32} m^{5 / 16}+X^{4 / 5} \tau^{1 / 8} m^{7 / 20}\right) X^{o(1)}
$$

is established in Banks et al [2]. Note that, for either of the above bounds to be nontrivial, one must have $\tau \geqslant m^{10 / 11} X^{o(1)}$ (to control the first term), hence also

$$
m \leqslant X^{22 / 51+o(1)}
$$

(to control the second), as $X \rightarrow \infty$. For shorter sums, new ideas are needed.

In the present paper, we study the exponential sums $S_{m}(a ; X)$ in the special case that $m=q^{\gamma}$ for some fixed prime $q$. Our aim is to establish nontrivial bounds for short sums in which $X$ is smaller than the modulus $m$. Our approach relies on an idea of Korobov [12] coupled with the use of Vinogradov's mean value theorem in the explicit form given by Ford [8].
1.2. Statement of results. Since our main motivation comes from applications to Mersenne numbers, we always assume that $q \geqslant 3$, which simplifies the formulas in Section 2.3 (and can easily be avoided at the cost of some small typographical changes).

Theorem 1.1. Fix a prime $q \geqslant 3$ and an integer $g \geqslant 2$ not divisible by $q$. Let $\gamma$ be a positive integer, $A>0$ be an arbitrary constant and suppose $X \geqslant 2$ satisfies

$$
\begin{equation*}
X \leqslant q^{A \gamma} \tag{1.2}
\end{equation*}
$$

Then, for all integers a with $\operatorname{gcd}(a, q)=1$, we have

$$
\left|S_{q^{\gamma}}(a ; X)\right| \leqslant c(g, q, A)\left(X^{1-\delta(A) \rho^{2}} \log X+X q^{-\delta(A) \gamma}\right)
$$

where $\delta(A)>0$ is a constant depending only on $A$,

$$
\begin{equation*}
\rho=\frac{\log X}{\log q^{\gamma}} \tag{1.3}
\end{equation*}
$$

and $c(g, q, A)$ depends only on $g, q$ and $A$.
We remark that Theorem 1.1 is nontrivial in the range

$$
q^{A \gamma} \geqslant X \geqslant q^{\gamma^{2 / 3+\varepsilon}},
$$

for an arbitrary small $\varepsilon>0$, provided that $X$ is large enough, and with $g=2$ yields (via partial summation) a nontrivial bound on exponential sums with Mersenne numbers $M_{p}=2^{p}-1, p$ prime.

Corollary 1.2. For a prime $q \geqslant 3$ and a real $X \geqslant 2$ satisfying (1.2) we have

$$
\max _{(a, q)=1}\left|\sum_{\substack{p \leqslant X \\ p \text { prime }}} \mathbf{e}_{q^{\gamma}}\left(a M_{p}\right)\right| \leqslant c(q, A)\left(X^{1-\delta_{0}(A) \rho^{2}}+X q^{-\delta_{0}(A) \gamma}\right),
$$

where $\delta_{0}(A)>0$ is a constant depending only on $A, \rho$ is as in (1.3) and $c(q, A)$ depends only on $q$ and $A$.

We are now able to address the question of distribution of rightmost digits of Mersenne numbers. Given a string $\sigma$ of $s$ digits to base $q$,

$$
\begin{equation*}
\sigma=\left(a_{s-1}, \ldots, a_{0}\right) \in\{0, \ldots, q-1\}^{s} \tag{1.4}
\end{equation*}
$$

we denote by $A_{r}(X, \sigma)$ the number of primes $p \leqslant X$ such that $M_{p}$ written in base $q$ has $\sigma$ as the string on $s$ consecutive digits on positions $r, \ldots, r-s+1$, counting from the right to the left, where the numbering starts with zero.

We recall that by the prime number theorem (in a very crude form) we have $\pi(X)=(1+o(1)) X / \log X$ as $X \rightarrow \infty$.

Theorem 1.3. For a fixed prime $q \geqslant 3$, a real $\varepsilon>0$ and a string $\sigma$ of length $s$ of the form (1.4), uniformly over $\varepsilon \log X \leqslant r \leqslant(\log X)^{3 / 2-\varepsilon}$ and strings $\sigma$ of length $s$ of the form (1.4) we have

$$
A_{r}(X, \sigma)=\left(q^{-s}+o(1)\right) \pi(X)
$$

as $X \rightarrow \infty$.
We remark that the lower bound on $r$ can be relaxed but a condition of this kind is necessary. For example, if 2 is not a primitive root modulo $q$ the distribution of digits on the rightmost positions cannot be uniform.

## 2. Preliminaries

2.1. Notation. Throughout, $\mathbb{N}$ is the set of positive integers. The letters $k, m$ and $n$ (with or without subscripts) are always used to denote positive integers; the letter $q$ (with or without subscripts) is always used to denote a prime.

Given a prime $q$, let $\nu_{q}$ denote the standard $q$-adic valuation. In particular, for every $n \in \mathbb{Z} \backslash\{0\}$ one has $\nu_{q}(n)=k$, where $k$ is the largest nonnegative integer for which $q^{k} \mid n$.

Given a sequence of complex weights

$$
\gamma=\left(\gamma_{h}\right)_{h \in \mathcal{H}}
$$

supported on a finite set $\mathcal{H}$ and $\varsigma \geqslant 1$ we define norms of $\gamma$ in the usual way

$$
\|\gamma\|_{\infty}=\max _{h \in \mathcal{H}}\left|\gamma_{h}\right| \quad \text { and } \quad\|\gamma\|_{\varsigma}=\left(\sum_{h \in \mathcal{H}}\left|\gamma_{h}\right|^{\varsigma}\right)^{\frac{1}{\varsigma}} .
$$

For given functions $F$ and $G$, the notations $F \ll G, G \gg F$ and $F=$ $O(G)$ are all equivalent to the statement that the inequality $|F| \leqslant c|G|$ holds with some constant $c>0$. Throughout the paper, any implied constants in symbols $O, \ll$ and $\gg$ may depend on the parameters $q$, $A$ and are absolute unless specified otherwise.

We write $F \asymp G$ to indicate that $F \ll G$ and $G \ll F$ both hold.
Finally we use $\# \mathcal{S}$ to denote the cardinality of a finite set $\mathcal{S}$.
2.2. Sums over primes. It is convenient to use a form of the Vaughan identity given by [6, Chapter 24, Equation (6)].

Lemma 2.1. For any complex-valued function $f(n)$ with $|f(n)| \leqslant 1$ and any real numbers $1<U, V \leqslant X$ with $U V \leqslant X$, we have

$$
\sum_{n \leqslant X} \Lambda(n) f(n) \ll U+\Sigma_{1} \log X+\Sigma_{2}^{1 / 2} X^{1 / 2}(\log X)^{3}
$$

where

$$
\begin{aligned}
& \Sigma_{1}=\sum_{t \leqslant U V} \max _{w \leqslant X / t}\left|\sum_{w \leqslant m \leqslant X / t} f(m t)\right|, \\
& \Sigma_{2}=\max _{U \leqslant w \leqslant X / V} \max _{V \leqslant j \leqslant X / w} \sum_{V<m \leqslant X / w}\left|\sum_{\substack{w<n \leqslant 2 w \\
n \leqslant X / m \\
n \leqslant X / j}} f(j n) \bar{f}(m n)\right| .
\end{aligned}
$$

2.3. Multiplicative order of integers. Fix a prime $q \geqslant 3$ and an integer $g \neq \pm 1$ with $\operatorname{gcd}(g, q)=1$. For every $n \in \mathbb{N}$, let $\tau_{n}=\operatorname{ord}_{q^{n}} g$ denote the order of $g$ modulo $q^{n}$. We write

$$
\begin{equation*}
g^{\tau_{n}}=1+h_{n} q^{n+\mathfrak{g}_{n}} \quad(n \in \mathbb{N}) \tag{2.1}
\end{equation*}
$$

with some uniquely determined integers $h_{n}$ and $\mathfrak{g}_{n} \geqslant 0$ such that $\operatorname{gcd}\left(h_{n}, q\right)=1$. We also put

$$
\begin{equation*}
\tau=\tau_{1} \quad \text { and } \quad G=\mathfrak{g}_{1}+1=\nu_{q}\left(g^{\tau}-1\right) \tag{2.2}
\end{equation*}
$$

A simple argument shows

$$
\mathfrak{g}_{n}=\left\{\begin{array}{ll}
G-n & \text { if } n \leqslant G,  \tag{2.3}\\
0 & \text { if } n \geqslant G,
\end{array} \quad \text { and } \quad \tau_{n}= \begin{cases}\tau & \text { if } n \leqslant G \\
q^{n-G} \tau & \text { if } n \geqslant G\end{cases}\right.
$$

The following two statements are easy consequences of (2.3).
Lemma 2.2. For $r \geqslant s \geqslant G$ we have

$$
g^{n_{1} \tau_{s}} \equiv g^{n_{2} \tau_{s}} \bmod q^{r} \quad \Longleftrightarrow \quad q^{r-s} \mid\left(n_{1}-n_{2}\right) .
$$

Lemma 2.3. For $m \in \mathbb{N}$ and nonnegative integers $x$ and $y$ with $x \neq y$, either $q \nmid g^{m x}-g^{m y}$ or

$$
\nu_{q}\left(g^{m x}-g^{m y}\right)=\nu_{q}(x-y)+\nu_{q}(m)+G .
$$

Proof. Put $\tau_{0}=1$. For any integer $n \geqslant 0$ we have $q^{n} \mid g^{m x}-g^{m y}$ if and only if $m x \equiv m y \bmod \tau_{n}$. Consequently,

$$
\nu_{q}\left(g^{m x}-g^{m y}\right)=\max \left\{n \geqslant 0: \tau_{n} \mid m(x-y)\right\},
$$

and the result follows from (2.3) as $\operatorname{gcd}(\tau, q)=1$.
2.4. Explicit form of the Vinogradov mean value theorem. Let $N_{r, k}(P)$ be the number of integral solutions to the system of equations

$$
n_{1}^{j}+\cdots+n_{r}^{j}=m_{1}^{j}+\cdots+m_{r}^{j} \quad\left(1 \leqslant j \leqslant k, 1 \leqslant n_{\ell}, m_{\ell} \leqslant P\right) .
$$

Our application of Lemma 2.5 below requires a precise form of the Vinogradov mean value theorem. For this purpose, we use a fully explicit version due to Ford [8, Theorem 3], which is presented here in a weakened and simplified form.

Lemma 2.4. For any integer $k \geqslant 129$ there is an integer $r \in\left[2 k^{2}, 4 k^{2}\right]$ such that for $P>0$

$$
N_{r, k}(P) \leqslant k^{3 k^{3}} P^{2 r-k(k+1) / 2+k^{2} / 1000} .
$$

We note that the condition $r \geqslant 2 k^{2}$ is not explicit in [8, Theorem 3] however we can always impose this in view of the well-know (and essentially trivial) monotonicity property

$$
N_{r+1, k}(P) P^{-2(r+1)} \leqslant N_{r, k}(P) P^{-2 r} .
$$

We also observe that the recent striking advances in the Vinogradov mean value theorem due to Bourgain, Demeter and Guth [3] and Wooley [14] are not suitable for our purposes here as they contain implicit constants that depend on $r$ and $k$, whereas in our approach $r$ and $k$ grow together with $P$. On the other hand, a result of Steiner [13] may perhaps be used to improve numerical constants in our estimates in some ranges of parameters.
2.5. Double exponential sums with polynomials. Our main tool to bound the exponential sum $S_{m}(a, X)$ is the following variation of a result of Korobov [12, Lemma 3]; examining the proof of [12, Lemma 3] one can easily see that one can add complex weights $\alpha(x)$ and $\beta(y)$ without any changes in the proof.

It is convenient to denote

$$
\mathbf{e}(t)=\exp (2 \pi i t) \quad(t \in \mathbb{R})
$$

Lemma 2.5. Let $\xi_{j} \in \mathbb{R}$ for $j=1, \ldots, k$, and suppose that each $\xi_{j}$ has a rational approximation such that

$$
\left|\xi_{j}-\frac{b_{j}}{q_{j}}\right| \leqslant \frac{1}{q_{j}^{2}} \quad \text { with } \quad b_{j} \in \mathbb{Z}, \quad q_{j} \in \mathbb{N}, \quad \text { and } \quad\left(b_{j}, q_{j}\right)=1
$$

Then, for any natural number $r$ and sequences of complex numbers $\alpha(x), \beta(y)$ satisfying

$$
|\alpha(x)|,|\beta(y)| \leqslant 1,
$$

the sum

$$
S=\sum_{x, y=1}^{P} \alpha(x) \beta(y) \mathbf{e}\left(\xi_{1} x y+\cdots+\xi_{k} x^{k} y^{k}\right)
$$

admits the upper bound

$$
\begin{aligned}
|S|^{2 r^{2}} \leqslant\left(64 r^{2} \log (3 Q)\right)^{k / 2} & P^{4 r^{2}-2 r} N_{r, k}(P) \\
& \prod_{j=1}^{k} \min \left\{P^{j}, P^{j} q_{j}^{-1 / 2}+q_{j}^{1 / 2}\right\},
\end{aligned}
$$

where

$$
Q=\max _{1 \leqslant j \leqslant k}\left\{q_{j}\right\} .
$$

The following result follows from the standard completing technique, see [11, Section 12.2].

Lemma 2.6. For an arbitrary function $f: \mathbb{R} \rightarrow \mathbb{R}$, an interval $\mathcal{I}$ of length $N$, and integers $U, V$ satisfying

$$
U V \leqslant \frac{N}{2}
$$

there exists some $\alpha \in \mathbb{R}$ such that

$$
\sum_{x \in \mathcal{I}} \mathbf{e}(f(x)) \ll \frac{\log N}{U V} \sum_{x \in \mathcal{J}} \sum_{u \leqslant U}\left|\sum_{v \leqslant V} \mathbf{e}(f(x+u v)+\alpha v)\right|,
$$

and $\mathcal{J}$ is some interval of length $2 N$.
Proof. It is enough to write

$$
\sum_{x \in \mathcal{I}} \mathbf{e}(f(x))=\sum_{\substack{x \in \mathcal{J} \\ x+u v \in \mathcal{I}}} \mathbf{e}(f(x+u v))
$$

and the use the completing technique from [11, Section 12.2$]$ to encode the condition $x+u v \in \mathcal{I}$ into linear exponential sums and the use [11, Bound (8.6)].
2.6. Bilinear forms with exponential functions. Fix a prime $q$ and integer $g \neq \pm 1$ with $\operatorname{gcd}(q, g)=1$. We denote by $\tau_{n}$ the order of $g$ modulo $q^{n}$, and recall how $G$ is defined in (2.2).

The following proposition is the main ingredient for Theorem 1.1. It uses some ideas of Korobov [12, Theorem 4].
Proposition 2.7. Let $\gamma \in \mathbb{N}$ with $\gamma>16 G$. Given integers $K, L \geqslant 0$ and $M, N \geqslant 1$ with

$$
M \leqslant q^{2 \gamma / 65}
$$

two sequences of complex weights

$$
\boldsymbol{\alpha}=\left(\alpha_{m}\right)_{m=K+1}^{K+M} \quad \text { and } \quad \boldsymbol{\beta}=\left(\beta_{n}\right)_{n=L+1}^{L+N}
$$

and an integer z not divisible by $q$, for the sum

$$
S=\sum_{m=K+1}^{K+M} \sum_{n=L+1}^{L+N} \alpha_{m} \beta_{n} \mathbf{e}_{q^{\gamma}}\left(z g^{m n}\right)
$$

we have

$$
\begin{aligned}
& S \ll\|\boldsymbol{\alpha}\|_{2}\|\boldsymbol{\beta}\|_{\infty}\left(M^{1 / 2-10^{-10} \rho^{2}} N \log M+M^{1 / 2} N^{1 / 2}\right) \\
&+\|\boldsymbol{\alpha}\|_{\infty}\|\boldsymbol{\beta}\|_{\infty} N q^{8 G}
\end{aligned}
$$

where

$$
\rho=\frac{\log M}{\log q^{\gamma}}
$$

Proof. To simplify the notation, we write

$$
\mathcal{M}=\{K+1, \ldots, K+M\} \quad \text { and } \quad \mathcal{N}=\{L+1, \ldots, L+N\}
$$

First note we may assume

$$
\begin{equation*}
M \geqslant\left(\log q^{\gamma}\right)^{32} \tag{2.4}
\end{equation*}
$$

as otherwise

$$
M^{\rho^{2}} \ll 1,
$$

and hence for the first term in the bound for $S$

$$
\|\boldsymbol{\alpha}\|_{2}\|\boldsymbol{\beta}\|_{\infty} M^{1 / 2-10^{-10} \rho^{2}} N \log M \gg\|\boldsymbol{\alpha}\|_{2}\|\boldsymbol{\beta}\|_{\infty} M^{1 / 2} N \log M,
$$

which is worse than trivial. If

$$
M \leqslant q^{8 G}
$$

then we have

$$
S \leqslant \sum_{m=K+1}^{K+M} \sum_{n=L+1}^{L+N}\left|\alpha_{m}\left\|\beta_{n} \mid \leqslant\right\| \boldsymbol{\alpha}\left\|_{\infty}\right\| \boldsymbol{\beta} \|_{\infty} N q^{8 G} .\right.
$$

Hence we may assume

$$
M \geqslant q^{8 G} .
$$

By the Cauchy-Schwarz inequality

$$
\begin{align*}
|S|^{2} & \leqslant\|\boldsymbol{\alpha}\|_{2}^{2} \sum_{m \in \mathcal{M}}\left|\sum_{n \in \mathcal{N}} \beta_{n} \mathbf{e}_{q^{\gamma}}\left(z g^{m n}\right)\right|^{2} \\
& \leqslant\|\boldsymbol{\alpha}\|_{2}^{2} \sum_{n_{1}, n_{2} \in \mathcal{N}}\left|\beta_{n_{1}}\left\|\beta_{n_{2}}\right\| S\left(n_{1}, n_{2}\right)\right|  \tag{2.5}\\
& \leqslant\|\boldsymbol{\alpha}\|_{2}^{2}\|\boldsymbol{\beta}\|_{\infty}^{2} \sum_{n_{1}, n_{2} \in \mathcal{N}}\left|S\left(n_{1}, n_{2}\right)\right|,
\end{align*}
$$

where

$$
S\left(n_{1}, n_{2}\right)=\sum_{m \in \mathcal{M}} \mathbf{e}_{q^{\gamma}}\left(z\left(g^{n_{1} m}-g^{n_{2} m}\right)\right) .
$$

Recall we are assuming

$$
\begin{equation*}
\rho \leqslant \frac{2}{65} . \tag{2.6}
\end{equation*}
$$

Define $s$ by

$$
\begin{equation*}
s=\left\lfloor\frac{\rho \gamma}{8}\right\rfloor=\left\lfloor\frac{1}{8} \frac{\log M}{\log q}\right\rfloor \geqslant G, \tag{2.7}
\end{equation*}
$$

so that from (2.3), we have

$$
\begin{equation*}
\tau_{s} \leqslant q^{s} \leqslant M^{1 / 8} \tag{2.8}
\end{equation*}
$$

and

$$
\begin{equation*}
q^{s}>\frac{M^{1 / 8}}{q} \gg M^{1 / 8} \tag{2.9}
\end{equation*}
$$

with implied constant depending on $q$. To establish the desired result we bound $S\left(n_{1}, n_{2}\right)$ in different ways as the pair $\left(n_{1}, n_{2}\right)$ varies over $\mathcal{N} \times \mathcal{N}$.

We denote

$$
\begin{aligned}
& \mathcal{A}_{1}=\left\{\left(n_{1}, n_{2}\right) \in \mathcal{N} \times \mathcal{N}: \nu_{q}\left(n_{1}\right)>s \text { or } \nu_{q}\left(n_{2}\right)>s\right\} \\
& \mathcal{A}_{2}=\left\{\left(n_{1}, n_{2}\right) \in \mathcal{N} \times \mathcal{N}: g^{n_{1} \tau_{s}} \equiv g^{n_{2} \tau_{s}} \bmod q^{2 s}\right\} \\
& \mathcal{A}_{3}=(\mathcal{N} \times \mathcal{N}) \backslash\left(\mathcal{A}_{1} \cup \mathcal{A}_{2}\right)
\end{aligned}
$$

Clearly,

$$
\# \mathcal{A}_{1} \leqslant 2 N^{2} / q^{s}
$$

and Lemma 2.2 implies that

$$
\# \mathcal{A}_{2} \leqslant N^{2} / q^{s}+N
$$

Thus using the trivial bound $\left|S\left(n_{1}, n_{2}\right)\right| \leqslant M$ along with (2.9) we get that

$$
\begin{align*}
\sum_{j=1,2} \sum_{\left(n_{1}, n_{2}\right) \in \mathcal{A}_{j}}\left|S\left(n_{1}, n_{2}\right)\right| & \ll\left(\frac{M N^{2}}{q^{s}}+M N\right)  \tag{2.10}\\
& \ll\left(N^{2} M^{7 / 8}+M N\right)
\end{align*}
$$

For the final set $\mathcal{A}_{3}$, we need a nontrivial bound on $S\left(n_{1}, n_{2}\right)$. Let $\left(n_{1}, n_{2}\right) \in \mathcal{A}_{3}$ be fixed. Since $\left|S\left(n_{1}, n_{2}\right)\right|=\left|S\left(n_{2}, n_{1}\right)\right|$, without loss of generality we can assume

and

\mathcal{Y}=\left(K / \tau_{s},(K+M) / \tau_{s}\right] \cap \mathbb{Z}

By (2.14) we have

& \equiv \lambda^{x}-\mu^{x}+\sum_{i=1}^{k} q^{(s+a) i}\left(\lambda^{x} u^{i}-\mu^{x} v^{i} q^{\Delta i}\right)\binom{y}{i} \bmod q^{\gamma},
\end{aligned}
$$

where we have put $\Delta=b-a$ (note that (2.12) is used in the last step); therefore,

We apply Lemma 2.6 with the function

& \quad \ll \frac{\log M}{P^{2}} \sum_{x=1}^{\tau_{s}} \sum_{y \in \mathcal{Z}} \sum_{z_{1}=1}^{P}\left|\sum_{z_{2}=1}^{P} \mathbf{e}\left(\alpha_{x} z_{2}\right) \mathbf{e}_{q^{\gamma}}\left(f\left(y+z_{1} z_{2}\right)\right)\right|  \tag{2.16}\\
& \\
& \quad \ll \frac{\log M}{P^{2}} \sum_{x=1}^{\tau_{s}} \sum_{y \in \mathcal{Z}}\left|\sum_{z_{1}=1}^{P} \sum_{z_{2}=1}^{P} \mathbf{e}\left(\alpha_{x} z_{2}\right) \beta_{x, y}\left(z_{1}\right) \mathbf{e}_{q^{\gamma}}\left(f\left(y+z_{1} z_{2}\right)\right)\right|,
\end{align*}
$$

where $\mathcal{Z}$ is an interval of length $O\left(M / \tau_{s}\right)$ and $\alpha_{x}$ may depend on the variable $x$ and $\beta_{x, y}$ may depend on the variables $x$ and $y$ and satisfies

Since $\lambda^{x}-\mu^{x}=$ $g^{n_{1} x}-g^{n_{2} x}$ and $n_{1} \neq n_{2}$ (in fact, $\nu_{q}\left(n_{1}-n_{2}\right)<s$ by Lemma 2.2 since $\left(n_{1}, n_{2}\right) \notin \mathcal{A}_{2}$ ), by Lemma 2.3 and inequalities (2.7) and (2.8) we have
$\nu_{q}\left(\lambda^{x}-\mu^{x}\right)=0 \quad$ or $\quad \nu_{q}\left(\lambda^{x}-\mu^{x}\right)=\nu_{q}\left(n_{1}-n_{2}\right)+\nu_{q}(x)+G \leqslant 3 s ;$
this implies that $\bar{\nu} \leqslant 3 s$. Thus, for every $j \in \mathcal{J}$ we have by (2.24):

\end{aligned}
$$

Lemma 2.5 shows that for any natural number $r$, the bound

holds with $Q=\max _{1 \leqslant j \leqslant k} q_{j}$. Note that (2.23) and (2.27) imply that

since $M^{7 / 16} N$ never dominates the term $N M^{1 / 2-10^{-10} \rho^{2}} \log M$, we obtain the desired result.

We may remove the condition $M \leqslant q^{2 \gamma / 65}$ by partitioning the summation over $M$ into short intervals and this is done for applications to Theorem 1.3 where we need to considered both large and short ranges of the parameter $M$.

S \ll\|\boldsymbol{\alpha}\|_{2}\|\boldsymbol{\beta}\|_{\infty}\left(M^{1 / 2-c \rho^{2}} N \log M\right. & \left.+M^{1 / 2} N^{1 / 2}\right) \\
& +\left(1+\frac{M}{q^{2 \gamma / 65}}\right)\|\boldsymbol{\alpha}\|_{\infty}\|\boldsymbol{\beta}\|_{\infty} N q^{8 G}
\end{aligned}
$$

where

$$
\rho=\frac{\log M}{\log q^{\gamma}}
$$

and $c>0$ is a constant depending on $A$.
Proof. By Proposition 2.7 we may assume $M \geqslant q^{2 \gamma / 65}$, and by modifying the coefficients $\boldsymbol{\alpha}$ (appending them with at most $\left\lfloor q^{2 \gamma / 65}\right\rfloor$ zeros) we may assume

\begin{equation*}
M=J M_{0}, \quad \text { with } \quad M_{0}=\left\lfloor q^{2 \gamma / 65}\right\rfloor \tag{2.37}
\end{equation*}
$$

for some integer $J \geqslant 1$. Subdividing $S$ into $J$ sums

$$
S_{j}=\sum_{m=K+1+M_{0} j}^{K+M_{0}(j+1)} \sum_{n=L+1}^{L+N} \alpha_{m} \beta_{n} \mathbf{e}_{q^{\gamma}}\left(z g^{m n}\right),
$$

by the the Cauchy-Schwarz inequality and Proposition 2.7 (applied for each $0 \leqslant j \leqslant J-1$ ), denoting where

$$
\begin{equation*}
\rho_{0}=\frac{\log M_{0}}{\log q^{\gamma}} . \tag{2.38}
\end{equation*}
$$

we obtain

$$
\begin{aligned}
& |S|^{2} \leqslant J \sum_{j=0}^{J-1}\left|S_{j}\right|^{2} \\
& \ll J\|\boldsymbol{\beta}\|_{\infty}^{2} \sum_{j=0}^{J-1} \sum_{m=K+1+M_{0} j}^{K+M_{0}(j+1)}\left|\alpha_{m}\right|^{2} \\
& \left(M_{0}^{1-2 \cdot 10^{-10} \rho_{0}^{2}} N^{2} \log ^{2} M+q^{2 \gamma / 65} N\right) \\
& +J^{2}\|\boldsymbol{\alpha}\|_{\infty}^{2}\|\boldsymbol{\beta}\|_{\infty}^{2} N^{2} q^{16 G} \\
& \ll\|\boldsymbol{\alpha}\|_{2}^{2}\|\boldsymbol{\beta}\|_{\infty}^{2}\left(J q^{2 \gamma\left(1-2 \cdot 10^{-10} \rho_{0}^{2}\right) / 65} N^{2} \log ^{2} M+J q^{2 \gamma / 65} N\right) \\
& +J^{2}\|\boldsymbol{\alpha}\|_{\infty}^{2}\|\boldsymbol{\beta}\|_{\infty}^{2} N^{2} q^{16 G} \\
& \ll\|\boldsymbol{\alpha}\|_{2}^{2}\|\boldsymbol{\beta}\|_{\infty}^{2}\left(M q^{-2 \cdot 10^{-10} \gamma \rho_{0}^{2} / 65} N^{2} \log ^{2} M+M N\right) \\
& +\|\boldsymbol{\alpha}\|_{\infty}^{2}\|\boldsymbol{\beta}\|_{\infty}^{2} N^{2} \frac{q^{16 G} M^{2}}{q^{4 \gamma / 65}} .
\end{aligned}
$$

By (2.36), (2.37) and (2.38) we have

$$
q^{10^{10} \gamma \rho_{0}^{2}} \geqslant M^{c \rho^{2}}
$$

for some constant $c$ depending on $A$. Hence

$$
\begin{aligned}
&|S| \ll\|\boldsymbol{\alpha}\|_{2}\|\boldsymbol{\beta}\|_{\infty}\left(M^{1 / 2-c \rho^{2}} N \log ^{2} M\right.\left.+M^{1 / 2} N^{1 / 2}\right) \\
&+\|\boldsymbol{\alpha}\|_{\infty}\|\boldsymbol{\beta}\|_{\infty} N \frac{q^{8 G} M}{q^{2 \gamma / 65}},
\end{aligned}
$$

which completes the proof.
We now estimate double sums with variables limits of summation for one variable.

Lemma 2.9. Let $\gamma \in \mathbb{N}$ with $\gamma>16 G$ and let $A>0$ be arbitrary. Given integers $M, N \geqslant 1$ and $L \geqslant 0$ with

$$
M \leqslant q^{A \gamma}
$$

two sequences

$$
\left(K_{m}\right)_{m=1}^{M} \quad \text { and } \quad\left(N_{m}\right)_{m=1}^{M}
$$

of nonnegative integers such that $K_{m}<N_{m} \leqslant N$ for each $m$, two sequences of complex weights

$$
\boldsymbol{\alpha}=\left(\alpha_{m}\right)_{m=1}^{M} \quad \text { and } \quad \boldsymbol{\beta}=\left(\beta_{n}\right)_{n=1}^{N}
$$

with

$$
\|\boldsymbol{\alpha}\|_{\infty},\|\boldsymbol{\beta}\|_{\infty} \ll 1
$$

and an integer $z$ not divisible by $q$, for the sum

$$
\widetilde{S}=\sum_{m=L+1}^{L+M} \sum_{K_{m} \leqslant n \leqslant N_{m}} \alpha_{m} \beta_{n} \mathbf{e}_{q^{\gamma}}\left(z g^{m n}\right)
$$

we have

$$
\widetilde{S} \ll\left(N M^{1-c \rho^{2}}+N^{1 / 2} M\right) \log M \log N+\left(1+\frac{M}{q^{2 \gamma / 65}}\right) N q^{8 G} \log N
$$

where

$$
\rho=\frac{\log M}{\log q^{\gamma}}
$$

and $c>0$ is a constant depending on $A$.
Proof. Using the standard completing technique, see [11, Section 12.2], and $[11$, Bound (8.6)] it follows that

$$
\widetilde{S}=\sum_{-N / 2<r \leqslant N / 2} \frac{1}{|r|+1} \sum_{m=L+1}^{L+M} \sum_{n=1}^{N} \widetilde{\alpha}_{m, r} \widetilde{\beta}_{n, r} \mathbf{e}_{q^{\gamma}}\left(z g^{m n}\right),
$$

where

$$
\widetilde{\alpha}_{m, r}=\alpha_{m} \eta_{m, r} \quad \text { and } \quad \widetilde{\beta}_{n, r}=\beta_{n} \mathbf{e}_{N}(r n),
$$

for some complex number $\eta_{m, r} \ll 1$. Applying Corollary 2.8 and noting that

$$
\sum_{-N / 2<r \leqslant N / 2} \frac{1}{|r|+1} \ll \log N,
$$

we derive

$$
\widetilde{S} \ll\left(N M^{1-c \rho^{2}}+N^{1 / 2} M\right) \log M \log N+\left(1+\frac{M}{q^{2 \gamma / 65}}\right) N q^{8 G} \log N
$$

which completes the proof.
2.7. Bounds on double exponential sums over hyperbolic domains. One of our main technical tool is the following result, which gives a bound on double exponential sums over certain "hyperbolic" regions of summation.

We recall the definition of $G$, given in (2.2).
Lemma 2.10. Let $\gamma \in \mathbb{N}$ with $\gamma>16 G$ and $A>0$. Given real numbers $X, Y, Z \geqslant 1$ with

$$
Z<Y \leqslant q^{A \gamma}
$$

and a sequence $\boldsymbol{\beta}=\left(\beta_{n}\right)_{n \leqslant X / Z}$ of complex numbers with

$$
\|\boldsymbol{\beta}\|_{\infty} \leqslant 1
$$

any sequences

$$
\left(K_{m}\right)_{m=1}^{M} \quad \text { and } \quad\left(N_{m}\right)_{m=1}^{M}
$$

of nonnegative integers such that $K_{m}<N_{m} \leqslant X / m$ for each $m$, and any integer $z$ coprime to $q$, we have

$$
\begin{aligned}
\sum_{Z<m \leqslant Y} & \left|\sum_{K_{m} \leqslant n \leqslant N_{m}} \beta_{n} \mathbf{e}_{q^{\gamma}}\left(z g^{m n}\right)\right| \\
& \ll\left(X Z^{-c \zeta^{2}}+(Y X)^{1 / 2}\right)(\log X)^{2}+\left(\frac{1}{Z}+\frac{1}{q^{2 \gamma / 65}}\right) X q^{8 G} \log X
\end{aligned}
$$

where

$$
\begin{equation*}
\zeta=\frac{\log Z}{\log q^{\gamma}} \tag{2.39}
\end{equation*}
$$

and $c>0$ is a constant depending only $A$.
Proof. Clearly there are complex numbers $\alpha_{m}$ such that $\left|\alpha_{m}\right|=1$ for $Z<m \leqslant Y$ and $\alpha_{m}=0$ otherwise, such that

$$
\sum_{Z<m \leqslant Y}\left|\sum_{K_{m} \leqslant n \leqslant N_{m}} \beta_{n} \mathbf{e}_{q^{\gamma}}\left(z g^{m n}\right)\right|=\sum_{z<m \leqslant Y} \alpha_{m} \sum_{K_{m} \leqslant n \leqslant N_{m}} \beta_{n} \mathbf{e}_{q^{\gamma}}\left(z g^{m n}\right)
$$

Furthermore

$$
\begin{aligned}
\sum_{Z<m \leqslant Y} \alpha_{m} & \sum_{K_{m} \leqslant n \leqslant N_{m}} \beta_{n} \mathbf{e}_{q^{\gamma}}\left(z g^{m n}\right) \\
& =\sum_{\log Z-1 \leqslant j \leqslant \log Y} \sum_{e^{j}<m \leqslant e^{j+1}} \sum_{K_{m} \leqslant n \leqslant N_{m}} \alpha_{m} \beta_{n} \mathbf{e}_{q^{\gamma}}\left(z g^{m n}\right)
\end{aligned}
$$

and we have set $\alpha_{m}=0$ if $m \leqslant Z$ or $m \geqslant Y$. We observe that for each $j$ within the summation range, we have

$$
\frac{\log \left(e^{j+1}-e^{j}\right)}{\log q^{\gamma}} \geqslant \frac{\log (Z-1)}{\log q^{\gamma}} \geqslant \frac{\zeta}{2}
$$

where $\zeta$ is given by (2.39). Hence

$$
\begin{aligned}
& \sum_{e^{j}<m \leqslant e^{j+1}} \sum_{K_{m} \leqslant n \leqslant N_{m}} \alpha_{m} \beta_{n} \mathbf{e}_{q^{\gamma}}\left(z g^{m n}\right) \\
& \ll\left(\frac{X}{e^{j}} e^{j\left(1-c \zeta^{2} / 4\right)}+e^{j}\left(\frac{X}{e^{j}}\right)^{1 / 2}\right)(\log X)^{2} \\
&+\left(1+\frac{2^{j}}{q^{2 \gamma / 65}}\right) \frac{X}{2^{j}} q^{8 G} \log N
\end{aligned}
$$

by Lemma 2.9 and the result follows after renaming $c$, summing the above over $j$ satisfying $\log Z-1 \leqslant j \leqslant \log Y$ and using the estimates

$$
\sum_{\log Z \leqslant j \leqslant \log Y} e^{-\alpha j} \ll Z^{-\alpha} \quad \text { and } \quad \sum_{\log Z \leqslant j \leqslant \log Y} e^{j \alpha} \ll Y^{\alpha}
$$

provided $\alpha>0$ is bounded away from 0 .
2.8. Bounds on single exponential sums. Combining Proposition 2.7 with Lemma 2.6 allows us to estimate sums over an interval which has previously been considered by Korobov [12, Theorem 4]. We present a proof for completeness.

Lemma 2.11. With notation as in (2.2) and Proposition 2.7 suppose $M$ satisfies

$$
M \leqslant q^{2 \gamma / 65}
$$

Then we have

$$
\sum_{m=K+1}^{K+M} \mathbf{e}_{q^{\gamma}}\left(z g^{m}\right) \ll M^{1-10^{-11} \rho^{2}}(\log M)^{2}+M^{10^{-10} \rho^{2}} q^{8 G} \log M
$$

where

$$
\rho=\frac{\log M}{\log q^{\gamma}} .
$$

Proof. Let

$$
S=\sum_{m=K+1}^{K+M} \mathbf{e}_{q^{\gamma}}\left(z g^{m}\right)
$$

and apply Lemma 2.6 with

$$
U=M^{1-10^{-10} \rho^{2}}, \quad V=M^{10^{-10} \rho^{2}}
$$

to get

$$
S \ll \frac{\log N}{M} \sum_{m=K+1}^{K+M} \sum_{u \leqslant U}\left|\sum_{v \leqslant V} \mathbf{e}(\alpha v) \mathbf{e}_{q^{\gamma}}\left(z g^{m} g^{u v}\right)\right| .
$$

Taking a maximum over $m$ in the above, we get

$$
S \ll \log M \sum_{u \leqslant U} \sum_{v \leqslant V} \alpha(u) \beta(v) \mathbf{e}_{q^{\gamma}}\left(z_{0} g^{u v}\right),
$$

for some $\operatorname{gcd}\left(z_{0}, p\right)=1$ and complex numbers $\alpha, \beta$ satisfying

$$
|\alpha(u)|,|\beta(v)| \leqslant 1
$$

With

$$
\rho_{0}=\frac{\log U}{\log q^{\gamma}},
$$

we have

$$
\rho_{0}=\rho\left(1-10^{-10} \rho^{2}\right),
$$

hence by Proposition 2.7

$$
\begin{aligned}
S & \ll(\log M)^{2}\left(V\left(U^{1-10^{-10} \rho_{0}^{2}}+q^{8 G}\right)+U^{1 / 2} V^{1 / 2}\right) \\
& \ll(\log M)^{2} M\left(M^{-10^{-10} \rho^{2}\left(1-10^{-10} \rho^{2}\right)^{2}}+M^{-\frac{1}{2}-\frac{1}{2} 10^{-10} \rho^{2}}\right) .
\end{aligned}
$$

Note the assumption

$$
M \leqslant q^{2 \gamma / 65}
$$

implies that

$$
\rho \leqslant \frac{2}{65}
$$

and hence

$$
\left(1-10^{-10} \rho^{2}\right)^{2} \geqslant\left(1-10^{-10}\left(\frac{2}{65}\right)^{2}\right)^{2} \geqslant \frac{1}{10}
$$

which completes the proof.
Partitioning the summation into small intervals as in the proof of Corollary 2.8 allows us again to remove the restriction $M \leqslant q^{2 \gamma / 65}$ in Lemma 2.11.

Corollary 2.12. With notation as in (2.2) and Proposition 2.7 suppose $M$ satisfies

$$
M \leqslant q^{A \gamma}
$$

Then we have

$$
\sum_{m=K+1}^{K+M} \mathbf{e}_{q^{\gamma}}\left(z g^{m}\right) \ll M^{1-c \rho^{2}} \log M+M^{1-c} q^{8 G}
$$

where

$$
\rho=\frac{\log M}{\log q^{\gamma}}
$$

and $c>0$ is a constant depending only $A$.
Proof. Arguing as in the proof of Corollary 2.8, we may partition the summation over $m$ into intervals of length at most $q^{2 \gamma / 65}$ and apply Lemma 2.11 to each of these intervals. This produces a bound of the form

$$
\begin{equation*}
\sum_{m=K+1}^{K+M} \mathbf{e}_{q^{\gamma}}\left(z g^{m}\right) \ll M^{1-c \rho^{2}}(\log M)^{2}+M^{1-c} q^{8 G} \log M \tag{2.40}
\end{equation*}
$$

for a constant $c$ depending on $A$. Unless we have $M^{c \rho^{2}} \geqslant(\log M)^{2}$ the estimate (2.40) is trivial. Under this condition we have

$$
M^{-c \rho^{2}}(\log M)^{2} \leqslant \sqrt{M^{-c \rho^{2}}(\log M)^{2}}
$$

which allows us to replace $(\log M)^{2}$ with $\log M$ after changing the constant $c>0$. Reducing $c$ if necessary, we can also discard $\log M$ in the second term.

## 3. Proofs of Main Results

### 3.1. Proof of Theorem 1.1. We apply Lemma 2.1 with

$$
\begin{equation*}
U=X^{1 / 4}, \quad V=X^{1 / 4} \tag{3.1}
\end{equation*}
$$

to get

$$
\begin{equation*}
S_{q^{\gamma}}(a ; X) \ll X^{1 / 4}+\Sigma_{1}(\log X)+\Sigma_{2}^{1 / 2} X^{1 / 2}(\log X)^{3}, \tag{3.2}
\end{equation*}
$$

where

$$
\Sigma_{1}=\sum_{t \leqslant U V} \max _{w \leqslant X / t}\left|\sum_{w \leqslant m \leqslant X / t} \mathbf{e}_{q^{\gamma}}\left(a g^{t m}\right)\right|,
$$

and

$$
\Sigma_{2}=\max _{U \leqslant w \leqslant X / V} \max _{V \leqslant j \leqslant X / w} \sum_{V<m \leqslant X / w}\left|\sum_{\substack{w<n \leqslant 2 w \\ n \leqslant X / m \\ n \leqslant X / j}} \alpha_{n} \mathbf{e}_{q^{\gamma}}\left(a g^{m n}\right)\right|,
$$

for some $\left|\alpha_{n}\right| \leqslant 1$. Considering $\Sigma_{1}$, for each fixed $t \leqslant U V=X^{1 / 2}$, define

$$
G_{t}=\nu_{q}\left(g^{t \operatorname{ord}_{q}\left(g^{t}\right)}-1\right)
$$

and

$$
\rho_{t}=\frac{\log (X / t)}{\log q^{\gamma}} .
$$

By (3.1) and $t \leqslant U V=X^{1 / 2}$ we have

$$
\begin{equation*}
\rho_{t} \geqslant \frac{\rho}{2} . \tag{3.3}
\end{equation*}
$$

We claim, that the following inequality holds

$$
\begin{align*}
& \max _{w \leqslant X / t}\left|\sum_{w \leqslant m \leqslant X / t} \mathbf{e}_{q^{\gamma}}\left(a g^{t m}\right)\right|  \tag{3.4}\\
& \\
& \ll\left(\frac{X}{t}\right)^{1-c \rho_{t}^{2}} \log X+\left(\frac{X}{t}\right)^{1-c} q^{8 G_{t}}
\end{align*}
$$

Indeed, if $\gamma>16 G_{t}$ it follows from Corollary 2.12.
If $\gamma \leqslant 16 G_{t}$ then

$$
\left(\frac{X}{t}\right)^{1-c} q^{8 G_{t}} \geqslant\left(\frac{X}{t}\right)^{1-c} q^{\gamma / 2} \geqslant\left(\frac{X}{t}\right)
$$

so (3.4) is trivially true as well since

$$
\begin{equation*}
\max _{w \leqslant X / t}\left|\sum_{w \leqslant m \leqslant X / t} \mathbf{e}_{q^{\gamma}}\left(a g^{t m}\right)\right| \ll \frac{X}{t}, \tag{3.5}
\end{equation*}
$$

which proves (3.4).
Summing (3.4) over $t \leqslant U V$ and using (3.4), (3.3) and (3.5) gives

$$
\begin{equation*}
\Sigma_{1} \ll \sum_{t \leqslant X^{1 / 2}}\left(\frac{X}{t}\right)^{1-c \rho_{t}^{2}} \log X+\widetilde{\Sigma}_{1} \tag{3.6}
\end{equation*}
$$

where

$$
\widetilde{\Sigma}_{1}=\sum_{t \leqslant X^{1 / 2}} \min \left\{\frac{X}{t},\left(\frac{X}{t}\right)^{1-c} q^{8 G_{t}}\right\}
$$

For $t \leqslant X^{1 / 2}$ we have $(X / t)^{1-c \rho_{t}^{2} / 4} \leqslant X^{1-c \rho^{2} / 8} t^{-1}$, thus

$$
\sum_{t \leqslant X^{1 / 2}}\left(\frac{X}{t}\right)^{1-c \rho_{t}^{2}} \leqslant \sum_{t \leqslant X^{1 / 2}}\left(\frac{X}{t}\right)^{1-c \rho^{2} / 4} \ll X^{1-c \rho^{2} / 8} \log X .
$$

This, together with (3.6), implies

$$
\begin{equation*}
\Sigma_{1} \ll X^{1-c \rho^{2} / 8} \log X+\widetilde{\Sigma}_{1} \tag{3.7}
\end{equation*}
$$

Considering $\widetilde{\Sigma}_{1}$, we partition summation over $t$ into dyadic intervals to obtain

$$
\begin{aligned}
\widetilde{\Sigma}_{1} & \ll \sum_{k \leqslant \frac{\log X}{2 \log 2}} \sum_{2^{k} \leqslant t<2^{k+1}} \min \left\{\frac{X}{t},\left(\frac{X}{t}\right)^{1-c} q^{8 G_{t}}\right\} \\
& \ll \sum_{k \leqslant \frac{\log X}{2 \log 2}} \sum_{2^{k} \leqslant t<2^{k+1}} \min \left\{\frac{X}{2^{k}},\left(\frac{X}{2^{k}}\right)^{1-c} q^{8 G_{t}}\right\} .
\end{aligned}
$$

Let $k_{0}$ be such an index with $k_{0} \leqslant(\log X) /(2 \log 2)$ that the maximum of the inner sums over $t$ is attained and write

$$
Z=\frac{X}{2^{k_{0}}} .
$$

Then

$$
X^{1 / 2} \leqslant Z \leqslant X
$$

and

$$
\widetilde{\Sigma}_{1} \ll(\log X) \sum_{X / Z \leqslant t \leqslant 2 X / Z} \min \left\{Z, Z^{1-c} q^{8 G_{t}}\right\}
$$

Recalling the definition of $G$, given by (2.2), we see that

$$
\operatorname{ord}_{q}\left(g^{t}\right)=\frac{\tau}{\operatorname{gcd}(\tau, t)},
$$

and by Lemma 2.3, used with $m=1, x=\tau t / \operatorname{gcd}(\tau, t)$ and $y=0$,

$$
G_{t}=\nu_{q}\left(g^{\tau t / \operatorname{gcd}(\tau, t)}-1\right)=G+\nu_{q}(t) .
$$

As $g$ and $q$ are fixed, $G=O(1)$ and hence

$$
\widetilde{\Sigma}_{1} \ll \log X \sum_{X / Z \leqslant t \leqslant 2 X / Z} \min \left\{Z, Z^{1-c} q^{8 \nu_{q}(t)}\right\} .
$$

For $O\left(X Z^{-1-c / 9}\right)$ values of $t \leqslant 2 X / Z$ with $q^{\nu_{q}(t)}>Z^{c / 9}$ we use

$$
\min \left\{Z, Z^{1-c} q^{8 \nu_{q}(t)}\right\} \leqslant Z
$$

Their total contribution is $O\left(X Z^{-c / 9}\right)$. For the remaining values of $t$ we

$$
\min \left\{Z, Z^{1-c} q^{8 \nu_{q}(t)}\right\} \leqslant Z^{1-c+8 c / 9}=Z^{1-c / 9}
$$

which gives the same total contribution $O\left(X Z^{-c / 9}\right)$. Hence, recalling $Z \geqslant X^{1 / 2}$, we obtain

$$
\widetilde{\Sigma}_{1} \ll X Z^{-c / 9} \log X \leqslant X^{1-c / 18} \log X .
$$

Using the above in (3.7) gives

$$
\begin{equation*}
\Sigma_{1} \ll X^{1-c \rho^{2} / 8} \log X+X^{1-c / 18} \log X \ll X^{1-\delta(A) \rho^{2}}(\log X)^{2} \tag{3.8}
\end{equation*}
$$

for some constant $\delta(A)>0$ that depends only on $A$.
To estimate $\Sigma_{2}$ we apply Lemma 2.10 to get

$$
\Sigma_{2} \ll\left(X^{1-\delta(A) \rho^{2}}+X^{7 / 8}+\frac{X}{q^{2 \gamma / 65}}\right)(\log X)^{2}
$$

for a suitably reduced $\delta(A)$ if necessary. By the above bounds (3.2) and (3.8)

$$
S_{q^{\gamma}}(a ; X) \ll X^{1-\delta(A) \rho^{2}}(\log X)^{3}+\frac{X}{q^{2 \gamma / 65}}(\log X)^{4}
$$

Now, using the same argument as in the proof of Corollary 2.12, and reducing $\delta(A)$ if necessary, we see that we can replace $(\log X)^{3}$ with $\log X$ (or any other power of $\log X$ ) in the first term, and also discard completely $(\log X)^{4}$ in the second term.
3.2. Proof of Theorem 1.3. We observe that the property of having $\sigma$ on positions $r, \ldots, r-s+1$ of $M_{p}$ is equivalent to the property of the fractional part of $M_{p} / q^{r+1}$ falling in a prescribed half-open interval of length $1 / q^{s}$, namely, to

$$
\begin{equation*}
\left\{\frac{M_{p}}{q^{r+1}}\right\} \in\left[\frac{\bar{\sigma}}{q^{s}}, \frac{\bar{\sigma}+1}{q^{s}}\right) \tag{3.9}
\end{equation*}
$$

(we recall that the numbering starts from zero) where

$$
\bar{\sigma}=\sum_{i=0}^{s-1} a_{i} q^{i}
$$

is the integer which $q$-ary digits are given by $\sigma$. We now combine the bound of Corollary 1.2 with the Erdős-Turán inequality (see [7, Theorem 1.21]), which gives a bound of the discrepancy via exponential sums, and conclude that for any integer parameter $H \geqslant 1$

$$
A_{r}(X, \sigma)-q^{-s} \pi(X) \ll \pi(X) H^{-1}+\sum_{h=1}^{H} \frac{1}{h}\left|\sum_{\substack{p \leqslant X \\ p \text { prime }}} \mathbf{e}_{q^{r+1}}\left(h M_{p}\right)\right|
$$

We now set

$$
H=\left\lfloor X^{\varepsilon / 2}\right\rfloor .
$$

Below we use very crude bounds, many of them can be done in a more refined way, however this does not improve the final result.

Namely, for any positive integer $h \leqslant H$, writing

$$
q^{\gamma}=\frac{q^{r+1}}{\operatorname{gcd}\left(h, q^{r+1}\right)}
$$

since $r \geqslant \varepsilon \log X$, we see that

$$
\begin{equation*}
q^{\gamma} \geqslant q^{r+1} / H \geqslant e^{r} / H \geqslant X^{\varepsilon / 2} . \tag{3.10}
\end{equation*}
$$

We now use Corollary 1.2 with $A=2 / \varepsilon$ and note by (3.10) the condition (1.2) is satisfied. This implies that (3.9) happens for

$$
\begin{align*}
A_{r}(X, \sigma)=q^{-s} & \pi(X) \\
& +O\left(X^{1-\varepsilon / 2}+X^{1-c \varrho^{2}} \log X+X q^{-c r} \log X\right) \tag{3.11}
\end{align*}
$$

primes $p \leqslant X$, where

$$
\varrho=\frac{\log X}{\log q^{r+1}} .
$$

and $c>0$ is some constant that depends on $\varepsilon$ and $q$.
Using that $r \leqslant(\log X)^{3 / 2-\varepsilon}$ we obtain $\varrho \geqslant(\log X)^{-1 / 2+\varepsilon / 2}$. Thus

$$
X^{1-c \varrho^{2}} \log X \leqslant X \exp \left(-c(\log X)^{\varepsilon}\right) \log X
$$

We also have

$$
X q^{-c r} \leqslant X^{1-c \varepsilon}
$$

and then (3.11) implies

$$
A_{r}(X, \sigma)=q^{-s} \pi(X)+O\left(X \exp \left(-0.5 c(\log X)^{\varepsilon}\right)\right)
$$

which concludes the proof.
