# DOUBLING NODAL SOLUTIONS TO THE YAMABE EQUATION IN $\mathbb{R}^{n}$ WITH MAXIMAL RANK

Abstract. We construct a new family of entire solutions to the Yamabe equation

$$
-\Delta u=\frac{n(n-2)}{4}|u|^{\frac{4}{n-2}} u \text { in } \mathcal{D}^{1,2}\left(\mathbb{R}^{n}\right)
$$

If $n=3$ our solutions have maximal rank, being the first example in odd dimension. Our construction has analogies with the doubling of the equatorial spheres in the construction of minimal surfaces in $S^{3}(1)$.

## 1. Introduction

Consider the problem

$$
\begin{equation*}
-\Delta u=\gamma|u|^{p-1} u \text { in } \mathbb{R}^{n}, \quad \gamma:=\frac{n(n-2)}{4}, \quad u \in \mathcal{D}^{1,2}\left(\mathbb{R}^{n}\right), \tag{1.1}
\end{equation*}
$$

where $n \geqslant 3, p:=\frac{n+2}{n-2}$ and $\mathcal{D}^{1,2}\left(\mathbb{R}^{n}\right)$ is the completion of $C_{0}^{\infty}\left(\mathbb{R}^{n}\right)$ with the norm $\|\nabla u\|_{L^{2}\left(\mathbb{R}^{n}\right)}$. Problem (1.1) corresponds to the steady state of the energy-critical focusing nonlinear wave equation

$$
\partial_{t}^{2} u-\Delta u-|u|^{\frac{4}{n-2}} u=0,(t, x) \in \mathbb{R} \times \mathbb{R}^{n}
$$

whose study (see for instance [4, 6, 7, [14, [15) naturally relies on the complete classification of the set of non-zero finite energy solutions to (1.1), which is defined by

\Sigma:=\left\{Q \in \mathcal{D}^{1,2}\left(\mathbb{R}^{n}\right) \backslash\{0\}:-\Delta Q=\frac{n(n-2)}{4}|Q|^{\frac{4}{n-2}} Q\right\},
$$

in particular in connection with the soliton resolution conjecture for which only a few examples have become known [13, 14, 5, 6, 7, Observe that (1.1) is the Euler-Lagrange equation of the functional defined by

\mathbf{e}(u):=\frac{1}{2} \int_{\mathbb{R}^{n}}|\nabla u|^{2} d x-\frac{\gamma(n-2)}{2 n} \int_{\mathbb{R}^{n}}|u|^{\frac{2 n}{n-2}} d x . \tag{1.2}
\end{equation*}
$$

Positive solutions to (1.1) solve the Yamabe problem on the sphere (after a stereographic projection) and are the extremal functions for the Sobolev embedding. Thanks to the classical work

[^0]of Caffarelli-Gidas-Spruck [2], it is known that all positive solutions to (1.1) are given by the so called bubble and all its possible translations and dilations, that is,

\end{equation*}

\]

previously discovered independently by Aubin [1] and Talenti [19]. In fact, all radial solutions in $\Sigma$ have the form (1.3). Sign-changing solutions belonging to $\Sigma$ have thus to be non radial. Using the classical theory of Ljusternik-Schnirelman category, Ding proved in [3] the existence of infinitely many elements in $\Sigma$ that are non radial, sign-changing, and with arbitrary large energy. The key idea in [3] is to look for solutions to (1.1) that are invariant under the action of $O(2) \times O(n-2) \subset O(n)$ to recover compactness for the functional $\mathbf{e}(u)$. No further information though is known on the solutions found by Ding. Recently, more explicit constructions for signchanging (non radial) solutions to (1.1) have been obtained by del Pino-Musso-Pacard-Pistoia and Medina-Musso-Wei (see [8, 9, 16). The solutions obtained in [8] are invariant under the action of $D_{k} \times O(n-2)$, where $D_{k}$ is the dihedral group of rotations and reflections leaving a regular polygon with $k$ sides invariant. More precisely, for any $k$ large enough, the authors construct a solution to (1.1) looking like the bubble $U$ in (1.3) surrounded by $k$ negative scaled copies of $U$ arranged along the vertices of a $k$-regular polygon in $\mathbb{R}^{2}$. At main order the solution looks like

U(y)-\sum_{j=1}^{k} \lambda^{-\frac{n-2}{2}} U\left(\lambda^{-1}\left(y-\xi_{j}\right)\right) \tag{1.4}
\end{equation*}
$$

where $\xi_{j}:=\left(e^{\frac{2 \pi(j-1) i}{k}}, 0, \ldots\right), \lambda=O\left(k^{-2}\right)$ if $n \geqslant 4$ and $\lambda=O\left((k \ln k)^{-2}\right)$ if $n=3$, as $k \rightarrow \infty$. Observe that

$$
\sum_{j=1}^{k} \lambda^{-\frac{n-2}{2}} U\left(\lambda^{-1}\left(y-\xi_{j}\right)\right) \rightharpoonup c_{n} \delta_{\Gamma}, \quad \text { as } \quad k \rightarrow \infty
$$

for a positive constant $c_{n}$, where $\delta_{\Gamma}$ is the Dirac-delta at the equatorial on the $\left(y_{1}, y_{2}\right)$-plane $\Gamma=\left\{y \in \mathbb{R}^{n}: y_{1}^{2}+y_{2}^{2}=1\right\}$ in $S^{n}(1)$. We thus can think of the solutions obtained in [8] and described at main order in (1.4) as the sum of a positive fixed central bubble surrounded by a negative smooth function that desingularizes a Dirac-delta along the equatorial $\Gamma$, in the limit as $k \rightarrow \infty$. We call this construction a desingularization of the equatorial, in analogy with similar desingularization constructions for minimal surfaces in Riemannian three-manifolds [10. We remark that these solutions are not invariant under the action of $O(2) \times O(n-2)$, thus they differ from the ones found by Ding. Besides, these solutions are the first example of non degenerate sign-changing solutions to (1.1) as shown in [17]. For any $Q \in \Sigma$, consider the linear operator $L_{Q}:=-\Delta-\gamma p|Q|^{p-1}$ and define the null space

z_{Q}:=\left\{f \in \mathcal{D}^{1,2}\left(\mathbb{R}^{n}\right): f \neq 0, L_{Q}(f)=0\right\} .
$$

Duyckaerts-Kenig-Merle [5] introduced the following definition of non-degeneracy for a solution of problem (1.1): $Q \in \Sigma$ is said to be non degenerate if $z_{Q}$ coincides with the vector space generated by the elements in $z_{Q}$ related to the group of isometries in $\mathcal{D}^{1,2}\left(\mathbb{R}^{n}\right)$ under which problem (1.1) is invariant, given by translations, scalings, rotations and Kelvin transformation. More precisely, $Q$ is non degenerate if

z_{Q}=\tilde{z}_{Q},
$$

where

$$
\tilde{z}_{Q}:=\operatorname{span}\left\{\begin{array}{ll}
(2-n) x_{j} Q+|x|^{2} \partial_{x_{j}} Q-2 x_{j} x \cdot \nabla Q, \quad \partial_{x_{j}} Q, \quad 1 \leqslant j \leqslant n, \\
\left(x_{j} \partial_{x_{k}}-x_{k} \partial_{x_{j}}\right) Q, \quad 1 \leqslant j<k \leqslant n, \quad \frac{n-2}{2} Q+x \cdot Q
\end{array}\right\} .

The rank of a solution $Q \in \Sigma$ is the dimension of the vector space $\tilde{z}_{Q}$, and it cannot exceed the number

$$
\mathcal{N}:=2 n+1+\frac{n(n-1)}{2},
$$

being this the largest possible dimension for $\tilde{z}_{Q}$. It is well known for instance that $U$ in (1.3) is non degenerate and its rank is $n+1$ (see [18]). In [17] it is proven that the solutions built in [8], looking at main order as in (1.4), are non degenerate and their rank is $3 n$.

A question we address in [16] is about the existence of solutions $Q \in \Sigma$ to (1.1) whose rank is maximal. In fact, observe that not the bubbles in (1.3) nor the solutions built in [8] have maximal rank. We partially answer this question building a new family of solutions to (1.1), where another polygon with a large number of sides is replicated for $n \geqslant 4$ in the third and fourth coordinates, giving rise to a new family of non degenerate solutions to (1.1) that at main order look like

U(y)-\sum_{j=1}^{k} \lambda^{-\frac{n-2}{2}} U\left(\lambda^{-1}\left(y-\bar{\xi}_{j}\right)\right)-\sum_{j=1}^{h} \mu^{-\frac{n-2}{2}} U\left(\mu^{-1}\left(y-\underline{\xi}_{j}\right)\right), \tag{1.5}
\end{equation*}
$$

where $\bar{\xi}_{j}:=\left(e^{\frac{2 \pi(j-1) i}{k}}, 0, \ldots\right), \underline{\xi}_{j}:=\left(0,0, e^{\frac{2 \pi(j-1) i}{h}}, 0, \ldots\right), \lambda=O\left(k^{-2}\right)$ and $\mu=O\left(h^{-2}\right)$, for $k$ and $h$ sufficiently large, see [16]. Using the terminology we introduced before, this construction is a desingularization of the two equators, one in the $\left(y_{1}, y_{2}\right)$-plane and the other in the $\left(y_{3}, y_{4}\right)$-plane. These solutions are non degenerate. Furthermore, their rank is $5(n-1)$, which is maximal when $n=4$. A generalization of this result is to consider non degenerate solutions obtained by gluing a central positive bubble with negative scaled copies of $U$ centered at the vertices of $\ell$ regular polygons with a large number of sides and lying in consecutive planes, which have maximal rank provided the dimension $n$ is $2 \ell$. In other words, a desingularization of $\ell$ equators in consecutive planes would provide an example of non degenerate solutions with maximal rank in any even dimension $2 \ell$. If the dimension $n$ is odd, the existence of non degenerate solutions for (1.1) with maximal rank remains an open problem and a different construction is required.

Roughly speaking, the solution built in [16] breaks the radial behavior of the bubble in the first four coordinates, loosing the related invariances. This fact adds extra terms in the kernel of the linearized operator, being all the possible precisely when $n=4$. Thus, to prove the analogue in odd dimension one needs to find a solution breaking the radiality in an odd number of coordinates.

The aim of this work is to address this question and to provide a new family of sign-changing solutions for problem (1.1) that we claim to have maximal rank in dimension $n=3$. We prove the following result.

Theorem 1.1. Let $n \geqslant 3$ and let $k$ be a positive integer. Then for any sufficiently large $k$ there is a finite energy solution to (1.1) of the form

u(y)=U(y)-\sum_{j=1}^{k} \lambda^{-\frac{n-2}{2}} U\left(\lambda^{-1}\left(y-\bar{\xi}_{j}\right)\right)-\sum_{j=1}^{k} \lambda^{-\frac{n-2}{2}} U\left(\lambda^{-1}\left(y-\underline{\xi}_{j}\right)\right)+o_{k}(1)\left(1+\lambda^{-\frac{n-2}{2}}\right),
$$

where

$$
\bar{\xi}_{j}:=R\left(\sqrt{1-\tau^{2}} e^{\frac{2 \pi(j-1)}{k} i}, \tau, 0, \ldots\right), \quad \underline{\xi}_{j}:=R\left(\sqrt{1-\tau^{2}} e^{\frac{2 \pi(j-1)}{k} i},-\tau, 0, \ldots\right), \quad j=1, \ldots, k,
$$

and

$$
\lambda:=\frac{\ell^{\frac{2}{n-2}}}{k^{2}}, \tau:=\frac{t}{k^{1-\frac{2}{n-1}}}, \text { if } n \geqslant 4, \quad \lambda:=\frac{\ell^{2}}{k^{2}(\ln k)^{2}}, \tau:=\frac{t}{\sqrt{\ln k}}, \text { if } n=3 .
$$

Here

$$
\lambda^{2}+R^{2}=1, \quad \text { and } \quad \eta<\ell, t<\eta^{-1},
$$

for some positive fixed number $\eta$ independent of $k$. The term $o_{k}(1) \rightarrow 0$ uniformly on compact sets of $\mathbb{R}^{n}$ as $k \rightarrow \infty$.

These solutions have maximal rank in dimension 3.
Some remarks are in order.
Remark 1.2. Let us briefly discuss our construction. The solution predicted by Theorem 1.1 looks at main order as

$$
u_{0}(y):=U(y)-\sum_{j=1}^{k} \lambda^{-\frac{n-2}{2}} U\left(\lambda^{-1}\left(y-\bar{\xi}_{j}\right)\right)-\sum_{j=1}^{k} \lambda^{-\frac{n-2}{2}} U\left(\lambda^{-1}\left(y-\underline{\xi}_{j}\right)\right) .
$$

The polygonal distribution of the points $\bar{\xi}_{1}, \ldots, \bar{\xi}_{k}$ and $\underline{\xi}_{1}, \ldots \underline{\xi}_{k}$ makes $u_{0}$ a function with several important symmetries: it is invariant under rotation of angle $\frac{2 \pi}{k}$ in the ( $y_{1}, y_{2}$ )-plane, and even in the other variables $y_{j}, j=3, \ldots, n$. The assumption that $\lambda^{2}+R^{2}=1$ gives that $u_{0}$ is also invariant under Kelvin transformation. We will take great advantage of these symmetries in many different ways in our proof. For instance they allow us to choose the same scaling factor $\lambda$ for each one of the negative bubbles centred at the different points $\bar{\xi}_{j}$ and $\underline{\xi}_{j}, j=1, \ldots, k$, which in principle may not be the same, reducing substantially the number of scaling parameters to adjust. Taking $\lambda$ and $\tau$ small positive parameters as $k \rightarrow \infty$, a formal computation shows that the energy functional defined in (1.2) and evaluated at $u=u_{0}$ has the following expansion, as $k \rightarrow \infty$,

\mathbf{e}\left(u_{0}\right) \sim(2 k+1) a_{n}+k\left(\lambda^{\frac{n-2}{2}}\left(b_{n}-c_{n} \tau^{2}\right)-d_{n} \lambda^{n-2} k^{n-2}-e_{n} \frac{\lambda^{n-2}}{\tau^{n-3}}\right),
$$

when dimension $n \geqslant 4$, for some explicit positive constants $a_{n}, b_{n}, c_{n}, d_{n}$ and $e_{n}$. Our choice for $\lambda$ and $\tau$ in terms of $k$ is to get at main order the balance

$$
\nabla_{\lambda, \tau} \mathbf{e}\left(u_{0}\right) \sim 0
$$

We will justify this heuristic argument in Section 2.
Remark 1.3. The construction obtained in Theorem 1.1 differs from the desingularization of the equatorial in (1.4) obtained in [8] or of two equators in (1.5) in [16]. In fact the solutions in Theorem 1.1 can be thought as the sum of a positive fixed central bubble surrounded by a negative smooth function that desingularizes Dirac-deltas located in points on two circles that are collapsing into a Dirac-delta supported along the equatorial $\Gamma$, in the limit as $k \rightarrow \infty$. We call this construction a doubling of the equatorial in the ( $y_{1}, y_{2}$ )-plane, in analogy with similar doubling constructions for minimal surfaces in Riemannian three-manifolds obtained in [10, 11, 12].

Remark 1.4. Let $u$ be the solution predicted in Theorem 1.1 and define the following $4 n-2$ functions

\begin{aligned}
& z_{0}(y):= \frac{n-2}{2} u(y)+\nabla u(y) \cdot y, \quad z_{\alpha}(y):=\frac{\partial}{\partial y_{\alpha}} u(y), \alpha=1, \ldots, n, \\
& z_{n+1}(y):=-2 y_{1} z_{0}(y)+|y|^{2} z_{1}(y), \quad z_{n+2}(y):=-2 y_{2} z_{0}(y)+|y|^{2} z_{2}(y), \\
& z_{n+3}(y):=-2 y_{3} z_{0}(y)+|y|^{2} z_{3}(y), \\
& z_{n+\alpha+2}(y):=-y_{\alpha} z_{1}(y)+y_{1} z_{\alpha}(y), \alpha=2, \ldots, n, \\
& z_{2 n+\alpha}(y):=-y_{\alpha} z_{2}(y)+y_{2} z_{\alpha}(y), \alpha=3, \ldots, n, \\
& z_{3 n+\alpha-3}(y):=-y_{\alpha} z_{3}(y)+y_{3} z_{\alpha}(y), \alpha=4, \ldots, n .
\end{aligned}
$$

These functions belong to $\mathcal{D}^{1,2}\left(\mathbb{R}^{n}\right)$ and also to the kernel of $L_{u}:=-\Delta-\gamma p|u|^{p-1}$. Furthermore, if $k$ is even they are linearly independent (see Appendix B). Consider now the case $n=3$ : we have that $4 n-2=\mathcal{N}=10$. Thus the solutions constructed in Theorem 1.1 have maximal rank in dimension 3 when $k$ is even. The non-degeneracy of the solution remains an open problem.
Remark 1.5. The doubling of the equatorial in $\mathbb{R}^{3}$ presumably closes the question about solutions with maximal rank. Indeed, for any odd dimension we could combine a doubling of the equatorial in three coordinates with a desingularization of the equatorial as in [8 in two coordinates or a desingularization of two equators as in [16] in four coordinates, as many times as needed. We conjecture that combining these three structures we can build a maximal solution in any odd dimension.

Remark 1.6. This doubling construction also provides an alternative example of solution with maximal rank for even dimensions of the form $n=6 \ell, \ell \in \mathbb{N}$. For these dimensions, in [16] the authors propose to replicate $3 \ell$ times the desingularization of $[8$. We conjecture that combining $2 \ell$ structures like the doubling of the equatorial of Theorem [1.1] would provide a different solution with maximal rank in these dimensions.

Remark 1.7. The construction described in Theorem 1.1 is not the only possible way to double the equatorial $\Gamma$. For any even integer $2 m$, we can construct another sequence of solutions that doubles the equatorial in the form of the sum of a positive fixed central bubble surrounded by a negative smooth function that desingularizes Dirac-deltas located in points on $2 m$ circles that are collapsing into a Dirac-delta supported along the equatorial $\Gamma$, in the limit as $k \rightarrow \infty$, where $m$ of these circles collapse onto $\Gamma$ from above and $m$ from below.

We can also combine desingularization of the equatorial and doubling of the equatorial. For any odd integer $2 m+1$, we can construct a sequence of solutions with the form of the sum of a positive fixed central bubble surrounded by a negative smooth function that consists of two parts. One part desingularizes Dirac-deltas located in points on $2 m$ circles that are collapsing into a Dirac-delta supported along the equatorial $\Gamma$, in the limit as $k \rightarrow \infty$. The other part desingularizes Dirac-deltas located at points along the equatorial, desingularizing a Dirac-delta along the equatorial $\Gamma$, in the limit as $k \rightarrow \infty$.

Since the proofs of these constructions are in the same spirit as the one of Theorem 1.1, we will briefly describe them in section 6, explaining the principal differences.

The proof of Theorem 1.1 is based on a Lyapunov-Schmidt reduction in the spirit of [8]: we define a first approximation and we look for a solution in a nearby neighborhood, by linearizing around the approximation and, after developing an appropriate linear theory, solving by a fixed
point argument. This allows to reduce the original problem to the solvability of a finite dimensional one. However, for the construction in Theorem 1.1 this last step is rather delicate. In fact, the finite dimensional reduction leads to two equations (in the two parameters to adjust, $\lambda$ and $\tau$ ) where the sizes of the error and the non linear term play a fundamental role. If one follows the strategy of [8], the nonlinear term cannot be controlled and the reduced problem cannot be solved. For this reason, we need to carry on a much more refined argument.

The key point is the following: if one pays attention to the error term near the bubbles, this can be decomposed in a (relatively) large but symmetric part, and a smaller but non symmetric part (see Proposition 2.2). In the final argument (the reduction procedure) the symmetric part is orthogonal to the element of the kernel, and therefore not seen. Thus, the part playing a role in the reduction is the non symmetric one, that is significatively smaller. Roughly speaking, this allows to solve the linearized problem in two parts, a symmetric and large but irrelevant part, and a non symmetric but small one. Indeed, if our solution has the form $u_{*}+\phi$, being $u_{*}$ the approximation, we will split $\phi$ near each bubble as $\phi=\phi^{s}+\phi^{*}$, where $\phi^{s}$ is symmetric with respect to the hyperplane $y_{3}=\tau$ (or analogously $y_{3}=-\tau$ ). This behavior is also inherited by the nonlinear part of the equation and we will be able to perform the fixed point argument setting the size of $\phi^{*}$ very small (see Proposition 4.6), what will allow us to conclude the reduction. This new strategy requires delicate decompositions and estimates of every term of the equations, as well as the development of a sharp linear invertibility theory.

The structure of the article is the following. In section 2 we detail the approximation and the error associated, estimating it near and far from the bubbles in different norms, and identifying the symmetric and non symmetric parts and their sizes. Section 3 is devoted to the linear theory, where a refinement of the theory in [8] is developed. Section 4 is the core of the strategy, where the gluing scheme is performed, together with the precise decomposition of the function in their symmetric and non symmetric part. In section 5 we carry on the dimensional reduction, concluding the proof of Theorem 1.1. The appendix contains fundamental computations concerning the shape of the approximation.

## 2. Doubling construction: a first approximation

Let $n \geqslant 3$ and $\tau \in(0,1)$. In $\mathbb{R}^{n}$ we fix the following points

\bar{P}:=\left(\sqrt{1-\tau^{2}}, 0, \tau, 0, \ldots, 0\right), \quad \underline{P}:=\left(\sqrt{1-\tau^{2}}, 0,-\tau, 0, \ldots, 0\right) .
$$

Let $\lambda \in(0,1)$ be a positive number, and define $R$ as

$$
\begin{equation*}
\lambda^{2}+R^{2}=1 \tag{2.1}
\end{equation*}
$$

Let $k$ be an integer number and

$$
\begin{equation*}
\mathbf{u}[\lambda, \tau](y):=U(y)-\sum_{j=1}^{k} \underbrace{\lambda^{-\frac{n-2}{2}} U\left(\frac{y-\bar{\xi}_{j}}{\lambda}\right)}_{\bar{U}_{j}(y)}-\sum_{j=1}^{k} \underbrace{\lambda^{-\frac{n-2}{2} U\left(\frac{y-\underline{\xi}_{j}}{\lambda}\right)}}_{\underline{U}_{j}(y)} \tag{2.2}
\end{equation*}
$$

where

$$
\begin{align*}
& \bar{\xi}_{j}:=R\left(\sqrt{1-\tau^{2}} \cos \theta_{j}, \sqrt{1-\tau^{2}} \sin \theta_{j}, \tau, 0, \ldots, 0\right), \quad \text { with } \quad \theta_{j}:=2 \pi \frac{j-1}{k} .  \tag{2.3}\\
& \underline{\xi}_{j}:=R\left(\sqrt{1-\tau^{2}} \cos \theta_{j}, \sqrt{1-\tau^{2}} \sin \theta_{j},-\tau, 0, \ldots, 0\right),
\end{align*}
$$

Observe that $\bar{\xi}_{1}=R \bar{P}$ and $\underline{\xi}_{1}=R \underline{P}$, while $\bar{\xi}_{j}$ and $\underline{\xi}_{j}$ are obtained respectively from $\bar{P}$ and $\underline{P}$ after a rotation in the $\left(y_{1}, y_{2}\right)$-plane of angle $2 \pi \frac{j-1}{k}$. Thanks to (2.1), the functions $\bar{U}_{j}, \underline{U}_{j}$ are invariant under Kelvin transform, so that $\mathbf{u}$ is also invariant under this transformation, that is

$$
\begin{equation*}
\mathbf{u}(y)=|y|^{2-n} \mathbf{u}\left(\frac{y}{|y|^{2}}\right) . \tag{2.4}
\end{equation*}
$$

A direct observation reflects that $\mathbf{u}$ also shares the following symmetries

$$
\begin{gather*}
\mathbf{u}\left(y_{1}, \ldots,-y_{j}, \ldots, y_{n}\right)=\mathbf{u}\left(y_{1}, \ldots, y_{j}, \ldots, y_{n}\right), \quad j=2, \ldots, n,  \tag{2.5}\\
\mathbf{u}\left(e^{2 \pi \frac{(j-1)}{k} i} \bar{y}, y_{3}, \ldots, y_{n}\right)=\mathbf{u}\left(\bar{y}, y_{3}, \ldots, y_{n}\right), \quad \bar{y}=\left(y_{1}, y_{2}\right), \quad j=2, \ldots, k . \tag{2.6}
\end{gather*}
$$

In our construction, we assume that the integer $k$ is large and the parameters $\lambda$ and $\tau$ are given by

& \lambda:=\frac{\ell^{\frac{2}{n-2}}}{k^{2}}, \quad \tau:=\frac{t}{k^{1-\frac{2}{n-1}}}, \quad \text { if } \quad n \geqslant 4,  \tag{2.7}\\
& \lambda:=\frac{\ell^{2}}{k^{2}(\ln k)^{2}}, \quad \tau:=\frac{t}{\sqrt{\ln k}}, \quad \text { if } \quad n=3,
\end{align*}

for some $\eta$ small and fixed, independent of $k$, for any $k$ large enough. The error function, defined as

\end{equation*}

inherits the symmetries (2.5), (2.6). As a consequence, fixing a small $\delta>0$ independent of $k$, it is enough to describe the error function in the sets $B\left(\bar{\xi}_{1}, \frac{\delta}{k}\right)$ and $\mathbb{R}^{n} \backslash \bigcup_{j=1}^{k}\left(B\left(\bar{\xi}_{j}, \frac{\delta}{k}\right) \cup B\left(\underline{\xi}_{j}, \frac{\delta}{k}\right)\right)$ in order to know it in the whole space $\mathbb{R}^{n}$.

For our purpose it is convenient to measure the error using the following weighted $L^{q}$ norm

For the moment we request that $q$ is a fixed number with $\frac{n}{2}<q<n$. Later on, we will need a more restrictive assumption on $q, \frac{n}{2}<q<\frac{n}{2-\frac{2}{n-1}}$. We will evaluate the $\|\cdot\|_{* *}$-norm of $E$ in the interior regions $B\left(\bar{\xi}_{j}, \frac{\delta}{k}\right)$ and $B\left(\underline{\xi}_{j}, \frac{\delta}{k}\right)$, for any $j=1, \ldots, k$, and in the exterior region $\mathbb{R}^{n} \backslash \bigcup_{j=1}^{k}\left(B\left(\bar{\xi}_{j}, \frac{\delta}{k}\right) \cup B\left(\underline{\xi}_{j}, \frac{\delta}{k}\right)\right)$.

The error in the interior regions $B\left(\bar{\xi}_{j}, \frac{\delta}{k}\right)$ and $B\left(\underline{\xi}_{j}, \frac{\delta}{k}\right), j=1, \ldots, k$. To describe the error $E$ in each one of the balls $B\left(\bar{\xi}_{j}, \frac{\delta}{k}\right), B\left(\underline{\xi}_{j}, \frac{\delta}{k}\right)$, it is enough to do it in $B\left(\bar{\xi}_{1}, \frac{\delta}{k}\right)$, as already observed. In this region the dominant term of the function $\mathbf{u}$ in (2.2) is $\bar{U}_{1}$. Thus, for some $s \in(0,1)$, we have

for $x \in B\left(\bar{\xi}_{1}, \frac{\delta}{k}\right)$. Let us introduce the change of variable $\lambda y=x-\bar{\xi}_{1}$, so that $\bar{U}_{1}\left(\lambda y+\bar{\xi}_{1}\right)=$ $\lambda^{-\frac{n-2}{2}} U(y)$. In these expanded variables, the error takes the form

& +\lambda^{\frac{n+2}{2}}\left[\sum_{j \neq 1} \bar{U}_{j}^{p}\left(\lambda y+\bar{\xi}_{1}\right)+\sum_{j=1}^{k} \underline{U}_{j}^{p}\left(\lambda y+\bar{\xi}_{1}\right)-U^{p}\left(\lambda y+\bar{\xi}_{1}\right)\right] \tag{2.10}
\end{align*}
$$

for some $s \in(0,1)$, and uniformly for $|y|<\frac{\delta}{\lambda k}$. A direct Taylor expansion gives that

& =\frac{2^{\frac{n-2}{2}} \lambda^{\frac{n-2}{2}}}{\left|\bar{\xi}_{1}-\bar{\xi}_{j}\right|^{n-2}}\left[1-(n-2) \frac{\left(y, \bar{\xi}_{1}-\bar{\xi}_{j}\right)}{\left|\bar{\xi}_{1}-\bar{\xi}_{j}\right|^{2}} \lambda+O\left(\frac{\lambda^{2}\left(1+|y|^{2}\right)}{\left|\bar{\xi}_{1}-\bar{\xi}_{j}\right|^{2}}\right)\right], \\
\underline{U}_{j}\left(\lambda y+\bar{\xi}_{1}\right) & =\frac{2^{\frac{n-2}{2}} \lambda^{\frac{n-2}{2}}}{\left(\lambda^{2}+\left|\lambda y+\bar{\xi}_{1}-\underline{\xi}_{j}\right|^{2}\right)^{\frac{n-2}{2}}} \text { for } j=1, \ldots, k  \tag{2.11}\\
& =\frac{2^{\frac{n-2}{2}} \lambda^{\frac{n-2}{2}}}{\left|\bar{\xi}_{1}-\underline{\xi}_{j}\right|^{n-2}}\left[1-(n-2) \frac{\left(y, \bar{\xi}_{1}-\underline{\xi}_{j}\right)}{\left|\bar{\xi}_{1}-\underline{\xi}_{j}\right|^{2}} \lambda+O\left(\frac{\lambda^{2}\left(1+|y|^{2}\right)}{\left|\bar{\xi}_{1}-\underline{\xi}_{j}\right|^{2}}\right)\right], \\
U\left(\lambda y+\bar{\xi}_{1}\right) & =U\left(\bar{\xi}_{1}\right)\left[1-(n-2) \frac{\left(y, \bar{\xi}_{1}\right)}{1+\left|\bar{\xi}_{1}\right|^{2}} \lambda+O\left(\frac{\lambda^{2}|y|^{2}}{1+\left|\bar{\xi}_{1}\right|^{2}}\right)\right],

uniformly for $|y| \leqslant \frac{\delta}{\lambda k}$. In the Appendix we will show that

where $A_{3}:=\pi^{-1}$ and, if $n \geqslant 4$,

From (2.10), (2.11), (2.12) and (2.13) we get that

C k^{-\frac{n}{q}} & \text { if } n \geqslant 4,  \tag{2.15}\\
\frac{C}{k \ln k} & \text { if } n=3 .
\end{array}\right.
$$

The error in $\mathbb{R}^{n} \backslash \bigcup_{j=1}^{k}\left(B\left(\underline{\xi}_{j}, \frac{\delta}{k}\right) \cup B\left(\bar{\xi}_{j}, \frac{\delta}{k}\right)\right)$. For $y$ in this region we have

& \times\left[\sum_{j=1}^{k}\left(\frac{\lambda^{\frac{n-2}{2}}}{\left|y-\underline{\xi}_{j}\right|^{n-2}}+\frac{\lambda^{\frac{n-2}{2}}}{\left|y-\bar{\xi}_{j}\right|^{n-2}}\right)\right]  \tag{2.16}\\
& \leqslant C \frac{\lambda^{\frac{n-2}{2}}}{\left(1+|y|^{2}\right)^{2}} \sum_{j=1}^{k}\left(\frac{1}{\left|y-\underline{\xi}_{j}\right|^{n-2}}+\frac{1}{\left|y-\bar{\xi}_{j}\right|^{n-2}}\right)
\end{align*}

where we have used that in this exterior region

& \leqslant C \lambda^{\frac{n-2}{2}} \sum_{j=1}^{k}\left[\left(\int_{\left|y-\underline{\xi}_{j}\right|>\frac{\delta}{k}} \frac{(1+|y|)^{(n+2) q-2 n-4 q}}{\left|y-\underline{\xi}_{j}\right|^{(n-2) q}} d y\right)^{\frac{1}{q}}\right. \\
&\left.+\left(\int_{\left|y-\bar{\xi}_{j}\right|>\frac{\delta}{k}} \frac{(1+|y|)^{(n+2) q-2 n-4 q}}{\left|y-\bar{\xi}_{j}\right|^{(n-2) q}} d y\right)^{\frac{1}{q}}\right]  \tag{2.18}\\
& \leqslant C \lambda^{\frac{n-2}{2}} k\left(\int_{\frac{\delta}{k}}^{1} \frac{t^{n-1}}{t^{(n-2) q}} d t\right)^{\frac{1}{q}} \leqslant C k^{1-\frac{n}{q}}
\end{align*}
$$

for some constant $C$. Similarly, if $n=3$, we get

Estimates (2.14), (2.15), (2.18) and (2.19) merge in the following
Proposition 2.1. Assume that $\lambda$ and $\tau$ satisfy (2.7). There exist an integer $k_{0}$ and a positive constant $C$ such that for all $k \geqslant k_{0}$ the following estimates hold true

The following result is the key point of the argument carried out for the gluing procedure and the reduction method in sections 4 and 5, It provides a decomposition of the interior error term in two parts: one is relatively large but symmetric, and the other is non symmetric but smaller in size. Thanks to this observation we can refine the fixed point argument to fix a smaller size of the functions involved in the reduction.

Proposition 2.2. Assume that $\lambda$ and $\tau$ satisfy (2.7) and $|y|<\frac{\delta}{\lambda k}$. Then, there exists a decomposition

\end{array} \quad, \quad|y|<\frac{\delta}{\lambda k} .\right.
$$

Proof. The idea is to identify in (2.10) the main order terms using (2.11). Indeed, we write, for $|y|<\frac{\delta}{k \lambda}$,

& +\lambda^{\frac{n+2}{2}}\left[\sum_{j \neq 1}\left(\frac{2^{\frac{n-2}{2}} \lambda^{\frac{n-2}{2}}}{\left|\bar{\xi}_{1}-\bar{\xi}_{j}\right|^{n-2}}\right)^{p}+\sum_{j=1}^{k}\left(\frac{2^{\frac{n-2}{2}} \lambda^{\frac{n-2}{2}}}{\left|\bar{\xi}_{1}-\underline{\xi}_{j}\right|^{n-2}}\right)^{p}-U^{p}\left(\bar{\xi}_{1}\right)\right]
\end{align*}
$$

that is even with respect to every $y_{\alpha}, \alpha=1, \ldots, n$. Let us define

C \frac{|y|}{k} \text { if } n \geqslant 4, \\
C \frac{|y|}{k(\ln k)^{3}} \text { if } n=3,
\end{array}\right.
$$

and (2.20) follows for $|y|<\frac{\delta}{\lambda k}$.

## 3. The linear theory

Consider the linear problem

\end{equation*}

Defining the norm

\|\varphi\|_{*}:=\left\|\left(1+|y|^{n-2}\right) \varphi\right\|_{L^{\infty}\left(\mathbb{R}^{n}\right)} \tag{3.3}
\end{equation*}

in [8, Lemma 3.1] the following existence result is proved.
Lemma 3.1. Assume $\frac{n}{2}<q<n$ in the definition of $\|\cdot\|_{* *}$. Let $h$ be a function such that $\|h\|_{* *}<+\infty$ and

We will also need a priori estimates of the gradient of such solution.
Lemma 3.2. Let $\varphi$ be the solution of (3.1) predicted by Lemma 3.1 and assume $\left\|\left(1+|y|^{n+2}\right) h\right\|_{L^{\infty}\left(\mathbb{R}^{n}\right)}<$ $+\infty$. Then, there exists $C>0$ depending only on $n$ such that

\|\nabla \varphi\|_{L^{\infty}\left(B_{1}\right)} \leqslant C\left(\|\varphi\|_{L^{\infty}\left(B_{2}\right)}+\|h\|_{L^{\infty}\left(B_{2}\right)}\right) \leqslant C\left(\|\varphi\|_{*}+\left\|\left(1+|y|^{n+2}\right) h\right\|_{L^{\infty}\left(\mathbb{R}^{n}\right)}\right) . \tag{3.4}
\end{equation*}
$$

Defining $\tilde{\varphi}(y):=|y|^{2-n} \varphi\left(|y|^{-2} y\right)$ it can be checked that

\Delta \tilde{\varphi}+p \gamma U^{p-1} \tilde{\varphi}=\tilde{h} \text { in } \mathbb{R}^{n} \backslash\{0\},
$$

with $\tilde{h}(y):=|y|^{-n-2} h\left(y|y|^{-2}\right)$, and thus

\|\tilde{h}\|_{L^{\infty}\left(B_{2}\right)}=\left\||y|^{n+2} h\right\|_{L^{\infty}\left(\mathbb{R}^{n} \backslash B_{1 / 2}\right)} \leqslant\left\|\left(1+|y|^{n+2}\right) h\right\|_{L^{\infty}\left(\mathbb{R}^{n}\right)},
\end{gathered}
$$

we obtain

$$
\begin{equation*}
\|\nabla \tilde{\varphi}\|_{L^{\infty}\left(B_{1}\right)} \leqslant C\left(\|\varphi\|_{*}+\left\|\left(1+|y|^{n+2}\right) h\right\|_{L^{\infty}\left(\mathbb{R}^{n}\right)}\right) . \tag{3.5}
\end{equation*}
$$

Writing $\varphi(y)=|y|^{-(n-2)} \tilde{\varphi}\left(|y|^{-2} y\right)$ it can be seen that

Putting together (3.4), (3.5) and (3.6) the estimate follows.

## 4. The gluing scheme

Our goal will be to find a solution of the form

u=\mathbf{u}+\phi \tag{4.1}
\end{equation*}

with $\phi$ a small function (in a sense that will be precised later). Thus, $u$ is a solution of (1.1) if and only if

where

and $E$ was defined in (2.8).
Let $\zeta(s)$ be a smooth function such that $\zeta(s)=1$ for $s<1$ and $\zeta(s)=0$ for $s>2$, and let $\delta>0$ be a fixed number independent of $k$. Let us define

$$

for $j=1, \ldots, k$. We notice that a function $\phi$ of the form

is a solution of (4.2) provided the functions $\bar{\phi}_{j}, \underline{\phi}_{j}$ and $\psi$ solve the following system of coupled non linear equations

& \Delta \bar{\phi}_{j}+p \gamma|\mathbf{u}|^{p-1} \bar{\zeta}_{j} \bar{\phi}_{j}+\bar{\zeta}_{j}\left[p \gamma|\mathbf{u}|^{p-1} \psi+E+\gamma N(\phi)\right]=0, \quad j=1, \ldots, k,  \tag{4.4}\\
& \Delta \underline{\phi}_{j}+p \gamma|\mathbf{u}|^{p-1} \underline{\zeta}_{j} \underline{\phi}_{j}+\underline{\zeta}_{j}\left[p \gamma|\mathbf{u}|^{p-1} \psi+E+\gamma N(\phi)\right]=0, j=1, \ldots, k,  \tag{4.5}\\
& \Delta \psi+p \gamma U^{p-1} \psi+\left[p \gamma\left(|\mathbf{u}|^{p-1}-U^{p-1}\right)\left(1-\sum_{j=1}^{k}\left(\bar{\zeta}_{j}+\underline{\zeta}_{j}\right)\right)\right. \\
& \left.\quad+p \gamma U^{p-1} \sum_{j=1}^{k}\left(\bar{\zeta}_{j}+\underline{\zeta}_{j}\right)\right] \psi+p \gamma|\mathbf{u}|^{p-1} \sum_{j=1}^{k}\left(1-\bar{\zeta}_{j}\right) \bar{\phi}_{j}  \tag{4.6}\\
& \quad+p \gamma|\mathbf{u}|^{p-1} \sum_{j=1}^{k}\left(1-\underline{\zeta}_{j}\right) \underline{\phi}_{j}+\left(1-\sum_{j=1}^{k}\left(\bar{\zeta}_{j}+\underline{\zeta}_{j}\right)\right)(E+\gamma N(\phi))=0 .
\end{align*}
$$

Given our setting it is natural to ask for some symmetry properties on $\bar{\phi}_{j}$ and $\underline{\phi}_{j}$. In particular, denoting $\hat{y}:=\left(y_{1}, y_{2}\right)$ and $y^{\prime}:=\left(y_{3}, \ldots, y_{n}\right)$, we want them to satisfy

\bar{\phi}_{j}\left(\hat{y}, y^{\prime}\right)=\bar{\phi}_{1}\left(e^{2 \pi \frac{(j-1)}{k} i} \hat{y}, y^{\prime}\right), \quad j=1, \ldots k \tag{4.7}

$$

where

$$
\begin{align*}
& \bar{\phi}_{1}\left(y_{1}, \ldots, y_{\alpha}, \ldots, y_{n}\right)=\bar{\phi}_{1}\left(y_{1}, \ldots,-y_{\alpha}, \ldots, y_{n}\right), \alpha=2,4, \ldots, n,  \tag{4.8}\\
& \bar{\phi}_{1}(y)=|y|^{2-n} \bar{\phi}_{1}\left(|y|^{-2} y\right)
\end{align*}
$$

and

$$
\begin{equation*}
\underline{\phi}_{1}(y)=\bar{\phi}_{1}\left(y_{1}, y_{2},-y_{3}, \ldots, y_{n}\right) . \tag{4.9}
\end{equation*}
$$

Remark 4.1. The functions $\bar{\phi}_{j}$ and $\underline{\phi}_{j}$ are not even in the third coordinate separately but $\bar{\phi}_{j}+\underline{\phi}_{j}$ is so, that is,

\left(\bar{\phi}_{j}+\underline{\phi}_{j}\right)(y)=\left(\bar{\phi}_{j}+\underline{\phi}_{j}\right)\left(y_{1}, y_{2},-y_{3}, \ldots, y_{n}\right) .

Likewise, the functions $\left(\bar{\zeta}_{j}+\underline{\zeta}_{j}\right)$ and $\left(\bar{\zeta}_{j} \bar{\phi}_{j}+\underline{\zeta}_{j} \underline{\phi}_{j}\right)$ are even in the third coordinate.
For $\rho>0$ small and fixed we assume in addition

\end{equation*}

where $\overline{\bar{\phi}}_{1}(y):=\lambda^{\frac{n-2}{2}} \bar{\phi}_{1}\left(\bar{\xi}_{1}+\lambda y\right)$ and $\|\cdot\|_{*}$ is defined in (3.3).
Proposition 4.2. There exist constants $k_{0}, C$ and $\rho_{0}$ such that, for all $k \geqslant k_{0}$ and $\rho<\rho_{0}$, if $\bar{\phi}_{j}$ and $\underline{\phi}_{j}$ satisfy conditions (4.7) -(4.10) then there exists a unique solution $\psi=\Psi\left(\overline{\bar{\phi}}_{1}\right)$ of (4.6) such that

\psi\left(\hat{y}, y^{\prime}\right)=\psi\left(e^{\frac{2 \pi(j-1)}{k}} \hat{y}, y^{\prime}\right), \quad j=1, \ldots k  \tag{4.12}\\
\psi(y)=|y|^{2-n} \psi\left(|y|^{-2} y\right), \tag{4.13}
\end{gather*}
$$

and

\|\psi\|_{*} \leqslant C\left(\left\|\overline{\bar{\phi}}_{1}\right\|_{*}+k^{1-\frac{n}{q}}\right) \quad \text { if } n \geqslant 4, \quad\|\psi\|_{*} \leqslant C\left(\left\|\overline{\bar{\phi}}_{1}\right\|_{*}+(\ln k)^{-1}\right) \quad \text { if } n=3
$$

Furthermore, given two functions $\phi^{1}, \phi^{2}$ the operator $\Psi$ satisfies

Proof. We prove the result by combining a linear theory with a fixed point argument as in [8, Lemma 4.1]. Indeed, consider first the problem

\end{equation*}
$$

and

$$
\begin{equation*}
M(\psi):=\left(1-\sum_{j=1}^{k}\left(\bar{\zeta}_{j}+\underline{\zeta}_{j}\right)\right)(E+\gamma N(\phi)) . \tag{4.17}
\end{equation*}
$$

Thus, in order to solve (4.6) by a fixed point argument, we write

\psi=-T\left(V \psi+p \gamma|\mathbf{u}|^{p-1}\left(\sum_{j=1}^{k}\left(1-\bar{\zeta}_{j}\right) \bar{\phi}_{j}+\sum_{j=1}^{k}\left(1-\underline{\zeta}_{j}\right) \underline{\phi}_{j}\right)+M(\psi)\right)=: \mathcal{N}(\psi),
$$

where $\psi \in X$, the space of continuous functions with $\|\cdot\|_{*}<+\infty$ and satisfying (4.11)-(4.13). Pointing out Remark 4.1 and the special symmetries of $\mathbf{u}$ it can be checked that

V \psi+p \gamma|\mathbf{u}|^{p-1}\left(\sum_{j=1}^{k}\left(1-\bar{\zeta}_{j}\right) \bar{\phi}_{j}+\sum_{j=1}^{k}\left(1-\underline{\zeta}_{j}\right) \underline{\phi}_{j}\right)+M(\psi)
$$

satisfies (4.11), (4.12) and (4.15) for every $\psi \in X$ and thus $\mathcal{M}(\psi)$ is well defined. Let us see that $\mathcal{M}$ is actually a contraction mapping in the $\|\cdot\|_{*}$ norm in a small ball around the origin in $X$. Proceeding as in [8, Lemma 4.1] we see that

C k^{1-\frac{n}{q}}\left\|\overline{\bar{\phi}}_{1}\right\|_{*} \quad \text { if } n \geqslant 4, \\
\frac{C}{\ln k}\|\psi\|_{*} \quad \text { if } n=3,
\end{array} \quad\left\|\overline{\bar{\phi}}_{1}\right\|_{*} \quad \text { if } n=3,\right. \tag{4.18}
\end{array}\right.
$$

whenever $\left|y-\bar{\xi}_{j}\right|>\frac{\delta}{k},\left|y-\underline{\xi}_{j}\right|>\frac{\delta}{k}$. Using Proposition 2.1 we get

\|M(\psi)\|_{* *} \leqslant\left\{\begin{array}{l}
C k^{1-\frac{n}{q}}\left(1+\left\|\overline{\bar{\phi}}_{1}\right\|_{*}^{2}\right)+C\|\psi\|_{*}^{2} \quad \text { if } n \geqslant 4  \tag{4.19}\\
C \frac{1}{\ln k}\left(1+\left\|\overline{\bar{\phi}}_{1}\right\|_{*}^{2}\right)+C\|\psi\|_{*}^{2} \quad \text { if } n=3
\end{array}\right.
$$

Similarly, for $\psi_{1}, \psi_{2}$ such that $\left\|\psi_{1}\right\|_{*}<\rho,\left\|\psi_{2}\right\|_{*}<\rho$ it can be seen that

This estimate, together with (4.18)-(4.19), allows us to conclude that for $\rho$ small enough (independent of $k$ ) the operator $\mathcal{M}$ is a contraction map in the set of functions $\psi \in X$ with

\left(1+|y|^{n+2}\right)\left|V_{2} \psi\right| \leqslant\|\psi\|_{*}\left(1+|y|^{4}\right) U^{p-1} \leqslant C\|\psi\|_{*} .
\end{gather*}

Analogously, noticing that $\left(1+|y|^{n+2}\right) U^{p} \approx 1$, we have

\left(1+|y|^{n+2}\right)\left(1-\sum_{j=1}^{k}\left(\bar{\zeta}_{j}+\underline{\zeta}_{j}\right)\right)|N(\phi)| & \leqslant\left(1+|y|^{n+2}\right) U^{p-2}\left(\left|\sum_{j=1}^{k}\left(\bar{\phi}_{j}+\underline{\phi}_{j}\right)\right|^{2}+|\psi|^{2}\right)  \tag{4.22}\\
& \leqslant C\left(\left\|\overline{\bar{\phi}}_{1}\right\|_{*}^{2}+\|\psi\|_{*}^{2}\right) .
\end{align*}
$$

On the other hand

\left(1+|y|^{n+2}\right)\left(1-\sum_{j=1}^{k}\left(\bar{\zeta}_{j}+\underline{\zeta}_{j}\right)\right)|E| \leqslant C
$$

as a consequence of (2.16) and (2.17). Using the estimates in Proposition 4.2 and Lemma 3.2 we conclude (4.20).

Let $\psi=\Psi\left(\overline{\bar{\phi}}_{1}\right)$ given by Proposition 4.2. Notice that, thanks to the imposed conditions (4.7) and (4.9), solving the systems (4.4) and (4.5) can be reduced to solving the equation for $\bar{\phi}_{1}$, that is,

\end{equation*}

where

\mathcal{N}\left(\bar{\phi}_{1}, \phi\right):=p\left(|\mathbf{u}|^{p-1} \bar{\zeta}_{1}-\left|\bar{U}_{1}\right|^{p-1}\right) \bar{\phi}_{1}+\bar{\zeta}_{1}\left[p|\mathbf{u}|^{p-1} \Psi\left(\overline{\bar{\phi}}_{1}\right)+N(\phi)\right]
$$

Denote

\bar{Z}_{\alpha}(y):=\lambda^{-\frac{n-2}{2}} Z_{\alpha}\left(\frac{y-\bar{\xi}_{1}}{\lambda}\right), \alpha=1, \ldots, n+1
$$

where $Z_{\alpha}$ was defined in (3.2). In order to solve (4.23) we will deal first with a projected linear version. Given a general function $\bar{h}$ we consider

c_{3}:=\frac{\int_{\mathbb{R}^{n}} \overline{h Z}_{3}}{\int_{\mathbb{R}^{n}} \bar{U}_{1}^{p-1} \bar{Z}_{3}^{2}}, \quad c_{n+1}:=\frac{\int_{\mathbb{R}^{n}} \overline{h Z}_{n+1}}{\int_{\mathbb{R}^{n}} \bar{U}_{1}^{p-1} \bar{Z}_{n+1}^{2}}
$$

Lemma 4.4. Suppose that $\bar{h}$ is even with respect to $y_{2}, y_{4}, \ldots, y_{n}$ and satisfies (4.15), and assume that $h(y):=\lambda^{\frac{n+2}{2}} \bar{h}\left(\bar{\xi}_{1}+\lambda y\right)$ satisfies $\|h\|_{* *}<+\infty$.

Then problem (4.24) has a unique solution $\bar{\phi}=\bar{T}(\bar{h})$ that is even with respect to $y_{2}, y_{4}, \ldots, y_{n}$ and satisfies

\bar{\phi}(y)=|y|^{2-n} \bar{\phi}\left(|y|^{-2} y\right) \\
\int_{\mathbb{R}^{n}} \overline{\bar{\phi}} U^{p-1} Z_{n+1}=0, \quad \int_{\mathbb{R}^{n}} \overline{\bar{\phi}} U^{p-1} Z_{3}=0, \quad\|\overline{\bar{\phi}}\|_{*} \leqslant C\|h\|_{* *}
\end{gathered}
$$

with $\overline{\bar{\phi}}(y):=\lambda^{\frac{n-2}{2}} \bar{\phi}\left(\bar{\xi}_{1}+\lambda y\right)$.
Proof. Notice that, up to redefining $\bar{h}$ as $\bar{h}-c_{3} \bar{U}_{1}^{p-1} \bar{Z}_{3}-c_{n+1} \bar{U}_{1}^{p-1} \bar{Z}_{n+1}$, we can assume

We want to apply [8, Lemma 3.1] to solve this problem, and therefore we need to prove that

This follows straightforward for $\alpha=2,4,5, \ldots, n$ due to the evenness of $h$. The case $\alpha=1$ holds as a consequence of (4.15) (see the proof of [8, Lemma 4.2]). Then the result follows by [8, Lemma 3.1].

If instead of satisfying condition (4.15) the function $h$ is even in all its coordinates we can prove a similar result (notice that in such case $c_{3}=0$ ).
Lemma 4.5. Suppose that $h(y):=\lambda^{\frac{n+2}{2}} \bar{h}\left(\bar{\xi}_{1}+\lambda y\right)$ is even with respect to $y_{\alpha}$ for every $\alpha=$ $1, \ldots, n$ and $\|h\|_{* *}<+\infty$. Then problem (4.24) has a unique solution $\bar{\phi}=\bar{T}(\bar{h})$ that is even with respect to $y_{\alpha}$ for every $\alpha=1, \ldots, n$ and satisfies

To perform the reduction procedure in section 5 we will need more precise estimates on the pointwise behavior of $\bar{\phi}_{1}$, in particular on the part that will not be orthogonal to the kernel, whose size is smaller.

C \frac{\lambda^{1 / 2}}{k(\ln k)^{3}} \frac{1}{1+|y|^{3}} \text { if } n=3
\end{array}\right.

and the same bound can be proved for $\tilde{f}_{3}^{*}$ and $\tilde{f}_{4}^{*}$ by using the estimates in Proposition 4.2 and Proposition 4.3. Using this together with Proposition 2.2 we can proceed as in the proof of Proposition 4.7 to estimate the size of $\left|\overline{\overline{\phi_{1}^{*}}}\right|$. That is, we can rewrite problem (4.31) as

Applying again [8, Lemma 3.2] with $\nu=3$ for $n \geqslant 4$ and $2<\nu<3$ for $n=3$ we obtain (4.30).

Likewise, we will need accurate estimates on the non symmetric part of $\psi$.
Proposition 4.9. Let $\psi$ be the solution of (4.6) provided by Proposition 4.2. Then

where $c_{n}$ is a constant depending only on the dimension and $V, M$ were defined in (4.16) and (4.17) respectively. Furthermore,

B_{1}(x, y):=-(n-2) \lambda y_{3} \frac{x_{3}-\tau}{\left|x-\bar{\xi}_{1}\right|^{n}}, \quad B_{2}(x, y):=O\left(\left(\frac{\left(\lambda^{2} y^{2}+2 \lambda\left(y, x-\bar{\xi}_{1}\right)\right)^{2}}{\left|x-\bar{\xi}_{1}\right|^{n+2}}\right)\right)

Notice that $A(x, y)$ is even with respect to $y_{3}$ and thus we can define

& \left|\int_{\mathbb{R}^{n}} B_{1}(x, y)\left(1-\sum_{j=1}^{k}\left(\bar{\zeta}_{j}+\underline{\zeta}_{j}\right)\right) N(\phi)\right| \leqslant C \lambda|y|\left(\left\|\overline{\bar{\phi}}_{1}\right\|_{*}+\|\psi\|_{*}\right), \tag{4.36}
\end{align*}

and thus the only term left is the one concerning the error, namely

& +p\left(U^{p-1}-U^{p-1}\left(\bar{\xi}_{1}\right)\right) \sum_{j=1}^{k} \bar{U}_{j}+p\left(U^{p-1}-U^{p-1}\left(\bar{\xi}_{1}\right)\right) \sum_{j=1}^{k} \underline{U}_{j} .
\end{aligned}

Notice first that, since $B_{1}(x, y)$ is odd with respect to the hyperplane $x_{3}=\tau$, there holds

& \left.+O\left(\left(\frac{\left(x-\bar{\xi}_{1}, \bar{\xi}_{1}-\underline{\xi}_{j}\right)}{\lambda^{2}+\left|\bar{\xi}_{1}-\underline{\xi}_{j}\right|^{2}+\left|x-\bar{\xi}_{1}\right|^{2}}\right)^{2}\right)\right],
\end{aligned}
$$

and applying again the evenness of its main terms with respect to $x_{3}=\tau$ we have that

& \leqslant C \lambda^{1+\frac{n-2}{2}}|y| \int_{B\left(\bar{\xi}_{1}, R\right)} \frac{\left|x_{3}-\tau\right|}{\left|x-\bar{\xi}_{1}\right|^{n}} \sum_{j=1}^{k} \frac{\tau\left|x_{3}-\tau\right|}{\left(\lambda^{2}+\left|\bar{\xi}_{1}-\underline{\xi}_{j}\right|^{2}+\left|x-\bar{\xi}_{1}\right|^{2}\right)^{\frac{n}{2}}} d x \\
& \quad+C \lambda^{1+\frac{n-2}{2}}|y| \int_{B\left(\bar{\xi}_{1}, R\right)} \frac{\left|x_{3}-\tau\right|}{\left|x-\bar{\xi}_{1}\right|^{n}} \sum_{j=1}^{k} \frac{\left|x-\bar{\xi}_{1}\right|^{2}\left|\bar{\xi}_{1}-\underline{\xi}_{j}\right|^{2}}{\left(\lambda^{2}+\left|\bar{\xi}_{1}-\underline{\xi}_{j}\right|^{2}+\left|x-\bar{\xi}_{1}\right|^{2}\right)^{\frac{n+2}{2}}} d x \\
& \leqslant \\
& \leqslant C \lambda^{1+\frac{n-2}{2}}|y| \int_{B\left(\bar{\xi}_{1}, R\right)} \frac{1}{\left|x-\bar{\xi}_{1}\right|^{n-1}} \sum_{j=1}^{k}\left(\frac{\tau}{\left|\bar{\xi}_{1}-\underline{\xi}_{j}\right|^{n-1}}+\frac{1}{\left|\bar{\xi}_{1}-\underline{\xi}_{j}\right|^{n-2}}\right) d x \\
& \quad=\lambda \tau|y| o_{k}(1),
\end{aligned}
$$

where in the last inequality we have used (2.13). Proceeding analogously with the other terms it can be concluded that

## 5. Proof of Theorem 1.1

The goal of this section is to find positive parameters $\ell$ and $t$ that enter in the definition of $\lambda$ and $\tau$ in (2.7) and are independent of $k$, in such a way that $c_{3}$ and $c_{n+1}$ (defined in (4.26)) vanish. In fact, if such a choice is possible, then the solution $\bar{\phi}_{1}$ found in Proposition 4.6 solves (4.23) and thus, applying Proposition 4.2 and (4.7)-(4.9), we can conclude that $\phi$ solves (4.2) and therefore

u=\mathbf{u}+\phi
$$

is a solution of (1.1).

Thus, we want to prove the existence of $\ell$ and $t$ so that

It is worth pointing out that, due to some symmetry, the main order term of $\bar{c}_{3}$ vanishes, what makes necessary an expansion of $\bar{c}_{3}$ at lower order. This is usually a delicate issue and it requires sharper estimates on the non linear term, that is, a finer control on the size of the terms $\psi$ and $\bar{\phi}_{1}$ in the spirit of Proposition 4.7. However in this case this type of estimates are not enough, since they do not produce a non linear term sufficiently small. We need to identify a precise decomposition of $\bar{\phi}_{1}$ and $\psi$ in one symmetric part whose contribution to the computation of $\bar{c}_{3}$ is zero, and a smaller non-symmetric part (see Claim 6). This decompositions were developed in Proposition 4.8 and Proposition 4.9 .

What we obtain at the end is that, for $n \geqslant 4$,

& \bar{c}_{n+1}(\ell, t)=E_{n} \frac{\ell}{k^{n-2}}\left[e_{n} \ell^{2}-1\right]+\frac{1}{k^{\beta}} \Theta_{k}(\ell, t),
\end{align*}
$$

where

\alpha>n+1-\frac{2}{n-1}, \quad \beta>n-2,
$$

and

\begin{align*}
& \bar{c}_{3}(\ell, t)=F \frac{\ell^{3} t}{\sqrt{\ln k}(k \ln k)^{3}}\left[f \frac{\ell}{t^{2}}-1\right]+\frac{1}{k^{3}(\ln k)^{4}} \Theta_{k}(\ell, t), \\
& \bar{c}_{4}(\ell, t)=G \frac{\ell}{k \ln k}\left[g \ell^{2}-1\right]+\frac{1}{k \ln k} \frac{\ln \left(\frac{2 \pi}{\sqrt{\ln k}}\right)}{\ln k} \Theta_{k}(\ell, t), \tag{5.2}
\end{align*}
$$

for $n=3$, where $D_{n}, d_{n}, E_{n}, e_{n}, F, f, G, g$ are fixed positive numbers (depending only on $n$ ) and $\Theta_{k}(\ell, t)$ is a generic function, smooth on its variables, and uniformly bounded as $k \rightarrow \infty$. Hence, by a fixed point argument we can conclude the existence of $\ell$ and $t$ such that

Using the smoothness of $\Theta_{k}$ it is easy to see that $F_{\rho}$ maps $X$ into itself and that it is a contraction for $k$ large enough. Thus, for any fixed $\rho$ there exists a fixed point $\eta_{\rho} \in X$ such that $\eta_{\rho}=F_{\rho}\left(\eta_{\rho}\right)$.

Replacing on the first equation this translates into

Considering the set $Y:=\left\{\rho \in \mathbb{R}: 0<\rho \leqslant \frac{2 f}{g^{1 / 2}}\right\}$ and using the smoothness of $\Theta$ it can be checked that $G$ is a contraction that maps the set $Y$ into itself, and therefore we conclude the existence of a fixed point $\rho=G(\rho)$, what concludes the argument.

The rest of the section is devoted to prove (5.1) and (5.2). Let us consider first the case of $\bar{c}_{n+1}$, that follows analogously to [8]. We write

Notice that these claims together give the second equation in (5.1) and (5.2).

Indeed, to prove this claim we will have to make use of the decomposition of $\psi$ in a large but symmetric part (that happens to be orthogonal to $\bar{Z}_{3}$ ) and a non symmetric but small part specified in Proposition 4.9. & \leqslant \frac{C}{k^{3}(\ln k)^{5}},
\end{aligned}
$$

and

## 6. Remark 1.7: The general construction

This section is devoted to the constructions described in Remark 1.7. The first is the construction of the doubling of the equatorial $\Gamma$ with an even number of circles, which is done in subsection 6.1. The second is a combination of the doubling and the desingularization of the equatorial with an odd number of circles. This is done in subsection 6.2,
6.1. Even number of circles. Let $m$ be a fixed integer. Let $\tau_{i} \in(0,1), i=1, \ldots, m$, and fix the points

In dimension $n=3$, system (6.11) decouples and becomes

& =\frac{k \tau}{\pi \sqrt{1-\tau^{2}}}\left(\int_{0}^{\infty} \frac{d s}{\left(1+s^{2}\right)^{\frac{n-2}{2}}}\right)\left(1+O\left((k \tau)^{-2}\right)+O\left(\tau^{n-3}\right)\right) \tag{6.12}

## Appendix B: Linear independence of the functions $z_{j}(y)$.

We give here the proof of the linear independence of the functions $z_{j}(y), j=0, \ldots, 4 n-3$, defined in Remark 1.4, in the case $k$ even. Indeed, we claim that, if there are $4 n-2$ constants $c_{j}$ with

& a=\left(1+o_{k}(1)\right), \quad b=2\left(1+o_{k}(1)\right), \\
& c=4 k \lambda^{\frac{n-2}{2}}\left(1+o_{k}(1)\right),
\end{aligned}
$$

where $\lim _{k \rightarrow \infty} o_{k}(1)=0$. Evaluating (6.17) at three points $\left(r_{1}, 0, \ldots, 0\right),\left(r_{2}, 0, \ldots, 0\right),\left(r_{3}, 0, \ldots, 0\right)$, with $r_{i}$ large, we arrive at a system which at main order looks like

$$
\left(\begin{array}{lll}
a r_{1} & b & c r_{1}^{2} \\
a r_{2} & b & c r_{2}^{2} \\
a r_{3} & b & c r_{3}^{3}
\end{array}\right)\left(\begin{array}{c}
c_{0} \\
c_{1} \\
c_{n+1}
\end{array}\right)=\left(\begin{array}{c}
0 \\
0 \\
0
\end{array}\right)
$$

Choosing properly $r_{1} \neq r_{2} \neq r_{3}$ it can be seen that the determinant of the matrix is not zero and thus necessarily

$$
c_{0}=c_{1}=c_{n+1}=0 .
$$

Let us take now $q=\left(q_{1}, q_{2}, 0, \ldots, 0\right)$. From (6.16) we obtain

$$
\begin{equation*}
c_{2} z_{2}(q)+c_{n+2}\left(-2 q_{2} z_{0}(q)+z_{2}(q)|q|^{2}\right)+c_{n+4}\left(-q_{2} z_{1}(q)+q_{1} z_{2}(q)\right)=0 . \tag{6.19}
\end{equation*}
$$

If $q_{2}=0$, then $-q_{2} z_{1}(q)+q_{1} z_{2}(q)=0$. Since $u(y)$ is invariant under rotations of angle $\frac{2 \pi}{k}$ in the ( $y_{1}, y_{2}$ )-plane, we have that $-q_{2} z_{1}(q)+q_{1} z_{2}(q)=0$ for all points of the form $q=$
$\left(e^{\frac{2 \pi}{k}(j-1) i} \tilde{r}, 0,0,0, ..\right)$, with $\tilde{r}=(r, 0)$, for some $j=2, \ldots, k$. Evaluating (6.19) at these points $q$, we get

$$
c_{2} z_{2}(q)+c_{n+2}\left(-2 q_{2} z_{0}(q)+z_{2}(q)|q|^{2}\right)=0
$$

Replacing in the above equation the points $q_{1}=\left(e^{\frac{2 \pi}{k}(j-1) i} \tilde{r}_{1}, 0,0,0, ..\right), q_{2}=\left(e^{\frac{2 \pi}{k}(j-1) i} \tilde{r}_{2}, 0,0,0, ..\right)$, with $\tilde{r}_{1}=\left(r_{1}, 0\right), \tilde{r}_{2}=\left(r_{2}, 0\right), r_{1} \neq r_{2}$, we get a $2 \times 2$ system in $c_{2}$ and $c_{n+2}$. Arguing as before and choosing $r_{1}, r_{2}$ properly, we obtain $c_{2}=c_{n+2}=0$. Thus so far we have proven that

$$
c_{0}=c_{1}=c_{n+1}=c_{2}=c_{n+2}=0
$$

Next we evaluate (6.16) at points of the form $q=\left(q_{1}, 0, q_{3}, 0, \ldots, 0\right)$ we deduce

$$
c_{3} z_{3}(q)+c_{n+3}\left(-2 q_{3} z_{0}(q)+|q|^{2} z_{3}(q)\right)+c_{n+5}\left(q_{1} z_{3}(q)-q_{3} z_{1}(q)\right)=0
$$

Taking now $\bar{q}=\left(-q_{1}, 0,-q_{3}, 0, \ldots, 0\right)$ and using that $z_{0}(\bar{q})=z_{0}(q), z_{1}(\bar{q})=-z_{1}(q), z_{3}(\bar{q})=$ $-z_{3}(q)$, we obtain

$$
c_{3} z_{3}(q)+c_{n+3}\left(-2 q_{3} z_{0}(q)+|q|^{2} z_{3}(q)\right)=0
$$

Similar decay rates as in (6.18) allow us to choose two different points of the form $q=\left(q_{1}, 0, q_{3}, 0, \ldots, 0\right)$ that inserted in the above equation produce an invertible $2 \times 2$ system. This gives $c_{3}=c_{n+3}=0$.

Evaluate (6.16) at $q=\left(q_{1}, q_{2}, 0,0,0 . .0\right)$ to get

$$
c_{n+4}\left[q_{2} z_{1}(q)-q_{2} z_{2}(q)\right]=0
$$

Since our solution $u$ is not radially symmetric in the $\left(y_{1}, y_{2}\right)$-plane, the function $y_{2} z_{1}(y)-y_{1} z_{2}(y)$ is not identically zero. Thus we get $c_{n+4}=0$. Arguing similarly, we prove that $c_{n+5}=c_{2 n+3}=0$ (we use (6.16) for $q=\left(q_{1}, 0, q_{3}, 0,0, ..\right)$ and $q=\left(0, q_{2}, q_{3}, 0,0, \ldots 0\right)$ respectively, and the fact that the solution is not radially symmetric in the $\left(y_{1}, y_{3}\right)$ and $\left(y_{2}, y_{3}\right)$ planes).

Let now $\ell=4, \ldots, n$ and evaluate (6.16) at points of the form $q=\left(q_{1}, 0, . ., 0, q_{\ell}, \ldots\right)$ We obtain

$$
c_{\ell} z_{\ell}(q)+c_{2 n+\ell}\left(-q_{\ell} z_{1}(q)+q_{1} z_{\ell}(q)\right)=0
$$

Since $u$ is not radially symmetric in the $\left(y_{1}, y_{\ell}\right)$-plane, the function $y \rightarrow-y_{\ell} z_{1}(y)+y_{1} z_{\ell}(y)$ is not identically zero. Choose now two different points of the form $q=\left(q_{1}, 0, q_{\ell}, 0, \ldots, 0\right)$ that inserted in the above equation produce an invertible $2 \times 2$ system. This gives $c_{\ell}=c_{2 n+\ell}=0$, for $\ell=4, \ldots, n$.

Hence, so far we have proven that

$$
c_{0}=c_{1}=\ldots . .=c_{3 n}=0
$$

It remains to see that

$$
\sum_{j=4}^{n} c_{3 n+j-3}\left[y_{3} z_{j}(y)-y_{j} z_{3}(y)\right]=0 \quad \forall y
$$

implies $c_{3 n+4}=\ldots=c_{4 n-3}=0$. Let us evaluate this linear combination at the points $q_{3, j}=$ $\left(0,0, q_{3}, 0, \ldots, q_{j}, 0, \ldots\right)$, for $j=4, \ldots, n$. We get

$$
c_{3 n+j-3}\left(q_{3} z_{j}\left(q_{3, j}\right)-q_{j} z_{j}\left(q_{3, j}\right)\right)=0
$$

Since $u$ is not radially symmetric in the $\left(y_{3}, y_{j}\right)$-plane, we can choose $q_{3, j}$ to show that $c_{3 n+j-3}=0$ for all $j=4, \ldots, n$. We then conclude that (6.16) implies that

$$
c_{j}=0, \quad \text { for all } \quad j=0,1, \ldots, 4 n-3
$$
