# Efficient decoding of polar codes with some $16 \times 16$ kernels

#### Abstract

A decoding algorithm for polar codes with binary $16 \times 16$ kernels with polarization rate 0.51828 and scaling exponents 3.346 and 3.450 is presented. The proposed approach exploits the relationship of the considered kernels and the Arikan matrix to significantly reduce the decoding complexity without any performance loss. Simulation results show that polar (sub)codes with $16 \times 16$ kernels can outperform polar codes with Arikan kernel, while having lower decoding complexity.


## I. Introduction

Polar codes are a novel class of error-correcting codes, which achieve the symmetric capacity of a binary-input discrete memoryless channel $W$, have low complexity construction, encoding and decoding algorithms [1]. However, the performance of polar codes of practical length is quite poor. The reasons for this are the presence of imperfectly polarized subchannels and the suboptimality of the successive cancellation (SC) decoding algorithm. To improve performance, successive cancellation list decoding (SCL) algorithm [2], as well as various code constructions were proposed [3], [4], [5].

Polarization is a general phenomenon, and is not restricted to the case of Arikan matrix [6]. One can replace it by a larger matrix, called polarization kernel, which can provide higher polarization rate. Polar codes with large kernels were shown to provide asymptotically optimal scaling exponent [7]. Many kernels with various properties were proposed [6], [8], [9], [10], but, to the best of our knowledge, no efficient decoding algorithms for kernels with polarization rate greater than 0.5 were presented, except [11], where an approximate algorithm was introduced. Therefore, polar codes with large kernels are believed to be impractical due to very high decoding complexity.

In this paper we present reduced complexity decoding algorithms for $16 \times 16$ polarization kernels with polarization rate 0.51828 and scaling exponents 3.346 and 3.45 . We show that with these kernels increasing list size in the SCL decoder provides much more significant performance gain compared to the case of Arikan kernel, and ultimately the proposed approach results in lower decoding complexity compared to the case of polar codes with Arikan kernel with the same performance.

The proposed approach exploits the relationship between the considered kernels and the Arikan matrix. Essentially, the log-likelihood ratios (LLRs) for the input symbols of the considered kernels are obtained from the LLRs computed via the Arikan recursive expressions.

## II. BACKGROUND

## A. Channel polarization

Consider a binary input memoryless channel with transition probabilities $W\{y \mid c\}, c \in \mathbb{F}_{2}, y \in \mathcal{Y}$, where $\mathcal{Y}$ is output alphabet. For a positive integer $n$, denote by $[n]$ the set of $n$ integers $\{0,1, \ldots n-1\}$. A polarization kernel $K$ is a binary invertible $l \times l$ matrix, which is not upper-triangular under any column permutation. The Arikan kernel is given by $F_{2}=\left(\begin{array}{ll}1 & 0 \\ 1 & 1\end{array}\right)$. An $\left(n=l^{m}, k\right)$ polar code is a linear block code generated by $k$ rows of matrix $G_{m}=M^{(m)} K^{\otimes m}$, where $M^{(m)}$ is a digit-reversal permutation matrix, corresponding to mapping $\sum_{i=0}^{m-1} t_{i} l^{i} \rightarrow \sum_{i=0}^{m-1} t_{m-1-i} l^{i}, t_{i} \in[l]$. The encoding scheme is given by $c_{0}^{n-1}=u_{0}^{n-1} G_{m}$, where $u_{i}, i \in \mathcal{F}$ are set to some pre-defined values, e.g. zero (frozen symbols), $|\mathcal{F}|=n-k$, and the remaining values $u_{i}$ are set to the payload data.

It is possible to show that a binary input memoryless channel $W$ together with matrix $G_{m}$ gives rise to bit subchannels $W_{m, K}^{(i)}\left(y_{0}^{n-1}, u_{0}^{i-1} \mid u_{i}\right)$ with capacities approaching 0 or 1 , and fraction of noiseless subchannels approaching $I(W)$ [6]. Selecting $\mathcal{F}$ as the set of indices of low-capacity subchannels enables almost error-free communication. It is convenient to define probabilities

Let us further define $\mathbf{W}_{m}^{(j)}\left(u_{0}^{j} \mid y_{0}^{n-1}\right)=W_{m, K}^{(j)}\left(u_{0}^{j} \mid y_{0}^{n-1}\right)$, where kernel $K$ will be clear from the context. We also need probabilities $W_{t}^{(j)}\left(u_{0}^{j} \mid y_{0}^{l-1}\right)=W_{1, F_{2}^{\otimes t}}^{(j)}\left(u_{0}^{j} \mid y_{0}^{l-1}\right)$ for Arikan matrix $F_{2}^{\otimes t}$. Due to the recursive structure of $G_{n}$, one has

where $\theta_{K}\left[u_{0}^{(s+1) l-1}, j\right]_{r}=\left(u_{l r}^{l(r+1)-1} G_{n}\right)_{j}, r \in[s+1]$. A trellis-based algorithm for computing these values was presented in [12].

At the receiver side, one can successively estimate

This is known as the successive cancellation (SC) decoding algorithm.

## III. Computing kernel input symbols LLRs

## A. General case

Our goal is to compute efficiently probabilities $\mathbf{W}_{m}^{(i)}\left(u_{0}^{i} \mid y_{0}^{n-1}\right)$ for a given polarization transform $K^{\otimes m}$. Let us assume for the sake of simplicity that $m=1$. The corresponding task will be referred to as kernel processing.

We propose to introduce approximate probabilities

This is the probability of the most likely continuation of path $u_{0}^{j}$ in the code tree, without taking into account possible freezing constraints on symbols $u_{i}, i>j$. Note that the same probabilities were introduced in [11], [13], and shown to provide substantial reduction of the complexity of sequential decoding of polar codes.

Decoding can be implemented using the log-likelihood ratios $\overline{\mathbf{S}}_{m, i}=\overline{\mathbf{S}}_{m}^{(i)}\left(u_{0}^{i-1} \mid y_{0}^{n-1}\right)=\ln \frac{\mathbf{W}_{m}^{(i)}\left(u_{0}^{i-1} .0 \mid y_{0}^{n-1}\right)}{\mathbf{W}_{m}^{(i)}\left(u_{0}^{i-1} .1 \mid y_{0}^{n-1}\right)}$. Hence, kernel output LLRs $\overline{\mathbf{S}}_{1, i}, i \in[l]$ can be approximated by

where $b(a)^{i}=\left(b_{0}^{i-1} \cdot a \cdot b_{i+1}^{l-1}\right)$. The above expression means that $\mathbf{S}_{1, i}$ can be computed by performing ML decoding of the code, generated by last $l-i+1$ rows of the kernel $K$, assuming that all $u_{j}, i<j<l$, are equiprobable.

## B. Binary algorithm

Straightforward evaluation of (5) for arbitrary kernel has complexity $O\left(2^{l} l\right)$. However, we have a simple explicit recursive procedure for computing these values for the case of the Arikan matrix $F_{2}^{\otimes t}$.

Let $l=2^{t}$. Consider encoding scheme $c_{0}^{l-1}=v_{0}^{l-1} F_{2}^{\otimes t}$. Similarly to (4), define approximate probabilities

where $N=2^{\lambda}, a=S_{\lambda-1}^{(i)}\left(v_{0, e}^{2 i-1} \oplus v_{0, o}^{2 i-1}, y_{0, e}^{N-1}\right), b=$ $S_{\lambda-1}^{(i)}\left(v_{0, o}^{2 i-1}, y_{0, o}^{N-1}\right), \quad Q(a, b)=\operatorname{sgn}(a) \operatorname{sgn}(b) \min (|a|,|b|)$, $P(a, b, c)=(-1)^{c} a+b$. Then the log-likelihood of a path (path score) $v_{0}^{i}$ can be obtained as [14]

where $R\left(\epsilon \mid y_{0}^{l-1}\right)$ can be set to $0, \epsilon$ is an empty sequence, and

It can be verified that

where $c=v_{0}^{2^{j}-1} F_{2}^{\otimes j}$.
It was suggested in [15] to express values $\mathbf{W}_{1}^{(i)}\left(u_{0}^{i} \mid y_{0}^{l-1}\right)$ via $W_{t}^{(j)}\left(v_{0}^{j} \mid y_{0}^{l-1}\right)$ for some $j$. One can represent the kernel $K$ as $K=T F_{2}^{\otimes t}$, where $T$ is an $l \times l$ matrix. Let $v_{0}^{l-1}=u_{0}^{l-1} T$. Then, $c_{0}^{l-1}=v_{0}^{l-1} F_{2}^{\otimes t}=u_{0}^{l-1} K$, so that $u_{0}^{l-1}=v_{0}^{l-1} T^{-1}$.

Observe, that it is possible to reconstruct $u_{0}^{i}$ from $v_{0}^{\tau_{i}}$, where $\tau_{i}$ is the position of the last non-zero symbol in the $i$-th row of $T^{-1}$. Recall that successive cancellation decoding of polar codes with arbitrary kernel requires one to compute values $\mathbf{W}_{1}^{(i)}\left(u_{0}^{i} \mid y_{0}^{l-1}\right), u_{i} \in \mathbb{F}_{2}$. However, fixing the values $u_{0}^{i-1}$ may impose constraints on $v_{j}, j>\tau_{i}$, which must be taken into account while computing these probabilities.

Indeed, vectors $u_{0}^{l-1}$ and $v_{0}^{l-1}$ satisfy the equation

where $\Theta^{\prime}=(\mathbb{S} I)$, and $l \times l$ matrix $\mathbb{S}$ is obtained by transposing $T$ and reversing the order of columns in the obtained matrix. By applying elementary row operations, matrix $\Theta^{\prime}$ can be transformed into a minimum-span form $\Theta$, such that the first and last non-zero elements of the $i$-th row are located in columns $i$ and $z_{i}$, respectively, where all $z_{i}$ are distinct. This enables one to obtain symbols of vector $u$ as

[^0]where $\mathcal{Z}_{j}$ is the set of vectors $v_{0}^{h_{j}}$, such that (10) holds for $i \in[j]$. Similarly we can rewrite the above expression for the case of the approximate probabilities

Observe that computing these values requires considering multiple vectors $v_{0}^{h_{i}}$ of input symbols of the Arikan transform $F_{2}^{\otimes t}$. Let $\mathcal{D}_{i}=\left\{0, \ldots, h_{i}\right\} \backslash\left\{j_{0}, \ldots, j_{i}\right\}$ be a decoding window, i.e. the set of indices of Arikan input symbols $v_{0}^{h_{i}}$, which are not determined by symbols $u_{0}^{i-1}$. The number of such vectors, which determines the decoding complexity, is $2^{\left|\mathcal{D}_{i}\right|}$. In general, one has $\left|\mathcal{D}_{i}\right|=O(l)$ for an arbitrary kernel.

## IV. Efficient processing of $16 \times 16$ KERNELS

To minimize complexity of proposed approach (13) one needs to find kernels with small decoding windows while preserving required polarization rate ( $>0.5$ in our case) and scaling exponent. By computer search, based on heuristic algorithm presented in [8], we found a $16 \times 16$ kernel

with BEC scaling exponent $\mu\left(K_{1}\right)=3.346$ [8]. Furthermore, to minimize the size of decoding windows, we derived another kernel $K_{2}=P_{\sigma} K_{1}$, were $P_{\sigma}$ is a permutation matrix corresponding to permutation $\sigma=[0,1,2,7,3,4,5,6,9,10,11,12,8,13,14,15]$, with scaling exponent $\mu\left(K_{2}\right)=3.45$. Both kernels have polarization rate 0.51828 .

Table $\square$ presents the right hand side of expression (10) for each $i \in[16]$, as well as the corresponding decoding windows $\mathcal{D}_{i}$, for both kernels. It can be seen that the maximal decoding windows size for $K_{1}$ and $K_{2}$ is 4 and 3 , respectively. Note that by applying the row permutation to $K_{1}$, we have reduced decoding windows, but increased scaling exponent. Below we present efficient methods for computing some input symbol LLRs for these kernels.

## A. Processing of kernel $K_{1}$ with $\mu=3.346$

It can be seen that for $\phi \in\{0,1,2,13,14,15\}$ one has $\mathbf{S}_{1, \phi}=S_{4}^{(\phi)}\left(v_{0}^{\phi}, y_{0}^{15}\right)$, i.e. LLR for $F_{2}^{\otimes 4}$.

1) phase 3: In case of $\phi=3$ expressions (13) and (10) imply that the decoding window $\mathcal{D}_{3}=\{3\}$ and LLR for $u_{3}$ is given by

\mathbf{S}_{1,3}=\max _{v_{3}} R\left(\hat{v}_{0} \hat{v}_{1} \hat{v}_{2} v_{3} 0 \mid y_{0}^{15}\right)-\max _{v_{3}} R\left(\hat{v}_{0} \hat{v}_{1} \hat{v}_{2} v_{3} 1 \mid y_{0}^{15}\right)
$$

where $\hat{v}_{i}=\hat{u}_{i}, i \in[3]$, are already estimated symbols.
To obtain LLR $\mathbf{S}_{1,3}$ one should compute:

- $S_{4}^{(3)}\left(v_{0}^{2}, y_{0}^{15}\right)$ with 1 operation,
- $R\left(\hat{v}_{0} \hat{v}_{1} \hat{v}_{2} v_{3} \mid y_{0}^{15}\right)$ for $v_{3} \in[2]$. Observe that this can be done with 1 summation, since $R\left(\hat{v}_{0} \hat{v}_{1} \hat{v}_{2} v_{3} \mid y_{0}^{15}\right)=$ $R\left(\hat{v}_{0} \hat{v}_{1} \hat{v}_{2} \mid y_{0}^{15}\right)+\tau\left(S_{4}^{(3)}\left(v_{0}^{2}, y_{0}^{15}\right), v_{3}\right)$ and there is $v_{3}$ such as $\tau\left(S_{4}^{(3)}\left(v_{0}^{2}, y_{0}^{15}\right), v_{3}\right)=0$,
- $S_{4}^{(4)}\left(v_{0}^{3}, y_{0}^{15}\right)$ for $v_{3} \in[2]$ with $7 * 2$ operations,
- $R\left(\hat{v}_{0} \hat{v}_{1} \hat{v}_{2} v_{3} v_{4} \mid y_{0}^{15}\right)$ for $v_{3}, v_{4} \in[2]$ with 2 operations,
- $\max _{v_{3}} R\left(\hat{v}_{0} \hat{v}_{1} \hat{v}_{2} v_{3} v_{4} \mid y_{0}^{15}\right)$ for $v_{4} \in[2]$ with 2 operations,
- $\max _{v_{3}} R\left(\hat{v}_{0} \hat{v}_{1} \hat{v}_{2} v_{3} 0 \mid y_{0}^{15}\right)-\max _{v_{3}} R\left(\hat{v}_{0} \hat{v}_{1} \hat{v}_{2} v_{3} 1 \mid y_{0}^{15}\right)$ with 1 operation.
Total number of operations is given by 21.

2) phase 4: The decoding window is given by $\mathcal{D}_{4}=$ $\{3,5,6,7\}$ and

$$
\mathbf{S}_{1,4}=\max _{v_{0}^{8} \in \mathcal{Z}_{4,0}} R\left(v_{0}^{8} \mid y_{0}^{15}\right)-\max _{v_{0}^{8} \in \mathcal{Z}_{4,1}} R\left(v_{0}^{8} \mid y_{0}^{l-1}\right)
$$

where $\mathcal{Z}_{4, b}$ is given by the set of vectors $\left[\hat{v}_{0} \hat{v}_{1} \hat{v}_{2} v_{3} \hat{v}_{4} v_{5} v_{6} v_{7} b\right]$, $v_{3}, v_{5}, v_{6}, v_{7} \in[2]$.

Instead of exhaustive enumeration of vectors $v_{0}^{h_{j}}$ in (13), we propose to exploit the structure of $K_{1}$ to identify some common subexpressions (CSE) in formulas for $R\left(v_{0}^{h_{i}} \mid y_{0}^{l-1}\right)$ and $S_{\lambda}^{(i)}=S_{\lambda}^{(i)}\left(v_{0}^{i-1}, y_{0}^{l-1}\right)$, which can be computed once and used multiple times. In some cases computing these subexpressions reduces to decoding of well-known codes, which can be implemented with appropriate fast algorithms. Furthermore, we observe that the set of possible values of these subexpressions is less than the number of different $v_{0}^{h_{j}}$ to be considered. This results in further complexity reduction. More accurate and detailed description of CSE can be found
in [16]. To demonstrate this approach, we consider computing the LLR for $u_{4}$ of $K_{1}$.

This requires considering 16 vectors $v_{0}^{7}$ satisfying (10). According to (8), one obtains $R\left(v_{0}^{8} \mid y_{0}^{15}\right)=R\left(v_{0}^{7} \mid y_{0}^{15}\right)+$ $\tau\left(S_{4}^{(8)}\left(v_{0}^{7}, y_{0}^{15}\right), v_{8}\right)$. Observe that $\left\{v_{0}^{7} F_{2}^{\otimes 3} \mid v_{0}^{7} \in \overline{\mathcal{Z}}_{4}\right\}$ is a coset of Reed-Muller code $R M(1,3)$, where $\overline{\mathcal{Z}}_{4}$ is the set of vectors $v_{0}^{7}$, so that (10) holds for $i \in[4]$. Furthermore,

$$
R\left(v_{0}^{7} \mid y_{0}^{15}\right)=\frac{1}{2}\left(\sum_{i=0}^{7}(-1)^{c_{i}} s_{i}-\sum_{i=0}^{7}\left|s_{i}\right|\right)
$$

where $s_{i}=S_{1}^{(0)}\left(\epsilon,\left(y_{i}, y_{i+8}\right)\right), i \in[8], c_{0}^{7}=v_{0}^{7} F_{2}^{\otimes 3}$. Assume for the sake of simplicity that $v_{j}=0, j \in\{0,1,2,4\}$. Then the first term in this expression can be obtained for each $v_{0}^{7} \in \overline{\mathcal{Z}}_{4}$ via the fast Hadamard transform (FHT) [17] of vector $s$, and the second one does not need to be computed, since it cancels in (13).

It remains to compute $S_{4}^{(8)}\left(v_{0}^{7}, y_{0}^{15}\right), v_{0}^{7} \in \overline{\mathcal{Z}}_{4}$ and $\left|\overline{\mathcal{Z}}_{4}\right|=$ 16. In a straightforward implementation, one would recursively apply formulas (6) and (7) to compute $S_{4}^{(8)}$ for 16 vectors $v_{0}^{7}$. It appears that there are some CSE arising in this computation.

At first, one needs to compute $S_{1}^{(1)}\left(c_{i}, y_{i}, y_{i+8}\right), i \in$ [8], $c_{0}^{7}=v_{0}^{7} F_{2}^{\otimes 3}$. Since $c_{i} \in\{0,1\}$, the values $S_{1}^{(1)}\left(j, y_{i}, y_{i+8}\right), j \in\{0,1\}, i \in[8]$ constitute the first set of CSE. We store them in the array $L$

L[4 i+j]=S_{1}^{(1)}\left(j \bmod 2, y_{i+\bar{j}}, y_{i+8+\bar{j}}\right)
$$

where $i, j \in[4], \bar{j}=4\lfloor j / 2\rfloor$. Computing these values requires 16 summations only, instead of $16 \cdot 8=128$ summations in a straightforward implementation.

The next step is to compute the values $S_{2}^{(2)}\left(\left(c_{i}, c_{i+4}\right),\left(y_{i}, y_{i+4}, y_{i+8}, y_{i+12}\right)\right), i \in$ [4] which are equal to $Q\left(S_{1}^{(1)}\left(c_{i}, y_{i}, y_{i+8}\right), S_{1}^{(1)}\left(c_{i+4}, y_{i+4}, y_{i+12}\right)\right)$. Since $\left(c_{i}, c_{i+4}\right) \in \mathbb{F}_{2}^{2}, S_{2}^{(2)}$ gives us the second set of CSE. One can use values stored in $L$ to compute $S_{2}^{(2)}$ as

$$

Observe that for any $c_{0}^{7} \in R M(1,3)$ one has $c_{i}^{i+4} \in$ $R M(1,2), i \in\{0,4\}$. That is, one needs to consider only vectors $c_{i}^{i+4}$ of even weight while computing $S_{3}^{(4)}$. These values can be calculated as

Y[i][j+4 k]=Q(X[i][j \oplus 3 k], X[i+2][j]), i, k \in[2], j \in[4] .
$$

Finally, the values $S_{4}^{(8)}\left(v_{0}^{7}, y_{0}^{15}\right)$ can be obtained as

$$
Z[i+8 j]=Q(Y[0][i \oplus 3 j], Y[1][i]), i \in[8], j \in[2] .
$$

Each element of $Z$ corresponds to some $c_{0}^{7} \in R M(1,3)$. Finally, these values are used in (13) together with $R\left(v_{0}^{7} \mid y_{0}^{15}\right)$ to calculate $\mathbf{S}_{1,4}$.

Let us compute the number of operations required to process phase 4 . One need to compute

- $R\left(v_{0}^{7} \mid y_{0}^{15}\right)$ for $v_{0}^{7} \in \overline{\mathcal{Z}}_{4}$ via FHT with 24 operations,
- all different $S_{1}^{(1)}$ arising in CSE (array $L$ ) with 16 operations,
- all $S_{2}^{(2)}$ in CSE (array $X$ ) with 16 operations,
- all $S_{3}^{(4)}$ in CSE (array $Y$ ) with 16 operations,
- all $S_{4}^{(8)}$ in CSE (array $Z$ ) with 16 operations,
- $R\left(v_{0}^{8} \mid y_{0}^{15}\right)$ for $v_{0}^{8} \in \mathcal{Z}_{4}$ with 16 operations,
- $\max _{v_{0}^{8} \in \mathcal{Z}_{4, b}} R\left(v_{0}^{8} \mid y_{0}^{15}\right), b \in[2]$, with $15 * 2$ operations,
- $\mathbf{S}_{1,4}$ with 1 operation.

The overall complexity is given by 135 operation.
We also employ one observation to reduce the complexity of computing $\max _{v_{0}^{8} \in \mathcal{Z}_{4, b}} R\left(v_{0}^{8} \mid y_{0}^{15}\right)$. Let $s$ be a FHT of the vector $s$, where $s_{i}=S_{1}^{(0)}\left(\epsilon,\left(y_{i}, y_{i+8}\right)\right), i \in[8]$. Observe that we can compute $\arg \max _{i \in[8]}\left|s_{i}\right|$ with 7 operations and obtain $v_{3}, v_{5}, v_{6}, v_{7}$ which gives us max $R\left(v_{0}^{7} \mid y_{0}^{15}\right)$. Recall that $\tau(S, c)$ function is zero for one of $b \in[2]$, therefore, there is a value of $\hat{b}, b \in[2]$ such as $\max _{v_{0}^{8} \in \mathcal{Z}_{4, \hat{b}}} R\left(v_{0}^{8} \mid y_{0}^{15}\right)=$ $\max R\left(v_{0}^{7} \mid y_{0}^{15}\right)$. It implies that we remain need to compute $\max _{v_{0}^{8} \in \mathcal{Z}_{4,1 \oplus \hat{b}}} R\left(v_{0}^{8} \mid y_{0}^{15}\right)$. With this modification we have the complexity given by 127 operations.
3) phase 5: The decoding window $\mathcal{D}_{5}$ remains the same as in the previous phase. According to expressions (7) and (8) to obtain $\mathbf{S}_{1,5}$ one should compute:

- all $S_{4}^{(9)}$ with 16 operations,
- $R\left(v_{0}^{9} \mid y_{0}^{15}\right)$ for $v_{0}^{9} \in \mathcal{Z}_{5}$ with 16 operations,
- $\max _{v_{0}^{9} \in \mathcal{Z}_{5, b}} R\left(v_{0}^{9} \mid y_{0}^{15}\right), b \in[2]$, with 15 operations. Similarly to phase 4 , there is a value of $\hat{b} \in[2]$ such as $\max _{v_{0}^{9} \in \mathcal{Z}_{5, \hat{b}}} R\left(v_{0}^{9} \mid y_{0}^{15}\right)=\max _{v_{0}^{8} \in \mathcal{Z}_{4, v_{4}}} R\left(v_{0}^{8} \mid y_{0}^{15}\right)$,
- $\mathbf{S}_{1,5}$ with 1 operation.

Total complexity is given by 48 operations.
4) phase 6: The decoding window $\mathcal{D}_{6}=\{3,5,6,7\}$.

At this phase according to expressions (6)-(7) one should compute:

- 32 values of $S_{3}^{(5)}$ in CSE with 32 operations,
- 16 LLRs $S_{4}^{(10)}$ with 16 operations,
- $R\left(v_{0}^{10} \mid y_{0}^{15}\right)$ for $v_{0}^{10} \in \mathcal{Z}_{6}$ with 16 operations,
- $\max _{v_{0}^{10} \in \mathcal{Z}_{6, b}} R\left(v_{0}^{10} \mid y_{0}^{15}\right), b \in[2]$, with 30 operations,
- $\mathbf{S}_{1,5}$ with 1 operation.

Total complexity is given by 95 operations.
5) phase 7: At this phase the decoding window is reduced and given by $\mathcal{D}_{7}=\{5,6,7\}$. Moreover, the value $h_{7}=h_{6}=$ $v_{10}$, which means that the values $R\left(v_{0}^{10} \mid y_{0}^{15}\right)$ remains the same. We propose to use the following method: at phase 6 one should compute $\max _{\left\{v_{0}^{10} \mid v_{0}^{10} \in \mathcal{Z}_{7, b}, u_{6}=\bar{b}\right\}} R\left(v_{0}^{10} \mid y_{0}^{15}\right)$ for $b \in[2], \bar{b} \in$ [2] and obtain

$$
\max _{v_{0}^{10} \in \mathcal{Z}_{6, b}} R\left(v_{0}^{10} \mid y_{0}^{15}\right)=\max _{\bar{b} \in[2]} \max _{\left\{v_{0}^{10} \mid v_{0}^{10} \in \mathcal{Z}_{7, b}, u_{6}=\bar{b}\right\}} R\left(v_{0}^{10} \mid y_{0}^{15}\right)
$$

Once the value $u_{6}$ is determined, one can obtain $\mathbf{S}_{1,7}$ with one operation directly from already computed values $\max _{v_{0}^{10} \in \mathcal{Z}_{7, b}} R\left(v_{0}^{10} \mid y_{0}^{15}\right)$.
6) phase 8: At this phase the decoding window is increased and given by $\mathcal{D}_{8}=\{5,6,7,11\}$ and $h_{8}=12$. To obtain kernel input symbol LLR one should compute:

- 8 LLRs $S_{4}^{(11)}$ with 8 operations,
- 16 path scores $R\left(v_{0}^{11} \mid y_{0}^{15}\right)$ with 8 operations,
- 16 values $S_{2}^{(3)}$ in CSE with 16 operations,
- 32 values $S_{3}^{(6)}$ in CSE with 32 operations,
- 16 values $S_{4}^{(12)}$ with 16 operations,
- 32 path scores $R\left(v_{0}^{12} \mid y_{0}^{15}\right)$ with 16 operations,
- $\max _{v_{0}^{12} \in \mathcal{Z}_{12, b}} R\left(v_{0}^{12} \mid y_{0}^{15}\right), b$ in $[2]$ with $15 * 2$ operations,
- $\mathbf{S}_{1,12}$ with one operation.

Total complexity is given by 127 operations.
One can recursively apply approach described for phase 7, namely, construct tree of maximums of $R\left(v_{0}^{12} \mid y_{0}^{(15)}\right)$, and obtain $\mathbf{S}_{1, \phi}, 8<\phi<13$ with one operation.

## B. Processing of kernel $K_{2}$ with $\mu=3.45$

Below we briefly present a complete processing algorithm for kernel $K_{2}$. It provides much better performancecomplexity tradeoff compared to $K_{1}$. The algorithm uses the same CSE elimination techniques as described in section IV-A After the pre-computation steps for $\phi \in\{5,6,7\}$, the LLR is obtained via (13).

- For $\phi \in\{0,1,2,3,4,11,12,13,14,15\}$, compute $\mathbf{S}_{1, \phi}$ as LLRs $S_{4}^{(\phi)}\left(v_{0}^{\phi-1}, y_{0}^{15}\right)$ for the Arikan transform $F_{2}^{\otimes 4}$.
- For $\phi=5$ :

1) Since the set of vectors $c_{0}^{3}=\left[\hat{v}_{4} v_{5} v_{6} v_{7}\right] F_{2}^{\otimes 2}$ fixed $v_{i}, i \in\{0,1,2,3,4\}$, a coset of $R M(1,2)$, one can obtain 8 values of $R\left(v_{4}^{7} \mid y_{0}^{15}\right)$ (recall that $\left.R\left(v_{0}^{7} \mid y_{0}^{15}\right)=R\left(\hat{v}_{0}^{3} \mid y_{0}^{15}\right)+R\left(v_{4}^{7} \mid y_{0}^{15}\right)\right)$ from the FHT of the vector $s_{i}=S_{2}^{(1)}\left(\bar{c}_{i},\left(y_{i}, y_{4}, y_{i+8}, y_{i+12}\right)\right), i \in$ [4], $\bar{c}=\hat{v}_{0}^{3} F_{2}^{\otimes 2}$.
2) Compute
$L[i+8 j]=S_{1}^{(1)}\left(j \bmod 2, y_{i}, y_{i+8}\right), i \in[8], j \in[2]$.
3) Since $\left\{\left(c_{i}, c_{i+4}\right)\right\}=\{(0,0),(1,1)\}$, compute all possible $S_{2}^{(2)}$ values as
$X[i][j]=Q(L[i+8 j], L[i+4+8 j]), i \in[4], j \in[2]$.
4) Since $\left\{\left(c_{i}, c_{i+4}, c_{i+2}, c_{i+6}\right)\right\}$ is a code generated by $\left(\begin{array}{cccc}1 & 1 & 0 & 0 \\ 1 & 1 & 1 & 1\end{array}\right)$, compute all possible $S_{3}^{(4)}$ values as $Y[i][j]=Q(X[i][j / 2], X[i+2][j \bmod 2]), i \in$ $[2], j \in[4]$.
5) For every $c_{0}^{7}=v_{0}^{7} F_{2}$ compute $S_{4}^{(8)}\left(v_{0}^{7}, y_{0}^{15}\right)$ as
$Z[i+4 j]=Q(Y[0][i \oplus 3 j], Y[1][i]), i \in[4], j \in[2]$.

- For $\phi=6$, compute $S_{4}^{(9)}\left(v_{0}^{8}, y_{0}^{15}\right)$ as
$Z[i+4 j]=P\left(Y[0][i \oplus 3 j], Y[1][i], v_{8}\right), i \in[4], j \in[2]$.
- For $\phi=7$ :

1) Compute $S_{3}^{(5)}$ as
$\bar{Y}[0][j+4 k]=P\left(X[0][j / 2], X[2][j \bmod 2], \bar{c}_{0, k}\right)$, $\bar{Y}[1][j+4 k]=P\left(X[3]\left[\bar{j}_{k} / 2\right], X[1]\left[\bar{j}_{k} \bmod 2\right], \bar{c}_{1, k}\right)$ and $\bar{c}_{0, k}=v_{8} \oplus u_{6} \oplus k, \bar{c}_{1, k}=u_{6} \oplus k, \bar{j}_{k}=j \oplus 3$, $i \in[2], j \in[4], k \in[2]$.
2) Obtain $S_{4}^{(10)}$ as $Z[i]=Q(\bar{Y}[0][i], \bar{Y}[1][i]), i \in[8]$.

- For $\phi \in\{8,9,10\}$ : Use 16 already computed values of $R\left(v_{0}^{10} \mid y_{0}^{15}\right)$ to obtain $\mathbf{S}_{1, \phi}$.
Remark 1. Let us comment the case of $\phi=7$. In conventional Arikan SC for $F_{2}^{\otimes 4}$, after symbol $v_{9}$ is estimated, the LLRs $S_{3}^{(5)}$ for $v_{10}$ are obtained by applying $P$ function to $S_{2}^{(2)}$ and values $\left(v_{8} \oplus v_{9}, v_{8}\right)$. In the case of $K_{2}$, we do not have a fixed value for $v_{9}$. Instead, we have a constraint $u_{6}=v_{6}+v_{9}$. Therefore,

for each vector $v_{0}^{9} \in \overline{\mathcal{Z}}_{7}$ the value of $v_{9}$ is changed according to $v_{6}$. This property is taken into account in the expressions for computing of $\bar{Y}[i][j]$.

For processing of $K_{2}$ we also used trick with simplified computation of path score maximums similarly to phase 5 of $K_{1}$.

The cost, in terms of the total number of summations and comparisons, of computing $\mathbf{S}_{1, \phi}$ using the proposed algorithm is shown in Table [] The overall processing complexity is 447 and 181 operations for kernels $K_{1}$ and $K_{2}$ respectively, while the trellis-based algorithm [12] requires 7557 and 9693 operations, respectively.

The above described techniques can be also used to implement an SCL decoder for polar codes with the considered kernels, using a straightforward generalization of the algorithm and data structures presented in [2].

## V. Numeric results

We constructed $(4096,2048)$ polar codes with the considered kernels, and investigated their performance for the case of AWGN channel with BPSK modulation. The sets of frozen symbols were obtained by Monte-Karlo simulations.

Figure 1 illustrates the performance of plain polar codes, polar codes with CRC² and polar subcodes [4]. It can be seen that the codes based on kernels $K_{1}$ and $K_{2}$ with improved polarization rate $E\left(K_{1}\right)=E\left(K_{2}\right)=0.51828$ provide significant performance gain compared to polar codes with Arikan kernel. Observe also that randomized polar subcodes provide better performance compared to polar codes with CRC. Moreover, polar subcodes with kernels $K_{1}, K_{2}$ under SCL with $L=8$ have almost the same performance as polar subcodes with Arikan kernel under SCL with $L=32$. Observe also that the codes based on kernels with lower scaling exponent exhibit better performance.

Figure 2a presents simulation results for $(4096,2048)$ polar subcodes with different kernels under SCL with different $L$

at $E_{b} / N_{0}=1.25 \mathrm{~dB}$. It can be seen that the kernels with polarization rate 0.51828 require significantly lower list size $L$ to achieve the same performance as the code with the Arikan kernel. Moreover, this gap grows with $L$. This is due to improved rate of polarization, which results in smaller number of unfrozen imperfectly polarized bit subchannels. The size of the list needed to correct possible errors in these subchannels grows exponentially with their number (at least for the genieaided decoder considered in [18]). On the other hand, lower scaling exponent gives better performance with the same list $L$, but the slope of the curve remains the same for both kernels $K_{1}, K_{2}$.

Figure 2 b presents the same results in terms of the actual decoding complexity. Recall that proposed kernel processing algorithm uses only summations and comparisons. The SCL algorithm was implemented using the randomized order statistic algorithm for selection of the paths to be killed at each phase, which has complexity $O(L)$. Observe that the polar subcode based on kernel $K_{2}$ can provide better performance with the same decoding complexity for FER $\leq 8 \cdot 10^{-3}$. This is due to higher slope of the corresponding curve in Figure 2a, which eventually enables one to compensate relatively high complexity of the LLR computation algorithm presented in Section IV

Unfortunately, $K_{1}$ kernel, which provides lower scaling exponent, has greater processing complexity than $K_{2}$, so that its curve intersects the one for the Arikan kernel only at $\mathrm{FER}=2 \cdot 10^{-3}$.

## VI. Conclusions

In this paper efficient decoding algorithms for some $16 \times$ 16 polarization kernels with polarization rate 0.51828 were proposed. The algorithms compute kernel input symbols LLRs via the ones for the Arikan kernel, and exploit the structure of the codes induced by the kernel to identify and re-use the values of some common subexpressions. It was shown that in the case of SCL decoding with sufficiently large list size, the proposed approach results in lower decoding complexity compared to the case of polar (sub)codes with Arikan kernel with the same performance.

Extension of the proposed approach to the case of other kernels remains an open problem.
