# Carleman estimate for complex second order elliptic operators with discontinuous Lipschitz coefficients

#### Abstract

In this paper, we derive a local Carleman estimate for the complex second order elliptic operator with Lipschitz coefficients having jump discontinuities. Combing the result in [BL] and the arguments in [DcFLVW], we present an elementary method to derive the Carleman estimate under the optimal regularity assumption on the coefficients.


## 1 Introduction

Carleman estimates are important tools for proving the unique continuation property for partial differential equations. Additionally, Carleman estimates have been successfully applied to study inverse problems and controllability of partial differential equations. Most of Carleman estimates are proved under the assumption that the leading coefficients possess certain regularity. For example, for general second order elliptic operators, Carleman estimates were proved when the leading coefficients are at least Lipschitz [Ho3]. In general, the Lipschitz regularity assumption is the optimal condition for the unique continuation property to hold in $\mathbb{R}^{n}$ with $n \geq 3$ (see counterexamples constructed by Pliś [P] and Miller [M]). Therefore, Carleman estimates for second order elliptic operators with general discontinuous coefficients are most likely not valid. Nonetheless, recently, in the case of coefficients having jump discontinuities at an interface with homogeneous or non-homogeneous transmission conditions, one can still prove useful Carleman estimates, see, for example, Le Rousseau-Robbiano [LR1], [LR2], Le Rousseau-Lerner [LL], and [DcFLVW].

Above mentioned results are proved for real coefficients. In many real world problems, the case of complex-valued coefficients arises naturally. The modeling of the current flows in biological tissues or the propagation of the electromagnetic

[^0]waves in conductive media are typical examples. In these cases, the conductivities are complex-valued functions. On the other hand, in some situations, the conductivities are not continuous functions. For instance, in the human body, different organs have different conductivities. Therefore, to model the current flow in the human body, it is more reasonable to consider an anisotrotopic complex-valued conductivity with jump-type discontinuities [MPH].

With potential applications in mind, our goal in this paper is to derive a Carleman estimate for the second order elliptic equations with complex-valued leading coefficients having jump-type discontinuities. Although such a Carleman estimate has been derived in [BL], we want to remark that the method used in [BL], also in [LR1], [LR2], and [LL], are based on the technique of pseudodifferential operators and hence requires $C^{\infty}$ coefficients and interface; while the method in [DcFLVW] (and its parabolic counterpart, [FV]) relies on the Fourier transform and a version of partition of unity which requires only Lipschitz coefficients and $C^{1,1}$ interface. Hence, the main purpose of the paper is to extend the method in [DcFLVW], [FV] to second order elliptic operators with complex-valued coefficients. It is important to point out that even though second order elliptic operators with complex-valued coefficients can be written as a coupled second order elliptic system with real coefficients, neither the method in [LR1], [LR2], [LL] nor that in [DcFLVW] can be applied to coupled elliptic systems. Therefore, we need to work on operators with complex-valued coefficients directly.

Our strategy to derive the Carleman estimate consists of two major steps. In the first step, we treat second order elliptic operators with constant complex coefficients. Based on [BL], by checking the strong pseudoconvexity and the transmission conditions in a neighborhood of a fixed point at the interface, we can derive a Carleman estimate for second order elliptic operators with constant complex coefficients from [BL, Theorem 1.6]. We would like to mention that the result in [BL] is stated for quite general complex coefficients, but here we can only verify the transmission condition with our choice of weight functions for complex coefficients having small imaginary parts. So in this paper we will consider this case. In the second step, we extend the Carleman estimate to the operator with non-constant complex coefficients with small imaginary parts. This method in this step is taken from the argument in [DcFLVW, Section 4]. The key tool is a version of partition of unity.

Furthermore, in the second step, we need an interior Carleman estimate for second order elliptic operators having Lipschitz leading coefficients and with the weight function $\psi_{\varepsilon}$. An interior Carleman estimate was proved in [Ho1, Theorem 8.3.1], but for operators with $C^{1}$ leading coefficients. Another interior estimate was established in [Ho3, Proposition 17.2.3] for operators with Lipschitz leading coefficients, but with a different weight function. Hörmander remarked in [Ho4] (page 703, line 7-8) that "Inspection of proof of Theorem 8.3.1 in [Ho1] shows that only Lipschitz continuity was actually used in the proof." But, as far as we can check, there is no formal proof of this statement in literature. To make the paper self contained, we would like give a detailed proof of interior Carleman estimate for second order elliptic opera-
tor with Lipschitz leading coefficients and with a rather general weight function, see Proposition 4.1. This interior Carleman estimate may be useful on other occasions.

In this paper, we present a detailed and elementary derivation of the Carleman estimate for the second order elliptic equations with complex-valued coefficients having jump-type discontinuities following our method in [DcFLVW]. Having established the Carleman estimate, we then can apply the ideas in [FLVW] to prove a three-region inequality and those in [CW] to prove a three-ball inequality across the interface. With the help of the three-ball inequality, we can study the size estimate problem for the complex conductivity equation following the ideas in [CNW]. We will present these quantitative uniqueness results and the application to the size estimate in the forthcoming paper.

The paper is organized as follows. In Section 2, we introduce notations that will be used in the paper and the statement of the theorem. In Section 3, we derive a Carleman estimate for the operator having discontinuous piecewise constant coefficients. This Carleman estimate is a special case of [BL, Theorem 1.6]. Therefore, the main task of Section 3 is to check the transmission condition and the strong pseudoconvexity condition. Finally, the main Carleman estimate is proved in Section 4. The key ingredient is a partition of unity introduced in [DcFLVW].

## 2 Notations and statement of the main theorem

We will state and prove the Carleman estimate for the case where the interface is flat. Since our Carleman estimate is local near any point at the interface, for general $C^{1,1}$ interface, it can be flatten by a suitable change of coordinates. Moreover, the transformed coefficients away from the interface remain Lipschitz. Define $H_{ \pm}=\chi_{\mathbb{R}_{ \pm}^{n}}$ where $\mathbb{R}_{ \pm}^{n}=\left\{\left(x^{\prime}, x_{n}\right) \in \mathbb{R}^{n-1} \times \mathbb{R} \mid x_{n} \gtrless 0\right\}$ and $\chi_{\mathbb{R}_{ \pm}^{n}}$ is the characteristic function of $\mathbb{R}_{ \pm}^{n}$. In places we will use equivalently the symbols $\partial, \nabla$ and $D=-i \nabla$ to denote the gradient of a function and we will add the index $x^{\prime}$ or $x_{n}$ to denote gradient in $\mathbb{R}^{n-1}$ and the derivative with respect to $x_{n}$ respectively. We further denote $\partial_{\ell}=\partial / \partial x_{\ell}$, $D_{\ell}=-i \partial_{\ell}$, and $\partial_{\xi_{\ell}}=\partial / \partial \xi_{\ell}$.

Let $u_{ \pm} \in C^{\infty}\left(\mathbb{R}^{n}\right)$. We define

is a Lipschitz symmetric matrix-valued function. Assume that

where $\left(M_{\ell j}^{ \pm}\right)$and $\left(N_{\ell j}^{ \pm}\right)$are real-valued matrices and $\gamma>0$. We further assume that there exist $\lambda_{0}, \Lambda_{0}>0$ such that for all $\xi \in \mathbb{R}^{n}$ and $x \in \mathbb{R}^{n}$ we have

In the paper, we consider Lipschitz coefficients $A_{ \pm}$, i.e., there exists a constant $M_{0}>0$ such that

To treat the transmission conditions, we write

where $\nu=e_{n}$.
Let us now introduce the weight function. Let $\varphi$ be

where $\alpha_{+}, \alpha_{-}$and $\beta$ are positive numbers which will be determined later. In what follows we denote by $\varphi_{+}$and $\varphi_{-}$the restriction of the weight function $\varphi$ to $[0,+\infty)$ and to $(-\infty, 0)$ respectively. We use similar notation for any other weight functions. For any $\varepsilon>0$ let

and recall that there is a positive constant $C$, depending only on $n$, such that

so that the norm (2.13) is equivalent to the norm $\|f\|_{L^{2}\left(\mathbb{R}^{n-1}\right)}+[f]_{1 / 2, \mathbb{R}^{n-1}}$. We use the letters $C, C_{0}, C_{1}, \cdots$ to denote constants. The value of the constants may change from line to line, but it is always greater than 1.

We will denote by $B_{r}^{\prime}\left(x^{\prime}\right)$ the $(n-1)$-ball centered at $x^{\prime} \in \mathbb{R}^{n-1}$ with radius $r>0$. Whenever $x^{\prime}=0$ we denote $B_{r}^{\prime}=B_{r}^{\prime}(0)$. Likewise, we denote $B_{r}(x)$ be the $n$-ball centered at $x \in \mathbb{R}^{n}$ with radius $r>0$ and $B_{r}=B_{r}(0)$.

Theorem 2.1 Let $u$ and $A_{ \pm}(x)$ satisfy (2.1)-(2.9). There exist $\alpha_{+}, \alpha_{-}, \beta, \delta_{0}, r_{0}, \gamma_{0}$ and $C$ depending on $\lambda_{0}, \Lambda_{0}, M_{0}$ such that if $\gamma<\gamma_{0}, \delta \leq \delta_{0}$ and $\tau \geq C$, then

where $u=H_{+} u_{+}+H_{-} u_{-}, u_{ \pm} \in C^{\infty}\left(\mathbb{R}^{n}\right)$ and $\operatorname{supp} u \subset B_{\delta r_{0}}^{\prime} \times\left[-\delta r_{0}, \delta r_{0}\right]$, and $\phi_{\delta}$ is given by (2.12).

Remark 2.2 Estimate (2.14) is a local Carleman estimate near $x_{n}=0$. As mentioned above, by flattening the interface, we can derive a local Carleman estimate near a $C^{1,1}$ interface from (2.14). Nonetheless, an estimate like (2.14) is sufficient for some applications such as the inverse problem of estimating the size of an inclusion by one pair of boundary measurement (see, for example, [FLVW]).

## 3 Carleman estimate for operators with constant coefficients

The purpose of this section is to derive (2.14) for $\mathcal{L}(x, D)$ with discontinuous piecewise constant coefficients. More precisely, we derive (2.14) for $\mathcal{L}_{0}(D)$, where $\mathcal{L}_{0}(D)$ is
obtained from $\mathcal{L}(x, D)$ by freezing the variable $x$ at $\left(x_{0}^{\prime}, 0\right)$. Without loss of generality, we take $\left(x_{0}^{\prime}, 0\right)=(0,0)=0$ and thus

Since $\mathcal{L}_{0}$ has piecewise constant coefficients, to prove (2.14), we will apply [BL, Theorem 1.6]. So the task here is to verify the strong pseudoconvexity and transmission conditions for operator $\mathcal{L}_{0}$ with the weight function given in (2.11).

To streamline the presentation, we define $\Omega_{1}:=\left\{x_{n}<0\right\}, \Omega_{2}:=\left\{x_{n}>0\right\}$. On each side of the interface, we have complex second order elliptic operators. We denote

where $a_{\ell j}^{(1)}=a_{\ell j}^{-}$and $a_{\ell j}^{(2)}=a_{\ell j}^{+}$. Here we denote $a_{\ell j}^{(k)}=a_{\ell j}^{(k)}(0)$. Corresponding to (2.3)-(2.6), we have

Since some computations in the verification of the transmission conditions are useful in proving the strong pseudoconvexity condition, we will begin with the discussion of the transmission conditions at the interface $\left\{x_{n}=0\right\}$.

### 3.1 Transmission conditions

We consider the natural transmission conditions that use the interface operators

that correspond to the continuity of the solution and of the normal flux, respectively. We now write the weight function

with $\alpha_{1}, \alpha_{2}>0$ (corresponding to $\alpha_{-}$and $\alpha_{+}$in (2.10), respectively) and $\beta>0$. Notice that $\varphi$ is smooth in $\Omega_{1}, \Omega_{2}$ and is continuous across the interface. Then we have

Following the notations and the calculations in [BL, Section 1.7.1], we have for $\omega:=\left(0, \xi^{\prime}, \nu, \tau\right)$ with $\xi^{\prime}=\left(\xi_{1}, \cdots, \xi_{n-1}\right) \neq 0, \nu=e_{n}$ and $\lambda \in \mathbb{C}$,

= & a_{n n}^{(k)}\left[\left((-1)^{k} \lambda+i \tau \alpha_{k}+\sum_{1 \leq j \leq n-1} \frac{a_{n j}^{(k)}}{a_{n n}^{(k)}} \xi_{j}\right)^{2}+b_{k}\left(\xi^{\prime}\right)\right] .
\end{align*}
$$

Let us introduce $A^{(k)}, B^{(k)} \in \mathbb{R}$ for $k=1,2$ such that

Definition 3.1 The pair $\left\{P_{k}, \psi_{\varepsilon}, T_{k}^{j}, k=1,2, j=1,2\right\}$ satisfies the transmission condition at $\omega$ if for any polynomials $q_{1}(\lambda), q_{2}(\lambda)$, there exist polynomials $U_{1}(\lambda), U_{2}(\lambda)$ and constant $c_{1}, c_{2}$ such that

In order to check the transmission conditions, we need to study the polynomial $K_{k, \psi_{\varepsilon}}(\omega, \lambda)$. For this reason, we need to determine the signs of the imaginary parts of the roots $\sigma_{j}^{(k)}$ defined above. Note that we can write

= & \xi_{n}^{2}+2 b_{0}^{(k)}\left(\xi^{\prime}\right) \xi_{n}+b_{1}^{(k)}\left(\xi^{\prime}\right),
\end{align*}

Then for any polynomial $q_{1}(\lambda)$, we choose $U_{1}(\lambda)$ to be the quotient of the division between $q_{1}$ and $K_{1, \psi_{\varepsilon}}$. The remainder term is equal to $c_{1} \tilde{t}_{1, \psi_{\varepsilon}}+c_{2} \tilde{t}_{2, \psi_{\varepsilon}}$ with suitable $c_{1}, c_{2}$.

Case 2. Assume that $\operatorname{Im} \sigma_{2}^{(2)} \geq 0$ and $\operatorname{Im} \sigma_{2}^{(1)} \geq 0$, i.e.,

Therefore, if

$$
\begin{equation*}
a_{n n}^{(2)}\left(B^{(2)}+i A^{(2)}\right)+a_{n n}^{(1)}\left(B^{(1)}+i A^{(1)}\right) \neq 0, \tag{3.26}
\end{equation*}
$$

then the transmission condition holds.
We now verify (3.26). In the real case where $a_{n n}^{(2)}, a_{n n}^{(1)}$ are positive real numbers, it is easy to see that

$$
a_{n n}^{(2)} A^{(2)}+a_{n n}^{(1)} A^{(1)}>0
$$

and thus (3.26) holds.
For the complex case, we want to show that there exists $\gamma_{0}>0$ such that if $\gamma<\gamma_{0}$, then (3.26) is satisfied. Let $u_{k}=A^{(k)}+i B^{(k)}$ and $v_{k}=i u_{k}=-B^{(k)}+i A^{(k)}$. We will consider $u_{k}$ and $v_{k}$ as vectors in $\mathbb{R}^{2}$, i.e., $u_{k}=\left(A^{(k)}, B^{(k)}\right), v_{k}=u_{k}^{\perp}=\left(-B^{(k)}, A^{(k)}\right)$. Let $a_{n n}^{(k)}=\eta^{(k)}+i \gamma \delta^{(k)}$ for $\eta^{(k)}, \delta^{(k)} \in \mathbb{R}$. By the ellipticity conditions (3.3), (3.4), we have

$$
\lambda_{0} \leq \eta^{(k)} \leq \Lambda_{0}, \quad \lambda_{0} \leq \delta^{(k)} \leq \Lambda_{0}
$$

Notice that $\operatorname{det} T=0$ if and only if

$$
\left(\eta^{(2)}+i \gamma \delta^{(2)}\right)\left(B^{(2)}+i A^{(2)}\right)+\left(\eta^{(1)}+i \gamma \delta^{(1)}\right)\left(B^{(1)}+i A^{(1)}\right)=0,
$$

i.e.,

$$
\begin{aligned}
& \left(\eta^{(2)} B^{(2)}-\gamma \delta^{(2)} A^{(2)}+\eta^{(1)} B^{(1)}-\gamma \delta^{(1)} A^{(1)}\right) \\
& \quad+i\left(\eta^{(2)} A^{(2)}+\gamma \delta^{(2)} B^{(2)}+\eta^{(1)} A^{(1)}+\gamma \delta^{(1)} B^{(1)}\right)=0,
\end{aligned}
$$

which is equivalent to

$$
\begin{equation*}
\eta^{(2)}\binom{A^{(2)}}{B^{(2)}}+\eta^{(1)}\binom{A^{(1)}}{B^{(1)}}=\gamma \delta^{(2)}\binom{-B^{(2)}}{A^{(2)}}+\gamma \delta^{(1)}\binom{-B^{(1)}}{A^{(1)}} \tag{3.27}
\end{equation*}
$$

or simply

$$
\begin{equation*}
\eta^{(2)} u_{2}+\eta^{(1)} u_{1}=\gamma \delta^{(2)} v_{2}+\gamma \delta^{(1)} v_{1} . \tag{3.28}
\end{equation*}
$$

Recall that $A^{(k)} \geq\left|F^{(k)}\right|>0$. Therefore, in the real case $\gamma \delta^{(k)}=0$, then (3.27) will never be satisfied. If $B^{(1)}$ and $B^{(2)}$ have the same sign, that is, either $B^{(k)} \geq 0$ or $B^{(k)} \leq 0$ for $k=1,2$, (3.28) can not hold. To see this, let us consider $B^{(k)} \geq 0$,
$k=1,2$. Then $u_{1}, u_{2}$ are in the first quadrant of the plane and $v_{1}, v_{2}$ are in the second quadrant of the plane. The sets

$$
C_{u}=\left\{\eta^{(2)} u_{2}+\eta^{(1)} u_{1}: \eta^{(k)} \geq 0\right\}, \quad C_{u}=\left\{\gamma \delta^{(2)} v_{2}+\gamma \delta^{(1)} v_{1}: \gamma \delta^{(k)} \geq 0\right\}
$$

can only intersect at the original. Same thing happens if $B^{(k)} \leq 0$ for $k=1,2$.
The only case we need to investigate is when $B^{(1)}$ and $B^{(2)}$ have different signs. For example, let us assume

$$
B^{(1)}>0, \quad B^{(2)}<0 .
$$

Even in this case, the intersection between $C_{u}$ and $C_{v}$ is non-trivial if the angle $\phi$ between $u_{1}$ and $u_{2}$ is less than $\pi / 2$. Note that $u_{1}$ is the first quadrant and $u_{2}$ is in the fourth quadrant. So the angle between $u_{1}$ and $u_{2}$ is less than $\pi$. We would like to show that (3.28) cannot hold for $\phi \in\left[\pi / 2, \pi\right.$ ) if we choose $\gamma_{0}$ small enough.

Note that in this case $\cos \phi \leq 0$. To do so, we estimate $\left\|\eta^{(2)} u_{2}+\eta^{(1)} u_{1}\right\|$ from below and $\left\|\delta^{(2)} v_{2}+\delta^{(1)} v_{1}\right\|$ from above. We now discuss the estimate of $\left\|\delta^{(2)} v_{2}+\delta^{(1)} v_{1}\right\|$ from above. Compute

$$
\begin{align*}
\left\|\delta^{(2)} v_{2}+\delta^{(1)} v_{1}\right\|^{2} & =\left(\delta^{(2)}\right)^{2}\left[\left(A^{(2)}\right)^{2}+\left(B^{(2)}\right)^{2}\right]+\left(\delta^{(1)}\right)^{2}\left[\left(A^{(1)}\right)^{2}+\left(B^{(1)}\right)^{2}\right] \\
& +2 \delta^{(1)} \delta^{(2)}\left(-B^{(2)}, A^{(2)}\right) \cdot\left(-B^{(1)}, A^{(1)}\right) \\
& =\left(\delta^{(2)}\right)^{2}\left[\left(A^{(2)}\right)^{2}+\left(B^{(2)}\right)^{2}\right]+\left(\delta^{(1)}\right)^{2}\left[\left(A^{(1)}\right)^{2}+\left(B^{(1)}\right)^{2}\right]  \tag{3.29}\\
& +2 \delta^{(1)} \delta^{(2)}\left[\left(A^{(2)}\right)^{2}+\left(B^{(2)}\right)^{2}\right]^{1 / 2}\left[\left(A^{(1)}\right)^{2}+\left(B^{(1)}\right)^{2}\right]^{1 / 2} \cos \phi \\
& \leq\left(\delta^{(2)}\right)^{2}\left[\left(A^{(2)}\right)^{2}+\left(B^{(2)}\right)^{2}\right]+\left(\delta^{(1)}\right)^{2}\left[\left(A^{(1)}\right)^{2}+\left(B^{(1)}\right)^{2}\right] .
\end{align*}
$$

In view of (3.9) and (3.11), we have

$$
\begin{align*}
\left(A^{(k)}\right)^{2}+\left(B^{(k)}\right)^{2}=\left|b_{k}\right| & =\left|\sum_{1 \leq \ell, j \leq n-1} \frac{a_{\ell j}^{(k)}}{a_{n n}^{(k)}} \xi_{\ell} \xi_{j}-\left(E^{(k)}+i F^{(k)}\right)^{2}\right|  \tag{3.30}\\
& \leq\left|\sum_{1 \leq \ell, j \leq n-1} \frac{a_{\ell j}^{(k)}}{a_{n n}^{(k)}} \xi_{\ell} \xi_{j}\right|+\left|\left(E^{(k)}+i F^{(k)}\right)^{2}\right|
\end{align*}
$$

By (3.3), (3.4), and (3.12), we can obtain

$$
\begin{aligned}
& \left|\sum_{1 \leq \ell, j \leq n-1} \frac{a_{\ell j}^{(k)}}{a_{n n}^{(k)}} \xi_{\ell} \xi_{j}\right|^{2}=\left|\frac{1}{a_{n n}^{(k)}} \mathcal{A}^{(k)} \xi \cdot \xi\right|^{2}\left(\text { with } \xi=\left(\xi^{\prime}, 0\right)\right) \\
& =\left|a_{n n}^{(k)}\right|^{-2}\left|\cos \theta M^{(k)} \xi \cdot \xi+\gamma \sin \theta N^{(k)} \xi \cdot \xi+i\left(-\sin \theta M^{(k)} \xi \cdot \xi+\gamma \cos \theta N^{(k)} \xi \cdot \xi\right)\right|^{2} \\
& =\left|a_{n n}^{(k)}\right|^{-2}\left[\left(M^{(k)} \xi \cdot \xi\right)^{2}+\gamma^{2}\left(N^{(k)} \xi \cdot \xi\right)^{2}\right] \\
& \leq \frac{\Lambda^{2}\left(1+\gamma^{2}\right)|\xi|^{4}}{\lambda_{0}^{2}\left(1+\gamma^{2}\right)}=\tilde{\lambda}_{1}^{-1}|\xi|^{4},
\end{aligned}
$$

where we have used the estimate

$$
\begin{equation*}
\lambda_{0}\left(1+\gamma^{2}\right)^{1 / 2} \leq\left|a_{n n}^{(k)}\right| \leq \Lambda_{0}\left(1+\gamma^{2}\right)^{1 / 2} \tag{3.31}
\end{equation*}
$$

in deriving the inequality above. We thus obtain

\left|\sum_{1 \leq \ell, j \leq n-1} \frac{a_{\ell j}^{(k)}}{a_{n n}^{(k)}} \xi_{\ell} \xi_{j}\right| \leq \tilde{\lambda}_{1}^{-1 / 2}\left|\xi^{\prime}\right|^{2} \tag{3.32}
\end{equation*}
$$

Furthermore, we can estimate

$$
\begin{align*}
\left|\left(E^{(k)}+i F^{(k)}\right)^{2}\right| & =\left|\left(\sum_{1 \leq j \leq n-1} \frac{a_{n j}^{(k)}}{a_{n n}^{(k)}} \xi_{j}\right)^{2}\right|=\left|\sum_{1 \leq j \leq n-1} \frac{a_{n j}^{(k)}}{a_{n n}^{(k)}} \xi_{j}\right|^{2} \\
& \leq\left(\sum_{1 \leq j \leq n-1}\left|\frac{a_{n j}^{(k)}}{a_{n n}^{(k)}}\right|^{2}\right)\left|\xi^{\prime}\right|^{2} \leq \frac{(n-1) \Lambda_{0}^{2}\left(1+\gamma^{2}\right)}{\lambda_{0}^{2}\left(1+\gamma^{2}\right)}\left|\xi^{\prime}\right|^{2}  \tag{3.33}\\
& =(n-1) \tilde{\lambda}_{1}^{-1}\left|\xi^{\prime}\right|^{2} .
\end{align*}
$$

Substituting (3.32), (3.33) into (3.30) gives

$$
\begin{equation*}
\left(A^{(k)}\right)^{2}+\left(B^{(k)}\right)^{2} \leq\left(\tilde{\lambda}_{1}^{-1 / 2}+(n-1) \tilde{\lambda}_{1}^{-1}\right)\left|\xi^{\prime}\right|^{2} \leq n \frac{\Lambda_{0}^{2}}{\lambda_{0}^{2}}\left|\xi^{\prime}\right|^{2} \tag{3.34}
\end{equation*}
$$

It follows from (3.29) and (3.34) that

\begin{equation*}
\left\|\delta^{(2)} v_{2}+\delta^{(1)} v_{1}\right\|^{2} \leq 2 \Lambda_{0}^{2} n \frac{\Lambda_{0}^{2}}{\lambda_{0}^{2}}\left|\xi^{\prime}\right|^{2} \tag{3.35}
\end{equation*}
$$

Next, we want to estimate $\left\|\eta^{(2)} u_{2}+\eta^{(1)} u_{1}\right\|$ from below. As above, we have

$$
\begin{align*}
\left\|\eta^{(2)} u_{2}+\eta^{(1)} u_{1}\right\|^{2} & =\left(\eta^{(2)}\right)^{2}\left[\left(A^{(2)}\right)^{2}+\left(B^{(2)}\right)^{2}\right]+\left(\eta^{(1)}\right)^{2}\left[\left(A^{(1)}\right)^{2}+\left(B^{(1)}\right)^{2}\right] \\
& +2 \eta^{(1)} \eta^{(2)}\left[\left(A^{(2)}\right)^{2}+\left(B^{(2)}\right)^{2}\right]^{1 / 2}\left[\left(A^{(1)}\right)^{2}+\left(B^{(1)}\right)^{2}\right]^{1 / 2} \cos \phi . \tag{3.36}
\end{align*}
$$

Recall that $B_{1}>0, B_{2}<0$. Thus,

\begin{aligned}
\cos \phi & =\frac{A^{(1)} A^{(2)}+B^{(1)} B^{(2)}}{\left[\left(A^{(2)}\right)^{2}+\left(B^{(2)}\right)^{2}\right]^{1 / 2}\left[\left(A^{(1)}\right)^{2}+\left(B^{(1)}\right)^{2}\right]^{1 / 2}} \\
& =\frac{A^{(1)} A^{(2)}-\left|B^{(1)}\right|\left|B^{(2)}\right|}{\left[\left(A^{(2)}\right)^{2}+\left(B^{(2)}\right)^{2}\right]^{1 / 2}\left[\left(A^{(1)}\right)^{2}+\left(B^{(1)}\right)^{2}\right]^{1 / 2}} \\
& =\frac{1-\frac{\left|B^{(1)}\right|}{A^{(1)}} \frac{\left|B^{(2)}\right|}{A^{(2)}}}{\left(1+\left(\frac{B^{(2)}}{A^{(2)}}\right)^{2}\right)^{1 / 2}\left(1+\left(\frac{B^{(1)}}{A^{(1)}}\right)^{2}\right)^{1 / 2}} .
\end{aligned}
$$

Notice that by (3.19) and (3.35)

0 \leq \frac{\left|B^{(k)}\right|}{A^{(k)}} \leq \frac{\sqrt{\left(A^{(k)}\right)^{2}+\left(B^{(k)}\right)^{2}}}{A^{(k)}} \leq \frac{\sqrt{n} \frac{\Lambda_{0}}{\lambda_{0}}\left|\xi^{\prime}\right|}{\sqrt{\tilde{\lambda}_{1}}\left|\xi^{\prime}\right|}=\frac{\sqrt{n} \Lambda_{0}^{2}}{\lambda_{0}^{2}}:=\tilde{\lambda}_{2} \geq 1 .
$$

It is readily seen that the function

$$
f(x, y)=\frac{1-x y}{\sqrt{1+x^{2}} \sqrt{1+y^{2}}}
$$

defined on $(x, y) \in\left[0, \tilde{\lambda}_{2}\right] \times\left[0, \tilde{\lambda}_{2}\right]$ attains its minimum at $x=y=\tilde{\lambda}_{2}$. Hence, we have

\cos \phi \geq \frac{1-\tilde{\lambda}_{2}^{2}}{1+\tilde{\lambda}_{2}^{2}}=-1+\frac{2}{1+\tilde{\lambda}_{2}^{2}}
$$

Now (3.36) gives

&\left\|\eta^{(2)} u_{2}+\eta^{(1)} u_{1}\right\|^{2} \\
& \geq\left(\eta^{(2)}\right)^{2}\left[\left(A^{(2)}\right)^{2}+\left(B^{(2)}\right)^{2}\right]+\left(\eta^{(1)}\right)^{2}\left[\left(A^{(1)}\right)^{2}+\left(B^{(1)}\right)^{2}\right] \\
&+2 \eta^{(1)} \eta^{(2)}\left[\left(A^{(2)}\right)^{2}+\left(B^{(2)}\right)^{2}\right]^{1 / 2}\left[\left(A^{(1)}\right)^{2}+\left(B^{(1)}\right)^{2}\right]^{1 / 2}\left(-1+\frac{2}{1+\tilde{\lambda}_{2}^{2}}\right) \\
&=\left(\left(\eta^{(2)}\right)^{2}\left[\left(A^{(2)}\right)^{2}+\left(B^{(2)}\right)^{2}\right]^{1 / 2}-\left(\eta^{(1)}\right)^{2}\left[\left(A^{(1)}\right)^{2}+\left(B^{(1)}\right)^{2}\right]^{1 / 2}\right)^{2}  \tag{3.37}\\
&+\frac{4}{1+\tilde{\lambda}_{2}^{2}} \eta^{(1)} \eta^{(2)}\left[\left(A^{(2)}\right)^{2}+\left(B^{(2)}\right)^{2}\right]^{1 / 2}\left[\left(A^{(1)}\right)^{2}+\left(B^{(1)}\right)^{2}\right]^{1 / 2} \\
& \quad \geq \frac{4}{1+\tilde{\lambda}_{2}^{2}} A^{(1)} A^{(2)} \lambda_{0}^{2} \geq \frac{4}{1+\tilde{\lambda}_{2}^{2}} \tilde{\lambda}_{1}\left|\xi^{\prime}\right|^{2} \lambda_{0}^{2}=\frac{4}{1+\tilde{\lambda}_{2}^{2}} \frac{\lambda_{0}^{4}}{\Lambda_{0}^{2}}\left|\xi^{\prime}\right|^{2} .
\end{align*}
$$

Hence, in view of (3.35), (3.37), if we choose

\begin{equation*}
\gamma_{0}=\frac{\sqrt{2} \lambda_{0}^{5}}{\Lambda_{0}^{3} \sqrt{n \lambda_{0}^{4}+n^{2} \Lambda_{0}^{4}}}, \tag{3.38}
\end{equation*}

then for $\gamma<\gamma_{0}$ we have

\left\|\eta^{(2)} u_{2}+\eta^{(1)} u_{1}\right\|^{2}>\gamma^{2}\left\|\delta^{(2)} v_{2}+\delta^{(1)} v_{1}\right\|^{2}
$$

In other words, (3.28) cannot hold (i.e., $\operatorname{det} T \neq 0$ ), and equivalently, (3.26) is satisfied. In conclusion, we have shown that
Theorem 3.2 Assume that $a_{\ell j}^{(k)}$ have properties (3.1)-(3.4). Moreover, the number $\gamma$ in (3.2) satisfies $\gamma<\gamma_{0}$, where $\gamma_{0}$ is defined in (3.38). Let $\psi_{\varepsilon}$ be given by (3.5) with $a_{1}, a_{2}$ satisfying (3.23). The $\left\{P_{k}, \psi_{\varepsilon}, T_{k}^{j}, k=1,2, j=1,2\right\}$ satisfies the transmission condition at 0 .

### 3.2 Strong pseudoconvexity

Here we want to check the strong pseudoconvexity condition for the operator $\mathcal{L}_{0}$ and the weight function $\psi_{\varepsilon}(x)$ in $B_{\delta^{\prime}} \cap \Omega_{1}$ and $B_{\delta^{\prime}} \cap \Omega_{2}$ for some small $\delta^{\prime}>0$. Even though $\mathcal{L}_{0}$ is represented by $P_{k}$ in $\Omega_{k}, k=1,2$, it is not necessary to discuss the
strong pseudoconvexity condition for $P_{1}$ and $P_{2}$ separately. We suppress the index $k$ in notations and denote the symbol

$$
p(\xi)=\sum_{1 \leq j, \ell \leq n} a_{\ell j} \xi_{\ell} \xi_{j}
$$

with $a_{\ell j}=M_{\ell j}+i \gamma N_{\ell j}$ and consider the weight function

$$
\psi_{\varepsilon}(x)=\alpha x_{n}+\frac{\beta}{2} x_{n}^{2}-\frac{\varepsilon}{2}\left|x^{\prime}\right|^{2}
$$

In view of the definition of $\psi_{\varepsilon}(x)$ in (2.10), $\alpha$ here represents either $\alpha_{2}=\alpha_{+}$or $\alpha_{1}=\alpha_{-}$. Hence, we have that

\left(\partial_{j} \psi_{\varepsilon}(x)\right)_{j=1}^{n}=\nabla \psi_{\varepsilon}(x)=\left(-\varepsilon x^{\prime}, \alpha+\beta x_{n}\right)
$$

and

$$
\left(\partial_{\ell j}^{2} \psi_{\varepsilon}(x)\right)_{\ell, j=1}^{n}=\nabla^{2} \psi_{\varepsilon}(x)=\left(\begin{array}{cc}
-\varepsilon I_{n-1} & 0  \tag{3.39}\\
0 & \beta
\end{array}\right) .
$$

The strong pseudoconvexity condition reads that in $B_{\delta^{\prime}}$, if

\left\{\begin{array}{l}
p\left(\xi+i \tau \nabla \psi_{\varepsilon}(x)\right)=0, \\
(\xi, \tau) \neq 0, \quad \nabla \psi_{\varepsilon}(x) \neq 0, \quad x \in \overline{B_{\delta^{\prime}}}
\end{array}\right.
$$

then

$$
\begin{align*}
Q(x, \xi, \tau):= & \sum_{\ell, j=1}^{n} \partial_{\ell j}^{2} \psi_{\varepsilon}(x) \partial_{\xi_{j}} p\left(\xi+i \tau \nabla \psi_{\varepsilon}(x)\right) \overline{\partial_{\xi_{\ell}} p\left(\xi+i \tau \nabla \psi_{\varepsilon}(x)\right)} \\
& +\frac{1}{\tau} \operatorname{Im} \sum_{j=1}^{n} \partial_{j} p\left(\xi+i \tau \nabla \psi_{\varepsilon}(x)\right) \overline{\partial_{\xi_{j}} p\left(\xi+i \tau \nabla \psi_{\varepsilon}(x)\right)}  \tag{3.40}\\
= & \sum_{\ell, j=1}^{n} \partial_{\ell j}^{2} \psi_{\varepsilon}(x) \partial_{\xi_{j}} p\left(\xi+i \tau \nabla \psi_{\varepsilon}(x)\right) \overline{\partial_{\xi_{\ell}} p\left(\xi+i \tau \nabla \psi_{\varepsilon}(x)\right)}>0
\end{align*}
$$

(see [Ho1]).
We now write

\begin{aligned}
& p\left(\xi+i \tau \nabla \psi_{\varepsilon}\right) \\
= & \sum_{1 \leq \ell, j \leq n} a_{\ell j}\left(\xi_{\ell}+i \tau \partial_{\ell} \psi_{\varepsilon}\right)\left(\xi_{\ell}+i \tau \partial_{\ell} \psi_{\varepsilon}\right) \\
= & \sum_{1 \leq \ell, j \leq n} a_{\ell j} \xi_{\ell} \xi_{j}+2 i \sum_{1 \leq \ell, j \leq n} a_{\ell j} \xi_{l}\left(\tau \partial_{j} \psi_{\varepsilon}\right)-\sum_{1 \leq \ell j \leq n} a_{\ell j}\left(\tau \partial_{\ell} \psi_{\varepsilon}\right)\left(\tau \partial_{j} \psi_{\varepsilon}\right) .
\end{aligned}
$$

Hence $p\left(\xi+i \tau \nabla \psi_{\varepsilon}\right)=0$ implies

\sum_{1 \leq \ell j \leq n} a_{\ell j}\left(\tau \partial_{\ell} \psi_{\varepsilon}\right)\left(\tau \partial_{j} \psi_{\varepsilon}\right)=\sum_{1 \leq \ell, j \leq n} a_{\ell j} \xi_{\ell} \xi_{j}+2 i \sum_{1 \leq \ell, j \leq n} a_{\ell j} \xi_{l}\left(\tau \partial_{j} \psi_{\varepsilon}\right) \tag{3.41}
\end{equation*}
$$

By (3.2)-(3.4), we have

\left|\sum_{1 \leq \ell \leq n} a_{\ell j}\left(\tau \partial_{\ell} \psi_{\varepsilon}\right)\left(\tau \partial_{j} \psi_{\varepsilon}\right)\right| \leq \sqrt{1+\gamma^{2}} \Lambda_{0}\left|\tau \nabla \psi_{\varepsilon}\right|^{2} .
$$

From this estimate, we obtain from (3.41) that

\sqrt{1+\gamma^{2}} \Lambda_{0}\left|\tau \nabla \psi_{\varepsilon}\right|^{2} & \geq\left|\sum_{1 \leq \ell, j \leq n} a_{\ell j} \xi_{\ell} \xi_{j}+2 i \sum_{1 \leq \ell, j \leq n} a_{\ell j} \xi_{l}\left(\tau \partial_{j} \psi_{\varepsilon}\right)\right| \\
& \geq \sqrt{1+\gamma^{2}} \lambda_{0}|\xi|^{2}-2 \sqrt{1+\gamma^{2}} \Lambda_{0}|\xi|\left|\tau \nabla \psi_{\varepsilon}\right| \\
& \geq \sqrt{1+\gamma^{2}} \lambda_{0}|\xi|^{2}-\frac{\sqrt{1+\gamma^{2}} \lambda_{0}}{2}|\xi|^{2}-2 \frac{\sqrt{1+\gamma^{2}} \Lambda_{0}^{2}}{\lambda_{0}}\left|\tau \nabla \psi_{\varepsilon}\right|^{2} \tag{3.42}
\end{align*}
$$

which leads to

$$
\begin{equation*}
\frac{\lambda_{0}}{2}|\xi|^{2} \leq\left(\Lambda_{0}+\frac{2 \Lambda_{0}^{2}}{\lambda_{0}}\right)\left|\tau \nabla \psi_{\varepsilon}\right|^{2} \tag{3.43}
\end{equation*}
$$

By (3.43) and exchanging the roles of $\xi$ and $\tau \nabla \psi_{\varepsilon}$ in (3.42), we thus conclude that there exist positive constants $C_{1}, C_{2}$, depending on $\lambda_{0}, \Lambda_{0}$ such that

C_{1}|\xi| \leq\left|\tau \nabla \psi_{\varepsilon}\right| \leq C_{2}|\xi| \tag{3.44}
\end{equation*}
$$

whenever $p\left(\xi+i \tau \nabla \psi_{\varepsilon}\right)=0$.
As in (3.6) and (3.7), we can write

b\left(\xi^{\prime}\right)=\frac{1}{a_{n n}^{2}} \sum_{1 \leq \ell, j \leq n-1}\left(a_{\ell j} a_{n n}-a_{n \ell} a_{n j}\right) \xi_{\ell} \xi_{j} .
$$

Similar to (3.9) and (3.10), we further express

b\left(\xi^{\prime}\right)=\left(A\left(\xi^{\prime}\right)-i B\left(\xi^{\prime}\right)\right)^{2} \tag{3.45}
\end{equation*}
$$

with $A\left(\xi^{\prime}\right) \geq 0$ and

\begin{equation*}
\sum_{1 \leq j \leq n-1} \frac{a_{n j}}{a_{n n}} \xi_{j}=E\left(\xi^{\prime}\right)+i F\left(\xi^{\prime}\right) \tag{3.46}
\end{equation*}
$$

where $E\left(\xi^{\prime}\right), F\left(\xi^{\prime}\right) \in \mathbb{R}$.
To verify that (3.40) for $x$ near 0 , we first derive an estimate of $Q(0, \xi, \tau)$. At $x=0$, we have $\partial_{j} \psi_{\varepsilon}(0)=0,1 \leq j \leq n-1$ and $\partial_{n} \psi_{\varepsilon}(0)=\alpha$, i.e.,

\end{equation*}

where

\sigma_{1}=-E-B-i(\tau \alpha+F+A)  \tag{3.48}\\
\sigma_{2}=-E+B-i(\tau \alpha+F-A)
\end{array}\right.
$$

From now on we suppress the dependence of coefficients at 0 if there is no danger of causing confusion.

By (3.39), we have that

Q(0, \xi, \tau)=-\varepsilon \sum_{1 \leq j \leq n-1}\left|\partial_{\xi_{j}} p\left(\xi+i \tau \alpha e_{n}\right)\right|^{2}+\beta\left|\partial_{\xi_{n}} p\left(\xi+i \tau \alpha e_{n}\right)\right|^{2}
$$

where for $1 \leq j \leq n-1$

$$
\partial_{\xi_{j}} p\left(\xi+i \tau \alpha e_{n}\right)=2 \sum_{1 \leq \ell \leq n-1} a_{\ell j} \xi_{\ell}+a_{n j}\left(\xi_{n}+i \tau \alpha\right)
$$

and

$$
\partial_{\xi_{n}} p\left(\xi+i \tau \alpha e_{n}\right)=2 \sum_{1 \leq \ell \leq n-1} a_{\ell n} \xi_{\ell}+a_{n n}\left(\xi_{n}+i \tau \alpha\right) .
$$

Therefore, we can write

Q(0, \xi, \tau)= & -4 \varepsilon \sum_{1 \leq j \leq n-1}\left|\sum_{1 \leq \ell \leq n-1} a_{\ell j} \xi_{\ell}+a_{n j}\left(\xi_{n}+i \tau \alpha\right)\right|^{2} \\
& +4 \beta\left|\sum_{1 \leq \ell \leq n-1} a_{\ell n} \xi_{\ell}+a_{n n}\left(\xi_{n}+i \tau \alpha\right)\right|^{2} . \tag{3.49}
\end{align*}
$$

It follows from (3.47) and (3.48) that $p\left(\xi+i \tau \alpha e_{n}\right)=0$ if and only if

& \left|\sum_{1 \leq \ell \leq n-1} a_{\ell n} \xi_{\ell}+a_{n n}\left(\xi_{n}+i \tau \alpha\right)\right|^{2}=\left|a_{n n}\right|^{2}\left|\sum_{1 \leq \ell \leq n-1} \frac{a_{\ell n}}{a_{n n}} \xi_{\ell}+\left(\xi_{n}+i \tau \alpha\right)\right|^{2}  \tag{3.52}\\
& =\left|a_{n n}\right|^{2}\left|E+i F+\left(\xi_{n}+i \tau \alpha\right)\right|^{2}=\left|a_{n n}\right|^{2}\left(A^{2}+B^{2}\right),
\end{align*}
$$

where we have used (3.46), (3.50) or (3.51). Combining (3.45), (3.46), (3.50) or (3.51), we have that

\end{equation*}

which implies

\sum_{1 \leq j \leq n-1}\left|\sum_{1 \leq \ell \leq n-1} a_{\ell j} \xi_{\ell}+a_{n j}\left(\xi_{n}+i \tau \alpha\right)\right|^{2} \leq C \Lambda_{0}^{2}\left|\xi^{\prime}\right|^{2} \tag{3.54}
\end{equation*}
$$

Putting (3.49), (3.52), and (3.54) together gives

Q(0, \xi, \tau) \geq 4 \beta\left|a_{n n}\right|^{2}\left(A^{2}+B^{2}\right)-4 \varepsilon C \Lambda_{0}\left|\xi^{\prime}\right|^{2} \tag{3.55}
\end{equation*}
$$

Recall the estimate (3.19) in Lemma 3.1

A^{2} \geq \tilde{\lambda}_{1}\left|\xi^{\prime}\right|^{2}+|F|^{2} \geq \tilde{\lambda}_{1}\left|\xi^{\prime}\right|^{2}
$$

Using this estimate in (3.55) and choosing $\varepsilon$ sufficiently small leads to

whenever $p\left(\xi+i \tau \alpha e_{n}\right)=0$. Furthermore, (3.53) implies

\left|\xi+i \tau \alpha e_{n}\right|^{2} \leq\left(1+C^{2} \Lambda_{0}^{2}\right)\left|\xi^{\prime}\right|^{2}
$$

and it follows that if $p\left(\xi+i \tau \alpha e_{n}\right)=0$ then

Q(0, \xi, \tau) \geq C \beta\left|\xi+i \tau \alpha e_{n}\right|^{2} \tag{3.56}
\end{equation*}
$$

In conclusion, we have shown that

(\xi, \tau) \in\left\{(\xi, \tau) \in S: p\left(\xi+i \tau \alpha e_{n}\right)=0\right\} \Rightarrow Q(0, \xi, \tau)>0 \tag{3.57}
\end{equation*}
$$

where $S:=\left\{(\xi, \tau) \in \mathbb{R}^{n+1}:|\xi|^{2}+\tau^{2}=1\right\}$.
Now we recall the following elementary theorem. Let $X$ be a compact subset of $\mathbb{R}^{N}$ and $F, G: X \rightarrow \mathbb{R}$ be two continuous functions, then the following two statements are equivalent:
(i) $F(x)=0, \forall x \in X \Rightarrow G(x)>0$.
(ii) There exist positive constants $C_{1}, C_{2}$ such that $C_{1} G(x)+|F(x)| \geq C_{2}, \forall x \in X$.

With the help of this theorem, (3.57) is equivalent to

\begin{equation*}
C_{1} Q(0, \xi, \tau)+\left|p\left(\xi+i \tau \alpha e_{n}\right)\right| \geq C_{2} \tag{3.58}
\end{equation*}
$$

for all $(\xi, \tau) \in S$. Thanks to (3.58), we can estimate

\begin{aligned}
C_{1} Q(x, \xi, \tau)+\left|p\left(\xi+i \tau \nabla \psi_{\varepsilon}(x)\right)\right| & =C_{1} Q(0, \xi, \tau)+\left|p\left(\xi+i \tau \alpha e_{n}\right)\right|+R(x, \xi, \tau) \\
& \geq C_{2}+R(x, \xi, \tau)
\end{aligned}
$$

where

$$
R(x, \xi, \tau)=C_{1}[Q(x, \xi, \tau)-Q(0, \xi, \tau)]+\left|p\left(\xi+i \tau \nabla \psi_{\varepsilon}(x)\right)\right|-\left|p\left(\xi+i \tau \alpha e_{n}\right)\right| .
$$

Observe that $R(0, \xi, \tau)=0$ for $(\xi, \tau) \in S$. Since $R$ is continuous, there exists a small number $\delta^{\prime}>0$ such that

|R(x, \xi, \tau)| \leq \frac{C_{2}}{2}
$$

for all $x$ with $|x| \leq \delta^{\prime}<\frac{\alpha}{2 \beta}$ and $(\xi, \tau) \in S$. In other words, we have that

C_{1} Q(x, \xi, \tau)+\left|p\left(\xi+i \tau \nabla \psi_{\varepsilon}(x)\right)\right| \geq \frac{C_{2}}{2} \tag{3.59}
\end{equation*}

in $\left\{|x| \leq \delta^{\prime}\right\} \times S$. By the elementary theorem stated above, (3.59) is equivalent to

& p\left(\xi+i \tau \nabla \psi_{\varepsilon}(x)\right)=0, \forall x \in \overline{B_{\delta^{\prime}}},(\xi, \tau) \in S \\
\Rightarrow & Q(x, \xi, \tau)>0, \forall x \in \overline{B_{\delta^{\prime}}},(\xi, \tau) \in S
\end{aligned}
$$

which immediately implies the strong pseudoconvexity condition near 0 in view of the homogeneity of $p$ and $Q$ in $(\xi, \tau)$.

Having verified the strong psudoconvexity in a neighborhood of 0 and the transmission conditions at 0 , we can derive a Carleman estimate with weight $\psi_{\varepsilon}(x)$ for the operator $\mathcal{L}_{0}$.

Theorem 3.3 [BL, Theorem 1.6] Assume that coefficients $A_{ \pm}(0)$ satisfy conditions (3.1)-(3.4). There exist $\alpha_{+}, \alpha_{-}, \beta, \varepsilon_{0}, \gamma_{0}, r_{0}$ and $C$, depending on $\lambda_{0}, \Lambda_{0}$, such that if $\varepsilon \leq \varepsilon_{0}, \gamma \leq \gamma_{0}, \tau \geq C$, then

& \sum_{ \pm} \sum_{k=0}^{2} \tau^{3-2 k} \int_{\mathbb{R}_{ \pm}^{n}}\left|D^{k} u_{ \pm}\right|^{2} e^{2 \tau \psi_{\varepsilon, \pm}(x)} d x+\sum_{ \pm} \sum_{k=0}^{1} \tau^{3-2 k} \int_{\mathbb{R}^{n-1}}\left|D^{k} u_{ \pm}\left(x^{\prime}, 0\right)\right|^{2} e^{2 \psi_{\varepsilon}\left(x^{\prime}, 0\right)} d x^{\prime} \\
& +\sum_{ \pm} \tau^{2}\left[e^{\tau \psi_{\varepsilon}(\cdot, 0)} u_{ \pm}(\cdot, 0)\right]_{1 / 2, \mathbb{R}^{n-1}}^{2}+\sum_{ \pm}\left[D\left(e^{\tau \psi_{\varepsilon, \pm}} u_{ \pm}\right)(\cdot, 0)\right]_{1 / 2, \mathbb{R}^{n-1}}^{2} \\
& \leq C\left(\int_{\mathbb{R}_{ \pm}^{n}}\left|\mathcal{L}_{0}(D)\left(u_{ \pm}\right)\right|^{2} e^{2 \tau \psi_{\varepsilon, \pm}(x)} d x+\left[e^{\tau \psi_{\varepsilon}(\cdot, 0)} h_{1}^{(0)}\right]_{1 / 2, \mathbb{R}^{n-1}}^{2}\right.  \tag{3.60}\\
& \left.+\left[D_{x^{\prime}}\left(e^{\tau \psi_{\varepsilon}} h_{0}^{(0)}\right)(\cdot, 0)\right]_{1 / 2, \mathbb{R}^{n-1}}^{2}+\tau^{3} \int_{\mathbb{R}^{n-1}}\left|h_{0}^{(0)}\right|^{2} e^{2 \tau \psi_{\varepsilon}(x, 0)} d x+\tau \int_{\mathbb{R}^{n-1}}\left|h_{1}^{(0)}\right|^{2} e^{2 \tau \psi_{\varepsilon}(x, 0)} d x\right)
\end{align*}
$$

for $u=H_{+} u_{+}+H_{-} u_{-}, u_{ \pm} \in C^{\infty}\left(\mathbb{R}^{n}\right)$ and $\operatorname{supp} u \subset B_{r_{0}}^{\prime} \times\left[-r_{0}, r_{0}\right]$, and

$$
\begin{gathered}
h_{0}^{(0)}\left(x^{\prime}\right):=u_{+}\left(x^{\prime}, 0\right)-u_{-}\left(x^{\prime}, 0\right), \forall x^{\prime} \in \mathbb{R}^{n-1}, \\
h_{1}^{(0)}\left(x^{\prime}\right):=A_{+}(0) \nabla u_{+}\left(x^{\prime}, 0\right) \cdot e_{n}-A_{-}(0) \nabla u_{-}\left(x^{\prime}, 0\right) \cdot e_{n}, \forall x \in \mathbb{R}^{n-1} .
\end{gathered}
$$

## 4 Derivation of the Carleman estimate

This section is devoted to the derivation of the Carleman estimate (2.14) following the ideas used in [DcFLVW]. We first introduce the partition of unity given in [DcFLVW]. For any $r>0$ and $x^{\prime} \in \mathbb{R}^{n-1}$, denote the $(n-1)$-cube $Q_{r}\left(x^{\prime}\right)=\left\{y^{\prime} \in \mathbb{R}^{n-1}:\left|y_{j}^{\prime}-x_{j}^{\prime}\right| \leq\right.$ $r, j=1,2, \cdots, n-1\}$. Let $\vartheta_{0} \in C_{0}^{\infty}(\mathbb{R})$ such that

$$
\begin{equation*}
0 \leq \vartheta_{0} \leq 1, \quad \operatorname{supp} \vartheta_{0} \subset(-3 / 2,3 / 2) \quad \text { and } \quad \vartheta_{0}(t)=1 \text { for } t \in[-1,1] \tag{4.1}
\end{equation*}
$$

Let $\vartheta\left(x^{\prime}\right)=\vartheta_{0}\left(x_{1}\right) \cdots \vartheta_{0}\left(x_{n-1}\right)$, so that

\operatorname{supp} \vartheta \subset \stackrel{\circ}{Q}_{3 / 2}(0) \text { and } \vartheta\left(x^{\prime}\right)=1 \text { for } x^{\prime} \in Q_{1}(0)
$$

where $\stackrel{\circ}{Q}$ denotes the interior of the set $Q$. Given $\mu \geq 1$ and $g \in \mathbb{Z}^{n-1}$, we define

and

\vartheta_{g, \mu}\left(x^{\prime}\right)=\vartheta\left(\mu\left(x^{\prime}-x_{g}^{\prime}\right)\right)

Thus, we can see that

\operatorname{supp} \vartheta_{g, \mu} \subset \stackrel{\circ}{Q}_{3 / 2 \mu}\left(x_{g}^{\prime}\right) \subset Q_{2 / \mu}\left(x_{g}^{\prime}\right)
$$

and

$$
\begin{equation*}
\left|D^{k} \vartheta_{g, \mu}\right| \leq C_{1} \mu^{k}\left(\chi_{Q_{3 / 2 \mu}\left(x_{g}^{\prime}\right)}-\chi_{Q_{1 / \mu}\left(x_{g}^{\prime}\right)}\right), \quad k=0,1,2, \tag{4.2}
\end{equation*}
$$

where $C_{1} \geq 1$ depends only on $n$.
Notice that, for any $g \in \mathbb{Z}^{n-1}$,

\operatorname{card}\left(\left\{g^{\prime} \in \mathbb{Z}^{n-1}: \operatorname{supp} \vartheta_{g^{\prime}, \mu} \cap \operatorname{supp} \vartheta_{g, \mu} \neq \emptyset\right\}\right)=5^{n-1} \tag{4.3}
\end{equation*}
$$

Thus, we can define

\bar{\vartheta}_{\mu}\left(x^{\prime}\right):=\sum_{g \in \mathbb{Z}^{n-1}} \vartheta_{g, \mu} \geq 1, \quad x^{\prime} \in \mathbb{R}^{n-1} \tag{4.4}
\end{equation*}
$$

By (4.2), we get that

\left|D^{k} \bar{\vartheta}_{\mu}\right| \leq C_{2} \mu^{k} \tag{4.5}
\end{equation*}
$$

where $C_{2} \geq 1$ depends on $n$. Define

\eta_{g, \mu}\left(x^{\prime}\right)=\vartheta_{g, \mu}\left(x^{\prime}\right) / \bar{\vartheta}_{\mu}\left(x^{\prime}\right), \quad x^{\prime} \in \mathbb{R}^{n-1} \tag{4.6}
\end{equation*}
$$

then we have that

$$
\left\{\begin{array}{l}
\sum_{g \in \mathbb{Z}^{n-1}} \eta_{g, \mu}=1, \quad x^{\prime} \in \mathbb{R}^{n-1}  \tag{4.7}\\
\operatorname{supp} \eta_{g, \mu} \subset Q_{3 / 2 \mu}\left(x_{g}^{\prime}\right) \subset Q_{2 / \mu}\left(x_{g}^{\prime}\right) \\
\left|D^{k} \eta_{g, \mu}\right| \leq C_{3} \mu^{k} \chi_{Q_{3 / 2 \mu}\left(x_{g}^{\prime}\right)}, \quad k=0,1,2
\end{array}\right.
$$

where $C_{3} \geq 1$ depends on $n$.
We will first extend (3.60) to operators with leading coefficients depending on the vertical variable $x_{n}$. To do so, we need to derive an interior Carleman estimate for second order elliptic operators having Lipschitz leading coefficients and with the weight function $\psi_{\varepsilon}$. To derive such Carleman estimate, we define the $n$-cube $K_{R}=$ $\left\{x=\left(x_{1}, \cdots, x_{n}\right):\left|x_{j}\right| \leq R, 1 \leq j \leq n\right\}$ for $R>0$. Let us denote

$$
P(x, D)=\sum_{1 \leq j, \ell \leq n} a_{j \ell}(x) D_{j \ell}^{2}
$$

and its symbol $p(x, \xi)=\sum_{1 \leq j, \ell \leq n} a_{j \ell}(x) \xi_{j} \xi_{\ell}$. Assume that for all $1 \leq j, \ell \leq n$ and $x, y \in K_{1}$,

$$
\left\{\begin{array}{l}
a_{j \ell}(x)=a_{\ell j}(x),  \tag{4.8}\\
\left|a_{j \ell}(x)\right| \leq \Lambda, \\
\left|a_{j \ell}(x)-a_{j \ell}(y)\right| \leq M_{0}|x-y|, \\
|p(x, \xi)| \geq \lambda|\xi|^{2}, \quad \forall \xi \in \mathbb{R}^{n},
\end{array}\right.
$$

where $\Lambda, \lambda>0$. Let $\varphi(x) \in C^{2}\left(K_{1}\right)$ be real-valued and satisfy $|\nabla \varphi(x)| \neq 0$ for all $x \in K_{1}$. We denote

$$
S(x, y ; \xi, \tau)=\sum_{\ell, j=1}^{n} \partial_{\ell j}^{2} \varphi(x) \partial_{\xi_{j}} p(y, \xi+i \tau \nabla \varphi(x)) \overline{\partial_{\xi_{\ell}} p(y, \xi+i \tau \nabla \varphi(x))}
$$

for $x, y \in K_{1}, \xi \in \mathbb{R}^{n}, \tau>0$.
Proposition 4.1 Assume that the following condition holds:

Then there exist $\bar{R} \in(0,1], \delta_{0} \in(0,1], C_{0} \geq 1, \tau_{0} \geq 1$, depending on $\lambda, \Lambda, M_{0},\|\varphi\|_{C^{2}\left(Q_{1}\right)}$, such that

\begin{equation*}
\sum_{|\alpha| \leq 2} \tau^{3-2|\alpha|} \int\left|D^{\alpha} u\right|^{2} e^{2 \tau \varphi(x)} d x \leq C_{0} \int|P(\delta x, D) u|^{2} e^{2 \tau \varphi(x)} d x \tag{4.10}
\end{equation*}
$$

$\forall u \in C_{0}^{\infty}\left(\stackrel{\circ}{K}_{\bar{R}}\right), \tau \geq \tau_{0}, 0<\delta \leq \delta_{0}$.
Proof. In view of the homogeneity in $(\xi, \tau),(4.9)$ is equivalent to that there exist $C_{1}>0, C_{2}>0$ such that

From (4.8), we can see that there exists $\bar{R} \in(0,1]$ such that

where $\tilde{C}_{1}>0, \tilde{C}_{2}>0$ are independent of $x, y$. Thanks to (4.11), the Carleman derived in [Ho1, Theorem 8.3.1] holds for

Now we use the partition of unity introduced above, but with $n-1$ being replaced by $n$. In particular, for $h \in \mathbb{Z}^{n}$, we define

\leq & c \eta_{h, \mu} \frac{\delta M_{0}}{\mu}\left|D^{2} u\right|+2 C_{4} \Lambda(\sqrt{\varepsilon \tau}|D u|+\varepsilon \tau|u|) \chi_{K_{2 / \mu}\left(x_{h}\right)}

with $c=c(n)$. Here $K_{2 / \mu}\left(x_{h}\right)$ denotes the $n$-cube centered at $x_{h}$ with length $4 / \mu$ and $\chi_{K_{2 / \mu}\left(x_{h}\right)}$ is the characteristic function of $K_{2 / \mu}\left(x_{h}\right)$. Substituting (4.14)-(4.16) into (4.13) gives

### 4.1 Carleman estimate for operators depending on the vertical variable

Here we would like to prove a Carleman estimate for the operator that satisfies conditions (3.1)-(3.4) but depending only on the $x_{n}$ variable. That is, we consider

It is clear that $A_{ \pm}\left(\delta x_{n}\right)$ satisfies (3.3), (3.4) and (2.7). Moreover, estimate (3.58) implies that the condition (4.9) holds for $\sum_{1 \leq j, \ell \leq n} a_{j \ell}^{ \pm}(x) D_{j \ell}^{2}$ with $\varphi=\psi_{\varepsilon}$. Observe that $z_{\mu}$ is supported away from $x_{n}=0$. Therefore, it follows from (4.10) in Proposition 4.1 that there exist $\delta_{0} \in(0,1], \tau_{0}>0$, and choose a small $r_{0}$ if necessary, such that

To treat this case we proceed exactly as in [DcFLVW, Section 4.2 , pp.198-200], that is, we approximate with coefficients depending only on $x_{n}$. We use the partition of unity introduced at the beginning of Section 4 and show that

R_{1}:=(\varepsilon \tau)^{1 / 2} \sum_{ \pm} \int_{\mathbb{R}^{n-1}} e^{2 \tau \psi_{\varepsilon}\left(x^{\prime}, 0\right)}\left(\left|D_{x_{n}} u_{ \pm}\left(x^{\prime}, 0\right)\right|^{2}+\left|D_{x^{\prime}} u_{ \pm}\left(x^{\prime}, 0\right)\right|^{2}+\tau^{2}\left|u_{ \pm}\left(x^{\prime}, 0\right)\right|^{2}\right) d x^{\prime}
$$

Remind that $\eta_{g, \mu}$ is defined in (4.6). Notice that $\Xi$ in (4.25) of [DcFLVW] corresponds to $L H S$ here.

As in [DcFLVW, Section 4.3], we introduce some local differential operators that only depend on $x_{n}$, in such a way that we can apply estimate (4.23). Let us define

$$
\begin{equation*}
A_{ \pm}^{\delta}\left(x^{\prime}, x_{n}\right):=A_{ \pm}\left(\delta x^{\prime}, \delta x_{n}\right) \tag{4.33}
\end{equation*}
$$

$$
\begin{equation*}
\mathcal{L}_{\delta}\left(x^{\prime}, x_{n}, D\right) u:=\sum_{ \pm} H_{ \pm} \operatorname{div}\left(A_{ \pm}^{\delta}\left(x^{\prime}, x_{n}\right) \nabla u_{ \pm}\right) \tag{4.34}
\end{equation*}
$$

and the transmission conditions

$$
\left\{\begin{array}{l}
\theta_{0}\left(x^{\prime}\right)=u_{+}\left(x^{\prime}, 0\right)-u_{-}\left(x^{\prime}, 0\right) \\
\theta_{1}\left(x^{\prime}\right)=A_{+}^{\delta}\left(x^{\prime}, 0\right) \nabla u_{+}\left(x^{\prime}, 0\right) \cdot e_{n}-A_{-}^{\delta}\left(x^{\prime}, 0\right) \nabla u_{-}\left(x^{\prime}, 0\right) \cdot e_{n}
\end{array}\right.
$$

Next, recalling that $x_{g}^{\prime}=g / \mu$ and $g \in \mathbb{Z}^{n-1}$, we define

$$
\left\{\begin{array}{l}
A_{ \pm}^{\delta, g}\left(x_{n}\right):=A_{ \pm}^{\delta}\left(x_{g}^{\prime}, x_{n}\right)=A_{ \pm}\left(\delta x_{g}^{\prime}, \delta x_{n}\right) \\
\mathcal{L}_{\delta, g}\left(x_{n}, D\right) u:=\sum_{ \pm} H_{ \pm} \operatorname{div}\left(A_{ \pm}^{\delta, g}\left(x_{n}\right) \nabla u_{ \pm}\right)
\end{array}\right.
$$

We notice that $A_{ \pm}^{\delta, g}\left(x_{n}\right)$ satisfies assumptions (3.3), (3.4) and also the Lipschitz condition

$$
\left|A_{ \pm}^{\delta, g}\left(\tilde{x}_{n}\right)-A_{ \pm}^{\delta, g}\left(x_{n}\right)\right| \leq M_{0} \delta\left|\tilde{x}_{n}-x_{n}\right|
$$

We now apply (4.23) to each summand and add up with respect to $g \in \mathbb{Z}^{n-1}$ to obtain that

$$
\begin{equation*}
\sum_{g \in \mathbb{Z}^{n-1}} L H S\left(u \eta_{g, \mu}\right) \leq C \sum_{g \in \mathbb{Z}^{n-1}}\left(d_{g, \mu}^{(1)}+d_{g, \mu}^{(2)}+d_{g, \mu}^{(3)}\right) \tag{4.35}
\end{equation*}
$$

where

$$
\begin{aligned}
d_{g, \mu}^{(1)} & =\int_{\mathbb{R}^{n}}\left|\mathcal{L}_{\delta, g}\left(x_{n}, D\right)\left(u \eta_{g, \mu}\right)\right|^{2} e^{2 \tau \psi_{\varepsilon}(x)} d x, \\
d_{g, \mu}^{(2)} & =\tau^{3} \int_{\mathbb{R}^{n-1}}\left|e^{\tau \psi_{\varepsilon}\left(x^{\prime}, 0\right)} \theta_{0 ; g, \mu}\left(x^{\prime}\right)\right|^{2} d x^{\prime}+\left[D_{x^{\prime}}\left(e^{\tau \psi_{\varepsilon}} \theta_{0 ; g, \mu}\right)(\cdot, 0)\right]_{1 / 2, \mathbb{R}^{n-1}}^{2}, \\
d_{g, \mu}^{(3)} & =\tau \int_{\mathbb{R}^{n-1}}\left|e^{\tau \psi_{\varepsilon}\left(x^{\prime}, 0\right)} \theta_{1 ; g, \mu}\left(x^{\prime}\right)\right|^{2} d x^{\prime}+\left[e^{\tau \psi_{\varepsilon}(\cdot, 0)} \theta_{1 ; g, \mu}(\cdot)\right]_{1 / 2, \mathbb{R}^{n-1}}^{2},
\end{aligned}
$$

where we set

$$
\begin{gathered}
\theta_{0 ; g, \mu}\left(x^{\prime}\right):=u_{+}\left(x^{\prime}, 0\right) \eta_{g, \mu}\left(x^{\prime}\right)-u_{-}\left(x^{\prime}, 0\right) \eta_{g, \mu}\left(x^{\prime}\right)=\theta_{0}\left(x^{\prime}\right) \eta_{g, \mu}, \\
\theta_{1 ; g, \mu}\left(x^{\prime}\right):=A_{+}^{\delta, g}(0) \nabla\left(u_{+} \eta_{g, \mu}\right) \cdot e_{n}-A_{-}^{\delta, g}(0) \nabla\left(u_{-} \eta_{g, \mu}\right) \cdot e_{n}
\end{gathered}
$$

We now proceed as in [DcFLVW, Section 4.3, pp.201-204] for the estimates of the terms $d_{g, \mu}^{(j)}, j=1,2,3$ in (4.35). For the sake of clarity, we show here the estimate of the term $d_{g, \mu}^{(1)}$. By (3.3), (3.4), (2.7), (4.7) and (4.33) we obtain that

$$
\begin{aligned}
& \left|\mathcal{L}_{\delta, g}\left(x_{n}, D\right)\left(u \eta_{g, \mu}\right)\right| \\
& \leq\left|\mathcal{L}_{\delta}\left(x^{\prime}, x_{n}, D\right)\left(u \eta_{g, \mu}\right)\right|+\left|\mathcal{L}_{\delta}\left(x^{\prime}, x_{n}, D\right)\left(u \eta_{g, \mu}\right)-\mathcal{L}_{\delta, g}\left(x_{n}, D\right)\left(u \eta_{g, \mu}\right)\right| \\
& \leq \eta_{g, \mu}\left|\mathcal{L}_{\delta}\left(x^{\prime}, x_{n}, D\right) u\right|+C \eta_{g, \mu} \sum_{ \pm}\left|A_{ \pm}^{\delta}\left(x^{\prime}, x_{n}\right)-A_{ \pm}^{\delta}\left(x_{g}^{\prime}, x_{n}\right)\right|\left|D^{2} u_{ \pm}\right| \\
& +C \chi_{Q_{\frac{2}{\mu}}\left(x_{g}^{\prime}\right)} \sum_{ \pm}\left(\mu\left|D u_{ \pm}\right|+\mu^{2}\left|u_{ \pm}\right|\right) \\
& \leq \eta_{g, \mu}\left|\mathcal{L}_{\delta}\left(x^{\prime}, x_{n}, D\right) u\right|+C \chi_{Q_{\frac{2}{\mu}}\left(x_{g}^{\prime}\right)} \sum_{ \pm}\left(\delta \mu^{-1}\left|D^{2} u_{ \pm}\right|+\mu\left|D u_{ \pm}\right|+\mu^{2}\left|u_{ \pm}\right|\right)
\end{aligned}
$$

which, together with (4.3) and since $\mu=(\varepsilon \tau)^{1 / 2}>1$, implies

$$
\begin{equation*}
\sum_{g \in \mathbb{Z}^{n-1}} d_{g, \mu}^{(1)} \leq C \int_{\mathbb{R}^{n}}\left|\mathcal{L}_{\delta}\left(x^{\prime}, x_{n}, D\right) u\right|^{2} e^{2 \tau \psi_{\varepsilon}} d x+C R_{2} \tag{4.36}
\end{equation*}
$$

where

$$
R_{2}=\frac{\delta^{2}}{\mu^{2}} \sum_{ \pm} \int_{\mathbb{R}_{ \pm}^{n}}\left|D^{2} u_{ \pm}\right|^{2} e^{2 \tau \psi_{\varepsilon, \pm}} d x+\mu^{2} \sum_{ \pm} \int_{\mathbb{R}_{ \pm}^{n}}\left|D u_{ \pm}\right|^{2} e^{2 \tau \psi_{\varepsilon, \pm}} d x+\mu^{4} \int_{\mathbb{R}^{n}}|u|^{2} e^{2 \tau \psi_{\varepsilon}} d x
$$

With similar calculations, which are explicitly written in the above mentioned pages of [DcFLVW], we can estimate $d_{g, \mu}^{(2)}, d_{g, \mu}^{(3)}$ and get

$$
\begin{align*}
\operatorname{LHS}(u) \leq & C\left(\int_{\mathbb{R}^{n}}\left|\mathcal{L}_{\delta}\left(x^{\prime}, x_{n}, D\right) u\right|^{2} e^{2 \tau \psi_{\varepsilon}} d x+\left[e^{\tau \psi_{\varepsilon}(\cdot, 0)} \theta_{1}\right]_{1 / 2, \mathbb{R}^{n-1}}^{2}\right. \\
& +\left[D_{x^{\prime}}\left(e^{\tau \psi_{\varepsilon}} \theta_{0}\right)(\cdot, 0)\right]_{1 / 2, \mathbb{R}^{n-1}}^{2}+\tau^{3} \int_{\mathbb{R}^{n-1}} e^{2 \tau \psi_{\varepsilon}\left(x^{\prime}, 0\right)}\left|\theta_{0}\left(x^{\prime}\right)\right|^{2} d x^{\prime} \\
& \left.+\tau \int_{\mathbb{R}^{n-1}} e^{2 \tau \psi_{\varepsilon}\left(x^{\prime}, 0\right)}\left|\theta_{1}\left(x^{\prime}\right)\right|^{2} d x^{\prime}+R_{3}\right) . \tag{4.37}
\end{align*}
$$

where

$$
\begin{aligned}
R_{3}= & \frac{\delta^{2}}{\mu^{2}} \sum_{ \pm} \int_{\mathbb{R}_{ \pm}^{n}}\left|D^{2} u_{ \pm}\right|^{2} e^{2 \tau \psi_{\varepsilon, \pm}} d x+\mu^{2} \sum_{ \pm} \int_{\mathbb{R}_{ \pm}^{n}}\left|D u_{ \pm}\right|^{2} e^{2 \tau \psi_{\varepsilon, \pm}} d x \\
& +\mu^{4} \int_{\mathbb{R}^{n}}|u|^{2} e^{2 \tau \psi_{\varepsilon}} d x+\left(\mu+\delta^{2} \varepsilon^{-1}\right) \sum_{ \pm} \int_{\mathbb{R}^{n-1}}\left|D u_{ \pm}\left(x^{\prime}, 0\right)\right|^{2} e^{2 \tau \psi_{\varepsilon}(x, 0)} d x \\
& +\mu \tau^{2} \sum_{ \pm} \int_{\mathbb{R}^{n-1}}\left|u_{ \pm}\left(x^{\prime}, 0\right)\right|^{2} e^{2 \tau \psi_{\varepsilon}\left(x^{\prime}, 0\right)} d x^{\prime}+\left(\mu^{4}+\delta^{2} \mu^{-2} \tau^{2}\right) \sum_{ \pm}\left[e^{\tau \psi_{\varepsilon}(\cdot, 0)} u_{ \pm}(\cdot, 0)\right]_{1 / 2, \mathbb{R}^{n-1}}^{2} \\
& +\delta^{2} \mu^{-2} \sum_{ \pm}\left[D\left(u_{ \pm} e^{\tau \psi_{\varepsilon, \pm}}\right)(\cdot, 0)\right]_{1 / 2, \mathbb{R}^{n-1}}^{2} .
\end{aligned}
$$

We now set $\varepsilon=\delta$ and choose a sufficiently small $\delta_{0}$ and a sufficiently large $\tau_{0}$, both depending on $\lambda_{0}, \Lambda_{0}, M_{0}$, and $n$ such that if $\varepsilon=\delta \leq \delta_{0}$ inequalities (4.31) are satisfied and if $\tau \geq \tau_{0}$, then $R_{3}$ on the right hand side of (4.37) can be absorbed by $\operatorname{LHS}(u)$. We finally get the estimate (4.23) by the standard change of variable $u\left(\delta x^{\prime}, \delta x_{n}\right)$.
