# On capacity and torsional rigidity

#### Abstract

We investigate extremal properties of shape functionals which are products of Newtonian capacity $\operatorname{cap}(\bar{\Omega})$, and powers of the torsional rigidity $T(\Omega)$, for an open set $\Omega \subset \mathbb{R}^{d}$ with compact closure $\bar{\Omega}$, and prescribed Lebesgue measure. It is shown that if $\Omega$ is convex then $\operatorname{cap}(\bar{\Omega}) T^{q}(\Omega)$ is (i) bounded from above if and only if $q \geq 1$, and (ii) bounded from below and away from 0 if and only if $q \leq \frac{d-2}{2(d-1)}$. Moreover a convex maximiser for the product exists if either $q>1$, or $d=3$ and $q=1$. A convex minimiser exists for $q<\frac{d-2}{2(d-1)}$. If $q \leq 0$, then the product is minimised among all bounded sets by a ball of measure 1 .

## 1 Introduction and main results

Several classical inequalities of mathematical physics are of the following form. Let $F$ and $H$ be strictly positive set functions defined on a suitable collection $\mathfrak{C}$ of open sets in $\mathbb{R}^{d}$, and which satisfy scaling relations

$$
F(t \Omega)=t^{\beta_{1}} F(\Omega), \quad H(t \Omega)=t^{\beta_{2}} H(\Omega), \quad t>0
$$

where $t \Omega$ is homothety of $\Omega$, and $\beta_{1}, \beta_{2}$ are constants. Then the shape functional

$$
G(\Omega)=H(\Omega) F(\Omega)^{-\beta_{2} / \beta_{1}}
$$

is invariant under homotheties, and in some cases this quantity is minimal (respectively maximal) for some open set $\Omega^{*} \in \mathfrak{C}$,

$$
G(\Omega) \geq G\left(\Omega^{*}\right) \quad\left(\text { respectively } G(\Omega) \leq G\left(\Omega^{*}\right)\right), \quad \Omega \in \mathfrak{C}
$$

The Faber-Krahn, Krahn-Szegö, and Kohler-Jobin inequalities are of this form. See for example the seminal text [11]. In a recent paper [3] a more general set of inequalities was investigated. These are of the following form: let $q \in \mathbb{R}$, and consider the shape functional

$$
G(\Omega)=H(\Omega) F(\Omega)^{q}
$$

Then, unless $q=-\beta_{2} / \beta_{1}$, this product is not scaling invariant. However, denoting by $|\Omega|$ the Lebesgue measure of $\Omega$, the quantity

$$
\frac{H(\Omega) F(\Omega)^{q}}{|\Omega|^{\left(\beta_{2}+q \beta_{1}\right) / d}}
$$

is scaling invariant. The case where $H$ is the principal Dirichlet eigenvalue, and $F$ is the torsional rigidity was analysed in [3]. In the present paper we investigate, in the spirit of [11], the case where $H$ is the Newtonian capacity, and $F$ is the torsional rigidity. Since the Newtonian capacity is most easily defined for compact subsets of $\mathbb{R}^{d}, d \geq 3$, we restrict ourselves to open sets $\Omega \subset \mathbb{R}^{d}, d \geq 3$ which are precompact. In that case the Newtonian capacity scales as a power $\beta_{2}=d-2$ of the homothety.

Throughout this paper we let $\Omega$ be a non-empty, open, bounded set in Euclidean space $\mathbb{R}^{d}, d \geq 3$. For a set $A \subset \mathbb{R}^{d}$ we denote by $\bar{A}$ its closure, $\operatorname{diam}(A)=\sup \{|x-y|: x \in$ $A, y \in A\}$ its diameter, and $r(A)=\sup \left\{r \geq 0:(\exists x \in A),\left(B_{r}(x) \subset A\right)\right\}$ its inradius, where $B_{r}(x)=\left\{y \in \mathbb{R}^{d}:|x-y|<r\right\}$ is the ball of radius $r$ centred at $x$. Before we state the main results we recall some basic facts about the torsion function, torsional rigidity, and Newtonian capacity.

The torsion function for an open set $\Omega$ with finite measure is the solution of

$$
-\Delta u=1, \quad u \in H_{0}^{1}(\Omega)
$$

and is denoted by $u_{\Omega}$. It is convenient to extend $u_{\Omega}$ to all of $\mathbb{R}^{d}$ by defining $u_{\Omega}=0$ on $\mathbb{R}^{d} \backslash \Omega$. It is well known that $u_{\Omega}$ is non-negative, bounded ([2, 4, 6, 12]), and monotone increasing with respect to $\Omega$, that is

$$
\Omega_{1} \subset \Omega_{2} \Rightarrow u_{\Omega_{1}} \leq u_{\Omega_{2}}
$$

The torsional rigidity of $\Omega$, or torsion for short, is denoted by

$$
T(\Omega)=\left\|u_{\Omega}\right\|_{1}
$$

where $\|\cdot\|_{p}, 1 \leq p \leq \infty$ denotes the usual $L^{p}$ norm. It follows that

$$
\begin{equation*}
\Omega_{1} \subset \Omega_{2} \Rightarrow T\left(\Omega_{1}\right) \leq T\left(\Omega_{2}\right) \tag{1}
\end{equation*}
$$

and that the torsion satisfies the scaling property

$$
\begin{equation*}
T(t \Omega)=t^{d+2} T(\Omega), \quad t>0 \tag{2}
\end{equation*}
$$

Moreover $T$ is additive on unions of disjoint families of open sets:

$$
T\left(\cup_{i \in I} \Omega_{i}\right)=\sum_{i \in I} T\left(\Omega_{i}\right)
$$

It is straightforward to verify that if $E(a)$, with $a=\left(a_{1}, a_{2}, \ldots, a_{d}\right) \in \mathbb{R}_{+}^{d}$, is the ellipsoid

$$
E(a)=\left\{x \in \mathbb{R}^{d}: \sum_{i=1}^{d} \frac{x_{i}^{2}}{a_{i}^{2}}<1\right\}
$$

then

$$
u_{E(a)}(x)=\frac{1}{2}\left(\sum_{i=1}^{d} \frac{1}{a_{i}^{2}}\right)^{-1}\left(1-\sum_{i=1}^{d} \frac{x_{i}^{2}}{a_{i}^{2}}\right),
$$

and

$$
\begin{equation*}
T(E(a))=\frac{\omega_{d}}{d+2}\left(\prod_{i=1}^{d} a_{i}\right)\left(\sum_{i=1}^{d} \frac{1}{a_{i}^{2}}\right)^{-1} \tag{3}
\end{equation*}
$$

where

$$
\omega_{d}=\frac{\pi^{d / 2}}{\Gamma((d+2) / 2)}
$$

is the Lebesgue measure of a ball $B_{1}$ with radius 1 in $\mathbb{R}^{d}$. We put

$$
\tau_{d}=T\left(B_{1}\right)=\frac{\omega_{d}}{d(d+2)}
$$

The de Saint-Venant inequality (see for instance Chapter V in [11) asserts that

$$
\begin{equation*}
T(\Omega) \leq T\left(\Omega^{*}\right), \tag{4}
\end{equation*}
$$

where $\Omega^{*}$ is any ball with $|\Omega|=\left|\Omega^{*}\right|$. It follows by scaling that

$$
\begin{equation*}
\frac{T(\Omega)}{|\Omega|^{(d+2) / d}} \leq \frac{\tau_{d}}{\omega_{d}^{(d+2) / d}}=\frac{1}{d(d+2) \omega_{d}^{2 / d}} \tag{5}
\end{equation*}
$$

Below we recall some basic facts about the Newtonian capacity cap $(K)$ of a compact set $K \subset \mathbb{R}^{d}, d \geq 3$. There are several equivalent definitions of $\operatorname{cap}(K)$ of which we choose

$$
\operatorname{cap}(K)=\inf \left\{\int_{\mathbb{R}^{d}}|D \varphi|^{2} d x: \varphi_{K_{\varepsilon}} \geq 1, \varphi \in C_{0}^{1}\left(\mathbb{R}^{d}\right), \varepsilon>0\right\}
$$

where $\varphi_{K_{\varepsilon}}$ is the restriction of $\varphi$ to $K_{\varepsilon}=\left\{x \in \mathbb{R}^{d}: \operatorname{dist}(x, K)<\varepsilon\right\}$. It follows that

$$
\begin{equation*}
K_{1} \subset K_{2} \Rightarrow \operatorname{cap}\left(K_{1}\right) \leq \operatorname{cap}\left(K_{2}\right), \tag{6}
\end{equation*}
$$

and that the capacity satisfies the scaling property

$$
\begin{equation*}
\operatorname{cap}(t K)=t^{d-2} \operatorname{cap}(K), t>0 \tag{7}
\end{equation*}
$$

Moreover if $\left\{K_{i}, i \in I\right\}$ is a countable family of compact sets such that $\cup_{i \in I} K_{i}$ is compact, then

$$
\operatorname{cap}\left(\cup_{i \in I} K_{i}\right) \leq \sum_{i \in I} \operatorname{cap}\left(K_{i}\right)
$$

It was reported in [8] p. 260 that the Newtonian capacity of an ellipsoid was computed in volume 8, pp. 103-104 in [5]. The formula is given in terms of an elliptic integral, and reads

$$
\begin{equation*}
\operatorname{cap}(\overline{E(a)})=\frac{4 \pi^{d / 2}}{\Gamma(d / 2)} \mathfrak{e}(a)^{-1}, \tag{8}
\end{equation*}
$$

where

$$
\begin{equation*}
\mathfrak{e}(a)=\int_{0}^{\infty}\left(\prod_{i=1}^{d}\left(a_{i}^{2}+t\right)\right)^{-1 / 2} d t \tag{9}
\end{equation*}
$$

We put

$$
\kappa_{d}=\operatorname{cap}\left(\overline{B_{1}}\right)=\frac{4 \pi^{d / 2}}{\Gamma((d-2) / 2)},
$$

so that

$$
\begin{equation*}
\operatorname{cap}(\overline{E(a)})=\frac{2 \kappa_{d}}{d-2} \mathfrak{e}(a)^{-1} . \tag{10}
\end{equation*}
$$

The isoperimetric inequality for Newtonian capacity (see [11) asserts that for all compact sets $K \subset \mathbb{R}^{d}, d \geq 3$,

$$
\operatorname{cap}(K) \geq \operatorname{cap}\left(K^{*}\right),
$$

where $K^{*}$ is a closed ball with $|K|=\left|K^{*}\right|$. It follows by scaling that

$$
\begin{equation*}
\frac{\operatorname{cap}(K)}{|K|^{(d-2) / d}} \geq \frac{\kappa_{d}}{\omega_{d}^{(d-2) / d}} \tag{11}
\end{equation*}
$$

The shape functional we consider in the present paper is

$$
\begin{equation*}
G_{q}(\Omega)=\frac{\operatorname{cap}(\bar{\Omega}) T(\Omega)^{q}}{|\Omega|^{1+q+2(q-1) / d}}, \tag{12}
\end{equation*}
$$

defined for a bounded open set $\Omega \subset \mathbb{R}^{d}, d \geq 3$. By (2) and (7) we obtain that $G_{q}$ is scaling invariant. With the definitions above we have

$$
G_{q}\left(B_{1}\right)=\frac{\kappa_{d} \tau_{d}^{q}}{\omega_{d}^{1+q+2(q-1) / d}} .
$$

Since the ball $\Omega^{*}$ with measure $\left|\Omega^{*}\right|=|\Omega|$ maximises the torsional rigidity $T(\Omega)$ (de Saint-Venant), and its closure minimises the Newtonian capacity cap $(\bar{\Omega})$, competition enters in the minimisation or maximisation problems for the functional in (12).

All of our main results are for $d \geq 3$, and are as follows.
Theorem 1. (i) If $q \in \mathbb{R}$, then

$$
\sup \left\{G_{q}(\Omega): \Omega \text { open and bounded }\right\}=+\infty
$$

(ii) If $q \leq 0$, then

$$
\begin{equation*}
\min \left\{G_{q}(\Omega): \Omega \text { open and bounded }\right\}=G_{q}\left(B_{1}\right), \tag{13}
\end{equation*}
$$

with equality if and only if $\Omega$ is (up to sets of capacity 0 ) a ball in $\mathbb{R}^{d}$.
(iii) If $q>0$, then

$$
\inf \left\{G_{q}(\Omega): \Omega \text { open and bounded }\right\}=0
$$

Theorem 2. (i) If $q<1$, then

$$
\sup \left\{G_{q}(\Omega): \Omega \text { open, bounded and convex }\right\}=+\infty .
$$

(ii) If $q \geq 1$, then

$$
\begin{align*}
\sup \left\{G_{q}(\Omega):\right. & \Omega \text { open, bounded and convex }\} \\
& \leq \frac{2^{(d+2) / 2} d^{3 q-2+d(q+1)}}{d-2} G_{q}\left(B_{1}\right) \tag{14}
\end{align*}
$$

If $q>1$, then the variational problem in the left-hand side of (14) has a maximiser, say $\Omega^{+}$. For any such maximiser,

$$
\begin{equation*}
\frac{\operatorname{diam}\left(\Omega^{+}\right)}{r\left(\Omega^{+}\right)} \leq 2 d\left(\frac{2^{(d+2) / 2} d^{(1+q) d+3 q-2}}{d-2}\right)^{d /(2(q-1))} . \tag{15}
\end{equation*}
$$

(iii) If $q=1$ and $d=3$, then the variational problem in the left-hand side of (14) has a maximiser, say $\Omega^{+}$. For any such maximiser,

$$
\begin{equation*}
\frac{\operatorname{diam}\left(\Omega^{+}\right)}{r\left(\Omega^{+}\right)} \leq 2 \cdot 3^{8} e^{3^{7}} . \tag{16}
\end{equation*}
$$

Theorem 3. (i) If $q>(d-2) /(2(d-1))$, then

$$
\begin{equation*}
\inf \left\{G_{q}(\Omega): \Omega \text { open, bounded and convex }\right\}=0 . \tag{17}
\end{equation*}
$$

(ii) If $0<q \leq(d-2) /(2(d-1))$, then

$$
\begin{equation*}
\inf \left\{G_{q}(\Omega): \Omega \text { open, bounded and convex }\right\} \geq \frac{1}{2 d^{d+(d+2) q}} G_{q}\left(B_{1}\right) . \tag{18}
\end{equation*}
$$

If $0<q<(d-2) /(2(d-1))$, then the variational problem in the left-hand side of (18) has a convex minimiser, say $\Omega^{-}$. For any such minimiser,

$$
\begin{equation*}
\frac{\operatorname{diam}\left(\Omega^{-}\right)}{r\left(\Omega^{-}\right)} \leq 2 d\left(2 d^{d+(d+2) q}\right)^{\frac{d(d-1)}{d-2-2 q(d-1)}} . \tag{19}
\end{equation*}
$$

We were unable to prove the existence or non-existence of a maximiser for the lefthand side of (14) for $q=1$ and $d>3$. In these higher-dimensional cases there is a lack of compactness. For example if

$$
a_{\varepsilon}=(\underbrace{1, \ldots, 1}_{d-k}, \underbrace{\varepsilon, \ldots, \varepsilon}_{k}),
$$

and if $k \geq 3$, then $\lim _{\varepsilon \rightarrow 0} G_{1}\left(E\left(a_{\varepsilon}\right)\right)$ exists and is strictly positive. Similarly we were unable to prove the existence of a minimiser of the left-hand side of (18) at the critical point $q=(d-2) /(2 d-2)$.

The proofs of Theorems 1, 2, and 3 are deferred to Sections 2, 3, and 4 respectively. A key ingredient in these proofs is John's ellipsoid theorem 99 . This theorem asserts that for any open, bounded convex set $\Omega$ in $\mathbb{R}^{d}$ there exists a translation and rotation of $\Omega$, again denoted by $\Omega$, and an open ellipsoid $E(a)$ such that

$$
\begin{equation*}
E(a / d) \subset \Omega \subset E(a) . \tag{20}
\end{equation*}
$$

Moreover, among all ellipsoids in $\Omega, E(a / d)$ has maximal measure.
Finally in Section 5 we discuss the optimisation of a functional over all open bounded planar convex sets with fixed measure, and which involves the logarithmic capacity and torsional rigidity.

## 2 Proof of Theorem 1

Proof. To prove the assertion under (i) we let $\Omega$ be the disjoint union of an open ball $B^{\prime}$ of measure $1 / 2$ and an open ellipsoid $E\left(b_{\varepsilon}\right)$, with $b_{\varepsilon}=\left(L_{\varepsilon}, \ldots, L_{\varepsilon}, \varepsilon\right)$, of measure $1 / 2$, where

$$
L_{\varepsilon}=\left(2 \omega_{d} \varepsilon\right)^{1 /(1-d)} .
$$

We have, by (8) and (9),

$$
\begin{aligned}
\left.\operatorname{cap}\left(\overline{E\left(b_{\varepsilon}\right.}\right)\right) & =\frac{4 \pi^{d / 2}}{\Gamma(d / 2)}\left(\int_{0}^{\infty} d t\left(L_{\varepsilon}^{2}+t\right)^{(1-d) / 2}\left(\varepsilon^{2}+t\right)^{-1 / 2}\right)^{-1} \\
& \geq \frac{4 \pi^{d / 2}}{\Gamma(d / 2)}\left(\int_{0}^{\infty} d t\left(L_{\varepsilon}^{2}+t\right)^{(1-d) / 2} t^{-1 / 2}\right)^{-1} \\
& =\frac{4 \pi^{(d-1) / 2} \Gamma((d-1) / 2)}{\Gamma(d / 2) \Gamma((d-2) / 2)} L_{\varepsilon}^{d-2}
\end{aligned}
$$

where we have used formulae 8.380 .3 and 8.384.1 in [7]. Hence

$$
\begin{aligned}
G_{q}(\Omega) & =\operatorname{cap}\left(\overline{B^{\prime}} \cup \overline{E\left(b_{\varepsilon}\right)}\right) T\left(B^{\prime} \cup E\left(b_{\varepsilon}\right)\right)^{q} \\
& \geq \operatorname{cap}\left(\overline{E\left(b_{\varepsilon}\right)}\right) T\left(B^{\prime}\right)^{q} \\
& \geq \frac{4 \pi^{(d-1) / 2} \Gamma((d-1) / 2)}{\Gamma(d / 2) \Gamma((d-2) / 2)} T\left(B^{\prime}\right)^{q}\left(2 \omega_{d} \varepsilon\right)^{(d-2) /(1-d)}
\end{aligned}
$$

which tends to $+\infty$ as $\varepsilon \downarrow 0$.
To prove the assertion under (ii), we recall (4), and infer that $T^{q}(\Omega) \geq T^{q}\left(\Omega^{*}\right)$ for $q \leq 0$. This implies (13) by (5) and (11).

To prove (iii), we let $Q \subset \mathbb{R}^{d}$ be a cube with $|Q|=1$. Let $N \in \mathbb{N}$ be arbitrary. The cube $Q$ contains $N^{d}$ open disjoint cubes each of measure $N^{-d}$. Each open cube contains an open ball with radius $1 /(2 N)$. Let $Q_{N}$ be the union of these $N^{d}$ open balls. Since $Q_{N} \subset Q$ we have $\operatorname{cap}\left(\overline{Q_{N}}\right) \leq \operatorname{cap}(\bar{Q})$. On the other hand, additivity and scaling properties of the torsion give

$$
T\left(Q_{N}\right)=N^{d}(2 N)^{-(d+2)} T\left(B_{1}\right)=2^{-d-2} N^{-2} T\left(B_{1}\right)
$$

Furthermore,

$$
\left|Q_{N}\right|=\frac{\omega_{d}}{2^{d}}
$$

Hence

$$
\begin{aligned}
\inf \left\{G_{q}(\Omega): \Omega \text { open and bounded }\right\} & \leq \frac{\operatorname{cap}(\bar{Q}) T^{q}\left(Q_{N}\right)}{\left|Q_{N}\right|^{1+q+2(q-1) / d}} \\
& =\frac{2^{d-2}}{\omega_{d}^{1+q+2(q-1) / d}} \operatorname{cap}(\bar{Q}) T^{q}\left(B_{1}\right) N^{-2 q}
\end{aligned}
$$

This implies (17) since $q>0$, and $N \in \mathbb{N}$ was arbitrary.

## 3 Proof of Theorem 2

Proof. To prove (i) we consider the open ellipsoid $E\left(a_{\varepsilon}\right)$ with $a_{\varepsilon}=(1, \varepsilon, \ldots, \varepsilon)$. We have

$$
\left|E\left(a_{\varepsilon}\right)\right|=\omega_{d} \varepsilon^{d-1}
$$

$$
\begin{gathered}
T\left(E\left(a_{\varepsilon}\right)\right)=\frac{\omega_{d}}{d+2} \frac{\varepsilon^{d+1}}{d-1+\varepsilon^{2}}, \\
\operatorname{cap}\left(\overline{E\left(a_{\varepsilon}\right)}\right)= \begin{cases}4 \pi \varepsilon\left(\log \left(\varepsilon^{-1}\right)\right)^{-1}(1+o(1)), & d=3, \varepsilon \downarrow 0, \\
\frac{2 \pi^{d / 2}(d-3)}{\Gamma(d / 2)} \varepsilon^{d-3}(1+o(1)), & d>3, \varepsilon \downarrow 0,\end{cases}
\end{gathered}
$$

where we have used the formulae on p. 260 in [8]. Hence

$$
G_{q}\left(E\left(a_{\varepsilon}\right)\right)= \begin{cases}C_{3} \varepsilon^{2(q-1) / 3}\left(\log \varepsilon^{-1}\right)^{-1}(1+o(1)), & d=3, \varepsilon \downarrow 0, \\ C_{d} \varepsilon^{2(q-1) / d}(1+o(1)), & d>3, \varepsilon \downarrow 0 .\end{cases}
$$

where $C_{d}$ is a positive constant depending only on $d$. Since $q<1$ we obtain the desired result by letting $\varepsilon \downarrow 0$.

To prove (ii) we first observe that the formulae for $|E(a)|$, cap $(\overline{E(a)})$, and $T(E(a))$ are symmetric in the $a_{i}$ 's. Without loss of generality we may therefore assume here, and throughout this paper, that $a_{1} \geq a_{2} \geq \ldots \geq a_{d}$. By inclusion, and (20) we have

$$
\begin{equation*}
d^{-d} \omega_{d} \prod_{i=1}^{d} a_{i}=|E(a / d)| \leq|\Omega| \leq|E(a)|=\omega_{d} \prod_{i=1}^{d} a_{i} \tag{21}
\end{equation*}
$$

and

$$
\begin{equation*}
T(\Omega) \geq T(E(a / d))=\frac{\omega_{d}}{d^{d+2}(d+2)}\left(\prod_{i=1}^{d} a_{i}\right)\left(\sum_{i=1}^{d} \frac{1}{a_{i}^{2}}\right)^{-1} \geq \frac{\tau_{d}}{d^{d+2}}\left(\prod_{i=1}^{d} a_{i}\right) a_{d}^{2} . \tag{22}
\end{equation*}
$$

We have by (8),

$$
\begin{align*}
\mathfrak{e}(a) & \geq \int_{0}^{a_{d}^{2}} d t\left(\prod_{i=1}^{d}\left(a_{i}^{2}+t\right)\right)^{-1 / 2} \\
& \geq a_{d}^{2}\left(\prod_{i=1}^{d}\left(a_{i}^{2}+a_{d}^{2}\right)\right)^{-1 / 2} \\
& \geq 2^{-d / 2} a_{d}^{2}\left(\prod_{i=1}^{d} a_{i}^{2}\right)^{-1 / 2} \\
& =2^{-d / 2}\left(\prod_{i=1}^{d} a_{i}\right)^{-1} a_{d}^{2} . \tag{23}
\end{align*}
$$

By (9), (10) and (23), taking into account that $\Gamma(z+1)=z \Gamma(z), z>0$,

$$
\begin{equation*}
\operatorname{cap}(\bar{\Omega}) \leq \operatorname{cap}(\overline{E(a)}) \leq \frac{2^{(d+2) / 2} \kappa_{d}}{d-2}\left(\prod_{i=1}^{d} a_{i}\right) a_{d}^{-2} . \tag{24}
\end{equation*}
$$

By (11) and (3),

$$
\begin{equation*}
T(\Omega) \leq T(E(a)) \leq d \tau_{d}\left(\prod_{i=1}^{d} a_{i}\right) a_{d}^{2} \tag{25}
\end{equation*}
$$

By (21), (24), (25), $a_{1} \geq a_{2} \geq \ldots \geq a_{d}$, and $q>1$ we obtain,

$$
\begin{align*}
G_{q}(\Omega) & \leq \frac{\operatorname{cap}(\overline{E(a)}) T(E(a))^{q}}{|E(a / d)|^{1+q+2(q-1) / d}} \\
& \leq \frac{2^{(d+2) / 2} \kappa_{d}}{d-2}\left(d \tau_{d}\right)^{q}\left(d^{-d} \omega_{d}\right)^{-(1+q+2(q-1) / d)}\left(\prod_{i=1}^{d} a_{i}\right)^{2(1-q) / d} a_{d}^{2 q-2} \\
& =\frac{2^{(d+2) / 2} d^{3 q-2+d(q+1)}}{d-2} G_{q}\left(B_{1}\right)\left(\prod_{i=1}^{d} a_{i}\right)^{2(1-q) / d} a_{d}^{2 q-2} \\
& \leq \frac{2^{(d+2) / 2} d^{3 q-2+d(q+1)}}{d-2} G_{q}\left(B_{1}\right) \tag{26}
\end{align*}
$$

This proves (14).
To prove the existence of a maximiser, we observe that if the left-hand side of (14) equals $G_{q}\left(B_{1}\right)$ then $B_{1}$ is a maximiser which satisfies (15). If the left-hand side of (14) is strictly greater than $G_{q}\left(B_{1}\right)$, we let $\Omega$ be bounded, open, and convex, and such that

$$
\begin{equation*}
G_{q}(\Omega)>G_{q}\left(B_{1}\right) \tag{27}
\end{equation*}
$$

By the third inequality in (26), (27), $q>1$, and $a_{1} \geq a_{2} \geq \ldots \geq a_{d}$, we find that

$$
\begin{equation*}
a_{1} \leq \beta_{d}^{d /(2(q-1))} a_{d} \tag{28}
\end{equation*}
$$

where $\beta_{d}$ is the coefficient of $G_{q}\left(B_{1}\right)$ in the right-hand side of (26). Since

$$
\begin{equation*}
\operatorname{diam}(\Omega) \leq \operatorname{diam}(E(a)) \leq 2 a_{1} \tag{29}
\end{equation*}
$$

and

$$
\begin{equation*}
r(\Omega) \geq r(E(a / d))=\frac{a_{d}}{d} \tag{30}
\end{equation*}
$$

we obtain by (28)-(30),

$$
\begin{equation*}
\frac{\operatorname{diam}(\Omega)}{r(\Omega)} \leq 2 d\left(\frac{2^{(d+2) / 2} d^{3 q-2+d(q+1)}}{d-2}\right)^{d /(2(q-1))} \tag{31}
\end{equation*}
$$

Let $\left(\Omega_{n}\right)$ be a maximising sequence for the left-hand side of (14). Since this supremum is scaling invariant we fix $r\left(\Omega_{n}\right)=1$. By (31), $\operatorname{diam}\left(\Omega_{n}\right) \leq L$ for some $L<\infty$, and for all $n$. By taking translations of $\left(\Omega_{n}\right)$ these translates are contained in a closed ball $B_{L}$ of radius $L$. Since the Hausdorff metric is compact on the space of convex, compact sets in $B_{L}$, there exists a subsequence of $\left(\overline{\Omega_{n}}\right)$, again denoted by $\left(\overline{\Omega_{n}}\right)$ which converges in the Hausdorff (and in the complementary Hausdorff) metric to an element say $\tilde{\Omega}^{+}$. Set $\Omega^{+}=\operatorname{int}\left(\tilde{\Omega}^{+}\right)$. Note that $\Omega^{+}$is an open, bounded, convex set which is non-empty since $\Omega^{+}$ has inradius 1. Furthermore measure, torsion, capacity, and diameter are all continuous with respect to this metric. Hence

$$
G_{q}\left(\Omega^{+}\right)=\lim _{n \rightarrow \infty} G_{q}\left(\Omega_{n}\right)
$$

and $\Omega^{+}$is a maximiser which satisfies (15).
To prove (iii) we let $q=1$ and $d=3$. Let $\Omega$ be an element of a maximising sequence. We may assume that

$$
\begin{equation*}
G_{1}\left(B_{1}\right) \leq G_{1}(\Omega) \leq \frac{\operatorname{cap}(\overline{E(a)}) T(E(a))}{|E(a / 3)|^{2}} \tag{32}
\end{equation*}
$$

We obtain an upper bound on $\operatorname{cap}(\overline{E(a)})$ by obtaining a lower bound on $\mathfrak{e}(a)$. By (9), we have

$$
\begin{align*}
\mathfrak{e}\left(a_{1}, a_{2}, a_{3}\right) & \geq \int_{0}^{\infty}\left(a_{1}^{2}+t\right)^{-1 / 2}\left(a_{2}^{2}+t\right)^{-1} d t \\
& =\frac{2}{\left(a_{1}^{2}-a_{2}^{2}\right)^{1 / 2}} \log \left(\frac{a_{1}}{a_{2}}+\left(\frac{a_{1}^{2}}{a_{2}^{2}}-1\right)^{1 / 2}\right) \\
& \geq \frac{2}{a_{1}} \log \left(a_{1} a_{2}^{-1}\right) \tag{33}
\end{align*}
$$

By (8) for $d=3$, and (33),

$$
\operatorname{cap}(\overline{E(a)}) \leq \kappa_{3} a_{1}\left(\log \left(a_{1} a_{2}^{-1}\right)\right)^{-1}
$$

Since $\Omega \subset B_{a_{1}}$, we also have

$$
\operatorname{cap}(\bar{\Omega}) \leq \operatorname{cap}\left(\overline{B_{a_{1}}}\right)=\kappa_{3} a_{1}
$$

Hence

$$
\operatorname{cap}(\bar{\Omega}) \leq \kappa_{3} a_{1} \min \left\{1,\left(\log \left(a_{1} a_{2}^{-1}\right)\right)^{-1}\right\}
$$

In addition,

$$
T(E(a)) \leq 3 \tau_{3} a_{1} a_{2} a_{3}^{3}, \quad|E(a / 3)|=3^{-3} \omega_{3} a_{1} a_{2} a_{3}
$$

Summarising, from (32) we obtain

$$
\begin{equation*}
G_{1}(\Omega) \leq 3^{7} G_{1}\left(B_{1}\right) \cdot \frac{a_{3}}{a_{2}} \cdot \min \left\{1,\left(\log \left(a_{1} a_{2}^{-1}\right)\right)^{-1}\right\} \tag{34}
\end{equation*}
$$

If the supremum in the left-hand side of (14) equals $G_{1}\left(B_{1}\right)$, then $B_{1}$ is a maximiser which satisfies (16). If not then we may assume that $G_{1}(\Omega)>G_{1}\left(B_{1}\right)$. This, together with (34), yields $a_{3} \geq 3^{-7} a_{2}, a_{1} \leq a_{2} e^{3^{7}}$. These inequalities imply that $a_{1} / a_{3} \leq 3^{7} e^{3^{7}}$. Hence (29) and (30) yield

$$
\frac{\operatorname{diam}(\Omega)}{r(\Omega)} \leq 2 \cdot 3^{8} e^{3^{7}}
$$

The remaining part of the proof follows similar lines as those in the proof of (ii).

## 4 Proof of Theorem 3

Proof. To prove (i), we consider as $\Omega$ the ellipsoid $E(a)$ with

$$
a=\left(a_{1}, \ldots, a_{1}, a_{d}\right), \quad a_{1} \geq a_{d}, \quad a_{1}^{d-1} a_{d}=1
$$

where $a_{d} \in(0,1)$ is arbitrary. Since $E(a) \subset B_{a_{1}}$ we have by (6), (17) and (10),

$$
\begin{equation*}
\operatorname{cap}(\overline{E(a)}) \leq \kappa_{d} a_{1}^{d-2} \tag{35}
\end{equation*}
$$

By (3) and (35),

$$
G_{q}(E(a)) \leq \frac{\kappa_{d} a_{1}^{d-2}}{\omega_{d}^{1+q+2(q-1) / d}}\left(\frac{\omega_{d}}{d+2} \frac{a_{1}^{2} a_{d}^{2}}{(d-1) a_{d}^{2}+a_{1}^{2}}\right)^{q} \leq \frac{\kappa_{d} a_{1}^{d-2} a_{d}^{2 q}}{\omega_{d}^{1+2(q-1) / d}(d+2)^{q}}
$$

Since $a_{1}=a_{d}^{-1 /(d-1)}$ we have

$$
G_{q}(E(a)) \leq \frac{\kappa_{d}}{\omega_{d}^{1+2(q-1) / d}(d+2)^{q}} a_{d}^{-(d-2) /(d-1)+2 q},
$$

and since $a_{d} \in(0,1)$ was arbitrary we obtain (17).
To prove (ii) we let $a_{1} \geq a_{2} \geq \ldots \geq a_{d}$. We have

$$
\begin{equation*}
\operatorname{cap}(\bar{\Omega}) \geq \operatorname{cap}(\overline{E(a / d)})=d^{2-d} \operatorname{cap}(\overline{E(a)})=\frac{2 \kappa_{d}}{d^{d-2}(d-2)}(\mathfrak{e}(a))^{-1} . \tag{36}
\end{equation*}
$$

In order to obtain an upper bound on $\mathfrak{e}(a)$ we have by using the inequality $\left(x^{2}+t\right)^{1 / 2} \geq$ $2^{-1 / 2}\left(x+t^{1 / 2}\right)$, and the change of variables $t=\theta^{2}$,

$$
\begin{align*}
\mathfrak{e}(a) & \leq\left(\prod_{i \leq d-3} a_{i}^{-1}\right) \int_{0}^{\infty} d t\left(\left(a_{d-2}^{2}+t\right)\left(a_{d-1}^{2}+t\right)\left(a_{d}^{2}+t\right)\right)^{-1 / 2} \\
& \leq\left(\prod_{i \leq d-3} a_{i}^{-1}\right) \int_{0}^{\infty} d t\left(\left(a_{d-2}^{2}+t\right)\left(a_{d-1}^{2}+t\right) t\right)^{-1 / 2} \\
& \leq 2\left(\prod_{i \leq d-3} a_{i}^{-1}\right) \int_{0}^{\infty} d t\left(\left(a_{d-2}+t^{1 / 2}\right)\left(a_{d-1}+t^{1 / 2}\right) t^{1 / 2}\right)^{-1} \\
& =4\left(\prod_{i \leq d-3} a_{i}^{-1}\right) \int_{0}^{\infty} d \theta\left(\left(a_{d-2}+\theta\right)\left(a_{d-1}+\theta\right)\right)^{-1} \\
& =4\left(\prod_{i \leq d-2} a_{i}^{-1}\right)\left(1-\frac{a_{d-1}}{a_{d-2}}\right)^{-1} \log \left(a_{d-2} / a_{d-1}\right), \tag{37}
\end{align*}
$$

where the product over the empty set in the right-hand side of (37) is defined to be equal to 1 , and where the case $a_{d-2}=a_{d-1}$ follows by taking the appropriate limit in the right-hand side of (37). It is elementary to verify that

$$
(1-x)^{-1} \log \left(x^{-1}\right) \leq \log (e / x), \quad 0<x<1,
$$

and

$$
\lim _{x \uparrow 1}(1-x)^{-1} \log \left(x^{-1}\right)=1 .
$$

This gives by (37),

$$
\begin{equation*}
\mathfrak{e}(a) \leq 4\left(\prod_{i \leq d-2} a_{i}^{-1}\right) \log \left(e a_{d-2} / a_{d-1}\right) . \tag{38}
\end{equation*}
$$

Hence by (36) and (38),

$$
\begin{equation*}
\operatorname{cap}(\bar{\Omega}) \geq \frac{\kappa_{d}}{2 d^{d-2}(d-2)}\left(\prod_{i \leq d-2} a_{i}\right)\left(\log \left(e a_{d-2} / a_{d-1}\right)\right)^{-1} . \tag{39}
\end{equation*}
$$

By (21), (222), and (39),

$$
\begin{equation*}
G_{q}(\Omega) \geq \frac{1}{2 d^{d-2+(d+2) q}(d-2)} G_{q}\left(B_{1}\right) \frac{a_{d}^{2 q-1}}{a_{d-1}}\left(\prod_{i=1}^{d} a_{i}\right)^{2(1-q) / d}\left(\log \left(e a_{d-2} / a_{d-1}\right)\right)^{-1} . \tag{40}
\end{equation*}
$$

The $a$-dependence in the right-hand side of (40) is scaling invariant. It is convenient to choose $\prod_{i=1}^{d} a_{i}=1$. We then have

$$
\frac{a_{d-2}}{a_{d-1}}=\left(\prod_{i \leq d-3} a_{i}^{-1}\right) a_{d-1}^{-2} a_{d}^{-1} \leq a_{d-1}^{-(d-1)} a_{d}^{-1} .
$$

This gives with (40),

$$
\begin{equation*}
G_{q}(\Omega) \geq \frac{1}{2 d^{d-2+(d+2) q}(d-2)} G_{q}\left(B_{1}\right) \frac{a_{d}^{2 q-1}}{a_{d-1}}\left(\log \left(e /\left(a_{d-1}^{d-1} a_{d}\right)\right)\right)^{-1} . \tag{41}
\end{equation*}
$$

Since

$$
x^{1 /(d-1)} \log (e / x) \leq d-1, \quad 0<x<1,
$$

we have, with $x=a_{d-1}^{d-1} a_{d}$,

$$
\left(\log \left(e /\left(a_{d-1}^{d-1} a_{d}\right)\right)\right)^{-1} \geq a_{d-1} a_{d}^{1 /(d-1)}(d-1)^{-1} .
$$

This, together with (41), gives

$$
\begin{align*}
G_{q}(\Omega) & \geq \frac{1}{2 d^{d-2+(d+2) q}(d-2)(d-1)} G_{q}\left(B_{1}\right) a_{d}^{2 q-\frac{d-2}{d-1}} \\
& \geq \frac{1}{2 d^{d+(d+2) q}} G_{q}\left(B_{1}\right) a_{d}^{2 q-\frac{d-2}{d-1}} . \tag{42}
\end{align*}
$$

This proves (18) since $a_{d} \in(0,1]$, and $q \leq(d-2) /(2(d-1))$.
To prove the existence of a minimiser, we observe that if the left-hand side of (18) equals $G_{q}\left(B_{1}\right)$ then $B_{1}$ is a minimiser which satisfies (19). If the left-hand side of (18) is strictly less than $G_{q}\left(B_{1}\right)$, we let $\Omega$ be bounded and convex such that

$$
\begin{equation*}
G_{q}(\Omega)<G_{q}\left(B_{1}\right) . \tag{43}
\end{equation*}
$$

By (42) and (43) we infer

$$
\begin{equation*}
a_{d} \geq\left(\frac{1}{2 d^{d+(d+2) q}}\right)^{(d-1) /(d-2-2 q(d-1))} . \tag{44}
\end{equation*}
$$

Since $\prod_{i=1}^{d} a_{i}=1$, and $a_{1} \geq a_{2} \geq \ldots \geq a_{d}$ we have $a_{1} \leq a_{d}^{1-d}$. By (29), (30) and (44) we obtain,

$$
\begin{equation*}
\frac{\operatorname{diam}(\Omega)}{r(\Omega)} \leq 2 d a_{d}^{-d} \leq 2 d\left(2 d^{d+(d+2) q}\right)^{\frac{d(d-1)}{d-2-2 q(d-1)}} . \tag{45}
\end{equation*}
$$

The proof of the existence of a minimiser is similar to the proof of the existence of a maximiser in Theorem 1 (ii), and has been omitted. If $\Omega^{-}$is a minimiser then, by continuity of diameter and inradius, $\Omega^{-}$satisfies (45). This proves (19).

## 5 The logarithmic capacity

We briefly recall some basic properties of the logarithmic capacity of a compact set $K$ in $\mathbb{R}^{2}$. Let $\mu$ be a probability measure supported on $K$, and let

$$
I(\mu)=\iint_{K \times K} \log \left(\frac{1}{|x-y|}\right) \mu(d x) \mu(d y) .
$$

Furthermore let

$$
V(K)=\inf \{I(\mu): \mu \text { a probability measure on } K\} .
$$

The logarithmic capacity of $K$ is denoted by cap $(K)$, and is the non-negative real number

$$
\operatorname{cap}(K)=e^{-V(K)} .
$$

It shares some of the properties of the Newtonian capacity. In particular if $K_{1}$ and $K_{2}$ are compact sets in $\mathbb{R}^{2}$ with $K_{1} \subset K_{2}$ then $\operatorname{cap}\left(K_{1}\right) \leq \operatorname{cap}\left(K_{2}\right)$. Moreover, $\operatorname{cap}(K)$ is invariant under translations and rotations of $K$, and

$$
\begin{equation*}
\operatorname{cap}(K) \geq \operatorname{cap}\left(K^{*}\right), \tag{46}
\end{equation*}
$$

where $K^{*}$ is the disc with $|K|=\left|K^{*}\right|$. See [] for some refinements. Finally for a homothety,

$$
\begin{equation*}
\operatorname{cap}(t K)=t \operatorname{cap}(K), \quad t>0 . \tag{47}
\end{equation*}
$$

The classic treatise [10] gives various planar domains for which the logarithmic capacity can be computed analytically. In particular for the ellipse with semi axes $a_{1}$ and $a_{2}$,

$$
\begin{equation*}
\operatorname{cap}\left(\overline{E\left(a_{1}, a_{2}\right)}\right)=\frac{1}{2}\left(a_{1}+a_{2}\right) . \tag{48}
\end{equation*}
$$

For an open, bounded, convex planar set $\Omega$ we define the functional

$$
H_{q}(\Omega)=\frac{\operatorname{cap}(\bar{\Omega}) T^{q}(\Omega)}{|\Omega|^{(1+4 q) / 2}} .
$$

In particular we have

$$
H_{q}\left(B_{1}\right)=\frac{\tau_{2}^{q}}{\omega_{2}^{(1+4 q) / 2}}=\frac{1}{8^{q} \pi^{q+1 / 2}} .
$$

We immediately see that by (2), and (47) that $H_{q}(t \Omega)=H_{q}(\Omega), t>0$. Our main result is the following.

Theorem 4. (i) If $q \geq 1 / 2$, then

$$
\begin{equation*}
\sup \left\{H_{q}(\Omega): \Omega \text { open, bounded, planar, and convex }\right\} \leq 2^{1+5 q} H_{q}\left(B_{1}\right) . \tag{49}
\end{equation*}
$$

(ii) If $q>1 / 2$ then the left-hand side of (49) has an open, bounded, planar, and convex maximiser. For any such maximiser, say $\Omega^{+}$,

$$
\begin{equation*}
\frac{\operatorname{diam}\left(\Omega^{+}\right)}{r\left(\Omega^{+}\right)} \leq \frac{2^{14 q}}{2 q-1} . \tag{50}
\end{equation*}
$$

(iii) If $q<1 / 2$, then

$$
\begin{equation*}
\sup \left\{H_{q}(\Omega): \Omega \text { open, bounded, planar, and convex }\right\}=+\infty . \tag{51}
\end{equation*}
$$

(iv) If $q \leq 1 / 2$, then

$$
\begin{equation*}
\inf \left\{H_{q}(\Omega): \Omega \text { open, bounded, planar, and convex }\right\} \geq 2^{-2(1+2 q)} H_{q}\left(B_{1}\right) . \tag{52}
\end{equation*}
$$

(v) If $q<1 / 2$ then the left-hand side of (52) has an open, bounded, planar, and convex minimiser. For any such minimiser, say $\Omega^{-}$,

$$
\begin{equation*}
\frac{\operatorname{diam}\left(\Omega^{-}\right)}{r\left(\Omega^{-}\right)} \leq 2^{2(3+2 q) /(1-2 q)} \tag{53}
\end{equation*}
$$

(vi) If $q>1 / 2$, then

$$
\inf \left\{H_{q}(\Omega): \Omega \text { open, bounded, planar, and convex }\right\}=0
$$

Proof. (i) If $E(a)$ is the John's ellipsoid for $\Omega$ then, $E(a / 2) \subset \Omega \subset E(a)$ with $a_{1} \geq a_{2}$. Furthermore,

$$
\operatorname{cap}(\overline{E(a)}) \leq a_{1}, \quad T(E(a)) \leq 2 \tau_{2} a_{1} a_{2}^{3}, \quad|\Omega| \geq|E(a / 2)|=\omega_{2} a_{1} a_{2} / 4
$$

so that

$$
\begin{equation*}
H_{q}(\Omega) \leq 2^{1+5 q} \frac{\tau_{2}^{q}}{\omega_{2}^{(1+4 q) / 2}}\left(\frac{a_{2}}{a_{1}}\right)^{q-1 / 2} \tag{54}
\end{equation*}
$$

This implies (49) since $q \geq 1 / 2$.
(ii) To prove (50) we have that either the supremum in the left-hand side of (49) is attained for a ball, in which case the maximiser exists and satisfies (50), or we may assume that $H_{q}(\Omega)>H_{q}\left(B_{1}\right)$. This implies, by (29) and (30), that

$$
\frac{\operatorname{diam}(\Omega)}{r(\Omega)} \leq \frac{2^{14 q}}{2 q-1}
$$

The remaining part of the proof is similar to the corresponding parts in the proof of Theorem 2.
(iii) By (21), (22), and (48),

$$
\begin{equation*}
H_{q}(\Omega) \geq 2^{-2(1+2 q)} \frac{\tau_{2}^{q}}{\omega_{2}^{(1+4 q) / 2}}\left(\frac{a_{2}}{a_{1}}\right)^{q-1 / 2} \tag{55}
\end{equation*}
$$

This implies (51) by letting $a_{2} / a_{1} \rightarrow 0$ in (55).
(iv) This follows from (55) and $a_{1} \geq a_{2}$.
(v) Either the infimum in the left-hand side of (52) is attained for a ball, in which case the minimiser exists and satisfies (53), or we may assume that $H_{q}(\Omega)<H_{q}\left(B_{1}\right)$. By (55), (29), and (30)

$$
\frac{\operatorname{diam}(\Omega)}{r(\Omega)} \leq 2^{\frac{2(3+2 q)}{1-2 q}}
$$

The remaining part of the proof is similar to the corresponding parts in the proof of Theorem 2.
(vi) This follows by letting $a_{2} / a_{1} \rightarrow 0$ in (54).
