# On number of pendants in local antimagic chromatic number

#### Abstract

An edge labeling of a connected graph $G=(V, E)$ is said to be local antimagic if it is a bijection $f: E \rightarrow\{1, \ldots,|E|\}$ such that for any pair of adjacent vertices $x$ and $y, f^{+}(x) \neq f^{+}(y)$, where the induced vertex label $f^{+}(x)=\sum f(e)$, with $e$ ranging over all the edges incident to $x$. The local antimagic chromatic number of $G$, denoted by $\chi_{l a}(G)$, is the minimum number of distinct induced vertex labels over all local antimagic labelings of $G$. Let $\chi(G)$ be the chromatic number of $G$. In this paper, sharp upper and lower bounds of $\chi_{l a}(G)$ for $G$ with pendant vertices, and sufficient conditions for the bounds to equal, are obtained. Consequently, for $k \geq 1$, there are infinitely many graphs with $k \geq \chi(G)-1$ pendant vertices and $\chi_{l a}(G)=k+1$. We conjecture that every tree $T_{k}$, other than certain caterpillars, spiders and lobsters, with $k \geq 1$ pendant vertices has $\chi_{l a}\left(T_{k}\right)=k+1$.

## 1 Introduction

A connected graph $G=(V, E)$ is said to be local antimagic if it admits a local antimagic edge labeling, i.e., a bijection $f: E \rightarrow\{1, \ldots,|E|\}$ such that the induced vertex labeling $f^{+}: V \rightarrow \mathbb{Z}$ given by $f^{+}(u)=\sum f(e)$ (with $e$ ranging over all the edges incident to $u$ ) has the property that any two adjacent vertices have distinct induced vertex labels [1]. Thus, $f^{+}$is a coloring of $G$. Clearly, the order of $G$ must be at least 3 . The vertex label $f^{+}(u)$ is called the induced color of $u$ under $f$ (the color of $u$, for short, if no ambiguous occurs). The number of distinct induced colors under $f$ is denoted by $c(f)$, and is called the color number of $f$. The local antimagic chromatic number of $G$, denoted by $\chi_{l a}(G)$, is $\min \{c(f): f$ is a local antimagic labeling of $G\}$. Clearly, $2 \leq \chi_{l a}(G) \leq|V(G)|$. Haslegrave 4] proved that every graph is local antimagic. This paper relates the number of pendant vertices of $G$ to $\chi_{l a}(G)$. Sharp upper and lower bounds, and sufficient conditions for the bounds to equal, are obtained. Consequently, there exist infinitely many graphs with $k \geq \chi(G)-1 \geq 1$ pendant vertices and $\chi_{l a}(G)=k+1$. We conjecture that every tree $T_{k}$, other than certain caterpillars, with $k \geq 1$ pendant vertices has $\chi_{l a}\left(T_{k}\right)=k+1$. The following two results in [7] are needed.

Lemma 1.1. Let $G$ be a graph of size $q$ containing $k$ pendants. Let $f$ be a local antimagic labeling of $G$ such that $f(e)=q$. If $e$ is not a pendant edge, then $c(f) \geq k+2$.

[^0]Theorem 1.2. Let $G$ be a graph having $k$ pendants. If $G$ is not $K_{2}$, then $\chi_{l a}(G) \geq k+1$ and the bound is sharp.

The sharp bound for $k \geq 2$ is given by the star $S_{k}$ with maximum degree $k$. The left labeling below is another example for $k=2$. The right labeling shows that the lower bound is sharp for $k=1$.


For $1 \leq i \leq t, a_{i}, n_{i} \geq 1$ and $d=\sum_{i=1}^{t} n_{i} \geq 3$, a spider of $d$ legs, denoted $S p\left(a_{1}^{\left[n_{1}\right]}, a_{2}^{\left[n_{2}\right]}, \ldots, a_{t}^{\left[n_{t}\right]}\right)$, is a tree formed by identifying an end-vertex of $n_{i}$ path(s) of length $a_{i}$. The vertex $u$ of degree $d$ is the core of the spider. Note that $S p\left(1^{[n]}\right)$ is the star graph of $n$ pendant vertices with $\chi_{l a}\left(S p\left(1^{[n]}\right)\right)=n+1$. We first give a family of spiders with $k$ pendant vertices to have $\chi_{l a}>k+1$.

Theorem 1.3. For $n \geq 3$,

$$
\chi_{l a}\left(S p\left(2^{[n]}\right)= \begin{cases}n+2 & \text { if } n \geq 4 \\ n+1 & \text { otherwise }\end{cases}\right.
$$

Proof. Let the neighbors of $u$ be $v_{1}, \ldots, v_{n}$. Let $w_{i}$ be the pendant adjacent to $v_{i}, 1 \leq i \leq n$. By Theorem [1.2, it is easy to conclude that $\chi_{l a}\left(S p\left(2^{[3]}\right)\right)=4$. Consider $n \geq 4$. Let $f$ be a local antimagic labeling of $S p\left(2^{[n]}\right)$ with minimum $c(f)$. By Lemma 1.1 and symmetry, suffice to consider $f\left(v_{1} w_{1}\right)=2 n=f^{+}\left(w_{1}\right)$. By definition, $f^{+}(u) \neq f^{+}\left(v_{1}\right)$. Now, $f^{+}(u)>n(n+1) / 2>2 n \geq f^{+}\left(w_{i}\right)$ and $f^{+}\left(v_{1}\right)=2 n>f^{+}\left(w_{i}\right)$ for $1 \leq i \leq n$. Thus, $c(f) \geq n+2$ and $\chi_{l a}\left(S p\left(2^{[n]}\right)\right) \geq n+2$.

Define a bijection $f: E\left(S p\left(2^{[n]}\right)\right) \rightarrow[1,2 n]$ such that $f\left(u v_{i}\right)=i$ and $f\left(v_{i} w_{i}\right)=2 n+1-i$. We have $f^{+}(u)=n(n+1) / 2>f^{+}\left(v_{i}\right)=2 n+1>f^{+}\left(w_{i}\right)=2 n+1-i, 1 \leq i \leq n$. Consequently, $\chi_{l a}\left(S p\left(2^{[n]}\right)\right)=n+2$ for $n \geq 4$. The theorem holds.

## 2 Adding pendant edges

Suppose $G$ has $e \geq 2$ edges with $\chi_{l a}(G)=t \geq 2$ such that the corresponding local antimagic labeling $f$ induces a $t$-independent set $\left\{V_{1}, V_{2}, \ldots, V_{t}\right\}$ with $\left|V_{i}\right|=n_{i} \geq 1$. Moreover, each non-pendant vertex must be in one of $V_{i}$ for $1 \leq i \leq r \leq t$, and $V_{i}$ is a singleton consisting of a pendant vertex for $r+1 \leq i \leq t$ if $r<t$. Let $f^{+}(v)=c_{i}$ for each vertex $v \in V_{i}$. Without loss of generality, we assume that $c_{1}<c_{2}<\cdots<c_{r}$ and that $c_{r+1}<c_{r+2}<\cdots<c_{t}$. Note that $c_{r+1}$ to $c_{t}$ do not exist for $r=t$. By Theorem 1.2, $G$ contains at most $t-1$ pendant vertices.

Let $b \geq 0$ be the number of pendant vertices in $\cup_{i=1}^{r} V_{i}$ so that $G$ has exactly $t-r+b$ pendant vertices. Let $f\left(u^{\prime} v^{\prime}\right)=e \leq f^{+}\left(u^{\prime}\right)<f^{+}\left(v^{\prime}\right)$ such that $v^{\prime} \in V_{i}, 1 \leq i \leq r$ and that $u^{\prime} \in V_{j}$. Suppose $e=f^{+}\left(u^{\prime}\right)$, then $u^{\prime}$ is a pendant vertex. We now have (a) $j<i \leq r$ so that $1 \leq b \leq j$ or (b) $i \leq r<j$ so that $0 \leq b \leq i-1$. Otherwise, if $e<f^{+}\left(u^{\prime}\right)$, then $u^{\prime}$ is not a pendant vertex so that $j<i \leq r$ and $0 \leq b \leq j-1$.

Let $G\left(V_{i}, s\right)$ be a graph obtained from $G$ by adding $s$ pendant edges $v_{a} w_{a, k}(1 \leq k \leq s)$ to each vertex in $V_{i}=\left\{v_{a} \mid 1 \leq a \leq n_{i}\right\}$.

Theorem 2.1. Suppose $G$ and $G\left(V_{i}, s\right)$ are as defined above. Let $r \geq 2$ and

$$
e+s n_{i} \geq \begin{cases}c_{r} & \text { for } i<r \\ c_{r-1} & \text { for } i=r\end{cases}
$$

such that $s \geq 1$ if $n_{i}=1$, and $s \geq 2$ is even if $n_{i} \geq 2$.
(1) Suppose $e<c_{1}$. For $1 \leq i \leq r, \chi_{l a}\left(G\left(V_{i}, s\right)\right)=s n_{i}+t-r+1$.
(2) Suppose $c_{1} \leq e<c_{2}$, then $\chi_{l a}\left(G\left(V_{1}, s\right)\right)=s n_{1}+t-r+1$. For $2 \leq i \leq r$, $s n_{i}+t-r+b+1 \leq$ $\chi_{l a}\left(G\left(V_{i}, s\right)\right) \leq s n_{i}+t-r+2$. Moreover, if $c_{1}=e$ and $b=1$, then $\chi_{l a}\left(G\left(V_{i}, s\right)\right)=s n_{i}+t-r+2$.
(3) Suppose $c_{j-1} \leq e<c_{j}$ for $3 \leq j \leq r$, then
(a) $s n_{i}+t-r+b \leq \chi_{l a}\left(G\left(V_{i}, s\right)\right) \leq s n_{i}+t-r+j-1$ for $1 \leq i \leq j-1$, if $V_{i}$ has a pendant vertex;
(b) $s n_{i}+t-r+b+1 \leq \chi_{l a}\left(G\left(V_{i}, s\right)\right) \leq s n_{i}+t-r+j-1$ for $1 \leq i \leq j-1$, if $V_{i}$ has no pendant vertex;
(c) $s n_{i}+t-r+b+1 \leq \chi_{l a}\left(G\left(V_{i}, s\right)\right) \leq s n_{i}+t-r+j$ for $j \leq i \leq r$.

Moreover, when $c_{j-1}=e$ and $b=j-1, \chi_{l a}\left(G\left(V_{i}, s\right)\right)=s n_{i}+t-r+j-1$ for $1 \leq i \leq j-1$, and $\chi_{l a}\left(G\left(V_{i}, s\right)\right)=s n_{i}+t-r+j$ for $j \leq i \leq r$.

In particular, if $c_{r-1} \leq e<c_{r}$, then in $G\left(V_{r}, s\right)$, the condition on $e+s n_{i}$ is simplified to $s \geq 1$ for $n_{r}=1$, and $s \geq 2$ is even for $n_{r} \geq 2$.

Proof. Note that $G$ must contain a non-pendant vertex $v$ such that $f^{+}(v)>e$. So $c_{r}>e \geq c_{t}$. Moreover, $u v \notin E(G)$ implies that $u v \notin E\left(G\left(V_{i}, s\right)\right)$. For $1 \leq i \leq r$, define a bijection $g_{i}: E\left(G\left(V_{i}, s\right)\right) \rightarrow\left[1, e+s n_{i}\right]$ such that $g_{i}(e)=f(e)$ if $e \in E(G)$ and that

$$
g_{i}\left(v_{a} w_{a, k}\right)=e+\left[k+\frac{(-1)^{k}}{2}-\frac{1}{2}\right] n_{i}-(-1)^{k}\left(a-\frac{1}{2}\right)+\frac{1}{2}= \begin{cases}e+(k-1) n_{i}+a & \text { if } k \text { is odd } \\ e+k n_{i}+1-a & \text { if } k \text { is even }\end{cases}
$$

Therefore $g_{i}^{+}\left(v_{a}\right)=c_{i}+e s+\frac{s}{2}\left(s n_{i}+1\right)>e+s n_{i}$ when $s$ is even; $g_{i}^{+}\left(v_{a}\right)=c_{i}+e s+\frac{s}{2}(s+1)+a-1>e+s n_{i}$ when $s$ is odd (in this case $n_{i}=1$ and $a=1$ ).
Observe that $g_{i}^{+}(v)=f^{+}(v)$ for each $v \notin V_{i}$ so that $c_{1}, \ldots, c_{i-1}, c_{i+1}, \ldots, c_{t}$ are vertex colors under $g_{i}$. Moreover, for $v_{a} \in V_{i}, f^{+}\left(v_{a}\right)$ is replaced by $g_{i}^{+}\left(v_{a}\right)>c_{t}$ for $1 \leq a \leq n_{i}$ and $\left\{g_{i}^{+}\left(w_{a, k}\right)=g_{i}\left(v_{a} w_{a, k}\right) \mid 1 \leq a \leq n_{i}, 1 \leq k \leq s\right\}=\left[e+1, e+s n_{i}\right]$.
(1) Since $e<c_{1}$, in $G\left(V_{i}, s\right)$, we have $c_{r+1}<\cdots<c_{t}<e+1 \leq c_{1}<\cdots<c_{r} \leq e+s n_{i}$ when $1 \leq i<r$, and $c_{r+1}<\cdots<c_{t}<e+1 \leq c_{1}<\cdots<c_{r-1} \leq e+s n_{i}$ when $i=r$. So $\left(\left\{c_{j} \mid 1 \leq j \leq r\right\} \backslash\left\{c_{i}\right\}\right) \subset\left[e+1, e+s n_{i}\right]$ but all the $c_{r+1}, \ldots, c_{t}$ are not in $\left[e+1, e+s n_{i}\right]$. Since $c_{i}+e s+\frac{s}{2}\left(n_{i} s+1\right)>e+s n_{i}, g_{i}$ is a local antimagic labeling with induced vertex color set $\left\{c_{r+1}, c_{r+2}, \ldots, c_{t}\right\} \cup\left[e+1, e+s n_{i}\right] \cup\left\{c_{i}+e s+\frac{s}{2}\left(n_{i} s+1\right)\right\}$. Therefore, $\chi_{l a}\left(G\left(V_{i}, s\right)\right) \leq s n_{i}+t-r+1$. Since $G\left(V_{i}, s\right)$ contains at least $s n_{i}+t-r$ pendant vertices, by Theorem [1.2, $\chi_{l a}\left(G\left(V_{i}, s\right)\right) \geq s n_{i}+t-r+1$. Thus, $\chi_{l a}\left(G\left(V_{i}, s\right)\right)=s n_{i}+t-r+1$.
(2) For $c_{1} \leq e<c_{2}$, in $G\left(V_{i}, s\right)$, similar to the above case, $\left(\left\{c_{j} \mid 1 \leq j \leq r\right\} \backslash\left\{c_{1}, c_{i}\right\}\right) \subset\left[e+1, e+s n_{i}\right]$ but all the $c_{1}, c_{r+1}, \ldots, c_{t}$ are not in $\left[e+1, e+s n_{i}\right]$.
Suppose $i=1$, then $g_{1}$ is a local antimagic labeling with induced vertex color set $\left\{c_{r+1}, c_{r+2}, \ldots, c_{t}\right\} \cup$ $\left[e+1, e+s n_{1}\right] \cup\left\{c_{1}+e s+\frac{s}{2}\left(n_{1} s+1\right)\right\}$. Thus, $\chi_{l a}\left(G\left(V_{1}, s\right)\right) \leq s n_{1}+t-r+1$. By the same argument of (1), we get $\chi_{l a}\left(G\left(V_{1}, s\right)\right)=s n_{1}+t-r+1$.
Suppose $2 \leq i \leq r$. In this case, $0 \leq b \leq 1$. Similar to the above case, $g_{i}$ is a local antimagic labeling with induced vertex color set $\left\{c_{r+1}, c_{r+2}, \ldots, c_{t}, c_{1}\right\} \cup\left[e+1, e+s n_{i}\right] \cup\left\{c_{i}+e s+\frac{s}{2}\left(s n_{i}+1\right)\right\}$. Thus, $\chi_{l a}\left(G\left(V_{1}, s\right)\right) \leq s n_{i}+t-r+2$. Combining with Theorem 1.2, we have $s n_{i}+t-r+b+1 \leq \chi_{l a}\left(G\left(V_{i}, s\right)\right) \leq$ $s n_{i}+t-r+2$. Moreover, $e=c_{1}$ implies that $b=1$ so $\chi_{l a}\left(G\left(V_{i}, s\right)\right)=s n_{i}+t-r+2$.
(3) For $c_{j-1} \leq e<c_{j}, 3 \leq j \leq r$, we have $0 \leq b \leq j-1$. In $G\left(V_{i}, s\right)$, similar to above case, $\left\{c_{j}, \ldots, c_{r}\right\} \subset$ $\left[e+1, e+s n_{i}\right]$ but all the $c_{1}, \ldots, c_{j-1}$ are not in $\left[e+1, e+s n_{i}\right]$. Similar to the above case, if $1 \leq i \leq j-1$, then $g_{i}$ is a local antimagic labeling with induced vertex color set $\left\{c_{k} \mid r+1 \leq k \leq t\right\} \cup\left(\left\{c_{k} \mid 1 \leq k \leq\right.\right.$ $\left.j-1\} \backslash\left\{c_{i}\right\}\right) \cup\left[e+1, e+s n_{i}\right] \cup\left\{c_{i}+e s+\frac{s}{2}\left(n_{i} s+1\right)\right\}$ so that $\chi_{l a}\left(G\left(V_{i}, s\right)\right) \leq s n_{i}+t-r+j-1$. If $j \leq i \leq r$, then the induced vertex color set is $\left\{c_{k} \mid r+1 \leq k \leq t\right\} \cup\left\{c_{k} \mid 1 \leq k \leq j-1\right\} \cup\left[e+1, e+s n_{i}\right] \cup\left\{c_{i}+e s+\frac{s}{2}\left(n_{i} s+1\right)\right\}$ so that $\chi_{l a}\left(G\left(V_{i}, s\right)\right) \leq s n_{i}+t-r+j$.
Note that for $1 \leq i \leq j-1$, if $V_{i}$ has a pendant vertex, then $G\left(V_{i}, s\right)$ has $s n_{i}+t-r+b-1$ pendant vertices, otherwise $G\left(V_{i}, s\right)$ has $s n_{i}+t-r+b$ pendant vertices. For $j \leq i \leq t, G\left(V_{i}, s\right)$ also has $s n_{i}+t-r+b$ pendant vertices. Combining with Theorem 1.2, we have the conclusion. Moreover, if $c_{j-1}=e$ and $b=j-1$, only case (a) exists for $1 \leq i \leq j-1$ so that $\chi_{l a}\left(G\left(V_{i}, s\right)\right)=s n_{i}+t-r+j-1$, and $\chi_{l a}\left(G\left(V_{i}, s\right)\right)=s n_{i}+t-r+j$ for $j \leq i \leq r$.

In particular, if $c_{r-1} \leq e<c_{r}$, we know the condition $e+s n_{r} \geq c_{r-1}$ always hold and can be omitted.

## Example 2.1.

(1) In [5, Theorem 5], the authors proved that every $G=W_{4 k}, k \geq 1$ with $e=8 k$ edges admits a local antimagic labeling with $\chi_{l a}\left(W_{4 k}\right)=3$ such that for $k \geq 2$, $e<c_{1}=9 k+2<c_{2}=11 k+1<c_{3}=$ $2 k(12 k+1)$, while $W_{4}$ has $c_{1}=11, c_{2}=15, c_{3}=20$. Moreover, $n_{1}=n_{2}=2 k, n_{3}=1$. Thus, $r=t=3$. Suppose $k \geq 2$, we can add $s \geq 12 k-3$ (s even) pendant edges to each vertex in $V_{i}, i=1$ or 2 , and label them accordingly. We can also add $s \geq 3 k+1$ pendant edges to the vertex in $V_{3}$ and label them accordingly. By Theorem [2.1, we get $W_{4 k}\left(V_{i}, s\right)$ that has $\chi_{l a}=s n_{i}+1$ for the respective $s$ and $n_{i}$. We can also add edges to $W_{4}$ similarly.
(2) The right graph under Theorem 1.2, say $G$, has $e=7$ with $t=r=2 ; c_{1}=7, c_{2}=14$ and $n_{1}=4, n_{2}=2$. Thus, $\chi_{l a}\left(G\left(V_{1}, s\right)\right)=4 s+1$. In particular, since $c_{1}=e$ and $b=1$, we also can get $\chi_{l a}\left(G\left(V_{2}, s\right)\right)=2 s+2$.
(3) The left graph under Theorem 1.2, say $H$, has $e=5$ with $t=r=3 ; c_{1}=4<c_{2}=e<c_{3}$ and $b=2$. Thus, $\chi_{l a} H\left(V_{3}, s\right)=s+3$ for $s \geq 1$.

By a similar argument for Theorem 2.1, we can get the following theorem.
Theorem 2.2. Suppose $G \not \not K_{1, e}$ and $G\left(V_{i}, s\right)$ are as defined above with $r<t$ and $e+s \geq c_{r}$. Let $r+1 \leq i \leq t$.
(1) If $e<c_{1}$, then $\chi_{l a}\left(G\left(V_{i}, s\right)\right)=s+t-r$.
(2) If $c_{j-1} \leq e<c_{j}$ for $2 \leq j \leq r$, then $s+t-r+b \leq \chi_{l a}\left(G\left(V_{i}, s\right)\right) \leq s+t-r+j-1$. Moreover, if $b=j-1$, then $\chi_{l a}\left(G\left(V_{i}, s\right)\right)=s+t-r+j-1$.

## Example 2.2.

(1) It is easy to verify that the graph $G$ below has $\chi_{l a}(G)=9$ with $e=9<c_{1}=10, c_{2}=20, c_{3}=25$ and $r=3<t=9$. We may apply Theorem 2.2 (1) accordingly.

(2) We can add $k \geq 1$ pendant edges to the degree 4 vertex of the left graph under Theorem 1.2 and label the edges by 6 to $5+k$ bijectively to get a graph, say $G$, with $k+2$ pendant vertices. Clearly, $r=3<t=k+3$ with $c_{1}=4, c_{2}=5<e=k+5<c_{3}=(k+3)(k+8) / 2, c_{i}=i+2$ for $i=4, \ldots, k+2, j=3$ and $b=j-1$. By Theorem 2.2 (2), we know $\chi_{l a}\left(G\left(V_{i}, s\right)\right)=s+k+2$ for $s \geq(k+2)(k+7) / 2$.

Suppose $G$ is a graph containing $k \geq 1$ pendant vertices with $\chi_{l a}(G)=k+1$. Keeping the notation defined before Theorem [2.1, we have $t=k+1$. Then there is only one independent set, which is $V_{r}$, containing no pendant vertex. Clearly, $r \geq 1$. So we have $c_{1}<\cdots<c_{r-1} \leq e<c_{r}$ and $c_{r+1}<\cdots<c_{k+1} \leq e$ for $r \geq 2$, whereas for $r=1, G \cong K_{1, k}, k \geq 2$ with $c_{1}=k(k+1) / 2$ and $c_{i}=i-1$ for $2 \leq i \leq k+1$.

Corollary 2.3. Keep all notation defined before Theorem 2.1. Suppose $G$ has $k$ pendant vertices and $\chi_{l a}(G)=k+1$. Let

$$
e+s n_{i} \geq \begin{cases}c_{r} & \text { for } i \in[1, k+1] \backslash\{r\} \\ c_{r-1} & \text { for } i=r\end{cases}
$$

such that $s \geq 1$ if $n_{i}=1$, and $s \geq 2$ is even if $n_{i} \geq 2$, then $G\left(V_{r}, s\right)$ has sn $n_{r}+k-1$ pendant vertices with $\chi_{l a}\left(G\left(V_{r}, s\right)\right)=s n_{r}+k+1$, whereas $G\left(V_{i}, s\right)$ has $s n_{i}+k-1$ pendant vertices with $\chi_{l a}\left(G\left(V_{i}, s\right)\right)=s n_{i}+k$ when $i \in[1, k+1] \backslash\{r\}$.

Proof. Suppose $r=1$. Recall that $e=k$ and $c_{1}=k(k+1) / 2$. Since $G\left(V_{1}, s\right) \cong K_{1, k+s}$, we only consider $G\left(V_{i}, s\right), 2 \leq i \leq k+1$. By labeling the $s$ added edges of $G\left(V_{i}, s\right)$ by $k+1$ to $k+s$ bijectively, $c_{i}$ is now replaced by $i-1+k s+s(s+1) / 2>k+s \geq c_{1}>c_{k+1}>\cdots>c_{2}$. Thus, $G\left(V_{i}, s\right)$ now admits a local antimagic labeling with vertex color set $[1, k+s] \backslash\{i-1\} \cup\{i-1+k s+s(s+1) / 2\}$. Therefore, $\chi_{l a}\left(G\left(V_{i}, s\right)\right) \leq s+k$. Since $G\left(V_{i}, s\right)$ has $s+k-1$ pendant vertices, by Theorem 1.2 , the equality holds.
Consider $r \geq 2$. Suppose $i=r$, then $G\left(V_{r}, s\right)$ has $s n_{r}+k$ pendant vertices so that $\chi_{l a}\left(G\left(V_{r}, s\right)\right) \geq s n_{r}+k+1$. By a labeling $g_{i}$ as in the proof of Theorem 2.1, we know $g_{i}$ is a local antimagic labeling with induced vertex color set $\left\{c_{1}, c_{2}, \ldots, c_{r-1}, c_{r+1}, \ldots, c_{k+1}\right\} \cup\left[e+1, e+s n_{r}\right] \cup\left\{g_{r}^{+}(v) \mid v \in V_{r}\right\}$ of size $s n_{r}+k+1$. By Theorem 1.2. we have $\chi_{l a}\left(G\left(V_{r}, s\right)\right)=s n_{r}+k+1$.
Suppose $i \in[1, k+1] \backslash\{r\}$, then $G\left(V_{i}, s\right)$ has $s n_{i}+k-1$ pendant vertices so that $\chi_{l a}\left(G\left(V_{i}, s\right)\right) \geq s n_{i}+k$. By a labeling $g_{r}$ as in the proof of Theorem 2.1, we know $g_{r}$ is a local antimagic labeling with induced vertex color set $\left(\left\{c_{1}, c_{2}, \ldots, c_{k+1}\right\} \backslash\left\{c_{i}, c_{r}\right\}\right) \cup\left[e+1, e+s n_{i}\right] \cup\left\{g_{i}^{+}(v) \mid v \in V_{i}\right\}$ of size $s n_{r}+k$. By Theorem 1.2, we have $\chi_{l a}\left(G\left(V_{r}, s\right)\right)=s n_{r}+k$.

Example 2.3. Consider $W_{4}$ under Example 2.1. We have $W_{4}\left(V_{3}, 12\right)$ with $k=12$, $\chi_{l a}\left(W_{4}\left(V_{3}, 12\right)\right)=13$ and $c_{1}=11, c_{2}=15<e=20<c_{3}=194$. Moreover, $P_{n}, n \geq 3$ and $K_{1, k}$, is a tree with $k \geq 2$ pendant vertices and $\chi_{l a}=k+1$. We may apply Corollary 2.3 accordingly.

Thus, we get the following.
Theorem 2.4. For $k \geq 1$, there exist infinitely many graphs $G$ with $k \geq \chi(G)-1 \geq 1$ pendant vertices and $\chi_{l a}(G)=k+1$.

Let $G-e$ be the graph $G$ with an edge $e$ deleted. In [6, Lemmas 2.2-2.4], the authors obtained sufficient conditions for $\chi_{l a}(G)=\chi_{l a}(G-e)$. We note that these lemmas may be applied to $G\left(V_{i}, s\right)$ if all vertices in each $V_{j}, 1 \leq j \leq t$, are of same degree like $W_{4 k}\left(V_{i}, s\right)$ in Example 2.1.

## 3 Existing results and open problems

In [2], [5, Theorem 7 and Theoreom 9] and [7, Theorems 2.4-2.6, 2.9, 3.1, Lemma 2.10 and Section 3], the authors also determined the exact value of $\chi_{l a}(G)$ for many families of $G$ with pendant vertices. Particularly, they showed that there are infinitely many caterpillars of $k$-pendant vertices with $\chi_{l a}=k+1$ or $\chi_{l a} \geq k+2$. Note that [7, Theorem 2.6] corrected Theorem 2.2 in [8]. A lobster is a tree such that the removal of its pendant vertices resulted in a caterpillar. Note that the graph $S p\left(2^{[n]}\right)$ is also a lobster. We end this paper with the followings.

Conjecture 3.1. Every tree $T_{k}$, other than certain caterpillars, spiders and lobsters, with $k \geq 2$ pendant vertices has $\chi_{l a}\left(T_{k}\right)=k+1$.

Problem 3.1. Characterize all graphs $G$ with $k \geq \chi(G)-1 \geq 1$ pendant vertice(s) and $\chi_{l a}(G)=k+1$.
