Direct and inverse problems for a periodic problem with non-local potential

Abstract. Sum of a second derivative operator with periodic boundary conditions and an integral operator of rank one (non-local potential) is studied in this manuscript. Not only spectral analysis is conducted for this operator but the inverse problem is solved, viz., a method of the reconstruction of non-local potential by the spectral data is presented. Class of spectral data that give the solution to the inverse problem is described.

Key words: non-local potential, direct problem, inverse problem, periodic boundary problem.

Spectral analysis of the Sturm – Liouville operator on a finite interval is well-studied and has multiple applications [1] – [3]. Operators with non-local potential emerged for the first time in the study of behavior of particles on a crystalline surface [4]. Such operators are sums of a second derivative operator and an integral operator. In the case when the differential operator has simple spectrum, direct and inverse spectral problems are solved in the papers [5], [6].

This manuscript deals with the direct and inverse problems for the operator

$$(Ly)(x) = -y''(x) + \alpha \int_{0}^{\pi} y(t)v(t)dtv(x), \quad x \in (0,\pi),$$

where $\alpha \in \mathbb{R}$, $v \in L^2(0,\pi)$, with the domain $y \in W_2^2(0,\pi)$ and

$$y(0) = y(\pi), \quad y'(0) = y'(\pi).$$

Initial second derivative operator in $L^2(0,\pi)$ with the domain defined by these boundary conditions has discrete spectrum of multiplicity two. In the manuscript description of the spectrum of operator L is presented and it is shown that spectral multiplicity of the eigenvalues of operator L can be equal to 1, 2, 3. It is shown that the number α and the real function v(x) are unambiguously defined by the three spectra.

1 Characteristic function. Eigenfunctions

1.1. Let us denote by L_0 a self-adjoint non-negative operator in $L^2(0,\pi)$,

$$(L_0 y)(x) \stackrel{\text{def}}{=} -\frac{d^2}{dx^2} y(x), \tag{1.1}$$

domain of which is defined by the boundary conditions

$$\mathfrak{D}(L_0) = \left\{ y \in W_2^2(0, \pi) : y(0) = y(\pi), y'(0) = y'(\pi) \right\}. \tag{1.2}$$

Eigenfunctions of the operator L_0 satisfy the equation

$$-y''(\lambda, x) = zy(\lambda, x) \quad (z = \lambda^2),$$

general solution to which is given by

$$y(\lambda, x) = A\cos \lambda x + B\frac{\sin \lambda x}{\lambda}.$$

Boundary conditions for $y(\lambda, x)$ imply the system of equations

$$\begin{cases} A(\cos \lambda \pi - 1) + B \frac{\sin \lambda \pi}{\lambda} = 0; \\ -A\lambda \sin \lambda \pi + B(\cos \lambda \pi - 1) = 0, \end{cases}$$

for A and B, solutions to which are non-trivial only when its determinant $\Delta(0,\lambda)$ vanishes, $\Delta(0,\lambda) = 0$,

$$\Delta(0,\lambda) = (\cos \lambda \pi - 1)^2 + \sin^2 \lambda \pi = 2(1 - \cos \lambda \pi) = 0.$$

The function

$$\Delta(0,\lambda) \stackrel{\text{def}}{=} 2(1 - \cos \lambda \pi) = 2 - e^{i\lambda\pi} - e^{-i\lambda\pi}$$
(1.3)

is said to be the characteristic function of the operator L_0 (1.1), (1.2). It has the properties

$$\Delta(0, -\lambda) = \Delta(0, \lambda); \quad \Delta^*(\lambda) = \Delta(\lambda) \tag{1.4}$$

where

$$f^* \stackrel{\text{def}}{=} \overline{f(\bar{\lambda})}. \tag{1.5}$$

Zeroes $\lambda_k(0) = 2k \ (k \in \mathbb{Z}_+)$ of the function $\Delta(0, \lambda)$ have the algebraic multiplicity $2 \ (\Delta(0, \lambda_k(0)) = \Delta'(0, \lambda_k(0)) = 0)$ and define spectrum of the operator L_0 ,

$$\sigma(L_0) = \left\{ z_k(0) = \lambda_k^2(0) = 4k^2 : k \in \mathbb{Z}_+ \right\}. \tag{1.6}$$

To the eigenvalue $z_0(0) = 0$ (k = 0) there corresponds the one-dimensional eigenspace, it is defined by the normalized eigenfunction $u(0, x) = \frac{1}{\sqrt{\pi}}$. To the eigenvalue $z_k(0) = 4k^2$ (to the root $\lambda_k(0) = 2k$, $k \in \mathbb{N}$) there corresponds the two-dimensional eigenspace

$$G_k = \operatorname{span}\left\{\sqrt{\frac{2}{\pi}}\cos 2kx, \sqrt{\frac{2}{\pi}}\sin 2kx\right\}. \tag{1.7}$$

Thus all the eigenvalues $z_k(0)$ $(k \in \mathbb{N})$ have spectral multiplicity 2, except for the number $z_0(0)$ which has spectral multiplicity 1. The totality

$$\frac{1}{\sqrt{\pi}}, \quad \left\{ \sqrt{\frac{2}{\pi}} \cos 2kx, \sqrt{\frac{2}{\pi}} \sin 2kx \right\}_{k \in \mathbb{N}}$$
 (1.8)

is an orthonormal basis in $L^2(0,\pi)$.

1.2. Consider the self-adjoint operator

$$L = L(\alpha, v) \stackrel{\text{def}}{=} L_0 + \alpha \langle \cdot, v \rangle v \tag{1.9}$$

which is a one-dimensional perturbation of the operator L_0 (1.1), (1.2) where $\alpha \in \mathbb{R}$ and $v \in L^2(0,\pi)$. Domains of the operator L and L_0 coincide, $\mathfrak{D}(L) = \mathfrak{D}(L_0)$ (1.2).

Remark 1 On account of renormalization, we assume that either $\alpha = \pm 1$ $(v \to \sqrt{|\alpha|}v)$ or ||v|| = 1 $(\alpha \to \alpha ||v||^2)$.

Solving the equation

$$-y''(x) - \lambda^2 y(x) = f(x)$$
 (1.10)

by the method of variation of arbitrary constants, we obtain that the function

$$y(\lambda, x) = a(\lambda) \left\{ \frac{\sin \lambda x}{\lambda} + \frac{\sin \lambda (\pi - x)}{\lambda} \right\} - \frac{2}{\Delta(0, \lambda)} \left\{ \int_{0}^{x} \frac{\sin \lambda (x - t)}{\lambda} f(t) dt + \frac{\sin \lambda (\pi - x)}{\lambda} \int_{0}^{x} \cos \lambda t f(t) dt + \cos \lambda x \int_{x}^{\pi} \frac{\sin \lambda (\pi - t)}{\lambda} f(t) dt \right\}.$$

$$(1.11)$$

is the solution to equation (1.10) and satisfies the first boundary condition $y(\lambda, 0) = y(\lambda, \pi)$. Hence it follows that the eigenfunction $u(\lambda, x)$ of the operator L (1.9),

$$-u''(\lambda, x) + \alpha \langle u, v \rangle v(x) = \lambda^2 u(\lambda, x),$$

is the solution to the integral equation

$$u(\lambda, x) = a(\lambda) \left\{ \frac{\sin \lambda x}{\lambda} + \frac{\sin \lambda (\pi - x)}{\lambda} \right\} + \frac{2b(\lambda)}{\Delta(0, \lambda)} \left\{ \int_{0}^{x} \frac{\sin \lambda (x - t)}{\lambda} v(t) dt + \frac{\sin \lambda (\pi - x)}{\lambda} \int_{0}^{x} \cos \lambda t v(t) dt + \cos \lambda x \int_{x}^{\pi} \frac{\sin \lambda (\pi - t)}{\lambda} v(t) dt \right\}$$

$$(1.12)$$

and satisfies the boundary condition $u(\lambda, 0) = u(\lambda, \pi)$ where $b(\lambda) = \alpha \langle u, v \rangle$. Scalarly multiplying equality (1.12) by $\alpha v(x)$, we obtain

$$\alpha a(\lambda)W(\lambda) + \frac{2b(\lambda)}{\Delta(0,\lambda)} \left\{ \alpha F(\lambda) + \alpha F^*(\lambda) + \alpha G(\lambda) - \frac{\Delta(0,\lambda)}{2} \right\} = 0 \quad (1.13)$$

where

$$W(\lambda) = \int_{0}^{\pi} \frac{\sin \lambda x}{\lambda} \bar{v}(x) dx + \int_{0}^{\pi} \frac{\sin \lambda (\pi - x)}{\lambda} \bar{v}(x) dx;$$

$$F(\lambda) = \int_{0}^{\pi} \frac{\sin \lambda (\pi - x)}{\lambda} \int_{0}^{x} \cos \lambda t v(t) dt \bar{v}(x) dx; \qquad (1.14)$$

$$G(x) = \int_{0}^{\pi} \int_{0}^{x} \frac{\sin \lambda (x - t)}{\lambda} v(t) dt \bar{v}(x) dx.$$

Formula (1.12) yields

$$u'(\lambda, x) = a(\lambda) \{\cos \lambda x - \cos \lambda (\pi - x)\} + \frac{2b(\lambda)}{\Delta(0, \lambda)} \left\{ \int_{0}^{x} \cos \lambda (x - t) v(t) dt - \cos \lambda (\pi - x) \int_{0}^{x} \cos \lambda t v(t) dt - \sin \lambda x \int_{x}^{\pi} \sin \lambda (\pi - t) v(t) dt \right\}$$

and according to the second boundary condition, $u'(\lambda, 0) = u'(\lambda, \pi)$,

$$a(\lambda)\Delta(0,\lambda) + \frac{2b(\lambda)}{\Delta(0,\lambda)}N(\lambda) = 0$$
(1.15)

where

$$N(\lambda) = \int_{0}^{\pi} (\cos \lambda t - \cos \lambda (\pi - t)) v(t) dt.$$
 (1.16)

From the relations (1.13), (1.15) we obtain the system of linear equations relative to $a(\lambda)$, $b(\lambda)$

$$\begin{cases} \alpha a(\lambda)W(\lambda) + \frac{2b(\lambda)}{\Delta(0,\lambda)} \left\{ \alpha F(\lambda) + \alpha F^*(\lambda) + \alpha G(\lambda) - \frac{\Delta(0,\lambda)}{2} \right\} = 0; \\ a(\lambda)\Delta(0,\lambda) + \frac{2b(\lambda)}{\Delta(0,\lambda)} N(\lambda) = 0; \end{cases}$$

non-trivial solution to which exists if the determinant $\Delta(\alpha, \lambda)$ of this system vanishes, $\Delta(\alpha, \lambda) = 0$, where

$$\Delta(\alpha, \lambda) \stackrel{\text{def}}{=} \Delta(0, \lambda) + 2\alpha \left\{ \frac{W(\lambda)N(\lambda)}{\Delta(0, \lambda)} - F(\lambda) - F^*(\lambda) - G(\lambda) \right\}. \tag{1.17}$$

The function $\Delta(\alpha, \lambda)$ (1.17) is said to be the characteristic function of the operator L (1.9) which coincides with $\Delta(0, \lambda)$ (1.3) when $\alpha = 0$. Its zeroes $\lambda_k(\alpha)$ define the eigenvalues $z_k(\alpha) = \lambda_k^2(\alpha)$ of the operator L (1.9), i. e.,

$$\sigma(L) = \left\{ z_k(\alpha) = \lambda_k^2(\alpha); \Delta\left(\alpha, \lambda_k(\alpha)\right) = 0 \right\}. \tag{1.18}$$

1.3. Let us simplify the formula for the character function $\Delta(\alpha, \lambda)$ (1.17). Let

$$\widetilde{v}(\lambda) = \int_{0}^{\pi} e^{-i\lambda x} v(x) dx \tag{1.19}$$

be the Fourier transform of the function v(x). Then the function $W(\lambda)$ (1.14) equals

$$W(\lambda) = \frac{1}{2i\lambda} \left\{ \int_{0}^{\pi} e^{i\lambda x} \overline{v(x)} dx - \int_{0}^{\pi} e^{-i\lambda x} \overline{v(x)} dx + e^{i\lambda \pi} \int_{0}^{\pi} e^{-i\lambda x} \overline{v}(x) dx - e^{-i\lambda \pi} \int_{0}^{\pi} e^{i\lambda x} \overline{v}(x) dx \right\}$$

or, in terms of $\widetilde{v}(\lambda)$ (1.19),

$$W(\lambda) = \frac{1}{2i\lambda} \left\{ \widetilde{v}^*(\lambda) \left(1 - e^{-i\lambda\pi} \right) - \widetilde{v}^*(-\lambda) \left(1 - e^{i\lambda\pi} \right) \right\}.$$

Similarly, $N(\lambda)$ (1.16) equals

$$N(\lambda) = \frac{1}{2} \left\{ \widetilde{v}(\lambda) \left(1 - e^{i\lambda \pi} \right) + \widetilde{v}(-\lambda) \left(1 - e^{-i\lambda \pi} \right) \right\}.$$

Using these expressions for $W(\lambda)$ and $N(\lambda)$, we obtain

$$\frac{W(\lambda)N(\lambda)}{\Delta(0,\lambda)} = \frac{1}{4i\lambda\Delta(0,\lambda)} \left\{ \widetilde{v}(\lambda)\widetilde{v}^*(\lambda) \left(1 - e^{i\lambda\pi} \right) \left(1 - e^{-i\lambda\pi} \right) + \widetilde{v}(\lambda)\widetilde{v}^*(-\lambda) \left(1 - e^{i\lambda\pi} \right) \left(1 - e^{-i\lambda\pi} \right) e^{i\lambda\pi} - \widetilde{v}(-\lambda)\widetilde{v}^*(\lambda) \left(1 - e^{i\lambda\pi} \right) \left(1 - e^{-i\lambda\pi} \right) \right) \\
\times e^{-i\lambda\pi} - \widetilde{v}(-\lambda)\widetilde{v}^*(-\lambda) \left(1 - e^{i\lambda\pi} \right) \left(1 - e^{-i\lambda\pi} \right) \right\} = \frac{1}{4i\lambda} \left\{ \widetilde{v}(\lambda)\widetilde{v}^*(\lambda) \right\} \tag{1.20}$$

$$-\widetilde{v}(-\lambda)\widetilde{v}^*(-\lambda) + \widetilde{v}(\lambda)\widetilde{v}^*(-\lambda)e^{i\lambda\pi} - \widetilde{v}(-\lambda)\widetilde{v}^*(\lambda)e^{-i\lambda\pi} \Big\} .$$

The function $G(\lambda)$ (1.14) equals

$$G(\lambda = \frac{1}{2i\lambda} \left(\Phi^*(\lambda) - \Phi(-\lambda) \right) \tag{1.21}$$

where

$$\Phi(\lambda) \stackrel{\text{def}}{=} \int_{0}^{\pi} \int_{0}^{x} e^{-i\lambda(x-t)} \overline{v}(t) dt v(x) dx = \int_{0}^{\pi} \int_{0}^{x} e^{-i\lambda\xi} \overline{v(x-\xi)} d\xi v(x) dx$$

$$= \int_{0}^{\pi} e^{-i\lambda\xi} \int_{\xi}^{\pi} \overline{v(x-\xi)} v(x) dx.$$
(1.22)

Consequently, $\Phi(\lambda)$ is the Fourier transform,

$$\Phi(\lambda) = \int_{0}^{\pi} e^{-i\lambda x} g(x) dx, \qquad (1.23)$$

of the convolution

$$g(x) \stackrel{\text{def}}{=} \int_{x}^{\pi} \overline{v(t-x)} v(t) dt.$$
 (1.24)

Lemma 1 The entire function $\Phi(\lambda)$ (1.22) of exponential type ($\leq \pi$) satisfies the relation

$$\Phi(\lambda) + \Phi^*(\lambda) = \widetilde{v}(\lambda)\widetilde{v}^*(\lambda) \tag{1.25}$$

where $\widetilde{v}(\lambda)$ is given by (1.19). Any entire function with indicator diagram $[0, i\pi]$ that satisfies equality (1.25) coincides with $\Phi(\lambda)$ where g(x) is given by (1.24).

Proof. Equality (1.25) follows from the formula for integration by parts,

$$\Phi(\lambda) = \int_{0}^{\pi} \int_{0}^{x} e^{i\lambda t} \overline{v(t)} dt dx \int_{0}^{x} e^{-i\lambda s} v(s) ds = \widetilde{v}(\lambda) \widetilde{v}^{*}(\lambda) -$$

$$-\int_{0}^{\pi}\int_{0}^{x}e^{-i\lambda s}v(s)ds\cdot e^{i\lambda x}\overline{v(x)}dx=\widetilde{v}(\lambda)\widetilde{v}^{*}(\lambda)-\Phi^{*}(\lambda).$$

Let $F(\lambda)$ be an entire function of exponential type with indicator diagram $[0, 2\pi]$, then the Paley – Wiener theorem implies that

$$F(\lambda) = \int_{0}^{\pi} e^{-i\lambda t} f(t)dt \quad (f \in L^{2}(0, \pi)).$$

If $F(\lambda)$ satisfies relation (1.25), then the difference $G(\lambda) = F(\lambda) - \Phi(\lambda)$ ($\Phi(\lambda)$ is given by (1.23)) has the property $G(\lambda) = G^*(\lambda)$ which implies

$$0 = \int_{0}^{\pi} e^{-i\lambda t} (f(t) - g(t)) dt - \int_{0}^{\pi} e^{i\lambda t} \left(\overline{f(t)} - \overline{g(t)} \right) dt$$
$$= \int_{-\pi}^{\pi} e^{-i\lambda t} \left\{ (f(t) - g(t)) \chi_{+}(t) - \left(\overline{f(-t)} - \overline{g(-t)} \right) \chi_{-}(t) \right\} dt$$

 $(\chi_{\pm}(t))$ are characteristic functions of the sets \mathbb{R}_{\pm}). This and Parseval's identity yield that f(t) = g(t).

Lemma 2 The identity

$$F(\lambda) + F^*(\lambda) = \frac{1}{4i\lambda} \left\{ (\Phi(\lambda) - \Phi(-\lambda)) \left(e^{i\lambda\pi} + e^{-i\lambda\pi} \right) + (\widetilde{v}(\lambda) + \widetilde{v}(-\lambda)) \left(e^{i\lambda\pi} \widetilde{v}^*(-\lambda) - e^{-i\lambda\pi} \widetilde{v}^*(\lambda) \right) \right\}$$

$$(1.26)$$

is true for $F(\lambda)$ (1.14) where $\widetilde{v}(\lambda)$ and $\Phi(\lambda)$ are given by (1.19) and (1.22).

Proof. Formula (1.14) implies

$$F(\lambda) = \frac{1}{4i\lambda} \int_{0}^{\pi} \left(e^{i\lambda(\pi - x)} - e^{-i\lambda(\pi - x)} \right) \int_{0}^{x} \left(e^{i\lambda t} + e^{-i\lambda t} \right) v(t) dt \overline{v}(x) dx$$

$$= \frac{1}{4i\lambda} \left\{ e^{i\lambda\pi} \int_{0}^{\pi} \int_{0}^{x} e^{i\lambda t} v(t) dt e^{-i\lambda x} \overline{v(x)} dx + e^{i\lambda\pi} \int_{0}^{\pi} \int_{0}^{x} e^{-i\lambda t} v(t) dt e^{-i\lambda x} \overline{v(x)} dx - e^{-i\lambda\pi} \int_{0}^{\pi} \int_{0}^{x} e^{-i\lambda t} v(t) dt e^{i\lambda x} \overline{v(x)} dx \right\}$$

$$= \frac{1}{4i\lambda} \left\{ e^{i\lambda\pi} \Phi^*(-\lambda) - e^{-i\lambda\pi} \Phi^*(\lambda) + e^{i\lambda\pi} \psi(\lambda) - e^{-i\lambda\pi} \psi(-\lambda) \right\}$$

where

$$\psi(\lambda) = \int_{0}^{\pi} \int_{0}^{x} e^{-i\lambda t} v(t) dt e^{-i\lambda x} \overline{v(x)} dx.$$

Similarly to (1.25), the identity

$$\psi(\lambda) + \psi^*(\lambda) = \widetilde{v}(\lambda)\widetilde{v}^*(-\lambda)$$

is true for $\psi(\lambda)$. This identity and (1.25) implies

$$\begin{split} F(\lambda) + F^*(\lambda) &= \frac{1}{4i\lambda} \left\{ e^{i\lambda\pi} \Phi^*(-\lambda) - e^{-i\lambda\pi} \Phi^*(\lambda) + e^{i\lambda\pi} \psi(\lambda) - e^{-i\lambda\pi} \psi(-\lambda) \right. \\ &- e^{-i\lambda\pi} \Phi(-\lambda) + e^{i\lambda\pi} \Phi(\lambda) - e^{-i\lambda\pi} \psi^*(\lambda) + e^{i\lambda\pi} \psi^*(-\lambda) \right\} \\ &= \frac{1}{4i\lambda} \left\{ e^{i\lambda\pi} \Phi(\lambda) - e^{-i\lambda\pi} \Phi(-\lambda) + e^{i\lambda\pi} \left(\widetilde{v}(-\lambda) \widetilde{v}^*(-\lambda) - \Phi(-\lambda) \right) \right. \\ &- e^{-i\lambda\pi} \left(\widetilde{v}(\lambda) \widetilde{v}^*(\lambda) - \Phi(\lambda) \right) + e^{i\lambda\pi} \widetilde{v}(\lambda) \widetilde{v}^*(-\lambda) - e^{-i\lambda\pi} \widetilde{v}(-\lambda) \widetilde{v}^*(\lambda) \right\} \\ &= \frac{1}{4i\lambda} \left\{ \Phi(\lambda) \left(e^{i\lambda\pi} + e^{-i\lambda\pi} \right) - \Phi(-\lambda) \left(e^{i\lambda\pi} + e^{-i\lambda\pi} \right) + \widetilde{v}(\lambda) \left(e^{i\lambda\pi} \widetilde{v}^*(-\lambda) - e^{-i\lambda\pi} \widetilde{v}^*(\lambda) \right) \right\} \end{split}$$

which proves (1.26).

As a result, we arrive at the following statement.

Theorem 1 The representation

$$\Delta(\alpha, \lambda) = \Delta(0, \lambda) + \frac{\alpha}{2i\lambda} (R(\lambda) - R(-\lambda))$$
 (1.27)

is true for the characteristic function (1.17), where $R(\lambda)$ is expressed via $\widetilde{v}(\lambda)$ (1.19) and $\Phi(\lambda)$ (1.22) by the formula

$$R(\lambda) \stackrel{\text{def}}{=} \left(1 - e^{-i\lambda\pi}\right) \left\{\Phi(\lambda) \left(1 - e^{i\lambda\pi}\right) - \widetilde{v}(\lambda)\widetilde{v}^*(\lambda)\right\}. \tag{1.28}$$

Proof. The relations (1.17), (1.20), (1.21), (1.26) imply

$$\Delta(\alpha,\lambda) = \Delta(0,\lambda) + \frac{\alpha}{2i\lambda} \left\{ \widetilde{v}(\lambda)\widetilde{v}^*(\lambda) - \widetilde{v}(-\lambda)\widetilde{v}^*(-\lambda) + e^{i\lambda\pi}\widetilde{v}(\lambda)\widetilde{v}^*(-\lambda) - e^{-i\lambda\pi}\widetilde{v}(-\lambda)\widetilde{v}^*(\lambda) - (\Phi(\lambda) - \Phi(-\lambda)) \left(e^{i\lambda\pi} + e^{-i\lambda\pi} \right) - \widetilde{v}(\lambda)e^{i\lambda\pi}\widetilde{v}^*(-\lambda) + \widetilde{v}(\lambda)e^{-i\lambda\pi}\widetilde{v}^*(\lambda) - \widetilde{v}(-\lambda)e^{i\lambda\pi}\widetilde{v}^*(-\lambda) + \widetilde{v}(-\lambda)e^{-i\lambda\pi}\widetilde{v}^*(\lambda) - 2\left[\widetilde{v}(\lambda)\widetilde{v}^*(\lambda) - \Phi(\lambda) - \widetilde{v}(-\lambda)\widetilde{v}^*(-\lambda) + \Phi(-\lambda)\right] \right\} = \Delta(0,\lambda) + \frac{\alpha}{2i\lambda} \left\{ \widetilde{v}(\lambda)\widetilde{v}^*(\lambda) \left(-1 + e^{-i\lambda\pi} \right) - \widetilde{v}(-\lambda)\widetilde{v}^*(-\lambda) \left(-1 + e^{i\lambda\pi} \right) + (\Phi(\lambda) - \Phi(-\lambda)) \left(1 - e^{i\lambda\pi} \right) \left(1 - e^{-i\lambda\pi} \right) \right\}. \Box$$

Similarly to (1.4), the function $\Delta(\alpha, \lambda)$ satisfies the relations

$$\Delta(\alpha, \lambda) = \Delta(\alpha, -\lambda); \quad \Delta^*(\alpha, \lambda) = \Delta(\alpha, \lambda).$$
 (1.29)

The first equality is a corollary of formula (1.27). To prove the second equality, we calculate

$$R^*(\lambda) = (1 - e^{i\lambda\pi}) \left(1 - e^{-i\lambda\pi}\right) \Phi^*(\lambda) - \left(1 - e^{i\lambda\pi}\right) v^*(\lambda) v(\lambda)$$

$$= (1 - e^{i\lambda\pi}) (1 - e^{-i\lambda\pi}) (v^*(\lambda)v(\lambda) - \Phi(\lambda)) - (1 - e^{i\lambda\pi}) v^*(\lambda)v(\lambda)$$

$$= - (1 - e^{i\lambda\pi}) (1 - e^{-i\lambda\pi}) \Phi(\lambda) + (1 - e^{-i\lambda\pi}) v^*(\lambda)v(\lambda)$$

$$= - (1 - e^{-i\lambda\pi}) \{ (1 - e^{i\lambda\pi}) \Phi(\lambda) - v^*(\lambda)v(\lambda) \} = -R(\lambda),$$

hence it follows that $\Delta^*(\alpha, \lambda) = \Delta(\alpha, \lambda)$.

1.4. Let us find the eigenfunctions of the operator L (1.9). We find $a(\lambda)$ from formula (1.15),

$$a(\lambda) = -\frac{2b(\lambda)}{\Delta(0,\lambda)} \frac{N(\lambda)}{\Delta(0,\lambda)},$$

then from (1.12) we obtain

$$u(\lambda, x) = \frac{2b(\lambda)}{\Delta(0, \lambda)} \left\{ -\frac{N(\lambda)}{\lambda \cdot \Delta(0, \lambda)} 2 \sin \frac{\lambda \pi}{2} \cos \lambda \left(\frac{\pi}{2} - x \right) + \int_{0}^{x} \frac{\sin \lambda (x - t)}{\lambda} v(t) dt + \frac{\sin \lambda (\pi - x)}{\lambda} \int_{0}^{x} \cos \lambda t v(t) dt + \cos \lambda x \int_{x}^{\pi} \frac{\sin \lambda (\pi - t)}{\lambda} v(t) dt \right\}.$$
(1.30)

Since

$$N(\lambda) = \frac{1}{i} \sin \frac{\lambda \pi}{2} \left[\widetilde{v}(\lambda) e^{\frac{i\lambda \pi}{2}} - v(-\lambda) e^{-\frac{i\lambda \pi}{2}} \right] = 2 \sin \frac{\lambda \pi}{2} \int_{0}^{\pi} \sin \lambda \left(\frac{\pi}{2} - t \right) v(t) dt,$$

then

$$-\frac{N(\lambda)}{\lambda \cdot \Delta(0,\lambda)} 2\sin\frac{\lambda\pi}{2}\cos\lambda\left(\frac{\pi}{2} - x\right) = -\cos\lambda\left(\frac{\pi}{2} - x\right) \int_{0}^{\pi} \frac{\sin\lambda\left(\frac{\pi}{2} - t\right)}{\lambda} v(t)dt,$$

and after elementary transformations from (1.30) we find the form of eigenfunctions of the operator L (1.9).

Theorem 2 To each zero $\lambda = \lambda_k(\alpha) \notin \sigma(L_0)$ (1.6) of the characteristic function $\Delta(\alpha, \lambda)$ (1.27) there corresponds an eigenfunction of the operator L (1.9),

$$u(\lambda, x) = \int_{0}^{x} \cos \lambda \left(\frac{\pi}{2} - x + t\right) v(t) dt + \int_{x}^{\pi} \cos \lambda \left(\frac{\pi}{2} - t + x\right) v(t) dt. \quad (1.31)$$

2 Abstract formulation of the problem. Spectrum of the operator L

2.1. Consider in a Hilbert space H a self-adjoint operator L_0 with dense domain $\mathfrak{D}(L_0)$, spectrum of which consists of the eigenvalues z_k of spectral multiplicity

$$\sigma(L_0) = \{ z_k \in \mathbb{R}; k \in \mathbb{Z}_+ \}$$
 (2.1)

assuming that numbers z_k are numbered in increasing order and do not have finite limit points, i. e., $z_k \to \infty$ $(k \to \infty)$. To an eigenvalue z_k there corresponds an eigenspace G_k of finite dimension, dim $G_k = m_k < \infty$. Further, we assume that $m_k \le m < \infty$ $(\forall k)$. Spectral decomposition of the operator L_0 is

$$L_0 = \sum_{k=0}^{\infty} z_k E_k, \tag{2.2}$$

where E_k are the orthoprojectors onto G_k and $E_k E_s = \delta_{k,s} E_k$. Resolvent $R_{L_0}(z) = (L_0 - zI)^{-1}$ of the operator L_0 (2.2) equals

$$R_{L_0}(z) = \sum_{k} \frac{E_k}{z_k - z}.$$
 (2.3)

Similarly to (1.9), we define the self-adjoint operator

$$L = L_{\alpha} \stackrel{\text{def}}{=} L_0 + \alpha \langle \cdot, v \rangle v, \tag{2.4}$$

where $\alpha \in \mathbb{R}$, $v \in H$, and domains of the operators L and L_0 coincide. Resolvent $R_L(z) = (L - zI)^{-1}$ of the operator L is expressed via the resolvent $R_{L_0}(z)$ by the formula

$$R_L(z)f = R_{L_0}(z)f - \alpha \frac{\langle R_{L_0}(z)f, v \rangle}{1 + \alpha \langle R_{L_0}(z)v, v \rangle} \cdot R_{L_0}(z)f$$
 (2.5)

 $(f \in H)$, and taking (2.3) into account we obtain

$$R_L(z)f = \sum_k \frac{f_k}{z_k - z} - \frac{\alpha \sum_s \frac{\langle f_s, v_s \rangle}{z_s - z}}{1 + \alpha \sum_s \frac{\|v_s\|^2}{z_s - z}} \cdot \sum_k \frac{v_k}{z_k - z}, \tag{2.6}$$

where $f_k = E_k f$, $v_k = E_k v$ are projections of f and v onto the subspace G_k . Residue of the function $R_L(z)f$ in the point $z = z_p$ equals

$$\operatorname{res}_{z_p} R_L(z) = f_p - \langle f, v_p \rangle \frac{v_p}{\|v_p\|^2} \stackrel{\text{def}}{=} f_p^1.$$

Hence it follows: 1) if $v_p = 0$, then the totality $f_p^1 (= f_p)$ runs through all the subspace G_p , when $f \in H$, and consequently spectral multiplicity of z_p equals m_p ; 2) for $v_p \neq 0$, the vectors f_p^1 belong to G_p and are orthogonal to v_p , and thus the totality of f_p^1 forms the subspace G_p^1 in G_p of dimension $m_p - 1$. Therefore it is natural to distinguish two not-intersecting subsets in $\sigma(L_0)$ (2.1):

$$\sigma_0 \stackrel{\text{def}}{=} \{ z_k \in \sigma(L_0) : v_k = 0 \};$$

$$\sigma_1 \stackrel{\text{def}}{=} \{ z_k \in \sigma(L_0) : v_k \neq 0, m_k > 1 \}.$$
(2.7)

It is obvious that σ_0 and σ_1 belong to the spectrum of the operator L (2.4), σ_0 , $\sigma_1 \subset \sigma(L)$, besides, spectral multiplicities of the points $z_k \in \sigma_0$ do not change and equal m_k , and for $z_k \in \sigma_1$ spectral multiplicities decrease by 1 and equal $m_k - 1$. Formula (2.6) implies that zeroes of the function

$$Q(z) \stackrel{\text{def}}{=} 1 + \alpha \langle R_{L_0}(z)v, v \rangle = 1 + \alpha \sum_{k} \frac{\|v_k\|^2}{z_k - z}$$
 (2.8)

belong to the spectrum $\sigma(L)$ of the operator L, besides, summation in (2.8) is carried out by such k that $z_k \in (\sigma(L_0) \setminus \sigma_0)$. Function Q(z) has simple zeroes $\mu_k \in \mathbb{R}$ interchanging with points from the set $\sigma(L_0) \setminus \sigma_0$. This set of zeroes $\{\mu_k\}$ we denote by σ_2 ,

$$\sigma_2 \stackrel{\text{def}}{=} \{ \mu_k : Q(\mu_k) = 0 \}. \tag{2.9}$$

A number μ_k may coincide with some z_s from σ_0 , i. e., $\sigma_2 \cap \sigma_0 \neq \emptyset$, and in this case spectral multiplicity of z_s increases by 1 and equals $m_s + 1$.

Theorem 3 If spectrum $\sigma(L_0)$ (1.1) of a self-adjoint operator L_0 is discrete, besides, spectral multiplicities of the eigenvalues z_k equal $m_k < m < \infty$ ($\forall k$) and $\sigma(L_0)$ does not have finite limit points, then spectrum $\sigma(L)$ of the operator L (2.4) is the union of four non-intersecting sets,

$$\sigma(L) = \{ \sigma_0 \setminus (\sigma_0 \cap \sigma_2) \} \cup \{ \sigma_2 \setminus (\sigma_0 \cap \sigma_3) \} \cup \{ \sigma_0 \cap \sigma_2 \} \cup \sigma_1, \tag{2.10}$$

besides, (i) spectral multiplicity m_k of the points z_k from $\sigma_0 \setminus (\sigma_0 \cap \sigma_2)$ remains unchanged and σ_0 is given by (2.7);

- (ii) the points μ_k from $\sigma_2 \setminus (\sigma_0 \cap \sigma_2)$ have spectral multiplicity 1 and σ_2 is given by (2.9);
- (iii) the points z_k from $\sigma_0 \cap \sigma_2$, which coincide with zeroes μ_s of the function Q(z) (2.8), have spectral multiplicity $m_k + 1$;
 - (iv) the points $z_k \in \sigma_1$ have spectral multiplicity $m_k 1$;
 - (v) points of the sets σ_2 and $\sigma(L_0) \setminus \sigma_0$ alternate.

Remark 2 If points of the specrum $z_k \in \sigma(L_0)$ (2.1) of the operator L_0 satisfy the separability property

$$\inf_{k} (z_{k+1} - z_k) = d > 0, \tag{2.11}$$

then the set $\sigma_0 \cap \sigma_2$ is finite.

If the set $\sigma_0 \cap \sigma_2$ is infinite, then there exists the infinite sequence of roots μ_{k_p} of the function Q(z) $(Q(\mu_{k_p}) = 0)$ coinciding with z_p from σ_0 . Formula (2.8) implies

$$1 + \alpha \sum_{k} \frac{\|v_k\|^2}{z_k - z_p} = 0 \quad (\forall z_p \in \sigma_0 \cap \sigma_2).$$

Series in this sum converges uniformly by p since $|z_k - z_p| > d$ and $\sum_k ||v_k||^2 < \infty$ ($v \in H$). Proceeding to the limit as $p \to \infty$ and considering that $z_p \to \infty$, we obtain 0 = 1, which is impossible.

Remark 3 Spectrum $\sigma(L_0)$ (1.6) of the operator L_0 (1.1), (1.2) has separability property (2.11) and every eigenvalue $z_k(0)$ (1.6) has finite spectral multiplicity $m_k = 2$ ($k \ge 1$), $m_0 = 1$. Therefore Theorem 3 is true for L (1.9). For the convenience sake, we formulate it separately.

Theorem 4 Spectrum $\sigma(L)$ of the operator L (1.9) is the union of four non-intersecting sets,

$$\sigma(L) = \{\sigma_0 \setminus (\sigma_0 \cap \sigma_2)\} \cup \{\sigma_2 \setminus (\sigma_0 \cap \sigma_2)\} \cup \{\sigma_0 \cap \sigma_2\} \cup \sigma_1. \tag{2.12}$$

Besides,

- (i) spectral multiplicity $(m_0 = 0, m_k = 2, k \ge 1)$ of the points $z_k(\alpha) = z_k(0)$ from $\sigma_0 \setminus (\sigma_0 \cap \sigma_2)$ remains unchanged;
 - (ii) the points $z_k(\alpha) = \mu_k \in \sigma_2 \setminus (\sigma_0 \cap \sigma_2)$ have multiplicity 1;
- (iii) the set $\sigma_0 \cap \sigma_2$ is finite and its points $z_k(\alpha) = z_k(0) = \mu_p \in \sigma_0 \cap \sigma_2$ have multiplicity $m_k = 3$ $(k \ge 1)$ and $m_0 = 2$ (k = 0);
 - (iv) the points $z_k(\alpha) = z_k(0) \in \sigma_1$ (2.7) have multiplicity 1;
 - (v) the points μ_k from σ_2 (2.9) alternate with the points $z_k(0)$ from σ (L_0) \ σ_0 .

This theorem implies the description of eigenfunctions of the operator L (1.9).

Theorem 5 In accordance with decomposition (2.12) of the spectrum $\sigma(L)$, eigenfunctions of the operator L (1.9) are as follows:

- (i) to the points $z_k(\alpha) = z_k(0) \in \sigma_0 \setminus (\sigma_0 \cap \sigma_2)$ there correspond the twodimensional eigenspaces G_k (1.7), for $z_k(0) = 4k^2$ ($k \ge 1$), and the onedimensional eigenspace $\left\{\xi \frac{1}{\sqrt{\pi}}\right\}$, for $z_k(0) = 0$;
- (ii) to the eigenvalues $z_k(\alpha) = \mu_k \in \sigma_2 \setminus (\sigma_0 \cap \sigma_2)$ there correspond the eigenfunctions $u(\sqrt{\mu_k}, x)$ (1.31), where μ_k are zeroes (2.9) of the function Q(z) (2.8);
- (iii) to the points $z_k(\alpha) = z_k(0) = \mu_p \in \sigma_0 \cap \sigma_2$ there corresponds the eigenspace span $\{E_k + u(\sqrt{\mu_p}, x)\};$
- (iv) to the eigenvalues $z_k(0) \in \sigma_1$ there correspond the eigenfunctions $(c_k^2 + s_k^2)^{-1/2} \left(s_k \sqrt{\frac{2}{\pi}} \cos 2kx s_k \sqrt{\frac{2}{\pi}} \sin 2kx \right)$, where $s_k = \left\langle v, \sqrt{\frac{2}{\pi}} \sin 2kx \right\rangle$, $c_k = \left\langle v, \sqrt{\frac{2}{\pi}} \cos 2kx \right\rangle$.
- **2.2.** Let us study in detail the function Q(z) (2.8) characterizing change of the spectrum of the operator L_0 under the one-dimensional perturbation (2.4). We express the function $Q(\lambda^2)$ via the characteristic functions $\Delta(\alpha, \lambda)$ and $\Delta(0, \lambda)$.

If $R_{L_0}(\lambda^2) f = y$, then $L_0 y - \lambda^2 y = f$, this coincides with equation (1.10), the solution to which is given by (1.11). We find $a(\lambda)$ from the second boundary condition for $y(\lambda, x)$ and after some elementary transformations we obtain that

$$y(\lambda, x) = (R_{L_0}(\lambda^2) f)(x) = -\frac{1}{2\lambda \sin \frac{\pi \lambda}{2}} \left\{ \int_0^x \cos \lambda \left(\frac{\pi}{2} - x + t \right) f(t) dt + \int_x^\pi \cos \lambda \left(\frac{\pi}{2} - t + x \right) f(t) dt \right\}.$$

$$(2.13)$$

Hence

$$\langle R_{L_0}(\lambda^2) v, v \rangle = -\frac{1}{2\lambda \sin \frac{\pi \lambda}{2}} \left\{ \int_0^{\pi} \int_0^x \cos \lambda \left(\frac{\pi}{2} - x + t \right) v(t) dt \overline{v(x)} dx \right\}$$

$$+\int\limits_0^\pi\int\limits_x^\pi\cos\lambda\left(\frac{\pi}{2}-t+x\right)v(t)dt\overline{v(x)}dx\right\} = -\frac{1}{4\lambda\sin\frac{\pi\lambda}{2}}\left\{e^{i\lambda\frac{\pi}{2}}\int\limits_0^\pi\int\limits_0^x e^{i\lambda t}v(t)dt\right\}$$

$$\times e^{-i\lambda x} \overline{v(x)} dx + e^{-i\lambda \frac{\pi}{2}} \int_{0}^{\pi} \int_{0}^{x} e^{-i\lambda t} v(t) dt e^{i\lambda x} \overline{v(x)} dx + e^{i\lambda \frac{\pi}{2}} \int_{0}^{\pi} \int_{x}^{\pi} e^{-i\lambda t} v(t) dt$$

$$\times e^{i\lambda x} \overline{v(x)} dx + e^{-i\lambda \frac{\pi}{2}} \int_{0}^{\pi} \int_{x}^{\pi} e^{i\lambda t} v(t) dt e^{-i\lambda x} \overline{v(x)} dx$$

$$= -\frac{1}{4\lambda \sin \frac{\pi\lambda}{2}} \left\{ e^{i\lambda \frac{\pi}{2}} \Phi^*(-\lambda) + e^{-\frac{i\lambda \pi}{2}} \Phi^*(\lambda) + e^{i\lambda \frac{\pi}{2}} \Phi(\lambda) + e^{-\frac{i\lambda \pi}{2}} \Phi(-\lambda) \right\}$$

in view of definition (1.21) of the function $\Phi(\lambda)$. Relation (1.25) yields

$$\langle R_{L_0} \left(\lambda^2 \right) v, v \rangle = -\frac{1}{4\lambda \sin \frac{\lambda \pi}{2}} \left\{ e^{i\lambda \frac{\pi}{2}} \left(\widetilde{v}(-\lambda) \widetilde{v}^*(-\lambda) - \Phi(-\lambda) \right) + e^{-\frac{i\lambda \pi}{2}} \left(\widetilde{v}(\lambda) \widetilde{v}^*(\lambda) - \Phi(\lambda) \right) + e^{i\lambda \frac{\pi}{2}} \Phi(\lambda) + e^{-\frac{i\lambda \pi}{2}} \Phi(-\lambda) \right\}$$

$$= -\frac{1}{4\lambda \sin \frac{\lambda \pi}{2}} \left\{ e^{\frac{i\lambda \pi}{2}} \left[\widetilde{v}(-\lambda) \widetilde{v}^*(-\lambda) - \left(1 - e^{-i\lambda \pi} \right) \Phi(-\lambda) \right] + e^{-\frac{i\lambda \pi}{2}} \left[\widetilde{v}(\lambda) \widetilde{v}^*(\lambda) - \left(1 - e^{i\lambda \pi} \right) \Phi(\lambda) \right] \right\}.$$

Taking (1.28) into account, we obtain

$$1 + \alpha \left\langle R_{L_0} \left(\lambda^2 \right) v, v \right\rangle = 1 - \frac{\alpha}{4\lambda \sin \frac{\lambda \pi}{2}} \left\{ -\frac{e^{-\frac{i\lambda \pi}{2}}}{1 - e^{-i\lambda \pi}} R(\lambda) - \frac{e^{\frac{i\lambda \pi}{2}}}{1 - e^{i\lambda \pi}} R(-\lambda) \right\}$$
$$= 1 + \frac{\alpha}{4\lambda \sin \frac{\lambda \pi}{2}} \left\{ \frac{1}{2i \sin \frac{\lambda \pi}{2}} R(\lambda) - \frac{1}{2i \sin \frac{\lambda \pi}{2}} R(-\lambda) \right\}$$
$$= 1 + \frac{\alpha}{2i\lambda\Delta(0,\lambda)} \left\{ R(\lambda) - R(-\lambda) \right\} = \frac{\Delta(\alpha,\lambda)}{\Delta(0,\lambda)},$$

in view of (1.27).

Theorem 6 The function $Q(\lambda^2)$ (2.8) is expressed via the characteristic function $\Delta(\alpha, \lambda)$ (1.27) of the operator L (1.9) by the formula

$$Q(\lambda^2) = \frac{\Delta(\alpha, \lambda)}{\Delta(0, \lambda)}$$
 (2.14)

where $\Delta(0,\lambda)$ is the characteristic function (1.3) of the operator L_0 (1.1), (1.2).

3 Structure of the function Q(z)

- **3.1.** In order to obtain the multiplicative expansion of the characteristic function $\Delta(\alpha, \lambda)$ (1.27), we use the well-known statements. Let us recall [9] that a function $f(\lambda)$ is of class C (Cartwright) if
 - (a) $f(\lambda)$ is an entire function of exponential type;
 - (b) the integral

$$\int_{\mathbb{R}} \frac{\ln^+ |f(x)|}{1+x^2} dx < \infty \tag{3.1}$$

converges. The function $\Delta(\alpha, \lambda)$ (1.27) is of class C. So the Paley – Wiener theorem for $\widetilde{v}(\lambda)$ (1.19) and $\Phi(\lambda)$ (1.22) implies that $\Delta(\alpha, \lambda)$ satisfies condition (a). Convergence of integral (3.1) follows from analyticity and boundedness of the function $R(\lambda)$ (1.28).

Indicator diagram [9] of the function $\Delta(\alpha, \lambda)$ coincides with the segment of imaginary axis $\left[-ih_{\Delta}\left(-\frac{\pi}{2}\right), ih_{\Delta}\left(\frac{\pi}{2}\right)\right]$, besides, $h_{\Delta}\left(-\frac{\pi}{2}\right) = h_{\Delta}\left(\frac{\pi}{2}\right)$ in view of $|\Delta(\alpha, iy)| = |\Delta(\alpha, -iy)|$ (1.29). The next statement follows from the more general Cartwright – Levinson theorem [9].

Theorem 7 [9]. For any function $f(\lambda)$ of class C such that $f(0) \neq 0$ and $h_{\Delta}\left(-\frac{\pi}{2}\right) = h_{\Delta}\left(\frac{\pi}{2}\right)$,

$$f(\lambda) = f(0) \lim_{R \to \infty} \prod_{|a_k| < R} \left(1 - \frac{\lambda}{a_k} \right),$$

where $\{a_k\}_1^{\infty}$ are roots of the function $f(\lambda)$.

Relations (1.27), (1.28) imply that $\Delta(\alpha, 0) = -\alpha \pi |\widetilde{v}(0)|^2 \neq 0$. Applying Theorem 7 and taking (1.29) into account, we obtain

$$\Delta(\alpha, \lambda) = A \prod_{k} \left(1 - \frac{\lambda^2}{z_k(\alpha)} \right)$$
 (3.2)

where $z_k(\alpha) = \lambda_k^2(\alpha)$ and $\lambda_k(\alpha)$ are zeroes of $\Delta(\alpha, \lambda)$. Equalities (2.8), (2.14) yield

$$1 + \alpha \sum_{k} \frac{\|v_{k}\|^{2}}{z_{k}(0) - z} = \frac{A \prod_{k} \left(1 - \frac{z}{z_{k}(\alpha)}\right)}{4 \sin^{2} \sqrt{z} \frac{\pi}{2}},$$

and since [9]

$$\sin \xi = \xi \prod_{k} \left(1 - \frac{\xi^2}{\pi^2 k^2} \right); \quad 4 \sin^2 \sqrt{z} \frac{\pi}{2} = \pi^2 z \prod_{k} \left(1 - \frac{z}{z_k(0)} \right),$$

then

$$1 + \alpha \sum_{k} \frac{\|v_{k}\|^{2}}{z_{k}(0) - z} = \frac{A \prod_{k} \left(1 - \frac{z}{z_{k}(\alpha)}\right)}{\pi^{2} z \prod_{k} \left(1 - \frac{z}{z_{k}(0)}\right)^{2}}.$$

Using Theorem 4, we obtain

$$1 + \alpha \sum_{k} \frac{\|v_{k}\|^{2}}{z_{k}(0) - z} = \frac{A \prod_{k} \left(1 - \frac{z}{\mu_{k}}\right)}{\pi^{2} z \prod_{k} \left(1 - \frac{z}{z_{k}(0)}\right)}$$
(3.3)

where summation in the left-hand side of this equality and product in the denominator in the right-hand side is carried out only by $z_k(0)$ belonging to $\sigma(L_0) \setminus \sigma_0$. We obtain the number A from (3.3),

$$\frac{1}{A} = \lim_{y \to \infty} \frac{\prod_{k} \left(1 - \frac{iy}{\mu_k}\right)}{\pi^2 iy \prod_{k} \left(1 - \frac{iy}{z_k(0)}\right)}.$$
(3.4)

Calculating the residue at the point z_p in equality (3.3), we obtain

$$\alpha \|v_p\|^2 = A \frac{\mu_p - z_p(0)}{\pi^2 \mu_p} \prod_{k \neq p} \frac{z_k(0)}{\mu_k} \left(1 - \frac{z_k(0) - \mu_k}{z_k(0) - z_p(0)} \right) \quad (p \neq 0);$$

$$\alpha \|v_0\|^2 = -\frac{A}{\pi^2} \quad (p = 0).$$
(3.5)

Theorem 8 The numbers $\alpha \|v_p\|^2$ $(p \in \mathbb{Z}_+)$, where $v_p = E_p v$ is the projection of the function v onto the subspace G_p (1.7), are obtained unambiguously from the spectrum $\sigma(L)$ (2.12) of the operator L (1.9) using the formulas (3.5).

Remark 4 The number α is calculated from the equalities (3.5) unambiguously if we initially consider ||v|| = 1, i. e., $\sum ||v_p||^2 = 1$ (cf. Remark 1). Consequently, the numbers α and $||v_p||^2$ are defined from $\sigma(L)$ unambiguously.

In the abstract formulation of the problem, when L_0 is not necessarily defined by (1.1), to obtain α and $\|v_p\|^2$ we must know the two spectra $\sigma(L_0)$ and $\sigma(L)$.

3.2. Let us present another method of calculation of numbers $\alpha \|v_p\|^2$. To

do this, we write equality (2.14) as

$$1 + \alpha \sum_{k} \frac{\|v_k\|^2}{z_k(0) - z} = \frac{\Delta(\alpha, \lambda)}{\Delta(0, \lambda)} \quad (z = \lambda^2), \qquad (3.6)$$

where summation in (3.6) is carried out by those k for which $z_k(0) \in \sigma(L_0) \setminus \sigma_0$, then

$$\alpha \|v_p\|^2 = \lim_{\lambda \to \lambda_p(0)} \frac{\left(\lambda_p^2(0) - \lambda^2\right) \Delta(\alpha, \lambda)}{\Delta(0, \lambda)}.$$
 (3.7)

Since $\lambda_p(0) \neq 0$ is the second order zero of $\Delta(0, \lambda)$ and the first order zero of $\Delta(\alpha, \lambda)$, then taking into account that

$$\frac{\left(\lambda_p^2(0) - \lambda^2\right) \Delta(\alpha, \lambda)}{\Delta(0, \lambda)} = -\left(\lambda_p(0) + \lambda\right) \frac{\frac{\Delta(\alpha, \lambda) - \Delta(\alpha, \lambda_p(0))}{\lambda - \lambda_p(0)}}{\frac{\Delta(0, \lambda) - \Delta(\alpha, \lambda_p(0))}{\left(\lambda - \lambda_p(0)\right)^2}},$$

from (3.7) we obtain

$$\alpha \|v_p\|^2 = -4\lambda_p(0) \frac{\Delta'(0, \lambda_p(0))}{\Delta''(0, \lambda_p(0))}.$$

Hence from $\Delta''(0,\lambda) = 2\pi^2 \cos \lambda \pi$ we find

$$\alpha \|v_p\|^2 = -\frac{2}{\pi^2} \lambda_p(0) \frac{\Delta'(0, \lambda_p(0))}{\cos \lambda_p(0)\pi} \quad (\lambda_p = 0)$$

or

$$\alpha \|v_p\|^2 = -\frac{4p}{\pi^2} \Delta'(\alpha, 2p) \quad (p \neq 0).$$
 (3.8)

Similarly,

$$\alpha |v_0|^2 = -\frac{1}{\pi^2} \Delta(\alpha, 0) \quad (p = 0).$$
 (3.9)

Theorem 9 The numbers $\alpha \|v_p\|^2$ are calculated via the characteristic function $\Delta(\alpha, \lambda)$ (1.27) by the formulas (3.8), (3.9).

4 Inverse problem. Description of inverse problem data

4.1. Theorem 8 and Remark 4 imply that the number α and squares of the norms $||v_k||^2$ of the projections $v_k = E_k v$ of the function v onto the spaces G_k (1.7) are unambiguously found from the spectrum $\sigma(L)$ of the operator L (1.9). Due to arbitrariness of an orthonormal basis in G_k , this means that v(x) is recovered from $||v_k||^2$ with a large degree of uncertainty.

Since

$$v_k = c_k(v)\sqrt{\frac{2}{\pi}}\cos 2kx + s_k(v)\sqrt{\frac{2}{\pi}}\sin 2kx$$
 (4.1)

where

$$c_k(v) = \left\langle v(x), \sqrt{\frac{2}{\pi}} \cos 2kx \right\rangle, \quad s_k(v) = \left\langle v(x), \sqrt{2\pi} \sin 2kx \right\rangle$$
 (4.2)

are Fourier coefficients of the function v(x), then

$$||v_k||^2 = |c_k(v)|^2 + |s_k(v)|^2. (4.3)$$

We represent $L^2(0,\pi)$ as an orthogonal sum of subspaces,

$$L^2(0,\pi) = L_+ \oplus L_- \tag{4.4}$$

where

$$L_{\pm} = \left\{ f_{\pm}(x) = \frac{1}{2} (f(x) \pm f(\pi - x)) : f \in L^{2}(0, \pi) \right\}. \tag{4.5}$$

Orthogonality $L_{+} \perp L_{-}$ is a corollary of equalities

$$f_{+}(\pi - x) = f_{+}(x), \quad f_{-}(\pi - x) = -f_{-}(x).$$

Remark 5 Since $\cos 2kx \in L_+$ and $\sin 2kx \in L_-$, the Fourier coefficients (4.2) of the function f_{\pm} are

$$c_k(f_+) = c_k(f), \quad s_k(f_+) = 0;$$

 $c_k(f_-) = 0, \quad s_k(f_-) = s_k(f).$ (4.6)

Theorem 8 and Remark 5 implies the following statement.

Theorem 10 The numbers $\alpha c_k(v)|^2$ and $\alpha |s_k(v)|^2$ are unambiguously found from the two spectra $\sigma(L_{\pm})$ of operators $L_{\pm} = L(\alpha, v_{\pm})$ (1.9) where $v_{\pm} = P_{\pm}v$, P_{\pm} are the orthoprojectors onto the subspaces L_{\pm} (4.5).

Number α and coefficients $|c_k(v)|$ and $|s_k(v)|$ are calculated from $\alpha |c_k(v)|^2$ and $\alpha |s_k(v)|^2$ under the condition ||v|| = 1 (cf. Remark 4). This allows one to (ambiguously) recover v. Formula (4.3) implies that instead of spectra $\sigma(L_{\pm})$ we can take spectra $\sigma(L)$ and $\sigma(L_{+})$ (or $\sigma(L)$ and $\sigma(L_{-})$).

4.2. In the case of real v, one can unambiguously recover v(x). Formula (4.2) for a real function v implies

$$||v_k||^2 = c_k^2(v) + s_k^2(v). (4.7)$$

Consider the function

$$w(x) = v(x) + x - \frac{\pi}{2},\tag{4.8}$$

and since $x - \frac{\pi}{2} \in L_{-}$ (4.5), then

$$c_k\left(x - \frac{\pi}{2}\right) = 0, \quad s_k\left(x - \frac{\pi}{2}\right) = -\sqrt{\frac{\pi}{2}}\frac{1}{k},$$

therefore

$$c_k(w) = c_k(v), \quad s_k(w) = s_k(v) - \sqrt{\frac{\pi}{2}} \frac{1}{k},$$

and thus

$$||w_k||^2 = c_k^2(v) + s_k^2(v) - \frac{\sqrt{2\pi}}{k}s_k(v) + \frac{\pi}{2k^2}.$$

Hence from (4.7) we find

$$s_k(v) = \frac{k}{\sqrt{2\pi}} \left\{ \|v_k\|^2 - \|w_k\|^2 + \frac{\pi}{2k^2} \right\}. \tag{4.9}$$

Similarly, consider

$$\widehat{w}(x) = v(x) + \left(x - \frac{\pi}{2}\right)^2,\tag{4.10}$$

and taking $\left(x - \frac{\pi}{2}\right)^2 \in L_+$ (4.5) we obtain

$$s_k\left(\left(x - \frac{\pi}{2}\right)^2\right) = 0; \quad c_k\left(\left(x - \frac{\pi}{2}\right)^2\right) = \sqrt{\frac{\pi}{2}} \frac{1}{k^2} \quad (k \ge 1);$$

$$c_0\left(\left(x - \frac{\pi}{2}\right)^2\right) = \frac{\pi^{5/2}}{12},$$

and thus

$$s_k(\widehat{w}) = s_k(v);$$
 $c_k(\widehat{w}) = c_k(v) + \sqrt{\frac{\pi}{2}} \frac{1}{k^2}$ $(k \ge 1);$ $c_0(\widehat{w}) = c_0(v) + \frac{\pi^{5/2}}{12};$

therefore

$$\|\widehat{w}_k\|^2 = c_k^2(v) + \frac{\sqrt{2\pi}}{k^2}c_k(v) + \frac{\pi}{2k^4} + s_k^2(v) \quad (k \ge 1);$$
$$\|\widehat{w}_0\|^2 = c_0^2(v) + \frac{\pi^{5/2}}{6}c_0(v) + \frac{\pi^5}{144} \quad (k = 0),$$

and according to (4.7)

$$c_k(v) = \frac{k^2}{\sqrt{2\pi}} \left\{ \|\widehat{w}_k\|^2 - \|v_k\|^2 - \frac{\pi}{2k^4} \right\} \quad (k \ge 1);$$

$$c_0(v) = \frac{6}{\pi^{5/2}} \left\{ \|\widehat{w}_0\|^2 - \|v_0\|^2 - \frac{\pi^5}{144} \right\} \quad (k = 0).$$
(4.11)

Using Theorem 11, we arrive at the statement.

Theorem 11 If v(x) is real, then from the three spectra:

- (i) spectrum $\sigma(L)$ (2.12) of the operator $L = L(\alpha, v)$ (1.9);
- (ii) spectrum $\sigma(L_w)$ of the operator $L_w = L(\alpha, w)$ (1.9) where w is given by (4.8);
- (iii) spectrum $\sigma(L_{\widehat{w}})$ of the operator $L_{\widehat{w}} = L(\alpha, \widehat{w})$ (1.9) where \widehat{w} is given by (4.10);

the numbers $\alpha s_k(v)$ and $\alpha c_k(v)$ are unambiguously found via the formulas (3.5) and (4.9), (4.11).

Remark 6 Due to the normalization condition ||v|| = 1, α^2 is determined by the numbers $\alpha s_k(v)$, $\alpha c_k(v)$, and thus the number α is determined up to sign which is found from the pattern of intermittency of the numbers μ_k and $z_k(0) \in \sigma(L_0) \setminus \sigma_0$ (Theorem 4, (v)). Thus, the number α and the real function v(x) are unambiguously recovered from the three spectra $\sigma(L)$, $\sigma(L_w)$, $\sigma(L_{\widehat{w}})$.

Instead of the functions $\left(x - \frac{\pi}{2}\right) \in L_{-}$ and $\left(x - \frac{\pi}{2}\right)^{2} \in L_{+}$, one can take any other functions f and g from the subspaces L_{-} and L_{+} (4.5) with non-zero Fourier coefficients $s_{k}(f)$ and $c_{k}(g)$ correspondingly.

3.4. Let us proceed to the definition of spectral data of the operator L (1.9). First, we give the formal definition of the set $\sigma(L)$ (2.12).

Definition 1 Let $\sigma(L_0)$ be a countable set (1.6) with each point of multiplicity 2. We chose a discrete subset A from $\sigma(L_0)$ and no more then countable set of points B which intermit with the elements of $\sigma(L_0)\backslash A$. We match every such pair A, B with the countable set

$$\sigma(L_0, A, B) \stackrel{\text{def}}{=} \{A \setminus (A \cap B)\} \cup \{B \setminus (A \cap B)\} \cup \{A \cap B\} + \sigma_1 \tag{4.12}$$

where $\sigma_1 = \sigma(L_0) \setminus \{A \cup \{z(0)\}\}\$. Becides,

- (i) points $z_k(0) \in A \setminus \{A \cap B\}$ are of multiplicity 2;
- (ii) points $\mu_k \in B \setminus \{A \cap B\}$ are of multiplicity 1;
- (iii) the set $A \cap B$ is countable and its elements are of multiplicity 3;
- (iv) points $z_k(0) \in \sigma_1$ are of multiplicity 1.

It is more convenient to define the numerical sequences $z_k(\alpha)$ which make up the spectrum $\sigma(L)$ of the operator L (1.9) in terms of characteristic functions $\Delta(\alpha, \lambda)$ (1.26). Let us proceed to definition of the class of functions which are characteristic for the operators of the type L (1.9).

Definition 2 Function $\Delta(\lambda)$ is of class $JP\{z_k(0)\}$, where $z_k(0) = 4k^2$ $(k \in \mathbb{Z}_+)$ if

- (i) $\Delta(\lambda)$ is an entire function of exponential type σ ($\leq 2\pi$) such that $|\Delta(\lambda)| < \infty$ as $\lambda \in \mathbb{R}$ and $\Delta(-\lambda) = \Delta(\lambda)$, $\Delta^*(\lambda) = \Delta(\lambda)$;
- (ii) zeroes $\{\pm a_k\}$ of the function $\Delta(\lambda)$ $(a_k \neq 0 \ \forall k)$ have the property that $a_k^2 \in \sigma(L_0, A, B)$ (4.12) for some A and B;
 - (iii) the function

$$F(z) = \frac{\Delta(\lambda)}{\Delta(0,\lambda)} \quad (\lambda^2 = z) \tag{4.13}$$

 $(\Delta(0,\lambda) = 2(1-\cos\lambda\pi) \ (1.3))$ has the property

$$\lim_{y \to \infty} F(iy) = 1; \tag{4.14}$$

(iv) the limit

$$\lim_{y \to \infty} y|F(iy) - 1| < \infty \tag{4.15}$$

exists.

The function $\Delta(\alpha, \lambda)$ (1.26) is of class $JP\{z_k(0)\}$ due to (1.8) and Theorem 4. Condition (4.15) in view of (3.6) provides convergence of the series $\alpha \sum ||v_k||^2 < \infty$, i. e., the fact that v(x) belongs to the space $L^2(0, \pi)$.

Theorem 12 If $\Delta(\lambda) \in JP\{z_k(0)\}$, then there exists the operator L (1.9), characteristic function $\Delta(\alpha, \lambda)$ (1.26) of which coincides with $\Delta(\lambda)$.

Proof. Boundedness of $\Delta(\lambda)$ as $\lambda \in \mathbb{R}$ implies that the function $\Delta(\lambda)$ is of Cartwright class C. Using Theorem 7 and structure of the set $\sigma(L_0, A, B)$, we obtain that

$$F(z) = \frac{A\prod_{k} \left(1 - \frac{z}{\mu_k}\right)}{\pi^2 z \prod_{k} \left(1 - \frac{z}{z_k(0)}\right)},\tag{4.16}$$

where number A we find from condition (4.14), and μ_k and $z_k(0)$ alternate. We will use the theorem by M. G. Krein [9].

Theorem 13 (M. G. Krein) In order that a real meromorphic function f(z) map $\mathbb{C}_+ \to \mathbb{C}_-$, it is necessary and sufficient that it is given by

$$f(z) = c \frac{z - a_0}{z - b_0} \prod_{k \neq 0} \left(1 - \frac{z}{a_k} \right) \left(1 - \frac{z}{b_k} \right)^{-1}$$
 (4.17)

where $b_k < a_k < b_{k+1} \ (k \in \mathbb{Z}_+); \ a_{-1} < 0 < b_1; \ c > 0.$

Representation (4.17), with $a_k < b_k < a_{k+1}$ ($\forall k \in \mathbb{Z}$) and $b_{-1} < 0 < a_1$, is also true for a real meromorphic function f(z): $\mathbb{C}_+ \to \mathbb{C}_-$. Along with the multiplicative representation (4.17), there exists the additive decomposition [9] for this class of meromorphic functions.

Theorem 14 (N. G. Chebotarev) Any real meromorphic function $f(z): \mathbb{C}_+ \to \mathbb{C}_+$ has the decomposition

$$f(z) = az + b - \frac{A_0}{z} + \sum_{\omega_1}^{\omega_2} A_k \left(\frac{1}{b_k - z} - \frac{1}{b_k} \right)$$
 (4.18)

where $-\infty \leq \omega_1 \leq \omega_2 \leq \infty$; $A_k \geq 0 \ (\forall k \in \mathbb{Z})$; $a \geq 0$, $b \in \mathbb{R}$, $b_k < b_{k+1}$ $(b_k \neq 0, \forall k \in \mathbb{Z})$; the series

$$\sum_{\omega_1}^{\omega_2} \frac{A_k}{b_k^2} < \infty$$

converges.

For real meromorphic functions $f(z): \mathbb{C}_+ \to \mathbb{C}_-$ there also exists decomposition (4.18) where $a \leq 0$ and $A_k \leq 0$ $(k \in \mathbb{Z}_+)$.

Due to the Krein theorem, the function F(z) (4.16) maps $\mathbb{C}_+ \to \mathbb{C}_+$ (or $\mathbb{C}_+ \to \mathbb{C}_-$). Using the Chebotarev theorem for F(z), we obtain decomposition (4.18) where sign $A_k = \operatorname{sign} A_0$. Relation (4.14) implies that a = 0 and

$$b - \sum \frac{A_k}{z_k(0)} = 1,$$

therefore

$$F(z) = 1 + \sum_{k} \frac{A_k}{z_k(0) - z}; \quad \sum_{k} \frac{|A_k|}{z_k(0)} < \infty.$$

Using (4.15), we obtain

$$\sum_{k} |A_k| < \infty.$$

Designating

$$\alpha = \sum_{k} A_{k}, \quad ||v_{k}||^{2} = \frac{A_{k}}{\sum_{s} A_{s}};$$

we have

$$F(z) = 1 + \alpha \sum \frac{\|v_k\|^2}{z_k(0) - z}.$$

It is left to set the function v(x) such that $||E_k v||^2 = ||v_k||^2$ and to define the operator $L = L(\alpha, v)$ (1.9). Its characteristic function $\Delta(\alpha, \lambda)$, in view of (2.14), equals $\Delta(\alpha, \lambda) = F(\lambda^2)\Delta(0, \lambda) = \Delta(\lambda)$.
