# BOUSSINESQ SYSTEM WITH MEASURE FORCING

#### Abstract

We address a question concerning the issue of existence to a Boussinesq type system with a heat source. The problem is studied in the whole two dimensional plane and the heat source is a measure transported by the flow. For arbitrary initial data, we prove global in time existence of unique regular solutions. Measure being a heat source limits regularity of constructing solutions and make us work in a non-standard framework of inhomogeneous Besov spaces of the $L^{\infty}\left(0, T ; B_{p, \infty}^{s}\right)$-type. Application of the Lagrangian coordinates yields uniqueness omitting difficulties with comparison of measures.


## 1. Introduction

Heat conducting fluids are an important part of the fluid mechanics. In the highest generality they are complete from the viewpoint of the conservation of the total energy. Viscous fluids generate internal friction and produce thermal effects, and vice versa variability of the temperature creates a motion of the fluid. In the general form we distinguish the Navier-Stokes-Fourier model for the compressible flows:

In short, $\rho, u, \theta$ are sought quantities: the density, velocity and the temperature of the fluid. Functions $p(\cdot, \cdot)$ and $s(\cdot, \cdot)$ are the pressure and entropy. The stress tensor $S$ is given in the Newtonian form and the energy flux is given in the Fourier form $q=-\kappa(\theta) \nabla \theta$ and the entropy production $\sigma=\frac{1}{\theta}\left(S: \nabla u+\frac{\kappa(\theta)|\nabla \theta|^{2}}{\theta}\right)$ (for more details see [9]).

Nowadays mathematics is able to deliver just existence of weak solutions [9, 10, 12] for the system (1.1), and regular solutions are just possible to get for small data [18, 3, 22]. The system looks too much complex. It makes us look for a reduction of it. Taking a low Mach number limit (see [11, 7]), we obtain an incompressible limit which takes into account weak thermal effects, known as the Boussinesq approximation

where $d=2,3, v$ is the velocity vector field, $\theta$ is the temperature field, and $e_{d}$ is the last canonical vector of $\mathbb{R}^{d}$. In the simplest explanation, the above system (1.2) is the incompressible NavierStokes equations coupled with the heat equation with a drift given by the velocity, forcing for the momentum equation is defined by the change of temperature in the direction of the gravitational

[^0]force (i.e. $e_{d}$-direction). For the mathematical study of system (1.2) with $f=0$, one can see [2, 14, 21, 1 for the global well-posedness results (with small data assumption in 3D case).

What is important to underline is the following fact, the system does not preserve the energy, in [1] the authors proved that for $f=0$ in system (1.2) the total energy $\|u(t)\|_{L^{2}}^{2}$ may grow in time. It makes our mathematical analysis more interesting. The dynamics is nontrivial for long time and most of norms of solutions are expected to growth in time.

Let us explain the goal of our paper. We want to consider a special case of system (1.2) as the force is given by a heat source transported by the flow:

where the system is consider in the whole space $\mathbb{R}^{d}$.
In the most interesting case one can think that $\mu$ describes a combustion distributed by some measure like a linear combination of some Dirac atoms. The physical explanation can be a modeling the movement of water after putting some chemical material like Sodium (Na) into a square pool fully containing water.

The main goal of the paper is to consider large solutions to construct global in time solvability. Since the Millennium Problem concerning the regularity of weak solutions to the three dimensional Navier-Stokes system is still open, we here concentrate our attention on the case of two spacial dimension. The key point is to consider general data admitting initial heat production as a Radon measure and large initial data of velocity and temperature.

Our result is the global in time existence and uniqueness of regular solution for the system (1.3) at the 2 D case.

Theorem 1.1. Let $\mu_{0} \in \mathcal{M}_{+}\left(\mathbb{R}^{2}\right)$ with $\operatorname{supp} \mu_{0} \subset B_{R_{0}}(0)$ for some $R_{0}>0$. For each $\left.\sigma \in\right] 0,2[$, let $\theta_{0} \in L^{1} \cap B_{\frac{4}{4-\sigma}, \infty}^{2-\sigma}\left(\mathbb{R}^{2}\right)$ with $\theta_{0} \geq 0$, and $v_{0} \in H^{1}\left(\mathbb{R}^{2}\right)$ be a divergence-free vector field with initial vorticity $\omega_{0}=\partial_{1} v_{2,0}-\partial_{2} v_{1,0} \in B_{\frac{4}{4-\sigma}, \infty}^{3-\sigma}\left(\mathbb{R}^{2}\right)$. Let $T>0$ be any given. Then the system (1.3) admits a unique solution $(\mu, \theta, v)$ on $[0, T]$ such that

where $C_{T}>0$ is a constant depending on $T$ and the norms of initial data.
The above statement requires some explanation. In general the global wellposedness of system (1.3) with smooth forcing $\mu$ in the two spacial dimension case for large data is clear. Thanks to the famous result of Ladyzhenskaya [16] (and in the language of Besov space [8]), we are able to obtain the regular solutions to the Navier-Stokes equations. The system (1.3) from the regularity viewpoint is a relatively weak perturbation and basic energy norms grant us the standard existence at the level of Galerkin's method, but only for a suitable approximation related with smoothed out initial data - see details in the subsection 3.2. However this approach works just for smooth forcing $\mu$, and for the original initial data we are required to proceed in a non-standard way. To avoid
technical problem with definition of measures at infinity we assume that the initial heat source is compactly supported in space.

Our result has three interesting ingredients:

* The first one, the heat source is just a measure which is not vanishing in time, and the only information one can get here is the $L^{\infty}$ in time and measure in space (see Proposition (3.1). It requires quite high regularity of the velocity, indeed the Lipschitz continuity, to guarantee the existence and uniqueness. On the other hand we can not expect too much regular solutions since they are generated by a measure forcing. Nevertheless, our solutions are regular and (1.3) $1_{1}$ solves $\mu$ in terms of characteristics, which are well-defined.
* The second one, it is an application of non-standard Besov spaces $L^{\infty}\left(0, T ; B_{p, \infty}^{s}\left(\mathbb{R}^{2}\right)\right)$ of first time to consider the measure force. The basic restriction here is that the measure $\mu$ will belong to $L_{T}^{\infty}\left(B_{\frac{4}{4-\sigma}, \infty}^{-\sigma}\right)$, which is slightly larger than the expected one. Such a framework fits perfectly to the regularity properties of the right-hand side of equation (1.3) $)_{2}$.
* The last one is the limited regularity of solution. In the construction of the a priori estimates, it appears that the force $\mu$ given as a measure does not allow to use just standard bounds by the energy norms. In showing the crucial $L^{2}$-estimate of velocity $v$ and vorticity $\omega$, we have to control $\|\theta(t)\|_{L^{2}}$ which is not so direct due to the effect of the measure force; we have a natural uniform $L^{1}-$ bound $\|\theta\|_{L_{t}^{\infty}\left(L^{1}\right)}$, and for the higher regularity we use Lemma 2.4 to derive an estimate of quantity $\left.\|\theta\|_{L_{t}^{\infty}\left(B_{\frac{4}{4}, \infty}^{2-\sigma}, \infty\right.}\right)$ in terms of $\|(v, \omega)\|_{L_{t}^{\infty}\left(L^{2}\right)}$, and then the needing estimate $\|\theta(t)\|_{L^{2}}$ is bounded from interpolation of these two quantities. Somehow we consider here a limit case and the final estimate of $\|(v, \omega)\|_{L_{t}^{\infty}\left(L^{2}\right)}$ (see (3.15) below) is obtained by an application of a new logarithmic interpolation inequality for the Besov spaces (see Lemma (2.6).

Besides, we also point out that since the measure force $\mu$ is determined via a transport equation, it seems not sufficient to show the uniqueness in the framework of Eulerian coordinates and we have to adapt the Lagrangian coordinates (see [5, 6] and references therein for this novel method used in the density-dependent incompressible Navier-Stokes equations). The limited regularity of velocity and temperature field also makes much difficulty in considering the difference system (3.41) by using the standard $L^{2}$-energy estimates, but instead we work on a non-standard setting, that is, we consider the $\dot{H}^{-1}$-estimate of $\delta \bar{\theta}$ and $\dot{H}^{1}$-estimate of $\delta \bar{v}$ simultaneously, and by a series of energy type estimates in the Lagrangian coordinates we manage to show the uniqueness.

The outline of this paper is as follows. We present preliminary results including some auxiliary lemmas in subsection 2. We give the detailed proof of Theorem 1.1 in the whole section 3 we firstly show the key a priori estimates of solution $(\mu, \theta, v)$ in subsection 3.1, then we sketch the proof of existence in subsection 3.2, and finally we prove the uniqueness by using Lagrangian coordinates in subsection 3.3. In the last appendix section we show the proof of Lemma 2.5.

## 2. Preliminaries

In this section, some notations are listed, and we compile basic results related to measure and Lagrangian coordinates, and also show some auxiliary lemmas used in the paper.

The following notations are used throughout this paper.
$\diamond C$ stands for a constant which may be different from line to line, and $C\left(\lambda_{1}, \cdots, \lambda_{n}\right)$ denotes a constant $C$ depending on the coefficients $\lambda_{1}, \cdots, \lambda_{n}$.
$\diamond$ The notation $\mathcal{D}\left(\mathbb{R}^{d}\right)$ or $\mathcal{D}\left(\mathbb{R}^{d} \times[0, T]\right)$ denotes the space of $C^{\infty}$-smooth functions with compact support on $\mathbb{R}^{d}$ or $\mathbb{R}^{d} \times[0, T]$, respectively. $\mathcal{D}^{\prime}\left(\mathbb{R}^{d} \times[0, T]\right)$ is the space of distribution on $\mathbb{R}^{d} \times[0, T]$ which is the dual space of $\mathcal{D}\left(\mathbb{R}^{d} \times[0, T]\right)$.
$\diamond$ The notation $\mathcal{S}\left(\mathbb{R}^{d}\right)$ is the Schwartz class of rapidly decreasing $C^{\infty}$-smooth functions, and $\mathcal{S}^{\prime}\left(\mathbb{R}^{d}\right)$ is the space of tempered distributions which is the dual space of $\mathcal{S}\left(\mathbb{R}^{d}\right)$.
$\diamond$ For $m \in \mathbb{N}, r \in[1,+\infty], s \in \mathbb{R}$, we denote by $W^{m, r}\left(\mathbb{R}^{d}\right)\left(\dot{W}^{m, r}\left(\mathbb{R}^{d}\right)\right)$ and $H^{s}\left(\mathbb{R}^{d}\right)\left(\dot{H}^{s}\left(\mathbb{R}^{d}\right)\right)$ the usual $L^{r}$-based and $L^{2}$-based inhomogeneous (homogenous) Sobolev spaces.
$\diamond$ For Banach space $X=X\left(\mathbb{R}^{d}\right)$ and $\rho \in[1, \infty]$, the notation $L^{\rho}(0, T ; X)$ denotes the usual spacetime space $L^{\rho}([0, T] ; X)$, which is also abbreviated as $L_{T}^{\rho}(X)$.
$\diamond$ We use $B_{r}\left(x_{0}\right):=\left\{x \in \mathbb{R}^{d}:\left|x-x_{0}\right|<r\right\}$ to denote the open ball of $\mathbb{R}^{d}$.
2.1. Results related to measure. We denote $\mathcal{M}=\mathcal{M}\left(\mathbb{R}^{d}\right)$ as the space of finite Radon measures defined on $\mathbb{R}^{d}$ with total variation topology, i.e., for any $\mu$ Radon measure, define

As a consequence of Riesz representation theorem, $\mathcal{M}\left(\mathbb{R}^{d}\right)$ is the dual space of $C_{0}\left(\mathbb{R}^{d}\right)$. For $\left\{\mu_{n}\right\}_{n \in \mathbb{N}} \subset \mathcal{M}\left(\mathbb{R}^{d}\right)$ and $\mu \in \mathcal{M}\left(\mathbb{R}^{d}\right)$, we say $\mu_{n} \rightarrow \mu$ weakly* if

We denote $\mathcal{M}_{+}=\mathcal{M}_{+}\left(\mathbb{R}^{d}\right)$ the set of nonnegative finite Radon measures on $\mathbb{R}^{d}$, i.e.,

both with the strong total variation and weak $d(\cdot, \cdot)$ topologies.
Definition 2.1. We say that a sequence $\left\{\mu_{n}\right\} \subset \mathcal{M}\left(\mathbb{R}^{d}\right)$ is tight if for any $\epsilon>0$, there exists a compact set $K_{\epsilon} \subset \subset \mathbb{R}^{d}$ so that

where $\left|\mu_{n}\right|$ is the total variation measure of $\mu_{n}$.
Proposition 2.2 (cf. Theorem 2.7 of [15]). Let $\left\{\mu_{n}\right\}_{n \in \mathbb{N}}$ be a tight sequence in $\mathcal{M}\left(\mathbb{R}^{d}\right)$ and let $\mu \in \mathcal{M}\left(\mathbb{R}^{d}\right)$. Then as $n \rightarrow \infty, \mu_{n} \rightarrow \mu$ weakly* if and only if $d\left(\mu_{n}, \mu\right) \rightarrow 0$ and $\sup _{n \in \mathbb{N}}\left|\mu_{n}\right|\left(\mathbb{R}^{d}\right)<\infty$.

The space $\left(\mathcal{M}_{+}, d\right)$ is a complete metric space.
Proposition 2.3 (cf. Corollary 21 of [19]). Let $\left\{\mu_{n}\right\}_{n \in \mathbb{N}}$ be a sequence bounded in $\mathcal{M}_{+}\left(\mathbb{R}^{d}\right)$ with support contained in a given ball. Then there exists a $\left(\mathcal{M}_{+}, d\right)$-convergent subsequence $\left\{\mu_{n_{k}}\right\}$.
2.2. Auxiliary lemmas. Before presenting some auxiliary lemmas used in this paper, we recall the definitions of nonhomogeneous Besov spaces and their space-time counterparts. One can choose two nonnegative radial functions $\chi, \varphi \in \mathcal{D}\left(\mathbb{R}^{d}\right)$ be supported respectively in the ball $\left\{\xi \in \mathbb{R}^{d}:|\xi| \leq \frac{4}{3}\right\}$ and the annulus $\left\{\xi \in \mathbb{R}^{d}: \frac{3}{4} \leq|\xi| \leq \frac{8}{3}\right\}$ such that (e.g. see [4])

For every $f \in S^{\prime}\left(\mathbb{R}^{d}\right)$, we define the non-homogeneous Littlewood-Paley operators as follows

The classical space-time Besov space $L^{\rho}\left([0, T], B_{p, r}^{s}\right)$, abbreviated by $L_{T}^{\rho}\left(B_{p, r}^{s}\right)$, is the set of tempered distribution $f$ such that

Another one is the Chemin-Lerner's mixed space-time Besov space $\widetilde{L}^{\rho}\left([0, T], B_{p, r}^{s}\right)$, abbreviated by $\widetilde{L}_{T}^{\rho}\left(B_{p, r}^{s}\right)$, which is the set of tempered distribution $f$ satisfying

Then we have the following regularity estimates of the heat equation in the framework of Besov spaces (see [4, Theorem 2.2.5]).
Lemma 2.4. Let $s \in \mathbb{R}$ and $1 \leq \rho, \rho_{1}, r \leq \infty$. Let $T>0$, $u_{0} \in B_{p, r}^{s}\left(\mathbb{R}^{d}\right)$, and $f \in \widetilde{L}_{T}^{\rho}\left(B_{p, r}^{s-2+2 / \rho}\right)$. Then the following nonhomogeneous heat equation

has a unique solution $u$ in $\widetilde{L}_{T}^{\rho}\left(B_{p, r}^{s+2 / \rho}\right) \cap \widetilde{L}_{T}^{\infty}\left(B_{p, r}^{s}\right)$ and there exists a constant $C=C(d)$ such that for all $\rho_{1} \in[\rho, \infty]$,

In obtaining the a priori estimates of the main theorem, we use the following product estimates in Besov spaces (whose proof is put to the appendix section).
Lemma 2.5. Let $v: \mathbb{R}^{2} \rightarrow \mathbb{R}^{2}$ be a divergence-free vector field and $\theta: \mathbb{R}^{2} \rightarrow \mathbb{R}$ be a scalar function.
(1) Let $s \in] 0,1[, p \in[1, \infty]$. Then there exists a positive constant $C=C(s)$ such that

\|v \cdot \nabla \theta\|_{B_{p, \infty}^{s}\left(\mathbb{R}^{2}\right)} & \leq C_{0}\left(\|v\|_{L^{2 p}\left(\mathbb{R}^{2}\right)}\|\theta\|_{B_{2 p, \infty}^{1+s}\left(\mathbb{R}^{2}\right)}+\|v\|_{B_{2 p, \infty}^{s}\left(\mathbb{R}^{2}\right)}\|\nabla \theta\|_{L^{2 p}\left(\mathbb{R}^{2}\right)}\right)  \tag{2.5}\\
& \leq C\|v\|_{B_{2 p, \infty}^{s}\left(\mathbb{R}^{2}\right)}\|\theta\|_{B_{2 p, \infty}\left(\mathbb{R}^{2}\right)} .
\end{align*}
$$

(3) Let $s \in] 0, \infty[, p \in[1, \infty]$. Then there exists a positive constant $C=C(s)$ such that

Proof of Lemma 2.6. Let $N \in \mathbb{N} \cap[2, \infty[$ be an integer chosen later, then by using Bernsteins's inequality we have

& \leq C_{0} \sup _{-1 \leq k \leq N} 2^{k(1-s)} \sqrt{2+k} 2^{k\left(d-\frac{d}{p}\right)}\left\|\Delta_{k} \theta\right\|_{L^{1}}+C_{0} \sup _{k \geq N} \sqrt{2+k} 2^{-k} 2^{k(2-s)}\left\|\Delta_{k} \theta\right\|_{L^{p}} \\
& \leq C_{0} 2^{N\left(1+d-s-\frac{d}{p}\right)} \sqrt{N}\|\theta\|_{L^{1}\left(\mathbb{R}^{d}\right)}+C_{0} 2^{-N} \sqrt{N}\|\theta\|_{B_{p, \infty}^{2-s}\left(\mathbb{R}^{d}\right)} .

Now we define the constant $N$ as

where notation $[a]$ means the integer part of $a \in \mathbb{R}$, then it is clear that the desired inequality (2.7) is followed by a direct computation.

The following $L^{2}$-based estimate on the linear Stokes system is useful in the uniqueness proof.
Lemma 2.7 (cf. Lemma 3 of [6]). Let $R$ be a vector field satisfying $\left.\left.R_{t} \in L^{2}\left(\mathbb{R}^{d} \times\right] 0, T\right]\right)$ and $\left.\left.\nabla \operatorname{div} R \in L^{2}\left(\mathbb{R}^{d} \times\right] 0, T\right]\right)$. Then the following system

where $C$ is a positive constant independent of $T$.
2.3. The Lagrangian coordinates. The use of Lagrange coordinates plays a fundamental role in the proof of the uniqueness part. In this subsection, we introduce some notations and basic results related to the Lagrangian coordinates.

Let $X_{v}(t, y)$ solve the following ordinary differential equation (treating $y$ as a parameter)

Lemma 2.8. Assume that $v \in L^{1}\left(0, T ; \dot{W}^{1, \infty}\left(\mathbb{R}^{d}\right)\right)$. Then the system (2.11) has a unique solution $X_{v}(t, y)$ on the time interval $[0, T]$ satisfying $\nabla_{y} X_{v} \in L^{\infty}\left(0, T ; L^{\infty}\right)$ with

Let $Y(t, \cdot)$ be the inverse diffeomorphism of $X(t, \cdot)$, then $\nabla_{x} Y_{v}(t, x)=\left(\nabla_{y} X_{v}(t, y)\right)^{-1}$ with $x=$ $X_{v}(t, y)$, and if

Proof of Lemma 2.8. The proof is standard, and one can refer to [6, Proposition 1] for details. We only note that as long as $\nabla_{y} X_{v}-\mathrm{Id}=\int_{0}^{t} \nabla_{y} \bar{v}(\tau, y) \mathrm{d} \tau$ is sufficiently small so that (2.16) holds, we have

\operatorname{div}_{y}\left(A_{v} \bar{v}\right)=0, \\
\left.\bar{\mu}\right|_{t=0}=\mu_{0},\left.\quad \bar{\theta}\right|_{t=0}=\theta_{0},\left.\quad \bar{v}\right|_{t=0}=v_{0}
\end{array}\right.
$$

where we have adopted the notation

As pointed out by [5, 6], under the condition (2.16), the system (2.20) in the Lagrangian coordinates is equivalent to the system (1.3) in the Eulerian coordinates.

The first equation of (2.20) guarantees

\operatorname{div}_{y}\left(A_{v} \bar{v}\right)=0, \\
\left.\bar{\theta}\right|_{t=0}=\theta_{0},\left.\quad \bar{v}\right|_{t=0}=v_{0}
\end{array}\right.

## 3. Proof of Theorem 1.1

### 3.1. A priori estimates.

Proposition 3.1. Let $\mu_{0} \in \mathcal{M}_{+}\left(\mathbb{R}^{2}\right)$ be satisfying that $\operatorname{supp} \mu_{0} \subset B_{R_{0}}(0)$ for some $R_{0}>0$. Let $T>0$ be any given, and $(\mu, \theta, v)$ be smooth functions on $\mathbb{R}^{2} \times[0, T]$ solving the system (1.3). Then for every $t \in[0, T]$, we have $\mu(t, x)=\mu_{t}(x) \in \mathcal{M}_{+}\left(\mathbb{R}^{2}\right)$ with

$$
\begin{equation*}
\left\|\mu_{t}\right\|_{\mathcal{M}\left(\mathbb{R}^{2}\right)} \leq\left\|\mu_{0}\right\|_{\mathcal{M}\left(\mathbb{R}^{2}\right)}, \quad \forall t \in[0, T], \tag{3.1}
\end{equation*}
$$

and also $\operatorname{supp} \mu_{t} \subset B_{R_{0}+C}(0)$ with $C=\|v\|_{L_{T}^{1}\left(L^{\infty}\right)}$.
Proof of Proposition 3.1. Let $X_{t}(y)=X(t, y)$ be the flow function generated by the velocity $v$, which solves equation (2.11) or (2.12). Since we assume that $v \in L^{1}\left([0, T] ; W^{1, \infty}\left(\mathbb{R}^{2}\right)\right)$, from Lemma 2.8, it admits a unique vector field $X_{t}: \mathbb{R}^{2} \rightarrow \mathbb{R}^{2}, t \in[0, T]$ which is a diffeomorphism.

Let $Y_{t}=Y(t, \cdot)$ be the inverse diffeomorphism of $X_{t}$, then we see that

Clearly, $\mu_{t} \geq 0$, and since $X_{t}$ is volume-preserving (from the divergence-free property of $v$ ), we have

& =\sup _{\|g\|_{L^{\infty}} \leq 1}\left|\int_{\mathbb{R}^{2}} g\left(X_{t}(y)\right) \mathrm{d} \mu_{0}(y)\right| \\
& \leq \sup _{\|\tilde{g}\|_{L^{\infty} \leq 1} \leq 1}\left|\int_{\mathbb{R}^{2}} \tilde{g}(y) \mathrm{d} \mu_{0}(y)\right|=\left\|\mu_{0}\right\|_{\mathcal{M}\left(\mathbb{R}^{2}\right)},
\end{aligned}
$$

where the supremum is taken over all $C_{0}\left(\mathbb{R}^{2}\right)$ fuctions.
From (3.2) and $\operatorname{supp} \mu_{0} \subset B_{R_{0}}(0)$, we get $\operatorname{supp} \mu_{t} \subset X_{t}\left(B_{R_{0}}(0)\right)$, and thus formula (2.12) implies that supp $\mu_{t} \subset B_{R_{0}+\|v\|_{L_{T}^{1}\left(L^{\infty}\right)}}(0)$.
Proposition 3.2. Let $\mu_{0} \in \mathcal{M}_{+}\left(\mathbb{R}^{2}\right)$ with $\operatorname{supp} \mu_{0} \subset B_{R_{0}}(0)$ for some $R_{0}>0$, and $\theta_{0} \in L^{1}\left(\mathbb{R}^{2}\right)$ with $\theta_{0} \geq 0$. For $T>0$ any given, let $(\mu, \theta, v)$ be smooth functions on $\mathbb{R}^{2} \times[0, T]$ solving system (1.3). Then we have that $\theta(t) \geq 0$ for every $t \in[0, T]$ and also

$$
\begin{equation*}
\sup _{t \in[0, T]}\|\theta(t)\|_{L^{1}\left(\mathbb{R}^{2}\right)} \leq\left\|\theta_{0}\right\|_{L^{1}\left(\mathbb{R}^{2}\right)}+T\left\|\mu_{0}\right\|_{\mathcal{M}\left(\mathbb{R}^{2}\right)} . \tag{3.3}
\end{equation*}
$$

Proof of Proposition 3.2. We first prove the nonnegativity property of $\theta(t)$. The proof is standard (e.g. see [17) and it uses a contradiction argument. Denote by $\left.\left.\Omega_{T}:=\right] 0, T\right] \times \mathbb{R}^{2}$. We define $\tilde{\theta}(t, x)=\theta(t, x) e^{-t}$ and assume that there is a constant $\lambda>0$ so that

$$
\inf _{(t, x) \in \Omega_{T}} \tilde{\theta}(t, x)=-\lambda .
$$

Such a constant $\lambda$ exists since we assume $\tilde{\theta}$ is a bounded smooth function. We also infer that there exists some point $\left(t_{*}, x_{*}\right) \in \Omega_{T}$ attaining this infimum. Indeed, if not, there exists a sequence of points $\left(t_{n}, x_{n}\right)_{n \in \mathbb{N}}$ becoming unbounded such that $\tilde{\theta}\left(t_{n}, x_{n}\right) \rightarrow-\lambda$ as $n \rightarrow \infty$, which is a contradiction with the assumption that $\tilde{\theta}$ is a smooth function with suitable spatial decay.

From the equation of $\tilde{\theta}$, we get

$$
\left(\partial_{t} \tilde{\theta}\right)\left(t_{*}, x_{*}\right)=-\tilde{\theta}\left(t_{*}, x_{*}\right)-(v \cdot \nabla \tilde{\theta})\left(t_{*}, x_{*}\right)+\Delta \tilde{\theta}\left(t_{*}, x_{*}\right)
$$

Due to that $\tilde{\theta}$ attains the infimum at $\left(t_{*}, x_{*}\right)$, it yields that $(\nabla \tilde{\theta})\left(t_{*}, x_{*}\right)=0$ and $(\Delta \tilde{\theta})\left(t_{*}, x_{*}\right) \geq 0$, thus we find

But this clearly contradicts with the fact that $\left(t_{*}, x_{*}\right)$ is the infimum point of $\tilde{\theta}$, hence the nonnegativity of $\theta$ for every $t \in[0, T]$ is followed. Note that in the above proof the smoothness of $\theta$ is required. So this part work for smooth approximation of solutions (see Section 3.21). Passage to the limit saves the nonnegativity of the temperature.

Next, we show $\theta \in L^{\infty}\left([0, T] ; L^{1}\left(\mathbb{R}^{2}\right)\right)$. Let $\varphi \in \mathcal{D}\left(\mathbb{R}^{2}\right)$ be a test function satisfying $\operatorname{supp} \varphi \subset$ $B_{1}(0), \varphi \equiv 1$ on $B_{1 / 2}(0)$, and $0 \leq \varphi \leq 1$. Set $\varphi_{R}:=\varphi(\dot{\bar{R}})$ for every $R>0$. Multiplying both sides of the equation of $\theta$ with $\varphi_{R}$ and integrating on the spatial variable, we obtain

By viewing the measure $\mu(t)$ as the dual space of $C_{0}\left(\mathbb{R}^{2}\right)$, we deduce that

\int_{\mathbb{R}^{2}} \mu(t, x) \varphi_{R}(x) \mathrm{d} x=\left(\mu(t), \varphi_{R}\right) \leq\|\mu(t)\|_{\mathcal{M}} \leq\left\|\mu_{0}\right\|_{\mathcal{M}}
$$

Thus integrating on the time interval $[0, t](t \in[0, T])$ and using integration by parts, we find
$\int_{\mathbb{R}^{2}} \theta(t) \varphi_{R} \mathrm{~d} x \leq \int_{\mathbb{R}^{2}} \theta_{0} \varphi_{R} \mathrm{~d} x+\frac{1}{R} \int_{0}^{T} \int_{\mathbb{R}^{2}}|v \theta|\left|\nabla \varphi\left(\frac{x}{R}\right)\right| \mathrm{d} x \mathrm{~d} t+\frac{1}{R} \int_{0}^{T} \int_{\mathbb{R}^{2}}|\nabla \theta|\left|\nabla \varphi\left(\frac{x}{R}\right)\right| \mathrm{d} x \mathrm{~d} t+T\left\|\mu_{0}\right\|_{\mathcal{M}}$.
Since we assume $\theta, v$ are smooth functions which guarantees that $v, \theta, \nabla \theta \in L^{2}\left([0, T] \times \mathbb{R}^{2}\right)$, by passing $R$ to $\infty$, it yields that

\int_{\mathbb{R}^{2}} \theta(t, x) \mathrm{d} x \leq \int_{\mathbb{R}^{2}} \theta_{0}(x) \mathrm{d} x+T\left\|\mu_{0}\right\|_{\mathcal{M}} .

Hence the desired inequality (3.3) is followed from the nonnegativity of $\theta(t)$.
Proposition 3.3. Let $\mu_{0} \in \mathcal{M}_{+}\left(\mathbb{R}^{2}\right)$ with $\operatorname{supp} \mu_{0} \subset B_{R_{0}}(0)$ for some $R_{0}>0$. For each $\left.\sigma \in\right] 0,2[$, let $\theta_{0} \in L^{1} \cap B_{\frac{4}{4-\sigma}, \infty}^{2-\sigma}\left(\mathbb{R}^{2}\right)$ with $\theta_{0} \geq 0$, and $v_{0} \in H^{1}\left(\mathbb{R}^{2}\right)$ be a divergence-free vector field with initial vorticity $\omega_{0}:=\partial_{1} v_{2,0}-\partial_{2} v_{1,0} \in B_{\frac{-}{4-\sigma}, \infty}^{3-\sigma}\left(\mathbb{R}^{2}\right)$. Let $T>0$ be any given, and assume that $(\mu, \theta, v)$ are smooth functions on $\mathbb{R}^{2} \times[0, T]$ solving the system (1.3). Then we have

Note that this choice of the space seems to be not optimal, however this leads to lower power index of integrability of the ground space. Thanks to this choice the estimation closes.

Applying Lemma [2.4 to the equation $\partial_{t} \theta-\Delta \theta=-v \cdot \nabla \theta+\mu$, we infer that for every $t \in[0, T]$,

3.2. Global existence. The issue of existence for our system is not immediate since $\mu=\mu(x, t)$ is just a measure. In order to construct a suitable approximation we consider the system with smooth initial data. One can start with an initial sequence

To show the existence of system (1.3) with such initial data (3.22), we want to use a standard approach via Galerkin method. An approximation we build on the following spaces:

* $H^{2}\left(\mathbb{R}^{2}\right)$ for the velocity field in the divergence-free subset
and
* $H^{1}\left(\mathbb{R}^{2}\right)$ for the temperature.

In short, $v^{(n), N}$ and $\theta^{(n), N}$ are approximations based on the $N$-dimensional restriction of $H^{2}$ and $H^{1}$ spaces. We have

The sought functions $V_{k}^{(n), N}(t)$ and $\Theta_{k}^{(n), N}(t)$ are derived by solving of the following ODEs

For $v^{(n)}$ and $\theta^{(n)}$, from (3.32) and based on the standard compactness argument for the Besov/Soblev spaces, we find a subsequence with strong (point-wise) convergence to some functions $v$ and $\theta$, more precisely, one has that for every $\varphi \in \mathcal{D}\left(\mathbb{R}^{2}\right)$,

$$
\begin{align*}
& T^{\prime} \leq \frac{1}{256}, \quad C T^{\prime \frac{3-\sigma}{2(1-\sigma)}}\left(\left\|\nabla \bar{v}_{2}\right\|_{L_{T}^{\infty}\left(L^{\infty}\right)}\left\|\nabla^{2} X_{v_{1}}\right\|_{L_{T}^{\infty}\left(L^{\left.\frac{2}{\sigma}\right)}\right.}+\left\|\nabla^{2} \bar{v}_{2}\right\|_{L_{T}^{\infty}\left(L^{\frac{2}{\sigma}}\right)}\right)^{\frac{1}{1-\sigma} \leq \frac{1}{4},}  \tag{3.55}\\
& C T^{\prime \frac{3-\sigma}{2(1-\sigma)}}\left(\left\|\nabla \bar{p}_{2}\right\|_{L_{T}^{\infty}\left(L^{\left.\frac{2}{\sigma}\right)}\right.}^{\frac{1}{1-\sigma}}+\left\|\partial_{t} \bar{v}_{2}\right\|_{L_{T}^{\infty}\left(L^{\left.\frac{2}{\sigma}\right)}\right.}^{\frac{1}{1-\sigma}}\right)+C T^{\prime \frac{1}{2}}\left(\left\|\nabla^{2} X_{v_{1}}\right\|_{L_{T}^{\infty}\left(L^{\left.\frac{2}{\sigma}\right)}\right.}^{\frac{1}{1-\sigma}}+\left\|\bar{v}_{2}\right\|_{L_{T}^{\infty}\left(L^{\infty}\right)}\right) \leq \frac{1}{4},
\end{align*}
$$

the whole right-hand side of inequality (3.54) can be absorbed by the left-hand side, which leads to $\|\nabla \delta \bar{v}\|_{L_{T^{\prime}}^{\infty}\left(L^{2}\right)}=\left\|\nabla^{2} \delta \bar{v}\right\|_{L_{T^{\prime}}^{2}\left(L^{2}\right)} \equiv 0$, and also by estimate (3.50), $\left\|\Lambda^{-1} \delta \bar{\theta}\right\|_{L_{T^{\prime}}^{\infty}\left(L^{2}\right)}=\|\delta \bar{\theta}\|_{L_{T^{\prime}}^{2}\left(L^{2}\right)} \equiv 0$. Since $\left.\delta \bar{v}\right|_{t=0} \equiv 0$, we conclude that $\delta \bar{v}=0$ and $\delta \bar{\theta}=0$ a.e. on $\mathbb{R}^{2} \times\left[0, T^{\prime}\right]$. Repeating the above procedure, we can further prove $\delta \bar{v}=\delta \bar{\theta}=0$ a.e. on $\left[T^{\prime}, 2 T^{\prime}\right],\left[2 T^{\prime}, 3 T^{\prime}\right], \cdots$, where $T^{\prime}>0$ is a small constant depending only on the time $T$ and the norms of $\left(\theta_{i}, v_{i}, p_{i}\right)$ in estimate (3.37) (similar to conditions (3.49) and (3.55), hence we finally get $\delta \bar{v}=\delta \bar{\theta}=0$ and also $X_{v_{1}}=X_{v_{2}}$ a.e. on $\mathbb{R}^{2} \times[0, T]$. Going back to the Eulerian coordinates implies that $\left(\mu_{1}, \theta_{1}, v_{1}\right)=\left(\mu_{2}, \theta_{2}, v_{2}\right)$ a.e. on $\mathbb{R}^{2} \times[0, T]$ and the uniqueness of system (1.3) is followed.

## 4. Appendix

Proof of Lemma 2.5. (1) For every $q \geq-1$, Bony's decomposition yields that

$$
\begin{align*}
\Delta_{q}(v \cdot \nabla \theta)= & \sum_{k \geq-1,|k-q| \leq 4} \Delta_{q}\left(S_{k-1} v \cdot \nabla \Delta_{k} \theta\right)+\sum_{k \geq-1,|k-q| \leq 4} \Delta_{q}\left(\Delta_{k} v \cdot \nabla S_{k-1} \theta\right) \\
& +\sum_{k \geq q-3} \Delta_{q}\left(\Delta_{k} v \cdot \nabla \widetilde{\Delta}_{k} \theta\right):=I_{q}+I I_{q}+I I I_{q}, \tag{4.1}
\end{align*}
$$

where $\Delta_{k}$ and $S_{k-1}$ are Littlewood-Paley operators introduced in (2.2) and $\widetilde{\Delta}_{k}:=\Delta_{k-1}+\Delta_{k}+$ $\Delta_{k+1}$. Taking advantage of Hölder's inequality, Bernstein's inequality and the fact that $\|v\|_{L^{2}}^{2}=$ $\sum_{k \geq-1}\left\|\Delta_{k} v\right\|_{L^{2}}^{2}$, we get

\begin{aligned}
2^{-q s}\left\|I_{q}\right\|_{L^{p}\left(\mathbb{R}^{2}\right)} & \leq C_{0} \sum_{k \geq-1,|k-q| \leq 4} 2^{-q s}\left\|S_{k-1} v\right\|_{L^{\infty}\left(\mathbb{R}^{2}\right)}\left\|\nabla \Delta_{k} \theta\right\|_{L^{p}\left(\mathbb{R}^{2}\right)} \\
& \leq C_{0} \sum_{k \geq-1,|k-q| \leq 4}\left(\sum_{-1 \leq l \leq k-2}\left\|\Delta_{l} v\right\|_{L^{\infty}\left(\mathbb{R}^{2}\right)}\right) 2^{k(1-s)}\left\|\Delta_{k} \theta\right\|_{L^{p}\left(\mathbb{R}^{2}\right)} \\
& \leq C_{0} \sum_{k \geq-1,|k-q| \leq 4}\left(\left\|\Delta_{-1} v\right\|_{L^{2}\left(\mathbb{R}^{2}\right)}+\sum_{0 \leq l \leq k+2} 2^{l}\left\|\Delta_{l} v\right\|_{L^{2}\left(\mathbb{R}^{2}\right)}\right) 2^{k(1-s)}\left\|\Delta_{k} \theta\right\|_{L^{p}\left(\mathbb{R}^{2}\right)} \\
& \leq C_{0} \sum_{k \geq-1,|k-q| \leq 4}\left(\|v\|_{L^{2}\left(\mathbb{R}^{2}\right)}+\left(\sum_{0 \leq l \leq k+2}\left\|\Delta_{l} \nabla v\right\|_{L^{2}\left(\mathbb{R}^{2}\right)}^{2}\right)^{1 / 2}\right) \sqrt{k+2} 2^{k(1-s)}\left\|\Delta_{k} \theta\right\|_{L^{p}\left(\mathbb{R}^{2}\right)} \\
& \leq C_{0}\left(\|v\|_{L^{2}\left(\mathbb{R}^{2}\right)}+\|\nabla v\|_{L^{2}\left(\mathbb{R}^{2}\right)}\right)\left(\sup _{k \geq-1} 2^{k(1-s)} \sqrt{k+2}\left\|\Delta_{k} \theta\right\|_{L^{p}\left(\mathbb{R}^{2}\right)}\right),
\end{aligned}
$$

and

$$
\begin{aligned}
& 2^{-q s}\left\|I I_{q}\right\|_{L^{p}\left(\mathbb{R}^{2}\right)} \leq C_{0} \sum_{k \geq-1,|k-q| \leq 4} 2^{-q s}\left\|\Delta_{k} v\right\|_{L^{\infty}\left(\mathbb{R}^{2}\right)}\left\|\nabla S_{k-1} \theta\right\|_{L^{p}\left(\mathbb{R}^{2}\right)} \\
& \leq C_{0} \sum_{k \geq-1,|k-q| \leq 4}\left(\left\|\Delta_{-1} v\right\|_{L^{\infty}\left(\mathbb{R}^{2}\right)}+\left\|\left(\operatorname{Id}-\Delta_{-1}\right) \Delta_{k} v\right\|_{L^{\infty}\left(\mathbb{R}^{2}\right)}\right)\left(2^{-k s} \sum_{-1 \leq l \leq k-2} 2^{l}\left\|\Delta_{l} \theta\right\|_{L^{p}\left(\mathbb{R}^{2}\right)}\right)
\end{aligned}
$$

$$
\begin{aligned}
& \leq C_{0} \sum_{k \geq-1,|k-q| \leq 4}\left(\|v\|_{L^{2}\left(\mathbb{R}^{2}\right)}+\left\|\left(\operatorname{Id}-\Delta_{-1}\right) \Delta_{k} \nabla v\right\|_{L^{2}\left(\mathbb{R}^{2}\right)}\right)\left(2^{-k s} \sum_{-1 \leq l \leq k-2} 2^{l s}\|\theta\|_{B_{p, \infty}^{1-s}\left(\mathbb{R}^{2}\right)}\right) \\
& \leq C\left(\|v\|_{L^{2}\left(\mathbb{R}^{2}\right)}+\|\nabla v\|_{L^{2}\left(\mathbb{R}^{2}\right)}\right)\|\theta\|_{B_{p, \infty}^{1-s}\left(\mathbb{R}^{2}\right)} .
\end{aligned}
$$

By using the divergence-free property of $v$, we similarly obtain

$$
\begin{aligned}
2^{-q s}\left\|I I I_{q}\right\|_{L^{p}\left(\mathbb{R}^{2}\right)} & \leq C_{0} \sum_{k \geq-1, k \geq q-3} 2^{q(1-s)}\left\|\Delta_{k} v\right\|_{L^{\infty}\left(\mathbb{R}^{2}\right)}\left\|\widetilde{\Delta}_{k} \theta\right\|_{L^{p}\left(\mathbb{R}^{2}\right)} \\
& \leq C_{0}\left(\|v\|_{L^{2}\left(\mathbb{R}^{2}\right)}+\|\nabla v\|_{L^{2}\left(\mathbb{R}^{2}\right)}\right) \sum_{k \geq-1, k \geq q-3} 2^{(q-k)(1-s)} 2^{k(1-s)}\left\|\widetilde{\Delta}_{k} \theta\right\|_{L^{p}\left(\mathbb{R}^{2}\right)} \\
& \leq C\left(\|v\|_{L^{2}\left(\mathbb{R}^{2}\right)}+\|\nabla v\|_{L^{2}\left(\mathbb{R}^{2}\right)}\right)\|\theta\|_{B_{p, \infty}^{1-s}\left(\mathbb{R}^{2}\right)} .
\end{aligned}
$$

Gathering the above estimates leads to estimate (2.4), as desired.
(2) In order to prove the first inequality of (2.5), we also have the splitting (4.1), and by arguing as above, we deduce that for every $q \geq-1$,

$$
2^{q s}\left\|I_{q}\right\|_{L^{p}\left(\mathbb{R}^{2}\right)} \leq C_{0} \sum_{k \geq-1,|k-q| \leq 4} 2^{q s}\left\|S_{k-1} v\right\|_{L^{2 p}\left(\mathbb{R}^{2}\right)}\left\|\nabla \Delta_{k} \theta\right\|_{L^{2 p}\left(\mathbb{R}^{2}\right)} \leq C_{0}\|v\|_{L^{2 p}\left(\mathbb{R}^{2}\right)}\|\theta\|_{B_{2 p, \infty}^{1+s}\left(\mathbb{R}^{2}\right)},
$$

and

$$
2^{q s}\left\|I I_{q}\right\|_{L^{p}\left(\mathbb{R}^{2}\right)} \leq C_{0} \sum_{k \geq-1,|k-q| \leq 4} 2^{q s}\left\|\Delta_{k} v\right\|_{L^{2 p}\left(\mathbb{R}^{2}\right)}\left\|S_{k-1} \nabla \theta\right\|_{L^{2 p}\left(\mathbb{R}^{2}\right)} \leq C\|v\|_{B_{2 p, \infty}^{s}\left(\mathbb{R}^{2}\right)}\|\nabla \theta\|_{L^{2 p}\left(\mathbb{R}^{2}\right)},
$$

and

$$
\begin{aligned}
2^{q s}\left\|I I I_{q}\right\|_{L^{p}\left(\mathbb{R}^{2}\right)} & \leq C_{0} \sum_{k \geq-1, k \geq q-3} 2^{q(1+s)}\left\|\Delta_{k} v\right\|_{L^{2 p}\left(\mathbb{R}^{2}\right)}\left\|\widetilde{\Delta}_{k} \theta\right\|_{L^{2 p}\left(\mathbb{R}^{2}\right)} \\
& \leq C_{0}\left(\sum_{k \geq-1, k \geq q-3} 2^{(q-k)(1+s)}\right)\|v\|_{L^{2 p}\left(\mathbb{R}^{2}\right)}\|\theta\|_{B_{2 p, \infty}^{1+s}\left(\mathbb{R}^{2}\right)} \leq C_{0}\|v\|_{L^{2 p}\left(\mathbb{R}^{2}\right)}\|\theta\|_{B_{2 p, \infty}^{1+s}\left(\mathbb{R}^{2}\right)} .
\end{aligned}
$$

Hence, by collecting the above estimates we conclude the first inequality of (2.5), and then from the continuous embedding $B_{2 p, \infty}^{s} \hookrightarrow L^{2 p}$ and $B_{2 p, \infty}^{1+s} \hookrightarrow W^{1,2 p}$, the second inequality of (2.5) is directly followed.
(3) The proof of inequality (2.6) can be directly deduced from the Bony's paraproduct estimates as above, and we here omit the details.
