# HYPERGEOMETRIC INTEGRALS MODULO $p$ AND HASSE-WITT MATRICES

#### Abstract

We consider the KZ differential equations over $\mathbb{C}$ in the case, when the hypergeometric solutions are one-dimensional integrals. We also consider the same differential equations over a finite field $\mathbb{F}_{p}$. We study the space of polynomial solutions of these differential equations over $\mathbb{F}_{p}$, constructed in a previous work by V. Schechtman and the second author. Using Hasse-Witt matrices we identify the space of these polynomial solutions over $\mathbb{F}_{p}$ with the space dual to a certain subspace of regular differentials on an associated curve. We also relate these polynomial solutions over $\mathbb{F}_{p}$ and the hypergeometric solutions over $\mathbb{C}$.

## 1. Introduction

The KZ equations were discovered by Vadim Knizhnik and Alexander Zamolodchikov [KZ] to describe the differential equations for conformal blocks on sphere in the Wess-ZuminoWitten model of conformal field theory. The hypergeometric solutions of the KZ equations were constructed more than 30 years ago, see [SV1, SV2]. The polynomial solutions of the KZ equations over the finite field $\mathbb{F}_{p}$ with a prime number $p$ of elements were constructed recently in [SV3]. We call these solutions over $\mathbb{F}_{p}$ the arithmetic solutions. The general problem is to find the dimension of the space of arithmetic solutions and to understand relations between the hypergeometric solutions of the KZ equations over $\mathbb{C}$ and the arithmetic solutions over $\mathbb{F}_{p}$.

In this paper we consider an example of the KZ differential equations, whose hypergeometric solutions over $\mathbb{C}$ are $n$-vectors of the integrals

I^{(\gamma)}\left(z_{1}, \ldots, z_{n}\right)=\left(\int_{\gamma} \frac{1}{x-z_{1}} \frac{d x}{y}, \ldots, \int_{\gamma} \frac{1}{x-z_{n}} \frac{d x}{y}\right) \tag{1.1}
\end{equation*}
$$

where

$$
\begin{equation*}
y^{q}=\left(x-z_{1}\right) \ldots\left(x-z_{n}\right) \tag{1.2}
\end{equation*}
$$

and $\gamma$ is a suitable 1 -cycle. It is well known that the space of such $n$-vectors is $n-1$ dimensional. We consider the same differential KZ equations over the field $\mathbb{F}_{p}$ under the assumption that $q$ is also a prime number and $p>q, p>n, n=k q+1$ for some positive integer $k$. We show that the dimension of the space of arithmetic solutions equals only a fraction of $n$. Namely, let $a_{1}$ be the unique positive integer such that $1 \leqslant a_{1} \leqslant q-1$ and $a_{1} p \equiv 1(\bmod q)$. This $a_{1}$ is the inverse of $p$ modulo $q$. It turns out that the dimension of the space of arithmetic solutions equals $a_{1} k$. More precisely the dimension of the space of arithmetic solutions can be defined as follows. Consider the curve $X$ defined by the affine equation (1.2). The cyclic group $\mathbb{Z}_{q}$ of $q$-th roots of unity acts on $X$ by multiplication on the coordinate $y$. The space $\Omega^{1}(X)$ of regular differentials on $X$ splits into eigenspaces of the $\mathbb{Z}_{q^{-}}$ action, $\Omega^{1}(X)=\bigoplus_{a=1}^{q-1} \Omega_{a}^{1}(X)$, where $\Omega_{a}^{1}(X)$ consists of differentials of the form $u(x) d x / y^{a}$. We show that the dimension of the space of arithmetic solutions equals the dimension of $\Omega_{a_{1}}^{1}(X)$. Moreover, we establish an isomorphism of the space of arithmetic solutions and the space dual to $\Omega_{a_{1}}^{1}(X)$. That isomorphism is constructed with the help of the map adjoint to the corresponding Cartier map, and more precisely, with the help of the corresponding Hasse-Witt matrix. This is our first main result.

We also choose one solution of the KZ equations over $\mathbb{C}$ and call it distinguished. We expand the distinguished solutions into the Taylor series at some point, reduce the coefficients of the Taylor expansion modulo $p$ and present this reduced Taylor series as an infinite formal sum of arithmetic solutions, with coefficients being matrix elements of iterates of the associated Hasse-Witt matrix. Moreover, this presentation allows one to recover a basis of arithmetic solutions in terms of the reduced Taylor expansion. This statement is our second main result.

Our comparison of the reduced Taylor expansion of a solution over $\mathbb{C}$ and arithmetic solutions over $\mathbb{F}_{p}$ is analogous to Y.I. Manin's considerations of the elliptic integral in his classical paper [Ma] in 1961, see also Section "Manin's Result: The Unity of Mathematics" in the book [Cl] by Clemens.

For $q=2$ the results of this paper have been obtained in [V5].
The paper is organized as follows. In Section 2 we describe the differential KZ equations considered in this paper. We construct the hypergeometric solutions of these equations over $\mathbb{C}$ and the arithmetic solutions over $\mathbb{F}_{p}$. In Section 3 we define the module of arithmetic solutions, show that it is free, and calculate the rank of the module. In Section 3.3 we describe the fusion procedure for modules of arithmetic solutions.

In Section 4 we prove a generalization of the classical Lucas theorem, which will allow us to reduce modulo $p$ the coefficient of the Taylor expansion of the distinguished solution.

In Section 5 we discuss different bases in the module of arithmetic solutions. One of the bases naturally appears in the defining construction of arithmetic solutions and the other is convenient to relate the arithmetic solutions to the Taylor expansion of the distinguished solution.

In Sections 6 and 7 we study the Cartier map related to our arithmetic solutions and prove our first main result by identifying the module of arithmetic solutions with the space dual
to $\Omega_{a_{1}}^{1}(X)$, see Theorems 6.2 and 7.4. In Section 8 we change variables in the Hasse-Witt matrix preparing it for application to the study of the distinguished solution.

In Section 9 we compare the reduced Taylor series of the distinguished solution and arithmetic solutions, see Theorem 9.8.

## 2. KZ EQUATIONS

2.1. Description of equations. Let $\mathfrak{g}$ be a simple Lie algebra over the field $\mathbb{C}, \Omega \in \mathfrak{g}^{\otimes 2}$ the Casimir element corresponding to an invariant scalar product on $\mathfrak{g}, V_{1}, \ldots, V_{n}$ finitedimensional irreducible $\mathfrak{g}$-modules.

The system of KZ equations with parameter $\kappa \in \mathbb{C}^{\times}$on a tensor $\otimes_{i=1}^{n} V_{i}$ valued function $I\left(z_{1}, \ldots, z_{n}\right)$ is the system of the differential equations

$$
\begin{equation*}
\frac{\partial I}{\partial z_{i}}=\frac{1}{\kappa} \sum_{j \neq i} \frac{\Omega^{(i, j)}}{z_{i}-z_{j}} I, \quad i=1, \ldots, n \tag{2.1}
\end{equation*}
$$

where $\Omega^{(i, j)}$ is the Casimir element acting in the $i$-th and $j$-th factors, see [KZ, EFK]. The KZ differential equations commute with the action of $\mathfrak{g}$ on $\otimes_{i=1}^{n} V_{i}$, in particular, they preserve the subspaces of singular vectors of a given weight.

In [SV1, SV2] the KZ equations restricted to the subspace of singular vectors of a given weight were identified with a suitable Gauss-Manin differential equations and the corresponding solutions of the KZ equations were presented as multidimensional hypergeometric integrals.

Let $p$ be a prime number and $\mathbb{F}_{p}$ the field with $p$ elements. Let $\mathfrak{g}^{p}$ be the same Lie algebra considered over $\mathbb{F}_{p}$. Let $V_{1}^{p}, \ldots, V_{n}^{p}$ be the $\mathfrak{g}^{p}$-modules which are reductions modulo $p$ of $V_{1}, \ldots, V_{n}$, respectively. If $\kappa$ is an integer and $p$ large enough with respect to $\kappa$, then one can look for solutions $I\left(z_{1}, \ldots, z_{n}\right)$ of the KZ equations in $\otimes_{i=1}^{n} V_{i}^{p} \otimes \mathbb{F}_{p}\left[z_{1}, \ldots, z_{n}\right]$. Such solutions were constructed in [SV3].

In this paper we address two questions:
A. What is the number of independent solutions constructed in [SV3] for a given $\mathbb{F}_{p}$ ?
B. How are those solutions related to the solutions over $\mathbb{C}$, that are given by hypergeometric integrals?
We answer these questions in an example in which the hypergeometric solutions are presented by one-dimensional integrals. The case of hyperelliptic integrals was considered in [V5]. The object of our study is the following joint system of differential and algebraic equations.
2.1.1. Assumptions in this paper. We fix prime numbers $p, q, p>q$, a positive integer $n$, $a$ vector $\Lambda=\left(\Lambda_{1}, \ldots, \Lambda_{n}\right) \in \mathbb{Z}_{>0}^{n}$, such that $\Lambda_{i}<q$ for all $i=1, \ldots, n$.

For $z=\left(z_{1}, \ldots, z_{n}\right)$, we study the column vectors $I(z)=\left(I_{1}(z), \ldots, I_{n}(z)\right)$ satisfying the system of differential and algebraic linear equations:

$$
\begin{equation*}
\frac{\partial I}{\partial z_{i}}=\frac{1}{q} \sum_{j \neq i} \frac{\Omega_{i j}}{z_{i}-z_{j}} I, \quad i=1, \ldots, n, \quad \Lambda_{1} I_{1}(z)+\cdots+\Lambda_{n} I_{n}(z)=0 \tag{2.2}
\end{equation*}
$$

where

$$
\Omega_{i j}=\left(\begin{array}{ccccc} 
& \vdots & & \vdots &  \tag{2.3}\\
& \vdots & & \vdots & \\
i \cdots & -\Lambda_{j} & \cdots & \Lambda_{j} & \cdots \\
& \vdots & & \vdots & \\
j \cdots & \Lambda_{i} & \cdots & -\Lambda_{i} & \cdots \\
& \vdots & & \vdots &
\end{array}\right),
$$

and all other entries are zero.
In this paper this joint system of differential and algebraic equations will be called the $K Z$ differential equations.

We will construct solutions of these KZ differential equations over $\mathbb{C}$ and over $\mathbb{F}_{p}$ and compare the properties of solutions.

Remark. The system of equations (2.2) is the system of the true KZ differential equations (2.1) with parameter $\kappa=q$, associated with the Lie algebra $\mathfrak{s l}_{2}$ and the subspace of singular vectors of weight $\sum_{i=1}^{n} \Lambda_{i}-2$ of the tensor product $V_{\Lambda_{1}} \otimes \cdots \otimes V_{\Lambda_{n}}$, where $V_{\Lambda_{i}}$ is the irreducible $\Lambda_{i}+1$ dimensional $\mathfrak{s l}_{2}$-module, up to a gauge transformation, see this example in [V2, Section 1.1].

Notice also that the assumption $\Lambda_{i}<q$ for $i=1, \ldots, n$ appears, when one is interested in differential equations for $\mathfrak{s l}_{2}$ conformal blocks with central charge $q-2$.
2.2. Solutions over $\mathbb{C}$. Consider the master function

$$
\begin{equation*}
\Phi\left(t, z_{1}, \ldots, z_{n}\right)=\prod_{a=1}^{n}\left(t-z_{a}\right)^{-\Lambda_{a} / q} \tag{2.4}
\end{equation*}
$$

and the $n$-vector of hypergeometric integrals

$$
\begin{equation*}
I^{(\gamma)}(z)=\left(I_{1}(z), \ldots, I_{n}(z)\right) \tag{2.5}
\end{equation*}
$$

where

$$
\begin{equation*}
I_{j}=\int \Phi\left(t, z_{1}, \ldots, z_{n}\right) \frac{d t}{t-z_{j}}, \quad j=1, \ldots, n \tag{2.6}
\end{equation*}
$$

The integrals $I_{j}, j=1, \ldots, n$, are over an element $\gamma$ of the first homology group of the algebraic curve with affine equation

$$
y^{q}=\left(t-z_{1}\right)^{\Lambda_{1}} \ldots\left(t-z_{n}\right)^{\Lambda_{n}}
$$

Starting from such $\gamma$, chosen for given $\left\{z_{1}, \ldots, z_{n}\right\}$, the vector $I^{(\gamma)}(z)$ can be analytically continued as a multivalued holomorphic function of $z$ to the complement in $\mathbb{C}^{n}$ to the union of the diagonal hyperplanes $z_{i}=z_{j}$.
Theorem 2.1. The vector $I^{(\gamma)}(z)$ satisfies the $K Z$ differential equations (2.2).
Theorem 2.1 is a classical statement. Much more general algebraic and differential equations satisfied by analogous multidimensional hypergeometric integrals were considered in [SV1, SV2]. Theorem 2.1 is discussed as an example in [V2, Section 1.1].

Theorem 2.2 ([V1, Formula (1.3)]). All solutions of equations (2.2) have this form. Namely, the complex vector space of solutions of the form (2.5)-(2.6) is $n$-1-dimensional.

This theorem follows from the determinant formula for multidimensional hypergeometric integrals in [V1], in particular, from [V1, Formula (1.3)].
2.3. Solutions over $\mathbb{F}_{p}$. Polynomial solutions of system (2.2), considered over the field $\mathbb{F}_{p}$, were constructed in [SV3].

For $i=1, \ldots, n$, choose positive integers $M_{i}$ such that

$$
\begin{equation*}
M_{i} \equiv-\frac{\Lambda_{i}}{q} \quad(\bmod p) \tag{2.7}
\end{equation*}
$$

that is, project $\Lambda_{i}, q$ to $\mathbb{F}_{p}$, calculate $-\frac{\Lambda_{i}}{q}$ in $\mathbb{F}_{p}$ and then choose positive integers $M_{i}$ satisfying these equations. Denote $M=\left(M_{1}, \ldots, M_{n}\right)$. Consider the master polynomial

$$
\begin{equation*}
\Phi_{p}(t, z, M):=\prod_{i=1}^{n}\left(t-z_{i}\right)^{M_{i}} \tag{2.8}
\end{equation*}
$$

and the Taylor expansion with respect to the variable $t$ of the vector of polynomials

$$
P(t, z, M):=\Phi_{p}(t, z, M)\left(\frac{1}{t-z_{1}}, \ldots, \frac{1}{t-z_{n}}\right)=\sum_{i} P^{i}(z, M) t^{i}
$$

where $P^{i}(z, M)$ are $n$-vectors of polynomials in $z_{1}, \ldots, z_{n}$ with coefficients in $\mathbb{F}_{p}$.
Theorem 2.3 ([SV3, Theorem 1.2]). For any positive integer $l$, the vector of polynomials $P^{l p-1}(z, M)$ satisfies the KZ differential equations (2.2).

Theorem 2.3 is a particular case of [SV3, Theorem 2.4]. Cf. Theorem 2.3 in $[\mathrm{K}]$. See also [V3, V4, V5].

The solutions $P^{l p-1}(z, M)$ given by this construction will be called the arithmetic solutions of the KZ differential equations (2.2).

## 3. Module of arithmetic solutions

3.1. Definition of the module. Denote $\mathbb{F}_{p}\left[z^{p}\right]:=\mathbb{F}_{p}\left[z_{1}^{p}, \ldots, z_{n}^{p}\right]$. The set of all polynomial solutions of (2.2) with coefficients in $\mathbb{F}_{p}$ is a module over the ring $\mathbb{F}_{p}\left[z^{p}\right]$ since equations (2.2) are linear and $\frac{\partial z_{i}^{p}}{\partial z_{j}}=0$ in $\mathbb{F}_{p}[z]$ for all $i, j$.

The arithmetic solutions $P^{l p-1}(z, M)$ of equations (2.2) depend on the choice of the positive integers $M=\left(M_{1}, \ldots, M_{n}\right)$ in congruences (2.7). Given $M$ satisfying (2.7), denote by

$$
\begin{equation*}
\mathcal{M}_{M}=\left\{\sum_{l} c_{l}(z) P^{l p-1}(z, M) \mid c_{l}(z) \in \mathbb{F}_{p}\left[z^{p}\right]\right\} \tag{3.1}
\end{equation*}
$$

the $\mathbb{F}_{p}\left[z^{p}\right]$-module generated by the solutions $P^{l p-1}(z, M)$.
Let $M=\left(M_{1}, \ldots, M_{n}\right)$ and $M^{\prime}=\left(M_{1}^{\prime}, \ldots, M_{n}^{\prime}\right)$ be two vectors of positive integers, each satisfying congruences (2.7). We say that $M^{\prime}>M$ if $M_{i}^{\prime} \geqslant M_{i}$ for $i=1, \ldots, n$ and there exists $i$ such that $M_{i}^{\prime}>M_{i}$.

Assume that $M^{\prime}>M$. Then $M_{i}^{\prime}=M_{i}+p N_{i}$ for some $N_{i} \in \mathbb{Z}_{\geqslant 0}$. We have

$$
\begin{equation*}
P\left(t, z, M^{\prime}\right)=\left(\prod_{i=1}^{n}\left(t-z_{i}\right)^{p N_{i}}\right) P(t, z, M)=\left(\prod_{i=1}^{n}\left(t^{p}-z_{i}^{p}\right)^{N_{i}}\right) P(t, z, M) \tag{3.2}
\end{equation*}
$$

This identity defines an embedding of modules,

$$
\begin{equation*}
\varphi_{M^{\prime}, M}: \mathcal{M}_{M^{\prime}} \hookrightarrow \mathcal{M}_{M} \tag{3.3}
\end{equation*}
$$

Namely, formula (3.2), allows us to present any solution $P^{l^{\prime} p-1}\left(z, M^{\prime}\right)$, coming from the Taylor expansion of the left-hand side, as a linear combination of the solutions $P^{l p-1}(z, M)$, coming from the Taylor expansion of the right-hand side, with coefficients in $\mathbb{F}_{p}\left[z^{p}\right]$.

Clearly, if $M^{\prime \prime}>M^{\prime}$ and $M^{\prime}>M$, then $M^{\prime \prime}>M$ and

$$
\begin{equation*}
\varphi_{M^{\prime}, M} \varphi_{M^{\prime \prime}, M^{\prime}}=\varphi_{M^{\prime \prime}, M} \tag{3.4}
\end{equation*}
$$

Theorem 3.1. For any $M^{\prime}>M$, the embedding $\varphi_{M^{\prime}, M}: \mathcal{M}_{M^{\prime}} \hookrightarrow \mathcal{M}_{M}$ is an isomorphism.
Proof. Let $v^{\prime}$ and $v$ be the greatest integers such that $v^{\prime} p-1 \leqslant \operatorname{deg}_{t} P\left(t, z, M^{\prime}\right)$ and $v p-1 \leqslant$ $\operatorname{deg}_{t} P(t, z, M)$. Comparing the coefficients in (3.2), we observe that

$$
\left[\begin{array}{c}
P^{v^{\prime} p-1}\left(z, M^{\prime}\right)  \tag{3.5}\\
\vdots \\
\vdots \\
P^{\left(v^{\prime}-v+1\right) p-1}\left(z, M^{\prime}\right)
\end{array}\right]=\left[\begin{array}{cccc}
1 & 0 & \cdots & 0 \\
* & \ddots & \ddots & \vdots \\
\vdots & \ddots & \ddots & 0 \\
* & \cdots & * & 1
\end{array}\right] \cdot\left[\begin{array}{c}
P^{v p-1}(z, M) \\
\vdots \\
\vdots \\
P^{p-1}(z, M)
\end{array}\right]
$$

where all the diagonal entries are 1's and stars denote some polynomials in $\mathbb{F}_{p}\left[z^{p}\right]$. Hence this matrix is invertible and therefore $\mathcal{M}_{M} \subset \mathcal{M}_{M^{\prime}}$. The theorem is proved.

The set of tuples $M=\left(M_{1}, \ldots, M_{n}\right)$ satisfying (2.7) has the minimal element $\bar{M}=$ $\left(\bar{M}_{1}, \ldots, \bar{M}_{n}\right)$, where $\bar{M}_{i}$ is the minimal positive integer satisfying (2.7). Hence for any $M=\left(M_{1}, \ldots, M_{n}\right)$ satisfying (2.7) we have an isomorphism

$$
\begin{equation*}
\varphi_{M, \bar{M}}: \mathcal{M}_{M} \hookrightarrow \mathcal{M}_{\bar{M}} \tag{3.6}
\end{equation*}
$$

The module $\mathcal{M}_{M}$, which does not depend on the choice of $M$, will be called the module of arithmetic solutions and denoted by $\mathcal{M}_{\Lambda}$, where $\Lambda$ see in Section 2.1.1.
3.2. The module is free. Recall $\Lambda=\left(\Lambda_{1}, \ldots, \Lambda_{n}\right) \in \mathbb{Z}_{>0}^{n}$ with $\Lambda_{i}<q$ for $i=1, \ldots, n$. Recall $\bar{M}=\left(\bar{M}_{1}, \ldots, \bar{M}_{n}\right)$ defined in Section 3.1. Denote

$$
\begin{equation*}
d_{\Lambda}:=\left[\sum_{i=1}^{n} \bar{M}_{i} / p\right], \tag{3.7}
\end{equation*}
$$

the integer part of the number $\sum_{i=1}^{n} \bar{M}_{i} / p$.
Consider the module $\mathcal{M}_{\bar{M}}$ spanned over $\mathbb{F}_{p}\left[z^{p}\right]$ by the solutions $P^{l p-1}(z, \bar{M})$, corresponding to $\bar{M}$. The range for the index $l$ is defined by the inequalities $0<l p-1 \leqslant \sum_{i=1}^{n} \bar{M}_{i}-1$. This means that $l=1, \ldots, d_{\Lambda}$.
Theorem 3.2. The solutions $P^{l p-1}(z, \bar{M}), l=1, \ldots, d_{\Lambda}$, are linearly independent over the ring $\mathbb{F}_{p}\left[z^{p}\right]$, that is, if $\sum_{l=1}^{d_{\Lambda}} c_{l}(z) P^{l p-1}(z, \bar{M})=0$ for some $c_{l}(z) \in \mathbb{F}_{p}\left[z^{p}\right]$, then $c_{l}(z)=0$ for all l.

Corollary 3.3. The module $\mathcal{M}_{\Lambda}$ of arithmetic solutions is free of rank $d_{\Lambda}$.
For $q=2$ this theorem is Theorem 3.1 in [V5]. The proof of Theorem 3.2 below is the same as the proof of [V5, Theorem 3.1].

Proof. For $l=1, \ldots, d_{\Lambda}$, the coordinates of the vector

$$
P^{l p-1}(z, \bar{M})=\left(P_{1}^{l p-1}(z, \bar{M}), \ldots, P_{n}^{l p-1}(z, \bar{M})\right)
$$

are homogeneous polynomials in $z_{1}, \ldots, z_{n}$ of degree $\sum_{i=1}^{n} \bar{M}_{i}-l p$ and

$$
P_{j}^{l p-1}(z, \bar{M})=\sum P_{j ; \ell_{1}, \ldots, \ell_{n}}^{l p-1} z_{1}^{\ell_{1}} \ldots z_{n}^{\ell_{n}}
$$

where the sum is over the elements of the set
$\Gamma_{j}^{l}=\left\{\left(\ell_{1}, \ldots, \ell_{n}\right) \in \mathbb{Z}_{\geqslant 0}^{n} \mid \sum_{s=1}^{n} \ell_{s}=\sum_{i=1}^{n} \bar{M}_{i}-l p, 0 \leqslant \ell_{j} \leqslant \bar{M}_{j}-1,0 \leqslant \ell_{i} \leqslant \bar{M}_{i}\right.$ for $\left.i \neq j\right\}$
and

$$
P_{j ; \ell_{1}, \ldots, \ell_{n}}^{l p-1}=(-1)^{\sum_{i=1}^{n} \bar{M}_{i}-l p}\binom{\bar{M}_{j}-1}{\ell_{j}} \prod_{i \neq j}\binom{\bar{M}_{i}}{\ell_{i}} \in \mathbb{F}_{p}
$$

Notice that all coefficients $P_{j ; \ell_{1}, \ldots, \ell_{n}}^{l p-1}$ are nonzero. Hence each solution $P^{l p-1}(z, \bar{M})$ is nonzero.
We show that the first coordinates $P_{1}^{l p-1}(z, \bar{M}), l=1, \ldots, d_{\Lambda}$, are linearly independent over the ring $\mathbb{F}_{p}\left[z^{p}\right]$.

Let $\bar{\Gamma}_{1}^{l} \subset \mathbb{F}_{p}^{n}$ be the image of the set $\Gamma_{1}^{l}$ under the natural projection $\mathbb{Z}^{n} \rightarrow \mathbb{F}_{p}^{n}$. The points of $\bar{\Gamma}_{1}^{l}$ are in bijective correspondence with the points of $\Gamma_{1}^{l}$, since $\bar{M}_{i}<p$ for all $i$. Any two sets $\bar{\Gamma}_{1}^{l}$ and $\bar{\Gamma}_{1}^{l^{\prime}}$ do not intersect, if $l \neq l^{\prime}$.

For any $l$ and any nonzero polynomial $c_{l}(z) \in \mathbb{F}_{p}\left[z^{p}\right]$, consider the nonzero polynomial $c_{l}(z) P_{1}^{l p-1}(z, \bar{M}) \in \mathbb{F}_{p}\left[z_{1}, \ldots, z_{n}\right]$ and the set $\Gamma_{1, c_{l}}^{l}$ of vectors $\vec{\ell} \in \mathbb{Z}^{n}$ such that the monomial $z_{1}^{\ell_{1}} \ldots z_{n}^{\ell_{n}}$ enters $c_{l}(z) P_{1}^{l p-1}(z, \bar{M})$ with nonzero coefficient. Then the natural projection of $\Gamma_{1, c_{l}}^{l}$ to $\mathbb{F}_{p}^{n}$ coincides with $\bar{\Gamma}_{1}^{l}$. Hence the polynomials $P_{1}^{l}(z, \bar{M}), l=1, \ldots, d_{\Lambda}$, are linearly independent over the ring $\mathbb{F}_{p}\left[z^{p}\right]$.
3.3. Fusion of arithmetic solutions. Consider solutions $I\left(z_{1}, \ldots, z_{n}\right)$ of the KZ differential equations over $\mathbb{C}$ with values in some tensor product $V_{1} \otimes \cdots \otimes V_{n}$. Assume that $z_{1}, \ldots, z_{n}$ tend to some limit $\tilde{z}_{1}, \ldots, \tilde{z}_{\tilde{n}}$, in which some groups of the points $z_{1}, \ldots, z_{n}$ collide. It is well-known that under this limit the leading term of asymptotics of solutions satisfies the KZ equations with respect to $\tilde{z}_{1}, \ldots, \tilde{z}_{\tilde{n}}$ with values in the tensor product $\tilde{V}_{1} \otimes \cdots \otimes \tilde{V}_{\tilde{n}}$, where each $\tilde{V}_{j}$ is the tensor product of some of $V_{1}, \ldots, V_{n}$.

In this section we show that the arithmetic solutions of the KZ equations have a similar functorial property but even simpler.

Namely, let $\Lambda=\left(\Lambda_{1}, \ldots, \Lambda_{n}\right) \in \mathbb{Z}_{>0}^{n}$ with $\Lambda_{i}<q$ for $i=1, \ldots, n$, and $\tilde{\Lambda}=\left(\tilde{\Lambda}_{1}, \ldots, \tilde{\Lambda}_{\tilde{n}}\right) \in$ $\mathbb{Z}_{>0}^{\tilde{n}}$ with $\tilde{\Lambda}_{j}<q$ for $j=1, \ldots, \tilde{n}$.

Assume that there is a partition $\{1, \ldots, n\}=I_{1} \cup \cdots \cup I_{\tilde{n}}$ such that

$$
\begin{equation*}
\sum_{i \in I_{j}} \Lambda_{i}=\tilde{\Lambda}_{j}, \quad j=1, \ldots, \tilde{n} \tag{3.8}
\end{equation*}
$$

We say that $\tilde{\Lambda}$ is a fusion of $\Lambda$.
Recall the modules of arithmetic solutions $\mathcal{M}_{\Lambda}$ and $\mathcal{M}_{\tilde{\Lambda}}$. We define an epimorphism of modules,

$$
\begin{equation*}
\psi_{\Lambda, \tilde{\Lambda}}: \mathcal{M}_{\Lambda} \rightarrow \mathcal{M}_{\tilde{\Lambda}} \tag{3.9}
\end{equation*}
$$

as follows.
Let $M=\left(M_{1}, \ldots, M_{n}\right)$ be a vector of positive integers such that $M_{i} \equiv-\Lambda_{i} / q \bmod p$ for $i=1, \ldots, n$. Define $\tilde{M}=\left(\tilde{M}_{1}, \ldots, \tilde{M}_{\tilde{n}}\right)$ by the formula

$$
\tilde{M}_{j}=\sum_{i \in I_{j}} M_{i}, \quad j=1, \ldots, \tilde{n}
$$

Then $\tilde{M}_{j} \equiv-\tilde{\Lambda}_{j} / q(\bmod p)$ for $j=1, \ldots, \tilde{n}$.
Consider the module $\mathcal{M}_{M}$ generated by the solutions $\left(P^{l p-1}(z, M)\right)_{l}$, which are $n$-vectors of polynomials in $z_{1}, \ldots, z_{n}$. Consider the module $\mathcal{M}_{\tilde{M}}$ generated by the solutions $\left(P^{l p-1}(\tilde{z}, \tilde{M})\right)_{l}$, which are $\tilde{n}$-vectors of polynomials in $\tilde{z}_{1}, \ldots, \tilde{z}_{\tilde{n}}$.

Define the module homomorphism

$$
\psi_{\Lambda, \tilde{\Lambda}}: \mathcal{M}_{\Lambda}=\mathcal{M}_{M} \rightarrow \mathcal{M}_{\tilde{M}}=\mathcal{M}_{\tilde{\Lambda}}
$$

as the map which sends a generator $P^{l p-1}(z, M)$ to the generator $P^{l p-1}(\tilde{z}, \tilde{M})$.
On the level of coordinates of these vectors, the vectors $P^{l p-1}(z, M)$ and $P^{l p-1}(\tilde{z}, \tilde{M})$ have the following relation. Choose a coordinate $P_{a}^{l p-1}(z, M)$ of $P^{l p-1}(z, M)$, replace in it every $z_{i}$ with $\tilde{z}_{j}$ if $i \in I_{j}$, then the resulting polynomial $P_{a}^{l p-1}(z(\tilde{z}), M)$ equals the $b$-th coordinate $P_{b}^{l p-1}(\tilde{z}, \tilde{M})$ of $P^{l p-1}(\tilde{z}, \tilde{M})$ if $a \in I_{b}$.

It is easy to see that the homomorphism $\mathcal{M}_{\Lambda} \rightarrow \mathcal{M}_{\tilde{\Lambda}}$, does not depend of the choice of $M$ solving congruences (2.7).

Also it is easy to see that if $\tilde{\Lambda}$ is a fusion of $\Lambda$ and $\hat{\Lambda}$ is a fusion of $\tilde{\Lambda}$, then $\hat{\Lambda}$ is a fusion of $\Lambda$ and

$$
\begin{equation*}
\psi_{\tilde{\Lambda}, \hat{\Lambda}} \psi_{\Lambda, \tilde{\Lambda}}=\psi_{\Lambda, \hat{\Lambda}} \tag{3.10}
\end{equation*}
$$

## 4. Binomial coefficients modulo $p$

### 4.1. Lucas' theorem.

Theorem 4.1 ([L]). For nonnegative integers $m$ and $n$ and a prime $p$, the following congruence relation holds:

$$
\begin{equation*}
\binom{n}{m} \equiv \prod_{i=0}^{k}\binom{n_{i}}{m_{i}} \quad(\bmod p) \tag{4.1}
\end{equation*}
$$

where $m=m_{k} p^{k}+m_{k-1} p^{k-1}+\cdots+m_{1} p+m_{0}$ and $n=n_{k} p^{k}+n_{k-1} p^{k-1}+\cdots+n_{1} p+n_{0}$ are the base $p$ expansions of $m$ and $n$ respectively. This uses the convention that $\binom{n}{m}=0$ if $n<m$.

On Lucas' theorem see for example, [Me].
4.2. Factorization of $\binom{-1 / q}{m}$ modulo $p$. In the next sections we will use the binomial coefficients $\binom{-1 / q}{m}$ modulo $p$. Recall that $p>q$ are prime numbers. Denote by $d$ the order of $p$ modulo $q$, that is the least integer $k$ such that $p^{k} \equiv 1(\bmod q)$.

Let

$$
\begin{equation*}
\frac{p^{d}-1}{q}=A_{0}+A_{1} p+A_{2} p^{2}+\cdots+A_{d-1} p^{d-1} \tag{4.2}
\end{equation*}
$$

be the base $p$ expansion of $\left(p^{d}-1\right) / q$.
Theorem 4.2. Let $m$ be a positive integer with the base $p$ expansion given by

$$
\begin{equation*}
m=m_{b} p^{b}+m_{b-1} p^{b-1}+\cdots+m_{1} p+m_{0} \tag{4.3}
\end{equation*}
$$

Then the binomial coefficient $\binom{-1 / q}{m}$ is well-defined modulo $p$ and the following congruence holds

$$
\begin{equation*}
\binom{-1 / q}{m} \equiv \prod_{j \geqslant 0} \prod_{i=0}^{d-1}\binom{A_{i}}{m_{d j+i}} \quad(\bmod p) \tag{4.4}
\end{equation*}
$$

The case $q=2$ was considered in [V5].
Proof. The proof of this theorem is based on Lucas' theorem and the following three lemmas.
Lemma 4.3. For any positive integer $c$

$$
\begin{equation*}
\frac{p^{d c}-1}{q}=\sum_{j=0}^{c-1}\left(\sum_{i=0}^{d-1} A_{i} p^{i}\right) p^{j d} \tag{4.5}
\end{equation*}
$$

Proof. We have

$$
\frac{p^{d c}-1}{q}=\frac{\left(p^{d}-1\right)\left(p^{d(c-1)}+\cdots+p+1\right)}{q}=\sum_{j=0}^{c-1}\left(\sum_{i=0}^{d-1} A_{i} p^{i}\right) p^{j d}
$$

where we use (4.2) to obtain the last equality.
Lemma 4.4. Let $m$ be a positive integer with the base $p$ expansion given by (4.3). If $c$ is $a$ positive integer such that $d c>b$, then

$$
\begin{equation*}
\binom{\left(p^{d c}-1\right) / q}{m} \equiv \prod_{j=0}^{c-1} \prod_{i=0}^{d-1}\binom{A_{i}}{m_{d j+i}} \quad(\bmod p) \tag{4.6}
\end{equation*}
$$

Proof. The lemma follows from Theorem 4.1 and Lemma 4.3.
Given a prime $p$, define the $p$-adic norm on $\mathbb{Q}$ as follows. Any nonzero rational number $x$ can be represented uniquely by $x=p^{\ell}(r / s)$, where $r$ and $s$ are integers not divisible by $p$. Set $|x|_{p}=p^{-\ell}$. Also define the $p$-adic value $|0|_{p}=0$. We call $p^{\ell}(r / s)$ the $p$-reduced presentation of $x$.

Lemma 4.5. Let $m$ be a positive integer with the base $p$ expansion given by (4.3). Then the following statements hold.
(i) The binomial coefficient $\binom{-1 / q}{m}$ is well-defined modulo $p$.
(ii) For any positive integer $c$ such that $d c>b+1$ we have

$$
\begin{equation*}
\binom{-1 / q}{m} \equiv\binom{\left(p^{d c}-1\right) / q}{m} \quad(\bmod p) \tag{4.7}
\end{equation*}
$$

Proof. We have

$$
\begin{equation*}
\binom{-1 / q}{m}=(-1 / q)^{m} \prod_{\ell=0}^{m-1} \frac{q \ell+1}{\ell+1} \tag{4.8}
\end{equation*}
$$

We also have

$$
\begin{equation*}
\binom{\left(p^{d c}-1\right) / q}{m}=(-1 / q)^{m} \prod_{\ell=0}^{m-1} \frac{q \ell+1-p^{d c}}{\ell+1}=(-1 / q)^{m} \prod_{\ell=0}^{m-1} \frac{q \ell+1}{\ell+1}+\ldots \tag{4.9}
\end{equation*}
$$

For each $\ell=0, \ldots, m-1$ we have $\left|\frac{q \ell+1-p^{d c}}{\ell+1}\right|_{p}=\left|\frac{q \ell+1}{\ell+1}\right|_{p}$, since $q \ell+1<q m<q p^{b+1}<$ $p^{b+2} \leqslant p^{d c}$.

By the same reasoning for every $\ell$ the power of $p$ in the $p$-reduced presentation of the number $\frac{p^{d c}}{\ell+1}$ is greater than the power of $p$ in the $p$-reduced presentation of $\frac{q \ell+1}{\ell+1}$. This observation implies that in the right-hand side of (4.9) the power of $p$ in the $p$-reduced presentation of terms denoted by '...' is greater than the corresponding power in the $p$ reduced presentation of $(-1 / q)^{m} \prod_{\ell=0}^{m-1} \frac{q \ell+1}{\ell+1}$. Since the left-hand side of (4.9) is an integer, we conclude that in the $p$-reduced presentation of the binomial coefficient $\binom{-1 / q}{m}$ the power of $p$ is non-negative, i.e. $\binom{-1 / q}{m}$ is well-defined modulo $p$. This gives part (i). Moreover, the following congruence holds

$$
\begin{equation*}
\binom{\left(p^{d c}-1\right) / q}{m} \equiv(-1 / q)^{m} \prod_{\ell=0}^{m-1} \frac{q \ell+1}{\ell+1} \quad(\bmod p) \tag{4.10}
\end{equation*}
$$

Formulas (4.8) and (4.10) give (4.7).
Theorem 4.2 follows from Lemmas 4.4 and 4.5.
4.3. Factorization of $\binom{u / v}{m}$ modulo $p$. Here are some generalizations of Theorem 4.2. Let $p$ be prime. Let $u, v$ be relatively prime integers with $0<u, v<p$.

Assume that there exists a positive integer $\ell$ such that

$$
\begin{equation*}
p^{\ell}+u \equiv 0 \quad(\bmod v) \tag{4.11}
\end{equation*}
$$

Let

$$
\begin{equation*}
\frac{p^{\ell}+u}{v}=B_{0}+B_{1} p+B_{2} p^{2}+\cdots+B_{\ell-1} p^{\ell-1} \tag{4.12}
\end{equation*}
$$

be the base $p$ expansion of $\left(p^{\ell}+u\right) / v$.
Let $\varphi(v)$ be the number of positive divisors of $v$ and

$$
\begin{equation*}
\frac{p^{\varphi(v)}-1}{v}=C_{0}+C_{1} p+C_{2} p^{2}+\cdots+C_{\varphi(v)-1} p^{\varphi(v)-1} \tag{4.13}
\end{equation*}
$$

the base $p$ expansion of $\left(p^{\varphi(v)}-1\right) / v$.

Let $m$ be a positive integer with the base $p$ expansion

$$
m=m_{b} p^{b}+m_{b-1} p^{b-1}+\cdots+m_{1} p+m_{0}
$$

Theorem 4.6. Under these assumptions the binomial coefficient $\binom{u / v}{m}$ is well-defined modulo $p$ and the following congruence holds:

$$
\begin{equation*}
\binom{u / v}{m} \equiv\left[\prod_{i=0}^{\ell-1}\binom{B_{i}}{m_{i}}\right] \cdot\left[\prod_{j \geqslant 0} \prod_{i=0}^{\varphi(v)-1}\binom{C_{i}}{m_{\ell+j \varphi(v)+i}}\right] \quad(\bmod p) \tag{4.14}
\end{equation*}
$$

Proof. The proof of Theorem 4.6 is parallel to the proof of Theorem 4.2 and follows from the analysis of the base $p$ expansion of the integers of the form

$$
\frac{p^{k \varphi(v)+\ell}+u}{v}=p^{\ell} \frac{p^{k \varphi(v)}-1}{v}+\frac{p^{\ell}+u}{v}
$$

for $k \in \mathbb{Z}_{\geqslant 0}$.
In the same way we prove the following statement.
Theorem 4.7. Let $p$ be a prime. Let $u, v$ be integers such that $p, u, v$ are pairwise relatively prime. Let

$$
\begin{equation*}
\frac{u}{v}=A_{0}+A_{1} p+A_{2} p^{2}+\ldots, \quad 0 \leqslant A_{i}<p \quad \text { for } i \in \mathbb{Z}_{\geqslant 0} \tag{4.15}
\end{equation*}
$$

be the $p$-adic presentation of $u / v$. Let $m$ be a positive integer with the base $p$ expansion

$$
m=m_{b} p^{b}+m_{b-1} p^{b-1}+\cdots+m_{1} p+m_{0}
$$

Then

$$
\begin{equation*}
\binom{u / v}{m} \equiv \prod_{i \geqslant 0}\binom{A_{i}}{m_{i}} \quad(\bmod p) \tag{4.16}
\end{equation*}
$$

4.4. Map $\eta$. Recall that $p$ and $q$ be prime numbers, $p>q$, and $d$ the order of $p$ modulo $q$. Define the map

$$
\begin{equation*}
\eta:\{1, \ldots, q-1\} \rightarrow\{1, \ldots, q-1\}, \quad a \mapsto \eta(a) \tag{4.17}
\end{equation*}
$$

the division by $p$ modulo $q$. More precisely, $\eta(a)$ is defined by the conditions

$$
\begin{equation*}
\eta(a) p \equiv a \quad(\bmod q), \quad 1 \leqslant \eta(a)<q . \tag{4.18}
\end{equation*}
$$

Denote $\eta^{(s)}=\eta \circ \eta \circ \cdots \circ \eta$ the $s$-th iteration of $\eta$. We have $\eta^{(s+d)}=\eta^{(s)}$. Define

$$
\begin{equation*}
a_{s}:=\eta^{(s)}(1) \tag{4.19}
\end{equation*}
$$

We have $a_{s+d}=a_{s}$ and $a_{0}=1$.
The integer $a_{1}$ will play a special role in the next sections. It is the unique integer such that

$$
\begin{equation*}
1 \leqslant a_{1}<q \quad \text { and } \quad q \mid\left(a_{1} p-1\right) \tag{4.20}
\end{equation*}
$$

Example 4.8. Let $p=5, q=3$. The order $d$ of 5 modulo 3 is 2. The map $\eta:\{1,2\} \rightarrow\{2,1\}$ is the transposition. We have $a_{0}=1, a_{1}=2, a_{2}=1$.
4.5. Formulas for $A_{s}$. Recall the base $p$ expansion

$$
\begin{equation*}
\frac{p^{d}-1}{q}=A_{0}+A_{1} p+A_{2} p^{2}+\cdots+A_{d-1} p^{d-1} . \tag{4.21}
\end{equation*}
$$

Lemma 4.9. The integers $A_{s}$ are given by the formula

$$
\begin{equation*}
A_{s}=\frac{a_{s+1} p-a_{s}}{q}, \quad s=0, \ldots, d-1 . \tag{4.22}
\end{equation*}
$$

Moreover, $A_{s}>0$ for $s=0, \ldots, d-1$.
Proof. We have

$$
\begin{equation*}
0<\frac{a_{s+1} p-a_{s}}{q}<p \tag{4.23}
\end{equation*}
$$

for every $s$. Indeed, since $1 \leqslant a_{s} \leqslant q-1$ and $p>q$, we have

$$
0<\frac{p-a_{s}}{q} \leqslant \frac{a_{s+1} p-a_{s}}{q}<\frac{a_{s+1} p}{q}<p .
$$

We show that (4.21) holds for $A_{s}$ given by (4.22). Indeed
$q\left(A_{0}+A_{1} p+\cdots+A_{d-1} p^{d-1}\right)=q\left(\frac{a_{1} p-1}{q}+\frac{a_{2} p-a_{1}}{q} p+\cdots+\frac{p-a_{d-1}}{q} p^{d-1}\right)=p^{d}-1$.

## 5. Solutions for the case $\Lambda_{i}=1, i=1, \ldots, n$

In Sections 5, 6, and 9 we study the arithmetic solutions of the KZ equations over $\mathbb{F}_{p}$ in the case $\Lambda_{i}=1, i=1, \ldots, n$.
5.1. Basis of arithmetic solutions. Recall that $p, q$ are prime numbers, $p>q$. Assume that

$$
\begin{equation*}
n=k q+1 \tag{5.1}
\end{equation*}
$$

for some positive integer $k$ and

$$
\begin{equation*}
\Lambda=(1, \ldots, 1) \in \mathbb{Z}^{n} \tag{5.2}
\end{equation*}
$$

The minimal positive solution of the system of the congruences

$$
\begin{equation*}
M_{i} \equiv-1 / q \quad(\bmod p), \quad i=1, \ldots, n \tag{5.3}
\end{equation*}
$$

is the vector

$$
\begin{equation*}
\bar{M}=\left(\bar{M}_{1}, \ldots, \bar{M}_{n}\right):=\left(\left(a_{1} p-1\right) / q, \ldots,\left(a_{1} p-1\right) / q\right) \tag{5.4}
\end{equation*}
$$

where $a_{1}$ is introduced in (4.20).
Recall that the rank of the module of arithmetic solutions $\mathcal{M}_{\Lambda}$ in this case equals

$$
\begin{equation*}
d_{\Lambda}=\left[n\left(a_{1} p-1\right) / q p\right], \tag{5.5}
\end{equation*}
$$

see Corollary 3.3.
Lemma 5.1. If $p>n$, then $d_{\Lambda}=a_{1} k$.

Proof. We have

$$
d_{\Lambda}=\left[n \frac{a_{1} p-1}{q p}\right]=\left[\frac{n a_{1}}{q}-\frac{n}{q p}\right]=\left[k a_{1}+\frac{a_{1}}{q}-\frac{n}{p q}\right] .
$$

Notice that $1 / q \leqslant a_{1} / q<1$ and $n / q p<1 / q$. Hence $d_{\Lambda}=a_{1} k$.
The master polynomial is

\Phi_{p}(x, z, \bar{M})=\prod_{i=1}^{n}\left(x-z_{i}\right)^{\left(a_{1} p-1\right) / q} \tag{5.6}
\end{equation*}
$$

The $n$-vector of polynomials $P(x, z, \bar{M})$ is

P(x, z, \bar{M})=\left(P_{1}(x, z, \bar{M}), \ldots, P_{n}(x, z, \bar{M})\right), \quad P_{j}(x, z, \bar{M})=\frac{\Phi_{p}(x, z, \bar{M})}{x-z_{j}} \tag{5.7}
\end{equation*}
$$

with the Taylor expansion

\begin{equation*}
P(x, z, \bar{M})=\sum_{i=0}^{n\left(a_{1} p-1\right) / q-1} P^{i}(z, \bar{M}) x^{i}, \quad P^{i}(z, \bar{M})=\left(P_{1}^{i}(z, \bar{M}), \ldots, P_{n}^{i}(z, \bar{M})\right) \tag{5.8}
\end{equation*}
$$

The coefficients $P^{i}(z, \bar{M})$ with $i=l p-1$ are solutions of (2.2). There are $k a_{1}$ of them. They are linearly independent by Theorem 3.2. Denote them

I^{m}(z)=\left(I_{1}^{m}(z), \ldots, I_{n}^{m}(z)\right), \quad I^{m}(z):=P^{\left(a_{1} k-m\right) p+p-1}(z, \bar{M}) \tag{5.9}

for $m=1, \ldots, a_{1} k$. The coordinates of the $n$-vector of polynomials $I^{m}(z)$ are homogeneous polynomials in $z$ of degree

$$
\left(a_{1} p-1\right) / q+(m-1) p-k .
$$

For example, $I^{1}=P^{a_{1} k p-1}(z, \bar{M})$ is a homogeneous polynomial in $z$ of degree $\left(a_{1} p-1\right) / q-k$, and $I^{a_{1} k}=P^{p-1}(z, \bar{M})$ is a homogeneous polynomial in $z$ of degree $\left(a_{1} p-1\right) / q-k+\left(a_{1} k-1\right) p$.
5.2. Change of the basis of $\mathcal{M}_{\Lambda}$. For future use we introduce a new basis of $\mathcal{M}_{\Lambda}$. For $m=1, \ldots, a_{1} k$, define

J^{2}(z) & =I^{1}(z) z_{1}^{p}\binom{a_{1} k-1}{a_{1} k-2}+I^{2}(z) \\
J^{3}(z) & =I^{1}(z) z_{1}^{2 p}\binom{a_{1} k-1}{a_{1} k-3}+I^{2}(z) z_{1}^{p}\binom{a_{1} k-2}{a_{1} k-3}+I^{3}(z),
\end{aligned}
$$

and so on. The coordinates of the $n$-vector of polynomials $J^{m}(z)$ are homogeneous polynomials in $z$ of degree

\left(a_{1} p-1\right) / p+(m-1) p-k .
$$

Lemma 5.2. The $n$-vectors of polynomials $J^{m}(z)$ belong to the module $\mathcal{M}_{\Lambda}$ of arithmetic solutions and form a basis of $\mathcal{M}_{\Lambda}$.

The solutions $J^{m}(z)$ of the KZ equations (2.2) can be defined as coefficients of the Taylor expansion of a suitable $n$-vector of polynomials similarly to the definition of solutions $I^{m}(z)$ in (5.9).

Namely, change $x$ to $x+z_{1}$ in (5.6) to obtain the polynomial

Consider the associated $n$-vector of polynomials

\tilde{P}(x, z)=\tilde{\Phi}_{p}(x, z)\left(\frac{1}{x}, \frac{1}{x+z_{1}-z_{2}}, \ldots, \frac{1}{x+z_{1}-z_{n}}\right) \tag{5.12}
\end{equation*}
$$

and its Taylor expansion

\begin{equation*}
\tilde{P}(x, z)=\sum_{i=0}^{n\left(a_{1} p-1\right) / q-1} \tilde{P}^{i}(z) x^{i}, \quad \tilde{P}^{i}(z) \in \mathbb{F}_{p}[z]^{n} \tag{5.13}
\end{equation*}
$$

Lemma 5.3 ([V5, Lemma 5.2]). For $m=1, \ldots, a_{1} k$, we have

\begin{equation*}
J^{m}(z)=\tilde{P}^{\left(a_{1} k-m\right) p+p-1}(z) . \tag{5.14}
\end{equation*}
$$

5.3. Change of variables in $J^{m}(z)$.

Lemma 5.4. For $m=1, \ldots, a_{1} k$, the homogeneous polynomial $J^{m}(z)$ can be written as $a$ homogeneous polynomial in variables $z_{2}-z_{1}, z_{3}-z_{1}, \ldots, z_{n}-z_{1}$, see (5.11) and (5.12).

Hence we may pull out from the polynomial $J^{m}(z)$ the factor $\left(z_{2}-z_{1}\right)^{\left(a_{1} p-1\right) / q+(m-1) p-k}$ and present $J^{m}(z)$ in the form

J^{m}(z)=\left(z_{2}-z_{1}\right)^{\left(a_{1} p-1\right) / q+(m-1) p-k} K^{m}(\lambda), \tag{5.15}
\end{equation*}
$$

where $\lambda:=\left(\lambda_{3}, \ldots, \lambda_{n}\right)$,

$$
\begin{equation*}
\lambda_{i}:=\frac{z_{i}-z_{1}}{z_{2}-z_{1}}, \quad i=3, \ldots, n \tag{5.16}
\end{equation*}
$$

and $K^{m}(\lambda)$ is a suitable $n$-vector of polynomials in $\lambda$.
Another way to define the $n$-vector $K^{m}(\lambda)$ is as follows.
Consider the polynomial

\end{equation*}

and the associated $n$-vector of polynomials

\hat{P}(x, \lambda)=\hat{\Phi}_{p}(x, \lambda)\left(\frac{1}{x}, \frac{1}{x-1}, \frac{1}{x-\lambda_{3}}, \ldots, \frac{1}{x-\lambda_{n}}\right) \tag{5.18}
\end{equation*}
$$

with Taylor expansion

$$
\begin{equation*}
\hat{P}(x, \lambda)=\sum_{i=0}^{n\left(a_{1} p-1\right) / q-1} \hat{P}^{i}(\lambda) x^{i}, \quad \hat{P}^{i}(\lambda) \in \mathbb{F}_{p}[\lambda]^{n} \tag{5.19}
\end{equation*}
$$

Lemma 5.5. For $m=1, \ldots, a_{1} k$, we have

$$
\begin{equation*}
K^{m}(\lambda)=\hat{P}^{\left(a_{1} k-m\right) p+p-1}(\lambda), \tag{5.20}
\end{equation*}
$$

cf. formulas (5.9) and (5.14).
5.4. Formula for $K^{m}(\lambda)$. For $m=1, \ldots, a_{1} k$, denote

\begin{align*}
\Delta^{m}=\left\{\left(\ell_{3}, \ldots, \ell_{n}\right) \in \mathbb{Z}_{\geqslant 0}^{n-2} \mid 0\right. & \leqslant \sum_{i=3}^{n} \ell_{i}+k-(m-1) p \leqslant\left(a_{1} p-1\right) / q  \tag{5.21}\\
\ell_{j} & \left.\leqslant\left(a_{1} p-1\right) / q \text { for } j=3, \ldots, n\right\} .
\end{align*}
$$

Theorem 5.6. For $m=1, \ldots, a_{1} k$, we have

K^{m}(\lambda)=\sum_{\left(\ell_{3}, \ldots, \ell_{n}\right) \in \Delta^{m}} K_{\ell_{3}, \ldots, \ell_{n}}^{m}(\lambda) \tag{5.22}
\end{equation*}
$$

where

$$
\begin{align*}
& K_{\ell_{3}, \ldots, \ell_{n}}^{m}(\lambda)=(-1)^{\left(a_{1} p-1\right) / q+(m-1) p-k}\binom{\left(a_{1} p-1\right) / q}{\sum_{i=3}^{n} \ell_{i}+k-(m-1) p}  \tag{5.23}\\
& \quad \times \prod_{i=3}^{n}\binom{\left(a_{1} p-1\right) / q}{\ell_{i}} \lambda_{3}^{\ell_{3}} \ldots \lambda_{n}^{\ell_{n}}\left(1,-q\left(\sum_{i=3}^{n} \ell_{i}+k\right), q \ell_{3}+1, \ldots, q \ell_{n}+1\right)
\end{align*}
$$

modulo $p$. In particular, all coefficients $K_{\ell_{3}, \ldots, \ell_{n}}^{m}(\lambda)$ are nonzero.
Proof. We have

$$

Expressing $\ell_{2}$ from the conditions defining $\Delta$ we write

& K_{1}^{m}(\lambda)=(-1)^{\left(a_{1} p-1\right) / q+(m-1) p-k} \\
& \quad \times \sum_{\Delta^{m}}\binom{\left(a_{1} p-1\right) / q}{\sum_{i=3}^{n} \ell_{i}-(m-1) p+k} \prod_{i=3}^{n}\binom{\left(a_{1} p-1\right) / q}{\ell_{i}} \lambda_{3}^{\ell_{3}} \ldots \lambda_{n}^{\ell_{n}}
\end{aligned}
$$

Similarly we have

K_{2}^{m}(\lambda)=(-1)^{\left(a_{1} p-1\right) / q+(m-1) p-k} \sum_{\Delta^{\prime}}\binom{\left(a_{1} p-1\right) / q-1}{\ell_{2}} \prod_{i=3}^{n}\binom{\left(a_{1} p-1\right) / q}{\ell_{i}} \lambda_{3}^{\ell_{3}} \ldots \lambda_{n}^{\ell_{n}},
$$

where

$$
\begin{aligned}
& \Delta^{\prime}=\left\{\left(\ell_{2}, \ldots, \ell_{n}\right) \in \mathbb{Z}_{\geqslant 0}^{n-1} \mid \sum_{i=2}^{n} \ell_{i}=\left(a_{1} p-1\right) / q+(m-1) p-k\right. \\
&\left.\ell_{2} \leqslant\left(a_{1} p-1\right) / q-1 \text { and } \ell_{i} \leqslant\left(a_{1} p-1\right) / q \text { for } i>2\right\} .
\end{aligned}
$$

Expressing $\ell_{2}$ from the conditions defining $\Delta^{\prime}$ we write

K_{2}^{m}(\lambda)= & (-1)^{\left(a_{1} p-1\right) / q+(m-1) p-k} \\
& \times \sum_{\Delta^{m}}\binom{\left(a_{1} p-1\right) / q-1}{\sum_{i=3}^{n} \ell_{i}-(m-1) p+k-1} \prod_{i=3}^{n}\binom{\left(a_{1} p-1\right) / q}{\ell_{i}} \lambda_{3}^{\ell_{3}} \ldots \lambda_{n}^{\ell_{n}} \\
= & (-1)^{\left(a_{1} p-1\right) / q+(m-1) p-k} \frac{\sum_{i=3}^{n} \ell_{i}-(m-1) p+k}{\left(a_{1} p-1\right) / q} \\
& \times \sum_{\Delta^{m}}\binom{\left(a_{1} p-1\right) / q}{\sum_{i=3}^{n} \ell_{i}-(m-1) p+k} \prod_{i=3}^{n}\binom{\left(a_{1} p-1\right) / q}{\ell_{i}} \lambda_{3}^{\ell_{3}} \ldots \lambda_{n}^{\ell_{n}}
\end{aligned}
$$

For $j=3, \ldots, n$ we have

K_{j}^{m}(\lambda)=(-1)^{\left(a_{1} p-1\right) / q+(m-1) p-k} \sum_{\Delta^{\prime \prime}}\binom{\left(a_{1} p-1\right) / q-1}{\ell_{j}} \prod_{\substack{i=2 \\ i \neq j}}^{n}\binom{\left(a_{1} p-1\right) / q}{\ell_{i}} \lambda_{3}^{\ell_{3}} \ldots \lambda_{n}^{\ell_{n}}
$$

where

$$
\begin{array}{r}
\Delta^{\prime \prime}=\left\{\left(\ell_{2}, \ldots, \ell_{n}\right) \in \mathbb{Z}_{\geqslant 0}^{n-1} \mid \sum_{i=2}^{n} \ell_{i}=\left(a_{1} p-1\right) / q+(m-1) p-k\right. \\
\left.\ell_{j} \leqslant\left(a_{1} p-1\right) / q-1 \text { and } \ell_{i} \leqslant\left(a_{1} p-1\right) / q \text { for } i \neq j\right\}
\end{array}
$$

Expressing $\ell_{2}$ from the conditions defining $\Delta^{\prime \prime}$ we write

$$
\begin{aligned}
& K_{j}^{m}(\lambda)=(-1)^{\left(a_{1} p-1\right) / q+(m-1) p-k} \\
& \quad \times \sum_{\Delta^{m}}\binom{\left(a_{1} p-1\right) / q}{\sum_{i=3}^{n} \ell_{i}-(m-1) p+k}\binom{\left(a_{1} p-1\right) / q-1}{\ell_{j}} \prod_{\substack{i=3 \\
i \neq j}}^{n}\binom{\left(a_{1} p-1\right) / q}{\ell_{i}} \lambda_{3}^{\ell_{3}} \ldots \lambda_{n}^{\ell_{n}} \\
& \quad=(-1)^{\left(a_{1} p-1\right) / q+(m-1) p-k}\left(1-\frac{\ell_{j} q}{a_{1} p-1}\right) \\
& \quad \times \sum_{\Delta^{m}}\binom{\left(a_{1} p-1\right) / q}{\sum_{i=3}^{n} \ell_{i}-(m-1) p+k} \prod_{i=3}^{n}\binom{\left(a_{1} p-1\right) / q}{\ell_{i}} \lambda_{3}^{\ell_{3}} \ldots \lambda_{n}^{\ell_{n}}
\end{aligned}
$$

The congruences

$$
\begin{aligned}
\frac{\sum_{i=3}^{n} \ell_{i}-(m-1) p+k}{\left(a_{1} p-1\right) / q} & \equiv-q\left(\sum_{i=3}^{n} \ell_{i}+k\right) \quad(\bmod p) \\
1-\frac{\ell_{j} q}{a_{1} p-1} & \equiv q \ell_{j}+1 \quad(\bmod p)
\end{aligned}
$$

allow us to rewrite $K_{j}^{m}(\lambda), j=2, \ldots, n$, in the form indicated in the theorem.
5.5. Example. For $p=5, q=3, n=4$, the module $\mathcal{M}_{\Lambda}$ of arithmetic solutions is twodimensional and is generated by solutions $J^{1}$ and $J^{2}$ which are 4-vectors, whose coefficients are homogeneous polynomials in $z_{1}, z_{2}, z_{3}, z_{4}$ of degrees 2 and 7 , respectively.

The corresponding 4 -vectors $K^{1}$ and $K^{2}$ are given by the formulas

K^{1}\left(\lambda_{3}, \lambda_{4}\right) & =(3,1,3,3)+(4,1,1,4) \lambda_{3}+(4,1,4,1) \lambda_{4} \\
& +(3,3,1,3) \lambda_{3}^{2}+(4,4,1,1) \lambda_{3} \lambda_{4}+(3,3,3,1) \lambda_{4}^{2} \\
K^{2}\left(\lambda_{3}, \lambda_{4}\right) & =(2,0,0,3) \lambda_{3}^{2} \lambda_{4}+(1,0,2,2) \lambda_{3}^{2} \lambda_{4}^{2}+(2,0,3,0) \lambda_{3} \lambda_{4}^{3} \\
& +(1,2,0,2) \lambda_{3}^{3} \lambda_{4}^{2}+(1,2,2,0) \lambda_{3}^{2} \lambda_{4}^{3}+(2,3,0,0) \lambda_{3}^{3} \lambda_{4}^{3}
\end{aligned}
$$

## 6. Cartier map

### 6.1. Matrices and semilinear algebra, [AH].

6.1.1. Bases, matrices, and linear operators. Let $W$ be a vector space over a field $\mathbb{K}$ with basis $\mathcal{C}=\left\{w_{1}, \ldots, w_{n}\right\}$. Any $w \in W$ is expressible as $w=\sum c_{i} w_{i}$. Let $[w]_{\mathcal{C}}$ denote the column vector $[w]_{\mathcal{C}}=\left(c_{1}, \ldots, c_{n}\right)^{T}$.

Let V be a vector space with basis $\mathcal{B}=\left\{v_{1}, \ldots, v_{m}\right\}$, and $f: W \rightarrow V$ a linear map. The matrix of $f$ relative to the bases $\mathcal{C}$ and $\mathcal{B}$ is $[f]_{\mathcal{B} \leftarrow \mathcal{C}}=\left(a_{i j}\right) \in \operatorname{Mat}_{m \times n}(\mathbb{K})$, where $f\left(w_{j}\right)=\sum_{i=1}^{m} a_{i j} v_{i}$. Matrix multiplication gives

$$
[f(w)]_{\mathcal{B}}=[f]_{\mathcal{B} \leftarrow \mathcal{C}}[w]_{\mathcal{C}} .
$$

Let $f: V \rightarrow V$ be an endomorphism, and $\mathcal{B}$ and $\mathcal{D}$ two bases for $V$. Then

$$
[f]_{\mathcal{D} \leftarrow \mathcal{D}}=[\mathrm{id}]_{\mathcal{D} \leftarrow \mathcal{B}}[f]_{\mathcal{B} \leftarrow \mathcal{B}}[\mathrm{id}]_{\mathcal{B} \leftarrow \mathcal{D}} .
$$

If $S=[\mathrm{id}]_{\mathcal{B} \leftarrow \mathcal{D}}$, then

$$
[f]_{\mathcal{D} \leftarrow \mathcal{D}}=S^{-1}[f]_{\mathcal{B} \leftarrow \mathcal{B}} S
$$

6.1.2. Semilinear algebra. Let $\tau$ be an automorphism of $\mathbb{K}$ and $\sigma=\tau^{-1}$. Then $f: V \rightarrow V$ is called $\tau$-linear, if for $a \in \mathbb{K}$ and $v \in V$,

$$
f(a v)=a^{\tau} f(v)
$$

where $a^{\tau}=\tau(a)$. Let $f\left(v_{j}\right)=\sum_{i} a_{i j} v_{i}$. If $v=\sum_{j} c_{j} v_{j}$, then

$$
f(v)=\sum_{j} f\left(c_{j} v_{j}\right)=\sum_{j} c_{j}^{\tau} f\left(v_{j}\right)=\sum_{j}\left(\sum_{i} a_{i j} v_{i}\right) c_{j}^{\tau}
$$

and so

$$
[f(v)]_{\mathcal{B}}=[f]_{\mathcal{B} \leftarrow \mathcal{B}}[v]_{\mathcal{B}}^{\tau},
$$

where $B^{\tau}$ is the matrix obtained by applying $\tau$ to each entry of $B$.
Change of basis is accomplished with $\tau$-twisted conjugacy:

$$
[f]_{\mathcal{D} \leftarrow \mathcal{D}}=[\mathrm{id}]_{\mathcal{D} \leftarrow \mathcal{B}}[f]_{\mathcal{B} \leftarrow \mathcal{B}}[\mathrm{id}]_{\mathcal{B} \leftarrow \mathcal{D}}^{\tau}=S^{-1}[f]_{\mathcal{B} \leftarrow \mathcal{B}} S^{\tau}
$$

The iterates of $f$ are represented by

$$
\begin{equation*}
\left[f^{\circ r}\right]=[f][f]^{\tau}[f]^{\tau^{2}} \ldots[f]^{\tau^{r-1}} \tag{6.1}
\end{equation*}
$$

6.1.3. Adjoint map. Let $V^{*}$ be the dual vector space of $V$ and $(\cdot, \cdot)_{V}: V \times V^{*} \rightarrow \mathbb{K}$ the natural pairing, linear with respect to each argument. Similarly, let $W^{*}$ be the dual vector space of $W$ and $(\cdot, \cdot)_{W}: W \times W^{*} \rightarrow \mathbb{K}$ the natural pairing.

Let $f: W \rightarrow V$ be $\tau$-linear. Define the adjoint map $f^{*}: V^{*} \rightarrow W^{*}$ by the formula

$$
\left(w, f^{*}(\varphi)\right)_{W}=(f(w), \varphi)_{V}^{\sigma}, \quad w \in W, \varphi \in V^{*}
$$

The map $f^{*}$ is $\sigma$-linear, $f^{*}(a \varphi)=a^{\sigma} f^{*}(\varphi)$ for $a \in \mathbb{K}$. Indeed,

$$
\left(w, f^{*}(a \varphi)\right)_{W}=(f(w), a \varphi)_{V}^{\sigma}=a^{\sigma}(f(w), \varphi)_{V}^{\sigma}=a^{\sigma}\left(w, f^{*}(\varphi)\right)_{W}=\left(w, a^{\sigma} f^{*}(\varphi)\right)_{W}
$$

Let $\mathcal{C}=\left\{w_{1}, \ldots, w_{n}\right\}$ be a basis of $W$ and $\mathcal{B}=\left\{v_{1}, \ldots, v_{m}\right\}$ a basis of $V$. Let $\mathcal{C}^{*}=$ $\left\{\varphi_{1}, \ldots, \varphi_{n}\right\}$ be the dual basis of $W^{*}$ and $\mathcal{B}^{*}=\left\{\psi_{1}, \ldots, \psi_{m}\right\}$ the dual basis of $V^{*}$.

If $[f]_{\mathcal{B} \leftarrow \mathcal{C}}=\left(a_{i j}\right)$, then

$$
\begin{equation*}
\left[f^{*}\right]_{\mathcal{C}^{*} \leftarrow \mathcal{B}^{*}}=\left([f]_{\mathcal{B} \leftarrow \mathcal{C}}^{\sigma}\right)^{T} \tag{6.2}
\end{equation*}
$$

6.2. Field $\mathbb{K}(u)$. In this paper we consider some particular fields $\mathbb{K}(u)$.

Let $u=\left(u_{1}, \ldots, u_{r}\right)$ be variables. Let $\mathbb{K}(u)$ be the field of rational functions in variables

$$
\begin{equation*}
u_{i}^{1 / p^{s}}, \quad i=1, \ldots, r, \quad s \in \mathbb{Z}_{>0} \tag{6.3}
\end{equation*}
$$

with coefficients in $\mathbb{F}_{p}$. Thus an element of $\mathbb{K}(u)$ is the ratio of two polynomials in variables $u_{i}^{1 / p^{s}}$ with coefficients in $\mathbb{F}_{p}$.

For any $f\left(u_{1}, \ldots, u_{r}\right) \in \mathbb{K}(u)$, we have

$$
\begin{equation*}
f\left(u_{1}, \ldots, u_{r}\right)^{1 / p}=f\left(u_{1}^{1 / p}, \ldots, u_{r}^{1 / p}\right) \tag{6.4}
\end{equation*}
$$

cf. [PF].
The field $\mathbb{K}(u)$ has the Frobenius automorphism

$$
\begin{equation*}
\sigma: \mathbb{K}(u) \rightarrow \mathbb{K}(u), \quad f(u) \mapsto f(u)^{p}, \tag{6.5}
\end{equation*}
$$

and its inverse

$$
\begin{equation*}
\tau: \mathbb{K}(u) \rightarrow \mathbb{K}(u), \quad f(u) \mapsto f(u)^{1 / p} \tag{6.6}
\end{equation*}
$$

6.3. Curve $X$. Recall that $n=q k+1$, see Section 5.1. Consider the field $\mathbb{K}(z)$, $z=\left(z_{1}, \ldots, z_{n}\right)$. Consider the algebraic curve $X$ over $\mathbb{K}(z)$ defined by the affine equation

$$
\begin{equation*}
y^{q}=F(x, z):=\left(x-z_{1}\right)\left(x-z_{2}\right) \ldots\left(x-z_{n}\right) . \tag{6.7}
\end{equation*}
$$

The curve has genus

$$
\begin{equation*}
g:=k \frac{q(q-1)}{2} \tag{6.8}
\end{equation*}
$$

The space $\Omega^{1}(X)$ of regular 1-forms on $X$ is the direct sum

$$
\begin{equation*}
\Omega^{1}(X)=\bigoplus_{a=1}^{q-1} \Omega_{a}^{1}(X) \tag{6.9}
\end{equation*}
$$

where $\operatorname{dim} \Omega_{a}^{1}(X)=a k$, and $\Omega_{a}^{1}(X)$ has basis:

$$
\begin{equation*}
x^{i-1} \frac{d x}{y^{a}}, \quad i=1, \ldots, a k \tag{6.10}
\end{equation*}
$$

6.4. Cartier operator. Following $[\mathrm{AH}]$, we introduce the Cartier operator

$$
\begin{equation*}
C: \Omega^{1}(X) \rightarrow \Omega^{1}(X) \tag{6.11}
\end{equation*}
$$

which is $\tau$-linear. It has block structure. For $a=1, \ldots, q-1$, we have

$$
\begin{equation*}
C\left(\Omega_{a}^{1}(X)\right) \subset \Omega_{\eta(a)}^{1}(X) \tag{6.12}
\end{equation*}
$$

where $\eta:\{1, \ldots, q-1\} \rightarrow\{1, \ldots, q-1\}$ is the division by $p$ modulo $q$ defined in (4.17).
We define the Cartier operator by the action on the basis vectors as follows.
For $a=1, \ldots, q-1$, formula (4.18) implies $q \mid(\eta(a) p-a)$. Hence, for $f=1, \ldots, a k$, we have

$$
\begin{align*}
x^{a k-f} \frac{d x}{y^{a}} & =x^{a k-f} y^{\eta(a) p-a} \frac{d x}{y^{a} y^{\eta(a) p-a}}=x^{a k-f}\left(y^{q}\right)^{(\eta(a) p-a) / q} \frac{d x}{y^{\eta(a) p}}  \tag{6.13}\\
& =x^{a k-f} F(x, z)^{(\eta(a) p-a) / q} \frac{d x}{y^{\eta(a) p}}=\sum_{w \geqslant 0}{ }^{a} F_{f}^{w}(z) x^{w} \frac{d x}{y^{\eta(a) p}},
\end{align*}
$$

where ${ }^{a} F_{f}^{w}(z) \in \mathbb{F}_{p}[z]$.
The Cartier operator is defined by the formula

$$
\begin{equation*}
x^{a k-f} \frac{d x}{y^{a}} \mapsto \sum_{h=1}^{\eta(a) k}\left({ }^{a} F_{f}^{(\eta(a) k-h) p+p-1}(z)\right)^{1 / p} x^{\eta(a) k-h} \frac{d x}{y^{\eta(a)}} \tag{6.14}
\end{equation*}
$$

This formula has the following meaning. If $w$ in (6.13) is not of the form $l p+p-1$ for some $l$, then the summand ${ }^{a} F_{f}^{w}(z) x^{w} \frac{d x}{y^{\eta(a) p}}$ in (6.13) is ignored in the definition (6.14), and if $w=l p+p-1$ for some $l$, then the term ${ }^{a} F_{f}^{l p+p-1}(z) x^{l p+p-1} \frac{d x}{y^{\eta(a) p}}$ produces the summand

$$
\left({ }^{a} F_{f}^{l p+p-1}(z)\right)^{1 / p} x^{l} \frac{d x}{y^{\eta(a)}}
$$

in the definition (6.14). It turns out that there are exactly $\eta(a) k$ such values $w=l p+p-1$ and that explains the upper index $\eta(a) k$ in the sum in (6.14).

The coefficients $\left({ }^{a} F_{f}^{(\eta(a) k-h) p+p-1}(z)\right)^{1 / p}$ form the $g \times g$-matrix of the Cartier operator with respect to the basis $x^{i-1} d x / y^{a}$ in (7.4). The matrix is called the Cartier-Manin matrix.

Let $\Omega^{1}(X)^{*}$ be the space dual to $\Omega^{1}(X)$. Let

$$
\begin{equation*}
\varphi_{a}^{i}, \quad a=1, \ldots, q-1, \quad i=1, \ldots, k a \tag{6.15}
\end{equation*}
$$

denote the basis of $\Omega^{1}(X)^{*}$ dual to the basis $\left(x^{i-1} d x / y^{a}\right)$ of $\Omega^{1}(X)$.
The map

$$
C^{*}: \Omega^{1}(X)^{*} \rightarrow \Omega^{1}(X)^{*}
$$

adjoint to the Cartier operator is $\sigma$-linear. Following Serre the matrix of the map $C^{*}$ is called the Hasse-Witt matrix with respect to the basis $\left(\varphi_{a}^{i}\right)$, see $[\mathrm{AH}]$. The entries of the Hasse-Witt matrix are the polynomials

$$
{ }^{a} F_{f}^{(\eta(a) k-h) p+p-1}(z) \in \mathbb{F}_{p}[z]
$$

see (6.2).

Remark. The map $C^{*}$ is identified with the Frobenius map

$$
H^{1}(X, \mathcal{O}(X)) \rightarrow H^{1}(X, \mathcal{O}(X))
$$

see for example [AH].
For each $a=1, \ldots, q-1$, consider the columns of the Hasse-Witt matrix, corresponding to the basis vectors of $\Omega_{\eta(a)}^{1}(X)^{*}$ and the rows corresponding to the basis vectors of $\Omega_{a}^{1}(X)^{*}$. The respective block of the Hasse-Witt matrix of size $a k \times \eta(a) k$ is denoted by ${ }^{a} \mathcal{I}$. Its entries are denoted by

$$
\begin{equation*}
{ }^{a} \mathcal{I}_{f}^{h}(z):={ }^{a} F_{f}^{(\eta(a) k-h) p+p-1}(z), \quad f=1, \ldots, a k, \quad h=1, \ldots, \eta(a) k \tag{6.16}
\end{equation*}
$$

Lemma 6.1. The entry ${ }^{a} \mathcal{I}_{f}^{h}(z)$ is a homogeneous polynomial in $z_{1}, \ldots, z_{n}$ of degree

$$
(\eta(a) p-a) / q-(f-1)+(h-1) p .
$$

6.5. Cartier map and arithmetic solutions. Let $W(X)$ be the $n$-dimensional $\mathbb{K}(z)$ vector space spanned by the following differential 1-forms on $X$ :

\frac{1}{x-z_{i}} \frac{d x}{y}, \quad i=1, \ldots, n \tag{6.17}
\end{equation*}
$$

Notice that these are the differential 1-forms on $X$, which appear in the construction of the solutions of the KZ equations over $\mathbb{C}$. Notice also that they are not regular on $X$.

Let $W(X)^{*}$ be the space dual to $W(X)$ and $\psi_{j}, j=1, \ldots, n$, the basis of $W(X)^{*}$ dual to the basis $\left(d x / y\left(x-z_{i}\right)\right)$.

Define the $\tau$-linear Cartier map

$$
\begin{equation*}
\hat{C}: W(X) \rightarrow \Omega_{a_{1}}^{1}(X) \tag{6.18}
\end{equation*}
$$

in the standard way. Namely we have

$$
\begin{aligned}
\frac{1}{x-z_{j}} \frac{d x}{y} & =\frac{F(x, z)^{\left(a_{1} p-1\right) / q}}{x-z_{j}} \frac{d x}{y^{a_{1} p}}=\frac{\Phi_{p}(x, z, \bar{M})}{x-z_{j}} \frac{d x}{y^{a_{1} p}} \\
& =P_{j}(z, \bar{M}) \frac{d x}{y^{a_{1} p}}=\sum_{i} P_{j}^{i}(z, \bar{M}) x^{i} \frac{d x}{y^{a_{1} p}}
\end{aligned}
$$

where $\Phi_{p}, P_{j}, P_{j}^{i}$ see in (5.6), (5.7), (5.8). Define $\hat{C}$ by the formula

$$
\begin{equation*}
\frac{1}{x-z_{j}} \frac{d x}{y} \mapsto \sum_{h=1}^{a_{1} k}\left(P_{j}^{\left(a_{1} k-h\right) p+p-1}(z, \bar{M})\right)^{1 / p} x^{a_{1} k-h} \frac{d x}{y^{a_{1}}}, \tag{6.19}
\end{equation*}
$$

The map

$$
\begin{equation*}
\hat{C}^{*}: \Omega_{a_{1}}^{1}(X)^{*} \rightarrow W(X)^{*} \tag{6.20}
\end{equation*}
$$

adjoint to the Cartier map $\hat{C}$ is $\sigma$-linear. The matrix of the map $\hat{C}^{*}$ will be called the Hasse-Witt matrix with respect to the bases $\left(\varphi_{a_{1}}^{i}\right)$ and $\left(\psi_{j}\right)$. The entries of the Hasse-Witt matrix are the polynomials $P_{j}^{\left(a_{1} k-h\right) p+p-1}(z, \bar{M})$.

For any $m=1, \ldots, a_{1} k$, we have

$$
\begin{equation*}
\hat{C}^{*}\left(\varphi_{a_{1}}^{m}\right)=\sum_{j=1}^{n} P_{j}^{\left(a_{1} k-m\right) p+p-1}(z, \bar{M}) \psi_{j} . \tag{6.21}
\end{equation*}
$$

This formula shows that the coordinate vector

$$
\begin{equation*}
\left(P_{1}^{\left(a_{1} k-m\right) p+p-1}(z, \bar{M}), \ldots, P_{n}^{\left(a_{1} k-m\right) p+p-1}(z, \bar{M})\right) \tag{6.22}
\end{equation*}
$$

of $\hat{C}^{*}\left(\varphi_{a_{1}}^{h}\right)$ is exactly the arithmetic solution $I^{m}(z)$ defined in (5.9).
This construction gives us the following theorem.
Theorem 6.2. The Hasse-Witt matrix of the map $\hat{C}^{*}$ defines an isomorphism

$$
\begin{equation*}
\iota_{\Lambda}: \Omega_{a_{1}}(X)^{*} \rightarrow \mathcal{M}_{\Lambda}, \quad \varphi_{a_{1}}^{m} \mapsto I^{m}(z) \tag{6.23}
\end{equation*}
$$

of the vector space $\Omega_{a_{1}}(X)^{*}$ and the module $\mathcal{M}_{\Lambda}$ of arithmetic solutions for $\Lambda=(1, \ldots, 1)$.
Proof. Clearly the map $\iota_{\Lambda}$ is an epimorphism. The fact that $\iota_{\Lambda}$ is an isomorphism follows from the fact that $\operatorname{dim} \mathcal{M}_{\Lambda}=\operatorname{dim} \Omega_{a_{1}}(X)^{*}=a_{1} k$ by Lemma 5.1.
6.6. Arithmetic solutions from iterates. Consider an iterate of the Cartier map,

$$
C^{\circ b} \circ \hat{C}:=C \circ C \cdots \circ C \circ \hat{C}: W(X) \rightarrow \Omega^{1}(X) .
$$

The image lies in $\Omega_{a_{b}}^{1}(X)$. Choose any element $\varphi_{a_{b}}^{m}$ of the basis of $\Omega_{a_{b}}^{1}(X)^{*}$ dual to the basis $\left(x^{i-1} d x / y^{a_{b}}\right)$ and express the vector

$$
\left(C^{\circ b} \circ \hat{C}\right)^{*}\left(\varphi_{a_{b}}^{m}\right)
$$

in terms of the basis $\left(\psi_{j}\right)$ of $W(X)^{*}$. By Theorem 6.2 the coordinates of that vector is an arithmetic solution, namely, it is the solution

$$
\begin{equation*}
{ }^{b} I^{m}(z):=\sum_{m_{1}, \ldots, m_{b}}{ }^{a_{b}} \mathcal{I}_{m_{b}}^{m}\left(z_{1}^{p^{b}}, \ldots, z_{n}^{p^{b}}\right) \ldots{ }^{a_{1}} \mathcal{I}_{m_{1}}^{m_{2}}\left(z_{1}^{p}, \ldots, z_{n}^{p}\right) \cdot I^{m_{1}}\left(z_{1}, \ldots, z_{n}\right) \tag{6.24}
\end{equation*}
$$

Here $m=1, \ldots, a_{b} k$. We will call these arithmetic solutions the iterated arithmetic solutions.
We will see these solutions in Sections 9.5 and 9.6.

## 7. Cartier map and module $\mathcal{M}_{\Lambda}$ for more general $\Lambda$

7.1. Curve $\tilde{X}$. Recall that $n=q k+1$, see Section 5.1. Let $\tilde{\Lambda}=\left(\tilde{\Lambda}_{1}, \ldots, \tilde{\Lambda}_{\tilde{n}}\right) \in \mathbb{Z}_{>0}^{\tilde{n}}$ be such that

$$
\sum_{j=1}^{\tilde{n}} \tilde{\Lambda}_{j}=n, \quad \tilde{\Lambda}_{j}<q, \quad j=1, \ldots, \tilde{n}
$$

This means that $\tilde{\Lambda}$ is a fusion of $\Lambda=(1, \ldots, 1) \in \mathbb{Z}_{>0}^{n}$, see Section 3.3.
For $j=1, \ldots, \tilde{n}, a=1, \ldots, q-1$, denote

$$
\begin{equation*}
e_{j}(a):=\left\lceil\frac{\tilde{\Lambda}_{j} a+1}{q}-1\right\rceil, \quad e(a)=\sum_{j=1}^{\tilde{n}} e_{j}(a) \tag{7.1}
\end{equation*}
$$

where $\lceil x\rceil$ is the smallest integer greater than $x$ or equal to $x$.

Consider the field $\mathbb{K}(\tilde{z})$, $\tilde{z}=\left(\tilde{z}_{1}, \ldots, \tilde{z}_{\tilde{n}}\right)$. Consider the algebraic curve $\tilde{X}$ over $\mathbb{K}(\tilde{z})$ defined by the affine equation

$$
\begin{equation*}
y^{q}=\tilde{F}(x, \tilde{z}):=\left(x-\tilde{z}_{1}\right)^{\tilde{\Lambda}_{1}}\left(x-\tilde{z}_{2}\right)^{\tilde{\Lambda}_{2}} \ldots\left(x-\tilde{z}_{\tilde{n}}\right)^{\tilde{\Lambda}_{\tilde{n}}} \tag{7.2}
\end{equation*}
$$

The space $\Omega^{1}(\tilde{X})$ of regular 1-forms on $\tilde{X}$ is the direct sum

$$
\begin{equation*}
\Omega^{1}(\tilde{X})=\bigoplus_{a=1}^{q-1} \Omega_{a}^{1}(\tilde{X}) \tag{7.3}
\end{equation*}
$$

where $\Omega_{a}^{1}(\tilde{X})$ consists of 1-forms

$$
\begin{equation*}
u(x) \frac{d x}{y^{a}} \tag{7.4}
\end{equation*}
$$

such that $u(x)$ is a polynomial in $x$ of degree $<a k$, and for any $j=1, \ldots, \tilde{n}$, the polynomial $u(z)$ has zero at $\tilde{z}_{j}$ of multiplicity at least $e_{j}(a)$.

This fact is checked by writing $u(x) d x / y^{a}$ in local coordinates on $\tilde{X}$ at $\infty, \tilde{z}_{1}, \ldots, \tilde{z}_{\tilde{n}}$. Namely, at $x=\infty$ we have

$$
x=t^{-q}, \quad y=t^{-n}(1+\mathcal{O}(t))
$$

where $t$ is a local coordinate. If $d=\operatorname{deg}_{x} u(x)$, then $u(x) d x / y^{a}=-q t^{a n-d q-q-1}(1+\mathcal{O}(t)) d t$. Hence $u(x) d x / y^{a}$ is regular at infinity if $a n-d q-q-1 \geqslant 0$, which is equivalent to $d<a k$. At $x=\tilde{z}_{j}$ we have

$$
x-\tilde{z}_{j}=t^{q}, \quad y=\operatorname{const} t^{\tilde{\Lambda}_{j}}(1+\mathcal{O}(t))
$$

where $t$ is a local coordinate. If $d$ is the multiplicity of $u(x)$ at $x=\tilde{z}_{j}$, then $u(x) d x / y^{a}=$ const $t^{-a \tilde{\Lambda}_{j}+d q+q-1}(1+\mathcal{O}(t)) d t$. Hence $u(x) d x / y^{a}$ is regular at $x=\tilde{z}_{j}$ if $-a \tilde{\Lambda}_{j}+d q+q-1 \geqslant 0$, which is equivalent to $d \geqslant e_{j}(a)$.

Therefore,

$$
\begin{equation*}
\operatorname{dim} \Omega_{a}^{1}(\tilde{X})=a k-e(a) \tag{7.5}
\end{equation*}
$$

and $\Omega_{a}^{1}(\tilde{X})$ consists of elements

$$
\begin{equation*}
\tilde{u}(x) \frac{d x}{y^{a}} \prod_{j=1}^{\tilde{n}}\left(x-\tilde{z}_{j}\right)^{e_{j}(a)} \tag{7.6}
\end{equation*}
$$

where $\tilde{u}(x)$ is an arbitrary polynomial of degree less than $a k-e(a)$.
7.2. Rank of $\mathcal{M}_{\tilde{\Lambda}}$. Consider the module $\mathcal{M}_{\tilde{\Lambda}}$ of arithmetic solutions of the KZ equations associated with $\tilde{\Lambda}$.

Theorem 7.1. Let $p>n=k q+1$, then the rank $d_{\tilde{\Lambda}}$ of $\mathcal{M}_{\tilde{\Lambda}}$ equals $a_{1} k-e\left(a_{1}\right)$.
This theorem is a generalization of Lemma 5.1.
Proof. We have $d_{\Lambda}=\left[\sum_{j=1}^{\tilde{n}} \bar{M}_{j} / p\right]$ by formula (3.7). Here $\bar{M}_{j}$ is the minimal positive integer solution of the congruence

$$
\begin{equation*}
M_{j} \equiv-\frac{\bar{\Lambda}_{j}}{q} \quad(\bmod p) \tag{7.7}
\end{equation*}
$$

Recall the integer $a_{1}$ defined by

$$
\begin{equation*}
1 \leqslant a_{1}<q \quad \text { and } \quad q \mid\left(a_{1} p-1\right) \tag{7.8}
\end{equation*}
$$

Then

$$
\begin{equation*}
\tilde{M}_{j}=\tilde{\Lambda}_{j} \frac{a_{1} p-1}{q} \tag{7.9}
\end{equation*}
$$

is another solution of the congruence in (7.7). Denote

$$
\begin{equation*}
\tilde{M}=\left(\tilde{M}_{1}, \ldots, \tilde{M}_{\tilde{n}}\right) \tag{7.10}
\end{equation*}
$$

Lemma 7.2. We have

$$
\begin{equation*}
\tilde{M}_{j}=\bar{M}_{j}+e_{j}\left(a_{1}\right) p \tag{7.11}
\end{equation*}
$$

Proof. Clearly, we have $\tilde{M}_{j}=\bar{M}_{j}+l p$, where

$$
l=\left[\frac{\tilde{\Lambda}_{j}\left(a_{1} p-1\right) / q}{p}\right]=\left[\frac{\tilde{\Lambda}_{j} a_{1}}{q}-\frac{\tilde{\Lambda}_{j}}{q p}\right] .
$$

Since $\tilde{\Lambda}_{j}<q<p$, we have

$$
\frac{\tilde{\Lambda}_{j}}{q p}<\frac{q}{q p}<\frac{1}{q}
$$

Furthermore, since $\tilde{\Lambda}_{j}, a_{1}<q$ and $q$ is prime, we conclude that $\tilde{\Lambda}_{j} a_{1} / q$ is not an integer. These two observations imply that

$$
l=\left[\frac{\tilde{\Lambda}_{j} a_{1}}{q}-\frac{\tilde{\Lambda}_{j}}{q p}\right]=\left[\frac{\tilde{\Lambda}_{j} a_{1}}{q}\right] .
$$

On the other hand,

$$
e_{j}\left(a_{1}\right)=\left\lceil\frac{\tilde{\Lambda}_{j} a_{1}+1}{q}-1\right\rceil=\left\lceil\frac{\tilde{\Lambda}_{j} a_{1}}{q}+\frac{1}{q}\right\rceil-1=\left\lceil\frac{\tilde{\Lambda}_{j} a_{1}}{q}\right\rceil-1=\left\lceil\frac{\tilde{\Lambda}_{j} a_{1}}{q}\right\rceil
$$

where the last two equalities follow from the fact that $\tilde{\Lambda}_{j} a_{1} / q$ is not an integer. The lemma is proved.

To finish the proof of Theorem 7.1 we observe that

$$
\begin{aligned}
d_{\tilde{\Lambda}} & =\left[\sum_{j=1}^{\tilde{n}} \frac{\bar{M}_{j}}{p}\right]=\left[\sum_{j=1}^{\tilde{n}}\left(\tilde{\Lambda}_{j} \frac{\left(a_{1} p-1\right) / q}{p}-e_{j}\left(a_{1}\right)\right)\right] \\
& =\left[n \frac{\left(a_{1} p-1\right) / q}{p}\right]-e\left(a_{1}\right)=a_{1} k-e\left(a_{1}\right),
\end{aligned}
$$

where we use Lemmas 7.2 and 5.1.
7.3. Cartier map for $\tilde{X}$. Let $W(\tilde{X})$ be the $\tilde{n}$-dimensional $\mathbb{K}(\tilde{z})$-vector space spanned by the following differential 1-forms on $\tilde{X}$ :

$$
\begin{equation*}
\frac{1}{x-\tilde{z}_{i}} \frac{d x}{y}, \quad i=1, \ldots, \tilde{n} \tag{7.12}
\end{equation*}
$$

Let $W(\tilde{X})^{*}$ be the space dual to $W(\tilde{X})$ and $\psi_{j}, j=1, \ldots, \tilde{n}$, be the basis of $W(\tilde{X})^{*}$ dual to the basis $\left(d x / y\left(x-\tilde{z}_{i}\right)\right)$.

Define the $\tau$-linear Cartier map $\hat{C}$ of the space $W(\tilde{X})$ to the space of differential 1-forms on $\tilde{X}$ in the standard way. Namely we have

$$
\frac{1}{x-\tilde{z}_{j}} \frac{d x}{y}=\frac{\tilde{F}(x, \tilde{z})^{\left(a_{1} p-1\right) / q}}{x-\tilde{z}_{j}} \frac{d x}{y^{a_{1} p}}=P_{j}(\tilde{z}, \tilde{M}) \frac{d x}{y^{a_{1} p}}=\sum_{l} P_{j}^{l}(\tilde{z}, \tilde{M}) x^{l} \frac{d x}{y^{a_{1} p}}
$$

where $\tilde{M}, P_{j}, P_{j}^{l}$ see in $(7.10),(5.7),(5.8)$. Define $\hat{C}$ by the formula

$$
\begin{equation*}
\frac{1}{x-\tilde{z}_{j}} \frac{d x}{y} \mapsto \sum_{h=1}^{a_{1} k}\left(P_{j}^{\left(a_{1} k-h\right) p+p-1}(\tilde{z}, \tilde{M})\right)^{1 / p} x^{a_{1} k-h} \frac{d x}{y^{a_{1}}} \tag{7.13}
\end{equation*}
$$

cf. (6.14), (7.13).
Theorem 7.3. For $j=1, \ldots, \tilde{n}$, the 1-form $\hat{C}\left(d x / y\left(x-\tilde{z}_{j}\right)\right)$ lies in $\Omega_{a_{1}}^{1}(\tilde{X})$, and hence the Cartier map maps $W(\tilde{X})$ to $\Omega_{a_{1}}^{1}(\tilde{X})$.
Proof. The polynomial

$$
u(x):=\sum_{h=1}^{a_{1} k}\left(P_{j}^{\left(a_{1} k-h\right) p+p-1}(\tilde{z}, \tilde{M})\right)^{1 / p} x^{a_{1} k-h} \frac{d x}{y^{a_{1}}}
$$

has degree $<a_{1} k$. We need to check that for any $i=1, \ldots, \tilde{n}$, the polynomial $u(x)$ has zero at $x=\tilde{z}_{i}$ of multiplicity at least $e_{i}\left(a_{1}\right)$.

Indeed, on the one hand, we have

$$
\tilde{F}\left(x+\tilde{z}_{i}, \tilde{z}\right)^{\left(a_{1} p-1\right) / q}=x^{\bar{M}_{i}+e_{i}\left(a_{1}\right) p} \prod_{l \neq i}\left(x+\tilde{z}_{i}-\tilde{z}_{l}\right)^{\tilde{\Lambda}_{i}\left(a_{1} p-1\right) / q}
$$

by Lemma 7.2. Hence in the Taylor expansion

$$
\begin{equation*}
\frac{\tilde{F}\left(x+\tilde{z}_{i}, \tilde{z}\right)^{\left(a_{1} p-1\right) / q}}{x-\tilde{z}_{j}}=: \sum_{l} \tilde{P}_{j}^{l}(\tilde{z}) x^{l} \tag{7.14}
\end{equation*}
$$

we have

$$
\begin{equation*}
\tilde{P}_{j}^{l p+p-1}(\tilde{z})=0, \quad l=0, \ldots, e_{i}\left(a_{1}\right)-1 \tag{7.15}
\end{equation*}
$$

On the other hand, we have

$$
\begin{equation*}
\frac{\tilde{F}\left(x+\tilde{z}_{i}, \tilde{z}\right)^{\left(a_{1} p-1\right) / q}}{x-\tilde{z}_{j}}=\sum_{l} P_{j}^{l}(\tilde{z}, \tilde{M})\left(x+\tilde{z}_{i}\right)^{l} \tag{7.16}
\end{equation*}
$$

By Lucas' Theorem 4.1 we have

$$
\begin{equation*}
\tilde{P}^{l p+p-1}(\tilde{z})=\sum_{h \geqslant 0}\binom{l+h}{h} \tilde{z}_{i}^{(l+h) p} P_{j}^{(l+h) p+p-1}(\tilde{z}, \tilde{M}) \tag{7.17}
\end{equation*}
$$

for any $l$. Formulas (7.15) and (7.17) show that the polynomial $u(x)$ has zero at $x=\tilde{z}_{i}$ of multiplicity at least $e_{i}\left(a_{1}\right)$. The theorem is proved.
7.4. Cartier map and arithmetic solutions. The map

$$
\begin{equation*}
\hat{C}^{*}: \Omega_{a}^{1}(\tilde{X})^{*} \rightarrow W(\tilde{X})^{*}, \tag{7.18}
\end{equation*}
$$

adjoint to the Cartier operator $\hat{C}$ is $\sigma$-linear.
Elements of $\Omega_{a}^{1}(\tilde{X})$ have the form

$$
u(x) \frac{d x}{y^{a_{1}}}=\sum_{i=0}^{a_{1} k-1} u^{i} x^{i} \frac{d x}{y^{a_{1}}}
$$

with suitable coefficients $u^{i}$, see Section 7.1. For $m=0, \ldots, a_{1} k-1$ define an element $\varphi^{m} \in W(\tilde{X})^{*}$ by the formula

$$
\begin{equation*}
\varphi^{m}: u(x) \frac{d x}{y^{a_{1}}} \mapsto u^{m} \tag{7.19}
\end{equation*}
$$

For any $m=1, \ldots, a_{1} k$, we have

$$
\begin{equation*}
\hat{C}^{*}\left(\varphi^{m}\right)=\sum_{j=1}^{\tilde{n}} P_{j}^{m p+p-1}(\tilde{z}, \tilde{M}) \psi_{j} \tag{7.20}
\end{equation*}
$$

This formula shows that the coordinate vector

$$
\begin{equation*}
\left(P_{1}^{m p+p-1}(\tilde{z}, \tilde{M}), \ldots, P_{\tilde{n}}^{m p+p-1}(\tilde{z}, \tilde{M})\right) \tag{7.21}
\end{equation*}
$$

of $\hat{C}^{*}\left(\varphi^{m}\right)$ is an arithmetic solution constructed in Theorem 2.3 and all solutions constructed in Theorem 2.3 are of this form.

This construction gives us the following theorem.
Theorem 7.4. The map $\hat{C}^{*}$ adjoint to the Cartier map $\hat{C}: W(\tilde{X}) \rightarrow \Omega_{a_{1}}^{1}(\tilde{X})$ defines an isomorphism

$$
\begin{equation*}
\iota_{\tilde{\Lambda}}: \Omega_{a_{1}}(\tilde{X})^{*} \rightarrow \mathcal{M}_{\tilde{\Lambda}}, \quad \varphi^{m} \mapsto\left(P_{1}^{m p+p-1}(\tilde{z}, \tilde{M}), \ldots, P_{\tilde{n}}^{m p+p-1}(\tilde{z}, \tilde{M})\right) \tag{7.22}
\end{equation*}
$$

of the vector space $\Omega_{a_{1}}(\tilde{X})^{*}$ and the module $\mathcal{M}_{\tilde{\Lambda}}$ of arithmetic solutions for $\tilde{\Lambda}$.
Proof. Clearly the map $\iota_{\Lambda}$ is an epimorphism. The fact that $\iota_{\Lambda}$ is an isomorphism follows from the fact that $\operatorname{dim} \mathcal{M}_{\tilde{\Lambda}}=\operatorname{dim} \Omega_{a_{1}}(\tilde{X})^{*}=a_{1} k-e\left(a_{1}\right)$ by Theorem 7.1.

## 8. Hasse-Witt matrix for curve $Y$

In Section 6 we introduced the curve $X$ over the field $\mathbb{K}(z)$ and determined its Hasse-Witt matrix. In this section we consider the same curve over a new field $\mathbb{K}(\lambda)$, where $z$ and $\lambda$ are related by a fractional linear transformation, and calculate its Hasse-Witt matrix. We will use that new Hasse-Witt matrix to relate the arithmetic solutions of the KZ equations over $\mathbb{C}$ and over $\mathbb{F}_{p}$.
8.1. Curve $Y$. Recall that $n=q k+1$, see Section 5.1. Consider the field $\mathbb{K}(\lambda)$, $\lambda=\left(\lambda_{3}, \ldots, \lambda_{n}\right)$. Consider the algebraic curve $Y$ over $\mathbb{K}(\lambda)$ defined by the affine equation

$$
\begin{equation*}
y^{q}=G(x, \lambda):=x(x-1)\left(x-\lambda_{2}\right) \ldots\left(x-\lambda_{n}\right) \tag{8.1}
\end{equation*}
$$

The space $\Omega^{1}(Y)$ of regular 1-forms on $Y$ is the direct sum $\Omega^{1}(Y)=\bigoplus_{a=1}^{q-1} \Omega_{a}^{1}(Y)$, where $\operatorname{dim} \Omega_{a}^{1}(Y)=a k$, and $\Omega_{a}^{1}(Y)$ has basis :

$$
\begin{equation*}
x^{i-1} \frac{d x}{y^{a}}, \quad i=1, \ldots, a k \tag{8.2}
\end{equation*}
$$

We define the Cartier operator

$$
\begin{equation*}
C: \Omega^{1}(Y) \rightarrow \Omega^{1}(Y) \tag{8.3}
\end{equation*}
$$

in the same way as in Section 6.4. The operator has block structure. For $a=1, \ldots, q-1$, we have $C\left(\Omega_{a}^{1}(Y)\right) \subset \Omega_{\eta(a)}^{1}(Y)$.

For $f=1, \ldots, a k$, we have

$$
\begin{equation*}
x^{a k-f} \frac{d x}{y^{a}}=x^{a k-f} G(x, \lambda)^{(\eta(a) p-a) / q} \frac{d x}{y^{\eta(a) p}}=\sum_{w \geqslant 0}{ }^{a} G_{f}^{w}(\lambda) x^{w} \frac{d x}{y^{\eta(a) p}}, \tag{8.4}
\end{equation*}
$$

where ${ }^{a} G_{f}^{w}(\lambda) \in \mathbb{F}_{p}[\lambda]$. The Cartier operator is defined by the formula

$$
\begin{equation*}
x^{a k-f} \frac{d x}{y^{a}} \mapsto \sum_{h=1}^{\eta(a) k}\left({ }^{a} G_{f}^{(\eta(a) k-h) p+p-1}(\lambda)\right)^{1 / p} x^{\eta(a) k-h} \frac{d x}{y^{\eta(a)}} . \tag{8.5}
\end{equation*}
$$

Let $\Omega^{1}(Y)^{*}$ be the space dual to $\Omega^{1}(Y)$. Let

$$
\begin{equation*}
\varphi_{a}^{i}, \quad a=1, \ldots, q-1, \quad i=1, \ldots, k a \tag{8.6}
\end{equation*}
$$

denote the basis of $\Omega^{1}(Y)^{*}$ dual to the basis $\left(x^{i-1} d x / y^{a}\right)$ of $\Omega_{a}^{1}(Y)$.
The map

$$
C^{*}: \Omega^{1}(Y)^{*} \rightarrow \Omega^{1}(Y)^{*}
$$

adjoint to the Cartier operator is $\sigma$-linear. The matrix of the map $C^{*}$ is called the HasseWitt matrix with respect to the basis $\left(\varphi_{a}^{i}\right)$. The entries of the Hasse-Witt matrix are the polynomials ${ }^{a} G_{f}^{(\eta(a) k-h) p+p-1}(\lambda)$, see (6.2).

For each $a=1, \ldots, q-1$, consider the columns of the Hasse-Witt matrix, corresponding to the basis vectors of $\Omega_{\eta(a)}^{1}(Y)^{*}$ and the rows corresponding to the basis vectors of $\Omega_{a}^{1}(Y)^{*}$. The respective block of the Hasse-Witt matrix of size $a k \times \eta(a) k$ is denoted by ${ }^{a} \mathcal{K}$. Its entries are denoted by

$$
\begin{equation*}
{ }^{a} \mathcal{K}_{f}^{h}(z):={ }^{a} G_{f}^{(\eta(a) k-h) p+p-1}(z), \quad f=1, \ldots, a k, \quad h=1, \ldots, \eta(a) k \tag{8.7}
\end{equation*}
$$

8.2. Example. For $p=5, q=3, n=4$, we have

$$
\begin{aligned}
& y^{3}=x(x-1)\left(x-\lambda_{3}\right)\left(x-\lambda_{4}\right) \\
& \Omega^{1}(Y)=\Omega_{1}^{1}(Y) \oplus \Omega_{2}^{1}(Y)=\left\langle\frac{d x}{y}\right\rangle \oplus\left\langle\frac{d x}{y^{2}}, x \frac{d x}{y^{2}}\right\rangle \\
& \frac{d x}{y} \mapsto\left({ }^{1} \mathcal{K}_{1}^{1}\right)^{1 / p} \frac{d x}{y^{2}}+\left({ }^{1} \mathcal{K}_{1}^{2}\right)^{1 / p} \frac{x d x}{y^{2}} \\
& \frac{d x}{y^{2}} \mapsto\left({ }^{2} \mathcal{K}_{1}^{1}\right)^{1 / p} \frac{d x}{y} \\
& \frac{x d x}{y^{2}} \mapsto\left({ }^{2} \mathcal{K}_{2}^{1}\right)^{1 / p} \frac{d x}{y}
\end{aligned}
$$

where

$$
\begin{aligned}
& { }^{1} \mathcal{K}_{1}^{1}(\lambda)=-\lambda_{3}^{3}-\lambda_{4}^{3}-9 \lambda_{3}^{2} \lambda_{4}-9 \lambda_{4}^{2} \lambda_{3}-9 \lambda_{3}^{2}-9 \lambda_{4}^{2}-9 \lambda_{3}-9 \lambda_{4}-27 \lambda_{3} \lambda_{4}-1, \\
& { }^{1} \mathcal{K}_{1}^{2}(\lambda)=3 \lambda_{3}^{2} \lambda_{4}^{2}\left(\lambda_{3} \lambda_{4}+\lambda_{3}+\lambda_{4}\right), \\
& { }^{2} \mathcal{K}_{1}^{1}(\lambda)=-\lambda_{3}-\lambda_{4}-1, \\
& { }^{2} \mathcal{K}_{2}^{1}(\lambda)=1 .
\end{aligned}
$$

The Hasse-Witt matrix is

$$
\left(\begin{array}{ccc}
0 & { }^{1} \mathcal{K}_{1}^{1}(\lambda) & { }^{1} \mathcal{K}_{1}^{2}(\lambda) \\
{ }^{2} \mathcal{K}_{1}^{1}(\lambda) & 0 & 0 \\
{ }^{2} \mathcal{K}_{2}^{1}(\lambda) & 0 & 0
\end{array}\right)
$$

8.3. Homogeneous polynomials ${ }^{a} \mathcal{J}_{f}^{h}(z)$. Change variables in the polynomial ${ }^{a} \mathcal{K}_{f}^{h}(\lambda)$,

$$
\lambda_{j}=\frac{z_{j}-z_{1}}{z_{2}-z_{1}}, \quad j=3, \ldots, n
$$

and multiply the result by $\left(z_{2}-z_{1}\right)^{(\eta(a) p-a) / q+(h-1) p-(f-1)}$.
Lemma 8.1. The function

$$
\begin{equation*}
{ }^{a} \mathcal{J}_{f}^{h}(z):=\left(z_{2}-z_{1}\right)^{(\eta(a) p-a) / q+(h-1) p-(f-1)} \cdot{ }^{a} \mathcal{K}_{f}^{h}(\lambda(z)) \tag{8.8}
\end{equation*}
$$

is a homogeneous polynomial in $z_{1}, \ldots, z_{n}$ of degree $(\eta(a) p-a) / q+(h-1) p-(f-1)$.
Remark. The polynomials ${ }^{a} \mathcal{J}_{f}^{h}(z)$ are entries of the Hasse-Witt matrix of the curve defined by equation

$$
y^{q}=x\left(x-\left(z_{2}-z_{1}\right)\right) \ldots\left(x-\left(z_{n}-z_{1}\right)\right)
$$

and that curve is isomorphic to the curve with equation

$$
y^{q}=\left(x-z_{1}\right)\left(x-z_{2}\right) \ldots\left(x-z_{n}\right),
$$

which is discussed in Section 6.
8.4. Formula for ${ }^{a_{s}} \mathcal{K}_{f}^{h}(\lambda)$. Recall the numbers $a_{s}$ introduced in (4.19), the base $p$ expansion

$$
\frac{p^{d}-1}{q}=A_{0}+A_{1} p+A_{2} p^{2}+\cdots+A_{d-1} p^{d-1}
$$

in (4.21), and the relation

$$
A_{s}=\frac{a_{s+1} p-a_{s}}{q}, \quad s=0, \ldots, d-1
$$

in Lemma 4.9 .
For $s \in \mathbb{Z}_{\geqslant 0}, f=1, \ldots, a_{s} k, h=1, \ldots, a_{s+1} k$, define the sets

$$
\begin{align*}
{ }^{s} \Delta_{f}^{h}=\left\{\left(\ell_{3}, \ldots, \ell_{n}\right) \in \mathbb{Z}_{\geqslant 0}^{n-2} \mid 0 \leqslant\right. & \sum_{i=3}^{n} \ell_{i}+f-1-(h-1) p \leqslant A_{s}  \tag{8.9}\\
& \left.\ell_{j} \leqslant A_{s} \text { for } j=3, \ldots, n\right\}
\end{align*}
$$

Lemma 8.2. We have

$$
\begin{equation*}
{ }^{a_{s}} \mathcal{K}_{f}^{h}(\lambda)=\sum_{\left(\ell_{3}, \ldots, \ell_{n}\right) \in \Delta^{s} \Delta_{f}^{h}}^{a_{s}} \mathcal{K}_{f ; \ell_{3}, \ldots, \ell_{n}}^{h}(\lambda), \tag{8.10}
\end{equation*}
$$

where

$$
\begin{align*}
& { }^{a_{s}} \mathcal{K}_{f ; \ell_{3}, \ldots, \ell_{n}}^{h}\left(\lambda_{3}, \ldots, \lambda_{n}\right)=(-1)^{A_{s}-f+1+(h-1) p}  \tag{8.11}\\
& \quad \times\binom{ A_{s}}{\sum_{i=3}^{n} \ell_{i}+f-1-(h-1) p} \prod_{i=3}^{n}\binom{A_{s}}{\ell_{i}} \lambda_{3}^{\ell_{3}} \ldots \lambda_{n}^{\ell_{n}} .
\end{align*}
$$

In particular all terms ${ }^{a_{s}} \mathcal{K}_{f ; \ell_{3}, \ldots, \ell_{n}}^{h}\left(\lambda_{3}, \ldots, \lambda_{n}\right)$ are nonzero.
Proof. The lemma is proved by straightforward calculation similar to the proof of Theorem 5.6.

Similar formulas can be obtained for all entries ${ }^{a} \mathcal{K}_{f}^{h}(\lambda)$.

## 9. Comparison of solutions over $\mathbb{C}$ and $\mathbb{F}_{p}$

In this section we will
(1) distinguish one holomorphic solution of the KZ equations for $\Lambda=(1, \ldots, 1)$,
(2) expand it into the Taylor series,
(3) reduce this Taylor expansion modulo $p$,
(4) observe that the reduction mod $p$ of the Taylor expansion of the distinguished solution gives all arithmetic solutions $\bmod p$, and conversely the arithmetic solutions together with matrix coefficients of the Hasse-Witt matrix determine this Taylor expansion.
9.1. Distinguished holomorphic solution. Consider the KZ equations (2.2) for $\Lambda=$ $(1, \ldots, 1)$ over the field $\mathbb{C}$. We assume that $n=q k+1$ as in Section 5.1.

Recall that the solutions have the form $I^{(\gamma)}(z)=\left(I_{1}(z), \ldots, I_{n}(z)\right)$, where

$$
I_{j}(z)=\int_{\gamma} \frac{1}{\sqrt[q]{\left(t-z_{1}\right) \ldots\left(t-z_{n}\right)}} \frac{d t}{t-z_{j}}
$$

and $\gamma$ is an oriented loop on the complex algebraic curve with equation

$$
y^{q}=\left(x-z_{1}\right) \ldots\left(x-z_{n}\right) .
$$

Assume that $z_{3}, \ldots, z_{n}$ are closer to $z_{1}$ than to $z_{2}$ :

$$
\left|\frac{z_{j}-z_{1}}{z_{2}-z_{1}}\right|<\frac{1}{2}, \quad j=3, \ldots, n
$$

Choose $\gamma$ to be the circle $\left\{t \in \mathbb{C}\left|\left|\frac{t-z_{1}}{z_{2}-z_{1}}\right|=\frac{1}{2}\right\}\right.$ oriented counter-clockwise, and multiply the vector $I(z)$ by the normalization constant $(-1)^{1 / q} / 2 \pi i$.

We will describe the normalization procedure of the solution $I(z)$ more precisely in Section 9.2.

We call the solution $I(z)$ the distinguished solution.
9.2. Rescaling. Change variables, $t=\left(z_{2}-z_{1}\right) x+z_{1}$, and write

$$
\begin{equation*}
I\left(z_{1}, \ldots, z_{n}\right)=\left(z_{2}-z_{1}\right)^{-1 / q-k} L\left(\lambda_{3}, \ldots, \lambda_{n}\right) \tag{9.1}
\end{equation*}
$$

where

$$
\lambda=\left(\lambda_{3}, \ldots, \lambda_{n}\right)=\left(\frac{z_{3}-z_{1}}{z_{2}-z_{1}}, \ldots, \frac{z_{n}-z_{1}}{z_{2}-z_{1}}\right)
$$

$L(\lambda)=\left(L_{1}, \ldots, L_{n}\right)$,

$$
\begin{equation*}
L_{j}=\frac{(-1)^{1 / q}}{2 \pi i} \int_{|x|=1 / 2} \frac{d x}{\sqrt[q]{x(x-1)\left(x-\lambda_{3}\right) \ldots\left(x-\lambda_{n}\right)}} \frac{1}{x-\lambda_{j}} \tag{9.2}
\end{equation*}
$$

and $\lambda_{1}=0, \lambda_{2}=1$.
The integral $L(\lambda)$ is well-defined at $\left(\lambda_{3}, \ldots, \lambda_{n}\right)=(0 \ldots, 0)$ and

$$
L_{j}(0, \ldots, 0)=\frac{(-1)^{1 / q}}{2 \pi i} \int_{|x|=1 / 2} \frac{d x}{x^{k} \sqrt[q]{x-1}} \frac{1}{x-\lambda_{j}}
$$

The $q$-valued function

$$
\frac{(-1)^{1 / q}}{x^{k} \sqrt[q]{x-1}}
$$

has no monodromy over the circle $|x|=1 / 2$. To fix the value of the integrals in (9.2) we choose over the circle $|x|=1 / 2$ that branch of the $q$-valued function

$$
\frac{(-1)^{1 / q}}{\sqrt[q]{x(x-1)\left(x-\lambda_{3}\right) \ldots\left(x-\lambda_{n}\right)}}
$$

which is positive at $x=1 / 2$ and $\left(\lambda_{3}, \ldots, \lambda_{n}\right)=(0 \ldots, 0)$.

## HYPERGEOMETRIC INTEGRALS MODULO $p$

The function $L(\lambda)$ is holomorphic at the point $\left(\lambda_{3}, \ldots, \lambda_{n}\right)=(0, \ldots, 0)$. Hence

$$
\begin{equation*}
L(\lambda)=\sum_{\left(k_{3}, \ldots, k_{n}\right) \in \mathbb{Z}_{\geqslant 0}^{n-2}} L_{k_{3}, \ldots, k_{n}} \lambda_{3}^{k_{3}} \ldots \lambda_{n}^{k_{n}} \tag{9.3}
\end{equation*}
$$

for suitable complex numbers $L_{k_{3}, \ldots, k_{n}}$ in a neighborhood of the point $(0, \ldots, 0)$.

### 9.3. Taylor expansion of $L(\lambda)$.

Lemma 9.1. We have

$$
\begin{align*}
L_{k_{3}, \ldots, k_{n}} & =(-1)^{k}\binom{-1 / q}{k_{3}+\cdots+k_{n}+k} \prod_{i=3}^{n}\binom{-1 / q}{k_{i}}  \tag{9.4}\\
& \times\left(1,-q\left(\sum_{i=3}^{n} k_{i}+k\right), q k_{3}+1, \ldots, q k_{n}+1\right)
\end{align*}
$$

where the integer $k$ is defined by the equation $n=q k+1$.
Proof. Indeed,

$$
\begin{aligned}
L_{1}(\lambda) & =\sum_{k_{3}, \ldots, k_{n}=0}^{\infty} \frac{\lambda_{3}^{k_{3}} \ldots \lambda_{n}^{k_{n}}}{k_{3}!\ldots k_{n}!} \frac{\partial^{k_{3}+\cdots+k_{n}} L_{1}}{\partial \lambda_{3}^{k_{3}} \ldots \partial \lambda_{n}^{k_{n}}}(0) \\
& =\frac{(-1)^{1 / q}}{2 \pi i} \sum_{k_{3}, \ldots, k_{n}=0}^{\infty} \lambda_{3}^{k_{3}} \ldots \lambda_{n}^{k_{n}}(-1)^{\sum_{i=3}^{n} k_{i}} \prod_{i=3}^{n}\binom{-1 / q}{k_{i}} \\
& \times \int_{|x|=1 / 2} x^{-(n-1) / q-\sum_{i=3}^{n} k_{i}-1}(x-1)^{-1 / q} d x \\
& =(-1)^{k} \sum_{k_{3}, \ldots, k_{n}=0}^{\infty} \lambda_{3}^{k_{3}} \ldots \lambda_{n}^{k_{n}}\binom{-1 / q}{\sum_{i=3}^{n} k_{i}+k} \prod_{i=3}^{n}\binom{-1 / q}{k_{i}} .
\end{aligned}
$$

Similarly,

$$
L_{2}(\lambda)=(-1)^{k} \sum_{k_{3}, \ldots, k_{n}=0}^{\infty} \lambda_{3}^{k_{3}} \ldots \lambda_{n}^{k_{n}}\binom{-1 / q}{\sum_{i=3}^{n} k_{i}+k} \prod_{i=3}^{n}\binom{-1 / q}{k_{i}}\left(-q\left(\sum_{i=3}^{n} k_{i}+k\right)\right)
$$

and

$$
L_{j}(\lambda)=(-1)^{k} \sum_{k_{3}, \ldots, k_{n}=0}^{\infty} \lambda_{3}^{k_{3}} \ldots \lambda_{n}^{k_{n}}\binom{-1 / q}{\sum_{i=3}^{n} k_{i}+k} \prod_{i=3}^{n}\binom{-1 / q}{k_{i}}\left(q k_{j}+1\right)
$$

for $j=3, \ldots, n$. The lemma is proved.
Corollary 9.2. Each coefficient of the series $L(\lambda)$ is well-defined modulo $p$.
Proof. The corollary follows from Theorem 4.2.
9.4. Coefficients $L_{k_{3}, \ldots, k_{n}}$ nonzero modulo $p$. Let $\left(k_{3}, \ldots, k_{n}\right) \in \mathbb{Z}_{\geqslant 0}^{n-2}$ with

$$
k_{i}=k_{i}^{0}+k_{i}^{1} p+\cdots+k_{i}^{b} p^{b}, \quad 0 \leqslant k_{i}^{j} \leqslant p-1, \quad i=3, \ldots, n,
$$

the base $p$ expansions. Assume that not all numbers $k_{i}^{b}, i=3, \ldots, n$, are equal to zero.
Recall the base $p$ expansion

$$
\frac{p^{d}-1}{q}=A_{0}+A_{1} p+A_{2} p^{2}+\cdots+A_{d-1} p^{d-1}, \quad A_{s}=\frac{a_{s+1} p-a_{s}}{q}
$$

Extend the sequence $\left(A_{s}\right) d$-periodically,

$$
\begin{equation*}
A_{s+d}:=A_{s} \tag{9.5}
\end{equation*}
$$

Lemma 9.3. We have $\prod_{i=3}^{n}\binom{-1 / q}{k_{i}} \not \equiv 0(\bmod p)$ if and only if

$$
\begin{equation*}
k_{i}^{s} \leqslant A_{s} \tag{9.6}
\end{equation*}
$$

for $i=3, \ldots, n, s=0, \ldots, b$.
Proof. The lemma follows from Theorem 4.2.
Lemma 9.4. Assume that condition (9.6) holds. Then for $s=0, \ldots, b$, we have

$$
\begin{equation*}
\sum_{i=3}^{n} k_{i}^{s}+a_{s} k<a_{s+1} k p \tag{9.7}
\end{equation*}
$$

Proof. We have

$$
\begin{aligned}
\sum_{i=3}^{n} k_{i}^{s} & \leqslant(n-2) A_{s}=(q k-1) A_{s}=q k \frac{a_{s+1} p-a_{s}}{q}-A_{s} \\
& =a_{s+1} k p-a_{s} k-A_{s}<a_{s+1} k p-a_{s} k,
\end{aligned}
$$

where the last inequality follows from the inequality $0<A_{s}$, see (4.23).
Following [V5] define the shift coefficients $\left(m_{0}, \ldots, m_{b+1}\right)$ as follows. Define $m_{0}=k+1$. For $s=0$ formula (9.7) takes the form

$$
\sum_{i=3}^{n} k_{i}^{0}+m_{0}-1<a_{1} k p
$$

since $a_{0}=1$. Hence there exists a unique integer $m_{1}, 1 \leqslant m_{1} \leqslant a_{1} k$, such that

$$
0 \leqslant \sum_{i=3}^{n} k_{i}^{0}+m_{0}-1-\left(m_{1}-1\right) p<p
$$

For $s=1$ formula (9.7) takes the form

$$
\sum_{i=3}^{n} k_{i}^{1}+a_{1} k<a_{2} k p
$$

By construction $m_{1} \leqslant a_{1} k$, hence

$$
\sum_{i=3}^{n} k_{i}^{1}+m_{1}-1<a_{2} k p
$$

Therefore, there exists a unique integer $m_{2}, 1 \leqslant m_{2} \leqslant a_{2} k$, such that

$$
0 \leqslant \sum_{i=3}^{n} k_{i}^{1}+m_{1}-1-\left(m_{2}-1\right) p<p
$$

and so on.
We will obtain $m_{s}$ with $1 \leqslant m_{s} \leqslant a_{s} k$ for $s=1, \ldots, b$. We define $m_{b+1}$ to be the unique integer such that $1 \leqslant m_{b+1} \leqslant a_{b+1} k$ and

$$
0 \leqslant \sum_{i=3}^{n} k_{i}^{b}+m_{b}-1-\left(m_{b+1}-1\right) p<p
$$

We say that a tuple $\left(k_{3}, \ldots, k_{n}\right)$ is admissible with respect to $p$ if the following inequalities hold

$$
\begin{array}{ll}
k_{i}^{s} \leqslant A_{s}, & i=3, \ldots, n, s=0, \ldots, b \\
\sum_{i=3}^{n} k_{i}^{s}+m_{s}-1-\left(m_{s+1}-1\right) p \leqslant A_{s}, & s=0, \ldots, b \\
m_{b+1}-1 \leqslant A_{b+1} \tag{9.10}
\end{array}
$$

Lemma 9.5. We have

$$
\binom{-1 / q}{k_{3}+\cdots+k_{n}+k} \not \equiv 0 \quad(\bmod p)
$$

if and only if the shift coefficients of the tuple $\left(k_{3}, \ldots, k_{n}\right)$ satisfy (9.9) and (9.10).
Proof. The $p$-ary expansion of $k_{3}+\cdots+k_{n}+k$ is

$$
\begin{aligned}
& \left(\sum_{i=3}^{n} k_{i}^{0}+m_{0}-1-\left(m_{1}-1\right) p\right)+\left(\sum_{i=3}^{n} k_{i}^{1}+m_{1}-1-\left(m_{2}-1\right) p\right) p+\ldots \\
& \quad+\left(\sum_{i=3}^{n} k_{i}^{b}+m_{b}-1-\left(m_{b+1}-1\right) p\right) p^{b}+\left(m_{b+1}-1\right) p^{b+1}
\end{aligned}
$$

By Theorem 4.2 the following congruence holds modulo $p$ :

$$
\binom{-1 / q}{k_{3}+\cdots+k_{n}+k} \equiv\binom{A_{b+1}}{m_{b+1}-1} \cdot \prod_{s=0}^{b}\binom{A_{s}}{\sum_{i=3}^{n} k_{i}^{s}+m_{s}-1-\left(m_{s+1}-1\right) p} .
$$

The right-hand side of the congruence above is nonzero, if and only if (9.9) and (9.10) hold.

Recall the sets ${ }^{s} \Delta_{f}^{h}$ defined in (8.9).
Lemma 9.6. The tuple $\left(k_{3}, \ldots, k_{n}\right)$ is admissible if and only if $m_{b+1}-1 \leqslant A_{b+1}$ and

$$
\left(k_{3}^{s}, \ldots, k_{n}^{s}\right) \in{ }^{s} \Delta_{m_{s}}^{m_{s+1}} \quad \text { for } s=0, \ldots, b
$$

Theorem 9.7. The following statements hold true:
(i) $L_{k_{3}, \ldots, k_{n}} \not \equiv 0(\bmod p)$ if and only if the tuple $\left(k_{3}, \ldots, k_{n}\right)$ is admissible.
(ii) If the tuple $\left(k_{3}, \ldots, k_{n}\right)$ is admissible, then

$$
\begin{align*}
& L_{k_{3}, \ldots, k_{n}} \lambda_{3}^{k_{3}} \ldots \lambda_{n}^{k_{n}} \equiv(-1)^{\left(a_{b+1} p^{b+1}-1\right) / q+m_{b+1}-1}\binom{A_{b+1}}{m_{b+1}-1}  \tag{9.11}\\
& \quad \times\left(\prod_{s=1}^{b}{ }^{a_{s}} \mathcal{K}_{m_{s} ; k_{3}^{s}, \ldots, k_{n}^{s}}^{m_{s+1}}\left(\lambda_{3}^{p^{s}}, \ldots, \lambda_{n}^{p^{s}}\right)\right) K_{k_{3}^{0}, \ldots, k_{n}^{0}}^{m_{1}}(\lambda) \quad(\bmod p),
\end{align*}
$$

where ${ }^{a_{s} \mathcal{K}_{f ; \vec{k}}^{h}}(\lambda)$ are terms of the Hasse-Witt matrix expansion in (8.10) and $K_{\vec{k}}^{m}(\lambda)$ are the terms of the expansion of vector polynomial $K^{m}(\lambda)$ in (5.22).
Proof. We have $L_{k_{3}, \ldots, k_{n}} \not \equiv 0(\bmod p)$ if and only if each of the binomial coefficients in (9.4) is not divisibly by $p$. By Lemmas 9.3 and 9.5 this is equivalent to saying that the tuple $\left(k_{3}, \ldots, k_{n}\right)$ is admissible. This gives part (i).

By Lemma 9.1 we have

$$
\begin{align*}
L_{k_{3}, \ldots, k_{n}} & =(-1)^{k}\binom{-1 / q}{k_{3}+\cdots+k_{n}+k} \prod_{i=3}^{n}\binom{-1 / q}{k_{i}}  \tag{9.12}\\
& \times\left(1,-q\left(\sum_{i=3}^{n} k_{i}+k\right), q k_{3}+1, \ldots, q k_{n}+1\right) .
\end{align*}
$$

Theorem 4.2 allows us to write the binomial coefficients in formula (9.12) as products and then formula (9.11) becomes a straightforward corollary of formulas for ${ }^{a_{s}} \mathcal{K}_{f ; \vec{k}}^{h}$ and $K_{\vec{k}}^{m}$.

Notice that calculating the power of -1 in the right-hand side of formula (9.11) we use the identity

$$
A_{0}+A_{1} p+\cdots+A_{b} p^{b}=\frac{a_{1} p-1}{q}+\frac{a_{2} p-a_{1}}{q} p+\cdots+\frac{a_{b+1} p-a_{b}}{q} p^{b}=\frac{a_{b+1} p^{b+1}-1}{q} .
$$

9.5. Decomposition of $L(\lambda)$ as a sum of $K^{m}(\lambda)$. Define the set

$$
\begin{array}{r}
M=\left\{\left(m_{0}, \ldots, m_{b+1}\right) \in \mathbb{Z}_{\geqslant 1}^{b+2} \mid b \in \mathbb{Z}_{\geqslant 0}, m_{0}=k+1,1 \leqslant m_{s} \leqslant a_{s} k\right.  \tag{9.13}\\
\text { for } \left.s=1, \ldots, b, 1 \leqslant m_{b+1} \leqslant a_{b+1} k\right\} .
\end{array}
$$

For any $\vec{m}=\left(m_{0}, \ldots, m_{b+1}\right) \in M$, define the $n$-vector of polynomials in $\lambda$ :

$$
\begin{align*}
N_{\vec{m}}(\lambda) & =(-1)^{\left(a_{b+1} p^{b+1}-1\right) / q+m_{b+1}-1}\binom{A_{b+1}}{m_{b+1}-1}  \tag{9.14}\\
& \times\left(\prod_{s=1}^{b}{ }^{a_{s}} \mathcal{K}_{m_{s}}^{m_{s+1}}\left(\lambda_{3}^{p^{s}}, \ldots, \lambda_{n}^{p^{s}}\right)\right) K^{m_{1}}\left(\lambda_{3}, \ldots, \lambda_{n}\right)
\end{align*}
$$

Theorem 9.8. We have

$$
\begin{equation*}
L(\lambda) \equiv \sum_{\vec{m} \in M} N_{\vec{m}}(\lambda) \quad(\bmod p) \tag{9.15}
\end{equation*}
$$

Moreover, if a monomial $\lambda_{3}^{k_{3}} \ldots \lambda_{n}^{k_{n}}$ enters one of the vector polynomials $N_{\vec{m}}(\lambda)$ with a nonzero coefficient, then this monomial does not enter with nonzero coefficient any other vector polynomial $N_{\vec{m}^{\prime}}(\lambda)$.

Proof. The theorem is a straightforward corollary of Theorem 5.6, Lemma 8.2, and Theorem 9.7.

For $q=2$ this theorem is [V5, Corollary 7.4].
9.6. Distinguished solution over $\mathbb{C}$ and solutions $J^{m}(z)$ over $\mathbb{F}_{p}$. Consider the distinguished solution $I\left(z_{1}, \ldots, z_{n}\right)$ of the KZ equations (2.2) over $\mathbb{C}$, see (9.1), and the arithmetic solutions $J^{m}(z)$ of the same equations over $\mathbb{F}_{p}$, see (5.10).

We have

$$
\begin{align*}
I\left(z_{1}, \ldots, z_{n}\right) & =\left(z_{2}-z_{1}\right)^{-1 / q-k} \cdot L\left(\lambda_{3}, \ldots, \lambda_{n}\right),  \tag{9.16}\\
J^{m}(z) & =\left(z_{2}-z_{1}\right)^{\left(a_{1} p-1\right) / q+(m-1) p-k} \cdot K^{m}(\lambda),  \tag{9.17}\\
{ }^{a} \mathcal{J}_{f}^{h}(z) & =\left(z_{2}-z_{1}\right)^{(\eta(a) p-a) / q+(h-1) p-(f-1)} \cdot{ }^{a} \mathcal{K}_{f}^{h}(\lambda(z)), \tag{9.18}
\end{align*}
$$

see (9.1), (5.15), and (8.8).
Expressing $L\left(\lambda_{3}, \ldots, \lambda_{n}\right), K^{m}(\lambda), \mathcal{K}_{f}^{h}(\lambda(z))$ in terms of $I\left(z_{1}, \ldots, z_{n}\right), J^{m}(z),{ }^{a} \mathcal{J}_{f}^{h}(z)$ from these equations, and using the congruence

$$
\begin{equation*}
L(\lambda) \equiv \sum_{\vec{m} \in M} N_{\vec{m}}(\lambda) \quad(\bmod p) \tag{9.19}
\end{equation*}
$$

of Theorem 9.8, we obtain a relation between the distinguished holomorphic solution $I(z)$ and the arithmetic data $J^{m}(z)$ and ${ }^{a} \mathcal{J}_{f}^{h}(z)$.

This relation shows that knowing the distinguished holomorphic solution we may recover the arithmetic solutions as well as the entries of the associated Hasse-Witt matrix. Conversely, knowing the arithmetic solutions and the entries of the associated Hasse-Witt matrix, we may recover the distinguished holomorphic solution modulo $p$.

Remark. Notice that summands in the right-hand side of (9.15) correspond to the iterated arithmetic solutions defined in Section 6.6. We may interpret formula (9.15) as a statement that the Taylor expansion of the distinguished holomorphic solution reduced modulo $p$ is the sum of all iterated arithmetic solutions.
