# DEGREE BOUNDS FOR MODULAR COVARIANTS 

JONATHAN ELMER AND MÜFIT SEZER


#### Abstract

Let $V, W$ be representations of a cyclic group $G$ of prime order $p$ over a field $\mathbb{k}$ of characteristic $p$. The module of covariants $\mathbb{k}[V, W]^{G}$ is the set of $G$-equivariant polynomial maps $V \rightarrow W$, and is a module over $\mathbb{k}[V]^{G}$. We give a formula for the Noether bound $\beta\left(\mathbb{k}[V, W]^{G}, \mathbb{k}[V]^{G}\right)$, i.e. the minimal degree $d$ such that $\mathbb{k}[V, W]^{G}$ is generated over $\mathbb{k}[V]^{G}$ by elements of degree at most $d$.


## 1. Introduction

Let $G$ be a finite group, $\mathbb{k}$ a field and $V, W$ a pair of finite-dimensional $\mathbb{k} G$ modules. Let $\mathbb{k}[V]$ denote the symmetric algebra on the dual $V^{*}$ of $V$ and let $\mathbb{k}[V, W]=\mathbb{k}[V] \otimes_{\mathfrak{k}} W$. Elements of $\mathbb{k}[V]$ represent polynomial functions $V \rightarrow \mathbb{k}$ and elements of $\mathbb{k}[V, W]$ represent polynomial functions $V \rightarrow W$; for $f \otimes w \in \mathbb{k}[V, W]$ the corresponding function takes $v$ to $f(v) w . G$ acts by algebra automorphisms on $\mathbb{k}[V]$ and hence diagonally on $\mathbb{k}[V, W]$. The fixed points $\mathbb{k}[V, W]^{G}$ of this action are called covariants and represent $G$-equivariant polynomial functions $V \rightarrow W$. The the fixed points $\mathbb{k}[V]^{G}$ are called invariants. For $f \in \mathbb{k}[V]^{G}$ and $\phi \in \mathbb{k}[V, W]^{G}$ we define the product

$$
f \phi(v)=f(v) \phi(v) .
$$

Then $\mathbb{k}[V]^{G}$ is a $\mathbb{k}$-algebra and $\mathbb{k}[V, W]^{G}$ is a finite $\mathbb{k}[V]^{G}$-module. Modules of covariants in the non-modular case $(|G| \neq 0 \in \mathbb{k})$ were studied by Chevalley [3], Shephard-Todd [10, Eagon-Hochster [7. In the modular case far less is known, but recent work of Broer and Chuai [1] has shed some light on the subject. A systematic attempt to construct generating sets for modules of covariants when $G$ is a cyclic group of order $p$ was begun by the first author in 5 .

Let $A=\oplus_{d \geq 0} A_{d}$ be any graded $\mathbb{k}$-algebra and $M=\sum_{d \geq 0} M_{d}$ any graded $A$ module. Then the Noether bound $\beta(A)$ is defined to be the minimum degree $d>0$ such that $A$ is generated by the set $\left\{a: a \in A_{k}, k \leq d\right\}$. Similarly, $\beta(M, A)$ is defined to be the minimum degree $d>0$ such that $M$ is generated over $A$ by the set $\left\{m: m \in M_{k}, k \leq d\right\}$, and we sometimes write $\beta(M)=\beta(M, A)$ when the context is clear.

Noether famously showed that $\beta\left(\mathbb{C}[V]^{G}\right) \leq|G|$ for arbitrary finite $G$, but computing Noether bounds in the modular case is highly nontrivial. When $G$ is cyclic of prime order, the second author along with Fleischmann, Shank and Woodcock [6] determined the Noether bound for any $\mathbb{k} G$-module. The purpose of this short article is to find results similar to those in [6] for covariants. Our main result can be stated concisely as:

Theorem 1. Let $G$ be a cyclic group of order $p, \mathbb{k}$ a field of characteristic $p, V$ a reduced $\mathbb{k} G$-module and $W$ a nontrivial indecomposable $\mathbb{k} G$-module. Then

\beta\left(\mathbb{k}[V, W]^{G}\right)=\beta\left(\mathbb{k}[V]^{G}\right)
$$
unless $V$ is indecomposable of dimension 2.

## 2. Preliminaries

For the rest of this article, $G$ denotes a cyclic group of order $p>0$, and we let $\mathbb{k}$ be a field of characteristic $p$. We choose a generator $\sigma$ for $G$. Over $\mathbb{k}$, there are $p$ indecomposable representations $V_{1}, \ldots, V_{p}$ and each indecomposable representation $V_{i}$ is afforded by a Jordan block of size $i$. Note that $V_{p}$ is isomorphic to the free module $\mathbb{k} G$, and this is the unique free indecomposable $\mathbb{k} G$-module.

Let $\Delta=\sigma-1 \in \mathbb{k} G$. We define the transfer map $\operatorname{Tr}: \mathbb{k}[V] \rightarrow \mathbb{k}[V]$ by $\sum_{1 \leq i \leq p} \sigma^{i}$. Notice that we also have $\operatorname{Tr}=\Delta^{p-1}$. Invariants that are in the image of $\operatorname{Tr}$ are called transfers.

Remark 2. Let $e_{1}, \ldots, e_{i}$ be an upper triangular basis for the $i$-dimensional indecomposable representation $V_{i}$. The $\Delta\left(e_{j}\right)=e_{j-1}$ for $2 \leq j \leq i$ and $\Delta\left(e_{1}\right)=0$. Therefore $\Delta^{j}\left(V_{i}\right)=0$ for all $j \geq i$. Note that for an indecomposable module $V_{i}$ we have $\Delta\left(V_{i}\right) \cong V_{i-1}$ for $2 \leq i \leq p$ and $\Delta\left(V_{1}\right)=0$. It follows that an invariant $f$ is in the image of the linear map $\Delta^{j}: \mathbb{k}[V] \rightarrow \mathbb{k}[V]$ if and only if it is a linear combination of fixed points in indecomposable modules of dimension at least $j+1$. In particular, an invariant is in the image of the transfer map $\left(=\Delta^{p-1}\right)$ if and only if it is a linear combination of fixed points of free $\mathbb{k} G$-modules.

We assume that $V$ and $W$ are $\mathbb{k} G$-modules with $W$ indecomposable and we choose a basis $w_{1}, \ldots, w_{n}$ for $W$ so that we have

$$
\sigma w_{i}=\sum_{1 \leq j \leq i}(-1)^{i-j} w_{j}
$$

for $1 \leq i \leq n$. For $f \in \mathbb{k}[V]$ we define the weight of $f$ to be the smallest positive integer $d$ with $\Delta^{d}(f)=0$. Note that $\Delta^{p}=(\sigma-1)^{p}=0$, so the weight of a polynomial is at most $p$.

A useful description of covariants is given in [5]. We include this description here for completeness.

Proposition 3. [5, Proposition 3] Let $f \in \mathbb{k}[V]$ with weight $d \leq n$. Then

$$
\sum_{1 \leq j \leq d} \Delta^{j-1}(f) w_{j} \in \mathbb{k}[V, W]^{G}
$$

Conversely, if

$$
f_{1} w_{1}+f_{2} w_{2}+\cdots+f_{n} w_{n} \in \mathbb{k}[V, W]^{G}
$$

then there exists $f \in \mathbb{k}[V]$ with weight $\leq n$ such that $f_{j}=\Delta^{j-1}(f)$ for $1 \leq j \leq n$.
For a non-zero covariant $h=f_{1} w_{1}+f_{2} w_{2}+\cdots+f_{n} w_{n}$, we define the support of $h$ to be the largest integer $j$ such that $f_{j} \neq 0$. We denote the support of $h$ by $s(h)$. We shall say $h$ is a transfer covariant if there exists a non-negative integer $k$ and $f \in \mathbb{k}[V]$ such that $f_{1}=\Delta^{k}(f), f_{2}=\Delta^{k+1}(f), \cdots, f_{s(h)}=\Delta^{p-1}(f)$ for some $f \in \mathbb{k}[V]$.

We call a homogeneous invariant in $\mathbb{k}[V]^{G}$ indecomposable if it is not in the subalgebra of $\mathbb{k}[V]^{G}$ generated by invariants of strictly smaller degree. Similarly, a homogeneous covariant in $\mathbb{k}[V, W]^{G}$ is indecomposable if it does not lie in the submodule of $\mathbb{k}[V, W]^{G}$ generated by covariants of strictly smaller degree.

## 3. Upper bounds

We first prove a result on decomposability of a transfer covariant. In the proof below we set $\gamma=\beta\left(\mathbb{k}[V], \mathbb{k}[V]^{G}\right)$.
Proposition 4. Let $f \in \mathbb{k}[V]$ be homogeneous and $h=\Delta^{k}(f) w_{1}+\Delta^{k+1}(f) w_{2}+$ $\cdots+\Delta^{p-1}(f) w_{s(h)}$ be a transfer covariant of degree $>\gamma$. Then $h$ is decomposable.

Proof. Let $g_{1}, \ldots, g_{t}$ be a set of homogeneous polynomials of degree at most $\gamma$ generating $\mathbb{k}[V]$ as a module over $\mathbb{k}[V]^{G}$. So we can write $f=\sum_{1 \leq i \leq t} q_{i} g_{i}$, where each $q_{i} \in \mathbb{k}[V]_{+}^{G}$ is a positive degree invariant. Since $\Delta^{j}$ is $\mathbb{k}[V]^{G}$-linear, we have $\Delta^{j}(f)=\sum_{1 \leq i \leq t} q_{i} \Delta^{j}\left(g_{i}\right)$ for $k \leq j \leq p-1$. It follows that

$$
h=\sum_{1 \leq i \leq t} q_{i}\left(\Delta^{k}\left(g_{i}\right) w_{1}+\cdots+\Delta^{p-1}\left(g_{i}\right) w_{s(h)}\right)
$$

Note that $\Delta^{k}\left(g_{i}\right) w_{1}+\cdots+\Delta^{p-1}\left(g_{i}\right) w_{s(h)}$ is a covariant for each $1 \leq i \leq t$ by Proposition [3. We also have $q_{i} \in \mathbb{k}[V]_{+}^{G}$ so it follows that $h$ is decomposable.

Write $V=\oplus_{j=1}^{m} V_{n_{j}}$ as a sum of indecomposable modules. Note that $\mathbb{k}[V \oplus$ $\left.\left.V_{1}, W\right]^{G}=\left(S\left(V^{*}\right) \otimes S\left(V_{1}^{*}\right)\right) \otimes W\right)^{G}=\mathbb{k}[V, W]^{G} \otimes \mathbb{k}\left[V_{1}\right]$. Therefore we will assume that $n_{j}>1$ for all $j$; such representations are called reduced. Choose a basis $\left\{x_{i, j} \mid 1 \leq i \leq n_{j}, 1 \leq j \leq m\right\}$ for $V^{*}$, with respect to which we have

$$
\sigma\left(x_{i, j}\right)= \begin{cases}x_{i, j}+x_{i+1, j} & i<n_{j} \\ x_{i, j} & i=n_{j}\end{cases}
$$

This induces a multidegree on $\mathbb{k}[V]=\oplus_{\mathbf{d} \in \mathbb{N}^{m}} \mathbb{k}[V]_{\mathbf{d}}$ which is compatible with the action of $G$. For $1 \leq j \leq m$ we define $N_{j}=\prod_{k=0}^{p-1} \sigma^{k} x_{1, j}$, and note that the coefficient of $x_{1, j}^{p}$ in $N_{j}$ is 1 . Given any $f \in \mathbb{k}\left[V_{n_{j}}\right]$, we can therefore perform long division, writing

$$
\begin{equation*}
f=q_{j} N_{j}+r \tag{1}
\end{equation*}
$$

where $q_{j} \in \mathbb{k}\left[V_{n_{j}}\right]$ for all $j$ and $r \in \mathbb{k}\left[V_{n_{j}}\right]$ has degree $<p$ in the variable $x_{1, j}$. This induces a vector space decomposition

$$
\mathbb{k}\left[V_{n_{j}}\right]=N_{j} \mathbb{k}\left[V_{n_{j}}\right] \oplus B_{j}
$$

where $B_{j}$ is the subspace of $\mathbb{k}\left[V_{n_{j}}\right]$ spanned by monomials with $x_{1, j}$-degree $<p$, but the form of the action implies that $B_{j}$ and its complement are $\mathbb{k} G$-modules, so we obtain a $\mathbb{k} G$-module decomposition. Since $\mathbb{k}[V]=\otimes_{j=1}^{m} \mathbb{k}\left[V_{n_{j}}\right]$, it follows that

$$
\mathbb{k}[V]=N_{j} \mathbb{k}[V] \oplus\left(B_{j} \otimes \mathbb{k}\left[V^{\prime}\right]\right)
$$

where $V^{\prime}=V_{n_{1}} \oplus \cdots \oplus V_{n_{j-1}} \oplus V_{n_{j+1}} \cdots \oplus V_{n_{m}}$. From this decomposition it follows that if $M$ is a $\mathbb{k} G$ direct summand of $\mathbb{k}[V]_{d}$, then $N_{j} M$ is a $\mathbb{k} G$ direct summand of $\mathbb{k}[V]_{d+p}$ with the same isomorphism type. Further, any $f \in \mathbb{k}[V]^{G}$ can be written as $f=q N_{j}+r$ with $q \in \mathbb{k}[V]^{G}$ and $r \in\left(B_{j} \otimes \mathbb{k}\left[V^{\prime}\right]\right)^{G}$. If in addition $\operatorname{deg}(f)=$ $\left(d_{1}, d_{2}, \ldots, d_{m}\right)$ with $d_{j}>p-n_{j}$, then the degree $d_{j}$ homogeneous component of $B_{j}$ is free by [8, 2.10] and since tensoring a module with a free (projective) module gives a free (projective) module we may further assume, by Remark 2, that $r$ is in the image of the transfer map.

If $h=\sum_{i=1}^{s(h)} \Delta^{i-1}(f) w_{i} \in \mathbb{k}[V, W]^{G}$, we define the multidegree of $h$ to be that of $f$. Since $G$ preserves the multidegree, this is the same as the multidegree of $\Delta^{i-1}(f)$ for all $i \leq s(h)$. Then the analogue of this result for covariants is the following:

Proposition 5. Let $h$ be a covariant of multidegree $d_{1}, d_{2}, \ldots, d_{m}$ with $d_{j}>p-n_{j}$ for some $j$. Then there exists a covariant $h_{1}$ and a transfer covariant $h_{2}$ such that $h=N_{j} h_{1}+h_{2}$.

Proof. We proceed by induction on the support $s(h)$ of $h$. If $s(h)=1$, then by Proposition 3, we have that $h=f w_{1}$ with $f \in \mathbb{k}[V]^{G}$. Then we can write $f=$ $q N_{j}+\Delta^{p-1}(t)$ for some $q \in \mathbb{k}[V]^{G}$ and $t \in \mathbb{k}[V]$. Then both $q w_{1}$ and $\Delta^{p-1}(t) w_{1}$ are covariants by Proposition 3 and therefore $h=q N_{j} w_{1}+\Delta^{p-1}(t) w_{1}$ gives us the desired decomposition.

Now assume that $s(h)=k$. Then by Proposition 3 there exists $f \in \mathbb{k}[V]$ such that

$$
h=f w_{1}+\Delta(f) w_{2}+\cdots+\Delta^{k-1}(f) w_{k}
$$

with $\Delta^{k}(f)=0$. Since $\Delta^{k-1}(f) \in \mathbb{k}[V]^{G}$ and $d_{j}>p-n_{j}$, we can write $\Delta^{k-1}(f)=$ $q N_{j}+\Delta^{p-1}(t)$ for some $q \in \mathbb{k}[V]^{G}$ and $t \in \mathbb{k}[V]$. It follows that $q N_{j}$ is in the image of $\Delta^{k-1}$. But since multiplication by $N_{j}$ preserves the isomorphism type of a module, it follows that $q$ is in the image of $\Delta^{k-1}$. Write $q=\Delta^{k-1}\left(f^{\prime}\right)$ with $f^{\prime} \in \mathbb{k}[V]$. Set $h_{1}=f^{\prime} w_{1}+\Delta\left(f^{\prime}\right) w_{2}+\cdots+\Delta^{k-1}\left(f^{\prime}\right) w_{k}$ and $h_{2}=\Delta^{p-k}(t) w_{1}+\cdots+\Delta^{p-1}(t) w_{k}$. Since $\Delta^{k-1}\left(f^{\prime}\right) \in \mathbb{k}[V]^{G}, h_{1}$ is a covariant by Proposition 3. Consider the covariant $h^{\prime}=h-N_{j} h_{1}-h_{2}$. Since $\Delta^{k-1}(f)=\Delta^{p-1}(t)+\Delta^{k-1}\left(f^{\prime}\right) N_{j}$, the support of $h^{\prime}$ is strictly smaller than the support of $h$. Moreover, $h_{2}$ is a transfer covariant and so the assertion of the proposition follows by induction.

We obtain the following upper bound for the Noether number of covariants:
Proposition 6. $\beta\left(\mathbb{k}[V, W]^{G}\right) \leq \max \left(\beta\left(\mathbb{k}[V], \mathbb{k}[V]^{G}\right), m p-\operatorname{dim}(V)\right)$.
Proof. Let $h \in \mathbb{k}[V, W]^{G}$ with degree $d>\max \left(\beta\left(\mathbb{k}[V], \mathbb{k}[V]^{G}\right), m p-\operatorname{dim}(V)\right)$. Let $\left(d_{1}, d_{2}, \ldots, d_{m}\right)$ be the multidegree of $h$. Then we must have $d_{j}>p-n_{j}$ for some $j$. Consequently we may apply Proposition 5, writing

$$
h=N_{j} h_{1}+h_{2}
$$

where $h_{2}$ is a transfer covariant. Since $\operatorname{deg}\left(h_{2}\right)>\beta\left(\mathbb{k}[V], \mathbb{k}[V]^{G}\right), h_{2}$ is decomposable by Proposition 4 and so we have shown that $h$ is decomposable.

## 4. LOWER BOUNDS

Indecomposable transfers are one method of obtaining lower bounds for $\beta\left(\mathbb{k}[V]^{G}\right)$. The analogous result for covariants is:
Lemma 7. Let $n \geq 2$ and let $\Delta^{p-1}(f) \in \mathbb{k}[V]^{G}$ be an indecomposable homogeneous transfer. Then the transfer covariant

$$
h=\Delta^{p-n}(f) w_{1}+\cdots+\Delta^{p-1}(f) w_{n}
$$

is indecomposable.
Proof. Assume on the contrary that $h$ is decomposable. Then there exist homogeneous $q_{i} \in \mathbb{k}[V]_{+}^{G}$ and $h_{i} \in \mathbb{k}[V, W]^{G}$ such that $h=\sum_{1 \leq i \leq t} q_{i} h_{i}$. Write $h_{i}=h_{i, 1} w_{1}+\cdots+h_{i, n} w_{n}$ for $1 \leq i \leq t$. Then we have $\Delta^{p-1}(f)=\sum_{1 \leq i \leq t} q_{i} h_{i, n}$. By Proposition 3 we have $\Delta\left(h_{i, n-1}\right)=h_{i, n}$ and so $h_{i, n} \in \mathbb{k}[V]_{+}^{G}$ because $n \geq 2$. It follows that $\sum_{1 \leq i \leq t} q_{i} h_{i, n}$ is a decomposition of $\Delta^{p-1}(f)$ in terms of invariants of strictly smaller degree, contradicting the indecomposability of $\Delta^{p-1}(f)$.
Corollary 8. Suppose $n \geq 2$ and $\beta\left(\mathbb{k}[V]^{G}\right)>\max (p, m p-\operatorname{dim}(V))$. Then $\beta\left(\mathbb{k}[V]^{G}\right) \leq \beta\left(\mathbb{k}[V, W]^{G}\right)$.

Proof. By [8, Lemma 2.12], $\mathbb{k}[V]^{G}$ is generated by the norms $N_{1}, N_{2}, \ldots, N_{m}$, invariants of degree at most $m p-\operatorname{dim}(V)$, and transfers. Since there exists an indecomposable invariant of degree $\beta\left(\mathbb{k}[V]^{G}\right)$, if the hypotheses of the corollary above hold, then $\mathbb{k}[V]^{G}$ contains an indecomposable transfer with this degree. By Lemma 7 $\mathbb{k}[V, W]^{G}$ contains a transfer covariant of degree $\beta\left(\mathbb{k}[V]^{G}\right)$ which is indecomposable, from which the conclusion follows.

## 5. Main Results

We are now ready to prove Theorem 1$]$ Note that $\mathbb{k}\left[V, V_{1}\right]^{G}$ is generated over $\mathbb{k}[V]^{G}$ by $w_{1}$ alone, which has degree zero, and therefore $\beta\left(\mathbb{k}\left[V, V_{1}\right]^{G}\right)=0$. For this reason we assume $n \geq 2$ throughout.

Proof. Suppose first that $n_{j}>3$ for some $j$. Then by [6, Proposition 1.1(a)], we have

$$
\beta\left(\mathbb{k}[V]^{G}\right)=m(p-1)+(p-2) .
$$

Since $V$ is reduced we have $\operatorname{dim}(V) \geq 2 m$ and hence

$$
\beta\left(\mathbb{k}[V]^{G}\right)>m(p-2) \geq m p-\operatorname{dim}(V)
$$

Also, $\beta\left(\mathbb{k}[V]^{G}\right) \geq 2 p-3>p$ since $n_{j} \leq p$ for all $j$. Therefore Corollary 8 implies that $\beta\left(\mathbb{k}[V]^{G}\right) \leq \beta\left(\mathbb{k}[V, W]^{G}\right)$. On the other hand, [6, Lemma 3.3] shows that the top degree of $\mathbb{k}[V] / \mathbb{k}[V]_{+}^{G} \mathbb{k}[V]$ is bounded above by $m(p-1)+(p-2)$. By the graded Nakayama Lemma it follows that $\beta\left(\mathbb{k}[V], \mathbb{k}[V]^{G}\right) \leq m(p-1)+(p-2)$. We have already shown that this number is at least $m p-\operatorname{dim}(V)+1$, so by Proposition (6) we get that

$$
\beta\left(\mathbb{k}[V, W]^{G}\right) \leq m(p-1)+(p-2)=\beta\left(\mathbb{k}[V]^{G}\right)
$$

as required.
Now suppose that $n_{i} \leq 3$ for all $i$ and $n_{j}=3$ for some $j$. Then by 6, Proposition 1.1(b)], we have

$$
\beta\left(\mathbb{k}[V]^{G}\right)=m(p-1)+1
$$

Since $V$ is reduced we have $\operatorname{dim}(V) \geq 2 m$ and hence

$$
\beta\left(\mathbb{k}[V]^{G}\right)>m(p-2) \geq m p-\operatorname{dim}(V)
$$

Also $\beta\left(\mathbb{k}[V]^{G}\right) \geq 2 p-1>p$ provided $m \geq 2$. In that case Corollary 8 applies. If $m=1$ then Dickson [4] has shown that $\mathbb{k}[V]^{G}=\mathbb{k}\left[x_{1}, x_{2}, x_{3}\right]^{G}$ is minimally generated by the invariants $x_{3}, x_{2}^{2}-2 x_{1} x_{3}-x_{2} x_{3}, N, \Delta^{p-1}\left(x_{1}^{p-1} x_{2}\right)$. It follows that $\Delta^{p-1}\left(x_{1}^{p-1} x_{2}\right)$ is an indecomposable transfer, so by Lemma $7, \mathbb{k}[V, W]^{G}$ contains an indecomposable transfer covariant of degree $p=\beta\left(\mathbb{k}[V]^{G}\right)$. In either case we obtain

$$
\beta\left(\mathbb{k}[V, W]^{G}\right) \geq \beta\left(\mathbb{k}[V]^{G}\right)
$$

On the other hand, by [9, Corollary 2.8], $m(p-1)+1$ is an upper bound for the top degree of $\mathbb{k}[V] / \mathbb{k}[V]_{+}^{G}$. By the same argument as before we get $\beta\left(\mathbb{k}[V]^{G}, \mathbb{k}[V]\right) \leq$ $m(p-1)+1$. We have already shown that this number is at least $m p-\operatorname{dim}(V)+1$, so by Proposition 6 we get that

$$
\beta\left(\mathbb{k}[V, W]^{G}\right) \leq m(p-1)+1=\beta\left(\mathbb{k}[V]^{G}\right)
$$

as required.
It remains to deal with the case $n_{i}=2$ for all $i$, i.e. $V=m V_{2}$. We assume $m \geq 2$. In this case Campbell and Hughes [2] showed that $\beta\left(\mathbb{k}[V]^{G}\right)=(p-1) m$. As $\operatorname{dim}(V)=2 m$ we have $\beta\left(\mathbb{k}[V]^{G}\right)>m(p-2)=m p-\operatorname{dim}(V)$. If $m \geq 3$ or $m=2$ and $p>2$ then we have $\beta\left(\mathbb{k}[V]^{G}\right)>p$ and Corollary 8 applies. In case $m=2=p, \mathbb{k}[V]^{G}=\mathbb{k}\left[x_{1,1}, x_{2,1}, x_{1,2}, x_{2,2}\right]^{G}$ is a hypersurface, minimally generated by $\left\{x_{2,1}, N_{1}, x_{2,2}, N_{2}, \Delta^{p-1}\left(x_{1,1} x_{1,2}\right)\right\}$. In particular $\Delta^{p-1}\left(x_{1,1} x_{1,2}\right)$ is an indecomposable transfer, so by Lemma $7, \mathbb{k}[V, W]^{G}$ contains an indecomposable transfer covariant of degree 2 . In both cases we get

$$
\beta\left(\mathbb{k}[V, W]^{G}\right) \geq \beta\left(\mathbb{k}[V]^{G}\right)
$$

On the other hand, by [9, Theorem 2.1], the top degree of $\mathbb{k}[V] / \mathbb{k}[V]_{+}^{G} \mathbb{k}[V]$ is bounded above by $m(p-1)$. We have already shown this number is at least
$m p-\operatorname{dim}(V)+1$. Therefore by Proposition 6 we get $\beta\left(\mathbb{k}[V, W]^{G}\right) \leq \beta\left(\mathbb{k}[V]^{G}\right)$ as required.

Remark 9. The only reduced representation not covered by Theorem 1 is $V=V_{2}$. An explicit minimal set of generators of $\mathbb{k}\left[V_{2}, W\right]^{G}$ as a module over $\mathbb{k}\left[V_{2}\right]^{G}$ is given in [5], the result is

$$
\beta\left(\mathbb{k}\left[V_{2}, W\right]\right)=n-1 .
$$

This is the only situation in which the Noether number is seen to depend on $W$.
Remark 10. Suppose $V$ is any reduced $\mathbb{k} G$-module and $W=\bigoplus_{i=1}^{r} W_{i}$ is a decomposable $\mathbb{k} G$-module. Then

$$
\mathbb{k}[V, W]^{G}=\left(\left(S\left(V^{*}\right) \otimes\left(\oplus_{i=1}^{r} W_{i}\right)\right)^{G}=\bigoplus_{i=1}^{r}\left(S\left(V^{*}\right) \otimes W_{i}\right)^{G}\right.
$$

So $\beta\left(\mathbb{k}[V, W]^{G}\right)=\max \left\{\left(\beta\left(\mathbb{k}\left[V, W_{i}\right]^{G}\right): i=1, \ldots, r\right)\right\}=\beta\left(\mathbb{k}[V]^{G}\right)$ unless $V$ is indecomposable of dimension 2 , in which case we have
$\beta\left(\mathbb{k}\left[V_{2}, W\right]^{G}\right)=\max \left\{\left(\beta\left(\mathbb{k}\left[V_{2}, W_{i}\right]^{G}\right): i=1, \ldots, r\right)\right\}=\max \left\{\operatorname{dim}\left(W_{i}\right)-1: i=1, \ldots, r\right\}$.
Thus, the results of this paper can be used to compute $\beta\left(\mathbb{k}[V, W]^{G}\right)$ for arbitrary $\mathbb{k} G$-modules $V$ and $W$.
