# Approximation by sampling-type operators in $L_{p}$-spaces

#### Abstract

Approximation properties of the sampling-type quasi-projection operators $Q_{j}(f, \varphi, \widetilde{\varphi})$ for functions $f$ from anisotropic Besov spaces are studied. Error estimates in $L_{p}$-norm are obtained for a large class of tempered distributions $\widetilde{\varphi}$ and a large class of functions $\varphi$ under the assumptions that $\varphi$ has enough decay, satisfies the Strang-Fix conditions and a compatibility condition with $\widetilde{\varphi}$. The estimates are given in terms of moduli of smoothness and best approximations.


Keywords. Sampling-type operators, Error estimate, Best approximation, Moduli of smoothness, Anisotropic Besov space.

## 1 Introduction

The well-known sampling theorem (Kotel'nikov's or Shannon's formula) states that

$$
\begin{equation*}
f(x)=\sum_{k \in \mathbb{Z}} f\left(-2^{-j} k\right) \frac{\sin \pi\left(2^{j} x+k\right)}{\pi\left(2^{j} x+k\right)} \tag{1}
\end{equation*}
$$

for band-limited to $\left[-2^{j-1}, 2^{j-1}\right]$ signals (functions) $f$. Equality (11) holds only for functions $f \in$ $L_{2}(\mathbb{R})$ whose Fourier transform is supported on $\left[-2^{j-1}, 2^{j-1}\right]$. However the right hand side of (1) (the sampling expansion of $f$ ) has meaning for every continuous $f$ with a good enough decay, which attracted mathematicians to study approximation properties of classical sampling and sampling-type expansions as $j \rightarrow \infty$. The most general form of such expansions looks as follows

Q_{j}(f, \varphi, \widetilde{\varphi})=|\operatorname{det} M|^{j} \sum_{k \in \mathbb{Z}^{d}}\left\langle f, \widetilde{\varphi}\left(M^{j} \cdot+k\right)\right\rangle \varphi\left(M^{j} \cdot+k\right),
$$

where $\varphi$ is a function and $\widetilde{\varphi}$ is a distribution or function, $M$ is a matrix, and the inner product $\left\langle f, \widetilde{\varphi}\left(M^{j} \cdot+k\right)\right\rangle$ has meaning in some sense. The operator $Q_{j}(f, \varphi, \widetilde{\varphi})$ is usually called a quasiprojection or sampling operator. The class of quasi-projection operators is very large. In particular, it includes operators with a regular function $\widetilde{\varphi}$, such as scaling expansions associated with wavelet constructions (see 4, 5, 14, 16, 21, 29] and others) and Kantorovich-Kotelnikov operators and their generalizations (see, e.g., [10, 11, 19, 34, 26]). One has an essentially different class of operators $Q_{j}(f, \varphi, \widetilde{\varphi})$ if $\widetilde{\varphi}$ is a distribution. This class includes the classical sampling operators, where $\widetilde{\varphi}$ is the Dirac delta-function. There are a lot of papers devoted to the study of approximation properties
of such operators for different classes of functions $\varphi$ (see, e.g., [2, 6, 7, 8, 18, 21, 27, 28, 33] and the references therein). Consideration of functions $\varphi$ with a good decay, in particular, compactly supported ones, is very useful for apllications. The case, where $\varphi$ is a certain linear combination of $B$-splines and $\widetilde{\varphi}$ is the Dirac delta-function, was studed, e.g., in [3, 9, 27, 28]. For a wide class of fast decaying functions $\varphi$ and a wide class of tempered distributions $\widetilde{\varphi}$, quasi-projection operators were considered in [21], in which error estimations in $L_{p}$-norm, $2 \leq p \leq \infty$, were given in terms of the Fourier transform of the approximated function $f$.

The goal of the present paper is to improve the results of 21 in several directions. In particular, we obtain error estimates for the case $1 \leq p<2$.

## 2 Notation

We use the standard multi-index notations. Let $\mathbb{N}$ be the set of positive integers, $\mathbb{R}^{d}$ be the $d$ dimensional Euclidean space, $\mathbb{Z}^{d}$ be the integer lattice in $\mathbb{R}^{d}, \mathbb{T}^{d}=\mathbb{R}^{d} / \mathbb{Z}^{d}$ be the $d$-dimensional torus. Let $x=\left(x_{1}, \ldots, x_{d}\right)^{T}$ and $y=\left(y_{1}, \ldots, y_{d}\right)^{T}$ be column vectors in $\mathbb{R}^{d}$, then $(x, y):=x_{1} y_{1}+\cdots+x_{d} y_{d}$, $|x|:=\sqrt{(x, x)} ; \mathbf{0}=(0, \ldots, 0)^{T} \in \mathbb{R}^{d} ; \mathbb{Z}_{+}^{d}:=\left\{x \in \mathbb{Z}^{d}: x_{k} \geq 0, k=1, \ldots, d\right\}$. If $r>0$, then $B_{r}$ denotes the ball of radius $r$ with the center in $\mathbf{0}$.

If $\alpha \in \mathbb{Z}_{+}^{d}, a, b \in \mathbb{R}^{d}$, we set

$$
[\alpha]=\sum_{j=1}^{d} \alpha_{j}, \quad \alpha!=\prod_{j=1}^{d} \alpha_{j}!, \quad a^{b}=\prod_{j=1}^{d} a_{j}^{b_{j}}, \quad D^{\alpha} f=\frac{\partial^{[\alpha]} f}{\partial x^{\alpha}}=\frac{\partial^{[\alpha]} f}{\partial^{\alpha_{1}} x_{1} \ldots \partial^{\alpha_{d}} x_{d}}
$$

If $A$ is a $d \times d$ matrix, then $\|A\|$ denotes its operator norm in $\mathbb{R}^{d} ; A^{*}$ denotes the conjugate matrix to $A$; the identity matrix is denoted by $I$.

A $d \times d$ matrix $M$ whose eigenvalues are bigger than 1 in modulus is called a dilation matrix. Throughout the paper we consider that such a matrix $M$ is fixed and $m=|\operatorname{det} M|$ unless other is specified. Since the spectrum of the operator $M^{-1}$ is located in $B_{r}$, where $r=r\left(M^{-1}\right):=$ $\lim _{j \rightarrow+\infty}\left\|M^{-j}\right\|^{1 / j}$ is the spectral radius of $M^{-1}$, and there exists at least one point of the spectrum on the boundary of the ball, we have

\lim _{j \rightarrow \infty}\left\|M^{-j}\right\|=0
$$

A matrix $M$ is called isotropic if it is similar to a diagonal matrix such that its eigenvalues $\lambda_{1}, \ldots, \lambda_{d}$ are placed on the main diagonal and $\left|\lambda_{1}\right|=\cdots=\left|\lambda_{d}\right|$. Note that if the matrix $M$ is isotropic then $M^{*}$ and $M^{j}$ are isotropic for all $j \in \mathbb{Z}$. It is well known that for an isotropic matrix $M$ and for any $j \in \mathbb{Z}$ we have

\begin{equation*}
C_{1}^{M}|\lambda|^{j} \leq\left\|M^{j}\right\| \leq C_{2}^{M}|\lambda|^{j}, \quad j \in \mathbb{Z} \tag{2}
\end{equation*}
$$

where $\lambda$ is one of the eigenvalues of $M$ and the constants $C_{1}^{M}, C_{2}^{M}$ do not depend on $j$.
By $L_{p}$ we denote the space $L_{p}\left(\mathbb{R}^{d}\right), 1 \leq p \leq \infty$, with the usual norm $\|f\|_{p}=\left(\int_{\mathbb{R}^{d}}|f|^{p}\right)^{1 / p}$ for $p<\infty$, and $\|f\|_{\infty}=\operatorname{ess} \sup |f|$.

If $f, g$ are functions defined on $\mathbb{R}^{d}$ and $f \bar{g} \in L_{1}$, then

$$
\langle f, g\rangle:=\int_{\mathbb{R}^{d}} f \bar{g}
$$

If $f \in L_{1}$, then its Fourier transform is

$$
\mathcal{F} f(\xi)=\widehat{f}(\xi)=\int_{\mathbb{R}^{d}} f(x) e^{-2 \pi i(x, \xi)} d x
$$

Denote by $\mathcal{S}$ the Schwartz class of functions defined on $\mathbb{R}^{d}$. The dual space of $\mathcal{S}$ is $\mathcal{S}^{\prime}$, i.e. $\mathcal{S}^{\prime}$ is the space of tempered distributions. Suppose $f \in \mathcal{S}, \varphi \in \mathcal{S}^{\prime}$, then $\langle\varphi, f\rangle:=\overline{\langle f, \varphi\rangle}:=\varphi(f)$. If $\varphi \in \mathcal{S}^{\prime}$, then $\widehat{\varphi}$ denotes its Fourier transform defined by $\langle\widehat{f}, \widehat{\varphi}\rangle=\langle f, \varphi\rangle, f \in \mathcal{S}$.

If $\varphi$ is a function defined on $\mathbb{R}^{d}$, we set

$$
\varphi_{j k}(x):=m^{j / 2} \varphi\left(M^{j} x+k\right), \quad j \in \mathbb{Z}, \quad k \in \mathbb{R}^{d}
$$

If $\widetilde{\varphi} \in \mathcal{S}^{\prime}, j \in \mathbb{Z}, k \in \mathbb{Z}^{d}$, then we define $\widetilde{\varphi}_{j k}$ by

$$
\left\langle f, \widetilde{\varphi}_{j k}\right\rangle:=\left\langle f_{-j,-M^{-j} k}, \widetilde{\varphi}\right\rangle, \quad \forall f \in \mathcal{S} .
$$

Denote by $\mathcal{S}_{N}^{\prime}, N \geq 0$, the set of tempered distributions $\widetilde{\varphi}$ whose Fourier transform $\widehat{\widetilde{\varphi}}$ is a function on $\mathbb{R}^{d}$ such that $|\widehat{\widetilde{\varphi}}(\xi)| \leq C_{\widetilde{\varphi}}|\xi|^{N}$ for almost all $\xi \notin \mathbb{T}^{d}$ and $|\widehat{\widetilde{\varphi}}(\xi)| \leq C_{\widetilde{\varphi}}$ for almost all $\xi \in \mathbb{T}^{d}$.

Let $1 \leq p \leq \infty$. Denote by $\mathcal{L}_{p}$ the set

$$
\mathcal{L}_{p}:=\left\{\varphi \in L_{p}:\|\varphi\|_{\mathcal{L}_{p}}:=\left\|\sum_{k \in \mathbb{Z}^{d}}|\varphi(\cdot+k)|\right\|_{L_{p}\left(\mathbb{T}^{d}\right)}<\infty\right\}
$$

It is known (see, e.g., [14) that $\mathcal{L}_{p}$ is a Banach space with the norm $\|\cdot\|_{\mathcal{L}_{p}}$, and the following properties hold: $\mathcal{L}_{1}=L_{1},\|\varphi\|_{p} \leq\|\varphi\|_{\mathcal{L}_{p}},\|\varphi\|_{\mathcal{L}_{q}} \leq\|\varphi\|_{\mathcal{L}_{p}}$ for $1 \leq q \leq p \leq \infty$. Therefore, $\mathcal{L}_{p} \subset L_{p}$ and $\mathcal{L}_{p} \subset \mathcal{L}_{q}$ for $1 \leq q \leq p \leq \infty$. If $\varphi \in L_{p}$ and there exist constants $C>0$ and $\varepsilon>0$ such that $|\varphi(x)| \leq C(1+|x|)^{-d-\varepsilon}$ for all $x \in \mathbb{R}^{d}$, then $\varphi \in \mathcal{L}_{\infty}$.

If $A$ is a $d \times d$ matrix and $1 \leq p \leq \infty$, then

$$
\mathcal{B}_{A, p}:=\left\{g \in L_{p}: \operatorname{supp} \widehat{g} \subset A \mathbb{T}^{d}\right\}
$$

is a class of functions band-limited to $A \mathbb{T}^{d}$, and

$$
E_{A}(f)_{p}:=\inf \left\{\|f-g\|_{p}: g \in \mathcal{B}_{A, p}\right\}
$$

is the best approximation of $f \in L_{p}$ by band-limited functions $g$ from the class $\mathcal{B}_{A, p}$. Additionally, we consider the following special best approximation

$$
E_{A}^{*}(f)_{p}:=\inf \left\{\|f-g\|_{p}: g \in \mathcal{B}_{A, p} \cap L_{2}\right\}
$$

which is equivalent to $E_{A}(f)_{p}$ for all $1 \leq p<\infty$ (see Lemma 8 below).
We will use the following anisotropic Besov spaces with respect to the matrix $M$. We say that $f \in \mathbb{B}_{p, q}^{s}(M), 1 \leq p \leq \infty, 0<q \leq \infty$, and $s>0$, if $f \in L_{p}$ and

$$
\|f\|_{\mathbb{B}_{p, q}^{s}(M)}:=\|f\|_{p}+\left(\sum_{\nu=1}^{\infty} m^{\frac{s}{d} q \nu} E_{M^{\nu}}(f)_{p}^{q}\right)^{\frac{1}{q}}<\infty .
$$

If $A$ is a $d \times d$ nonsingular matrix, $f \in L_{p}$ and $s \in \mathbb{N}$, then

$$
\Omega_{s}\left(f, A^{-1}\right)_{p}:=\sup _{|A t|<1, t \in \mathbb{R}^{d}}\left\|\Delta_{t}^{s} f\right\|_{p}
$$

where

$$
\Delta_{t}^{s} f(x):=\sum_{\nu=0}^{s}(-1)^{\nu}\binom{s}{\nu} f(x+t \nu)
$$

This is the so-called (total) anisotropic modulus of smoothness associated with $A$. The classical modulus of smoothness is defined by

$$
\omega_{s}(f, h)_{p}:=\sup _{|t|<h}\left\|\Delta_{t}^{s} f\right\|_{p}, \quad h>0 .
$$

As usual, if $\left\{a_{k}\right\}_{k}$ is a sequence, then

$$
\left\|\left\{a_{k}\right\}_{k}\right\|_{\ell_{p}}:= \begin{cases}\left(\sum_{k \in \mathbb{Z}^{d}}\left|a_{k}\right|^{p}\right)^{\frac{1}{p}}, & \text { if } 1 \leq p<\infty \\ \sup _{k \in \mathbb{Z}^{d}}\left|a_{k}\right|, & \text { if } p=\infty\end{cases}
$$

Finally, for an appropriate function $h: \mathbb{R}^{d} \rightarrow \mathbb{C}$ we denote the Fourier multiplier-type operator $\Lambda_{h}$ by

\Lambda_{h}(f):=\mathcal{F}^{-1}(h \widehat{f}), \quad f \in L_{2}
$$

## 3 Preliminary information and auxiliary results.

Sampling-type expansions $\sum_{k \in \mathbb{Z}^{d}}\left\langle f, \widetilde{\varphi}_{j k}\right\rangle \varphi_{j k}$ are elements of the shift-invariate spaces generated by $\varphi$. It is well known that a function $f$ can be approximated by elements of such spaces only if $\varphi$ satisfies a special property, the so-called Strang-Fix conditions.

Definition 1 function $\varphi$ is said to satisfy the Strang-Fix conditions of order $s \in \mathbb{N}$ if there exists $\delta \in(0,1 / 2)$ such that for any $k \in \mathbb{Z}^{d}, k \neq \mathbf{0}, \widehat{\varphi}$ is boundedly differentiable up to order $s$ on $\{|\xi+k|<\delta\}$ and $D^{\beta} \widehat{\varphi}(k)=0$ for $[\beta]<s$.

Approximation properties of the quasi-projection operators

$$
Q_{j}(f, \varphi, \widetilde{\varphi})=\sum_{k \in \mathbb{Z}^{d}}\left\langle f, \widetilde{\varphi}_{j k}\right\rangle \varphi_{j k}
$$

with $\widetilde{\varphi} \in S_{N}^{\prime}$, were studied in [29], [21] and [18] for different classes of functions $\varphi$. Since $\widetilde{\varphi}$ is a tempered distribution, the inner product $\left\langle f, \widetilde{\varphi}_{j k}\right\rangle$ has meaning only for functions $f$ in $\mathcal{S}$. To extend the class of functions $f$, the inner product $\left\langle f, \widetilde{\varphi}_{j k}\right\rangle$ was replaced by $\left\langle\widehat{f}, \widehat{\widehat{\varphi}_{j k}}\right\rangle$ in these papers. In particular, for $\varphi \in \mathcal{L}_{p}$ the following result was obtained in 21] (see Theorems 4 and 5).

Theorem 2 Let $2 \leq p \leq \infty, 1 / p+1 / q=1, s \in \mathbb{N}, N \in \mathbb{Z}_{+}, \delta \in(0,1 / 2), \varepsilon>0$. Let also $M$ be an isotropic dilation matrix, $\varphi \in \mathcal{L}_{p}$, and $\widetilde{\varphi} \in \mathcal{S}_{N}^{\prime}$. Suppose
$\star$ there exists $B_{\varphi}>0$ such that $\sum_{k \in \mathbb{Z}^{d}}|\widehat{\varphi}(\xi+k)|^{q}<B_{\varphi}$ for all $\xi \in \mathbb{R}^{d}$;
$\star \widehat{\varphi}$ is boundedly differentiable up to order $s$ on $\{|\xi+l|<\delta\}$ for all $l \in \mathbb{Z}^{d} \backslash\{\mathbf{0}\}$; the function $\sum_{l \in \mathbb{Z}^{d}, l \neq \mathbf{0}}\left|D^{\beta} \widehat{\varphi}(\xi+l)\right|^{q}$ is bounded on $\{|\xi|<\delta\}$ for $[\beta]=s$, and the Strang-Fix conditions of order s hold for $\varphi$;
$\star \widehat{\varphi} \widehat{\widetilde{\varphi}}$ is boundedly differentiable up to order s on $\{|\xi|<\delta\}$, and $D^{\beta}(1-\widehat{\varphi} \widehat{\widetilde{\varphi}})(\mathbf{0})=0$ for all $[\beta]<s$.
If $f \in L_{p}, \widehat{f} \in L_{q}$, and $\widehat{f}(\xi)=\mathcal{O}\left(|\xi|^{-N-d-\varepsilon}\right)$ as $|\xi| \rightarrow \infty$, then

$$
\left\|f-\sum_{k \in \mathbb{Z}^{d}}\left\langle\widehat{f}, \widehat{\widetilde{\varphi}_{j k}}\right\rangle \varphi_{j k}\right\|_{p} \leq \begin{cases}C|\lambda|^{-j\left(N+\frac{d}{p}+\varepsilon\right)} & \text { if } s>N+\frac{d}{p}+\varepsilon \\ C(j+1)^{1 / q}|\lambda|^{-j s} & \text { if } s=N+\frac{d}{p}+\varepsilon \\ C|\lambda|^{-j s} & \text { if } s<N+\frac{d}{p}+\varepsilon\end{cases}
$$

where $\lambda$ is an eigenvalue of $M$ and $C$ does not depends on $j$.

There are several drawbacks in Theorem 2. First, an error estimate is obtained only for the case $p \geq 2$. Second, there are additional restrictions on the function $f$. Even in the case of regular functions $\widetilde{\varphi}$ for which the inner product $\left\langle f, \widetilde{\varphi}_{j k}\right\rangle$ has meaning for every $f \in L_{p}$, the error estimate is obtained only under additional assumption $\widehat{f}(\xi)=\mathcal{O}\left(|\xi|^{-d-\varepsilon}\right)$ as $|\xi| \rightarrow \infty$. Third, although Theorem 2 provides approximation order for $Q_{j}(f, \varphi, \widetilde{\varphi})$, more accurate error estimates were not obtained in contrast to common results in approximation theory, where estimates are usually given in the terms of moduli of smoothness.

The described shortcomings of Theorem 2 were avoided in [19, where the Kantorovich-type quasi-projection operators $Q_{j}(f, \varphi, \widetilde{\varphi})$ with regular functions $\widetilde{\varphi}$ and band-limited functions $\varphi \in \mathcal{B}$ were studied. Here $\mathcal{B}$ is the class of functions $\varphi$ given by

$$
\varphi(x)=\int_{\mathbb{R}^{d}} \theta(\xi) e^{2 \pi i(x, \xi)} d \xi
$$

where $\theta$ is supported in a parallelepiped $\Pi:=\left[a_{1}, b_{1}\right] \times \cdots \times\left[a_{d}, b_{d}\right]$ and such that $\left.\theta\right|_{\Pi} \in C^{d}(\Pi)$. In particular, the following result was obtained in [19, Theorem 17].

Theorem 3 Let $f \in L_{p}, 1<p<\infty$, and $s \in \mathbb{N}$. Suppose $\varphi \in \mathcal{B}$, $\operatorname{supp} \widehat{\varphi} \subset B_{1-\varepsilon}$ for some $\varepsilon \in(0,1)$, $\widehat{\varphi} \in C^{s+d+1}\left(B_{\delta}\right)$ for some $\delta>0 ; \widetilde{\varphi} \in \mathcal{B} \cup \mathcal{L}_{q}, 1 / p+1 / q=1, \widehat{\widetilde{\varphi}} \in C^{s+d+1}\left(B_{\delta}\right)$ and $D^{\beta}(1-\widehat{\varphi} \overline{\widetilde{\varphi}})(\mathbf{0})=0$ for all $\beta \in \mathbb{Z}_{+}^{d},[\beta]<s$. Then

$$
\left\|f-\sum_{k \in \mathbb{Z}^{d}}\left\langle f, \widetilde{\varphi}_{j k}\right\rangle \varphi_{j k}\right\|_{p} \leq C \omega_{s}\left(f,\left\|M^{-j}\right\|\right)_{p}
$$

where $C$ does not depend on $f$ and $j$.
A similar estimate for other classes of functions $\varphi$ and $\widetilde{\varphi}$ follows from the results of Jia. Namely, the next theorem can be obtained by combining Theorem 3.2 in [16] with Lemma 3.2 in [15].

Theorem 4 Let $f \in L_{p}, 1 \leq p<\infty$ or $f \in C\left(\mathbb{R}^{d}\right)$ and $p=\infty, M=m I$, and $s \in \mathbb{N}$. Suppose $\varphi$ and $\widetilde{\varphi}$ are compactly supported functions, the Strang-Fix conditions of order $s$ hold for $\varphi$, and $D^{\beta}(1-\widehat{\varphi} \overline{\widehat{\varphi}})(\mathbf{0})=0$ for all $\beta \in \mathbb{Z}_{+}^{d},[\beta]<s$. Then

$$
\left\|f-\sum_{k \in \mathbb{Z}^{d}}\left\langle f, \widetilde{\varphi}_{j k}\right\rangle \varphi_{j k}\right\|_{p} \leq C \omega_{s}\left(f, m^{-j}\right)_{p}
$$

where $C$ does not depend on $f$ and $j$.
Our goal is to avoid the mentioned above drawbacks of Theorem 2 in the case of $\varphi \in \mathcal{L}_{p}$ and $\widetilde{\varphi} \in S_{N}^{\prime}$. For this, we need to specify the tempered distributions $\widetilde{\varphi}$. We will say that a tempered distribution $\widetilde{\varphi}$ belongs to the class $\mathcal{S}_{N, p}^{\prime}$ for some $N \geq 0$ and $1 \leq p \leq \infty$ if $\widetilde{\varphi} \in \mathcal{S}_{N}^{\prime}$ and there exists a constant $C_{\widetilde{\varphi}, p}$ such that

$$
\begin{equation*}
\left\|\Lambda_{\widehat{\widetilde{\varphi}}}\left(T_{\mu}\right)\right\|_{p} \leq C_{\widetilde{\varphi}, p} m^{\frac{N \mu}{d}}\left\|T_{\mu}\right\|_{p} \tag{3}
\end{equation*}
$$

for all $\mu \in \mathbb{Z}_{+}$and $T_{\mu} \in \mathcal{B}_{M^{\mu}, p} \cap L_{2}$.
Obviously, (3) is satisfied if $\widetilde{\varphi}$ is the Dirac delta-function. If $M$ is an isotropic matrix, then any distribution $\widetilde{\varphi}$ corresponding to some differential operator (see [21, [18]), namely

$$
\widehat{\widetilde{\varphi}}(\xi)=\sum_{[\beta] \leq N} c_{\beta}(2 \pi i \xi)^{\beta}, \quad N \in \mathbb{Z}_{+}, j \in \mathbb{N}
$$

is also in $\mathcal{S}_{N, p}^{\prime}$. This easily follows from the well-known Bernstein inequality (see, e.g., [25, p. 115])

\left\|g^{\prime}\right\|_{L_{p}} \leq \sigma\|g\|_{L_{p}}, \quad g \in L_{p}(\mathbb{R}), \quad \operatorname{supp} \widehat{g} \subset[-\sigma, \sigma]
$$

To extend the operator $Q_{j}(f, \varphi, \widetilde{\varphi})$ with $\widetilde{\varphi} \in \mathcal{S}_{N, p}^{\prime}$ to the space $\mathbb{B}_{p, 1}^{d / p+N}(M)$, we need the following lemmas.

Lemma 5 ([32, Theorem 4.3.1]) Let $1 \leq p<\infty, f \in L_{p}$, and supp $\widehat{f} \subset[-\sigma, \sigma]^{d}, \sigma>0$. Then

\sum_{k \in \mathbb{Z}^{d}} \max _{x \in Q_{k, \sigma}}|f(x)|^{p} \leq C(p, d) \sigma^{d}\|f\|_{p}^{p}
$$

where $Q_{k, \sigma}=\left[-\frac{1}{\sigma}, \frac{1}{\sigma}\right]^{d}+\frac{2 k}{\sigma}$.
Lemma $6\left(\left[14\right.\right.$, Theorem 2.1]) Let $1 \leq p \leq \infty, \varphi \in \mathcal{L}_{p}$, and $\left\{a_{k}\right\}_{k \in \mathbb{Z}^{d}} \subset \mathbb{C}$. Then

\left\|\sum_{k \in \mathbb{Z}^{d}} a_{k} \varphi_{0 k}\right\|_{p} \leq\|\varphi\|_{\mathcal{L}_{p}}\left\|\left\{a_{k}\right\}_{k}\right\|_{\ell_{p}}
$$

Lemma 7 ([24, Proposition 5]) Let $1 \leq p \leq \infty, 1 / p+1 / q=1, f \in L_{p}$, and $\varphi \in \mathcal{L}_{q}$. Then

\left\|\left\{\left\langle f, \varphi_{0 k}\right\rangle\right\}_{k}\right\|_{\ell_{p}} \leq\|\varphi\|_{\mathcal{L}_{q}}\|f\|_{p}
$$

Lemma 8 Let $1 \leq p<\infty$ and $A$ be $d \times d$ matrix. Then

E_{A}(f)_{p} \leq E_{A}^{*}(f)_{p} \leq C(p, d) E_{A}(f)_{p} \tag{4}
\end{equation*}
$$

Proof. We need to prove only the second inequality in (4). Let $Q \in \mathcal{B}_{A, p}$ be such that $\|f-Q\|_{p} \leq$ $2 E_{A}(f)_{p}$. If $1 \leq p \leq 2$, then using the embedding $\mathcal{B}_{A, p} \subset \mathcal{B}_{A, 2}$ (see, e.g., [25, Theorem 3.3.5]), we get $E_{A}^{*}(f)_{p} \leq\|f-Q\|_{p} \leq 2 E_{A}(f)_{p}$.

Now consider the case $p>2$. Let $T \in \mathcal{S}$ be such that $\|f-T\|_{p} \leq E_{A}(f)_{p}$. Denote $S_{A} g:=$ $\mathcal{F}^{-1} \chi_{A \mathbb{T}^{d}} * g$. It is clear that $S_{A} T \in L_{p} \cap L_{2}$ and $S_{A} Q=Q$. Thus, taking into account that $S_{A}$ is bounded in $L_{p}$ for all $1<p<\infty$ (see, e.g., [25, Section 1.5.7]), we derive

E_{A}^{*}(f)_{p} & \leq\left\|f-S_{A} T\right\|_{p} \leq\|f-Q\|_{p}+\left\|S_{A}(Q-T)\right\|_{p} \\
& \leq\|f-Q\|_{p}+C_{1}\|Q-T\|_{p} \leq\left(1+C_{1}\right)\|f-Q\|_{p}+C_{1}\|f-T\|_{p} \leq C_{2} E_{A}(f)_{p}
\end{aligned}
$$

which proves the lemma. $\diamond$
In particular Lemma 8 implies that for any $f \in L_{p}, 1 \leq p<\infty$, there exists a function $T \in$ $\mathcal{B}_{A, p} \cap L_{2}$ such that $\left\|f-T_{\mu}\right\|_{p} \leq C(p, d) E_{A}(f)_{p}$.

Lemma 9 Let $1 \leq p<\infty, N \geq 0, \delta \in(0,1], \widetilde{\varphi} \in \mathcal{S}_{N, p}^{\prime}$, and $f \in \mathbb{B}_{p, 1}^{d / p+N}(M)$. Suppose that functions $T_{\mu} \in \mathcal{B}_{\delta M^{\mu}, p} \cap L_{2}, \mu \in \mathbb{Z}_{+}$, are such that

\left\|f-T_{\mu}\right\|_{p} \leq C(p, d) E_{\delta M^{\mu}}(f)_{p}
$$

Then the sequence $\left\{\left\{\left\langle\widehat{T}_{\mu}, \widehat{\widetilde{\varphi}}_{0 k}\right\rangle\right\}_{k}\right\}_{\mu=0}^{\infty}$ converges in $\ell_{p}$ as $\mu \rightarrow \infty$; a fortiori the sequence $\left\{\left\langle\widehat{T}_{\mu}, \widehat{\widetilde{\varphi}}_{0 k}\right\rangle\right\}_{\mu=0}^{\infty}$ converges uniformly with respect to $k \in \mathbb{Z}^{d}$, and the limit does not depend on the choice of functions $T_{\mu}$;

$$
\sum_{\mu=n}^{\infty}\left\|\left\{\left\langle\widehat{T}_{\mu+1}-\widehat{T}_{\mu}, \widehat{\widetilde{\varphi}}_{0 k}\right\rangle\right\}_{k}\right\|_{\ell_{p}} \leq C \sum_{\mu=n}^{\infty} m^{\mu\left(\frac{N}{d}+\frac{1}{p}\right)} E_{\delta M^{\mu}}(f)_{p}, \quad \forall n \in \mathbb{Z}_{+}
$$

where the constant $C$ depends only on $\widetilde{\varphi}, d$, $p$, and $M$.

Proof. Set

F(x):=\int_{\mathbb{R}^{d}}\left(\widehat{T}_{\mu+1}\left(M^{* \mu+1} \xi\right)-\widehat{T}_{\mu}\left(M^{* \mu+1} \xi\right)\right) \overline{\widehat{\widehat{\varphi}}\left(M^{* \mu+1} \xi\right)} e^{2 \pi i(\xi, x)} d \xi .
$$

We have

\left\|\left\{\left\langle\widehat{T}_{\mu+1}, \widehat{\widetilde{\varphi}}_{0 k}\right\rangle-\left\langle\widehat{T}_{\mu}, \widehat{\widetilde{\varphi}}_{0 k}\right\rangle\right\}_{k}\right\|_{\ell_{p}}^{p} & =\sum_{k \in \mathbb{Z}^{d}}\left|\int_{\mathbb{R}^{d}}\left(\widehat{T}_{\mu+1}(\xi)-\widehat{T}_{\mu}(\xi)\right) \overline{\widehat{\varphi}(\xi)} e^{-2 \pi i(\xi, k)} d \xi\right|^{p}  \tag{5}\\
& =m^{p(\mu+1)} \sum_{k \in \mathbb{Z}^{d}}\left|F\left(M^{\mu+1} k\right)\right|^{p} .
\end{align*}
$$

Since

$$
\operatorname{supp} \widehat{T}_{\mu+1}\left(M^{* \mu+1} \cdot\right) \subset \mathbb{T}^{d}, \quad \operatorname{supp} \widehat{T}_{\mu}\left(M^{* \mu+1} \cdot\right) \subset \sqrt{d}\left\|M^{-1}\right\| \mathbb{T}^{d},
$$

one can easily see that

$$
\operatorname{supp} \widehat{F} \subset[-\sigma, \sigma]^{d}, \quad \text { where } \sigma=\sigma(M, d) \text {. }
$$

Thus, by Lemma taking into account that each set $Q_{r, \sigma}$ contains only finite number (depending only on $M$ and $d$ ) of points $M^{\mu+1} k \in \mathbb{Z}^{d}, k \in \mathbb{Z}^{d}$, we obtain

After the change of variables, the above inequality yields

m^{p(\mu+1)} \sum_{k \in \mathbb{Z}^{d}}\left|F\left(M^{\mu+1} k\right)\right|^{p} \leq C_{1} \sigma^{d} m^{\mu+1}\left\|\Lambda_{\mathcal{F}-1}\left(\overline{T_{\mu+1}}-\overline{T_{\mu}}\right)\right\|_{p}^{p} .
$$

Using this estimate together with (5) and (3), we get

\left\|\left\{\left\langle\widehat{T}_{\mu+1}, \widehat{\widetilde{\varphi}}_{0 k}\right\rangle-\left\langle\widehat{T}_{\mu}, \widehat{\widetilde{\varphi}}_{0 k}\right\rangle\right\}_{k}\right\|_{\ell_{p}} \leq C_{2} m^{\mu\left(\frac{N}{d}+\frac{1}{p}\right)}\left\|T_{\mu+1}-T_{\mu}\right\|_{p} .
$$

Hence, for any $n \in \mathbb{Z}_{+}$, we have

\begin{aligned}
\sum_{\mu=n}^{\infty}\left\|\left\{\left\langle\widehat{T}_{\mu+1}, \widehat{\widetilde{\varphi}}_{0 k}\right\rangle-\left\langle\widehat{T}_{\mu}, \widehat{\widetilde{\varphi}}_{0 k}\right\rangle\right\}_{k}\right\|_{\ell_{p}} & \leq C_{4} \sum_{\mu=n}^{\infty} m^{\mu\left(\frac{N}{d}+\frac{1}{p}\right)}\left\|T_{\mu+1}-T_{\mu}\right\|_{p} \\
& \leq 2 C_{4} \sum_{\mu=n}^{\infty} m^{\mu\left(\frac{N}{d}+\frac{1}{p}\right)} E_{\delta M^{\mu}}(f)_{p}
\end{aligned}
$$

and it is easy to see that $C_{4}$ depends only on $\widetilde{\varphi}, d, p$, and $M$.
The latter series is convergent because $f \in \mathbb{B}_{p, 1}^{d / p+N}(M)$, which yields that $\left\{\left\{\left\langle\widehat{T}_{\mu}, \widehat{\widetilde{\varphi}}_{0 k}\right\rangle\right\}_{k}\right\}_{\mu=0}^{\infty}$ is a Cauchy sequence in $\ell_{p}$. In particular, this implies that the sequence $\left\{\left\langle\widehat{T}_{\mu}, \widehat{\widetilde{\varphi}}_{0 k}\right\rangle\right\}_{\mu=0}^{\infty}$ is convergent for every $k \in \mathbb{Z}^{d}$. It remains to check that the limit does not depend on the choice of functions $T_{\mu}$. Let $\left\{T_{\mu}^{\prime}\right\}_{\mu}$ be another sequence of functions with the same properties. Repeating all above arguments with $T_{\mu}^{\prime}$ instead of $T_{\mu+1}$, we obtain

\left\|\left\{\left\langle\widehat{T}_{\mu}^{\prime}, \widehat{\widetilde{\varphi}}_{0 k}\right\rangle-\left\langle\widehat{T}_{\mu}, \widehat{\widetilde{\varphi}}_{0 k}\right\rangle\right\}_{k}\right\|_{\ell_{p}} \leq C_{5} m^{\mu\left(\frac{N}{d}+\frac{1}{p}\right)}\left\|T_{\mu}^{\prime}-T_{\mu}\right\|_{p} \leq 2 C_{5} m^{\mu\left(\frac{N}{d}+\frac{1}{p}\right)} E_{\delta M^{\mu}}(f)_{p},
$$

where $C_{5}$ depends only on $\widetilde{\varphi}, d, p$, and $M$.
It follows that $\left\langle\widehat{T}_{\mu}^{\prime}, \widehat{\widetilde{\varphi}}_{0 k}\right\rangle-\left\langle\widehat{T}_{\mu}, \widehat{\widetilde{\varphi}}_{0 k}\right\rangle \rightarrow 0$ as $\mu \rightarrow \infty$ for any $k \in \mathbb{Z}^{d}$, which completes the proof.
Consider the functional $\left\langle f, \widetilde{\varphi}_{j k}\right\rangle$. If $\widetilde{\varphi} \in \mathcal{S}_{N}^{\prime}$, then $\left\langle f, \widetilde{\varphi}_{j k}\right\rangle$ has meaning whenever $f \in \mathcal{S}$. Due to Lemma 9 we can extend the linear functional $\left\langle f, \widetilde{\varphi}_{j k}\right\rangle$ from $\mathcal{S}$ to $\mathbb{B}_{p, 1}^{d / p+N}(M)$ as follows.

Definition 10 Let $1 \leq p<\infty, N \geq 0, \widetilde{\varphi} \in S_{N, p}^{\prime}$, and the functions $T_{\mu}$ be as in Lemma 9 . For every $f \in \mathbb{B}_{p, 1}^{d / p+N}(M)$ and $k \in \mathbb{Z}^{d}$, we set

\left\langle f, \widetilde{\varphi}_{0 k}\right\rangle:=\lim _{\mu \rightarrow \infty}\left\langle\widehat{T}_{\mu}, \widehat{\widetilde{\varphi}}_{0 k}\right\rangle
$$

and

$$
\left\langle f, \widetilde{\varphi}_{j k}\right\rangle:=m^{-j / 2}\left\langle f\left(M^{-j} \cdot\right), \widetilde{\varphi}_{0 k}\right\rangle, \quad j \in \mathbb{Z}_{+}
$$

Now, the quasi projection operators

$$
Q_{j}(f, \varphi, \widetilde{\varphi})=\sum_{k \in \mathbb{Z}^{d}}\left\langle f, \widetilde{\varphi}_{j k}\right\rangle \varphi_{j k}
$$

are defined on the space $\mathbb{B}_{p, 1}^{d / p+N}(M)$ for a wide class of appropriate functions $\varphi$.
Remark 11 If $\varphi \in \mathcal{L}_{p}$, then the operator $Q_{j}(f, \varphi, \widetilde{\varphi})$ is well defined because the series $\sum_{k \in \mathbb{Z}^{d}}\left\langle f, \widetilde{\varphi}_{j k}\right\rangle \varphi_{j k}$ converges unconditionally in $L_{p}$, which follows from Lemmas 6 and 9 .

Remark 12 If the Fourier transform of a function $f$ has enough decay for the inner product $\left\langle\widehat{f}, \widehat{\widetilde{\varphi}_{0 k}}\right\rangle$ to have meaning, then it is natural to define $Q_{j}(f, \varphi, \widetilde{\varphi})$ setting $\left\langle f, \widetilde{\varphi}_{0 k}\right\rangle:=\left\langle\widehat{f}, \widehat{\widetilde{\varphi}_{0 k}}\right\rangle$ (see Theorem 圆). Such an operator $Q_{j}(f, \varphi, \widetilde{\varphi})$ will be the same as one in correspondence with Definition 10.

Proof. We assume that $f \in L_{p}, \widehat{f} \in L_{q}, 1 / p+1 / q=1, \widehat{f}(\xi)=\mathcal{O}\left(|\xi|^{-N-d-\varepsilon}\right)$ as $|\xi| \rightarrow \infty, \varepsilon>0$, $f \in \mathbb{B}_{p, 1}^{d / p+N}(M), \widetilde{\varphi} \in S_{N}^{\prime}$, and $M$ is an isotropic matrix.

First we consider the case $p<2$. Let $T_{\mu} \in \mathcal{B}_{\delta M^{\mu}, p}$ be such that $\left\|f-T_{\mu}\right\|_{p} \leq 2 E_{\delta M^{\mu}}(f)_{p}$ Since $\mathcal{B}_{\delta M^{\mu}, p} \subset \mathcal{B}_{\delta M^{\mu}, 2}$ (see, e.g., [25, Theorem 3.3.5]), we have $T_{\mu} \in \mathcal{B}_{\delta M^{\mu}, p} \cap L_{2}$ and, due to the Hausdorff-Young inequality,

\left\|\widehat{f}-\widehat{T}_{\mu}\right\|_{q} \leq\left\|f-T_{\mu}\right\|_{p} \leq 2 E_{\delta M^{\mu}}(f)_{p} \tag{6}
\end{equation*}
$$

Next we have

\begin{aligned}
&\left|\left\langle\widehat{f}, \widehat{\widehat{\varphi}_{0 k}}\right\rangle-\left\langle\widehat{T}_{\mu}, \widehat{\widehat{\varphi}_{0 k}}\right\rangle\right| \leq C_{1} \int_{|\xi| \leq \delta \sqrt{d}\left\|M^{\mu}\right\|}(1+|\xi|)^{N}\left|\widehat{f}(\xi)-\widehat{T}_{\mu}(\xi)\right| d \xi \\
&+C_{2} \int_{|\xi| \geq \delta \sqrt{d}\left\|M^{\mu}\right\|}(1+|\xi|)^{N}\left|\widehat{f}(\xi)-\widehat{T}_{\mu}(\xi)\right| d \xi=: C_{1} I_{1}+C_{2} I_{2}
\end{aligned}
$$

If $|\xi| \geq \delta \sqrt{d}\left\|M^{\mu}\right\|$, then $\xi \notin \delta M^{\mu} \mathbb{T}^{d}$, and hence $\widehat{T}_{\mu}(\xi)=0$, which yields

I_{2}=\int_{|\xi| \geq \delta \sqrt{d}\left\|M^{\mu}\right\|}(1+|\xi|)^{N}|\widehat{f}(\xi)| d \xi \underset{\mu \rightarrow \infty}{\longrightarrow} 0
$$

Using Hölder's inequality and (6), we derive

I_{1} \leq 2\left(\int_{|\xi| \leq \delta \sqrt{d}\left\|M^{\mu}\right\|}(1+|\xi|)^{p N}\right)^{1 / p} E_{\delta M^{\mu}}(f)_{p} \leq C_{3}\left\|M^{\mu}\right\|^{N+\frac{d}{p}} E_{\delta M^{\mu}}(f)_{p}
$$

Taking into account that $f \in \mathbb{B}_{p, 1}^{d / p+N}(M)$ and the inequality $\left\|M^{\mu}\right\| \leq C(d, M) m^{\mu / d}$, which holds for any isotropic matrix, we obtain that $I_{1} \rightarrow 0$ as $\mu \rightarrow \infty$. Thus

\left|\left\langle\widehat{f}, \widehat{\widetilde{\varphi}_{0 k}}\right\rangle-\left\langle\widehat{T}_{\mu}, \widehat{\widetilde{\varphi}_{0 k}}\right\rangle\right| \underset{\mu \rightarrow \infty}{\longrightarrow} 0 \tag{7}
\end{equation*}
$$

Let now $p \geq 2$. Denote $T_{\mu}=\mathcal{F}^{-1}\left(\chi_{\delta M^{\mu} \mathbb{T}^{d}}\right) * g_{\mu}$, where $g_{\mu} \in \mathcal{S}$ is such that

\begin{equation*}
\left\|\widehat{f}-\widehat{g_{\mu}}\right\|_{q} \leq E_{\delta M^{\mu}}(f)_{p} \tag{8}
\end{equation*}
$$

Obviously, $T_{\mu} \in \mathcal{B}_{\delta M^{\mu}, p} \cap L_{2}$ and $\widehat{T}_{\mu}=\chi_{\delta M^{\mu} \mathbb{T}^{d}} \widehat{g_{\mu}}$. Next we have

\begin{aligned}
& \left|\left\langle\widehat{f}, \widehat{\widehat{\varphi}_{0 k}}\right\rangle-\left\langle\widehat{T_{\mu}}, \widehat{\widehat{\varphi}_{0 k}}\right\rangle\right| \\
& \leq \int_{\mathbb{R}^{d}}(1+|\xi|)^{N}\left|\widehat{f}(\xi)-\chi_{\delta M^{\mu} \mathbb{T}^{d}}(\xi) \widehat{f}(\xi)\right| d \xi+\int_{\mathbb{R}^{d}}(1+|\xi|)^{N} \mid \chi_{\delta M^{\mu} \mathbb{T}^{d}}(\xi)\left(\widehat{f}(\xi)-\widehat{g_{\mu}}(\xi) \mid d \xi\right. \\
& =\int_{\xi \notin \delta M^{\mu} \mathbb{T}^{d}}(1+|\xi|)^{N}|\widehat{f}(\xi)| d \xi+\int_{\xi \in \delta M^{\mu} \mathbb{T}^{d}}(1+|\xi|)^{N}\left|\widehat{f}(\xi)-\widehat{g_{\mu}}(\xi)\right| d \xi
\end{aligned}
$$

Due to the same arguments as above, using (8) instead of (6), we conclude again that relation (7) holds true. To complete the proof it remains to note that the limit of the sequence $\left\{\left\langle\widehat{T_{\mu}}, \widehat{\widehat{\varphi}_{0 k}}\right\rangle\right\}_{\mu}$ does not depend on the choice of appropriate functions $T_{\mu}$. $\diamond$

Lemma 13 Let $1 \leq p<\infty, 1 / p+1 / q=1, \delta \in(0,1], \varphi \in \mathcal{L}_{p}$, and the functions $T_{\nu}, \nu \in \mathbb{Z}_{+}$, be as in Lemma 9 .
(i) If $N \geq 0, \widetilde{\varphi} \in S_{N, p}^{\prime}, f \in \mathbb{B}_{p, 1}^{d / p+N}(M)$, and $\nu \in \mathbb{Z}_{+}$, then

\left\|f-Q_{0}(f, \varphi, \widetilde{\varphi})\right\|_{p} \leq\left\|T_{\nu}-Q_{0}\left(T_{\nu}, \varphi, \widetilde{\varphi}\right)\right\|_{p}+C \sum_{\mu=\nu}^{\infty} m^{\mu\left(\frac{N}{d}+\frac{1}{p}\right)} E_{\delta M^{\mu}}(f)_{p} \tag{9}
\end{equation*}
$$

where the constant $C$ does not depend on $f$ and $\nu$. (ii) If $\widetilde{\varphi} \in \mathcal{L}_{q}, f \in L_{p}$, and $\nu \in \mathbb{Z}_{+}$, then

\left\|f-Q_{0}(f, \varphi, \widetilde{\varphi})\right\|_{p} \leq\left\|T_{\nu}-Q_{0}\left(T_{\nu}, \varphi, \widetilde{\varphi}\right)\right\|_{p}+C E_{\delta M^{\nu}}(f)_{p} \tag{10}
\end{equation*}
$$

where the constant $C$ does not depend on $f$ and $\nu$.
Proof. We have

\left\|f-Q_{0}(f, \varphi, \widetilde{\varphi})\right\|_{p} \leq\left\|f-T_{\nu}\right\|_{p}+\left\|T_{\nu}-Q_{0}\left(T_{\nu}, \varphi, \widetilde{\varphi}\right)\right\|_{p}+\left\|Q_{0}\left(f-T_{\nu}, \varphi, \widetilde{\varphi}\right)\right\|_{p} \tag{11}
\end{equation*}
$$

Under assumptions of item (i), by Definition 10, using Lemmas 6and 9, we derive

\left\|Q_{0}\left(f-T_{\nu}, \varphi, \widetilde{\varphi}\right)\right\|_{p} & \leq C_{1}\left\|\left\{\left\langle f-T_{\nu}, \widetilde{\varphi}_{0 k}\right\rangle\right\}_{k}\right\|_{\ell_{p}} \leq C_{2} \sum_{\mu=\nu}^{\infty}\left\|\left\{\left\langle T_{\mu+1}-T_{\mu}, \widetilde{\varphi}_{0 k}\right\rangle\right\}_{k}\right\|_{\ell_{p}} \\
& \leq C_{3} \sum_{\mu=\nu}^{\infty} m^{\mu\left(\frac{N}{d}+\frac{1}{p}\right)} E_{\delta M^{\mu}}(f)_{p} \tag{12}
\end{align*}
$$

Combining (11) and (12), we get (9).

Under assumptions of item (ii), it follows from Lemmas 6 and 7 that

& \leq\|\varphi\|_{\mathcal{L}_{p}}\|\widetilde{\varphi}\|_{\mathcal{L}_{q}}\left\|f-T_{\nu}\right\|_{p} \leq C_{4} E_{\delta M^{\nu}}(f)_{p} \tag{13}
\end{align*}
$$

Combining (11) and (13), we obtain (10). $\diamond$
We will use the following Jackson-type theorem (see, e.g., [25, Theorem 5.2.1 (7)] or [30, 5.3.2]).
Lemma 14 Let $f \in L_{p}, 1 \leq p \leq \infty$, and $s \in \mathbb{N}$. Then

Lemma 15 (SEE [35].) Let $1 \leq p \leq \infty, s \in \mathbb{N}$, and $T \in \mathcal{B}_{I, p}$. Then

where the constant $C$ depends only on $p$ and $s$.

## 4 Main results

Theorem 16 Let $1 \leq p<\infty, N \geq 0, s \in \mathbb{N}, \delta \in(0,1 / 2)$. Suppose that $\varphi \in \mathcal{L}_{p}$ and $\widetilde{\varphi} \in S_{N, p}^{\prime}$ satisfy the following conditions:

1) $\widehat{\widetilde{\varphi}} \in C^{s+d+1}\left(2 \delta \mathbb{T}^{d}\right)$;
2) $\widehat{\varphi} \in C^{s+d+1}\left(\cup_{l \in \mathbb{Z}^{d}}\left(2 \delta \mathbb{T}^{d}+l\right)\right)$;
3) the Strang-Fix conditions of order $s$ hold for $\varphi$;
4) $D^{\beta}(1-\widehat{\varphi} \overline{\widetilde{\varphi}})(\mathbf{0})=0$ for all $\beta \in \mathbb{Z}_{+}^{d},[\beta]<s$;
5) $\sum_{l \neq \mathbf{0}} \sup _{\xi \in 2 \delta \mathbb{T}^{d}}\left|D^{\beta} \widehat{\varphi}(\xi+l)\right| \leq B_{\varphi}$ for all $\beta \in \mathbb{Z}_{+}^{d}, s \leq[\beta] \leq s+d+1$.

Then, for every $f \in \mathbb{B}_{p, 1}^{d / p+N}(M)$ and $j \in \mathbb{Z}_{+}$, we have

$$
\begin{equation*}
\left\|f-Q_{j}(f, \varphi, \widetilde{\varphi})\right\|_{p} \leq C\left(\Omega_{s}\left(f, M^{-j}\right)_{p}+m^{-j\left(\frac{1}{p}+\frac{N}{d}\right)} \sum_{\nu=j}^{\infty} m^{\left(\frac{1}{p}+\frac{N}{d}\right) \nu} E_{\delta M^{\nu}}(f)_{p}\right) \tag{14}
\end{equation*}
$$

and if, moreover, $\widetilde{\varphi} \in \mathcal{L}_{q}, 1 / p+1 / q=1$, then for every $f \in L_{p}$

\begin{equation*}
\left\|f-Q_{j}(f, \varphi, \widetilde{\varphi})\right\|_{p} \leq C \Omega_{s}\left(f, M^{-j}\right)_{p} \tag{15}
\end{equation*}
$$

where the constant $C$ does not depend on $f$ and $j$.
Proof. First of all note that it suffices to prove (14) and (15) for $j=0$. Indeed,

Obviously, $m^{-j / p} f\left(M^{-j}.\right) \in \mathbb{B}_{p, 1}^{d / p+N}\left(M^{0}\right)$ whenever $f \in \mathbb{B}_{p, 1}^{d / p+N}(M)$. We have also that

E_{\delta M^{\nu}}\left(m^{-j / p} f\left(M^{-j} \cdot\right)\right)_{p} \leq E_{\delta M^{\nu+j}}(f)_{p}
$$

and

\omega_{s}\left(f\left(M^{-j} \cdot\right), 1\right)_{p}=m^{j / p} \Omega_{s}\left(f, M^{-j}\right)_{p}
$$

which yield (14) and (15) whenever these relations hold true for $j=0$.
Let $T \in \mathcal{B}_{\delta I, p} \cap L_{2}$ be such that $\|f-T\|_{p} \leq 2 E_{\delta I}(f)_{p}$. Due to Lemman we need only to check that

Since supp $\widehat{T} \subset \delta \mathbb{T}^{d}$, without loss of generality, in what follows we assume that $\widehat{\widetilde{\varphi}} \in C^{s+d+1}\left(\mathbb{R}^{d}\right)$ and $\operatorname{supp} \widehat{\widetilde{\varphi}} \subset 2 \delta \mathbb{T}^{d}$.

Using Lemma 1 from [21, Carleson's theorem (with cubic convergence of the Fourier series), we derive

\mathcal{F}\left(\sum_{k \in \mathbb{Z}^{d}}\left\langle T, \widetilde{\varphi}_{0 k}\right\rangle \varphi_{0 k}\right)=G \widehat{\varphi}, \tag{17}
\end{equation*}

where $G(\xi):=\sum_{k \in \mathbb{Z}^{d}} \widehat{T}(\xi+k) \overline{\widehat{\widetilde{\varphi}}(\xi+k)}$.
Consider auxiliary functions $\varphi^{*}$ and $\varphi^{(\beta)},[\beta]=s, \beta \in \mathbb{Z}_{+}^{d}$, such that $\widehat{\varphi^{*}}, \widehat{\varphi^{(\beta)}} \in C^{s+d+1}\left(\mathbb{R}^{d}\right)$,

\begin{gathered}
\widehat{\varphi^{*}}(\xi)=\left\{\begin{array}{ll}
\widehat{\varphi}(\xi), & \xi \in \delta \mathbb{T}^{d}, \\
0, & \xi \in \mathbb{T}^{d} \backslash 2 \delta \mathbb{T}^{d}, \\
\widehat{\varphi^{(\beta)}}(\xi)=0 & \text { for } \quad \xi \in \mathbb{T}^{d},
\end{array},\right.
\end{gathered}
$$

and for any $l \in \mathbb{Z}^{d} \backslash\{0\}$

$$
\widehat{\varphi^{(\beta)}}(\xi+l)= \begin{cases}\frac{s}{\beta!} \xi^{\beta} \int_{0}^{1}(1-t)^{s-1} D^{\beta} \widehat{\varphi}(t \xi+l) d t, & \xi \in \delta \mathbb{T}^{d}  \tag{18}\\ 0, & \xi \in \mathbb{T}^{d} \backslash 2 \delta \mathbb{T}^{d}\end{cases}
$$

In view of condition 5 ), we can also provide that

\sum_{l \neq \mathbf{0}} \sup _{\xi \in 2 \delta \mathbb{T}^{d}}\left|D^{\beta^{\prime}}\left(\frac{\widehat{\varphi^{(\beta)}}(\xi+l)}{\xi^{\beta}}\right)\right| \leq B_{\varphi}^{\prime}, \quad \beta^{\prime} \in \mathbb{Z}_{+}^{d}, 0 \leq\left[\beta^{\prime}\right] \leq d+1 \tag{19}
\end{equation*}
$$

By condition 3), taking into account the fact that $\operatorname{supp} \widehat{T} \subset \delta \mathbb{T}^{d}$ and that, by Taylor's formula with the integral reminder,

G(\xi) \widehat{\varphi}(\xi)=\widehat{T}(\xi) \overline{\widetilde{\widetilde{\varphi}}(\xi)} \widehat{\varphi^{*}}(\xi)+G(\xi) \sum_{[\beta]=s} \widehat{\varphi^{(\beta)}}(\xi) \tag{20}
\end{equation*}
$$

It is easy to see that $D^{\beta^{\prime}} \widehat{\varphi^{*}}, D^{\beta^{\prime}} \widehat{\varphi^{(\beta)}} \in L$ for all $\beta^{\prime} \in \mathbb{Z}_{+}^{d}, 0 \leq\left[\beta^{\prime}\right] \leq d+1$. It follows that the functions $\varphi^{*}=\mathcal{F}^{-1}\left(\widehat{\varphi^{*}}\right)$ and $\varphi^{(\beta)}=\mathcal{F}^{-1}\left(\widehat{\varphi^{(\beta)}}\right)$ are in $\mathcal{L}_{p}$.

Using (17) and (20), we have

\left\|T-\sum_{k \in \mathbb{Z}^{d}}\left\langle T, \widetilde{\varphi}_{0 k}\right\rangle \varphi_{0 k}\right\|_{p} & \leq\left\|T-\sum_{k \in \mathbb{Z}^{d}}\left\langle T, \widetilde{\varphi}_{0 k}\right\rangle \varphi_{0 k}^{*}\right\|_{p}+\sum_{[\beta]=s}\left\|\sum_{k \in \mathbb{Z}^{d}}\left\langle T, \widetilde{\varphi}_{0 k}\right\rangle \varphi_{0 k}^{(\beta)}\right\|_{p}  \tag{21}\\
& =: I^{*}+\sum_{[\beta]=s} I^{(\beta)}
\end{align*}
$$

By condition 4), using the Jensen inequality and taking into account the fact that supp $\widehat{T} \subset \delta \mathbb{T}^{d}$ and that by Taylor's formula with the integral reminder

\widehat{\varphi}(\xi) \overline{\widetilde{\widetilde{\varphi}}(\xi)}=1+\sum_{[\beta]=s} \frac{s}{\beta!} \xi^{\beta} \int_{0}^{1}(1-t)^{s-1} D^{\beta} \widehat{\varphi} \overline{\widetilde{\widetilde{\varphi}}}(t \xi) d t
$$

we obtain

\begin{aligned}
I^{*} & =\left\|\mathcal{F}^{-1}\left\{\left(1-\left(\overline{\widehat{\widehat{\varphi}}} \widehat{\varphi^{*}}\right)\right) \widehat{T}\right\}\right\|_{p} \\
& \leq \sum_{[\beta]=s} \frac{s}{\beta!} \int_{0}^{1} d t\left(\int_{\mathbb{R}^{d}}\left|\int_{\mathbb{R}^{d}} D^{\beta} \widehat{\varphi^{*}} \overline{\widehat{\varphi}}(t \xi) \xi^{\beta} \widehat{T}(\xi) e^{2 \pi i(x, \xi)} d \xi\right|^{p} d x\right)^{1 / p} \\
& =\sum_{[\beta]=s} \frac{s}{\beta!} \int_{0}^{1} d t\left(\int_{\mathbb{R}^{d}}\left|\int_{\mathbb{R}^{d}} t^{-d} \mathcal{F}^{-1}\left(D^{\beta} \widehat{\varphi^{*}} \overline{\widetilde{\widetilde{\varphi}}}\right)\left(\frac{y}{t}\right) D^{\beta} T(x-y) d y\right|^{p} d x\right)^{1 / p}
\end{aligned}
$$

Since, obviously, the function $\mathcal{F}^{-1}\left(D^{\beta} \widehat{\varphi^{*}} \overline{\widetilde{\varphi}}\right)$ is summable on $\mathbb{R}^{d}$, this yields

I^{*} \leq \sum_{[\beta]=s} \frac{s}{\beta!}\left\|\mathcal{F}^{-1}\left(D^{\beta} \widehat{\varphi^{*}} \overline{\widetilde{\varphi}}\right)\right\|_{1}\left\|D^{\beta} T\right\|_{p} \leq C_{2} \sum_{[\beta]=s}\left\|D^{\beta} T\right\|_{p} \tag{22}
\end{equation*}
$$

Next, we fix $\beta$ and estimate $I^{(\beta)}$. Set

\widehat{\psi}(\xi)=\frac{\widehat{\varphi^{(\beta)}}(\xi)}{\gamma(\xi)}
$$

where $\gamma$ is a 1-periodic functions (in each variable) such that $\gamma \in C^{d+1}\left(\mathbb{R}^{d}\right)$ and $\gamma(\xi)=\xi^{\beta}$ on $2 \delta \mathbb{T}^{d}$.
Using (18) and (19), we have

\int_{\mathbb{R}^{d}}|\widehat{\psi}(\xi)| d \xi=\sum_{k \in \mathbb{Z}^{d} \mathbb{T}^{d}-k} \int_{\left|\widehat{\varphi^{(\beta)}}(\xi)\right|}^{|\gamma(\xi)|} d \xi=\int_{2 \delta \mathbb{T}^{d}} \frac{\sum_{k \in \mathbb{Z}^{d}}\left|\widehat{\varphi^{(\beta)}}(\xi+k)\right|}{\left|\xi^{\beta}\right|} d \xi \leq B_{\varphi}^{\prime}
$$

Thus $\widehat{\psi} \in L_{1}$, and similarly $D^{\beta^{\prime}} \widehat{\psi} \in L_{1}$ for all $\beta^{\prime}$ such that $\left[\beta^{\prime}\right] \leq d+1$. It follows that $\psi \in \mathcal{L}_{p}$.
Next, we set

\widetilde{\psi}=\mathcal{F}^{-1}(\widehat{\widetilde{\varphi}} \gamma)
$$

and note that $\widetilde{\psi} \in L_{1}$. Since $\psi \in \mathcal{L}_{p}$, using Lemmas 6 and 5, we obtain

\left\|\sum_{k \in \mathbb{Z}^{d}}\left\langle T, \widetilde{\psi}_{0 k}\right\rangle \psi_{0 k}\right\|_{p} \leq\|\psi\|_{\mathcal{L}_{p}}\left(\sum_{k \in \mathbb{Z}^{d}}\left|\left\langle T, \tilde{\psi}_{0 k}\right\rangle\right|^{p}\right)^{1 / p} \leq C_{\beta}\|T * \overline{\widetilde{\psi}}\|_{p}=C_{\beta}\left\|\mathcal{F}^{-1}(\widehat{T} \overline{\widetilde{\widetilde{\psi}}})\right\|_{p}
$$

and

$$
\begin{aligned}
\left\|\mathcal{F}^{-1}(\widehat{T} \overline{\widetilde{\tilde{\psi}}})\right\|_{p} & =\left\|\mathcal{F}^{-1}(\widehat{T} \overline{\widetilde{\widetilde{\varphi}}} \gamma)\right\|_{p}=\left\|\mathcal{F}^{-1}\left(\widehat{D^{\beta} T} \overline{\widetilde{\widetilde{\varphi}}}\right)\right\|_{p} \\
& =\left\|D^{\beta} T * \mathcal{F}^{-1} \overline{\widetilde{\widetilde{\varphi}}}\right\|_{p} \leq\left\|\mathcal{F}^{-1} \overline{\widetilde{\widetilde{\varphi}}}\right\|_{1}\left\|D^{\beta} T\right\|_{p}
\end{aligned}
$$

Since the function $\mathcal{F}^{-1} \overline{\widetilde{\widetilde{\varphi}}}$ is obviously summable on $\mathbb{R}^{d}$, it follows that

\left\|\sum_{k \in \mathbb{Z}^{d}}\left\langle T, \widetilde{\psi}_{0 k}\right\rangle \psi_{0 k}\right\|_{p} \leq C_{\beta}^{\prime}\left\|D^{\beta} T\right\|_{p} \tag{23}

Now let us show that

\end{equation*}

Since the functions $\sum_{k \in \mathbb{Z}^{d}}\left\langle T, \widetilde{\psi}_{0 k}\right\rangle \psi_{0 k}$ and $\sum_{k \in \mathbb{Z}^{d}}\left\langle T, \widetilde{\varphi}_{0 k}\right\rangle \varphi_{0 k}^{(\beta)}$ are locally summable, it suffices to check that their Fourier transforms coincide almost everywhere. Due to Lemma 1 from [21] and Carleson's theorem, we derive

\mathcal{F}\left(\sum_{k \in \mathbb{Z}^{d}}\left\langle T, \widetilde{\psi}_{0 k}\right\rangle \psi_{0 k}\right)(\xi)=\sum_{k \in \mathbb{Z}^{d}} \widehat{T}(\xi+k) \overline{\widehat{\tilde{\psi}}(\xi+k)} \widehat{\psi}(\xi), \\
\mathcal{F}\left(\sum_{k \in \mathbb{Z}^{d}}\left\langle T, \widetilde{\varphi}_{0 k}\right\rangle \varphi_{0 k}^{(\beta)}\right)(\xi)=\sum_{k \in \mathbb{Z}^{d}} \widehat{T}(\xi+k) \overline{\widetilde{\widetilde{\varphi}}(\xi+k)} \widehat{\varphi^{(\beta)}}(\xi) .
\end{gathered}
$$

Since supp $\widehat{T} \subset \delta \mathbb{T}^{d} \subset \mathbb{T}^{d}$, we have for every $\xi \in \mathbb{T}^{d}$ and $l \in \mathbb{Z}^{d}$ that

\mathcal{F}\left(\sum_{k \in \mathbb{Z}^{d}}\left\langle T, \tilde{\psi}_{0 k}\right\rangle \psi_{0 k}\right)(\xi+l) & =\widehat{T}(\xi) \overline{\widehat{\widetilde{\psi}}(\xi)} \widehat{\psi}(\xi+l) \\
& =\widehat{T}(\xi) \overline{\widehat{\widetilde{\varphi}}(\xi)} \widehat{\varphi^{(\beta)}}(\xi+l)=\mathcal{F}\left(\sum_{k \in \mathbb{Z}^{d}}\left\langle T, \widetilde{\varphi}_{0 k}\right\rangle \varphi_{0 k}^{(\beta)}\right)(\xi+l)
\end{aligned}
$$

which implies (24). Therefore, by (23) we have

To prove (16) it remains to apply Lemmas 15 and (14, which completes the proof. $\diamond$
Theorem 17 Let $1 \leq p<\infty, N \geq 0, s \in \mathbb{N}$, and $\delta \in(0,1 / 2)$. Suppose that $\widetilde{\varphi} \in S_{N, p}^{\prime}$ and $\varphi \in L_{p}$ satisfy the following conditions:

1) $\operatorname{supp} \varphi$ is compact;
2) the Strang-Fix conditions of order $s$ hold for $\varphi$;
3) $D^{\beta}(1-\widehat{\varphi} \overline{\widetilde{\varphi}})(\mathbf{0})=0$ for all $\beta \in \mathbb{Z}_{+}^{d},[\beta]<s$;
4) $\widehat{\widetilde{\varphi}} \in C^{s+d+1}\left(2 \delta \mathbb{T}^{d}\right)$.

Then, for every $f \in \mathbb{B}_{p, 1}^{d / p+N}(M)$ and $j \in \mathbb{Z}_{+}$, we have

$$
\left\|f-Q_{j}(f, \varphi, \widetilde{\varphi})\right\|_{p} \leq C\left(\Omega_{s}\left(f, M^{-j}\right)_{p}+m^{-j\left(\frac{1}{p}+\frac{N}{d}\right)} \sum_{\nu=j}^{\infty} m^{\left(\frac{1}{p}+\frac{N}{d}\right) \nu} E_{\delta M^{\nu}}(f)_{p}\right)
$$

and if, moreover, $\widetilde{\varphi} \in \mathcal{L}_{q}, 1 / p+1 / q=1$, then for every $f \in L_{p}$ we have

$$
\left\|f-Q_{j}(f, \varphi, \widetilde{\varphi})\right\|_{p} \leq C \Omega_{s}\left(f, M^{-j}\right)_{p}
$$

where the constant $C$ does not depend on $f$ and $j$.
Proof. It is sufficient to prove the theorem for $j=0$ (see explanations in the proof of Theorem(16), and due to Lemma 13, we need only to check that

\left\|T-\sum_{k \in \mathbb{Z}^{d}}\left\langle T, \widetilde{\varphi}_{0 k}\right\rangle \varphi_{0 k}\right\|_{p} \leq C_{1} \omega_{s}(f, 1)_{p} \tag{25}
\end{equation*}
$$

where $T \in \mathcal{B}_{\delta I, p} \cap L_{2}$ is such that $\|f-T\|_{p} \leq C E_{\delta I}(f)_{p}$.
Let us choose a compactly supported and localy summable function $\widetilde{\theta}$ such that

D^{\beta} \widehat{\widetilde{\theta}}(\mathbf{0})=D^{\beta} \widehat{\widetilde{\varphi}}(\mathbf{0}) \quad \text { for all } \quad \beta \in \mathbb{Z}_{+}^{d},[\beta]<s
$$

An appropriate function $\widetilde{\theta}$ can be easily constructed, e.g., as a linear combination of $B$-splines. Setting $\widetilde{\psi}=\widetilde{\varphi}-\widetilde{\theta}$, we get $D^{\beta} \widehat{\widetilde{\psi}}(\mathbf{0})=0$ whenever $[\beta]<s$.

We have

\left\|T-\sum_{k \in \mathbb{Z}^{d}}\left\langle T, \widetilde{\varphi}_{0 k}\right\rangle \varphi_{0 k}\right\|_{p} \leq\left\|T-\sum_{k \in \mathbb{Z}^{d}}\left\langle T, \widetilde{\theta}_{0 k}\right\rangle \varphi_{0 k}\right\|_{p}+\left\|\sum_{k \in \mathbb{Z}^{d}}\left\langle T, \widetilde{\psi}_{0 k}\right\rangle \varphi_{0 k}\right\|_{p}=I_{1}+I_{2} \tag{26}
\end{equation*}
$$

Since both the functions $\varphi$ and $\widetilde{\theta}$ are compactly supported, due to Theorem 4 and Lemma 14 we derive

\begin{equation*}
I_{1} \leq C_{2} \omega_{s}(T, 1)_{p} \leq C_{2}\left(2^{s}\|f-T\|_{p}+\omega_{s}(f, 1)_{p}\right) \leq C_{3} \omega_{s}(f, 1)_{p} \tag{27}
\end{equation*}
$$

Let us estimate $I_{2}$. Since $\varphi$ has a compact support and $\operatorname{supp} \widehat{T} \subset \delta \mathbb{T}^{d}$, it follows from Lemmas 6 and 5 that

$$
\begin{equation*}
I_{2}^{p} \leq C_{4} \sum_{k \in \mathbb{Z}^{d}}\left|\left\langle T, \widetilde{\psi}_{0 k}\right\rangle\right|^{p} \leq C_{5}\|T * \widetilde{\psi}\|_{p}^{p} \tag{28}
\end{equation*}
$$

Now we check that

$$
\begin{equation*}
\|T * \widetilde{\psi}\|_{p} \leq C_{6} \sum_{[\beta]=s}\left\|D^{\beta} T\right\|_{p} \tag{29}
\end{equation*}
$$

Taking again into account that supp $\widehat{T} \subset \delta \mathbb{T}^{d}$, without loss of generality we can assume that $\widehat{\widetilde{\psi}} \in$ $C^{s+d+1}\left(\mathbb{R}^{d}\right)$. By Taylor's formula with the integral reminder, we have

$$
\widehat{\widetilde{\psi}}(\xi)=\sum_{[\beta]=s} \frac{s}{\beta!} \xi^{\beta} \int_{0}^{1}(1-t)^{s-1} D^{\beta} \widehat{\widetilde{\psi}}(t \xi) d t
$$

Hence,

$$
\begin{align*}
\|T * \widetilde{\psi}\|_{p} & =\left\|\mathcal{F}^{-1}(\overline{\widetilde{\widetilde{\psi}}} \widehat{T})\right\|_{p} \\
& \leq \sum_{[\beta]=s} \frac{s}{\beta!}\left(\left.\left.\int_{\mathbb{R}^{d}} d x\right|_{0} ^{1} d t(1-t)^{s} \int_{\mathbb{R}^{d}} \overline{D^{\beta} \widehat{\widetilde{\psi}}(t \xi)} \xi^{\beta} \widehat{T}(\xi) e^{2 \pi i(\xi, x)} d \xi\right|^{p}\right)^{1 / p} \\
& \leq \sum_{[\beta]=s} \frac{s}{\beta!} \int_{0}^{1} d t\left(\left.\left.\int_{\mathbb{R}^{d}} d x\right|_{\mathbb{R}^{d}} \overline{D^{\beta} \widehat{\widetilde{\psi}}(t \xi)} \widehat{D^{\beta} T}(\xi) e^{2 \pi i(\xi, x)} d \xi\right|^{p}\right)^{1 / p}  \tag{30}\\
& \leq \sum_{[\beta]=s} \frac{s}{\beta!} \int_{0}^{1} \frac{d t}{t^{d-d / p}}\left(\int_{\mathbb{R}^{d}} d x \mid \int_{\mathbb{R}^{d}} \overline{D^{\beta}} \overline{\widetilde{\psi}}(\xi)\right. \\
D^{\beta} T & \left.\left.\frac{\xi}{t}\right)\left.e^{2 \pi i(\xi, x)} d \xi\right|^{p}\right)^{1 / p} \\
& =\sum_{[\beta]=s} \frac{s}{\beta!} \int_{0}^{1} t^{d / p}\left\|\mathcal{F}^{-1}\left\{\overline{D^{\beta} \widehat{\widetilde{\psi}}} \widehat{Q_{\beta, t}}\right\}\right\| \|_{p} d t
\end{align*}
$$

where $Q_{\beta, t}(x)=D^{\beta} T(t x)$. Taking into account that $D^{\beta} \widehat{\widetilde{\psi}} \in C^{d+1}\left(\mathbb{R}^{d}\right)$ whenever $[\beta]=s$, i.e. $\mathcal{F}^{-1}\left\{D^{\beta} \widetilde{\widetilde{\psi}}\right\} \in L_{1}$, we have

$$
\begin{align*}
\left\|\mathcal{F}^{-1}\left\{\overline{D^{\beta} \widehat{\widetilde{\psi}}} \widehat{Q_{\beta, t}}\right\}\right\|_{p} & =\left\|\mathcal{F}^{-1}\left\{D^{\beta} \widehat{\widetilde{\psi}}\right\} * Q_{\beta, t}\right\|_{p}  \tag{31}\\
& \leq\left\|\mathcal{F}^{-1}\left\{D^{\beta} \widehat{\widetilde{\psi}}\right\}\right\|_{1} t^{-d / p}\left\|D^{\beta} T\right\|_{p}=C_{8} t^{-d / p}\left\|D^{\beta} T\right\|_{p}
\end{align*}
$$

Combining these estimates with (30), we obtain (29). Next, similarly as in (27), using (29), (28), and Lemmas 15 and 14 , we get

$$
\begin{equation*}
I_{2} \leq C_{9} \omega_{s}(f, 1)_{p} \tag{32}
\end{equation*}
$$

Finally, combining (26), (27), and (32), we complete the proof. $\diamond$
Remark 18 The conditions on smoothness of $\widehat{\widetilde{\varphi}}$ in Theorem 17 can be relaxed and given in other terms using different sufficient conditions for Fourier multiplier in $L_{p}$ spaces, see e.g., [22] and [17]. For this, one needs to estimate the corresponding multiplier norm of the function $D^{\beta} \widehat{\widetilde{\psi}}$ instead of to show that $\mathcal{F}^{-1}\left\{D^{\beta} \widehat{\widetilde{\psi}}\right\} \in L_{1}$ in inequality (31). A similar conclusion is valid also for the smoothness conditions on $\widehat{\varphi}$ and $\widehat{\widetilde{\varphi}}$ in Theorem (16.

Remark 19 It is not difficult to verify that Theorems 16 and 17 are valid also in the spaces $L_{\infty}$ if we additionally suppose that $f \in L_{2} \cap L_{\infty}$ and replace the best approximation $E_{\delta M^{\mu}}(f)_{p}$ with $E_{\delta M^{\mu}}^{*}(f)_{p}$. See also [20, Theorem 17] for the corresponding analogue of Lemma 14.

Let us compare Theorems 16 and 17 with Theorem 2 in the case of the isotropic matrix $M$, $\widetilde{\varphi} \in S_{N, p}^{\prime}$, and $p \geq 2$. First let us show that the class of functions $f$ considered in Theorem 2 is smaller than $\mathbb{B}_{p, 1}^{d / p+N}(M)$. Let $\lambda$ be an eigenvalue of $M, f \in L_{p}, \widehat{f} \in L_{q}$, and $\widehat{f}(\xi)=O\left(|\xi|^{-N-d-\varepsilon}\right)$ as $|\xi| \rightarrow \infty, \varepsilon>0$. Setting $V_{\mu} f=\mathcal{F}^{-1} v * f$, where $v \in C^{\infty}(\mathbb{R}), v(\xi) \leq 1, v(\xi)=1$ if $\left|M^{-\mu} \xi\right| \leq 1 / 2$ and $v(\xi)=0$ if $\left|M^{-\mu} \xi\right| \geq 1$, using Pitt's inequality (see, e.g., [13, inequality (1.1)])

$$
\|f\|_{p} \leq C(p)\left(\int_{\mathbb{R}^{d}}|\xi|^{d(p-2)}|\widehat{f}(\xi)|^{p} d \xi\right)^{\frac{1}{p}}, \quad 2<p<\infty
$$

and taking into account (2), we obtain

$$
\begin{aligned}
E_{M^{\mu}}(f)_{p} & \leq\left\|f-V_{\mu}(f)\right\|_{p} \leq C(p)\left(\int_{\left|M^{-\mu} \xi\right| \geq 1 / 2}|\xi|^{d(p-2)}|(1-v(\xi)) \widehat{f}(\xi)|^{p} d \xi\right)^{\frac{1}{p}} \\
& \leq 2 C(p)\left(\int_{|\xi| \geq 1 / 2\left\|M^{-\mu}\right\|}|\xi|^{d(p-2)}|\widehat{f}(\xi)|^{p} d \xi\right)^{\frac{1}{p}}=\mathcal{O}\left(|\lambda|^{-\mu(d / p+N+\varepsilon)}\right), \quad \mu \rightarrow \infty .
\end{aligned}
$$

It follows that $f \in \mathbb{B}_{p, 1}^{d / p+N}(M)$.
Next let us compare the error estimates. Using (2), we have

$$
\Omega_{s}\left(f, M^{-j}\right) \leq C_{1} \omega_{s}\left(f,|\lambda|^{-j}\right)
$$

where $C_{1}$ does not depend on $f$ and $j$, and

$$
E_{|\lambda|^{\mu} I}(f) \leq C_{2} E_{\sigma M^{\mu}}(f)_{p} \leq C_{3} E_{M^{\mu-\mu_{0}}}(f)_{p}
$$

where $C_{2}, C_{3}, \sigma$, and $\mu_{0}$ do not depend on $f$ and $j$. Hence

$$
E_{|\lambda|^{\mu} I}(f)_{p}=\mathcal{O}\left(|\lambda|^{-\mu(d / p+N+\varepsilon)}\right), \quad \mu \rightarrow \infty
$$

Using these relations and the following inverse approximation inequality (see [12]):

$$
\begin{equation*}
\omega_{s}\left(f, 2^{-j}\right)_{p} \leq C 2^{-s j}\left(\sum_{k=0}^{j} 2^{2 s k} E_{2^{k} I}(f)_{p}^{2}\right)^{\frac{1}{2}} \tag{33}
\end{equation*}
$$

we can easily see that inequality (14) provides the following approximation order

$$
\left\|f-Q_{j}(f, \varphi, \widetilde{\varphi})\right\|_{p} \leq \begin{cases}C|\lambda|^{-j\left(N+\frac{d}{p}+\varepsilon\right)} & \text { if } s>N+\frac{d}{p}+\varepsilon \\ C(j+1)^{1 / 2}|\lambda|^{-j s} & \text { if } s=N+\frac{d}{p}+\varepsilon \\ C|\lambda|^{-j s} & \text { if } s<N+\frac{d}{p}+\varepsilon\end{cases}
$$

which is better than one given in Theorem 2 in the case $s=N+\frac{d}{p}+\varepsilon$, and the same in the other cases.

On the other hand, there exist functions in $\mathbb{B}_{p, 1}^{d / p+N}(M)$ which do not satisfy assumptions of Theorem 2, Indeed, let $b \leq N+d, \varepsilon>0$,

$$
\begin{gathered}
a>\max \left\{1,(d+N+\varepsilon-b)\left(\frac{1}{2}-\frac{1}{p}\right)^{-1}\right\} \\
\widehat{f}(\xi)=\kappa(|\xi|) \frac{e^{i|\xi|^{a}}}{|\xi|^{b}}
\end{gathered}
$$

where $\kappa \in C^{\infty}(\mathbb{R}), \kappa(u)=0$ for $u=[0,1], \kappa(u)=1$ for $u \geq 2$. Obviously, the decay of $\widehat{f}$ is not enough for Theorem 2] Let us verify that $f:=\mathcal{F}^{-1}(\widehat{f})$ is in $L_{p}$ and $E_{M^{\nu}}(f)_{p}=\mathcal{O}\left(|\lambda|^{-\gamma \nu}\right)$, where $\gamma=\frac{d}{p}+N+\varepsilon$, i.e., $f \in \mathbb{B}_{p, 1}^{d / p+N}(M)$. Setting $g(\xi):=|\xi|^{\gamma} \widehat{f}(\xi)$ and using Proposition 5.1 from [23]) we conclude that the functions $\mathcal{F}^{-1} \widehat{f}$ and $\mathcal{F}^{-1} g$ are smooth throughout $\mathbb{R}^{d}$ and

$$
\mathcal{F}^{-1}(\widehat{f})(x)=d_{0}|x|^{-\frac{b-d+d a / 2}{a-1}} \exp \left(i d_{1}|x|^{\frac{a}{a-1}}\right)+o\left(|x|^{-\frac{b-d+d a / 2}{a-1}}\right) \quad \text { as } \quad|x| \rightarrow \infty
$$

$$
\mathcal{F}^{-1}(g)(x)=d_{0}|x|^{-\frac{b-\gamma-d+d a / 2}{a-1}} \exp \left(i d_{1}|x|^{\frac{a}{a-1}}\right)+o\left(|x|^{-\frac{b-\gamma-d+d a / 2}{a-1}}\right) \quad \text { as } \quad|x| \rightarrow \infty
$$

It follows that $f \in L_{p}$ and $\mathcal{F}^{-1} g \in L_{p}$, which yields that $f \in \dot{H}_{p}^{\gamma}$ (the homogeneous Sobolev spaces). Then, using the embedding $\dot{H}_{p}^{\gamma} \subset \dot{B}_{p, \infty}^{\gamma}$ (the homogeneous Besov space, see, e.g., [1, Theorem 6.3.1]) and Jackson's theorem, we obtain $E_{M^{\nu}}(f)_{p} \leq C \omega_{[\gamma]+1}\left(f,|\lambda|^{j}\right)_{p} \leq C\|f\|_{\dot{B}_{p, \infty}^{\gamma}}|\lambda|^{-\gamma j}$.

Finally we consider an anisotropic case. Let $d=2, M=\operatorname{diag}\left(m_{1}, m_{2}\right)$, and $\frac{\partial^{r_{1}}}{\partial x_{1}^{r_{1}}} f, \frac{\partial^{r_{2}}}{\partial x_{2}^{r_{2}}} f \in L_{p}$, where $r_{1}>\left(\frac{1}{p}+\frac{N}{d}\right)\left(1+\frac{\ln m_{2}}{\ln m_{1}}\right)$ and $r_{2}>\left(\frac{1}{p}+\frac{N}{d}\right)\left(1+\frac{\ln m_{1}}{\ln m_{2}}\right)$. Then, taking into account that for $1<p<\infty$ and $s>\max \left(r_{1}, r_{2}\right)$, see, e.g., 31.

$$
E_{M^{\nu}}(f)_{p} \leq C \Omega_{s}\left(f, M^{-\nu}\right)_{p} \leq C\left(\omega_{s}^{(1)}\left(f, m_{1}^{-j}\right)_{p}+\omega_{s}^{(2)}\left(f, m_{2}^{-j}\right)_{p}\right)=\mathcal{O}\left(m_{1}^{-r_{1} j}+m_{2}^{-r_{2} j}\right)
$$

where $\omega_{s}^{(\ell)}(f, h)_{p}$ is the partial modulus of smoothness with respect to $\ell$-th variable, we have that $f \in \mathbb{B}_{p, 1}^{d / p+N}(M)$, and by Theorem 16 with $s>\max \left(r_{1}, r_{2}\right)$, we get

$$
\left\|f-Q_{j}(f, \varphi, \widetilde{\varphi})\right\|_{p}=\mathcal{O}\left(m_{1}^{-r_{1} j}+m_{2}^{-r_{2} j}\right)
$$

That is, the order of approximation by $Q_{j}(f, \varphi, \widetilde{\varphi})$ essentially depends on anisotropic nature of the function $f$ and the matrix $M$.

## 5 Conclusions

Error estimates in $L_{p}$-norm are obtained for a large class of sampling-type quasi-projection operators $Q_{j}(f, \varphi, \widetilde{\varphi})$ including the classical case, where $\widetilde{\varphi}$ is the Dirac delta-function. Theorems 16 and 17 provide essential improvements of the recent results in [21]. First, the estimates are given for a wider class of approximated functions, namely for functions from anisotropic Besov spaces. Second, only the case $p \geq 2$ was considered in [21], while $1 \leq p<\infty$ in Theorems 16 and 17 Third, the estimates are given in terms of the moduli of smoothness and best approximations, while the results in [21] provide only approximation order.
