# CONVERGENCE OF A FINITE ELEMENT METHOD FOR DEGENERATE TWO-PHASE FLOW IN POROUS MEDIA

#### Abstract

A finite element method with mass-lumping and flux upwinding, is formulated for solving the immiscible two-phase flow problem in porous media. The method approximates directly the wetting phase pressure and saturation, which are the primary unknowns. The discrete saturation satisfies a maximum principle. Theoretical convergence is proved via a compactness argument. The proof is convoluted because of the degeneracy of the phase mobilities and the unboundedness of the capillary pressure.


1. Introduction. This work discretizes on a suitable mesh a degenerate two-phase flow system set in a polyhedral domain by a new finite element scheme that directly approximates the wetting phase pressure and saturation, similar to the formulation proposed in [18]. Mass lumping is used to compute the integrals and a suitable upwinding is used to compute the flux, guaranteeing that the discrete saturation satisfies a maximum principle. The resulting system of discrete equations is a finite element analogue of the finite volume scheme introduced and analyzed by Eymard et al in the seminal work [16. From the point of view of implementation, the advantage of finite elements is that they only use nodal values and a single simplicial mesh. In particular, no orthogonality property is required between the faces and the lines joining the centers of control volumes. From a theoretical point of view, owing that the finite element scheme is based on functions, some steps in its convergence analysis are simpler, but nevertheless the major difficulty in the analysis consists in proving sufficient a priori estimates in spite of the degeneracy. By following closely [16], the degeneracy is remediated by reintroducing in the proofs discrete artificial pressures. From there, convergence of the numerical solutions is shown via a compactness argument.
Incompressible two-phase flow is a popular and important multiphase flow model in reservoirs for the oil and gas industry. Based on conservation laws at the continuum scale, the model assumes the existence of a representative elementary volume. Each wetting phase and non-wetting phase saturation satisfies a mass balance equation and each phase velocity follows the generalized Darcy law [25, 4]. The equations of the mathematical model read

complemented by initial and boundary conditions. Here $p_{w}, s_{w}, \eta_{w}, f_{w}$, (respectively, $p_{o}, s_{o}, \eta_{o}, f_{o}$ ), are the pressure, saturation, mobility and fractional flow of the wetting (respectively non-

[^0]wetting) phase, $\varphi$ is the porosity, $s_{\text {in }}$ is a given input saturation, and $\bar{q}, \underline{q}$ are given flow rates. The capillary pressure, $p_{c}$, is a given function that depends nonlinearly on the saturation. Because the phase mobilities are degenerate when they are evaluated at the residual phase saturations and the derivative of the capillary pressure is unbounded, this system of two coupled nonlinear partial differential equations has coefficients that vanish in parts of the domain; this degeneracy makes the numerical analysis challenging.
At the continuous level, this problem has several equivalent formulations, see [7]. They are linked to the choice of primary unknowns selected among wetting phase and non-wetting phase pressure and saturation, or capillary pressure [20, 5]. A good state of the art can be found in the reference [2]. Up to our knowledge, the mathematical analysis of the system of equations was first done in [21, 1]. An equivalent formulation of the model, based on Chavent's global pressure that removes the degeneracy, was analyzed in [8, 9]. Since then, the global pressure formulation has been discretized and analyzed in many references [24, 10, 23], but unfortunately, this formulation is not used in engineering practice because the global pressure is not a physical unknown. Otherwise, with one exception, the numerical analysis of the discrete version of (1.1), has always been done under unrealistic assumptions that cannot be checked at the discrete level [13, 14]. Related to this line of work, the discretization of a degenerate parabolic equation has been studied in the literature [3, 28, 27, 17]. The only paper that performs the complete numerical analysis of the discrete degenerate two-phase flow system written as above (i.e., in the form used by engineers) is the analysis on finite volumes done in reference [16]. This motivates our extension of this work to finite elements.

The remaining part of this introduction makes precise problem (1.1). The numerical scheme is developed in Section 2. Because of the nonlinearity and degeneracy of its equations, existence of a discrete solution requires that the discrete wetting phase saturation satisfies a maximum principle. This is the first object of Section 3, the second one being basic a priori pressure estimates, after which existence is shown in Section 4. The most technical part, done in Section 5 , is the derivation of an unconditional bound on an auxiliary pressure, which allows to use a compactness argument. Weak and strong convergences are proved in Section 6 and the equations satisfied by the limit are identified in Section 7, thus confirming existence of a solution of the weak formulation (1.16). Numerical results are presented in Section 8 .
1.1. Model problem. Let $\Omega \subset \mathbb{R}^{d}, d=2$ or 3 , be a bounded connected Lipschitz domain with boundary $\partial \Omega$ and unit exterior normal $\boldsymbol{n}$, and let $T$ be a final time. With the last relation in (1.1), $s_{w}$ is the only unknown saturation; so we set $s=s_{w}$, and rewrite (1.1) almost everywhere in $\Omega \times] 0, T[$ as

complemented by a natural boundary condition almost everywhere on $\partial \Omega \times] 0, T$ [

The fractional flows are related to the mobilities by

Recall that the phase saturations sum up to 1 and the phase pressures are related by

The first part of this work, up to Section 5.7, is done under the following basic assumptions:

## Assumptions

- The porosity $\varphi$ is piecewise constant in space, independent of time, positive, bounded and uniformly bounded away from zero.
- The mobility of the wetting phase $\eta_{w} \geq 0$ is continuous and increasing. The mobility of the non-wetting phase $\eta_{o} \geq 0$ is continuous and decreasing. This implies that the function $f_{w}$ is increasing and the function $f_{o}$ is decreasing.
- There is a positive constant $\eta_{*}$ such that

- The capillary pressure $p_{c}$ is a continuous, strictly decreasing function in $W^{1,1}(0,1)$.
- The flow rates at the injection and production wells, $\bar{q}, \underline{q} \in L^{2}(\Omega \times] 0, T[)$ satisfy

- The prescribed input saturation $s_{\text {in }}$ satisfies almost everywhere in $\left.\Omega \times\right] 0, T[$

Since $p_{c}, \eta_{\alpha}, f_{\alpha}, \alpha=w, o$ are bounded above and below, it is convenient to extend them continuously by constants to $\mathbb{R}$.

Although the numerical scheme studied below does not discretize the global pressure, following [16], its convergence proof uses a number of auxiliary functions related to the global pressure. First, we introduce the primitive $g_{c}$ of $p_{c}$,

Since $p_{c}$ is a continuous function on $[0,1]$, the function $g_{c}$ belongs to $\mathcal{C}^{1}([0,1])$. Next, we introduce the auxiliary pressures $p_{w g}, p_{w o}$, and $g$,

1.2. Weak variational formulation. By multiplying (1.2) and (1.3) with a smooth function $v$, say $v \in \mathcal{C}^{1}(\Omega \times[0, T])$ that vanishes at $t=T$, applying Green's formula in time and space, and using the boundary and initial conditions (1.4) and (1.5), we formally derive a weak variational formulation

But in general, the pressures are not sufficiently smooth to make this formulation meaningful and following [7], by using (1.15), it is rewritten in terms of the artificial pressures,

The two formulas coincide when the pressures are slightly more regular. With the above assumptions, problem (1.16) has been analyzed in reference [1], where it is shown that it has a solution $s$ in $L^{\infty}(\Omega \times] 0, T[)$ with $g(s)$ in $L^{2}\left(0, T ; H^{1}(\Omega)\right), p_{\alpha}, \alpha=w, o$, in $L^{2}(\Omega \times] 0, T[)$ with both $p_{w}+p_{w g}(s)$ and $p_{o}-p_{o g}(s)$ in $L^{2}\left(0, T ; H^{1}(\Omega)\right)$.
2. Scheme. From now on, we assume that $\Omega$ is a polygon $(d=2)$ or Lipschitz polyhedron $(d=3)$ so it can be entirely meshed.
2.1. Meshes and discretization spaces. The mesh $\mathcal{T}_{h}$ is a regular family of simplices $K$, with a constraint on the angle that will be used to enforce the maximum principle: each angle is not larger than $\pi / 2$, see [6]. This is easily constructed in 2D. In 3D, since we only investigate convergence we can embed the domain in a triangulated box. Moreover, since the porosity $\varphi$ is a piecewise constant, to simplify we also assume that the mesh is such that $\varphi$ is a constant per element. The parameter $h$ denotes the mesh size i.e., the maximum diameter of the simplices. On this mesh, we consider the standard finite element space of order one

Thus the dimension of $X_{h}$ is the number of nodes, say $M$, of $\mathcal{T}_{h}$. Let $\phi_{i}$ be the Lagrange basis function, that is piecewise linear, and takes the value 1 at node $i$ and the value 0 elsewhere. As usual, the Lagrange interpolation operator $I_{h} \in \mathcal{L}\left(\mathcal{C}^{0}(\bar{\Omega}) ; X_{h}\right)$ is defined by

where $v_{i}$ is the value of $v$ at the node of index $i$. It is easy to see that under the mesh condition, we have

where $f_{i_{\ell}}$ is the value of the function $f$ at the $\ell^{\text {th }}$ node (vertex), with global number $i_{\ell}$, of $K$. For any region $\mathcal{O}$, the notation $|\mathcal{O}|$ means the measure (volume) of $\mathcal{O}$.

We define

and taking into account the porosity $\varphi$, we define more generally

This is also true for other piecewise polynomial functions, but with possibly different constants. The scalar product associated with this norm is denoted by $(\cdot, \cdot)_{h}$,

The assumptions on the porosity $\varphi$ imply that (2.7) defines a weighted scalar product associated with the weighted norm $\|\cdot\|_{h}^{\varphi}$,

2.2. Motivation of the space discretization. While discretizing the time derivative is fairly straightforward, discretizing the space derivatives is more delicate because we need a scheme that is consistent and satisfies the maximum principle for the saturation. For the moment, we freeze the time variable and focus on consistency in space. First, we recall a standard property of functions of $X_{h}$ on meshes satisfying (2.3).
Proposition 2.1. Under condition (2.3), the following identities holds for all $U_{h}$ and $V_{h}$ in $X_{h}$, with $c_{i j}$ defined in (2.4):

Note that $c_{i j}$ vanishes when $j \notin \mathcal{N}(i)$. Therefore, when there is no ambiguity it is convenient to write the above double sums on $i$ and $j$ with $i$ and $j$ running from 1 to $M$.

As an immediate consequence of Proposition 2.1, we have, by taking $V_{h}=U_{h}$,

Now, we consider the case of the product of the gradients by a third function. Beforehand, we introduce the following notation: for indices $i$ and $j$ of two neighboring interior nodes, $\Delta_{i} \cap \Delta_{j}$ in two dimensions is the union of two triangles and in three dimensions the union of a number of tetrahedra bounded by a fixed constant, say $L$, determined by the regularity of the mesh. We shall use the following notation

But, in view of (2.11) and (2.15), and since $\nabla \phi_{i} \cdot \nabla \phi_{j}$ is a constant in each element $K$ contained in $\Delta_{i} \cap \Delta_{j}$,

Note that $d_{i j}=d_{j i}$ owing to (2.17). The first consequence of Proposition 2.2 is that the right-hand side of (2.13) is a consistent approximation of $(w, \nabla u \cdot \nabla v)$.
Proposition 2.3. Let (2.3) hold, let $u$ and $v$ belong to $H^{2}(\Omega)$ and $w$ to $L^{\infty}(\Omega)$, and let $U_{h}=I_{h} u, V_{h}=I_{h} v$ be defined by (2.2). Then, there exists a constant $C$, independent of $h, M, u, v$, and $w$, such that

REmark 2.5. Before setting (2.32)-(2.35) in variational form, observe that:

1. The scheme (2.32) $-(2.35)$ forms a square system in the primary unknowns, $S_{h}^{n}$ and $P_{w}^{n}$.
2. Formula (2.32) is also valid for $i=M$. Indeed, we pass to the left-hand side the righthand side of (2.32) and set $A^{i}$ the resulting line of index $i$. Let $\tilde{A}^{M}$ denote what should be the line of index $M$, i.e.,

As usual, it is convenient to associate time functions $S_{h, \tau}, P_{\alpha, h, \tau}$ with the sequences indexed by $n$. These are piecewise constant in time in $] 0, T[$, for instance

Strictly speaking, the interpolation operator $I_{h}$ is introduced in (2.42) and (2.43) because the forms are defined for functions of $X_{h}$, but for the sake of simplicity, since only nodal values are used, it may be dropped further on.
We shall see that under the above basic hypotheses, the discrete problem (2.42)-(2.45) has at least one solution. In the sequel, we shall use the following discrete auxiliary pressures (compare with (1.16)):

The proof of the theorem requires several steps that are covered in the remaining of this work.
3. First a priori bounds. This section is devoted to basic a priori bounds used in proving existence of a discrete solution. Existence is fairly technical and will be postponed till Section 4. The first step is a key bound on the discrete saturation. In a second step, this bound will lead to a pressure estimate and in particular to a bound on the discrete analogue of auxiliary pressures.
3.1. Maximum principle. The scheme (2.32)-(2.35) satisfies the maximum principle property. The proof given below uses a standard argument as in [16].
Theorem 3.1. The following bounds hold:

We first show that (3.2) holds true with $S_{w}^{i j}$ replaced by $S^{i}$. Indeed if $P_{w}^{i}>P_{w}^{j}$, then $S_{w}^{i j}=S^{i}$. If $P_{w}^{i}<P_{w}^{j}$, then $S_{w}^{i j}=S^{j}$, and as $\eta_{w}$ is increasing and by assumption, $S^{j} \leq S^{i}$,

Y= & \left(\bar{q}_{h}-\underline{q}_{h}, U_{w, h}\right)_{h}+\left(f_{o}\left(s_{\mathrm{in}, h}\right) \bar{q}_{h}-f_{o}\left(S_{h}\right) \underline{q}_{h}, p_{c}(0)\right)_{h} \\
& +\left(f_{o}\left(s_{\mathrm{in}, h}\right) \bar{q}_{h}-f_{o}\left(S_{h}\right) \underline{q}_{h}, p_{o g}\left(S_{h}\right)\right)_{h}-\left(f_{w}\left(s_{\mathrm{in}, h}\right) \bar{q}_{h}-f_{w}\left(S_{h}\right) \underline{q}_{h}, p_{w g}\left(S_{h}\right)\right)_{h}=T_{1}+\cdots+T_{4} .
\end{aligned}

We now bound each term $T_{i}$. For $T_{1}$, (2.31) implies that any constant $\beta$ can be added to $U_{w, h}$, in particular $\beta$ can be chosen so that the sum has zero mean value in $\Omega$. Hence, considering the generalized Poincaré inequality

4. Existence of numerical solution. We fix $n \geq 1$ and assume there exists a solution $\left(S_{h}^{n-1}, P_{w, h}^{n-1}\right)$ at time $t^{n-1}$ with $0 \leq S_{h}^{n-1} \leq 1$. We want to show existence of a solution $\left(S_{h}^{n}, P_{w, h}^{n}\right)$ by means of the topological degree [11, 12].
Let $\theta$ be a constant parameter in $[0,1]$. For any continuous function $f:[0,1] \rightarrow \mathbb{R}$, we define the transformed function $\widetilde{f}:[0,1] \rightarrow \mathbb{R}$ by

As in (2.36) and (2.37), it leads us to introduce the variables $\zeta_{w}^{i j}$ and $\zeta_{o}^{i j}$ for all $1 \leq i, j \leq M$. Clearly, (4.2)-(4.4) determine uniquely $A_{h}$ and $B_{h}$, and it is easy to check that $A_{h}+B_{h}$ belongs to $X_{0, h}$.

The mapping $t \mapsto \mathcal{F}\left(t, \zeta_{h}, \Lambda_{h}\right)$ is continuous. Indeed, since the space has finite dimension, we only need to check continuity of the upwinding. By splitting $x$ into its positive and negative part, $x=x^{+}+x^{-}$, the upwind term, say $\widetilde{\eta_{w}}\left(\zeta_{w}^{i j}\right)\left(P_{w}^{j}-P_{w}^{i}\right)$ reads

Conversely, if $\left(\zeta_{h}, \Lambda_{h}\right)$ solves (2.42)-(2.45) then $\mathcal{F}\left(1, \zeta_{h}, \Lambda_{h}\right)=\mathbf{0}$. Thus showing existence of a solution to the problem (2.42)-(2.45) is equivalent to showing existence of a zero of $\mathcal{F}\left(1, \zeta_{h}, \Lambda_{h}\right)$. Before proving existence of a zero, we use the estimates established in the previous section to determine an a priori bound of any zero $\left(\zeta_{h}, \Lambda_{h}\right)$ of $\mathcal{F}\left(1, \zeta_{h}, \Lambda_{h}\right)$.
4.1. A priori bounds on $\left(\zeta_{h}, \Lambda_{h}\right)$. In the following we consider $t \in[0,1]$ and $\left(\zeta_{h}, \Lambda_{h}\right) \in$ $X_{h} \times X_{0, h}$ that satisfy

To finish the proof we must show that

We add the first two equations, multiply by $\Lambda^{i}$, and sum over i. Then (2.10) and (2.41) imply that $\Lambda_{h}$ is a constant and finally (4.13) shows that this constant is zero. This yields $\zeta_{h}=0$.
Next, we argue on the topological degree. Since the topological degree of a linear map is the sign of its determinant, we have

Therefore we have

5. Additional pressure estimates. The pressure estimates (3.18) and (3.23) are not sufficient to pass to the limit in the scheme (2.42)-(2.45). These are nonlinear equations and we need strong convergences that do not stem directly from (3.18) and (3.23).

Following [16], we propose to derive a bound for the gradient of $g$, see (1.13), at $s=S_{h, \tau}$. Then, under suitable assumptions on the behavior of $\eta_{w}^{\prime}, \eta_{o}^{\prime}$, and $p_{c}^{\prime}$, we shall prove the strong convergence of $g\left(S_{h, \tau}\right)$ in $L^{2}(\Omega \times] 0, T[)$ and in turn the strong convergence of $S_{h, \tau}$ in $L^{2}(\Omega \times] 0, T[)$.
Estimating the gradient of $g\left(S_{h, \tau}\right)$ is a long and intricate process; it is based on the fact that

G\left(S_{h}^{n}\right)-G\left(S_{h}^{n-1}\right)=\left(S_{h}^{n}-S_{h}^{n-1}\right) G^{\prime}(c)
$$

for some $c$ between $S_{h}^{n}-S_{h}^{n-1}$, we easily check that

5.2. Some discrete total flux inequalities. In this section, it is convenient to work directly on the scheme (2.32) $-(2.33)$. For each index $i$, the sum of the equations (2.32) and (2.33) give, for $1 \leq i \leq M$ and $1 \leq n \leq N$,

& +\sum_{i=1}^{M} \sum_{j \in \mathcal{N}(i), P_{w}^{n, i}=P_{w}^{n, j}} c_{i j}\left(f_{w}\left(S^{n, j}\right)-f_{w}\left(S^{n, i}\right)\right)\left(g\left(S^{n, j}\right)-g\left(S^{n, i}\right)\right),
\end{aligned}
$$

and (5.40), with another constant $C$, follows by substituting this equality into (5.41). $\square$
5.7. Bound for the gradient of $g$. In order to deduce from (5.40) a direct bound for the gradient of $g$, we need to sharpen the assumptions on the mobility.

\frac{1}{\alpha_{3}} x^{\beta_{3}-1}(1-x)^{\beta_{4}-1} \geq-p_{c}^{\prime}(x) \geq \alpha_{3} x^{\beta_{3}-1}(1-x)^{\beta_{4}-1}, \quad \beta_{3}, \beta_{4}>0,0<\alpha_{3} \leq 1 . \tag{5.44}
\end{gather*}

\end{equation*}

Let us use these results to compare $g^{\prime}$ and $f_{w}^{\prime}$. It follows from (5.49) that

and comparing with (5.53), we obtain

6. Convergence. The interpolants of $p_{\alpha g}\left(S_{h, \tau}\right), g\left(S_{h, \tau}\right)$, and $p_{c}\left(S_{h, \tau}\right)$ play an important part in this work, see Theorems 3.5 and 5.15, and (2.44). Therefore, we begin by studying convergence properties first of $I_{h}\left(g\left(S_{h, \tau}\right)\right)$ and $I_{h}\left(p_{\alpha g}\left(S_{h, \tau}\right)\right), \alpha=w, o$, and next $I_{h}\left(p_{c}\left(S_{h, \tau}\right)\right)$. Some results will stem from an interesting relation between differences in values of $S_{h, \tau}$ and $g\left(S_{h, \tau}\right)$.
6.1. Properties of $I_{h}\left(g\left(S_{h, \tau}\right)\right)$ and $I_{h}\left(p_{\alpha g}\left(S_{h, \tau}\right)\right), \alpha=w, o$.
6.1.1. Convergence properties of $I_{h}\left(g\left(S_{h, \tau}\right)\right)$. Let $K$ be an element of $\mathcal{T}_{h}$ with vertices $\boldsymbol{a}_{i}, 1 \leq i \leq d+1$ (local numbers); then

\end{equation*}

owing to (2.5) and (2.8). These inequalities carry over to the norm in $L^{2}(\Omega \times] 0, T[)$.
Now, let us prove the following convergence property of $I_{h}\left(g\left(S_{h, \tau}\right)\right)$.
Lemma 6.1. Under the assumptions of Theorem 5.15, we have

$$
\begin{equation*}
\lim _{(h, \tau) \rightarrow(0,0)}\left\|g\left(S_{h, \tau}\right)-I_{h}\left(g\left(S_{h, \tau}\right)\right)\right\|_{L^{2}(\Omega \times] 0, T[)}=0 . \tag{6.2}
\end{equation*}
$$

Proof. For any $\boldsymbol{x}$ in any element $K$ of $\mathcal{T}_{h}$, we have

I_{h}\left(g\left(S_{h, \tau}\right)\right)\left(\boldsymbol{x}, t_{n}\right)-g\left(S_{h, \tau}\right)\left(\boldsymbol{x}, t_{n}\right)=\sum_{i=1}^{d+1} g\left(S^{n, i}\right) \phi_{i}(\boldsymbol{x})-g\left(\sum_{i=1}^{d+1} S^{n, i} \phi_{i}(\boldsymbol{x})\right)
$$

As $S_{h, \tau}$ is a polynomial of degree one in $K$, it attains its maximum and its minimum in space at vertices of $K$, say $g\left(S^{n, \ell}\right)$ and $g\left(S^{n, r}\right)$ are its maximum and minimum respectively. Thus, recalling that $g$ is a nonnegative monotonically increasing function,

\sum_{i=1}^{d+1} g\left(S^{n, i}\right) \phi_{i}(\boldsymbol{x}) \leq g\left(S^{n, \ell}\right), \quad g\left(\sum_{i=1}^{d+1} S^{n, i} \phi_{i}(\boldsymbol{x})\right) \geq g\left(S^{n, r}\right)
$$

Hence

\begin{equation*}
\left\|I_{h}\left(g\left(S_{h, \tau}\right)\right)-g\left(S_{h, \tau}\right)\right\|_{L^{2}(\Omega \times] 0, T[)}^{2} \leq \sum_{n=1}^{N} \tau \sum_{K \in \mathcal{T}_{h}}|K|\left|g\left(S^{n, \ell}\right)-g\left(S^{n, r}\right)\right|^{2} \tag{6.3}
\end{equation*}
$$

For any node $i$, let

$$
\kappa_{i}=\operatorname{Max}|K|,
$$

where the maximum is taken over all elements $K$ in $\Delta_{i}$. Then we can readily check that

$$
\sum_{n=1}^{N} \tau \sum_{K \in \mathcal{T}_{h}}|K|\left|g\left(S^{n, \ell}\right)-g\left(S^{n, r}\right)\right|^{2} \leq C \sum_{n=1}^{N} \tau \sum_{i=1}^{M} \kappa_{i} \sum_{j \in \mathcal{N}(i)}\left|g\left(S^{n, j}\right)-g\left(S^{n, i}\right)\right|^{2}
$$

where $C$ is a bound for the maximum number of elements that share a common edge, bound independent of $h$ and $\tau$ by virtue of the regularity of the mesh. Now, recall the classical formula in each $d$-simplex $K$,

$$
\begin{equation*}
\int_{K}\left|\nabla \phi_{i} \cdot \nabla \phi_{j}\right|=\frac{1}{d^{2}} \frac{\left|F_{i}\right|\left|F_{j}\right|}{|K|}\left|\boldsymbol{n}_{i} \cdot \boldsymbol{n}_{j}\right|, \tag{6.4}
\end{equation*}
$$

where $F_{i}$ is the face opposite to the vertex $\boldsymbol{a}_{i}$ and $\boldsymbol{n}_{i}$ is the exterior (to $K$ ) unit normal to the face $F_{i}$. The regularity of the mesh implies that there exists a constant $c_{0}$, independent of $h$ and $\tau$, such that

Hence, using again the regularity of the mesh, we obtain

and denoting by $\rho_{i j}$ the minimum of $h_{K}$ for all $K$ in $\Delta_{i} \cap \Delta_{j}$, we deduce

\end{equation*}
$$

with another constant $C$ independent of $h$ and $\tau$. By collecting these results, we derive

\left\|I_{h}\left(g\left(S_{h, \tau}\right)\right)-g\left(S_{h, \tau}\right)\right\|_{L^{2}(\Omega \times] 0, T[)}^{2} \leq C \sum_{n=1}^{N} \tau \sum_{i=1}^{M} \kappa_{i} \sum_{j \in \mathcal{N}(i)}\left(\frac{1}{\rho_{i j}^{d-2}}\right) c_{i j}\left|g\left(S^{n, j}\right)-g\left(S^{n, i}\right)\right|^{2} \tag{6.6}
\end{equation*}
$$

With another application of the regularity of the mesh, this becomes

$$
\begin{equation*}
\left\|I_{h}\left(g\left(S_{h, \tau}\right)\right)-g\left(S_{h, \tau}\right)\right\|_{L^{2}(\Omega \times] 0, T[)}^{2} \leq C h^{2}\left\|\nabla\left(I_{h}\left(g\left(S_{h, \tau}\right)\right)\right)\right\|_{L^{2}(\Omega \times] 0, T[)}^{2} \tag{6.7}
\end{equation*}
$$

(note that the power of $h$ is independent of the dimension) and the limit (6.2) follows from Theorem 5.15.
6.1.2. Relation between $g\left(S^{n, j}\right)-g\left(S^{n, i}\right)$ and $S^{n, j}-S^{n, i}$. Here, we derive an upper bound for $S^{n, j}-S^{n, i}$ in terms of $g\left(S^{n, j}\right)-g\left(S^{n, i}\right)$.
Lemma 6.2. Under the assumptions (5.42) -(5.44) on the derivatives of the mobilities and capillary pressure, there exists a constant $C$, independent of $h$ and $\tau$, such that for all $i$, j, and $n$

\end{equation*}

where $r=\max \left(\theta_{\mathrm{o}}+\beta_{4}, \theta_{\mathrm{w}}+\beta_{3}\right)>1$.
Proof. To simplify, we set $c=S^{n, i}, d=S^{n, j}$ and assume $c<d$. From (5.51), it follows that

For the sake of brevity, we do not specify the constant factor in (6.9) and write

Now, we argue according to the positions of $c$ and $d$. There are four cases.

1) If $\frac{1}{8} \leq c \leq \frac{7}{8}$, then (6.9) gives

& =C_{1}\left(\frac{1}{8}\right)^{\theta_{w}+\beta_{3}-1} \frac{1}{\theta_{o}+\beta_{4}}\left((1-c)^{\theta_{o}+\beta_{4}}-(1-d)^{\theta_{o}+\beta_{4}}\right) .
\end{aligned}
$$

But

$$
\begin{aligned}
(1-c)^{\theta_{o}+\beta_{4}}-(1-d)^{\theta_{o}+\beta_{4}} & =(1-c)^{\theta_{o}+\beta_{4}-1}(d-c)+(1-d)\left((1-c)^{\theta_{o}+\beta_{4}-1}-(1-d)^{\theta_{o}+\beta_{4}-1}\right) \\
& \geq(d-c)\left(\frac{1}{8}\right)^{\theta_{o}+\beta_{4}-1}
\end{aligned}
$$

Hence

$$
\begin{equation*}
g(d)-g(c) \geq \frac{C_{1}}{\theta_{o}+\beta_{4}}\left(\frac{1}{8}\right)^{\theta_{w}+\beta_{3}+\theta_{o}+\beta_{4}-2}(d-c) . \tag{6.10}
\end{equation*}
$$

2) If $c>\frac{7}{8}$, then $d>\frac{7}{8}$ and (6.9) gives

$$
g(d)-g(c) \geq C_{1}\left(\frac{7}{8}\right)^{\theta_{w}+\beta_{3}-1} \frac{1}{\theta_{o}+\beta_{4}}\left((1-c)^{\theta_{o}+\beta_{4}}-(1-d)^{\theta_{o}+\beta_{4}}\right) .
$$

Let us set $a=1-d, b=d-c \gamma=\theta_{o}+\beta_{4}-1>0$. We can also write

(1-c)^{\theta_{0}+\beta_{4}}-(1-d)^{\theta_{o}+\beta_{4}}=a^{\gamma+1}\left(\left(1+\frac{b}{a}\right)^{\gamma+1}-1\right)
$$

It is easy to check that the function

x \mapsto(1+x)^{\gamma+1}-1-x^{\gamma+1}
$$

vanishes at $x=0$ and is strictly monotonic increasing, hence is strictly positive for $x>0$. Hence

a^{\gamma+1}\left(\left(1+\frac{b}{a}\right)^{\gamma+1}-1\right)>a^{\gamma+1}\left(\frac{b}{a}\right)^{\gamma+1}=b^{\gamma+1} .
$$

Thus

(1-c)^{\theta_{0}+\beta_{4}}-(1-d)^{\theta_{o}+\beta_{4}} \geq(d-c)^{\theta_{o}+\beta_{4}}
$$

and

$$
\begin{equation*}
g(d)-g(c) \geq C_{1}\left(\frac{7}{8}\right)^{\theta_{w}+\beta_{3}-1} \frac{1}{\theta_{o}+\beta_{4}}(d-c)^{\theta_{o}+\beta_{4}} . \tag{6.11}
\end{equation*}
$$

3) If $c<\frac{1}{8}$ and $d<\frac{7}{8}$, then the integrand $1-x \geq 1-d>\frac{1}{8}$ and by the above argument,

$$
\begin{align*}
g(d)-g(c) & \geq C_{1}\left(\frac{1}{8}\right)^{\theta_{o}+\beta_{4}-1} \frac{1}{\theta_{w}+\beta_{3}}\left(d^{\theta_{w}+\beta_{3}}-c^{\theta_{w}+\beta_{3}}\right) \\
& \geq C_{1}\left(\frac{1}{8}\right)^{\theta_{o}+\beta_{4}-1} \frac{1}{\theta_{w}+\beta_{3}}(d-c)^{\theta_{w}+\beta_{3}} . \tag{6.12}
\end{align*}
$$

4) If $c<\frac{1}{8}$ and $d>\frac{7}{8}$, then $c<\frac{1}{6}(d-c)<\frac{1}{2}(d-c)<d$. Therefore, we can write

$$
\begin{align*}
g(d)-g(c) & \geq C_{1} \int_{\frac{1}{6}(d-c)}^{\frac{1}{2}(d-c)} x^{\theta_{w}+\beta_{3}-1}(1-x)^{\theta_{o}+\beta_{4}-1} \\
& \geq C_{1}\left(\frac{1}{2}\right)^{\theta_{o}+\beta_{4}-1} \frac{1}{\theta_{w}+\beta_{3}}\left(\left(\frac{1}{2}(d-c)\right)^{\theta_{w}+\beta_{3}}-\left(\frac{1}{6}(d-c)\right)^{\theta_{w}+\beta_{3}}\right)  \tag{6.13}\\
& \geq C_{1}\left(\frac{1}{2}\right)^{\theta_{o}+\theta_{w}+\beta_{3}+\beta_{4}-1} \frac{1}{\theta_{w}+\beta_{3}}\left(1-\left(\frac{1}{3}\right)^{\theta_{w}+\beta_{3}}\right)(d-c)^{\theta_{w}+\beta_{3}} .
\end{align*}
$$

Since $d-c \leq 1, \theta_{o}+\beta_{4}>1$, and $\theta_{w}+\beta_{3}>1$, we have in all cases

$$
g(d)-g(c) \geq C_{2}(d-c)^{\max \left(\theta_{o}+\beta_{4}, \theta_{w}+\beta_{3}\right)}
$$

where $C_{2}$ is the minimum of the constant factors in (6.10)-(6.13).
The convergence to zero of the differences $I_{h}\left(p_{\alpha g}\left(S_{h, \tau}\right)\right)-p_{\alpha g}\left(S_{h, \tau}\right), \alpha=w, o$, follows from this lemma and Theorem 5.15.
Lemma 6.3. Under the assumptions (5.42) -(5.44) on the derivatives of the mobilities and capillary pressure, there exists a constant $C$, independent of $h$ and $\tau$, such that

$$
\begin{equation*}
\left\|I_{h}\left(p_{\alpha g}\left(S_{h, \tau}\right)\right)-p_{\alpha g}\left(S_{h, \tau}\right)\right\|_{\left.L^{2}(\Omega \times] 0, T\right]} \leq C h^{\gamma_{\alpha}}, \alpha=w, o, \tag{6.14}
\end{equation*}
$$

where $\gamma_{w}=\frac{\beta_{3}}{r}, \gamma_{o}=\frac{\beta_{4}}{r}$ and in both cases, $r$ is the exponent of Lemma 6.2.
Proof. Let us start with $\alpha=w$. Arguing as in the proof of Lemma 6.1, with $-p_{w g}$ (monotonic increasing) instead of $g$, the analogue of (6.6) holds for $-p_{w g}\left(S_{h, \tau}\right)$, with the same notation

\left\|I_{h}\left(p_{w g}\left(S_{h, \tau}\right)\right)-p_{w g}\left(S_{h, \tau}\right)\right\|_{\left.\left.L^{2}(\Omega \times] 0, T\right]\right)}^{2} \leq C \sum_{n=1}^{N} \tau \sum_{i=1}^{M} \sum_{j \in \mathcal{N}(i)}\left(\frac{\kappa_{i}}{c_{i j}}\right) c_{i j}\left|p_{w g}\left(S^{n, j}\right)-p_{w g}\left(S^{n, i}\right)\right|^{2} \tag{6.15}
\end{equation*}
$$

and the result will stem from an adequate upper bound for $p_{w g}\left(S^{n, j}\right)-p_{w g}\left(S^{n, i}\right)$, for all neighbors $j$ of $i$. To this end, we proceed as in Lemma 6.2. Let $c=S^{n, i}, d=S^{n, j}$ and suppose again that $c<d$; then by (1.12), (5.44), (5.46), and (5.47),

\end{equation*}
$$

that we write as

$$
\left|p_{w g}\left(S^{n, j}\right)-p_{w g}\left(S^{n, i}\right)\right| \leq C_{1}^{\prime} \int_{c}^{d} x^{\beta_{3}-1}(1-x)^{\theta_{o}+\beta_{4}-1}
$$

Here, the discussion reduces to three cases.

1) If $\frac{1}{8} \leq c \leq \frac{7}{8}$, since $\theta_{o}+\beta_{4}-1>0$,

$$
\begin{equation*}
\int_{c}^{d} x^{\beta_{3}-1}(1-x)^{\theta_{o}+\beta_{4}-1} \leq 8^{1-\beta_{3}} \int_{c}^{d}(1-x)^{\theta_{o}+\beta_{4}-1} \leq 8^{1-\beta_{3}}(d-c) \tag{6.17}
\end{equation*}
$$

2) Likewise, if $c>\frac{7}{8}$,

$$
\begin{equation*}
\int_{c}^{d} x^{\beta_{3}-1}(1-x)^{\theta_{o}+\beta_{4}-1} \leq\left(\frac{8}{7}\right)^{1-\beta_{3}}(d-c) \tag{6.18}
\end{equation*}
$$

3) If $c<\frac{1}{8}$,

$$
\begin{equation*}
\int_{c}^{d} x^{\beta_{3}-1}(1-x)^{\theta_{o}+\beta_{4}-1} \leq \int_{c}^{d} x^{\beta_{3}-1}=\frac{1}{\beta_{3}}\left(d^{\beta_{3}}-c^{\beta_{3}}\right) \leq \frac{1}{\beta_{3}}(d-c)^{\beta_{3}} \tag{6.19}
\end{equation*}
$$

Indeed, by Jensen's inequality, valid for $0<\beta_{3} \leq 1$,

$$
d=c+(d-c) \leq\left(c^{\beta_{3}}+(d-c)^{\beta_{3}}\right)^{\frac{1}{\beta_{3}}}, \quad \text { i.e., } d^{\beta_{3}} \leq c^{\beta_{3}}+(d-c)^{\beta_{3}}
$$

Consequently, in all cases,

\begin{equation*}
\left|p_{w g}\left(S^{n, j}\right)-p_{w g}\left(S^{n, i}\right)\right| \leq C_{2}^{\prime}\left|S^{n, j}-S^{n, i}\right|^{\beta_{3}} \tag{6.20}
\end{equation*}
$$

Thus, by substituting into (6.15), applying Lemma 6.2, and setting $\gamma_{w}=\frac{\beta_{3}}{r}$, we infer

\begin{aligned}
\left\|I_{h}\left(p_{w g}\left(S_{h, \tau}\right)\right)-p_{w g}\left(S_{h, \tau}\right)\right\|_{\left.L^{2}(\Omega \times] 0, T\right]}^{2} & \leq C \sum_{n=1}^{N} \sum_{i=1}^{M} \sum_{j \in \mathcal{N}(i)} \frac{\kappa_{i}}{c_{i j}} \tau c_{i j}\left|S^{n, j}-S^{n, i}\right|^{2 \beta_{3}} \\
& \leq C \sum_{n=1}^{N} \sum_{i=1}^{M} \sum_{j \in \mathcal{N}(i)} \frac{\kappa_{i}}{c_{i j}} \tau c_{i j} A_{i j}^{2 \gamma_{w}}
\end{aligned}
$$

where $A_{i j}=\left|g\left(S^{n, j}\right)-g\left(S^{n, i}\right)\right|$. Note that $r>\beta_{3}$, hence $\gamma_{w}<1$. Then

$$
\begin{array}{r}
\left\|I_{h}\left(p_{w g}\left(S_{h, \tau}\right)\right)-p_{w g}\left(S_{h, \tau}\right)\right\|_{\left.L^{2}(\Omega \times] 0, T\right)}^{2} \leq C \sum_{n=1}^{N} \sum_{i=1}^{M} \sum_{j \in \mathcal{N}(i)} \frac{\kappa_{i}}{c_{i j}}\left(\tau c_{i j}\right)^{1-\gamma_{w}}\left(\tau c_{i j}\right)^{\gamma_{w}} A_{i j}^{2 \gamma_{w}} \\
\leq C\left(\sum_{n=1}^{N} \sum_{i=1}^{M} \sum_{j \in \mathcal{N}(i)} \tau c_{i j} A_{i j}^{2}\right)^{\gamma_{w}}\left(\sum_{n=1}^{N} \sum_{i=1}^{M} \sum_{j \in \mathcal{N}(i)}\left(\frac{\kappa_{i}}{c_{i j}}\right)^{\frac{1}{1-\gamma_{w}}} \tau c_{i j}\right)^{1-\gamma_{w}} .
\end{array}
$$

But

$$
\left(\sum_{n=1}^{N} \sum_{i=1}^{M} \sum_{j \in \mathcal{N}(i)}\left(\frac{\kappa_{i}}{c_{i j}}\right)^{\frac{1}{1-\gamma_{w}}} \tau c_{i j}\right)^{1-\gamma_{w}} \leq C(T|\Omega|)^{1-\gamma_{w}} \sup _{i, j}\left(\frac{\kappa_{i}}{c_{i j}}\right)^{\gamma_{w}},
$$

and (6.14) with $\alpha=w$ follows from (6.5), the regularity of the mesh, and Theorem 5.15.
When $\alpha=o$, the proof is based on fact that $-p_{o g}$ is nonnegative, monotonically increasing, and satisfies the inequality

-p_{o g}(x) \leq \frac{1}{C_{\min }} \frac{1}{\alpha_{3} \alpha_{w} \theta_{w}} \int_{0}^{x} x^{\theta_{w}+\beta_{3}-1}(1-x)^{\beta_{4}-1}

By comparing with (6.16), we see that the above argument carries over to $p_{o g}$ with $\beta_{3}$ replaced by $\beta_{4}$.
Finally, with the notation of Lemma 6.3, the following bound regarding $p_{c}\left(S_{h, \tau}\right)$ follows from (6.14) and (1.14), and the fact that $p_{c}(0)$ is a constant:

where $\gamma=\frac{1}{r} \min \left(\beta_{3}, \beta_{4}\right)$.
6.2. Weak convergence. All constants below are independent of $h$ and $\tau$.

The bound (3.1) on the discrete saturation $S_{h, \tau}$ implies that there exists a function $\bar{s} \in$ $L^{\infty}(\Omega \times] 0, T[)$ and a subsequence of $(h, \tau)$ not indicated, such that

\lim _{(h, \tau) \rightarrow(0,0)} S_{h, \tau}=\bar{s} \quad \text { weakly* in } L^{\infty}(\Omega \times] 0, T[) \tag{6.22}
\end{equation*}

Proposition 6.4. The limit function $\bar{s}$ satisfies

\forall(x, t) \text { a.e. in } \Omega \times] 0, T[, \quad 0 \leq \bar{s}(x, t) \leq 1 \tag{6.23}
\end{equation*}
$$

Proof. The convergence (6.22) means that for all $\psi \in L^{1}(\Omega \times] 0, T[)$,

\int_{\Omega \times] 0, T[ } S_{h, \tau} \psi \rightarrow \int_{\Omega \times] 0, T[ } \bar{s} \psi \text { and } \int_{\Omega \times] 0, T[ }\left(1-S_{h, \tau}\right) \psi \rightarrow \int_{\Omega \times] 0, T[ }(1-\bar{s}) \psi
$$

We argue by contradiction. Suppose that $\bar{s}>1$ on a set of positive measure, say $D$, and take $\psi=(\bar{s}-1)_{+}$, the positive part of $\bar{s}-1$. Then

thus contradicting the fact that $(1-\bar{s})<0$ on $D$. This proves that $\bar{s} \leq 1$. The proof that $\bar{s} \geq 0$ is similar.

Regarding the pressure, the bound (3.23) yields weak convergence, up to a subsequence, of the gradient of $U_{\alpha, h, \tau}$. We can deduce weak convergence of the sequences themselves by applying (3.22). Indeed,

owing to (2.45). Then the properties of $p_{w g}$ and the boundedness of $S_{h, \tau}$ imply that

This implies in particular that for almost every time $t, I_{h}\left(g\left(S_{h, \tau}\right)\right)$ converges strongly in $L^{2}(\Omega)$. But as is well-known, these convergences are not sufficient to pass to the limit in the nonlinear terms: they must be supplemented by a bound for a fractional derivative in time of $S_{h, \tau}$ that yields compactness in time. This will stem via a bound for a fractional derivative in time of $g\left(S_{h, \tau}\right)$.
6.3. Compactness in time. Following the argument introduced by Kazhikhov, see [22], and recalling that $\|\cdot\|_{h}^{\varphi}$ is equivalent to the $L^{2}$ norm in finite dimension, we want to derive first a fractional estimate in time for $I_{h}\left(g\left(S_{h, \tau}\right)\right)$ and next for $g\left(S_{h, \tau}\right)$. The following lemma is a preliminary bound written in terms of sums of the pointwise values in time.
Lemma 6.5. Under the assumptions of Theorem5.15, there exist constants $C$, independent of $h$ and $\tau$, such that for all integers $1 \leq \ell \leq N-1$,

Thus, again up to a subsequence, $I_{h}\left(g\left(S_{h, \tau}\right)\right)$ converges strongly in $L^{2}(\Omega \times] 0, T[)$. Since it converges weakly to $\bar{K}$ in $L^{2}\left(0, T ; H^{1}(\Omega)\right)\left(\bar{K}\right.$ belongs also to $L^{\infty}(\Omega \times] 0, T[)$ ), uniqueness of the limit implies

Furthermore, uniqueness of the limit implies that $\bar{W}_{\alpha}$, the limit function of $U_{\alpha, h, \tau}$ has the form

7. Identification of the limit. Let us pass to the limit in the equations of the scheme. This is done in several steps because we do not have convergence of the pressure gradient.
7.1. The upwind diffusions. Since the discrete auxiliary pressures $U_{\alpha, h, \tau}$ converge weakly to $\bar{W}_{\alpha}$ in $L^{2}\left(0, T ; H^{1}(\Omega)\right)$, instead of treating directly the upwind diffusion terms $\left[P_{\alpha, h, \tau}, I_{h}\left(\eta_{\alpha}\left(S_{h, \tau}\right)\right) ; P_{\alpha, h, \tau}, \theta_{h}\right]_{h}$, we begin with $\left[P_{\alpha, h, \tau}, I_{h}\left(\eta_{\alpha}\left(S_{h, \tau}\right)\right) ; U_{\alpha, h, \tau}, \theta_{h}\right]_{h}$.
7.1.1. Discrete auxiliary pressure. Let us start with the wetting phase, the treatment of the non-wetting phase being much the same.
Let $v$ be a smooth function, say $v \in \mathcal{C}^{1}(\bar{\Omega} \times[0, T])$ and let $V_{h, \tau}=\rho_{\tau}\left(I_{h}(v)\right)$. Assume for the moment that $\bar{s}$, the limit of $S_{h, \tau}$, is sufficiently smooth, say $\bar{s} \in W^{1, \infty}(\Omega \times] 0, T[)$ and let $\bar{s}_{\tau}=\bar{s}\left(t_{n}\right)$ in $\left.] t_{n-1}, t_{n}\right]$. Then assumption (5.42) implies

\end{aligned}
$$

and the boundedness of all factors of $\tau$, owing to (3.23) and the regularity of $v$, implies

& \leq C h\left\|\eta_{w}^{\prime}\right\|_{L^{\infty}(0,1)}\|\nabla \bar{s}\|_{\left.L^{\infty}(\Omega \times] 0, T\right]} \mid\left\|\nabla U_{w, h, \tau}\right\|_{\left.L^{2}(\Omega \times] 0, T\right]}\left\|\nabla V_{h, \tau}\right\|_{L^{2}(\Omega \times] 0, T[)} \\
& \leq C h\left\|\eta_{w}^{\prime}\right\|_{L^{\infty}(0,1)}\|\nabla \bar{s}\|_{\left.\left.L^{\infty}(\Omega \times] 0, T\right]\right)}|v|_{H^{1}\left(0, T ; H^{2}(\Omega)\right)}
\end{aligned}

& =C\|\nabla v\|_{\left.\left.L^{\infty}(\Omega \times] 0, T\right]\right)}\left\|\nabla U_{w, h, \tau}\right\|_{\left.\left.L^{2}(\Omega \times] 0, T\right]\right)}\left\|I_{h}\left(\bar{s}_{\tau}\right)-S_{h, \tau}\right\|_{L^{2}(\Omega \times] 0, T[)}
\end{aligned}

& +\int_{0}^{T} \int_{\Omega} f_{\alpha}\left(\rho_{\tau}\left(\rho_{K}\left(s_{\text {in }}\right)\right)\right) \rho_{\tau}\left(\rho_{K}(\bar{q})\right) V_{h, \tau}=X_{1}+X_{2}+X_{3}
\end{aligned}
$$

since the last summand is a polynomial of degree one. We have

$$
\lim _{(h, \tau) \rightarrow(0,0)} X_{3}=\int_{0}^{T} \int_{\Omega} f_{o}\left(s_{\text {in }}\right) \bar{q} v
$$

It remains to show that $X_{1}$ and $X_{2}$ tend to zero. For $X_{1}$, since $f_{o}$ and $f_{w}$ have the same derivative (up to the sign), we deduce from (5.52), (5.42), (5.43), (5.45), (5.46), and (5.47) that $f_{\alpha}^{\prime}$ is bounded in $[0,1]$; hence

$$
\left|f_{\alpha}\left(s_{\mathrm{in}, \mathrm{~h}, \tau}^{n, \ell_{i}}\right)-f_{\alpha}\left(\rho_{\tau}\left(\rho_{K}\left(s_{\mathrm{in}}\right)\right)\right)\right| \leq C\left|s_{\mathrm{in}, \mathrm{~h}, \tau}^{n, \ell_{i}}-\rho_{\tau}\left(\rho_{K}\left(s_{\mathrm{in}}\right)\right)\right| .
$$

Thus, the summand is bounded by polynomials and the equivalence of norms yields

$$
\left|X_{1}\right| \leq C\|v\|_{\left.\left.L^{\infty}(\Omega \times] 0, T\right]\right)}\left\|s_{\mathrm{in}, \mathrm{~h}, \tau}-\rho_{\tau}\left(\rho_{K}\left(s_{\mathrm{in}}\right)\right)\right\|_{\left.\left.L^{2}(\Omega \times] 0, T\right]\right)}\left\|\bar{q}_{h, \tau}\right\|_{\left.L^{2}(\Omega \times] 0, T\right]},
$$

that tends to zero with $(h, \tau)$. It is easy to check that the same holds for $X_{2}$. Hence

$$
\begin{equation*}
\lim _{(h, \tau) \rightarrow(0,0)} \int_{0}^{T}\left(I_{h}\left(f_{\alpha}\left(s_{\text {in }, h, \tau}\right)\right) \bar{q}_{h, \tau}, V_{h, \tau}\right)_{h}=\int_{0}^{T} \int_{\Omega} f_{\alpha}\left(s_{\text {in }}\right) \bar{q} v . \tag{7.55}
\end{equation*}
$$

The argument for the second term in the right-hand side of (2.42) is much the same; we insert $\rho_{\tau}\left(\rho_{K}(\bar{s})\right)$ and we use the fact that

$$
\lim _{(h, \tau) \rightarrow(0,0)}\left\|S_{h, \tau}-\rho_{\tau}\left(\rho_{K}(\bar{s})\right)\right\|_{L^{2}(\Omega \times] 0, T[)}=0 .
$$

Then the argument used for the first term readily gives

$$
\begin{equation*}
\lim _{(h, \tau) \rightarrow(0,0)} \int_{0}^{T}\left(I_{h}\left(f_{\alpha}\left(S_{h, \tau}\right)\right) \underline{q}_{h_{\tau}}, V_{h, \tau}\right)_{h}=\int_{0}^{T} \int_{\Omega} f_{\alpha}(\bar{s}) \bar{q} v \tag{7.56}
\end{equation*}
$$

By combining (7.55) and (7.56), we obtain convergence of the right-hand sides,

$$
\begin{equation*}
\lim _{(h, \tau) \rightarrow(0,0)}\left(\int_{0}^{T}\left(I_{h}\left(f_{\alpha}\left(s_{\mathrm{in}, h, \tau}\right)\right) \bar{q}_{h, \tau}-I_{h}\left(f_{\alpha}\left(S_{h, \tau}\right)\right) \underline{q}_{h_{\tau}}, V_{h, \tau}\right)_{h}=\int_{0}^{T} \int_{\Omega}\left(f_{\alpha}\left(s_{\mathrm{in}}\right) \bar{q}-f_{\alpha}(\bar{s}) \bar{q}\right) v\right. \tag{7.57}
\end{equation*}
$$

7.3. The full scheme. It remains to pass to the limit in the time derivative, say in (2.42), summed over $n$, and tested with the same $V_{h, \tau}$ as previously, except that here we take $v(T)=0$. After summation by parts, this term reads

$$
\begin{equation*}
\sum_{n=1}^{N}\left(S_{h}^{n}-S_{h}^{n-1}, V_{h}^{n}\right)_{h}^{\varphi}=-\sum_{n=1}^{N-1}\left(V_{h}^{n+1}-V_{h}^{n}, S_{h}^{n}\right)_{h}^{\varphi}-\left(V_{h}^{1}, S_{h}^{0}\right)_{h}^{\varphi} \tag{7.58}
\end{equation*}
$$

By definition,

$$
\left(V_{h}^{n+1}-V_{h}^{n}, S_{h}^{n}\right)_{h}^{\varphi}=\left.\sum_{K \in \bar{\Omega}} \frac{|K|}{d+1} \varphi\right|_{K} \sum_{\ell=1}^{d+1}\left(V^{n+1, i_{\ell}}-V^{n, i_{\ell}}\right) S^{n, i_{\ell}} .
$$

By inserting $\rho_{K}\left(V^{n+1, i_{\ell}}-V^{n, i_{\ell}}\right)$ in each element, this becomes

$$
\left(V_{h}^{n+1}-V_{h}^{n}, S_{h}^{n}\right)_{h}^{\varphi}=\left(V_{h}^{n+1}-V_{h}^{n}-\rho_{h}\left(V^{n+1}-V^{n}\right), S_{h}^{n}\right)_{h}^{\varphi}+\int_{\Omega} \varphi \rho_{h}\left(V^{n+1}-V^{n}\right) S_{h}^{n}
$$

The first term has the bound

$$
\left|\left(V_{h}^{n+1}-V_{h}^{n}-\rho_{h}\left(V^{n+1}-V^{n}\right), S_{h}^{n}\right)_{h}^{\varphi}\right| \leq\|\varphi\|_{L^{\infty}(\Omega)}\left\|V_{h}^{n+1}-V_{h}^{n}-\rho_{h}\left(V^{n+1}-V^{n}\right)\right\|_{h}\left\|S_{h}^{n}\right\|_{h}
$$

Since the functions are piecewise polynomials, the equivalence of norms yields

$$
\begin{aligned}
& \left|\sum_{n=1}^{N-1}\left(V_{h}^{n+1}-V_{h}^{n}-\rho_{h}\left(V^{n+1}-V^{n}\right), S_{h}^{n}\right)_{h}^{\varphi}\right| \leq C\|\varphi\|_{L^{\infty}(\Omega)} \\
& \quad \times\left(\sum_{n=1}^{N-1} \tau\left\|\frac{1}{\tau}\left(I_{h}\left(v^{n+1}-v^{n}\right)-\rho_{h}\left(V^{n+1}-V^{n}\right)\right)\right\|_{L^{2}(\Omega)}^{2}\right)^{\frac{1}{2}}\left(\sum_{n=1}^{N-1} \tau\left\|S_{h}^{n}\right\|_{L^{2}(\Omega)}^{2}\right)^{\frac{1}{2}}
\end{aligned}
$$

Then the regularity of $v$, the approximation properties of $I_{h}$ and $\rho_{h}$ and the boundedness of $S_{h, \tau}$ imply that

$$
\lim _{(h, \tau) \rightarrow(0,0)}\left|\sum_{n=1}^{N-1}\left(V_{h}^{n+1}-V_{h}^{n}-\rho_{h}\left(V^{n+1}-V^{n}\right), S_{h}^{n}\right)_{h}^{\varphi}\right|=0 .
$$

Similarly, it is easy to check from the convergence of $S_{h, \tau}$ that

$$
-\lim _{(h, \tau) \rightarrow(0,0)} \sum_{n=1}^{N-1} \int_{\Omega} \varphi \rho_{h}\left(V^{n+1}-V^{n}\right) S_{h}^{n}=-\int_{0}^{T} \int_{\Omega} \varphi\left(\partial_{t} v\right) \bar{s}
$$

The treatment of the initial term is the same. Hence

$$
\begin{equation*}
\lim _{(h, \tau) \rightarrow(0,0)} \sum_{n=1}^{N}\left(S_{h}^{n}-S_{h}^{n-1}, V_{h}^{n}\right)_{h}^{\varphi}=-\int_{0}^{T} \int_{\Omega} \varphi\left(\partial_{t} v\right) \bar{s}-\int_{\Omega} \varphi s^{0} v \tag{7.59}
\end{equation*}
$$

By combining (7.59), with (7.9) and (7.57), we readily see that the limit functions $\bar{s}, \bar{p}_{\alpha}$ and $p_{\alpha g}(\bar{s})$ satisfy the weak formulation (1.16). This proves Theorem 2.6.
8. Numerical validation. This section proposes a numerical validation of our algorithm with a two dimensional finite difference code. Details on the algorithm implemented are given. A problem with manufactured solutions is then considered to study the convergence properties of our algorithm.
8.1. Implementation of the model. To avoid dealing with nonlinear terms, we implement a modified version of the algorithm proposed in section 2.3. The main difference
consists of approximating the terms $S_{w}^{n+1, i j}, S_{o}^{n+1, i j}$ and $P_{o}^{n+1}$ with first time order extrapolation. For each node $1 \leq i \leq M$, the unknowns ( $S^{n+1, i}, P_{w}^{n+1, i}$ ) are computed as the solution of the following problem:

$$
\begin{array}{r}
\frac{\tilde{m}_{i}}{\Delta t}\left(S^{n+1, i}-S^{n, i}\right)-\sum_{j \neq i, j \in N(i)} c_{i j} \eta_{w}\left(S_{w}^{*, n+1, i j}\right)\left(P_{w}^{n+1, j}-P_{w}^{n+1, i}\right) \\
=m_{i} f_{1}^{n+1, i}, \quad 1 \leq i \leq M \\
-\frac{\tilde{m}_{i}}{\Delta t}\left(S^{n+1, i}-S^{n, i}\right)-\sum_{j \neq i, j \in N(i)} c_{i j} \eta_{o}\left(S_{o}^{*, n+1, i j}\right)\left(P_{w}^{n+1, j}-P_{w}^{n+1, i}\right) \\
-\sum_{j \neq i, j \in N(i)} c_{i j} \eta_{o}\left(S_{o}^{*, n+1, i j}\right)\left(p_{c}^{*, n+1, j}-p_{c}^{*, n+1, i}\right)=m_{i} f_{2}^{n+1, i}, \quad 1 \leq i \leq M, \tag{8.2}
\end{array}
$$

where the pressure $P_{o}$ has been substituted with $P_{w}+p_{c}$ with respect to (2.34). The solution $P_{w}$ is enforced to satisfy (2.35) a posteriori by subtracting its integral $\sum_{i=1}^{M} m_{i} P_{w}^{i}$ after solving the above problem. The terms $S_{w}^{*, n+1, i j}$ and $S_{o}^{*, n+1, i j}$ are approximated at time iteration n by setting them to $S_{w}^{n, i j}$ and $S_{o}^{n, i j}$. Eventually, the capillary pressure $p_{c}^{*, n+1}$ is approximated with a first order Taylor expansion with respect to the saturation $S$, it reads:

$$
\begin{equation*}
p_{c}^{*, n+1}=p_{c}^{n}+\left(\frac{\partial p_{c}}{\partial S}\right)^{n}\left(S^{n+1}-S^{n}\right) \tag{8.3}
\end{equation*}
$$

We note that to facilitate the implementation of this algorithm in a two dimensional finite difference code, the source terms of the equations (2.32)-(2.33) have been replaced by functions denoted by $f_{1}$ and $f_{2}$.
8.2. Numerical test with a manufactured solution. The numerical validation of the algorithm is done by approximating the analytical solutions defined by

$$
\begin{gather*}
P_{w}(t, x, y)=2+x^{2} y-y^{2}+x^{2} \sin (t+y)  \tag{8.4}\\
S(t, x, y)=0.2(2+2 x y+\cos (t+x)) \tag{8.5}
\end{gather*}
$$

on the computational domain $\Omega=[0,1]^{2}$. Dirichlet boundary conditions are applied on $\partial \Omega$ on both unknowns $P_{w}$ and $S$. The initial conditions of the problem satisfy (8.4)-(8.5). The porosity of the domain is set to:

$$
\begin{equation*}
\phi(t, x, y)=0.2(1+x y) \tag{8.6}
\end{equation*}
$$

The mobilities $\eta_{w}$ and $\eta_{o}$, introduced in section 1.1, are defined as follows:

$$
\begin{equation*}
\eta_{w}=4 S^{2}, \quad \eta_{o}=0.4(1-S)^{2} . \tag{8.7}
\end{equation*}
$$

The capillary pressure is based on the Brooks-Corey model, it reads:

$$
P_{c}= \begin{cases}A S^{-0.5} & \text { if } S>0.05  \tag{8.8}\\ A(1.5-10 S) \times 0.05^{-0.5} & \text { otherwise } \\ 67 & \end{cases}
$$

where $A$ is a constant set to 50 . The term sources $f_{1}$ and $f_{2}$ are computed accordingly. The convergence tests are performed on a set of six uniform grids with respective mesh size $h \in$ $\{0.2,0.1,0.05,0.025,0.0125,0.00625\}$. The convergence properties are evaluated by using a time step $\tau$ set to the mesh size $h$ with a final time $T=1$. As the time derivatives and the saturations $S_{w}^{n+1, i j}, S_{o}^{n+1, i j}$ are computed with first order time approximation, we expect the convergence rate in the $L^{2}$ norm to be of order one. The results of the convergence

tests are presented in Table 8.1. The theoretical order of convergence, equal to one, is recovered for both unknowns which confirms the correct behavior of the algorithm.
9. Conclusions. This paper formulates a $\mathbb{P}_{1}$ finite element method to solve the immiscible two-phase flow problem in porous media. The unknowns are the phase pressure and saturation, which are the preferred unknowns in industrial reservoir simulators. The numerical method employs mass lumping for integration and an upwind flux technique. As a consequence, the saturation is shown to be bounded between zero and one. The discrete approximations of pressure and saturation converge to the weak solution as the time step and mesh sizes tend to zero.
