# ON SHARP FRONTS AND ALMOST-SHARP FRONTS FOR SINGULAR SQG

#### Abstract

In this paper we consider a family of active scalars with a velocity field given by $u=\Lambda^{-1+\alpha} \nabla^{\perp} \theta$, for $\alpha \in(0,1)$. This family of equations is a more singular version of the two-dimensional Surface QuasiGeostrophic (SQG) equation, which would correspond to $\alpha=0$.

We consider the evolution of sharp fronts by studying families of almost-sharp fronts. These are smooth solutions with simple geometry in which a sharp transition in the solution occurs in a tubular neighbourhood (of size $\delta$ ). We study their evolution and that of compatible curves, and introduce the notion of a spine for which we obtain improved evolution results, gaining a full power (of $\delta$ ) compared to other compatible curves.


## 1. Introduction

In this paper, we develop and study the notions of sharp front, almost-sharp front, and spine curve for the following more singular

[^0]version of the two-dimensional SQG equation,
\[

We will focus in the range $\alpha \in(0,1)$. Here $\theta=\theta(x, t) \in \mathbb{R}, x \in \mathbb{R}^{2}$, and $t \geq 0$ and the operator $\Lambda=|\nabla|$ is the half Laplacian on $\mathbb{R}^{2}$. To simplify the presentation we will define $\Lambda^{-1+\alpha}$ as given by a convolution with the kernel $K(x)=|x|^{-1-\alpha} \in L_{\text {loc }}^{2}\left(\mathbb{R}^{2}\right)$,

$$
\Lambda^{-1+\alpha} f(x)=K * f(x)=\int_{\mathbb{R}^{2}} \frac{f(y)}{|x-y|^{1+\alpha}} \mathrm{d} y
$$

In $\mathbb{R}^{2}$, usually one has $\Lambda^{-\beta} f=c_{\beta}|x|^{\beta-2} * f$ but we ignore $c_{\beta}$ here. For $\alpha \in[-1,0]$, the family interpolates between the 2 D Euler equation $(\alpha=$ $-1)$ and the 2D SQG equation $(\alpha=0)$. The model with $\alpha \in(0,1)$ is the natural extrapolation of this family and the focus of this paper.

Sharp fronts are weak solutions of (1.1) that have the special form

$$
\theta(x, t)=\mathbf{1}_{x \in A(t)},
$$

where $A$ is a bounded simply connected domain with sufficiently regular boundary (say $C^{2}$ ), and $\mathbf{1}_{U}$ is the indicator function of the set $U$.

Periodic graph-type SQG sharp fronts have been considered in [13] and [6] by periodising one of the space variables. For SQG, sharp fronts have already been studied in the Sobolev setting in [9] and [2] (see Chae et. al. [1] as well).

Non-periodic graph-type sharp fronts of (1.1) were studied in the recent papers, and of Hunter, Shu, and Zhang. They gave two different approaches in [17] and [19] to deriving the correct contour dynamics equation in this setting, and proved [16] global existence under a certain smallness condition. They also study two-front dynamics [15] and approximate equations for sharp fronts [18]; these differ from the almost-sharp fronts considered in this paper, which are smooth functions solving (1.1) exactly, approximating a sharp front.

Finally, a second paper [20] by the authors has been prepared alongside this one that proves local existence of sharp fronts of (1.1) a bounded domain in the analytic setting. This is an analogous result to the existence theorem for SQG in [6].

Analogously to [7] and [8], we define an almost-sharp front (ASF) of size $\delta$ as a regular ${ }^{1}$ approximation of a sharp front:

\theta(x, t)= \begin{cases}1 & x \in A_{\text {in }}(t) \\ \text { regular } & x \in A_{\text {mid }}(t) \\ 0 & x \in \mathbb{R}^{2} \backslash\left(A_{\text {in }}(t) \cup A_{\text {mid }}(t)\right)\end{cases}
$$

where supp $\nabla \theta \subset A_{\text {mid }}$ and this 'transition region' has area $O(\delta)$, so that in the limit as $\delta \rightarrow 0$, one formally recovers a sharp front.

In the Appendix, we derive asymptotics for integrals appearing in the equation, which we use to write down an approximate equation for an almost-sharp front. In doing so, we discover a significant difference with [7], which corresponds to $\alpha=0$ : the appearance of a logarithm in the equation of [7] and the property $\log (a b)=\log b+\log b$ led to the development of an 'approximate unwinding' for their equation in [8]. However, in our case, the singularity is stronger and we have $|a b|^{-\alpha} \neq|a|^{-\alpha}+|b|^{-\alpha}$, so we have a nonlinear term that explodes as $\delta \rightarrow 0$. Regardless, the analogous function to the $h$ function of [7] does satisfy a well behaved linear homogeneous equation in the limit as $\delta \rightarrow 0$.

The remainder of this paper is organised as follows. In Section 2, we set up some notation. Section 3 discusses sharp fronts, with almostsharp fronts introduced in Section 4. The regularisation effect for $\Omega$ that leads to a limit equation for $h$ is discussed in Section 5. Finally, Section 6 discusses the notion of compatible curves for almost-sharp fronts, and Section 7 introduces the notion of a spine, and establishes an improved evolution result.

## 2. Notation

Let $\mathbb{T}:=\mathbb{R} / \mathbb{Z}$, with fundamental domain $[-1 / 2,1 / 2)$. The $90^{\circ}$ counter-clockwise rotation of $x=\binom{a}{b} \in \mathbb{R}^{2}$ is $x^{\perp}:=\binom{-b}{a}$, and similarly $\nabla^{\perp}=\binom{-\partial_{x^{2}}}{\partial_{x^{1}}}$. We will frequently employ the shorthand notation

$$

\int_{A} F\left(g, f_{*}\right) \mathrm{d} s_{*} & :=\int_{A} F\left(g(s), f\left(s_{*}\right)\right) \mathrm{d} s_{*}, \\
\int_{A} \int_{B} F\left(g, f_{*}\right) \mathrm{d} s_{*} \mathrm{~d} \xi_{*} & :=\int_{A} \int_{B} F\left(g(s, \xi), f\left(s_{*}, \xi_{*}\right)\right) \mathrm{d} s_{*} \mathrm{~d} \xi_{*}

That is, evaluation at $s, \xi$ is assumed unless a function is subscripted by $*$, and then we will assume it is evaluated at $s_{*}, \xi_{*}$.

## 3. Evolution equation for a sharp front

In this section, we give the contour dynamics equation (CDE) for sharp fronts. Recall that $K(x)=|x|^{-1-\alpha}$. The equation we study (1.1) can be written equivalently as

$$
\left\{\begin{array}{r}
\partial_{t} \theta+u \cdot \nabla \theta=0,  \tag{3.1}\\
u=\left(\nabla^{\perp} K\right) * \theta .
\end{array}\right.
$$

Definition 3.1. We say that $\theta=\theta(x, t)$ for $x \in \mathbb{R}^{2}, t \geq 0$ is a weak solution to (3.1) if there exists $T>0$ such that $\theta \in L^{2}\left(0, T ; L^{2}\left(\mathbb{R}^{2}\right)\right)$, $u=\nabla^{\perp} K * \theta \in L^{2}\left(0, T ; L^{2}\left(\mathbb{R}^{2} ; \mathbb{R}^{2}\right)\right)$, and for any $\phi \in C_{c}^{\infty}\left((0, T) \times \mathbb{R}^{2}\right)$

$$
\int_{0}^{T} \int_{\mathbb{R}^{2}} \theta \partial_{t} \phi+u \cdot \nabla \phi \mathrm{~d} x \mathrm{~d} t=0
$$

Definition 3.2. (Sharp front) We say that a weak solution $\theta$ to (3.1) is a sharp-front solution to (3.1) if
(1) for each $t \in[0, T]$, there exists a bounded simply connected closed set $A(t)$ with sufficiently regular boundary $\left(C^{2}\right)$, parameterised (anti-clockwise) by $z=z(s, t)$, with $s \in \mathbb{T}, t \in[0, T]$,
(2) $\theta$ is the indicator function of $A(t)$ for each $t \in(0, T)$,

$$
\theta(x, t)=\mathbf{1}_{x \in A(t)}:= \begin{cases}1 & x \in A(t) \\ 0 & x \notin A(t)\end{cases}
$$

It will be useful to have coordinates defined on a fixed domain $\mathbb{T}$. Therefore, we will not use arc-length, as the length of the curve may not be preserved in time. Instead, we use a uniform speed parameterisation (also see Section 4.1) $z: \mathbb{T} \rightarrow \mathbb{R}^{2}$ where the speed $\left|\frac{\mathrm{d} z}{\mathrm{~d} s}\right|=L$ is constant in $s$, and $L(t)$ is the length of the curve at time $t$. If $z$ is positively oriented, the 2D Frenet formulas are $\frac{\mathrm{d} T}{\mathrm{~d} s}=L \kappa N, \frac{\mathrm{~d} N}{\mathrm{~d} s}=-L \kappa T$, with unit tangent $T=\frac{1}{L} \frac{\mathrm{~d} z}{\mathrm{~d} s}$ and unit normal $N:=T^{\perp}$. The curvature is $\kappa=\frac{1}{L} \frac{\mathrm{~d} T}{\mathrm{~d} s} \cdot N=L^{-3} z_{s s} \cdot z_{s}^{\perp}$. Integration along $z$ will be written as

$$
\int_{z(\mathbb{T})} f(z) \mathrm{d} l:=L \int_{\mathbb{T}} f(z(s)) \mathrm{d} s
$$

A similar argument to [13] yields a rigorous derivation of the evolution equation for $z$.

Proposition 3.3 (Evolution of a sharp front). If $\theta=\mathbf{1}_{A}$ is a sharp front solution to (3.1), then the uniform speed counter-clockwise parameterisation $z: \mathbb{T} \rightarrow \mathbb{R}^{2}$ of $\partial A$ with normal $N=\partial_{s} z^{\perp}$ satisfies the
following CDE,

$$
\begin{equation*}
\partial_{t} z \cdot N=\left(-\int_{\mathbb{T}} K\left(z-z_{*}\right)\left(\partial_{s} z_{*}-\partial_{s} z\right) \mathrm{d} s_{*}\right) \cdot N=:-\mathcal{I}(z) \cdot N \tag{3.2}
\end{equation*}
$$

## 4. Almost-Sharp Fronts

In this chapter, we define an almost-sharp front as a regularisation (in a small strip) of a sharp front. Then we derive an asymptotic equation for an almost-sharp front, using an asymptotic lemma for a parameterised family of integrals. We also show that integrating across the transition region has a regularising effect, simplifying the asymptotic equation of an almost-sharp front.

Definition 4.1 (Almost-sharp front). An almost-sharp front (ASF) $\theta=\theta_{\delta}(x, t)$ to SQG is a family of solutions to (3.1), such that for each $\delta>0$ sufficiently small, there exists a closed $C^{2}$ curve $z$ bounding a simply connected region $A$, and a constant $C^{z}$ with $0<C^{z}<C$ for some fixed $C$ independent of $\delta$, such that with the following sets,

$$
\begin{aligned}
A_{\text {mid }}(t) & =\left\{x \in \mathbb{R}^{2}: \operatorname{dist}(x, \partial A(t)) \leq C^{z} \delta\right\}, \\
A_{\text {in }}(t) & =\left\{x \in A: \operatorname{dist}(x, A(t))>C^{z} \delta\right\}, \\
A_{\text {out }}(t) & =\mathbb{R}^{2} \backslash\left(A_{\text {in }} \cup A_{\text {mid }}\right)
\end{aligned}
$$

$\theta$ is a $C^{2}$ function in $\mathbb{R}^{2}$ (as a function of $x$ ) such that

$$
\theta(x, t)= \begin{cases}1 & x \in A_{\mathrm{in}}(t) \\ C^{2} \text { smooth } & x \in A_{\text {mid }}(t) \\ 0 & x \in A_{\text {out }}(t)\end{cases}
$$

We also demand the following growth condition for $\theta_{\delta}$,

$$
\begin{equation*}
\|\nabla \theta\|_{L^{\infty}} \lesssim \frac{1}{\delta} \tag{4.1}
\end{equation*}
$$

In particular $\theta$ is locally constant in $A_{\text {out }}(t) \cup A_{\text {in }}(t)$, and

$$
\operatorname{supp} \theta \subset A_{\text {mid }}(t) \cup A_{\text {in }}(t), \quad \operatorname{supp} \nabla \theta(\cdot, t) \subset A_{\text {mid }}(t)
$$

Note that the curve $z$ in the above definition is not unique.
Definition 4.2 (Compatible curve). Any curve $z$ satisfying the above definition for an ASF $\theta$ is called a compatible curve for $\theta$.
4.1. Tubular neighbourhood coordinates. Given a curve $z(s, t)$ with uniform speed (denoted by $L(t)$ ), we define the tubular neighbourhood coordinates around $z$ (for $\delta \ll 1$ ) by (we suppress the explicit dependence on $t$ )

$$
\begin{equation*}
x(s, \xi)=z(s)+\delta \xi N(s), s \in \mathbb{T}, \xi \in[-1,1] . \tag{4.2}
\end{equation*}
$$

We will denote by $L_{1}:=L(1-\delta \kappa \xi)$, where as before $\kappa$ is the curvature of $z$, and $L(t)$ is the length of the curve (which agrees with the uniform speed of the parameterisation). With $s, \xi$ as above and setting $\tau=t$, then elementary calculations yield
$\partial_{x^{1}}=\frac{T^{1}}{L_{1}} \partial_{s}-\frac{T^{2}}{\delta} \partial_{\xi}, \quad \partial_{x^{2}}=\frac{T^{2}}{L_{1}} \partial_{s}+\frac{T^{1}}{\delta} \partial_{\xi}, \quad \partial_{t}=A_{0}^{1} \partial_{s}+A_{0}^{2} \partial_{\xi}+\partial_{\tau}$,
where $A_{0}=\binom{A_{0}^{1}}{A_{0}^{2}}=\binom{-x_{\tau} \cdot T / L_{1}}{-x_{\tau} \cdot N / \delta}$, and $\mathrm{d} x$ under the change of variables is $\mathrm{d} x^{1} \mathrm{~d} x^{2}=\left|\operatorname{det} \frac{\mathrm{d}\left(x^{1}, x^{2}, t\right)}{\mathrm{d}(s, \xi, \tau)}\right| \mathrm{d} s \mathrm{~d} \xi=L_{1} \delta \mathrm{~d} s \mathrm{~d} \xi$.
4.2. Equation in tubular neighbourhood coordinates. Define $\Omega$ as $\theta$ expressed in the tubular neighbourhood coordinates, $\Omega(s, \xi, \tau)=$ $\theta(x, t)$. Then the gradient of $\theta$ and its perpendicular can be written as

$$
\nabla \theta=T \frac{\Omega_{s}}{L_{1}}+N \frac{\Omega_{\xi}}{\delta}, \quad \nabla^{\perp} \theta=N \frac{\Omega_{s}}{L_{1}}-T \frac{\Omega_{\xi}}{\delta}
$$

Since $u(x, t)=\int_{\mathbb{R}^{2}} \frac{\nabla^{\perp} \theta\left(x_{*}\right)}{\left|x-x_{*}\right|^{1+\alpha}} \mathrm{d} x_{*}$ from (1.1) we obtain the following expression for $u$ in terms of $\Omega$ (using $x=x(s, \xi, \tau)$ and $x_{*}=x\left(s_{*}, \xi_{*}, \tau\right)$ ),

$$
u(x)=\iint_{\mathbb{T} \times[-1,1]} \frac{\delta N_{*} \Omega_{s *}-L_{1 *} T_{*} \Omega_{\xi^{*}}}{\left|x-x_{*}\right|^{1+\alpha}} \mathrm{d} \xi_{*} \mathrm{~d} s_{*} .
$$

Then since

$$
\begin{aligned}
\nabla \theta(x) \cdot \nabla^{\perp} \theta\left(x_{*}\right)= & N_{*} \cdot T \frac{\Omega_{s *} \Omega_{s}}{L_{1 *} L_{1}}+N_{*} \cdot N \frac{\Omega_{s *} \Omega_{\xi}}{\delta L_{1 *}} \\
& -T_{*} \cdot T \frac{\Omega_{\xi *} \Omega_{s}}{\delta L_{1}}-T_{*} \cdot N \frac{\Omega_{\xi *} \Omega_{\xi}}{\delta^{2}},
\end{aligned}
$$

we can write the $u \cdot \nabla \theta$ term in the equation (3.1) as

$$
\begin{aligned}
u \cdot \nabla \theta(x)= & \iint_{\mathbb{T} \times[-1,1]} \frac{1}{\left|x-x_{*}\right|^{1+\alpha}}\left(N_{*} \cdot T \frac{\delta \Omega_{s *} \Omega_{s}}{L_{1}}+N_{*} \cdot N \Omega_{s *} \Omega_{\xi}\right. \\
& \left.-T_{*} \cdot T \frac{L_{1 *} \Omega_{\xi *} \Omega_{s}}{L_{1}}-T_{*} \cdot N \frac{L_{1 *} \Omega_{\xi *} \Omega_{\xi}}{\delta}\right) \mathrm{d} \xi_{*} \mathrm{~d} s_{*} .
\end{aligned}
$$

Therefore, using $\frac{L_{1 *}}{L_{1}}=1-\frac{\delta\left(\xi_{*} \kappa_{*}-\xi \kappa\right)}{1-\delta \kappa \xi}$, the equation (3.1) can be written in the new coordinates as (using $\nabla^{\perp} \Omega_{*} \cdot \nabla \Omega=\Omega_{s *} \Omega_{\xi}-\Omega_{\xi *} \Omega_{s}$ )

0= & \Omega_{\tau}+\Omega_{s}\left(A_{0}^{1}+\iint_{\mathbb{T} \times[-1,1]} \frac{\delta N_{*} \cdot T}{L_{1}\left|x_{*}-x\right|^{1+\alpha}} \Omega_{s *} \mathrm{~d} \xi_{*} \mathrm{~d} s_{*}\right. \\
& \left.+\iint_{\mathbb{T} \times[-1,1]} \frac{\delta\left(\xi_{*} \kappa_{*}-\xi \kappa\right) T_{*} \cdot T}{(1-\delta \xi \kappa)\left|x_{*}-x\right|^{1+\alpha}} \Omega_{\xi *} \mathrm{~d} \xi_{*} \mathrm{~d} s_{*}\right) \\
& +\left(\iint_{\mathbb{T} \times[-1,1]} \frac{T_{*} \cdot T}{\left.\left|x_{*}-x\right|^{1+\alpha} \nabla^{\perp} \Omega_{*} \mathrm{~d} \xi_{*} \mathrm{~d} s_{*}\right) \cdot \nabla \Omega}\right. \\
& +\frac{1}{\delta} \Omega_{\xi}\left(\iint_{\mathbb{T} \times[-1,1]} \frac{-L_{1 *} T_{*} \cdot N}{\left|x_{*}-x\right|^{1+\alpha}} \Omega_{\xi *} \mathrm{~d} \xi_{*} \mathrm{~d} s_{*}-z_{\tau} \cdot N\right) . \tag{4.2}
\end{align*}

4.3. An approximate equation for an almost-sharp front. We rewrite (4.2) as (this defines the terms $I_{i}$ )

$$
\begin{equation*}
0=\Omega_{\tau}+\Omega_{s}\left(A_{0}^{1}+\delta I_{1}+\delta I_{2}\right)+I_{3} \cdot \nabla \Omega+\frac{\Omega_{\xi}}{\delta}\left(I_{4}-z_{\tau} \cdot N\right) \tag{4.3}
\end{equation*}
$$

where $A_{0}^{1}=\frac{-z_{\tau} \cdot T}{L}+O(\delta)$, and aside from explicit dependencies, $I_{i}$ depends on $\delta$ through the coordinate function $x=z+\delta \xi N$ in (4.2).

We now want to find the leading order behaviour in $\delta \ll 1$. Asymptotic expansions for the integrals in (4.2) will be obtained using Lemma A. 1 and Corollary A.2, which are deferred to Appendix A.

Theorem 4.3 (Approximate Equation for an ASF). Given $\Omega$, a $\delta$ - $A S F$ solution of the generalised $S Q G$ equation (in the sense of Definition 4.1, tubular neighbourhood of the z) we have

& \quad+\int_{-1}^{1} \int_{\mathbb{T}} \frac{L \kappa_{*} T_{*} \cdot N}{\left|z-z_{*}\right|{ }^{1+\alpha} \xi_{*} \partial_{\xi} \Omega_{*} \mathrm{~d} s_{*} \mathrm{~d} \xi_{*} \partial_{\xi} \Omega} \\
& \quad+\frac{C_{1, \alpha} \delta^{-\alpha}}{L} \int_{-1}^{1} \frac{\left.\nabla \Omega_{*}^{\perp}\right|_{s_{*}=s}}{\left|\xi-\xi_{*}\right|^{\alpha}} \mathrm{d} \xi_{*} \cdot \nabla \Omega+\left.\frac{C_{2, \alpha}}{L^{1+\alpha}} \int_{-1}^{1} \nabla \Omega^{\perp}\right|_{s_{*}=s} \mathrm{~d} \xi_{*} \cdot \nabla \Omega \\
& \quad+\int_{-1}^{1} \int_{\mathbb{T}} \frac{T_{*} \cdot T \nabla^{\perp} \Omega_{*} \cdot \nabla \Omega}{\left|z-z_{*}\right|^{(1+\alpha) / 2}}-\frac{\left.\nabla^{\perp} \Omega_{*}\right|_{s_{*}=s} \cdot \nabla \Omega}{L^{1+\alpha}\left|\operatorname{Sin}\left(s-s_{*}\right)\right|^{1+\alpha}} \mathrm{d} s_{*} \mathrm{~d} \xi_{*} \tag{4.4}

Remark 4.4. In (4.4), the integral term

$$
(2+2 \alpha) L \int_{-1}^{1} \int_{\mathbb{T}} \frac{T_{*} \cdot N}{\left|z-z_{*}\right|^{3+\alpha}}\left(z-z_{*}\right) \cdot\left(\xi N-\xi_{*} N_{*}\right) \partial_{\xi} \Omega_{*} \mathrm{~d} s_{*} \mathrm{~d} \xi_{*} \partial_{\xi} \Omega
$$

is well defined, despite the strength of the singularity in the denominator, since the dot product introduces a cancellation as long as say, $z \in C^{3}(\mathbb{T})$.

Proof of Theorem 4.3. To use the lemma, we will perform an approximation of the integral in $s_{*}$ for fixed $\xi, \xi_{*}$, and $s$. For given $s, \xi, \xi_{*}$, when applying Lemma A.1, we will write $a_{*}=a\left(s_{*}\right)=a\left(s, s_{*}, \xi, \xi_{*}\right)$, and $a=a(s)=a\left(s, s, \xi, \xi_{*}\right)$.

We rewrite $I_{1}, I_{2}, I_{3}, I_{4}$ in (4.3) in a form suitable for Lemma A.1. We have $x=z+\xi \delta N$, and $x_{*}=z+\xi_{*} \delta N_{*}$ and so

\tau^{2} & =\delta^{2}\left(\xi_{*}-\xi\right)^{2}, \\
g\left(s_{*}\right) & =\left|x_{*}-x\right|^{2}-\tau^{2}, \\
g^{\prime}\left(s_{*}\right) & =2 x_{s *} \cdot x_{*}-2 x_{s *} \cdot x=2 x_{s *} \cdot\left(x_{*}-x\right), \\
g^{\prime \prime}\left(s_{*}\right) & =2\left|x_{s *}\right|^{2}+2 x_{s s *} \cdot\left(x_{*}-x\right) \\
& =2 L^{2}\left(1-\xi_{*} \delta \kappa_{*}\right)^{2}+2 x_{s s *} \cdot\left(x_{*}-x\right) .
\end{aligned}
$$

Since (as a function of $s_{*}$ with $s, \xi, \xi_{*}$ fixed) $g^{\prime}(s)=0$ and $g^{\prime \prime}(s)>0$ for $\delta \ll 1, g$ has a non-degenerate minimum at $s_{*}=s$, with $g(s)=$ $\tau^{2}-\tau^{2}=0$. As the curve $z$ has no self-intersections, this is the unique minimum. Therefore we have (as in Lemma A.1)

(Note that $G \neq L_{1}$, defined earlier as $L(1-\delta \kappa \xi)$.) For $a_{*}=a\left(s_{*}\right)$, Lemma A. 1 gives the following expansion for $I=\int_{\mathbb{T}} \frac{a_{*}}{\left|g_{*}+\tau^{2}\right|(1+\alpha) / 2} \mathrm{~d} s_{*}$,

where $\operatorname{Sin}$ is the rescaled $\operatorname{Sin}(s):=\sin (\pi s) / \pi$, and $C_{1, \alpha}, C_{2, \alpha}$ are two known constants. Also, with $g_{*}=g\left(s_{*}, \delta\right), G=G(\delta)$,

\partial_{\delta} G=-L \kappa \xi_{*},
$$

so that

\partial_{\delta} g\left(s_{*}, 0\right) & =2\left(\xi_{*} N_{*}-\xi N\right) \cdot\left(z_{*}-z\right), \\
\partial_{\delta}\left(G^{-1-\alpha}\right)(\delta) & =(-1-\alpha) G^{-2-\alpha} \partial_{\delta} G=\frac{(1+\alpha)}{L^{1+\alpha}\left(1-\xi_{*} \delta \kappa\right)^{2+\alpha}} \kappa \xi_{*} .

Corollary A. 2 in this setting gives

& +\delta \int_{\mathbb{T}} \frac{(-2-2 \alpha) a(s)}{\left|g\left(s_{*}, 0\right)\right|^{(3+\alpha) / 2}}\left(\xi_{*} N_{*}-\xi N\right) \cdot\left(z_{*}-z\right)-\frac{\partial_{\delta}\left(G^{-1-\alpha}\right)(0) a(s)}{|\operatorname{Sin} s|^{1+\alpha}} \mathrm{d} s_{*} \\
& +O\left(\delta^{1-\alpha}\right) .
\end{aligned}
$$

The terms $I_{1}, I_{2}$ are simpler. For $I_{1}, a\left(s_{*}\right)=\frac{N_{*} \cdot T}{L(1-\delta \kappa \xi)} \Omega_{s *}$, with $a(s)=0$. Lemma A. 1 gives

& =O\left(\delta^{1-\alpha}\right)
\end{aligned}
$$

For $I_{4}$, since $L_{1 *}=L\left(1-\delta \kappa_{*} \xi_{*}\right)$, we write $I_{4}=I_{4,1}+\delta I_{4,2}$, with

For $I_{4,1}, a\left(s_{*}\right)=-L T_{*} \cdot N \Omega_{\xi^{*}}$, and $a(s)=0$. Therefore, Lemma A. 1 and Corollary A. 2 gives (since $\partial_{\delta} g\left(s_{*}, 0\right)=L\left(x-x_{*}\right) \cdot\left(\xi N-\xi_{*} N_{*}\right)$ )

& +O\left(\delta^{2-\alpha}\right)
\end{aligned}
$$

Since we have chosen $\int_{-1}^{1} \Omega_{\xi_{*}} \mathrm{~d} \xi_{*}=1$, the first term is equal to the sharp front evolution term $-\mathcal{I}(z) \cdot N=z_{\tau} \cdot N$, and

For $I_{4,2}, a\left(s_{*}\right)=L \kappa_{*} \xi_{*} T_{*} \cdot N \Omega_{\xi *}$. Lemma A. 1 and Corollary A. 2 give

\end{aligned}
$$

For $I_{3}, a\left(s_{*}\right)=T_{*} \cdot T \nabla^{\perp} \Omega_{*}$. Applying Lemma A. 1 gives

& \left.+\int_{\mathbb{T}} \frac{T_{*} \cdot T \nabla^{\perp} \Omega_{*}}{\left|g_{*}\right|^{(1+\alpha) / 2}}-\frac{\left.\pi^{1+\alpha} \nabla^{\perp} \Omega_{*}\right|_{s_{*}=s}}{\left(L\left(1-\delta \kappa \xi_{*}\right)\right)^{1+\alpha}\left|\sin \left(\pi\left(s-s_{*}\right)\right)\right|^{1+\alpha}} \mathrm{d} s_{*}\right) \mathrm{d} \xi_{*} \\
& +O\left(\delta^{1-\alpha}\right)
\end{aligned}
$$

The remaining integral in $s_{*}$ is dealt with by applying Corrolary A.2,

& +\int_{\mathbb{T}} \frac{T_{*} \cdot T \int_{-1}^{1} \nabla^{\perp} \Omega_{*} \mathrm{~d} \xi_{*}}{\left|z-z_{*}\right|^{1+\alpha}}-\frac{\left.\pi^{1+\alpha} \int_{-1}^{1} \nabla^{\perp} \Omega_{*}\right|_{s_{*}=s} \mathrm{~d} \xi_{*}}{L^{1+\alpha}\left|\sin \left(\pi\left(s-s_{*}\right)\right)\right|^{1+\alpha}} \mathrm{d} s_{*}+O\left(\delta^{1-\alpha}\right),
\end{aligned}
$$

completing the proof.

## 5. A REGULARISAtion By integration across the Almost-Sharp Front

As noticed in [7], the most singular terms in $\left.\nabla \Omega^{\perp} \cdot \nabla \Omega_{*}\right|_{s_{*}=s}$ in the equation disappear upon integration in $\xi$ over $[-1,1]$, since for any even
integrable function $F$ and two functions $f, g$, we have the cancellation

$$
\iint_{\xi, \xi_{*} \in[-1,1]} F\left(\xi-\xi_{*}\right)\left[f(\xi) g\left(\xi_{*}\right)-f\left(\xi_{*}\right) g(\xi)\right] \mathrm{d} \xi \mathrm{~d} \xi_{*}=0
$$

The integrals with $\left.\nabla \Omega^{\perp} \cdot \nabla \Omega_{*}\right|_{s_{*}=s}$ are of this form, with $f=\partial_{s} \Omega$ and $g=\partial_{\xi} \Omega$, for fixed $s$. In particular, the term of order $\delta^{-\alpha}$ can be written in this form. This motivates shifting $\Omega$ by a constant so that

The identities $\int_{-1}^{1} \xi \partial_{\xi} \Omega(s, \xi) \mathrm{d} \xi=-h(s)$, and $\int_{-1}^{1} \partial_{\xi} \Omega(s, \xi) \mathrm{d} \xi=1$ yield

& +\int_{\mathbb{T}} \frac{L \kappa_{*} T_{*} \cdot N}{\left|z-z_{*}\right|^{1+\alpha}} h_{*} \mathrm{~d} s_{*}+\int_{\mathbb{T}} \frac{T_{*} \cdot T\left(h_{*}^{\prime}-h^{\prime}\right)}{\left|z-z_{*}\right|^{\mid+\alpha}} \mathrm{d} s_{*} .
\end{aligned}
$$

Namely, in the limit $\delta \rightarrow 0, h$ evolves via a linear homogenous integrodifferential equation that doesn't depend on $\Omega$. Rewriting the $\xi_{*}$ integrals in (4.4) using the two further identities

we can treat $h$ as an independently evolving function coupled with $\Omega$ via the following equation,

& +(2+2 \alpha) L \int_{\mathbb{T}} \frac{T_{*} \cdot N}{\left|z-z_{*}\right|^{3+\alpha}}\left(z-z_{*}\right) \cdot\left(\xi N+h_{*} N_{*}\right) \mathrm{d} s_{*} \partial_{\xi} \Omega \\
& +\int_{\mathbb{T}} \frac{L \kappa_{*} T_{*} \cdot N}{\left|z-z_{*}\right|^{1+\alpha} h_{*} \mathrm{~d} s_{*} \partial_{\xi} \Omega} \\
& +\frac{C_{1, \alpha} \delta^{-\alpha}}{L} \int_{-1}^{1} \frac{\left.\nabla \Omega_{*}^{\perp}\right|_{s_{*}=s}}{\left|\xi-\xi_{*}\right|^{\alpha}} \mathrm{d} \xi_{*} \cdot \nabla \Omega+\frac{C_{2, \alpha}}{L^{1+\alpha}}\binom{-1}{h^{\prime}} \cdot \nabla \Omega \\
& +\int_{\mathbb{T}}\left(\frac{T_{*} \cdot T\binom{-1}{h_{*}^{\prime}}}{\left|z-z_{*}\right|^{1+\alpha}}-\frac{\binom{-1}{h^{\prime}}}{L^{1-\alpha}\left|\operatorname{Sin}\left(s-s_{*}\right)\right|^{1+\alpha}}\right) \mathrm{d} s_{*} \cdot \nabla \Omega .
\end{aligned}
$$

Thus, using $h$ reduces the understanding of the evolution of $\Omega$ to understanding a nonlinear system, where the main nonlinearity is in the single term $L^{-1} C_{1, \alpha} \delta^{-\alpha} \int_{-1}^{1} \frac{\nabla \Omega_{*}^{1} \mid s_{*}=s}{\left|\xi-\xi_{*}\right|^{\alpha}} \mathrm{d} \xi_{*} \cdot \nabla \Omega$.

For SQG, this term can be expressed in terms of $h$ and $\Omega$, as a bilinear map, making the analysis completely different (see [8] for more details).

## 6. Evolution of compatible curves

A sharp front solution to (1.1) is completely determined by the evolution of a curve. In this section, by considering how compatible curves are transported by (1.1) in the regime $\delta \ll 1$, we show that an almostsharp front solution is approximately determined by the evolution of a compatible curve.

We will first present the main result of this section, Theorem 6.2 by relying on a fractional Leibniz rule (6.2). Lemma 6.3 replaces the more complicated (6.2) at the cost of a small loss in the error term. The proof is similar to Lemma 6.1 (see [4] - we present a short proof as the approach will be relevant for Lemma 6.3).

Lemma 6.1. Let $0<s<1 / 2$ and suppose $A \subseteq \mathbb{R}^{d}$ is a bounded set with $C^{2}$ boundary in $\mathbb{R}^{d}$. Then $\mathbf{1}_{A} \in H^{s}\left(\mathbb{R}^{d}\right)$ with

$$
\left\|\Lambda^{s} \mathbf{1}_{A}\right\|_{L^{2}}^{2} \lesssim_{d, s}|A|^{1-2 s}
$$

Proof. We bound the Gagliardo seminorm $\left[\mathbf{1}_{A}\right]_{H^{s}}$ directly, which is known (see for instance [12]) to be equal to $\left\|\Lambda^{s} \mathbf{1}_{A}\right\|_{L^{2}}$ up to a constant depending on $s$ alone. By definition,

\left[\mathbf{1}_{A}\right]_{H^{s}}^{2}:=\int_{\mathbb{R}^{d}} \int_{\mathbb{R}^{d}} \frac{\left|\mathbf{1}_{A}(x)-\mathbf{1}_{A}(y)\right|^{2}}{|x-y|^{d+2 s}} \mathrm{~d} y \mathrm{~d} x=2 \int_{x \in A} \int_{y \in A^{c}} \frac{\mathrm{~d} y \mathrm{~d} x}{|x-y|^{d+2 s}} .
$$

Writing out a 'layer cake' decomposition(see for example [11, page 26]) with $\mu$ the $2 d$-dimensional Lebesgue measure,

$$
\left[\mathbf{1}_{A}\right]_{H^{s}}^{2}=\int_{0}^{\infty} \mu\left[x \in A, y \in A^{c}:|x-y|<\frac{1}{t^{1 /(d+2 s)}}\right] \mathrm{d} t
$$

From this, we have $\left[\mathbf{1}_{A}\right]_{H^{s}}^{2}=\int_{0}^{\infty} m\left(\frac{1}{t^{1 /(d+2 s)}}\right) \mathrm{d} t$, where $m(t)$ is

m(t):=\mu\left[x \in A, y \in A^{c}:|x-y|<t\right] .
$$

For any set $U \subseteq \mathbb{R}^{d}$, define $(U)_{\varepsilon}=\{x: d(x, U)<\varepsilon\}$. The change of variables $\tau=\frac{1}{t^{1 /(2+2 s)}}, \mathrm{d} t=(d+2 s) \tau^{-d-2 s-1} \mathrm{~d} \tau$ yields

\left[\mathbf{1}_{A}\right]_{H^{s}}^{2}=(2 d+4 s) \int_{0}^{\infty} \frac{m(\tau)}{\tau^{d+2 s+1}} \mathrm{~d} \tau \lesssim_{d, s} \int_{0}^{\varepsilon_{0}} \frac{m(\tau)}{\tau^{d+2 s+1}} \mathrm{~d} \tau+\int_{\varepsilon_{0}}^{\infty} \frac{m(\tau)}{\tau^{d+2 s+1}} \mathrm{~d} \tau
$$

For some $\epsilon_{0}$ to be chosen as follows. We can bound $m(\tau)$ using the following inclusion:

$$
\left\{x \in A, y \in A^{c}:|x-y|<\tau\right\} \subset\left\{x \in A, y \in B_{\mathbb{R}^{d}}(x, \tau): d(x, \partial A)<\tau\right\}
$$ where $B_{\mathbb{R}^{d}}(x, \tau)$ is the ball around $x$ of radius $\tau$, which implies

m(\tau) \leq \mu\left[x \in A, y \in B_{\mathbb{R}^{d}}(x, \tau): d(x, \partial A)<\tau\right] \lesssim\left|B_{\mathbb{R}^{d}}(0,1)\right| \tau^{d+1}
$$

since $(\partial A)_{\tau}$ is $O(\tau)$ by the $C^{2}$ regularity of the boundary. But for $\tau>|A|$, the following easier bound is better,

m(\tau) \leq \mu\left[x \in A: y \in B_{\mathbb{R}^{d}}(x, \tau)\right] \lesssim\left|B_{\mathbb{R}^{d}}(0,1)\right||A| \tau^{d}
$$

For the optimal bound, we choose $\epsilon_{0}=|A|$ to define $I_{1}, I_{2}$, giving

\int_{0}^{\varepsilon_{0}} \frac{m(\tau)}{\tau^{d+2 s+1}} \mathrm{~d} \tau \lesssim_{d} \int_{0}^{|A|} \frac{\mathrm{d} \tau}{\tau^{2 s}}=\frac{1}{1-2 s}|A|^{1-2 s} \lesssim_{s}|A|^{1-2 s}
$$

and

$$
\int_{\varepsilon_{0}}^{\infty} \frac{m(\tau)}{\tau^{d+2 s+1}} \mathrm{~d} \tau \lesssim_{d}|A| \int_{|A|}^{\infty} \frac{\mathrm{d} \tau}{\tau^{2 s+1}}=|A| \frac{|A|^{-2 s}}{2 s} \lesssim s|A|^{1-2 s}
$$

Combining these bounds gives the claimed bound on $\left[\mathbf{1}_{A}\right]_{H^{s}}^{2}$.
We now present the main result of this section.

Theorem 6.2. Suppose that $\theta$ is an ASF solution, and $z$ is a compatible curve as defined in (4.2). Then $z$ satisfies the sharp front equation (in the weak sense) up to $O\left(\delta^{1-\alpha}\right)$ errors,

\partial_{t} z \cdot N=\left(-\int_{\mathbb{T}} K\left(z-z_{*}\right)\left(\partial_{s} z_{*}-\partial_{s} z\right) \mathrm{d} s_{*}\right) \cdot N+O\left(\delta^{1-\alpha}\right)

Proof. The strategy of this proof is the same as [3]. For brevity of notation, we shall in this proof write

\left(\mathbf{1}_{\text {in }}, \mathbf{1}_{\text {mid }}, \mathbf{1}_{\text {out }}\right):=\left(\mathbf{1}_{A_{\mathrm{in}}^{z}}, \mathbf{1}_{A_{\mathrm{mid}}^{z}}^{z}, \mathbf{1}_{A_{\text {out }}^{z}}\right) .
$$

As in Proposition 3.3, the term $\iint_{\mathbb{R}^{2}, t} \partial_{t} \phi \theta$ brings out the time derivative of the $C^{2}$ boundary curve: since the set $A_{\text {mid }}$ has measure $O(\delta)$, we see that if $z^{\delta}=z+\delta N$ parameterises the boundary of $A_{\mathrm{in}}$,

$$
\begin{aligned}
\iint_{\mathbb{R}^{2} \times[0, \infty]} \partial_{t} \phi \theta \mathrm{~d} x \mathrm{~d} t & =\iint_{\left\{x \in \mathbb{R}^{2}, t \geq 0: x \in A_{\mathrm{in}}(t)\right\}} \partial_{t} \phi \mathrm{~d} x \mathrm{~d} t+O(\delta) \\
& =\int_{0}^{\infty} \int_{\mathbb{T}} \partial_{t}\left(z^{\delta}\right) \nu^{3} \phi\left(z^{\delta}, t\right) \mathrm{d} s \mathrm{~d} t+O(\delta) .
\end{aligned}
$$

Here, $\nu^{3}$ is the third component of the outward normal $\nu$ 's as a vector in $\left(x^{1}, x^{2}, t\right)$-space, and

$$
\begin{aligned}
\partial_{t}\left(z^{\delta}\right) \nu^{3}=\partial_{t}\left(z^{\delta}\right) \cdot \partial_{s}\left(\left(z^{\delta}\right)^{\perp}\right) & =(L-\delta L \kappa) \partial_{t}(z+\delta N) \cdot \partial_{s} z^{\perp} \\
& =L \partial_{t} z \cdot N+O(\delta),
\end{aligned}
$$

where we used our definition of a compatible curve. Hence, as $\phi \in C^{1}$ and $\mathrm{d} l=L \mathrm{~d} s$ for the uniform speed parameterised curve $z$, writing $\partial A$ for the curve parameterised by $z$, we have

$$
\iint_{\mathbb{R}^{2} \times[0, \infty]} \partial_{t} \phi \theta \mathrm{~d} x \mathrm{~d} t=-\int_{0}^{\infty} \int_{\partial A} \phi(z) \partial_{t} z \cdot N \mathrm{~d} l \mathrm{~d} t+O(\delta) .
$$

We now treat the second term $\iint_{\mathbb{R}^{2} \times[0, \infty]} u \cdot \nabla \phi \theta$ : observe the following decomposition, where we have written $u=\nabla^{\perp} K * \theta=\left(\nabla^{\perp} K\right) * \theta$ as a convolution of $\theta$ with the kernel $\nabla^{\perp} K$, and used the bilinearity of $(f, g) \mapsto \int_{\mathbb{R}^{2}} \nabla^{\perp} K * f \cdot \nabla \phi g$, and $\theta=\theta \cdot\left(\mathbf{1}_{\text {in }}+\mathbf{1}_{\text {mid }}+\mathbf{1}_{\text {out }}\right)=\theta \mathbf{1}_{\text {mid }}+\mathbf{1}_{\text {in }}:$

$$
\begin{align*}
\int_{\mathbb{R}^{2}} u \cdot \nabla \phi \theta & =\int_{\mathbb{R}^{2}} \nabla^{\perp} K * \mathbf{1}_{\text {in }} \cdot \nabla \phi \mathbf{1}_{\text {in }}+\int_{\mathbb{R}^{2}} \nabla^{\perp} K * \mathbf{1}_{\text {in }} \cdot \nabla \phi \theta \mathbf{1}_{\text {mid }} \\
& +\int_{\mathbb{R}^{2}} \nabla^{\perp} K *\left(\theta \mathbf{1}_{\text {mid }}\right) \cdot \nabla \phi \theta \mathbf{1}_{\text {mid }}+\int_{\mathbb{R}^{2}} \nabla^{\perp} K *\left(\theta \mathbf{1}_{\text {mid }}\right) \cdot \nabla \phi \mathbf{1}_{\text {in }} \\
& =:(\mathrm{EVO})+(\mathrm{A})+(\mathrm{B})+(\mathrm{C}) \\
& =(\mathrm{EVO})+[(\mathrm{A})+(\mathrm{B})]+[(\mathrm{B})+(\mathrm{C})]-(\mathrm{B}) . \tag{6.1}
\end{align*}
$$

We will estimate separately each of the 4 terms in the last line of (6.1). Up to $O\left(\delta^{1-\alpha}\right)$ errors, (EVO) will give us the evolution term, and the square-bracketed terms will use the $C^{\varepsilon}$ regularity of $\theta=\theta \mathbf{1}_{\text {mid }}+\mathbf{1}_{\text {in }}$ that is not available when estimating (A) or (C) alone.

Control on $[(\mathbf{A})+(\mathbf{B})]$. We proceed by splitting the kernel $K$,

$$
\begin{aligned}
{[(\mathrm{A})} & +(\mathrm{B})]=\int_{\mathbb{R}^{2}} \nabla^{\perp} K * \theta \cdot \nabla \phi \mathbf{1}_{\text {mid }} \\
& =\int_{\mathbb{R}^{2}}\left(\left(\nabla^{\perp} K\right) \mathbf{1}_{|\cdot|>\delta}\right) * \theta \cdot \nabla \phi \mathbf{1}_{\text {mid }}+\int_{\mathbb{R}^{2}}\left(\left(\nabla^{\perp} K\right) \mathbf{1}_{|\cdot|<\delta}\right) * \theta \cdot \nabla \phi \mathbf{1}_{\text {mid }}
\end{aligned}
$$

We note the bounds (recall that $\int_{|y|<\delta} K(y) \mathrm{d} y=0$ )

$$
\begin{aligned}
\left|\left(\left(\nabla^{\perp} K\right) \mathbf{1}_{\cdot \mid>\delta}\right) * \theta(x)\right| & \lesssim\|\theta\|_{L^{\infty}} \int_{r=\delta}^{\infty} \frac{r \mathrm{~d} r}{r^{2+\alpha}} \lesssim_{\theta, \alpha} \delta^{-\alpha}, \text { and } \\
\left|\left(\left(\nabla^{\perp} K\right) \mathbf{1}_{|\cdot|<\delta}\right) * \theta(x)\right| & =\left|\int_{|y|<\delta} K(y) \theta(x-y) \mathrm{d} y\right| \\
& \left.=\left.\left|\int_{|y|<\delta} K(y)\right| y\right|^{\alpha^{\prime}}\left(\frac{\theta(x-y)-\theta(x)}{|y|^{\alpha^{\prime}}}\right) \mathrm{d} y \right\rvert\, \\
& \lesssim[\theta]_{C^{\alpha^{\prime}}} \int_{r=0}^{\delta} \frac{r \mathrm{~d} r}{r^{2+\alpha-\alpha^{\prime}}} \lesssim[\theta]_{C^{\alpha^{\prime}}} \delta^{\alpha^{\prime}-\alpha}=O\left(\delta^{-\alpha}\right),
\end{aligned}
$$

where in the second inequality, we used the regularity assumption $[\theta]_{C \alpha^{\prime}} \lesssim \delta^{-\alpha^{\prime}}$ for some $\alpha^{\prime}>\alpha$. Hence both terms are integrals of $O\left(\delta^{-\alpha}\right)$ functions that have support of size $O(\delta)$, due to the $\mathbf{1}_{\text {mid }}$ term. Therefore, $(\mathrm{A})+(\mathrm{B})=O\left(\delta^{1-\alpha}\right)$.

Control on $[(\mathbf{B})+(\mathbf{C})]$. Here, notice that

$$
\begin{aligned}
\int_{\mathbb{R}^{2}} \nabla^{\perp} K * f \cdot g & =-\int_{\mathbb{R}^{2}} \partial_{x^{2}} K * f g^{1}+\int_{\mathbb{R}^{2}} \partial_{x^{1}} K * f g^{2} \\
& =-\int_{\mathbb{R}^{2}} f \partial_{x^{2}} K * g^{1}+\int_{\mathbb{R}^{2}} f \partial_{x^{1}} K * g^{2} .
\end{aligned}
$$

The important feature is that the two kernels $\partial_{x^{1}} K(-x), \partial_{x^{2}} K(-x)$ have the same $-2-\alpha$ homogeneity as $\nabla^{\perp} K$, and have mean zero on the unit sphere. Hence, with $f=\theta \mathbf{1}_{\text {mid }}$ and $g=\nabla \phi \theta \in C^{\varepsilon}$, we can repeat the proof as for $[(\mathrm{A})+(\mathrm{B})]$, obtaining the same $O\left(\delta^{1-\alpha}\right)$ estimate.

Control on (B). Writing $R=\nabla \Lambda^{-1}$ for the vector of Riesz transforms (see for instance [14]), we have $\nabla^{\perp} K * f=R^{\perp} \Lambda^{\alpha} f$, so that

$$
\begin{aligned}
|(\mathrm{B})| & =\left|\int_{\mathbb{R}^{2}} R^{\perp} \Lambda^{\alpha / 2}\left(\theta \mathbf{1}_{\text {mid }}\right) \cdot \Lambda^{\alpha / 2}\left(\nabla \phi \theta \mathbf{1}_{\text {mid }}\right)\right| \\
& \lesssim\left\|R^{\perp} \Lambda^{\alpha / 2}\left(\theta \mathbf{1}_{\text {mid }}\right)\right\|_{L^{2}}\left\|\Lambda^{\alpha / 2}\left(\nabla \phi \theta \mathbf{1}_{\text {mid }}\right)\right\|_{L^{2}} \\
& \lesssim\left\|\Lambda^{\alpha / 2}\left(\theta \mathbf{1}_{\text {mid }}\right)\right\|_{L^{2}}\left\|\Lambda^{\alpha / 2}\left(\nabla \phi \theta \mathbf{1}_{\text {mid }}\right)\right\|_{L^{2}},
\end{aligned}
$$

where the last line uses the boundedness of $R^{\perp}: L^{2} \rightarrow L^{2}$. To bound these terms, we will use the following fractional Leibniz rule of e.g. [10],

$$
\begin{equation*}
\left\|\Lambda^{s}(f g)\right\|_{L^{2}} \leq\left\|\Lambda^{s} f\right\|_{L^{\infty}}\|g\|_{L^{2}}+\|f\|_{L^{\infty}}\left\|\Lambda^{s} g\right\|_{L^{2}} \quad s \in(0,1) \tag{6.2}
\end{equation*}
$$

and the following easy estimate, valid for $s+\epsilon \leq 1$ that comes from bounding the following two terms separately (similarly to the earlier part of this proof) $\Lambda^{s} f(x)=\left(\int_{|x-y| \leq \delta}+\int_{|x-y|>\delta}\right) \frac{f(x)-f(y)}{|x-y|^{2+s}} \mathrm{~d} y$,

$$
\left\|\Lambda^{s} f(x)\right\|_{L^{\infty}} \lesssim \delta^{\epsilon}[f]_{C^{s+\epsilon}}+\delta^{-s}\|f\|_{L^{\infty}}
$$

By interpolation, since $|\nabla \theta| \lesssim \frac{1}{\delta}$ (Definition 4.1), $[f]_{C^{s+\epsilon}} \lesssim \delta^{-s-\epsilon}$ for $s+\epsilon \leq 1$. Setting $s=\alpha / 2, g=\mathbf{1}_{\text {mid }}$ and $f=\theta$ or $\nabla \phi \theta$, we obtain

$$
\left\|\Lambda^{\alpha / 2}\left(\theta \mathbf{1}_{\text {mid }}\right)\right\|_{L^{2}} \lesssim \delta^{(1-\alpha) / 2}, \quad\left\|\Lambda^{\alpha / 2}\left(\nabla \phi \theta \mathbf{1}_{\text {mid }}\right)\right\|_{L^{2}} \lesssim \delta^{(1-\alpha) / 2}
$$

Together, these inequalities prove that $|(\mathrm{B})| \lesssim \delta^{1-\alpha}$.
Evolution term in (EVO). By following the proof of the analogous sharp front result (3.3) and using $z^{\delta}=z+\delta N$ again,

$$
\begin{aligned}
I_{\text {in }} & =\int_{\mathbb{T}} \phi\left(z^{\delta}\right)\left(\int_{\mathbb{T}} K\left(z^{\delta}-z_{*}^{\delta}\right) \partial_{s} z_{*}^{\delta} \cdot \partial_{s}\left(z_{*}^{\delta}\right)^{\perp} \mathrm{d} s_{*}\right) \mathrm{d} s \\
& =\int_{s \in I} \phi(z)\left(\int_{\mathbb{T}} K\left(z-z_{*}\right)\left(\partial_{s} z_{*}-\partial_{s} z\right) \mathrm{d} s_{*}\right) \cdot N \mathrm{~d} s+O(\delta) .
\end{aligned}
$$

This last line follows from a simple application of Mean Value Theorem, completing the proof.

In the above proof, we relied on a fractional Leibniz rule (6.2). The following lemma can serve as a weak replacement:

Lemma 6.3 (Hölder-Indicator Leibniz Rule). Let $0<s<1 / 2$, $s<s^{\prime}$. Suppose $A \subseteq \mathbb{R}^{d}$ is a bounded set with $C^{2}$ boundary and let $f \in C^{s^{\prime}}(A)$. Then the extension of $f$ by zero, $f \mathbf{1}_{A}$ belongs to $H^{s}\left(\mathbb{R}^{d}\right)$ with

$$
\left\|\Lambda^{s}\left(f \mathbf{1}_{A}\right)\right\|_{L^{2}\left(\mathbb{R}^{d}\right)}^{2} \lesssim_{d, s}\|f\|_{L^{\infty}(A)}^{2}|A|^{1-2 s}+[f]_{C^{s^{\prime}}(A)}^{2}|A|^{1-\frac{2\left(s-s^{\prime}\right)}{d}} .
$$

Proof. We again bound the Gagliardo seminorm $\left[f \mathbf{1}_{A}\right]_{H^{s}}^{2}$. We have

$$
\begin{aligned}
{\left[f \mathbf{1}_{A}\right]_{H^{s}}^{2} } & =\left(2 \int_{A^{c}} \int_{A}+\int_{A} \int_{A}\right) \frac{\left|\left(f \mathbf{1}_{A}\right)(x)-\left(f \mathbf{1}_{A}\right)(y)\right|^{2}}{|x-y|^{d+2 s}} \mathrm{~d} x \mathrm{~d} y \\
& =2 \int_{A^{c}} \int_{A} \frac{|f(x)|^{2}}{|x-y|^{d+2 s}} \mathrm{~d} x \mathrm{~d} y+\int_{A} \int_{A} \frac{|f(x)-f(y)|^{2}}{|x-y|^{d+2 s}} \mathrm{~d} x \mathrm{~d} y .
\end{aligned}
$$

the proof of Lemma 6.1 (when only one of $x, y$ is in $A$ ) yields

$$
\int_{A^{c}} \int_{A} \frac{|f(x)|^{2}}{|x-y|^{d+2 s}} \mathrm{~d} x \mathrm{~d} y \lesssim d, s\|f\|_{L^{\infty}}^{2}|A|^{1-2 s}
$$

but unlike Lemma 6.1, we do have contributions when $(x, y) \in A \times A$. That is, we need to obtain a bound on the integral

$$
I_{A}:=\int_{A} \int_{A} \frac{|f(x)-f(y)|^{2}}{|x-y|^{d+2 s}} \mathrm{~d} x \mathrm{~d} y .
$$

Using a layer cake decomposition again with

$$
\tilde{m}(t):=\mu(x, y \in A, y \in A:|x-y|<t),
$$

we can estimate $I_{A}$ as follows:

$$
\begin{aligned}
I_{A} & =\int_{0}^{\infty} \mu\left[x \in A, y \in A: \frac{|f(x)-f(y)|^{2}}{|x-y|^{d+2 s}}>t\right] \mathrm{d} t \\
& \leq \int_{0}^{\infty} \mu\left[x \in A, y \in A: \frac{[f]_{C^{s^{\prime}}}^{2}}{|x-y|^{\left.d+2\left(s-s^{\prime}\right)\right)}}>t\right] \mathrm{d} t \\
& =\int_{0}^{\infty} \tilde{m}\left(\left([f]_{C^{s^{\prime}}}^{2} / t\right)^{\frac{1}{d+2\left(s-s^{\prime}\right)}}\right) \mathrm{d} t \lesssim_{d, s, s^{\prime}}[f]_{C^{s^{\prime}}}^{2} \int_{0}^{\infty} \frac{\tilde{m}(\tau)}{\tau^{d+2\left(s-s^{\prime}\right)+1}} \mathrm{~d} \tau
\end{aligned}
$$

where in the last line we have changed variables $\tau=\left([f]_{C^{s^{\prime}}}^{2} / t\right)^{\frac{1}{d+2\left(s-s^{\prime}\right)}}$ and ignored constants. Observe that by reasoning similarly to Lemma 6.1,

$$
\tilde{m}(\tau) \lesssim_{d} \min \left(|A|^{2},|A| \tau^{d}\right) .
$$

Hence, the optimal bound is obtained by splitting the integration region $\tau>0$ into the sets $\tau \in\left[0,|A|^{1 / d}\right]$ and $\tau \in\left[|A|^{1 / d}, \infty\right]$, which yields

$$
\begin{aligned}
I_{A} & \lesssim[f]_{C^{s^{\prime}}}^{2}|A| \int_{0}^{|A|^{1 / d}} \frac{\mathrm{~d} \tau}{\tau^{2\left(s-s^{\prime}\right)+1}}+[f]_{C^{s^{\prime}}}^{2}|A|^{2} \int_{|A|^{1 / d}}^{\infty} \frac{\mathrm{d} \tau}{\tau^{d+2\left(s-s^{\prime}\right)+1}} \\
& =[f]_{C^{s^{\prime}}}^{2}\left(|A|^{1-\frac{2\left(s-s^{\prime}\right)}{d}}+|A|^{2-\frac{d+2\left(s-s^{\prime}\right)}{d}}\right) \lesssim[f]_{C^{s^{\prime}}}^{2}|A|^{1-\frac{2\left(s-s^{\prime}\right)}{d}},
\end{aligned}
$$

so long as $s^{\prime}>s$. As there is no contribution to $\left[f \mathbf{1}_{A}\right]_{H^{s}}^{2}$ when $(x, y) \in$ $A^{c} \times A^{c}$, this concludes the proof.

Using Lemma 6.3 instead of the fractional Leibniz rule (6.2), we obtain the following weaker result.

Theorem 6.4. Suppose that $\theta$ is an ASF solution, and $z$ is a compatible curve as defined in (4.2). Then $z$ satisfies the sharp front equation (in the weak sense) up to $O\left(\delta^{1-\alpha^{\prime}}\right)$ errors for any $\alpha^{\prime}>\alpha$,

$$
\partial_{t} z \cdot N=\left(-\int_{\mathbb{T}} K\left(z-z_{*}\right)\left(\partial_{s} z_{*}-\partial_{s} z\right) \mathrm{d} s_{*}\right) \cdot N+O\left(\delta^{1-\alpha^{\prime}}\right)
$$

## 7. The spine of an almost-sharp front

Here we introduce the concept of the spine, first considered by Fefferman, Luli and Rodrigo in [5] for SQG in the periodic setting (our contours are however not graphs). To simplify the following calculations, assume without loss of generality $\Omega$ is given by (5.1).

Definition 7.1. Suppose an almost-sharp front has tubular neighbourhood coordinates (see Section 4.1) $(s, \xi)$ for the transition region, induced by the compatible curve $z$.

We say that the curve $\vec{S}$ is a spine for the almost-sharp front if $\vec{S}$ is also a compatible curve, and there is a $C^{2}$ function of the uniform speed parameter $f=f(s)$ taking values in $\left[-C^{z}, C^{z}\right]$ such that

$$
\int_{-C^{z}}^{C^{z}}\left(\xi_{*}-f\left(s_{*}\right)\right) \partial_{\xi} \Omega_{*} \mathrm{~d} \xi_{*}=0
$$

or equivalently by the choice $\left.\Omega\right|_{\xi= \pm C^{z}}= \pm 1 / 2, f\left(s_{*}\right)=-\int_{-C^{z}}^{C^{z}} \Omega_{*} \mathrm{~d} \xi_{*}$, and the corresponding spine is the curve $\vec{S}$ given in $(s, \xi)$ coordinates as $\xi=f(s)$, that is:

$$
\vec{S}(s)=z(s)+\delta f(s) N(s)
$$

The function $f$ acts as a correction, so that for example, the base curve is also a spine if $f=0$.

An immediate consequence of Definition 7.1 by integrating by parts is the following cancellation property for any constant $C \geq\|f\|_{L^{\infty}}$,

$$
\begin{equation*}
0=\int_{\xi_{*}=f-C-C^{z}}^{f+C+C^{z}} \Omega_{*} \mathrm{~d} \xi_{*}, \tag{7.1}
\end{equation*}
$$

where $\Omega$ is continuously extended to be constant on $|\xi| \geq C^{z}$ past the geometrically significant range that defines the tubular neighbourhood.

Indeed, for $D \gg 1$,

$$
\int_{f-D}^{f+D} \Omega_{*} \mathrm{~d} \xi_{*}=\underbrace{\left.\xi_{*} \Omega_{*}\right|_{f-D} ^{f+D}}_{=-f}-\underbrace{\int_{f-D}^{f+D} \xi_{*} \partial_{\xi} \Omega_{*} \mathrm{~d} \xi_{*}}_{=\int_{-C^{z}}^{C^{z}} \xi_{*} \partial_{\xi} \Omega_{*} \mathrm{~d} \xi_{*}}=\int_{-C^{z}}^{C^{z}}\left(\xi_{*}-f\right) \partial_{\xi} \Omega_{*} \mathrm{~d} \xi_{*}=0
$$

We also have the following property.
Proposition 7.2 (Spine approximation property). Let $\theta$ be a $C^{2}$ almostsharp front, and let $\vec{S}$ be the spine curve defined by the above (7.1). Then for any $\Gamma=\Gamma(x) \in C_{c}^{2}\left(\mathbb{R}^{2}\right)$, as $\delta \rightarrow 0$,

$$
\begin{equation*}
\int_{x \in \mathbb{R}^{2}} \Gamma \nabla^{\perp} \theta \mathrm{d} x=-\int_{\mathbb{T}} \Gamma\left(\vec{S}_{*}\right) \partial_{s} \vec{S}_{*} \mathrm{~d} s_{*}+O\left(\|\Gamma\|_{C^{2}} \delta^{2}\right) \tag{7.2}
\end{equation*}
$$

We keep the $\|\Gamma\|_{C^{2}}$ dependence in (7.2) because we will require the use of test functions with $\|\Gamma\|_{C^{2}}$ that degenerate as $\delta \rightarrow 0$.

Proof. Write $\tilde{\Gamma}=\Gamma(x(s, \xi))$, with $x=z+\delta \xi N$. We are looking for the following expansion

$$
\begin{equation*}
\iint\left(\delta \partial_{s} \Omega_{*} N_{*}-L\left(1-\delta \kappa_{*} \xi_{*}\right) \partial_{\xi} \Omega_{*} T_{*}\right) \tilde{\Gamma}_{*} \mathrm{~d} s_{*} \mathrm{~d} \xi_{*}+\int_{\mathbb{T}} \tilde{\Gamma}_{*} \partial_{s} \vec{S}_{*} \mathrm{~d} s_{*} \stackrel{?}{=} O\left(\delta^{2}\right) . \tag{7.3}
\end{equation*}
$$

We Taylor expand around $\vec{S}_{*}$ in the direction of $N_{*}$ to obtain

$$
\begin{aligned}
\tilde{\Gamma}_{*}=\Gamma\left(x_{*}\right) & =\Gamma\left(\vec{S}_{*}\right)+\nabla \Gamma\left(\vec{S}_{*}\right) \cdot\left(x_{*}-\vec{S}_{*}\right)+O\left(\left|x_{*}-\vec{S}_{*}\right|^{2}\right) \\
& =\Gamma\left(\vec{S}_{*}\right)+\delta \nabla \Gamma\left(\vec{S}_{*}\right) \cdot N_{*}\left(\xi_{*}-f_{*}\right)+O\left(\delta^{2}\right) .
\end{aligned}
$$

Plugging into the left hand side (LHS) of (7.3) we have

## LHS

$$
\begin{align*}
& =\int_{\mathbb{T}}\left[\Gamma\left(\vec{S}_{*}\right)\left(\partial_{s} \vec{S}_{*}-T_{*} \int_{-1}^{1} L\left(1-\delta \kappa_{*} \xi_{*}\right) \partial_{\xi} \Omega_{*} \mathrm{~d} \xi_{*}+\delta N_{*} \int_{-1}^{1} \partial_{s} \Omega_{*} \mathrm{~d} \xi_{*}\right)\right. \\
& \left.-L \delta \nabla \Gamma\left(\vec{S}_{*}\right) \cdot N_{*} \int_{-1}^{1}\left(\xi_{*}-f_{*}\right) \partial_{\xi} \Omega_{*} T_{*} \mathrm{~d} \xi_{*}\right] \mathrm{d} s_{*}+O\left(\delta^{2}\right) \tag{7.4}
\end{align*}

The following identities (immediate from the definitions of $\vec{S}$ and $f$ ),

show that the right-hand side of (7.4) is of order $\delta^{2}$, as the terms in the square brackets vanish.
7.1. Evolution of a spine. Theorem 6.2 showed that any compatible curve evolves by the sharp front equation (3.2) up to an error of order $O\left(\delta^{1-\alpha}\right)$. However, for the spine, we will improve this to $O\left(\delta^{2-\alpha}\right)$.

Theorem 7.3. Suppose that $\theta$ is an ASF solution. Then the spine curve $\vec{S}$ in Definition 7.1 evolves (in the weak sense) according to the sharp front equation up to $O\left(\delta^{2-\alpha}\right)$ error. That is,

Without loss of generality, assume the constant for the base curve $C^{z}=1$, and choose $\delta \ll 1$ so that we can extend the $\xi$ coordinate to the range $[-3,3]$, having a well defined neighbourhood of thickness $6 \delta$. Recall that $\theta$ is a weak solution if for every $\Gamma \in C_{c}^{\infty}\left((0, \infty) \times \mathbb{R}^{2}\right)$,

We give the names $\vec{S}^{+}$and $\vec{S}^{-}$to the inner and outer boundary curves of $A_{\text {mid }}^{\vec{S}}$ respectively,

We treat the two integrands $\theta \partial_{t} \Gamma$ and $\theta(u \cdot \nabla \Gamma)$ in (7.6) separately, with the three sets to integrate over. For the first integrand, we have

\end{aligned}

By the spine cancellation property (7.1) we have

Since $\vec{S}^{ \pm}=\vec{S} \pm O(\delta)$, we obtain by the approximation formula valid for $C^{2}$ functions, $f(a+b)+f(a-b)=2 f(a)+O\left(b^{2}\right)$, (with $O\left(b^{2}\right)$ constant depending on $\left.\left\|f^{\prime \prime}\right\|_{L^{\infty}}\right)$ that

& {[\nabla \Gamma(x)-\nabla \Gamma(y)] \theta(x) \theta(y) \mathrm{d} x \mathrm{~d} y } \\
= & B_{11}+B_{12} .
\end{aligned}

We show below that $B_{12}$ is of order $O\left(\delta^{2-\alpha}\right) ; B_{11}$ can be estimated similarly. Integrating by parts the derivative in $\nabla_{x}^{\perp}|x-y|^{-1-\alpha}$ and using the product rule $\nabla^{\perp} \cdot(f V)=\nabla^{\perp} f \cdot V+f \nabla^{\perp} \cdot V$, we are left with only the boundary terms because $\nabla^{\perp} \cdot \nabla \Gamma=0$ and also $\left.\nabla^{\perp} \theta\right|_{x \in(\text { mid })^{c}}=0$. To get the sign on the integration by parts correct, note

=-\sum_{\sigma= \pm 1} \int_{\mathbb{T}} F\left(\vec{S}_{*}^{\sigma}\right) \cdot\left(\partial_{s} \vec{S}_{*}^{\sigma}\right)^{\perp} \sigma \mathrm{d} s_{*}

So as $\theta\left(\vec{S}^{\sigma}\right)=\frac{\sigma}{2}, \nabla^{\perp} \cdot F=\nabla \cdot\left(-F^{\perp}\right)$, and $\left.\nabla \theta\right|_{\partial \text { mid }}=0$, we have the following versions of Divergence Theorem:

We now use a smooth cut-off function $\rho_{\delta}(s)=\rho(s / \delta)$ with $\operatorname{supp} \rho=[-1,1],\left.\rho\right|_{[-1 / 2,1 / 2]}=1$ to split $G(y)$ into two parts,

& +\sum_{\sigma= \pm 1} \int_{\mathbb{T}}\left(1-\rho_{\delta}\left(s-s_{*}\right)\right) \mathcal{G}\left(\vec{S}_{*}^{\sigma}, y\right) \cdot \partial_{s_{*}}\left(\vec{S}_{*}^{\sigma}\right) \mathrm{d} s_{*} \\
= & : G_{1}(y)+G_{2}(y) .

Note the function $\mathcal{G}=\mathcal{G}(x, y)$ defined by the above lines, with $x=\vec{S}_{*}^{\sigma}$. For $G_{1}$, the support in $s_{*}$ of $\rho_{\delta}\left(s-s_{*}\right)$ gives us the required control using
$|\mathcal{G}(x, y)| \lesssim_{\Gamma}|x-y|^{-\alpha}$, so that $\left|\mathcal{G}\left(\vec{S}_{*}^{\sigma}, y\right)\right|=O\left(\left|s_{*}-s\right|^{-\alpha}\right)$. Therefore, we have the bound

& =\sum_{\sigma= \pm 1} \int_{\mathbb{T}}\left(1-\rho_{\delta}\left(s-s_{*}\right)\right)\left(\partial_{s_{*}} \mathcal{G}\left(\vec{S}_{*}^{\sigma}, y\right)+\partial_{s} \mathcal{G}\left(\vec{S}_{*}^{\sigma}, y\right)\right) \cdot \partial_{s_{*}}\left(\vec{S}_{*}^{\sigma}\right) \mathrm{d} s_{*} \\
& +\sum_{\sigma= \pm 1} \int_{\mathbb{T}}\left(1-\rho_{\delta}\left(s-s_{*}\right)\right) \mathcal{G}\left(\vec{S}_{*}^{\sigma}, y\right) \cdot \partial_{s_{*}}^{2}\left(\vec{S}_{*}^{\sigma}\right) \mathrm{d} s_{*}
\end{aligned}
$$

The worst term $\partial_{s_{*}} \mathcal{G}\left(\vec{S}_{*}^{\sigma}, y\right)+\partial_{s} \mathcal{G}\left(\vec{S}_{*}^{\sigma}, y\right)$ is $O\left(\left|s_{*}-s\right|^{-1-\alpha}\right)$, and the cutoff function restricts the integration to the region $\left|s-s_{*}\right| \geq \delta / 2$. Thus, $\partial_{s} G_{2}=O\left(\delta^{-\alpha}\right)$.

The other derivative $\frac{\partial_{\varepsilon}}{\delta} G_{2}(y)$ is simpler since the cutoff $\rho_{\delta}$ does not depend on $\xi$,

Note that $\frac{\partial_{\xi}}{\delta} G_{2,1}(y)=\nabla_{y} G_{2,1}(y) \cdot \frac{\partial_{\xi}}{\delta} y$, and $\frac{\partial_{\xi}}{\delta} y=N=O(1)$; so we have an $O\left(\left|s-s_{*}\right|^{-1-\alpha}\right)$ integrand, integrated on the region $\left|s-s_{*}\right|>\delta / 2$. Hence, $G_{2}(y)=O\left(\delta^{2-\alpha}\right)$, so $B_{11}, B_{12}=O\left(\delta^{2-\alpha}\right)$, and therefore

$$
B_{1}=O\left(\delta^{2-\alpha}\right)
$$

$2 B_{2}(t)$
$=\iint_{(x, y) \in C_{1}} \nabla_{x}^{\perp}|x-y|^{-1-\alpha} \cdot[\nabla \Gamma(x)-\nabla \Gamma(y)] \theta(x) \theta(y) \mathrm{d} x \mathrm{~d} y$

$$
\begin{align*}
= & -\frac{1}{2} \sum_{\sigma= \pm 1} \int_{\mathbb{T}} \int_{\text {mid }} \theta(y)\left|\vec{S}_{*}^{\sigma}-y\right|^{-1-\alpha}\left[\nabla \Gamma\left(\vec{S}_{*}^{\sigma}\right)-\nabla \Gamma(y)\right] \cdot \partial_{s_{*}}\left(\vec{S}_{*}^{\sigma}\right) \mathrm{d} s_{*} \mathrm{~d} y  \tag{7.9}\\
& -\int_{\text {mid }} \underbrace{\left(\int_{\text {mid }}|x-y|^{-1-\alpha}[\nabla \Gamma(x)-\nabla \Gamma(y)] \theta(y) \mathrm{d} y\right)}_{=: Q(x)} \cdot \nabla^{\perp} \theta(x) \mathrm{d} x(7.10)
\end{align*}
$$

Above, the $\nabla_{x}^{\perp}$ never falls on $\nabla \Gamma$ due to $\nabla \cdot \nabla^{\perp}=0$. For (7.9), the singularity is no worse than the one for $B_{1}$ and can be treated in exactly the same way. For (7.10), we aim to use (7.2) of Proposition 7.2, so we need to estimate $\left\|\nabla^{2} Q\right\|_{C^{2}}$. In what follows, we concatenate vectors to denote a tensor e.g. $(U W V)_{i j k}=U_{i} W_{j} V_{k}$, and $\left(\nabla^{2} F\right)_{i j k}=\partial_{i} \partial_{j} F_{k}$. Integrating by parts twice, and introducing the term $r=r(x)$,

$$
\begin{align*}
& \nabla^{2} Q(x)=\int_{\text {mid }} \nabla_{x}^{2}\left(|x-y|^{-1-\alpha}[\nabla \Gamma(x)-\nabla \Gamma(y)]\right) \theta(y) \mathrm{d} y \\
&= \int_{\text {mid }} \nabla_{y}^{2}\left(|x-y|^{-1-\alpha}[\nabla \Gamma(x)-\nabla \Gamma(y)]\right) \theta(y) \mathrm{d} y  \tag{7.11}\\
& \quad+\left(\nabla_{x}^{2}-\nabla_{y}^{2}\right)\left(|x-y|^{-1-\alpha}[\nabla \Gamma(x)-\nabla \Gamma(y)]\right) \\
&= \int_{\partial \text { mid }} \nabla_{y}\left(|x-y|^{-1-\alpha}[\nabla \Gamma(x)-\nabla \Gamma(y)]\right) \theta(y) N_{\text {out }, \partial \text { mid }} \mathrm{d} l(y)  \tag{7.12}\\
& \quad+\int_{\text {mid }} \nabla_{y}\left(|x-y|^{-1-\alpha}[\nabla \Gamma(x)-\nabla \Gamma(y)]\right) \nabla \theta(y) \mathrm{d} y+O\left(|x-y|^{-1-\alpha}\right) \tag{7.13}
\end{align*}
$$

The boundary term (7.12) from integation by parts is

$$
\begin{aligned}
& \int_{\partial \text { mid }} \nabla_{y}\left(|x-y|^{-1-\alpha}[\nabla \Gamma(x)-\nabla \Gamma(y)]\right) \theta(y) N_{\text {out }, \partial \text { mid }} \mathrm{d} s \\
& =\left.\frac{1}{2} \sum_{\sigma= \pm 1} \int_{\mathbb{T}} \nabla_{y}\left(|x-y|^{-1-\alpha}[\nabla \Gamma(x)-\nabla \Gamma(y)]\right)\right|_{y=\vec{S}^{\sigma}}\left(\partial_{s} \vec{S}^{\sigma}\right)^{\perp} \mathrm{d} s
\end{aligned}
$$

For the remaining term in (7.13), we have

$$
\begin{aligned}
& \left|\nabla_{y}\left(|x-y|^{-1-\alpha}[\nabla \Gamma(x)-\nabla \Gamma(y)]\right)\right| \\
& =\left|\frac{(-1-\alpha)(x-y)(\nabla \Gamma(x)-\nabla \Gamma(y))+\nabla^{2} \Gamma(y)|x-y|^{2}}{|x-y|^{3+\alpha}}\right| \\
& =\frac{(1+\alpha)\left|\nabla^{2} \Gamma(x)\right|}{|x-y|^{1+\alpha}}+O\left(|x-y|^{-\alpha}\right) .
\end{aligned}
$$

All of these terms (7.11), (7.12), (7.13) are $O\left(\delta^{-\alpha}\right)$ terms, which can be seen by using the asymptotic lemma A. 1 to compute the $s$ integral
to leading order. For instance, for (7.13), we write out the integral explicitly using the coordinates $y=z\left(s_{*}\right)+\delta \xi_{*} N\left(s_{*}\right), x=z(s)+$ $\delta \xi N(s)$, and the growth condition $|\nabla \theta| \lesssim \frac{1}{\delta}$ from (4.1),

$$
\begin{aligned}
& \left|\int_{\text {mid }} \nabla_{y}\left(|x-y|^{-1-\alpha}[\nabla \Gamma(x)-\nabla \Gamma(y)]\right) \nabla \theta(y) \mathrm{d} y\right| \\
& \leq \frac{1}{\delta}(1+\alpha)\left|\nabla^{2} \Gamma(x)\right| \int_{\xi=f-2}^{f+2} \int_{\mathbb{T}} \frac{\delta L\left(1-\delta \kappa_{*} \xi_{*}\right)}{\left|z-z_{*}+\delta\left(\xi N-\xi_{*} N_{*}\right)\right|^{1+\alpha}} \mathrm{d} s_{*} \mathrm{~d} \xi_{*} \\
& =O\left(\delta^{-\alpha}\right),
\end{aligned}
$$

which follows by applying the asymptotic Lemma A.1. Thus, $\left\|\nabla^{2} Q\right\|_{L^{\infty}}=$ $O\left(\delta^{-\alpha}\right)$, and Proposition 7.2 implies that

$$
\begin{aligned}
2 B_{2}(t) & =\int_{\mathbb{T}}\left(\int_{\operatorname{mid}}|\vec{S}-y|^{-1-\alpha}[\nabla \Gamma(\vec{S})-\nabla \Gamma(y)] \theta(y) \mathrm{d} y\right) \cdot \partial_{s} \vec{S} \mathrm{~d} s \\
& +O\left(\delta^{2-\alpha}\right)
\end{aligned}
$$

Reversing the order of integration and using the tubular coordinates we notice we can again use the spine condition (7.1) to bring out an extra cancellation. That is, defining $H$ by

$$
H\left(y_{*}\right):=\int_{\mathbb{T}}\left|\vec{S}-y_{*}\right|^{-1-\alpha}\left[\nabla \Gamma(\vec{S})-\nabla \Gamma\left(y_{*}\right)\right] \cdot \partial_{s} \vec{S} \mathrm{~d} s
$$

we deduce that

$$
\begin{aligned}
2 B_{2}(t) & =\int_{f-2}^{f+2} \int_{\mathbb{T}} H\left(y_{*}\right) \Omega_{*} \delta L_{1 *} \mathrm{~d} s_{*} \mathrm{~d} \xi_{*}+O\left(\delta^{2-\alpha}\right) \\
& =\delta \int_{f-2}^{f+2} \int_{\mathbb{T}} \Omega_{*} H\left(y_{*}\right) L \mathrm{~d} s_{*} \mathrm{~d} \xi_{*}+O\left(\delta^{2-\alpha}\right) \\
& =\delta \int_{f-2}^{f+2} \int_{\mathbb{T}} \Omega_{*}\left(H\left(y_{*}\right)-H\left(\vec{S}_{*}\right)\right) L \mathrm{~d} s_{*} \mathrm{~d} \xi_{*}+O\left(\delta^{2-\alpha}\right) \\
& =O\left(\delta^{2-\alpha}\right) .
\end{aligned}
$$

The final term to estimate is

$$
B_{0}(t)=\int_{(\operatorname{mid})^{c}} \int_{(\operatorname{mid})^{c}} \nabla_{x}^{\perp}|x-y|^{-1-\alpha} \cdot \nabla \Gamma(x) \theta(x) \theta(y) \mathrm{d} x \mathrm{~d} y .
$$

We use both gradients appearing in $B_{0}$ to integrate by parts (via the formulas $(7.8),(7.7)$ ), on which we obtain only boundary terms due to either of the two cancellations $\nabla^{\perp} \cdot \nabla=0$ or $\left.\nabla \theta\right|_{\partial \text { mid }}=0$ :

& =\int_{(\operatorname{mid})^{c}} \int_{(\operatorname{mid})^{c}} \nabla_{x}^{\perp}|x-y|^{-1-\alpha} \cdot \nabla \Gamma(x) \theta(x) \theta(y) \mathrm{d} x \mathrm{~d} y
\end{aligned}
$$

$$
\begin{aligned}
& =-\left.\frac{1}{2} \sum_{\sigma_{1}= \pm 1} \int_{(\text {mid })^{c}} \int_{\mathbb{T}} \nabla_{x}^{\perp}|x-y|^{-1-\alpha}\right|_{x=\vec{S}^{\sigma_{1}}} \cdot\left(\partial_{s} \vec{S}^{\sigma_{1}}\right)^{\perp} \Gamma\left(\vec{S}^{\sigma_{1}}\right) \theta(y) \mathrm{d} s \mathrm{~d} y \\
& =\frac{1}{2} \sum_{\sigma_{1}= \pm 1} \int_{(\text {mid })^{c}} \int_{\mathbb{T}} \nabla_{y}^{\perp}\left|\vec{S}^{\sigma_{1}}-y\right|^{-1-\alpha} \cdot\left(\partial_{s} \vec{S}^{\sigma_{1}}\right)^{\perp} \Gamma\left(\vec{S}^{\sigma_{1}}\right) \theta(y) \mathrm{d} s \mathrm{~d} y \\
& =\frac{1}{4} \sum_{\sigma_{1}= \pm 1} \sum_{\sigma_{2}= \pm 1} \int_{\mathbb{T}} \int_{\mathbb{T}}\left|\vec{S}^{\sigma_{1}}-\vec{S}_{*}^{\sigma_{2}}\right|^{-1-\alpha} \cdot\left(\partial_{s} \vec{S}^{\sigma_{1}}\right)^{\perp} \cdot \partial_{s} \vec{S}_{*}^{\sigma_{2}} \Gamma\left(\vec{S}^{\sigma_{1}}\right) \mathrm{d} s \mathrm{~d} s_{*} \\
& =-\frac{1}{4} \sum_{\sigma_{1}= \pm 1} \sum_{\sigma_{2}= \pm 1} \int_{\mathbb{T}} \int_{\mathbb{T}}\left|\vec{S}^{\sigma_{1}}-\vec{S}_{*}^{\sigma_{2}}\right|^{-1-\alpha} \partial_{s} \vec{S}^{\sigma_{1}} \cdot\left[\partial_{s} \vec{S}_{*}^{\sigma_{2}}\right]^{\perp} \Gamma\left(\vec{S}^{\sigma_{1}}\right) \mathrm{d} s \mathrm{~d} s_{*}
\end{aligned}
$$

This sum of four terms will now be regrouped into two terms $B_{0}(t)=$ $B_{00}(t)+B_{01}(t)$, one where $\sigma_{1}=\sigma_{2}$ and one where $\sigma_{1}=-\sigma_{2}$,

$$
\begin{aligned}
& B_{00}(t)=-\frac{1}{4} \sum_{\sigma= \pm 1} \int_{\mathbb{T}} \int_{\mathbb{T}}\left|\vec{S}^{\sigma}-\left[\vec{S}^{\sigma}\right]_{*}\right|^{-1-\alpha} \partial_{s} \vec{S}^{\sigma} \cdot\left[\partial_{s} \vec{S}^{\sigma}\right]_{*}^{\perp} \Gamma\left(\vec{S}^{\sigma}\right) \mathrm{d} s \mathrm{~d} s_{*} \\
& B_{01}(t)=-\frac{1}{4} \sum_{\sigma= \pm 1} \int_{\mathbb{T}} \int_{\mathbb{T}}\left|\vec{S}^{\sigma}-\left[\vec{S}^{-\sigma}\right]_{*}\right|^{-1-\alpha} \partial_{s} \vec{S}^{\sigma} \cdot\left[\partial_{s} \vec{S}^{-\sigma}\right]_{*}^{\perp} \Gamma\left(\overrightarrow{S^{\sigma}}\right) \mathrm{d} s \mathrm{~d} s_{*}
\end{aligned}
$$

For $B_{00}(t)$, we can use the formula $f(a+b)+f(a-b)=2 f(a)+O\left(b^{2}\right)$ to get that

$$
B_{00}(t)=-\frac{1}{2} \int_{\mathbb{T}} \int_{\mathbb{T}} \frac{\partial_{s} \vec{S} \cdot \partial_{s} \vec{S}_{*}^{\perp}}{\left|\vec{S}-\vec{S}_{*}\right|^{1+\alpha}} \Gamma(\vec{S}) \mathrm{d} s \mathrm{~d} s_{*}+O\left(\delta^{2}\right)
$$

Treating $B_{01}(t)=: \mathcal{B}(\delta)$ as a function of $\delta$, we need to prove that

$$
\mathcal{B}(\delta)=\mathcal{B}(0)+O\left(\delta^{2-\alpha}\right)
$$

since $\mathcal{B}(0)=-\frac{1}{2} \int_{\mathbb{T}} \int_{\mathbb{T}} \frac{\partial_{s} \vec{S} \cdot \partial_{s} \vec{S}_{*}^{\perp}}{\left|\vec{S}-\vec{S}_{*}\right|^{1+\alpha}} \Gamma(\vec{S}) \mathrm{d} s \mathrm{~d} s_{*}$ with $B_{00}(t)$ gives the required evolution term:

$$
B_{00}(t)+\mathcal{B}(0)=\int_{\mathbb{T}}\left(\int_{\mathbb{T}} \frac{\partial_{s} \vec{S}_{*}-\partial_{s} \vec{S}}{\left|\vec{S}-\vec{S}_{*}\right|^{1+\alpha}} \mathrm{d} s_{*}\right) \cdot \partial_{s} \vec{S}^{\perp} \Gamma(\vec{S}) \mathrm{d} s+O\left(\delta^{2}\right)
$$

Symmetrizing as before, we obtain

$$
\mathcal{B}(\delta)=-\frac{1}{8} \sum_{\sigma= \pm 1} \int_{\mathbb{T}} \int_{\mathbb{T}} \frac{\partial_{s} \vec{S}^{\sigma} \cdot\left[\partial_{s} \vec{S}^{-\sigma}\right]_{*}^{\perp}}{\left|\vec{S}^{\sigma}-\left[\vec{S}^{-\sigma}\right]_{*}\right|^{1+\alpha}}\left(\Gamma\left(\vec{S}^{\sigma}\right)-\Gamma\left(\left[\vec{S}^{-\sigma}\right]_{*}\right)\right) \mathrm{d} s \mathrm{~d} s_{*}
$$

Since (7.5) involves test functions supported on the curve $\vec{S}$, we may assume that $\Gamma$ does not depend on $\xi$ on a $\delta$ neighbourhood of $\vec{S}$, giving

$$
\mathcal{B}(\delta)=-\frac{1}{8} \sum_{\sigma= \pm 1} \int_{\mathbb{T}} \int_{\mathbb{T}} \frac{\partial_{s} \vec{S}^{\sigma} \cdot\left[\partial_{s} \vec{S}^{-\sigma}\right]_{*}^{\perp}}{\left|\vec{S}^{\sigma}-\left[\vec{S}^{-\sigma}\right]_{*}\right|^{1+\alpha}}\left(\Gamma(\vec{S})-\Gamma\left(\vec{S}_{*}\right)\right) \mathrm{d} s \mathrm{~d} s_{*}
$$

Note that $\mathcal{B}(0)$ has the well-behaved $O\left(\left|s-s_{*}\right|^{1-\alpha}\right)$ integrand. Recalling that $\mathcal{B}^{\prime}(\tilde{\delta})=\frac{\mathcal{B}(\delta)-\mathcal{B}(0)}{\delta}$ for some $\tilde{\delta} \in(0, \delta)$, it suffices to prove that

$$
\mathcal{B}^{\prime}(\delta) \stackrel{?}{=} O\left(\delta^{1-\alpha}\right)
$$

since $s \mapsto s^{1-\alpha}$ is increasing for $0<s$. On differentiation with respect to $\delta$, a factor of $\sigma$ appears, which means the sum over $\sigma= \pm 1$ becomes a symmetric difference. We expand the shorthand notation $\partial_{s} \vec{S}^{\sigma} \cdot\left[\partial_{s} \vec{S}^{-\sigma}\right]_{*}^{\perp}$ to find the derivative in $\delta$,

$$
\partial_{s} \vec{S}^{\sigma} \cdot\left[\partial_{s} \vec{S}^{-\sigma}\right]_{*}^{\perp}=\partial_{s} \vec{S} \cdot \partial_{s} \vec{S}_{*}^{\perp}+\sigma \delta\left(\partial_{s} \vec{S} \cdot T_{*}+T \cdot \partial_{s} \vec{S}_{*}\right)+O\left(\delta^{2}\right) .
$$

Hence, its $\delta$-derivative is some bounded function, say $E\left(s, s_{*}\right)$. When $\partial_{\delta}$ hits the kernel $\left|\vec{S}^{\sigma}-\left[\vec{S}^{-\sigma}\right]_{*}\right|^{-1-\alpha}$, we have

$$
\begin{aligned}
& \partial_{\delta}\left|\vec{S}^{\sigma}-\left[\vec{S}^{-\sigma}\right]_{*}\right|^{-1-\alpha} \\
& =(-1-\alpha)\left|\vec{S}^{\sigma}-\left[\vec{S}^{-\sigma}\right]_{*}\right|^{-3-\alpha}\left(\vec{S}^{\sigma}-\left[\vec{S}^{-\sigma}\right]_{*}\right) \cdot \partial_{\delta}\left(\vec{S}^{\sigma}-\left[\vec{S}^{-\sigma}\right]_{*}\right) \\
& =(-1-\alpha)\left|\vec{S}^{\sigma}-\left[\vec{S}^{-\sigma}\right]_{*}\right|^{-3-\alpha}\left[\left(\vec{S}-\vec{S}_{*}\right) \cdot \sigma\left(N+N_{*}\right)+O(\delta)\right] .
\end{aligned}
$$

With the cancellation from the symmetrisation in $\Gamma$, we see that we have

$$
\begin{aligned}
& -8 \mathcal{B}^{\prime}(\delta)=\sum_{\sigma= \pm 1} \sigma \int_{\mathbb{T}} \int_{\mathbb{T}}\left|\vec{S}^{\sigma}-\left[\vec{S}^{-\sigma}\right]_{*}\right|^{-1-\alpha}\left(\Gamma(\vec{S})-\Gamma\left(\vec{S}_{*}\right)\right) \times \\
& \quad\left(E\left(s, s_{*}\right)+(-1-\alpha) \partial_{s} \vec{S} \cdot\left[\partial_{s} \vec{S}_{*}^{\perp} \frac{\vec{S}^{\sigma}-\left[\vec{S}^{-\sigma}\right]_{*}}{\left|\vec{S}^{\sigma}-\left[\overrightarrow{S^{-\sigma}}\right]_{*}\right|^{2}}\right) \mathrm{d} s \mathrm{~d} s_{*}+O(\delta) .\right.
\end{aligned}
$$

The factor of $\sigma$ means that we can use the Mean Value Theorem in the form $f(x+\delta)-f(x-\delta)=O(\delta)$ to obtain that actually $\mathcal{B}^{\prime}(\delta)=O(\delta)$, which finally implies the result.

## Appendix A. Asymptotic for a parameterised integral

Lemma A.1. Let $\alpha \in(0,1)$ and $\mathbb{T}:=\mathbb{R} / \mathbb{Z}$. For $\tau>0$, let $I=I(\tau)$ denote the following family of integrals,

$$
I=\int_{s \in \mathbb{T}} \frac{a(s)}{\left|g(s)+\tau^{2}\right|^{(1+\alpha) / 2}} \mathrm{~d} s
$$

where $a=a(s), g=g(s) \in C^{\infty}(\mathbb{T})$ and $g$ has 0 as its unique global minimum at $s=0$ that is non-degenerate, i.e. $g^{\prime \prime}(0)>0, \quad \operatorname{argmin} g=$ $0, \quad g(0)=\min g=0$. Then we have the asymptotic relation as $\tau \rightarrow 0$,

$$
\begin{aligned}
I & =\frac{a(0)}{G} C_{\alpha} \tau^{-\alpha}-\frac{a(0)\left(\alpha^{-1} 2^{1+\alpha}+b_{\alpha}\right)}{G^{1+\alpha}} \\
& +\int_{s \in \mathbb{T}} \frac{a(s)}{|g(s)|^{(1+\alpha) / 2}}-\frac{a(0)}{G^{1+\alpha}|\operatorname{Sin} s|^{1+\alpha}} \mathrm{d} s+O\left(\tau^{2-\alpha}\right), \quad(\tau \rightarrow 0),
\end{aligned}
$$

where:
(1) $\operatorname{Sin} s:=\sin (\pi s) / \pi$,
(2) $C_{\alpha}$ is the constant $C_{\alpha}=\frac{\sqrt{\pi \Gamma\left(\frac{\alpha}{2}\right)}}{\Gamma\left(\frac{\alpha+1}{2}\right)}<\infty$ (which diverges as $\alpha \rightarrow 0$ ),
(3) $b_{\alpha}$ is the constant $b_{\alpha}:=\int_{-1 / 2}^{1 / 2}\left(\frac{1}{|s|^{1+\alpha}}-\frac{1}{|\operatorname{Sin} s|^{1+\alpha}}\right) \mathrm{d} s<\infty$,
(4) $G$ is the constant $G:=\sqrt{g^{\prime \prime}(0) / 2}$, and
(5) the $O\left(\tau^{2-\alpha}\right)$ constant depends on $W^{3, \infty}$ norms of $a$ and $g$.

Proof. The proof for the case $\alpha=0$ can be found in [7]. We take $(-1 / 2,1 / 2)$ as a fundamental domain for $\mathbb{T}$. We split $I=I_{\text {near }}+I_{\text {far }}$ into an integral $I_{\text {near }}$ around the minimiser of $g$ and $I_{\text {far }}$ on the complement,

$$
\begin{align*}
A_{\text {near }}:=\left(s_{-}, s_{+}\right), & I_{\text {near }}:=\int_{A_{\text {near }}} \frac{a(s)}{\left|g(s)+\tau^{2}\right|^{(1+\alpha) / 2}} \mathrm{~d} s \\
A_{\text {far }}:=\mathbb{T} \backslash A_{\text {near }}, & I_{\text {far }}:=\int_{A_{\text {far }}} \frac{a(s)}{\left|g(s)+\tau^{2}\right|^{(1+\alpha) / 2}} \mathrm{~d} s \tag{A.1}
\end{align*}
$$

where $s_{ \pm}$are chosen (depending on $g$ ) sufficiently close to 0 so that we can choose new coordinates $\sigma$ such that $g(s)=\sigma^{2}$, and that $g\left(s_{-}\right)=$ $g\left(s_{+}\right)=: \sigma_{0}^{2} \ll 1$. Also define $\bar{a}(\sigma)$ so that $\bar{a}(\sigma) \mathrm{d} \sigma=a(s) \mathrm{d} s$ in the integral. Thus $I_{\text {near }}=\int_{-\sigma_{0}}^{\sigma_{0}} \frac{\bar{a}(\sigma)}{\left|\sigma^{2}+\tau^{2}\right|(1+\alpha) / 2} \mathrm{~d} \sigma=I_{\text {near }, 1}+I_{\text {near }, 2}+I_{\text {near }, 3}$, where

$$
\begin{aligned}
& I_{\text {near }, 1}=\bar{a}(0) \int_{-\sigma_{0}}^{\sigma_{0}} \frac{1}{\left|\sigma^{2}+\tau^{2}\right|^{(1+\alpha) / 2}} \mathrm{~d} \sigma, \quad I_{\text {near }, 2}=\int_{-\sigma_{0}}^{\sigma_{0}} \frac{\bar{a}(\sigma)-\bar{a}(0)}{|\sigma|^{1+\alpha}} \mathrm{d} \sigma \\
& I_{\text {near }, 3}=\int_{-\sigma_{0}}^{\sigma_{0}}\left(\bar{a}(\sigma)-\bar{a}(0)-\bar{a}^{\prime}(0) \sigma\right)\left(\frac{1}{\left|\sigma^{2}+\tau^{2}\right|^{(1+\alpha) / 2}}-\frac{1}{|\sigma|^{1+\alpha}}\right) \mathrm{d} \sigma .
\end{aligned}
$$

By the regularity of $\bar{a}$, these integrals are well-defined. $I_{\text {near }, 1}$ is the only term that appears for a constant function $\bar{a} \equiv \bar{a}(0)$. $I_{\text {near }, 2}$ is bounded independent of $\tau . I_{\text {near,3 }}$ can easily be seen to be $O\left(\tau^{2-\alpha}\right)$ using

$$
\left|\frac{1}{\left|\sigma^{2}+\tau^{2}\right|^{(1+\alpha) / 2}}-\frac{1}{\sigma^{1+\alpha}}\right| \leq \begin{cases}2 \sigma^{-1-\alpha} & |\sigma| \leq \tau \\ \tau^{2} \sigma^{-3-\alpha} & |\sigma|>\tau\end{cases}
$$

The first bound follows from the triangle inequality and $\frac{1}{\left|\sigma^{2}+\tau^{2}\right|^{(1+\alpha) / 2}} \leq$ $\frac{1}{|\sigma|^{1+\alpha}}$; the second bound follows from $\frac{1+\alpha}{2}<1$ and the Mean Value Theorem applied to $f(x)=x^{-(1+\alpha) / 2}$, i.e. for some $\theta \in(0,1)$,

$$
\begin{equation*}
f(x+h)-f(x)=f^{\prime}(x+\theta h) h=-\left(\frac{1+\alpha}{2}\right) \frac{h}{|x+\theta h|^{(3+\alpha) / 2}} \tag{A.2}
\end{equation*}
$$

with $x=\sigma^{2}, h=\tau^{2}$, and $|x+\theta h|^{-(3+\alpha) / 2} \leq|x|^{-(3+\alpha) / 2}$. This implies

$$
\left|I_{\text {near }, 3}\right| \lesssim\left\|a^{\prime \prime}\right\|_{L^{\infty}} \int_{-\tau}^{\tau} 2 \sigma^{2-1-\alpha} \mathrm{d} \sigma+\int_{\tau \leq|\sigma| \leq \sigma_{0}} \tau^{2} \sigma^{2-3-\alpha} \mathrm{d} \sigma=O\left(\tau^{2-\alpha}\right)
$$

We focus now on $I_{\text {near }, 1}$. Define

$$
J:=\int_{-\sigma_{0}}^{\sigma_{0}} \frac{1}{\left|\sigma^{2}+\tau^{2}\right|^{(1+\alpha) / 2}} \mathrm{~d} \sigma=2 \tau^{-\alpha} \int_{0}^{\sigma_{0} / \tau} \frac{1}{\left|\sigma^{2}+1\right|^{(1+\alpha) / 2}} \mathrm{~d} \sigma
$$

In contrast with the $\alpha=0$ case, the integrand is in $L^{1}(\mathbb{R})$, so we can easily write down the following expression with an error term,

$$
\begin{aligned}
J & =2 \tau^{-\alpha}\left(\int_{0}^{\infty} \frac{\mathrm{d} \sigma}{\left|\sigma^{2}+1\right|^{(1+\alpha) / 2}}-\int_{\sigma_{0} / \tau}^{\infty} \frac{\mathrm{d} \sigma}{\left|\sigma^{2}+1\right|^{(1+\alpha) / 2}}\right) \\
& =2 \tau^{-\alpha}\left(\int_{0}^{\infty} \frac{\mathrm{d} \sigma}{\left|\sigma^{2}+1\right|^{(1+\alpha) / 2}}-\int_{\sigma_{0} / \tau}^{\infty} \frac{\mathrm{d} \sigma}{\sigma^{1+\alpha}}\right) \\
& +\int_{\sigma_{0} / \tau}^{\infty} \frac{1}{\sigma^{1+\alpha}}-\frac{1}{\left|\sigma^{2}+1\right|^{(1+\alpha) / 2}} \mathrm{~d} \sigma=C_{\alpha} \tau^{-\alpha}-\frac{2}{\alpha \sigma_{0}^{\alpha}}+\text { Rem }
\end{aligned}
$$

where $C_{\alpha}=\int_{\mathbb{R}} \frac{\mathrm{d} \sigma}{\left|\sigma^{2}+1\right|^{(1+\alpha) / 2}}=\frac{\sqrt{\pi} \Gamma\left(\frac{\alpha}{2}\right)}{\Gamma\left(\frac{\alpha+1}{2}\right)}<\infty$ and the remainder term Rem satisfies (using (A.2) with $x=\sigma^{2}, h=1$ )

$$
|\operatorname{Rem}| \leq 2 \tau^{-\alpha} \int_{\sigma_{0} / \tau}^{\infty} \frac{\mathrm{d} \sigma}{\sigma^{3+\alpha}}=2 \tau^{-\alpha} \frac{\tau^{2+\alpha}}{(2+\alpha) \sigma_{0}^{2+\alpha}}=O\left(\tau^{2}\right), \quad \tau \rightarrow 0
$$

Hence we have that $J=C_{\alpha} \tau^{-\alpha}-\frac{2}{\alpha \sigma_{0}^{\alpha}}+O\left(\tau^{2}\right)$ as $\tau \rightarrow 0$.
Recall the transformation's defining equation $g(s)=\sigma^{2}$. We can write $g(s)=g^{\prime \prime}(0) s^{2} / 2+O\left(s^{3}\right)$ since $s=0$ is a global nondegenerate minimum of $g$ with $g(0)=0$. Hence for $\sigma>0$ (and therefore $s>0$ ), $\sigma=s \sqrt{g^{\prime \prime}(0) / 2+O(s)}=s \sqrt{g^{\prime \prime}(0) / 2}+O\left(s^{2}\right)$ as $s \rightarrow 0^{+}$, by the differentiability in $h$ of $\sqrt{g^{\prime \prime}(0) / 2+h}$. The case $\sigma<0$ is treated similarly, leading to

$$
\sigma=\sqrt{g(s)}=\sqrt{\frac{g^{\prime \prime}(0)}{2}} s+O\left(s^{2}\right), \quad s \rightarrow 0
$$

and hence $\frac{\mathrm{d} \sigma}{\mathrm{d} s} \underset{s \rightarrow 0}{\longrightarrow} \sqrt{\frac{g^{\prime \prime}(0)}{2}}$. Below, we use $G:=\sqrt{\frac{g^{\prime \prime}(0)}{2}}$. Since $a(s)=$ $\frac{\mathrm{d} \sigma}{\mathrm{d} s} \bar{a}(\sigma)$ we have $\bar{a}(0)=a(0) / G$, which allows us to rewrite $I_{\text {near }, 1}$,

$$
I_{\text {near }, 1}=\frac{a(0)}{G} C_{\alpha} \tau^{-\alpha}-2 \frac{a(0)}{\alpha G \sigma_{0}^{\alpha}}+O\left(\tau^{2}\right), \quad \tau \rightarrow 0
$$

Let us now treat $I_{\text {near, } 2}$. Let $0<\sigma_{1} \ll \sigma_{0}$, and let $s_{1-}<0, s_{1+}>0$ be the two unique numbers such that $g\left(s_{1 \pm}\right)=\sigma_{1}^{2}$. Since $\bar{a}(\sigma) \mathrm{d} \sigma=$ $a(s) \mathrm{d} s$, it is clear that $\frac{\bar{a}(\sigma) \mathrm{d} \sigma}{|\sigma|^{1+\alpha}}=\frac{a(s) \mathrm{ds} s}{g(s)^{(1+\alpha) / 2}}$. Hence, we only need to rewrite the other term of the difference $\frac{(\bar{a}(\sigma)-\bar{a}(0)) \mathrm{d} \sigma}{|\sigma|^{1+\alpha}}$, which is $\bar{a}(0) \int_{\sigma_{1}}^{\sigma_{0}} \frac{\mathrm{~d} \sigma}{\sigma^{1+\alpha}}$. We would like to replace the integral in $\sigma$ with an integral in $s$. Observe that as $0<\sigma_{1}<\sigma_{0}$ and $0<s_{1+}<s_{+}$,

$$
\int_{\sigma_{1}}^{\sigma_{0}} \frac{\mathrm{~d} \sigma}{\sigma^{1+\alpha}}=\frac{1}{\alpha}\left(\frac{1}{\sigma_{1}^{\alpha}}-\frac{1}{\sigma_{0}^{\alpha}}\right), \text { and } \int_{s_{1+}}^{s_{+}} \frac{\mathrm{d} s}{s^{1+\alpha}}=\frac{1}{\alpha}\left(\frac{1}{s_{1+}^{\alpha}}-\frac{1}{s_{+}^{\alpha}}\right) .
$$

Thus, we have the following equality for any constant $\tilde{C}$,

$$
\int_{\sigma_{1}}^{\sigma_{0}} \frac{\mathrm{~d} \sigma}{\sigma^{1+\alpha}}=\tilde{C} \int_{s_{1+}}^{s_{+}} \frac{\mathrm{d} s}{s^{1+\alpha}}+\frac{1}{\alpha}(\underbrace{\frac{1}{\sigma_{1}^{\alpha}}-\frac{\tilde{C}}{s_{1+}^{\alpha}}}_{\star}+\frac{\tilde{C}}{s_{+}^{\alpha}}-\frac{1}{\sigma_{0}^{\alpha}}) .
$$

Treating $s$ as a function $s=s(\sigma)$, the Inverse Function Theorem gives the asymptotic $s=G^{-1} \sigma+O\left(\sigma^{2}\right)$ for $\sigma \ll 1$. Setting $\tilde{C}=G^{-\alpha}$, as then the terms marked with a star $\star$ become error terms for $\sigma_{1} \ll 1$,

$$
\star=\frac{1}{\sigma_{1}^{\alpha}}-\frac{1}{\left(G s_{1+}\right)^{\alpha}}=\frac{1}{\sigma_{1}^{\alpha}}-\frac{1}{\left(\sigma_{1}+O\left(\sigma_{1}^{2}\right)\right)^{\alpha}} \leq \frac{2 O\left(\sigma_{1}^{2}\right)}{\alpha \sigma_{1}^{1+\alpha}}=O\left(\sigma_{1}^{1-\alpha}\right)
$$

We can do a similar analysis for the integral $\int_{-\sigma_{0}}^{-\sigma_{1}} \frac{\mathrm{~d} \sigma}{|\sigma|^{1+\alpha}}$, yielding

$$
\int_{-\sigma_{0}}^{-\sigma_{1}} \frac{\mathrm{~d} \sigma}{|\sigma|^{1+\alpha}}=\frac{1}{G^{\alpha}} \int_{s_{-}}^{s_{1-}} \frac{\mathrm{d} s}{|s|^{1+\alpha}}+\frac{1}{\alpha}(\underbrace{\frac{1}{\sigma_{1}^{\alpha}}-\frac{1}{\left|G s_{1-}\right|^{\alpha}}}_{=O\left(\sigma_{1}^{1-\alpha}\right)}+\frac{1}{\left|G s_{-}\right|^{\alpha}}-\frac{1}{\sigma_{0}^{\alpha}})
$$

which together yield (as $\int_{-\sigma_{0}}^{-\sigma_{1}} \frac{\mathrm{~d} \sigma}{|\sigma|^{1+\alpha}}=\int_{\sigma_{1}}^{\sigma_{0}} \frac{\mathrm{~d} \sigma}{|\sigma|^{1+\alpha}}$ )

$$
\begin{aligned}
2 \int_{\sigma_{0}}^{\sigma_{1}} \frac{\mathrm{~d} \sigma}{|\sigma|^{1+\alpha}}= & \int_{s_{1}+}^{s_{+}} \frac{\mathrm{d} s}{G^{\alpha}|s|^{1+\alpha}}+\int_{s_{-}}^{s_{1-}} \frac{\mathrm{d} s}{G^{\alpha}|s|^{1+\alpha}} \\
& +\frac{1}{\alpha}\left(\frac{1}{\left|G s_{+}\right|^{\alpha}}+\frac{1}{\left|G s_{-}\right|^{\alpha}}-\frac{2}{\left|\sigma_{0}\right|^{\alpha}}\right)+O\left(\sigma_{1}^{1-\alpha}\right) .
\end{aligned}
$$

Hence, we rewrite $I_{\text {near,2 }}$ as follows,

$$
I_{\text {near }, 2}=\int_{-\sigma_{0}}^{\sigma_{0}} \frac{\bar{a}(\sigma)-\bar{a}(0)}{|\sigma|^{1+\alpha}} \mathrm{d} \sigma
$$

$$
\begin{align*}
= & \lim _{\sigma_{1} \rightarrow 0}\left(\int_{\sigma_{1}}^{\sigma_{0}} \frac{\bar{a}(\sigma)}{|\sigma|^{1+\alpha}} \mathrm{d} \sigma+\int_{-\sigma_{0}}^{-\sigma_{1}} \frac{\bar{a}(\sigma)}{|\sigma|^{1+\alpha}} \mathrm{d} \sigma-2 \int_{\sigma_{1}}^{\sigma_{0}} \frac{\bar{a}(0)}{|\sigma|^{1+\alpha}} \mathrm{d} \sigma\right) \\
= & \lim _{\sigma_{1} \rightarrow 0}\left(\int_{s_{1+}}^{s_{+}} \frac{a(s)}{|g(s)|^{1+\alpha}}-\frac{a(0)}{G^{1+\alpha}|s|^{1+\alpha}} \mathrm{d} s\right. \\
& \left.+\int_{s_{-}}^{s_{1-}} \frac{a(s)}{|g(s)|^{1+\alpha}}-\frac{a(0)}{G^{1+\alpha}|s|^{1+\alpha}} \mathrm{d} s+O\left(\sigma_{1}^{1-\alpha}\right)\right) \\
& -\frac{a(0)}{\alpha G^{1+\alpha} s_{+}^{\alpha}}-\frac{a(0)}{\alpha G^{1+\alpha}\left|s_{-}\right|^{\alpha}}+2 \frac{a(0)}{\alpha G \sigma_{0}^{\alpha}} \\
= & \int_{s_{-}}^{s_{+}} \frac{a(s)}{|g(s)|^{1+\alpha}}-\frac{a(0)}{G^{1+\alpha}|s|^{1+\alpha}} \mathrm{d} s \\
& -\frac{a(0)}{\alpha G^{1+\alpha} s_{+}^{\alpha}}-\frac{a(0)}{\alpha G^{1+\alpha}\left|s_{-}\right|^{\alpha}}+2 \frac{a(0)}{\alpha G \sigma_{0}^{\alpha}} .+O\left(\sigma_{1}^{1-\alpha}\right) . \tag{A.3}
\end{align*}
$$

The term $2 \frac{a(0)}{\alpha G \sigma_{0}^{\alpha}}$ here in (A.3) exactly cancels with the term with $-2 \frac{a(0)}{\alpha G \sigma_{0}^{\alpha}}$ in the equation (A.4) for $I_{\text {near }, 1}$. We therefore can write $I_{\text {near }}$ as follows,

$$
\begin{align*}
I_{\text {near }}= & \frac{a(0)}{G} C_{\alpha} \tau^{-\alpha}+\int_{s_{-}}^{s_{+}} \frac{a(s)}{|g(s)|^{1+\alpha}}-\frac{a(0)}{G^{1+\alpha}|s|^{1+\alpha}} \mathrm{d} s \\
& -\frac{a(0)}{\alpha G^{1+\alpha} s_{+}^{\alpha}}-\frac{a(0)}{\alpha G^{1+\alpha}\left|s_{-}\right|^{\alpha}}+O\left(\tau^{2-\alpha}\right), \quad \tau \rightarrow 0 . \tag{A.4}
\end{align*}
$$

To finish, we need to include $I_{\text {far }}$. Recall from (A.1) that $A_{\text {far }}=\mathbb{T} \backslash$ $\left(s_{-}, s_{+}\right)$. Note that with $s_{ \pm}$fixed, $g(s)^{-(1+\alpha) / 2}$ is $L_{s}^{\infty}\left(A_{\text {far }}\right)$, and the following error estimate holds, since $\frac{a(s)}{\left|g(s)+\tau^{2}\right|^{(1+\alpha) / 2}}$ is smooth in $\tau \ll 1$ :

$$
\int_{A_{\mathrm{far}}} \frac{a(s) \mathrm{d} s}{\left|g(s)+\tau^{2}\right|^{(1+\alpha) / 2}}=\int_{A_{\mathrm{far}}} \frac{a(s) \mathrm{d} s}{|g(s)|^{(1+\alpha) / 2}}+O\left(\tau^{2}\right) .
$$

Since $\int_{A_{\mathrm{far}}} \frac{\mathrm{d} s}{|s|^{1+\alpha}}=\left(\int_{-1 / 2}^{s_{-}}+\int_{s_{+}}^{1 / 2}\right) \frac{\mathrm{d} s}{|s|^{1+\alpha}}=\frac{-2^{1+\alpha}}{\alpha}+\frac{1}{\alpha s_{+}^{\alpha}}+\frac{1}{\alpha\left|s_{-}\right|^{\alpha}}$, We have

$$
\begin{align*}
I_{\mathrm{far}}= & \int_{A_{\mathrm{far}}} \frac{a(s)}{|g(s)|^{(1+\alpha) / 2}}-\frac{a(0)}{G^{1+\alpha}|s|^{1+\alpha}} \mathrm{d} s+\frac{a(0)}{G^{1+\alpha}} \int_{A_{\mathrm{far}}} \frac{1}{|s|^{1+\alpha}} \mathrm{d} s+O\left(\tau^{2}\right) \\
= & \int_{A_{\mathrm{far}}} \frac{a(s)}{|g(s)|^{(1+\alpha) / 2}}-\frac{a(0)}{G^{1+\alpha}|s|^{1+\alpha}} \mathrm{d} s \\
& \frac{-2^{1+\alpha} a(0)}{\alpha G^{1+\alpha}}+\frac{a(0)}{\alpha G^{1+\alpha} s_{+}^{\alpha}}+\frac{a(0)}{\alpha G^{1+\alpha}\left|s_{-}\right|^{\alpha}}+O\left(\tau^{2}\right) . \tag{A.5}
\end{align*}
$$

The terms $\frac{a(0)}{\alpha G^{1+\alpha} s_{+}^{\alpha}}+\frac{a(0)}{\alpha G^{1+\alpha}\left|s_{-}\right|^{\alpha}}$ in (A.5) cancel $-\frac{a(0)}{\alpha G^{1+\alpha} s_{+}^{\alpha}}-\frac{a(0)}{\alpha G^{1+\alpha}\left|s_{-}\right|^{\alpha}}$ in (A.4), leaving an expression that does not depend on $s_{ \pm}$. Therefore,

$$
\begin{aligned}
I & =\frac{a(0)}{G} C_{\alpha} \tau^{-\alpha}-\frac{2^{1+\alpha} a(0)}{\alpha G^{1+\alpha}} \\
& +\int_{-1 / 2}^{1 / 2} \frac{a(s)}{|g(s)|^{(1+\alpha) / 2}}-\frac{a(0)}{G^{1+\alpha}|s|^{1+\alpha}} \mathrm{d} s+O\left(\tau^{2-\alpha}\right), \quad \tau \rightarrow 0
\end{aligned}
$$

Since $a, g$ are 1-periodic functions, we rewrite this with the constant $b_{\alpha}:=\int_{-1 / 2}^{1 / 2} \frac{1}{|s|^{1+\alpha}}-\frac{\pi^{1+\alpha}}{|\sin (\pi s)|^{1+\alpha}} \mathrm{d} s \in \mathbb{R}$,

$$
\begin{aligned}
I & =\frac{a(0)}{G} C_{\alpha} \tau^{-\alpha}-\frac{a(0)\left(\alpha^{-1} 2^{1+\alpha}+b_{\alpha}\right)}{G^{1+\alpha}} \\
& +\int_{s \in \mathbb{T}} \frac{a(s)}{|g(s)|^{(1+\alpha) / 2}}-\frac{\pi^{1+\alpha} a(0)}{G^{1+\alpha}|\sin (\pi s)|^{1+\alpha}} \mathrm{d} s+O\left(\tau^{2-\alpha}\right), \quad \tau \rightarrow 0
\end{aligned}
$$

as claimed.
Concerning the integral in Lemma A.1, we have the following result.
Corollary A.2. Let $\mathbb{T}:=\mathbb{R} / \mathbb{Z}$. For $\delta \in\left(-\delta_{0}, \delta_{0}\right)$ sufficiently small, let $H=H(\delta)$ denote the following family of integrals,

$$
H=\int_{s \in \mathbb{T}}\left(\frac{a(s)}{|g(s, \delta)|^{(1+\alpha) / 2}}-\frac{a(0)}{G(\delta)^{1+\alpha}|\operatorname{Sin} s|^{1+\alpha}}\right) \mathrm{d} s
$$

where $a=a(s) \in C^{\infty}(\mathbb{T}), g=g(s, \delta) \in C^{\infty}(\mathbb{T} \times[0, \infty))$, and $g$ has a unique global minimum that is non-degenerate with $\partial_{s}^{2} g(0, \cdot)>c>0$ for a constant $c$ independent of $\delta$, and

$$
\operatorname{argmin} g(\cdot, \delta)=0, \quad g(0, \delta)=\min g(\cdot, \delta)=0
$$

and $G(\delta):=\sqrt{\partial_{s}^{2} g(0, \delta) / 2}$. Then we have the first order Taylor expansion $H(\tau)=H(0)+H^{\prime}(0) \delta+O\left(\delta^{2}\right)$ for $\tau \ll 1$, with

$$
H^{\prime}(0)=\int_{s \in \mathbb{T}}\left(\frac{a(s) \partial_{\delta} g(s, 0)(-1-\alpha)}{|g(s, 0)|^{(3+\alpha) / 2}}-\frac{\partial_{\delta}\left(G^{-1-\alpha}\right)(0) a(0)}{|\operatorname{Sin} s|^{1+\alpha}}\right) \mathrm{d} s
$$
