# Matching Book Embedding of the Cartesian Product of a Complete Graph and a Cycle

#### Abstract

The book embedding of a graph $G$ is to place the vertices of $G$ on the spine and draw the edges to the pages so that the edges in the same page do not cross with each other. The book embedding is matching if the pages have maximum degree 1 . The matching book thickness is the minimum number of pages in which graphs can be matching book embedded. In this paper, we show that the matching book thickness of the Cartesian product $K_{p} \square C_{q}$ of a complete graph $K_{p}$ and a cycle $C_{q}$ is equal to $\Delta\left(K_{p} \square C_{q}\right)+1$.

## 1 Introduction

The concept of a book-embedding of a graph was introduced by Ollmann and Kainen. A book of the book embedding consists of a spine which is just a line and the pages each of which is a half-plane with spine as boundary. The book thickness $b t(G)$ is a measure of the quality of a book embedding which is the minimum number of pages in which $G$ can be embedded. Book embedding has been found wide applications in the computer science, VLSI theory, multilayer printed circuit boards, sorting with parallel stacks and turning-machine graphs (see [1, 2]). The Cartesian product of two arbitrary graphs $G$ and $B$ is the graph denoted by $G \square B$ whose vertex set is $V(G) \times V(B)$, the vertex $\left(u_{1}, v_{1}\right)$ and the vertex $\left(u_{2}, v_{2}\right)$ are adjacent in $G \square B$ if and only if $u_{1}=u_{2}$ and $v_{1}$ is adjacent to $v_{2}$ in $B$, or $v_{1}=v_{2}$ and $u_{1}$ is adjacent to $u_{2}$ in $G$ (see [3]). The book embedding of graphs has been discussed for a variety of graph families, for examples on complete graphs[4], complete bipartite graphs[5], generalized Petersen graph[6], some Cartesian product graphs $[1,7,8]$, some semistrong product graphs[9] and Schrijver graphs[10], etc.

A book embedding of graph $G$ is matching if every vertex must have degree at most one on every page. The matching book thickness of graph $G$, denoted by $\operatorname{mbt}(G)$, is defined analogously

[^0]to the book thickness as the minimum number of pages required by any matching book embedding of graph $G$ (see [11-13]). A graph $G$ is dispersable if $\operatorname{mbt}(G)=\Delta(G)$, where $\Delta(G)$ is the maximum degree index (see $[4,11,13]$ ). Complete bipartite graphs $K_{n, n}(n \geq 1)$, even cycles $C_{2 m}(m \geq 2)$, cubes $Q_{d}(d \geq 0)$ and trees are dispersable [4]. Given an arbitrary graph $G=(V, E)$, let $\chi^{\prime}(G)$ is the edge chromatic number, by definition, it is easy to know that $\operatorname{mbt}(G) \geq \chi^{\prime}(G) \geq$ $\Delta(G)$. Kainen [14] showed that $\operatorname{mbt}\left(C_{p} \square C_{q}\right)$ is 4 , when $p, q$ are both even and $\operatorname{mbt}\left(C_{p} \square C_{q}\right)$ is 5 , when $p$ is even and $q$ is odd. But for the case $p, q$ are both odd, $\operatorname{mbt}\left(C_{p} \square C_{q}\right)$ is still undetermined.
S. Overbay [11] showed that any $k$-regular dispersable graph $G$ is bipartite. Also, she considered the matching book embedding of complete graphs $K_{n}$ and got $\operatorname{mbt}\left(K_{n}\right)=n$. Back in 1979, Bernhart and Kainen conjectured that any $k$-regular bipartite graph $G$ is dispersable, i.e., $m b t(G)=k$. J.M. Alam, M.A. Bekos, M. Gronemann, M. Kaufmann, and S. Pupyrev [13] disprove this conjecture for the cases $k=3$, and $k=4$. In particular, they showed that the Gray graph, which is 3-regular and bipartite, has dispersable book thickness four, while the Folkman graph, which is 4-regular and bipartite, has dispersable book thickness five.

In this paper, we compute the matching book thickness of the Cartesian product of a complete graph $K_{p}$ and a cycle $C_{q}$ as follows.

Main Theorem: For $p, q \geq 3, \operatorname{mbt}\left(K_{p} \square C_{q}\right)=\Delta\left(K_{p} \square C_{q}\right)+1$

## 2 Proof of the main theorem

The proof will be completed by a sequence of lemmas.
Lemma 2.1. ${ }^{[11]}$ If a graph $G$ is regular and dispersable, then $G$ is bipartite.
Lemma 2.2. Let $K_{p}$ be a complete graph and $C_{q}$ be a cycle, $p, q \geq 3$, then $\operatorname{mbt}\left(K_{p} \square C_{q}\right) \geq$ $\Delta\left(K_{p} \square C_{q}\right)+1$.

Proof. A graph is not bipartite if and only if it contains an odd cycle. Since the Cartesian product of $K_{p}$ and $C_{q}$ contains at least one odd cycle, then $K_{p} \square C_{q}$ is not bipartite. Hence the graph $K_{p} \square C_{q}$ is not dispersable. Therefore $\operatorname{mbt}\left(K_{p} \square C_{q}\right) \geq \Delta\left(K_{p} \square C_{q}\right)+1$.

We will compute the matching book thickness of $K_{p} \square C_{q}$ from four cases.
Case 1: $K_{2 n+1} \square C_{2 m+1}$
Lemma 2.3. If $n \geq 2, m \geq 1$, then $m b t\left(K_{2 n+1} \square C_{2 m+1}\right)=\Delta\left(K_{2 n+1} \square C_{2 m+1}\right)+1=2 n+3$.
Proof. Since $\Delta\left(K_{2 n+1} \square C_{2 m+1}\right)=2 n+2$, by Lemma 2.2, we have $m b t\left(K_{2 n+1} \square C_{2 m+1}\right) \geq 2 n+3$.
There are $(2 n+1)(2 m+1)$ vertices for graph $K_{2 n+1} \square C_{2 m+1}$, and these vertices can be separated into $2 n+1$ rows and $2 m+1$ columns. Each columns holding a consecutive number from top to
bottom. Let the ordering on spine be as $u_{1} v_{2 n+1}, u_{1} v_{2 n}, u_{1} v_{2 n-1}, \ldots, u_{1} v_{1}, u_{2} v_{1}, u_{2} v_{2}, \ldots, u_{2} v_{2 n+1}, \ldots$, $u_{2 m+1} v_{2 n+1}, \ldots, u_{2 m+1} v_{1}$.

Page 0: the edge $\left\{\left(u_{1} v_{1}\right),\left(u_{2 m+1} v_{1}\right) \mid m \geq 1\right\}$, and edges $\left\{\left(u_{i} v_{a}\right)\left(u_{i} v_{b}\right) \mid i=1\right.$ or $2 m+1 ; a+b=$ $2 n+3 ; 1<a, b \leq 2 n+1\}$.

Page 1: the edge $\left\{\left(u_{1} v_{2}\right),\left(u_{2 m+1} v_{2}\right) \mid m \geq 1\right\}$, and edges $\left\{\left(u_{i} v_{a}\right),\left(u_{i} v_{b}\right) \mid i=1\right.$ or $2 m+1 ; a+b=$ $2 n+4 ; 2<a, b \leq 2 n+1\}$.

Page 2: the edge $\left\{\left(u_{1} v_{3}\right),\left(u_{2 m+1} v_{3}\right) \mid m \geq 1\right\}$, and edges $\left\{\left(u_{i} v_{a}\right),\left(u_{i} v_{b}\right) ;\left(u_{i} v_{1}\right),\left(u_{i} v_{2}\right) \mid i=1\right.$ or $2 m+1 ; a+b=2 n+5 ; 3<a, b \leq 2 n+1\}$.

Page $n-1$ : the edge $\left\{\left(u_{1} v_{n}\right),\left(u_{2 m+1} v_{n}\right) \mid n \geq 2, m \geq 1\right\}$, and edges $\left\{\left(u_{i} v_{a}\right),\left(u_{i} v_{b}\right) ;\left(u_{i} v_{c}\right),\left(u_{i} v_{d}\right) \mid\right.$ $i=1$ or $2 m+1 ; a+b=3 n+2 ; c+d=n ; n<a, b \leq 2 n+1 ; 1 \leq c, d<n\}$.

Page $n$ : the edge $\left\{\left(u_{1} v_{n+1}\right),\left(u_{2 m+1} v_{n+1}\right) \mid n \geq 2, m \geq 1\right\}$, and edges $\left\{\left(u_{i} v_{a}\right),\left(u_{i} v_{b}\right) ;\left(u_{i} v_{c}\right),\left(u_{i} v_{d}\right) \mid\right.$ $i=1$ or $2 m+1 ; a+b=3 n+3 ; c+d=n+1 ; n+1<a, b \leq 2 n+1 ; 1 \leq c, d<n+1\}$.

Page $2 n-2$ : the edge $\left\{\left(u_{1} v_{2 n-1}\right),\left(u_{2 m+1} v_{2 n-1}\right) \mid n \geq 2, m \geq 1\right\}$, and edges $\left\{\left(u_{i} v_{a}\right),\left(u_{i} v_{b}\right) ;\left(u_{i} v_{2 n}\right)\right.$, $\left(u_{i} v_{2 n+1}\right) \mid i=1$ or $\left.2 m+1 ; a+b=2 n-1 ; 1 \leq a, b<2 n-1\right\}$.

Page $2 n-1$ : the edge $\left\{\left(u_{1} v_{2 n}\right),\left(u_{2 m+1} v_{2 n}\right) \mid n \geq 2, m \geq 1\right\}$, and edges $\left\{\left(u_{i} v_{a}\right),\left(u_{i} v_{b}\right) \mid i=1\right.$ or $2 m+1 ; a+b=2 n ; 1 \leq a, b<2 n\}$.

Page $2 n$ : the edge $\left\{\left(u_{1} v_{2 n+1}\right),\left(u_{2 m+1} v_{2 n+1}\right) \mid n \geq 2, m \geq 1\right\}$, and edges $\left\{\left(u_{i} v_{a}\right),\left(u_{i} v_{b}\right) \mid i=1\right.$ or $2 m+1 ; a+b=2 n+1 ; 1 \leq a, b<2 n+1\}$.

Page $2 n+1$ : edges $\left\{\left(u_{i} v_{j}\right),\left(u_{i+1} v_{j}\right) \mid 1 \leq i<2 m+1 ; j=1,2,3, \ldots, 2 n+1, i\right.$ is odd $\}$, and edges $\left\{\left(u_{2 m+1} v_{a}\right),\left(u_{2 m+1} v_{b}\right) \mid a+b=2 n+2 ; 1 \leq a, b \leq 2 n+1\right\}$.

Page $2 n+2$ : edges $\left\{\left(u_{i} v_{j}\right),\left(u_{i+1} v_{j}\right) \mid 2 \leq i<2 m+1 ; j=1,2,3, \ldots, 2 n+1, i\right.$ is even $\}$, and edges $\left\{\left(u_{1} v_{a}\right),\left(u_{1} v_{b}\right) \mid a+b=2 n+2 ; 1 \leq a, b \leq 2 n+1\right\}$.

For $k=0,1,2,3, \ldots, 2 n$, other edges $\left\{\left(u_{i} v_{a}\right),\left(u_{i} v_{b}\right) \mid i=2,3, \ldots, 2 m ; 1 \leq a, b \leq 2 n+1\right\}$ of $K_{2 n+1} \square C_{2 m+1}$ are placed on page $k$, where $k \equiv a+b(\bmod 2 n+1)$.

So $K_{2 n+1} \square C_{2 m+1}$ can be matching book embedded in $2 n+3$ pages. Therefore the matching book thickness of $K_{2 n+1} \square C_{2 m+1}$ is $2 n+3$ (see Fig. 1 for the case $n=2, m=1$ ).

Case 2: $K_{2 n} \square C_{2 m+1}$
Lemma 2.4. If $n \geq 2, m \geq 1$, then $m b t\left(K_{2 n} \square C_{2 m+1}\right)=\Delta\left(K_{2 n} \square C_{2 m+1}\right)+1=2 n+2$.
Proof. Since $\Delta\left(K_{2 n} \square C_{2 m+1}\right)=2 n+1$, by Lemma 2.2, $m b t\left(K_{2 n} \square C_{2 m+1}\right) \geq 2 n+2$. Vertices of graph $K_{2 n} \square C_{2 m+1}$ can be separated into $2 n$ rows and $2 m+1$ columns. The edges of graph $K_{2 n} \square C_{2 m+1}$ can be put on $2 n+2$ pages analogously to that of $K_{2 n+1} \square C_{2 m+1}$ in Lemma 2.3. Hence we have $\operatorname{mbt}\left(K_{2 n} \square C_{2 m+1}\right) \leq 2 n+2$. Therefore the result is established (see Fig. 2 for the case $n=3, m=1$ ).

The following result will be applied to case 3 and case 4, which is a generalization of Theorem 4.3 of [4]:

Lemma 2.5. Let $G$ be arbitrary and $B$ be a dispersable bipartite graph, then $\operatorname{mbt}(G \square B) \leq$ $m b t(G)+\Delta(B)$.

Proof. Since $B$ is dispersable, then there is a $\Delta(B)$-edge coloring and a corresponding matching book embedding in a $\Delta(B)$-page book so that all edges of one color lie in the same page. Since $B$ is bipartite, there is a 2-vertex coloring using colors $a$ and $b$.

Now we consider the matching book embedding of $G \square B$. Take a matching book embedding of $G$ in $\operatorname{mbt}(G)$ pages. Using a matching book embedding of $B$, replace all vertices which colored $a$ with a copy of this matching book embedding of $G$ and replace all vertices which colored $b$ with the same matching book embedding of $G$, but in reverse order.

Now each of vertex of $B$ is represent by a copy of $G$. Since each of these copies are placed on the spine, then the edges of $G \square B$ corresponding to the copies of $G$ can all be matching embedded in $m b t(G)$ pages.

The remaining edges of $G \square B$ connect corresponding vertices in adjacent copies of $G$. Since $B$ is bipartite, then edges of $B$ connect vertices of different colors. Since the order of vertices in adjacent copies of $G$ is reversed, then edges connect two adjacent copies corresponding to a single
edge of $B$ can be embedded in the appropriate page as concentric semicircles, which makes sure that the book embedding is matching. Since $\operatorname{mbt}(B)=\Delta(B)$, the copies of the edges of $B$ can also embedded in $\Delta(B)$ pages.

Hence all edges of $G \square B$ can be matching book embedded in $\operatorname{mbt}(G)+\Delta(B)$ pages.
For example, let $G=K_{5}-e, B=P_{3}$, the matching book embedding of $G$ and $B$ is shown in Fig.3. The resulting matching book embedding of graph $G \square B$ in 7 pages is shown in Fig.4.

Case 3 and Case 4: $K_{2 n} \square C_{2 m}, K_{2 n+1} \square C_{2 m}$

Lemma 2.6. If $n, m \geq 2$, then
(i) $\operatorname{mbt}\left(K_{2 n} \square C_{2 m}\right)=\Delta\left(K_{2 n} \square C_{2 m}\right)+1=2 n+2$;
(ii) $\operatorname{mbt}\left(K_{2 n+1} \square C_{2 m}\right)=\Delta\left(K_{2 n+1} \square C_{2 m}\right)+1=2 n+3$.

Proof. Since $K_{2 n} \square C_{2 m}$ is $2 n+1$-regular and $K_{2 n+1} \square C_{2 m}$ is $2 n+2$-regular, by Lemma 2.2, it can be obtained that $\operatorname{mbt}\left(K_{2 n} \square C_{2 m}\right) \geq 2 n+2, \operatorname{mbt}\left(K_{2 n+1} \square C_{2 m}\right) \geq 2 n+3$.

While the even cycle $C_{2 m}$ is dispersable, by Lemma 2.5, for complete graph $K_{2 n}$ and $K_{2 n+1}$, we have

$$
\begin{aligned}
m b t\left(K_{2 n} \square C_{2 m}\right) & \leq m b t\left(K_{2 n}\right)+2=2 n+2 \\
m b t\left(K_{2 n+1} \square C_{2 m}\right) & \leq m b t\left(K_{2 n+1}\right)+2=2 n+3 .
\end{aligned}
$$

This gives the upper bound of $K_{2 n} \square C_{2 m}$ and $K_{2 n+1} \square C_{2 m}$. Hence the equalities of (i) and (ii) both hold.
