Approximation by periodic multivariate quasi-projection operators *

Abstract

Approximation properties of periodic quasi-projection operators with matrix dilations are studied. Such operators are generated by a sequence of functions φ_j and a sequence of distributions/functions $\tilde{\varphi}_j$. Error estimates for sampling-type quasi-projection operators are obtained under the periodic Strang-Fix conditions for φ_j and the compatibility conditions for φ_j and $\tilde{\varphi}_j$. These estimates are given in terms of the Fourier coefficients of approximated functions and provide analogs of some known non-periodic results. Under some additional assumptions error estimates are given in other terms in particular using the best approximation. A number of examples are provided.

Keywords. Periodic quasi-projection operators, Sampling-type operators, Kantorovich-type operators, Periodic Strang-Fix conditions, Matrix dilation, Error of approximation, Best approximation, Wiener's classes.

1 Introduction

Approximation properties of non-periodic quasi-projection operators are actively studied by many authors. The class of such operators is very large, it includes classical sampling and sampling-type expansions (see, e.g., [40, 42, 6, 37, 1, 9, 8, 17, 22, 24, 26] and the references therein), Kantorovich-Kotelnikov operators and their generalizations (see, e.g., [2, 30, 10, 12, 11, 41, 25]), scaling expansions associated with wavelet constructions (see, e.g., [19, 20, 4, 5, 18, 23, 38]) and others. The most general form of the multivariate quasi-projection operator with a dilation matrix M is given by

$$\sum_{k \in \mathbb{Z}^d} m^j \langle f, \widetilde{\varphi}(M^j \cdot -k) \rangle \varphi(M^j \cdot -k), \tag{1}$$

where φ is a function and $\tilde{\varphi}$ is a distribution or function, $m = |\det M|$, and the inner product $\langle f, \tilde{\varphi}(M^j \cdot -k) \rangle$ has meaning in some sense.

For a suitable function/distribution φ , the periodization of $m^j \varphi(M^j \cdot)$ leads to the sequence $\{\varphi_j\}_j$ of periodic functions/distributions such that the k-th Fourier coefficient of φ_j is equal to $\widehat{\varphi}(M^{*-j}k)$,

where $\hat{\varphi}$ is the Fourier transform of φ . So, in the periodic case, the quasi-projection operators take the form

$$Q_j(f,\varphi_j,\widetilde{\varphi}_j) = \frac{1}{m^j} \sum_k \langle f, \widetilde{\varphi}_j(\cdot - M^{-j}k) \rangle \varphi_j(\cdot - M^{-j}k),$$

where the sum over k is finite due to the periodicity of φ_j and the multiplier $\frac{1}{m^j}$ is for a suitable normalization (see Section 3 for more details). In particular, the periodization of the classical sampling expansion, where $\tilde{\varphi}$ is the Dirac delta-function and φ is the sinc-function, leads to $Q_j(f,\varphi_j,\tilde{\varphi}_j)$, where $\tilde{\varphi}_j$ is a periodic distribution whose Fourier coefficients are $\widehat{\varphi}_j(k) = 1, k \in \mathbb{Z}^d$, and $\varphi_j = m^j \Lambda_j$, where Λ_j is a 1-periodic fundamental interpolant on a grid $M^{-j}k$, i.e. $\Lambda_j(M^{-j}k) = \delta_{0k}$, $k \in M^j[-1/2, 1/2)^d \cap \mathbb{Z}^d$. It is easy to see that in this case, $Q_j(f,\varphi_j,\tilde{\varphi}_j)$ takes a sampling form

$$Q_j(f,\varphi_j,\widetilde{\varphi}_j) = P_j(f) = \sum_k f(M^{-j}k)\Lambda_j(\cdot - M^{-j}k).$$

Univariate and multivariate fundamental interpolants Λ_j on the uniform grids and the corresponding quasi-projection operators $P_j(f)$ were investigated by many authors (see, e.g., [28, 13, 36, 31, 32, 35]).

It is well known that in the non-periodic case some compatibility of φ and $\tilde{\varphi}$ and the Strang-Fix conditions for φ are required for successful error estimates. The periodic Strang-Fix conditions were introduced in [7]. For the case of the diagonal dilation matrix $M = 2I_d$ under the periodic Strang-Fix conditions of order s > d/2 for the sequence $\{\Lambda_j\}$, the results in [7] and [34] yield the following error estimate for P_j in L_2 norm

$$||f - P_j(f)||_2 \le C 2^{-j \min\{\gamma, s\}} ||f||_{H_2^{\max\{\gamma, s\}}},$$

where $\gamma > d/2$ and H_2^r is the Sobolev space of order r.

Many results in harmonic analysis involve spaces described in terms of the Fourier transform (in the non-periodic case) such as the Fourier algebra and different its generalizations, see, e.g., [15], [27]. Similarly, in the periodic case, spaces described in terms of the Fourier coefficients appear. In particular, a natural class of such spaces, including the Sobolev space H_2^r and the Wiener algebra, consists of the spaces A_q^{α} such that the A_q^{α} -norm is a weighted ℓ_q -norm of the sequence of Fourier coefficients (see Section 2). For the case $M = 2I_d$, under the strengthened Strang-Fix conditions of order s the following error estimate for P_j in the A_q^{α} -norm was obtained by Sprengel [35]

$$\|f - P_{i}(f)\|_{A^{\alpha}_{\sigma}} \le C2^{-j\min\{\gamma - \alpha, s\}} \|f\|_{A^{\gamma}_{\sigma}},\tag{2}$$

where $q \ge 1$, $\gamma \ge \alpha \ge 0$, and $\gamma > d(1-1/q)$. For lattices generated by a matrix M whose eigenvalues are greater or equal (in absolute value) than 2, an analogous estimate was obtained by Bergmann and Prestin in [3].

The goal of this paper is to obtain periodic analogs of some author's results in [22, 24, 25]. Namely, in [22] the error analysis of non-periodic quasi-projection operators (1) was given for a class of tempered distributions $\tilde{\varphi}$, including the Dirac delta-function, and for a wide class of functions φ with enough decay of φ itself as well as its Fourier transform $\hat{\varphi}$. Error estimates in L_p -norm, $p \geq 2$, were obtained under the assumptions of the Strang-Fix conditions of order s for φ and the weak compatibility of φ and $\tilde{\varphi}$ of order s (which means vanishing of all derivatives up to order s in the origin of the function $1 - \tilde{\varphi}\tilde{\varphi}$). The obtained estimates show that the approximation order depends on the smoothness of f and on s. In particular, it was established that the approximation order equals s for smooth enough functions f. Similar results were obtained in [24] for the same class of distributions $\tilde{\varphi}$ and a class of band-limited functions φ , including the sinc-function, under the assumption of strict compatibility of φ and $\tilde{\varphi}$ (which means that the function $1 - \tilde{\varphi}\tilde{\varphi}$ is identical zero in a neighborhood of the origin). In this case, it was shown that the approximation order depends only on the smoothness of f. In [25], Kantorovich-Kotelnikov type operators, that are the quasi-projection operators (1) with summable $\tilde{\varphi}$ and band-limited φ , were investigated. These operators are bounded in L_p for $1 . Under the assumption of weak compatibility of <math>\varphi$ and $\tilde{\varphi}$ of order s, the L_p -rate of convergence was given in terms of the classical moduli of smoothness of order s.

The paper is organized as follows. Section 2 is devoted to notation and basic definitions. A wide class of periodic sampling-type quasi-projection operators $Q_j(f, \varphi_j, \tilde{\varphi}_j)$ with matrix dilations is introduced in Section 3. The main results are presented in Section 4. Error estimates in terms of the Fourier coefficients of the approximated function is given in Section 4.1. Under the Strang-Fix conditions of order s for φ_j and the weak compatibility of order s of functions φ_j and distributions $\tilde{\varphi}_j$, an error estimate in the A_q^{α} -norm is obtained in Theorem 6. Under the same assumptions, an error estimate for Q_j in the L_p -norm, $p \geq 2$, is obtained in Theorem 9. This theorem provides a periodic analog of the results obtained in [22]. In Section 4.2, under some additional assumptions on the distributions $\tilde{\varphi}_j$ and the matrix dilations M, we give several improvements of the error estimates obtained in the previous section. Particularly, if φ_j and $\tilde{\varphi}_j$ are strongly compatible, then we show that the error estimate for $Q_j(f, \varphi_j, \tilde{\varphi}_j)$ can be given only in terms of the best approximation (see Theorem 19), but if φ_j and $\tilde{\varphi}_j$ are weakly compatible, then the corresponding estimates are given simultaneously in terms of Fourier coefficients and the best approximation (see Theorem 22). The case of Kantorovich-type quasi-projection operators (i.e., $\tilde{\varphi}_j$ is an integrable function) is also considered. In Section 5, we provide some examples.

2 Notation

We use the standard multi-index notations. Let \mathbb{N} be the set of positive integers, \mathbb{R}^d be the *d*-dimensional Euclidean space, \mathbb{Z}^d be the integer lattice in \mathbb{R}^d , $\mathbb{T}^d = \mathbb{R}^d / \mathbb{Z}^d$ be the *d*-dimensional torus. Let $x = (x_1, \ldots, x_d)^T$ and $y = (y_1, \ldots, y_d)^T$ be column vectors in \mathbb{R}^d , then $(x, y) := x_1 y_1 + \cdots + x_d y_d$, $|x| := \sqrt{(x, x)}; \mathbf{0} = (0, \ldots, 0)^T \in \mathbb{R}^d; \mathbb{Z}^d_+ := \{x \in \mathbb{Z}^d : x_k \ge 0, k = 1, \ldots, d\}$. If $a \in \mathbb{R}^d$, r > 0, then $B_r(a)$ denotes the ball of radius r with the center in a.

If
$$\alpha \in \mathbb{Z}^d_+$$
, we set $[\alpha] = \sum_{k=1}^d \alpha_k$, $D^{\alpha}f = \frac{\partial^{[\alpha]}f}{\partial^{\alpha_1}x_1...\partial^{\alpha_d}x_d}$

If A is a $d \times d$ matrix, then ||A|| denotes its operator norm in \mathbb{R}^d ; A^* denotes the conjugate matrix to A.

Let M be a dilation matrix, i.e. an integer valued $d \times d$ matrix, such that the absolute value of each its eigenvalue is greater than 1, $m := |\det M|$, $D(M) := M[-1/2, 1/2)^d \cap \mathbb{Z}^d$. It is known (see, e.g., [21, Chapter 2]) that D(M) is a set of digits of M, and any $k \in \mathbb{Z}^d$ can be uniquely represented as k = Mn + r, $r \in D(M)$, $n \in \mathbb{Z}^d$.

Since the spectrum of the operator M^{-1} is located in $B_r(\mathbf{0})$, where $r = r(M^{-1}) := \lim_{j \to +\infty} \|M^{-j}\|^{\frac{1}{j}}$

is the spectral radius of M^{-1} , and there exists at least one point of the spectrum on the boundary of the ball, we have

$$\|M^{-j}\| \le C_{M,\vartheta} \,\vartheta^{-j}, \quad j \ge 0,\tag{3}$$

for every positive number ϑ whose absolute value is smaller than absolute value of any eigenvalue of M. In particular, we can take $\vartheta > 1$ and, hence, $\lim_{j \to +\infty} ||M^{-j}|| = 0$.

A matrix M is called isotropic if it is similar to a diagonal matrix such that numbers $\lambda_1, \ldots, \lambda_d$ are placed on the main diagonal and $|\lambda_1| = \cdots = |\lambda_d|$. Thus, $\lambda_1, \ldots, \lambda_d$ are eigenvalues of M and the spectral radius of M is equal to $|\lambda|$, where λ is one of the eigenvalues of M. Note that if the matrix M is isotropic then M^* and M^j are isotropic for all $j \in \mathbb{Z}$. It is well known that for an isotropic matrix M and for any $j \in \mathbb{Z}$ we have

$$C_1^M |\lambda|^j \le ||M^j|| \le C_2^M |\lambda|^j, \quad j \in \mathbb{Z},$$
(4)

where λ is one of the eigenvalues of M, constants C_1^M, C_2^M do not depend on j.

We will use notation L_p for the space $L_p(\mathbb{T}^d)$ with the usual norm $||f||_p = \left(\int_{\mathbb{T}^d} |f(x)|^p dx\right)^{1/p}$ for $1 \le p < \infty$, and $||f||_{\infty} = \operatorname{vraisup} |f|$.

If $f \in L_1$, then $f(k), k \in \mathbb{Z}^d$, denotes the k-th Fourier coefficient of f.

For $g \in L_1$, we will use the following notation $g^-(t) = \overline{g(-t)}$.

As usual, the convolution of appropriate functions f and g is given by

$$(f*g)(x) = \int_{\mathbb{T}^d} f(x-t)g(t)dt.$$

We will use notation $\theta_{\alpha}(x) := (1+|x|^2)^{\frac{\alpha}{2}}, \alpha \geq 0, x \in \mathbb{R}^d$. It is easy to check that

$$\theta_{\alpha}(x+y) \le \theta_{\alpha}(x)\theta_{\alpha}(y) \quad \forall x, y \in \mathbb{R}^{d}.$$
(5)

Since ||M|| > 1 for any dilation matrix M, and hence $||M^{*j}|| > 1$ for all $j \in \mathbb{N}$, we have

$$\theta_{\alpha}(x) = \theta_{\alpha}(M^{*j}M^{*-j}x) \le \|M^{*j}\|^{\alpha}\theta_{\alpha}(M^{*-j}x).$$
(6)

Also, for $\alpha \geq 0$ and $1 \leq q \leq \infty$, we will use notation

$$\ell_q^{\alpha} := \{x = \{x_k\}_k : \{\theta_{\alpha}(k)x_k\}_k \in \ell_q\}, \quad \ell_q = \ell_q(\mathbb{Z}^d),$$

and $||x||_{\ell_q^{\alpha}} = ||\{\theta_{\alpha}(k)x_k\}_k||_{\ell_q}$ for $x \in \ell_q^{\alpha}$. Let $1 \leq q \leq \infty$ and $\alpha \geq 0$. The space A_q^{α} of periodic functions is defined by

$$A_q^{\alpha} := \left\{ f \in L_1 : \{ \widehat{f}(k) \}_k \in \ell_q^{\alpha} \right\}, \quad \|f\|_{A_q^{\alpha}} := \|\{ \widehat{f}(k) \}_k \|_{\ell_q^{\alpha}}.$$

These spaces include the Wiener algebra $A := A_1^0$ of functions with absolutely convergent Fourier series. It is clear that $A_q^{\beta} \subset A_q^{\alpha}$ for $\beta \geq \alpha$. If q = 2, then the space A_2^{α} coincides with the Sobolev space H_2^{α} . So α can be considered as a smoothness parameter. However, these smoothness properties (except p = 2) differ from usual smoothness of the fractional Sobolev spaces H_p^{α} . Some embeddings of A_q^{α} into H_p^{β} and vice versa can be found in [35]. For a function $f \in A_q^{\alpha}$, we set

$$\|f\|_{A^{\alpha}_{q},j}^{Out} := \Big(\sum_{k \notin D(M^{*j})} |\widehat{f}(k)|^{q} \theta^{q}_{\alpha}(k)\Big)^{1/q}, \quad \|f\|_{A^{\alpha}_{q},j}^{In} := \Big(\sum_{k \in D(M^{*j})} |\widehat{f}(k)|^{q} \theta^{q}_{\alpha}(k)\Big)^{1/q}.$$

for $1 \leq q < \infty$, and

$$\|f\|_{A^{\alpha}_{\infty},j}^{Out} := \sup_{k \notin D(M^{*j})} |\widehat{f}(k)| \theta_{\alpha}(k), \quad \|f\|_{A^{\alpha}_{\infty},j}^{In} := \sup_{k \in D(M^{*j})} |\widehat{f}(k)| \theta_{\alpha}(k)$$

for $q = \infty$. For convenience, we will also use the following notation:

$$\|f\|_{A^{\alpha}_{q},j}^{q,Out} := \sum_{k \notin D(M^{*j})} |\widehat{f}(k)|^{q} \theta^{q}_{\alpha}(k), \quad \|f\|_{A^{\alpha}_{q},j}^{q,In} := \sum_{k \in D(M^{*j})} |\widehat{f}(k)|^{q} \theta^{q}_{\alpha}(k).$$

Let $\mathcal{D} = C^{\infty}(\mathbb{T}^d)$ be the space of infinitely differentiable functions on \mathbb{R}^d that are periodic with period 1. A continuous linear functional on the space \mathcal{D} is a periodic distribution. The linear space of periodic distributions we denote by \mathcal{D}' . For a periodic distribution $\varphi \in \mathcal{D}'$ and a function $f \in \mathcal{D}$, we denote the action of φ on f by $\varphi(f)$. For convenience, we will use notation $\langle \varphi, f \rangle := \varphi(\overline{f})$ and $\langle f, \varphi \rangle = \overline{\langle \varphi, f \rangle}$. It is known (see, e.g., [14, p. 322], [33, p. 144]) that any periodic distribution φ can be expanded in a weakly convergent (in \mathcal{D}') Fourier series

$$\varphi(x) = \sum_{n \in \mathbb{Z}^d} \widehat{\varphi}(n) e^{2\pi i (n, x)},\tag{7}$$

where the sequence $\{\widehat{\varphi}(n)\}_n$ has at most polynomial growth and for any $f \in \mathcal{D}$

$$\langle f, \varphi \rangle = \sum_{n \in \mathbb{Z}^d} \widehat{f}(n) \overline{\widehat{\varphi}(n)}.$$

Also, conversely, for any sequence $\{\widehat{\varphi}(n)\}_n$ of at most polynomial growth the series in the right-hand side of (7) converges weakly to a periodic distribution. The numbers $\widehat{\varphi}(n)$ are called the Fourier coefficients of a periodic distribution φ and $\widehat{\varphi}(n) = \langle \varphi, e^{2\pi i (n, \cdot)} \rangle = \varphi(e^{-2\pi i (n, \cdot)})$. The convolution of $f \in \mathcal{D}$ and the distribution φ is defined by $(f * \varphi)(x) = \langle f, \overline{\varphi(x - \cdot)} \rangle$.

3 Sampling-type quasi-projection operators

In this section, we define the periodic quasi-projection operators $Q_j(f, \varphi_j, \tilde{\varphi}_j)$, where $\varphi \in L_1, \tilde{\varphi}_j \in \mathcal{D}', j \in \mathbb{N}$, by

$$Q_j(f,\varphi_j,\widetilde{\varphi}_j) = \frac{1}{m^j} \sum_{k \in D(M^j)} \langle f, \widetilde{\varphi}_j(\cdot - M^{-j}k) \rangle \varphi_j(\cdot - M^{-j}k).$$

By the definition of \mathcal{D}' , such an operator Q_j has meaning only for $f \in \mathcal{D}$, and

$$\langle f, \widetilde{\varphi}_j(\cdot - M^{-j}k) \rangle = \sum_{l \in \mathbb{Z}^d} \widehat{f}(l) \overline{\widetilde{\varphi}_j(l)} e^{2\pi i (k, M^{*-j}l)}.$$
(8)

But since the Fourier coefficients of $\tilde{\varphi}_j$ have polynomial growth, the latter series converges for any f whose Fourier coefficients decay sufficiently fast. Thus, to extend the class of functions f, we define the inner product $\langle f, \tilde{\varphi}_j(\cdot - M^{-j}k) \rangle$ by (8).

Next, we introduce several conditions on the sequences of functions φ_j and distributions $\tilde{\varphi}_j$ under which the quasi-projection operator $Q_j(f, \varphi_j, \tilde{\varphi}_j)$ provides good enough approximation of an appropriate function f. For additional motivation of these conditions, we consider their connection with the analogous conditions for the non-periodic case (see [22, 24]). For this, we note that the periodic and non-periodic cases can be connected via periodization as follows. Let $\varphi \in L_1(\mathbb{R}^d)$ with $\{\widehat{\varphi}(k)\}_{k \in \mathbb{Z}^d} \in \ell_1$. Setting $\varphi_{j,l}(x) := m^{j/2} \varphi(M^j x + l)$ and

$$\varphi_j(x) := m^j \sum_k \varphi(M^j(x+k)) = m^{j/2} \sum_k \varphi_{j,0}(x+k), \tag{9}$$

where the multiplier $m^{j/2}$ is for a suitable normalization, we have that each φ_j is in L_1 and by the Poisson summation formula,

$$\varphi_j(x) = m^{j/2} \sum_k \widehat{\varphi_{j,0}}(k) e^{2\pi i (k,x)} = \sum_k \widehat{\varphi}(M^{*-j}k) e^{2\pi i (k,x)} = \sum_k \widehat{\varphi_j}(k) e^{2\pi i (k,x)},$$

which implies that $\widehat{\varphi_j}(k) = \widehat{\varphi}(M^{*-j}k).$

1. The conditions on the growth of order $N \ge 0$ for Fourier coefficients of $\{\widetilde{\varphi}_j\}_j$:

$$\begin{aligned} |\widehat{\widetilde{\varphi}_{j}}(k)| &\leq C_{\widetilde{\varphi}}|M^{*-j}k|^{N}, \quad \forall k \notin D(M^{*j}), \quad \forall j \in \mathbb{N}, \\ \max_{k \in D(M^{*j})} |\widehat{\widetilde{\varphi}_{j}}(k)| &\leq C_{\widetilde{\varphi}}, \qquad \forall j \in \mathbb{N}. \end{aligned}$$
(10)

These conditions correspond to the following non-periodic conditions:

$$|\widehat{\widetilde{\varphi}}(\xi)| \le C_{\widetilde{\varphi}}|\xi|^N$$
 for $\xi \notin [-1/2, 1/2]^d$

and

$$|\widehat{\widetilde{\varphi}}(\xi)| \le C_{\widetilde{\varphi}} \quad \text{for} \quad \xi \in [-1/2, 1/2]^d.$$

To show this, we note that $\widehat{\varphi}_{j}(k) = \widehat{\varphi}(M^{*-j}k)$. Thus, if non-periodic conditions are valid for $\widetilde{\varphi}$, then conditions (10) are valid for $\widetilde{\varphi}_{j}$.

2. The Strang-Fix conditions of order s, s > 0, for a sequence of functions $\{\varphi_j\}_j$:

$$|\widehat{\varphi_j}(M^{*j}n+r)| \le b_n |M^{*-j}r|^s, \quad \forall n \ne \mathbf{0}, \quad \forall r \in D(M^{*j}).$$
(11)

This corresponds to the well known Strang-Fix conditions for a non-periodic function φ : $D^{\beta}\widehat{\varphi}(n) = 0$, for $n \neq \mathbf{0}$, $[\beta] < s, s \in \mathbb{N}$ and the condition that $\widehat{\varphi}$ is boundedly differentiable up to order s. Indeed, by Taylor's formula near the point $\xi = n$, we have for $r \in D(M^{*j})$

$$\widehat{\varphi}(n+M^{*-j}r) = \sum_{[\beta]=s} \frac{s}{\beta!} (M^{*-j}r)^{\beta} \int_0^1 (1-t)^{s-1} D^{\beta} \widehat{\varphi}(n+tM^{*-j}r) dt.$$

Thus, since $\widehat{\varphi_j}(M^{*j}n+r) = \widehat{\varphi}(n+M^{*-j}r)$, we get $|\widehat{\varphi_j}(M^{*j}n+r)| \le C_{s,\varphi}|M^{*-j}r|^s$.

For error estimates in the non-periodic case (see, e.g., [22]), the following additional assumption helps:

$$\sum_{n \in \mathbb{Z}^d} |D^{\beta} \widehat{\varphi}(n+\xi)|^q \le B_s, \quad \forall \xi \in \mathbb{R}^d, [\beta] < s$$

A periodic analog of this condition is $\{b_n\}_n \in \ell_q$.

3. The weak compatibility conditions of order s, s > 0, for $\{\varphi_j\}_j$ and $\{\widetilde{\varphi}_j\}_j$:

$$\left|1 - \widehat{\varphi_j}(r)\overline{\widehat{\widetilde{\varphi_j}}(r)}\right| \le b_0 |M^{*-j}r|^s, \quad \forall r \in D(M^{*j}), \quad \forall j \in \mathbb{N}.$$
(12)

This corresponds to the following non-periodic condition: $D^{\beta}(1-\widehat{\varphi}\overline{\widehat{\phi}})(\mathbf{0}) = 0$, $[\beta] < s, s \in \mathbb{N}$, and condition that $\widehat{\varphi}\overline{\widehat{\phi}}$ is boundedly differentiable up to order s. Indeed, by Taylor's formula near the point $\xi = 0$,

$$\widehat{\varphi}(M^{*-j}r)\overline{\widehat{\widetilde{\varphi}}(M^{*-j}r)} = 1 + \sum_{[\beta]=s} \frac{s}{\beta!} (M^{*-j}r)^{\beta} \int_0^1 (1-t)^{s-1} D^{\beta} \widehat{\varphi}\overline{\widehat{\widetilde{\varphi}}}(tM^{*-j}r) dt.$$
(13)

Thus, since $\widehat{\varphi}(M^{*-j}r)\overline{\widehat{\varphi}(M^{*-j}r)} = \widehat{\varphi_j}(r)\overline{\widehat{\varphi_j}(r)}$, we have $|1 - \widehat{\varphi_j}(r)\overline{\widehat{\varphi_j}(r)}| \le C_{s,\widetilde{\varphi}}|M^{*-j}r|^s$. 4. The conditions on the uniform boundedness of the Fourier coefficients of $\{\varphi_i\}_i$:

$$\max_{k \in D(M^{*j})} |\widehat{\varphi_j}(k)| \le C_{\varphi}, \quad \forall j \in \mathbb{N}.$$
(14)

4 Error estimates for $Q_j(f, \varphi_j, \widetilde{\varphi}_j)$

4.1 Estimates in terms of the Fourier coefficients

First we establish two utility lemmas. For convenience, in the proofs of these lemmas we will use the following notation

$$C_d := \max_{x \in [-\frac{1}{2}, \frac{1}{2}]^d} \theta_1(x) = \left(1 + \frac{d}{4}\right)^{\frac{1}{2}}.$$

Lemma 1 Let $1 \le q \le \infty$, 1/p+1/q = 1, $j \in \mathbb{N}$, $\alpha \ge 0$, $\{\widetilde{\varphi}_j\}_j$ be a sequence of periodic distributions whose Fourier coefficients satisfy condition (10) with parameter $N \ge 0$. Suppose $f \in A_a^{\gamma}$, where $\gamma > N + d/p$ for $q \neq 1$ or $\gamma \ge N$ for q = 1. Then, if $1 \le q < \infty$

$$\left(\sum_{r\in D(M^{*j})} \left|\sum_{n\neq 0} \widehat{f}(r+M^{*j}n)\overline{\widehat{\varphi}_{j}(r+M^{*j}n)}\right|^{q} \theta_{\alpha}^{q}(r)\right)^{\frac{1}{q}} \leq C_{Lem} \|M^{*j}\|^{\alpha} \|M^{*-j}\|^{\gamma} \|f\|_{A^{\gamma}_{q},j}^{Out},$$

and if $q = \infty$

.

$$\sup_{r\in D(M^{*j})} \left| \sum_{n\neq 0} \widehat{f}(r+M^{*j}n) \overline{\widehat{\widetilde{\varphi}_j}(r+M^{*j}n)} \right| \theta_\alpha(r) \le C_{Lem} \|M^{*j}\|^\alpha \|M^{*-j}\|^\gamma \|f\|_{A^\gamma_{\infty,j}}^{Out},$$

where the constant C_{Lem} does not depend on j and f.

Proof. First, let $1 < q < \infty$ and $\alpha = 0$. Applying Hölder's inequality, condition (10), and the fact that $\frac{1}{|M^{*j}k|} \leq \frac{||M^{*-j}||}{|k|}$, we derive

$$\begin{split} \sum_{r \in D(M^{*j})} \left| \sum_{n \neq \mathbf{0}} \widehat{f}(r + M^{*j}n) \overline{\widehat{\varphi_{j}}(r + M^{*j}n)} \right|^{q} \\ &\leq \sum_{r \in D(M^{*j})} \left(\sum_{n \neq \mathbf{0}} \frac{1}{|r + M^{*j}n|^{p(\gamma - N)}} \right)^{\frac{q}{p}} \\ &\times \sum_{n \neq \mathbf{0}} |\widehat{f}(r + M^{*j}n)|^{q} |\widehat{\varphi_{j}}(r + M^{*j}n)|^{q} |r + M^{*j}n|^{q(\gamma - N)} \\ &\leq \max_{r \in D(M^{*j})} \left(\sum_{n \neq \mathbf{0}} \frac{1}{|r + M^{*j}n|^{p(\gamma - N)}} \right)^{\frac{q}{p}} \sum_{k \notin D(M^{*j})} |\widehat{f}(k)|^{q} |\widehat{\varphi_{j}}(k)|^{q} |k|^{q(\gamma - N)} \\ &\leq \|M^{*-j}\|^{(\gamma - N)q} \max_{\xi \in [-1/2, 1/2)^{d}} \left(\sum_{n \neq \mathbf{0}} \frac{1}{|n + \xi|^{p(\gamma - N)}} \right)^{\frac{q}{p}} C_{\widetilde{\varphi}}^{q} \|M^{*-j}\|^{qN} \sum_{k \notin D(M^{*j})} |\widehat{f}(k)|^{q} |k|^{q\gamma} \\ &\leq C_{p,\gamma,N}^{q} C_{\widetilde{\varphi}}^{q} \|M^{*-j}\|^{q\gamma} \|f\|_{A_{\widetilde{\gamma}}^{q}, j}^{q, Out}. \end{split}$$

Repeating the same steps, the required estimate for $q = \infty$ can be derived. For q = 1, we have

$$\begin{split} \sum_{r \in D(M^{*j})} \left| \sum_{n \neq \mathbf{0}} \widehat{f}(r + M^{*j}n) \overline{\widehat{\widetilde{\varphi_j}}(r + M^{*j}n)} \right| &\leq \sum_{k \notin D(M^{*j})} |\widehat{f}(k)| \overline{\widehat{\varphi_j}(k)}| \\ &\leq C_{\widetilde{\varphi}} \sum_{k \notin D(M^{*j})} |\widehat{f}(k)| |M^{*-j}k|^N \leq 2^{\gamma} C_{\widetilde{\varphi}} \sum_{k \notin D(M^{*j})} |\widehat{f}(k)| |M^{*-j}k|^{\gamma} \leq 2^{\gamma} C_{\widetilde{\varphi}} ||M^{*-j}||^{\gamma} ||f||_{A_1^{\gamma}, j}^{Out} \end{split}$$

since $|M^{*-j}k| \ge \frac{1}{2}$ for $k \notin D(M^{*j})$ and $|M^{*-j}k|^N \le (2|M^{*-j}k|)^N \le (2|M^{*-j}k|)^{\gamma}$. To prove the lemma for $\alpha > 0$, it is sufficient to note that

$$\max_{r \in D(M^{*j})} \theta_{\alpha}^{q}(r) \le \|M^{*j}\|^{q\alpha} \max_{r \in D(M^{*j})} \theta_{\alpha}^{q}(M^{*-j}r) \le \|M^{*j}\|^{q\alpha} \max_{x \in [-\frac{1}{2}, \frac{1}{2}]^{d}} \theta_{\alpha}^{q}(x) \le C_{d}^{\alpha q} \|M^{*j}\|^{q\alpha},$$
(15)

and $C_{Lem} = C_{p,\gamma,N} C_{\widetilde{\varphi}} C_d^{\alpha}$ for q > 1 and $C_{Lem} = 2^{\gamma} C_{\widetilde{\varphi}} C_d^{\alpha}$ for q = 1.

Remark 2 The constant $C_{p,\gamma,N}$ in the proof of Lemma 1 can be estimated as follows (see [31, Lemma 1.10])

$$C^p_{p,\gamma,N} = \max_{\xi \in [-\frac{1}{2},\frac{1}{2})^d} \sum_{n \neq \mathbf{0}} \frac{1}{|n+\xi|^{p(\gamma-N)}} \le 2^{p(\gamma-N)} \sum_{v=1}^d 2^v \frac{1}{v^{p(\gamma-N)/2}} \binom{d}{v} \left(1 + \frac{v}{2(p(\gamma-N)-v)}\right)^v.$$

Lemma 3 Let $1 \leq q \leq \infty$, 1/p + 1/q = 1, $j \in \mathbb{N}$, $\alpha \geq 0$, $\{\varphi_j\}_j$ and $\{\widetilde{\varphi}_j\}_j$ be sequences of periodic functions and periodic distributions, respectively, whose Fourier coefficients are such that conditions (10), (11), (12), (14) are valid with parameters $N \geq 0$, s > 0, and $b = \{b_n\}_n \in \ell_q^{\alpha}$. Suppose $f \in A_q^{\gamma}$, where $\gamma \geq \alpha$ and $\gamma > N + d/p$ for $q \neq 1$ or $\gamma \geq N$ for q = 1,

$$I := \begin{cases} \left(\sum_{n \in \mathbb{Z}^d} \left| \widehat{f}(n) - \sum_{l \in \mathbb{Z}^d} \widehat{f}(n + M^{*j}l) \overline{\widehat{\varphi_j}(n + M^{*j}l)} \widehat{\varphi_j}(n) \right|^q \theta_{\alpha}^q(n) \right)^{\frac{1}{q}}, & \text{if } q < \infty, \\ \sup_{n \in \mathbb{Z}^d} \left| \widehat{f}(n) - \sum_{l \in \mathbb{Z}^d} \widehat{f}(n + M^{*j}l) \overline{\widehat{\varphi_j}(n + M^{*j}l)} \widehat{\varphi_j}(n) \right| \theta_{\alpha}(n), & \text{if } q = \infty. \end{cases}$$

Then

$$I \le C_1 \|M^{*j}\|^{\alpha} \|M^{*-j}\|^s \|f\|_{A_q^{s+\alpha},j}^{In} + C_2 \|M^{*j}\|^{\alpha} \|M^{*-j}\|^{\gamma} \|f\|_{A_q^{\gamma},j}^{Out},$$
(16)

where the constants C_1 and C_2 do not depend on j and f.

Proof. First, we consider the case $q < \infty$. Set

$$J := I^q = \sum_{n \in \mathbb{Z}^d} \left| \widehat{f}(n) - \sum_{l \in \mathbb{Z}^d} \widehat{f}(n + M^{*j}l) \overline{\widehat{\varphi}_j(n + M^{*j}l)} \widehat{\varphi}_j(n) \right|^q \theta^q_\alpha(n)$$

and split the sum J into two parts such that

$$J = \sum_{n \in D(M^{*j})} + \sum_{n \notin D(M^{*j})} := J_0 + J_1.$$

Estimating J_0 , we derive

$$\begin{split} J_{0} &= \sum_{n \in D(M^{*j})} \left| \widehat{f}(n) - \widehat{f}(n) \overline{\widehat{\varphi_{j}}(n)} \widehat{\varphi_{j}}(n) - \sum_{l \neq \mathbf{0}} \widehat{f}(n + M^{*j}l) \overline{\widehat{\varphi_{j}}(n + M^{*j}l)} \widehat{\varphi_{j}}(n) \right|^{q} \theta_{\alpha}^{q}(n) \\ &\leq 2^{\frac{q}{p}} \sum_{n \in D(M^{*j})} \left| \widehat{f}(n) - \widehat{f}(n) \overline{\widehat{\varphi_{j}}(n)} \widehat{\varphi_{j}}(n) \right|^{q} \theta_{\alpha}^{q}(n) \\ &+ 2^{\frac{q}{p}} \sum_{n \in D(M^{*j})} \left| \sum_{l \neq \mathbf{0}} \widehat{f}(n + M^{*j}l) \overline{\widehat{\varphi_{j}}(n + M^{*j}l)} \widehat{\varphi_{j}}(n) \right|^{q} \theta_{\alpha}^{q}(n) =: J_{00} + J_{01}. \end{split}$$

For the first term J_{00} , by the compatibility conditions for φ_j and $\tilde{\varphi}_j$ of order s, see (12), we get

$$J_{00} = 2^{\frac{q}{p}} \sum_{n \in D(M^{*j})} |\widehat{f}(n)|^{q} |1 - \overline{\widehat{\varphi_{j}}(n)} \widehat{\varphi_{j}}(n)|^{q} \theta_{\alpha}^{q}(n)$$

$$\leq 2^{\frac{q}{p}} b_{0}^{q} \|M^{*-j}\|^{qs} \sum_{n \in D(M^{*j})} |\widehat{f}(n)|^{q} |n|^{qs} \theta_{\alpha}^{q}(n) \leq 2^{\frac{q}{p}} b_{0}^{q} \|M^{*-j}\|^{qs} \|f\|_{A_{q}^{s+\alpha},j}^{q,In}.$$

For the second term J_{01} , by Lemma 1 and (14), we have

$$J_{01} = 2^{\frac{q}{p}} \sum_{n \in D(M^{*j})} \left| \sum_{l \neq \mathbf{0}} \widehat{f}(n + M^{*j}l) \overline{\widehat{\varphi_{j}}(n + M^{*j}l)} \widehat{\varphi_{j}}(n) \right|^{q} \theta_{\alpha}^{q}(n)$$

$$\leq 2^{\frac{q}{p}} \max_{n \in D(M^{*j})} |\widehat{\varphi_{j}}(n)|^{q} \sum_{n \in D(M^{*j})} \left| \sum_{l \neq \mathbf{0}} \widehat{f}(n + M^{*j}l) \overline{\widehat{\varphi_{j}}(n + M^{*j}l)} \right|^{q} \theta_{\alpha}^{q}(n)$$

$$\leq 2^{\frac{q}{p}} C_{\varphi}^{q} C_{Lem}^{q} \| M^{*j} \|^{q\alpha} \| M^{*-j} \|^{q\gamma} \| f \|_{A_{q,j}^{q},j}^{q,Out}.$$

Thus, the term J_0 is estimated by

$$J_{0} \leq 2^{\frac{q}{p}} \left(b_{0}^{q} \| M^{*-j} \|^{qs} \| f \|_{A_{q}^{s+\alpha}, j}^{q, In} + C_{\varphi}^{q} C_{Lem}^{q} \| M^{*j} \|^{q\alpha} \| M^{*-j} \|^{q\gamma} \| f \|_{A_{q}^{\gamma}, j}^{q, Out} \right).$$
(17)

Consider J_1 . By Minkowski's inequality, we get

$$J_{1} := \sum_{\substack{n \notin D(M^{*j}) \\ n \notin D(M^{*j})}} \left| \widehat{f}(n) - \widehat{f}(n)\overline{\widehat{\varphi_{j}}(n)}\widehat{\varphi_{j}}(n) - \sum_{\substack{l \neq \mathbf{0}}} \widehat{f}(n + M^{*j}l)\overline{\widehat{\varphi_{j}}(n + M^{*j}l)}\widehat{\varphi_{j}}(n) \right|^{q} \theta_{\alpha}^{q}(n)$$
$$\leq 2^{\frac{q}{p}} \sum_{\substack{n \notin D(M^{*j}) \\ n \notin D(M^{*j})}} \left| \widehat{f}(n) - \widehat{f}(n)\overline{\widehat{\varphi_{j}}(n)}\widehat{\varphi_{j}}(n) \right|^{q} \theta_{\alpha}^{q}(n)$$
$$+ 2^{\frac{q}{p}} \sum_{\substack{n \notin D(M^{*j}) \\ l \neq \mathbf{0}}} \widehat{f}(n + M^{*j}l)\overline{\widehat{\varphi_{j}}(n + M^{*j}l)}\widehat{\varphi_{j}}(n) \right|^{q} \theta_{\alpha}^{q}(n) =: J_{10} + J_{11}.$$

Again, by Minkowski's inequality,

$$J_{10} \le 2^{\frac{2q}{p}} \sum_{n \notin D(M^{*j})} |\widehat{f}(n)|^q \theta^q_{\alpha}(n) + 2^{\frac{2q}{p}} \sum_{n \notin D(M^{*j})} \left| \widehat{f}(n) \overline{\widehat{\varphi_j}(n)} \widehat{\varphi_j}(n) \right|^q \theta^q_{\alpha}(n) =: J_{100} + J_{101}.$$

For the sum J_{100} , using the inequality $\frac{1}{|n|} \leq \frac{||M^{*-j}||}{|M^{*-j}n|}$, we derive

$$J_{100} = 2^{\frac{2q}{p}} \sum_{\substack{n \notin D(M^{*j}) \\ n \notin D(M^{*j})}} \frac{|n|^{q(\gamma-\alpha)}}{|n|^{q(\gamma-\alpha)}} |\widehat{f}(n)|^{q} \theta^{q}_{\alpha}(n) \leq 2^{\frac{2q}{p}} ||f||^{q,Out}_{A^{\gamma}_{q},j} \max_{\substack{n \notin D(M^{*j}) \\ n \notin D(M^{*j})}} \frac{1}{|n|^{q(\gamma-\alpha)}}$$
$$\leq 2^{\frac{2q}{p}} ||f||^{q,Out}_{A^{\gamma}_{q},j} ||M^{*-j}||^{q(\gamma-\alpha)} \max_{\substack{n \notin D(M^{*j}) \\ n \notin D(M^{*j})}} \frac{1}{|M^{*-j}n|^{q(\gamma-\alpha)}}$$
$$\leq 2^{\frac{2q}{p}} 2^{q(\gamma-\alpha)} ||M^{*-j}||^{q(\gamma-\alpha)} ||f||^{q,Out}_{A^{\gamma}_{q},j},$$

where the last inequality is valid since for $n \notin D(M^{*j})$ we have $|M^{*-j}n| > 1/2$.

Consider J_{101} . By the Strang-Fix conditions (11) and inequalities (5), (6) and (15), for any $n = M^{*j}k + r$ with $k \neq \mathbf{0}$ and $r \in D(M^{*j})$, we obtain

$$|\widehat{\varphi_j}(n)|^q \theta^q_\alpha(n) \le b^q_k |M^{*-j}r|^{qs} \|M^{*j}\|^{\alpha q} \theta^q_\alpha(k) \theta^q_\alpha(M^{*-j}r) \le \|b\|^q_{\ell^\infty_\alpha} C_d^{q(s+\alpha)} \|M^{*j}\|^{\alpha q}.$$

Therefore,

$$\begin{split} J_{101} &= 2^{\frac{2q}{p}} \sum_{n \notin D(M^{*j})} \left| \widehat{f(n)} \widehat{\widehat{\varphi_{j}}(n)} \widehat{\varphi_{j}}(n) \right|^{q} \theta_{\alpha}^{q}(n) \\ &= 2^{\frac{2q}{p}} \|b\|_{\ell_{\infty}^{q}}^{q} C_{d}^{q(s+\alpha)} \|M^{*j}\|^{\alpha q} \sum_{n \notin D(M^{*j})} \left| \widehat{f(n)} \overline{\widehat{\varphi_{j}}(n)} \right|^{q} \\ &\leq 2^{\frac{2q}{p}} \|b\|_{\ell_{\infty}^{\infty}}^{q} C_{d}^{q(s+\alpha)} \|M^{*j}\|^{\alpha q} C_{\widetilde{\varphi}}^{q} \|M^{*-j}\|^{Nq} \sum_{n \notin D(M^{*j})} |\widehat{f(n)}|^{q} |n|^{qN} \\ &= 2^{\frac{2q}{p}} \|b\|_{\ell_{\infty}^{\infty}}^{q} C_{d}^{q(s+\alpha)} C_{\widetilde{\varphi}}^{q} \|M^{*j}\|^{\alpha q} \|M^{*-j}\|^{Nq} \sum_{n \notin D(M^{*j})} |\widehat{f(n)}|^{q} \frac{|n|^{q\gamma}}{|n|^{q(\gamma-N)}} \\ &\leq 2^{\frac{2q}{p}} \|b\|_{\ell_{\infty}^{\infty}}^{q} C_{d}^{q(s+\alpha)} C_{\widetilde{\varphi}}^{q} \|M^{*j}\|^{\alpha q} \|M^{*-j}\|^{Nq} \sum_{n \notin D(M^{*j})} |\widehat{f(n)}|^{q} |n|^{q\gamma} \frac{\|M^{*-j}\|^{q(\gamma-N)}}{|M^{*-j}n|^{q(\gamma-N)}} \\ &\leq 2^{\frac{2q}{p}} 2^{q(\gamma-N)} \|b\|_{\ell_{\infty}^{\alpha}}^{q} C_{d}^{q(s+\alpha)} C_{\widetilde{\varphi}}^{q} \|M^{*j}\|^{\alpha q} \|M^{*-j}\|^{q\gamma} \|M^{*-j}\|^{q\gamma} \|f\|_{A_{q,j}^{q},j}^{q,Out}, \end{split}$$

where the last inequality is valid because $|M^{*-j}n| > 1/2$ whenever $n \notin D(M^{*j})$, and, therefore,

$$\frac{1}{|M^{*-j}n|^{q(\gamma-N)}} \le \max_{n \notin D(M^{*j})} \frac{1}{|M^{*-j}n|^{q(\gamma-N)}} = 2^{q(\gamma-N)}.$$

Combining the estimates for J_{100} and J_{101} , we get

$$J_{10} \le 2^{\frac{2q}{p}} \left(2^{q(\gamma-\alpha)} + 2^{q(\gamma-N)} \|b\|_{\ell_{\infty}^{\alpha}}^{q} C_{d}^{q(s+\alpha)} C_{\widetilde{\varphi}}^{q} \right) \|M^{*j}\|^{q\alpha} \|M^{*-j}\|^{q\gamma} \|f\|_{A_{q,j}^{\gamma}}^{q,Out}.$$

Now, let us estimate J_{11} . By Minkowski's inequality,

$$\begin{split} J_{11} &= 2^{\frac{q}{p}} \sum_{\substack{n \notin D(M^{*j}) \\ n \notin D(M^{*j})}} \left| \sum_{\substack{l \neq \mathbf{0}}} \widehat{f}(n + M^{*j}l) \overline{\widehat{\varphi_{j}}(n + M^{*j}l)} \widehat{\varphi_{j}}(n) \right|^{q} \theta_{\alpha}^{q}(n) \\ &= 2^{\frac{q}{p}} \sum_{\substack{r \in D(M^{*j}) \\ r \in D(M^{*j})}} \sum_{\substack{k \neq \mathbf{0}}} |\widehat{\varphi_{j}}(r + M^{*j}k)|^{q} \left| \sum_{\substack{l \neq \mathbf{0}}} \widehat{f}(r + M^{*j}(k + l)) \overline{\widehat{\varphi_{j}}(r + M^{*j}(k + l))} \right|^{q} \theta_{\alpha}^{q}(r + M^{*j}k) \\ &= 2^{\frac{2q}{p}} \sum_{\substack{r \in D(M^{*j}) \\ r \in D(M^{*j})}} \sum_{\substack{k \neq \mathbf{0}}} |\widehat{\varphi_{j}}(r + M^{*j}k)|^{q} |\widehat{f}(r) \overline{\widehat{\varphi_{j}}(r)}|^{q} \theta_{\alpha}^{q}(r + M^{*j}k) \\ &+ 2^{\frac{2q}{p}} \sum_{\substack{r \in D(M^{*j}) \\ r \in D(M^{*j})}} \sum_{\substack{k \neq \mathbf{0}}} |\widehat{\varphi_{j}}(r + M^{*j}k)|^{q} \left| \sum_{\substack{l \neq \mathbf{0} \\ \substack{l \neq -k}} \widehat{f}(r + M^{*j}(k + l)) \overline{\widehat{\varphi_{j}}(r + M^{*j}(k + l))} \right|^{q} \theta_{\alpha}^{q}(r + M^{*j}k) \\ &=: J_{110} + J_{111} \end{split}$$

Using the Strang-Fix conditions (11), inequalities (5), (6) and conditions (10), we obtain

$$J_{110} \leq 2^{\frac{2q}{p}} \sum_{r \in D(M^{*j})} |M^{*-j}r|^{sq} |\widehat{f}(r) \overline{\widetilde{\varphi_{j}}(r)}|^{q} \theta^{q}_{\alpha}(r) \sum_{k \neq \mathbf{0}} b^{q}_{k} \theta^{q}_{\alpha}(M^{*j}k)$$
$$\leq 2^{\frac{2q}{p}} C^{q}_{\widetilde{\varphi}} \|M^{*-j}\|^{sq} \sum_{r \in D(M^{*j})} |r|^{sq} |\widehat{f}(r)|^{q} \theta^{q}_{\alpha}(r) \|M^{*j}\|^{\alpha q} \|b\|^{q}_{\ell^{\alpha}_{q}}$$
$$\leq 2^{\frac{2q}{p}} C^{q}_{\widetilde{\varphi}} \|b\|^{q}_{\ell^{\alpha}_{q}} \|M^{*j}\|^{\alpha q} \|M^{*-j}\|^{sq} \|f\|^{q,In}_{A^{s+\alpha}_{q},j}.$$

For the second term J_{111} , using Lemma 1 with $\alpha = 0$, the Strang-Fix conditions (11) and (10), inequalities (5) and (6), we get

$$\begin{split} J_{111} &:= 2^{\frac{2q}{p}} \sum_{r \in D(M^{*j})} \sum_{k \neq 0} |\widehat{\varphi_j}(r + M^{*j}k)|^q \left| \sum_{\substack{l \neq 0 \\ l \neq -k}} \widehat{f}(r + M^{*j}(k + l))\overline{\widehat{\varphi_j}(r + M^{*j}(k + l))} \right|^q \theta_{\alpha}^q(r + M^{*j}k) \\ &\leq 2^{\frac{2q}{p}} \sum_{r \in D(M^{*j})} \sum_{k \neq 0} b_k^q |M^{*-j}r|^{sq} ||M^{*j}||^{\alpha q} \theta_{\alpha}^q(M^{*-j}r) \theta_{\alpha}^q(k) \\ &\qquad \times \left| \sum_{\substack{l \neq 0 \\ l \neq -k}} \widehat{f}(r + M^{*j}(k + l))\overline{\widehat{\varphi_j}(r + M^{*j}(k + l))} \right|^q \\ &\leq 2^{\frac{2q}{p}} C_d^{q(s+\alpha)} ||M^{*j}||^{\alpha q} \sum_{k \neq 0} b_k^q \theta_{\alpha}^q(k) \sum_{r \in D(M^{*j})} \left| \sum_{\substack{l \neq 0 \\ l \neq -k}} \widehat{f}(r + M^{*j}(k + l)) \overline{\widehat{\varphi_j}(r + M^{*j}(k + l))} \right|^q \\ &\leq 2^{\frac{2q}{p}} C_d^{q(s+\alpha)} ||b||_{\ell_q}^q C_{Lem}^q ||M^{*j}||^{\alpha q} ||M^{*-j}||^{q\gamma} ||f||_{A_{q,j}^{q,j}}^{q,Out}. \end{split}$$

Thus, combining the estimates for J_{11} , J_{110} , and J_{111} , we derive

$$J_{11} \leq 2^{\frac{2q}{p}} C^{q}_{\widetilde{\varphi}} \|b\|^{q}_{\ell^{\alpha}_{q}} \|M^{*j}\|^{q\alpha} \|M^{*-j}\|^{sq} \|f\|^{q,In}_{A^{s+\alpha}_{q},j} + 2^{\frac{2q}{p}} C^{q(s+\alpha)}_{d} \|b\|^{q}_{\ell^{\alpha}_{q}} C^{q}_{Lem} \|M^{*j}\|^{q\alpha} \|M^{*-j}\|^{q\gamma} \|f\|^{q,Out}_{A^{\alpha}_{q},j}.$$

Finally, the estimates for J_1 , J_{10} , and J_{11} yield

$$J_{1} \leq C_{J_{10}} \|M^{*j}\|^{q\alpha} \|M^{*-j}\|^{q\gamma} \|f\|^{q,Out}_{A^{\gamma}_{q},j} + C_{J_{110}} \|M^{*j}\|^{q\alpha} \|M^{*-j}\|^{q\alpha} \|M^{*-j}\|^{sq} \|f\|^{q,In}_{A^{s+\alpha}_{q},j} + C_{J_{111}} \|M^{*j}\|^{q\alpha} \|M^{*-j}\|^{q\gamma} \|f\|^{q,Out}_{A^{\gamma}_{q},j}$$

which together with (17) implies

$$\begin{split} &\sum_{n\in\mathbb{Z}^d} \left| \widehat{f}(n) - \sum_{l\in\mathbb{Z}^d} \widehat{f}(n+M^{*j}l) \overline{\widehat{\varphi_j}(n+M^{*j}l)} \widehat{\varphi_j}(n) \right|^q \theta_{\alpha}^q(n) \\ &\leq 2^{\frac{q}{p}} b_0^q \|M^{*-j}\|^{qs} \|f\|_{A_q^{s+\alpha},j}^{q,n} + 2^{\frac{q}{p}} C_{\varphi}^q C_{Lem}^q \|M^{*j}\|^{q\alpha} \|M^{*-j}\|^{q\gamma} \|f\|_{A_q^{\gamma},j}^{q,Out} \\ &+ C_{J_{110}} \|M^{*j}\|^{q\alpha} \|M^{*-j}\|^{sq} \|f\|_{A_q^{s+\alpha},j}^{q,In} + (C_{J_{10}} + C_{J_{111}}) \|M^{*j}\|^{q\alpha} \|M^{*-j}\|^{q\gamma} \|f\|_{A_q^{\gamma},j}^{q,Out} \\ &\leq C_1 \|M^{*j}\|^{q\alpha} \|M^{*-j}\|^{qs} \|f\|_{A_q^{s+\alpha},j}^{q,In} + C_2 \|M^{*j}\|^{q\alpha} \|M^{*-j}\|^{q\gamma} \|f\|_{A_q^{\gamma},j}^{q,Out}, \end{split}$$

which completes the proof of (16) for the case $q < \infty$.

If now $q = \infty$, then repeating step by step all above estimates, one can easily obtain (16) for this case. \diamond

Remark 4 Analyzing the proof of Lemma 3, it is not difficult see that

$$C_1 = 2^{\frac{q}{p}} b_0^q + 2^{\frac{2q}{p}} C_{\tilde{\varphi}}^q \|b\|_{\ell_q^{\alpha}}^q, \quad C_2 \le C_2' \|b\|_{\ell_\infty} + C_2'' \|b\|_{\ell_q^{\alpha}}^q,$$

where C'_2 and C''_2 do not depend on b.

Remark 5 If under the assumptions of Lemma 3 the functions φ_j are trigonometric polynomials such that spec $\varphi_j \subset M^{*j}B_R(\mathbf{0})$, then the assumption $\{b_n\}_n \in \ell_q^{\alpha}$ is not required. Indeed, there exists a finite set $\Omega \subset \mathbb{Z}^d$, depending only on R and d, such that $\widehat{\varphi_j}(M^{*j}n+r) \neq 0$ for at least one $r \in D(M^{*j})$ only for $n \in \Omega$. Analyzing the proof of Lemma 3, we see that $\|b\|_{\ell_q^{\alpha}}$ can be replaced by $C_{R,\alpha}\|b\|_{\ell_{\infty}}$.

Theorem 6 Let $1 \le q \le \infty$, 1/p + 1/q = 1, $j \in \mathbb{N}$, $\alpha \ge 0$, and let $\{\varphi_j\}_j$, $\{\tilde{\varphi}_j\}_j$ be a sequence of periodic functions in L_p and periodic distributions, respectively, whose Fourier coefficients are such that conditions (10), (11), (12), (14) are valid with parameters $N \ge 0$, s > 0, and $\{b_n\}_n \in \ell_q^{\alpha}$. Suppose $f \in A_q^{\alpha}$, where $\gamma > \alpha$ and $\gamma > N + d/p$ for $q \ne 1$ or $\gamma \ge N$ for q = 1. Then

$$\|f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)\|_{A_q^{\alpha}} \le C \|M^{*j}\|^{2\alpha} \|M^{*-j}\|^{\min\{\gamma,s+\alpha\}} \|f\|_{A_q^{\gamma}},\tag{18}$$

where C does not depend on j and f.

In addition, if M is an isotropic matrix and λ is its eigenvalue, then

$$\|f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)\|_{A^{\alpha}_q} \le C'|\lambda|^{-j\min\{\gamma - 2\alpha, s - \alpha\}} \|f\|_{A^{\gamma}_q},\tag{19}$$

where C' does not depend on j and f.

Proof. First of all we mention that the inner product $\langle f, \tilde{\varphi}_j(\cdot - M^{-j}k) \rangle$ has meaning under our assumptions, and hence the operator $Q_j(f, \varphi_j, \tilde{\varphi}_j)$ is well defined. Taking into account that

$$\sum_{k \in D(M^j)} e^{2\pi i (k, M^{*-j}r)} = \begin{cases} m^j, & \text{if} \quad r \equiv \mathbf{0} \pmod{M^{*j}}, \\ 0, & \text{if} \quad r \not\equiv \mathbf{0} \pmod{M^{*j}}, \end{cases}$$

we derive the following representation for the Fourier coefficients of $g := f - Q_j(f, \varphi_j, \widetilde{\varphi}_j)$:

$$\begin{split} \widehat{g}(n) &= \widehat{f}(n) - \frac{1}{m^j} \sum_{k \in D(M^j)} \langle f, \widetilde{\varphi}_j(\cdot - M^{-j}k) \rangle \widehat{\varphi_j}(n) e^{-2\pi i (n, M^{-j}k)} \\ &= \widehat{f}(n) - \frac{1}{m^j} \widehat{\varphi_j}(n) \sum_{l \in \mathbb{Z}^d} \widehat{f}(l) \overline{\widehat{\varphi_j}(l)} \sum_{k \in D(M^j)} e^{2\pi i (k, M^{*-j}(l-n))} \\ &= \widehat{f}(n) - \widehat{\varphi_j}(n) \sum_{l \in \mathbb{Z}^d} \widehat{f}(n + M^{*j}l) \overline{\widehat{\varphi_j}(n + M^{*j}l)}. \end{split}$$

Using this together with Lemma 3, taking into account that $||M^{*j}||^{-1} \leq ||M^{*-j}||$, we obtain

$$\|f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)\|_{A_q^{\alpha}} \le C_1 \|M^{*j}\|^{2\alpha} \|M^{*-j}\|^{s+\alpha} \|f\|_{A_q^{s+\alpha}} + C_2 \|M^{*j}\|^{\alpha} \|M^{*-j}\|^{\gamma} \|f\|_{A_q^{\gamma}}.$$
 (20)

Assume first that $s + \alpha \leq \gamma$. Obviously, in this case, $\|f\|_{A_q^{s+\alpha}} \leq \|f\|_{A_q^{\gamma}}$ and $\|M^{*-j}\|^{\gamma} \leq \|M^{*-j}\|^{s+\alpha}$ for all j such that $\|M^{*-j}\| \leq 1$. By (3), the last inequality is valid for all j which are greater than some appropriate j_0 , and there exists a constant C_{j_0} such that $\|M^{*-j}\|^{\gamma} \leq C_{j_0}\|M^{*-j}\|^{s+\alpha}$ for all $j \leq j_0$, which yields (18).

Next, if $s + \alpha > \gamma$, then we set $s' = \gamma - \alpha$ and note that all assumptions of Theorem 6 with s' instead of s are satisfied. Indeed, we need to check that (11) and (12) are valid for s'. For low dimensions $(d \le 4)$, we have $|M^{*-j}r| \le 1$ for $r \in D(M^{*j})$ and, therefore, (11) and (12) obviously hold. For d > 4, (11) and (12) are valid for s' if we replace the constants b_n by $b_n \left(\frac{\sqrt{d}}{2}\right)^{s-s'}$. Hence, inequality (20) with s' instead of s holds and $s' + \alpha = \gamma = \min\{s + \alpha, \gamma\}$, which yields (18).

Finally, inequality (19) follows immediately from (18) and relation (4). \diamond

Note that estimate (19) is actually a generalization of (2). To compare these relations, one has to take into account that (2) was obtained under the following strengthened Strang-Fix conditions of order s for a sequence of fundamental interpolants $\{\Lambda_i\}_i$:

$$|\widehat{\Lambda_j}(2^j n + r)| \le b_n |r|^s 2^{-j(s+\alpha)}, \quad \forall n \ne \mathbf{0}, r \in D(M^{*j}).$$

Analyzing the proof of Lemma 3, it is not difficult to see that under the same strengthened Strang-Fix conditions for $\{\varphi_j\}_j$ instead of (11), we can replace $\min\{\gamma - 2\alpha, s - \alpha\}$ by $\min\{\gamma - \alpha, s\}$ in inequality (19).

Remark 7 If under the assumptions of Theorem 6, the functions φ_j are trigonometric polynomials such that spec $\varphi_j \subset D(M^{*j})$, then, analyzing the proof of Lemma 3, one can easily see that

$$J_1 = J_{100} = \sum_{n \notin D(M^{*j})} |\widehat{f}(n)|^q \theta^q_\alpha(n) \le 2^{q(\gamma - \alpha)} \|M^{*-j}\|^{q(\gamma - \alpha)} \|f\|^{q, Out}_{A^\gamma_q, j},$$

which together with (17) implies

$$J \le C_1 \|f\|_{A_q^{s+\alpha},j}^{q,In} \|M^{*-j}\|^{qs} + C_2 \|M^{*j}\|^{q\alpha} \|M^{*-j}\|^{q\gamma} \|f\|_{A_q^{\gamma},j}^{q,Out}.$$

It follows that (18) can be replaced by

$$\|f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)\|_{A^{\alpha}_q} \le C \|M^{*j}\|^{\alpha} \|M^{*-j}\|^{\min\{\gamma,s+\alpha\}} \|f\|_{A^{\gamma}_q}$$

where C does not depend on j and f. In a similar way, relation (19) can be also improved in this case.

Next we need the following embedding properties between the spaces L_p and A_a^0 .

Proposition 8 If $2 \le p \le \infty$, 1/p + 1/q = 1, then $A_q^0 \subset L_p$, with

$$\|f\|_{p} \le \|f\|_{A^{0}_{q}}.$$
(21)

Relation (21) is the classical Hausdorff-Young inequality, for its multivariate version see, e.g., [16, p. 174] or [35].

Theorem 9 Let $2 \le p \le \infty$, 1/p + 1/q = 1, $\{\varphi_j\}_j$, $\{\widetilde{\varphi}_j\}_j$, N, s, and γ be as in Theorem 6 with $\alpha = 0$ and $f \in A_a^{\gamma}$. Then

$$\|f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)\|_p \le C_1 \|M^{*-j}\|^s \|f\|_{A^s_q,j}^{In} + C_2 \|M^{*-j}\|^\gamma \|f\|_{A^{\gamma}_q,j}^{Out},$$
(22)

where C_1 and C_2 do not depend on j and f.

If ϑ is any positive number which is smaller in absolute value than any eigenvalue of M, then

$$\|f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)\|_p \le C\vartheta^{-j\min\{s,\gamma\}} \|f\|_{A_q^{\gamma}},\tag{23}$$

where C does not depend on j and f. In addition, if M is an isotropic matrix and λ is its eigenvalue, then ϑ can be replaced by $|\lambda|$ in (23).

Proof. Obviously, the operator $Q_j(f, \varphi_j, \tilde{\varphi}_j)$ is well defined and belongs to L_p under our assumptions. Using (21), one can see that $f \in L_p$ and

$$\|f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)\|_p \le \|f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)\|_{A^0_q}.$$
(24)

Analyzing the proof of Theorem 6 and using Lemma 3, we obtain (22). Inequality (23) follows from (24), (18) with $\alpha = 0$, and (3). It remains to say that in the case of isoropic matrix M, one can use (4) instead of (3). \diamond

Note that non-periodic counterparts of the results stated in Theorem 9 were obtained in [22], see Theorems 4, 5.

Corollary 10 If under the assumptions of Theorem 9 we have $\widehat{f}(n) = \mathcal{O}(|n|^{-\kappa})$, where $\kappa > N + d$, and M is an isotropic matrix, then

$$\|f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)\|_p = \begin{cases} \mathcal{O}(|\lambda|^{-js}), & s < \kappa - d/q, \\ \mathcal{O}(j|\lambda|^{-js}), & s = \kappa - d/q, \\ \mathcal{O}(|\lambda|^{-j(\kappa - \frac{d}{q})}), & s > \kappa - d/q, \end{cases}$$
(25)

where λ is an eigenvalue of M.

Proof. First, we assume that $s < \kappa - \frac{d}{q}$ and choose $\gamma > N + \frac{d}{p}$ such that $s < \gamma < \kappa - \frac{d}{q}$. Therefore, $s - \kappa < \gamma - \kappa < -\frac{d}{q}$ and both expressions $\|f\|_{A_q^{\gamma},j}^{q,Out}$ and $\|f\|_{A_q^s,j}^{q,In}$, in (22) are finite. Hence, inequality (22) together with (4) yields that

$$||f - Q_j(f, \varphi_j, \widetilde{\varphi}_j)||_p^q \le C ||M^{*-j}||^{qs} \sum_{k \in \mathbb{Z}^d} |k|^{(\gamma - \kappa)q} = \mathcal{O}(||M^{*-j}||^{qs}).$$

Now, we assume that $s \ge \kappa - \frac{d}{q}$. Choose $\gamma > N + \frac{d}{p}$ such that $\gamma < \kappa - \frac{d}{q}$. Let us consider the second term in (22). Since $\frac{1}{|n|} \le \frac{||M^{*-j}||}{|M^{*-j}n|}$ we get

$$\begin{split} \|M^{*-j}\|^{q\gamma} \|f\|_{A^{\gamma}_{q,j}}^{q,Out} &\leq \|M^{*-j}\|^{q\gamma} \sum_{n \neq \mathbf{0}} \sum_{r \in D(M^{*j})} \frac{1}{|M^{*j}n + r|^{(\kappa - \gamma)q}} \\ &\leq \|M^{*-j}\|^{q\gamma} \sum_{n \neq \mathbf{0}} \sum_{r \in D(M^{*j})} \max_{\xi \in [-\frac{1}{2}, \frac{1}{2})^d} \frac{\|M^{*-j}\|^{q(\kappa - \gamma)}}{|n + \xi|^{(\kappa - \gamma)q}} \\ &\leq Cm^j \|M^{*-j}\|^{q\kappa} \end{split}$$

Next, consider the first term in (22). Then

$$\|M^{*-j}\|^{qs} \|f\|_{A^{s}_{q},j}^{q,In} \le C \|M^{*-j}\|^{qs} \sum_{n \in D(M^{*j})} |n|^{(s-\kappa)q}.$$

It is clear that there exists $A = A(d) > \sqrt{d}/2$ such that for $|n| \ge A$, $|x|/2 \le |n| \le 2|x|$ for any $x \in n + \frac{1}{2}[-1,1)^d$ (note that anyway $|x| > \widetilde{A}$, for some $\widetilde{A} > 0$). Therefore, if $s - \kappa \ge 0$, then $|n|^{(s-\kappa)q} \le 2^{(s-\kappa)q}|x|^{(s-\kappa)q}$, and if $s - \kappa < 0$, then $|n|^{(s-\kappa)q} \le (|x|/2)^{(s-\kappa)q}$. Thus,

$$|n|^{(s-\kappa)q} \le 2^{|s-\kappa|q} \int_{n+\frac{1}{2}[-1,1)^d} |x|^{(s-\kappa)q} dx.$$

Hence,

$$\sum_{n \in D(M^{*j})} |n|^{(s-\kappa)q} = \sum_{|n| < A} |n|^{(s-\kappa)q} + \sum_{|n| \ge A} |n|^{(s-\kappa)q} \le \widetilde{C}_1 + 2^{|s-\kappa|q} \int_{\widetilde{A} < |x| < ||M^{*j}|| \sqrt{\frac{d}{4}}} |x|^{(s-\kappa)q} dx$$
$$\le \widetilde{C}_2 \int_{\widetilde{A}}^{||M^{*j}|| \sqrt{\frac{d}{4}}} r^{(s-\kappa)q+d-1} dr \le \begin{cases} \widetilde{C}_3 \log ||M^{*j}||, \ s = \kappa - \frac{d}{q}; \\ \widetilde{C}_4 ||M^{*j}||^{(s-(\kappa - \frac{d}{q}))q}, \ s > \kappa - \frac{d}{q}. \end{cases}$$

Overall, for $s = \kappa - \frac{d}{q}$ inequality (22) and above considerations yields that

$$\|f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)\|_p^q \le C \|M^{*-j}\|^{qs} (m^j \|M^{*-j}\|^d + \log \|M^{*j}\|).$$

For $s > \kappa - \frac{d}{q}$ inequality (22) and above considerations yields that

$$\|f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)\|_p^q \le C(m^j \|M^{*-j}\|^{q\kappa} + \|M^{*-j}\|^{qs} \|M^{*j}\|^{(s-(\kappa-\frac{d}{q}))q}).$$

It remains to note that $m = |\lambda|^d$ for isotropic dilation matrix, and using (4), we get the required estimates. \diamond

Let $\mathcal{B} = \mathcal{B}_{\delta,R}$ denote the class of sequences of trigonometric polynomials $\varphi_j, j \in \mathbb{N}$, such that

spec
$$\varphi_j \subset M^{*j} \Big(B_R(\mathbf{0}) \setminus \bigcup_{n \in \mathbb{Z}^d \setminus \{\mathbf{0}\}} B_\delta(n) \Big),$$
 (26)

$$|\widehat{\varphi_j}(l)| \le C'_{\varphi} \quad \forall j \in \mathbb{N}, \forall l \in \mathbb{Z}^d,$$
(27)

for some positive constants R, δ , and C'_{ω} .

Note that $\{\varphi_j\}_j$ belongs to \mathcal{B} whenever (27) is valid and

spec $\varphi_j \subset M^{*j} ([-1+\delta, 1-\delta]^d), \quad \delta \in (0, 1/2).$

Definition 11 We say that a sequence of integrable periodic functions $\{\varphi_j\}_j$ is strictly compatible with a sequence of periodic distributions $\{\widetilde{\varphi}_j\}_j$ if

$$\widehat{\widehat{\varphi}_j}(l)\overline{\widehat{\varphi_j}(l)} = 1, \quad \forall j \in \mathbb{N}, \forall l \in \mathbb{Z}^d : |M^{*-j}l| \le \delta,$$
(28)

for some $\delta > 0$.

Theorem 12 Let $1 \leq q < \infty$, 1/p + 1/q = 1, $\{\widetilde{\varphi}_j\}_j$ be a sequence of periodic distributions satisfying (10) with $N \geq 0$, and a sequence of trigonometric polynomials $\{\varphi_j\}_j \in \mathcal{B}$ be strictly compatible with $\{\widetilde{\varphi}_j\}_j$ with respect to the parameter $\delta \in (0, 1/2)$. Suppose $f \in A_q^{\gamma}$, where $\gamma > 0$ and $\gamma > N + d/p$ for $q \neq 1$ or $\gamma \geq N$ for q = 1, and $\alpha \in [0, \gamma)$. Then

$$\|f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)\|_{A^{\alpha}_q} \le C \|M^{*j}\|^{2\alpha} \|M^{*-j}\|^{\gamma} \left(\sum_{|M^{*-j}r| \ge \delta} |r|^{q\gamma} |\widehat{f}(r)|^q\right)^{\frac{1}{q}},$$
(29)

and moreover, in the case $p \geq 2$,

$$\|f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)\|_p \le C' \|M^{*-j}\|^{\gamma} \left(\sum_{|M^{*-j}r| \ge \delta} |r|^{q\gamma} |\widehat{f}(r)|^q\right)^{\frac{1}{q}},\tag{30}$$

where C, C' do not depend on f and j.

Proof. As in Theorem 6, the operator $Q_j(f, \varphi_j, \widetilde{\varphi}_j)$ is well defined under our assumptions. Let us check that for any s > 0 the Strang-Fix conditions of order s for φ_j and the weak compatibility conditions for φ_j and $\widetilde{\varphi}_j$ of order s are satisfied. Indeed, let $n \in \mathbb{Z}^d, n \neq \mathbf{0}, r \in D(M^{*j})$. If $|M^{*-j}r| \leq \delta$, then $\widehat{\varphi_j}(M^{*j}n + r) = 0$; if $|M^{*-j}r| > \delta$, then, by (27),

$$|\widehat{\varphi_j}(M^{*j}n+r)| \le C'_{\varphi} \delta^{-s} \delta^s \le C'_{\varphi} \delta^{-s} |M^{*-j}r|^s.$$

Thus, conditions (11) are satisfied with $b_n \equiv C'_{\varphi} \delta^{-s}$. Similarly, for every $r \in D(M^{*j})$, using (27), (28) and (10), we have

$$|1 - \widehat{\widetilde{\varphi}_j}(r)\widehat{\varphi_j}(r)| \le (1 + C'_{\varphi}C_{\widetilde{\varphi}})\delta^{-s}\delta^s \le (1 + C'_{\varphi}C_{\widetilde{\varphi}})\delta^{-s}|M^{*-j}r|^s,$$

which implies that (12) is satisfied with $b_0 = (1 + C'_{\varphi}C_{\widetilde{\varphi}})\delta^{-s}$.

Now, taking into account Remark 5, we see that all assumptions of Lemma 3 are fulfilled with any s > 0. Analyzing the proof of this lemma, we see that

$$J := \sum_{n \in \mathbb{Z}^d} \left| \widehat{f}(n) - \widehat{\varphi_j(n)} \sum_{l \in \mathbb{Z}^d} \widehat{f}(n + M^{*j}l) \overline{\widehat{\varphi_j}(n + M^{*j}l)} \right|^q \theta_{\alpha}^q(n)$$

$$\leq J_{00} + J_{110} + C_2 \| M^{*j} \|^{\alpha q} \| M^{*-j} \|^{q\gamma} \| f \|_{A_{q,j}^q}^{q,Out},$$
(31)

Obviously,

$$\|f\|_{A^{\gamma}_{q},j}^{q,Out} \leq 2^{q\gamma} \sum_{|M^{*-j}r| \geq \delta} |r|^{q\gamma} |\widehat{f}(r)|^{q\gamma}.$$

Repeating step by step the estimates for J_{00} and J_{110} , using (28), (26), and Remark 5, and taking into account that $||M^{*j}||^{-1} \leq ||M^{*-j}||$, we obtain

$$J_{00} = 2^{q/p} \sum_{r \in D(M^{*j})} |\widehat{f}(r)|^{q} |1 - \overline{\widehat{\varphi_{j}}(r)} \widehat{\varphi_{j}}(r)|^{q} \theta_{\alpha}^{q}(r) \\ \leq 2^{q(\alpha+1/p)} b_{0}^{q} ||M^{*j}||^{\alpha q} ||M^{*-j}||^{(s+\alpha)q} \sum_{|M^{*-j}r| \geq \delta} |r|^{q(s+\alpha)} |\widehat{f}(r)|^{q}$$
(32)

and

$$J_{110} = 2^{\frac{2q}{p}} \sum_{r \in D(M^{*j})} \sum_{k \neq \mathbf{0}} |\widehat{\varphi_j}(r + M^{*j}k)|^q |\widehat{f}(r) \overline{\widehat{\varphi_j}(r)}|^q \theta^q_\alpha(r + M^{*j}k)$$

$$\leq 2^{q(\alpha + 2/p)} \delta^{-s} C'_{\varphi} C^q_{\widetilde{\varphi}} C^q_{R,\alpha} \|M^{*j}\|^{2\alpha q} \|M^{*-j}\|^{(s+\alpha)q} \sum_{|M^{*-j}r| \geq \delta} |r|^{q(s+\alpha)} |\widehat{f}(r)|^q,$$

where $C_{R,\alpha}$ is the constant from Remark 5. Substituting these relations into (31) and choosing $s = \gamma - \alpha$, we obtain (29).

To prove (30) it remains to set $\alpha = 0$ and combine (29) with (21).

Note that relation (30) with $p = \infty$ is a periodic analog of Theorem 15 in [24], which, in turn, is a generalization of Brown's inequality, see [6].

Proposition 13 If under the assumptions of Theorem 12, equality (28) holds for all $l \in D(M^{*j})$ and spec $\varphi_j \subset D(M^{*j})$, then

$$\|f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)\|_{A_q^{\alpha}} \le C \|M^{*j}\|^{\alpha} \|M^{*-j}\|^{\gamma} \left(\sum_{r \notin D(M^{*j})} |r|^{q\gamma} |\widehat{f}(r)|^q\right)^{\frac{1}{q}},$$
(33)

and moreover, in the case $p \geq 2$,

$$\left\|f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)\right\|_p \le C' \left\|M^{*-j}\right\|^{\gamma} \left(\sum_{\substack{r \notin D(M^{*j})}} |r|^{q\gamma} |\widehat{f}(r)|^q\right)^{\frac{1}{q}},\tag{34}$$

where C and C' do not depend on f and j.

Proof. Analyzing the proof of Theorem 12, we see that under our assumptions $J_{00} = J_{110} = 0$ and

$$||f||_{A^{\gamma}_{q,j}}^{q,Out} \le 2^{q\gamma} \sum_{r \notin D(M^{*j})} |r|^{q\gamma} |\widehat{f}(r)|^{q\gamma}.$$

Using this and taking into account Remark 7, we obtain (33) and (34). \diamond

4.2 L_p -errors using the best approximation

In this section, we will show that in some partial cases the results obtained in the previous sections can be sharpened and extended to a wider class of functions f than those considered in Theorems 6, 9, and 12. Moreover, we show that the L_p -error estimates for $Q_i(f, \varphi_i, \tilde{\varphi}_i)$ can be given using the best approximation.

We restrict ourselves to the case of a diagonal dilation matrix $M = \text{diag}(m_1, m_2, \dots, m_d), m_i \in \mathbb{Z}$, and the case $\{\varphi_j\}_j \in \mathcal{B}$, where $\mathcal{B} = \mathcal{B}_{\delta,R}$ is the class of sequences of trigonometric polynomials introduced in Section 4.1.

We need to specify the class of tempered distributions $\{\tilde{\varphi}_i\}_i$. We will say that a sequence of tempered distributions $\{\widetilde{\varphi}_j\}_j$ belongs to the class $\mathcal{S}'_{N,p}$ for some $N \geq 0$ and $1 \leq p \leq \infty$ if it satisfies (10) and for any trigonometric polynomial T_n such that spec $T_n \subset \{k \in \mathbb{Z}^d : |M^{-n}k| \le 1\}$, one has

$$||T_n * \widetilde{\varphi}_j||_p \le C_{\widetilde{\varphi},p} m^{\frac{N}{d}(n-j)} ||T_n||_p \quad \text{for all} \quad n \ge j, \quad j, n \in \mathbb{N}.$$
(35)

Note that in the case of p = 2 and an isotropic matrix M, conditions (10) imply inequality (35). As a simple example of $\{\widetilde{\varphi}_j\}_j \in \mathcal{S}'_{N,p}$, we can take distributions $\{\widetilde{\varphi}_j\}_j$ corresponding to some differential operator. Namely, let d = 1 and $\widehat{\widetilde{\varphi}_j}(l) = \sum_{0 \le \beta \le N} c_\beta (2\pi i M^{-j} l)^\beta$, $N \in \mathbb{Z}_+, j \in \mathbb{N}$, then by the well-known Bernstein inequality for trigonometric polynomials $\|T_n^{(r)}\|_{L_p(\mathbb{T})} \leq n^r \|T_n\|_{L_p(\mathbb{T})}$ (see, e.g., [39, p. 215]), we easily derive that $\{\widetilde{\varphi}_j\}_j \in \mathcal{S}'_{N,p}$. We will also use the following class of sequences \mathcal{L}_p , $1 \leq p \leq \infty$. We will say that a sequence

 $\{\widetilde{\varphi}_j\}_j$ belongs to \mathcal{L}_p if for all $j \in \mathbb{N}$

$$\|\widetilde{\varphi}_j\|_{\mathcal{L}_{p,j}} := \left(m^j \int_{M^{-j}\mathbb{T}^d} \left(\frac{1}{m^j} \sum_{k \in D(M^j)} |\widetilde{\varphi}_j(x - M^{-j}k)|\right)^p dx\right)^{\frac{1}{p}} < \infty \quad \text{if} \quad 1 \le p < \infty$$

and

$$\|\widetilde{\varphi}_j\|_{\mathcal{L}_{\infty,j}} := \frac{1}{m^j} \sup_{x \in \mathbb{R}^d} \sum_{k \in D(M^j)} |\widetilde{\varphi}_j(x - M^{-j}k)| < \infty \quad \text{if} \quad p = \infty.$$

An important example of $\{\widetilde{\varphi}_j\}_j \in \mathcal{L}_p$ is given by the normalized characteristic functions of $M^{-j}[-\frac{1}{2},\frac{1}{2})^d$, $\tilde{\varphi}_j(x) = m^j \chi_{M^{-j}[-\frac{1}{2},\frac{1}{2}]^d}(x)$. It is worth noting that such $\tilde{\varphi}_j$ provide a periodic counterpart of Kantorovich-Kotelnikov operators studied in [25].

For any $d \times d$ -matrix A, we denote

$$\mathcal{T}_A := \{T : \operatorname{spec} T \subset \{k \in \mathbb{Z}^d : |A^{-1}k| < 1\}\}.$$

The error of the best approximation of $f \in L_p$ by trigonometric polynomials $T \in \mathcal{T}_A$ is defined by

$$E_A(f)_p := \inf \{ \|f - T\|_p : T \in \mathcal{T}_A \}.$$

We will use the following anisotropic Besov spaces with respect to the matrix M. We will say that $f \in \mathbb{B}_{p,q}^{s}(M)$, $1 \leq p \leq \infty$, $0 < q \leq \infty$, and s > 0, if $f \in L_{p}$ and

$$||f||_{\mathbb{B}^{s}_{p,q}(M)} := ||f||_{p} + \left(\sum_{\nu=1}^{\infty} m^{\frac{s}{d}q\nu} E_{M^{\nu}}(f)_{p}^{q}\right)^{\frac{1}{q}} < \infty.$$

For simplicity, we will also denote

$$\|\{a_k\}_k\|_{\ell_{p,M^j}} := \begin{cases} \left(\frac{1}{m^j} \sum_{k \in D(M^j)} |a_k|^p\right)^{\frac{1}{p}}, & \text{if } 1 \le p < \infty, \\ \sup_{k \in D(M^j)} |a_k|, & \text{if } p = \infty. \end{cases}$$

Lemma 14 Let $1 \le p \le \infty$ and $T_j \in \mathcal{T}_{\lambda M^j}$ for some $\lambda > 0$. Then, for any $j \in \mathbb{N}$,

$$\left\| \{T_j(M^{-j}k)\}_k \right\|_{\ell_{p,M^j}} \le C \|T_j\|_p$$

where the constant C depends only on p, d, and λ .

Proof. In the case $p = \infty$, the proof is obvious. The case $1 \le p < \infty$ directly follows from the following Marcinkiewicz-Zygmund type inequality (see [29])

$$\sum_{j=1}^{m} |T_n(\tau_j)|^p \le (p+1)\frac{e}{2} \left(2n + \frac{1}{\delta}\right) \int_0^1 |T_n(x)|^p dx,$$

where T_n is a univariate trigonometric polynomial of degree at most $n, -1/2 \leq \tau_1 < \tau_2 < \cdots < \tau_m < 1/2$, and $\delta = \min\{\tau_2 - \tau_1, \tau_3 - \tau_2, \dots, \tau_m - \tau_{m-1}, 1 - (\tau_m - \tau_1)\}$.

Lemma 15 Let $1 \le p \le \infty$, $N \ge 0$, $\delta \in (0, 1/2)$, $\widetilde{\varphi} \in \mathcal{S}'_{N,p}$, and $f \in \mathbb{B}^{d/p+N}_{p,1}(M)$. Suppose that the polynomials T_{μ} , $\mu \in \mathbb{Z}_+$, are such that spec $T_{\mu} \subset D(M^{\mu})$ and

$$||f - T_{\mu}||_p \le \sigma E_{\delta M^{\mu}}(f)_p$$

with some constant σ independent of f and μ . Then the sequence $\{\langle T_{\mu}, \tilde{\varphi}_j(\cdot - M^{-j}k) \rangle\}_{\mu=0}^{\infty}$ converges uniformly with respect to $k \in \mathbb{Z}^d$ and $j \in \mathbb{N}$, and the limit does not depend on the choice of polynomials T_{μ} . Moreover, for all $n \in \mathbb{N}$,

$$\sum_{\mu=n}^{\infty} \|\{\langle T_{\mu+1} - T_{\mu}, \widetilde{\varphi}_j(\cdot - M^{-j}k)\rangle\}_k\|_{\ell_{p,M^j}} \le Cm^{-(\frac{1}{p} + \frac{N}{d})j} \sum_{\mu=n}^{\infty} m^{(\frac{1}{p} + \frac{N}{d})\mu} E_{\delta M^{\mu}}(f)_p,$$

where the constant C depends only on d, p, M, and σ .

Proof. Let $n \ge j$, $n \in \mathbb{N}$. Using Lemma 14, condition 35, we obtain

$$\sum_{\mu=n}^{\infty} \|\{\langle T_{\mu+1}, \widetilde{\varphi}_{j}(\cdot - M^{-j}k)\rangle - \langle T_{\mu}, \widetilde{\varphi}_{j}(\cdot - M^{-j}k)\rangle\}_{k}\|_{\ell_{p,M^{j}}} = \sum_{\mu=n}^{\infty} \|\{\langle T_{\mu+1} - T_{\mu}, \widetilde{\varphi}_{j}(\cdot - M^{-j}k)\rangle\}_{k}\|_{\ell_{p,M^{j}}} = \sum_{\mu=n}^{\infty} \|\{\langle T_{\mu+1}^{-} - T_{\mu}^{-}\rangle * \widetilde{\varphi}_{j}(M^{-j}k)\}_{k}\|_{\ell_{p,M^{j}}}$$

$$\leq m^{-\frac{j}{p}} \sum_{\mu=n}^{\infty} m^{\frac{\mu}{p}} \|\{\langle T_{\mu+1}^{-} - T_{\mu}^{-}\rangle * \widetilde{\varphi}_{j}(M^{-\mu}k)\}_{k}\|_{\ell_{p,M^{\mu}}} \leq C_{1}m^{-\frac{j}{p}} \sum_{\mu=n}^{\infty} m^{\frac{\mu}{p}} \|\langle T_{\mu+1}^{-} - T_{\mu}^{-}\rangle * \widetilde{\varphi}_{j}\|_{p}$$

$$\leq C_{2}m^{-(\frac{1}{p} + \frac{N}{d})j} \sum_{\mu=n}^{\infty} m^{(\frac{1}{p} + \frac{N}{d})\mu} \|T_{\mu+1}^{-} - T_{\mu}^{-}\|_{p} \leq C_{2}m^{-(\frac{1}{p} + \frac{N}{d})j} \sum_{\mu=n}^{\infty} m^{(\frac{1}{p} + \frac{N}{d})\mu} E_{\delta M^{\mu}}(f)_{p}.$$
(36)

The latter series is convergent since $f \in \mathbb{B}_{p,1}^{d/p+N}(M)$, which yields that the sequence $\{\langle T_{\mu}, \widetilde{\varphi}_j(\cdot - M^{-j}k)\rangle\}_{\mu=1}^{\infty}$ is convergent for every $k \in \mathbb{Z}^d$ and $j \in \mathbb{N}$. By analogy with (36), it is also easy to check that the limit does not depend on the choice of functions T_{μ} .

In the previous section, the operator

$$Q_j(f,\varphi_j,\widetilde{\varphi}_j) = \frac{1}{m^j} \sum_{k \in D(M^j)} \langle f, \widetilde{\varphi}_j(\cdot - M^{-j}k) \rangle \varphi_j(\cdot - M^{-j}k),$$

was considered for functions f whose Fourier coefficients decay sufficiently fast. In particular, supposing that (10) holds and $f \in A_q^{\gamma}$ with $\gamma \ge N$, we defined the inner product by

$$\langle f, \widetilde{\varphi}_j(\cdot - M^{-j}k) \rangle = \sum_{l \in \mathbb{Z}^d} \widehat{f}(l) \overline{\widehat{\varphi}_j(l)} e^{2\pi i (k, M^{*-j}l)}.$$
(37)

Taking into account Lemma 15 and using condition (35), we extend the functional $\langle f, \tilde{\varphi}_j(\cdot - M^{-j}k) \rangle$ from $f \in A_q^{\gamma}$ to the Besov spaces $\mathbb{B}_{p,1}^{d/p+N}(M)$ as follows.

Definition 16 Let $1 \leq p \leq \infty$, $N \geq 0$, $\tilde{\varphi} \in S'_{N,p}$, and the polynomials T_{μ} be as in Lemma 15. For every $f \in \mathbb{B}_{p,1}^{d/p+N}(M)$ and $k \in \mathbb{Z}^d$, we set

$$\langle f, \widetilde{\varphi}_j(\cdot - M^{-j}k) \rangle := \lim_{\mu \to \infty} \langle T_\mu, \widetilde{\varphi}_j(\cdot - M^{-j}k) \rangle, \quad j \in \mathbb{N}.$$

Now, if $\widetilde{\varphi}\in S_{N,p}',$ then the quasi-projection operators

$$Q_j(f,\varphi,\widetilde{\varphi}) = \sum_{k \in \mathbb{Z}^d} \langle f, \widetilde{\varphi}_j(\cdot - M^{-j}k) \rangle \varphi_j(\cdot - M^{-j}k)$$

are defined on the space $\mathbb{B}_{p,1}^{d/p+N}(M)$ for a wide class of appropriate functions φ .

Note that below we will consider the operators $Q_j(f, \varphi, \widetilde{\varphi})$ for the sequences $\{\widetilde{\varphi}_j\}_j$ belonging to \mathcal{L}_q . In this case, the inner product $\langle f, \widetilde{\varphi}_j(\cdot - M^{-j}k) \rangle$ has sense for any $f \in L_p$, 1/p + 1/q = 1. As usual, we have $\langle f, \widetilde{\varphi}_j(\cdot - M^{-j}k) \rangle = \int_{\mathbb{T}^d} f(t) \overline{\widetilde{\varphi}_j}(t - M^{-j}k) dt$.

In what follows, a Fourier multiplier operator associated with a function φ_j is denoted by S_{φ_j} , i.e. for any function $f \in L_p$, $1 \le p \le \infty$, we set

$$S_{\varphi_j}(f;x) := \sum_{k \in \mathbb{Z}^d} \widehat{\varphi_j}(k) \widehat{f}(k) e^{2\pi i (k,x)}.$$

Denote also

$$K_{\varphi_j,q} := \sup_{\|f\|_q \le 1} \|S_{\varphi_j}(f; \cdot)\|_q$$

The standard example of such operators is the partial sums of Fourier series. For example, if $\widehat{\varphi_j}(\xi) = \chi_{M^j[-\frac{1}{2},\frac{1}{2})^d}(\xi)$, then S_{φ_j} represents the rectangular partial sums of Fourier series and

$$K_{\varphi_j,q} \asymp \begin{cases} 1, & 1 < q < \infty, \\ j^d, & q = 1 \text{ or } \infty. \end{cases}$$

We will need the following two auxiliary lemmas.

Lemma 17 Let $1 \leq p \leq \infty$, 1/p + 1/q = 1, $\{a_k\}_{k \in D(M^j)} \in \mathbb{C}$, and $\{\varphi_j\}_j \in \mathcal{B}$. Then, for any $j \in \mathbb{N}$,

$$\left\|\frac{1}{m^{j}}\sum_{k\in D(M^{j})}a_{k}\varphi_{j}(\cdot-M^{-j}k)\right\|_{p} \leq CK_{\varphi_{j},q} \left\|\{a_{k}\}_{k}\right\|_{\ell_{p,M^{j}}}.$$

where the constant C does not depend on j and $\{a_k\}$.

Proof. Consider the case $1 \le p < \infty$. By duality, we can find a function g_j such that $||g_j||_q \le 1$ and

$$\left\|\sum_{k\in D(M^{j})}a_{k}\varphi_{j}(\cdot - M^{-j}k)\right\|_{p} = \left|\left\langle\sum_{k\in D(M^{j})}a_{k}\varphi_{j}(\cdot - M^{-j}k),g_{j}\right\rangle\right|$$

$$= \left|\sum_{k\in D(M^{j})}a_{k}\langle\varphi_{j}(\cdot - M^{-j}k),g_{j}\rangle\right|.$$
(38)

Applying Hölder's inequality and Lemma 14, taking into account that $\langle \varphi_j(\cdot - M^{-j}k), g_j \rangle = \varphi_j * g_j^-(-M^{-j}k)$ and $\varphi_j * g_j^- \in \mathcal{T}_{RM^j}$, we obtain

$$\sum_{k \in D(M^{j})} |a_{k} \langle \varphi_{j}(\cdot - M^{-j}k), g_{j} \rangle| \leq \left(\sum_{k \in D(M^{j})} |a_{k}|^{p} \right)^{\frac{1}{p}} \left(\sum_{k \in D(M^{j})} |\langle \varphi_{j}(\cdot - M^{-j}k), g_{j} \rangle|^{q} \right)^{\frac{1}{q}}$$

$$\leq C \left(\sum_{k \in D(M^{j})} |a_{k}|^{p} \right)^{\frac{1}{p}} m^{j/q} \|\varphi_{j} * g_{j}^{-}\|_{q} \leq C \left(\sum_{k \in D(M^{j})} |a_{k}|^{p} \right)^{\frac{1}{p}} m^{j/q} K_{\varphi_{j},q} \|g_{j}\|_{q} \qquad (39)$$

$$\leq C m^{j} K_{\varphi_{j},q} \|\{a_{k}\}_{k}\|_{\ell_{p,M^{j}}}.$$

Then, combining (38) and (39), we prove the lemma for $p \neq \infty$. In the case $p = \infty$, the proof is similar. \diamond

Lemma 18 Let $1 \le p \le \infty$, 1/p + 1/q = 1, and $\{\widetilde{\varphi}_j\}_j \in \mathcal{L}_q$. Then, for any $f \in L_p$ and $j \in \mathbb{N}$, we have

$$\left\|\left\{\langle f, \widetilde{\varphi}_j(\cdot - M^{-j}k)\rangle\right\}_k\right\|_{\ell_{p,M^j}} \le \|\widetilde{\varphi}_j\|_{\mathcal{L}_{q,j}}\|f\|_p.$$

Proof. In the case $p = \infty$, the proof is obvious since $\|\widetilde{\varphi}_j\|_{\mathcal{L}_{1,j}} = \|\widetilde{\varphi}_j\|_1$. For $p < \infty$, we have

$$\begin{split} \sum_{k \in D(M^j)} |\langle f, \widetilde{\varphi}_j(\cdot - M^{-j}k) \rangle|^p \Big)^{\frac{1}{p}} \\ &= \left(\sum_{k \in D(M^j)} \left| \sum_{l \in D(M^j)} \int_{\frac{l_1}{m_1^j}}^{\frac{l_1+1}{m_1^j}} dx_1 \cdots \int_{\frac{l_d}{m_d^j}}^{\frac{l_d+1}{m_d^j}} f(x) \overline{\widetilde{\varphi}_j}(x - M^{-j}k) dx_d \right|^p \right)^{\frac{1}{p}} \\ &= \left(\sum_{k \in D(M^j)} \left| \int_{M^{-j} \mathbb{T}^d} \sum_{l \in D(M^j)} f(x + M^{-j}l) \overline{\widetilde{\varphi}_j}(x - M^{-j}(k - l)) dx \right|^p \right)^{\frac{1}{p}} \\ &\leq \int_{M^{-j} \mathbb{T}^d} \left(\sum_{k \in D(M^j)} \left| \sum_{l \in D(M^j)} f(x + M^{-j}l) \overline{\widetilde{\varphi}_j}(x - M^{-j}(k - l)) \right|^p \right)^{\frac{1}{p}} dx, \end{split}$$

where the last formula follows from Minkowski's inequality.

Next, applying Young's inequality for the discrete convolution and Hölder's inequality, we derive that the last expression can be estimated from above by

$$\begin{split} &\int_{M^{-j}\mathbb{T}^d} \left(\sum_{l\in D(M^j)} |f(x+M^{-j}l)|^p \right)^{\frac{1}{p}} \sum_{k\in D(M^j)} |\widetilde{\varphi}_j(x-M^{-j}k)| dx \\ &\leq \|f\|_p \left(\int_{M^{-j}\mathbb{T}^d} \left(\sum_{k\in D(M^j)} |\widetilde{\varphi}_j(x-M^{-j}k)| \right)^q dx \right)^{\frac{1}{q}} = m^{j/p} \|\widetilde{\varphi}_j\|_{\mathcal{L}_{q,j}} \|f\|_p, \end{split}$$

which proves the lemma. \diamond

Now, we are ready to formulate and prove the main results of this section. We start from the case of strictly compatible functions/distributions φ_j and $\tilde{\varphi}_j$.

Theorem 19 Let $1 \leq p \leq \infty$, 1/p + 1/q = 1, and $N \geq 0$. Suppose that $\{\widetilde{\varphi}_j\}_j \in \mathcal{S}'_{N,p}, \{\varphi_j\}_j \in \mathcal{B}$ with respect to the parameter $\delta \in (0, 1/2)$, and φ_j and $\widetilde{\varphi}_j$ are strictly compatible with respect to δ . Then, for any $f \in \mathbb{B}^{d/p+N}_{p,1}(M)$ and $j \in \mathbb{N}$, we have

$$\|f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)\|_p \le CK_{\varphi_j,q}m^{-j(\frac{1}{p} + \frac{N}{d})}\sum_{\nu=j}^{\infty}m^{(\frac{1}{p} + \frac{N}{d})\nu}E_{\delta M^{\nu}}(f)_p,\tag{40}$$

if, additionally, $\{\widetilde{\varphi}_j\}_j \in \mathcal{L}_q$, then for any $f \in L_p$, we have

$$\|f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)\|_p \le CK_{\varphi_j,q} \|\widetilde{\varphi}_j\|_{\mathcal{L}_{q,j}} E_{\delta M^j}(f)_p, \tag{41}$$

where the constant C does not depend on f and j.

Proof. Let $T_j \in \mathcal{T}_{\delta M^j}$ be such that $||f - T_j||_p = E_{\delta M^j}(f)_p$, then

$$\left\| f - \frac{1}{m^{j}} \sum_{k \in D(M^{j})} \langle f, \widetilde{\varphi}_{j}(\cdot - M^{-j}k) \rangle \varphi_{j}(\cdot - M^{-j}k) \right\|_{p}$$

$$\leq \| f - T_{j} \|_{p} + \left\| T_{j} - \frac{1}{m^{j}} \sum_{k \in D(M^{j})} \langle T_{j}, \widetilde{\varphi}_{j}(\cdot - M^{-j}k) \rangle \varphi_{j}(\cdot - M^{-j}k) \right\|_{p}$$

$$+ \left\| \frac{1}{m^{j}} \sum_{k \in D(M^{j})} \langle f - T_{j}, \widetilde{\varphi}_{j}(\cdot - M^{-j}k) \rangle \varphi_{j}(\cdot - M^{-j}k) \right\|_{p} := I_{1} + I_{2} + I_{3}.$$

$$(42)$$

To estimate I_2 , we note that by Theorem 12,

$$T_j(x) - \frac{1}{m^j} \sum_{k \in D(M^j)} \langle T_j, \widetilde{\varphi}_j(\cdot - M^{-j}k) \rangle \varphi_j(x - M^{-j}k) = 0,$$

which implies that

$$I_2 = 0.$$
 (43)

Consider I_3 . Using Lemmas 17 and 15, we derive

$$I_{3} \leq C_{1}K_{\varphi_{j},q} \|\{\langle f - T_{j}, \tilde{\varphi}_{j}(\cdot - M^{-j}k)\rangle\}_{k}\|_{\ell_{p,M^{j}}} \leq C_{2}K_{\varphi_{j},q} \sum_{\mu=n}^{\infty} \|\{\langle T_{\mu+1} - T_{\mu}, \tilde{\varphi}_{j}(\cdot - M^{-j}k)\rangle\}_{k}\|_{\ell_{p,M^{j}}} \leq C_{3}K_{\varphi_{j},q} \sum_{\mu=n}^{\infty} m^{\mu(\frac{N}{d} + \frac{1}{p})} E_{\delta M^{\mu}}(f)_{p}.$$

$$(44)$$

Then, combining (42), (43), and (44), we prove (40).

To obtain inequality (41), it is sufficient to use inequalities (42) and (43) as well as the following estimate

$$I_3 \le C_4 K_{\varphi_j,q} \|\{\langle f - T_j, \widetilde{\varphi}_j(\cdot - M^{-j}k)\rangle\}_k\|_{\ell_{p,M^j}} \le C_5 K_{\varphi_j,q} \|\widetilde{\varphi}_j\|_{\mathcal{L}_{q,j}} \|f - T_j\|_p,$$
(45)

which easily follows from Lemmas 17 and 18. \diamond

Applying Hausdorff–Young's inequality (21) to the right-hand sides of (40) and (41), we derive the following improvements of the error estimate given in Theorem 12.

Corollary 20 Let $2 \leq p \leq \infty$, 1/p + 1/q = 1, and $N \geq 0$. Suppose that $M = \lambda I_d$, $\lambda > 1$, $\{\widetilde{\varphi}_j\}_j \in \mathcal{S}'_{N,p}, \{\varphi_j\}_j \in \mathcal{B}$ with respect to the parameter $\delta \in (0, 1/2)$, and φ_j and $\widetilde{\varphi}_j$ are strictly compatible with respect to δ . Then, for any $f \in \mathbb{B}_{p,1}^{d/p+N}(M)$ and $j \in \mathbb{N}$, we have

$$\|f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)\|_p \le CK_{\varphi_j,q}\lambda^{-j(\frac{d}{p}+N)}\sum_{\nu=j}^{\infty}\lambda^{(\frac{d}{p}+N)\nu} \left(\sum_{|r|\ge\delta\lambda^{\nu}}|\widehat{f}(r)|^q\right)^{1/q}$$

if, additionally, $\{\widetilde{\varphi}_j\}_j \in \mathcal{L}_q$, then

$$\|f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)\|_p \le CK_{\varphi_j,q} \|\widetilde{\varphi}_j\|_{\mathcal{L}_{q,j}} \left(\sum_{|r|\ge\delta\lambda^j} |\widehat{f}(r)|^q\right)^{1/q},$$

where the constant C does not depend on f and j.

In light of Proposition 13, it is not difficult to derive the following improvements of Theorem 19, in which we replace the best approximation $E_{\delta M^j}(f)_p$ by

$$E_{M^j}^*(f)_p := \inf\left\{ \|f - T\|_p : \operatorname{spec} T \subset D(M^j) \right\}, \quad j \in \mathbb{N}.$$

Proposition 21 If under the assumptions of Theorem 19, equality (28) holds for all $l \in D(M^j)$ and spec $\varphi_j \subset D(M^j)$, then, for any $f \in \mathbb{B}_{p,1}^{d/p+N}(M)$ and $j \in \mathbb{N}$, we have

$$\|f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)\|_p \le CK_{\varphi_j,q}m^{-j(\frac{1}{p}+\frac{N}{d})}\sum_{\nu=j}^{\infty}m^{(\frac{1}{p}+\frac{N}{d})\nu}E^*_{M^{\nu}}(f)_p$$

if, additionally, $\{\widetilde{\varphi}_j\}_j \in \mathcal{L}_q$, then for any $f \in L_p$, we have

$$\|f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)\|_p \le CK_{\varphi_j,q} \|\widetilde{\varphi}_j\|_{\mathcal{L}_{q,j}} E^*_{M^j}(f)_p,$$

where the constant C does not depend on f and j.

Now, we consider the case of weakly compatible functions/distributions φ_j and $\tilde{\varphi}_j$.

Theorem 22 Let $2 \leq p \leq \infty$, 1/p + 1/q = 1, and $N \geq 0$. Suppose that $\{\widetilde{\varphi}_j\}_j \in \mathcal{S}'_{N,p}, \{\varphi_j\}_j \in \mathcal{B}$ with respect to the parameter $\delta \in (0, 1/2)$, and φ_j and $\widetilde{\varphi}_j$ are weakly compatible of order s > 0. Then, for any $f \in \mathbb{B}_{p,1}^{d/p+N}(M)$ and $j \in \mathbb{N}$, we have

$$\|f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)\|_p \le C \left(\|M^{-j}\|^s \|f\|_{A^s_q,j}^{In} + K_{\varphi_j,q} m^{-j(\frac{1}{p} + \frac{N}{d})} \sum_{\nu=j}^{\infty} m^{(\frac{1}{p} + \frac{N}{d})\nu} E_{\delta M^{\nu}}(f)_p \right)$$
(46)

if, additionally, $\{\widetilde{\varphi}_j\}_j \in \mathcal{L}_q$, then for any $f \in L_p$, we have

$$\|f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)\|_p \le C\left(\|M^{-j}\|^s \|f\|_{A^s,j}^{In} + K_{\varphi_j,q}\|\widetilde{\varphi}_j\|_{\mathcal{L}_{q,j}} E_{\delta M^j}(f)_p\right),\tag{47}$$

where the constant C does not depend on f and j.

Proof. First, we prove inequality (46). Consider the de la Vallée–Poussin means $V_j(f)$ defined by

$$V_j(f)(x) = \sum_{k \in \mathbb{Z}^d} v_{\delta}(M^{-j}k)\widehat{f}(k)e^{2\pi i(k,x)},$$

where $v_{\delta} \in C^{\infty}(\mathbb{R}^d)$, $v_{\delta}(\xi) = 1$ if $|\xi| < \delta$ and $v_{\delta}(\xi) = 0$ if $\xi \notin (-\frac{1}{2}, \frac{1}{2})^d$. As usual, we have for any $j \in \mathbb{N}$ that

$$\|f - V_j(f)\|_p \le (1 + \|V_j\|_1) E_{\delta M^j}(f)_p \le c E_{\delta M^j}(f)_p,$$
(48)

where the constant c does not depend on j and f.

Repeating the proof of Theorem 19 with $V_j(f)$ instead of the polynomials of the best approximation T_j and using (48), we derive

$$\left\| f - \frac{1}{m^{j}} \sum_{k \in D(M^{j})} \langle f, \widetilde{\varphi}_{j}(\cdot - M^{-j}k) \rangle \varphi_{j}(\cdot - M^{-j}k) \right\|_{p}$$

$$\leq \left\| V_{j}(f) - \frac{1}{m^{j}} \sum_{k \in D(M^{j})} \langle V_{j}(f), \widetilde{\varphi}_{j}(\cdot - M^{-j}k) \rangle \varphi_{j}(\cdot - M^{-j}k) \right\|_{p}$$

$$+ C_{1}K_{\varphi_{j},q}m^{-j(\frac{1}{p} + \frac{N}{d})} \sum_{\nu=j}^{\infty} m^{(\frac{1}{p} + \frac{N}{d})\nu} E_{\delta M^{\nu}}(f)_{p} := J_{1} + J_{2}.$$

$$(49)$$

By Theorem 9, taking into account that the Strang-Fix conditions of order s for φ_j and the weak compatibility conditions for φ_j and $\tilde{\varphi}_j$ of order s are satisfied (see the proof of Theorem 12), we derive

$$J_1 \le C_2 \|M^{-j}\|^s \|V_j(f)\|_{A^s_{q,j}}^{I_n} \le C_3 \|M^{-j}\|^s \|f\|_{A^s_{q,j}}^{I_n}.$$
(50)

Thus, combining (49) and (50), we prove (46).

The proof of estimate (47) is similar. One needs only to use inequality (45) instead of (44). \diamond

Next, using the Hausdorff-Young inequality, we obtain the following corollaries, which provide two shaper versions of Theorem 9.

Corollary 23 If under the assumptions of Theorem 22, $\{\widetilde{\varphi}_j\}_j \in \mathcal{L}_q \text{ and } f \in A_q^{\gamma}$, where $\gamma > 0$, then

$$\|f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)\|_p \le CK_{\varphi_j,q} \|M^{-j}\|^{\min\{s,\gamma\}} \|f\|_{A_q^{\gamma}}.$$

In particular, if $M = \lambda I_d$, $\sup_j K_{\varphi_j,q} < \infty$, and $\widehat{f}(n) = \mathcal{O}(|n|^{-\kappa})$ for some $\kappa > d/q$, then

$$||f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)||_p = \mathcal{O}(\lambda^{-j\min\{s,\kappa-d/q\}}).$$

Corollary 24 If under the assumptions of Theorem 22, $M = \lambda I_d$, $0 < s \leq d/p + N$, $f \in A_q^s \cap \mathbb{B}_{p,1}^{d/p+N}(M)$, then

$$\|f - Q_j(f,\varphi_j,\widetilde{\varphi}_j)\|_p \le CK_{\varphi_j,q}\lambda^{-js}.$$

Remark 25 Note that this result provides a shaper version of Theorem 9 because there exist functions $f \notin A_q^{\gamma}$, $\gamma > d/p + N$, for which conditions of Corollary 24 are valid. As an example in the case d = 1, one can take the function

$$f(x) = \sum_{k=1}^{\infty} \frac{e^{ik\log k}}{k^{\frac{1}{2} + \frac{1}{p} + N + \varepsilon}} e^{2\pi ikx}, \quad \varepsilon > 0.$$

It follows from [44, Ch. V, Theorem 4.2] that $f^{(N)} \in \operatorname{Lip}(\frac{1}{p} + \varepsilon)$ and, therefore, by the classical Jackson inequality (see, e.g., [39, p. 260]), we have that $E_{\lambda^{\nu}}(f)_p = \mathcal{O}(\lambda^{-\gamma\nu})$ with $\gamma = 1/p + N + \varepsilon$, which implies that $f \in B_{p,1}^{1/p+N}$. At the same time, $f \in A_q^s$ for $s < \gamma - 1/q$ and $f \notin A_q^{\gamma}$.

5 Examples

1. In fact, for a sequence of periodic distributions $\{\widetilde{\varphi}_j\}$ satisfying conditions (10) and such that $|\widehat{\varphi}_j(k)| \ge c > 0$ for $k \in \mathbb{Z}^d : |M^{*-j}k| \le \delta$ for any $j \in \mathbb{N}$ and some fixed $\delta \in (0, \frac{1}{2})$, an appropriate

strictly compatible sequence of trigonometric polynomials φ_j can be constructed via defining its Fourier coefficients by condition (28), namely

$$\overline{\widehat{\varphi_j}(k)} = \frac{1}{\widehat{\widetilde{\varphi_j}}(k)}, \quad k \in \mathbb{Z}^d : |M^{*-j}k| \le \delta$$

and $\widehat{\varphi_j}(k) = 0$ for others $k \in \mathbb{Z}^d$. Obviously, the sequence $\{\varphi_j\}_j$ belongs to \mathcal{B} , and hence we are under the assumptions of Theorem 12 or Theorem 19 (if $\{\widetilde{\varphi}_j\}_j \in \mathcal{S}'_{N,p}$ and M is diagonal). For instance, assume that $\widetilde{\varphi_j}$ is a periodic distribution corresponding to some differential operator. Namely, let

$$\widehat{\widetilde{\varphi}_j}(k) = \sum_{[\beta] \le N} c_\beta (2\pi i M^{*-j} k)^\beta, \quad N \in \mathbb{Z}_+, \quad c_0 \neq 0.$$

For any good enough function f, we have

$$\begin{split} \langle f, \widetilde{\varphi}_j(\cdot - M^{-j}k) \rangle &= \sum_{l \in \mathbb{Z}^d} \widehat{f}(l) \overline{\widetilde{\varphi}_j(l)} e^{2\pi i (M^{-j}k,l)} = \sum_{[\beta] \le N} \overline{c}_\beta \sum_{l \in \mathbb{Z}^d} \widehat{f}(l) (-2\pi i M^{*-j}l)^\beta e^{2\pi i (k,M^{*-j}l)} \\ &= \sum_{[\beta] \le N} \overline{c}_\beta [D^\beta f(-M^{-j}\cdot)](k) =: [Lf(M^{-j}\cdot)](k). \end{split}$$

This sequence of periodic distributions $\widetilde{\varphi}_j$ satisfies conditions (10). Since $\widehat{\widetilde{\varphi}_j}(k) = P(M^{*-j}k)$, where P is an algebraic polynomial and $P(\mathbf{0}) \neq 0$, there exists $\delta > 0$ such that $|\widehat{\widetilde{\varphi}_j}(k)| \geq c > 0$ whenever $k \in \mathbb{Z}^d : |M^{*-j}k| \leq \delta$. In particular, if N = 0 and $c_0 = 1$, then $\widehat{\widetilde{\varphi}_j}(k) = 1$ for $k \in \mathbb{Z}^d$. For the strict compatibility, one can take $\widehat{\varphi_j}(k) = 1$ for $k \in \mathbb{Z}^d : |M^{*-j}k| \leq \frac{1}{2}$ and $\widehat{\varphi_j}(k) = 0$ for other $k \in \mathbb{Z}^d$, i.e., $\{\varphi_j\}_j$ is a sequence of Dirichlet-type kernels.

2. Let $\widehat{\varphi}_{j}(k) = 1$ for $k \in \mathbb{Z}^{d}$. In order to achieve only the weak compatibility, we can take truncated Fejer-type kernels φ_{j} defined by

$$\widehat{\varphi_j}(k) = \begin{cases} 1 - C_F \| M^{*-j} k \|_{\infty}, & \text{if } | M^{*-j} k | \le \delta, \\ 0, & \text{otherwise,} \end{cases}$$

where $\delta \in (0, \frac{1}{2})$ and C_F is a positive real number. In this case

$$1 - \widehat{\widetilde{\varphi}_j}(k)\widehat{\varphi_j}(k) = C_F \|M^{*-j}k\|_{\infty} \le C_F |M^{-j}k|, \quad k \in D(M^{*j}),$$

which means that compatibility condition (12) is valid for s = 1. Thus, we are in case of Theorem 22.

Alongside, consider the following Fejer-type kernels defined by

$$\widehat{\varphi_j}(k) = \begin{cases} 1 - C_F \| M^{*-j} k \|_{\infty}, & \text{if } \| M^{*-j} k \|_{\infty} \le 1, \\ 0, & \text{otherwise.} \end{cases}$$

In this case, we have to check the Strang-Fix conditions only for points $M^{*j}n + r$, where $||n||_{\infty} = 1$ and $r \in D(M^{*j})$. Then

$$|\widehat{\varphi_j}(M^{*j}n+r)| = |1 - \|n + M^{*-j}r\|_{\infty}| = |\|n\|_{\infty} - \|n + M^{*-j}r\|_{\infty}| \le \|M^{*-j}r\|_{\infty} \le |M^{-j}r|_{\infty}.$$

Therefore, the Strang-Fix condition of order 1 for the sequence $\{\varphi_j\}_j$ is satisfied. So, we are under assumptions of Theorem 6 or Theorem 9 with s = 1.

3. Next, we discuss sequences $\{\varphi_j\}_j$ obtained by periodization of splines, which are applicable in Theorem 6 or 9. We restrict ourselves to the case d = 1, and M is an integer greater than 1. Assume that φ^s is a B-spline of an even order s, whose Fourier transform is given by

$$\widehat{\varphi^s}(\xi) = \left(\frac{\sin \pi\xi}{\pi\xi}\right)^s.$$
(51)

Recall that $\operatorname{supp} \varphi^s \subset [-s/2, s/2]$ and the non-periodic Strang-Fix conditions of order s are valid for φ^s . Therefore, after periodization of φ^s by (9), we obtain the functions $\varphi^s_j(x)$ whose Fourier coefficients are

$$\widehat{\varphi_j^s}(k) = \left(\frac{\sin \pi \frac{k}{M^j}}{\pi \frac{k}{M^j}}\right)^s.$$

In fact, after periodization for a big enough j (such that $\left[-\frac{s/2}{M^j}, \frac{s/2}{M^j}\right] \in \left[-1/2, 1/2\right]$) we have $\varphi_j^s(x) = \varphi^s(M^j x)$ for $x \in \left[-1/2, 1/2\right]$, i.e. φ_j^s is a contracted B-spline φ^s .

Now, check that the periodic Strang-Fix conditions of order s for the sequence $\{\varphi_j^s\}_j$ are valid and the corresponding sequence $\{b_n\}_n$ from (11) belongs to ℓ_q for any q > 1. Indeed, let $n \neq 0$ and $r \in D(M^j)$, then

$$|\widehat{\varphi_{j}^{s}}(M^{j}n+r)| = \left|\frac{\sin \pi \frac{M^{j}n+r}{M^{j}}}{\pi \frac{M^{j}n+r}{M^{j}}}\right|^{s} = \left|\frac{\sin \pi \frac{r}{M^{j}}}{\pi (n+\frac{r}{M^{j}})}\right|^{s} \le \left|\frac{\frac{r}{M^{j}}}{n+\frac{r}{M^{j}}}\right|^{s} \le \frac{2^{s}}{(2|n|-1)^{s}} \left|\frac{r}{M^{j}}\right|^{s}.$$

Also, we have that $b_n = \frac{2^s}{(2|n|-1)^s}$, $n \neq 0$, which implies that $\{b_n\}_n \in \ell_q$.

Next, for a given sequence $\{\widetilde{\varphi}_j\}_j$, we can consider linear combinations of splines in order to construct an appropriate sequence $\{\varphi_j\}_j$. For instance, in order to reduce noise contribution, it is reasonable to use smoothed version of samples instead of the exact samples of f (see, e.g. [43]). Let $\widetilde{\varphi}_j$ be such that

$$\langle f, \widetilde{\varphi}_j(\cdot - M^{-j}k) \rangle = \frac{1}{2}f(M^{-j}k) + \frac{1}{4}f(M^{-j}(k+1)) + \frac{1}{4}f(M^{-j}(k-1)).$$

This means that $\widehat{\widetilde{\varphi}_j}(k) = \frac{1}{2} + \frac{1}{2}\cos 2\pi \frac{k}{M^j}$. Thus, condition (10) is satisfied with N = 0. Consider a periodized B-spline as a dual sequence $\{\varphi_j^s\}$, whose Fourier coefficients are defined by (51). Therefore,

$$1 - \widehat{\widetilde{\varphi}_j}(k)\widehat{\varphi_j^s}(k) = 1 - \left(\frac{1}{2} + \frac{1}{2}\cos 2\pi \frac{k}{M^j}\right) \left(\frac{\sin \pi \frac{k}{M^j}}{\pi \frac{k}{M^j}}\right)^s$$

Since, by Taylor's formula, $f_1(x) := 1 - \left(\frac{1}{2} + \frac{1}{2}\cos 2\pi x\right) \left(\frac{\sin \pi x}{\pi x}\right)^s = \frac{1}{6} \left(6\pi^2 + s\pi^2\right) x^2 + \mathcal{O}(x^4)$ as $x \to 0$, it is clear that the order of compatibility cannot be better than 2. Thus, using Lagrange's reminder for the case s = 2, we can state that

$$|f_1(x)| \le \frac{|x|^2}{2!} \max_{x \in [-1/2, 1/2]} |f_1''(x)| = \frac{4}{3} \pi^2 |x|^2,$$

which implies

$$|1 - \widehat{\widetilde{\varphi_j}}(k)\widehat{\varphi_j^s}(k)| \le \frac{4}{3}\pi^2 \left|\frac{k}{M^j}\right|^2, \quad k \in D(M^{*j}).$$

Now, consider a linear combination of the shifted splines φ_j^s , which allows to provide a better order of compatibility. For instance, let $\varphi_j := u_1 \varphi_j^s + \frac{u_2}{2} \varphi_j^s (\cdot + \frac{1}{M^j}) + \frac{u_2}{2} \varphi_j^s (\cdot - \frac{1}{M^j})$. The Fourier coefficients of φ_j are

$$\widehat{\varphi_j}(k) = \left(u_1 \left(\frac{\sin \pi \frac{k}{M^j}}{\pi \frac{k}{M^j}}\right)^s + u_2 \cos \left(2\pi \frac{k}{M^j}\right) \left(\frac{\sin \pi \frac{k}{M^j}}{\pi \frac{k}{M^j}}\right)^s\right). \tag{52}$$

To find the compatibility order, we consider the function

$$f_2(x) := 1 - \left(\frac{1}{2} + \frac{1}{2}\cos 2\pi x\right) \left(\frac{\sin \pi x}{\pi x}\right)^s (u_1 + u_2\cos(2\pi x)).$$

From its Taylor's formula near the origin, we get

$$f_2(x) = (1 - u_1 - u_2) + \frac{\pi^2}{6} x^2 (u_1 s + 6u_1 + u_2 s + 18u_2) + \mathcal{O}(x^4).$$

It is clear that for s = 4, $u_1 = 11/6$, $u_2 = -5/6$, the first two terms are vanished. In order to get constant value b_0 from condition (12), Moreover, using Taylor's reminder, we have

$$|f_2(x)| \le \frac{|x|^4}{4!} \max_{x \in [-1/2, 1/2]} |f_2^{(IV)}(x)| = \frac{32}{15} \pi^4 |x|^4.$$

This yields the weak compatibility of order 4 for $\{\varphi_j^s\}_j$ and $\{\widetilde{\varphi}_j\}_j$, i.e.,

$$|1 - \widehat{\widetilde{\varphi_j}}(k)\widehat{\varphi_j}(k)| \le \frac{32}{15}\pi^4 \left|\frac{k}{M^j}\right|^4, \quad k \in D(M^{*j}).$$

A similar procedure can be applied for the construction of a sequence $\{\varphi_j\}_j$, which is weakly compatible with a sequence of distributions $\{\tilde{\varphi}_j\}_j$ corresponding to some differential operator. For instance, assume that

$$\widehat{\widetilde{\varphi}_j}(k) = 1 + c_1 (2\pi i M^{-j} k)^2$$

and $\widehat{\varphi_j}(k)$ are defined by (52) with s = 4. Let us try to achieve the weak compatibility of order 4 for the corresponding sequences $\{\varphi_j\}_j$ and $\{\widetilde{\varphi_j}\}_j$. For this, it is enough to apply Taylor's formula to the function

$$f_3(x) := 1 - \left(1 + c_1(2\pi i x)^2\right) \left(\frac{\sin \pi x}{\pi x}\right)^4 \left(u_1 + u_2 \cos(2\pi x)\right)$$

and chose $u_1 = 2c_1 + 4/3$ and $u_2 = 1 - u_1$ in (52). In particular, if $c_1 = -1/4$, then

$$|1 - \widehat{\widetilde{\varphi}_j}(k)\widehat{\varphi_j}(k)| \le \frac{7}{15}\pi^4 \left|\frac{k}{M^j}\right|^4, \quad k \in D(M^{*j}),$$

which implies the required fact.
