# POLYNOMIAL FUNCTIONS OVER DUAL NUMBERS OF SEVERAL VARIABLES

#### Abstract

Let $k$ be a positive integer. For a commutative ring $R$, the ring of dual numbers of $k$ variables over $R$ is the quotient ring $R\left[x_{1}, \ldots, x_{k}\right] / I$, where $I$ is the ideal generated by the set $\left\{x_{i} x_{j} \mid i, j \in\{1, \ldots, k\}\right\}$. This ring can be viewed as $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ with $\alpha_{i} \alpha_{j}=0$, where $\alpha_{i}=x_{i}+I$ for $1 \leq i, j \leq k$. We investigate the polynomial functions of $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ whenever $R$ is a finite commutative ring. We derive counting formulas for the number of polynomial functions and polynomial permutations on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ depending on the order of the pointwise stabilizer of the subring of constants $R$ in the group of polynomial permutations of $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$. Further, we show that the stabilizer group of $R$ is independent of the number of variables $k$. Moreover, we prove that a function $F$ on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ is a polynomial function if and only if a system of linear equations on $R$ that depends on $F$ has a solution.


## 1. Introduction

Let $R$ be a finite commutative ring with unity. Then a function $F: R \longrightarrow R$ is said to be a polynomial function on $R$ if there exists a polynomial $f \in R[x]$ such that $f(a)=F(a)$ for every $a \in R$. In this case, we say that $F$ is the induced function of $f$ on $R$ and $f$ represents (induces) $F$. Moreover, if $F$ is a bijection, we say that $F$ is a polynomial permutation and $f$ is a permutation polynomial. If $R$ is a finite field, it can be shown easily by using Lagrange interpolation that every function on $R$ is a polynomial function. The situation is different when $R$ is not a field and it is somewhat more complicated to study the properties of polynomial functions on such a ring. We denote by $\mathcal{F}(R)$ the set of polynomial functions on $R$, which is evidently a monoid under the composition of functions. Moreover, its subset of polynomial permutations forms a group and we denote it by $\mathcal{P}(R)$.

Kempner [9] was the first mathematician who studied polynomial functions on a finite ring which is not a field. He studied extensively the polynomial functions on $\mathbb{Z}_{m}$, the ring of integers modulo $m$. However, his arguments and results were somewhat lengthy and sophisticated. Therefore, for a long time some researchers [8, 14, 11] followed up his work, obtained simpler proofs and contributed to the subject as well. Meanwhile, some others were interested in the group of polynomial permutations modulo $p^{n}$ [13, 7]. Other mathematicians have generalized the concepts of polynomial functions on $\mathbb{Z}_{m}$ into other rings, for example, local principal ideal rings 12 and Galois rings 4. Later, Frisch [6 characterized the polynomial functions over a

[^0]more general class of local rings. Surprisingly, all rings examined in [4, 12, 9] are contained in this class.

In a recent paper [1], the authors considered the polynomial functions of the ring $R[x] /\left(x^{2}\right)$, the ring of dual numbers over $R$. In particular, they examined extensively the properties of the polynomial functions on dual numbers over the integers modulo $p^{n}$ by relating them to the polynomial functions modulo $p^{n}$. However, dual numbers over finite local rings that are not fields are not contained in the class of rings covered in [6], (see Proposition 2.9).

It should be mentioned that some mathematicians examined the properties of polynomial functions on weaker structures such as semi groups [10] and monoids [17.

The importance of studying polynomial functions emanates from their intrinsic applications in other areas. For example, permutation polynomials modulo $p^{n}$ have been employed widely in computer science (see for example [15, 16]). Also, they occur as isomorphisms of combinatorial objects with vertex set $\mathbb{Z}_{p^{n}}$ [2, 3]. For this reason, we think that investigating the polynomial functions on new structures will give a good chance for new applications to come out.

In this paper, we are interested in the polynomial functions of the ring of dual numbers of several variables over a finite local ring $R$, that is, the ring $R\left[x_{1}, \ldots, x_{k}\right] / I$, where $I$ is the ideal generated by the set $\left\{x_{i} x_{j} \mid i, j \in\{1, \ldots, k\}\right\}$, alternatively, the ring $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ with $\alpha_{i} \alpha_{j}=0$. We relate the properties of the polynomial functions on such a ring to the polynomial functions on $R$ (see for example Theorems 3.4 and 4.1). Furthermore, we show that the pointwise stablizer of $R$ in the group of polynomial permutations on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ plays an essential role in the counting formulas of the polynomial functions and the polynomial permutations on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$. More generally, we show that the properties of the polynomial functions on $R[x] /\left(x^{2}\right)$ discussed in [1] can be carried over to those on the ring $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$.
Here is a summary of the paper. Section 2 contains some basics and notations. In Section 3, we characterize null polynomials on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$. Section 4 considers permutation polynomials and polynomial permutations on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$. Then, in Section 鲟, we consider a group of polynomial permutations on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ that stabilizes (fixes) the elements of $R$ pointwise, and derive some counting formulas in terms of the order of this stabilizer group. Finally, we obtain necessary and sufficient conditions for polynomial functions on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ in section 6

## 2. BASICS

In this section, we introduce some definitions and facts that appear in the paper frequently. Throughout this paper, let $k$ be a positive integer, and for $f \in R[x]$ let $f^{\prime}$ denote its first formal derivative.

Definition 2.1. Let $A$ be a commutative ring, and $f \in A[x]$. Then:
(1) The polynomial $f$ gives rise to a polynomial function on $A$ by substitution for the variable. We use the notation $[f]_{A}$ for this function. We just write $[f]$ instead of $[f]_{A}$, when there is no confusion.
(2) If $[f]$ is a permutation of $A$, then we call $[f]$ is a polynomial permutation and $f$ a permutation polynomial on $A$.
(3) If $g \in A[x]$ and $[f]=[g]$, this means that $f$ and $g$ induce the same function on $A$ and we abbreviate this with $f \triangleq g$ on $A$.
(4) We define

$$
\begin{gathered}
\mathcal{F}(A)=\{[f] \mid f \in A[x]\}, \text { and } \\
\mathcal{P}(A)=\{[f] \mid[f] \text { is a permutation of } A \text { and } f \in A[x]\} .
\end{gathered}
$$

(5) If $R$ is a subring of $A$, and $f \in R[x]$, then $f$ gives rise to polynomial functions on $R$ and as well as on $A$. To distinguish between them we write $[f]_{R}$ and $[f]_{A}$.

Remark 2.2. Clearly, $\triangleq$ on $A$ is an equivalence relation on $A[x]$. Also, there is a bijective correspondence between the equivalence classes of $\triangleq$ and the polynomial functions on $A$. In particular, if $A$ is finite, then the number $|\mathcal{F}(A)|$ of different polynomial functions on $A$ equals the number of equivalence classes of $\triangleq$ on $A[x]$.

Definition 2.3. For a commutative ring $R$, the ring of dual numbers of $k$ variables over $R$ is the quotient ring $R\left[x_{1}, \ldots, x_{k}\right] / I$, where $I$ is the ideal generated by the set $\left\{x_{i} x_{j} \mid i, j \in\{1, \ldots, k\}\right\}$. We write $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ for $R\left[x_{1}, \ldots, x_{k}\right] / I$, where $\alpha_{i}$ represents $x_{i}+I$.

Remark 2.4. Note that every element of $R\left[x_{1}, \ldots, x_{k}\right] / I$ has a unique representation as an $R$-linear combination of $1, \alpha_{1}, \ldots, \alpha_{k}$. That is, $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ is a free $R$-algebra with basis $\left\{1, \alpha_{1}, \ldots, \alpha_{k}\right\}$. We call the coefficient of 1 the "constant coefficient". Also, $R$ is canonically embedded as a subring in $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ by $r \rightarrow r \cdot 1$, and we have

$$
R\left[\alpha_{1}, \ldots, \alpha_{k}\right]=\left\{r_{0}+\sum_{i=1}^{k} r_{i} \alpha_{i} \mid r_{0}, r_{i} \in R, \text { with } \alpha_{i} \alpha_{j}=0 \text { for } 1 \leq i, j \leq k\right\}
$$

It follows from this that every polynomial $f \in R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ has a unique representation $f=$ $f_{0}+\sum_{i=1}^{k} f_{i} \alpha_{i}$, where $f_{0}, f_{1}, \ldots, f_{k} \in R[x]$.

The following proposition summarizes some properties of $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ whose proof is immediate from Definition 2.3.

Proposition 2.5. Let $R$ be a commutative ring. Then the following hold.
(1) For $a_{0}, \ldots, a_{k}, b_{0}, \ldots, b_{k} \in R$, we have:
(a) $\left(a_{0}+\sum_{i=1}^{k} a_{i} \alpha_{i}\right)\left(b_{0}+\sum_{i=1}^{k} b_{i} \alpha_{i}\right)=a_{0} b_{0}+\sum_{i=1}^{k}\left(a_{0} b_{i}+b_{0} a_{i}\right) \alpha_{i} ;$
(b) $a_{0}+\sum_{i=1}^{k} a_{i} \alpha_{i}$ is a unit in $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ if and only if $a_{0}$ is a unit in $R$. In this case, $\left(a_{0}+\sum_{i=1}^{k} a_{i} \alpha_{i}\right)^{-1}=a_{0}^{-1}-\sum_{i=1}^{k} a_{0}^{-2} a_{i} \alpha_{i}$.
(2) $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ is a local ring if and only if $R$ is a local ring.
(3) If $R$ is a local ring with a maximal ideal $\mathfrak{m}$ of nilpotency $n$, then $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ is a local ring whose maximal ideal $\mathfrak{m}+\sum_{i=1}^{k} \alpha_{i} R$ has nilpotency $n+1$.

We use the following lemma frequently.
Lemma 2.6. Let $R$ be a commutative ring and $a_{0}, \ldots, a_{k} \in R$.
(1) If $f \in R[x]$, then

$$
f\left(a_{0}+\sum_{i=1}^{k} a_{i} \alpha_{i}\right)=f\left(a_{0}\right)+\sum_{i=1}^{k} a_{i} f^{\prime}\left(a_{0}\right) \alpha_{i} .
$$

(2) If $f \in R\left[\alpha_{1}, \ldots, \alpha_{k}\right][x]$ and $f_{0}, \ldots, f_{k}$ are the unique polynomials in $R[x]$ such that $f=f_{0}+\sum_{i=1}^{k} f_{i} \alpha_{i}$, then

$$
f\left(a_{0}+\sum_{i=1}^{k} a_{i} \alpha_{i}\right)=f_{0}\left(a_{0}\right)+\sum_{i=1}^{k}\left(a_{i} f_{0}^{\prime}\left(a_{0}\right)+f_{i}\left(a_{0}\right)\right) \alpha_{i} .
$$

Proof. (1) Follows from Taylor expansion and the fact that $\alpha_{i} \alpha_{j}=0$ for $1 \leq i, j \leq k$.
(2) Follows from (1).

The above lemma yields necessary conditions for a function $F: R\left[\alpha_{1}, \ldots, \alpha_{k}\right] \longrightarrow R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ to be a polynomial function.

Corollary 2.7. Let $F: R\left[\alpha_{1}, \ldots, \alpha_{k}\right] \longrightarrow R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ be a polynomial function and let $a_{0}, a_{1}, \ldots, a_{k} \in R$. Then:
(1) The constant coefficient of $F\left(a_{0}+\sum_{i=1}^{k} a_{i} \alpha_{i}\right)$ depends only on $a_{0}$;
(2) The coefficient of $\alpha_{i}$ in $F\left(a_{0}+\sum_{i=1}^{k} a_{i} \alpha_{i}\right)$ depends only on $a_{0}$ and $a_{i}$.

Definition 2.8. [6]. Let $R$ be a finite commutative local ring with a maximal ideal $\mathfrak{m}$ and $L \in \mathbb{N}$ minimal with $\mathfrak{m}^{L}=(0)$. We call $R$ suitable, if for all $a, b \in R$ and all $l \in \mathbb{N}, a b \in \mathfrak{m}^{l} \Rightarrow a \in \mathfrak{m}^{i}$ and $b \in \mathfrak{m}^{j}$ with $i+j \geq \min (L, l)$.

The following proposition shows that $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ is not in the class of rings covered in [6] unless $R$ is a finite field.

Proposition 2.9. Let $R$ be a finite local ring. Then $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ is suitable if and only if $R$ is a finite field.

Proof. Since $R$ is a local ring with a maximal ideal $\mathfrak{m}$ and nilpotency $n, R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ is a local ring with maximal ideal $\mathfrak{m}_{1}=\mathfrak{m}+\sum_{i=1}^{k} \alpha_{i} R$ and nilpotency $L=n+1$ by Proposition [2.5, Now if $R$ is a field, the result follows easily since $\mathfrak{m}_{1}^{2}=(0)$. If $R$ is not a field, we notice that $L=n+1>2$ and $\alpha_{1} \in \mathfrak{m}_{1} \backslash \mathfrak{m}_{1}^{2}$, but $\alpha_{1}^{2}=0 \in \mathfrak{m}_{1}^{n+1}$. Hence $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ is not suitable, when $R$ is not a field.

## 3. Polynomial functions on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$

From now on, let $R$ be a finite commutative ring with unity. In this section, we determine when a given polynomial is a null polynomial on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$, and whether two polynomials induce the same function on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$. Then we apply these results to obtain a counting formula for the number of polynomial functions on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$, depending on the indices of the ideals $N_{R}, N_{R}^{\prime}$ in $R[x]$ (defined below).

Definition 3.1.
(1) A polynomial $f \in R[x]$ is called a null polynomial on $R$ if $f$ induces the zero function.
(2) We define $N_{R}, N_{R}^{\prime}$ as:
(a) $N_{R}=\{f \in R[x] \mid f \triangleq 0$ on $R\}$;
(b) $N_{R}^{\prime}=\left\{f \in R[x] \mid f \triangleq 0\right.$ and $f^{\prime} \triangleq 0$ on $\left.R\right\}$.

Remark 3.2. It is evident that $N_{R}$ and $N_{R}^{\prime}$ are ideals of $R[x]$ with $N_{R}^{\prime} \subseteq N_{R}$. Also, $f \equiv g$ $\bmod N_{R}$ if and only if $[f]=[g]$; that is polynomial functions on $R$ are in bijective correspondence with residue classes $\bmod N_{R}$. In particular, $|\mathcal{F}(R)|=\left[R[x]: N_{R}\right]$.

Lemma 3.3. Let $f \in R[x]$. Then:
(1) $f$ is a null polynomial on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ if and only if $f \in N_{R}^{\prime}$;
(2) $f \alpha_{i}$ is a null polynomial on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ for every $1 \leq i \leq k$ if and only if $f \in N_{R}$.

Proof. (1) By Lemma 2.6, for every $a_{0}, \ldots, a_{k} \in R, f\left(a_{0}+\sum_{i=1}^{k} a_{i} \alpha_{i}\right)=f\left(a_{0}\right)+\sum_{i=1}^{k} a_{i} f^{\prime}\left(a_{0}\right) \alpha_{i}$. Thus the fact that $f$ is a null polynomial on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ is equivalent to

$$
f\left(a_{0}+\sum_{i=1}^{k} a_{i} \alpha_{i}\right)=f\left(a_{0}\right)+\sum_{i=1}^{k} a_{i} f^{\prime}\left(a_{0}\right) \alpha_{i}=0 \text { for all } a_{0}, \ldots, a_{k} \in R
$$

But this is equivalent to $f\left(a_{0}\right)=0$ and $a_{i} f^{\prime}\left(a_{0}\right)=0$ for all $a_{0}, a_{i} \in R$ and $i=1, \ldots, k$, which implies that $f\left(a_{0}\right)=0$ and $f^{\prime}\left(a_{0}\right)=0$ for all $a_{0} \in R$. Hence $f$ and $f^{\prime}$ are null polynomials on $R$, which means that $f \in N_{R}^{\prime}$.
(2) Follows immediately from Lemma 2.6.

Theorem 3.4. Let $N_{R}$ and $N_{R}^{\prime}$ as in Definition 3.1, and let $f=f_{0}+\sum_{i=1}^{k} f_{i} \alpha_{i}$, where $f_{0}, \ldots, f_{k} \in$ $R[x]$. Then $f$ is a null polynomial on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ if and only if $f_{0} \in N_{R}^{\prime}$ and $f_{i} \in N_{R}$ for $i=1, \ldots, k$.

Proof. By Lemma[2.6, $f\left(a_{0}+\sum_{i=1}^{k} a_{i} \alpha_{i}\right)=f_{0}\left(a_{0}\right)+\sum_{i=1}^{k}\left(a_{i} f_{0}^{\prime}\left(a_{0}\right)+f_{i}\left(a_{0}\right)\right) \alpha_{i}$ for all $a_{0}, \ldots, a_{k} \in R$. This immediately implies the "if" direction. To see the "only if", suppose that $f$ is a null polynomial on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$. Then

$$
f_{0}\left(a_{0}\right)+\sum_{i=1}^{k}\left(a_{i} f_{0}^{\prime}\left(a_{0}\right)+f_{i}\left(a_{0}\right)\right) \alpha_{i}=0 \text { for all } a_{0}, \ldots, a_{k} \in R
$$

Clearly, $f_{0}$ is a null polynomial on $R$. Substituting first 0 , then 1 , for $a_{i}, i=1, \ldots, k$, we find that $f_{i}$ and $f_{0}^{\prime}$ are null polynomials on $R$. Therefore $f_{0} \in N_{R}^{\prime}$ and $f_{i} \in N_{R}$ for $i=1, \ldots, k$.

Combining Lemma 3.3 with Theorem 3.4 gives the following criterion.
Corollary 3.5. Let $f=f_{0}+\sum_{i=1}^{k} f_{i} \alpha_{i}$, where $f_{0}, \ldots, f_{k} \in R[x]$. Then $f$ is a null polynomial on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ if and only if $f_{0}$ and $f_{i} \alpha_{i}$ are null polynomials on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ for $i=1, \ldots, k$.

Theorem 3.4 implies the following corollary, which determines whether two polynomials $f, g \in$ $R\left[\alpha_{1}, \ldots, \alpha_{k}\right][x]$ induce the same function on $\underset{5}{R\left[\alpha_{1}, \ldots, \alpha_{k}\right] .}$

Corollary 3.6. Let $f=f_{0}+\sum_{i=1}^{k} f_{i} \alpha_{i}$ and $g=g_{0}+\sum_{i=1}^{k} g_{i} \alpha_{i}$, where $f_{0}, \ldots, f_{k}, g_{0}, \ldots, g_{k} \in R[x]$.
Then $f \triangleq g$ on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ if and only if the following conditions hold:
(1) $\left[f_{i}\right]_{R}=\left[g_{i}\right]_{R}$ for $i=0, \ldots, k$;
(2) $\left[f_{0}^{\prime}\right]_{R}=\left[g_{0}^{\prime}\right]_{R}$.

In other words, $f \triangleq g$ on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ if and only if the following congruences hold:
(1) $f_{i} \equiv g_{i} \bmod N_{R}$ for $i=1, \ldots, k$;
(2) $f_{0} \equiv g_{0} \bmod N_{R}^{\prime}$.

Proof. It is sufficient to consider the polynomial $h=f-g$ and notice that $f \triangleq g$ on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ if and only if $h \triangleq 0$ on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$.

Recall from Definition 2.1 that $\mathcal{F}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)$ denotes the set of polynomial functions on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$. In the following proposition, we derive a counting formula for $\mathcal{F}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)$ depending on the indices of the ideals $N_{R}, N_{R}^{\prime}$.

Proposition 3.7. The number of polynomial functions on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ is given by

$$
\left|\mathcal{F}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)\right|=\left[R[x]: N_{R}^{\prime}\right]\left[R[x]: N_{R}\right]^{k}
$$

Proof. Let $f=f_{0}+\sum_{i=1}^{k} f_{i} \alpha_{i}$ and $g=g_{0}+\sum_{i=1}^{k} g_{i} \alpha_{i}$ where $f_{0}, \ldots, f_{k}, g_{0}, \ldots, g_{k} \in R[x]$. Then by Corollary [3.6, $f \triangleq g$ on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ if and only if $f_{0} \equiv g_{0} \bmod N_{R}^{\prime}$ and $f_{i} \equiv g_{i} \bmod N_{R}$ for $i=1, \ldots, k$.

Define $\varphi: \bigoplus_{i=0}^{k} R[x] \longrightarrow \mathcal{F}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)$ by $\varphi\left(f_{0}, \ldots, f_{k}\right)=[f]$, where $[f]$ is the function induced on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ by $f=f_{0}+\sum_{i=1}^{k} f_{i} \alpha_{i}$. Then $\varphi$ is a group epimorphism of additive groups with $\operatorname{ker} \varphi=N_{R}^{\prime} \times \bigoplus_{i=1}^{k} N_{R}$ by Theorem 3.4, Hence

$$
\left|\mathcal{F}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)\right|=\left[\bigoplus_{i=0}^{k} R[x]: N_{R}^{\prime} \times \bigoplus_{i=1}^{k} N_{R}\right]=\left[R[x]: N_{R}^{\prime}\right]\left[R[x]: N_{R}\right]^{k} .
$$

The following proposition gives an upper bound for the minimal degree of a representative of a polynomial function on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$.

Proposition 3.8. Let $h_{1} \in R\left[\alpha_{1}, \ldots, \alpha_{k}\right][x]$ and $h_{2} \in R[x]$ be monic null polynomials on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ and $R$, respectively, such that $\operatorname{deg} h_{1}=d_{1}$ and $\operatorname{deg} h_{2}=d_{2}$.

Then every polynomial function $F: R\left[\alpha_{1}, \ldots, \alpha_{k}\right] \longrightarrow R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ is induced by a polynomial $f=f_{0}+\sum_{i=1}^{k} f_{i} \alpha_{i}$, where $f_{0}, \ldots, f_{k} \in R[x]$ such that $\operatorname{deg} f_{0}<d_{1}$ and $\operatorname{deg} f_{i}<d_{2}$ for $i=1, \ldots, k$.

Moreover, if $F$ is induced by a polynomial $f \in R[x]$ and $h_{1} \in R[x]$ (rather than in $R\left[\alpha_{1}, \ldots, \alpha_{k}\right][x]$ ), then there exists a polynomial $g \in R[x]$ with $\operatorname{deg} g<d_{1}$, such that $[g]_{R}=[f]_{R}$ and $\left[g^{\prime}\right]_{R}=\left[f^{\prime}\right]_{R}$.

Proof. Suppose that $h_{1} \in R\left[\alpha_{1}, \ldots, \alpha_{k}\right][x]$ is a monic null polynomial on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ of degree $d_{1}$. Let $g \in R\left[\alpha_{1}, \ldots, \alpha_{k}\right][x]$ be a polynomial that represents $F$. By the division algorithm, we have $g(x)=q(x) h_{1}(x)+r(x)$ for some $r, q \in R\left[\alpha_{1}, \ldots, \alpha_{k}\right][x]$, where $\operatorname{deg} r \leq d_{1}-1$. Then clearly, $r(x)$ represents $F$. By Lemma 2.6, $r=f_{0}+\sum_{i=1}^{k} r_{i} \alpha_{i}$ for some $f_{0}, r_{1}, \ldots, r_{k} \in R[x]$, and it is obvious that $\operatorname{deg} f_{0}, \operatorname{deg} r_{i} \leq d_{1}-1$ for $i=1, \ldots, k$. Now let $h_{2} \in R[x]$ be a monic null polynomial on $R$ of degree $d_{2}$. Again, by the division algorithm, we have for $i=1, \ldots, k$, $r_{i}(x)=q_{i}(x) h_{2}(x)+f_{i}(x)$ for some $f_{i}, q_{i} \in R[x]$, where $\operatorname{deg} f_{i} \leq d_{2}-1$. Then by Corollary 3.6, $r_{i} \alpha_{i} \triangleq f_{i} \alpha_{i}$ on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$. Thus $f=f_{0}+\sum_{i=1}^{k} f_{i} \alpha_{i}$ is the desired polynomial.
For the second part, the existence of $g \in R[x]$ with $\operatorname{deg} g<d_{1}$ such that $f \triangleq g$ on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ follows by the same argument given in the previous part. By Corollary [3.6, $[g]_{R}=[f]_{R}$ and $\left[g^{\prime}\right]_{R}=\left[f^{\prime}\right]_{R}$.

Remark 3.9. Let $h(x)=\prod_{r \in R}(x-r)^{2}$. Then $h$ is a monic polynomial in $R[x]$, and by Lemma 3.3, it is a null polynomial on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$. This shows that the monic null polynomial mentioned in the last part of Proposition 3.8 always exists.

## 4. Permutation polynomials on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$

This section deals with the group of polynomial permutations on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$. In the following theorem, we give a characterization for a permutation polynomial on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$.

Theorem 4.1. Let $R$ be a finite ring. Let $f=f_{0}+\sum_{i=1}^{k} f_{i} \alpha_{i}$, where $f_{0}, \ldots, f_{k} \in R[x]$. Then $f$ is a permutation polynomial on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ if and only if the following conditions hold:
(1) $f_{0}$ is a permutation polynomial on $R$;
(2) for all $a \in R, f_{0}^{\prime}(a)$ is a unit in $R$.

Proof. ( $\Rightarrow$ ) Let $c \in R$. Then $c \in R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$. Since $f$ is a permutation polynomial on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$, there exist $a_{0}, \ldots, a_{k} \in R$ such that $f\left(a_{0}+\sum_{i=1}^{k} a_{i} \alpha_{i}\right)=c$. Thus, by Lemma 2.6,

$$
f_{0}\left(a_{0}\right)+\sum_{i=1}^{k}\left(a_{i} f_{0}^{\prime}\left(a_{0}\right)+f_{i}\left(a_{0}\right)\right) \alpha_{i}=c .
$$

So $f_{0}\left(a_{0}\right)=c$, therefore $f_{0}$ is onto, and hence a permutation polynomial on $R$.
Let $a \in R$ and suppose that $f_{0}^{\prime}(a)$ is a non-unit in $R$. Then $f_{0}^{\prime}(a)$ is a zerodivisor of $R$. Let $b \in R, b \neq 0$, such that $b f_{0}^{\prime}(a)=0$. Then, by Lemma 2.6,

$$
f\left(a+\sum_{i=1}^{k} b \alpha_{i}\right)=f_{0}(a)+\sum_{i=1}^{k}\left(b f_{0}^{\prime}(a)+f_{i}(a)\right) \alpha_{i}=f_{0}(a)+\sum_{i=1}^{k} f_{i}(a) \alpha_{i}=f(a) .
$$

So $f$ is not one-to-one, which is a contradiction. This proves (2).
$(\Leftarrow)$ It is enough to show that $f$ is one-to-one. Let $a_{0}, \ldots, a_{k}, b_{0}, \ldots, b_{k} \in R$ such that

$$
f\left(a_{0}+\sum_{i=1}^{k} a_{i} \alpha_{i}\right)=f\left(b_{0}+\sum_{i=1}^{k} b_{i} \alpha_{i}\right),
$$

that is,

$$
f_{0}\left(a_{0}\right)+\sum_{i=1}^{k}\left(a_{i} f_{0}^{\prime}\left(a_{0}\right)+f_{i}\left(a_{0}\right)\right) \alpha_{i}=f_{0}\left(b_{0}\right)+\sum_{i=1}^{k}\left(b_{i} f_{0}^{\prime}\left(b_{0}\right)+f_{i}\left(b_{0}\right)\right) \alpha_{i}
$$

by Lemma 2.6. Then we have $f_{0}\left(a_{0}\right)=f_{0}\left(b_{0}\right)$ and $a_{i} f_{0}^{\prime}\left(a_{0}\right)+f_{i}\left(a_{0}\right)=b_{i} f_{0}^{\prime}\left(b_{0}\right)+f_{i}\left(b_{0}\right)$ for $i=1, \ldots, k$. Hence $a_{0}=b_{0}$ since $f_{0}$ is a permutation polynomial on $R$. Then, since $f_{0}^{\prime}\left(a_{0}\right)$ is a unit in $R, a_{i}=b_{i}$ follows for $i=1, \ldots, k$.

Theorem 4.1 shows that the criterion to be a permutation polynomial on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ depends only on $f_{0}$, and implies the following corollary.

Corollary 4.2. Let $f=f_{0}+\sum_{i=1}^{k} f_{i} \alpha_{i}$, where $f_{0}, \ldots, f_{k} \in R[x]$. Then the following statements are equivalent:
(1) $f$ is a permutation polynomial on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$;
(2) $f_{0}+f_{i} \alpha_{i}$ is a permutation polynomial on $R\left[\alpha_{i}\right]$ for every $i \in\{1, \ldots, k\}$;
(3) $f_{0}$ is a permutation polynomial on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$;
(4) $f_{0}$ is a permutation polynomial on $R\left[\alpha_{i}\right]$ for every $i \in\{1, \ldots, k\}$.

Recall from definition [2.1] that $\mathcal{P}(A)$ stands for the group of polynomial permutations on the ring $A$.

Corollary 4.3. The group $\mathcal{P}\left(R\left[\alpha_{i}\right]\right)$ is embedded in $\mathcal{P}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)$ for every $i=1, \ldots, k$.
Proof. Fix $i \in\{1, \ldots, k\}$ and let $F \in \mathcal{P}\left(R\left[\alpha_{i}\right]\right)$. Then $F$ is induced by $f=f_{0}+f_{i} \alpha_{i}$ for some $f_{0}, f_{i} \in R[x]$. Furthermore, $f_{0}+f_{i} \alpha_{i}$ is permutation polynomial on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ by Corollary [4.2. Define a function $\psi: \mathcal{P}\left(R\left[\alpha_{i}\right]\right) \longrightarrow \mathcal{P}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)$ by $\psi(F)=[f]_{R\left[\alpha_{1}, \ldots, \alpha_{k}\right]}$, where $[f]_{R\left[\alpha_{1}, \ldots, \alpha_{k}\right]}$ denotes the function induced by $f$ on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$. By Corollary 3.6. $\psi$ is well defined and one-to-one. Now if $F_{1} \in \mathcal{P}\left(R\left[\alpha_{i}\right]\right)$ is induced by $g \in R\left[\alpha_{i}\right][x]$, then $f \circ g$ induces $F \circ F_{1}$ on $R\left[\alpha_{i}\right]$. Hence,

$$
\begin{aligned}
\psi\left(F \circ F_{1}\right) & =[f \circ g]_{R\left[\alpha_{1}, \ldots, \alpha_{k}\right]} \\
& =[f]_{R\left[\alpha_{1}, \ldots, \alpha_{k}\right]} \circ[g]_{R\left[\alpha_{1}, \ldots, \alpha_{k}\right]} \text { since } f, g \in R\left[\alpha_{1}, \ldots, \alpha_{k}\right][x] \\
& =\psi(F) \circ \psi\left(F_{1}\right) .
\end{aligned}
$$

This completes the proof.
Remark 4.4. We will show in Proposition 4.7 that the condition on the derivative in Theorem 4.1 is redundant, when $R$ is a direct sum of local rings none of which is a field.

Lemma 4.5. [12, Theorem 3] Let $R$ be a finite local ring with a maximal ideal $M \neq\{0\}$ and suppose that $f \in R[x]$. Then $f$ is a permutation polynomial on $R$ if and only if the following conditions hold:
(1) $f$ is a permutation polynomial on $R / M$;
(2) for all $a \in R, f^{\prime}(a) \neq 0 \bmod M$.

Lemma 4.6. Let $R$ be a finite ring and suppose that $R=\oplus_{i=1}^{n} R_{i}$, where $R_{i}$ is local for $i=$ $1, \ldots, n$. Let $f=\left(f_{1}, \ldots, f_{n}\right) \in R[x]$, where $f_{i} \in R_{i}[x]$. Then $f$ is a permutation polynomial on $R$ if and only if $f_{i}$ is a permutation polynomial on $R_{i}$ for $i=1, \ldots, n$.

Proof. $(\Rightarrow)$ Suppose that $f$ is a permutation polynomial on $R$ and fix an $i$. Let $b_{i} \in R_{i}$. Then $\left(0, \ldots, b_{i}, \ldots, 0\right) \in R$. Thus there exists $a=\left(a_{1}, \ldots, a_{i}, \ldots, a_{n}\right) \in R$, where $a_{j} \in R_{j}, j=1, \ldots, n$ such that $f(a)=\left(f_{1}\left(a_{1}\right), \ldots, f_{i}\left(a_{i}\right), \ldots, f_{n}\left(a_{n}\right)\right)=\left(0, \ldots, b_{i}, \ldots, 0\right)$. Hence $f_{i}\left(a_{i}\right)=b_{i}$, and therefore $f_{i}$ is surjective, whence $f_{i}$ is a permutation polynomial on $R_{i}$.
$(\Leftarrow)$ Easy and left to the reader.
From now on, let $R^{\times}$denote the group of units of $R$.
Proposition 4.7. Let $R$ be a finite ring which is a direct sum of local rings which are not fields, and let $f=f_{0}+\sum_{i=1}^{k} f_{i} \alpha_{i}$, where $f_{0}, \ldots, f_{k} \in R[x]$. Then $f$ is a permutation polynomial on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ if and only if $f_{0}$ is a permutation polynomial on $R$.

Proof. ( $\Rightarrow$ ) Follows by Theorem 4.1,
$(\Leftarrow)$ Assume that $f_{0}$ is a permutation polynomial on $R$. By Theorem 4.1, we need only show that $f_{0}^{\prime}(r) \in R^{\times}$for every $r \in R$. Write $f_{0}=\left(g_{1}, \ldots, g_{n}\right)$, where $g_{i} \in R_{i}[x]$ for $i=1, \ldots, n$. Then $g_{i}$ is a permutation polynomial on $R_{i}$ for $i=1, \ldots, n$ by Lemma 4.6. Now let $r \in R$, so $r=\left(r_{1}, \ldots, r_{n}\right)$, where $r_{i} \in R_{i}$. Hence $f_{0}^{\prime}(r)=\left(g_{1}^{\prime}\left(r_{1}\right), \ldots, g_{n}^{\prime}\left(r_{n}\right)\right)$ but $g_{i}^{\prime}\left(r_{i}\right) \in R_{i}^{\times}$by Lemma 4.5 for $i=1, \ldots, n$. Therefore $f_{0}^{\prime}(r)=\left(g_{1}^{\prime}\left(r_{1}\right), \ldots, g_{n}^{\prime}\left(r_{n}\right)\right) \in R^{\times}$, i.e, $f_{0}^{\prime}(r)$ is a unit in $R$ for every $r \in R$. Thus $f_{0}$ satisfies the conditions of Theorem4.1. Therefore $f$ is a permutation polynomial on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$.

Corollary 4.8. Let $R$ be a finite ring which is a direct sum of local rings which are not fields. Let $f \in R[x]$ be a permutation polynomial on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$. Then $f+h$ is a permutation polynomial on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ for every $h \in N_{R}$. In particular, $x+h$ is a permutation polynomial on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ for every $h \in N_{R}$.

Proposition 4.9. Let $R$ be a finite ring. Let $B$ denote the number of pairs of functions ( $H, G$ ) with

$$
H: R \longrightarrow R \text { bijective and } G: R \longrightarrow R^{\times}
$$

that occur as $\left([g],\left[g^{\prime}\right]\right)$ for some $g \in R[x]$. Then the number of polynomial permutations on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ is given by

$$
\left|\mathcal{P}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)\right|=B \cdot|\mathcal{F}(R)|^{k} .
$$

Proof. Let $F \in \mathcal{P}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)$. Then by definition $F$ is induced by a polynomial $f=f_{0}+$ $\sum_{i=1}^{k} f_{i} \alpha_{i}$, where $f_{0}, \ldots, f_{k} \in R[x]$. By Theorem 4.1,
$\left[f_{0}\right]: R \longrightarrow R$ bijective, $\left[f_{0}^{\prime}\right]: R \longrightarrow R^{\times}$and $\left[f_{i}\right]$ is arbitrary in $\mathcal{F}(R)$ for $i=1, \ldots, k$. The rest follows by Corollary 3.6.

In the next section, we show that the number $B$ of Proposition 4.9 depends on the order of the pointwise stabilizer of $R$ in the group $\mathcal{P}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)$. However, when $R$ is a finite field, we can find explicitly this number. For this, we need the following well known lemma.

Lemma 4.10. Let $\mathbb{F}_{q}$ be a finite field with $q$ elements. Then for all functions

$$
F, G: \mathbb{F}_{q} \longrightarrow \mathbb{F}_{q},
$$

there exists $f \in \mathbb{F}_{q}[x]$ such that

$$
(F, G)=\left([f],\left[f^{\prime}\right]\right) \text { and } \operatorname{deg} f<2 q
$$

Proof. Let $f_{0}, f_{1} \in \mathbb{F}_{q}[x]$ such that $\left[f_{0}\right]=F$ and $\left[f_{1}\right]=G$ and set

$$
f(x)=f_{0}(x)+\left(f_{0}^{\prime}(x)-f_{1}(x)\right)\left(x^{q}-x\right)
$$

Then

$$
f^{\prime}(x)=\left(f_{0}^{\prime \prime}(x)-f_{1}^{\prime}(x)\right)\left(x^{q}-x\right)+f_{1}(x)
$$

Thus $[f]=\left[f_{0}\right]=F$ and $\left[f^{\prime}\right]=\left[f_{1}\right]=G$ since $\left(x^{q}-x\right)$ is a null polynomial on $\mathbb{F}_{q}$. Moreover, since $\left(x^{q}-x\right)$ is a null polynomial on $\mathbb{F}_{q}$, we can choose $f_{0}, f_{1}$ such that $\operatorname{deg} f_{0}, \operatorname{deg} f_{1}<q$. Hence $\operatorname{deg} f<2 q$.

Proposition 4.11. Let $\mathbb{F}_{q}$ be a finite field with $q$ elements. The number of polynomial permutations on $\mathbb{F}_{q}\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ is given by

$$
\left|\mathcal{P}\left(\mathbb{F}_{q}\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)\right|=q!(q-1)^{q} q^{k q}
$$

Proof. Let $\mathcal{B}$ be the set of pairs of functions $(F, G)$ such that

$$
F: \mathbb{F}_{q} \longrightarrow \mathbb{F}_{q} \text { bijective and } G: \mathbb{F}_{q} \longrightarrow \mathbb{F}_{q} \backslash\{0\}
$$

By Lemma 4.10, each $(F, G) \in \mathcal{B}$ arises as $\left([f],\left[f^{\prime}\right]\right)$ for some $f \in \mathbb{F}_{q}[x]$. By Proposition 4.9, $\left|\mathcal{P}\left(\mathbb{F}_{q}\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)\right|=|\mathcal{B}| \cdot\left|\mathcal{F}\left(\mathbb{F}_{q}\right)\right|^{k}$. Clearly $|\mathcal{B}|=q!(q-1)^{q}$ and $\left|\mathcal{F}\left(\mathbb{F}_{q}\right)\right|^{k}=q^{k q}$.

## 5. The stabilizer of $R$ in the group of polynomial permutations of $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$

The main object of this section is to describe the order of the subgroup of those polynomial permutations on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ that fix pointwise each element of $R$, and then to use this order to find a counting formula for the number of polynomial permutations on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$.

Definition 5.1. Let $S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)=\left\{F \in \mathcal{P}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right) \mid F(a)=a\right.$ for every $\left.a \in R\right\}$.
Evidently, $S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)$ is a subgroup of $\mathcal{P}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)$.
Proposition 5.2. Let $R$ be a finite ring. Then

$$
S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)=\left\{F \in \mathcal{P}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right) \mid F \text { is induced by } x+h(x), h \in N_{R}\right\} .
$$

In particular, every element of $S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)$ is induced by a polynomial in $R[x]$.
Proof. It is obvious that

$$
S t_{\alpha_{1}, \ldots, \alpha_{k}}(R) \supseteq\left\{F \in \mathcal{P}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right) \mid F \text { is induced by } x+h(x), h \in N_{R}\right\}
$$

For the other inclusion, let $F \in \mathcal{P}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)$ such that $F(a)=a$ for every $a \in R$. Then $F$ is represented by $f_{0}+\sum_{i=1}^{k} f_{i} \alpha_{i}$, where $f_{0}, \ldots, f_{k} \in R[x]$, and $a=F(a)=f_{0}(a)+\sum_{i=1}^{k} f_{i}(a) \alpha_{i}$ for every $a \in R$. It follows that $f_{i}(a)=0$ for every $a \in R$, i.e., $f_{i}$ is a null polynomial on $R$ for $i=1, \ldots, k$. Thus $f_{0}+\sum_{i=1}^{k} f_{i} \alpha_{i} \triangleq f_{0}$ on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ by Corollary [3.6, that is, $F$ is represented by $f_{0}$. Also, $f_{0} \triangleq i d_{R}$ on $R$, where $i d_{R}$ is the identity function on $R$, and therefore $f_{0}(x)=x+h(x)$ for some $h \in N_{R}$ by Remark 3.2.

We have the following theorem, when $R$ is a finite field, which describes the order of $S t_{\alpha_{1}, \ldots, \alpha_{k}}\left(\mathbb{F}_{q}\right)$. The proof is almost the same as in [1, Theorem 4.11].

Theorem 5.3. Let $\mathbb{F}_{q}$ be a finite field with $q$ elements. Then:
(1) $\left|S t_{\alpha_{1}, \ldots, \alpha_{k}}\left(\mathbb{F}_{q}\right)\right|=\mid\left\{\left[f^{\prime}\right]_{\mathbb{F}_{q}} \mid f \in N_{\mathbb{F}_{q}}\right.$ and for every $\left.a \in \mathbb{F}_{q}, f^{\prime}(a) \neq-1\right\} \mid$;
(2) $\left|S t_{\alpha_{1}, \ldots, \alpha_{k}}\left(\mathbb{F}_{q}\right)\right|=\mid\left\{\left[f^{\prime}\right]_{\mathbb{F}_{q}} \mid f \in N_{\mathbb{F}_{q}}, \operatorname{deg} f<2 q\right.$ and for every $\left.a \in \mathbb{F}_{q}, f^{\prime}(a) \neq-1\right\} \mid$;
(3) $\left|S t_{\alpha_{1}, \ldots, \alpha_{k}}\left(\mathbb{F}_{q}\right)\right|=(q-1)^{q}$.

Proof. We begin with the proof of (1) and (2). Set

$$
A=\left\{\left[f^{\prime}\right]_{\mathbb{F}_{q}} \mid f \in N_{\mathbb{F}_{q}} \text { and for every } a \in \mathbb{F}_{q}, f^{\prime}(a) \neq-1\right\}
$$

We define a bijection $\varphi$ from $S t_{\alpha_{1}, \ldots, \alpha_{k}}\left(\mathbb{F}_{q}\right)$ to the set $A$. If $F \in S t_{\alpha_{1}, \ldots, \alpha_{k}}\left(\mathbb{F}_{q}\right)$, then it is represented by $x+h(x)$, where $h \in \mathbb{F}_{q}[x]$ is a null polynomial on $\mathbb{F}_{q}$, by Proposition 5.2, Now $h^{\prime}(a) \neq-1$ for every $a \in \mathbb{F}_{q}$, by Theorem 4.1, whence $\left[h^{\prime}\right]_{\mathbb{F}_{q}} \in A$. Now, set $\varphi(F)=\left[h^{\prime}\right]_{\mathbb{F}_{q}}$. Then Corollary 3.6 shows that $\varphi$ is well-defined and injective. To show $\varphi$ is surjective, let $\left[h^{\prime}\right]_{\mathbb{F}_{q}} \in A$, where $h \in N_{\mathbb{F}_{q}}$. Then, by Theorem 4.1 and Proposition [5.2, $F=[x+h]_{\mathbb{F}_{q}\left[\alpha_{1}, \ldots, \alpha_{k}\right]} \in$ $S t_{\alpha_{1}, \ldots, \alpha_{k}}\left(\mathbb{F}_{q}\right)$. Thus $\varphi(F)=\left[h^{\prime}\right]_{\mathbb{F}_{q}}$. Moreover, by Lemma 4.10, $h$ can be chosen such that $\operatorname{deg} h<2 q$.

Next, we prove (3). By (1),

$$
\left|S t_{\alpha_{1}, \ldots, \alpha_{k}}\left(\mathbb{F}_{q}\right)\right| \leq\left|\left\{G: \mathbb{F}_{q} \longrightarrow \mathbb{F}_{q} \backslash\{-1\}\right\}\right|=(q-1)^{q} .
$$

Now for every function $G: \mathbb{F}_{q} \longrightarrow \mathbb{F}_{q} \backslash\{-1\}$ there exists a polynomial $f \in N_{\mathbb{F}_{q}}$ such that $\left[f^{\prime}\right]_{\mathbb{F}_{q}}=G$ by Lemma 4.10. Thus $f(x)+x$ is a permutation polynomial on $\mathbb{F}_{q}\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ by Theorem 4.1. Obviously, $x+f(x)$ induces the identity on $\mathbb{F}_{q}$, and hence $[x+f(x)]_{\mathbb{F}_{q}\left[\alpha_{1}, \ldots, \alpha_{k}\right]} \in$ $S t_{\alpha_{1}, \ldots, \alpha_{k}}\left(\mathbb{F}_{q}\right)$. Therefore every element of the set $\left\{G: \mathbb{F}_{q} \longrightarrow \mathbb{F}_{q} \backslash\{-1\}\right\}$ corresponds to an element of $S t_{\alpha_{1}, \ldots, \alpha_{k}}\left(\mathbb{F}_{q}\right)$, from which we conclude that $\left|S t_{\alpha_{1}, \ldots, \alpha_{k}}\left(\mathbb{F}_{q}\right)\right| \geq(q-1)^{q}$. This completes the proof.

Notation 5.4. Let

$$
\mathcal{P}_{R}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)=\left\{F \in \mathcal{P}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right) \mid F=[f]_{R\left[\alpha_{1}, \ldots, \alpha_{k}\right]} \text { for some } f \in R[x]\right\} .
$$

In similar manner, let $\mathcal{P}_{R}\left(R\left[\alpha_{i}\right]\right)=\left\{F \in \mathcal{P}\left(R\left[\alpha_{i}\right]\right) \mid F=[f]_{R\left[\alpha_{i}\right]}\right.$ for some $\left.f \in R[x]\right\}$.
We now show that $\mathcal{P}_{R}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)$ is a subgroup of $\mathcal{P}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)$.
Proposition 5.5. The set $\mathcal{P}_{R}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)$ is a subgroup of $\mathcal{P}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)$ and $\mathcal{P}_{R}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right) \cong \mathcal{P}_{R}\left(R\left[\alpha_{i}\right]\right)$ for $i=1, \ldots, k$.

Proof. It is clear that $\mathcal{P}_{R}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)$ is closed under composition. Since it is finite, it is a subgroup of $\mathcal{P}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)$. Let $F \in \mathcal{P}_{R}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)$ and suppose that $F$ is induced by $f \in R[x]$. Define

$$
\psi: \mathcal{P}_{R}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right) \longrightarrow \mathcal{P}_{R}\left(R\left[\alpha_{i}\right]\right), \quad F \mapsto[f]_{R\left[\alpha_{i}\right]} .
$$

Then $\psi$ is well defined by Corollary 3.6, and evidently it is a homomorphism. By Corollary 4.2, $\psi$ is surjective. To show that $\psi$ is one-to-one, let $F_{1} \in \mathcal{P}_{R}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)$ be induced by $g \in R[x]$ with $F \neq F_{1}$. Then either $f \neq g$ on $R$ or $f^{\prime} \neq g^{\prime}$ on $R$ by Corollary 3.6. Thus $\psi(F)=[f]_{R\left[\alpha_{i}\right]} \neq \psi\left(F_{1}\right)=[g]_{R\left[\alpha_{i}\right]}$.

We will see that $S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)$ is a normal subgroup of $\mathcal{P}_{R}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)$. But first we prove the following fact.

Proposition 5.6. Let $R$ be a finite ring. Then for every $F \in \mathcal{P}(R)$ there exists a polynomial $f \in R[x]$ such that $F$ is induced by $f$ and $f^{\prime}(r) \in R^{\times}$for every $r \in R$.

Proof. Set $\mathcal{P}_{u}(R)=\left\{F \in \mathcal{P}(R) \mid F\right.$ is induced by $\left.f \in R[x], f^{\prime}: R \longrightarrow R^{\times}\right\}$. By definition $\mathcal{P}_{u}(R) \subseteq \mathcal{P}(R)$. Let $F \in \mathcal{P}(R)$. Then $F$ is induced by $f \in R[x]$. Since $R$ is finite, $R=\oplus_{i=1}^{n} R_{i}$, where $R_{i}$ are local rings. We distinguish two cases. For the first case, we suppose that no $R_{i}$ is a field. Then $f$ is a permutation polynomial on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ by Proposition 4.7. Hence $f^{\prime}(a) \in R^{\times}$for every $a \in R$ by Theorem 4.1. So $F \in \mathcal{P}_{u}(R)$. For the second case, we assume without loss of generality that $R_{1}, \ldots, R_{r}$ are fields and no $R_{i}$ is a field for $i>r$. We identify $R[x]$ with $\bigoplus_{i=1}^{n} R[x]$ and write $f=\left(f_{1}, \ldots, f_{n}\right)$ where $f_{i} \in R_{i}[x]$ for $i=1, \ldots, n$. By Lemma 4.6, $f_{i}$ is a permutation polynomial on $R_{i}$, for $i=1, \ldots, n$. Now a similar argument like the one given in the first case shows that $f_{i}^{\prime}\left(a_{i}\right) \in R_{i}^{\times}$for every $a_{i} \in R_{i}$ for $i=r+1, \ldots, n$. On the other hand, there exists $g_{j} \in R_{j}[x]$ such that $g_{j} \triangleq f_{j}$ on $R_{j}$ and $g_{j}^{\prime}\left(a_{j}\right) \in R_{j}^{\times}$for every $a_{j} \in R_{j}$, $j=1, \ldots, r$ by Lemma 4.10. Then take $g=\left(g_{1}, \ldots, g_{r}, f_{r+1}, \ldots, f_{n}\right)$. Thus $g \triangleq f$ on $R$ and $g^{\prime}(a) \in R^{\times}$for every $a \in R$. Therefore $g$ induces $F$ and $F \in \mathcal{P}_{u}(R)$.

Theorem 5.7. Let $R$ be a finite ring. Then:
(1) every element of $\mathcal{P}(R)$ occurs as the restriction to $R$ of some $F \in \mathcal{P}_{R}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)$;
(2) $\mathcal{P}_{R}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)$ contains $S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)$ as a normal subgroup and

$$
\mathcal{P}_{R}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right) / S t_{\alpha_{1}, \ldots, \alpha_{k}}(R) \cong \mathcal{P}(R) .
$$

Proof. (1) This is obvious from Proposition 5.6 and Theorem 4.1.
(2) $S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)$ is contained in $\mathcal{P}_{R}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)$, because every element of $S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)$ can be represented by a polynomial with coefficients in $R$ by Proposition 5.2, Let $F \in$ $\mathcal{P}_{R}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)$ be represented by $f \in R[x]$. Then define $\varphi: \mathcal{P}_{R}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right) \longrightarrow \mathcal{P}(R)$ by $\varphi(F)=[f]_{R}$. Now $\varphi$ is well defined by Corollary [3.6, and it is a group homomorphism with $\operatorname{ker} \varphi=S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)$. By Proposition 5.6, $\varphi$ is surjective.

Corollary 5.8. For any fixed $F \in \mathcal{P}(R)$,

$$
\left|S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)\right|=\mid\left\{\left[f^{\prime}\right]_{R} \mid f \in R[x],[f] \in \mathcal{P}_{R}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right) \text { and }[f]_{R}=F\right\} \mid .
$$

Proof. Let $f \in R[x]$ be a permutation polynomial on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ with $[f]_{R}=F$. Such an $f$ exists by Theorem 5.7 (1). We denote by [f] the permutation induced by $f$ on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$. Then the coset of $[f]$ with respect to $S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)$ has $\left|S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)\right|$ elements. By Theorem $[5.7$ (21), this coset consists of all polynomial permutations $G \in \mathcal{P}_{R}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)$ with $[f]_{R}=G_{\mid R}$, where $G_{\left.\right|_{R}}$ is the restriction of the function $G$ to $R$. Let $g \in R[x]$ with $[g]=G$. By Corollary 3.6, $G \neq[f]$ if and only if $\left[f^{\prime}\right]_{R} \neq\left[g^{\prime}\right]_{R}$. Thus we have a bijection between the coset of $[f]$ with respect to $S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)$ and the set of functions $\left[g^{\prime}\right]_{R}$ occurring for $g \in R[x]$ such that $[g]=G$ permutes $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ and $[f]_{R}=[g]_{R}$.

When $R$ is a finite ring which is a direct sum of local rings that are not fields, Corollary 5.8 is a special case of a general result (see Proposition 5.13).

We now employ Corollary 5.8 to find the number of polynomial permutations on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ in terms of $\left|S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)\right|$.

Theorem 5.9. Let $R$ be a finite ring. For any integer $k \geq 1$,

$$
\left|\mathcal{P}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)\right|=|\mathcal{F}(R)|^{k} \cdot|\mathcal{P}(R)| \cdot\left|S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)\right| .
$$

Proof. For $f \in R[x]$, let $[f]$ be the function induced by $f$ on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$.

Set $B \underset{F \in \mathcal{P}(R)}{\bigcup}\left\{\left[f^{\prime}\right]_{R} \mid f \in R[x],[f] \in \mathcal{P}_{R}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)\right.$ and $\left.[f]_{R}=F\right\}$.
Then $|B|=|\mathcal{P}(R)| \cdot\left|S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)\right|$ by Corollary 5.8.
Now we define a function $\Psi: \mathcal{P}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right) \longrightarrow B \times \prod_{i=1}^{k} \mathcal{F}(R)$ as follows: if $G \in \mathcal{P}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)$ is induced by $g=g_{0}+\sum_{i=1}^{k} g_{i} \alpha_{i}$, where $g_{0}, \ldots, g_{k} \in R[x]$, we let $\Psi(G)=\left(\left[g_{0}^{\prime}\right]_{R},\left[g_{1}\right]_{R}, \ldots,\left[g_{k}\right]_{R}\right)$. By Theorem 4.1 and Corollary 3.6, $\Psi$ is well-defined and one-to-one. The surjectivity of $\Psi$ follows by Theorem 5.7 and Theorem 4.1. Therefore

$$
\left|\mathcal{P}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)\right|=\left|B \times \prod_{i=1}^{k} \mathcal{F}(R)\right|=|\mathcal{P}(R)| \cdot\left|S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)\right| \cdot|\mathcal{F}(R)|^{k}
$$

Definition 5.10. Let $N_{R}(<n)=\left\{f \in R[x] \mid f \in N_{R}\right.$ with $\left.\operatorname{deg} f<n\right\}$, and

$$
N_{R}^{\prime}(<n)=\left\{f \in R[x] \mid f \in N_{R}^{\prime} \text { with } \operatorname{deg} f<n\right\} .
$$

In the following theorem, we obtain several descriptions for the order of the group $S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)$ whenever $R$ is a direct sum of local rings which are not fields.

Theorem 5.11. Let $R$ be a finite ring which is a direct sum of local rings that are not fields. Then the following hold.
(1) $\left|S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)\right|=\left|\left\{\left[f^{\prime}\right]_{R} \mid f \in N_{R}\right\}\right|$.
(2) If there exists a monic null polynomial on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ in $R[x]$ of degree $n$, then:
(a) $\left|S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)\right|=\mid\left\{\left[f^{\prime}\right]_{R} \mid f \in N_{R}\right.$ with $\left.\operatorname{deg} f<n\right\} \mid$;
(b) $\left|S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)\right|=\left[N_{R}: N_{R}^{\prime}\right]=\frac{\left|N_{R}(<n)\right|}{\left|N_{R}^{\prime}(<n)\right|}$.

Proof. (1) We define a bijection $\varphi$ from $S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)$ to the set of functions induced on $R$ by the derivative of some null polynomial on $R$. By Proposition 5.2, every $F \in S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)$ is represented by $x+f(x)$, where $f \in R[x]$ is a null polynomial on $R$. We set $\varphi(F)=\left[f^{\prime}\right]_{R}$. Then Corollary 3.6 shows that $\varphi$ is well-defined and injective, and Corollary 4.8 shows that it is surjective.
(2) Monic null polynomials on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ with coefficients in $R$ always exist by Remark 3.9, (2a) If $g \in N_{R}$, then by Proposition 3.8, there exists $f \in R[x]$ with $\operatorname{deg} f<n$ such that $[f]_{R}=[g]_{R}$ and $\left[f^{\prime}\right]_{R}=\left[g^{\prime}\right]_{R}$. Evidently, $f \in N_{R}$.
(2b) For computing the index, define $\varphi: N_{R} \longrightarrow \mathcal{F}(R)$ by $\varphi(f)=\left[f^{\prime}\right]_{R}$. Clearly, $\varphi$ is a homomorphism of additive groups. Furthermore,

$$
\operatorname{ker} \varphi=N_{R}^{\prime} \text { and } \operatorname{Im} \varphi=\left\{\left[f^{\prime}\right]_{R} \mid f \in N_{R}\right\},
$$

and hence $N_{R} / N_{R}^{\prime} \cong\left\{\left[f^{\prime}\right]_{R} \mid f \in N_{R}\right\}$. Therefore $\left|S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)\right|=\left[N_{R}: N_{R}^{\prime}\right]$ by (1).
Finally consider the ratio, consider the sets $N_{R}(<n)$ and $N_{R}^{\prime}(<n)$ as defined in Definition 5.10. The equivalence relation in Definition 2.1 restricted to these two additive subgroups and the analogous proof to the previous part show that

$$
\left|S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)\right|=\left[N_{R}(<n): N_{R}^{\prime}(<n)\right] .
$$

## Remark 5.12.

(1) When $R=\mathbb{F}_{q}$ is a finite field, we have shown in Theorem 5.3 (3) that $\left|S t_{\alpha_{1}, \ldots, \alpha_{k}}\left(\mathbb{F}_{q}\right)\right|=$ $(q-1)$ !. But we will see later that

$$
\left[N_{\mathbb{F}_{q}}: N_{\mathbb{F}_{q}}^{\prime}\right]=\left[N_{\mathbb{F}_{q}}(<2 q): N_{\mathbb{F}_{q}}^{\prime}(<2 q)\right]=q^{q} .
$$

(2) Even when $k=1$, Theorem 5.11 is still a generalization of [1, Proposition 7.2].

Proposition 5.13. Let $R$ be a finite ring which is a direct sum of local rings that are not fields. Then for any fixed $F \in \mathcal{F}(R)$,

$$
\left|S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)\right|=\mid\left\{\left[g^{\prime}\right]_{R} \mid g \in R[x] \text { with }[g]_{R}=F\right\} \mid \text {. }
$$

Proof. Set

$$
A=\left\{\left[g^{\prime}\right]_{R} \mid g \in R[x] \text { with }[g]_{R}=F\right\}
$$

and fix $g_{0} \in R[x]$ with $\left[g_{0}\right]_{R}=F$. Then $g-g_{0}$ is a null polynomial on $R$ for any $g \in R[x]$ with $\left[g^{\prime}\right]_{R} \in A$.

We define a bijection

$$
\phi: A \longrightarrow\left\{\left[f^{\prime}\right]_{R} \mid f \in N_{R}\right\}, \quad \phi\left(\left[g^{\prime}\right]_{R}\right)=\left[\left(g-g_{0}\right)^{\prime}\right]_{R} .
$$

Since $\left[\left(g-g_{0}\right)^{\prime}\right]_{R}=\left[g^{\prime}\right]_{R}-\left[g_{0}^{\prime}\right]_{R}, \phi$ is well defined. Further, $\phi$ is injective, because, for two distinct elements of $A,\left[g_{1}^{\prime}\right]_{R} \neq\left[g^{\prime}\right]_{R}$ implies that $\left[\left(g_{1}-g_{0}\right)^{\prime}\right]_{R} \neq\left[\left(g-g_{0}\right)^{\prime}\right]_{R}$.

Now, consider $\left[f^{\prime}\right]_{R}$, where $f \in N_{R}$. Then $\left[g_{0}+f\right]_{R}=F$ and, thus, $\left[g_{0}^{\prime}+f^{\prime}\right]_{R}$ is in $A$ and $\phi\left(\left[g_{0}^{\prime}+f^{\prime}\right]_{R}\right)=\left[f^{\prime}\right]_{R}$. Therefore $\phi$ is surjective.

By Theorem 5.11 (1),

$$
\left|S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)\right|=\left|\left\{\left[h^{\prime}\right]_{R} \mid h \in N_{R}\right\}\right|=|A| .
$$

## Remark 5.14.

(1) For any fixed polynomial function $F \in \mathcal{F}(R)$, Proposition 5.13 tells us that the cardinality of the set

$$
\left\{\left[g^{\prime}\right]_{R} \mid g \in R[x] \text { with }[g]_{R}=F\right\}
$$

is independent from our choice of the polynomial function $F$.
(2) Note that Proposition 5.13 is a generalization of [1, Corollary 7.6] which considers the case when $k=1$ and $R=\mathbb{Z}_{p^{n}}(n>1)$.

Next we show that for all $k \geq 1$ the stabilizer groups $S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)$ are isomorphic.
Theorem 5.15. Let $R$ be a finite ring and let $k$ be a positive integer. Then $S t_{\alpha_{1}, \ldots, \alpha_{k}}(R) \cong$ $S t_{\alpha_{i}}(R)$ for $i=1, \ldots, k$.

Proof. Fix $i \in\{1, \ldots, k\}$. Then by the definition of dual numbers (for the case $k=1$ ), $R\left[\alpha_{1}\right] \cong$ $R\left[\alpha_{i}\right]$. Let $F \in \mathcal{P}_{R}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)$ and suppose that $F$ is induced by $f \in R[x]$. Define

$$
\psi: \mathcal{P}_{R}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right) \longrightarrow \mathcal{P}_{R}\left(R\left[\alpha_{i}\right]\right), \quad F \mapsto[f]_{R\left[\alpha_{i}\right]} .
$$

The proof of Proposition 5.5 shows that $\psi$ is an isomorphism. If $\phi$ denotes the restriction of $\psi$ to $S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)$, then $S t_{\alpha_{1}, \ldots, \alpha_{k}}(R) \cong \phi\left(S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)\right)$. Therefore, we need only show that $\phi\left(S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)\right)=S t_{\alpha_{i}}(R)$. Let $G \in S t_{\alpha_{i}}(R)$. Then $G$ is induced by $x+h(x)$ for some $h \in N_{R}$ by Proposition 5.2 (with $k=1$ ). By Corollary 4.2 and Proposition 5.2, $F=[x+h(x)]_{R\left[\alpha_{1}, \ldots, \alpha_{k}\right]} \in$ $S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)$. But then $\phi(F)=\psi(F)=[x+h(x)]_{R\left[\alpha_{i}\right]}=G$, hence $G \in \phi\left(S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)\right)$. This shows that $S t_{\alpha_{i}}(R) \subseteq \phi\left(S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)\right)$. The other inclusion is similar.

We need the following lemma which is a straightforward result of the Third Isomorpism Theorem for rings.

Lemma 5.16. Let $R$ be a finite ring. Then $\left[R[x]: N_{R}^{\prime}\right]=\left[R[x]: N_{R}\right]\left[N_{R}: N_{R}^{\prime}\right]$.
Theorem 5.17. Let $R$ be a finite ring. Then

$$
\left|\mathcal{F}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)\right|=\left[N_{R}: N_{R}^{\prime}\right]|\mathcal{F}(R)|^{k+1}
$$

Moreover, when $R$ is a direct sum of local rings which are not fields, we have

$$
\left|\mathcal{F}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)\right|=\left|S t_{\alpha_{1}, \ldots, \alpha_{k}}(R)\right| \cdot|\mathcal{F}(R)|^{k+1}
$$

Proof. We have,

$$
\begin{aligned}
\left|\mathcal{F}\left(R\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)\right| & =\left[R[x]: N_{R}^{\prime}\right]|\mathcal{F}(R)|^{k} \text { (By Proposition 3.7 and Remark 3.2) } \\
& =\left[N_{R}: N_{R}^{\prime}\right]|\mathcal{F}(R)|^{k+1} \text { (By Lemma 5.16) } .
\end{aligned}
$$

The second part follows from the above and Theorem 5.11 (2b).
We turn now to find explicitly the number of polynomial functions on $\mathbb{F}_{q}\left[\alpha_{1}, \ldots, \alpha_{k}\right]$. To do this, we need the following lemma, and we leave its proof to the reader.

Lemma 5.18. Let $\mathbb{F}_{q}$ be a finite field. Then:
(1) $N_{\mathbb{F}_{q}}=\left(x^{q}-x\right) \mathbb{F}_{q}[x]$;
(2) $N_{\mathbb{F}_{q}}^{\prime}=\left(x^{q}-x\right)^{2} \mathbb{F}_{q}[x]$.

Proposition 5.19. Let $\mathbb{F}_{q}$ be a finite field. Then $\left|\mathcal{F}\left(\mathbb{F}_{q}\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)\right|=q^{(k+2) q}$.
Proof. Set

$$
\mathcal{A}=\left\{f \mid f=f_{0}+\sum_{i=1}^{k} f_{i} \alpha_{i}, \text { where } f_{0}, f_{i} \in \mathbb{F}_{q}[x], \operatorname{deg} f_{0}<2 q, \operatorname{deg} f_{i}<q \text { for } i=1, \ldots, k\right\} .
$$

Then it is clear that $|\mathcal{A}|=q^{(k+2) q}$. To complete the proof, we show that if $f, g \in \mathcal{A}$ with $f \neq g$, then $[f] \neq[g]$, or equivalently if $[f]=[g]$, then $f=g$. Suppose that $f, g \in \mathcal{A}$, where $f_{0}+\sum_{i=1}^{k} f_{i} \alpha_{i}$ and $g_{0}+\sum_{i=1}^{k} g_{i} \alpha_{i}$, such that $[f]=[g]$. Thus $[f-g]$ is the zero function on $\mathbb{F}_{q}\left[\alpha_{1}, \ldots, \alpha_{k}\right]$. Hence $f-g=\left(f_{0}-g_{0}\right)+\sum_{i=1}^{k}\left(f_{i}-g_{i}\right) \alpha_{i}$ is a null polynomial on $\mathbb{F}_{q}\left[\alpha_{1}, \ldots, \alpha_{k}\right]$, whence $f_{0}-g_{0} \in N_{\mathbb{F}_{q}}^{\prime}$ and $f_{i}-g_{i} \in N_{\mathbb{F}_{q}}$ for $i=1, \ldots, k$ by Theorem 3.4. Then, by Lemma [5.18, we have $\left(x^{q}-x\right)^{2} \mid\left(f_{0}-g_{0}\right)$ and $\left(x^{q}-x\right) \mid\left(f_{i}-g_{i}\right)$ for $i=1, \ldots, k$. Therefore $f_{0}-g_{0}=0, f_{i}-g_{i}=0$ for $i=1, \ldots, k$ since $\operatorname{deg}\left(f_{0}-g_{0}\right)<2 q$ and $\operatorname{deg}\left(f_{i}-g_{i}\right)<q$ for $i=1, \ldots, k$. Thus $f=g$.

The following corollary shows that, when $R=\mathbb{F}_{q},\left[N_{\mathbb{F}_{q}}: N_{\mathbb{F}_{q}}^{\prime}\right] \neq\left|S t_{\alpha_{1}, \ldots, \alpha_{k}}\left(\mathbb{F}_{q}\right)\right|$ (see Theorem 5.3 and Theorem (5.11).

Corollary 5.20. Let $\mathbb{F}_{q}$ be a finite field. Then $\left[N_{\mathbb{F}_{q}}: N_{\mathbb{F}_{q}}^{\prime}\right]=\left[N_{\mathbb{F}_{q}}(<2 q): N_{\mathbb{F}_{q}}^{\prime}(<2 q)\right]=q^{q}$.
Proof. By Theorem 5.17, $\left|\mathcal{F}\left(\mathbb{F}_{q}\left[\alpha_{1}, \ldots, \alpha_{k}\right]\right)\right|=\left[N_{\mathbb{F}_{q}}: N_{\mathbb{F}_{q}}^{\prime}\right]\left|\mathcal{F}\left(\mathbb{F}_{q}\right)\right|^{k+1}$, whence $\left[N_{\mathbb{F}_{q}}: N_{\mathbb{F}_{q}}^{\prime}\right]=q^{q}$ by Proposition 5.19, On the other hand, Lemma5.18 gives $\left|N_{\mathbb{F}_{q}}(<2 q)\right|=q^{q}$ and $\left|N_{\mathbb{F}_{q}}^{\prime}(<2 q)\right|=$ 1. Thus

$$
\left[N_{\mathbb{F}_{q}}(<2 q): N_{\mathbb{F}_{q}}^{\prime}(<2 q)\right]=\frac{\left|N_{\mathbb{F}_{q}}(<2 q)\right|}{\left|N_{\mathbb{F}_{q}}^{\prime}(<2 q)\right|}=q^{q} .
$$

## 6. Necessary and sufficient conditions

In this section, an algorithm is provided which decides whether or not a given function on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ is a polynomial function and if this is so it returns its polynomial representation.

Motivated by [5, Theorem 5], we prove the following theorem.
Theorem 6.1. Let $R$ be a finite commutative ring with $n$ elements, and let $d_{1}, d_{2}$ be as in Proposition [3.8. Let $F: R\left[\alpha_{1}, \ldots, \alpha_{k}\right] \longrightarrow R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$ be a function and, for $0 \leq i \leq k$, $F_{i}: R^{k+1} \longrightarrow R$ the functions such that

$$
F\left(r_{0}+\sum_{i=1}^{k} r_{i} \alpha_{i}\right)=F_{0}\left(r_{0}, \ldots, r_{k}\right)+\sum_{i=1}^{k} F_{i}\left(r_{0}, \ldots, r_{k}\right) \alpha_{i},
$$

for all $\left(r_{0}, \ldots, r_{k}\right) \in R^{k+1}$. Then the following statements are equivalent:
(1) $F$ is a polynomial function on $R\left[\alpha_{1}, \ldots, \alpha_{k}\right]$;
(2) $F$ can be represented by a polynomial of degree $\leq d_{1}-1$;
(3) F can be represented by a polynomial

$$
f(x)=f_{0}(x)+\sum_{i=1}^{k} f_{i}(x) \alpha_{i},
$$

where $f_{0}(x)=\sum_{l=0}^{d_{1}-1} a_{0 l} x^{l}, f_{i}(x)=\sum_{m=0}^{d_{2}-1} a_{i m} x^{m}$ with $a_{0 l}, a_{i m} \in R$ for $l=0, \ldots, d_{1}-1$, $i=1, \ldots, k, m=0, \ldots, d_{2}-1 ;$
(4) $F_{0}\left(r_{0}, \ldots, r_{k}\right)$ depends only on $r_{0}$; and for $1 \leq i \leq k, F_{i}\left(r_{0}, \ldots, r_{k}\right)$ depends only on $r_{0}$ and $r_{i}$.

The system of $|R|+k|R|^{2}$ linear equations in $d_{1}+k d_{2}$ variables ( $y_{0 l}$ with $0 \leq l<d_{1}$ and $y_{i m}$ with $1 \leq i \leq k$ and $0 \leq m<d_{2}$ ),

$$
\begin{gather*}
\sum_{l=0}^{d_{1}-1} y_{0} r_{0}^{l}=b_{0}\left(r_{0}\right) \\
\sum_{l=1}^{d_{1}-1}\left(l y_{0} l r_{0}^{l-1}\right) r_{i}+\sum_{m=0}^{d_{2}-1} y_{i m} r_{0}^{m}=b_{i}\left(r_{0}, r_{i}\right) \text { for } i=1, \ldots, k, \tag{1}
\end{gather*}
$$

where $b_{0}\left(r_{0}\right)=F_{0}\left(r_{0}, \ldots, r_{k}\right), b_{i}\left(r_{0}, r_{i}\right)=F_{i}\left(r_{0}, \ldots, r_{k}\right)$ and $r_{j}$ varies through all elements of $R$ for $j=0,1, \ldots, k$, has a solution in $R$.

Proof. It is clear that $(3) \Rightarrow(2) \Rightarrow(1)$. The implication $(1) \Rightarrow(3)$ follows by Proposition 3.8, $(3) \Rightarrow(4)$ the first statement follows from Corollary [2.7. Then, suppose that $F$ can be represented by a polynomial $f \in R\left[\alpha_{1}, \ldots, \alpha_{k}\right][x]$, where $f=f_{0}+\sum_{i=1}^{k} f_{i} \alpha_{i}$, such that $f_{0}(x)=$ $\sum_{l=0}^{d_{1}-1} a_{0} x^{l}, f_{i}(x)=\sum_{m=0}^{d_{2}-1} a_{i m} x^{m}$, where $f_{0}, f_{i} \in R[x]$ for $i=1, \ldots, k$. So, for $r_{0}, \ldots, r_{k} \in R$, we have since $F$ is induced by $f$,

$$
\begin{aligned}
F\left(r_{0}+\right. & \left.\sum_{i=1}^{k} r_{i} \alpha_{i}\right)=f\left(r_{0}+\sum_{i=1}^{k} r_{i} \alpha_{i}\right)=f_{0}\left(r_{0}\right)+\sum_{i=1}^{k}\left(r_{i} f_{0}^{\prime}\left(r_{0}\right)+f_{i}\left(r_{0}\right)\right) \alpha_{i} \text { (by Lemma 2.6) } \\
& =\sum_{l=0}^{d_{1}-1} a_{0} r_{0}^{l}+\sum_{i=1}^{k}\left(\sum_{l=1}^{d_{1}-1} r_{i}\left(l a_{0} l r_{0}^{l-1}\right)+\sum_{m=0}^{d_{2}-1} a_{i m} r_{0}^{m}\right) \alpha_{i} \\
& =F_{0}\left(r_{0}, \ldots, r_{k}\right)+\sum_{i=1}^{k} F_{i}\left(r_{0}, \ldots, r_{k}\right) \alpha_{i}(\text { by the definition of } F) \\
& =b_{0}\left(r_{0}\right)+\sum_{i=1}^{k} b_{i}\left(r_{0}, r_{i}\right) \alpha_{i} .
\end{aligned}
$$

Therefore,

$$
\begin{gathered}
\sum_{l=0}^{d_{1}-1} a_{0 l} r_{0}^{l}=b_{0}\left(r_{0}\right) \\
\sum_{l=1}^{d_{1}-1}\left(l a_{0} l r_{0}^{l-1}\right) r_{i}+\sum_{m=0}^{d_{2}-1} a_{i m} r_{0}^{m}=b_{i}\left(r_{0}, r_{i}\right) \text { for } i=1, \ldots, k .
\end{gathered}
$$

Hence, since each $r_{j}$ varies through all the elements of $R$, the system of linear equations (1) has a solution $y_{0 l}=a_{0 l}, y_{i m}=a_{i m}$, for $l=0, \ldots, d_{1}-1 ; m=0, \ldots, d_{2}-1 ; i=1, \ldots, k$.

Finally, we can prove (4) $\Rightarrow(3)$ by reversing the previous steps.
