# $n$-exact Character Graphs

#### Abstract

Let $\Gamma$ be a finite simple graph. If for some integer $n \geqslant 4, \Gamma$ is a $K_{n}$-free graph whose complement has an odd cycle of length at least $2 n-5$, then we say that $\Gamma$ is an $n$-exact graph. For a finite group $G$, let $\Delta(G)$ denote the character graph built on the set of degrees of the irreducible complex characters of $G$. In this paper, we prove that the order of an $n$-exact character graph is at most $2 n-1$. Also we determine the structure of all finite groups $G$ with extremal $n$-exact character graph $\Delta(G)$.

## 1 Introduction

Let $G$ be a finite group and $R(G)$ be the solvable radical of $G$. Also let $\operatorname{cd}(G)$ be the set of all character degrees of $G$, that is, $\operatorname{cd}(G)=\{\chi(1) \mid \chi \in \operatorname{Irr}(G)\}$, where $\operatorname{Irr}(G)$ is the set of all complex irreducible characters of $G$. The set of prime divisors of character degrees of $G$ is denoted by $\rho(G)$. It is well known that the character degree set $\operatorname{cd}(G)$ may be used to provide information on the structure of the group $G$. For example, a result due to Berkovich [5] says that if a prime $p$ divides every non-linear character degree of a group $G$, then $G$ is solvable.

A useful way to study the character degree set of a finite group $G$ is to associate a graph to $\operatorname{cd}(G)$. One of these graphs is the character graph $\Delta(G)$ of $G$ [13]. Its vertex set is $\rho(G)$ and two vertices $p$ and $q$ are joined by an edge

[^0]if the product $p q$ divides some character degree of $G$. We refer the readers to a survey by Lewis [10] for results concerning this graph and related topics.

There is an interesting conjecture on the structure of $\Delta(G)$ which is posed by Akhlaghi and Tong-Viet in 4]:

Conjecture. Let $G$ be a finite group such that for some positive integer $n$, $\Delta(G)$ is $K_{n}$-free. If $G$ is solvable, then $|\rho(G)| \leqslant 2 n-2$, and if $G$ is nonsolvable, then $|\rho(G)| \leqslant 2 n-1$.
In [1], it was shown that for a solvable group $G$, the complement of $\Delta(G)$ does not have an odd cycle, in other word, it is bipartite. This result guarantees this conjecture for solvable groups. The conjecture still is not proved for non-solvable groups, however the results in [15], [4] and [3] say that it is true when $n \in\{3,4,5\}$. Now let $\Gamma$ be a finite simple graph. If for some integer $n \geqslant 4, \Gamma$ is a $K_{n}$-free graph whose complement has an odd cycle of length at least $2 n-5$, then we say that $\Gamma$ is an $n$-exact graph. For example, $K_{4}$-free graphs with non-bipartite complement are 4-exact. In this paper, we wish to show that the conjecture is true for a finite group whose character graph is $n$-exact, for some integer $n \geqslant 4$.

Theorem A. Let $G$ be a finite group, and $n \geqslant 4$ be an integer. If $\Delta(G)$ is an n-exact graph, then there exists a normal subgroup $R(G)<M \leqslant G$ so that $G / R(G)$ is an almost simple group with socle $S:=M / R(G) \cong \mathrm{PSL}_{2}(\mathrm{q})$, where $q$ is a prime power, and $|\rho(G)| \leqslant 2 n-1$.

The solvable group $G$ is said to be disconnected if $\Delta(G)$ is disconnected. Also $G$ is called of disconnected Type $n$ if $G$ satisfies the hypotheses of Example $2 . n$ in [9]. Let $n \geqslant 4$ be an integer and $\Gamma$ be a finite simple graph with vertex set $V$. The cardinality of $V$ is called the order of $\Gamma$. An $n$-exact graph $\Gamma$ with minimum or maximum possible order is called an extremal $n$-exact graph. Note that for an integer $n \geqslant 1$, the set of prime divisors of $n$ is denoted by $\pi(n)$. Now we are ready to state the next result of this paper.

Corollary B. Let $G$ be a finite group with extremal $n$-exact character graph $\Delta(G)$, for some integer $n \geqslant 4$. Then one of the following cases occurs:
a) $|\rho(G)|=2 n-5$ and for some integer $\alpha \geqslant 2, G \cong \operatorname{PSL}_{2}\left(2^{\alpha}\right) \times \mathrm{R}(\mathrm{G})$, where $\left|\pi\left(2^{\alpha} \pm 1\right)\right|=n-3$ and $R(G)$ is abelian.
b) $|\rho(G)|=2 n-1$ and for some integer $\alpha \geqslant 2, G \cong \operatorname{PSL}_{2}\left(2^{\alpha}\right) \times \mathrm{R}(\mathrm{G})$, where $\left|\pi\left(2^{\alpha} \pm 1\right)\right|=n-3, n-2$ or $n-1$. Also
i) If $\left|\pi\left(2^{\alpha} \pm 1\right)\right|=n-3$, then for some disconnected groups $A$ and $B$ of disconnected Types 1 or $4, R(G) \cong A \times B,|\rho(A)|=|\rho(B)|=2$ and $\rho(G)=$ $\pi(S) \uplus \rho(A) \uplus \rho(B)$.
ii) If $\left|\pi\left(2^{\alpha} \pm 1\right)\right|=n-2$, then $R(G)$ is a disconnected group of disconnected Type 1 or $4,|\rho(R(G))|=2$ and $\rho(G)=\pi(S) \uplus \rho(R(G))$.
iii) If $\left|\pi\left(2^{\alpha} \pm 1\right)\right|=n-1$, then $R(G)$ is abelian and $\rho(G)=\pi(S)$.

## 2 Preliminaries

In this paper, all groups are assumed to be finite and all graphs are simple and finite. For a finite group $G$, the set of prime divisors of $|G|$ is denoted by $\pi(G)$. If $H \leqslant G$ and $\theta \in \operatorname{Irr}(\mathrm{H})$, we denote by $\operatorname{Irr}(\mathrm{G} \mid \theta)$ the set of irreducible characters of $G$ lying over $\theta$ and define $\operatorname{cd}(\mathrm{G} \mid \theta):=\{\chi(1) \mid \chi \in \operatorname{Irr}(\mathrm{G} \mid \theta)\}$. We frequently use, Gallagher's Theorem which is corollary 6.17 of [8].

Lemma 2.1. Let $N \triangleleft G$ and $\varphi \in \operatorname{Irr}(\mathrm{N})$. Then for every $\chi \in \operatorname{Irr}(\mathrm{G} \mid \varphi)$, $\chi(1) / \varphi(1)$ divides $[G: N]$.

Let $\Gamma$ be a graph with vertex set $V(\Gamma)$ and edge set $E(\Gamma)$. The complement of $\Gamma$ and the induced subgraph of $\Gamma$ on $X \subseteq V(\Gamma)$ are denoted by $\Gamma^{c}$ and $\Gamma[X]$, respectively. If $E(\Gamma)=\emptyset, \Gamma$ is called an empty graph. When $n:=|V(\Gamma)|$, any cycle of $\Gamma$ of length $n$ is called a Hamilton cycle. We say that $\Gamma$ is Hamiltonian if it contains a Hamilton cycle. We use the notations $K_{n}$ for a complete graph with $n$ vertices and $C_{n}$ for a cycle of length $n$. If for some integer $n \geqslant 2$, $\Gamma$ does not contain a copy of $K_{n}$ as an induced subgraph, then $\Gamma$ is called a $K_{n}$-free graph. We now state some relevant results on character graphs needed in the next sections.

Lemma 2.2. [1] Let $G$ be a solvable group. Then $\Delta(G)^{c}$ is bipartite.
Lemma 2.3. [11] Let $G$ be a solvable group with $\Delta(G) \cong C_{4}$. Then $G \cong$ $A \times B$, where $A$ and $B$ are disconnected groups. Also for some distinct primes $p, q, r$ and $s, \rho(A)=\{p, q\}$ and $\rho(B)=\{r, s\}$.

Lemma 2.4. [11] Let $G$ be a solvable group. If $\Delta(G)$ has at least 4 vertices, then either $\Delta(G)$ contains a triangle or $\Delta(G) \cong C_{4}$.

The structure of the character graphs of $\mathrm{PSL}_{2}(\mathrm{q})$ and ${ }^{2} B_{2}\left(q^{2}\right)$ are determined as follows:

Lemma 2.5. 177 Let $G \cong \operatorname{PSL}_{2}(\mathrm{q})$, where $q \geqslant 4$ is a power of a prime $p$.
a) If $q$ is even, then $\Delta(G)$ has three connected components, $\{2\}, \pi(q-1)$ and $\pi(q+1)$, and each component is a complete graph.
b) If $q>5$ is odd, then $\Delta(G)$ has two connected components, $\{p\}$ and $\pi((q-$ 1) $(q+1))$.
i) The connected component $\pi((q-1)(q+1))$ is a complete graph if and only
if $q-1$ or $q+1$ is a power of 2 .
ii) If neither of $q-1$ or $q+1$ is a power of 2 , then $\pi((q-1)(q+1))$ can be partitioned as $\{2\} \cup M \cup P$, where $M=\pi(q-1)-\{2\}$ and $P=\pi(q+1)-\{2\}$ are both non-empty sets. The subgraph of $\Delta(G)$ corresponding to each of the subsets $M, P$ is complete, all primes are adjacent to 2, and no prime in $M$ is adjacent to any prime in $P$.

Lemma 2.6. [16] Let $G \cong^{2} B_{2}\left(q^{2}\right)$, where $q^{2}=2^{2 m+1}$ and $m \geqslant 1$. The set of primes $\rho(G)$ can be partitioned as $\rho(G)=\{2\} \cup \pi\left(q^{2}-1\right) \cup \pi\left(q^{4}+1\right)$. The subgraph of $\Delta(G)$ on $\rho(G)-\{2\}$ is complete and 2 is adjacent in $\Delta(G)$ to precisely the primes in $\pi\left(q^{2}-1\right)$.

When $\Delta(G)^{c}$ is not a bipartite graph, then there exists a useful restriction on the structure of $G$ as follows:

Lemma 2.7. [2] Let $G$ be a finite group and $\pi$ be a subset of the vertex set of $\Delta(G)$ such that $|\pi|>1$ is an odd number. Then $\pi$ is the set of vertices of a cycle in $\Delta(G)^{c}$ if and only if $O^{\pi^{\prime}}(G)=S \times A$, where $A$ is abelian, $S \cong \mathrm{SL}_{2}\left(\mathrm{u}^{\alpha}\right)$ or $S \cong \mathrm{PSL}_{2}\left(\mathrm{u}^{\alpha}\right)$ for a prime $u \in \pi$ and a positive integer $\alpha$, and the primes in $\pi-\{u\}$ are alternately odd divisors of $u^{\alpha}+1$ and $u^{\alpha}-1$.
Lemma 2.8. [12] Let $p$ be a prime, $f \geqslant 2$ be an integer, $q=p^{f} \geqslant 5$ and $S \cong \mathrm{PSL}_{2}(\mathrm{q})$. If $q \neq 9$ and $S \leqslant G \leqslant \operatorname{Aut}(\mathrm{~S})$, then $G$ has irreducible characters of degrees $(q+1)\left[G: G \cap \mathrm{PGL}_{2}(\mathrm{q})\right]$ and $(q-1)\left[G: G \cap \mathrm{PGL}_{2}(\mathrm{q})\right]$.

Now we present some facts on the structure of character graphs with non-bipartite complement.

Lemma 2.9. [7] Let $G$ be a finite group, $R(G)<M \leqslant G, S:=M / R(G)$ be isomorphic to $\mathrm{PSL}_{2}(\mathrm{q})$, where for some prime $p$ and positive integer $f \geqslant 1$, $q=p^{f},|\pi(S)| \geqslant 4$ and $S \leqslant G / R(G) \leqslant \operatorname{Aut}(\mathrm{S})$. Also let $\theta \in \operatorname{Irr}(\mathrm{R}(\mathrm{G}))$. If $\Delta(G)^{c}$ is not bipartite, then $\theta$ is $M$-invariant.

Lemma 2.10. 77] Assume that $f \geqslant 2$ is an integer, $q=2^{f}, S \cong \mathrm{PSL}_{2}$ (q) and $G$ is a finite group such that $G / R(G)=S$. If $\Delta(G)[\pi(S)]=\Delta(S)$, then $G \cong S \times R(G)$.

Lemma 2.11. [6] Let $G$ be a finite group. The complement of the character graph $\Delta(G)$ is a non-bipartite Hamiltonian graph if and only if $G \cong \operatorname{SL}_{2}\left(2^{\mathrm{f}}\right) \times$ A, where $f \geqslant 2$ is an integer, $\left|\left|\pi\left(2^{f}+1\right)\right|-\left|\pi\left(2^{f}-1\right)\right|\right| \leqslant 1$ and $A$ is an abelian group.

We end this section with the following result.
Lemma 2.12. [7] Let $G$ be a disconnected group. If $|\rho(G)|=2$ and $2 \notin \rho(G)$, then $G$ is of disconnected Type 1 or 4.

## 3 The proof of Main results

In this section, we wish to prove our main results. When $G$ is a finite group with 4 -exact character graph, then using [4, 7] and Lemma 2.11 we have nothing to prove. Hence in the sequel, we assume that $G$ is a finite group such that for some integer $n \geqslant 5, \Delta(G)$ is $n$-exact.

Lemma 3.1. Suppose $G$ is a finite group and $\Delta(G)$ is an n-exact graph, for some integer $n \geqslant 5$. Then
a) There exists a normal subgroup $R(G)<M \leqslant G$ so that $G / R(G)$ is an almost simple group with socle $S:=M / R(G) \cong \mathrm{PSL}_{2}\left(\mathrm{u}^{\alpha}\right)$, where $u$ is a prime, $\alpha$ is a positive integer and $u^{\alpha}>5$.
b) For some $\pi_{0} \subseteq \pi(S)$ and integer $m \geqslant n-3, \Delta(G)\left[\pi_{0}\right]$ precisely contains three connected components $\Delta(G)[\{u\}]$ and $\Delta(G)\left[\pi\left(u^{\alpha} \pm 1\right) \cap \pi_{0}\right] \cong K_{m}$.
c) If $\pi$ is the set of vertices of an odd cycle in $\Delta(G)^{c}$, then $u \in \pi \subseteq \pi(S)$.

Now let $\pi_{R}:=\rho(R(G))-\pi(G / R(G)), \pi_{M}:=\pi([G: M])-\rho(M)$ and $\pi_{F}=\pi_{R} \cup \pi_{M}$.
d) $\Delta(G)\left[\pi_{M}\right]$ is a complete graph with at most two vertices and every $p \in \pi_{F}$ is adjacent to all vertices in $\pi\left(u^{2 \alpha}-1\right)$.
e) If $u=2$ and $\pi([G: M]) \subseteq \pi_{F}$, then for every $\theta \in \operatorname{Irr}(\mathrm{R}(\mathrm{G})), \Delta(G)[\pi(\theta(1)[G$ : $\left.\left.M]\left(u^{\alpha} \pm 1\right)\right)\right]$ are complete.

Proof. a,b) Since $\Delta(G)$ is an $n$-exact graph, for some $\pi_{0} \subseteq \rho(G), \pi_{0}$ is the set of vertices of an odd cycle in $\Delta(G)^{c}$ and $\left|\pi_{0}\right| \geqslant 2 n-5$. By Lemma 2.7, $N:=O^{\pi_{0}^{\prime}}(G)=R \times A$, where $A$ is abelian, $R \cong \operatorname{SL}_{2}\left(\mathrm{u}^{\alpha}\right)$ or $R \cong \operatorname{PSL}_{2}\left(\mathrm{u}^{\alpha}\right)$ for a prime $u \in \pi_{0}$ and a positive integer $\alpha$, and the primes in $\pi_{0}-\{u\}$ are alternately odd divisors of $u^{\alpha}+1$ and $u^{\alpha}-1$. Hence $m:=\mid \pi\left(u^{\alpha} \pm\right.$ 1) $\cap \pi_{0} \mid \geqslant n-3$ and $\Delta(G)\left[\pi\left(u^{\alpha} \pm 1\right) \cap \pi_{0}\right] \cong K_{m}$. Assume that for some $\epsilon \in\{ \pm 1\}$, there exist $x \in\left(\pi\left(u^{\alpha}+\epsilon\right) \cap \pi_{0}\right) \cup\{u\}$ and $y \in \pi\left(u^{\alpha}-\epsilon\right) \cap \pi_{0}$ so that $x$ and $y$ are adjacent vertices in $\Delta(G)$. Then for some $\chi \in \operatorname{Irr}(\mathrm{G})$, $x y$ divides $\chi(1)$. No let $\theta \in \operatorname{Irr}(\mathrm{N})$ be a constituent of $\chi_{N}$. By Lemma 2.1, xy divides $\theta(1)$. It is a contradiction. Thus $\Delta(G)[\{u\}]$ and $\Delta(G)\left[\pi\left(u^{\alpha} \pm 1\right) \cap \pi_{0}\right]$ are precisely connected components of $\Delta(G)\left[\pi_{0}\right]$. Let $M:=N R(G)$. Then $S:=M / R(G) \cong N / R(N) \cong \mathrm{PSL}_{2}\left(\mathrm{u}^{\alpha}\right)$ is a non-abelian minimal normal subgroup of $G / R(G)$.

Let $C / R(G)=C_{G / R(G)}(M / R(G))$. We claim that $C=R(G)$ and $G / R(G)$ is an almost simple group with socle $S=M / R(G)$. Suppose on the contrary that $C \neq R(G)$ and let $L / R(G)$ be a chief factor of $G$ with $L \leqslant C$. Then $L / R(G) \cong T^{k}$, for some non-abelian simple group $T$ and some integer $k \geqslant 1$. As $L \leqslant C, L M / R(G) \cong L / R(G) \times M / R(G) \cong S \times T^{k}$. Let $F:=\pi(S) \cap \pi(T)$. Note that $\pi_{0} \cap \rho(T)=\emptyset,|\rho(T)| \geqslant 3$ and $2 \in F$. Now one of the following cases occurs:

Case 1. $|F|=1$ : Then $F=\{2\}$. Hence 3 does not divide $|T|$. Therefore by [14], $T$ is a Suzuki simple group. By Lemma[2.6, $\Delta(T) \subseteq \Delta\left(S \times T^{k}\right)$ contains a triangle. Thus $\Delta\left(S \times T^{k}\right)\left[\pi\left(u^{\alpha}+1\right) \cup \rho(T)\right]$ contains a copy of $K_{n}$ and it is a contradiction.
Case 2. $|F| \geqslant 2$ : Then it is easy to see that $\Delta\left(S \times T^{k}\right)\left[\pi\left(u^{\alpha}+1\right) \cup \rho(T)\right]$ contains a copy of $K_{n}$ and it is again a contradiction.
c) Let $\pi \subseteq \rho(G)$ be the set of vertices of an odd cycle in $\Delta(G)^{c}$. Then using Lemma 2.7, $N_{1}:=O^{\pi^{\prime}}(G)=R_{1} \times A_{1}$, where $A_{1}$ is abelian, $R_{1} \cong \operatorname{SL}_{2}\left(\mathrm{u}_{1}^{\alpha_{1}}\right)$ or $R_{1} \cong \mathrm{PSL}_{2}\left(\mathrm{u}_{1}^{\alpha_{1}}\right)$ for a prime $u_{1} \in \pi$ and a positive integer $\alpha_{1}$, and the primes in $\pi-\left\{u_{1}\right\}$ are alternately odd divisors of $u_{1}^{\alpha_{1}}+1$ and $u_{1}^{\alpha_{1}}-1$. Thus $S_{1}:=N_{1} R(G) / R(G) \cong \mathrm{PSL}_{2}\left(\mathrm{u}_{1}^{\alpha_{1}}\right)$ is a minimal normal subgroup of $G / R(G)$ and $u_{1} \in \pi \subseteq \pi\left(S_{1}\right)$. Hence by part (a), $S=S_{1}$ and $u=u_{1}$.
d) Using Lemma [2.8, Lemma 2.9 and this fact that $\mathrm{SL}_{2}\left(\mathrm{u}^{\alpha}\right)$ is the schur representation of $S, \Delta(G)\left[\pi_{M}\right]$ is complete and every $p \in \pi_{F}$ is adjacent to all vertices in $\pi\left(u^{2 \alpha}-1\right)$. If $\left|\pi_{M}\right| \geqslant 3$, then $\Delta(G)\left[\pi_{M} \cup \pi\left(u^{\alpha}+1\right)\right]$ contains a copy of $K_{n}$ and it is a contradiction. Thus $\left|\pi_{M}\right| \leqslant 2$.
e) Let $d=[G: M]$. Then $G / R(G) \cong S \rtimes \mathbb{Z}_{d}$. Note that $\pi(d) \cap \pi(S)=$ $\emptyset$. Therefore as the schur multiplier of $S$ is trivial, the schur multiplier of $G / R(G)$ is too. Hence by Lemma 2.8 and Gallagher's Theorem, for every $\theta \in \operatorname{Irr}(\mathrm{R}(\mathrm{G})), \theta(1) d\left(u^{\alpha} \pm 1\right) \in \mathrm{cd}(\mathrm{G})$ and it completes the proof.

Proof of Theorem A. By Lemma $3.1(\mathrm{a}, \mathrm{b})$, there exists a normal subgroup $R(G)<M \leqslant G$ so that $G / R(G)$ is an almost simple group with socle $S:=$ $M / R(G) \cong \mathrm{PSL}_{2}\left(\mathrm{u}^{\alpha}\right)$, where $u$ is a prime, $\alpha$ is a positive integer and $u^{\alpha}>5$. Also for some $\pi_{0} \subseteq \pi(S)$ and integer $m \geqslant n-3, \Delta(G)\left[\pi_{0}\right]$ precisely contains three connected components $\Delta(G)[\{u\}]$ and $\Delta(G)\left[\pi\left(u^{\alpha} \pm 1\right) \cap \pi_{0}\right] \cong K_{m}$. It is easy to see that $\rho(G)=\pi_{F} \uplus \pi(S)$. Using Lemma 3.1 (d), $\Delta(G)\left[\pi_{M}\right]$ is a complete graph with at most two vertices and every $p \in \pi_{F}$ is adjacent to all vertices in $\pi\left(u^{2 \alpha}-1\right)$. Now one of the following cases occurs:
Case 1: $\left|\pi\left(u^{\alpha} \pm 1\right)\right|=n-3$. Then by Lemma[2.5, $u=2$ and $\Delta(G)\left[\pi_{0}\right]=\Delta(S)$. We claim that $\left|\pi_{F}\right| \leqslant 4$. On the contrary, we assume that $\left|\pi_{F}\right| \geqslant 5$. Let $d:=[G: M]$. Then using Lemma [2.8, $\pi(d) \cap \pi(S)=\emptyset$ and $\pi(d) \subseteq \pi_{F}$. If $\pi_{M} \neq \emptyset$, then as $\left|\pi_{M}\right| \leqslant 2$, using Lemmas 2.2] and 3.1(e), $\Delta(G)\left[\pi_{F} \cup \pi\left(u^{\alpha}+1\right)\right]$ contains a copy of $K_{n}$ which is impossible. Thus $\pi_{M}=\emptyset$ and $\pi_{F}=\pi_{R}$. Therefore using Lemma [2.2, $\Delta(G)\left[\pi_{F}\right]$ contains a triangle and by Lemma 3.1 (e), we again obtain a contradiction. Thus $\left|\pi_{F}\right| \leqslant 4$ and $|\rho(G)| \leqslant 2 n-1$.

Case 2: $\left|\pi\left(u^{\alpha} \pm 1\right)\right| \leqslant n-2$ and for some $\epsilon \in\{ \pm 1\},\left|\pi\left(u^{\alpha}+\epsilon\right)\right|=n-2$. If $\left|\pi_{F}\right| \geqslant 3$, then using Lemma 3.1 (c), $\Delta(G)\left[\pi_{F}\right]$ is a non-empty graph and $\Delta(G)\left[\pi_{F} \cup \pi\left(u^{\alpha}+\epsilon\right)\right]$ contains a copy of $K_{n}$ which is a contradiction. Thus $\left|\pi_{F}\right| \leqslant 2$ and $|\rho(G)| \leqslant 2 n-1$.
Case 3: For some $\epsilon \in\{ \pm 1\},\left|\pi\left(u^{\alpha}+\epsilon\right)\right|=n-1$. Then by Lemma 3.1 (d),
$\pi_{F}=\emptyset$ and so $|\rho(G)| \leqslant 2 n-1$.

### 3.1 Proof of Corollary B.

Let $G$ be a finite group with extremal $n$-exact character graph $\Delta(G)$, for some integer $n \geqslant 5$. Then using Theorem A, $|\rho(G)|=2 n-5$ or $2 n-1$. If $|\rho(G)|=2 n-5$, then by Lemma 2.11, we are done. Thus we can assume that $|\rho(G)|=2 n-1$. By Lemma 3.1, there exists a normal subgroup $R(G)<M \leqslant$ $G$ so that $G / R(G)$ is an almost simple group with socle $S:=M / R(G) \cong$ $\operatorname{PSL}_{2}\left(\mathrm{u}^{\alpha}\right)$, where $u$ is a prime, $\alpha$ is a positive integer and $u^{\alpha}>5$. Also for some $\pi_{0} \subseteq \pi(S)$ and integer $m \geqslant n-3, \Delta(G)\left[\pi_{0}\right]$ precisely contains three connected components $\Delta(G)[\{u\}]$ and $\Delta(G)\left[\pi\left(u^{\alpha} \pm 1\right) \cap \pi_{0}\right] \cong K_{m}$. Since $\Delta(G)$ is $K_{n}$-free, $\Delta(S)$ is too. The structure of $\Delta(S)$ is determined by Lemma 2.5.

Lemma 3.2. Let $\Delta(G)\left[\pi_{F}\right]$ be a non-empty graph and $|\pi(S)| \geqslant 2 n-4$. Then $G$ does not exist.

Proof. Since $|\pi(S)| \geqslant 2 n-4$, there exists $\epsilon \in\{ \pm 1\}$ such that $\left|\pi\left(u^{\alpha}+\epsilon\right)\right| \geqslant$ $n-2$. Thus using Lemma 3.1 (d), $\Delta(G)\left[\pi_{F} \cup \pi\left(u^{\alpha}+\epsilon\right)\right]$ contains a copy of $K_{n}$ and it is a contradiction.

Lemma 3.3. If $\left|\pi\left(u^{\alpha} \pm 1\right)\right|=n-3$, then $u=2$ and $G \cong S \times A \times B$, where $A$ and $B$ are disconnected groups of disconnected Types 1 or $4,|\rho(A)|=$ $|\rho(B)|=2$ and $\rho(G)=\pi(S) \uplus \rho(A) \uplus \rho(B)$.

Proof. Since $\left|\pi\left(u^{\alpha} \pm 1\right)\right|=n-3, \pi(S)=\pi_{0}$. Thus $\left|\pi_{F}\right|=4, u=2$ and $\Delta(G)[\pi(S)]=\Delta(S)$. If $d:=[G: M]$, then using Lemma 2.8, $\pi(d) \cap \pi(S)=$ $\emptyset$ and so $\pi(d) \subseteq \pi_{F}$. Now we claim that $d=1$ and $G=M$. On the contrary, we assume that $d \neq 1$. If $|\pi(d)| \geqslant 2$, then by Lemma 3.1 (e), $\Delta(G)\left[\pi_{F} \cup \pi\left(u^{\alpha}+1\right)\right]$ contains a copy of $K_{n}$ which is a contradiction. Also if $|\pi(d)|=1$, then using Lemma 2.2, $\Delta(G)\left[\pi_{R}\right]$ is non-empty and by Lemma3.1] (e), $\Delta(G)\left[\pi_{F} \cup \pi\left(u^{\alpha}+1\right)\right]$ again contains a copy of $K_{n}$ and it is a contradiction. Therefore $d=1$ and $G=M$. Hence by Lemma 2.10, $G \cong S \times R(G)$. Thus as $\Delta(G)[\pi(S)]=\Delta(S), \pi(S) \cap \rho(R(G))=\emptyset$ and $\rho(R(G))=\pi_{R}=\pi_{F}$. Also as $\Delta(G)$ is $K_{n}$-free, $\Delta(R(G))$ is $K_{3}$-free. Hence using Lemma 2.4, $\Delta(R(G)) \cong$ $C_{4}$. Thus by Lemma 2.3, $R(G) \cong A \times B$, where $A$ and $B$ are disconnected groups with $|\rho(A)|=|\rho(B)|=2$. Therefor by Lemma 2.12, $A$ and $B$ are of disconnected Types 1 or 4 and the proof is completed.

Lemma 3.4. If $\left|\pi\left(u^{\alpha} \pm 1\right)\right|=n-2$ and $u=2$, then $G \cong S \times R(G)$, where $R(G)$ is a disconnected group of disconnected Type 1 or 4 . Also $|\rho(R(G))|=2$ and $\rho(G)=\pi(S) \uplus \rho(R(G))$.

Proof. Since $|\rho(G)|=2 n-1,\left|\pi_{F}\right|=2$. If $\pi_{F}=\pi_{M}$, then using Lemma 3.1 (d), $\Delta(G)\left[\pi_{F} \cup \pi\left(u^{\alpha}+1\right)\right]$ is a copy of $K_{n}$ which is a contradiction. Hence $\pi_{R}$ is non-empty. Note that there exist $x \in \pi\left(u^{\alpha}+1\right)$ and $y \in \pi\left(u^{\alpha}-1\right)$ such that $\pi\left(u^{\alpha}+1\right)=\pi_{0} \cup\{x\}$ and $\pi\left(u^{\alpha}-1\right)=\pi_{0} \cup\{y\}$. Let $d:=[G: M]$. We claim that $x, y \notin \pi(d)$. On the contrary, we assume that $z \in\{x, y\} \cap \pi(d)$. Then using Lemmas 2.8 and 3.1 (d), $\Delta(G)\left[\pi_{R} \cup\{z\} \cup \pi\left(u^{2 \alpha}-1\right)\right]$ contains a copy of $K_{n}$ which is impossible. Thus $x, y \notin \pi(d)$. Suppose $p \in \pi_{0} \cap \pi(d)$. Then by Lemma [2.8, $p$ is adjacent to all vertices in $\pi_{0}-\{u, p\}$. It is a contradiction with the structure of $\Delta\left(G\left[\pi_{0}\right]\right)$. Therefore $\pi(d) \subseteq \pi_{F}$. If $d \neq 1$, then by Lemma $3.1(\mathrm{e}), \Delta(G)\left[\pi_{F} \cup \pi\left(u^{\alpha}+1\right)\right]$ contains a copy of $K_{n}$ which is a contradiction. Thus $d=1$ and $G=M$. Hence there exist distinct primes $q$ and $q^{\prime}$ such that $\pi_{F}=\pi_{R}=\left\{q, q^{\prime}\right\}$. Note that as the schur multiplier of $S$ is trivial, by Gallagher's Theorem, $q$ and $q^{\prime}$ are adjacent to all vertices in $\pi(S)$. Now we claim that $\Delta(G)[\pi(S)]=\Delta(S)$. On the contrary, we assume that there exist adjacent vertices $a, b \in \pi(S)$ in $\Delta(G)$ such that $a$ and $b$ are non-adjacent vertices in $\Delta(S)$. Then for some $\chi \in \operatorname{Irr}(\mathrm{G}), a b$ divides $\chi(1)$. Let $\theta \in \operatorname{Irr}(\mathrm{R}(\mathrm{G}))$ be a constituent of $\chi_{R(G)}$. Then using Lemma 2.9, $\theta$ is $G$-invariant. Thus as the Schur multiplier of $S$ is trivial, by Gallagher's Theorem, $\operatorname{cd}(\mathrm{G} \mid \theta)=\{\mathrm{m} \theta(1) \mid \mathrm{m} \in \operatorname{cd}(\mathrm{S})\}$. Hence as $\chi(1) \in \operatorname{cd}(\mathrm{G} \mid \theta), \theta(1)$ is divisible by $a$ or $b$. Without loss of generality, we assume that $a$ divides $\theta(1)$. There exists $\epsilon \in\{ \pm 1\}$ so that $a \notin \pi\left(u^{\alpha}+\epsilon\right)$. Thus the induced subgraph of $\Delta(G)$ on $X:=\pi\left(u^{\alpha}+\epsilon\right) \cup\{a, q\}$ is a copy of $K_{n}$ and it is a contradiction. Therefore $\Delta(G)[\pi(S)]=\Delta(S)$. Hence by Lemma 2.10, $G \cong S \times R(G)$. If $\rho(R(G)) \cap \pi(S) \neq \emptyset$, then the induced subgraph of $\Delta(G)$ on $\pi(S) \cup\{q\}$ contains a copy of $K_{n}$ and it is a contradiction. Thus as $\Delta(G)$ is $K_{n}$-free, it is easy to see that $\rho(R(G))=\pi_{R}=\left\{q, q^{\prime}\right\}$ and $\Delta(R(G)) \cong K_{2}^{c}$. Therefore by Lemma [2.12, $R(G)$ is a disconnected group of disconnected Type 1 or 4. Finally, $\rho(G)=\pi(S) \uplus \rho(R(G))$ and the proof is completed.

Lemma 3.5. If $\left|\pi\left(u^{\alpha} \pm 1\right)\right|=n-1$ and $u=2$, then $G \cong S \times R(G)$, where $R(G)$ is abelian and $\rho(G)=\pi(S)$.

Proof. Since $|\rho(G)|=2 n-1, \rho(G)=\pi(S)$. If $G \neq M$, then using Lemma 2.8, $\Delta(G)$ contains a copy of $K_{n}$ which is impossible. Thus $G=M$. We claim that $\Delta(G)[\pi(S)]=\Delta(S)$. On the contrary, we assume that there exist nonadjacent vertices $x$ and $y$ in $\Delta(S)$ such that $x$ and $y$ are adjacent vertices in $\Delta(G)$. Thus for some $\chi \in \operatorname{Irr}(\mathrm{G}), \chi(1)$ is divisible by $x y$. Let $\theta \in \operatorname{Irr}(\mathrm{R}(\mathrm{G}))$ be a constituent of $\chi_{R(G)}$. Using Lemma [2.9, $\theta$ is $G$-invariant. Thus as the Schur multiplier of $S$ is trivial, $\theta$ extends to $G$. By Gallagher's Theorem, $\operatorname{cd}(\mathrm{G} \mid \theta)=\{\mathrm{m} \theta(1) \mid \mathrm{m} \in \mathrm{cd}(\mathrm{S})\}$. Thus as $\chi(1) \in \operatorname{cd}(\mathrm{G} \mid \theta)$ is divisible by $x y$, $\theta(1)$ is divisible by $x$ or $y$. Hence one of the character degrees $\theta(1)\left(u^{\alpha}-1\right)$ or $\theta(1)\left(u^{\alpha}+1\right)$ of $G$ is divisible by $n$ distinct primes which is a contradiction.

Therefore $\Delta(G)[\pi(S)]=\Delta(S)$. Thus using Lemma 2.10, $G \cong S \times R(G)$. Hence as $\Delta(G)$ is $K_{n}$-free, $R(G)$ is abelian and we are done.

Lemma 3.6. If either $u=2$ and $\left|\pi\left(u^{\alpha}+1\right)\right| \neq\left|\pi\left(u^{\alpha}-1\right)\right|$, or $u$ is odd, then $G$ does not exist.

Proof. By Lemma 2.5, one of the following cases occurs:
Case 1: Either $\left|\pi\left(u^{\alpha} \pm 1\right)\right|=n-2$ and $u$ is odd, or for some $\epsilon \in\{ \pm 1\}$, $\left|\pi\left(u^{\alpha}+\epsilon\right)\right|=n-3$ and $\left|\pi\left(u^{\alpha}-\epsilon\right)\right|=n-2$ : Since $|\rho(G)|=2 n-1,\left|\pi_{F}\right|=3$. Thus by Lemma 3.1 (c), $\Delta(G)\left[\pi_{F}\right]$ is a non-empty graph. Hence as $|\pi(S)|=$ $2 n-4$, using Lemma 3.2, we are done.
Case 2: for some $\epsilon \in\{ \pm 1\},\left|\pi\left(u^{\alpha}-\epsilon\right)\right|=n-1$ and either $\left|\pi\left(u^{\alpha}+\epsilon\right)\right| \leqslant n-2$ and $u=2$, or $\left|\pi\left(u^{\alpha}+\epsilon\right)\right|=n-2$ or $n-1$ and $u$ is odd: Since $|\rho(G)|=2 n-1$, $\pi_{F} \neq \emptyset$. Thus using Lemma 3.1 (d), the induced subgraph of $\Delta(G)$ on $\pi_{F} \cup \pi\left(u^{\alpha}-\epsilon\right)$ contains a copy of $K_{n}$ and it is a contradiction.
