# FREE ROTA-BAXTER FAMILY ALGEBRAS AND FREE (TRI)DENDRIFORM FAMILY ALGEBRAS

#### Abstract

In this paper, we first construct the free Rota-Baxter family algebra generated by some set $X$ in terms of typed angularly $X$-decorated planar rooted trees. As an application, we obtain a new construction of the free Rota-Baxter algebra only in terms of angularly decorated planar rooted trees (not forests), which is quite different from the known construction via angularly decorated planar rooted forests by K. Ebrahimi-Fard and L. Guo. We then embed the free dendriform (resp. tridendriform) family algebra into the free Rota-Baxter family algebra of weight zero (resp. one). Finally, we prove that the free Rota-Baxter family algebra is the universal enveloping algebra of the free (tri)dendriform family algebra.

## 1. Introduction

Algebraic structures may appear in "family versions", where the operations at hand are replaced by a family of operations indexed by some set $\Omega$, in general endowed with a semigroup structure. The first example of this situation appeared in 2007 in a paper by K. Ebrahimi-Fard, J. Gracia-Bondia and F. Patras [9, Proposition 9.1] (see also [16, Theorem 3.7.2]) about algebraic aspects of renormalization in Quantum Field Theory, where a "Rota-Baxter family" appears: this terminology was suggested to the authors by Li Guo (see Footnote following Proposition 9.2 therein), who further duscussed the underlying structure under the name Rota-Baxter Family algebra in [14]. Various other kinds of family algebraic structures have been recently defined [11, 20, 21, 22].

[^0]Definition 1.1. Let $\Omega$ be a semigroup, let $\mathbf{k}$ be a unital commutative ring and let $\lambda \in \mathbf{k}$ be given. A Rota-Baxter family of weight $\lambda$ on a $\mathbf{k}$-algebra $R$ is a collection of linear operators $\left(P_{\omega}\right)_{\omega \in \Omega}$ on $R$ such that

$$
\begin{equation*}
P_{\alpha}(a) P_{\beta}(b)=P_{\alpha \beta}\left(P_{\alpha}(a) b+a P_{\beta}(b)+\lambda a b\right), \text { for } a, b \in R \text { and } \alpha, \beta \in \Omega . \tag{1}
\end{equation*}
$$

The pair $\left(R,\left(P_{\omega}\right)_{\omega \in \Omega}\right)$ is called a Rota-Baxter family algebra of weight $\lambda$. The example considered in $[9,14,16]$ is the algebra of Laurent series $\left.R=\mathbf{k}\left[z^{-1}, z\right]\right]$. It is a Rota-Baxter family algebra of weight -1 , with $\Omega=(\mathbb{Z},+)$, where the operator $P_{\omega}$ is the projection onto the subspace $R_{<\omega}$ generated by $\left\{z^{k}, k<\omega\right\}$ parallel to the supplementary subspace $R_{\geq \omega}$ generated by $\left\{z^{k}, k \geq \omega\right\}$.

Rota-Baxter algebras (in the ordinary sense) are Rota-Baxter family algebras indexed by the trivial semigroup reduced to one element. They find their origin in the work of the American mathematician Glen E. Baxter [2] in the realm of probability theory. The free Rota-Baxter algebras were constructed in [12, 15], as well as in [7] and [13]. The authors in [20] constructed free commutative Rota-Baxter family algebras and free noncommutative Rota-Baxter family algebras via the method of Gröbner-Shirshov bases.

In this paper, we use planar rooted trees, both angularly decorated by the set $X$ of generators and typed by the semigroup $\Omega$ (see Definition 2.2 below), to provide an alternative realization of free Rota-Baxter family algebras (Theorem 2.10). The model we propose here is inspired by our recent description of free dendriform and tridendriform family algebras [20, 21], which we now briefly outline: J.-L. Loday proposed the concept of dendriform algebra [19] with motivation from algebraic K-theory. J.-L. Loday and M. Ronco later introduced the concept of a tridendriform algebra [17] in the study of polytopes and Koszul duality. Dendriform and tridendriform family algebras (see Definitions 3.1 and 3.6 below) were introduced in [20]. Free tridendriform family algebra were constructed in [21] in terms of typed angularly decorated Schröder trees, also known as planar reduced trees. They are exactly the same trees as above, except that each vertex has at least two incoming edges. Free dendriform family algebras were similarly constructed in terms of typed decorated planar binary trees.

It is well known that a Rota-Baxter algebra of weight zero (resp. weight $\lambda \neq 0$ ) possesses a dendriform (resp. tridendriform) algebra structure [1, 6]. This also holds for the family versions [20]. Universal enveloping Rota-Baxter algebras of (tri)dendriform algebras have been studied in [8]. Whenever $\mathbf{k}$ is a field, we prove, using the natural inclusion of binary trees and Schröder trees into planar rooted trees, that the free Rota-Baxter family algebra of weight $\lambda=0$ (resp. $\lambda \neq 0$ ) generated by a set $X$ is the universal enveloping algebra of the free dendriform (resp. tridendriform) family algebra generated by $X$ (Theorem 3.13 and Theorem 3.14).

The paper is organized as follows: In Section 2, we first define a multiplication on the linear span of the set $\mathcal{T}(X, \Omega)$ of typed angularly decorated planar rooted trees. Second, we introduce the set $\mathfrak{X}_{\infty}$ of Rota-Baxter family words, and contruct a bijection $\psi$ from $\mathfrak{X}_{\infty}$ onto $\mathcal{T}(X, \Omega)$ (Proposition 2.8). Finally, using the bijection $\psi$ and the results of [20], we prove that the linear span $\mathbf{k} \mathcal{T}(X, \Omega)$ is the free Rota-Baxter family algebra generated by $X$ (Theorem 2.10). In Section 3, we show that the natural inclusion of typed decorated planar binary trees into typed angularly decorated planar rooted trees makes the free dendriform family algebra on $X$ a canonical dendriform family subalgebra of the free Rota-Baxter family algebra $\mathbf{k} \mathcal{T}(X, \Omega)$ of weight 0 (Theorem 3.5).

Similarly, the natural inclusion of typed decorated Schröder trees makes the free tridendriform family algebra on $X$ a canonical tridendriform family subalgebra of the free Rota-Baxter family algebra $\mathbf{k} \mathcal{T}(X, \Omega)$ of weight 1 (Theorem 3.10). At the same time, we prove that the free RotaBaxter family algebra of weight zero (resp. one) is the universal enveloping algebra of the free dendriform (resp. tridendriform) family algebra Theorem 3.13 (resp. Theorem 3.14). Whenever $\mathbf{k}$ is a field, the results outlined above for weight one are also valid for weight $\lambda$ modulo multiplicating the embedding map by $\lambda^{-1}$.

Notation. Throughout this paper, let $\mathbf{k}$ be a unitary commutative ring which will be the base ring of all modules, algebras, as well as linear maps, unless otherwise specified. Algebras are unitary associative algebras but not necessary commutative. Let RBFAs, DFAs and TFAs be short for Rota-Baxter family algebras, dendriform family algebras and tridendriform family algebras, respectively.

## 2. Free Rota-Baxter family algebras

In this section, we construct free Rota-Baxter family algebras in terms of typed angularly decorated planar rooted trees.
2.1. Typed angularly decorated planar rooted trees. Typed decorated rooted trees $[4,10]$ are rooted trees with vertex decoration and edge decoration. For a rooted tree $T$, denote by $V(T)$ (resp. $E(T)$ ) the set of its vertices (resp. edges). In this subsection, we introduce typed angularly decorated planar rooted trees.

Definition 2.1. [4] Let $X$ and $\Omega$ be two sets. An $X$-decorated $\Omega$-typed (abbreviated typed decorated) rooted tree is a triple $T=(T$, dec, type $)$, where
(a) $T$ is a rooted tree.
(b) dec : $V(T) \rightarrow X$ is a map.
(c) type : $E(T) \rightarrow \Omega$ is a map.

In [21], typed decorated planar binary trees were used to construct free dendriform family algebras. Along these lines, in the present paper, we use typed decorated planar rooted trees to construct free Rota-Baxter family algebras which have close relationship with free dendriform family algebras. So we adopt the graphical representation of planar rooted trees as the one of planar binary trees in [21], which is slightly different from the graphical representation of rooted trees used in $[4,10]$ : the root and the leaves are now edges rather than vertices. See examples below. So the set $E(T)$ must be replaced by the set $I E(T)$ of internal edges, i.e. edges which are neither leaves nor the root. However, a planar rooted tree has at least one vertex. Each vertex $v$ yields a (possibly empty) set of angles $A(v)$, an angle being a pair ( $e, e^{\prime}$ ) of adjacent incoming edges for $v$. Let $A(T)=\bigsqcup_{v \in V(T)} A(v)$ be the set of angles of the planar rooted tree $T$. We propose the following concept:

Definition 2.2. Let $X$ and $\Omega$ be two sets. An $X$-angularly decorated $\Omega$-typed (abbreviated typed angularly decorated) planar rooted tree is a triple $T=(T$, dec, type), where
(a) $T$ is a planar rooted tree.
(b) dec : $A(T) \rightarrow X$ is a map.
(c) type : $\operatorname{IE}(T) \rightarrow \Omega$ is a map.

If a semigroup $\Omega$ has no identity element, we consider the monoid $\Omega^{1}:=\Omega \sqcup\{1\}$ obtained from $\Omega$ by adjoining an identity:

$$
1 \omega:=\omega 1:=\omega, \text { for } \omega \in \Omega \text { and } 11:=1
$$

For $n \geq 0$, let $\mathcal{T}_{n}(X, \Omega)$ denote the set of $X$-angularly decorated $\Omega^{1}$-typed planar rooted trees with $n+1$ leaves such that leaves are decorated by the identity 1 in $\Omega^{1}$ and internal edges are decorated by elements of $\Omega$. Note that the root is not decorated. Denote by

$$
\mathcal{T}(X, \Omega):=\bigsqcup_{n \geq 0} \mathcal{T}_{n}(X, \Omega) \text { and } \mathbf{k} \mathcal{T}(X, \Omega):=\bigoplus_{n \geq 0} \mathbf{k} \mathcal{T}_{n}(X, \Omega) .
$$

Here are some examples in $\mathcal{T}(X, \Omega)$.

Graphically, an element $T \in \mathcal{T}(X, \Omega)$ is of the form:
i.e., $\alpha_{j} \in \Omega$ if $T_{j} \neq \mid ; \alpha_{j}=1$ if $T_{j}=\mid$. For each $\omega \in \Omega$, define a linear operator

$$
B_{\omega}^{+}: \mathbf{k} \mathcal{T}(X, \Omega) \rightarrow \mathbf{k} \mathcal{T}(X, \Omega),
$$

where $B_{\omega}^{+}(T)$ is the typed angularly decorated planar rooted tree obtained by adding a new root and an new internal edge decorated by $\omega$ connecting the new root and the root of $T$. For example,

$$
B_{\omega}^{+}(\emptyset)=\left\{_{\omega}, \quad B_{\omega}^{+}\left(Y^{x} /\right)=\omega^{x}, \quad B_{\omega}^{+}\left(\stackrel{\alpha}{y}_{x}^{x} / \beta\right)=\stackrel{\alpha}{\omega}{ }_{\omega}^{x}\right\rangle^{z} \beta .
$$

Remark 2.3. If $\Omega$ is a singleton set, then typed angularly decorated planar rooted trees are reduced to angularly decorated planar rooted trees studied by Guo [14], who used them to obtain angularly decorated planar rooted forests and to construct free Rota-Baxter algebras.

The depth $\operatorname{dep}(T)$ of a rooted tree $T$ is the maximal length of linear chains from the root to the leaves of the tree. For example,

$$
\operatorname{dep}(\downarrow)=\operatorname{dep}\left(\curlyvee^{x}\right)=1 \text { and } \operatorname{dep}(\stackrel{x \mid y}{\alpha},)=2 .
$$

For later use, we add the "zero-vertex tree" $\mid$ to the picture, and set $\operatorname{dep}(\mid)=0$. Note that the operators $B_{\omega}^{+}$are not defined on $\mid$.

Remark 2.4. For any $T \in \mathcal{T}(X, \Omega) \sqcup\{\mid\}$, if $\operatorname{dep}(T)=0$, then $T=\mid$. Define the number of branches $\operatorname{bra}(T)$ of $T$ to be 0 in this case. Otherwise, $\operatorname{dep}(T) \geq 1$ and $T$ is of the form

$$
T=T_{1} Q_{\alpha_{1}}^{\stackrel{T_{2}}{\mathrm{Q}_{1}} \underbrace{\alpha_{2}}_{\alpha_{2}} \cdots \alpha_{x_{n}}^{\alpha_{n}} \overbrace{\alpha_{n+1}}^{T_{n}}} \mathrm{O} T_{n+1} \text { with } n \geq 0
$$

Here any branch $T_{j} \in \mathcal{T}(X, \Omega) \sqcup\{\mid\}, j=1, \ldots, n+1$ is of depth at most one less than the depth of $T$, and equal to zero if and only if $T_{j}=\mid$. We define $\operatorname{bra}(T):=n+1$. For example,

$$
\operatorname{bra}\left(\emptyset^{\dagger} \omega\right)=1, \operatorname{bra}\left(Y^{x}\right)=2 \text { and } \operatorname{bra}\left(\Psi^{x \mid y}\right)=3 .
$$

2.2. A multiplication on $\mathbf{k} \mathcal{T}(X, \Omega)$. This subsection is devoted to define a unital multiplication $\diamond$ on $\mathbf{k} \mathcal{T}(X, \Omega)$, which is the crucial ingredient to construct a free Rota-Baxter family algebra.

Let $X$ be a set and let $\Omega$ be a semigroup. Let $T, T^{\prime} \in \mathcal{T}(X, \Omega)$. We define $T \diamond T^{\prime}$ by induction on $\operatorname{dep}(T)+\operatorname{dep}\left(T^{\prime}\right) \geq 2$. For the initial step $\operatorname{dep}(T)+\operatorname{dep}\left(T^{\prime}\right)=2$, we have $\operatorname{dep}(T)=\operatorname{dep}\left(T^{\prime}\right)=1$ and $T, T^{\prime}$ are of the form

$$
T=\underbrace{x_{1} \cdots x_{m}} \text { and } T^{\prime}=\underbrace{y_{1} \cdots \frac{y_{n}}{}} \text {, with } m, n \geq 0 \text {. }
$$

Define


For the induction step $\operatorname{dep}(T)+\operatorname{dep}\left(T^{\prime}\right) \geq 3$, the trees $T$ and $T^{\prime}$ are of the form

There are four cases to consider.
Case 1: $T_{m+1}=\mid=T_{1}^{\prime}$. Define
(3)


Case 2: $T_{m+1} \neq \mid=T_{1}^{\prime}$. Define
(4)


Case 3: $T_{m+1}=\mid \neq T_{1}^{\prime}$. Define


Case 4: $T_{m+1} \neq \mid \neq T_{1}^{\prime}$. Define

(6)


Here the first $\diamond$ is defined by Case 3 , the second, third and fourth $\diamond$ are defined by induction and the last $\diamond$ is defined by Case 2 . This completes the inductive definition of the multiplication $\diamond$ on $\mathcal{T}(X, \Omega)$. Extending by linearity, we can expand the $\diamond$ to $\mathbf{k} \mathcal{T}(X, \Omega)$. Let us expose an example for better understanding.
Example 2.5. Let $X$ be a set and let $\Omega$ be a semigroup. For $x, y \in X$ and $\alpha, \beta \in \Omega$, we have

$$
\begin{aligned}
& Y^{x} \stackrel{y}{y}=y^{x \mid y} \text { (by Eq. (2)), }
\end{aligned}
$$

$$
\begin{aligned}
& { }_{9}^{\alpha} \diamond \beta_{q}^{y}=B_{\alpha}^{+}\left(Y^{x}\right) \diamond B_{\beta}^{+}\left(Y^{y}\right)
\end{aligned}
$$


(by Eq. (6))


(by Eqs. (4), (5) and (2))


Remark 2.6. The unit for the product $\diamond$ is given by the tree $\oint$.
2.3. Construction of free RBFA. In this subsection, we prove that $\mathbf{k} \mathcal{T}(X, \Omega)$ is the free RotaBaxter family algebra of weight $\lambda$ generated by $X$, via a bijection between $\mathcal{T}(X, \Omega)$ and the set of Rota-Baxter family bracketed words. The latter is a subset of bracketed words [3, 14] and is used to construct free Rota-Baxter family algebras [20].

Denote by $M(X)$ the free monoid generated by $X$. Let $\Omega$ be a set. For any set $Y$ and $\omega \in \Omega$, let $\lfloor Y\rfloor_{\omega}$ denote the set $\left\{\lfloor y\rfloor_{\omega} \mid y \in Y\right\}$. So $\lfloor Y\rfloor_{\omega}$ is a disjoint copy of $Y$. Assume the sets $\lfloor Y\rfloor_{\omega}$ to be disjoint with each other when $\omega$ varies in $\Omega$. We use induction to define a direct system $\left\{\mathfrak{M}_{n}:=\mathfrak{M}_{\mathfrak{n}}(\Omega, X), i_{n, n+1}: \mathfrak{M}_{\mathfrak{n}} \rightarrow \mathfrak{M}_{n+1}\right\}_{n \geq 1}$ of free monoids. First, define

$$
\mathfrak{M}_{1}:=M(X) \text { and } \mathfrak{M}_{2}:=M\left(X \sqcup\left(\sqcup_{\omega \in \Omega}\left\lfloor\mathfrak{M}_{1}\right\rfloor_{\omega}\right)\right),
$$

with $i_{1,2}$ being the inclusion

$$
i_{1,2}: \mathfrak{M}_{1}=M(X) \hookrightarrow \mathfrak{M}_{2}=M\left(X \sqcup\left(\sqcup_{\omega \in \Omega}\left\lfloor\mathfrak{M}_{1}\right\rfloor\right)\right) .
$$

Inductively assume that $\mathfrak{M}_{n-1}$ has been defined for $n \geq 3$, with the inclusion

$$
\begin{equation*}
i_{n-2, n-1}: \mathfrak{M}_{n-2} \rightarrow \mathfrak{M}_{n-1} \tag{7}
\end{equation*}
$$

Then, define

$$
\mathfrak{M}_{n}:=M\left(X \sqcup\left(\sqcup_{\omega \in \Omega}\left\lfloor\mathfrak{M}_{n-1}\right\rfloor_{\omega}\right)\right) .
$$

The inclusion in Eq. (7) induces the inclusion

$$
\left\lfloor\mathfrak{M}_{n-2}\right\rfloor_{\omega} \rightarrow\left\lfloor\mathfrak{M}_{n-1}\right\rfloor_{\omega}, \text { for each } \omega \in \Omega,
$$

and generates an inclusion of free monoids

$$
i_{n-1, n}: \mathfrak{M}_{n-1}=M\left(X \sqcup\left(\sqcup_{\omega \in \Omega}\left\lfloor\mathfrak{M}_{n-2}\right\rfloor_{\omega}\right)\right) \hookrightarrow M\left(X \sqcup\left(\sqcup_{\omega \in \Omega}\left\lfloor\mathfrak{M}_{n-1}\right\rfloor_{\omega}\right)\right)=\mathfrak{M}_{n}
$$

This completes the inductive construction of the direct systems. Finally, define the direct limit of monoids

$$
\mathfrak{M}(\Omega, X):=\underset{\rightarrow}{\lim } \mathfrak{M}_{n}=\bigcup_{n \geq 0} \mathfrak{M}_{n}
$$

with identity 1 . An element in $\mathfrak{M}(\Omega, X)$ is called a bracketed word and is said to be of depth $n$ if it is in $\mathfrak{M}_{n} \backslash \mathfrak{M}_{n-1}$. For each $u \in \mathfrak{M}(\Omega, X)$ with $u \neq 1$, we may write $u$ as a product $u_{1} \cdots u_{k}$
uniquely for some $k$ with $u_{i} \in X \sqcup\left(\sqcup_{\omega \in \Omega}\lfloor\mathfrak{M}(\Omega, X)\rfloor_{\omega}\right)$ for $1 \leq i \leq k$. We call $k$ the breadth of $u$ and denote it by $|u|$. If $u=1$, we define $|u|:=0$. For each $\omega \in \Omega$, we introduce the linear operator

$$
P_{\omega}: \mathfrak{M}(\Omega, X) \rightarrow \mathfrak{M}(\Omega, X), \quad u \mapsto\lfloor u\rfloor_{\omega} .
$$

Let $Y, Z$ be the subsets of $\mathfrak{M}(\Omega, X)$. First define the alternating products of $Y$ and $Z$ by

$$
\begin{aligned}
\Lambda(Y, Z):= & \left(\bigcup_{\substack{r \geq 1, \omega \in \Omega}}\left(Y \sqcup_{\omega \in \Omega}\lfloor Z\rfloor_{\omega}\right)^{r}\right) \bigcup\left(\bigcup_{\substack{r \geq 0, \omega \in \Omega}}\left(Y \sqcup_{\omega \in \Omega}\lfloor Z\rfloor_{\omega}\right)^{r} Y\right) \bigcup\left(\bigcup_{\substack{r \geq 1, \omega \in \Omega}}\left(\sqcup_{\omega \in \Omega}\lfloor Z\rfloor_{\omega} Y\right)^{r}\right) \\
& \bigcup\left(\bigcup_{\substack{r \geq 0, \omega \in \Omega}}\left(\sqcup_{\omega \in \Omega}\lfloor Z\rfloor_{\omega} Y\right)^{r} \sqcup_{\omega \in \Omega}\lfloor Z\rfloor_{\omega}\right) \bigcup\{1\}
\end{aligned}
$$

where 1 is the identity in $\mathfrak{M}(\Omega, X)$. Obviously, $\Lambda(Y, Z) \subseteq \mathfrak{M}(\Omega, X)$. Then define recursively

$$
\mathfrak{X}_{0}:=M(X) \text { and } \mathfrak{X}_{n}:=\Lambda\left(M(X), \mathfrak{X}_{n-1}\right), n \geq 1 .
$$

Thus $\mathfrak{X}_{0} \subseteq \cdots \subseteq \mathfrak{X}_{n} \subseteq \cdots$ and we may define

$$
\mathfrak{X}_{\infty}:=\underset{\rightarrow}{\lim \mathfrak{X}_{n}=\cup_{n \geq 0} \mathfrak{X}_{n} .}
$$

Elements in $\mathfrak{X}_{\infty}$ are called Rota-Baxter family bracketed words. Denote by $S$ the following vector subspace of $\mathbf{k} \mathfrak{M}(\Omega, X)$ :

$$
S:=\left\{\lfloor x\rfloor_{\alpha}\lfloor y\rfloor_{\beta}-\left\lfloor\lfloor x\rfloor_{\alpha} y\right\rfloor_{\alpha \beta}-\left\lfloor x\lfloor y\rfloor_{\beta}\right\rfloor_{\alpha \beta}-\lambda\lfloor x y\rfloor_{\alpha \beta} \mid \alpha, \beta \in \Omega, x, y \in \mathfrak{M}(\Omega, X)\right\} .
$$

Lemma 2.7. [20] Let $X$ be a set and let $\Omega$ be a semigroup.
(a) $S$ is a Gröbner-Shirshov basis in $\mathbf{k M}(\Omega, X)$ with respect to a monomial order.
(b) The set $\mathfrak{X}_{\infty}$ is a $\mathbf{k}$-basis of the free Rota-Baxter family algebra $\left(\mathbf{k} \mathfrak{X}_{\infty}, \diamond_{w},\left(\mathrm{~L} J_{\omega}\right)_{\omega \in \Omega}\right)=$ $\mathbf{k} \mathfrak{M}(\Omega, X) / \operatorname{Id}(S)$ of weight $\lambda$, where $\operatorname{Id}(S)$ is the operated ideal generated by $S$ in $\mathbf{k} \mathfrak{M}(\Omega, X)$.

We are going to erect a one-one correspondence between $\mathbf{k} \mathcal{T}(X, \Omega)$ and $\mathbf{k} \mathfrak{X}_{\infty}$. Let us first expose some examples in the following table:

The following result shows that the linear map $\phi$ is compatible with respect to the multiplications $\diamond$ and $\diamond_{w}$, where $\diamond_{w}$ is the associative multiplication on the free Rota-Baxter family algebra given in Lemma 2.7.

Theorem 2.10. Let $X$ be a set and let $\Omega$ be a semigroup. The triple $\left(\mathbf{k} \mathcal{T}(X, \Omega), \diamond,\left(B_{\omega}^{+}\right)_{\omega \in \Omega}\right)$, together with the $j_{X}$, is the free Rota-Baxter family algebra of weight $\lambda$ on $X$.

Proof. We divide the proof into two steps.
Step 1: We prove that $\left(\mathbf{k} \mathcal{T}(X, \Omega), \diamond,\left(B_{\omega}^{+}\right)_{\omega \in \Omega}\right)$ is a Rota-Baxter family algebra. First, for $T_{1}, T_{2}, T_{3} \in \mathcal{T}(X, \Omega)$, we have

$$

& =\phi\left(T_{1} \diamond\left(T_{2} \diamond T_{3}\right)\right) \quad(\text { by Lemma 2.9 }) .

= & \left\lfloor\phi(T) \diamond_{w}\left\lfloor\phi\left(T^{\prime}\right)\right\rfloor_{\beta}+\lfloor\phi(T)\rfloor_{\alpha} \diamond_{w} \phi\left(T^{\prime}\right)+\lambda \phi(T) \diamond_{w} \phi\left(T^{\prime}\right)\right\rfloor_{\alpha \beta} \\
& \quad \quad \text { by Lemma } 2.7(\text { b) }) \\
= & \phi\left(B_{\alpha \beta}^{+}\left(T \diamond B_{\beta}^{+}\left(T^{\prime}\right)+B_{\alpha}^{+}(T) \diamond T^{\prime}+\lambda T \diamond T^{\prime}\right)\right) \quad \text { (by Eq. (9) and Lemma 2.9). }
\end{aligned}
$$

Again by $\psi \circ \phi=\mathrm{id}$, we have

B_{\alpha}^{+}(T) \diamond B_{\beta}^{+}\left(T^{\prime}\right)=B_{\alpha \beta}^{+}\left(T \diamond B_{\beta}^{+}\left(T^{\prime}\right)+B_{\alpha}^{+}(T) \diamond T^{\prime}+\lambda T \diamond T^{\prime}\right),
$$

whence $\left(B_{\omega}^{+}\right)_{\omega \in \Omega}$ is a Rota-Baxter family on $(\mathbf{k} \mathcal{T}(X, \Omega), \diamond)$.
Step 2: We prove the freeness of $\left(\mathbf{k} \mathcal{T}(X, \Omega), \diamond,\left(B_{\omega}^{+}\right)_{\omega \in \Omega}\right)$. By Proposition $2.8, \phi: \mathbf{k} \mathcal{T}(X, \Omega) \rightarrow$ $\mathbf{k} \mathfrak{X}_{\infty}$ is a linear isomorphism. Further, by Eq. (9) and Lemma 2.9, $\phi$ is a Rota-Baxter family isomorphism. Finally, since $\left.\left(\mathbf{k} \mathfrak{X}_{\infty}, \diamond_{w},(L\rfloor_{\omega}\right)_{\omega \in \Omega}\right)$ is a free Rota-Baxter family algebra on $X$ by Lemma 2.7 (b), the result holds.

If $\Omega$ is a trivial semigroup, all typed angularly decorated planar rooted trees in $\mathcal{T}(X, \Omega)$ have the same edge decorations, and so $\mathcal{T}(X, \Omega)$ reduces to angularly decorated planar rooted trees $\mathcal{T}(X)$ without edge decorations. Meanwhile, the unique $B_{\omega}^{+}$with $\omega \in \Omega$ reduces to the grafting operation $B^{+}$applied in the Connes-Kreimer Hopf algebra [5]. As a consequence, we obtain a new construction of free Rota-Baxter algebra in terms of $\mathcal{T}(X)$.
Corollary 2.11. Let $X$ be a set and let $\Omega$ be a trivial semigroup. Then the triple $\left(\mathbf{k} \mathcal{T}(X), \diamond, B^{+}\right)$, together with the $j_{X}$, is the free Rota-Baxter algebra of weight $\lambda$ on $X$.
Proof. If $\Omega$ is a trivial semigroup, Eq. (1) is precisely the Rota-Baxter equation. So the result follows directly from Theorem 2.10.

## 3. Embedding free DFAs (resp. TFAs) into free RBFAs

In this section, we show that the free dendriform (resp. tridendriform) family algebra on a set $X$ is a canonical dendriform (resp. tridendriform) family subalgebra of the free Rota-Baxter family algebra $\mathbf{k} \mathcal{T}(X, \Omega)$ of weight zero (resp. one).
3.1. Embedding free DFAs into free RBFAs. The concept of a dendriform family algebra was proposed in [20], as a generalization of a dendriform algebra invented by Loday [19] in the study of algebraic $K$-theory.
Definition 3.1. [20] Let $\Omega$ be a semigroup. A dendriform family algebra is a k-module $D$ with a family of binary operations $\left(\left\langle_{\omega},\right\rangle_{\omega}\right)_{\omega \in \Omega}$ such that for $x, y, z \in D$ and $\alpha, \beta \in \Omega$,

$$
\begin{aligned}
\left(x<_{\alpha} y\right) \prec_{\beta} z & =x \prec_{\alpha \beta}\left(y<_{\beta} z+y \succ_{\alpha} z\right), \\
\left(x \succ_{\alpha} y\right)<_{\beta} z & =x \succ_{\alpha}\left(y<_{\beta} z\right), \\
\left(x<_{\beta} y+x>_{\alpha} y\right) \succ_{\alpha \beta} z & =x \succ_{\alpha}\left(y>_{\beta} z\right) .
\end{aligned}
$$

Let $X$ be a set and let $\Omega$ be a semigroup. For $n \geq 1$, let

$$
\left.Y_{n}:=Y_{n, X, \Omega}:=\mathcal{T}_{n}(X, \Omega) \cap \text { \{planar binary trees }\right\}
$$

that is, $Y_{n}$ is the set of $X$-angularly decorated $\Omega^{1}$-typed planar binary trees with $n+1$ leaves, such that leaves are decorated by the identity 1 in $\Omega^{1}$ and internal edges are decorated by elements of $\Omega$. Here are some examples for better understanding. For convenience, we omit the decoration 1 in the sequel.

For $T \in Y_{m}, U \in Y_{n}, x \in X$ and $\alpha, \beta \in \Omega^{1}$, the grafting $\vee_{x,(\alpha, \beta)}$ of $T$ and $U$ over $x$ and $(\alpha, \beta)$ is defined to be $T \vee_{x,(\alpha, \beta)} U \in Y_{m+n+1}$, obtained by adding a new vertex decorated by $x$ and joining the roots of $T$ and $U$ with the new vertex via two new edges decorated by $\alpha$ and $\beta$ respectively.

Conversely, for $T \in Y_{n}$ not equal to |, there is a unique decomposition

T=T^{l} \vee_{x,(\alpha, \beta)} T^{r} \text { for some } x \in X \text { and } \alpha, \beta \in \Omega^{1}
$$

Denote by

\mathrm{DD}(X, \Omega):=\bigoplus_{n \geq 1} \mathbf{k} Y_{n}
$$

Definition 3.2. Let $X$ be a set and let $\Omega$ be a semigroup. Slightly extending [21, Paragraph 3.1], we define binary operations
$\left.<_{\omega},\right\rangle_{\omega}:(\mathrm{DD}(X, \Omega) \otimes \mathrm{DD}(X, \Omega)) \oplus(\mathbf{k} \mid \otimes \mathrm{DD}(X, \Omega)) \oplus(\mathrm{DD}(X, \Omega) \otimes \mathbf{k} \mid) \rightarrow \mathrm{DD}(X, \Omega)$ for $\omega \in \Omega$ recursively on $\operatorname{dep}(T)+\operatorname{dep}(U)$ by
(a) $\left|>_{\omega} T:=T<_{\omega}\right|:=T$ and $\left|<_{\omega} T:=T>_{\omega}\right|:=0$ for $\omega \in \Omega$ and $T \in Y_{n}$ with $n \geq 1$.
(b) For $T=T^{l} \vee_{x,\left(\alpha_{1}, \alpha_{2}\right)} T^{r}$ and $U=U^{l} \vee_{y,\left(\beta_{1}, \beta_{2}\right)} U^{r}$, define

$$
\begin{align*}
& T \prec_{\omega} U:=T^{l} \vee_{x,\left(\alpha_{1}, \alpha_{2} \omega\right)}\left(T^{r} \prec_{\omega} U+T^{r}>_{\alpha_{2}} U\right),  \tag{16}\\
& T \succ_{\omega} U:=\left(T<_{\beta_{1}} U^{l}+T \succ_{\omega} U^{l}\right) \vee_{y,\left(\omega \beta_{1}, \beta_{2}\right)} U^{r}, \text { where } \omega \in \Omega . \tag{17}
\end{align*}

Note that $\left|<_{\omega}\right|$ and $\left\rangle_{\omega}\right|$ are not defined for $\omega \in \Omega^{1}$. Here we apply the convention

Let $j: X \rightarrow \mathrm{DD}(X, \Omega)$ be the map defined by $j(x)=\Varangle^{x}$ for $x \in X$.
Theorem 3.3. [21] Let $X$ be a set and let $\Omega$ be a semigroup. Then $\left(\operatorname{DD}(X, \Omega),\left(\left\langle_{\omega},\right\rangle_{\omega}\right)_{\omega \in \Omega}\right)$, together with the map $j$, is the free dendriform family algebra on $X$.

It is well-known that a Rota-Baxter algebra of weight 0 induces a dendriform algebra [1, 6]. Similarly, we have the following fact.
Lemma 3.4. [20] Let $X$ be a set and let $\Omega$ be a semigroup. The Rota-Baxter family algebra $\left(\mathbf{k} \mathcal{T}(X, \Omega), \diamond,\left(B_{\omega}^{+}\right)_{\omega \in \Omega}\right)$ of weight 0 induces a dendriform family algebra $\left(\mathbf{k} \mathcal{T}(X, \Omega),\left(\left\langle_{\omega}^{\prime},\right\rangle_{\omega}^{\prime}\right)_{\omega \in \Omega}\right)$, where

T \prec_{\omega}^{\prime} U:=T \diamond B_{\omega}^{+}(U) \text { and } T \succ_{\omega}^{\prime} U:=B_{\omega}^{+}(T) \diamond U, \text { for } T, U \in \mathcal{T}(X, \Omega) . \tag{19}
\end{equation*}
$$

Now we arrive at our main result.
Theorem 3.5. Let $X$ be a set and let $\Omega$ be a semigroup. The free dendriform family algebra $\left.\left(\mathrm{DD}(X, \Omega),\left(<_{\omega},\right\rangle_{\omega}\right)_{\omega \in \Omega}\right)$ on $X$ is a dendriform family subalgebra of the free Rota-Baxter family algebra $\left(\mathbf{k} \mathcal{T}(X, \Omega), \diamond,\left(B_{\omega}^{+}\right)_{\omega \in \Omega}\right)$ of weight 0 .
Proof. By Lemma 3.4, a Rota-Baxter family algebra $\left(\mathbf{k} \mathcal{T}(X, \Omega), \diamond,\left(B_{\omega}^{+}\right)_{\omega \in \Omega}\right)$ of weight 0 induces a dendriform family algebra $\left(\mathbf{k} \mathcal{T}(X, \Omega),\left(\left\langle_{\omega}^{\prime},\right\rangle_{\omega}^{\prime}\right)_{\omega \in \Omega}\right)$. 3.2. Embedding free TFAs into free RBFAs. The concept of a tridendriform family algebra was introduced in [20], which is a generalization of a tridendriform algebra invented by Loday and Ronco [18] in the study of polytopes and Koszul duality.

Definition 3.6. [20] Let $\Omega$ be a semigroup. A tridendriform family algebra is a k-module $T$ equipped with a family of binary operations $\left.\left(<_{\omega},\right\rangle_{\omega}\right)_{\omega \in \Omega}$ and a binary operation $\cdot$ such that for $x, y, z \in T$ and $\alpha, \beta \in \Omega$,

By Lemma 3.9, a Rota-Baxter family algebra $\left(\mathbf{k} \mathcal{T}(X, \Omega), \diamond,\left(B_{\omega}^{+}\right)_{\omega \in \Omega}\right)$ of weight 1 induces a tridendriform family algebra $\left.\left(\mathbf{k} \mathcal{T}(X, \Omega),\left(<_{\omega}^{\prime},\right\rangle_{\omega}^{\prime}\right)_{\omega \in \Omega},{ }^{\prime}\right)$. Remark 3.11. In the rest of this paper, let $\mathbf{k}$ be a field. Theorem 3.10 is also true for any weight $\lambda \neq 0$, at the price of replacing the canonical inclusion $j$ by $\lambda^{-1} j$. A similar (and simpler) proof yields an analogon in weight zero case, namely that the free dendriform family algebra $\left(\mathrm{DD}(X, \Omega),\left(\left\langle_{\omega},\right\rangle_{\omega}\right)_{\omega \in \Omega}\right)$ on $X$ is a dendriform family subalgebra of the free Rota-Baxter family algebra of weight zero. The image of $\operatorname{DD}(X, \Omega)$ in $\mathbf{k} \mathcal{T}(X, \Omega)$ is included in the linear span $\left(\mathbf{k} \mathcal{T}_{b}(X, \Omega), \diamond,\left(B_{\omega}^{+}\right)_{\omega \in \Omega}\right)$ of typed decorated rooted trees in which any vertex has exactly one or two incoming edges. Details are left to the reader.
3.3. Universal enveloping algebras of (tri)dendriform family algebras. In this subsection, we mainly prove that the free Rota-Baxter family algebra $\left(\mathbf{k T}(X, \Omega), \diamond,\left(B_{\omega}^{+}\right)_{\omega \in \Omega}\right)$ is the universal enveloping algebra of the free dendriform (resp. tridendriform) family algebra $\operatorname{DD}(X, \Omega)$ (resp. $\mathrm{DT}(X, \Omega)$ ).

Definition 3.12. Let $D$ be a dendriform (resp. tridendriform) family algebra. A universal enveloping Rota-Baxter family algebra of weight $\lambda$ of $D$ is a Rota-Baxter family algebra $\operatorname{RBF}(D):=$ $\mathrm{RBF}_{\lambda}(D)$, together with a dendriform (resp. tridendriform) family algebra morphism $j: D \rightarrow$ $\operatorname{RBF}(D)$ such that for any weight $\lambda$ Rota-Baxter family algebra $A$ and dendriform (resp. tridendriform) family algebra morphism $f: D \rightarrow A$, there is a unique Rota-Baxter family algebra morphism $\bar{f}: \operatorname{RBF}(D) \rightarrow A$ such that $\bar{f} \circ j=f$.

From Theorem 3.5, we know that the free dendriform family algebra $\mathrm{DD}(X, \Omega)$ is a dendriform family subalgebra of $\mathbf{k} \mathcal{T}(X, \Omega)$. Let $j: \mathrm{DD}(X, \Omega) \rightarrow \mathbf{k} \mathcal{T}(X, \Omega)$ be the natural embedding map.

Theorem 3.13. Let $X$ be a set and let $\Omega$ be a semigroup. Then $\mathbf{k} \mathcal{T}(X, \Omega)$, together with the canonical inclusion map $j$, is the universal enveloping weight zero Rota-Baxter family algebra of the free dendriform family algebra $\operatorname{DD}(X, \Omega)$.

Proof. From Lemma 3.4, a Rota-Baxter family algebra of weight 0 induces a dendriform family algebra. Let $\left(A,\left(Q_{\omega}\right)_{\omega}\right)$ be any Rota-Baxter family algebra of weight 0 and let $g: \operatorname{DD}(X, \Omega) \rightarrow$ $A$ be a dendriform family algebra morphism. We need to find a Rota-Baxter family algebra morphism $\bar{g}: \mathbf{k} \mathcal{F}(X, \Omega) \rightarrow A$ making the following diagram commute.


From Lemma 3.3 and Theorem 3.5, we know that $\operatorname{DD}(X, \Omega)$ is generated by $\{\underbrace{x} \mid x \in X\}$ and $\mathbf{k T}(X, \Omega)$ is generated by $\operatorname{DD}(X, \Omega)$ under the operations $\left(B_{\omega}^{+}\right)_{\omega \in \Omega}$ and $\diamond$. Hence $\mathbf{k} \mathcal{T}(X, \Omega)$ is generated by $\left\{\mathcal{Y}^{x} \mid x \in X\right\}$ under the operations $\left(B_{\omega}^{+}\right)_{\omega \in \Omega}$ and $\diamond$. By the freeness of $\mathbf{k} \mathcal{T}(X, \Omega)$, there is a unique Rota-Baxter family algebra morphism $\bar{g}: \mathbf{k} \mathcal{T}(X, \Omega) \rightarrow A$, so that $\bar{g}\left(\chi^{x}\right):=$ $g\left(\bigvee^{x /}\right)=a_{x}$. Then $g\left(\zeta^{x}\right)=\bar{g} \circ j\left(Y^{x}\right)$. So $g=\bar{g} \circ j$ and the diagram commutes.

From Theorem 3.10, we know that the free tridendriform family algebra $\mathrm{DT}(X, \Omega)$ is a tridendriform family subalgebra of $\mathbf{k} \mathcal{T}(X, \Omega)$. Let $j: \mathrm{DT}(X, \Omega) \rightarrow \mathbf{k} \mathcal{T}(X, \Omega)$ be the natural embedding map.

Theorem 3.14. Let $X$ be a set and let $\Omega$ be a semigroup. Let $\lambda$ be any nonzero element of the base field $\mathbf{k}$. Then $\mathbf{k} \mathcal{T}(X, \Omega)$, together with $\lambda^{-1} j$, is the universal enveloping weight $\lambda$ Rota-Baxter family algebra of the free tridendriform family algebra $\mathrm{DT}(X, \Omega)$.

Proof. The proof is similar to Theorem 3.13. Details are left to the reader.
