# THE PYRAMIDAL GROWTH 

JOSEPH GUBELADZE


#### Abstract

Can one build an arbitrary polytope from any polytope inside by iteratively stacking pyramids onto facets, without losing the convexity throughout the process? We prove that this is indeed possible for (i) 3-polytopes, (ii) 4polytopes under a certain infinitesimal quasi-pyramidal relaxation, and (iii) all dimensions asymptotically. The motivation partly comes from our study of $K$ theory of monoid rings and of certain posets of discrete-convex objects.


## 1. Main results

A polytope in this paper means the convex hull of a finite subset of $\oplus_{\mathbb{N}} \mathbb{R}$, where we have the usual notion of convexity, Euclidean norm, angle between two finite dimensional affine spaces that meet in codimension one, topological closure etc.

The topological closure of a subset $X \subset \oplus_{\mathbb{N}} \mathbb{R}$ will be denoted by $\bar{X}$.
The Hausdrorff distance between two nonempty compact subsets $X, Y \subset \oplus_{\mathbb{N}} \mathbb{R}$ will be denoted by $\mathrm{d}_{\mathrm{H}}(X, Y)\left[9\right.$, Ch. 1.2]. For a sequence of polytopes $\left\{P_{i}\right\}_{\mathbb{N}}$ and a polytope $Q$, we write $\lim _{i \rightarrow \infty} P_{i}=Q$ if $\lim _{i \rightarrow \infty} \mathrm{~d}_{\mathrm{H}}\left(P_{i}, Q\right)=0$.

The set of polytopes of dimension at most $d$ will be denoted by $\operatorname{Pol}(d)$. The set of all polytopes will be denoted by $\operatorname{Pol}(\infty)$. For a subfield $k \subset \mathbb{R}$, the corresponding sets of polytopes with vertices in $\oplus_{\mathbb{N}} k$ will be denoted by $\operatorname{Pol}_{k}(d)$ and $\operatorname{Pol}_{k}(\infty)$.

Let $P$ be a polytope. A pyramid over or with base $P$ is the convex hull $Q$ of $P$ and a point $v$, not in the affine hull of $P$. The point $v$ is the apex of $Q$.

Let $k \subset \mathbb{R}$ be a subfield, $d \leq \infty$, and $\operatorname{Pol}$ be one of the sets $\operatorname{Pol}(d), \operatorname{Pol}_{k}(d)$.
Definition 1.1. (a) A pair of polytopes $P \subset Q$ in $\mathbf{P o l}$ forms a pyramidal extension if $\Delta=\overline{Q \backslash P}$ is a pyramid and $\Delta \cap P$ is a facet of $\Delta$, i.e., either $Q$ is a pyramid over $P$ or obtained from $P$ by stacking a pyramid onto a facet. For a pyramidal extension $P \subset Q$ we write $P \subset \subset_{\Delta} Q$.
(b) The partial order on Pol, generated by the pyramidal extensions within Pol, will be denoted by $\underset{\Delta}{\leq}$ and called the pyramidal growth.
(c) The transfinite pyramidal growth $\underset{\infty}{\leq}$ is the smallest partial order on Pol, containing $\underset{\Delta}{\leq}$ and satisfying $P \underset{\infty}{\leq} Q$ whenever there exists an ascending sequence $P=P_{0} \underset{\infty}{\leq} P_{1} \underset{\infty}{\leq} P_{2} \underset{\infty}{\leq} \ldots$ with $\underset{i \rightarrow \infty}{Q}=\lim _{i \rightarrow \infty} P_{i}$.

[^0]It is easily shown that $\underset{\Delta}{\leq}$ is the inclusion order on $\operatorname{Pol}(2)$; see Corollary 4.3. In Figure 1, the outer quadrilateral is grown from the hexagon inside by stacking triangles onto edges in the indicated order:

Pyramidal extensions are more general than the extensions, used in the definition of stacked polytopes [2, Ch. 3.19] [9, Ch. 10.6], along with their direct generalization to arbitrary initial polytopes: by only allowing the stackings of pyramids onto facets when none of the codimension 2 faces disappears we get a new partial order on polytopes. Obviously, it does not coincide with the inclusion order. We do not know whether the transfinite completion of this order is the same as $\underset{\infty}{\leq}$.

Definition 1.2. (a) A quasi-pyramidal growth in $\mathbf{P o l}$, is a pair of polytopes $P \subset Q$, admitting within Pol a finite sequence of polytopes

P=P_{0} \subset P_{1} \subset \ldots \subset P_{n}=Q
$$

and pyramidal extensions

$$
P_{i}^{\prime} \underset{\Delta}{\subset} P_{i}, \quad i=1, \ldots, n
$$

such that

$$
P_{0} \subset P_{i}^{\prime} \subset P_{i-1}, \quad i=1, \ldots, n
$$

The resulting partial order on $\mathbf{P o l}$ will be denoted by $\underset{\mathbf{q}}{\leq}$.
(b) The quasi-pyramidal defect of a pair of polytopes $P \underset{\mathbf{q}}{\leq} Q$ in $\mathbf{P o l}$ is defined by

$$
\delta(P, Q)=\inf \left\{\sum \mathrm{d}_{\mathrm{H}}\left(P_{i}^{\prime}, P_{i}\right) \mid P_{i}^{\prime} \subsetneq P_{i-1}\right\}
$$

where the infimum is taken over the sequences as in the part (a).

Informally, the quasi-pyramidal defect measures how close an equality $P \underset{\mathbf{q}}{\leq} Q$ is to the inequality $P \underset{\Delta}{\leq} Q$. Observe that the first extension $P_{0} \subset P_{1}$ in Definition $1.2(\mathrm{a})$ is necessarily pyramidal.

Recently several notions of minimal enlargements of polytopes appeared in the literature: extensions of lattice 3-polytopes by adding one lattice point play an important role in a classification of lattice 3-polytopes [1]; connectivity of the graph on the set of polytopes is studied in [7], where two polytopes form an edge if their vertex sets differ by adding/deleting one element.

Let $k \subset \mathbb{R}$ be a subfield. Our main results are:
Theorem A. $\underset{\infty}{\leq}$ is the inclusion order on $\operatorname{Pol}_{k}(\infty)$.
Theorem B. $\underset{\Delta}{\leq}$ is the inclusion order on $\operatorname{Pol}_{k}(3)$.
The classical proof of the Steinitz Theorem [9, Ch. 13.1] implies that the set of 3polytopes in $\mathbb{R}^{3}$ is connected via combinatorial modifications, which can be realized geometrically as 'up-down' pyramidal extensions, when the pyramids being stacked are simplices. On the other hand, Theorem B implies that the poset of 3-polytopes in $\mathbb{R}^{3}$, ordered by $\underset{\Delta}{\leq}$, is topologically contractible, i.e., the geometric realization of the corresponding order complex is a contractible space: every finite system in this poset has an upper bound

Theorem C. If $\underset{\Delta}{\leq}$ is the inclusion order on $\mathbf{P o l}_{k}(d)$ then $\underset{\mathbf{q}}{\leq}$ is the inclusion order on $\operatorname{Pol}_{k}(d+1)$. Moreover, $\delta(P, Q)=0$ for any two polytopes $P \subset Q$ in $\mathbf{P o l}_{k}(d+1)$.

In particular, $\underset{\mathbf{q}}{\leq}$ is the inclusion order on $\mathbf{P o l}_{k}(4)$ and $\delta(P, Q)=0$ for any two polytopes $P \subset Q$ in $\mathbf{P o l}_{k}(4)$. The proof of Theorem C also implies that the same result on quasi-pyramidal growth can be proved unconditionally in all dimensions if a local conical version of the induction step can be worked out; see Remark 7.2.
$K$-theory. The poset $\left(\operatorname{Pol}_{\mathbb{Q}}(\infty), \underset{\Delta}{\leq}\right)$ is implicit in our $K$-theoretic works on monoid rings. Informally, a pyramidal extension $P \underset{\Delta}{\subset} Q$ represents a minimal enlargement of a polytope, allowing to transfer certain $K$-theoretic information on $P$ to the polytope $Q$. More precisely, rational polytopes give rise to submonoids of $\mathbb{Z}^{d}$ and, when $P \underset{\Delta}{\subset} Q$, certain $K$-theoretic objects over the monoid ring, associated with $Q$, are extended from the submonoid ring, associated with $P$. Results of this type in various $K$-theoretic scenarios are obtained in [10, 11, 12]. Assume $\underset{\Delta}{\leq}$ coincides with $\subset$. Then the $K$-theoretic objects in question, defined over the monoid ring of $Q$, extend from polynomial rings because there is a rational simplex $P \subset Q$, defining a free commutative monoid. But $K$-theory of the monoid rings of free commutative monoid, which is the same as polynomial rings, is one of the best understood topics in algebraic $K$-theory - the so-called homotopy invariance properties. Most likely,
the relations $\subset$ and $\underset{\Delta}{\leq}$ are different; see below. In the mentioned works we used the following substitute, which suffices for the $K$-theoretic purposes: for two rational polytopes $P \subset Q$, there is a sequence of rational polytopes of the form

& P=P_{0}, P_{1}, \ldots, P_{n}=Q \\
& \quad P_{i} \subset Q \text { and } P_{i-1} \underset{\Delta}{\subset} P_{i} \text { or } P_{i-1} \supset P_{i}, \\
& \quad i=1, \ldots, n .
\end{aligned}
$$

With a small additional $K$-theoretic work, one can show that the relevant $K$ theoretic information still can be transferred from $P$ to $Q$ if $P \underset{\mathbf{q}}{\leq} Q$ or $P \underset{\infty}{\leq} Q$. Thus Theorem A allows to avoid the non-monotonicity fluctuations $P_{i-1} \supset P_{i}$ above in the process of descending from the larger polytope $Q$ to $P$

Quantum jumps and rational cones. In [6, 14] we explored two posets: (i) the poset $\operatorname{NPol}(d)$ of normal polytopes - essentially the projectively normal embeddings of toric varieties - whose minimal elements have played crucial role in disproving various covering conjectures in the 1990s [3, 5], and (ii) the poset Cones ( $d$ ) of rational cones, as the additive counterpart of $\mathrm{NPol}(d-1)$ via the correspondence $P \mapsto$ the homogenization cone of $P$. The poset of cones is more amenable to arithmetic and topological analysis and can provide a handle on the poset of normal polytopes. The elementary relation in $\operatorname{NPol}(d)$, called quantum jumps, are the extensions of normal polytopes by adding one lattice point. The order in Cones $(d)$ is generated by the extensions of the monoids of the form $C \cap \mathbb{Z}^{d}, C \subset \mathbb{R}^{d}$ a rational cone, by adding one generator. Currently, even the existence of isolated points in $\operatorname{NPol}(d)$ is not excluded for $d \geq 4$, whereas the order in $\operatorname{Cones}(d)$ is conjectured to be the inclusion order for any $d$. The poset $(\operatorname{Pol}(d), \underset{\mathbf{q}}{\leq})$ is a continuous analogue of $\operatorname{Cones}(d+1)$ and so it too is expected to be ordered by inclusion. This is partially confirmed by Theorem C. The poset $(\operatorname{Pol}(d), \underset{\Delta}{\leq})$ is a continuous version of another poset, also introduced in $[14, \S 2 \mathrm{~B}]$. It is generated by the so-called height 1 extensions over facets of cones, has fewer relations than Cones $(d+1)$, and allows extensive computational experimentation.

Do the pyramidal growth and inclusion order coincide? If $P \underset{\Delta}{\subset} Q$ and $P$ is a rational polytope, then $Q$ is combinatorially equivalent to a rational polytope. Whether the same can be said when $P \underset{\Delta}{\leq} Q$ is an interesting question. In view of the existence of polytopes of irrational type (e.g., [9, Ch. 5.4]), the positive answer would imply that $\underset{\Delta}{\leq}$ and $\subset$ are different in the corresponding dimension over the corresponding subfield $k \subset \mathbb{R}$

Another question of independent interest, in the spirit of approximations by polytopes [8], is whether there is a sequence $0=P_{0} \leq P_{1} \underset{\Delta}{\Delta} \ldots$ in $\operatorname{Pol}(d)$, starting with the origin $0 \in \mathbb{R}^{d}$ and such that $\bigcup_{i=0}^{\infty} P_{i}=\stackrel{\circ}{\mathrm{B}}_{d}$, where $\stackrel{\circ}{\mathrm{B}}_{d}$ is the open unit $d$-ball. The negative answer would show that $\underset{\Delta}{\leq}$ is not the inclusion order on $\mathbf{P o l}_{\mathbb{Q}}(d)$.

Remark 1.3. (a) In the rest of the paper we only consider polytopes in $\operatorname{Pol}(d)$. But adjusting the arguments to $\mathbf{P o l}_{k}(d)$ for any subfield $k \subset \mathbb{R}$ is straightforward.
(b) The proof of the main results yields an algorithm for building up arbitrary 3 -polytopes via pyramidal growth and arbitrary 4 -polytopes via quasi-pyramidal growth, arbitrarily close to pyramidal growth.

## 2. Notation

Our references for basic facts on polytopes are [4, Ch.1] and [9]. The relatively standard notation/terminology we will use is as follows.

A space refers to a finite-dimensional affine subspace of $\oplus_{\mathbb{N}} \mathbb{R}$. A half-space of a space will mean a closed affine half-space.

The convex and affine hulls of a subset $X \subset \oplus_{\mathbb{N}} \mathbb{R}$ will be denoted by $\operatorname{conv}(X)$ and $\operatorname{Aff}(X)$, respectively. For two points $x, y \in \oplus_{\mathbb{N}} \mathbb{R}$ we will use $[x, y]$ for $\operatorname{conv}(x, y)$.

The conical hull of a subset $X \subset \oplus_{\mathbb{N}} \mathbb{R}$ will be denoted by $\mathbb{R}_{+} X$, i.e., $\mathbb{R}_{+} X=$ $\{c x \mid x \in X, c \geq 0\}$.

For a finite dimensional convex set $X$, by $\operatorname{int}(X)$ we denote the relative interior of $X$. The boundary of $X$ is $\partial X=X \backslash \operatorname{int}(X)$.

For a polytope $P$, the set of its vertices and facets will be denoted by vert $(P)$ and $\mathbb{F}(P)$, respectively.

We also need a more specialized notation.
(i) Let $P, Q$ be polytopes, such that $f=P \cap R$ is a common face and, moreover, $\operatorname{dim}(\operatorname{conv}(P, Q))=\operatorname{dim} P+\operatorname{dim} Q-\operatorname{dim} f$. Then $\operatorname{conv}(P \cup Q)$ is the colimit in the category of convex polytopes and affine maps of the diagram of face embeddings $P_{\nwarrow_{f} \nearrow} Q$; for the categorial analysis of polytopes see [13]. Correspondingly, instead of $\operatorname{conv}(P, Q)$ we will use the more informative notation $P \vee \underset{f}{\vee} Q$. Figure 2 represents the construction for two pentagons, sharing an edge:

(ii) For a full-dimensional polytope $P$ in a space $H$, a point $v \in H \backslash P$, and a not necessarily proper face $P^{\prime} \subset P$, we denote by $\partial_{v}\left(P^{\prime}\right)^{+}$and $\mathbb{F}_{v}\left(P^{\prime}\right)^{+}$the part of $\partial\left(P^{\prime}\right)$
and the set of facets of $P^{\prime}$, respectively, whose visibility is not obstructed by $P$. We skip $P$ from the notation because the polytope $P$ will be clear from the context. In Figure 3, the set $\mathbb{F}_{v}(P)^{+}$consists of two triangles and, for the facet $P^{\prime} \subset P$, the set $\mathbb{F}_{v}\left(P^{\prime}\right)^{+}$consists of two edges:

(iii) For a polytope $P$ and a facet $f \subset P$, we denote by $\operatorname{Aff}_{f}(P)^{+} \subset \operatorname{Aff}(P)$ the half-space, bounded by $\operatorname{Aff}(f)$ and containing $P$ (Figure 4).

(iv) For a space $H$ and a point $w \notin H$, we denote by $H_{w}^{-}$the half-space in $\operatorname{Aff}(H, w)$, not containing $w$ (Figure 5).

(v) Consider a finite dimensional convex set $C$, a space $H$, a polytope $\pi$, and a point $z$, satisfying the conditions:

- $\pi \subset H$ and $z \in C \backslash H$,
- $\operatorname{dim}(\operatorname{Aff}(C, H))=\operatorname{dim}(H)+1=\operatorname{dim}(\pi)+2$,
- $C \cap H$ is contained in exactly one of the half-spaces of $H$, bounded by $\operatorname{Aff}(\pi)$.

Then, for a real number $\vartheta \geq 0$, denote by:

- $H_{\vartheta}(\pi, C, z)$ the rotation of $H$ inside $\operatorname{Aff}(C, H)$ around $\operatorname{Aff}(\pi)$ by the angle $\vartheta$, moving the half-pace of $H$, which contains $H \cap C$, towards $z$ in such a way that $H \cap C$ stays nonempty during the rotation;
- $H_{\vartheta}(\pi, C, z)^{-}$the half-space of $\operatorname{Aff}(C, H)$, bounded by $H_{\vartheta}(\pi, C, z)$ and not containing $z$; this half-space exists for every sufficiently small $\vartheta \geq 0$; this notation is a simplification of $\left(H_{\vartheta}(\pi, C, z)\right)_{z}^{-}$, which results from (iv) above.

Figure 6 represents the notation introduced:

For the convenience of the reader, we will often reference to the special notation above, using (i), (ii), (iii), (iv), (v.

## 3. Outline of the proof

The proof is by induction on dimension $d$. Let $\leq$ denote any of the three partial orders. In the preparatory Section 4 we show that, for dimension $d$, it is enough to have $P \leq P \underset{f}{\vee} Q$ for $\operatorname{dim} P=\operatorname{dim} Q=d-1$ and $f$ a common facet.

If $Q$ is a pyramid over $f$ then polytope $P \underset{f}{\vee} Q$ is a pyramid over $P$. By inducting on the number of vertices, it is enough to show that, for a point $v$ in the half-space
$\operatorname{Aff}_{f}(Q)^{+}$(iii) and not in $Q$, the inequality $P \leq P \underset{f}{\vee} Q$ propagates to the inequality $P \leq P \vee \underset{f}{\vee} \operatorname{conv}(Q, v)$. This is accomplished by gradually growing $Q$ in the sense of $\leq$ towards conv $(Q, v)$. The process of growing $Q$ breaks up into several different steps.

Theorem $A$. First we show that there is an intermediate polytope $Q \subset Q_{1} \subset$ $\operatorname{conv}(Q, v)$, such that $P \underset{f}{\vee} Q \leq P \vee_{f} Q_{1}$ and whose facets visible from $v$ are paired with the facets of $P$ visible from $v$ so that the pairs span facets of $P \vee{ }_{f} Q_{1}$. In the next step we show that for any number $\lambda<1$, sufficiently close to 1 , the homothetic transformation - up to a projective transformation, moving $f$ to infinity - of the visible boundary $\partial_{v}\left(Q_{1}\right)^{+}$(iii, centered at $v$ with factor $\lambda$, and $Q_{1}$ together span a polytope $Q_{2}$ with the same properties as $Q_{1}$ and, simultaneously, $P \underset{f}{\vee} Q_{1} \leq P \underset{f}{\vee} Q_{2}$. Moreover, the process, which is summarized in Proposition 5.1 and represented by Figure 7, can be iterated with respect to the same $\lambda$. This is enough for $\underset{\infty}{\leq}$, i.e., proves Theorem A. The main vehicle for growing polytopes are the elementary moves, called the R- and $\mathbf{S}$-constructions. (In Figures 7 and 8 we have not marked the edges, joining $v$ with vertices of $P$.)

Theorem B. Since $\underset{\Delta}{\leq}$ is the same as $\subset$ in dimension 2, the first step for $\leq_{\Delta}$ as described above, reduces the problem to the inequality $P \leq P \underset{f}{\vee} Q$, where $Q$ has the properties
of $Q_{1}$ above. The main idea is to show the existence of the ascending sequence

$$
P \underset{f}{\vee} Q=\Pi_{1} \underset{\Delta}{\leq} \Pi_{2} \underset{\Delta}{\leq} \Pi_{3} \underset{\Delta}{\leq} \cdots \underset{\Delta}{\leq} \Pi_{n}=P \underset{f}{\vee} \operatorname{conv}(Q, v)
$$

where $n+1$ is the number of vertices of $Q$, visible from $v$, and the facets of $\Pi_{i}$ in $\operatorname{Aff}(Q)$ grow along with the index $i$ as shown on Figure 8:

This is done by induction on complexity of the suspensions $\overline{\Pi_{i+1} \backslash \Pi_{i}}$ for $i=$ $1, \ldots, n-1$. For instance, $\overline{\Pi_{n} \backslash \Pi_{n-1}}$ is of zero complexity because $\Pi_{n-1} \underset{\Delta}{\leq} \Pi_{n}$.

Theorem $C$. Using the notation in the description of the proof of Theorem A, if $n$ is sufficiently large then the polytope $Q_{n}$ is sufficiently close to $\operatorname{conv}(Q, v)$. Correspondingly, the corner cones of $P \underset{f}{\vee} Q_{n}$ at the vertices of $P$, visible from $v$, approximate from within the corner cones of $P \underset{f}{\vee} \operatorname{conv}(Q, v)$ at the same vertices. These vertices are circled in Figure 9. It can be shown that the polytope $P \underset{f}{\vee} Q_{n}$ can be grown along $\underset{\Delta}{\leq}$, staying inside $P \underset{f}{\vee} \operatorname{conv}(Q, v)$ and making the mentioned corner cones of $P \vee \operatorname{conv}(Q, v)$ exactly match with the corresponding corner cones of the new (larger) polytope $P \underset{f}{\vee} Q_{n} \underset{\Delta}{\leq} T$. This is achieved by applying the induction assumption on dimension to the cross-sections of the corner cones. In the final step, using appropriate projective and homothetic transformations, similar to the ones used in the proof of Theorem A, one chooses $n$ sufficiently large and contracts the difference between $P \underset{f}{\vee} \operatorname{conv}(Q, v)$ and $T$ towards the vertex $v$. Since $\underset{\mathbf{q}}{\leq}$ is the relaxation of $\underset{\Delta}{\leq}$ by discarding such small differences, Theorem C follows.

## 4. Reduction to $\vee$-polytopes

In this section $\leq$ denotes any of the inequalities $\underset{\Delta}{\leq}, \underset{\mathrm{q}}{\leq}$, and $\underset{\infty}{\leq}$.
Consider the following statement:

$$
\begin{equation*}
P \leq P \underset{f}{\vee} R \text { in } \operatorname{Pol}(d) \text { whenever } \operatorname{dim} R=\operatorname{dim} P=d-1 \text { and } f=P \cap R \tag{1}
\end{equation*}
$$ is a common facet.

Lemma 4.1. Assume $d \geq 2$ is a natural number and (1) holds for $d$. Assume $Q_{1} \subset Q_{2}$ are d-polytopes and $Q_{1}$ has a facet $F \subset \partial Q_{2}$. Then $Q_{1} \leq Q_{2}$.
Proof. We will induct on the number $n\left(Q_{1}, Q_{2}\right):=\#\left\{G \in \mathbb{F}\left(Q_{1}\right) \mid G \notin \partial\left(Q_{2}\right)\right\}$.
If $n\left(Q_{1}, Q_{2}\right)=0$ then $Q_{1}=Q_{2}$ and there is nothing to prove.
Assume $Q_{1} \subsetneq Q_{2}$. Then we can find a facet $G \in \mathbb{F}\left(Q_{1}\right)$ with $G \notin \partial\left(Q_{2}\right)$ and adjacent to a facet $F \in \mathbb{F}\left(Q_{1}\right)$ with $F \subset \partial\left(Q_{2}\right)$. Let $g=G \cap F$. We have $\operatorname{dim} g=$ $d-2$.

The space $\operatorname{Aff}(G)$ cuts $Q_{2}$ in two parts. Let $Q_{2}^{-}$the part containing $Q_{1}$ and $Q_{2}^{+}$be the other part. Let $\vartheta>0$ be the smallest angle for which there exists a ( $d-1$ )-dimensional space $H \subset \operatorname{Aff}\left(Q_{2}\right)$, satisfying the conditions:

- $\operatorname{Aff}(G) \cap H=\operatorname{Aff}(g)$,
- $Q_{2}^{+}$is between $H$ and $\operatorname{Aff}(G)$,
- The angle between $H$ and $\operatorname{Aff}(G)$ equals $\vartheta$.
(It can happen that $H=\operatorname{Aff}(F)$.)

Pick any element $v$ from the nonempty set $\left(\operatorname{vert}\left(Q_{2}\right) \cap H\right) \backslash\{g\}$ and consider the angles

$$
0=\vartheta_{0}<\vartheta_{1}<\ldots<\vartheta_{k}=\vartheta
$$

for which the hyperplane $\operatorname{Aff}(G)_{\vartheta_{i}}\left(g, Q_{2}^{+}, v\right)$ © meets vert $\left(Q_{2}^{+}\right)$.
For every index $i \in\{0, \ldots, k-1\}$, the piece $Q_{2}\left[\vartheta_{i}, \vartheta_{i+1}\right]$ of $Q_{2}^{+}$between the spaces $\operatorname{Aff}(G)_{\vartheta_{i}}\left(g, Q_{2}^{+}, v\right)$ and $\operatorname{Aff}(G)_{\vartheta_{i+1}}\left(g, Q_{2}^{+}, v\right)$ is of the form (i)

$$
Q_{2}\left[\vartheta_{i}, \vartheta_{i+1}\right]=\left(Q_{2} \cap \operatorname{Aff}(G)_{\vartheta_{i}}\left(g, Q_{2}^{+}, v\right)\right) \underset{g}{\vee}\left(Q_{2} \cap \operatorname{Aff}(G)_{\vartheta_{i+1}}\left(g, Q_{2}^{+}, v\right)\right)
$$

By the assumption that (1) holds for $d$, we have

$$
Q_{2}^{-} \leq Q_{2}^{-} \cup Q_{2}\left[\vartheta_{0}, \vartheta_{1}\right] \leq \ldots \leq Q_{2}^{-} \cup Q_{2}\left[\vartheta_{0}, \vartheta_{1}\right] \cup \ldots \cup Q_{2}\left[\vartheta_{k-1}, \vartheta_{k}\right]=Q_{2} .
$$

On the other hand, $n\left(Q_{1}, Q_{2}^{-}\right)<n\left(Q_{1}, Q_{2}\right)$. Hence, by the induction assumption, $Q_{1} \leq Q_{2}^{-}$.

The first reduction in the proof of the main results is provided by the following
Lemma 4.2. To prove Theorems $\mathrm{A}, \mathrm{B}$, and C in dimension $d \geq 2$, it is enough to prove that (1) is true for $d$.
Proof. Let $Q_{1} \subset Q_{2}$ be polytopes. By iteratively taking pyramids over $Q_{1}$ inside $Q_{2}$, we can without loss of generality assume $\operatorname{dim} Q_{1}=\operatorname{dim} Q_{2}$. Let $\left\{v_{1}, \ldots, v_{n}\right\}=$ $\operatorname{vert}\left(Q_{2}\right) \backslash Q_{1}$. Any two consecutive members in the series of inclusions

$$
Q_{1} \subset \operatorname{conv}\left(Q_{1}, v_{1}\right) \subset \operatorname{conv}\left(Q_{1}, v_{1}, v_{2}\right) \subset \ldots \subset \operatorname{conv}\left(Q_{1}, v_{1}, \ldots, v_{n}\right)=Q_{2}
$$

satisfy the condition in Lemma 4.1. This proves the part of Lemma 4.2, concerning inequalities. As for the infinitesimal nature of the pyramidal defect in Theorem C, it also reduces to the extensions of the form $P \subset P \underset{f}{\vee} R$ as in (1) because the number of such extensions, involved in the proof of Lemma 4.1, is finite.
Corollary 4.3. For $d \leq 2$, the pyramidal growth in $\operatorname{Pol}(d)$ is the same as the inclusion order.

Proof. The claim is obvious for $d=1$.
When $\operatorname{dim} P=\operatorname{dim} Q=1$ and $f=P \cap Q$ is a common vertex, the polygon $P \vee_{f} Q$ is a triangle. In particular, $P \underset{\Delta}{\leq} P \underset{f}{\vee} Q$ and Lemma 4.2 applies.

## 5. V-GROWTH

As in Section 4, we let $\leq$ denote any of the inequalities $\underset{\Delta}{\leq}, \underset{\mathrm{q}}{\leq}$, and $\underset{\infty}{\leq}$.
Throughout this section, we assume $d \geq 2$ and that $P$ and $Q$ are polytopes, such that $\operatorname{dim} P=\operatorname{dim} Q=d-1$ with $f=P \cap Q$ is a common facet.

We also fix a point $v \in \operatorname{Aff}_{f}(Q)^{+} \backslash Q$ (iii) and a projective transformation $\Phi$ of $\operatorname{Aff}(P, Q)$, moving $\operatorname{Aff}(f)$ to infinity, but not moving any of the points of $(P \underset{f}{\vee} Q) \backslash f$ to infinity.

Below, when we write $\partial_{v}(-)^{+}$and $\mathbb{F}_{v}(-)^{+}$(ii), the visibility is understood with respect to the polytope $P \underset{F}{\vee} Q$.

Proposition 5.1. Assume $\leq$ coincides with the inclusion order on $\operatorname{Pol}(d-1)$. Then, for any number $\lambda<1$, sufficiently close to 1 , there exists an infinite sequence of polytopes $Q=Q_{0} \subset Q_{1} \subset Q_{2} \subset \ldots \subset \operatorname{conv}(Q, v)$, such that:
(a) For every index $i \geq 1$, the sets $\mathbb{F}_{v}(P)^{+}$and $\mathbb{F}_{v}\left(Q_{i}\right)^{+}$are in bijective correspondence so that $\operatorname{conv}(D, E) \in \mathbb{F}_{v}\left(P \bigvee_{f} Q_{i}\right)^{+}$whenever $D \in \mathbb{F}_{v}(P)^{+}$and $E \in \mathbb{F}_{v}\left(Q_{i}\right)^{+}$ correspond to each other;
(b) For every index $i \geq 1$, the set $\Phi\left(Q_{i} \backslash f\right)$ is the homothetic image of $\Phi\left(Q_{i-1} \backslash f\right)$ centered at $\Phi(v)$ with coefficient $\lambda$;
(c) $P \underset{f}{\vee} Q_{0} \leq P \underset{f}{\vee} Q_{1} \leq P \underset{f}{\vee} Q_{2} \leq \ldots$.

The proof requires a preparation.
5.1. R- and S-constructions. We will need two auxiliary polytopal constructions. Consider the polytope

$$
\begin{equation*}
\mathbf{R}(Q, P)=\operatorname{conv}(Q, v) \quad \bigcap_{\substack{w \in \operatorname{vert}(Q) \cap \partial_{v}(Q)^{+} \\ D \in \mathbb{F}_{v}(P)^{+} \\ \operatorname{conv}(D, w) \subset \partial_{v}(P \vee f)^{+}}} \operatorname{Aff}(D, w)_{v}^{-} . \tag{ii}
\end{equation*}
$$

This polytope is determined by the following properties:

- $Q \subset \mathbf{R}(Q, P) \subset \operatorname{conv}(Q, v)$;
. For every point $z \in \mathbf{R}(Q, P) \backslash Q$, every element of $\mathbb{F}_{z}(P \vee \underset{f}{\vee} Q)^{+}$is the convex hull of an element of $\mathbb{F}_{v}(Q)^{+}$and a face of $P$ inside $\partial_{v}(P)^{+}$(ii), which is not a facet of $P$, i.e., the point $z$ can not see a facet of $P$;
- $\mathbf{R}(Q, P)$ is the largest polytope with these properties.

Let an intermediate polytope $Q \subset S \subset \operatorname{conv}(Q, v)$ satisfy the condition:
$(\boldsymbol{\star})$ For every element $s \in \mathbb{F}_{v}(S)^{+}$there is an element $p \in \mathbb{F}_{v}(P)^{+}$such that $\operatorname{conv}(p, s) \in \mathbb{F}_{v}(P \underset{f}{\vee} S)^{+}$(ii).

In this situation, we have the injective map

$$
\begin{aligned}
\rho: \mathbb{F}_{v}(S)^{+} & \rightarrow \mathbb{F}_{v}(P)^{+}, \\
s & \mapsto p .
\end{aligned}
$$

Furthermore, for every element $p \in \mathbb{F}_{v}(P)^{+}$, there is a unique element of $\mathbb{F}_{v}\left(P \vee{ }_{f} S\right)^{+}$, containing $p$. This assignment gives rise to a bijective map

$$
\sigma: \mathbb{F}_{v}(P)^{+} \rightarrow \mathbb{F}_{v}(P \underset{f}{\vee} S)^{+}
$$

and the correspondence

$$
s \mapsto(\sigma(\rho(s)) \cap \operatorname{Aff}(Q)
$$

is the identity map of $\mathbb{F}_{v}(S)^{+}$.
For an intermediate polytope $Q \subset S \subset \operatorname{conv}(Q, v)$, satisfying $(\star)$, and a system of positive real numbers

$$
\Theta=\left\{\vartheta_{s}>0 \mid s \in \mathbb{F}_{v}(S)^{+}\right\}
$$

we introduce the following polytope:

$$
\begin{aligned}
\mathbf{S}_{\Theta}(S, P)=\operatorname{conv}(Q, v) & \bigcap \bigcap_{s \in \mathbb{F}_{v}(S)^{+}} \operatorname{Aff}\left((\sigma(\rho(q)))_{\vartheta_{s}}(\rho(s), S, v)^{-} \bigcap\right. \\
& \bigcap_{p \in \mathbb{F}_{v}(P)^{+} \backslash \operatorname{Im}(\rho)} \operatorname{Aff}_{v}(\sigma(p))^{-}
\end{aligned}
$$

In other words, the polytope $P \underset{f}{\vee} \mathbf{S}_{\Theta}(S, P)$ is obtained from $P \underset{f}{\vee} S$ by rotating the affine hulls of the facets in $\mathbb{F}_{v}\left(P \vee_{f} S\right)^{+}$, which contain the elements of $\mathbb{F}_{v}(S)^{+}$as subsets, towards $v$ by the angles $\vartheta_{s}$ about $\operatorname{Aff}(\rho(s))$, respectively, and not moving the affine hulls of the other facets in $\mathbb{F}_{v}\left(P \vee{ }_{f} S\right)^{+}$.

The following lemma is straightforward:
Lemma 5.2. $\mathbf{R}(Q, P)$ satisfies $(\boldsymbol{\star})$. If an intermediate polytope $Q \subset S \subset \operatorname{conv}(Q, v)$ satisfies $(\boldsymbol{\star})$ then the polytope $\mathbf{S}_{\Theta}(S, P)$ also satisfies $(\boldsymbol{\star})$, where $\Theta=\left\{\vartheta_{s} \mid s \in\right.$ $\left.\mathbb{F}_{v}(S)^{+}\right\}$and the $\vartheta_{s}>0$ are sufficiently small.

### 5.2. R- and S-growths. We need

Lemma 5.3. For an intermediate polytope $Q \subset Q^{\prime} \subset \mathbf{R}(P, Q)$ and a point $z \in$ $\mathbf{R}(P, Q) \backslash Q^{\prime}$ with $\mathbb{F}_{z}\left(Q^{\prime}\right)^{+}=\left\{q^{\prime}\right\}$, the set $\mathbb{F}_{z}\left(P \vee_{f} Q^{\prime}\right)^{+}$has one element. This facet of $P \vee{ }_{f} Q^{\prime}$ is the convex hull of $q^{\prime}$ and a face of $P$ inside $\partial_{v}(P)^{+}$, which is not a facet of $P$. Furthermore, $P \underset{f}{\vee} Q^{\prime} \leq P \underset{f}{\vee} \operatorname{conv}\left(Q^{\prime}, z\right)$.
Proof. As remarked in the definition of the R-construction, $z$ can not see a facet of $P$ from outside of $P \underset{f}{\vee} Q$, and a fortiori from outside of $P \underset{f}{\vee} Q^{\prime}$. This implies

$$
\mathbb{F}_{z}\left(P \underset{f}{\vee} Q^{\prime}\right)^{+}=\left\{\operatorname{conv}\left(p^{\prime}, q^{\prime}\right)\right\}
$$

for some face $p^{\prime} \subset P$, not in $\mathbb{F}(P)$. As a result, the closure of the set

$$
\left(P \vee_{f} \operatorname{conv}\left(Q^{\prime}, z\right)\right) \backslash\left(P \underset{f}{\vee} Q^{\prime}\right)
$$

is the pyramid over $\operatorname{conv}\left(p^{\prime}, q^{\prime}\right)$ with apex at $z$. In particular,

$$
P \underset{f}{\vee} Q^{\prime} \underset{\Delta}{\leq} P \underset{f}{\vee} \operatorname{conv}\left(Q^{\prime}, z\right)
$$

Lemma 5.4. Assume $\leq$ coincides with the inclusion order on $\operatorname{Pol}(d-1)$. Then $P \underset{f}{\vee} Q \leq P \underset{f}{\vee} \mathbf{R}(Q, P)$.

Proof. By Lemma 5.3, for any intermediate polytopes $Q \subset Q^{\prime} \subset Q^{\prime \prime} \subset \mathbf{R}(Q, P)$, forming an elementary order relation $Q^{\prime} \leq Q^{\prime \prime}$, we have $P \underset{f}{\vee} Q^{\prime} \leq P \underset{f}{\vee} Q^{\prime \prime}$. This proves the lemma because, by the inductive assumption on the dimension, $Q \leq \mathbf{R}(Q, P)$.

Notice that Lemma 5.3 applies to $\underset{\mathbf{q}}{\leq}$ because of the requirement $P_{0} \subset P_{i}^{\prime}$, mentioned in Definition 1.2.

Lemma 5.5. Assume $\leq$ coincides with the inclusion order on $\operatorname{Pol}(d-1)$. Let an intermediate polytope $Q \subset S \subset \operatorname{conv}(Q, v)$ satisfy $(\star)$. Then, for all sufficiently small real numbers $\vartheta_{s}>0, s \in \mathbb{F}_{v}(S)^{+}$, we have $P \vee_{f} S \leq P \vee_{f} \mathbf{S}_{\Theta}(S, P)$, where $\Theta=\left\{\vartheta_{s} \mid s \in \mathbb{F}_{v}(S)^{+}\right\}$.
Proof. Assume $\mathbb{F}_{v}(S)^{+}=\left\{s_{1}, \ldots, s_{n}\right\}$. For every index $i \in\{1, \ldots, n\}$, let $\gamma_{i}$ be the barycenter of $s_{i}$. ${ }^{1}$ Choose $z_{i}$ in $\left[\gamma\left(s_{i}\right), v\right]$, sufficiently close to but different from $\gamma_{i}$, so that the following two conditions are satisfied:

$$
\begin{aligned}
s_{i} \in \mathbf{R}\left(\operatorname{conv}\left(S, s_{1}, \ldots, s_{n}\right), P\right) \quad \text { and } \quad\left[z_{i}, z_{j}\right] & \cap \operatorname{int}(S) \neq \emptyset \\
& 1 \leq i, j \leq n, \quad i \neq j
\end{aligned}
$$

Then Lemma 5.3 implies

$$
P \underset{f}{\vee} S \leq P \underset{f}{\vee} \operatorname{conv}\left(S, s_{1}\right) \leq P \underset{f}{\vee} \operatorname{conv}\left(S, s_{1}, s_{2}\right) \leq \ldots \leq P \underset{f}{\vee} \operatorname{conv}\left(S, s_{1}, \ldots, s_{n}\right)
$$

By Lemma 5.4, we also have

$$
P \underset{f}{\vee} \operatorname{conv}\left(S, s_{1}, \ldots, s_{n}\right) \leq P \underset{f}{\vee} \mathbf{R}\left(\operatorname{conv}\left(S, s_{1}, \ldots, s_{n}\right), P\right)
$$

We are done because

$$
P \underset{f}{\vee} \mathbf{R}\left(\operatorname{conv}\left(S, s_{1}, \ldots, s_{n}\right), P\right)=\mathbf{S}_{\Theta}(S, P)
$$

for the appropriate $\Theta=\left\{\vartheta_{s} \mid s \in \mathbb{F}_{v}(S)^{+}\right\}$. Namely, the angles $\vartheta_{s}$ are determined by the condition

$$
z_{s} \in \operatorname{Aff}\left(\sigma(\rho(s))_{\vartheta_{s}}(\rho(s), S, v), \quad s \in \mathbb{F}_{v}(S)^{+}\right.
$$

Lemma 5.6. Assume $\leq$ coincides with the inclusion order on $\operatorname{Pol}(d-1)$. Then there is an intermediate polytope $\mathbf{R}(Q, P) \subset Q_{1} \subset \operatorname{conv}(Q, v)$, such that:
(a) $Q_{1}$ satisfies $(\boldsymbol{\star})$;
(b) The map $\rho: \mathbb{F}_{v}\left(Q_{1}\right)^{+} \rightarrow \mathbb{F}_{v}(P)^{+}$from Section 5.1 is a bijection;

[^1](c) $P \underset{f}{\vee} \mathbf{R}(Q, P) \leq P \underset{f}{\vee} Q_{1}$.

Proof. To simplify notation, put $R:=\mathbf{R}(Q, P)$. By Lemma 5.2 , the polytope $R$ satisfies $(\boldsymbol{\star})$. We have the maps, mentioned in Section 5.1:

$$
\begin{aligned}
& \rho: \mathbb{F}_{v}(R)^{+} \rightarrow \mathbb{F}_{v}(P)^{+} \\
& \sigma: \mathbb{F}(P)^{+} \rightarrow \mathbb{F}_{v}(P \underset{f}{\vee} R)^{+} .
\end{aligned}
$$

Assume the injective map $\rho$ is not bijective. We will promote $\rho$ to a bijection by inductively constructing a sequence of polytopes

$$
R=R_{0} \subset R_{1} \subset \ldots \subset R_{n} \subset \operatorname{conv}(Q, v)
$$

such that:

- Each $R_{i}$ satisfies ( $\star$ );
. $P \underset{f}{\vee} R_{0} \leq P \underset{f}{\vee} R_{1} \leq \ldots \leq P \underset{f}{\vee} R_{n}$;
- $\# \mathbb{F}\left(R_{0}\right)<\# \mathbb{F}\left(R_{1}\right)<\ldots<\# \mathbb{F}\left(R_{n}\right)=\# \mathbb{F}(P)$.

We will use the following notation for the corresponding maps:

$$
\begin{aligned}
& \rho_{i}: \mathbb{F}_{v}\left(R_{i}\right)^{+} \rightarrow \mathbb{F}_{v}(P)^{+}, \\
& \sigma_{i}: \mathbb{F}(P)^{+} \rightarrow \mathbb{F}_{v}\left(P \underset{f}{\vee} R_{i}\right)^{+} .
\end{aligned}
$$

In particular, $\rho_{0}=\rho$ and $\sigma_{0}=\sigma$.
Assume, after $t$ steps, we have produced polytopes $R_{1}, \ldots, R_{t}$ with the desired properties. Assume $\# \mathbb{F}\left(R_{t}\right)<\# \mathbb{F}(P)$ or, equivalently, $\rho_{t}$ is not a bijection. Choose sufficiently small real numbers

$$
\vartheta_{r}>0, \quad r \in \mathbb{F}_{v}\left(R_{t}\right)^{+}
$$

and put $\Theta=\left\{\vartheta_{r}\right\}$. The polytope $R_{t+1}$ satisfies ( $\star$ ) (Lemma 5.2). By Lemma 5.5, we have $P \underset{f}{\vee} R_{t} \leq P \underset{f}{\vee} R_{t+1}$. Simultaneously,

$$
\begin{aligned}
\left\{p \in \mathbb{F}_{v}(P)^{+}\right. & \left.\mid \sigma_{k}(p) \cap R_{t} \text { is a facet in } \partial_{v}\left(R_{t}\right)^{+}\right\} \subsetneq \\
& \left\{p \in \mathbb{F}_{v}(P)^{+} \mid \sigma_{t+1}(p) \cap R_{t+1} \text { is a facet in } \partial_{v}\left(R_{t+1}\right)^{+}\right\} .
\end{aligned}
$$

or, equivalently, $\operatorname{Im}\left(\rho_{t}\right) \subsetneq \operatorname{Im}\left(\rho_{t+1}\right)$.
5.3. Projective transformation $\Psi_{\lambda}$. To complete the proof of Proposition 5.1, we need another projective transformation.

Let $A$ be a space and $H \neq H^{\prime}$ be parallel codimension one subspaces of $A$. Choose a point $w \in H$. Then, for any real number $\lambda \neq 0$, there is a (unique) projective transformation $\Psi_{\lambda}$ of $A$, such that the restriction $\left.\left(\Psi_{\lambda}\right)\right|_{H}$ is the homothety, centered at $w$ with coefficient $\lambda$, and the restriction $\left.\left(\Psi_{\lambda}\right)\right|_{H^{\prime}}$ is the identity map.

Next we give a geometric description of $\Psi_{\lambda}$ when $0<\lambda<1$. This description implies a property of $\Psi_{\lambda}$, which will be important in the second use of $\Psi_{\lambda}$ in Section 7. Let $\curvearrowright$ be any $90^{\circ}$-rotation of $A$ inside $\oplus_{\mathbb{N}} \mathbb{R}$ about $H^{\prime}$ and $\curvearrowleft$ be the $90^{\circ}$-rotation in the opposite direction. Denote by $\overparen{A}, \stackrel{\overparen{H}}{ }$, and $\overparen{w}$ the corresponding images. Consider
the point $\pi \in \operatorname{Aff}\left(w, \stackrel{\overparen{w}}{)}\right.$, such that $\overparen{\sim}$ is between $\pi$ and $w$ and $\frac{\|\pi-\overparen{w}\|}{\|\pi-w\|}=\lambda$; see Figure 10 below.

Figure 10


Consider the polar projection $\operatorname{proj}_{\pi}: A \rightarrow \tilde{A}$ from the pole $\pi$. Its domain includes the half-space of $A$, bounded by $H^{\prime}$ and containing $H$. We have

$$
\Psi_{\lambda}=\curvearrowleft \circ \operatorname{proj}_{\pi}
$$

When $\lambda$ converges to 0 from the right and $A, H, H^{\prime}, w$ stay fixed, the pole $\pi$ converges to $\overparen{w}$ by sliding along the line $\operatorname{Aff}(w, \overparen{w})$. In view of the equality above we arrive at the conclusion that, for $A, H, H^{\prime}, w$ as above and a point in the half-space of $A$, bounded by $H^{\prime}$ and containing $H$

$$
\begin{equation*}
\lim _{\lambda \rightarrow 0^{+}} \Psi_{\lambda}(z)=w \tag{2}
\end{equation*}
$$

### 5.4. Proof of Proposition 5.1. Let $Q_{1}$ be as in Lemma 5.6.

First we observe that, for any number $0<\lambda<1$, there is a sequence of polytopes

$$
Q_{1} \subset Q_{2} \subset \ldots \subset \operatorname{conv}(Q, v)
$$

and a system of real numbers

$$
\vartheta_{i q}>0, \quad q \in \mathbb{F}_{v}\left(Q_{i-1}\right)^{+}, \quad i=2,3, \ldots,
$$

such that, for every $i \geq 2$, we have:

- $Q_{i}=\mathbf{S}_{\Theta_{i}}\left(Q_{i-1}, P\right)$ with $\Theta_{i}=\left\{\vartheta_{i q}\right\}$;
- $\Phi\left(Q_{i} \backslash f\right)$ is the homothetic image of $\Phi\left(Q_{i-1} \backslash f\right)$ with center $\Phi(v)$ and factor $\lambda$.

In fact, for the existence of the family $\left\{\vartheta_{2 q}>0 \mid q \in \mathbb{F}_{v}\left(Q_{1}\right)^{+}\right\}$, such that $Q_{1}$ and the corresponding polytope $Q_{2}$ have the desired properties, one only needs to adjust the angles $\vartheta_{2 q}$ to fit $\partial_{v}\left(Q_{2}\right)^{+}$into the homothety condition. Once we determine the $\vartheta_{2 q}$, the existence of the next family of real numbers $\left\{\vartheta_{3 q}>0 \mid q \in \mathbb{F}_{v}\left(Q_{2}\right)^{+}\right\}$ with the similar properties is obvious for the same reason, and the process can be iterated.

By Lemma 5.5 , if $\lambda<1$ is sufficiently close to 1 then $P \underset{f}{\vee} Q_{1} \leq P \underset{f}{\vee} Q_{2}$. We want to show that, for the same $\lambda$, we have

$$
P \underset{f}{\vee} Q_{i-1} \leq P \underset{f}{\vee} Q_{i}, \quad i=2,3, \ldots
$$

This is done as follows. Let $\Psi_{\lambda}$ be the projective transformation, introduced in Section 5.3, with the following specializations:

$$
\begin{aligned}
& A=\operatorname{Aff}(\Phi((P \underset{f}{\vee} Q) \backslash f)) \\
& H=\operatorname{Aff}(\Phi(Q \backslash f)) \\
& H^{\prime}=\operatorname{Aff}(\Phi(P \backslash f)) \\
& w=\Phi(v)
\end{aligned}
$$

We have

$$
Q_{i}=\operatorname{conv}\left(Q,\left(\Phi^{-1} \circ \Psi \circ \Phi\right)\left(Q_{i-1} \backslash f\right)\right)
$$

In particular, by pushing forward the chain of elementary order relations along the projective transformation $\Phi^{-1} \circ \Psi \circ \Phi$, we arrive at the implication

$$
P \underset{f}{\vee} Q_{i-1} \leq P \underset{f}{\vee} Q_{i} \quad \Longrightarrow \quad P \underset{f}{\vee} Q_{i} \leq P \underset{f}{\vee} Q_{i+1}
$$

Consequently, the inequality $P \underset{f}{\vee} Q_{i-1} \leq P \underset{f}{\vee} Q_{i}$ propagates from the initial value $i=2$ to all values of $i$.
5.5. Transfinite pyramidal growth. Here we prove Theorem A. We will induct on dimension, the base one-dimensional case being obvious. Assume the claim has been shown for $\operatorname{Pol}(d-1)$. By Lemmas 4.2, it is enough to show (1) holds for $d$, i.e., we have to show $P \leq \underset{\infty}{\leq} P \underset{f}{\vee} Q$.

Assume $\left\{v_{0}, v_{1}, \ldots, v_{n}\right\}=\operatorname{vert}(Q) \backslash f$ and consider the polytopes

$$
T_{i}=\operatorname{conv}\left(f, v_{0}, \ldots, v_{i}\right), \quad i=0, \ldots, n
$$

In view of Proposition 5.1, we can write

$$
P \underset{\Delta}{\leq} \operatorname{conv}\left(P, v_{0}\right)=P \underset{f}{\vee} T_{0} \underset{\infty}{\leq} P \underset{f}{\vee} T_{1} \underset{\infty}{\leq} \cdots \underset{\infty}{\leq} P \underset{f}{\vee} T_{n}=P \underset{f}{\vee} Q .
$$

## 6. Pyramidal growth of 3-polytopes

By Corollary 4.3, we already know that the pyramidal growth is the inclusion order in $\operatorname{Pol}(d), d \leq 2$.

Here we prove Theorem B, with the use of an essential part of Proposition 5.1.
By Lemma 4.2, to prove Theorem B, it is enough to show $P^{\prime} \underset{\Delta}{\leq} P^{\prime} \vee_{f^{\prime}} Q^{\prime}$, where $P^{\prime}$ and $Q^{\prime}$ are two polygons and $f^{\prime}=P^{\prime} \cap Q^{\prime}$ is a common edge. As we did in Section 5.5, assume $\left\{v_{0}, v_{1}, \ldots, v_{n}\right\}=\operatorname{vert}\left(Q^{\prime}\right) \backslash f^{\prime}$ and consider the polygons

$$
T_{i}=\operatorname{conv}\left(f, v_{0}, \ldots, v_{i}\right), \quad i=0, \ldots, n
$$

Then $P^{\prime} \underset{\Delta}{\leq} \operatorname{conv}\left(P^{\prime}, v_{0}\right)$ and, moreover, every inclusion in the sequence

$$
\operatorname{conv}\left(P^{\prime}, v_{0}\right)=P^{\prime} \underset{f^{\prime}}{\vee} T_{0} \subset P^{\prime} \underset{f^{\prime}}{\vee} T_{1} \subset \ldots \subset P_{f^{\prime}}^{\vee} T_{n}=P^{\prime} \underset{f^{\prime}}{\vee} Q^{\prime}
$$

can be changed to $\underset{\Delta}{\leq}$ if we show that

$$
\begin{equation*}
P \underset{f}{\vee} Q \underset{\Delta}{\leq} P \underset{f}{\vee} \operatorname{conv}(Q, v) \tag{3}
\end{equation*}
$$

whenever:

- $\operatorname{dim} P=\operatorname{dim} Q=2$,
- $f=P \cap Q$ is a common edge, - $v \in \operatorname{Aff}_{f}(Q)^{+} \backslash Q$. (iii)

We will induct on $\# \mathbb{F}_{v}(P)^{+}$(ii), where the visibility is with respect to $P \vee{ }_{f} Q$.
In the base case, when $\# \mathbb{F}_{v}(P)^{+}=1$, we pick an intermediate polygon $\mathbf{R}(P, Q) \subset$ $Q_{1} \subset \operatorname{conv}(Q, v)$ as in Lemma 5.6, and write

$$
P \underset{f}{\vee} Q \underset{\Delta}{\leq} P \underset{f}{\vee} \mathbf{R}(P, Q) \underset{\Delta}{\leq} P \underset{f}{\vee} Q_{1} \underset{\Delta}{\subset} P \underset{f}{\vee} \operatorname{conv}(Q, v),
$$

where the leftmost inequality is due to Lemma 5.4.
Assume $n>1$ and we have shown (3) for $\# \mathbb{F}_{v}(P)^{+} \leq n-1$.
Consider the case $\# \mathbb{F}_{v}(P)^{+}=n$. In view of Lemmas 5.4 and 5.6 , we can assume that there is bijective correpondence between $\mathbb{F}_{v}(Q)^{+}$and $\mathbb{F}_{v}(P)^{+}$so that the facets in $\mathbb{F}_{v}\left(P \bigvee_{f} Q\right)^{+}$are of the form $\operatorname{conv}(p, q)$, where the edges $p \in \mathbb{F}_{v}(P)^{+}$and $q \in \mathbb{F}_{v}(Q)^{+}$ correspond to each other.

By successively enumerating the adjacent vertices in $P$ and $Q$, visible from $v$, we can assume:

$$
\begin{align*}
& \left\{x_{i}\right\}_{i=1}^{n+1}=\partial_{v}(P)^{+} \cap \operatorname{vert}(P), \\
& \left\{y_{i}\right\}_{i=1}^{n+1}=\partial_{v}(Q)^{+} \cap \operatorname{vert}(Q), \\
& \left\{\left[x_{i}, x_{i+1}\right]\right\}_{i=1}^{n}=\mathbb{F}_{v}(P)^{+} \\
& \left\{\left[y_{i}, y_{i+1}\right]\right\}_{i=1}^{n}=\mathbb{F}_{v}(P)^{+}, \\
& \left\{\operatorname{conv}\left(x_{i}, x_{i+1}, y_{i}, y_{i+1}\right)\right\}_{i=1}^{n}=\mathbb{F}_{v}(P \underset{f}{\vee} Q)^{+} . \tag{ii}
\end{align*}
$$

Consider the family of polytopes $\Pi_{i}$ and polygons $P_{i}$ and $Q_{i}$ :

$$
\begin{aligned}
\Pi_{i} & =(P \underset{f}{\vee} \operatorname{conv}(Q, v)) \bigcap \bigcap_{j=i}^{n} \operatorname{Aff}\left(x_{i}, x_{i+1}, y_{i}, y_{i+1}\right)_{v}^{-} \\
P_{i} & =\Pi_{i} \cap \operatorname{Aff}\left(x_{i}, x_{i+1}, y_{i}, y_{i+1}\right), \\
Q_{i} & =\left(P_{i} \backslash \operatorname{conv}\left(x_{i}, x_{i+1}, y_{i}, y_{i+1}\right)\right) \cup\left[x_{i}, y_{i}\right], \\
& i=1, \ldots, n .
\end{aligned}
$$

We have:

$$
\begin{aligned}
& \Pi_{1}=P \underset{f}{\vee} Q \\
& \Pi_{n} \underset{\Delta}{\subset} P \underset{f}{\vee} \operatorname{conv}(Q, v) \\
& \bar{\Pi}_{i+1} \backslash \Pi_{i}
\end{aligned}=P_{i} \underset{\left[x_{i+1}, y_{i+1}\right]}{\vee} Q_{i+1} \text { for } i=1, \ldots, n-1 .
$$

Consequently, to prove (3) it is enough to show

$$
\begin{equation*}
P_{i} \underset{\Delta}{\leq} P_{i} \underset{\left[x_{i+1}, y_{i+1}\right]}{\vee} Q_{i+1}, \quad i=1, \ldots, n-1 \tag{4}
\end{equation*}
$$

For every index $1 \leq i \leq n$, the vertices of $P_{i}$ are determined as follows:

$$
\operatorname{vert}\left(P_{i}\right)=\left\{x_{1}^{\prime}, x_{2}^{\prime}, \ldots, x_{i-1}^{\prime}, x_{i}, x_{i+1}, y_{i+1}, y_{1}^{\prime}\right\}
$$

where

$$
\begin{aligned}
x_{1}^{\prime} & =\left[x_{1}, v\right] \cap \operatorname{Aff}\left(x_{i}, x_{i+1}, y_{i}, y_{i+1}\right), \\
x_{2}^{\prime} & =\left[x_{2}, v\right] \cap \operatorname{Aff}\left(x_{i}, x_{i+1}, y_{i}, y_{i+1}\right), \\
& \cdots \cdots \cdots \cdots \\
x_{i-1}^{\prime} & =\left[x_{i-1}, v\right] \cap \operatorname{Aff}\left(x_{i}, x_{i+1}, y_{i}, y_{i+1}\right), \\
y_{1}^{\prime} & =\left[y_{1}, v\right] \cap \operatorname{Aff}\left(x_{i}, x_{i+1}, y_{i}, y_{i+1}\right) .
\end{aligned}
$$

In particular, \# vert $\left(P_{i}\right)=i+3$. Therefore, (4) follows from the following
Lemma 6.1. Assume $n \geq 2$ and (3) holds for $\# \mathbb{F}_{v}(P)^{+} \leq n-1$. If $P^{\prime}$ and $Q^{\prime}$ are polygons, $f^{\prime}=P^{\prime} \cap Q^{\prime}$ is a common edge, and $\# \operatorname{vert}\left(P^{\prime}\right) \leq n+2$ then $P^{\prime} \underset{\Delta}{\leq} P^{\prime} \vee_{f^{\prime}} Q^{\prime}$.
Proof. Let $z_{1}, \ldots, z_{k}$ be the vertices of $P^{\prime}$, enumerated in the cyclic order so that $f^{\prime}=\left[z_{1}, z_{k}\right]$. There exists a plane $H \subset \operatorname{Aff}\left(P^{\prime}, Q^{\prime}\right)$, such that

$$
\emptyset \neq Q^{\prime} \cap H \subset \partial\left(Q^{\prime}\right) \quad \text { and } \quad P^{\prime} \cap H=\left\{\begin{array}{l}
z_{l+1}, \quad \text { if } k=2 l+1 \\
{\left[z_{l}, z_{l+1}\right], \quad \text { if } k=2 l .}
\end{array}\right.
$$

To see this, pick a line $L \subset \operatorname{Aff}\left(P^{\prime}\right)$ with

$$
P^{\prime} \cap L=\left\{\begin{array}{l}
z_{l+1}, \quad \text { if } k=2 l+1 \\
{\left[z_{l}, z_{l+1}\right], \quad \text { if } k=2 l}
\end{array}\right.
$$

and start rotating the plane $\operatorname{Aff}\left(P^{\prime}\right)$ about $L$ away from $P^{\prime} \underset{f^{\prime}}{\vee} Q^{\prime}$, until it hits $\partial Q^{\prime}$ from the other side.

The plane $H$ contains an element $v^{\prime} \in \operatorname{vert}\left(Q^{\prime}\right)$. Consider the pyramid

$$
\operatorname{conv}\left(P^{\prime}, v^{\prime}\right)=P^{\prime} \underset{f^{\prime}}{ } \operatorname{conv}\left(f^{\prime}, v^{\prime}\right)
$$

It splits up the set

$$
\left(P_{f^{\prime}}^{\vee} Q^{\prime}\right) \backslash\left(P_{f^{\prime}}^{\vee} \operatorname{conv}\left(f^{\prime}, v^{\prime}\right)\right)
$$

in such a way that, for every vertex $w^{\prime} \in \operatorname{vert}\left(Q^{\prime}\right) \backslash\left\{z_{1}, z_{k}, v^{\prime}\right\}$, we have

$$
\mathbb{F}_{w^{\prime}}\left(P^{\prime}\right)^{+} \subset\left\{\begin{array}{l}
\left\{\left[z_{1}, z_{2}\right], \ldots,\left[z_{l}, z_{l+1}\right]\right\} \text { or }\left\{\left[z_{l+1}, z_{l+2}\right], \ldots\left[z_{k-1}, z_{k}\right]\right\}, \text { if } \quad k=2 l+1, \\
\left\{\left[z_{1}, z_{2}\right], \ldots,\left[z_{l-1}, z_{l}\right]\right\} \text { or }\left\{\left[z_{l+1}, z_{l+2}\right], \ldots\left[z_{k-1}, z_{k}\right]\right\}, \text { if } \quad k=2 l,
\end{array}\right.
$$

where the visibility is understood with respect to $P^{\prime} \underset{f^{\prime}}{\vee} \operatorname{conv}\left(f^{\prime}, v^{\prime}\right)$. In particular, for every vertex $w^{\prime} \in \operatorname{vert}\left(Q^{\prime}\right) \backslash\left\{z_{1}, z_{k}, v^{\prime}\right\}$, we can write

$$
\# \mathbb{F}_{w^{\prime}}\left(P^{\prime}\right)^{+} \leq\left\{\begin{array}{l}
l \leq \max (1, k-3) \leq n-1, \quad \text { if } k=2 l+1 \text { and } l \geq 1 \\
l-1 \leq k-3 \leq n-1, \quad \text { if } k=2 l \text { and } l \geq 2
\end{array}\right.
$$

Since the visibility of facets and vertices of $P^{\prime}$ does not improve when one passes from $P^{\prime} \underset{f^{\prime}}{\vee} \operatorname{conv}\left(f^{\prime}, v^{\prime}\right)$ to $P^{\prime} \underset{f^{\prime}}{\vee} Q^{\prime \prime}$ for any intermediate polytope $\operatorname{conv}\left(f^{\prime}, v^{\prime}\right) \subset Q^{\prime \prime} \subset Q^{\prime}$, the induction assumption yields the sequence of inequalities

$$
\begin{aligned}
& P^{\prime} \underset{\Delta}{\subset} \operatorname{conv}\left(P^{\prime}, v^{\prime}\right)= P^{\prime} \\
& \underbrace{\vee}_{f^{\prime}} \operatorname{conv}\left(f^{\prime}, v^{\prime}\right) \underset{\Delta}{\leq} P^{\prime} \underset{f^{\prime}}{\vee} \operatorname{conv}\left(f^{\prime}, v^{\prime}, w_{1}^{\prime}\right) \underset{\Delta}{\leq} \cdots \\
& \stackrel{\leq}{\Delta} P^{\prime} \underset{f^{\prime}}{\vee} \operatorname{conv}\left(f^{\prime}, v^{\prime}, w_{1}^{\prime}, \ldots, w_{k-3}^{\prime}\right)=P_{f^{\prime}}^{\vee} Q^{\prime}
\end{aligned}
$$

where $\left\{w_{1}^{\prime}, \ldots, w_{k}^{\prime}\right\}=\operatorname{vert}\left(Q^{\prime}\right) \backslash\left\{z_{1}, z_{k}, v^{\prime}\right\}$.

## 7. Quasi-pyramidal growth

Here we prove Theorem C, with a crucial use of Proposition 5.1.
Lemma 7.1. Let $R \subset S$ be two $(d+1)$-polytopes, sharing a vertex $w$. Then there exists a polytope $T$, for which $R \underset{\Delta}{\leq} T \subset S$ and the corner cones of $T$ and $S$ at $w$ coincide, i.e., $\mathbb{R}_{+}(T-w)+w=\mathbb{R}_{+}(S-w)+w$.

Proof. We can assume $w=0$. Fix a $d$-space $H \subset(\mathbb{R} S) \backslash\{0\}$, traversing the cone $\mathbb{R}_{+} S$ [4, Prop. 1.21]. By the assumption, there exist pyramidal extensions

$$
\mathbb{R}_{+} R \cap H=\Sigma_{0} \underset{\Delta}{\subset} \Sigma_{1} \underset{\Delta}{\subset} \cdots \underset{\Delta}{\subset} \Sigma_{m}=\mathbb{R}_{+} S \cap H
$$

Assume $\zeta_{j}=\operatorname{vert}\left(\Sigma_{j}\right) \backslash \Sigma_{j-1}$ for $j=1, \ldots, m$. For a system of real numbers

$$
0<\mu_{m} \ll \mu_{n-1} \ll \ldots \ll \mu_{1} \ll 1
$$

where $a \ll b$ means " $\frac{a}{b}$ is sufficiently small", the points $z_{j}=\mu_{j} \zeta_{j}$ satisfy the conditions:

$$
\begin{aligned}
& z_{1}, \ldots, z_{m} \in S \\
& \operatorname{vert}\left(\operatorname{conv}\left(R, z_{1}, \ldots, z_{j}\right)\right)=\operatorname{vert}(R) \cup\left\{z_{1}, \ldots, z_{j}\right\} \\
& R \subset \operatorname{conv}\left(R, z_{1}\right) \underset{\Delta}{\subset} \operatorname{conv}\left(R, z_{1}, z_{2}\right) \subset_{\Delta} \ldots \bigodot_{\Delta}^{\subset} \operatorname{conv}\left(R, z_{1}, \ldots, z_{m}\right), \\
& \mathbb{R}_{+} \operatorname{conv}\left(R, z_{1}, \ldots, z_{m}\right)=\mathbb{R}_{+} S .
\end{aligned}
$$

We can choose $T=\operatorname{conv}\left(R, z_{1}, \ldots, z_{m}\right)$.

Assume $\underset{\Delta}{\leq}$ is the inclusion order on $\operatorname{Pol}(d)$. By Lemma 4.2, it is enough to show that the conclusion of Theorem C holds for a pair of polytopes $P \subset P \underset{f}{\vee} Q^{\prime}$, where $P$ and $Q^{\prime}$ are $d$-polytopes with $f=P \cap Q^{\prime}$ a common facet.

Assume vert $\left(Q^{\prime}\right) \backslash f=\left\{v_{1}, \ldots, v_{n}\right\}$. We will induct on $n$.
For $n=1$, we are done because $P \underset{\Delta}{\leq} \operatorname{conv}\left(P, v_{1}\right)=P \vee_{f} \operatorname{conv}\left(f, v_{1}\right)$.
Put $Q=\operatorname{conv}\left(Q^{\prime}, v_{1}, \ldots, v_{n-1}\right)$ and $v=v_{n}$. Let a number $\lambda$, a projective transformation $\Phi$, and a sequence of polytopes $Q=Q_{0} \subset Q_{1} \subset Q_{2} \subset \ldots$ be as in Proposition 5.1. Assume $\Psi_{\lambda}$ is the projective transformation, used in Section 5.4, i.e., $\Psi_{\lambda}$ is the homothetic contraction of $\operatorname{Aff}(\Phi(Q \backslash f))$, centered at $\Phi(v)$ with coefficient $\lambda$, and the identity map on $\operatorname{Aff}(\Phi(P \backslash f))$.

We can assume that the polytopes $P \underset{f}{\vee} Q_{1}$ and $P \underset{f}{\vee} \operatorname{conv}(Q, v)$ have the same corner cones at every vertex from vert $(f)$ : this can be achieved by starting with $Q_{2}$ instead of $Q_{1}$, if necessary. By Lemma 7.1, iteratively applied to the elements of $\operatorname{vert}(P) \backslash f$, viewed as vertices in $\operatorname{vert}\left(P \underset{f}{\vee} Q_{1}\right) \backslash f$, we find a polytope $T$ with the properties:
(i) The corner cones of $T$ and $P \vee \underset{f}{\vee} \operatorname{conv}(Q, v)$ at every vertex of $P$ coincide;
(ii) $P \underset{f}{\vee} Q_{1} \underset{\Delta}{\leq} T \subset P \underset{f}{\vee} \operatorname{conv}(Q, v)$.

In view of the convergence (2) in Section 5.3 and the property (i) above, for any real number $\varepsilon>0$, the following inclusion is satisfied if $k \in \mathbb{N}$ is sufficiently large:

$$
\left(\Phi^{-1} \circ \Psi_{\lambda^{k}} \circ \Phi\right)(u) \in \mathrm{B}_{\varepsilon}(v), \quad u \in \operatorname{vert}(T) \backslash P
$$

where $\mathrm{B}_{\varepsilon}(v)$ stands for the $\varepsilon$-ball, centered at $v$. In particular, for any $\varepsilon>0$ and sufficiently large $k \in \mathbb{N}$, we have

$$
(P \underset{f}{\vee} \operatorname{conv}(Q, v)) \backslash \mathrm{B}_{\varepsilon}(v)=\operatorname{conv}\left(Q,\left(\Phi \circ \Psi_{\lambda^{k}} \circ \Phi\right)(T \backslash f)\right) \backslash \mathrm{B}_{\varepsilon}(v)
$$

Consequently, for any $\varepsilon>0$ and sufficiently large $k \in \mathbb{N}$ (depending on $\varepsilon$ ), we can find a pyramidal extension

$$
T^{\prime} \underset{\Delta}{\subset} P \underset{f}{\vee} \operatorname{conv}(Q, v)
$$

with the properties:

$$
\begin{equation*}
T^{\prime} \subset \operatorname{conv}\left(Q,\left(\Phi \circ \Psi_{\lambda^{k}} \circ \Phi\right)(T \backslash f)\right) \quad \text { and } \quad \mathrm{d}_{\mathrm{H}}\left(T^{\prime}, P \bigvee_{f} \operatorname{conv}(Q, v)\right)<\varepsilon \tag{5}
\end{equation*}
$$

We write

$$
\begin{aligned}
P \vee_{f} Q_{k+1}= & \operatorname{conv}\left(Q,\left(\Phi^{-1} \circ \Psi_{\lambda^{k}} \circ \Phi\right)\left(\left(P \underset{f}{\vee} Q_{1}\right) \backslash f\right)\right) \underset{\Delta}{\leq} \\
& \operatorname{conv}\left(Q,\left(\Phi \circ \Psi_{\lambda^{k}} \circ \Phi\right)(T \backslash f)\right) \underset{\mathbf{q}}{\leq} P \underset{f}{\vee} \operatorname{conv}(Q, v),
\end{aligned}
$$

where:

- the inequality $\underset{\Delta}{\leq}$ results from pushing forward the inequality $P \underset{f}{\vee_{f}} Q_{1} \underset{\Delta}{\leq} T$ in (ii) above along the composite transformation $\Phi^{-1} \circ \Psi_{\lambda^{k}} \circ \Phi$,
- the inequality $\underset{\mathrm{q}}{\leq}$ follows for the inclusion in (5) for $\varepsilon$ sufficiently small.

We also have $P \underset{f}{\vee} Q=P \underset{f}{\vee} Q_{0} \underset{\Delta}{\leq} P \bigvee_{f} Q_{k+1}$, whereas the inequality in (5) implies

$$
\delta(P, P \underset{f}{\vee} \operatorname{conv}(Q, v)) \leq \delta(P, P \underset{f}{\vee} Q)+\varepsilon
$$

Remark 7.2. The proof of Theorem $C$ shows that, for the coincidence of $\underset{\mathbf{q}}{ }$ and $\subset$ on $\operatorname{Pol}(d+1)$, it is enough to have the following 'quasi' version of Lemma 7.1: if $\underset{\mathbf{q}}{\leq}$ and $\subset$ coincide on $\operatorname{Pol}(d)$ and $R \subset S$ are two $(d+1)$-polytopes, sharing 0 as a vertex, then there exists an intermediate polytope $R \underset{\mathbf{q}}{\leq} T \subset S$, such that $\mathbb{R}_{+} T=\mathbb{R}_{+} S$. Unlike Proposition 5.1, whose proof also uses induction on dimension and goes through for $\underset{\mathrm{q}}{\leq}$, we do not know how to involve the quasi-pyramidal growth in the context of Lemma 7.1. As for the infinitesimal nature of the pyramidal defect, it is easy to show that it causes no additional challenge.
