# ANDERSON LOCALIZATION FOR LONG-RANGE OPERATORS WITH SINGULAR POTENTIALS

#### Abstract

In this paper, we use Cartan estimate for meromorphic functions to prove Anderson localization for a class of long-range operators with singular potenials.


## 1. Introduction and main result

In this paper, we study quasi-periodic operators. Start with the almost Mathieu operator

$$
\begin{equation*}
H=H_{\omega, \lambda, \theta}=\lambda \cos 2 \pi(\theta+n \omega) \delta_{n n^{\prime}}+\Delta \tag{1.1}
\end{equation*}
$$

where $\Delta$ is the lattice Laplacian on $\mathbb{Z}$

$$
\Delta\left(n, n^{\prime}\right)= \begin{cases}1, & \left|n-n^{\prime}\right|=1 \\ 0, & \left|n-n^{\prime}\right| \neq 1\end{cases}
$$

$\lambda>0$ is the coupling, $\theta \in \mathbb{T}=\mathbb{R} / \mathbb{Z}$ is the phase and $\omega \in \mathbb{R} \backslash \mathbb{Q}$ is the frequency. Jitomirskaya [11] proved that for Diophantine $\omega$ and almost every $\theta$, the almost Mathieu operator $H$ (1.1) satisfies Anderson localization for $\lambda>2$. Anderson localization means that $H$ has pure point spectrum with exponentially decaying eigenfunctions. Bourgain and Goldstein [3] proved Anderson localization for quasi-periodic Schrödinger operators

\begin{equation*}
H=H_{\omega, \lambda, \theta}=\lambda v(\theta+n \omega) \delta_{n n^{\prime}}+\Delta \tag{1.2}
\end{equation*}
$$

when $\lambda>\lambda_{0}(v)$, where $v$ is a nonconstant real analytic potential on $\mathbb{T}$. Their results is non-perturbative, which means that $\lambda_{0}$ does not depend on $\omega$. The proof was based on fundamental matrix and Lyapounov exponent.

If the Laplacian $\Delta$ is replaced by a Toeplitz operator

$$
\begin{equation*}
S_{\phi}\left(n, n^{\prime}\right)=\hat{\phi}\left(n-n^{\prime}\right) \tag{1.3}
\end{equation*}
$$

with $\phi$ real analytic, we obtain the long-range operators

$$
\begin{equation*}
H=H_{\omega, \lambda, \theta}=\lambda \cos 2 \pi(\theta+n \omega) \delta_{n n^{\prime}}+S_{\phi} \tag{1.4}
\end{equation*}
$$

Bourgain and Jitomirskaya [5] proved that there exists $\lambda_{0}(\phi)$ such that for any Diophantine $\omega$ and almost every $\theta, H$ (1.4) satisfies Anderson localization when $\lambda>\lambda_{0}$.

More generally, we can study the long-range operators of the form

$$
\begin{equation*}
H=H_{\omega}(x)=v(x+n \omega) \delta_{n n^{\prime}}+\varepsilon S_{\phi}, \tag{1.5}
\end{equation*}
$$

where $v$ is non-constant and real analytic on $\mathbb{T}$. Using Green's function estimates, Bourgain [1] proved that when $0<\varepsilon<\varepsilon_{0}=\varepsilon_{0}(v, \phi), H_{\omega}(x)$ satisfies Anderson localization for $(x, \omega) \in \mathbb{T}^{2}$ in a set of full measure. Note that in the long range case, we cannot use the fundamental matrix formalism.

Recently, using more elaborate semi-algebraic arguments, Bourgain and Kachkovskiy [6] proved Anderson localization for two interacting quasi-periodic particles. For the Anderson localization results of quasi-periodic operators on $\mathbb{Z}^{d}$, we refer to [8, 4, 2, 13].

[^0]In the cases above, the potentials $v$ are bounded functions and the operators $H$ are bounded. Now we consider quasi-periodic operators with unbounded potentials. For example, we can study the Maryland model

$$
\begin{equation*}
H=H_{\omega, \lambda, \theta}=\lambda \tan \pi(\theta+n \omega) \delta_{n n^{\prime}}+\Delta \tag{1.6}
\end{equation*}
$$

where

$$
\begin{equation*}
\theta+n \omega-\frac{1}{2} \notin \mathbb{Z}, \quad \forall n \in \mathbb{Z} \tag{1.7}
\end{equation*}
$$

For Diophantine frequencies $\omega$, the Maryland model (1.6) satisfies Anderson localization for all $\theta$ [18]. Jitomirskaya and Liu [12] proved arithmetic spectral transitions for the Maryland model. Recently, using transfer matrix and Lyapounov exponent, Jitomirskaya and Yang [15] developed a constructive method to prove Anderson localization for the Maryland model. We can also prove Anderson localization for the Maryland model with long range interactions [19].

Now we replace tan by more general singular potentials. Kachkovskiy [16] proved Anderson localization for the following class of quasi-periodic Schrödinger operators

$$
H(x)=f(x+n \omega) \delta_{n n^{\prime}}+\Delta, x \in \mathbb{R} \backslash(\mathbb{Z}+\omega \mathbb{Z})
$$

for Diophantine $\omega$ and almost everywhere $x$, where $f$ is defined on $\mathbb{R} \backslash \mathbb{Z}$, 1-periodic, continuous on $(0,1), f(0+)=-\infty, f(1-)=+\infty, \log |f| \in L^{1}(0,1)$, and Lipschitz monotone. That is, there exists $\gamma>0$ such that $f(y)-f(x) \geq \gamma(y-x)$ for all $0<x<y<1$. Jitomirskaya and Yang [14] study the singular continuous spectrum for operators of the form

$$
H_{\omega, \theta}=\frac{g(\theta+n \omega)}{f(\theta+n \omega)} \delta_{n n^{\prime}}+\Delta
$$

where $f$ is an analytic function and $g$ is Lipschitz.
In this paper, we will consider the following class of long-range operators with singular potentials

$$
\begin{equation*}
H_{\omega}(x)=\frac{g(x+n \omega)}{f(x+n \omega)} \delta_{n n^{\prime}}+\varepsilon S_{\phi} \tag{1.8}
\end{equation*}
$$

where $f, g$ are real analytic on $\mathbb{T}$. This extends the Maryland model.
We will prove the following result:
Theorem 1.1. Consider the following long-range operators with singular potentials

$$
\begin{equation*}
H_{\omega}(x)=v(x+n \omega) \delta_{n n^{\prime}}+\varepsilon S_{\phi} \tag{1.9}
\end{equation*}
$$

where $v=\frac{g}{f}, f, g$ are real analytic on $\mathbb{T}, f, v$ are nonconstant, $Z(f)=\{x \in \mathbb{T}: f(x)=0\} \neq \emptyset$. We will always assume

$$
\begin{equation*}
x+n \omega \notin Z(f), \quad \forall n \in \mathbb{Z} \tag{1.10}
\end{equation*}
$$

Assume $\omega \in D C$ (diophantine condition),

$$
\begin{equation*}
\|k \omega\|>a|k|^{-A}, \quad \forall k \in \mathbb{Z} \backslash\{0\} \tag{1.11}
\end{equation*}
$$

and $\phi$ real analytic satisfying

$$
\begin{equation*}
|\hat{\phi}(n)|<e^{-\rho|n|}, \quad \forall n \in \mathbb{Z} \tag{1.12}
\end{equation*}
$$

for some $\rho>0$. Fix $x_{0} \in \mathbb{T}$. Then there is $\varepsilon_{0}=\varepsilon_{0}(f, g, \phi)>0$, such that if $0<\varepsilon<\varepsilon_{0}$, for almost all $\omega \in D C, H_{\omega}\left(x_{0}\right)$ satisfies Anderson localization.

Our result is non-perturbative, since $\varepsilon_{0}$ does not depend on $\omega$. In the long range case here, the transfer matrix formalism is not applicable. Our basic strategy is the same as that in [1], which is based on a combination of large deviation estimates and semi-algebraic set theory. The key point is the Green's function estimates for

\begin{equation*}
G_{[0, N]}(x, E)=\left(R_{[0, N]}(H(x)-E) R_{[0, N]}\right)^{-1} \tag{1.13}
\end{equation*}
$$

where $R_{\Lambda}$ is the restriction operator to $\Lambda \subset \mathbb{Z}$. The main difficulty here is that $v$ is singular. We will first prove Cartan estimate for meromorphic functions in Section 2, then we can obtain Lojasiewicz type lemma in Section 3, which is needed for Green's function estimates in Section 4. Finally, we recall some facts about semi-algebraic sets and give the proof of Anderson localization in Section 5.

We will use the following notations. For positive numbers $a, b, a \lesssim b$ means $C a \leq b$ for some constant $C>0$. $a \ll b$ means $C$ is large. $a \sim b$ means $a \lesssim b$ and $b \lesssim a$. For $x \in \mathbb{R},\|x\|=\inf _{m \in \mathbb{Z}}|x-m|$.

## 2. CARTAN ESTIMATE FOR MEROMORPHIC FUNCTIONS

In this section, we will prove Cartan estimate for meromorphic functions. We need the following lower bounds for analytic functions.

Theorem 2.1 (Theorem 11.2 in [17]). If an analytic function $f(z)$ has no zeros in a disk $\{z \in \mathbb{C}:|z| \leq$ $R\}$ and if $|f(0)|=1$, then

$$
\log |f(z)| \geq-\frac{2 r}{R-r} \log M_{f}(R), \forall|z|=r<R
$$

where $M_{f}(R)=\max _{|z|=R}|f(z)|$.
Theorem 2.2. Take $0<R_{2}<R_{1}=R \leq 1, f(z)$ is a meromorphic function in the disk $\{z \in \mathbb{C}:|z| \leq R\}$ with neither zeros nor poles on $\{z \in \mathbb{C}:|z|=R\}$ and $|f(0)|=1$. Let $a_{1}, \ldots, a_{n}$ be the zeros of $f(z)$ in $\{z \in \mathbb{C}:|z|<R\}$ and $b_{1}, \ldots, b_{n^{\prime}}$ be the poles of $f(z)$ in $\{z \in \mathbb{C}:|z|<R\}$, where we write down each zero and pole as many times as its multiplicity. Assume $\left|b_{m}\right| \geq \delta>0,1 \leq m \leq n^{\prime}$. Given $0<H<1,0<$ $H^{\prime}<1$, then there exists a system of disks $C_{j}, C_{j^{\prime}}^{\prime}, 1 \leq j \leq n, 1 \leq j^{\prime} \leq n^{\prime}$ with radii $r_{j}=H, r_{j^{\prime}}^{\prime}=H^{\prime}$ such that the estimate

$$
\log |f(z)| \geq-\frac{2 R_{2}}{R-R_{2}} \log M_{f}(R)-n \log \frac{R+R_{2}}{H}-n^{\prime}\left[\frac{2 R}{R-R_{2}} \log \frac{1}{\delta}+\log \frac{R\left(R+R_{2}\right)}{H^{\prime}}\right]
$$

is valid in $\left\{z \in \mathbb{C}:|z| \leq R_{2}\right\}$ outside these disks.
Proof. The proof of Cartan estimate for analytic functions can be found in [17]. Following the same idea as in [17] with minor modification, we give the proof for meromorphic functions.

Let

$$
\begin{equation*}
\psi(z)=f(z)\left[\prod_{\left|b_{m}\right|<R} \frac{R\left(z-b_{m}\right)}{R^{2}-\overline{b_{m}} z}\right]\left[\prod_{\left|a_{m}\right|<R} \frac{R\left(z-a_{m}\right)}{R^{2}-\overline{a_{m} z}}\right]^{-1}\left(\prod_{\left|b_{m}\right|<R} \frac{R}{b_{m}}\right)\left(\prod_{\left|a_{m}\right|<R} \frac{a_{m}}{R}\right), \tag{2.1}
\end{equation*}
$$

then $\psi(z)$ is an analytic function without zeros in $\{z \in \mathbb{C}:|z| \leq R\}$ and $|\psi(0)|=1$. By Theorem 2.1, we have

$$
\begin{equation*}
\log |\psi(z)| \geq-\frac{2 R_{2}}{R-R_{2}} \log M_{\psi}(R), \forall|z| \leq R_{2} \tag{2.2}
\end{equation*}
$$

Hence

$$
\begin{equation*}
\log |f(z)| \geq-\frac{2 R_{2}}{R-R_{2}} \log M_{\psi}(R)+\log \prod_{\left|a_{m}\right|<R} \frac{R\left|z-a_{m}\right|}{\left|R^{2}-\overline{a_{m}} z\right|}-\log \prod_{\left|b_{m}\right|<R} \frac{R\left|z-b_{m}\right|}{\left|R^{2}-\overline{b_{m} z}\right|} \tag{2.3}
\end{equation*}
$$

$$
-\log \prod_{\left|b_{m}\right|<R} \frac{R}{\left|b_{m}\right|}-\log \prod_{\left|a_{m}\right|<R} \frac{\left|a_{m}\right|}{R}, \forall|z| \leq R_{2}
$$

Let

$$
\begin{equation*}
s_{1}=\log \prod_{\left|a_{m}\right|<R} \frac{R\left|z-a_{m}\right|}{\left|R^{2}-\overline{a_{m}} z\right|}=n \log R+\log \prod_{\left|a_{m}\right|<R}\left|z-a_{m}\right|-\log \prod_{\left|a_{m}\right|<R}\left|R^{2}-\overline{a_{m}} z\right| \tag{2.4}
\end{equation*}
$$

Since $\prod_{\left|a_{m}\right|<R}\left|z-a_{m}\right| \geq H^{n}$ outside disks $C_{j}, 1 \leq j \leq n$ with radii $r_{j}=H$, we have

$$
\begin{equation*}
s_{1} \geq n \log R+n \log H-n \log R\left(R+R_{2}\right)=-n \log \frac{R+R_{2}}{H} \tag{2.5}
\end{equation*}
$$

holds in $\left\{z \in \mathbb{C}:|z| \leq R_{2}\right\}$ outside disks $C_{j}, 1 \leq j \leq n$ with radii $r_{j}=H$.
Let

$$
\begin{equation*}
s_{2}=-\log \prod_{\left|b_{m}\right|<R} \frac{R\left|z-b_{m}\right|}{\left|R^{2}-\overline{b_{m}} z\right|}=-n^{\prime} \log R-\log \prod_{\left|b_{m}\right|<R}\left|z-b_{m}\right|+\log \prod_{\left|b_{m}\right|<R}\left|b_{m}\right|+\log \prod_{\left|b_{m}\right|<R}\left|z-\frac{R^{2}}{\overline{b_{m}}}\right| \tag{2.6}
\end{equation*}
$$

Since $\prod_{\left|b_{m}\right|<R}\left|z-\frac{R^{2}}{b_{m}}\right| \geq\left(H^{\prime}\right)^{n^{\prime}}$ outside disks $C_{j^{\prime}}^{\prime}, 1 \leq j^{\prime} \leq n^{\prime}$ with radii $r_{j^{\prime}}^{\prime}=H^{\prime}$, we have

$$
\begin{equation*}
s_{2} \geq-n^{\prime} \log R-n^{\prime} \log \left(R+R_{2}\right)+n^{\prime} \log \delta+n^{\prime} \log H^{\prime}=-n^{\prime}\left[\log \frac{1}{\delta}+\log \frac{R\left(R+R_{2}\right)}{H^{\prime}}\right] \tag{2.7}
\end{equation*}
$$

holds in $\left\{z \in \mathbb{C}:|z| \leq R_{2}\right\}$ outside disks $C_{j^{\prime}}^{\prime}, 1 \leq j^{\prime} \leq n^{\prime}$ with radii $r_{j^{\prime}}^{\prime}=H^{\prime}$.
By (2.1),

$$
\begin{equation*}
M_{\psi}(R)=M_{f}(R)\left(\prod_{\left|b_{m}\right|<R} \frac{R}{\left|b_{m}\right|}\right)\left(\prod_{\left|a_{m}\right|<R} \frac{\left|a_{m}\right|}{R}\right) \tag{2.8}
\end{equation*}
$$

Using (2.3), (2.5), (2.7), (2.8),

$$
\begin{gathered}
\log |f(z)| \geq-\frac{2 R_{2}}{R-R_{2}} \log M_{f}(R)-\frac{R+R_{2}}{R-R_{2}} \log \prod_{\left|b_{m}\right|<R} \frac{R}{\left|b_{m}\right|} \\
-\frac{R+R_{2}}{R-R_{2}} \log \prod_{\left|a_{m}\right|<R} \frac{\left|a_{m}\right|}{R}-n \log \frac{R+R_{2}}{H}-n^{\prime}\left[\log \frac{1}{\delta}+\log \frac{R\left(R+R_{2}\right)}{H^{\prime}}\right] \\
\geq-\frac{2 R_{2}}{R-R_{2}} \log M_{f}(R)-n \log \frac{R+R_{2}}{H}-n^{\prime}\left[\frac{2 R}{R-R_{2}} \log \frac{1}{\delta}+\log \frac{R\left(R+R_{2}\right)}{H^{\prime}}\right]
\end{gathered}
$$

holds in $\left\{z \in \mathbb{C}:|z| \leq R_{2}\right\}$ outside disks $C_{j}, C_{j^{\prime}}^{\prime}, 1 \leq j \leq n, 1 \leq j^{\prime} \leq n^{\prime}$ with radii $r_{j}=H, r_{j^{\prime}}^{\prime}=H^{\prime}$.

## 3. LOJASIEWICZ TYPE LEMMAS

For real analytic functions, we have the following Lojasiewicz type inequality.
Lemma 3.1 (Lemma 7.3 in [1]). Let $v_{0}$ be non-constant real analytic on $\mathbb{T}$, there is a constant $c_{0}=$ $c_{0}\left(v_{0}\right)>0$ such that

$$
\operatorname{mes}\left\{x \in \mathbb{T}:\left|v_{0}(x)-E\right|<\delta\right\}<\delta^{c_{0}}
$$

for all $E \in \mathbb{R}$ and sufficiently small $\delta>0$.
Using the Cartan estimate in Section 2, we can prove Lojasiewicz type inequality for meromorphic functions.

Lemma 3.2. Let $v=\frac{g}{f}, f, g$ are real analytic on $\mathbb{T}$, $f, v$ are nonconstant, $Z(f)=\{x \in \mathbb{T}: f(x)=0\} \neq \emptyset$. There is a constant $c_{0}=c_{0}(v)>0$ such that

$$
\operatorname{mes}\{x \in \mathbb{T}:|v(x)-E|<\varepsilon\}<\varepsilon^{c_{0}}
$$

for all $E \in \mathbb{R}$ and sufficiently small $\varepsilon>0$.
Proof. Consider a covering $[0,1] \subset \cup_{l=1}^{m}\left(p_{l}-r_{l}, p_{l}+r_{l}\right)$, where $0<\left|v^{\prime}\left(p_{l}\right)\right|<\infty$. By Theorem 2.2, $\left\{x \in\left(p_{l}-r_{l}, p_{l}+r_{l}\right):\left|v^{\prime}(x)\right| \leq \varepsilon^{\frac{1}{2}}\right\}$ is contained in a union of at most $C$ intervals of total measure at most $C \varepsilon^{c}$, where $C=C(v), c=c(v)$. Hence

$$
\begin{gathered}
\operatorname{mes}\{x \in \mathbb{T}:|v(x)-E|<\varepsilon\} \leq \operatorname{mes}\left\{x \in \mathbb{T}:\left|v^{\prime}(x)\right| \leq \varepsilon^{\frac{1}{2}}\right\} \\
+\operatorname{mes}\left\{x \in \mathbb{T}:|v(x)-E|<\varepsilon,\left|v^{\prime}(x)\right|>\varepsilon^{\frac{1}{2}}\right\} \leq C \varepsilon^{c}+C \varepsilon^{\frac{1}{2}}<\varepsilon^{c_{0}} .
\end{gathered}
$$

By Lemma 3.1, Lemma 3.2, we have
Lemma 3.3. Let $v, f, g$ as in Lemma 3.2 there is a constant $c=c(f, g)>0$ such that

$$
\operatorname{mes}\{x \in \mathbb{T}:|g(x)-E f(x)|<\varepsilon\}<\varepsilon^{c}
$$

for all $E \in \mathbb{R}$ and sufficiently small $\varepsilon>0$.
Proof.

$$
\begin{aligned}
& \operatorname{mes}\{x \in \mathbb{T}:|g(x)-E f(x)|<\varepsilon\} \leq \operatorname{mes}\left\{x \in \mathbb{T}:|g(x)-E f(x)|<\varepsilon,|f(x)| \geq \varepsilon^{\frac{1}{2}}\right\} \\
& \quad+\operatorname{mes}\left\{x \in \mathbb{T}:|f(x)|<\varepsilon^{\frac{1}{2}}\right\} \leq \operatorname{mes}\left\{x \in \mathbb{T}:|v(x)-E|<\varepsilon^{\frac{1}{2}}\right\}+\varepsilon^{c_{0}}<\varepsilon^{c}
\end{aligned}
$$

We introduce the uniform Lojasiewicz inequality.
Lemma 3.4 (Lemma 6.1 in [9]). We denote by $C_{r}^{\omega}(\mathbb{T}, \mathbb{R})$ the Banach space of real analytic functions with continuous extension to $A_{r}=\{z \in \mathbb{C}: 1-r<|z|<1+r\}$ and norm $\|f\|_{r}=\sup _{z \in A_{r}}|f(z)|$. Let $0 \neq f \in C_{r}^{\omega}(\mathbb{T}, \mathbb{R})$. Then there are constants $\delta=\delta(f)>0, S=S(f)>0, b=b(f)>0$ such that if $g \in C_{r}^{\omega}(\mathbb{T}, \mathbb{R})$ with $\|g-f\|_{r}<\delta$, then

$$
\operatorname{mes}\{x \in \mathbb{T}:|g(x)|<t\}<S t^{b}, \forall t>0
$$

Now, we can prove the following lemma.
Lemma 3.5. Let $f, g$ as in Lemma 3.2 there is a constant $c=c(f, g)>0$ such that

$$
\operatorname{mes}\left\{x \in \mathbb{T}: \frac{1}{\sqrt{1+E^{2}}}|g(x)-E f(x)|<\varepsilon\right\}<\varepsilon^{c}
$$

for all $E \in \mathbb{R}$ and sufficiently small $\varepsilon>0$.
Proof. If $E>0$, consider

$$
\begin{equation*}
s_{1}=\left\|-\frac{1}{\sqrt{1+E^{2}}} g+\frac{E}{\sqrt{1+E^{2}}} f-f\right\|_{r} \leq \frac{\|f\|_{r}+\|g\|_{r}}{\sqrt{1+E^{2}}} \tag{3.1}
\end{equation*}
$$

Since $\forall E \geq C_{1}=C_{1}(f, g)>0, s_{1}<\delta(f)$, by Lemma3.4,

$$
\begin{equation*}
\operatorname{mes}\left\{x \in \mathbb{T}: \frac{1}{\sqrt{1+E^{2}}}|g(x)-E f(x)|<\varepsilon\right\}<S \varepsilon^{b}, \forall E \geq C_{1} \tag{3.2}
\end{equation*}
$$

If $E<0$, consider

$$
\begin{equation*}
s_{2}=\left\|\frac{1}{\sqrt{1+E^{2}}} g-\frac{E}{\sqrt{1+E^{2}}} f-f\right\|_{r} \leq \frac{\|f\|_{r}+\|g\|_{r}}{\sqrt{1+E^{2}}} \tag{3.3}
\end{equation*}
$$

Since $\forall E \leq-C_{1}, s_{2}<\delta(f)$, by Lemma 3.4 ,

$$
\begin{equation*}
\operatorname{mes}\left\{x \in \mathbb{T}: \frac{1}{\sqrt{1+E^{2}}}|g(x)-E f(x)|<\varepsilon\right\}<S \varepsilon^{b}, \forall E \leq-C_{1} . \tag{3.4}
\end{equation*}
$$

This proves Lemma3.5 for $|E| \geq C_{1}$. If $|E| \leq C_{1}$, Lemma 3.5 follows from Lemma3.3

## 4. Green's function estimates

In this section, we will prove Green's function estimates for

$$
\begin{equation*}
G_{N}(x, E)=\left(R_{[0, N)}(H(x)-E) R_{[0, N)}\right)^{-1} \tag{4.1}
\end{equation*}
$$

where

$$
\begin{equation*}
H(x)=v(x+n \omega) \delta_{n n^{\prime}}+\varepsilon S_{\phi} \tag{4.2}
\end{equation*}
$$

with the potential $v=\frac{g}{f}, f, g$ are real analytic on $\mathbb{T}, f, v$ are nonconstant, $Z(f)=\{x \in \mathbb{T}: f(x)=0\} \neq \emptyset$ and $\phi$ real analytic satisfying

$$
\begin{equation*}

## 5. Proof of Anderson localization

In this section, we give the proof of Anderson localization as in [3].
We first recall some basic facts of semi-algebraic sets . Let

$$
\mathscr{P}=\left\{P_{1}, \ldots, P_{s}\right\} \subset \mathbb{R}\left[X_{1}, \ldots, X_{n}\right]
$$

be a family of real polynomials whose degrees are bounded by $d$. A semi-algebraic set is given by

S=\bigcup_{j} \bigcap_{l \in L_{j}}\left\{\mathbb{R}^{n}: P_{l} s_{j l} 0\right\} \tag{5.1}
\end{equation*}

where $L_{j} \subset\{1, \ldots, s\}, s_{j l} \in\{\leq, \geq,=\}$ are arbitrary. We say that $S$ has degree at most $s d$ and its degree is the inf of $s d$ over all representations as in (5.1).

We need the following quantitative version of the Tarski-Seidenberg principle.
Proposition 5.1 ([7]). Let $S \subset \mathbb{R}^{n}$ be a semi-algebraic set of degree $B$, then any projection of $S$ is semi-algebraic of degree at most $B^{C}, C=C(n)$.

Next fact deals with the intersection of a semi-algebraic set of small measure and the orbit of a diophantine shift.

Proposition 5.2 (Corollary 9.7 in [1]). Let $S \subset[0,1]^{n}$ be semi-algebraic of degree $B$ and $\operatorname{mes}_{n} S<\eta$. Let $\omega \in \mathbb{T}^{n}$ satisfy a $D C$ and

\log B \ll \log N \ll \log \frac{1}{\eta} .
$$

Then for any $x_{0} \in \mathbb{T}^{n}$,

\#\left\{k=1, \ldots, N: x_{0}+k \omega \in S\right\}<N^{1-\delta}

for some $\delta=\delta(\omega)>0$.
We will make essential use of the following transversality property.
Lemma 5.3 (Lemma 9.9 in [1]). Let $S \subset[0,1]^{2 n}$ be a semi-algebraic set of degree $B$ and $\operatorname{mes}_{2 n} S<$ $\eta, \log B \ll \log \frac{1}{\eta}$. We denote $(\omega, x) \in[0,1]^{n} \times[0,1]^{n}$ the product variable and $\left\{e_{j}: 0 \leq j \leq n-1\right\}$ the $\omega$-coordinate vectors. Fix $\varepsilon>\eta^{\frac{1}{2 n}}$. Then there is a decomposition $S=S_{1} \cup S_{2}, S_{1}$ satisfying

\operatorname{mes}_{n}\left(\operatorname{Proj}_{\omega} S_{1}\right)<B^{C} \varepsilon
$$

and $S_{2}$ satisfying the transversality property

for any $n$-dimensional hyperplane $L$ such that $\max _{0 \leq j \leq n-1}\left|\operatorname{Proj}_{L}\left(e_{j}\right)\right|<\frac{\varepsilon}{100}$.
By application of the resolvent identity, we have the following
Lemma 5.4. Let $I \subset \mathbb{Z}$ be an interval of size $N$ and $\left\{I_{\alpha}\right\}$ subintervals of size $M=N^{\tau}, \tau>0$ is small. Assume $\forall k \in I$, there is some $\alpha$ such that

\begin{equation*}
\left|G_{I_{\alpha}}\left(n_{1}, n_{2}\right)\right|<e^{-c_{0}\left(\left|n_{1}-n_{2}\right|-\left(\kappa+\varepsilon_{0}^{\delta}\right) M\right)}, \quad n_{1}, n_{2} \in I_{\alpha} . \tag{5.3}
\end{equation*}
$$

Then

$$
\begin{gather*}
\left|G_{I}\left(n_{1}, n_{2}\right)\right|<2 e^{c_{0}\left(\kappa+\varepsilon_{0}^{\delta}\right) M}, \quad n_{1}, n_{2} \in I,  \tag{5.4}\\
\left|G_{I}\left(n_{1}, n_{2}\right)\right|<e^{-\frac{1}{2} c_{0}\left|n_{1}-n_{2}\right|}, \quad n_{1}, n_{2} \in I,\left|n_{1}-n_{2}\right|>\frac{N}{10} . \tag{5.5}
\end{gather*}
$$

Proof. For $m, n \in I$, there is some $\alpha$ such that

\left[m-\frac{M}{4}, m+\frac{M}{4}\right] \cap I \subset I_{\alpha} . \tag{5.6}
\end{equation*}

By resolvent identity,

\left|G_{I}(m, n)\right| \leq e^{c_{0}\left(\kappa+\varepsilon_{0}^{\delta}\right) M}+\sum_{m_{1} \in I_{\alpha}, m_{2} \notin I_{\alpha}}\left|G_{I_{\alpha}}\left(m, m_{1}\right)\right| e^{-\rho\left|m_{1}-m_{2}\right|}\left|G_{I}\left(m_{2}, n\right)\right| . \tag{5.7}
\end{equation*}
$$

If $\left|m_{1}-m\right| \leq \frac{M}{8}$, then $\left|m_{1}-m_{2}\right| \geq \frac{M}{8}$, hence

\sum_{\left|m_{1}-m\right| \leq \frac{M}{8}, m_{2} \notin I_{\alpha}}\left|G_{I_{\alpha}}\left(m, m_{1}\right)\right| e^{-\rho\left|m_{1}-m_{2}\right|}<M e^{-\rho \frac{M}{8}} e^{c_{0}\left(\kappa+\varepsilon_{0}^{\delta}\right) M}<\frac{1}{4} . \tag{5.8}
\end{equation*}
$$

If $\left|m_{1}-m\right|>\frac{M}{8}$, then

$$
\begin{equation*}
\sum_{\left|m_{1}-m\right|>\frac{M}{8}, m_{2} \notin I_{\alpha}}\left|G_{I_{\alpha}}\left(m, m_{1}\right)\right| e^{-\rho\left|m_{1}-m_{2}\right|}<M e^{-c_{0} \frac{M}{8}} e^{c_{0}\left(\kappa+\varepsilon_{0}^{\delta}\right) M}<\frac{1}{4} . \tag{5.9}
\end{equation*}
$$

By 5.7), (5.8), 5.9),

$$
\begin{equation*}
\max _{m, n \in I}\left|G_{I}(m, n)\right|<e^{c_{0}\left(\kappa+\varepsilon_{0}^{\delta}\right) M}+\frac{1}{2} \max _{m, n \in I}\left|G_{I}(m, n)\right| . \tag{5.10}
\end{equation*}
$$

(5.4) follows from (5.10).

Take $m, n \in I,|m-n|>\frac{N}{10}$, assume (5.6), by resolvent identity,

\left|G_{I}(m, n)\right| \leq \sum_{n_{0} \in I_{\alpha}, n_{1} \notin I_{\alpha}}\left|G_{I_{\alpha}}\left(m, n_{0}\right)\right| e^{-\rho\left|n_{0}-n_{1}\right|}\left|G_{I}\left(n_{1}, n\right)\right|  \tag{5.11}\\
\leq M e^{c_{0}\left(\kappa+\varepsilon_{0}^{\delta}\right) M} \sum_{\left|m-n_{1}\right|>\frac{M}{4}} e^{-c_{0}\left|m-n_{1}\right|}\left|G_{I}\left(n_{1}, n\right)\right| \\
\leq M^{t} N^{t} e^{t c_{0}\left(\kappa+\varepsilon_{0}^{\delta}\right) M} e^{-c_{0}\left(\left|m-n_{1}\right|+\cdots+\left|n_{t-1}-n_{t}\right|\right)}\left|G_{I}\left(n_{t}, n\right)\right|,
\end{gather*}
$$

where $t \leq 10 \frac{N}{M},\left|m-n_{1}\right|>\frac{M}{4}, \ldots,\left|n_{t-1}-n_{t}\right|>\frac{M}{4}$.
If $\left|n-n_{t}\right| \leq M$, then by 5.4, (5.11,

\left|G_{I}(m, n)\right| \leq M^{t} N^{t} e^{t c_{0}\left(\kappa+\varepsilon_{0}^{\delta}\right) M} e^{-c_{0}(|m-n|-M)} 2 e^{c_{0}\left(\kappa+\varepsilon_{0}^{\delta}\right) M} \leq e^{20 c_{0}\left(\kappa+\varepsilon_{0}^{\delta}\right) N-c_{0}|m-n|}<e^{-\frac{1}{2} c_{0}|m-n|} \tag{5.12}
\end{equation*}
$$

If $t=10 \frac{N}{M}$, then by (5.4), (5.11),
(5.13) $\left|G_{I}(m, n)\right| \leq M^{t} N^{t} e^{t c_{0}\left(\kappa+\varepsilon_{0}^{\delta}\right) M} e^{-t c_{0} \frac{M}{4}} 2 e^{c_{0}\left(\kappa+\varepsilon_{0}^{\delta}\right) M} \leq e^{40 c_{0}\left(\kappa+\varepsilon_{0}^{\delta}\right) N-\frac{5}{2} c_{0} N}<e^{-2 c_{0} N}<e^{-c_{0}|m-n|}$. (5.5) follows from (5.12), 5.13). This proves Lemma 5.4

Now we can prove the main result.
Theorem 5.5. Consider the following long-range operators with singular potentials

where $v=\frac{g}{f}, f, g$ are real analytic on $\mathbb{T}, f, v$ are nonconstant, $Z(f)=\{x \in \mathbb{T}: f(x)=0\} \neq \emptyset$. Assume $\omega \in D C$ (diophantine condition),

\|k \omega\|>a|k|^{-A}, \quad \forall k \in \mathbb{Z} \backslash\{0\} \tag{5.15}
\end{equation*}

and $\phi$ real analytic satisfying

|\hat{\phi}(n)|<e^{-\rho|n|}, \quad \forall n \in \mathbb{Z} \tag{5.16}
\end{equation*}
$$

for some $\rho>0$. Fix $x_{0} \in \mathbb{T}$. Then there is $\varepsilon_{0}=\varepsilon_{0}(f, g, \phi)>0$, such that if $0<\varepsilon<\varepsilon_{0}$, for almost all $\omega \in D C, H_{\omega}\left(x_{0}\right)$ satisfies Anderson localization.

Proof. By Shnol's theorem [10], to establish Anderson localization, it suffices to show that if $\xi=$ $\left(\xi_{n}\right)_{n \in \mathbb{Z}}, E \in \mathbb{R}$ satisfy

H\left(x_{0}\right) \xi=E \xi \tag{5.18}

\left|\xi_{n}\right|<e^{-c|n|}, \quad|n| \rightarrow \infty . \tag{5.19}
\end{equation*}
$$

By Proposition 4.3, there is $\Omega=\Omega_{N}(E) \subset \mathbb{T}$, mes $\Omega<e^{-c N^{\sigma}}$, such that if $x \notin \Omega$, then for some $|m|<\sqrt{N}$,

\left|G_{[-N, N]}(x+m \omega, E)\left(n_{1}, n_{2}\right)\right|<e^{-c_{0}\left(\left|n_{1}-n_{2}\right|-\left(\kappa+\varepsilon_{0}^{\delta}\right) N\right)}, \quad\left|n_{1}\right|,\left|n_{2}\right| \leq N \tag{5.20}
\end{equation*}
$$

As in Section 4,

$$
\begin{equation*}
\left|G_{[-N, N]}(x+m \omega, E)\left(n_{1}, n_{2}\right)\right|=\frac{\left|f\left(x+m \omega+n_{2} \omega\right)\right|}{\sqrt{1+E^{2}}}\left|B_{[-N, N]}(x+m \omega, E)^{-1}\left(n_{1}, n_{2}\right)\right| \tag{5.21}
\end{equation*}
$$

Truncate power series for $f, g$ in 5.21, $\Omega$ may be assumed semi-algebraic of degree at most $N^{8}$. Let $N_{1}=N^{C_{1}}, C_{1}$ is a sufficiently large constant. Then by Proposition5.2,

\#\left\{|j| \leq N_{1}: x_{0}+j \omega \in \Omega\right\}<N_{1}^{1-\delta_{1}}, \quad \delta_{1}>0 \tag{5.22}
\end{equation*}
$$

Using (5.22), we may find an interval $I \subset\left[0, N_{1}\right]$ of size $N$ such that

x_{0}+j \omega \notin \Omega, \quad \forall j \in I \cup(-I) \tag{5.23}
\end{equation*}

Then for some $\left|m_{j}\right|<\sqrt{N}$,

\left|G_{[a, b]}\left(x_{0}, E\right)\left(n_{1}, n_{2}\right)\right|<e^{-c_{0}\left(\left|n_{1}-n_{2}\right|-\left(\kappa+\varepsilon_{0}^{\delta}\right) N\right)}, \quad n_{1}, n_{2} \in[a, b] \tag{5.24}
\end{equation*}
$$

where $[a, b]=\left[j+m_{j}-N, j+m_{j}+N\right]$. By 5.17), (5.18), (5.24),

$$
\begin{equation*}
\left|\xi_{j}\right| \leq C \sum_{n \in[a, b], n^{\prime} \notin[a, b]} e^{-c_{0}\left(|j-n|-\left(\kappa+\varepsilon_{0}^{\delta}\right) N\right)} e^{-\rho\left|n-n^{\prime}\right|}\left|n^{\prime}\right| \leq C N_{1} e^{c_{0}\left(\kappa+\varepsilon_{0}^{\delta}\right) N} e^{-\frac{c_{0}}{2} N}<e^{-\frac{c_{0}}{3} N} \tag{5.25}
\end{equation*}
$$

Let $j_{0}$ be the center of $I$, we have

$$
\begin{equation*}
1=\xi_{0} \leq\left\|G_{\left[-j_{0}, j_{0}\right]}\left(x_{0}, E\right)\right\|\left\|R_{\left[-j_{0}, j_{0}\right]} H\left(x_{0}\right) R_{\mathbb{Z} \backslash\left[-j_{0}, j_{0}\right]} \xi\right\| \tag{5.26}
\end{equation*}
$$

For $|n| \leq j_{0}$, by 5.25],

$$
\begin{gather*}
\left|\left(R_{\left[-j_{0}, j_{0}\right]} H\left(x_{0}\right) R_{\mathbb{Z} \backslash\left[-j_{0}, j_{0}\right]} \xi\right)_{n}\right| \leq \sum_{\left|n^{\prime}\right|>j_{0}} e^{-\rho\left|n-n^{\prime}\right|}\left|\xi_{n^{\prime}}\right|  \tag{5.27}\\
\leq \sum_{j_{0}<\left|n^{\prime}\right| \leq j_{0}+\frac{N}{2}} e^{-\rho\left|n-n^{\prime}\right|} e^{-\frac{c_{0}}{3} N}+C \sum_{\left|n^{\prime}\right|>j_{0}+\frac{N}{2}} e^{-\rho\left|n-n^{\prime}\right|}\left|n^{\prime}\right|<C e^{-\frac{c_{0}}{3} N}+C N_{1} e^{-\rho \frac{N}{3}}<e^{-\frac{c_{0}}{4} N} .
\end{gather*}
$$

By (5.26), 5.27),

\left\|G_{\left[-j_{0}, j_{0}\right]}\left(x_{0}, E\right)\right\|>e^{\frac{c_{0}}{5} N} \tag{5.28}
\end{equation*}

\operatorname{dist}\left(E, \operatorname{spec} H_{\left[-j_{0}, j_{0}\right]}\left(x_{0}\right)\right)<e^{-\frac{c_{0}}{5} N} \tag{5.29}

Denote

\mathscr{E}_{\omega}=\bigcup_{|j| \leq N_{1}} \operatorname{spec} H_{[-j, j]}\left(x_{0}\right) \tag{5.30}
\end{equation*}

It follows from (5.29) that if $x \notin \bigcup_{E^{\prime} \in \mathscr{E}_{\omega}} \Omega\left(E^{\prime}\right)$, then for some $|m|<\sqrt{N}$,

\left|G_{[-N, N]+m}(x, E)\left(n_{1}, n_{2}\right)\right|<e^{-c_{0}\left(\left|n_{1}-n_{2}\right|-\left(\kappa+\varepsilon_{0}^{\delta}\right) N\right)}, \quad n_{1}, n_{2} \in[-N, N]+m \tag{5.31}
\end{equation*}
$$

Let $N_{2}=N^{C_{2}}, C_{2}$ is a sufficiently large constant. Suppose

x_{0}+n \omega \notin \bigcup_{E^{\prime} \in \mathscr{E}_{\omega}} \Omega\left(E^{\prime}\right), \quad \forall \sqrt{N_{2}}<|n|<2 N_{2}, \tag{5.32}
\end{equation*}
$$

then by (5.31), there are $\left|m_{n}\right|<\sqrt{N}$ such that

\begin{equation*}
\left|G_{[-N, N]+n+m_{n}}\left(x_{0}, E\right)\left(n_{1}, n_{2}\right)\right|<e^{-c_{0}\left(\left|n_{1}-n_{2}\right|-\left(\kappa+\varepsilon_{0}^{\delta}\right) N\right)}, \quad n_{1}, n_{2} \in[-N, N]+n+m_{n} \tag{5.33}
\end{equation*}
$$

Let $\Lambda=\underset{\sqrt{N_{2}}<n<2 N_{2}}{ }\left([-N, N]+n+m_{n}\right) \supset\left[\sqrt{N_{2}}, 2 N_{2}\right]$. By Lemma5.4

\left|G_{\Lambda}\left(x_{0}, E\right)\left(n_{1}, n_{2}\right)\right|<2 e^{c_{0}\left(\kappa+\varepsilon_{0}^{\delta}\right) N}, \quad n_{1}, n_{2} \in \Lambda,  \tag{5.34}\\
\left|G_{\Lambda}\left(x_{0}, E\right)\left(n_{1}, n_{2}\right)\right|<e^{-\frac{c_{0}}{2}\left|n_{1}-n_{2}\right|}, \quad n_{1}, n_{2} \in \Lambda,\left|n_{1}-n_{2}\right|>\frac{N_{2}}{10} . \tag{5.35}
\end{gather*}
$$

For $\frac{1}{2} N_{2} \leq j \leq N_{2}$, by (5.34), (5.35),

\begin{gather*}
\left|\xi_{j}\right| \leq C \sum_{n \in \Lambda, n^{\prime} \notin \Lambda}\left|G_{\Lambda}\left(x_{0}, E\right)(j, n)\right| e^{-\rho\left|n-n^{\prime}\right|}\left|n^{\prime}\right|  \tag{5.36}\\
\leq C N_{2} \sum_{|n-j|>\frac{N_{2}}{10}} e^{-\frac{c_{0}}{2}|n-j|}+C N_{2}^{2} e^{c_{0}\left(\kappa+\varepsilon_{0}^{\delta}\right) N} e^{-\rho \frac{N_{2}}{4}} \leq e^{-\frac{c_{0}}{50} N_{2}} \leq e^{-\frac{c_{0}}{50} j}
\end{gather*}
$$

Now we need to prove (5.32). Consider for $|j| \leq N_{1}$, the set $S_{j} \subset \mathbb{T}^{2} \times \mathbb{R}$ of $\left(\omega, x, E^{\prime}\right)$ where

\|k \omega\|>a|k|^{-A}, \quad \forall 0<|k| \leq N,  \tag{5.37}\\
x \in \Omega\left(E^{\prime}\right)  \tag{5.38}\\
E^{\prime} \in \operatorname{spec} H_{[-j, j]}\left(x_{0}\right) \tag{5.39}
\end{gather*}
$$

Let

$$
\begin{equation*}
S=\operatorname{Proj}_{\mathbb{T}^{2}} S_{j} \tag{5.40}
\end{equation*}
$$

Since $\operatorname{mes} \Omega\left(E^{\prime}\right)<e^{-c N^{\sigma}}$,

$$
\begin{equation*}
\operatorname{mes} S<N_{1} e^{-c N^{\sigma}}<e^{-c N^{\frac{\sigma}{2}}} \tag{5.41}
\end{equation*}
$$

Since $S_{j}$ is a semi-algebraic set of degree at most $N_{1}^{10}$, by Proposition 5.1 $S$ is a semi-algebraic set of degree at most $N_{1}^{10 C}$.

Take $n=1, B=N_{1}^{10 C}, \eta=e^{-c N^{\frac{\sigma}{2}}}, \varepsilon=N_{2}^{-\frac{1}{10}}$ in Lemma 5.3, we have $S=S_{1} \cup S_{2}$,

$$
\begin{equation*}
\operatorname{mesProj}_{\omega} S_{1}<B^{C} \varepsilon<N_{1}^{C} N_{2}^{-\frac{1}{10}}<N_{2}^{-\frac{1}{\Pi}} \tag{5.42}
\end{equation*}
$$

We study the intersection of $S_{2}$ and sets

$$
\begin{equation*}
\left\{\left(\omega, x_{0}+n \omega\right): \omega \in[0,1]\right\}, \quad \sqrt{N_{2}}<|n|<2 N_{2} \tag{5.43}
\end{equation*}
$$

where $x_{0}+n \omega$ are considered mod 1. (5.43) lies in the parallel lines

$$
\begin{equation*}
L=L_{m}^{(n)}=\left[\omega=\frac{x}{n}\right]-\frac{m+x_{0}}{n} e_{\omega}, \quad|m|<N_{2} . \tag{5.44}
\end{equation*}
$$

Since $\left|\operatorname{Proj}_{L} e_{\omega}\right|<\frac{\varepsilon}{100}$, by Lemma 5.3,

$$
\begin{equation*}
\operatorname{mes}\left(S_{2} \cap L\right)<B^{C} \varepsilon^{-1} \eta^{\frac{1}{2}}<N_{1}^{C} N_{2}^{\frac{1}{10}} e^{-\frac{1}{2} c N^{\frac{\sigma}{2}}} \tag{5.45}
\end{equation*}
$$

Summing over $n, m$,

$$
\begin{equation*}
\operatorname{mes}\left\{\omega \in[0,1]:\left(\omega, x_{0}+n \omega\right) \in S_{2}, \exists \sqrt{N_{2}}<|n|<2 N_{2}\right\}<N_{2}^{2} N_{1}^{C} N_{2}^{\frac{1}{10}} e^{-\frac{1}{2} c N^{\frac{\sigma}{2}}}<e^{-c N^{\frac{\sigma}{4}}} \tag{5.46}
\end{equation*}
$$

From (5.42), (5.46), we exclude an $\omega$-set of measure $N_{2}^{-\frac{1}{11}}+e^{-c N^{\frac{\sigma}{4}}}<N_{2}^{-\frac{1}{12}}$. Summing over $|j| \leq N_{1}$, we get an $\omega$-set $\mathscr{R}_{N}$, mes $\mathscr{R}_{N}<N_{2}^{-\frac{1}{13}}<N^{-10}$, such that for $\omega \notin \mathscr{R}_{N}$,

\left|\xi_{j}\right|<e^{-\frac{c_{0}}{50}|j|}, \quad \forall|j| \in\left[\frac{1}{2} N^{C_{2}}, N^{C_{2}}\right] . \tag{5.47}

\mathscr{R}=\bigcap_{N_{0} \geq 1} \bigcup_{N \geq N_{0}} \mathscr{R}_{N} \tag{5.48}
\end{equation*}
$$

then mes $\mathscr{R}=0$. If $\omega \notin \mathscr{R}$, then by (5.48), there is $N_{0} \geq 1$ such that $\omega \notin \mathscr{R}_{N}, \forall N \geq N_{0}$. By (5.47),

\begin{equation*}
\left|\xi_{j}\right|<e^{-\frac{c_{0}}{50}|j|}, \quad \forall|j| \in \bigcup_{N \geq N_{0}}\left[\frac{1}{2} N^{C_{2}}, N^{C_{2}}\right]=\left[\frac{1}{2} N_{0}^{C_{2}}, \infty\right) \tag{5.49}
\end{equation*}
$$

This proves 5.19) and Theorem 5.5
