# On Dimensions, Standard Part Maps, and p-Adically Closed Fields

#### Abstract

The aim of this paper is to study the dimensions and standard part maps between the field of $p$-adic numbers $\mathbb{Q}_{p}$ and its elementary extension $K$ in the language of rings $L_{r}$.

We show that for any $K$-definable set $X \subseteq K^{m}, \operatorname{dim}_{K}(X) \geq \operatorname{dim}_{\mathbb{Q}_{p}}\left(X \cap \mathbb{Q}_{p}^{m}\right)$. Let $V \subseteq K$ be convex hull of $K$ over $\mathbb{Q}_{p}$, and st : $V \rightarrow \mathbb{Q}_{p}$ be the standard part map. We show that for any $K$-definable function $f: K^{m} \rightarrow K$, there is definable subset $D \subseteq \mathbb{Q}_{p}^{m}$ such that $\mathbb{Q}_{p}^{m} \backslash D$ has no interior, and for all $x \in D$, either $f(x) \in V$ and $\operatorname{st}\left(f\left(\mathrm{st}^{-1}(x)\right)\right)$ is constant, or $f\left(\mathrm{st}^{-1}(x)\right) \cap V=\emptyset$.

We also prove that $\operatorname{dim}_{K}(X) \geq \operatorname{dim}_{\mathbb{Q}_{p}}\left(\operatorname{st}\left(X \cap V^{m}\right)\right)$ for every definable $X \subseteq$ $K^{m}$ 。


## 1 Introduction

In [15], L. van den Dries consider a pair $(R, V)$, where $R$ is an $o$-minimal extension of a real closed field, and $V$ is a convex hull of an elementary submodel $M$ of $R$. Let $\mu \subseteq R$ be the set infinitesimals over $M$ and $\hat{V}=V / \mu$ be the reside field with residue class map $x \mapsto \hat{x}$. If $M$ is Dedekind complete in $R$, then $\hat{V}=M$ and the residue class map coincide the standard part map st : $R \longrightarrow M$. In this context, van den Dries showed the follows:

Theorem 1. [15] Let $S \subseteq R^{n}$ be $R$-definable and $\hat{S}=\left\{\hat{x} \mid x \in S \cap V^{n}\right\}$. Then
(i) $S \cap M^{n}$ is definable in $M$ and $\operatorname{dim}_{M}\left(S \cap M^{n}\right) \leq \operatorname{dim}_{R}(S)$;
(ii) $\operatorname{st}(S)$ is definable in $M$ and $\operatorname{dim}_{M}(\operatorname{st}(S)) \leq \operatorname{dim}_{R}(S)$.

Theorem 2. [15] Let $f: R^{m} \rightarrow R$ be an $R$-definable function. Then here is a finite partition $\mathcal{P}$ of $M^{m}$ into definable sets, where each set in the partition is either open in $M^{m}$ or lacks of interior. On each open set $C \in \mathcal{P}$ we have:
(i) either $f(x) \notin V$ for all $x \in C^{h}$;
(ii) or there is a continuous function $g: C \longrightarrow M$, definable in $M$, such that $f(x) \in V$ and $\operatorname{st}(f(x))=g(\operatorname{st}(x))$, for all $x \in C^{h}$,
where $C^{h}$ is the hull of $C$ defined by

$$
C^{h}=\left\{\bar{x} \in R^{m} \mid \exists \bar{y} \in C\left(\bigwedge_{i=1}^{m}\left(x_{i}-y_{i} \in \mu\right)\right)\right\}
$$

Remark 1.1. For any topological space $Y$, and $X \subseteq Y$, by $\operatorname{Int}(X)$ we mean the set of interiors in $X$. Namely, $x \in \operatorname{Int}(X)$ iff there is an open neighborhood $B \subseteq Y$ of $x$ contained in $X$.

There are fairly good analogies between the field of reals $\mathbb{R}$ and the field of $p$-adic numbers $\mathbb{Q}_{p}$, in both model-theoretic and field-theoretic view. For example, both of them are complete and locally compact topological fields, are distal and dp-minimal structures, have quantifier eliminations with adding the new predicates for $n$-th power, and have cell decompositions.

In this paper, we treat the $p$-adic analogue of above two Theorems, where $M$ is replaced by $\mathbb{Q}_{p}$, and $R$ is replaced by an arbitrary elementary extension $K$ of $\mathbb{Q}_{p}$. In our case, the convex hull $V$ is the set

$$
\{x \in K \mid x=0 \vee \exists n \in \mathbb{Z}(v(x)>n)\}
$$

and $\mu$, the infinitesimals of $K$ over $\mathbb{Q}_{p}$, is the set

$$
\{x \in K \mid x=0 \vee \forall n \in \mathbb{Z}(v(x)>n)\} .
$$

By Lemma 2.1 in [11], for every $x \in V$, there is a unique element $\operatorname{st}(x)$ in $\mathbb{Q}_{p}$ such that $a-\operatorname{st}(a) \in \mu$, we call it the standard part of $a$ and st : $a \mapsto \operatorname{st}(a)$ the standard part map. It is easy to see that st : $V \longrightarrow \mathbb{Q}_{p}$ is a surjective ring homomorphism and $\mathrm{st}^{-1}(0)=\mu$. So $\hat{V}=V / \mu$ is isomorphic to $\mathbb{Q}_{p}$ in our context. With the notations as above, we now highlight our main results.

Theorem 1.2. Let $S \subseteq K^{n}$ be $K$-definable. Then
(i) $S \cap \mathbb{Q}_{p}^{n}$ is definable in $\mathbb{Q}_{p}$ and $\operatorname{dim}_{\mathbb{Q}_{p}}\left(S \cap \mathbb{Q}_{p}^{n}\right) \leq \operatorname{dim}_{K}(S)$;
(ii) $\operatorname{st}\left(S \cap V^{n}\right)$ is definable in $\mathbb{Q}_{p}$ and $\operatorname{dim}_{\mathbb{Q}_{p}}\left(\operatorname{st}\left(S \cap V^{n}\right)\right) \leq \operatorname{dim}_{K}(S)$.

Theorem 1.3. Let $f: K^{m} \rightarrow K$ be an $K$-definable function. Then here is a finite partition $\mathcal{P}$ of $\mathbb{Q}_{p}$ into definable sets, where each set in the partition is either open in $\mathbb{Q}_{p}^{m}$ or lacks of interior. On each open set $C \in \mathcal{P}$ we have:
(i) either $f(x) \notin V$ for all $x \in C^{h}$;
(ii) or there is a continuous function $g: C \longrightarrow \mathbb{Q}_{p}$, definable in $\mathbb{Q}_{p}$, such that $f(x) \in V$ and $\operatorname{st}(f(x))=g(\operatorname{st}(x))$, for all $x \in C^{h}$.

In the rest of this introduction we give more notations and model-theoretic approach.

### 1.1 Notations

Let $p$ denote a fixed prime number, $\mathbb{Q}_{p}$ the field the $p$-adic field, and $v: \mathbb{Q}_{p} \backslash\{0\} \rightarrow \mathbb{Z}$ is the valuation map. Let $K$ be a fixed elementary extension of $\mathbb{Q}_{p}$. Then valuation $v$ extends to a valuation map from $K \backslash\{0\}$ to $\Gamma_{K}$, we also denote it by $v$, where $\left(\Gamma_{K},+,<\right.$ $, 0)$ is the corresponding elementary extension of $(\mathbb{Z},+,<, 0)$.

Fact 1.4. Let $v: K \backslash\{0\} \longrightarrow \Gamma_{K}$ be as above. Then we have

- $v(x y)=v(x)+v(y)$ for all $x, y \in K$;
- $v(x+y) \geq \min \{v(x), v(y)\}$, and $v(x+y)=\min \{v(x), v(y)\}$ if $v(x) \neq v(y)$;
- For $x \in \mathbb{Q}_{p},|x|=p^{-v(x)}$ if $x \neq 0$ and $|x|=0$ if $x=0$ defines a non-archimedean metric on $\mathbb{Q}_{p}$.
- $K$ is a non-archimedean topological field.

We will assume a basic knowledge of model theory. Good references are [12] and [9]. We will be referring a lot to the comprehensive survey [1] for the basic model theory of the p-adics. A key point is Macintyres theorem [8] that $\operatorname{Th}\left(\mathbb{Q}_{p},+, \times, 0,1\right)$ has quantifier elimination in the language $L=L_{r} \cup\left\{P_{n} \mid n \in \mathbb{N}^{+}\right\}$, where $L_{r}$ is the language of rings, and the predicate $P_{n}$ is interpreted as the $n$-th powers

$$
\left\{y \in \mathbb{Q}_{p} \mid y \neq 0 \wedge \exists x\left(y=x^{n}\right)\right\}
$$

for each $n \in \mathbb{N}^{+}$. Note that $P_{n}$ is definable in $L_{r}$. Moreover, the valuation is definable in $L_{r}$ as follows.

Fact 1.5. [3] Let $f, g \in K\left[x_{1}, \ldots, x_{m}\right]$. Then $\left\{\bar{a} \in K^{m} \mid v(f(\bar{a})) \leq v(g(\bar{a}))\right\}$ is definable.
Remark 1.6. It is easy to see from Fact 1.5 that $\{a \in K \mid v(a)=\gamma\}$ and $\{a \in K \mid v(a)<$ $\gamma\}$ are definable for any fixed $\gamma \in \Gamma_{K}$.

For $A$ a subset of $K$, by an $L_{A}$-formula we mean a formula with parameters from $A$. By $\bar{x}, \bar{y}, \bar{z}$ we mean arbitrary $n$-variables and $\bar{a}, \bar{b}, \bar{c} \in K^{n}$ denote $n$-tuples in $K^{n}$ with $n \in \mathbb{N}^{+}$. By $|\bar{x}|$, we mean the length of the tuple $\bar{x}$. We say that $X \subseteq K^{m}$ is $A$-definable if there is a $L_{A}$-formula $\phi\left(x_{1}, \ldots, x_{m}\right)$ such that

$$
X=\left\{\left(a_{1}, \ldots, a_{m}\right) \in K^{m} \mid K \models \phi\left(a_{1}, \ldots, a_{m}\right)\right\} .
$$

We also denote $X$ by $\phi\left(K^{m}\right)$ and say that $X$ is defined by $\phi(\bar{x})$. We say that $X$ is definable in $K$ if $X \subseteq K^{m}$ is $K$-definable. If $X \in \mathbb{Q}_{p}^{m}$ is defined by some $L_{\mathbb{Q}_{p}}$-formula $\psi(\bar{x})$. Then by $X(K)$ we mean $\psi\left(K^{m}\right)$, namely, the realizations of $\psi$ in $K$, which is a definable subset of $K^{m}$.

For any subset $A$ of $K$, by $\operatorname{acl}(A)$ we mean the algebraic closure of $A$. Namely, $b \in \operatorname{acl}(A)$ if and only if there is a formula $\phi(x)$ with parameters from $A$ such that $b \in \phi(K)$ and $\phi(K)$ is finite. Let $\alpha=\left(\alpha_{1}, \ldots, \alpha_{n}\right) \in K^{m}$, we denote $\operatorname{acl}\left(A \cup\left\{\alpha_{1}, \ldots, \alpha_{n}\right\}\right)$ by $\operatorname{acl}(A, \alpha)$.

By a saturated extension $\mathbb{K}$ of $K$, we mean that $|\mathbb{K}|$ is a sufficiently large cardinality, and every type over $A \subseteq \mathbb{K}$ is realized in $\mathbb{K}$ whenever $|A|<|\mathbb{K}|$.

### 1.2 Preliminaries

The $p$-adic field $\mathbb{Q}_{p}$ is a complete, locally compact topological field, with basis given by the sets

$$
B_{(a, n)}=\left\{x \in \mathbb{Q}_{p} \mid x=a \wedge v(x-a) \geq n\right\}
$$

for $a \in \mathbb{Q}_{p}$ and $n \in \mathbb{Z}$. The elementary extension $K \succ \mathbb{Q}_{p}$ is also a topological field but not need to be complete or locally compact. Let $X \subseteq K^{m}$, we say that $\bar{a} \in X$ is an interior if there is $\gamma \in \Gamma_{k}$ such that

$$
B_{(\bar{b}, \gamma)}=\left\{\left(b_{1}, \ldots, b_{m}\right) \in \mathbb{K} \mid \bigwedge_{i=1}^{n} v\left(a_{i}-b_{i}\right)>\gamma\right\} \subseteq X
$$

Let $V=\{x \in K \mid x=0 \vee \exists n \in \mathbb{Z}(v(x)>n)\}$. We call $V$ the convex hull of $\mathbb{Q}_{p}$. It is easy to see that for any $a, b \in K$, if $b \in V$ and $v(a)>v(b)$, then $a \in V$. As we said before, for every $a \in V$, there is a unique $a_{0} \in \mathbb{Q}_{p}$ such that $v\left(a-a_{0}\right)>n$ for all $n \in \mathbb{Z}$. This gives a map $a \mapsto a_{0}$ from $V$ onto $\mathbb{Q}_{p}$. We call this map the standard part map, denoted by st : $V \longrightarrow \mathbb{Q}_{p}$. For any $\bar{a}=\left(a_{1}, \ldots, a_{m}\right) \in V^{m}$, by st $(\bar{a})$ we mean (st $\left.\left(a_{1}\right), \ldots, \operatorname{st}\left(a_{m}\right)\right)$. Let $f(\bar{x}) \in K[\bar{x}]$ be a polynomial with every coefficient contained in $V$. Then by st $(f)$, we mean the polynomial over $\mathbb{Q}_{p}$ obtained by replace each coefficient of $f$ by its standard part. Let

$$
\mu=\{a \in K \mid \operatorname{st}(a)=0\},
$$

which is the collection of all infinitesimals of $K$ over $\mathbb{Q}_{p}$. It is easy to see that for any $a \in K \backslash\{0\}, a \notin V$ iff $a^{-1} \in \mu$.

Any definable subset $X \subseteq K^{n}$ has a topological dimension which is defined as follows:
Definition 1.7. Let $X \subseteq K^{n}$. By $\operatorname{dim}_{K}(X)$, we mean the maximal $k \leq n$ such that the image of the projection

$$
\pi: X \longrightarrow K^{k} ; \quad\left(x_{1}, \ldots, x_{n}\right) \mapsto\left(x_{r_{1}}, \ldots, x_{r_{k}}\right)
$$

has interiors, for suitable $1 \leq r_{1}<\ldots<r_{k} \leq n$. We call $\operatorname{dim}_{K}(X)$ the topological dimension of $X$.

Recall that $\mathbb{Q}_{p}$ is a geometry structure (see Definition 2.1 and Proposition 2.11 of [7] ), so any $K \models \operatorname{Th}\left(\mathbb{Q}_{p}\right)$ is a geometry structure. The fields has geometric structure are certain fields in which model-theoretic algebraic closure equals field-theoretic algebraic closure.

Every geometry structure is a pregeometry structure, which means that for any $\bar{a}=\left(a_{1}, \ldots, a_{n}\right) \in K^{n}$ and $A \subseteq K, \operatorname{dim}(\bar{a} / A)$ makes sense, which by definition is the maximal $k$ such that $a_{r_{1}} \notin \operatorname{acl}(A)$ and $a_{r_{i+1}} \notin \operatorname{acl}\left(A, a_{r_{1}}, \ldots, a_{r_{i}}\right)$ for some subtuple $\left(a_{r_{1}}, \ldots, a_{r_{k}}\right)$ of $\bar{a}$. We call $\operatorname{dim}(\bar{a} / A)$ the algebraic dimension of $\bar{a}$ over $A$.

Fact 1.8. [7] Let $A$ be a subset of $K$ and $X$ an $A$-definable subset of $K^{m}$.
(i) If $\bar{a} \in K^{m}$ and $\bar{b} \in K^{n}$. Then we have

$$
\operatorname{dim}(\bar{a}, \bar{b} / A)=\operatorname{dim}(\bar{a} / A, \bar{b})+\operatorname{dim}(\bar{b} / A)=\operatorname{dim}(\bar{b}, \bar{a} / A)
$$

(ii) Let $\mathbb{K} \succ K$ be a saturated model. Then $\operatorname{dim}_{K}(X)=\max \{\operatorname{dim}(\bar{a} / A) \mid \bar{a} \in X(\mathbb{K})\}$.
(iii) Let $\phi\left(x_{1}, \ldots, x_{m}, y_{1}, \ldots, y_{n}\right)$ be any $L_{A}$-formula and $r \in \mathbb{N}$. Then the set

$$
\left\{\bar{b} \in K^{n} \mid \operatorname{dim}_{K}\left(\phi\left(K^{m}, \bar{b}\right)\right) \leq r\right\}
$$

is A-definable.
(iv) If $X \subseteq K$ is $K$-definable. Then $X$ is infinite iff $\operatorname{dim}_{K}(X) \geq 1$.
(v) Let $A_{0}$ be a countable subset of $\mathbb{Q}_{p}$, and let $Y$ be an $A_{0}$-definable subset of $\mathbb{Q}_{p}^{n}$. Then there is $\bar{a}_{0} \in Y$ such that $\operatorname{dim}\left(\bar{a}_{0} / A_{0}\right)=\operatorname{dim}_{\mathbb{Q}_{p}}(Y)$.

It is easy to see from Fact 1.8 that for any $L_{K}$-formula $\phi\left(x_{1}, \ldots, x_{n}\right)$ and $K^{\prime} \succ K$, we have

$$
\operatorname{dim}_{K}\left(\phi\left(K^{n}\right)\right)=\operatorname{dim}_{K^{\prime}}\left(\phi\left(K^{\prime n}\right)\right) .
$$

We will write $\operatorname{dim}_{K}(X)$ by $\operatorname{dim}(X)$ if there is no ambiguity. If the function $f: X \longrightarrow K$ is definable in $K$, and $Y \subseteq X \times K$ is the graph of $f$. Then we conclude directly that $\operatorname{dim}(X)=\operatorname{dim}(Y)$ by Fact 1.8 (ii).

For later use, we recall some well-known facts and terminology.
Hensel's Lemma. Let $\mathbb{Z}_{p}=\left\{x \in \mathbb{Q}_{p} \mid x=0 \vee v(x) \geq 0\right\}$ be the valuation ring of $\mathbb{Q}_{p}$. Let $f(x)$ be a polynomial over $\mathbb{Z}_{p}$ in one variable $x$, and let $a \in \mathbb{Z}_{p}$ such that $v(f(a))>2 n+1$ and $v\left(f^{\prime}(a)\right) \leq n$, where $f^{\prime}$ denotes the derivative of $f$. Then there exists a unique $\hat{a} \in \mathbb{Z}_{p}$ such that

$$
f(\hat{a})=0 \text { and } v(\hat{a}-a) \geq n+1 .
$$

We say a field $E$ is a Henselian field if Hensel's Lemma holds in $E$. Note that to be a henselian field is a first-order property of a field in the language of rings. Namely, there is a $L_{r}$-sentence $\sigma$ such that $E \models \sigma$ iff $E$ is a henselian field. So any $K \succ \mathbb{Q}_{p}$ is henselian.

## 2 Main results

### 2.1 Some Properties of Henselian Fields

Since $\mathbb{Q}_{p}$ is complete and local compact, it is easy to see that:
Fact 2.1. Suppose that $E$ is a finite (or algebraic) field extension of $\mathbb{Q}_{p}$. Then for any $\alpha \in E \backslash \mathbb{Q}_{p}$, there is $n \in \mathbb{Z}$ such that $v(\alpha-a)<n\left(|\alpha-a|>p^{-n}\right)$ for all $a \in \mathbb{Q}_{p}$. Namely, $\mathbb{Q}_{p}$ is closed in $E$.

We now show that Fact 2.1 holds for any $K \models \operatorname{Th}\left(\mathbb{Q}_{p}\right)$.
Lemma 2.2. Let $K$ be a henselian field, $R=\{x \in K \mid x=0 \vee v(x) \geq 0\}$ be the valuation ring of $K$, and $f(x) \in R[x]$ a polynomial, $D \subseteq \Gamma_{K}$ a cofinal subset, and $X=\left\{x_{d} \mid d \in D\right\} \subseteq R$. If

$$
\lim _{d \in D, d \rightarrow+\infty} f\left(x_{d}\right)=0
$$

Then there exist a cofinal subset $I \subseteq D$ and $a \in K$ such that

$$
\lim _{i \in I, i \rightarrow+\infty} x_{i}=a \text { and } f(a)=0
$$

Proof. Induction on $\operatorname{deg}(f)$. Suppose that $f$ has degree 1, say, $f(x)=\alpha x+\beta$. Then for any $\gamma \in \Gamma_{K}$, there is $d_{0} \in D$ such that $v\left(f\left(x_{d}\right)\right)>\gamma$ for all $d_{0}<d \in D$. Now $v\left(\alpha x_{d}+\beta\right)>\gamma$ implies that $v\left(x_{d}-\left(-\frac{\beta}{\alpha}\right)\right)>\gamma-v(\alpha)$. So

$$
\lim _{d \in D, d \rightarrow+\infty}\left|x_{d}-\left(-\frac{\beta}{\alpha}\right)\right|=0
$$

and hence

$$
\lim _{d \in D, d \rightarrow+\infty} x_{d}=-\frac{\beta}{\alpha} \text { and } f\left(-\frac{\beta}{\alpha}\right)=0
$$

as required.
Now suppose that $\operatorname{deg}(f)=n+1>1$. We see that the derivative $f^{\prime}$ has degree $n$.
If there are $\gamma_{0} \in \Gamma_{K}$ and $\varepsilon_{0} \in D$ such that $v\left(f^{\prime}\left(x_{\varepsilon}\right)\right) \leq \gamma_{0}$ for all $\varepsilon_{0}<\varepsilon \in D$. Take $\varepsilon_{0}$ sufficiently large such that

$$
v\left(f\left(x_{\varepsilon}\right)\right)>4 \gamma_{0}+1
$$

for all $\varepsilon_{0}<\varepsilon \in D$. Then, by Hensel's Lemma, we see that for all $\varepsilon>\varepsilon_{0}$, there is $\hat{x}_{\varepsilon}$ such that

$$
v\left(\hat{x}_{\varepsilon}-x_{\varepsilon}\right) \geq \frac{v\left(f\left(x_{\varepsilon}\right)\right)-1}{2} \text { and } f\left(\hat{x}_{\varepsilon}\right)=0
$$

As $f$ has at most finitely many roots, there is a cofinal subset $I \subseteq D$ and some $\hat{x}_{\varepsilon} \in K$ such that

$$
v\left(\hat{x}_{\varepsilon}-x_{i}\right)>\frac{v\left(f\left(x_{i}\right)\right)-1}{2}
$$

for all $i \in I$. Since $v\left(f\left(x_{i}\right)\right) \rightarrow+\infty$, we see that $v\left(\hat{x}_{\varepsilon}-x_{i}\right) \rightarrow+\infty$. Thus we have

$$
\lim _{i \in I, i \rightarrow+\infty} x_{i}=\hat{x}_{\varepsilon} \text { and } f\left(\hat{x}_{\varepsilon}\right)=0
$$

as required.
Otherwise, if for every $\gamma \in \Gamma_{K}$, there is $\gamma<d_{\gamma} \in D$ such that $v\left(f^{\prime}\left(x_{d_{\gamma}}\right)\right)>\gamma$. Then there is a cofinal subset $I=\left\{d_{\gamma} \mid \gamma \in \Gamma_{K}\right\} \subseteq D$ such that

$$
\lim _{i \in I, i \rightarrow+\infty} f^{\prime}\left(x_{i}\right)=0
$$

Then, by induction hypothesis, there exist a cofinal subset $J \subseteq I$ and $b \in K$ such that

$$
\lim _{j \in J, j \rightarrow+\infty} x_{j}=b \text { and } f^{\prime}(b)=0
$$

Since $f$ is continuous, $\lim _{j \in J, j \rightarrow+\infty} f\left(x_{j}\right)=f(b)$. Now $J$ is cofinal in $I$, and $I$ is cofinal in $D$, we conclude that $J$ is cofinal in $D$. This complete the proof.

Proposition 2.3. If $K$ is a henselian field, and $E$ is a finite extension of $K$. Then for any $\alpha \in E \backslash K$, there is $\gamma_{0} \in \Gamma_{K}$ such that $v(\alpha-a)<\gamma_{0}$ for all $a \in K$. Namely, $K$ is closed in $E$.

Proof. By ([5], Lemma 4.1.1), the valuation of $K$ extends uniquely to $E$. For each $\beta \in E$, Let $g(x)=x^{n}+a_{n-1} x^{n-1}+\ldots+a_{1} x+a_{0}$ be the minimal polynomial of $\beta$ over $K$, then the valuation of $\beta$ is exactly $\frac{v\left(a_{0}\right)}{n}$ (See [6], Prop. 5.3.4).

Let $\alpha \in E \backslash K$, and $d(x)$ be the minimal polynomial of $\alpha$ over $K$ with degree $k$. Then $d(x+a)$ is the minimal polynomial of $(\alpha-a)$ over $K$ for any $a \in K$. Since $d(x+a)=x f(x)+d(a)$ for some $f(x) \in K[x]$, we see that $v(\alpha-a)=\frac{v(d(a))}{k}$. We claim that there is $\gamma_{0} \in \Gamma_{K}$ such that $v(d(a))<\gamma_{0}$ for all $a \in K$. Otherwise, we will find a sequence $\left\{a_{\gamma} \mid \gamma \in \Gamma_{K}\right\}$ such that $v\left(d\left(a_{\gamma}\right)\right)>\gamma$. Replace $d(x)$ by $\epsilon d(x)$ with some $\epsilon$ sufficiently close to 0 , we may assume that $d \in R[x]$. Moreover, fix $\gamma_{0} \in \Gamma$, if $v(\alpha-a)>\gamma_{0}$, and $v(\alpha-b)>2 \gamma_{0}$, then $v(a-b) \geq \gamma_{0}$. So

$$
\left\{b \in K \mid v(\alpha-b)>\gamma_{0}\right\} \subseteq \delta_{0} R
$$

for some $\delta_{0} \in K$, and hence

$$
\left\{b \in K \mid v(d(b))>\gamma_{0}\right\}=\left\{b \in K \mid k v(\alpha-b)>\gamma_{0}\right\} \subseteq k \delta_{0} R .
$$

Let $\delta=k \delta_{0}$. If $\delta \in R$, then, by Lemma [2.2, there is $b \in K$ such that $d(b)=0$. However $d$ is minimal polynomial of degree $>1$, so has no roots in $K$. A contradiction.

If $\delta \notin R$, then $\delta^{-1} \in R$. Suppose that

$$
d(x)=d_{k} x^{k}+\ldots+d_{1} x+d_{0} .
$$

Let

$$
h(x)=d_{k} x^{k}+\ldots+d_{1} \delta^{-k+1} x+d_{0} \delta^{-k} .
$$

We see that $h(x) \in R[x]$ and

$$
h\left(\delta^{-1} x\right)=d_{k}\left(\delta^{-1} x\right)^{k}+\ldots+d_{1} \delta^{-k+1}\left(\delta^{-1} x\right)+d_{0} \delta^{-k}=\delta^{-k} d(x)
$$

Now we have

$$
v\left(h\left(\delta^{-1} a_{\gamma}\right)\right)=v\left(\delta^{-k} d\left(a_{\gamma}\right)\right)>\gamma-k v(\delta) .
$$

For $\gamma>\gamma_{0}$, we have $a_{\gamma} \in \delta R$. Therefore $\delta^{-1} a_{\gamma} \in R$ for all $\gamma>\gamma_{0}$. Applying Lemma 2.2 to $h(x)$, we can find $c \in K$ such that

$$
h(c)=h\left(\delta^{-1} \delta c\right)=0=\delta^{-k} d(\delta c) .
$$

So $d(\delta c)=0$. A contradiction.
Now we assume that $K$ is an elementary extension of $\mathbb{Q}_{p}$ in the language of rings $L_{r}$. This follow result was proven by [13] in the case of $K=\mathbb{Q}_{p}$.
Lemma 2.4. Let $\bar{x}=\left(x_{1}, \ldots, x_{m}\right)$ and $f(\bar{x}, y)=\sum_{i=0}^{n} p_{i}(\bar{x}) y^{i} \in K[\bar{x}, y]$. Then there is a partition of

$$
R=\left\{\bar{x} \in K^{m} \mid \bigvee_{i=0}^{n} p_{i}(\bar{x}) \neq 0 \wedge \exists y(f(\bar{x}, y)=0)\right\}
$$

into finitely many definable subsets $S$, over each of which $f$ has some fixed number $k \geq 1$ of distinct roots in $K$ with fixed multiplicities $m_{1}, \ldots, m_{k}$. For any fixed $\bar{x}_{0} \in S$, let the roots of $f\left(\bar{x}_{0}, y\right)$ be $r_{1}, \ldots, r_{k}$, and $e=\max \left\{v\left(r_{i}-r_{j}\right) \mid 1 \leq i<j \leq k\right\}$. Then $\bar{x}_{0}$ has a neighborhood $N \subseteq K^{m}, \gamma \in \Gamma_{K}$, and continuous, definable functions $F_{1}, \ldots, F_{k}$ : $S \cap N \longrightarrow K$ such that for each $\bar{x} \in S \cap N, F_{1}(\bar{x}), \ldots, F_{k}(\bar{x})$ are roots of $f(\bar{x}, y)$ of multiplicities $m_{1}, \ldots, m_{k}$ and $v\left(F_{i}(\bar{x})-r_{i}\right)>2 e$.

Proof. The proof of Lemma 1.1 in [13] applies almost word for word to the present context. The only problem is that the authors used Fact 2.1 in their proof. But the Proposition 2.3 saying that we could replace $\mathbb{Q}_{p}$ by arbitrary $K \models \operatorname{Th}\left(\mathbb{Q}_{p}\right)$ in our argument.

Remark 2.5. Lemma 1.1 of [13] saying that definable functions $F_{1}, \ldots, F_{k}$ are not only continuous but analytic. However we can't proof it in arbitrary $K \models \operatorname{Th}\left(\mathbb{Q}_{p}\right)$ as $K$ might not be complete as a topological field.

Similarly, Lemma 1.3 in [13] could be generalized to arbitrary $K \models \operatorname{Th}\left(\mathbb{Q}_{p}\right)$ as follows:

Lemma 2.6. If $A \subseteq K^{m}$ and $f: A \longrightarrow K$ is definable. Then there is a definable set $B \subseteq A$, open in $K^{m}$ such that $A \backslash B$ has no interior and $f$ is continuous on $B$.

Proof. The proof of Lemma 1.3 in [13] applies almost word for word to the present context.

### 2.2 Dimensions

We now assume that $K$ is an elementary extension of $\mathbb{Q}_{p}$.
Lemma 2.7. Suppose that $A \subseteq K, X, Y$ are $A$-definable in $K, f: X \longrightarrow Y$ is an A-definable function. If $f$ is a finite-to-one map, $\operatorname{dim}(X)=\operatorname{dim}(f(X))$.

Proof. Let $\mathbb{K}$ be a saturated elementary extension of $K$. By Fact 1.8 (iii), there is $r \in \mathbb{N}$ such that $\left|f^{-1}(y)\right| \leq r$ for all $y \in Y(\mathbb{K})$. For any $a \in X(\mathbb{K})$, since

$$
|\{b \in X \mid f(b)=f(a)\}| \leq r,
$$

we see that $a \in \operatorname{acl}(A, f(a))$. So $\operatorname{dim}(a / A, f(a))=0$. By Fact 1.8 (i) we have

$$
\operatorname{dim}(a / A)=\operatorname{dim}(a, f(a) / A)=\operatorname{dim}(a / A, f(a))+\operatorname{dim}(f(a) / A)=0+\operatorname{dim}(f(a) / A)
$$

So $\operatorname{dim}(a / A)=\operatorname{dim}(f(a) / A)$. By Fact 1.8 (ii), we conclude that $\operatorname{dim}(X)=\operatorname{dim}(Y)$.
Lemma 2.8. Suppose that $A \subseteq K, f: X \longrightarrow Y$ is an $A$-definable function in $K$. Then

$$
\operatorname{dim}(X) \geq \operatorname{dim}(f(X))
$$

Proof. Generally, we have

$$
\operatorname{dim}(a / A)=\operatorname{dim}(a, f(a) / A)=\operatorname{dim}(a / A, f(a))+\operatorname{dim}(f(a) / A) \geq \operatorname{dim}(f(a) / A)
$$

By Fact 1.8 (ii), we conclude that $\operatorname{dim}(X) \geq \operatorname{dim}(Y)$.
Corollary 2.9. Suppose that $A \subseteq K, f: X \longrightarrow Y$ is an $A$-definable bijection function in K. Then

$$
\operatorname{dim}(X)=\operatorname{dim}(f(X))
$$

Proof. $f^{-1}$ is a definable function as $f$ is bijection. So we conclude that

$$
\operatorname{dim}(X) \geq \operatorname{dim}(f(X))=\operatorname{dim}(Y) \geq \operatorname{dim}\left(f^{-1}(Y)\right)=\operatorname{dim}(X)
$$

Lemma 2.10. Suppose that $X, Y$ are $A$-definable in $K$. Then

$$
\operatorname{dim}(X \cup Y)=\max \{\operatorname{dim}(X), \operatorname{dim}(Y)\}
$$

Proof. By Fact 1.8 (ii).
Lemma 2.11. Let $X \subseteq K^{n}$. Then $\operatorname{dim}(X)$ is the minimal $k \leq n$ such that there is definable $Y \subseteq X$ with $\operatorname{dim}(Y)=\operatorname{dim}(X)$ and projection

$$
\pi: X \longrightarrow K^{k} ; \quad\left(x_{1}, \ldots, x_{n}\right) \mapsto\left(x_{r_{1}}, \ldots, x_{r_{k}}\right)
$$

is a finite-to-one map on $Y$, for suitable $1 \leq r_{1}<\ldots<r_{k} \leq n$.
Proof. Let $k$ be as above and $\pi: X \longrightarrow K^{k}$ be a projection with $\pi\left(x_{1}, \ldots, x_{n}\right)=$ $\left(x_{r_{1}}, \ldots, x_{r_{k}}\right)$. If $Y \subseteq X$ such that the restriction $\pi \upharpoonright Y: Y \longrightarrow K^{k}$ is a finite-to-one map. Then by Lemma 2.7 we have $\operatorname{dim}(Y)=\operatorname{dim}(\pi(Y))$ and hence

$$
\operatorname{dim}(X)=\operatorname{dim}(Y)=\operatorname{dim}(\pi(Y)) \leq k
$$

Now suppose that $\operatorname{dim}(X)=l \leq k$. Without loss of generality, we assume that $f: X \longrightarrow K^{l} ;\left(x_{1}, \ldots, x_{n}\right) \mapsto\left(x_{1}, \ldots, x_{l}\right)$ is a projection such that $f(X)$ has nonempty interior. We claim that

Claim. Let $Z_{0}=\left\{b \in K^{l} \mid f^{-1}(b)\right.$ is finite $\}$ and $Z_{1}=K^{l} \backslash Z_{0}$. Then $\operatorname{dim}\left(Z_{1}\right)<l$.
Proof. Clearly,

$$
Z_{1}=\left\{b \in K^{l} \mid \operatorname{dim}\left(f^{-1}(b)\right) \geq 1\right\}
$$

is definable in $K$. If $\operatorname{dim}\left(Z_{1}\right)=l$. Then, there is $\beta \in Z_{1}(\mathbb{K})$ such that $\operatorname{dim}(\beta / A)=l$, where is $\mathbb{K} \succ K$ is saturated. Since $\operatorname{dim}\left(f^{-1}(\beta)\right) \geq 1$, by Fact 1.8 (ii), there is $\alpha \in$ $\operatorname{dim}\left(f^{-1}(\beta)\right)$ such that $\operatorname{dim}(\alpha / A, \beta) \geq 1$. By Fact 1.8 (i), we conclude that

$$
\operatorname{dim}(\alpha / A)=\operatorname{dim}(\alpha, f(\alpha) / A)=\operatorname{dim}(a / A, f(\alpha))+\operatorname{dim}(f(\alpha) / A) \geq l+1
$$

But $\operatorname{dim}(\alpha / A) \leq \operatorname{dim}(X)=l$. A contradiction.
Since $\operatorname{dim}\left(Z_{1}\right)<l$, by Lemma 2.10, $\operatorname{dim}\left(Z_{0}\right)=l$. The restriction of $f$ on $f^{-1}\left(Z_{0}\right)$ is a finite-to-one map, we conclude that

$$
\operatorname{dim}\left(f^{-1}\left(Z_{0}\right)\right)=\operatorname{dim}\left(Z_{0}\right)=l=\operatorname{dim}(X)
$$

by Lemma 2.7. Now $\operatorname{dim}\left(f^{-1}\left(Z_{0}\right)\right)=\operatorname{dim}(X)$ and the restriction of $f$ on $f^{-1}\left(Z_{0}\right)$ is a finite-to-one map. So $k \leq l$ as $k$ is minimal. We conclude that $k=l=\operatorname{dim}(X)$ as required.

Corollary 2.12. Let $X \subseteq K^{n}$ be definable with $\operatorname{dim}(X)=k$. Then there exists $a$ partition of $X$ into finitely many $K$-definable subsets $S$ such that whenever $\operatorname{dim}(S)=$ $\operatorname{dim}(X)$, there is a projection $\pi_{S}: S \longrightarrow K^{k}$ on $k$ suitable coordinate axes which is finite-to-one.

Proof. Let $X_{0}=X$ and $[n]^{k}$ be the set of all subset of $\{1, \ldots, n\}$ of cardinality $k$. By Lemma 2.11, there exist $D_{0}=\left\{r_{1}, \ldots, r_{k}\right\} \in[n]^{k}, S_{0} \subseteq X$ with $\operatorname{dim}\left(S_{0}\right)=\operatorname{dim}\left(X_{0}\right)$, such that the projection

$$
\pi:\left(x_{1}, \ldots, x_{n}\right) \mapsto\left(x_{r_{1}}, \ldots, x_{r_{k}}\right)
$$

is finite-to-one on $S_{0}$ and infinite-to-one on $X_{0} \backslash S_{0}$. If $\operatorname{dim}\left(X_{0} \backslash S_{0}\right)<\operatorname{dim}\left(X_{0}\right)$, then the partition $\left\{X_{0} \backslash S_{0}, S_{0}\right\}$ meets our requirements.

Otherwise, let $X_{1}=X_{0} \backslash S_{0}$, we could find $D_{1} \in[n]^{k} \backslash\left\{D_{0}\right\}$ and $S_{1} \in X_{1}$ such that the projection on coordinate axes from $D_{1}$ is finite-to-one over $S_{1}$. Repeating the above steps, we obtained sequences $X_{i}$ and $S_{i}$ such that $X_{i+1}=X_{i} \backslash S_{i}$. As $[n]^{k}$ is finite, there is a minimal $t \in \mathbb{N}$ such that $\operatorname{dim}\left(X_{t}\right)<\operatorname{dim}\left(X_{0}\right)$ and $\operatorname{dim}\left(S_{i}\right)=\operatorname{dim}\left(X_{0}\right)$ for all $i<t$. It is easy to see that $\left\{S_{0}, \ldots, S_{t-1}, X_{t}\right\}$ meets our requirements.

Recall that by [14], $\operatorname{Th}\left(\mathbb{Q}_{p}\right)$ admits definable Skolem functions. Namely, we have
Fact 2.13. 14] Let $A \subseteq K$ and $\phi(\bar{x}, y)$ be a $L_{A}$-formula such that

$$
K \models \forall \bar{x} \exists y \phi(\bar{x}, y) .
$$

Then there $A$-definable function $f: K^{m} \rightarrow K$ such that $K \models \forall \bar{x} \phi(\bar{x}, f(\bar{x}))$.
With the above Fact, we could refine Corollary 2.12 as follows:
Corollary 2.14. Let $X \subseteq K^{n}$ be definable with $\operatorname{dim}(X)=k$. Then there exists $a$ partition of $X$ into finitely many $K$-definable subsets $S$ such that whenever $\operatorname{dim}(S)=$ $\operatorname{dim}(X)$, there is a projection $\pi_{S}: S \longrightarrow K^{k}$ on $k$ suitable coordinate axes which is injective.

Proof. Let $X_{0}=X$. By Corollary 2.12, we may assume that the projection $\pi: X_{0} \longrightarrow$ $K^{k}$ given by $\left(x_{1}, \ldots, x_{n}\right) \mapsto\left(x_{1}, \ldots, x_{k}\right)$ is finite-to-one. By compactness, there is $r \in \mathbb{N}$ such that

$$
\left|\pi^{-1}(\bar{y}) \cap X_{0}\right| \leq r
$$

for all $\bar{y} \in K^{k}$. Induction on $r$. If $r=1$, then $\pi$ is injective on $X_{0}$. Otherwise, by Fact 2.13, there is a definable function

$$
f: \pi(X) \longrightarrow X
$$

such that $\pi(f(\bar{y}))=x$ for all $\bar{y} \in \pi\left(X_{0}\right)$. It is easy to see that $f$ is injective and hence, by Corollary [2.7, $S_{0}=f\left(\pi\left(X_{0}\right)\right)$ is a definable subset of $X$ of dimension $k$. Moreover $\pi: S_{0} \longrightarrow K^{k}$ is exactly the inverse of $f$, hence injective. If $\operatorname{dim}\left(X_{0} \backslash S_{0}\right)$ then the partition $\left\{X_{0} \backslash S_{0}, S_{1}\right\}$ satisfies our require. Otherwise, $X_{1}=X_{0} \backslash S_{0}$ has dimension $k$ and

$$
\left|\pi^{-1}(\bar{y}) \cap X_{1}\right| \leq r-1
$$

By our induction hypothesis, there is a partition of $X_{1}$ into finitely may definable subsets meets our requirements. This completes the proof.

Theorem 2.15. Let $B \subseteq K^{m}$ be definable in $K$. Then $\operatorname{dim}_{K}(B) \geq \operatorname{dim}_{\mathbb{Q}_{p}}\left(B \cap \mathbb{Q}_{p}^{m}\right)$.
Proof. Suppose that $\operatorname{dim}_{K}(B)=k$. By Lemma 2.10 and Corollary 2.14, we may assume that $\pi: B \longrightarrow K^{k}$ is injective. The restriction of $\pi$ to $B \cap \mathbb{Q}_{p}^{m}$ is a injective projection from $B \cap \mathbb{Q}_{p}^{m}$ to $\mathbb{Q}_{p}^{k}$. By Lemma [2.11, $\operatorname{dim}_{\mathbb{Q}_{p}}\left(B \cap \mathbb{Q}_{p}^{m}\right) \leq k$.

Note that $P_{n}(K)=\left\{a \in K \mid a \neq 0 \wedge \exists b \in K\left(a=b^{n}\right)\right\}$ is an open subset of $K$ whenever $K$ is a hensilian field. For any polynomial $f\left(x_{1}, \ldots, x_{m}\right) \in K\left[x_{1}, \ldots, x_{m}\right]$,

$$
P_{n}\left(f\left(K^{m}\right)\right)=\left\{a \in K^{m} \mid f(a) \neq 0 \wedge \exists b \in K\left(f(a)=b^{n}\right)\right\}
$$

is an open subset of $K^{m}$ since $f$ is continuous.

### 2.3 Standard Part Map and Definable Functions

The following Facts will be used later.
Fact 2.16. [2] Every complete n-type over $\mathbb{Q}_{p}$ is definable. Equivalently, for any $K \succ$ $\mathbb{Q}_{p}$, any $L_{r}$-formula $\phi\left(x_{1}, \ldots, x_{n}, y_{1}, \ldots, y_{m}\right)$, and any $\bar{b} \in K^{m}$, the set

$$
\left\{\bar{a} \in \mathbb{Q}_{p}^{n} \mid K \models \phi(\bar{a}, \bar{b})\right\}
$$

is definable in $\mathbb{Q}_{p}$.
Fact 2.17. [10] Let $X \subseteq K^{m}$ be a $\mathbb{Q}_{p}$-definable open set, let $Y \subseteq X$ be a $K$-definable subset of $X$. Then either $Y$ or $X \backslash Y$ contains a $\mathbb{Q}_{p}$-definable open set.

Fact 2.18. [10] Let $X \subseteq K^{m}$ be a $K$-definable set. Then $\operatorname{st}(X) \cap \operatorname{st}\left(K^{m} \backslash X\right)$ has no interior.

Recall that $\mu$ is the collection of all infinitesimals of $K$ over $\mathbb{Q}_{p}$, which induces a equivalence relation $\sim_{\mu}$ on $K$, which is defined by

$$
a \sim_{\mu} b \Longleftrightarrow a-b \in \mu .
$$

Definition 2.19. Let $f(\bar{x}, y), g(\bar{x}, y) \in K[\bar{x}, y]$ be polynomials. By $f \sim_{\mu} g$ we mean that
(i) if $|\bar{x}|=0, f(y)=\sum_{i=1}^{n} a_{i} y^{i}$, and $g(y)=\sum_{i=1}^{n} b_{i} y^{i}$, then $f \sim_{\mu} g$ iff $a_{i} \sim_{\mu} b_{i}$ for each $i \leq n$.
(ii) if $|\bar{x}|>0, f(\bar{x}, y)=\sum_{i=1}^{n} a_{i}(\bar{x}) y^{i}$, and $g(y)=\sum_{i=1}^{n} b_{i}(\bar{x}) y^{i}$, where $a$ 's and $b$ 's are polynomials with variables from $\bar{x}$. Then $f \sim_{\mu} g$ iff $a_{i} \sim_{\mu} b_{i}$ for each $i \leq n$.

Lemma 2.20. Let $\bar{x}=\left(x_{1}, \ldots, x_{n}\right), f(\bar{x})$ and $g(\bar{x})$ be polynomials over $K$ with $f \sim_{\mu} g$. If $\bar{a}=\left(a_{1}, \ldots, a_{n}\right)$ and $\bar{b}=\left(b_{1}, \ldots, b_{n}\right)$ are tuples from $K$ with $a_{i} \sim_{\mu} b_{i}$ for each $i \leq n$. Then $f(\bar{a}) \sim_{\mu} g(\bar{b})$.

Proof. We see that $\alpha \in \mu$ iff $v(\alpha)>\mathbb{Z}$. Since $v(\alpha+\beta) \geq \min \{v(\alpha), v(\beta)\}$ and $v(\alpha \beta)=$ $v(\alpha)+v(\beta)$, we see that $\mu$ is closed under addition and multiplication. As polynomials are functions obtained by compositions of addition and multiplication, we conclude that $f(\bar{a}) \sim_{\mu} g(\bar{b})$.

Since $V \subseteq K$ is also closed under addition and multiplication. We conclude directly that:

Corollary 2.21. Let $\bar{x}=\left(x_{1}, \ldots, x_{n}\right)$, and $f(\bar{x}) \in K[\bar{x}]$ be a polynomial with every coefficient contained in $V$. If $a=\left(a_{1}, \ldots, a_{n}\right) \in V^{n}$, then $\operatorname{st}(f)(\operatorname{st}(a))=\operatorname{st}(f(a))$.

Corollary 2.22. Let $f(x)=a_{n} x^{n}+\ldots+a_{1} x^{1}+a_{0}$ be a polynomial over $K$ with every coefficient contained in $V$ and $a_{n} \notin \mu$. If $b \in K$ such that $f(b)=0$. Then $b \in V$.

Proof. Suppose for a contradiction that $b \notin V$. Then $\operatorname{st}\left(b^{-1}\right)=0$. Clearly, we have

$$
b^{-n} f(b)=a_{n}+\ldots+a_{1} b^{-n+1}+a_{0} b^{-n}=0 .
$$

Let

$$
g(y)=a_{0} y^{n}+\ldots+a_{n-1} y+a_{n} .
$$

Then $g\left(b^{-1}\right)=0$. By Corollary 2.21, we have $\operatorname{st}(g)\left(\operatorname{st}\left(b^{-1}\right)\right)=0$. As st $\left(b^{-1}\right)=0$, we see that $\operatorname{st}\left(a_{n}\right)=0$, which contradicts to $a_{n} \notin \mu$.

Fact 2.23. [10] Let $S \subseteq K^{m}$ be definable in $K$. Then $\operatorname{st}\left(S \cap V^{m}\right) \subseteq \mathbb{Q}_{p}^{m}$ is definable in $\mathbb{Q}_{p}$.

Lemma 2.24. Let $f: K^{k} \longrightarrow K$ be definable in $K$. Then
(i) $X_{\infty}=\left\{a \in \mathbb{Q}_{p}^{k} \mid f(a) \notin V\right\}$ is definable in $\mathbb{Q}_{p}$.
(ii) Let $X=\mathbb{Q}_{p}^{k} \backslash X_{\infty}$. Then $g: X \longrightarrow \mathbb{Q}_{p}$ given by $a \mapsto \operatorname{st}(f(a))$ is definable in $\mathbb{Q}_{p}$

Proof. By Fact 2.16, there is a $L_{\mathbb{Q}_{p}}$-formula $\phi(x, y)$ such that for all $a \in \mathbb{Q}_{p}^{k}$ and $b \in \mathbb{Q}_{p}$, we have

$$
\mathbb{Q}_{p} \models \phi(a, b) \Longleftrightarrow v(f(a))<v(b) .
$$

Hence

$$
a \in X_{\infty} \Longleftrightarrow \mathbb{Q}_{p} \models \forall y \phi(a, y),
$$

which shows that $X_{\infty}$ is definable in $\mathbb{Q}_{p}$. Again by Fact 2.16, there is $L_{\mathbb{Q}_{p}}$-formula $\psi\left(x, y_{1}, y_{2}\right)$ such that for all $a \in \mathbb{Q}_{p}^{k}, b_{1}, b_{2} \in \mathbb{Q}_{p}$,

$$
M \models \psi\left(a, b_{1}, b_{2}\right) \Longleftrightarrow v\left(f(a)-b_{1}\right)>v\left(b_{2}-b_{1}\right) .
$$

Therefore

$$
b=\operatorname{st}(f(a)) \Longleftrightarrow \mathbb{Q}_{p} \equiv \forall y_{1} \forall y_{2}\left(v\left(b-y_{1}\right)>v\left(y_{1}-y_{2}\right) \rightarrow \psi\left(a, y_{1}, y_{2}\right)\right)
$$

for all $a \in \mathbb{Q}_{p}^{k}$ and $b \in \mathbb{Q}_{p}$. We conclude that $g: X \longrightarrow \mathbb{Q}_{p}, a \mapsto \operatorname{st}(f(a))$ is definable in $\mathbb{Q}_{p}$

Lemma 2.25. Let $X \subseteq \mathbb{Q}_{p}^{m}$ be a clopen subset of $\mathbb{Q}_{p}^{m}$. If $\bar{a} \in V^{m}$ and $\operatorname{st}(\bar{a}) \notin X$, then $\bar{a} \notin X(K)$.

Proof. As $X$ is clopen and $\operatorname{st}(\bar{a}) \notin X$, there is $N \in \mathbb{Z}$ such that

$$
B_{(\bar{a}, N)}=\left\{\bar{b} \in \mathbb{Q}_{p}^{m} \mid \bigwedge_{i=1}^{m} v\left(b_{i}-\operatorname{st}\left(a_{i}\right)\right)>N\right\} \cap X=\emptyset .
$$

So $B_{(\bar{a}, N)}(K) \cap X(K)=\emptyset$. But $v\left(a_{i}-\operatorname{st}\left(a_{i}\right)\right)>\mathbb{Z}$, hence

$$
\bar{a} \in\left\{\bar{b} \in K^{m} \mid \bigwedge_{i+1}^{m} v\left(b_{i}-\operatorname{st}\left(a_{i}\right)\right)>N\right\}=B_{(\bar{a}, N)}(K)
$$

So $\bar{a} \notin X(K)$ as required.
Lemma 2.26. If $X \subseteq K^{m}$ and $f: X \longrightarrow K$ are definable in $K$, then there is $a$ polynomial $q\left(x_{1}, \ldots, x_{m}, y\right)$ such that the graph of $f$ is contained in the variety

$$
\left\{\left(a_{1}, \ldots, a_{m}, b\right) \in K^{m+1} \mid q\left(a_{1}, \ldots, a_{m}, b\right)=0\right\}
$$

Proof. Let $Y$ be the graph of $f$. Since $\operatorname{Th}\left(\mathbb{Q}_{p}\right)$ has quantifier elimination, $Y$ is defined by a disjunction $\bigvee_{i=1}^{s} \phi_{i}(\bar{x})$, where each $\phi_{i}(\bar{x})$ is a conjunction

$$
\left(\bigwedge_{j=1}^{l_{i}} g_{i_{j}}(\bar{x}, y)=0\right) \wedge \bigwedge_{j=1}^{l_{i}} P_{n_{i_{j}}}\left(h_{i_{j}}(\bar{x}, y)\right)
$$

where $g$ 's and $h$ 's belong to $K[\bar{x}, y]$. Now each $P_{n_{i_{j}}}\left(h_{i_{j}}(\bar{x}, y)\right)$ defines an open subset of $K^{m+1}$. Since $\operatorname{dim}(Y) \leq m$, we see that for each $i \leq s$, there is $f(i) \leq l_{i}$ such that $g_{i_{f(i)}} \neq 0$. Let $q(\bar{x}, y)=\prod_{i=1}^{s} g_{i_{f(i)}}(\bar{x}, y)$. Then

$$
Y \subseteq\left\{\left(a_{1}, \ldots, a_{m}, b\right) \in K^{m+1} \mid q\left(a_{1}, \ldots, a_{m}, b\right)=0\right\}
$$

as required.
Proposition 2.27. If $f: K^{m} \longrightarrow K$ is definable in $K$. Let $X=\left\{\bar{a} \in \mathbb{Q}_{p}^{m} \mid f(\bar{a}) \in V\right\}$. Then

$$
D_{X}=\left\{\bar{a} \in X \mid \exists \bar{b}, \bar{c} \in \operatorname{st}^{-1}(\bar{a})(f(\bar{b})-f(\bar{c}) \notin \mu)\right\}
$$

has no interiors.
Proof. By Lemma 2.26, there is a polynomial

$$
g\left(x_{1}, \ldots, x_{m}, y\right) \in K\left[x_{1}, \ldots, x_{m}, y\right]
$$

such that the graph of $f$ is contained in the variety of $g$. Without loss of generality, we may assume that each coefficient of $g$ is in $V$, otherwise, we could replace $g$ by $g / c$, where $c$ is a coefficient of $g$ with minimal valuation. Moreover, we could assume that at least one coefficient of $g$ is not in $\mu$.

Suppose for a contradiction that $D_{X}$ contains a open subset of $\mathbb{Q}_{p}^{m}$. Shrink $D_{X}$ if necessary, we may assume that $D_{X} \subseteq X$ is a $\mathbb{Q}_{p}$-definable open set in $\mathbb{Q}_{p}^{m}$. By Lemma 2.4, there is a partition $\mathcal{P}$ of $D_{X}(K) \subseteq K^{m}$ into finitely many definable subsets $S$,
over each of which $g$ has some fixed number $k \geq 1$ of distinct roots in $K$ with fixed multiplicities $m_{1}, \ldots, m_{k}$. For any fixed $\bar{x}_{0} \in S$, let the roots of $g\left(\bar{x}_{0}, y\right)$ be $r_{1}, \ldots, r_{k}$, and $e=\max \left\{v\left(r_{i}-r_{j}\right) \mid 1 \leq i<j \leq k\right\}$. Then $\bar{x}_{0}$ has a neighborhood $N \subseteq K^{m}, \gamma \in \Gamma_{K}$, and continuous, definable functions $F_{1}, \ldots, F_{k}: S \cap N \longrightarrow K$ such that for each $\bar{x} \in S \cap N$, $F_{1}(\bar{x}), \ldots, F_{k}(\bar{x})$ are roots of $g(\bar{x}, y)$ of multiplicities $m_{1}, \ldots, m_{k}$ and $v\left(F_{i}(\bar{x})-r_{i}\right)>2 e$.

Since $D_{X}(K)$ is a $\mathbb{Q}_{p}$-definable open subset of $X(K)$. By Fact 2.17, some $S \in \mathcal{P}$ contains a $\mathbb{Q}_{p}$-definable open subset $\psi\left(K^{m}\right)$ of $X(K)$. Where $\psi$ is an $L_{\mathbb{Q}_{p}}$-formula. Let $A_{0}=\phi\left(\mathbb{Q}_{p}^{m}\right)$. Then $A_{0} \subseteq A$ is an open subset of $\mathbb{Q}_{p}^{m}$, and over $A_{0}(K)$ we have
(i) $g$ has some fixed number $k \geq 1$ of distinct roots in $K$ with fixed multiplicities $m_{1}, \ldots, m_{k}$.
(ii) For any fixed $\bar{x}_{0} \in A_{0}(K)$, let the roots of $g\left(\bar{x}_{0}, y\right)$ be $r_{1}, \ldots, r_{k}$, and $e=\max \left\{v\left(r_{i}-\right.\right.$ $\left.\left.r_{j}\right) \mid 1 \leq i<j \leq k\right\}$. Then $\bar{x}_{0}$ has a neighborhood $N \subseteq K^{m}, \gamma \in \Gamma_{K}$, and continuous, definable functions $F_{1}, \ldots, F_{k}: A_{0}(K) \cap N \longrightarrow K$ such that for each $\bar{x} \in A_{0}(K) \cap N, F_{1}(\bar{x}), \ldots, F_{k}(\bar{x})$ are roots of $g(\bar{x}, y)$ of multiplicities $m_{1}, \ldots, m_{k}$ and $v\left(F_{i}(\bar{x})-r_{i}\right)>2 e$.
(iii) for any $\bar{a} \in A_{0}$, there exist $\bar{b}, \bar{c} \in \operatorname{st}^{-1}(\bar{a})$ such that $\operatorname{st}(f(\bar{b})) \neq \operatorname{st}(f(\bar{c}))$.

Suppose that

$$
g\left(x_{1}, \ldots, x_{m}, y\right)=\sum_{i=0}^{n} g_{i}\left(x_{1}, \ldots, x_{m}\right) y^{i}
$$

where each $g_{i}(\bar{x}) \in K[\bar{x}]$. Since the variety $\left\{\bar{a} \in \mathbb{Q}_{p}^{m} \mid \operatorname{st}\left(g_{n}\right)(\bar{a})=0\right\}$ has dimension $m-1$, it has no interior. By Fact 2.17,

$$
A_{0} \backslash\left\{\bar{a} \in \mathbb{Q}_{p}^{m} \mid \operatorname{st}\left(g_{n}\right)(\bar{a})=0\right\}
$$

contains a open subset of $\mathbb{Q}_{p}^{m}$. Without loss of generality, we may assume that

$$
\left\{\bar{a} \in \mathbb{Q}_{p}^{m} \mid \operatorname{st}\left(g_{n}\right)(\bar{a})=0\right\} \cap A_{0}=\emptyset .
$$

Since the family of clopen subsets forms a base for topology on $\mathbb{Q}_{p}^{m}$, we may assume that $A_{0}$ is clopen. We now claim that

Claim 1. For every $\bar{a} \in A_{0}(K), g_{n}(\bar{a}) \notin \mu$.
Proof. Otherwise, by Corollary 2.21, we have $\operatorname{st}\left(g_{n}\right)(\operatorname{st}(\bar{a}))=\operatorname{st}\left(g_{n}(\bar{a})\right)=0 . \operatorname{Sost}(\bar{a}) \notin$ $A_{0}$. By Lemma [2.25, we see that $\bar{a} \notin A_{0}(K)$. A contradiction.

By Claim 1 and Corollary [2.22, we see that for every $\bar{a} \in A_{0}(K)$ and $b \in K$, if $g(\bar{a}, b)=0$, then $b \in V$. By Corollary 2.21, we conclude the following claim

Claim 2. For every $\bar{a} \in A_{0}(K)$ and $b \in K$, if $g(\bar{a}, b)=0$, then $b \in V$ and

$$
\operatorname{st}(g)(\operatorname{st}(\bar{a}), \operatorname{st}(b))=0 .
$$

Now $\operatorname{st}(g)$ is a polynomial over $\mathbb{Q}_{p}$. Applying Lemma 2.4 to st $(g)$ and Fact 2.17, and shrink $A_{0}$ if necessary, we may assume that

- st $(g)$ has some fixed number $d \geq 1$ of distinct roots in $K$ with fixed multiplicities $n_{1}, \ldots, n_{d}$ over $A_{0}$.
- Fix some $\bar{x}_{0} \in A_{0}$, let the roots of $\operatorname{st}(g)\left(\bar{x}_{0}, y\right)\left(\right.$ in $\left.\mathbb{Q}_{p}\right)$ be $s_{1}, \ldots, s_{d}$, and

$$
\Delta=\max \left\{v\left(s_{i}-s_{j}\right) \mid 1 \leq i<j \leq d\right\}
$$

Then there are definable continuous functions $H_{1}, \ldots, H_{d}: A_{0} \longrightarrow \mathbb{Q}_{p}$ such that for each $\bar{x} \in A_{0}, H_{1}(\bar{x}), \ldots, H_{d}(\bar{x})$ are roots of $\operatorname{st}(g)(\bar{x}, y)$ of multiplicities $n_{1}, \ldots, n_{d}$ and $v\left(H_{i}(\bar{x})-s_{i}\right)>2 \Delta$.

- for any $\bar{a} \in A_{0}$, there exist $\bar{b}, \bar{c} \in \operatorname{st}^{-1}(\bar{a})$ such that $\operatorname{st}(f(\bar{b})) \neq \operatorname{st}(f(\bar{c}))$.

By Claim 2, we see that for any $\bar{x} \in A_{0}(K)$, and $b \in K$, if $g(\bar{x}, b)=0$, then $b \sim_{\mu} H_{i}(\operatorname{st}(\bar{x}))$ for some $i \leq d$. As $g(\bar{x}, f(\bar{x}))=0$ for all $\bar{x} \in K^{m}$, we see that
Claim 3. For each $\bar{x} \in A_{0}(K), f(\bar{x}) \sim_{\mu} H_{i}(\operatorname{st}(\bar{x}))$ for some $i \leq d$.
Let $D_{i}=\left\{\bar{x} \in A(K) \mid v\left(f(\bar{x})-s_{i}\right)>2 \Delta\right\}$. We claim that
Claim 4. $A_{0}(K)=\bigcup_{i=1}^{d} D_{i}$ and $D_{i} \cap D_{j}=\emptyset$ for each $i \neq j$. Namely, $\left\{D_{1}, \ldots, D_{d}\right\}$ is a partition of $A_{0}(K)$.

Proof. Let $\bar{x} \in A_{0}(K)$. By Claim 3, there is some $i \leq d$ such that $f(\bar{x}) \sim_{\mu} H_{i}(\operatorname{st}(\bar{x}))$. It is easy to see that

$$
v\left(f(\bar{x})-s_{i}\right)=v\left(f(\bar{x})-H_{i}(\operatorname{st}(\bar{x}))+H_{i}(\operatorname{st}(\bar{x}))-s_{i}\right)=v\left(H_{i}(\operatorname{st}(\bar{x}))-s_{i}\right)>2 \Delta .
$$

So $\bar{x} \in D_{i}$ and this implies that $A_{0}(K)=\bigcup_{i=1}^{d} D_{i}$.
On the other side, if $\bar{x} \in D_{i} \cap D_{j}$ for some $1 \leq i<j \leq d$, we have $v\left(f(\bar{x})-s_{i}\right)>2 \Delta$ and $v\left(f(\bar{x})-s_{j}\right)>2 \Delta$, which implies that

$$
v\left(s_{i}-s_{j}\right)=v\left(s_{i}-f(\bar{x})+f(\bar{x})-s_{j}\right) \geq \min \left\{v\left(s_{i}-f(\bar{x})\right), v\left(f(\bar{x})-s_{j}\right)\right\} \geq 2 \Delta .
$$

But $v\left(s_{i}-s_{j}\right) \leq \Delta$. A contradiction.
Claim 5. Let $i \leq d$. For any $\bar{a}, \bar{b} \in D_{i}$, if $\bar{a} \sim_{\mu} \bar{b}$ then $\operatorname{st}(f(\bar{a}))=\operatorname{st}(f(\bar{b}))$.
Proof. Let $\bar{x} \in D_{i}$. By Claim 3, there is $j \leq d$ such that $\operatorname{st}(f(\bar{x}))=H_{j}(\operatorname{st}(\bar{x}))$. We see that

$$
\left.v\left(f(\bar{x})-s_{j}\right)=v\left(f(\bar{x})-H_{j}(\operatorname{st}(\bar{x}))+H_{j} \operatorname{st}(\bar{x})\right)-s_{j}\right)=v\left(H_{j}(\operatorname{st}(\bar{x}))-s_{j}\right)>2 \Delta .
$$

So $\bar{x} \in D_{j}$. By Claim $4, i=j$. We conclude that $\operatorname{st}(f(\bar{x}))=H_{i}(\operatorname{st}(\bar{x}))$ whenever $\bar{x} \in D_{i}$. This complete the proof of Claim 5.

Recall that for any $\bar{a} \in A_{0}$, there exist $\bar{b}, \bar{c} \in \operatorname{st}^{-1}(\bar{a})$ such that $\operatorname{st}(f(\bar{b})) \neq \operatorname{st}(f(\bar{c}))$. By Claim 4 and Claim 5, we see that for each $\bar{a} \in A_{0}$, there is $1 \leq i \neq j \leq d$ such that $\bar{a} \in \operatorname{st}\left(D_{i}\right) \cap \operatorname{st}\left(D_{j}\right)$. This means that

$$
A_{0} \subseteq \bigcup_{1 \leq i \neq j \leq d} \operatorname{st}\left(D_{i}\right) \cap \operatorname{st}\left(D_{j}\right)
$$

By Fact 2.18, each $\operatorname{st}\left(D_{i}\right) \cap \operatorname{st}\left(D_{j}\right)$ has no interior. By Fact 2.17, $A_{0}$ has no interiors. A contradiction.

Corollary 2.28. If $f: K^{m} \longrightarrow K$ is definable in $K$. Let $X_{\infty}=\left\{\bar{a} \in \mathbb{Q}_{p}^{m} \mid f(\bar{a}) \notin V\right\}$. Then

$$
U=\left\{\bar{a} \in X_{\infty} \mid \exists \bar{b}, \bar{c} \in \operatorname{st}^{-1}(\bar{a})(f(\bar{b}) \in V \wedge f(\bar{c}) \notin V)\right\}
$$

has no interior.
Proof. Otherwise, suppose that $U \subseteq K^{m}$ is open. Applying Proposition 2.27 to $g(x)=$ $(f(x))^{-1}$, we see that $g(U) \subseteq V$, and for all $\bar{a} \in U$ there are $\bar{b}, \bar{c} \in \operatorname{st}^{-1}(a)$ such that $\operatorname{st}(g(\bar{b})) \neq 0$ and $\operatorname{st}(g(\bar{c}))=0$. A contradiction.
Lemma 2.29. Let $f: K^{k} \longrightarrow K$ be definable in $K, X=\left\{a \in \mathbb{Q}_{p}^{k} \mid f(a) \in V\right\}$, and $X_{\infty}=\left\{a \in \mathbb{Q}_{p}^{k} \mid f(a) \notin V\right\}$. Then both

$$
D_{X}=\left\{\bar{a} \in X \mid \exists \bar{b}, \bar{c} \in \operatorname{st}^{-1}(\bar{a})(f(\bar{b})-f(\bar{c}) \notin \mu)\right\}
$$

and

$$
U=\left\{\bar{a} \in X_{\infty} \mid \exists \bar{b}, \bar{c} \in \operatorname{st}^{-1}(\bar{a})(f(\bar{b}) \in V \wedge f(\bar{c}) \notin V)\right\}
$$

are definable sets over $\mathbb{Q}_{p}$
Proof. Let $X_{0}=\{\bar{a} \in X \mid \operatorname{st}(f(\bar{a}))=0\}$ and $X_{1}=\{\bar{a} \in X \mid \operatorname{st}(f(\bar{a})) \neq 0\}$. As we showed in Lemma 2.24, both $X_{0}$ and $X_{1}$ are $\mathbb{Q}_{p}$-definable sets. Let

$$
g: K^{k} \backslash f^{-1}(0) \longrightarrow K
$$

be the $K$-definable function given by $\bar{x} \mapsto 1 / f(\bar{x})$. Let $Y \subseteq K^{k+1}$ be the graph of $f$ and $Z \subseteq K^{k+1}$ be the graph of $g$. For each $\bar{a} \in \mathbb{Q}_{p}^{k}$, let

$$
\operatorname{st}(Y)_{\bar{a}}=\left\{b \in \mathbb{Q}_{p} \mid(\bar{a}, b) \in \operatorname{st}(Y)\right\} \quad \text { and } \operatorname{st}(Z)_{\bar{a}}=\left\{b \in \mathbb{Q}_{p} \mid(\bar{a}, b) \in \operatorname{st}(Z)\right\}
$$

Let
$S_{1}=\left\{\bar{a} \in X| | \operatorname{st}(Y)_{\bar{a}} \mid>1\right\}, S_{2}=\left\{\bar{a} \in X_{0}| | \operatorname{st}(Z)_{\bar{a}} \mid \geq 1\right\}$, and $S_{3}=\left\{\bar{a} \in X_{1}| | \operatorname{st}(Z)_{\bar{a}} \mid>1\right\}$.
We now show that $D_{X}=S_{1} \cup S_{2} \cup S_{3}$.
Clearly, $S_{1}$ and $S_{3}$ are subsets of $D_{X}$. If $\bar{a} \in S_{2}$, then $\operatorname{st}(f(\bar{a}))=0$ and there is $\bar{b} \in \operatorname{st}^{-1}(\bar{a})$ such that $1 / f(\bar{b}) \in V$, so $f(\bar{a})-f(\bar{b}) \notin \mu$, which implies that $\bar{a} \in D_{X}$. Therefore, we conclude that $S_{1} \cup S_{2} \cup S_{3} \subseteq D_{X}$.

Conversely, take any $\bar{a} \in D_{X}$ and suppose that $\bar{b}, \bar{c} \in \operatorname{st}^{-1}(\bar{a})$ such that $f(\bar{b})-f(\bar{c}) \notin$ $\mu$. If both $f(\bar{b})$ and $f(\bar{c})$ are in $V$, then $\bar{a} \in S_{1}$; If $f(\bar{b}) \notin V$ and $\operatorname{st}(f(\bar{a}))=0$, then $\bar{b} \in \operatorname{dom}(g)$. We see that $(\bar{a}, 0) \in \operatorname{st}(Z)$, so $\bar{a} \in S_{2}$; If $f(\bar{b}) \notin V$ and $\operatorname{st}(f(\bar{a})) \neq 0$, then $\bar{a}, \bar{b} \in \operatorname{dom}(g), \operatorname{st}(g(\bar{b}))=0$ and $\operatorname{st}(g(\bar{a})) \neq 0$, which implies that $\left|\operatorname{st}(Z)_{\bar{a}}\right|>1$, and thus $\bar{a} \in S_{3}$. So we conclude that $D_{X} \subseteq S_{1} \cup S_{2} \cup S_{3}$ as required.

As $S_{1}, S_{2}$, and $S_{3}$ are definable sets over $\mathbb{Q}_{p}, D_{X}$ is definable over $\mathbb{Q}_{p}$. Similarly, $U$ is definable over $\mathbb{Q}_{p}$.

Suppose that $C \subseteq \mathbb{Q}_{p}^{m}$, we define the hull $C^{h}$ by

$$
C^{h}=\left\{\bar{x} \in K^{m} \mid \operatorname{st}(\bar{x}) \in C\right\}
$$

Theorem 2.30. Let $f: K^{m} \rightarrow K$ be an $K$-definable function. Then here is a finite partition $\mathcal{P}$ of $\mathbb{Q}_{p}$ into definable sets, where each set in the partition is either open in $\mathbb{Q}_{p}^{m}$ or lacks of interior. On each open set $C \in \mathcal{P}$ we have:
(i) either $f(x) \notin V$ for all $x \in C^{h}$;
(ii) or there is a continuous function $g: C \longrightarrow \mathbb{Q}_{p}$, definable in $\mathbb{Q}_{p}$, such that $f(x) \in V$ and $\operatorname{st}(f(x))=g(\operatorname{st}(x))$, for all $x \in C^{h}$.

Proof. Let $X, X_{\infty}$ be as in Lemma 2.24, $D_{X}$ as in Proposition 2.27, and $U$ as in Corollary 2.28, then $D_{X}$ and $U$ have no interior, and by Lemma 2.29, they are definable. Now $\left\{D_{X}, X \backslash D_{X}, U, X_{\infty} \backslash U\right\}$ is a partition of $\mathbb{Q}_{p}^{m}$. Clearly, $\left\{\operatorname{Int}\left(X_{\infty} \backslash U\right),\left(X_{\infty} \backslash U\right) \backslash \operatorname{Int}\left(X_{\infty} \backslash U\right)\right\}$ is a partition of $X_{\infty} \backslash U$ where $\operatorname{Int}\left(X_{\infty} \backslash U\right)$ is open and $\left(X_{\infty} \backslash U\right) \backslash \operatorname{Int}\left(X_{\infty} \backslash U\right)$ lacks of interior.

Let $h: X \backslash D_{X} \longrightarrow \mathbb{Q}_{p}$ be a definable function defined by $x \mapsto \operatorname{st}(f(x))$. By Theorem 1.1 of [13], there is a finite partition $\mathcal{P}^{*}$ of $X \backslash D_{X}$ into definable sets, on each of which $h$ is analytic. Each set in the partition is either open in $\mathbb{Q}_{p}^{m}$ or lacks of interior.

Clearly, the partition

$$
\mathcal{P}=\left\{D_{X}, U, \operatorname{Int}\left(X_{\infty} \backslash U\right),\left(X_{\infty} \backslash U\right) \backslash \operatorname{Int}\left(X_{\infty} \backslash U\right)\right\} \cup \mathcal{P}^{*}
$$

satisfies our condition.
We now prove our last result.
Lemma 2.31. Let $Z \subseteq K^{n}$ be definable in $K$ of dimension $k<n$, and the projection

$$
\pi:\left(x_{1}, \ldots x_{n}\right) \mapsto\left(x_{1}, \ldots, x_{k}\right)
$$

is injective on $Z$. Then $\operatorname{dim}_{\mathbb{Q}_{p}}\left(\operatorname{st}\left(Z \cap V^{n}\right)\right) \leq k$.
Proof. As $\pi$ is injective on $X$, there is a definable function

$$
f=\left(f_{1}, \ldots, f_{n}\right): K^{k} \longrightarrow K^{n}
$$

such that

- $f(\pi(\bar{x}))=\left(f_{1}(\pi(\bar{x})), \ldots, f_{n}(\pi(\bar{x}))\right)=\bar{x}$ for all $\bar{x} \in Z ;$
- $f(\bar{y})=(0, \ldots, 0)$ for all $\bar{y} \in K^{k} \backslash \pi(X)$.

By Lemma 2.26, for each $i \leq n$, there is a polynomial $F_{i}(\bar{y}, u)$ such that the graph of $f_{i}$ is contained in the variety

$$
V\left(F_{i}\right)=\left\{(\bar{y}, u) \in K^{k+1} \mid F_{i}(\bar{y}, u)=0\right\}
$$

of $F_{i}$. We assume that each coefficient belongs to $V$. It is easy to see that for each

$$
\left(a_{1}, \ldots, a_{n}\right) \in Z \cap V^{n}
$$

we have $f_{i}\left(\pi\left(a_{1}, \ldots, a_{n}\right)\right)=a_{i}$. So $F_{i}\left(a_{1}, \ldots, a_{k}, a_{i}\right)=0$. By Corollary 2.21,

$$
\left.\operatorname{st}\left(F_{i}\right)\left(\operatorname{st}\left(a_{1}\right), \ldots, \operatorname{st}\left(a_{k}\right), \operatorname{st}\left(a_{i}\right)\right)\right)=0
$$

So $\operatorname{st}\left(Z \cap V^{n}\right)$ is contained in the variety

$$
\left.V\left(\operatorname{st}\left(F_{1}\right), \ldots, \operatorname{st}\left(F_{n}\right)\right)=\left\{\left(a_{1}, \ldots, a_{n}\right) \in \mathbb{Q}_{p}^{n} \mid \bigwedge_{i=1}^{n}\left(\operatorname{st}\left(F_{i}\right)\left(\operatorname{st}\left(a_{1}\right), \ldots, \operatorname{st}\left(a_{k}\right), \operatorname{st}\left(a_{i}\right)\right)\right)=0\right)\right\}
$$

Let $A \subseteq \mathbb{Q}_{p}$ be the collection of all coefficients from $\operatorname{st}\left(F_{i}\right)$ 's. Then for each

$$
\left(a_{1}, \ldots, a_{n}\right) \in V\left(\operatorname{st}\left(F_{1}\right), \ldots, \operatorname{st}\left(F_{n}\right)\right)
$$

we see that $a_{i}$ is a root of $F_{i}\left(a_{1}, \ldots, a_{k}, u\right)$, and hence $a_{i} \in \operatorname{acl}\left(A, a_{1}, \ldots, a_{k}\right)$, where $i \leq n$. This implies that

$$
\operatorname{dim}\left(a_{1}, \ldots, a_{n} / A\right)=\operatorname{dim}\left(a_{1}, \ldots, a_{k} / A\right) \leq k
$$

for all $\left(a_{1}, \ldots, a_{n}\right) \in V\left(\operatorname{st}\left(F_{1}\right), \ldots, \operatorname{st}\left(F_{n}\right)\right)$. By Fact $1.8(\mathrm{v})$, we see that
$\operatorname{dim}_{\mathbb{Q}_{p}}\left(V\left(\operatorname{st}\left(F_{1}\right), \ldots, \operatorname{st}\left(F_{n}\right)\right)\right)=\max \left\{\operatorname{dim}\left(a_{1}, \ldots, a_{n} / A\right) \mid\left(a_{1}, \ldots, a_{n}\right) \in V\left(\operatorname{st}\left(F_{1}\right), \ldots, \operatorname{st}\left(F_{n}\right)\right)\right\} \leq k$.
So $\operatorname{st}\left(Z \cap V^{n}\right) \leq k$ as required.
Theorem 2.32. Let $Z \subseteq K^{n}$ be definable in $K$. Then $\operatorname{dim}_{\mathbb{Q}_{p}}\left(\mathrm{st}\left(Z \cap V^{n}\right)\right) \leq \operatorname{dim}_{K}(Z)$.
Proof. Since $\operatorname{st}(X \cup Y)=\operatorname{st}(X) \cup \operatorname{st}(Y)$ and $\operatorname{dim}(X \cup Y)=\max \{\operatorname{dim}(X), \operatorname{dim}(Y)\}$ hold for all definable $X, Y \subseteq K^{n}$. Applying Corollary 2.14, we many assume that $\operatorname{dim}(Z)=k$ and $\pi:\left(x_{1}, \ldots x_{n}\right) \mapsto\left(x_{1}, \ldots, x_{k}\right)$ is injective on $Z$. If $k=n$, then

$$
\operatorname{dim}_{\mathbb{Q}_{p}}\left(\operatorname{st}\left(Z \cap V^{n}\right)\right) \leq n
$$

as $\operatorname{st}\left(Z \cap V^{n}\right) \subseteq \mathbb{Q}_{p}^{n}$. If $k<n$, then by Lemma 2.31,

$$
\operatorname{dim}_{\mathbb{Q}_{p}}\left(\operatorname{st}\left(Z \cap V^{n}\right)\right) \leq k
$$

as required.
