# F-MANIFOLD ALGEBRAS AND DEFORMATION QUANTIZATION VIA PRE-LIE ALGEBRAS

#### Abstract

The notion of an $F$-manifold algebra is the underlying algebraic structure of an $F$ manifold. We introduce the notion of pre-Lie formal deformations of commutative associative algebras and show that $F$-manifold algebras are the corresponding semi-classical limits. We study pre-Lie infinitesimal deformations and extension of pre-Lie $n$-deformation to pre-Lie ( $n+$ $1)$-deformation of a commutative associative algebra through the cohomology groups of preLie algebras. We introduce the notions of pre- $F$-manifold algebras and dual pre- $F$-manifold algebras, and show that a pre- $F$-manifold algebra gives rise to an $F$-manifold algebra through the sub-adjacent associative algebra and the sub-adjacent Lie algebra. We use Rota-Baxter operators, more generally $O$-operators and average operators on $F$-manifold algebras to construct pre- $F$ manifold algebras and dual pre- $F$-manifold algebras.

## 1. Introduction

The concept of Frobenius manifolds was introduced by Dubrovin in [14] as a geometrical manifestation of the Witten-Dijkgraaf-Verlinde-Verlinde (WDVV) associativity equations in the 2-dimensional topological field theories. Hertling and Manin weakened the conditions of

[^0]a Frobenius manifold and introduced the notion of an $F$-manifold in [23]. Any Frobenius manifold is an $F$-manifold. $F$-manifolds appear in many fields of mathematics such as singularity theory [22], quantum K-theory [25], integrable systems [10, 11, 30], operad [33] and so on.

Motivated by the study of the operad of the underlying algebraic structure of an $F$-manifold, Dotsenko introduced the notion of an $F$-manifold algebra in [13] and showed that the graded object of the filtration of the operad encoding pre-Lie algebras is the operad encoding $F$-manifold algebras. The slogan for $F$-manifold algebras promoted by Dotsenko is that " $F$-manifold algebras are the same to pre-Lie algebras as Poisson algebras to associative algebras". It is wellknown that Poisson algebras can be understood as semi-classical limits of associative formal deformations of commutative associative algebras. So it is natural to ask whether $F$-manifold algebras can be understood as certain semi-classical limits.

The first aim of this paper is to answer the above question. We introduce the notion of pre-Lie formal deformations of commutative associative algebras and show that $F$-manifold algebras are the corresponding semi-classical limits. Note that a commutative pre-Lie algebra is associative and hence the aforementioned formal deformation can put into an extent of "pure" pre-Lie algebras, that is, $F$-manifold algebras are the semi-classical limits of pre-Lie formal deformations of commutative pre-Lie algebras. This result is parallel to that the semi-classical limit of an associative formal deformation of a commutative associative algebra is a Poisson algebra and illustrates the slogan promoted by Dotsenko. Viewing the commutative associative algebra as a pre-Lie algebra, we show that pre-Lie infinitesimal deformation and extension of pre-Lie $n$-deformation to pre-Lie $(n+1)$-deformation of a commutative associative algebra are classified by the second and the third cohomology groups of the pre-Lie algebra respectively.

The notion of a pre-Poisson algebra was introduced by Aguiar in [价, which combines a Zinbiel algebra and a pre-Lie algebra such that some compatibility conditions are satisfied. Zinbiel algebras (also called dual Leibniz algebras) were introduced by Loday in [28] in his study of the algebraic structure behind the cup product on the cohomology groups of the Leibniz algebra. See [27, 29] for more details on Zinbiel algebras. More importantly, a pre-Poisson algebra gives rise to a Poisson algebra naturally through the sub-adjacent commutative associative algebra of the Zinbiel algebra and the sub-adjacent Lie algebra of the pre-Lie algebra. Conversely, a RotaBaxter operator action (more generally an $O$-operator action) on a Poisson algebra gives rise to a pre-Poisson algebra. In this paper, we introduce the notion of a pre- $F$-manifold algebra, which also contains a Zinbiel algebra and a pre-Lie algebra, such that some compatibility conditions are satisfied. By the sub-adjacent associative algebra and the sub-adjacent Lie algebra, a pre- $F$-manifold algebra gives rise to an $F$-manifold algebra naturally. We further introduce the notion of a Rota-Baxter operator (more generally an $O$-operator) on an $F$-manifold algebra, which is simultaneously a Rota-Baxter operator on the underlying associative algebra and a Rota-Baxter operator on the underlying Lie algebra. See [1, 2, 3, 2, 16, 20, 21] for more details on Rota-Baxter operators and $O$-operators. A pre- $F$-manifold algebra can be obtained through the action of a Rota-Baxter operator (more generally an $O$-operator). This coincides with the general theory of splitting of operads [4, 34]. The above relations can be summarized into the
following commutative diagram:

It is well known that the Koszul duals of the operad PreLie of pre-Lie algebras and the operad Zinb of Zinbiel algebras are the operad Perm of permutative algebras and the operad Leib of Leibniz algebras respectively ([29, 8]). We further introduce the notion of a dual pre- $F$ manifold algebra, which contains a permutative algebra and a Leibniz algebra such that some compatibility conditions hold. By the action of an average operator on an $F$-manifold algebra, we can obtain a dual pre- $F$-manifold algebra.

The paper is organized as follows. In Section 2, we recall pre-Lie algebras, Lie-admissible algebras and the cohomology theory of pre-Lie algebras. In Section 3, first we introduce the notion of $F$-manifold-admissible algebras, which gives rise to $F$-manifold algebras. Various examples on $F$-manifold algebras are given. Then we introduce the notion of pre-Lie formal deformations of commutative associative algebras and show that $F$-manifold algebras are the corresponding semi-classical limits. Furthermore, we study pre-Lie infinitesimal deformations and extensions of pre-Lie $n$-deformations to pre-Lie $(n+1)$-deformations of a commutative associative algebra. In Section $\ddagger$, first we study representations of an $F$-manifold algebra. Then we introduce the notions of pre- $F$-manifold algebras and Rota-Baxter operators (more generally $O$-operators) on an $F$-manifold algebra. We show that on one hand, an $O$-operator on an $F$ manifold algebra gives a pre- $F$-manifold algebra, and on the other hand, a pre- $F$-manifold algebra naturally gives an $O$-operator on the sub-adjacent $F$-manifold algebra. More examples of pre- $F$-manifold algebras and $F$-manifold algebras are given. In Section 5 , we introduce the notions of dual pre- $F$-manifold algebras and average operators on an $F$-manifold algebra and show that an average operator on an $F$-manifold algebra gives a dual pre- $F$-manifold algebra naturally.

In this paper, all the vector spaces are over algebraically closed field $\mathbb{K}$ of characteristic 0 , and finite dimensional.

## 2. Preliminaries

In this section, we briefly recall pre-Lie algebras, Lie-admissible algebras and the cohomology theory of pre-Lie algebras.

Pre-Lie algebras are a class of nonassociative algebras appearing in many fields in mathe-
 pointed out in [[|3], the operad of pre-Lie algebras is "one of the most famous operads in the literature".

Definition 2.1. A pre-Lie algebra is a pair $\left(\mathfrak{g}, *_{\mathfrak{g}}\right)$, where $\mathfrak{g}$ is a vector space and $*_{\mathfrak{g}}: \mathfrak{g} \otimes \mathfrak{g} \longrightarrow \mathfrak{g}$ is a bilinear multiplication satisfying that for all $x, y, z \in \mathfrak{g}$, the associator $(x, y, z)=\left(x *_{\mathfrak{g}} y\right) *_{\mathfrak{g}}$
$z-x *_{\mathfrak{g}}\left(y *_{\mathfrak{g}} z\right)$ is symmetric in $x, y$, i.e.
$(x, y, z)=(y, x, z)$, or equivalently, $\left(x *_{\mathfrak{g}} y\right) *_{\mathfrak{g}} z-x *_{\mathfrak{g}}\left(y *_{\mathfrak{g}} z\right)=\left(y *_{\mathfrak{g}} x\right) *_{\mathfrak{g}} z-y *_{\mathfrak{g}}\left(x *_{\mathfrak{g}} z\right)$.
It is obvious that any associative algebra is a pre-Lie algebra.
Lemma 2.2. ([7]) A commutative pre-Lie algebra is associative.
Lemma 2.3. ([7]) Let $\left(\mathfrak{g}, *_{\mathfrak{g}}\right)$ be a pre-Lie algebra. The commutator $[x, y]_{\mathfrak{g}}=x *_{\mathfrak{g}} y-y *_{\mathfrak{g}} x$ defines a Lie algebra structure on $\mathfrak{g}$, which is called the sub-adjacent Lie algebra of $\left(\mathfrak{g}, *_{\mathfrak{g}}\right)$ and denoted by $\mathfrak{g}{ }^{c}$. Furthermore, $L: \mathfrak{g} \rightarrow \mathfrak{g l}(\mathfrak{g})$ defined by

$$
\begin{equation*}
L_{x} y=x *_{\mathfrak{g}} y, \quad \forall x, y \in \mathfrak{g} \tag{1}
\end{equation*}
$$

gives a representation of $\mathfrak{g}^{c}$ on $\mathfrak{g}$.
A Lie-admissible algebra is a nonassociative algebra $\left(\mathfrak{g}, *_{g}\right)$ whose commutator algebra is a Lie algebra. More precisely, it is equivalent to the following condition:

$$
\begin{equation*}
(x, y, z)-(y, x, z)+(y, z, x)-(z, y, x)+(z, x, y)-(x, z, y)=0, \quad \forall x, y, z \in \mathfrak{g} \tag{2}
\end{equation*}
$$

Obviously, a pre-Lie algebra is a Lie-admissible algebra.
Definition 2.4. Let $\left(\mathfrak{g}, *_{\mathfrak{g}}\right)$ be a pre-Lie algebra and $V$ a vector space. A representation of $\mathfrak{g}$ on $V$ consists of a pair $(\rho, \mu)$, where $\rho: \mathfrak{g} \longrightarrow \mathfrak{g l}(V)$ is a representation of the Lie algebra $\mathfrak{g}^{c}$ on $V$ and $\mu: \mathfrak{g} \longrightarrow \mathfrak{g l}(V)$ is a linear map satisfying

$$
\begin{equation*}
\rho(x) \mu(y) u-\mu(y) \rho(x) u=\mu\left(x *_{\mathfrak{g}} y\right) u-\mu(y) \mu(x) u, \quad \forall x, y \in \mathfrak{g}, u \in V . \tag{3}
\end{equation*}
$$

Usually, we denote a representation by $(V ; \rho, \mu)$. Let $R: \mathfrak{g} \rightarrow \mathfrak{g l}(\mathfrak{g})$ be a linear map with $x \longrightarrow R_{x}$, where the linear map $R_{x}: \mathfrak{g} \longrightarrow \mathfrak{g}$ is defined by $R_{x}(y)=y *_{\mathfrak{g}} x$, for all $x, y \in \mathfrak{g}$. Then ( $\mathfrak{g} ; \rho=L, \mu=R$ ) is a representation, which we call the regular representation. Define two linear maps $L^{*}, R^{*}: \mathfrak{g} \longrightarrow \mathfrak{g l}\left(\mathfrak{g}^{*}\right)$ with $x \longrightarrow L_{x}^{*}$ and $x \longrightarrow R_{x}^{*}$ respectively (for all $x \in \mathfrak{g}$ ) by

$$
\begin{equation*}
\left\langle L_{x}^{*}(\xi), y\right\rangle=-\left\langle\xi, x *_{\mathfrak{g}} y\right\rangle, \quad\left\langle R_{x}^{*}(\xi), y\right\rangle=-\left\langle\xi, y *_{\mathfrak{g}} x\right\rangle, \quad \forall x, y \in \mathfrak{g}, \xi \in \mathfrak{g}^{*} . \tag{4}
\end{equation*}
$$

Then $\left(\mathfrak{g}^{*} ; \rho=\mathrm{ad}^{*}=L^{*}-R^{*}, \mu=-R^{*}\right)$ is a representation of $\left(\mathfrak{g}, \cdot{ }_{\mathfrak{g}}\right)$.
The cohomology complex for a pre-Lie algebra $\left(\mathfrak{g}, *_{\mathfrak{g}}\right)$ with a representation $(V ; \rho, \mu)$ is given as follows ([[15]). The set of $n$-cochains is given by $C^{n}(\mathfrak{g}, V):=\operatorname{Hom}\left(\wedge^{n-1} \mathfrak{g} \otimes \mathfrak{g}, V\right), n \geq 1$. For all $\phi \in C^{n}(\mathfrak{g}, V)$, the coboundary operator $\mathrm{d}: C^{n}(\mathfrak{g}, V) \longrightarrow C^{n+1}(\mathfrak{g}, V)$ is given by

$$
\begin{align*}
\mathrm{d} \phi\left(x_{1}, \cdots, x_{n+1}\right)= & \sum_{i=1}^{n}(-1)^{i+1} \rho\left(x_{i}\right) \phi\left(x_{1}, \cdots, \hat{x}_{i}, \cdots, x_{n+1}\right) \\
& +\sum_{i=1}^{n}(-1)^{i+1} \mu\left(x_{n+1}\right) \phi\left(x_{1}, \cdots, \hat{x}_{i}, \cdots, x_{n}, x_{i}\right) \\
& -\sum_{i=1}^{n}(-1)^{i+1} \phi\left(x_{1}, \cdots, \hat{x}_{i}, \cdots, x_{n}, x_{i} *_{\mathrm{g}} x_{n+1}\right) \\
& +\sum_{1 \leq i<j \leq n}(-1)^{i+j} \phi\left(\left[x_{i}, x_{j}\right]_{\mathrm{g}}, x_{1}, \cdots, \hat{x}_{i}, \cdots, \hat{x}_{j}, \cdots, x_{n+1}\right), \tag{5}
\end{align*}
$$

for all $x_{i} \in \mathfrak{g}, i=1, \cdots, n+1$. In particular, we use the symbol dreg to refer the coboundary operator associated to the regular representation. We denote the $n$-th cohomology group for the coboundary operator dreg by $H_{\text {reg }}^{n}(\mathfrak{g}, \mathfrak{g})$ and $H_{\text {reg }}(\mathfrak{g}, \mathfrak{g})=\oplus_{n \geq 1} H_{\text {reg }}^{n}(\mathfrak{g}, \mathfrak{g})$.
3. $F$-manifold algebras and pre-Lie deformations of commutative associative algebras
3.1. $F$-manifold algebras and $F$-manifold-admissible algebras. In this subsection, we introduce the notion of $F$-manifold-admissible algebras, which give rise to $F$-manifold algebras. Various examples are given.
Definition 3.1. ([[13]) An $F$-manifold algebra is a triple $\left(A,{ }_{A},[-,-]_{A}\right)$, where $\left(A, \cdot{ }_{A}\right)$ is a commutative associative algebra and $\left(A,[-,-]_{A}\right)$ is a Lie algebra, such that for all $x, y, z, w \in A$, the Hertling-Manin relation holds:

$$
\begin{equation*}
P_{x \cdot A}(z, w)=x \cdot{ }_{A} P_{y}(z, w)+y \cdot{ }_{A} P_{x}(z, w), \tag{6}
\end{equation*}
$$

where $P_{x}(y, z)$ is defined by

$$
\begin{equation*}
P_{x}(y, z)=[x, y \cdot A z]_{A}-[x, y]_{A} \cdot A z-y \cdot \cdot_{A}[x, z]_{A} . \tag{7}
\end{equation*}
$$

Remark 3.2. For any elements $z, w \in A$, the Hertling-Manin relation means that the linear map $P_{-}(z, w): A \longrightarrow A$ defined by $P_{-}(z, w)(x):=P_{x}(z, w)$ is a Hochschild 2-cocycle of the commutative associative algebra $\left(A,{ }_{A}\right)$.
Remark 3.3. An $F$-manifold is a pair $(M, \cdot)$, where $M$ is a manifold, $\cdot$ is a $C^{\infty}(M)$-bilinear, commutative, associative multiplication on the tangent bundle TM, such that the HertlingManin relation holds, where the Lie bracket in the Hertling-Manin relation is the usual Lie bracket of vector fields. Thus the underlying algebraic structure of an F-manifold (ignore the geometry of the arguments) is an F-manifold algebra.

Definition 3.4. Let $\left(A,{ }_{A},[-,-]_{A}\right)$ and $\left(B,{ }_{B},[-,-]_{B}\right)$ be two $F$-manifold algebras. $A$ homomorphism between $A$ and $B$ is a linear map $\varphi: A \rightarrow B$ such that

$$
\begin{align*}
\varphi\left(x \cdot_{A} y\right) & =\varphi(x) \cdot{ }_{B} \varphi(y),  \tag{8}\\
\varphi[x, y]_{A} & =[\varphi(x), \varphi(y)]_{B}, \quad \forall x, y \in A . \tag{9}
\end{align*}
$$

Example 3.5. Let $\left(A,{ }_{A},[-,-]_{A}\right)$ and $\left(B, \cdot_{B},[-,-]_{B}\right)$ be two $F$-manifold algebras. Then $(A \oplus$ $\left.B, \cdot_{A \oplus B},[-,-]_{A \oplus B}\right)$ is an $F$-manifold algebra, where the product ${ }_{A \oplus B}$ and bracket $[-,-]_{A \oplus B}$ are given by

$$
\begin{aligned}
\left(x_{1}+x_{2}\right) \cdot \cdot_{A \oplus B}\left(y_{1}+y_{2}\right) & =x_{1} \cdot \cdot_{A} y_{1}+x_{2} \cdot{ }_{B} y_{2}, \\
{\left[\left(x_{1}+x_{2}\right),\left(y_{1}+y_{2}\right)\right]_{A \oplus B} } & =\left[x_{1}, y_{1}\right]_{A}+\left[x_{2}, y_{2}\right]_{B}
\end{aligned}
$$

for all $x_{1}, y_{1} \in A, x_{2}, y_{2} \in B$.
Example 3.6. Let $\left(A,{ }_{A},[-,-]_{A}\right)$ and $\left(B, \cdot_{B},[-,-]_{B}\right)$ be two $F$-manifold algebras. Then $(A \otimes$ $\left.B, \cdot_{A \otimes B},[-,-]_{A \otimes B}\right)$ is an $F$-manifold algebra, where the product $\cdot_{A \otimes B}$ and bracket $[-,-]_{A \otimes B}$ are given by

$$
\begin{aligned}
\left(x_{1} \otimes x_{2}\right) \cdot{ }_{A \otimes B}\left(y_{1} \otimes y_{2}\right) & =\left(x_{1} \cdot{ }_{A} y_{1}\right) \otimes\left(x_{2} \cdot{ }_{B} y_{2}\right), \\
{\left[x_{1} \otimes x_{2}, y_{1} \otimes y_{2}\right]_{A \otimes B} } & =\left[x_{1}, y_{1}\right]_{A} \otimes\left(x_{2} \cdot{ }_{B} y_{2}\right)+\left(x_{1} \cdot{ }_{A} y_{1}\right) \otimes\left[x_{2}, y_{2}\right]_{B}
\end{aligned}
$$

for all $x_{1}, y_{1} \in A, x_{2}, y_{2} \in B$.
Recall that a Poisson algebra is a triple $\left(P, \cdot_{P},\{-,-\}_{P}\right)$, where $\left(P,{ }_{P}\right)$ is a commutative associative algebra and $\left(P,\{-,-\}_{P}\right)$ is a Lie algebra, such that the Leibniz rule holds:

$$
\left\{x, y \cdot_{P} z\right\}_{P}=\{x, y\}_{P} \cdot{ }_{P} z+y \cdot_{P}\{x, z\}_{P}, \quad \forall x, y, z \in P .
$$

Example 3.7. Any Poisson algebra is an $F$-manifold algebra.
The notion of PreLie-Com algebras was given in [18, 32].
Definition 3.8. $A$ pre-Lie commutative algebra (or PreLie-Com algebra) is a triple $\left(A,{ }_{A}, *_{A}\right)$, where $\left(A,{ }_{A}\right)$ is a commutative associative algebra and $\left(A, *_{A}\right)$ is a pre-Lie algebra satisfying

$$
\begin{equation*}
x *_{A}\left(y \cdot{ }_{A} z\right)-\left(x *_{A} y\right) \cdot_{A} z-y \cdot y \cdot\left(x *_{A} z\right)=0, \quad \forall x, y, z \in A . \tag{10}
\end{equation*}
$$

Corollary 3.9. ([|13]) Let $\left(A, \cdot_{A}, *_{A}\right)$ be a PreLie-Com algebra. Then $\left(A, \cdot_{A},[-,-]_{A}\right)$ is an $F$ manifold algebra, where the bracket $[-,-]_{A}$ is given by

$$
\begin{equation*}
[x, y]_{A}=x *_{A} y-y *_{A} x, \quad \forall x, y \in A . \tag{11}
\end{equation*}
$$

Let $A=\mathbb{K}\left[x_{1}, x_{2}, \cdots, x_{n}\right]$ be the algebra of polynomials in $n$ variables. Let

$$
\mathcal{D}_{n}=\left\{\partial_{x_{1}}, \partial_{x_{2}}, \ldots, \partial_{x_{n}}\right\}
$$

be the system of derivations over $A$. For any polynomial $f \in A$, the endomorphisms

$$
f \partial_{x_{i}}: A \longrightarrow A, \quad\left(f \partial_{x_{i}}\right)(g)=f \partial_{x_{i}}(g), \quad \forall g \in A
$$

are derivations of $A$. Denote by $A \mathcal{D}_{n}=\left\{\sum_{i=1}^{n} f_{i} \partial_{x_{i}} \mid f_{i} \in A, \partial_{x_{i}} \in \mathcal{D}_{n}\right\}$ the space of derivations.
Example 3.10. Let $A$ be the algebra of polynomials in $n$ variables. Define • : $A \mathcal{D}_{n} \times A \mathcal{D}_{n} \longrightarrow$ $A \mathcal{D}_{n}$ and $*: A \mathcal{D}_{n} \times A \mathcal{D}_{n} \longrightarrow A \mathcal{D}_{n}$ by

$$
\begin{aligned}
\left(f \partial_{x_{i}}\right) \cdot\left(g \partial_{x_{j}}\right) & =(f g) \delta_{i j} \partial_{x_{i}}, \\
\left(f \partial_{x_{i}}\right) *\left(g \partial_{x_{j}}\right) & =f \partial_{x_{i}}(g) \partial_{x_{j}}, \quad \forall f, g \in A .
\end{aligned}
$$

Then $\left(A \mathcal{D}_{n}, \cdot, *\right)$ is a PreLie-Com algebra. Furthermore, $\left(A \mathcal{D}_{n}, \cdot,[-,-]\right)$ is an $F$-manifold algebra, where the bracket is given by

$$
\left[f \partial_{x_{i}}, g \partial_{x_{j}}\right]=f \partial_{x_{i}}(g) \partial_{x_{j}}-g \partial_{x_{j}}(f) \partial_{x_{i}}, \quad \forall f, g \in A
$$

Example 3.11. Let $A=\mathbb{K}\left[x_{1}, x_{2}\right]$ be the algebra of polynomials in two variables. Besides the PreLie-Com algebra structure given in Example 3.10 on $A \mathcal{D}_{2}$, there is another PreLie-Com algebra $\left(A \mathcal{D}_{2}, \cdot, *\right)$, where the operations $\cdot$ and $*$ are determined by

$$
\begin{aligned}
\partial_{x_{1}} \cdot \partial_{x_{1}}=\partial_{x_{1}}, \quad \partial_{x_{1}} \cdot \partial_{x_{2}} & =\partial_{x_{2}} \cdot \partial_{x_{1}}=\partial_{x_{2}}, \quad \partial_{x_{2}} \cdot \partial_{x_{2}}=0, \\
\left(f \partial_{x_{i}}\right) *\left(g \partial_{x_{j}}\right) & =f \partial_{x_{i}}(g) \partial_{x_{j}}, \quad \forall f, g \in A(i, j=1,2) .
\end{aligned}
$$

Furthermore, $\left(A \mathcal{D}_{2}, \cdot,[-,-]\right)$ is an $F$-manifold algebra, where the bracket is given by

$$
\left[f \partial_{x_{i}}, g \partial_{x_{j}}\right]=f \partial_{x_{i}}(g) \partial_{x_{j}}-g \partial_{x_{j}}(f) \partial_{x_{i}}, \quad \forall f, g \in A
$$

In the sequel, we introduce the notion of $F$-manifold-admissible algebras, which include PreLie-Com algebras as special cases, and can be used to construct $F$-manifold algebras.
Definition 3.12. An $F$-manifold-admissible algebra is a vector space $A$ equipped with two bilinear maps $\cdot A \times A \rightarrow A$ and $*_{A}: A \times A \rightarrow A$ such that $\left(A,{ }_{A}\right)$ is a commutative associative algebra and $\left(A, *_{A}\right)$ is a Lie-admissible algebra satisfying for all $x, y, z \in A$,

$$
\begin{equation*}
x *_{A}\left(y \cdot_{A} z\right)-\left(x *_{A} y\right) \cdot_{A} z-y \cdot{ }_{A}\left(x *_{A} z\right)=y *_{A}\left(x \cdot_{A} z\right)-\left(y *_{A} x\right) \cdot \cdot_{A} z-x \cdot_{A}\left(y *_{A} z\right) . \tag{12}
\end{equation*}
$$

Remark 3.13. Viewing the associative algebra A as a pre-Lie algebra, the condition (12) means that the $F$-manifold admissible operation $*_{A}: A \times A \rightarrow A$ is a 2-cocycle of the pre-Lie algebra $\left(A,{ }_{A}\right)$ with the coefficients in the regular representation, i.e. $\mathrm{d}^{\mathrm{reg}}\left(*_{A}\right)=0$.

Theorem 3.14. Let $\left(A, \cdot_{A}, *_{A}\right)$ be an $F$-manifold-admissible algebra. Then $\left(A,{ }_{A},[-,-]_{A}\right)$ is an $F$-manifold algebra, where $[-,-]_{A}$ is given by (11).

Proof. We only need to verify the Hertling-Manin relation. By (12), we have

$$
\begin{aligned}
P_{x}(y, z)= & {\left[x, y \cdot_{A} z\right]_{A}-[x, y]_{A} \cdot{ }_{A} z-y \cdot_{A}[x, z]_{A} } \\
= & x *_{A}\left(y \cdot{ }_{A} z\right)-(y \cdot A z) *_{A} x-\left(x *_{A} y\right) \cdot_{A} z+\left(y *_{A} x\right) \cdot{ }_{A} z \\
& -y \cdot y\left(x *_{A} z\right)+y \cdot_{A}\left(z *_{A} x\right) \\
= & x *_{A}(y \cdot A z)-\left(x *_{A} y\right) \cdot{ }_{A} z-y \cdot_{A}\left(x *_{A} z\right)-\left(y \cdot{ }_{A} z\right) *_{A} x \\
& +\left(y *_{A} x\right) \cdot{ }_{A} z+y \cdot_{A}\left(z *_{A} x\right) \\
= & y *_{A}\left(x \cdot{ }_{A} z\right)-\left(y *_{A} x\right) \cdot A z-x \cdot_{A}\left(y *_{A} z\right)-\left(y \cdot{ }_{A} z\right) *_{A} x \\
& +\left(y *_{A} x\right) \cdot A z+y \cdot_{A}\left(z *_{A} x\right) .
\end{aligned}
$$

By this formula and (12), we have

$$
\begin{aligned}
& P_{x_{A} y}(z, w)=z *_{A}\left(\left(x \cdot_{A} y\right) \cdot_{A} w\right)-\left(z *_{A}\left(x \cdot_{A} y\right)\right) \cdot \cdot_{A} w-\left(x \cdot_{A} y\right) \cdot_{A}\left(z *_{A} w\right)-\left(z \cdot_{A} w\right) *_{A}\left(x \cdot_{A} y\right) \\
& +\left(z *_{A}\left(x \cdot_{A} y\right)\right) \cdot{ }_{A} w+z \cdot \cdot_{A}\left(w *_{A}\left(x \cdot_{A} y\right)\right) \\
& =z *_{A}\left(x \cdot \cdot_{A}(y \cdot A w)\right)-\left(\left(z *_{A} x\right) \cdot \cdot_{A} y-x \cdot_{A}\left(z *_{A} y\right)+x *_{A}\left(z \cdot{ }_{A} y\right)-\left(x *_{A} z\right) \cdot \cdot_{A} y\right. \\
& \left.-z \cdot{ }_{A}\left(x *_{A} y\right)\right) \cdot{ }_{A} w-\left(x \cdot_{A} y\right) \cdot{ }_{A}\left(z *_{A} w\right)-\left(\left(\left(z \cdot_{A} w\right) *_{A} x\right) \cdot{ }_{A} y+x \cdot_{A}\left(\left(z \cdot \cdot_{A} w\right) *_{A} y\right)\right. \\
& \left.+x *_{A}\left(\left(z \cdot{ }_{A} w\right) \cdot{ }_{A} y\right)-\left(x *_{A}\left(z \cdot{ }_{A} w\right) \cdot \cdot_{A} y\right)-\left(z \cdot_{A} w\right) \cdot{ }_{A}\left(x *_{A} y\right)\right)+\left(\left(z *_{A} x\right) \cdot \cdot_{A} y\right. \\
& \left.\left.+x \cdot_{A}\left(z *_{A} y\right)+x *_{A}\left(z \cdot \cdot_{A} y\right)-\left(x *_{A} z\right) \cdot{ }_{A} y-z \cdot_{A}\left(x *_{A} y\right)\right)\right) \cdot A w+\left(\left(w *_{A} x\right) \cdot{ }_{A} y\right. \\
& \left.+x \cdot{ }_{A}\left(w *_{A} y\right)+x *_{A}\left(w \cdot{ }_{A} y\right)-\left(x *_{A} w\right) \cdot \cdot_{A} y-w \cdot_{A}\left(x *_{A} y\right)\right) \cdot{ }_{A} z \\
& =y \cdot{ }_{A} P_{x}(z, w)+x \cdot A\left(-w \cdot{ }_{A}\left(z *_{A} y\right)-y \cdot{ }_{A}\left(z *_{A} w\right)-\left(z \cdot{ }_{A} w\right) *_{A} y+(z * y) \cdot{ }_{A} w\right. \\
& \left.+\left(w *_{A} y\right) \cdot_{A} z\right)+\left(z *_{A}\left(x \cdot_{A}\left(y \cdot_{A} w\right)\right)-\left(z *_{A} x\right) \cdot{ }_{A}\left(y \cdot_{A} w\right)\right. \\
& \left.-x *_{A}\left(z \cdot{ }_{A}\left(y \cdot{ }_{A} w\right)\right)+\left(x *_{A} z\right) \cdot \cdot_{A}\left(y \cdot{ }_{A} w\right)+z \cdot \cdot_{A}\left(x *_{A}\left(y \cdot{ }_{A} w\right)\right)\right) \\
& =y \cdot{ }_{A} P_{x}(z, w)+x \cdot A\left(-w \cdot A\left(z *_{A} y\right)-y \cdot{ }_{A}\left(z *_{A} w\right)-\left(z \cdot{ }_{A} w\right) *_{A} y+(z * y) \cdot{ }_{A} w\right. \\
& \left.+\left(w *_{A} y\right) \cdot{ }_{A} z+\right)+x \cdot A\left(z *_{A}(y \cdot A w)\right) \\
& =y \cdot{ }_{A} P_{x}(z, w)+x \cdot{ }_{A} P_{y}(z, w) .
\end{aligned}
$$

This shows that the Hertling-Manin relation holds.
Proposition 3.15. Let $(A, \cdot)$ be a commutative associative algebra with a derivation $D$. Then the new product

$$
x *_{a} y=x \cdot D(y)+a \cdot x \cdot y, \quad \forall x, y \in A
$$

makes $\left(A, \cdot, *_{a}\right)$ being an $F$-manifold-admissible algebra for any fixed $a \in \mathbb{K}$ or $a \in A$. In particular, for $a=0,\left(A, \cdot, *_{0}\right)$ is a PreLie-Com algebra. Furthermore, $(A, \cdot,[-,-])$ is an $F$ manifold algebra, where the bracket is given by

$$
[x, y]=x *_{a} y-y *_{a} x=x \cdot D(y)-y \cdot D(x), \quad \forall x, y \in A .
$$

Proof. It was shown that $\left(A, *_{a}\right)$ is a pre-Lie algebra for $a=0$ by S.I. Gel'fand [19], for $a \in \mathbb{K}$ by Filippov [17] and for $a \in A$ by Xu [35]. Thus $\left(A, *_{a}\right)$ is a Lie-admissible algebra. Furthermore, by the fact that $(A, \cdot)$ is a commutative associative algebra and $D$ is a derivation on it, we have

$$
x *_{a}(y \cdot z)-\left(x *_{a} y\right) \cdot z-y \cdot\left(x *_{a} z\right)
$$

$$
\begin{aligned}
& =x \cdot D(y \cdot z)+x \cdot(a \cdot y \cdot z)-(x \cdot D(y)+a \cdot x \cdot y) \cdot z-y \cdot(x \cdot D(z)+a \cdot x \cdot z) \\
& =-a \cdot x \cdot y \cdot z
\end{aligned}
$$

Similarly, we have

$$
y *_{a}(x \cdot z)-\left(y *_{a} x\right) \cdot z-x \cdot\left(y *_{a} z\right)=-a \cdot x \cdot y \cdot z
$$

Thus

$$
x *_{a}(y \cdot z)-\left(x *_{a} y\right) \cdot z-y \cdot\left(x *_{a} z\right)=y *_{a}(x \cdot z)-\left(y *_{a} x\right) \cdot z-x \cdot\left(y *_{a} z\right)
$$

which implies that $\left(A, \cdot, *_{a}\right)$ is an $F$-manifold-admissible algebra for any fixed $a \in \mathbb{K}$ or $a \in A$. It is obvious that $\left(A, \cdot, *_{0}\right)$ is a PreLie-Com algebra. By Theorem 3.14, $(A, \cdot,[-,-])$ is an $F$ manifold algebra.

Example 3.16. Let $A$ be the algebra of polynomials in $n$ variables. Set $D=\sum_{i=1}^{n} f_{i} \partial_{x_{i}} \in A \mathcal{D}_{n}$ for $f_{i} \in A, \partial_{x_{i}} \in \mathcal{D}_{n}$. Fixed a polynomial $\kappa \in A$, define $\cdot: A \times A \longrightarrow A$ and $*_{\kappa}: A \times A \longrightarrow A$ by

$$
\begin{aligned}
g \cdot h & =g h \\
g *_{\kappa} h & =g D(h)+\kappa g h=\sum_{i=1}^{n} g f_{i} \partial_{x_{i}}(h)+\kappa g h, \quad \forall g, h \in A .
\end{aligned}
$$

Then by Proposition $3.15,\left(A, \cdot, *_{k}\right)$ is an $F$-manifold-admissible algebra. Furthermore, $(A, \cdot,[-,-])$ is an $F$-manifold algebra, where the bracket is given by

$$
[g, h]=\sum_{i=1}^{n} f_{i}\left(g \partial_{x_{i}}(h)-h \partial_{x_{i}}(g)\right), \quad \forall g, h \in A
$$

Example 3.17. Let $A$ be a 2 -dimensional vector space with basis $\left\{e_{1}, e_{2}\right\}$. Then $A$ with the non-zero multiplication

$$
e_{1} \cdot e_{1}=e_{1}, \quad e_{1} \cdot e_{2}=e_{2} \cdot e_{1}=e_{2}
$$

is a commutative associative algebra. It is straightforward to check that all derivations on $(A, \cdot)$ are determined by

$$
D\left(e_{2}\right)=a e_{2}, \quad \forall a \in \mathbb{K}
$$

Thus by Proposition 3.15, $(A, \cdot,[-,-])$ with the bracket

$$
\left[e_{1}, e_{2}\right]=a e_{2}
$$

is an $F$-manifold algebra.
Example 3.18. Let $A$ be a 3-dimensional vector space with basis $\left\{e_{1}, e_{2}, e_{3}\right\}$. Then $A$ with the non-zero multiplication

$$
e_{2} \cdot e_{3}=e_{3} \cdot e_{2}=e_{1}, \quad e_{3} \cdot e_{3}=e_{2}
$$

is a commutative associative algebra. It is straightforward to check that all derivations on $(A, \cdot)$ are determined by

$$
D\left(e_{1}\right)=3 a e_{1}, \quad D\left(e_{2}\right)=2 b e_{1}+2 a e_{2}, \quad D\left(e_{3}\right)=c e_{1}+b e_{2}+a e_{3}, \quad \forall a, b, c \in \mathbb{K}
$$

Thus by Proposition $3.15,(A, \cdot,[-,-])$ with the bracket

$$
\left[e_{2}, e_{3}\right]=-a e_{1}
$$

is an $F$-manifold algebra.
3.2. Pre-Lie deformation quantization of commutative pre-Lie algebras. In this subsection, we introduce the notion of pre-Lie formal deformations of commutative associative algebras (that is, commutative pre-Lie algebras) and show that $F$-manifold algebras are the corresponding semi-classical limits. This illustrates that $F$-manifold algebras are the same to pre-Lie algebras as Poisson algebras to associative algebras. Furthermore, we show that pre-Lie infinitesimal deformations and extensions of pre-Lie $n$-deformations to pre-Lie ( $n+1$ )-deformations of a commutative associative algebra $A$ are classified by the second and the third cohomology group of the pre-Lie algebra $A$ (view the commutative associative algebra $A$ as a pre-Lie algebra).

Let $\left(A,{ }_{A}\right)$ be a commutative associative algebra. Recall that an associative formal deformation of $A$ is a sequence of bilinear maps $\mu_{n}: A \times A \rightarrow A$ for $n \geqslant 0$ with $\mu_{0}$ being the commutative associative algebra product ${ }_{A}$ on $A$, such that the $\mathbb{K}[[h]]$-bilinear product ${ }_{\hbar}$ on $A[[\hbar]]$ determined by

$$
x{ }_{\hbar} y=\sum_{n=0}^{\infty} \hbar^{n} \mu_{n}(x, y), \quad \forall x, y \in A
$$

is associative, where $A[[\hbar]]$ is the set of formal power series of $\hbar$ with coefficients in $A$. Define

$$
\{x, y\}=\mu_{1}(x, y)-\mu_{1}(y, x), \quad \forall x, y \in A .
$$

It is well known that $\left(A,{ }_{A},\{-,-\}\right)$ is a Poisson algebra, called the semi-classical limit of ( $A[[\hbar]], \cdot \hbar$ ).

Since an associative algebra can be regarded as a pre-Lie algebra, one may look for formal deformations of a commutative associative algebra into pre-Lie algebras, that is, in the aforementioned associative formal deformation, replace the associative product $\cdot \bar{h}$ by the preLie product, and wonder what additional structure will appear on $A$. On the other hand, such an approach can be also seen as formal deformations of a commutative pre-Lie algebra into (non-commutative) pre-Lie algebras, which is completely parallel to the associative formal deformations of a commutative associative algebra into (non-commutative) associative algebras. Surprisingly, we find that this is the structure of the $F$-manifold algebra. Now we give the definition of a pre-Lie formal deformation of a commutative associative algebra.

Definition 3.19. Let $\left(A,{ }_{A}\right)$ be a commutative associative algebra. A pre-Lie formal deformation of $A$ is a sequence of bilinear maps $\mu_{k}: A \times A \rightarrow A$ for $k \geqslant 0$ with $\mu_{0}$ being the commutative associative algebra product ${ }_{A}$ on $A$, such that the $\mathbb{K}[[h]]$-bilinear product ${ }_{\hbar}$ on $A[[\hbar]]$ determined by

$$
x_{\hbar} y=\sum_{n=0}^{\infty} \hbar^{n} \mu_{n}(x, y), \quad \forall x, y \in A
$$

is a pre-Lie algebra product.
Note that the rule of pre-Lie algebra product ${ }^{\hbar}$ on $A[[\hbar]]$ is equivalent to

$$
\begin{equation*}
\sum_{i+j=k}\left(\mu_{i}\left(\mu_{j}(x, y), z\right)-\mu_{i}\left(x, \mu_{j}(y, z)\right)\right)=\sum_{i+j=k}\left(\mu_{i}\left(\mu_{j}(y, x), z\right)-\mu_{i}\left(y, \mu_{j}(x, z)\right)\right), \quad \forall k \geqslant 0 . \tag{13}
\end{equation*}
$$

Theorem 3.20. Let $\left(A,{ }_{A}\right)$ be a commutative associative algebra and $\left(A[[\hbar]],{ }_{\hbar}\right)$ a pre-Lie formal deformation of $A$. Define

$$
[x, y]_{A}=\mu_{1}(x, y)-\mu_{1}(y, x), \quad \forall x, y \in A .
$$

Then $\left(A, \cdot_{A},[-,-]_{A}\right)$ is an $F$-manifold algebra. The $F$-manifold algebra $\left(A, \cdot_{A},[-,-]_{A}\right)$ is called the semi-classical limit of $(A[[\hbar]], \cdot \hbar)$. The pre-Lie algebra $\left(A[[\hbar]],{ }^{\hbar}\right)$ is called a pre-Lie deformation quantization of $\left(A,{ }_{A}\right)$.
Proof. Define the bracket $[-,-]_{\hbar}$ on $A[[\hbar]]$ by

$$
[x, y]_{\hbar}=x \cdot \hbar y-y \cdot \hbar x=\hbar[x, y]_{A}+\hbar^{2}\left(\mu_{2}(x, y)-\mu_{2}(y, x)\right)+\cdots, \quad \forall x, y \in A .
$$

By the fact that $\left(A[[\hbar]],{ }^{\hbar}\right)$ is a pre-Lie algebra, $\left(A[[\hbar]],[-,-]_{\hbar}\right)$ is a Lie algebra. The $\hbar^{2}$-terms of the Jacobi identity for $[-,-]_{\hbar}$ gives the Jacobi identity for $[-,-]_{A}$. Thus $\left(A,[-,-]_{A}\right)$ is a Lie algebra.

For $k=1$ in (13), by the commutativity of $\mu_{0}$, we have
$\mu_{0}\left(\mu_{1}(x, y), z\right)-\mu_{0}\left(x, \mu_{1}(y, z)\right)-\mu_{1}\left(x, \mu_{0}(y, z)\right)=\mu_{0}\left(\mu_{1}(y, x), z\right)-\mu_{0}\left(y, \mu_{1}(x, z)\right)-\mu_{1}\left(y, \mu_{0}(x, z)\right)$.
This is just the equality (12) with $x \cdot{ }_{A} y=\mu_{0}(x, y)$ and $x *_{A} y=\mu_{1}(x, y)$ for $x, y \in A$. Thus $\left(A,{ }_{A}, *_{A}\right)$ is an $F$-manifold-admissible algebra. By Theorem 3.14, $\left(A, \cdot_{A},[-,-]_{A}\right)$ is an $F$-manifold algebra.

In the sequel, we study pre-Lie $n$-deformations and pre-Lie infinitesimal deformations of commutative associative algebras.
Definition 3.21. Let $\left(A,{ }_{A}\right)$ be a commutative associative algebra. A pre-Lie $n$-deformation of $A$ is a sequence of bilinear maps $\mu_{i}: A \times A \rightarrow A$ for $0 \leq i \leq n$ with $\mu_{0}$ being the commutative associative algebra product ${ }_{A}$ on $A$, such that the $\mathbb{K}[[h]] /\left(\hbar^{n+1}\right)$-bilinear product ${ }_{\hbar}$ on $A[[\hbar]] /\left(\hbar^{n+1}\right)$ determined by

$$
x \cdot \hbar y=\sum_{k=0}^{n} \hbar^{n} \mu_{k}(x, y), \quad \forall x, y \in A
$$

is a pre-Lie algebra product.
We call a pre-Lie 1-deformation of a commutative associative algebra $\left(A,{ }_{A}\right)$ a pre-Lie infinitesimal deformation and denote it by $\left(A, \mu_{1}\right)$.

By direct calculations, $\left(A, \mu_{1}\right)$ is a pre-Lie infinitesimal deformation of a commutative associative algebra $\left(A,{ }_{A}\right)$ if and only if for all $x, y, z \in A$
$\mu_{1}(x, y) \cdot{ }_{A} z-x \cdot{ }_{A} \mu_{1}(y, z)-\mu_{1}\left(x, y \cdot{ }_{A} z\right)=\mu_{1}(y, x) \cdot{ }_{A} z-y \cdot{ }_{A} \mu_{1}(x, z)-\mu_{1}\left(y, x \cdot{ }_{A} z\right)$.
Equation (14) means that $\mu_{1}$ is a 2-cocycle for the pre-Lie algebra $\left(A,{ }_{A}\right)$, i.e. $\mathrm{d}^{\text {reg }} \mu_{1}=0$.
Two pre-Lie infinitesimal deformations $A_{\hbar}=\left(A, \mu_{1}\right)$ and $A_{\hbar}^{\prime}=\left(A, \mu_{1}^{\prime}\right)$ of a commutative associative algebra $\left(A,{ }_{A}\right)$ are said to be equivalent if there exists a family of pre-Lie algebra homomorphisms Id $+\hbar \varphi: A_{\hbar} \longrightarrow A_{\hbar}^{\prime}$ modulo $\hbar^{2}$. A pre-Lie infinitesimal deformation is said to be trivial if there exists a family of pre-Lie algebra homomorphisms Id $+\hbar \varphi: A_{\hbar} \longrightarrow\left(A,{ }_{A}\right)$ modulo $\hbar^{2}$.

By direct calculations, $A_{\hbar}$ and $A_{\hbar}^{\prime}$ are equivalent pre-Lie infinitesimal deformations if and only if

$$
\begin{equation*}
\mu_{1}(x, y)-\mu_{1}^{\prime}(x, y)=x \cdot{ }_{A} \varphi(y)+\varphi(x) \cdot{ }_{A} y-\varphi\left(x \cdot{ }_{A} y\right) . \tag{15}
\end{equation*}
$$

Equation (15) means that $\mu_{1}-\mu_{1}^{\prime}=\mathrm{d}^{\text {reg }} \varphi$. Thus we have
Theorem 3.22. There is a one-to-one correspondence between the space of equivalence classes of pre-Lie infinitesimal deformations of $A$ and the second cohomology group $H_{\mathrm{reg}}^{2}(A, A)$.

It is routine to check that
Proposition 3.23. Let $\left(A,{ }_{A}\right)$ be a commutative associative algebra such that $H_{\mathrm{reg}}^{2}(A, A)=0$. Then all pre-Lie infinitesimal deformations of $A$ are trivial.

Definition 3.24. Let $\left\{\mu_{1}, \cdots, \mu_{n}\right\}$ be a pre-Lie $n$-deformation of a commutative associative algebra $\left(A,{ }^{\prime}\right)$. A pre-Lie $(n+1)$-deformation of a commutative associative algebra $\left(A,{ }^{A}\right)$ given by $\left\{\mu_{1}, \cdots, \mu_{n}, \mu_{n+1}\right\}$ is called an extension of the pre-Lie $n$-deformation given by $\left\{\mu_{1}, \cdots, \mu_{n}\right\}$.

Theorem 3.25. For any pre-Lie $n$-deformation of a commutative associative algebra $\left(A,{ }_{A}\right)$, the $\Theta_{n} \in \operatorname{Hom}\left(\otimes^{3} \mathfrak{g}, \mathfrak{g}\right)$ defined by

$$
\begin{equation*}
\Theta_{n}(x, y, z)=\sum_{i+j=n+1, i, j \geq 1}\left(\mu_{i}\left(\mu_{j}(x, y), z\right)-\mu_{i}\left(x, \mu_{j}(y, z)\right)-\mu_{i}\left(\mu_{j}(y, x), z\right)+\mu_{i}\left(y, \mu_{j}(x, z)\right)\right) . \tag{16}
\end{equation*}
$$

is a cocycle, i.e. $\mathrm{d}^{\mathrm{reg}} \Theta_{n}=0$.
Moreover, the pre-Lie n-deformation $\left\{\mu_{1}, \cdots, \mu_{n}\right\}$ extends into some pre-Lie ( $n+1$ )-deformation if and only if $\left[\Theta_{n}\right]=0$ in $H_{\mathrm{reg}}^{3}(A, A)$.

Proof. It is obvious that

$$
\Theta_{n}(x, y, z)=-\Theta_{n}(y, x, z), \quad \forall x, y, z \in A .
$$

Thus $\Theta_{n}$ is an element of $C^{3}(A, A)$. It is straightforward to check that the cochain $\Theta_{n} \in C^{3}(A, A)$ is closed.

Assume that the pre-Lie $(n+1)$-deformation of a commutative associative algebra $\left(A,{ }_{A}\right)$ given by $\left\{\mu_{1}, \cdots, \mu_{n}, \mu_{n+1}\right\}$ is an extension of the pre-Lie $n$-deformation given by $\left\{\mu_{1}, \cdots, \mu_{n}\right\}$, then we have

$$
\begin{aligned}
& x \cdot{ }_{A} \mu_{n+1}(y, z)-y \cdot{ }_{A} \mu_{n+1}(x, z)+\mu_{n+1}(y, x) \cdot{ }_{A} z-\mu_{n+1}(x, y) \cdot{ }_{A} z+\mu_{n+1}(y, x) \cdot{ }_{A} z \\
& \quad-\mu_{n+1}(x, y) \cdot{ }_{A} z=\sum_{i+j=n+1, i, j \geq 1}\left(\mu_{i}\left(\mu_{j}(x, y), z\right)-\mu_{i}\left(x, \mu_{j}(y, z)\right)-\mu_{i}\left(\mu_{j}(y, x), z\right)+\mu_{i}\left(y, \mu_{j}(x, z)\right)\right) .
\end{aligned}
$$

It is obvious that the right-hand side of the above equality is just $\Theta_{n}(x, y, z)$. We can rewrite the above equality as

$$
\mathrm{d}^{\mathrm{reg}} \mu_{n+1}(x, y, z)=\Theta_{n}(x, y, z)
$$

We conclude that, if a pre-Lie $n$-deformation of a commutative associative algebra $\left(A,{ }_{A}\right)$ extends to a pre-Lie $(n+1)$-deformation, then $\Theta_{n}$ is coboundary.

Conversely, if $\Theta_{n}$ is coboundary, then there exists an element $\psi \in C^{2}(A, A)$ such that

$$
\mathrm{d}^{\mathrm{reg}} \psi(x, y, z)=\Theta_{n}(x, y, z) .
$$

It is not hard to check that $\left\{\mu_{1}, \cdots, \mu_{n}, \mu_{n+1}\right\}$ with $\mu_{n+1}=\psi$ generates a pre-Lie $(n+1)$ deformation of $\left(A,{ }_{A}\right)$ and thus this pre-Lie $(n+1)$-deformation is an extension of the pre-Lie $n$-deformation given by $\left\{\mu_{1}, \cdots, \mu_{n}\right\}$.

## 4. Pre- $F$-manifold algebras, Rota-Baxter operators and $O$-operators on $F$-manifold algebras

In this section, first we study representations of an $F$-manifold algebra. Then we introduce the notions of pre- $F$-manifold algebras and Rota-Baxter operators (more generally $O$-operators) on an $F$-manifold algebra. We show that on one hand, an $O$-operator on an $F$-manifold algebra
gives a pre- $F$-manifold algebra, and on the other hand, a pre- $F$-manifold algebra naturally gives an $O$-operator on the sub-adjacent $F$-manifold algebra. More examples on pre- $F$-manifold algebras and $F$-manifold algebras are given.
4.1. Representations of $F$-manifold algebras. In this subsection, we introduce the notion of representations of $F$-manifold algebras.

Let $\left(A,{ }_{A}\right)$ be a commutative associative algebra. Recall that a representation of $A$ on a vector space $V$ is a linear map $\mu: A \longrightarrow \mathfrak{g l}(V)$ such that $\mu\left(x{ }_{A} y\right)=\mu(x) \circ \mu(y)$ for any $x, y \in A$. We will denote a representation of $A$ by $(V ; \mu)$. Let $(V ; \mu)$ be a representation of a commutative associative algebra $\left(A,{ }_{A}\right)$. Define $\mu^{*}: A \longrightarrow \mathfrak{g l}\left(V^{*}\right)$ by

$$
\left\langle\mu^{*}(x) \alpha, v\right\rangle=-\langle\alpha, \mu(x) v\rangle, \quad \forall x \in A, \alpha \in V^{*}, v \in V
$$

Then $\left(V^{*} ;-\mu^{*}\right)$ is a representation of $\left(A,{ }_{A}\right)$.
Example 4.1. Let $\left(A,{ }_{A}\right)$ be a commutative associative algebra. Let $\mathcal{L}_{x}$ denote the multiplication operator, that is, $\mathcal{L}_{x} y=x \cdot_{A} y$, for all $x, y \in A$. Then $(A ; \mathcal{L})$ is a representation of $\left(A,{ }_{A}\right)$, called the regular representation. Furthermore, $\left(A^{*} ;-\mathcal{L}^{*}\right)$ is also a representation of $\left(A,{ }_{A}\right)$.

Similarly, let $\left(\mathfrak{g},[-,-]_{\mathfrak{g}}\right)$ be a Lie algebra and $V$ a vector space. Let $\rho: \mathfrak{g} \rightarrow \mathfrak{g l}(V)$ be a linear map. The pair $(V ; \rho)$ is called a representation of $\mathfrak{g}$ if for all $x, y \in \mathfrak{g}$, we have $\rho\left([x, y]_{\mathfrak{g}}\right)=$ $[\rho(x), \rho(y)]$. Let $(V ; \rho)$ be a representation of a Lie algebra $\left(\mathfrak{g},[-,-]_{\mathfrak{g}}\right)$. Define $\rho^{*}: \mathfrak{g} \longrightarrow \mathfrak{g l}\left(V^{*}\right)$ by

$$
\left\langle\rho^{*}(x)(\alpha), v\right\rangle=-\langle\alpha, \rho(x)(v)\rangle, \quad \forall x \in \mathfrak{g}, \alpha \in V^{*}, v \in V .
$$

Then $\left(V^{*} ; \rho^{*}\right)$ is a representation of $\left(\mathfrak{g},[-,-]_{\mathfrak{g}}\right)$.
Example 4.2. Define ad $: \mathfrak{g} \rightarrow \mathfrak{g l}(\mathfrak{g})$ by $\operatorname{ad}_{x} y=[x, y]_{\mathfrak{g}}$ for all $x, y \in \mathfrak{g}$. Then $(\mathfrak{g} ; \mathrm{ad})$ is a representation of $\left(\mathfrak{g},[-,-]_{\mathfrak{g}}\right)$, called the adjoint representation. Furthermore, $\left(\mathfrak{g}^{*} ;\right.$ ad $\left.{ }^{*}\right)$ is also a representation of $\left(\mathfrak{g},[-,-]_{\mathfrak{g}}\right)$.

Definition 4.3. Let $\left(A,{ }_{A},[-,-]_{A}\right)$ be an $F$-manifold algebra. $A$ representation of $A$ is a triple $(V ; \rho, \mu)$ such that $(V ; \rho)$ is a representation of the Lie algebra $\left(A,[-,-]_{A}\right)$ and $(V ; \mu)$ is a representation of the commutative associative algebra $\left(A,{ }_{A}\right)$ satisfying

$$
\begin{align*}
R_{\rho, \mu}(x \cdot A y, z) & =\mu(x) \circ R_{\rho, \mu}(y, z)+\mu(y) \circ R_{\rho, \mu}(x, z),  \tag{17}\\
\mu\left(P_{x}(y, z)\right) & =S_{\rho, \mu}(y, z) \circ \mu(x)-\mu(x) \circ S_{\rho, \mu}(y, z), \tag{18}
\end{align*}
$$

where $R_{\rho, \mu}, S_{\rho, \mu}: A \otimes A \rightarrow \mathfrak{g l}(V)$ are defined by

$$
\begin{align*}
& R_{\rho, \mu}(x, y)=\rho(x) \circ \mu(y)-\mu(y) \circ \rho(x)-\mu\left([x, y]_{A}\right),  \tag{19}\\
& S_{\rho, \mu}(x, y)=\mu(x) \circ \rho(y)+\mu(y) \circ \rho(x)-\rho\left(x \cdot_{A} y\right) \tag{20}
\end{align*}
$$

for all $x, y, z \in A$.
It is straightforward to obtain the following conclusion.
Proposition 4.4. Let $\left(A,{ }_{A},[-,-]_{A}\right)$ be an $F$-manifold algebra and $(V ; \rho, \mu)$ a representation. Then $\left(A \oplus V, \cdot{ }_{\mu},[-,-]_{\rho}\right)$ is an $F$-manifold algebra, where $(A \oplus V, \cdot \mu)$ is the semi-direct product commutative associative algebra $A \ltimes_{\mu} V$, i.e.

$$
\left(x_{1}+v_{1}\right) \cdot \mu\left(x_{2}+v_{2}\right)=x_{1} \cdot{ }_{A} x_{2}+\mu\left(x_{1}\right) v_{2}+\mu\left(x_{2}\right) v_{1}, \quad \forall x_{1}, x_{2} \in A, v_{1}, v_{2} \in V
$$

and $\left(A \oplus V,[-,-]_{\rho}\right)$ is the semi-direct product Lie algebra $A \ltimes_{\rho} V$, i.e.

$$
\left[x_{1}+v_{1}, x_{2}+v_{2}\right]_{\rho}=\left[x_{1}, x_{2}\right]_{g}+\rho\left(x_{1}\right)\left(v_{2}\right)-\rho\left(x_{2}\right)\left(v_{1}\right), \quad \forall x_{1}, x_{2} \in A, v_{1}, v_{2} \in V
$$

Example 4.5. Let $(V ; \rho, \mu)$ be a representation of a Poisson algebra $\left(P,{ }_{P},\{-,-\}_{P}\right)$, i.e. $(V ; \rho)$ is a representation of the Lie algebra $\left(P,\{-,-\}_{P}\right)$ and $(V ; \mu)$ is a representation of the commutative associative algebra $\left(P,{ }_{P}\right)$ satisfying

$$
\begin{align*}
\rho(x) \circ \mu(y)-\mu(y) \circ \rho(x)-\mu\left([x, y]_{A}\right) & =0,  \tag{21}\\
\mu(x) \circ \rho(y)+\mu(y) \circ \rho(x)-\rho\left(x \cdot_{A} y\right) & =0, \quad \forall x, y, z \in P . \tag{22}
\end{align*}
$$

Then $(V ; \rho, \mu)$ is also a representation of the $F$-manifold algebra given by this Poisson algebra $P$.

Let $(V ; \rho, \mu)$ be a representation of a Poisson algebra $\left(P,{ }_{P},\{-,-\}_{P}\right)$. Then the triple $\left(V^{*} ; \rho^{*},-\mu^{*}\right)$ is also a representation of $P$. But $F$-manifold algebras do not have this property. In fact, we have

Proposition 4.6. Let $\left(A,{ }_{A},[-,-]_{A}\right)$ be an $F$-manifold algebra. If the triple $(V ; \rho, \mu)$, where $(V ; \rho)$ is a representation of the Lie algebra $\left(A,[-,-]_{A}\right)$ and $(V ; \mu)$ is a representation of the commutative associative algebra $\left(A,{ }_{A}\right)$, satisfies

$$
\begin{array}{r}
R_{\rho, \mu}(x \cdot A y, z)=R_{\rho, \mu}(y, z) \circ \mu(x)+R_{\rho, \mu}(x, z) \circ \mu(y) \\
\mu\left(P_{x}(y, z)\right)=T_{\rho, \mu}(y, z) \circ \mu(x)-\mu(x) \circ T_{\rho, \mu}(y, z) \tag{24}
\end{array}
$$

where $R_{\rho, \mu}$ is given by (19) and $T_{\rho, \mu}: A \otimes A \rightarrow \mathfrak{g l}(V)$ is defined by

$$
\begin{equation*}
T_{\rho, \mu}(x, y)=\rho(y) \circ \mu(x)+\rho(x) \circ \mu(y)-\rho\left(x \cdot_{A} y\right), \quad \forall x, y \in A, \tag{25}
\end{equation*}
$$

then $\left(V^{*} ; \rho^{*},-\mu^{*}\right)$ is a representation of $A$.
Proof. By direct calculations, for all $x, y \in A, v \in V, \alpha \in V^{*}$, we have

$$
\left\langle R_{\rho^{*},-\mu^{*}}(x, y)(\alpha), v\right\rangle=\left\langle\alpha, R_{\rho, \mu}(v)\right\rangle, \quad\left\langle S_{\rho^{*},-\mu^{*}}(x, y)(\alpha), v\right\rangle=\left\langle\alpha, T_{\rho, \mu}(v)\right\rangle .
$$

Furthermore, we have

$$
\begin{aligned}
& \left\langle R_{\rho^{*},-\mu^{*}}\left(x \cdot_{A} y, z\right)(\alpha)+\mu^{*}(x) R_{\rho^{*},-\mu^{*}}(y, z)(\alpha)+\mu^{*}(y) R_{\rho^{*},-\mu^{*}}(x, z)(\alpha), v\right\rangle \\
= & \left\langle\alpha, R_{\rho, \mu}\left(x \cdot_{A} y, z\right)(v)-R_{\rho, \mu}(y, z) \mu(x)(v)-R_{\rho, \mu}(x, z) \mu(y)(v)\right\rangle
\end{aligned}
$$

and

$$
\begin{aligned}
& \left\langle-\mu^{*}\left(P_{x}(y, z)\right)(\alpha)+S_{\rho^{*},-\mu^{*}}(y, z) \mu^{*}(x)(\alpha)+\mu^{*}(x) S_{\rho^{*},-\mu^{*}}(y, z)(\alpha), v\right\rangle \\
= & \left\langle\alpha, \mu\left(P_{x}(y, z)\right)(v)-T_{\rho, \mu}(y, z) \mu(x)(v)+\mu(x) T_{\rho, \mu}(y, z)(v)\right\rangle .
\end{aligned}
$$

By the hypothesis and the definition of representation, the conclusion follows immediately.
Example 4.7. Let $\left(A, \cdot_{A},[-,-]_{A}\right)$ be an $F$-manifold algebra. Then $(A ; \mathrm{ad}, \mathcal{L})$ is a representation of $A$, which is also called the regular representation. Furthermore, if the $F$-manifold algebra also satisfies the following relations:

$$
\begin{align*}
P_{x_{A} y}(z, w) & =P_{y}\left(z, x \cdot{ }_{A} w\right)+P_{x}\left(z, y \cdot{ }_{A} w\right),  \tag{26}\\
P_{x}(y, z) \cdot{ }_{A} w & =x \cdot{ }_{A} Q(y, z, w)-Q\left(y, z, x \cdot{ }_{A} w\right), \quad \forall x, y, z, w \in A \tag{27}
\end{align*}
$$

where $Q: \otimes^{3} \rightarrow A$ is defined by

$$
Q(x, y, z)=\left[x \cdot \cdot_{A} y, z\right]_{A}+\left[y \cdot{ }_{A} z, x\right]_{A}+\left[z \cdot{ }_{A} x, y\right]_{A} .
$$

Then $\left(A^{*} ; \mathrm{ad}^{*},-\mathcal{L}^{*}\right)$ is a representation of $A$.
Definition 4.8. A coherence $F$-manifold algebra is an $F$-manifold algebra such that (26) and (27) hold.

Proposition 4.9. Let $\left(A, \cdot_{A},[-,-]_{A}\right)$ be an $F$-manifold algebra. Suppose that there is a nondegenerate symmetric bilinear form $\mathfrak{B}$ such that $\mathfrak{B}$ is invariant in the following sense

$$
\begin{equation*}
\mathfrak{B}\left(x \cdot{ }_{A} y, z\right)=\mathfrak{B}\left(x, y \cdot{ }_{A} z\right), \quad \mathfrak{B}\left([x, y]_{A}, z\right)=\mathfrak{B}\left(x,[y, z]_{A}\right), \quad \forall x, y, z \in A . \tag{28}
\end{equation*}
$$

Then $\left(A,{ }^{A},[-,-]_{A}\right)$ is a coherence $F$-manifold algebra.
Proof. By the invariance of $\mathfrak{B}$, we have

$$
\mathfrak{B}\left(P_{x}(y, z), w\right)=\mathfrak{B}\left(z, P_{x}(y, w)\right)=\mathfrak{B}(x, Q(y, z, w)), \quad \forall x, y, z, w \in P .
$$

By the above relations, for $x, y, z, w_{1}, w_{2} \in P$, we have

$$
\begin{aligned}
& \mathfrak{B}\left(P_{x \cdot A y}\left(z, w_{1}\right)-P_{y}\left(z, x \cdot{ }_{A} w_{1}\right)-P_{x}\left(z, y \cdot{ }_{A} w_{1}\right), w_{2}\right) \\
= & \mathfrak{B}\left(w_{1}, P_{x \cdot A}\left(z, w_{2}\right)-x \cdot{ }_{A} P_{y}\left(z, w_{2}\right)-y \cdot{ }_{A} P_{x}\left(z, w_{2}\right)\right)
\end{aligned}
$$

and

$$
\begin{aligned}
& \mathfrak{B}\left(P_{x}(y, z) \cdot{ }_{A} w_{1}-x \cdot{ }_{A} Q\left(y, z, w_{1}\right)+Q\left(y, z, x \cdot{ }_{A} w\right), w_{2}\right) \\
= & \mathfrak{B}\left(w_{1},-P_{x \cdot A}\left(z, w_{2}\right)+x \cdot A P_{y}\left(z, w_{2}\right)+y \cdot{ }_{A} P_{x}\left(z, w_{2}\right)\right) .
\end{aligned}
$$

By the fact that $A$ is an $F$-manifold algebra and $\mathfrak{B}$ is nondegenerate, we deduce that (26) and (27) hold. Thus $\left(A, \cdot_{A},[-,-]_{A}\right)$ is a coherence $F$-manifold algebra.
4.2. Pre- $F$-manifold algebras. Recall that a Zinbiel algebra is a pair $(A, \diamond)$, where $A$ is a vector space, and $\diamond: A \otimes A \longrightarrow A$ is a bilinear multiplication satisfying that for all $x, y, z \in A$,

$$
\begin{equation*}
x \diamond(y \diamond z)=(y \diamond x) \diamond z+(x \diamond y) \diamond z . \tag{29}
\end{equation*}
$$

Lemma 4.10. Let $(A, \diamond)$ be a Zinbiel algebra. Then $(A, \cdot)$ is a commutative associative algebra, where $x \cdot y=x \diamond y+y \diamond x$. Moreover, for $x \in A$, define $\mathfrak{Z}_{x}: A \longrightarrow \operatorname{gl}(A)$ by

$$
\begin{equation*}
\mathfrak{L}_{x} y=x \diamond y, \quad \forall y \in A \tag{30}
\end{equation*}
$$

Then $(A ; \mathfrak{R})$ is a representation of the commutative associative algebra $(A, \cdot)$.
Now we are ready to give the main notion in this subsection.
Definition 4.11. $A$ pre- $F$-manifold algebra is a triple $(A, \diamond, *$, where $(A, \diamond)$ is a Zinbiel algebra and $(A, *)$ is a pre-Lie algebra, such that the following compatibility conditions hold:

$$
\begin{array}{r}
F_{1}(x \cdot y, z, w)=x \diamond F_{1}(y, z, w)+y \diamond F_{1}(x, z, w), \\
\left(F_{1}(x, y, z)+F_{1}(x, z, y)+F_{2}(y, z, x)\right) \diamond w=F_{2}(y, z, x \diamond w)-x \diamond F_{2}(y, z, w) \tag{32}
\end{array}
$$

for all $x, y, z, w \in A$. Here $F_{1}, F_{2}: \otimes^{3} A \longrightarrow A$ are defined by

$$
\begin{align*}
& F_{1}(x, y, z)=x *(y \diamond z)-y \diamond(x * z)-[x, y] \diamond z,  \tag{33}\\
& F_{2}(x, y, z)=x \diamond(y * z)+y \diamond(x * z)-(x \cdot y) * z \tag{34}
\end{align*}
$$

and the operation $\cdot$ and bracket $[-,-]$ are defined by

$$
\begin{equation*}
x \cdot y=x \diamond y+y \diamond x, \quad[x, y]=x * y-y * x . \tag{35}
\end{equation*}
$$

Remark 4.12. If $F_{1}$ and $F_{2}$ vanish in the definition of a pre- $F$-manifold algebra $(A, \diamond, *)$, then we obtain Aguiar's notion of a pre-Poisson algebra. See []] for more details.

Theorem 4.13. Let $(A, \diamond, *)$ be a pre-F-manifold algebra. Then
(i) $(A, \cdot,[-,-])$ is an $F$-manifold algebra, where the operation $\cdot$ and bracket $[-,-]$ are given by (35), which is called the sub-adjacent $F$-manifold algebra of $(A, \diamond, *)$ and denoted by $A^{c}$.
(ii) $(A ; L, \mathfrak{Z})$ is a representation of the sub-adjacent $F$-manifold algebras $A^{c}$, where $L$ and $\mathfrak{L}$ are given by (1) and (30), respectively.

Proof. (i) By Lemma 2.3 and Lemma 4.10, we deduce that $(A, \cdot)$ is a commutative associative algebra and $(A,[-,-])$ is a Lie algebra. By direct calculations, we obtain

$$
\begin{equation*}
P_{x}(y, z)=F_{1}(x, y, z)+F_{1}(x, z, y)+F_{2}(y, z, x), \quad \forall x, y, z \in A . \tag{36}
\end{equation*}
$$

By (31), (32) and (36), we have

$$
\begin{aligned}
& P_{x \cdot y}(z, w)-x \cdot P_{y}(z, w)-y \cdot P_{x}(z, w) \\
= & F_{1}(x \cdot y, z, w)+F_{1}(x \cdot y, w, z)+F_{2}(z, w, x \cdot y)-x \cdot\left(F_{1}(y, z, w)+F_{1}(y, w, z)+F_{2}(z, w, y)\right) \\
& -y \cdot\left(F_{1}(x, z, w)+F_{1}(x, w, z)+F_{2}(z, w, x)\right) \\
= & \left(F_{1}(x \cdot y, z, w)-x \diamond F_{1}(y, z, w)-y \diamond F_{1}(x, z, w)\right) \\
& +\left(F_{1}(x \cdot y, w, z)-x \diamond F_{1}(y, w, z)-y \diamond F_{1}(x, w, z)\right) \\
& +\left(F_{2}(z, w, x \diamond y)-F_{1}(x, z, w) \diamond y+F_{1}(x, w, z) \diamond y+F_{2}(z, w, x) \diamond y+x \diamond F_{2}(z, w, y)\right) \\
& +\left(F_{2}(z, w, y \diamond x)-F_{1}(y, z, w) \diamond x+F_{1}(y, w, z) \diamond x+F_{2}(z, w, y) \diamond x+y \diamond F_{2}(z, w, x)\right) \\
= & 0 .
\end{aligned}
$$

Thus $(A, \cdot,[-,-])$ is an $F$-manifold algebra.
(ii) By Lemma 2.3, $(A ; L)$ is a representation of the sub-adjacent Lie algebra $A^{c}$. By Lemma 4.10, $(A ; \mathbb{R})$ is a representation of the commutative associative algebra $(A, \cdot)$. Moreover, note that $F_{1}(x, y, z)=R_{L, \mathfrak{e}}(x, y)(z)$ and $F_{2}(x, y, z)=S_{L, \mathfrak{P}}(x, y)(z)$. Thus (31) implies that (17) holds and, by (36), (32) implies that (18) holds. Thus $(A ; L, \mathfrak{L})$ is a representation of the sub-adjacent $F$-manifold algebra $A^{c}$.

Remark 4.14. In fact, the operad PreFMan of pre- $F$-manifold algebras is the arity splitting of the operad FMan of $F$-manifold algebras (into two pieces) in the sense of [34] or the disuccessor of FMan in the sense of [母].
4.3. Rota-Baxter operators and $O$-operators on $F$-manifold algebras. The notion of an $O$ operator was first given for Lie algebras by Kupershmidt in [24] as a natural generalization of the classical Yang-Baxter equation.

A linear map $T: V \longrightarrow A$ is called an $O$-operator on a commutative associative algebra ( $A,{ }_{A}$ ) with respect to a representation $(V ; \mu)$ if $T$ satisfies

$$
\begin{equation*}
T(u) \cdot_{A} T(v)=T(\mu(T(u)) v+\mu(T(v)) u), \quad \forall u, v \in V \tag{37}
\end{equation*}
$$

In particular, an $O$-operator on a commutative associative algebra $\left(A,{ }_{A}\right)$ with respect to the regular representation is called a Rota-Baxter operator of weight zero or briefly a RotaBaxter operator on $A$.

Lemma 4.15. ([3]) Let $\left(A,{ }_{A}\right)$ be a commutative associative algebra and $(V ; \mu)$ a representation. Let $T: V \rightarrow A$ be an $O$-operator on $\left(A,{ }_{A}\right)$ with respect to $(V ; \mu)$. Then there exists a Zinbiel algebra structure on $V$ given by

$$
u \diamond v=\mu(T(u)) v, \quad \forall u, v \in V
$$

A linear map $T: V \longrightarrow \mathfrak{g}$ is called an $O$-operator on a Lie algebra $\left(\mathfrak{g},[-,-]_{\mathfrak{g}}\right)$ with respect to a representation $(V ; \rho)$ if $T$ satisfies

$$
\begin{equation*}
[T(u), T(v)]_{\mathrm{g}}=T(\rho(T(u))(v)-\rho(T(v))(u)), \quad \forall u, v \in V . \tag{38}
\end{equation*}
$$

In particular, an $O$-operator on a Lie algebra $\left(\mathfrak{g},[-,-]_{\mathfrak{g}}\right)$ with respect to the adjoint representation is called a Rota-Baxter operator of weight zero or briefly a Rota-Baxter operator on $\mathfrak{g}$.

Lemma 4.16. ([哟]) Let $T: V \rightarrow \mathfrak{g}$ be an O-operator on a Lie algebra $\left(\mathfrak{g},[-,-]_{\mathfrak{g}}\right)$ with respect to a representation $(V ; \rho)$. Define a multiplication $*$ on $V$ by

$$
\begin{equation*}
u * v=\rho(T(u))(v), \quad \forall u, v \in V \tag{39}
\end{equation*}
$$

Then $(V, *)$ is a pre-Lie algebra.
Let $(V ; \rho, \mu)$ be a representation of an $F$-manifold algebra $\left(A,{ }_{A},[-,-]_{A}\right)$.
Definition 4.17. (i) A linear operator $T: V \longrightarrow A$ is called an $O$-operator on $A$ if $T$ is both an $O$-operator on the commutative associative algebra $\left(A,{ }_{A}\right)$ and an $O$-operator on the Lie algebra $\left(A,[-,-]_{A}\right)$;
(ii) A linear operator $\mathcal{B}: A \longrightarrow A$ is called a Rota-Baxter operator of weight zero or briefly a Rota-Baxter operator on $A$, if $\mathcal{B}$ is both a Rota-Baxter operator on the commutative associative algebra $\left(A,{ }_{A}\right)$ and a Rota-Baxter operator on the Lie algebra $\left(A,[-,-]_{A}\right)$.

It is obvious that $\mathcal{B}: A \longrightarrow A$ is a Rota-Baxter operator on $A$ if and only if $\mathcal{B}$ is an $O$-operator on $A$ with respect to the representation $(A ; \mathrm{ad}, \mathcal{L})$.

Example 4.18. Let $(A, \diamond, *)$ be a pre- $F$-manifold algebra. Then the identity map Id is an $O$ operator on $A^{c}$ with respect to the representation $(A ; L, \mathfrak{Z})$, where $L$ and $\mathfrak{R}$ are given by ( $\left.\mathbb{Z}\right)$ and (30) respectively.

An $O$-operator on an $F$-manifold algebra gives a pre- $F$-manifold algebra.
Theorem 4.19. Let $\left(A,{ }_{A},[-,-]_{A}\right)$ be an $F$-manifold algebra and $T: V \longrightarrow A$ an $O$-operator on $A$ with respect to the representation $(V ; \rho, \mu)$. Define new operations $\diamond$ and $*$ on $V$ by

$$
u \diamond v=\mu(T(u)) v, \quad u * v=\rho(T(u)) v .
$$

Then $(V, \diamond, *)$ is a pre- $F$-manifold algebra and $T$ is a homomorphism from $V^{c}$ to $\left(A,{ }_{A},[-,-]_{A}\right)$.
Proof. First by the fact that $T$ is an $O$-operator on the commutative associative algebra $\left(A,{ }_{A}\right)$ as well as an $O$-operator on the Lie algebra $\left(A,[-,-]_{A}\right)$ with respect to the representations $(V ; \mu)$ and $(V ; \rho)$ respectively, we deduce that $(V, \diamond)$ is a Zinbiel algebra and $(V, *)$ is a pre-Lie algebra.

Denote by $[u, v]_{T}:=u * v-v * u$ and $u \cdot_{T} v:=u \diamond v+v \diamond u$, we have $T\left([u, v]_{T}\right)=[T(u), T(v)]_{A}$ and $T\left(u{ }_{\cdot T} v\right)=T(u){ }_{A} T(v)$. By these facts and (I7), for $v_{1}, v_{2}, v_{3}, v_{4} \in V$, one has

$$
F_{1}\left(v_{1}{ }_{T} v_{2}, v_{3}, v_{4}\right)-v_{1} \diamond F_{1}\left(v_{2}, v_{3}, v_{4}\right)-v_{2} \diamond F_{1}\left(v_{1}, v_{3}, v_{4}\right)
$$

$$
\begin{aligned}
= & R_{\rho, \mu}\left(T\left(v_{1}\right) \cdot A T\left(v_{2}\right), T\left(v_{3}\right)\right)\left(v_{4}\right)-\mu\left(T\left(v_{1}\right)\right) R_{\rho, \mu}\left(T\left(v_{2}\right), T\left(v_{3}\right)\right)\left(v_{4}\right) \\
& -\mu\left(T\left(v_{2}\right)\right) R_{\rho, \mu}\left(T\left(v_{1}\right), T\left(v_{3}\right)\right)\left(v_{4}\right)=0,
\end{aligned}
$$

which implies that (31) holds.
Similarly, by (18), one has

$$
\begin{aligned}
& \left(F_{1}\left(v_{1}, v_{2}, v_{3}\right)+F_{1}\left(v_{1}, v_{3}, v_{2}\right)+F_{2}\left(v_{2}, v_{3}, v_{1}\right)\right) \diamond v_{4}-F_{2}\left(v_{2}, v_{3}, v_{1} \diamond v_{4}\right)+v_{1} \diamond F_{2}\left(v_{2}, v_{3}, v_{4}\right) \\
= & \mu\left(P_{T\left(v_{1}\right)}\left(T\left(v_{2}\right), T\left(v_{3}\right)\right)\left(v_{4}\right)-S_{\rho, \mu}\left(T\left(v_{2}\right), T\left(v_{3}\right)\right) \mu\left(T\left(v_{1}\right)\right)\left(v_{4}\right)\right. \\
& +\mu\left(T\left(v_{1}\right)\right) S_{\rho, \mu}\left(T\left(v_{2}\right), T\left(v_{3}\right)\right)\left(v_{4}\right)=0
\end{aligned}
$$

which implies that (32) holds. Thus, $(V, \diamond, *)$ is a pre- $F$-manifold algebra. It is obvious that $T$ is a homomorphism from $V^{c}$ to $\left(A, \cdot_{A},[-,-]_{A}\right)$.
Corollary 4.20. Let $\left(A,{ }_{A},[-,-]_{A}\right)$ be an $F$-manifold algebra and $T: V \longrightarrow A$ an $O$-operator on $A$ with respect to the representation $(V ; \rho, \mu)$. Then $T(V)=\{T(v) \mid v \in V\} \subset A$ is a subalgebra of $A$ and there is an induced $F$-manifold algebras structure on $T(V)$ given by

$$
T(u) \diamond T(v)=T(u \diamond v), \quad T(u) * T(v)=T(u * v)
$$

for all $u, v \in V$.
Corollary 4.21. Let $\left(A,{ }_{A},[-,-]_{A}\right)$ be an $F$-manifold algebra and $\mathcal{B}: A \longrightarrow A$ a Rota-Baxter operator. Define new operations on $A$ by

$$
x \diamond y=\mathcal{B}(x) \cdot_{A} y, \quad x * y=[\mathcal{B}(x), y]_{A} .
$$

Then $(A, \diamond, *)$ is a pre- $F$-manifold algebra and $\mathcal{B}$ is a homomorphism from the sub-adjacent F-manifold algebras $\left(A,{ }_{\mathcal{B}},[-,-]_{\mathcal{B}}\right)$ to $\left(A,{ }_{A},[-,-]_{A}\right)$, where $x \cdot_{\mathcal{B}} y=x \diamond y+y \diamond x$ and $[x, y]_{\mathcal{B}}=$ $x * y-y * x$.

Corollary 4.22. Consider the $F$-manifold algebra $(A, \cdot,[-,-])$ given by Proposition 3.15. If $\mathcal{B}: A \longrightarrow A$ is a Rota-Baxter operator on the commutative associative algebra $(A, \cdot)$ and satisfies $\mathcal{B} \circ D=D \circ B$, then $\mathcal{B}: A \longrightarrow A$ is a Rota-Baxter operator on the Lie algebra $(A,[-,-])$. Thus $\left(A, \diamond_{\mathcal{B}}, *_{\mathcal{B}}\right)$ is a pre-F-manifold algebra, where

$$
x \diamond_{\mathcal{B}} y=\mathcal{B}(x) \cdot y, \quad x *_{\mathcal{B}} y=\mathcal{B}(x) \cdot D(y)-y \cdot D(\mathcal{B}(x))
$$

and $\left(A,{ }_{\mathcal{B}},[-,-]_{\mathcal{B}}\right)$ is the sub-adjacent $F$-manifold algebra with

$$
x \cdot_{\mathcal{B}} y=x \diamond_{\mathcal{B}} y+y \diamond_{\mathcal{B}} x, \quad[x, y]_{\mathcal{B}}=x *_{\mathcal{B}} y-y *_{\mathcal{B}} x .
$$

Example 4.23. We put $A=C^{1}([0,1])$. Then $(A, \cdot,[-,-])$ with the following multiplication and bracket

$$
\begin{aligned}
f \cdot g & =f g, \\
{[f, g] } & =f g^{\prime}-g f^{\prime}, \quad \forall f, g \in A
\end{aligned}
$$

is an $F$-manifold algebra. It is well-known that the integral operator is a Rota-Baxter operator:

$$
\mathcal{B}: A \rightarrow A, \quad \mathcal{B}(f)(x):=\int_{0}^{x} f(t) d t .
$$

It is easy to see that

$$
\mathcal{B} \circ \partial_{x}=\partial_{x} \circ \mathcal{B}=\mathrm{Id} .
$$

Thus $\left(A, \diamond_{\mathcal{B}}, *_{\mathcal{B}}\right)$ is a pre- $F$-manifold algebra, where

$$
f \diamond_{\mathcal{B}} g=g \int_{0}^{x} f(t) d t, \quad f *_{\mathcal{B}} g=g^{\prime} \int_{0}^{x} f(t) d t-f \cdot g
$$

and $\left(A,{ }_{\mathcal{B}},[-,-]_{\mathcal{B}}\right)$ is the sub-adjacent $F$-manifold algebra with

$$
f_{\cdot \mathcal{B}} g=f \int_{0}^{x} g(t) d t+g \int_{0}^{x} f(t) d t, \quad[f, g]_{\mathcal{B}}=f^{\prime} \int_{0}^{x} g(t) d t-g^{\prime} \int_{0}^{x} f(t) d t
$$

Example 4.24. Consider the $F$-manifold algebra $(A, \cdot,[-,-])$ given by Example 3.18. It is straightforward to check that $\mathcal{B}$ given by

$$
\mathcal{B}\left(e_{1}\right)=r e_{1}, \quad \mathcal{B}\left(e_{2}\right)=2 s e_{1}+\frac{3}{2} r e_{2}, \quad \mathcal{B}\left(e_{3}\right)=t e_{1}+3 s e_{2}+3 r e_{3}, \quad r, s, t \in \mathbb{K}
$$

is a Rota-Baxter operator on the $F$-manifold algebra $A$. Thus $\left(A, \diamond_{\mathcal{B}}, *_{\mathcal{B}}\right)$ is a pre- $F$-manifold algebra, where

$$
\begin{aligned}
& e_{2} \diamond_{\mathcal{B}} e_{3}=\frac{3}{2} r e_{1}, \quad e_{3} \diamond_{\mathcal{B}} e_{2}=3 r e_{1}, \quad e_{3} \diamond_{\mathcal{B}} e_{3}=3 s e_{1}+3 r e_{2} ; \\
& e_{2} *_{\mathcal{B}} e_{3}=-\frac{3}{2} \text { are }_{1}, \quad e_{3} *_{\mathcal{B}} e_{2}=3 \text { are }_{1}, \quad e_{3} *_{\mathcal{B}} e_{3}=-3 \text { ase }_{1}
\end{aligned}
$$

and $\left(A,{ }_{\mathcal{B}},[-,-]_{\mathcal{B}}\right)$ is the sub-adjacent $F$-manifold algebra with

$$
\begin{aligned}
e_{2} \cdot \mathcal{B} e_{3} & =\frac{9}{2} r e_{1}, \quad e_{3} \cdot \mathcal{B} e_{3}=6 s e_{1}+6 r e_{2} \\
{\left[e_{2}, e_{3}\right]_{\mathcal{B}} } & =-\frac{9}{2} \operatorname{are}_{1}
\end{aligned}
$$

At the end of this section, we give a necessary and sufficient condition on an $F$-manifold algebra admitting a pre- $F$-manifold algebra structure.
Proposition 4.25. Let $\left(A,{ }_{A},[-,-]_{A}\right)$ be an $F$-manifold algebra. There is a pre-F-manifold algebra structure on $A$ such that its sub-adjacent $F$-manifold algebra is exactly $\left(A, \cdot_{A},[-,-]_{A}\right)$ if and only if there exists an invertible $O$-operator on $\left(A,{ }_{A},[-,-]_{A}\right)$.
Proof. If $T: V \longrightarrow A$ is an invertible $O$-operator on $A$ with respect to the representation $(V ; \rho, \mu)$, then the compatible pre- $F$-manifold algebra structure on $A$ is given by

$$
x \diamond y=T\left(\mu(x)\left(T^{-1}(y)\right)\right), \quad x * y=T\left(\rho(x)\left(T^{-1}(y)\right)\right)
$$

for all $x, y \in P$.
Conversely, let $(A, \diamond, *)$ be a pre- $F$-manifold algebra and $\left(A,{ }_{A},[-,-]_{A}\right)$ the sub-adjacent $F$ manifold algebra. Then the identity map Id is an $O$-operator on $A$ with respect to the representation $(A ; L, \mathfrak{I})$.

Corollary 4.26. Let $\left(A,{ }^{\prime},[-,-]_{A}\right)$ be a coherence $F$-manifold algebra. Let $\omega \in \wedge^{2} A^{*}$ be a cyclic 2-cocycle in the sense of Connes on the commutative associative algebra $\left(A, \cdot_{A}\right)$, i.e.

$$
\omega\left(x \cdot_{A} y, z\right)+\omega\left(y \cdot{ }_{A} z, x\right)+\omega\left(z \cdot{ }_{A} x, y\right)=0, \quad \forall x, y, z \in A,
$$

as well as a symplectic structure on the Lie algebra $\left(A,[-,-]_{A}\right)$, i.e.

$$
\omega\left([x, y]_{A}, z\right)+\omega\left([y, z]_{A}, x\right)+\omega\left([z, x]_{A}, y\right)=0, \quad \forall x, y, z \in A .
$$

Then there is a compatible pre-F-manifold algebra structure on $A$ given by

$$
\omega(x \diamond y, z)=\omega\left(y, x \cdot_{A} z\right), \quad \omega(x * y, z)=\omega\left(y,[z, x]_{A}\right) .
$$

Proof. Since $\left(A,{ }_{\cdot A},[-,-]_{A}\right)$ is a coherence $F$-manifold algebra, $\left(A^{*} ; \mathrm{ad}^{*},-\mathcal{L}^{*}\right)$ is a representation of $A$. By the fact that $\omega$ is a cyclic 2 -cocycle, $\left(\omega^{\sharp}\right)^{-1}$ is an $O$-operator on the commutative associative algebra $\left(A,{ }_{A}\right)$ with respect to the representation $\left(A^{*},-\mathcal{L}^{*}\right)$, where $\omega^{\sharp}: A \longrightarrow A^{*}$ is defined by $\left\langle\omega^{\sharp}(x), y\right\rangle=\omega(x, y)$. By the fact that $\omega$ is a symplectic structure, $\left(\omega^{\sharp}\right)^{-1}$ is an $O$ operator on the Lie algebra $\left(A,[\cdot, \cdot]_{A}\right)$ with respect to the representation $\left(A^{*}, \mathrm{ad}^{*}\right)$. Thus, $\left(\omega^{\sharp}\right)^{-1}$ is an $O$-operator on the coherence $F$-manifold algebra ( $A,{ }_{A},[-,-]_{A}$ ) with respect to the representation $\left(A^{*} ; \mathrm{ad}^{*},-\mathcal{L}^{*}\right)$. By Proposition 4.25, there is a compatible pre- $F$-manifold algebra structure on $A$ given as above.

## 5. Dual pre- $F$-manifold algebras and average operators on $F$-manifold algebras

It is well known that the Koszul dual of the operad PreLie of pre-Lie algebras is the operad Perm of permutative algebras ([29]). Recall that a permutative algebra is a pair $(A, \bullet)$, where $A$ is a vector space and $\bullet: A \otimes A \longrightarrow A$ is a bilinear multiplication satisfying that for all $x, y, z \in A$,

$$
\begin{equation*}
x \bullet(y \bullet z)=(x \bullet y) \bullet z=(y \bullet x) \bullet z . \tag{40}
\end{equation*}
$$

It is well known that the Koszul dual of the operad Zinb of Zinbiel algebras is the operad Leib of Leibniz algebras ([团]). Recall that a Leibniz algebra is a pair $(\mathfrak{g},\{-,-\})$, where $\mathfrak{g}$ is a vector space and $\{-,-\}: \mathfrak{g} \otimes \mathfrak{g} \longrightarrow \mathfrak{g}$ is a bilinear bracket satisfying that for all $x, y, z \in \mathfrak{g}$,

$$
\begin{equation*}
\{x,\{y, z\}\}=\{\{x, y\}, z\}+\{y,\{x, z\}\} . \tag{41}
\end{equation*}
$$

Now we give the definition of a dual pre- $F$-manifold algebra.
Definition 5.1. $A$ dual pre- $F$-manifold algebra is a triple $(A, \bullet,\{-,-\})$, where $(A, \bullet)$ is a permutative algebra and $(A,\{-,-\})$ is a Leibniz algebra, such that for all $x, y, z, w \in A$, the following conditions hold:

$$
\begin{align*}
G_{1}(x \bullet y, z, w) & =x \bullet G_{1}(y, z, w)+y \bullet G_{1}(x, z, w),  \tag{42}\\
G_{2}(y \bullet x, z, w) & =y \bullet G_{2}(x, z, w)-G_{1}(y, z, w) \bullet x,  \tag{43}\\
\{x, y\} \bullet z+\{y, x\} \bullet z & =0, \tag{44}
\end{align*}
$$

where $G_{1}, G_{2}: \otimes^{3} A \longrightarrow A$ are defined by

$$
\begin{align*}
G_{1}(x, y, z) & =\{x, y \bullet z\}-\{x, y\} \bullet z-y \bullet\{x, z\},  \tag{45}\\
G_{2}(x, y, z) & =\{y \bullet z, x\}-z \bullet\{y, x\}-y \bullet\{z, x\} . \tag{46}
\end{align*}
$$

Recall that an average operator on a commutative associative algebra $(A, \cdot)$ is a linear map $\alpha: A \rightarrow A$ such that

$$
\alpha(x) \cdot \alpha(y)=\alpha(\alpha(x) \cdot y), \quad \forall x, y \in A .
$$

Lemma 5.2. ([]]) Let $(A, \cdot)$ be a commutative associative algebra and $\alpha: A \rightarrow A$ an average operator. Define a multiplication $\bullet$ on $A$ by

$$
\begin{equation*}
x \bullet y=\alpha(x) \cdot y, \quad \forall x, y \in A . \tag{47}
\end{equation*}
$$

Then $(A, \bullet)$ is a permutative algebra.

Recall that an average operator on a Lie algebra $(\mathfrak{g},[-,-])$ is a linear map $\alpha: \mathfrak{g} \rightarrow \mathfrak{g}$ such that

$$
[\alpha(x), \alpha(y)]=\alpha([\alpha(x), y]), \quad \forall x, y \in \mathfrak{g} .
$$

Lemma 5.3. ([]]) Let $(\mathfrak{g},[-,-])$ be a Lie algebra and $\alpha: \mathfrak{g} \rightarrow \mathfrak{g}$ an average operator. Define a bracket $\{-,-\}$ on $\mathfrak{g}$ by

$$
\begin{equation*}
\{x, y\}=[\alpha(x), y], \quad \forall x, y \in \mathfrak{g} \tag{48}
\end{equation*}
$$

Then $(\mathfrak{g},\{-,-\})$ is a Leibniz algebra.
Definition 5.4. Let $\left(A,{ }_{A},[-,]_{A}\right)$ be an $F$-manifold algebra. A linear operator $\alpha: A \longrightarrow$ $A$ is called an average operator on $A$ if $\alpha$ is both an average operator on the commutative associative algebra $\left(A,{ }_{A}\right)$ and an average operator on the Lie algebra $\left(A,[-,-]_{A}\right)$.

Theorem 5.5. Let $\left(A,{ }_{A},[-,-]_{A}\right)$ be an $F$-manifold algebra and $\alpha: A \rightarrow A$ an average operator. Define new operations on $A$ by

$$
\begin{equation*}
x \bullet y=\alpha(x) \cdot \cdot_{A} y \quad \text { and } \quad\{x, y\}=[\alpha(x), y]_{A}, \quad \forall x, y \in A \tag{49}
\end{equation*}
$$

Then $(A, \bullet,\{-,-\})$ is a dual pre- $F$-manifold algebras.
Proof. Let $\left(A,{ }_{A},[-,-]_{A}\right)$ be an $F$-manifold algebra. Since $\alpha: A \rightarrow A$ is an average operator, we have $[\alpha(x), \alpha(y)]_{A}=\alpha\left([\alpha(x), y]_{A}\right)$ and $\alpha(x) \cdot{ }_{A} \alpha(y)=\alpha\left(\alpha(x) \cdot{ }_{A} y\right)$. By Lemma 5.2 and Lemma 5.3, $\left(A, \cdot{ }_{A}\right)$ is a permutative algebra and $\left(A,[-,-]_{A}\right)$ is a Leibniz algebra. By a direct calculation, we have

$$
\begin{equation*}
P_{\alpha(x)}(\alpha(y), z)=P_{\alpha(x)}(z, \alpha(y))=G_{1}(x, y, z), \quad P_{x}(\alpha(y), \alpha(z))=-G_{2}(x, y, z) \tag{50}
\end{equation*}
$$

By the definition of an average operator and (50), we have

$$
\begin{aligned}
& P_{\alpha(x) \cdot A} \alpha(y) \\
&=(\alpha(z), w)-\alpha(x) \cdot{ }_{A} P_{\alpha(y)}(\alpha(z), w)-\alpha(y) \cdot{ }_{A} P_{\alpha(x)}(\alpha(z), w) \\
&= G_{\alpha(x \cdot A y)}(\alpha(z), w)-x \bullet P_{\alpha(y)}(\alpha(z), w)-y \bullet P_{\alpha(x)}(\alpha(z), w) \\
&(x, w)-x \bullet G_{1}(y, z, w)-y \bullet G_{1}(x, z, w),
\end{aligned}
$$

which implies that (42) holds.
Similarly, we have

$$
\begin{aligned}
& P_{x_{A} \alpha(y)}(\alpha(z), \alpha(w))-x \cdot{ }_{A} P_{\alpha(y)}(\alpha(z), \alpha(w))-\alpha(y) \cdot{ }_{A} P_{x}(\alpha(z), \alpha(w)) \\
= & P_{y \bullet x}(\alpha(z), w)-x \cdot_{A} \alpha\left(G_{1}(y, z, w)\right)-y \bullet P_{x}(\alpha(z), \alpha(w)) \\
= & -G_{2}(y \bullet x, z, w)-G_{1}(y, z, w) \bullet x+y \bullet G_{2}(x, z, w),
\end{aligned}
$$

which implies that (43) holds.
Since $\left.\alpha\left([\alpha(x), y]_{A}\right)=\alpha\left([x, \alpha(y)]_{A}\right)=[\alpha(x), \alpha(y)]_{A}\right)$, we have

$$
\begin{aligned}
\{x, y\} \bullet z+\{y, x\} \bullet z & =\alpha\left([\alpha(x), y]_{A}\right) \cdot{ }_{A} z+\left([\alpha(y), x]_{A}\right) \cdot{ }_{A} z \\
& =\left([\alpha(x), \alpha(y)]_{A}+[\alpha(y), \alpha(x)]_{A}\right) \cdot{ }_{A} z=0,
\end{aligned}
$$

which implies that (44) holds.
Proposition 5.6. Consider the F-manifold algebra $(A, \cdot,[-,-])$ given by Proposition 3.15. If $\alpha: A \longrightarrow A$ is an average operator on the commutative associative algebra $(A, \cdot)$ and satisfies
$\alpha \circ D=D \circ \alpha$, then $\alpha: A \longrightarrow A$ is an average operator on the Lie algebra $(A,[-,-])$. Thus $(A, \bullet,\{-,-\})$ is a dual pre- $F$-manifold algebra, where

$$
x \bullet y=\alpha(x) \cdot y \quad \text { and } \quad\{x, y\}=\alpha(x) \cdot D(y)-y \cdot D(\alpha(x)), \quad \forall x, y \in A .
$$

Proof. It follows by a direct calculation.
Example 5.7. Consider the $F$-manifold algebra $(A, \cdot,[-,-])$ given by Example 3.18. It is straightforward to check that $\alpha$ given by

$$
\alpha\left(e_{1}\right)=r e_{1}, \quad \alpha\left(e_{2}\right)=s e_{1}+r e_{2}, \quad \alpha\left(e_{3}\right)=t e_{1}+s e_{2}+r e_{3}, \quad r, s, t \in \mathbb{K}
$$

is an average operator on the $F$-manifold algebra $A$. Thus $(A, \bullet,\{-,-\})$ is a dual pre- $F$-manifold algebra, where

$$
\begin{aligned}
& e_{2} \bullet e_{3}=r e_{1}, \quad e_{3} \bullet e_{2}=r e_{1}, \quad e_{3} \bullet e_{3}=s e_{1}+r e_{2} ; \\
& \left\{e_{2}, e_{3}\right\}=- \text { are }_{1}, \quad\left\{e_{3}, e_{2}\right\}=\text { are }_{1}, \quad\left\{e_{3}, e_{3}\right\}=- \text { ase }_{1} \quad a, r, s \in \mathbb{K} .
\end{aligned}
$$
