# Purely singular splittings of cyclic groups

#### Abstract

Let $G$ be a finite abelian group. We say that $M$ and $S$ form a splitting of $G$ if every nonzero element $g$ of $G$ has a unique representation of the form $g=m s$ with $m \in M$ and $s \in S$, while 0 has no such representation. The splitting is called purely singular if for each prime divisor $p$ of $|G|$, there is at least one element of $M$ is divisible by $p$.

In this paper, we mainly study the purely singular splittings of cyclic groups. We first prove that if $k \geq 3$ is a positive integer such that $[-k+$ $1, k]^{*}$ splits a cyclic group $\mathbb{Z}_{m}$, then $m=2 k$. Next, we have the following general result. Suppose $M=\left[-k_{1}, k_{2}\right]^{*}$ splits $\mathbb{Z}_{n\left(k_{1}+k_{2}\right)+1}$ with $1 \leq k_{1}<$ $k_{2}$. If $n \geq 2$, then $k_{1} \leq n-2$ and $k_{2} \leq 2 n-5$. Applying this result, we prove that if $M=\left[-k_{1}, k_{2}\right]^{*}$ splits $\mathbb{Z}_{m}$ purely singularly, and either (i) $\operatorname{gcd}(s, m)=1$ for all $s \in S$ or (ii) $m=2^{\alpha} p^{\beta}$ or $2^{\alpha} p_{1} p_{2}$ with $\alpha \geq 0, \beta \geq 1$ and $p, p_{1}, p_{2}$ odd primes, then $m=k_{1}+k_{2}+1$ or $k_{1}=0$ and $m=k_{2}+1$ or $2 k_{2}+1$.


Keywords: splitter sets, perfect codes, factorizations of cyclic groups.

## 1 Introduction

Let $G$ be a finite group, written additively, $M$ a set of integers, and $S$ a subset of $G$. We say that $M$ and $S$ form a splitting of $G$ if every nonzero element $g$ of $G$ has a unique representation of the form $g=m s$ with $m \in M$ and $s \in S$, while 0 has no such representation. (Here" $m s$ " denotes the sum of $m s$ 's if $m \geq 0$, and $-((-m) s)$ if $m<0$.) We write " $G \backslash\{0\}=M S$ " to indicate that $M$ and $S$ form a splitting of $G . M$ is referred to as the multiplier set and $S$ as the splitter set. We also say that $M$ splits $G$ with a splitter set $S$, or simply that $M$ splits $G$.

[^0]Let $a, b$ be integers such that $a \leq b$, denote

$$
[a, b]=\{a, a+1, a+2, \ldots, b\} \text { and }[a, b]^{*}=\{a, a+1, a+2, \ldots, b\} \backslash\{0\} .
$$

For any positive integer $q$, let $\mathbb{Z}_{q}$ be the ring of integers modulo $q$ and $\mathbb{Z}_{q}^{*}=$ $\mathbb{Z}_{q} \backslash\{0\}$. For $a \in \mathbb{Z}_{q}^{*}, o(a)$ denotes the order of $a$ in the multiplicative group $\mathbb{Z}_{q}^{*}$.

Let $q$ be a positive integer and $k_{1}, k_{2}$ be non-negative integers with $0 \leq k_{1} \leq$ $k_{2}$. The set $B \subset \mathbb{Z}_{q}$ of size $n$ is called a splitter set (or a packing set) if all the sets

$$
\left\{a b \quad(\bmod q): a \in\left[-k_{1}, k_{2}\right]\right\}, \quad b \in B
$$

have $k_{1}+k_{2}$ nonzero elements, and they are disjoint. We denote such a splitter set by $B\left[-k_{1}, k_{2}\right](q)$ set. A $B\left[-k_{1}, k_{2}\right](q)$ set is called perfect if $n=\frac{q-1}{k_{1}+k_{2}}$. Clearly, a perfect set can exist only if $q \equiv 1\left(\bmod k_{1}+k_{2}\right)$. A perfect $B\left[-k_{1}, k_{2}\right](q)$ set is called nonsingular if $\operatorname{gcd}\left(q, k_{2}!\right)=1$. Otherwise, the set is called singular. If for any prime $p \mid q$, there is some $k$ with $0<k \leq k_{2}$ such that $p \mid k$, then the perfect $B\left[-k_{1}, k_{2}\right](q)$ set is called purely singular.

Remark: Let $q$ be a positive integer and $k_{1}, k_{2}$ be non-negative integers with $0 \leq k_{1} \leq k_{2}$. Let $M=\left[-k_{1}, k_{2}\right]^{*}$. Then $B$ is a perfect $B\left[-k_{1}, k_{2}\right](q)$ set if and only if $M B$ is a splitting of $\mathbb{Z}_{q}$ by the works of D. Hickerson [1] and Schwarz [3]. Therefore, we are only interested in considering purely singular perfect $B\left[-k_{1}, k_{2}\right](q)$ sets for the cyclic group $\mathbb{Z}_{q}$ and nonsingular perfect $B\left[-k_{1}, k_{2}\right](p)$ sets for an odd prime $p$.

In this paper, we focus our attention to the purely singular perfect $B\left[-k_{1}, k_{2}\right](q)$ sets for the cyclic group $\mathbb{Z}_{q}$. Zhang and Ge [9] proposed the following conjecture.

Conjecture 1.1 Let $k_{1}$, $k_{2}$ be integers with $1 \leq k_{1}<k_{2}$ and $k_{1}+k_{2} \geq 4$, then there does not exist any purely singular perfect $B\left[-k_{1}, k_{2}\right](m)$ set except for $m=1$ and except possibly for $m=k_{1}+k_{2}+1$.

Zhang and Ge [9] proved that Conjecture 1.1 holds for $[-1, k]^{*}$ when $k=$ $3,4,5,6,8,9,10$ and $[-2, k]^{*}$ when $k=3,4,6$. The authors [8] obtain some results on the purely singular perfect $B\left[-k_{1}, k_{2}\right](q)$ sets and showed that Conjecture 1.1 holds for $q=2^{n}$.

For the case when $k_{1}=0$, we have the following conjecture of Woldar [7].
Conjecture 1.2 Let $k$ be a positive integer. If $[1, k]$ splits the finite abelian group $G$ purely singularly, then $G$ is one of $\mathbb{Z}_{1}, \mathbb{Z}_{k+1}$, or $\mathbb{Z}_{2 k+1}$.

Conjecture 1.2 has been verified by Hickerson [7] for all $k<3000$. In this paper, by using some technique of the paper [8], we first prove that Conjecture 1.1 holds for $[-k+1, k]^{*}$ when $k \geq 3$. We have

Theorem 1.1 Let $G$ be a finite cyclic group and $k \geq 3$ a positive integer. Then $[-k+1, k]^{*}$ splits $G$ if and only if $G$ is a cyclic group of order $2 k$.

Next we prove a theorem which is very useful in the proof of Theorems 1.3 and 1.4.

Theorem 1.2 Let $n, k_{1}$ and $k_{2}$ be positive integers with $n \geq 2,1 \leq k_{1}<k_{2}$. If $\left[-k_{1}, k_{2}\right]^{*}$ splits $\mathbb{Z}_{n\left(k_{1}+k_{2}\right)+1}$, then $k_{1} \leq n-2$ and $k_{2} \leq 2 n-5$.

Finally we prove that Conjectures 1.1 and 1.2 hold for cyclic groups $\mathbb{Z}_{q}$ of various $q$, we have

Theorem 1.3 Let $k_{1}, k_{2}$, $m$ be integers with $0 \leq k_{1} \leq k_{2}$ and $k_{2} \geq 3$, and let $\mathbb{Z}_{m} \backslash\{0\}=\left[-k_{1}, k_{2}\right]^{*} \cdot S$ be a splitting of the cyclic group $\mathbb{Z}_{m}$ with the splitter set $S$. If $\operatorname{gcd}(s, m)=1$ for all $s \in S$, then either $m=k_{1}+k_{2}+1$ or $k_{1}=0$ and $m=2 k_{2}+1$.

Theorem 1.4 Let $\alpha, \beta, k_{1}, k_{2}$ be integers, $1 \leq k_{1} \leq k_{2}$ and $k_{2} \geq 3$. Suppose $\left[-k_{1}, k_{2}\right]^{*}$ splits a cyclic group $\mathbb{Z}_{m}$. If the splitting is purely singular and $m=2^{\alpha} p^{\beta}$ or $2^{\alpha} p_{1} p_{2}$ with $\alpha \geq 0, \beta \geq 1$ and $p, p_{1}, p_{2}$ are odd primes, then $m=k_{1}+k_{2}+1$. Furthermore, if $k_{1}=0$, then either $m=k_{2}+1$ or $m=2 k_{2}+1$.

Theorem 1.5 Let $k_{1}, k_{2}$, $m$ be integers with $0 \leq k_{1} \leq k_{2}$ and $4 \leq k_{1}+k_{2} \leq 14$. Then there does not exist any purely singular perfect $B\left[-k_{1}, k_{2}\right](m)$ set except for $m=1$ and except possibly for $m=k_{1}+k_{2}+1$, and except possibly for $m=$ $2\left(k_{1}+k_{2}\right)+1$ when $k_{1}=0$. In particular, Conjecture 1.1 holds for $k_{1}+k_{2} \leq 14$.

## 2 Preliminaries

An equivalence between lattice tilings and Abelian-group splittings was described in $[1,2,3]$. In [4], there are two important lemmas (in the language of splitting).

Lemma 2.1 ([4], Theorem 2) If $n \geq 2$ and the $[-k, k]^{*}$ splits the cyclic group $\mathbb{Z}_{2 k n+1}$, then $k \leq n-1$.

Lemma 2.2 ([4], Theorem 3) If $n \geq 3$ and the $[1, k]$ splits the cyclic group $\mathbb{Z}_{k n+1}$, then $k \leq n-2$.

To prove our main theorems, we need some lemmas. The following lemma will be used repeatedly.

Lemma 2.3 ([9], Lemma 2) If $m \mid n$ and there exist both a perfect $B\left[-k_{1}, k_{2}\right](m)$ set and a perfect $B\left[-k_{1}, k_{2}\right](n)$ set, then there exists a perfect $B\left[-k_{1}, k_{2}\right](n / m)$ set.

We also need the following lemma ([7] Theorem 6).

Lemma 2.4 Suppose $[1, k]$ splits $\mathbb{Z}_{m}$ with $2 k+1$ composite. Then either
(i) $\operatorname{gcd}(2 k+1, m)=1$, or
(ii) $2 k+1$ divides $m$ and $\operatorname{gcd}\left(2 k+1, \frac{m}{2 k+1}\right)=1$.

Combining Lemma 2.5 [8] and Theorem 5 in [7] yields the following lemma.
Lemma 2.5 Let $k_{1}$, $k_{2}$ be integers, $0 \leq k_{1} \leq k_{2}$. Suppose there exists a perfect $B\left[-k_{1}, k_{2}\right](m)$ set with $k_{1}+k_{2}+1$ composite. If $k_{1}+k_{2} \geq 4,1 \leq k_{1} \leq k_{2}$ or $k_{1}=0$, then either
(i) $\operatorname{gcd}\left(k_{1}+k_{2}+1, m\right)=1$, or
(ii) $k_{1}+k_{2}+1 \mid m$ and $\operatorname{gcd}\left(k_{1}+k_{2}+1, \frac{m}{k_{1}+k_{2}+1}\right)=1$.

Definition 2.1 Let $(G, \cdot)$ be an abelian group (written multiplicatively). If each element $g \in G$ can be expressed uniquely in the form

$$
g=a \cdot b, a \in A, b \in B
$$

then the equation $G=A \cdot B$ is called a factorization of $G$. A non-empty subset of $G$ is called to be a direct factor of $G$ if there exists a subset $B$ such that $G=A \cdot B$ is a factorization.

We also need the following result for the factorization of abelian groups.
Proposition 2.1 ([6] Theorem 7.12) If $G=A \cdot B$ is a factorization of the finite abelian group $G$ (written multiplicatively) and $k$ is an integer relatively prime to $|A|$, then $G=A^{k} \cdot B$ is a factorization of the abelian group $G$, where $A^{k}=\left\{a^{k}\right.$ : $a \in A\}$.

## 3 Proof of Theorem 1.1

In [1], the authors proved that if $G \backslash\{0\}=M S$ is a purely singular splitting with $|M|=3$, then $G=\mathbb{Z}_{2^{2 r}}$ for some $r \geq 0$; moreover Schwartz [3] has constructed an infinite family of purely singular perfect $B[-1,2]\left(4^{l}\right)$ sets.

If $M=[-k+1, k]^{*}$ with $k \geq 3$, Schwartz [3] proved that $(k,|G|) \neq 1$. We will prove Theorem 1.1.

Proof of Theorem 1.1: Suppose $[-k+1, k]^{*}$ splits $\mathbb{Z}_{q}$ with the splitter set $S$ and $n=|S|$. It suffices to show that $q=2 k$.

We claim that if $q>1$, then $(k, q)>1$. Let $S=\left\{a_{1}, \cdots, a_{n}\right\}$. Obviously, for any $1 \leq u \leq n,-k a_{u} \in \mathbb{Z}_{q} \backslash\{0\}$. Set $-k a_{u}=i a_{j}$ where $i \in[-k+1, k]^{*}$ and $1 \leq j \leq n$. If $i<k$, then we have $k a_{u}=-i a_{j}$, a contradiction. Hence, $i=k$ and
$k\left(a_{u}+a_{j}\right)=0$. If $\operatorname{gcd}(k, q)=1$, then $a_{u}=-a_{j}$, which is impossible. Therefore, $(k, q)>1$, and so $(2 k, q)>1$.

Since $(k-1)+k \geq 4(k \geq 3)$ and $(k-1)+k+1=2 k$ is composite, by Lemma 2.5, we have $2 k \mid q$ and $\left(2 k, \frac{q}{2 k}\right)=1$. By Lemma 2.3, it is easy to see that $[-k+1, k]^{*}$ splits $\mathbb{Z}_{\frac{q}{2 k}}$. If $\frac{q}{2 k}>1$, then by the claim, $\left(k, \frac{q}{2 k}\right)>1$, which is impossible. The converse is obvious. This completes the proof.

## 4 Proof of Theorem 1.2

In this section, we will prove Theorem 1.2. Theorem 1.2 can be viewed as a generalization of Lemma 2.1 and 2.2. To prove Theorem 1.2, we need some lemmas.

Lemma 4.1 Let $n$, $k$ and $l$ be integers with $n \geq 2, k \geq n-1$ and $l \geq 1$. Suppose $[-k, k+2 l]^{*}$ splits the cyclic group $\mathbb{Z}_{n(2 k+2 l)+1}$. Let $s$ and $s^{\prime}$ be two elements of a splitter set. Then one of these two conditions holds:
(a) There are integers $x$ and $y, 1 \leq x \leq 2 n+2 l-3,1 \leq|y| \leq k$, such that $x s+y s^{\prime}=0$;
(b) $s^{\prime}= \pm(2 n+2 l-2) s, k=n-1$ or $l=1$ and $s$ is a generator of $\mathbb{Z}_{n(2 k+2 l)+1}$.

Proof. Define a map $f: \mathbb{Z} \oplus \mathbb{Z} \rightarrow \mathbb{Z}_{n(2 k+2 l)+1}$ by $f(i, j)=i s+j s^{\prime}$. Put $A=$ $\{(i, j): 0 \leq i \leq 2 n+2 l-3,0 \leq j \leq k\}$.

If $\left.f\right|_{A}: A \rightarrow \mathbb{Z}_{n(2 k+2 l)+1}$ is not an injective map, then there are two distinct elements $\left(i_{1}, j_{1}\right),\left(i_{2}, j_{2}\right)$ of $A$ such that $i_{1} s+j_{1} s^{\prime}=i_{2} s+j_{2} s^{\prime}, i_{1}, i_{2} \in[0,2 n+2 l-3]$ and $j_{1}, j_{2} \in[0, k]$. Note that $i_{1}=i_{2}$ implies that $j_{1} s^{\prime}=j_{2} s^{\prime}$, which contradicts the fact that $[-k, k+2 l]^{*}$ splits $\mathbb{Z}_{n(2 k+2 l)+1}$. If $j_{1}=j_{2}$, then $\left(i_{1}-i_{2}\right) s=0$ and hence $\operatorname{ord}(s) \leq\left|i_{1}-i_{2}\right| \leq 2 n+2 l-3$. Since $k \geq n-1$ and all elements is for $i \in[-k, k+2 l]^{*}$ are distinct and nonzero, we have $\operatorname{ord}(s) \geq 2 k+2 l+1 \geq$ $2 n+2 l-1>2 n+2 l-3 \geq \operatorname{ord}(s)$, a contradiction. Consequently, we may assume that $i_{1}<i_{2}$ and $j_{1} \neq j_{2}$. Let $x=i_{2}-i_{1}$ and $y=j_{2}-j_{1}$. Then $1 \leq x \leq 2 n+2 l-3$, $1 \leq|y| \leq k$ and $x s+y s^{\prime}=0$. Hence condition (a) holds.

If $\left.f\right|_{A}: A \rightarrow \mathbb{Z}_{n(2 k+2 l)+1}$ is injective, then $|A|=|f(A)| \leq\left|\mathbb{Z}_{n(2 k+2 l)+1}\right|=$ $2 n(k+l)+1$. Since $|A|=(2 n+2 l-2)(k+1)=2 n(k+l)+2(l-1)(k+1-$ $n) \leq 2 n(k+l)+1$ and $k \geq n-1$, we must have $k=n-1$ or $l=1$. Thus $|A|=|f(A)|=2 n(k+l)=\left|\mathbb{Z}_{n(2 k+2 l)+1}\right|-1$, say,

$$
f(A)=\mathbb{Z}_{n(2 k+2 l)+1} \backslash\{x\}
$$

Obviously, $\left\{x-s, x+s, x-s^{\prime}, x+s^{\prime}\right\} \subseteq \mathbb{Z}_{n(2 k+2 l)+1} \backslash\{x\}$. Let

$$
x-s=f(i, j)=i s+j s^{\prime}, \quad 0 \leq i \leq 2 n+2 l-3,0 \leq j \leq k
$$

then $x=(i+1) s+j s^{\prime} \notin f(A)$, which implies that $i=2 n+2 l-3$. Hence

$$
\begin{equation*}
x-s=f\left(2 n+2 l-3, j_{1}\right)=(2 n+2 l-3) s+j_{1} s^{\prime}, \quad j_{1} \in[0, k] \tag{1}
\end{equation*}
$$

Similarly, there are $i_{1}, i_{2} \in[0,2 n+2 l-3]$ and $j_{2} \in[0, k]$ such that

$$
\begin{gather*}
x+s=f\left(0, j_{2}\right)=j_{2} s^{\prime}  \tag{2}\\
x-s^{\prime}=f\left(i_{1}, k\right)=i_{1} s+k s^{\prime}  \tag{3}\\
x+s^{\prime}=f\left(i_{2}, 0\right)=i_{2} s \tag{4}
\end{gather*}
$$

Delete $x$ from (2) and (4), we obtain

$$
\begin{equation*}
\left(i_{2}+1\right) s-\left(j_{2}+1\right) s^{\prime}=0 \tag{5}
\end{equation*}
$$

Similarly, from (11), (21), (3) and (4) we conclude that

$$
\begin{gather*}
(2 n+2 l-1) s+\left(j_{1}-j_{2}\right) s^{\prime}=0  \tag{6}\\
\left(2 n+2 l-2-i_{1}\right) s+\left(j_{1}-(k+1)\right) s^{\prime}=0 ;  \tag{7}\\
\left(2 n+2 l-2-i_{2}\right) s+\left(j_{1}+1\right) s^{\prime}=0  \tag{8}\\
\quad\left(i_{1}+1\right) s+\left(k+1-j_{2}\right) s^{\prime}=0 \tag{9}
\end{gather*}
$$

If the condition (a) does not hold, since $i_{2}+1 \leq 2 n+2 l-2$ and $j_{2}+1 \leq k+1$, so $i_{2}=2 n+2 l-3$ or $j_{2}=k$ by (51). Similarly, if the condition (a) does not hold, then it follows from (2), (3) and (4) that

$$
\begin{gathered}
i_{1}=0 \text { or } j_{1}=0 \\
i_{2}=0 \text { or } j_{1}=k \\
i_{1}=2 n+2 l-3 \text { or } j_{2}=0
\end{gathered}
$$

If $i_{1}=2 n+2 l-3$, then $j_{1}=0, i_{2}=0$ and $j_{2}=k$. By (9),

$$
s^{\prime}=-(2 n+2 l-2) s
$$

If $j_{2}=0$, then $i_{2}=2 n+2 l-3, j_{1}=k$ and $i_{1}=0$. By (7),

$$
s^{\prime}=(2 n+2 l-2) s
$$

Since $s$ and $s^{\prime}$ generate $\mathbb{Z}_{n(2 k+2 l)+1}$ and $s^{\prime}= \pm(2 n+2 l-2) s$, it follows that $s$ generates $\mathbb{Z}_{n(2 k+2 l)+1}$. This proves the lemma.

Lemma 4.2 Let $n$, $k$ and $l$ be integers, $n \geq 2, k \geq n-1$ and $l \geq 0$. Suppose that $[-k, k+2 l+1]^{*}$ splits the cyclic group $\mathbb{Z}_{n(2 k+2 l+1)+1}$. Let $s$ and $s^{\prime}$ be elements of a splitter set. Then one of the following statements holds:
(a) there are integers $x$ and $y, 1 \leq x \leq 2 n+2 l-2,1 \leq|y| \leq k$, such that $x s+y s^{\prime}=0 ;$
(b) $s^{\prime}= \pm(2 n+2 l-1) s$ and $G$ is cyclic with generator $s$ and $k=n-1$.

Proof. We prove the lemma by the similar argument as in the proof of Lemma 4.1. Define a map $f: Z \oplus Z \rightarrow G$ by $f(i, j)=i s+j s^{\prime}$. Let $A=\{(i, j): 0 \leq i \leq$ $2 n+2 l-2,0 \leq j \leq k\}$.

If $\left.f\right|_{A}: A \rightarrow G$ is not an injective map, then similarly, condition (a) holds.
If $\left.f\right|_{A}: A \rightarrow G$ is injective, then $|A|=|f(A)| \leq|G|=n(2 k+2 l+1)+1$. Since $|A|=(2 n+2 l-1)(k+1)=n(2 k+2 l+1)+(2 l-1)(k+1-n)$, we have either $k=n-1$ and $|A|=|G|-1$ or $k=n, l=1$ and $|A|=|G|$. If $k=n-1$ and $|A|=|G|-1$, the statement (b) holds by a similar argument as in the proof of Lemma 4.1.

If $k=n, l=1$ and $|A|=|G|$, then $|G|=(2 n+1)(n+1), A=\{(i, j): 0 \leq$ $i \leq 2 n, 0 \leq j \leq n\}$ and $f(A)=G$. From this we have

$$
-s=i s+j s^{\prime}
$$

and

$$
-s^{\prime}=i_{1} s+j_{1} s^{\prime}
$$

where $(i, j),\left(i_{1}, j_{1}\right) \in A$. Now suppose $(a)$ does not holds, then we must have $i=2 n$ and $j_{1}=n$. It follows that

$$
\begin{equation*}
(2 n+1) s+j s^{\prime}=0 \tag{10}
\end{equation*}
$$

and

$$
\begin{equation*}
i_{1} s+(n+1) s^{\prime}=0 \tag{11}
\end{equation*}
$$

Since $|G|=(2 n+1)(n+1)$, we get $(n+1) j s^{\prime}=0$ and $(2 n+1) i_{1} s=0$. The results follows upon multiplying on both sides of Equations (10) and (11) by $n+1$ and $2 n+1$, respectively. Once again multiply on both sides of (10) and (11) by $i_{1}$ and $j$, respectively, and we get $i_{1} j s^{\prime}=0$ and $i_{1} j s=0$. Since $s$ and $s^{\prime}$ generate $G$, then for any $g \in G, i_{1} j g=0$ which says that $\mid G \| i_{1} j$. Since $0 \leq i_{1} \leq 2 n$ and $0 \leq j \leq n$, we have $|G|=(2 n+1)(n+1) \leq 2 n^{2}$, a contradiction. This proves the lemma.

Applying the above two lemmas, we obtain
Proposition 4.1 Let $n$, $k_{1}$ and $k_{2}$ be integers, $n \geq 2,0 \leq k_{1}<k_{2}$. If $\left[-k_{1}, k_{2}\right]^{*}$ splits an abelian group $G$ of order $n\left(k_{1}+k_{2}\right)+1$, then $k_{1} \leq n-2$.

Proof. If $k_{2}-k_{1}>0$ is even, write $k=k_{1}$ with $k \geq 0$ and $2 l=k_{2}-k_{1}$ with $l \geq 1$. Then the order of $G$ is $|G|=2 n(k+l)+1$.

If $n=2$ and $k \geq 1$, let $S=\left\{s, s^{\prime}\right\}$ be the splitter set. The statement $(a)$ in Lemma 4.1 implies that $2 n+2 l-3>k+2 l$, which contradicts with $k \geq 1$. If the statement $(b)$ in Lemma 4.1 holds, then $s^{\prime}= \pm(2 l+2) s$. Since $(2 l+2) \cdot s= \pm s^{\prime}$, we must have $k_{2}=k+2 l<2 l+2$, and so $k=1$. For $k_{2}=k+2 l \geq 2$ and $|G|=4(l+1)+1$, we can derive a contradiction from $2 \cdot s^{\prime}= \pm s$.

Now we assume that $n \geq 3$ and suppose $k \geq n-1$. Let $S=\left\{s_{1}, \ldots, s_{n}\right\}$ be a splitter set of $G$. For each index $j, 2 \leq j \leq n$, consider the pair of elements $s_{1}$ and $s_{j}$. Assume that for each such $j$, the statement ( $a$ ) in Lemma 4.1 holds, that is, there are $x_{j}$ and $y_{j}, 1 \leq x_{j} \leq 2 n+2 l-3,1 \leq\left|y_{j}\right| \leq k$, such that $x_{j} s_{1}+y_{j} s_{j}=0$. If there are $u, v$ with $u \neq v$ in $[2, n]$ such that $x_{u}=x_{v}$, then $y_{u} s_{u}=y_{v} s_{v}$, a contradiction to the fact that $S$ is a splitter set. If for any $2 \leq u<v \leq n$, $x_{u} \neq x_{v}$, say, $x_{2}<x_{3}<\cdots<x_{n}$, then $1 \leq x_{2}<x_{3}<\cdots<x_{n} \leq 2 n+2 l-3$, and then $x_{2} \leq n+2 l-1$. It follows that $-y_{2} s_{2}=x_{2} s_{1}$ with $-y_{2}, x_{2} \in[-k, k+2 l]^{*}$, a contradiction.

Thus, there must be an index $j$ such that the statement $(b)$ in Lemma 4.1 holds. It means that $(2 n+2 l-2) s_{1} \in S$ or $-(2 n+2 l-2) s_{1} \in S$ and $k=n-1$ or $l=1$. If $(2 n+2 l-2) s_{1} \in S$, then $(k+1) \cdot(2 n+2 l-2) s_{1}=2 n(k+l) s_{1}=(-1) \cdot s_{1}$. If $-(2 n+2 l-2) s_{1} \in S$, then $(k+1) \cdot\left(-(2 n+2 l-2) s_{1}\right)=-2 n(k+l) s_{1}=(1) \cdot s_{1}$. Both of above are impossible.

The case $k_{2}-k_{1}$ odd follows from Lemma 4.2 and the same discussion as in the above proof. This proves the proposition.

Lemma 4.3 Let $n, k_{1}$ and $k_{2}$ be integers with $n \geq 2, k_{2} \geq k_{1} \geq 1$ and $k_{2} \geq n-1$. Suppose that $\left[-k_{1}, k_{2}\right]^{*}$ splits the cyclic group $G=\mathbb{Z}_{n\left(k_{1}+k_{2}\right)+1}$. Then for any two distinct elements $s$ and $s^{\prime}$ in a splitter set, one of the following statements holds:
(a) there are integers $x$ and $y$ satisfying $1 \leq x \leq n+k_{1}-2,1 \leq y \leq k_{2}$ and $x s+y s^{\prime}=0 ;$
(b) $k_{2} \leq n+k_{1}-3$ or $k_{1}=1, k_{2}=n-1$ or $k_{1}=2$ and $k_{2}=n$.

Proof. Define a map $f: \mathbb{Z} \oplus \mathbb{Z} \rightarrow G$ by $f(i, j)=i s+j s^{\prime}$. Put $A=\left\{(i, j):-k_{1} \leq\right.$ $\left.i \leq n-2,0 \leq j \leq k_{2}\right\}$.

If $\left.f\right|_{A}: A \rightarrow G$ is not an injective map, then there are two distinct elements $\left(i_{1}, j_{1}\right),\left(i_{2}, j_{2}\right)$ of $A$ such that $i_{1} s+j_{1} s^{\prime}=i_{2} s+j_{2} s^{\prime}, i_{1}, i_{2} \in\left[-k_{1}, n-2\right]$, $j_{1}, j_{2} \in\left[0, k_{2}\right]$. Note that $i_{1}=i_{2}$ implies $j_{1} s^{\prime}=j_{2} s^{\prime}, j_{1}, j_{2} \in\left[0, k_{2}\right]$, so $j_{1}=j_{2}$, a contradiction. If $j_{1}=j_{2}$, then $\left(i_{1}-i_{2}\right) s=0$, and hence $\operatorname{ord}(s) \leq\left|i_{1}-i_{2}\right| \leq$ $n+k_{1}-2 \leq k_{1}+k_{2}-1$, which is also impossible. Therefore we may assume that $i_{1}<i_{2}$ and $j_{1} \neq j_{2}$. Thus, $\left(i_{2}-i_{1}\right) s+\left(j_{2}-j_{1}\right) s^{\prime}=0$, where $1 \leq i_{2}-i_{1} \leq n+k_{1}-2$ and $1 \leq\left|j_{2}-j_{1}\right| \leq k_{2}$. If $1 \leq j_{2}-j_{1} \leq k_{2}$, then statement (a) holds. If $1 \leq j_{1}-j_{2} \leq k_{2}$, then $\left(i_{2}-i_{1}\right) s=\left(j_{1}-j_{2}\right) s^{\prime}$, which implies $k_{2} \leq n+k_{1}-3$.

Now suppose that $\left.f\right|_{A}: A \rightarrow G$ is injective. Then $|A|=|f(A)| \leq|G|=$ $n\left(k_{1}+k_{2}\right)+1$. Since $|A|=\left(n-1+k_{1}\right)\left(k_{2}+1\right)=n\left(k_{1}+k_{2}\right)+\left(k_{2}+1-n\right)\left(k_{1}-1\right)$, $k_{1} \geq 1$ and $k_{2} \geq n-1$, we must have that $k_{2}=n-1$ or $k_{1}=1$ or $k_{1}=2, k_{2}=n$.

If $k_{1}=1$ or $k_{2}=n-1$, then $|A|=|f(A)|=|G|-1$. Put

$$
f(A)=G \backslash\{x\} .
$$

Then $\left\{x-s, x+s, x-s^{\prime}, x+s^{\prime}\right\} \subseteq G \backslash\{x\}$. By the same arguments as in the proof Lemma 4.1, we have

$$
\begin{gathered}
x-s=f\left(n-2, j_{1}\right)=(n-2) s+j_{1} s^{\prime} \\
x+s=f\left(-1, j_{2}\right)=-s+j_{2} s^{\prime} \\
x-s^{\prime}=f\left(i_{1}, k_{2}\right)=i_{1} s+k_{2} s^{\prime} \\
x+s^{\prime}=f\left(i_{2}, 0\right)=i_{2} s
\end{gathered}
$$

where $i_{1}, i_{2} \in[-1, n-2]$ and $j_{1}, j_{2} \in\left[0, k_{2}\right]$. Hence

$$
x=(n-1) s+j_{1} s^{\prime}=-2 s+j_{2} s^{\prime}=i_{1} s+\left(k_{2}+1\right) s^{\prime}=i_{2} s-s^{\prime} .
$$

It follows from $(n-1) s+j_{1} s^{\prime}=i_{1} s+\left(k_{2}+1\right) s^{\prime}$ that

$$
\left(n-1-i_{1}\right) s=\left(k_{2}+1-j_{1}\right) s^{\prime}
$$

where $1 \leq n-1-i_{1} \leq n$ and $1 \leq k_{2}+1-j_{1} \leq k_{2}+1$. If $1 \leq k_{2}+1-j_{1} \leq k_{2}$ that is $j_{1} \in\left[1, k_{2}\right]$, then $n-1-i_{1}>k_{2}$. Since $k_{2} \geq n-1$, we obtain that $k_{2}=n-1$ and $i_{1}=-1$. Hence,

$$
j_{1}=0 \text { or } k_{2}=n-1, i_{1}=-1
$$

Similarly, $-2 s+j_{2} s^{\prime}=i_{2} s-s^{\prime}$ implies $\left(i_{2}+2\right) s=\left(j_{2}+1\right) s^{\prime}$ with $1 \leq i_{2}+2 \leq n$ and $1 \leq j_{2}+1 \leq k_{2}+1$. Thus

$$
j_{2}=k_{2} \text { or } k_{2}=n-1, i_{2}=n-2 .
$$

By $-2 s+j_{2} s^{\prime}=i_{1} s+\left(k_{2}+1\right) s^{\prime}$, we get $\left(i_{1}+2\right) s+\left(k_{2}+1-j_{2}\right) s^{\prime}=0$ with $1 \leq i_{1}+2 \leq n$ and $1 \leq k_{2}+1-j_{2} \leq k_{2}+1$. If the statement ( $a$ ) does not hold, then $i_{1}+2=n$ or $k_{2}+1-j_{2}=k_{2}+1$, that is

$$
i_{1}=n-2 \text { or } j_{2}=0
$$

From $(n-1) s+j_{1} s^{\prime}=i_{2} s-s^{\prime}$, we have $\left(n-1-i_{2}\right) s+\left(j_{1}+1\right) s^{\prime}=0$ with $1 \leq n-1-i_{2} \leq n$ and $1 \leq j_{1}+1 \leq k_{2}+1$. Hence the statement $(a)$ is not true yields $n-1-i_{2}=n$ or $j_{1}+1=k_{2}+1$, that is

$$
i_{2}=-1 \text { or } j_{1}=k_{2}
$$

Hence, $\left(j_{1}, j_{2}, i_{1}, i_{2}\right)=\left(0, k_{2}, n-2,-1\right),-s^{\prime}=n s$ or $\left(j_{1}, j_{2}, i_{1}, i_{2}\right)=\left(k_{2}, 0,-1, n-\right.$ 2), $k_{2}=n-1$. If $-s^{\prime}=n s$, then $n \geq k_{2}+1$. By $k_{2} \geq n-1, k_{2}=n-1$. This completes the proof.

Lemma 4.4 ( 8 Theorems 4.3-4.4) Let $p$ be an odd prime with $p \equiv 1(\bmod 4)$. Then there exists a perfect $B[-1,3](p)$ set if and only if 6 is a quartic residue modulo $p$, if $p \equiv 5(\bmod 8) ; ~ o\left(-\frac{3}{2}\right)$ is odd and $4 \|<-1,2,3>\mid$, if $p \equiv 1(\bmod$ 8).

Lemma 4.5 ([1], Theorem 2.2.3) Let $G$ be a finite group and $M$ a set of nonzero integers. Then $M$ splits $G$ nonsingularly if and only if $M$ splits $\mathbb{Z}_{p}$ for each prime divisor $p$ of $|G|$.

For a finite group $G$, if the size of its splitter set $S$ is 2 , then it is easy to prove the following result.
Lemma 4.6 Let $k_{1}$ and $k_{2}$ be integers with $0 \leq k_{1}<k_{2}$ and let $M=\left[-k_{1}, k_{2}\right]^{*}$. If $M$ splits an abelian group $G$ of order $2|M|+1$, then $G$ is cyclic and $k_{1}=0$.

Proof. Let $S=\left\{g_{1}, g_{2}\right\}$ be a splitter set, then $G \backslash\{0\}=\left[-k_{1}, k_{2}\right]^{*} \cdot\left\{g_{1}, g_{2}\right\}$. Suppose $G$ is not a cyclic group, we see that $g_{1}+g_{2} \notin\left[-k_{1}, k_{2}\right]^{*} \cdot\left\{g_{1}, g_{2}\right\}$, a contradiction.

Since $G$ is a cyclic group, without loss of generality, we may assume that $G=\mathbb{Z}_{2|M|+1}$ and $S=\{1, a\}$ is a splitter set. If $k_{1}>0$, then the statement $(a)$ in Lemma 4.3 says that there are integers $x$ and $y$ such that $1 \leq x \leq n+k_{1}-2=k_{1}$, $1 \leq y \leq k_{2}$ and $x+y a=0$, that is $y=-x \cdot a$ with $-x, y \in\left[-k_{1}, k_{2}\right]^{*}$, which is impossible.

By the statement (b) in Lemma 4.3, we have $k_{2} \leq k_{1}-1$ or $k_{1}=k_{2}=1$ or $k_{1}=k_{2}=2$. This contradicts with $k_{1}<k_{2}$. Therefore $k_{1}=0$ and $M=\left[1, k_{2}\right]$.

Proposition 4.2 Let $n, k_{1}$ and $k_{2}$ be integers with $n \geq 2$ and $1 \leq k_{1}<k_{2}$. If $\left[-k_{1}, k_{2}\right]^{*}$ splits a cyclic group $G$ of order $n\left(k_{1}+k_{2}\right)+1$, then $k_{2} \leq 2 n-5$.

Proof. If $n=2$, the result follows immediately from Lemma 4.6,
For $n \geq 3$ and $k_{2} \geq n-1$, following the argument in the proof of Proposition 4.1, we see that the statement (a) in Lemma 4.3 does not hold.

Suppose that the statement (b) in Lemma 4.3 holds. Then $k_{2} \leq n+k_{1}-3$ or $k_{1}=1, k_{2}=n-1$ or $k_{1}=2, k_{2}=n$. By Proposition 4.1, $k_{2} \leq n+k_{1}-3$ implies $k_{2} \leq 2 n-5$. For $\left(k_{1}, k_{2}\right)=(1, n-1)$ or $(2, n)$, if $n \geq 5$, it is easily seen that $k_{2} \leq 2 n-5$. If $n=4$, then we infer that $[-1,3]^{*}$ splits the cyclic group $\mathbb{Z}_{17}$ or $[-2,4]^{*}$ splits an abelian group $G$ of order 25 . However, Lemma 4.4 yields that $[-1,3]^{*}$ can not split $\mathbb{Z}_{17}$. In addition, Lemma 4.5 yields that $[-2,4]^{*}$ splits the cyclic group $\mathbb{Z}_{5}$, which is impossible.

If $n=3$, by Proposition 4.1, $k_{1} \leq n-2$ implies $\left(k_{1}, k_{2}\right)=(1,2)$. It follows from the proof of Lemma 4.3 that $|G|=n\left(k_{1}+k_{2}\right)+1=10$, so $[-1,2]^{*}$ splits the cyclic group $\mathbb{Z}_{5}$ by Lemma 4.5, which is impossible. This completes the proof.

The proofs of Theorem 1.2: The proof follows immediately from Propositions 4.1 and 4.2 .

## 5 Proofs of Theorems 1.3-1.5

In this section, we will prove Theorems 1.3, 1.4 and 1.5. We first prove Theorem 1.3.

Proof of Theorem 1.3: Since $\operatorname{gcd}(s, m)=1$ for all $s \in S$ and the splitting is purely singular, then for any prime $p \mid m$ we have $p \leq k_{2}$, and for any $d \mid m, 1<$ $d<m$,

$$
\left\{g \in \mathbb{Z}_{m} \backslash\{0\}: d \mid g\right\}=M_{d} \cdot S,
$$

where $M_{d}=\left\{i \in\left[-k_{1}, k_{2}\right]^{*}: d \mid i\right\}$. Hence $d \leq k_{2}$ and $\left|\left\{g \in \mathbb{Z}_{m} \backslash\{0\}: d \mid g\right\}\right|=$ $\frac{m}{d}-1=\left|M_{d}\right| \cdot|S|=\left(\left[\frac{k_{1}}{d}\right]+\left[\frac{k_{2}}{d}\right]\right) \cdot|S|$. Let $k_{1}=u_{1} d+v_{1}, v_{1} \in[0, d-1]$ and $k_{2}=$ $u_{2} d+v_{2}, v_{2} \in[0, d-1]$, then $u_{1}=\left[\frac{k_{1}}{d}\right]$ and $u_{2}=\left[\frac{k_{2}}{d}\right]$. Form $m=\left(k_{1}+k_{2}\right)|S|+1$, we have
$\left(u_{1}+u_{2}\right)|S|=\frac{\left(\left(u_{1}+u_{2}\right) d+\left(v_{1}+v_{2}\right)\right)|S|+1}{d}-1=\left(u_{1}+u_{2}\right)|S|+\frac{\left(v_{1}+v_{2}\right)|S|+1}{d}-1$.
Since $d \leq k_{2}$, we see that

$$
\left(v_{1}+v_{2}\right)|S|=d-1 \leq k_{2}-1,
$$

which implies that $v_{1}+v_{2} \geq 1$.
If $k_{1}=k_{2}$, then $|S| \geq 2$ and Lemma 2.1 implies $k_{2} \leq|S|-1$. Hence $|S| \leq$ $\left(v_{1}+v_{2}\right)|S|=d-1 \leq k_{2}-1 \leq|S|-2$, a contradiction. Therefore $|S|=1$ and $m=k_{1}+k_{2}+1$. If $k_{1}=0$ and $|S| \geq 3$, then $k_{2} \leq|S|-2$ by Lemma 2.2. Hence $|S| \leq\left(v_{1}+v_{2}\right)|S| \leq k_{2}-1 \leq|S|-3$, again a contradiction. If $k_{1}=0$ and $|S|=2$, it follows that $m=2 k_{2}+1$.

If $1 \leq k_{1}<k_{2}$ and $|S| \geq 2$, by Proposition 4.2 we have $k_{2} \leq 2|S|-5$. Hence

$$
|S| \leq\left(v_{1}+v_{2}\right)|S|=d-1 \leq k_{2}-1 \leq 2|S|-6
$$

It follows that $v_{1}+v_{2}=1$ and $|S|=d-1$ for any $d \mid m, 1<d<m$. This means that $m$ has only one positive divisor other than 1 and $m$, so $m=p^{2}$ for some prime $p$. In this case, we have $k_{1}=1, k_{2}=p$ and $|S|=p-1$,

$$
p S=\left\{p \in \mathbb{Z}_{p^{2}} \backslash\{0\}, p \mid g\right\}=\left\{i p \quad\left(\bmod p^{2}\right), i \in[1, p-1]\right\}
$$

Hence we may assume that

$$
S=\left\{l_{i} p+i \mid 1 \leq i \leq p-1 \text { and } 1 \leq l_{i} \leq p\right\}
$$

Let

$$
l_{p-1}=p-j
$$

for some $j \in[1, p]$. If $j=1$, then $l_{p-1} p+p-1 \equiv-1\left(\bmod p^{2}\right) \in S$, a contradiction. If $j \in[2, p-1]$, let $y$ be the least positive integer modulo $p$ such that $(p-1) y \equiv 1(\bmod p)$, then $\left(l_{p-1} p+p-1\right)(p-y) \equiv(j-1) y p-p+y \equiv y$
$\left(\bmod p^{2}\right)$. This means $y$ has two different representations in $[-1, p]^{*} \cdot S$, again a contradiction. This completes the proof.

To prove Theorem 1.4, we also need the following result for the splittings of cyclic groups.

Lemma 5.1 ([5], Theorem 3.2) If $p$ is an odd prime and $\mathbb{Z}_{p^{\alpha}} \backslash\{0\}=M S$ is a splitting, then either $M$ or $S$ contains only elements relatively prime to $p$.

Corollary 5.1 Let $\alpha, k_{1}, k_{2}$ be integers, $\alpha \geq 2,0 \leq k_{1} \leq k_{2}$ and $k_{2} \geq 3$, and let $p_{0}, p, q$ be primes, $p_{0} \neq 2$. Suppose that $\left[-k_{1}, k_{2}\right]^{*}$ splits a cyclic group $\mathbb{Z}_{m}$. If the splitting is purely singular and $m=p_{0}^{\alpha}$ or $p q$, then either $m=k_{1}+k_{2}+1$ or $k_{1}=0$ and $m=2 k_{2}+1$.

Let $S$ be the splitter set. By Theorem 1.3, it suffices to show that $\operatorname{gcd}(s, m)=$ 1 for all $s \in S$. If $m=p_{0}^{\alpha}$, since the splitting is purely singular, so it follows from Lemma 5.1] that $\operatorname{gcd}(s, m)=1$ for all $s \in S$.

Put

$$
M_{\ell}=\left\{k \in\left[-k_{1}, k_{2}\right]^{*}: \ell \mid k\right\}, \quad S_{\ell}=\{s \in S: \ell \mid s\} .
$$

If $m=p q$, since the splitting is purely singular, so we have $\left|M_{p}\right|>0$ and $\left|M_{q}\right|>0$. Hence $\left|S_{p}\right|=\left|S_{q}\right|=0$, for otherwise 0 is contained in $\left[-k_{1}, k_{2}\right]^{*} \cdot S=\mathbb{Z}_{m} \backslash\{0\}$. It follows that $\operatorname{gcd}(s, m)=1$ for all $s \in S$. This completes the proof.

## Proof of Theorem 1.4:

For $\alpha=0$, the result follows immediately from Corollary 5.1.
If $\alpha>0$, since $m \equiv 1\left(\bmod k_{1}+k_{2}\right)$, so $k_{1}+k_{2}$ is odd and $2 \mid k_{1}+k_{2}+1$. It follows that $2 \mid\left(k_{1}+k_{2}+1, m\right)>1$. By Lemma 2.5, we obtain that $k_{1}+k_{2}+1 \mid m$ and $\operatorname{gcd}\left(k_{1}+k_{2}+1, \frac{m}{k_{1}+k_{2}+1}\right)=1$. Thus $2^{\alpha} \mid k_{1}+k_{2}+1$ and $\frac{m}{k_{1}+k_{2}+1}=p^{\gamma}$ or $p_{1} p_{2}$. Recall that $\left[-k_{1}, k_{2}\right]^{*}$ splits both $\mathbb{Z}_{m}$ and $\mathbb{Z}_{k_{1}+k_{2}+1}$. It follows from Lemma 2.3 that $\left[-k_{1}, k_{2}\right]^{*}$ splits $\mathbb{Z}_{\frac{m}{k_{1}+k_{2}+1}}$, so $\frac{m}{k_{1}+k_{2}+1}=k_{1}+k_{2}+1$ by Corollary 5.1, which contradicts with Lemma [2.5. This completes the proof of Theorem 1.4.

To prove Theorem 1.5, we need some other results. The following result follows immediately from a similar argument as in Lemma 15 [9]. We have

Lemma 5.2 Let $n, k_{1}$ and $k_{2}$ be positive integers with $0 \leq k_{1}<k_{2}$. Suppose $B$ is a perfect $B\left[-k_{1}, k_{2}\right](n)$ set. Set $\mathbb{Z}_{n}^{\prime}=\left\{i: i \in \mathbb{Z}_{n}, \operatorname{gcd}(i, n)=1\right\}, M(n)=$ $\left\{i: i \in\left[-k_{1}, k_{2}\right]^{*}, \operatorname{gcd}(i, n)=1\right\}$ and $B(n)=\{i: i \in B, \operatorname{gcd}(i, n)=1\}$. Then $\mathbb{Z}_{n}^{\prime}=M(n) \cdot B(n)$.

We also need the following result.
Proposition 5.1 Let $G$ be an abelian group (written multiplicatively) with $|G|=$ $2 m, m \in \mathbb{N}$. Suppose $N$ is a subset of $G$ such that $\{1, a\} \subseteq N, a \neq 1, a^{2}=1$, where 1 denote the unity of the group $G$, and $|N|$ is odd, then $N$ is not a direct factor of $G$.

Proof. If $N$ is a direct factor of $G$, then there exists a sunset $A$ of $G$ such that $N \cdot A=G$ is a factorization. Since $|N|$ is odd, by Proposition $2.1, N^{2} \cdot A$ is also a factorization of $G$, which implies that $\left|N^{2}\right|=|N|$. However, $1^{2}=a^{2}=1$ in $G$, it follows that $\left|N^{2}\right| \leq|N|-1$, a contradiction.

Proof of Theorem 1.5: Recall that Hickerson have verified the theorem for all $[1, k]$ with $k<3000$. Moreover, Zhang and Ge [9] solved the case $[-1, k]^{*}$ when $k=3,4,5,6,8,9,10$ and $[-2, k]^{*}$ when $k=3,4,6$. So we need only consider the case with $k_{1}>0$. By Theorem 1.4 and Lemma 2.5, to prove Theorem 1.5 , it suffices to show that $\left[-k_{1}, k_{2}\right]^{*}$ does not split the cyclic group $\mathbb{Z}_{m}$ with $\operatorname{gcd}\left(m,\left(k_{1}+k_{2}\right)\left(k_{1}+k_{2}+1\right)\right)=1, m$ has at least two distinct odd prime divisors and $m$ has no prime divisor greater than $k_{2}$. Now we prove the theorem case by case.

For $k_{1}+k_{2} \leq 6$, there is not any $m$ with the above property.

- $k_{1}+k_{2}=7,\left[-k_{1}, k_{2}\right]^{*}=[-2,5]^{*}$. For this case, $m=3^{\alpha} 5^{\beta}, \alpha, \beta \in \mathbb{N}$. By Lemma 5.2, $\mathbb{Z}_{n}^{\prime}=B \cdot M$, where $M=\{-2,-1,1,2,4\}$, is a factorization. Since $|M|=5$ is odd, $(-1)^{2}=1$ and $\left|\mathbb{Z}_{n}^{\prime}\right|=\varphi(m)$ is even, so it is impossible by Proposition 5.1. Thus there does not exist any purely singular perfect $B[-2,5](m)$ set except for $m=1,8$.
$\bullet k_{1}+k_{2}=8,\left[-k_{1}, k_{2}\right]^{*}=[-1,7]^{*}$. For this case, $m=5^{\alpha} 7^{\beta}, \alpha, \beta \in \mathbb{N}$. Put
$B_{0}=\{x \in B, \operatorname{gcd}(x, m)=1\}, \quad B_{5}=\{x \in B, \operatorname{gcd}(x, m)=5\}, \quad B_{7}=\{x \in B, \operatorname{gcd}(x, m)=7\}$.
By calculating the number of the elements $x$ of $\mathbb{Z}_{m}$ with $\operatorname{gcd}(x, m)=1, \operatorname{gcd}(x, m)=$ 5 and $\operatorname{gcd}(x, m)=7$, respectively, we get

$$
6\left|B_{0}\right|=\varphi(m)=4 \cdot 6 \cdot 5^{\alpha-1} 7^{\beta-1}
$$

so $\left|B_{0}\right|=4 \cdot 5^{\alpha-1} 7^{\beta-1}$. If $\alpha>1$, then we have

$$
6\left|B_{5}\right|+\left|B_{0}\right|=\varphi\left(\frac{m}{5}\right)=4 \cdot 6 \cdot 5^{\alpha-2} 7^{\beta-1}
$$

which implies that $3\left|\left|B_{0}\right|\right.$, a contradiction. If $\beta>1$, then we have

$$
6\left|B_{7}\right|+\left|B_{0}\right|=\varphi\left(\frac{m}{7}\right)=4 \cdot 6 \cdot 5^{\alpha-1} 7^{\beta-2}
$$

which also implies that $3\left|\left|B_{0}\right|\right.$, again a contradiction. Hence $m=35 \not \equiv 1$ $(\bmod 8)$, which is impossible. Thus there does not exist any purely singular perfect $B[-1,7](m)$ set except for $m=1,9$.

- $k_{1}+k_{2}=9$. Then $\operatorname{gcd}(m, 30)=1$, and there are no such $m$ satisfies the required properties. Hence, there does not exist any purely singular perfect $B\left[-k_{1}, k_{2}\right](m)$ set except for $m=1,10$.
- $k_{1}+k_{2}=10,\left[-k_{1}, k_{2}\right]^{*}=[-2,8]^{*}$. For this case, $m=3^{\alpha} 7^{\beta}, \alpha, \beta \in \mathbb{N}$. By Lemma 5.2, $\mathbb{Z}_{n}^{\prime}=B \cdot M$, where $M=\{-2,-1,1,2,4,5,8\}$, is a factorization.

Since $|M|=7$ is odd, $(-1)^{2}=1$ and $\left|\mathbb{Z}_{n}^{\prime}\right|=\varphi(m)$ is even, so it is impossible by Proposition 5.1. Thus there does not exist any purely singular perfect $B[-2,8](m)$ set except for $m=1$.

- $k_{1}+k_{2}=10,\left[-k_{1}, k_{2}\right]^{*}=[-3,7]^{*}$. For this case, $m=3^{\alpha} 7^{\beta}, \alpha, \beta \in \mathbb{N}$. Put
$B_{0}=\{x \in B, \operatorname{gcd}(x, m)=1\}, \quad B_{3}=\{x \in B, \operatorname{gcd}(x, m)=3\}, \quad B_{7}=\{x \in B, \operatorname{gcd}(x, m)=7\}$.
By calculating the number of the elements $x$ of $\mathbb{Z}_{m}$ with $\operatorname{gcd}(x, m)=1, \operatorname{gcd}(x, m)=$ 3 and $\operatorname{gcd}(x, m)=7$, respectively, we get

$$
6\left|B_{0}\right|=\varphi(m)=2 \cdot 6 \cdot 3^{\alpha-1} 7^{\beta-1}
$$

so $\left|B_{0}\right|=2 \cdot 3^{\alpha-1} 7^{\beta-1}$. If $\alpha>1$, then we have

$$
6\left|B_{5}\right|+3\left|B_{0}\right|=\varphi\left(\frac{m}{3}\right)=2 \cdot 6 \cdot 3^{\alpha-2} 7^{\beta-1}<3\left|B_{0}\right|
$$

a contradiction. If $\beta>1$, then we have

$$
6\left|B_{7}\right|+\left|B_{0}\right|=\varphi\left(\frac{m}{7}\right)=2 \cdot 6 \cdot 3^{\alpha-1} 7^{\beta-2}<\left|B_{0}\right|
$$

again a contradiction. Hence $m=21 \not \equiv 1(\bmod 8)$, which is impossible. Thus there does not exist any purely singular perfect $B[-3,7](m)$ set except for $m=1$.

- $k_{1}+k_{2}=11,\left[-k_{1}, k_{2}\right]^{*}=[-2,9]^{*}$. For this case, $m=5^{\alpha} 7^{\beta}, \alpha, \beta \in$ $\mathbb{N}$. By Lemma 5.2, $\mathbb{Z}_{n}^{\prime}=B \cdot M$, where $M=\{-2,-1,1,2,3,4,6,8,9\}$, is a factorization. Since $|M|=9$ is odd, $(-1)^{2}=1$ and $\left|\mathbb{Z}_{n}^{\prime}\right|=\varphi(m)$ is even, so it is impossible by Proposition 5.1. Thus there does not exist any purely singular perfect $B[-2,9](m)$ set except for $m=1,12$.
- $k_{1}+k_{2}=11,\left[-k_{1}, k_{2}\right]^{*}=[-3,8]^{*}$ or $[-4,7]^{*}$. The argument is the same as the proof of the case $\left[-k_{1}, k_{2}\right]^{*}=[-2,9]^{*}$.
- $k_{1}+k_{2}=12,\left[-k_{1}, k_{2}\right]^{*}=[-1,11]^{*}$. For this case, $m=5^{\alpha} 7^{\beta} 11^{\gamma}, \alpha, \beta, \gamma \in \mathbb{N}$ or $m=5^{\alpha} 11^{\gamma}, \alpha, \gamma \in \mathbb{N}$ or $m=7^{\beta} 11^{\gamma}, \beta, \gamma \in \mathbb{N}$ or $m=5^{\alpha} 7^{\beta}, \alpha, \beta \in \mathbb{N}$. If $m=5^{\alpha} 7^{\beta} 11^{\gamma}, \alpha, \beta, \gamma \in \mathbb{N}$, let $S_{11}=\{x \in B, \operatorname{gcd}(x, 11)=1\}$, by calculating the number of the elements $x$ of $\mathbb{Z}_{m}$ with $\operatorname{gcd}(x, 11)=1$, we obtain $11 S_{11}=$ $10 \cdot 5^{\alpha} 7^{\beta} 11^{\gamma-1}$, which implies that $\gamma>1$. Put

$$
B_{0}=\{x \in B, \operatorname{gcd}(x, m)=1\}, \quad B_{11}=\{x \in B, \operatorname{gcd}(x, m)=11\} .
$$

By calculating the number of the elements $x$ of $\mathbb{Z}_{m}$ with $\operatorname{gcd}(x, m)=1$ and $\operatorname{gcd}(x, m)=11$, respectively, we get

$$
8\left|B_{0}\right|=240 \cdot 5^{\alpha-1} 7^{\beta-1} 11^{\gamma-1}
$$

so $\left|B_{0}\right|=30 \cdot 5^{\alpha-1} 7^{\beta-1} 11^{\gamma-1}$. Since $\gamma>1$, then we have

$$
\left|B_{0}\right|+8\left|B_{11}\right|=\varphi\left(\frac{m}{11}\right)=240 \cdot 5^{\alpha-1} 7^{\beta-1} 11^{\gamma-2}
$$

therefore $8 \| B_{0} \mid=30 \cdot 5^{\alpha-1} 7^{\beta-1} 11^{\gamma-1}$, a contradiction. If $m=5^{\alpha} 11^{\gamma}, \alpha, \gamma \in \mathbb{N}$ or $m=5^{\alpha} 7^{\beta}, \alpha, \beta \in \mathbb{N}$, let

$$
B_{0}=\{x \in B, \operatorname{gcd}(x, m)=1\} .
$$

Calculating the number of the elements $x$ of $\mathbb{Z}_{m}$ with $\operatorname{gcd}(x, m)=1$, we get $9\left|B_{0}\right|=40 \cdot 5^{\alpha-1} 11^{\gamma-1}$ or $9\left|B_{0}\right|=24 \cdot 5^{\alpha-1} 7^{\beta-1}$, which is impossible. If $m=$ $7^{\beta} 11^{\gamma}, \beta, \gamma \in \mathbb{N}$, let $S_{11}=\{x \in B, \operatorname{gcd}(x, 11)=1\}$, by calculating the number of the elements $x$ of $\mathbb{Z}_{m}$ with $\operatorname{gcd}(x, 11)=1$, we obtain $11 S_{11}=10 \cdot 7^{\beta} 11^{\gamma-1}$, which implies that $\gamma>1$. Put

$$
B_{0}=\{x \in B, \operatorname{gcd}(x, m)=1\}, \quad B_{11}=\{x \in B, \operatorname{gcd}(x, m)=11\} .
$$

By calculating the number of the elements $x$ of $\mathbb{Z}_{m}$ with $\operatorname{gcd}(x, m)=1$ and $\operatorname{gcd}(x, m)=11$, respectively, we get

$$
10\left|B_{0}\right|=60 \cdot 7^{\beta-1} 11^{\gamma-1}
$$

so $\left|B_{0}\right|=6 \cdot 7^{\beta-1} 11^{\gamma-1}$. Since $\gamma>1$, then we have

$$
\left|B_{0}\right|+10\left|B_{11}\right|=\varphi\left(\frac{m}{11}\right)=60 \cdot 5^{\alpha-1} 7^{\beta-1} 11^{\gamma-2}<\left|B_{0}\right|
$$

a contradiction. Thus there does not exist any purely singular perfect $B[-1,11](m)$ set except for $m=1$.

- $k_{1}+k_{2}=12,\left[-k_{1}, k_{2}\right]^{*}=[-2,10]^{*},[-3,9]^{*},[-4,8]^{*}$ or $[-5,7]^{*}$. For these cases, $m=5^{\alpha} 7^{\beta}, \alpha, \beta \in \mathbb{N}$. Put $S_{7}=\{x \in B, \operatorname{gcd}(x, 7)=1\}$, by calculating the number of the elements $x$ of $\mathbb{Z}_{m}$ with $\operatorname{gcd}(x, 11)=1$, we obtain $11 S_{7}=$ $6 \cdot 5^{\alpha} 7^{\beta-1}$, which is impossible. Thus there does not exist any purely singular perfect $B\left[-k_{1}, k_{2}\right](m)$ set except for $m=1$.
- $k_{1}+k_{2}=13,\left[-k_{1}, k_{2}\right]^{*}=[-1,12]^{*}$. For this case, $m=3^{\alpha} 5^{\beta} 11^{\gamma}, \alpha, \beta, \gamma \in \mathbb{N}$ or $m=3^{\alpha} 11^{\gamma}, \alpha, \gamma \in \mathbb{N}$ or $m=5^{\beta} 11^{\gamma}, \beta, \gamma \in \mathbb{N}$ or $m=3^{\alpha} 5^{\beta}, \alpha, \beta \in \mathbb{N}$. If $m=3^{\alpha} 5^{\beta} 11^{\gamma}, \alpha, \beta, \gamma \in \mathbb{N}$ or $m=3^{\alpha} 11^{\gamma}, \alpha, \gamma \in \mathbb{N}$ or $m=5^{\beta} 11^{\gamma}, \beta, \gamma \in \mathbb{N}$, let $S_{11}=\{x \in B, \operatorname{gcd}(x, 11)=1\}$, by calculating the number of the elements $x$ of $\mathbb{Z}_{m}$ with $\operatorname{gcd}(x, 11)=1$, we obtain $12 S_{11}=10 \cdot 3^{\alpha} 5^{\beta} 11^{\gamma-1}$ or $12 S_{11}=10 \cdot 3^{\alpha} 11^{\gamma-1}$ or $12 S_{11}=10 \cdot 5^{\beta} 11^{\gamma-1}$, which is impossible. If $m=3^{\alpha} 5^{\beta}, \alpha, \beta \in \mathbb{N}$, let $B_{0}=$ $\{x \in B, \operatorname{gcd}(x, m)=1\}$, then we calculate the number of the elements $x$ of $\mathbb{Z}_{m}$ with $\operatorname{gcd}(x, m)=1$, we obtain $7 S_{0}=8 \cdot 3^{\alpha-1} 5^{\beta-1}$, which is impossible. Thus there does not exist any purely singular perfect $B[-1,12](m)$ sets except for $m=1,14$.
- $k_{1}+k_{2}=13,\left[-k_{1}, k_{2}\right]^{*}=[-2,11]^{*}$. For this case, $m=3^{\alpha} 5^{\beta} 11^{\gamma}, \alpha, \beta, \gamma \in \mathbb{N}$ or $m=3^{\alpha} 11^{\gamma}, \alpha, \gamma \in \mathbb{N}$ or $m=5^{\beta} 11^{\gamma}, \beta, \gamma \in \mathbb{N}$ or $m=3^{\alpha} 5^{\beta}, \alpha, \beta \in \mathbb{N}$. If $m=3^{\alpha} 5^{\beta} 11^{\gamma}, \alpha, \beta, \gamma \in \mathbb{N}$, let $B_{0}=\{x \in B, \operatorname{gcd}(x, m)=1\}$, then we calculate the number of the elements $x$ of $\mathbb{Z}_{m}$ with $\operatorname{gcd}(x, m)=1$, we obtain $7\left|B_{0}\right|=80$. $3^{\alpha-1} 5^{\beta-1} 11^{\gamma-1}$, which is impossible. If $m=3^{\alpha} 11^{\gamma}, \alpha, \gamma \in \mathbb{N}$ or $m=5^{\beta} 11^{\gamma}, \beta, \gamma \in$ $\mathbb{N}$, let $S_{11}=\{x \in B, \operatorname{gcd}(x, 11)=1\}$, by calculating the number of the elements $x$
of $\mathbb{Z}_{m}$ with $\operatorname{gcd}(x, 11)=1$, we obtain $12 S_{11}=10 \cdot 3^{\alpha} 11^{\gamma-1}$ or $12 S_{11}=10 \cdot 5^{\beta} 11^{\gamma-1}$, which is impossible. If $m=3^{\alpha} 5^{\beta}, \alpha, \beta \in \mathbb{N}$, let $S_{5}=\{x \in B, \operatorname{gcd}(x, 5)=1\}$, then we calculate the number of the elements $x$ of $\mathbb{Z}_{m}$ with $\operatorname{gcd}(x, 5)=1$, we obtain $11\left|S_{5}\right|=4 \cdot 3^{\alpha} 5^{\beta-1}$, which is impossible. Thus there does not exist any purely singular perfect $B[-2,11](m)$ sets except for $m=1,14$.
- $k_{1}+k_{2}=13,\left[-k_{1}, k_{2}\right]^{*}=[-3,10]^{*}$. For this case, $m=3^{\alpha} 5^{\beta}, \alpha, \beta \in \mathbb{N}$, let $B_{0}=\{x \in B, \operatorname{gcd}(x, m)=1\}$, then we calculate the number of the elements $x$ of $\mathbb{Z}_{m}$ with $\operatorname{gcd}(x, m)=1$, we obtain $7 S_{0}=8 \cdot 3^{\alpha-1} 5^{\beta-1}$, which is impossible. Thus there does not exist any purely singular perfect $B[-3,10](m)$ sets except for $m=1,14$.
- $k_{1}+k_{2}=13,\left[-k_{1}, k_{2}\right]^{*}=[-4,9]^{*}$ or $[-5,8]^{*}$. For these two cases, $m=3^{\alpha} 5^{\beta}$, $\alpha, \beta \in \mathbb{N}$. Put
$B_{0}=\{x \in B, \operatorname{gcd}(x, m)=1\}, \quad B_{3}=\{x \in B, \operatorname{gcd}(x, m)=3\}, \quad B_{5}=\{x \in B, \operatorname{gcd}(x, m)=5\}$.
By calculating the number of the elements $x$ of $\mathbb{Z}_{m}$ with $\operatorname{gcd}(x, m)=1, \operatorname{gcd}(x, m)=$ 3 and $\operatorname{gcd}(x, m)=5$, respectively, we get

$$
8\left|B_{0}\right|=\varphi(m)=8 \cdot 3^{\alpha-1} 5^{\beta-1}
$$

so $\left|B_{0}\right|=3^{\alpha-1} 5^{\beta-1}$. If $\alpha>1$, then we have

$$
8\left|B_{3}\right|+3\left|B_{0}\right|=\varphi\left(\frac{m}{3}\right)=8 \cdot 3^{\alpha-2} 5^{\beta-1}<3\left|B_{0}\right|
$$

a contradiction. If $\beta>1$, then we have

$$
8\left|B_{5}\right|+\sigma\left|B_{0}\right|=\varphi\left(\frac{m}{5}\right)=8 \cdot 3^{\alpha-1} 5^{\beta-2}
$$

where $\sigma=1$ if $\left[-k_{1}, k_{2}\right]^{*}=[-4,9]^{*} ; \sigma=2$ if $\left[-k_{1}, k_{2}\right]^{*}=[-5,8]^{*}$. This implies that $2 \| B_{0} \mid$, a contradiction. Hence $m=15 \not \equiv 1(\bmod 13)$, which is impossible. Thus there does not exist any purely singular perfect $B[-4,9](m)$ or $B[-5,8](m)$ sets except for $m=1,14$.

- $k_{1}+k_{2}=13,\left[-k_{1}, k_{2}\right]^{*}=[-6,7]^{*}$. For this case, $m=3^{\alpha} 5^{\beta}, \alpha, \beta \in \mathbb{N}$, let $B_{0}=\{x \in B, \operatorname{gcd}(x, m)=1\}$, then we calculate the number of the elements $x$ of $\mathbb{Z}_{m}$ with $\operatorname{gcd}(x, m)=1$, we obtain $7 S_{0}=8 \cdot 3^{\alpha-1} 5^{\beta-1}$, which is impossible. Thus there does not exist any purely singular perfect $B[-6,7](m)$ sets except for $m=1,14$.
- $k_{1}+k_{2}=14,\left[-k_{1}, k_{2}\right]^{*}=[-1,13]^{*}$. For this case, $m=11^{\alpha} 13^{\beta}, \alpha, \beta \in \mathbb{N}$, put $B_{0}=\{x \in B, \operatorname{gcd}(x, m)=1\}, \quad B_{11}=\{x \in B, \operatorname{gcd}(x, m)=11\}, \quad B_{13}=$ $\{x \in B, \operatorname{gcd}(x, m)=13\}$. By calculating the number of the elements $x$ of $\mathbb{Z}_{m}$ with $\operatorname{gcd}(x, m)=1, \operatorname{gcd}(x, m)=11$ and $\operatorname{gcd}(x, m)=13$, respectively, we get

$$
12\left|B_{0}\right|=\varphi(m)=120 \cdot 11^{\alpha-1} 13^{\beta-1}
$$

so $\left|B_{0}\right|=10 \cdot 11^{\alpha-1} 13^{\beta-1}$. If $\alpha>1$, then we have

$$
12\left|B_{11}\right|+\left|B_{0}\right|=\varphi\left(\frac{m}{11}\right)=120 \cdot 11^{\alpha-2} 13^{\beta-1}
$$

which implies that $12\left|\left|B_{0}\right|\right.$, a contradiction. If $\beta>1$, then we have

$$
12\left|B_{13}\right|+\left|B_{0}\right|=\varphi\left(\frac{m}{13}\right)=120 \cdot 11^{\alpha-1} 13^{\beta-2}<\left|B_{0}\right|,
$$

again a contradiction. Hence $m=143 \not \equiv 1(\bmod 14)$, which is impossible. Thus there does not exist any purely singular perfect $B[-1,13](m)$ sets except for $m=1,15$. This completes the proof of Theorem 1.5.

Remark: It is easy to see that we can prove more by the method in the proof of Theorem 1.5, since there are many cases have to be discussed, we stop here.

Finally, by Theorem 1.3, we propose the following conjecture which implies both Conjecture 1.1 and Conjecture 1.2 .

Conjecture 5.1 Let $k_{1}, k_{2}$ be integers with $0 \leq k_{1} \leq k_{2}$ and $k_{1}+k_{2} \geq 4$. If there exists a purely singular perfect $B\left[-k_{1}, k_{2}\right](m)$ set with the splitter set $S$, then $\operatorname{gcd}(s, m)=1$ for all $s \in S$.
