# A CONSTRUCTION OF THE FREE SKEW-BRACE

#### Abstract

The aim of this paper is to give a simple construction of the free skew-brace over a set $X$.


## Introduction

The concept of skew-brace was introduced by Guarnieri and Vendramin [1] in order to study non-involutive set theoretical solutions of de braid equation using method of non-commutative ring theory. For the original definition we refer to this paper. In 3] the author ask for a construction of the skew-brace over a set $X$. The free skew-brace over $X$ exist by general result of universal algebra, but the constructions of free objects valid in the context of universal algebra are very involved. So, in this note we present a simple construction of the free skew-brace using the following result established in [2]:

Proposition. A group $(A, \circ)$, endowed with a pair of left actions $b \mapsto a \cdot b$ y $b \mapsto a: b$ on $A$ (as a set), is a skew-brace if and only if the following equality holds:

$$
\begin{equation*}
(a \cdot b) \circ a=(b: a) \circ b \quad \text { for all } a, b \in A \tag{1}
\end{equation*}
$$

1. A construction of the free skew-brace over $X$

To begin with, we recursively define a set $Y$ in the following way: first we set

$$
Y_{1}:=X \sqcup X^{*}
$$

where $X^{*}:=\left\{x^{*}: x \in X\right\}$ is a disjoint copy of the elements of $X$. Next we define the sets

$$
\begin{aligned}
X_{n}^{*} & :=\left\{a \cdot b \mid a, b \in Y_{n-1}, b \neq a^{*} \cdot c \text { for any } c \in Y_{n-1}\right\} \\
X_{n}^{:} & :=\left\{a: b \mid a, b \in Y_{n-1}, b \neq a^{*}: c \text { for any } c \in Y_{n-1}\right\} \\
Y_{n} & :=Y_{n-1} \sqcup\left(X_{n}^{*} \sqcup X_{n}^{\dot{*}}\right) \sqcup\left(X_{n}^{*} \sqcup X_{n}^{*}\right)^{*}
\end{aligned}
$$

where $a \cdot b$ and $a: b$ are formal elements. Then we set $Y:=\bigcup_{n \geq 1} Y_{n}$ and we let $G$ denotes the free group $F(Y)$ over $Y$ (with underlying set the collection of reduced words, with the element $x^{*}$ playing the roll of the inverse of $x$ ). In the sequel, we are going to denote the multiplication of $G$ by juxtaposition $a \circ b=a b$.

The next step is to define maps • and : from $Y \times Y$ to $Y$ by

$$
\begin{aligned}
& a \cdot b= \begin{cases}a \cdot b & \text { if } b \neq a^{*} \cdot c \\
c & \text { if } b=a^{*} \cdot c\end{cases} \\
& a: b= \begin{cases}a: b & \text { if } b \neq a^{*}: c \\
c & \text { if } b=a^{*}: c\end{cases}
\end{aligned}
$$

We want to extend both • and : to left actions of $G$ on $G$ in such away that $(a \cdot b) a=(b: a) b$ for all $a, b \in G$, which happen if and only if

$$
\begin{equation*}
a \cdot b=(b: a) b a^{-1} \quad \text { for all } a, b \in G, \tag{2}
\end{equation*}
$$

or, equivalently,

$$
\begin{equation*}
b: a=(a \cdot b) a b^{-1} \quad \text { for all } a, b \in G . \tag{3}
\end{equation*}
$$

Taking $b=1$ in this equalities we see that necessarily $a \cdot 1=a: 1=1$ for all $a \in G$. Let $a, b, c \in G$. From (3) it follows that

$$
\begin{array}{rlrl}
(a b): c & =a:(b: c) \\
\Leftrightarrow & (c \cdot(a b)) c(a b)^{-1} & =a:\left((c \cdot b) c b^{-1}\right) \\
\Leftrightarrow & (c \cdot(a b)) c b^{-1} a^{-1} & =\left(\left((c \cdot b) c b^{-1}\right) \cdot a\right)(c \cdot b) c b^{-1} a^{-1} \\
\Leftrightarrow & c \cdot(a b) & =((b: c) \cdot a)(c \cdot b) .
\end{array}
$$

Similarly, from (2) it follows that:

$$
(a b) \cdot c=a \cdot(b \cdot c) \Leftrightarrow c:(a b)=((b \cdot c): a)(c \cdot b) .
$$

This motivates to extend both • and : to maps from $Y \times G$ to $G$, by defining

$$
\begin{align*}
& x \cdot(g y):=((y: x) \cdot g)(x \cdot y),  \tag{4}\\
& x:(g y):=((y \cdot x): g)(x: y), \tag{5}
\end{align*}
$$

for each $x, y \in X$ and each reduced word $g y$, and then to extend these definitions to left actions of $G$ on $G$, by defining

$$
\begin{aligned}
\left(x_{1} x_{2} \ldots x_{n}\right) \cdot g & =x_{1} \cdot\left(x_{2} \cdot\left(\ldots\left(x_{n} \cdot g\right) \ldots\right)\right) \\
\left(x_{1} x_{2} \ldots x_{n}\right): g & =x_{1}:\left(x_{2}:\left(\ldots\left(x_{n}: g\right) \ldots\right)\right) \\
1 \cdot g & =1: g=g
\end{aligned}
$$

for all $x_{i} \in Y$ and $g \in G$.
Now we check that

$$
x \cdot(a b)=((b: x) \cdot a)(x \cdot b) \quad \text { for all } x \in Y \text { and } a, b \in G .
$$

We proceed by induction on the length of $b$. This is clear for $b=1$. Assume that it is true for $b \in G$, and let us see that it is true for by with $y \in Y$ :

$$
\begin{aligned}
x \cdot(a(b y)) & =((y: x) \cdot(a b))(x \cdot y) \\
& =((b:(y: x)) \cdot a)((y: x) \cdot b)(x \cdot y) \\
& =(((b y): x) \cdot a)(x \cdot(b y))
\end{aligned}
$$

In a similar way it is proved that $x:(a b)=((b \cdot x): a)(x: b)$.
Lemma 1.1. For all $a, b, c \in G$, the identities

$$
\begin{equation*}
a \cdot(b c)=((c: a) \cdot b)(a \cdot c) \quad \text { and } \quad a:(b c)=((c \cdot a): b)(a: c) \tag{6}
\end{equation*}
$$

are fulfilled.
Proof. We prove the first equality and left the second one, which is similar, to the reader. Clearly the first equality in (6) is true if $a=1$ or $c=1$. Take $c=x \in Y$ and suppose that the first equality in (6) holds for $a \in G$. Then,

$$
\begin{aligned}
(y a) \cdot(b x) & =y \cdot(a \cdot(b x)) \\
& =y \cdot(((x: a) \cdot b)(a \cdot x)) \\
& =(((a \cdot x): y) \cdot((x: a) \cdot b))(y \cdot(a \cdot x)) \\
& =(((a \cdot x): y)(x: a) \cdot b)((y a) \cdot x) \\
& =((x:(y a)) \cdot b)((y a) \cdot x)
\end{aligned}
$$

Let $a, b, c \in G, z \in X$, and suppose that the first equality in (6) holds $c \in G$. We have

$$
\begin{aligned}
a \cdot(b(c z)) & =((z: a) \cdot(b c))(a \cdot z) \\
& =((c:(z: a)) \cdot b)((z: a) \cdot c)(a \cdot z) \\
& =((c z: a) \cdot b)(a \cdot(c z)) .
\end{aligned}
$$

which proves that the first equality in (61) also holds for $c z$.

It is not true that $(a \cdot b) a=(b: a) b$ for all $a, b \in G$. So, in order to finish our task we need to take a quotient $G / \sim$ of $G$ by a suitable congruence relation.

Proposition 1.2. Let $A$ be a group endowed with a pair of left actions $b \mapsto a \cdot b y$ $b \mapsto a: b$ on $A$ (as a set) such that

$$
a \cdot(b c)=((c: a) \cdot b)(a \cdot c) \quad \text { and } \quad a:(b c)=((c \cdot a): b)(a: c) \quad \text { for all } a, b, \in A,
$$

and let $X$ be a set of generators of $A$ as a monoid. If $(x \cdot y) x=(y: x) y$ for all $x, y \in X$, then $(a \cdot b) a=(b: a) b$ for all $a, b \in A$.

Proof. Suppose that $(x \cdot b) x=(b: x) b$ for some $b \in G$ and all $x, y \in X$. Then, for all $x, y \in X$,

$$
\begin{aligned}
(x \cdot(b y)) x & =((y: x) \cdot b)(x \cdot y) x \\
& =(b:(y: x)) b y \\
& =((b y): x) b y .
\end{aligned}
$$

So, $(x \cdot b) x=(b: x) b$ for all $x \in X$ and $b \in G$. Let $a \in G$. Suppose that $(a \cdot b) a=(b: a) b$ for all $b \in A$. Then

$$
\begin{aligned}
((a x) \cdot b) a x & =(a \cdot(x \cdot b)) a x \\
& =((x \cdot b): a)(x \cdot b) x \\
& =((x \cdot b): a)(b: x) b \\
& =(b:(a x)) b,
\end{aligned}
$$

which finishes the proof.
Let $\sim$ be the minimal equivalence relation in $A$ such that:
(1) $(x \cdot y) x \sim(y: x) y$ for all $x, y \in X$, and
(2) If $a \sim b$ and $c \sim d$, then

$$
\begin{gather*}
a c \sim b d,  \tag{7}\\
a \cdot c \sim b \cdot d,  \tag{8}\\
a: c \sim b: d . \tag{9}
\end{gather*}
$$

By Proposition 1.2 and the proposition in the introduction, $G / \sim$ is a skew brace.
Theorem 1.3. The group $G / \sim$, endowed with the binary operations $\cdot$ and : induced by the corresponding operations in $G$, is the free skew brace over $X$.

Proof. Let $A$ be a skew brace and let $f: X \rightarrow A$ be a map. Next, we extend $f$ to a group morphism $\widetilde{f}: G \rightarrow A$ such that

$$
\widetilde{f}(x \cdot y)=f(x) \cdot f(y) \quad \text { and } \quad \tilde{f}(x: y)=f(x): f(y) \quad \text { for all } x, y \in Y
$$

For this, first we extend $f$ to $Y$ as follows:

- We extend $f$ to $Y_{1}$ by defining $\widetilde{f}\left(x^{*}\right):=f(x)^{-1}$ for each $x \in X$;
- Assuming that we have defined $\widetilde{f}$ on $Y_{n-1}$, we extend $\tilde{f}$ to $Y_{n}$ by defining

$$
\widetilde{f}(x \cdot y):=f(x) \cdot f(y) \text { and } \widetilde{f}(x: y):=f(x): f(y), \text { for all } x, y \in Y_{n-1}
$$

Then, we extend $f$ to $G$ by defining

$$
\widetilde{f}\left(x_{1} x_{2} \ldots x_{n}\right):=\widetilde{f}\left(x_{1}\right) \tilde{f}\left(x_{2}\right) \cdots \widetilde{f}\left(x_{n}\right) \quad \text { for } x_{i} \in Y
$$

Since equality (1) is satisfied in $A$, the map $\tilde{f}$ induce a skew brace morphism $\varphi: G / \sim \rightarrow A$, unique such that $f=\varphi \circ i$, where $i: X \rightarrow G / \sim$ is the canonical map.
