# THE MINIMALITY OF DETERMINANTAL VARIETIES 

MARTIN BORDEMANN, JAIGYOUNG CHOE, AND JENS HOPPE


#### Abstract

The determinantal variety $\Sigma_{p q}$ is defined to be the set of all $p \times q$ real matrices with $p \geq q$ whose ranks are strictly smaller than $q$. It is proved that $\Sigma_{p q}$ is a minimal cone in $\mathbb{R}^{p q}$ and all its strata are regular minimal submanifolds.


Keywords: minimal submanifold, determinantal variety, helicoidal MSC: 53A10, 49Q05

## 1. INTRODUCTION

Determinantal varieties are spaces of matrices with a given upper bound on their ranks. Given $p$ and $q$ and $r<\min (p, q)$, the determinantal variety $Y_{r}$ is the set of all $p \times q$ matrices with rank $\leq r$. $Y_{r}$ is naturally an algebraic variety as the rank condition on a matrix is equivalent to the vanishing of all of its $(r+1) \times(r+1)$ minors which are polynomials of degree $r+1$. Let $Z_{r}=Y_{r} \backslash Y_{r-1}$ denote the set of all $p \times q$-matrices whose rank is equal to $r$. By projecting each $p \times q$ matrix of rank $r$ on the $r$-dimensional subspace $V$ of $\mathbb{R}^{p}$ generated by its columns and on the $r$ dimensional subspace $W$ of $\mathbb{R}^{q}$ generated by its rows it can be seen that $Z_{r}$ is a fibre bundle over the cartesian product of two real Grassmannians $\mathrm{G}_{r}\left(\mathbb{R}^{p}\right) \times \mathrm{G}_{r}\left(\mathbb{R}^{q}\right)$ where the fibre over $(V, W)$ is the set of all linear bijections $V \rightarrow W$ (canonical bundles), see e.g. [7, p.8]. Hence it is a regular submanifold of dimension $r(p-r)+q r$. It is well-known that $Y_{r}$ is decomposed into the disjoint union of regular subvarieties $Z_{s}$, $s$ being an integer $0 \leq s \leq r$ (where of course $Y_{-1}=\emptyset$ ), see e.g. [7, p.4-6] for more details.

More concretely: let $M_{p q}$ the set of all real $p \times q$ matrices with $p \geq q$ and identify $M_{p q}$ with $\mathbb{R}^{p q}$. Let us define $\Sigma_{p q}=\left\{\left(x_{11}, x_{12}, \ldots, x_{p q}\right) \in \mathbb{R}^{p q}: \operatorname{det}\left(X^{T} X\right)=0, X=\right.$ $\left.\left(x_{i j}\right) \in M_{p q}\right\}$ and call $\Sigma_{p q}$ the determinantal variety in $\mathbb{R}^{p q}$. It can be identified with $Y_{q-1}$. The vector space $M_{p q}$ carries a natural positive definite inner product

\langle X, Y\rangle=\operatorname{tr}\left(X^{T} Y\right) . \tag{1.1}
\end{equation*}

Many studies have been done about determinantal varieties, mostly on their algebraic properties. In this paper we are interested in an analytic property, the minimality of $\Sigma_{p q}$ in $\mathbb{R}^{p q}$, which we prove in 3 different ways (two of which generalize existing results for $p=q, \mathrm{cp}$. [6], [4], [1], while concerning the first, parametric proof, see [3] for some low-dimensional $p>q$ examples):

Theorem 1.1. Every stratum $Z_{r}$ for $0 \leq r \leq q-1$ of the determinantal variety $\Sigma_{p q}$ is a regular minimal submanifold of the inner product space $M_{p q}$.

## 2. Parametric Proof

Consider the real vector space $\mathbb{R}^{p r+r(q-r)}$ whose elements are written as pairs $\binom{a}{\lambda}$ where $a=\left(\overrightarrow{a_{1}} \overrightarrow{a_{2}} \ldots \overrightarrow{a_{r}}\right)=\left(a_{J s}\right)_{\substack{J=1 \ldots p \\ s=1 \ldots r}}$ is a real $p \times r$-matrix and $\lambda=\left(\lambda_{s s^{\prime}}\right)_{\substack{s=1 \ldots r \\ s^{\prime}=1 \ldots r^{\prime}:=q-r}}$ is a real $r \times(q-r)$-matrix. Let $U_{p q r}$ denote the open subset of $\mathbb{R}^{p r+r(q-r)}$ consisting of those pairs $\binom{a}{\lambda}$ where the matrix $a$ is of maximal rank $r$. We denote the natural euclidean scalar product on $U_{p q r}$ by $\gamma$, i.e.

a^{T} & a^{\prime} \tag{2.1}
\end{array}\right)+\operatorname{tr}\left(\lambda^{T} \lambda^{\prime}\right) .
$$

Then the following smooth map $X: U_{p q r} \rightarrow M_{p q} \cong \mathbb{R}^{p q}$ given by

X:\binom{a}{\lambda} \mapsto X\binom{a}{\lambda}=(a, a \cdot \lambda) \tag{2.2}
\end{equation*}

clearly parametrizes an open subset of the stratum $Z_{r}$ (the regular submanifold of all rank $r p \times q$-matrices) of the determinantal variety $\Sigma_{p q}$. It can be seen as a natural chart domain of $Z_{r}$ (with the inverse of $X$ being the chart), the other domains being obtained by permutations of the $r$ column vectors $\overrightarrow{a_{1}}, \overrightarrow{a_{2}}, \ldots, \overrightarrow{a_{r}}$.
Due to

D_{\binom{a}{\lambda}}\binom{c}{\mu}:=\left.\frac{d}{d t} X\binom{a+t c}{\lambda+t \mu}\right|_{t=0}=(c, c \lambda+a \mu) \tag{2.3}
\end{equation*}

the Riemannian metric $\hat{G}=X^{*}\langle$,$\rangle on U_{p q r}$ that is induced from the inner product
$\langle$,$\rangle (1.1) on \mathbb{R}^{p q} \cong M_{p q}$ (the space of real $p \times q$ matrices) by $X$ is computed to be

& =\gamma\left(\binom{c_{1}}{\mu_{1}}, \phi\binom{a}{\lambda}\binom{c}{\mu_{2}}\right),
\end{align*}

with

\phi\binom{a}{\lambda}\binom{c}{\mu}=\binom{c\left(1+\lambda \lambda^{T}\right)+a \mu \lambda^{T}}{a^{T} c \lambda+a^{T} a \mu} . \tag{2.5}

Written as a $\left(p r+r r^{\prime}\right) \times\left(p r+r r^{\prime}\right)$ dimensional symmetric matrix,

\end{array}\right)=\left(\begin{array}{cc}
g_{\beta \gamma} & b_{\beta v} \\
b_{\gamma u} & d_{u v}

L_{a^{T}} R_{\lambda} & L_{a^{T} a}
\end{array}\right)

where $R_{Y}$ resp. $L_{Y}$ denote right-, resp. left-, multiplication with $Y$.
As both $G=\left(g_{\alpha \beta}\right)_{\alpha, \beta=1 \ldots p \cdot r}$ and $D=\left(d_{u v}\right)_{u, v=1 \ldots r \cdot r^{\prime}}$ are invertible one may invert
$\widehat{G}$ in the form

\end{array}\right) \tag{2.7}
\end{align*}

with $\rho$, defined as the inverse of $D-B^{T} G^{-1} B$, existing due to the factorization

or, following from the factorization

in the form

\left(G^{\prime}\right)^{-1} & -\left(G^{\prime}\right)^{-1} B D^{-1}  \tag{2.10}\\
-D^{-1} B^{T}\left(G^{\prime}\right)^{-1} & D^{-1}+D^{-1} B^{T}\left(G^{\prime}\right)^{-1} B D^{-1}
\end{array}\right)

Due to the blocks in $\widehat{G}$ being given in terms of left- and right- multiplication one also has, more explicitly,

1-L_{P_{a}} R_{\lambda \lambda^{T}\left(1+\lambda \lambda^{T}\right)^{-1}} & -L_{a\left(a^{T} a\right)^{-1}} R_{\lambda^{T}}  \tag{2.11}\\
R_{\lambda} L_{\left(a^{T} a\right)^{-1} a^{T}} & \rho=L_{\left(a^{T} a\right)^{-1}} R_{1+\lambda^{T} \lambda}
\end{array}\right)

with $P_{a}:=1-a\left(a^{T} a\right) a^{T}$ projecting onto the $r^{\prime \prime}=p-r$ dimensional space orthogonal to the column-space $C(a)$, i.e. the span of the $\vec{a}_{s}$. Using $L_{Y} L_{Y^{\prime}}=L_{Y Y^{\prime}}, R_{Y} R_{Y^{\prime}}=$ $R_{Y^{\prime} Y}$ one trivially verifies $\widehat{G}^{-1} \cdot \widehat{G}=1$ also in the $R-L$ form.

To shown the minimality of $Y_{r}$ in the chart defined by $X$ we have to compute the second order derivatives of $X$ summed over the components of $\widehat{G}^{-1}$ and prove that the component normal to the tangent space of that vector (the mean curvature vector $H)$ vanishes. A straight-forward, but rather lengthy computation gives $(\mu=(\alpha, u)$, $\nu=(\beta, v))$

\sum \hat{G}^{\mu \nu} \frac{\partial^{2} X}{\partial x^{\mu} \partial x^{\nu}}\binom{a}{\lambda}=-2 D_{\binom{a}{\lambda}} X\binom{0}{\left(a^{T} a\right)^{-1} \lambda}, \tag{2.12}
\end{equation*}
$$

which obviously is tangential to the surface whence $H$ vanishes.
The computation can be shortened by the following simple arguments: note that the only non-vanishing second derivatives of $X$ are (independent of $s$ )

(the matrix that is everywhere zero except $=1$ in the $J^{\text {th }}$ row and $s^{\prime}$ column), and that the $r^{\prime} r^{\prime \prime}=r^{\prime}(p-r)$ normal directions are

N_{s^{\prime} s^{\prime \prime}}:=\gamma_{s^{\prime}}\left(\lambda_{1 s^{\prime}} \vec{e}_{s^{\prime \prime}}, \lambda_{2 s^{\prime}} \vec{e}_{s^{\prime \prime}}, \ldots, \lambda_{r s^{\prime}} \vec{e}_{s^{\prime \prime}}, \overrightarrow{0}, \ldots,-\vec{e}_{s^{\prime \prime}}, \overrightarrow{0} \ldots \overrightarrow{0}\right) \tag{2.14}
\end{equation*}
$$

where $s^{\prime}=1 \ldots r^{\prime}=q-r, s^{\prime \prime}=1 \ldots r^{\prime \prime}=p-r$, and the $\left\{\vec{e}_{s^{\prime \prime}}\right\}_{s^{\prime \prime}=1 \ldots r^{\prime \prime}}$ being an orthonormal basis of the kernel of $a^{T}$. The only non-vanishing elements of the second fundamental form are therefore

h_{J s, s s^{\prime}}^{\left(t^{\prime} t^{\prime \prime}\right)}=\gamma_{t^{\prime}} \delta_{t^{\prime} s^{\prime}}\left(\vec{e}_{t^{\prime \prime}}\right)_{J}=h_{s s^{\prime}, J s}^{\left(t^{\prime} t^{\prime \prime}\right)} \tag{2.15}
\end{equation*}
$$

hence

\begin{equation*}
H^{\left(t^{\prime} t^{\prime \prime}\right)} \sim \gamma_{t^{\prime}} \sum_{J, s} \widehat{G}^{J s, s t^{\prime}}\left(\vec{e}_{t^{\prime \prime}}\right)_{J} \tag{2.16}
\end{equation*}
$$

for the components of the mean-curvature vector, -all of which vanish, due to the sum over $J\left(=1 \ldots p\right.$ ), involving (only) scalar products of the $\vec{e}_{t^{\prime \prime}}$ with the $\vec{a}_{s}$ (all of which are $=0$ as the $\vec{e}$ 's are by definition in the kernel of $a^{T}$ ). While (cp. (2.11)) $\widehat{G}^{J s, s t^{\prime}}=\left(-L_{a\left(a^{T} a\right)^{-1}} R_{\lambda^{T}}\right)^{J s, s t^{\prime}}$ can easily be calculated explicitely, in analogy with

as $-\left(\vec{a}_{t}\right)_{J}\left(\vec{a}^{T} a\right)_{t s}^{-1} \lambda_{s t^{\prime}}$, note that this is not really necessary, due to the following (cp.[3], p.38): as $g_{\alpha \beta}=g_{J s, K t} \sim \delta_{J K}$ is diagonal in the indices transforming as vectors under $O(p)$, its inverse $g^{\alpha \beta}$ (as well as, trivially, $\rho^{u v}$ as the inverse of a matrix of $O(p)$-invariants) will not touch any $O(p)$ vector-index; implying that the (due to (2.13), (2.15) only relevant) components

must be linear combinations of the $B_{J t, u}$, hence carry the $O(p)$ vector index entirely through the columns of $a$ (which is sufficient to conclude the vanishing of the mean curvature vector).

## 3. Geometric Proof

Our algebraic proof of the minimality of the zero determinant set $\Sigma$ in [1] was based on the property that the hypersurface $\Sigma$ is helicoidal. In this section we prove the minimality of the determinantal variety by using the fact (Theorem 3.1) that a helicoidal subset with higher codimension is still minimal (we should mention that this fact was first proved by Adrian C. Chu [2]).

Definition. Let $M$ be a complete Riemannian manifold and $\Sigma$ a subset of $M$. Suppose that $\Sigma_{0}$ is the subset of $\Sigma$ which is a twice differentiable submanifold of $M$ and $\Sigma \backslash \Sigma_{0}$ has measure zero on $\Sigma$. Suppose also that at any point $\bar{p}$ of $\Sigma$ there is an isometry $\varphi$ of $M$ such that

\varphi(\bar{p})=\bar{p}, \quad \varphi(\Sigma)=\Sigma, \quad \varphi_{*}(v)=-v \text { for any } v \perp T_{\bar{p}} \Sigma_{0}
$$

Then we say that $\Sigma$ is helicoidal in $M$.
Theorem 3.1. Every helicoidal subset $\Sigma^{m}$ of a Riemannian manifold $M^{n}$ is minimal in $M$ wherever $\Sigma$ is twice differentiable.

Proof. Let $\vec{H}$ be the mean curvature vector of $\Sigma$ at a point $\bar{p} \in \Sigma_{0}$, that is,

\vec{H}=\sum_{i=1}^{m}\left(\bar{\nabla}_{e_{i}} e_{i}\right)^{\perp}
$$

where $\bar{\nabla}$ is the Riemannian connection on $M$ and $e_{1}, \ldots, e_{m}$ are orthonormal vectors on a neighborhood of $\bar{p}$ in $\Sigma_{0}$. Since $\varphi(\Sigma)=\Sigma$ and $\bar{p}$ is a fixed point of $\varphi$, one sees that $\varphi_{*}\left(e_{1}\right), \ldots, \varphi_{*}\left(e_{m}\right)$ are also orthonormal on $\Sigma$ near $\bar{p}$. Hence

$$
\begin{equation*}
\varphi_{*}(\vec{H})=\sum_{i=1}^{m}\left(\bar{\nabla}_{\varphi_{*}\left(e_{i}\right)} \varphi_{*}\left(e_{i}\right)\right)^{\perp}=\sum_{i=1}^{m}\left(\bar{\nabla}_{e_{i}} e_{i}\right)^{\perp}=\vec{H} . \tag{3.1}
\end{equation*}
$$

On the other hand, by the hypothesis, $\varphi_{*}(\vec{H})=-\vec{H}$. Hence $\vec{H}=0$ at $\bar{p}$. As $\bar{p}$ is arbitrarily chosen, one concludes that $\Sigma$ is minimal.
Proof. (of Theorem 1.1): Recall the inner product $\langle$,$\rangle on M_{p q}$,

\langle X, Y\rangle=\operatorname{tr}\left(X^{T} Y\right), \quad X, Y \in M_{p q} .
$$

For any $A \in O(p)$ and $X \in M_{p q}$, define $\varphi_{A}(X)=A X$. Then $\varphi_{A}$ is an isometry on $M_{p q}$ since $\varphi_{A}$ is invertible and for $Y \in M_{p q}$,

\left\langle\varphi_{A}(X), \varphi_{A}(Y)\right\rangle=\langle A X, A Y\rangle=\operatorname{tr}\left(X^{T} A^{T} A Y\right)=\operatorname{tr}\left(X^{T} Y\right)=\langle X, Y\rangle
$$

Let $Z_{r} \subset \Sigma_{p q}$ be the set of all $p \times q$ matrices of rank $r, 0 \leq r<q$. As $\varphi_{A}$ preserves rank, we have

$$
\begin{equation*}
\varphi_{A}\left(Z_{r}\right)=Z_{r} . \tag{3.2}
\end{equation*}
$$

Given $X \in Z_{r}$, let $\mathcal{C}(X)$ be the column space of $X$ and $\mathcal{C}(X)^{\perp}$ its orthogonal complement in $\mathbb{R}^{p}$. There exists a $p \times p$ orthogonal matrix $B$ such that $\mathcal{C}(X)$ is its eigenspace with eigenvalue 1 and $\mathcal{C}(X)^{\perp}$ is its eigenspace with eigenvalue -1 . Then we have

$$
\begin{equation*}
\varphi_{B}(X)=X \tag{3.3}
\end{equation*}
$$

Let $\mathcal{R}(X)$ be the row space of $X$. Define a subset $N$ of $M_{p q}$ by

$$
N=\left\{Y \in M_{p q}: \mathcal{C}(Y) \subset \mathcal{C}(X) \text { or } \mathcal{R}(Y) \subset \mathcal{R}(X)\right\} .
$$

Choose $Y \in N$ and let $\sigma(t)$ be the curve of $p \times q$ matrices from $X$ to $Y$ defined by $\sigma(t)=X+t Y, 0 \leq t \leq 1$. Clearly $\sigma(t) \subset Z_{r}$ for sufficiently small $t$. The tangent vector $\sigma^{\prime}(0)$ at $X$ equals

$$
\sigma^{\prime}(0)=\lim _{t \rightarrow 0} \frac{\sigma(t)-X}{t}=Y \in T_{X} Z_{r}
$$

Therefore $N$ is a subset of $T_{X} Z_{r}$ as well. Suppose $W$ is a $p \times q$ matrix which is perpendicular to $T_{X} Z_{r}$. Then $W \perp N$. Here we claim

$$
\mathcal{C}(W) \subset \mathcal{C}(X)^{\perp}
$$

Let $v_{i}$ be the orthogonal projection of the $i$-th column of $W$ onto $\mathcal{C}(X)$ and let $W_{X}$ be the $p \times q$ matrix with the $i$-th column vector $v_{i}, 1 \leq i \leq q$. Then $W_{X}$ is in $N$ and satisfies

$$
\left\langle W_{X}, W_{X}\right\rangle=\sum_{i}\left|v_{i}\right|^{2} .
$$

Since

$$
0=\left\langle W_{X}, W\right\rangle=\left\langle W_{X}, W_{X}\right\rangle=\sum_{i}\left|v_{i}\right|^{2}
$$

we see that $v_{i}=0$ for all $i$ and so the claim follows. Hence $\varphi_{B}(W)=-W$. Note that $\left(\varphi_{B}\right)_{*}=\varphi_{B}$ since $\varphi_{B}$ is linear. Thus

\left(\varphi_{B}\right)_{*}(v)=-v \text { for any } v \perp T_{X} Z_{r} \tag{3.4}
\end{equation*}
$$

It follows from (3.2), (3.3), (3.4) that $Z_{r}$ is helicoidal and by Theorem 3.1 it is minimal in $\mathbb{R}^{p q}$.

## 4. Level-Set Proof

Let us also give a level-set proof, for simplicity restricting to $\Sigma_{n}$, the space of all $(n+1) \times n$ matrices of $\operatorname{rank}(n-1)$

x_{n+1} \ldots x_{2 n} \\
\vdots \\
x_{n^{2}+1} \ldots x_{n^{2}+n}
\end{array}\right)
$$

for which the first and last rows are not identically zero; $\Sigma_{n}$ can be characterized by the vanishing of the upper and lower $n \times n$ determinant (each of which, alone, 'trivially' defining a minimal surface),

$$
\chi_{1}:=\left|\begin{array}{c}
x_{1} \ldots x_{n}  \tag{4.2}\\
\vdots \\
x_{n^{2}-n+1} \ldots x_{n^{2}}
\end{array}\right| \stackrel{!}{=} 0 \stackrel{!}{=}\left|\begin{array}{c}
x_{n+1} \ldots x_{n+n} \\
\vdots \\
x_{n^{2}+1} \ldots x_{n^{2}+n}
\end{array}\right|=: \chi_{2} \cdot(-1)^{n-1}
$$

and the minimality-condition for the intersection $\left(\chi_{1}=0\right.$ and $\left.\chi_{2}=0\right)$ taking the form

\forall A \in \Sigma_{n}: \quad \operatorname{tr}\left(P \cdot \partial^{2} \chi_{\alpha}\right)(A)_{\alpha=1,2}=0 \tag{4.3}
\end{equation*}

with

## 5. Generalizations

1. Among the possible generalizations, it is natural to replace real by complex numbers and to consider complex $p \times q$ matrices of rank $r$ which also forms a $r^{2}+r(p-r)+r(q-r)$ complex submanifold $Z_{r}^{\mathbb{C}}$ of the space of all $p \times q$-matrices, $\mathbb{C}^{p q}$. Putting the sesquilinear inner product $\left\langle Z, Z^{\prime}\right\rangle=\operatorname{tr}\left(Z^{\dagger} Z^{\prime}\right)$ on $\mathbb{C}^{p q}$ we can view it as a Kähler manifold (recall that the riemannian metric is given by the real part of the sesquilinear form) and $Z_{r}^{\mathbb{C}}$ as a complex submanifold. It is wellknown that arbitrary complex submanifolds of Kähler manifolds are always minimal submanifolds, see e.g. [9, p.380] for a simple argument. Hence $Z_{r}^{\mathbb{C}}$ is a minimal submanifold of $\mathbb{C}^{p q}$. Moreover, since $Z_{r}^{\mathbb{C}}$ is obviously invariant under multiplication with nonzero complex numbers, $\mathbb{C}^{\times}$, the above-mentioned fact also implies that the projectivization $Z_{r}^{\mathbb{C}} / \mathbb{C}^{\times}$is a complex, hence minimal submanifold of complex projective space $\mathbb{C} P^{p q-1}=\left(\mathbb{C}^{p q} \backslash\{0\}\right) / \mathbb{C}^{\times}$(in the real case the projectivizations are minimal in spheres).

As concrete examples let us here consider only 2 special cases, $p=q=r+1$ and $p=3, q=2, r=1$, i.e. the 8 dimensional real manifold of complex $3 \times 2$ matrices $Z=\left(\begin{array}{cc}z_{1} & z_{4} \\ z_{2} & z_{5} \\ z_{3} & z_{6}\end{array}\right)=(\vec{x}+i \vec{y}, \vec{u}+i \vec{v}) \triangleq \vec{z} \in \mathbb{R}^{12}$ of the form

For these Kählerian examples it may be interesting to consider its quantization or noncommutative or fuzzy analog: most of all Kähler manifolds admit a quantization by Toeplitz operators or geometric quantization (see e.g. [10]) which leads to approximations of the function algebras by a sequence of finite-dimensional matrix algebras. Since the complex $Z_{r}^{\mathbb{C}}$ has a relatively simple structure as a complex holomorphic fibre bundle over a cartesian product of two complex Grassmannians it does not seem to be so hard to compute the Toeplitz quantization by representation theory of the homogeneous space. It may be simpler to do it for the projectivization since one is then working inside complex projective space which is compact. In the particular example of complex rank $12 \times 2$-matrices, the determinant condition gives $Z_{r}^{\mathbb{C}}$ and its projectivization the structure of a complex quadric for which quantization exist, see e.g. [11] (concerning recent work on quantum minimal surfaces, see e.g. [12]).
2. Another possible generalization is the case of pseudo-euclidean spaces: consider again the space $\mathbb{R}^{p q}$ of all real $p \times q$-matrices where the positive inner product (1.1) is generalized by the following indefinite scalar product

Moreover for a finite-dimensional vector space equipped with an indefinite nondegenerate symmetric bilinear form $g$ we call a vector subspace $P$ of signature $(a, b)$ if the restriction of $g$ to $P \times P$ is nondegenerate and has signature $(a, b)$. With these notations we set

$$
\begin{equation*}
Z_{r}^{\prime}=\left\{M \in Z_{r} \mid V_{M} \text { of signature }\left(\tilde{p}_{1}, \tilde{p}_{2}\right), W_{M} \text { of signature }\left(\tilde{q}_{1}, \tilde{q}_{2}\right)\right\} \tag{5.18}
\end{equation*}
$$

where we have suppressed the obvious dependence of $Z_{r}^{\prime}$ on the choice of integers $\tilde{p}_{1}, \tilde{q}_{1}$. A lengthy computation shows that for each such choice $Z_{r}^{\prime}$ is a nondegenerate submanifold of $\mathbb{R}^{p q}$ equipped with (5.16) whose induced metric has signature

$$
\begin{equation*}
\left(-\tilde{p}_{1} \tilde{q}_{1}-\tilde{p}_{2} \tilde{q}_{2}+p_{1} \tilde{q}_{1}+p_{2} \tilde{q}_{2}+\tilde{p}_{1} q_{1}+\tilde{p}_{1} q_{1},-\tilde{p}_{1} \tilde{q}_{2}-\tilde{p}_{2} \tilde{q}_{1}+p_{1} \tilde{q}_{2}+p_{2} \tilde{q}_{1}+\tilde{p}_{1} q_{2}+\tilde{p}_{2} q_{1}\right) \tag{5.19}
\end{equation*}
$$

As a drawback of the above indefinite scalar product (5.16) we can deduce -using the preceding equation- that a Minkowski signature $(1, s)$ can only be obtained for rather trivial cases. A generalization of the techniques described in the previous Sections, in particular Section 3, shows that each submanifold $Z_{r}^{\prime}$ is helicoidal and hence minimal.
