# Optimal Control Problems Governed by 1-D Kobayashi-Warren-Carter Type Systems*

#### Abstract

This paper is devoted to the study of a class of optimal control problems governed by 1-D Kobayashi-Warren-Carter type systems, which are based on a phasefield model of grain boundary motion, proposed by [Kobayashi et al, Physica D, 140, 141$150,2000]$. The class consists of an optimal control problem for a physically realistic statesystem of Kobayashi-Warren-Carter type, and its regularized approximating problems. The results of this paper are stated in three Main Theorems 1-3. The first Main Theorem 1 is concerned with the solvability and continuous dependence for the state-systems. Meanwhile, the second Main Theorem 2 is concerned with the solvability of optimal control problems, and some semi-continuous association in the class of our optimal control problems. Finally, in the third Main Theorem 3, we derive the first order necessary optimality conditions for optimal controls of the regularized approximating problems. By taking the approximating limit, we also derive the optimality conditions for the optimal controls for the physically realistic problem.

## Introduction

Let $(0, T)$ be a time-interval with a constant $0<T<\infty$, and let $\Omega:=(0,1) \subset \mathbb{R}$ be a onedimensional spatial domain with a boundary $\Gamma:=\{0,1\}$. Besides, we set $Q:=(0, T) \times \Omega$ and $\Sigma:=(0, T) \times \Gamma$, and we define $H:=L^{2}(\Omega)$ and $\mathscr{H}:=L^{2}\left(0, T ; L^{2}(\Omega)\right)$ as the base spaces for our problems.

In this paper, we consider a class of optimal control problems governed by the following state-systems, which are denoted by $(S)_{\varepsilon}$, with $\varepsilon \geq 0$ :

For each $\varepsilon \geq 0$, we denote the optimal control problem by $(\mathrm{OP})_{\varepsilon}$, and prescribe the problem as follows:
$(\mathrm{OP})_{\varepsilon}$ Find a pair of functions $\left[u^{*}, v^{*}\right] \in[\mathscr{H}]^{2}$, called optimal control, which minimizes a cost functional $\mathcal{J}_{\varepsilon}=\mathcal{J}_{\mathcal{\varepsilon}}(u, v)$, defined as:

where $[\eta, \theta] \in[\mathscr{H}]^{2}$ solves the state-system $(\mathrm{S})_{\varepsilon}$.
The state-system $(S)_{\varepsilon}$ is a type of Kobayashi-Warren-Carter system, i.e. it is based on a phase-field model of grain boundary motion, proposed by Kobayashi et al [19, 20]. The order parameters, $\eta \in \mathscr{H}$ and $\theta \in \mathscr{H}$ indicate the orientation order and orientation angle of the polycrystal body, respectively. Moreover, $\left[\eta_{0}, \theta_{0}\right] \in H^{1}(\Omega) \times H_{0}^{1}(\Omega)$ is an initial pair, i.e. a pair of initial data of $[\eta, \theta]$. The forcing pair $[u, v] \in[\mathscr{H}]^{2}$ denotes the control variables that can control the profile of solution $[\eta, \theta] \in[\mathscr{H}]^{2}$ to $(\mathrm{S})_{\varepsilon}$. Additionally, $0<\alpha_{0} \in W^{1, \infty}(Q)$ and $0<\alpha \in C^{2}(\mathbb{R})$ are given functions to reproduce the mobilities of grain boundary motions. Finally, $g \in W_{\text {loc }}^{1, \infty}(\mathbb{R})$ is a perturbation for the orientation order $\eta$, and $\nu>0$ is a fixed constant to relax the diffusion of the orientation angle $\theta$.

In the state-system $(S)_{\varepsilon}$, the PDE part of the first initial-boundary value problem (0.1) is a type of Allen-Cahn equation, so that the forcing term $u$ can be regarded as a temperature control of the grain boundary formation. Also, the second problem (0.2) is to reproduce crystalline micro-structure of polycrystal, and the case of $\varepsilon=0$ is the closest
to the original setting adopted by Kobayashi et al [19,20]. Indeed, when $\varepsilon=0$, the quasilinear diffusion as in (0.2) is described in a singular form $-\partial_{x}\left(\alpha(\eta) \frac{\partial_{x} \theta}{\left|\partial_{x} \theta\right|}+\nu^{2} \partial_{x} \theta\right)$, and it is known that this type of singularity is effective to reproduce the facet, i.e. the locally uniform (constant) phase in each oriented grain (cf. [1,6,9,10,12,18-20,22,23,26,28,29,32]). Hence, the systems $(S)_{\varepsilon}$, for positive $\varepsilon$, can be said as regularized approximating systems, that are to approach to the physically realistic situation, reproduced by the limiting system $(S)_{0}$, as $\varepsilon \downarrow 0$.

On the other hand, the pair of functions $\left[\eta_{\mathrm{ad}}, \theta_{\mathrm{ad}}\right] \in[\mathscr{H}]^{2}$, in the optimal control problem $(\mathrm{OP})_{\varepsilon}$, is a given admissible target profile of $[\eta, \theta] \in[\mathscr{H}]^{2}$. Moreover, $M_{\eta} \geq 0$, $M_{\theta} \geq 0, M_{u} \geq 0$, and $M_{v} \geq 0$ are fixed constants, that are to adjust the meaning of optimality in the problem $(\mathrm{OP})_{\varepsilon}$.

This paper focuses on two issues:
$\sharp 1)$ key-properties of the state-systems $(S)_{\varepsilon}$, for $\varepsilon \geq 0$;
$\sharp 2)$ mathematical analysis of the optimal control problem $(\mathrm{OP})_{\varepsilon}$, for $\varepsilon \geq 0$.
With regard to the first issue $\sharp 1$ ), various singular systems, related to $(S)_{\varepsilon}$, have been studied by several authors, e.g. [13-15, 17, 23, 25, 30-33, 36, 37]. In particular, the mathematical theories developed in [13, Theorems 2.1 and 2.2] and [25, Main Theorems 1 and 2] are applicable for the well-posedness and $\varepsilon$-dependence of the system $(S)_{\varepsilon}$. However, since the previous works dealt with only homogeneous case, i.e., the case of $[u, v]=[0,0]$, some extension of the existing theories is needed for the application to our optimal control problem $(\mathrm{OP})_{\varepsilon}$. Meanwhile, for issue $\sharp 2$ ), the important point will be how to compute the Gâteaux differential of the cost $\mathcal{J}_{\mathcal{E}}$. This will be carried via a linearization of the state-system $(\mathrm{S})_{\varepsilon}$. When $\varepsilon>0$, the problem $(\mathrm{OP})_{\varepsilon}$ admits sufficient regularity, and we can address the issue $\sharp 2$ ) by using the standard linearization method. Although such linearization method does not work for the problem $(\mathrm{OP})_{0}$, i.e. the case of $\varepsilon=0$, it is possible to obtain some partial results by considering the limit as $\varepsilon \downarrow 0$ for (OP) $)_{\varepsilon}$.

Now, based on these, the goal of this paper is to prove three Main Theorems, summarized as follows:

Main Theorem 1 mathematical results concerning the following items:
(I-A)(Solvability of state-systems) Existence and uniqueness for the state-system $(S)_{\varepsilon}$, for any $\varepsilon \geq 0$.
(I-B)(Continuous dependence among state-systems) Continuous dependence of solutions to the systems $(S)_{\varepsilon}$, with respect to $\varepsilon \geq 0$. Roughly summarized, the uniform convergence of the solutions and governing convex energies, under the convergence of $\varepsilon$ to a value $\varepsilon_{0} \geq 0$, weak $H^{1}$-convergence of initial values, and weak $L^{2}$-convergence of forces (controls).

Main Theorem 2 mathematical results concerning the following items:
(II-A)(Solvability of optimal control problems) Existence for the optimal control problem $(\mathrm{OP})_{\varepsilon}$, for any $\varepsilon \geq 0$.
(II-B)( $\varepsilon$-dependence of optimal controls) Some semi-continuous association between the optimal controls, with respect to $\varepsilon$.

Main Theorem 3 mathematical results concerning the following items:
(III-A)(Necessary optimality conditions in cases of $\varepsilon>\mathbf{0}$ ) Derivation of first order necessary optimality conditions for $(\mathrm{OP})_{\varepsilon}$ via adjoint method.
(III-B)(Limiting optimality conditions as $\varepsilon \downarrow 0$ ) The limiting adjoint system as $\varepsilon \downarrow 0$.

This paper is organized as follows. Preliminaries are given in Section 2, the auxiliary lemmas are given in Section 2 and the Main Theorems are proved in Sections 5-7, with an appendix in Section 8.

## 1 Preliminaries

We begin by prescribing the notations used throughout this paper.
 $X$, and denote by $\langle\cdot, \cdot\rangle_{X}$ the duality pairing between $X$ and its dual $X^{*}$. In particular, when $X$ is a Hilbert space, we denote by $(\cdot, \cdot)_{X}$ the inner product of $X$. For any subset $A$ of a Banach space $X$, let $\chi_{A}: X \longrightarrow\{0,1\}$ be the characteristic function of $A$, i.e.:

For two Banach spaces $X$ and $Y$, we denote by $\mathscr{L}(X ; Y)$ the Banach space of bounded linear operators from $X$ into $Y$, and in particular, we let $\mathscr{L}(X):=\mathscr{L}(X ; X)$.

For Banach spaces $X_{1}, \ldots, X_{N}$, with $1<N \in \mathbb{N}$, let $X_{1} \times \cdots \times X_{N}$ be the product Banach space endowed with the norm $|\cdot|_{X_{1} \times \cdots \times X_{N}}:=|\cdot|_{X_{1}}+\cdots+|\cdot|_{X_{N}}$. However, when all $X_{1}, \ldots, X_{N}$ are Hilbert spaces, $X_{1} \times \cdots \times X_{N}$ denotes the product Hilbert space endowed with the inner product $(\cdot, \cdot)_{X_{1} \times \cdots \times X_{N}}:=(\cdot, \cdot)_{X_{1}}+\cdots+(\cdot, \cdot)_{X_{N}}$ and the norm $|\cdot|_{X_{1} \times \cdots \times X_{N}}:=\left(|\cdot|_{X_{1}}^{2}+\cdots+|\cdot|_{X_{N}}^{2}\right)^{\frac{1}{2}}$. In particular, when all $X_{1}, \ldots, X_{N}$ coincide with a Banach space $Y$, we write:

Additionally, for any transform (operator) $\mathcal{T}: X \longrightarrow Y$, we let:

Specific notations of this paper. As is mentioned in the previous section, let $(0, T) \subset$ $\mathbb{R}$ be a bounded time-interval with a finite constant $T>0$, and let $\Omega:=(0,1) \subset \mathbb{R}$ be a one-dimensional bounded spatial domain. We denote by $\Gamma$ the boundary $\partial \Omega=\{0,1\}$ of $\Omega$, and we let $Q:=(0, T) \times \Omega$ and $\Sigma:=(0, T) \times \Gamma$. Especially, we denote by $\partial_{t}$ and $\partial_{x}$ the distributional time-derivative and the distributional spatial-derivative, respectively. Also,
the measure theoretical phrases, such as "a.e.", "dt", " $d x$ ", and so on, are all with respect to the Lebesgue measure in each corresponding dimension.

On this basis, we define

Also, we identify the Hilbert spaces $H$ and $\mathscr{H}$ with their dual spaces. Based on the identifications, we have the following relationships of continuous embeddings:

among the Hilbert spaces $H, V, V_{0}, \mathscr{H}, \mathscr{V}$, and $\mathscr{V}_{0}$, and the respective dual spaces $H^{*}$, $V^{*}, V_{0}^{*}, \mathscr{H}^{*}, \mathscr{V}^{*}$, and $\mathscr{V}_{0}^{*}$. Additionally, in this paper, we define the topology of the Hilbert space $V_{0}$ by using the following inner product:

Remark 1. Due to the one-dimensional embeddings $V \subset C(\bar{\Omega})$ and $V_{0} \subset C(\bar{\Omega})$, it is easily checked that:

- if $\check{\mu} \in H$ and $\check{p} \in V$, then $\check{\mu} \check{p} \in H$, and $|\check{\mu} \check{p}|_{H} \leq \sqrt{2}|\check{\mu}|_{H}|\check{p}|_{V}$,
- if $\hat{\mu} \in L^{\infty}(0, T ; H)$ and $\hat{p} \in \mathscr{V}$, then $\hat{\mu} \hat{p} \in \mathscr{H}$, and $|\hat{\mu} \hat{p}|_{\mathscr{H}} \leq \sqrt{2}|\hat{\mu}|_{L^{\infty}(0, T ; H)}|\hat{p}|_{\mathscr{V}}$.

Here, we note that the constant $\sqrt{2}$ corresponds to the constant of embedding $V \subset C(\bar{\Omega})$. Moreover, under the setting $\Omega:=(0,1)$, this $\sqrt{2}$ can be used as a upper bound of the constants of embeddings $V \subset L^{q}(\Omega)$ and $V_{0} \subset L^{q}(\Omega)$, for all $1 \leq q \leq \infty$.

Notations in convex analysis. (cf. [5, Chapter II]) For a proper, lower semi-continuous (l.s.c.), and convex function $\Psi: X \rightarrow(-\infty, \infty]$ on a Hilbert space $X$, we denote by $D(\Psi)$ the effective domain of $\Psi$. Also, we denote by $\partial \Psi$ the subdifferential of $\Psi$. The subdifferential $\partial \Psi$ corresponds to a generalized derivative of $\Psi$, and it is known as a maximal monotone graph in the product space $X \times X$. The set $D(\partial \Psi):=\{z \in$ $X \mid \partial \Psi(z) \neq \emptyset\}$ is called the domain of $\partial \Psi$. We often use the notation " $\left[w_{0}, w_{0}^{*}\right] \in \partial \Psi$ in $X \times X$ ", to mean that " $w_{0}^{*} \in \partial \Psi\left(w_{0}\right)$ in $X$ for $w_{0} \in D(\partial \Psi)$ ", by identifying the operator $\partial \Psi$ with its graph in $X \times X$.

For Hilbert spaces $X_{1}, \cdots, X_{N}$, with $1<N \in \mathbb{N}$, let us consider a proper, l.s.c., and convex function on the product space $X_{1} \times \cdots \times X_{N}$ :

As is easily checked,

But, it should be noted that the converse inclusion of (1.2) is not true, in general.
Remark 2 (Examples of the subdifferential). As one of the representatives of the subdifferentials, we exemplify the following set-valued function $\operatorname{Sgn}^{N}: \mathbb{R}^{N} \rightarrow 2^{\mathbb{R}^{N}}$, with $N \in \mathbb{N}$, which is defined as:

where $\mathbb{D}^{N}$ denotes the closed unit ball in $\mathbb{R}^{N}$ centered at the origin. Indeed, the set-valued function $\operatorname{Sgn}^{N}$ coincides with the subdifferential of the Euclidean norm $|\cdot|: \xi \in \mathbb{R}^{N} \mapsto$ $|\xi|=\sqrt{\xi_{1}^{2}+\cdots+\xi_{N}^{2}} \in[0, \infty)$, i.e.:

Finally, we mention about a notion of functional convergence, known as "Moscoconvergence".

Definition 1.1 (Mosco-convergence: cf. [24]). Let $X$ be an abstract Hilbert space. Let $\Psi: X \rightarrow(-\infty, \infty]$ be a proper, l.s.c., and convex function, and let $\left\{\Psi_{n}\right\}_{n=1}^{\infty}$ be a sequence of proper, l.s.c., and convex functions $\Psi_{n}: X \rightarrow(-\infty, \infty], n=1,2,3, \ldots$ Then, it is said that $\Psi_{n} \rightarrow \Psi$ on $X$, in the sense of Mosco, as $n \rightarrow \infty$, iff. the following two conditions are fulfilled:
 and $\check{w}_{n} \rightarrow \check{w}$ weakly in $X$, as $n \rightarrow \infty$.
(M2) The condition of optimality: for any $\hat{w} \in D(\Psi)$, there exists a sequence $\left\{\hat{w}_{n}\right\}_{n=1}^{\infty} \subset X$ such that $\hat{w}_{n} \rightarrow \hat{w}$ in $X$ and $\Psi_{n}\left(\hat{w}_{n}\right) \rightarrow \Psi(\hat{w})$, as $n \rightarrow \infty$.

As well as, if the sequence of convex functions $\left\{\tilde{\Psi}_{\varepsilon}\right\}_{\varepsilon \in \Xi}$ is labeled by a continuous argument $\varepsilon \in \Xi$ with a infinite set $\Xi \subset \mathbb{R}$, then for any $\varepsilon_{0} \in \Xi$, the Mosco-convergence of $\left\{\tilde{\Psi}_{\varepsilon}\right\}_{\varepsilon \in \Xi}$, as $\varepsilon \rightarrow \varepsilon_{0}$, is defined by those of subsequences $\left\{\tilde{\Psi}_{\varepsilon_{n}}\right\}_{n=1}^{\infty}$, for all sequences $\left\{\varepsilon_{n}\right\}_{n=1}^{\infty} \subset \Xi$, satisfying $\varepsilon_{n} \rightarrow \varepsilon_{0}$ as $n \rightarrow \infty$.
Remark 3. Let $X, \Psi$, and $\left\{\Psi_{n}\right\}_{n=1}^{\infty}$ be as in Definition 1.1. Then, the following hold:
(Fact 1) (cf. [3, Theorem 3.66], [16, Chapter 2]) Let us assume that

Remark 4 (Example of Mosco-convergence). For any $\varepsilon \geq 0$, let $f_{\varepsilon}: \mathbb{R} \longrightarrow[0, \infty)$ be a continuous and convex function, defined as:

## 2 Auxiliary Lemmas

In this section, we recall the previous work [2], and set up some auxiliary results. In what follows, we let $\mathscr{Y}:=\mathscr{V} \times \mathscr{V}_{0}$, with the dual $\mathscr{Y}^{*}:=\mathscr{V}^{*} \times \mathscr{V}_{0}^{*}$. Note that $\mathscr{Y}$ is a Hilbert space which is endowed with a uniform convex topology, based on the inner product for product space, as in the Preliminaries (see the paragraph of Abstruct notations).

Besides, we define:

Based on this, let us consider the following linear system of parabolic initial-boundary value problem, denoted by (P):

This system is studied in [2] as a key-problem for the Gâteaux differential of the cost $\mathcal{J}_{\varepsilon}$. In the context, $[a, b, \mu, \lambda, \omega, A] \in[\mathscr{H}]^{6}$ is a given sextuplet of functions which belongs to a subclass $\mathscr{S} \subset[\mathscr{H}]^{6}$, defined as:

Also, $\left[p_{0}, z_{0}\right] \in[H]^{2}$ and $[h, k] \in \mathscr{Y}^{*}$ are, respectively, an initial pair and forcing pair, in the system ( P ).

Now, we refer to the previous work [2], to recall the key-properties of the system (P), in forms of Propositions.

For every $\ell=1,2$, let us take arbitrary $\left[a^{\ell}, b^{\ell}, \mu^{\ell}, \lambda^{\ell}, \omega^{\ell}, A^{\ell}\right] \in \mathscr{S},\left[p_{0}^{\ell}, z_{0}^{\ell}\right] \in[H]^{2}$, and $\left[h^{\ell}, k^{\ell}\right] \in \mathscr{Y}^{*}$, and let us denote by $\left[p^{\ell}, z^{\ell}\right] \in$ $[\mathscr{H}]^{2}$ the solution to $(P)$, corresponding to the sextuplet $\left[a^{\ell}, b^{\ell}, \mu^{\ell}, \lambda^{\ell}, \omega^{\ell}, A^{\ell}\right]$, initial pair $\left[p_{0}^{\ell}, z_{0}^{\ell}\right]$, and forcing pair $\left[h^{\ell}, k^{\ell}\right]$. Besides, let $C_{0}^{*}=C_{0}^{*}\left(a^{1}, b^{1}, \lambda^{1}, \omega^{1}\right)$ be a positive constant, depending on $a^{1}, b^{1}, \lambda^{1}$, and $\omega^{1}$, which is defined as:

Note that the setting (2.5) corresponds to the special case of the original one (2.7), under the one-dimensional situation, as in Remark 1.

Proposition 3 (cf. [2, Corollary 1]). For any $[a, b, \mu, \lambda, \omega, A] \in \mathscr{S}$, let us denote by $\mathcal{P}=$ $\mathcal{P}(a, b, \mu, \lambda, \omega, A):[H]^{2} \times \mathscr{Y}^{*} \longrightarrow \mathscr{Z}$ a linear operator, which maps any $\left[\left[p_{0}, z_{0}\right],[h, k]\right] \in$ $[H]^{2} \times \mathscr{Y}^{*}$ to the solution $[p, z] \in \mathscr{Z}$ to the linear system $(P)$, for the sextuplet $[a, b, \mu, \lambda, \omega, A]$, initial pair $\left[p_{0}, z_{0}\right]$, and forcing pair $[h, k]$. Then, for any sextuplet $[a, b, \mu, \lambda, \omega, A] \in \mathscr{S}$, there exist positive constants $M_{0}^{*}=M_{0}^{*}(a, b, \mu, \lambda, \omega, A)$ and $M_{1}^{*}=M_{1}^{*}(a, b, \mu, \lambda, \omega, A)$, depending on $a, b, \mu, \lambda, \omega$, and $A$, such that:

Also, let us assume $\left\{\left[p_{0}^{n}, z_{0}^{n}\right]\right\}_{n=1}^{\infty} \subset$ $[H]^{2},\left\{\left[h^{n}, k^{n}\right]\right\}_{n=1}^{\infty} \subset \mathscr{Y}^{*}$, and for any $n \in \mathbb{N}$, let us denote by $\left[p^{n}, z^{n}\right] \in[\mathscr{H}]^{2}$ the solution to $(P)$, for the initial pair $\left[p_{0}^{n}, z_{0}^{n}\right]$ and forcing pair $\left[h^{n}, k^{n}\right]$. ## 3 Main Theorems

We begin by setting up some assumptions needed in our Main Theorems.
(A1) $\nu>0$ is a fixed constant. Let $\left[\eta_{0}, \theta_{0}\right] \in V \times V_{0}$ be a fixed initial pair. Let $\left[\eta_{\mathrm{ad}}, \theta_{\mathrm{ad}}\right] \in$ $[\mathscr{H}]^{2}$ be a fixed pair of functions, called the admissible target profile.
(A2) $g: \mathbb{R} \longrightarrow \mathbb{R}$ is a $C^{1}$-function, which is a Lipschitz continuous on $\mathbb{R}$. Also $g$ has a nonnegative primitive $0 \leq G \in C^{2}(\mathbb{R})$, i.e. the derivative $G^{\prime}=\frac{d G}{d \eta}$ coincides with $g$ on $\mathbb{R}$.
(A3) $\alpha: \mathbb{R} \longrightarrow(0, \infty)$ and $\alpha_{0}: Q \longrightarrow(0, \infty)$ are Lipschitz continuous functions, such that:
$-\alpha \in C^{2}(\mathbb{R})$, with the first derivative $\alpha^{\prime}=\frac{d \alpha}{d \eta}$ and the second one $\alpha^{\prime \prime}=\frac{d^{2} \alpha}{d \eta^{2}}$;

- $\alpha^{\prime}(0)=0, \alpha^{\prime \prime} \geq 0$ on $\mathbb{R}$, and $\alpha \alpha^{\prime}$ is a Lipschitz continuous function on $\mathbb{R}$;
$-\alpha \geq \delta_{*}$ on $\mathbb{R}$, and $\alpha_{0} \geq \delta_{*}$ on $\bar{Q}$, for some constant $\delta_{*} \in(0,1)$.
Additionally, for any $\varepsilon \geq 0$, let $f_{\varepsilon}: \mathbb{R} \longrightarrow[0, \infty)$ be the convex function, defined in (1.3).

Now, the Main Theorems of this paper are stated as follows:
Main Theorem 1. Let us assume (A1)-(A3). Let us fix a constant $\varepsilon \geq 0$, an initial pair $\left[\eta_{0}, \theta_{0}\right] \in V \times V_{0}$, and a forcing pair $[u, v] \in[\mathscr{H}]^{2}$. Then, the following hold:
(I-A) The state-system $(S)_{\varepsilon}$ admits a unique solution $[\eta, \theta] \in[\mathscr{H}]^{2}$, in the sense that:

## 4 Proof of Main Theorem 1

In this section, we give the proof of the first Main Theorem 1. Before the proof, we refer to the reformulation method as in [25], and consider to reduce the state-system $(\mathrm{S})_{\varepsilon}$ to an evolution equation in the Hilbert space $[H]^{2}$.

Let us fix any $\varepsilon \geq 0$. Besides, let us define time-dependent operators $\mathcal{A}(t) \in \mathscr{L}\left([H]^{2}\right)$, for $t \in[0, T]$, a nonlinear operator $\mathcal{G}:[H]^{2} \longrightarrow[H]^{2}$, and a proper functional $\Phi_{\varepsilon}$ : $[H]^{2} \longrightarrow[0, \infty]$, by setting:

Remark 9. In the case of $\varepsilon=0$, the equivalence between the corresponding state-system $(\mathrm{S})_{0}$ and Cauchy problem $(\mathrm{E})_{0}$ is not so obvious. However, we can show a partial relation, such that:

Similarly, for any $\tilde{\eta} \in V$, one can see that $\left[\theta, \theta^{*}\right] \in \partial_{\theta} \Phi_{0}(\tilde{\eta}, \cdot)$ in $H \times H$, iff.:

Taking into account (4.1)-(4.4), we deduce that the variational problem as in (3.1)-(3.3) is equivalently reformulated to the following Cauchy problem:

The item $(\star 0)$ is a straightforward consequence of this reformulation and the inclusion $\partial \Phi_{0} \subset\left[\partial_{\eta} \Phi_{0} \times \partial_{\theta} \Phi_{0}\right]$ in $[H]^{2} \times[H]^{2}$, mentioned in (1.2).

Now, we are ready to prove the Main Theorem 1.

Proof of Main Theorem 1 (I-A) First, we verify the existence part. Under the setting (4.1)-(4.3), we immediately check that:

Next, for the verification of the uniqueness part, we suppose that the both pairs of functions $\left[\eta^{\ell}, \theta^{\ell}\right] \in[\mathscr{H}]^{2}, \ell=1,2$, solve the state-system $(S)_{\varepsilon}$ for the common initial pair $\left[\eta_{0}, \theta_{0}\right]$ and forcing pair $[u, v] \in[\mathscr{H}]^{2}$. Besides, let us take the difference between two variational forms (3.2) for $\eta^{\ell}, \ell=1,2$, and put $\varphi=\eta^{1}-\eta^{2}$. Then, by using the assumptions (A1)-(A3), and Hölder's and Young's inequalities, we have:

Now, with (A3) in mind, we can verify the uniqueness part of (I-A), just by applying Gronwall's lemma to the estimate (4.7).

Remark 10. As a consequence of the uniqueness result in (I-A), we can say that the converse of $(\star 0)$ in Remark 9 is also true, i.e. the three problems $(S)_{0},(E)_{0}$, and $(\widetilde{\mathrm{E}})$ are equivalent each other.

Proof of Main Theorem 1 (I-B) By Remarks 8-10, the solution $w:=[\eta, \theta] \in[\mathscr{H}]^{2}$ to the state-system $(\mathrm{S})_{\varepsilon}$ coincides with that to the Cauchy problem $(\mathrm{E})_{\varepsilon}$ for the initial data $w_{0}:=\left[\eta_{0}, \theta_{0}\right] \in V \times V_{0}$ and forcing term $\mathfrak{f}:=\left[M_{u} u, M_{v} v\right] \in[\mathscr{H}]^{2}$. we can suppose that the sequence $\left\{w_{n}\right\}_{n=1}^{\infty}=\left\{\left[\eta_{n}, \theta_{n}\right]\right\}_{n=1}^{\infty}$ of solutions to systems (S) $)_{\varepsilon_{n}}$, $n=1,2,3, \ldots$, coincides with that of solutions to the problems $(\mathrm{E})_{\varepsilon_{n}}$, for the initial data $w_{0, n}$ and forcing terms $\mathfrak{f}_{n}, n=1,2,3, \ldots$. In addition:

& \quad=\frac{1}{2}|\tilde{\eta}|_{\mathscr{Y}}^{2}+\left.\frac{\nu^{2}}{2}\left|\tilde{\theta}_{\mathscr{Y}_{0}}^{2}+\left|\alpha(\tilde{\eta}) f_{\tilde{\varepsilon}}\left(\partial_{x} \tilde{\theta}\right)\right|_{L^{1}(Q)}+\frac{1}{2 \nu^{2}}\right| \alpha(\tilde{\eta})\right|_{\mathscr{H}} ^{2}+\frac{\nu^{2} \tilde{\varepsilon}^{2}}{2} T \\
& \quad \quad \text { for all } \tilde{\varepsilon}>0 \text { and } \tilde{w}=[\tilde{\eta}, \tilde{\theta}] \in D\left(\Phi_{\tilde{\varepsilon}}\right)=\mathscr{Y} . \tag{4.12}
\end{align*}
$$

Taking into account (4.9a), (4.11), and (4.12), we deduce that:

\left|\eta_{n}\right|_{\mathscr{Y}}^{2}+\nu^{2}\left|\theta_{n}\right|_{\mathscr{Y}_{0}}^{2} \rightarrow|\eta|_{\mathscr{V}}^{2}+\nu^{2}|\theta|_{\mathscr{Y}_{0}}^{2}, \text { and hence, }\left|w_{n}\right|_{\mathscr{Y}} \rightarrow|w|_{\mathscr{Y}}, \text { as } n \rightarrow \infty . \tag{4.13}
\end{equation*}
$$

Since the norm of Hilbert space $\mathscr{Y}$ is uniformly convex, the convergences (4.9b) and (4.13) imply the strong convergences:

& \quad \leq\left|\theta_{n}-\theta\right|_{\mathscr{H}_{0}}+\sqrt{T}\left|\varepsilon_{n}-\varepsilon\right| \rightarrow 0, \text { as } n \rightarrow \infty . \tag{4.14b}
\end{align*}
$$

The convergences (4.9) and (4.14) are sufficient to verify the conclusions (3.5) and (3.6) of Main Theorem 1 (I-B).

## 5 Proof of Main Theorem 2

In this section, we prove the second Main Theorem 2. Let $\left[\eta_{0}, \theta_{0}\right] \in V \times V_{0}$ be the initial pair, fixed in (A1). Also, let us fix arbitrary forcing pair $[\bar{u}, \bar{v}] \in[\mathscr{H}]^{2}$, and let us invoke the definition of the cost function (0.3), to estimate that:

Also, for any $\varepsilon \geq 0$, we denote by $\left[\bar{\eta}_{\varepsilon}, \bar{\theta}_{\varepsilon}\right]$ the solution to $(\mathrm{S})_{\varepsilon}$, for the initial pair $\left[\eta_{0}, \theta_{0}\right.$ ] and forcing pair $[\bar{u}, \bar{v}]$.

Based on these, the proof of Main Theorem 2 is demonstrated as follows.

Proof of Main Theorem 2 (II-A) Let us fix any $\varepsilon \geq 0$. Then, from the estimate (5.1), we immediately find a sequence of forcing pairs $\left\{\left[u_{n}, v_{n}\right]\right\}_{n=1}^{\infty} \subset[\mathscr{H}]^{2}$, such that:

Also, the estimate (5.2b) enables us to take a subsequence of $\left\{\left[u_{n}, v_{n}\right]\right\}_{n=1}^{\infty} \subset[\mathscr{H}]^{2}$ (not relabeled), and to find a pair of functions $\left[u^{*}, v^{*}\right] \in[\mathscr{H}]^{2}$, such that:

Let $\left[\eta^{*}, \theta^{*}\right] \in[\mathscr{H}]^{2}$ be the solution to $(\mathrm{S})_{\varepsilon}$, for the initial pair $\left[\eta_{0}, \theta_{0}\right]$ and forcing pair $\left[u^{*}, v^{*}\right]$. As well as, for any $n \in \mathbb{N}$, let $\left[\eta_{n}, \theta_{n}\right] \in[\mathscr{H}]^{2}$ be the solution to $(\mathrm{S})_{\varepsilon}$, for the forcing pair $\left[u_{n}, v_{n}\right]$. Then, having in mind (5.3) and the initial condition:

On account of (5.2a), (5.3), and (5.4), it is computed that:

& +\frac{1}{2}\left|\left[\sqrt{M_{u}} u^{*}, \sqrt{M_{v}} v^{*}\right]\right|_{[\mathscr{H}]^{2}}^{2} \\
\leq & \frac{1}{2} \lim _{n \rightarrow \infty}\left|\left[\sqrt{M_{\eta}}\left(\eta_{n}-\eta_{\mathrm{ad}}\right), \sqrt{M_{\theta}}\left(\theta_{n}-\theta_{\mathrm{ad}}\right)\right]\right|_{[\mathscr{H}]^{2}}^{2} \\
& +\frac{1}{2} \underline{\lim _{\rightarrow \infty}}\left|\left[\sqrt{M_{u}} u_{n}, \sqrt{M_{v}} v_{n}\right]\right|_{[\mathscr{H}]^{2}}^{2} \\
= & \lim _{n \rightarrow \infty} \mathcal{J}_{\varepsilon}\left(u_{n}, v_{n}\right)=\underline{J}_{\varepsilon}\left(\leq \mathcal{J}_{\varepsilon}\left(u^{*}, v^{*}\right)\right),
\end{aligned}
$$

and it implies that

\mathcal{J}_{\varepsilon}\left(u^{*}, v^{*}\right)=\min _{[u, v] \in[\mathscr{H}]^{2}} \mathcal{J}_{\varepsilon}(u, v) .
$$

Thus, we conclude the item (II-A).
Proof of Main Theorem 2 (II-B) Let $\varepsilon \in[0,1]$ and $\left\{\varepsilon_{n}\right\}_{n=1}^{\infty} \subset[0,1]$ be as in (3.9). Let $\left[\bar{\eta}_{\varepsilon}, \bar{\theta}_{\varepsilon}\right] \in[\mathscr{H}]^{2}$ be the solution to the system $(\mathrm{S})_{\varepsilon}$, for the initial pair $\left[\eta_{0}, \theta_{0}\right]$ and forcing pair $[\bar{u}, \bar{v}]$, and let $\left[\bar{\eta}_{\varepsilon_{n}}, \bar{\theta}_{\varepsilon_{n}}\right] \in[\mathscr{H}]^{2}, n=1,2,3, \ldots$, be the solutions to $(\mathrm{S})_{\varepsilon_{n}}$, for the respective initial pairs $\left[\eta_{0, n}, \theta_{0, n}\right], n=1,2,3, \ldots$, and the fixed forcing pair $[\bar{u}, \bar{v}]$. On this basis, let us first apply Main Theorem 1 (I-B) to the solutions $\left[\bar{\eta}_{\varepsilon}, \bar{\theta}_{\varepsilon}\right] \in[\mathscr{H}]^{2}$ and $\left[\bar{\eta}_{\varepsilon_{n}}, \bar{\theta}_{\varepsilon_{n}}\right] \in[\mathscr{H}]^{2}, n=1,2,3, \ldots$. Then, we have

\quad \rightarrow\left[\eta_{0}, \theta_{0}\right]=\left[\bar{\eta}_{\varepsilon}(0), \bar{\theta}_{\varepsilon}(0)\right] \text { in }[C(\bar{\Omega})]^{2},
\end{array} \quad \text { as } n \rightarrow \infty,\right.
$$

and hence,

$$
\begin{equation*}
\bar{J}_{\text {sup }}:=\sup _{n \in \mathbb{N}} \mathcal{J}_{\varepsilon_{n}}(\bar{u}, \bar{v})<\infty . \tag{5.6}
\end{equation*}
$$

Next, for any $n \in \mathbb{N}$, let us denote by $\left[\eta_{n}^{*}, \theta_{n}^{*}\right] \in[\mathscr{H}]^{2}$ the solution to $(\mathrm{S})_{\varepsilon_{n}}$, for the initial pair $\left[\eta_{0, n}, \theta_{0, n}\right]$ and forcing pair $\left[u_{n}^{*}, v_{n}^{*}\right]$. Then, in the light of (5.1) and (5.6), we can see that:

$$

Therefore, we can find a subsequence $\left\{n_{i}\right\}_{i=1}^{\infty} \subset\{n\}$, together with a pair of functions $\left[u^{* *}, v^{* *}\right] \in[\mathscr{H}]^{2}$, such that:

\end{equation*}
$$

Here, let us denote by $\left[\eta^{* *}, \theta^{* *}\right] \in[\mathscr{H}]^{2}$ the solution to $(\mathrm{S})_{\varepsilon}$, for the initial pair $\left[\eta_{0}, \theta_{0}\right]$ and forcing pair $\left[u^{* *}, v^{* *}\right]$. Then, applying Main Theorem 1 (I-B), again, to the solutions $\left[\eta^{* *}, \theta^{* *}\right]$ and $\left[\eta_{n_{i}}^{*}, \theta_{n_{i}}^{*}\right], i=1,2,3, \ldots$, we can observe that:

Now, as a consequence of (5.5), (5.7), and (5.8), it is verified that:

\mathcal{J}_{\varepsilon}\left(u^{* *}, v^{* *}\right)= & \frac{1}{2}\left|\left[\sqrt{M_{\eta}}\left(\eta^{* *}-\eta_{\mathrm{ad}}\right), \sqrt{M_{\theta}}\left(\theta^{* *}-\theta_{\mathrm{ad}}\right)\right]\right|_{[\mathscr{H}]^{2}}^{2} \\
& +\frac{1}{2}\left|\left[\sqrt{M_{u}} u^{* *}, \sqrt{M_{v}} v^{* *}\right]\right|_{[\mathscr{H}]^{2}}^{2} \\
\leq & \frac{1}{2} \lim _{i \rightarrow \infty}\left|\left[\sqrt{M_{\eta}}\left(\eta_{n_{i}}^{*}-\eta_{\mathrm{ad}}\right), \sqrt{M_{\theta}}\left(\theta_{n_{i}}^{*}-\theta_{\mathrm{ad}}\right)\right]\right|_{[\mathscr{H}]^{2}}^{2} \\
& +\frac{1}{2} \underline{\lim _{i \rightarrow \infty}}\left|\left[\sqrt{M_{u}} u_{n_{i}}^{*}, \sqrt{M_{v}} v_{n_{i}}^{*}\right]\right|_{[\mathscr{H}]^{2}}^{2} \\
\leq & \lim _{i \rightarrow \infty} \mathcal{J}_{\varepsilon_{n_{i}}}\left(u_{n_{i}}^{*}, v_{n_{i}}^{*}\right) \leq \lim _{i \rightarrow \infty} \mathcal{J}_{\varepsilon_{n_{i}}}(\bar{u}, \bar{v}) \\
= & \frac{1}{2} \lim _{i \rightarrow \infty}\left|\left[\sqrt{M_{\eta}}\left(\bar{\eta}_{\varepsilon_{n_{i}}}-\eta_{\mathrm{ad}}\right), \sqrt{M_{\theta}}\left(\bar{\theta}_{\varepsilon_{n_{i}}}-\theta_{\mathrm{ad}}\right)\right]\right|_{[\mathscr{H}]^{2}}^{2} \\
& +\frac{1}{2}\left|\left[\sqrt{M_{u}} \bar{u}, \sqrt{M_{v}} \bar{v}\right]\right|_{[\mathscr{H}]^{2}}^{2} \\
= & \mathcal{J}_{\varepsilon}(\bar{u}, \bar{v}) .
\end{aligned}
$$

Since the choice of $[\bar{u}, \bar{v}] \in[\mathscr{H}]^{2}$ is arbitrary, we conclude that:

and complete the proof of the item (II-B).

## 6 Proof of Main Theorem 3

This section is devoted to the proof of Main Theorem 3. To this end, we need to start with the case of $\varepsilon>0$, and prepare some Lemmas, associated with the Gâteaux differential of the regular cost function $\mathcal{J}_{\mathcal{\varepsilon}}$.

Let $\varepsilon>0$ be a fixed constant, and let $\left[\eta_{0}, \theta_{0}\right] \in V \times V_{0}$ be the initial pair, fixed in (A1). Let us take any forcing pair $[u, v] \in[\mathscr{H}]^{2}$, and consider the unique solution $[\eta, \theta] \in[\mathscr{H}]^{2}$ to the state-system $(\mathrm{S})_{\varepsilon}$. Also, let us take any constant $\delta \in(-1,1) \backslash\{0\}$ and any pair of functions $[h, k] \in[\mathscr{H}]^{2}$, and consider another solution $\left[\eta^{\delta}, \theta^{\delta}\right] \in[\mathscr{H}]^{2}$ to the system $(\mathrm{S})_{\varepsilon}$,
for the initial pair $\left[\eta_{0}, \theta_{0}\right]$ and a perturbed forcing pair $[u+\delta h, v+\delta k]$. On this basis, we consider a sequence of pairs of functions $\left\{\left[\chi^{\delta}, \gamma^{\delta}\right]\right\}_{\delta \in(-1,1) \backslash\{0\}} \subset[\mathscr{H}]^{2}$, defined as:

\left[\chi^{\delta}, \gamma^{\delta}\right]:=\left[\frac{\eta^{\delta}-\eta}{\delta}, \frac{\theta^{\delta}-\theta}{\delta}\right] \in[\mathscr{H}]^{2}, \text { for } \delta \in(-1,1) \backslash\{0\} . \tag{6.1}

This sequence acts a key-role in the computation of Gâteaux differential of the cost function $\mathcal{J}_{\varepsilon}$, for $\varepsilon>0$.

Remark 11. Note that for any $\delta \in(-1,1) \backslash\{0\}$, the pair of functions $\left[\chi^{\delta}, \gamma^{\delta}\right] \in[\mathscr{H}]^{2}$ fulfills the following variational forms:

& \quad+\int_{\Omega}\left(\alpha^{\prime}\left(\eta^{\delta}(t)\right) \int_{0}^{1} f_{\varepsilon}^{\prime}\left(\partial_{x} \theta(t)+\varsigma \delta \partial_{x} \gamma^{\delta}(t)\right) d \varsigma\right) \partial_{x} \gamma^{\delta}(t) \varphi d x \\
& =\left(M_{u} h(t), \varphi\right)_{H}, \text { for any } \varphi \in V, \text { a.e. } t \in(0, T), \text { subject to } \chi^{\delta}(0)=0 \text { in } H,
\end{aligned}
$$

and

$$
\begin{aligned}
& \left(\alpha_{0}(t) \partial_{t} \gamma^{\delta}(t), \psi\right)_{H}+\nu^{2}\left(\partial_{x} \gamma^{\delta}(t), \partial_{x} \psi\right)_{H} \\
& \quad+\int_{\Omega}\left(\alpha\left(\eta^{\delta}(t)\right) \int_{0}^{1} f_{\varepsilon}^{\prime \prime}\left(\partial_{x} \theta(t)+\varsigma \delta \partial_{x} \gamma^{\delta}(t)\right) d \varsigma\right) \partial_{x} \gamma^{\delta}(t) \partial_{x} \psi d x \\
& \quad+\int_{\Omega}\left(f_{\varepsilon}^{\prime}\left(\partial_{x} \theta(t)\right) \int_{0}^{1} \alpha^{\prime}\left(\eta(t)+\varsigma \delta \chi^{\delta}(t)\right) d \varsigma\right) \chi^{\delta}(t) \partial_{x} \psi d x \\
& =\left(M_{v} k(t), \psi\right)_{H}, \text { for any } \psi \in V_{0}, \text { a.e. } t \in(0, T), \text { subject to } \gamma^{\delta}(0)=0 \text { in } H .
\end{aligned}
$$

In fact, these variational forms are obtained by taking the difference between respective two variational forms for $\left[\eta^{\delta}, \theta^{\delta}\right]$ and $[\eta, \theta]$, as in Main Theorem 1 (I-A), and by using the following linearization formulas:

=\frac{1}{\delta}\left(\left(\alpha^{\prime}\left(\eta^{\delta}\right)-\alpha^{\prime}(\eta)\right) f_{\varepsilon}\left(\partial_{x} \theta\right)\right)+\frac{1}{\delta}\left(\alpha^{\prime}\left(\eta^{\delta}\right)\left(f_{\varepsilon}\left(\partial_{x} \theta^{\delta}\right)-f_{\varepsilon}\left(\partial_{x} \theta\right)\right)\right) \\
=\left(f_{\varepsilon}\left(\partial_{x} \theta\right) \int_{0}^{1} \alpha^{\prime \prime}\left(\eta+\varsigma \delta \chi^{\delta}\right) d \varsigma\right) \chi^{\delta} \\
\quad+\left(\alpha^{\prime}\left(\eta^{\delta}\right) \int_{0}^{1} f_{\varepsilon}^{\prime}\left(\partial_{x} \theta+\varsigma \delta \partial_{x} \gamma^{\delta}\right) d \varsigma\right) \partial_{x} \gamma^{\delta} \text { in } \mathscr{H}
\end{array}
$$

and

$$
\begin{aligned}
& \frac{1}{\delta}\left(\alpha\left(\eta^{\delta}\right) f_{\varepsilon}^{\prime}\left(\partial_{x} \theta^{\delta}\right)-\alpha(\eta) f_{\varepsilon}^{\prime}\left(\partial_{x} \theta\right)\right) \\

## 7 Appendix

The objective of the Appendix is to reorganize the general theory of nonlinear evolution equation, which enables us to handle the state-systems $(S)_{\varepsilon}$, for all $\varepsilon \geq 0$ in a unified fashion.

In what follows, let $X$ be an abstract Hilbert space. On this basis, the general theory will be stated by considering two Lemmas, and the proofs will be modified (mixed and reduced) versions of the existing theories, such as $[4,5,16]$.

Lemma 7.1. Let $\left\{\mathcal{A}_{0}(t) \mid t \in[0, T]\right\} \subset \mathscr{L}(X)$ be a class of time-dependent bounded linear operators, let $\mathcal{G}_{0}: X \longrightarrow X$ be a given nonlinear operator, and let $\Psi_{0}: X \longrightarrow[0, \infty]$ be a non-negative, proper, l.s.c., and convex function, fulfilling the following conditions:
(cp.0) $\mathcal{A}_{0}(t) \in \mathscr{L}(X)$ is positive and selfadjoint, for any $t \in[0, T]$, and it holds that

(cp.2) $\mathcal{G}_{0}: X \longrightarrow X$ is a Lipschitz continuous operator with a Lipschitz constant $L_{0}$, and $\mathcal{G}_{0}$ has a $C^{1}$-potential functional $\widehat{\mathcal{G}}_{0}: X \longrightarrow \mathbb{R}$, so that the Gâteaux derivative $\widehat{\mathcal{G}}_{0}^{\prime}(w) \in X^{*}(=X)$ at any $w \in X$ coincides with $\mathcal{G}_{0}(w) \in X$;
(cp.3) $\Psi_{0} \geq 0$ on $X$, and the sublevel set $\left\{w \in X \mid \Psi_{0}(w) \leq r\right\}$ is compact in $X$, for any $r \geq 0$.

Then, for any initial data $w_{0} \in D\left(\Psi_{0}\right)$ and a forcing term $\mathfrak{f}_{0} \in L^{2}(0, T ; X)$, the following Cauchy problem of evolution equation:

\left|w_{i}-w_{0}\right|_{X}^{2} \leq \frac{1}{\kappa_{0}}\left(\mathcal{A}_{0, i}\left(w_{i}-w_{0}\right), w_{i}-w_{0}\right)_{X}=\frac{1}{\kappa_{0}}\left|\mathcal{A}_{0, i}^{\frac{1}{2}}\left(w_{i}-w_{0}\right)\right|_{X}^{2}, \text { for } i=1, \ldots, n .
$$

So, applying the discrete version of Gronwall's lemma (cf. [8, Section 3.1]) to (7.8), and having in mind (7.7), it is observed that:

& \left|\mathcal{A}_{0, i}^{\frac{1}{2}}\left(w_{i}-w_{0}\right)\right|_{X}^{2} \\
& \quad \leq \frac{1+2 L^{2}}{L} e^{\frac{4 T\left(A_{T}^{*}+5 L\right)}{\kappa_{0}}}\left(\sup _{n \in \mathbb{N}}\left|\left[\overline{f_{0}}\right]_{n}\right|_{L^{2}(0, T ; X)}^{2}+T\left(\left|w_{0}\right|_{X}^{2}+\Psi_{0}\left(w_{0}\right)+\widehat{\mathcal{F}}_{L}\left(w_{0}\right)\right)\right) \\
& \quad=: r_{0}^{*}<\infty, \text { for } i=1, \ldots, n,
\end{aligned}
$$

and

$$
\begin{align*}
\left|w_{i}\right|_{X}^{2} & \leq 2\left(\left|w_{0}\right|_{X}^{2}+\frac{1}{\kappa_{0}}\left|\mathcal{A}_{0, i}^{\frac{1}{2}}\left(w_{i}-w_{0}\right)\right|_{X}^{2}\right) \\
& \leq 2\left(\left|w_{0}\right|_{X}^{2}+\frac{r_{0}^{*}}{\kappa_{0}}\right)=: r_{1}^{*}<\infty, \text { for } i=1, \ldots, n . \tag{7.10}
\end{align*}
$$

Additionally, multiplying the both sides of (7.5) by $w_{i}-w_{i-1}$, and using (cp.0)-(cp.3) and (7.10), we infer that:

\frac{\kappa_{0}}{2 \tau_{n}}\left|w_{i}-w_{i-1}\right|_{X}^{2}+\left(\Psi_{0}\left(w_{i}\right)+\widehat{\mathcal{F}}_{L}\left(w_{i}\right)\right)-\left(\Psi_{0}\left(w_{i-1}\right)+\widehat{\mathcal{F}}_{L}\left(w_{i-1}\right)\right) \\
\leq \frac{1+4 L^{2}}{\kappa_{0}} \cdot \tau_{n}\left(r_{1}^{*}+\left|\mathfrak{f}_{0, i}\right|_{X}^{2}\right), \text { for } i=1, \ldots, n \tag{7.11}
\end{gather*}
$$

via the following calculations:

& \left(w_{i}^{*}, w_{i}-w_{i-1}\right)_{X}+2 L\left|w_{i}-w_{i-1}\right|_{X}^{2}+\left(\mathcal{G}_{0}\left(w_{i}\right), w_{i}-w_{i-1}\right)_{X} \\
& \quad \geq \Psi_{0}\left(w_{i}\right)-\Psi_{0}\left(w_{i-1}\right)+\left(\widehat{\mathcal{F}}_{L}^{\prime}\left(w_{i}\right), w_{i}-w_{i-1}\right)_{X}-2 L\left(w_{i-1}, w_{i}-w_{i-1}\right)_{X} \\
& \quad \geq\left(\Psi_{0}\left(w_{i}\right)+\widehat{\mathcal{F}}_{L}\left(w_{i}\right)\right)-\left(\Psi_{0}\left(w_{i-1}\right)+\widehat{\mathcal{F}}_{L}\left(w_{i-1}\right)\right)-\frac{\kappa_{0}}{4 \tau_{n}}\left|w_{i}-w_{i-1}\right|_{X}^{2}-\frac{4 L^{2}}{\kappa_{0}} \cdot \tau_{n} r_{1}^{*},
\end{aligned}
$$

with the element $w_{i}^{*} \in \partial \Psi_{0}\left(w_{i}\right)$, as in (7.9),
and

$$
\left(\mathfrak{f}_{0, i}, w_{i}-w_{i-1}\right)_{X} \leq \frac{\kappa_{0}}{4 \tau_{n}}\left|w_{i}-w_{i-1}\right|_{X}^{2}+\frac{1}{\kappa_{0}} \cdot \tau_{n}\left|\mathfrak{f}_{0, i}\right|_{X}^{2}, \text { for } i=1, \ldots, n .
$$

So, summing up (7.11), for $i=1, \ldots, n$, and invoking (7.7), we can derive the following estimate:

& \quad \leq \Psi_{0}\left(w_{0}\right)+\widehat{\mathcal{F}}_{L}\left(w_{0}\right)+\frac{1+4 L^{2}}{\kappa_{0}}\left(T r_{1}^{*}+\sup _{n \in \mathbb{N}}\left|\left[\overline{\mathfrak{F}}_{0}\right]_{n}\right|_{L^{2}(0, T ; X)}^{2}\right) \\
& \quad=r_{2}^{*}<\infty, \text { for all } t \in[0, T], \text { and } n=1,2,3, \ldots .
\end{aligned}
$$

This estimate enable us to say that:
$(\star 3)\left\{[\widehat{w}]_{n}\right\}_{n=1}^{\infty}$ is bounded in $W^{1,2}(0, T ; X)$, and $\left\{[\bar{w}]_{n}\right\}_{n=1}^{\infty}$ is bounded in $L^{\infty}(0, T ; X)$;
$(\star 4)\left\{\begin{array}{l}\left.[\bar{w}]_{n}(t),[\widehat{w}]_{n}(t) \mid t \in[0, T], n=1,2,3, \ldots\right\} \text { is contained in a compact sublevel set } \\ \left.\varpi \in X \mid \Psi_{0}(\varpi) \leq r_{2}^{*}\right\} .\end{array}\right.$
By virtue of $(\star 3)$ and $(\star 4)$, we can apply the general theories of compactness, such as Ascoli's and Alaoglu's theorems (cf. [34, Corollary 4], [35, Section 1.2], and so on), and we can find a limit function $w \in W^{1,2}(0, T ; X)$ for some subsequences of $\left\{[\widehat{w}]_{n}\right\}_{n=1}^{\infty}$ and $\left\{[\bar{w}]_{n}\right\}_{n=1}^{\infty}$ (not relabeled), such that:

we can also see that

[\bar{w}]_{n} \rightarrow w \text { in } L^{\infty}(0, T ; X), \text { as } n \rightarrow \infty . \tag{7.12b}
\end{equation*}

Taking into account (7.5), (7.7), (7.12), and (cp.0)-(cp.3), we deduce that:

& \quad+\int_{I} \Psi_{0}(w(t)) d t-\int_{I} \Psi_{0}(\varpi) d t \\
& \quad \leq \lim _{n \rightarrow \infty} \int_{I}\left([\widehat{w}]_{n}^{\prime}(t),\left[\overline{\mathcal{A}}_{0}\right]_{n}(t)\left([\bar{w}]_{n}(t)-\varpi\right)\right)_{X} d t \\
& \quad+\lim _{n \rightarrow \infty} \tau_{n} \int_{I}\left(2 L[\widehat{w}]_{n}^{\prime}(t),[\bar{w}]_{n}(t)-\varpi\right)_{X} d t \\
& \quad+\lim _{n \rightarrow \infty} \int_{I}\left(\mathcal{G}_{0}\left([\bar{w}]_{n}(t)\right)-\left[\overline{\mathfrak{f}_{0}}\right]_{n}(t),[\bar{w}]_{n}(t)-\varpi\right)_{X} d t \\
& \quad+{\underset{n \rightarrow \infty}{ }} \quad \int_{I} \Psi_{0}\left([\bar{w}]_{n}(t)\right) d t-\int_{I} \Psi_{0}(\varpi) d t \leq 0, \\
& \quad \\
& \quad \text { for any } \varpi \in D\left(\Psi_{0}\right), \text { and any open interval } I \subset(0, T) .
\end{aligned}
$$

This implies that $w$ is a solution to the problem (CP).
Next, for the proof of uniqueness, we suppose that the both $w^{\ell} \in L^{2}(0, T ; X), \ell=1,2$, are solutions to (CP). Then, by virtue of (cp.0)-(cp.3), it is immediately verified that:

&\left(\mathcal { A } _ { 0 } ( t ) \left(w^{1}\right.\right.\left.\left.-w^{2}\right)^{\prime}(t),\left(w^{1}-w^{2}\right)(t)\right)_{X} \\
&=\frac{1}{2}( {\left.\left[\mathcal{A}_{0}\left(w^{1}-w^{2}\right)\right]^{\prime}(t),\left(w^{1}-w^{2}\right)(t)\right)_{X} } \\
& \quad-\frac{1}{2}\left(\mathcal{A}_{0}^{\prime}(t)\left(w^{1}-w^{2}\right)(t),\left(w^{1}-w^{2}\right)(t)\right)_{X} \\
&+\frac{1}{2}\left(\mathcal{A}_{0}(t)\left(w^{1}-w^{2}\right)(t),\left(w^{1}-w^{2}\right)^{\prime}(t)\right)_{X} \\
& \geq \frac{1}{2} \frac{d}{d t}\left|\mathcal{A}_{0}(t)^{\frac{1}{2}}\left(w^{1}-w^{2}\right)(t)\right|_{X}^{2} \\
& \quad-\frac{A_{T}^{*}}{2 \kappa_{0}}\left|\mathcal{A}_{0}(t)^{\frac{1}{2}}\left(w^{1}-w^{2}\right)(t)\right|_{X}^{2}, \text { for a.e. } t \in(0, T) \tag{7.13b}
\end{align*}
$$

and

$$
\begin{align*}
\left(\mathcal{G}_{0}\left(w^{1}(t)\right)\right. & \left.-\mathcal{G}_{0}\left(w^{2}(t)\right),\left(w^{1}-w^{2}\right)(t)\right)_{X} \\
\quad \geq & -\frac{L_{0}}{\kappa_{0}}\left|\mathcal{A}_{0}(t)^{\frac{1}{2}}\left(w^{1}-w^{2}\right)(t)\right|_{X}^{2}, \text { for a.e. } t \in(0, T) . \tag{7.13c}
\end{align*}
$$

Hence, the uniqueness for the problem (CP) will be verified via the following Gronwall type estimate:

that will be obtained by referring to the standard method, i.e.: by taking the difference between two equations, as in (7.13a); by multiplying the both sides by $\left(w^{1}-w^{2}\right)(t)$; and by applying (7.13b) and (7.13c), the monotonicity of $\partial \Psi_{0}$ in $X \times X$, and the initial condition $w^{1}(0)=w^{2}(0)=w_{0}$ in $X$.

Finally, we verify (7.3). Owing to (cp.2) and [5, Lemma 3.3], one can say that the both functions $t \in[0, T] \mapsto \Psi_{0}(w(t)) \in[0, \infty)$ and $t \in[0, T] \mapsto \widehat{\mathcal{G}}_{0}(w(t)) \in \mathbb{R}$ are absolutely continuous, and:

The equality (7.3) will be obtained as a consequence of (7.14) and (cp.0).
Lemma 7.2. Under the notations $\mathcal{A}_{0}, \mathcal{G}_{0}$, and $\Psi_{0}$, and assumptions (cp.0)-(cp.3) as in the previous Lemma 7.1, let us fix $w_{0} \in D\left(\Psi_{0}\right)$ and $\mathfrak{f}_{0} \in L^{2}(0, T ; X)$, and take the unique solution $w \in L^{2}(0, T ; X)$ to the Cauchy problem (CP). Let $\left\{\Psi_{n}\right\}_{n=1}^{\infty},\left\{w_{0, n}\right\}_{n=1}^{\infty} \subset X$, and $\left\{\mathfrak{f}_{n}\right\}_{n=1}^{\infty}$ be, respectively, a sequence of proper, l.s.c., and convex functions on $X$, a sequence of initial data in $X$, and a sequence of forcing terms in $L^{2}(0, T ; X)$, such that:
(cp.4) $\Psi_{n} \geq 0$ on $X$, for $n=1,2,3, \ldots$, and the union $\bigcup_{n=1}^{\infty}\left\{w \in X \mid \Psi_{n}(w) \leq r\right\}$ of sublevel sets is relatively compact in $X$, for any $r \geq 0$;
(cp.5) $\Psi_{n}$ converges to $\Psi_{0}$ on $X$, in the sense of Mosco, as $n \rightarrow \infty$;
(cp.6) $\sup _{n \in \mathbb{N}} \Psi_{n}\left(w_{0, n}\right)<\infty$, and $w_{0, n} \rightarrow w_{0}$ in $X$, as $n \rightarrow \infty$;
(cp.7) $\mathfrak{f}_{n} \rightarrow \mathfrak{f}_{0}$ weakly in $L^{2}(0, T ; X)$, as $n \rightarrow \infty$.
Let $w_{n} \in W^{1,2}(0, T ; X)$ be the solution to the Cauchy problem (CP), for the initial data $w_{0, n} \in D\left(\Psi_{n}\right)$ and forcing term $\mathfrak{f}_{n} \in L^{2}(0, T ; X)$. Then,

\begin{gathered}
w_{n} \rightarrow w \text { in } C([0, T] ; X), \text { weakly in } W^{1,2}(0, T ; X), \\
\int_{0}^{T} \Psi_{n}\left(w_{n}(t)\right) d t \rightarrow \int_{0}^{T} \Psi_{0}(w(t)) d t, \text { as } n \rightarrow \infty
\end{gathered}
$$

and

$$
\left|\Psi_{0}(w)\right|_{C([0, T])} \leq \sup _{n \in \mathbb{N}}\left|\Psi_{n}\left(w_{n}\right)\right|_{C([0, T])}<\infty
$$

Proof. This Lemma is proved by referring to the method of proof as in [16, Theorem 2.7.1] (also see [7, Main Theorem 2]).

First, let us apply (7.3) to the solutions $w_{n}$, for $n=1,2,3, \ldots$ Then, we have:

\left|\mathcal{A}_{0}(t)^{\frac{1}{2}} w_{n}^{\prime}(t)\right|_{X}^{2}+\frac{d}{d t}\left(\Psi_{n}\left(w_{n}(t)\right)+\widehat{\mathcal{G}}_{0}\left(w_{n}(t)\right)\right)=\left(\mathfrak{f}_{n}(t), w_{n}^{\prime}(t)\right)_{X},  \tag{7.15}\\
\text { for a.e. } t \in(0, T), n=1,2,3, \ldots
\end{gather*}
$$

Besides, for simplicity of description, we define:

$$
\begin{gathered}
\widehat{\Psi}_{0}(\varpi):=\int_{0}^{T} \Psi_{0}(\varpi(t)) d t \text { and } \widehat{\Psi}_{n}(\varpi):=\int_{0}^{T} \Psi_{n}(\varpi(t)) d t, n=1,2,3, \ldots, \\
\text { for any } \varpi \in L^{2}(0, T ; X) .
\end{gathered}
$$

By (cp.5), Remark 3 (Fact 2), and [5, Proposition 2.16], the above $\widehat{\Psi}_{0}$ and $\widehat{\Psi}_{n}, n=$ $1,2,3, \ldots$, form proper, l.s.c., and convex functions on $L^{2}(0, T ; X)$, such that:

\left\{\begin{array}{l}
{\left[w, \mathfrak{f}_{0}-\mathcal{A}_{0} w^{\prime}-\mathcal{G}_{0}(w)\right] \in \partial \widehat{\Psi}_{0} \text { in } L^{2}(0, T ; X) \times L^{2}(0, T ; X)}  \tag{7.16a}\\
{\left[w_{n}, \mathfrak{f}_{0, n}-\mathcal{A}_{0} w_{n}^{\prime}-\mathcal{G}_{0}\left(w_{n}\right)\right] \in \partial \widehat{\Psi}_{n} \text { in } L^{2}(0, T ; X) \times L^{2}(0, T ; X)} \\
\quad \text { for } n=1,2,3, \ldots
\end{array}\right.
$$

and

$$
\begin{equation*}
\widehat{\Psi}_{n} \rightarrow \widehat{\Psi}_{0} \text { on } L^{2}(0, T ; X) \text {, in the sense of Mosco, as } n \rightarrow \infty . \tag{7.16b}
\end{equation*}
$$

Next, let us take arbitrary $t \in[0, T]$, and integrate the both sides of (7.15) over $[0, t]$. Then, by using Hölder's and Young's inequalities, and by applying (cp.0), (cp.2), (cp.6),
(cp.7), and the mean-value theorem (cf. [21, Theorem 5 in p. 313]), we deduce that:

& \quad \leq\left(\Psi_{n}\left(w_{0, n}\right)+\widehat{\mathcal{G}}_{0}\left(w_{0, n}\right)\right)+\frac{1}{2 \kappa_{0}} \int_{0}^{T}\left|\mathfrak{f}_{n}(t)\right|_{X}^{2} d t \\
& \quad \leq \sup _{n \in \mathbb{N}}\left(\Psi_{n}\left(w_{0, n}\right)+\frac{1}{2 \kappa_{0}}\left|\mathfrak{f}_{n}\right|_{L^{2}(0, T ; X)}^{2}\right. \\
& \left.\quad \quad+\left|\widehat{\mathcal{G}}_{0}(0)\right|+\left|w_{0, n}\right|_{X}\left(\left|\mathcal{G}_{0}(0)\right|_{X}+L_{0}\left|w_{0, n}\right|_{X}\right)\right) \\
& =  \tag{7.17}\\
& \quad r_{3}^{*}<\infty, \text { for all } t \in[0, T], \text { and } n=1,2,3, \ldots .
\end{align*}
$$

From the above estimate, one can say that:

$$
\left\{\begin{aligned}
& \bullet\left\{w_{n}\right\}_{n=1}^{\infty} \text { is bounded in } W^{1,2}(0, T ; X), \text { and is also bounded in } C([0, T] ; X), \\
& \bullet\left\{w_{n}(t) \mid t \in[0, T], n=1,2,3, \ldots\right\} \text { is contained in a relatively compact set } \\
& \bigcup_{n=1}^{\infty}\left\{\varpi \in X \mid \Psi_{n}(\varpi) \leq r_{3}^{*}\right\} .
\end{aligned}\right.
$$

Therefore, applying (cp.1)-(cp.7), and the general theories of compactness, such as Ascoli's and Alaoglu's theorems (cf. [34, Corollary 4], [35, Section 1.2], and so on), we find a limit function $\bar{w} \in W^{1,2}(0, T ; X)$, with a subsequence of $\left\{w_{n}\right\}_{n=1}^{\infty}$ (not relabeled), such that:

$$
\begin{align*}
& w_{n} \rightarrow \bar{w} \text { in } C([0, T] ; X), \text { weakly in } W^{1,2}(0, T ; X), \\
& \text { and in particular, } w_{0, n}=w_{n}(0) \rightarrow w_{0}=\bar{w}(0), \text { as } n \rightarrow \infty,  \tag{7.18a}\\
& \qquad \mathfrak{f}_{n}-\mathcal{A}_{0} w_{n}^{\prime}-\mathcal{G}_{0}\left(w_{n}\right) \rightarrow \mathfrak{f}_{0}-\mathcal{A}_{0} \bar{w}^{\prime}-\mathcal{G}_{0}(\bar{w}) \\
& \quad \text { weakly in } L^{2}(0, T ; X), \text { as } n \rightarrow \infty, \tag{7.18b}
\end{align*}
$$

and

$$
\begin{align*}
0 \leq \Psi_{0}(\bar{w}(t)) & \leq \liminf _{n \rightarrow \infty} \Psi_{n}\left(w_{n}(t)\right) \leq \sup _{n \in \mathbb{N}}\left|\Psi_{n}\left(w_{n}\right)\right|_{C([0, T])} \\
& \leq r_{3}^{*}<\infty, \text { for any } t \in[0, T] \tag{7.18c}
\end{align*}
$$

On account of (7.16), (7.18), and Remark 3 (Fact 1), we can observe that $\bar{w}$ coincides with the unique solution $w$ to the problem (CP), and we can conclude this Lemma.
