# EXTRAPOLATION OF COMPACTNESS ON WEIGHTED SPACES

#### Abstract

Let $T$ be a linear operator that, for some $p_{1} \in(1, \infty)$, is bounded on $L^{p_{1}}(\tilde{w})$ for all $\tilde{w} \in A_{p_{1}}\left(\mathbb{R}^{d}\right)$ and in addition compact on $L^{p_{1}}\left(w_{1}\right)$ for some $w_{1} \in A_{p_{1}}\left(\mathbb{R}^{d}\right)$. Then $T$ is bounded and compact on $L^{p}(w)$ for all $p \in(1, \infty)$ and all $w \in A_{p}\left(\mathbb{R}^{d}\right)$. This "compact version" of Rubio de Francia's celebrated weighted extrapolation theorem follows from a combination of results in the interpolation and extrapolation theory of weighted spaces on the one hand, and of compact operators on abstract spaces on the other hand. Moreover, generalizations of this extrapolation of compactness are obtained for operators that are bounded from one space to a different one ("off-diagonal estimates") or only in a limited range of the $L^{p}$ scale. As applications, we easily recover several recent results on the weighted compactness of commutators of singular integral operators, fractional integrals and pseudo-differential operators, and obtain new results about the weighted compactness of commutators of Bochner-Riesz multipliers.


## 1. Introduction

By a weight we understand a locally integrable function $w \in L_{\mathrm{loc}}^{1}\left(\mathbb{R}^{d}\right)$ that is positive almost everywhere. As we will work in the weighted setting, we define the weighted Lebesgue spaces

L^{p}(w):=\left\{f: \mathbb{R}^{d} \rightarrow \mathbb{C} \text { measurable } \mid\|f\|_{L^{p}(w)}:=\left(\int_{\mathbb{R}^{d}}|f|^{p} w\right)^{1 / p}<\infty\right\}

and we recall the definitions of $A_{p}\left(\mathbb{R}^{d}\right), A_{p, q}\left(\mathbb{R}^{d}\right)$, and $R H_{r}\left(\mathbb{R}^{d}\right)$ classes of weights first introduced by Muckenhoupt [51, Muckenhoupt-Wheeden [52], and Gehring [33], respectively:

[^0]1.1. Definition. A weight $w \in L_{\mathrm{loc}}^{1}\left(\mathbb{R}^{d}\right)$ is called a Muckenhoupt $A_{p}\left(\mathbb{R}^{d}\right)$ weight (or $w \in A_{p}\left(\mathbb{R}^{d}\right)$ ) if

where the supremum is taken over all cubes $Q \subset \mathbb{R}^{d}$, and $\langle w\rangle_{Q}:=|Q|^{-1} \int_{Q} w$. A weight $w$ is called an $A_{p, q}\left(\mathbb{R}^{d}\right)$ weight (or $w \in A_{p, q}\left(\mathbb{R}^{d}\right)$ ) if

[w]_{A_{p, q}}:=\sup _{Q}\left\langle w^{q}\right\rangle_{Q}^{1 / q}\left\langle w^{-p^{\prime}}\right\rangle_{Q}^{1 / p^{\prime}}<\infty, \quad 1<p \leq q<\infty

where $p^{\prime}:=p /(p-1)$ denotes the conjugate exponent.
We say that $w$ belongs to the reverse Hölder class $R H_{r}\left(\mathbb{R}^{d}\right)$ (or $w \in$ $R H_{r}\left(\mathbb{R}^{d}\right)$ ) if

The role of these weights in Analysis is well recognised since the pioneering works [18, 33, 39, 51]. In particular, the classes $A_{p}\left(\mathbb{R}^{d}\right)$ and $A_{p, q}\left(\mathbb{R}^{d}\right)$ were introduced to study the weighted norm inequalities for the Hardy-Littlewood maximal function and for fractional integral operators, respectively; see [51, 52]. On the other hand, the reverse Hölder classes $R H_{r}\left(\mathbb{R}^{d}\right)$ were introduced to study the $L^{p}$-integrability of the partial derivatives of a quasiconformal mapping; see 33.

The following theorem of Rubio de Francia 53] on the extrapolation of boundedness on weighted spaces is one of the most useful and powerful tools in the theory of weighted norm inequalities: (See also 31] for a constructive proof, [27] for a quantitative formulation, [23] for an extensive treatment of related matters, and 45] for a recent survey on applications of this result to elliptic and parabolic equations.)
1.2. Theorem (53]). Let $1 \leq \lambda<p_{1}<\infty$, and let $T$ be a linear operator simultaneously defined and bounded on $L^{p_{1}}(\tilde{w})$ for all $\tilde{w} \in A_{p_{1} / \lambda}\left(\mathbb{R}^{d}\right)$, with the operator norm dominated by some increasing function of $[\tilde{w}]_{A_{p_{1} / \lambda}}$. Then $T$ is also defined and bounded on $L^{p}(w)$ for all $p \in(\lambda, \infty)$ and all $w \in$ $A_{p / \lambda}\left(\mathbb{R}^{d}\right)$.

In this paper, we provide a variant for extrapolation of compactness: (See Theorems 2.3 and 2.4 in Section 2 for extension to off-diagonal and limited range extrapolation of compactness.)
1.3. Theorem. In the setting of Theorem 1.2, suppose in addition that $T$ is compact on $L^{p_{1}}\left(w_{1}\right)$ for some $w_{1} \in A_{p_{1} / \lambda}\left(\mathbb{R}^{d}\right)$. Then $T$ is compact on $L^{p}(w)$ for all $p \in(\lambda, \infty)$ and all $w \in A_{p / \lambda}\left(\mathbb{R}^{d}\right)$.

When $w_{1} \equiv 1$, Theorem 1.3 says, roughly, that unweighted compactness bootstraps to weighted compactness, if weighted boundedness is already known. This is probably the most relevant case for most applications, like Corollary 7.2 below (see also Sections 811).

The paper is organized as follows: in Section 2 we state Theorems 2.3 and 2.4 which are extensions of Theorem 1.3 . The proofs of these results are presented in Section 3 by collecting some previously known results and taking some auxiliary results for granted. Section 4 is dedicated to the proofs of these auxiliary results (see Propositions 3.2, 3.3 and 3.4). In Sections 510 we provide several applications of our main results. In particular, we obtain previously known results for the commutators of singular integral operators, fractional integrals and a new result for the commutators of Bochner-Riesz multipliers. In Section 11 we develop and apply yet another variant for extrapolation of compactness for a special class of weights related to the commutators of pseudo-differential operators with smooth symbols.

Notation. Throughout the paper, we denote by $C$ a positive constant which is independent of the main parameters but it may change at each occurrence, and we write $f \lesssim g$ if $f \leq C g$. The term cube will always refer to a cube $Q \subset \mathbb{R}^{d}$ and $|Q|$ will denote its Lebesgue measure. Recall from Definition 1.1 that $\langle w\rangle_{Q}$ denotes $|Q|^{-1} \int_{Q} w$, the average of $w$ over $Q$, and $p^{\prime}$ is the conjugate exponent to $p$, that is $p^{\prime}:=p /(p-1)$.

## 2. EXTENSION TO OFF-DIAGONAL AND LIMITED RANGE EXTRAPOLATION OF COMPACTNESS

In this section, we state extrapolation of compactness theorems for operators that are bounded either from $L^{p}$ to $L^{q}$, for possibly different exponents $1<p \leq q<\infty$ or on $L^{p}$, for a limited range of the exponent $p$. For these type of operators the following versions of Rubio de Francia's extrapolation theorems are available:
2.1. Theorem ([38], Harboure-Macías-Segovia). Let $T$ be a linear operator defined and bounded from $L^{p_{1}}\left(\tilde{w}^{p_{1}}\right)$ to $L^{q_{1}}\left(\tilde{w}^{q_{1}}\right)$ for some $1<p_{1} \leq q_{1}<\infty$ and all $\tilde{w} \in A_{p_{1}, q_{1}}\left(\mathbb{R}^{d}\right)$. Then $T$ is also defined and bounded from $L^{p}\left(w^{p}\right)$ to $L^{q}\left(w^{q}\right)$ for all $1<p \leq q<\infty$ such that $\frac{1}{p}-\frac{1}{q}=\frac{1}{p_{1}}-\frac{1}{q_{1}}$ and all $w \in A_{p, q}\left(\mathbb{R}^{d}\right)$.

This applies to the study of the fractional integral operators, also known as the Riesz potentials (see Section 9). A version of Theorem 2.1, with sharp constants is due to Lacey-Moen-Peréz-Torres [47]. A more general version, with sharp constants and including values of $0<q<p$, was given by Duoandikoetxea [30].
2.2. Theorem ([2], Theorem 4.9 of Auscher-Martell). Let $1 \leq p_{-}<p_{+}<$ $\infty$, and let $T$ be a linear operator simultaneously defined and bounded on $L^{p_{1}}(\tilde{w})$ for some $1 \leq p_{-} \leq p_{1} \leq p_{+}<\infty$ and all $\tilde{w} \in A_{p_{1} / p_{-}}\left(\mathbb{R}^{d}\right) \cap$
$R H_{\left(p_{+} / p_{1}\right)^{\prime}}\left(\mathbb{R}^{d}\right)$. Then $T$ is also defined and bounded on $L^{p}(w)$ for all $p \in$ $\left(p_{-}, p_{+}\right)$and all $w \in A_{p / p_{-}}\left(\mathbb{R}^{d}\right) \cap R H_{\left(p_{+} / p\right)^{\prime}}\left(\mathbb{R}^{d}\right)$.

See also [23] where these extrapolation theorems and some others are discussed. In [23], Theorems 2.1 and 2.2 are stated in terms of non-negative, measurable pairs of functions $(f, g)$. The reason is that one does not need to work with specific operators since nothing about the operators themselves is used (like linearity or sublinearity) and they play no role. However, we work with linear operators since an abstract compactness result that we will use in order to prove Theorems [2.3 and 2.4 below holds for linear operators (see Theorem 3.1 of Cwikel-Kalton).

As we will see below, we extend Theorem 1.3 about the extrapolation of compactness to the setting of Theorems 2.1 and 2.2:
2.3. Theorem. In the setting of Theorem [2.1, suppose in addition that $T$ is compact from $L^{p_{1}}\left(w_{1}^{p_{1}}\right)$ to $L^{q_{1}}\left(w_{1}^{q_{1}}\right)$ for some $w_{1} \in A_{p_{1}, q_{1}}\left(\mathbb{R}^{d}\right)$. Then $T$ is compact from $L^{p}\left(w^{p}\right)$ to $L^{q}\left(w^{q}\right)$ for all $1<p \leq q<\infty$ such that $\frac{1}{p}-\frac{1}{q}=\frac{1}{p_{1}}-\frac{1}{q_{1}}$ and all $w \in A_{p, q}\left(\mathbb{R}^{d}\right)$.
2.4. Theorem. In the setting of Theorem 2.2, suppose in addition that $T$ is compact on $L^{p_{1}}\left(w_{1}\right)$ for some $w_{1} \in A_{p_{1} / p_{-}}\left(\mathbb{R}^{d}\right) \cap R H_{\left(p_{+} / p_{1}\right)^{\prime}}\left(\mathbb{R}^{d}\right)$. Then $T$ is compact on $L^{p}(w)$ for all $p \in\left(p_{-}, p_{+}\right)$and all $w \in A_{p / p_{-}}\left(\mathbb{R}^{d}\right) \cap$ $R H_{\left(p_{+} / p\right)^{\prime}}\left(\mathbb{R}^{d}\right)$.
2.5. Remark. Theorems 2.2 and 2.4 remain true in the case $p_{+}=\infty$, provided that $p_{1}<\infty$ in Theorem [2.4. In this case they reduce to Theorems 1.2 and 1.3 and thus the reverse Hölder conditions on $\tilde{w}, w, w_{1}$ are vacuous.

## 3. Auxiliary results; proofs of Theorems [1.3, [2.3] and 2.4

We collect the results from which the proofs of Theorems $1.3,2.3$ and 2.4 follow. Our main abstract tool is the following theorem of Cwikel-Kalton [25]:
3.1. Theorem ([25]). Let $\left(X_{0}, X_{1}\right)$ and $\left(Y_{0}, Y_{1}\right)$ be Banach couples and let $T$ be a linear operator such that $T: X_{0}+X_{1} \rightarrow Y_{0}+Y_{1}$ and $T: X_{j} \rightarrow Y_{j}$ boundedly for $j=0,1$. Suppose moreover that $T: X_{1} \rightarrow Y_{1}$ is compact. Let $[,]_{\theta}$ be the complex interpolation functor of Calderón. Then also $T$ : $\left[X_{0}, X_{1}\right]_{\theta} \rightarrow\left[Y_{0}, Y_{1}\right]_{\theta}$ is compact for $\theta \in(0,1)$ under any of the following four side conditions:
(1) $X_{1}$ has the UMD (unconditional martingale differences) property,
(2) $X_{1}$ is reflexive, and $X_{1}=\left[X_{0}, E\right]_{\alpha}$ for some Banach space $E$ and $\alpha \in(0,1)$,
(3) $Y_{1}=\left[Y_{0}, F\right]_{\beta}$ for some Banach space $F$ and $\beta \in(0,1)$,
(4) $X_{0}$ and $X_{1}$ are both complexified Banach lattices of measurable functions on a common measure space.
(We have swapped the roles of the indices 0 and 1 in comparison to [25]. For the UMD property, see Chapter 4 of [43].) Interestingly, the question whether Theorem 3.1 would remain valid without any side conditions whatsoever seems to remain open; see [26] for a relatively recent discussion. This is not a major concern for the present needs, as we will only use Theorem 3.1 in the following special settings: (Indeed, for these present needs in weighted $L^{p}$ spaces, we could have replaced the use of Theorem 3.1 by a much older result of [9, Sec. 10.4], which gives the same conclusion under yet another side condition about the existence of certain finite dimensional approximate identities in the spaces under investigation. This was kindly pointed to us by Prof. Cwikel.)
3.2. Proposition. Let $\lambda \in[1, \infty)$, let $q, q_{1} \in(\lambda, \infty)$ and $v \in A_{q / \lambda}\left(\mathbb{R}^{d}\right)$, $v_{1} \in A_{q_{1} / \lambda}\left(\mathbb{R}^{d}\right)$. Then

L^{q}(v)=\left[L^{q_{0}}\left(v_{0}\right), L^{q_{1}}\left(v_{1}\right)\right]_{\gamma}
$$

for some $q_{0} \in(\lambda, \infty)$, $v_{0} \in A_{q_{0} / \lambda}\left(\mathbb{R}^{d}\right)$, and $\gamma \in(0,1)$.
3.3. Proposition. Suppose that $1<p \leq q<\infty, 1<p_{1} \leq q_{1}<\infty$ and $v \in A_{p, q}\left(\mathbb{R}^{d}\right), v_{1} \in A_{p_{1}, q_{1}}\left(\mathbb{R}^{d}\right)$. Then

$$
\left[L^{p_{0}}\left(v_{0}^{p_{0}}\right), L^{p_{1}}\left(v_{1}^{p_{1}}\right)\right]_{\gamma}=L^{p}\left(v^{p}\right) \text { and }\left[L^{q_{0}}\left(v_{0}{ }^{q_{0}}\right), L^{q_{1}}\left(v_{1}^{q_{1}}\right)\right]_{\gamma}=L^{q}\left(v^{q}\right)
$$

for some $1<p_{0} \leq q_{0}<\infty, v_{0} \in A_{p_{0}, q_{0}}\left(\mathbb{R}^{d}\right)$, and $\gamma \in(0,1)$. Moreover, if $\frac{1}{p}-\frac{1}{q}=\frac{1}{p_{1}}-\frac{1}{q_{1}}$ we can choose $p_{0}, q_{0}$ in such a way that $\frac{1}{p}-\frac{1}{q}=\frac{1}{p_{0}}-\frac{1}{q_{0}}$.
3.4. Proposition. Suppose that $1 \leq p_{-}<p_{+}<\infty, q_{1} \in\left[p_{-}, p_{+}\right], q \in$ $\left(p_{-}, p_{+}\right)$and

v \in A_{q / p_{-}}\left(\mathbb{R}^{d}\right) \cap R H_{\left(p_{+} / q\right)^{\prime}}\left(\mathbb{R}^{d}\right), \quad v_{1} \in A_{q_{1} / p_{-}}\left(\mathbb{R}^{d}\right) \cap R H_{\left(p_{+} / q_{1}\right)^{\prime}}\left(\mathbb{R}^{d}\right) .
$$

Then

$$
\left[L^{q_{0}}\left(v_{0}\right), L^{q_{1}}\left(v_{1}\right)\right]_{\gamma}=L^{q}(v)
$$

for some $q_{0} \in\left(p_{-}, p_{+}\right)$, $v_{0} \in A_{q_{0} / p_{-}}\left(\mathbb{R}^{d}\right) \cap R H_{\left(p_{+} / q_{0}\right)^{\prime}}\left(\mathbb{R}^{d}\right)$, and $\gamma \in(0,1)$.
We postpone the proofs of Propositions 3.2, 3.3 and 3.4 to the following section. The verifications of these propositions are the only components of the proofs of Theorems $1.3,2.3$ and 2.4 that require actual computations, rather than just a soft application of known results.
3.5. Lemma. If $p_{j} \in[1, \infty)$ and $w_{j}$ are weights, then the spaces $X_{j}=$ $L^{p_{j}}\left(w_{j}\right)$ satisfy the condition (4) of Theorem 3.1.
Proof. It is immediate that both $X_{j}=L^{p_{j}}\left(w_{j}\right), j=0,1$, are complexified Banach lattices of measurable functions on the common measure space $\mathbb{R}^{d}$.
3.6. Remark. If $p_{j}, q_{j} \in(1, \infty)$ and $u_{j}, v_{j}$ are weights, then the condition (11) of Theorem 3.1 is also satisfied by the spaces $X_{j}=L^{p_{j}}\left(u_{j}\right)$ and $Y_{j}=L^{q_{j}}\left(v_{j}\right)$. Indeed, it is well known (see e.g. Proposition 4.2.15 in [43]) that all $L^{p}(\mu)$ spaces with $p \in(1, \infty)$ have the UMD property for any measure $\mu$, so in
particular for the weighted Lebesgue measure. Moreover, in all our concrete applications where the weights belong to appropriate Muckenhoupt classes we could also verify conditions (2) and (3) but we do not give the details here. For example, if $u_{j} \in A_{p_{j} / \lambda}\left(\mathbb{R}^{d}\right)$ then by Proposition 3.2 we could deduce these conditions. Similar considerations could be done in the settings of Propositions 3.3 and 3.4 .

For applications of Theorem 3.1 to these concrete spaces, this is of course more than sufficient. We would only need one of the four side conditions, but in fact we have them all. Indeed, as already mentioned, we could have also verified the much older condition from Section 10.4 in [9] instead of those of Theorem 3.1.

We can now give the proof of our main results:
Proof of Theorem 1.3. Recall that the assumptions, and hence the conclusions, of Theorem 1.2 are in force. In particular, $T$ is a bounded linear operator on $L^{p}(w)$ for all $p \in(\lambda, \infty)$ and all $w \in A_{p / \lambda}\left(\mathbb{R}^{d}\right)$. In addition, it is assumed that $T$ is a compact operator on $L^{p_{1}}\left(w_{1}\right)$ for some $p_{1} \in(\lambda, \infty)$ and some $w_{1} \in A_{p_{1} / \lambda}\left(\mathbb{R}^{d}\right)$. We need to prove that $T$ is actually compact on $L^{p}(w)$ for all $p \in(\lambda, \infty)$ and all $w \in A_{p / \lambda}\left(\mathbb{R}^{d}\right)$. Now, fix some $p \in(\lambda, \infty)$ and $w \in A_{p / \lambda}\left(\mathbb{R}^{d}\right)$. By Proposition 3.2, we have

L^{p}(w)=\left[L^{p_{0}}\left(w_{0}\right), L^{p_{1}}\left(w_{1}\right)\right]_{\theta}
$$

for some $p_{0} \in(\lambda, \infty)$, some $w_{0} \in A_{p_{0} / \lambda}\left(\mathbb{R}^{d}\right)$, and some $\theta \in(0,1)$. Writing $X_{j}=Y_{j}=L^{p_{j}}\left(w_{j}\right)$, we know that $T: X_{0}+X_{1} \rightarrow Y_{0}+Y_{1}$, that $T: X_{j} \rightarrow Y_{j}$ is bounded (since $T$ is bounded on all $L^{q}(w)$ with $q \in(\lambda, \infty)$ and $w \in A_{q / \lambda}\left(\mathbb{R}^{d}\right)$ by Theorem (1.2), and that $T: X_{1} \rightarrow Y_{1}$ is compact (since this was assumed). By Lemma 3.5, the last condition (4) of Theorem 3.1 is also satisfied by these spaces $X_{j}=L^{p_{j}}\left(w_{j}\right)$. By Theorem 3.1, it follows that $T$ is also compact on $\left[X_{0}, X_{1}\right]_{\theta}=\left[Y_{0}, Y_{1}\right]_{\theta}=L^{p}(w)$.

Proof of Theorem 2.3. Recall that the assumptions, and hence the conclusions, of Theorem 2.1 are in force. In particular, $T: L^{p}\left(w^{p}\right) \rightarrow L^{q}\left(w^{q}\right)$ is a bounded linear operator for all $1<p \leq q<\infty$ such that $\frac{1}{p}-\frac{1}{q}=\frac{1}{p_{1}}-\frac{1}{q_{1}}$ and all $w \in A_{p, q}\left(\mathbb{R}^{d}\right)$. In addition, it is assumed that $T: L^{p_{1}}\left(w_{1}^{p_{1}}\right) \rightarrow L^{q_{1}}\left(w_{1}^{q_{1}}\right)$ is a compact operator for some $1<p_{1} \leq q_{1}<\infty$ and some $w_{1} \in A_{p_{1}, q_{1}}\left(\mathbb{R}^{d}\right)$. We need to prove that $T: L^{p}\left(w^{p}\right) \rightarrow L^{q}\left(w^{q}\right)$ is actually compact for all $1<p \leq q<\infty$ such that $\frac{1}{p}-\frac{1}{q}=\frac{1}{p_{1}}-\frac{1}{q_{1}}$ and all $w \in A_{p, q}\left(\mathbb{R}^{d}\right)$. Now, fix some $1<p \leq q<\infty$ and $w \in A_{p, q}\left(\mathbb{R}^{d}\right)$. By Proposition [3.3, we have

L^{p}\left(w^{p}\right)=\left[L^{p_{0}}\left(w_{0}{ }^{p_{0}}\right), L^{p_{1}}\left(w_{1}{ }^{p_{1}}\right)\right]_{\theta} \text { and } L^{q}\left(w^{q}\right)=\left[L^{q_{0}}\left(w_{0}{ }^{q_{0}}\right), L^{q_{1}}\left(w_{1}{ }^{q_{1}}\right)\right]_{\theta}
$$

for some $1<p_{0} \leq q_{0}<\infty$, some $w_{0} \in A_{p_{0}, q_{0}}\left(\mathbb{R}^{d}\right)$, some $\theta \in(0,1)$ and $\frac{1}{p}-\frac{1}{q}=\frac{1}{p_{0}}-\frac{1}{q_{0}}$. Writing $X_{j}=L^{p_{j}}\left(w_{j}^{p_{j}}\right)$ and $Y_{j}=L^{q_{j}}\left(w_{j}^{q_{j}}\right)$, we know that $T: X_{0}+X_{1} \rightarrow Y_{0}+Y_{1}$ and $T: X_{j} \rightarrow Y_{j}$ is bounded $\left(T: L^{\tilde{p}}\left(w^{\tilde{p}}\right) \rightarrow L^{\tilde{q}}\left(w^{\tilde{q}}\right)\right.$ is a bounded linear operator for all $1<\tilde{p} \leq \tilde{q}<\infty$ such that $\frac{1}{\tilde{p}}-\frac{1}{\tilde{q}}=\frac{1}{\hat{p}_{1}}-\frac{1}{\tilde{q}_{1}}$ and
all $w \in A_{\tilde{p}, \tilde{\tilde{q}}}\left(\mathbb{R}^{d}\right)$ by Theorem (2.1), and that $T: X_{1} \rightarrow Y_{1}$ is compact (since this was assumed). By Lemma (3.5, the last condition (4) of Theorem 3.1 is also satisfied by these spaces $X_{j}=L^{p_{j}}\left(w_{j}^{p_{j}}\right)$. By Theorem 3.1, it follows that $T: L^{p}\left(w^{p}\right)=\left[X_{0}, X_{1}\right]_{\theta} \rightarrow L^{q}\left(w^{q}\right)=\left[Y_{0}, Y_{1}\right]_{\theta}$ is also compact.
Proof of Theorem 2.4. Recall that the assumptions, and hence the conclusions, of Theorem 2.2 are in force. In particular, $T$ is a bounded linear operator on $L^{p}(w)$ for all $p \in\left(p_{-}, p_{+}\right)$and all $w \in A_{p / p_{-}}\left(\mathbb{R}^{d}\right) \cap R H_{\left(p_{+} / p\right)^{\prime}}\left(\mathbb{R}^{d}\right)$. In addition, it is assumed that $T$ is a compact operator on $L^{p_{1}}\left(w_{1}\right)$ for some $p_{1} \in\left[p_{-}, p_{+}\right]$and some $w_{1} \in A_{p_{1} / p_{-}}\left(\mathbb{R}^{d}\right) \cap R H_{\left(p_{+} / p_{1}\right)^{\prime}}\left(\mathbb{R}^{d}\right)$. We need to prove that $T$ is actually compact on $L^{p}(w)$ for all $p \in\left(p_{-}, p_{+}\right)$and all $w \in A_{p / p_{-}}\left(\mathbb{R}^{d}\right) \cap R H_{\left(p_{+} / p\right)^{\prime}}\left(\mathbb{R}^{d}\right)$. Now, fix some $p \in\left(p_{-}, p_{+}\right)$and $w \in$ $A_{p / p_{-}}\left(\mathbb{R}^{d}\right) \cap R H_{\left(p_{+} / p\right)^{\prime}}\left(\mathbb{R}^{d}\right)$. By Proposition 3.4, we have

$$
L^{p}(w)=\left[L^{p_{0}}\left(w_{0}\right), L^{p_{1}}\left(w_{1}\right)\right]_{\theta}
$$

for some $p_{0} \in\left(p_{-}, p_{+}\right)$, some $w_{0} \in A_{p_{0} / p_{-}}\left(\mathbb{R}^{d}\right) \cap R H_{\left(p_{+} / p_{0}\right)^{\prime}}\left(\mathbb{R}^{d}\right)$ and some $\theta \in(0,1)$. Writing $X_{j}=Y_{j}=L^{p_{j}}\left(w_{j}\right)$, we know that $T: X_{0}+X_{1} \rightarrow Y_{0}+Y_{1}$, that $T: X_{j} \rightarrow Y_{j}$ is bounded (since $T$ is bounded on all $L^{q}(w)$ with $q \in$ $\left(p_{-}, p_{+}\right) \cup\left\{p_{1}\right\}$ and $w \in A_{q / p_{-}}\left(\mathbb{R}^{d}\right) \cap R H_{\left(p_{+} / q\right)^{\prime}}\left(\mathbb{R}^{d}\right)$ by the assumptions and the conclusion of Theorem (2.2), and also that $T: X_{1} \rightarrow Y_{1}$ is compact (since this was assumed). By Lemma 3.5, the last condition (4) of Theorem 3.1 is also satisfied by these spaces $X_{j}=L^{p_{j}}\left(w_{j}\right)$. By Theorem 3.1, it follows that $T$ is also compact on $\left[X_{0}, X_{1}\right]_{\theta}=\left[Y_{0}, Y_{1}\right]_{\theta}=L^{p}(w)$.

## 4. The Proofs of Propositions 3.2, 3.3 and 3.4

To complete the proofs of Theorems [1.3, 2.3 and 2.4, it remains to verify Propositions 3.2, 3.3 and 3.4 We quote two more classical results:
4.1. Proposition ([32, 33, 44]). The following statements hold:
(1) (Theorem 1.14 in [32]) If $1<p<\infty$, we have $w \in A_{p}\left(\mathbb{R}^{d}\right)$ if and only if $w^{1-p^{\prime}} \in A_{p^{\prime}}\left(\mathbb{R}^{d}\right)$.
(2) (Theorem 2.6 in [32]) If $w \in A_{p}\left(\mathbb{R}^{d}\right), 1<p<\infty$, then there exists $1<q<p$ such that $w \in A_{q}\left(\mathbb{R}^{d}\right)$.
(3) (Lemma 3 in [33]) If $w \in R H_{q}\left(\mathbb{R}^{d}\right), 1<q<\infty$, then there exists $q<p<\infty$ such that $w \in R H_{p}\left(\mathbb{R}^{d}\right)$.
(4) If $w \in A_{p, q}\left(\mathbb{R}^{d}\right)$, for $1<p \leq q<\infty$, then $w^{q} \in A_{1+q / p^{\prime}}\left(\mathbb{R}^{d}\right)$ and $w^{-p^{\prime}} \in A_{1+p^{\prime} / q}\left(\mathbb{R}^{d}\right)$, where $\frac{1}{p}+\frac{1}{p^{\prime}}=1$.
(5) (Statement (P6) in [44) If $1<q, s<\infty$, then $w \in A_{q}\left(\mathbb{R}^{d}\right) \cap$ $R H_{s}\left(\mathbb{R}^{d}\right)$ if and only if $w^{s} \in A_{s(q-1)+1}\left(\mathbb{R}^{d}\right)$.

Proof. We only prove property (4). Notice that $w \in A_{p, q}\left(\mathbb{R}^{d}\right) \Longleftrightarrow w^{q} \in$ $A_{r}\left(\mathbb{R}^{d}\right)$, with $[w]_{A_{p, q}}=\left[w^{q}\right]_{A_{r}}$, where

$$
r:=1+q / p^{\prime}
$$

The proof of $w^{-p^{\prime}} \in A_{1+p^{\prime} / q}\left(\mathbb{R}^{d}\right)$ follows in a similar fashion.
4.2. Theorem ([5, 55]). If $q_{0}, q_{1} \in[1, \infty)$ and $w_{0}, w_{1}$ are two weights, then for all $\theta \in(0,1)$ we have

$$
\left[L^{q_{0}}\left(w_{0}\right), L^{q_{1}}\left(w_{1}\right)\right]_{\theta}=L^{q}(w),
$$

where

$$
\begin{equation*}
\frac{1}{q}=\frac{1-\theta}{q_{0}}+\frac{\theta}{q_{1}} \quad \text { and } \quad w^{\frac{1}{q}}=w_{0}^{\frac{1-\theta}{q_{0}}} w_{1}^{\frac{\theta}{q_{1}}} \tag{4.3}
\end{equation*}
$$

As stated, this can be found in Theorem 5.5.3 of [5], but it is essentially a reformulation of an old theorem of Stein-Weiss 55 that predates the general interpolation theory. In order to connect Theorem4.2 with $A_{p}\left(\mathbb{R}^{d}\right), A_{p, q}\left(\mathbb{R}^{d}\right)$ and $A_{q / p_{-}}\left(\mathbb{R}^{d}\right) \cap R H_{\left(p_{+} / q\right)^{\prime}}\left(\mathbb{R}^{d}\right)$ weights, we need:
4.4. Lemma. Let $\lambda \in[1, \infty), q_{1}, q \in(\lambda, \infty)$, $w_{1} \in A_{q_{1} / \lambda}\left(\mathbb{R}^{d}\right), w \in A_{q / \lambda}\left(\mathbb{R}^{d}\right)$. Then there exist $q_{0} \in(\lambda, \infty)$, $w_{0} \in A_{q_{0} / \lambda}\left(\mathbb{R}^{d}\right)$, and $\theta \in(0,1)$ such that (4.3) holds.

Proof. Note that the choice of $\theta \in(0,1)$ determines both

$$
q_{0}=q_{0}(\theta)=\frac{1-\theta}{\frac{1}{q}-\frac{\theta}{q_{1}}} \quad \text { and } \quad w_{0}=w_{0}(\theta)=w^{\frac{q_{0}}{q(1-\theta)}} w_{1}^{-\frac{q_{0} \cdot \theta}{q_{1}(1-\theta)}},
$$

so it remains to check that we can choose $\theta \in(0,1)$ so that $q_{0} \in(\lambda, \infty)$ and $w_{0} \in A_{q_{0} / \lambda}\left(\mathbb{R}^{d}\right)$. Since $q_{0}(0)=q \in(\lambda, \infty)$, the first condition is obvious for small enough $\theta>0$ by continuity. To simplify writing, we denote $p_{i}:=q_{i} / \lambda$ for $i=0,1$ and $p:=q / \lambda$, and observe that these satisfy the same relations

$$
p_{0}=p_{0}(\theta)=\frac{q_{0}(\theta)}{\lambda}=\frac{1-\theta}{\frac{\lambda}{q}-\frac{\theta \lambda}{q_{1}}}=\frac{1-\theta}{\frac{1}{p}-\frac{\theta}{p_{1}}}
$$

and $p_{0}(0)=p$ as the original exponent $q_{i}$ and $q$.
We need to check that $w_{0} \in A_{p_{0}}\left(\mathbb{R}^{d}\right)$, so we consider a cube $Q$ and write

$$
\begin{aligned}
& \left\langle w_{0}\right\rangle_{Q}\left\langle w_{0}^{-\frac{1}{p_{0}-1}}\right\rangle_{Q}^{p_{0}-1}=\left\langle w^{\frac{p_{0}}{p(1-\theta)}} w_{1}^{-\frac{p_{0} \cdot \theta}{p_{1}(1-\theta)}}\right\rangle_{Q}\left\langle w^{-\frac{p_{0}^{\prime}}{p(1-\theta)}} w_{1}^{\left.\frac{p_{0}^{\prime} \cdot \theta}{p_{1}^{(1-\theta)}}\right\rangle_{Q}^{p_{0}-1}}\right. \\
& =\left\langle w^{\frac{p_{0}}{p(1-\theta)}}\left(w_{1}^{-\frac{1}{p_{1}-1}}\right)^{\frac{p_{0} \cdot \theta}{p_{1}^{(1-\theta)}}}\right\rangle_{Q}\left\langle\left( w^{\left.\left.-\frac{1}{p-1}\right)^{\frac{p_{0}^{\prime}}{p^{\prime}(1-\theta)}} w_{1}^{\frac{p_{0}^{\prime} \cdot \theta}{p_{1}(1-\theta)}}\right\rangle_{Q}^{p_{0}-1},}\right.\right. \text {, }
\end{aligned}
$$

where $u^{\prime}:=u /(u-1)$ denotes the conjugate exponent of $u \in\left\{p, p_{0}, p_{1}\right\}$.
In the first average, we use Hölder's inequality with exponents $1+\varepsilon^{ \pm 1}$, and in the second with exponents $1+\delta^{ \pm 1}$ to get

& \quad \times\left\langle w_{1}^{\frac{p_{0}^{\prime} \theta(1+\delta)}{p_{1} \delta(1-\theta)}}\right\rangle_{Q}^{\frac{\delta\left(p_{0}-1\right)}{1+\delta}}  \tag{4.5}\\
&=\left\langle w^{r(\theta)}\right\rangle_{Q}^{\frac{1}{1+\varepsilon}}\left\langle\left(w_{1}^{-\frac{1}{p_{1}-1}}\right)^{s(\theta)}\right\rangle_{Q}^{\frac{\varepsilon}{1+\varepsilon}}\left\langle\left(w^{-\frac{1}{p-1}}\right)^{t(\theta)}\right\rangle_{Q}^{\frac{p_{0}-1}{1+\delta}} \\
& \quad \times\left\langle w_{1}^{u(\theta)}\right\rangle_{Q}^{\frac{\delta\left(p_{0}-1\right)}{1+\delta}}
\end{align*}
$$

where

$$
r(\theta):=\frac{p_{0}(\theta)(1+\varepsilon)}{p(1-\theta)}, \quad s(\theta):=\frac{\theta p_{0}(\theta)(1+\varepsilon)}{p_{1}^{\prime} \varepsilon(1-\theta)}
$$

and

$$
t(\theta):=\frac{p_{0}^{\prime}(\theta)(1+\delta)}{p^{\prime}(1-\theta)}, \quad u(\theta):=\frac{\theta p_{0}^{\prime}(\theta)(1+\delta)}{p_{1} \delta(1-\theta)}
$$

Now, we choose $\varepsilon=\frac{\theta p}{p_{1}^{\prime}}$ and $\delta=\frac{\theta p^{\prime}}{p_{1}}$ in such a way that

$$
r(\theta)=s(\theta)=\frac{p_{0}(\theta)\left(p_{1}^{\prime}+\theta p\right)}{p p_{1}^{\prime}(1-\theta)}
$$

and

$$
t(\theta)=u(\theta)=\frac{p_{0}(\theta)^{\prime}\left(p_{1}+\theta p^{\prime}\right)}{p^{\prime} p_{1}(1-\theta)}
$$

The strategy to proceed is to use the reverse Hölder inequality for $A_{u}\left(\mathbb{R}^{d}\right)$ weights due to Coifman-Fefferman [18], which says that each $v \in A_{u}\left(\mathbb{R}^{d}\right)$ satisfies

$$
\begin{equation*}
\left\langle v^{t}\right\rangle_{Q}^{1 / t} \lesssim\langle v\rangle_{Q} \tag{4.6}
\end{equation*}
$$

for all $t \leq 1+\eta$, for some $\eta>0$ depending only on $[v]_{A_{u}}$. (For a sharp quantitative version, see Theorem 2.3 in 41.)

Recalling that $p_{0}(0)=p$, we see that $r(0)=s(0)=1$. By continuity, given any $\eta>0$, we find that

$$
\max (r(\theta), s(\theta)) \leq 1+\eta \text { for all small enough } \theta>0
$$

By property (11) of Proposition 4.1 each of the four functions $w \in A_{p}\left(\mathbb{R}^{d}\right)$, $w^{-\frac{1}{p-1}} \in A_{p^{\prime}}\left(\mathbb{R}^{d}\right), w_{1} \in A_{p_{1}}\left(\mathbb{R}^{d}\right)$ and $w_{1}^{-\frac{1}{p_{1}-1}} \in A_{p_{1}^{\prime}}\left(\mathbb{R}^{d}\right)$ satisfies the reverse Hölder inequality (4.6) for all $t \leq 1+\eta$ and for some $\eta>0$. Thus, for all small enough $\theta>0$, we have

\text { (4.5) }) & \lesssim\langle w\rangle_{Q}^{\frac{p_{0}}{p(1-\theta)}}\left\langle w_{1}^{-\frac{1}{p_{1}-1}}\right\rangle_{Q}^{\frac{\theta p_{0}}{p_{1}^{\prime}(1-\theta)}}\left\langle w^{-\frac{1}{p-1}}\right\rangle_{Q}^{\frac{p_{0}^{\prime}\left(p_{0}-1\right)}{p^{\prime}(1-\theta)}}\left\langle w_{1}\right\rangle_{Q}^{\frac{\theta p_{0}^{\prime}\left(p_{0}-1\right)}{p_{1}(1-\theta)}} \\
& =\langle w\rangle_{Q}^{\frac{p_{0}(\theta)}{p(1-\theta)}}\left\langle w_{1}^{-\frac{1}{p_{1}-1}}\right\rangle_{Q}^{\frac{\theta p_{0}(\theta)}{p_{1}^{\prime}(1-\theta)}}\left\langle w^{-\frac{1}{p-1}}\right\rangle_{Q}^{\frac{p_{0}(\theta)}{p^{\prime}(1-\theta)}}\left\langle w_{1}\right\rangle_{Q}^{\frac{\theta p_{0}(\theta)}{p_{1}(1-\theta)}} \\
& =\left(\langle w\rangle_{Q}\left\langle w^{-\frac{1}{p-1}}\right\rangle_{Q}^{p-1}\right)^{\frac{p_{0}(\theta)}{p(1-\theta)}}\left(\left\langle w_{1}\right\rangle_{Q}\left\langle w_{1}^{-\frac{1}{p_{1}-1}}\right\rangle_{Q}^{p_{1}-1}\right)^{\frac{\theta p_{0}(\theta)}{p_{1}(1-\theta)}} \\
& \leq[w]_{A_{p}}^{\frac{p_{1}}{p_{1}-\theta p}}\left[w_{1}\right]_{A_{p_{1}}^{\frac{\theta p}{p_{1}-\theta p}}}
\end{aligned}
$$

In combination with the lines preceding (4.5), we have shown that

$$
\left[w_{0}\right]_{A_{p_{0}}} \lesssim[w]_{A_{p}}^{\frac{p_{1}}{p_{1}-\theta_{p}}}\left[w_{1}\right]_{A_{p_{1}}}^{\frac{\theta p}{p_{1}-\theta_{p}}}<\infty
$$

provided that $\theta>0$ is small enough. This concludes the proof.
4.7. Lemma. Let $1<p_{1} \leq q_{1}<\infty, 1<p \leq q<\infty$, $w_{1} \in A_{p_{1}, q_{1}}\left(\mathbb{R}^{d}\right)$, $w \in A_{p, q}\left(\mathbb{R}^{d}\right)$. Then there exist $1<p_{0} \leq q_{0}<\infty$, $w_{0} \in A_{p_{0}, q_{0}}\left(\mathbb{R}^{d}\right)$, and $\theta \in(0,1)$ such that the conclusion of Theorem 4.2 holds, i.e.,

\left[L^{p_{0}}\left(w_{0}^{p_{0}}\right), L^{p_{1}}\left(w_{1}^{p_{1}}\right)\right]_{\theta}=L^{p}\left(w^{p}\right), \quad\left[L^{q_{0}}\left(w_{0}^{q_{0}}\right), L^{q_{1}}\left(w_{1}^{q_{1}}\right)\right]_{\theta}=L^{q}\left(w^{q}\right)
$$

where

$$
\frac{1}{p}=\frac{1-\theta}{p_{0}}+\frac{\theta}{p_{1}}, \quad \frac{1}{q}=\frac{1-\theta}{q_{0}}+\frac{\theta}{q_{1}}, \quad w=w_{0}^{1-\theta} w_{1}^{\theta}
$$

Proof. Note that the choice of $\theta \in(0,1)$ determines

$$
p_{0}=p_{0}(\theta)=\frac{1-\theta}{\frac{1}{p}-\frac{\theta}{p_{1}}}, \quad q_{0}=q_{0}(\theta)=\frac{1-\theta}{\frac{1}{q}-\frac{\theta}{q_{1}}}, \quad w_{0}=w_{0}(\theta)=w^{\frac{1}{1-\theta}} w_{1}^{-\frac{\theta}{1-\theta}}
$$

so it remains to check that we can choose $\theta \in(0,1)$ so that $1<p_{0} \leq q_{0}<\infty$ and $w_{0} \in A_{p_{0}, q_{0}}\left(\mathbb{R}^{d}\right)$. Since $1<p_{0}(0)=p \leq q=q_{0}(0)<\infty$, the first condition is obvious for small enough $\theta>0$ by continuity.

We need to check that $w_{0} \in A_{p_{0}, q_{0}}\left(\mathbb{R}^{d}\right)$, so we consider a cube $Q$ and write

$$
\left\langle w_{0}^{q_{0}}\right\rangle_{Q}^{\frac{1}{q_{0}}}\left\langle w_{0}^{-p_{0}^{\prime}}\right\rangle_{Q}^{\frac{1}{p_{0}^{\prime}}}=\left\langle w^{\frac{q_{0}}{1-\theta}} w_{1}^{-\frac{q_{0} \cdot \theta}{1-\theta}}\right\rangle_{Q}^{\frac{1}{q_{0}}}\left\langle w^{-\frac{p_{0}^{\prime}}{1-\theta}} w_{1}^{\frac{p_{0}^{\prime} \cdot \theta}{1-\theta}}\right\rangle_{Q}^{\frac{1}{p_{0}^{\prime}}}
$$

where $p_{0}^{\prime}:=p_{0} /\left(p_{0}-1\right)$ denotes the conjugate exponent of $p_{0}$.
In the first average, we use Hölder's inequality with exponents $1+\varepsilon^{ \pm 1}$, and in the second with exponents $1+\delta^{ \pm 1}$ to get

& =\left\langle\left(w^{q}\right)^{r(\theta)}\right\rangle_{Q}^{\frac{1}{q_{0}(1+\varepsilon)}}\left\langle\left(w_{1}^{-p_{1}^{\prime}}\right)^{s(\theta)}\right\rangle_{Q}^{\frac{\varepsilon}{q_{0}(1+\varepsilon)}} \\
& \quad \times\left\langle\left(w^{-p^{\prime}}\right)^{t(\theta)}\right\rangle_{Q}^{\frac{1}{p_{0}^{\prime}(1+\delta)}}\left\langle\left(w_{1}^{q_{1}}\right)^{u(\theta)}\right\rangle_{Q}^{\frac{\delta}{p_{0}^{\prime}(1+\delta)}}
\end{align*}
$$

where

$$
r(\theta):=\frac{q_{0}(\theta)(1+\varepsilon)}{q(1-\theta)}, \quad s(\theta):=\frac{\theta q_{0}(\theta)(1+\varepsilon)}{p_{1}^{\prime} \varepsilon(1-\theta)}
$$

and

$$
t(\theta):=\frac{p_{0}^{\prime}(\theta)(1+\delta)}{p^{\prime}(1-\theta)}, \quad u(\theta):=\frac{\theta p_{0}(\theta)^{\prime}(1+\delta)}{q_{1} \delta(1-\theta)} .
$$

Now, we choose $\varepsilon=\frac{\theta q}{p_{1}^{\prime}}$ and $\delta=\frac{\theta p^{\prime}}{q_{1}}$ in such a way that

r(\theta)=s(\theta)=\frac{q_{0}(\theta)\left(p_{1}^{\prime}+\theta q\right)}{q p_{1}^{\prime}(1-\theta)}
$$

and

t(\theta)=u(\theta)=\frac{p_{0}^{\prime}(\theta)\left(q_{1}+\theta p^{\prime}\right)}{q_{1} p^{\prime}(1-\theta)}
$$

The strategy to proceed is the same as in the proof of Lemma 4.4. In particular, we use the reverse Hölder inequality (4.6) for $A_{v}\left(\mathbb{R}^{d}\right)$ weights. Recalling that $p_{0}(0)=p$ and $q_{0}(0)=q$, we see that $r(0)=t(0)=1$. By continuity, given any $\eta>0$, we find that

Recalling that $q_{0}(0)=q$, we see that $\tilde{r}(0)=\tilde{t}(0)=1$. By continuity, given any $\eta>0$, we find that

$$
\max (\tilde{r}(\theta), \tilde{t}(\theta)) \leq 1+\eta \text { for all small enough } \theta>0
$$

By property (1) of Proposition 4.1 each of the three functions $w^{\left(p_{+} / q\right)^{\prime}} \in$ $A_{s}\left(\mathbb{R}^{d}\right), w^{\left(p_{+} / q\right)^{\prime}\left(-\frac{1}{s-1}\right)} \in A_{s^{\prime}}\left(\mathbb{R}^{d}\right)$ and $w_{1}^{-\frac{1}{p_{ \pm}}{ }^{\frac{p_{-}}{-1}}} \in A_{\left(p_{+} / p_{-}\right)^{\prime}}\left(\mathbb{R}^{d}\right)$ satisfies the reverse Hölder inequality (4.6) for all $t \leq 1+\eta$ and for some $\eta>0$. Thus, for all small enough $\theta>0$, we have

$$
\begin{aligned}
& \text { (4.12) } \lesssim\left\langle w^{\left(p_{+} / q\right)^{\prime}}\right\rangle_{Q}^{\frac{q_{0}\left(p_{+}-q\right)}{q(1-\theta)\left(p_{+}-q_{0}\right)}}\left\langle w_{1}^{-\frac{1}{p_{+}} p_{-}-1}\right\rangle_{Q}^{\frac{\theta q_{0}\left(p_{+}-p_{-}\right)}{p_{-}(1-\theta)\left(p_{+}-q_{0}\right)}} \\
& \times\left\langle w^{\left(p_{+} / q\right)^{\prime}\left(-\frac{1}{s-1}\right)}\right\rangle_{Q}^{\frac{q_{0}\left(p_{+}-q\right)(s-1)}{q(1-\theta)\left(p_{+}-q_{0}\right)}}\left\|w_{1}\right\|_{L^{\infty}(Q)}^{\frac{\theta q_{0}}{(1-\theta)\left(p_{+}-q_{0}\right)}} \\
& =\left(\left\langle w^{\left(p_{+} / q\right)^{\prime}}\right\rangle_{Q}\left\langle w^{\left(p_{+} / q\right)^{\prime}\left(-\frac{1}{s-1}\right)}\right\rangle_{Q}^{s-1}\right)^{\frac{q_{0}\left(p_{+}-q\right)}{q(1-\theta)\left(p_{+}-q_{0}\right)}} \\
& \times\left(\left\|w_{1}\right\|_{L^{\infty}(Q)}\left\langle w_{1}^{-\frac{1}{p_{+}}{ }^{p_{-}-1}}\right\rangle_{Q}^{\frac{p_{+}}{p_{-}-1}}\right)^{\frac{\theta q_{0}}{(1-\theta)\left(p_{+}-q_{0}\right)}} \\
& \leq\left[w^{\left(p_{+} / q\right)^{\prime}}\right]_{A_{s}}\left(\left[w_{1}\right]_{R H_{\infty}}\left[w_{1}\right]_{\frac{p_{+}}{p_{-}}}\right)^{\frac{\theta q}{p_{+}-q}} .
\end{aligned}
$$

In combination with the lines preceding (4.12), we have shown that

$$
\left[w_{0}^{\left(p_{+} / q_{0}\right)^{\prime}}\right]_{A_{s_{0}}} \lesssim\left[w^{\left(p_{+} / q\right)^{\prime}}\right]_{A_{s}}\left(\left[w_{1}\right]_{R H_{\infty}}\left[w_{1}\right]_{\frac{p_{+}}{p_{-}}}{ }^{\frac{\theta q}{p_{+}-q}}<\infty,\right.
$$

provided that $\theta>0$ is small enough. This concludes the proof in the case $q_{1}=p_{+}$.
4.13. Remark. Lemma 4.9 remains true in the case $p_{+}=\infty$, provided that $q_{1}<\infty$. In this case the reverse Hölder conditions on $w, w_{0}, w_{1}$ are vacuous and the proof is the same as in Lemma 4.4.

We now have the last missing ingredients of the proofs of Theorems 1.3 , 2.3 and 2.4:

Proof of Proposition 3.2. With some $\lambda \in[1, \infty)$, we are given $q, q_{1} \in(\lambda, \infty)$ and weights $v \in A_{q / \lambda}\left(\mathbb{R}^{d}\right), v_{1} \in A_{q_{1} / \lambda}\left(\mathbb{R}^{d}\right)$. By Lemma 4.4, there is some $q_{0} \in(\lambda, \infty)$, a weight $v_{0} \in A_{q_{0} / \lambda}\left(\mathbb{R}^{d}\right)$, and $\theta \in(0,1)$ such that

$$
\frac{1}{q}=\frac{1-\theta}{q_{0}}+\frac{\theta}{q_{1}}, \quad v^{\frac{1}{q}}=v_{0}^{\frac{1-\theta}{q_{0}}} v_{1}^{\frac{\theta}{q_{1}}} .
$$

By Theorem4.2, we then have $L^{q}(v)=\left[L^{q_{0}}\left(v_{0}\right), L^{q_{1}}\left(v_{1}\right)\right]_{\theta}$, as we claimed.

Proof of Proposition 3.3. We are given $1<p \leq q<\infty, 1<p_{1} \leq q_{1}<\infty$, and weights $v \in A_{p, q}\left(\mathbb{R}^{d}\right), v_{1} \in A_{p_{1}, q_{1}}\left(\mathbb{R}^{d}\right)$. By Lemma 4.7, there is some $1<p_{0} \leq q_{0}<\infty$, a weight $v_{0} \in A_{p_{0}, q_{0}}\left(\mathbb{R}^{d}\right)$, and $\theta \in(0,1)$ such that

$$
\begin{equation*}
\frac{1}{p}=\frac{1-\theta}{p_{0}}+\frac{\theta}{p_{1}}, \quad \frac{1}{q}=\frac{1-\theta}{q_{0}}+\frac{\theta}{q_{1}}, \quad v=v_{0}^{1-\theta} v_{1}^{\theta} . \tag{4.14}
\end{equation*}
$$

By Theorem 4.2, we then have

$$
\left[L^{p_{0}}\left(v_{0}^{p_{0}}\right), L^{p_{1}}\left(v_{1}^{p_{1}}\right)\right]_{\theta}=L^{p}\left(v^{p}\right) \text { and }\left[L^{q_{0}}\left(v_{0}^{q_{0}}\right), L^{q_{1}}\left(v_{1}^{q_{1}}\right)\right]_{\theta}=L^{q}\left(v^{q}\right) .
$$

Moreover, by (4.14) the claim of the proposition follows.
Proof of Proposition 3.4. We are given $1 \leq p_{-}<p_{+}<\infty, q_{1} \in\left[p_{-}, p_{+}\right]$, $q \in\left(p_{-}, p_{+}\right)$and weights $v \in A_{q / p_{-}}\left(\mathbb{R}^{d}\right) \cap R H_{\left(p_{+} / q\right)^{\prime}}\left(\mathbb{R}^{d}\right), v_{1} \in A_{q_{1} / p_{-}}\left(\mathbb{R}^{d}\right) \cap$ $R H_{\left(p_{+} / q_{1}\right)^{\prime}}\left(\mathbb{R}^{d}\right)$. By Lemma 4.9, there is some $q_{0} \in\left(p_{-}, p_{+}\right)$, a weight $v_{0} \in$ $A_{q_{0} / p_{-}}\left(\mathbb{R}^{d}\right) \cap R H_{\left(p_{+} / q_{0}\right)^{\prime}}\left(\mathbb{R}^{d}\right)$, and $\theta \in(0,1)$ such that

$$
\frac{1}{q}=\frac{1-\theta}{q_{0}}+\frac{\theta}{q_{1}}, \quad v^{\frac{1}{q}}=v_{0}^{\frac{1-\theta}{q_{0}}} v_{1}^{\frac{\theta}{q_{1}}} .
$$

By Theorem4.2, we then have $L^{q}(v)=\left[L^{q_{0}}\left(v_{0}\right), L^{q_{1}}\left(v_{1}\right)\right]_{\theta}$, as we claimed.

## 5. Calderón-Zygmund singular integrals

In two applications below, we consider Calderón-Zygmund singular integral operators, or just Calderón-Zygmund operators for short, which are defined as follows: $T$ is a linear operator defined on a suitable class of test functions on $\mathbb{R}^{d}$, and it has the representation

$$
T f(x)=\int_{\mathbb{R}^{d}} K(x, y) f(y) \mathrm{d} y, \quad x \notin \operatorname{supp} f
$$

where the kernel $K$ satisfies the standard estimates

$$
|K(x, y)| \lesssim \frac{1}{|x-y|^{d}}
$$

and, for some $\delta \in(0,1]$,

$$
\left|K(x, y)-K\left(x^{\prime}, y\right)\right|+\left|K(y, x)-K\left(y, x^{\prime}\right)\right| \lesssim \frac{\left|x-x^{\prime}\right|^{\delta}}{|x-y|^{d+\delta}}
$$

for all $x, x^{\prime}, y \in \mathbb{R}^{d}$ such that $|x-y|>\frac{1}{2}\left|x-x^{\prime}\right|$.
In our applications of Theorem 1.3 to these operators, we never need to refer to the above definition; rather, we can apply several previous results for these operators as a black box. For our first application, we only need the following classical result of Coifman-Fefferman [18]. (See [49] for a modern approach that also gives the sharp dependence on $[w]_{A_{p}}$ from [40].)
5.1. Theorem ([18). Let $T$ be a Calderón-Zygmund operator that extends to a bounded operator on $L^{2}\left(\mathbb{R}^{d}\right)$. Then $T$ extends to a bounded operator on $L^{p}(w)$ for all $p \in(1, \infty)$ and all $w \in A_{p}\left(\mathbb{R}^{d}\right)$.

We can now give a quick proof and a minor extension of a very recent result of Stockdale-Villarroya-Wick [56, which deals with $p_{1}=2$ and $w_{1} \equiv 1$ :
5.2. Corollary ([56], Theorem 1.1). Let $T$ be a Calderón-Zygmund operator that extends compactly to $L^{p_{1}}\left(w_{1}\right)$ for some $p_{1} \in(1, \infty)$ and some $w_{1} \in$ $A_{p_{1}}\left(\mathbb{R}^{d}\right)$. Then $T$ extends to a compact operator on $L^{p}(w)$ for all $p \in(1, \infty)$ and all $w \in A_{p}\left(\mathbb{R}^{d}\right)$.
Proof. We verify the assumptions of Theorem 1.3 for $\lambda=1$, and the exponent $p_{1}$ and weight $w_{1}$ appearing in the statement of the Corollary: By Theorem 5.1. $T$ extends to a bounded operator on $L^{p_{1}}(\tilde{w})$ for all $\tilde{w} \in A_{p_{1}}\left(\mathbb{R}^{d}\right)$. By assumption, $T$ is compact on $L^{p_{1}}\left(w_{1}\right)$ for some $w_{1} \in A_{p_{1}}\left(\mathbb{R}^{d}\right)$. Thus Theorem 1.3 applies to give the compactness of $T$ on $L^{p}(w)$ for all $p \in(1, \infty)$ and all $w \in A_{p}\left(\mathbb{R}^{d}\right)$.

The proof in [56] was based on two quite recent ingredients: the technique of sparse domination of Calderón-Zygmund operators, which was essentially started by Lerner [49] and thereafter extensively developed by many authors, together with a characterisation of compactness of Calderón-Zygmund operators due to Villarroya [60]. We avoid all this.

## 6. Commutators with functions of bounded mean oscillation

Our several subsequent applications of Theorem 1.3 deal with commutators of the form

$$
[b, T]: f \mapsto b T(f)-T(b f),
$$

where the pointwise multiplier $b$ belongs to the space

$$
\operatorname{BMO}\left(\mathbb{R}^{d}\right):=\left\{f: \mathbb{R}^{d} \rightarrow \mathbb{C} \mid\|f\|_{\text {Вмо }}:=\sup _{Q}\langle | f-\langle f\rangle_{Q}| \rangle_{Q}<\infty\right\}
$$

of functions of bounded mean oscillation, or its subspace

$$
\operatorname{CMO}\left(\mathbb{R}^{d}\right):={\overline{C_{c}^{\infty}\left(\mathbb{R}^{d}\right)}}^{\mathrm{BMO}\left(\mathbb{R}^{d}\right)},
$$

where the closure in the BMO norm. This subspace is also denoted by $\mathrm{VMO}\left(\mathbb{R}^{d}\right)$ in some papers; however, a distinction between the two notions is made in [6]. There appears to be some confusion about these spaces in the literature, resulting from the fact that not all "natural" definitions lead to the same space.

A powerful general result about commutators is due to Álvarez et al. [1:
6.1. Theorem (1). In the setting of Theorem 1.2, suppose also that $b \in$ $\operatorname{BMO}\left(\mathbb{R}^{d}\right)$. Then also $[b, T]$ extends to a bounded linear operator on $L^{p_{1}}(\tilde{w})$ for all $\tilde{w} \in A_{p_{1} / \lambda}\left(\mathbb{R}^{d}\right)$, and its operator norm is dominated by another increasing function of $[\tilde{w}]_{A_{p_{1} / \lambda}}$.

The statement in Theorem 2.13 of [1] is somewhat more general, but the above particular case is easily seen to be contained in it. In fact, the idea
behind this general theorem is already implicit in the work of Coifman-Rochberg-Weiss [20], which deals with the case of Calderón-Zygmund operators. See also [16] for a sharp quantitative version, and [4] for an up-to-date treatment of this type of results.

A combination of Theorems 1.3 and 6.1 immediately gives:
6.2. Corollary. Let $1 \leq \lambda<p_{1}<\infty$, and let $T$ be a linear operator defined and bounded on $L^{p_{1}}(\tilde{w})$ for all $\tilde{w} \in A_{p_{1} / \lambda}\left(\mathbb{R}^{d}\right)$, with the operator norm dominated by some increasing function of $[\tilde{w}]_{A_{p_{1} / \lambda}}$. Suppose moreover that the commutator $[b, T]$ is compact on $L^{p_{1}}\left(w_{1}\right)$ for some $b \in \operatorname{BMO}\left(\mathbb{R}^{d}\right)$ and some $w_{1} \in A_{p_{1} / \lambda}\left(\mathbb{R}^{d}\right)$. Then $[b, T]$ is compact for the same $b$, and for all $p \in(\lambda, \infty)$ and all $w \in A_{p / \lambda}\left(\mathbb{R}^{d}\right)$.
Proof. We verify the assumptions of Theorem 1.3 for the numbers $\lambda, p_{1}$ and the weight $w_{1}$ appearing in the statement of the Corollary, and the operator $[b, T]$ in place of $T$. By Theorem [6.1, $[b, T]$ is bounded on $L^{p_{1}}(\tilde{w})$ for all $\tilde{w} \in A_{p_{1} / \lambda}\left(\mathbb{R}^{d}\right)$. By assumption, $[b, T]$ is compact on $L^{p_{1}}\left(w_{1}\right)$ for some $w_{1} \in$ $A_{p_{1} / \lambda}\left(\mathbb{R}^{d}\right)$. Thus the assumptions, and hence the conclusion, of Theorem 1.3 hold for the operator $[b, T]$ in place of $T$, and this is what we claimed.

## 7. Commutators of Calderón-Zygmund operators

The following result of Uchiyama [59], based on a classical Fréchet-Kolmogorov criterion for compactness in $L^{p}\left(\mathbb{R}^{d}\right)$, provides a concrete condition to verify the assumptions of Corollary 6.2:
7.1. Theorem (59]). Let $T$ be a Calderón-Zygmund operator that extends to a bounded operator on $L^{2}\left(\mathbb{R}^{d}\right)$. If $b \in \operatorname{CMO}\left(\mathbb{R}^{d}\right)$, then $[b, T]$ is compact on the unweighted $L^{p}\left(\mathbb{R}^{d}\right)$ for all $p \in(1, \infty)$.

Our next application of Theorem 1.3 (via Corollary 6.2) is a quick proof of the following result of Clop-Cruz [17], which they used to obtain weighted estimates for Beltrami equations. This result has also inspired a fair number of follow-up works dealing with the compactness of commutators in different settings, and we refer the reader to the several papers citing [17] for this.
7.2. Corollary ([17, Theorem 2). Let $b \in \operatorname{CMO}\left(\mathbb{R}^{d}\right)$, and let $T$ be a Calderón $-Z y g m u n d ~ o p e r a t o r ~ t h a t ~ e x t e n d s ~ b o u n d e d l y ~ t o ~ L^{2}\left(\mathbb{R}^{d}\right)$. Then the commutator $[b, T]$ is compact on $L^{p}(w)$ for all $p \in(1, \infty)$ and all $w \in A_{p}\left(\mathbb{R}^{d}\right)$.
Proof. Let us fix some $p_{1} \in(1, \infty)$ (any choice will do) for which we verify the assumptions of Corollary 6.2 with $\lambda=1$. By Theorem 5.1 $T$ extends to a bounded operator on $L^{p_{1}}(\tilde{w})$ for all $\tilde{w} \in A_{p_{1}}\left(\mathbb{R}^{d}\right)$. By Theorem 7.1, $[b, T]$ is a compact operator on $L^{p_{1}}\left(\mathbb{R}^{d}\right)=L^{p_{1}}\left(w_{1}\right)$ with $w_{1} \equiv 1 \in A_{p_{1}}\left(\mathbb{R}^{d}\right)$. Thus Corollary 6.2 applies to give the compactness of $[b, T]$ on $L^{p}(w)$ for all $p \in(1, \infty)$ and all $w \in A_{p}\left(\mathbb{R}^{d}\right)$.

The original proof in [17 relied on finding and verifying a weighted analogue of the classical (unweighted) Fréchet-Kolmogorov criterion, providing
a sufficient condition for compactness in $L^{p}(w)$. This is avoided by the soft argument above.
7.3. Remark. Corollary 7.2 is in particular valid for pseudo-differential operators with symbol of class $S_{1,0}^{0}$, namely (denoting by $\hat{f}$ the Fourier transform of $f$ )
$T f(x)=\int_{\mathbb{R}^{d}} \sigma(x, \xi) \hat{f}(\xi) e^{i 2 \pi x \cdot \xi} \mathrm{~d} \xi, \quad\left|\partial_{x}^{\alpha} \partial_{\xi}^{\beta} \sigma(x, \xi)\right| \lesssim(1+|\xi|)^{-|\beta|} \forall \alpha, \beta \in \mathbb{N}^{d}$,
as these are instances of Calderón-Zygmund operators by Théorème 19 in [19]. For these $T$, Corollary 7.2 is also obtained by Guo-Zhou [37] as a corollary to Theorem 2.1 in [37], which allows a certain larger weight class $A_{p}(\varphi)$ introduced by Tang [57]. Recovering Theorem 2.1 in [37] by our approach requires its extension to $A_{p}(\varphi)$ in place of $A_{p}\left(\mathbb{R}^{d}\right)$. We refer to Section 11 for detailed results concerning extrapolation with $A_{p}(\varphi)$ weights.

## 8. Commutators of rough singular integrals

Let us now consider

$$
T_{\Omega} f(x):=\lim _{\varepsilon \rightarrow 0} \int_{|x-y|>\varepsilon} \frac{\Omega(x-y)}{|x-y|^{d}} f(y) \mathrm{d} y,
$$

where $\Omega$ is homogeneous of order zero, and integrable with vanishing mean on the unit sphere $S^{d-1}$. There are the following analogues of Theorems 5.1 and 7.1:
8.1. Theorem ([28, 62]). Let $r \in(1, \infty)$ and let $\Omega \in L^{r}\left(S^{d-1}\right)$ be homogeneous of order zero with vanishing mean on $S^{d-1}$. Then $T_{\Omega}$ extends to a bounded operator on $L^{p}(w)$ for all $p \in\left(r^{\prime}, \infty\right)$ and all $w \in A_{p / r^{\prime}}\left(\mathbb{R}^{d}\right)$.

Here and below, $r^{\prime}:=r /(r-1)$ denotes the conjugate exponent.
8.2. Theorem ([14, 34]). Let $\Omega$ be homogeneous of order zero, and integrable with vanishing mean on $S^{d-1}$. Let $b \in \operatorname{CMO}\left(\mathbb{R}^{d}\right)$. Then the commutator $\left[b, T_{\Omega}\right]$ acts as a compact operator
(1) on the unweighted $L^{p}\left(\mathbb{R}^{d}\right)$ for all $p \in\left(\theta^{\prime}, \theta\right)$, provided that $\theta>2$ and

$$
\sup _{\zeta \in S^{d-1}} \int_{S^{d-1}}|\Omega(\eta)|\left(\log \frac{1}{|\zeta \cdot \eta|}\right)^{\theta} \mathrm{d} \eta<\infty
$$

(2) on the power-weighted $L^{p}\left(w_{\gamma}\right)$ for all $p \in(1, \infty)$ and $\gamma \in(-1, p-1)$, where $w_{\gamma}(x)=|x|^{\gamma}$, provided that $\Omega \in L(\log L)^{2}\left(S^{d-1}\right)$ [34].

A combination of Corollary 6.2 and Theorem 8.1 together with either version (11) or (2) of Theorem 8.2, gives a recent result of Guo-Hu [35]:
8.3. Corollary (35). Let $r \in(1, \infty)$ and let $\Omega \in L^{r}\left(S^{d-1}\right)$ be homogeneous of order zero with vanishing mean on $S^{d-1}$. Let $b \in \operatorname{CMO}\left(\mathbb{R}^{d}\right)$. Then the commutator $\left[b, T_{\Omega}\right]$ is compact on $L^{p}(w)$ for all $p \in\left(r^{\prime}, \infty\right)$ and all $w \in$ $A_{p / r^{\prime}}\left(\mathbb{R}^{d}\right)$.
8.4. Remark. Both Theorem 8.1 and Corollary 8.3 also hold for $r=\infty$ : Of course $L^{\infty}\left(S^{d-1}\right) \subset L^{r}\left(S^{d-1}\right)$ for all $r \in(1, \infty)$, while if $w \in A_{p}\left(\mathbb{R}^{d}\right)$, then also $w \in A_{p / r^{\prime}}\left(\mathbb{R}^{d}\right)$ for large $r \in(1, \infty)$ by the openness of the $A_{p}\left(\mathbb{R}^{d}\right)$ condition from [18]. See 42 for a quantitative version of Theorem 8.1 with $r=\infty$.

Proof of Corollary 8.3. We verify the assumptions of Corollary 6.2 with $\lambda=$ $r^{\prime}$, a suitable $p_{1} \in\left(r^{\prime}, \infty\right)$ to be specified shortly, and $w_{1} \equiv 1 \in A_{p_{1} / r^{\prime}}\left(\mathbb{R}^{d}\right)$. It is clear that $\Omega \in L^{r}\left(S^{d-1}\right)$ satisfies both conditions (1) (with any $\theta \in(2, \infty)$ ) and (2) of Theorem8.2. If we wish to apply (1), we choose $\theta$ sufficiently large so that $\left(\theta^{\prime}, \theta\right) \cap\left(r^{\prime}, \infty\right) \neq \varnothing$, and then we pick $p_{1}$ from this intersection. If we wish to apply (2) instead, then we are free to pick any $p_{1} \in(1, \infty)$. In either case, the relevant version of Theorem 8.2 guarantees that $\left[b, T_{\Omega}\right]$ is compact on $L^{p_{1}}\left(w_{1}\right)$ for the particular exponent $p_{1} \in\left(r^{\prime}, \infty\right)$ and weight $w_{1} \equiv 1 \in A_{p_{1} / r^{\prime}}\left(\mathbb{R}^{d}\right)$; in case (2), we use $\gamma=0$. On the other hand, a direct application of Theorem 8.1 shows that $T_{\Omega}$ is bounded on $L^{p_{1}}(\tilde{w})$ for all $\tilde{w} \in A_{p_{1} / r^{\prime}}\left(\mathbb{R}^{d}\right)$. Thus Corollary 6.2 applies to give the compactness of $\left[b, T_{\Omega}\right]$ on $L^{p}(w)$ for all $p \in\left(r^{\prime}, \infty\right)$ and all $w \in A_{p / r^{\prime}}\left(\mathbb{R}^{d}\right)$.

## 9. Commutators of fractional integral operators

In this section we will apply Theorem 2.3 to the commutator $\left[b, I_{\alpha}\right]$, where for $0<\alpha<d$, the fractional integral operator or Riesz potential $I_{\alpha}$ is defined by

$$
I_{\alpha} f(x)=\int_{\mathbb{R}^{d}} \frac{f(y)}{|x-y|^{d-\alpha}} d y
$$

The weighted norm inequalities for $I_{\alpha}$ were obtained by MuckenhouptWheeden 52 and the sharp behavior in terms of the weight constants by Lacey-Moen-Pérez-Torres 47]. The commutators of fractional integral operators and BMO functions were first studied by Chanillo [13]. In [54], Segovia-Torrea obtained the following weighted commutator result (see Cruz-Uribe and Moen [24] for a sharp quantitative version):
9.1. Theorem ([54]). Fix $0<\alpha<d, 1<p<d / \alpha$, and $1 / p-1 / q=\alpha / d$. Suppose also that $b \in \operatorname{BMO}\left(\mathbb{R}^{d}\right)$. Then $\left[b, I_{\alpha}\right]: L^{p}\left(w^{p}\right) \rightarrow L^{q}\left(w^{q}\right)$ is a bounded linear operator for all $w \in A_{p, q}\left(\mathbb{R}^{d}\right)$.

For the application of our Theorem 2.3 we need the following result of Wang [61] about the compactness of the commutator $\left[b, I_{\alpha}\right]$ :
9.2. Theorem $(6 \underline{61})$. If $b \in \operatorname{CMO}\left(\mathbb{R}^{d}\right)$, then $\left[b, I_{\alpha}\right]: L^{p}\left(\mathbb{R}^{d}\right) \rightarrow L^{q}\left(\mathbb{R}^{d}\right)$ is a compact operator, where $0<\alpha<d, 1<p<d / \alpha$, and $1 / p-1 / q=\alpha / d$.

A combination of Theorems 2.3, 9.1 and 9.2 immediately gives a quick proof of the following recent result of $\mathrm{Wu}-$ Yang [63]:
9.3. Corollary ([63], Theorem 1.3). Let $\alpha \in(0, d), p, q \in(1, \infty)$ with $\frac{1}{p}=$ $\frac{1}{q}+\frac{\alpha}{d}, w \in A_{p, q}\left(\mathbb{R}^{d}\right)$ and $b \in \operatorname{CMO}\left(\mathbb{R}^{d}\right)$. Then the commutator $\left[b, I_{\alpha}\right]$ is compact from $L^{p}\left(w^{p}\right)$ to $L^{q}\left(w^{q}\right)$.

Proof. Let us fix some $p_{1}, q_{1} \in(1, \infty)$ for which we verify the assumptions of Theorem 2.3 for $\left[b, I_{\alpha}\right]$ in place of $T$ : By Theorem $9.1,\left[b, I_{\alpha}\right]$ is a bounded operator from $L^{p_{1}}\left(\tilde{w}^{p_{1}}\right)$ to $L^{q_{1}}\left(\tilde{w}^{q_{1}}\right)$ for all $1<p_{1} \leq q_{1}<\infty$ such that $\frac{1}{p}-\frac{1}{q}=\frac{1}{p_{1}}-\frac{1}{q_{1}}=\frac{\alpha}{d}$ and all $\tilde{w} \in A_{p_{1}, q_{1}}\left(\mathbb{R}^{d}\right)$. By Theorem $9.2,\left[b, I_{\alpha}\right]$ is a compact operator from $L^{p_{1}}\left(\mathbb{R}^{d}\right)=L^{p_{1}}\left(w_{1}^{p_{1}}\right)$ to $L^{q_{1}}\left(\mathbb{R}^{d}\right)=L^{q_{1}}\left(w_{1}^{q_{1}}\right)$ with $w_{1} \equiv 1 \in A_{p_{1}, q_{1}}\left(\mathbb{R}^{d}\right)$. Thus the assumptions, and hence the conclusion, of Theorem [2.3 hold for the operator $\left[b, I_{\alpha}\right]$ in place of $T$, and this is what we wanted.

As in the case of the commutators of Calderón-Zygmund operators in Section 7 the original proof in [63] relied on verifying the weighted FréchetKolmogorov criterion [17]. This is avoided by the aforementioned argument.

Consider now, for $\alpha \in(0, d)$, the so-called $\rho$-type fractional integral operator defined by

$$
T_{K_{\alpha}} f(x)=\int_{\mathbb{R}^{d}} K_{\alpha}(x, y) f(y) d y, \quad x \notin \operatorname{supp} f
$$

with kernel $K_{\alpha}$ satisfying the size condition

$$
\left|K_{\alpha}(x, y)\right| \lesssim \frac{1}{|x-y|^{d-\alpha}},
$$

and the smoothness condition

$$
\left|K_{\alpha}(x, y)-K_{\alpha}(z, y)\right|+\left|K_{\alpha}(y, x)-K_{\alpha}(y, z)\right| \leq \rho\left(\frac{|x-z|}{|x-y|}\right) \frac{1}{|x-y|^{d-\alpha}}
$$

for all $x, z, y \in \mathbb{R}^{d}$ such that $|x-y|>2|x-z|$, where $\rho:[0,1] \rightarrow[0, \infty)$ is a modulus of continuity, that is, $\rho$ is a continuous, increasing, subadditive function with $\rho(0)=0$ and satisfies the following Dini condition:

$$
\int_{0}^{1} \rho(t) \frac{d t}{t}<\infty
$$

By observing that $\left|T_{K_{\alpha}}(f)\right| \lesssim I_{\alpha}(|f|)$ and applying the result of Muckenhoupt and Wheeden [52] to the operator $I_{\alpha}(|f|)$ we have that $T_{K_{\alpha}}$ is bounded from $L^{p}\left(w^{p}\right)$ to $L^{q}\left(w^{q}\right)$ for all $1<p \leq q<\infty$ such that $\frac{1}{p}-\frac{1}{q}=\frac{\alpha}{d}$ and all weights $w \in A_{p, q}\left(\mathbb{R}^{d}\right)$. We extend this result to the commutator $\left[b, T_{K_{\alpha}}\right]$ by recalling the following result of Bényi-Martell-Moen-Stachura-Torres [4] (this is a generalized version of the classical theorem of Coifman-RochbergWeiss [20]):
9.4. Theorem ([4, Theorem 3.22). Let $T$ be a linear operator. Fix $1 \leq p, q<$ $\infty$. Suppose also that $T: L^{p}\left(w^{p}\right) \rightarrow L^{q}\left(w^{q}\right)$ is bounded for all $w \in A_{p, q}\left(\mathbb{R}^{d}\right)$ and $b \in \operatorname{BMO}\left(\mathbb{R}^{d}\right)$. Then $[b, T]$ is a bounded operator from $L^{p}\left(w^{p}\right)$ to $L^{q}\left(w^{q}\right)$.

By applying Theorem 9.4 to the operator $T_{K_{\alpha}}$ in place of $T$, the following weighted boundedness result for the commutator $\left[b, T_{K_{\alpha}}\right]$ is automatically valid:
9.5. Corollary. Fix $0<\alpha<d, 1<p<d / \alpha$ and $1 / p-1 / q=\alpha / d$. Suppose also that $b \in \operatorname{BMO}\left(\mathbb{R}^{d}\right)$. Then $\left[b, T_{K_{\alpha}}\right]: L^{p}\left(w^{p}\right) \rightarrow L^{q}\left(w^{q}\right)$ is a bounded linear operator for all $w \in A_{p, q}\left(\mathbb{R}^{d}\right)$.

The compactness result about the commutator $\left[b, T_{K_{\alpha}}\right.$ ] is due to Guo-Wu-Yang 36:
9.6. Theorem ([36], Theorem 1.5). Let $w \in A_{p, q}\left(\mathbb{R}^{d}\right), 1<p, q<\infty, 0<$ $\alpha<d, 1 / q=1 / p-\alpha / d$. If $b \in \operatorname{CMO}\left(\mathbb{R}^{d}\right)$, then $\left[b, T_{K_{\alpha}}\right]$ is a compact operator from $L^{p}\left(w^{p}\right)$ to $L^{q}\left(w^{q}\right)$.

The original proof of Theorem 9.6 again follows by applying the weighted Fréchet-Kolmogorov criterion obtained in [17] and restated in Lemma 5.4 of [36]. However, by only applying and verifying the unweighted FréchetKolmogorov criterion the proof of Theorem 9.6 can be simplified as follows:

Proof. Let us fix some $p_{1}, q_{1} \in(1, \infty)$ for which we verify the assumptions of Theorem 2.3 for $\left[b, T_{K_{\alpha}}\right.$ ] in place of $T$ : By Corollary $9.5,\left[b, T_{K_{\alpha}}\right]$ is a bounded operator from $L^{p_{1}}\left(\tilde{w}^{p_{1}}\right)$ to $L^{q_{1}}\left(\tilde{w}^{q_{1}}\right)$ for all $1<p_{1} \leq q_{1}<\infty$ such that $\frac{1}{p}-\frac{1}{q}=\frac{1}{p_{1}}-\frac{1}{q_{1}}=\frac{\alpha}{d}$ and all $\tilde{w} \in A_{p_{1}, q_{1}}\left(\mathbb{R}^{d}\right)$. By the unweighted version of Theorem 1.5 in [36] (which in turn depends on the classical, unweighted version of the Fréchet-Kolmogorov criterion), $\left[b, T_{K_{\alpha}}\right]$ is a compact operator from $L^{p_{1}}\left(\mathbb{R}^{d}\right)=L^{p_{1}}\left(w_{1}^{p_{1}}\right)$ to $L^{q_{1}}\left(\mathbb{R}^{d}\right)=L^{q_{1}}\left(w_{1}{ }^{q_{1}}\right)$ with $w_{1} \equiv 1 \in A_{p_{1}, q_{1}}\left(\mathbb{R}^{d}\right)$. Thus the assumptions, and hence the conclusion of Theorem 2.3 hold for the operator $\left[b, T_{K_{\alpha}}\right]$ in place of $T$, and this is what we wanted.

## 10. Commutators of Bochner-Riesz multipliers

In this section we will apply Theorem 2.4 to the commutators of BochnerRiesz multipliers in dimensions $d \geq 2$. The latter is a Fourier multiplier $B^{\kappa}$ with the symbol $\left(1-|\xi|^{2}\right)_{+}^{\kappa}$, where $\kappa>0$ and $t_{+}=\max (t, 0)$. That is, the Bochner-Riesz operator is defined, on the class $\mathcal{S}\left(\mathbb{R}^{d}\right)$ of Schwartz functions, by

$$
\widehat{B^{\kappa}} f(\xi)=\left(1-|\xi|^{2}\right)_{+}^{\kappa} \widehat{f}(\xi)
$$

where $\widehat{f}$ denotes the Fourier transform of $f$.
The following Bochner-Riesz conjecture is well-known:
10.1. Conjecture (Bochner-Riesz Conjecture). For $0<\kappa<\frac{d-1}{2}$, there holds that $B^{\kappa}: L^{p}\left(\mathbb{R}^{d}\right) \mapsto L^{p}\left(\mathbb{R}^{d}\right)$ if

$$
p \in\left(\frac{2 d}{d+1+2 \kappa}, \frac{2 d}{d-1-2 \kappa}\right)
$$

This conjecture holds in two dimensions, as was proved by Carleson-Sjölin [11] (see also Córdoba [22]). In the case $d \geq 3$, the best results are currently due to Bourgain-Guth [7], but also see Lee [48].

In [46], an equivalent form of the Bochner-Riesz Conjecture 10.1 is stated as follows:
10.2. Conjecture. Let $\mathbf{1}_{[-1 / 4,1 / 4]} \leq \chi \leq \mathbf{1}_{[-1 / 2,1 / 2]}$ be a Schwartz function and denote by $S_{\tau}$ the Fourier multiplier with symbol $\chi((|\xi|-1) / \tau)$. If $\frac{2 d}{d+1}<$ $p<\frac{2 d}{d-1}$, then

$$
\begin{equation*}
\left\|S_{\tau}\right\|_{L^{p}\left(\mathbb{R}^{d}\right) \mapsto L^{p}\left(\mathbb{R}^{d}\right)} \leq C_{\epsilon} \tau^{-\epsilon} \tag{10.3}
\end{equation*}
$$

where $0<\tau<1$ and $C_{\epsilon}$ is a constant that depends on $0<\epsilon<1$.
The connection between the Bochner-Riesz and the $S_{\tau}$ Fourier multipliers is well-known and it can be found in [10, 21, 22] and [29, Chapter 8.5]. We briefly recall it here. For each $0<\kappa<\frac{d-1}{2}$, we have

$$
B^{\kappa}=T^{0}+\sum_{i=1}^{\infty} 2^{-i \kappa} \operatorname{Dil}_{1-2^{-i}} S_{2^{-i}}
$$

where $T^{0}$ is a Fourier multiplier, with the multiplier being a Schwartz function supported near the origin and the operator $\operatorname{Dil}_{s} f(x)=f(x / s)$ is a dilation operator. Moreover, each $S_{2^{-i}}$ is a Fourier multiplier with symbol $\chi_{i}\left(2^{i}| | \xi|-1|\right)$, where the $\chi_{i}$ satisfy a uniform class of derivative estimates.

The partial knowledge of the range of exponents (which depends on the parameter $1<p_{0}<2$ ) such that the estimate (10.3) of Conjecture 10.2 holds is used in the following theorem of Lacey-Mena-Reguera [46:
10.4. Theorem (46], Theorem 6.1). If $d=2,0<\kappa<\tilde{\kappa}<\frac{1}{2}$ and $p \in\left(\frac{4}{1+6 \kappa}, \frac{4}{1-2 \kappa}\right)$, then $B^{\tilde{\kappa}}$ is bounded on $L^{p}(w)$ for all $w \in A_{\frac{p(1+6 \kappa)}{4}}\left(\mathbb{R}^{2}\right) \cap$ $R H_{\left(\frac{4}{p(1-2 \kappa)}\right)^{\prime}}\left(\mathbb{R}^{2}\right)$.
Moreover, if $d \geq 3,0<\kappa<\tilde{\kappa}<\frac{d-1}{2}$ and $1<p_{0}<2$ are such that the estimate (10.3) of Conjecture 10.2 holds, and

$$
p \in\left(\frac{p_{0}(d-1)}{d-1+2 \kappa\left(p_{0}-1\right)}, \frac{p_{0}(d-1)}{d-1-2 \kappa}\right)
$$

then $B^{\tilde{\kappa}}$ is bounded on $L^{p}(w)$ for all

$$
w \in A_{\frac{p\left(d-1+2 \kappa\left(p_{0}-1\right)\right)}{p_{0}(d-1)}}\left(\mathbb{R}^{d}\right) \cap R H_{\left(\frac{p_{0}(d-1)}{p(d-1-2 k)}\right)^{\prime}}\left(\mathbb{R}^{d}\right) .
$$

Some earlier results in the same direction are contained in [3, 12] and [15.

To streamline the presentation of our main result in this section about the compactness of commutators of Bochner-Riesz multipliers, we formulate the following Corollary of Theorem 10.4:
10.5. Corollary. If $d=2,0<\tilde{\kappa}<\frac{1}{2}$ and $p \in\left(\frac{4}{1+6 \tilde{\kappa}}, \frac{4}{1-2 \tilde{\kappa}}\right)$, then $B^{\tilde{\kappa}}$ is bounded on $L^{p}(w)$ for all $w \in A_{\frac{p(1+6 \tilde{\kappa})}{4}}\left(\mathbb{R}^{2}\right) \cap R H_{\left(\frac{4}{p(1-2 \tilde{\kappa})}\right)^{\prime}}\left(\mathbb{R}^{2}\right)$.
Moreover, if $d \geq 3,0<\tilde{\kappa}<\frac{d-1}{2}$ and $1<p_{0}<2$ are such that the estimate (10.3) of Conjecture 10.2 holds, and

$$
p \in\left(\frac{p_{0}(d-1)}{d-1+2 \tilde{\kappa}\left(p_{0}-1\right)}, \frac{p_{0}(d-1)}{d-1-2 \tilde{\kappa}}\right)
$$

then $B^{\tilde{\kappa}}$ is bounded on $L^{p}(w)$ for all

$$
w \in A_{\frac{p\left(d-1+2 \tilde{\kappa}\left(p_{0}-1\right)\right)}{p_{0}(d-1)}}\left(\mathbb{R}^{d}\right) \cap R H_{\left(\frac{p_{0}(d-1)}{p(d-1-2 \bar{k})}\right)^{\prime}}\left(\mathbb{R}^{d}\right) .
$$

Proof. Let us fix $\tilde{\kappa}, p$ and the weight $w$ of our assumptions. For each selection of these fixed values we show that we can choose $\kappa$ sufficiently close to $\tilde{\kappa}$ (depending on $\tilde{\kappa}, p$ and the weight $w$ ) such that the assumptions of Theorem 10.4 are satisfied. By properties (2) and (3) of Proposition 4.1 if

$$
w \in A_{\frac{p\left(d-1+2 \tilde{\hbar}\left(p_{0}-1\right)\right)}{p_{0}(d-1)}}\left(\mathbb{R}^{d}\right) \cap R H_{\left(\frac{p_{0}(d-1)}{p(d-1-2 \kappa)}\right)}\left(\mathbb{R}^{d}\right)
$$

then for $\kappa$ sufficiently close to $\tilde{\kappa}$ we also have that $\frac{p\left(d-1+2 \kappa\left(p_{0}-1\right)\right)}{p_{0}(d-1)}$ is sufficiently close to $\frac{p\left(d-1+2 \tilde{\kappa}\left(p_{0}-1\right)\right)}{p_{0}(d-1)}$ and $\left(\frac{p_{0}(d-1)}{p(d-1-2 \kappa)}\right)^{\prime}$ is sufficiently close to $\left(\frac{p_{0}(d-1)}{p(d-1-2 \tilde{k})}\right)^{\prime}$ such that

$$
w \in A_{\frac{p\left(d-1+2 \kappa\left(p_{0}-1\right)\right)}{p_{0}(d-1)}}\left(\mathbb{R}^{d}\right) \cap R H_{\left(\frac{p_{0}(d-1)}{p(d-1-2 k)}\right)^{\prime}}\left(\mathbb{R}^{d}\right) .
$$

By continuity, since

$$
p \in\left(\frac{p_{0}(d-1)}{d-1+2 \tilde{\kappa}\left(p_{0}-1\right)}, \frac{p_{0}(d-1)}{d-1-2 \tilde{\kappa}}\right)
$$

we also have that

$$
p \in\left(\frac{p_{0}(d-1)}{d-1+2 \kappa\left(p_{0}-1\right)}, \frac{p_{0}(d-1)}{d-1-2 \kappa}\right),
$$

provided that $\kappa$ is sufficiently close to $\tilde{\kappa}$.
Hence the assumptions of Theorem 10.4 are satisfied, and thus $B^{\tilde{\kappa}}$ is bounded on $L^{p}(w)$ for the arbitrary choice of the quantities $\tilde{\kappa}, p$ and $w$ in the statement of Corollary 10.5 that we considered. This concludes the proof.

We extend this result to the commutator $\left[b, B^{\kappa}\right]$ by recalling the following corollary of Theorem 9.4 obtained in $[4]$ (it follows by applying property (5) of Proposition 4.1):
10.6. Corollary (4], Corollary 5.3). Let $1 \leq p_{-}<p<p_{+} \leq \infty$, and let $T$ be a linear operator bounded on $L^{p}(w)$ for all $w \in A_{p_{p_{-}}}\left(\mathbb{R}^{d}\right) \cap R H_{\left(\frac{p_{+}}{p}\right)^{\prime}}\left(\mathbb{R}^{d}\right)$. If $b \in \operatorname{BMO}\left(\mathbb{R}^{d}\right)$, then $[b, T]$ is bounded on $L^{p}(w)$ for all $w \in A_{p_{-}}\left(\mathbb{R}^{d}\right) \cap$ $R H_{\left(\frac{p_{+}}{p}\right)^{\prime}}\left(\mathbb{R}^{d}\right)$.

By applying Corollary 10.6 to the operator $B^{\kappa}$ in place of $T$, the following weighted boundedness for the commutator $\left[b, B^{\kappa}\right]$ holds:
10.7. Corollary. If $d=2,0<\kappa<\frac{1}{2}$, and $p \in\left(\frac{4}{1+6 \kappa}, \frac{4}{1-2 \kappa}\right)$, then for $b \in \operatorname{BMO}\left(\mathbb{R}^{2}\right)$, the commutator $\left[b, B^{\kappa}\right]$ is bounded on $L^{p}(w)$ for all $w \in$ $\left.A_{\frac{p(1+6 \kappa)}{4}}\left(\mathbb{R}^{2}\right) \cap R H_{\left(\frac{4}{p(1-2 \kappa)}\right.}\right)^{\prime}\left(\mathbb{R}^{2}\right)$.

Moreover, if $d \geq 3,0<\kappa<\frac{d-1}{2}$ and $1<p_{0}<2$ are such that the estimate (10.3) of Conjecture 10.2 holds and

$$
p \in\left(\frac{p_{0}(d-1)}{d-1+2 \kappa\left(p_{0}-1\right)}, \frac{p_{0}(d-1)}{d-1-2 \kappa}\right),
$$

then for $b \in \operatorname{BMO}\left(\mathbb{R}^{d}\right)$, the commutator $\left[b, B^{\kappa}\right]$ is bounded on $L^{p}(w)$ for all

$$
w \in A_{\frac{p\left(d-1+2 \kappa\left(p_{0}-1\right)\right)}{p_{0}(d-1)}}\left(\mathbb{R}^{d}\right) \cap R H_{\left(\frac{p_{0}(d-1)}{p(d-1-2 \kappa)}\right)} \prime\left(\mathbb{R}^{d}\right) .
$$

Moreover, an unweighted compactness result for the commutator $\left[b, B^{\kappa}\right]$ is due to $\mathrm{Bu}-\mathrm{Chen}-\mathrm{Hu}$ [8]:
10.8. Theorem ([8], Theorems 1.1 and 1.2). If $d=2,0<\kappa<\frac{1}{2}$, and $p \in\left(\frac{4}{3+2 \kappa}, \frac{4}{1-2 \kappa}\right)$, then for $b \in \operatorname{CMO}\left(\mathbb{R}^{2}\right)$, the commutator $\left[b, B^{\kappa}\right]$ is compact on $L^{p}\left(\mathbb{R}^{2}\right)$.
Let $d \geq 3, \frac{d-1}{2 d+2}<\kappa<\frac{d-1}{2}$, and $p \in\left(\frac{2 d}{d+1+2 \kappa}, \frac{2 d}{d-1-2 \kappa}\right)$. Then for $b \in$ $\operatorname{CMO}\left(\mathbb{R}^{d}\right)$, the commutator $\left[b, B^{\kappa}\right]$ is compact on $L^{p}\left(\mathbb{R}^{d}\right)$.

Combining Theorem 2.4. Corollary 10.7 and Theorem 10.8 we can give a new weighted compactness result for the Bochner-Riesz commutator $\left[b, B^{\kappa}\right]$ :
10.9. Corollary. If $d=2,0<\kappa<\frac{1}{2}$, and $p \in\left(\frac{4}{1+6 \kappa}, \frac{4}{1-2 \kappa}\right)$, then for $b \in \operatorname{CMO}\left(\mathbb{R}^{2}\right)$, the commutator $\left[b, B^{\kappa}\right]$ is compact on $L^{p}(w)$ for all $w \in$ $\left.A_{\frac{p(1+6 \kappa)}{4}}\left(\mathbb{R}^{2}\right) \cap R H_{\left(\frac{4}{p(1-2 \kappa)}\right)}\right)^{\prime}\left(\mathbb{R}^{2}\right)$.
Moreover, if $d \geq 3, \frac{d-1}{2 d+2}<\kappa<\frac{d-1}{2}$ and $1<p_{0}<2$ are such that the estimate (10.3) of Conjecture 10.2 holds,

$$
p \in\left(\frac{p_{0}(d-1)}{d-1+2 \kappa\left(p_{0}-1\right)}, \frac{p_{0}(d-1)}{d-1-2 \kappa}\right),
$$

and $b \in \operatorname{CMO}\left(\mathbb{R}^{d}\right)$, then the commutator $\left[b, B^{\kappa}\right]$ is compact on $L^{p}(w)$ for all

$$
w \in A_{\frac{p\left(d-1+2 \kappa\left(p_{0}-1\right)\right)}{p_{0}(d-1)}}\left(\mathbb{R}^{d}\right) \cap R H_{\left(\frac{p_{0}(d-1)}{p(d-1-2 \kappa)}\right)^{\prime}}\left(\mathbb{R}^{d}\right) .
$$

Proof. Let $d \geq 3, \frac{d-1}{2 d+2}<\kappa<\frac{d-1}{2}$ and $p_{0}$ be as in the assumptions. We verify the assumptions of Theorem [2.4 for the fixed exponent

$$
\frac{p_{0}(d-1)}{d-1+2 \kappa\left(p_{0}-1\right)}<p_{1}<\frac{p_{0}(d-1)}{d-1-2 \kappa}
$$

and the operator $\left[b, B^{\kappa}\right]$ in place of $T$. By Corollary $10.7,\left[b, B^{\kappa}\right]$ is a bounded operator on $L^{p_{1}}(\tilde{w})$ for all

$$
\left.\tilde{w} \in A_{\frac{p_{1}\left(d-1+2 \kappa\left(p_{0}-1\right)\right)}{p_{0}(d-1)}}\left(\mathbb{R}^{d}\right) \cap R H_{\left(\frac{p_{0}(d-1)}{p_{1}(d-1-2 \kappa)}\right.}\right)\left(\mathbb{R}^{d}\right) .
$$

By Theorem 10.8, $\left[b, B^{\kappa}\right]$ is a compact operator on $L^{p_{1}}\left(\mathbb{R}^{d}\right)=L^{p_{1}}\left(w_{1}\right)$ with

$$
\left.w_{1} \equiv 1 \in A_{\frac{p_{1}\left(d-1+2 \kappa\left(p_{0}-1\right)\right)}{p_{0}(d-1)}}\left(\mathbb{R}^{d}\right) \cap R H_{\left(\frac{p_{0}(d-1)}{p_{1}(d-1-2 \kappa)}\right)}\right)\left(\mathbb{R}^{d}\right) .
$$

Thus Theorem [2.4 applies to give the compactness of $\left[b, B^{\kappa}\right]$ on $L^{p}(w)$ for all

$$
p \in\left(\frac{p_{0}(d-1)}{d-1+2 \kappa\left(p_{0}-1\right)}, \frac{p_{0}(d-1)}{d-1-2 \kappa}\right)
$$

and all

$$
w \in A_{\frac{p\left(d-1+2 \kappa\left(p_{0}-1\right)\right)}{p_{0}(d-1)}}\left(\mathbb{R}^{d}\right) \cap R H_{\left(\frac{p_{0}(d-1)}{p(d-1-2 \kappa)}\right)^{\prime}}\left(\mathbb{R}^{d}\right) .
$$

The case $d=2$ follows in a similar way.
11. $A_{p}^{\zeta}(\varphi)$ WEIGHTS AND COMMUTATORS OF PSEUDO-DIFFERENTIAL operators

In this section, we develop and apply yet another variant for extrapolation of compactness for a special class of weights related to commutators of pseudo-differential operators with smooth symbols.

Following Wu-Wang [64], we consider the following:
11.1. Definition. A function $\varphi:[0, \infty) \rightarrow[1, \infty)$ is called admissible if it is non-decreasing and satisfies the following:

$$
\varphi(\zeta t) \lesssim \zeta^{\omega} \varphi(t)
$$

for all $\zeta \geq 1, t \geq 0$ and some $\omega>0$.
11.2. Definition. Let $\varphi$ be an admissible function and let $p \in(1, \infty), \zeta>0$. A weight $0<w \in L_{\mathrm{loc}}^{1}\left(\mathbb{R}^{d}\right)$ is called an $A_{p}^{\zeta}(\varphi)$ weight (or $w \in A_{p}^{\zeta}(\varphi)$ ) if

$$
[w]_{A_{p}^{\zeta}(\varphi)}:=\sup _{Q} \frac{\langle w\rangle_{Q}\left\langle w^{-\frac{1}{p-1}}\right\rangle_{Q}^{p-1}}{\varphi(|Q|)^{\zeta p}}<\infty,
$$

where the supremum is taken over all cubes $Q \subset \mathbb{R}^{d}$.
11.3. Remark. In 57], Tang introduced the weight class $A_{p}(\varphi)$ which coincides with $A_{p}^{1}(\varphi)$. We remark that $A_{p}^{\zeta}(\varphi)=A_{p}\left(\varphi^{\zeta}\right)$. In general, it holds that $A_{p}\left(\mathbb{R}^{d}\right) \subset A_{p}^{\zeta}(\varphi)$ for all $1<p<\infty$. On the other hand, when $\varphi$ is a constant function, $A_{p}^{\zeta}(\varphi)=A_{p}\left(\mathbb{R}^{d}\right)$ for any $\zeta>0$. A main example of admissible function that we consider below is $\varphi(t)=1+t$.
11.A. Extrapolation with $A_{p}^{\zeta}(\varphi)$ weights. In Theorem 2.1 of [37], Guo and Zhou proved the compactness of commutators of pseudo-differential operators with smooth symbols on weighted Lebesgue spaces where the weight functions belong to the weight class $A_{p}^{\zeta}(\varphi)$. Motivated by their work we show the following extrapolation of compactness:
11.4. Theorem. Let $\varphi$ be an admissible function, let $1<p<\infty$, and let $T$ be a linear operator simultaneously defined and bounded on $L^{p}(w)$ for all $1<p<\infty$, all $w \in A_{p}^{\zeta}(\varphi)$ and all $\zeta>0$. Suppose in addition that $T$ is compact on $L^{p_{1}}\left(w_{1}\right)$ for some $1<p_{1}<\infty$, some $w_{1} \in A_{p_{1}}^{\zeta_{1}}(\varphi)$ and some $\zeta_{1}>0$. Then $T$ is compact on $L^{p}(w)$ for all $p \in(1, \infty)$, all $w \in A_{p}^{\zeta}(\varphi)$ and all $\zeta>0$.

We proceed by collecting the results from which the proof of Theorem 11.4 follows. We will use Theorem 3.1 in the special setting:
11.5. Proposition. Let $\varphi$ be an admissible function and suppose that $q, q_{1} \in$ $(1, \infty), \zeta, \zeta_{1}>0, v \in A_{q}^{\zeta}(\varphi)$ and $v \in A_{q_{1}}^{\zeta_{1}}(\varphi)$. Then

$$
\left[L^{q_{0}}\left(v_{0}\right), L^{q_{1}}\left(v_{1}\right)\right]_{\gamma}=L^{q}(v)
$$

for some $q_{0} \in(1, \infty), \zeta_{0}>0, v_{0} \in A_{q_{0}}^{\zeta_{0}}(\varphi)$, and $\gamma \in(0,1)$.
The only component of the proof of Theorem 11.4 that requires actual computations is the verification of this proposition. For this purpose we will need Theorem 4.2 which we connect with the $A_{p}^{\zeta}(\varphi)$ weights as follows:
11.6. Lemma. Let $\varphi$ be an admissible function, and suppose that $p_{1}, p \in$ $(1, \infty), \zeta, \zeta_{1}>0, w_{1} \in A_{p_{1}}^{\zeta_{1}}(\varphi)$ and $w \in A_{p}^{\zeta}(\varphi)$. Then there exist $p_{0} \in$ $(1, \infty), \zeta_{0}>0, w_{0} \in A_{p_{0}}^{\zeta_{0}}(\varphi)$, and $\theta \in(0,1)$ such that the conclusion of Theorem 4.2 holds, i.e.,

$$
\left[L^{p_{0}}\left(w_{0}\right), L^{p_{1}}\left(w_{1}\right)\right]_{\theta}=L^{p}(w)
$$

where

$$
\frac{1}{p}=\frac{1-\theta}{p_{0}}+\frac{\theta}{p_{1}}, \quad w^{\frac{1}{p}}=w_{0}^{\frac{1-\theta}{p_{0}}} w_{1}^{\frac{\theta}{p_{1}}}
$$

Proof. Note that the choice of $\theta \in(0,1)$ determines both

$$
p_{0}=p_{0}(\theta)=\frac{1-\theta}{\frac{1}{p}-\frac{\theta}{p_{1}}}, \quad w_{0}=w_{0}(\theta)=w^{\frac{p_{0}}{p(1-\theta)}} w_{1}^{-\frac{p_{0} \cdot \theta}{p_{1}(1-\theta)}}
$$

so it remains to check that we can choose $\theta \in(0,1)$ so that $p_{0} \in(1, \infty)$ and $w_{0} \in A_{p_{0}}^{\zeta_{0}}(\varphi)$ for some $\zeta_{0}>0$. Since $p_{0}(0)=p \in(1, \infty)$, the first condition is obvious for small enough $\theta>0$ by continuity.

To check that $w_{0} \in A_{p_{0}}^{\zeta_{0}}(\varphi)$ for some $\zeta_{0}>0$, we consider a cube $Q$ and write

$$
\begin{aligned}
& \left\langle w_{0}\right\rangle_{Q}\left\langle w_{0}^{-\frac{1}{p_{0}-1}}\right\rangle_{Q}^{p_{0}-1}=\left\langle w^{\frac{p_{0}}{p(1-\theta)}} w_{1}^{-\frac{p_{0} \cdot \theta}{p_{1}(1-\theta)}}\right\rangle_{Q}\left\langle w^{-\frac{p_{0}^{\prime}}{p(1-\theta)}} w_{1}^{\frac{p_{0}^{\prime} \cdot \theta}{p_{1}(1-\theta)}}\right\rangle_{Q}^{p_{0}-1} \\
& =\left\langle w^{\frac{p_{0}}{p(1-\theta)}}\left(w_{1}^{-\frac{1}{p_{1}-1}}\right)^{\frac{p_{0} \cdot \theta}{p_{1}^{\prime}(1-\theta)}}\right\rangle_{Q}\left\langle\left( w^{\left.\left.-\frac{1}{p-1}\right)^{\frac{p_{0}^{\prime}}{p^{\prime}(1-\theta)}} w_{1}^{\frac{p_{0}^{\prime} \cdot \theta}{p_{1}(1-\theta)}}\right\rangle_{Q}^{p_{0}-1}}\right.\right.
\end{aligned}
$$

where $q^{\prime}:=q /(q-1)$ denotes the conjugate exponent of $q \in\left\{p, p_{0}, p_{1}\right\}$.
In the first average, we use Hölder's inequality with exponents $1+\varepsilon^{ \pm 1}$, and in the second with exponents $1+\delta^{ \pm 1}$ to get

$$
\begin{align*}
& \leq\left\langle w^{\frac{p_{0}(1+\varepsilon)}{p(1-\theta)}}\right\rangle_{Q}^{\frac{1}{1+\varepsilon}}\left\langle\left(w_{1}^{-\frac{1}{p_{1}-1}}\right)^{\frac{p_{0} \theta(1+\varepsilon)}{p_{1}^{\prime} \varepsilon(1-\theta)}}\right\rangle_{Q}^{\frac{\varepsilon}{1+\varepsilon}}\left\langle\left(w^{-\frac{1}{p-1}}\right)^{\frac{p_{0}^{\prime}(1+\delta)}{p^{\prime}(1-\theta)}}\right\rangle_{Q}^{\frac{p_{0}-1}{1+\delta}} \\
& \quad \times\left\langle w_{1}^{\frac{p_{0}^{\prime} \theta(1+\delta)}{p_{1} \delta(1-\theta)}}\right\rangle_{Q}^{\frac{\delta\left(p_{0}-1\right)}{1+\delta}}  \tag{11.7}\\
& =\left\langle w^{r(\theta)}\right\rangle_{Q}^{\frac{1}{1+\varepsilon}}\left\langle\left(w_{1}^{-\frac{1}{p_{1}-1}}\right)^{s(\theta)}\right\rangle_{Q}^{\frac{\varepsilon}{1+\varepsilon}}\left\langle\left(w^{-\frac{1}{p-1}}\right)^{t(\theta)}\right\rangle_{Q}^{\frac{p_{0}-1}{1+\delta}} \\
& \quad \times\left\langle w_{1}^{u(\theta)}\right\rangle_{Q}^{\frac{\delta\left(p_{0}-1\right)}{1+\delta}}
\end{align*}
$$

where

$$
r(\theta):=\frac{p_{0}(\theta)(1+\varepsilon)}{p(1-\theta)}, \quad s(\theta):=\frac{\theta p_{0}(\theta)(1+\varepsilon)}{p_{1}^{\prime} \varepsilon(1-\theta)}
$$

and

$$
t(\theta):=\frac{p_{0}^{\prime}(\theta)(1+\delta)}{p^{\prime}(1-\theta)}, \quad u(\theta):=\frac{\theta p_{0}^{\prime}(\theta)(1+\delta)}{p_{1} \delta(1-\theta)}
$$

Now, we choose $\varepsilon=\frac{\theta p}{p_{1}^{\prime}}$ and $\delta=\frac{\theta p^{\prime}}{p_{1}}$ in a such a way that

$$
r(\theta)=s(\theta)=\frac{p_{0}(\theta)\left(p_{1}^{\prime}+\theta p\right)}{p p_{1}^{\prime}(1-\theta)}
$$

and

$$
t(\theta)=u(\theta)=\frac{p_{0}(\theta)^{\prime}\left(p_{1}+\theta p^{\prime}\right)}{p^{\prime} p_{1}(1-\theta)}
$$

The strategy to proceed is to use the reverse Hölder inequality for $A_{v}^{\tilde{\zeta}}(\varphi)$ weights due to $\mathrm{Wu}-$ Wang (see Proposition 15 in 64]), which says that for each $W \in A_{v}^{\tilde{\zeta}}(\varphi)$ there exists $\eta>0$ such that

$$
\begin{equation*}
\left\langle W^{t}\right\rangle_{Q}^{1 / t} \lesssim\langle W\rangle_{Q} \varphi(|Q|)^{\eta} \tag{11.8}
\end{equation*}
$$

for all $t \leq 1+\tilde{\eta}$ and for some $\tilde{\eta}>0$.
Recalling that $p_{0}(0)=p$, we see that $r(0)=t(0)=1$. By continuity, given any $\tilde{\eta}>0$, we find that

$$
\begin{equation*}
\max (r(\theta), t(\theta)) \leq 1+\tilde{\eta} \text { for all small enough } \theta>0 \tag{11.9}
\end{equation*}
$$

Next we will apply another property of $A_{v}^{\tilde{\zeta}}(\varphi)$ weights as stated by $\mathrm{Wu}-$ Wang in Proposition 15 of [64], namely:
If $1<v<\infty$, we have

$$
\begin{equation*}
W \in A_{v}^{\tilde{\zeta}}(\varphi) \Longleftrightarrow W^{1-v^{\prime}} \in A_{v^{\prime}}^{\tilde{\zeta}}(\varphi), \quad \text { where } \quad \frac{1}{v}+\frac{1}{v^{\prime}}=1 \tag{11.10}
\end{equation*}
$$

By (11.10) we have that $w \in A_{p}^{\zeta}(\varphi), w^{-\frac{1}{p-1}} \in A_{p^{\prime}}^{\zeta}(\varphi), w_{1} \in A_{p_{1}}^{\zeta_{1}}(\varphi)$ and $w_{1}^{-\frac{1}{p_{1}-1}} \in A_{p_{1}^{\prime}}^{\zeta_{1}}(\varphi)$. Hence by (11.9) each of these four functions satisfies the reverse Hölder inequality (11.8) for all $t \leq 1+\tilde{\eta}$ and for some $\tilde{\eta}>0$. Thus,
for all small enough $\theta>0$, we have

$$
\begin{aligned}
& \text { (11.7) } \lesssim\langle w\rangle_{Q}^{\frac{p_{0}}{p(1-\theta)}}\left\langle w_{1}^{-\frac{1}{p_{1}-1}}\right\rangle_{Q}^{\frac{\theta p_{0}}{p_{1}^{\prime}(1-\theta)}}\left\langle w^{-\frac{1}{p^{-1}}}\right\rangle_{Q}^{\frac{p_{p}^{\prime}\left(p_{0}-1\right)}{p^{\prime}(1-\theta)}}
\end{aligned}
$$

$$
\begin{aligned}
& =\langle w\rangle_{Q}^{\frac{p_{0}(\theta)}{p(1-\theta)}}\left\langle w_{1}^{-\frac{1}{p_{1}-1}}\right\rangle_{Q}^{\frac{\theta p_{0}(\theta)}{p_{1}^{\prime}(1-\theta)}}\left\langle w^{-\frac{1}{p-1}}\right\rangle_{Q}^{\frac{p_{0}(\theta)}{p_{0}(1-\theta)}} \\
& \times\left\langle w_{1}\right\rangle_{Q}^{\frac{\theta p_{0}(\theta)}{p_{1}(1-\theta)}} \varphi(|Q|)^{\eta \frac{p_{0}(\theta)}{p(1-\theta)}+\eta \frac{\theta p_{0}(\theta)}{p_{1}^{0}(1-\theta)}+\eta \frac{p_{0}(\theta)}{p^{0}(1-\theta)}+\eta \frac{\theta p_{0}(\theta)}{p_{1}(1-\theta)}} \\
& =\left(\langle w\rangle_{Q}\left\langle w^{-\frac{1}{p-1}}\right\rangle_{Q}^{p-1}\right)^{\frac{p_{0}(\theta)}{p(1-\theta)}}\left(\left\langle w_{1}\right\rangle_{Q}\left\langle w_{1}^{-\frac{1}{p_{1}-1}}\right\rangle_{Q}^{p_{1}-1}\right)^{\frac{\theta p_{0}(\theta)}{p_{1}(1-\theta)}} \\
& \times \varphi(|Q|)^{\frac{p_{0}(\theta)(\eta+\eta \theta)}{1-\theta}} \\
& \leq[w]_{A_{p}^{\zeta}(\varphi)}^{\frac{p_{1}}{p_{1}-\theta_{p}}}\left[w_{1}\right]_{A_{p_{1}}^{\zeta_{1}}(\varphi)}^{\frac{\theta_{p}}{p_{1}-\theta_{p}}} \varphi(|Q|)^{\zeta_{0} p_{0}(\theta)},
\end{aligned}
$$

where $\zeta_{0}=\frac{\eta+\eta \theta+\zeta+\zeta_{1} \theta}{1-\theta}>0$. In combination with the lines preceding (11.7), we have shown that

$$
\left[w_{0}\right]_{A_{p_{0}}^{\zeta_{0}}(\varphi)} \lesssim[w]_{A_{p}^{\zeta}(\varphi)}^{\frac{p_{1}}{p_{1}-\theta_{p}}}\left[w_{1}\right]_{A_{p_{1}}^{\zeta_{1}}(\varphi)}^{\frac{\theta_{p}}{p_{p}}}<\infty,
$$

provided that $\theta>0$ is small enough. This concludes the proof.
We now have the last missing ingredient of the proof of Theorem 11.4
Proof of Proposition 11.5. We are given $q, q_{1} \in(1, \infty), \zeta, \zeta_{1}>0$, and weights $v \in A_{q}^{\zeta}(\varphi), v_{1} \in A_{q_{1}}^{\zeta_{1}}(\varphi)$. By Lemma 11.6, there is some $q_{0} \in(1, \infty), \zeta_{0}>0$, a weight $v_{0} \in A_{q_{0}}^{\zeta_{0}}(\varphi)$, and $\theta \in(0,1)$ such that

$$
\frac{1}{q}=\frac{1-\theta}{q_{0}}+\frac{\theta}{q_{1}}, \quad v^{\frac{1}{q}}=v_{0}^{\frac{1-\theta}{q_{0}}} v_{1}^{\frac{\theta}{q_{1}}}
$$

By Theorem4.2, we then have $L^{q}(v)=\left[L^{q_{0}}\left(v_{0}\right), L^{q_{1}}\left(v_{1}\right)\right]_{\theta}$, as we claimed.
By combining Theorem 3.1, Lemma 3.5 and Proposition 11.5 we can prove Theorem 11.4 as follows:

Proof of Theorem 11.4. Recall that the assumptions of Theorem 11.4 are in force. In particular, $T$ is a bounded linear operator on $L^{p}(w)$ for all $p \in(1, \infty)$, all $w \in A_{p}^{\zeta}(\varphi)$ and all $\zeta>0$. In addition, it is assumed that $T$ is a compact operator on $L^{p_{1}}\left(w_{1}\right)$ for some $p_{1} \in(1, \infty)$, some $w_{1} \in A_{p_{1}}^{\zeta_{1}}(\varphi)$ and some $\zeta_{1}>0$. We need to prove that $T$ is actually compact on $L^{p}(w)$ for all $p \in(1, \infty)$, all $w \in A_{p}^{\zeta}(\varphi)$ and all $\zeta>0$. By Proposition 11.5, we have

$$
L^{p}(w)=\left[L^{p_{0}}\left(w_{0}\right), L^{p_{1}}\left(w_{1}\right)\right]_{\theta}
$$

for some $p_{0} \in(1, \infty)$, some $\zeta_{0}>0$, some $w_{0} \in A_{p_{0}}^{\zeta_{0}}(\varphi)$, and some $\theta \in(0,1)$. Writing $X_{j}=Y_{j}=L^{p_{j}}\left(w_{j}\right)$, we know that $T: X_{0}+X_{1} \rightarrow Y_{0}+Y_{1}$, that $T: X_{j} \rightarrow Y_{j}$ is bounded, and that $T: X_{1} \rightarrow Y_{1}$ is compact (since the last two
assertions were assumed). By Lemma 3.5, the last condition (4) of Theorem 3.1 is also satisfied by these spaces $X_{j}=L^{p_{j}}\left(w_{j}\right)$. By Theorem 3.1, it follows that $T$ is also compact on $\left[X_{0}, X_{1}\right]_{\theta}=\left[Y_{0}, Y_{1}\right]_{\theta}=L^{p}(w)$.

We provide an application of Theorem 11.4 that concerns pseudo-differential operators with smooth symbols.
11.B. Commutators of pseudo-differential operators with smooth symbols. Following [58], we say that a symbol $\sigma$ belongs to $S_{1, \lambda}^{m}$ if $\sigma(x, \xi)$ is a smooth function of $(x, \xi) \in \mathbb{R}^{d} \times \mathbb{R}^{d}$ and satisfies the following estimate:

$$
\left|\partial_{x}^{\mu} \partial_{\xi}^{\nu} \sigma(x, \xi)\right| \lesssim(1+|\xi|)^{m-|\nu|+\lambda|\mu|}
$$

for all $\mu, \nu \in \mathbb{N}^{d}$, where $m \in \mathbb{R}$.
Let $\sigma(x, \xi) \in S_{1, \lambda}^{m}$. The pseudo-differential operator $T$ is defined by

$$
T f(x)=\int_{\mathbb{R}^{d}} \sigma(x, \xi) e^{2 \pi i x \cdot \xi} \widehat{f}(\xi) d \xi
$$

where $f$ is a Schwartz function and $\widehat{f}$ denotes the Fourier transform of $f$. As usual, $L_{1, \lambda}^{m}$ will denote the class of pseudo-differential operators with symbols in $S_{1, \lambda}^{m}$.

Miller [50] showed the boundedness of $L_{1,0}^{0}$ pseudo-differential operators on $L^{p}(w)$ for $1<p<\infty$ and $w \in A_{p}\left(\mathbb{R}^{d}\right)$. Tang [57] improved the results of Miller by showing the boundedness of $L_{1,0}^{0}$ pseudo-differential operators and their commutators on $L^{p}(w)$, where $w \in A_{p}^{\zeta}(\varphi), \varphi(t)=1+t$ and $\zeta>0$ (Tang also makes a remark about the case $L_{1, \lambda}^{0}(0<\lambda<1)$; see [57, after Corollary 1.2]).

We will apply Theorem 11.4 to the commutators of pseudo-differential operators $T \in L_{1,0}^{0}$. We need the following result of Tang [57]:
11.11. Theorem ([57], Theorem 1.2). Suppose that $T \in L_{1,0}^{0}$ and let $b \in$ $\operatorname{BMO}\left(\mathbb{R}^{d}\right)$, for $1<p<\infty$. Then $[b, T]$ is bounded on $L^{p}(w)$ for all $w \in$ $A_{p}^{\zeta}(\varphi)$, where $\varphi(t)=1+t$ and $\zeta>0$.

As explained in Remark 7.3 these operators are instances of CalderónZygmund operators and thus they satisfy the assumption of Uchiyama's Theorem 7.1. Therefore, we can combine Theorems 7.1, 11.4 and 11.11 in order to recover a very recent result of Guo-Zhou [37]:
11.12. Theorem ([37], Theorem 2.1). Suppose that $T \in L_{1,0}^{0}$ and let $b \in$ $C M O\left(\mathbb{R}^{d}\right)$, for $1<p<\infty$. Then the commutator $[b, T]$ is a compact operator on $L^{p}(w)$ for all $w \in A_{p}^{\zeta}(\varphi)$, where $\varphi(t)=1+t$ and $\zeta>0$.
Proof. We verify the assumptions of Theorem 11.4 for $[b, T]$ in place of $T$ : By Theorem $11.11[b, T]$ is a bounded operator on $L^{p}(w)$ for all $1<p<\infty$, all $w \in A_{p}^{\zeta}(\varphi)$ and all $\zeta>0$. By Theorem 7.1, $[b, T]$ is a compact operator on $L^{p_{1}}\left(\mathbb{R}^{d}\right)=L^{p_{1}}\left(w_{1}\right)$ for any $1<p_{1}<\infty$ with $w_{1} \equiv 1 \in A_{p_{1}}^{\zeta_{1}}(\varphi)$ and
any $\zeta_{1}>0$. Thus Theorem 11.4 applies to give the compactness of $[b, T]$ on $L^{p}(w)$ for all $p \in(1, \infty)$, all $w \in A_{p}^{\zeta}(\varphi)$ and all $\zeta>0$.

As in the case of the commutators of fractional integral operators in Section 9 the original proof in 37 relied on verifying the weighted FréchetKolmogorov criterion [17], which is avoided by the argument above.
