# POSITIVE ALTERNATING SUMS OF INTEGER PARTITIONS 

MOHAMED EL BACHRAOUI


#### Abstract

We combine an extended version of Bailey's transform with an identity of Bressoud and with some identities of Berkovich and Warnaar to prove a variety of positivity results for alternating sums involving partition functions.


## 1. Introduction

Throughout the paper $n$ is a nonnegative integer. The $q$-shifted factorials are given by

(a ; q)_{0}=(a)_{0}=1, \quad,(a ; q)_{n}=(a)_{n}=\prod_{j=0}^{n-1}\left(1-a q^{j}\right), \quad(a ; q)_{\infty}=(a)_{\infty}=\prod_{j=0}^{\infty}\left(1-a q^{j}\right)
$$

and the $q$-binomial coefficient is given for any nonnegative integers $M$ and $N$ by

\end{array}\right]= \begin{cases}\frac{(q)_{N}}{(q)_{M}(q)_{N-M}} & \text { if } N \geq M \\

It is well-known that for integers $N \geq M \geq 0$, the $q$-binomial coefficient $\left[\begin{array}{l}N \\ M\end{array}\right]$ is a polynomial of degree $N(N-M)$ which has nonnegative integer coefficients. As usual we let $p(n)$ denote the number of partitions of $n$. Information about $q$ binomial coefficients and integer partition can be found in the book by Andrews [3]. Following [12] an overpartition of $n$ is a partition with the extra condition that the first occurrence of any part may be overlined or not and the number of such overpartitions is written $\bar{p}(n)$. As to generating functions, we have

\sum_{n=0}^{\infty} p(n) q^{n}=\frac{1}{(q ; q)_{\infty}} \text { and } \sum_{n=0}^{\infty} \bar{p}(n) q^{n}=\frac{(-q ; q)_{\infty}}{(q ; q)_{\infty}}, \quad(p(0)=\bar{p}(0)=1) \tag{1}
\end{equation*}
$$

Alternating sums of integer partitions have received much attention by mathematicians in recent years. For paper on this subject which are related to our work, see for instance [6, 7, 14, 15]. Merca [15] proved that for all $n>0$

p(n-5)-p(n-2)-p(n-1)+p(n) \geq 0
$$

which Andrews and Merca [6] generalized by showing that for $n, k>0$,

(-1)^{k-1} \sum_{j=0}^{k-1}(-1)^{j}(p(n-j(3 j+1) / 2)-p(n-j(3 j+5) / 2-1)) \geq 0 \tag{2}
\end{equation*}
$$

[^0]Their proof is partition-theoretic but it is based on the following truncated sum
(3) $\frac{1}{(q ; q)_{\infty}} \sum_{j=0}^{k-1}(-1)^{j} q^{j(3 j+1) / 2}\left(1-q^{2 j+1}\right)=1+(-1)^{k-1} \sum_{n=1}^{\infty} \frac{q^{\binom{k}{2}+(k+1) n}}{(q ; q)_{n}}\left[\begin{array}{l}n-1 \\ k-1\end{array}\right]$.

To derive the foregoing identity, Andrews and Merca used induction along with the $q$-binomial theorem and the basic properties of the $q$-binomial coefficients. Guo and Zeng [14] established the following truncated sum

\end{array}\right]

and as a consequence they obtained

(-1)^{k}\left(\bar{p}(n)+2 \sum_{j=0}^{k}(-1)^{j} \bar{p}\left(n-j^{2}\right)\right) \geq 0 \tag{5}
\end{equation*}

The authors' proof for (4) relies on the following formula of Andrews [2]

\sum_{j=0}^{n} \frac{(b)_{j}\left(1-b q^{2 j}\right)(b / a)_{j} a^{j} q^{j^{2}}}{(1-b)(q)_{j}(a q)_{j}}=\frac{(b q)_{n}}{(a q)_{n}} \sum_{j=0}^{n} \frac{(b / a)_{j} a^{j} q^{(n+1) j}}{(q)_{j}}
$$

which is a limiting case of Watson $q$-Whipple transformation, see Gasper and Rahman [13, III. 18] and Andrews [2, Lemma 2]. Besides, Guo and Zeng [14, p. 702] stated that it is an open problem to give partition-theoretic interpretation for (5). Recently, Andrews and Merca [7] provided such interpretations by first rewriting (4) in the following form

=1+2(-1)^{k} \frac{(-q)_{k}}{(q)_{k}} \sum_{j=0}^{\infty} \frac{q^{(k+1)(k+j+1)}\left(-q^{k+j+2}\right)_{\infty}}{\left(1-q^{j+k+1}\right)\left(q^{j+k+2}\right)_{\infty}}

and then explaining the right-hand side of this formula in terms integer partitions. The main argument in the authors' proofs for (6) is the following formula which is due to Rogers and Fine (see [16, p. 15])

Furthermore, Andrews and Merca 7 showed that both (3) and (4)) can be established as instances of (7). In this paper we shall establish positivity results for alternating sums of the partition functions $p(n)$ and $\bar{p}(n)$. We do that by showing that their corresponding generating functions have nonnegative coefficients. Specifically, we will prove the following main results.

Theorem 1. There holds

\frac{1}{(q ; q)_{\infty}} \sum_{n=0}^{\infty}(-1)^{n} q^{\frac{13 n^{2}+11 n}{2}}\left(1-q^{2 n+1}\right)=\sum_{n=0}^{\infty} \frac{q^{n^{2}+2 n}}{\left(q^{2} ; q\right)_{2 n+1}} \sum_{k=0}^{n} q^{k^{2}+k}\left[\begin{array}{l}
n \\
k
\end{array}\right]_{q} .
$$

## Corollary 1.

$$
\sum_{j=0}^{n}(-1)^{j}(p(n-j(13 j+11) / 2)-p(n-j(13 j+15) / 2-1)) \geq 0
$$

Theorem 2. We have

\frac{1}{(q ; q)_{\infty}} \sum_{n=0}^{\infty}(-1)^{n} q^{4 n(10 n-1)+4}\left(1-q^{16 n+8}\right) \\
=\sum_{n=0}^{\infty} \frac{\left(-q^{-1} ; q^{2}\right)_{n}}{(q ; q)_{2 n+3}} \sum_{k=0}^{n} \frac{q^{(n-2 k)^{2}+5 n+2 k}\left(-q^{4} ; q^{4}\right)_{k+1}}{\left(1-q^{4 k+2}\right)\left(-q^{3-2 n} ; q^{2}\right)_{2 k}}\left[\begin{array}{l}
2 n \\
2 k
\end{array}\right]_{q^{2}} .
\end{gathered}
$$

## Corollary 2.

\sum_{j=0}^{n}(-1)^{j}(\bar{p}(n-4 j(10 j+1)-4)-\bar{p}(n-4 j(10 j+3)-12)) \geq 0
$$

Theorem 3. We have

\frac{1}{(q ; q)_{\infty}} \sum_{n=0}^{\infty}(-1)^{n} q^{8 n(3 n+1)}\left(1-q^{32 n+16}\right) \\
=\sum_{n=0}^{\infty} \frac{\left(-q^{-1} ; q^{2}\right)_{n}}{\left(q^{2} ; q^{2}\right)_{n}\left(q ; q^{2}\right)_{n+2}} \sum_{k=0}^{n} \frac{q^{(n-2 k)^{2}+5 n+6 k}\left(1+q^{4 k+4}\right)}{1-q^{4 k+2}}\left[\begin{array}{c}
2 n \\
2 k
\end{array}\right]_{q^{2}} .
\end{gathered}

## Corollary 3.

\sum_{j=0}^{n}(-1)^{j}(p(n-8 j(3 j+1))-p(n-8 j(3 j+5)-16)) \geq 0

Theorem 4. There holds

\frac{1}{(q ; q)_{\infty}} \sum_{n=0}^{\infty}(-1)^{n} q^{6 n(9 n+7)}\left(1-q^{24 n+12}\right) \\
=\sum_{n=0}^{\infty} \frac{\left(-q^{-1} ; q^{2}\right)_{n}}{\left(q^{2} ; q^{2}\right)_{n}\left(q ; q^{2}\right)_{n+3}} \sum_{k=0}^{n} \frac{q^{(n-2 k)^{2}+7 n+2 k}\left(1+q^{4}+q^{8}\right)\left(1+q^{6+4 k}\right)}{\left(1-q^{2 k+2}\right)\left(1-q^{2 k+4}\right)\left(-q^{3-2 n} ; q^{2}\right)_{2 k}}\left[\begin{array}{l}
2 n \\
2 k
\end{array}\right]_{q^{2}} .

## Corollary 4.

\sum_{j=0}^{n}(-1)^{j}(\bar{p}(n-6 j(9 j+7))-\bar{p}(n-6 j(9 j+11)-12)) \geq 0
$$

The key argument of our proofs is the following extension of the Bailey's transform.
Lemma 1. [8, Lemma 1] Let $d, e, m$ and $n$ be positive integers such that $d \mid m$. Assuming convergence of the series, if

B_{n}=\sum_{j=0}^{\lfloor d n / m\rfloor} A_{e j} U_{d n-m j} V_{d n+m j} \quad \text { and } \quad C_{n}=\sum_{j=m n / d}^{\infty} D_{e j} U_{d j-m n} V_{d j+m n}
$$

then

$$
\sum_{n=0}^{\infty} A_{e n} C_{n}=\sum_{n=0}^{\infty} B_{n} D_{e n}
$$

Note that the case $d=e=m=1$ in Lemma 1 gives the classical Bailey's transform [9]. For a survey on Bailey's transform along with applications we refer for instance to [4, 5, 20, 22, 10]. We need the following well-known result

\end{equation*}

see for instance Bressoud [11, p. 215], Schilling and Warnaar [17, (1.3)], and Warnaar [21, (1.5)]. Note that according to Schilling and Warnaar [17], the pair of sequences $\left(\delta_{k}\right)_{k \geq 0}$ and $\left(\gamma_{k}\right)_{k \geq 0}$ where

\delta_{k}=a^{k} q^{k^{2}} \quad \text { and } \quad \gamma_{k}=\frac{a^{k} q^{k^{2}}}{(a q)_{\infty}}
$$

is a conjugate Bailey pair as they are connected through the relation (8). We refer the reader to [17, 21] for an survey on Bailey pairs, conjugate Bailey pairs, and applications.

## 2. Proof of Theorem 1 and Corollary 1

We need the following identity of Bressoud [11, (3.4)]

=\frac{\left(a^{2} q ; q\right)_{2 n}(q ; q)_{n}}{(a q ; q)_{n}} \sum_{k=0}^{\lfloor n / 2\rfloor} \frac{a^{2 k} \gamma^{k} q^{2 k^{2}}\left(1-a q^{2 k}\right)(a ; q)_{k}\left(\gamma^{-1} ; q\right)_{k}}{(1-a)(q ; q)_{k}(a \gamma q ; q)_{k}(q ; q)_{n-2 k}\left(a^{2} q ; q\right)_{n+2 k}} .
\end{gather*}

We want to apply Lemma 1 to (9) as follows. Let $m=2, d=e=1$ and let

U_{n}=\frac{1}{(q ; q)_{n}}, \quad V_{n}=\frac{1}{\left(a^{2} q ; q\right)_{n}} .
\end{gathered}

Then

B_{n} & =\sum_{k=0}^{\lfloor n / 2\rfloor} A_{k} U_{n-2 k} V_{n+2 k} \\
& =\sum_{k=0}^{\lfloor n / 2\rfloor} \frac{a^{2 k} \gamma^{k} q^{2 k^{2}}\left(1-a q^{2 k}\right)(a ; q)_{k}\left(\gamma^{-1} ; q\right)_{k}}{(1-a)(q ; q)_{k}(a \gamma q ; q)_{k}(q ; q)_{n-2 k}\left(a^{2} q ; q\right)_{n+2 k}} \\
& =\frac{(a q ; q)_{n}}{\left(a^{2} q ; q\right)_{2 n}(q ; q)_{n}} \sum_{k=0}^{n} a^{k} q^{k^{2}}\left[\begin{array}{l}
n \\
k
\end{array}\right]_{q} \frac{(a \gamma q ; q)_{n}}{(a \gamma q ; q)_{k}(a \gamma q ; q)_{n-k}}
\end{aligned}
$$

where the last identity follows by (9). Moreover, by virtue of identity (18) we have

$$

Then by Lemma 1, we get

\end{array}\right]_{q}}{(a \gamma q ; q)_{k}(a \gamma q ; q)_{n-k}}

=\sum_{n=0}^{\infty} A_{n} C_{n}=\frac{1}{\left(a^{2} q ; q\right)_{\infty}} \sum_{n=0}^{\infty} \frac{a^{6 n} \gamma^{n} q^{6 n^{2}}\left(1-q^{2 n}\right)(a ; q)_{n}\left(\gamma^{-1} ; q\right)_{n}}{(1-a)(q ; q)_{n}(a \gamma q ; q)_{n}}
$$

Letting $\gamma \rightarrow 0$ in (10) yields

& \frac{1}{\left(a^{2} q ; q\right)_{\infty}} \sum_{n=0}^{\infty} \frac{(-1)^{n} a^{6 n} q^{\frac{13 n^{2}-n}{2}}\left(1-a q^{2 n}\right)(a ; q)_{n}}{(1-a)(q ; q)_{n}}  \tag{11}\\
& \quad=\sum_{n=0}^{\infty} \frac{a^{2 n} q^{n^{2}}(a q ; q)_{n}}{\left(a^{2} q ; q\right)_{2 n}(q ; q)_{n}} \sum_{k=0}^{n} a^{k} q^{k^{2}}\left[\begin{array}{l}
n \\
k
\end{array}\right]_{q} .
\end{align*}

Now let $a=q$ in (11) and simplify to obtain

\frac{1}{(q ; q)_{\infty}} \sum_{n=0}^{\infty}(-1)^{n}\left(1-q^{2 n+1}\right) q^{\frac{13 n^{2}+11 n}{2}}=(1-q) \sum_{n=0}^{\infty} \frac{q^{n^{2}+2 n}}{(q ; q)_{2 n+2}} \sum_{k=0}^{n} q^{k^{2}+k}\left[\begin{array}{l}
n \\
k
\end{array}\right]_{q} .
$$

That is

\frac{1}{(q ; q)_{\infty}} \sum_{n=0}^{\infty}(-1)^{n}\left(1-q^{2 n+1}\right) q^{\frac{13 n^{2}+11 n}{2}}=\sum_{n=0}^{\infty} \frac{q^{n^{2}+2 n}}{\left(q^{2} ; q\right)_{2 n+1}} \sum_{k=0}^{n} q^{k^{2}+k}\left[\begin{array}{l}
n \\
k
\end{array}\right]_{q}
$$

which completes the proof of the theorem. As to the corollary, simply note that the left-hand side of previous formula is the generating function of

and that its right-hand side has nonnegative coefficients.

## 3. Proof of Theorem 2 and Corollary 2

We need the following formula of Berkovich and Warnaar [5, p. 36]

=\frac{q^{n}\left(-q^{-1} ; q^{2}\right)_{n}(a q ; q)_{n}}{(-q ; q)_{n}\left(a q ; q^{2}\right)_{n}} \sum_{k \geq 0} \frac{\left(b^{1 / 2},-b^{1 / 2},-a q^{4}, q^{-2 n}, q^{2-2 n} ; q^{4}\right)_{k} q^{4 k}}{\left(q^{4}, b, a q^{2},-q^{3-2 n},-q^{5-2 n} ; q^{4}\right)_{k}}
\end{gathered}
$$

which is equivalent with

= & \frac{q^{n}\left(-q^{-1} ; q^{2}\right)_{n}(a q ; q)_{n}}{(-q ; q)_{n}\left(a q ; q^{2}\right)_{n}} \sum_{k \geq 0} \frac{\left(b^{1 / 2},-b^{1 / 2},-a q^{4}, q^{-2 n}, q^{2-2 n} ; q^{4}\right)_{k} q^{4 k}}{\left(q^{4}, b, a q^{2},-q^{3-2 n},-q^{5-2 n} ; q^{4}\right)_{k}} .
\end{align*}

We apply Lemma 1 to (12) as follows. Let $m=4, d=e=1$ and let

A_{n}=\frac{b^{n} q^{4 n(2 n-1)}\left(1-a^{2} q^{16 n}\right)\left(a^{2}, a^{2} q^{4} / b ; q^{8}\right)_{n}}{\left(1-a^{2}\right)\left(q^{8}, b q^{4} ; q^{8}\right)_{n}}, \quad D_{n}=a^{n} q^{n^{2}} \\
U_{n}=\frac{1}{(q ; q)_{n}}, \quad V_{n}=\frac{1}{(a q ; q)_{n}}
\end{gathered}
$$

Then on the one hand by (12),

& =\frac{q^{n}\left(-q^{-1} ; q^{2}\right)_{n}}{(-q ; q)_{n}(q ; q)_{n}\left(a q ; q^{2}\right)_{n}} \sum_{k \geq 0} \frac{\left(b^{1 / 2},-b^{1 / 2},-a q^{4}, q^{-2 n}, q^{2-2 n} ; q^{4}\right)_{k} q^{4 k}}{\left(q^{4}, b, a q^{2},-q^{3-2 n},-q^{5-2 n} ; q^{4}\right)_{k}}
\end{aligned}
$$

On the other hand by (8),

C_{n}=\sum_{k=4 n}^{\infty} \frac{a^{k} q^{k^{2}}}{(q ; q)_{k-4 n}(a q ; q)_{k+4 n}}=\frac{a^{4 n} q^{16 n^{2}}}{(a q ; q)_{\infty}}
$$

Now apply Lemma 1 to these sequences to obtain from

$$

that

& \sum_{n=0}^{\infty} \frac{a^{n} q^{n^{2}+n}\left(-q^{-1} ; q^{2}\right)_{n}}{\left(q^{2} ; q^{2}\right)_{n}\left(a q ; q^{2}\right)_{n}} \sum_{k \geq 0} \frac{q^{4 k}\left(b^{1 / 2},-b^{1 / 2},-a q^{4}, q^{-2 n}, q^{2-2 n} ; q^{4}\right)_{k}}{\left(q^{4}, b, a q^{2},-q^{3-2 n},-q^{5-2 n} ; q^{4}\right)_{k}}  \tag{13}\\
& \quad=\frac{1}{(a q ; q)_{\infty}} \sum_{n=0}^{\infty} a^{4 n} b^{n} q^{24 n^{2}-4 n} \frac{\left(1-a^{2} q^{16 n}\right)\left(a^{2}, a^{2} q^{4} / b ; q^{8}\right)_{n}}{\left(1-a^{2}\right)\left(q^{8}, b q^{4} ; q^{8}\right)_{n}}
\end{align*}
$$

Letting in (13) $b \rightarrow 0$ and then $a=q^{4}$ we obtain

\frac{1}{\left(q^{5} ; q\right)_{\infty}} \sum_{n=0}^{\infty}(-1)^{n} q^{40 n^{2}-4 n+4} \frac{1-q^{16 n+8}}{1-q^{8}} \\
=\sum_{n=0}^{\infty} \frac{q^{n^{2}+5 n}\left(-q^{-1} ; q^{2}\right)_{n}}{\left(q^{2} ; q^{2}\right)_{n}\left(q^{5} ; q^{2}\right)_{n}} \sum_{k \geq 0} \frac{\left(-q^{8} ; q^{4}\right)_{k}\left(q^{-2 n} ; q^{2}\right)_{2 k}}{\left(q^{4} ; q^{4}\right)_{k}\left(q^{6} ; q^{4}\right)_{k}\left(-q^{3-2 n} ; q^{2}\right)_{2 k} q^{4 k}},
\end{gathered}

which after some straightforward simplification yields

\frac{1}{(q)_{\infty}} \sum_{n=0}^{\infty}(-1)^{n} q^{40 n^{2}-4 n+4}\left(1-q^{16 n+8}\right) \\
=\sum_{n=0}^{\infty} \frac{q^{n^{2}+5 n}\left(-q^{-1} ; q^{2}\right)_{n}}{(q ; q)_{2 n+3}} \sum_{k=0}^{n} \frac{q^{4 k^{2}+2 k-4 n k}\left(-q^{4} ; q^{4}\right)_{k+1}\left(q^{2} ; q^{2}\right)_{2 n}}{\left(q^{2} ; q^{2}\right)_{2 k+1}\left(q^{2} ; q^{2}\right)_{2 n-2 k}\left(-q^{3-2 n} ; q^{2}\right)_{2 k}},
\end{gathered}
$$

or equivalently,

$$
\begin{gather*}
\frac{1}{(q)_{\infty}} \sum_{n=0}^{\infty}(-1)^{n} q^{40 n^{2}-4 n+4}\left(1-q^{16 n+8}\right)  \tag{14}\\
=\sum_{n=0}^{\infty} \frac{\left(-q^{-1} ; q^{2}\right)_{n}}{(q ; q)_{2 n+3}} \sum_{k=0}^{n} \frac{q^{(n-2 k)^{2}+5 n+2 k}\left(-q^{4} ; q^{4}\right)_{k+1}}{\left(1-q^{4 k+2}\right)\left(-q^{3-2 n} ; q^{2}\right)_{2 k}}\left[\begin{array}{l}
2 n \\
2 k
\end{array}\right]_{q^{2}} .
\end{gather*}
$$

This proves the theorem. Concerning the corollary, multiply both sides of (14) by $(-q ; q)_{\infty}$. Then by (11) the left-hand side of the obtained formula is the generating function of

$$
\sum_{j=0}^{n}(-1)^{j}(\bar{p}(n-4 j(10 j+1)-4)-\bar{p}(n-4 j(10 j+3)-12))
$$

Moreover, it is easily seen that the right-hand side of the obtained formula has nonnegative coefficients. This completes the proof.

## 4. Proof of Theorem 3 and Corollary 3

As to this result we shall appeal to the following formula of Berkovich and Warnaar [10, p. 36]

$$
\begin{gathered}
\sum_{k=0}^{\lfloor n / 4\rfloor} \frac{\left(1-a^{4} q^{32 k}\right)\left(a^{4} ; q^{16}\right)_{k}\left(q^{-n} ; q\right)_{4 k}}{\left.\left(1-a^{4}\right)\left(q^{16} ; q^{16}\right)_{k}\right)\left(a q^{n+1} ; q\right)_{4 k}}\left(-q^{4 n-6}\right)^{k} \\
=q^{n} \frac{\left(a q^{-1} ; q^{2}\right)_{n}(a q ; q)_{n}}{(-q ; q)_{n}\left(a q ; q^{2}\right)_{n}} \sum_{k \geq 0} \frac{\left(i q^{-2},-i q^{-2},-a q^{4}, q^{-2 n}, q^{2-2 n} ; q^{4}\right)_{k}}{\left(q^{4},-q^{4}, a q^{2}, q^{3-2 n}, q^{5-2 n} ; q^{4}\right)_{k}} q^{8 k}
\end{gathered}
$$

which after simplification yields

$$
\begin{align*}
& \sum_{k=0}^{\lfloor n / 4\rfloor}(-1)^{k} q^{8 k^{2}-8 k} \frac{\left(1-a^{4} q^{32 k}\right)\left(a^{4} ; q^{16}\right)_{k}}{\left(1-a^{4}\right)\left(q^{16} ; q^{16}\right)_{k}(q ; q)_{n-4 k}(a q ; q)_{n+4 k}}  \tag{15}\\
= & \frac{q^{n}\left(-q^{-1} ; q^{2}\right)_{n}}{\left(q^{2} ; q^{2}\right)_{n}\left(a q ; q^{2}\right)_{n}} \sum_{k \geq 0} \frac{q^{8 k}\left(-q^{4} ; q^{8}\right)_{k}\left(q^{-2 n} ; q^{2}\right)_{2 k}\left(-a q^{4} ; q^{4}\right)_{k}}{\left(-q^{8} ; q^{8}\right)_{k}\left(a q^{2} ; q^{4}\right)_{k}\left(q^{3-2 n} ; q^{2}\right)_{2 k}} .
\end{align*}
$$

Let $m=4$ and $d=e=1$ and let

$$
\begin{gathered}
A_{n}=\frac{(-1)^{n} q^{2 n(4 n-4)}\left(1-a^{4} q^{32 n}\right)\left(a^{4} ; q^{16}\right)_{n}}{\left(1-a^{4}\right)\left(q^{16} ; q^{16}\right)_{n}}, \quad D_{n}=a^{n} q^{n^{2}} \\
U_{n}=\frac{1}{(q ; q)_{n}}, \quad V_{n}=\frac{1}{(a q ; q)_{n}}
\end{gathered}
$$

Then by (15),

$$
\begin{aligned}
B_{n} & =\sum_{j=0}^{\lfloor n / 4\rfloor} A_{j} U_{n-4 j} V_{n+4 j} \\
& =\frac{q^{n}\left(-q^{-1} ; q^{2}\right)_{n}}{\left(q^{2} ; q^{2}\right)_{n}\left(a q ; q^{2}\right)_{n}} \sum_{k \geq 0} \frac{q^{8 k}\left(-q^{4} ; q^{8}\right)_{k}\left(q^{-2 n} ; q^{2}\right)_{2 k}\left(-a q^{4} ; q^{4}\right)_{k}}{\left(-q^{8} ; q^{8}\right)_{k}\left(a q^{2} ; q^{4}\right)_{k}\left(q^{3-2 n} ; q^{2}\right)_{2 k}}
\end{aligned}
$$

and by (8),

$$
C_{n}=\sum_{k=4 n}^{\infty} \frac{a^{k} q^{k^{2}}}{(q ; q)_{k-4 n}(a q ; q)_{k+4 n}}=\frac{a^{4 n} q^{16 n^{2}}}{(a q ; q)_{\infty}}
$$

Thus by virtue of Lemma 1

$$
\sum_{n=0}^{\infty} B_{n} D_{n}=\sum_{n=0}^{\infty} A_{n} C_{n}
$$

and therefore

$$
\begin{gathered}
\sum_{n=0}^{\infty} \frac{a^{n} q^{n^{2}+n}\left(-q^{-1} ; q^{2}\right)_{n}}{\left(q^{2} ; q^{2}\right)_{n}\left(a q ; q^{2}\right)_{n}} \sum_{k \geq 0} \frac{q^{8 k}\left(-q^{4} ; q^{8}\right)_{k}\left(q^{-2 n} ; q^{2}\right)_{2 k}\left(-a q^{4} ; q^{4}\right)_{k}}{\left(-q^{8} ; q^{8}\right)_{k}\left(q^{3-2 n} ; q^{2}\right)_{2 k}\left(a q^{2} ; q^{4}\right)_{k}} \\
=\frac{1}{(a q ; q)_{\infty}} \sum_{n=0}^{\infty}(-1)^{n} a^{4 n} q^{24 n^{2}-8 n} \frac{\left(1-a^{4} q^{32 n}\right)\left(a^{4} ; q^{16}\right)_{n}}{\left(1-a^{4}\right)\left(q^{16} ; q^{16}\right)_{n}}
\end{gathered}
$$

Letting in the foregoing identity $a=q^{4}$ and simplifying give

$$
\begin{gathered}
\frac{1}{\left(q^{5} ; q\right)_{\infty}} \sum_{n=0}^{\infty}(-1)^{n} q^{24 n^{2}+8 n} \frac{1-q^{32 n+16}}{1-q^{8}} \\
=\sum_{n=0}^{\infty} \frac{q^{n^{2}+5 n}\left(-q^{-1} ; q^{2}\right)_{n}}{\left(q^{2} ; q^{2}\right)_{n}\left(q^{5} ; q^{2}\right)_{n}} \sum_{k \geq 0} \frac{1+q^{4 k+4}}{1+q^{4}} \frac{q^{4 k^{2}+6 k-4 n k}\left(-q^{4} ; q^{8}\right)_{k}\left(q^{2} ; q^{2}\right)_{2 n}}{\left(q^{4} ; q^{4}\right)_{k}\left(q^{6} ; q^{4}\right)_{k}\left(q^{2} ; q^{2}\right)_{2 n-2 k}\left(q^{3-2 n} ; q^{2}\right)_{2 k}}
\end{gathered}
$$

which by rearranging becomes

$$
\begin{gathered}
\frac{1}{(q ; q)_{\infty}} \sum_{n=0}^{\infty}(-1)^{n} q^{8 n(3 n+1)}\left(1-q^{32 n+16}\right) \\
=\sum_{n=0}^{\infty} \frac{\left(-q^{-1} ; q^{2}\right)_{n}}{\left(q^{2} ; q^{2}\right)_{n}\left(q ; q^{2}\right)_{n+2}} \sum_{k=0}^{n} \frac{q^{(n-2 k)^{2}+5 n+6 k}\left(1+q^{4 k+4}\right)}{1-q^{4 k+2}}\left[\begin{array}{l}
2 n \\
2 k
\end{array}\right]_{q^{2}} .
\end{gathered}
$$

which proves the theorem. The corollary follows immediately as the left-hand side of the foregoing formula is the generating function of

$$
\sum_{j=0}^{n}(-1)^{j}(p(n-8 j(3 j+1))-p(n-8 j(3 j+5)-16))
$$

and its right-hand side has nonnegative coefficients.

## 5. Proof of Theorem 4 and Corollary 4

The proof relies on the following relation due to Berkovich and Warnaar [10, p. 36]

$$
\begin{gathered}
\sum_{k=0}^{\lfloor n / 6\rfloor} \frac{\left(1-a^{2} q^{24 k}\right)\left(a^{2} ; q^{12}\right)_{k}\left(q^{-n} ; q\right)_{6 k}}{\left(q^{12} ; q^{12}\right)_{k}\left(a q^{n+1} ; q\right)_{6 k}}\left(-a^{2} q^{6 n-3}\right)^{k} \\
=\frac{q^{n}\left(-q^{-1} ; q^{2}\right)_{n}(a q ; q)_{n}}{(-q ; q)_{n}\left(a q ; q^{2}\right)_{n}} \sum_{k \geq 0} \frac{q^{4 k}\left(a^{2 / 3}, \omega a^{2 / 3}, \omega^{2} a^{2 / 3},-a q^{4}, q^{-2 n}, q^{2-2 n} ; q^{4}\right)_{k}}{\left(q^{4}, a,-a, a q^{2},-q^{3-2 n},-q^{5-2 n} ; q^{4}\right)_{k}}
\end{gathered}
$$

where $\omega$ is a third root of unity. Then the previous formula becomes

$$
\begin{align*}
& \quad \sum_{k=0}^{\lfloor n / 6\rfloor}(-1)^{k} a^{2 k} q^{18 k^{2}-6 k} \frac{\left(1-a^{2} q^{24 k}\right)\left(a^{2} ; q^{12}\right)_{k}}{\left(1-a^{2}\right)\left(q^{12} ; q^{12}\right)_{k}(q ; q)_{n-6 k}(a q ; q)_{n+6 k}}  \tag{16}\\
& =\frac{q^{n}\left(-q^{-1} ; q^{2}\right)_{n}}{\left(q^{2} ; q^{2}\right)_{n}\left(a q ; q^{2}\right)_{n}} \sum_{k \geq 0} \frac{q^{4 k}\left(a^{2 / 3}, \omega a^{2 / 3}, \omega^{2} a^{2 / 3} ; q^{4}\right)_{k}\left(q^{-2 n} ; q^{2}\right)_{2 k}\left(-a q^{4} ; q^{4}\right)_{k}}{\left(q^{4}, a,-a, a q^{2} ; q^{4}\right)_{k}\left(-q^{3-2 n} ; q^{2}\right)_{2 k}} .
\end{align*}
$$

Let $m=6, d=e=1$ and let

$$
\begin{gathered}
A_{n}=\frac{(-1)^{n} a^{2 n} q^{3 n(6 n-2)}\left(1-a^{2} q^{24 n}\right)\left(a^{2} ; q^{12}\right)_{n}}{\left(1-a^{2}\right)\left(q^{12} ; q^{12}\right)_{n}}, \quad D_{n}=a^{n} q^{n^{2}} \\
U_{n}=\frac{1}{(q ; q)_{n}}, \quad V_{n}=\frac{1}{(a q ; q)_{n}}
\end{gathered}
$$

Thus by Lemma 1 applied to these items we find

$$
\begin{gathered}
\sum_{n=0}^{\infty} \frac{a^{n} q^{n^{2}+n}\left(-q^{-1} ; q^{2}\right)_{n}}{\left(q^{2} ; q^{2}\right)_{n}\left(a q ; q^{2}\right)_{n}} \sum_{k \geq 0} \frac{q^{4 k}\left(a^{2 / 3}, \omega a^{2 / 3}, \omega^{2} a^{2 / 3},-a q^{4} ; q^{4}\right)_{k}\left(q^{-2 n} ; q^{2}\right)_{2 k}}{\left(q^{4}, a,-a, a q^{2} ; q^{4}\right)_{k}\left(-q^{3-2 n} ; q^{2}\right)_{2 k}} \\
=\frac{1}{(a q ; q)_{\infty}} \sum_{n=0}^{\infty}(-1)^{n} a^{8 n} q^{54 n^{2}-6 n} \frac{\left(1-a^{2} q^{24 n}\right)\left(a^{2} ; q^{12}\right)_{n}}{\left(1-a^{2}\right)\left(q^{12} ; q^{12}\right)_{n}}
\end{gathered}
$$

Letting $a=q^{6}$ in the forgoing formula we find after easy simplification, including basic facts on $\omega$,

$$
\begin{gathered}
\frac{1}{\left(q^{7} ; q\right)_{\infty}} \sum_{n=0}^{\infty}(-1)^{n} q^{54 n^{2}+42 n} \frac{1-q^{24 n+12}}{1-q^{12}} \\
=\sum_{n=0}^{\infty} \frac{q^{n^{2}+7 n}\left(-q^{-1} ; q^{2}\right)_{n}}{\left(q^{2} ; q^{2}\right)_{n}\left(q^{7} ; q^{2}\right)_{n}} \sum_{k \geq 0} \frac{q^{4 k}\left(1+q^{4}+q^{8}\right)\left(-q^{10} ; q^{4}\right)_{k}\left(q^{-2 n} ; q^{2}\right)_{2 k}}{\left(q^{12} ; q^{8}\right)_{k}\left(q^{8} ; q^{4}\right)_{k}\left(-q^{3-2 n} ; q^{2}\right)_{2 k}},
\end{gathered}
$$

or equivalently,

$$
\begin{gathered}
\frac{1}{\left(q^{6} ; q\right)_{\infty}} \sum_{n=0}^{\infty}(-1)^{n} q^{54 n^{2}+42 n}\left(1-q^{24 n+12}\right) \\
=\sum_{n=0}^{\infty} \frac{q^{n^{2}+7 n}\left(-q^{-1} ; q^{2}\right)_{n}}{\left(q^{2} ; q^{2}\right)_{n}\left(q^{7} ; q^{2}\right)_{n}} \sum_{k \geq 0} \frac{q^{4 k}\left(1+q^{4}+q^{8}\right)\left(1+q^{6+4 k}\right)\left(q^{-2 n} ; q^{2}\right)_{2 k}}{\left(q^{6} ; q^{4}\right)_{k}\left(q^{8} ; q^{4}\right)_{k}\left(-q^{3-2 n} ; q^{2}\right)_{2 k}},
\end{gathered}
$$

which yields,

$$
\begin{gathered}
\frac{1}{(q ; q)_{\infty}} \sum_{n=0}^{\infty}(-1)^{n} q^{54 n^{2}+42 n}\left(1-q^{24 n+12}\right) \\
=\sum_{n=0}^{\infty} \frac{q^{n^{2}+7 n}\left(-q^{-1} ; q^{2}\right)_{n}}{\left(q^{2} ; q^{2}\right)_{n}\left(q ; q^{2}\right)_{n+3}} \sum_{k \geq 0} \frac{q^{4 k^{2}+2 k-4 n k}\left(1+q^{4}+q^{8}\right)\left(1+q^{6+4 k}\right)\left(q^{2} ; q^{2}\right)_{2 n}}{\left(q^{2} ; q^{4}\right)_{k+1}\left(q^{4} ; q^{4}\right)_{k+1}\left(q^{2} ; q^{2}\right)_{2 n-2 k}\left(-q^{3-2 n} ; q^{2}\right)_{2 k}} .
\end{gathered}
$$

That is,

$$
\begin{gathered}
\frac{1}{(q ; q)_{\infty}} \sum_{n=0}^{\infty}(-1)^{n} q^{54 n^{2}+42 n}\left(1-q^{24 n+12}\right) \\
=\sum_{n=0}^{\infty} \frac{\left(-q^{-1} ; q^{2}\right)_{n}}{\left(q^{2} ; q^{2}\right)_{n}\left(q ; q^{2}\right)_{n+3}} \sum_{k=0}^{n} \frac{q^{(n-2 k)^{2}+7 n+2 k}\left(1+q^{4}+q^{8}\right)\left(1+q^{6+4 k}\right)}{\left(1-q^{2 k+2}\right)\left(1-q^{2 k+4}\right)\left(-q^{3-2 n} ; q^{2}\right)_{2 k}}\left[\begin{array}{l}
2 n \\
2 k
\end{array}\right]_{q^{2}}
\end{gathered}
$$

which confirms the theorem. To prove the corollary, first multiply both sides of the previous identity by $(-q ; q)_{\infty}$. Next observe that the left-hand side of the obtained formula is the generating function of

$$
\sum_{j=0}^{n}(-1)^{j}(\bar{p}(n-6 j(9 j+7))-\bar{p}(n-6 j(9 j+11)-12))
$$

and the right-hand side of the obtained formula has nonnegative coefficients. This completes the proof.

## 6. Concluding remarks and open questions

Each one of our proofs for Theorems 1-4 relies on substituting specific values for the parameter $a$ which lead to the appropriate formulas. By choosing different values for $a$ one might derive other important results. For instance, upon letting in the relation (11) $a \rightarrow 1$ instead of $a=q$, we get after simplification

$$
\frac{1}{(q ; q)_{\infty}} \sum_{n=0}^{\infty}(-1)^{n}\left(1+q^{n}\right) q^{\frac{13 n^{2}-n}{2}}=\sum_{n=0}^{\infty} \sum_{k=0}^{n} \frac{q^{n^{2}+k^{2}}}{(q ; q)_{2 n}}\left[\begin{array}{l}
n  \tag{17}\\
k
\end{array}\right]_{q}
$$

or equivalently

$$
\frac{1}{(q ; q)_{\infty}} \sum_{n=-\infty}^{\infty}(-1)^{n} q^{\frac{13 n^{2}+n}{2}}=\sum_{n=0}^{\infty} \sum_{k=0}^{n} \frac{q^{n^{2}+k^{2}}}{(q ; q)_{2 n}}\left[\begin{array}{l}
n  \tag{18}\\
k
\end{array}\right]_{q}
$$

In addition, Andrews [1, formula (5.8) for $k=1$ ] and Warnaar [20, Theorem 1.2 for $k=4$ ] evaluated the right-hand side of (18) as follows

$$
\sum_{n=0}^{\infty} \sum_{k=0}^{n} \frac{q^{n^{2}+k^{2}}}{(q ; q)_{2 n}}\left[\begin{array}{l}
n  \tag{19}\\
k
\end{array}\right]_{q}=\frac{\left(q^{6}, q^{7}, q^{13} ; q^{13}\right)_{\infty}}{(q ; q)_{\infty}}
$$

Then by a combination of (18) and (19) we deduce

$$
\begin{equation*}
\frac{1}{(q ; q)_{\infty}} \sum_{n=-\infty}^{\infty}(-1)^{n} q^{\frac{13 n^{2}+n}{2}}=\frac{\left(q^{6}, q^{7}, q^{13} ; q^{13}\right)_{\infty}}{(q ; q)_{\infty}} \tag{20}
\end{equation*}
$$

which is also easily obtained by Jacobi's triple product identity [13, p. 15]

$$
\begin{equation*}
\left(z q, z^{-1} q, q 2 ; q^{2}\right)_{\infty}=\sum_{n=-\infty}^{\infty}(-1)^{n} q^{n^{2}} z^{n} \tag{21}
\end{equation*}
$$

applied to $z=q^{1 / 2}$ and $q$ replaced by $q^{13 / 2}$. Therefore both (18) and (20) imply that the power series

$$
\frac{1}{(q ; q)_{\infty}} \sum_{n=-\infty}^{\infty}(-1)^{n} q^{\frac{13 n^{2}+n}{2}}
$$

has nonnegative coefficients. Besides, it turns out that for any nonnegative odd integer $M$ we find by (21) that

$$
\frac{1}{(q ; q)_{\infty}} \sum_{n=-\infty}^{\infty}(-1)^{n} q^{\frac{M n^{2}+n}{2}}=\frac{\left(q^{(M-1) / 2}, q^{(M+1) / 2}, q^{M} ; q^{M}\right)_{\infty}}{(q ; q)_{\infty}}
$$

showing that the left-hand side of this formula has nonnegative integer coefficients. However, we do not how to arrive at this fact using Lemma 1 This would suggest a general pattern for our proofs in Theorems 1-4. Obviously, the first challenging part is how to obtain a terminating identity of the form

$$
\sum_{k=0}^{\lfloor n / m\rfloor} \frac{A_{k}(a, q)}{(q ; q)_{n-m k}(a q ; q)_{n+m k}}=B_{n}(a, q)
$$

where $A_{k}(a, q)$ and $B_{n}(a, q)$ are rational functions of $a$ and $q$. Furthermore, as each one of the alternating sums in Corollaries 1-4 are nonnegative, it is natural to ask the question whether combinatorial interpretations exist for such sums.
