THE RIGOROUS DERIVATION OF THE \mathbb{T}^2 Focusing cubic NLS from 3D

SHUNLIN SHEN

ABSTRACT. We derive rigorously the 2D periodic focusing cubic NLS as the mean-field limit of the 3D focusing quantum many-body dynamics describing a dilute Bose gas with periodic boundary condition in the *x*-direction and a well of infinite-depth in the *z*-direction. Physical experiments for these systems are scarce. We find that, to fulfill the empirical requirement for observing NLS dynamics in experiments, namely, the kinetic energy dominates the potential energy, it is necessary to impose an extra restriction on the system parameters. This restriction gives rises to an unusual coupling constant.

1. INTRODUCTION

Boes-Einstein condensate (BEC) is the phenomenon that occurs when particles the same quantum state. The first experimental observation of BEC in an interacting atomic gas occurred in 1995, using laser cooling techniques [2, 29].

Let $t \in \mathbb{R}$ be the time variable and $\mathbf{r}_N = (r_1, r_2, ..., r_N) \in \mathbb{R}^{3N}$ be the position vector of N particles in \mathbb{R}^3 . Then BEC naively means that the N-body wave function $\psi_N(t, \mathbf{r}_N)$ satisfies

$$\psi_N(t, \mathbf{r}_N) \sim \prod_{j=1}^N \varphi(t, r_j)$$

up to a phase factor solely depending on t, for some one particle state φ . That is, every particle takes the same quantum state. Equivalently, there is the Penrose-Onsager formulation of BEC: if we take $\gamma_N^{(k)}$ be the k-particle marginal densities associated with ψ_N by

$$\gamma_N^{(k)}(t, \mathbf{r}_k, \mathbf{r}'_k) = \int \psi_N(t, \mathbf{r}_k, \mathbf{r}_{N-k}) \overline{\psi}_N(t, \mathbf{r}'_k, \mathbf{r}_{N-k}) d\mathbf{r}_{N-k}, \quad \mathbf{r}_k, \mathbf{r}'_k \in \mathbb{R}^{3k}.$$

Then BEC equivalently means

(1.2)
$$\gamma_N^{(k)}(t, \mathbf{r}_k, \mathbf{r}'_k) \sim \prod_{j=1}^k \varphi(t, r_j) \overline{\varphi}(t, r'_j)$$

It is widely believed that the cubic nonlinear Schrödinger equation (NLS)

(1.3)
$$i\partial_t \varphi = -\Delta \varphi + \mu |\varphi|^2 \varphi,$$

which is called focusing if $\mu < 0$ and defocusing $\mu > 0$, describes BEC in the sense that φ satisfies NLS. In this paper, we are interested in the focusing case. There have been many physical experiments [28, 30, 46, 66] and mathematical results [21, 23, 24, 52, 54, 55, 58] regarding the focusing case. However, from the experiment [28], one infers that not only it is very difficult to prove the 3D focusing NLS as the mean-field limit of a 3D focusing quantum many-body dynamic, but such a limit also may not be true. Thus, in focusing settings, both physical experiments and mathematical results emphasize one dimensional and two dimensional behaviours. To our knowledge, physical experiments regarding the two dimensional behavior in the real-world three dimensional setting are limited and the corresponding mathematical research only studies the two dimensional behaviour in 2D. Therefore, we turn our attention to the derivation of 2D focusing NLS from 3D. Interestingly, our analysis produces an unusual microscopic-to-macroscopic coupling constant and might provide some suggestions to the experiment. To expect a two-dimensional behaviour, we should confine a large number of bosons inside a trap with strong confinement in one direction. We consider a simple physical model, namely, quantum many-body dynamics with periodic boundary condition in the *x*-direction

and a well of infinite-depth in the z-direction¹. Such model with strong restriction in one direction was first considered by Schnee and Yngvason [62] for the defocusing time-independent problem. Then, the defocusing time-dependent 3D-to-2D program was studied by X. Chen and Holmer in [19], in which they used the quadratic potential $|\cdot|^2$ to represent the trap. Here, we model the trap by using a well of infinite-depth in the z-direction. That is, we consider the Hamiltonian (see [62])

(1.4)
$$H_{N,L,a} = \sum_{j=1}^{N} (-\Delta_{r_j} + L^{-2} V^{\perp}(z_j/L)) + \sum_{1 \le i < j \le N} \frac{1}{a^{3\beta-1}} V\left(\frac{r_i - r_j}{a^{\beta}}\right),$$

where

$$V^{\perp}(z) = \begin{cases} 1, & z \in (-\pi/2, \pi/2), \\ \infty, & z \notin (-\pi/2, \pi/2). \end{cases}$$

For parameter a, the scaling of the interaction potential, we consider the case, which is called Region I in [62]. Schnee and Yngvason define g = g(N, L, a) as follows

$$g \sim (-\ln(L^2\overline{\rho}) + L/a)^{-1},$$

where $\overline{\rho}$ is the mean density. The Gross-Pitaevskii limit means $Ng \sim 1$ and hence $\overline{\rho} \sim N$. Then, the term a/L dominates in the definition of g. Therefore,

$$1 \sim Ng \sim Na/L \iff a \sim L/N.$$

For mathematical convenience, we take a = L/N and consider the Hamiltonian

(1.5)
$$H_{N,L} = \sum_{j=1}^{N} -\Delta_{r_j} + \frac{L}{N-1} \sum_{1 \le i < j \le N} V_{N,L} (r_i - r_j).$$

acing on the Hilbert space $L^2_s(\Omega_L^{\otimes N})$, the subspace of $L^2(\Omega_L^{\otimes N})$ consisting of functions that are symmetric with respect to permutations of the N particles, where

$$V_{N,L}(r_i - r_j) = (N/L)^{3\beta} V \left((N/L)^{\beta} (r_i - r_j) \right)$$

and the domain² $\Omega_L = (-\pi, \pi)^2 \times (-L\pi/2, L\pi/2)$. As $L \to 0$, we see that the particles are strongly confined in the z-direction. For more detailed analysis of system parameters, also see [19].

We take the periodic boundary condition³ in the x-direction and Dirichlet boundary condition in the z-direction. We will derive rigorously \mathbb{T}^2 focusing cubic NLS from the 3D quantum many-body dynamic. For simplicity, we take $\cos_L(z) = (2/\pi)^{1/2} \cos(z/L)/L^2$, which is the normalized ground state eigenfunction. With the lowest energy, we notice that, as $L \to 0$, $\cos_L(z)$ has infinite energy. Thus, our main theorem is better to be stated regarding the renormalization.

Let $\psi_{N,L}(t,\cdot) = e^{it\bar{H}_{N,L}}\psi_{N,L}(0,\cdot)$ denote the evolution of this initial data corresponding to the Hamiltonian operator (1.5). Define the rescaled solution

(1.6)
$$\widetilde{\psi}_{N,L}(t,\mathbf{r}_N) \stackrel{def}{=} L^{N/2} \psi_{N,L}(t,\mathbf{x}_N,L\mathbf{z}_N), \quad \mathbf{r}_N \in \mathbb{T}^{2N} \times (-\pi/2,\pi/2)^N,$$

and the rescaled Hamiltonian

$$\widetilde{H}_{N,L} = \sum_{j=1}^{N} \left(-\Delta_{x_j} - \frac{1}{L^2} \partial_{z_j}^2 \right) + \frac{1}{N-1} \sum_{1 \le i < j \le N} \widetilde{V}_{N,L}(r_i - r_j),$$

where

(1.8)
$$\widetilde{V}_{N,L}(r) = L \left(N/L \right)^{3\beta} V \left((N/L)^{\beta} x, L(N/L)^{\beta} z \right)$$

Then

$$\left(\widetilde{H}_{N,L}\widetilde{\psi}_{N,L}\right)\left(t,\mathbf{x}_{N},\mathbf{z}_{N}\right) = L^{N/2}\left(H_{N,L}\psi_{N,L}\right)\left(t,\mathbf{x}_{N},L\mathbf{z}_{N}\right)$$

Definition 1.1. We denote C_{gn} the sharp constant of the 2D inhomogeneous Gagliardo-Nirenberg estimate⁴ on torus:

$$\|\phi\|_{L^4(\mathbb{T}^2)} \le C_{gn} \|\phi\|_{L^2(\mathbb{T}^2)}^{\frac{1}{2}} \|\sqrt{1-\Delta}\phi\|_{L^2(\mathbb{T}^2)}^{\frac{1}{2}}.$$

Theorem 1.2. Assume $L(N/L)^{\beta} \to 1^{-5}$ and the pair interaction V is an even nonpositive smooth function compactly support on Ω such that $\|V\|_{L^{\infty}_{z}L^{1}_{x}} \leq \frac{2\alpha}{C_{gn}^{4}}$ for some $\alpha \in (0,1)$. Let $\{\widetilde{\gamma}^{(k)}_{N,L}(t,\mathbf{r}_{k},\mathbf{r}'_{k})\}$ be the family of marginal densities associated with the 3D rescaled Hamiltonian evolution $\widetilde{\psi}_{N,L}(t) = e^{it\widetilde{H}_{N,L}}\widetilde{\psi}_{N,L}(0)$ for $\beta \in (0,3/7)$. Suppose the initial datum $\widetilde{\psi}_{N,L}(0)$ satisfies the following: (i) $\widetilde{\psi}_{N,L}(0)$ is normalized, that is, $\|\widetilde{\psi}_{N,L}(0)\|_{L^{2}} = 1$,

 $(i) \ \psi_{N,L}(0) \ is \ normalized, \ indicate \ is, \ \|\psi_{N,L}(0)\|_{L^{2}} = 1,$

(ii) $\psi_{N,L}(0)$ is asymptotically factorized in the sense that

$$\lim_{N,1/L\to\infty} Tr \left| \widetilde{\gamma}_{N,L}^{(1)}(0,x_1,z_1;x_1',z_1') - \frac{2}{\pi} \phi_0(x_1) \overline{\phi_0}(x_1') \cos(z_1) \cos(z_1') \right| = 0,$$

for some one particle state $\phi_0 \in H^1(\mathbb{T}^2)$,

(iii) Away from the z-direction ground state energy, $\tilde{\psi}_{N,L}(0)$ has finite energy per particle

$$\sup_{N,L} \langle \widetilde{\psi}_{N,L}(0), (N^{-1}\widetilde{H}_{N,L} - 1/L^2) \widetilde{\psi}_{N,L}(0) \rangle \le C.$$

Then $\forall k \geq 1, t \geq 0$, we have the convergence in trace norm that

where $\phi(t, x)$ solves the 2D periodic focusing cubic NLS with coupling constant

$$g_0 = \frac{4}{\pi^2} \int \int V(x, z_1 - z_2) dx |\cos(z_1) \cos(z_2)|^2 dz_1 dz_2 < 0,$$

 $that \ is$

(1.11)
$$i\partial_t \phi = -\Delta_x \phi + g_0 |\phi|^2 \phi,$$

with initial condition $\phi(0, x) = \phi_0(x)$.

It is well-known that Theorem 1.2 is equivalent to Theorem 1.3 by the method of Erdös, Schlein, and Yau [32, 33, 34, 35, 36].

Theorem 1.3. Assume $L(N/L)^{\beta} \to 1^{-}$ and the pair interaction V is an even nonpositive smooth function compactly support on Ω such that $\|V\|_{L^{\infty}_{x}L^{1}_{x}} \leq \frac{2\alpha}{C_{gn}^{4}}$ for some $\alpha \in (0,1)$. Let $\{\widetilde{\gamma}^{(k)}_{N,L}(t,\mathbf{r}_{k},\mathbf{r}'_{k})\}$ be the family of marginal densities associated with the 3D rescaled Hamiltonian evolution $\widetilde{\psi}_{N,L}(t) = e^{it\widetilde{H}_{N,L}}\widetilde{\psi}_{N,L}(0)$ for $\beta \in (0,3/7)$. Suppose the initial datum $\widetilde{\psi}_{N,L}(0)$ is normalized asymptotically factorized and satisfies the energy condition that

(iii') there is a constant C > 0 such that

$$\sup_{N,L} \langle \widetilde{\psi}_{N,L}(0), (N^{-1}\widetilde{H}_{N,L} - 1/L^2)^k \widetilde{\psi}_{N,L}(0) \rangle \le C^k, \quad \forall k \ge 1$$

Then $\forall k \geq 1, t \geq 0$, we have the convergence in trace norm that

where $\phi(t, x)$ solves the 2D periodic focusing cubic NLS with the coupling constant

$$g_0 = \frac{4}{\pi^2} \int \int V(x, z_1 - z_2) dx |\cos(z_1)\cos(z_2)|^2 dz_1 dz_2 < 0,$$

that is (1.12)

$$i\partial_t\phi = -\Delta_x\phi + g_0|\phi|^2\phi,$$

with initial condition $\phi(0, x) = \phi_0(x)$.

For $\beta < 1/3$, our exact proof also works for the case in which we put \mathbb{R}^2 in the x-direction.

Theorem 1.4. Under the same condition of Theorem 1.2 with $\beta \in (0, 1/3)$, then $\forall k \ge 1, t \ge 0$, we have the convergence in trace norm that

$$\lim_{\substack{N,1/L\to\infty\\L(N/L)^{\beta}\to 1^{-}}} Tr \left| \widetilde{\gamma}_{N,L}^{(k)}(t, \mathbf{x}_k, \mathbf{z}_k; \mathbf{x}'_k, \mathbf{z}'_k) - \prod_{j=1}^k \frac{2}{\pi} \phi(t, x_j) \overline{\phi}(t, x'_j) \cos(z_j) \cos(z'_j) \right| = 0,$$

where $\phi(t, x)$ solves the 2D focusing cubic NLS with the coupling constant

$$g_0 = \frac{4}{\pi^2} \int \int V(x, z_1 - z_2) dx |\cos(z_1)\cos(z_2)|^2 dz_1 dz_2 < 0,$$

that is (1.13)

$$i\partial_t \phi = -\Delta_x \phi + g_0 |\phi|^2 \phi_t$$

with initial condition $\phi(0, x) = \phi_0(x) \in H^1(\mathbb{R}^2)$.

We notice that Theorems 1.2 – 1.3 carry an extra requirement $L(N/L)^{\beta} \to 1^{-}$ and a different coupling constant⁶, if compared to the previous work, for example [19, 23, 24], in which the constant is usually $\int V$ or the scattering length of V. It emerges from the empirical requirement for observing NLS dynamics in experiments, namely, the kinetic energy dominates the potential energy. We will certainly explain it in detail during the course of the proof. Due to the requirement, the limit of $\tilde{V}_{N,L}$ defined by (1.8) is not a 3D δ -function, though it scales like one.

There are two well-developed schemes to deal with this type of procedure. One is the Fock space method, while the other is the hierarchy approach. We take the hierarchy approach here⁷. The BBGKY hierarchy associated with $\tilde{\psi}_{N,L}$ is

It was Erdös, Schlein, and Yau who first rigorously derived the 3D cubic defocusing NLS from a 3D quantum many-body dynamic in their fundamental papers [32, 33, 34, 35, 36]. They proved a-prior $L_T^{\infty} H_x^1$ bound to establish the compactness of BBGKY with respect to a topology on the trace class operators. Then, they showed that the limit point satisfies GP hierarchy. Finally, the proof for the uniqueness of GP hierarchy was the principal part and also surprisingly dedicate due to the fact that it is a system of infinitely many coupled equations over an unbounded number of variables. It motivated a large amount of works [1, 8, 9, 10, 11, 12, 13, 15, 16, 17, 18, 19, 25, 47, 48, 60, 67].

Subsequently, with imposing an additional a-prior condition on space-time norm, Klainerman and Machedon [48] gave an another proof of the uniqueness of GP hierarchy in a different space of density matrices defined by Hilbert-Schmidt type Sobolev norms. Later, the approach of Klainerman and Machedon was used by Kirkpatrick, Schlein and Staffilani [47] to derived the 2D cubic defocusing NLS from the 2D quantum many-body dynamic both on \mathbb{R}^2 and \mathbb{T}^2 ; by T. Chen and Pavlović [10] to derive the quintic NLS for d = 1,

2; by X. Chen [18] to investigate the trapping problem in 2D and 3D; and by X. Chen and Holmer [19] to derive 2D cubic defocusing NLS from the 3D quantum many-body dynamic.

Later on, T. Chen, Hainzl, Pavlović and Seiringer [8], using the quantum de Finetti theorem from [53], provided a simplified proof of the $L_T^{\infty} H_x^1$ -type 3D cubic uniqueness theorem in [33]. This method in [8] inspired the study for refined uniqueness theorems, such as [26, 45, 64].

Using Fock space methods to study the convergence rate has also been worked on by many authors, for example, see [3, 7, 39, 40, 50, 51, 58, 61], and the references within.

For the focusing setting, which is a natural continuation of the defocusing problem, X. Chen and Holmer [21] first derived the 1D focusing cubic NLS and later a 3D-to-1D reduction in [23]. But the 2D cubic case did not see any process until [54], in which Lewin, Nam, and Rougerie used a quantitative version of the quantum de Finetti theorem [27] to show that the ground state energy of the 2D N-body was described by a NLS ground state energy. Using the finite-dimensional quantum de Finetti theorem in [54], X. Chen and Holmer [24] derived 2D focusing cubic NLS from the 2D quantum many-body dynamic for $\beta \in (0, 1/6)$. For higher β , Lewin, Nam, and Rougerie [55] used a bootstrapping argument to improve β , which, together with the approach in [24], implied the convergence of the quantum many-body dynamics to the focusing NLS for $\beta \in (0, 3/4)$. In the 2D focusing case, the stability of the second kind which is the energy bound when k = 1 was improved to $\beta < 1$ in [59]. Besides the convergence of density matrix, the convergence rate is also of interest and extended to lower dimension in both focusing and defocusing cases by Nam and Napiórkowski in [58] using H^4 regularity.

The derivation of 2D defocusing cubic NLS from 3D was first by X. Chen and Holmer in [19] and then by Boßmann in [5] for the regime $\beta \in (0, 1]$. To our knowledge, the derivation of 2D focusing cubic NLS from 3D has not been completed before. In this paper, we follow the lead of the aforementioned focusing works [21, 23, 24, 52, 54, 55] and pursuit the treatment of 2D case from the 3D physical setting.

1.1. Outline of the Proof of Theorem 1.2. We first establish in Section 2, under the assumption $L(N/L)^{\beta} \rightarrow 1^{-}$, that the renormalized kinetic energy controls the potential energy and hence yield an H^{1} regularity bound to make the other parts of the paper work.

In section 2.1, we use scaling arguments to show why we choose the uncommon mixed norm $||V||_{L_x^{\infty}L_x^1}$ and we are bounded by the extra restriction $L(N/L)^{\beta} \to 1^-$. In fact, a similar requirement would also show up in the harmonic well case studied by X. Chen and Holmer [19] if one wants the renormalized kinetic energy to bound the potential energy instead of dropping it. Subsequently we prove the energy bound with $\beta < 1/2$ when k = 1, which is divided into two parts. First in Section 2.2, we get to $\beta < 1/3$. Instead of taking the approach in X. Chen and Holmer [19, 23, 24], our proof improvises from Lewin, Nam, and Rougerie [55] and Lewin [52]. This proof does not use the finite-dimensional quantum de Finetti theorem and thus can be applied to the \mathbb{R}^2 case as well. Hence, the main Theorem 1.2 works the same for \mathbb{R}^2 with $\beta < 1/3$. Second in Section 2.3, we adapt the bootstrapping argument in [55] to reach $\beta < 1/2$. Then in Section 2.4, we complete Theorem 2.1 when k > 1, where the restriction $\beta < 3/7$ is required. In the defocusing case [19], if we require a similar requirement, the index β can be improved to 3/7 as well.

In Section 3, we show the compactness of the BBGKY sequence. Then, we use a modified version of the approximation of identity type lemma to show that limit points satisfy the GP hierarchy with the unusual coupling constant g_0 . The uniqueness for GP hierarchy on \mathbb{T}^2 has been well studied by Kirkpatrick, Schlein and Staffilani [47], Herr and Sohinger [42, 43]. We use their uniqueness theorems to conclude our proof.

2. Focusing energy estimates

In this section, we prove focusing energy estimates. Define

$$S_j := (1 - \Delta_{r_j} - 1/L^2)^{1/2},$$

and write

$$S^{(k)} = \prod_{j=1}^{k} S_j.$$

Theorem 2.1. Assume $L(N/L)^{\beta} \to 1^{-}$, $\beta < \frac{3}{7}$, and $\|V\|_{L_{z}^{\infty}L_{x}^{1}} \leq \frac{2\alpha}{C_{gn}^{4}}$ for some $\alpha \in (0,1)$, then let $c_{0} = \min\left(\frac{1-\alpha}{\sqrt{2}}, \frac{1}{2}\right)$, we have $\forall k \geq 0$, there exists an $N_{0}(k) > 0$ such that

(2.1)
$$\langle \psi_{N,L}, \left(2 + N^{-1}H_{N,L} - 1/L^2\right)^k \psi_{N,L} \rangle \ge c_0^k \|S^{(k)}\psi_{N,L}\|_{L^2}^2$$

for all $N > N_0$ and for all $\psi_{N,L} \in L^2_s(\Omega_L^{\otimes N})$.

Proof. For smoothness of presentation, we postpone the proof of Theorem 2.1 to Section 2.2 - 2.4.

Now we convert the conclusions of Theorem 2.1 into the statement about the rescaled solution, which we will use in the remainder of the paper.

Let \tilde{P}_0 denote the orthogonal projection onto the ground state of $-\partial_z^2 - 1$ on the region $(-\pi/2, \pi/2)$ with Dirichlet boundary condition and $\tilde{P}_{\geq 1} = I - \tilde{P}_0$. We define \tilde{P}_0^j and \tilde{P}_1^j to be respectively \tilde{P}_0 and $\tilde{P}_{\geq 1}$ acting on the z_j -variable, and

(2.2)
$$\widetilde{P}_{\alpha} = \widetilde{P}^{1}_{\alpha_{1}} \cdots \widetilde{P}^{k}_{\alpha_{k}}$$

for a k-tuple $\alpha = (\alpha_1, ..., \alpha_k)$ with $\alpha_j \in \{0, 1\}$ and adopt the notation $|\alpha| = \alpha_1 + \cdots + \alpha_k$. Then

(2.3)
$$I = \sum_{\alpha} \widetilde{\mathcal{P}}_{\alpha}$$

where $I: L^2(\Omega^k) \to L^2(\Omega^k)$.

Corollary 2.2. Define

$$\widetilde{S}_j = (1 - \Delta_{x_j} - \partial_{z_j}^2 / L^2 - 1 / L^2)^{1/2},$$

and write

$$\widetilde{S}^{(k)} = \prod_{j=1}^{k} \widetilde{S}_j, \quad \langle \nabla \rangle^{(k)} = \prod_{j=1}^{k} \sqrt{1 - \Delta_{r_j}}.$$

Assume $L(N/L)^{\beta} \to 1^-$. Let $\tilde{\psi}_{N,L}(t) = e^{it\tilde{H}_{N,L}}\tilde{\psi}_{N,L}(0)$ and $\left\{\tilde{\gamma}_{N,L}^{(k)}(t)\right\}$ be the associated marginal densities. Then for all $k \ge 0$, we have the uniform-in-time bound

(2.4)
$$Tr\widetilde{S}^{(k)}\widetilde{\gamma}_{N,L}^{(k)}\widetilde{S}^{(k)} = \|\widetilde{S}^{(k)}\widetilde{\psi}_{N,L}(t)\|_{L^2}^2 \le C^k.$$

Consequently,

(2.5)
$$Tr\langle \nabla \rangle^{(k)} \widetilde{\gamma}_{N,L}^{(k)} \langle \nabla \rangle^{(k)} = \|\langle \nabla \rangle^{(k)} \widetilde{\psi}_{N,L}(t)\|_{L^2}^2 \le C^k,$$

and

(2.6)
$$\|\widetilde{\mathcal{P}}_{\alpha}\widetilde{\psi}_{N,L}\|_{L^{2}} \leq C^{k}L^{|\alpha|}, \quad |Tr\widetilde{\mathcal{P}}_{\alpha}\widetilde{\gamma}_{N,L}^{(k)}\widetilde{\mathcal{P}}_{\beta}| \leq C^{k}L^{|\alpha|+|\beta|}.$$

where $\widetilde{\mathcal{P}}_{\alpha}$ and $\widetilde{\mathcal{P}}_{\beta}$ are defined as in (2.2).

Proof. We notice that

$$(\widetilde{S}_{j}^{2}\widetilde{\psi}_{N,L})(t,\mathbf{x}_{N},\mathbf{z}_{N}) = L^{N/2}(S_{j}^{2}\psi_{N,L})(t,\mathbf{x}_{N},L\mathbf{z}_{N}),$$
$$\left(\widetilde{H}_{N,L}\widetilde{\psi}_{N,L}\right)(t,\mathbf{x}_{N},\mathbf{z}_{N}) = L^{N/2}\left(H_{N,L}\psi_{N,L}\right)(t,\mathbf{x}_{N},L\mathbf{z}_{N})$$

where $\tilde{\psi}_{N,L}$ is defined by (1.6). Thus, we have

$$\begin{split} \|\widetilde{S}^{(k)}\widetilde{\psi}_{N,L}\|_{L^{2}}^{2} &= \|S^{(k)}\psi_{N,L}\|_{L^{2}}^{2}, \\ \langle \widetilde{\psi}_{N,L}, (2+N^{-1}\widetilde{H}_{N,L}-1/L^{2})^{k}\widetilde{\psi}_{N,L} \rangle &= \langle \psi_{N,L}, \left(2+N^{-1}H_{N,L}-1/L^{2}\right)^{k}\psi_{N,L} \rangle. \end{split}$$

From estimate (2.1) in Theorem 2.1, we obtain

$$\|\widetilde{S}^{(k)}\widetilde{\psi}_{N,L}(t)\|_{L^{2}}^{2} \leq C^{k} \langle \widetilde{\psi}_{N,L}(t), (2+N^{-1}\widetilde{H}_{N,L}-1/L^{2})^{k} \widetilde{\psi}_{N,L}(t) \rangle$$

The term on the right-hand side is conserved, so

$$\|\widetilde{S}^{(k)}\widetilde{\psi}_{N,L}(t)\|_{L^{2}}^{2} \leq C^{k} \langle \widetilde{\psi}_{N,L}(0), (2+N^{-1}\widetilde{H}_{N,L}-1/L^{2})^{k} \widetilde{\psi}_{N,L}(0) \rangle$$

Applying the binomial theorem twice,

$$\begin{split} \|\widetilde{S}^{(k)}\widetilde{\psi}_{N,L}(t)\|_{L^{2}}^{2} &\leq C^{k} \sum_{j=0}^{k} \binom{k}{j} 2^{j} \langle \widetilde{\psi}_{N,L}(0), (N^{-1}\widetilde{H}_{N,L} - 1/L^{2})^{k-j} \widetilde{\psi}_{N,L}(0) \rangle \\ &\leq C^{k} \sum_{j=0}^{k} \binom{k}{j} 2^{j} C^{k-j} \\ &= C^{k} (2+C)^{k} \leq \widetilde{C}^{k}, \end{split}$$

where we used initial condition in the second-to-last line. So we have established (2.4). Combining (2.4) and (A.31), estimate (2.5) then follows. By (2.4) and (A.30), we obtain the first inequality of (2.6). By Lemma A.7,

$$Tr\widetilde{\mathcal{P}}_{\alpha}\widetilde{\gamma}_{N,L}^{(k)}\widetilde{\mathcal{P}}_{\beta} = \langle \widetilde{\mathcal{P}}_{\alpha}\widetilde{\psi}_{N,L}, \widetilde{\mathcal{P}}_{\beta}\widetilde{\psi}_{N,L} \rangle$$

so the second inequality of (2.6) follows by Cauchy-Schwarz inequality.

2.1. Explainations on the assumptions. We will explain the idea that we choose the mixed norm $\|V\|_{L_x^{\infty}L_x^1}$ and the relationship $L(N/L)^{\beta} \to 1^-$, both of which are different from the previous work, such as [19, 23, 24]. In fact, to derive the 2D focusing NLS equations, the key point is that the interaction energy can be controlled by the kinetic energy, which is described by Theorem 2.1 when k = 1. By a scaling, we can see that the mixed norm $\|V\|_{L_x^{\infty}L_x^1}$ is reasonable and $L(N/L)^{\beta}$ should be bounded.

2.1.1. We begin by setting up some notations for simplicity. Let

$$H_{ij} = S_i^2 + S_j^2 + H_{Iij}$$

and

$$H_{Iij} = LV_{N,L}(r_i - r_j)$$

where the subscript I represents the interaction energy. Then, we can rewrite

(2.7)
$$1 + N^{-1}H_{N,L} - 1/L^2 = \frac{1}{N(N-1)} \sum_{1 \le i < j \le N} H_{ij}.$$

When we take $\psi_{N,L} = \phi_L^{\otimes N}$ with $\|\phi_L\|_{L^2} = 1$, we find

$$\langle \psi_{N,L}, \left(1 + N^{-1}H_{N,L} - 1/L^2\right)\psi_{N,L}\rangle = \frac{1}{2}\langle \phi_L^{\otimes 2}, H_{12}\phi_L^{\otimes 2}\rangle.$$

If $H_{12} \ge 0$, we can deduce that

$$(2.9) \qquad -L \int_{\Omega_L^2} V_{N,L}(r_1 - r_2) |\phi_L(r_1)\phi_L(r_2)|^2 dr_1 dr_2 \leq C(V) \langle S_1^2 \phi_L(r_1)\phi_L(r_2), \phi_L(r_1)\phi_L(r_2) \rangle \\ \leq C(V) \langle (1 - \Delta_{r_1})\phi_L(r_1)\phi_L(r_2), \phi_L(r_1)\phi_L(r_2) \rangle,$$

where C(V) depends on V. Moreover, if we assume $C(V) = C ||V||_X$ where $||\cdot||_X$ is a norm, by a scaling argument, it should satisfy

$$\|V\|_X \le \lambda^{-2} \|V(\cdot/\lambda)\|_X, \quad \forall \lambda \in (0,1).$$

Indeed, we take $V^{\lambda}(\cdot) = V(\cdot/\lambda)$ and $\phi_L^{\lambda}(\cdot) = \lambda^{-3/2}\phi_L(\cdot/\lambda)$ to replace V and ϕ_L respectively. Since we take the periodic condition in the x-direction, a scaling argument can only used for the function supported in the interior of the domain. Thus, we consider the test function $\phi_L \in C_c^{\infty}(\Omega_L)$, the space of smooth functions compactly supported in $(-\pi, \pi)^2 \times (-L\pi/2, L\pi/2)$. For every $\phi_L \in C_c^{\infty}(\Omega_L)$, we have

(2.10)
$$-L \int_{\Omega_L^2} V_{N,L}(r_1 - r_2) |\phi_L(r_1)\phi_L(r_2)|^2 dr_1 dr_2 = -L \int_{\Omega_L^2} V_{N,L}^{\lambda}(r_1 - r_2) |\phi_L^{\lambda}(r_1)\phi_L^{\lambda}(r_2)|^2 dr_1 dr_2,$$

and

(2.11)

$$C\|V^{\lambda}\|_{X}\langle (1-\Delta_{r_{1}})\phi_{L}^{\lambda}(r_{1})\phi_{L}^{\lambda}(r_{2}),\phi_{L}^{\lambda}(r_{1})\phi_{L}^{\lambda}(r_{2})\rangle \leq C\|V^{\lambda}\|_{X}\lambda^{-2}\langle (1-\Delta_{r_{1}})\phi_{L}(r_{1})\phi_{L}(r_{2}),\phi_{L}(r_{1})\phi_{L}(r_{2})\rangle.$$

If there exists a $\lambda_0 \in (0, 1)$ such that $\lambda_0^{-2} \|V(\cdot/\lambda_0)\|_X \leq q_0 \|V\|_X$ for some $q_0 \in (0, 1)$, we take $\lambda = \lambda_0$. Putting (2.9) (2.10) and (2.11) together, we get

$$-L \int_{\Omega_L^2} V_{N,L}(r_1 - r_2) |\phi_L(r_1)\phi_L(r_2)|^2 dr_1 dr_2 \le q_0 C ||V||_X \langle (1 - \Delta_{r_1})\phi_L(r_1)\phi_L(r_2), \phi_L(r_1)\phi_L(r_2) \rangle,$$

for all $\phi_L \in C_c^{\infty}(\Omega_L)$. Iterating the process, it will lead to a contradiction for $q_0 < 1$.

On the one hand, the common norm $\|\cdot\|_{L^1}$ cannot satisfy the above requirement, since

$$\|V\|_{L^1} = \lambda^{-3} \|V^{\lambda}\|_{L^1} \ge \lambda^{-2} \|V^{\lambda}\|_{L^1}, \quad \forall \lambda \in (0, 1).$$

On the other hand, we note that

$$\|V\|_{L_{z}^{\infty}L_{x}^{1}} = \lambda^{-2} \|V(\cdot/\lambda)\|_{L_{z}^{\infty}L_{x}^{1}}, \quad \forall \lambda \in (0,1).$$

That is, the mixed norm $L_z^{\infty} L_x^1$ satisfies the requirement. Indeed, we can establish a general Lemma 2.7 in Section 2.2.

2.1.2. To derive the relationship between N and L, the key point is also that the interaction energy can be controlled by the kinetic energy. More precisely, let us consider the rescaled system. We take the test function $\tilde{\phi}(r) = f(x)\tilde{g}(z)$, where $f(x) \in C_c^{\infty}((-\pi,\pi)^2)$, $\tilde{g}(z) \in C_c^{\infty}(-\pi/2,\pi/2)$ and

$$\|f\|_{L^2} = \|\widetilde{g}\|_{L^2} = 1$$

Define

(2.12)
$$f_{\varepsilon}(x) = \frac{1}{\varepsilon} f(x/\varepsilon) \in C_{c}^{\infty}((-\pi,\pi)^{2}), \quad \varepsilon \in (0,1),$$

(2.13)
$$\widetilde{g}_{\lambda}(z) = \frac{1}{\sqrt{\lambda}} \widetilde{g}(z/\lambda) \in C_c^{\infty}(-\pi/2, \pi/2), \quad \lambda \in (0, 1)$$

(2.14)
$$\phi_{\varepsilon,\lambda}(r) = f_{\varepsilon}(x)\widetilde{g}_{\lambda}(z),$$

(2.15)
$$\widetilde{\psi}_{\varepsilon,\lambda}(r_1, r_2) = \widetilde{\phi}_{\varepsilon,\lambda}(r_1)\widetilde{\phi}_{\varepsilon,\lambda}(r_2).$$

where $f_{\varepsilon}(x)$ should be considered as a periodic extension and $f_{\varepsilon}(x) \in C^{\infty}(\mathbb{T}^2)$.

The interaction energy is

(2.16)
$$\int \widetilde{V}_{N,L}(r_1 - r_2) |f_{\varepsilon}(x_1)\widetilde{g}_{\lambda}(z_1)f_{\varepsilon}(x_2)\widetilde{g}_{\lambda}(z_2)|^2 dr_1 dr_2$$
$$= \int \widetilde{V}_{N,L}(\varepsilon(x_1 - x_2), \lambda(z_1 - z_2)) |f(x_1)\widetilde{g}(z_1)f(x_2)\widetilde{g}(z_2)|^2 dr_1 dr_2$$

The kinetic energy is

$$\begin{aligned} (2.17) \qquad \langle S_1^2 \psi_{\varepsilon,\lambda}, \psi_{\varepsilon,\lambda} \rangle \\ &= \|f_{\varepsilon}\|_{L^2}^2 \|\widetilde{g}_{\lambda}\|_{L^2}^2 \left(\langle (1 - \Delta_x) f_{\varepsilon}(x) \widetilde{g}_{\lambda}(z), f_{\varepsilon}(x) \widetilde{g}_{\lambda}(z) \rangle + \frac{1}{L^2} \langle f_{\varepsilon}(x) (-\partial_z^2 - 1) \widetilde{g}_{\lambda}(z), f_{\varepsilon}(x) \widetilde{g}_{\lambda}(z) \rangle \right) \\ &= \|f_{\varepsilon}\|_{L^2}^2 \|\widetilde{g}_{\lambda}\|_{L^2}^2 \left(\|\nabla_x f_{\varepsilon}\|_{L^2}^2 \|\widetilde{g}_{\lambda}\|_{L^2}^2 + \|f_{\varepsilon}\|_{L^2}^2 \|\widetilde{g}_{\lambda}\|_{L^2}^2 + \frac{1}{L^2} \|f_{\varepsilon}\|_{L^2}^2 \|\partial_z \widetilde{g}_{\lambda}\|_{L^2}^2 - \frac{1}{L^2} \|f_{\varepsilon}\|_{L^2}^2 \|\widetilde{g}_{\lambda}\|_{L^2}^2 \right) \\ &= \|f\|_{L^2}^2 \|\widetilde{g}\|_{L^2}^4 \left(\frac{\|\nabla_x f\|_{L^2}^2}{\varepsilon^2} + \|f\|_{L^2}^2 \right) + \frac{1}{L^2} \|f\|_{L^2}^4 \|\widetilde{g}\|_{L^2}^2 \left(\frac{\|\partial_z \widetilde{g}\|_{L^2}^2}{\lambda^2} - \|\widetilde{g}\|_{L^2}^2 \right). \end{aligned}$$
When we take $\lambda^{-1} = L(N/L)^{\beta}$, $\varepsilon^{-1} = (N/L)^{\beta}$, the interaction energy is equal to

$$L(N/L)^{3\beta} \int V(x_1 - x_2, z_1 - z_2) |f(x_1)\tilde{g}(z_1)f(x_2)\tilde{g}(z_2)|^2 dr_1 dr_2$$

and the kinetic energy is controlled by

$$(N/L)^{2\beta} + \frac{L^2(N/L)^{2\beta}}{L^2} = 2(N/L)^{2\beta}.$$

Since $L(N/L)^{\beta} \to \infty$, the interaction energy cannot be controlled by the kinetic energy. Therefore, it implies that we should consider the case $L(N/L)^{\beta} \leq C$. On the other hand, to make the limit of $\tilde{V}_{N,L}$ exist, we should take $L(N/L)^{\beta}$ to be a constant or tend to 0. For the case $L(N/L)^{\beta} \to 0$, we note that the limit of $\widetilde{V}_{N,L}$ equals to 0, which is not sufficient to derive the cubic NLS equation. Hence, we only consider the case $L(N/L)^{\beta} \to 1$ and it works the same for $L(N/L)^{\beta} \to R_0$.

Remark 2.3. A similar argument can also apply to [19] in the focusing setting. To control the interaction energy instead of dropping it like the defocusing case, it also needs an extra condition $(N\sqrt{\omega})^{\beta}\omega^{-1/2} \leq C$.

2.2. Focusing energy estimates when k = 1.

Theorem 2.4. Assume $L(N/L)^{\beta} \to 1^{-}$, $\beta < \frac{1}{2}$, and $\|V\|_{L^{\infty}_{z}L^{1}_{x}} \leq \frac{2\alpha}{C^{4}_{gn}}$ for some $\alpha \in (0,1)$, then let $c_{0} = \min\left(\frac{1-\alpha}{\sqrt{2}}, \frac{1}{2}\right)$, we have $\forall C_{0} > 0$, there exists an $N_{0} > 0$ such that

(2.18)
$$\langle \psi_{N,L}, (C_0 + 1 + N^{-1} H_{N,L} - 1/L^2) \psi_{N,L} \rangle \ge c_0 \|S_1 \psi_{N,L}\|_{L^2}^2$$

for all $N > N_0$ and for all $\psi_{N,L} \in L^2_s(\Omega_L^{\otimes N})$.

We divide the proof of Theorem 2.4 into two parts. The first is Theorem 2.5 where the energy bound holds for $\beta < 1/3$ and the second is Theorem 2.15 which implies Theorem 2.4. In this section, we prove Theorem 2.5 with $\beta < 1/3$.

Theorem 2.5. Assume $L(N/L)^{\beta} \to 1^-$, $\beta < \frac{1}{3}$, and $\|V\|_{L_z^{\infty}L_x^1} \leq \frac{2\alpha}{C_{gn}^4}$ for some $\alpha \in (0,1)$, then $\forall C_0 > 0$, there exists an $N_0 > 0$ such that

(2.19)
$$\langle \psi_{N,L}, (C_0 + 1 + N^{-1} H_{N,L} - 1/L^2) \psi_{N,L} \rangle \ge (1 - \alpha) \|S_1 \psi_{N,L}\|_{L^2}^2,$$

for all $N > N_0$ and for all $\psi_{N,L} \in L^2_s(\Omega_L^{\otimes N})$.

The key of the proof of Theorem 2.5 is the following theorem.

Theorem 2.6. Assume $L(N/L)^{\beta} \to 1^-$, $\beta < \frac{1}{3}$, and $\|V\|_{L^{\infty}_{z}L^{1}_{x}} \leq \frac{2\alpha}{C^{4}_{gn}}$ for some $\alpha \in (0,1)$, define the operator

(2.20)
$$H_{ij,\alpha} = \alpha S_i^2 + \alpha S_j^2 + H_{Iij}.$$

Then $\forall C_0 > 0$, there exists an $N_0 > 0$ such that

$$\langle \psi_{N,L}, (2C_0 + H_{12,\alpha})\psi_{N,L}\rangle \ge 0,$$

for all $N > N_0$ and for all $\psi_{N,L} \in L^2_s(\Omega_L^{\otimes N})$.

Proof of Theorem 2.5 assuming Theorem 2.6. Using formula (2.7) and the symmetry of $\psi_{N,L}$, we have

$$\langle \psi_{N,L}, \left(C_{0} + 1 + N^{-1}H_{N,L} - 1/L^{2}\right)\psi_{N,L} \rangle$$

$$= \frac{1}{N(N-1)} \sum_{1 \le i < j \le N} \langle \psi_{N,L}, (2C_{0} + H_{ij})\psi_{N,L} \rangle$$

$$= \frac{1}{2} \langle \psi_{N,L}, (2C_{0} + H_{12})\psi_{N,L} \rangle$$

$$= \frac{1}{2} \langle \psi_{N,L}, (2C_{0} + H_{12,\alpha})\psi_{N,L} \rangle + \frac{1-\alpha}{2} \langle \psi_{N,L}, (S_{1}^{2} + S_{2}^{2})\psi_{N,L} \rangle$$

$$\ge (1-\alpha) \|S_{1}\psi_{N,L}\|_{L^{2}}^{2}.$$

Next, we turn our attention onto the proof of Theorem 2.6. Under the assumption $L(N/L)^{\beta} \to 1^{-}$, the renormalized kinetic energy can control the potential energy.

Lemma 2.7. Assume $L(N/L)^{\beta} \to 1^-$, $M \ge 1$, then for all $\psi_{M,L} \in L^2_s(\Omega_L^{\otimes M})$ with $\|\psi_{M,L}\|_{L^2} = 1$, we have

(2.21)
$$L \int_{\Omega_L^2} |V_{N,L}(r_1 - r_2)| \rho_{M,L}(r_1) \rho_{M,L}(r_2) dr_1 dr_2 \le C_{gn}^4 ||V||_{L_z^\infty L_x^1} \langle S_1^2 \psi_{M,L}, \psi_{M,L} \rangle,$$

where density function $\rho_{M,L}(r_1) := \int \cdots \int |\psi_{M,L}|^2 (r_1, ..., r_M) dr_2 \cdots dr_M$. Especially, if $\psi_{M,L} = \phi_L^{\otimes M}$ with $\|\phi_L\|_{L^2} = 1$, then

(2.22)
$$L \int_{\Omega_L^2} |V_{N,L}(r_1 - r_2)|\phi_L(r_1)\phi_L(r_2)|^2 dr_1 dr_2 \le C_{gn}^4 ||V||_{L_z^\infty L_x^1} \langle S_1^2 \phi_L, \phi_L \rangle.$$

Proof. Using Cauchy-Schwarz inequality and Young's convolution inequality, we get

$$(2.23) L \int_{\Omega_L^2} |V_{N,L}(r_1 - r_2)| \rho_{M,L}(r_1) \rho_{M,L}(r_2) dr_1 dr_2 \leq L ||V_{N,L} * \rho_{M,L}||_{L_x^\infty L_x^2} ||\rho_{M,L}||_{L_x^1 L_x^2} \\ \leq L ||V_{N,L}||_{L_x^\infty L_x^1} ||\rho_{M,L}||_{L_x^1 L_x^2}^2.$$

For $\|\rho_{M,L}\|_{L^1_x L^2_x}^2$ on the right-hand side of (2.23), we use 2D inhomogeneous Gagliardo-Nirenberg inequality (1.10),

(2.24)
$$\|\rho_{M,L}\|_{L^{1}_{z}L^{2}_{x}}^{2} = \|\sqrt{\rho_{M,L}}\|_{L^{2}_{z}L^{4}_{x}}^{4} \le C^{4}_{gn}\|\sqrt{\rho_{M,L}}\|_{L^{2}_{z}L^{2}_{x}}^{2}\|\sqrt{1-\Delta_{x}}\sqrt{\rho_{M,L}}\|_{L^{2}_{z}L^{2}_{x}}^{2}$$
$$= C^{4}_{gn}\|\sqrt{\rho_{M,L}}\|_{L^{2}_{z}L^{2}_{x}}^{2}\left(\|\sqrt{\rho_{M,L}}\|_{L^{2}_{z}L^{2}_{x}}^{2} + \|\nabla_{x}\sqrt{\rho_{M,L}}\|_{L^{2}_{z}L^{2}_{x}}^{2}\right).$$

By the Hoffman-Ostenhof inequality (A.1), we have

(2.25)
$$\|\nabla_x \sqrt{\rho_{M,L}}\|_{L^2}^2 \le \langle -\Delta_{x_1} \psi_{M,L}, \psi_{M,L} \rangle$$

Now, putting (2.25) into (2.24) and (2.24) into (2.23), we have

(2.26)
$$L \int_{\Omega_L^2} |V_{N,L}(r_1 - r_2)| \rho_{M,L}(r_1) \rho_{M,L}(r_2) dr_1 dr_2 \le C_{gn}^4 L \|V_{N,L}\|_{L_z^\infty L_x^1} \langle (1 - \Delta_{x_1}) \psi_{M,L}, \psi_{M,L} \rangle.$$

Noting that $\|V_{N,L}\|_{L_z^{\infty}L_x^1} = (N/L)^{\beta} \|V\|_{L_z^{\infty}L_x^1}$, with the assumption $L(N/L)^{\beta} \to 1^-$, we conclude that

(2.27)
$$L \int_{\Omega_L^2} |V_{N,L}(r_1 - r_2)| \rho_{M,L}(r_1) \rho_{M,L}(r_2) dr_1 dr_2 \le C_{gn}^4 ||V||_{L_z^\infty L_x^1} \langle (1 - \Delta_{x_1}) \psi_{M,L}, \psi_{M,L} \rangle.$$

Since $S_1^2 \ge (1 - \Delta_{x_1})$, we arrive at the estimate (2.21) from estimate (2.27).

The following lemma is used to estimate the two-body interaction energy by a one-body term.

Lemma 2.8. If $V \in C_c^{\infty}(\mathbb{T}^2 \times \mathbb{R})$ and has a positive Fourier transform $\widehat{V} \geq 0$, then for all real function $\eta \in L^1(\mathbb{T}^2 \times \mathbb{R})$ (2.28)

$$\sum_{1 \le j < k \le N} V(r_j - r_k) \ge \frac{1}{(2\pi)^3} \sum_{j=1}^N \eta * V(r_j) - \frac{1}{2(2\pi)^6} \int_{\mathbb{T}^2 \times \mathbb{R}} \int_{\mathbb{T}^2 \times \mathbb{R}} V(r_1 - r_2) \eta(r_1) \eta(r_2) dr_1 dr_2 - \frac{N}{2} V(0).$$

Proof. With the Fourier inversion formula,

$$(2.29) \qquad \sum_{1 \le j < k \le N} V(r_j - r_k) \\ = \int \sum_{1 \le j < k \le N} e^{i\xi \cdot (r_j - r_k)} \hat{V}(\xi) d\xi \\ = \frac{1}{2} \int \Big| \sum_{j=1}^N e^{i\xi \cdot r_j} - \hat{\eta}(\xi) \Big|^2 \hat{V}(\xi) d\xi + \frac{1}{(2\pi)^3} \sum_{j=1}^N \eta * V(r_j) \\ - \frac{1}{2(2\pi)^6} \int_{\mathbb{T}^2 \times \mathbb{R}} \int_{\mathbb{T}^2 \times \mathbb{R}} V(r_1 - r_2) \eta(r_1) \eta(r_2) dr_1 dr_2 - \frac{N}{2} V(0) \\ \ge \frac{1}{(2\pi)^3} \sum_{j=1}^N \eta * V(r_j) - \frac{1}{2(2\pi)^6} \int_{\mathbb{T}^2 \times \mathbb{R}} \int_{\mathbb{T}^2 \times \mathbb{R}} V(r_1 - r_2) \eta(r_1) \eta(r_2) dr_1 dr_2 - \frac{N}{2} V(0), \\ \text{where } \xi = (n_1, n_2, \tau) \text{ and } \int \cdot d\xi \text{ is short for } \int_{\mathbb{T}} \sum_{n_1, n_2} \cdot d\tau. \qquad \Box$$

where $\xi = (n_1, n_2, \tau)$ and $\int d\xi$ is short for $\int_{\mathbb{R}} \sum_{n_1, n_2} d\tau$.

Remark 2.9. In our setting, the integral region is Ω_L . To use Lemma 2.8, $V_{N,L}$ should be understood as the periodic extension in the x-direction and zero extension in the z-direction of the rescaled V which is compactly supported on Ω . That is, $V_{N,L} \in C_c^{\infty}(\mathbb{T}^2 \times \mathbb{R})$. Similarly, $\rho_{N,L}(r)$ and $\psi_{N,L}$ should be seen as $\rho_{N,L}(r) \mathbf{1}_{\Omega_L}(r) \in L^1(\mathbb{T}^2 \times \mathbb{R})$ and $\psi_{N,L} \mathbf{1}_{\Omega_L^{\otimes N}}$ respectively.

In case $\widehat{V}_{N,L} \ge 0$, if we take $V = V_{N,L}$ and $\eta = (2\pi)^3 N \rho_{N,L}$, we obtain

(2.30)
$$\sum_{1 \le j < k \le N} \langle \psi_{N,L}, V_{N,L}(r_j - r_k)\psi_{N,L} \rangle$$
$$\geq N \sum_{j=1}^N \int \rho_{N,L} * V_{N,L}(r_j) |\psi_{N,L}|^2 (\mathbf{r}_N) d\mathbf{r}_N - \frac{N^2}{2} \langle \rho_{N,L} * V_{N,L}, \rho_{N,L} \rangle - \frac{N}{2} V_{N,L}(0)$$
$$= \frac{N^2}{2} \int \rho_{N,L}(r_1) \rho_{N,L}(r_2) V_{N,L}(r_1 - r_2) dr_1 dr_2 - \frac{N(N/L)^{3\beta} V(0)}{2}$$
$$\geq -\frac{N(N/L)^{3\beta} V(0)}{2},$$

where we have used

$$\int \rho_{N,L}(r_1)\rho_{N,L}(r_2)V_{N,L}(r_1-r_2)dr_1dr_2 = (2\pi)^6 \int |\widehat{\rho}_{N,L}(\xi)|^2 \widehat{V}_{N,L}(\xi)d\xi$$

and $\widehat{V}_{N,L} \ge 0$ in the last inequality. By estimate (2.30), we have

$$\langle \psi_{N,L}, (2C_0 + H_{12,\alpha})\psi_{N,L} \rangle \ge 2C_0 - \frac{(N/L)^{3\beta}V(0)}{(N-1)/L} \ge 0$$

as long as $\beta < 1/3$ and N/L is large enough.

Hence, we have established Theorem 2.6 if $\hat{V}_{N,L} \geq 0$. Next, we will use Lemma 2.8 to deal with a general interaction function V.

Proof of Theorem 2.6. For general V, we consider N = 2M particles which we split into two groups of M. For the case N = 2M + 1, the proof works the same if we split the system into two groups of M and M + 1. We denote the first M variables by $r_1, ..., r_M$ and the others by $r'_1 = r_{M+1}, ..., r'_M = r_{2M}$. We decompose $V_{N,L} = V_{N,L}^+ - V_{N,L}^-$ on the Fourier side where $\widehat{V_{N,L}^+} = (\widehat{V_{N,L}})_+ \ge 0$ and $\widehat{V_{N,L}^-} = (\widehat{V_{N,L}})_- \ge 0$. By its symmetry in the 2M variables, we rewrite

$$\begin{split} &\frac{1}{2} \langle \psi_{N,L}, H_{I12} \psi_{N,L} \rangle \\ = & \frac{L}{2M(2M-1)} \Big\langle \psi_{2M,L}, \sum_{1 \le j < k \le 2M} V_{N,L}(r_j - r_k) \psi_{2M,L} \Big\rangle \\ &= & \frac{L}{M(M-1)} \Big\langle \psi_{2M,L}, \sum_{1 \le j < k \le M} V_{N,L}^+(r_j - r_k) \psi_{2M,L} \Big\rangle \\ &+ & \frac{L}{M(M-1)} \Big\langle \psi_{2M,L}, \sum_{1 \le l < m \le M} V_{N,L}^-(r_l' - r_m') \psi_{2M,L} \Big\rangle - & \frac{L}{M^2} \Big\langle \psi_{2M,L}, \sum_{j=1}^M \sum_{l=1}^M V_{N,L}^-(r_j - r_l') \psi_{2M,L} \Big\rangle. \end{split}$$

This means that

(2.31)
$$\frac{1}{2} \langle \psi_{2M,L}, H_{I12} \psi_{2M,L} \rangle = \langle \psi_{2M,L}, I_{M,L} \psi_{2M,L} \rangle$$

where

(2.32)
$$I_{M,L} = \frac{L}{M(M-1)} \sum_{1 \le j < k \le M} V_{N,L}^+(r_j - r_k) + \frac{L}{M(M-1)} \sum_{1 \le l < m \le M} V_{N,L}^-(r_l' - r_m') - \frac{L}{M^2} \sum_{j=1}^M \sum_{l=1}^M V_{N,L}^-(r_j - r_l').$$

Then we have

(2.33)
$$\langle \psi_{2M,L}, (2C_0 + H_{12,\alpha})\psi_{2M,L} \rangle = \langle \psi_{2M,L}, (2C_0 + 2I_{M,L} + \alpha(S_1^2 + S_2^2))\psi_{2M,L} \rangle.$$

Thus, in order to bound the interaction $2C_0 + H_{12,\alpha}$ from below, it suffices to consider $I_{M,L}$. We fix the variables $r'_1, ..., r'_M$ in the second group. For simplicity, we use the notation $\langle \cdot, \cdot \rangle_{\mathbf{r}_M}$ to denote the integral only in the variables $\mathbf{r}_M := (r_1, ..., r_M)$. We denote the one-particle density by

(2.34)
$$\rho_{M,L}(r, \mathbf{r}'_{\mathbf{M}}) := \int_{\Omega_L} \cdots \int_{\Omega_L} |\psi_{2M,L}|^2(r, r_2, ..., r_M, \mathbf{r}'_{\mathbf{M}}) dr_2 \cdots dr_M.$$

Our goal is to get

(2.35)
$$\langle \psi_{2M,L}, (2C_0 + 2I_{M,L} + \alpha(S_1^2 + S_2^2))\psi_{2M,L} \rangle_{\mathbf{r}_{\mathbf{M}}}$$

$$\geq \left(2\alpha - C_{gn}^4 \|V\|_{L_z^{\infty}L_x^1} \right) \langle \psi_{2M,L}, S_1^2 \psi_{2M,L} \rangle_{\mathbf{r}_{\mathbf{M}}} + \int \rho_{M,L}(r, \mathbf{r}'_{\mathbf{M}}) dr \left(2C_0 - \frac{LV_{N,L}^+(0) + LV_{N,L}^-(0)}{(M-1)} \right).$$

First, we may assume $\int \rho_{M,L}(r, \mathbf{r}'_{\mathbf{M}}) dr > 0$. The case $\int \rho_{M,L}(r, \mathbf{r}'_{\mathbf{M}}) dr = 0$ is easier and will be presented later. By using Lemma 2.8 with

$$V = V_{N,L}^+, \quad \eta = \frac{(2\pi)^3 M \rho_{M,L}(r, \mathbf{r'_M})}{\int \rho_{M,L}(r, \mathbf{r'_M}) dr},$$

we have

$$(2.36) \qquad \langle \psi_{2M,L}, I_{M,L}\psi_{2M,L} \rangle_{\mathbf{r}_{\mathbf{M}}} \\ \geq \frac{ML}{2(M-1)\int \rho_{M,L}(r, \mathbf{r}'_{\mathbf{M}})dr} \int V_{N,L}^{+}(r_{1}-r_{2})\rho_{M,L}(r_{1}, \mathbf{r}'_{\mathbf{M}})\rho_{M,L}(r_{2}, \mathbf{r}'_{\mathbf{M}})dr_{1}dr_{2} \\ - \frac{LV_{N,L}^{+}(0)\int \rho_{M,L}(r, \mathbf{r}'_{\mathbf{M}})dr}{2(M-1)} + \frac{L}{M(M-1)} \sum_{1 \leq l < m \leq M} V_{N,L}^{-}(r_{l}' - r_{m}') \int \rho_{M,L}(r, \mathbf{r}'_{\mathbf{M}})dr \\ - \frac{L}{M} \sum_{l=1}^{M} \rho_{M,L} * V_{N,L}^{-}(r_{l}').$$

Next we use again Lemma 2.8 with

$$V = V_{N,L}^{-}, \quad \eta = \frac{(2\pi)^3 (M-1)\rho_{M,L}(r, \mathbf{r'_M})}{\int \rho_{M,L}(r, \mathbf{r'_M}) dr},$$

and obtain

(2.37)
$$\frac{L}{M(M-1)} \sum_{1 \le l < m \le M} V_{N,L}^{-}(r_{l}' - r_{m}') \int \rho_{M,L}(r, \mathbf{r}_{\mathbf{M}}') dr - \frac{L}{M} \sum_{l=1}^{M} \rho_{M,L} * V_{N,L}^{-}(r_{l}') \\ \ge -\frac{(M-1)}{2M} \frac{L}{\int \rho_{M,L}(r, \mathbf{r}_{\mathbf{M}}') dr} \int V_{N,L}^{-}(r_{1} - r_{2}) \rho_{M,L}(r_{1}, \mathbf{r}_{\mathbf{M}}') \rho_{M,L}(r_{2}, \mathbf{r}_{\mathbf{M}}') dr_{1} dr_{2} \\ -\frac{LV_{N,L}^{-}(0) \int \rho_{M,L}(r, \mathbf{r}_{\mathbf{M}}') dr}{2(M-1)}.$$

Thus, we have

(2.38)
$$\langle \psi_{2M,L}, I_{M,L}\psi_{2M,L} \rangle_{\mathbf{r}_{\mathbf{M}}}$$

$$\geq \int \rho_{M,L}(r, \mathbf{r'_M}) dr \int \frac{L}{2} V_{N,L}(r_1 - r_2) \frac{\rho_{M,L}(r_1, \mathbf{r'_M})}{\int \rho_{M,L}(r, \mathbf{r'_M}) dr} \frac{\rho_{M,L}(r_2, \mathbf{r'_M})}{\int \rho_{M,L}(r, \mathbf{r'_M}) dr} dr_1 dr_2 - \int \rho_{M,L}(r, \mathbf{r'_M}) dr \frac{L V_{N,L}^+(0) + L V_{N,L}^-(0)}{2(M-1)}.$$

By Lemma 2.7, we obtain

$$(2.39) \quad \langle \psi_{2M,L}, (2C_0 + 2I_{M,L} + \alpha(S_1^2 + S_2^2))\psi_{2M,L} \rangle_{\mathbf{r}_{\mathbf{M}}} \\ \geq \left(2\alpha - C_{gn}^4 \|V\|_{L_z^{\infty}L_x^1}\right) \langle \psi_{2M,L}, S_1^2\psi_{2M,L} \rangle_{\mathbf{r}_{\mathbf{M}}} + \int \rho_{M,L}(r, \mathbf{r}'_{\mathbf{M}}) dr \left(2C_0 - \frac{LV_{N,L}^+(0) + LV_{N,L}^-(0)}{(M-1)}\right).$$

We arrive at the estimate (2.35) for the case $\int \rho_{M,L}(r, \mathbf{r}'_{\mathbf{M}}) dr > 0$.

Next, if $\int \rho_{M,L}(r, \mathbf{r}'_{\mathbf{M}}) dr = 0$, we can deduce that $\rho_{M,L}(r, \mathbf{r}'_{\mathbf{M}}) = 0$ due to the nonnegativity and smoothness of $\rho_{M,L}$. Then, we have

(2.40)

$$\begin{aligned} \langle \psi_{2M,L}, I_{M,L}\psi_{2M,L} \rangle_{\mathbf{r}_{M}} \\ &= \frac{L}{M(M-1)} \sum_{1 \le j < k \le M} \int V_{N,L}^{+}(r_{j} - r_{k}) |\psi_{M,L}(\mathbf{r}_{M}, \mathbf{r}'_{M})|^{2} d\mathbf{r}_{M} \\ &+ \frac{L}{M(M-1)} \sum_{1 \le l < m \le M} V_{N,L}^{-}(r'_{l} - r'_{m}) \int \rho_{M,L}(r, \mathbf{r}'_{M}) dr \\ &- \frac{L}{M^{2}} \sum_{j=1}^{M} \sum_{l=1}^{M} \int V_{N,L}^{-}(r_{j} - r'_{l}) \rho_{M,L}(r_{j}, \mathbf{r}'_{M}) dr_{j} \\ &= I + II + III. \end{aligned}$$

Since $V_{N,L}^+$ has a positive Fourier transform, we have $I \ge 0$. By the fact that $\rho_{M,L}(r, \mathbf{r}'_{\mathbf{M}}) = 0$, we obtain II = III = 0. That is, the estimate (2.35) still holds.

Hence, when $||V||_{L^{\infty}_{z}L^{1}_{x}} \leq \frac{2\alpha}{C^{4}_{an}}$, we have

(2.41)
$$\langle \psi_{2M,L}, (2C_0 + H_{12,\alpha})\psi_{2M,L} \rangle = \langle \psi_{2M,L}, (2C_0 + 2I_{M,L} + \alpha(S_1^2 + S_2^2))\psi_{2M,L} \rangle$$
$$\geq 2C_0 - \frac{L(N/L)^{3\beta}(V^+(0) + V^-(0))}{2(M-1)}.$$

Since $\beta < \frac{1}{3}$, there exists an $N_0 > 0$ such that

(2.42)
$$\langle \psi_{2M,L}, (2C_0 + H_{12,\alpha})\psi_{2M,L} \rangle \ge 0,$$

for all $N = 2M \ge N_0$.

The proof also works for the case in which we put \mathbb{R}^2 in the *x*-direction and hence the main theorem works the same for \mathbb{R}^2 with $\beta < 1/3$.

2.3. Bootstrapping argument.⁸ In [55], Lewin, Nam, and Rougerie can improve the index β by a bootstraping argument for 2D case. Here, such a method also works for $\beta < 1/2$ with a starting point $\eta_0 \leq (22\beta - 4)/5$ in our setting. Let us define

(2.43)
$$E_{N,L} := \inf_{\|\psi_{N,L}\|_{L^2} = 1} \langle \psi_{N,L}, \left(1 + N^{-1} H_{N,L} - 1/L^2\right) \psi_{N,L} \rangle,$$

(2.44)
$$E_{N,L,\varepsilon} := \inf_{\|\psi_{N,L}\|_{L^2}=1} \langle \psi_{N,L}, \left(1 + N^{-1}H_{N,L} - 1/L^2 - \varepsilon N^{-1}\sum_{j=1}^N S_j^2\right) \psi_{N,L} \rangle,$$

where $E_{N,L}$ denotes the many-body ground state energy per particle. From the definition (2.44), estimate (2.19) in Theorem 2.5, is equivalent to prove $E_{N,L,1-\alpha} \ge -C_0$ for $N \ge N_0$. Indeed, if $E_{N,L,1-\alpha} \ge -C_0$ for $N \ge N_0$, it means that

$$C_0 + 1 + N^{-1}H_{N,L} - 1/L^2 - (1 - \alpha)S_1^2 \ge 0,$$

for $N \ge N_0$, which is the estimate (2.19).

Thus, our goal is to bound $E_{N,L,\varepsilon}$ from below. We note that $E_{N,L,\varepsilon} = (1-\varepsilon)E_{N,L}^{\varepsilon}$, where $E_{N,L}^{\varepsilon}$ is the ground state energy with interaction function $V^{\varepsilon} = (1-\varepsilon)^{-1}V$. So we only need to deal with $E_{N,L}^{\varepsilon}$ or $E_{N,L}$. A main tool is the finite-dimensional quantum de Finetti theorem (Lemma 2.11). Then we can give a lower bound on the Hamiltonian energy in Lemma 2.13, that is,

(2.45)
$$\left\langle \psi_{N,L}, \left(1 + N^{-1}H_{N,L} - 1/L^2\right)\psi_{N,L}\right\rangle \geq C(V, N, L, \lambda_x, \lambda_z, \|S_1\psi_{N,L}\|_{L^2}, \|S_1S_2\psi_{N,L}\|_{L^2}),$$

where λ_x and λ_z are cut-off parameters.

⁸The finite dimensional quantum de Finetti theorem is only used in this section. In Section 2.2, we have already reached $\beta < 1/3$ without it. Hence, the main theorem works the same for \mathbb{R}^2 with $\beta < 1/3$.

Subsequently in Lemma 2.14, we will control $||S_1\psi_{N,L}||_{L^2}$ and $||S_1S_2\psi_{N,L}||_{L^2}$ for the ground state $\psi_{N,L}$. More precisely,

(2.46)
$$Tr\left(S_1^2\gamma_{N,L}^{(1)}\right) \lesssim C_{up}\frac{1+|E_{N,L,\theta}|}{\theta},$$

(2.47)
$$Tr\left(S_1^2 S_2^2 \gamma_{N,L}^{(2)}\right) \lesssim C_{up}^2 \left(\frac{1+|E_{N,L,\theta}|}{\theta}\right)^2,$$

where C_{up} is an upper bound constant defined by (2.50).

With Lemma 2.13 and 2.14, we arrive at a closed control relationship, namely,

 $|E_{N,L}| \le C(V, N, L, \lambda_x, \lambda_z, |E_{N,L,\theta}|).$

Thus we can use the bootstapping argument to bound $|E_{N,L,\varepsilon}|$ as long as there exists a starting point.

Now, we present the above procedure in detail. First, we take $\psi_{N,L} = \phi_L^{\otimes N}$ with $\|\phi_L\|_{L^2} = 1$ and obtain the NLS energy functional

(2.48)
$$\mathcal{E}_{N,L}(\phi_L) = \langle \phi_L^{\otimes N}, \left(1 + N^{-1} H_{N,L} - 1/L^2\right) \phi_L^{\otimes N} \rangle$$
$$= \frac{1}{2} \langle \phi_L^{\otimes 2}, H_{12} \phi_L^{\otimes 2} \rangle = \langle S_1^2 \phi_L, \phi_L \rangle + \frac{L}{2} \int_{\Omega_L^2} V_{N,L}(r_1 - r_2) |\phi_L(r_1) \phi_L(r_2)|^2 dr_1 dr_2.$$

Define

(2.49)
$$e_{N,L} := \inf_{\|\phi_L\|_{L^2} = 1} \mathcal{E}_{N,L}(\phi_L),$$

where $e_{N,L}$ stands for the ground state energy of the NLS energy functional. From the above definition, we know $e_{N,L} \ge E_{N,L} \ge E_{N,L,\varepsilon}$. To bound $E_{N,L,\varepsilon}$ from below, it is necessary to bound $e_{N,L}$ from below. Here, we first give a sufficient condition to bound $e_{N,L}$ as follows.

Lemma 2.10. Assume $L(N/L)^{\beta} \to 1^{-}$ and $\|V\|_{L_{z}^{\infty}L_{x}^{1}} \leq \frac{2}{C_{gn}^{4}}$, then $0 \leq e_{N,L} \leq C_{up}$, where

(2.50)
$$C_{up} = 1 + \frac{C_{gn}^4 \|V\|_{L_z^\infty L_x^1}}{2}$$

Proof. For the lower bound, it suffices to prove $\mathcal{E}_{N,L}(\phi_L) \geq 0$. From estimate (2.22) in Lemma 2.7, we have

$$\mathcal{E}_{N,L}(\phi_L) = \langle S_1^2 \phi_L, \phi_L \rangle + \frac{L}{2} \int_{\Omega_L^2} V_{N,L}(r_1 - r_2) |\phi_L(r_1)\phi_L(r_2)|^2 dr_1 dr_2$$
$$\geq \langle S_1^2 \phi_L, \phi_L \rangle - \frac{C_{gn}^4 ||V||_{L_z^\infty L_x^1}}{2} \langle S_1^2 \phi_L, \phi_L \rangle \ge 0,$$

as long as $||V||_{L_z^{\infty}L_x^1} \leq \frac{2}{C_{gn}^4}$.

For the upper bound, we use estimate (2.22) again and obtain

(2.52)
$$\mathcal{E}_{N,L}(\phi_L) = \langle S_1^2 \phi_L, \phi_L \rangle + \frac{L}{2} \int_{\Omega_L^2} V_{N,L}(r_1 - r_2) |\phi_L(r_1)\phi_L(r_2)|^2 dr_1 dr_2 \\ \leq \langle S_1^2 \phi_L, \phi_L \rangle + \frac{C_{gn}^4 ||V||_{L_z^\infty L_x^1}}{2} \langle S_1^2 \phi_L, \phi_L \rangle.$$

When we take $\phi_L(x,z) = \cos_L(z)$, which is the L^2 normalized ground state wave function of S_1^2 , then $\langle S_1^2 \phi_L, \phi_L \rangle = 1$. Hence, we have

(2.53)
$$e_{N,L} \le 1 + \frac{C_{gn}^4 \|V\|_{L^{\infty}_z L^1_x}}{2}.$$

To establish the lower bound estimate for $E_{N,L}$, we need the finite-dimensional quantum de Finetti theorem. We define the Littlewood-Paley projectors (eigenspace projector) by

(2.54) $P_{x_j,m} = \chi_{\{m\}}(-\Delta_{x_j}), \quad m \ge 0,$

(2.55)
$$P_{x_j,\leq\lambda} = \chi_{[0,\lambda^2]} \left(-\Delta_{x_j} \right), \quad P_{z_j,\leq\lambda} = \chi_{[1/L^2,\lambda^2/L^2]} \left(-\partial_{z_j}^2 \right),$$

$$(2.56) P_{x_j,>\lambda} = I - P_{x_j,\leq\lambda}, \quad P_{z_j,>\lambda} = I - P_{z_j,\leq\lambda}.$$

From the definition, we notice that $P_{z_j,\leq\lambda}$ and $P_{z_j,>\lambda}$ are L dependent. However, we omit it for simplicity.

Lemma 2.11 (Finite-dimensional quantum de Finetti[54]). Assume $\left\{\gamma_{N,L}^{(k)}\right\}_{k=1}^{N}$ is the marginal density generated by an N-body wave function $\psi_{N,L} \in L^2_s(\Omega^N_L)$ and P_L be a finite-rank orthogonal projector with

$$\dim(P_L(L^2(\Omega_L))) = d < \infty,$$

where d can be independent of L. Then, there is a positive Borel measure $d\mu_{N,L}$ supported on the unit sphere $SP_L(L^2(\Omega_L))$ such that

(2.57)
$$Tr \left| P_L^{\otimes 2} \gamma_{N,L}^{(2)} P_L^{\otimes 2} - \int_{\mathcal{S}(P_L(L^2(\Omega_L))))} |\phi_L^{\otimes 2}\rangle \langle \phi_L^{\otimes 2} | d\mu_{N,L}(\phi_L) \right| \le \frac{8d}{N}$$

Moreover, we will need operator inequalities for two-body interaction as follows.

Lemma 2.12. Assume $L(N/L)^{\beta} \to 1^{-}$. For $\delta \in (0,1)$, the multiplication operator $V_{N,L}(r_1 - r_2)$ on $L^2(\Omega_L^{\otimes 2})$ satisfies

$$L|V_{N,L}(r_1 - r_2)| \le C_{\delta}(N/L)^{\delta} \|V\|_{L^{\infty}_{z}L^{1+\delta}_{x}}(1 - \Delta_{x_1}),$$

$$L|V_{N,L}(r_1 - r_2)| \le C_{\delta} \|V\|_{L^{\infty}_{z} L^1_x} (1 - \Delta_{x_1})^{1/2 + \delta} (1 - \Delta_{x_2})^{1/2 + \delta},$$

(2.60)
$$\| \langle \nabla_{x_1} \rangle^{-1} \langle \nabla_{x_2} \rangle^{-1} V(r_1 - r_2) \langle \nabla_{x_1} \rangle^{-1} \langle \nabla_{x_2} \rangle^{-1} \|_{op} \le C \| V \|_{L^{\infty}_{z} L^1_x},$$

(2.61)
$$S_1^2 L V_{N,L}(r_1 - r_2) + L V_{N,L}(r_1 - r_2) S_1^2 \ge -C_{\delta}(V) (N/L)^{\beta + \delta} S_1^2 S_2^2$$

where $C_{\delta}(V)$ is dependent on V.

Proof. For smoothness of presentation, we put the proof in the Appendix.

Now, along with Lemma 2.11, we can establish the following lower bound estimate.

Lemma 2.13. Assume $L(N/L)^{\beta} \to 1^{-}$ and $\|V\|_{L_{z}^{\infty}L_{x}^{1}} \leq \frac{2}{C_{gn}^{4}}$. Then for every $\delta \in (0, 1/2)$, there exists a constant $C_{\delta} > 0$ such that for all $N \geq 2$, $\lambda_{z} \geq 1$, $\lambda_{x} \geq 0$ and for all wave functions $\psi_{N,L}$

$$\left\langle \psi_{N,L}, \left(1 + N^{-1}H_{N,L} - 1/L^2\right)\psi_{N,L} \right\rangle$$

$$\gtrsim -C_{\delta} \|V\|_{L_{z}^{\infty}L_{x}^{1}} \left(1 + \lambda_{x}^{2}\right)^{1+2\delta} \frac{d}{N}$$

$$- \frac{C_{\delta} \|V\|_{L_{z}^{\infty}L_{x}^{1}}}{\min\left\{1 + \lambda_{x}^{2}, 1 + (\lambda_{z}^{2} - 1)/L^{2}\right\}^{1/4 - \delta/2}} \left(Tr\left(S_{1}^{2}\gamma_{N,L}^{(1)}\right)\right)^{1/4 - \delta/2} \left(Tr\left(S_{1}^{2}S_{2}^{2}\gamma_{N,L}^{(2)}\right)\right)^{1/2 + \delta},$$

$$= \dim(P_{-\epsilon}) \cdot P_{-\epsilon} \left(L^{2}(\Omega_{1})\right)$$

where $d = dim(P_{x, \leq \lambda_x} P_{z, \leq \lambda_z} L^2(\Omega_L)).$

Proof. For simplicity, we adopt the notation

$$P := P_{x, \leq \lambda_x} P_{z, \leq \lambda_z}, \quad Q = 1 - P,$$

$$P^j := P_{x_j, \leq \lambda_x} P_{z_j, \leq \lambda_z}, \quad Q^j := 1 - P^j,$$

$$P^{(k)} := \prod_{j=1}^k P_{x_j, \leq \lambda_x}, \quad P_{z_j, \leq \lambda_z} = \prod_{j=1}^k P^j.$$

Recall $H_{12} = S_1^2 + S_2^2 + LV_{N,L}(r_1 - r_2)$ and $S_1^2 = 1 - \Delta_{r_1} - 1/L^2$. Using Lemma 2.11, we write

$$\left\langle \psi_{N,L}, \left(1 + N^{-1}H_{N,L} - 1/L^2\right)\psi_{N,L} \right\rangle = \frac{1}{2} \langle \psi_{N,L}, H_{12}\psi_{N,L} \rangle$$

$$\geq \langle \psi_{N,L}, \left(1 - \Delta_{x_1} + \frac{1}{2}LV_{N,L}(r_1 - r_2)\right)\psi_{N,L} \rangle$$

$$= I + II + III,$$

where

(2.62)
$$I = \int \langle \phi_L^{\otimes 2}, (1 - \Delta_{x_1} + \frac{1}{2}LV_{N,L}(r_1 - r_2))\phi_L^{\otimes 2} \rangle d\mu_{N,L}(\phi_L)$$

(2.63)
$$II = Tr\left(\left(1 - \Delta_{x_1} + \frac{1}{2}LV_{N,L}(r_1 - r_2)\right)\left[\gamma_{N,L}^{(2)} - P^{(2)}\gamma_{N,L}^{(2)}P^{(2)}\right]\right)$$

$$(2.64) \quad III = Tr\left(\left(1 - \Delta_{x_1} + \frac{1}{2}LV_{N,L}(r_1 - r_2)\right) \left[P^{(2)}\gamma_{N,L}^{(2)}P^{(2)} - \int_{\mathcal{S}(P(L^2(\Omega_L)))} |\phi_L^{\otimes 2}\rangle \langle \phi_L^{\otimes 2}| d\mu_{N,L}(\phi_L)\right]\right)$$

We only need to bound these terms from below.

We first handle *I*. By estimate (2.27) with $\psi_{M,L} = \phi_L^{\otimes 2}$, we have

$$\langle \phi_L^{\otimes 2}, (1 - \Delta_{x_1} + \frac{1}{2}LV_{N,L}(r_1 - r_2))\phi_L^{\otimes 2} \rangle \ge 0.$$

Noting that $\mu_{N,L}$ is a positive measure, we obtain $I \ge 0$. Hence we can discard it.

We now deal with II and rewrite

$$= II_K + II_V.$$

Since $(1 - \Delta_{x_1}) \ge (1 - \Delta_{x_1})P^{(2)}$, with Lemma A.7, we obtain

$$II_{K} = Tr\left((1 - \Delta_{x_{1}})\left[\gamma_{N,L}^{(2)} - P^{(2)}\gamma_{N,L}^{(2)}P^{(2)}\right]\right)$$
$$= \left\langle \left[(1 - \Delta_{x_{1}}) - (1 - \Delta_{x_{1}})P^{(2)}\right]\psi_{N,L}, \psi_{N,L}\right\rangle \ge 0$$

For II_V , we expand

(2.67)
$$2\left(LV_{N,L}(r_1 - r_2) - P^{(2)}LV_{N,L}(r_1 - r_2)P^{(2)}\right)$$
$$= LV_{N,L}(r_1 - r_2)(1 - P^{(2)}) + (1 - P^{(2)})LV_{N,L}(r_1 - r_2)$$
$$+ (1 - P^{(2)})LV_{N,L}(r_1 - r_2)P^{(2)} + P^{(2)}LV_{N,L}(r_1 - r_2)(1 - P^{(2)})$$

By Lemma A.7 and Cauchy-Schwarz inequality,

$$(2.68) \qquad \frac{1}{2} \Big| Tr\left(\left(LV_{N,L}(r_1 - r_2)(1 - P^{(2)}) + (1 - P^{(2)})LV_{N,L}(r_1 - r_2) \right) \gamma_{N,L}^{(2)} \right) \Big| \\ = \frac{1}{2} \Big| \langle LV_{N,L}(r_1 - r_2)(1 - P^{(2)})\psi_{N,L}, \psi_{N,L} \rangle + \langle LV_{N,L}(r_1 - r_2)\psi_{N,L}, (1 - P^{(2)})\psi_{N,L} \rangle \Big| \\ \leq L \| |V_{N,L}(r_1 - r_2)|^{1/2}\psi_{N,L}\|_{L^2} \| |V_{N,L}(r_1 - r_2)|^{1/2}(1 - P^{(2)})\psi_{N,L}\|_{L^2}.$$

Computing in the same way, we have

$$(2.69) \qquad \frac{1}{2} \left| Tr\left((1-P^{(2)})LV_{N,L}(r_1-r_2)P^{(2)} + P^{(2)}LV_{N,L}(r_1-r_2)(1-P^{(2)}) \right) \gamma_{N,L}^{(2)} \right| \\ = \frac{1}{2} \left| \langle LV_{N,L}(r_1-r_2)P^{(2)}\psi_{N,L}, (1-P^{(2)})\psi_{N,L} \rangle + \langle LV_{N,L}(r_1-r_2)(1-P^{(2)})\psi_{N,L}, P^{(2)}\psi_{N,L} \rangle \right| \\ \leq L \| |V_{N,L}(r_1-r_2)|^{1/2}P^{(2)}\psi_{N,L}\|_{L^2} \| |V_{N,L}(r_1-r_2)|^{1/2}(1-P^{(2)})\psi_{N,L}\|_{L^2}.$$

Combining estimates (2.68) and (2.69), we obtain

$$|II_V| \leq L \left(\| |V_{N,L}(r_1 - r_2)|^{1/2} \psi_{N,L} \|_{L^2} + \| |V_{N,L}(r_1 - r_2)|^{1/2} P^{(2)} \psi_{N,L} \|_{L^2} \right) \\ \times \| |V_{N,L}(r_1 - r_2)|^{1/2} (1 - P^{(2)}) \psi_{N,L} \|_{L^2}.$$

Next, we need to bound the right side terms. From estimate (2.59), we obtain

$$\begin{aligned} |LV_{N,L}(r_1 - r_2)| &\leq C_{\delta} ||V||_{L_z^{\infty} L_x^1} \left((1 - \Delta_{x_1})(1 - \Delta_{x_2}) \right)^{1/2 + \delta} \\ &\leq C_{\delta} ||V||_{L_z^{\infty} L_x^1} \left(\eta^{-1}(1 - \Delta_{x_1})(1 - \Delta_{x_2}) + \eta^{\frac{1+2\delta}{1-2\delta}} \right), \end{aligned}$$

(2.71)
$$L \| |V_{N,L}(r_1 - r_2)|^{1/2} \psi_{N,L} \|_{L^2}^2 = \langle L | V_{N,L}(r_1 - r_2) | \psi_{N,L}, \psi_{N,L} \rangle$$

 $\leq C_{\delta} \| V \|_{L^{\infty}_{z} L^1_x} \left(\langle (1 - \Delta_{x_1})(1 - \Delta_{x_2}) \psi_{N,L}, \psi_{N,L} \rangle \right)^{1/2 + \delta} .$

Similarly,

$$(2.72) L \| |V_{N,L}(r_1 - r_2)|^{1/2} P^{(2)} \psi_{N,L} \|_{L^2}^2 \le C_{\delta} \| V \|_{L^{\infty}_z L^1_x} \left(\langle (1 - \Delta_{x_1})(1 - \Delta_{x_2}) \psi_{N,L}, \psi_{N,L} \rangle \right)^{1/2 + \delta}$$

Using estimate (2.59) again, we get

$$(2.75) \qquad (Q_1 + Q_2) \left((1 - \Delta_{x_1}) (1 - \Delta_{x_2}) \right)^{1/2 + \delta} \\ \leq (Q_1 + Q_2) (S_1^2 S_2^2)^{1/2 + \delta} \\ \leq \frac{1}{\min \left\{ 1 + \lambda_x^2, 1 + (\lambda_z^2 - 1)/L^2 \right\}^{1/2 - \delta}} \left(S_1^2 \left(S_2^2 \right)^{1/2 + \delta} + \left(S_1^2 \right)^{1/2 + \delta} S_2^2 \right) \\ \leq \frac{1}{\min \left\{ 1 + \lambda_x^2, 1 + (\lambda_z^2 - 1)/L^2 \right\}^{1/2 - \delta}} \left[\eta^{-1} S_1^2 S_2^2 + \eta^{\frac{1+2\delta}{1-2\delta}} \left(S_1^2 + S_2^2 \right) \right].$$

where we have used the interpolation inequality for fractional powers in Lemma A.3 in the last line. Putting estimates (2.73) (2.74) and (2.75) together, we have

By optimizing over η , we deduce that

$$(2.77) \qquad L \| |V_{N,L}(r_1 - r_2)|^{1/2} (1 - P^{(2)}) \psi_{N,L} \|_{L^2}^2 = \langle L | V_{N,L}(r_1 - r_2)| (1 - P^{(2)}) \psi_{N,L}, (1 - P^{(2)}) \psi_{N,L} \rangle \leq \frac{C_{\delta} \| V \|_{L^{\infty}_{z} L^1_{x}}}{\min \{1 + \lambda_x^2, 1 + (\lambda_z^2 - 1)/L^2\}^{1/2 - \delta}} \left(Tr \left(S_1^2 \gamma_{N,L}^{(1)} \right) \right)^{1/2 - \delta} \left(Tr \left(S_1^2 S_2^2 \gamma_{N,L}^{(2)} \right) \right)^{1/2 + \delta}.$$

Combining estimates (2.70) (2.71) (2.72) and (2.77), we get

For *III*, we rewrite

$$(2.79) III = Tr(1 - \Delta_{x_1}) \left[P^{(2)} \gamma_{N,L}^{(2)} P^{(2)} - \int_{\mathcal{S}P(L^2(\Omega_L))} |\phi_L^{\otimes 2}\rangle \langle \phi_L^{\otimes 2} | d\mu_{N,L}(\phi_L) \right] \\ + \frac{1}{2} Tr \left(LV_{N,L}(r_1 - r_2) \left[P^{(2)} \gamma_{N,L}^{(2)} P^{(2)} - \int |\phi_L^{\otimes 2}\rangle \langle \phi_L^{\otimes 2} | d\mu_{N,L}(\phi_L) \right] \right) \\ = III_K + III_V.$$

For the first term III_K , we can use the inequality $|TrAB| \leq ||A||_{op}Tr|B|$ to get

$$|III_K| \le ||(1 - \Delta_x)P||_{op} Tr \Big| P^{(2)} \gamma_{N,L}^{(2)} P^{(2)} - \int_{\mathcal{S}P(L^2(\Omega_L))} |\phi_L^{\otimes 2}\rangle \langle \phi_L^{\otimes 2} | d\mu_{N,L}(\phi_L) \Big|.$$

Using $(1 - \Delta_x)P \leq (1 + \lambda_x^2)P$ and Lemma 2.11, we have

(2.81)
$$|III_K| \lesssim (1+\lambda_x^2)\frac{d}{N}.$$

For the second term III_V , we use the inequality $|TrAB| \leq ||A||_{op}Tr|B|$ again to get

$$(2.82) |III_V| \le ||P^{(2)}| LV_{N,L}(r_1 - r_2)|P^{(2)}||_{op} Tr \Big| P^{(2)} \gamma_{N,L}^{(2)} P^{(2)} - \int_{\mathcal{S}P(L^2(\Omega_L))} |\phi_L^{\otimes 2}\rangle \langle \phi_L^{\otimes 2}| d\mu_{N,L}(\phi_L) \Big|$$

By estimate (2.59) and $P^j(1 - \Delta_{x_j}) \leq (1 + \lambda_x^2)P^j$, we have

$$P^{(2)}|LV_{N,L}(r_1 - r_2)|P^{(2)} \leq C_{\delta} ||V||_{L_z^{\infty} L_x^1} \left(\left(P^1(1 - \Delta_{x_1}) \right) \otimes \left(P^2(1 - \Delta_{x_2}) \right) \right)^{1/2 + \delta} \\ \leq C_{\delta} ||V||_{L_z^{\infty} L_x^1} (1 + \lambda_x^2)^{1 + 2\delta} P^{(2)}.$$

Noting that $[P^{(2)}|LV_{N,L}(r_1 - r_2)|P^{(2)}, P^{(2)}] = 0$, by Property 2 in Lemma A.6, we deduce that

$$|P^{(2)}|LV_{N,L}(r_1 - r_2)|P^{(2)}||_{op} \le C_{\delta} ||V||_{L^{\infty}_{z}L^{1}_{x}}(1 + \lambda_{x}^{2})^{1+2\delta}.$$

Therefore, using Lemma 2.11 again, we get

(2.84)
$$\left| Tr \left(LV_{N,L}(r_1 - r_2) \left[P^{(2)} \gamma_{N,L}^{(2)} P^{(2)} - \int_{\mathcal{S}P(L^2(\Omega_L))} |\phi_L^{\otimes 2} \rangle \langle \phi_L^{\otimes 2} | d\mu_{N,L}(\phi_L) \right] \right) \right|$$
$$\lesssim C_{\delta} \|V\|_{L_z^{\infty} L_x^1} (1 + \lambda_x^2)^{1+2\delta} \frac{d}{N}.$$

Thus, for all $\delta > 0$, combining estimates (2.81) and (2.84), we obtain

(2.85)
$$III \gtrsim -C_{\delta} \|V\|_{L^{\infty}_{z}L^{1}_{x}} (1+\lambda_{x}^{2})^{1+2\delta} \frac{d}{N}$$

Combining estimates (2.78) and (2.85), we get the desired lower bound, that is,

$$\left\langle \psi_{N,L}, \left(1 + N^{-1}H_{N,L} - 1/L^2\right)\psi_{N,L} \right\rangle$$

$$\gtrsim -C_{\delta} \|V\|_{L_{z}^{\infty}L_{x}^{1}} (1 + \lambda_{x}^{2})^{1+2\delta} \frac{d}{N}$$

$$- \frac{C_{\delta} \|V\|_{L_{z}^{\infty}L_{x}^{1}}}{\min\left\{1 + \lambda_{x}^{2}, 1 + (\lambda_{z}^{2} - 1)/L^{2}\right\}^{1/4 - \delta/2}} \left(Tr\left(S_{1}^{2}\gamma_{N,L}^{(1)}\right)\right)^{1/4 - \delta/2} \left(Tr\left(S_{1}^{2}S_{2}^{2}\gamma_{N,L}^{(2)}\right)\right)^{1/2 + \delta}.$$

From Lemma 2.13, to get the lower bound estimate for $E_{N,L}$, we are left to control $Tr(S_1^2\gamma_{N,L}^{(1)})$ and $Tr(S_1^2S_2^2\gamma_{N,L}^{(2)})$ for the ground state $\psi_{N,L}$.

Lemma 2.14. Assume $L(N/L)^{\beta} \to 1^{-}$, $\beta < \frac{1}{2}$. Let $\psi_{N,L}$ be a ground state of $1 + H_{N,L} - 1/L^2$. For all $\theta \in (0,1)$, we have

(2.86)
$$Tr\left(S_1^2\gamma_{N,L}^{(1)}\right) \lesssim C_{up}\frac{1+|E_{N,L,\theta}|}{\theta},$$

(2.87)
$$Tr\left(S_1^2 S_2^2 \gamma_{N,L}^{(2)}\right) \lesssim C_{up}^2 \left(\frac{1+|E_{N,L,\theta}|}{\theta}\right)^2.$$

Proof. For estimate (2.86), from the definition of $E_{N,L,\theta}$, we have

(2.88)
$$1 + N^{-1}H_{N,L} - 1/L^2 - \theta N^{-1} \sum_{j=1}^{N} S_j^2 \ge E_{N,L,\theta}.$$

Let $\psi_{N,L}$ be a ground state of $1 + N^{-1}H_{N,L} - 1/L^2$. By taking the expectation against $\psi_{N,L}$ on both sides of (2.88), we obtain

$$Tr\left(S_{1}^{2}\gamma_{N,L}^{(1)}\right) \leq \frac{1}{\theta}\left(\left\langle\psi_{N,L}, \left(1+N^{-1}H_{N,L}-1/L^{2}\right)\psi_{N,L}\right\rangle - E_{N,L,\theta}\right) = \frac{E_{N,L}-E_{N,L,\theta}}{\theta}.$$

From Lemma 2.10, we see $C_{up} \ge e_{N,L} \ge E_{N,L,\theta}$. Therefore, $|E_{N,L}| \le C_{up} + |E_{N,L,\theta}|$ and

(2.89)
$$Tr\left(S_1^2\gamma_{N,L}^{(1)}\right) \le \frac{2C_{up}(1+|E_{N,L,\theta}|)}{\theta}$$

For estimate (2.87), we notice that

(2.90)
$$Tr\left(S_1^2 S_2^2 \gamma_{N,L}^{(2)}\right) \le \frac{2}{N^2} \left\langle \psi_{N,L}, \left(\sum_{j=1}^N S_j^2\right)^2 \psi_{N,L} \right\rangle.$$

Thus, it needs only to control the right term of (2.90). We rewrite

$$(2.91) \qquad \frac{2}{N^2} \left(\sum_{j=1}^N S_j^2 \right)^2 = \left(1 + N^{-1} H_{N,L} - 1/L^2 \right) \frac{1}{N} \sum_{j=1}^N S_j^2 + \frac{1}{N} \sum_{j=1}^N S_j^2 \left(1 + N^{-1} H_{N,L} - 1/L^2 \right) \\ - \frac{1}{N^2(N-1)} \sum_{i=1}^N \sum_{j$$

We need to control the right side terms of (2.91).

For the first and second terms, by using the ground state $\psi_{N,L}$ and estimate (2.89), we have

(2.92)
$$\left\langle \psi_{N,L}, \left(\left(1 + N^{-1} H_{N,L} - 1/L^2 \right) \frac{1}{N} \sum_{j=1}^N S_j^2 + \frac{1}{N} \sum_{j=1}^N S_j^2 \left(1 + N^{-1} H_{N,L} - 1/L^2 \right) \right) \psi_{N,L} \right\rangle$$
$$= \frac{2E_{N,L}}{N} \left\langle \psi_{N,L}, \sum_{j=1}^N S_j^2 \psi_{N,L} \right\rangle \le \frac{4C_{up}^2 (1 + |E_{N,L,\theta}|)^2}{\theta}.$$

For the third term, we decompose it into two cases. On the one hand, we consider the case $j \neq i$ and $k \neq i$. By estimate (2.58), we have

$$(2.93) \qquad \frac{1}{N(N-1)} \sum_{i \neq j < k \neq i} LV_{N,L}(r_j - r_k) = 1 + N^{-1}H_{N,L} - 1/L^2 - \theta N^{-1} \sum_{j=1}^N S_j^2 - (1-\theta)N^{-1} \sum_{j=1}^N S_j^2 - \frac{1}{N(N-1)} \sum_{j \neq i} LV_{N,L}(r_i - r_j) \geq E_{N,L,\theta} - \left(\frac{1-\theta}{N} + \frac{C_{\delta}(N/L)^{\delta} \|V\|_{L_x^{\infty} L_x^{1+\delta}}}{N^2}\right) \sum_{j=1}^N S_j^2.$$

Since $[V_{N,L}(r_j - r_k), S_i^2] = 0$, by summing over *i*, we obtain

(2.94)
$$\frac{1}{N^{2}(N-1)} \sum_{i=1}^{N} \sum_{i \neq j < k \neq i} \left(S_{i}^{2} L V_{N,L}(r_{j} - r_{k}) + L V_{N,L}(r_{j} - r_{k}) S_{i}^{2} \right)$$
$$\geq \frac{2}{N} \sum_{i=1}^{N} S_{i}^{2} \left(E_{N,L,\theta} - \left(\frac{1-\theta}{N} + \frac{C_{\delta}(N/L)^{\delta} \|V\|_{L_{z}^{\infty} L_{x}^{1+\delta}}}{N^{2}} \right) \sum_{j=1}^{N} S_{j}^{2} \right)$$
$$= \frac{2E_{N,L,\theta}}{N} \sum_{j=1}^{N} S_{j}^{2} - \frac{2}{N} \left(\frac{1-\theta}{N} + \frac{C_{\delta}(N/L)^{\delta} \|V\|_{L_{z}^{\infty} L_{x}^{1+\delta}}}{N^{2}} \right) \left(\sum_{j=1}^{N} S_{j}^{2} \right)^{2}.$$

On the other hand, when j = i or k = i, by estimate (2.61), we have

$$S_j^2 L V_{N,L}(r_j - r_k) + L V_{N,L}(r_j - r_k) S_j^2 \ge -C_{\delta}(V) (N/L)^{\beta + \delta} S_j^2 S_k^2.$$

Therefore,

(2.95)
$$\frac{1}{N^2(N-1)} \sum_{j \neq k} \left(S_j^2 L V_{N,L}(r_j - r_k) + L V_{N,L}(r_j - r_k) S_j^2 \right)$$
$$\geq -C_{\delta}(V) \frac{(N/L)^{\beta+\delta}}{N^3} \left(\sum_{j=1}^N S_j^2 \right)^2.$$

Putting estimates (2.94) and (2.95) together, we obtain

(2.96)
$$\frac{1}{N^2(N-1)} \sum_{i=1}^N \sum_{j < k} \left(S_i^2 L V_{N,L}(r_j - r_k) + L V_{N,L}(r_j - r_k) S_i^2 \right)$$
$$\geq -\frac{2}{N^2} \left(1 - \theta + \frac{C_\delta(V)(N/L)^{\beta + \delta}}{N} \right) \left(\sum_{j=1}^N S_j^2 \right)^2 + \frac{2E_{N,L,\theta}}{N} \sum_{j=1}^N S_j^2.$$

Taking the expectation against the ground state $\psi_{N,L}$ on both sides of (2.96), we obtain

$$(2.97) \qquad \frac{1}{N^{2}(N-1)} \sum_{i=1}^{N} \sum_{j < k} \langle \psi_{N,L}, \left(S_{i}^{2}LV_{N,L}(r_{j} - r_{k}) + LV_{N,L}(r_{j} - r_{k})S_{i}^{2}\right)\psi_{N,L}\rangle \\ \geq -\frac{2}{N^{2}} \left(1 - \theta + \frac{C_{\delta}(V)(N/L)^{\beta + \delta}}{N}\right) \left\langle \psi_{N,L}, \left(\sum_{j=1}^{N}S_{j}^{2}\right)^{2}\psi_{N,L}\right\rangle + \frac{2E_{N,L,\theta}}{N} \sum_{j=1}^{N} \langle \psi_{N,L}, S_{j}^{2}\psi_{N,L}\rangle \\ \geq -\frac{2}{N^{2}} \left(1 - \theta + \frac{C_{\delta}(V)(N/L)^{\beta + \delta}}{N}\right) \left\langle \psi_{N,L}, \left(\sum_{j=1}^{N}S_{j}^{2}\right)^{2}\psi_{N,L}\right\rangle - \frac{2C_{up}(1 + |E_{N,L,\theta}|)^{2}}{\theta},$$

where we used estimate (2.89) in the last line.

Taking the expectation against the ground state $\psi_{N,L}$ on both sides of (2.91), we use estimates (2.92) and (2.97) to obtain

(2.98)
$$\frac{2}{N^2} \left\langle \psi_{N,L}, \left(\sum_{j=1}^N S_j^2 \right)^2 \psi_{N,L} \right\rangle \\ \leq \frac{8C_{up}^2 (1+|E_{N,L,\theta}|)^2}{\theta} + \frac{2}{N^2} \left(1 - \theta + \frac{C_{\delta}(V)(N/L)^{\beta+\delta}}{N} \right) \left\langle \psi_{N,L}, \left(\sum_{j=1}^N S_j^2 \right)^2 \psi_{N,L} \right\rangle.$$

Equivalently, we have

(2.99)
$$\frac{2}{N^2} \left(\theta - \frac{C_{\delta}(V)(N/L)^{\beta+\delta}}{N} \right) \left\langle \psi_{N,L}, \left(\sum_{j=1}^N S_j^2 \right)^2 \psi_{N,L} \right\rangle \le \frac{8C_{up}^2 (1+|E_{N,L,\theta}|)^2}{\theta}.$$

Since $\beta < 1/2$, we can take δ such that $2\beta + \delta < 1$. Then, with $L(N/L)^{\beta} \to 1^{-}$, we deduce that $\rho = C_{\delta}(V)(N/L)^{\beta+\delta} \simeq \rho = C_{\delta}(V)(N/L)^{2\beta+\delta} \simeq \rho/2$

$$\theta - \frac{C_{\delta}(V)(N/L)^{V+V}}{N} \ge \theta - \frac{C_{\delta}(V)(N/L)^{V+V}}{N/L} \ge \theta/2,$$

for large N and 1/L. With estimate (2.99), we conclude

$$Tr\left(S_{1}^{2}S_{2}^{2}\gamma_{N,L}^{(2)}\right) \leq \frac{2}{N^{2}} \left\langle \left(\sum_{j=1}^{N}S_{j}^{2}\right)^{2}\psi_{N,L},\psi_{N,L}\right\rangle \lesssim \frac{C_{up}^{2}(1+|E_{N,L,\theta}|)^{2}}{\theta^{2}}.$$

Then, we prove the following theorem with a bootstrapping argument.

Theorem 2.15. Assume $L(N/L)^{\beta} \to 1^{-}$, $\beta < \frac{1}{2}$, and $\|V\|_{L^{\infty}_{z}L^{1}_{x}} \leq \frac{2\alpha}{C_{gn}^{4}}$ for some $\alpha \in (0,1)$, then we have $\liminf_{\substack{N,1/L \to \infty \\ L(N/L)^{\beta} \to 1^{-}}} E_{N,L,\varepsilon} \geq 0$

for
$$\varepsilon \in [0, 1 - \alpha)$$
.

Proof. From Lemma 2.13 and Lemma 2.14, we have

(2.100)
$$E_{N,L} \gtrsim -C_{\delta} \|V\|_{L_{z}^{\infty} L_{x}^{1}} (1+\lambda_{x}^{2})^{1+2\delta} \frac{d}{N} - \frac{C_{\delta} \|V\|_{L_{z}^{\infty} L_{x}^{1}}}{\min\left\{1+\lambda_{x}^{2}, 1+(\lambda_{z}^{2}-1)/L^{2}\right\}^{1/4-\delta/2}} \left(\frac{C_{up}(1+|E_{N,L,\theta}|)}{\theta}\right)^{5/4+3\delta/2}$$

Similarly, we use $e_{N,L}^{\varepsilon}$, $E_{N,L}^{\varepsilon}$, $E_{N,L,\theta}^{\varepsilon}$ to denote the ground state energy and C_{up}^{ε} to denote the upper bound in Lemma 2.10 with interaction function $V^{\varepsilon} = (1 - \varepsilon)^{-1}V$. Then, we obtain

(2.101)
$$E_{N,L}^{\varepsilon} \gtrsim C_{\delta} \|V^{\varepsilon}\|_{L_{x}^{\infty}L_{x}^{1}} (1+\lambda_{x}^{2})^{1+2\delta} \frac{d}{N} - \frac{C_{\delta} \|V^{\varepsilon}\|_{L_{x}^{\infty}L_{x}^{1}}}{\min\left\{1+\lambda_{x}^{2}, 1+(\lambda_{x}^{2}-1)/L^{2}\right\}^{1/4-\delta/2}} \left(\frac{C_{up}^{\varepsilon}(1+|E_{N,L,\theta}^{\varepsilon}|)}{\theta}\right)^{5/4+3\delta/2},$$

Noting that $E_{N,L,\varepsilon} = (1-\varepsilon)E_{N,L}^{\varepsilon}$ and $d \lesssim \lambda_x^2 \lambda_z$, we take $\theta = (\varepsilon' - \varepsilon)/(1-\varepsilon)$ to obtain

(2.102)
$$E_{N,L,\varepsilon} \ge -C(V,\delta,\varepsilon,\varepsilon') \left((1+\lambda_x^2)^{1+2\delta} \frac{\lambda_x^2 \lambda_z}{N} + \frac{|E_{N,L,\varepsilon'}|^{5/4+3\delta/2}}{\min\{1+\lambda_x^2, 1+(\lambda_z^2-1)/L^2\}^{1/4-\delta/2}} \right).$$

for all $0 < \varepsilon < \varepsilon' < 1/2$ and $\delta \in (0, 1/2), N \ge N(\delta, \varepsilon, \varepsilon')$. We make the induction hypothesis (labeled I_{η})

(2.103)
$$\lim_{\substack{N,1/L \to \infty \\ L(N/L)^{\beta} \to 1^{-}}} \frac{|E_{N,L,\varepsilon}|}{1 + (N/L)^{\eta}} < \infty \text{ for all } 0 < \varepsilon < 1 - \alpha.$$

We may assume I_{η} holds for $\eta = \eta_0$ as a start point. Under the assumption $L(N/L)^{\beta} \to 1^-$, we have $N^{-1} \sim (N/L)^{\beta-1}$.

Then, by taking $\lambda_z = 2$ and $\lambda_x = (N/L)^{\tau}$ with $\tau \leq \beta$, we deduce that $I_{\eta'}$ holds provided that (2.104) $\eta' > \max \{4\tau + \beta - 1, 5\eta_0/4 - \tau/2\}.$

With the optimal choice $\tau = 5\eta_0/18 + 2(1-\beta)/9$, we get

(2.105)
$$\eta' > \eta_0 + \frac{\eta_0 + \beta - 1}{9}$$

Noting that $\tau \leq \beta$, we have to require

$$(2.106) \qquad \qquad \eta_0 \le \frac{22\beta - 4}{5}.$$

By Theorem 2.5, we can choose $\eta_0 = 3\beta - 1$, which satisfies (2.106). With $\beta < 1/2$, we choose a constant c such that

$$0 < c < \frac{2 - 4\beta}{9}$$

and $I_{\eta'}$ holds with $\eta' = \eta_0 - c$. Repeating the process, we finally deduce that I_0 holds. It means that $|E_{N,L,\varepsilon}| \leq C_{\varepsilon}$ for $N \geq N_{\varepsilon}$. Then by taking $\lambda_z = 2$ and $\lambda_x = (N/L)^{\tau}$ with τ small enough, we use estimate (2.102) to obtain

$$\lim_{\substack{N,1/L\to\infty\\L(N/L)^{\beta}\to 1^{-}}} E_{N,L,\varepsilon} \ge 0.$$

By taking $\varepsilon = \frac{1-\alpha}{\sqrt{2}}$ in Theorem 2.15, we obtain Theorem 2.4.

2.4. High Energy estimates when k > 1. Assuming (2.1) holds for k, we now prove it for k + 2. By the induction hypothesis, we have

$$\frac{1}{c_0^{k+2}} \langle \psi_{N,L}, \left(2 + N^{-1} H_{N,L} - 1/L^2\right)^{k+2} \psi_{N,L} \rangle$$

$$\geq \frac{1}{c_0^2} \|S^{(k)}(2 + N^{-1} H_{N,L} - 1/L^2) \psi_{N,L}\|_{L^2}^2$$

$$= MS + E_C + E_P$$

where the main sum MS is

$$MS = \frac{1}{c_0^2 N^2 (N-1)^2} \sum_{\substack{1 \le i_1 < j_1 \le N \\ 1 \le i_2 < j_2 \le N \\ i_1 > k, i_2 > k}} \langle S^{(k)} (2 + H_{i_1 j_1}) \psi_{N,L}, S^{(k)} (2 + H_{i_2 j_2}) \psi_{N,L} \rangle,$$

the cross error term E_C is

$$E_C = \frac{1}{c_0^2 N^2 (N-1)^2} \sum_{\substack{1 \le i_1 < j_1 \le N \\ 1 \le i_2 < j_2 \le N \\ i_1 \le k, i_2 > k}} 2Re \langle S^{(k)}(2+H_{i_1j_1})\psi_{N,L}, S^{(k)}(2+H_{i_2j_2})\psi_{N,L} \rangle,$$

and the nonnegative error term E_P is

$$E_{P} = \frac{1}{c_{0}^{2}N^{2}(N-1)^{2}} \sum_{\substack{1 \leq i_{1} < j_{1} \leq N \\ 1 \leq i_{2} < j_{2} \leq N \\ i_{1} \leq k, i_{2} \leq k}} \langle S^{(k)}(2+H_{i_{1}j_{1}})\psi_{N,L}, S^{(k)}(2+H_{i_{2}j_{2}})\psi_{N,L} \rangle$$
$$= \frac{1}{c_{0}^{2}N^{2}(N-1)^{2}} \Big\langle \sum_{\substack{1 \leq i_{1} < j \leq N \\ i \leq k}} S^{(k)}(2+H_{ij})\psi_{N,L}, \sum_{\substack{1 \leq i_{1} < j \leq N \\ i \leq k}} S^{(k)}(2+H_{ij})\psi_{N,L} \Big\rangle$$
$$\geq 0.$$

2.4.1. Handling the main sum. Commuting $(1 + H_{i_1j_1})$ and $(1 + H_{i_2j_2})$ with $S^{(k)}$ in MS, we get $MS = M_1 + M_2 + M_3,$

where M_1 consists of the terms with

$$\{i_1, j_1\} \cap \{i_2, j_2\} = \emptyset,$$

 M_2 consists of the terms with

$$|\{i_1, j_1\} \cap \{i_2, j_2\}| = 1,$$

and M_3 consists of the terms with

$$|\{i_1, j_1\} \cap \{i_2, j_2\}| = 2.$$

By symmetric of $\psi_{N,L}$, we have

$$\begin{split} M_1 &= \frac{1}{4c_0^2} \langle S^{(k)}(2 + H_{(k+1)(k+2)})\psi_{N,L}, S^{(k)}(2 + H_{(k+3)(k+4)})\psi_{N,L} \rangle, \\ M_2 &= \frac{1}{2c_0^2} N^{-1} \langle S^{(k)}(2 + H_{(k+1)(k+2)})\psi_{N,L}, S^{(k)}(2 + H_{(k+2)(k+3)})\psi_{N,L} \rangle, \\ M_3 &= \frac{1}{2c_0^2} N^{-2} \langle S^{(k)}(2 + H_{(k+1)(k+2)})\psi_{N,L}, S^{(k)}(2 + H_{(k+1)(k+2)})\psi_{N,L} \rangle, \end{split}$$

up to an unimportant combination number.

Since $M_3 \ge 0$, we drop it. By the fact that

$$[2 + H_{(k+1)(k+2)}, 2 + H_{(k+3)(k+4)}] = 0,$$

we have

$$M_1 \ge \frac{4(1-\alpha)^2}{4c_0^2} \langle S^{(k)}\psi_{N,L}, S^2_{k+1}S^2_{k+2}S^{(k)}\psi_{N,L} \rangle$$

using Theorem 2.5 and Lemma A.6. Recall $c_0 = \min\left(\frac{1-\alpha}{\sqrt{2}}, \frac{1}{2}\right)$, hence

(2.107)
$$M_1 \ge 2\langle S^{(k+2)}\psi_{N,L}, S^{(k+2)}\psi_{N,L}\rangle = 2\|S^{(k+2)}\psi_{N,L}\|_{L^2}^2.$$

To deal with M_2 , we expand

$$M_2 = M_{21} + M_{22} + M_{23},$$

where

$$M_{21} = \frac{N^{-1}}{2c_0^2} \langle \left(2 + S_{k+1}^2 + S_{k+2}^2\right) S^{(k)} \psi_{N,L}, \left(2 + S_{k+2}^2 + S_{k+3}^2\right) S^{(k)} \psi_{N,L} \rangle,$$

$$M_{22} = \frac{N^{-1}}{c_0^2} Re \langle \left(2 + S_{k+1}^2 + S_{k+2}^2\right) S^{(k)} \psi_{N,L}, LV_{N,L} (r_{k+2} - r_{k+3}) S^{(k)} \psi_{N,L} \rangle,$$

$$M_{23} = \frac{N^{-1}}{2c_0^2} \langle LV_{N,L} (r_{k+1} - r_{k+2}) S^{(k)} \psi_{N,L}, LV_{N,L} (r_{k+2} - r_{k+3}) S^{(k)} \psi_{N,L} \rangle.$$

We keep only the S_{k+2}^4 terms inside M_{21} , which is the main contribution. That is,

(2.108)
$$M_{21} \ge \frac{N^{-1}}{2c_0^2} \langle S_{k+2}^2 S_{k+2}^2 S^{(k)} \psi_{N,L}, S^{(k)} \psi_{N,L} \rangle \ge 2N^{-1} \langle S_{k+1}^4 S^{(k)} \psi_N, S^{(k)} \psi_{N,L} \rangle$$
$$= 2N^{-1} \| S_1 S^{(k+1)} \psi_{N,L} \|_{L^2}^2.$$

For M_{22} , we expand

3. Compactness, Convergence, and Uniqueness

To work on compactness, convergence and uniqueness, we introduce an appropriate topology on the density matrices, as was previously done in [10, 16, 19, 23, 24, 32, 33, 34, 35, 36, 47, 64]. Denote the spaces of compact operators and trace class operators on $L^2(\Omega^{\otimes k})$ as \mathcal{K}_k and \mathcal{L}_k^1 , respectively. Then $(\mathcal{K}_k)' = \mathcal{L}_k^1$. By the fact that \mathcal{K}_k is separable, we select a dense countable subset $\left\{J_i^{(k)}\right\}_{i\geq 1} \subset \mathcal{K}_k$ in the unit ball of \mathcal{K}_k (so $\|J_i^{(k)}\|_{op} \leq 1$ where $\|\cdot\|_{op}$ is the operator norm). For $\gamma^{(k)}$, $\tilde{\gamma}^{(k)} \in \mathcal{L}_k^1$, we then define a metric d_k on \mathcal{L}_k^1 by

$$d_k(\gamma^{(k)}, \widetilde{\gamma}^{(k)}) = \sum_{i=1}^{\infty} 2^{-i} \Big| Tr J_i^{(k)} \left(\gamma^{(k)} - \widetilde{\gamma}^{(k)} \right) \Big|.$$

A uniformly bounded sequence $\tilde{\gamma}_{N,L}^{(k)} \in \mathcal{L}_k^1$ converges to $\tilde{\gamma}^{(k)}$ with respect to the weak* topology if and only if

$$\lim_{N,1/L\to\infty} d_k(\widetilde{\gamma}_{N,L}^{(k)},\widetilde{\gamma}^{(k)}) = 0.$$

For fixed T > 0, let $C([0, T]; \mathcal{L}_k^1)$ be the space of functions of $t \in [0, T]$ with values in \mathcal{L}_k^1 that are continuous with respect to the metric d_k . On $C([0, T]; \mathcal{L}_k^1)$, we define the metric

$$\hat{d}_k(\gamma^{(k)}(\cdot), \widetilde{\gamma}^{(k)}(\cdot)) = \sup_{t \in [0,T]} d_k(\gamma^{(k)}(t), \widetilde{\gamma}^{(k)}(t)),$$

and denote by τ_{prod} the topology on the space $\bigotimes_{k\geq 1} C([0,T];\mathcal{L}^1_k)$ given by the product of topologies generated by the metrics \hat{d}_k on $C([0,T],\mathcal{L}^1_k)$.

3.1. Compactness of the BBGKY sequence.

Theorem 3.1. Assume $L(N/L)^{\beta} \rightarrow 1^{-}$. Then the sequence

(3.2)
$$\left\{\Gamma_{N,L}(t) = \left\{\widetilde{\gamma}_{N,L}^{(k)}\right\}_{k=1}^{N}\right\} \subset \bigotimes_{k\geq 1} C\left([0,T];\mathcal{L}_{k}^{1}\right),$$

which satisfies the BBGKY hierarchy, is compact with respect to the product topology τ_{prod} . For any limit point $\Gamma(t) = \left\{ \widetilde{\gamma}^{(k)}(t) \right\}_{k=1}^{\infty}$, we have $\widetilde{\gamma}^{(k)}$ is a symmetric nonnegative trace class operator with trace bounded by 1.

Proof. By the standard diagonalization argument, it suffices to show the compactness of $\tilde{\gamma}_{N,L}^{(k)}$ for fixed k with respect to the metric \hat{d}_k . By the Arzelà-Ascoli theorem, this is equivalent to the equicontinuity of $\gamma_{N,L}^{(k)}$, and by, this is equivalent to the statement that for every observable $J^{(k)}$ from a dense subset of \mathcal{K}_k and for every $\varepsilon > 0$, there exists $\delta(J^{(k)}, \varepsilon)$ such that for all $t_1, t_2 \in [0, T]$ with $|t_1 - t_2| \leq \delta$, we have

(3.3)
$$\sup_{N,L} \left| Tr J^{(k)} \widetilde{\gamma}_{N,L}^{(k)}(t_1) - Tr J^{(k)} \widetilde{\gamma}_{N,L}^{(k)}(t_2) \right| \le \varepsilon.$$

We assume that compact operators $J^{(k)}$ have been cutoff in Lemma A.8. Since the observable $J^{(k)}$ can be written as a sum of a self-adjoint operator and an anti-self-adjoint operator, we may assume $J^{(k)}$ is self-adjoint. Inserting the decomposition (2.3) on the left and right sides of $\tilde{\gamma}_{N,L}^{(k)}$, we obtain

$$\left| Tr J^{(k)} \widetilde{\mathcal{P}}_{\alpha} \widetilde{\gamma}_{N,L}^{(k)} \widetilde{\mathcal{P}}_{\beta}(t_1) - Tr J^{(k)} \widetilde{\mathcal{P}}_{\alpha} \widetilde{\gamma}_{N,L}^{(k)} \widetilde{\mathcal{P}}_{\beta}(t_2) \right|$$
$$\leq C |t_2 - t_1| \left(\mathbb{1}_{\{\alpha = 0, \beta = 0\}} + \max\left\{ \mathbb{1}, L^{|\alpha| + |\beta| - 2} \right\} \mathbb{1}_{\{\alpha \neq 0 \text{ or } \beta \neq 0\}} \right).$$

By (3.5), we can directly establish (3.4) except for the case $|\alpha| + |\beta| = 1$. However, from Corollary 2.2, we can also get a bound

$$(3.6) \qquad \begin{aligned} \left| TrJ^{(k)}\widetilde{\mathcal{P}}_{\alpha}\widetilde{\gamma}_{N,L}^{(k)}\widetilde{\mathcal{P}}_{\beta}(t_{1}) - TrJ^{(k)}\widetilde{\mathcal{P}}_{\alpha}\widetilde{\gamma}_{N,L}^{(k)}\widetilde{\mathcal{P}}_{\beta}(t_{2}) \right| \\ \leq & 2\sup_{t} \left| \langle J^{(k)}\widetilde{\mathcal{P}}_{\alpha}\widetilde{\psi}_{N,L}(t), \widetilde{\mathcal{P}}_{\beta}\widetilde{\psi}_{N,L}(t) \rangle \right| \\ \leq & 2\|J^{(k)}\|_{op}\|\widetilde{\mathcal{P}}_{\alpha}\widetilde{\psi}_{N,L}(t)\|_{L^{2}}\|\widetilde{\mathcal{P}}_{\beta}\widetilde{\psi}_{N,L}(t)\|_{L^{2}} \\ \lesssim & L^{|\alpha|+|\beta|}. \end{aligned}$$

By averaging (3.5) and (3.6) in the case $|\alpha| + |\beta| = 1$, we obtain

$$\left| Tr J^{(k)} \widetilde{\mathcal{P}}_{\alpha} \widetilde{\gamma}_{N,L}^{(k)} \widetilde{\mathcal{P}}_{\beta}(t_1) - Tr J^{(k)} \widetilde{\mathcal{P}}_{\alpha} \widetilde{\gamma}_{N,L}^{(k)} \widetilde{\mathcal{P}}_{\beta}(t_2) \right| \lesssim |t_2 - t_1|^{1/2},$$

which suffices to establish (3.4).

Thus, we are left to prove (3.5) The BBGKY hierarchy (1.14) yields

(3.7)
$$\partial_t Tr J^{(k)} \widetilde{\mathcal{P}}_{\alpha} \widetilde{\gamma}_{N,L}^{(k)} \widetilde{\mathcal{P}}_{\beta} = I + II + III + IV,$$

where

$$\begin{split} I &= -i \sum_{j=1}^{k} Tr J^{(k)} \left[-\Delta_{x_{j}}, \widetilde{\mathcal{P}}_{\alpha} \widetilde{\gamma}_{N,L}^{(k)} \widetilde{\mathcal{P}}_{\beta} \right], \\ II &= -i \frac{1}{L^{2}} \sum_{j=1}^{k} Tr J^{(k)} \left[-\partial_{z_{j}}^{2}, \widetilde{\mathcal{P}}_{\alpha} \widetilde{\gamma}_{N,L}^{(k)} \widetilde{\mathcal{P}}_{\beta} \right], \\ III &= -i \frac{1}{N-1} \sum_{1 \leq i < j \leq k} Tr J^{(k)} \widetilde{\mathcal{P}}_{\alpha} \left[\widetilde{V}_{N,L}(r_{i} - r_{j}), \widetilde{\gamma}_{N,L}^{(k)} \right] \widetilde{\mathcal{P}}_{\beta}, \\ IV &= -i \frac{N-k}{N-1} \sum_{j=1}^{k} Tr J^{(k)} Tr_{r_{k+1}} \widetilde{\mathcal{P}}_{\alpha} \left[\widetilde{V}_{N,L}(r_{j} - r_{k+1}), \widetilde{\gamma}_{N,L}^{(k+1)} \right] \widetilde{\mathcal{P}}_{\beta}. \end{split}$$

First, we handle I. By Lemma A.7 and integration by parts, we have

$$I = i \sum_{j=1}^{k} \left(\langle J^{(k)} \Delta_{x_j} \widetilde{\mathcal{P}}_{\alpha} \widetilde{\psi}_{N,L}, \widetilde{\mathcal{P}}_{\beta} \widetilde{\psi}_{N,L} \rangle - \langle J^{(k)} \widetilde{\mathcal{P}}_{\alpha} \widetilde{\psi}_{N,L}, \widetilde{\mathcal{P}}_{\beta} \Delta_{x_j} \widetilde{\psi}_{N,L} \rangle \right)$$
$$= i \sum_{j=1}^{k} \left(\langle J^{(k)} \Delta_{x_j} \widetilde{\mathcal{P}}_{\alpha} \widetilde{\psi}_{N,L}, \widetilde{\mathcal{P}}_{\beta} \widetilde{\psi}_{N,L} \rangle - \langle \Delta_{x_j} J^{(k)} \widetilde{\mathcal{P}}_{\alpha} \widetilde{\psi}_{N,L}, \widetilde{\mathcal{P}}_{\beta} \widetilde{\psi}_{N,L} \rangle \right)$$

Hence

(3.8)
$$|I| \leq \sum_{j=1}^{k} \left(\|J^{(k)} \Delta_{x_j}\|_{op} + \|\Delta_{x_j} J^{(k)}\|_{op} \right) \|\widetilde{\mathcal{P}}_{\alpha} \widetilde{\psi}_{N,L}\|_{L^2} \|\widetilde{\mathcal{P}}_{\beta} \widetilde{\psi}_{N,L}\|_{L^2} \leq C_{k,J^{(k)}},$$

where in the last step we used the energy estimate.

Next, we consider II. When $\alpha = \beta = 0$, we have

$$II = -i\frac{1}{L^2}\sum_{j=1}^{k} TrJ^{(k)} \left[-\partial_{z_j}^2 - 1, \widetilde{\mathcal{P}}_{\mathbf{0}}\widetilde{\gamma}_{N,L}^{(k)}\widetilde{\mathcal{P}}_{\mathbf{0}} \right] = 0,$$

where we used $[1, \widetilde{\mathcal{P}}_{\alpha} \widetilde{\gamma}_{N,L}^{(k)} \widetilde{\mathcal{P}}_{\beta}] = 0$ in the first equality. When $|\alpha| + |\beta| \ge 1$, applying Lemma A.7 and integration by parts again, we have

$$\begin{split} II = & i \frac{1}{L^2} \sum_{j=1}^k \left(\langle J^{(k)} \partial_{z_j}^2 \widetilde{\mathcal{P}}_{\alpha} \widetilde{\psi}_{N,L}, \widetilde{\mathcal{P}}_{\beta} \widetilde{\psi}_{N,L} \rangle - \langle J^{(k)} \widetilde{\mathcal{P}}_{\alpha} \widetilde{\psi}_{N,L}, \partial_{z_j}^2 \widetilde{\mathcal{P}}_{\beta} \widetilde{\psi}_{N,L} \rangle \right) \\ = & i \frac{1}{L^2} \sum_{j=1}^k \left(\langle J^{(k)} \partial_{z_j}^2 \widetilde{\mathcal{P}}_{\alpha} \widetilde{\psi}_{N,L}, \widetilde{\mathcal{P}}_{\beta} \widetilde{\psi}_{N,L} \rangle - \langle \partial_{z_j}^2 J^{(k)} \widetilde{\mathcal{P}}_{\alpha} \widetilde{\psi}_{N,L}, \widetilde{\mathcal{P}}_{\beta} \widetilde{\psi}_{N,L} \rangle \right). \end{split}$$

Hence

$$|II| \leq \frac{1}{L^2} \sum_{j=1}^{k} \left(\|J^{(k)}\partial_{z_j}^2\|_{op} + \|\partial_{z_j}^2 J^{(k)}\|_{op} \right) \|\widetilde{\mathcal{P}}_{\alpha}\widetilde{\psi}_{N,L}\|_{L^2} \|\widetilde{\mathcal{P}}_{\beta}\widetilde{\psi}_{N,L}\|_{L^2}.$$

By the energy estimate (2.6),

(3.9)
$$|II| = 0,$$
 $|\alpha| + |\beta| = 0,$

$$(3.10) \qquad \qquad |II| \lesssim C_{k,J^{(k)}} L^{|\alpha|+|\beta|-2}, \qquad \qquad |\alpha|+|\beta| \ge 1.$$

Next, we consider III. Similarly,

$$\begin{split} III = & \frac{-i}{N-1} \sum_{1 \le i < j \le k} \langle J^{(k)} \widetilde{\mathcal{P}}_{\alpha} \widetilde{V}_{N,L} (r_i - r_j) \widetilde{\psi}_{N,L}, \widetilde{\mathcal{P}}_{\beta} \widetilde{\psi}_{N,L} \rangle \\ &+ \frac{i}{N-1} \sum_{1 \le i < j \le k} \langle J^{(k)} \widetilde{\mathcal{P}}_{\alpha} \widetilde{\psi}_{N,L}, \widetilde{\mathcal{P}}_{\beta} \widetilde{V}_{N,L} (r_i - r_j) \widetilde{\psi}_{N,L} \rangle \\ = & \frac{-i}{N-1} \sum_{1 \le i < j \le k} \langle J^{(k)} \widetilde{\mathcal{P}}_{\alpha} \widetilde{V}_{N,L} (r_i - r_j) \widetilde{\psi}_{N,L}, \widetilde{\mathcal{P}}_{\beta} \widetilde{\psi}_{N,L} \rangle \\ &+ \frac{i}{N-1} \sum_{1 \le i < j \le k} \langle \widetilde{\mathcal{P}}_{\alpha} \widetilde{\psi}_{N,L}, J^{(k)} \widetilde{\mathcal{P}}_{\beta} \widetilde{V}_{N,L} (r_i - r_j) \widetilde{\psi}_{N,L} \rangle. \end{split}$$

Let

$$W_{ij} = \langle \nabla_{r_i} \rangle^{-1} \langle \nabla_{r_j} \rangle^{-1} \widetilde{V}_{N,L}(r_i - r_j) \langle \nabla_{r_i} \rangle^{-1} \langle \nabla_{r_j} \rangle^{-1}.$$

Hence

$$\begin{aligned} |III| \lesssim N^{-1} \sum_{1 \leq i < j \leq k} \|J^{(k)} \langle \nabla_{r_i} \rangle \langle \nabla_{r_j} \rangle \|_{op} \|W_{ij}\|_{op} \|\langle \nabla_{r_i} \rangle \langle \nabla_{r_j} \rangle \widetilde{\psi}_{N,L}\|_{L^2} \|\widetilde{\mathcal{P}}_{\beta} \widetilde{\psi}_{N,L}\|_{L^2} \\ + N^{-1} \sum_{1 \leq i < j \leq k} \|\langle \nabla_{r_i} \rangle \langle \nabla_{r_j} \rangle J^{(k)}\|_{op} \|W_{ij}\|_{op} \|\langle \nabla_{r_i} \rangle \langle \nabla_{r_j} \rangle \widetilde{\psi}_{N,L}\|_{L^2} \|\widetilde{\mathcal{P}}_{\alpha} \widetilde{\psi}_{N,L}\|_{L^2}. \end{aligned}$$

Since $||W_{ij}||_{op} \lesssim ||\widetilde{V}_{N,L}||_{L_x^{\infty}L_x^1} \leq ||V||_{L_x^{\infty}L_x^1}$ by (2.60), the energy estimates (2.5) (2.6) imply that

$$(3.11) |III| \lesssim \frac{C_{k,J^{(k)}}}{N}.$$

For IV, we have

$$IV = -i\frac{N-k}{N-1}\sum_{j=1}^{k} \langle J^{(k)}\widetilde{\mathcal{P}}_{\alpha}\widetilde{V}_{N,L}(r_{j}-r_{k+1})\psi_{N,L},\widetilde{\mathcal{P}}_{\beta}\psi_{N,L}\rangle$$
$$+i\frac{N-k}{N-1}\sum_{j=1}^{k} \langle J^{(k)}\widetilde{\mathcal{P}}_{\alpha}\widetilde{V}_{N,L}(r_{j}-r_{k+1})\psi_{N,L},\widetilde{\mathcal{P}}_{\beta}\psi_{N,L}\rangle$$

Then, since $J^{(k)}\langle \nabla_{r_{k+1}}\rangle = \langle \nabla_{r_{k+1}}\rangle J^{(k)}$,

$$IV = -i\frac{N-k}{N-1}\sum_{j=1}^{k} \langle J^{(k)}\widetilde{\mathcal{P}}_{\alpha}\langle \nabla_{r_{j}}\rangle W_{j(k+1)}\langle \nabla_{r_{j}}\rangle\langle \nabla_{r_{k+1}}\rangle \widetilde{\psi}_{N,L}, \widetilde{\mathcal{P}}_{\beta}\langle \nabla_{r_{k+1}}\rangle \widetilde{\psi}_{N,L}\rangle + i\frac{N-k}{N-1}\sum_{j=1}^{k} \langle \langle \nabla_{r_{j}}\rangle J^{(k)}\widetilde{\mathcal{P}}_{\alpha}\langle \nabla_{r_{k+1}}\rangle \widetilde{\psi}_{N,L}, \widetilde{\mathcal{P}}_{\beta}W_{j(k+1)}\langle \nabla_{r_{j}}\rangle\langle \nabla_{r_{k+1}}\rangle \widetilde{\psi}_{N,L}\rangle.$$

Hence

$$|IV| \lesssim \sum_{j=1}^{k} \left(\|J^{(k)} \langle \nabla_{r_{j}} \rangle \|_{op} + \| \langle \nabla_{r_{j}} \rangle J^{(k)} \|_{op} \right) \|W_{j(k+1)} \|_{op} \| \langle \nabla_{r_{j}} \rangle \langle \nabla_{r_{k+1}} \rangle \widetilde{\psi}_{N,L} \|_{L^{2}} \| \langle \nabla_{r_{k+1}} \rangle \widetilde{\psi}_{N,L} \|_{L^{2}}$$

By energy estimate (2.5),

$$(3.12) |IV| \lesssim C_{k,J^{(k)}}.$$

Integrating (3.7) from t_1 to t_2 and putting (3.8), (3.9), (3.10), (3.11) and (3.12) together, we obtain (3.5).

Corollary 3.2. Let $\Gamma(t) = \{\widetilde{\gamma}^{(k)}\}_{k=1}^{\infty}$ be a limit point of $\{\Gamma_{N,L}(t) = \{\widetilde{\gamma}_{N,L}^{(k)}\}_{k=1}^{N}\}$, with respect to the product topology τ_{prod} . Then $\widetilde{\gamma}^{(k)}$ satisfies the priori bound

(3.13)
$$Tr\langle \nabla \rangle^{(k)} \widetilde{\gamma}^{(k)} \langle \nabla \rangle^{(k)} \le C^k$$

and takes the structure

(3.14)
$$\widetilde{\gamma}^{(k)}(t, (\mathbf{x}_k, \mathbf{z}_k); (\mathbf{x}'_k, \mathbf{z}'_k)) = \widetilde{\gamma}^{(k)}_x(t, \mathbf{x}_k; \mathbf{x}'_k) \left(\prod_{j=1}^k \frac{2}{\pi} \cos(z_j) \cos(z'_j)\right),$$

where $\widetilde{\gamma}_x^{(k)} = T r_z \widetilde{\gamma}^{(k)}$.

Proof. The estimate (3.13) follows by (2.5) in Corollary 2.2 and Theorem 3.1. To establish the formula (3.14), it suffices to prove $\tilde{\mathcal{P}}_{\alpha}\tilde{\gamma}^{(k)}\tilde{\mathcal{P}}_{\beta}=0$ if either $\alpha \neq 0$ or $\beta \neq 0$. This is equivalent to the statement that for any $J^{(k)} \in \mathcal{K}_k$, $TrJ^{(k)}\tilde{\mathcal{P}}_{\alpha}\tilde{\gamma}^{(k)}\tilde{\mathcal{P}}_{\beta}=0$. By Corollary (2.2), we obtain

(3.15)
$$TrJ^{(k)}\widetilde{\mathcal{P}}_{\alpha}\widetilde{\gamma}^{(k)}\widetilde{\mathcal{P}}_{\beta} = \lim_{\substack{N,1/L \to \infty \\ L(N/L)^{\beta} \to 1^{-}}} TrJ^{(k)}\widetilde{\mathcal{P}}_{\alpha}\widetilde{\gamma}_{N,L}^{(k)}\widetilde{\mathcal{P}}_{\beta}.$$

By Lemma A.7,

$$TrJ^{(k)}\widetilde{\mathcal{P}}_{\alpha}\widetilde{\gamma}_{N,L}^{(k)}\widetilde{\mathcal{P}}_{\beta} = \langle J^{(k)}\mathcal{P}_{\alpha}\widetilde{\psi}_{N,L}, \widetilde{\mathcal{P}}_{\beta}\widetilde{\psi}_{N,L} \rangle_{\mathcal{P}}$$

and by Cauchy-Schwarz and (2.6),

$$\begin{aligned} \left| Tr J^{(k)} \widetilde{\mathcal{P}}_{\alpha} \widetilde{\gamma}_{N,L} \widetilde{\mathcal{P}}_{\beta} \right| &\leq \| J^{(k)} \|_{op} \| \widetilde{\mathcal{P}}_{\alpha} \widetilde{\psi}_{N,L} \|_{L^{2}} \| \widetilde{\mathcal{P}}_{\beta} \widetilde{\psi}_{N,L} \|_{L^{2}} \\ &\leq C^{k} L^{|\alpha| + |\beta|}. \end{aligned}$$

Hence the right side of (3.15) is 0.

Theorem 3.3. The sequence

$$\Gamma_{x,N,L} = \left\{ \widetilde{\gamma}_{x,N,L} = Tr_z \widetilde{\gamma}_{N,L}^{(k)} \right\}_{k=1}^N \in \bigotimes_{k \ge 1} C\left([0,T]; \mathcal{L}_k^1(\mathbb{T}^{2k}) \right)$$

is compact with respect to the 2D version of the product topology τ_{prod} used in Theorem 3.1.

Proof. The proof is similar to the 3D case and we omit it. Also see [19, Theorem 5].

3.2. Limit points satisfy GP hierarchy. To prove the limit points satisfy the GP hierarchy, a technical tool we need is the approximation of identity type lemma, which is used to compare the δ -function and its approximation. Since we request $L(N/L)^{\beta} \to 1^{-}$, we see that $\tilde{V}_{N,L}(x,z)$ defined by (1.8) formally converges to $\delta(x) \int V(x,z) dx$. Thus, we need a modified version of this type lemma as follows.

Lemma 3.4. Let $\rho \in L^1(\Omega)$ be a function compactly supported on Ω such that

$$\sup_{z} \int |\rho(x,z)| |x| dx < \infty$$

and define $\rho_{\varepsilon,\lambda}(x,z) = \varepsilon^{-2}\lambda^{-1}\rho(x/\varepsilon,z/\lambda)$ and $g(z) = \int \rho(x,z)dx$. Then, for every $\kappa \in [0,1)$, there exists C > 0, such that

$$\begin{aligned} \left| Tr J^{(k)}(\rho_{\varepsilon,\lambda}(r_j - r_{k+1}) - \delta(x_j - x_{k+1})g(z_j - z_{k+1}))\gamma^{(k+1)} \right| \\ \leq & C\varepsilon^{\kappa} \sup_{z} \int |\rho(x,z)| |x|^{\kappa} dx \left(\|\langle \nabla_{x_j} \rangle^{-1} J^{(k)} \langle \nabla_{x_j} \rangle \|_{op} + \|\langle \nabla_{x_j} \rangle J^{(k)} \langle \nabla_{x_j} \rangle^{-1} \|_{op} \right) Tr \langle \nabla_{x_j} \rangle^2 \langle \nabla_{x_{k+1}} \rangle^2 \gamma^{(k+1)} \\ &+ C_J \|\rho_{1,\lambda} - \rho_{1,1}\|_{L^1} Tr \langle \nabla_{r_j} \rangle^2 \langle \nabla_{r_{k+1}} \rangle^2 \gamma^{(k+1)} \end{aligned}$$

for all nonnegative $\gamma^{(k+1)} \in \mathcal{L}^1_{k+1}$.

Proof. We will give a proof for Lemma 3.4 in the Appendix.

Theorem 3.5. Assume $L(N/L)^{\beta} \to 1^{-}$, and let $\Gamma(t) = \left\{ \widetilde{\gamma}^{(k)} \right\}_{k=1}^{\infty}$ be a limit point of $\left\{ \Gamma_{N,L}(t) = \left\{ \widetilde{\gamma}^{(k)}_{N,L}(t) \right\}_{k=1}^{N} \right\}$

with respect to the product topology τ_{prod} . Then $\left\{\widetilde{\gamma}_x^{(k)} = Tr_z\widetilde{\gamma}^{(k)}\right\}_{k=1}^{\infty}$ is a solution to the coupled focusing Gross-Pitaevskii hierarchy subject to initial data $\widetilde{\gamma}_x^{(k)}(0) = |\phi_0\rangle\langle\phi_0|^{\otimes k}$, which, rewritten in integral form, is (3.16)

$$\widetilde{\gamma}_{x}^{(k)} = U^{(k)}(t)\widetilde{\gamma}_{x}^{(k)}(0) - i\sum_{j=1}^{k} \int_{0}^{t} U^{(k)}(t-s)Tr_{x_{k+1}}Tr_{z} \left[\delta(x_{j}-x_{k+1})\int V(x,z_{j}-z_{k+1})dx, \widetilde{\gamma}^{(k+1)}(s)\right]ds,$$
(i) $U(x,z_{j}-z_{k+1})dx, \widetilde{\gamma}^{(k+1)}(s) = 0$

where $U^{(k)}(t) = \prod_{j=1}^{k} e^{it\Delta_{x_j}} e^{-it\Delta_{x'_j}}$.

Proof. Passing to subsequences if necessary, we have

(3.17)
$$\lim_{\substack{N,1/L\to\infty\\L(N/L)^{\beta}\to 1^{-}}} \sup_{t} Tr J^{(k)} \left(\widetilde{\gamma}_{N,L}^{(k)} - \widetilde{\gamma}^{(k)}(t) \right) = 0, \quad \forall J^{(k)} \in \mathcal{K}(L^2(\Omega^k))$$

(3.18)
$$\lim_{\substack{N,1/L \to \infty \\ L(N/L)^{\beta} \to 1^{-}}} \sup_{t} Tr J_x^{(k)} \left(\widetilde{\gamma}_{x,N,L}^{(k)} - \widetilde{\gamma}_x^{(k)}(t) \right) = 0, \quad \forall J_x^{(k)} \in \mathcal{K}(L^2(\mathbb{T}^{2k}))$$

from Theorem 3.1 and 3.3.

It suffices to test the limit point against the test function $J_x^{(k)} \in \mathcal{K}(L^2(\mathbb{T}^{2k}))$. We will prove that the limit point satisfies

(3.19)
$$Tr J_x^{(k)} \widetilde{\gamma}_x^{(k)}(0) = Tr J_x^{(k)} |\phi_0\rangle \langle \phi_0|^{\otimes k},$$

and

(3.20)
$$Tr J_x^{(k)} \widetilde{\gamma}_x^{(k)}(t) = Tr J_x^{(k)} U^{(k)}(t) \widetilde{\gamma}_x^{(k)}(0) + i \sum_{j=1}^k \int_0^t U^{(k)}(t-s) Tr_{x_{k+1}} Tr_z \left[\delta(x_j - x_{k+1})g(z_j - z_{k+1}), \widetilde{\gamma}^{(k+1)}(s) \right] ds,$$

where we adopt the notation $g(z) = \int V(x, z) dx$ for simplicity.

To end this, we use the coupled focusing BBGKY hierarchy, which is

(3.21)
$$Tr J_x^{(k)} \tilde{\gamma}_{x,N,L}^{(k)}(t) = A - \frac{i}{N-1} \sum_{i < j}^k B - i \left(1 - \frac{k+1}{N-1} \right) \sum_{j=1}^k D_j$$

where

$$\begin{split} A &= Tr J_x^{(k)} U^{(k)}(t) \widetilde{\gamma}_{x,N,L}^{(k)}(0), \\ B &= \int_0^t Tr J_x^{(k)} U^{(k)}(t-s) \left[\widetilde{V}_{N,L}(r_i-r_j), \widetilde{\gamma}_{N,L}^{(k)}(s) \right] ds, \\ D &= \int_0^t Tr J_x^{(k)} U^{(k)}(t-s) \left[\widetilde{V}_{N,L}(r_j-r_{k+1}), \widetilde{\gamma}_{N,L}^{(k+1)}(s) \right] ds. \end{split}$$

By (3.18), we have

(3.22)
$$\lim_{\substack{N,1/L \to \infty \\ L(N/L)^{\beta} \to 1^{-}}} Tr J_{x}^{(k)} \widetilde{\gamma}_{x,N,L}^{(k)}(t) = Tr J_{x}^{(k)} \widetilde{\gamma}_{x}^{(k)}(t),$$

(3.23)
$$\lim_{\substack{N,1/L \to \infty \\ L(N/L)^{\beta} \to 1^{-}}} Tr J_{x}^{(k)} U^{(k)}(t) \widetilde{\gamma}_{x,N,L}^{(k)}(0) = Tr J_{x}^{(k)} U^{(k)}(t) \widetilde{\gamma}_{x}^{(k)}(0).$$

By the argument in [56], we know, from assumption (*ii*) in Theorem 1.2,

$$\widetilde{\gamma}_{N,L}^{(1)}(0) \to \frac{2}{\pi} \phi_0(x_1) \overline{\phi_0}(x_1') \cos(z_1) \cos(z_1'), \quad strongly \ in \ trace \ norm;$$

that is,

$$\widetilde{\gamma}_{N,L}^{(k)}(0) \to \prod_{j=1}^{k} \frac{2}{\pi} \phi_0(x_j) \overline{\phi}_0(x'_j) \cos(z_j) \cos(z'_j), \quad strongly \ in \ trace \ norm.$$

Thus we have checked (3.19), the left-hand side of (3.20), and the first term on the right-hand side of (3.20) for the limit point. We are left to prove that

$$(3.24) \qquad \lim_{\substack{N,1/L \to \infty \\ L(N/L)^{\beta} \to 1^{-}}} \frac{B}{N-1} = 0,$$

$$(3.25) \qquad \lim_{\substack{N,1/L \to \infty \\ L(N/L)^{\beta} \to 1^{-}}} \left(1 - \frac{k+1}{N-1}\right) D = \int_{0}^{t} Tr J_{x}^{(k)} U^{(k)}(t-s) \left[\delta(x_{j} - x_{k+1})g(z_{j} - z_{k+1}), \widetilde{\gamma}^{(k+1)}(s)\right] ds.$$

First, we will show the boundedness of |B| and |D| for every finite time t. Noting that $[U^{(k)}, \langle \nabla_{r_i} \rangle] = 0$, we have

$$\begin{split} |B| &\leq \int_{0}^{t} \left| Tr J_{x}^{(k)} U^{(k)}(t-s) \left[\widetilde{V}_{N,L}(r_{i}-r_{j}), \widetilde{\gamma}_{N,L}^{(k)}(s) \right] \right| ds \\ &= \int_{0}^{t} ds \left| Tr \langle \nabla_{r_{i}} \rangle^{-1} \langle \nabla_{r_{j}} \rangle^{-1} J_{x}^{(k)} \langle \nabla_{r_{i}} \rangle \langle \nabla_{r_{j}} \rangle U^{(k)}(t-s) W_{ij} \langle \nabla_{r_{i}} \rangle \langle \nabla_{r_{j}} \rangle \widetilde{\gamma}_{N,L}^{(k)}(s) \langle \nabla_{r_{i}} \rangle \langle \nabla_{r_{j}} \rangle \\ &- Tr \langle \nabla_{r_{i}} \rangle \langle \nabla_{r_{j}} \rangle J_{x}^{(k)} \langle \nabla_{r_{i}} \rangle^{-1} \langle \nabla_{r_{j}} \rangle^{-1} U^{(k)}(t-s) \langle \nabla_{r_{i}} \rangle \langle \nabla_{r_{j}} \rangle \widetilde{\gamma}_{N,L}^{(k)} \langle \nabla_{r_{j}} \rangle W_{ij} \right| \\ &\leq \int_{0}^{t} ds \| \langle \nabla_{r_{i}} \rangle^{-1} \langle \nabla_{r_{j}} \rangle^{-1} J_{x}^{(k)} \langle \nabla_{r_{i}} \rangle \langle \nabla_{r_{j}} \rangle \|_{op} \| U^{(k)} \|_{op} \| W_{ij} \|_{op} Tr \langle \nabla_{r_{i}} \rangle^{2} \langle \nabla_{r_{j}} \rangle^{2} \widetilde{\gamma}_{N,L}^{(k)}(s) \\ &+ \int_{0}^{t} ds \| \langle \nabla_{r_{i}} \rangle \langle \nabla_{r_{j}} \rangle J_{x}^{(k)} \langle \nabla_{r_{i}} \rangle^{-1} \langle \nabla_{r_{j}} \rangle^{-1} \|_{op} \| U^{(k)} \|_{op} \| W_{ij} \|_{op} Tr \langle \nabla_{r_{i}} \rangle^{2} \langle \nabla_{r_{j}} \rangle^{2} \widetilde{\gamma}_{N,L}^{(k)}(s) \\ &\leq C_{J} t. \end{split}$$

|D| can be estimated in the same way as |B| and hence

$$|D| \le C_J t.$$

That is,

$$\lim_{\substack{N,1/L \to \infty \\ L(N/L)^{\beta} \to 1^{-}}} \frac{B}{N-1} = \lim_{\substack{N,1/L \to \infty \\ L(N/L)^{\beta} \to 1^{-}}} \frac{(k+1)D}{N-1} = 0.$$

Next, we will use Lemma 3.4 to prove

(3.26)
$$\lim_{\substack{N,1/L \to \infty \\ L(N/L)^{\beta} \to 1^{-}}} D = \int_{0}^{t} Tr J_{x}^{(k)} U^{(k)}(t-s) \left[\delta(x_{j} - x_{k+1}) g(z_{j} - z_{k+1}), \widetilde{\gamma}^{(k+1)}(s) \right] ds$$

Let $\eta \in L^1(\mathbb{T}^2)$ be a smooth probability density function compactly supported on $(-\pi, \pi)^2$ and define $\eta_{\varepsilon}(x) = \varepsilon^{-2} \eta(x/\varepsilon)$. For simplicity, we adopt the notation $M_{s,t}^{(k)} = J_x^{(k)} U^{(k)}(t-s)$. Then, we expand

$$Tr J_x^{(k)} U^{(k)}(t-s) \left(\tilde{V}_{N,L}(r_j - r_{k+1}) \tilde{\gamma}_{N,L}^{(k+1)}(s) - \delta(x_j - x_{k+1}) g(z_j - z_{k+1}) \tilde{\gamma}^{(k+1)}(s) \right)$$

= I + II + III + IV,

where

$$\begin{split} I &= Tr M_{s,t}^{(k)} \left(\widetilde{V}_{N,L}(r_j - r_{k+1}) - \delta(x_j - x_{k+1}) g(z_j - z_{k+1}) \right) \widetilde{\gamma}_{N,L}^{(k+1)}(s), \\ II &= Tr M_{s,t}^{(k)} \left(\delta(x_j - x_{k+1}) - \eta_{\varepsilon}(x_j - x_{k+1}) \right) g(z_j - z_{k+1}) \widetilde{\gamma}_{N,L}^{(k+1)}(s), \\ III &= Tr M_{s,t}^{(k)} \eta_{\varepsilon}(x_j - x_{k+1}) g(z_j - z_{k+1}) \left(\widetilde{\gamma}_{N,L}^{(k+1)}(s) - \widetilde{\gamma}^{(k+1)}(s) \right), \\ IV &= Tr M_{s,t}^{(k)} \left(\eta_{\varepsilon}(x_j - x_{k+1}) - \delta(x_j - x_{k+1}) \right) g(z_j - z_{k+1}) \widetilde{\gamma}_{N,L}^{(k+1)}(s). \end{split}$$

It needs only to prove I - IV converge to 0 as $N, 1/L \to \infty$. By Lemma 3.4, we have

$$(3.27) |I| = \left| Tr M_{s,t}^{(k)} \left(\widetilde{V}_{N,L}(r_j - r_{k+1}) - \delta(x_j - x_{k+1})g(z_j - z_{k+1}) \right) \widetilde{\gamma}_{N,L}^{(k+1)}(s) \right| \\ \leq \frac{C}{(N/L)^{\beta\kappa}} \sup_{z} \int |V(x,z)| |x|^{\kappa} dx \left(\left\| \langle \nabla_{x_j} \rangle J_x^{(k)} \langle \nabla_{x_j} \rangle^{-1} \right\|_{op} + \left\| \langle \nabla_{x_j} \rangle^{-1} J_x^{(k)} \langle \nabla_{x_j} \rangle \right\|_{op} \right) \\ \times Tr \langle \nabla_{x_j} \rangle \langle \nabla_{x_{k+1}} \rangle \widetilde{\gamma}_{N,L}^{(k+1)}(s) \langle \nabla_{x_{k+1}} \rangle \langle \nabla_{x_j} \rangle + C_J \| \widetilde{V}_{1,\lambda} - \widetilde{V}_{1,1} \|_{L^1} Tr \langle \nabla_{r_j} \rangle^2 \langle \nabla_{r_{k+1}} \rangle^2 \gamma_{N,L}^{(k+1)} \\ \leq C_J \left[\frac{\sup_{z} \int |V(x,z)| |x|^{\kappa} dx}{(N/L)^{\beta\kappa}} + \| L(N/L)^{\beta} \widetilde{V}(x, L(N/L)^{\beta}z) - \widetilde{V}(x,z) \|_{L^1} \right].$$

Similarly, for II and IV, via Lemma 3.4, we have

where the last inequality follows from Corollary 2.2, and

$$(3.29) |IV| = |TrM_{s,t}^{(k)} \left(\eta_{\varepsilon}(x_{j} - x_{k+1}) - \delta(x_{j} - x_{k+1})\right) g(z_{j} - z_{k+1}) \widetilde{\gamma}^{(k+1)}(s)| \\ \leq C\varepsilon^{\kappa} ||V||_{L_{z}^{\infty}L_{x}^{1}} \int \eta(x)|x|^{\kappa} dx \left(\left\| \langle \nabla_{x_{j}} \rangle J_{x}^{(k)} \langle \nabla_{x_{j}} \rangle^{-1} \right\|_{op} + \left\| \langle \nabla_{x_{j}} \rangle^{-1} J_{x}^{(k)} \langle \nabla_{x_{j}} \rangle \right\|_{op} \right) \\ \times Tr \langle \nabla_{x_{j}} \rangle \langle \nabla_{x_{k+1}} \rangle \widetilde{\gamma}^{(k+1)}(s) \langle \nabla_{x_{k+1}} \rangle \langle \nabla_{x_{j}} \rangle \\ \leq C_{J} \varepsilon^{\kappa},$$

where the last inequality follows from Corollary 3.2. That is,

$$|II| \leq C_J \varepsilon^{\kappa} \text{ and } |IV| \leq C_J \varepsilon^{\kappa}.$$

Hence II and IV converge to 0 as $\varepsilon \to 0,$ uniformly in N and L. For III,

$$(3.30) |III| = \left| Tr M_{s,t}^{(k)} \eta_{\varepsilon} (x_j - x_{k+1}) g(z_j - z_{k+1}) \left(\widetilde{\gamma}_{N,L}^{(k+1)}(s) - \widetilde{\gamma}^{(k+1)}(s) \right) \right| \\ \leq \left| Tr M_{s,t}^{(k)} \eta_{\varepsilon} (x_j - x_{k+1}) g(z_j - z_{k+1}) \frac{1}{1 + \theta \langle \nabla_{r_{k+1}} \rangle} \left(\widetilde{\gamma}_{N,L}^{(k+1)}(s) - \widetilde{\gamma}^{(k+1)}(s) \right) \right| \\ + \left| Tr M_{s,t}^{(k)} \eta_{\varepsilon} (x_j - x_{k+1}) g(z_j - z_{k+1}) \frac{\theta \langle \nabla_{r_{k+1}} \rangle}{1 + \theta \langle \nabla_{r_{k+1}} \rangle} \left(\widetilde{\gamma}_{N,L}^{(k+1)}(s) - \widetilde{\gamma}^{(k+1)}(s) \right) \right|.$$

The first term in the above estimate goes to zero as N, $1/L \to \infty$ for every $\theta > 0$, since we have condition (3.17) and $M_{s,t}^{(k)} \eta_{\varepsilon}(x_j - x_{k+1}) g(z_j - z_{k+1}) \frac{1}{1 + \theta \langle \nabla_{r_{k+1}} \rangle}$ is a compact operator. Due to the energy bounds on $\widetilde{\gamma}_{N,L}^{(k+1)}$ and $\widetilde{\gamma}^{(k+1)}$, the second term tends to zero as $\theta \to 0$, uniformly in N and L.

Putting together the estimates for I - IV, we have established (3.26). Hence, we have obtained Theorem 3.5.

Combining Corollary 3.2 and Theorem 3.5, we see that $\tilde{\gamma}_x^{(k)}$ solves the 2D Gross-Pitaevskii hierarchy with the desired coupling constant $g_0 = \frac{4}{\pi^2} \int \int V(x, z_1 - z_2) dx |\cos(z_1) \cos(z_2)|^2 dz_1 dz_2$.

Corollary 3.6. Assume $L(N/L)^{\beta} \to 1^{-}$, and let $\Gamma(t) = \left\{ \widetilde{\gamma}^{(k)} \right\}_{k=1}^{\infty}$ be a limit point of

$$\left\{\Gamma_{N,L}(t) = \left\{\widetilde{\gamma}_{N,L}^{(k)}(t)\right\}_{k=1}^{N}\right\}$$

with respect to the product topology τ_{prod} . Then $\left\{\widetilde{\gamma}_x^{(k)} = Tr_z\widetilde{\gamma}^{(k)}\right\}_{k=1}^{\infty}$ is a solution to the 2D Gross-Pitaevskii hierarchy subject to initial data $\widetilde{\gamma}_x^{(k)}(0) = |\phi_0\rangle\langle\phi_0|^{\otimes k}$ with coupling constant

$$g_0 = \frac{4}{\pi^2} \int \int V(x, z_1 - z_2) dx |\cos(z_1)\cos(z_2)|^2 dz_1 dz_2,$$

which, rewritten in integral form, is

(3.31)
$$\widetilde{\gamma}_x^{(k)}(t) = U^{(k)}(t)\widetilde{\gamma}_x^{(k)}(0) - ig_0 \sum_{j=1}^k \int_0^t U^{(k)}(t-s)Tr_{x_{k+1}} \left[\delta(x_j - x_{k+1}), \widetilde{\gamma}_x^{(k+1)}(s)\right] ds.$$

Proof. The inhomogeneous term in hierarchy (3.16) is

$$\begin{split} &i \int_0^t U^{(k)}(t-s) Tr_{x_{k+1}} Tr_z \left[\delta(x_j - x_{k+1}) \int V(x, z_j - z_{k+1}) dx, \widetilde{\gamma}^{(k+1)}(s) \right] ds \\ &= i \int_0^t U^{(k)}(t-s) Tr_{x_{k+1}} Tr_z \left(\delta(x_j - x_{k+1}) \int V(x, z_j - z_{k+1}) dx \widetilde{\gamma}^{(k+1)}(s) \right) ds \\ &- i \int_0^t U^{(k)}(t-s) Tr_{x_{k+1}} Tr_z \left(\delta(x'_j - x'_{k+1}) \int V(x, z'_j - z'_{k+1}) dx \widetilde{\gamma}^{(k+1)}(s) \right) ds \\ &= I - II. \end{split}$$

From Corollary 3.2, we have

$$I = i \int_0^t U^{(k)}(t-s) Tr_{x_{k+1}} \left(\delta(x_j - x_{k+1}) \widetilde{\gamma}_x^{(k+1)}(s) Tr_z \left(\int V(x, z_j - z_{k+1}) dx \prod_{j=1}^{k+1} \frac{2}{\pi} \cos(z_j) \cos(z'_j) \right) \right) ds$$

= $i g_0 \int_0^t U^{(k)}(t-s) Tr_{x_{k+1}} \left(\delta(x_j - x_{k+1}) \widetilde{\gamma}_x^{(k+1)}(s) \right) ds.$

In the same manner we can see that

$$II = ig_0 \int_0^t U^{(k)}(t-s) Tr_{x_{k+1}} \left(\delta(x'_j - x'_{k+1}) \widetilde{\gamma}_x^{(k+1)}(s) \right) ds$$

In summary, we have

$$\widetilde{\gamma}_{x}^{(k)}(t) = U^{(k)}(t)\widetilde{\gamma}_{x}^{(k)}(0) - ig_0 \sum_{j=1}^{k} \int_0^t U^{(k)}(t-s)Tr_{x_{k+1}} \left[\delta(x_j - x_{k+1}), \widetilde{\gamma}_{x}^{(k+1)}(s)\right] ds.$$

3.3. Uniqueness of the 2D GP Hierarchy. By Bourgain [6], as we are below the Gagliardo-Nirenberg threshold here, we have the H^1 global wellposedness for the \mathbb{T}^2 focusing cubic NLS (1.11). Thus, when $\tilde{\gamma}_x^{(k)}(0) = |\phi_0\rangle\langle\phi_0|^{\otimes k}$, we know one solution to the focusing GP hierarchy (1.14), namely $|\phi\rangle\langle\phi|^{\otimes k}$, where ϕ solves (1.11).

Theorem 3.7 ([42, 43, 47]). There is at most one nonnegative operator sequence

$$\left\{\gamma_x^{(k)}\right\}_{k=1}^{\infty} \in \bigotimes_{k \ge 1} C\left([0,T], \mathcal{L}_k^1(\mathbb{T}^2)\right)$$

that solves the 2D Gross-Pitaevskii hierarchy (3.31) subject to the energy condition

(3.32)
$$Tr\left(\prod_{j=1}^{k} (1-\Delta_{x_j})\right)\gamma_x^{(k)} \le C^k.$$

From Theorem 3.7, we conclude that the compact sequence

$$\left\{\Gamma_{N,L}(t) = \left\{\widetilde{\gamma}_{N,L}^{(k)}\right\}_{k=1}^{N}\right\}$$

has only one $L(N/L)^{\beta} \to 1^{-}$ limit point, namely

$$\widetilde{\gamma}^{(k)} = \prod_{j=1}^{k} \frac{2}{\pi} \phi(t, x_j) \overline{\phi}(t, x'_j) \cos(z_j) \cos(z'_j).$$

We then infer that as trace class operators

$$\widetilde{\gamma}_{N,L}^{(k)} \to \prod_{j=1}^{k} \frac{2}{\pi} \phi(t, x_j) \overline{\phi}(t, x'_j) \cos(z_j) \cos(z'_j) \ weak^*.$$

Since the limit point $\tilde{\gamma}^{(k)}$ is an orthogonal projection, the well-known argument in [35, P_{296}] upgrades the weak^{*} convergence to strong, by using Grümm's convergence theorem [63, Theorem 2.19].

APPENDIX A. BASIC OPERATOR FACTS AND SOBOLEV-TYPE LEMMAS

Lemma A.1 (Hoffman-Ostenhof inequality[44]). For $\psi_N \in H^1(\mathbb{T}^{dN})$, we have

(A.1)
$$\|\nabla_x \sqrt{\rho_N}\|_{L^2(\mathbb{T}^d)} \le \|\nabla_{x_1} \psi_N\|_{L^2(\mathbb{T}^{dN})}.$$

with the one-particle density

$$\rho_N(x) = \int_{\mathbb{T}^d} \cdots \int_{\mathbb{T}^d} |\psi_N(x, x_2, ..., x_N)|^2 dx_2 \cdots dx_N$$

Proof. We may assume ψ_N is a test function, So $\rho_N(x) \in C^\infty(\mathbb{T}^d)$. By Cauchy-Schwarz inequality, we have

$$\begin{aligned} \|\nabla_x \sqrt{\rho_N + \varepsilon}\|_{L^2}^2 &= \int \left|\frac{\nabla_x \rho_N}{2\sqrt{\rho_N + \varepsilon}}\right|^2 dx \\ &= \int \frac{|\int \psi_N \nabla_x \psi_N dx_2 \cdots dx_N|^2}{\rho_N(x) + \varepsilon} dx \\ &\leq \int |\nabla_x \psi_N|^2 dx_2 \cdots dx_N \frac{\rho_N(x)}{\rho_N(x) + \varepsilon} dx \\ &\leq \int |\nabla_x \psi_N|^2 dx dx_2 \cdots dx_N. \end{aligned}$$

Thus, $\sqrt{\rho_N + \varepsilon}$ is uniform bounded in $H^1(\mathbb{T}^d)$ norm. We note that $-\Delta_x$ is a self-adjoint operator on $H^1(\mathbb{T}^d)$ and $\sqrt{\rho_N + \varepsilon}$ converges to $\sqrt{\rho_N}$ in $L^2(\mathbb{T}^d)$ norm as $\varepsilon \to 0$. From the definition of adjoint operator, we deduce that $\sqrt{\rho_N} \in H^1(\mathbb{T}^d)$ and

$$\|\nabla_x \sqrt{\rho_N}\|_{L^2}^2 \le \int |\nabla_x \psi_N|^2 dx dx_2 \cdots dx_N.$$

Lemma A.2. Assume $L(N/L)^{\beta} \to 1^{-}$. For $\delta \in (0,1)$, the multiplication operator $V_{N,L}(r_1 - r_2)$ on $L^2(\Omega_L^{\otimes 2})$ satisfies

(A.2)
$$L|V_{N,L}(r_1 - r_2)| \le C_{\delta}(N/L)^{\delta} ||V||_{L^{\infty}_{z} L^{1+\delta}_{x}} (1 - \Delta_{x_1}),$$

(A.3)
$$L|V_{N,L}(r_1 - r_2)| \le C_{\delta} \|V\|_{L_z^{\infty} L_x^1} (1 - \Delta_{x_1})^{1/2 + \delta} (1 - \Delta_{x_2})^{1/2 + \delta},$$

(A.4)
$$\|\langle \nabla_{x_1} \rangle^{-1} \langle \nabla_{x_2} \rangle^{-1} V(r_1 - r_2) \langle \nabla_{x_1} \rangle^{-1} \langle \nabla_{x_2} \rangle^{-1} \|_{op} \le C \|V\|_{L^{\infty}_z L^1_x},$$

(A.5)
$$S_1^2 L V_{N,L}(r_1 - r_2) + L V_{N,L}(r_1 - r_2) S_1^2 \ge -C_{\delta}(V) (N/L)^{\beta + \delta} S_1^2 S_2^2$$

where $C_{\delta}(V)$ is dependent on V.

Proof. For estimate (A.2), by Hölder and Sobolev inequality, we get

(A.6)
$$\langle LV_{N,L}(r_1 - r_2)\varphi_L, \varphi_L \rangle \leq \|LV_{N,L}\|_{L_z^{\infty}L_x^{1+}} \|\varphi_L\|_{L^2L_{x_1}^{\infty-}}^2$$
$$\leq C_{\delta}L(N/L)^{\beta+\delta} \|V\|_{L_z^{\infty}L_x^{1+\delta}} \|\sqrt{1 - \Delta_{x_1}}\varphi_L\|_{L^2}^2$$
$$= C_{\delta}L(N/L)^{\beta+\delta} \|V\|_{L_{\infty}^{\infty}L_x^{1+\delta}} \langle (1 - \Delta_{x_1})\varphi_L, \varphi_L \rangle.$$

With $L(N/L)^{\beta} \to 1^-$, we obtain estimate (A.2).

For estimate (A.3), we recall Littlewood-Paley projectors defined by (2.54) and decompose φ_L that

(A.7)
$$\varphi_L = \varphi_{L,1} + \varphi_{L,2}$$

where

$$\varphi_{L,1} = \sum_{0 \le m_1 < m_2} P_{x_1,m_1} P_{x_2,m_2} \varphi_L,$$

and

$$\varphi_{L,2} = \sum_{0 \le m_2 \le m_1} P_{x_1,m_1} P_{x_2,m_2} \varphi_L.$$

Then we have

(A.8)
(A.9)

$$\begin{aligned} \|\sqrt{1-\Delta_{x_1}}\varphi_{L,1}\|_{L^2} &\leq \|\sqrt{1-\Delta_{x_2}}\varphi_{L,1}\|_{L^2}, \\ \|\sqrt{1-\Delta_{x_2}}\varphi_{L,2}\|_{L^2} &\leq \|\sqrt{1-\Delta_{x_1}}\varphi_{L,2}\|_{L^2}. \end{aligned}$$

By estimates (A.8), (A.9) and Sobolev inequality, we find that

$$(A.10) \qquad |\langle LV_{N,L}(r_{1}-r_{2})\varphi_{L},\varphi_{L}\rangle| \\ \leq \int L|V_{N,L}(r_{1}-r_{2})|(|\varphi_{L,1}|^{2}+|\varphi_{L,2}|^{2})dr_{1}dr_{2} \\ \leq L\|V_{N,L}\|_{L_{z}^{\infty}L_{x}^{1}}(\|\varphi_{L,1}\|_{L^{2}L_{x_{1}}^{\infty}}^{2}+\|\varphi_{L,2}\|_{L^{2}L_{x_{2}}}^{2}) \\ \leq C_{\delta}L(N/L)^{\beta}\|V\|_{L_{z}^{\infty}L_{x}^{1}}\left(\|(\sqrt{1-\Delta_{x_{1}}})^{1+2\delta}\varphi_{L,1}\|_{L^{2}}^{2}+\|(\sqrt{1-\Delta_{x_{2}}})^{1+2\delta}\varphi_{L,2}\|_{L^{2}}^{2}\right) \\ \leq C_{\delta}L(N/L)^{\beta}\|V\|_{L_{z}^{\infty}L_{x}^{1}}\langle(1-\Delta_{x_{1}})^{1/2+\delta}(1-\Delta_{x_{2}})^{1/2+\delta}\varphi_{L},\varphi_{L}\rangle.$$

With $L(N/L)^{\beta} \to 1^{-}$, we obtain estimate (A.3).

For estimate (A.4), in the same manner as estimate (A.3), we get

(A.11)
$$\langle |V(r_1 - r_2)|\varphi,\varphi\rangle \le C ||V||_{L_z^{\infty}L_x^1} \langle (1 - \Delta_{x_1})(1 - \Delta_{x_2})\varphi,\varphi\rangle,$$

which is equivalent to

$$\langle \nabla_{x_1} \rangle^{-1} \langle \nabla_{x_2} \rangle^{-1} |V(r_1 - r_2)| \langle \nabla_{x_1} \rangle^{-1} \langle \nabla_{x_2} \rangle^{-1} \le C ||V||_{L^{\infty}_z L^1_x}.$$

By Property 2 in Lemma A.6, we obtain estimate (A.4).

For estimate (A.5), we decompose

$$\langle S_1^2 L V_{N,L}(r_1 - r_2) \varphi_L, \varphi_L \rangle$$
$$= \langle (1 - \Delta_{x_1}) (L V_{N,L}(r_1 - r_2) \varphi_L), \varphi_L \rangle + \langle (-\partial_{z_1}^2 - 1/L^2) (L V_{N,L}(r_1 - r_2) \varphi_L), \varphi_L \rangle$$
$$= A + B.$$

It needs only to control A and B. Using the identity $\nabla_{x_1} V_{N,L}(r_1 - r_2) = -\nabla_{x_2} V_{N,L}(r_1 - r_2)$ and integration by parts, we get

By Hölder and Sobolev inequality, we have

$$\leq L(N/L)^{2\beta} \|V\|_{L_{z}^{\infty}L_{x}^{2}} \|\sqrt{1-\Delta_{x_{2}}}\nabla_{x_{1}}\varphi_{L}\|_{L^{2}} \|\nabla_{x_{1}}\varphi_{L}\|_{L^{2}}^{2}$$
$$\leq L(N/L)^{2\beta} \|V\|_{L_{z}^{\infty}L_{x}^{2}} \langle S_{1}^{2}S_{2}^{2}\varphi_{L},\varphi_{L} \rangle.$$

Estimated in the same way as A_1 ,

(A.15)
$$|A_2| \leq \int L |V_{N,L}(r_1 - r_2)| (|\nabla_{x_1} \varphi_L|^2 + \nabla_{x_2} \varphi_L|^2) dr_1 dr_2$$
$$\leq L (N/L)^{2\beta} \|V\|_{L^{\infty}_{z} L^2_x} \langle S_1^2 S_2^2 \varphi_L, \varphi_L \rangle.$$

For A_3 , we have

$$|A_3| \leq ||LV_{N,L}(r_1 - r_2)\varphi_L||_{L^2} ||\nabla_{x_1} \nabla_{x_2} \varphi_L||_{L^2}$$
$$\leq CL(N/L)^{2\beta} ||V||_{L^{\infty}_z L^2_x} \langle (1 - \Delta_{x_1})(1 - \Delta_{x_2})\varphi_L, \varphi_L \rangle,$$

where we have used estimate (A.3) with $\delta = 1/2$ and V replaced by V^2 in the last inequality. Hence we have

$$= \langle -\partial_{z_1}^2 (L V_{N,L} (r_1 - r_2) \varphi_L), P_{z_1,>1} \varphi_L \rangle - L^{-2} \langle L V_{N,L} (r_1 - r_2) \varphi_L, P_{z_1,>1} \varphi_L \rangle$$
$$= B_1 + B_2.$$

For B_1 , we expand

$$B_1 = B_{11} + B_{12},$$

where

$$B_{11} = \langle L(\partial_{z_1} V_{N,L}(r_1 - r_2))\varphi_L, \partial_{z_1} P_{z_1,>1}\varphi_L \rangle,$$

$$B_{12} = \langle LV_{N,L}(r_1 - r_2)\partial_{z_1}\varphi_L, \partial_{z_1} P_{z_1,>1}\varphi_L \rangle$$

For B_{11} , applying Hölder inequality at x_2 , we obtain

$$|B_{11}| \leq ||L\partial_{z_1}V_{N,L}(r_1 - r_2)||_{L^{\infty}_{z_2}L^{1+}_{x_2}} ||\varphi_L||_{L^2L^{\infty-}_{x_2}} ||\partial_{z_1}P_{z_1,>1}\varphi_L||_{L^2L^{\infty-}_{x_2}} \\ \leq C_{\delta}L(N/L)^{2\beta+\delta} ||\partial_z V||_{L^{\infty}_{z}L^{1+\delta}_{x}} ||S_2\varphi_L||_{L^2} ||S_2\partial_{z_1}P_{z_1,>1}\varphi_L||_{L^2} \\ \leq C_{\delta}L(N/L)^{2\beta+\delta} ||\partial_z V||_{L^{\infty}_{x}L^{1+\delta}_{x}} \langle S_1^2 S_2^2 \varphi_L, \varphi_L \rangle.$$

where we have used estimate (A.29) in the last inequality.

Computing in the same way, we have

$$\leq C_{\delta}(N/L)^{\beta+\delta} ||V||_{L^{\infty}_{z}L^{1+\delta}_{x}} ||S_2S_1\varphi_L||^2_{L^2},$$

where we have used (A.28) and (A.29) in the last inequality.

Hence, with $L(N/L)^{\beta} \to 1^{-}$, we have

$$\leq C_{\delta}L^{-1}(N/L)^{\beta+\delta} \|V\|_{L^{\infty}_{z}L^{1+\delta}_{x}} \|S_{2}\varphi_{L}\|_{L^{2}} \|S_{2}P_{z_{1},>1}\varphi_{L}\|_{L^{2}}$$

$$\leq C_{\delta}(N/L)^{\beta+\delta} \|V\|_{L^{\infty}_{x}L^{1+\delta}_{x}} \langle S^{2}_{1}S^{2}_{2}\varphi_{L},\varphi_{L}\rangle,$$

where we used $L^{-2}P_{z_1,>1} \leq S_1^2 P_{z_1,>1}$ in the last inequality.

Putting (A.17) (A.22) and (A.23) together, with $L(N/L)^{\beta} \to 1^{-}$, we obtain estimate (A.5).

Lemma A.3. Let $A : D(A) \mapsto H$, be a positive selfadjoint operator in the Hilbert space H, and let $0 < \alpha < 1$. Then

Recall Lemma 3.4, we now give the proof as follows.

for all nonnegative $\gamma^{(k+1)} \in \mathcal{L}^1_{k+1}$.

Proof. We present a proof by modifying the proof in [47]. Such a method has been used by various authors, for example [19]. It suffices to prove the estimate for k = 1. Since the observable $J^{(1)}$ can be written as a sum of a self-adjoint operator and an anti-self-adjoint operator, we may assume $J^{(1)}$ is self-adjoint. We represent $\gamma^{(2)}$ by $\gamma^{(2)} = \sum_j \lambda_j |\varphi_j\rangle \langle \varphi_j |$, where $\varphi_j \in L^2(\Omega^2)$ and $\lambda_j \ge 0$. Then, we have

= $\sum_j \lambda_j \langle \psi_j, (\rho_{\varepsilon,\lambda}(r_1-r_2)-\delta(x_1-x_2)g(z_1-z_2))\varphi_j \rangle,$

where $\psi_j = (J^{(1)} \otimes 1)\varphi_j$. Then, we decompose

$$\langle \psi_j, (\rho_{\varepsilon,\lambda}(r_1-r_2)-\delta(x_1-x_2)g(z_1-z_2))\varphi_j \rangle = A_j + B_j,$$

where

$$A_j = \langle \psi_j, (\rho_{\varepsilon,1}(r_1 - r_2) - \delta(x_1 - x_2)g(z_1 - z_2))\varphi_j \rangle, B_j = \langle \psi_j, (\rho_{\varepsilon,\lambda}(r_1 - r_2) - \rho_{\varepsilon,1}(r_1 - r_2))\varphi_j \rangle.$$

For A_j , switching to Fourier space in the x-direction, we find

$$\begin{aligned} |A_j| &= \Big| \int \overline{\psi}_j(n_1, n_2; z_1, z_2) \widehat{\varphi}_j(m_1, m_2; z_1, z_2) \rho_{1,\lambda}(x, z_1 - z_2) (e^{i\varepsilon x \cdot (n_1 - m_1)} - 1) \\ &\times \delta(n_1 + n_2 - m_1 - m_2) dx dz_1 dz_2 dn_1 dn_2 dm_1 dm_2 \Big| \\ &\leq \int |\widehat{\psi}_j(n_1, n_2; z_1, z_2)| |\widehat{\varphi}_j(m_1, m_2; z_1, z_2)| \delta(n_1 + n_2 - m_1 - m_2) \\ &\times \Big| \int \rho(x, z_1 - z_2) (e^{i\varepsilon x \cdot (n_1 - m_1)} - 1) dx \Big| dz_1 dz_2 dn_1 dn_2 dm_1 dm_2. \end{aligned}$$

Using the inequality that $\forall \kappa \in (0, 1)$

$$\left| e^{i\varepsilon x \cdot (n_1 - m_1)} - 1 \right| \leq \varepsilon^{\kappa} |x|^{\kappa} |n_1 - m_1|^{\kappa} \leq \varepsilon^{\kappa} |x|^{\kappa} \left(|n_1|^{\kappa} + |m_1|^{\kappa} \right),$$

we get

$$\begin{split} |\langle \psi_j, (\rho_{\varepsilon,1}(r_1 - r_2) - \delta(x_1 - x_2)g(z_1 - z_2))\varphi_j \rangle| \\ \leq & \varepsilon^{\kappa} \sup_{z} \int |\rho(x, z)| |x|^{\kappa} dx \int \delta(n_1 + n_2 - m_1 - m_2) \\ & (|n_1|^{\kappa} + |m_1|^{\kappa}) |\widehat{\psi}_j(n_1, n_2; z_1, z_2)| |\widehat{\varphi}_j(m_1, m_2; z_1, z_2)| dz_1 dz_2 dn_1 dn_2 dm_1 dm_2 \\ = & \varepsilon^{\kappa} \sup_{z} \int |\rho(x, z)| |x|^{\kappa} dx (I + II), \end{split}$$

where

$$I = \int \delta(n_1 + n_2 - m_1 - m_2) |n_1|^{\kappa} |\widehat{\psi}_j(n_1, n_2; z_1, z_2)| |\widehat{\varphi}_j(m_1, m_2; z_1, z_2)| dz_1 dz_2 dn_1 dn_2 dm_1 dm_2,$$

$$II = \int \delta(n_1 + n_2 - m_1 - m_2) |m_1|^{\kappa} |\widehat{\psi}_j(n_1, n_2; z_1, z_2)| |\widehat{\varphi}_j(m_1, m_2; z_1, z_2)| dz_1 dz_2 dn_1 dn_2 dm_1 dm_2.$$

The estimates for I and II are similar, so we only deal with I explicitly.

$$\begin{split} I &\leq \int \delta(n_1 + n_2 - m_1 - m_2) \frac{\langle n_1 \rangle \langle n_2 \rangle}{\langle m_1 \rangle \langle m_2 \rangle} |\hat{\psi}_j(n_1, n_2; z_1, z_2)| \\ &\times \frac{\langle m_1 \rangle \langle m_2 \rangle}{\langle n_1 \rangle^{1-\kappa} \langle n_2 \rangle} |\hat{\varphi}_j(m_1, m_2; z_1, z_2)| dz_1 dz_2 dn_1 dn_2 dm_1 dm_2 \\ &\leq \theta \int \delta(n_1 + n_2 - m_1 - m_2) \frac{\langle n_1 \rangle^2 \langle n_2 \rangle^2}{\langle m_1 \rangle^2 \langle m_2 \rangle^2} |\hat{\psi}_j(n_1, n_2; z_1, z_2)|^2 dz_1 dz_2 dn_1 dn_2 dm_1 dm_2 \\ &\quad + \theta^{-1} \int \delta(n_1 + n_2 - m_1 - m_2) \frac{\langle m_1 \rangle^2 \langle m_2 \rangle^2}{\langle n_1 \rangle^{2(1-\kappa)} \langle n_2 \rangle^2} |\hat{\varphi}_j(m_1, m_2; z_1, z_2)|^2 dz_1 dz_2 dn_1 dn_2 dm_1 dm_2 \\ &\leq \theta \langle \psi_j, (1 - \Delta_{x_1}) (1 - \Delta_{x_2}) \psi_j \rangle \sup_{n} \sum_{m_2} \frac{1}{\langle m_2 - n \rangle^2 \langle m_2 \rangle^2} \\ &\quad + \theta^{-1} \langle \varphi_j, (1 - \Delta_{x_1}) (1 - \Delta_{x_2}) \varphi_j \rangle \sup_{n} \sum_{m_2} \frac{1}{\langle m_2 - n \rangle^{2(1-\kappa)} \langle m_2 \rangle^2}. \end{split}$$

$$\sup_{n} \sum_{m \in \mathbb{Z}^2} \frac{1}{\langle m - n \rangle^{2(1-\kappa)} \langle m \rangle^2} < \infty$$

$$\begin{aligned} (A.25) \\ & \left| TrJ^{(1)}(\rho_{\varepsilon,1}(r_{1}-r_{2})-\delta(x_{1}-x_{2})g(z_{1}-z_{2}))\gamma^{(2)} \right| \\ \leq C\varepsilon^{\kappa}\sup_{z} \int |\rho(x,z)||x|^{\kappa}dx \left(\theta Tr\langle\nabla_{x_{1}}\rangle^{2}\langle\nabla_{x_{2}}\rangle^{2}\gamma^{(2)} + \theta^{-1}TrJ^{(1)}\langle\nabla_{x_{1}}\rangle^{2}\langle\nabla_{x_{2}}\rangle^{2}J^{(1)}\gamma^{(2)} \right) \\ = C\varepsilon^{\kappa}\sup_{z} \int |\rho(x,z)||x|^{\kappa}dx (\theta Tr\langle\nabla_{x_{1}}\rangle^{2}\langle\nabla_{x_{2}}\rangle^{2}\gamma^{(2)} \\ & + \theta^{-1}Tr\langle\nabla_{x_{1}}\rangle^{-1}\langle\nabla_{x_{2}}\rangle^{-1}J^{(1)}\langle\nabla_{x_{1}}\rangle^{2}J^{(1)}\langle\nabla_{x_{1}}\rangle^{-1}\langle\nabla_{x_{1}}\rangle\langle\nabla_{x_{2}}\rangle^{2}\gamma^{(2)}\langle\nabla_{x_{1}}\rangle\langle\nabla_{x_{2}}\rangle) \\ \leq C\varepsilon^{\kappa}\sup_{z} \int |\rho(x,z)||x|^{\kappa}dx \left(\theta + \theta^{-1}\|\langle\nabla_{x_{1}}\rangle^{-1}J^{(1)}\langle\nabla_{x_{1}}\rangle\|_{op}\|\langle\nabla_{x_{1}}\rangle J^{(1)}\langle\nabla_{x_{1}}\rangle^{-1}\|_{op} \right) Tr\langle\nabla_{x_{1}}\rangle^{2}\langle\nabla_{x_{2}}\rangle^{2}\gamma^{(2)} \\ = C\varepsilon^{\kappa}\sup_{z} \int |\rho(x,z)||x|^{\kappa}dx \left(\|\langle\nabla_{x_{1}}\rangle^{-1}J^{(1)}\langle\nabla_{x_{1}}\rangle\|_{op} + \|\langle\nabla_{x_{1}}\rangle J^{(1)}\langle\nabla_{x_{1}}\rangle^{-1}\|_{op} \right) Tr\langle\nabla_{x_{1}}\rangle^{2}\langle\nabla_{x_{2}}\rangle^{2}\gamma^{(2)} , \end{aligned}$$

where we have taken $\theta = \|\langle \nabla_{x_1} \rangle J^{(1)} \langle \nabla_{x_1} \rangle^{-1} \|_{op}$ in the last line. For B_j , we use the operator inequality (also see [31, (A.63)])

$$(A.26) |B_j| \leq \theta \langle \psi_i, |(\rho_{\varepsilon,\lambda} - \rho_{\varepsilon,1})(r_1 - r_2)|\psi_i\rangle + \theta^{-1} \langle \varphi_i, |(\rho_{\varepsilon,\lambda} - \rho_{\varepsilon,1})(r_1 - r_2)|\varphi_i\rangle \\\leq C \|\rho_{\varepsilon,\lambda} - \rho_{\varepsilon,1}\|_{L^1_z L^1_x} \left(\theta \langle \psi_i, (1 - \Delta_{r_1})(1 - \Delta_{r_2})\psi_i\rangle + \theta^{-1} \langle \varphi_i, (1 - \Delta_{r_1})(1 - \Delta_{r_2})\varphi_i\rangle\right) \\= C \|\rho_{1,\lambda} - \rho_{1,1}\|_{L^1_z L^1_x} \left(\theta \langle \psi_i, (1 - \Delta_{r_1})(1 - \Delta_{r_2})\psi_i\rangle + \theta^{-1} \langle \varphi_i, (1 - \Delta_{r_1})(1 - \Delta_{r_2})\varphi_i\rangle\right).$$

Similarly, we have

(A.27)
$$|TrJ^{(1)}(\rho_{\varepsilon,\lambda}(r_1-r_2)-\rho_{\varepsilon,\lambda}(r_1-r_2))\gamma^{(2)}| \le C_J \|\rho_{1,\lambda}-\rho_{1,1}\|_{L^1} Tr\langle \nabla_{r_1}\rangle^2 \langle \nabla_{r_2}\rangle^2 \gamma^{(2)}.$$

Together with estimate (A.25) and (A.27), we complete the proof.

Lemma A.5. Recall

$$S^{2} = 1 - \Delta_{r} - 1/L^{2},$$

 $\widetilde{S}^{2} = 1 - \Delta_{x} - \partial_{z}^{2}/L^{2} - 1/L^{2}.$

We have

(A.28)
$$(1 - \Delta_r) \le 2L^{-2}S^2,$$

(A.20) $(1 - \Delta_r) \ge 2L^{-2}S^2,$

(A.29)
$$(1 - \Delta_r)P_{z,>1} \le 2S^2 P_{z,>1},$$

(A.30)
$$\widetilde{S}^2 \widetilde{P}_1 \ge L^{-2} \widetilde{P}_1,$$

(A.30)
$$\widetilde{S}^2 \widetilde{P}_1 \ge L^{-2} \widetilde{P}_1$$

(A.31)
$$2\widetilde{S}^2 \ge 1 - \Delta_r$$

Proof. For (A.28), we have

$$1 - \Delta_r = S^2 + 1/L^2 \le 2L^{-2}S^2.$$

For (A.29), we note that

$$L^{-2}P_{z,>1} \le (-\partial_z^2 - 1/L^2)P_{z,>1} \le S^2 P_{z,>1}.$$

Thus, we obtain

$$(1 - \Delta_r)P_{z,>1} = (S^2 + 1/L^2)P_{z,>1} \le 2S^2P_{z,>1}$$

For (A.30), we have

$$L^{-2}\widetilde{P}_1 \le (-\partial_z^2/L^2 - 1/L^2)\widetilde{P}_1 \le \widetilde{S}^2\widetilde{P}_1.$$

For (A.31), we note that

Then we have

(A.33)

$$2\widetilde{S}^2 \ge 2(1 - \Delta_x) + 2L^{-2}(-\partial_z^2 - 1)\widetilde{P}_1$$
$$\ge 2(1 - \Delta_x) - L^{-2}\partial_z^2\widetilde{P}_1$$
$$\ge 2(1 - \Delta_x) - \partial_z^2\widetilde{P}_1.$$

Noting that $-\partial_z^2 \widetilde{P}_0 = \widetilde{P}_0$, we obtain

(A.34)
$$1 - \Delta_x \ge 1 - \partial_z^2 \widetilde{P}_0.$$

Putting (A.33) and (A.34) together, we establish (A.31).

We need the following facts as well. The proofs are elementary and we omit them.

Lemma A.6. 1. Suppose that $A \ge 0$, $P_j = P_j^*$, and $I = P_0 + P_1$. Then $A \le 2P_0AP_0 + 2P_1AP_1$. 2. If $A \ge B \ge 0$, and AB = BA, then $A^{\alpha} \ge B^{\alpha}$ for any $\alpha > 0$. Especially, if $\alpha = 2$, then $||A||_{op} \ge ||B||_{op}$. 3. If $A_1 \ge A_2 \ge 0$, $B_1 \ge B_2 \ge 0$ and $A_iB_j = B_jA_i$ for all $1 \le i, j \le 2$, then $A_1B_1 \ge A_2B_2$. 4. If $A \ge 0$ and AB = BA, then $A^{1/2}B = BA^{1/2}$.

Lemma A.7. Suppose $\sigma: L^2(\Omega^k) \mapsto L^2(\Omega^k)$ has kernel

$$\sigma(\mathbf{r}_k, \mathbf{r}'_k) = \int \psi(\mathbf{r}_k, \mathbf{r}_{N-k}) \overline{\psi}(\mathbf{r}'_k, \mathbf{r}_{N-k}) d\mathbf{r}_{N-k},$$

for some $\psi \in L^2(\Omega^k)$, and let $A, B: L^2(\Omega^k) \mapsto L^2(\Omega^k)$. Then the composition $A\sigma B$ has kernel

$$(A\sigma B)(\mathbf{r}_k,\mathbf{r}'_k) = \int (A\psi)(\mathbf{r}_k,\mathbf{r}_{N-k})(\overline{B^*\psi})(\mathbf{r}'_k,\mathbf{r}_{N-k})d\mathbf{r}_{N-k}$$

It follows that

$$TrA\sigma B = \langle A\psi, B^*\psi \rangle.$$

Lemma A.8. Let P_M^j be the orthogonal projection onto the sum of the first M eigenspaces with respect to the spectral decomposition of $L^2(\Omega)$ to the operator $-\Delta_{r_j}$ and

$$P_M^{(k)} = \prod_{j=1}^k P_M^j$$

1. Suppose that $J^{(k)}$ is a compact operator. Then $J_M^{(k)} := P_M^{(k)} J^{(k)} P_M^{(k)}$ converges to $J^{(k)}$ in the operator norm.

2. $\Delta_{r_j} J_M^{(k)}$ and $J_M^{(k)} \Delta_{r_j}$ are bounded operators.

3. There exists a countable dense subset $\{T_i\}$ of the closed unit ball in the space of bounded operators on $L^2(\Omega^k)$ such that T_i is compact and in fact for each i there exists M (depending on i) such that $T_i = P_M^{(k)} T_i P_M^{(k)}$.
