# Rayleigh-Taylor instability for nonhomogeneous incompressible fluids with Navier-slip boundary conditions

#### Abstract

This paper is concerned with the Rayleigh-Taylor instability for the nonhomogeneous incompressible Navier-Stokes equations with Navier-slip boundary conditions around a steady-state in an infinite slab, where the Navier-slip coefficients do not have defined sign and the slab is horizontally periodic. Motivated by [18], we extend the result from Dirichlet boundary condition to Navier-slip boundary conditions. Our results indicate the factor that "heavier density with increasing height" still plays a key role in the instability under Navier-slip boundary conditions.


Keywords: Navier-Stokes equations, incompressible flows, Rayleigh-Taylor instability, Navierslip boundary conditions.

## 1 Introduction

In this paper, we focus on the instability of the following nonhomogeneous incompressible Navier-Stokes equations with gravity in an infinite slab domain $\Omega=2 \pi L \mathbb{T} \times(0,1)$ :

\operatorname{div\mathbf {v}}=0 .
\end{array}\right.

where the unknowns ( $\rho, \mathbf{v}, p$ ) denote density, velocity, and pressure of the fluid, respectively. The constant $\mu>0$ stands for the coefficient of shear viscosity, $\mathbf{e}_{2}=(0,1)$ is the vertical unit vector, and $-g \mathbf{e}_{2}$ describes the gravity.

The Navier-slip boundary conditions being considered is given as follows:

[^0]where $\mathbb{D}(\mathbf{v})=\frac{1}{2}\left(\nabla \mathbf{v}+\nabla^{T} \mathbf{v}\right), \mathbf{n}$ is the outward normal vector of the boundary and $\tau$ is the tangential vector, $\Sigma_{1}$ and $\Sigma_{0}$ are the upper and lower boundary, respectively, i.e. $\Sigma_{1}=2 \pi L \mathbb{T} \times$ $\{1\}, \Sigma_{0}=2 \pi L \mathbb{T} \times\{0\}$, where $2 \pi L \mathbb{T}$ stands for the 1D-torus of length $2 \pi L$. In addition, $k(\mathrm{x})$ is a scalar function describing the slip effect on the boundary. In this paper, $k(\mathrm{x})$ will be taken to be constant $k_{0}$ and $k_{1}$ on $\Sigma_{0}$ and $\Sigma_{1}$, respectively, which do not have defined sign.

We first look for a smooth steady-state $(\bar{\rho}, 0, \bar{p})$ to the system (1.1), where the density profile $\bar{\rho}:=\bar{\rho}(y)$ satisfies:

and the pressure $\bar{p}$ is determined by the following equality:

Since we are interested in Rayleigh-Taylor(RT) instability, we assume that the steady density satisfies

This condition means that there is a neighborhood of $y_{0}$, such that $\bar{\rho}$ increases with $y$, i.e., a heavy fluid is on top of the light one.

Now, we define the perturbation as

Then, $(\varrho, \mathbf{u}, q)$ satisfies the following equations

with the corresponding initial data and boundary conditions turning to

Linearizing system (1.6), one gets

\operatorname{div} \mathbf{u}=0

To analyze our problem, we would like to apply the growing normal mode method, for which the readers can refer to [7], for instance.

Precisely, we first assume a growing mode ansatz of solutions

to the linearized system (1.8) with some constant $\lambda>0$. Substituting these ansatz into (1.8) deduces a system for the new unknowns ( $\tilde{\rho}, \tilde{\mathbf{v}}, \tilde{p})$ as follows

Eliminating $\tilde{\rho}$ in (1.9), one arrives at

which is endowed with the following initial data and boundary conditions:

Second, for any frequency $\xi \in \mathbb{R}, \xi \neq 0$, we rewrite the unknowns in (1.10)-11) in terms of $(\phi, \psi, \pi)(y):(0,1) \rightarrow \mathbb{R}$ with

from which we can infer that the new unknowns $(\phi, \psi, \pi)$ satisfy the following ODEs

with the corresponding boundary conditions

Third, eliminating $\pi$ in (1.12), one yields a fourth-order ODE of $\psi(y)$ :

In conclusion, the problem (1.7)-(1.8) is finally reduced to the fourth-order ODE system (1.14)-1.15).

The main results of this paper are stated as follows:
Theorem 1.1. (Linear instability) The steady-state $(\bar{\rho}, 0, \bar{p})$ is linearly unstable, provied that the steady density profile $\bar{\rho}$ satisfies (1.3) and (1.5). Precisely, there exists exponentially growing solution to the linearized perturbed problem (1.7)-(1.8), such that $\|(\varrho, \mathbf{u}, q)(t)\|_{H^{k}(\Omega)} \rightarrow \infty$, as $t \rightarrow \infty$.

Theorem 1.2. (Nonlinear instability) The steady state solution $(\bar{\rho}, 0, \bar{p})$ is nonlinearly unstable in the Hardama sense, provided that the steady density profile $\bar{\rho}$ satisfies (1.3) and (1.5). Precisely, there exist positive constants $\Lambda, \varepsilon, m_{0}$, and a pair $\left(\bar{\varrho}_{0}, \overline{\mathbf{u}}_{0}\right) \in L^{2}(\Omega) \times H^{2}(\Omega)$, such that for any $\delta \in(0, \varepsilon)$, there is an unique global strong solution $(\varrho, \mathbf{u})$ to the nonlinear perturbed problem (1.6)-1.7) on $[0, T)$ with the initial data $\left(\varrho_{0}, \mathbf{u}_{0}\right):=\left(\delta \bar{\varrho}_{0}, \delta \overline{\mathbf{u}}_{0}\right)$, but

for some escape time $T^{\delta}:=\frac{1}{\Lambda} \ln \frac{2 \varepsilon}{m_{0} \delta} \in(0, T)$.
Before proving these theorems, let us recall some results on the RT instability problems. The RT instability is a kind of well-known instability in fluid dynamics, which is driven by the gravity when the upper fluid is heavier than the lower one. In 1883, Rayleigh [28] first considered the linear instability for an incompressible fluid. 120 years later, in 2003, Hwang and Guo [15] studied 2D nonhomogeneous incompressible inviscid fluid in strip domain with zero normal velocity on the boundary, and proved the RT instability in the Hardama sense. However, when the viscosity is taken into account, there is no direct variational structure for constructing exponentially growing solution. In 2011, Guo and Tice [13] introduced a general method for these problem, they turned to study the modified variational problem first and then went back to the original problem by fixed-point theory. Motivated by [13], F. Jiang, S. Jiang and G. Ni [18] in 2013 studied the RT instability of nonhomogeneous incompressible viscous fluid at the present of the uniform gravity field in $\mathbb{R}^{3}$. Whereafter, F. Jiang and S. Jiang made a breakthrough in three-dimensional bounded domain case [17] and analyzed both the instability and stability for given different steady density profile $\bar{\rho}$.

When fluids are electrically conducting at the present of magnetic field, the RT instability arises and the growth of the instability will be influenced by the magnetic field due to the Lorentz force. Thus, there are also some authors pay considerable attention to the inhibition of the magnetic field on the RT instability. In 1954, Kruskal and Schwarzchild first proved that a horizontal magnetic field has no effect on the development of the linear RT instability [22]. Afterwards, Hide in [14] investigated the influence of a vertical magnetic field. To our knowledge, there is
some critical magnetic number $B_{c}$, such that when the vertical background magnetic field is less than the critical magnetic number, then the magnetic field has no effect on the RT instability [20], while the vertical background magnetic field is larger than the critical magnetic number, then the magnetic field has an inhibitory on the RT instability [33]. Therefore, this physical phenomenon has been verified mathematically in some cases.

In 2018, Ding, Li and Xin [7] found that there exists a critical viscosity coefficient for distinguishing stability from instability when considering the homogeneous fluid with Navierslip boundary conditions in 2D strip domain.

As for the Navier-slip boundary conditions, which was first proposed by C. Navier [26] in 1827, it describes the phenomenon that fluid moves along the boundary. Mathematically, it can be depicted as in (1.2). Compared to the classical Dirichlet boundary condition, Navier-slip boundary conditions are more realistic in some situations, but the mathematical literature is less. Early in 1973, V. Solonnikov and V. Ščailov [30] gave the first rigorous mathematical analysis to Navier-Stokes equations with Navier-slip boundary conditions, they focused on linear stationary equations in 3D with the coefficient $k(x)=0$ and the external force $\mathbf{f} \in L^{2}$. In 1980s, G. Mulone and F. Salemi [24, 25] considered the Navier-Stokes equations with Navier-slip boundary conditions in a three dimensional bounded domain. They proved the well-posedness for the corresponding stationary problem, and the existence of weak solution for the evolutionary problem. Afterwards, J.Kelliher [21] established the existence, uniqueness and regularity for 2D bounded domain case in 2006, where the domain is consisted of a finite number of connected components with the slip coefficient $k(\mathrm{x}) \in L^{\infty}(\partial \Omega)$. Based on the above results of weak solution, in 2010, H. B. da Veiga [32] improved the regularity of the weak solutions, up to the boundary. Later, C. Amrouche and co-authors studied stationary and evolutionary problems [1-3] in $L^{p}$ with $p \in(1, \infty)$, proving the existence of weak and strong solutions in a three-dimensional bounded domain with smooth boundary. It should be noted that, the noncompact infinite slab case is not included in any result mentioned above. In 2018, Ding and Li proved the existence and uniqueness of strong solution of incompressible fluid with Navier boundary conditions in 2D infinite slab [23]. For the references on the vanishing viscosity limit of Navier-Stokes equation with Navier boundary conditions, we refer the readers to [5, 34, 35] and the reference therein. The main aim of this paper is to investigate the slip effect from the boundary on the RT instability.

The rest of the paper is arranged as follows. In Section 2, we give some notations and list some useful inequalities. In Section 3 and Section 5, we will give the proofs of Theorem1.1 and Theorem 1.2, respectively. In Section 4, we deduce the energy estimates, which is a preparation for proving the nonlinear instability in Section 5.

## 2 Preliminary

For simplicity, we denote $L^{2}(0,1)$ and $H^{k}(0,1)$ by $L^{2}$ and $H^{k}$. Without confusion, we will also write $L^{p}(\Omega)$ and $H^{k}(\Omega)$ by $L^{p}$ and $H^{k}$, respectively. The integral form $\int_{\Omega} f d x d y$ will be simply denoted by $\int f$. In addition, the scalar function and vector function will be denoted by $f$ and $\mathbf{f}$ for distinction, such as $\mathbf{f}=\left(f_{1}, f_{2}\right)$. The product functional space $(X)^{2}$ will also be denoted by $X$, for example, the vector function $\mathbf{u} \in\left(H^{1}\right)^{2}$ will be still denoted by $\mathbf{u} \in H^{1}$. The usual notations will be used as in general unless with extra statements.

For convenience, we list a few lemmas that will be used in this paper, without the proofs. The readers interested in the proof could refer to [23] for the details.

Lemma 2.1. (Poincaré inequality in $\Omega$ ) There exists constant $C>0$, such that for any $\mathbf{u} \in V=$ $\left\{\mathbf{v} \in H^{1} \mid \nabla \cdot \mathbf{v}=0, \mathbf{v} \cdot \mathbf{n}=0\right.$ on $\left.\partial \Omega\right\}$, the following inequality holds:

Lemma 2.2. ( $L^{4}$ estimate in $\Omega$ ) There exists constant $C>0$, such that for any $\mathbf{u} \in W=\{\mathbf{v} \in$ $V \cap H^{2} \mid \mathbf{v}$ satisfies $\left.(1.2)_{2}\right\}$, there holds

Lemma 2.3. ( $L^{\infty}$ estimate in $\Omega$ ) There exists constant $C>0$, such that for any $\mathbf{u} \in W$, one has

Proof. Using estimate (2.3), the proof of (2.5) is similar to that of (2.4).

## 3 The proof of Theorem 1.1

In this section, we will make effort to construct a solution for $1.14-1.15$ by variational method, which at once deduces a solution for ODE system (1.12)-(1.13). Then, an exponentially growing solution will be given for linearized perturbed equation 1.8 -1.7), and Theorem 1.1 follows.

However, similar to [13], the appearance of $\lambda$ both quadratically and linearly in equation (1.14) breaks the natural variational structure of problem (1.14)-1.15). To circumvent this obstacle, for any spatial frequency $\xi(\neq 0)$, we introduce a family $(s>0)$ of modified variational problem

and the corresponding admissible set

In addition, to emphasize the dependence on $\xi$, we sometimes write (3.1) as

In order to recover the corresponding variational form of problem (1.14)-1.15), we will show later in this section that there exists a fixed point $s_{0}>0$, so that $\alpha\left(s_{0}\right)=-s_{0}^{2}$. The first proposition is devoted to proving the well-definedness of (3.1).

Proposition 3.1. Suppose that the steady density satisfies (1.3). Then, for any $\xi \neq 0$ and $s \in$ $(0,+\infty), E(\psi, s)$ achieves its minimum on $\mathcal{A}$.

Proof. For any $\psi \in \mathcal{A}$, since $J(\psi)=1$, by Cauchy inequality, one has

& \geq-g\left\|\frac{\bar{\rho}^{\prime}}{\bar{\rho}}\right\|_{L^{\infty}}-s C_{0} \int_{0}^{1}\left|\psi^{\prime}\right|^{2} d y \geq-g\left\|\frac{\bar{\rho}^{\prime}}{\bar{\rho}}\right\|_{L^{\infty}}-s C_{0}\left\|\frac{1}{\bar{\rho}}\right\|_{L^{\infty}}, \tag{3.4}
\end{align*}
$$

where $C_{0}:=\max _{0 \leq y \leq 1}\left[\left|k_{0}+k_{1}\right|+\mu^{-1}\left(\left(k_{0}+k_{1}\right) y-k_{0}\right)^{2}\right]$.
Since $\bar{\rho}$ has a positive lower bound, it follows from (3.4) that $E(\psi)$ is bounded below on $\mathcal{A}$, and so it has an infimum. Denote that

M:=\inf _{\psi \in \mathcal{A}} E(\psi)
$$

In view of the definition of infimum, there exists a minimizing sequence $\left\{\psi_{n}\right\}_{n=1}^{\infty} \in \mathcal{A}$, such that

Without loss of generality, we suppose that

which imply that $\left\{\psi_{n}\right\}_{n=1}^{\infty}$ is a bounded sequence in $H_{0}^{1}$.

On the other hand, similar to (3.4), it follows from the definition of $E(\psi)$ that

& \leq \frac{M+1+g\left\|\overline{\bar{\rho}}^{\prime}\right\|_{\bar{\rho}} L_{L^{\infty}}}{s}+2 C_{0} \int_{0}^{1}\left|\psi_{n}^{\prime}\right|^{2} d y+\frac{\mu}{2} \int_{0}^{1}\left|\psi_{n}^{\prime \prime}\right|^{2} d y \tag{3.7}
\end{align*}
$$

which, together with (3.6), indicate that

\int_{0}^{1}\left|\psi_{n}^{\prime \prime}\right|^{2} d y \leq 2 \mu^{-1}\left[s^{-1}\left(M+1+g\left\|\frac{\bar{\rho}^{\prime}}{\bar{\rho}}\right\|_{L^{\infty}}\right)+2 C_{0}\left\|\frac{1}{\bar{\rho}}\right\|_{L^{\infty}}\right] \tag{3.8}
\end{equation*}

In conclusion, for any fixed $s \in(0, \infty),\left\{\psi_{n}\right\}_{n=1}^{\infty}$ is a bounded sequence in $H_{0}^{1} \cap H^{2}$, and hence, there exists a convergent subsequence, still denoted by $\left\{\psi_{n}\right\}_{n=1}^{\infty}$, such that $\psi_{n} \rightharpoonup \psi$ weakly in $H^{2}$ and $\psi_{n} \rightarrow \psi$ strongly in $H_{0}^{1}$. Then $J(\psi)=\lim _{n \rightarrow+\infty} J\left(\psi_{n}\right)=1$, which implies $\psi \in \mathcal{A}$.

In addition, using the weak lower semi-continuity and the convergence of $\left\{\psi_{n}\right\}_{n=1}^{\infty}$, one gets

& +\xi^{2} \int_{0}^{1}\left(\xi^{2} s \mu-g \bar{\rho}^{\prime}\right) \psi^{2} d y-s \int_{0}^{1}\left(\left(k_{1}+k_{0}\right) y-k_{0}\right) \psi^{\prime} \psi^{\prime \prime} d y \\
\leq & \liminf _{n \rightarrow+\infty} E\left(\psi_{n}\right)=\lim _{n^{\prime} \rightarrow \infty} E\left(\psi_{n^{\prime}}\right)=M \tag{3.9}
\end{align*}
$$

which means that $\psi$ is the minimizer of $E(\cdot)$ on $\mathcal{A}$. The proof of this proposition is finished.
In what follows, we will prove that $\alpha(s)$ is negative for any $s \in(0, \mathfrak{S})$, where $\mathfrak{S}$ will be defined in Proposition 3.4 For convenience, we denote

E_{2}(\psi)=\int_{0}^{1} g \xi^{2} \bar{\rho}^{\prime} \psi^{2} d y
\end{array}\right.

Then, (3.2) can be rewritten as $E(\psi)=s G(\psi)-E_{2}(\psi)$.
Similar to [7], firstly, we define the critical viscosity:

It is clear that $E_{0}(\psi) \geq 0$ for any $\psi \in \mathcal{A}$, provided $\mu \geq \mu_{c}$. Conversely, there exists $\psi \in \mathcal{A}$ such that $E_{0}(\psi)<0$, if $\mu<\mu_{c}$.

Further, according to [7], if $\mu<\mu_{c}$, there exists a critical frequency defined by

0<\xi_{c}^{2}:=\sup _{\psi \in \mathcal{A}} \frac{k_{1}\left|\psi^{\prime}(1)\right|^{2}+k_{0}\left|\psi^{\prime}(0)\right|^{2}-\int_{0}^{1} \mu\left|\psi^{\prime \prime}\right|^{2} d y}{\mu \int_{0}^{1}\left(2\left|\psi^{\prime}\right|^{2}+\xi_{c}^{2} \psi^{2}\right) d y}=\sup _{\psi \in \mathcal{A}} \frac{-E_{0}(\psi)}{E_{1}\left(\psi, \xi_{c}\right)} .

And, under the assumption of $\mu<\mu_{c}$, one can point out from the definition of $\xi_{c}$ that

0<\xi_{c}^{2} \leq \frac{k_{1}\left|\psi^{\prime}(1)\right|^{2}+k_{0}\left|\psi^{\prime}(0)\right|^{2}-\int_{0}^{1} \mu\left|\psi^{\prime \prime}\right|^{2} d y}{\mu \int_{0}^{1} 2\left|\psi^{\prime}\right|^{2} d y} \leq \frac{C_{0} \int_{0}^{1}\left|\psi^{\prime}\right|^{2} d y}{2 \mu \int_{0}^{1}\left|\psi^{\prime}\right|^{2} d y}=\frac{C_{0}}{2 \mu},
$$

which indicates that $0<\left|\xi_{c}\right| \leq \sqrt{\frac{C_{0}}{2 \mu}}$. Here, $C_{0}$ is the same number defined as in (3.4). In conclusion, for any $\mu>0$, the functional $G(\psi)$ is positive on $\mathcal{A}$, provided $|\xi|>\xi_{c}$.

Now, we define the solvable domain for frequency

\mathbb{A}^{g}:=\left\{\xi \in \mathbb{R} \| \xi \mid \in(a, b):=\left(\left|\xi_{c}\right|, b\right) \subset(0,+\infty)\right\},

where $0<a \ll b<+\infty$. Next, we will show that for any $\xi \in \mathbb{A}^{g}$, there exists a fixed point $s_{0}>0$ such that $\alpha\left(s_{0}\right)=-s_{0}^{2}$. To this end, several propositions will be devoted to study some properties of $\alpha(s)$ in what follows.

Proposition 3.2. For any $\xi \in \mathbb{A}^{g}$ and $s \in(0,+\infty)$, there exist positive numbers $C_{1}, C_{2}$, depending on $\mu, a, b, \bar{\rho}, g, k_{0}, k_{1}$, such that $\alpha(s) \leq s C_{2}-C_{1}$.

Proof. In view of (1.5), there is a point $y_{0} \in(0,1)$, such that $\bar{\rho}^{\prime}\left(y_{0}\right)>0$. Thus, there exists an open neighbourhood of $y_{0}$

B_{y_{0}}^{\delta}:=\left\{y \in(0,1)| | y-y_{0} \mid<\delta\right\} \subset(0,1)
$$

with $\delta$ small sufficiently, such that $\bar{\rho}^{\prime}(y)>\bar{\rho}^{\prime}\left(y_{0}\right) / 2$ in $B_{y_{0}}^{\delta}$. Now, define

where $f(r) \in C_{0}^{\infty}(\mathbb{R})$ is a cut-off function satisfying $f(r)=1$ for $|r|<\delta / 2$ and $f(r)=0$ for $|r| \geq 3 \delta / 4$. Then, $\tilde{\psi}(y) \in H_{0}^{1} \cap H^{2}$ and $E_{2}(\tilde{\psi})=\int_{0}^{1} g \xi^{2} \bar{\rho}^{\prime} \tilde{\psi}^{2} d y>g \xi^{2} \bar{\rho}^{\prime}\left(y_{0}\right) \delta / 4>0$.

So, for any $\xi \in \mathbb{A}^{g}$, there holds that

\frac{E_{2}(\tilde{\psi})}{J(\tilde{\psi})}=\frac{g \xi^{2} \int_{0}^{1} \bar{\rho}^{\prime} \tilde{\psi}^{2} d y}{\int_{0}^{1} \bar{\rho}\left(\xi^{2} \tilde{\psi}^{2}+\left|\tilde{\psi}^{\prime}\right|^{2}\right) d y} \geq \frac{g a^{2} \int_{0}^{1} \bar{\rho}^{\prime} \tilde{\psi}^{2} d y}{\int_{0}^{1} \bar{\rho}\left(b^{2} \tilde{\psi}^{2}+\left|\tilde{\psi}^{\prime}\right|^{2}\right) d y}:=C_{1} \tag{3.10}
\end{equation*}
$$

and that

\frac{G(\tilde{\psi})}{J(\tilde{\psi})}=\frac{\mu \int_{0}^{1}\left(\left|\tilde{\psi}^{\prime \prime}\right|^{2}+2 \xi^{2}\left|\tilde{\psi}^{\prime}\right|^{2}+\xi^{4} \tilde{\psi}^{2}\right) d y-\left(k_{1}\left|\tilde{\psi}^{\prime}(1)\right|^{2}+k_{0}\left|\tilde{\psi}^{\prime}(0)\right|^{2}\right)}{\int_{0}^{1} \bar{\rho}\left(\xi^{2} \tilde{\psi}^{2}+\left|\tilde{\psi}^{\prime}\right|^{2}\right) d y}
$$

$$
\begin{equation*}
\leq \frac{\mu \int_{0}^{1}\left(2 b^{2}\left|\tilde{\psi}^{\prime}\right|^{2}+b^{4} \tilde{\psi}^{2}\right) d y+C_{0}\left\|\frac{1}{\bar{\rho}}\right\|_{L^{\infty}(0,1)}}{\int_{0}^{1} \bar{\rho}\left(a^{2} \tilde{\psi}^{2}+\left|\tilde{\psi}^{\prime}\right|^{2}\right) d y}:=C_{2}, \tag{3.11}
\end{equation*}
$$

where $C_{1}$ and $C_{2}$ are positive constants depending on $a, b, \bar{\rho}, \mu, k_{0}, k_{1}$.
In conclusion, recalling that

\end{equation*}
$$

for any $\xi \in \mathbb{A}^{g}$.

Proposition 3.3. For any $\xi \in \mathbb{A}^{g}, \alpha(s)$ is a locally Lipschitz continuous function on $(0, \infty)$, that is, $\alpha(s) \in C_{\text {loc }}^{0,1}(0, \infty)$.

Proof. For any $[c, d] \subset(0, \infty)$ and $s \in[c, d]$, in view of Proposition 3.1, there exists a minimizer $\psi_{s} \in \mathcal{A}$, such that $\alpha(s)=E\left(\psi_{s}, s\right)$. Then, by the definition of $G\left(\psi_{s}, s\right)$, one has

where $K$ is a positive number depending on $c, d, \mu, \bar{\rho}, g, k_{0}, k_{1}$.
Similarly, for any $s_{1}, s_{2} \in[c, d]$, there exist $\psi_{s_{1}}, \psi_{s_{2}} \in \mathcal{A}$, such that $\alpha\left(s_{1}\right)=E\left(\psi_{s_{1}}, s_{1}\right)$ and $\alpha\left(s_{2}\right)=E\left(\psi_{s_{2}}, s_{2}\right)$. Furthermore, note that

& \alpha\left(s_{1}\right)=E\left(\psi_{s_{1}}, s_{1}\right) \leq E\left(\psi_{s_{2}}, s_{1}\right)=E\left(\psi_{s_{2}}, s_{2}\right)+\left(s_{1}-s_{2}\right) G\left(\psi_{s_{2}}\right) \leq \alpha\left(s_{2}\right)+K\left|s_{1}-s_{2}\right|, \\
& \alpha\left(s_{2}\right)=E\left(\psi_{s_{2}}, s_{2}\right) \leq E\left(\psi_{s_{1}}, s_{2}\right)=E\left(\psi_{s_{1}}, s_{1}\right)+\left(s_{2}-s_{1}\right) G\left(\psi_{s_{1}}\right) \leq \alpha\left(s_{1}\right)+K\left|s_{1}-s_{2}\right| .

Proposition 3.4. For any $\xi \in \mathbb{A}^{g}$, denote $\mathfrak{S}:=\inf \{\tau \mid \alpha(\tau)>0\}$. Then $\alpha(s)<0$ holds for any $s \in(0, \mathfrak{S})$.

Next, we will prove the well-definedness of $-\lambda^{2}=\alpha(\lambda)$ with $\lambda \in(0, \mathfrak{S})$ by intermediary theorem.

Proposition 3.5. For any $\xi \in \mathbb{A}^{g}$, there exists $\lambda \in(0, \mathfrak{S})$, such that

On one hand, by proposition 3.2 one has

By virtue of the continuity and monotonicity of $\alpha(s)$, together with the fact that $\alpha(s)<0$ on $(0, \mathfrak{S})$, we infer that $\Phi(s)$ is continuous and monotonically increasing on $(0, \mathfrak{S})$, and hence it follows from intermediary theorem that there exists an unique fixed-point $s_{0} \in(0, \mathfrak{S})$, such that $\Phi\left(s_{0}\right)=1$, in other words, $-s_{0}^{2}=\alpha\left(s_{0}\right)$. Taking $\lambda=s_{0}$, and we get $-\lambda^{2}=\alpha(\lambda)$. This proposition follows.

It should be noted that the variational problem (3.17) achieves its minimizer on $\mathcal{A}$ according to proposition 3.1. Now we are on the position to show that the minimizer of problem 3.17) is also a solution to a boundary value problem equivalent to problem (1.14)-(1.15), where $\lambda>0$.

Proposition 3.6. If $\psi \in \mathcal{A}$ is a minimizer of problem (3.17) and denote $-\lambda^{2}:=E(\psi, \lambda)$, then $\psi$ is a solution to boundary value problem (1.14)-(1.15).

Proof. For any $t, r \in \mathbb{R}$ and $\psi_{0} \in H_{0}^{1} \cap H^{2}$, define $j(t, r):=J\left(\psi+t \psi_{0}+r \psi\right)$. Then, $j(t, r)$ is a smooth function of $(t, r)$ with $j(0,0)=1$. Note that

\partial_{t} j(0,0)=2 \int_{0}^{1} \bar{\rho}\left(\xi^{2} \psi \psi_{0}+\psi^{\prime} \psi_{0}^{\prime}\right) d y, \quad \partial_{r} j(0,0)=2 \int_{0}^{1} \bar{\rho}\left(\xi^{2} \psi^{2}+\left|\psi^{\prime}\right|^{2}\right) d y=2 \neq 0
$$

By implicit function theorem, there exists a smooth function $r=r(t)$ near $t=0$ satisfying $r(0)=0$ and $j(t, r(t))=1$.

Since $\psi$ is the minimizer of $E(\cdot)$ on $\mathcal{A}$, one deduces that the single-variable smooth function $e(t)=E\left(\psi+t \psi_{0}+r(t) \psi\right)$ reaches its minimum at $t=0$, which, by Fermat's Lemma, implies that $e^{\prime}(0)=0$, that is

-\lambda^{2} \int_{0}^{1} \bar{\rho}\left(\xi^{2} \psi \psi_{0}+\psi^{\prime} \psi_{0}^{\prime}\right) d y=\lambda & {\left[\int_{0}^{1} \mu \psi^{\prime \prime} \psi_{0}^{\prime \prime} d y-\left(k_{1} \psi^{\prime}(1) \psi_{0}^{\prime}(1)+k_{0} \psi^{\prime}(0) \psi_{0}^{\prime}(0)\right)\right] } \\
& +\lambda \mu \int_{0}^{1}\left(2 \xi^{2} \psi^{\prime} \psi_{0}^{\prime}+\xi^{4} \psi \psi_{0}\right) d y-\int_{0}^{1} g \xi^{2} \bar{\rho}^{\prime} \psi \psi_{0} d y \tag{3.25}
\end{align*}
$$

Taking $\psi_{0} \in C_{0}^{\infty}(0,1)$ in (3.25) infers that the minimizer $\psi$ satisfies (1.14) in the weak sense. Then, by standard bootstrap arguments, one can deduce that $\psi$ is smooth.

Now, it remains to show that the minimizer $\psi$ satisfies boundary conditions 1.15). In fact, since $\psi \in \mathcal{A}$, it is clear that $\psi(0)=\psi(1)=0$. Moreover, since $\psi_{0} \in H_{0}^{1} \cap H^{2}$, in view of (1.14), applying integration by parts to 3.25 , one obtains that

As $\psi_{0}$ being arbitrary, we deduce that

which implies that $\psi$ satisfies boundary conditions (1.15).

In conclusion, $\psi$ is the solution to (1.14) with boundary condition (1.15).
So far, we have proved that there exists smooth solution $\psi(y)$ with the corresponding eigenvalue $\lambda>0$ for problem (1.14)-(1.15). To ensure the validity of Fourier synthesis in constructing exponential growing mode solution to $(1.8)-(1.7)$, we still need some properties of function $\lambda(\xi)$.

Proposition 3.7. The eigenvalue function $\lambda(\xi): \mathbb{A}^{g} \rightarrow(0, \infty)$ defined by (3.17) is continuous and bounded.

Proof. Since the definition of $-\lambda^{2}=\inf _{\psi \in \mathcal{A}} E(\psi, \lambda)$ is equivalent to $\lambda^{2}=\sup _{\psi \in \mathcal{A}}(-E(\psi, \lambda))$, it follows from (3.4) that

\lambda^{2} \leq-E(\psi)+1 \leq g\left\|\frac{\bar{\rho}^{\prime}}{\bar{\rho}}\right\|_{L^{\infty}}+\lambda C_{0}\left\|\frac{1}{\bar{\rho}}\right\|_{L^{\infty}}+1,

which indicates the boundedness of $\lambda(\xi)$ on $\mathbb{A}^{g}$.
We now turn to the proof of the continuity, which is similar to Proposition 2.5 in [18]. For the reader's convenience, we give the details here to make it more clear. For any fixed $\xi_{0} \in \mathbb{A}^{g}$, let $\xi \in \mathbb{A}^{g}$ with $\kappa=|\xi|^{2}-\left|\xi_{0}\right|^{2}$, then $|\xi| \rightarrow\left|\xi_{0}\right|$ as $\kappa \rightarrow 0$. The first step is to show that

In view of Proposition 3.1 for any $\xi \in \mathbb{A}^{g}$, there exists $\psi_{\xi} \in \mathcal{A}$, such that

\alpha(\xi, s)=\int_{0}^{1} s \mu\left(\left|\psi_{\xi}^{\prime \prime}\right|^{2}+2 \xi^{2}\left|\psi_{\xi}^{\prime}\right|^{2}+\xi^{4} \psi_{\xi}^{2}\right)-s \sum_{i=0}^{1} k_{i}\left|\psi_{\xi}^{\prime}(i)\right|^{2}-\int_{0}^{1} g \xi^{2} \bar{\rho}^{\prime} \psi_{\xi}^{2} . \tag{3.28}
\end{equation*}
$$

Substituting $|\xi|^{2}=\left|\xi_{0}\right|^{2}+\kappa$ into (3.28), we get

\alpha(\xi, s)= & \int_{0}^{1} s \mu\left(\left|\psi_{\xi}^{\prime \prime}\right|^{2}+2 \xi_{0}^{2}\left|\psi_{\xi}^{\prime}\right|^{2}+\xi_{0}^{4} \psi_{\xi}^{2}\right)-s \sum_{i=0}^{1} k_{i}\left|\psi_{\xi}^{\prime}(i)\right|^{2}-\int_{0}^{1} g \xi_{0}^{2} \bar{\rho}^{\prime} \psi_{\xi}^{2} \\
& +\kappa \int_{0}^{1}\left[s \mu\left(2\left|\psi_{\xi}^{\prime}\right|^{2}+2 \xi_{0}^{2}\left|\psi_{\xi}^{\prime}\right|^{2}+\kappa \psi_{\xi}^{2}\right)-g \bar{\rho}^{\prime} \psi_{\xi}^{2}\right] \\
\geq & \alpha\left(\xi_{0}, s\right)+\kappa f\left(\kappa, \psi_{\xi}\right), \tag{3.29}
\end{align*}
$$

where

$$
f\left(\kappa, \psi_{\xi}\right):=\int_{0}^{1}\left[s \mu\left(2\left|\psi_{\xi}^{\prime}\right|^{2}+2 \xi_{0}^{2}\left|\psi_{\xi}^{\prime}\right|^{2}+\kappa \psi_{\xi}^{2}\right)-g \bar{\rho}^{\prime} \psi_{\xi}^{2}\right] .
$$

Since $\psi \in \mathcal{A}$, there exists constant $\tilde{c}$, depending on $\bar{\rho}, g, a, b$ and s, such that $\left|f\left(\kappa, \psi_{\xi}\right)\right| \leq \tilde{c}$.
Similarly, we also have

\alpha\left(\xi_{0}, s\right) \geq \alpha(\xi, s)-\kappa f\left(-\kappa, \psi_{\xi_{0}}\right), \tag{3.30}
\end{equation*}
$$

and there exists a constant $\bar{c}$ depending on $\bar{\rho}, g, a, b$ and s , such that

\left|f\left(-\kappa, \psi_{\xi_{0}}\right)\right| \leq \bar{c} .
$$

Thus

\kappa f\left(\kappa, \psi_{\xi}\right) \leq \alpha(\xi, s)-\alpha\left(\xi_{0}, s\right) \leq \kappa f\left(-\kappa, \psi_{\xi_{0}}\right) \tag{3.31}
\end{equation*}

The boundedness of $f\left(\kappa, \psi_{\xi}\right)$ and $f\left(-\kappa, \psi_{\xi_{0}}\right)$ implies that, as $\kappa \rightarrow 0$, one has

Now, denote $\lambda(\xi, s)=\sqrt{-\alpha(\xi, s)}$, then it follows from (3.32) that

In the second step, by virtue of proposition 3.5, for any $\xi \in \mathbb{A}^{g}$, there exists a unique $s_{\xi} \in$ $(0, \mathfrak{S})$, such that

Then, the main aim of this proposition is to prove

\end{equation*}

In view of (3.33), for any $\varepsilon>0$, there exists a constant $\delta>0$, as $\left||\xi|-\left|\xi_{0}\right|\right|<\delta$, so that

Moreover, since that for any $\xi \in \mathbb{A}^{g}, \alpha(\xi, s)$ is monotonically increasing on $s \in(0, \mathfrak{S})$, refer to (3.18), one also has that $\lambda(\xi, s)$ is decreasing with respect to $s \in(0, \mathfrak{S})$.

Now, using (3.34), (3.36) and the monotonicity of $\lambda$ with respect to $s$, we are able to prove (3.35). If $s_{\xi} \leq s_{\xi_{0}}$, then

On the contrary, if $s_{\xi} \geq s_{\xi_{0}}$, then

$$

In conclusion, (3.35) follows from the above two inequality and the proof of this proposition is completed.

Now, we are able to construct solutions $(\phi, \psi, \pi)$ to ODE system (1.12)-(1.13).
Proposition 3.8. For any $\xi \in \mathbb{A}^{g}$, there exist solutions $(\phi, \psi, \pi)(\xi, y)$ to system (1.12)-(1.13) with the corresponding eigenvalue $\lambda(\xi)>0$. Furthermore, $(\phi, \psi, \pi)(y) \in H^{k}$ for any $k \in \mathbb{N}$.

Proof. In view of Proposition 3.1 and Proposition 3.6, we have constructed solution $\psi(\xi, y)$ to problem (1.14)-(1.15) with $\psi \in \mathcal{A} \cap H^{k}$, for any $k \in \mathbb{N}$. According to (1.12) $)_{3}$ and $(1.12)_{1}$, we have

\phi(\xi, y)=-\xi^{-1} \psi^{\prime}, \pi(\xi, y)=\xi^{-1}\left(\lambda \bar{\rho} \phi+\mu \xi^{2} \phi-\mu \phi^{\prime \prime}\right)=-\xi^{-2}\left(\lambda \bar{\rho} \psi^{\prime}+\mu \xi^{2} \psi^{\prime}-\mu \psi^{\prime \prime \prime}\right)
$$

which gives rise to solutions $(\phi, \psi, \pi)$ to (1.12), and also indicates that $(\phi, \psi, \pi)(y) \in H^{k}$. In addition, boundary conditions (1.13) follows directly from (1.15) and (1.12) 3 .

Remark 3.9. In view of the definition of functional $E(\psi)$ and the definition of $\lambda(\xi)$ in (3.17), it is clear that the function $\lambda(\xi)$ with respect to $\xi$ is an even function on $\mathbb{A}^{g}$. In the meantime, the associated $\psi(\xi)$ constructed in Proposition 3.6 is also an even function with respect to $\xi$ defined on $\mathbb{A}^{g}$. Subsequently, in view of proposition 3.8 the corresponding function $\pi(\xi, y)$ is also an even function on $\xi \in \mathbb{A}^{g}$, while $\phi(\xi, y)$ is an odd function on $\xi \in \mathbb{A}^{g}$.

The next proposition provides $H^{k}$-estimates for the solution $(\phi, \psi, \pi)(y)$ with $\xi$ varying. To emphasize the dependence on $\xi$, we denote the solution by $(\phi, \psi, \pi)(\xi):=(\phi, \psi, \pi)(\xi, y)$.

Proposition 3.10. For any $\xi \in \mathbb{A}^{g}$, let $(\phi, \psi, \pi)(\xi)$ with the corresponding function $\lambda(\xi)$ be solution to problem (1.12)-(1.13), constructed as above. Then, for any $k \in \mathbb{N}$, there exist positive constants $A_{k}, B_{k}, C_{k}$ depending on $a, b, \bar{\rho}, \mu, k_{0}, k_{1}, g$, such that

\|\psi(\xi)\|_{H^{k}} \leq A_{k}, \quad\|\phi(\xi)\|_{H^{k}} \leq B_{k}, \quad\|\pi(\xi)\|_{H^{k}} \leq C_{k}
$$

Proof. Throughout the proof, $\tilde{C}$ is a generic positive number depending on $a, b, \bar{\rho}, \mu, k_{0}, k_{1}, g$. Firstly, since $\psi \in \mathcal{A}$, one gets $\|\psi\|_{L^{2}}^{2}>0$. Furthermore, there exists constant $A_{1}$, such that

Secondly, Proposition 3.5 implies that there exists $\psi(\xi) \in \mathcal{A}$, such that

Rewriting (3.37), similar to (3.4), one can deduce that

= & -\lambda^{2}+\lambda\left[\sum_{i=0}^{1} k_{i}\left|\psi^{\prime}(i)\right|^{2}-\mu \int_{0}^{1} \xi^{2}\left(2\left|\psi^{\prime}\right|^{2}+\xi^{2} \psi^{2}\right) d y\right]+\int_{0}^{1} g \xi^{2} \bar{\rho}^{\prime} \psi^{2} d y \\
\leq & -\lambda^{2}+\frac{\lambda \mu}{2} \int_{0}^{1}\left|\psi^{\prime \prime}(\xi)\right|^{2} d y+\lambda C_{0}\left\|\frac{1}{\bar{\rho}}\right\|_{L^{\infty}(0,1)}+g\left\|\frac{\bar{\rho}^{\prime}}{\bar{\rho}}\right\|_{L^{\infty}(0,1)}
\end{aligned}
$$

According to Proposition 3.7, $\lambda$ has positive bounds from upper and lower, and hence

& =\left\{\left(2 \lambda \mu \xi^{2}+\lambda^{2} \bar{\rho}\right) \psi^{\prime \prime}+\lambda^{2} \bar{\rho}^{\prime} \psi^{\prime}+\xi^{2}\left(g \bar{\rho}^{\prime}-\lambda \mu \xi^{2}-\lambda^{2} \bar{\rho}\right) \psi\right\} / \lambda \mu
\end{align*}
$$

which infers that

Applying Gagliardo-Nirenberg interpolation inequality, one has

Differentiating equation (3.39) with respect to $y$ and using (3.40), we find, by induction on $k$, that $\|\psi(y)\|_{H^{k}} \leq A_{k}$, for any $k \in \mathbb{N}$. Note that $\phi, \pi$ can be expressed by $\psi$ and some constants, the rest inequalities then follows.

In the next proposition, we will construct the exponentially growing solutions of linearized problem (1.8)-(1.7).

Proposition 3.11. Under the assumptions of Theorem [1.1] let

\mathbf{w}(\xi, y)=-i \phi(\xi, y) \mathbf{e}_{1}+\psi(\xi, y) \mathbf{e}_{2}, \tag{3.46}

where $(\phi, \psi)$ with an associated growth rate $\lambda(\xi)$ is constructed in Proposition 3.8 for any given $\xi \in \mathbb{A}^{g}$. Recalling the definition of $\Lambda$, there exist $\xi \in \mathbb{A}^{g} \cap L^{-1} \mathbb{Z}$, such that

& q(x, y ; t)=e^{\Lambda^{*} t} \pi(\xi, y)\left[e^{i x \xi}+e^{-i x \xi}\right] \tag{3.49}

constitute a horizontally periodic, real-value solution to linearized problem (1.7)-(1.8) with

\|(\varrho, \mathbf{u}, q)(0)\|_{H^{k}} \leq M_{k}, \text { and }\left\|u_{2}(0)\right\|_{L^{2}}>0 . \tag{3.50}

where $M_{k}$ are positive numbers depending on $A_{k}, B_{k}, C_{k}$ in Proposition 3.10. In addition, $\left\|u_{1}(0)\right\|_{L^{2}}\left\|u_{2}(0)\right\|_{L^{2}}>0$ is clear, since that $\psi \in \mathcal{A}$ and $\xi \phi+\psi^{\prime}=0$, and thus (3.50) follows.

It remains to prove (3.43) and (3.44). We take $q(x, y ; t)$ for an example, and the others can be done similarly. Recalling the expression of $q(x, y ; t)$, one sees that

## 4 Energy estimates for the nonlinear perturbed problem

As a preparation to prove nonlinear instability in next section, referring to [12, 18, 19], we establish some energy estimates for nonlinear perturbation equations in this section.

Suppose that $(\varrho, \mathbf{u}, q)$ is a strong solution to nonlinear problem (1.6)-(1.7). Then, for convenience, we denote

& \mathcal{E}_{0}:=\mathcal{E}\left(\left(\varrho_{0}, \mathbf{u}_{0}\right)\right)=\sqrt{\left\|\varrho_{0}\right\|_{H^{1}}^{2}+\left\|\mathbf{u}_{0}\right\|_{H^{2}}^{2}} \tag{4.2}
\end{align*}
$$

and assume that there exists a constant $\delta_{0} \in(0,1)$ depending only on $\mu, \bar{\rho}, g, k_{0}, k_{1}$, such that

\end{equation*}
$$

In this section, $C$ is denoted as a generic positive number depending only $\mu, g, \bar{\rho}, k_{0}, k_{1}$.
For $\mathbf{x} \in \Omega$, we define $X \in \Omega_{t}$ as below

where v is the velocity of the fluid given in (1.1). Then, recalling 1.1$)_{1}$, one sees that

Denote that

\alpha:=\inf _{\mathbf{x} \in \Omega}\left\{\rho_{0}(\mathbf{x})\right\}>0, \quad \beta:=\sup _{\mathbf{x} \in \Omega}\left\{\rho_{0}(\mathbf{x})\right\}<\infty . \tag{4.5}
\end{equation*}
$$

Then, for any $t \in(0, T]$, it follows from (4.4) that

As for $I_{1}$, using Hölder inequality and Cauchy inequality, together with $\bar{\rho}(y) \in C_{0}^{\infty}(0,1)$, one gets

\|\mathbf{u}\|_{H^{2}}^{2}+\|\nabla q\|_{L^{2}}^{2} & \lesssim\left\|\rho \mathbf{u}_{t}\right\|_{L^{2}}^{2}+\|\rho \mathbf{u} \cdot \nabla \mathbf{u}\|_{L^{2}}^{2}+\|\varrho\|_{L^{2}}^{2} \\
& \left.\lesssim\left\|\mathbf{u}_{t}\right\|_{L^{2}}^{2}+\|\varrho\|_{L^{2}}^{2}+\|\mathbf{u}\|_{L^{\infty}}^{2}\|\nabla \mathbf{u}\|_{L^{2}}^{2}\right) \\
& \lesssim\left\|\mathbf{u}_{t}\right\|_{L^{2}}^{2}+\|\varrho\|_{L^{2}}^{2}+\|\mathbf{u}\|_{L^{2}}\|\nabla \mathbf{u}\|_{L^{2}}^{2}\|\mathbf{u}\|_{H^{2}} \\
& \leq C_{\varepsilon}\left(\left\|\mathbf{u}_{t}\right\|_{L^{2}}^{2}+\|\varrho\|_{L^{2}}^{2}+\|\mathbf{u}\|_{L^{2}}^{2}\|\nabla \mathbf{u}\|_{L^{2}}^{4}\right)+\varepsilon\|\mathbf{u}\|_{H^{2}}^{2} \tag{4.33}
\end{align*}

which, together with $\mathcal{E}(t) \leq \bar{\delta}$ implies that

Compared to classical well-posedness results of nonhomogeneous Navier-Stokes equations in [4 [29], the boundary integral terms produced by the Navier-slip boundary condition in this paper bring some new difficulties in the energy estimates. However, these difficulties can be overcome by using the technique applied in [23]. Thus, based on estimate (4.41], the global well-posedness of the nonlinear system (1.6)-(1.7) follows. We state this result below without the proof.
Proposition 4.1. Suppose that the steady state satisfies (1.3). Then for any given initial data $\left(\varrho_{0}, \mathbf{u}_{0}\right) \in\left(H^{1} \cap L^{\infty}\right) \times H^{2}$ satisfying (4.2), (4.5), $\nabla \cdot \mathbf{u}_{0}=0$, and also being compatible with the boundary conditions (1.2), the nonlinear problem (1.6)- (1.7) has a global strong solution $(\varrho, \mathbf{u}, \nabla q) \in C\left([0, T] ; H^{1} \times H^{2} \times L^{2}\right)$, such that

where the positive number $C_{4}(T)$ depends only on $g, \mu, \alpha, \beta, \bar{\rho}$ and also $T$.

## 5 The proof of nonlinear instability

In this section, we will prove the nonlinear instability by the bootstrap argument proposed by Y. Guo et al. in [11]. To be precise, we will show that there exists a constant $\varepsilon>0$ such that for any $\delta_{0}$, though small enough, and the initial data is smaller then $\delta_{0}$ in some suitable sense, the nonlinear system (1.6)-(1.7) admits a strong solution $\mathbf{u}^{\delta}$ and an escape time $T^{\delta}>0$ such that $\left\|\mathbf{u}^{\delta}\left(T^{\delta}\right)\right\|_{L^{2}}>\varepsilon$.

To this end, we first give the following elementary inequality, which will be used in the proof of Proposition 5.2

Lemma 5.1. Let $\mathbf{w} \in H_{\sigma}^{1} \cap H^{2}$, where $H_{\sigma}^{1}=\left\{\mathbf{w} \in H^{1} \mid \operatorname{div} \mathbf{w}=0, w_{2}=0\right.$ on $\left.\Sigma_{1} \cup \Sigma_{0}\right\}$, then it holds that

Denote $\left(\varrho_{0}^{\delta}, \mathbf{u}_{0}^{\delta}\right):=\delta\left(\varrho_{0}, \overline{\mathbf{u}}_{0}\right)$, and $C_{5}:=\left\|\left(\bar{\varrho}_{0}, \overline{\mathbf{u}}_{0}\right)\right\|_{L^{2}}$. Keeping in mind that

Hence, by virtue of Proposition 4.1, the perturbed problem (1.6) (1.7) admits a strong solution $\left(\varrho^{\delta}, \mathbf{u}^{\delta}\right) \in C^{0}\left(\left[0, T^{\max }\right), H^{1} \times H^{2}\right)$ with an associated pressure $\nabla q^{\delta} \in C^{0}\left(\left[0, T^{\max }\right), L^{2}\right)$, satisfying the initial data $\left(\varrho_{0}^{\delta}, \mathbf{u}_{0}^{\delta}\right)$ with $\mathcal{E}\left(\left(\varrho_{0}^{\delta}, \mathbf{u}_{0}^{\delta}\right)\right)=\delta$. Moreover, we have

R_{1}=\left[\int\left(\varrho^{\delta}+\bar{\rho}\right)\left|\mathbf{u}_{t}^{\mathrm{d}}\right|^{2} \mathrm{~d} x\right]_{t=0}
$$

and

$$
R_{2}(t)=\int_{0}^{t}\left(2 \mathbf{f}_{\tau}+2 g \mathbf{u}^{\delta} \cdot \nabla \varrho^{\delta} \mathbf{e}_{2}-\varrho_{\tau}^{\delta} \mathbf{u}_{\tau}^{\mathrm{d}}\right) \cdot \mathbf{u}_{\tau}^{\mathrm{d}} \mathrm{~d} \tau
$$

The estimate of the above two terms $R_{1}$ and $R_{2}(t)$ follows from [20]. For convenience, we state the conclusion without proofs

$$
\begin{equation*}
R_{1}+R_{2}(t) \lesssim \delta^{3} e^{3 \Lambda^{*} t} \tag{5.16}
\end{equation*}
$$

which, together with (5.15), yields that

$$
\begin{align*}
& \left\|\sqrt{\varrho^{\delta}+\bar{\rho}} \mathbf{u}_{t}^{\mathrm{d}}(t)\right\|_{L^{2}}^{2}+2 \int_{0}^{t}\left(\mu\left\|\nabla \mathbf{u}_{\tau}^{\mathrm{d}}\right\|_{L^{2}}^{2}-\int_{2 \pi L \mathbb{T}} k_{i}\left|\partial_{\tau} u_{1}^{\mathrm{d}}(x, i)\right|^{2} \mathrm{~d} x\right) \mathrm{d} \tau \\
\leq & \int g \bar{\rho}^{\prime}\left|u_{2}^{\mathrm{d}}\right|^{2}+C \delta^{3} e^{3 \Lambda^{*} t} . \tag{5.17}
\end{align*}
$$

In addition, it follows from Lemma5.1 that

$$
\begin{equation*}
\int g \bar{\rho}^{\prime}\left|u_{2}^{\mathrm{d}}\right|^{2} \leq \Lambda^{2} \int\left(\varrho^{\delta}+\bar{\rho}\right)\left|\mathbf{u}^{\mathrm{d}}\right|^{2}+\Lambda \mu \int\left|\nabla \mathbf{u}^{\mathrm{d}}\right|^{2}-\Lambda \sum_{i=0}^{1} k_{i} \int_{2 \pi L \mathbb{T}}\left|u_{1}^{\mathrm{d}}(x, i)\right|^{2} \mathrm{~d} x \tag{5.18}
\end{equation*}
$$

Recalling that $\mathbf{u}^{\mathrm{d}} \in C^{0}\left(\bar{I}_{T_{\text {min }}}, H^{2}\right)$ and $\left.\nabla \mathbf{u}^{\mathrm{d}}(t)\right|_{t=0}=0$, using Newton-Leibniz's formula and Cauchy inequality, we rewrite and estimate the last two terms in the right hand side as follows:

\begin{align*}
& \Lambda\left(\mu \int\left|\nabla \mathbf{u}^{\mathrm{d}}\right|^{2}-\sum_{i=0}^{1} k_{i} \int_{2 \pi L \mathbb{T}}\left|u_{1}^{\mathrm{d}}(x, i)\right|^{2} \mathrm{~d} x\right) \\
& \leq \Lambda^{2} \int_{0}^{t}\left(\mu\left\|\nabla \mathbf{u}^{\mathrm{d}}\right\|_{L^{2}}^{2}-\sum_{i=0}^{1} \int_{2 \pi L \mathbb{T}} k_{i}\left|u_{1}^{\mathrm{d}}(x, i)\right|^{2} \mathrm{~d} x\right) \mathrm{d} \tau \\
&+\int_{0}^{t}\left(\mu\left\|\nabla \mathbf{u}_{\tau}^{\mathrm{d}}\right\|_{L^{2}}^{2}-\sum_{i=0}^{1} \int_{2 \pi L \mathbb{T}} k_{i}\left|\partial_{\tau} u_{1}^{\mathrm{d}}(x, i)\right|^{2} \mathrm{~d} x\right) \mathrm{d} \tau \\
&+\int_{0}^{t}\left[\sum_{i=0}^{1} \int_{2 \pi L \mathbb{T}} k_{i}\left(\Lambda u_{1}^{\mathrm{d}}(x, i)-\partial_{\tau} u_{1}^{\mathrm{d}}(x, i)\right)^{2} \mathrm{~d} x\right] \mathrm{d} \tau \tag{5.19}
\end{align*}
$$

Putting the above three inequalities together gives

$$
\begin{align*}
&\left\|\sqrt{\varrho^{\delta}+\bar{\rho}} \mathbf{u}_{t}^{\mathrm{d}}(t)\right\|_{L^{2}}^{2}+\frac{1}{2} \int_{0}^{t}\left(\mu\left\|\nabla \mathbf{u}_{\tau}^{\mathrm{d}}\right\|_{L^{2}}^{2}-\sum_{i=0}^{1} \int_{2 \pi L \mathbb{T}} k_{i}\left|\partial_{\tau} u_{1}^{\mathrm{d}}(x, i)\right|^{2} \mathrm{~d} x\right) \mathrm{d} \tau \\
&+\frac{1}{2} \Lambda\left(\mu \int\left|\nabla \mathbf{u}^{\mathrm{d}}\right|^{2}-\sum_{i=0}^{1} k_{i} \int_{2 \pi L \mathbb{T}}\left|u_{1}^{\mathrm{d}}(x, i)\right|^{2} \mathrm{~d} x\right) \\
& \leq \Lambda^{2} \int\left(\varrho^{\delta}+\bar{\rho}\right)\left|\mathbf{u}^{\mathrm{d}}\right|^{2}+C \delta^{3} e^{3 \Lambda^{*} t}+\frac{3}{2} \Lambda^{2} \int_{0}^{t}\left(\mu\left\|\nabla \mathbf{u}^{\mathrm{d}}\right\|_{L^{2}}^{2}-\sum_{i=0}^{1} \int_{2 \pi L \mathbb{T}} k_{i}\left|u_{1}^{\mathrm{d}}(x, i)\right|^{2} \mathrm{~d} x\right) \mathrm{d} \tau \\
&+\frac{3}{2} \int_{0}^{t}\left[\sum_{i=0}^{1} \int_{2 \pi L \mathbb{T}} k_{i}\left(\Lambda u_{1}^{\mathrm{d}}(x, i)-\partial_{\tau} u_{1}^{\mathrm{d}}(x, i)\right)^{2} \mathrm{~d} x\right] \mathrm{d} \tau \tag{5.20}
\end{align*}
$$

On the other hand, by virtue of Cauchy inequality, we get

$$
\begin{align*}
\frac{\mathrm{d}}{\mathrm{~d} t}\left\|\sqrt{\varrho^{\delta}+\bar{\rho}} \mathbf{u}^{\mathrm{d}}\right\|_{L^{2}}^{2} & =2 \int\left(\varrho^{\delta}+\bar{\rho}\right) \mathbf{u}^{\mathrm{d}} \cdot \mathbf{u}_{t}^{\mathrm{d}}+\int \varrho_{t}^{\delta}\left|\mathbf{u}^{\mathrm{d}}\right|^{2}  \tag{5.21}\\
& \leq \frac{1}{\Lambda}\left\|\sqrt{\left(\varrho^{\delta}+\bar{\rho}\right)} \mathbf{u}_{t}^{\mathrm{d}}\right\|_{L^{2}}^{2}+\Lambda\left\|\sqrt{\varrho^{\delta}+\bar{\rho}} \mathbf{u}^{\mathrm{d}}\right\|_{L^{2}}^{2}+\int \varrho_{t}^{\delta}\left|\mathbf{u}^{\mathrm{d}}\right|^{2}
\end{align*}
$$

Utilizing (5.2), (5.5), (5.9) and embedding inequality, the last term can be estimated as

$$
\begin{equation*}
\int \varrho_{t}^{\delta}\left|\mathbf{u}^{\mathrm{d}}\right|^{2}=-\int\left(\mathbf{u}^{\delta} \cdot \nabla \varrho^{\delta}+\bar{\rho}^{\prime} u_{2}^{\delta}\right)\left|\mathbf{u}^{\mathrm{d}}\right|^{2}=\int\left(2 \varrho^{\delta} \mathbf{u}^{\delta} \cdot \nabla \mathbf{u}^{\mathrm{d}}-\bar{\rho}^{\prime} u_{2}^{\delta} \mathbf{u}^{\mathrm{d}}\right) \cdot \mathbf{u}^{\mathrm{d}} \lesssim \delta^{3} e^{3 \Lambda^{*} t} \tag{5.22}
\end{equation*}
$$

Furthermore, integrating (5.21) in time from 0 to $t$, together with 5.20 and using Young inequality, we have

$$
\begin{align*}
& \left\|\sqrt{\varrho^{\delta}+\bar{\rho}} \mathbf{u}_{t}^{\mathrm{d}}\right\|_{L^{2}}^{2}+\Lambda \mu\left\|\nabla \mathbf{u}^{\mathrm{d}}\right\|_{L^{2}}^{2}+\int_{0}^{t} \mu\left\|\nabla \mathbf{u}_{\tau}^{\mathrm{d}}\right\|_{L^{2}}^{2} \mathrm{~d} \tau \\
\leq & \Lambda \int_{0}^{t}\left(\left\|\sqrt{\varrho^{\delta}+\bar{\rho}} \mathbf{u}_{\tau}^{\mathrm{d}}\right\|_{L^{2}}^{2}+\Lambda \mu\left\|\nabla \mathbf{u}^{\mathrm{d}}\right\|_{L^{2}}^{2}\right) \mathrm{d} \tau+\Lambda\left\|\sqrt{\varrho^{\delta}+\bar{\rho}} \mathbf{u}^{\mathrm{d}}\right\|_{L^{2}}^{2}+C \delta^{3} e^{3 \Lambda^{*} t} \tag{5.23}
\end{align*}
$$

Summing up the previous three estimates together yields

$$
\begin{align*}
& \quad \frac{\mathrm{d}}{\mathrm{~d} t}\left\|\sqrt{\varrho^{\delta}+\bar{\rho}} \mathbf{u}^{\mathrm{d}}(t)\right\|_{L^{2}}^{2}+\left(\left\|\sqrt{\varrho^{\delta}+\bar{\rho}} \mathbf{u}_{t}^{\mathrm{d}}(t)\right\|_{L^{2}}^{2}+\Lambda \mu\left\|\nabla \mathbf{u}^{\mathrm{d}}(t)\right\|_{L^{2}}^{2}\right) \\
& \leq \Lambda\left[\left\|\sqrt{\varrho^{\delta}+\bar{\rho}} \mathbf{u}^{\mathrm{d}}(t)\right\|_{L^{2}}^{2}+\int_{0}^{t}\left(\left\|\sqrt{\varrho^{\delta}+\bar{\rho}} \mathbf{u}_{\tau}^{\mathrm{d}}\right\|_{L^{2}}^{2}+\Lambda \mu\left\|\nabla \mathbf{u}^{\mathrm{d}}\right\|_{L^{2}}^{2}\right) \mathrm{d} \tau\right]+C \delta^{3} e^{3 \Lambda^{*} t} \tag{5.24}
\end{align*}
$$

Therefore, applying Gronwall's inequality to (5.24), one obtains

$$
\begin{equation*}
\left\|\sqrt{\varrho^{\delta}+\bar{\rho}} \mathbf{u}^{\mathrm{d}}(t)\right\|_{L^{2}}^{2}+\int_{0}^{t}\left(\left\|\sqrt{\varrho^{\delta}+\bar{\rho}} \mathbf{u}_{\tau}^{\mathrm{d}}\right\|_{L^{2}}^{2}+\left\|\nabla \mathbf{u}^{\mathrm{d}}\right\|_{L^{2}}^{2}\right) \mathrm{d} \tau \lesssim C \delta^{3} e^{3 \Lambda^{*} t}, \tag{5.25}
\end{equation*}
$$

for all $t \leq \bar{I}_{T_{\min }}$, where the constant $C$ depends on $k_{0}, k_{1}, \mu, \bar{\rho}, T_{\text {min }}, \Lambda$. Together with (5.5) and (5.23), we deduce that

$$
\begin{equation*}
\left\|\mathbf{u}^{\mathrm{d}}(t)\right\|_{H^{1}}^{2}+\int_{0}^{t}\left(\left\|\mathbf{u}_{\tau}^{\mathrm{d}}\right\|_{L^{2}}^{2}+\left\|\nabla \mathbf{u}^{\mathrm{d}}\right\|_{L^{2}}^{2}\right) \mathrm{d} \tau \lesssim \delta^{3} e^{3 \Lambda^{*} t} . \tag{5.26}
\end{equation*}
$$

Finally, using the estimates (5.9), (5.26) and embedding inequality, we can deduce from the equation (5.10) that

$$
\begin{align*}
\left\|\varrho^{\mathrm{d}}(t)\right\|_{L^{2}} & \leq \int_{0}^{t}\left\|\varrho_{\tau}^{\mathrm{d}}\right\|_{L^{2}} \mathrm{~d} \tau \lesssim \int_{0}^{t}\left(\left\|\mathbf{u}^{\mathrm{d}}\right\|_{H^{1}}+\left\|\mathbf{u}^{\delta} \cdot \nabla \varrho^{\delta}\right\|_{L^{2}}\right) \mathrm{d} \tau  \tag{5.27}\\
& \lesssim \int_{0}^{t}\left(\delta^{\frac{3}{2}} e^{\frac{3 \Lambda^{*}}{2} \tau}+\delta^{2} e^{2 \Lambda^{*} \tau}\right) \mathrm{d} \tau \lesssim \delta^{\frac{3}{2}} e^{\frac{3 \Lambda^{*}}{2} t},
\end{align*}
$$

in which we have used the following fact

$$
\begin{equation*}
\delta e^{\Lambda^{*} t} \leq \delta e^{\Lambda^{*} T^{\delta}}=\varepsilon_{0}<1 \text { for any } t \in \bar{I}_{T_{\min }} . \tag{5.28}
\end{equation*}
$$

Therefore, consolidating (5.27) with (5.25), the desired estimate (5.11) follows. This completes the proof of this proposition.

Proof of Theorem 1.2. Now, with [5.2],(5.6), (5.9) and (5.11) in hands, referring to [20] for details, we can conclude that

$$
\begin{equation*}
T^{\delta}=T_{\min }, \text { provided } \varepsilon_{0}=\min \left\{\frac{\delta_{0}}{4 \sqrt{C_{4}}}, \frac{C_{5}^{2}}{2 C_{7}^{2}}, \frac{m_{0}^{2}}{8 C_{7}}\right\}, \tag{5.29}
\end{equation*}
$$

where we have defined that $m_{0}=: \min \left\{\left\|\bar{\varrho}_{0}\right\|_{L^{2}},\left\|\bar{u}_{02}\right\|_{L^{2}},\left\|\bar{u}_{01}\right\|_{L^{2}}\right\}>0$ due to (5.3).
Since $T^{\delta}=T_{\min }$, 5.11) holds for $t=T^{\delta}$. Therefore, we can use 5.11) and (5.29) with $t=T^{\delta}$ to obtain that

$$
\begin{aligned}
\left\|\varrho^{\delta}\left(T^{\delta}\right)\right\|_{L^{2}} & \geq\left\|\varrho_{\delta}^{\mathrm{a}}\left(T^{\delta}\right)\right\|_{L^{2}}-\left\|\varrho^{\mathrm{d}}\left(T^{\delta}\right)\right\|_{L^{2}} \geq \delta e^{\Lambda^{*} T^{\delta}}\left\|\varrho_{0}\right\|_{L^{2}}-\sqrt{C_{7}} \delta^{3 / 2} e^{3 \Lambda^{*} T^{\delta} / 2} \\
& \geq 2 \varepsilon_{0}\left\|\bar{\varrho}_{0}\right\|_{L^{2}}-2^{3 / 2} \sqrt{C_{7}} \varepsilon_{0}^{3 / 2} \geq 2 m_{0} \varepsilon_{0}-2^{3 / 2} \sqrt{C_{7}} \varepsilon_{0}^{3 / 2} \geq m_{0} \varepsilon_{0} .
\end{aligned}
$$

Similarly, it is easy to get that

$$
\left\|u_{i}^{\delta}\left(T^{\delta}\right)\right\|_{L^{2}} \geq 2 m_{0} \varepsilon_{0}-2^{3 / 2} \sqrt{C_{7}} \varepsilon_{0}^{3 / 2} \geq m_{0} \varepsilon_{0}
$$

where $u_{i}^{\delta}\left(T^{\delta}\right)$ denotes the $i$-th component of $u^{\delta}\left(T^{\delta}\right)$ for $i=1,2$. This completes the proof of Theorem 1.2 by defining $\varepsilon:=m_{0} \varepsilon_{0}$.
