THE NEUMANN PROBLEM OF HESSIAN QUOTIENT EQUATIONS

ABSTRACT. In this paper, we obtain some important inequalities of Hessian quotient operators, and global C^2 estimates of the Neumann problem of Hessian quotient equations. By the method of continuity, we establish the existence theorem of k-admissible solutions of the Neumann problem of Hessian quotient equations.

Key words: Hessian quotient equation, Neumann problem, k-admissible solution.

1. Introduction

In this paper, we consider the k-admissible solution of the Neumann problem of Hessian quotient equations

(1.1)
$$\frac{\sigma_k(D^2u)}{\sigma_l(D^2u)} = f(x), \quad \text{in} \quad \Omega \subset \mathbb{R}^n,$$

where $0 \le l < k \le n$, and for any $k = 1, \dots, n$,

$$\sigma_k(D^2u) = \sigma_k(\lambda(D^2u)) = \sum_{1 \le i_1 \le i_2 < \dots < i_k \le n} \lambda_{i_1} \lambda_{i_2} \cdots \lambda_{i_k},$$

with $\lambda(D^2u)=(\lambda_1,\cdots,\lambda_n)$ be the eigenvalues of D^2u . We also set $\sigma_0=1$. Recall that the Garding's cone is defined as

$$\Gamma_k = \{ \lambda \in \mathbb{R}^n : \sigma_i(\lambda) > 0, \forall 1 \le i \le k \}.$$

If $\lambda(D^2u) \in \Gamma_k$ for any $x \in \Omega$, then the equation (1.1) is elliptic (see [12]), and we say u is a k-admissible solution of (1.1).

If l = 0, (1.1) is known as the k-Hessian equation. In particular, (1.1) is the Laplace equation if k = 1, l = 0, and the Monge-Ampère equation if k = n, l = 0. Hessian quotient equations are a more general form of k-Hessian equations, which appear naturally in classical geometry, conformal geometry and Kähler geometry, etc.

For the Dirichlet problem of elliptic equaions in \mathbb{R}^n , many results are known. For example, the Dirichlet problem of Laplace equation was studied in [5], Caffarelli-Nirenberg-Spruck [1] and Ivochkina [8] solved the Dirichlet problem of the Monge-Ampère equation, and Caffarelli-Nirenberg-Spruck [2] solved the Dirichlet problem of the k-Hessian equation. For the general Hessian quotient equation, the Dirichlet problem was solved by Trudinger in [24].

Also, the Neumann or oblique derivative problem of partial differential equations was widely studied. For a priori estimates and the existence theorem of Laplace equation with Neumann boundary condition, we refer to the book [5]. Also, we can see the recent book written by Lieberman [13] for the Neumann or oblique derivative problem of linear and quasilinear elliptic equations. In 1986, Lions-Trudinger-Urbas solved the Neumann problem of Monge-Ampère equation in the celebrated paper [16]. For related results on the Neumann or oblique derivative problem for some class fully nonlinear elliptic equations can be found in Urbas [25] and [26]. For the the Neumann problem of k-Hessian equations, Trudinger [23] established the existence theorem when the domain is a ball, and he conjectured (in [23], page 305) that one could solve the problem in sufficiently smooth strictly convex domains. Recently, Ma-Qiu [17] gave a positive answer to this problem and solved the Neumann problem of k-Hessian equations in strictly convex domains.

Naturally, we want to know how about the Neumann problem of Hessian quotient equations. In this paper, we establish global C^2 estimates of the Neumann problem of Hessian quotient equations and obtain the existence theorem as follows,

Theorem 1.1. Suppose that $\Omega \subset \mathbb{R}^n$ is a C^4 convex and strictly (k-1)-convex domain, $0 \le l < k \le n$, ν is the outer unit normal vector of $\partial\Omega$, $f \in C^2(\overline{\Omega})$ is a positive function and $\varphi \in C^3(\partial\Omega)$. Then there exists a unique k-admissible solution $u \in C^{3,\alpha}(\overline{\Omega})$ of the Neumann problem of Hessian quotient equation

(1.2)
$$\begin{cases} \frac{\sigma_k(D^2u)}{\sigma_l(D^2u)} = f(x), & in \quad \Omega, \\ u_{\nu} = -u + \varphi(x), & on \quad \partial\Omega. \end{cases}$$

Remark 1.2. The C^2 domain $\Omega \subset \mathbb{R}^n$ is convex, that is, $\kappa_i(x) \geq 0$ for any $x \in \partial\Omega$ and $i = 1, \dots, n-1$, or equivalently, $\kappa(x) = (\kappa_1, \dots, \kappa_{n-1}) \in \overline{\Gamma_{n-1}}$ for any $x \in \partial\Omega$, where $\kappa(x) = (\kappa_1, \dots, \kappa_{n-1})$ denote the principal curvatures of $\partial\Omega$ with respect to its inner normal. Similarly, Ω is strictly (k-1)-convex, in the sense of $\kappa(x) = (\kappa_1, \dots, \kappa_{n-1}) \in \Gamma_{k-1}$ for any $x \in \partial\Omega$. For simplify, a domain is called strictly convex if it is strictly (n-1)-convex.

Following the idea in [20], we can obtain the existence theorem of the classical Neumann problem of Hessian quotient equations

Theorem 1.3. Suppose that $\Omega \subset \mathbb{R}^n$ is a C^4 strictly convex domain, $0 \le l < k \le n$, ν is the outer unit normal vector of $\partial \Omega$, $f \in C^2(\overline{\Omega})$ is a positive function and

 $\varphi \in C^3(\partial\Omega)$. Then there exists a unique constant c, such that the Neumann problem of the Hessian quotient equation

(1.3)
$$\begin{cases} \frac{\sigma_k(D^2u)}{\sigma_l(D^2u)} = f(x), & in \quad \Omega, \\ u_{\nu} = c + \varphi(x), & on \quad \partial \Omega, \end{cases}$$

has k-admissible solutions $u \in C^{3,\alpha}(\overline{\Omega})$, which are unique up to a constant.

Remark 1.4. For the classical Neumann problem of Hessian quotient equations (1.3), it is easy to know that a solution plus any constant is still a solution. So we cannot obtain a uniform bound for the solutions of (1.3), and cannot use the method of continuity directly to get the existence. As in Lions-Trudinger-Urbas [16] and Qiu-Xia [20], we consider the k-admissible solution u^{ε} of the equation

(1.4)
$$\begin{cases} \frac{\sigma_k(D^2u^{\varepsilon})}{\sigma_l(D^2u^{\varepsilon})} = f(x), & \text{in } \Omega, \\ (u^{\varepsilon})_{\nu} = -\varepsilon u^{\varepsilon} + \varphi(x), & \text{on } \partial\Omega, \end{cases}$$

for any small $\varepsilon > 0$. We need to establish a priori estimates of u^{ε} independent of ε , and the strict convexity of Ω plays an important role. By letting $\varepsilon \to 0$ and a perturbation argument, we can obtain a solution of (1.3). The uniqueness holds from the maximum principle and Hopf Lemma.

Remark 1.5. In the recent papers [9, 10], Jiang and Trudinger studied the general oblique boundary value problems for augmented Hessian equations with some regular conditions and some concavity conditions. But here, the problems (1.2) and (1.3) do not satisfy the strictly regular condition and the uniform concavity condition.

Remark 1.6. As we all know, the Dirichlet problems of Hessian and Hessian quotient equations are solved in strictly (k-1)-convex domains. For the Neumann problems, we also want to know the existence results in strictly (k-1)-convex but not convex domains. A special case, that is

(1.5)
$$\begin{cases} \sigma_k(D^2u) = f(x), & \text{in } \Omega \subset \mathbb{R}^n, \\ u_\nu = -u, & \text{on } \partial\Omega, \end{cases}$$

is solvable in strictly (k-1)-convex domains, and see [19] for the proof. For general cases, the problem is open.

The rest of the paper is organized as follows. In Section 2, we collect some properties of the lementary symmetric function σ_k , and establish some key inequalities of Hessian quotient operators. Following the idea of Lions-Trudinger-Urbas [16] and Ma-Qiu [17], we establish the C^0 , C^1 and C^2 estimates for the Neumann problem of Hessian quotient equations in Section 3, Section 4, Section 5, respectively. At last, we prove Theorem 1.1 and Theorem 1.3 in Section 6.

2. Preliminary

In this section, we give some basic properties of elementary symmetric functions, which could be found in [12], and establish some key inequalities of Hessian quotient operators.

2.1. Basic properties of elementary symmetric functions. First, we denote by $\sigma_k(\lambda | i)$ the symmetric function with $\lambda_i = 0$ and $\sigma_k(\lambda | ij)$ the symmetric function with $\lambda_i = \lambda_j = 0$.

Proposition 2.1. Let
$$\lambda = (\lambda_1, \dots, \lambda_n) \in \mathbb{R}^n$$
 and $k = 1, \dots, n$, then $\sigma_k(\lambda) = \sigma_k(\lambda|i) + \lambda_i \sigma_{k-1}(\lambda|i), \quad \forall 1 \leq i \leq n,$
$$\sum_i \lambda_i \sigma_{k-1}(\lambda|i) = k \sigma_k(\lambda),$$

$$\sum_i \sigma_k(\lambda|i) = (n-k)\sigma_k(\lambda).$$

We also denote by $\sigma_k(W|i)$ the symmetric function with W deleting the i-row and i-column and $\sigma_k(W|ij)$ the symmetric function with W deleting the i, j-rows and i, j-columns. Then we have the following identities.

Proposition 2.2. Suppose $W = (W_{ij})$ is diagonal, and m is a positive integer, then

$$\frac{\partial \sigma_m(W)}{\partial W_{ij}} = \begin{cases} \sigma_{m-1}(W|i), & \text{if } i = j, \\ 0, & \text{if } i \neq j. \end{cases}$$

Recall that the Garding's cone is defined as

(2.1)
$$\Gamma_k = \{ \lambda \in \mathbb{R}^n : \sigma_i(\lambda) > 0, \forall 1 \le i \le k \}.$$

Proposition 2.3. Let $\lambda \in \Gamma_k$ and $k \in \{1, 2, \dots, n\}$. Suppose that

$$\lambda_1 \ge \cdots \ge \lambda_k \ge \cdots \ge \lambda_n$$

then we have

$$(2.2) \sigma_{k-1}(\lambda|n) \ge \sigma_{k-1}(\lambda|n-1) \ge \cdots \ge \sigma_{k-1}(\lambda|k) \ge \cdots \ge \sigma_{k-1}(\lambda|1) > 0;$$

(2.3)
$$\lambda_1 \geq \cdots \geq \lambda_k > 0, \quad \sigma_k(\lambda) \leq C_n^k \lambda_1 \cdots \lambda_k;$$

(2.4)
$$\lambda_1 \sigma_{k-1}(\lambda|1) \ge \frac{k}{n} \sigma_k(\lambda),$$

where $C_n^k = \frac{n!}{k!(n-k)!}$.

Proof. All the properties are well known. For example, see [12] or [7] for a proof of (2.2), [11] for (2.3), and [4] or [6] for (2.4).

The generalized Newton-MacLaurin inequality is as follows, which will be used all the time.

Proposition 2.4. For $\lambda \in \Gamma_k$ and $k > l \ge 0$, $r > s \ge 0$, $k \ge r$, $l \ge s$, we have

(2.5)
$$\left[\frac{\sigma_k(\lambda)/C_n^k}{\sigma_l(\lambda)/C_n^l}\right]^{\frac{1}{k-l}} \le \left[\frac{\sigma_r(\lambda)/C_n^r}{\sigma_s(\lambda)/C_n^s}\right]^{\frac{1}{r-s}}.$$

Proof. See [22]. \Box

2.2. **Key Lemmas.** In the establishment of the a priori estimates, the following inequalities of Hessian quotient operators play an important role.

Lemma 2.5. Suppose $\lambda = (\lambda_1, \lambda_2, \dots, \lambda_n) \in \Gamma_k$, $k \ge 1$, and $\lambda_1 < 0$. Then we have

(2.6)
$$\sigma_m(\lambda|1) \ge \sigma_m(\lambda), \quad \forall \quad m = 0, 1, \dots, k.$$

Moreover, we have

(2.7)
$$\frac{\partial \left[\frac{\sigma_k(\lambda)}{\sigma_l(\lambda)}\right]}{\partial \lambda_1} \geqslant \frac{n}{k} \frac{k-l}{n-l} \frac{1}{n-k+1} \sum_{i=1}^n \frac{\partial \left[\frac{\sigma_k(\lambda)}{\sigma_l(\lambda)}\right]}{\partial \lambda_i}, \quad \forall \quad 0 \le l < k.$$

Proof. Firstly, we can easily get

$$\sigma_m(\lambda) = \sigma_m(\lambda|1) + \lambda_1 \sigma_{m-1}(\lambda|1) \leqslant \sigma_m(\lambda|1),$$

so (2.6) holds.

Directly calculations yield

$$\sum_{i=1}^{n} \frac{\partial \left[\frac{\sigma_{k}(\lambda)}{\sigma_{l}(\lambda)}\right]}{\partial \lambda_{i}} = \sum_{i=1}^{n} \frac{\sigma_{k-1}(\lambda|i)\sigma_{l}(\lambda) - \sigma_{k}(\lambda)\sigma_{l-1}(\lambda|i)}{\sigma_{l}(\lambda)^{2}}$$

$$= \frac{(n-k+1)\sigma_{k-1}(\lambda)\sigma_{l}(\lambda) - (n-l+1)\sigma_{k}(\lambda)\sigma_{l-1}(\lambda)}{\sigma_{l}(\lambda)^{2}}$$

$$\leq (n-k+1)\frac{\sigma_{k-1}(\lambda)\sigma_{l}(\lambda)}{\sigma_{l}(\lambda)^{2}},$$
(2.8)

hence we can get

$$\frac{\partial \left[\frac{\sigma_{k}(\lambda)}{\sigma_{l}(\lambda)}\right]}{\partial \lambda_{1}} = \frac{\sigma_{k-1}(\lambda|1)\sigma_{l}(\lambda) - \sigma_{k}(\lambda)\sigma_{l-1}(\lambda|1)}{\sigma_{l}(\lambda)^{2}}$$

$$= \frac{\sigma_{k-1}(\lambda|1)\sigma_{l}(\lambda|1) - \sigma_{k}(\lambda|1)\sigma_{l-1}(\lambda|1)}{\sigma_{l}(\lambda)^{2}}$$

$$\geq \left(1 - \frac{l}{k} \frac{n-k}{n-l}\right) \frac{\sigma_{k-1}(\lambda|1)\sigma_{l}(\lambda|1)}{\sigma_{l}(\lambda)^{2}}$$

$$\geq \frac{n}{k} \frac{k-l}{n-l} \frac{\sigma_{k-1}(\lambda)\sigma_{l}(\lambda)}{\sigma_{l}(\lambda)^{2}}$$

$$\geq \frac{n}{k} \frac{k-l}{n-l} \frac{1}{n-k+1} \sum_{i=1}^{n} \frac{\partial \left[\frac{\sigma_{k}(\lambda)}{\sigma_{l}(\lambda)}\right]}{\partial \lambda_{i}}.$$
(2.9)

Lemma 2.6. Suppose $A = \{a_{ij}\}_{n \times n}$ satisfies

$$(2.10) a_{11} < 0, \{a_{ij}\}_{2 \le i,j \le n} is diagonal,$$

and $\lambda(A) \in \Gamma_k$ with $k \ge 1$. Then we have

(2.11)
$$\frac{\partial \left[\frac{\sigma_k(A)}{\sigma_l(A)}\right]}{\partial a_{11}} \geqslant \frac{n}{k} \frac{k-l}{n-l} \frac{1}{n-k+1} \sum_{i=1}^n \frac{\partial \left[\frac{\sigma_k(A)}{\sigma_l(A)}\right]}{\partial a_{ii}}, \quad \forall \quad 0 \le l < k,$$

and

(2.12)
$$\sum_{i=1}^{n} \frac{\partial \left[\frac{\sigma_{k}(A)}{\sigma_{l}(A)}\right]}{\partial a_{ii}} \ge \frac{k-l}{k} \frac{1}{C_{n}^{l}} (-a_{11})^{k-l-1}, \quad \forall \quad 0 \le l < k.$$

Proof. See Lemma 3.9 in [3] for the proof of (2.11).

To prove (2.12), we assume that $\lambda = (\lambda_1, \lambda_2, \dots, \lambda_n)$ are the eigenvalues of A, and $\lambda_1 \geq \lambda_2 \geq \dots \geq \lambda_n$. It is easy to know that $\lambda_n \leq a_{11} < 0$. Direct calculation

yields

$$\sum_{i=1}^{n} \frac{\partial \left[\frac{\sigma_{k}(A)}{\sigma_{l}(A)}\right]}{\partial a_{ii}} = \sum_{i=1}^{n} \frac{\partial \left[\frac{\sigma_{k}(\lambda)}{\sigma_{l}(\lambda)}\right]}{\partial \lambda_{i}} \ge \frac{k-l}{k} (n-k+1) \frac{\sigma_{k-1}(\lambda)}{\sigma_{l}(\lambda)}$$

$$\ge \frac{k-l}{k} (n-k+1) \frac{\lambda_{1} \cdots \lambda_{l} \sigma_{k-l-1}(\lambda|1, \cdots, l)}{C_{n}^{l} \lambda_{1} \cdots \lambda_{l}}$$

$$= \frac{k-l}{k} (n-k+1) \frac{1}{C_{n}^{l}} \sigma_{k-l-1}(\lambda|1, \cdots, l)$$

$$= \frac{k-l}{k} \frac{1}{C_{n}^{l}} \left[\sum_{j=l+1}^{n-1} \sigma_{k-l-1}(\lambda|1, \cdots, l, j) + \sigma_{k-l-1}(\lambda|1, \cdots, l, n) \right]$$

$$\ge \frac{k-l}{k} \frac{1}{C_{n}^{l}} \sigma_{k-l-1}(\lambda|1, \cdots, l, n)$$

$$\ge \frac{k-l}{k} \frac{1}{C_{n}^{l}} (-\lambda_{n})^{k-l-1} \ge \frac{k-l}{k} \frac{1}{C_{n}^{l}} (-a_{11})^{k-l-1}.$$
(2.13)

Hence (2.12) holds.

Lemma 2.7. Suppose $\lambda = (\lambda_1, \lambda_2, \dots, \lambda_n) \in \Gamma_k$, $k \geq 2$, and $\lambda_2 \geq \dots \geq \lambda_n$. If $\lambda_1 > 0$, $\lambda_n < 0$, $\lambda_1 \geq \delta \lambda_2$, and $-\lambda_n \geq \varepsilon \lambda_1$ for small positive constants δ and ε , then we have

(2.14)
$$\sigma_m(\lambda|1) \ge c_0 \sigma_m(\lambda), \quad \forall \quad m = 0, 1, \dots, k-1,$$

where $c_0 = \min\{\frac{\varepsilon^2 \delta^2}{2(n-2)(n-1)}, \frac{\varepsilon^2 \delta}{4(n-1)}\}$. Moreover, we have

(2.15)
$$\frac{\partial \left[\frac{\sigma_k(\lambda)}{\sigma_l(\lambda)}\right]}{\partial \lambda_1} \geqslant c_1 \sum_{i=1}^n \frac{\partial \left[\frac{\sigma_k(\lambda)}{\sigma_l(\lambda)}\right]}{\partial \lambda_i}, \quad \forall \quad 0 \le l < k,$$

where $c_1 = \frac{n}{k} \frac{k-l}{n-l} \frac{c_0^2}{n-k+1}$.

Proof. The idea of proof of (2.14) is from [17], and we produce the proof here. For m = 0, (2.14) holds directly. In the following, we assume $1 \le m \le k - 1$. Firstly, if $\lambda_1 \ge \lambda_2$, we have from (2.4)

(2.16)
$$\lambda_1 \sigma_{m-1}(\lambda | 1n) \ge \frac{m}{n-1} \sigma_m(\lambda | n).$$

If $\lambda_1 < \lambda_2$, we have

(2.17)
$$\lambda_1 \sigma_{m-1}(\lambda | 1n) \ge \lambda_1 \sigma_{m-1}(\lambda | 2n) \ge \delta \lambda_2 \sigma_{m-1}(\lambda | 2n)$$

$$\ge \delta \frac{m}{n-1} \sigma_m(\lambda | n).$$

Hence from (2.16) and (2.17), it holds

$$(-\lambda_n)\sigma_{m-1}(\lambda|1n) \ge \varepsilon \lambda_1 \sigma_{m-1}(\lambda|1n)$$

$$\ge \varepsilon \delta \frac{m}{n-1} \sigma_m(\lambda|n)$$

$$\ge \varepsilon \delta \frac{m}{n-1} \sigma_m(\lambda).$$

Let

(2.19)
$$\theta = \frac{\varepsilon \delta}{2(n-2)}.$$

We divide into two cases to prove (2.14).

♦ Case 1: $\sigma_m(\lambda|1) \ge \theta(-\lambda_n)\sigma_{m-1}(\lambda|1n)$. In this case, we can get directly from (2.18)

(2.20)
$$\sigma_{m}(\lambda|1) \geq \theta(-\lambda_{n})\sigma_{m-1}(\lambda|1n)$$

$$\geq \theta\varepsilon\delta\frac{m}{n-1}\sigma_{m}(\lambda)$$

$$= \frac{\varepsilon^{2}\delta^{2}m}{2(n-2)(n-1)}\sigma_{m}(\lambda) \geq \frac{\varepsilon^{2}\delta^{2}}{2(n-2)(n-1)}\sigma_{m}(\lambda).$$

♦ Case 2: $\sigma_m(\lambda|1) < \theta(-\lambda_n)\sigma_{m-1}(\lambda|1n)$. In this case, we have

$$(m+1)\sigma_{m+1}(\lambda|1) = \sum_{i=2}^{n} \lambda_{i}\sigma_{m}(\lambda|1i) = \sum_{i=2}^{n} \lambda_{i}[\sigma_{m}(\lambda|1) - \lambda_{i}\sigma_{m-1}(\lambda|1i)]$$

$$= \sum_{i=2}^{n} \lambda_{i}\sigma_{m}(\lambda|1) - \sum_{i=2}^{n} \lambda_{i}^{2}\sigma_{m-1}(\lambda|1i)$$

$$\leq \sum_{i=2}^{n} \lambda_{i}\sigma_{m}(\lambda|1) - \lambda_{n}^{2}\sigma_{m-1}(\lambda|1n)$$

$$\leq (n-2)\lambda_{2}\sigma_{m}(\lambda|1) - \lambda_{n}^{2}\sigma_{m-1}(\lambda|1n)$$

$$< \frac{(n-2)}{\delta}\lambda_{1}\theta(-\lambda_{n})\sigma_{m-1}(\lambda|1n) + \varepsilon\lambda_{n}\lambda_{1}\sigma_{m-1}(\lambda|1n)$$

$$= -\frac{\varepsilon}{2}\lambda_{1}(-\lambda_{n})\sigma_{m-1}(\lambda|1n).$$

$$(2.21)$$

From (2.18), we can get

$$(2.22) (m+1)\sigma_{m+1}(\lambda|1) < -\frac{\varepsilon^2 \delta}{2} \frac{m}{n-1} \lambda_1 \sigma_m(\lambda),$$

then

(2.23)
$$\sigma_{m}(\lambda|1) = \frac{\sigma_{m+1}(\lambda) - \sigma_{m+1}(\lambda|1)}{\lambda_{1}} > \frac{-\sigma_{m+1}(\lambda|1)}{\lambda_{1}} > \frac{\varepsilon^{2}\delta}{2(m+1)} \frac{m}{n-1} \sigma_{m}(\lambda) \ge \frac{\varepsilon^{2}\delta}{4(n-1)} \sigma_{m}(\lambda).$$

Hence (2.14) holds.

From (2.9) and the generalized Newton-MacLaurin inequality, we can get

$$\frac{\partial \left[\frac{\sigma_{k}(\lambda)}{\sigma_{l}(\lambda)}\right]}{\partial \lambda_{1}} = \frac{\sigma_{k-1}(\lambda|1)\sigma_{l}(\lambda) - \sigma_{k}(\lambda)\sigma_{l-1}(\lambda|1)}{\sigma_{l}(\lambda)^{2}}$$

$$= \frac{\sigma_{k-1}(\lambda|1)\sigma_{l}(\lambda|1) - \sigma_{k}(\lambda|1)\sigma_{l-1}(\lambda|1)}{\sigma_{l}(\lambda)^{2}}$$

$$\geq \left(1 - \frac{l}{k} \frac{n-k}{n-l}\right) \frac{\sigma_{k-1}(\lambda|1)\sigma_{l}(\lambda|1)}{\sigma_{l}(\lambda)^{2}}$$

$$\geq \frac{n}{k} \frac{k-l}{n-l} c_{0}^{2} \frac{\sigma_{k-1}(\lambda)\sigma_{l}(\lambda)}{\sigma_{l}(\lambda)^{2}}$$

$$\geq \frac{n}{k} \frac{k-l}{n-l} \frac{c_{0}^{2}}{n-k+1} \sum_{i=1}^{n} \frac{\partial \left[\frac{\sigma_{k}(\lambda)}{\sigma_{l}(\lambda)}\right]}{\partial \lambda_{i}}.$$
(2.24)

Remark 2.8. These lemmas play an important role in the establishment of a priori estimates. Precisely, Lemma 2.6 is the key of the gradient estimates in Section 4, including the interior gradient estimate and the near boundary gradient estimate. Lemmas 2.5 and Lemma 2.7 are the keys of the lower and upper estimates of double normal second order derivatives on the boundary in Section 5, respectively.

3. C^0 ESTIMATE

The C^0 estimate is easy. For completeness, we produce a proof here following the idea of Lions-Trudinger-Urbas [16] and Ma-Qiu [17].

Theorem 3.1. Suppose $\Omega \subset \mathbb{R}^n$ is a C^1 bounded domain, $f \in C^0(\overline{\Omega})$ is a positive function, $\varphi \in C^0(\partial \Omega)$ and $u \in C^2(\Omega) \cap C^1(\overline{\Omega})$ is the k-admissible solution of Hessian quotient equation (1.2), then we have

$$\sup_{\Omega} |u| \le M_0,$$

where M_0 depends on n, k, l, $diam(\Omega)$, $\max_{\partial\Omega} |\varphi|$ and $\sup_{\Omega} f$.

Proof. Firstly, since u is subharmonic, the maximum of u is attained at some boundary point $x_0 \in \partial \Omega$. Then we can get

$$(3.2) 0 \le u_{\nu}(x_0) = -u(x_0) + \varphi(x_0).$$

Hence

(3.3)
$$\max_{\Omega} u = u(x_0) \le \varphi(x_0) \le \max_{\partial \Omega} |\varphi|.$$

For a fixed point $x_1 \in \Omega$, and a constant $A = \frac{1}{2} \left[\frac{C_n^l}{C_n^k} \sup_{\Omega} f \right]^{\frac{1}{k-l}}$, we have

$$\frac{\sigma_k(D^2u)}{\sigma_l(D^2u)} = f(x) \le \sup_{\Omega} f = \frac{\sigma_k(D^2(A|x-x_1|^2))}{\sigma_l(D^2(A|x-x_1|^2))}.$$

By the comparison principle, we know $u - A|x - x_1|^2$ attains its minimum at some boundary point $x_2 \in \partial \Omega$. Then

$$0 \ge (u - A|x - x_1|^2)_{\nu}(x_2) = u_{\nu}(x_2) - 2A(x_2 - x_1) \cdot \nu$$

$$= -u(x_2) + \varphi(x_2) - 2A(x_2 - x_1) \cdot \nu$$

$$\ge -u(x_2) - \max_{\partial \Omega} |\varphi| - 2A \operatorname{diam}(\Omega).$$
(3.5)

Hence

$$\min_{\Omega} u \ge \min_{\Omega} (u - A|x - x_1|^2) = u(x_2) - A|x_2 - x_1|^2$$

$$\ge -\max_{\partial\Omega} |\varphi| - 2A\operatorname{diam}(\Omega) - A\operatorname{diam}(\Omega)^2.$$

Here, following the proof of Theorem 3.1, we can easily obtain

Theorem 3.2. Suppose $\Omega \subset \mathbb{R}^n$ is a C^1 bounded domain, $f \in C^0(\overline{\Omega})$ is a positive function, $\varphi \in C^0(\partial\Omega)$ and $u^{\varepsilon} \in C^2(\Omega) \cap C^1(\overline{\Omega})$ is the k-admissible solution of the Hessian quotient equation (1.4) with $\varepsilon \in (0,1)$, then we have

(3.7)
$$\sup_{\Omega} |\varepsilon u^{\varepsilon}| \leq \overline{M_0},$$

where $\overline{M_0}$ depends on $n, k, l, diam(\Omega), \max_{\partial \Omega} |\varphi|$ and $\sup_{\Omega} f$.

4. Global gradient estimate

In this section, we prove the global gradient estimate, involving the interior gradient estimate and the near boundary gradient estimate. To state our theorems, we denote $d(x) = \operatorname{dist}(x, \partial\Omega)$, and $\Omega_{\mu} = \{x \in \Omega | d(x) < \mu\}$ where μ is a small positive universal constant depending only on Ω . In Subsection 4.1, we give the interior gradient estimate in $\Omega \setminus \Omega_{\mu}$, and in Subsection 4.2 we establish the near boundary gradient estimate in Ω_{μ} , following the idea of Ma-Qiu-Xu [18] and Ma-Qiu [17].

4.1. **Interior gradient estimate.** The interior gradient estimate is established in [3] as follows

Theorem 4.1. Suppose $u \in C^3(B_r(0))$ is a k-admissible solution to the Hessian quotient equation

(4.1)
$$\frac{\sigma_k(D^2u)}{\sigma_l(D^2u)} = f(x, u, Du), \quad x \in B_r(0) \subset \mathbb{R}^n,$$

with f(x, u, Du) > 0 in $B_r(0)$ and $f(x, u, p) \in C^1(B_r(0) \times \mathbb{R} \times \mathbb{R}^n)$. Then

$$(4.2) |Du(0)| \le C \left(\frac{{}^{OSC}_{P_r(0)}}{r} + \left[\underset{B_r(0)}{osc} u \right]^{\frac{k-l+1}{2(k-l)}} + \left[\underset{B_r(0)}{osc} u \right]^{\frac{k-l}{2(k-l)+1}} \right),$$

where C is a positive constant depending only on n, k, l and $|D_x f|_{C^0}$, $|D_u f|_{C^0}$, $|D_p f|_{C^0}$.

Hence we can get the interior gradient estimate in $\Omega \setminus \Omega_{\mu}$ directly.

Theorem 4.2. Suppose $\Omega \subset \mathbb{R}^n$ is a bounded domain, $f \in C^1(\overline{\Omega})$ is a positive function and $u \in C^3(\Omega)$ is a k-admissible solution of Hessian quotient equation (1.1), then we have

$$\sup_{\Omega \setminus \Omega_u} |Du| \le M_1,$$

where M_1 depends on n, k, l, μ , $|u|_{C^0}$ and $|D_x f|_{C^0}$.

4.2. Near boundary gradient estimate.

Theorem 4.3. Suppose $\Omega \subset \mathbb{R}^n$ is a C^3 bounded domain, $f \in C^1(\overline{\Omega})$ is a positive function, $\varphi \in C^3(\partial\Omega)$ and $u \in C^3(\Omega) \cap C^2(\overline{\Omega})$ is the k-admissible solution of the Hessian quotient equation (1.2), then we have

$$\sup_{\Omega_{\mu}} |Du| \le \max\{M_1, \widetilde{M}_1\},$$

where M_1 depends on n, k, l, μ , M_0 and $|Df|_{C^0}$, and \widetilde{M}_1 depends on n, k, l, μ , Ω , M_0 , $\sup f$, $|Df|_{C^0}$ and $|\varphi|_{C^3}$.

Proof. The proof follows the idea of Ma-Qiu-Xu [18] and Ma-Qiu [17].

Since Ω is a C^3 domain, it is well known that there exists a small positive universal constant $0 < \mu < \frac{1}{10}$ such that $d(x) \in C^3(\overline{\Omega_{\mu}})$. As in Simon-Spruck [21] or Lieberman [13] (in page 331), we can extend ν by $\nu = -Dd$ in Ω_{μ} and thus ν is a $C^2(\overline{\Omega_{\mu}})$ vector field. As mentioned in the book [13], we also have the following formulas

$$(4.5) |D\nu| + |D^2\nu| \le C_0, in \overline{\Omega_{\mu}},$$

(4.6)
$$\sum_{i=1}^{n} \nu^{i} D_{j} \nu^{i} = 0, \quad \sum_{i=1}^{n} \nu^{i} D_{i} \nu^{j} = 0, \quad |\nu| = 1, \quad \text{in} \quad \overline{\Omega_{\mu}},$$

where C_0 depends only on n and Ω . As in [13], we define

(4.7)
$$c^{ij} = \delta_{ij} - \nu^i \nu^j, \quad \text{in} \quad \overline{\Omega_{\mu}},$$

and for a vector $\zeta \in \mathbb{R}^n$, we write ζ' for the vector with *i*-th component $\sum_{j=1}^n c^{ij} \zeta^j$. Then we have

(4.8)
$$|(Du)'|^2 = \sum_{i,j=1}^n c^{ij} u_i u_j, \quad \text{and} \quad |Du|^2 = |(Du)'|^2 + u_\nu^2.$$

We consider the auxiliary function

(4.9)
$$G(x) = \log |Dw|^2 + h(u) + g(d),$$

where

$$w(x) = (1 - d)u + \varphi(x)d(x),$$

$$h(u) = -\log(1 + M_0 - u),$$

$$g(d) = \alpha_0 d,$$

with $\alpha_0 > 0$ to be determined later. Note that here $\varphi \in C^3(\overline{\Omega})$ is a extension with universal C^3 norms.

It is easy to know G(x) is well-defined in $\overline{\Omega}_{\mu}$. Then we assume that G(x) attains its maximum at a point $x_0 \in \overline{\Omega}_{\mu}$. If we have $|Du|(x_0) \leq 10n[|\varphi|_{C^1(\Omega)} + \sup_{\Omega} |u|]$, then we can get directly

$$\sup_{\Omega_{\mu}} \log |Du|^{2} = \sup_{\Omega_{\mu}} \log \frac{|Dw - dD\varphi + (\varphi - u)Dd|^{2}}{(1 - d)^{2}}$$

$$\leq 2[\sup_{\Omega_{\mu}} \log |Dw|^{2} + (|\varphi|_{C^{1}(\Omega)} + \sup_{\Omega} |u|)^{2}]$$

$$\leq 2[\log |Dw|^{2}(x_{0}) + \sup_{\Omega_{\mu}} |h(u)| + \sup_{\Omega_{\mu}} |g(d)| + (|\varphi|_{C^{1}(\Omega)} + \sup_{\Omega} |u|)^{2}]$$

$$\leq 2[\log |Du|^{2}(x_{0}) + \log(1 + 2M_{0}) + \alpha_{0} + 2(|\varphi|_{C^{1}(\Omega)} + \sup_{\Omega} |u|)^{2}]$$

$$\leq 2[\log(1 + 2M_{0}) + \alpha_{0} + (10n + 2)(|\varphi|_{C^{1}(\Omega)} + \sup_{\Omega} |u|)^{2}].$$

$$(4.10)$$

So (4.4) holds.

Hence, we can assume $|Du|(x_0) > 10n[|\varphi|_{C^1(\Omega)} + \sup_{\Omega} |u|]$ in the following. Then we have

(4.11)
$$\frac{1}{2}|Du|^2 \le |Dw|^2 \le 2|Du|^2,$$

where we used $w_i = (1 - d)u_i + \varphi_i d + (\varphi - u)d_i$. Now we divide into three cases to complete the proof of Theorem 4.3.

lacktriangle CASE I: $x_0 \in \partial \Omega_{\mu} \cap \Omega$.

Then $x_0 \in \Omega \setminus \Omega_{\mu}$, and we can use the interior gradient estimate, that is from Theorem 4.2,

$$(4.14) \qquad \leq C_{1}|Dw|^{2} + 2c^{pq}u_{pi}w_{q}\nu^{i} + C_{2}[|Dw| + |Dw|^{2}],$$

where $C_1 = \sum_{pq} |Dc^{pq}|_{C^0}$ and $C_2 = 2\sum_{pq} |c^{pq}|_{C^0} [2|D\varphi|_{C^0} + (|\varphi|_{C^0} + |u|_{C^0})||D^2d|_{C^0} + 4].$ Also by the Neumann boundary condition, we can get

$$c^{pq}D_p(u_i\nu^i) = c^{pq}D_p[-u+\varphi],$$

SO

$$c^{pq}u_{pi}\nu^i = -c^{pq}u_i\nu^i_{,p} + c^{pq}(-u_p + \varphi_p).$$

Hence

$$\alpha_0 = C_1 + C_2 + C_3 + |u|_{C^0} + |\varphi|_{C^0} + 1,$$

$$(4.18) |Dw| \le C_2 + C_3.$$

So we can prove (4.4) by a calculation similar with (4.10), or x_0 cannot be at the boundary $\partial\Omega$ by a contradiction discussion.

lacktriangle CASE III: $x_0 \in \Omega_{\mu}$.

At x_0 , we have $0 < d < \mu$, and by rotating the coordinate e_1, \dots, e_n , we can assume

$$(4.19) w_1(x_0) = |Dw|(x_0) > 0, \{u_{ij}(x_0)\}_{2 \le i, j \le n} \text{ is diagonal.}$$

In the following, we denote $\widetilde{\lambda} = (\widetilde{\lambda}_2, \dots, \widetilde{\lambda}_n) = (u_{22}(x_0), \dots, u_{nn}(x_0))$, and all the calculations are at x_0 . So from the definition of w, we know $w_i = (1 - d)u_i + [\varphi - u]d_i + \varphi_i d$, and by (4.19) we get

As discussed in Remark 1.4, we need to consider the equation (1.4) to prove Theorem 1.3. It is crucial to establish a global gradient estimate of u^{ε} independent of ε , and we need the strict convexity of Ω . Following the idea of [20], we can easily obtain

Theorem 4.4. Suppose $\Omega \subset \mathbb{R}^n$ is a C^3 strictly convex domain, $f \in C^1(\overline{\Omega})$ is a positive function, $\varphi \in C^3(\partial \Omega)$ and $u^{\varepsilon} \in C^3(\Omega) \cap C^2(\overline{\Omega})$ is the k-admissible solution of Hessian quotient equation (1.4) with $\varepsilon > 0$ sufficiently small, then we have

$$\sup_{\Omega} |Du^{\varepsilon}| \le \overline{M_1},$$

and

(4.37)
$$\sup_{\Omega} |u^{\varepsilon} - \frac{1}{|\Omega|} \int_{\Omega} u^{\varepsilon}| \leq \overline{M_1},$$

where $\overline{M_1}$ depends on $n, k, l, \Omega, |f|_{C^1}$ and $|\varphi|_{C^3}$.

5. Global second derivatives estimate

We now come to the a priori estimates of global second derivatives, and we obtain the following theorem

Theorem 5.1. Suppose that $\Omega \subset \mathbb{R}^n$ is a C^4 convex and strictly (k-1)-convex domain, $f \in C^2(\overline{\Omega})$ is a positive function, $\varphi \in C^3(\partial\Omega)$ and $u \in C^4(\Omega) \cap C^3(\overline{\Omega})$ is the k-admissible solution of Hessian quotient equation (1.2), then we have

$$\sup_{\Omega} |D^2 u| \le M_2,$$

where M_2 depends on n, k, l, Ω , $|u|_{C^1}$, $\inf f$, $|f|_{C^2}$ and $|\varphi|_{C^3}$.

Following the idea of Lions-Trudinger-Urbas [16] and Ma-Qiu [17], we divide the proof of Theorem 5.1 into three steps. In step one, we reduce global second derivatives to double normal second derivatives on boundary, then we prove the lower estimate of double normal second derivatives on the boundary in step two, and at last we prove the upper estimate of double normal second derivatives on the boundary.

5.1. Reduce global second derivatives to double normal second derivatives on the boundary.

Lemma 5.2. Suppose that $\Omega \subset \mathbb{R}^n$ is a C^4 convex domain, $f \in C^2(\overline{\Omega})$ is a positive function, $\varphi \in C^3(\partial \Omega)$ and $u \in C^4(\Omega) \cap C^3(\overline{\Omega})$ is the k-admissible solution of Hessian quotient equation (1.2), then we have

(5.2)
$$\sup_{\Omega} |D^2 u| \le C_9 (1 + \max_{\partial \Omega} |u_{\nu\nu}|),$$

where C_9 depends on n, k, l, Ω , $|u|_{C^1}$, $\inf f$, $|f|_{C^2}$ and $|\varphi|_{C^3}$.

Proof. Since Ω is a C^4 domain, it is well known that there exists a small positive universal constant $0 < \mu < \frac{1}{10}$ such that $d(x) \in C^4(\overline{\Omega_{\mu}})$ and $\nu = -Dd$ on $\partial\Omega$. We define $\widetilde{d} \in C^4(\overline{\Omega})$ such that $\widetilde{d} = d$ in $\overline{\Omega_{\mu}}$ and denote

$$\nu = -D\widetilde{d}, \quad \text{in } \Omega.$$

In fact, ν is a $C^3(\overline{\Omega})$ extension of the outer unit normal vector field on $\partial\Omega$. We assume $0 \in \Omega$, and consider the function

(5.3)
$$v(x,\xi) = u_{\xi\xi} - v'(x,\xi) + K|x|^2 + |Du|^2,$$

where
$$v'(x,\xi) = 2(\xi \cdot \nu)\xi'(D\varphi - Du - u_lD\nu^l) = a^lu_l + b$$
, $\xi' = \xi - (\xi \cdot \nu)\nu$, $a^l = -2(\xi \cdot \nu)(\xi' \cdot D\nu^l) - 2(\xi \cdot \nu)(\xi')^l$, $b = 2(\xi \cdot \nu)(\xi' \cdot D\varphi)$, and

$$K = \left[\frac{C_n^l}{C_n^k}\right]^{\frac{1}{k-l}} \left[|D^2(f^{\frac{1}{k-l}})|_{C^0} + |a^l|_{C^0} |D(f^{\frac{1}{k-l}})|_{C^0} + 2|D(f^{\frac{1}{k-l}})|_{C^0} |Du|_{C^0} \right] + |Da^l|_{C^0}^2 + |D^2a^l|_{C^0} |Du|_{C^0} + |D^2b|_{C^0}.$$

Denote

$$\widetilde{F}(D^2u) = \left[\frac{\sigma_k(D^2u)}{\sigma_l(D^2u)}\right]^{\frac{1}{k-l}}, \text{ and } \widetilde{F}^{ij} = \frac{\partial \widetilde{F}}{\partial u_{ij}}.$$

For any fixed $\xi \in \mathbb{S}^{n-1}$, we have

$$\begin{split} \widetilde{F}^{ij}v_{ij} &= \sum_{ij=1}^{n} \widetilde{F}^{ij}u_{ij\xi\xi} - \sum_{ij=1}^{n} \widetilde{F}^{ij}[a^{l}u_{ijl} + 2D_{i}a^{l}u_{jl} + D_{ij}a^{l}u_{l} + b_{ij}] \\ &+ 2K\sum_{i=1}^{n} \widetilde{F}^{ii} + \sum_{ij=1}^{n} \widetilde{F}^{ij}[2u_{ijk}u_{k} + 2u_{ki}u_{kj}] \\ &= (f^{\frac{1}{k-l}})_{\xi\xi} - \widetilde{F}^{ij,kl}u_{ij\xi\xi} - a^{l}(f^{\frac{1}{k-l}})_{l} - \sum_{ij=1}^{n} \widetilde{F}^{ij}[2D_{i}a^{l}u_{jl} + D_{ij}a^{l}u_{l} + b_{ij}] \\ &+ 2K\sum_{i=1}^{n} \widetilde{F}^{ii} + 2(f^{\frac{1}{k-l}})_{k}u_{k} + 2\sum_{ij=1}^{n} \widetilde{F}^{ij}u_{ki}u_{kj} \\ &\geq (f^{\frac{1}{k-l}})_{\xi\xi} - a^{l}(f^{\frac{1}{k-l}})_{l} - \sum_{ij=1}^{n} \widetilde{F}^{ij}[D_{i}a^{l}D_{j}a^{l} + D_{ij}a^{l}u_{l} + b_{ij}] \\ &+ 2K\sum_{i=1}^{n} \widetilde{F}^{ii} + 2(f^{\frac{1}{k-l}})_{k}u_{k} \\ &\geq (f^{\frac{1}{k-l}})_{\xi\xi} - a^{l}(f^{\frac{1}{k-l}})_{l} - 2|D(f^{\frac{1}{k-l}})||Du| \\ &+ [2K - |Da^{l}|^{2} - |D^{2}a^{l}||Du| - |D^{2}b|]\sum_{i=1}^{n} \widetilde{F}^{ii} \\ &\geq (f^{\frac{1}{k-l}})_{\xi\xi} - a^{l}(f^{\frac{1}{k-l}})_{l} - 2|D(f^{\frac{1}{k-l}})||Du| \\ &+ [2K - |Da^{l}|^{2} - |D^{2}a^{l}||Du| - |D^{2}b|] \cdot [\frac{C_{n}^{l}}{C_{n}^{l}}]^{\frac{1}{k-l}} \\ &> 0, \end{split}$$

where we have used

(5.4)
$$2\sum_{ij=1}^{n} \widetilde{F}^{ij} D_{i} a^{l} u_{jl} \leq \sum_{ij=1}^{n} \widetilde{F}^{ij} u_{ki} u_{kj} + \sum_{ij=1}^{n} \widetilde{F}^{ij} D_{i} a^{l} D_{j} a^{l}.$$

So $\max_{\Omega} v(x,\xi)$ attains at a point on $\partial\Omega$. Hence $\max_{\Omega \times \mathbb{S}^{n-1}} v(x,\xi)$ attains at some point $x_0 \in \partial\Omega$ and some direction $\xi_0 \in \mathbb{S}^{n-1}$.

Case a: ξ_0 is tangential to $\partial\Omega$ at x_0 .

We directly have $\xi_0 \cdot \nu = 0$, $v'(x_0, \xi_0) = 0$, and $u_{\xi_0 \xi_0}(x_0) > 0$. In the following, the calculations are at the point x_0 and $\xi = \xi_0$.

From the boundary condition, we have

$$u_{li}\nu^{l} = [c^{ij} + \nu^{i}\nu^{j}]\nu^{l}u_{lj}$$

$$= c^{ij}[D_{j}(\nu^{l}u_{l}) - D_{j}\nu^{l}u_{l}] + \nu^{i}\nu^{j}\nu^{l}u_{lj}$$

$$= -c^{ij}u_{j} + c^{ij}D_{j}\varphi - c^{ij}u_{l}D_{j}\nu^{l} + \nu^{i}\nu^{j}\nu^{l}u_{lj}.$$
(5.5)

So it follows that

$$u_{lip}\nu^{l} = [c^{pq} + \nu^{p}\nu^{q}]u_{liq}\nu^{l}$$

$$= c^{pq}[D_{q}(u_{li}\nu^{l}) - u_{li}D_{q}\nu^{l}] + \nu^{p}\nu^{q}u_{liq}\nu^{l}$$

$$= c^{pq}D_{q}(-c^{ij}u_{j} + c^{ij}D_{j}\varphi - c^{ij}u_{l}D_{j}\nu^{l} + \nu^{i}\nu^{j}\nu^{l}u_{lj})$$

$$- c^{pq}u_{li}D_{q}\nu^{l} + \nu^{p}\nu^{q}\nu^{l}u_{liq},$$
(5.6)

then we obtain

$$u_{\xi_{0}\xi_{0}\nu} = \sum_{ipl=1}^{n} \xi_{0}^{i} \xi_{0}^{p} u_{lip} \nu^{l}$$

$$= \sum_{ip=1}^{n} \xi_{0}^{i} \xi_{0}^{p} [c^{pq} D_{q} (-c^{ij} u_{j} + c^{ij} D_{j} \varphi - c^{ij} u_{l} D_{j} \nu^{l} + \nu^{i} \nu^{j} \nu^{l} u_{lj})$$

$$- c^{pq} u_{li} D_{q} \nu^{l} + \nu^{p} \nu^{q} \nu^{l} u_{liq}]$$

$$= \sum_{i=1}^{n} \xi_{0}^{i} \xi_{0}^{q} [D_{q} (-c^{ij} u_{j} + c^{ij} D_{j} \varphi - c^{ij} u_{l} D_{j} \nu^{l} + \nu^{i} \nu^{j} \nu^{l} u_{lj}) - u_{li} D_{q} \nu^{l}]$$

$$= - \xi_{0}^{i} \xi_{0}^{q} [c^{ij} u_{jq} - D_{q} c^{ij} u_{j}] + \xi_{0}^{i} \xi_{0}^{q} D_{q} (c^{ij} D_{j} \varphi)$$

$$- \xi_{0}^{i} \xi_{0}^{q} D_{q} (c^{ij} D_{j} \nu^{l}) u_{l} - \xi_{0}^{j} \xi_{0}^{q} u_{lq} D_{j} \nu^{l} + \xi_{0}^{i} \xi_{0}^{q} D_{q} \nu^{i} u_{\nu\nu} - \xi_{0}^{i} \xi_{0}^{q} u_{lq} D_{i} \nu^{l}$$

$$\leq - u_{\xi_{0}\xi_{0}} - 2\xi_{0}^{i} u_{l\xi_{0}} D_{i} \nu^{l} + C_{10} + C_{10} |Du| + C_{10} |u_{\nu\nu}|.$$
(5.7)

We assume $\xi_0 = e_1$, it is easy to get the bound for $u_{1i}(x_0)$ for i > 1 from the maximum of $v(x,\xi)$ in the ξ_0 direction. In fact, we can assume $\xi(t) = \frac{(1,t,0,\cdots,0)}{\sqrt{1+t^2}}$. Then we have

$$0 = \frac{dv(x_0, \xi(t))}{dt}|_{t=0}$$

$$= 2u_{ij}(x_0) \frac{d\xi^i(t)}{dt}|_{t=0} \xi^j(0) - \frac{dv'(x_0, \xi(t))}{dt}|_{t=0}$$

$$= 2u_{12}(x_0) - 2\nu^2(D_1\varphi - u_1 - u_l D_1 \nu^l),$$
(5.8)

SO

$$(5.9) |u_{12}(x_0)| = |\nu^2(D_1\varphi - u_1 - u_lD_1\nu^l)| \le C_{11} + C_{11}|Du|.$$

Similarly, we have for all i > 1,

$$|u_{1i}(x_0)| \le C_{11} + C_{11}|Du|.$$

so by $\{D_i \nu^l\} \geq 0$, we have

$$u_{\xi_0\xi_0\nu} \le -u_{\xi_0\xi_0} - D_1\nu^1 u_{\xi_0\xi_0} + C_{12}(1+|u_{\nu\nu}|)$$

$$\le -u_{\xi_0\xi_0} + C_{12}(1+|u_{\nu\nu}|).$$

On the other hand, we have from the Hopf lemma, and (5.5),

$$0 \leq v_{\nu}(x_{0}, \xi_{0})$$

$$= u_{\xi_{0}\xi_{0}\nu} - a^{l}u_{l\nu} - D_{\nu}a^{l}u_{l} - b_{\nu} + 2K(x \cdot \nu)$$

$$\leq -u_{\xi_{0}\xi_{0}} + C_{12}(1 + |u_{\nu\nu}|) + C_{13}.$$

Then we get

$$(5.13) u_{\xi_0\xi_0}(x_0) \le (C_{12} + C_{13})(1 + |u_{\nu\nu}|),$$

and

$$\max_{\Omega \times \mathbb{S}^{n-1}} |u_{\xi\xi}(x)| \leq (n-1) \max_{\Omega \times \mathbb{S}^{n-1}} u_{\xi\xi}(x)
\leq (n-1) [\max_{\Omega \times \mathbb{S}^{n-1}} v(x,\xi) + C_{14}] = (n-1) [v(x_0,\xi_0) + C_{14}]
\leq (n-1) [u_{\xi_0\xi_0}(x_0) + 2C_{14}]
\leq C_{15}(1 + |u_{\nu\nu}|).$$

Case b: ξ_0 is non-tangential.

We can directly have $\xi_0 \cdot \nu \neq 0$. We can find a tangential vector τ , such that $\xi_0 = \alpha \tau + \beta \nu$, with $\alpha = \xi_0 \cdot \tau \geq 0$, $\beta = \xi_0 \cdot \nu \neq 0$, $\alpha^2 + \beta^2 = 1$ and $\tau \cdot \nu = 0$. Then we have

5.2. Lower estimate of double normal second derivatives on boundary.

Lemma 5.3. Suppose that $\Omega \subset \mathbb{R}^n$ is a C^3 convex and strictly (k-1)-convex domain, $f \in C^2(\overline{\Omega})$ is a positive function, $\varphi \in C^3(\partial\Omega)$ and $u \in C^3(\Omega) \cap C^2(\overline{\Omega})$ is the k-admissible solution of Hessian quotient equation (1.2), then we have

$$\min_{\partial\Omega} u_{\nu\nu} \ge -C_{15},$$

where C_{15} is a positive constants depending on n, k,l, Ω , $|u|_{C^1}$, $\inf f$, $|f|_{C^2}$ and $|\varphi|_{C^3}$.

To prove Lemma 5.3 and Lemma 5.5, we need the following lemma.

Lemma 5.4. Suppose $\Omega \subset \mathbb{R}^n$ is a C^2 convex and strictly (k-1)-convex domain, $f \in C^2(\overline{\Omega})$ is a positive function, and $u \in C^2(\Omega)$ is the k-admissible solution of Hessian quotient equation

$$\frac{\sigma_k(D^2u)}{\sigma_l(D^2u)} = f(x), \quad in \quad \Omega \subset \mathbb{R}^n.$$

Denote
$$F^{ij} = \frac{\partial \frac{\sigma_k(D^2u)}{\sigma_l(D^2u)}}{\partial u_{ij}}$$
, and

(5.20)
$$h(x) = -d(x) + d^{2}(x),$$

where $d(x) = dist(x, \partial\Omega)$ is the distance function of Ω . Then

(5.21)
$$\sum_{ij=1}^{n} F^{ij} h_{ij} \ge c_4 (\sum_{i=1}^{n} F^{ii} + 1), \quad in \ \Omega_{\mu},$$

where $\Omega_{\mu} = \{x \in \Omega : d(x) < \mu\}$ for a small universal constant μ and c_4 is a positive constant depending only on n, k, l, Ω and inf f.

Proof. We know from the classic book [5] section 14.6 that the distance function d is C^4 in $\Omega_{\mu} = \{x \in \Omega : 0 < d(x) < \mu\}$ for some constant $\mu \in (0, \frac{1}{10})$ small depending on Ω . Also it holds

(5.22)
$$|Dd| = 1, \quad \text{in } \overline{\Omega_{\mu}}; \quad -Dd = \nu, \quad \text{on } \partial \Omega_{\mu}.$$

For any $x_0 \in \Omega_{\mu}$, there is a $y_0 \in \partial \Omega$ such that $d(x_0) = |x_0 - y_0|$. In the principal coordinate system (see [5] section 14.6), we have

(5.23)
$$-Dd(x_0) = \nu(y_0) = (0, \dots, 0, 1);$$

(5.24)
$$-D^2 d(x_0) = \operatorname{diag} \left\{ \frac{\kappa_1(y_0)}{1 - \kappa_1(y_0)d(x_0)}, \cdots, \frac{\kappa_{n-1}(y_0)}{1 - \kappa_{n-1}(y_0)d(x_0)}, 0 \right\},$$

where $\kappa_1(y_0), \dots, \kappa_{n-1}(y_0)$ are the principal curvature of $\partial\Omega$ at y_0 . Since Ω is convex and strictly (k-1)-convex, then there exist two positive constants $\kappa_{min} < 1$ and κ_{max} depending only on Ω and μ such that

(5.25)
$$\kappa_{min}\operatorname{diag}\{\underbrace{1,\cdots,1}_{k-1},0,\cdots,0\} \le -D^2d(x_0) \le \kappa_{max}\operatorname{diag}\{1,\cdots,1,0\},$$

in the principal coordinate system. Hence

(5.26)
$$\kappa_{min} \operatorname{diag}\{\underbrace{1, \dots, 1}_{k-1}, 0, \dots, 0, 1\} \le D^2 h(x_0) \le (\kappa_{max} + 1) \operatorname{diag}\{1, \dots, 1, 1\},$$

in the principal coordinate system.

If $D^2u(x_0)$ is diagonal, and denote $\lambda = (\lambda_1, \dots, \lambda_n)$ with $\lambda_i = u_{ii}$. We also assume $\lambda_1 \geq \lambda_2 \geq \dots \geq \lambda_n$. We can easily get

$$F^{ii} = \frac{\sigma_{k-1}(\lambda|i)\sigma_l(\lambda) - \sigma_k(\lambda|i)\sigma_{l-1}(\lambda)}{\sigma_l^2(\lambda)}$$
$$\geq (1 - \frac{l}{k}\frac{n-k}{n-l})\frac{\sigma_{k-1}(\lambda|i)\sigma_l(\lambda|i)}{\sigma_l^2(\lambda)}.$$

Then

$$\sum_{i,j=1}^{n} F^{ij} h_{ij} \ge \left(1 - \frac{l}{k} \frac{n-k}{n-l}\right) \sum_{i=1}^{n} \frac{\sigma_{k-1}(\lambda|i)\sigma_{l}(\lambda|i)}{\sigma_{l}^{2}(\lambda)} h_{ii}$$

$$\ge \kappa_{min} \frac{\sigma_{k-1}(\lambda|k)\sigma_{l}(\lambda|k)}{\sigma_{l}^{2}(\lambda)},$$

From Lin-Trudinger [15], we know $\sigma_{k-1}(\lambda|k) \geq c(n,k)\sigma_{k-1}(\lambda)$ for some positive constant c(n,k) depending only on n and k. So

$$\sum_{i,j=1}^{n} F^{ij} h_{ij} \ge \kappa_{min} \frac{\sigma_{k-1}(\lambda|k)\sigma_{l}(\lambda|k)}{\sigma_{l}^{2}(\lambda)}$$

$$\ge \kappa_{min} c(n,k)c(n,l) \frac{\sigma_{k-1}(\lambda)\sigma_{l}(\lambda)}{\sigma_{l}^{2}(\lambda)}$$

$$\ge c \sum_{i=1}^{n} F^{ii}.$$
(5.27)

Also, we have

$$\sum_{i=1}^{n} F^{ii} = \frac{(n-k+1)\sigma_{k-1}(D^{2}u)\sigma_{l}(D^{2}u) - (n-l+1)\sigma_{k}(D^{2}u)\sigma_{l-1}(D^{2}u)}{\sigma_{l}^{2}(D^{2}u)}$$

$$\geq \frac{k-l}{k}(n-k+1)\frac{\sigma_{k-1}(D^{2}u)}{\sigma_{l}(D^{2}u)}$$

$$\geq c(n,k,l)\left[\frac{\sigma_{k}(D^{2}u)}{\sigma_{l}(D^{2}u)}\right]^{\frac{k-l-1}{k-l}} = c(n,k,l)f^{\frac{k-l-1}{k-l}} \geq c_{5} > 0.$$
(5.28)

Hence from (5.27) and (5.28), we get

$$\sum_{ij=1}^{n} F^{ij} h_{ij} \ge c \sum_{i=1}^{n} F^{ii} \ge \frac{c}{2} \sum_{i=1}^{n} F^{ii} + \frac{c}{2} c_5 \ge c_4 (\sum_{i=1}^{n} F^{ii} + 1), \quad \text{in } \Omega_{\mu}.$$

Now we come to prove Lemma 5.3.

Proof. Firstly, we assume $\min_{\partial\Omega} u_{\nu\nu} < 0$, otherwise there is nothing to prove. Also, if $-\min_{\partial\Omega} u_{\nu\nu} < \max_{\partial\Omega} u_{\nu\nu}$, that is $\max_{\partial\Omega} |u_{\nu\nu}| = \max_{\partial\Omega} u_{\nu\nu}$, we can easily get from Lemma 5.4

$$-\min_{\partial\Omega} u_{\nu\nu} < \max_{\partial\Omega} u_{\nu\nu} \le C_{18}.$$

In the following, we assume $-\min_{\partial\Omega} u_{\nu\nu} \geq \max_{\partial\Omega} u_{\nu\nu}$, that is $\max_{\partial\Omega} |u_{\nu\nu}| = -\min_{\partial\Omega} u_{\nu\nu}$. Denote $M = -\min_{\partial\Omega} u_{\nu\nu} > 0$ and let $z_0 \in \partial\Omega$ such that $\min_{\partial\Omega} u_{\nu\nu} = u_{\nu\nu}(z_0)$.

Motivated by Ma-Qiu [17], we consider the test function

(5.29)
$$P(x) = (1 + \beta d)[Du \cdot (-Dd) + u(x) - \varphi(x)] + (A + \frac{1}{2}M)h(x),$$

where

(5.30)
$$\beta = \max\{\frac{1}{\mu}, 5n(2\kappa_{max} + \frac{1}{n})\frac{C_9}{c_6}\},$$

(5.31)
$$A = \max\{A_1, A_2, \frac{C_{17} + \frac{2(k-l)}{n}f}{c_4}\}.$$

We divide into three cases to prove the result. Without generality, we assume that $i_0 = 1 \in G$, and $u_{22} \ge \cdots \ge u_{nn}$.

lacktriangle CASE I: $u_{nn} \geq 0$. In this case, we have

$$(5.72) \quad (4\kappa_{max} + \frac{2}{n}) \sum_{u_{ii} > 0} F^{ii} u_{ii} = (4\kappa_{max} + \frac{2}{n}) \sum_{i=1}^{n} F^{ii} u_{ii} = (k-l)(4\kappa_{max} + \frac{2}{n}) f.$$

Hence from (5.71) and (5.72)

$$0 \leq \sum_{i=1}^{n} F^{ii} \widetilde{P}_{ii} \leq (4\kappa_{max} + \frac{2}{n}) \sum_{u_{ii}>0} F^{ii} u_{ii} + \left[-(A + \frac{1}{2}M)c_4 + C_{20} \right] (\sum_{i=1}^{n} F^{ii} + 1)$$

$$\leq (k - l)(4\kappa_{max} + \frac{2}{n})f + \left[-(A + \frac{1}{2}M)c_4 + C_{20} \right]$$
(5.73)
$$<0,$$

since $A \ge \frac{(k-l)(4\kappa_{max} + \frac{2}{n})|f|_{C^0} + C_{20}}{c_4} =: A_3$. This is a contradiction. \blacklozenge CASE II: $u_{nn} < 0$ and $-u_{nn} < \frac{c_4}{10(4\kappa_{max} + \frac{2}{n})}u_{11}$.

In this case, we have

$$(4\kappa_{max} + \frac{2}{n}) \sum_{u_{ii}>0} F^{ii} u_{ii} = (8\kappa_{max} + \frac{2}{n})[(k-l)f - \sum_{u_{ii}<0} F^{ii} u_{ii}]$$

$$\leq (4\kappa_{max} + \frac{2}{n})[(k-l)f - u_{nn} \sum_{i=1}^{n} F^{ii}]$$

$$< (4\kappa_{max} + \frac{2}{n})(k-l)f + \frac{c_4}{10}u_{11} \sum_{i=1}^{n} F^{ii}$$

$$\leq (4\kappa_{max} + \frac{2}{n})(k-l)f + \frac{c_4}{10}(\frac{6A}{5} + \frac{M}{2}) \sum_{i=1}^{n} F^{ii}.$$

$$(5.74)$$

Hence from (5.71) and (5.74)

$$0 \leq \sum_{i=1}^{n} F^{ii} \widetilde{P}_{ii} \leq (4\kappa_{max} + \frac{2}{n}) \sum_{u_{ii}>0} F^{ii} u_{ii}$$

$$+ \left[-(A + \frac{1}{2}M)c_4 + C_{20} \right] \left(\sum_{i=1}^{n} F^{ii} + 1 \right)$$

$$< (4\kappa_{max} + \frac{2}{n})(k - l)f + \frac{c_4}{10} \left(\frac{6A}{5} + \frac{M}{2} \right) \sum_{i=1}^{n} F^{ii}$$

$$+ \left[-(A + \frac{1}{2}M)c_4 + C_{20} \right] \left(\sum_{i=1}^{n} F^{ii} + 1 \right)$$

$$< 0,$$

$$(5.75)$$

since $A \ge \max\{\frac{(k-l)(4\kappa_{max}+\frac{2}{n})|f|_{C^0}+C_{20}}{c_4}, \frac{25C_{20}}{3c_4}\} =: A_4$. This is a contradiction. \blacklozenge CASE III: $u_{nn} < 0$ and $-u_{nn} \ge \frac{c_4}{10(4\kappa_{max}+\frac{2}{n})}u_{11}$.

In this case, we have $u_{11} \ge \frac{3A}{5} + \frac{2M}{5}$, and $u_{22} \le C_9(1+M)$. So

$$(5.76) u_{11} \ge \frac{2}{5C_9} u_{22}.$$

Let $\delta = \frac{2}{5C_9}$ and $\varepsilon = \frac{c_4}{10(4\kappa_{max} + \frac{2}{n})}$, (2.15) in Lemma 2.7 holds, that is

(5.77)
$$F^{11} \ge c_1 \sum_{i=1}^{n} F^{ii},$$

where $c_1 = \frac{n}{k} \frac{k-l}{n-l} \frac{c_0^2}{n-k+1}$ and $c_0 = \min\{\frac{\varepsilon^2 \delta^2}{2(n-2)(n-1)}, \frac{\varepsilon^2 \delta}{4(n-1)}\}$. Hence from (5.71) and

$$0 \leq \sum_{i=1}^{n} F^{ii} \widetilde{P}_{ii} \leq -\frac{2\beta}{n} F^{11} u_{11} + (4\kappa_{max} + \frac{2}{n}) \sum_{u_{ii}>0} F^{ii} u_{ii}$$

$$+ \left[-(A + \frac{1}{2}M)c_4 + C_{20} \right] \left(\sum_{i=1}^{n} F^{ii} + 1 \right)$$

$$\leq -\frac{2\beta}{n} c_1 \left(\frac{3A}{5} + \frac{2M}{5} \right) \sum_{i=1}^{n} F^{ii} + (4\kappa_{max} + \frac{2}{n}) C_9 (1+M) \sum_{i=1}^{n} F^{ii}$$

$$(5.78)$$

$$< 0,$$

since $\beta \geq \frac{5n}{2}(2\kappa_{max} + \frac{1}{n})\frac{C_9}{c_1}$. This is a contradiction.

So \widetilde{P} attains its maximum only on $\partial\Omega$. The proof of Lemma 5.5 is complete.

Following above proofs, we can also obtain the estimates of second order derivatives of u^{ε} in (1.4), and the strict convexity of Ω is important in reducing global second derivatives to double normal second derivatives on boundary. So we have

Theorem 5.6. Suppose $\Omega \subset \mathbb{R}^n$ is a C^4 strictly convex domain, $f \in C^2(\overline{\Omega})$ is a positive function, $\varphi \in C^3(\partial\Omega)$ and $u^{\varepsilon} \in C^4(\Omega) \cap C^3(\overline{\Omega})$ is the k-admissible solution of Hessian quotient equation (1.4) with $\varepsilon > 0$ sufficiently small,, then we have

$$\sup_{\Omega} |D^2 u^{\varepsilon}| \le \overline{M_2},$$

where $\overline{M_2}$ depends on $n, k, l, \Omega, \overline{M_1}$, inf $f, |f|_{C^2}$ and $|\varphi|_{C^3}$.

6. Existence of the boundary problems

In this section we complete the proof of the Theorem 1.1 and Theorem 1.3.

6.1. **Proof of Theorem 1.1.** For the Neumann problem of Hessian quotient equations (1.2), we have established the C^0 , C^1 and C^2 estimates in Section 3, Section 4, Section 5, respectively. By the global C^2 a priori estimates, Hessian quotient equations (1.2) is uniformly elliptic in $\overline{\Omega}$. Due to the concavity of Hessian quotient operator $\left[\frac{\sigma_k(\lambda)}{\sigma_l(\lambda)}\right]^{\frac{1}{k-l}}$ in Γ_k , we can get the global Hölder estimates of second derivative following the discussions in [14], that is, we can get

$$(6.1) |u|_{C^{2,\alpha}(\overline{\Omega})} \le C,$$

where C and α depend on n, k, l, Ω , inf f, $|f|_{C^2}$ and $|\varphi|_{C^3}$. From (6.1) one also obtains $C^{3,\alpha}(\overline{\Omega})$ estimates by differentiating the equation (1.2) and apply the Schauder theory for linear, uniformly elliptic equations.

Applying the method of continuity (see [5], Theorem 17.28), the existence of the classical solution holds. By the standard regularity theory of uniformly elliptic partial differential equations, we can obtain the higher regularity.

6.2. **Proof of Theorem 1.3.** The proof is following the idea of Qiu-Xia [20].

By a similar proof of Theorem 1.1, we know there exists a unique k-admissible solution $u^{\varepsilon} \in C^{3,\alpha}(\overline{\Omega})$ to (1.4) for any small $\varepsilon > 0$. Let $v^{\varepsilon} = u^{\varepsilon} - \frac{1}{|\Omega|} \int_{\Omega} u^{\varepsilon}$, and it is easy to know v^{ε} satisfies

(6.2)
$$\begin{cases} \frac{\sigma_k(D^2v^{\varepsilon})}{\sigma_l(D^2v^{\varepsilon})} = f(x), & \text{in } \Omega, \\ (v^{\varepsilon})_{\nu} = -\varepsilon v^{\varepsilon} - \frac{1}{|\Omega|} \int_{\Omega} \varepsilon u^{\varepsilon} + \varphi(x), & \text{on } \partial\Omega. \end{cases}$$

By the global gradient estimate (4.36), it is easy to know $\varepsilon \sup |Du^{\varepsilon}| \to 0$. Hence there is a constant c and a function $v \in C^2(\overline{\Omega})$, such that $-\varepsilon u^{\varepsilon} \to c$, $-\varepsilon v^{\varepsilon} \to 0$,

 $\frac{1}{|\Omega|} \int_{\Omega} \varepsilon u^{\varepsilon} \to c$ and $v^{\varepsilon} \to v$ uniformly in $C^{2}(\overline{\Omega})$ as $\varepsilon \to 0$. It is easy to verify that v is a solution of

(6.3)
$$\begin{cases} \frac{\sigma_k(D^2v)}{\sigma_l(D^2v)} = f(x), & \text{in } \Omega, \\ v_{\nu} = c + \varphi(x), & \text{on } \partial\Omega. \end{cases}$$

If there is another function $v_1 \in C^2(\overline{\Omega})$ and another constant c_1 such that

(6.4)
$$\begin{cases} \frac{\sigma_k(D^2v_1)}{\sigma_l(D^2v_1)} = f(x), & \text{in } \Omega, \\ (v_1)_{\nu} = c_1 + \varphi(x), & \text{on } \partial\Omega. \end{cases}$$

Applying the maximum principle and Hopf Lemma, we can know $c = c_1$ and $v - v_1$ is a constant. By the standard regularity theory of uniformly elliptic partial differential equations, we can obtain the higher regularity.
