# LINEAR PULLBACK COMPONENTS OF THE SPACE OF CODIMENSION ONE FOLIATIONS 

V. FERRER AND I. VAINSENCHER


#### Abstract

The space of holomorphic foliations of codimension one and degree $d \geq 2$ in $\mathbb{P}^{n}(n \geq 3)$ has an irreducible component whose general element can be written as a pullback $F^{*} \mathcal{F}$, where $\mathcal{F}$ is a general foliation of degree $d$ in $\mathbb{P}^{2}$ and $F: \mathbb{P}^{n} \longrightarrow \mathbb{P}^{2}$ is a general rational linear map. We give a polynomial formula for the degrees of such components.


## Introduction

Codimension one holomorphic foliations in $\mathbb{P}^{n}$ are defined by nonzero integrable twisted 1 -forms, i.e., $\omega \in H^{0}\left(\mathbb{P}^{n}, \Omega_{\mathbb{P}^{n}}(d+2)\right)$ satisfying

$$
\begin{equation*}
\omega \wedge d \omega=0 \tag{1}
\end{equation*}
$$

Since $\omega, \lambda \omega$ yield the same foliation for any $\lambda \in \mathbb{C}^{*}$, the space of such foliations is in fact a closed subscheme $\mathbb{F}(d, n)$ of the projective space $\mathbb{P}\left(H^{0}\left(\mathbb{P}^{n}, \Omega_{\mathbb{P}^{n}}(d+2)\right)\right)$ defined by the equations derived from (1).

Explicitly, these equations are as follows. Any element $\omega$ of $H^{0}\left(\mathbb{P}^{n}, \Omega_{\mathbb{P}^{n}}(d+2)\right)$ can be written $\omega=A_{0} d Z_{0}+\cdots+A_{n} d Z_{n}$, where $A_{i}$ are homogeneous polynomials of degree $d+1$ in the variables $Z_{0}, \ldots, Z_{n}$, such that $A_{0} Z_{0}+\cdots+A_{n} Z_{n}=0$. The integrability condition (1) imposes relations arising from

$$
A_{i}\left(\frac{\partial A_{k}}{\partial Z_{j}}-\frac{\partial A_{j}}{\partial Z_{k}}\right)+A_{j}\left(\frac{\partial A_{i}}{\partial Z_{k}}-\frac{\partial A_{k}}{\partial Z_{i}}\right)+A_{k}\left(\frac{\partial A_{j}}{\partial Z_{i}}-\frac{\partial A_{i}}{\partial Z_{j}}\right)=0 .
$$

with $0 \leq i<j<k \leq n$. These equations are quadratic in the coefficients of the polynomials $A_{i}$. For $n=2$ the space of foliations is a projective space: the integrability condition is automatically satisfied.

The geometry of the space of codimension one foliations in $\mathbb{P}^{n}$ for $n \geq 3$ is a rich field of research. In particular the problem of describing the irreducible components of these spaces has received many contributions, cf. [2], [4], [5], [12] and references therein just to quote a few.

In [11] Jouanolou describes the irreducible components for the space of foliations of degrees $d=0,1$. We have that $\mathbb{F}(0, n)$ is naturally isomorphic to the grassmannian of subspaces of codimenion 2 in $\mathbb{P}^{n}$. The space of foliations of degree $d=1$ has two irreducible components.

For foliations of degree 2 in $\mathbb{P}^{n}, n \geq 3$ Cerveau and Lins Neto [2] have shown that there are just 6 components. We recall some known components of $\mathbb{F}(d, n)$ pinpointing those for which the degree has been found.

[^0](1) Logarithmic components. Let $F_{1}, \ldots, F_{m}$ denote homogeneous polynomials in $\mathbb{C}^{n+1}, m \geq 3$. Set $d_{i}=\operatorname{deg}\left(F_{i}\right)$, and let $\lambda_{1}, \ldots, \lambda_{m} \in \mathbb{C}^{*}$ be such that $\sum_{i} \lambda_{i} d_{i}=0$. Then the form $\omega=F_{1} \ldots F_{m} \sum \lambda_{i} \frac{d F_{i}}{F_{i}}$ is an integrable 1-form in $\mathbb{P}^{n}$. The foliation induced by $\omega$ is called a logarithmic foliation. Suppose that $F_{1}, \ldots, F_{m}$ are irreducible and relatively prime. The space of this type of foliations is denoted by $\mathcal{L}\left(d_{1}, \ldots, d_{m}\right)$. Its closure $\overline{\mathcal{L}\left(d_{1}, \ldots, d_{m}\right)}$ is an irreducible component of $\mathbb{F}(d, n)$, where $d=d_{1}+\cdots+d_{m}-2$, cf. [1]. In the case $d=2$ we have two possibilities: $\overline{\mathcal{L}(1,1,1,1)}$ and $\overline{\mathcal{L}(1,1,2)}$. Their degrees have not been found to the best of our knowledge.
(2) Rational components. Let $F, G$ be homogeneous polynomials such that

- $\operatorname{deg}(F)=l, \operatorname{deg}(G)=m, m+l-2=d$;
- $d F \wedge d G \neq 0$ along $\{F=G=0\} \backslash\{0\}$ and
- the hypersurface $\{F=0\} \subset \mathbb{P}^{n}$ is smooth.

Then $\omega=m G d F-l F d G$ defines a foliation in $\mathbb{P}^{n}$ of degree $d$. Denote by $R(l, m)$ the set of foliations of this type. The closure $\overline{R(l, m)}$ is an irreducible component of $\mathbb{F}(d, n)$, cf. Gómez-Mont and Lins Neto [8]. Observe that for $d=2$ we have two possibilities: $l=m=2$ or $l=1, m=3$. In this way we obtain two more components of $\mathbb{F}(2, n): \overline{R(2,2)}$ and $\overline{R(1,3)}$. The degrees of these components were computed in Cukierman-PereiraVainsencher [5].
(3) The exceptional component $\mathcal{E}$ of $\mathbb{F}(2,3)$. Here the leaves of a typical foliation are the orbits of a linear action of the affine group in one variable in $\mathbb{P}^{3}$. It is shown in [2] that for $n>3$, in addition to the components described above there exists a component $\mathcal{E}_{n}$ obtained by linear pullback $\mathbb{P}^{n} \longrightarrow \mathbb{P}^{3}$ of foliations in $\mathcal{E}$. The degree of $\mathcal{E}$ has been found in [14].
(4) Pullback components. Let $\mathcal{F}$ be a foliation of degree $k$ in $\mathbb{P}^{2}$, defined by a 1 -form $\omega$, and $F: \mathbb{P}^{n} \rightarrow \mathbb{P}^{2}$ a dominant rational map of degree $m$. Then the 1 -form $F^{*} \omega$ defines a foliation $\mathcal{F}^{*}$ of degree $d=(k+2) m-2$ in $\mathbb{P}^{n}$. In [3] Cerveau, Lins Neto and Edixhoven prove that for $n \geq 3$ the closure of the set of foliations obtained by such $F^{*} \omega$ form an irreducible component $P B(m, k, n)$ of $\mathbb{F}((k+2) m-2, n)$.

Our goal in this work is to compute the degrees and dimensions of the linear pullback components, $L P B(d, n):=P B(1, d, n)$. Note that for $d=$ $(k+2) m-2 \leq 6$ the only pullback components in $\mathbb{F}(d, n)$ are linear or quadratic. For $d=7$ there exists a component of cubic pullbacks. For $d=8,9$ the only pullback components in $\mathbb{F}(d, n)$ are linear or quadratic. If $d+2$ is prime, then the only pullback component of $\mathbb{F}(d, n)$ is linear pullback. Our main result is a polynomial formula for $\operatorname{deg} \operatorname{LPB}(d, n)$, see 3.5.

## 1. Pull-back of projective 1-Forms.

1.1. Projective 1-forms. The main reference for this material is [11]. A projective 1-form of degree $d$ in $\mathbb{P}^{n}$ is a global section of $\Omega_{\mathbb{P}^{n}}^{1}(d+2)$, for some $d \geq 0$.

We denote by $S_{d}$ the space $H^{0}\left(\mathbb{P}^{n}, \mathcal{O}_{\mathbb{P}^{n}}(d)\right)=\operatorname{Sym}_{d}\left(\mathbb{C}^{n+1}\right)^{\vee}$ of homogeneous polynomials of degree $d$ in the variables $Z_{0}, \ldots, Z_{n}$. We write $\partial_{i}=\partial / \partial Z_{i}$ thought of as a vector field basis for $\mathbb{C}^{n+1}$. The dual basis will also be written as $d Z_{0}, \ldots, d Z_{n}$
whenever we think of differential forms. Twisting the Euler exact sequence (cf. [10, Thm 8.13, p. 176]): we get

0 \rightarrow \Omega_{\mathbb{P}^{n}}^{1}(d+2) \rightarrow \mathcal{O}_{\mathbb{P}^{n}}(d+1) \otimes S_{1} \rightarrow \mathcal{O}_{\mathbb{P}^{n}}(d+2) \rightarrow 0
$$

Taking global sections we find the exact sequence

$$
\begin{equation*}
0 \rightarrow V_{d}^{n}:=H^{0}\left(\mathbb{P}^{n}, \Omega_{\mathbb{P}^{n}}^{1}(d+2)\right) \longrightarrow S_{d+1} \otimes S_{1} \xrightarrow{\iota_{R_{n}}} S_{d+2} \rightarrow 0 \tag{2}
\end{equation*}
$$

where $\iota_{R_{n}}\left(\sum A_{i} d Z_{i}\right)=\sum A_{i} Z_{i}$ is the contraction by the radial vector field. Thus a 1-form $\omega \in V_{d}^{n}$ can be written in homogeneous coordinates as

$$
\omega=A_{0} d Z_{0}+\cdots+A_{n} d Z_{n}
$$

where the $A_{i}$ 's are homogeneous polynomials of degree $d+1$ satisfying

$$
A_{0} Z_{0}+\cdots+A_{n} Z_{n}=0
$$

1.2. Linear Pullback. Let $F: \mathbb{P}^{n} \rightarrow \mathbb{P}^{2}$ be a linear projection, i.e., $F=$ [ $F_{0}: F_{1}: F_{2}$ ], with $F_{i}$ linearly independent homogeneous polynomials of degree 1. Pick $\omega \in H^{0}\left(\mathbb{P}^{2}, \Omega_{\mathbb{P}^{2}}^{1}(d+2)\right)$. Write $\omega=B_{0} d X_{0}+B_{1} d X_{1}+B_{2} d X_{2}$ where $B_{i} \in S_{d+1}\left(X_{0}, X_{1}, X_{2}\right)$. The pullback $F^{*}(\omega)$ is the 1-form

$$
\begin{equation*}
F^{*}(\omega)=F^{*} B_{0} d F_{0}+F^{*} B_{1} d F_{1}+F^{*} B_{2} d F_{2} . \tag{3}
\end{equation*}
$$

A simple application of Euler relation shows that $\iota_{R_{n}}\left(F^{*}(\omega)\right)=F^{*}\left(\iota_{R_{2}}(w)\right)=0$. On the other hand, as any projective 1-form in $\mathbb{P}^{2}$ is integrable we have $0=F^{*}(\omega \wedge$ $d \omega)=F^{*}(\omega) \wedge d F^{*}(\omega)$ i.e., $F^{*}(\omega)$ is a projective integrable 1-form of degree $d$,

$$
F^{*}(\omega) \in H^{0}\left(\mathbb{P}^{n}, \Omega_{\mathbb{P}^{n}}^{1}((d+2))\right)
$$

1.3. Remark. For a fixed map $F$ as above we obtain injective linear maps

$$
\begin{aligned}
H^{0}\left(\mathbb{P}^{2}, \Omega_{\mathbb{P}^{2}}^{1}(d+2)\right) & \longrightarrow H^{0}\left(\mathbb{P}^{n}, \Omega_{\mathbb{P}^{n}}^{1}(d+2)\right), \\
\mathbb{F}(d, 2) & \longrightarrow \mathbb{F}(d, n)
\end{aligned}
$$

1.4. Parameter space for rational maps. Let $F=\left[F_{0}: F_{1}: F_{2}\right]$ be a rational map as above, with $F_{i} \in S_{1}$. Note that if we change the basis of the linear system $\left\langle F_{0}, F_{1}, F_{2}\right\rangle$ then we obtain projectively equivalent pullbacks. So the natural parameter space for rational linear maps is the Grassmannian of dimension 3 subspaces of the space $S_{1}$ of forms of degree 1,

$$
\begin{equation*}
\mathbb{G}:=\mathbb{G}\left(3, S_{1}\right) . \tag{4}
\end{equation*}
$$

## 2. Linear Pullback component

We show next that the locus in $\mathbb{P}\left(V_{d}^{n}\right)$ (cf. 2) corresponding to codimension one foliations obtained by linear pullbacks of foliations in $\mathbb{P}^{2}$ is the birational image of a natural projective bundle over the Grassmannian $\mathbb{G}\left(3, S_{1}\right)$.
2.1. Proposition. Notation as in (2) and (4), let

$$
\mathcal{V}_{d}:=\left\{(F, \mu) \in \mathbb{G} \times V_{d}^{n} \mid \mu=F^{\star} \omega \text { for some } \omega \in V_{d}^{2}\right\}
$$

Then
(i) $\mathcal{V}_{d}$ is a vector subbundle of $\mathbb{G} \times V_{d}^{n}$ of $\operatorname{rank}(d+1)(d+3)$.

Let $q_{2}: \mathbb{P}\left(\mathcal{V}_{d}\right) \subset \mathbb{G} \times \mathbb{P}\left(V_{d}^{n}\right) \rightarrow \mathbb{P}\left(V_{d}^{n}\right)$ be the projection and set

$$
\mathbb{Y}:=q_{2}\left(\mathbb{P}\left(\mathcal{V}_{d}\right)\right), g:=\operatorname{dim} \mathbb{G}=3(n-2)
$$

Then
(ii) the dimension of $\mathbb{Y}$ is $g+(d+1)(d+3)-1$ and
(iii) the degree of $\mathbb{Y}$ is given by the Segre class $s_{g}\left(\mathcal{V}_{d}\right)$.

Proof. Consider the tautological exact sequence of vector bundles over $\mathbb{G}$, (cf. 4)

\begin{equation*}
0 \rightarrow \mathcal{T} \rightarrow \mathbb{G} \times S_{1} \rightarrow \mathcal{Q} \rightarrow 0 \tag{5}
\end{equation*}
$$

where $\mathcal{T}$ is of rank 3 with fiber $\mathcal{T}_{F}=\left\langle F_{0}, F_{1}, F_{2}\right\rangle, F_{i} \in S_{1}$. We obtain a natural rational map,


We interpret the map $\bar{F}$ as the family of $F$ 's as in 1.2 and $\mathbb{P}\left(\mathcal{T}^{\vee}\right)$ as the family of $\mathbb{P}^{2}$ 's obtained as the fibers of $\psi$. The relative cotangent bundle of $\psi$ fits into the relative Euler exact sequence (cf. [6, B.5.8, p. 435]):

$$
0 \rightarrow \Omega_{\psi}(1) \rightarrow \psi^{*} \mathcal{T} \rightarrow \mathcal{O}_{\mathcal{T} \vee}(1) \rightarrow 0
$$

Twisting by $\mathcal{O}_{\mathcal{T} \vee}(d+1)$ we find

$$
0 \rightarrow \Omega_{\psi}(d+2) \rightarrow \psi^{*} \mathcal{T}(d+1) \rightarrow \mathcal{O}_{\mathcal{T} \vee}(d+2) \rightarrow 0
$$

Taking direct image yields the following exact sequence over $\mathbb{G}$

$$
\begin{equation*}
0 \rightarrow \psi_{*} \Omega_{\psi}(d+2) \rightarrow \operatorname{Sym}_{d+1} \mathcal{T} \otimes \mathcal{T} \rightarrow \operatorname{Sym}_{d+2}(\mathcal{T}) \rightarrow 0 \tag{6}
\end{equation*}
$$

Define

$$
\begin{equation*}
\mathcal{V}_{d}:=\psi_{*} \Omega_{\psi}(d+2) \tag{7}
\end{equation*}
$$

The fiber of $\mathcal{V}_{d}$ over each $F \in \mathbb{G}$, is

$$
H^{0}\left(\mathbb{P}\left(\mathcal{T}_{F}^{\vee}\right), \Omega_{\mathbb{P}\left(\mathcal{T}_{F}^{\vee}\right)}(d+2)\right)
$$

i.e., the space of 1 -forms defining foliations of degree $d$ in the varying $\mathbb{P}^{2} \simeq \mathbb{P}\left(\mathcal{T}_{F}^{\vee}\right)$.

On the other hand, we obtain from (5) injective maps of vector bundles over $\mathbb{G}$,

$$
\iota_{1}: \operatorname{Sym}_{d+1} \mathcal{T} \otimes \mathcal{T} \longrightarrow S_{d+1} \otimes S_{1}
$$

and

$$
\iota_{2}: \operatorname{Sym}_{d+2} \mathcal{T} \longrightarrow S_{d+2}
$$

These two maps fit into the following diagram of exact sequences


In this way we obtain an injective map of vector bundles over $\mathbb{G}$,

$$
\begin{equation*}
j: \mathcal{V}_{d} \longrightarrow \mathbb{G} \times V_{d}^{n} \tag{8}
\end{equation*}
$$

The vector subbundle $\mathcal{V}_{d} \subset \mathbb{G} \times V_{d}^{n}$ is as stated in (i).

Let $q_{1}: \mathbb{P}\left(\mathcal{V}_{d}\right) \rightarrow \mathbb{G}$ and $q_{2}: \mathbb{P}\left(\mathcal{V}_{d}\right) \rightarrow \mathbb{P}\left(V_{d}^{n}\right)$ be the maps induced by projection:


We prove in Lemma 2.3 below that $q_{2}: \mathbb{P}\left(\mathcal{V}_{d}\right) \rightarrow \mathbb{P}\left(V_{d}^{n}\right)$ is generically injective. Set $u:=\operatorname{dim} \mathbb{Y}=\operatorname{dim} \mathbb{P}\left(\mathcal{V}_{d}\right)$. Write $H$ for the hyperplane class of $\mathbb{P}\left(V_{d}^{n}\right)$. We have $q_{2}^{*} H=c_{1} \mathcal{O}_{\mathcal{V}_{d}}(1)=: h$. Using [6, §3.1, p. 47, Prop.4.4, p. 83 and Ex. 8.3.14, p. 143], we may compute

$$
\operatorname{deg} \mathbb{Y}=\int_{\mathbb{P}\left(V_{d}^{n}\right)} H^{u} \cap \mathbb{Y}=\int_{\mathbb{P}\left(\mathcal{V}_{d}\right)} h^{u}=\int_{\mathbb{G}} q_{1 *}\left(h^{u}\right)=\int_{\mathbb{G}} s_{g}\left(\mathcal{V}_{d}\right)
$$

2.2. Remark From sequence (6) we obtain $s\left(\mathcal{V}_{d}\right)=s\left(\operatorname{Sym}_{d+1} \mathcal{T} \otimes \mathcal{T}\right) c\left(\operatorname{Sym}_{d+2}(\mathcal{T})\right)$.
2.3. Lemma. For general $(F, \omega) \in \mathbb{G} \times H^{0}\left(\mathbb{P}^{2}, \Omega_{\mathbb{P}^{2}}^{1}(d+2)\right)$, $F^{*}(\omega)$ determines uniquely $\omega$ and $F$.

Proof. With notation as in 1.2 , let $I(F)=Z\left(F_{0}, F_{1}, F_{2}\right) \subset \mathbb{P}^{n}$ denote the indeterminacy locus of $F$. For generic $(F, \omega)$, the singular set of $F^{*}(\omega)$ consists of linear components of codimension two of the form $F^{-1}(q)$ where $q \in \operatorname{Sing}(\omega)$. These linear components intersect in $I(F)$. Indeed, we can suppose $q_{1}=[0: 0: 1]$ and $q_{2}=[0: 1: 0]$, so $F^{-1}\left(q_{1}\right)=Z\left(F_{0}, F_{1}\right)$ and $F^{-1}\left(q_{2}\right)=Z\left(F_{0}, F_{2}\right)$. From $I(F)$ we retrieve the linear system $\left\langle F_{0}, F_{1}, F_{2}\right\rangle$ i.e., the point $F \in \mathbb{G}$.

On the other hand, consider the blow-up $\pi: \mathbb{B} \longrightarrow \mathbb{P}^{n}$ of $\mathbb{P}^{n}$ in $I(F)$. We proceed to show that it is possible to recover the 1-form $\omega$ from the strict transform $\tilde{\omega}$ of $F^{*}(\omega)$. Indeed, recall $\mathbb{B}=\left\{\left(p,\left[x_{0}: x_{1}: x_{2}\right]\right) \in \mathbb{P}^{n} \times \mathbb{P}^{2} \mid x_{i} F_{j}(p)-x_{j} F_{i}(p)=\right.$ $0\}$. Therefore over $U:=\left\{x_{0} \neq 0\right\}$ we have $\mathbb{B}_{\mid U}=\left\{(p,[1: t: s]) \mid F_{1}(p)=\right.$ $\left.t F_{0}(p) ; F_{2}(p)=s F_{0}(p)\right\}$ and the equation of the exceptional divisor is $F_{0}=0$. In this chart we have $d F_{1}=F_{0} d t+t d F_{0}, d F_{2}=F_{0} d s+s d F_{0}$, therefore

$$
\begin{gathered}
\pi^{*} F^{*}(\omega)=B_{0}\left(F_{0}, t F_{0}, s F_{0}\right) d F_{0}+B_{1}\left(F_{0}, t F_{0}, s F_{0}\right) d F_{1}+B_{2}\left(F_{0}, t F_{0}, s F_{0}\right) d F_{2}= \\
F_{0}^{d+1}\left[B_{0}(1, t, s) d F_{0}+B_{1}(1, t, s)\left(F_{0} d t+t d F_{0}\right)+B_{2}(1, t, s)\left(F_{0} d s+s d F_{0}\right)\right]= \\
F_{0}^{d+1}\left[\left(B_{0}(1, t, s)+t B_{1}(1, t, s)+s B_{2}(1, t, s)\right) d F_{0}+B_{1}(1, t, s) F_{0} d t+B_{2}(1, t, s) F_{0} d s\right]
\end{gathered}
$$

Recalling $\omega$ is a projective 1-form, so $B_{0}(1, t, s)+t B_{1}(1, t, s)+s B_{2}(1, t, s)=0$, we obtain

$$
\pi^{*} F^{*}(\omega)=F_{0}^{d+2}\left[B_{1}(1, t, s) d t+B_{2}(1, t, s) d s\right]
$$

Therefore the strict transform of $F^{*} \omega$ is $\tilde{\omega}=B_{1}(1, t, s) d t+B_{2}(1, t, s) d s$. Ditto for the other local charts of the blowup. This shows that we may recover $\omega$ from $\tilde{\omega}$.
2.4. Corollary. The component $\operatorname{LPB}(d, n) \subset \mathbb{F}(d, n)$ is rational.

## 3. Computation of the degree of $L P B(d, n)$

3.1. Proposition. Notation as in 2.1, $\operatorname{deg}(\operatorname{LPB}(d, n))$ is a polynomial in $d$ of degree $3 g=9(n-2)$.

We need some preliminary results.
3.2. Lemma. Let $E$ be a vector bundle of rank $r$ on a variety $X$. The $k$-Segre class

$$
s_{k}\left(\operatorname{Sym}_{d}(E)\right)=\sum_{|\lambda|=k} p_{\lambda}(d) c_{\lambda}(E)
$$

where $p_{\lambda}(d)$ is a polynomial in $d$ of degree $\leq r k$, and there exists $p_{\lambda}$ of degree $r k$. Here the sum runs over the partitions of $k$, and if $\lambda=\left(\lambda_{1}, \ldots, \lambda_{l}\right)$ is a partition of $k, c_{\lambda}(E):=c_{\lambda_{1}}(E) \cdots c_{\lambda_{l}}(E)$.
Proof. First we prove the following assertion relating the Chern characters to the Segre classes of $\operatorname{Sym}_{d}(E)$.
3.3. Claim $\mathbf{A}(\mathbf{k})$ : Assume the Chern character

$$
c h_{j}\left(\operatorname{Sym}_{d}\left(E^{\vee}\right)\right)=\sum_{|\mu|=j} q_{\mu}(d) c_{\mu}(E)
$$

where $q_{\mu}(d)$ are polynomials in $d$ of degree $\leq r+j-1$ for all $j \geq 0$. Then $s_{k}\left(\operatorname{Sym}_{d}(E)\right)=\sum_{|\lambda|=k} p_{\lambda}(d) c_{\lambda}(E)$ where $p_{\lambda}(d)$ are polynomials in $d$ of degree $\leq r k$. Moreover, if $\operatorname{ch}_{1}\left(\operatorname{Sym}_{d}(E)\right)=q_{1}(d) c_{1}(E)$ and $\operatorname{deg}\left(q_{1}\right)=r$, then $s_{k}\left(\operatorname{Sym}_{d}(E)\right)$ has a coefficient of degree rk.

For a vector bundle $F$ of rank $r$, let $x_{1}, \ldots, x_{r}$ be the Chern roots of $F^{\vee}$. Then for all $k \geq 0$, the Segre class

$$
s_{k}(F)=\sum_{1 \leq i_{1} \leq \cdots \leq i_{k} \leq r} x_{i_{1}} \cdots x_{i_{k}}
$$

is the $k$-complete symmetric function (cf. [7, p. 28]).
On the other hand the complete symmetric functions can be expressed in term of the power sum symmetric functions, $p_{k}=\sum_{i} x_{i}^{k}$. We borrow from ([13, p. 25]) the explicit relations:

$$
\begin{equation*}
s_{k}(F)=\sum_{|\lambda|=k} w_{\lambda} c h_{\lambda}\left(F^{\vee}\right) \tag{9}
\end{equation*}
$$

where $\lambda=\left(\lambda_{1}, \ldots, \lambda_{l}\right)$ is a partition of $k$. Following the notation in [13] we write $\lambda=\left(1^{m_{1}}, 2^{m_{2}}, \ldots\right)$ where $m_{i}:=\#\left\{j \mid \lambda_{j}=i\right\}$ and $w_{\lambda}=\prod_{i \geq 1} \frac{\lambda_{i}!}{i^{m_{i} m_{i}!}}$.

Write for short $c h_{j}=c h_{j}\left(\operatorname{Sym}_{d}\left(E^{\vee}\right)\right)$. Whenever the coefficients of $c h_{j}$ are polynomials in $d$ of degree $m$ we will write $\operatorname{deg}\left(c h_{j}\right)=m$, by abuse of notation. We observe that $\operatorname{deg}\left(c h_{\lambda}\right)=\operatorname{deg}\left(c h_{\lambda_{1}} \cdots c h_{\lambda_{l}}\right) \leq l(r-1)+k \leq r k$ and the equality holds if and only if $l=k$, i.e. if $\lambda=(1, \ldots 1)$ in which case the coefficient of $c h_{1}^{k}$ is $\frac{1}{k!}$. In other words

$$
s_{k}\left(\operatorname{Sym}_{d}(E)\right)=\frac{1}{k!} c h_{1}^{k}+\text { l.o.t }
$$

Hence $s_{k}\left(\operatorname{Sym}_{d}(E)\right)$ is a linear combination of monomials in the Chern classes of $E$ whose coefficients are polynomials in $d$ of degree $\leq r k$.

Next we prove the following claim by induction on $r=\operatorname{rank}(E)$ and on $k$ :
3.4. Claim $\mathbf{P}(\mathbf{k}):$ For $k \geq 0, \operatorname{ch}_{k}\left(\operatorname{Sym}_{d}(E)\right)=\sum_{|\mu|=j} q_{\mu}(d) c_{\mu}(E)$, where $q_{\mu}(d)$ are polynomials in $d$ of degree $\leq r+k-1$. Moreover, $\operatorname{ch}_{1}\left(\operatorname{Sym}_{d}(E)\right)=q_{1}(d) c_{1}(E)$ where $q_{1}(d)$ is a polynomial of degree $r$.

For $r=1$ we have $c h_{k}\left(\operatorname{Sym}_{d}(E)\right)=\frac{1}{k!} d^{k} c_{1}(E)^{k}$.
Suppose that $\mathbf{P}(\mathbf{k})$ is true for vector bundles of rank $r-1$. Let $\pi: E \rightarrow X$ be a vector bundle of $\operatorname{rank}(E)=r$ and $p: \mathbb{P}(E) \rightarrow X$ the induced projective bundle. For $k=0$ we have $c h_{0}\left(\operatorname{Sym}_{d}(E)\right)=\operatorname{rank}\left(\operatorname{Sym}_{d}(E)\right)=\binom{d+r-1}{r-1}$, a polynomial in $d$ of degree $r-1$. Suppose that $k \geq 1$, and that $\mathbf{P}(\mathbf{s})$ holds for $\mathbf{s}<k$.

Over $\mathbb{P}(E)$ we have the tautological exact sequence:

$$
\begin{equation*}
0 \rightarrow \mathcal{O}_{E}(-1) \rightarrow p^{*} E \rightarrow Q \rightarrow 0 \tag{10}
\end{equation*}
$$

It induces the following exact sequence for $d \geq 1$

$$
0 \rightarrow \mathcal{O}_{E}(-1) \otimes \operatorname{Sym}_{d-1}\left(p^{*} E\right) \rightarrow \operatorname{Sym}_{d}\left(p^{*} E\right) \rightarrow \operatorname{Sym}_{d}(Q) \rightarrow 0
$$

Hence we may write the relation for the Chern characters

$$
\begin{equation*}
\operatorname{ch}\left(\operatorname{Sym}_{d}\left(p^{*} E\right)\right)=\operatorname{ch}\left(\mathcal{O}_{E}(-1) \otimes \operatorname{Sym}_{d-1}\left(p^{*} E\right)\right)+\operatorname{ch}\left(\operatorname{Sym}_{d}(Q)\right) \tag{11}
\end{equation*}
$$

On the other hand, $\operatorname{ch}\left(\mathcal{O}_{E}(-1) \otimes \operatorname{Sym}_{d-1}\left(p^{*} E\right)\right)=\operatorname{ch}\left(\mathcal{O}_{E}(-1)\right) \operatorname{ch}\left(\operatorname{Sym}_{d-1}\left(p^{*} E\right)\right.$.
So each graded part satisfies

$$
\begin{equation*}
c h_{k}\left(\mathcal{O}_{E}(-1) \otimes \operatorname{Sym}_{d-1}\left(p^{*} E\right)\right)=\sum_{i=0}^{k} \frac{\alpha^{i}}{i!} c h_{k-i}\left(\operatorname{Sym}_{d-1}\left(p^{*} E\right)\right) \tag{12}
\end{equation*}
$$

where $\alpha:=c_{1}\left(\mathcal{O}_{E}(-1)\right)$. It follows from (11) and (12) that

$$
c h_{k}\left(\operatorname{Sym}_{d}\left(p^{*} E\right)\right)=\sum_{i=0}^{k} \frac{\alpha^{i}}{i!} c h_{k-i}\left(\operatorname{Sym}_{d-1}\left(p^{*} E\right)\right)+c h_{k}\left(\operatorname{Sym}_{d}(Q)\right)
$$

Hence

$$
\begin{array}{r}
c h_{k}\left(\operatorname{Sym}_{d}\left(p^{*} E\right)\right)-c h_{k}\left(\operatorname{Sym}_{d-1}\left(p^{*} E\right)\right)=\sum_{i=1}^{k} \frac{\alpha^{i}}{i!} c h_{k-i}\left(\operatorname{Sym}_{d-1}\left(p^{*} E\right)\right)  \tag{13}\\
+c h_{k}\left(\operatorname{Sym}_{d}(Q)\right) .
\end{array}
$$

Observe that the right hand side of (13) involves:

- $c_{k}\left(\operatorname{Sym}_{d}(Q)\right)$, which by induction, $\operatorname{since} \operatorname{rank}(Q)=r-1$, is of the form $\sum_{|\mu|=k} q_{\mu}(d) c_{\mu}(Q)$ where $q_{\mu}(d)$ are polynomials in $d$ of degree $\leq r-1+$ $k-1=r+k-2$. Moreover, by (10) $c_{s}(Q)=c_{s}\left(p^{*} E\right)-\alpha c_{s-1}\left(p^{*} E\right)$. Thus $c h_{k}\left(\operatorname{Sym}_{d}(Q)\right)$ is a linear combination of monomials in the Chern classes of $p^{*} E$ and in $\alpha$ whose coefficients are polynomials in $d$ of degree $\leq r+k-2$.
- $c h_{s}\left(\operatorname{Sym}_{d-1}\left(p^{*} E\right)\right)$ with $s<k$ which, by induction on $k$ is of the form $\sum_{|\mu|=k} q_{\mu}(d) c_{\mu}\left(p^{*}(E)\right)$ where $q_{\mu}(d)$ are polynomials in $d$ of degree $\leq r+$ $s-1$; the maximal degree appearing is $r+k-2$ (coming from the coefficients in $\left.\alpha c h_{k-1}\left(\operatorname{Sym}_{d-1}\left(p^{*} E\right)\right)\right)$.
Recall that the pullback $p^{*}: A_{*}(X) \rightarrow A_{*}(\mathbb{P}(E))$ is a monomorphism with left inverse $\beta \mapsto p_{*}\left(c_{1}\left(\mathcal{O}_{E}(1)\right)^{r-1} \cap(\beta)\right)([6$, p. 49]). Applying this inverse to (13) we conclude that

$$
c h_{k}\left(\operatorname{Sym}_{d}(E)\right)-c h_{k}\left(\operatorname{Sym}_{d-1}(E)\right)
$$

is a linear combination of monomials in the Chern classes of $E$ whose coefficients are polynomials in $d$ of degree $\leq r+k-2$, and this implies that the coefficients in $c h_{k}\left(\operatorname{Sym}_{d}(E)\right)$ are polynomials in $d$ of degree $\leq r+k-1$.

Observe that for $k=1$ we obtain that $c h_{1}\left(\operatorname{Sym}_{d}(E)\right)-c h_{1}\left(\operatorname{Sym}_{d-1}(E)\right)=$ $\binom{d+r-2}{r-1} c_{1}(E)$, a polynomial of degree $r-1$. So $c h_{1}\left(\operatorname{Sym}_{d}(E)\right)=q_{1}(d) c_{1}(E)$ where $q_{1}(d)$ is polynomial of degree $r$.

Using $\mathbf{A}(\mathbf{k}) 3.3$, we deduce that $s_{k}\left(\operatorname{Sym}_{d}(E)\right)$ is a linear combination of monomials in the Chern classes of $E$ whose coefficients are polynomials in $d$ of degree $\leq \operatorname{rank}(E) k$ and there exists a coefficient of degree $\operatorname{rank}(E) k$.

Next we prove Proposition 3.1.
Proof. From the exact sequence

$$
0 \rightarrow \mathcal{V}_{d} \rightarrow \operatorname{Sym}_{d+1} \mathcal{T} \otimes \mathcal{T} \rightarrow \operatorname{Sym}_{d+2}(\mathcal{T}) \rightarrow 0
$$

we obtain the relation for Chern characters

$$
\operatorname{ch}\left(\mathcal{V}_{d}^{\vee}\right)=\operatorname{ch}\left(\operatorname{Sym}_{d+1} \mathcal{T}^{\vee} \otimes \mathcal{T}^{\vee}\right)-\operatorname{ch}\left(\operatorname{Sym}_{d+2}\left(\mathcal{T}^{\vee}\right)\right)
$$

Thus for each $k \geq 1$ we have

$$
\operatorname{ch} h_{k}\left(\mathcal{V}_{d}^{\vee}\right)=\sum_{i=0}^{k} c h_{k-i}\left(\operatorname{Sym}_{d+1} \mathcal{T}^{\vee}\right) \operatorname{ch}\left(\mathcal{T}^{\vee}\right)-\operatorname{ch} k\left(\operatorname{Sym}_{d+2}\left(\mathcal{T}^{\vee}\right)\right)
$$

By assertion $\mathbf{P}(\mathbf{k})(3.4) c h_{k}\left(\operatorname{Sym}_{d}\left(\mathcal{T}^{\vee}\right)\right)$ is a polynomial in $d$ of degree $\leq k+2$. Therefore $c h_{k}\left(\mathcal{V}_{d}^{\vee}\right)$ is a polynomial in $d$ of degree $\leq k+2$. Moreover,

$$
\operatorname{ch}_{1}\left(\operatorname{Sym}_{d}\left(\mathcal{T}^{\vee}\right)\right)=q_{1}(d) c_{1}\left(\mathcal{T}^{\vee}\right)
$$

where $q_{1}(d)$ is a polynomial of degree 3 . Therefore

$$
\begin{gathered}
c h_{1}\left(\mathcal{V}_{d}^{\vee}\right)=c h_{1}\left(\operatorname{Sym}_{d+1} \mathcal{T}^{\vee}\right) c h_{0}\left(\mathcal{T}^{\vee}\right)+c h_{0}\left(\operatorname{Sym}_{d+1} \mathcal{T}^{\vee}\right) c h_{1}\left(\mathcal{T}^{\vee}\right)-c h_{1}\left(\operatorname{Sym}_{d+2}\left(\mathcal{T}^{\vee}\right)\right)= \\
\left(3 q_{1}(d+1)+\binom{d+3}{2}-q_{1}(d+2)\right) c_{1}\left(\mathcal{T}^{\vee}\right)
\end{gathered}
$$

is a polynomial in $d$ of degree 3 .
As in the proof of assertion $\mathbf{A}(\mathbf{k})$ (3.3), we conclude that $s_{k}\left(\mathcal{V}_{d}\right)$ is polynomial in $d$ of degree $3 k$.
3.5. Some formulas. To get explicit formulas for $s_{g}\left(\mathcal{V}_{d}\right)$ for any fixed $d, n$ we use sequence (6), and Macaulay2, [9]. We find (cf. script $\S 5$ below)
$\operatorname{deg}(L P B(d, 3))=\frac{20}{27}\binom{d+4}{5}\left(d^{2}+6 d+11\right)\left(d^{2}+2 d+3\right)$.
$\operatorname{deg}(L P B(d, 4))=\frac{1}{839808} \frac{(d+4)!}{(d-1)!}\left(8 d^{12}+192 d^{11}+2176 d^{10}+15360 d^{9}+75090 d^{8}+\right.$ $267552 d^{7}+711859 d^{6}+1423716 d^{5}+2119892 d^{4}+2279136 d^{3}+1662291 d^{2}+730188 d+$ 125388) $(2+d)$.

## 4. Higher degree pullback components

As stated in the Introduction, the set of foliations obtained by pullback of foliations in $\mathbb{P}^{2}$ by rational maps of degree $m$ also form an irreducible component $P B(m, k, n)$ of $\mathbb{F}(d, n), d:=(k+2) m-2$.

As in the linear case, a natural parameter space of rational maps $F: \mathbb{P}^{n} \rightarrow \mathbb{P}^{2}$ of degree $m$ is the grassmannian $\mathbb{G}\left(3, S_{m}\right)$. Mimicking 2.1, we can construct a fiber bundle

$$
\mathcal{V}_{m, k}:=\left\{(F, \mu) \in \mathbb{G}\left(3, S_{m}\right) \times V_{k}^{n} \mid \mu=F^{\star} \omega \text { for some } \omega \in V_{k}^{2}\right\}
$$

However, for $m \geq 2$, the $\operatorname{map} j: \mathcal{V}_{m, k} \rightarrow V_{d}^{n}$ (analogous to the map in (8)) is injective only over the open subset consisting of dominant maps. So its image is not a subundle of $V_{d}^{n}$. In fact, for a non-dominant map $F \in \mathbb{G}\left(3, S_{m}\right), j_{F}(\omega)=$ $F^{*}(\omega)=0$ for all $\omega \in H^{0}\left(\mathbb{P}^{2}, \Omega_{\mathbb{P}^{2}}^{1}(k+2)\right)$ defining a foliation that leaves invariant the closure of $\operatorname{Im}(F)$.

We could in principle find the locus $Z \subset \mathbb{G}\left(3, S_{m}\right)$ where the rank of $\operatorname{Im}(j)$ drops and then blow-up $\mathbb{G}\left(3, S_{m}\right)$ along $Z$. Doing this we expect to build a subundle $\widetilde{\mathcal{V}}_{k}$ of $V_{d}^{n}$ over the blow-up that coincides with $\operatorname{Im}(j)$ over the open set of dominant maps. The projection of $\mathbb{P}\left(\widetilde{\mathcal{V}}_{k}\right)$ to $\mathbb{P}\left(V_{d}^{n}\right)$ is the space of foliations obtained as pullback by dominant maps. To make it work, we'd need to know how to get our hands on the Segre classes of $Z$. We hope to report on this elsewhere.

## 5. SCRIPTS

5.1. Scripts for Macaulay2. In order to compute $\operatorname{deg}(L P B(d, n))$ for any given value of $n \geq 3$, just set $N=n$ at the beginning of the script below. It can be fed into http://habanero.math.cornell.edu:3690/.
