# NEARLY INVARIANT SUBSPACES FOR OPERATORS IN HILBERT SPACES 

YUXIA LIANG AND JONATHAN R. PARTINGTON


#### Abstract

For a shift operator $T$ with finite multiplicity acting on a separable infinite dimensional Hilbert space we represent its nearly $T^{-1}$ invariant subspaces in Hilbert space in terms of invariant subspaces under the backward shift. Going further, given any finite Blaschke product $B$, we give a description of the nearly $T_{B}^{-1}$ invariant subspaces for the operator $T_{B}$ of multiplication by $B$ in a scale of Dirichlet-type spaces.


## 1. Introduction

Given $\alpha$ a real number, the Dirichlet-type space $\mathcal{D}_{\alpha}(\mathbb{D})$ consists of all analytic functions $f(z)=\sum_{k=0}^{\infty} a_{k} z^{k}$ in $\mathbb{D}$ such that its norm

$$
\|f\|_{\alpha}:=\left(\sum_{k=0}^{\infty}\left|a_{k}\right|^{2}(k+1)^{\alpha}\right)^{1 / 2}<+\infty .
$$

If $\alpha=-1, \mathcal{D}_{-1}=A^{2}(\mathbb{D})$ the classical Bergman space, for $\alpha=0$, $\mathcal{D}_{0}=H^{2}(\mathbb{D})$ the Hardy space, and for $\alpha=1, \mathcal{D}_{1}=\mathcal{D}(\mathbb{D})$ the classical Dirichlet space, systematically investigated in the book [6]. These are particular instances of separable infinite dimensional Hilbert spaces, to be denoted by $\mathcal{H}$ in this paper. We let $\mathcal{B}(\mathcal{H})$ denote the collection of all bounded linear operators acting on $\mathcal{H}$.

The notations $\mathbb{N}_{0}$ and $\mathbb{N}$ denote the set of all nonnegative integers and positive integers, respectively. Here we recall the $\mathbb{C}^{l}$-vector-valued Hardy space $H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right)$ consists of all analytic $F: \mathbb{D} \rightarrow \mathbb{C}^{l}$ such that the norm

$$
\|F\|=\left(\sup _{0<r<1} \frac{1}{2 \pi} \int_{0}^{2 \pi}\left\|F\left(r e^{i w}\right)\right\|^{2} d w\right)^{\frac{1}{2}}<\infty
$$

Writing $F=\left[f_{1}, f_{2}, \cdots, f_{l}\right]$ with $f_{i}: \mathbb{D} \rightarrow \mathbb{C}$, it is clear that $F \in$ $H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right)$ if and only if $f_{i} \in H^{2}(\mathbb{D})$ for $i=1,2, \cdots, l$ with $l \in \mathbb{N}$.

[^0]Inner functions play important role in describing the invariant subspaces of the unilateral shift $S f(z)=z f(z)$ (multiplication by the independent variable) on $H^{2}(\mathbb{D})$. Beurling's Theorem states that a nontrivial closed subspace $\mathcal{M} \subset H^{2}(\mathbb{D})$ satisfies $S \mathcal{M} \subset \mathcal{M}$ if and only if $\mathcal{M}=\theta H^{2}(\mathbb{D})$ with $\theta$ is inner. The simplest nontrivial inner function is an automorphism of $\mathbb{D}$ mapping $\mathbb{T}$ onto $\mathbb{T}$. More generally, if $\left\{a_{n}\right\}_{n \geq 1}$ is a sequence of points in $\mathbb{D} \backslash\{0\}$ satisfying the Blaschke condition $\sum_{n=1}^{\infty}\left(1-\left|a_{n}\right|\right)<\infty$, then we can construct the corresponding Blaschke product

$$
B(z):=z^{m} \prod_{n=1}^{\infty} \frac{\left|a_{n}\right|}{a_{n}} \frac{a_{n}-z}{1-\overline{a_{n}} z}, m \in \mathbb{N}_{0} .
$$

The Toeplitz operator $T_{g}$ on $H^{2}(\mathbb{D})$ is defined by

$$
T_{g} f=P(g f) \text { with } g \in L^{\infty}(\mathbb{T})
$$

and $P$ is the orthogonal projection from $L^{2}(\mathbb{T})$ on $H^{2}(\mathbb{D})$. It is wellknown that the kernel of $T_{\bar{\theta}}$ on $H^{2}(\mathbb{D})$ is a model space $K_{\theta}:=H^{2} \ominus \theta H^{2}$ with $\theta$ an inner function (cf. [8, 9, 15]).

Given a Blaschke product $B$, the Wold Decomposition Theorem implies that every $f \in H^{2}(\mathbb{D})$ has an expression

$$
f(z)=\sum_{k=0}^{\infty} B^{k}(z) h_{k}(z)
$$

with $h_{k}$ are functions in $K_{B}=H^{2} \ominus B H^{2}$. An analogous theorem for Dirichlet-type space $\mathcal{D}_{\alpha}(\mathbb{D})$ has been proved as follows.

Theorem 1.1. [5, Theorem 3.1], [4, Theorem 2.1] Let $\alpha \in[-1,1]$ and $B$ a finite Blaschke product. Then $f \in \mathcal{D}_{\alpha}(\mathbb{D})$ if and only if $f=$ $\sum_{k=0}^{\infty} B^{k} h_{k}$ (convergence in $\mathcal{D}_{\alpha}$ norm) with $h_{k} \in K_{B}$ and

$$
\begin{equation*}
\sum_{k=0}^{\infty}(k+1)^{\alpha}\left\|h_{k}\right\|_{H^{2}}^{2}<\infty \tag{1.1}
\end{equation*}
$$

Since $K_{B}$ is finite-dimensional, we may take other (equivalent) norms here, such as $\left\|h_{k}\right\|_{\mathcal{D}_{\alpha}}$.

A concept commonly appearing in operator theory and complex function theory is that of near invariance, which arises in the investigations of (almost) invariant subspaces. At the beginning, nearly $S^{*}$ invariant subspaces of $H^{2}(\mathbb{D})$ were introduced by Hayashi [9], Hitt [10], and then Sarason [14] in the context of kernels of Toeplitz operators. There are also many other contributions related with this topic; for example the
case of backwards shifts on vector-valued Hardy spaces was analysed in [3]. The interested reader can also refer to [1, 2, 12] and the references therein. Roughly speaking, a subspace $\mathcal{M} \subset \mathcal{H}$ is said to be nearly $S^{*}$ invariant if the zeros of functions in $\mathcal{M}$ can be divided out without leaving the space. The following definition presents a nearly $T^{-1}$ invariant subspace for any left invertible $T \in \mathcal{B}(\mathcal{H})$.

Definition 1.2. Let $\mathcal{H}$ be a separable infinite dimensional Hilbert space and $T \in \mathcal{B}(\mathcal{H})$ be left invertible. Then a subspace $\mathcal{M} \subset \mathcal{H}$ is said to be nearly $T^{-1}$ invariant if for every $g \in \mathcal{H}$ such that $T g \in \mathcal{M}$, it holds that $g \in \mathcal{M}$.

A shift operator acting on a separable infinite dimensional Hilbert space is the direct generalization of the unilateral shift $S$ and multiplication operator $T_{B}$ on $H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right)$. It is isometric and left invertible, and was abstractly defined in [13, Chapter 1] as below.

Definition 1.3. An operator $T \in \mathcal{B}(\mathcal{H})$ is a shift operator if $T$ is an isometry and $\left\|T^{* n} f\right\| \rightarrow 0$ for all $f \in \mathcal{H}$ as $n \rightarrow \infty$.

There are also other equivalent descriptions for a shift operator. For example, an isometry $T \in \mathcal{B}(\mathcal{H})$ is a shift operator if and only if $T$ is pure. Here an isometry $T$ on $\mathcal{H}$ is pure whenever $\bigcap_{n \geq 0} T^{n} \mathcal{H}=\{0\}$. Furthermore, a pure isometry $T \in \mathcal{B}(\mathcal{H})$ has multiplicity $m$ if the dimension of the subspace $\mathcal{K}:=\mathcal{H} \ominus T \mathcal{H}=\operatorname{Ker} T^{*}$ is $m$.

Besides, an operator $A \in \mathcal{B}(\mathcal{H})$ is $T$-inner if $A$ is analytic (that is, $A T=T A)$ and partially isometric. Based on the concept of $T$-inner operator, the Beurling-Lax Theorem for invariant subspaces under a shift operator $T \in \mathcal{B}(\mathcal{H})$ was given in [13, Section 1.12], as follows.

Theorem 1.4. A subspace $\mathcal{F}$ of $\mathcal{H}$ is invariant under the shift operator $T \in \mathcal{B}(\mathcal{H})$ if and only if $\mathcal{F}=A \mathcal{H}$ for some $T$-inner operator $A$ on $\mathcal{H}$.

It is natural to ask how to give an expression for nearly $T^{-1}$ invariant subspaces in $\mathcal{H}$. Motivated by this question, we organize the rest of the paper as follows. In Section 2, using the formulae of $S^{*}$ invariant subspaces in vector-valued Hardy space, we present a characterization for nearly $T^{-1}$ invariant subspaces when $T \in \mathcal{B}(\mathcal{H})$ is a shift operator with multiplicity $m$. Going beyond this, noting that a finite Blaschke product $B$ is a multiplier of Dirichlet-type spaces, we give some descriptions for nearly $T_{B}^{-1}$ invariant subspaces in Section 3, extending considerably some work of Erard [7].

## 2. NEARLY $T^{-1}$ INVARIANT SUBSPACES

In this section, we always suppose $T \in \mathcal{B}(\mathcal{H})$ is a shift operator with multiplicity $m$. This gives

$$
\begin{equation*}
1 \leq l:=\operatorname{dim}[\mathcal{M} \ominus(\mathcal{M} \cap T \mathcal{H})] \leq m \tag{2.1}
\end{equation*}
$$

for every nonzero nearly $T^{-1}$ invariant subspace $\mathcal{M} \subset \mathcal{H}$. Denote an orthonormal basis of $\mathcal{K}:=\mathcal{H} \ominus T \mathcal{H}$ by $e_{1}, \cdots, e_{m}$. And let $\delta_{j}^{m}=$ $(0, \cdots, 0,1,0, \cdots, 0)$ with 1 in the $j$-th place be an orthonormal basis of $K:=H^{2}\left(\mathbb{D}, \mathbb{C}^{m}\right) \ominus z H^{2}\left(\mathbb{D}, \mathbb{C}^{m}\right)$ for $j=1,2, \cdots, m$. Based on the following two orthogonal decompositions

$$
\mathcal{H}=\bigoplus_{i=0}^{\infty} T^{i} \mathcal{K} \text { and } H^{2}\left(\mathbb{D}, \mathbb{C}^{m}\right)=\bigoplus_{i=0}^{\infty} z^{i} K
$$

there exists a unitary mapping $U: \mathcal{H} \rightarrow H^{2}\left(\mathbb{D}, \mathbb{C}^{m}\right)$ defined by

$$
\begin{equation*}
U\left(T^{i} e_{j}\right)=z^{i} \delta_{j}^{m} . \tag{2.2}
\end{equation*}
$$

So the following commutative diagram (2.3) holds for the unilateral shift $S: H^{2}\left(\mathbb{D}, \mathbb{C}^{m}\right) \rightarrow H^{2}\left(\mathbb{D}, \mathbb{C}^{m}\right)$ and the shift operator $T: \mathcal{H} \rightarrow \mathcal{H}$ with multiplicity $m$.

which implies the following equations

$$
\begin{equation*}
S^{n} U=U T^{n} \text { for } n \in \mathbb{N}_{0} \tag{2.4}
\end{equation*}
$$

Using the unitary mapping $U: \mathcal{H} \rightarrow H^{2}\left(\mathbb{D}, \mathbb{C}^{m}\right)$, the following lemma holds, where the superscript ' $t$ ' means the transpose of a matrix.
Lemma 2.1. Let $\mathcal{M} \subset \mathcal{H}$ be a nonzero nearly $T^{-1}$ invariant subspace and $G_{0}:=\left[g_{1}, g_{2}, \cdots, g_{l}\right]^{t}$ be a matrix containing an orthonormal basis $\left(g_{i}\right)_{i \in\{1, \cdots, l\}}$ of $\mathcal{M} \ominus(\mathcal{M} \cap T \mathcal{H})$. Then

$$
\begin{equation*}
F_{0}:=\left[U g_{1}, U g_{2}, \cdots, U g_{l}\right]^{t} \tag{2.5}
\end{equation*}
$$

is a matrix containing an orthonormal basis $\left(U g_{i}\right)_{i \in\{1, \cdots, l\}}$ of $U \mathcal{M} \ominus$ $\left(U \mathcal{M} \cap z H^{2}\left(\mathbb{D}, \mathbb{C}^{m}\right)\right)$.

The lemma below shows the link of nearly invariant subspaces between similar operators.

Lemma 2.2. Suppose $\mathcal{H}_{1}$ and $\mathcal{H}_{2}$ are two Hilbert spaces and $T_{1} \in$ $\mathcal{B}\left(\mathcal{H}_{1}\right)$ and $T_{2} \in \mathcal{B}\left(\mathcal{H}_{2}\right)$ are two left invertible operators. Assume there exists an invertible operator $V: \mathcal{H}_{1} \rightarrow \mathcal{H}_{2}$ so that $T_{2}=V T_{1} V^{-1}$. Let $\mathcal{M}$ be a nearly $T_{1}^{-1}$ invariant subspace in $\mathcal{H}_{1}$, then $V(\mathcal{M})$ is a nearly $T_{2}^{-1}$ invariant subspace in $\mathcal{H}_{2}$.

Proof. For any $h \in \mathcal{H}_{2}$, if $T_{2} h \in V(\mathcal{M})$, we need to show $h \in V(\mathcal{M})$. Since $T_{2} h=V T_{1} V^{-1} h \in V(\mathcal{M})$, it follows that $T_{1} V^{-1} h \in \mathcal{M}$, so that $V^{-1} h \in \mathcal{M}$. This means $h \in V(\mathcal{M})$, ending the proof.

Lemma 2.3. Suppose that $T: \mathcal{H} \rightarrow \mathcal{H}$ is a shift operator, and let $U$ be as (2.2). Then

$$
\begin{equation*}
U^{*}[(U g) h]=h(T) g, \tag{2.6}
\end{equation*}
$$

for any $g \in \mathcal{H}, h \in H^{2}(\mathbb{D})$ such that $(U g) h \in H^{2}\left(\mathbb{D}, \mathbb{C}^{m}\right)$.
Proof. From the commutative diagram (2.3), we have $U g \in H^{2}\left(\mathbb{D}, \mathbb{C}^{m}\right)$ and $(U g) z^{n}=S^{n}(U g)$, and then (2.4) implies that

$$
U^{*}\left[(U g) z^{n}\right]=U^{*} S^{n}(U g)=T^{n} U^{*} U g=T^{n} g, \text { for } n \in \mathbb{N}_{0} .
$$

For any polynomial $p(z)=\sum_{k=0}^{n} a_{k} z^{k} \in H^{2}(\mathbb{D})$, since $U^{*}$ is a linear operator, we have

$$
U^{*}[(U g) p(z)]=\sum_{k=0}^{n} a_{k} T^{k} g=p(T) g
$$

where the operator $p(T)=\sum_{k=0}^{n} a_{k} T^{k}$. So for any $h(z)=\sum_{k=0}^{\infty} h_{k} z^{k} \in$ $H^{2}(\mathbb{D})$ such that $(U g) h \in H^{2}\left(\mathbb{D}, \mathbb{C}^{m}\right)$, there exists a sequence of polynomials $q_{n}(z)=\sum_{k=0}^{n} h_{k} z^{k} \in H^{2}(\mathbb{D})$ such that $q_{n} \rightarrow h$ in $H^{2}(\mathbb{D})$, as $n \rightarrow \infty$. Then we deduce that

$$
U^{*}[(U g) h(z)]=U^{*}\left[(U g)\left(\lim _{n \rightarrow \infty} q_{n}(z)\right)\right]=\lim _{n \rightarrow \infty} q_{n}(T) g=h(T) g
$$

with the operator $h(T)=\sum_{k=0}^{\infty} h_{k} T^{k}$.
We are now in a position to state a theorem for nearly $T^{-1}$ invariant subspaces in $\mathcal{H}$. Recall that $\Phi \in H^{\infty}\left(\mathbb{D}, \mathcal{L}\left(\mathbb{C}^{l^{\prime}}, \mathbb{C}^{l}\right)\right)$ is an operatorvalued inner function if $\Phi\left(e^{i w}\right)$ is an isometry a.e. on $\mathbb{T}$.
Theorem 2.4. Suppose $T: \mathcal{H} \rightarrow \mathcal{H}$ is a shift operator with multiplicity $m$ and $\mathcal{M} \subset \mathcal{H}$ is a nonzero nearly $T^{-1}$ invariant subspace. Let $G_{0}:=$ $\left[g_{1}, g_{2}, \cdots, g_{l}\right]^{t}$ be a matrix containing an orthonormal basis $\left(g_{i}\right)_{i \in\{1, \cdots, l\}}$ of $\mathcal{M} \ominus(\mathcal{M} \cap T \mathcal{H})$. Then there exist a nonnegative integer $l^{\prime} \leq l$ and an operator-valued inner function $\Phi$ belonging to $H^{\infty}\left(\mathbb{D}, \mathcal{L}\left(\mathbb{C}^{l^{\prime}}, \mathbb{C}^{l}\right)\right)$, unique up to unitary equivalence, such that

$$
\mathcal{M}=\left\{f \in \mathcal{H}: \exists h \in H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right) \ominus \Phi H^{2}\left(\mathbb{D}, \mathbb{C}^{l^{\prime}}\right), f=h(T) G_{0}\right\}
$$

Besides, there is an isometric mapping

$$
\begin{equation*}
Q: \mathcal{M} \rightarrow H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right) \ominus \Phi H^{2}\left(\mathbb{D}, \mathbb{C}^{l^{\prime}}\right) \text { given by } Q(f)=h . \tag{2.7}
\end{equation*}
$$

Proof. From Lemma 2.2 and the commutative diagram (2.3), it follows $U \mathcal{M}$ is a nearly $S^{*}$ invariant subspace in $H^{2}\left(\mathbb{D}, \mathbb{C}^{m}\right)$. From 3, Theorem 4.4], there exists an isometric mapping

$$
\begin{equation*}
J: U \mathcal{M} \rightarrow \mathcal{F}^{\prime} \text { given by } J\left(h F_{0}\right)=h, \tag{2.8}
\end{equation*}
$$

with a subspace

$$
\mathcal{F}^{\prime}:=\left\{h \in H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right): \exists U f \in U \mathcal{M}, \quad U f=h F_{0}\right\}
$$

and $F_{0}$ given in (2.5). Moreover, $\mathcal{F}^{\prime}$ is an $S^{*}$ invariant subspace in $H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right)$. The Beurling-Lax Theorem on $H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right)$ implies there exist a nonnegative integer $l^{\prime} \leq l$ and an inner function $\Phi \in H^{\infty}\left(\mathbb{D}, \mathcal{L}\left(\mathbb{C}^{l^{\prime}}, \mathbb{C}^{l}\right)\right)$, unique to unitary equivalence, such that

$$
\mathcal{F}^{\prime}=H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right) \ominus \Phi H^{2}\left(\mathbb{D}, \mathbb{C}^{l^{\prime}}\right) .
$$

Given any $f \in \mathcal{M}$, the isometric mapping (2.8) implies there exists $h=\left[h_{1}, \cdots, h_{l}\right] \in \mathcal{F}^{\prime}$ such that

$$
U f=h F_{0}=\left[h_{1}, \cdots, h_{l}\right]\left[U g_{1}, \cdots, U g_{l}\right]^{t}=\sum_{i=1}^{l}\left(U g_{i}\right) h_{i},
$$

with $\|f\|=\|U f\|=\|h\|$. Then the formula (2.6) gives

$$
f=\sum_{i=1}^{l} U^{*}\left[\left(U g_{i}\right) h_{i}\right]=\sum_{i=1}^{l} h_{i}(T) g_{i}=h(T) G_{0}
$$

with $h(T)=\left[h_{1}(T), \cdots, h_{l}(T)\right]$. We therefore have

$$
\mathcal{M}=\left\{f \in \mathcal{H}: \exists h \in H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right) \ominus \Phi H^{2}\left(\mathbb{D}, \mathbb{C}^{l^{\prime}}\right), f=h(T) G_{0}\right\}
$$

and there is an isometric mapping $Q: \mathcal{M} \rightarrow H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right) \ominus \Phi H^{2}\left(\mathbb{D}, \mathbb{C}^{l^{\prime}}\right)$ given by $Q=J U$ satisfying (2.7).

Remark 2.5. Let

$$
\mathcal{M}^{\prime}=U^{*} \mathcal{F}^{\prime}=U^{*}\left[H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right) \ominus \Phi H^{2}\left(\mathbb{D}, \mathbb{C}^{l^{\prime}}\right)\right] \subset \mathcal{H}
$$

Then $\mathcal{M}^{\prime}$ is a $T^{*}$ invariant subspace and there also exists an isometric mapping $\widetilde{Q}=U^{*} J U: \mathcal{M} \rightarrow \mathcal{M}^{\prime}$ defined by $f \mapsto U^{*} h$.

Given a degree- $m$ Blaschke product $B, T_{B}: H^{2}(\mathbb{D}) \rightarrow H^{2}(\mathbb{D})$ is a shift operator with multiplicity $m$, so we can deduce a corollary.

Corollary 2.6. Let $\mathcal{M} \subset H^{2}(\mathbb{D})$ is a nonzero nearly $T_{B}^{-1}$ invariant subspace with a degree-m Blaschke product B. Let the matrix $G_{0}(z):=$ $\left[g_{1}(z), g_{2}(z), \cdots, g_{l}(z)\right]^{t}$ contain an orthonormal basis $\left(g_{i}(z)\right)_{i \in\{1, \cdots, l\}}$ of $\mathcal{M} \ominus\left(\mathcal{M} \cap B H^{2}(\mathbb{D})\right)$. Then there exist a nonnegative integer $l^{\prime} \leq l$ and an operator-valued inner function $\Phi \in H^{\infty}\left(\mathbb{D}, \mathcal{L}\left(\mathbb{C}^{l^{\prime}}, \mathbb{C}^{l}\right)\right)$, unique up to unitary equivalence, such that
$\mathcal{M}=\left\{f \in H^{2}(\mathbb{D}): \exists h \in H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right) \ominus \Phi H^{2}\left(\mathbb{D}, \mathbb{C}^{l^{\prime}}\right), f(z)=h\left(T_{B}\right) G_{0}(z)\right\}$.
Here we show an example to illustrate Corollary 2.6.
Example 2.7. Given $a \in \mathbb{D} \backslash\{0\}$ and some $m \in \mathbb{N}_{0}$, denote a subspace

$$
\mathcal{M}=\varphi_{a}(z) \cdot\left(\bigvee\left\{z^{2 k}: k \in \mathbb{N}\right\} \oplus \bigvee\left\{z, z^{3}, \cdots, z^{2 m+1}\right\}\right)
$$

which is nearly $T_{z^{2}}^{-1}$ invariant in $H^{2}(\mathbb{D})$. It holds that

$$
\mathcal{M} \ominus\left(\mathcal{M} \cap z^{2} \mathcal{M}\right)=\left\langle g_{1}(z), g_{2}(z)\right\rangle
$$

with the function matrix $G_{0}(z):=\left[g_{1}(z), g_{2}(z)\right]^{t}=\varphi_{a}(z) \cdot[1, z]^{t}$.
For any $f \in \mathcal{M}$, it turns out

$$
f(z)=\left[\sum_{i=0}^{\infty} a_{i 1} z^{2 i}, \sum_{i=0}^{m} a_{i, 2} z^{2 i}\right] G_{0}(z)
$$

where $\left(a_{i, j}\right)_{i, j}$ satisfies

$$
\left[a_{i, 1}, a_{i, 2}\right] \in \begin{cases}\mathbb{C} \times \mathbb{C}, & i=0,1, \cdots, m \\ \mathbb{C} \times\{0\}, & i \geq m+1\end{cases}
$$

The formula in Corollary 2.6 together the above facts imply

$$
\mathcal{M}=\left\{f \in H^{2}(\mathbb{D}): \exists h \in H^{2}\left(\mathbb{D}, \mathbb{C}^{2}\right) \ominus \Phi(z) H^{2}(\mathbb{D}), f(z)=h\left(T_{z^{2}}\right) G_{0}(z)\right\}
$$

with an operator-valued inner function $\Phi(z)=z^{m+1}(0,1) \in \mathbb{C}^{2}$.

## 3. Nearly $T_{B}^{-1}$ invariant subspaces in $\mathcal{D}_{\alpha}$

In this section we address the more difficult question of near invariance for the operator $T_{B}: \mathcal{D}_{\alpha}(\mathbb{D}) \rightarrow \mathcal{D}_{\alpha}(\mathbb{D})$ with a degree- $m$ Blaschke product $B$, which is not isometric but simply bounded below, extending the methods of Erard [7].

It is known that the special multiplication operator $T_{B}$ is always bounded on Dirichlet-type space $\mathcal{D}_{\alpha}:=\mathcal{D}_{\alpha}(\mathbb{D})$ for any finite Blaschke product $B$. The study of multiplication invariant subspaces of Hardy spaces can be traced back to Lance and Stessin's work [11]; they described closed subspaces of the Hardy spaces $H^{p}(\mathbb{D})$ which are innerinvariant. In 2004, Erard investigated the nearly invariant subspaces
related to lower bounded multiplication operator $M_{u}$ on a Hilbert space $\mathcal{H}$ in [7]. There are four conditions on the pairs $(\mathcal{H}, u)$ as below:
(i) $\mathcal{H}$ is a Hilbert space and a linear submanifold of

$$
\mathcal{O}(\mathcal{W}):=\{f: \mathcal{W} \rightarrow \mathbb{C} \mid f \text { is analytic }\}
$$

where $\mathcal{W}$ is an open subset of $\mathbb{C}^{d}(d \in \mathbb{N})$,
(ii) $u \in \mathcal{O}(\mathcal{W})$ satisfies $u h \in \mathcal{H}$ for all $h \in \mathcal{H}$,
(iii) for all $w \in \mathcal{W}$, the evaluation $\mathcal{H} \rightarrow \mathbb{C}, h \rightarrow h(w)$ is continuous,
(iv) there exists $c>0$ such that for all $h \in \mathcal{H}, c\|h\|_{\mathcal{H}} \leq\|u h\|_{\mathcal{H}}$.

In the sequel, a "subspace" means a closed linear subspace, and a "linear manifold" is an algebraic subspace that is not necessarily closed.

For the above $(\mathcal{H}, u)$, the lower bound of $M_{u}$ relative to the norm $\|\cdot\|_{\mathcal{H}}$ is defined by

$$
\begin{equation*}
\left.\gamma_{\mathcal{H}, M_{u}}=\sup \left\{c>0: \forall h \in \mathcal{H}, c\|h\|_{\mathcal{H}} \leq\|u h\|_{\mathcal{H}}\right\} \in\right] 0, \infty[. \tag{3.1}
\end{equation*}
$$

Erard gave the definition of "nearly invariant under division by $u$ ", which is same as "nearly $M_{u}^{-1}$ invariant", a special case of Definition 1.2. Considering the importance of the backward shift $M_{z}$, Erard proved the following theorem on nearly $S^{*}$ invariant subspaces in $\mathcal{H}$, under the assumption that $M_{z}: \mathcal{H} \rightarrow \mathcal{H}$ is bounded below.

Theorem 3.1. [7, Theorem 5.1] Assume that $\mathcal{H}$ satisfies (i)-(iv) with $u(z)=z$, and

$$
\operatorname{dim}\left(\mathcal{H} \ominus M_{z} \mathcal{H}\right)=1 \text { and }\|h\|_{\mathcal{H}} \leq\left\|M_{z} h\right\|_{\mathcal{H}} \text { for all } h \in \mathcal{H} .
$$

Assume also that there exists $f \in \mathcal{H}$ with $f(0) \neq 0$. Let $\mathcal{M}$ be a nonzero subspace of $\mathcal{H}$ which is nearly invariant under the backward shift $M_{z}$. Let $g$ be any unit vector of $\mathcal{M} \ominus\left(\mathcal{M} \cap M_{z} \mathcal{H}\right)$. Then there exists a linear submanifold $\mathcal{N}$ of $H^{2}(\mathbb{D})$ such that $\mathcal{M}=g \mathcal{N}$ and for all $h \in \mathcal{M}$, we have

$$
\|h\|_{\mathcal{H}} \geq\left\|\frac{h}{g}\right\|_{H^{2}(\mathbb{D})}
$$

Besides, $\mathcal{N}$ is invariant under the backward shift and $g(0) \neq 0$.
We note the operator $T_{B}: \mathcal{D}_{\alpha} \rightarrow \mathcal{D}_{\alpha}$ is more general than $M_{z}$ : $H^{2}(\mathbb{D}) \rightarrow H^{2}(\mathbb{D})$, so we seek characterizations for nearly $T_{B}^{-1}$ invariant subspaces in $\mathcal{D}_{\alpha}$ with $\alpha \in[-1,1]$ and a degree- $m$ Blaschke product $B$. The following lemma is the factorization of elements in a nearly $T^{-1}$ invariant subspace with a bounded below $T \in \mathcal{B}(\mathcal{H})$. (We use the notation $P^{\mathcal{N}}$ for the orthogonal projection onto a subspace $\mathcal{N}$.)

Lemma 3.2. [7, Lemma 2.1] Let $\mathcal{H}$ be a Hilbert space, $T: \mathcal{H} \rightarrow \mathcal{H}$ be a bounded operator such that for all $h \in \mathcal{H},\|h\|_{\mathcal{H}} \leq\|T h\|_{\mathcal{H}}$ and $\mathcal{M}$ be
a nearly $T^{-1}$ invariant subspace of $\mathcal{H}$. Set

$$
\begin{equation*}
R=\left(T^{*} T\right)^{-1} T^{*} P^{\mathcal{M} \cap T \mathcal{H}} \text { and } Q=P^{\mathcal{M} \ominus(\mathcal{M} \cap T \mathcal{H})} \tag{3.2}
\end{equation*}
$$

Then for all $h \in \mathcal{M}$ and $p \in \mathbb{N}_{0}$, we have

$$
\begin{equation*}
h=\sum_{k=0}^{p} T^{k} Q R^{k} h+T^{p+1} R^{p+1} h \tag{3.3}
\end{equation*}
$$

In this section, the range of the symbol $l$ in (2.1) is also true for $T=T_{B}$, a nonzero nearly $T_{B}^{-1}$ invariant subspace $\mathcal{M}$ of $\mathcal{H}=\mathcal{D}_{\alpha}$ with $\alpha \in[-1,1]$ and a degree- $m$ Blaschke product $B$. In the sequel, we will endow the space $\mathcal{D}_{\alpha}$ with two different equivalent norms according to the cases $\alpha \in[0,1]$ and $\alpha \in[-1,0)$, so we divide the discussion into two subsections.
3.1. Nearly $T_{B}^{-1}$ invariant subspaces in $\mathcal{D}_{\alpha}$ with $\alpha \in[0,1]$. In this subsection, $\mathcal{D}_{\alpha}$ is endowed with an equivalent norm as in (1.1) denoted by $\|\cdot\|_{1}$, that is,

$$
\begin{equation*}
\|f\|_{1}^{2}:=\sum_{k=0}^{\infty}(k+1)^{\alpha}\left\|h_{k}\right\|_{H^{2}}^{2} \tag{3.4}
\end{equation*}
$$

for any $f=\sum_{k=0}^{\infty} B^{k} h_{k}$ with $h_{k} \in K_{B}$. Then it holds that

$$
\left\|T_{B} f\right\|_{1}^{2}=\|B f\|_{1}^{2}=\sum_{k=0}^{\infty}(k+2)^{\alpha}\left\|h_{k}\right\|_{H^{2}}^{2} \geq\|f\|_{1}^{2}
$$

which implies the operator $T_{B}: \mathcal{D}_{\alpha} \rightarrow \mathcal{D}_{\alpha}$ is lower bounded. This confirms that $\left(\mathcal{D}_{\alpha}, T_{B}\right)$ satisfies Conditions $(i)-(i v)$ and the lower bound of $T_{B}$ relative the norm $\|\cdot\|_{1}$ is $\gamma_{1}:=1$. And it is also true that $B^{-1}(D(0,1))=B^{-1}(\mathbb{D})=\mathbb{D}$. The above facts together with

$$
\bigcap_{n \in \mathbb{N}} B^{n} \mathcal{D}_{\alpha}=\{0\} \text { on } \mathbb{D}
$$

imply the following lemma, which can be deduced from [7, Theorem 3.2] with $\mathcal{H}=\mathcal{D}_{\alpha}, u=B, \gamma=\gamma_{1}:=1$ and the index set $I=\{1,2, \cdots, l\}$.

Lemma 3.3. For $\alpha \in[0,1]$, let $\mathcal{M}$ be a nonzero nearly $T_{B}^{-1}$ invariant subspace of $\mathcal{D}_{\alpha}$ endowed with the norm $\|\cdot\|_{1}$ in (3.4) and $\left(g_{i}\right)_{i \in\{1, \ldots, l\}}$ be a hilbertian basis of $\mathcal{M} \ominus\left(\mathcal{M} \cap T_{B} \mathcal{D}_{\alpha}\right)$. Then for all $h \in \mathcal{M}$, there exists $\left(q_{i}\right)_{i \in\{1, \cdots, l\}}$ in $\mathcal{O}(\mathbb{D})$ such that

$$
\begin{equation*}
h=\sum_{i=1}^{l} g_{i} q_{i} \text { on } \mathbb{D}, \tag{3.5}
\end{equation*}
$$

and for all $i \in\{1, \cdots, l\}$, there exists a sequence $\left\{c_{k i}\right\}_{k \in \mathbb{N}} \in \mathbb{C}^{\mathbb{N}}$ with

$$
\begin{align*}
& q_{i}=\sum_{k=0}^{\infty} c_{k i} B^{k}  \tag{3.6}\\
& \sum_{i=1}^{l} \sum_{k=0}^{\infty}\left|c_{k i}\right|^{2} \leq\|h\|_{1}^{2} . \tag{3.7}
\end{align*}
$$

Now we are ready to state a theorem on nearly $T_{B}^{-1}$ invariant subspaces in $\mathcal{D}_{\alpha}$ with $\alpha \in[0,1]$.
Theorem 3.4. For $\alpha \in[0,1]$, let $\mathcal{M}$ be a nonzero nearly $T_{B}^{-1}$ invariant subspace of $\mathcal{D}_{\alpha}$ endowed with the norm $\|\cdot\|_{1}$ in (3.4) and $G_{0}:=\left[g_{1}, g_{2}, \cdots, g_{l}\right]^{t}$ be a matrix containing an orthonormal basis $\left(g_{i}\right)_{i \in\{1, \cdots, l\}}$ of $\mathcal{M} \ominus\left(\mathcal{M} \cap T_{B} \mathcal{D}_{\alpha}\right)$. Then there exists a linear submanifold $\mathcal{N} \subset H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right)$ such that $\mathcal{M}=\mathcal{N} G_{0}$ and for all $h \in \mathcal{M}$, there exists $q \in \mathcal{N}$ such that $h=q G_{0}$ and

$$
\|h\|_{1} \geq\|q\|_{H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right)}
$$

Moreover, $\mathcal{N}$ is invariant under $T_{\bar{B}}$.
Proof. For $\alpha \in[0,1]$, the equation (3.5) implies that every $h \in \mathcal{M}$ has the form

$$
\begin{equation*}
h=\sum_{i=1}^{l} g_{i} q_{i}=q G_{0} \text { on } \mathbb{D}, \tag{3.8}
\end{equation*}
$$

with $q=\left[q_{1}, q_{2}, \cdots, q_{l}\right]$. Combining the series of $q_{i}$ in (3.6), we deduce

$$
\left\|q_{i}\right\|_{H^{2}(\mathbb{D})}^{2}=\sum_{k=0}^{\infty}\left|c_{k i}\right|^{2} \text { for all } i \in\{1, \cdots, l\} .
$$

And then the norm estimation in (3.7) implies

$$
\begin{equation*}
\|q\|_{H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right)}^{2}=\sum_{i=1}^{l}\left\|q_{i}\right\|_{H^{2}(\mathbb{D})}^{2}=\sum_{i=1}^{l} \sum_{k=0}^{\infty}\left|c_{k i}\right|^{2} \leq\|h\|_{1}^{2}, \tag{3.9}
\end{equation*}
$$

with

$$
q=\left[q_{1}, q_{2}, \cdots, q_{l}\right]=\sum_{k=0}^{\infty} B^{k} C_{k} \in H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right)
$$

where $C_{k}=\left(c_{k 1}, \cdots, c_{k l}\right) \in \mathbb{C}^{l}$. Then there exists a linear submanifold

$$
\mathcal{N}:=\left\{q \in H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right): \exists h \in \mathcal{M}, h=q G_{0}\right\},
$$

satisfying $\mathcal{M}=\mathcal{N} G_{0}$. For all $h \in \mathcal{M}$, (3.9) implies

$$
\|h\|_{1} \geq\|q\|_{H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right)}
$$

Next we show $\mathcal{N}$ is invariant under $T_{\bar{B}}$. Let $T=T_{B}$ and $\mathcal{H}=\mathcal{D}_{\alpha}$ with $\alpha \in[0,1]$ in Lemma [3.2, and then the operators in (3.2) become

$$
R=\left(T_{B}^{*} T_{B}\right)^{-1} T_{B}^{*} P^{\mathcal{M} \cap T_{B} \mathcal{D}_{\alpha}} \text { and } Q=P^{\mathcal{M} \ominus\left(\mathcal{M} \cap T_{B} \mathcal{D}_{\alpha}\right)}
$$

Hence the equation (3.3) with $p=0$ gives $h=Q h+T_{B} R h$, which together with (3.8) entail

$$
q G_{0}=Q\left(q G_{0}\right)+T_{B} R\left(q G_{0}\right)=C_{0} G_{0}+B R\left(q G_{0}\right)
$$

And then we obtain

$$
B R\left(q G_{0}\right)=\left(q-C_{0}\right) G_{0}=\left(\sum_{k=1}^{\infty} B^{k} C_{k}\right) G_{0}
$$

which implies

$$
\begin{aligned}
R\left(q G_{0}\right) & =\left(\sum_{k=1}^{\infty} B^{k-1} C_{k}\right) G_{0} \\
& =\left(T_{\bar{B}}\left(\sum_{k=0}^{\infty} B^{k} C_{k}\right)\right) G_{0} \\
& =\left(T_{\bar{B}}(q)\right) G_{0} .
\end{aligned}
$$

The formula $T_{B} R h=P^{\mathcal{M} \cap T_{B} \mathcal{D}_{\alpha}} h \in \mathcal{M}$ together with the fact that $\mathcal{M}$ is a nearly $T_{B}^{-1}$ invariant subspace imply $R(\mathcal{M}) \subset \mathcal{M}$. In particular, $R\left(q G_{0}\right) \in \mathcal{M}$ and then $T_{\bar{B}}(q) \in \mathcal{N}$ from the definition of $\mathcal{N}$. This means $\mathcal{N}$ is a $T_{\bar{B}}$ invariant submanifold of $H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right)$.

Now consider the following special case of (2.3):


Here $S U=U T_{B}$ holds for the unilateral shift $S: H^{2}\left(\mathbb{D}, \mathbb{C}^{m l}\right) \rightarrow$ $H^{2}\left(\mathbb{D}, \mathbb{C}^{m l}\right)$ and $T_{B}: H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right) \rightarrow H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right)$ with multiplicity $m l$. This leads to the following remark for finite-dimensional nearly $T_{B}^{-1}$ invariant subspaces in $\mathcal{D}_{\alpha}$ with $\alpha \in[0,1]$.

Remark 3.5. In Theorem 3.4, if $\mathcal{M}$ is finite-dimensional, then $\mathcal{N} \subset$ $H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right)$ is also finite-dimensional and hence closed. From the BeurlingLax Theorem and the commutative diagram (3.10), we deduce that

$$
\mathcal{N}=U^{*}\left(H^{2}\left(\mathbb{D}, \mathbb{C}^{m l}\right) \ominus \Psi H^{2}\left(\mathbb{D}, \mathbb{C}^{r}\right)\right)
$$

with $0 \leq r \leq m l$ and an inner function $\Psi \in H^{\infty}\left(\mathbb{D}, \mathcal{L}\left(\mathbb{C}^{r}, \mathbb{C}^{m l}\right)\right)$. Then $\mathcal{M}=\left[U^{*}\left(H^{2}\left(\mathbb{D}, \mathbb{C}^{m l}\right) \ominus \Psi H^{2}\left(\mathbb{D}, \mathbb{C}^{r}\right)\right)\right] G_{0}$.
3.2. Nearly $T_{B}^{-1}$ invariant subspaces in $\mathcal{D}_{\alpha}$ with $\alpha \in[-1,0)$. In this subsection, we cannot make $T_{B}$ into an expansive operator, but it is possible to achieve a good enough lower bound by taking an equivalent norm. So we endow $\mathcal{D}_{\alpha}$ with the modified equivalent norm denoted by $\|\cdot\|_{2}$ as follows: for any $f=\sum_{k=0}^{\infty} B^{k} h_{k}$ with $h_{k} \in K_{B}$,

$$
\begin{equation*}
\|f\|_{2}^{2}:=\sum_{k=0}^{N-1} N^{\alpha}\left\|h_{k}\right\|_{H^{2}}^{2}+\sum_{k=N}^{\infty}(k+1)^{\alpha}\left\|h_{k}\right\|_{H^{2}}^{2}, \tag{3.11}
\end{equation*}
$$

where $N$ is a fixed and sufficiently large positive integer, to be specified below. With respect to the norm $\|\cdot\|_{2}$, the lower bound of $T_{B}$ defined in (3.1) is

$$
\begin{equation*}
\gamma_{2}:=\left(1-\frac{1}{N+1}\right)^{-\alpha / 2} . \tag{3.12}
\end{equation*}
$$

Then it holds that $\left\|T_{B} f\right\|_{2}^{2}=\|B f\|_{2}^{2} \geq \gamma_{2}^{2}\|f\|_{2}^{2}$ for any $f \in \mathcal{D}_{\alpha}$, implying that the operator $T:=\gamma_{2}^{-1} T_{B}: \mathcal{D}_{\alpha} \rightarrow \mathcal{D}_{\alpha}$ satisfies

$$
\|T f\|_{2}=\left\|\gamma_{2}^{-1} T_{B} f\right\|_{2} \geq\|f\|_{2} \text { for any } f \in \mathcal{D}_{\alpha}
$$

So ( $\mathcal{D}_{\alpha}, T_{B}$ ) also satisfies Conditions (i)-(iv) with the lower bound $\gamma_{2}$ given in (3.12) for $\alpha \in[-1,0)$. Here we choose $N$ large enough such that $\gamma_{2}$ satisfies $B^{-1}\left(D\left(0, \gamma_{2}\right)\right) \supset s \mathbb{D}$ with $s \mathbb{D}$ a disc containing all the zeros of $B$. This ensures that

$$
\begin{equation*}
\left\|\gamma_{2}^{-1} B\right\|_{H^{\infty}(s \mathbb{D})}<1 \tag{3.13}
\end{equation*}
$$

Furthermore, $T:=\gamma_{2}^{-1} T_{B}$ satisfies the assumptions in Lemma 3.2 and

$$
\left.\bigcap_{n \in \mathbb{N}}\left(B^{n} \mathcal{D}_{\alpha}\right)\right|_{s \mathbb{D}}=\left.\bigcap_{n \in \mathbb{N}}\left(T^{n} \mathcal{D}_{\alpha}\right)\right|_{s \mathbb{D}}=\{0\}
$$

Based on the above facts and [7, Theorem 3.2], a lemma similar to Lemma 3.3 holds for the case $\alpha \in[-1,0)$ with $\gamma_{2}$ in (3.12).

Lemma 3.6. For $\alpha \in[-1,0)$ and $\gamma_{2}:=\left(1-\frac{1}{N+1}\right)^{-\alpha / 2}$ with large enough $N$, let $\mathcal{M}$ be a nonzero nearly $T_{B}^{-1}$ invariant subspace of $\mathcal{D}_{\alpha}$ endowed with the norm $\|\cdot\|_{2}$ in (3.11) and $\left(g_{i}\right)_{i \in\{1, \cdots, l\}}$ be a hilbertian basis of $\mathcal{M} \ominus\left(\mathcal{M} \cap T_{B} \mathcal{D}_{\alpha}\right)$. Then for all $h \in \mathcal{M}$, there exists $\left(q_{i}\right)_{i \in\{1, \ldots, l\}}$ in $\mathcal{O}(s \mathbb{D})$ such that

$$
\begin{equation*}
h=\sum_{i=1}^{l} g_{i} q_{i} \text { on } s \mathbb{D}, \tag{3.14}
\end{equation*}
$$

and for all $i \in\{1, \cdots, l\}$, there exists a sequence $\left\{d_{k i}\right\}_{k \in \mathbb{N}} \in \mathbb{C}^{\mathbb{N}}$ with

$$
\begin{align*}
& q_{i}=\sum_{k=0}^{\infty} d_{k i}\left(\gamma_{2}^{-1} B\right)^{k} \text { on } s \mathbb{D},  \tag{3.15}\\
& \sum_{i=1}^{l} \sum_{k=0}^{\infty}\left|d_{k i}\right|^{2} \leq\|h\|_{2}^{2} \tag{3.16}
\end{align*}
$$

In order to use the submanifold in $H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right)$ to describe nearly $T_{B}^{-1}$ invariant subspaces in $\mathcal{D}_{\alpha}$ with $\alpha \in[-1,0)$, here we introduce an unitary mapping $U_{s}: H^{2}\left(s \mathbb{D}, \mathbb{C}^{l}\right) \rightarrow H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right)$ by

$$
\left(U_{s} f\right)(z)=f(s z)
$$

Then the diagram (3.17) commutes, with $T_{s}^{*}:=U_{s} T_{B^{-1}} U_{s}^{*}$,

$$
\begin{array}{rlll}
H^{2}\left(s \mathbb{D}, \mathbb{C}^{l}\right) & \xrightarrow{T_{B^{-1}}} & H^{2}\left(s \mathbb{D}, \mathbb{C}^{l}\right) \\
\downarrow_{s} & & \downarrow^{U_{s}}  \tag{3.17}\\
H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right) & \xrightarrow{T_{s}^{*}} & H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right) .
\end{array}
$$

Since the disc $s \mathbb{D}$ contains all zeros of $B$, the symbol $B^{-1}$ lies in $L^{\infty}(s \mathbb{T})$, and thus

$$
\begin{align*}
\left(T_{s}^{*} f\right)(z) & =\left(U_{s} T_{B^{-1}} U_{s}^{*} f\right)(z) \\
& =\left(U_{s} T_{B^{-1}}\right) f\left(s^{-1} z\right) \\
& =U_{s}\left[P_{H^{2}\left(s \mathbb{D}, \mathbb{C}^{l}\right)}\left(\frac{1}{B(z)} f\left(s^{-1} z\right)\right)\right] \\
& =P_{H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right)}\left(\frac{1}{B(s z)} f(z)\right) \\
& =T_{\overline{B(s z)}} f(z)=T_{\overline{B\left(s^{-1} z\right)}} f(z), \tag{3.18}
\end{align*}
$$

due to the fact $B^{-1}(s z)=\overline{B\left(s^{-1} z\right)}$ for $z \in \mathbb{T}$.
Based on the above notations, we present a theorem for nearly $T_{B}^{-1}$ invariant subspaces in $\mathcal{D}_{\alpha}$ with $\alpha \in[-1,0)$ and $\gamma_{2}$ in (3.12).

Theorem 3.7. For $\alpha \in[-1,0)$ and $\gamma_{2}:=\left(1-\frac{1}{N+1}\right)^{-\alpha / 2}$ with large enough $N$, let $\mathcal{M}$ be a nonzero nearly $T_{B}^{-1}$ invariant subspace of $\mathcal{D}_{\alpha}$ endowed with the norm $\|\cdot\|_{2}$ in (3.11) and $G_{0}:=\left[g_{1}, g_{2}, \cdots, g_{l}\right]^{t}$ be a matrix containing an orthonormal basis $\left(g_{i}\right)_{i \in\{1, \cdots, l\}}$ of $\mathcal{M} \ominus(\mathcal{M} \cap$ $\left.T_{B} \mathcal{D}_{\alpha}\right)$. Then there exists a linear submanifold $\mathcal{N} \subset H^{2}\left(s \mathbb{D}, \mathbb{C}^{l}\right)$ such that $\mathcal{M}=\mathcal{N} G_{0}$ on $s \mathbb{D}$ and for all $h \in \mathcal{M}$ there exists $q \in \mathcal{N}$ such that
$h=q G_{0}$ on $s \mathbb{D}$ with

$$
\|h\|_{2} \geq\left(1-\left\|\gamma_{2}^{-1} B\right\|_{H^{\infty}(s \mathbb{D})}^{2}\right)^{1 / 2}\|q\|_{H^{2}\left(s \mathbb{D}, \mathbb{C}^{l}\right)}
$$

Moreover, $\mathcal{N}$ is invariant under $T_{B^{-1}}$ and then $U_{s}(\mathcal{N})$ is invariant under $T_{s}^{*}:=U_{s} T_{B^{-1}} U_{s}^{*}$ in $H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right)$.

Proof. For $\alpha \in[-1,0)$, the equation (3.14) implies

$$
\begin{equation*}
h=\sum_{i=1}^{l} g_{i} q_{i}=q G_{0} \text { on } s \mathbb{D} \tag{3.19}
\end{equation*}
$$

with $q=\left[q_{1}, q_{2}, \cdots, q_{l}\right]$. The display (3.13) and $q_{i}$ in (3.15) entail

$$
\begin{aligned}
\left\|q_{i}\right\|_{H^{2}(s \mathbb{D})} & =\left\|\sum_{k=0}^{\infty} d_{k i}\left(\gamma_{2}^{-1} B\right)^{k}\right\|_{H^{2}(s \mathbb{D})} \\
& \leq \sum_{k=0}^{\infty}\left|d_{k i}\right|\left\|\gamma_{2}^{-1} B\right\|_{H^{\infty}(s \mathbb{D})}^{k} \\
& \leq\left(\sum_{k=0}^{\infty}\left\|\gamma_{2}^{-1} B\right\|_{H^{\infty}(s \mathbb{D})}^{2 k}\right)^{1 / 2}\left(\sum_{k=0}^{\infty}\left|d_{k i}\right|^{2}\right)^{1 / 2} \\
& \leq\left(1-\left\|\gamma_{2}^{-1} B\right\|_{H^{\infty}(s \mathbb{D})}^{2}\right)^{-1 / 2}\left(\sum_{k=0}^{\infty}\left|d_{k i}\right|^{2}\right)^{1 / 2}
\end{aligned}
$$

for all $i=1, \cdots, l$. Thus the above estimations and (3.16) imply

$$
\begin{align*}
\|q\|_{H^{2}\left(s \mathbb{D}, \mathbb{C}^{l}\right)}^{2} & =\sum_{i=1}^{l}\left\|q_{i}\right\|_{H^{2}(s \mathbb{D})}^{2} \\
& \leq\left(1-\left\|\gamma_{2}^{-1} B\right\|_{H^{\infty}(s \mathbb{D})}^{2}\right)^{-1} \sum_{i=1}^{l} \sum_{k=0}^{\infty}\left|d_{k i}\right|^{2} \\
& \leq\left(1-\left\|\gamma_{2}^{-1} B\right\|_{H^{\infty}(s \mathbb{D})}^{2}\right)^{-1}\|h\|_{2}^{2}<+\infty . \tag{3.20}
\end{align*}
$$

This implies

$$
q=\sum_{k=0}^{\infty}\left(\gamma_{2}^{-1} B\right)^{k} D_{k} \in H^{2}\left(s \mathbb{D}, \mathbb{C}^{l}\right)
$$

where $D_{k}=\left(d_{k 1}, d_{k 2}, \cdots, d_{k l}\right) \in \mathbb{C}^{l}$. Hence define a linear submanifold

$$
\begin{equation*}
\mathcal{N}:=\left\{q \in H^{2}\left(s \mathbb{D}, \mathbb{C}^{l}\right): \exists h \in \mathcal{M}, \quad h=q G_{0} \text { on } s \mathbb{D}\right\} \tag{3.21}
\end{equation*}
$$

satisfying $\mathcal{M}=\mathcal{N} G_{0}$ on $s \mathbb{D}$. For all $h \in \mathcal{M}$, (3.20) gives

$$
\|h\|_{2} \geq\left(1-\left\|\gamma_{2}^{-1} B\right\|_{H^{\infty}(s \mathbb{D})}^{2}\right)^{1 / 2}\|q\|_{H^{2}\left(s \mathbb{D}, \mathbb{C}^{l}\right)}
$$

Next we show $\mathcal{N}$ is invariant under $T_{B^{-1}}$. Let $T=\gamma_{2}^{-1} T_{B}$ in the display (3.2), and then the equation (3.3) with $p=0$ gives

$$
h=Q h+T R h=Q h+\gamma_{2}^{-1} T_{B} R h .
$$

On $s \mathbb{D}$, the above equation together with (3.19) entail

$$
q G_{0}=Q\left(q G_{0}\right)+\gamma_{2}^{-1} T_{B} R\left(q G_{0}\right)=D_{0} G_{0}+\gamma_{2}^{-1} B R\left(q G_{0}\right)
$$

which further verifies

$$
\begin{aligned}
\gamma_{2}^{-1} B R\left(q G_{0}\right) & =\left(q-D_{0}\right) G_{0} \\
& =\left(\sum_{k=1}^{\infty}\left(\gamma_{2}^{-1} B\right)^{k} D_{k}\right) G_{0} \text { on } s \mathbb{D} .
\end{aligned}
$$

Letting $B^{-1}$ act on both sides, it yields that

$$
\begin{aligned}
\gamma_{2}^{-1} R\left(q G_{0}\right) & =\gamma_{2}^{-1}\left(\sum_{k=1}^{\infty}\left(\gamma_{2}^{-1} B\right)^{k-1} D_{k}\right) G_{0} \\
& =\gamma_{2}^{-1}\left(\gamma_{2} T_{B^{-1}}(q)\right) G_{0} \\
& =\left(T_{B^{-1}}(q)\right) G_{0}
\end{aligned}
$$

which together with $\gamma_{2}^{-1} R\left(q G_{0}\right) \in \mathcal{M}$ entail $T_{B^{-1}}(q) \in \mathcal{N}$ from the definition of $\mathcal{N}$ in (3.21). That means $\mathcal{N}$ is $T_{B^{-1}}$ invariant in $H^{2}\left(s \mathbb{D}, \mathbb{C}^{l}\right)$. Finally, the commutative diagram (3.17) ensures that $T_{s}^{*}\left(U_{s}(\mathcal{N})\right) \subset$ $U_{s}(\mathcal{N})$, ending the proof.

In order to illustrate the operator $T_{s}^{*}$ given in (3.18), we firstly take a degree-1 Blaschke product $B(z)=(a-z)(1-\bar{a} z)^{-1}$ with $a \in \mathbb{D}$, it is easy to obtain

$$
\begin{equation*}
B\left(s^{-1} z\right)=\frac{a-s^{-1} z}{1-\bar{a} s^{-1} z}=\frac{1}{s} \frac{a s-z}{1-\bar{a} s z} \frac{1-\bar{a} s z}{1-\bar{a} s^{-1} z} . \tag{3.22}
\end{equation*}
$$

Since the disc $s \mathbb{D}$ contains the zero of $B$, that means $\left|\bar{a} s^{-1}\right|<1$, and then the last term in (3.22) is an invertible analytic function on $\mathbb{D}$. This is to say that $B\left(s^{-1} z\right)$ can be written as a degree-1 Blaschke product times an invertible analytic function.

Generally, if $B$ is a degree- $m$ Blaschke product, it can be similarly calculated that

$$
B\left(s^{-1} z\right)=b(z) F_{s}(z)
$$

with a degree- $m$ Blaschke product $b(z)$ and an invertible analytic function $F_{s}(z)$ on $\mathbb{D}$. So $T_{s}^{*}=T_{\overline{b F_{s}}}$ and then $T_{s}=T_{b F_{s}}$ on $H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right)$.

Suppose $\mathcal{F} \subset H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right)$ is a $T_{b}$ invariant subspace, Theorem 1.4 implies $\mathcal{F}=A H^{2}\left(\mathbb{D}, \mathbb{C}^{l}\right)$ with some $T_{b}$-inner operator $A$. For the special case $l=1$, it follows that $\mathcal{F}=\theta H^{2}(\mathbb{D})$ with an inner function $\theta$. The fact $F_{s} H^{2}(\mathbb{D})=H^{2}(\mathbb{D})$ entails $\theta H^{2}(\mathbb{D})$ is also a $T_{b F_{s}}$-invariant subspace in $H^{2}(\mathbb{D})$. So the model space $K_{\theta}$ is $T_{s}^{*}$ invariant.

In general, there is no simple description for $T_{s}^{*}$-invariant subspaces of $H^{2}(\mathbb{D})$, although in the finite-dimensional case, elementary linear algebra tells us that they are spanned by generalized eigenvectors of $T_{s}^{*}$, that is, elements of Toeplitz kernels. The paper [2] is relevant here.
