# GEOMETRY OF SUB-ALGEBRAS OF $\mathcal{H}$ ol $(\Gamma \cup \operatorname{Int}(\Gamma))$ AND ZEROS OF HOLOMORPHIC FUNCTIONS

#### Abstract

We study $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$, the normed algebra of all holomorphic functions defined on some simply connected neighborhood of a simple closed curve $\Gamma$ in $\mathbb{C}$, equipped with the supremum norm on $\Gamma$. We explore the geometry of nowhere vanishing, point separating sub-algebras of $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$. We characterize the extreme points and the exposed points of the unit balls of the said sub-algebras for $\Gamma$ analytic. We also characterize the smoothness of an element in these sub-algebras by using Birkhoff-James orthogonality techniques without any restriction on $\Gamma$. As a culmination of our study, we assimilate the geometry of the aforesaid subalgebras with some classical concepts of complex analysis and establish a connection between Birkhoff-James orthogonality and zeros of holomorphic functions.


## 1. Introduction

The aim of the present article is to study the geometry of a family of normed algebras and to establish a connection between Birkhoff-James orthogonality and zeros of holomorphic functions. The mentioned normed algebras consist of holomorphic functions defined on any simply connected neighborhood of a simple closed curve in $\mathbb{C}$. We shall let $\mathcal{H o l}(K)$ denote the normed algebra of all continuous functions on a compact set $K \subset \mathbb{C}$ that can be extended to a holomorphic function on some neighborhood of $K$, equipped with the supremum norm on $K$. In the same spirit, we consider the normed algebra $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$ for a simple closed curve $\Gamma \subset \mathbb{C}$, where $\operatorname{Int}(\Gamma)$ denotes the simply connected

[^0]region enclosed by $\Gamma$, i.e.,
$\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma)):=\left\{f: \Gamma \cup \operatorname{Int}(\Gamma) \rightarrow \mathbb{C}: \exists U_{f} \supset \Gamma \cup \operatorname{Int}(\Gamma)\right.$ open, $f$ holomorphic on $\left.U_{f}\right\}$,
with the norm defined as:
$$
\|f\|:=\sup _{z \in \Gamma}|f(z)|, f \in \mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))
$$

Clearly, if $f \in \mathcal{H} o l(\Gamma \cup \operatorname{Int}(\Gamma))$, then $f^{(n)} \in \mathcal{H} o l(\Gamma \cup \operatorname{Int}(\Gamma))$ for every $n \in \mathbb{N}$, where $f^{(n)}$ denotes the $n$-th order derivative of $f$.

A sub-algebra $\mathfrak{A}$ of $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$ is said to be nowhere vanishing and point separating at $\Gamma$ if for every $z \in \Gamma$, there exists $f \in \mathfrak{A}$ such that $f(z) \neq 0$, and for every $z_{1}, z_{2} \in \Gamma$, there exists $g \in \mathfrak{A}$ such that $g\left(z_{1}\right) \neq g\left(z_{2}\right)$. Throughout this article, we call these sub-algebras as nowhere vanishing point separating sub-algebras of $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$, without any ambiguity.

For a given choice of $\Gamma \subset \mathbb{C}$, define:

$$
\begin{equation*}
\mathcal{J}(\Gamma):=\{f \in \mathcal{H} o l(\Gamma \cup \operatorname{Int}(\Gamma)):|f(z)|=\|f\| \forall z \in \Gamma\} \tag{1.1}
\end{equation*}
$$

and for a given $f \in \mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$, set:

$$
\begin{align*}
M_{f} & :=\{z \in \Gamma:|f(z)|=\|f\|\}  \tag{1.2}\\
\mathcal{Z}_{f} & :=\{z \in \Gamma \cup \operatorname{Int}(\Gamma): f(z)=0\} \tag{1.3}
\end{align*}
$$

For example, if $\Gamma=\{z \in \mathbb{C}:|z|=r\}$ for some $r>0$, then $f \in \mathcal{J}(\Gamma)$ if and only if $f$ is constant or

$$
f(z)=c \prod_{k=1}^{n}\left(\frac{z-r a_{k}}{r-\overline{a_{k}} z}\right), z \in \Gamma \cup \operatorname{Int}(\Gamma)
$$

for some $c \in \mathbb{C} \backslash\{0\}, n \in \mathbb{N}$ and $a_{k} \in \mathbb{D}$ for $1 \leq k \leq n$, where $\mathbb{D}$ denotes the open unit disc in $\mathbb{C}$.

For a given $z \in \mathbb{C}$, the real and the imaginary parts of $z$ are denoted by $\Re(z)$ and $\Im(z)$, respectively. If additionally, $z \neq 0$, let $\arg (z)$ denote the real number $\theta \in[0,2 \pi)$ such that $z=|z| e^{i \theta}$. Also, the sign function sgn : $\mathbb{C} \rightarrow \mathbb{C}$ is defined by

$$
\operatorname{sgn}(z):=\left\{\begin{array}{l}
\frac{z}{|z|}, z \neq 0 \\
0, z=0
\end{array}\right.
$$

Given a normed linear space $X$, let $B_{X}$ and $S_{X}$ denote the closed unit ball and the unit sphere of $X$ respectively, i.e.,

$$
B_{X}=\{x \in X:\|x\| \leq 1\}, \quad S_{X}=\{x \in X:\|x\|=1\}
$$

Let $X^{*}$ denote the continuous dual of $X$. For a non-zero element $x \in X$, we denote the collection of all support functionals at $x$ by $J(x)$, i.e.,

$$
J(x)=\left\{\Psi \in S_{X^{*}}: \Psi(x)=\|x\|\right\}
$$

Let $\operatorname{Ext}(X)$ denote the collection of all extreme points of $B_{X}$. An element $x \in B_{X}$ is said to be an exposed point of $B_{X}$ if $\|x\|=1$ and there exists $\Psi \in J(x)$ such that

$$
|\Psi(y)|=\|y\| \text { if and only if } y=c x \text { for some } c \in \mathbb{C}
$$

We denote the collection of all exposed points of $B_{X}$ by $\operatorname{Exp}(X)$. It is wellknown that $\operatorname{Exp}(X) \subseteq \operatorname{Ext}(X)$. For $x, y \in X, x$ is said to be Birkhoff-James orthogonal to $y$, denoted by $x \perp_{B} y$, if

$$
\|x+\lambda y\| \geq\|x\| \text { for all } \lambda \in \mathbb{C} .
$$

In [8], James proved that for $x, y \in X, x \perp_{B} y$ if and only if $x=0$ or there exists some $\Psi \in J(x)$ such that $\Psi(y)=0$. A non-zero element $x \in X$ is said to be smooth if $J(x)$ is singleton. James [8] proved that a non-zero $x \in X$ is smooth if and only if

$$
x \perp_{B} y, \quad x \perp_{B} z \Longrightarrow x \perp_{B}(y+z) \text { for all } y, z \in X
$$

In the first section of this article, we characterize the extreme points and the exposed points of any nowhere vanishing, point separating sub-algebra of $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$ for $\Gamma$ analytic. In the next section, we characterize BirkhoffJames orthogonality in the said sub-algebras and also identify its smooth points but for any simple closed curve $\Gamma$, not necessarily analytic. Characterizing the extreme points, the exposed points and the smooth points of the closed unit ball of a given normed linear space is of fundamental importance in determining the geometry of the space. We refer the readers to [1], [3], [4], [5], [7], [9], [10], [11], [12], [13], [14], [15] for some of the illustrative works in this regard.

In the final section, we find an interrelation between Birkhoff-James orthogonality in nowhere vanishing, point separating sub-algebras of $\mathcal{H o l}(\Gamma \cup$ Int $(\Gamma)$ ) with the zeros of holomorphic functions using some classical concepts of complex analysis.

## 2. Geomtery of $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$ for $\Gamma$ simple, closed and analytic

We begin with a couple of simple propositions. In the first one, we characterize the set $\mathcal{J}(\Gamma)$ for $\Gamma \subset \mathbb{C}$ analytic.
Proposition 2.1. Let $\Gamma \subset \mathbb{C}$ be a simple closed analytic curve and let $f$ : $\operatorname{Int}(\Gamma) \rightarrow \mathbb{D}$ be an onto biholomorphic map. Then
(i) $f$ extends to a biholomorphic function $F: U \rightarrow \mathbb{C}$ for some neighborhood $U$ of $\Gamma \cup \operatorname{Int}(\Gamma)$ such that $F(\Gamma \cup \operatorname{Int}(\Gamma))=\overline{\mathbb{D}}$.
(ii) $h \in \mathcal{J}(\Gamma)$ if and only if $h$ is constant or

$$
h(z)=c \prod_{k=1}^{n}\left(\frac{F(z)-a_{k}}{1-\overline{a_{k}} F(z)}\right), z \in \Gamma \cup \operatorname{Int}(\Gamma)
$$

for some $c \in \mathbb{C} \backslash\{0\}, n \in \mathbb{N}$ and $a_{k} \in \mathbb{D}$ for $1 \leq k \leq n$.

Proof. The first part of the proposition follows from the observation that for every $z \in \Gamma$, there exists $U_{z} \subset \mathbb{C}$ open such that $\Gamma \cap U_{z}$ is a one-sided free arc of $\Gamma$ containing $z$ and hence $f$ can be extended biholomorphically to some neighborhood $V_{z}$ of $\Gamma \cap U_{z}$, using the Schwarz reflection principle (see [2, Theorem 4, p. 235] for details). The desired $F$ is now obtained by considering the extensions on $V_{z}$ for every $z \in \Gamma$ and restricting the function on a sufficiently small neighborhood of $\Gamma \cup \operatorname{Int}(\Gamma)$ so that it remains injective.

The second part follows from the observation that $T: \mathcal{H o l}(\overline{\mathbb{D}}) \rightarrow$ $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$ given by

$$
\begin{equation*}
T(g)(z):=g \circ F(z), z \in F^{-1}\left(U_{g}\right), \tag{2.1}
\end{equation*}
$$

where $\overline{\mathbb{D}} \subset U_{g}$ open and $g: U_{g} \rightarrow \mathbb{C}$ holomorphic is an isometric isomorphism and $T(g) \in \mathcal{J}(\Gamma)$ if and only if $|g(z)|=\|g\|$ for every $|z|=1$.

The second proposition pertains to the completion of $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$ for arbitrary simple closed curves $\Gamma \subset \mathbb{C}$ (not necessarily analytic). The result follows easily from the observation that $\mathcal{H}$ ol $(\Gamma \cup \operatorname{Int}(\Gamma))$ contains all the polynomials.

Proposition 2.2. If $\Gamma \subset \mathbb{C}$ is a simple closed curve, then $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$ is incomplete and its completion is isometrically isomorphic to

$$
\mathcal{A}(\operatorname{Int}(\Gamma)):=\{f \in \mathcal{H} o l(\operatorname{Int}(\Gamma)): f \text { extends continuously on } \Gamma \cup \operatorname{Int}(\Gamma)\}
$$

equipped with the supremum norm.
Now, we characterize the extreme points and the exposed points of the closed unit ball of any nowhere vanishing, point separating sub-algebra of $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$ for $\Gamma$ simple, closed and analytic. We begin with a preliminary lemma.

Lemma 2.3. Let $\Gamma \subset \mathbb{C}$ be a simple closed analytic curve. Let $X=\mathcal{H o l}(\Gamma \cup$ $\operatorname{Int}(\Gamma)$ ) and let $f \in S_{X}$. If $z_{0} \in \Gamma$ is an isolated point of $M_{f}$ (see (1.2)) and $f\left(z_{0}\right)=e^{i \theta_{0}}$ for some $\theta_{0} \in[0,2 \pi)$, then

$$
\begin{equation*}
\lim _{\substack{z \rightarrow z_{0} \\ z \in \Gamma}}\left|z-z_{0}\right|^{r} \frac{\left|e^{i \theta_{0}}-f(z)\right|}{1-|f(z)|}=0 \tag{2.2}
\end{equation*}
$$

for some natural number $r$.
Proof. Replacing $f$ by $e^{-i \theta_{0}} f$, we may and do assume that $f\left(z_{0}\right)=1$. Also, let $f$ be holomorphic on the domain $\Omega \supset \Gamma \cup \operatorname{Int}(\Gamma)$. Choose a neighborhood $N$ of $z_{0}$, contained in $\Omega$ such that $|f(z)|<1$ for every $z \in(\Gamma \cap N) \backslash\left\{z_{0}\right\}$. Set $g(z):=1-f(z)$ on $N$. Then $g$ is holomorphic on $N$ and has a zero at $z=z_{0}$. Let $m_{0}$ be the multiplicity of the zero of $g$ at $z=z_{0}$. Then there exists a
neighbourhood $N^{\prime}$ of $z_{0}$ and a holomorphic function $h: N^{\prime} \rightarrow \mathbb{C}$ with $h\left(z_{0}\right) \neq 0$ such that:

$$
g(z)=\left(z-z_{0}\right)^{m_{0}} h(z), z \in N^{\prime}
$$

Now, observe that

$$
\begin{equation*}
\left|z-z_{0}\right|^{r} \frac{|1-f(z)|}{1-|f(z)|}=\left|z-z_{0}\right|^{r+m_{0}} \frac{|h(z)|}{1-|1-g(z)|}, \tag{2.3}
\end{equation*}
$$

and

$$
\begin{align*}
\frac{1}{1-|1-g(z)|} & =\frac{1+|1-g(z)|}{1-|1-g(z)|^{2}} \\
& =\frac{1+|1-g(z)|}{2 \Re(g(z))-|g(z)|^{2}} \tag{2.4}
\end{align*}
$$

Now, let $I \subset \mathbb{R}$ be some interval and $\gamma: I \rightarrow \mathbb{C}$ be an analytic parametrization of $\Gamma$ in some neighborhood of $z_{0}$. Since $g \circ \gamma$ is analytic on $I, \Re(g \circ \gamma)$ is a real-analytic function. Without loss of generality, we may and will assume that $0 \in I$ and $\gamma(0)=z_{0}$. Then $\Re(g \circ \gamma)$ has a zero at 0 and hence, there exist a natural number $k$, a neighbourhood $I^{\prime} \subset I$ of 0 and a real-analytic function $\nu: I^{\prime} \rightarrow \mathbb{R}$ with $\nu(0) \neq 0$ such that

$$
\begin{equation*}
g(\gamma(t))=t^{k} \nu(t), t \in I^{\prime} \tag{2.5}
\end{equation*}
$$

Also, by the analyticity of the function $t \mapsto \gamma(t)-z_{0}$, there exist a natural number $n$, a neighbourhood $I " \subset I$ of 0 and an analytic map $\psi: I " \rightarrow \mathbb{C}$ with $\psi(0) \neq 0$ such that

$$
\begin{equation*}
\gamma(t)-z_{0}=t^{n} \psi(t), t \in I^{\prime \prime} \tag{2.6}
\end{equation*}
$$

Now, to show that (2.2) holds for some $r \in \mathbb{N}$, applying (2.3), (2.4),(2.5) and (2.6) we need to show:

$$
\begin{aligned}
\lim _{t \rightarrow 0}\left|\gamma(t)-z_{0}\right|^{r+m_{0}} \frac{h \circ \gamma(t)(1+|1-g \circ \gamma(t)|)}{2 t^{k} \nu(t)-\left|\gamma(t)-z_{0}\right|^{2 m_{0}}|h \circ \gamma(t)|^{2}} & =0 \\
\Leftrightarrow \lim _{t \rightarrow 0}|t|^{n\left(r+m_{0}\right)}|\psi(t)|^{r+m_{0}} \frac{h \circ \gamma(t)(1+|1-g \circ \gamma(t)|)}{2 t^{k} \nu(t)-\left|t^{n} \psi(t)\right|^{2 m_{0}}|h \circ \gamma(t)|^{2}} & =0
\end{aligned}
$$

Clearly, choosing $r \in \mathbb{N}$ sufficiently large yields the result.
We now come to the first of our main results.
Theorem 2.4. Let $\Gamma \subset \mathbb{C}$ be a simple closed analytic curve and let $\mathfrak{A}$ be a nowhere vanishing, point separating sub-algebra of $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$. Then the following are equivalent:
(i) $f \in \operatorname{Exp}(\mathfrak{A})$.
(ii) $f \in \operatorname{Ext}(\mathfrak{A})$.
(iii) $\|f\|=1$ and $f \in J(\Gamma)$, i.e., $|f(z)|=1$ for every $z \in \Gamma$.

Proof. (i) $\Rightarrow$ (ii)
Elementary as discussed before.
(ii) $\Rightarrow$ (iii)

Suppose that $\Gamma \cup \operatorname{Int}(\Gamma) \subset \Omega$ is open and $f: \Omega \rightarrow \mathbb{C}$ is holomorphic. If $f \in$ $\operatorname{Ext}(\mathfrak{A})$, clearly, $f \in S_{\mathfrak{A}}$.

We first prove that $f \in J(\Gamma)$ if and only if $M_{f}$ is infinite. The only if part is clearly trivial and for the if part, let $z_{n} \in M_{f}$ be an infinite sequence such that $z_{n} \rightarrow z_{0}$. Consider an interval $I \subset \mathbb{R}$ such that $0 \in I$ and $\gamma: I \rightarrow \mathbb{C}$ is an analytic parametrization of $\Gamma$ in some neighbourhood of the point $z_{0}$ with $\gamma(0)=z_{0}$. Clearly, $|f \circ \gamma(t)|^{2}=(\Re(f \circ \gamma(t)))^{2}+(\Im(f \circ \gamma(t)))^{2}$ is real analytic on $I$. Since $|f \circ \gamma(t)|^{2}=1$ for infinitely many $t \in I$, by the identity theorem for real-analytic functions, $|f \circ \gamma(t)|=1$ for every $t \in I$. The result now follows using an elementary connectedness argument.

Now, assume for the sake of contradiction, $f \in S_{\mathfrak{A}}$ and $M_{f}=\left\{z_{1}, z_{2}, \ldots, z_{n}\right\}$ for some $n \in \mathbb{N}$. Then by Lemma 2.3, there exist $r_{k} \in \mathbb{N}$ such that

$$
\begin{equation*}
\lim _{\substack{z \vec{z} z_{k} \\ z \in \Gamma}}\left|z-z_{k}\right|^{r_{k}} \frac{\left|e^{i \theta_{k}}-f(z)\right|}{1-|f(z)|}=0 \tag{2.7}
\end{equation*}
$$

where $f\left(z_{k}\right)=e^{i \theta_{k}}$ for every $1 \leq k \leq n$. Also, let $m_{k}$ denote the multiplicity of the zero $z_{k}$ of the holomorphic map $e^{i \theta_{k}}-f(z), z \in \Omega$ for every $1 \leq k \leq n$.

Now, let $w_{1}, w_{2} \in \Gamma$ and $c_{1}, c_{2} \in \mathbb{C}$. Since $\mathfrak{A}$ is nowhere vanishing and point separating, there exist $h_{1}, h_{2}, h_{3} \in \mathfrak{A}$ such that

$$
h_{1}\left(w_{1}\right), h_{2}\left(w_{2}\right) \neq 0, \quad h_{3}\left(w_{1}\right) \neq h_{3}\left(w_{2}\right) .
$$

Then

$$
h:=\frac{c_{1}\left(h_{1} h_{3}-h_{3}\left(w_{2}\right) h_{1}\right)}{h_{1}\left(w_{1}\right)\left(h_{3}\left(w_{1}\right)-h_{3}\left(w_{2}\right)\right)}+\frac{c_{2}\left(h_{2} h_{3}-h_{3}\left(w_{1}\right) h_{2}\right)}{h_{2}\left(w_{2}\right)\left(h_{3}\left(w_{2}\right)-h_{3}\left(w_{1}\right)\right)},
$$

is well-defined and belongs to $\mathfrak{A}$ with $h\left(w_{1}\right)=c_{1}$ and $h\left(w_{2}\right)=c_{2}$.
Now, fix $z_{0} \in \Gamma \backslash M_{f}$. Then, there exist $f_{1}, f_{2}, \ldots f_{n} \in \mathfrak{A}$, such that $f_{k}\left(z_{k}\right)=0$ and $f_{k}\left(z_{0}\right)=1$ for every $1 \leq k \leq n$. Suppose $\Gamma \cup \operatorname{Int}(\Gamma) \subset U_{k}$ is open such that $f_{k}: U_{k} \rightarrow \mathbb{C}$ is holomorphic and $\mu_{k}$ is the multiplicity of the zero $z_{k}$ of the holomorphic map $f_{k}$ for every $1 \leq k \leq n$. Define $P: \Omega \cap\left(\bigcap_{k=1}^{n} U_{k}\right) \rightarrow \mathbb{C}$ by

$$
P(z):=\prod_{k=1}^{n}\left(f_{k}(z)\right)^{\left\lceil\frac{m_{k}+r_{k}}{\mu_{k}}\right\rceil}, z \in \Omega \cap\left(\bigcap_{k=1}^{n} U_{k}\right)
$$

where $\lceil\alpha\rceil=\min \{n \in \mathbb{Z}: \alpha \leq n\}$ for any $\alpha \in \mathbb{R}$. Then, since the multiplicity of the zero $z_{k}$ of $P$ is at least $m_{k}+r_{k}$, for every $1 \leq k \leq n$,

$$
P(z)=\left(z-z_{k}\right)^{m_{k}+r_{k}} G_{k}(z), z \in \Omega \cap\left(\bigcap_{k=1}^{n} U_{k}\right),
$$

for some $G_{k}: \Omega \cap\left(\bigcap_{k=1}^{n} U_{k}\right) \rightarrow \mathbb{C}$ holomorphic. Note that $G_{k}\left(z_{k}\right)$ may be zero for some $1 \leq k \leq n$. Therefore, for any $1 \leq k \leq n$, by (2.7),

$$
\lim _{\substack{z \rightarrow z_{k} \\ z \in \Gamma}} \frac{|P(z)|}{1-|f(z)|}=G_{k}\left(z_{k}\right) \lim _{\substack{z \rightarrow z_{k} \\ z \in \Gamma}} \frac{\left|z-z_{k}\right|^{m_{k}}}{\left|e^{i \theta_{k}}-f(z)\right|}\left|z-z_{k}\right|^{r_{k}} \frac{\left|e^{i \theta_{k}}-f(z)\right|}{1-|f(z)|}=0 .
$$

Fix $\epsilon>0$. Then there exist $N_{1}, N_{2}, \ldots, N_{n} \subset \mathbb{C}$ open such that $z_{k} \in N_{k}$ and

$$
\frac{|P(z)|}{1-|f(z)|}<\epsilon, z \in \Gamma \cap N_{k} \backslash\left\{z_{k}\right\}, 1 \leq k \leq n
$$

Since $\Gamma \backslash\left(\bigcup_{k=1}^{n} N_{k}\right)$ is compact and $z \mapsto \frac{|P(z)|}{1-|f(z)|}$ is continuous on $\Gamma \backslash\left(\bigcup_{k=1}^{n} N_{k}\right)$,

$$
\frac{|P(z)|}{1-|f(z)|} \leq M, z \in \Gamma \backslash\left(\bigcup_{k=1}^{n} N_{k}\right)
$$

for some $M>0$. Set $K=\max \{M, \epsilon\}$. Then

$$
|P(z)| \leq K(1-|f(z)|), z \in \Gamma
$$

Hence,

$$
|f(z)|+\left|\frac{1}{K} P(z)\right| \leq 1, z \in \Gamma
$$

Clearly, $\frac{1}{K} P \in \mathfrak{A}$ and $P\left(z_{0}\right)=1$. Hence $P \not \equiv 0$ proving $f \notin \operatorname{Ext}(\mathfrak{A})$.
(iii) $\Rightarrow(i)$

Let $f \in S_{\mathfrak{A}} \cap J(\Gamma)$. Fix $\left\{z_{n}: n \in \mathbb{N}\right\} \subset M_{f}=\Gamma$ such that $z_{n} \rightarrow z_{0}$ for some $z_{0}$. Consider $\Psi: \mathfrak{A} \rightarrow \mathbb{C}$ given by

$$
\Psi(h):=\sum_{n=1}^{\infty} \frac{\overline{\operatorname{sgn}\left(f\left(z_{n}\right)\right)}}{2^{n}} h\left(z_{n}\right), h \in \mathfrak{A}
$$

Then clearly, $\Psi$ is unit norm functional on $\mathfrak{A}$ and $\Psi(f)=\|f\|$. Also, $|\Psi(h)|=\|h\|$ for some $h \in \mathfrak{A}$ if and only if

$$
h\left(z_{n}\right)=e^{i \theta_{0}}\|h\| f\left(z_{n}\right),
$$

for every $n \in \mathbb{N}$ and some fixed $\theta_{0} \in[0,2 \pi)$. Since $f$ and $h$ are holomorphic on some connected neighborhood of $\Gamma \cup \operatorname{Int}(\Gamma)$, by identity theorem, $h=e^{i \theta_{0}}\|h\| f$ proving $f \in \operatorname{Exp}(\mathfrak{A})$.

Clearly, if $\Gamma$ is not analytic, there exist functions $f \in \operatorname{Ext}(\mathcal{H o l}(\Gamma \cup$ $\operatorname{Int}(\Gamma)))$ such that $M_{f} \neq \Gamma$. The following simple example illustrates this:

Example 2.5. Let $\Gamma:=\left\{e^{i t}: t \in[0, \pi]\right\} \cup[-1,1]$. Then any monomial $h_{n}:=$ $z^{n}, z \in \mathbb{C}$ is not in $\mathcal{J}(\Gamma)$ but is an extreme point of the closed unit ball of $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$, since $M_{h_{n}}=\left\{e^{i t}: t \in[0, \pi]\right\}$ is an infinite set and therefore if $h_{n}=\frac{1}{2}(f+g)$ for some $f, g \in S_{\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))}$, then $h_{n}=f=g$ on $M_{h_{n}}$ proving $f=h_{n}=g$ by the identity theorem.

Proposition 2.1 and Theorem 2.4 completely characterize the extreme points of the closed unit ball of $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$ for simple closed analytic curves $\Gamma \subset \mathbb{C}$ as $B \circ F$ where $B$ is a finite Blaschke product or a unimodualr constant function on $\mathbb{D}$ and $F$ is a holomorphic extension of the Riemann map $f: \operatorname{Int}(\Gamma) \rightarrow$ $\mathbb{D}$ on some neighborhood of $\Gamma \cup \operatorname{Int}(\Gamma)$. Let us recall the characterization of the extreme points of the closed unit ball of the disc algebra $\mathcal{A}(\mathbb{D})$ from [6, p.139] given by:

Theorem 2.6. A function $f \in \operatorname{Ext}(\mathcal{A}(\mathbb{D}))$ if and only if $|f| \leq 1$ on $\overline{\mathbb{D}}$ and

$$
\int_{0}^{2 \pi} \ln \left(1-\left|f\left(e^{i t}\right)\right|\right) d t=-\infty
$$

Hence clearly, if $f$ is an extreme point of the closed unit ball of $\mathcal{H o l}(\overline{\mathbb{D}})$, $f \in \operatorname{Ext}(\mathcal{A}(\mathbb{D}))$. Also observing that the map $T$ defined in (2.1) can be extended to an isometric isomorphism from $\mathcal{A}(\mathbb{D})$ onto $\mathcal{A}(\operatorname{Int}(\Gamma)$ ), we can conclude the following corollary:

Corollary 2.7. If $\Gamma \subset \mathbb{C}$ is a simple closed analytic curve, any extreme point of the closed unit ball of any nowhere vanishing, point separating sub-algebra of $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$ is an extreme point of the closed unit ball of its completion $\mathcal{A}(\operatorname{Int}(\Gamma))$.

The converse of this result is not true, i.e., there exist extreme points of the closed unit ball of the disc algebra $\mathcal{A}(\mathbb{D})$ that are not holomorphic on any neighborhood of $\overline{\mathbb{D}}$ as illustrated by the following example. Note that any function $f \in \operatorname{Ext}(\mathcal{A}(\mathbb{D}))$ which is holomorphic in some neighborhood of $\overline{\mathbb{D}}$ must be an extreme point of the closed unit ball of $\mathcal{H o l}(\overline{\mathbb{D}})$, i.e., in particular, $f$ must be a finite Blaschke product or a unimodular constant.

Example 2.8. Let $g:[0,2 \pi] \rightarrow[0,1)$ be a continuous function such that $g(t)=$ $e^{-n}$ on $\left[\frac{1}{2 n}, \frac{1}{2 n-1}\right] ; n \in \mathbb{N}$ with $g(0)=g(2 \pi)=0, g$ is increasing on $[0,1]$ and strictly decreasing on $[1,2 \pi]$. Note that $\ln (1-g(t))$ is continuous and of
bounded variation. Consider $f: \mathbb{D} \rightarrow \mathbb{C}$ given by

$$
f(z):=\exp \left[\frac{1}{2 \pi} \int_{0}^{2 \pi}\left(\frac{e^{i t}+z}{e^{i t}-z}\right) \ln (1-g(t)) d t\right], \quad z \in \mathbb{D} .
$$

Then $f$ is holomorphic on $\mathbb{D}$ and has absolutely summable Taylor coefficients by Hardy's Theorem [6, p.70]. Hence $f$ can be extended continuously to the boundary of $\mathbb{D}$, i.e., $f \in \mathcal{A}(\mathbb{D})$. Also, $\left|f\left(e^{i t}\right)\right|=1-g(t)$ for $t \in[0,2 \pi)$ and so $|f| \leq 1$ on $\overline{\mathbb{D}}$. Further,

$$
\int_{0}^{2 \pi} \ln \left(1-\left|f\left(e^{i t}\right)\right|\right) d t=\int_{0}^{2 \pi} \ln (g(t)) d t \leq \sum_{n=1}^{\infty} \frac{-n}{2 n(2 n-1)}=-\infty
$$

proving $f \in \operatorname{Ext}(\mathcal{A}(\mathbb{D}))$. However, $f\left(e^{i t}\right)=1$ for $t \in[0,2 \pi)$ if and only if $t=0$. Therefore, $f \notin \operatorname{Ext}(\mathcal{H o l}(\overline{\mathbb{D}}))$, i.e., $f \notin \mathcal{H o l}(\overline{\mathbb{D}})$.

## 3. Birkhoff-James orthogonality and characterization of smooth POINTS OF $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$

Now, we characterize Birkhoff-James orthogonality of two elements in any nowhere vanishing, point separating sub-algebra of $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$ for a simple closed curve $\Gamma \subset \mathbb{C}$. We begin by providing two sufficient conditions.

Proposition 3.1. Let $\Gamma \subset \mathbb{C}$ be a simple closed curve, and $\mathfrak{A}$ be a nowhere vanishing, point separating sub-algebra of $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$. Let $f_{1}, f_{2} \in \mathfrak{A}$.
(i) If for every $\theta \in[0,2 \pi)$ there exists $z \in M_{f_{1}}$ such that $\arg \frac{f_{2}(z)}{f_{1}(z)}=\theta$, then $f_{1} \perp_{B} f_{2}$.
(ii) If there exists $z \in M_{f_{1}} \cap \mathcal{Z}_{f_{2}}$, then $f_{1} \perp_{B} f_{2}$ (see (1.3) for definition of $\mathcal{Z}_{f}$ ).

Proof. (i) For $\lambda=0,\left\|f_{1}+\lambda f_{2}\right\|=\left\|f_{1}\right\|$. If instead, $\lambda=r e^{i \phi}$ for some $r>0$ and $\phi \in(0,2 \pi]$, then by the hypotheses, there exists $z \in M_{f_{1}}$ such that $\arg \frac{f_{2}(z)}{f_{1}(z)}=$ $2 \pi-\phi$. Let $\frac{f_{2}(z)}{f_{1}(z)}=r_{1} e^{i(2 \pi-\phi)}$ for some $r_{1}>0$. Then clearly,

$$
\left\|f_{1}+\lambda f_{2}\right\| \geq\left|f_{1}(z)+\lambda f_{2}(z)\right| \geq\left\|f_{1}\right\|
$$

Since $\lambda \in \mathbb{C} \backslash\{0\}$ was chosen arbitrarily, $f_{1} \perp_{B} f_{2}$.
(ii) This is immediate since for $\lambda \in \mathbb{C}$ arbitrary,

$$
\left\|f_{1}+\lambda f_{2}\right\| \geq\left|f_{1}(z)+\lambda f_{2}(z)\right|=\left\|f_{1}\right\|
$$

The following corollary follows directly from the first part of the above proposition.

Corollary 3.2. Let $\Gamma:=\{z \in \mathbb{C}:|z|=r\}$. Let $h_{j}(z):=z^{j}, z \in \mathbb{C}$ for $j \in \mathbb{N}$. Then $h_{n} \perp_{B} h_{m}$ for $m \neq n$ in any nowhere vanishing, point separating sub-algebra of $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$ containing all the monomials.

In order to completely characterize the Birkhoff-James orthogonality of two elements in any nowhere vanishing, point separating sub-algebra of $\mathcal{H o l}(\Gamma \cup$ $\operatorname{Int}(\Gamma)$ ), we introduce the following definition.

Definition 3.3. A subset $A \subseteq \mathbb{C}^{2}$ is said to be an orthogonality covering set if

$$
\mathbb{C}=\bigcup_{(u, v) \in A}\{\lambda \in \mathbb{C}:|u+\lambda v| \geq|u|\}
$$

We furnish the following two examples illustrating the idea.
Example 3.4. $A=\left\{\left(z_{1}, z_{2}\right)\right\} \subset \mathbb{C}^{2}$ is an orthogonality covering set if and only if $z_{1}=0$ or $z_{2}=0$.

Example 3.5. $A=\left\{\left(z_{1}, z_{2}\right),\left(w_{1}, w_{2}\right)\right\} \subset \mathbb{C}^{2}$ is an orthogonality covering set if and only if $\overline{z_{1}} z_{2} w_{1} \overline{w_{2}} \in(-\infty, 0]$.
Theorem 3.6. Let $\Gamma \subset \mathbb{C}$ be a simple closed curve, and $\mathfrak{A}$ be a nowhere vanishing, point separating sub-algebra of $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$. Let $f_{1}, f_{2} \in \mathfrak{A}$. Then
$f_{1} \perp_{B} f_{2} \Leftrightarrow\left\{\left(f_{1}(z), f_{2}(z)\right): z \in M_{f_{1}}\right\}$ is an orthogonality covering set.
Proof. Let $A=\left\{\left(f_{1}(z), f_{2}(z)\right): z \in M_{f_{1}}\right\}$. First we prove the necessity. Suppose by contradiction that $A$ is not an orthogonality covering set. Then there exists $\lambda \in \mathbb{C}$ such that

$$
\left|f_{1}(z)+\lambda f_{2}(z)\right|<\left|f_{1}(z)\right| \text { for all } z \in M_{f_{1}}
$$

We claim that $\left|f_{1}(z)+\mu \lambda f_{2}(z)\right|<\left|f_{1}(z)\right|$ for all $z \in M_{f_{1}}$ and for all $\mu \in(0,1)$. Indeed for $z_{0} \in M_{f_{1}}$ and $\mu_{0} \in(0,1)$,

$$
f_{1}\left(z_{0}\right)+\mu_{0} \lambda f_{2}\left(z_{0}\right)=\left(1-\mu_{0}\right) f_{1}\left(z_{0}\right)+\mu_{0}\left(f_{1}\left(z_{0}\right)+\lambda f_{2}\left(z_{0}\right)\right)
$$

The claim now follows:

$$
\begin{aligned}
\left|f_{1}\left(z_{0}\right)+\mu_{0} \lambda f_{2}\left(z_{0}\right)\right| & =\left|\left(1-\mu_{0}\right) f_{1}\left(z_{0}\right)+\mu_{0}\left(f_{1}\left(z_{0}\right)+\lambda f_{2}\left(z_{0}\right)\right)\right| \\
& <\left(1-\mu_{0}\right)\left|f_{1}\left(z_{0}\right)\right|+\mu_{0}\left|f_{1}\left(z_{0}\right)\right| \\
& =\left|f_{1}\left(z_{0}\right)\right|
\end{aligned}
$$

Now, let $g: \Gamma \times[-1,1] \longrightarrow \mathbb{R}$ be defined by

$$
g(z, \mu):=\left|f_{1}(z)+\mu \lambda f_{2}(z)\right|, z \in \Gamma,-1 \leq \mu \leq 1
$$

Clearly, $g$ is continuous. Let $z_{0} \in M_{f_{1}}$ and $\mu_{z_{0}} \in(0,1)$. Then from the claim,

$$
g\left(z_{0}, \mu_{z_{0}}\right)<\left\|f_{1}\right\| .
$$

From the continuity of $g$, there exist $\epsilon_{z_{0}}>0$ and $\delta_{z_{0}}>0$ such that

$$
g(z, \sigma)<\left\|f_{1}\right\| \text { for all } \quad(z, \sigma) \in B\left(z_{0}, \epsilon_{z_{0}}\right) \times\left(\mu_{z_{0}}-\delta_{z_{0}}, \mu_{z_{0}}+\delta_{z_{0}}\right)
$$

In particular, $g\left(z, \mu_{z_{0}}\right)<\left\|f_{1}\right\|$ for all $z \in B\left(z_{0}, \epsilon_{z_{0}}\right)$. Thus, clearly from our claim,

$$
g(z, \sigma)<\left\|f_{1}\right\| \text { for all }(z, \sigma) \in B\left(z_{0}, \epsilon_{z_{0}}\right) \times\left(0, \mu_{z_{0}}\right)
$$

Similarly, if $u_{0} \in \Gamma \backslash M_{f_{1}}$, then $g\left(u_{0}, 0\right)<\left\|f_{1}\right\|$. Again, from the continuity of $g$, there exist $\epsilon_{u_{0}}>0$ and $\delta_{u_{0}}>0$ such that

$$
g(z, \alpha)<\left\|f_{1}\right\| \text { for all }(z, \alpha) \in B\left(u_{0}, \epsilon_{u_{0}}\right) \times\left(-\delta_{u_{0}}, \delta_{u_{0}}\right)
$$

Now,

$$
\Gamma \subseteq \bigcup_{z \in M_{f_{1}}} B\left(z, \epsilon_{z}\right) \cup \bigcup_{u \in \Gamma \backslash M_{f_{1}}} B\left(u, \epsilon_{u}\right)
$$

Since $\Gamma$ is compact, there exist $z_{1}, z_{2}, \ldots, z_{k_{1}} \in M_{f_{1}}$ and $u_{1}, u_{2}, \ldots, u_{k_{2}} \in \Gamma \backslash M_{f_{1}}$ such that

$$
\Gamma \subseteq \bigcup_{i=1}^{k_{1}} B\left(z_{i}, \epsilon_{z_{i}}\right) \cup \bigcup_{j=1}^{k_{2}} B\left(u_{j}, \epsilon_{u_{j}}\right) .
$$

Choose $\sigma_{0}>0$ such that $\sigma_{0}<\mu_{z_{i}}$ and $\sigma_{0}<\delta_{u_{j}}$ for all $1 \leq i \leq k_{1}$ and $1 \leq j \leq k_{2}$. Clearly, $\left(f_{1}+\sigma_{0} \lambda f_{2}\right) \in \mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$. Let $w_{0} \in M_{\left(f_{1}+\sigma_{0} \lambda f_{2}\right)}$. Now, either $w_{0} \in \bigcup_{i=1}^{k_{1}} B\left(z_{i}, \epsilon_{z_{i}}\right)$, or $w_{0} \in \bigcup_{j=1}^{k_{2}} B\left(u_{j}, \epsilon_{u_{j}}\right)$. However, in either case, from the choice of $\sigma_{0}$,

$$
\left\|f_{1}+\sigma_{0} \lambda f_{2}\right\|=\left|f_{1}\left(w_{0}\right)+\sigma_{0} \lambda f_{2}\left(w_{0}\right)\right|<\left\|f_{1}\right\|,
$$

proving $f_{1} \not \chi_{B} f_{2}$.
We now prove the sufficiency. Let $\kappa \in \mathbb{C}$ be arbitrary. Since $A$ is an orthogonality covering set, there exists $v \in M_{f_{1}}$ such that $\left|f_{1}(v)+\kappa f_{2}(v)\right| \geq\left|f_{1}(v)\right|$. Thus,

$$
\left\|f_{1}+\kappa f_{2}\right\|=\sup _{z \in \Gamma}\left|f_{1}(z)+\kappa f_{2}(z)\right| \geq\left|f_{1}(v)+\kappa f_{2}(v)\right| \geq\left\|f_{1}\right\| .
$$

Since $\kappa$ was chosen arbitrarily, $f_{1} \perp_{B} f_{2}$.
Next, we characterize the smoothness of an element in any nowhere vanishing, point separating sub-algebra of $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$.

Theorem 3.7. Let $\Gamma \subset \mathbb{C}$ be a simple closed curve, and $\mathfrak{A}$ be a nowhere vanishing, point separating sub-algebra of $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$. Let $f \in \mathfrak{A}$ be non-zero. Then $f$ is a smooth point in $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$ if and only if $M_{f}$ is a singleton set.

Proof. We first prove the necessity. Suppose by contradiction that $z_{1} \neq z_{2} \in M_{f}$. Define $\Psi, \Phi: \mathfrak{A} \rightarrow \mathbb{C}$ by

$$
\Psi(h):=\overline{\operatorname{sgn}\left(f\left(z_{1}\right)\right)} h\left(z_{1}\right), \quad \Phi(h):=\overline{\operatorname{sgn}\left(f\left(z_{2}\right)\right)} h\left(z_{2}\right), h \in \mathfrak{A} .
$$

Then $\Psi$ and $\Phi$ are two support functionals of $f$. Also, $\Psi \neq \Phi$ since $\mathfrak{A}$ is nowhere vanishing and point separating proving $f$ is not a smooth point of $\mathfrak{A}$.
To prove the sufficiency, let $M_{f}=\left\{z_{1}\right\}$. Let $f \perp_{B} g$ and $f \perp_{B} h$ for some $g, h \in \mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$. If either of $g, h$ is zero, then trivially $f \perp_{B}(g+h)$. Let $g, h$ be non-zero. From Theorem 3.6, $\left\{(f(z), g(z)): z \in M_{f}\right\}$ is a singleton orthogonality covering set. Therefore, by Example 3.4, $g\left(z_{1}\right)=0$. A similar argument shows $h\left(z_{1}\right)=0$. Hence $z_{1} \in \mathcal{Z}_{g+h}$ and consequently by Proposition 3.1, $f \perp_{B}(g+h)$.

## 4. $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$ and ZEROS OF holomorphic functions

We begin this section with a simple observation:
Proposition 4.1. Let $\Gamma \subset \mathbb{C}$ be a simple closed curve. Let $f \in \mathcal{J}(\Gamma)$ (see (1.1)). Then either $f$ is constant on $\Gamma \cup \operatorname{Int}(\Gamma)$ or $f$ has a zero enclosed by $\Gamma$.

Proof. Suppose by contradiction that $f$ is non-zero on $\Omega^{\prime}:=\operatorname{Int}(\Gamma)$. Hence, the minimum modulus principle yields

$$
\min _{z \in \Gamma \cup \Omega^{\prime}}|f(z)|=\min _{z \in \Gamma}|f(z)|=\|f\|
$$

Thus, $f\left(\Omega^{\prime}\right) \subseteq\left\{\|f\| e^{i \theta}: \theta \in[0,2 \pi)\right\}$. Clearly, $f\left(\Omega^{\prime}\right)$ is not open in $\mathbb{C}$ while $\Omega^{\prime}$ is and hence, $f$ must be constant on $\Omega$.

The first result of this section shows that Birkhoff-James orthogonality in nowhere vanishing, point separating sub-algebras of $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$ has a deep connection with the zeros of holomorphic functions.

Theorem 4.2. Let $\Gamma \subset \mathbb{C}$ be a simple closed curve, and $\mathfrak{A}$ be a nowhere vanishing, point separating sub-algebra of $\mathcal{H}$ ol $(\Gamma \cup \operatorname{Int}(\Gamma))$. Let $f \in \mathcal{J}(\Gamma) \cap \mathfrak{A}$ and let $g \in \mathfrak{A}$. Then $f \not \mathscr{L}_{B} g$ implies $f$ and $g$ have the same number of zeros enclosed by $\Gamma$.

Proof. Since $f \not \chi_{B} g$, there exists $\lambda \in \mathbb{C} \backslash\{0\}$ such that $\|f+\lambda g\|<\|f\|$. Now, since $f \in \mathcal{J}(\Gamma)$,

$$
|f(z)+\lambda g(z)| \leq\|f+\lambda g\|<\|f\|=|f(z)|, \forall z \in \Gamma
$$

Since, $f$ and $-\lambda g$ are holomorphic within and on $\Gamma$, by Rouche's Theorem, they have the same number of zeros enclosed by $\Gamma$, establishing the result.

The converse of the above theorem is not true as illustrated in the following example:

Example 4.3. Let $\Gamma:=\{z \in \mathbb{C}:|z|=1\}$. Let $f_{1}(z)=z$ and let $f_{2}(z)=z(z-1)$. Clearly, $f_{1} \in \mathcal{J}(\Gamma)$. Since $1 \in M_{f_{1}} \cap \mathcal{Z}_{f_{2}}$, by Proposition 3.1, $f_{1} \perp_{B} f_{2}$. However, $f_{1}$ and $f_{2}$ have the same number of zeros enclosed by $\Gamma$.

It follows from the above theorem that if $\mathfrak{A}$ is any nowhere vanishing, point separating sub-algebra of $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$ with $f \in \mathcal{J}(\Gamma) \cap \mathfrak{A}$, then for any $g \in \mathfrak{A}$ with $f$ and $g$ having different number of zeros enclosed by $\Gamma, f \perp_{B} g$. We record this observation in form of the following theorem.

Theorem 4.4. Let $\Gamma \subset \mathbb{C}$ be a simple closed curve, and $\mathfrak{A}$ be a nowhere vanishing, point separating sub-algebra of $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$. Let $f \in \mathcal{J}(\Gamma) \cap \mathfrak{A}$ and let $g \in \mathfrak{A}$. If $f$ and $g$ have different number of zeros enclosed by $\Gamma$, then $f \perp_{B} g$.

It is easy to see that Corollary 3.2 is also a direct consequence of Theorem 4.4. We derive from Theorem 4.4 the following important inequality regarding polynomials.
Corollary 4.5. Let $\Gamma:=\{z \in \mathbb{C}:|z|=r\}$. Let $h_{j}(z):=z^{j}, z \in \mathbb{C}$ for $j \in \mathbb{N}$. Then

$$
\inf _{\lambda \in \mathbb{C}} \max _{z \in \Gamma}\left|h_{n}(z)+\lambda Q_{m}(z)\right| \geq r^{n} \text { for every polynomial } Q_{m} \text { of degree } m<n .
$$

Proof. Clearly, $h_{j} \in \mathcal{J}(\Gamma)$ for every $j \in \mathbb{N}$. Now, $Q_{m}$ and $h_{n}$ have different number of zeros enclosed by $\Gamma$. Therefore, by Theorem 4.4, $h_{n} \perp_{B} P_{m}$ in $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$ for all $m<n$. Thus, we have for every $\lambda \in \mathbb{C}$,

$$
\max _{z \in \Gamma}\left|h_{n}(z)+\lambda Q_{m}(z)\right|=\left\|h_{n}+\lambda Q_{m}\right\| \geq\left\|h_{n}\right\|=r^{n}
$$

and the result follows.
Our next result relates Birkhoff-James orthogonality in $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$ for a simple closed curve $\Gamma \subset \mathbb{C}$ with the fundamental theorem of algebra.

Theorem 4.6. Let $\Gamma:=\{z \in \mathbb{C}:|z|=r\}$ and $h_{j}(z):=z^{j}, z \in \mathbb{C}$ for $j \in \mathbb{N}$. If $Q(z):=a_{n} z^{n}+a_{n-1} z^{n-1}+\cdots+a_{0}, z \in \mathbb{C}$ with $a_{n} \neq 0$ and $r>$ $\max \left\{1, \frac{1}{\left|a_{n}\right|} \sum_{k=0}^{n-1}\left|a_{k}\right|\right\}$, then $h_{n} \not \chi_{B} P$ in $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$.
Proof. Since $r>\max \left\{1, \frac{1}{\left|a_{n}\right|} \sum_{k=0}^{n-1}\left|a_{k}\right|\right\}$,

$$
\begin{aligned}
\left\|a_{n} h_{n}-Q\right\| & =\left\|-\left(a_{n-1} h_{n-1}+a_{n-2} h_{n-2}+\cdots+a_{0}\right)\right\| \\
& \leq\left\|a_{n-1} h_{n-1}\right\|+\left\|a_{n-2} h_{n-2}\right\|+\cdots+\left\|a_{1} h_{1}\right\|+\left|a_{0}\right| \\
& \leq r^{n-1}\left\{\left|a_{n-1}\right|+\left|a_{n-2}\right|+\cdots+\left|a_{0}\right|\right\} \\
& <r^{n}\left|a_{n}\right| \\
& =\left|a_{n}\right|\left\|h_{n}\right\| .
\end{aligned}
$$

Thus, $\left\|h_{n}-\frac{1}{a_{n}} Q\right\|<\left\|h_{n}\right\|$, giving $h_{n} \not \chi_{B} Q$.
We now obtain the fundamental theorem of algebra:
Corollary 4.7 (Fundamental Theorem of Algebra). A polynomial of degree $n$ has $n$ zeros in $\mathbb{C}$.
Proof. Let $Q(z)=a_{n} z^{n}+a_{n-1} z^{n-1}+\cdots+a_{0}, a_{n} \neq 0$ and $r>\max \left\{1, \frac{1}{\left|a_{n}\right|} \sum_{k=0}^{n-1}\left|a_{k}\right|\right\}$. Set $\Gamma:=\{z \in \mathbb{C}:|z|=r\}$ and $h_{j}(z):=z^{j}, z \in \mathbb{C}$ for $j \in \mathbb{N}$. Then by Theorem 4.6, $h_{n} \not \chi_{B} Q$. Since $h_{n} \in \mathcal{J}(\Gamma)$, by Theorem $4.2, h_{n}$ and $Q$ have the same number of zeros enclosed by $\Gamma$. Since $r>\max \left\{1, \frac{1}{\left|a_{n}\right|} \sum_{k=0}^{n-1}\left|a_{k}\right|\right\}$ was chosen arbitrarily, $P$ has $n$ number of zeros in $\mathbb{C}$.

Finally, we obtain a result regarding Birkhoff-James orthogonality between the $n$-th order derivatives of two holomorphic functions in $\mathcal{H o l}(\Gamma \cup \operatorname{Int}(\Gamma))$ for a simple closed curve $\Gamma \subset \mathbb{C}$. The result also has a connection between Birkhoff-James orthogonality and zeros of the $n$-th order derivatives of holomorphic functions.

Theorem 4.8. Let $\Gamma_{1}, \Gamma_{2} \subset \mathbb{C}$ be two simple closed curves such that $\Gamma_{2} \subset$ $\operatorname{Int}\left(\Gamma_{1}\right)$ and fix $0<r<\operatorname{dist}\left(\Gamma_{1}, \Gamma_{2}\right)$. Let $f, g \in \mathcal{H o l}\left(\Gamma_{1} \cup \operatorname{Int}\left(\Gamma_{1}\right)\right)$ be such that $g^{(n)} \neq 0$ for some fixed natural number $n$ and

$$
\max _{z \in \Gamma_{1}}\left|f(z)+\lambda_{0} g(z)\right|<\frac{r^{n}}{n!} \max _{z \in \Gamma_{2}}\left|f^{(n)}(z)\right| \text { for some } \lambda_{0} \in \mathbb{C}
$$

Then $f^{(n)} \not \perp_{B} g^{(n)}$ in any nowhere vanishing, point separating sub-algebra of $\mathcal{H o l}\left(\Gamma_{2} \cup \operatorname{Int}\left(\Gamma_{2}\right)\right)$ containing both the functions.

Using Theorem 4.2, we immediately derive the following:
Corollary 4.9. Let $\Gamma_{1}, \Gamma_{2}, r$ be as in Theorem 4.8. Let f, $g \in \mathcal{H o l}\left(\Gamma_{1} \cup \operatorname{Int}\left(\Gamma_{1}\right)\right)$ be such that $f^{(n)} \in \mathcal{J}\left(\Gamma_{2}\right), g^{(n)} \neq 0$ for some natural number $n$ and

$$
\max _{z \in \Gamma_{1}}\left|f(z)+\lambda_{0} g(z)\right|<\frac{r^{n}}{n!} \max _{z \in \Gamma_{2}}\left|f^{(n)}(z)\right| \text { for some } \lambda_{0} \in \mathbb{C} .
$$

Then $f^{(n)}$ and $g^{(n)}$ have the same number of zeros enclosed by $\Gamma_{2}$.
Proof of Theorem 4.8. We need to show that there exists some $\lambda \in \mathbb{C}$ such that

$$
\max _{z \in \Gamma_{2}}\left|f^{(n)}(z)+\lambda g^{(n)}(z)\right|<\max _{z \in \Gamma_{2}}\left|f^{(n)}(z)\right| .
$$

Since $\Gamma_{2}$ is compact,

$$
\max _{z \in \Gamma_{2}}\left|f^{(n)}(z)+\lambda_{0} g^{(n)}(z)\right|=\left|f^{(n)}\left(z_{0}\right)+\lambda_{0} g^{(n)}\left(z_{0}\right)\right| \text { for some } z_{0} \in \Gamma_{2}
$$

Denote $\operatorname{Int}\left(\Gamma_{1}\right)$ by $\Omega^{\prime}$. Let $\gamma_{r}$ be the circle of radius $r$ about $z_{0}$. From hypotheses, $\gamma_{r} \subset \Omega^{\prime}$. Now, by Cauchy's integral formula for the derivative, we have that

$$
f^{(n)}\left(z_{0}\right)+\lambda_{0} g^{(n)}\left(z_{0}\right)=\frac{n!}{2 \pi i} \int_{\gamma_{r}} \frac{f(z)+\lambda_{0} g(z)}{\left(z-z_{0}\right)^{n+1}} d z
$$

Taking modulus on both sides, we get

$$
\left|f^{(n)}\left(z_{0}\right)+\lambda_{0} g^{(n)}\left(z_{0}\right)\right| \leq \frac{n!}{r^{n}} \max _{z \in \gamma_{r}}\left|f(z)+\lambda_{0} g(z)\right|
$$

since $\int_{\gamma_{r}}\left|\frac{d z}{\left(z-z_{0}\right)^{n+1}}\right|=\frac{2 \pi}{r^{n}}$. Invoking the maximum modulus principle and noting $\gamma_{r} \subset \Omega^{\prime}$ yields:

$$
\max _{z \in \gamma_{r}}\left|f(z)+\lambda_{0} g(z)\right| \leq \max _{z \in \Gamma_{1}}\left|f(z)+\lambda_{0} g(z)\right|
$$

Thus,

$$
\left|f^{(n)}\left(z_{0}\right)+\lambda_{0} g^{(n)}\left(z_{0}\right)\right|<\frac{n!}{r^{n}} \max _{z \in \Gamma_{1}}\left|f(z)+\lambda_{0} g(z)\right| .
$$

Now, from the hypotheses,

$$
\max _{z \in \Gamma_{2}}\left|f^{(n)}(z)+\lambda_{0} g^{(n)}(z)\right|=\left|f^{(n)}\left(z_{0}\right)+\lambda_{0} g^{(n)}\left(z_{0}\right)\right|<\max _{z \in \Gamma_{2}}\left|f^{(n)}(z)\right|
$$

Thus, $f^{(n)} \not \chi_{B} g^{(n)}$ in any nowhere vanishing, point separating sub-algebra of $\mathcal{H o l}\left(\Gamma_{2} \cup \operatorname{Int}\left(\Gamma_{2}\right)\right)$ containing both the functions.
