# A Strong Solution of the Navier-Stokes Equation on $L_{p}(\Omega)$

#### Abstract

In this paper we prove that the Navier-Stokes initial value problem (1.1)-(1.4) has a unique smooth local strong solution $u(t, x)$ and $p(t, x)$ if $f(t) \in D L_{p}(\Omega)$ is Hölder continuous about $t$ on $(0, T]$ and the initial value $u_{0} \in D\left((-\Delta)^{\frac{1}{2}}\right) \cap\left(C^{\infty}(\Omega)\right)^{3}$ satisfies $\frac{\partial u_{0 i}}{\partial x_{j}}=0(i \neq j)$. ## (1) Introduction

The Navier-Stokes initial value problem can be written in the following form as
where $\Omega$ is a bounded domain in $R^{3}$ with smooth boundary $\partial \Omega$ of class $C^{3}, u=$
$u(t, x)=\left(u_{1}(t, x), u_{2}(t, x), u_{3}(t, x)\right)$ is the velocity field, $u_{0}=u_{0}(x)$ is the initial velocity, $p=p(t, x)$ is the pressure, $f=f(t, x)$ is the external force. In [17] we proved that the Navier-Stokes initial value problem (1.1)-(1.4) has a unique smooth local strong solution on $L_{2}(\Omega)$ if the initial velocity $u_{0}$ and the external force $f$ satisfy some conditions. In this paper we will extend this result to $L_{p}(\Omega)$.

Let $L_{p}(\Omega)(2 \leq p<\infty)$ be the Banach space of real vector functions in $L^{p}(\Omega)$ with the inner product defined in the usual way. That is

L_{p}(\Omega)=\left\{u: \Omega \rightarrow R^{3}, u=\left(u_{1}, u_{2}, u_{3}\right), u_{i} \in L^{p}(\Omega)(i=1,2,3)\right\} .
$$

For $u=\left(u_{1}, u_{2}, u_{3}\right) \in L_{p}(\Omega)$, we define the norm

\|u\|_{L_{p}(\Omega)}=\left(\sum_{i=1}^{3}\left\|u_{i}\right\|_{L^{p}(\Omega)}^{p}\right)^{\frac{1}{p}} .

The set of all real vector functions $u$ such that div $u=0$ and $u \in C_{0}^{\infty}(\Omega)$ is denoted by $C_{0, \sigma}^{\infty}(\Omega)$. Let $D L_{p}(\Omega)$ be the closure of $C_{0, \sigma}^{\infty}(\Omega)$ in $L_{p}(\Omega)$. If $u \in C^{\infty}(\Omega)$ then $u \in D L_{2}(\Omega) \quad$ implies div $u=0$. (see p. 270 in [4] ). We have

D L_{p}(\Omega) \subset L_{p}(\Omega)=W^{0, p}(\Omega), \quad\|\bullet\|_{D L_{p}(\Omega)}=\|\bullet\|_{L_{p}(\Omega)}

and

From [4] and [5] we see that $D L_{p}(\Omega)^{\perp}=\left\{\nabla h ; h \in W^{1, p}(\Omega)\right\}$. Let $P \quad$ be the orthogonal projection from $L_{p}(\Omega)$ onto $D L_{p}(\Omega)$. By applying $P$ to (1.1) and taking account of the other equations, we are let the following abstract initial value problem, Pr. II
where $F u=-P(u \bullet \nabla) u$.

We consider equation (3.1) in integral form Pr.III

For $u=\left(u_{1}, u_{2}, u_{3}\right) \in L_{p}(\Omega)$ we define $\Delta u=\left(\Delta u_{1}, \Delta u_{2}, \Delta u_{3}\right)$ and $\nabla u=\left(\frac{\partial u_{1}}{\partial x_{1}}, \frac{\partial u_{2}}{\partial x_{2}}, \frac{\partial u_{3}}{\partial x_{3}}\right)$ where $\nabla$ is considered as an operator operating on vector functions. Since the operator $-\nabla=-\sum_{i=1}^{3} \frac{\partial^{2}}{\partial x_{i}^{2}}$ is strongly elliptic of order 2. From Theorem7.3.6 in [12] $\Delta$ is the infinitesimal generator of an analytic semigroup of contractions on $L^{p}(\Omega)$ with $D(\Delta)=W^{2, p}(\Omega) \cap W_{0}^{1, p}(\Omega)$. Hence $\Delta$ is also the infinitesimal generator of an analytic semigroup of contraction on $L_{p}(\Omega)$ with $D(\Delta)=W_{2, p}(\Omega) \cap W_{1, p, 0}(\Omega)$, where $W_{2, p}(\Omega)$ and $W_{1, p, 0}(\Omega)$ are the Sobolev spaces of vector value in $W^{2, p}(\Omega)$ and $W_{0}^{1, P}(\Omega)$ respectively. We will prove that $\Delta$ is also the infinitesimal generator of an analytic semigroup of contraction on $D L_{p}(\Omega)$. This is a key point for our purpose.

## (2)Some lemmas

Lemma 1. If $u \in C^{\infty}(\Omega)$ then $u \in D L_{p}(\Omega)$ implies div $u=0$.

Proof. Suppose that $u=\left(u_{1}, u_{2}, u_{3}\right) \in C^{\infty}(\Omega) \cap D L_{p}(\Omega)$. Then there exists a sequence $\left\{u^{n} \in C_{0, \sigma}^{\infty}(\Omega): n=1,2, \ldots\right\}$ such that $u=\lim _{n \rightarrow \infty} u^{n}$, that is $\lim _{n \rightarrow \infty}\left\|u-u^{n}\right\|_{D L_{p}\left(R^{3}\right)}=0$ uniformly on $\Omega$ and $\lim _{n \rightarrow \infty}\left\|u_{i}-u_{i}^{n}\right\|_{L^{p}(\Omega)}=0$ uniformly on $\Omega$ for $i=1,2,3$. And so $\lim _{n \rightarrow \infty}\left|u_{i}(x)-u_{i}^{n}(x)\right| \stackrel{\text { a.e. }}{=} 0$ and $\lim _{n \rightarrow \infty} u_{i}^{n}(x) \stackrel{\text { a.e. }}{=} u_{i}(x)$ uniformly on $\Omega$ for $i=1,2,3$. (see Theorem 1.39 in [15]) It from the proof of Theorem 7.11 in [14] follows that

& =\sum_{i=1}^{3}\left[\lim _{n \rightarrow \infty} \lim _{x_{i} \rightarrow x_{i 0}} \frac{u_{i}^{n}\left(x_{i}\right)-u_{i}^{n}\left(x_{i 0}\right)}{x_{i}-x_{i 0}}\right]=\sum_{i=1}^{3}\left[\lim _{n \rightarrow \infty} \frac{\partial u_{i}^{n}}{\partial x_{i}}\right]=\lim _{n \rightarrow \infty} \sum_{i=1}^{3}\left[\frac{\partial u_{i}^{n}}{\partial x_{i}}\right]=0 .

This is to say $\operatorname{div} u=0$.

Lemma 2. For every $u \in L_{p}(\Omega)$, $\operatorname{div} u=0$ if and only if $\operatorname{div}(\lambda I-\Delta) u=0$ for

\lambda \in \Sigma_{\vartheta}=\{\lambda: \vartheta-\pi<\arg \lambda<\pi-\vartheta,|\lambda| \geq r\}
$$

where $0<\vartheta<\frac{1}{2}$.

Proof. It is similar to the proof of lemma 1 in [17].

Lemma 3. (1.5.12 in[8]) Let $\{T(t): t \geq 0\}$ be a $C_{0}$-semigroup on a Banach space $X$. If $Y$ is a closed subspace of $X$ such that $T(t) Y \subset Y$ for all $t \geq 0$, i.e., if $Y$ is $T(t)_{t \geq 0}-$ invariant, then the restrictions

form a $C_{0}$-semigroup $\{T(t): t \geq 0\}$, called the subspace semigroup on the Banach space $Y$.

Lemma 4. (Proposition 2.2.3 in [8]) Let $(A, D(A))$ be the generator of a $C_{0}$-semigroup $\{T(t): t \geq 0\}$ on a Banach space $X$ and assume that the restricted semigroup (subspace semigroup) $\left\{T(t)_{\mid}: t \geq 0\right\}$ is a $C_{0}$-semigroup on some $(T(t))_{t \geq 0}$ - invariant Banach space $Y \rightarrow X$. Then the generator of $\{T(t): t \geq 0\}$ is the part $\left(A_{4}, D\left(A_{\|}\right)\right)$of $A$ in $Y$.

Lemma 5. The operator $\Delta_{\mid D L_{p}(\Omega)}$ is the infinitesimal generator of an analytic semigroup of contractions on $D L_{p}(\Omega)$.

Proof. We have know that $\Delta$ is a infinitesimal generator of an analytic semigoup of contraction on $L_{p}(\Omega)$. Let $\{T(t) \mid t \geq 0\}$ be the restriction of the analytic semigroup generated
by $\Delta$ on $L_{p}(\Omega)$ to the real axis. Then $\{T(t) \mid t \geq 0\}$ is a $C_{0}$ semigroup of contractions . We have already noted that $D L_{p}(\Omega)$ is a closed subspace of $L_{p}(\Omega)$. We want to show that $D L_{p}(\Omega)$ is $T(t)_{t \geq 0}$ - invariant.

For every $u \in L_{p}(\Omega)$ with div $u=0 \quad$ and $\lambda \in \rho(\Delta) \cap \Sigma_{\vartheta}=\{\lambda: \vartheta-\pi<$ $\arg \lambda<\pi-\vartheta,|\lambda| \geq r\}$ we have $(\lambda I-\Delta)[R(\lambda: \Delta) u]=u$ where $\sum_{\vartheta}$ is the same as in the proof of lemma 2. From Lemma 2 it follows that $\operatorname{div} R(\lambda: \Delta) u=0$. That is to say that $R(\lambda: \Delta)$ is preserving divergence-free for $\lambda \in \rho(\Delta) \cap \Sigma_{\vartheta}$. From Theorem 2.5.2 (c) in [12] it follows that $\rho(\Delta) \supset R^{+}$, and so $\rho(\Delta) \cap \Sigma_{\vartheta} \supset\{\lambda: \lambda \geq r\}$. Hence $R(\lambda: \Delta)$ is preserving divergence-free for every $\lambda \geq r$. Let $u \in D L_{p}(\Omega)$ then there exists a sequence $u_{n}$ such that $\lim _{n \rightarrow \infty} u_{n}=u$ and div $u_{n}=0$ for $n=1,2, \ldots$. Since $R(\lambda: \Delta)$ is bounded and so is continuous . Hence $\lim _{n \rightarrow \infty} R(\lambda: \Delta) u_{n}=R(\lambda: \Delta) u$ and div $R(\lambda: \Delta) u_{n}=0$ for every $\lambda \geq r$. Therefore $R(\lambda: \Delta) u \in D L_{p}(\Omega)$ for every $\lambda \geq r$. It follows that $D L_{p}(\Omega)$ is $R(\lambda: \Delta)$-invariant for every $\lambda \geq r$. Now Theorem 4.5 .1 in [12] implies that $D L_{p}(\Omega)$ is $T(t)_{t \geq 0}$ - invariant. From Lemma 3 and Lemma 4 it follows that $\Delta_{\mid D L_{p}(\Omega)}$ is the infinitesimal generator of the $C_{0}$ semigroup $\left\{T(t)_{\mid D L_{p}(\Omega)}: t \geq 0\right\}$ of contractions on $D L_{p}(\Omega)$.

By the proof of Theorem 2.5.2 in [12] we see that the analytic semigroup generated by infinitesimal generator $\Delta$ on $L_{p}(\Omega)$ has a representation

for $z=t+i s \in \Delta_{1}=\left\{z:|\arg z|\langle\arctan 1 / C e\}\right.$ where $C$ is a constant with $\left\|T^{\prime}(t)\right\|=\|\Delta \mathrm{T}(t)\|$ $\leq C / t$ by Theorem $25.2(\mathrm{~d})$ in [12]. For every $u \in D L_{p}(\Omega)$ we have

& =T(t) u+\operatorname{Lim}_{k \rightarrow \infty} \sum_{n=1}^{k} \frac{\left[\Delta_{\mid D L_{2}(\Omega)} T\left(\frac{1}{n}\right)\right]^{n}}{n!}(i s)^{n} u \\
& =T(t) u-\operatorname{Lim}_{k \rightarrow \infty} \sum_{n=1}^{k} s^{2 n} \frac{\left.\Delta_{\mid D L_{2}(\Omega)} T\left(\frac{1}{n}\right)\right]^{2 n}}{(2 n)!} u .

We used the lemma 2.4.5 in [12] in the second step, and the fact that subsequence converges to the same limit in the fourth step. Since $D L_{p}(\Omega)$ is $\Delta_{\mid D L_{p}(\Omega)}$ - invariant and $T(t)_{t \geq 0}$ - invariant, hence
and so

Finally we have

because $D L_{p}(\Omega)$ is closed. Therefore $T(z) u \in D L_{p}(\Omega)$ for $z \in \Delta_{1}$. This is to say that $D L_{p}(\Omega)$ is $T(z)_{z \in \Delta_{1}}$ - invariant and $\Delta_{\mid D L_{p}(\Omega)}$ is a infinitesimal generator of the analytic semigroup $\left\{T(z): z \in \Delta_{1}\right\}$ on $D L_{p}(\Omega)$

Suppose that $-A$ is the infinitesimal generator of an analytic semigroup $T(t)$ on a Banach space $X$. From the results of section 2.6 in [12] we can define the fraction powers $A^{\alpha}$ for $0 \leq \alpha \leq 1$ and $A^{\alpha}$ is a closed linear invertible operator with domain $D\left(A^{\alpha}\right)$ dense in $X$ and $A^{-\alpha}$ is bounded. $D\left(A^{\alpha}\right)$ equipped with the norm $\|x\|_{\alpha}=\left\|A^{\alpha} x\right\|_{\text {is a Banach space }}$ denoted by $X_{\alpha}$. It is clear that $0<\alpha<\beta$ implies $X_{\alpha} \supset X_{\beta}$ and that the embedding of $X_{\beta}$
into $\quad X_{\alpha}$ is continuous. If $-A=\Delta \quad$ and $\quad \gamma>3 / 4>1 / 2$ then $X_{\gamma} \subset X_{\frac{1}{2}}$ and $D\left((-\Delta)^{\gamma}\right) \subset$ $D\left((-\Delta)^{1 / 2}\right)$, so the norms $\|\bullet\|_{D L_{p}\left(R^{3}\right)_{\gamma}}$ and $\|\bullet\|_{D L_{p}\left(R^{3}\right)_{\frac{1}{2}}}$ are equivalent (see p291 in [9]), i.e. there exists $L_{0}>0$ such that for any $u \in D\left((-\Delta)^{\gamma}\right)$

For $u \in D(\Delta)$ we have

In [5] Giga proved the following result:
Lemma 6. (Lemma 2.2 in [5]) Let $0 \leq \delta<1 / 2\left|-n\left(1-r^{-1}\right) / 2\right|$. Then

with some constant $M=M(\delta, \vartheta, \omega, r)$, provided $\delta+\vartheta+\omega \geq n / 2 r+1 / 2, \vartheta>0, \omega$ $>0, \omega+\delta>1 / 2$.

From the Lemma 6 and the formula (5) we see that if take $n=3, r=2$ $\delta=0, \quad \vartheta=3 / 4$ and $\omega=3 / 4$, then

& \leq M L_{0}^{2}\|u\|_{D L_{p}(\Omega)_{1 / 2}}\|v\|_{D L_{p}(\Omega)_{1 / 2}}
\end{aligned}

with some constant $M$ for any $u, v \in D L_{p}(\Omega)$. Hence we have

Lemma 7. Suppose that $u, v \in D L_{p}(\Omega)$ are velocity fields and $(u \bullet \nabla) v \in D L_{p}(\Omega)$, then

Now we introduce the main lemmas of this paper.

Assumption (F). Let $X=D L_{p}(\Omega)$ and $U$ be an open subset in $R^{+} \times X_{\alpha}(0 \leq \alpha \leq 1)$ The function $f: U \rightarrow X \quad$ satisfies the assumption (F) if for every $(t, u) \in U$ there is a neighborhood $V \subset U$ and constants $L \geq 0, \quad 0<\vartheta \leq 1$ such that for all $\left(t_{i}, u_{i}\right) \in V(i=1,2)$

Lemma 8.( Theorem 6.3.1 in [12]) Let $-A$ is the infinitesimal generator of an analytic semigroup $T(t)$ on the Banach space $X=D L_{p}(\Omega)$ satisfying $\|T(t)\| \leq 1$ and assume further that $0 \in \rho(-A)$. If, $0<\alpha<1$ and $f$ satisfies the assumption $(F)$, then for every initial data $\left(t_{0}, u_{0}\right) \in U$ the initial value problem

has a unique local solution

u \in C\left(\left[t_{0}, T\right): D L_{p}(\Omega)\right) \cap C^{1}\left(\left(t_{0}, T\right): D L_{p}(\Omega)\right)
$$

where $T=T\left(u_{0}\right)$.

In what follows we will need Banach lattice (see [3] ). A real vector space $G$ which is ordered by some order relation $\leq$ is called a vector lattice (or Riesz space) if any two elements $f, g \in G$ have a least upper bound, denoted by $f \vee g$, and a greatest lower bound, denoted by $f \wedge g$, and the following properties are satisfied:
(i) If $f \leq g$, then $f+h \leq g+h$ for all $f, g, h \in G$,
(ii) If $0 \leq f$, then $0 \leq t f$ for all $f \in G$ and $0 \leq t \in R$.

A Banach lattice is a real Banach space $G$ endowed with an ordering $\leq$ such that $(G, \leq)$ is a vector lattice and the norm is a lattice norm, that is $|f| \leq|g|$ implies $\|f\| \leq\|g\|$ for $f, g \in G$,
where $|f|=f \vee(-f)$ is the absolute value of $f$ and $\|\bullet\|$ is the norm in $G$ ．In a Banach lattice $G$ we define for $f \in G$

The absolute value of $f$ is $\quad|f|=f^{+}+f^{-}$and $f=f^{+}-f^{-}$．

In what follows one will need the above formula ．

In $L^{p}(\Omega)$ we define the order for $f, g \in L^{p}(\Omega)$

and

for a．e．$\quad x \in \Omega$ ．Then $W^{1, p}(\Omega), L^{p}(\Omega), L_{p}(\Omega)$ and $D L_{p}(\Omega)$ are all Banach lattices． （see［1］p．148）

Lemma9．Suppose that $u, v \in D L_{p}(\Omega)$ are divergence free satisfying $\frac{\partial u_{i}}{\partial x_{j}}=0, \frac{\partial v_{i}}{\partial x_{j}}=0$ $(i \neq j)$ ．Then $(u \bullet \nabla) v, \quad(v \bullet \nabla) u \in D L_{p}(\Omega)$.

Proof．If $u, v \in D L_{p}(\Omega)$ are divergence free satisfying $\frac{\partial u_{i}}{\partial x_{j}}=0, \frac{\partial v_{i}}{\partial x_{j}}=0(i \neq j)$ ．From【5】 and【6】we have

Since $v$ is divergence free, $\sum_{i=1}^{3} \frac{\partial v}{\partial x_{i}}=0$, so $\frac{\partial v}{\partial x_{i}}$ are all bounded, $\left|\frac{\partial v}{\partial x_{i}}\right| \leq L \quad(\mathrm{i}=1,2,3)$ for some constant $L>0$. A function $u$ which is differentiable almost everywhere on $[0, T]$ such that $u^{\prime} \in$ $L^{1}\left[0, T: D L_{2}(\Omega)\right] \quad$ is called a strong solution of the initial value problem (1.1)=(1.4) if $u(0)=u_{0}$ and $u$ satisfies (1.1)-(1.4) a.e. on $[0, T]$. A function $u:[0, T] \rightarrow D L_{2}(\Omega)$ is a classical solution of (3.1)-(3.2) on $[0, T]$ if $u$ is continuous on $[0, T]$, continuous differentiable on $(0, T), u \in D(\Delta)$ for $t \in(0, T)$ and (3.1)-(3.2) are satisfied on $[0, T]$.

Let $H\left([0, T] ; D L_{p}(\Omega)_{1 / 2}\right)$ denote the space of all Hölder continuous functions $u(t, x)$ on $[0, T]$ with different exponents in $(0,1]$ and with divergence free functions values satisfying $\frac{\partial u_{i}}{\partial x_{j}}=0(i \neq j)$ in the Banach space $D L_{p}(\Omega)_{\frac{1}{2}}$. Then from lemma 9 for any $u \in H$ $\left([0, T] ; D L_{p}(\Omega)_{1 / 2}\right)$ and any $t_{1}, t_{2} \in[0, T],\left(u\left(t_{1}\right) \bullet \nabla\right) u\left(t_{2}\right) \in D L_{p}(\Omega) ;$ and for any $u_{1}, u_{2}$ $\in H\left([0, T] ; D L_{p}(\Omega)_{1 / 2}\right)$ and any $t \in[0, T],\left(u_{1}(t) \bullet \nabla\right) u_{2}(t) \in D L_{p}(\Omega) . \quad$ In the following we will use these facts. Suppose that $u_{i}\left(x_{i}\right) \in D L_{p}(\Omega)(i=1,2,3)$ satisfying $\sum_{i=1}^{3} \frac{\partial u_{i}\left(x_{i}\right)}{\partial x_{i}}=0 . \operatorname{Let} u(x)=\left(u_{1}\left(x_{1}\right), u_{2}\left(x_{2}\right), u_{3}\left(x_{3}\right)\right)$ and $u(t, x) \equiv u(x)$ for $t \in[0, T]$. Then $u(t, x) \in H\left([0, T] ; D L_{p}(\Omega)_{1 / 2}\right)$ and $u(x) \in H$. Hence $H$ is not empty. Take the open kernel $H^{0}$ of $H$ in $D L_{p}(\Omega)_{1 / 2} . H^{0}$ is also not empty. It is clear that $H^{0}$ is a open subset in $D L_{p}(\Omega)_{1 / 2}$. The bilinear form $(v \bullet \nabla) u$ on $H^{0}$ takes value in
$D L_{p}(\Omega)$. Let

Theorem．The Navier－Stokes initial value problem（1．1）－（1．4）has a unique smooth local strong solution $u(t, x)$ and $p(t, x)$ if the following condition are satisfied
（1）$f \in D L_{p}(\Omega)$ is Hölder continuous about $t$ on $(0, T]$ ，
（2）The initial value $u_{0} \in D\left((-\Delta)^{\frac{1}{2}}\right) \cap\left(C^{\infty}(\Omega)\right)^{3}$ satisfies $\frac{\partial u_{0 i}}{\partial x_{j}}=0(i \neq j)$ ．

Proof．（Step1 ）First，$F(t, u(t))=-(u(t) \bullet \nabla) u(t)$ is a function ：$U \rightarrow D L_{p}(\Omega)$ because $(u(t) \bullet \nabla) u(t) \in D L_{p}(\Omega)$ according to the definition of $U$.

We will find that by incorporating the divergence－free condition we can remove the pressure term from our equation．（see p． $271^{3}$ in 【4】，p． $234_{6}$ and p． $239_{9}$ in 【13】）In fact，from $D L_{p}(\Omega)^{\perp}=\left\{\nabla h ; h \in W^{1, p}(\Omega)\right\}$ we see that $\nabla p \in D L_{p}(\Omega)^{\perp}$ and so $P \nabla p=0$ ．For $u \in$ $D L_{p}(\Omega)$ we have $\Delta u \in D L_{p}(\Omega)$ because to Lemma 5．Hence by applying $P$ to the equation （1．1）we have $P \Delta u=\Delta u$ ．It follows from $(u \bullet \nabla) u \in D L_{p}(\Omega)$ that $\quad P(u \bullet \nabla) u=(u \bullet \nabla) u$ ． Therefore we can first rewrite（1）into an abstract initial value problem on $D L_{p}(\Omega)$

$\leq L_{3}\left(\left|t_{1}-t_{2}\right|^{\beta_{2}}+\left\|u_{1}\left(t_{1}\right)-u_{2}\left(t_{2}\right)\right\|_{D L_{p}(\Omega) / / 2}\right)$.
Hence $F(t, u(t))$ satisfies the assumption $(F)$. Therefore from lemma 8 for every initial data
$\left(t_{0}, u_{0}\right) \in U_{1}$ the initial value problem (9) has unique local solution

$$
\begin{equation*}
u(t) \in C\left(\left[t_{0}, t_{1}\right): D L_{p}(\Omega)\right) \cap C^{1}\left(\left(t_{0}, t_{1}\right): D L_{p}(\Omega)\right) \tag{13}
\end{equation*}
$$

where $t_{1}=t_{1}\left(u_{0}\right)$.

The solution (13) of (9) is also the solution of (4). The Theorem 3.4 in [5] mean that as long as the solution of (4) exists, this solution is smooth. From Theorem 3.4 in [5]we have the solution $u(t, x) \in\left(C^{\infty}\left(\left[0, t_{1}\right) \times \bar{\Omega}\right)\right)^{3}$. Substituting $u(t, x)$ into (1.1) we get the solution $p(t, x)$. We also have $p(t, x) \in C^{\infty}\left(\left[0, t_{1}\right) \times \bar{\Omega}\right)$. It follows from the lemma 1 and $u \in D L_{p}(\Omega)$ that the solution $u(t, x)$ is divergence-free. Changing the value of $u$ on $\partial \Omega$ to zero we get a unique smooth local strong solution of the Navier-Stokes initial value problem (1.1)-(1.4).

If $\Omega$ is a bounded open subset of $R^{3}$ then the solution (13) is a classical solution of (9) and (3.1)-(3.2).
