# SUBGRAPH DENSITIES IN A SURFACE

#### Abstract

Given a fixed graph $H$ that embeds in a surface $\Sigma$, what is the maximum number of copies of $H$ in an $n$-vertex graph $G$ that embeds in $\Sigma$ ? We show that the answer is $\Theta\left(n^{f(H)}\right)$, where $f(H)$ is a graph invariant called the 'flap-number' of $H$, which is independent of $\Sigma$. This simultaneously answers two open problems posed by Eppstein (1993). The same proof also answers the question for minor-closed classes. That is, if $H$ is a $K_{3, t}$ minor-free graph, then the maximum number of copies of $H$ in an $n$-vertex $K_{3, t}$ minor-free graph $G$ is $\Theta\left(n^{f^{\prime}(H)}\right)$, where $f^{\prime}(H)$ is a graph invariant closely related to the flap-number of $H$. Finally, when $H$ is a complete graph we give more precise answers.


## 1. Introduction

All graphs in this paper are undirected, finite, and simple, unless stated otherwise. Many classical theorems in extremal graph theory concern the maximum number of copies of a fixed graph $H$ in an $n$-vertex graph in some class $\mathcal{G}$. Here, a copy means a subgraph isomorphic to $H$. For example, Turán's Theorem determines the maximum number of copies of $K_{2}$ (that is, edges) in an $n$-vertex $K_{t}$-free graph [67]. More generally, Zykov's Theorem determines the maximum number of copies of a given complete graph $K_{s}$ in an $n$-vertex $K_{t}$-free graph [71]. The excluded graph need not be complete. The Erdős-Stone Theorem [20] determines, for every non-bipartite graph $X$, the asymptotic maximum number of copies of $K_{2}$ in an $n$-vertex graph with no $X$-subgraph. Analogues of the Erdős-Stone Theorem for copies of $K_{s}$ have recently been studied by Alon and Shikhelman $[4,5]$. See $[3,21,24-27,34,49,50,55,66]$ for recent related results.

This paper studies similar questions when the class $\mathcal{G}$ consists of the graphs that embed ${ }^{1}$ in a given surface $\Sigma$ (rather than being defined by an excluded subgraph). For graphs $H$ and $G$, let $C(H, G)$ be the number of copies of $H$ in $G$. For a surface $\Sigma$, let $C(H, \Sigma, n)$ be the maximum of $C(H, G)$, where the maximum is taken over all $n$-vertex graphs $G$

[^0]that embeds in $\Sigma$. This paper determines the asymptotic behaviour of $C(H, \Sigma, n)$ as $n \rightarrow \infty$ for any fixed surface $\Sigma$ and any fixed graph $H$.

Before stating our theorem, we mention some related results that determine $C\left(H, \mathbb{S}_{0}, n\right)$ for specific planar graphs $H$ where the surface is the sphere $\mathbb{S}_{0}$. Alon and Caro [2] determined $C\left(H, \mathbb{S}_{0}, n\right)$ precisely if $H$ is either a complete bipartite graph or a triangulation without non-facial triangles. Hakimi and Schmeichel [35] studied $C\left(C_{k}, \mathbb{S}_{0}, n\right)$ where $C_{k}$ is the $k$-vertex cycle; they proved that $C\left(C_{3}, \mathbb{S}_{0}, n\right)=3 n-8$ and $C\left(C_{4}, \mathbb{S}_{0}, n\right)=$ $\frac{1}{2}\left(n^{2}+3 n-22\right)$. See $[36,37]$ for more results on $C\left(C_{3}, \mathbb{S}_{0}, n\right)$ and see [1] for more results on $C\left(C_{4}, \mathbb{S}_{0}, n\right)$. Gyôri, Paulos, Salia, Tompkins, and Zamora [32] proved that $C\left(C_{5}, \mathbb{S}_{0}, n\right)=2 n^{2}-10 n+12$ (except for $n \in\{5,7\}$ ). If $P_{k}$ is the $k$-vertex path, then $C\left(P_{4}, \mathbb{S}_{0}, n\right)=7 n^{2}-32 n+27$ with finitely many exceptions [31] and $C\left(P_{5}, \mathbb{S}_{0}, n\right)=n^{3}+O\left(n^{2}\right)$ [28]. Alon and Caro [2] and independently Wood [68] proved that $C\left(K_{4}, \mathbb{S}_{0}, n\right)=n-3$. More generally, Perles (see [2]) conjectured that if $H$ is a fixed 3 -connected planar graph, then $C\left(H, \mathbb{S}_{0}, n\right)=O(n)$. Perles noted the converse: If $H$ is planar, not 3 -connected and $|V(H)| \geqslant 4$, then $C\left(H, S_{0}, n\right) \geqslant \Omega\left(n^{2}\right)$. Perles' conjecture was proved by Wormald [70] and independently by Eppstein [18], who asked the following two open problems:

- Characterise the subgraphs occurring $O(n)$ times in graphs of given genus.
- Characterise the subgraphs occurring a number of times which is a nonlinear function of $n$.

This paper answers both these questions (and more).
We start with the following natural question: when is $C(H, \Sigma, n)$ bounded by a constant depending only on $H$ and $\Sigma$ (and independent of $n$ )? We prove that $H$ being 3-connected and non-planar is a sufficient condition. In fact we prove a stronger result that completely answers the question. We need the following standard definitions. A $k$-separation of a graph $H$ is a pair $\left(H_{1}, H_{2}\right)$ of edge-disjoint subgraphs of $H$ such that $H_{1} \cup H_{2}=H$, $V\left(H_{1}\right) \backslash V\left(H_{2}\right) \neq \emptyset, V\left(H_{2}\right) \backslash V\left(H_{1}\right) \neq \emptyset$, and $\left|V\left(H_{1} \cap H_{2}\right)\right|=k$. A $k^{\prime}$-separation for some $k^{\prime} \leqslant k$ is called a $(\leqslant k)$-separation. If $\left(H_{1}, H_{2}\right)$ is a separation of $H$ with $X=V\left(H_{1}\right) \cap V\left(H_{2}\right)$, then let $H_{i}^{-}$and $H_{i}^{+}$be the simple graphs obtained from $H_{i}$ by removing and adding all edges between vertices in $X$, respectively.

A graph $H$ is strongly non-planar if $H$ is non-planar and for every $(\leqslant 2)$-separation $\left(H_{1}, H_{2}\right)$ of $H$, both $H_{1}^{+}$and $H_{2}^{+}$are non-planar. Note that every 3 -connected nonplanar graph is strongly non-planar. The following is our first contribution. It says that $C(H, \Sigma, n)$ is bounded if and only if $H$ is strongly non-planar.

Theorem 1.1. There exists a function $c_{1.1}(h, g)$ such that for every strongly non-planar graph $H$ with $h$ vertices and every surface $\Sigma$ of Euler genus $g$,

$$
C(H, \Sigma, n) \leqslant c_{1.1}(h, g)
$$

Conversely, for every graph $H$ that is not strongly non-planar and for every surface $\Sigma$ in which $H$ embeds, there is a constant $c>0$ such that for all $n \geqslant 4|V(H)|$, there is an n-vertex graph that embeds in $\Sigma$ and contains at least cn copies of $H$; that is, $C(H, \Sigma, n) \geqslant c n$.

There are two important observations about Theorem 1.1. First, the characterisation of graphs $H$ does not depend on the surface $\Sigma$. Indeed, the only dependence on $\Sigma$ is in the constants. Second, Theorem 1.1 shows that $C(H, \Sigma, n)$ is either bounded or $\Omega(n)$.

Theorem 1.1 is in fact a special case of the following more general theorem. The next definition is a key to describing our results. A flap in a graph $H$ is a $(\leqslant 2)$-separation $(A, B)$ such that $A^{+}$is planar. Separations $(A, B)$ and $(C, D)$ of $H$ are independent if $E\left(A^{-}\right) \cap E\left(C^{-}\right)=\emptyset$ and $(V(A) \backslash V(B)) \cap(V(C) \backslash V(D))=\emptyset .^{2}$ If $H$ is planar and with no ( $\leqslant 2$ )-separation, then the flap-number of $H$ is defined to be 1 . Otherwise, the flap-number of $H$ is defined to be the maximum number of pairwise independent flaps in $H$. Let $f(H)$ denote the flap-number of $H$.

The following is our main theorem.
Theorem 1.2. For every graph $H$ and every surface $\Sigma$ in which $H$ embeds,

$$
C(H, \Sigma, n)=\Theta\left(n^{f(H)}\right) .
$$

It is immediate from the definitions that $f(H)=0$ if and only if $H$ is strongly non-planar. So Theorem 1.1 follows from the $f(H) \leqslant 1$ cases of Theorem 1.2.

As an aside, note that Theorem 1.2 can be restated as follows: for every graph $H$ and every surface $\Sigma$ in which $H$ embeds,

$$
\lim _{n \rightarrow \infty} \frac{\log C(H, \Sigma, n)}{\log n}=f(H)
$$

The above limit is sometimes referred to as the asymptotic logarithmic density of $H$ in $\Sigma$. A related result of Nešetril and Ossona de Mendez [55] shows that for every infinite nowhere dense hereditary graph class $\mathcal{G}$ and for every fixed graph $H$, the maximum, taken over all $n$-vertex graphs $G \in \mathcal{G}$, of the number of induced subgraphs of $G$ isomorphic to $H$ is $\Omega\left(n^{\beta}\right)$ and $O\left(n^{\beta+o(1)}\right)$ for some integer $\beta \leqslant f(H)$. Our results (in the case that $\mathcal{G}$ is the class of graphs embeddable in a fixed surface) imply this upper bound (since the number of induced copies of $H$ in $G$ is at most $C(H, G)$ ). Moreover, our bounds are often more precise since $f(H)$ can be significantly less than $\beta$.

[^1]The lower bound in Theorem 1.2 is proved in Section 2. Section 3 introduces some tools from the literature that are used in the proof of the upper bound. Theorem 1.1 is proved in Section 4. The upper bound in Theorem 1.2 is then proved in Section 5. Section 6 presents more precise bounds on $C(H, \Sigma, n)$ when $H$ is a complete graph $K_{s}$. Section 7 considers the maximum number of copies of a graph $H$ in an $n$-vertex graph in a given minor-closed class. Section 8 reinterprets our results in terms of homomorphism inequalities, and presents some open problems that arise from this viewpoint.

Before continuing, to give the reader some more intuition about Theorem 1.2, we now asymptotically determine $C(T, \Sigma, n)$ for a tree $T$.

Corollary 1.3. For every fixed tree $T$, let $\beta(T)$ be the size of a maximum stable set in the subforest $F$ of $T$ induced by the vertices with degree at most 2 . Then for every fixed surface $\Sigma$,

$$
C(T, \Sigma, n)=\Theta\left(n^{\beta(T)}\right)
$$

Proof. By Theorem 1.2, it suffices to show that $\beta(T)=f(T)$.
Let $I=\left\{v_{1}, \ldots, v_{\mathcal{B}(T)}\right\}$ be a maximum stable set in $F$. Let $x_{i}$ (and possibly $y_{i}$ ) be the neighbours of $v_{i}$. Let $A_{i}:=T\left[\left\{v_{i}, x_{i}, y_{i}\right\}\right]$ and $B_{i}:=T-v_{i}$. Then $\left(A_{i}, B_{i}\right)$ is a flap of $T$. Since $I$ is a stable set, for each $v_{i} \in I$ neither $x_{i}$ nor $y_{i}$ are in $I$, implying that $E\left(A_{i}^{-}\right) \cap$ $E\left(A_{j}^{-}\right)=\emptyset$ for distinct $i, j \in[\beta(T)]$. Moreover, $V\left(A_{i}\right) \backslash V\left(B_{i}\right)=\left\{v_{i}\right\}$, so $\left(V\left(A_{i}\right) \backslash\right.$ $\left.V\left(B_{i}\right)\right) \cap\left(V\left(A_{j}\right) \backslash V\left(B_{j}\right)\right)=\emptyset$ for all distinct $i, j$. Hence $\left(A_{1}, B_{1}\right), \ldots,\left(A_{\mathcal{\beta}(T)}, B_{\mathcal{\beta}(T)}\right)$ are pairwise independent flaps in $T$. Thus $\beta(T) \leqslant f(T)$. Theorem 1.2 then implies that $C(T, \Sigma, n)=\Omega\left(n^{\beta(T)}\right)$. This lower bound is particularly easy to see when $T$ is a tree. Let $G$ be the graph obtained from $T$ by replacing each vertex $v_{i} \in I$ by $\left\lfloor\frac{n-|V(T)|}{\beta(T)}\right\rfloor$ vertices with the same neighbourhood as $v_{i}$, as illustrated in Figure 1. Then $G$ is planar with at most $n$ vertices and at least $\left(\frac{n-|V(T)|}{\beta(T)}\right)^{\beta(T)}$ copies of $T$. Thus $C(T, \Sigma, n) \geqslant C\left(T, \mathbb{S}_{0}, n\right)=$ $\Omega\left(n^{\beta(T)}\right)$ for fixed $T$.

For the converse, let $\left(A_{1}, B_{1}\right), \ldots,\left(A_{f(T)}, B_{f(T)}\right)$ be pairwise independent flaps in $T$. Choose $\left(A_{1}, B_{1}\right), \ldots,\left(A_{f(T)}, B_{f(T)}\right)$ to minimise $\sum_{i=1}^{f(T)}\left|V\left(A_{i}\right)\right|$. A simple case-analysis shows that $\left|V\left(A_{i}\right) \backslash V\left(B_{i}\right)\right|=1$, and if $v_{i}$ is the vertex in $V\left(A_{i}\right) \backslash V\left(B_{i}\right)$, then $N\left(v_{i}\right)=$ $V\left(A_{i}\right) \cap V\left(B_{i}\right)$, implying $v_{i}$ has degree 1 or 2 in $T$. Moreover, $v_{i} v_{j} \notin E(T)$ for distinct $i, j \in[f(T)]$ as otherwise $E\left(A_{i}^{-}\right) \cap E\left(A_{j}^{-}\right) \neq \emptyset$. Hence $\left\{v_{1}, \ldots, v_{f(T)}\right\}$ is a stable set of vertices in $T$ all with degree at most 2 . Hence $\beta(T) \geqslant f(T)$.

## 2. Lower Bound

Now we prove the lower bound in Theorem 1.2. Let $H$ be an $h$-vertex graph with flap-number $k$. Let $\Sigma$ be a surface in which $H$ embeds. Our goal is to show that $C(H, \Sigma, n)=\Omega\left(n^{k}\right)$ for all $n \geqslant 4|V(H)|$. If $k=0$, then there is nothing to prove. If $H$ is planar and 3 -connected, then we may take $\lfloor n / h\rfloor$ disjoint copies of $H$. Thus, we may

assume that $H$ has at least one flap. Let $\left(A_{1}, B_{1}\right), \ldots,\left(A_{k}, B_{k}\right)$ be pairwise independent flaps in $H$. If $\left(A_{i}, B_{i}\right)$ is a 1-separation, then let $v_{i}$ be the vertex in $A_{i} \cap B_{i}$. If $\left(A_{i}, B_{i}\right)$ is a 2 -separation, then let $v_{i}$ and $w_{i}$ be the two vertices in $A_{i} \cap B_{i}$. Let $H^{\prime}$ be obtained from $H$ as follows: if $\left(A_{i}, B_{i}\right)$ is a 2-separation, then delete $A_{i}-V\left(B_{i}\right)$ from $H$, and add the edge $v_{i} w_{i}$ (if it does not already exist). Note that $H^{\prime}$ is a minor of $H$, since we may assume that whenever $\left(A_{i}, B_{i}\right)$ is a 2 -separation, there is a $v_{i} w_{i}$-path in $A_{i}$ (otherwise $\left(A_{i}, B_{i}\right)$ can be replaced by a ( $\leqslant 1$ )-separation). Since $H$ embeds in $\Sigma$, so does $H^{\prime}$. By assumption, $A_{i}^{+}$is planar for each $i$. Fix an embedding of $A_{i}^{+}$with $v_{i}$ and $w_{i}$ (if it exists) on the outerface (which exists since $v_{i} w_{i}$ is an edge of $A_{i}^{+}$in the case of a 2 -separation). Let $q:=\left\lfloor\frac{n}{|V(H)|}-1\right\rfloor$ and $G$ be the graph obtained from an embedding of $H^{\prime}$ in $\Sigma$ by adding $q$ disjoint copies of $A_{i}^{+}$(if $\left(A_{i}, B_{i}\right)$ is a 0 -separation), pasting $q$ copies of $A_{i}^{+}$onto $v_{i}$ (if $\left(A_{i}, B_{i}\right)$ is a 1-separation), and pasting $q$ copies of $A_{i}^{+}$onto $v_{i} w_{i}$ (if $\left(A_{i}, B_{i}\right)$ is a 2-separation). These copies of $A_{i}^{+}$can be embedded into a face of $H^{\prime}$, as illustrated in Figure 2.

Since $\left(V\left(A_{i}\right) \backslash V\left(B_{i}\right)\right) \cap\left(V\left(A_{j}\right) \backslash V\left(B_{j}\right)\right)=\emptyset$ for distinct $i, j \in[k]$,

$$
|V(G)|=|V(H)|+q \sum_{i}\left|V\left(A_{i}\right) \backslash V\left(B_{i}\right)\right| \leqslant(q+1)|V(H)| \leqslant n
$$

By construction, $G$ has at least $q^{k} \geqslant\left(\frac{n}{|V(H)|}-2\right)^{k}$ copies of $H$. Hence $C(H, \Sigma, n)=$ $\Omega\left(n^{k}\right)$.

## 3. Tools

In Sections 3-5 of this paper we work in the following setting. For graphs $G$ and $H$, an image of $H$ in $G$ is an injection $\phi: V(H) \rightarrow V(G)$ such that $\phi(u) \phi(v) \in E(G)$ for all $u v \in E(H)$. Let $I(H, G)$ be the number of images of $H$ in $G$, and let $I(H, \Sigma, n)$ be the maximum of $I(H, G)$ taken over all $n$-vertex graphs $G$ that embed in $\Sigma$. If $H$ is fixed then $C(H, G)$ and $I(H, G)$ differ by a constant factor. In particular, if $|V(H)|=h$ then

$$
\begin{aligned}
& C(H, G) \leqslant I(H, G) \\
& C h!C(H, G) .
\end{aligned}
$$

So to prove our main theorems, it suffices to work with images rather than copies.
To prove the upper bound in Theorem 1.2 we need several tools from the literature. The first two were proved by Eppstein [18]. To state the first result we need the following definition. A collection $\mathcal{H}$ of images of $H$ in $G$ is coherent if for all images $\phi_{1}, \phi_{2} \in \mathcal{H}$ and for all distinct vertices $x, y \in V(H)$, we have $\phi_{1}(x) \neq \phi_{2}(y)$.

Lemma 3.1 ([18]). Let $H$ be a graph with $h$ vertices and $G$ be a graph. Every collection of at least $c_{3.1}(h, t):=h!^{2} t^{h}$ images of $H$ in $G$ contains a coherent subcollection of size at least $t$.

Theorem 3.2 ([18]). There exists a function $c_{3.2}(h, g)$ such that for every planar graph $H$ with $h$ vertices and no $(\leqslant 2)$-separation, and every surface $\Sigma$ of Euler genus $g$,

$$
I(H, \Sigma, n) \leqslant c_{3.2}(h, g) n .
$$

The next key tool is the following result by Miller [52] and Archdeacon [7].
Theorem 3.3 (Additivity of Euler genus [7,52]). For all graphs $G_{1}$ and $G_{2}$, if $\mid V\left(G_{1}\right) \cap$ $V\left(G_{2}\right) \mid \leqslant 2$ then the Euler genus of $G_{1} \cup G_{2}$ is at least the Euler genus of $G_{1}$ plus the Euler genus of $G_{2}$.

We also use the following result of Erdős and Rado [19]; see [6] for a recent quantitative improvement. A $t$-sunflower is a collection $\mathcal{S}$ of $t$ sets for which there exists a set $R$ such that $X \cap Y=R$ for all distinct $X, Y \in \mathcal{S}$. The set $R$ is called the kernel of $\mathcal{S}$.

Lemma 3.4 (Sunflower Lemma [19]). There exists a function $c_{3.4}(h, t)$ such that every collection of $c_{3.4}(h, t)$ many $h$-subsets of a set contains a $t$-sunflower.

Finally, we mention some well-known corollaries of Euler's Formula that we use implicitly. Every graph with $n \geqslant 3$ vertices and Euler genus $g$ has at most $3(n+g-2)$ edges. Moreover, for bipartite graphs the above bound is $2(n+g-2)$. For example, this implies that the complete bipartite graph $K_{3,2 g+3}$ has Euler genus greater than $g$.

## 4. Strongly Non-Planar Graphs

We begin by proving a quantitative version of the upper bound in Theorem 1.1. In fact, we will prove that Theorem 1.1 holds more generally for what we call 'partially subdivided graphs'. A partially subdivided graph is a pair $(H, \mathcal{P})$, where $H$ is a graph and $\mathcal{P}$ is a collection of internally disjoint paths in $H$ such that the two ends of each path in $\mathcal{P}$ are not adjacent in $H$, and every internal vertex of each path in $\mathcal{P}$ has degree 2 in $H$. Let $H-\mathcal{P}$ be the graph obtained from $H$ by deleting every internal vertex of each path in $\mathcal{P}$. Finally, let $H / \mathcal{P}$ be the minor of $H$ obtained by contracting all but one edge from each path in $\mathcal{P}$.

Theorem 4.1. Let $c_{4.1}(h, g):=c_{3.1}\left(h, c_{3.4}(h, 2 g+3)\right)$. Then for every partially subdivided graph $(H, \mathcal{P})$ such that $H / \mathcal{P}$ is strongly non-planar and $|V(H)|=h$, for every surface $\Sigma$ with Euler genus $g$, and for every graph $G$ embedded in $\Sigma$, there are at most $c_{4.1}(h, g)$ images of $H-\mathcal{P}$ in $G$ that extend to an image of $H$ in $G$.

Proof. Assume for the sake of contradiction, that there is a collection $\mathcal{H}$ of more than $c_{4.1}(h, g)$ images of $H$ in $G$, such that all restrictions of these images to $H-\mathcal{P}$ are distinct. By Lemma 3.1, $\mathcal{H}$ contains a coherent subfamily $\mathcal{H}_{0}$ of size at least $c_{3.4}(h, 2 g+3)$. Let $\mathcal{V}$ be the collection of vertex sets of the images of $H$ in $\mathcal{H}_{0}$. By coherence, $|\mathcal{V}|=\left|\mathcal{H}_{0}\right| \geqslant$ $c_{3.4}(h, 2 g+3)$.

By the Sunflower Lemma, $\mathcal{V}$ contains a $(2 g+3)$-sunflower $\mathcal{F}$. (Abusing notations slightly, we equate sets in $\mathcal{F}$ with the corresponding images of $H$ in $\mathcal{H}_{0}$.) Let $Z$ be the kernel of $\mathcal{F}$. Thus $F \cap F^{\prime}=Z$ for all $F, F^{\prime} \in \mathcal{F}$. Let $/$ be the set of internal vertices of all $P \in \mathcal{P}$. Since the restrictions of the images of $H$ in $\mathcal{F}$ to $H-\mathcal{P}$ are all distinct, for each $F \in \mathcal{F}$ there exists a vertex $w_{F} \in F \backslash Z$ such that $w_{F}$ is the image of a vertex in $V(H) \backslash /$. By coherence, we may assume that every $w_{F}$ is the image of the same vertex of $V(H) \backslash I$. For each $F \in \mathcal{F}$, let $C_{F}$ be the component of $F-Z$ that contains $w_{F}$, and let $N_{F}$ be the vertices of $Z$ with at least one neighbour in $V\left(C_{F}\right)$. By coherence, $N_{F}$ is the same for all $F \in \mathcal{F}$. Therefore, we obtain a $K_{\left|N_{F}\right|,|\mathcal{F}|}$ minor in $G$ by contracting each $C_{F}$ to a vertex. Since $|\mathcal{F}|=2 g+3$ and $K_{3,2 g+3}$ does not embed in $\Sigma$, we must have $\left|N_{F}\right| \leqslant 2$.

For each $F \in \mathcal{F}$, consider the pair of subgraphs $\left(F_{1}, F_{2}\right):=\left(F[Z], F\left[(V(F) \backslash Z) \cup N_{F}\right]\right)$ of $F$. Since $\left|N_{F}\right| \leqslant 2$, either $\left(F_{1}, F_{2}\right)$ is a $(\leqslant 2)$-separation of $F$ or $F_{2}=F$. For each $P \in \mathcal{P}$ choose $e_{P} \in E(P)$ and let $E_{\mathcal{P}}:=\bigcup_{P \in \mathcal{P}} E(P) \backslash\left\{e_{P}\right\}$. For $i \in$ [2], let $\Gamma_{i}:=F_{i} /\left(E\left(F_{i}\right) \cap E_{\mathcal{P}}\right)$. Since $w_{F} \in V\left(F_{2}\right) \backslash V\left(F_{1}\right)$, it follows that either $\left(\Gamma_{1}, \Gamma_{2}\right)$ is a $(\leqslant 2)$-separation of $F / \mathcal{P}$ or $\Gamma_{2} \cong F / \mathcal{P}$. Since $F / \mathcal{P} \cong H / \mathcal{P}$ and $H / \mathcal{P}$ is strongly non-planar, either $\left(\Gamma_{2}\right)^{+}$is non-planar or $\Gamma_{2}=F / \mathcal{P}$. In the first case, $F_{2}^{+}$is also nonplanar since $\Gamma_{2}^{+}$is a minor of $F_{2}^{+}$. In the second case, $F_{2}=F$ is also non-planar. Let $F_{2}^{\prime}:=F_{2}^{+}$if the first case holds, and $F_{2}^{\prime}=F$ if the second case holds. If $N_{F}:=\{x, y\}$ and $x y \notin E(F)$, let $\Sigma^{\prime}$ be obtained from $\Sigma$ by adding a handle and using the handle to draw the edge $x y$, and let $G^{\prime}:=G \cup\{x y\}$. Otherwise, let $\Sigma^{\prime}:=\Sigma$ and $G^{\prime}:=G$. We conclude by noting that the family of subgraphs $\left\{F_{2}^{\prime} \mid F \in \mathcal{F}\right\}$ of $G^{\prime}$ contradicts the

Additivity of Euler genus (Theorem 3.3), since they each have Euler genus at least 1, they pairwise intersect only in $N_{F}$, are drawn on a surface $\Sigma^{\prime}$ of Euler genus at most $g+2$, and $|\mathcal{F}|=2 g+3>g+2$.

Note that if $H$ is a strongly non-planar graph, then we recover Theorem 1.1 by applying Theorem 4.1 to the partially subdivided graph $(H, \emptyset)$. We need the stronger statement in Theorem 4.1 for the proof of Theorem 5.9 to come.

## 5. Proof of Main Theorem

The proof of our main theorem uses a variant of the SPQR tree, which we now introduce.
5.1. SPQRK Trees. The $S P Q R$ tree of a 2-connected graph $G$ is a tree that displays all the 2-separations of $G$. Since we need to consider graphs that are not necessarily 2-connected, we use a variant of the SPQR tree that we call the $S P Q R K$ tree.

Let $G$ be a connected graph. The $S P Q R K$ tree $T_{G}$ of $G$ is a tree, where each node $a \in V\left(T_{G}\right)$ is associated with a multigraph $H_{a}$ which is a minor of $G$. Each vertex $x \in V\left(H_{a}\right)$ is a vertex of $G$, that is, $V\left(H_{a}\right) \subseteq V(G)$. Each edge $e \in E\left(H_{a}\right)$ is classified either as a real or virtual edge. By the construction of an SPQRK tree each edge $e \in E(G)$ appears in exactly one minor $H_{a}$ as a real edge, and each real edge $e \in E\left(H_{a}\right)$ is an edge of $G$. The SPQRK tree $T_{G}$ is defined recursively as follows.
(1) If $G$ is 3-connected, then $T_{G}$ consists of a single $R$-node a with $H_{a}:=G$. All edges of $H_{a}$ are real in this case.
(2) If $G$ is a cycle, then $T_{G}$ consists of a single $S$-node a with $H_{a}:=G$. Again, all edges of $H_{a}$ are real in this case.
(3) If $G$ is isomorphic to $K_{1}$ or $K_{2}$, then $T_{G}$ consists of a single $K$-node a with $H_{a}:=G$. Again, all edges of $H_{a}$ are real in this case.
(4) If $G$ is 2 -connected and has a cutset $\{x, y\}$ such that the vertices $x$ and $y$ have degree at least 3 , we construct $T_{G}$ inductively as follows. Let $C_{1}, \ldots, C_{r}(r \geqslant 2)$ be the connected components of $G-\{x, y\}$. First add a $P$-node a to $T_{G}$, for which $H_{a}$ is the graph with $V\left(H_{a}\right):=\{x, y\}$ consisting of $r$ parallel virtual edges and one additional real edge if $x y$ is an edge of $G$.

Next let $G_{i}$ be the graph $G\left[V\left(C_{i}\right) \cup\{x, y\}\right]$ with the additional edge $x y$ if it is not already there. Since we include the edge $x y$, each $G_{i}$ is 2-connected and we can construct the corresponding SPQRK tree $T_{G_{i}}$ by induction. Let $a_{i}$ be the (unique) node in $T_{G_{i}}$ for which $x y$ is a real edge in $H_{a_{i}}$. In order to construct $T_{G}$, we make $x y$ a virtual edge in the node $a_{i}$, and connect $a_{i}$ to $a$ in $T_{G}$.
(5) If $G$ has a cut-vertex $x$ and $C_{1}, \ldots, C_{s}(s \geqslant 2)$ are the connected components of $G-x$, then construct $T_{G}$ inductively as follows. First, add a $Q$-node a to $T_{G}$, for which $H_{a}$ is the graph consisting of the single vertex $x$. For each $i \in[s]$, let $G_{i}:=G\left[V\left(C_{i}\right) \cup\{x\}\right]$. Since $G_{i}$ is connected, we can construct the corresponding

SPQRK tree $T_{G_{i}}$ by induction. If there is a unique node $b_{i} \in V\left(T_{G_{i}}\right)$ such that $x \in V\left(H_{b_{i}}\right)$, then make a adjacent to $b_{i}$ in $T_{G}$. If $x$ is in at least two nodes of $V\left(T_{G_{i}}\right)$, then $x \in V(C) \cap V(D)$ for some ( $\leqslant 2$ )-separation ( $C, D$ ) of $G_{i}$. Since $G_{i}-x$ is connected, there must be a $P$-node $b_{i}$ in $T_{G_{i}}$ such that $x \in V\left(H_{b_{i}}\right)$. Note that $b_{i}$ is not necessarily unique. Choose one such $b_{i}$ and make a adjacent to $b_{i}$ in $T_{G}$.

As a side remark, note that the SPQRK tree $T_{G}$ of $G$ is in fact not unique-there is some freedom in choosing $b_{i}$ in the last point in the definition above-however, for our purposes we do not need uniqueness, we only need that $T_{G}$ displays all the $(\leqslant 2)$-separations of $G$.

The next lemma is the crux of the proof. Let $J$ and $G$ be graphs and $X$ and $Y$ be cliques in $J$ and $G$ respectively, with $|X|=|Y|$. Let $\phi: V(J) \rightarrow V(G)$ be an image of $J$ in $G$. We say that $\phi$ fixes $X$ at $Y$ if $\phi(X)=Y$. Let $\left(J^{\prime}, \mathcal{P}\right)$ be a partially subdivided graph such that $J=J^{\prime} / \mathcal{P}$. We call $u v \in E(J)$ a fake edge if $u$ and $v$ are the set of ends of some $P \in \mathcal{P}$. Otherwise, $u v$ is a true edge.

Lemma 5.1. Let $c_{5.1}(j, g):=12(g+1) c_{3.1}\left(j, c_{3.4}(j, 2 g+3)\right)$. Let $\Sigma$ be a surface of Euler genus $g$. Let $\left(J^{\prime}, \mathcal{P}\right)$ be a connected, partially subdivided planar graph with $\left|V\left(J^{\prime}\right)\right|=j$ and let $J:=J^{\prime} / \mathcal{P}$.

Let $X$ be a clique in $J$ such that:
(1) there do not exist independent flaps $(A, B)$ and $(C, D)$ of $J$ with $X \subseteq V(B \cap D)$,
(2) $|X| \in\{1,2\}$, and if $|X|=2$, then $X$ is a true edge,
(3) if $|X|=1$ and $J \cong P_{3}$, then $e$ is a true edge, where $e$ is the unique edge of $J$ not incident to $X$,
(4) if $|X|=1$ and $J \cong C_{3}$, then $e$ is a true edge, where $e$ is the unique edge of $J$ not incident to $X$,
(5) if $|X|=2$ and $J \cong C_{4}$, then $e$ is a true edge, where $e$ is the unique edge of $J$ not incident to a vertex of $X$,
(6) if $J$ is 3 -connected, then all edges of $J$ with neither end in $X$ are true,
(7) if $(A, B)$ is a flap of $J$, with $X \subseteq V(B),|V(A \cap B)|=1$, and $A \cong P_{3}$, then $e$ is a true edge, where $e$ is the unique edge of $A$ not incident to $V(A \cap B)$,
(8) if $(A, B)$ is a flap of $J$, with $X \subseteq V(B),|V(A \cap B)|=1$, and $A \cong C_{3}$, then e is a true edge, where $e$ is the unique edge of $A$ not incident to $V(A \cap B)$,
(9) if $(A, B)$ is a flap of $J$, with $X \subseteq V(B),|V(A \cap B)|=2$, and $A^{+} \cong C_{3}$, then at least one e or $f$ is a true edge, where $e$ and $f$ are the two edges of $A$ with an end not on $V(A \cap B)$.
(10) if $(A, B)$ is a flap of $J$, with $X \subseteq V(B),|V(A \cap B)|=2$, and $A^{+} \cong C_{4}$, then $e$ is a true edge, where $e$ is the unique edge of $A$ not incident to $V(A \cap B)$,
(11) if $(A, B)$ is a flap of $J$ such that $A^{+}$is 3-connected, then all edges of $A$ with neither end in $V(A \cap B)$ are true.

Then for every n-vertex graph $G$ embeddable in $\Sigma$ and every clique $Y$ in $G$ with $|Y|=|X|$, there are at most $c_{5.1}(j, g) n$ images of $J^{\prime}-\mathcal{P}$ in $G$ with $X$ fixed at $Y$ that extend to an image of $J^{\prime}$ in $G$.

Proof of Lemma 5.1. Let $G$ be an $n$-vertex graph embedded in a surface $\Sigma$ of Euler genus $g$ and $Y$ be a clique in $G$ with $|Y|=|X|$. We begin by proving the lemma when $J$ is small. The lemma clearly holds if $|V(J)|=1$ or $|V(J)|=2=|X|$. If $|V(J)|=2$ and $|X|=1$, let $y$ be the vertex of $J$ not in $X$. Since there are at most $n-1$ vertices of $G$ to send $y$ to, we are done. Similarly, we are done if $J \in\left\{P_{3}, C_{3}\right\}$ and $|X|=2$. If $J \in\left\{P_{3}, C_{3}\right\}$ and $|X|=1$ let $e$ be the unique edge of $J$ not incident to $X$. Note that $e$ exists in the case that $J \cong P_{3}$, since the vertex in $X$ cannot be the middle vertex of $J$ by (1). By (3) and (4), $e$ is a true edge, so there are at most $|E(G)| \leqslant 3(g+1) n$ edges of $G$ to send $e$ to. Each edge gives at most two images of $J^{\prime}-\mathcal{P}$ with $X$ fixed at $Y$ in $G$, so there are at most $6(g+1) n$ such images. Suppose that $|V(J)|=4$. Note that $J \not \approx P_{4}$, by (1). If $J \cong C_{4}$, then $|X|=2$ by (1). Let $e$ be the unique edge of $J$ not incident to a vertex of $X$. By (5), $e$ is a true edge, so again there are at most $3(g+1) n$ edges of $G$ to send $e$ to. Each edge gives at most four images of $J^{\prime}-\mathcal{P}$ with $X$ fixed at $Y$ in $G$, so there are at most $12(g+1) n$ such images.

In summary, by the above discussion we may assume that $|V(J)| \geqslant 4$, and $J \neq P_{4}, C_{4}$ in case $|V(J)|=4$.

Let $T_{J}$ be the SPQRK tree of $J$. Suppose that $V\left(T_{J}\right)=\{a\}$. If $a$ is a $K$-node, then we are done since $|V(J)| \leqslant 2$. If $a$ is an $S$-node, then by $(1), J \cong C_{3}$ or $J \cong C_{4}$, so we are done. By the preceding remarks, we may assume that $J$ is 3-connected, or $|V(J)| \geqslant 4$ and $\left|V\left(T_{J}\right)\right| \geqslant 2$. A clique $X^{\prime}$ of $J$ is a true clique if $\left|X^{\prime}\right|=1$, or $\left|X^{\prime}\right|=2$ and the edge of $X^{\prime}$ is a true edge. If $J$ is 3 -connected, we have the following easy claim.

Claim 5.2. If $J$ is 3 -connected, then there exists a true clique $X^{\prime}$ in $J$ such that for all $w \in V(J) \backslash\left(X \cup X^{\prime}\right)$, there are three internally disjoint paths in $J$ from $w$ to $X \cup X^{\prime}$, whose ends in $X \cup X^{\prime}$ are distinct.

Proof. Since $J$ is 3 -connected, there is an edge $X^{\prime}$ of $J$ with neither end in $X$; otherwise, $X$ is a cutset of $J$ with $|X| \leqslant 2$. By (6), $X^{\prime}$ is a true edge. Since $J$ is 3 -connected, we are done by Menger's theorem.

We now suppose that $|V(J)| \geqslant 4$ and $\left|V\left(T_{J}\right)\right| \geqslant 2$, and we prove that Claim 5.2 also holds in this case. Let $W$ be the set of $K-, S$-, and $R$-nodes of $V\left(T_{J}\right)$. Note that for each $a \in W, H_{a}$ is a subgraph of $J$. If $U$ is a non-empty proper subset of $W$, we define $H_{U}:=$ $\bigcup_{a \in U} H_{a}, \operatorname{bd}(U):=V\left(H_{U} \cap H_{w \backslash U}\right), \lambda(U):=\left|b d\left(H_{U}\right)\right|$, and $\operatorname{sep}(U):=\left(H_{U}, H_{w \backslash U}\right)$.

Claim 5.3. $T_{J}$ is a path and there is a leaf $\ell$ of $T_{J}$ such that $X \subseteq V\left(H_{\ell}\right)$ and $X \backslash \operatorname{bd}(\{\ell\}) \neq$ $\emptyset$.

Proof. Since $\left|V\left(T_{J}\right)\right| \geqslant 2, T_{J}$ has at least two leaves. For each leaf a of $T_{J}$, there is a flap $\left(C^{a}, D^{a}\right)$ such that $V\left(C^{a}\right)=V\left(H_{a}\right)$. Since $\left(C^{a}, D^{a}\right)$ and $\left(D^{a}, C^{a}\right)$ are independent flaps, exactly one of $\left(V\left(C^{a}\right) \backslash V\left(D^{a}\right)\right) \cap X$ or $\left(V\left(D^{a}\right) \backslash V\left(C^{a}\right)\right) \cap X$ is non-empty by (1). Thus, $T_{\jmath}$ has exactly two leaves and there is a leaf $\ell$ of $T_{\jmath}$ such that $X \subseteq V\left(H_{\ell}\right)$ and $X \backslash \operatorname{bd}(\{\ell\}) \neq \emptyset$.

Claim 5.4. Let $r$ be the other leaf of $T_{J}$. Then for all non-empty $U \subseteq W \backslash\{\ell, r\}$ such that $U$ is not a single $K$-node, $\lambda(U) \geqslant 3$.

Proof. Towards a contradiction, suppose that $\lambda(U) \leqslant 2$ for some non-empty $U \subseteq$ $W \backslash\{\ell, r\}$ which is not a single $K$-node. Let $\left(C^{r}, D^{r}\right)$ be the flap of $J$ such that $V\left(C^{r}\right)=V\left(H_{r}\right)$. Since $X \subseteq V\left(H_{\ell}\right),\left(C^{r}, D^{r}\right)$ and $\operatorname{sep}(U)$ are independent flaps of $J$ which contradict (1).

Claim 5.5. Let $S:=\left\{s \in V(J) \backslash X \mid \operatorname{deg}_{\jmath}(s) \leqslant 2\right\}$. Then $|S| \leqslant 2, S \subseteq V\left(H_{r}\right)$, and if $|S|=2$, then the two vertices in $S$ are adjacent in $J$.

Proof. Since $|V(J)| \geqslant 4$, for each $s \in S,(\delta(s), J-s)$ is a flap with $X \subseteq V(J-s)$, where $\delta(s)$ is the subgraph of $J$ induced by the edges incident to $s$. Thus, by (1), $S$ is a clique in $J$, and therefore $|S| \leqslant 3$. Moreover, $|S|=3$ is impossible, since $|V(J)| \geqslant 4$ and $J$ is connected. Thus, $|S| \leqslant 2$. Since $(A, B)=\operatorname{sep}(\{r\})$ is a flap with $X \subseteq V(B)$, (1) also implies $S \subseteq V\left(H_{r}\right)$.

Claim 5.6. J has at most two cut-vertices. Moreover, if J has two cut-vertices, then they are the vertex set of some $K$-node of $T_{J}$.

Proof. Let $c$ and $d$ be distinct cut-vertices of $J$. Let $W_{c d} \subseteq W$ be the set of $K-$, $S$-, and $R$-nodes of $V\left(T_{J}\right)$ strictly between the $Q$-nodes corresponding to $c$ and $d$ in $T_{J}$. Note that $\operatorname{sep}\left(W_{c d}\right)$ is a 2-separation of $J$, unless $W_{c d}$ is just a single $K$-node. Moreover, if $W_{c d}$ is not a single $K$-node, then $\operatorname{sep}(\{r\})$ and $\operatorname{sep}\left(W_{c d}\right)$ would contradict (1). It follows that $J$ has at most two cut-vertices, and that $\{c, d\}$ is the vertex set of some $K$-node of $T_{J}$.

Claim 5.7. There exists a true clique $X^{\prime}$ in $J$ such that for all $w \in V(J) \backslash\left(X \cup X^{\prime}\right)$, there are three internally disjoint paths in $J$ from $w$ to $X \cup X^{\prime}$, whose ends in $X \cup X^{\prime}$ are distinct.

Proof. If $r$ is an $R$-node, then all edges of $H_{r}^{-}$are true by (11). In this case we let $X^{\prime}$ be any edge of $H_{r}^{-}$such that $X^{\prime} \cap \operatorname{bd}(\{r\})=\emptyset$. If $r$ is an $S$-node, then by (1), either $H_{r} \cong C_{3}$, or $H_{r} \cong C_{4}$ and $|\operatorname{bd}(\{r\})|=2$. In either case, by (8), (9), and (10), we can choose $X^{\prime}$ to be a true edge such that $V\left(H_{r}\right) \backslash\left(X^{\prime} \cup b d(\{r\})\right)=\emptyset$. Lastly, suppose that $r$ is a $K$-node. Then $H_{r} \cong K_{2}$, say $H_{r}$ consists of the edge $u v$ with $v \in \operatorname{bd}(\{r\})$. If $v \notin S$, we let $X^{\prime}:=\{u\}$. If $v \in S$, we let $X^{\prime}:=\{u, v\}$; note that $u v$ is a true edge by (7) in this case.

Suppose the claim is false for the above choice of $X^{\prime}$ for some vertex $w \in V(J) \backslash\left(X \cup X^{\prime}\right)$, and let $X^{+}:=X \cup X^{\prime}$. Note that $\left|X^{+}\right| \geqslant 3$ by our choice of $X^{\prime}$, since if $|X|=1$ then $J$ is 2-connected by (1). (Indeed, if $J$ is not 2-connected then $J$ has a flap $(A, B)$ that is a 1 -separation with $X \subseteq B$, but then $(B, A \cup X)$ is also a flap, contradicting (1).) Thus, by Menger's theorem, there is a ( $\leqslant 2$ )-separation $\left(J_{1}, J_{2}\right)$ of $J$ with $w \in V\left(J_{1}\right) \backslash V\left(J_{2}\right)$ and $X^{+}:=X \cup X^{\prime} \subseteq V\left(J_{2}\right)$.

Let $a$ be an $S$-node of $T_{J}$. Observe that every 2 -separation of the cycle $H_{a}$ lifts to a 2-separation of $J$. We say that a 2 -separation of $J$ is rooted at a if it is a lift of a 2-separation of $H_{a}$. Since the SPQRK tree $T_{J}$ of $J$ 'displays' all the $(\leqslant 2)$-separations of $J$, every $(\leqslant 2)$-separation $(A, B)$ of $J$

- is equal to $\operatorname{sep}(U)$ for some $U \subseteq W$, or
- is rooted at some $S$-node a of $T_{J}$, or
- is obtained from a 1 -separation $\left(A^{\prime}, B^{\prime}\right)$ by adding an isolated vertex to $A^{\prime}$ or $B^{\prime}$ (which is thus in $A \cap B$ ).

Suppose $\left(J_{1}, J_{2}\right)=\operatorname{sep}(U)$ for some $U \subseteq W$. Since $X^{+} \subseteq V\left(J_{2}\right), X \backslash \operatorname{bd}(\{\ell\}) \neq \emptyset$, and $X^{\prime} \backslash \operatorname{bd}(\{r\}) \neq \emptyset$, we have $U \subseteq W \backslash\{\ell, r\}$. This is a contradiction since $\lambda(U) \geqslant 3$ by Claim 5.4. Similarly, $\left(J_{1}, J_{2}\right)$ cannot be rooted at an $S$-node, unless $\operatorname{deg}_{J}(x)=2$ for some $x \in V\left(J_{1}\right) \backslash V\left(J_{2}\right)$. However, by Claim 5.5 and our choice of $X^{\prime}, \operatorname{deg}_{j}(x) \geqslant 3$, for all $x \in V(J) \backslash X^{+}$, so this is also impossible.

Finally, suppose the third possibility holds for some 1-separation $\left(A^{\prime}, B^{\prime}\right)$ of $J$. Observe that every 1-separation $(A, B)$ of $J$ has $X^{\prime} \subseteq V(A)$ and $X \subseteq V(B)$; or $X \subseteq V(A)$ and $X^{\prime} \subseteq V(B)$. By swapping the order of $\left(A^{\prime}, B^{\prime}\right)$ we may assume that $X^{\prime} \subseteq V\left(A^{\prime}\right)$ and $X \subseteq V\left(B^{\prime}\right)$. Moreover, $\left(A^{\prime}, B^{\prime} \cup\{a\}\right) \in\left\{\left(J_{1}, J_{2}\right),\left(J_{2}, J_{1}\right)\right\}$ for some $a \in V\left(A^{\prime}\right) \backslash V\left(B^{\prime}\right)$; or $\left(A^{\prime} \cup\{b\}, B^{\prime}\right) \in\left\{\left(J_{1}, J_{2}\right),\left(J_{2}, J_{1}\right)\right\}$ for some $b \in V\left(B^{\prime}\right) \backslash V\left(A^{\prime}\right)$. If $\left(A^{\prime} \cup\{b\}, B^{\prime}\right)=$ $\left(J_{1}, J_{2}\right)$, then $\left(A^{\prime}, B^{\prime}\right)$ is a 1-separation of $J$ such that $X \cup X^{\prime} \subseteq V\left(B^{\prime}\right)$. However, no such separation exists (by the proof that $\left(J_{1}, J_{2}\right) \neq \operatorname{sep}(U)$ for all $U \subseteq W$ ). Similarly, $\left(A^{\prime}, B^{\prime} \cup\{a\}\right)=\left(J_{2}, J_{1}\right)$ is impossible. If $\left(A^{\prime} \cup\{b\}, B^{\prime}\right)=\left(J_{2}, J_{1}\right)$, then $\left(A^{\prime}, B^{\prime}\right)$ and $\left(B^{\prime}, A^{\prime} \cup\{b\}\right)$ contradict (1). The remaining case is $\left(A^{\prime}, B^{\prime} \cup\{a\}\right)=\left(J_{1}, J_{2}\right)$. Let $c$ be the unique vertex in $V\left(A^{\prime}\right) \cap V\left(B^{\prime}\right)$. Recall that by the choice of $X^{\prime}$, if $r$ is an $R$-node or an $S$-node, then $\left|X^{\prime}\right|=2$ and $c \notin X^{\prime}$. However, this contradicts $X^{\prime} \subseteq V\left(J_{2}\right)$. Thus, $r$ is a $K$-node. Note that $\left(A^{\prime}, B^{\prime}\right)=\operatorname{sep}(\{r\})$ is impossible, because $V\left(A^{\prime}\right) \backslash\left(V\left(B^{\prime} \cup\{a\}\right)\right)$ would be empty, and hence $\left(A^{\prime}, B^{\prime} \cup\{a\}\right)$ is not a 2-separation. Thus $c \notin V\left(H_{r}\right)$. Let $v$ be the cut-vertex of $J$ in $V\left(H_{r}\right)$. By Claim 5.6, $c$ and $v$ are adjacent and $v \in S=$ $\left\{s \in V(J) \backslash X \mid \operatorname{deg}_{J}(s) \leqslant 2\right\}$. In this case, by our choice of $X^{\prime}$, we have $\left|X^{\prime}\right|=2$ and $c \notin X^{\prime}$, so we again have a contradiction.

Let $X^{\prime}$ be the true clique of $J$ given by Claim 5.2 or by Claim 5.7, depending whether $J$ is 3 -connected, or $|V(J)| \geqslant 4$ and $\left|V\left(T_{J}\right)\right| \geqslant 2$. Suppose $\left|X^{\prime}\right|=1$. For each $y \in V(G)$, let $c_{y}$ be the number of images of $J^{\prime}-\mathcal{P}$ in $G$, with $X$ fixed at $Y$ and $X^{\prime}$ fixed at $y$, that extend to an image of $J^{\prime}$ in $G$. Suppose $\left|X^{\prime}\right|=2$. For each $f \in E(G)$, let $c_{f}$ be the
number of images of $J^{\prime}-\mathcal{P}$ in $G$, with $X$ fixed at $Y$ and $X^{\prime}$ fixed at $f$, that extend to an image of $J^{\prime}$ in $G$.

We claim that if $\left|X^{\prime}\right|=1$ then $c_{y} \leqslant c_{3.1}\left(j, c_{3.4}(j, 2 g+3)\right)$ for all $y \in V(G)$, if $\left|X^{\prime}\right|=2$ then $c_{f} \leqslant c_{3.1}\left(j, c_{3.4}(j, 2 g+3)\right)$ for all $f \in E(G)$. We will prove both inequalities simultaneously, since the proof is the same. Arguing by contradiction, suppose $y$ or $f:=u v$ is a counterexample, and set $Y^{+}=Y \cup\{y\}$ if $\left|X^{\prime}\right|=1$ and $Y^{+}=Y \cup\{u, v\}$ if $\left|X^{\prime}\right|=2$. Then, there exists a collection $\mathcal{J}_{1}$ of more than $c_{3.1}\left(j, c_{3.4}(j, 2 g+3)\right)$ images of $J^{\prime}$ in $G$ with $X$ fixed at $Y$ and $X^{\prime}$ fixed at $y$ (respectively, $X^{\prime}$ fixed at $f$ ) such that the restrictions of these images to $J^{\prime}-\mathcal{P}$ are all distinct.

By Lemma 3.1, $\mathcal{J}_{1}$ contains a coherent subfamily $\mathcal{J}_{2}$ of size at least $c_{3.4}(j, 2 g+3)$. Let $\mathcal{V}$ be the collection of vertex sets of $\mathcal{J}_{2}$. Note that by coherence, $|\mathcal{V}|=\left|\mathcal{J}_{2}\right| \geqslant$ $c_{3.4}(j, 2 g+3)$. By Lemma 3.4, $\mathcal{V}$ contains an $s$-sunflower $\mathcal{F}$, where $s \geqslant 2 g+3$. Let $Z$ be the kernel of $\mathcal{F}$. By construction, $Y^{+} \subseteq Z$. Let / be the set of internal vertices of all $P \in \mathcal{P}$. Since the restrictions of each copy of $J^{\prime}$ in $\mathcal{F}$ to $J^{\prime}-\mathcal{P}$ are all distinct, for all $F \in \mathcal{F}$ there must be a vertex $w_{F} \in F \backslash Z$ such that $w_{F}$ is the image of a vertex in $V\left(J^{\prime}\right) \backslash I$. By coherence, we may assume that each $w_{F}$ corresponds to the same vertex in $V\left(J^{\prime}\right) \backslash I$. By Claim 5.2 and Claim 5.7, there are three internally disjoint paths from $w_{F}$ to $Y^{+}$in $G[F]$ whose ends in $Y^{+}$are distinct. For each $F \in \mathcal{F}$, let $Z_{F}$ be the set consisting of the first vertices of $Z$ on each of these three paths. By coherence, we may assume $Z_{F}$ is the same for all $F \in \mathcal{F}$. Thus, $G$ contains a subdivision of $K_{3,2 g+3}$. However, this is impossible, since $K_{3,2 g+3}$ does not embed in $\Sigma$.

It follows that $c_{y}, c_{f} \leqslant c_{3.1}\left(j, c_{3.4}(j, 2 g+3)\right)$ for all $y \in V(G)$ and $f \in E(G)$. The proof is complete by summing over all possible $y \in V(G)$ if $\left|X^{\prime}\right|=1$, and summing over all possible $f \in E(G)$ if $\left|X^{\prime}\right|=2$.

The final ingredient we need is the following 'flap reduction' lemma.
Lemma 5.8. Let $H$ be a connected graph with flap-number $k \geqslant 1$. Let $A$ be a subgraph of $H$ that is maximal (under the subgraph relation) subject to the following conditions:

- A has no isolated vertices, and
- there exists a flap $(A, B)$ of $H$ and a set $\mathcal{F}$ of $k$ independent flaps in $H$ with $(A, B) \in \mathcal{F}$.

Then $B^{+}$has flap-number $k-1$. Moreover, $A$ is connected and $A^{+}$does not contain independent flaps $(C, D)$ and $\left(C^{\prime}, D^{\prime}\right)$ such that $V(A \cap B) \subseteq V\left(D \cap D^{\prime}\right)$.

Proof. We first show that $B^{+}$has flap-number at least $k-1$. To see this, let $\mathcal{F}$ be a set of $k$ independent flaps in $H$ such that $(A, B) \in \mathcal{F}$. Every flap $(C, D) \in \mathcal{F} \backslash\{(A, B)\}$ corresponds to a flap $\left(C, D^{\prime}\right)$ in $B^{+}$, unless $k=2, H$ is planar, and $\mathcal{F}=\{(A, B),(B, A)\}$. In either case, $B^{+}$has flap-number at least $k-1$.

We now prove the upper bound. Towards a contradiction, let $\left(C_{1}, D_{1}\right), \ldots,\left(C_{k}, D_{k}\right)$ be independent flaps in $B^{+}$. Let $X:=V(A \cap B)$. If $X \subseteq V(S)$ for a subgraph $S$ of $B^{+}$, we let $S+_{x} A$ be the subgraph of $H$ obtained by gluing $A$ to $S$ along $X$, and deleting the edge between the ends of $X$ in $B^{+}$if the edge does not exist in $H$. If $X$ is contained in $V\left(D_{\ell}\right)$ for every $\ell \in[k]$, then $(A, B),\left(C_{1}, D_{1}+x A\right), \ldots,\left(C_{k}, D_{k}+x A\right)$ are $k+1$ pairwise independent flaps in $H$. Thus $X$ is not contained in $V\left(D_{\ell}\right)$ for some $\ell \in[k]$. By relabelling, we may assume $\ell=1$. Since $\left(V\left(C_{1}\right) \backslash V\left(D_{1}\right)\right) \cap X \neq \emptyset$ and $\left(V\left(C_{1}\right) \backslash V\left(D_{1}\right)\right) \cap\left(V\left(C_{i}\right) \backslash V\left(D_{i}\right)\right)=\emptyset$ for all $i>1$, we have $X \subseteq V\left(D_{i}\right)$ for all $i>1$. Then, $\left(C_{1}+x A, D_{1}\right),\left(C_{2}, D_{2}+x A\right), \ldots\left(C_{k}, D_{k}+x A\right)$ are $k$ independent flaps in $H$. Since $A$ is a proper subgraph of $C_{1}+x A$, this contradicts the maximality of $A$.

Finally, we show that the last sentence of the lemma holds. Suppose that $A$ is disconnected and $A_{1}, \ldots, A_{c}$ are the connected components of $A$. Since $H$ is connected, $A_{i}$ contains a vertex of $V(A \cap B)$ for all $i \in[c]$. Thus, $c=2$ and $A_{1}$ and $A_{2}$ each contain exactly one vertex of $V(A \cap B)$. Since neither $A_{1}$ nor $A_{2}$ is an isolated vertex, there exist $B_{1}$ and $B_{2}$ such that $\left(A_{1}, B_{1}\right)$ and $\left(A_{2}, B_{2}\right)$ are independent flaps of $H$. Thus, $\mathcal{F} \backslash\{(A, B)\} \cup\left\{\left(A_{1}, B_{1}\right),\left(A_{2}, B_{2}\right)\right\}$ is a set of $k+1$ independent flaps of $H$, which contradicts that $H$ has flap-number $k$. Similarly, $A^{+}$does not contain independent flaps $(C, D)$ and $\left(C^{\prime}, D^{\prime}\right)$ such that $V(A \cap B) \subseteq V\left(D \cap D^{\prime}\right)$.

We call a subgraph $A$ of $H$ a half-flap if $(A, B)$ is a flap of $H$ for some $B$. Two halfflaps $A$ and $C$ are independent if there exist $B$ and $D$ such that $(A, B)$ and $(C, D)$ are independent flaps. We say that $A$ is a full-half-flap if $A$ satisfies the conditions of Lemma 5.8.

We stress that the condition that $A$ is maximal is essential in the definition of a full-half-flap. To see this, let $H$ be the $2 \times k$ grid, for $k$ large. Note that even though $H$ has many 2-separations, the flap-number of H is 2 . Moreover, the only full-half-flaps of $H$ are $H-y$, where $y$ is one of the four degree- 2 vertices of $H$. In this case, $B^{+} \cong K_{3}$, which has flap-number 1 . Reducing on any other flap of $H$ yields a graph that still has flap-number 2.

We now complete the proof of the upper bound in Theorem 1.2
Theorem 5.9. Let $c_{5.9}(h, g):=6(g+1) c_{4.1}(h, g) c_{3.2}(h, g) c_{5.1}(h, g+2)^{h}$. Then for every graph $H$ with $h$ vertices and every surface $\Sigma$ of Euler genus $g$ in which $H$ embeds,

$$
C(H, \Sigma, n) \leqslant I(H, \Sigma, n) \leqslant c_{5.9}(h, g) n^{f(H)} .
$$

Proof. Let $k:=f(H)$. Since $c_{5.9}\left(h_{1}, g\right) \cdot c_{5.9}\left(h_{2}, g\right) \leqslant c_{5.9}(h, g)$ whenever $h_{1}+h_{2}=h$, we may assume that $H$ is connected by induction on $|V(H)|$. A reduction sequence of $H$ is a sequence of graphs $H_{k}, \ldots, H_{j}$ for some $j \leqslant k$, where $H_{k}:=H$, and for all $i>j$, $H_{i-1}:=B_{i}^{+}$, where $\left(A_{i}, B_{i}\right)$ is a flap in $H_{i}$ satisfying the conditions of Lemma 5.8. By Lemma 5.8, every reduction sequence satisfies the following properties.

Claim 5.10. Let $H_{k}, \ldots, H_{j}$ be a reduction sequence of $H$, with corresponding flaps $\left(A_{\ell}, B_{\ell}\right)$ in $H_{\ell}$. Then for all $\ell \in\{k, \ldots, j+1\}, A_{\ell}$ is connected and $A_{\ell}^{+}$does not contain independent flaps $(C, D)$ and $\left(C^{\prime}, D^{\prime}\right)$ such that $V\left(A_{\ell}\right) \cap V\left(B_{\ell}\right) \subseteq V(D) \cap V\left(D^{\prime}\right)$. Moreover, for all $\ell \in\{k, \ldots, j\}, H_{\ell}$ has flap-number $\ell$.

We now establish further properties of reduction sequences. Let $H_{k}, \ldots, H_{j}$ be a reduction sequence of $H$, with corresponding flaps $\left(A_{\ell}, B_{\ell}\right)$ in $H_{\ell}$. If $V\left(A_{\ell}\right) \cap V\left(B_{\ell}\right):=\{u, v\}$ and $u v \notin E\left(H_{\ell}\right)$, we declare $u v$ to be a fake edge of $H_{\ell-1}$. An edge of $H_{\ell}$ is a fake edge if it is a fake edge of $H_{\ell^{\prime}}$ for some $\ell^{\prime} \geqslant \ell$, and it is a true edge if it is not a fake edge.

Claim 5.11. Let $H_{k}, \ldots, H_{j}$ be a reduction sequence of $H$, with corresponding flaps $\left(A_{\ell}, B_{\ell}\right)$ in $H_{\ell}$. Then for all $\ell \in\{k, \ldots, j\}$, if $(C, D)$ is a flap in $H_{\ell}$ such that $C^{+}$is 3-connected, then every edge of $C$ with neither end in $V(C \cap D)$ is true.

Proof. Let $(C, D)$ be a flap of $H_{\ell}$ that is a counterexample with $|E(C)|-|V(D)|$ maximum. Let $X:=V(C \cap D)$. Note that, by the maximality of $|E(C)|-|V(D)|$, if $H_{\ell}$ contains an edge $f$ whose ends are $X$, then $f \in E(C)$. We claim that each $x \in X$ is incident to an edge of $D$. If not, then $x$ must be an isolated vertex of $D$. But now, $(C, D-x)$ contradicts the maximality of $|E(C)|-|V(D)|$. For all $i \in\{k, \ldots, \ell+1\}$ set $X_{i}:=V\left(A_{i} \cap B_{i}\right)$. Let $\mathcal{I}$ be the set of indices $i \in\{k, \ldots, \ell+1\}$ such that $X_{i}$ is the set of ends of a fake edge of $C^{-}$. Let $s$ be the smallest index in $\mathcal{I}$, and let $e$ be the corresponding fake edge. Since $H_{k}, \ldots, H_{j}$ is a reduction sequence, there is a collection $\mathcal{F}_{s}$ of $s$ independent flaps of $H_{s}$ such that $\left(A_{s}, B_{s}\right) \in \mathcal{F}_{s}$ and $\sum_{\left(A^{\prime}, B^{\prime}\right) \in \mathcal{F}_{s}}\left|V\left(A^{\prime}\right)\right|+\left|E\left(A^{\prime}\right)\right|$ is minimum. Let $(A, B)$ be an arbitrary flap in $\mathcal{F}_{s} \backslash\left\{\left(A_{s}, B_{s}\right)\right\}$.

There are several cases to consider depending on how $A$ and $C$ interact.
Suppose that $V(A)$ is a proper subset of $V(C)$. Since $C^{+}$is 3-connected and $V(C) \backslash$ $V(A) \neq \emptyset$, for some $Y \in\left\{X_{s}, X\right\}$, one vertex $y$ of $Y$ is in $V(A) \backslash V(B)$ and the other vertex of $Y$ is in $V(B) \backslash V(A)$. Observe that $V\left(A_{s}\right) \subseteq V(B)$ because $\left(A_{s}, B_{s}\right)$ and $(A, B)$ are independent flaps of $H_{s}$. In particular, $X_{s} \subseteq V(B)$. By the minimality of $\sum_{\left(A^{\prime}, B^{\prime}\right) \in \mathcal{F}_{s}}\left|V\left(A^{\prime}\right)\right|+\left|E\left(A^{\prime}\right)\right|$, if $H_{s}$ contains an edge $f$ whose ends are $X$, then $f \in E(B)$. Since $V(A)$ is a proper subset of $V(C)$ and each $x \in X$ is incident to an edge of $D$, this implies $X \subseteq V(B)$. Therefore, for either choice of $Y$, we have $y \in V(B)$. Thus, $y \in V(A \cap B)$, which contradicts that $y \in V(A) \backslash V(B)$.

Suppose that $V(A)=V(C)$ and $\left|X_{s} \cup X\right| \geqslant 3$. Observe that $X_{s} \cup X \subseteq V(A)$. Since $V\left(A_{s}\right) \subseteq V(B), X_{s} \subseteq V(B)$. Moreover, since $V(D) \subseteq V(B), X \subseteq V(B)$. Therefore, $X_{s} \cup X \subseteq V(A \cap B)$. Since $\left|X_{s} \cup X\right| \geqslant 3$, this implies that $(A, B)$ is a ( $\geqslant 3$ )-separation of $H_{s}$, which contradicts that $(A, B)$ is a flap.

Suppose that $A \cap C=S$, where $S$ is a stable set and $S$ contains a vertex $x \notin X$. If $x \notin X_{s}$, then $x$ is an isolated vertex of $A$. If $x \in X_{s}$, then since $(A, B)$ and $\left(A_{s}, B_{s}\right)$ are independent flaps, $V\left(A \cap A_{s}\right) \backslash X_{s}=\emptyset$. Thus, $x$ is an isolated vertex of $A$ in this
case as well. But now, replacing $(A, B)$ by $(A-x, B)$ contradicts the minimality of $\sum_{\left(A^{\prime}, B^{\prime}\right) \in \mathcal{F}_{s}}\left|V\left(A^{\prime}\right)\right|+\left|E\left(A^{\prime}\right)\right|$.

Suppose that $A \cap C$ consists of just a single edge $x y$. Since $C^{+}$is 3-connected, $\operatorname{deg}_{C^{+}}(x) \geqslant 3$ and $\operatorname{deg}_{C^{+}}(y) \geqslant 3$. For $z \in\{x, y\}$, let $d(z)$ be the number of $Y \in\left\{X_{s}, X\right\} \backslash\{\{x, y\}\}$ such that $z \in Y$. Observe that $\operatorname{deg}_{C^{+}}(z) \leqslant \operatorname{deg}_{A \cap C}(z)+$ $\operatorname{deg}_{B \cap C}(z)+d(z)$ for both $z \in\{x, y\}$. Since $\operatorname{deg}_{A \cap C}(z)=1$ for both $z \in\{x, y\}$, this yields $\operatorname{deg}_{B \cap C}(z) \geqslant 2-d(z)$ for both $z \in\{x, y\}$. If $\{x, y\} \subseteq X \cup X_{s}$, then $d(x) \leqslant 1$ and $d(y) \leqslant 1$. Therefore, $\operatorname{deg}_{B \cap C}(x) \geqslant 1$ and $\operatorname{deg}_{B \cap C}(y) \geqslant 1$, which implies $\{x, y\} \subseteq V(A \cap B)$. But now, $(A-x y, B \cup\{x y\})$ is a $(\leqslant 2)$-separation, which contradicts the minimality of $\sum_{\left(A^{\prime}, B^{\prime}\right) \in \mathcal{F}_{s}}\left|V\left(A^{\prime}\right)\right|+\left|E\left(A^{\prime}\right)\right|$. By symmetry, we may assume $y \notin X_{s} \cup X$. Thus, $d(y)=0$, which gives $\operatorname{deg}_{B \cap C}(y) \geqslant 2$. In particular, $y \in V(A \cap B)$. Moreover, since $y \notin X_{s} \cup X$, we have $y \in V(C) \backslash V(D)$, and thus $\operatorname{deg}_{A}(y)=\operatorname{deg}_{A \cap C}(y)=1$. Observe that $|V(A-y) \cap V(B \cup\{x y\})| \leqslant 2$ because $V(A-y) \cap V(B \cup\{x y\}) \subseteq(V(A \cap B) \backslash\{y\}) \cup\{x\}$. Therefore $(A-y, B \cup\{x y\})$ is a $(\leqslant 2)$-separation. But now $A-y$ is a half-flap contained in $A$, which contradicts the minimality of $\sum_{\left(A^{\prime}, B^{\prime}\right) \in \mathcal{F}_{s}}\left|V\left(A^{\prime}\right)\right|+\left|E\left(A^{\prime}\right)\right|$.

Suppose that $V(C)$ is a proper subset of $V(A)$. Clearly, $X_{s} \subseteq V(A)$. Also, $X_{s} \subseteq V(B)$ since $(A, B)$ and $\left(A_{s}, B_{s}\right)$ are independent flaps. Therefore, $V(A \cap B)=X_{s}$, since $\left|X_{s}\right|=2$. Moreover, $A \cap D$ contains at least one vertex not in $X$, since $V(C)$ is a proper subset of $V(A)$. If $A \cap D$ meets $B \cap D$ at a vertex $x \notin X$, then $x \notin X_{s}$ and $x \in V(A \cap B)$, which contradicts that $V(A \cap B)=X_{s}$. Thus, $V(A \cap D) \cap V(B \cap D) \subseteq X$. It follows that $A \cap D$ is a half-flap, since $|X| \leqslant 2$. However, this contradicts the minimality of $\sum_{\left(A^{\prime}, B^{\prime}\right) \in \mathcal{F}_{s}}\left|V\left(A^{\prime}\right)\right|+\left|E\left(A^{\prime}\right)\right|$ since $|V(A \cap D)|<|V(A)|$.

Suppose that $3 \leqslant|V(A \cap C)|<|V(C)|$ and $V(A) \backslash V(C) \neq \emptyset$. Since $C^{+}$is 3-connected, for some $Y \in\left\{X_{s}, X\right\}$, one vertex $y$ of $Y$ is in $V(A) \backslash V(B)$ and the other vertex of $Y$ is in $V(B) \backslash V(A)$. Since $(A, B)$ and $\left(A_{s}, B_{s}\right)$ are independent flaps, we have $A_{s} \subseteq B$. Thus, $X_{s} \subseteq V(B)$, and so $Y=X$. Let $B^{*}$ be obtained from $B$ by replacing $A_{s}$ by an edge whose ends are $X_{s}$, and adding the edge with ends $X$. Since $C^{+}$is 3 -connected, $\left(C^{+} \cap A, C^{+} \cap B^{*}\right)$ is a ( $\geqslant 3$ )-separation of $C^{+}$. It follows that $A \cap C$ meets $B \cap C$ in at least two vertices of $V(C) \backslash X$, and thus exactly two since $|V(A \cap B)| \leqslant 2$. In particular, $V(A \cap B) \subseteq V(C) \backslash X$, and hence $V(A \cap D) \cap V(B \cap D)=\emptyset$. It follows that $A \cap D$ is a half-flap. However, this contradicts the minimality of $\sum_{\left(A^{\prime}, B^{\prime}\right) \in \mathcal{F}_{s}}\left|V\left(A^{\prime}\right)\right|+\left|E\left(A^{\prime}\right)\right|$ since $|V(A \cap D)|<|V(A)|$.

By the previous cases, there are only two cases left to consider for $(A, B)$, namely (1) $V(A \cap C) \subseteq X$ and $A \cap C$ has no edges, or (2) $V(A)=V(C)$ and $\left|X_{s} \cup X\right| \leqslant 2$. Since $(A, B)$ is an arbitrary flap of $\mathcal{F}_{s} \backslash\left\{\left(A_{s}, B_{s}\right)\right\}$, we may assume that either $V\left(A^{\prime} \cap C\right) \subseteq X$ and $A^{\prime} \cap C$ has no edges for all $\left(A^{\prime}, B^{\prime}\right) \in \mathcal{F}_{s} \backslash\left\{\left(A_{s}, B_{s}\right)\right\}$; or that $V(A)=V(C)$ and $\left|X_{s} \cup X\right| \leqslant 2$.

Suppose that $V\left(A^{\prime} \cap C\right) \subseteq X$ and $A^{\prime} \cap C$ has no edges for all $\left(A^{\prime}, B^{\prime}\right) \in \mathcal{F}_{s} \backslash\left\{\left(A_{s}, B_{s}\right)\right\}$. By replacing $\left(A_{s}, B_{s}\right)$ by $\left(A_{s}+x_{s} C, B_{s}-(V(C) \backslash X)\right)$ in $\mathcal{F}_{s}$, we contradict that $A_{s}$ is a full-half-flap.

The last case is that $V(A)=V(C)$ and $\left|X_{s} \cup X\right| \leqslant 2$. Since $X_{s}$ is the set of ends of a fake edge of $C^{-}$, this implies that $X_{s} \neq X$. Thus, we must have $|X|=1$ and $X \subseteq X_{s}$. Let $t$ be the smallest index in $\mathcal{I}$ larger than $s$, and let $f$ be the corresponding fake edge. Note that $t$ exists since $C^{-}$contains a fake edge with neither end in $X$. Let $\mathcal{F}_{t}$ be a collection of $t$ independent flaps of $H_{t}$ such that $\left(A_{t}, B_{t}\right) \in \mathcal{F}_{t}$ and $\sum_{\left(A^{\prime}, B^{\prime}\right) \in \mathcal{F}_{t}}\left|V\left(A^{\prime}\right)\right|+\left|E\left(A^{\prime}\right)\right|$ is minimum. Let $\left(A^{*}, B^{*}\right)$ be an arbitrary flap in $\mathcal{F}_{t} \backslash\left\{\left(A_{t}, B_{t}\right)\right\}$. Let $A_{s}^{*} \subseteq H_{t}$ be obtained from $A_{s}$ by reversing all the flap reductions for all $j \in[s, t]$. The remainder of the proof is essentially the same as the previous cases with $\left(A^{*}, B^{*}\right)$ taking the role of $(A, B)$ and $\left\{X_{s}, X_{t}\right\}$ taking the role of $\left\{X_{s}, X\right\}$. For completeness, we include all the details.

Suppose that $V\left(A^{*}\right)$ is a proper subset of $V(C)$. Since $C$ is 3 -connected, for some $Y \in\left\{X_{s}, X_{t}\right\}, V\left(A^{*}\right) \backslash V\left(B^{*}\right)$ contains one vertex $y$ of $Y$ and $V\left(B^{*}\right) \backslash V\left(A^{*}\right)$ contains the other vertex of $Y$. By Lemma 5.8, $A_{s}^{*}$ and $A_{t}$ are both connected. Since $V\left(A^{*}\right) \subseteq V(C)$, this implies $X_{s} \cup X_{t} \subseteq V\left(B^{*}\right)$. Thus, for either choice of $Y$, we have $y \in V\left(A^{*} \cap B^{*}\right)$, which contradicts that $y \in V\left(A^{*}\right) \backslash V\left(B^{*}\right)$.

Suppose that $V\left(A^{*}\right)=V(C)$. Clearly, $X_{s} \cup X_{t} \subseteq V(C)=V\left(A^{*}\right)$. Since $A_{s}^{*}$ and $A_{t}$ are both connnected by Lemma 5.8, $X_{s} \cup X_{t} \subseteq V\left(B^{*}\right)$. Therefore, $X_{s} \cup X_{t} \subseteq V\left(A^{*} \cap B^{*}\right)$. Since $\left|X_{s} \cup X_{t}\right| \geqslant 3$, this implies that $\left(A^{*}, B^{*}\right)$ is a ( $\geqslant 3$ )-separation of $H_{t}$, which contradicts that $\left(A^{*}, B^{*}\right)$ is a flap.

Suppose that $A^{*} \cap C=S$, where $S$ is a stable set and $S$ contains a vertex $x \notin X_{s}$. If $x \notin X_{t}$, then $x$ is an isolated vertex of $A$. If $x \in X_{t}$, then since $\left(A^{*}, B^{*}\right)$ and $\left(A_{t}, B_{t}\right)$ are independent flaps, $V\left(A^{*} \cap A_{t}\right) \backslash X_{t}=\emptyset$. Thus, $x$ is an isolated vertex of $A^{*}$ in this case as well. But now, replacing $\left(A^{*}, B^{*}\right)$ by $\left(A^{*}-x, B^{*}\right)$ contradicts the minimality of $\sum_{\left(A^{\prime}, B^{\prime}\right) \in \mathcal{F}_{t}}\left|V\left(A^{\prime}\right)\right|+\left|E\left(A^{\prime}\right)\right|$.

Suppose that $A^{*} \cap C$ consists of just a single edge $x y$. Since $C$ is 3 -connected, $\operatorname{deg}_{C}(x) \geqslant$ 3 and $\operatorname{deg}_{C}(y) \geqslant 3$. For $z \in\{x, y\}$, let $d(z)$ be the number of $Y \in\left\{X_{s}, X_{t}\right\} \backslash\{\{x, y\}\}$ such that $z \in Y$. Observe that $\operatorname{deg}_{C}(z) \leqslant \operatorname{deg}_{A^{*} \cap C}(z)+\operatorname{deg}_{B^{*} \cap C}(z)+d(z)$ for both $z \in\{x, y\}$. Since $\operatorname{deg}_{A^{*} \cap C}(z)=1$ for both $z \in\{x, y\}$, this yields $\operatorname{deg}_{B^{*} \cap C}(z) \geqslant$ $2-d(z)$ for both $z \in\{x, y\}$. If $\{x, y\} \subseteq X_{s} \cup X_{t}$, then $d(x) \leqslant 1$ and $d(y) \leqslant 1$. Therefore, $\operatorname{deg}_{B^{*} \cap C}(x) \geqslant 1$ and $\operatorname{deg}_{B^{*} \cap C}(y) \geqslant 1$, which implies $\{x, y\} \subseteq V\left(A^{*} \cap B^{*}\right)$. But now, $\left(A^{*}-x y, B^{*} \cup\{x y\}\right)$ is a $(\leqslant 2)$-separation, which contradicts the minimality of $\sum_{\left(A^{\prime}, B^{\prime}\right) \in \mathcal{F}_{t}}\left|V\left(A^{\prime}\right)\right|+\left|E\left(A^{\prime}\right)\right|$. By symmetry, we may assume $y \notin X_{s} \cup X_{t}$. Thus, $d(y)=0$, which gives $\operatorname{deg}_{B^{*} \cap C}(y) \geqslant 2$. In particular, $y \in V\left(A^{*} \cap B^{*}\right)$. Moreover, since $y \notin X_{s} \cup X_{t}$, we have $y \in V(C) \backslash V(D)$, and thus $\operatorname{deg}_{A^{*}}(y)=\operatorname{deg}_{A^{*} \cap C}(y)=1$. Observe that $\mid V\left(A^{*}-\right.$ $y) \cap V\left(B^{*} \cup\{x y\}\right) \mid \leqslant 2$ because $V\left(A^{*}-y\right) \cap V\left(B^{*} \cup\{x y\}\right) \subseteq\left(V\left(A^{*} \cap B^{*}\right) \backslash\{y\}\right) \cup\{x\}$. Therefore $\left(A^{*}-y, B^{*} \cup\{x y\}\right)$ is a $(\leqslant 2)$-separation. But now $A^{*}-y$ is a half-flap contained in $A^{*}$, which contradicts the minimality of $\sum_{\left(A^{\prime}, B^{\prime}\right) \in \mathcal{F}_{t}}\left|V\left(A^{\prime}\right)\right|+\left|E\left(A^{\prime}\right)\right|$.

Suppose that $V(C)$ is a proper subset of $V\left(A^{*}\right)$. Clearly, $X_{t} \subseteq V\left(A^{*}\right)$. Also, $X_{t} \subseteq$ $V\left(B^{*}\right)$ since $\left(A^{*}, B^{*}\right)$ and $\left(A_{t}, B_{t}\right)$ are independent flaps. Therefore, $V\left(A^{*} \cap B^{*}\right)=X_{t}$, since $\left|X_{t}\right|=2$. Moreover, $A^{*} \cap\left(D \cup A_{s}^{*}\right)$ contains at least one vertex not in $X_{t}$, since $V(C)$ is a proper subset of $V\left(A^{*}\right)$. If $A^{*} \cap\left(D \cup A_{s}^{*}\right)$ meets $B^{*} \cap\left(D \cup A_{s}^{*}\right)$ at a vertex $x \notin X_{s}$, then $x \in V(A \cap B)$, which contradicts that $V(A \cap B)=X_{s}$. Thus, $V\left(A^{*} \cap\left(D \cup A_{s}^{*}\right)\right) \cap V\left(B^{*} \cap\left(D \cup A_{s}^{*}\right)\right) \subseteq X_{s}$. It follows that $A^{*} \cap\left(D \cup A_{s}^{*}\right)$ is a half-flap, since $\left|X_{s}\right| \leqslant 2$. However, this contradicts the minimality of $\sum_{\left(A^{\prime}, B^{\prime}\right) \in \mathcal{F}_{t}}\left|V\left(A^{\prime}\right)\right|+\left|E\left(A^{\prime}\right)\right|$ since $\left|V\left(A^{*} \cap\left(D \cup A_{s}^{*}\right)\right)\right|<|V(A)|$.

Suppose that $3 \leqslant\left|V\left(A^{*} \cap C\right)\right|<|V(C)|$ and $V\left(A^{*}\right) \backslash V(C) \neq \emptyset$. Since $C$ is 3-connected, for some $Y \in\left\{X_{s}, X_{t}\right\}$, one vertex $y$ of $Y$ is in $V\left(A^{*}\right) \backslash V\left(B^{*}\right)$ and the other vertex of $Y$ is in $V\left(B^{*}\right) \backslash V\left(A^{*}\right)$. Since $\left(A^{*}, B^{*}\right)$ and $\left(A_{t}, B_{t}\right)$ are independent flaps, we have $A_{t} \subseteq B^{*}$. Thus, $X_{t} \subseteq V\left(B^{*}\right)$, and so $Y=X_{s}$. Let $\beta$ be obtained from $B^{*}$ by replacing $A_{t}$ by an edge whose ends are $X_{t}$ and adding the edge with ends $X_{s}$. Since $C$ is 3-connected, $\left(C \cap A^{*}, C \cap \beta\right)$ is a ( $\geqslant 3$ )-separation of $C$. It follows that $A \cap C$ meets $B \cap C$ in at least two vertices of $V(C) \backslash X$, and thus exactly two since $|V(A \cap B)| \leqslant 2$.

Thus, $A^{*} \cap C$ meets $B^{*} \cap C$ in at least two vertices of $V(C) \backslash X_{s}$, and thus exactly two since $\left|V\left(A^{*} \cap B^{*}\right)\right| \leqslant 2$. In particular, $V\left(A^{*} \cap B^{*}\right) \subseteq V(C) \backslash X_{s}$, and hence $V\left(A^{*} \cap(D \cup\right.$ $\left.\left.A_{s}^{*}\right)\right) \cap V\left(B^{*} \cap\left(D \cup A_{s}^{*}\right)\right)=\emptyset$. It follows that $A \cap\left(D \cup A_{s}^{*}\right)$ is a half-flap. However, this contradicts the minimality of $\sum_{\left(A^{\prime}, B^{\prime}\right) \in \mathcal{F}_{s}}\left|V\left(A^{\prime}\right)\right|+\left|E\left(A^{\prime}\right)\right|$ since $|V(A \cap D)|<|V(A)|$.

Since $\left(A^{*}, B^{*}\right)$ is an arbitrary flap of $\mathcal{F}_{t} \backslash\left\{\left(A_{t}, B_{t}\right)\right\}$, by the previous cases, we may assume $V\left(A^{\prime} \cap C\right) \subseteq X_{s}$ and $A^{\prime} \cap C$ has no edges for all $\left(A^{\prime}, B^{\prime}\right) \in \mathcal{F}_{t} \backslash\left\{\left(A_{t}, B_{t}\right)\right\}$. Therefore, by replacing $\left(A_{t}, B_{t}\right)$ by $\left(A_{t}+x_{t} C, B_{t}-\left(V(C) \backslash X_{t}\right)\right)$ in $\mathcal{F}_{t}$, we contradict that $A_{t}$ is a full-half-flap.

We will need to pick reduction sequences that satisfy a few additional properties. Let $H_{k}, \ldots, H_{j}$ be a reduction sequence of $H$, with corresponding flaps $\left(A_{\ell}, B_{\ell}\right)$ in $H_{\ell}$. We say that $H_{k}, \ldots, H_{j}$ is a good reduction sequence if for all $\ell \in\{k, \ldots, j\}, H_{\ell}$ is not a cycle, and for all $\ell \in\{k, \ldots, j+1\}$
(1) if $A_{\ell} \cong P_{3}$ and $V\left(A_{\ell}\right) \cap V\left(B_{\ell}\right)=\{x\}$, then $e$ is a true edge of $H_{\ell}$, where $e$ is the unique edge of $A_{\ell}$ not incident to $x$,
(2) if $A_{\ell} \cong C_{3}$ and $V\left(A_{\ell}\right) \cap V\left(B_{\ell}\right)=\{x\}$, then $e$ is a true edge of $H_{\ell}$, where $e$ is the unique edge of $A_{\ell}$ not incident to $x$,
(3) if $A_{\ell} \cong C_{4}$ and $V\left(A_{\ell}\right) \cap V\left(B_{\ell}\right)=\{x, y\}$, then $e$ is a true edge of $H_{\ell}$, where $e$ is the unique edge of $A_{\ell}$ not incident to either $x$ or $y$.

Note that, by Lemma 5.8, if $A_{\ell} \cong P_{3}$ and $V\left(A_{\ell}\right) \cap V\left(B_{\ell}\right)=\{x\}$ then $x$ cannot be the center of the $P_{3}$, hence edge $e$ is well-defined in case (1) above. Similarly, if $A_{\ell} \cong C_{4}$ and $V\left(A_{\ell}\right) \cap V\left(B_{\ell}\right)=\{x, y\}$, then $x$ and $y$ cannot be opposite vertices of the $C_{4}$, and thus $e$ is also well-defined in case (3).

We now give conditions under which a good reduction sequence can be extended to a longer good reduction sequence. Let $H^{\prime}$ be a graph where some edges are fake, and let $u, v \in V\left(H^{\prime}\right)$. A $u$-culdesac of $H^{\prime}$ is a cycle $C$ of $H^{\prime}$ such that $u \in V(C), \operatorname{deg}_{H^{\prime}}(u) \geqslant 3$, and $\operatorname{deg}_{H^{\prime}}(w)=2$ for all $w \in V(C) \backslash\{u\}$. A $u$-alley of $H^{\prime}$ is a path $P$ of $H^{\prime}$ such that $u$ is an end of $P,|V(P)| \geqslant 2, \operatorname{deg}_{H^{\prime}}(u) \geqslant 3$, and $\operatorname{deg}_{P}(w)=\operatorname{deg}_{H^{\prime}}(w)$ for all $w \in V(P) \backslash\{u\}$. A $u v$-path $P$ in $H^{\prime}$ is a $u v$-alley if $|V(P)| \geqslant 3$ and $\operatorname{deg}_{H^{\prime}}(u) \geqslant 3$ and $\operatorname{deg}_{H^{\prime}}(v) \geqslant 3$ and $\operatorname{deg}_{H^{\prime}}(w)=2$ for all $w \in V(P) \backslash\{u, v\}$.

Claim 5.12. Let $C$ be a u-culdesac of $H^{\prime}$ with $|V(C)| \geqslant 4$, and let $e:=u v$ be an edge of $C$ incident to $u$. Let $P$ and $Q$ be the 3- and 4-vertex paths of $C$ containing $e$ and ending at $u$, respectively. If $|V(C)|$ is even, then $P$ is a full-half flap of $H^{\prime}$, and if $|V(C)|$ is odd, then $Q$ is a full-half-flap.

Proof. Let $\mathcal{F}$ be a collection of $f\left(H^{\prime}\right)$ independent flaps in $H^{\prime}$, and let $\mathcal{F}^{\prime}$ be the collection of flaps $\left(F_{1}, F_{1}^{\prime}\right) \in \mathcal{F}$ such that $E\left(F_{1} \cap C\right) \neq \emptyset$. Since $C$ contains a set of $m:=\left\lfloor\frac{|V(C)|}{2}\right\rfloor$ independent half-flaps of $H^{\prime}$, we must have $\left|\mathcal{F}^{\prime}\right| \geqslant m$; otherwise, $|\mathcal{F}|$ is not maximum. If $\mathcal{F}^{\prime}$ contains a flap $\left(F_{1}, F_{1}^{\prime}\right)$ such that $F_{1} \cap C=u v$, then we replace $\left(F_{1}, F_{1}^{\prime}\right)$ by $\left(F_{1}-v, F_{1}^{\prime} \cup\{u v\}\right)$. Similarly, we may assume that $\mathcal{F}^{\prime}$ does not contain a flap ( $F_{1}, F_{1}^{\prime}$ ) such that $F_{1} \cap C=t u$, where $t$ is the other neighbour of $u$ in $C$. In particular, $\left|E\left(F_{1} \cap C\right)\right| \geqslant 2$ for all $\left(F_{1}, F_{1}^{\prime}\right) \in \mathcal{F}^{\prime}$. This implies that $\left|\mathcal{F}^{\prime}\right| \leqslant m$, and hence $\left|\mathcal{F}^{\prime}\right|=m$. Observe that $C$ contains a set $\mathcal{H}$ of $m$ independent half-flaps with $P \in \mathcal{H}$ if $|V(C)|$ is even, and $Q \in \mathcal{H}$ if $|V(C)|$ is odd. It follows that $P$ can be extended to a full-half-flap $P^{\prime}$ if $|V(C)|$ is even, and $Q$ can be extended to a full-half-flap $Q^{\prime}$ if $|V(C)|$ is odd. Since every collection of $f\left(H^{\prime}\right)$ independent flaps of $H^{\prime}$ must contain at least $m$ flaps that use an edge of $C$, and $\bigcup_{F \in \mathcal{H}} F=C$, it follows that $C \cap P^{\prime}=P$. If $P^{\prime}$ is not contained in $C$, then $P^{\prime}$ contains two independent half-flaps, which is a contradiction. Thus, $P^{\prime}=P$. The same argument gives $Q^{\prime}=Q$.

The same proof also establishes the following claim for $u v$-alleys.
Claim 5.13. Let $P$ be a $u v$-alley of $H^{\prime}$ with $|V(P)| \geqslant 5$. If $|V(P)|$ is even, let $P^{\prime}$ be the 4-vertex subpath of $P$ ending at $u$. If $|V(P)|$ is odd, let $P^{\prime}$ be 3-vertex subpath of $P$ ending at $u$. Then $P^{\prime}$ is a full-half-flap of $H^{\prime}$.

An edge $e$ is at distance 2 from a vertex $u$ if $e$ is not incident to $u$ and $e$ is incident to an edge that is incident to $u$. A $u$-culdesac $C$ is tame if $C$ has a true edge at distance 2 from $u$. A $u v$-alley $P$ is tame if $P$ has a true edge at distance 2 from $u$ or $v$. A $u$-alley $P$ is tame if $P$ has a true edge at distance 2 from $u$. Finally, we say that $H^{\prime}$ is tame if for all $u, v \in V\left(H^{\prime}\right)$ all $u$-culdesacs, $u$-alleys, and $u v$-alleys of $H^{\prime}$ are tame.

Claim 5.14. Let $H_{k}, \ldots, H_{j}$ be a good reduction sequence such that $j \geqslant 3$ and $H_{j}$ is tame. Then $H_{k}, \ldots, H_{j}$ can be extended to a good reduction sequence $H_{k}, \ldots, H_{j-1}$ such that $H_{j-1}$ is tame.

Proof. Suppose that $H_{j}$ contains a $u$-culdesac $C$ with $|V(C)| \geqslant 4$. Since $H_{j}$ is tame, $C$ contains a true edge $e$ at distance 2 from $u$. If $|V(C)|$ is even (respectively, odd), let $P$ be the 3-vertex (respectively, 4-vertex) path of $C$ such that one end of $P$ is $u$ and $e \notin E(P)$. By Claim 5.12, $P$ is a full-half-flap of $H_{j}$. Letting $H_{j-1}$ be obtained from $H_{j}$ by applying Lemma 5.8 with $A=P$, we have that $H_{\ell}, \ldots, H_{j-1}$ is a good reduction sequence and $H_{j-1}$ is tame. Thus, we may assume that all culdesacs of $H_{j}$ are triangles. By Claim 5.13, we may also assume that for all $u, v \in V\left(H_{j}\right)$, all $u v$-alleys of $H_{j}$ have at most four vertices.

Let $\left(A_{j}, B_{j}\right)$ be a flap of $H_{j}$ such that $A_{j}$ is a full-half-flap and let $H_{j-1}=B_{j}^{+}$. Suppose $H_{j-1}$ is a cycle. If $\left(A_{j}, B_{j}\right)$ is a 1-separation, then $H_{j-1} \cong C_{3}$, since all culdesacs of $H_{j}$ are triangles. Since $f\left(C_{3}\right)=1$, this contradicts $j \geqslant 3$. If $\left(A_{j}, B_{j}\right)$ is a 2-separation, then $H_{j-1} \in\left\{C_{3}, C_{4}\right\}$ since all alleys of $H_{j}$ have at most four vertices. In either case, $f\left(H_{j}\right)=2$, which contradicts $j \geqslant 3$. Thus $H_{j-1}$ is not a cycle.

Since $H_{j}$ is tame, it follows that $H_{k}, \ldots, H_{j-1}$ is a good reduction sequence. It only remains to show that $H_{j-1}$ is tame. Towards a contradiction, suppose $H_{j-1}$ contains a $u$-culdesac $C$ that is not tame. The cases in which $H_{j-1}$ contains a $u$-alley that is not tame, or a $u v$-alley that is not tame are similar and are omitted. We assume that $\left(A_{j}, B_{j}\right)$ is a 2-separation (the case that $\left(A_{j}, B_{j}\right)$ is a 1-separation is easier and is omitted). Since $H_{j}$ is tame, there must be an edge $x y \in E(C)$ such that $V\left(A_{j}\right) \cap V\left(B_{j}\right)=\{x, y\}$. Let $P_{x u}$ and $P_{y u}$ be the $x-u$ and $y-u$ paths in $C$ such that $V\left(P_{x u}\right) \cap V\left(P_{y u}\right)=\{u\}$. Since all alleys of $H_{j}$ have at most four vertices, $\left|V\left(P_{x u}\right)\right|,\left|V\left(P_{y u}\right)\right| \leqslant 4$. Moreover, if $\left|V\left(P_{x u}\right)\right| \in\{2,4\}$, then adding the edge of $P_{x u}$ incident to $x$ to $A_{j}$ contradicts that $A_{j}$ is a full-half-flap. Thus, $\left|V\left(P_{x u}\right)\right|,\left|V\left(P_{y u}\right)\right| \in\{1,3\}$. In particular, this implies that $C$ is not a triangle. For each fake edge $e \in E(C)$ let $\ell(e)$ be the smallest index such that $V\left(A_{\ell(e)}\right) \cap V\left(B_{\ell(e)}\right)$ is equal to the set of ends of $e$. Among all fake edges of $C \backslash\{x y\}$ in $H_{j-1}$, let $f$ be such that $\ell(f)$ is smallest. Since $C$ is not a triangle, there are two edges of $C$ at distance 2 from $u$ (both of which are fake). Therefore, $f$ exists. Let $g$ be the unique edge of $C$ such that $f \cup g$ is $P_{x u}$ or $P_{y u}$. Then adding $g$ to $A_{\ell(f)}$ contradicts that $A_{\ell(f)}$ is a full-half flap.

In the case that $H$ is non-planar, we do not need $j \geqslant 3$ in the statement of Claim 5.14.
Claim 5.15. Let $H_{k}, \ldots, H_{j}$ be a good reduction sequence of a non-planar graph such that $j \geqslant 1$ and $H_{j}$ is tame. Then $H_{k}, \ldots, H_{j}$ can be extended to a good reduction sequence $H_{k}, \ldots, H_{j-1}$ such that $H_{j-1}$ is tame.

Proof. The proof is identical to the proof of Claim 5.14, except for the second paragraph. Instead of using the assumption $j \geqslant 3$, we directly observe that $H_{j-1}$ cannot be a cycle because $H_{j-1}$ is non-planar. Note that if $j=1$, then $H_{1}$ contains a flap since it is non-planar. Therefore, $H_{0}$ exists.

The final ingredient we need is the existence of a certain collection of paths in $H$. Let $H_{k}, \ldots, H_{j}$ be a reduction sequence of $H$ with corresponding flaps $\left(A_{\ell}, B_{\ell}\right)$ in $H_{\ell}$, and for each $\ell \in\{k, \ldots, j\}$ let $F_{\ell}$ be the set of fake edges of $H_{\ell}$. For each fake edge $e$ we define a set of indices $\mathcal{I}(e)$ recursively as follows. Let $\ell$ be the largest index such that $e$ is a fake edge of $H_{\ell}$ and recursively define $\mathcal{I}(e)=\{\ell+1\} \cup \bigcup_{f \in F_{\ell+1} \cap E\left(A_{\ell+1}\right)} \mathcal{I}(f)$.

Claim 5.16. Let $H_{k}, \ldots, H_{j}$ be a reduction sequence of $H$ with corresponding flaps ( $A_{\ell}, B_{\ell}$ ) in $H_{\ell}$, and for each $\ell \in\{k, \ldots, j\}$ let $F_{\ell}$ be the set of fake edges of $H_{\ell}$. Then for all $\ell \in\{k, \ldots, j\}$, there is a collection of paths $\mathcal{P}_{\ell}=\left\{P_{f} \mid f \in F_{\ell}\right\}$ in $H$ such that for all $f \in F_{\ell}, P_{f}$ has the same ends as $f$, and $P_{f} \subseteq \bigcup_{i \in \mathcal{I}(f)} A_{i}$. Moreover, letting $H_{\ell}^{\prime}:=\left(H_{\ell} \backslash F_{\ell}\right) \cup \mathcal{P}_{\ell}$, we have that $\left(H_{\ell}^{\prime}, \mathcal{P}_{\ell}\right)$ is a partially subdivided graph, $H_{\ell}^{\prime}$ is a subgraph of $H$, and $H_{\ell}^{\prime} / \mathcal{P}_{\ell}$ is isomorphic to $H_{\ell}$.

Proof. We proceed by reverse induction. Since $H_{k}=H$ does not contain any fake edges, we may take $\mathcal{P}_{k}:=\emptyset$. Suppose the claim is true for some $\ell>j$, and consider $\ell-1$. If $\left|V\left(A_{\ell}\right) \cap V\left(B_{\ell}\right)\right|=2$ then let $\{a, b\}:=V\left(A_{\ell}\right) \cap V\left(B_{\ell}\right)$. We are done by induction if $\left|V\left(A_{\ell}\right) \cap V\left(B_{\ell}\right)\right| \leqslant 1$ or $e:=a b$ is a true edge of $H_{\ell-1}$. Thus, we may assume that $e$ is a fake edge of $H_{\ell-1}$. By the final part of Lemma 5.8, there is path $P_{e}^{\prime}$ in $A_{\ell}$ between a and b. By induction, for each fake edge $f$ in $P_{e}^{\prime}$, there is a path $P_{f}^{\prime} \subseteq \bigcup_{i \in \mathcal{I}(f)} A_{i}$. Moreover, note that if $f_{1}$ and $f_{2}$ are distinct fake edges of $H_{\ell-1}$, then $\mathcal{I}\left(f_{1}\right) \cap \mathcal{I}\left(f_{2}\right)=\emptyset$. Therefore, replacing each fake edge $f$ of $P_{e}^{\prime}$ with $P_{f}^{\prime}$, we obtain a path $P_{e}$ contained in $\bigcup_{i \in \mathcal{I}(e)} A_{i}$. Every other fake edge $e^{\prime}$ of $H_{\ell-1}$ is a fake edge of $H_{\ell^{\prime}}$ for some $\ell^{\prime}>\ell$. By induction, for each such fake edge $e^{\prime}$, there is a path $P_{e^{\prime}}$ contained in $\bigcup_{i \in \mathcal{I}\left(e^{\prime}\right)} A_{i}$. Note that $P_{f_{1}}$ and $P_{f_{2}}$ are internally-disjoint for all distinct $f_{1}, f_{2} \in F_{\ell-1}$, since $\mathcal{I}\left(f_{1}\right) \cap \mathcal{I}\left(f_{2}\right)=\emptyset$ Thus, $\mathcal{P}_{\ell-1}:=\left\{P_{f} \mid f \in F_{\ell-1}\right\}$ is the required set of paths.

We now prove the theorem in the case that $H$ is non-planar.
Claim 5.17. Suppose $H$ is an h-vertex, non-planar graph and $H_{k}, \ldots, H_{0}$ is a good reduction sequence of $H$ such that $H_{\ell}$ is tame for all $\ell \in\{k, \ldots, 0\}$. For each $\ell \in$ $\{0, \ldots, k\}$, let $F_{\ell}$ be the set of fake edges of $H_{\ell}$. Then for every $n$-vertex graph $G$ embeddable in a surface of Euler genus $g$, and for all $\ell \in\{0, \ldots, k\}$, there are at most $c_{4.1}(h, g) c_{5.1}(h, g+2)^{\ell} \cdot n^{\ell}$ images of $H_{\ell} \backslash F_{\ell}$ in $G$ that extend to an image of $H$ in $G$.

Before proceeding with the proof, we quickly show that Claim 5.17 does indeed imply Theorem 5.9 when $H$ is non-planar. First note that $H_{k}, \ldots, H_{0}$ exist by Claim 5.15. Next, applying Claim 5.17 for $\ell=k$, we get that there are at most $c_{4.1}(h, g) c_{5.1}(h, g+2)^{k} \cdot n^{k} \leqslant$ $c_{5.9}(h, g) n^{k}$ images of $H$ in $G$.

Proof. We proceed by induction on $\ell$. When $\ell=0$, there are at most $c_{4.1}(h, g)$ images of $H_{0} \backslash F_{0}$ in $G$ that extend to an image of $H$ in $G$, by Theorem 4.1. For the inductive step, suppose there are at most $c_{4.1}(h, g) c_{5.1}(h, g+2)^{\ell} \cdot n^{\ell}$ images of $H_{\ell} \backslash F_{\ell}$ in $G$ that extend to an image of $H$ in $G$, and consider $\ell+1$.

Let $\phi: V\left(H_{\ell} \backslash F_{\ell}\right) \rightarrow V(G)$ be a fixed copy of $H_{\ell} \backslash F_{\ell}$ in $G$ that extends to an image $\psi: V(H) \rightarrow V(G)$ of $H$ in $G$. For every subgraph $S$ of $H$, let $S^{\psi}$ be the subgraph of $G$ obtained by restricting $\psi$ to $S$. Let $\left(A_{\ell+1}, B_{\ell+1}\right)$ be the flap in $H_{\ell+1}$ such that $H_{\ell}=B_{\ell+1}^{+}$, and let $F_{A_{\ell+1}}$ be the set of fake edges of $H_{\ell+1}$ contained in $E\left(A_{\ell+1}\right)$. By Claim 5.16, there is a collection of paths $\mathcal{P}^{\psi}:=\left\{P_{f}^{\psi} \mid f \in F_{A_{\ell+1}}\right\}$ in $H^{\psi}$ such that for all $f \in F_{A_{\ell+1}}, P_{f}^{\psi}$ has the same ends as $f^{\psi}$ and $\left(\left(A_{\ell+1} \backslash F_{A_{\ell+1}}\right)^{\psi} \cup \mathcal{P}^{\psi}, \mathcal{P}^{\psi}\right)$ is a partially subdivided subgraph of $H^{\psi}$.

Let $G_{\ell+1}$ be the minor of $G$ obtained by contracting all but one edge from each path in $\mathcal{P}^{\psi}$. Since $\left(\left(A_{\ell+1} \backslash F_{A_{\ell+1}}\right)^{\psi} \cup \mathcal{P}^{\psi}\right) / \mathcal{P}^{\psi}$ is isomorphic to $A_{\ell+1},\left(A_{\ell+1} \backslash F_{A_{\ell+1}}\right)^{\psi} \cup \mathcal{P}^{\psi}$ becomes an image of $A_{\ell+1}$ in $G_{\ell+1}$.

Let $X:=V\left(A_{\ell+1}\right) \cap V\left(B_{\ell+1}\right)$ and $Y:=\phi(X)$. If $X:=\{a, b\}$ and $a b$ is a fake edge of $H_{\ell+1}$, then add a handle to $\Sigma$ and use the handle to draw an edge between the vertices in $Y$ to obtain a graph $G_{\ell+1}^{\prime} \supset G_{\ell+1}$ embedded in a surface of Euler genus $g+2$. Otherwise, let $G_{\ell+1}^{\prime}:=G_{\ell+1}$.

Note that by Claim 5.10, Claim 5.11, goodness of the reduction sequence, and tameness of $H_{\ell+1}$, the conditions of Lemma 5.1 are satisfied, with $J=A_{\ell+1}^{+}$. Therefore, by Lemma 5.1, there are at most $c_{5.1}\left(\left|V\left(A_{\ell+1}^{+}\right)\right|, g+2\right) n$ images of $A_{\ell+1}^{+}$with $X$ rooted at $Y$ in $G_{\ell+1}^{\prime}$. Hence, there are at most $c_{5.1}\left(\left|V\left(A_{1}^{+}\right)\right|, g+2\right) n$ images of $H_{\ell+1} \backslash F_{\ell+1}$ in $G$ that extend $\phi$ and also extend to an image of $H$ in $G$. By induction, there are at most $c_{4.1}(h, g) c_{5.1}(h, g+2)^{\ell} \cdot n^{\ell}$ possibilities for $\phi$, so there are at most

$$
c_{5.1}\left(\left|V\left(A_{1}^{+}\right)\right|, g+2\right) \cdot c_{4.1}(h, g) c_{5.1}(h, g+2)^{\ell} \cdot n^{\ell+1} \leqslant c_{4.1}(h, g) c_{5.1}(h, g+2)^{\ell+1} \cdot n^{\ell+1}
$$

images of $H_{\ell+1} \backslash F_{\ell+1}$ in $G$ that extend to an image of $H$ in $G$.

The case when $H$ is planar is similar, except that we must handle the case when $H$ is a cycle separately, which we do now. We make a case distinction depending if the cycle has even or odd length.

Suppose $H \cong C_{2 k}$. Note that $f\left(C_{2 k}\right)=k$. Let $M$ be a perfect matching of $C_{2 k}$. For each copy $\phi$ of $C_{2 k}$ in $G$, let $\phi(M)$ be the subset of $E(G)$ that $\phi$ maps $M$ to. Since there are at most $\binom{|E(G)|}{k}$ choices for $\phi(M)$, and each such choice corresponds to at most $2^{k}$ images of $C_{2 k}$ in $G$, there are at most $2^{k}\binom{|E(G)|}{k} \leqslant c_{5.9}(2 k, g) n^{k}$ images of $C_{2 k}$ in $G$.

Suppose $H \cong C_{2 k+1}$. Note that $f\left(C_{2 k+1}\right)=k$. We prove by induction on $n=|V(G)|$ that there are at most $6^{k}(\underset{2}{6(g+1)})(g+1)^{k} \cdot n^{k}$ images of $C_{2 k+1}$ in $G$. For each vertex $a$ of $C_{2 k+1}$ let $N_{C_{2 k+1}}(a)$ be the two neighbours of $a$, and let $M_{a}$ be the unique perfect matching of $C_{2 k+1}-\left(N_{C_{2 k+1}}(a) \cup\{a\}\right)$. Since $G$ is embedded in a surface of Euler genus $g, G$ has a vertex $x$ of degree at most $6(g+1)$. For each copy $\phi$ of $C_{2 k+1}$ in $G$ containing $x$, there are at most $\binom{|E(G-x)|}{k-1}$ choices for $\phi\left(M_{x}\right)$. Since $x$ has degree at most $6(g+1)$ in $G$, there are at most $\binom{6(g+1)}{2}$ choices for $N_{C_{2 k+1}}(x)$. Each choice of $M_{x}$ and $N_{C_{2 k+1}}(x)$ yields at most $2^{k}$ images of $C_{2 k+1}$, so there are at most $2^{k}\binom{6(g+1)}{2}\binom{3(g+1)(n-1)}{k-1}$ images of $C_{2 k+1}$ in $G$ containing $x$. By induction there are at most $6^{k}(\underset{2}{6(g+1)})(g+1)^{k} \cdot(n-1)^{k}$
images of $C_{2 k+1}$ in $G-x$. Summing these two bounds, we conclude that there are at most $6^{k}\binom{6(g+1)}{2}(g+1)^{k} \cdot n^{k}$ images of $C_{2 k+1}$ in $G$. Note that $6^{k}\binom{6(g+1)}{2}(g+1)^{k} \leqslant c_{5.9}(2 k+1, g)$.

If $H$ is planar and $f(H)=1$, then there are at most $c_{3.2}(h, g) n \leqslant c_{5.9}(h, g) n$ images of $H$ in $G$. Therefore, the last remaining case is when $H$ is planar, $f(H) \geqslant 2$, and $H$ is not a cycle. This is handled by the following claim.

Claim 5.18. Suppose $H$ is an h-vertex planar graph, $f(H) \geqslant 2$, and $H$ is not a cycle. Let $H_{k}, \ldots, H_{2}$ be a good reduction sequence of $H$ such that $H_{\ell}$ is tame for all $\ell \in$ $\{k, \ldots, 2\}$ Let $H_{1}:=u v$, where $u v$ is a true edge of $H_{2}$ such that there do not exist independent flaps $(C, D)$ and $\left(C^{\prime}, D^{\prime}\right)$ of $H_{2}$ such that $\{u, v\} \subseteq V\left(D \cap D^{\prime}\right)$. For all $\ell \in\{1, \ldots, k\}$, let $F_{\ell}$ be the set of fake edges of $H_{\ell}$. Then for every $n$-vertex graph $G$ embeddable in a surface of Euler genus $g$, and each $\ell \in\{1, \ldots, k\}$, there exist at most $6(g+1) c_{5.1}(h, g+2)^{\ell-1} \cdot n^{\ell}$ images of $H_{\ell} \backslash F_{\ell}$ in $G$ that extend to an image of $H$ in $G$.

Before proceeding with the proof we note that $H_{k}, \ldots, H_{2}$ exist by Claim 5.14. The true edge $u v$ exists, by considering a leaf node of the SPQRK tree of $\mathrm{H}_{2}$ and using Claim 5.11 and the tameness of $H_{2}$. Again, Theorem 5.9 follows by taking $\ell=k$.

Proof. We proceed by induction on $\ell$. For $\ell=1, H_{1}=u v$ is a true edge. Therefore, there are at most $6(g+1) n$ images of $H_{1}$ in $G$. For $\ell=2$, we apply Lemma 5.1, with $J^{\prime}=\left(H_{2} \backslash F_{2}\right) \cup \mathcal{P}_{2}, \mathcal{P}=\mathcal{P}_{2}, J=H_{2}$, and $X=\{u, v\}$, where $\mathcal{P}_{2}$ is defined in Claim 5.16. Note that conditions (1) and (2) of Lemma 5.1 hold since $u v$ is a true edge and there do not exist independent flaps ( $C, D$ ) and ( $C^{\prime}, D^{\prime}$ ) of $H_{2}$ such that $\{u, v\} \subseteq V\left(D \cap D^{\prime}\right)$. Conditions (3)-(6) hold vacuously. Conditions (7), (9), and (10) hold by goodness of the reduction sequence. Condition (8) holds since $H_{2}$ is tame. Finally, (11) holds by Claim 5.11. Therefore, each of the at most $6(g+1) n$ images of $H_{1}$ in $G$ extends to an image of $J^{\prime}$ in at most $c_{5.1}(h, g) n$ ways. Therefore, there are at most $6(g+1) c_{5.1}(h, g) n^{2} \leqslant 6(g+1) c_{5.1}(h, g+2) \cdot n^{2}$ images of $H_{2} \backslash F_{2}$ that extend to an image of $H$ in $G$. For $\ell \geqslant 3$, the inductive step is exactly as in the nonplanar case. Therefore, we conclude that for each $\ell \in\{1, \ldots, k\}$ there are at most $6(g+1) c_{5.1}(h, g+2)^{\ell-1} \cdot n^{\ell}$ images of $H_{\ell} \backslash F_{\ell}$ in $G$ that extend to an image of $H$ in $G$.

This completes the proof of Theorem 5.9.

## 6. Copies of Complete Graphs

This section studies the maximum number of copies of a given complete graph $K_{s}$ in an $n$-vertex graph that embeds in a given surface $\Sigma$. The flap-number of $K_{s}$ equals 1 if $s \leqslant 4$ and equals 0 if $s \geqslant 5$. Thus Theorem 1.2 implies that $C\left(n, K_{s}, \Sigma\right)=\Theta(n)$ for $s \leqslant 4$ and $C\left(n, K_{s}, \Sigma\right)=\Theta(1)$ for $s \geqslant 5$. The bounds obtained in this section are much more precise than those given by Theorem 1.2. Our method follows that of Dujmović, Fijavž, Joret, Sulanke, and Wood [17], who characterised the $n$-vertex graphs
that embed in a given surface $\Sigma$ and with the maximum number of complete subgraphs (in total), and then derived an upper bound on this maximum.

A triangulation of a surface $\Sigma$ is an embedding of a graph in $\Sigma$ in which each facial walk has three vertices and three edges with no repetitions. Let $G$ be a triangulation of $\Sigma$. An edge $v w$ of $G$ is reducible if $v w$ is in exactly two triangles in $G$. And $G$ is irreducible if no edge of $G$ is reducible $[8,9,15,41-43,54,63-65]$. Barnette and Edelson [8, 9] proved that each surface has a finite number of irreducible triangulations. For $\mathbb{S}_{h}$ with $h \leqslant 2$ and $\mathbb{N}_{c}$ with $c \leqslant 4$ the list of all irreducible triangulations is known [42, 43, 63, 65]. In general, the best known upper bound on the number of vertices in an irreducible triangulation of a surface with Euler genus $g \geqslant 1$ is $13 g-4$, due to Joret and Wood [41].

Let $v w$ be a reducible edge of a triangulation $G$ of $\sum$. Let $v w x$ and $v w y$ be the two faces incident to $v w$ in $G$. As illustrated in Figure 3, let $G / v w$ be the graph obtained from $G$ by contracting $v w$; that is, delete the edges $v w, w y, w x$, and identify $v$ and $w$ into $v . G / v w$ is a simple graph since $x$ and $y$ are the only common neighbours of $v$ and $w$. Indeed, $G / v w$ is a triangulation of $\Sigma$. Conversely, we say that $G$ is obtained from $G / v w$ by splitting the path $x v y$ at $v$. If, in addition, $x y \in E(G)$, then we say that $G$ is obtained from $G / v w$ by splitting the triangle $x v y$ at $v$. Note that $x v y$ need not be a face of $G / v w$. In the case that $x v y$ is a face, splitting $x v y$ is equivalent to adding a new vertex adjacent to each of $x, v, y$.

6.1. Copies of Triangles. In this section we consider $C\left(K_{3}, \Sigma, n\right)$, and define the excess of a graph $G$ to be $C\left(K_{3}, G\right)-3|V(G)|$.

Lemma 6.1. For each surface $\Sigma$, every graph embeddable in $\Sigma$ with maximum excess is a triangulation of $\Sigma$.

Proof. Let $G$ be a graph embedded in $\Sigma$ that maximises the excess. We claim that $G$ is a triangulation. Suppose on the contrary that $F$ is a non-triangular facial walk in $G$.

Suppose that two vertices in $F$ are not adjacent. Then there are vertices $v$ and $w$ at distance 2 in the subgraph induced by $F$. Thus adding the edge $v w$ 'across' the face increases the number of triangles and the excess. This contradicts the choice of $G$. Now assume that $F$ induces a clique.

Suppose that $F$ has at least four distinct vertices. Let $G^{\prime}$ be the embedded graph obtained from $G$ by adding one new vertex 'inside' the face adjacent to four distinct vertices of $F$. Thus $G^{\prime}$ is embeddable in $\Sigma$, has $|V(G)|+1$ vertices, has at least $C\left(K_{3}, G\right)+\binom{4}{2}=C\left(K_{3}, G\right)+6$ triangles, and thus has excess at least the excess of $G$ plus 3. This contradicts the choice of $G$. Now assume that $F$ has at most three distinct vertices.

By Lemma 6.2 below, $F=(u, v, w, u, v, w)$. Let $G^{\prime}$ be the graph obtained from $G$ by adding two new adjacent vertices $p$ and $q$, where $p$ is adjacent to the first $u, v, w$ sequence in $F$, and $q$ is adjacent to the second $u, v, w$ sequence in $F$. So $G^{\prime}$ is embeddable in $\Sigma$ and has $|V(G)|+2$ vertices. If $S$ is a non-empty subset of $\{p, q\}$ and $T \subseteq\{u, v, w\}$ with $|S|+|T|=3$, then $S \cup T$ is a triangle of $G^{\prime}$ but not of $G$. There are $\binom{2}{1}\binom{3}{2}+\binom{2}{2}\binom{3}{1}=6+3=9$ such triangles. Thus $C\left(K_{3}, G^{\prime}\right) \geqslant C\left(K_{3}, G\right)+9$ and the excess of $G^{\prime}$ is at least the excess of $G$ plus 3 , which contradicts the choice of $G$. Hence no face of $G$ has repeated vertices, and $G$ is a triangulation of $\Sigma$.

Lemma 6.2. Let $F$ be a facial walk in an embedded graph, such that $F$ has exactly three distinct vertices that are pairwise adjacent. Then $F=(u, v, w)$ or $F=(u, v, w, u, v, w)$.

Proof. Say $u, v, w$ are three consecutive vertices in $F$. Then $u \neq v$ and $v \neq w$ (since there are no loops). And $u \neq w$, since if $u=w$ then $\operatorname{deg}(v)=1$ (since there are no parallel edges), which is not possible since $v$ is adjacent to the two other vertices in $F$. So any three consecutive vertices in $F$ are pairwise distinct. If $F$ has no repeated vertex, then $F$ is the 3 -cycle $(u, v, w)$. Otherwise, $F=(u, v, w, u, \ldots)$. Again, since any three consecutive vertices in $F$ are pairwise distinct, $F=(u, v, w, u, \ldots)$. Repeating this argument, $F=(u, v, w, u, v, w, \ldots)$. Each edge is traversed at most twice; see [53, Sections 3.2 and 3.3]. Thus $F=(u, v, w, u, v, w)$.

Theorem 6.3. Let $\phi$ be the maximum excess of an irreducible triangulation of $\Sigma$. Let $X$ be the set of irreducible triangulations of $\Sigma$ with excess $\phi$. Then the excess of every graph $G$ embeddable in $\Sigma$ is at most $\phi$. Moreover, the excess of $G$ equals $\phi$ if and only if $G$ is obtained from some graph in $X$ by repeatedly splitting triangles.

Proof. We proceed by induction on $|V(G)|$. By Lemma 6.1, we may assume that $G$ is a triangulation of $\Sigma$. If $G$ is irreducible, then the claim follows from the definition of $X$ and $\phi$. Otherwise, some edge $v w$ of $G$ is in exactly two triangles $v w x$ and $v w y$. By induction, the excess of $G / v w$ is at most $\phi$. Moreover, the excess of $G / v w$ equals $\phi$ if and only if $G$ is obtained from some graph $H \in X$ by repeatedly splitting triangles.

Observe that every triangle of $G$ that is not in $G / v w$ is in $\{A \cup\{w\}: A \subseteq\{x, v, y\},|A|=$ $2\}$. Thus $C\left(K_{3}, G\right) \leqslant C\left(K_{3}, G / v w\right)+3$. Moreover, equality holds if and only if $x v y$ is a triangle. It follows from the definition of excess that the excess of $G$ is at most $\phi$. If the excess of $G$ equals $\phi$, then the excess of $G / v w$ equals $\phi$, and $x v y$ is a triangle and $G$ is obtained from $H$ by repeatedly splitting triangles.

Conversely, if $G$ is obtained from some $H \in X$ by repeatedly splitting triangles, then $x v y$ is a triangle and $G / v w$ is obtained from $H$ by repeatedly splitting triangles. By induction, the excess of $G / v w$ equals $\phi$, implying the excess of $G$ equals $\phi$.

In general, since every irreducible triangulation of a surface $\Sigma$ with Euler genus $g$ has $O(g)$ vertices [41, 54], Theorem 6.3 implies that $C\left(K_{3}, \Sigma, n\right) \leqslant 3 n+O\left(g^{3}\right)$. We now show that $C\left(K_{3}, \Sigma, n\right)=3 n+\Theta\left(g^{3 / 2}\right)$.

The following elementary fact will be useful. For integers $s \geqslant 2$ and $m \geqslant 2$,

$$
\begin{equation*}
\sum_{i \geqslant m} \frac{1}{j^{s}} \leqslant \int_{m-1}^{\infty} i^{-s} d i=\frac{1}{(s-1)(m-1)^{s-1}} \tag{1}
\end{equation*}
$$

Theorem 6.4. For every surface $\Sigma$ of Euler genus $g$,

$$
3 n+(\sqrt{6}-o(1)) g^{3 / 2} \leqslant C\left(K_{3}, \Sigma, n\right) \leqslant 3 n+\frac{21}{2} g^{3 / 2}+O(g \log g)
$$

where the lower bound holds for all $n \geqslant \sqrt{6 g}$ and the upper bound holds for all $n$.

Proof. First we prove the lower bound. Because of the $o(1)$ term we may assume that $g \geqslant 4$. Let $p:=\left\lfloor\frac{1}{2}(7+\sqrt{24 g+1})\right\rfloor$. Note that $p \geqslant 8$ and $p-\frac{5}{2}>\sqrt{6 g}$. The Map Colour Theorem [62] says that $K_{p}$ embeds in $\Sigma$. To obtain a graph with $n$ vertices embedded in $\Sigma$ repeat the following step $n-p$ times: choose a face $f$ and add a new vertex 'inside' $f$ adjacent to all the vertices on the boundary of $f$. Each new vertex creates at least three new triangles. Thus $C\left(K_{3}, \Sigma, n\right) \geqslant 3(n-p)+\binom{p}{3}$ for $n \geqslant p$. Since $p \geqslant 8$ we have $\binom{p}{3}-3 p \geqslant \frac{1}{6}\left(p-\frac{5}{2}\right)^{3} \geqslant \sqrt{6} g^{3 / 2}$. Thus $C\left(K_{3}, \Sigma, n\right) \geqslant 3 n+\sqrt{6} g^{3 / 2}$.

To prove the upper bound, by Theorem 6.3, it suffices to consider an $n$-vertex irreducible triangulation $G$ of $\Sigma$. So $n \leqslant 13 g$ [41]. Let $v_{1}, \ldots, v_{n}$ be a vertex ordering of $G$, where $v_{i}$ has minimum degree in $G_{i}:=G\left[\left\{v_{1}, \ldots, v_{i}\right\}\right]$. By Euler's formula, $i \cdot \operatorname{deg}_{G_{i}}\left(v_{i}\right) \leqslant$ $2\left|E\left(G_{i}\right)\right| \leqslant 6(i+g)$, implying

$$
\operatorname{deg}_{G_{i}}\left(v_{i}\right) \leqslant \sigma\left(1+\frac{g}{i}\right) .
$$

Let $m:=\lceil 3 \sqrt{g}\rceil$. The number of triangles $v_{a} v_{b} v_{i}$ with $a<b<i \leqslant m$ is at most $\binom{m}{3} \leqslant\binom{ 3 \sqrt{g}+1}{3} \leqslant \frac{9}{2} g^{3 / 2}$. Charge each triangle $v_{a} v_{b} v_{i}$ with $a<b<i$ and $i \geqslant m+1$ to vertex $v_{i}$. For $m+1 \leqslant i \leqslant n$, the number of triangles charged to $v_{i}$ is at most

$$
\binom{\operatorname{deg}_{G_{i}}\left(v_{i}\right)}{2}<18\left(1+\frac{g}{i}\right)^{2}=18\left(1+\frac{2 g}{i}+\frac{g^{2}}{i^{2}}\right) .
$$

Thus

$$
\begin{aligned}
C\left(K_{3}, G\right) & \leqslant \frac{9}{2} g^{3 / 2}+18 \sum_{i=m+1}^{n}\left(1+\frac{2 g}{i}+\frac{g^{2}}{i^{2}}\right) \\
& \leqslant \frac{9}{2} g^{3 / 2}+18 n+36 g(\ln (n)+1)+18 g^{2} \sum_{i \geqslant m+1} \frac{1}{i^{2}} .
\end{aligned}
$$

By (1) with $s=2$,

$$
C\left(K_{3}, G\right) \leqslant \frac{9}{2} g^{3 / 2}+18 n+36 g+36 g \ln (n)+\frac{18 g^{2}}{m}
$$

Since $m \geqslant 3 \sqrt{g}$ and $n \leqslant 13 g$,

$$
C\left(K_{3}, G\right) \leqslant \frac{9}{2} g^{3 / 2}+270 g+36 g \ln (13 g)+6 g^{3 / 2}=\frac{21}{2} g^{3 / 2}+270 g+36 g \ln (13 g)
$$

6.2. Copies of $K_{4}$. In this section, we consider the case $H=K_{4}$, and define the excess of a graph $G$ to be $C\left(K_{4}, G\right)-|V(G)|$.

Lemma 6.5. For each surface $\Sigma$, every graph embeddable in $\Sigma$ with maximum excess is a triangulation of $\Sigma$.

Proof. Let $G$ be a graph embedded in $\Sigma$ with maximum excess. We claim that $G$ is a triangulation.

Suppose that some facial walk $F$ contains non-adjacent vertices $v$ and $w$. Let $G^{\prime}$ be the graph obtained from $G$ by adding the edge $v w$. Thus $C\left(K_{4}, G^{\prime}\right) \geqslant C\left(K_{4}, G\right)$. If two common neighbours of $v$ and $w$ are adjacent, then $C\left(K_{4}, G+v w\right)>C\left(K_{4}, G\right)$, implying that the excess of $G+v w$ is greater than the excess of $G$, which contradicts the choice of $G$. Now assume that no two common neighbours of $v$ and $w$ are adjacent. Let $G^{\prime \prime}:=G^{\prime} / v w$. Every $K_{4}$ subgraph in $G^{\prime}$ is also in $G^{\prime \prime}$. Thus $C\left(K_{4}, G^{\prime \prime}\right) \geqslant C\left(K_{4}, G^{\prime}\right) \geqslant$ $C\left(K_{4}, G\right)$. Since $\left|V\left(G^{\prime \prime}\right)\right|<|V(G)|$, the excess of $G^{\prime \prime}$ is greater than the excess of $G$, which contradicts the choice of $G$. Now assume that every facial walk induces a clique in $G$.

Suppose that some facial walk $F$ has at least four distinct vertices. Let $G^{\prime}$ be the embedded graph obtained from $G$ by adding one new vertex 'inside' the face adjacent to four distinct vertices of $F$. Thus $G^{\prime}$ is embeddable in $\Sigma$, has $|V(G)|+1$ vertices, has at least $C\left(K_{4}, G\right)+\binom{4}{3}=C\left(K_{4}, G\right)+4$ triangles, and thus has excess at least the excess of $G$ plus 3. This contradicts the choice of $G$. Now assume that every facial walk in $G$ has at most three distinct vertices.

Suppose that some facial walk $F$ is not a triangle. By Lemma 6.2, $F=(u, v, w, u, v, w)$. Let $G^{\prime}$ be the graph obtained from $G$ by adding two new adjacent vertices $p$ and $q$, where $p$ is adjacent to the first $u, v, w$ sequence in $F$, and $q$ is adjacent to the second $u, v, w$ sequence in $F$. So $G^{\prime}$ is embeddable in $\Sigma$ and has $|V(G)|+2$ vertices. If $S$ is a nonempty subset of $\{p, q\}$ and $T \subseteq\{u, v, w\}$ with $|S|+|T|=4$, then $S \cup T$ induces a copy of $K_{4}$ in $G^{\prime}$ but not in $G$. There are $\binom{2}{2}\binom{3}{2}+\binom{2}{1}\binom{3}{3}=3+2=5$ such copies. Thus $C\left(K_{4}, G^{\prime}\right) \geqslant C\left(K_{4}, G\right)+5$ and the excess of $G^{\prime}$ is at least the excess of $G$ plus 3 , which contradicts the choice of $G$. Therefore $G$ is a triangulation of $\Sigma$.

Theorem 6.6. Let $\phi$ be the maximum excess of an irreducible triangulation of $\Sigma$. Let $X$ be the set of irreducible triangulations of $\Sigma$ with excess $\phi$. Then the excess of every
graph $G$ embeddable in $\Sigma$ is at most $\phi$. Moreover, the excess of $G$ equals $\phi$ if and only if $G$ is obtained from some graph in $X$ by repeatedly splitting triangles.

Proof. We proceed by induction on $|V(G)|$. By Lemma 6.5, we may assume that $G$ is a triangulation of $\Sigma$. If $G$ is irreducible, then the claim follows from the definition of $X$ and $\phi$. Otherwise, some edge $v w$ of $G$ is in exactly two triangles $v w x$ and $v w y$. By induction, the excess of $G / v w$ is at most $\phi$. Moreover, the excess of $G / v w$ equals $\phi$ if and only if $G$ is obtained from some graph $H \in X$ by repeatedly splitting triangles.

Observe that every clique of $G$ that is not in $G / v w$ is in $\{A \cup\{w\}: A \subseteq\{x, v, y\}\}$. Thus $C\left(K_{4}, G\right) \leqslant C\left(K_{4}, G / v w\right)+1$. Moreover, equality holds if and only if $x v y$ is a triangle. It follows from the definition of excess that the excess of $G$ is at most $\phi$. If the excess of $G$ equals $\phi$, then the excess of $G / v w$ equals $\phi$, and $x v y$ is a triangle, and $G$ is obtained from $H$ by repeatedly splitting triangles.

Conversely, if $G$ is obtained from some $H \in X$ by repeatedly splitting triangles, then $x v y$ is a triangle and $G / v w$ is obtained from $H$ by repeatedly splitting triangles. By induction, the excess of $G / v w$ equals $\phi$, implying the excess of $G$ equals $\phi$.

Since every irreducible triangulation of a surface $\Sigma$ with Euler genus $g$ has $O(g)$ vertices [41, 54], Theorem 6.6 implies that $C\left(K_{4}, \Sigma, n\right) \leqslant n+O\left(g^{4}\right)$. We now show that $C\left(K_{4}, \Sigma, n\right)=n+\Theta\left(g^{2}\right)$.

Theorem 6.7. For every surface $\Sigma$ of Euler genus $g$,

$$
n+\frac{3}{2} g^{2} \leqslant C\left(K_{4}, \Sigma, n\right) \leqslant n+\frac{283}{24} g^{2}+O\left(g^{3 / 2}\right)
$$

where the lower bound holds for $g \geqslant 1$ and $n \geqslant \sqrt{6 g}$, and the upper bound holds for all $n$.

Proof. First we prove the lower bound. If $\Sigma=\mathbb{N}_{2}$ then let $p:=6$. Otherwise, let $p:=\left\lfloor\frac{1}{2}(7+\sqrt{24 g+1})\right\rfloor$. Since $g \geqslant 1$ we have $p \geqslant 6$. The Map Colour Theorem [62] says that $K_{p}$ embeds in $\Sigma$. To obtain a graph with $n$ vertices embedded in $\Sigma$ repeat the following step $n-p$ times: choose a face $f$ and add a new vertex 'inside' $f$ adjacent to all the vertices on the boundary of $f$. Each new vertex creates at least one new copy of $K_{4}$ (since the boundary of each face is always a clique on at least three vertices). Thus $C\left(K_{4}, \Sigma, n\right) \geqslant n-p+\binom{p}{4}$ for $n \geqslant p$. Since $\binom{p}{4}-p \geqslant \frac{1}{24}\left(p-\frac{5}{2}\right)^{4}$ and $p-\frac{5}{2}>\sqrt{6 g}$ we have $C\left(K_{4}, \Sigma, n\right) \geqslant n+\frac{1}{24}(\sqrt{6 g})^{4}=n+\frac{3}{2} g^{2}$.

Now we prove the upper bound. The claim is trivial for $g=0$, so now assume that $g \geqslant 1$. By Theorem 6.6, it suffices to consider an irreducible triangulation $G$. Joret and Wood [41] proved that $n:=|V(G)| \leqslant 13 g$. Let $v_{1}, \ldots, v_{n}$ be a vertex ordering of $G$, where $v_{i}$ has minimum degree in $G_{i}:=G\left[\left\{v_{1}, \ldots, v_{i}\right\}\right]$. By Euler's formula,

$$
i \cdot \operatorname{deg}_{G_{i}}\left(v_{i}\right) \leqslant 2\left|E\left(G_{i}\right)\right| \leqslant 6(i+g)
$$

and

$$
\operatorname{deg}_{G_{i}}\left(v_{i}\right) \leqslant 6\left(1+\frac{g}{i}\right)
$$

Define $m:=\lceil 4 \sqrt{g}\rceil$. The number of copies $v_{a} v_{b} v_{c} v_{i}$ with $a<b<c<i \leqslant m$ is at most $\binom{m}{4} \leqslant\binom{ 4 \sqrt{g}+1}{4} \leqslant \frac{32}{3} g^{2}$. Charge each copy $v_{a} v_{b} v_{c} v_{i}$ with $a<b<c<i$ and $i \geqslant m+1$ to vertex $v_{i}$. For $m+1 \leqslant i \leqslant n$, the number of copies charged to $v_{i}$ is at most

$$
\binom{\operatorname{deg}_{G_{i}}\left(v_{i}\right)}{3}<36\left(1+\frac{g}{i}\right)^{3}=36\left(\left(\frac{g}{i}\right)^{3}+3\left(\frac{g}{i}\right)^{2}+3\left(\frac{g}{i}\right)+1\right)
$$

In total,

$$
C\left(K_{4}, G\right) \leqslant \frac{32}{3} g^{2}+36 \sum_{i=m+1}^{n}\left(\frac{g}{i}\right)^{3}+3\left(\frac{g}{i}\right)^{2}+3\left(\frac{g}{i}\right)+1
$$

By (1) with $s=2$ and $s=3$,

$$
C\left(K_{4}, G\right) \leqslant \frac{32}{3} g^{2}+36\left(\frac{g^{3}}{2 m^{2}}+\frac{3 g^{2}}{m}+3 g(\ln n+1)+n\right) .
$$

Since $m \geqslant 4 \sqrt{g}$ and $n \leqslant 13 g$,

$$
\begin{aligned}
C\left(K_{4}, G\right) & \leqslant \frac{32}{3} g^{2}+36\left(\frac{g^{2}}{32}+\frac{3 g^{3 / 2}}{4}+3 g(\ln (13 g)+1)+13 g\right) \\
& =\frac{283}{24} g^{2}+27 g^{3 / 2}+108 g(\ln (13 g)+1)+468 g
\end{aligned}
$$

6.3. General Complete Graph. Now consider the case when $H=K_{s}$ for some $s \geqslant 5$. Theorem 1.2 shows that $C\left(K_{s}, \Sigma, n\right)$ is bounded for fixed $s$ and $\Sigma$. We now show how to determine $C\left(K_{s}, \Sigma, n\right)$ more precisely.

Theorem 6.8. For every integer $s \geqslant 5$ and surface $\Sigma$ there is an irreducible triangulation $G$ such that $C\left(K_{s}, G\right)=\max _{n} C\left(K_{s}, \Sigma, n\right)$.

Proof. Let $q:=\max _{n} C\left(K_{s}, \Sigma, n\right)$. Let $G_{0}$ be a graph embedded in $\Sigma$ with $C\left(K_{s}, G_{0}\right)=$ q. As described in the proof of Lemma 6.1 we can add edges and vertices to $G_{0}$ to create a triangulation $G$ of $\Sigma$. Adding edges and vertices does not remove copies of $K_{s}$. Thus $C\left(K_{s}, G\right)=q$. If $G$ is irreducible, then we are done. Otherwise, some edge $v w$ of $G$ is in exactly two triangles $v w x$ and $v w y$. Let $G^{\prime}:=G / v w$. Then $G^{\prime}$ is another triangulation of $\Sigma$. Observe that every clique of $G$ that is not in $G^{\prime}$ is in $\{A \cup\{w\}: A \subseteq\{x, v, y\}\}$. Each such clique has at most four vertices. Thus $C\left(K_{s}, G^{\prime}\right)=C\left(K_{s}, G\right)=q$. Repeat this step to $G^{\prime}$ until we obtain an irreducible triangulation $G^{\prime \prime}$ with $C\left(K_{s}, G^{\prime \prime}\right)=q$.

We now prove a precise bound on $C\left(K_{s}, \Sigma, n\right)$, making no effort to optimise the constant 300.

Theorem 6.9. For every integer $s \geqslant 5$ and surface $\sum$ of Euler genus $g$ and for all $n$,

$$
\left(\frac{\sqrt{6 g}}{s}\right)^{s} \leqslant C\left(K_{s}, \Sigma, n\right) \leqslant\left(\frac{300 \sqrt{g}}{s}\right)^{s}
$$

where the lower bound holds for all $n \geqslant \sqrt{6 g} \geqslant s$ and the upper bound holds for all $n$.

Proof. For the lower bound, it follows from the Map Colour Theorem [62] that $K_{p}$ embeds in $\Sigma$ where $p:=\lceil\sqrt{6 g}\rceil$. Thus, for $n \geqslant p \geqslant s$,

$$
C\left(K_{s}, \Sigma, n\right) \geqslant\binom{\sqrt{6 g}}{s} \geqslant\left(\frac{\sqrt{6 g}}{s}\right)^{s}
$$

Now we prove the upper bound. The claim is trivial for $g=0$, so assume that $g \geqslant 1$. By Theorem 6.8, it suffices to consider an irreducible triangulation $G$ of $\Sigma$. Joret and Wood [41] proved that $n:=|V(G)| \leqslant 13 g$. Let $v_{1}, \ldots, v_{n}$ be a vertex ordering of $G$, where $v_{i}$ has minimum degree in $G_{i}:=G\left[\left\{v_{1}, \ldots, v_{i}\right\}\right]$. By Euler's formula,

$$
i \cdot \operatorname{deg}_{G_{i}}\left(v_{i}\right) \leqslant 2\left|E\left(G_{i}\right)\right| \leqslant 6(i+g) \leqslant 6(n+g) \leqslant 84 g .
$$

Define $m:=\lceil\sqrt{g}\rceil$. The number of copies of $K_{s}$ in $G\left[\left\{v_{1}, \ldots, v_{m}\right\}\right]$ is at most

$$
\binom{m}{s} \leqslant\left(\frac{2 e \sqrt{g}}{s}\right)^{s} \leqslant\left(\frac{2 e}{s}\right)^{s} g^{s / 2}
$$

Charge every other copy $X$ of $K_{s}$ to the rightmost vertex in $X$ (with respect to $v_{1}, \ldots, v_{n}$ ). For $m+1 \leqslant i \leqslant n$, the number of copies of $K_{s}$ charged to $v_{i}$ is at most

$$
\binom{\operatorname{deg}_{G_{i}}\left(v_{i}\right)}{s-1} \leqslant\left(\frac{e \operatorname{deg}_{G_{i}}\left(v_{i}\right)}{s-1}\right)^{s-1} \leqslant\left(\frac{84 e g}{i(s-1)}\right)^{s-1}
$$

In total,

$$
C\left(K_{s}, G\right) \leqslant\left(\frac{2 e}{s}\right)^{s} g^{s / 2}+\left(\frac{84 e g}{s-1}\right)^{s-1} \sum_{i \geqslant m+1} \frac{1}{i^{s-1}}
$$

By (1),

$$
C\left(K_{s}, G\right) \leqslant\left(\frac{2 e}{s}\right)^{s} g^{s / 2}+\left(\frac{84 e g}{s-1}\right)^{s-1} \frac{1}{(s-2) m^{s-2}}
$$

Since $m \geqslant \sqrt{g}$,

$$
C\left(K_{s}, G\right) \leqslant\left(\frac{2 e}{s}\right)^{s} g^{s / 2}+\left(\frac{84 e g}{s-1}\right)^{s-1} \frac{1}{(s-2) g^{(s-2) / 2}} \leqslant\left(\frac{300 \sqrt{g}}{s}\right)^{s}
$$

6.4. Computational Results. For $\Sigma \in\left\{\mathbb{S}_{0}, \mathbb{S}_{1}, \mathbb{S}_{2}, \mathbb{N}_{1}, \mathbb{N}_{2}, \mathbb{N}_{3}, \mathbb{N}_{4}\right\}$, we use Lemmas 6.1 and 6.5 and Theorem 6.8, the lists of all irreducible triangulations [42, 43, 63, 65], and an elementary computer program to count cliques to obtain the exact results for $C\left(K_{s}, \Sigma, n\right)$ shown in Table 1.

Table 1. The maximum number of copies of $K_{s}$ in an $n$-vertex graph embeddable in surface $\Sigma$.

Let $C(G)$ be the total number of complete subgraphs in a graph $G$; that is $C(G)=$ $\sum_{s \geqslant 0} C\left(K_{s}, G\right)$. For a surface $\Sigma$, let $C(\Sigma, n)$ be the maximum of $C(G)$ taken over all $n$-vertex graphs $G$ embeddable in $\Sigma$. Dujmović, Fijavž, Joret, Sulanke, and Wood [17] proved that $C(\Sigma, n)-8 n$ is bounded for fixed $\Sigma$, which is implied by Theorems 6.4, 6.7 and 6.9. The following conjectures have been verified for each of $\mathbb{S}_{0}, \mathbb{S}_{1}, \mathbb{S}_{2}, \mathbb{N}_{1}, \mathbb{N}_{2}$, $\mathbb{N}_{3}, \mathbb{N}_{4}$.

Conjecture 6.10. For every surface $\Sigma$ and integer $n$,

$$
C(\Sigma, n)=\sum_{s \geqslant 0} C\left(K_{s}, \Sigma, n\right) .
$$

Conjecture 6.11. If $C(G)=C(\Sigma, n)$ for some $n$-vertex graph $G$ embeddable in a surface $\Sigma$, then for $s \geqslant 0$,

$$
C\left(K_{s}, G\right)=C\left(K_{s}, \Sigma, n\right)
$$

Conversely, we conjecture that maximising the number of triangles is equivalent to maximising the total number of complete subgraphs. More precisely:

Conjecture 6.12. If $C\left(K_{3}, G\right)=C\left(K_{3}, \Sigma, n\right)$ for some $n$-vertex graph $G$ embeddable in a surface $\Sigma$, then

$$
C(G)=C(\Sigma, n) .
$$

Note that $K_{3}$ cannot be replaced by some arbitrary complete graph in Conjecture 6.12. For example, every graph embeddable in $\mathbb{N}_{3}$ contains at most one copy of $K_{7}$, but there are irreducible triangulations $G$ of $\mathbb{N}_{3}$ that contain $K_{7}$ and do not maximise the total number of cliques (that is, $C(G)<8|V(G)|+104$ ). Similarly, every graph embeddable in $\mathbb{N}_{4}$ contains at most 8 copies of $K_{7}$, but there are irreducible triangulations $G$ of $\mathbb{N}_{4}$ for which $C\left(K_{7}, G\right)=8$ and $C(G)<8|V(G)|+216$.

## 7. Minor-Closed Classes

Consider the following natural open problem extending our results for graphs on surfaces: For graphs $H$ and $X$ and an integer $n$, what is the maximum number of copies of $H$ in an $n$-vertex $X$-minor-free graph? This problem has been extensively studied when $H$ and $X$ are complete graphs [22, 23, 44, 58, 60, 69]. Eppstein [18] proved the following result when $X$ is a complete bipartite graph and $H$ is highly connected.

Theorem 7.1 ([18]). Fix positive integers $s \leqslant t$ and a $K_{s, t}$-minor-free graph $H$ with no $(\leqslant s-1)$-separation. Then every $n$-vertex $K_{s, t}$-minor-free graph contains $O(n)$ copies of $H$.

What happens when $H$ is not highly connected? We have the following lower bound. Fix positive integers $s \leqslant t$ and a $K_{s, t}$-minor-free graph $H$. If $H$ has no $(\leqslant s-1)$-separation, then let $k:=1$; otherwise, let $k$ be the maximum number of pairwise independent ( $\leqslant s-1$ )-separations in $H$. The construction in Section 2 generalises to give $n$-vertex $K_{s, t}$-minor-free graphs containing $\Theta\left(n^{k}\right)$ copies of $H$.

The following question naturally arises:
Open Problem 7.2. Does every $n$-vertex $K_{s, t}$-minor-free graph contain $O\left(n^{k}\right)$ copies of $H$ ?

By Theorem 7.1, the answer is 'yes' if $k=1$. The methods presented in this paper show the answer is 'yes' if $s \leqslant 3$. We omit the proof, since it is essentially the same as for graphs embedded on a surface, except that in the $k=1$ case we use Theorem 7.1 instead of the additivity of Euler genus (Theorem 3.3).

When $H$ is a tree, this problem specialises as follows: Fix a tree $T$ and positive integers $s \leqslant t$. Let $\beta(T)$ be the size of the largest stable set of vertices in $T$, each with degree at most $s-1$. The construction in Corollary 1.3 generalises to give $n$-vertex $K_{s, t}$-minor-free graphs containing $\Omega\left(n^{\beta(T)}\right)$ copies of $T$.

Open Problem 7.3. Does every $n$-vertex $K_{s, t}$-minor-free graph contain $O\left(n^{\beta(T)}\right)$ copies of $T$ ?

## 8. Homomorphism Inequalities

This section reinterprets some of our results in terms of homomorphism inequalities, and presents some open problems that arise from this viewpoint.

For two graphs $H$ and $G$, a homomorphism from $H$ to $G$ is a function $\phi: V(H) \rightarrow V(G)$ that preserves adjacency; that is, $\phi(v) \phi(w)$ is an edge of $G$ for each edge $v w$ of $H$. Let hom $(H, G)$ be the number of homomorphisms from $H$ to $G$. For example, hom $\left(H, K_{t}\right)>$ 0 if and only if $H$ is $t$-colourable. In the other direction, $\operatorname{hom}\left(K_{1}, G\right)$ is the number of
vertices in $G$, and $\operatorname{hom}\left(K_{2}, G\right)$ is twice the number of edges in $G$, and $\operatorname{hom}\left(K_{3}, G\right)$ is 6 times the number of triangles in $G$.

Homomorphism inequalities encode bounds on the number of copies of given graphs in a host graph. Much of extremal graph theory can be written in terms of homomorphism inequalities, and a beautiful theory has recently developed that greatly simplifies the task of proving such inequalities; see [46].

Consider the following concrete example. Mantel [51] proved that every $n$-vertex graph with more than $\frac{n^{2}}{4}$ edges has a triangle, which is tight for the complete bipartite graph $K_{n / 2, n / 2}$. Goodman [29] strengthened Mantel's Theorem by providing a lower bound of $\frac{m}{3}\left(\frac{4 m}{n}-n\right)$ on the number of triangles in an $n$-vertex $m$-edge graph. Goodman's Theorem can be rewritten as the following homomorphism inequality:

$$
\begin{equation*}
\operatorname{hom}\left(K_{1}, G\right) \operatorname{hom}\left(K_{3}, G\right) \geqslant \operatorname{hom}\left(K_{2}, G\right)\left(2 \operatorname{hom}\left(K_{2}, G\right)-\operatorname{hom}\left(K_{1}, G\right)^{2}\right) . \tag{2}
\end{equation*}
$$

In a celebrated application of the flag algebra method, Razborov [59] generalised (2) by determining the minimum number of triangles in an $n$-vertex $m$-edge graph. The minimum number of copies of $K_{r}$ in an $n$-vertex $m$-edge graph (the natural extension of Turan's Theorem) was a notoriously difficult question [47, 48], recently solved for $r=4$ by Nikiforov [57] and in general by Reiher [61]. All of these results can be written in terms of homomorphism inequalities.

The results of this paper can be written in terms of homomorphism counts, since $I(H, G)$ equals the number of injective homomorphisms from $H$ to $G$, which equals hom $(H, G)$ if $H$ is a complete graph.

Here is another example of a homomorphism inequality for graphs on surfaces. Euler's Formula implies ${ }^{3}$ that the number of triangles in an $n$-vertex $m$-edge graph with Euler genus $g$ is at least $2(m-2 n+4-2 g)$. This result is an analogue of Goodman's Theorem for graphs $G$ of Euler genus $g$, and can be written as the following homomorphism inequality:

$$
\operatorname{hom}\left(K_{3}, G\right) \geqslant 6 \operatorname{hom}\left(K_{2}, G\right)-24 \operatorname{hom}\left(K_{1}, G\right)+48-24 g
$$

We consider it an interesting line of research to prove similar homomorphism inequalities in other minor-closed classes. The following open problems naturally arise.

- Is there a method (akin to flag algebras [59] or graph algebras [46]) for systematically proving homomorphism inequalities in minor-closed classes?
- Hatami and Norine [39] proved that it is undecidable to test the validity of a linear homomorphism inequality. In which minor-closed classes is it decidable to test the validity of a linear homomorphism inequality?

[^2]These questions are open even for forests; see $[12-14,16]$ for related results.
Closely related to the study of graph homomorphisms is the theory of graph limits and graphons [46]. While this theory focuses on dense graphs, a theory of graph limits for sparse graphs is emerging. For example, results are known for bounded degree graphs [11, 38], planar graphs [10, 30], and bounded tree-depth graphs [56]. The above questions regarding graph homomorphisms parallel the theory of graph limits in sparse classes.

Gyốri, Paulos, Salia, Tompkins, and Zamora [33] prove Corollary 1.3 in the case $\Sigma=\mathbb{S}_{0}$, and conjecture that $C\left(H, \Sigma_{0}, n\right)=\Theta\left(n^{k}\right)$ for some integer $k=k(H)$, which is implied by Theorem 1.2. Finally, many thanks to the referee for several insightful comments.

Postscript. Following the initial release of this paper, Open Problem 7.2 was answered in the negative by Liu [45] and Open Problem 7.3 was answered in the affirmative by Huynh and Wood [40].

For $c \geqslant 0$, let $\mathbb{N}_{c}$ be the sphere with $c$ cross-caps. Every surface is homeomorphic to $\mathbb{S}_{h}$ or $\mathbb{N}_{c}$. The Euler genus of $\mathbb{S}_{h}$ is $2 h$. The Euler genus of $\mathbb{N}_{c}$ is $c$. The Euler genus of a graph $G$ is the minimum Euler genus of a surface in which $G$ embeds with no crossings. A graph $H$ is a minor of a graph $G$ if a graph isomorphic to $H$ can be obtained from a subgraph of $G$ by contracting edges. If $G$ embeds in a surface $\Sigma$, then every minor of $G$ also embeds in $\Sigma$.

If $G$ is a 4-cycle abcd, then the two 2-separations $(A, B)$ and $(C, D)$ obtained by considering respectively the cutsets $\{b, d\}$ and $\{a, c\}$ satisfy the second condition but not the first. If $G$ consists of 5 non-adjacent vertices $a, b, c, d, e$ then the two 2-separations $(A, B)$ and $(C, D)$ with $V(A)=\{a, b, c, e\}, V(B)=\{b, c, d\}, V(C)=\{b, c, d, e\}$, $V(D)=\{a, b, c\}$ satisfy the first condition but not the second.

[^2]:    ${ }^{3}$ Let $G$ be a graph with $n$ vertices, $m$ edges and $c$ components. Let $\Sigma$ be a surface with Euler genus g. Assume that $G$ embeds in $\Sigma$ with $t$ triangular faces and $f$ non-triangular faces. By Euler's formula, $n-m+t+f=1+c-g$. Double-counting edges, $3 t+4 f \leqslant 2 m$. Thus $4(m-n-t+1+c-g)=4 f \leqslant 2 m-3 t$ and $t \geqslant 2 m-4 n+4+4 c-4 g \geqslant 2(m-2 n+4-2 g)$, as claimed.
