# Orthonormal bases on $L^{2}\left(\mathbb{R}^{+}\right)$

#### Abstract

We derive the explicit form of eigenvectors of selfadjoint extension $H_{\xi}$, parametrized by $\xi \in\langle 0, \pi)$, of differential expression $H=-\frac{d^{2}}{d x^{2}}+$ $\frac{x^{2}}{4}$ together with the spectrum $\sigma\left(H_{\xi}\right)$ on the space $L^{2}\left(\mathbb{R}^{+}\right)$. For each $\xi$ the set of eigenvectors form an orthonormal basis of $L^{2}\left(\mathbb{R}^{+}\right)$.


## 1 Introduction

The basic examples of quantum mechanics is a quantization the harmonic oscillator. A selfadjoint Hamiltonian $H_{D}$ of the one-dimensional linear harmonic oscillator is generated by the differential expression

$$
\begin{equation*}
H=-\frac{d^{2}}{d x^{2}}+\frac{x^{2}}{4} \tag{1}
\end{equation*}
$$

with appropriate definition domain $D$. It is known that the operator $H_{D}$ has a pure point spectrum and its eigenfunctions form the orthonormal basis in $L^{2}(\mathbb{R})$, and $H_{D}$ is a unique selfadjoint operator generated by $H$ on $L^{2}(\mathbb{R})$.

The situation is quite different on $L^{2}\left(\mathbb{R}^{+}\right)$, there is one-parametric set of selfadjoint operators $H_{\xi}, \xi \in\langle 0, \pi)$ with corresponding definition domains $D_{\xi}$ and with the same differential expression (11) ([1],p. 137). All these selfadjoint operators are selfadjoint extensions of the closed symmetric operator $\hat{H}$ with the domain $\hat{D}=\bigcap_{\xi \in\langle 0, \pi)} D_{\xi}$. Following the theorem ([2] p. 246) all these extension have the same essential spectrum. As in the case of the operator $H_{\xi=0}$, where it applies $\sigma_{\text {ess }}\left(H_{\xi=0}\right)=\emptyset$, it applies for all operators $H_{\xi}, \xi \in\langle 0, \pi)$. In other words, for any $\xi \in\langle 0, \pi)$ there exist an orthonormal basis formed by eigenvectors of $H_{\xi}$. The objective of this paper is to derive explicit form of the orthonormal basis and express $\sigma\left(H_{\xi}\right)$.

## 2 Parabolic cylinder functions

The parabolic cylinder fuctions [3] (9.240, 9.210)

$$
\begin{equation*}
D_{\nu}(x)=e^{-\frac{x^{2}}{4}}\left[\frac{\sqrt{\pi} 2^{\frac{\nu}{2}}}{\Gamma\left(\frac{1-\nu}{2}\right)}{ }_{1} \Phi_{1}\left(-\frac{\nu}{2}, \frac{1}{2}, \frac{x^{2}}{2}\right)-\frac{\sqrt{\pi} 2^{\frac{\nu+1}{2}}}{\Gamma\left(\frac{-\nu}{2}\right)} x_{1} \Phi_{1}\left(\frac{1-\nu}{2}, \frac{3}{2}, \frac{x^{2}}{2}\right)\right] \tag{2}
\end{equation*}
$$

are the solutions of the Weber differential equation 3] (9.255)

$$
\left(\frac{d^{2}}{d x^{2}}-\frac{x^{2}}{4}+\nu+\frac{1}{2}\right) D_{\nu}(x)=0 .
$$

Values $\nu \in\{0,1,2, \ldots\} \equiv \mathbb{N}_{0}$ need special attention, because of

$$
\frac{1}{\Gamma\left(\frac{-\nu}{2}\right)}=0, \Gamma\left(\frac{1-\nu}{2}\right)=\infty \text { for } \nu=1,3,5, \ldots
$$

and

$$
\frac{1}{\Gamma\left(\frac{-\nu}{2}\right)}=\infty, \quad \Gamma\left(\frac{1-\nu}{2}\right)=0 \text { for } \nu=0,2,4, \ldots
$$

Definition (2) then gives $D_{\nu}(x)=h_{\nu}(x)$ known hermitian functions [3] (9.253).

The following relations holds for PCFs [3] (7.711, 8.370, 8.372):

$$
\begin{equation*}
\int_{0}^{\infty}\left|D_{\nu}(x)\right|^{2} d x=\frac{1}{c(\nu)^{2}}, c(\nu)=\sqrt{\sqrt{\frac{2}{\pi}} \frac{\Gamma(-\nu)}{\beta(-\nu)}}, \quad \beta(-\nu)=\sum_{k=0}^{\infty} \frac{(-1)^{k}}{-\nu+k} \tag{3}
\end{equation*}
$$

(note that $c(\nu) D_{\nu}$ is normalized), and

$$
\begin{equation*}
\int_{0}^{\infty} D_{\nu}(x) D_{\mu}(x) d x=\frac{\pi 2^{\frac{1}{2}(\nu+\mu+1)}}{\mu-\nu}\left[\frac{1}{\Gamma\left(\frac{1-\mu}{2}\right) \Gamma\left(-\frac{\nu}{2}\right)}-\frac{1}{\Gamma\left(\frac{1-\nu}{2}\right) \Gamma\left(-\frac{\mu}{2}\right)}\right] \tag{4}
\end{equation*}
$$

## 3 Two Lemmas and two Theorems

It is known that the differential expression (1)

$$
H=-\frac{d^{2}}{d x^{2}}+\frac{x^{2}}{4}
$$

with definition domain

$$
\begin{equation*}
D_{\xi}(H):=\left\{f \in \tilde{\mathcal{D}}, f(0) \cos \xi-f^{\prime}(0) \sin \xi=0\right\} \tag{5}
\end{equation*}
$$

is a selfadjoint operator on $L^{2}\left(R^{+}\right)$for all $\xi \in\langle 0, \pi)$, and $\tilde{\mathcal{D}}=\left\{f f^{\prime} \in\right.$ a.c. $\left.(0, \infty): f, H f, \in L^{2}\left(R^{+}\right)\right\}$[1] (p. 127, p. 137)

So, if $D_{\nu}$ will belong to $\mathcal{D}_{\xi}(H)$ for some $\nu$ then $D_{\nu}$ will be an eigenvector of the considered selfadjoint operator with eigenvalues $\nu+$ $1 / 2$. Eq. (3) guarantees that $D_{\nu}$ lies in $\left.L^{2}\left(\mathbb{R}^{+}\right)\right)$.

The last condition generates the relationship

$$
\begin{equation*}
D_{\nu}(0) \cos \xi-D_{\nu}^{\prime}(0) \sin \xi=0 \tag{6}
\end{equation*}
$$

Although, values $D_{\nu}(0)$ and $D_{\nu}^{\prime}(0)$ can be calculated using definition (2), we have to distinguish two cases:

1. when $\nu \notin \mathbb{N}_{0}$ we obtain

$$
\begin{equation*}
\eta \Gamma\left(-\frac{\nu}{2}\right)-\Gamma\left(\frac{1-\nu}{2}\right)=0, \eta=\frac{1}{\sqrt{2}} \cot \xi \tag{7}
\end{equation*}
$$

2. when $\nu \in \mathbb{N}_{0}$ we obtain

$$
\begin{equation*}
h_{\nu}(0) \cos \xi-h_{\nu}^{\prime}(0) \sin \xi=0 \tag{8}
\end{equation*}
$$

If $\nu$ is odd, then $h_{\nu}(0)=0, h_{\nu}^{\prime}(0)=1$, and Eq. (8) is fulfilled only if $\xi=0$. If $\nu$ is even, then $h_{\nu}(0)=1, h_{\nu}^{\prime}(0)=0$, and Eq. (8) is fulfilled only if $\xi=\frac{\pi}{2}$. In both cases, condition (8) is fulfilled by the set of Hermitian functions $\left\{h_{0}, h_{2}, h_{4}, \ldots\right\}$ and $\left\{h_{1}, h_{3}, h_{5}, \ldots\right\}$, respectively. It is known that both sets form orthonormal bases in $L^{2}\left(\mathbb{R}^{+}\right)$.
Eq.(77) has to be solved for $\nu$.
First we prove two lemmas.

## Lemma 1:

1. If $\nu \in(2 M-1,2 M), M=1,2, \ldots$ or $\nu<0$, then $\beta(-\nu) \geq 0$,
2. If $\nu \in(2 M-2,2 M-1), M=1,2, \ldots$, then $\beta(-\nu)<0$.

## Proof:

1. Using the relationship

$$
\beta(-\nu)=\sum_{k=0}^{\infty} \frac{1}{(-\nu+2 k)(-\nu+2 k+1)}
$$

[3] (8.372), it is possible to show by elementary calculation that $(-\nu+$ $2 k)(-\nu+2 k+1)>0$ for all $k=0,1, \ldots$ if $\nu \in(2 M-1,2 M), M=$ $0,1, \ldots$, or $\nu<0$.
2. In this case we rewrite the sum $\beta(-\nu)$ in the following form:

$$
\beta(-\nu)=-\frac{1}{\nu}+\sum_{k=0}^{\infty} \frac{1}{-\nu+k+1}+\frac{1}{-\nu+k+2}=-\frac{1}{\nu}-\sum_{k=0}^{\infty} \frac{1}{(-\nu+k+1)(-\nu+k+2)}
$$

For considered values of $\nu \in(2 M-2,2 M-1), M=1,2, \ldots$ the products $(-\nu+k+1)(-\nu+k+2)$ are positive, and therefore all denominators of the members in the previous sum are positive and so $\beta \leq 0\left(\right.$ note that $\left.-\frac{1}{\nu}<0\right)$.

Remark: Comparing functions $\Gamma(-\nu)$ and $\beta(-\nu)$ we have the relationship

$$
\operatorname{sgn}(\Gamma(-\nu))=\operatorname{sgn}(\beta(-\nu)), \nu \in \mathbb{R}
$$

It shows that normalization factor $c(\nu)($ Eq.3) is correctly defined.

## Lemma 2:

Function $y(\nu):=\frac{\Gamma\left(\frac{1-\nu}{2}\right)}{\Gamma\left(-\frac{\nu}{2}\right)}$ has the following properties:

1. There are asymptotes for $\nu_{\text {as }} \in\left\{2 n+1 \mid n \in \mathbb{N}_{0}\right\}$ and $\lim _{\nu \rightarrow \nu}{ }_{\text {as }} y(\nu)=$ $\infty, \lim _{\nu \rightarrow \nu_{\mathrm{as}}^{-}} y(\nu)=-\infty$. Further $\lim _{\nu \rightarrow-\infty} y(\nu)=+\infty$.
2. The set $\left\{2 n \mid n \in \mathbb{N}_{0}\right\}$ consists of all zero points of $y$.
3. In the intervals $(-\infty, 1),(M, M+1), M=0,1, \ldots, y$ is continuous decreasing function.

## Proof:

1. The first assertion is a direct consequence of explicit form [3] (8.314) of function $\Gamma$.

For the remaining assertions it is sufficient to prove that the sequence $\left\{y(-2 n) \mid n \in \mathbb{N}_{0}\right\}$ is growing and $\lim _{n \rightarrow \infty} y(-2 n)=+\infty$. As $y(-2 n)$ can be expressed as

$$
y(-2 n)=\frac{\Gamma\left(n+\frac{1}{2}\right)}{\Gamma(n)}=\frac{\sqrt{\pi}(2 n-1)!!}{2^{n}(n-1)!}
$$

[3] (8.339), the assertion can be easily verified.
2. $\Gamma$ - function has no zero points. Therefore $y(\nu)=0$ only if $\left|\Gamma\left(-\frac{\nu}{2}\right)\right|=\infty$, i. e. $\nu=2 n$.
3. For $y^{\prime}(\nu)$ we obtain

$$
\frac{d y(\nu)}{d \nu}=\frac{1}{2} \frac{\Gamma\left(\frac{1-\nu}{2}\right)}{\Gamma\left(-\frac{\nu}{2}\right)}\left[\psi\left(-\frac{\nu}{2}\right)-\psi\left(\frac{1-\nu}{2}\right)\right], \psi(\mu)=\frac{d}{d \mu} \lg \Gamma(\mu)
$$

Using the relationships
$\psi\left(-\frac{\nu}{2}\right)-\psi\left(\frac{1-\nu}{2}\right)=-2 \beta(-\nu)$, and $\Gamma(-\nu)=\frac{2^{-\nu-1}}{\sqrt{\pi}} \Gamma\left(\frac{1-\nu}{2}\right) \Gamma\left(-\frac{\nu}{2}\right)$,
[3] $(8.370,8.335)$ we obtain

$$
\frac{d y(\nu)}{d \nu}=-2^{\nu} \frac{\sqrt{\pi}}{\Gamma\left(-\frac{\nu}{2}\right)^{2}} \Gamma(-\nu) \beta(-\nu)
$$

As $\Gamma(-\nu) \beta(-\nu)>0$ (see Remark) the proof is completed.

The consequence of this Lemma is a Theorem
Theorem 1:
For any $\eta \in \mathbb{R}$ and any $M \in \mathbb{N}=\{1,2, \ldots\}$ there is just one solution $\nu_{\eta}^{(M)}$ of Eq. (7) in the interval $I_{M}$, where

$$
I_{1}=(-\infty, 1), I_{M}=(2 M-1,2 M+1), M=2,3, \ldots
$$

No further solution of Eq. (7) exists.

Let $\Omega_{\xi}$ denote the set

$$
\Omega_{\xi}=\left\{\nu_{\cot \xi}^{(M)}, M=1,2, \ldots\right\}, \xi \in\langle 0, \pi), \nu_{\cot \xi}^{(M)}=\nu_{\eta}^{(M)},
$$

(we understand $\Omega_{0}=\{0,2,4, \ldots\}$ ),
and let denote further by $\mathcal{E}_{\xi}$ the set

$$
\mathcal{E}_{\xi}=\left\{c(\nu) D_{\nu} \mid \nu \in \Omega_{\xi}\right\} .
$$

The set $\mathcal{E}_{\xi} \subset \mathcal{D}_{\xi}$ contains all eigenvectors of the selfadjoint operator $H_{\xi}$, and the set $\left\{\nu+\frac{1}{2}, \nu \in \Omega_{\xi}\right\}$ contains all eigenvalues of $H_{\xi}$.

Note that orthogonality of two different eigenvectors can bee seen also from the Eq.(4). For different $\mu, \nu$ fulfilling the condition $\left.\Gamma\left(\frac{1-\mu}{2}\right) / \Gamma\left(-\frac{\mu}{2}\right)\right)=$ $\Gamma\left(\frac{1-\nu}{2}\right) / \Gamma\left(-\frac{\nu}{2}\right)=\eta$, which is our case, Eq. (4) is the scalar product in $L^{2}\left(R^{+}\right)$equal to zero. Moreover, the Eq. (3) guarantees that the eigenvectors are normalized.

We denote further by $\hat{H}$ the restriction of $H_{\xi}$ to domain

$$
\hat{D}=\left\{f \in \tilde{D}, f(0)=f^{\prime}(0)=0\right\} \subset D_{\xi}(H) \subset L^{2}\left(\mathbb{R}^{+}\right) .
$$

Operator $\hat{H}$ is closed, symmetric with deficiency indices $(1,1)[1]$ (prop. 4.8.6, p.129), and $H_{\xi}$ is a selfadjoint extension of $\hat{H}$ for any $\xi \in$ $\langle 0, \pi)$. Selfadjoint extensions $H_{\xi=0}$ and $H_{\xi=\frac{\pi}{2}}$ have pure point spectra, which is equivalent to the existence of orthonormal bases in $L^{2}\left(\mathbb{R}^{+}\right)$. The basis is in the case $D_{\xi=0}(H)=\left\{h_{2 n+1} \mid n=0,1,2, \ldots\right\}$, and it is in the case $D_{\xi=\frac{\pi}{2}}(H)=\left\{h_{2 n+1} \mid n=0,1,2, \ldots\right\}$. As we mentioned in the introduction, the same is true for all operators $H_{\xi}$ with any parameter $\xi$.

Consequently, one can write theorem

## Theorem 2

The set $\mathcal{E}_{\xi}$ consisting of eigenvectors of $H_{\xi}$ is an orthonormal basis in $L^{2}\left(\mathbb{R}^{+}\right)$for any $\xi \in\langle 0, \pi)$, and $\sigma\left(H_{\xi}\right)=\left\{\nu+\frac{1}{2}, \nu \in \Omega_{\xi}\right\}$.

## 4 Concluding remarks

The results we present can be translated to the case $L^{2}\left(\mathbb{R}^{-}\right)$. In this case an orthonormal basis in $L^{2}\left(\mathbb{R}^{-}\right)$is

$$
\tilde{\mathcal{E}}_{\xi}:=\left\{\tilde{D}_{\nu} \mid \nu \in \Omega_{\xi}\right\}, \tilde{D}_{\nu}(x):=D_{\nu}(-x) .
$$

These two bases can be combined to the base in $L^{2}(\mathbb{R})$. As $L^{2}(\mathbb{R})=$ $L^{2}\left(\mathbb{R}^{+}\right) \oplus L^{2}\left(\mathbb{R}^{-}\right)$. Then for any pair $(\xi, \sigma) \in\langle 0, \pi) \times\langle 0, \pi)$ the set $\mathcal{E}_{\xi} \oplus \hat{\mathcal{E}}_{\sigma}$ is a basis in $L^{2}(\mathbb{R})$. Explicitly

$$
\mathcal{E}_{\xi} \oplus \tilde{\mathcal{E}}_{\sigma}=\left\{\left(D_{\nu}, 0\right), \nu \in \Omega_{\xi}\right\} \cup\left\{\left(0, \tilde{D}_{\nu}\right), \nu \in \Omega_{\sigma}\right\} .
$$

Of note, the known orthonormal basis $\left\{h_{n}, n=0,1, \ldots\right\}$ of $L^{2}(\mathbb{R})$ consisting of hermitian functions is not contained in this set. Functions $h_{n}$ are eigenvectors of selfadjoint operator $H_{D}$ with definition domain

$$
D=\left\{f, f^{\prime} \text { absolutely continuous, } f, H f \in L^{2}(\mathbb{R})\right\}
$$

and operator $H_{D}$ is physically interpreted as Hamiltonian of quantum linear harmonic oscillator.
