# UNIVERSAL TUTTE POLYNOMIAL

#### Abstract

The Tutte polynomial is a well-studied invariant of graphs and matroids. We first extend the Tutte polynomial from graphs to hypergraphs, and more generally from matroids to polymatroids, as a two-variable polynomial. Our definition is related to previous works of Cameron and Fink and of Kálmán and Postnikov. We then define the universal Tutte polynomial $\mathscr{T}_{n}$, which is a polynomial of degree $n$ in $2+\left(2^{n}-1\right)$ variables that specializes to the Tutte polynomials of all polymatroids (hence all matroids) on a ground set with $n$ elements. The universal polynomial $\mathscr{T}_{n}$ admits three kinds of symmetries: translation invariance, $S_{n}$-invariance, and duality.


## 1. Introduction

The Tutte polynomial $T_{M}(x, y)$ is an important invariant of a matroid $M$. For a graphical matroid $M_{G}$ associated to a graph $G$, the Tutte polynomial $T_{G}(x, y):=$ $T_{M_{G}}(x, y)$ specializes to many classical graph invariants, such as the chromatic polynomial, the flow polynomial, the reliability polynomial etc. The Tutte polynomial and its various evaluations were studied in the context of statistical physics (partition functions of the Ising and Potts models), knot theory (Jones and Kauffman polynomials), and many other areas of mathematics and physics. There is a vast literature on the Tutte polynomial; see for instance [Bol, Chapter 10] or [EM] for an introduction and references.

This paper contains two main contributions to the theory of the Tutte polynomial. The first is an extension of the Tutte polynomial, from the class of matroids to that of polymatroids. Our notion is related to previous works of Kálmán and Postnikov [Pos, Kal, KP] and of Cameron and Fink [CF]. The second contribution is the definition of the universal Tutte polynomial $\mathscr{T}_{n}$, which is a polynomial in $x$, $y$, and $2^{n}-1$ additional variables $z_{I}$ indexed by the non-empty subsets $I$ of $[n]$. This polynomial specializes to the Tutte polynomials of all polymatroids (hence all matroids) on a ground set with $n$ elements. The polynomial $\mathscr{T}_{n}$ admits three kinds of symmetries: translation-invariance, $S_{n}$-invariance, and duality.

Let us mention here that our definition of the Tutte polynomial of a polymatroid does not appear to be directly related to other, known extensions of the Tutte polynomial to the polymatroid (or hypergraph) setting, such as the one defined by Helgason Hel] (see also [Sta3, Whi]). In fact, it is an open question whether there exists a relation between our Tutte polynomial and the chromatic polynomial of a hypergraph as defined in Ber , or the 'basic invariant' defined in AA, AKT]. See Section 18.3 for a more thorough discussion. We also note that our universal

Tutte polynomial $\mathscr{T}_{n}$ is not directly related to the "multivariate" Tutte polynomials of [BR, Zas, ET] or [Sok, which all satisfy linear deletion-contraction recurrences. Rather, $\mathscr{T}_{n}$ is a two-variable refinement of the "Ehrhart-type" polynomial of Pos, counting lattice points in generalized permutahedra. It gives a polynomial parametrization of the Tutte polynomials of all the polymatroids on the ground set $[n]$ in terms of their rank functions.
A Tutte polynomial for polymatroids. Recall that a matroid over a ground set $[n]$ can be defined in terms of its set of bases, which is a subset of $\{0,1\}^{n}$ satisfying the exchange axiom. Similarly, an integer polymatroid can be defined in terms of its set of bases, which is a finite subset of $\mathbb{Z}^{n}$ satisfying the appropriate version of the exchange axiom; see Section 3 for a precise definition ${ }^{11}$. Polymatroids are an abstraction of hypergraphs in the same manner as matroids are an abstraction of graphs. Indeed, for any graph $G$ the spanning trees of $G$ are the bases of a matroid, and similarly the set of spanning hypertrees of any hypergraph is the set of bases of a polymatroid (see Section 14 for definitions and Tut3 for a proof). Hence any polymatroid invariant automatically gives a hypergraph invariant.

It is natural to attempt to generalize the Tutte polynomial from matroids to polymatroids using the notions of internal and external activity. Recall that the original definition of the Tutte polynomial of a matroid $M$ [Cr2, Tut2] uses the notion of internal activity $\operatorname{int}(B)$ and external activity $\operatorname{ext}(B)$ of a basis $B$ of the matroid $M$, with respect to some total ordering of the ground set. These definitions are recalled in Section 2. The Tutte polynomial is then given by the sum

$$
T_{M}(x, y):=\sum_{B: \text { basis of } M} x^{\operatorname{int}(B)} y^{\operatorname{ext}(B)} .
$$

A remarkable feature of this definition is that, although the activities of each basis depend on the ordering of the ground set, the sum $T_{M}(x, y)$ is invariant under reordering.

Motivated by the study of the Homfly polynomial, which is an important invariant in knot theory, Kálmán [Kal] extended the notions of activity to the setting of polymatroids and used them to define two invariants called interior and exterior polynomial. Precisely, for a polymatroid $P$, the interior polynomial and exterior polynomial of $P$ are equivalent (via a change of variables) to the sums

$$
J_{P}(x):=\sum_{\mathbf{a}: \text { basis of } P} x^{\operatorname{int}(\mathbf{a})} \text { and } \quad E_{P}(y):=\sum_{\mathbf{a}: \text { basis of } P} y^{\operatorname{ext}(\mathbf{a})}
$$

respectively, where $\operatorname{int}(\mathbf{a})$ and $\operatorname{ext}(\mathbf{a})$ are the internal and external activities, respectively, of a (see Section 4 for the definitions).

It was shown in Kal] that, although the activities int(a) and ext(a) depend on the natural ordering of the ground set, the interior and exterior polynomials (in analogy to $T_{M}$ above) are independent of this ordering. We refer to this property as $S_{n}$-invariance, where $S_{n}$ is the symmetric group acting on the ground set $[n]$. However, somewhat disappointingly, the two-variable polynomial

$$
\begin{equation*}
\sum_{\mathbf{a}: \text { basis of } P} x^{\operatorname{int}(\mathbf{a})} y^{\operatorname{ext}(\mathbf{a})} \tag{1}
\end{equation*}
$$

[^0]is not $S_{n}$-invariant for a general polymatroid, even though this is the case for matroids.

A second proof of $S_{n}$-invariance for the polynomials $J_{P}$ and $E_{P}$ is given in KP using a "point-counting" perspective. Let us denote by $\mathcal{P}=\operatorname{conv}(P)$ the convex hull of $P$, which is classically known as the base polytope of the polymatroid $P$. It is shown in KP that $J_{P}$ and $E_{P}$ can be obtained via a certain binomial transformation from the Ehrhart-style functions (in fact, polynomials)

$$
f(s):=\left|(\mathcal{P}+s \nabla) \cap \mathbb{Z}^{n}\right| \quad \text { and } \quad g(t):=\left|(\mathcal{P}+t \Delta) \cap \mathbb{Z}^{n}\right|,
$$

respectively, that count numbers of lattice points in Minkowski sums of $\mathcal{P}$ with scaled simplices. Here $\Delta=\operatorname{conv}\left(\mathbf{e}_{1}, \ldots, \mathbf{e}_{n}\right) \subset \mathbb{R}^{n}$ is the standard coordinate ( $n-1$ )-simplex and $\nabla=-\Delta$. The obvious $S_{n}$-invariance of the polynomials $f$ and $g$ implies the $S_{n}$-invariance of the polynomials $J_{P}$ and $E_{P}$.

Cameron and Fink [CF combined $f$ and $g$ and defined a two-variable invariant $\mathscr{Q}_{P}^{\prime}(x, y)$ of a polymatroid $P$ via a binomial transformation of the two-variable Ehrhart-style polynomial

$$
\mathscr{Q}_{P}(s, t)=\left|(\mathcal{P}+s \nabla+t \Delta) \cap \mathbb{Z}^{n}\right| .
$$

The $S_{n}$-invariance of $\mathscr{Q}_{P}(s, t)$ and $\mathscr{Q}_{P}^{\prime}(x, y)$ is clear from the definitions. Moreover, it is shown in CF that the invariant $\mathscr{Q}_{P}^{\prime}$ is equivalent (up to a change of variables) to the Tutte polynomial $T_{P}$ in the case when $P$ is a matroid.

In the present paper, we take a different route and define the polymatroid Tutte polynomial $\mathscr{T}_{P}(x, y)$ in terms of internal and external activities, as the following sum over elements (bases) of a polymatroid $P$ :

$$
\begin{equation*}
\mathscr{T}_{P}(x, y):=\sum_{\mathbf{a}: \text { basis of } P} x^{\mathrm{oi}(\mathbf{a})} y^{\circ e(\mathbf{a})}(x+y-1)^{\mathrm{i}(\mathbf{a})}, \tag{2}
\end{equation*}
$$

where oi(a) is the number of ground set elements (to which we will also refer as indices) that are "only internally" active, but not externally active, with respect to a basis $\mathbf{a} \in P$; the quantity oe $(\mathbf{a})$ is the number of indices which are "only externally" active, but not internally active with respect to a; and ie(a) is the number of indices which are both "internally and externally" active. That is, what would have been $(x y)^{\mathrm{ie}(\mathbf{a})}$ in (1) is replaced with $(x+y-1)^{\mathrm{ie}(\mathbf{a})}$. In Section 10 we show that this suffices to achieve the desired $S_{n}$-invariance.

We stress that the notion of activity in (2) is the same as in Kal and above. In Section 5 we show that when the polymatroid $P$ is a matroid, then the polynomial $\mathscr{T}_{P}(x, y)$ is related to the classical Tutte polynomial $T_{P}(x, y)$ by a simple change of variables. It is also clear from the definition that the polymatroid Tutte polynomial satisfies the duality relation

$$
\mathscr{T}_{-P}(x, y)=\mathscr{T}_{P}(y, x) .
$$

We establish several properties of $\mathscr{T}_{P}$ such as interpretation for various specializations, and information on coefficients (see Propositions 4.11 and 5.4). In particular we give a formula for the top coefficients of $\mathscr{T}_{P}$ and show that it implies and extend the so-called Brylawski identities Bry (as well as Gordon's identity (Gor) for the classical Tutte polynomial of matroids.

As we show in Section 13, our polymatroid Tutte polynomial $\mathscr{T}_{P}(x, y)$ is essentially the same as Cameron-Fink's polynomial $\mathscr{Q}_{P}^{\prime}(x, y)$. However, we believe that the construction of $\mathscr{T}_{P}(x, y)$ is more straightforward, since it does not require
computing Ehrhart-style polynomials and applying binomial transformations.
We give a second expression for the polymatroid Tutte polynomial $\mathscr{T}_{P}(x, y)$ in Section 10. This is the polymatroid analogue of the classical definition of the Tutte polynomial as the generating function of subsets of the ground set counted according to their corank and nullity. Namely, for a polymatroid $P \subset \mathbb{Z}^{n}$, we show that $\mathscr{T}_{P}(x, y)$ is equivalent (up to a change of variables) to the weighted sum

$$
\widetilde{\mathscr{T}_{P}}(u, v):=\sum_{\mathbf{c} \in \mathbb{Z}^{n}} w t_{P}(\mathbf{c})
$$

Here the weight $w t_{P}(\mathbf{c})$ of an arbitrary lattice point $\mathbf{c} \in \mathbb{Z}^{n}$ is defined in terms of the Manhattan distance $d_{1}(P, \mathbf{c})$ between the polymatroid $P$ and $\mathbf{c}$, and a splitting of this Manhattan distance into two summands $d_{1}(P, \mathbf{c})=d_{1}^{>}(P, \mathbf{c})+d_{1}^{<}(P, \mathbf{c})$. Then we have $w t_{P}(\mathbf{c}):=u^{d_{1}^{>}(P, \mathbf{c})} v^{d_{1}^{<}(P, \mathbf{c})}$.

This second expression of $\mathscr{T}_{P}(x, y)$, through $\widetilde{\mathscr{T}}_{P}$, has the advantage of being explicitly $S_{n}$-invariant. Since $\mathscr{T}_{P}(x, y)$ specializes to the interior and exterior polynomials, our result gives an alternative proof of the $S_{n}$-invariance of those as well.

The proof of the equivalence between the two expressions of $\mathscr{T}_{P}$ relies on a decomposition of the lattice $\mathbb{Z}^{n}$ into cones indexed by the bases of $P$. This cone decomposition is the polymatroid analogue of another classical result about matroids. Namely, it generalizes the decomposition due to Crapo Cr2 of the Boolean lattice $\left(2^{[n]}, \subseteq\right)$ into intervals indexed by the bases of a matroid.

We also give two additional formulas for $\mathscr{T}_{P}(x, y)$ in terms of shadows of polymatroids; see Section 11. For matroids, these recover known expressions due to Gordon and Traldi GT for the Tutte polynomial as sums over either independent sets or spanning sets of the matroid.

A universal Tutte polynomial. The second main contribution of the present paper is to define the universal Tutte polynomial $\mathscr{T}_{n}$ for every positive integer $n$. This is a polynomial in the variables $x, y$, and the $2^{n}-1$ variables $z_{I}$ indexed by the nonempty subsets $I$ of $[n]$. It parametrizes the Tutte polynomials of all polymatroids defined on the ground set $[n]$. More precisely, to a polymatroid $P$ one can associate its rank function $f$ (which is the function $f: 2^{[n]} \rightarrow \mathbb{Z}$ defined by $f(I)=\max \left\{\sum_{i \in I} a_{i} \mid\left(a_{1}, \ldots, a_{n}\right) \in P\right\}$ ), and the Tutte polynomial $\mathscr{T}_{P}(x, y)$ is obtained from $\mathscr{T}_{n}$ by setting $z_{I}=f(I)$ for all nonempty sets $I \subseteq[n]$. As we recall in Section 3.2, the rank functions of polymatroids are exactly the submodular functions with values in $\mathbb{Z}$.

The universal Tutte polynomial $\mathscr{T}_{n}$ has total degree $n$, and $(n-1)!\mathscr{T}_{n}$ has integer coefficients. It admits three kinds of symmetries: translation-invariance, $S_{n}$-invariance and duality.

We give an explicit formula for $\mathscr{T}_{n}$ in Section 7 The expression involves the draconian sequences introduced in Pos for the enumeration of lattice points of generalized permutohedra. In fact, the proof of the formula is based on the fact that the base polytope $\mathcal{P}=\operatorname{conv}(P)$ of a polymatroid $P$ (and hence each of its faces) is a generalized permutohedron.

As we explain in Section 15, the explicit formula for $\mathscr{T}_{n}$ has a nice combinatorial interpretation when applied in the context of (a class of) hypergraphical polymatroids. This allows us to compute the polymatroid Tutte polynomials of graphical zonotopes in Section 16. Namely, we show that when $P$ is the polymatroid whose
bases are the lattice points of the zonotope associated to a graph $G$, then the polymatroid Tutte polynomial $\mathscr{T}_{P}(x, y)$ is a specialization of the classical Tutte polynomial $T_{G}(x, y)$ associated to $G$.

Outline of the paper. In Section 2 we recall some classical definitions about matroids and the Tutte polynomial. In Section 3 we recall some background definitions about polymatroids. In Section 4 we define, for each polymatroid $P$, the polymatroid Tutte polynomial $\mathscr{T}_{P}(x, y)$, and state some of its properties. Our definition is a polymatroid analogue of the definition of the classical Tutte polynomial in terms of activities. In Section 5 we spell out the relation, for a matroid, between its polymatroid Tutte polynomial and its classical Tutte polynomial. In Section 6 we define, for each natural number $n$, the universal Tutte polynomial $\mathscr{T}_{n}$ which is a polynomial parametrizing the Tutte polynomials of every polymatroid in $\mathbb{Z}^{n}$. In Section 7 we give an explicit expression for $\mathscr{T}_{n}$. In Section 8 we gather the proofs of some basic facts about activities and some properties of the polymatroid Tutte polynomial such as Brylawski's identities.

Up to this point in the article, the focus is on the notions of internal and external activity. The next five sections deal with some decompositions of the lattice $\mathbb{Z}^{n}$, and an $S_{n}$-invariant definition of the polymatroid Tutte polynomial. In Section 9 we define, for a polymatroid in $\mathbb{Z}^{n}$, a canonical decomposition of the lattice $\mathbb{Z}^{n}$ into cones. In Section 10 we use the cone decomposition of $\mathbb{Z}^{n}$ to give the polymatroid analogue of the corank-nullity definition of the classical Tutte polynomial. It comes in the form of another characterization of the polymatroid Tutte polynomial as a sum over elements of $\mathbb{Z}^{n}$. In Section 11 we give two other descriptions of the polymatroid Tutte polynomial $\mathscr{T}_{P}$ which are halfway between the expression in Section 4 and the expression in Section 10. These additional characterizations are based on some refined cone decompositions of $\mathbb{Z}^{n}$ which we study in Section 12 . In Section 13 we explain the relation between the polymatroid Tutte polynomial and the polymatroid invariant defined by Cameron and Fink [CF].

For the rest of the paper we turn our attention to polymatroids associated to hypergraphs. In Section 14 we recall some background on hypergraphs and the associated polymatroids. In Section 15 we use the explicit formula of $\mathscr{T}_{n}$ to give another combinatorial formula for the Tutte polynomial of a large class of hypergraphical polymatroids. This class does not contain graphical matroids but it does contain the class of graphical zonotopes. In Section 16 we compute the polymatroid Tutte polynomials of graphical zonotopes and show a relation with the Tutte polynomials of the associated graphs. In Section 17 we consider a certain truncation of the polymatroid Tutte polynomial and study its properties in the context of hypergraphs.

We conclude with some open questions in Section 18 .

Notation. Throughout the paper we use the following notation. For a positive integer $n$, we let $[n]=\{1, \ldots, n\}$. The set of all subsets of $[n]$ is denoted by $2^{[n]}$. The set of permutations of $[n]$ is denoted by $S_{n}$. We use the symbol $\biguplus$ to indicate the disjoint union of sets. We denote by $\mathbf{e}_{1}, \ldots, \mathbf{e}_{n}$ the elements of the canonical basis of $\mathbb{R}^{n}$. Lastly, for a point $\mathbf{x} \in \mathbb{R}^{n}$, we denote by $x_{i}$ the $i$ 'th coordinate of $\mathbf{x}$, so that $\mathbf{x}=\sum_{i=1}^{n} x_{i} \mathbf{e}_{i}$.

## 2. Background: Tutte polynomials of matroids

In this section we recall the notion of a matroid, and the definition of the Tutte polynomial in terms of internal and external activities. We fix a positive integer $n$ throughout the section.

Definition 2.1. A matroid $M$ on the ground set $[n]$ is a non-empty subset of $2^{[n]}$ (whose elements are called bases) satisfying the following condition:
Basis Exchange Axiom. For any two bases $A, B \in M$ and any $i \in A \backslash B$, there exists $j \in B \backslash A$ such that both $(A \backslash\{i\}) \cup\{j\}$ and $(B \backslash\{j\}) \cup\{i\}$ are bases of $M$.

The Basis Exchange Axiom implies that the bases of $M$ all have the same cardinality. This value is called the rank of $M$.

Remark 2.2. In the above definition we identify the matroid with its set of bases. Note also that the Basis Exchange Axiom is given in its "strong version;" this is known to be equivalent to the "weaker version" which only states that for all $A, B \in M$ and all $i \in A \backslash B$, there exists $j \in B \backslash A$ such that $(A \backslash\{i\}) \cup\{j\} \in M$.

Recall that any graph $G$ has an associated matroid $M_{G}$. Namely, for a connected graph $G$ with edge set $E=\left\{e_{1}, \ldots, e_{n}\right\}$ indexed by $[n]$, the bases of the matroid $M_{G}$ correspond to the spanning trees of $G$. Precisely, $A \subseteq[n]$ is a basis of $M_{G}$ if and only if $\left\{e_{i} \mid i \in A\right\}$ is the edge set of a spanning tree of $G$. For a non-connected graph $G$, the matroid $M_{G}$ is defined similarly but considering the maximal spanning forests of $G$ (consisting of one spanning tree in each connected component of $G$ ) instead of the spanning trees. A matroid obtained in this manner is called graphical.

Definition 2.3. Let $M$ be a matroid on the ground set $[n]$, and let $A \in M$ be a basis of $M$. An element $i \in A$ is called internally active if there is no $j<i$ such that $(A \backslash\{i\}) \cup\{j\}$ is a basis of $M$. Let $\operatorname{Int}_{M}(A) \subseteq A$ denote the set of internally active elements with respect to the basis $A$.

An element $i \in[n] \backslash A$ is called externally active if there is no $j<i$ such that $(A \cup\{i\}) \backslash\{j\}$ is a basis of $M$. Let $\operatorname{Ext}_{M}(A) \subseteq[n] \backslash A$ denote the set of externally active elements with respect to the basis $A$.

Remark 2.4. The definitions of activity are sometimes presented in terms of the fundamental cycle or cocycle of an element $i \in[n]$, with respect to a basis $A$. Namely, an element $i \notin A$ (resp., $i \in A$ ) is called active if $i$ is the smallest element in the unique cycle of $A \cup\{i\}$ (resp. unique cocycle of $([n] \backslash A) \cup\{i\})$. It is easy to see that this is equivalent to Definition 2.3 .

Definition 2.5. The Tutte polynomial $T_{M}(x, y)$ of the matroid $M$ is the following sum over all bases $A$ of $M$ :

$$
T_{M}(x, y)=\sum_{A \in M} x^{\left|\operatorname{Int}_{M}(A)\right|} y^{\left|\operatorname{Ext}_{M}(A)\right|}
$$

Example 2.6. Consider the graph $G$ of Figure 1 and identify the set of its edges with the set [6] as shown. The bases of the graphical matroid $M=M_{G}$ associated to $G$ correspond to the 11 spanning trees of $G$. With respect to the spanning tree $A$ indicated in the figure, the internally active edges are 4 and 5 , and the unique externally active edge is 1 . Thus, $A$ contributes $x^{2} y$ to the Tutte polynomial

$T_{M}(x, y)$. After computing and adding the other 10 contributions, one finds

$$
T_{M}(x, y)=\left(\begin{array}{rrrrr}
y^{2} & & & & \\
+y & +2 x y & +x^{2} y & & \\
& +x & +2 x^{2} & +2 x^{3} & +x^{4}
\end{array}\right)
$$

Clearly, the notions of internally and externally active elements depend on the ordering of the ground set $[n]$ of the matroid $M$. However, as we now recall, the Tutte polynomial $T_{M}(x, y)$ is invariant under reordering the ground set. More precisely, let us consider the reordering induced by a permutation $w \in S_{n}$. The permutation $w$ acts on the power set $2^{[n]}$ as well, and gives a new matroid $w(M)$. Tutte established the following classical result for graphs, which was later extended to matroids by Crapo.
Theorem 2.7 ([Tut2, Cr2]). For any matroid $M \subseteq 2^{[n]}$ and any permutation $w \in S_{n}$, we have

$$
T_{M}(x, y)=T_{w(M)}(x, y)
$$

Lastly, we recall the other (equivalent) characterization of the Tutte polynomial of a matroid $M \subseteq 2^{[n]}$ :

$$
\begin{equation*}
T_{M}(x, y)=\sum_{S \subseteq[n]}(x-1)^{\operatorname{cork}(S)}(y-1)^{\operatorname{null}(S)}, \tag{3}
\end{equation*}
$$

where the corank $\operatorname{cork}(S)$ of a subset $S$ is the minimal number of elements one needs to add to $S$ in order to obtain a set $S^{+}$containing a basis of $M$, and the nullity $\operatorname{null}(S)$ is the minimal number of elements one needs to delete from $S$ in order to obtain a set $S^{-}$contained in a basis of $M$.

## 3. BACKGROUND: POLYMATROIDS

Polymatroids, introduced by Edmonds Edm, are a generalization of matroids. In this paper we will restrict our attention to so-called integer polymatroids, and simply call them polymatroids. There are several alternative ways to define and view polymatroids: as $M$-convex sets $P \subset \mathbb{Z}^{n}$, as submodular functions $f: 2^{[n]} \rightarrow \mathbb{Z}$, and as the class of polytopes $\mathcal{P} \subset \mathbb{R}^{n}$ called (integer) generalized permutohedra. We now review these three perspectives in order, and then we introduce polymatroid duality and the generalized Ehrhart polynomial.
3.1. M-convexity. Fix a positive integer $n$, and recall that $\mathbf{e}_{1}, \ldots, \mathbf{e}_{n}$ denotes the canonical basis of $\mathbb{R}^{n}$.

Definition 3.1. An $M$-convex set is any subset $P \subset \mathbb{Z}^{n}$ that satisfies:
Exchange Axiom. For any $\mathbf{a}=\left(a_{1}, \ldots, a_{n}\right), \mathbf{b}=\left(b_{1}, \ldots, b_{n}\right) \in P$, and any $i \in[n]$ such that $a_{i}>b_{i}$, there exists $j \in[n]$ such that $a_{j}<b_{j}$ and both $\mathbf{a}-\mathbf{e}_{i}+\mathbf{e}_{j}$ and $\mathbf{b}+\mathbf{e}_{i}-\mathbf{e}_{j}$ belong to $P$.

A polymatroid is a finite nonempty M-convex set. The elements of such a set are called the bases of the polymatroid.

The Exchange Axiom implies that any M-convex set belongs to an affine hyperplane $\left\{x_{1}+\cdots+x_{n}=c\right\}$, for some constant $c \in \mathbb{Z}$. The constant $c$ is called the level of $P$ and is denoted by level $(P)$. It is also clear that adding the same vector to each element of an M-convex set yields another M-convex set.

Remark 3.2. Everywhere in this paper the term "polymatroid" stands for a subset of $\mathbb{Z}^{n}$ (something that may be called "integer polymatroid" elsewhere). On the other hand, our polymatroids are slightly more general than Edmonds' original notion $[E d m]$ in that Edmonds' polymatroids belong to the positive orthant $\mathbb{R}_{\geq 0}^{n}$. We do not need this condition, so we omitted it in order to simplify the notation. Since our constructions are all translation-invariant, the reader who prefers polymatroids to belong to the positive orthant may assume so without loss of generality.
Remark 3.3. (Matroids as polymatroids) Let $M \subseteq 2^{[n]}$ be a matroid (viewed as the collection of its bases as in Section 2). By identifying each subset $B \subseteq[n]$ with the vector $\mathbf{b}=\sum_{i \in B} \mathbf{e}_{i} \in\{0,1\}^{n}$, it is clear that any matroid $M$ yields a polymatroid $P(M):=\{\mathbf{b} \mid B \in M\}$. This shows that matroids with ground set $[n]$ are in bijection with polymatroids contained in $\{0,1\}^{n}$.
3.2. Submodular functions. We use Edm and Sch, chapter 44] as general references for results mentioned in this subsection.

Definition 3.4. A function $f: 2^{[n]} \rightarrow \mathbb{R}$ is submodular if $f(\varnothing)=0$ and, for any subsets $I, J \subseteq[n]$, we have

$$
\begin{equation*}
f(I)+f(J) \geq f(I \cup J)+f(I \cap J) \tag{4}
\end{equation*}
$$

Polymatroids $P \subset \mathbb{Z}^{n}$ bijective with integer submodular functions $f: 2^{[n]} \rightarrow \mathbb{Z}$. Indeed, for a polymatroid $P \subset \mathbb{Z}^{n}$, the rank function $f=f_{P}$ of $P$, defined by

$$
f(I)=\max _{\mathbf{a} \in P} \sum_{i \in I} a_{i}
$$

for all $I \subseteq[n]$, is a submodular function. Conversely, for an integer submodular function $f: 2^{[n]} \rightarrow \mathbb{Z}$, the associated polymatroid $P=P_{f}$ is given by

$$
P_{f}:=\left\{\mathbf{x} \in \mathbb{Z}^{n} \mid \sum_{i \in I} x_{i} \leq f(I) \text { for any subset } I \subseteq[n], \text { and } \sum_{i \in[n]} x_{i}=f([n])\right\}
$$

The same scheme applies to infinite M-convex sets, which correspond to submodular functions that may take $\infty$ as a value. Note that if we translate the M-convex set $P$ by a vector $\mathbf{v} \in \mathbb{Z}^{n}$, then its rank function $f=f_{P}$ shifts by the function $I \mapsto \sum_{i \in I} v_{i}$ (which satisfies (4) with equality).
Remark 3.5 (Rank functions of matroids). The rank function $f: 2^{[n]} \rightarrow \mathbb{Z}$ of a matroid $M \subseteq 2^{[n]}$ is usually defined to associate, to a subset $I \subseteq[n]$, the maximal cardinality of an intersection of $I$ with a basis of $M$. This is equal to the rank
function of the associated polymatroid $P(M) \subset \mathbb{Z}^{n}$. In fact, from the point of view of rank functions, matroids correspond to polymatroids such that the rank function $f$ satisfies $0 \leq f(I) \leq f(I \cup\{i\}) \leq f(I)+1$ for any $I \subseteq[n]$ and any $i \in[n]$.
3.3. Generalized permutohedra. We mention two definitions below; for the proof of their equivalence, and several other alternative characterizations of generalized permutohedra, see [PRW, Theorem 15.3].
Definition 3.6. Pos, Section 6] A generalized permutohedron is a convex polytope $\mathcal{P}$ in $\mathbb{R}^{n}$ such that every edge of $\mathcal{P}$ is parallel to a vector of the form $\mathbf{e}_{i}-\mathbf{e}_{j}$ for some $i, j \in[n]$ (where, as usual, $\mathbf{e}_{1}, \ldots, \mathbf{e}_{n}$ denotes the canonical basis of $\mathbb{R}^{n}$ ).

Equivalently, a generalized permutohedron is a polytope in $\mathbb{R}^{n}$ whose normal fan is a coarsening of the Coxeter fan, that is, the normal fan of the standard permutohedron $\Pi_{n}:=\operatorname{conv}\left\{(w(1), \ldots, w(n)) \mid w \in S_{n}\right\} \subset \mathbb{R}^{n}$.

To any matroid $M \subseteq 2^{[n]}$ one can associate the matroid polytope (also known as matroid base polytope)

$$
\mathcal{P}(M):=\operatorname{conv}\left\{\sum_{i \in B} \mathbf{e}_{i} \mid B \in M\right\} \subset \mathbb{R}^{n} .
$$

In GGMS, Gelfand, Goresky, MacPherson and Serganova give the following characterization of matroid polytopes.
Theorem 3.7. GGMS A polytope $\mathcal{P} \subset \mathbb{R}^{n}$, whose vertices all belong to the set $\{0,1\}^{n}$, is a matroid polytope $\mathcal{P}(M)$ of some matroid $M$ if and only if every edge of $\mathcal{P}$ is parallel to a vector of the form $\mathbf{e}_{i}-\mathbf{e}_{j}$.

Clearly, Definition 3.6 of generalized permutohedra is an extension of this characterization of matroid polytopes. Thus every matroid polytope is a generalized permutohedron. Moreover, matroid polytopes are exactly the generalized permutohedra whose vertices belong to the set $\{0,1\}^{n}$.

Generalized permutohedra $\mathcal{P} \subset \mathbb{R}^{n}$ can also be described by inequalities, namely

$$
\mathcal{P}=\mathcal{P}_{f}:=\left\{\mathbf{x} \in \mathbb{R}^{n} \mid \sum_{i \in I} x_{i} \leq f(I) \text { for all } I \subseteq[n], \text { and } \sum_{i \in[n]} x_{i}=f([n])\right\},
$$

where $f: 2^{[n]} \rightarrow \mathbb{R}$ is a submodular function. This gives a one-to-one correspondence between generalized permutohedra and $\mathbb{R}$-valued submodular functions.

A generalized permutohedron $\mathcal{P}$ is integer if all its vertices lie in $\mathbb{Z}^{n}$, or, equivalently, if the corresponding submodular function $f$ is integer-valued. Integer generalized permutohedra $\mathcal{P} \subset \mathbb{R}^{n}$ are in a one-to-one correspondence with polymatroids $P \subset \mathbb{Z}^{n}$. The correspondence is simply given by

$$
P=\mathcal{P} \cap \mathbb{Z}^{n} \quad \text { and, conversely, } \quad \mathcal{P}=\operatorname{conv}(P)
$$

Remark 3.8 (Polymatroids and Minkowski sums). Recall that the Minkowski sum of two subsets $\mathcal{A}, \mathcal{B}$ of $\mathbb{R}^{n}$ is defined as

$$
\mathcal{A}+\mathcal{B}=\{\mathbf{a}+\mathbf{b} \mid \mathbf{a} \in \mathcal{A}, \mathbf{b} \in \mathcal{B}\} .
$$

It is easy to see that the class of generalized permutohedra in $\mathbb{R}^{n}$ is closed under taking Minkowski sums. Indeed, for two submodular functions $f, g: 2^{[n]} \rightarrow \mathbb{Z}$, the function $f+g$ is clearly submodular, and hence the Minkowski sum $\mathcal{P}_{f}+\mathcal{P}_{g}$ of the associated generalized permutohedra is the generalized permutohedron $\mathcal{P}_{f+g}$.

Although it is less trivial, the identity also holds at the level of polymatroids : the Minkowski sum $P_{f}+P_{g}$ of the polymatroids associated to $f$ and $g$ is the polymatroid $P_{f+g}$. Hence, the class of polymatroids in $\mathbb{Z}^{n}$ is closed under Minkowski sums.


Figure 2. A polymatroid (with bases indicated by large dots) in $\mathbb{Z}^{3}$.

Example 3.9. Figure 2 shows a polymatroid $P \subset \mathbb{Z}^{3}$ which has 11 bases. The rank function $f: 2^{[3]} \rightarrow \mathbb{Z}$ of $P$ is given by $f(123)=f(12)=f(13)=f(23)=4$, $f(1)=2, f(2)=3, f(3)=4$, and $f(\varnothing)=0$. (Here 123 is an abbreviation for $\{1,2,3\}$, etc.) The polymatroid $P_{H}$ lies in the plane $x_{1}+x_{2}+x_{3}=4$, and is given by the inequalities $0 \leq x_{1} \leq 2,0 \leq x_{2} \leq 3,0 \leq x_{3} \leq 4$. Note that the three non-negativity constraints are equivalent to upper bounds, by values of the rank function given above, on the three possible sums of two coordinates.

The convex hull $\mathcal{P}=\operatorname{conv}(P) \subset \mathbb{R}^{3}$ is a generalized permutohedron. Indeed, every edge of $\mathcal{P}$ is parallel to a vector of the form $\mathbf{e}_{i}-\mathbf{e}_{j}$. Notice that $\mathcal{P}$ can be expressed as a Minkowski sum of coordinate simplices $\Delta_{I}:=\operatorname{conv}\left\{\mathbf{e}_{i} \mid i \in I\right\}$ (which are themselves generalized permutohedra) as follows:

$$
\mathcal{P}=\Delta_{13}+2 \Delta_{23}+\Delta_{123}
$$

3.4. Polymatroid duality. Given a matroid $M$ with ground set $[n]$, the dual matroid is

$$
M^{*}=\{[n] \backslash A \mid A \in M\} .
$$

In other words, the bases of $M^{*}$ are the complements of the bases of $M$. It is clear from the definitions that for any polymatroid $P \subset \mathbb{Z}^{n}$, the set

$$
-P:=\left\{\left(-x_{1}, \ldots,-x_{n}\right) \mid\left(x_{1}, \ldots, x_{n}\right) \in P\right\}
$$

is a polymatroid. We call $-P$ the dual of $P$. Note that there is a slight discrepancy between the notions of duality for matroids and polymatroids. Indeed, the polymatroid $P\left(M^{*}\right)$ is obtained from the polymatroid $-P(M)$ by translating it by the vector $(1,1, \ldots, 1)$. We will ignore this issue because, as we will see below, there is very little difference for us between a polymatroid and its translates.
3.5. Generalized Ehrhart polynomial. It turns out that the number of bases $|P|$ of a polymatroid $P=P_{f}$ or, equivalently, the number of integer lattice points $\left|\mathcal{P} \cap \mathbb{Z}^{n}\right|$ of an integer generalized permutohedron $\mathcal{P}=\mathcal{P}_{f}$, is a polynomial function of the values $(f(I))_{I \subseteq[n]}$ of its rank function $f$. This fact follows from a general result of Brion Bri about lattice points of polytopes, as explained in Pos, Sections 11 and 19].

Proposition $3.10([\overline{\mathrm{PoS}}])$. Let $n$ be a positive integer, and let $\left(z_{I}\right)_{\varnothing \neq I \subseteq[n]}$ be a set of variables indexed by the $2^{n}-1$ non-empty subsets of $[n]$.
(1) There exists a unique polynomial $E_{n}\left(\left(z_{I}\right)\right)$ such that for any integer-valued submodular function $f: 2^{[n]} \rightarrow \mathbb{Z}$, the number of bases in the polymatroid $P_{f}=\mathcal{P}_{f} \cap \mathbb{Z}^{n}$ of rank function $f$ is equal to the evaluation $E_{n}((f(I)))$.
(2) The polynomial $E_{n}$ has degree $n-1$, and $(n-1)$ ! $E_{n}$ has integer coefficients.

The polynomial $E_{n}$ is called the generalized Ehrhart polynomial of permutohedra. An explicit formula for $E_{n}$ is given in [Pos, Theorem 11.3]. This formula, which is related to hypertrees (or, equivalently, draconian sequences) will be recalled in Section 7 . We will in fact use the following easy corollary about the number of (relative) interior points of polymatroids.

Corollary 3.11. Let $P \subset \mathbb{Z}^{n}$ be a polymatroid, and let $f$ be its rank function. Let $\mathcal{P}=\operatorname{conv}(P)$ be the associated permutahedron, of dimension $\operatorname{dim}(\mathcal{P})$, and let $\mathcal{P}^{\circ}$ be its relative interior (the interior of $P$ in the affine subspace it spans). The number of interior lattice points $\left|\mathcal{P}^{\circ} \cap \mathbb{Z}^{n}\right|$ is given by the evaluation $(-1)^{\operatorname{dim}(\mathcal{P})} E_{n}((-f(I)))$ of the generalized Ehrhart polynomial.

In particular, for the class of polymatroids of fixed dimension d, the number $\left|\mathcal{P}^{\circ} \cap \mathbb{Z}^{n}\right|$ of interior points is a polynomial function of the rank values $(f(I))_{I \subseteq[n]}$ with coefficients in $\frac{1}{(n-1)!} \mathbb{Z}$.

Proof. From Proposition 3.10 we see that the classical Ehrhart polynomial $\mathfrak{i}_{\mathcal{P}}(t)$ of


$$
\mathfrak{i}_{\mathcal{P}}(t)=E_{n}((t f(I))) .
$$

Hence the Ehrhart-Macdonald reciprocity theorem Mac gives

$$
\left|\mathcal{P}^{\circ} \cap \mathbb{Z}^{n}\right|=(-1)^{\operatorname{dim}(\mathcal{P})} \mathfrak{i}_{\mathcal{P}}(-1)=(-1)^{\operatorname{dim}(\mathcal{P})} E_{n}((-f(I))) .
$$

The other assertion is immediate from part (2) of Proposition 3.10

## 4. Polymatroid Tutte polynomial

In this section we define the main object of this paper, the polymatroid Tutte polynomial, and start discussing its properties. We begin by defining activities for bases of a polymatroid.

Definition 4.1. [Kal, section 5.2]. Let $P \subset \mathbb{Z}^{n}$ be a polymatroid (or more generally an M-convex set, not necessarily finite). For $\mathbf{a} \in P$, an index $i \in[n]$ is called internally active if there is no $j<i$ such that $\mathbf{a}-\mathbf{e}_{i}+\mathbf{e}_{j} \in P$. Let $\operatorname{Int}(\mathbf{a})=$ $\operatorname{Int}_{P}(\mathbf{a}) \subseteq[n]$ denote the set of internally active indices with respect to $\mathbf{a}$.

For $\mathbf{a} \in P$, an index $i \in[n]$ is called externally active if there is no $j<i$ such that $\mathbf{a}+\mathbf{e}_{i}-\mathbf{e}_{j} \in P$. Let $\operatorname{Ext}(\mathbf{a})=\operatorname{Ext}_{P}(\mathbf{a}) \subseteq[n]$ denote the set of externally active indices with respect to a.

Note that the smallest index $i=1$ is always simultaneously internally active and externally active for every element a of $P$. In Figure 3 we indicated the activities of the bases of the polymatroid of Example 3.9.

We mention the following analogue of the characterization of activities, in terms of "minimality in the fundamental cycle or cocycle" that we mentioned in Remark 2.4

Lemma 4.2. Let $P \subset \mathbb{Z}^{n}$ be a polymatroid, with rank function $f$. Let $\mathbf{a} \in P$ be $a$ basis, and let $i \in[n]$.
(1) The index $i$ is externally active for $\mathbf{a}$ if and only if there exists a subset $I \subseteq[n]$ such that $i=\min (I)$ and $\sum_{i \in I} a_{i}=f(I)$.
(2) The index $i$ is internally active for $\mathbf{a}$ if and only if there exists a subset $I \subseteq[n]$ such that $i=\min (I)$ and $\sum_{i \in[n] \backslash I} a_{i}=f([n] \backslash I)$.

The proof of Lemma 4.2 is delayed to Section 8 . We point out that in the context of matroids, the minimal subset $I$ containing $i$ and such that $\sum_{i \in I} a_{i}=f(I)$ would be the fundamental cycle of the element $i$ with respect to the basis a (assuming $i$ is an external element).

We can now define the main character of this story.
Definition 4.3. Let $P \subset \mathbb{Z}^{n}$ be a polymatroid. The polymatroid Tutte polynomial $\mathscr{T}_{P}(x, y)$ is defined as

$$
\mathscr{T}_{P}(x, y):=\sum_{\mathbf{a} \in P} x^{\mathrm{oi}(\mathbf{a})} y^{\mathrm{oe}(\mathbf{a})}(x+y-1)^{\mathrm{ie}(\mathbf{a})}
$$

where oi( $\mathbf{a}):=|\operatorname{Int}(\mathbf{a}) \backslash \operatorname{Ext}(\mathbf{a})|$, oe $(\mathbf{a}):=|\operatorname{Ext}(\mathbf{a}) \backslash \operatorname{Int}(\mathbf{a})|$, and $\mathrm{ie}(\mathbf{a}):=\mid \operatorname{Int}(\mathbf{a}) \cap$ $\operatorname{Ext}(\mathbf{a}) \mid$.

In words, the first exponent oi(a) in the formula of $\mathscr{T}_{P}(x, y)$ is the number of indices $i \in[n]$ which are "only internally" active, but not externally active. The second exponent oe $(\mathbf{a})$ is the number of indices which are "only externally" active, but not internally active. The third exponent ie(a) is the number of indices which are both "internally and externally" active. Because 1 is such an index for any $\mathbf{a} \in P$, the polymatroid Tutte polynomial is always divisible by $x+y-1$.

This polymatroid invariant is a natural generalization of the classical Tutte polynomial of matroids. More precisely, as we show in Section 5 for any matroid $M$ the polynomials $T_{M}(x, y)$ and $\mathscr{T}_{P(M)}(x, y)$ are equivalent up to a change of variables.

Example 4.4. Let us compute the Tutte polynomial of the polymatroid $P \subset \mathbb{Z}^{3}$ from Example 3.9 , which is represented in Figures 2 and 3 . The first index $1 \in[3]$ is automatically active, both internally and externally, for any basis of $P$. To decide whether 2 is internally (resp., externally) active for a basis $\mathbf{a} \in P$, we check whether the point $\mathbf{a}-\left(\mathbf{e}_{2}-\mathbf{e}_{1}\right)$ (resp., $\left.\mathbf{a}+\left(\mathbf{e}_{2}-\mathbf{e}_{1}\right)\right)$ is a basis of $P$ or not. From Figure 3 we see that there are five bases $\mathbf{a} \in P$ such that $\mathbf{a}+\left(\mathbf{e}_{1}-\mathbf{e}_{2}\right) \notin P$, so that 2 is internally active for those bases. Similarly, the index 2 is externally active for five bases. Regarding the internal (resp., external) activity of the index 3 for a basis $\mathbf{a} \in P$, the criterion is whether $\mathbf{a}-\left(\mathbf{e}_{3}-\mathbf{e}_{1}\right) \notin P$ and $\mathbf{a}-\left(\mathbf{e}_{3}-\mathbf{e}_{2}\right) \notin P$ both hold (resp., $\left.\mathbf{a}+\left(\mathbf{e}_{3}-\mathbf{e}_{1}\right), \mathbf{a}+\left(\mathbf{e}_{3}-\mathbf{e}_{2}\right) \notin P\right)$. The index 3 is internally active for two bases and externally active for one base.

At the right of Figure 3 we listed the contributions of each basis to the polymatroid Tutte polynomial. More precisely, we wrote the part of each contribution
which comes from the indices 2 and 3 , in that order, and omitted the factor $(x+y-1)$ corresponding to the index 1 . Summing all the contributions gives

$$
\mathscr{T}_{P}(x, y)=(x+y-1)\left(\begin{array}{rrr}
y^{2} & & \\
+2 y & +2 x y & \\
+2 & +3 x & +x^{2}
\end{array}\right) .
$$


externally


$$
\begin{aligned}
& (x+y-1) \cdot y \\
& x \cdot 1 \quad y \cdot 1 \\
& x \cdot 1 \quad 1 \cdot 1 \quad y \cdot 1 \\
& x \cdot 1 \quad 1 \cdot 1 \quad y \cdot 1 \\

Figure 3. Internal and external activities of the elements of the polymatroid $P$ from Figure 2 On the left and in the middle we indicate the elements of $P$ for which the indices 2 and 3 are internally/externally active. On the right we show the contribution of each element to the polynomial $\mathscr{T}_{P}(x, y) /(x+y-1)$.

It is immediately clear from the definitions that the polymatroid Tutte polynomial is invariant under affine translations of polymatroids.

Lemma 4.5. For any polymatroid $P \subset \mathbb{Z}^{n}$ and any $\mathbf{c} \in \mathbb{Z}^{n}$, we have

$$
\mathscr{T}_{P}(x, y)=\mathscr{T}_{\mathbf{c}+P}(x, y) .
$$

Another easy property is the relation between the Tutte polynomial of a polymatroid $P$ and its dual $-P$.

Lemma 4.6. For any polymatroid $P$ we have

$$
\mathscr{T}_{P}(x, y)=\mathscr{T}_{-P}(y, x)
$$

Proof. Clearly, $i \in \operatorname{Int}_{P}(\mathbf{a})$ if and only if $i \in \operatorname{Ext}_{-P}(-\mathbf{a})$. Likewise, $i \in \operatorname{Ext}_{P}(\mathbf{a})$ if and only if $i \in \operatorname{Int}_{-P}(-\mathbf{a})$.

Lemma 4.6 is reminiscent of the relation between the Tutte polynomial of a matroid $M$ and its dual $M^{*}$. Indeed, Lemma 4.6 is an extension of this known duality relation (via the relation between the Tutte polynomials of matroids and polymatroids discussed in Section 5 ).

A far less obvious property of $\mathscr{T}_{P}$ is its $S_{n}$-invariance, that is to say, its invariance with respect to permutations of the coordinates of $\mathbb{Z}^{n}$. Here we consider the natural action of the symmetric group $S_{n}$ on $\mathbb{Z}^{n}$ by permutations of coordinates. That is, for a permutation $w \in S_{n}$ and a point $\mathbf{a}=\left(a_{1}, \ldots, a_{n}\right) \in \mathbb{Z}^{n}$ we define $w(\mathbf{a})=$ $\left(a_{w(1)}, \ldots, a_{w(n)}\right)$, and for $P \subset \mathbb{Z}^{n}$ we define

$$
w(P):=\{w(\mathbf{a}) \mid \mathbf{a} \in P\}
$$

We will prove the following theorem in Section 10
Theorem 4.7. Let $P \subset \mathbb{Z}^{n}$ be a polymatroid. Then, for any permutation $w \in S_{n}$,

$$
\mathscr{T}_{P}(x, y)=\mathscr{T}_{w(P)}(x, y)
$$

In other words, the Tutte polynomial $\mathscr{T}_{P}(x, y)$ does not depend on the choice of ordering of the coordinates.

Theorem 4.7 is a subtle claim. It does not imply that the double statistics $\mathbf{a} \mapsto(|\operatorname{Int}(\mathbf{a})|,|\operatorname{Ext}(\mathbf{a})|)$, on elements a of $P$, are equidistributed with each other for different orderings of the coordinates. The following example illustrates this point.

Example 4.8. For the polymatroid represented in Figure3, the "naive" polynomial $N_{P}=\sum_{\mathbf{a} \in P} x^{\left|\operatorname{Int}_{P}(\mathbf{a})\right|} y^{\left|\operatorname{Ext}_{P}(\mathbf{a})\right|}$ is not $S_{n}$-invariant. Indeed $N_{P}=x y\left(x^{2}+x y^{2}+\right.$ $x y+3 x+3 y+2)$, while for $w=132$ one gets $N_{w(P)}=x y\left(x^{2}+2 x y+y^{2}+3 x+2 y+2\right)$.

However, as we now explain, these pathologies do not occur for polymatroids which are "generic enough". We say that a polymatroid is of generic type, if the generalized permutahedron $\mathcal{P}=\operatorname{conv}(P)$ has normal fan equal to the braid arrangement (as is the case for the classical permutahedron).
Corollary 4.9. If $P \subseteq \mathbb{Z}^{n}$ is a polymatroid of generic type, then the double statistics $\mathbf{a} \mapsto(|\operatorname{Int}(\mathbf{a})|,|\operatorname{Ext}(\mathbf{a})|)$, on elements $\mathbf{a}$ of $P$, is $S_{n}$-invariant.

We delay the proof of Corollary 4.9 to Section 8 . Interestingly, the $S_{n}$-invariance of the double statistics also occurs for matroids, which are far from generic. A more immediate consequence of Theorem4.7 is that the single statistics $\mathbf{a} \mapsto|\operatorname{Int}(\mathbf{a})|$ and $\mathbf{a} \mapsto|\operatorname{Ext}(\mathbf{a})|$ on $P$ are both $S_{n}$-invariant:
Corollary 4.10. Let $P \subset \mathbb{Z}^{n}$ be a polymatroid. The polynomials

$$
\mathscr{T}_{P}(x, 1)=J_{P}(x)=\sum_{\mathbf{a} \in P} x^{|\operatorname{Int}(\mathbf{a})|} \quad \text { and } \quad \mathscr{T}_{P}(1, y)=E_{P}(y)=\sum_{\mathbf{a} \in P} y^{|\operatorname{Ext}(\mathbf{a})|}
$$

are $S_{n}$-invariant. That is to say, $\mathscr{T}_{w(P)}(x, 1)=\mathscr{T}_{P}(x, 1)$ and $\mathscr{T}_{w(P)}(1, y)=\mathscr{T}_{P}(1, y)$ for any $w \in S_{n}$.

The above corollary was originally proved in Kal, where $I_{P}(x)=x^{n} \mathscr{T}_{P}\left(x^{-1}, 1\right)$ and $X_{P}(y)=y^{n} \mathscr{T}_{P}\left(1, y^{-1}\right)$ are called the interior and exterior polynomials of $P$, respectively.

We now list some additional properties of the polymatroid Tutte polynomial. For polymatroids $P \in \mathbb{Z}^{n}$ and $Q \in \mathbb{Z}^{m}$, we define their direct sum as

$$
P \oplus Q:=\left\{\left(a_{1}, a_{2}, \ldots, a_{n}, b_{1}, b_{2}, \ldots, b_{m}\right) \mid \mathbf{a} \in P, \mathbf{b} \in Q\right\} \subset \mathbb{Z}^{n+m}
$$

and their aggregated sum as

$$
P \boxplus Q:=\left\{\left(a_{1}+b_{1}, a_{2}, \ldots, a_{n}, b_{2}, \ldots, b_{m}\right) \mid \mathbf{a} \in P, \mathbf{b} \in Q\right\} \subset \mathbb{Z}^{n+m-1}
$$

These are easily seen to be polymatroids.
Proposition 4.11. Let $n$ be a positive integer, let $P \subset \mathbb{Z}^{n}$ be a polymatroid, and let $\mathcal{P}=\operatorname{conv}(P)$ be the associated generalized permutahedron.
(a) The polymatroid Tutte polynomial $\mathscr{T}_{P}(x, y)$ has degree $n$.
(b) The coefficients of $\mathscr{T}_{P}(x, y+1)$ and $\mathscr{T}_{P}(x+1, y)$ are non-negative integers, but $\mathscr{T}_{P}(x, y)$ always has both positive and negative coefficients.
(c) The polynomial $\mathscr{T}_{P}(x, y)$ is divisible by $(x+y-1)^{\operatorname{codim}(P)}$, where $\operatorname{codim}(P)=$ $n-\operatorname{dim}(\mathcal{P})$ is the codimension of $\mathcal{P}$.
(d) The top homogeneous component of $\mathscr{T}_{P}(x, y)$ equals $(x+y)^{n}$. Equivalently, for all $k \in[n]$, the coefficient of $x^{k} y^{n-k}$ in $\mathscr{T}_{P}(x, y)$ is $\binom{n}{k}$.
(e) For any polymatroid $Q$, we have

$$
\mathscr{T}_{P \oplus Q}(x, y)=\mathscr{T}_{P}(x, y) \mathscr{T}_{Q}(x, y) \quad \text { and } \quad \mathscr{T}_{P \boxplus Q}(x, y)=\frac{\mathscr{T}_{P}(x, y) \mathscr{T}_{Q}(x, y)}{x+y-1}
$$

(f) Let $i \in[n]$. For $\mathbf{a} \in \mathbb{Z}^{n}$ we put $\widehat{\mathbf{a}}^{i}=\left(a_{1}, \ldots, a_{i-1}, a_{i+1}, \ldots, a_{n}\right) \in \mathbb{Z}^{n-1}$. Let $f$ be the rank function of $P$, and let $r_{i}=f(\{i\})+f([n] \backslash\{i\})-f([n])$. If $r_{i}=0$, then

$$
\mathscr{T}_{P}(x, y)=(x+y-1) \mathscr{T}_{\widehat{P}^{i}}(x, y)
$$

where $\widehat{P}^{i}:=\left\{\widehat{\mathbf{a}}^{i} \mid \mathbf{a} \in P\right\}$. If $r_{i}=1$, then

$$
\begin{equation*}
\mathscr{T}_{P}(x, y)=x \mathscr{T}_{P \backslash i}(x, y)+y \mathscr{T}_{P / i}(x, y), \tag{6}
\end{equation*}
$$

where $P \backslash i:=\left\{\widehat{\mathbf{a}}^{i} \mid \mathbf{a} \in P, a_{i}=f(\{i\}-1)\right\}$ and $P / i:=\left\{\widehat{\mathbf{a}}^{i} \mid \mathbf{a} \in P, a_{i}=\right.$ $f(\{i\})\}$.
(g) $\mathscr{T}_{P}(1,1)=|P|=\left|\mathcal{P} \cap \mathbb{Z}^{n}\right|$ and $\mathscr{T}_{P}(0,0)=(-1)^{\operatorname{codim}(P)}\left|\mathcal{P}^{\circ} \cap \mathbb{Z}^{n}\right|$, where $\mathcal{P}^{\circ}$ is the relative interior of $\mathcal{P}$ (its interior in the affine subspace it spans).
(h) Consider the Minkowski differences of $\mathcal{P}$ with the standard simplex $\Delta=$ $\operatorname{conv}\left(\mathbf{e}_{i}, i \in[n]\right)$ and the reversed simplex $\nabla=\operatorname{conv}\left(-\mathbf{e}_{i}, i \in[n]\right)$ :
$\mathcal{P}-\Delta:=\left\{\mathbf{a} \in \mathbb{R}^{n} \mid \mathbf{a}+\Delta \in \mathcal{P}\right\}$ and $\mathcal{P}-\nabla:=\left\{\mathbf{a} \in \mathbb{R}^{n} \mid \mathbf{a}+\nabla \in \mathcal{P}\right\}$.
The numbers of lattice points in these polytopes are given by

$$
\left.\frac{\mathscr{T}_{P}(x, y)}{(x+y-1)}\right|_{x=1, y=0}=\left|(\mathcal{P}-\Delta) \cap \mathbb{Z}^{n}\right| \text { and }\left.\frac{\mathscr{T}_{P}(x, y)}{(x+y-1)}\right|_{x=0, y=1}=\left|(\mathcal{P}-\nabla) \cap \mathbb{Z}^{n}\right|
$$

respectively.
We postpone the proof of Proposition 4.11 to Section 8 . We mention that Prop$\operatorname{erty}(\mathrm{f})$ is a (partial) generalization to the polymatroid setting of the deletioncontraction identity satisfied by the classical Tutte polynomial; see Section 18.2 for further discussion of this point. We also mention, with respect to Property (h), that it is shown in Section 13 that for all positive integers $k$, the number of lattice points in the Minkowski sums $\mathcal{P}+k \Delta$ and $\mathcal{P}+k \nabla$ for $k \in \mathbb{Z} \geq 0$ are also captured by $\mathscr{T}_{P}(x, y)$.

## 5. Classical Tutte polynomial vs polymatroid Tutte polynomial

Recall from Remark 3.3 that any matroid $M$ (viewed as a set of bases) can be identified with a polymatroid

$$
P(M):=\left\{\sum_{i \in A} \mathbf{e}_{i} \mid A \in M\right\}
$$

Thus, for a matroid $M$, we have the classical Tutte polynomial $T_{M}(x, y)$ and the polymatroid Tutte polynomial $\mathscr{T}_{P(M)}(x, y)$. We claim that these polynomials, although not literally equal, are related by a simple change of variables.

Let us point out a few superficial differences between $T_{M}(x, y)$ and $\mathscr{T}_{P(M)}(x, y)$.
(1) The polymatroid Tutte polynomial $\mathscr{T}_{P}$ is invariant under affine translations of $P$, whereas $T_{M}(x, y)$ is not invariant under translation (not even for translations of $P(M)$ which stay within $\left.\{0,1\}^{n}\right)$. For instance, for a matroid $M$ with a single basis the classical Tutte polynomial is $T_{M}(x, y)=x^{d} y^{n-d}$, where $d$ is the rank. By contrast, for a polymatroid $P$ with a single basis the polymatroid Tutte polynomial is $\mathscr{T}_{P}(x, y)=(x+y-1)^{n}$, independently of the level.
(2) The polymatroid Tutte polynomial $\mathscr{T}_{P}(x, y)$ is always divisible by $(x+y-1)$. In contrast, the classical Tutte polynomial $T_{M}(x, y)$ is never divisible by $(x+y-1)$. To see this, recall that a factor of a matroid is a subset $S$ of the ground set $[n]$ so that the rank function $f$ satisfies $f(S)+f([n] \backslash S)=f([n])$. Matroids can be restricted to any subset of their ground set and when we restrict to a pair of factors $S$ and $[n] \backslash S$, then we have $T_{\left.M\right|_{S}} \cdot T_{\left.M\right|_{[n] \backslash S}}=T_{M}$. Finally when a matroid only has trivial factors, then its matroid Tutte polynomial cannot be divisible by $x+y-1$ because substituting $x=0$, $y=1$ in it yields a positive quantity (bounded below by the so called $\beta$ invariant, see [Cr1]).
One reason for the discrepancy between $T_{M}(x, y)$ and $\mathscr{T}_{P(M)}(x, y)$ is that the definitions of activities for matroids and polymatroids are not exactly equivalent. The following trivial lemma expresses the relationship between the two notions.

Lemma 5.1. Let $M \subset 2^{[n]}$ be a matroid, and let $P=P(M) \subset \mathbb{Z}^{n}$ be the corresponding polymatroid. Let $A \in M$ be a basis of $M$, and let $\mathbf{a}=\sum_{i \in A} \mathbf{e}_{i}$ be the corresponding point of $P$. Then the sets $\operatorname{Int}_{M}(A)$ and $\operatorname{Ext}_{M}(A)$ of internally/externally active elements with respect to the basis $A$ of the matroid $M$ are related to the sets $\operatorname{Int}_{P}(\mathbf{a})$ and $\operatorname{Ext}_{P}(\mathbf{a})$ of internally/externally active indices, with respect to the point a of the polymatroid $P$, as follows:

$$
\operatorname{Int}_{P}(\mathbf{a})=\operatorname{Int}_{M}(A) \cup([n] \backslash A) \quad \text { and } \quad \operatorname{Ext}_{P}(\mathbf{a})=\operatorname{Ext}_{M}(A) \cup A
$$

Since each basis $A$ of $M$ has the same cardinality (the rank $d$ of $M$ ), the discrepancy noted in Lemma 5.1 would only change the Tutte polynomial by a monomial factor. A more substantial effect comes from the presence of $(x+y-1)^{\mathrm{ie}(\mathbf{a})}$ in Definition 4.3 , which replaces what would be $(x y)^{\mathrm{ie}(\mathbf{a})}$ if we followed Definition 2.5 . Indeed, it is this change that leads to order-independence and some other favorable properties. The exact relation between the classical and polymatroid Tutte polynomials is as follows.

Theorem 5.2. Let $M \subset 2^{[n]}$ be a matroid of rank d on the ground set [n], and let $P=P(M) \subset\{0,1\}^{n}$ be the corresponding polymatroid as defined in Remark 3.3. Then we have

$$
\begin{equation*}
\mathscr{T}_{P}(x, y)=x^{n-d} y^{d} T_{M}\left(\frac{x+y-1}{y}, \frac{x+y-1}{x}\right) . \tag{7}
\end{equation*}
$$

Proof. Let $A$ be a basis of $M$. Let $\iota:=\left|\operatorname{Int}_{M}(A)\right|$ and $\epsilon:=\left|\operatorname{Ext}_{M}(A)\right|$ be the usual internal and external activities of $A$ (in the matroidal sense). For the corresponding point a of the polymatroid $P=P(M)$, all of these $\iota+\epsilon$ internally or externally active indices become both internally and externally active at the same time (in the polymatroidal sense). In addition, by Lemma 5.1. there will be another $n-d-\epsilon$ internally active indices and $d-\iota$ externally active indices with respect to the point
$\mathbf{a} \in P$. Thus if the basis $A \in M$ makes the contribution $x^{\iota} y^{\epsilon}$ to the classical Tutte polynomial $T_{M}(x, y)$, then the corresponding point $\mathbf{a} \in P$ makes the contribution

$$
(x+y-1)^{\iota+\epsilon} x^{n-d-\epsilon} y^{d-\iota}=x^{n-d} y^{d}\left(\frac{x+y-1}{y}\right)^{\iota}\left(\frac{x+y-1}{x}\right)^{\epsilon}
$$

to the polymatroid Tutte polynomial $\mathscr{T}_{P}(x, y)$. This implies the stated relation between the two polynomials.

Example 5.3. Let $M$ be the graphical matroid of Example 2.6. If we compute the polymatroid Tutte polynomial of $P=P(M)$, we obtain

$$
\mathscr{T}_{P}(x, y)=(x+y-1)\left(\begin{array}{rrrrrr}
y^{5} & & & & & \\
-y^{4} & +5 x y^{4} & & & & \\
& -4 x y^{3} & +10 x^{2} y^{3} & & \\
& +x y^{2} & -11 x^{2} y^{2} & +10 x^{3} y^{2} & & \\
& & +5 x^{2} y & -10 x^{3} y & +5 x^{4} y & \\
& & -x^{2} & +3 x^{3} & -3 x^{4} & +x^{5}
\end{array}\right)
$$

The polynomials $T_{M}$ and $\mathscr{T}_{P}$ are related by the substitution indicated in Theorem 5.2. Observe that, when viewed in triangular form, the two polynomials produce the same row-sums and column-sums of coefficients, owing to the fact that $x y$ and $x+y-1$ agree when $x=1$ or $y=1$.

We note that the inverse of the conversion formula (7) for a matroid $M$ on $[n]$ of rank $d$ is

$$
T_{M}(x, y)=\frac{(x+y-x y)^{n}}{x^{n-d} y^{d}} \mathscr{T}_{P(M)}\left(\frac{x}{x+y-x y}, \frac{y}{x+y-x y}\right)
$$

As we now explain, the Brylawski identities for the Tutte polynomial $T_{M}$ of a matroid $M$ are a direct consequence of Proposition 4.11(d) about the top coefficients of $\mathcal{T}_{P(M)}$. Recall that Brylawski identities are linear relations between the coefficients of $T_{M}$. These identities can be written as follows. Consider the power series

$$
B(x, y)=\sum_{i, j \geq 0}\binom{i}{j} x^{i} y^{j}=\sum_{i \geq 0} x^{i}(1+y)^{i}=\frac{1}{1-x(1+y)}
$$

It was shown by Brylawski Bry that for all integers $p, q$ such that $q \geq 0$ and $p<n+q$,

$$
\begin{equation*}
\left[x^{p} y^{q}\right] B(x, y) T_{M}(x,-1 / y)=0 \tag{8}
\end{equation*}
$$

Equivalently, denoting $t_{i, j}=\left[x^{i} y^{j}\right] T_{M}(x, y)$, and using the fact that $t_{i, j}=0$ for $i<0$ this identity can be written as

$$
\forall q \geq 0, \forall p<n+q, \sum_{i=0}^{p} \sum_{j=0}^{i}\binom{i}{j}(-1)^{j} t_{p-i,-q+j}=0
$$

For instance, the case $(p, q)=(0,0)$ gives $t_{0,0}=0$ for all $n>0$. The case $(p, q)=$ $(1,0)$ gives $t_{1,0}+t_{0,0}-t_{0,1}=0$, hence $t_{1,0}=t_{0,1}$, for all $n>1$.

Additionally it was proved by Gordon Gor that for all $q \geq 0$,

$$
\begin{equation*}
\left[x^{n+q} y^{q}\right] B(x, y) T_{M}(x,-1 / y)=(-1)^{n-d} \tag{9}
\end{equation*}
$$

Of course all the relations (8) and (9) are not all independent, and the case $q=0$ actually implies the general case $q \geq 0$. We will show in Section 8 that Proposition 4.11(d) implies the following generalization of (8) and (9) to polymatroids.

Proposition 5.4 (Brylawski identities). Let $P \subset \mathbb{Z}^{n}$ be a polymatroid of level d, and let $T_{P}(x, y):=\frac{(x+y-x y)^{n}}{x^{n-d} y^{d}} \mathscr{T}_{P}\left(\frac{x}{x+y-x y}, \frac{y}{x+y-x y}\right)$. Then $T_{P}(x, y)$ is a Laurent polynomial in $x, y$. Moreover, denoting $\ell$ the minimal $y$-degree of $T_{P}(x, y)$ one has for all $q \geq-\ell:\left[x^{p} y^{q}\right] B(x, y) T_{P}(x,-1 / y)=0$ for all $p<n+q$, and $\left[x^{n+q} y^{q}\right] B(x, y) T_{P}(x,-1 / y)=(-1)^{n-d}$.

## 6. Universal Tutte polynomial

In this section we define, for any positive integer $n$, the universal Tutte polynomial $\mathscr{T}_{n}$. This is a polynomial (of degree $n$ ) in the variables $x, y$ and $\left\{z_{I}\right\}$, where the index $I$ runs over all the nonempty subsets of $[n]$. The polynomial $\mathscr{T}_{n}$ contains the polymatroid Tutte polynomials of every polymatroid $P \subset \mathbb{Z}^{n}$, in the sense that $\mathscr{T}_{P}(x, y)$ is obtained from $\mathscr{T}_{n}$ by specializing the variables $z_{I}$. More precisely, we have the following.

Theorem 6.1. Let $n$ be a positive integer.
(1) There exists a unique polynomial $\mathscr{T}_{n}\left(x, y,\left(z_{I}\right)\right)$ in $x, y$ and the $2^{n}-1$ variables $z_{I}$ indexed by the nonempty subsets $I$ of $[n]$, such that, for any submodular function $f: 2^{[n]} \rightarrow \mathbb{Z}$, the specialization of $\mathscr{T}_{n}$ at $z_{I}=f(I)$, for all $I \subseteq[n]$, is the polymatroid Tutte polynomial of the polymatroid $P_{f}$ :

$$
\mathscr{T}_{P_{f}}(x, y)=\left.\mathscr{T}_{n}\left(x, y,\left(z_{I}\right)\right)\right|_{z_{I}=f(I), \forall I \subseteq[n]}
$$

(2) The polynomial $\mathscr{T}_{n}$ has total degree $n$, and $(n-1)$ ! $\mathscr{T}_{n}$ has integer coefficients.

Definition 6.2. The universal Tutte polynomial $\mathscr{T}_{n}\left(x, y,\left(z_{I}\right)\right)$ is the polynomial in the variables $x, y$, and $\left(z_{I}\right)_{\varnothing \neq I \subseteq[n]}$, whose existence and uniqueness are provided by part (1) of Theorem 6.1

An explicit expression of $\mathscr{T}_{n}$ will be given in Section 7 using results from [Pos.
Example 6.3. In the case $n=1$, all polymatroids are singletons, and their Tutte polynomial is $x+y-1$. Hence the universal Tutte polynomial is $\mathscr{T}_{1}=x+y-1$. (It does not depend on its third variable $z_{\{1\}}$.)

To illustrate Theorem 6.1 and the challenges in its proof, we now examine the case $n=2$. For conciseness, we will write the nonempty subsets of $[2]=\{1,2\}$ as 1,2 , and 12 .

The three constraints for the points $\mathbf{a}=\left(a_{1}, a_{2}\right)$ of a polymatroid $P \subset \mathbb{Z}^{2}$ are indicated in Figure 4. (Submodularity in this case means $z_{1}+z_{2} \geq z_{12}$.) As usual the index 1 is internally and externally active for every point $\mathbf{a} \in P$. The index 2 is internally active only for the bottom point and it is externally active only for the top point. Considering the case $z_{1}+z_{2}>z_{12}$ leads to the following tentative formula for the universal Tutte polynomial $\mathscr{T}_{2}$ :

$$
\begin{align*}
\mathscr{T}_{2} & =(x+y-1) x+\left(z_{1}+z_{2}-z_{12}-1\right)(x+y-1)+(x+y-1) y  \tag{10}\\
& =(x+y-1)\left(x+y-1+z_{1}+z_{2}-z_{12}\right)
\end{align*}
$$



Figure 4. An arbitrary polymatroid in $\mathbb{Z}^{2}$.
Now, when $z_{1}+z_{2}=z_{12}$, the polymatroid $P$ degenerates to a point and both indices are internally and externally active. The important observation is that the expression $\sqrt{10}$ for $\mathscr{T}_{2}$ specializes to the correct value $\mathscr{T}_{P}(x, y)=(x+y-1)^{2}$ for this case, despite the fact that the logic we used to write the formula does not apply.
Example 6.4. The third universal Tutte polynomial is

$$
\begin{aligned}
\mathscr{T}_{3}=(x & +y-1)\left(x^{2}+2 x y+y^{2}\right. \\
& +\left(z_{1}+z_{2}+z_{3}-z_{123}-2\right) x+\left(z_{12}+z_{13}+z_{23}-2 z_{123}-2\right) y \\
& +\frac{1}{2}\left(z_{123}^{2}-z_{12}^{2}-z_{13}^{2}-z_{23}^{2}-z_{1}^{2}-z_{2}^{2}-z_{3}^{2}-2 z_{123}\left(z_{1}+z_{2}+z_{3}\right)\right. \\
+2\left(z_{1} z_{12}+\right. & \left.\left.\left.z_{1} z_{13}+z_{2} z_{12}+z_{2} z_{23}+z_{3} z_{13}+z_{3} z_{23}\right)+3 z_{123}-z_{12}-z_{13}-z_{23}-z_{1}-z_{2}-z_{3}+2\right)\right)
\end{aligned}
$$

At $z_{1}=2, z_{2}=3, z_{3}=z_{12}=z_{13}=z_{23}=z_{123}=4$, it does specialize to the polymatroid Tutte polynomial that we computed in Example 4.4

In the proof of Theorem 6.1, and in the next section, it will be fruitful to consider an alternative to the set of variables $\left(z_{I}\right)_{\varnothing \neq I \subseteq[n]}$. Namely, we consider the indeterminates $\left(t_{I}\right)_{\varnothing \neq I \subseteq[n]}$, and the following change of variables:

$$
\begin{equation*}
z_{I}=\sum_{\varnothing \neq J \subseteq[n] \text { with } J \cap I \neq \varnothing} t_{J} \tag{11}
\end{equation*}
$$

By applying the inclusion-exclusion formula between $t_{I}$ and $y_{I}=M-z_{[n] \backslash I}=$ $\sum_{J \subseteq I} t_{J}$, where $M=\sum_{\varnothing \neq J \subseteq[n]} t_{J}$, we obtain the inverse

$$
\begin{equation*}
t_{I}=\sum_{\varnothing \neq J \subseteq[n] \text { with } J \cup I=[n]}(-1)^{|I \cap J|+1} z_{J} \tag{12}
\end{equation*}
$$

In this paper, we use the variables $\left(z_{I}\right)$ to parametrize the rank function of a generalized permutohedron $\mathcal{P}$ (and thus the positions of its facets). As we now explain, the variables $\left(t_{I}\right)$ should be thought of as parametrizing the coefficients in the decomposition of $\mathcal{P}$ into the Minkowski sum of simplices.

Remark 6.5. For a non-empty subset $I \subseteq[n]$, we denote by $\Delta_{I}=\operatorname{conv}\left(\mathbf{e}_{i} \mid i \in I\right)$ the coordinate simplex associated to $I$. For a (non-zero) tuple $\mathbf{m}=\left(m_{I}\right)_{\varnothing \neq I \subseteq[n]}$ of non-negative integers, we consider the Minkowski sum

$$
\mathcal{Q}_{\mathbf{m}}:=\sum_{\varnothing \neq I \subseteq[n]} m_{I} \Delta_{I} .
$$

Since each simplex $\Delta_{I}$ is a generalized permutohedron, Remark 3.8 lets us conclude that $\mathcal{Q}_{\mathrm{m}}$ is a generalized permutohedron, and that $Q_{\mathrm{m}}:=\mathcal{Q}_{\mathrm{m}} \cap \mathbb{Z}^{n}$ is a polymatroid. By computing the rank functions of the simplices $\Delta_{I}$, we deduce that the rank function of $Q_{\mathrm{m}}$ is the function $f_{\mathrm{m}}: 2^{[n]} \rightarrow \mathbb{Z}$ given by

$$
\begin{equation*}
f_{\mathbf{m}}(I)=\sum_{\varnothing \neq J \subseteq[n]: J \cap I \neq \varnothing} m_{J} \tag{13}
\end{equation*}
$$

for all $I \subseteq[n]$. In other words, $Q_{\mathrm{m}}=P_{f_{\mathrm{m}}}$. Comparing (11) to (13) justifies our interpretation of the variables $t_{I}$ as parametrizing the coefficients in the decomposition of generalized permutahedra into the Minkowski sum of simplices (at least when evaluating the variables $t_{I}$ at non-negative integers). We mention that it was proved in DK1, DK2 that any polymatroid can actually be written as a Minkowski sum and difference of simplices of the form $\Delta_{I}$.

Before embarking on the proof of Theorem 6.1 let us state a classical fact (see, e.g., Fuji, Theorem 3.15]), of which we include a proof for the reader's convenience.

Lemma 6.6. If a polymatroid $P \subset \mathbb{Z}^{n}$ has codimension $c$, then it is a direct sum of $c$ polymatroids. That is to say, there exists a permutation $w \in S_{n}$ and some polymatroids $P_{1}, \ldots, P_{c}$ such that $w(P)=P_{1} \oplus \cdots \oplus P_{c}$.

Proof. Assume $c>1$. Then there exists a subset $\varnothing \neq I \subsetneq[n]$ such that $P \subset$ $\left\{\mathbf{x} \in \mathbb{R}^{n} \mid \sum_{i \in I} x_{i}=f(I)\right\}$, where $f$ is the rank function of $P$. Up to permutation of coordinates, we can assume that $I=[k]$ for some $0<k<n$. Let $Q=\left\{\left(a_{1}, \ldots, a_{k}\right) \mid \mathbf{a} \in P\right\}$ and $Q^{\prime}=\left\{\left(a_{k+1}, \ldots, a_{n}\right) \mid \mathbf{a} \in P\right\}$. We claim that $Q \oplus Q^{\prime}=\left\{\left(a_{1}, \ldots, a_{n}\right) \mid\left(a_{1}, \ldots, a_{k}\right) \in Q,\left(a_{k+1}, \ldots, a_{n}\right) \in Q^{\prime}\right\}$ is equal to $P$. Indeed the inclusion $P \subseteq Q \oplus Q^{\prime}$ is obvious, and the exchange axiom easily implies that $Q \oplus Q^{\prime} \subseteq P$. Thus, if $c>1$, then $P$ is the direct sum of two polymatroids. The claimed property follows by induction on $c$.

Proof of Theorem 6.1. Let us start by proving the uniqueness of $\mathscr{T}_{n}$. Suppose that some polynomials $\mathscr{T}_{n}\left(x, y,\left(z_{I}\right)\right)$ and $\mathscr{T}_{n}^{\prime}\left(x, y,\left(z_{I}\right)\right)$ both satisfy Property (1). Let $\left(t_{I}\right)_{\varnothing \neq I \subseteq[n]}$ be a new set of variables, and let $\widehat{\mathscr{T}}_{n}\left(x, y,\left(t_{I}\right)\right)$ and $\widehat{\mathscr{T}}_{n}^{\prime}\left(x, y,\left(t_{I}\right)\right)$ be the polynomials obtained from $\mathscr{T}_{n}$ and $\mathscr{T}_{n}^{\prime}$, respectively, via the substitution 11). It suffices to show that $\widehat{\mathscr{T}_{n}}=\widehat{\mathscr{T}}_{n}^{\prime}$. For any tuple $\mathbf{m}=\left(m_{I}\right)_{\varnothing \neq I \subseteq[n]}$ of non-negative integers, the function $f_{\mathbf{m}}: 2^{[n]} \rightarrow \mathbb{Z}$ given by $(13)$ is the rank function of the polymatroid $Q_{\mathbf{m}}$. By assumption, $\mathscr{T}_{n}\left(x, y,\left(f_{\mathbf{m}}(I)\right)\right)=\mathscr{T}_{Q_{\mathbf{m}}}(x, y)=\mathscr{T}_{n}^{\prime}\left(x, y,\left(f_{\mathbf{m}}(I)\right)\right)$, hence $\widehat{\mathscr{T}}_{n}\left(x, y,\left(m_{I}\right)\right)=\widehat{\mathscr{T}}_{n}^{\prime}\left(x, y,\left(m_{I}\right)\right)$ for all tuples $\left(m_{I}\right)$ of non-negative integers. This implies $\widehat{\mathscr{T}}_{n}=\widehat{\mathscr{T}}_{n}^{\prime}$, and proves the uniqueness of $\mathscr{T}_{n}$.

We now embark on the proof of the existence of $\mathscr{T}_{n}$. Let us consider the set of polymatroids $P \subset \mathbb{Z}^{n}$ such that the generalized permutohedron $\mathcal{P}=\operatorname{conv}(P)$ has a given fixed "combinatorial type" (that is, a given normal fan). As we now explain, the number of lattice points in the relative interior $\mathcal{F}^{\circ}$ of any face $\mathcal{F}$ of $\mathcal{P}$ is a polynomial in the variables $\left(z_{I}\right)$ (which record the values of the rank function of $\mathcal{P}$ ). In fact, the face $\mathcal{F}$ is a generalized permutahedron, and by Corollary 3.11, the number of lattice points in $\mathcal{F}^{\circ}$ is a polynomial function of the rank function of $\mathcal{F}$. So it is sufficient to show that the values of the rank function $g$ of $\mathcal{F}$ are polynomial functions of the values of the rank function $f$ of $\mathcal{P}$. We will actually prove that each value $g(I)$ is a linear function of $(f(J))_{J \subseteq[n]}$. By induction on the codimension of $\mathcal{F}$, it suffices to show that this is true for each facet $\mathcal{F}$ of $\mathcal{P}$. So let
us fix a non-empty subset $K \subsetneq[n]$ and consider the facet $\mathcal{F}=\mathcal{P} \cap H_{K}$, where $H_{K}$ is the hyperplane $\left\{\mathbf{x} \in \mathbb{R}^{n} \mid \sum_{i \in K} x_{i}=f(K)\right\}$. We contend that the rank function $g$ of $\mathcal{F}$ is given in terms of the rank function $f$ of $\mathcal{P}$ by

$$
g(I)=f(I \cup K)+f(I \cap K)-f(K)
$$

Indeed it is not hard to prove that this function $g$ is submodular, and that $P_{g}=$ $P_{f} \cap H_{K}$ (the inclusion $P_{g} \subseteq P_{f}$ is by submodularity of $f$, the inclusion $P_{g} \subseteq H_{K}$ is because $g(K)=f(K)$ and $g([n] \backslash K)=f([n])-f(K)$, and the inclusion $P_{f} \cap H_{K} \subseteq$ $P_{g}$ is because any $\mathbf{a} \in P_{f} \cap H_{K}$ satisfies $\sum_{i \in I} a_{i}=\sum_{i \in I \cup K} a_{i}+\sum_{i \in I \cap K} a_{i}-$ $\left.\sum_{i \in K} a_{i} \leq g(I)\right)$. Hence we have indeed proved that the number of lattice points in $\mathcal{F}^{\circ}$ is a polynomial in the $\left(z_{I}\right)$.

Moreover, for a basis $\mathbf{a} \in P$ the sets $\operatorname{Int}_{P}(\mathbf{a})$ and $\operatorname{Ext}_{P}(\mathbf{a})$ of internally and externally active indices depend only on the unique face of the polytope $\mathcal{P}$ whose relative interior contains the point $\mathbf{a}$. This shows that, for the set of polymatroids of a given combinatorial type, the polymatroid Tutte polynomial $\mathscr{T}_{P}(x, y)$ can be expressed as a certain polynomial in $x, y$ and the $\left(z_{I}\right)$ (by writing it as a sum over the faces of $\mathcal{P}$ ).

As before, we say that a polymatroid $P$ has generic type if the normal fan of $\mathcal{P}$ is the braid arrangement (i.e., $\mathcal{P}$ is combinatorially equivalent to the classical permutohedron). Let $\mathscr{T}_{n}$ be the polynomial corresponding to the Tutte polynomials of polymatroids of generic type. We need to show that $\mathscr{T}_{n}$ specializes to the correct polynomials for all degenerate (i.e., non-generic) polymatroids as well. Since any degenerate polymatroid can be transformed into a generic one by repeatedly taking Minkowski sums with some line segments $\left[\mathbf{e}_{i}, \mathbf{e}_{j}\right]$, it is enough to prove the following claim.

Let $P$ be any polymatroid, and let $\mathcal{P}=\operatorname{conv}(P)$. For $t \in \mathbb{Z}_{>0}$, let $\mathcal{P}(t):=$ $\mathcal{P}+t\left[\mathbf{e}_{i}, \mathbf{e}_{j}\right]$ and $P(t)=\mathcal{P}(t) \cap \mathbb{Z}^{n}$. The above argument shows that the polymatroid Tutte polynomial $\mathscr{T}_{P(t)}(x, y)$ is a polynomial function of $t$ (and $\left.x, y\right)$ for $t \in \mathbb{Z}_{>0}$.
Claim. The specialization of this polynomial at $t=0$ is exactly $\mathscr{T}_{P}(x, y)$.

We now prove this claim. In the limit $t \rightarrow 0$, some faces $\mathcal{F}(t)$ of $\mathcal{P}(t)$ collapse to a face $\mathcal{F}$ of $P$ of dimension one less. We want nonetheless to establish a correspondence between the faces of $\mathcal{P}(t)$ and the faces of $\mathcal{P}$. For this, recall that a face of a polytope $\mathcal{Q} \subset \mathbb{R}^{n}$ is the set of points $\mathcal{F}$ in $\mathcal{Q}$ maximizing a linear functional $\alpha \in\left(\mathbb{R}^{n}\right)^{*}$. From this, it follows that the faces of the Minkowski sum of two polytopes are the Minkowski sums of the appropriate faces of these polytopes. Hence the faces of the Minkowski sum $\mathcal{P}(t)=\mathcal{P}+t\left[e_{i}, e_{j}\right]$ can be partitioned according to the face $\mathcal{F}$ of $\mathcal{P}$ that they correspond to. There are three possible situations, which are illustrated in Figure 5
(a) The face $\mathcal{F}$ is not the maximizer of any functional $\alpha$ such that $\alpha\left(\mathbf{e}_{i}\right)=$ $\alpha\left(\mathbf{e}_{j}\right)$. In this case, we associate to $\mathcal{F}$ the face $\mathcal{F}(t)$ of $\mathcal{P}(t)$ which is the translation of $\mathcal{F}$ by either $t \mathbf{e}_{i}$ (if $\alpha\left(\mathbf{e}_{i}\right)>\alpha\left(\mathbf{e}_{j}\right)$ ) or $t \mathbf{e}_{j}\left(\right.$ if $\left.\alpha\left(\mathbf{e}_{i}\right)<\alpha\left(\mathbf{e}_{j}\right)\right)$.
(b) The face $\mathcal{F}$ is the maximizer of a functional $\alpha$ such that $\alpha\left(\mathbf{e}_{i}\right)=\alpha\left(\mathbf{e}_{j}\right)$, and moreover the affine span of $\mathcal{F}$ contains (lines parallel to) the vector $\mathbf{e}_{i}-\mathbf{e}_{j}$. In this case, we associate to $\mathcal{F}$ the face $\mathcal{F}(t)$ of $\mathcal{P}(t)$ which is the Minkowski $\operatorname{sum} \mathcal{F}+t\left[\mathbf{e}_{i}, \mathbf{e}_{j}\right]$ (which has dimension $\operatorname{dim}(\mathcal{F})$ ).
(c) The face $\mathcal{F}$ is the maximizer of a functional $\alpha$ such that $\alpha\left(\mathbf{e}_{i}\right)=\alpha\left(\mathbf{e}_{j}\right)$, but the affine span of $\mathcal{F}$ does not contain the vector $\mathbf{e}_{i}-\mathbf{e}_{j}$. In this case, we
associate to $\mathcal{F}$ three faces of $\mathcal{P}(t)$, namely $\mathcal{F}_{1}(t)=\mathcal{F}+t \mathbf{e}_{i}, \mathcal{F}_{2}(t)=\mathcal{F}+t \mathbf{e}_{j}$, and $\mathcal{F}_{1,2}(t)=\mathcal{F}+t\left[\mathbf{e}_{i}, \mathbf{e}_{j}\right]$ (the last of which has $\operatorname{dimension} \operatorname{dim}(\mathcal{F})+1$ ).
We now show that in all three cases the contribution, to the Tutte polynomial, of the bases in the interior of the face (or faces) of $\mathcal{P}(t)$ is a polynomial in $t$ which specializes correctly at $t=0$.


Figure 5. The generalized permutahedra $\mathcal{P}$ (left) and $\mathcal{P}(t)=$ $\mathcal{P}+t\left[\mathbf{e}_{1}, \mathbf{e}_{2}\right]$ (right). For each face of $\mathcal{P}$ we indicate if this face corresponds to the situation described in case (a), (b), or (c).

In the cases (a) and (b) the number of lattice points in the interior of $\mathcal{F}(t)$ is a polynomial in $t$ (valid also at $t=0$ ), and any interior lattice points a of $\mathcal{F}(t)$ have the same activity sets $\operatorname{Int}_{P(t)}(\mathbf{a})$ and $\operatorname{Ext}_{P(t)}(\mathbf{a})$ as the interior lattice points of $\mathcal{F}$. Hence the contribution of those interior lattice points is indeed a polynomial function of $t$ valid at $t=0$. It remains to examine the case (c). Let $\mathcal{F}$ be a face of $\mathcal{P}$ of type (c). Let $F^{\circ}, F_{1}^{\circ}(t), F_{2}^{\circ}(t)$, and $F_{1,2}^{\circ}(t)$ be the sets of interior lattice points of $\mathcal{F}, \mathcal{F}_{1}(t), \mathcal{F}_{2}(t)$, and $\mathcal{F}_{1,2}(t)$, respectively. Then for all $t \geq 0$ we have the partition

$$
F_{1}^{\circ}(t) \cup F_{2}^{\circ}(t) \cup F_{1,2}^{\circ}(t)=\biguplus_{\mathbf{a} \in F^{\circ}} L_{\mathbf{a}}(t)
$$

where $L_{\mathbf{a}}(t)=\left(\mathbf{a}+t\left[\mathbf{e}_{i}, \mathbf{e}_{j}\right]\right) \cap \mathbb{Z}^{n}=\left\{\mathbf{a}+t \mathbf{e}_{i}, \mathbf{a}+(t-1) \mathbf{e}_{i}+\mathbf{e}_{j}, \ldots, \mathbf{a}+t \mathbf{e}_{j}\right\}$. Let us now fix $\mathbf{a} \in F^{\circ}$, and see how the contribution of the bases of $P(t)$ along $L_{\mathbf{a}}(t)$ depends on $t$. For a polymatroid $Q \subset \mathbb{Z}^{n}$ and $\mathbf{c} \in Q$, let us put

$$
A_{Q}(\mathbf{c})=\left\{(k, \ell) \in[n]^{2} \mid \mathbf{a}-\mathbf{e}_{k}+\mathbf{e}_{\ell} \in Q\right\}
$$

Note that for all $k \in[n]$, the pair $(k, k)$ is in $A_{Q}(\mathbf{c})$. Note also that $\operatorname{Int}_{Q}(\mathbf{c})=\{k \in$ $\left.[n] \mid \forall \ell<k,(k, \ell) \notin A_{Q}(\mathbf{c})\right\}$, and $\operatorname{Ext}_{Q}(\mathbf{c})=\left\{k \in[n] \mid \forall \ell<k,(\ell, k) \notin A_{Q}(\mathbf{c})\right\}$. We now use three facts.
Fact 1: If $(k, \ell)$ and $(\ell, m)$ belong to $A_{Q}(\mathbf{c})$, then so does $(k, m)$.
In order to prove Fact 1, let us consider the rank function $g$ of $Q$. Assuming $\mathbf{c}-\mathbf{e}_{k}+\mathbf{e}_{\ell} \in Q$ and $\mathbf{c}-\mathbf{e}_{\ell}+\mathbf{e}_{m} \in Q$, it follows that $\mathbf{c}-\frac{\mathbf{e}_{k}}{2}+\frac{\mathbf{e}_{m}}{2} \in \operatorname{conv}(Q)$. This, in turn, implies that for all subsets $I \subset[n]$ containing $m$ but not $k$, we have $\sum_{i \in I} c_{i}<g(I)$. Hence $\mathbf{b}:=\mathbf{c}-\mathbf{e}_{k}+\mathbf{e}_{m}$ satisfies $\sum_{i \in I} b_{i} \leq g(I)$, which shows that $\mathbf{b}$ is in $Q$, as wanted.

Let $A=A_{P}(\mathbf{a})$. For $t>0$ let $B_{1}=A_{P(t)}\left(\mathbf{a}+t \mathbf{e}_{i}\right)$, and $B_{2}=A_{P(t)}\left(\mathbf{a}+t \mathbf{e}_{j}\right)$. We observe that for $s \in[t-1]$, the set $A_{P(t)}\left(\mathbf{a}+s \mathbf{e}_{i}+(t-s) \mathbf{e}_{j}\right)$ does not depend
on $s$ (these points all belong to the interior of $\mathcal{F}(t)$ ), and we denote it by $B_{1,2}$. Let $C_{1}=\{(k, \ell) \mid(k, i),(j, \ell) \in A\}$ and $C_{2}=\{(k, \ell) \mid(k, j),(i, \ell) \in A\}$.
Fact 2: We have $B_{1}=A \cup C_{1}, B_{2}=A \cup C_{2}$, and $B_{1,2}=A \cup C_{1} \cup C_{2}$.
Let us show $B_{1}=A \cup C_{1}$. Using Fact 1, we get $A \cup C_{1} \subseteq B_{1}$ (since $(i, j) \in$ $\left.B_{1}\right)$. We now prove the other inclusion. Let $(k, \ell) \in B_{1}$. In this case, the vector $-\mathbf{e}_{k}+\mathbf{e}_{\ell}$ belongs to the cone generated by $\left\{-\mathbf{e}_{k^{\prime}}+\mathbf{e}_{\ell^{\prime}} \mid\left(k^{\prime}, \ell^{\prime}\right) \in A_{1}\right\}$, where $A_{1}=A \cup\{(i, j)\}$. That is to say, $-\mathbf{e}_{k}+\mathbf{e}_{\ell}=\sum_{\left(k^{\prime}, \ell^{\prime}\right) \in A_{1}} c_{k^{\prime}, \ell^{\prime}}\left(-\mathbf{e}_{k^{\prime}}+\mathbf{e}_{\ell^{\prime}}\right)$, with all the coefficients $c_{k^{\prime}, \ell^{\prime}}$ non-negative. We now fix such an expression of $-\mathbf{e}_{k}+\mathbf{e}_{\ell}$ so that it minimizes the number of non-zero coefficients. Consider the directed graph $D$ with vertex set $[n]$ and arc set $\left\{\left(k^{\prime}, \ell^{\prime}\right) \mid c_{k^{\prime}, \ell^{\prime}}>0\right\}$. The minimality condition ensures that $D$ has no directed cycles. It is easy to see that there exists a directed path from $k$ to $\ell$ in $D$. If the directed path does not use the $\operatorname{arc}(i, j)$, then Fact 1 implies that $(k, \ell) \in A$. If the directed path uses the $\operatorname{arc}(i, j)$, then Fact 1 implies that both $(k, i)$ and $(j, \ell)$ belong to $A$, whence $(k, \ell) \in C_{1}$. Hence $(k, \ell) \in A \cup C_{1}$, which completes the proof of $B_{1}=A \cup C_{1}$. The proof of $B_{2}=A \cup C_{2}$ (resp., $\left.B_{1,2}=A \cup C_{1} \cup C_{2}\right)$ is similar with $A_{1}$ replaced with $A_{2}=A \cup\{(j, i)\}$ (resp., $\left.A_{1,2}=A \cup\{(i, j),(j, i)\}\right)$. This proves Fact 2.

Let $i^{\prime}=\min \{\ell \in[n] \mid(i, \ell) \in A\}, i^{\prime \prime}=\min \{\ell \in[n] \mid(\ell, i) \in A\}, j^{\prime}=\min \{\ell \in$ $[n] \mid(j, \ell) \in A\}$, and $j^{\prime \prime}=\min \{\ell \in[n] \mid(\ell, j) \in A\}$. Let also $K_{1}^{\prime}=\left\{k \in[n] \mid i^{\prime}<\right.$ $k \leq j^{\prime}$ and $\left.(k, j) \in A\right\}$ and $K_{2}^{\prime}=\left\{k \in[n] \mid j^{\prime}<k \leq i^{\prime}\right.$ and $\left.(k, i) \in A\right\}$, as well as $K_{1}^{\prime \prime}=\left\{k \in[n] \mid i^{\prime \prime}<k \leq j^{\prime \prime}\right.$ and $\left.(j, k) \in A\right\}$ and $K_{2}^{\prime \prime}=\left\{k \in[n] \mid j^{\prime \prime}<k \leq\right.$ $i^{\prime \prime}$ and $\left.(i, k) \in A\right\}$.
Fact 3:

- $\operatorname{Int}\left(\mathbf{a}+t \mathbf{e}_{i}\right)=\operatorname{Int}(\mathbf{a}) \backslash K_{2}^{\prime}$ and $\operatorname{Ext}\left(\mathbf{a}+t \mathbf{e}_{i}\right)=\operatorname{Ext}(\mathbf{a}) \backslash K_{1}^{\prime \prime} ;$
- $\operatorname{Int}\left(\mathbf{a}+t \mathbf{e}_{j}\right)=\operatorname{Int}(\mathbf{a}) \backslash K_{1}^{\prime}$ and $\operatorname{Ext}\left(\mathbf{a}+t \mathbf{e}_{i}\right)=\operatorname{Ext}(\mathbf{a}) \backslash K_{2}^{\prime \prime} ;$
- For $\mathbf{b} \in L_{\mathbf{a}}(t) \backslash\left\{\mathbf{a}+t \mathbf{e}_{i}, \mathbf{a}+t \mathbf{e}_{j}\right\}$, we have $\operatorname{Int}(\mathbf{b})=\operatorname{Int}(\mathbf{a}) \backslash\left(K_{1}^{\prime} \cup K_{2}^{\prime}\right)$ and $\operatorname{Ext}(\mathbf{b})=\operatorname{Ext}(\mathbf{a}) \backslash\left(K_{1}^{\prime \prime} \cup K_{2}^{\prime \prime}\right)$.

Fact 3 follows directly from Fact 2 and we leave the details to the reader. By way of illustration, let us observe that if $(k, \ell)$ is in $A$ then $\left(k, i^{\prime}\right) \in A$ and $\left(k, j^{\prime}\right) \in C_{1}$ (in fact $j^{\prime}=\min \left\{\ell \mid(k, \ell) \in C_{1}\right\}$ ).

We can now finish the proof of the Claim. We assume, without loss of generality, that $i^{\prime} \leq j^{\prime}$. Note that this implies $K_{2}^{\prime}=\varnothing$. We now consider two cases and show that the aggregate contribution $w(t)$ of $L_{\mathbf{a}}(t)$ to $\mathscr{T}_{P(t)}$, seen as a polynomial in $t$, specializes correctly at $t=0$ to the contribution $w$ of a to $\mathscr{T}_{P}$.
Case 1: $i^{\prime \prime} \geq j^{\prime \prime}$. In this case, $K_{2}^{\prime}=\varnothing$ and $K_{1}^{\prime \prime}=\varnothing$, hence the contribution of $\mathbf{a}+t \mathbf{e}_{i}$ to $\mathscr{T}_{P(t)}$ is $w$. Moreover, the contributions of the other elements of $L_{\mathbf{a}}(t)$ are all equal; let us denote this common value by $w^{\prime}$. This gives $w(t)=w+t w^{\prime}$, and $w(0)=w$, as wanted.
Case 2: $i^{\prime \prime}<j^{\prime \prime}$. In this case $K_{2}^{\prime}=\varnothing$ and $K_{2}^{\prime \prime}=\varnothing$. First observe that if $K_{1}^{\prime \prime} \cap$ $\operatorname{Ext}_{P}(\mathbf{a})=\varnothing$, then we can reason as in Case 1. Similarly, if $K_{1}^{\prime} \cap \operatorname{Int}_{P}(\mathbf{a})=$ $\varnothing$, then the contribution of $\mathbf{a}+t \mathbf{e}_{j}$ to $\mathscr{T}_{P(t)}$ is $w$, while all the other elements of $L_{\mathbf{a}}(t)$ contribute the same value $w^{\prime}$. Hence in this case we get $w(t)=$ $w+t w^{\prime}$ and $w(0)=w$, as wanted. It remains to consider the case when both $K_{1}^{\prime} \cap \operatorname{Int}_{P}(\mathbf{a})$ and $K_{1}^{\prime \prime} \cap \operatorname{Ext}_{P}(\mathbf{a})$ are non-empty. Let $k^{\prime} \in K_{1}^{\prime} \cap \operatorname{Int}_{P}(\mathbf{a})$ and let $k^{\prime \prime} \in K_{1}^{\prime \prime} \cap \operatorname{Ext}_{P}(\mathbf{a})$. Since $k^{\prime} \in K_{1}^{\prime}$ we have $k^{\prime} \leq j^{\prime}$, and moreover $\left(k^{\prime}, j\right) \in A$ which implies $j^{\prime \prime} \leq k^{\prime}$. Similarly, $k^{\prime \prime} \in K_{1}^{\prime \prime}$ implies $j^{\prime} \leq k^{\prime \prime} \leq j^{\prime \prime}$.

Together this gives $j^{\prime}=j^{\prime \prime}=k^{\prime}=k^{\prime \prime}$. Hence $j^{\prime} \in \operatorname{Int}(\mathbf{a}) \cap \operatorname{Ext}(\mathbf{a})$ and $j^{\prime}$ is the only index which has different activity status for $\mathbf{a}$ and for $\mathbf{b} \in L_{\mathbf{a}}(t)$. Precisely, the contribution of $\mathbf{a}+t \mathbf{e}_{i}$ to $\mathscr{T}_{P(t)}$ is $\frac{x}{x+y-1} w$, the contribution of $\mathbf{a}+t \mathbf{e}_{j}$ is $\frac{y}{x+y-1} w$, and the contribution of any other element of $L_{\mathbf{a}}(t)$ is $\frac{1}{x+y-1} w$. Thus $w(t)=\frac{x+y+(t-1)}{x+y-1} w$, and $w(0)=w$, as wanted.
This completes the proof of the claim, and hence that of the existence of $\mathscr{T}_{n}$.
It only remains to prove that $(n-1)$ ! $\mathscr{T}_{n}$ has integer coefficients and degree $n$. The integrality of the coefficients follows from Corollary 3.11, and the linear relation explained above between the rank function of a polymatroid and that of its faces. Lastly we show that the degree of $\mathscr{T}_{n}$ is $n$. Recall that each $d$-dimensional face $\mathcal{F}$ of a generic permutohedron $\mathcal{P}$ corresponds to an ordered partition $B$ of $[n]$ into $n-d$ blocks. The correspondence is such that the vector $\mathbf{e}_{i}-\mathbf{e}_{j}$ is contained in the affine span of $\mathcal{F}$ if and only if the indices $i, j$ are in the same block of $B$. Consequently, only minimal elements in the blocks can potentially be internally or externally active with respect to a basis a of $P$ in the interior of $\mathcal{F}$ (since $\mathbf{a}+\mathbf{e}_{i}-\mathbf{e}_{j} \in \mathcal{F}$ for all $i, j$ in the same block of $B$ ). Hence the contribution of each basis of $P$ in the interior of $\mathcal{F}$ is a polynomial in $x, y$ of degree at most $d$.

Next we show that the number of bases in the interior of $\mathcal{F}$ is given by a polynomial in the $\left(z_{I}\right)$ of degree at most $d$. By Lemma6.6. the polymatroid $F=\mathcal{F} \cap \mathbb{Z}^{n}$ is a direct sum of $n-d$ polymatroids: $w(F)=P_{1} \oplus \ldots \oplus P_{n-d}$ for some permutation $w$ and polymatroids $P_{1}, \ldots, P_{n-d}$. The number of bases in the interior of $\mathcal{F}$ is $\prod_{i=1}^{n-d}\left|P_{i}^{\circ}\right|$, where $P_{i}^{\circ}$ is the set of lattice points in the relative interior of $\mathcal{P}_{i}=\operatorname{conv}\left(P_{i}\right)$. We have shown above that the values of the rank function $g$ of $w(F)$ are linear functions of the variables $\left(z_{I}\right)$ (which record the values of the rank function of $P$ ). Hence for each $i \in[n-d]$ the values of the rank function $f_{i}$ of $P_{i}$ are linear functions of the $\left(z_{I}\right)$. Finally, by Corollary $3.11,\left|P_{i}^{\circ}\right|$ is a polynomial, in the values of $f_{i}$, of degree $\operatorname{dim}\left(\mathcal{P}_{i}\right)$. Hence the number of bases in the interior of $\mathcal{F}$ is indeed a polynomial in the $\left(z_{I}\right)$ of degree $\prod_{i=1}^{n-d} \operatorname{dim}\left(\mathcal{P}_{i}\right)=\operatorname{dim}(\mathcal{P})=d$. So the contribution of the interior points of the face $\mathcal{F}$ to the polynomial $\mathscr{T}_{n}$ is a polynomial of degree at most $(n-d)+d=n$. The top-dimensional face of the permutohedron contributes a polynomial of degree $n$ to $T_{n}$. So $\mathscr{T}_{n}$ has degree $n$.

This completes the proof of Theorem 6.1.
Let us reformulate Lemmas 4.5 and 4.6, as well as Theorem 4.7, in terms of the universal Tutte polynomial. It is instructive to check these claims against Example 6.4.

Corollary 6.7. The universal Tutte polynomial $\mathscr{T}_{n}\left(x, y,\left(z_{I}\right)\right)$ has the following symmetries:
(1) affine translations: $\mathscr{T}_{n}\left(x, y,\left(z_{I}\right)\right)=\mathscr{T}_{n}\left(x, y,\left(z_{I}+\sum_{i \in I} t_{i}\right)\right)$, for formal variables $t_{1}, \ldots, t_{n}$.
(2) duality: $\mathscr{T}_{n}\left(x, y,\left(z_{I}\right)\right)=\mathscr{T}_{n}\left(y, x,\left(z_{[n] \backslash I}-z_{[n]}\right)\right)$, where we use the convention $z_{\varnothing}=0$.
(3) $S_{n}$-symmetry: $\mathscr{T}_{n}\left(x, y,\left(z_{I}\right)\right)=\mathscr{T}_{n}\left(x, y,\left(z_{w(I)}\right)\right)$, for any $w \in S_{n}$.

Let us mention a couple of additional properties of the universal Tutte polynomial $\mathscr{T}_{n}$ that easily follow from its definition.

Proposition 6.8. (a) The polynomial $\mathscr{T}_{n}$ is divisible by $(x+y-1)$.
(b) The specialization of $\mathscr{T}_{n}\left(x, y,\left(z_{I}\right)\right)$ obtained by setting all the variables $z_{I}$ equal to 0 , is $(x+y-1)^{n}$.
Proof. (a) We derive this property from the fact (cf. part (c) of Proposition 4.11) that any polymatroid Tutte polynomial is divisible by $(x+y-1)$. Consider the polynomial $\widehat{\mathscr{T}}_{n}\left(1-y, y,\left(t_{I}\right)\right)$ defined as in the proof of Theorem 6.1 For any tuple of positive integers $\left(t_{I}\right)$ the evaluation $\widehat{\mathscr{T}}_{n}\left(1-y, y,\left(t_{I}\right)\right)$ is equal to the evaluation of a polymatroid Tutte polynomial at $(x, y)=(1-y, y)$, which is 0 . Hence $\widehat{\mathscr{T}_{n}}(1-$ $\left.y, y,\left(t_{I}\right)\right)=0$. Thus $T_{n}\left(1-y, y,\left(z_{I}\right)\right)=0$, which shows that $T_{n}\left(x, y,\left(z_{I}\right)\right)$ is divisible by $(x+y-1)$.
(b) Let $P$ be the polymatroid with unique basis $(0,0, \ldots, 0) \in \mathbb{Z}^{n}$. It has an identically 0 rank function and satisfies $\mathscr{T}_{P}(x, y)=(x+y-1)^{n}$. Hence $\mathscr{T}_{n}(x, y,(0))=T_{P}(x, y)=(x+y-1)^{n}$.

In the next section we will give an explicit formula for the universal Tutte polynomial. In Sections 9 and 10 we will prove the $S_{n}$-invariance of the polymatroid Tutte polynomial by giving another construction for it which is manifestly $S_{n}$-invariant.

## 7. Formula for the universal Tutte polynomial

In this section, we give an explicit formula for the universal Tutte polynomial. We first recall a definition from [Pos which will play a role in the formula.

Definition 7.1. A function $g: 2^{[n]} \backslash\{\varnothing\} \rightarrow \mathbb{Z}^{\geq 0}$ is $n$-draconian if $\sum_{I \subseteq[n]} g(I)=$ $n-1$ and for any $k>0$ and any collection $I_{1}, \ldots, I_{k}$ of distinct non-empty subsets of $[n]$, we have

$$
\sum_{j=1}^{k} g\left(I_{j}\right) \leq\left|\bigcup_{j=1}^{k} I_{j}\right|-1
$$

The $n$ 'th dragon polynomial $D_{n}$ is the polynomial in the $2^{n}-1$ variables $\left(t_{I}\right)_{\varnothing \neq I \subseteq[n]}$ defined by

$$
D_{n}\left(\left(t_{I}\right)\right)=\sum_{g}\binom{t_{[n]}-1}{g([n])} \prod_{\varnothing \neq I \subsetneq[n]}\binom{t_{I}}{g(I)},
$$

where the sum is over all $n$-draconian functions, and $\binom{t}{k}$ is the polynomial $\frac{1}{k!} t(t-$ 1) $\cdots(t-k+1)$ (with the usual convention $\left.\binom{t}{0}:=1\right)$.

Example 7.2. For $n=1,2,3$ we get $D_{1}=1, D_{2}=t_{\{1,2\}}-1$, and

$$
D_{3}=\frac{1}{2} t_{\{1,2,3\}}^{2}+\left(e_{1}-\frac{3}{2}\right) t_{\{1,2,3\}}+e_{2}-e_{1}+1
$$

where $e_{1}=t_{\{1,2\}}+t_{\{1,3\}}+t_{\{2,3\}}$ and $e_{2}=t_{\{1,2\}} t_{\{1,3\}}+t_{\{1,2\}} t_{\{2,3\}}+t_{\{1,3\}} t_{\{2,3\}}$.
The dragon polynomial is related to the generalized Ehrhart polynomial of permutohedra $E_{n}\left(\left(z_{I}\right)\right)$ defined in Section 3.5. Namely, $D_{n}\left(\left(t_{I}\right)\right)$ is obtained from $E_{n}\left(\left(z_{I}\right)\right)$ by:

$$
\begin{equation*}
D_{n}\left(\left(t_{I}\right)\right)=\left.(-1)^{n-1} E_{n}\left(-\left(z_{I}\right)\right)\right|_{z_{I}=\sum_{J \subseteq[n], J \cap I \neq \varnothing} t_{J}} . \tag{14}
\end{equation*}
$$

Hence, according to Corollary 3.11, the dragon polynomial counts interior points of polymatroids. See Lemma 7.7 below for a precise statement. As we will explain in

Remark 14.5 , the $n$-draconian functions are in bijection with the spanning hypertrees of the hypergraph whose vertex set is $[n]$ and in which each non-empty subset of $[n]$ is a hyperedge. The numbers of $n$-draconian functions for $n=1,2,3,4,5$ are $1,1,7,188$, and 16626 , respectively.

Let $\mathcal{B}_{n}$ be the set of all ordered set partitions of $[n]$, that is, tuples $\left(B_{1}, \ldots, B_{\ell}\right)$ of non-empty disjoint subsets of $[n]$ such that $\biguplus_{i} B_{i}=[n]$. A left-to-right minimum (resp., right-to-left minimum) for $B=\left(B_{1}, \ldots, B_{\ell}\right) \in \mathcal{B}_{n}$ is an integer $m \in[n]$ such that $m=\min \left(\bigcup_{i \leq k} B_{i}\right)$ (resp., $m=\min \left(\bigcup_{i \geq k} B_{i}\right)$ ) for some $k \in[\ell]$.

Theorem 7.3. Let $n$ be a positive integer. Let $\mathscr{T}_{n}\left(x, y,\left(z_{I}\right)_{\varnothing \neq I \subseteq[n]}\right)$ be the universal Tutte polynomial and let $\widehat{\mathscr{T}}_{n}\left(x, y,\left(t_{I}\right)_{\varnothing \neq I \subseteq[n]}\right)$ be the polynomial obtained from $\mathscr{T}_{n}$ by the substitution (11) of Section 6. Then,

$$
\begin{equation*}
\widehat{\mathscr{T}_{n}}\left(x, y,\left(t_{I}\right)\right)=(x+y-1) \sum_{B \in \mathcal{B}_{n}}(-1)^{\ell(B)-1} D_{n}\left(\left(t_{I}^{B}\right)\right) x^{\operatorname{lr}(B)-1} y^{\mathrm{rl}(B)-1} \tag{15}
\end{equation*}
$$

where

- $\mathcal{B}_{n}$ is the set of ordered set partitions of $[n]$ and $D_{n}$ is the $n$ 'th dragon polynomial,
- $\ell(B)$ is the number of blocks of $B \in \mathcal{B}_{n}$, and $\operatorname{lr}(B)$ and $\operatorname{rl}(B)$ are the numbers of left-to-right and right-to-left minima of $B$, respectively; finally,
- for any $B=\left(B_{1}, \ldots, B_{\ell}\right) \in \mathcal{B}_{n}$ and any non-empty set $I \subseteq[n]$,

$$
t_{I}^{B}=\sum_{J \subseteq \bigcup_{i<k} B_{i}} t_{I \cup J}
$$

if $I \subseteq B_{k}$ for some $k \in[\ell]$, and $t_{I}^{B}=0$ if $I$ is contained in none of the subsets $B_{k}$ for $k \in[\ell]$.
The polynomial $\mathscr{T}_{n}\left(x, y,\left(z_{I}\right)\right)$ is obtained from $\widehat{\mathscr{T}}_{n}\left(x, y,\left(t_{I}\right)\right)$ by the substitution 12 .
Remark 7.4. Recall from Remark 6.5 the combinatorial interpretation of the variables $\left(t_{I}\right)$. It follows from Theorem 7.3 that, for any (non-zero) tuple $\mathbf{m}=$ $\left(m_{I}\right)_{\varnothing \neq I \subset[n]}$ of non-negative integers, the polymatroid

$$
\begin{equation*}
Q_{\mathrm{m}}=\mathbb{Z}^{n} \cap \sum_{\varnothing \neq I \subset[n]} m_{I} \Delta_{I} \tag{16}
\end{equation*}
$$

has Tutte polynomial

$$
\begin{equation*}
\mathscr{T}_{Q_{\mathbf{m}}}(x, y)=(x+y-1) \sum_{B \in \mathcal{B}_{n}}(-1)^{\ell(B)-1} D_{n}\left(\left(m_{I}^{B}\right)\right) x^{\operatorname{lr}(B)-1} y^{\mathrm{rl}(B)-1} \tag{17}
\end{equation*}
$$

where, for all nonempty subsets $I \subseteq[n]$,

$$
\begin{equation*}
m_{I}^{B}=\sum_{J \subseteq \bigcup_{i<k} B_{i}} m_{I \cup J} \tag{18}
\end{equation*}
$$

if $I \subseteq B_{k}$ for some $k \in[\ell]$, and $m_{I}^{B}=0$ if $I$ is contained in none of the subsets $B_{k}$ for $k \in[\ell]$.

Example 7.5. For $n=1,2,3$ we get $\frac{\widehat{\mathscr{F}}}{x+y-1}=1$, $\frac{\widehat{\mathscr{F}}}{(x+y-1)}=\left(x+y+t_{\{1,2\}}-1\right)$, and

$$
\begin{aligned}
\frac{\widehat{\mathscr{T}_{3}}}{(x+y-1)}= & x^{2}+2 x y+y^{2}+\left(2 t_{\{1,2,3\}}+e_{1}-2\right) x+\left(t_{\{1,2,3\}}+e_{1}-2\right) y \\
& +\frac{1}{2} t_{123}^{2}+\left(e_{1}-\frac{3}{2}\right) t_{\{1,2,3\}}+e_{2}-e_{1}+1
\end{aligned}
$$

where $e_{1}=t_{\{1,2\}}+t_{\{1,3\}}+t_{\{2,3\}}$, and $e_{2}=t_{\{1,2\}} t_{\{1,3\}}+t_{\{1,2\}} t_{\{2,3\}}+t_{\{1,3\}} t_{\{2,3\}}$.
Remark 7.6. Note that the polynomial $\widehat{\mathscr{T}_{n}}\left(x, y,\left(t_{I}\right)\right)$ only depends on $2^{n}-n+1$ variables: the variables $x, y$ and the variables $t_{I}$ for $I \subseteq[n]$ of cardinality at least 2 . Indeed, the dragon polynomial $D_{n}$ does not depend on $t_{I}$ for $|I| \leq 1$. The fact that $\widehat{\mathscr{T}_{n}}$ is independent of $\left\{t_{\{i\}} \mid i \in[n]\right\}$ simply reflects the invariance of the Tutte polynomial with respect to translations of polymatroids.

The rest of this section is dedicated to the proof of Theorem 7.3 . We want to prove that the polynomial $\widehat{\mathscr{T}_{n}}\left(x, y,\left(t_{I}\right)\right)$ is given by the formula 15 . As can be seen from the proof of Theorem 6.1 (uniqueness of $\mathscr{T}_{n}$ ), it suffices to show that for all tuples $\mathbf{m}=\left(m_{I}\right)_{\varnothing \neq I \subseteq[n]}$ of positive integers, the polymatroid $Q_{\mathbf{m}}$ defined by (16) satisfies (17).

We now fix a tuple $\mathbf{m}=\left(m_{I}\right)_{\varnothing \neq I \subseteq[n]}$ of positive integers and proceed to prove 17). We consider the partition of $Q_{\mathrm{m}}$ according to the faces of $\mathcal{Q}_{\mathrm{m}}$ :

$$
Q_{\mathbf{m}}=\biguplus_{\mathcal{F}: \text { face of } \mathcal{Q}_{\mathbf{m}}} F^{\circ}
$$

where $F^{\circ}:=\mathcal{F}^{\circ} \cap \mathbb{Z}^{n}$ and $\mathcal{F}^{\circ}$ denotes the relative interior of the face $\mathcal{F}$. It remains to count the points in $F^{\circ}$, and to determine their activities.

First, we observe that the polytope $\mathcal{Q}_{\mathrm{m}}$ is a generalized permutohedron with the same combinatorial type as the classical permutohedron $\Pi_{n}$. In other words, the normal fan of $\mathcal{Q}_{\mathbf{m}}$ is the braid arrangement, and its faces are indexed by the ordered set partitions of $[n]$. More precisely, for $B=\left(B_{1}, \ldots, B_{\ell}\right) \in \mathcal{B}_{n}$, we denote by $\mathcal{F}_{B}$ the face of $\mathcal{Q}_{\mathbf{m}}$ maximizing the linear form $\varphi_{B} \in\left(\mathbb{R}^{n}\right)^{*}$ defined by setting $\varphi_{B}\left(\mathbf{e}_{i}\right)=k$ for all $k \in[\ell]$ and all $i \in B_{k}$. Now, we again use the well-known fact that the faces of a Minkowski sum of polytopes correspond to appropriate Minkowski sums of the faces of these polytopes. In our case we get

$$
\mathcal{F}_{B}=\sum_{\varnothing \neq I \subseteq[n]} m_{I} \Delta_{I \cap B_{k(I)}}
$$

where $k(I)=\max \left\{k \in[\ell] \mid I \cap B_{k} \neq \varnothing\right\}$. Reordering the terms gives

$$
\mathcal{F}_{B}=\sum_{\varnothing \neq I \subseteq[n]} m_{I}^{B} \Delta_{I}=\mathcal{Q}_{\mathbf{m}^{B}}
$$

where $\mathbf{m}^{B}=\left(m_{I}^{B}\right)$ is given by 18 .
We now use the following key Lemma, which is a consequence of [PoS, Thm 11.3]. More precisely, combining (14) with Remark 6.5. we can reformulate Corollary 3.11 as follows.

Lemma 7.7. Let $\mathbf{m}^{\prime}=\left(m_{I}^{\prime}\right)_{\varnothing \neq I \subseteq[n]}$ be a tuple of non-negative integers. The number of lattice points in the relative interior of $\mathcal{Q}_{\mathbf{m}^{\prime}}$ is

$$
\left|\mathcal{Q}_{\mathbf{m}^{\prime}}^{\circ} \cap \mathbb{Z}^{n}\right|=(-1)^{\operatorname{codim}\left(\mathcal{Q}_{\mathbf{m}^{\prime}}\right)-1} D_{n}\left(\left(m_{I}^{\prime}\right)\right),
$$

where $D_{n}$ is the $n$ 'th dragon polynomial and $\operatorname{codim}\left(Q_{\mathbf{m}^{\prime}}\right)$ is the codimension of $Q_{\mathbf{m}^{\prime}}$.
Observe that the codimension of the face $\mathcal{F}_{B}=\mathcal{Q}_{\mathbf{m}^{B}}$ is $\ell(B)$ (since the set of linear forms that are maximized on $\mathcal{F}_{B}$ has dimension $\ell$ ). Hence Lemma 7.7 gives $\left|F_{B}^{\circ}\right|=(-1)^{\ell(B)-1} D_{n}\left(m_{I}^{B}\right)$. Next, we determine the activities of the points in $F_{B}^{\circ}$. From Lemma 4.2 we obtain the following.

Lemma 7.8. With the above notation, for all $\mathbf{a} \in F_{B}^{\circ} \subset \mathcal{Q}_{\mathbf{m}}$, the internally active indices of a are the left-to-right minima of $B$, while the externally active indices of a are the right-to-left minima of $B$.

Proof. Recall from Section 3.3 that the polytope $\mathcal{Q}_{\mathrm{m}}$ is the intersection of the halfspaces given by the rank function $f_{\mathbf{m}}$. Precisely, defining for each nonempty subset $I \subseteq[n]$ the sets
$H_{I}=\left\{\mathbf{x} \in \mathbb{R}^{n} \mid \sum_{i \in I} x_{i}=\sum_{J \cap I \neq \varnothing} m_{J}\right\}$ and $H_{I}^{-}=\left\{\mathbf{x} \in \mathbb{R}^{n} \mid \sum_{i \in I} x_{i} \leq \sum_{J \cap I \neq \varnothing} m_{J}\right\}$,
we have

$$
\mathcal{Q}_{\mathbf{m}}=H_{[n]} \cap \bigcap_{\varnothing \neq I \subset[n]} H_{I}^{-}
$$

Moreover, the face $\mathcal{F}_{B}$ is the intersection of $\mathcal{Q}_{\mathbf{m}}$ with the hyperplanes $H_{B_{\ell}}, H_{B_{\ell-1} \cup B_{\ell}}$, $\ldots, H_{B_{1} \cup B_{2} \cup \ldots \cup B_{\ell}}$, but is not contained in any other hyperplane $H_{I}$ (since it has codimension $\ell$ ).

By Lemma 7.8 , for any $\mathbf{a} \in Q_{\mathbf{m}}$, the index $i \in[n]$ is externally (resp., internally) active if and only if there exists a subset $I \subseteq[n]$ such that $i=\min (I)$ and $\mathbf{a} \in H_{I}$ (resp., $a \in H_{[n] \backslash I}$ ). Hence for $\mathbf{a} \in F_{B}^{\circ}$ the externally (resp., internally) active indices are the right-to-left (resp., left-to-right) minima of $B$.

To summarize, each element $\mathbf{a} \in F_{B}^{\circ}$ contributes $(x+y-1) x^{\operatorname{lr}(B)-1} y^{\mathrm{rl}(B)-1}$ to the Tutte polynomial of $Q_{\mathrm{m}}$ (since 1 is the only index which is both internally and externally active), so that their total contribution is

$$
(-1)^{\ell(B)-1} D_{n}\left(\left(m_{I}^{B}\right)\right)(x+y-1) x^{\operatorname{lr}(B)-1} y^{\mathrm{rl}(B)-1}
$$

Summing over all ordered set partitions of $[n]$ gives 16 , which concludes the proof of Theorem 7.3
8. Proofs of Lemma 4.2, Corollary 4.9, and Propositions 4.11 and 5.4

In this section we prove Lemma 4.2, Corollary 4.9, and Propositions 4.11 and 5.4. Before we embark on these proofs, let us set some notation and recall an easy fact. For a basis a of a polymatroid $P \subset \mathbb{Z}^{n}$ with rank function $f$, we denote

$$
\begin{equation*}
\mathcal{I}(\mathbf{a}) \equiv \mathcal{I}_{P}(\mathbf{a})=\left\{I \subset[n] \mid \sum_{i \in I} a_{i}=f(I)\right\} \tag{19}
\end{equation*}
$$

(Elements of $\mathcal{I}(\mathbf{a})$ were called 'tight at $\mathbf{a}$ ' in Kal].) Note that by convention $\varnothing,[n] \in$ $\mathcal{I}(\mathbf{a})$. We now observe that for all $I, J \in \mathcal{I}(\mathbf{a})$, both $I \cup J$ and $J \cap J$ are also in $\mathcal{I}(\mathbf{a})$. This is because $f$ is submodular while $\sum_{i \in I} a_{i}+\sum_{i \in J} a_{i}=\sum_{i \in I \cup J} a_{i}+\sum_{i \in I \cap J} a_{i}$.

Proof of Lemma 4.2. We first prove the statement about external activities. Let $\mathbf{a} \in P$. We want to prove that $\operatorname{Ext}(\mathbf{a})=\{\min (I) \mid I \in \mathcal{I}(\mathbf{a})\}$.

Suppose first that there exists $I \in \mathcal{I}(\mathbf{a})$ such that $i=\min (I)$. Then for all $j<i$ the point $\mathbf{b}:=\mathbf{a}-\mathbf{e}_{j}+\mathbf{e}_{i}$ is not in $P$ because $\sum_{i \in I} b_{i}>f(I)$. Hence $i$ is externally active for $\mathbf{a}$.

Conversely, suppose that there does not exist a subset $I \in \mathcal{I}(\mathbf{a})$ such that $i=$ $\min (I)$. Consider the set $\mathcal{I}^{\prime}=\{I \in \mathcal{I}(\mathbf{a}) \mid i \in I\}$. There is a smallest element $I_{0}$ of $\mathcal{I}^{\prime}$ for inclusion (indeed if $I, J \in \mathcal{I}^{\prime}$, then $I \cap J \in \mathcal{I}^{\prime}$ ). By our assumption, there exists $j<i$ in $I_{0}$. Hence $j$ is contained in every subset $I \in \mathcal{I}^{\prime}$. This implies that $\mathbf{a}-\mathbf{e}_{j}+\mathbf{e}_{i} \in P$, in particular that $i$ is not externally active.

This proves the statement about external activities. The one about internal activities follows by duality upon observing that $\operatorname{Int}_{P}(\mathbf{a})=\operatorname{Ext}_{-P}(-\mathbf{a})$ and that the rank function of $-P$ is $I \mapsto f([n] \backslash I)-f([n])$ (so that $\mathcal{I}_{-P}(-\mathbf{a})=\{[n] \backslash I \mid$ $\left.\left.I \in \mathcal{I}_{P}(\mathbf{a})\right\}\right)$.

Proof of Corollary 4.9. Let $P \subset \mathbb{Z}^{n}$ be a polymatroid of generic type, and let $f$ be its rank function. We claim that for all $\mathbf{a} \in P$, one has $\operatorname{Int}(\mathbf{a}) \cap \operatorname{Ext}(\mathbf{a})=\{1\}$. Suppose for contradiction that $m>1$ is in $\operatorname{Int}(\mathbf{a}) \cap \operatorname{Ext}(\mathbf{a})$. By Lemma 4.2, there exist $I, J \in \mathcal{I}(\mathbf{a})$ such that $m=\min (I)=\min ([n] \backslash J)$. However, this implies that $f(I)+f(J)=f(I \cup J)+f(I \cap J)$, while neither $I \subseteq J$ (for $m \in I \backslash J)$ nor $J \subseteq I$ (as $1 \in J \backslash I$ ). This is impossible for a polymatroid of generic type.

Proof of Proposition 4.11. Throughout we denote the rank function of $P$ by $f$.
(a) It is clear from Definition 4.3 that $\mathscr{T}_{P}(x, y)$ is a polynomial of degree at most $n$. The fact that the degree of $\mathscr{T}_{P}(x, y)$ is exactly $n$ can be deduced by picking the lexicographically minimal basis $\mathbf{a}_{\min }$ of $P$ and observing that any index $i \in[n]$ is externally active with respect to $\mathbf{a}_{\text {min }}$.
(b) It is clear from the definition that both $\mathscr{T}_{P}(x, y+1)$ and $\mathscr{T}_{P}(x+1, y)$ have non-negative integer coefficients. We now show that $\mathscr{T}_{P}(x, y)$ has both positive and negative coefficients. Suppose for contradiction that all the coefficients have the same sign. In this case the formal power series $\sum_{k=0}^{\infty} \mathscr{T}_{P}(x, y)(x+y)^{k}$ has infinite degree. However this is equal to the formal power series $(1-x-y)^{-1} \mathscr{T}_{P}(x, y)$, which is a polynomial since $\mathscr{T}_{P}(x, y)$ is divisible by $(x+y-1)$. A contradiction.
(c) Recall that by Lemma 6.6, a polymatroid $P$ of codimension $c$ is a direct sum of $c$ polymatroids. Hence by property (e) (proved below) and the $S_{n}$-invariance of $T_{P}$ (proved later), $\mathscr{T}_{P}(x, y)$ is a product of $c$ polymatroid Tutte polynomials. This proves the property since every polymatroid Tutte polynomial is divisible by $(x+y-1)$.
(d) Since the universal polynomial $\mathscr{T}_{n}\left(x, y,\left(z_{I}\right)\right)$ has total degree $n$, we have

$$
\begin{aligned}
{\left[x^{k} y^{n-k}\right] \mathscr{T}_{P}(x, y)=\left[x^{k} y^{n-k}\right] } & \mathscr{T}_{n}\left(x, y,\left(z_{I}\right)\right) \\
& =\left[x^{k} y^{n-k}\right] \mathscr{T}_{n}(x, y,(0))=\left[x^{k} y^{n-k}\right](x+y-1)^{n}
\end{aligned}
$$

where the last equality comes from Proposition 6.8 (b).
(e) Let $Q \subset \mathbb{Z}^{n}$ be a polymatroid. It is clear that for any $\mathbf{c} \in P \oplus Q$ there is a unique pair $(\mathbf{a}, \mathbf{b}) \in P \times Q$ such that $\mathbf{c}=\left(a_{1}, \ldots, a_{n}, b_{1}, \ldots, b_{m}\right)$. Moreover for
$i, j \in[n+m]$, the point $\mathbf{c}+\mathbf{e}_{i}-\mathbf{e}_{j}$ is in $P \oplus Q$ if and only if either $(i, j \leq n$ and $\left.\mathbf{a}+\mathbf{e}_{i}-\mathbf{e}_{j} \in P\right)$ or $\left(i, j>n\right.$ and $\left.\mathbf{b}+\mathbf{e}_{i-n}-\mathbf{e}_{j-n} \in Q\right)$. This implies $\operatorname{Int}_{P \oplus Q}(\mathbf{c})=\operatorname{Int}_{P}(\mathbf{a}) \cup\left(n+\operatorname{Int}_{Q}(\mathbf{b})\right)$ and $\operatorname{Ext}_{P \oplus Q}(\mathbf{c})=\operatorname{Ext}_{P}(\mathbf{a}) \cup\left(n+\operatorname{Ext}_{Q}(\mathbf{b})\right)$ Hence,

$$
\begin{aligned}
\mathscr{T}_{P \oplus Q}(x, y) & =\sum_{\mathbf{c} \in P \oplus Q} x^{\mathrm{oi}(\mathbf{c})} y^{\mathrm{oe}(\mathbf{c})}(x+y-1)^{\mathrm{ie}(\mathbf{c})} \\
& =\sum_{(\mathbf{a}, \mathbf{b}) \in P \times Q} x^{\mathrm{oi}(\mathbf{a})+\mathrm{oi}(\mathbf{b})} y^{\mathrm{oe}(\mathbf{a})+\mathrm{oe}(\mathbf{b})}(x+y-1)^{\mathrm{ie}(\mathbf{a})+\mathrm{ie}(\mathbf{b})} \\
& =\mathscr{T}_{P}(x, y) \mathscr{T}_{Q}(x, y) .
\end{aligned}
$$

Similarly for any $\mathbf{c} \in P \boxplus Q$ there is a unique pair $(\mathbf{a}, \mathbf{b}) \in P \times Q$ such that $\mathbf{c}=\left(a_{1}+b_{1}, a_{2}, \ldots, a_{n}, b_{2}, \ldots, b_{m}\right)$. (The decomposition of $c_{1}$ is determined by the levels of $P$ and $Q$.) Moreover for $1 \leq i<j \leq n+m-1$, the point $\mathbf{c}+\mathbf{e}_{i}-\mathbf{e}_{j}$ is in $P \boxplus Q$ if and only if either $\left(i, j \leq n\right.$ and $\left.\mathbf{a}+\mathbf{e}_{i}-\mathbf{e}_{j} \in P\right)$, or $(i, j>n$ and $\mathbf{b}+\mathbf{e}_{i+1-n}-\mathbf{e}_{j+1-n} \in Q$ ), or $\left(i \leq n<j\right.$ and $\mathbf{a}-\mathbf{e}_{1}+\mathbf{e}_{i} \in P$ and $\left.\mathbf{a}+\mathbf{e}_{1}-\mathbf{e}_{j+1-n} \in Q\right)$. This implies $\operatorname{Int}_{P \boxplus Q}(\mathbf{c})=\operatorname{Int}_{P}(\mathbf{a}) \cup\left\{n+i-1 \mid i \in \operatorname{Int}_{Q}(\mathbf{b}) \backslash\{1\}\right\}$. Similarly, $\operatorname{Ext}_{P \boxplus Q}(\mathbf{c})=\operatorname{Ext}_{P}(\mathbf{a}) \cup\left\{n+i-1 \mid i \in \operatorname{Ext}_{Q}(\mathbf{b}) \backslash\{1\}\right\}$. Consequently,

$$
\begin{aligned}
\mathscr{T}_{P \boxplus Q}(x, y) & =\sum_{(\mathbf{a}, \mathbf{b}) \in P \times Q} x^{\mathrm{oi}(\mathbf{a})+\mathrm{oi}(\mathbf{b})} y^{\mathrm{oe}(\mathbf{a})+\mathrm{oe}(\mathbf{b})}(x+y-1)^{\mathrm{ie}(\mathbf{a})+\mathrm{ie}(\mathbf{b})-1} \\
& =\frac{\mathscr{T}_{P}(x, y) \mathscr{T}_{Q}(x, y)}{x+y-1}
\end{aligned}
$$

(f) It is easy to verify that $\widehat{P}^{i}$ in the $r_{i}=0$ case, as well as $P \backslash i$ and $P / i$ in the $r_{i}=1$ case, are polymatroids. See Section 18.2 for more on the underlying geometry.

By the $S_{n}$-invariance of $\mathscr{T}_{P}$ we may assume $i=n$. In the case $r_{n}=0$ we have $P=\widehat{P}^{n} \oplus Q$, where $Q$ is the matroid in $\mathbb{Z}$ with unique basis $\mathbf{a}=f(\{n\})$. Hence (5) follows from property (e).

In the case $r_{n}=1$, any basis $\mathbf{a} \in P$ satisfies $a_{n} \in\{f(\{n\})-1, f(\{n\})\}$. Hence every basis of $P$ corresponds either to a basis of $P \backslash n$ (if $a_{n}=f(\{n\})-1$ ) or to a basis of $P / n$ (if $\left.a_{n}=f(\{n\})\right)$. If $a_{n}=f(\{n\})-1$, then it is clear that $n \in \operatorname{Int}_{P}(\mathbf{a})$, and the Exchange axiom easily implies that $n \notin \operatorname{Ext}_{P}(\mathbf{a})$. As to the other indices, the internal or external activity with respect to $\mathbf{a} \in P$ is the same as with respect to $\widehat{\mathbf{a}}^{n} \in P \backslash n$.

To summarize, if $a_{n}=f(\{n\})-1$, then $\operatorname{Int}_{P}(\mathbf{a})=\operatorname{Int}_{P \backslash n}\left(\widehat{\mathbf{a}}^{n}\right) \cup\{n\}$ and $\operatorname{Ext}_{P}(\mathbf{a})=\operatorname{Ext}_{P \backslash n}\left(\widehat{\mathbf{a}}^{n}\right)$. Similarly, if $a_{n}=f(\{n\})$, then $\operatorname{Int}_{P}(\mathbf{a})=\operatorname{Int}_{P / n}\left(\widehat{\mathbf{a}}^{n}\right)$ and $\operatorname{Ext}_{P}(\mathbf{a})=\operatorname{Ext}_{P / n}\left(\widehat{\mathbf{a}}^{n}\right) \cup\{n\}$. This gives (6).
(g) The property $\mathscr{T}_{P}(1,1)=|P|$ is clear from the definition. We now prove $\mathscr{T}_{P}(0,0)=(-1)^{\operatorname{codim}(P)}\left|P^{\circ}\right|$, where $P^{\circ}=\mathcal{P}^{\circ} \cap \mathbb{Z}^{n}$. By property (e), it suffices to do so when $\operatorname{codim}(P)=1$, so we assume this condition from now on. Also, by definition

$$
\mathscr{T}_{P}(0,0)=\sum_{\mathbf{a} \in P: \operatorname{Int}(\mathbf{a}) \triangle \operatorname{Ext}(\mathbf{a})=\varnothing}(-1)^{\operatorname{Int}(\mathbf{a}) \cap \operatorname{Ext}(\mathbf{a})}
$$

where $A \triangle B:=(A \backslash B) \cup(B \backslash A)$ denotes the symmetric difference of the sets $A$ and $B$. Hence it suffices to show that for all $\mathbf{a} \in P$, we have $\mathbf{a} \in P^{\circ}$ if and only if $\operatorname{Int}(\mathbf{a}) \triangle \operatorname{Ext}(\mathbf{a})=\varnothing$; furthermore in this case $\operatorname{Int}(\mathbf{a})=\operatorname{Ext}(\mathbf{a})=\{1\}$.

Let us prove this property. For $I \subseteq[n]$, we consider the hyperplane $H_{I}=\{\mathbf{x} \in$ $\left.\mathbb{Z}^{n} \mid \sum_{i \in I} x_{i}=f(I)\right\}$. Let us first assume $\mathbf{a} \in P^{\circ}$. This implies $\mathbf{a} \notin \bigcup_{\varnothing \neq I \subsetneq[n]} H_{I}$,
in particular for all $i, j \in[n]$, we have $\mathbf{a}+\mathbf{e}_{i}-\mathbf{e}_{j} \in P$. Thus $\operatorname{Int}(\mathbf{a})=\operatorname{Ext}(\mathbf{a})=\{1\}$, and $\operatorname{Int}(\mathbf{a}) \triangle \operatorname{Ext}(\mathbf{a})=\varnothing$.

Conversely, we now assume that $\mathbf{a} \in P \backslash P^{\circ}$, and want to prove $\operatorname{Int}(\mathbf{a}) \triangle \operatorname{Ext}(\mathbf{a}) \neq$ $\varnothing$. By Lemma 4.2, we have $\operatorname{Ext}(\mathbf{a})=\{\min (I) \mid \varnothing \neq I \in \mathcal{I}(\mathbf{a})\}$ and $\operatorname{Int}(\mathbf{a})=$ $\{\min ([n] \backslash I) \mid[n] \neq I \in \mathcal{I}(\mathbf{a})\}$. Since $\mathbf{a} \notin P^{\circ}$, there exists a set $I_{0} \in \mathcal{I}(\mathbf{a})$ which is neither empty nor equal to $[n]$. Hence $\max (\operatorname{Int}(\mathbf{a}) \cup \operatorname{Ext}(\mathbf{a}))>1$. Therefore, if $m:=\max (\operatorname{Int}(\mathbf{a}) \cap \operatorname{Ext}(\mathbf{a}))$ is equal to 1 , then $\operatorname{Int}(\mathbf{a}) \triangle \operatorname{Ext}(\mathbf{a}) \neq \varnothing$. Let us now assume $m>1$, and consider $I, J \in \mathcal{I}(\mathbf{a})$ such that $m=\min (I)=\min ([n] \backslash J)$. We have $I \neq[n] \backslash J$ (otherwise $P \subset H_{I}$ and $\operatorname{codim}(P)>1$ ), whence we get $I \cap J \neq \varnothing$ or $I \cup J \neq[n]$. Moreover, both $I \cap J$ and $I \cup J$ are in $\mathcal{I}(\mathbf{a})$. If $I \cap J \neq \varnothing$, then $k:=\min (I \cap J)>m$ and thus $k \in \operatorname{Ext}(\mathbf{a}) \triangle \operatorname{Int}(\mathbf{a})$. Similarly, if $I \cup J \neq[n]$, then $k:=\min ([n] \backslash(I \cup J))>m$, implying $k \in \operatorname{Int}(\mathbf{a}) \triangle \operatorname{Ext}(\mathbf{a})$. In both cases we obtain $\operatorname{Int}(\mathbf{a}) \triangle \operatorname{Ext}(\mathbf{a}) \neq \varnothing$, as wanted.
(h) It suffices to prove $\left.\frac{\mathscr{T}_{P}(x, y)}{(x+y-1)}\right|_{x=1, y=0}=\left|(\mathcal{P}-\Delta) \cap \mathbb{Z}^{n}\right|$, as the other identity follows by duality. Let $\mathcal{A}=\{\mathbf{a} \in P \mid \operatorname{Ext}(\mathbf{a})=\{1\}\}$ and let $\mathcal{B}=\left\{\mathbf{a} \in \mathbb{Z}^{n} \mid\right.$ $\left.\mathbf{a}-\mathbf{e}_{1}+\Delta \subseteq \mathcal{P}\right\}$. Clearly, $\left.\frac{\mathscr{T}_{P}(x, y)}{(x+y-1)}\right|_{x=1, y=0}=|\mathcal{A}|$, and $\left|(\mathcal{P}-\Delta) \cap \mathbb{Z}^{n}\right|=|\mathcal{B}|$, so it suffices to prove $\mathcal{A}=\mathcal{B}$.

For $i \in\{2,3, \ldots, n\}$, let $\mathcal{A}_{i}=\left\{a \in P \mid \exists j<i, \mathbf{a}+\mathbf{e}_{i}-\mathbf{e}_{j} \in P\right\}$ and $\mathcal{B}_{i}=\{\mathbf{a} \in$ $\left.P \mid \mathbf{a}+\mathbf{e}_{i}-\mathbf{e}_{1} \in P\right\}$. It is easy to see that $\mathcal{B}=\bigcap_{i=2}^{n} \mathcal{B}_{i} \subseteq \bigcap_{i=2}^{n} \mathcal{A}_{i}=\mathcal{A}$.

We now prove, by induction on $k$, that for all $k \in\{2,3, \ldots, n\}$, we have $\bigcap_{i=2}^{k} \mathcal{A}_{i} \subseteq$ $\bigcap_{i=2}^{k} \mathcal{B}_{i}$. The base case $k=2$ is trivial, and we now assume $\bigcap_{i=2}^{k-1} \mathcal{A}_{i} \subseteq \bigcap_{i=2}^{k-1} \mathcal{B}_{i}$. Let $\mathbf{a} \in \bigcap_{i=2}^{k} \mathcal{A}_{i}$. We need to prove that $\mathbf{b}=\mathbf{a}+\mathbf{e}_{k}-\mathbf{e}_{1}$ is in $P$. Since $\mathbf{a} \in \mathcal{A}_{k}$, there exists $j<k$ such that $\mathbf{a}+\mathbf{e}_{k}-\mathbf{e}_{j} \in P$. As $\mathbf{a} \in \bigcap_{i=2}^{k-1} \mathcal{A}_{i} \subseteq \bigcap_{i=2}^{k-1} \mathcal{B}_{i}$, we get $\mathbf{a}+\mathbf{e}_{j}-\mathbf{e}_{1} \in P$. Hence, by convexity, $\mathbf{a}+\frac{\mathbf{e}_{k}-\mathbf{e}_{1}}{2} \in \mathcal{P}$. This, in turn, implies that for all subsets $I \subset[n]$ containing $k$ but not 1 , we have $\sum_{i \in I} a_{i}<f(I)$. Thus we also have $\sum_{i \in I} b_{i} \leq f(I)$, which implies that $\mathbf{b}$ is in $P$, as wanted.

Proof of Proposition 5.4. It is clear that $T_{P}(x, y)$ is a Laurent polynomial since the degree of $\mathscr{T}_{P}(x, y)$ is $n$. Let us denote $b_{p, q}=\left[x^{p} y^{q}\right] B(x, y) T_{P}(x,-1 / y)$. Observe that for all integers $p, q$,

$$
\begin{aligned}
b_{p, q}-b_{p-1, q-1}-b_{p-1, q} & =\left[x^{p} y^{q}\right](1-x(1+y)) B(x, y) T_{P}(x,-1 / y) \\
& =\left[x^{p} y^{q}\right] T_{P}(x,-1 / y)
\end{aligned}
$$

The right-hand side of the above equation is equal to 0 whenever $q>-\ell$, since $\ell$ is the minimum $y$-degree of $T_{P}(x, y)$. Thus, if for a given $k \in \mathbb{Z}$ one has $b_{k+q, q}=0$ for all $q \geq-\ell$, then $b_{k+1+q, q}=b_{k+q, q-1}$ for all $q>-\ell$. Hence in this case the coefficients $b_{k+1+q, q}$ for $q \geq-\ell$ are all equal. Since for $k$ sufficiently small one has $b_{k+q, q}=0$ for all $q$, there exists an integer $k_{0} \in \mathbb{Z} \cup\{+\infty\}$ and a constant $c \neq 0$ such that for all $q \geq-\ell$ one has $b_{p, q}=0$ for all $p<k_{0}+q$ and $b_{k_{0}+q, q}=c$.

It remains to show that $k_{0}=n$ and $c=(-1)^{n-d}$. Since $\ell \geq-d$, it suffices to show

$$
\begin{equation*}
\forall p<n, b_{p+d, d}=0, \text { and } b_{n+d, d}=(-1)^{n-d} \tag{20}
\end{equation*}
$$

Let us denote $\tau_{i, j}=\left[x^{i} y^{j}\right] \mathscr{T}_{P}(x, y)$, so that

$$
T_{P}(x, y)=\sum_{i, j \geq 0} \tau_{i, j} x^{i+d-n} y^{j-d}(x+y-x y)^{n-i-j}
$$

One gets

$$
B(x, y) T_{P}(x,-1 / y)=\sum_{i, j \geq 0} \tau_{i, j}(-x y)^{i+d-n}(1-x-x y)^{n-i-j-1}
$$

Hence

$$
b_{p+d, d}=(-1)^{d} \sum_{i, j \geq 0} \tau_{i, j}(-1)^{n-i}\left[x^{p+n-i} y^{n-i}\right](1-x-x y)^{n-i-j-1}
$$

Note that for $i+j<n,\left[x^{p+n-i} y^{n-i}\right](1-x-x y)^{n-i-j-1}=0$, and that for $i+j>n$, $\tau_{i, j}=0$. Moreover, by Proposition 4.11 (d), $\tau_{n-j, j}=\binom{n}{j}$. Thus,

$$
b_{p+d, d}=(-1)^{d} \sum_{j=0}^{n}\binom{n}{j}(-1)^{j}\left[x^{p+j} y^{j}\right](1-x-x y)^{-1}
$$

For $p<0,\left[x^{p+j} y^{j}\right](1-x-x y)^{-1}=0$, hence $b_{p+d, d}=0$. For $p \geq 0,\left[x^{p+j} y^{j}\right](1-$ $x-x y)^{-1}=\binom{p+j}{j}$, hence

$$
\begin{aligned}
b_{p+d, d} & =(-1)^{d} \sum_{j=0}^{n}\binom{n}{j}(-1)^{j}\binom{p+j}{j} \\
& =(-1)^{d} \sum_{j=0}^{n}\left[x^{n-j}\right](1+x)^{n} \cdot\left[x^{j}\right](1+x)^{-p-1} \\
& =(-1)^{d}\left[x^{n}\right](1+x)^{n-p-1}
\end{aligned}
$$

This readily gives 20 .

## 9. Decomposition of the integer lattice into cones

In this section we describe, for a (not necessarily finite) M-convex set $P \subset \mathbb{Z}^{n}$, a decomposition of the integer lattice $\mathbb{Z}^{n}$ into a disjoint union of cones indexed by the elements of $P$. We will use this cone decomposition in the next section to give another characterization of the polymatroid Tutte polynomial, and prove the $S_{n}$-invariance stated in Theorem 4.7 .

Definition 9.1. Let $P \subset \mathbb{Z}^{n}$ be an M-convex set. For a $\in P$, define the cone $C(\mathbf{a})=C_{P}(\mathbf{a}) \subset \mathbb{Z}^{n}$ to consist of all points $\mathbf{a}+\mathbf{x} \in \mathbb{Z}^{n}$ such that, for any $i \in[n]$,
(1) if $i \notin \operatorname{Int}(\mathbf{a})$ and $i \notin \operatorname{Ext}(\mathbf{a})$, then $x_{i}=0$;
(2) if $i \in \operatorname{Int}(\mathbf{a})$ and $i \notin \operatorname{Ext}(\mathbf{a})$, then $x_{i} \leq 0$;
(3) if $i \notin \operatorname{Int}(\mathbf{a})$ and $i \in \operatorname{Ext}(\mathbf{a})$, then $x_{i} \geq 0$;
(4) if $i \in \operatorname{Int}(\mathbf{a})$ and $i \in \operatorname{Ext}(\mathbf{a})$, then $x_{i}$ can be any integer.

We now define the Manhattan distance on $\mathbb{Z}^{n}$ before stating the main result.
Definition 9.2. The Manhattan distance $d_{1}(\mathbf{a}, \mathbf{b})$ between two points $\mathbf{a}, \mathbf{b} \in \mathbb{R}^{n}$ is

$$
d_{1}(\mathbf{a}, \mathbf{b})=\|\mathbf{a}-\mathbf{b}\|_{1}:=\sum_{i=1}^{n}\left|a_{i}-b_{i}\right|
$$

For two subsets $A$ and $B$ of $\mathbb{Z}^{n}$, define

$$
d_{1}(A, B):=\min _{\mathbf{a} \in A, \mathbf{b} \in B} d_{1}(\mathbf{a}, \mathbf{b})
$$

Theorem 9.3. Let $P \subset \mathbb{Z}^{n}$ be a nonempty $M$-convex set.
(1) The collection of cones $C(\mathbf{a})=C_{P}(\mathbf{a})$, for $\mathbf{a}$ in $P$, gives a disjoint decomposition of $\mathbb{Z}^{n}$ :

$$
\biguplus_{\mathbf{a} \in P} C_{P}(\mathbf{a})=\mathbb{Z}^{n} .
$$

(2) If $\mathbf{a} \in P$ and $\mathbf{c} \in C(\mathbf{a})$, then $d_{1}(\mathbf{a}, \mathbf{c})=d_{1}(P, \mathbf{c})$. In other words, the point $\mathbf{a}$ is one of the points of $P$ closest to the point $\mathbf{c}$ with respect to the Manhattan distance.

Remark 9.4. Theorem 9.3 is the analogue, for M-convex sets, of a classical result about the Tutte polynomial of matroids due to Crapo [Cr2]. Indeed, for a matroid $M$ defined on the ground set $[n]$, one can consider the restriction of the conedecomposition given by Theorem 9.3 to the subset $\{0,1\}^{n} \subset \mathbb{Z}^{n}$. This translates into a partition of the Boolean lattice $\left(2^{[n]}, \subseteq\right)$ into intervals indexed by the bases of $M$, which is exactly the partition exhibited in [r2].

Proof. Let us first show that the cones $C(\mathbf{a})$ and $C(\mathbf{b})$, for two different elements $\mathbf{a}, \mathbf{b} \in P$, are disjoint. Suppose that this is not true, and there is $\mathbf{c} \in C(\mathbf{a}) \cap C(\mathbf{b})$. Let $i$ be the maximal index such that $a_{i} \neq b_{i}$. Without loss of generality, assume that $a_{i}<b_{i}$. According to the Exchange Axiom, there exists $j$ such that $a_{j}>b_{j}$ and $\mathbf{a}+\mathbf{e}_{i}-\mathbf{e}_{j} \in P$ and $\mathbf{b}-\mathbf{e}_{i}+\mathbf{e}_{j} \in P$. Because of our choice of $i$, we have $j<i$. Thus $i \notin \operatorname{Ext}(\mathbf{a})$ and $i \notin \operatorname{Int}(\mathbf{b})$. Hence $c_{i} \leq a_{i}$ and $c_{i} \geq b_{i}$. We reach a contradiction since $a_{i}<b_{i}$.

Next, let us show that, for any $\mathbf{c} \in \mathbb{Z}^{n}$, there exists $\mathbf{a} \in P$ such that $\mathbf{c} \in C(\mathbf{a})$. Pick any element $\mathbf{a}^{\prime} \in P$. We say that an index $i$ is bad for $\mathbf{a}^{\prime}$ (with respect to $\mathbf{c}$ ) if we have either $\left(a_{i}^{\prime}<c_{i}\right.$ and $\left.i \notin \operatorname{Ext}\left(\mathbf{a}^{\prime}\right)\right)$, or $\left(a_{i}^{\prime}>c_{i}\right.$ and $\left.i \notin \operatorname{Int}\left(\mathbf{a}^{\prime}\right)\right)$.

If there is no bad index for $\mathbf{a}^{\prime}$, then $\mathbf{c} \in C\left(\mathbf{a}^{\prime}\right)$ and we are done. Otherwise, let $i$ be the maximal bad index. If $a_{i}^{\prime}<c_{i}$, then $i \notin \operatorname{Ext}\left(\mathbf{a}^{\prime}\right)$, hence there exists $j<i$ such that $\mathbf{a}^{\prime \prime}:=\mathbf{a}^{\prime}+\mathbf{e}_{i}-\mathbf{e}_{j} \in P$. If $a_{i}^{\prime}>c_{i}$, then $i \notin \operatorname{Int}\left(\mathbf{a}^{\prime}\right)$, hence there exists $j<i$ such that $\mathbf{a}^{\prime \prime}:=\mathbf{a}^{\prime}-\mathbf{e}_{i}+\mathbf{e}_{j} \in P$.

We now show that $\mathbf{a}^{\prime \prime}$ has no bad index greater than $i$ (with respect to $\mathbf{c}$ ). For $k>i$ we know that $a_{k}^{\prime \prime}=a_{k}^{\prime}$ and want to show that $k$ is not a bad index for $\mathbf{a}^{\prime \prime}$. It suffices to show that if $k \notin \operatorname{Ext}\left(\mathbf{a}^{\prime \prime}\right)$ then $k \notin \operatorname{Ext}\left(\mathbf{a}^{\prime}\right)$, and if $k \notin \operatorname{Int}\left(\mathbf{a}^{\prime \prime}\right)$ then $k \notin$ $\operatorname{Int}\left(\mathbf{a}^{\prime}\right)$. Suppose that $k \notin \operatorname{Ext}\left(\mathbf{a}^{\prime \prime}\right)$. Then there is $\ell<k$ such that $\mathbf{a}^{\prime \prime}+\mathbf{e}_{k}-\mathbf{e}_{\ell} \in P$. Applying the Exchange Axiom to the pair $\mathbf{a}^{\prime}$ and $\mathbf{a}^{\prime \prime}+\mathbf{e}_{k}-\mathbf{e}_{\ell}$, we deduce that there is $r<k(r \in\{\ell, i, j\})$ such that $\mathbf{a}^{\prime}+\mathbf{e}_{k}-\mathbf{e}_{r} \in P$. Thus $k \notin \operatorname{Ext}\left(\mathbf{a}^{\prime}\right)$. Similarly, if $k \notin \operatorname{Int}\left(\mathbf{a}^{\prime \prime}\right)$, then there exists $r<k$ such that $\mathbf{a}^{\prime}-\mathbf{e}_{k}+\mathbf{e}_{r} \in P$, hence $k \notin \operatorname{Int}\left(\mathbf{a}^{\prime}\right)$.

Thus either $\mathbf{a}^{\prime \prime}$ has no bad index at all, or the maximal bad index for $\mathbf{a}^{\prime \prime}$ is less than $i$, or the maximal bad index for $\mathbf{a}^{\prime \prime}$ is $i$ and $\left|a_{i}^{\prime \prime}-c_{i}\right|<\left|a_{i}^{\prime}-c_{i}\right|$.

If $\mathbf{a}^{\prime \prime}$ has a bad index, then we can apply the same operation to the element $\mathbf{a}^{\prime \prime}$ and find a new element $\mathbf{a}^{\prime \prime \prime} \in P$, etc. The above argument shows that, after finitely many steps, we will find an element $\mathbf{a} \in P$ with no bad index. This means exactly that $\mathbf{c} \in C(\mathbf{a})$.

Finally, observe that, for the sequence of points $\mathbf{a}^{\prime}, \mathbf{a}^{\prime \prime}, \mathbf{a}^{\prime \prime \prime}, \cdots \in P$ that we constructed above we have $d_{1}\left(\mathbf{a}^{\prime}, \mathbf{c}\right) \geq d_{1}\left(\mathbf{a}^{\prime \prime}, \mathbf{c}\right) \geq d_{1}\left(\mathbf{a}^{\prime \prime \prime}, \mathbf{c}\right) \geq \cdots$. Indeed, $\mid a_{i}^{\prime}-$ $c_{i}\left|=\left|a_{i}^{\prime \prime}-c_{i}\right|-1\right.$ and $| a_{j}^{\prime}-c_{j}\left|\leq\left|a_{j}^{\prime \prime}-c_{j}\right|+1\right.$, and all other coordinates of $\mathbf{a}^{\prime}$ and
$\mathbf{a}^{\prime \prime}$ are the same. Since $\mathbf{a}^{\prime}$ can be any point of $P$ and the sequence $\mathbf{a}^{\prime}, \mathbf{a}^{\prime \prime}, \mathbf{a}^{\prime \prime \prime}, \ldots$ converges, after finitely many steps, to $\mathbf{a} \in P$ such that $\mathbf{c} \in C(\mathbf{a})$, we deduce that $d_{1}(\mathbf{a}, \mathbf{c}) \leq d_{1}\left(\mathbf{a}^{\prime}, \mathbf{c}\right)$ for any $\mathbf{a}^{\prime} \in P$, which proves part (2) of the theorem.
Example 9.5. In Figure 6 we show the cone decomposition for a polymatroid $P \subset \mathbb{Z}^{3}$. The polymatroid $P$ is the same as the one represented in Figures 2 and 3. Note that every cone of the decomposition contains the line $\mathbb{Z} \mathbf{e}_{1}$ as a Minkowski summand (because the index 1 is always both internally and externally active). Hence one may project the cone decomposition onto the space spanned by the coordinate vectors $\mathbf{e}_{2}, \mathbf{e}_{3}$ without loss of information (one could equivalently consider the induced decomposition of the hyperplane $\left\{\mathbf{x} \in \mathbb{Z}^{n} \mid \sum x_{i}=\operatorname{level}(P)\right\}$ containing $P$ ). This is represented on the right of Figure 6 .



Figure 6. Two views of the same cone decomposition of $\mathbb{Z}^{3}$. The picture on the right is the projection in the subspace $\operatorname{span}\left(\mathbf{e}_{2}, \mathbf{e}_{3}\right)$ of the cone decomposition of $\mathbb{Z}^{3}$ shown on the left.

## 10. Corank-nullity construction of the polymatroid Tutte POLYNOMIAL

In this section we provide another construction for the polymatroid Tutte polynomial. This alternative construction is clearly invariant under permutations of coordinates, hence it provides a proof of Theorem 4.7. In fact, this construction is the analogue of the corank-nullity definition of the Tutte polynomial of matroids given by (3).

First, we show that the Manhattan distance $d_{1}(P, \mathbf{c})$ between a nonempty Mconvex set $P \subset \mathbb{Z}^{n}$ and a lattice point $\mathbf{c} \in \mathbb{Z}^{n}$ splits canonically into two summands.

Definition 10.1. For $\mathbf{a}, \mathbf{b} \in \mathbb{R}^{n}$, define

$$
d_{1}^{>}(\mathbf{a}, \mathbf{b}):=\sum_{i: a_{i}>b_{i}}\left(a_{i}-b_{i}\right) \quad \text { and } \quad d_{1}^{<}(\mathbf{a}, \mathbf{b}):=\sum_{i: a_{i}<b_{i}}\left(b_{i}-a_{i}\right) .
$$

The functions $d_{1}^{>}$and $d_{1}^{<}$are non-symmetric (in fact $d_{1}^{<}(\mathbf{a}, \mathbf{b})=d_{1}^{>}(\mathbf{b}, \mathbf{a})$ ), but also non-negative and, clearly, $d_{1}(\mathbf{a}, \mathbf{b})=d_{1}^{>}(\mathbf{a}, \mathbf{b})+d_{1}^{<}(\mathbf{a}, \mathbf{b})$.

Definition 10.2. For a nonempty M-convex set $P \subset \mathbb{Z}^{n}$, and a lattice point $\mathbf{c} \in \mathbb{Z}^{n}$, define

$$
d_{1}^{>}(P, \mathbf{c}):=\min _{\mathbf{a} \in P} d_{1}^{>}(\mathbf{a}, \mathbf{c}) \quad \text { and } \quad d_{1}^{<}(P, \mathbf{c}):=\min _{\mathbf{a} \in P} d_{1}^{<}(\mathbf{a}, \mathbf{c}) .
$$

Lemma 10.3. Let $P \subset \mathbb{Z}^{n}$ be a nonempty $M$-convex set, and let $\mathbf{c} \in \mathbb{Z}^{n}$. For any point $\mathbf{a} \in P$ such that $d_{1}(\mathbf{a}, \mathbf{c})=d_{1}(P, \mathbf{c})$, we have $d_{1}^{>}(\mathbf{a}, \mathbf{c})=d_{1}^{>}(P, \mathbf{c})$ and $d_{1}^{<}(\mathbf{a}, \mathbf{c})=d_{1}^{<}(P, \mathbf{c})$. Thus

$$
d_{1}(P, \mathbf{c})=d_{1}^{>}(P, \mathbf{c})+d_{1}^{<}(P, \mathbf{c}) .
$$

Proof. Let us fix a point $\mathbf{a} \in P$ such that $d_{1}(\mathbf{a}, \mathbf{c})=d_{1}(P, \mathbf{c})$. Among all points $\mathbf{b} \in P$ such that $d_{1}^{>}(\mathbf{b}, \mathbf{c})=d_{1}^{>}(P, \mathbf{c})$, let us pick a point $\mathbf{b}$ with minimal possible Manhattan distance $d_{1}(\mathbf{a}, \mathbf{b})$. We will show that $\mathbf{a}=\mathbf{b}$.

Suppose for contradiction that $\mathbf{a} \neq \mathbf{b}$. Since $\mathbf{a}, \mathbf{b} \in P$ we have $\sum a_{i}=\operatorname{level}(P)=$ $\sum b_{i}$. Hence, there is an index $i$ such that $a_{i}>b_{i}$. According to the Exchange Axiom, there is an index $j$ such that $a_{j}<b_{j}$ and $\mathbf{a}^{\prime}=\mathbf{a}-\mathbf{e}_{i}+\mathbf{e}_{j}$ and $\mathbf{b}^{\prime}=\mathbf{b}+\mathbf{e}_{i}-\mathbf{e}_{j}$ both belong to $P$. Notice that $d_{1}\left(\mathbf{a}, \mathbf{b}^{\prime}\right)=d_{1}(\mathbf{a}, \mathbf{b})-2$. At this point we split into several cases and get contradictions in each case:
(1) In the case $c_{i} \geq a_{i}$, we get $c_{i}>b_{i}$ hence $d_{1}^{>}\left(\mathbf{b}^{\prime}, \mathbf{c}\right) \leq d_{1}^{>}(\mathbf{b}, \mathbf{c})$. Since $d_{1}\left(\mathbf{a}, \mathbf{b}^{\prime}\right)<d_{1}(\mathbf{a}, \mathbf{b})$, this contradicts our choice of $\mathbf{b}$.
(2) In the case $c_{j} \leq a_{j}$, we get $c_{j}<b_{j}$ hence $d_{1}^{>}\left(\mathbf{b}^{\prime}, \mathbf{c}\right) \leq d_{1}^{>}(\mathbf{b}, \mathbf{c})$. Since $d_{1}\left(\mathbf{a}, \mathbf{b}^{\prime}\right)<d_{1}(\mathbf{a}, \mathbf{b})$, this contradicts our choice of $\mathbf{b}$.
(3) In the case $\left(c_{i}<a_{i}\right.$ and $\left.c_{j}>a_{j}\right)$, we get $d_{1}\left(\mathbf{a}^{\prime}, \mathbf{c}\right)<d_{1}(\mathbf{a}, \mathbf{c})$, which contradicts our choice of $\mathbf{a}$.
This shows that $\mathbf{a}=\mathbf{b}$. So $d_{1}^{>}(\mathbf{a}, \mathbf{c})=d_{1}^{>}(P, \mathbf{c})$. Similarly, $d_{1}^{<}(\mathbf{a}, \mathbf{c})=d_{1}^{<}(P, \mathbf{c})$.
Finally, we get $d_{1}(P, \mathbf{c})=d_{1}(\mathbf{a}, \mathbf{c})=d_{1}^{>}(\mathbf{a}, \mathbf{c})+d_{1}^{<}(\mathbf{a}, \mathbf{c})=d_{1}^{>}(P, \mathbf{c})+d_{1}^{<}(P, \mathbf{c})$.

Remark 10.4. The quantities $d_{1}^{>}(P, \mathbf{c})$ and $d_{1}^{<}(P, \mathbf{c})$ extend the notions of corank and nullity from matroid theory. Indeed, let $M$ be a matroid with ground set [n], and let $P(M) \subset\{0,1\}^{n}$ be the corresponding polymatroid (as defined in Remark 3.3). Let $S \subseteq[n]$, and let $\mathbf{c}=\left(c_{1}, \ldots, c_{n}\right) \in\{0,1\}^{n}$ be the vector corresponding to $S$ (that is, $c_{i}=1$ if $i \in S$ and $c_{i}=0$ otherwise). By definition, the corank of $S$ with respect to the matroid $M$ is $\min \{|A \backslash S| \mid A$ is a basis of $M\}$, which is clearly equal to $d_{1}^{>}(P(M), \mathbf{c})$. Dually, the nullity of $S$ with respect to $M$ is $\min \{|S \backslash A| \mid A$ is a basis of $M\}=d_{1}^{<}(P(M), \mathbf{c})$.
Definition 10.5. Let $P \subset \mathbb{Z}^{n}$ be a polymatroid. Define the formal power series $\widetilde{\mathscr{T}_{P}}(u, v)$ in two variables $u$ and $v$ by

$$
\widetilde{\mathscr{T}_{P}}(u, v):=\sum_{\mathbf{c} \in \mathbb{Z}^{n}} w t_{P}(\mathbf{c})
$$

where the weight $w t_{P}(\mathbf{c})$ of a lattice point $\mathbf{c} \in \mathbb{Z}^{n}$ is given by

$$
w t_{P}(\mathbf{c}):=u^{d_{1}^{>}(P, \mathbf{c})} v^{d_{1}^{<}(P, \mathbf{c})} .
$$

As we now prove, the formal power series $\widetilde{\mathscr{T}}_{P}(u, v)$ is related to the polymatroid Tutte polynomial $\mathscr{T}_{P}(x, y)$ by a simple change of variables.

Theorem 10.6. For all polymatroids $P \subset \mathbb{Z}^{n}$, we have

$$
\widetilde{\mathscr{T}_{P}}(u, v)=\mathscr{T}_{P}\left(\frac{1}{1-u}, \frac{1}{1-v}\right)
$$

Theorem 10.6 is an identity for formal power series in $u, v$, and the expression $\frac{1}{1-u}$ stands for $\sum_{n=1}^{\infty} u^{n}$ (and similarly $\frac{1}{1-v}=\sum_{n=1}^{\infty} v^{n}$ ).

Proof. Using the decomposition $\mathbb{Z}^{n}=\biguplus_{\mathbf{a} \in P} C(\mathbf{a})$ from Theorem 9.3 (1), and applying Theorem 9.3(2) together with Lemma 10.3, we get

$$
\widetilde{\mathscr{T}_{P}}(u, v)=\sum_{\mathbf{a} \in P} \sum_{\mathbf{c} \in C(\mathbf{a})} w t_{P}(\mathbf{c})=\sum_{\mathbf{a} \in P} \prod_{i=1}^{n} m_{i}(\mathbf{a})
$$

where

$$
m_{i}(\mathbf{a})=\left\{\begin{array}{cl}
1 & \text { if } i \notin \operatorname{Int}(\mathbf{a}) \text { and } i \notin \operatorname{Ext}(\mathbf{a}), \\
1+u+u^{2}+\cdots & \text { if } i \in \operatorname{Int}(\mathbf{a}) \text { and } i \notin \operatorname{Ext}(\mathbf{a}) \\
1+v+v^{2}+\cdots & \text { if } i \notin \operatorname{Int}(\mathbf{a}) \text { and } i \in \operatorname{Ext}(\mathbf{a}) \\
1+\left(u+u^{2}+\cdots\right)+\left(v+v^{2}+\cdots\right) & \text { if } i \in \operatorname{Int}(\mathbf{a}) \text { and } i \in \operatorname{Ext}(\mathbf{a})
\end{array}\right.
$$

If we let $x=1+u+u^{2}+\cdots=1 /(1-u)$ and $y=1+v+v^{2}+\cdots=1 /(1-v)$, then $1+\left(u+u^{2}+\cdots\right)+\left(v+v^{2}+\cdots\right)=x+y-1$. Thus, for all $\mathbf{a} \in P$,

$$
\prod_{i=1}^{n} m_{i}(\mathbf{a})=x^{|\operatorname{Int}(\mathbf{a}) \backslash \operatorname{Ext}(\mathbf{a})|} y^{|\operatorname{Ext}(\mathbf{a}) \backslash \operatorname{Int}(\mathbf{a})|}(x+y-1)^{|\operatorname{Int}(\mathbf{a}) \cap \operatorname{Ext}(\mathbf{a})|}
$$

and $\widetilde{\mathscr{T}}_{P}(u, v)=\mathscr{T}_{P}(x, y)$.
Proof of Theorem 4.7. The order-independence ( $S_{n}$-invariance) of the Tutte polynomial $\mathscr{T}_{P}(x, y)$ follows from Theorem 10.6 , because the formal power series $\widetilde{\mathscr{T}}_{P}(u, v)$ is obviously independent of the ordering of the coordinates.

## 11. Polymatroid shadows

In this section, we give two additional expressions for the polymatroid Tutte polynomial, which are "halfway between" the forms in Definitions 4.3 and 10.5
Definition 11.1. Let $P \subset \mathbb{Z}^{n}$ be a polymatroid. The upper shadow of $P$ is the Minkowski sum $S^{\text {up }}(P):=P+\mathbb{Z}_{\geq 0}^{n} \subset \mathbb{Z}^{n}$. The lower shadow of $P$ is $S^{\text {low }}(P):=$ $P+\mathbb{Z}_{\leq 0}^{n} \subset \mathbb{Z}^{n}$.
Remark 11.2. Lower and upper shadows are related to the matroidal notions of independent sets and spanning sets, respectively. Precisely, for a matroid $M$ with ground set $[n]$, the independent (resp., spanning) sets of $M$ correspond to elements of $\{0,1\}^{n}$ lying in the lower (resp., upper) shadow of the polymatroid $P(M)$.

Recall that $\mathbf{e}_{1}, \ldots, \mathbf{e}_{n}$ are the standard coordinate vectors in $\mathbb{R}^{n}$. Also let $\mathbf{e}_{0}=0$.
Definition 11.3. Let $S \subset \mathbb{Z}^{n}$ be an upper or lower polymatroid shadow. For $\mathbf{a} \in S$, an index $i \in[n]$ is called internally active if there is no $j \in\{0,1, \ldots, i-1\}$ such that $\mathbf{a}-\mathbf{e}_{i}+\mathbf{e}_{j} \in S$. Let $\widetilde{\operatorname{Int}}(\mathbf{a})=\widetilde{\operatorname{Int}_{S}}(\mathbf{a}) \subseteq[n]$ denote the subset of internally active indices with respect to $\mathbf{a} \in S$.

For $\mathbf{a} \in S$, an index $i \in[n]$ is called externally active if there is no $j \in$ $\{0,1, \ldots, i-1\}$ such that $\mathbf{a}+\mathbf{e}_{i}-\mathbf{e}_{j} \in S$. Let $\widetilde{\operatorname{Ext}}(\mathbf{a})=\widetilde{\operatorname{Ext}}_{S}(\mathbf{a}) \subseteq[n]$ denote the subset of externally active indices with respect to $\mathbf{a} \in S$.

In fact, elements of an upper polymatroid shadow $S=S^{\mathrm{up}}(P)$ have no externally active indices. Indeed, for any $\mathbf{a} \in S$ and any $i \in[n]$, we have $0<i$ and $\mathbf{a}+\mathbf{e}_{i}=$ $\mathbf{a}+\mathbf{e}_{i}-\mathbf{e}_{0} \in S$. Likewise, elements of a lower polymatroid shadow have no internally
active indices. Observe also that the index $1 \in[n]$ is not necessarily active for an element of a polymatroid shadow.

Remark 11.4 (Shadows as projections of M-convex sets). Polymatroid shadows are actually the images of certain infinite $M$-convex sets in $\mathbb{Z}^{n+1}$ under the projection

$$
\pi: \mathbb{Z}^{n+1} \rightarrow \mathbb{Z}^{n} \quad \text { given by } \quad \pi:\left(x_{0}, x_{1}, \ldots, x_{n}\right) \mapsto\left(x_{1}, \ldots, x_{n}\right)
$$

Moreover the activities of the shadows correspond, via the projection $\pi$, to the activities of these $M$-convex sets. Explicitly, $S^{\text {up }}(P)=\pi\left(\tilde{S}^{\text {up }}(P)\right)$, where $\tilde{S}^{\text {up }}(P)=$ $\widetilde{P}+\widetilde{U}$ with $\widetilde{P}=\left\{\left(0, a_{1}, \ldots, a_{n}\right) \mid\left(a_{1}, \ldots, a_{n}\right) \in P\right\}$ and

$$
\widetilde{U}=\left\{\left(x_{0}, \ldots, x_{n}\right) \mid \sum_{i=0}^{n} x_{i}=0 \text { and }\left(x_{1}, \ldots, x_{n}\right) \in \mathbb{Z}_{\geq 0}^{n}\right\} .
$$

Similarly, $S^{\text {low }}(P)=\pi\left(\tilde{S}^{\text {low }}(P)\right)$, where $\tilde{S}^{\text {low }}(P)=\widetilde{P}+\widetilde{L}$ and $\widetilde{L}=\{-\mathbf{x} \mid \mathbf{x} \in \widetilde{U}\}$. It is easy to see that for any $\widetilde{\mathbf{a}}$ in $\tilde{S}^{\text {up }}(P)$ (resp., $\tilde{S}^{\text {low }}(P)$ ), an index $i \in[n]$ is internally/externally active for $\widetilde{\mathbf{a}}$ (in the sense of Definition 4.1) if and only if $i$ is internally/externally active for the element $\pi(\widetilde{\mathbf{a}})$ of the shadow $S^{\text {up }}(P)$ (resp., $\left.S^{\text {low }}(P)\right)$ in the sense of Definition 11.3 .

For $\mathbf{a} \in \mathbb{Z}^{n}$, let

$$
\operatorname{level}(\mathbf{a}):=a_{1}+\cdots+a_{n} \in \mathbb{Z}
$$

Recall that all the elements of a polymatroid $P$ have the same level, and that level $(P)$ denotes the level of the elements of $P$.

Theorem 11.5. Let $P \subset \mathbb{Z}^{n}$ be a polymatroid. Let $S^{u p}(P):=P+\mathbb{Z}_{\geq 0}^{n}$ and $S^{\text {low }}(P):=P+\mathbb{Z}_{\leq 0}^{n}$ be the upper and lower shadows of $P$. The polymatroid Tutte polynomial $\mathscr{T}_{P}(x, \bar{y})$ satisfies (and is uniquely determined by any of) the following two formulas:

$$
\begin{aligned}
& \mathscr{T}_{P}\left(x, \frac{1}{1-v}\right)=\sum_{\mathbf{a} \in S^{u p}(P)} x^{|\widetilde{\mathrm{Int}}(\mathbf{a})|} v^{\operatorname{level}(\mathbf{a})-\operatorname{level}(P)}, \\
& \mathscr{T}_{P}\left(\frac{1}{1-u}, y\right)=\sum_{\mathbf{a} \in S^{l o w}(P)} u^{\operatorname{level}(P)-\operatorname{level}(\mathbf{a})} y^{\mid \widetilde{\operatorname{Ext}(\mathbf{a}) \mid}} .
\end{aligned}
$$

Remark 11.6. Theorem 11.5 gives the polymatroid analogues of the so-called "independent sets expansion" and "spanning sets expansion" of the matroidal Tutte polynomial; see GT].

The proof of Theorem 11.5 relies on the construction of certain partitions of the lattice $\mathbb{Z}^{n}$ which are described in the next section.

## 12. SHADOW DECOMPOSITIONS

In this section we define, for an M-convex set $P \subset \mathbb{Z}^{n}$, two partitions of the lattice $\mathbb{Z}^{n}$ which are refinements of the cone decomposition presented in Section 9 . and we prove Theorem 11.5 .

Recall from Theorem 9.3 the cone decomposition associated to $P$ :

$$
\mathbb{Z}^{n}=\biguplus_{\mathbf{a} \in P} C_{P}(\mathbf{a})
$$

Let $\mathbf{a} \in P$. The cone $C_{P}(\mathbf{a})$ can be written as the following Minkowski sum:
$C_{P}(\mathbf{a})=\mathbf{a}+\sum_{i \in \operatorname{Int}_{P}(\mathbf{a}) \cap \operatorname{Ext}_{P}(\mathbf{a})} \mathbb{Z} \mathbf{e}_{i}+\sum_{i \in \operatorname{Int}_{P}(\mathbf{a}) \backslash \operatorname{Ext}_{P}(\mathbf{a})} \mathbb{Z}_{\leq 0} \mathbf{e}_{i}+\sum_{i \in \operatorname{Ext}_{P}(\mathbf{a}) \backslash \operatorname{Int}_{P}(\mathbf{a})} \mathbb{Z}_{\geq 0} \mathbf{e}_{i}$.
We define two subcones:

$$
C_{P}^{\mathrm{up}}(\mathbf{a}):=\mathbf{a}+\sum_{i \in \operatorname{Ext}_{P}(\mathbf{a})} \mathbb{Z}_{\geq 0} \mathbf{e}_{i}, \quad \text { and } C_{P}^{\mathrm{low}}(\mathbf{a}):=\mathbf{a}+\sum_{i \in \operatorname{Int}_{P}(\mathbf{a})} \mathbb{Z}_{\leq 0} \mathbf{e}_{i}
$$

Lemma 12.1. The cones $C_{P}^{u p}(\mathbf{a})$ and $C_{P}^{\text {low }}(\mathbf{a})$ partition the upper and lower shadows of $P$, respectively:

$$
S^{u p}(P)=\biguplus_{\mathbf{a} \in P} C_{P}^{u p}(\mathbf{a}), \quad \text { and } \quad S^{l o w}(P)=\biguplus_{\mathbf{a} \in P} C_{P}^{l o w}(\mathbf{a})
$$

Proof. It is clear that $\biguplus_{\mathbf{a} \in P} C_{P}^{\mathrm{up}}(\mathbf{a}) \subseteq S^{\mathrm{up}}(P)$. To prove the converse inclusion, let us consider $\mathbf{b}$ in $S^{\text {up }}(P) \cap C_{P}(\mathbf{a})$. As $\mathbf{b} \in S^{\text {up }}(P)$, we get $d_{1}^{>}(P, \mathbf{b})=0$. Since $\mathbf{b} \in$ $C_{P}(\mathbf{a})$, Theorem $9.3(2)$ and Lemma 10.3 combine to give $d_{1}^{>}(\mathbf{a}, \mathbf{b})=0$. Hence $\mathbf{b} \in$ $C_{P}^{\mathrm{up}}(\mathbf{a})$. Thus, $S^{\mathrm{up}}(P)=\biguplus_{\mathbf{a} \in P} C_{P}^{\mathrm{up}}(\mathbf{a})$. Similarly, $S^{\text {low }}(P)=\biguplus_{\mathbf{a} \in P} C_{P}^{\text {low }}(\mathbf{a})$.


Figure 7. Various decompositions into cones for a polymatroid $P \subset \mathbb{Z}^{2}$. The elements of $P$ are indicated by large dots. The first panel shows the cone decomposition $S^{\text {low }}(P)=\biguplus_{\mathbf{a} \in P} C_{P}^{\text {low }}(\mathbf{a})$ of the lower shadow. The second panel depicts the decomposition $S^{\mathrm{up}}(P)=\biguplus_{\mathbf{a} \in P} C_{P}^{\mathrm{up}}(\mathbf{a})$ of the upper shadow. The third panel shows the decomposition $\mathbb{Z}^{n}=\biguplus_{\mathbf{a} \in P} C_{P}(\mathbf{a})$ provided by Theorem 9.3. The fourth (resp., fifth) panel is a depiction of the refined decomposition of $\mathbb{Z}^{n}$, given by Theorem $12.2(1)$, in terms of cones indexed by elements $\mathbf{b}$ of $S^{\mathrm{up}}(P)$ (resp., $S^{\mathrm{low}}(P)$ ).

The partitions of the shadows given by Lemma 12.1 are illustrated in the first two panels of Figure 7 . We now consider some partitions of $\mathbb{Z}^{n}$ indexed by the points in the shadows. For $\mathbf{b} \in S^{\mathrm{up}}(P)$ we define

$$
C_{\bar{P}}^{\leq}(\mathbf{b})=\mathbf{b}+\sum_{i \in \widetilde{\operatorname{Int}}(\mathbf{b})} \mathbb{Z}_{\leq 0} \mathbf{e}_{i} .
$$

Now we observe that for all $\mathbf{b} \in C_{P}^{\mathrm{up}}(\mathbf{a})$, we have

$$
\widetilde{\operatorname{Int}}(\mathbf{b})=\operatorname{Int}_{P}(\mathbf{a}) \cap\left\{i \in[n] \mid a_{i}=b_{i}\right\}
$$

This implies

$$
\begin{equation*}
C_{P}(\mathbf{a})=\biguplus_{\mathbf{b} \in C_{P}^{\mathrm{up}}(\mathbf{a})} C_{\bar{P}}^{\leq}(\mathbf{b}) . \tag{21}
\end{equation*}
$$

Similarly, for $\mathbf{b} \in S^{\text {low }}(P)$, we define $C_{\bar{P}}^{>}(\mathbf{b})=\mathbf{b}+\sum_{i \in \widetilde{\operatorname{Ext}(\mathbf{b})}} \mathbb{Z}_{\geq 0} \mathbf{e}_{i}$ and get

$$
\begin{equation*}
C_{P}(\mathbf{a})=\biguplus_{\mathbf{b} \in C_{P}^{\mathrm{lww}}(\mathbf{a})} C_{\bar{P}}^{>}(\mathbf{b}) . \tag{22}
\end{equation*}
$$

We summarize our constructions:
Theorem 12.2. Let $P \subset \mathbb{Z}^{n}$ be an $M$-convex set.
(1) The cone decomposition of $\mathbb{Z}^{n}$ given by Theorem 9.3 has the following two refinements:

$$
\mathbb{Z}^{n}=\biguplus_{\mathbf{a} \in S^{\text {sup }}(P)} C_{\bar{P}}^{\leq}(\mathbf{b})=\biguplus_{\mathbf{b} \in S^{\text {low }}(P)} C_{\bar{P}}^{>}(\mathbf{b}) .
$$

(2) Let $\mathbf{a} \in P$, let $\mathbf{b} \in C_{P}^{u p}(\mathbf{a})$ and let $\mathbf{b}^{\prime} \in C_{P}^{l o w}(\mathbf{a})$. If for all $i \in \operatorname{Int}_{P}(\mathbf{a}) \cap$ $\operatorname{Ext}_{P}(\mathbf{a})$ either $a_{i}=b_{i}$ or $a_{i}=b_{i}^{\prime}$ (or both), then $C_{P}^{\triangle}(\mathbf{b}) \cap C_{P}^{\geq}\left(\mathbf{b}^{\prime}\right)=$ $\left\{\mathbf{b}+\mathbf{b}^{\prime}-\mathbf{a}\right\}$. Otherwise $C_{\bar{P}}^{\leq}(\mathbf{b}) \cap C_{\bar{P}}^{>}\left(\mathbf{b}^{\prime}\right)=\varnothing$.
(3) For all $\mathbf{b} \in S^{u p}(P)$ and all $\mathbf{c} \in C_{\bar{P}}^{\leq}(\mathbf{b})$, one has
$d_{1}^{<}(P, \mathbf{c})=d_{1}^{<}(P, \mathbf{b})=\operatorname{level}(\mathbf{b})-\operatorname{level}(P)$ and $d_{1}^{>}(P, \mathbf{c})=d_{1}^{>}(\mathbf{b}, \mathbf{c})$.
Symmetrically, for all $\mathbf{b} \in S^{l o w}(P)$ and all $\mathbf{c} \in C_{P}^{>}(\mathbf{b})$, one has
$d_{1}^{>}(P, \mathbf{c})=d_{1}^{>}(P, \mathbf{b})=\operatorname{level}(P)-\operatorname{level}(\mathbf{b})$ and $d_{1}^{<}(P, \mathbf{c})=d_{1}^{<}(\mathbf{b}, \mathbf{c})$.
The decompositions of $\mathbb{Z}^{n}$ given by Theorem $12.2(1)$ are illustrated in the last two panels of Figure 7 .

Proof. Property (1) is obtained by combining Lemma 12.1 with $(21)$ and $(22)$.
For Property (2), let us consider $\mathbf{c} \in C_{P}^{\leq}(\mathbf{b}) \cap C_{\bar{P}}^{\geq}\left(\mathbf{b}^{\prime}\right)$. We observe that for all $i \notin \operatorname{Int}_{P}(\mathbf{a})$ we have $i \notin \widetilde{\operatorname{Int}}(\mathbf{b})$ whence $c_{i}=b_{i}$. Symmetrically, for all $i \notin \operatorname{Ext}_{P}(\mathbf{a})$ we have $c_{i}=b_{i}^{\prime}$. Lastly for $i \in \operatorname{Int}_{P}(\mathbf{a}) \cap \operatorname{Ext}_{P}(\mathbf{a})$, if $b_{i} \neq a_{i}$ then $c_{i}=b_{i}>a_{i}$, and if $b_{i}^{\prime} \neq a_{i}$ then $c_{i}=b_{i}^{\prime}<a_{i}$. This easily implies Property (2).

We now prove Property (3). Let $\mathbf{b} \in S^{\text {up }}(P)$ and let $\mathbf{c} \in C_{P}^{\leq}(\mathbf{b})$. Let a be the element of $P$ such that $\mathbf{b} \in C_{P}(\mathbf{a})$. Theorem 9.3(2) together with Lemma 10.3 gives $d_{1}^{<}(P, \mathbf{c})=d_{1}^{<}(\mathbf{a}, \mathbf{c})$ and $d_{1}^{>}(P, \mathbf{c})=d_{1}^{>}(\mathbf{a}, \mathbf{c})$. Moreover, it is clear from the definitions that $d_{1}^{<}(\mathbf{a}, \mathbf{c})=d_{1}^{<}(\mathbf{a}, \mathbf{b})=\operatorname{level}(\mathbf{b})-\operatorname{level}(\mathbf{a})$ and $d_{1}^{>}(\mathbf{a}, \mathbf{c})=d_{1}^{>}(\mathbf{b}, \mathbf{c})$. This proves the first identity of Property (3), and the other identity is proved similarly.

Remark 12.3 (Shadow partitions as projections). Recall from Remark 11.4 that the shadows $S^{\text {up }}(P)$ and $S^{\text {low }}(P)$ are the projections of some M-convex sets $S^{\text {up }}(P)$ and $\tilde{S}^{\text {low }}(P)$. It is not hard to check that the decomposition of $\mathbb{Z}^{n}$ given by Theorem 12.2 (1) is the projection of the cone decompositions of $\mathbb{Z}^{n+1}$ obtained by applying Theorem 9.3 to the M-convex sets $\tilde{S}^{\text {up }}(P)$ and $\tilde{S}^{\text {low }}(P)$.

We now use Theorem 12.2 to prove Theorem 11.5 .
Proof of Theorem 11.5. Using Theorem 10.6 and Theorem 12.2(1), we obtain

$$
\mathscr{T}_{P}\left(\frac{1}{1-u}, \frac{1}{1-v}\right)=\sum_{\mathbf{b} \in S_{\text {upp }}(P)} \sum_{\mathbf{c} \in C_{\bar{P}}^{<}(\mathbf{b})} u^{d_{1}^{>}(P, \mathbf{c})} v^{d_{1}^{<}(P, \mathbf{c})} .
$$

Using Theorem 12.2 (3) then gives

$$
\begin{aligned}
\mathscr{T}_{P}\left(\frac{1}{1-u}, \frac{1}{1-v}\right) & =\sum_{\mathbf{b} \in S^{\operatorname{up}}(P)} v^{\operatorname{level}(\mathbf{b})-\operatorname{level}(P)} \sum_{\mathbf{c} \in C_{\bar{S}}^{\leq}(\mathbf{b})} u^{d_{1}^{>}(\mathbf{b}, \mathbf{c})} \\
& =\sum_{\mathbf{b} \in S^{\operatorname{up}}(P)} v^{\operatorname{level}(\mathbf{b})-\operatorname{level}(P)}\left(\frac{1}{1-u}\right)^{\mid \widetilde{\operatorname{nnt}(\mathbf{b}) \mid}} .
\end{aligned}
$$

Replacing $\frac{1}{1-u}$ by $x$ gives the first needed formula. The proof of the second formula is similar.

## 13. Cameron-Fink polynomials and polymatroid neighborhoods

In this section we explain the relation between the polymatroid Tutte polynomial and the invariant defined by Cameron and Fink in CF. Let us first recall their polymatroid invariant $\mathscr{Q}_{P}^{\prime}(x, y)$.
Definition 13.1. CF Let $P \subset \mathbb{Z}^{n}$ be a polymatroid and let $\mathcal{P}=\operatorname{conv}(P)$ be its convex hull. Let $\Delta$ be the coordinate $(n-1)$-dimensional simplex $\Delta:=$ $\operatorname{conv}\left(\mathbf{e}_{1}, \ldots, \mathbf{e}_{n}\right) \subset \mathbb{R}^{n}$, and let $\nabla=-\Delta=\operatorname{conv}\left(-\mathbf{e}_{1}, \ldots,-\mathbf{e}_{n}\right)$. It is shown in CF that there exists a (unique) two-variable polynomial $\mathscr{Q}_{P}$ such that for any positive integer values of $s$ and $t$, the value $\mathscr{Q}_{P}(s, t)$ counts the number of integer lattice points in the Minkowski sum $\mathcal{P}+s \nabla+t \Delta$ :

$$
\mathscr{Q}_{P}(s, t)=\left|(\mathcal{P}+s \nabla+t \Delta) \cap \mathbb{Z}^{n}\right|
$$

There are (unique) integer coefficients $c_{i, j}$ such that

$$
\mathscr{Q}_{P}(s, t)=\sum_{i, j \geq 0} c_{i, j}\binom{s}{i}\binom{t}{j}
$$

where $\binom{x}{i}:=\frac{x(x-1) \cdots(x-i+1)}{i!}$, and $\mathscr{Q}_{P}^{\prime}(x, y)$ is defined as the polynomial

$$
\mathscr{Q}_{P}^{\prime}(x, y):=\sum_{i, j \geq 0} c_{i, j}(x-1)^{i}(y-1)^{j} .
$$

The relation between $\mathscr{Q}_{P}^{\prime}(x, y)$ and $\mathscr{T}_{P}(x, y)$ takes the following simple form.
Theorem 13.2. The polynomial $\mathscr{Q}_{P}^{\prime}(x, y)$ equals $\mathscr{T}_{P}(x, y) /(x+y-1)$.
Remark 13.3. In view of Theorem 13.2 . Proposition 4.11 h) can be rephrased as follows:

$$
\mathscr{Q}_{P}(0,-1)=\left|(\mathcal{P}-\Delta) \cap \mathbb{Z}^{n}\right| \quad \text { and } \quad \mathscr{Q}_{P}(-1,0)=\left|(\mathcal{P}-\nabla) \cap \mathbb{Z}^{n}\right|
$$

The rest of this section is dedicated to the proof of Theorem 13.2 .
Definition 13.4. For a polymatroid $P \subset \mathbb{Z}^{n}$ and non-negative integers $s, t \in \mathbb{Z}_{\geq 0}$, the $(s, t)$-neighborhood of $P$ is the set

$$
N(s, t, P):=\left\{\mathbf{c} \in \mathbb{Z}^{n} \mid d_{1}^{>}(P, \mathbf{c}) \leq s \text { and } d_{1}^{<}(P, \mathbf{c}) \leq t\right\} .
$$

Let $H_{\ell} \subset \mathbb{Z}^{n}$ be the affine hyperplane $H_{\ell}:=\left\{\mathbf{c} \in \mathbb{Z}^{n} \mid \operatorname{level}(\mathbf{c})=\ell\right\}$.
Lemma 13.5. For a polymatroid $P \subset \mathbb{Z}^{n}$ and non-negative integers $s, t \in \mathbb{Z}_{\geq 0}$, the set of lattice points in the Minkowski sum $\mathcal{P}+s \nabla+t \Delta$ is a hyperplane section of the $(s, t)$-neighborhood of $P$, namely

$$
(\mathcal{P}+s \nabla+t \Delta) \cap \mathbb{Z}^{n}=N(s, t, P) \cap H_{\operatorname{level}(P)-s+t}
$$

Proof. For any lattice point $\mathbf{c} \in(\mathcal{P}+s \nabla+t \Delta) \cap \mathbb{Z}^{n}$, we have level $(\mathbf{c})=\operatorname{level}(P)-$ $s+t$. We also have $\mathbf{c}=\mathbf{a}+\mathbf{a}^{\prime}+\mathbf{a}^{\prime \prime}$, where $\mathbf{a} \in P, \mathbf{a}^{\prime} \in s \nabla$, and $\mathbf{a}^{\prime \prime} \in t \Delta$. So $d_{1}^{>}(P, \mathbf{c}) \leq d_{1}^{>}(\mathbf{a}, \mathbf{c}) \leq \sum_{i=1}^{n}\left|a_{i}^{\prime}\right|=s$ and $d_{1}^{<}(P, \mathbf{c}) \leq d_{1}^{<}(\mathbf{a}, \mathbf{c}) \leq \sum_{i=1}^{n}\left|a_{i}^{\prime \prime}\right|=t$. Thus $\mathbf{c} \in N(s, t, P)$.

On the other hand, for any $\mathbf{c} \in N(s, t, P)$ with level $(\mathbf{c})=\operatorname{level}(P)-s+t$, let $\mathbf{a} \in P$ be any closest point of $P$ to $\mathbf{c}$, i.e., $d_{1}(P, \mathbf{c})=d_{1}(\mathbf{a}, \mathbf{c})$. According to Lemma 10.3 , we have $d_{1}^{>}(\mathbf{a}, \mathbf{c})=d_{1}^{>}(P, \mathbf{c}) \leq s$ and $d_{1}^{<}(\mathbf{a}, \mathbf{c})=d_{1}^{<}(P, \mathbf{c}) \leq t$. So $\mathbf{c}=\mathbf{a}+\mathbf{a}^{\prime}+\mathbf{a}^{\prime \prime}$, where $\mathbf{a}^{\prime} \in s^{\prime} \nabla$ and $\mathbf{a}^{\prime \prime} \in t^{\prime} \Delta$ with $s^{\prime}:=d_{1}^{>}(P, \mathbf{c}) \leq s$ and $t^{\prime}:=d_{1}^{<}(P, \mathbf{c}) \leq t$. Pick any $\mathbf{a}^{\prime \prime \prime} \in r \Delta$, where $r:=s-s^{\prime}=t-t^{\prime}$. Then we have $\mathbf{c}=\mathbf{a}+\left(\mathbf{a}^{\prime}-\mathbf{a}^{\prime \prime \prime}\right)+\left(\mathbf{a}^{\prime \prime}+\mathbf{a}^{\prime \prime \prime}\right)$, where $\mathbf{a}^{\prime}-\mathbf{a}^{\prime \prime \prime} \in s \nabla$ and $\mathbf{a}^{\prime \prime}+\mathbf{a}^{\prime \prime \prime} \in t \Delta$. So $\mathbf{c} \in \mathcal{P}+s \nabla+t \Delta$.

Proof of Theorem 13.2. We have

$$
\begin{aligned}
\mathscr{Q}_{P}(s, t)=\left|(\mathcal{P}+s \nabla+t \Delta) \cap \mathbb{Z}^{n}\right|= & \left|N(s, t, P) \cap H_{\mathrm{level}(P)-s+t}\right| \\
& =\sum_{\mathbf{a} \in P}\left|C_{P}(\mathbf{a}) \cap N(s, t, P) \cap H_{\mathrm{level}(P)-s+t}\right| .
\end{aligned}
$$

The intersection $C_{P}(\mathbf{a}) \cap N(s, t, P) \cap H_{\text {level }(P)-s+t}$ consists of all points $\mathbf{a}+\mathbf{x} \in \mathbb{Z}^{n}$ such that
(1) If $x_{i}<0$ then $i \in \operatorname{Int}_{P}(\mathbf{a})$. If $x_{j}>0$ then $j \in \operatorname{Ext}_{P}(\mathbf{a})$.
(2) $\sum_{i: x_{i}<0}\left(-x_{i}\right) \leq s$ and $\sum_{i: x_{i}>0} x_{i} \leq t$.
(3) $\sum_{i=1}^{n} x_{i}=-s+t$.

Since we always have $1 \in \operatorname{Int}(\mathbf{a}) \cap \operatorname{Ext}(\mathbf{a})$, the above set is in bijection with points $\left(x_{2}, \ldots, x_{n}\right) \in \mathbb{Z}^{n-1}$ that satisfy only conditions (1) and (2).

For $\mathbf{a}+\mathbf{x} \in C_{P}(\mathbf{a}) \cap N(s, t, P) \cap H_{\operatorname{level}(P)-s+t}$, let $I(\mathbf{x}):=\left\{i \in[n] \backslash\{1\} \mid x_{i}<0\right\}$ and $J(\mathbf{x}):=\left\{j \in[n] \backslash\{1\} \mid x_{j}>0\right\}$. The pair $(I(\mathbf{x}), J(\mathbf{x}))$ belongs to the set $\mathcal{K}(\mathbf{a})$ of pairs $(I, J)$ of subsets of $[n] \backslash\{1\}$ such that $I \subset \operatorname{Int}(\mathbf{a}), J \subset \operatorname{Ext}(\mathbf{a})$, and $I \cap J=\varnothing$. Moreover for any $(I, J) \in \mathcal{K}(\mathbf{a})$ the number of points $\mathbf{a}+\mathbf{x} \in$ $C_{P}(\mathbf{a}) \cap N(s, t, P) \cap H_{\text {level }(P)-s+t}$ such that $I(\mathbf{x})=I$ and $J(\mathbf{x})=J$ is $\binom{s}{|I|}\binom{t}{|J|}$ (because for $k \geq 0$ the number of tuples $\left(s_{1}, \ldots, s_{k}\right) \in Z_{>0}^{k}$ such that $\sum_{i=1}^{k} s_{i} \leq s$ is $\binom{s}{k}$ ). This gives

$$
\mathscr{Q}_{P}(s, t)=\sum_{\mathbf{a} \in P} \sum_{(I, J) \in \mathcal{K}(\mathbf{a})}\binom{s}{|I|}\binom{t}{|J|}
$$

Thus,

$$
\mathscr{Q}_{P}^{\prime}(x+1, y+1)=\sum_{\mathbf{a} \in P} \sum_{(I, J) \in \mathcal{K}(\mathbf{a})} x^{|I|} y^{|J|}=\sum_{\mathbf{a} \in P}(x+1)^{\mathrm{oi}(\mathbf{a})}(y+1)^{\mathrm{oe}(\mathbf{a})}(x+y+1)^{\mathrm{ie}(\mathbf{a})-1}
$$

which is exactly $\mathscr{T}_{P}(x+1, y+1) /(x+y+1)$.

## 14. Background: Hypergraphical polymatroids

In this section and the following ones, we discuss the polymatroids associated to hypergraphs Hel Tut3. Some properties of the associated generalized permutohedra have been studied in Pos, Kal, KP. This class of polytopes extends two well known families of "graphical polytopes": base polytopes of graphical matroids and graphical zonotopes.
14.1. Hypergraphs. Roughly speaking, a hypergraph over a set $V$ of "vertices" is a multiset of subsets of $V$ called "hyperedges". More formally, a hypergraph with vertex set $V$ and hyperedge set $W$ is a function $\vec{H}$ from the set $W$ to the set $2^{V}$ of subsets of $V$. Clearly, undirected graphs without loops identify with hypergraphs such that every hyperedge has cardinality 2 . Next we recall that hypergraphs can be identified with bipartite graphs.

A bipartite graph is a simple graph where every vertex is either called left vertex or right vertex, and every edge joins a left vertex to a right vertex. We adopt the notation $H=(V \sqcup W, E)$ to indicate that $H$ is a bipartite graph, $V$ is the set of left vertices, $W$ is the set of right vertices, and $E$ is the set of edges (note that our bipartite graphs come with a fixed bipartition of the vertices). To the bipartite graph $H$ we associate the hypergraph $\vec{H}$ with vertex set $V$ and hyperedge set $W$ defined by setting $\vec{H}(w)$ to be the set of neighbors of $w$ in $H$. Clearly, this is a bijection between bipartite graphs and hypergraphs.

The bipartite graph setting makes the symmetric role between vertices and hyperedges more apparent. For a bipartite graph $H=(V \sqcup W, E)$, we define the transpose bipartite graph to be $H^{T}:=(W \sqcup V, E)$. We also say that the hypergraph $\vec{H}^{T}\left(\right.$ associated to $\left.H^{T}\right)$ is the transpose of $\vec{H}$.


Figure 8. A bipartite graph $H$ and its hypergraphical polymatroid $P_{H}$ (which is the same polymatroid as the one in Example 3.9 .

Example 14.1. Let $H$ be the bipartite graph shown in Figure 8 whose left and right vertex sets are $V=\{a, b, c, d, e\}$ and $W=\{1,2,3\}$ respectively. The hypergraph $\vec{H}$ has vertex set $V$, hyperedge set $W$ and is given by $\vec{H}(1)=\{a, b, c\}, \vec{H}(2)=$ $\{b, c, d, e\}$ and $\vec{H}(3)=\{a, b, c, d, e\}$. The transpose hypergraph $\vec{H}^{T}$ has the vertex set $W$, hyperedge set $V$ and is given by $\vec{H}^{T}(a)=\{1,3\}, \vec{H}^{T}(b)=\vec{H}^{T}(c)=\{1,2,3\}$ and $\vec{H}^{T}(d)=\vec{H}^{T}(e)=\{2,3\}$.

In the next subsections we will define the hypergraphical polymatroid $P_{H} \subset \mathbb{Z}^{W}$ associated to the bipartite graph $H=(V \sqcup W, E)$. There are two different (but equivalent) constructions of $P_{H}$ : one in terms of the hypergraph $\vec{H}$ (via spanning hypertrees) and one in terms of the transpose hypergraph $\vec{H}^{T}$ (via Minkowski sums of simplices).
14.2. Hypergraphical polymatroid in terms of hypertrees. We generalize the notion of spanning trees from graphs to hypergraphs as follows.

Definition 14.2. Pos, Section 12], Kal, KP. Let $H=(V \sqcup W, E)$ be a connected bipartite graph. A spanning hypertree of the hypergraph $\vec{H}$ is a non-negative integer vector $\mathbf{a} \in \mathbb{Z}_{\geq 0}^{W}$ for which there exists a usual spanning tree $T$ of the bipartite graph $H$ such that $a_{w}=\operatorname{deg}_{T}(w)-1$ for every right vertex $w \in W$. Here $\operatorname{deg}_{T}(w)$ denotes the degree of the vertex $w$ in the tree $T$.
Remark 14.3. Let $G=(V, E)$ be a graph. Let $\vec{H}(G)$ be the corresponding hypergraph, which is to say, $\vec{H}(G)$ is the hypergraph associated to the bipartite graph $H(G)=\left(V \sqcup W, E^{\prime}\right)$ obtained from $G$ by adding a right vertex $w_{e}$ in the middle of each edge $e$ of $G$ (see Figure 9). Then the spanning hypertrees of $\vec{H}(G)$ are in bijection with the spanning trees of $G$ (the bijection associates to a spanning tree $T \subseteq E$ of $G$ the hypertree in $\{0,1\}^{W}$ given by the indicator function of the set $T$ ).


Figure 9. A graph $G$ and the associated hypergraph $\vec{H}(G)$. The latter has five spanning hypertrees: $(1,1,0,0),(1,0,1,0)$, $(1,0,0,1),(0,1,1,0)$ and $(0,1,0,1)$.

The notion of spanning hypertree first appeared in Pos under the name of right degree vectors of $H$, and also as $H$-draconian sequences. The term hypertree was used in Kal, KP. In Pos, Proposition 5.4] several other equivalent ways to characterize spanning hypertrees are given. One characterization is in terms of the dragon marriage problem [Pos] - a variant of Hall's marriage problem that involves brides, grooms and one dragon. Another characterization from $\overline{\mathrm{Pos}}$ is given below. Proposition 14.4. Pos Let $H=(V \sqcup W, E)$ be a connected bipartite graph. The vector $\mathbf{a} \in \mathbb{Z}^{W}$ is a spanning hypertree of the hypergraph $\vec{H}$ if and only if a satisfies the following conditions:
(i) $\sum_{w \in W} a_{w}=|V|-1$, and
(ii) for all $S \subset W$ we have $\sum_{w \in S} a_{w} \leq\left|\bigcup_{w \in S} \vec{H}(w)\right|-1$.

Remark 14.5. We point out that (by Proposition 14.4 ) the $n$-draconian sequences of Definition 7.1 coincide with the spanning hypertrees of the complete hypergraph $\vec{H}_{n}$ having vertex set $[n]$ and one hyperedge for each non-empty subset of $[n]$.

Remark 14.6. It is easy to see that the right-hand side in Condition (ii) of Proposition 14.4 can equivalently be replaced with

$$
\begin{equation*}
f(S):=\left|\bigcup_{w \in S} \vec{H}(w)\right|-\widetilde{c}(S) \tag{23}
\end{equation*}
$$

where $\widetilde{c}(S)$ is the number of connected components of the subgraph of $H$ induced by $S \uplus \bigcup_{w \in S} \vec{H}(w)$. Moreover, it is not hard to check that $f: 2^{W} \rightarrow \mathbb{Z}$ is submodular [Kal, Proposition 4.7]. Thus the set of spanning hypertrees of the hypergraph $\vec{H}$ is a polymatroid with rank function $f$.

Moreover it is clear that

$$
\begin{equation*}
f(S)=|V|-c(S) \tag{24}
\end{equation*}
$$

where $c(S)$ is the number of connected components of the subgraph of $H$ induced by $S \uplus V$ (because the vertices in $V \backslash \bigcup_{w \in S} \vec{H}(w)$ are isolated in this induced subgraph). The expression (24) of the rank function $f$ of $P_{H}$ coincides with the definition given in [Hel, Section 1.7].
Definition 14.7. Pos, Kal, Hel Let $H=(V \sqcup W, E)$ be a connected bipartite graph. We define the hypergraphical polymatroid $P_{H} \subset \mathbb{Z}^{W}$ as the set of all spanning hypertrees of the hypergraph $\vec{H}$. It has rank function given by (23), or equivalently 24.

Note that, for notational convenience, our hypergraphical polymatroids are defined to be subsets of $\mathbb{Z}^{W}$ instead of $\mathbb{Z}^{n}$ for $n=|W|$. From now on we adopt this relaxed definition of polymatroids.

Remark 14.8. Observe from Remark 14.3 that for the hypergraph $\vec{H}(G)$ corresponding to a graph $G$, the polymatroid $P_{H(G)}$ is the base polytope of $G$ (which is the polymatroid associated with the graphical matroid of $G$ ).
14.3. Hypergraphical polymatroid as a Minkowski sum of simplices. Recall that, for two subsets $A, B \subset \mathbb{R}^{W}$, their Minkowski sum is $A+B:=\{\mathbf{a}+\mathbf{b} \mid \mathbf{a} \in$ $A, \mathbf{b} \in B\}$ and their Minkowski difference is $A-B:=\left\{\mathbf{c} \in \mathbb{R}^{W} \mid\{\mathbf{c}\}+B \subseteq A\right\}$.
Definition 14.9. Pos, Definition 11.2] Define the polytope $\mathcal{P}_{H} \subset \mathbb{R}^{W}$ in terms of the hyperedges $\vec{H}^{T}(v)$ of the transpose hypergraph $\vec{H}^{T}$ as the following Minkowski sum and difference of polytopes:

$$
\mathcal{P}_{H}:=\left(\sum_{v \in V} \Delta_{\vec{H}^{T}(v)}\right)-\Delta_{W} \subset \mathbb{R}^{W}
$$

where the polytopes $\Delta_{I}=\operatorname{conv}\left(\mathbf{e}_{i} \mid i \in I\right) \subset \mathbb{R}^{W}$ are the coordinate simplices associated with subsets $I \subseteq W$.

The two constructions above are actually equivalent, due to [Pos, Theorem 12.9] (which is a consequence of Proposition 14.4).
Proposition 14.10. Pos Let $H=(V \sqcup W, E)$ be a connected bipartite graph. Then the set $P_{H} \subset \mathbb{Z}^{W}$ of spanning hypertrees of the hypergraph $\vec{H}$ is a polymatroid, and the polytope $\mathcal{P}_{H} \subset \mathbb{R}^{W}$ defined as a Minkowski sum over the hyperedges of the transpose hypergraph $\vec{H}^{T}$ is the generalized permutohedron associated with $P_{H}$.

In other words, $P_{H}$ is the set of lattice points of $\mathcal{P}_{H}$, and $\mathcal{P}_{H}=\operatorname{conv}\left(P_{H}\right)$.
Example 14.11. For the bipartite graph $H$ of Example 14.1, the polymatroid $P_{H} \subset \mathbb{Z}^{3}$ has 11 elements as shown in Figure 8 . It coincides with the polymatroid of Example 3.9 and it can be described either as the 11 spanning hypertrees of the right hypergraph, or, equivalently, as the 11 lattice points of the Minkowski sum of simplices

$$
\mathcal{P}_{H}=\Delta_{13}+2 \Delta_{23}+(2-1) \Delta_{123} .
$$

Suppose that the bipartite graph $H=(V \sqcup W, E)$ has a left vertex $v_{0} \in V$ adjacent to every right vertex. Then the polytope $\mathcal{P}_{H}$ can be expressed as a Minkowski sum of simplices (without using a Minkowski difference):

$$
\mathcal{P}_{H}:=\sum_{v \in V, v \neq v_{0}} \Delta_{\vec{H}^{T}(v)}
$$

This follows from the identity $(A+B)-B=A$ for Minkowski sums and differences. (A little care is needed when using Minkowski differences, because it is not true in general that $(A-B)+B=A$.) The Tutte polynomial of this type of polymatroid will be studied in Section 15 . As we now explain, graphical zonotopes (studied in Section 16) are an even more special case.

Remark 14.12. Let $G=(W, E)$ be a graph and let $H_{G}^{+}=\left(V^{+} \sqcup W, E^{\prime}\right)$ be the bipartite graph obtained from $G$ by adding a left vertex $v_{e} \in V$ in the middle of each edge $e \in E$ and adding an additional left vertex $v_{0}$ adjacent to every right vertex. This is represented in Figure 10 . Then, $\mathcal{P}_{H_{G}^{+}}$is exactly the graphical zonotope $\mathcal{Z}(G)$ of the graph $G$ :

$$
\mathcal{P}_{H_{G}^{+}}=\mathcal{Z}(G)=\sum_{\{i, j\} \text { edge of } G}\left[\mathbf{e}_{i}, \mathbf{e}_{j}\right]
$$



Figure 10. Left: a graph $G$. Middle: the bipartite graph $H_{G}^{+}$. Right: the zonotope $\mathcal{Z}(G)=P_{H_{G}^{+}}=\left[\mathbf{e}_{a}, \mathbf{e}_{b}\right]+\left[\mathbf{e}_{a}, \mathbf{e}_{c}\right]+2\left[\mathbf{e}_{b}, \mathbf{e}_{c}\right]$.
14.4. Direct and aggregated sums of hypergraphs. The notion of hypergraphical polymatroid can be extended to non-connected bipartite graphs $H=$ $(V \sqcup W, E)$. For this, in the definition of $P_{H}$ in terms of spanning hypertrees, one just needs to replace the notion of spanning tree used in Definition 14.7 by the notion of maximal spanning forest of $H$. Equivalently, one can consider the connected components $H_{1}, \ldots, H_{k}$ of $H$ and define $P_{H}$ as the direct sum of polymatroids $P_{H_{1}} \oplus \cdots \oplus P_{H_{k}}$. Note that by Proposition4.11(e), this gives

$$
\mathscr{T}_{P_{H}}(x, y)=\mathscr{T}_{P_{H_{1}}}(x, y) \times \cdots \times \mathscr{T}_{P_{H_{k}}}(x, y) .
$$

We now describe a construction on hypergraphs corresponding to the aggregated sums of polymatroids (as defined just before Proposition 4.11). Let $H_{1}=\left(V_{1} \sqcup\right.$ $\left.W_{1}, E_{1}\right)$ and $H_{2}=\left(V_{2} \sqcup W_{2}, E_{2}\right)$ be (disjoint) bipartite graphs. Let us form $H=$ $(V \sqcup W, E)$ by choosing arbitrary edges $e_{1}=\left(v_{1}, w_{1}\right) \in E_{1}$ and $e_{2}=\left(v_{2}, w_{2}\right) \in E_{2}$, and identifying $v_{1}$ and $v_{2}$ to a single vertex $v \in V$, also $w_{1}$ and $w_{2}$ to a single vertex $w \in W$, as well as identifying $e_{1}$ and $e_{2}$ to a single edge $e \in E$. It is not hard to see that the polymatroid $P_{H}$ is equal to the aggregated sum of $P_{H_{1}}$ and $P_{H_{2}}$. Precisely, for $\mathbf{a} \in P_{H_{1}}$ and $\mathbf{b} \in P_{H_{2}}$, let us define the vector $\mathbf{c}:=\mathbf{a} \boxplus \mathbf{b} \in \mathbb{Z}^{W}$ by $c_{u}=a_{u}$ for
$u \in W_{1} \backslash\left\{w_{1}\right\}, c_{u}=b_{u}$ for $u \in W_{2} \backslash\left\{w_{2}\right\}$, and $c_{w}=a_{w_{1}}+b_{w_{2}}$. Then it is not hard to see that $\mathbf{c}$ is in $P_{H}$ and that the above gives a bijection between $P_{H_{1}} \boxplus P_{H_{2}}$ and $P_{H}$ (see [Kal, Theorem 6.7] for details).

Thus by Proposition 4.11 (e), we get

$$
\begin{equation*}
\mathscr{T}_{P_{H}}(x, y)=\frac{\mathscr{T}_{P_{H_{1}}}(x, y) \mathscr{T}_{P_{H_{2}}}(x, y)}{x+y-1} \tag{25}
\end{equation*}
$$

Example 14.13. Let $H$ be the bipartite graph which is the 4 -cycle. Then $\vec{H}=$ $\vec{H}(G)$ is the hypergraph associated to the graph $G$ having two vertices and two edges between them. One has $T_{G}(x, y)=x+y$, hence by Theorem 5.2, $\mathcal{T}_{P_{H}}=$ $(x+y-1)(x+y)$. Therefore the polymatroid Tutte polynomial of both (isomorphic) hypergraphs derived from the bipartite graph is $(x+y)^{2}(x+y-1)$.
14.5. Polymatroid duality for planar hypergraphs. We now recall the connection between duality of plane bipartite graphs and their polymatroids. Let $H=(V \sqcup W, E)$ be a connected bipartite graph properly embedded in the plane, where this time we do allow multiple edges between elements of $V$ and $W$. Then there is a notion of a dual bipartite graph $H^{*}=\left(V^{\prime} \sqcup W, E^{\prime}\right)$, obtained as follows:

- Place a vertex in each face of $H$; this gives the vertex set $V^{\prime}$.
- For every $v^{\prime} \in V^{\prime}$, create an edge from $v^{\prime}$ to each vertex $w$ of $W$ incident to the face of $H$ containing $v^{\prime}$ (more precisely, an edge is created between $v^{\prime}$ and $w$ for each incidence of $w$ with the face containing $v^{\prime}$ ); this gives the edge set $E^{\prime}$.
This construction is illustrated in Figure 11. It is easy to see that $\left(H^{*}\right)^{*}=H$ for all $H$.

We stress again that the order of $V$ and $W$ is part of the structure of $H$, which makes $H$ equivalent to the hypergraph $\vec{H}$. By iterating the operations of transposition and duality, a total of six hypergraphs can be generated from any connected plane bipartite graph. (This idea goes back to Cori and Penaud [CP.) They form a structure called a trinity that was first studied by Tutte Tut1.


Figure 11. A pair of dual hypergraphs $\vec{H}, \vec{H}^{*}$ with hyperedge set $W=[3]$. The bipartite graph $H$, drawn solid, is isomorphic to that of Figure 8. The bipartite graph $H^{*}$ is drawn dashed, and the associated polymatroid $P_{H^{*}}$ is depicted on the right.

It is known Kal, Thm. 8.3] that the spanning hypertrees of $\vec{H}$ and $\vec{H}^{*}$ are in a one-to-one correspondence. The canonical bijection associates to a spanning hypertree $\mathbf{t}=\left(t_{w}\right)_{w \in W}$ of $\vec{H}$ the spanning hypertree $\mathbf{t}^{*}=\left(\operatorname{deg}(w)-1-t_{w}\right)_{w \in W}$, where $\operatorname{deg}(w)$ denotes the degree of the vertex $w$ in $H$. This shows that the polymatroids $P_{H}$ and $P_{H^{*}}$ are dual (in the sense of Section 3.4) to each other modulo a linear translation. More precisely, $P_{H^{*}}=-P_{H}+(\operatorname{deg}(w)-1)_{w \in W}$. Via Lemma 4.6, this implies the following.

Proposition 14.14. For any pair of planar dual hypergraphs $\vec{H}$ and $\vec{H}^{*}$, we have

$$
\mathscr{T}_{P_{H}}(x, y)=\mathscr{T}_{P_{H^{*}}}(y, x) .
$$

Example 14.15. Figure 11 shows two dual hypergraphs $\vec{H}, \vec{H}^{*}$ (with $H$ as in Figure 8). The reader can check that the polymatroid $P_{H^{*}}$ is the one represented at the right of Figure 11 , and that $P_{H^{*}}=-P_{H}+(2,3,4)$.

## 15. Tutte polynomials of hypergraphs

In this section we give a formula for the Tutte polynomial of a large family of hypergraphs. More precisely, given a simple bipartite graph $H=(V \sqcup W, E)$, we give a formula for the Tutte polynomial $\mathscr{T}_{P_{H^{+}}}(x, y)$, where $H^{+}=\left(V^{+} \sqcup W, E^{+}\right)$is the bipartite graph obtained from $H$ by adding a vertex $v^{+}$to $V$ that is adjacent to every vertex in $W$.

We first need some notation and definitions. For $v \in V$ and $F \subseteq E$, we let

$$
N_{F}(v)=\{w \in W \mid\{v, w\} \in F\}
$$

and we also let $N(v)=N_{E}(v)$ (which is also the set we denoted by $\vec{H}^{T}(v)$ earlier).
Definition 15.1. We say that a subset of edges $F \subseteq E$ is a draconian set if there is no vertex $v \in V$ such that $N_{F}(v)=W$, and for any collection $\left\{I_{1}, \ldots, I_{k}\right\}$ of non-empty subsets of $W$,

$$
\begin{equation*}
\#\left\{v \in V \mid N_{F}(v) \in\left\{I_{1}, \ldots, I_{k}\right\}\right\}<\left|I_{1} \cup \cdots \cup I_{k}\right| \tag{26}
\end{equation*}
$$

Remark 15.2. The term "draconian" in Definition 15.1. comes from the relation with Definition 7.1 of $n$-draconian sequences. Indeed, consider a subset of edges $F \subseteq E$ such that there is no vertex $v \in V$ with $N_{F}(v)=W$. We associate to $F$ the function $g_{F}: 2^{W} \backslash\{\varnothing\} \rightarrow \mathbb{Z}^{\geq 0}$ defined by

$$
\forall \varnothing \neq I \subsetneq W, g_{F}(I)=\#\left\{v \in V \mid N_{F}(v)=I\right\}
$$

and $g_{F}(W)=|W|-1-\sum_{\varnothing \neq I \subsetneq W} g_{F}(I)$. Then, $F$ is a draconian set if and only if $g_{F}$ is an $n$-draconian sequence (when identifying $W$ with $[n]$ ).

Lastly, for $v \in V$, and an ordered set partition $B=\left(B_{1}, \ldots, B_{\ell}\right)$ of $W$, we denote by $B(v) \subseteq W$ the block $B_{m}$, where $m=\max \left\{k \in[\ell] \mid N(v) \cap B_{k} \neq \varnothing\right\}$.
Theorem 15.3. Let $H=(V \sqcup W, E)$ be a simple bipartite graph without isolated vertex in $V$. Let $k \geq 0$ be the number of vertices in $V$ that are adjacent to every vertex of $W$. Let $\preceq$ be a total order on $W$. Then, with the above notation,

$$
\frac{\mathscr{T}_{P_{H^{+}}}(x, y)}{(x+y-1)}=\sum_{\substack{\text { draconian } \\ \text { sets } F \subseteq E}} \sum_{\substack{B \in \mathcal{B}_{W} \\ F \text {-compatible }}}\binom{k \mathbf{1}_{\ell(B)=1}-1}{|W|-|V(F)|-1}(-1)^{\ell(B)-1} x^{\operatorname{lr}(B)-1} y^{\mathrm{rl}(B)-1}
$$

where

- $V(F)=\left\{v \in V \mid N_{F}(v) \neq \varnothing\right\} ;$
- $\mathcal{B}_{W}$ is the set of ordered set partitions of $W$;
- $B \in \mathcal{B}_{W}$ is $F$-compatible if for all $v \in V(F)$, we have $N_{F}(v)=N(v) \cap B(v)$;
- for $B \in \mathcal{B}_{W}$, the value $\ell(B)$ is the number of blocks of $B$, and $\operatorname{lr}(B)$ (resp., $\operatorname{rl}(B))$ is the number of left-to-right (resp., right-to-left) minima of $B$ when elements of $W$ are compared using the fixed linear order $\preceq$. (The definition of these minima was given in Section 7.)

Note that the binomial coefficient in Theorem 15.3 is equal to $(-1)^{|W|-|V(F)|-1}$ except for the partition $B^{\circ}=(W)$ with a single block. Observe all that the total contribution of the partition $B^{\circ}$ is $-\mathscr{T}_{P_{H^{+}}}(0,0)$, which (according to Proposition $4.11(\mathrm{~g})$ ) is equal to the number of interior lattice points of $\mathcal{P}_{H^{+}}$.

Remark 15.4. In Theorem 15.3 we do not assume that $H$ is connected. Indeed $H^{+}$is always connected since $H$ has no isolated vertices in $V$. As explained in Section 14.3. we have

$$
\mathcal{P}_{H^{+}}=\sum_{\varnothing \neq I \subseteq W} m_{I} \Delta_{I}
$$

where $m_{I}=\#\{v \in V \mid N(v)=I\}$ and $\Delta_{I}=\operatorname{conv}\left(\mathbf{e}_{i} \mid i \in W\right)$. Hence Theorem 15.3 can equivalently be stated as a result for polymatroids which are Minkowski sums of simplices.

Proof. Let us identify the ordered set $(W, \preceq)$ with $[n]$, where $n=|W|$. As $\mathcal{P}_{H^{+}}=$ $\sum_{I \subseteq[n]} m_{I} \Delta_{I}$, where $m_{I}=\#\{v \in V \mid N(v)=I\}$, Theorem 7.3 (together with Remark 7.4) gives

$$
\begin{align*}
\frac{\mathscr{T}_{P_{H^{+}}}(x, y)}{x+y-1} & =\sum_{B \in \mathcal{B}_{n}} D_{n}\left(\left(m_{I}^{B}\right)\right)(-1)^{\ell(B)-1} x^{\operatorname{lr}(B)-1} y^{\mathrm{rl}(B)-1} \\
& =\sum_{B \in \mathcal{B}_{n}} \sum_{g: n \text {-draconian }}\binom{m_{[n]}^{B}-1}{g([n])} \prod_{\varnothing \neq I \subsetneq[n]}\binom{m_{I}^{B}}{g(I)} \operatorname{weight}(B), \tag{27}
\end{align*}
$$

where $\mathbf{m}=\left(m_{I}^{B}\right)$ is given by 18$)$ and $\operatorname{weight}(B)=(-1)^{\ell(B)-1} x^{\operatorname{lr}(B)-1} y^{\mathrm{rl}(B)-1}$. Observe that for all $\varnothing \neq I \subseteq[n]$

$$
m_{I}^{B}=\#\{v \in V \mid N(v) \cap B(v)=I\} .
$$

We now interpret the product of binomial coefficients in (27) combinatorially. For $B \in \mathcal{B}_{n}$, we denote by $\Omega(B)$ the set of tuples $\left(V_{I}\right)_{\varnothing \neq I \subsetneq[n]}$ such that $V_{I} \subseteq\{v \in$ $V \mid N(v) \cap B(v)=I\}$. For an $n$-draconian function $g$, we say that the tuple $\left(V_{I}\right) \in \Omega(B)$ is $g$-draconian if $\left|V_{I}\right|=g(I)$ for all non-empty subsets $I \subsetneq[n]$. Then the product

$$
\prod_{\varnothing \neq I \subsetneq[n]}\binom{m_{I}^{B}}{g(I)}
$$

clearly equals the number of $g$-draconian tuples $\left(V_{I}\right)$ in $\Omega(B)$. For any tuple $\mathbf{V}=$ $\left(V_{I}\right) \in \Omega(B)$, the subsets $V_{I}$ are necessarily all disjoint. We can therefore associate to $\mathbf{V}$ a subset of edges

$$
F_{\mathbf{V}}:=\biguplus_{I \subsetneq[n]}\left\{\{v, w\} \mid v \in V_{I}, w \in I\right\} \subseteq E .
$$

It is easy to see that $F_{\mathbf{V}}$ is a draconian set if and only if $\mathbf{V}$ is draconian, that is, $g$-draconian for some $n$-draconian function $g$. Furthermore the mapping $\mathbf{V} \mapsto F_{V}$ is clearly a bijection between the set of draconian tuples $\mathbf{V}$ in $\Omega(B)$, and the set of draconian sets $F \subseteq E$ such that $B$ is $F$-compatible. Thus,

$$
\begin{aligned}
\frac{\mathscr{T}_{P_{H^{+}}}(x, y)}{x+y-1} & =\sum_{B \in \mathcal{B}_{n}} \sum_{g: n \text {-draconian }} \sum_{\substack{\mathbf{V} \in \Omega(B) \\
g \text {-draconian }}}\binom{m_{[n]}^{B}-1}{g([n])} \text { weight }(B) \\
& =\sum_{B \in \mathcal{B}_{n}} \sum_{\substack{F \subseteq E: \text { draconian set } \\
\text { such that } B \text { is } F \text {-compatible }}}\binom{m_{[n]}^{B}-1}{n-|V(F)|-1} \text { weight }(B),
\end{aligned}
$$

where the second equality comes from the fact that a $g$-draconian tuple $\mathbf{V}$ satisfies

$$
g([n])=n-1-\sum_{\varnothing \neq I \subsetneq[n]} g(I)=n-\left|V\left(F_{\mathbf{V}}\right)\right|-1
$$

Reordering the sums, and observing $m_{[n]}^{B}=k \mathbf{1}_{\ell(B)=1}$, gives the theorem.

## 16. Tutte polynomials of graphical zonotopes

In this section we use the formula of the universal Tutte polynomial (precisely, Theorem 15.3 in order to compute the polymatroid Tutte polynomials of graphical zonotopes. It turns out that for any graph $G$, the polymatroid Tutte polynomial of the zonotope of $G$ is a specialization of the classical Tutte polynomial of $G$.

Recall that for a loopless graph $G=(W, E)$ (with at least one edge), the zonotope of $G$ is the polytope $\mathcal{Z}(G) \subset \mathbb{R}^{W}$ obtained as the following Minkowski sum of line segments:

$$
\mathcal{Z}(G)=\sum_{\{i, j\} \subseteq W} m_{\{i, j\}}\left[\mathbf{e}_{i}, \mathbf{e}_{j}\right]
$$

where $m_{\{i, j\}}$ is the number of edges of $G$ with endpoints $\{i, j\}$. Recall from Remark 14.12 that $Z(G):=\mathcal{Z}(G) \cap \mathbb{Z}^{W}$ is a hypergraphical matroid.
Theorem 16.1. Let $G=(W, E)$ be a loopless graph with $k$ connected components, and at least one edge. Let $\mathcal{Z}(G)$ be the zonotope associated to $G$. The polymatroid Tutte polynomial of $Z(G):=\mathcal{Z}(G) \cap \mathbb{Z}^{W}$ is given in terms of the classical Tutte polynomial of the graph $G$ by

$$
\mathscr{T}_{Z(G)}(x, y)=(x+y-1)^{k} T_{G}(x+y, 1) .
$$

Equivalently,

$$
\mathscr{T}_{Z(G)}(x, y)=\sum_{F: \text { spanning forest of } G}(x+y-1)^{\# \text { connected components of } F},
$$

where the sum is over the subset of edges $F \subseteq E$ such that the subgraph $G_{F}=(W, F)$ has no cycle.

Example 16.2. The classical permutohedron $\Pi_{n}=\operatorname{conv}((w(1), \ldots, w(n)) \mid w \in$ $\left.S_{n}\right)$ is a graphical zonotope. More precisely, $\Pi_{n}=(1,1, \ldots, 1)+\mathcal{Z}\left(K_{n}\right)$, where $K_{n}$ is the complete graph on $n$ vertices. Hence, by Theorem 16.1 ,

$$
\mathscr{T}_{\Pi_{n} \cap \mathbb{Z}^{n}}(x, y)=\sum_{F}(x+y-1)^{\# \text { connected components of } F}
$$

where the sum is over forests (i.e. acyclic graphs) with vertex set $[n]$. For instance, $\mathscr{T}_{\Pi_{3} \cap \mathbb{Z}^{3}}(x, y)=(x+y-1)^{3}+3(x+y-1)^{2}+3(x+y-1)$, and

$$
\mathscr{T}_{\Pi_{4} \cap \mathbb{Z}^{4}}(x, y)=(x+y-1)^{4}+6(x+y-1)^{3}+15(x+y-1)^{2}+16(x+y-1)
$$

Remark 16.3. Specializing Theorem 16.1 at $x=y=1$ gives $|Z(G)|=T_{G}(2,1)$. The reader will recognize that this is a well known specialization of the Tutte polynomial Sta1] upon remembering that the points of $Z(G)$ are in clear bijection with the outdegree sequences of the orientations of $G$. The specialization $x=0, y=1$ also gives a classical result via Proposition 4.11(h), namely that the specialization $T_{G}(1,1)$ counts root-connected outdegree sequences of $G$. As we explain in Section 18.4 , the case $y=1$ of Theorem 16.1 can in fact be deduced from a relation proven in $[\mathrm{KP}]$ between the interior polynomial of a hypergraph and its transpose.
Proof. The case $|W|=2$ can be treated by hand, and we now assume $|W|>2$. Let $H_{G}=\left(V \sqcup W, E^{\prime}\right)$ be the bipartite graph obtained from $G=(W, E)$ by inserting a vertex $v_{e} \in V$ in the middle of each edge $e \in E$ (in other words, each edge $e \in E$ is replaced by a path of length 2). By Remark $14.12, Z(G)=P_{H_{G}^{+}}$. Hence Theorem 15.3 gives

$$
\frac{\mathscr{T}_{Z(G)}(x, y)}{(x+y-1)}=\sum_{\substack{F^{\prime} \subseteq E^{\prime} \\ \text { draconian set }}} \sum_{\substack{B \in \mathcal{B}_{W} \\ F^{\prime} \text { compatible }}}(-1)^{|W|-\left|V\left(F^{\prime}\right)\right|-1}(-1)^{\ell(B)-1} x^{\operatorname{lr}(B)-1} y^{\mathrm{rl}(B)-1}
$$

where we have used $k=0$ (which holds because $|W|>2$ ).
Next we observe that the draconian sets $F^{\prime} \subseteq E^{\prime}$ are in bijection with the spanning forests of $G$. Indeed, observe that if $F^{\prime} \subseteq E^{\prime}$ is a draconian set, then any vertex $v \in V$ is incident to either 0 or 2 edges from $F^{\prime}$ (because if we had $N_{F^{\prime}}(v)=\{w\}$, then the draconian condition (26) would be violated for $I_{1}=\{w\}$ ). Hence, to any draconian set $F^{\prime} \subseteq E^{\prime}$, we can bijectively associate the subset of edges $F=\left\{e \in E \mid N_{F^{\prime}}\left(v_{e}\right)=2\right\}$. Furthermore, it is not hard to see that $F^{\prime} \subset E^{\prime}$ is draconian if and only $F$ is a forest (because if $F$ had a cycle then $F^{\prime}$ would violate the draconian condition 26).

We also observe that a partition $B \in \mathcal{B}_{W}$ is $F^{\prime}$-compatible if and only if for all $e \in F$, the endpoints of $e$ are in the same block of $B$. In other words, denoting by $C_{F}$ the unordered partition of $W$ whose blocks correspond to the connected components of $F$, we see that $B \in \mathcal{B}_{W}$ is $F^{\prime}$-compatible if and only if $B$ is a coarsening of $C_{F}$.

Hence we get

$$
\mathscr{T}_{Z(G)}(x, y)=\sum_{\substack{F \subseteq E \\ \text { forest }}}(-1)^{k(F)} \sum_{\substack{B \in \mathcal{B}_{W} \\ \text { coarsening of } C_{F}}}(-1)^{\ell(B)}(x+y-1) x^{\operatorname{lr}(B)-1} y^{\mathrm{rl}(B)-1},
$$

where $k(F)=|W|-\left|V\left(F^{\prime}\right)\right|$ is the number of connected components of $F$. Moreover it is clear that the inner sum only depends on $k(F)$, and is equal to

$$
\sum_{B \in \mathcal{B}_{k(F)}}(-1)^{\ell(B)}(x+y-1) x^{\operatorname{lr}(B)-1} y^{\mathrm{rl}(B)-1}
$$

We now show that this sum is equal to $(1-x-y)^{k(F)}$ using some well-known combinatorial tricks (see for instance [Sta2, Chapter 1]). Let $\mathcal{C}_{k}$ be the set of unordered set partitions of $[k]$. First, let us compute the contribution of the ordered set partitions $B \in \mathcal{B}_{k}$ corresponding to a given unordered partition $C \in \mathcal{C}_{k}$ with $\ell$
blocks. For a permutation $w \in S_{\ell}$, we denote by $\operatorname{lr}(w)$ (resp., by $\left.\operatorname{rl}(w)\right)$ the number of left-to-right (resp., right-to-left) minima of $w$ :
$\operatorname{lr}(w)=\#\{i \in[\ell] \mid \forall j<i, w(i)<w(j)\}$ and $\operatorname{rl}(w)=\#\{i \in[\ell] \mid \forall j>i, w(i)<w(j)\}$.
It is easy to see that

$$
\sum_{\substack{B \in \mathcal{B}_{k} \\ \text { ordering of } C}}(x+y-1) x^{\operatorname{lr}(B)-1} y^{\mathrm{rl}(B)-1}=\sum_{w \in S_{\ell}}(x+y-1) x^{\operatorname{lr}(w)-1} y^{\mathrm{rl}(w)-1}=(x+y-1)^{(\ell)}
$$

where $u^{(\ell)}:=u(u+1) \cdots(u+\ell-1)$ (the second equality is justified by considering the insertion process producing the permutation $w$ seen as a word of $\ell$ letters). Moreover we have

$$
\sum_{C \in \mathcal{C}_{k}}(-1)^{\ell(C)} u^{(\ell(C))}=\sum_{C \in \mathcal{C}_{k}}(-u)_{(\ell(C))}=(-u)^{k}
$$

where $u_{(\ell)}:=u(u-1) \cdots(u-\ell+1)$ (the second equality is justified by recognizing that for $u \in \mathbb{Z}_{<0}$, both sides count the colorings of the set $[-u]$ by $k$ colors). Hence

$$
\sum_{B \in \mathcal{B}_{k}}(-1)^{\ell(B)}(x+y-1) x^{\operatorname{lr}(B)-1} y^{\mathrm{rl}(B)-1}=\sum_{C \in \mathcal{C}_{k}}(-1)^{\ell(C)}(x+y-1)^{(\ell(C))}=(1-x-y)^{k},
$$

as claimed. This completes the proof.

## 17. Boxed Tutte polynomials of hypergraphs and boxed polymatroids

Most polymatroids that one encounters (for instance, usual matroids and hypergraphical polymatroids) satisfy natural lower and upper bounds on the components of their elements (e.g., non-negativity). We now incorporate this in our theory by defining boxed polymatroids and their Tutte polynomials.
17.1. Boxed polymatroids and boxed Tutte polynomials. A box for a polymatroid $P \subset \mathbb{Z}^{n}$ is a pair of tuples $\boldsymbol{\alpha}=\left(\alpha_{1}, \ldots, \alpha_{n}\right)$ and $\boldsymbol{\beta}=\left(\beta_{1}, \ldots, \beta_{n}\right) \in \mathbb{Z}^{n}$ such that every point $\mathbf{a}$ in $P$ satisfies $\boldsymbol{\alpha} \leq \mathbf{a} \leq \boldsymbol{\beta}$, where inequalities are taken componentwise. In other words, $P$ is contained in the product of intervals $\prod_{i}\left[\alpha_{i}, \beta_{i}\right]$. A boxed polymatroid is a triple $(P, \boldsymbol{\alpha}, \boldsymbol{\beta})$, where $P$ is a polymatroid and $(\boldsymbol{\alpha}, \boldsymbol{\beta})$ is a box for $P$.

We now define the boxed Tutte polynomial of the boxed polymatroid ( $P, \boldsymbol{\alpha}, \boldsymbol{\beta}$ ). Recall from Section 10 the notation $w t(\mathbf{c})=u^{d_{1}^{>}(P, \mathbf{c})} v^{d_{1}^{<}(P, \mathbf{c})}$ for $\mathbf{c} \in \mathbb{Z}^{n}$. The boxed Tutte polynomial of $(P, \boldsymbol{\alpha}, \boldsymbol{\beta})$ is then defined as

$$
\begin{equation*}
\widetilde{\mathscr{T}}_{(P, \boldsymbol{\alpha}, \boldsymbol{\beta})}(u, v)=\sum_{\mathbf{c} \in \mathbb{Z}^{n}, \boldsymbol{\alpha} \leq \mathbf{c} \leq \boldsymbol{\beta}} w t(\mathbf{c}) \tag{28}
\end{equation*}
$$

observe that the invariant $\widetilde{\mathscr{T}}_{P}(u, v)=\sum_{\mathbf{c} \in \mathbb{Z}^{n}} w t(\mathbf{c})$ of Section 10 is the limit (in the sense of formal power series in $u, v)$ of $\widetilde{\mathscr{T}}_{(P, \boldsymbol{\alpha}, \boldsymbol{\beta})}(u, v)$ as $\alpha_{1}, \ldots, \alpha_{n} \rightarrow-\infty$ and $\beta_{1}, \ldots, \beta_{n} \rightarrow+\infty$.

It is clear that the boxed Tutte polynomial satisfies the translation invariance:

$$
\text { for all } \mathbf{c} \in \mathbb{Z}^{n}, \widetilde{\mathscr{T}}_{(P+\mathbf{c}, \boldsymbol{\alpha}+\mathbf{c}, \boldsymbol{\beta}+\mathbf{c})}(u, v)=\widetilde{\mathscr{T}}_{(P, \boldsymbol{\alpha}, \boldsymbol{\beta})}(u, v)
$$

the $S_{n}$-invariance:

$$
\text { for all } w \in S_{n}, \quad \widetilde{\mathscr{T}}_{(w(P), w(\boldsymbol{\alpha}), w(\boldsymbol{\beta}))}(u, v)=\widetilde{\mathscr{T}}_{(P, \boldsymbol{\alpha}, \boldsymbol{\beta})}(u, v)
$$

and the duality relation:

$$
\widetilde{\mathscr{T}}_{(-P,-\boldsymbol{\beta},-\boldsymbol{\alpha})}(u, v)=\widetilde{\mathscr{T}}_{(P, \boldsymbol{\alpha}, \boldsymbol{\beta})}(v, u) .
$$

The boxed Tutte polynomial is closely related to the classical Tutte polynomial of matroids. By Remark [3.3, matroids on the ground set $[n]$ can be identified with boxed polymatroids of the form $\left(P, 0^{n}, 1^{n}\right)$, where $0^{n}:=(0, \ldots, 0)$ and $1^{n}:=$ $(1, \ldots, 1)$. Moreover, it follows from Remark 10.4 (together with the corank-nullity formula (3) for the Tutte polynomial of $M$ ) that

$$
T_{M}(x, y)=\widetilde{\mathscr{T}}_{\left(P(M), 0^{n}, 1^{n}\right)}(x-1, y-1)
$$

Next, we express the boxed Tutte polynomial $\widetilde{\mathscr{T}}_{(P, \boldsymbol{\alpha}, \boldsymbol{\beta})}$ in terms of internal and external activities.

Proposition 17.1. For any boxed polymatroid $(P, \boldsymbol{\alpha}, \boldsymbol{\beta})$ in $\mathbb{Z}^{n}$,

$$
\widetilde{\mathscr{T}}_{(P, \boldsymbol{\alpha}, \boldsymbol{\beta})}(u, v)=\sum_{\mathbf{a} \in P} \prod_{i=1}^{n}\left(1+\mathbf{1}_{i \in \operatorname{Int}(\mathbf{a})} \frac{u\left(1-u^{a_{i}-\alpha_{i}}\right)}{(1-u)}+\mathbf{1}_{i \in \operatorname{Ext}(\mathbf{a})} \frac{v\left(1-v^{\beta_{i}-a_{i}}\right)}{(1-v)}\right)
$$

where $\mathbf{1}_{\text {condition }}$ denotes the characteristic function, which is equal to 1 if the condition is true and 0 otherwise.

Proof. This is analogous to the proof of Theorem 10.6. The decomposition $\mathbb{Z}^{n}=$ $\biguplus_{\mathbf{a} \in P} C_{P}(\mathbf{a})$ from Theorem 9.3 gives

$$
\widetilde{\mathscr{T}}_{(P, \boldsymbol{\alpha}, \boldsymbol{\beta})}(u, v)=\sum_{\mathbf{a} \in P} \sum_{\mathbf{c} \in C_{P}(\mathbf{a}), \boldsymbol{\alpha} \leq \mathbf{c} \leq \boldsymbol{\beta}} w t_{P}(\mathbf{c}) .
$$

Moreover, Theorem 9.3(2) together with Lemma 10.3 yield

$$
\sum_{\mathbf{c} \in C_{P}(\mathbf{a}), \boldsymbol{\alpha} \leq \mathbf{c} \leq \boldsymbol{\beta}} w t_{P}(\mathbf{c})=\prod_{i=1}^{n} \tilde{m}_{i}(\mathbf{a})
$$

where

$$
\tilde{m}_{i}(\mathbf{a})=\left\{\begin{array}{cl}
1 & \text { if } i \notin \operatorname{Int}(\mathbf{a}) \cup \operatorname{Ext}(\mathbf{a}), \\
\sum_{k=0}^{a_{i}-\alpha_{i}} u^{k} & \text { if } i \in \operatorname{Int}(\mathbf{a}) \backslash \operatorname{Ext}(\mathbf{a}), \\
\sum_{k=0}^{\beta_{i}-a_{i}} v^{k} & \text { if } i \in \operatorname{Ext}(\mathbf{a}) \backslash \operatorname{Int}(\mathbf{a}) \\
1+\sum_{k=1}^{a_{i}-\alpha_{i}} u^{k}+\sum_{k=1}^{\beta_{i}-a_{i}} v^{k} & \text { if } i \in \operatorname{Int}(\mathbf{a}) \cap \operatorname{Ext}(\mathbf{a})
\end{array}\right.
$$

Finally, observing $\sum_{k=0}^{a_{i}-\alpha_{i}} u^{k}=1+\frac{u\left(1-u^{a_{i}-\alpha_{i}}\right)}{1-u}$ and $\sum_{k=0}^{\beta_{i}-a_{i}} v^{k}=1+\frac{v\left(1-v^{\beta_{i}-a_{i}}\right)}{1-v}$ proves the stated relation.

We can also derive expressions for the boxed Tutte polynomial in the spirit of Theorem 11.5 Indeed, using the shadow decomposition of Theorem 12.2 and proceeding as in the proof of Theorem 11.5, one gets:

Proposition 17.2. For any boxed polymatroid $(P, \boldsymbol{\alpha}, \boldsymbol{\beta})$ in $\mathbb{Z}^{n}$,

$$
\widetilde{\mathscr{T}}_{(P, \boldsymbol{\alpha}, \boldsymbol{\beta})}(u, v)=\sum_{\mathbf{a} \in S^{u p}(P), \boldsymbol{\alpha} \leq \mathbf{a} \leq \boldsymbol{\beta}} v^{\operatorname{level}(\mathbf{a})-\operatorname{level}(P)} \prod_{i \in[n]}\left(1+\mathbf{1}_{i \in \widetilde{\operatorname{Int}(\mathbf{a})}} \frac{u\left(1-u^{a_{i}-\alpha_{i}}\right)}{1-u}\right)
$$

and
$\widetilde{\mathscr{T}}_{(P, \boldsymbol{\alpha}, \boldsymbol{\beta})}(u, v)=\sum_{\mathbf{a} \in S^{\text {low }}(P), \boldsymbol{\alpha} \leq \mathbf{a} \leq \boldsymbol{\beta}} u^{\operatorname{level}(P)-\operatorname{level}(\mathbf{a})} \prod_{i \in[n]}\left(1+\mathbf{1}_{i \in \widetilde{\operatorname{Ext}}(\mathbf{a})} \frac{v\left(1-v^{\beta_{i}-a_{i}}\right)}{1-v}\right)$.
17.2. Boxed Tutte polynomials of hypergraphs. Let $H=(V \sqcup W, E)$ be a connected bipartite graph, and let $\vec{H}$ be the corresponding hypergraph. We first recall and generalize the notion of spanning hypertrees of $\vec{H}$.

Let $\mathcal{S}$ be the set of subgraphs of $H$ which contain every vertex of $H$ and at least one edge incident to each right vertex $w \in W$. For a subgraph $S \in \mathcal{S}$ we denote by $\mathbf{c}_{S} \in \mathbb{Z}^{W}$ the tuple $\left(c_{w}\right)_{w \in W}$ where for all right vertex $w \in W, c_{w}$ is equal to the number of edges of $S$ incident to the vertex $w$ minus 1. Recall from Section 14 that a spanning hypertree of $\vec{H}$ is a point of the form $\mathbf{c}_{T} \in \mathbb{Z}^{W}$ for a spanning tree $T \in \mathcal{S}$ of $H$. Similarly, we call spanning hypergraph (resp. spanning hyperforest, spanning hyperconnex) of $\vec{H}$ a point of the form $\mathbf{c}_{S} \in \mathbb{Z}^{W}$ for a subgraph (resp. acyclic subgraph, connected subgraph) $S \in \mathcal{S}$.

Remark 17.3. Suppose that the bipartite graph $H$ is such that every right vertex $w \in W$ has degree 2. In this case we can identify the hypergraph $\vec{H}$ with the graph $G=\left(V, E^{\prime}\right)$ obtained by replacing every right vertex $w \in W$ and the incident edges by a single edge joining the vertices adjacent to $w$. Observe that in this context, the set of spanning hypersubgraphs (resp. hyperforests, hyperconnexes, hypertrees) of $\vec{H}$ is in obvious bijection with the set of spanning subgraphs (resp. forests, connected subgraphs, trees) of $G$.

As in Section 14 , we denote by $P_{H}$ the polymatroid whose elements are the spanning hypertrees of $\vec{H}$. In symbols,

$$
P_{H}:=\left\{\mathbf{c}_{T} \mid T \in \mathcal{T}\right\}
$$

where $\mathcal{T} \subset \mathcal{S}$ is the set of spanning trees of $H$. Clearly the pair $\left(0^{W}, \mathbf{c}_{H}\right)$ is a box for the polymatroid $P_{H}$. In fact, the set

$$
\operatorname{Box}_{H}:=\left\{\mathbf{c} \in \mathbb{Z}^{W} \quad \mid 0^{W} \leq \mathbf{c} \leq \mathbf{c}_{H}\right\}
$$

is clearly equal to the set of spanning hypersubgraphs of $\vec{H}$. Moreover, $S^{\text {low }}\left(P_{H}\right) \cap$ $\operatorname{Box}_{H}$ is the set of spanning hyperforests of $\vec{H}$, and $S^{\text {up }}\left(P_{H}\right) \cap \operatorname{Box}_{H}$ is the set of spanning hyperconnexes. In particular, we obtain the following evaluations of the boxed Tutte polynomial:

$$
\begin{aligned}
& \widetilde{\mathscr{T}}_{\left(P_{H}, 0^{W}, \mathbf{c}_{H}\right)}(0,0)=\text { \#spanning hypertrees, } \\
& \widetilde{\mathscr{T}}_{\left(P_{H}, 0^{W}, \mathbf{c}_{H}\right)}(0,1)=\text { \#spanning hyperconnexes, } \\
& \widetilde{\mathscr{T}}_{\left(P_{H}, 0^{W}, \mathbf{c}_{H}\right)}(1,0)=\text { \#spanning hyperforests, } \\
& \widetilde{\mathscr{T}}_{\left(P_{H}, 0^{W}, \mathbf{c}_{H}\right)}(1,1)=\text { \#spanning hypersubgraphs }=\prod_{w \in W} \operatorname{deg}(w) .
\end{aligned}
$$

In fact, Proposition 17.2 further gives

$$
\widetilde{\mathscr{T}}_{\left(P_{H}, 0^{W}, \mathbf{c}_{H}\right)}(0, v)=\sum_{\mathbf{c} \text { spanning hyperconnex }} v^{\operatorname{level}(\mathbf{c})-\operatorname{level}(P)},
$$

and

$$
\widetilde{\mathscr{T}}_{\left(P_{H}, 0^{W}, \mathbf{c}_{H}\right)}(u, 0)=\sum_{\text {cspanning hyperforest }} u^{\operatorname{level}(P)-\operatorname{level}(\mathbf{c})}
$$

We now relate the weight $w t_{P}(\mathbf{c})$ to the corank and nullity of the subgraphs of $H$. Consider the matroid $M_{H}$ (with ground set $E$ ) associated to the graph $H$ : the bases of $M_{H}$ are the spanning trees of $H$ (considered as subsets of $E$ ). Every spanning subgraph $S \in \mathcal{S}$ can be identified with a subset of $E$, whose corank and nullity in the matroid $M_{H}$ are given by

$$
\operatorname{cork}(S)=\min \{|T \backslash S| \mid T \in \mathcal{T}\} \quad \text { and } \quad \operatorname{null}(S)=\min \{|S \backslash T| \mid T \in \mathcal{T}\}
$$

respectively.
Lemma 17.4. For all $\mathbf{c} \in \operatorname{Box}_{H}$ we have

$$
d_{1}^{>}(P, \mathbf{c})=\min \left\{\operatorname{cork}(S) \mid S \in \mathcal{S}, \mathbf{c}_{S}=\mathbf{c}\right\}
$$

and dually

$$
d_{1}^{<}(P, \mathbf{c})=\min \left\{\operatorname{null}(S) \mid S \in \mathcal{S}, \mathbf{c}_{S}=\mathbf{c}\right\}
$$

Proof. We prove the identity for $d_{1}^{>}(P, \mathbf{c})$, the other one being symmetric. Let $m=\min \left\{\operatorname{cork}(S) \mid S \in \mathcal{S}, \mathbf{c}_{S}=\mathbf{c}\right\}$. We first show $d_{1}^{>}(P, \mathbf{c}) \leq m$. Let $S \in \mathcal{S}$ be such that $\mathbf{c}_{S}=\mathbf{c}$ and let $T \in \mathcal{T}$. Clearly $d_{1}^{>}(P, \mathbf{c}) \leq d_{1}^{>}\left(\mathbf{c}_{T}, \mathbf{c}_{S}\right) \leq|T \backslash S|$. Since by definition, $m=\min \left\{|T \backslash S| \mid T \in \mathcal{T}, S \in \mathcal{S}, \mathbf{c}_{S}=\mathbf{c}\right\}$, this gives $d_{1}^{>}(P, \mathbf{c}) \leq m$.

We now show $d_{1}^{>}(P, \mathbf{c}) \geq m$. Let $T \in \mathcal{T}$ be such that $d_{1}^{>}(P, \mathbf{c})=d_{1}^{>}\left(\mathbf{c}_{T}, \mathbf{c}\right)$. It is clearly possible to remove $d_{1}^{>}\left(\mathbf{c}_{T}, \mathbf{c}\right)$ edges from $T$ and then add $d_{1}^{>}\left(\mathbf{c}_{T}, \mathbf{c}\right)$ edges so as to obtain a subgraph $S \in \mathcal{S}$ such that $\mathbf{c}=\mathbf{c}_{S}$. Moreover $m \leq \operatorname{cork}(S) \leq$ $|T \backslash S|=d_{1}^{>}\left(\mathbf{c}_{T}, \mathbf{c}_{S}\right)=d_{1}^{>}(P, \mathbf{c})$.

Lemma 17.4 allows us to rewrite 28 in the context of hypergraphs:

$$
\widetilde{\mathscr{T}}_{\left(P_{H}, 0^{W}, \mathbf{c}_{H}\right)}(u, v)=\sum_{\begin{array}{c}
\mathbf{c} \text { spanning }  \tag{29}\\
\text { hypersubgraph of } H
\end{array}} u^{\min \left\{\operatorname{cork}(S) \mid S \in \mathcal{S}, \mathbf{c}_{S}=\mathbf{c}\right\}} v^{\min \left\{\operatorname{null}(S) \mid S \in \mathcal{S}, \mathbf{c}_{S}=\mathbf{c}\right\}}
$$

Remark 17.5. In the case when the hypergraph $H$ identifies with a graph $G=$ $\left(V, E^{\prime}\right)$ in the sense of Remark 17.3 , both exponents in 29 are minima of singletons and (29) reduces to a familiar expression for the Tutte polynomial of $G$ :

$$
\widetilde{\mathscr{T}}_{\left(P_{H}, 0^{W}, \mathbf{c}_{H}\right)}(u, v)=\sum_{S^{\prime} \subseteq E^{\prime}} u^{\operatorname{cork}\left(S^{\prime}\right)} v^{\operatorname{null}\left(S^{\prime}\right)}=T_{G}(u+1, v+1)
$$

Remember now the definition of duality of planar hypergraphs as defined in Section 14. Let $H$ be a plane hypergraph and let $H^{*}$ be its dual. Since $P_{H^{*}}=$ $-P_{H}+\mathbf{c}_{H}$, we know that

$$
\widetilde{\mathscr{T}}_{\left(P_{\left.H^{*}, 0^{W}, \mathbf{c}_{H}\right)}\right.}(u, v)={\widetilde{\mathscr{T}}\left(P_{H}, 0^{W}, \mathbf{c}_{H}\right)}(v, u)
$$

In fact, the mapping $\phi: \operatorname{Box}_{H} \rightarrow \operatorname{Box}_{H}$ defined by $\phi(\mathbf{c})=\mathbf{c}_{H}-\mathbf{c}$ is a bijection between the hypersubgraphs of $H$ and those of $H^{*}$ exchanging $d_{1}^{<}$and $d_{1}^{>}$. Denoting by $\mathcal{S}^{*}$, cork $^{*}$, and null ${ }^{*}$, respectively, the analogues of $\mathcal{S}$, cork, and null for the hypergraph $H^{*}$, Lemma 17.4 gives, for all $\mathbf{c} \in \operatorname{Box}_{H}$,

$$
\min \left\{\operatorname{cork}(S) \mid S \in \mathcal{S}, \mathbf{c}_{S}=\mathbf{c}\right\}=\min \left\{\operatorname{null}^{*}(S) \mid S \in \mathcal{S}^{*}, \mathbf{c}_{S}=\mathbf{c}_{H}-\mathbf{c}\right\}
$$

and dually

$$
\min \left\{\operatorname{null}(S) \mid S \in \mathcal{S}, \mathbf{c}_{S}=\mathbf{c}\right\}=\min \left\{\operatorname{cork}^{*}(S) \mid S \in \mathcal{S}^{*}, \mathbf{c}_{S}=\mathbf{c}_{H}-\mathbf{c}\right\}
$$

## 18. Concluding remarks and questions

We conclude with some open questions about the polymatroid Tutte polynomial and some directions for future research.
18.1. Trivariate Tutte polynomial and mixed Tutte polynomials. One consequence of the existence of the universal Tutte polynomial $\mathscr{T}_{n}$ is that for every polymatroid $P$, there exists a three-variable polynomial $\mathscr{T}_{P}(x, y ; u)$ such that for every non-negative integer $k$ we have

$$
T_{P}(x, y ; k)=T_{k P}(x, y)
$$

where $k P=\left\{\left(k a_{1}, \ldots, k a_{n}\right) \mid \mathbf{a} \in P\right\}$ denotes the $k$-dilation of $P$. Indeed, if $P$ has rank function $f$, then $k P$ has rank function $k f$. Hence the polynomial $\mathscr{T}_{P}(x, y ; u)$ is obtained from $\mathscr{T}_{n}\left(x, y,\left(z_{I}\right)\right)$ by substituting each variable $z_{I}$ by $u f(I)$. Note that this trivariate invariant inherits from $\mathscr{T}_{n}$ the translation invariance property $\mathscr{T}_{\mathbf{c}+P}(x, y ; u)=\mathscr{T}_{P}(x, y ; u)$, the $S_{n}$-invariance property $\mathscr{T}_{w(P)}(x, y ; u)=$ $\mathscr{T}_{P}(x, y ; u)$, and the duality relation $\mathscr{T}_{-P}(x, y ; u)=\mathscr{T}_{P}(y, x ; u)$. One might wonder about other properties of this invariant. For instance, are there nice combinatorialreciprocity properties when evaluating the variable $u$ at negative integers? We can also ask what information is captured by the trivariate polynomial $\mathscr{T}_{P}(x, y ; u)$, compared to $\mathscr{T}_{P}(x, y)=\mathscr{T}_{P}(x, y ; 1)$ (in particular when $P=P(M)$ is associated to a matroid $M$ ).

One can generalize the preceding idea to tuples of polymatroids. For polymatroids $P_{1}, \ldots, P_{d}$, there exists a unique $(k+2)$-variate mixed Tutte polynomial $\mathscr{T}_{P_{1}, \ldots, P_{d}}\left(x, y ; u_{1}, \ldots, u_{d}\right)$ such that for any tuple $\left(k_{1}, \ldots, k_{d}\right)$ of positive integers,

$$
\mathscr{T}_{P_{1}, \ldots, P_{d}}\left(x, y ; k_{1}, \ldots, k_{d}\right)=\mathscr{T}_{k_{1} P_{1}+\cdots+k_{d} P_{d}}(x, y) .
$$

Indeed, remembering the identity $P_{f}+P_{g}=P_{f+g}$, we see that the above polynomial is given by

$$
\mathscr{T}_{P_{1}, \ldots, P_{d}}\left(x, y ; u_{1}, \ldots, u_{d}\right)=\mathscr{T}_{n}\left(x, y,\left(u_{1} f_{1}(I)+\cdots+u_{d} f_{d}(I)\right)\right),
$$

where $f_{1}, \ldots, f_{d}$ are the rank functions of $P_{1}, \ldots, P_{d}$, respectively. Note that the Cameron-Fink polynomial $\mathscr{Q}_{P}(x, y)$ is equal to $\mathscr{T}_{P, \nabla, \Delta}(1,1 ; 1, x, y)$. Hence by Theorem 13.2 the specializations $\mathscr{T}_{P, \nabla, \Delta}(x, y ; 1,0,0)$ and $\mathscr{T}_{P, \nabla, \Delta}(1,1 ; 1, u, v)$ capture the same information about $P$. Again it would be interesting to study the properties of the mixed Tutte polynomials in general, or in the restricted context of matroids.
18.2. Polymatroid analogues for properties of the classical Tutte polynomial. The classical Tutte polynomial is known to enjoy many remarkable properties, and it is natural to wonder if these properties generalize to the polymatroid setting. For instance, does the convolution formula of [KRS] admit a generalization to the polymatroid setting? Also, can we consider more general notions of activities for the bases of a polymatroid in the spirit of GM?

Let us now focus on the deletion-contraction formula. Recall that for a matroid $M$ on the ground set [ $n$ ], and an element $i \in[n]$, one has $T_{M}(x, y)=y T_{M \backslash i}(x, y)$ if $i$ is a loop, $T_{M}(x, y)=y T_{M / i}(x, y)$ if $i$ is a coloop, and

$$
T_{M}(x, y)=T_{M \backslash i}(x, y)+T_{M / i}(x, y)
$$

if $i$ is neither a loop nor a coloop of $M$. These relations clearly determine $T_{M}(x, y)$, and they play an important role in the theory of the Tutte polynomial because the

Tutte polynomial is in fact "universal" among matroid invariants satisfying linear deletion-contraction relations (see, e.g., [Bol]). We also note that the "multivariate" Tutte polynomials of $\overline{B R}, \overline{Z a s}, \mathrm{ET}$, Sok are defined by adding more parameters to the deletion-contraction recurrence.

As we now explain, Property 4.11 (f) is a partial generalization of the deletioncontraction formula to the polymatroid setting. Let $f$ let the rank function of the polymatroid $P(M) \subset \mathbb{Z}^{n}$. For every element $i \in[n]$, the quantity $r_{i}:=f(\{i\})+$ $f([n] \backslash\{i\})-f([n])$ is equal to 0 if $i$ is a loop or coloop of $M$, and equal to 1 otherwise. Furthermore it is easy to check, via Theorem 5.2, that the relations (5) and (6) for $\mathscr{T}_{P(M)}$ specialize to the deletion-contraction formulas for $T_{M}$.

The main question is whether there exists a more general deletion-contraction relation (true for arbitrary values of $r_{i}$ ) at the polymatroid level. Let $P$ be a polymatroid on the ground set $[n]$ and let $i \in[n]$. The $i$ 'th coordinate of a base of $P$ can take any value between $\alpha_{i}=f([n])-f([n] \backslash\{i\})$ and $\beta_{i}=f(\{i\})$. Both the "bottom face" $\underline{P}$ consisting of the bases with $i$ 'th coordinate equal to $\alpha_{i}$ and the "top face" $\bar{P}$ consisting of the bases with $i$ 'th coordinate equal to $\beta_{i}$ are polymatroids. However the other "slices" of $P$ are not necessarily polymatroids, and it is not clear how to express $P \backslash(\underline{P} \cup \bar{P})$ as a union of polymatroids when $r_{i}=\beta_{i}-\alpha_{i}>1$. Still, when, say, $P \backslash \underline{P}$ is a polymatroid, is it possible to express $\mathscr{T}_{P}$ in terms of $\mathscr{T}_{P}$ and $\mathscr{T}_{P \backslash P}$ ? If not, which specializations of $\mathscr{T}_{P}$ can be expressed in this manner? (Note that $\mathscr{T}_{P}(1,1)$ always works.)

In a different direction, suppose that $I \subset[n]$ is such that $r_{I}:=f(I)+f([n] \backslash$ $I)-f([n])=1$. Can we express $\mathscr{T}_{P}$ in terms of $\mathscr{T}_{\underline{P}}$ and $\mathscr{T}_{\bar{P}}$, where now $\underline{P}=\{\mathbf{a} \in$ $\left.P \mid \sum_{i \in I} a_{I}=f(I)-1\right\}$ and $\bar{P}=\left\{\mathbf{a} \in P \mid \sum_{i \in I} a_{I}=f(I)\right\} ?$

Lastly, focusing on hypergraphs, can we find a generalization of the notions of deletion and contraction of edges which would lead to a recurrence for the polymatroid Tutte polynomial of hypergraphs? For instance, for a hypergraph $H$ and a hyperedge $e$, can we express $\mathscr{T}_{P_{H}}$ in terms of the polynomials $\mathscr{T}_{P_{H(B)}}$ for all the hypergraphs $H(B)$ obtained from $H$ by choosing a set partition $B$ of $e$, identifying the vertices in each block of $B$, and deleting $e$ ? Or, if this is not the right approach, then can we extend Kato's formula Ka, Corollary 1.3] that provides a recurrence relation for the interior polynomial?
18.3. Relation to other hypergraph and polymatroid invariants. Many invariants of polymatroids related to the Tutte polynomial have been considered in the literature. We wonder if the polymatroid Tutte polynomial introduced in the present paper is related to those invariants. For the reader's convenience, we now do a quick review of those invariants.

In Hel, Helgason defines the following Poincaré polynomial for a polymatroid $P \subset \mathbb{Z}^{n}$ having rank function $f$ :

$$
\begin{equation*}
\mathscr{P}_{P}(x, y)=\sum_{I \subseteq[n]}(y-1)^{|I|} x^{f([n])-f(I)} \tag{30}
\end{equation*}
$$

In words, the Poincaré polynomial counts subsets of $[n]$ according to their cardinality and rank. When specialized to matroid, this invariant is clearly equivalent (i.e. equal up to a change of variables) to the Tutte polynomial as defined by (3). The specialization $\mathscr{P}_{P}(x, 0)$ is called the characteristic polynomial of $P$.

Although both $\mathscr{P}_{P}$ and $\mathscr{T}_{P}$ are generalizations of the Tutte polynomial of matroids to the polymatroid setting, it seems unlikely they are equivalent. However, we
wonder if they have non-trivial common specializations. For instance, can the characteristic polynomial be obtained as a specialization of $\mathscr{T}_{P}$. In the other direction, can the number of bases of $P$ (given by $\left.\mathscr{T}_{P}(1,1)\right)$ be obtained as a specialization of $\mathscr{P}_{P}(x, y)$ ?

Let us now turn to hypergraph invariants. For a bipartite graph $H=(V \sqcup W, E)$ one can consider the hypergraph $\vec{H}$, and the polymatroid $P_{H}$ whose rank function is given by (24). The Poincaré polynomial of $P_{H}$ is then

$$
\begin{equation*}
\mathscr{P}_{P_{H}}(x, y)=\sum_{I \subseteq W}(y-1)^{|I|} x^{c(I)-c(W)} \tag{31}
\end{equation*}
$$

where $c(I)$ is the number of connected components of the subgraph of $H$ induced by the set $V \sqcup I$ of vertices. Now recall that the chromatic polynomial $\chi_{H}(q)$ of $\vec{H}$ (as defined in e.g. $\overline{\mathrm{Ber}}$ ) is the unique polynomial such that for every positive integer $k$, the evaluation $\chi_{H}(k)$ counts the number of $k$-colorings of the vertices (i.e. functions $V \rightarrow[k]$ ) without monochromatic hyperedge. It was shown in Hel] (see also Whil), that the chromatic polynomial $\vec{H}$ is related to the characteristic polynomial of $P_{H}$ by

$$
\chi_{H}(q)=q^{c(W)} \mathscr{P}_{P_{H}}(q, 0)=\sum_{I \subseteq W}(-1)^{|I|} q^{c(I)}
$$

More generally, it is shown in [Sta3, Section 3.3] that $\chi_{H}(q, y)=q^{c(W)} \mathscr{P}_{P_{H}}(q, y)$ counts the colorings of $H$ according to the number of monochromatic hyperedges. Precisely, for every positive integer $k$,

$$
k^{c(W)} \mathscr{P}_{P_{H}}(k, y)=\sum_{k-\text { coloring of vertices }} y^{\# \text { monochromatic hyperedges }}
$$

This is a generalization to hypergraphs of the classical relation between the Tutte polynomial and Potts model. We also mention another invariant of hypergraphs, which was defined in Ath as

$$
\mathscr{A}_{H}(x, y)=\sum_{I \subseteq W}(y-1)^{|I|} x^{d(I)}
$$

where $d(I)=|V|-\min \{|J| \mid J \subseteq W$ equivalent to $I\}$, where two sets of hyperedges $I, J$ are called equivalent if the subgraphs of $H$ induced by $V \sqcup I$ and $V \sqcup J$ have the same connected components. The invariants $\chi_{H}(x, y)$ and $\mathscr{A}_{H}(x, y)$ coincide for hypergraphs $\vec{H}$ which are graphs (every hyperedge of cardinality 2 ). Both are generalizations of the Tutte polynomial of graphs, in the sense that when restricted to graphs, these invariants are equal to the Tutte polynomial up to a change of variables.

More recently, Aval et al. AKT studied an invariant of hypergraph $\widetilde{\chi}_{H}(q)$, which is a different generalization of the chromatic polynomial of (loopless) graphs. Namely, $\widetilde{\chi}_{H}(q)$ is the unique polynomial such that for every positive integer $k$, the evaluation $\widetilde{\chi}_{H}(k)$ counts the number of $k$-colorings of the vertices such that for every hyperedge the maximum color appearing in the hyperedge only appears once in the hyperedge. When restricted to loopless graphs the invariant $\widetilde{\chi}_{H}(q)$ is equal to the chromatic polynomial $\chi_{H}(q)$. One could also consider the twovariable extension $\widetilde{\chi}_{H}(q, y)$ counting the colorings of $\vec{H}$ according to the number of hyperedges violating the above coloring condition - and this would again give a generalization of the Tutte polynomial of graphs.

We wonder again whether $\widetilde{\chi}_{H}(q)$ can be obtained as a specialization of $\mathscr{T}_{P_{H}}$. The invariant $\widetilde{\chi}_{H}(q)$ can be defined using the Hopf monoid framework of Aguiar and Ardila AA . Can the polymatroid Tutte polynomial be also described in this manner (using a character of the Hopf monoid of hypergraphs from AA)?

Lastly a generalization of the Tutte polynomial from the graph setting to the directed graph setting is defined in AB . Since hypergraphs can be seen as a subclass of directed graphs (namely the class of directed graphs such that every vertex is either a source or a sink), it is natural to ask whether there is any relation with the invariant defined in AB (which is actually a trivariate polynomial). While we do not know a satisfying answer to this question, we note that the invariant obtained from $[\mathrm{AB}$ is mirror invariant (that is, it takes the same value for $H$ and $\left.H^{T}\right)$. This leads us to our next topic.
18.4. Mirror symmetry. Let us recall the relation established in KP between the interior polynomial of a hypergraph and its transpose. Let $H=(V \sqcup W, E)$ be a connected bipartite graph. Then it is proved in KP] that

$$
\begin{equation*}
x^{-|W|} \mathscr{T}_{P_{H}}(x, 1)=x^{-|V|} \mathscr{T}_{P_{H^{T}}}(x, 1) \tag{32}
\end{equation*}
$$

However the proof of (32) in $\overline{\mathrm{KP}}$ is quite complicated. Therefore it would be nice if such a formula could be derived from the results of the present paper, for instance using the explicit expression of $\mathscr{T}_{n}$ established in Section 7 .

Another question concerns a possible extension of (32). As we now explain, the Tutte polynomial of a hypergraph does not determine the Tutte polynomial of its transpose. This can be seen from the case of graphical zonotopes treated in Section 16. Let $G=(W, E)$ be a connected graph, and let $Z(G) \subset \mathbb{Z}^{W}$ be the corresponding zonotope (seen as a polymatroid). Recall from Remark 14.12 that $Z(G)$ is a graphical polymatroid. Precisely, let $H=\left(V^{+} \sqcup W, E^{\prime}\right)$ be the bipartite graph obtained from $G=(W, E)$ by inserting a vertex $v_{e} \in V^{+}$in the middle of each edge $e \in E$, and adding a vertex $v_{0} \in V^{+}$joined to every vertex in $W$. Then $Z(G)=P_{H}$, and Theorem 16.1 reads

$$
\mathscr{T}_{P_{H}}(x, y)=(x+y-1) T_{G}(x+y, 1) .
$$

Now let us consider the transpose hypergraph $\vec{H}^{T}:=\left(\vec{H}_{G}^{+}\right)^{T}$. It can be shown that

$$
\begin{equation*}
\mathscr{T}_{P_{H^{T}}}(x, y)=x^{|E|-|W|+1} y^{|W|-1}(x+y-1) T_{G}\left(\frac{x+y}{y}, \frac{x+y-1}{x}\right) . \tag{33}
\end{equation*}
$$

Note that $\mathscr{T}_{P_{H}}(x, 1)=x T_{G}(x, 1)=x^{|W|-|E|-1} \mathscr{T}_{P_{H^{T}}}(x, 1)$, in accordance with 32 . The proof of 33 is left to the reader ${ }^{2}$. Hence the Tutte polynomial of $\vec{H}$ is equivalent to $T_{G}(x, 1)$ while the Tutte polynomial of the transpose hypergraph $\vec{H}^{T}$ is equivalent to the full Tutte polynomial $T_{G}(x, y)$. While this rules out a direct two-variable extension of (32), it raises the question of finding a three-variable invariant $\mathscr{R}_{\vec{H}}\left(x, y, y^{\prime}\right)$ of hypergraphs such that for any hypergraph $\vec{H}$, we have $\mathscr{R}_{\vec{H}}\left(x, y, y^{\prime}\right)=\mathscr{R}_{\vec{H}^{T}}\left(x, y^{\prime}, y\right)$.

[^1]18.5. Zonotopes and $x, y$ symmetry. In Theorem 16.1, we give an expression for the polymatroid Tutte polynomial $\mathscr{T}_{Z(G)}(x, y)$ of a graphical zonotope $Z(G)$. Could this expression be obtained directly without using the explicit formula for the universal Tutte polynomial $\mathscr{T}_{n}$ ? (the formula of $\mathscr{T}_{n}$ secretly captures the fact that a hypergraph and its mirror have the same number of spanning hypertrees).

Observe that the polymatroid Tutte polynomial $\mathscr{T}_{Z(G)}(x, y)$ of any graphical zonotope $Z(G)$ is a polynomial in $x+y$. Is it true that $\mathscr{T}_{P}(x, y)$ is a polynomial in $x+y$ if and only if $P$ is a zonotope?

Observe more generally that whenever $-P$ is a translate of $P$, we get $T_{P}(x, y)=$ $T_{-P}(y, x)=T_{P}(y, x)$. Hence in this case $T_{P}(x, y)$ is a symmetric polynomial in $x$ and $y$. Are there nice interpretations of the coefficients of $\mathscr{T}_{P}$ in some basis of the symmetric functions?
18.6. Miscellaneous. We leave the reader with a few additional questions.

In Section 7 we give an explicit formula for the universal Tutte polynomial $\mathscr{T}_{n}$ based on a formula from Pos for the number of points in polymatroids. There are other point-counting formulas in Pos , one of which is based on a result of Brion [Bri]. Could these alternative formulas be used to give alternative expressions of $\mathscr{T}_{n}$, which reveal other properties of this polynomial?

In Proposition 4.11, we provide interpretations of some evaluations of $\mathscr{T}_{P}(x, y)$. Is it possible to give combinatorial interpretations of some other specializations (possibly restricting our attention to hypergraphical polymatroids)? We wonder, in particular, if the evaluations $\mathscr{T}_{P}(1,2), \mathscr{T}_{P}(2,1)$, and $\left.\frac{\mathscr{T}_{P}(x, y)}{x+y-1}\right|_{x=1 / 2, y=1 / 2}$ can be given a combinatorial meaning.

Lastly, let us recall that the original motivation for introducing the interior and exterior polynomials in Kal was to give a combinatorial interpretation for some of the coefficients of the HOMFLY polynomials of knots associated to plane bipartite graphs. Can the polymatroid Tutte polynomial be interpreted as a knot invariant, or can it at least be used to further our understanding of (quantum) knot invariants?
