ON INDEFINITE AND POTENTIALLY UNIVERSAL QUADRATIC FORMS OVER NUMBER FIELDS

ABSTRACT. A number field k admits a binary integral quadratic form which represents all integers locally but not globally if and only if the class number of k is bigger than one. In this case, there are only finitely many classes of such binary integral quadratic forms over k.

A number field k admits a ternary integral quadratic form which represents all integers locally but not globally if and only if the class number of k is even. In this case, there are infinitely many classes of such ternary integral quadratic forms over k.

An integral quadratic form over a number field k with more than one variables represents all integers of k over the ring of integers of a finite extension of k if and only if this quadratic form represents 1 over the ring of integers of a finite extension of k.

1. INTRODUCTION

Universal integral quadratic forms over \mathbb{Z} have been studied extensively by Dickson [7] and Ross [24] for both positive definite and indefinite cases in the 1930s. A positive definite integral quadratic form is called universal if it represents all positive integers. Ross pointed out that there is no ternary positive definite universal form over \mathbb{Z} in [24] (see a more conceptual proof in [9, Lemma 3]). However, this result is not true over totally real number fields. In [20], Maass proved that $x^2 + y^2 + z^2$ is a positive definite universal quadratic form over the ring of integers of $\mathbb{Q}(\sqrt{5})$. Chan, Kim and Raghavan further determined all possible quadratic real fields which admit a positive definite universal ternary quadratic form and listed all positive definite universal ternary quadratic forms in [4]. A symbolic achievement for positive definite universal quadratic forms over \mathbb{Z} is the 15-theorem first proved by Conway and Schneeberger and simplified by Bhargava in [2], which claims that a positive definite classical integral quadratic form f is universal if and only if f represents all positive integers from 1 to 15. Lee in [17]established an analogy of Conway and Schneeberger's 15-theorem over the ring of integers of $\mathbb{Q}(\sqrt{5})$. In fact, for any fixed totally real field, universal quadratic forms always exist by [12]. By the reduction theory, Kim and Earnest [8, Corollary 1] showed that there are only finitely many classes of positive definite quadratic forms over a given totally real field with the minimal rank. The natural problems remain to determine the minimal rank for existing positive definite universal quadratic forms and classify all universal forms of the minimal rank over a given totally real field. Indeed, there are many articles concerning these subjects such as [3], [6], [9], [15], [16], [25], [32] etc.

Indefinite quadratic forms have significantly different features from positive definite quadratic forms. An indefinite integral quadratic form is called universal if it represents all integers. Since the representability of indefinite quadratic forms with more than three variables satisfies

the local-global principle by strong approximation for spin groups, the universal property of indefinite quadratic forms with more than three variables satisfies the local-global principle. By inspecting the integral spinor norms, one concludes that the class number of indefinite universal ternary quadratic forms over \mathbb{Z} is one. Therefore the universal property of indefinite ternary quadratic forms over \mathbb{Z} also satisfies the local-global principle. However, the local-global principle of universal property is not true any more over a number field because the class group of the ground number field will be involved. Indeed, Estes and Hsia [10] have determined all imaginary quadratic fields such that $x^2 + y^2 + z^2$ is locally universal but not globally. It is natural to ask what kind of number fields admit a binary or ternary integral quadratic form which is locally universal but not globally. We give a complete answer to this question (see Theorem 3.5).

Theorem 1.1. Let k be a number field.

(1) There is a binary integral indefinite quadratic form which is locally universal but not globally over k if and only if the class number of k is bigger than one. In this case, there are only finitely many classes of such binary integral quadratic forms.

(2) There is a ternary integral indefinite quadratic form which is locally universal but not globally over k if and only if the class number of k is even. In this case, there are infinitely many classes of such ternary integral quadratic forms.

Remark 1.2. Throughout this paper, an integral quadratic form means a quadratic form with integral coefficients as a polynomial but not necessarily a classical integral quadratic form (with an integral matrix). By Theorem 3.5 (1), there is no binary universal classical integral quadratic forms. The integral indefinite ternary quadratic forms constructed in the proof of Theorem 3.5 (2) are not classically integral. We will investigate the corresponding result for classical integral quadratic forms in future.

Dickson in [7, Theorem 22] (see also [24, Theorem 5]) proved that a ternary indefinite universal quadratic form over \mathbb{Z} has non-trivial zero over \mathbb{Q} . Ross in [24, Theorem 6] further proved that every ternary quadratic form with non-trivial zero over \mathbb{Q} and square-free discriminant is universal over \mathbb{Z} . We will point out that Dickson's result still holds over number fields (see Proposition 3.9) but Ross' result does not hold over general number fields any more (see Example 3.10). Moreover, we also show that one can not expect the result like Conway and Schneeberger's 15-theorem for indefinite universal quadratic forms (see Proposition 3.11).

Since the universal property for both positive definite case and indefinite case is not stable under base change, we consider the following generalization of universal quadratic forms.

Definition 1.3. Let f be an integral quadratic form f over the ring of integers \mathfrak{o}_k of a number field k.

i) We say f is potentially universal over k if there is a finite extension K/k such that every element in \mathbf{o}_k can be represented by f over the ring of integers of K.

ii) We say an element α in \mathbf{o}_k is potentially represented by f over k if α can be represented by f over the ring of integers of a finite extension K/k.

One has the following theorem.

Theorem 1.4. Let f be an integral quadratic form f over the ring of integers \mathbf{o}_k of a number field k with more than one variables. Then f is potentially universal over k if and only if 1 is potentially represented by f over k.

An immediate consequence of this theorem is that the potentially universal property is stable under base change (see Corollary 4.8).

Terminology and notation are standard if not explained and are adopted from [19]. Let k be a number field and \mathbf{o}_k be the ring of integers of k. Let Ω_k be the set of all primes of k and ∞_k be the set of all archimedean primes. For any $v \in \Omega_k$, we denote k_v the completion of k with respect to v. When $v \in \Omega_k \setminus \infty_k$, the completion of \mathbf{o}_k with respect to v inside k_v is denoted by \mathbf{o}_{k_v} and the group of units of \mathbf{o}_{k_v} is denoted by $\mathbf{o}_{k_v}^{\times}$. We fix a prime element π_v of \mathbf{o}_{k_v} for each $v \in \Omega_k \setminus \infty_k$. A non-degenerated quadratic space (V, Q) is defined to be a vector space V over k with a map $Q: V \to k$ such that

$$B(x,y) = \frac{1}{2}(Q(x+y) - Q(x) - Q(y))$$

is a non-degenerated bilinear map on $V \times V$. Write

$$O(V) = \{ \sigma \in GL(V) : Q(\sigma x) = Q(x), \forall x \in V \} \text{ and } O^+(V) = \{ \sigma \in O(V) : \det(\sigma) = 1 \}.$$

The adelic group of O(V) and $O^+(V)$ are denoted by $O_{\mathbb{A}}(V)$ and $O^+_{\mathbb{A}}(V)$ respectively.

A finitely generated \mathfrak{o}_k -module L is called an \mathfrak{o}_k -lattice if (kL, Q) is a non-degenerated quadratic space over k. We use $\mathfrak{s}(L)$ and $\mathfrak{n}(L)$ to denote the fractional ideals of \mathfrak{o}_k generated by B(x, y) with $x, y \in L$ and Q(x) with $x \in L$ respectively. Write

$$Q(L) = \{Q(x) : x \in L\}.$$

Similarly, for any \mathbf{o}_k -lattice L, we write L_v for the completion of L with respect to $v \notin \infty_k$ and for $k_v L$ with $v \in \infty_k$. Moreover, we also have an \mathbf{o}_{k_v} -lattice with the same notions as above for a non-archimedean prime v of k. For $\alpha, \beta, \gamma \in \mathbf{o}_{k_v}$, we denote $\gamma A(\alpha, \beta)$ a binary lattice

$$L = \mathfrak{o}_{k_v} x + \mathfrak{o}_{k_v} y \quad \text{with} \quad Q(x) = \alpha \gamma, \quad B(x, y) = \gamma \quad \text{and} \quad Q(y) = \beta \gamma.$$

The paper is organized as follows. In §2, we classify all local universal lattices of arbitrary rank over non-dyadic local fields and of rank less than 4 over dyadic local fields. Then we apply these result to study indefinite universal quadratic forms over number fields and give a proof of Theorem 1.1 in §3. We prove Theorem 1.4 in §4.

2. Locally universal conditions

In this section, we study the local universal property over a local field.

Definition 2.1. An \mathfrak{o}_{k_v} -lattice L is called universal if $Q(L) = \mathfrak{o}_{k_v}$ for $v \in \Omega_k \setminus \infty_k$.

One has the following criterion to verify the local universal lattices.

Lemma 2.2. Let L be an \mathfrak{o}_{kv} -lattice. Then L is universal if and only if

$$(\mathfrak{o}_{k_v}^{\times} \cup \pi_v \mathfrak{o}_{k_v}^{\times}) \subseteq Q(L) \subseteq \mathfrak{o}_{k_v}.$$

Proof. Since $(\mathfrak{o}_{k_v}^{\times} \cup \pi_v \mathfrak{o}_{k_v}^{\times}) \subseteq Q(L)$, one gets that $\pi_v^k \mathfrak{o}_{k_v}^{\times} \subseteq Q(L)$ for any integer $k \ge 0$. Since

$$\mathfrak{o}_{k_v} \setminus \{0\} = \bigcup_{k \ge 0} \pi_v^k \mathfrak{o}_{k_v}^\times,$$

one concludes $Q(L) = \mathbf{o}_{k_v}$ as desired.

2.1. Non-dyadic cases. By using Lemma 2.2, we can determine the universal lattices in term of Jordan splittings over non-dyadic local fields.

Proposition 2.3. Let L be an \mathfrak{o}_{k_v} -lattice L with the Jordan splitting

$$L = L_1 \perp L_2 \perp \cdots \perp L_t$$

over a non-dyadic local field k_v . Then L is universal if and only if L_1 is unimodular such that one of the following conditions holds

(1) rank $(L_1) \ge 3$ or $L_1 = A(0, 0)$.

(2) rank $(L_1) = 2$ with $L_1 \ncong A(0,0)$ and L_2 is (π_v) -modular with rank $(L_2) \ge 2$.

Proof. Sufficiency. For (1), it is clear that A(0,0) is universal. If rank $(L_1) \ge 3$, then $Q(L_1) = \mathfrak{o}_{k_v}$ by [19, 92:1b]. For (2), one has

$$Q(L_1) \supseteq \mathfrak{o}_{k_v}^{\times}$$
 and $Q(L_2) \supseteq \pi_v \mathfrak{o}_{k_v}^{\times}$

by [19, 92:1b]. The result follows from Lemma 2.2.

Necessity. Since L is universal, one has $\mathfrak{n}(L) = \mathfrak{s}(L) = \mathfrak{o}_{k_v}$. This implies that L_1 is unimodular. If $\operatorname{rank}(L_1) = 1$, then $\mathfrak{o}_{k_v}^{\times} \not\subseteq Q(L)$. If L_2 is not (π_v) -modular, then $\pi_v \not\in Q(L)$. If $\operatorname{rank}(L_1) = 2$ with $L_1 \ncong A(0,0)$ and $\operatorname{rank}(L_2) = 1$, then $\pi_v \mathfrak{o}_{k_v}^{\times} \nsubseteq Q(L)$. \Box

Remark 2.4. Since Condition (2) in Proposition 2.3 is not stable under base change, the universal property for both definite positive and indefinite cases is not stable under base change.

2.2. Dyadic cases of general rank. It is more complicated to determine the universal lattices over dyadic local fields. One can compare this with computing integral spinor norms over dyadic local fields. Based on various efforts of [11], [27], [28] and [29], Beli completed the computation of integral spinor norms over dyadic local fields in [1] in terms of BONGs. The complete determination of integral spinor norms over dyadic local fields in terms of Jordan splittings was given in [18]. Because of this complexity, we will only provide the complete solution of universal ternary quadratic forms which is sufficient for our global application.

Let's recall a minimal norm Jordan splitting of lattices over a dyadic local field.

Definition 2.5. Let L be a lattice over a dyadic local field k_v . A Jordan splitting

$$L = L_1 \perp L_2 \perp \dots \perp L_t \tag{2.1}$$

is called a minimal norm Jordan splitting if for any Jordan splitting

$$L = L'_1 \perp L'_2 \perp \cdots \perp L'_t,$$

one has $\mathfrak{n}(L_i) \subseteq \mathfrak{n}(L'_i)$ and $\perp_j \pi_v^{s_i} A(0,0)$ splits L_i as long as $\perp_j \pi_v^{s_i} A(0,0)$ splits L'_i for $1 \le i \le t$.

By [31, Theorem 1.1], such a minimal norm Jordan splitting always exists. For a minimal norm Jordan splitting (2.1), one can write

$$i(L) = \max\{1 \le i \le t : \ \mathfrak{n}(L_i) = \mathfrak{n}(L)\}.$$
(2.2)

Proposition 2.6. If there is j < i(L) such that $\mathfrak{n}(L_j) = \mathfrak{n}(L) = \mathfrak{o}_{k_v}$ in the above minimal norm Jordan splitting (2.1) over dyadic local fields, then L_j is an orthogonal sum of $2^{-1}A(0,0)$.

Proof. It follows from [29, Lemma 1.1].

For any $\xi \in k_v$, the quadratic defect is defined in [19, §63 A]

$$\mathfrak{d}(\xi) = \bigcap_{\alpha} \alpha \mathfrak{o}_{k_v}$$

where α runs over all possible expressions $\xi = \eta^2 + \alpha$ for some $\eta \in k_v$. Let $\Delta = 1 + 4\rho$ be a unit satisfying $\mathfrak{d}(\Delta) = 4\mathfrak{o}_{k_v}$ by [19, 63:2].

Proposition 2.7. Suppose that $L = L_1 \perp L_2 \perp \cdots \perp L_t$ is a minimal norm Jordan splitting such that rank $(L_1) = 2$ and $\mathfrak{n}(L_1) \neq 2\mathfrak{s}(L_1)$. If

$$(\pi_v)\mathfrak{n}(L_1) = \mathfrak{n}(L_2 \perp \cdots \perp L_t) \quad or \quad \mathfrak{n}(L_1) = (\pi_v)\mathfrak{n}(L_2 \perp \cdots \perp L_t),$$

then there is a minimal norm Jordan splitting $L = L'_1 \perp L'_2 \perp \cdots \perp L'_t$ such that

$$\mathfrak{d}(-\pi^{-2s_1}\det(L'_1)) \subseteq 4\mathfrak{o}_{k_v}$$
 with $s_1 = \operatorname{ord}_v(\mathfrak{s}(L_1))$

Proof. There is $2 \leq i \leq t$ such that $\mathfrak{n}(L_i) = \mathfrak{n}(L_2 \perp \cdots \perp L_t)$. Since $\mathfrak{n}(L_1) \neq 2\mathfrak{s}(L_1)$, one concludes that $\mathfrak{n}(L_i) \neq 2\mathfrak{s}(L_i)$. There is a sub-lattice K with rank $(K) \leq 2$ such that

$$L_i = K \perp K^{\perp}$$
 and $\mathfrak{n}(L_i) = \mathfrak{n}(K) \supseteq \mathfrak{n}(K^{\perp})$

by [19, 93:18]. Without loss of generality, we assume that L_1 is unimodular and only need to consider the splitting of $L_1 \perp K$. Suppose

$$\mathfrak{d}(-\det(L_1)) \supsetneq 4\mathfrak{o}_{k_v}.$$
(2.3)

One can write $L_1 = \mathfrak{o}_{k_v} x + \mathfrak{o}_{k_v} y \cong A(\alpha \pi_v^a, \beta \pi_v^b)$ with $0 \le a < b$ and $\alpha, \beta \in \mathfrak{o}_{k_v}^{\times}$ such that

 $\mathfrak{d}(-\det(L_1)) = (\pi_v^{a+b})$

by [19, 93:17]. Let $K = \mathfrak{o}_k u$ or $K = \mathfrak{o}_k u + \mathfrak{o} v$ such that $Q(u) = \gamma \pi_v^c$ with $\gamma \in \mathfrak{o}_{k_v}^{\times}$ and

$$\operatorname{ord}_v(\mathfrak{n}(K)) = c$$
 and $\operatorname{ord}_v(B(u, v)) \le c < \operatorname{ord}_v(Q(v))$

Since a + b is odd by (2.3) and [19, 63:2], one has $c \leq b$ and $c \equiv b \mod 2$. There are $\xi, \eta \in \mathfrak{o}_{k_v}^{\times}$ such that $\beta + \gamma \xi^2 = \eta \pi_v^d$ with $d \geq 1$. Let

$$L'_1 = \mathfrak{o}_k x + \mathfrak{o}_k (y + \xi \pi_v^{\frac{b-c}{2}} u) \subset L_1 \perp K.$$

Then one gets a new splitting $L_1 \perp K = L'_1 \perp K'$ with

$$K' = \begin{cases} \mathfrak{o}_{k_v}(u - \sigma x + \sigma Q(x)y) & \operatorname{rank}(K) = 1\\ \mathfrak{o}_{k_v}(u - \sigma x + \sigma Q(x)y) + \mathfrak{o}_{k_v}(v - \tau x + \tau Q(x)y) & \operatorname{rank}(K) = 2 \end{cases}$$

where

$$\sigma = \det(L_1)^{-1} \xi \pi_v^{\frac{b-c}{2}} Q(u) \quad \text{and} \quad \tau = \det(L_1)^{-1} \xi \pi_v^{\frac{b-c}{2}} B(u, v).$$

By a simple computation, one has

$$\mathfrak{d}(-\det(L'_1)) \subsetneq \mathfrak{d}(-\det(L_1))$$

with $\mathfrak{n}(L'_1) = \mathfrak{n}(L_1)$ and $\mathfrak{n}(K') = \mathfrak{n}(K)$. By repeating this argument, one eventually gets

$$\mathfrak{d}(-\det(L_1')) \subseteq 4\mathfrak{o}_{k_v}$$

as required.

Proposition 2.8. Let *L* be an \mathfrak{o}_{k_v} -lattice with the minimal norm Jordan splitting (2.1) over a dyadic local field k_v . Suppose rank $(L_{i(L)}) = 1$ and $\mathfrak{n}(L) = \mathfrak{o}_k$. If *L* is universal, then there is $1 \leq j \leq t$ with $j \neq i(L)$ such that $(\pi_v) \subseteq \mathfrak{n}(L_j) \subseteq \mathfrak{o}_{k_v}$.

Proof. Without loss of generality, we assume that $L_{i(L)} = \mathfrak{o}_{k_v} x$ with Q(x) = 1. Suppose

$$\mathfrak{n}(L_k) \subseteq (\pi_v^2)$$
 for all $k \neq i(L)$.

Since L is universal, there are $a \in \mathfrak{o}_{k_v}^{\times}$ and

$$y \in L_1 \perp \cdots \perp L_{i(L)-1} \perp L_{i(L)+1} \perp \cdots \perp L_t$$

such that

$$1 + \pi_v = Q(ax + y) = a^2 + Q(y).$$
(2.4)

Since $Q(y) \in (\pi_v^2)$, a contradiction is derived from (2.4) by [19, 63:5].

Corollary 2.9. A binary \mathfrak{o}_{k_v} -lattice L over dyadic local fields is universal if and only if $L = 2^{-1}A(0,0)$.

Proof. Suppose that L has two Jordan components. One can assume that

 $L = \mathfrak{o}_{k_v} x \perp \mathfrak{o}_{k_v} y$ with Q(x) = 1, $Q(y) = \epsilon \pi_v$

by Prop. 2.8. Then $\Delta \notin Q(L)$ by [19, 63:11].

Suppose that L is modular. Then one can assume that

$$L \cong \pi_v^{-a} A(\pi_v^a, \epsilon \pi_v^b)$$
 with $0 \le a \le b$ and $a \le \operatorname{ord}_v(2)$

by [19, 93:17].

If $a < \operatorname{ord}_v(2)$, then $\tau_z \in O(L)$ for any $z \in L$ with $\operatorname{ord}_v(Q(z)) \leq 1$. Since L is universal, one concludes that $\theta(O^+(L)) = k_v^{\times}$ by Lemma 2.2. This is impossible by [11, Prop.B, Prop.C, Prop.D, Prop.E] and [27].

Otherwise, one has $a = \operatorname{ord}_{v}(2)$. Then $L \cong 2^{-1}A(0,0)$ or $2^{-1}A(2,2\rho)$ by [19, 93:11]. Since $\pi_{v} \notin Q(2^{-1}A(2,2\rho))$ by the principle of domination in [23], one obtains the result as desired. \Box

2.3. Dyadic cases of rank three. Now we focus on ternary lattices over dyadic local fields. We first need the following lemma.

Lemma 2.10. Suppose

 $L = \mathfrak{o}_{k_v} x \perp \mathfrak{o}_{k_v} y \perp \mathfrak{o}_{k_v} z$ with Q(x) = 1, $Q(y) = \epsilon \pi_v$, $Q(z) = \delta \pi_v^k$ and $1 \le k \le 2 \operatorname{ord}_v(2)$ where $\epsilon, \delta \in \mathfrak{o}_{k_n}^{\times}$. Then $\mathfrak{o}_{k_n}^{\times} \subseteq Q(L)$ if and only if k is even.

Proof. For an even integer k, one considers

$$\mathfrak{o}_{k_v}^{\times} = (\mathfrak{o}_{k_v}^{\times} \cap Q(\mathfrak{o}_{k_v}x \perp \mathfrak{o}_{k_v}y)) \cup \Delta(\mathfrak{o}_{k_v}^{\times} \cap Q(\mathfrak{o}_{k_v}x \perp \mathfrak{o}_{k_v}y))$$

by [19, 63:11]. For any

$$(1+4\rho)(a^2+\epsilon\pi_v b^2) \in \Delta(\mathfrak{o}_{k_v}^{\times} \cap Q(\mathfrak{o}_{k_v} x \perp \mathfrak{o}_{k_v} y))$$

with $a \in \mathfrak{o}_{k_v}^{\times}$ and $b \in \mathfrak{o}_{k_v}$, there are $\xi \in \mathfrak{o}_{k_v}^{\times}$ and $\eta \in (\pi_v)$ such that $\rho \delta^{-1} = \xi^2 + \eta$. By [19, 63:1], there is $\gamma \in \mathfrak{o}_{k_n}^{\times}$ such that

$$\gamma^2 = a^2 + 4\rho\epsilon\pi_v b^2 + 4a^2\delta\eta.$$

Since

 $Q(\gamma x + by + 2a\pi_v^{-\frac{k}{2}}\xi z) = \gamma^2 + \epsilon\pi_v b^2 + 4a^2\xi^2 \delta = a^2 + 4\rho\epsilon\pi_v b^2 + 4a^2\delta n + \epsilon\pi_v b^2 + 4a^2\xi^2 \delta$ $= (a^{2} + \epsilon \pi_{v}b^{2}) + 4\rho \epsilon \pi_{v}b^{2} + 4a^{2}\delta(\xi^{2} + \eta) = (a^{2} + \epsilon \pi_{v}b^{2}) + 4\rho \epsilon \pi_{v}b^{2} + 4a^{2}\rho = (1 + 4\rho)(a^{2} + \epsilon \pi_{v}b^{2})$ with $\gamma x + by + 2a\pi_v^{-\frac{k}{2}}\xi z \in L$, one concludes that $\mathfrak{o}_{k_v}^{\times} \subseteq Q(L)$. For an odd integer k, we consider a new quadratic form Q' scaling by $-\epsilon\delta$. Then

$$\mathfrak{o}_{k_v}^{\times} \subseteq Q(L)$$
 if and only if $\mathfrak{o}_{k_v}^{\times} \subseteq Q'(L)$.

Suppose $\mathfrak{o}_{k_n}^{\times} \subseteq Q'(L)$. Then

 $L = \mathfrak{o}_{k_v} x' \perp \mathfrak{o}_{k_v} y' \perp \mathfrak{o}_{k_v} z'$ with Q'(x') = 1, $Q'(y') = \epsilon' \pi_v$ and $Q'(z') = \delta' \pi_v^k$ where $\epsilon', \delta' \in \mathfrak{o}_{k_v}^{\times}$ with $-\epsilon'\delta' \in (\mathfrak{o}_{k_v}^{\times})^2$. Since $\Delta \in Q'(L)$, one obtains that

$$\Delta \in Q'(\mathfrak{o}_{k_x}x' \perp (\pi_v^{\frac{k-1}{2}})y' \perp \mathfrak{o}_{k_v}z')$$

by [19, 63:5]. Since $(\pi_v^{\frac{k-1}{2}})y' \perp \mathfrak{o}_{k_v}z' = \mathfrak{o}_{k_v}u + \mathfrak{o}_{k_v}w$ where

$$Y'(u) = \gamma \pi_v^k, \quad Q'(w) = 0, \quad B'(u, w) = \pi_v^k \quad \text{with} \quad \gamma \in \mathfrak{o}_{k_v}^{\times},$$

there are $a \in \mathfrak{o}_{k_v}^{\times}$ and $b, c \in \mathfrak{o}_{k_v}$ such that $\Delta = Q'(ax'+bu+cw)$. By [19, 63:5], one concludes that $\operatorname{ord}_v(b) \geq e - \frac{1}{2}(k-1)$. This implies that $\Delta \in (\mathfrak{o}_{k_v}^{\times})^2$ by [19, 63:1], which is a contradiction. \Box

Proposition 2.11. A universal \mathfrak{o}_{k_v} -lattice of rank 3 has a Jordan component of rank ≥ 2 .

Proof. Suppose there is a universal \mathfrak{o}_{k_v} -lattice L of rank 3 such that all Jordan components of L are one dimensional. By Prop.2.8, one can assume that

$$L = \mathfrak{o}_{k_v} x \perp \mathfrak{o}_{k_v} y \perp \mathfrak{o}_{k_v} z$$
 with $Q(x) = 1$, $Q(y) = \epsilon \pi_v$, $Q(z) = \delta \pi_v^k$ and $k \ge 2$
where $\epsilon, \delta \in \mathfrak{o}_{k_v}^{\times}$. Then $k \le 2 \operatorname{ord}_v(2)$ is even by [19, 63:1] and Lemma 2.10. Since

$$\pi_v \mathfrak{o}_{k_v}^{\times} \subset Q(\mathfrak{o}_{k_v}(\pi_v x) \perp \mathfrak{o}_{k_v} y \perp \mathfrak{o}_{k_v} z),$$

one concludes that

$$\mathfrak{o}_{k_v}^{\times} \subset Q^{\epsilon^{-1}\pi_v^{-1}}(\mathfrak{o}_{k_v}y \perp \mathfrak{o}_{k_v}(\pi_v x) \perp \mathfrak{o}_{k_v}z)$$

by scaling $\epsilon^{-1}\pi_v^{-1}$. A contradiction is derived by Lemma 2.10.

Lemma 2.12. If $L = (\mathfrak{o}_{k_v}x + \mathfrak{o}_{k_v}y) \perp \mathfrak{o}_{k_v}z$ such that

$$Q(x) = \epsilon \pi_v, \quad B(x, y) = \pi_v^{-a}, \quad Q(y) = -4\rho \epsilon^{-1} \pi_v^{-2a-1} \quad and \quad Q(z) = 1$$

where $0 \leq a < \operatorname{ord}_{v}(2)$ is an integer and $\epsilon \in \mathfrak{o}_{k_{v}}^{\times}$, then $\Delta \notin Q(L)$.

Proof. Suppose not. There are $\alpha, \beta \in \mathfrak{o}_{k_v}$ and $\gamma \in \mathfrak{o}_{k_v}^{\times}$ such that

$$\Delta = Q(\alpha x + \beta y + \gamma z) = \gamma^2 + Q(\alpha x + \beta y).$$

Since

$$\operatorname{prd}_{v}Q(\alpha x + \beta y) = \min\{\operatorname{ord}_{v}(Q(\alpha x)), \operatorname{ord}_{v}(Q(\beta y))\}$$

is odd by the principle of domination in [23], a contradiction is derived by [19, 63:1 and 63:5]. \Box

Lemma 2.13. Let $L = L_1 \perp \mathfrak{o}_{k_v} z$ such that

$$L_1 \cong \pi_v^{-a} A(\pi_v^a, \delta \pi_v^{b-a}) \quad and \quad Q(z) = \epsilon \pi_v^r$$

in sense of [19, 93:17], where $0 \le a < \operatorname{ord}_v(2)$ and $\epsilon, \delta \in \mathfrak{o}_{k_v}^{\times}$. If $r \ge 2$, then L is not universal. Proof. Since $a < \operatorname{ord}_v(2)$, one has $b \ge 2a + 1$. When b > 2a + 1, then $\pi_v \notin Q(L)$. So one only needs to consider that b = 2a + 1. Let $\{x, y\}$ be the corresponding basis of L_1 . Then

$$Q(x) = 1$$
, $B(x, y) = \pi_v^{-a}$ and $Q(y) = \delta \pi_v^{b-2a}$.

Since $L \subset (\mathfrak{o}_{k_v} x + \mathfrak{o}_{k_v} y) \perp \mathfrak{o}_{k_v} (\pi_v^{-[\frac{r-2}{2}]} z)$, one only needs to prove the result for r = 2, 3.

For the case that $k_v L$ is anisotropic, we claim that $\Delta \epsilon \pi_v^r \notin Q(L)$. Suppose not, one has

$$\begin{cases} \Delta \epsilon \pi_v^r \in Q((\mathfrak{o}_{k_v} \pi_v x + \mathfrak{o}_{k_v} \pi_v y) \perp \mathfrak{o}_{k_v} z) & r = 2\\ \Delta \epsilon \pi_v^r \in Q((\mathfrak{o}_{k_v} \pi_v^2 x + \mathfrak{o}_{k_v} \pi_v y) \perp \mathfrak{o}_{k_v} z) & r = 3 \end{cases}$$

by the principle of domination in [23]. A contradiction is derived by [29, Lemma 1.1], Prop. 2.7 and Lemma 2.12 with scaling $\epsilon^{-1}\pi_v^{-r}$. Therefore we can further assume that $k_v L$ is isotropic.

<u>Case r = 2</u>. In this case, we claim that $\mathfrak{o}_{k_v}^{\times} \not\subseteq Q(L)$. Indeed, since $k_v L$ is isotropic, there are α, β and γ in \mathfrak{o}_{k_v} with

$$\operatorname{ord}_{v}(\alpha) \cdot \operatorname{ord}_{v}(\beta) \cdot \operatorname{ord}_{v}(\gamma) = 0$$
 such that $Q(\alpha x + \beta y + \gamma z) = 0.$

This implies that $\operatorname{ord}_{v}(\gamma) = \operatorname{ord}_{v}(\alpha) - 1 = 0$ and $\operatorname{ord}_{v}(\beta) \geq 1$ by the principle of domination in [23]. Therefore $-\epsilon$ is represented by L_{1} . By scaling $-\epsilon$ if necessary, one can simply assume that $\epsilon = -1$ by [19, 93:17]. Write

$$\det(L_1) = \omega_1 \pi_v^{-2a} \quad \text{with} \quad \omega_1 \in \mathfrak{o}_{k_v}^{\times}$$

Then $\mathfrak{d}(-\omega_1) = (\pi_v^{2a+1})$ by [19, 63:5]. By [11, Lemma 3], there is $\eta \in \mathfrak{o}_{k_v}^{\times}$ such that

 $\mathfrak{d}(\eta) = (\pi_v^{2(\mathrm{ord}_v(2)-a)-1})$ and the Hilbert symbol $(\eta, -\omega_1)_v = -1.$

Then $\mathfrak{d}(\omega_1\eta) = (\pi_v^s)$ satisfying

$$\begin{cases} s = 2a + 1 & \text{for } a < \frac{1}{2}(\operatorname{ord}_v(2) - 1) \\ s = 2\operatorname{ord}_v(2) - 2a - 1 & \text{for } a > \frac{1}{2}(\operatorname{ord}_v(2) - 1) \\ s \ge \operatorname{ord}_v(2) & \text{for } a = \frac{1}{2}(\operatorname{ord}_v(2) - 1) . \end{cases}$$
(2.5)

Suppose that the above claim is not true. Then $\eta \omega_1 \in Q(L)$. There are $g \in \mathfrak{o}_{k_v}^{\times}$, c and h in \mathfrak{o}_{k_v} such that

$$\omega_1 \eta = g^2 + 2\pi_v^{-a}gh + \delta\pi_v h^2 - c^2 \pi_v^2$$

= $[(g + c\pi_v)^2 + 2\pi_v^{-a}(g + c\pi_v)h + \delta\pi_v h^2] - 2\pi_v cg - 2\pi_v^{-a+1}ch - 2\pi_v^2 c^2.$ (2.6)

When $\operatorname{ord}_{v}(h) \ge \operatorname{ord}_{v}(2) - a - 1$, then

$$s \ge \min\{\operatorname{ord}_v(2) - a + \operatorname{ord}_v(h), \operatorname{ord}_v(2) + 1\} \ge \min\{2(\operatorname{ord}_v(2) - a) - 1, \operatorname{ord}_v(2) + 1\}$$

by (2.6). A contradiction is derived for $a < \frac{1}{2}(\operatorname{ord}_v(2) - 1)$ by (2.5). For $a \ge \frac{1}{2}(\operatorname{ord}_v(2) - 1)$, one obtains that

$$\operatorname{ord}_{v}(2\pi_{v}cg + 2\pi_{v}^{-a+1}ch + 2\pi_{v}^{2}c^{2}) \ge \min\{\operatorname{ord}_{v}(2) - a + 1 + \operatorname{ord}_{v}(h), \operatorname{ord}_{v}(2) + 1\}$$
$$\ge \min\{2(\operatorname{ord}_{v}(2) - a), \operatorname{ord}_{v}(2) + 1\} = 2(\operatorname{ord}_{v}(2) - a).$$

By [28, Remark 1], one concludes that the Hilbert symbol

$$(1 - \xi^{-1}(2\pi_v cg + 2\pi_v^{-a+1}ch + 2\pi_v^2 c^2), \ -\omega_1)_v = 1$$

with

$$\xi = (g + c\pi_v)^2 + 2\pi_v^{-a}(g + c\pi_v)h + \delta\pi_v h^2.$$

Since $\xi \in Q(k_v L_1)$, one has $(\xi, -\omega_1)_v = 1$. Therefore

$$1 = (\xi, -\omega_1)_v \cdot ([1 - \xi^{-1}(2\pi_v cg + 2\pi_v^{-a+1}ch + 2\pi_v^2 c^2)], -\omega_1)_v = (\omega_1\eta, -\omega_1)_v = (\eta, -\omega_1)_v$$

by (2.6), which contradicts to the choice of η .

When $\operatorname{ord}_v(h) < \operatorname{ord}_v(2) - a - 1$, then

$$2\operatorname{ord}_{v}(h) + 1 < \min\{\operatorname{ord}_{v}(2) - a + \operatorname{ord}_{v}(h), \operatorname{ord}_{v}(2) + 1\}$$

for $a > \frac{1}{2}(\operatorname{ord}_v(2) - 1)$ or $\operatorname{ord}_v(h) < a$. This implies that

$$s = 2 \operatorname{ord}_{v}(h) + 1 < \begin{cases} 2(\operatorname{ord}_{v}(2) - a) - 1 & \text{for } a > \frac{1}{2}(\operatorname{ord}_{v}(2) - 1) \\ 2a + 1 & \text{for } \operatorname{ord}_{v}(h) < a \end{cases}$$

by (2.6) and [19, 63:5]. A contradiction is derived by (2.5) except

$$a \leq \operatorname{ord}_v(h) < \operatorname{ord}_v(2) - a - 1.$$

For $a < \operatorname{ord}_v(h) < \operatorname{ord}_v(2) - a - 1$, one has

 $\operatorname{ord}_{v}(2\pi_{v}^{-a}(g+c\pi_{v})h+\delta\pi_{v}h^{2}-2\pi_{v}cg-2\pi_{v}^{-a+1}ch-2\pi_{v}^{2}c^{2}) \geq 2\operatorname{ord}_{v}(h)+1>2a+1.$ Then the Hilbert symbol

$$(\eta, \ 1 + 2\pi_v^{-a}(g + c\pi_v)h + \delta\pi_v h^2 - 2\pi_v cg - 2\pi_v^{-a+1}ch - 2\pi_v^2 c^2)_v = 1$$

by [28, Remark 1]. This implies that

$$1 = (\eta, \omega_1 \eta)_v = (\eta, -\omega_1)_v$$

by (2.6), which contradicts to the choice of η .

For $\operatorname{ord}_v(h) = a < \frac{1}{2}(\operatorname{ord}_v(2) - 1)$, one obtains that $\omega_1 \eta \in Q(M)$ with

$$M = A(1, \delta \pi_v^{2a+1}) \perp < -\pi_v^2 > = <1 > \perp < \omega_1 > \perp < -\pi_v^2 >$$

by (2.6). There are u, v and l in \mathfrak{o}_{k_v} such that

$$\omega_1 \eta = u^2 + \omega_1 v^2 - \pi_v^2 l^2 = (u + \pi_v l)^2 + \omega_1 v^2 - 2\pi_v u l - 2\pi_v^2 l^2.$$
(2.7)

Then

$$\eta = (u + \pi_v l)^2 \omega_1^{-1} + v^2 - 2\pi_v l \omega_1^{-1} (u + \pi_v l).$$

Since

$$\mathfrak{d}(\omega_1^{-1}) = \mathfrak{d}(-\omega_1) = (\pi_v^{2a+1}) \text{ and } \mathfrak{d}(\eta) = (\pi_v^{2(\mathrm{ord}_v(2)-a)-1}) \text{ with } 2a+1 < \mathrm{ord}_v(2),$$

one concludes that

$$v \in \mathfrak{o}_{k_v}^{\times}$$
 and $\operatorname{ord}_v(u + \pi_v l) \ge \operatorname{ord}_v(2) - 2a - 1$

by [19, 63:5]. This implies that

 $\operatorname{ord}_{v}(2\pi_{v}l\omega_{1}^{-1}(u+\pi_{v}l)) \geq 2\operatorname{ord}_{v}(2) - 2a \quad \text{and} \quad (-\omega_{1}, \ 1 - \lambda^{-1}(2\pi_{v}l\omega_{1}^{-1}(u+\pi_{v}l)))_{v} = 1$ with $\lambda = (u+\pi_{v}l)^{2}\omega_{1}^{-1} + v^{2}$ by [28, Remark 1]. Since

$$(\lambda, -\omega_1)_v = 1$$
 and $\eta = \lambda(1 - \lambda^{-1}(2\pi_v l\omega_1^{-1}(u + \pi_v l))),$

one obtains that $(-\omega_1, \eta)_v = 1$ which contradicts to the choice of η .

<u>Case r=3</u>. In this case, we claim that $\pi_v \mathfrak{o}_{k_v}^{\times} \not\subseteq Q(L)$. Suppose not, one has

$$\pi_v \mathfrak{o}_{k_v}^{\times} \subseteq Q((\mathfrak{o}_{k_v} \pi_v x + \mathfrak{o}_{k_v} y) \perp \mathfrak{o}_{k_v} z)$$

and reduces to the above case by scaling $\delta^{-1}\pi_v^{-1}$. A contradiction is derived.

Lemma 2.14. If $L = L_1 \perp \mathfrak{o}_{k_v} z$ such that

$$L_1 \cong 2^{-1}A(2,2\rho) \quad and \quad Q(z) = \epsilon \pi_v^r \quad with \quad r \ge 2,$$

then $\pi_v \notin Q(L)$.

Proof. It follows from the principle of domination in [23].

Lemma 2.15. Let $L = (\mathfrak{o}_{k_v}x + \mathfrak{o}_{k_v}y) \perp \mathfrak{o}_{k_v}z$ such that

Case 1.
$$Q(x) = 1$$
, $B(x, y) = \pi_v^{-a}$, $Q(y) = 0$ and $Q(z) = \epsilon \pi_v$

Case 2.
$$Q(x) = \epsilon \pi_v$$
, $B(x, y) = \pi_v^{-a}$, $Q(y) = 0$ and $Q(z) = 1$

where $0 \leq a < \operatorname{ord}_{v}(2)$ is an integer and $\epsilon \in \mathfrak{o}_{k_{v}}^{\times}$.

If L is one of the above lattices, then $\mathbf{o}_{k_v}^{\times} \subseteq Q(L)$.

Proof. Since

$$\mathfrak{o}_{k_v}^{\times} = (\mathfrak{o}_{k_v}^{\times} \cap Q(\mathfrak{o}_{k_v}x \perp \mathfrak{o}_{k_v}z)) \cup \Delta(\mathfrak{o}_{k_v}^{\times} \cap Q(\mathfrak{o}_{k_v}x \perp \mathfrak{o}_{k_v}z))$$

by [19, 63:11], one only needs to show that

$$\Delta(\mathfrak{o}_{k_v}^{\times} \cap Q(\mathfrak{o}_{k_v}x \perp \mathfrak{o}_{k_v}z)) \subset Q(L).$$

Indeed, for any $(1+4\rho)Q(\beta x+\gamma z) \in \mathfrak{o}_{k_v}^{\times}$ with $\beta, \gamma \in \mathfrak{o}_{k_v}$, one can take $\xi \in \mathfrak{o}_{k_v}^{\times}$ such that

$$\xi^{2} = \begin{cases} \beta^{2} + 4\rho\pi_{v}\epsilon\gamma^{2} & \text{for Case 1} \\ \gamma^{2} + 4\rho\pi_{v}\epsilon\beta^{2} & \text{for Case 2} \end{cases}$$

by [19, 63:1]. For Case 2, one can assume that $ord_v(\beta) < ord_v(2)$. Otherwise, one has $Q(\beta x + \gamma z) \in (\mathfrak{o}_{k_*}^{\times})^2$

by [19, 63:1]. Since

$$2x + (\rho - \epsilon \pi_v)\pi_v^a y + z \in L \quad \text{with} \quad Q(2x + (\rho - \epsilon \pi_v)\pi_v^a y + z) = 1 + 4\rho,$$

one concludes that $(1 + 4\rho)Q(\beta x + \gamma z) \in Q(L)$ as desired.

Let

$$\eta = \begin{cases} 2\rho \pi_v^a \beta^2 \xi^{-1} & \text{for Case 1} \\ 2\rho \pi_v^a \gamma^2 \beta^{-1} & \text{for Case 2} \end{cases}$$

in \mathbf{o}_{k_v} and

$$w = \begin{cases} \xi x + \eta y + \gamma z & \text{for Case 1} \\ \beta x + \eta y + \xi z & \text{for Case 2} \end{cases}$$

in L. Then $(1 + 4\rho)Q(\beta x + \gamma z) = Q(w) \in Q(L)$ as desired.

Proposition 2.16. Let L be an \mathfrak{o}_{k_v} -lattice of rank 3 with the minimal norm Jordan splitting $L = L_1 \perp L_2$. Then L is universal if and only if $\mathfrak{n}(L) = \mathfrak{o}_{k_v}$ and $\operatorname{rank}(L_1) = 2$ and one of the conditions holds.

- 1) $L_1 \cong 2^{-1}A(0,0).$ 2) $(\pi_v)\mathfrak{n}(L_1) = \mathfrak{n}(L_2)$ and k_vL is isotropic. 3) $\mathfrak{n}(L_1) = (\pi_v)\mathfrak{n}(L_2)$ and k_vL is isotropic.
- *Proof.* Sufficiency. For Case 1), since $2^{-1}A(0,0)$ is universal, one obtains that L is universal. For Case 2), one can assume that

$$\mathfrak{d}(-\det(L_1)\pi^{-2s_1}) \subseteq 4\mathfrak{o}_{k_n}$$

by Prop. 2.7, where $s_1 = \operatorname{ord}_v(\mathfrak{s}(L_1))$. Since $k_v L$ is isotropic, one concludes that

$$\mathfrak{d}(-\det(L_1)\pi^{-2s_1})=0$$

by the principle of domination in [23]. Therefore $\mathfrak{o}_{k_v}^{\times} \subseteq Q(L)$ by Lemma 2.15 Case 1. Write $L_1 = \mathfrak{o}_{k_v} x + \mathfrak{o}_{k_v} y$ with

$$Q(x) \in \mathfrak{o}_{k_v}^{\times}, \quad B(x,y) = \pi_v^{s_1} \quad \text{and} \quad Q(y) = 0.$$

Then

$$\pi_v \mathfrak{o}_{k_v}^{\times} \subset Q(((\pi_v)x + \mathfrak{o}_{k_v}y) \perp L_2) \subset Q(L)$$

by Lemma 2.15 Case 2 with scaling π_v . Therefore L is universal by Lemma 2.2.

Case 3) follows from the same argument as that of Case 2).

Necessity. Since $Q(L) = \mathfrak{o}_{k_v}$, one has $\mathfrak{n}(L) = \mathfrak{o}_{k_v}$. Suppose rank $(L_1) = 1$. This implies

$$\mathfrak{n}(L_1) = \mathfrak{s}(L_1) = \mathfrak{n}(L) = \mathfrak{o}_k$$
 and $\mathfrak{s}(L_2) = \mathfrak{n}(L_2) = (\pi_v)$

by Prop. 2.8. Therefore $\mathfrak{o}_{k_n}^{\times} \not\subseteq Q(L)$ by Lemma 2.10. A contradiction is derived.

If i(L) = 1 and $L_1 \not\cong 2^{-1} A(0,0)$, one obtains $(\pi_v)\mathfrak{n}(L_1) = \mathfrak{n}(L_2)$ by Lemma 2.13 and Lemma 2.14. Suppose that $k_v L$ is not isotropic. By Prop.2.7, one can assume

$$\mathfrak{d}(-\det(L_1)\pi_v^{-2s_1}) = 4\mathfrak{o}_{k_v}$$

with $s_1 = \operatorname{ord}_v(\mathfrak{s}(L_1))$. Then $\pi_v \mathfrak{o}_{k_v}^{\times} \not\subseteq Q(L)$ by Lemma 2.12 with scaling π_v^{-1} and a contradiction is derived.

If i(L) = 2 and $L_1 \not\cong 2^{-1}A(0,0)$, one obtains $\mathfrak{n}(L_1) = (\pi_v)\mathfrak{n}(L_2)$ by Prop.2.6 and Prop.2.8. Suppose that $k_v L$ is not isotropic. Then $\mathfrak{o}_{k_v}^{\times} \not\subseteq Q(L)$ by Prop.2.7 and Lemma 2.12 and a contradiction is derived.

Recall the norm group $\mathfrak{g}(L)$ and the weight $\mathfrak{w}(L)$ of \mathfrak{o}_{k_v} -lattice L is defined as follows

$$\mathfrak{g}(L) = Q(L) + 2\mathfrak{s}(L)$$
 and $\mathfrak{w}(L) = (\pi_v)\mathfrak{m}(L) + 2\mathfrak{s}(L)$

where $\mathfrak{m}(L)$ is the largest fractional ideal contained in $\mathfrak{g}(L)$ by [19, §93 A].

Proposition 2.17. A unimodular \mathfrak{o}_{k_v} -lattice L of rank 3 over dyadic local fields is universal if and only if $\mathfrak{w}(L) = (\pi_v)$ and $k_v L$ is isotropic.

Proof. Sufficiency. Since $k_v L$ is isotropic, one has

 $L = \mathfrak{o}_{k_v} x \perp (\mathfrak{o}_{k_v} y + \mathfrak{o}_{k_v} z) \text{ with } Q(x) \in \mathfrak{o}_{k_v}^{\times}, \text{ ord}_v(Q(y)) = 1, B(y, z) = 1 \text{ and } Q(z) = 0$

by [19, 93:18 (iv)] and the principle of domination in [23]. Then $\mathfrak{o}_{k_v}^{\times} \subseteq Q(L)$ by Lemma 2.15 Case 2. Since

 $\pi_v \mathfrak{o}_{k_v}^{\times} \subset Q((\pi_v) x \perp (\mathfrak{o}_{k_v} y + \mathfrak{o}_{k_v} z)) \subset Q(L)$

by Lemma 2.15 Case 1 with scaling π_v , one concludes that L is universal by Lemma 2.2.

Necessity. Suppose $\mathfrak{w}(L) \subseteq (\pi_v^2)$. Since $L = \mathfrak{o}_{k_v} x \perp (\mathfrak{o}_{k_v} y + \mathfrak{o}_{k_v} z)$ with

 $Q(x) \in \mathfrak{o}_{k_v}^{\times}, \quad \operatorname{ord}_v Q(y) = \operatorname{ord}_v \mathfrak{w}(L), \quad B(y, z) = 1 \quad \text{and} \quad \operatorname{ord}_v(Q(z)) \ge 2\operatorname{ord}_v 2 - \operatorname{ord}_v Q(y)$

by [19, 93:18 (iv)], one concludes $Q(x)(1 + \pi_v) \notin Q(L)$ by [19, 63:5]. A contradiction is derived. Suppose $k_v L$ is anisotropic. Then $L = \mathfrak{o}_{k_v} x \perp (\mathfrak{o}_{k_v} y + \mathfrak{o}_{k_v} z)$ with

 $Q(x) \in \mathfrak{o}_{k_v}^{\times}, \text{ ord}_v Q(y) = 1, B(y, z) = 1 \text{ and } \mathfrak{d}(1 - Q(y)Q(z)) = 4\mathfrak{o}_{k_v}$

by [19, 93:18 (iv)]. Therefore $Q(x)\Delta \notin Q(L)$ by [19, 63:1, 63:5] and the principle of domination in [23]. A contradiction is derived.

3. Indefinite universal quadratic forms over number fields

In this section, we will apply our computations in \S^2 to study indefinite universal quadratic forms over a number field k.

Definition 3.1. Let *L* be an \mathfrak{o}_k -lattice.

(1) We say that L is (globally) universal if $Q(L) = \mathfrak{o}_k$.

(2) We say that L is locally universal if L_v is universal for all $v \in \Omega_k \setminus \infty_k$ and $Q(k_v L) = k_v$ for all $v \in \infty_k$.

Recall that two \mathfrak{o}_k -lattices M and N in the same quadratic space V = kM = kN are in same class if there is $\sigma \in O(V)$ such that $M = \sigma N$. This class is denoted by cls(M). Moreover, we say M and N are in the same proper class if there is $\tau \in O^+(V)$ such that $M = \tau N$. This sub-class is denoted by $cls^+(M)$.

Let L be an \mathfrak{o}_k -lattice on a quadratic space (V, Q) and $O_{\mathbb{A}}(V)$ be the adelic group of O(V). One can define gen(L) to be the orbit of L under the action of $O_{\mathbb{A}}(V)$. It is well known that the number of proper classes in gen(L) is finite by [19, 103:4].

Proposition 3.2. Suppose that $|\operatorname{Pic}(\mathfrak{o}_k)|$ is odd and L is an \mathfrak{o}_k -lattice with $\operatorname{rank}(L) \geq 3$. If L is locally universal, then gen(L) contains only a single proper class. In particular, L is universal.

Proof. By [19, 101:8; 102:7; 104:5], the number $h^+(L)$ of proper classes in gen(L) is given by

$$h^+(L) = \left[\mathbb{I}_k : k^{\times} (\prod_{v \in \infty_k} k_v^{\times} \times \prod_{v \notin \infty_k} \theta(O^+(L_v)))\right]$$

where \mathbb{I}_k is the idelic group of k, $O^+(L_v) = \{ \sigma \in O^+(V_v) : \sigma(L_v) = L_v \}$ and θ is the spinor norm map. Since

$$\theta(O^+(L_v)) \supseteq \mathfrak{o}_{k_v}^{\times}(k_v^{\times})^2$$

by Lemma 2.2, one has

$$h^{+}(L) \mid [\mathbb{I}_{k} : k^{\times}((\prod_{v \in \infty_{k}} k_{v}^{\times}) \times (\prod_{v \notin \infty_{k}} \mathfrak{o}_{k_{v}}^{\times}))\mathbb{I}_{k}^{2}].$$

Since

$$|\operatorname{Pic}(\mathbf{o}_k)| = [\mathbb{I}_k : k^{\times}((\prod_{v \in \infty_k} k_v^{\times}) \times (\prod_{v \notin \infty_k} \mathbf{o}_{k_v}^{\times}))]$$

by [19, 33:14], one concludes that $h^+(L)$ divides 2-part of $|\operatorname{Pic}(\mathfrak{o}_k)|$. Since $|\operatorname{Pic}(\mathfrak{o}_k)|$ is odd, one obtains $h^+(L) = 1$ as desired. This in particular implies that L is universal.

As [24, Theorem 3 and Theorem 4] over \mathbb{Z} , one can apply Prop.3.2 to determine all universal ternary quadratic forms over the number fields of which the class numbers are odd by Prop.2.3, Prop.2.11, Prop.2.16 and Prop.2.17. On the other hand, there do exist universal quadratic forms such that the genera contain more than one (proper) classes.

Example 3.3. Let $k = \mathbb{Q}(\sqrt{-pq_1\cdots q_s})$ where p is a primes with $p \equiv 3 \mod 8$ and q_i is a prime with $q_i \equiv 1 \mod 8$ for $1 \leq i \leq s$. Consider $f = x^2 + y^2 + z^2$ over \mathfrak{o}_k . Then f is universal over \mathfrak{o}_k and gen(f) contains 2^s (proper) classes.

Proof. By [10, Theorem], the quadratic form f is universal over \boldsymbol{o}_k . By [19, 92:5] and [11, Prop.A], the number h(f) of (proper) classes in gen(f) is given by

$$h(f) = [\mathbb{I}_k : k^{\times}((\prod_{v \in \{2, \infty_k\}} k_v^{\times}) \times (\prod_{v \notin \{2, \infty_k\}} \mathfrak{o}_{k_v}^{\times}))\mathbb{I}_k^2]$$

where \mathbb{I}_k is the idelic group of k as Prop.3.2. Since $(i_v)_{v \in \Omega_k} = 2 \cdot (j_v)_{v \in \Omega_k}$ where

$$i_v = \begin{cases} 1 & v \neq 2 \\ 2 & v = 2 \end{cases} \quad \text{and} \quad j_v = \begin{cases} 2^{-1} & v \neq 2 \\ 1 & v = 2 \end{cases},$$

one concludes that

$$k^{\times}((\prod_{v \in \{2,\infty_k\}} k_v^{\times}) \times (\prod_{v \notin \{2,\infty_k\}} \mathfrak{o}_{k_v}^{\times})) = k^{\times}((\prod_{v \in \infty_k} k_v^{\times}) \times (\prod_{v \notin \infty_k} \mathfrak{o}_{k_v}^{\times})).$$

Therefore

$$h(f) = [\operatorname{Pic}(\mathfrak{o}_k) : \operatorname{Pic}(\mathfrak{o}_k)^2] = 2^s$$

by [19, 33:14] and [5, Theorem 6.1].

By strong approximation for spin groups, every integral quadratic forms with more than three variables which is locally universal is globally universal. However, this is not true any more for integral quadratic forms with two or three variables. Indeed, Estes and Hsia [10, Theorem] determined all imaginary quadratic fields such that $x^2 + y^2 + z^2$ is locally universal but not globally.

Let L be a ternary \mathfrak{o}_k -lattice such that $k_v L$ is indefinite for some $v \in \infty_k$. An integer $a \in \mathfrak{o}_k$ is called exceptional for gen(L) if a is represented by gen(L) but is not represented by every lattice in gen(L). A purely local criterion for determining exceptional integers was given by Schulze-Pillot in [26] and generalized by Hsia, Shao and Xu in [13].

Theorem 3.4. (Schulze-Pillot) Let L be a ternary \mathbf{o}_k -lattice such that $k_v L$ is indefinite for some $v \in \infty_k$. An integer $a \in \mathbf{o}_k$ is exceptional for gen(L) if and only if $-a \cdot \det(L) \notin (k^{\times})^2$ and

$$\theta_v(X(L_v, a)) = N_{k_v(\sqrt{-a \cdot \det(L)})/k_v}(k_v(\sqrt{-a \cdot \det(L)})^{\times}) \quad \text{for all } v \in \Omega_k$$

where θ_v is the spinor norm map and

$$X(L_v, a) = \{ \sigma \in O^+(k_v L) : x \in \sigma(L_v) \}$$

with $x \in L_v$ satisfying Q(x) = a.

The explicit computation of $X(L_v, a)$ over non-dyadic and unramified dyadic fields is given in [26] and over general dyadic fields in [30].

It is natural to ask what kind of number fields admit an integral quadratic form with two or three variables which are locally universal but not globally. We give a complete answer to this question by applying Theorem 3.4.

Theorem 3.5. Let k be a number field.

(1) There is a binary \mathbf{o}_k -lattice which is locally universal but not globally if and only if $|\operatorname{Pic}(\mathbf{o}_k)| > 1$. In this case, each binary \mathbf{o}_k -lattice L which is locally universal but not globally is given by

$$L = \mathfrak{a}x + \mathfrak{a}^{-1}y$$
 with $Q(x) = Q(y) = 0$ and $B(x, y) = \frac{1}{2}$

where \mathfrak{a} is a non-principal fractional ideal of k. Moreover, there is one to one correspondence between the set of proper classes of such binary \mathfrak{o}_k -lattices with the set of non-trivial classes in $\operatorname{Pic}(\mathfrak{o}_k)$ by sending L to $\overline{\mathfrak{a}} \in \operatorname{Pic}(\mathfrak{o}_k)$.

(2) There is a ternary \mathbf{o}_k -lattice which is locally universal but not globally if and only if $|\operatorname{Pic}(\mathbf{o}_k)|$ is even. In this case, there are infinitely many classes of such ternary free \mathbf{o}_k -lattices.

Proof. For (1), we consider a binary \mathfrak{o}_k -lattice L which is locally universal. Then kL is isotropic and L is $\frac{1}{2}\mathfrak{o}_k$ -modular by Prop.2.3 and Cor.2.9. There is a fractional ideal \mathfrak{a} of \mathfrak{o}_k such that

$$L = \mathfrak{a}x + \mathfrak{a}^{-1}y$$
 with $Q(x) = Q(y) = 0$ and $B(x, y) = \frac{1}{2}$

by [19, 82:21a].

If \mathfrak{a} is principal, then L is universal.

If \mathfrak{a} is not principal, we claim that L is not universal. Indeed, suppose not, then $1 \in Q(L)$. There are $a \in \mathfrak{a}$ and $b \in \mathfrak{a}^{-1}$ such that Q(ax + by) = ab = 1. Namely, both $a\mathfrak{a}^{-1}$ and $b\mathfrak{a}$ are contained in \mathfrak{o}_k . By the unique factorization theorem for Dedekind domain [19, 22:7], one concludes that $\mathfrak{a} = (a)$ and $\mathfrak{a}^{-1} = (b)$ which is a contradiction.

Since any $\sigma \in O^+(V)$ is given by

$$\sigma(x) = \alpha x; \quad \sigma(y) = \alpha^{-1} y$$

for $\alpha \in k^{\times}$, this implies that the above correspondence is well-defined and bijective.

For (2), the necessity follows from Prop.3.2. Now we prove the sufficiency. Since $|\operatorname{Pic}(\mathfrak{o}_k)|$ is even, there is an unramified quadratic extension $K = k(\sqrt{a})$ with $a \in \mathfrak{o}_k$ by [21, Chapter IV, (7.1) Theorem]. Let

$$L = (\mathbf{o}_k x + \mathbf{o}_k y) \perp \mathbf{o}_k z$$
 with $Q(x) = Q(y) = 0$, $B(x, y) = \frac{1}{2}$ and $Q(z) = 4a$.

Then every lattice in gen(L) is locally universal by Prop.2.3 and Corollary 2.9. We claim that 1 is an exceptional integer for gen(L). Indeed, since $K = k(\sqrt{a})$ is unramified, one concludes that $\operatorname{ord}_{v}(a)$ is even for all non-archimedean primes and the quadratic defect

$$\mathfrak{d}(\pi_v^{-\mathrm{ord}_v(a)}a) \subseteq (\pi_v^{2\mathrm{ord}_v(2)})$$

for all dyadic primes v. Then one can verify

$$\theta_v(X(L_v, 1)) = N_{K_{\mathfrak{P}}/k_v}(K_{\mathfrak{P}}^{\times}) \text{ for all } v \in \Omega_k$$

where \mathfrak{P} is a prime of K above v by [26, Satz 3] and [30, Theorem 2.1]. By Theorem 3.4, there is an \mathfrak{o}_k -lattice $M \in \text{gen}(L)$ such that M does not represent 1. Namely, M is locally universal but not globally universal as desired.

One can even construct such M explicitly. Indeed, choose an ideal \mathfrak{a} of \mathfrak{o}_k such that the image of \mathfrak{a} in $\operatorname{Gal}(K/k)$ is not trivial under the Artin map by [22, Chapter IV, (8.2) Theorem]. Then we take

$$M = (\mathfrak{a}x + \mathfrak{a}^{-1}y) \perp \mathfrak{o}_k z \in gen(L)$$

which is a free \mathfrak{o}_k -module by [19, 81:5 and 81:8]. By [13, Theorem 4.1], one concludes that $1 \notin Q(M)$. Based on M, we can construct infinitely many classes of free \mathfrak{o}_k -lattices which are locally universal but not globally. Indeed, by Tchebotarev's density theorem (see [22, Chapter V, (6.4) Theorem]), there are infinitely many principal prime ideals \mathfrak{p}_i of \mathfrak{o}_k for $i = 1, \cdots$. Let

$$M_i = (\mathfrak{a}x + \mathfrak{a}^{-1}y) \perp \mathfrak{p}_i z \subset M$$

for $i = 1, \dots$. Then M_i is locally universal by Prop.2.3 and Prop.2.16 and free by [19, 81:5 and 81:8] for $i = 1, \dots$. Since $1 \notin Q(M)$, one obtains that $1 \notin Q(M_i)$ for $i = 1, \dots$. Since $\det(M_i) \neq \det(M_j)$ for $i \neq j$, one has $\operatorname{cls}(M_i) \neq \operatorname{cls}(M_j)$ for $i \neq j$. The proof is complete. \Box

Corollary 3.6. A locally universal binary \mathfrak{o}_k -lattice L is globally universal if and only if L represents 1. In this case,

$$L = \mathfrak{o}_k x + \mathfrak{o}_k y$$
 with $Q(x) = Q(y) = 0$ and $B(x, y) = \frac{1}{2}$.

Proof. It follows from the proof of Theorem 3.5 (1).

Remark 3.7. For Theorem 3.5 (1), one also has one to one correspondence

{ classes of binary locally universal \mathfrak{o}_k -lattices } \leftrightarrow \operatorname{Pic}(\mathfrak{o}_k)/\mu_2

where μ_2 acts on $\operatorname{Pic}(\mathfrak{o}_k)$ by $(-1) \circ \mathfrak{a} = \mathfrak{a}^{-1}$ for any $\mathfrak{a} \in \operatorname{Pic}(\mathfrak{o}_k)$. The unique globally universal binary lattice corresponds the trivial element in $\operatorname{Pic}(\mathfrak{o}_k)/\mu_2$. This is because

$$O(V) = O^+(V) \cup \tau O^+(V)$$

where $V = Fx + Fy$ with $Q(x) = Q(y) = 0, B(x, y) = \frac{1}{2}$ and $\tau(x) = y, \ \tau(y) = x$

Example 3.8. Since every locally universal binary \mathfrak{o}_k -lattice L is free by Theorem 3.5 (1) and [19, 81:5 and 81:8], one can express such binary lattices in term of homogeneous polynomials of degree 2 with two variables.

Let $k = \mathbb{Q}(\sqrt{-5})$. The class number of k is 2 by the class number formula (see [22, Chapter VII, (5.11) Corollary, (2.9) Theorem and (10.5) Corollary]). By using Minkowski bound (see [22, Chapter I, §6, Exercise 3]), one has the ideal $\mathfrak{a} = (2, 1 + \sqrt{-5})$ is an ideal of \mathfrak{o}_k above 2 which is not principal.

Consider a binary \mathbf{o}_k -lattice

$$L = \mathfrak{a}\xi_1 + \mathfrak{a}^{-1}\xi_2$$
 with $Q(\xi_1) = Q(\xi_2) = 0$ and $B(\xi_1, \xi_2) = \frac{1}{2}$

which is universal by Prop.3.2. Since

$$\mathfrak{a}^{-1} = (\frac{1-\sqrt{-5}}{2}, 2)$$
 and $(1+\sqrt{-5})\mathfrak{a}^{-1} + \mathfrak{a} = \mathfrak{o}_k$,

one can make the following substitution

$$\begin{cases} \eta_1 = (1 + \sqrt{-5})\xi_1 + \xi_2\\ \eta_2 = 2\xi_1 + \frac{1}{2}(1 - \sqrt{-5})\xi_2 \end{cases}$$

Then $L = \mathbf{o}_k \eta_1 + \mathbf{o}_k \eta_2$ by [19, 81:8] and the corresponding quadratic form is

$$(1+\sqrt{-5})x^2 + 5xy + (1-\sqrt{-5})y^2$$

which is unique class of locally universal but not globally binary quadratic form.

By Theorem 3.5 (2), there are infinitely many ternary free \mathfrak{o}_k -lattices which are locally universal but not globally. Since the Hilbert class field of k is given by $k(\sqrt{-1})$ by [5, Theorem 6.1], one can exhibit the following infinitely many ternary integral quadratic forms which are locally universal but not globally

$$(1+\sqrt{-5})x^2 + 5xy + (1-\sqrt{-5})y^2 - 4p^2z^2$$

where p's are the primes such that $\left(\frac{-5}{p}\right) = -1$ and $p \equiv 1 \mod 4$ by the proof of Theorem 3.5 (2).

For ternary \mathbf{o}_k -lattices, we extend and refine [7, Theorem 22] (see also [24, Theorem 5]) to general number fields.

Proposition 3.9. Let L be an \mathfrak{o}_k -lattice of rank 3. If L is locally universal, then kL is isotropic.

Proof. By Prop.2.3, Prop.2.11, Prop.2.16 and Prop.2.17, one obtains that $k_v L_v$ is isotropic. Since $k_v L$ is also isotropic for all archimedean primes v, one concludes that kL is isotropic by Hasse-Minkowski Theorem (see [19, 66:1]).

In [24, Theorem 6], Ross further proved that every ternary quadratic form with non-trivial zero over \mathbb{Q} and square-free discriminant over \mathbb{Z} is universal. Such a result does not hold over general number fields.

Example 3.10. Let $k = \mathbb{Q}(\sqrt{-pq})$ where $p \equiv 7 \mod 8$ and $q \equiv 5 \mod 8$ are primes with $(\frac{q}{p}) = 1$. The quadratic form $f = x^2 + y^2 + z^2$ is locally universal over \mathfrak{o}_k with discriminant 1 by [14, Prop.2.2]. Then f is isotropic over k_v for all $v \in \Omega_k$ by Prop.2.3, Prop.2.11, Prop.2.16 and Prop.2.17. Therefore f is isotropic over k by Hasse-Minkowski Theorem (see [19, 66:1]). However, f is not universal over \mathfrak{o}_k by [10, Theorem].

Contrary to the positive definite case, one has the following result.

Proposition 3.11. For any positive integer N, there are infinitely many classes of integral quadratic forms over \mathbb{Z} which represents all integers between -N and N but are not universal.

Proof. Let p and q be primes with p > N and q > N such that $p \equiv q \equiv 3 \mod 4$. Consider indefinite quadratic form $f = x^2 + y^2 - pqz^2$.

First of all, we claim that f is not universal over \mathbb{Z} . Indeed, since $p \equiv q \equiv 3 \mod 4$, one obtains that f is not locally universal at v = p and q by Prop.2.3. In this case, the Hasse symbol of f is not equal to $\left(\frac{-1,-1}{\mathbb{Q}_v}\right)$ for v = p and q by [19, 58:6].

On the other hand, we have that f is locally universal at all odd primes $v \neq p, q$ by Prop.2.3. This implies that the Hasse symbol of f is equal to $\left(\frac{-1,-1}{\mathbb{Q}_v}\right)$ for all odd primes $v \neq p, q$.

Since the Hasse symbol of f at \mathbb{R} is equal to $(\frac{-1,-1}{\mathbb{R}})$, one concludes that the Hasse symbol of f at v = 2 is equal to $(\frac{-1,-1}{\mathbb{Q}_2})$ by the Hilbert reciprocity law [19, 71:18]. Therefore f is isotropic over \mathbb{Q}_2 by [19, 58:6]. By Prop.2.17, one obtains that f is locally universal over \mathbb{Z}_2 .

By the same proof of Prop.3.2, one concludes that gen(f) contains a single proper class. Therefore each integer which is represented by f locally will be represented by f. Since all integers between -N and N are not divisible by p and q, these integers are represented by fat primes v = p and q. This implies that all integers between -N and N are represented by fas desired.

Since there are infinitely many such pairs of primes (p, q) as above, one gets infinitely many quadratic forms as above. The proof is complete.

4. POTENTIAL UNIVERSAL QUADRATIC FORMS

In this section, we consider the following generalization of universal lattices.

Definition 4.1. Let k be a number field and L be an \boldsymbol{o}_k -lattice.

(1) We say that L is potentially universal if there is a finite extension K/k such that $\mathfrak{o}_k \subset Q(L)$ with $\widetilde{L} = L \otimes_{\mathfrak{o}_k} \mathfrak{o}_K$.

(2) An element $\alpha \in \mathfrak{o}_k$ is potentially represented by L if there is a finite extension K/k such that $\alpha \in Q(\widetilde{L})$ with $\widetilde{L} = L \otimes_{\mathfrak{o}_k} \mathfrak{o}_K$.

Let \bar{k} be an algebraic closure of k, $\mathfrak{o}_{\bar{k}}$ be the ring of all algebraic integers in \bar{k} and $\mathfrak{o}_{\bar{k}}^{\times}$ be the group of units in $\mathfrak{o}_{\bar{k}}$. For any $\delta \in \mathfrak{o}_{\bar{k}}$, we set

$$\mathfrak{o}_{\bar{k}}(\delta) = \{ x \in \mathfrak{o}_{\bar{k}} : (x, \delta) = \mathfrak{o}_{\bar{k}} \}.$$

Lemma 4.2. With the above notations, one has

$$\mathfrak{o}_{\bar{k}}(\delta) = \mathfrak{o}_{\bar{k}}^{\times} + \delta \mathfrak{o}_{\bar{k}}$$

for any $\delta \in \mathfrak{o}_{\bar{k}}$.

Proof. Since

$$\mathbf{o}_{\bar{k}}(\delta) = \begin{cases} \mathbf{o}_{\bar{k}}^{\times} & \text{if } \delta = 0\\ \mathbf{o}_{\bar{k}} & \text{if } \delta \in \mathbf{o}_{\bar{k}}^{\times} \end{cases}$$

by the definition of $\mathfrak{o}_{\bar{k}}(\delta)$, the result holds obviously for these two cases.

For $\delta \in \mathfrak{o}_{\bar{k}} \setminus \mathfrak{o}_{\bar{k}}^{\times}$ with $\delta \neq 0$, we only need to show $\mathfrak{o}_{\bar{k}}(\delta) \subseteq \mathfrak{o}_{\bar{k}}^{\times} + \delta \mathfrak{o}_{\bar{k}}$. For any $\gamma \in \mathfrak{o}_{\bar{k}}(\delta)$, one needs to construct two polynomials

 $f(x) = x^m + a_{m-1}x^{m-1} + \dots + a_1x + 1$ and $g(x) = x^m + b_{m-1}x^{m-1} + \dots + b_1x + b_0$

over $\mathfrak{o}_{\bar{k}}$ such that

$$\delta^m g(x) = \gamma^m f(\frac{1+\delta x}{\gamma})$$
 or $\gamma^m f(x) = \delta^m g(\frac{\gamma x - 1}{\delta}).$

Equivalently, the following linear equations

$$\begin{bmatrix} (-1)^{0}C_{m}^{0} & 0 & 0 & \cdots & 0\\ (-1)^{1}C_{m}^{1} & (-1)^{0}C_{m-1}^{0} & 0 & \cdots & 0\\ (-1)^{2}C_{m}^{2} & (-1)^{1}C_{m-1}^{1} & (-1)^{0}C_{m-2}^{0} & \cdots & 0\\ \vdots & \vdots & \vdots & \ddots & \vdots\\ (-1)^{m}C_{m}^{m} & (-1)^{m-1}C_{m-1}^{m-1} & (-1)^{m-2}C_{m-2}^{m-2} & \cdots & (-1)^{0}C_{0}^{0} \end{bmatrix} \begin{bmatrix} 1\\ \delta b_{m-1}\\ \delta^{2}b_{m-2}\\ \vdots\\ \delta^{m}b_{0} \end{bmatrix} = \begin{bmatrix} 1\\ \gamma a_{m-1}\\ \gamma^{2}a_{m-2}\\ \vdots\\ \gamma^{m} \end{bmatrix}$$

are solvable over $\mathbf{o}_{\bar{k}}$ for some positive integer m, where a_1, \dots, a_{m-1} and b_0, b_1, \dots, b_{m-1} are variables.

Let K/k be a finite extension such that $\delta, \gamma \in K$. Choose a positive even integer m such that $\gamma^m \equiv 1 \mod \delta \mathfrak{o}_K$. By Chinese Remainder Theorem [19, 21:2], the above linear equations are solvable over \mathfrak{o}_K if and only if they are solvable over all completions of \mathfrak{o}_K .

If $v \in \Omega_K \setminus \infty_K$ with $\operatorname{ord}_v(\delta) = 0$, one obtains that the above linear equations are solvable over \mathfrak{o}_{K_v} by arbitrarily choosing values of a_1, \dots, a_{m-1} in \mathfrak{o}_{K_v} and inverting the matrix.

If $v \in \Omega_K \setminus \infty_K$ with $\operatorname{ord}_v(\delta) > 0$, one obtains that $\operatorname{ord}_v(\gamma) = 0$ by $\gamma \in \mathfrak{o}_{\bar{k}}(\delta)$. By taking

$$b_0 = \dots = b_{m-2} = 0$$
 and $b_{m-1} = (1 - \gamma^m)\delta^{-1} \in \mathfrak{o}_K$,

one concludes that the above equations is solvable over \mathfrak{o}_{K_v} .

One can reformulate Lemma 4.2 as the following interesting result.

Corollary 4.3. For any ideal \mathfrak{a} of $\mathfrak{o}_{\bar{k}}$, the natural map $\mathfrak{o}_{\bar{k}}^{\times} \to (\mathfrak{o}_{\bar{k}}/\mathfrak{a})^{\times}$ is surjective.

Proof. Let $x \in \mathfrak{o}_{\bar{k}}$ with $\overline{x} \in (\mathfrak{o}_{\bar{k}}/\mathfrak{a})^{\times}$. Then $(x) + \mathfrak{a} = \mathfrak{o}_{\bar{k}}$. There is $\delta \in \mathfrak{a}$ such that $x \in \mathfrak{o}_{\bar{k}}(\delta)$. By Lemma 4.2, there is $y \in \mathfrak{o}_{\bar{k}}^{\times}$ such that $x - y \in (\delta) \subseteq \mathfrak{a}$ as desired.

The following theorem is known as the principal idea theorem in class field theory (see [21, Chapter IV, (8.6) Theorem]).

Theorem 4.4. Every ideal of k becomes an principal ideal in the Hilbert class field of k.

By applying Theorem 4.4, one can obtain the following result.

Lemma 4.5. Let k be a number field. If δ is a non-zero element in \mathfrak{o}_k , then there is a finite extension K/k with $b_1, \dots, b_n, \sqrt{\delta} \in \mathfrak{o}_K$ such that any non-zero element $x \in \mathfrak{o}_k$ can be written as

$$x = b_1^{r_1} b_2^{r_2} \cdots b_n^{r_n} (1 + 2\rho(x)\sqrt{\delta})$$

where $r_1 \ge 0, \cdots, r_n \ge 0$ are integers and $\rho(x) \in \mathfrak{o}_K$.

Proof. Let $K_1 = k(\sqrt{\delta})$ and K_2 be the Hilbert class field of K_1 . Let $\mathfrak{p}_1, \dots, \mathfrak{p}_m$ be all prime ideals of \mathfrak{o}_{K_1} containing $2\sqrt{\delta}\mathfrak{o}_{K_1}$. By , there is $a_i \in \mathfrak{o}_{K_2}$ such that $\mathfrak{p}_i\mathfrak{o}_{K_2} = (a_i)$ for $1 \leq i \leq m$.

Consider the action of additive group $(2\sqrt{\delta}\mathfrak{o}_{K_2}, +)$ on the set $\mathfrak{o}_{K_2} \cap \mathfrak{o}_{\bar{k}}(2\sqrt{\delta})$ by translation. Since $\delta \neq 0$ and $\mathfrak{o}_{K_2}/(2\sqrt{\delta}\mathfrak{o}_{K_2})$ is finite, the set $\mathfrak{o}_{K_2} \cap \mathfrak{o}_{\bar{k}}(2\sqrt{\delta})$ can be decomposed into finitely many orbits

$$\mathfrak{o}_{K_2} \cap \mathfrak{o}_{\bar{k}}(2\sqrt{\delta}) = \bigcup_{i=1}^{\iota} (\xi_i + 2\sqrt{\delta}\mathfrak{o}_{K_2}) \quad \text{with} \quad \xi_i = \eta_i + 2\sqrt{\delta}\tau_i \in \mathfrak{o}_{K_2} \cap \mathfrak{o}_{\bar{k}}(2\sqrt{\delta})$$

by Lemma 4.2, where $\eta_i \in \mathfrak{o}_{\bar{k}}^{\times}$ and $\tau_i \in \mathfrak{o}_{\bar{k}}$ for $i = 1, \dots, t$.

By Dirichlet Unit Theorem [19, 33:10], the group of units $\mathfrak{o}_{K_2}^{\times}$ is generated by u_1, \dots, u_s . Let

$$K = K_2(\eta_1, \cdots, \eta_t, \tau_1, \cdots, \tau_t)$$

with

$$\{b_1, \cdots, b_n\} = \{a_1, \cdots, a_m, \eta_1, \cdots, \eta_t, u_1, \cdots, u_s, u_1^{-1}, \cdots, u_s^{-1}\}.$$

For any $x \in \mathfrak{o}_k$ with $x \neq 0$, one has the decomposition

$$x \mathfrak{o}_{K_1} = \mathfrak{a} \cdot \prod_{i=1}^m \mathfrak{p}_i^{l_i} \quad \text{with} \quad (\mathfrak{a}, 2\sqrt{\delta}\mathfrak{o}_{K_1}) = 1$$

over \mathfrak{o}_{K_1} , where $l_1 \geq 0, \cdots, l_m \geq 0$ are integers. Since $\mathfrak{ao}_{K_2} = a\mathfrak{o}_{K_2}$ by Theorem 4.4, one obtains that

$$a \in \mathfrak{o}_{K_2} \cap \mathfrak{o}_{\bar{k}}(2\sqrt{\delta}) = \bigcup_{i=1}^{t} (\xi_i + 2\sqrt{\delta}\mathfrak{o}_{K_2}).$$

There is $1 \leq i_0 \leq t$ such that

$$a - \xi_{i_0} = a - (\eta_{i_0} + 2\sqrt{\delta}v_{i_0}) \in 2\sqrt{\delta}\mathfrak{o}_{K_2}.$$

This implies that $a = \eta_{i_0}(1 + 2\sqrt{\delta\rho(x)})$ with $\rho(x) \in \mathfrak{o}_K$. Since

$$x\mathfrak{o}_{K_2} = (a\mathfrak{o}_{K_2})\prod_{i=1}^m (a_i^{l_i}\mathfrak{o}_{K_2}),$$

there is $u \in \mathfrak{o}_{K_2}^{\times}$ such that

$$x = ua(\prod_{i=1}^{m} a_i^{l_i}) = (\prod_{i=1}^{s} u_i^{c_i})(\prod_{i=1}^{m} a_i^{l_i})\eta_{i_0}(1 + 2\sqrt{\delta\rho(x)})$$

with $c_i \in \mathbb{Z}$ for $1 \leq i \leq s$ as desired.

The main result of this section is the following theorem.

Theorem 4.6. An \mathfrak{o}_k -lattice L with $\operatorname{rank}(L) \geq 2$ is potentially universal if and only if 1 is potentially represented by L.

Proof. Sufficiency. By finite extension of the ground field if necessary, we simply assume that L represents 1 over \mathfrak{o}_k . There is $x \in L$ such that Q(x) = 1. Since $\operatorname{rank}(L) \geq 2$, there is $y \in L \cap (kx)^{\perp}$ satisfying $Q(y) \in \mathfrak{o}_k$, where $(kx)^{\perp}$ is the orthogonal complement of kx in kL. Let

$$M = (\mathfrak{o}_k x \perp \mathfrak{o}_k y) \subseteq L.$$

One only needs to show that M is potentially universal. Write $Q(y) = \delta \in \mathfrak{o}_k$. By Lemma 4.5, there is a finite extension F/k with $b_1, \dots, b_n, \sqrt{\delta} \in \mathfrak{o}_F$ such that any non-zero element $\alpha \in \mathfrak{o}_k$ can be written as

$$\alpha = b_1^{r_1} b_2^{r_2} \cdots b_n^{r_n} (1 + 2\rho(\alpha)\sqrt{\delta})$$

where $r_1 \ge 0, \cdots, r_n \ge 0$ are integers and $\rho(\alpha) \in \mathfrak{o}_F$. Let $K = F(\sqrt{-1}, \sqrt{b_1}, \sqrt{b_2}, ..., \sqrt{b_n})$. Then

$$\alpha = \left[\prod_{i=1}^{n} (\sqrt{b_i})^{r_i} (1 + \sqrt{\delta\rho(\alpha)})\right]^2 + \delta\left[\prod_{i=1}^{n} (\sqrt{b_i})^{r_i} (\sqrt{-1\rho(\alpha)})\right]^2 \in Q(\widetilde{M})$$

where $\widetilde{M} = M \otimes_{\mathfrak{o}_k} \mathfrak{o}_K$.

Necessity is obvious.

Inspired by the referee's question, we provide another description of potentially universal quadratic forms.

Corollary 4.7. An \mathfrak{o}_k -lattice L with rank $(L) \ge 2$ is potentially universal if and only if $\mathfrak{n}(L) = \mathfrak{o}_k$.

Proof. One only needs to show sufficiency. We first claim that there is a binary \mathfrak{o}_k sub-lattice M of L such that $\mathfrak{n}(M) = \mathfrak{o}_k$. Suppose rank $(L) \geq 3$. Let S be a finite set of non-archimedean primes of k containing all dyadic primes such that $\operatorname{ord}_v(\det(L)) = 0$ for $v \notin (S \cup \infty_k)$. Since $\mathfrak{n}(L) = \mathfrak{o}_k$, one can choose $x_v, y_v \in L_v$ such that

$$\mathfrak{n}(\mathfrak{o}_{k_v}x_v+\mathfrak{o}_{k_v}y_v)=\mathfrak{o}_{k_v}$$

for each $v \in S$. By the number field version of [12, Lemma 1.6] (see also [12, §3]), there are $x, y \in L$ which approximate x_v, y_v at each $v \in S$ respectively such that

 $M = \mathfrak{o}_k x + \mathfrak{o}_k y$ with $\det(M) \in \mathfrak{o}_{k_v}^{\times}$ for all $v \notin (S \cup \infty_k)$ except one prime v_0 and $\operatorname{ord}_{v_0}(\det(M)) = 1$. Since $\operatorname{ord}_{v_0}(\det(M)) = 1$, one concludes that $\mathfrak{n}(M_{v_0}) = \mathfrak{o}_{k_{v_0}}$. Therefore the claim follows and one can assume $\operatorname{rank}(L) = 2$. By Theorem 4.6, we only need to prove that 1 is potentially represented by L.

Let $K = k(\sqrt{-det(L)})$. Then the quadratic space kL becomes isotropic over K. Since

$$\mathfrak{n}(L\otimes_{\mathfrak{o}_k}\mathfrak{o}_K)=\mathfrak{n}(L)\otimes_{\mathfrak{o}_k}\mathfrak{o}_K,$$

one can further assume that the quadratic space kL is isotropic. Write

 $L = \mathfrak{a}x + \mathfrak{b}y$ with Q(x) = 0

where \mathfrak{a} and \mathfrak{b} are fractional ideals of k. By Theorem 4.4, one can assume that both \mathfrak{a} and \mathfrak{b} are principal by scalar extension to the Hilbert class field of k. Therefore one can write

$$L = \mathbf{o}_k x_1 + \mathbf{o}_k y_1$$
 with $Q(x_1) = 0$, $Q(y_1) = a$ and $B(x_1, y_1) = \frac{b}{2}$

where $a, b \in \mathfrak{o}_k$. Since $\mathfrak{n}(L) = \mathfrak{o}_k$, one concludes that $(a, b) = \mathfrak{o}_k$. By Lemma 4.2, there are $u \in \mathfrak{o}_k^{\times}$ and $\xi \in \mathfrak{o}_k$ such that $a = u + b\xi$. Let $E = k(\xi, \sqrt{u})$. Then

$$\frac{\xi}{\sqrt{u}}x_1 - \frac{1}{\sqrt{u}}y_1 \in (L \otimes_k \mathfrak{o}_E) \quad \text{and} \quad Q(\frac{\xi}{\sqrt{u}}x_1 - \frac{1}{\sqrt{u}}y_1) = 1$$

as desired.

Corollary 4.8. If L is a potentially universal \mathfrak{o}_k -lattice for a number field k, then $L \otimes_{\mathfrak{o}_k} \mathfrak{o}_K$ is a potentially universal \mathfrak{o}_K -lattice for any finite extension K/k.

Proof. Since there are only finitely many primes of k ramified in a fixed finite extension of k, one obtains that rank $(L) \ge 2$. The result follows from that fact $\mathfrak{n}(L \otimes_{\mathfrak{o}_k} \mathfrak{o}_K) = \mathfrak{n}(L) \otimes_{\mathfrak{o}_k} \mathfrak{o}_K$ and Corollary 4.7.
