# New Error Bounds in Multivariate Normal Approximations via Exchangeable Pairs with Applications to Wishart Matrices and Fourth Moment Theorems

#### Abstract

We extend Stein's celebrated Wasserstein bound for normal approximation via exchangeable pairs to the multi-dimensional setting. As an intermediate step, we exploit the symmetry of exchangeable pairs to obtain an error bound for smooth test functions. We also obtain a continuous version of the multi-dimensional Wasserstein bound in terms of fourth moments. We apply the main results to multivariate normal approximations to Wishart matrices of size $n$ and degree $d$, where we obtain the optimal convergence rate $\sqrt{n^{3} / d}$ under only moment assumptions, and to degenerate $U$-statistics and Poisson functionals, where we strengthen a few of the fourth moment bounds in the literature on the Wasserstein distance.

## 1 INTRODUCTION AND MAIN RESULTS

Let $W$ be a random variable with $\mathbb{E}(W)=0$ and $\operatorname{Var}(W)=1$. Stein (1986) introduced the following exchangeable pair approach to proving central limit theorems for $W$ with error bounds. Suppose we can construct another random variable $W^{\prime}$ on the same probability space such that ( $W, W^{\prime}$ ) and ( $W^{\prime}, W$ ) have the same distribution (exchangeable), and moreover,

$$
\mathbb{E}\left(W^{\prime}-W \mid W\right)=-\lambda W
$$

for some positive constant $\lambda$ (linearity condition). Then we have (cf. Stein (1986, Theorem 1, Lecture III) and Chen. Goldstein and Shao (2011, Theorem 4.9)):

$$
\begin{aligned}
d_{\mathcal{W}}(W, Z) & :=\sup _{h \in \operatorname{Lip}(\mathbb{R}, 1)}|\mathbb{E} h(W)-\mathbb{E} h(Z)| \\
& \leqslant \sqrt{\frac{2}{\pi}} \mathbb{E}\left|\mathbb{E}\left[\left.1-\frac{1}{2 \lambda}\left(W^{\prime}-W\right)^{2} \right\rvert\, W\right]\right|+\frac{1}{2 \lambda} \mathbb{E}\left|W^{\prime}-W\right|^{3},
\end{aligned}
$$

where $d_{\mathcal{W}}$ denotes the Wasserstein distance, $Z \sim N(0,1)$, and $\operatorname{Lip}(\mathbb{R}, 1)$ denotes the set of 1-Lipschitz functions $h$ on $\mathbb{R}$.

Stein's exchangeable pair approach and its variants have found wide applications in normal approximations. These applications include, but are not limited to, the binary expansion of a random integer (Diaconis (1977) and Stein (1986, Lecture IV)); the antivoter model (Rinott and Rotar (1997)); the representation theory of permutation groups (Fulman (2005)); character ratios (Shao and Su (2006)); the Erdös-Kac theorem (Harper) (2009)); the Curie-Weiss model (Chen. Fang and Shao (2013)); combinatorial central limit theorems (Chen and Fang (2015)); and degenerate $U$-statistics (Döbler and Peccati (2017)). Chatteriee and Shao (2011) extended the approach to non-normal approximations and Shao and Zhang (2019) used the approach to obtain optimal error bounds on the Kolmogorov distance for both normal and non-normal approximations.

Basic setting. Stein's exchangeable pair approach has been extended to the multidimensional setting. Let $d \geqslant 2$ be an integer. We follow the general setting of Reinert and Röllin (2009) and assume that for a $d$-dimensional random vector $W$, we can construct another random vector $W^{\prime}$ on the same probability space such that

$$
\mathcal{L}\left(W, W^{\prime}\right)=\mathcal{L}\left(W^{\prime}, W\right),
$$

and moreover,

$$
\begin{equation*}
\mathbb{E}\left[W^{\prime}-W \mid \mathcal{G}\right]=-\Lambda(W+R) \tag{1.1}
\end{equation*}
$$

for some invertible $d \times d$ matrix $\Lambda$ and $\sigma$-algebra $\mathcal{G}$ containing $\sigma(W)$. Gaussian approximation results and error bounds for such $W$ have been obtained bv. for example. Chatterjee and Meckes (2008) and Reinert and Röllin (2009). However, the existing error bounds mostly apply to smooth function distances (excluding those results in Chatterjee and Meckes (2008) which make the special assumption of a continuous underlying symmetry). Although we can deduce a Wasserstein bound from these results, such deduced bound is in general non-optimal. Our first main result is a Wasserstein bound assuming the existence of fourth moments. The optimality of the bound, in terms of the "sample size", is illustrated by applications to sums of independent random vectors below and to homogeneous sums in Section [2.2. Proofs of the main results stated in this section are given in Section 3.1 .

Theorem 1.1 (Wasserstein bound). Let ( $W, W^{\prime}$ ) be an exchangeable pair of d-dimensional random vectors satisfying the approximate linearity condition (1.1). Assume that $\mathbb{E}|W|^{4}<$ $\infty$. Let $D=W^{\prime}-W$. Also, let $\Sigma$ be a $d \times d$ positive definite symmetric matrix and define the random matrix $E$ by

$$
\begin{equation*}
E:=\frac{1}{2} \mathbb{E}\left[\left(\Lambda^{-1} D\right) D^{\top} \mid \mathcal{G}\right]-\Sigma . \tag{1.2}
\end{equation*}
$$

Then we have

$$
\begin{aligned}
d_{\mathcal{W}}(W, Z): & =\sup _{h \in \operatorname{Lip}\left(\mathbb{R}^{d}, 1\right)}|\mathbb{E} h(W)-\mathbb{E} h(Z)| \\
\leqslant & \mathbb{E}|R|+\left\|\Sigma^{-1 / 2}\right\|_{o p} \sqrt{\frac{2}{\pi}} \mathbb{E}\|E\|_{H . S .} \\
& +\left\|\Sigma^{-1 / 2}\right\|_{o p}^{3 / 2}\left(\frac{\pi}{8}\right)^{1 / 4}\left(\mathbb{E}|W|^{2} \vee \operatorname{tr}(\Sigma)\right)^{1 / 4} \sqrt{\mathbb{E}\left[\left|\Lambda^{-1} D \| D\right|^{3}\right]},
\end{aligned}
$$

where $\operatorname{Lip}\left(\mathbb{R}^{d}, 1\right)$ is the set of all 1-Lipschitz functions on $\mathbb{R}^{d}, Z \sim N(0, \Sigma)$ is a ddimensional centered Gaussian vector with covariance matrix $\Sigma,|\cdot|$ denotes the Euclidean norm, $\|\cdot\|_{o p}$ denotes the operator norm, and $\|\cdot\|_{H . S}$. denotes the Hilbert-Schmidt norm.

Remark 1.1. In Theorem 1.1, we implicitly assumed that $\mathbb{E}(W) \approx 0$ and $\operatorname{Cov}(W) \approx \Sigma$. Otherwise, $\mathbb{E}|R|$ and $\mathbb{E}\|E\|_{\text {H.S. }}$ are not small and the bound is not useful. We need $\Sigma$ to be non-singular to carry out integration by parts in the proof (cf. (3.5)). In the case that $\mathbb{E}(W)=0, \operatorname{Cov}(W)=I_{d}$, where $I_{d}$ denotes the $d \times d$ identity matrix, and $Z$ is a standard $d$-dimensional Gaussian vector, the bound reduces to

$$
\mathbb{E}|R|+\sqrt{\frac{2}{\pi}} \mathbb{E}\|E\|_{H . S .}+\left(\frac{\pi}{8}\right)^{1 / 4} d^{1 / 4} \sqrt{\mathbb{E}\left[\left|\Lambda^{-1} D \| D\right|^{3}\right]}
$$

Sums of independent random vectors. We first apply Theorem 1.1 to sums of independent random vectors to illustrate the order of magnitude of the error bound. Let $W=\frac{1}{\sqrt{n}} \sum_{i=1}^{n} X_{i}$ be a $d$-dimensional random vector, where $\left\{X_{1}, \ldots, X_{n}\right\}$ are independent, $\mathbb{E}\left(X_{i}\right)=0$ for each $i \in[n]:=\{1, \ldots, n\}$ and $\operatorname{Cov}(W)=I_{d}$. A standard construction of exchangeable pairs is as follows. Let $\left\{X_{1}^{*}, \ldots, X_{n}^{*}\right\}$ be an independent copy of $\left\{X_{1}, \ldots, X_{n}\right\}$. Let $I \sim \operatorname{Unif}[n]$ be an uniform random index that is independent of $\left\{X_{1}, \ldots, X_{n}, X_{1}^{*}, \ldots, X_{n}^{*}\right\}$. Let $W^{\prime}=W-\frac{1}{\sqrt{n}}\left(X_{I}-X_{I}^{*}\right)$. It is straightforward to verify that

$$
\mathbb{E}\left(W^{\prime}-W \mid W\right)=-\frac{1}{n} W
$$

and $E$ in (1.2) can be computed as

$$
E=\frac{1}{2}\left(\frac{1}{n} \sum_{i=1}^{n} X_{i} X_{i}^{\top}-\Sigma\right)
$$

Applying Theorem 1.1 with $\Sigma=I_{d}$ and $Z \sim N\left(0, I_{d}\right)$, we obtain

$$
d_{\mathcal{W}}(W, Z) \leqslant \text { constant } \cdot\left\{\left[\frac{1}{n^{2}} \sum_{i=1}^{n} \sum_{j, k=1}^{d} \operatorname{Var}\left(X_{i j} X_{i k}\right)\right]^{1 / 2}+d^{1 / 4}\left[\frac{1}{n^{2}} \sum_{i=1}^{n} \mathbb{E}\left|X_{i}-X_{i}^{*}\right|^{4}\right]^{1 / 2}\right\}
$$

where $\left\{X_{i j}: 1 \leqslant j \leqslant d\right\}$ are the components of $X_{i}$. For the typical case where $\left|X_{i}\right| \sim \sqrt{d}$ and $\left|X_{i j}\right| \sim 1$, the bound reduces to

$$
\sim \sqrt{\frac{d^{5 / 2}}{n}}
$$

This bound has optimal dependence on $n$. The dependence on the dimension $d$ is generally the same as in Bonis (2020, Eq. $(7)$ ), who obtained a Wasserstein- 2 bound in a comparatively complicated way (see also Theorem 2.5 in Anastasiou and Gaunt (2020)). Zhai (2018) obtained a Wasserstein-2 bound $\sim \sqrt{d^{2} / n} \cdot \log n$ when $\left|X_{i}\right|$ s are uniformly bounded by constant $\cdot \sqrt{d}$ and showed that his bound is optimal up to the $\log n$ factor; see also Theorem 1 in Eldan, Mikulincer and Zhai (2018), where the factor $\log n$ is improved to $\sqrt{\log n}$. It is unclear what is the optimal dependence on $d$ under only a moment condition.

As an intermediate step in proving Theorem 1.1, we exploit the symmetry of exchangeable pairs to obtain an error bound for smooth test functions. We introduce a few symbols. For an $r$-times differentiable function $f: \mathbb{R}^{d} \rightarrow \mathbb{R}$, we denote by $\nabla^{r} f(x)$ the $r$-th derivative of $f$ at $x$ regarded as an $r$-linear form on $\mathbb{R}^{d}$ : The value of $\nabla^{r} f(x)$ evaluated at $u_{1}, \ldots, u_{r} \in \mathbb{R}^{d}$ is given by

$$
\left\langle\nabla^{r} f(x), u_{1} \otimes \cdots \otimes u_{r}\right\rangle=\sum_{j_{1}, \ldots, j_{r}=1}^{d} \partial_{j_{1}, \ldots, j_{r}} f(x) u_{1, j_{1}} \cdots u_{r, j_{r}},
$$

where $\partial_{j_{1}, \ldots, j_{r}} f(x)$ is a shorthand notation for $\frac{\partial^{r} f}{\partial{j_{1}}_{\cdots} \cdots x_{j_{r}}}(x)$. When $u_{1}=\cdots=u_{r}=: u$, we write $u_{1} \otimes \cdots \otimes u_{r}=u^{\otimes r}$ for short. We define the injective norm of an $r$-linear form $T$ on $\mathbb{R}^{d}$ by

$$
|T|_{V}:=\sup _{\left|u_{1}\right| \vee \cdots \vee\left|u_{r}\right| \leqslant 1}\left|\left\langle T, u_{1} \otimes \cdots \otimes u_{r}\right\rangle\right| .
$$

Then, for an $(r-1)$-times differentiable function $h: \mathbb{R}^{d} \rightarrow \mathbb{R}$, we set

$$
M_{r}(h):=\sup _{x \neq y} \frac{\left|\nabla^{r-1} h(x)-\nabla^{r-1} h(y)\right|_{v}}{|x-y|} .
$$

Note that $M_{r}(h)=\sup _{x \in \mathbb{R}^{d}}\left|\nabla^{r} h(x)\right|_{V}$ if $h$ is $r$-times differentiable. See Section 5 of Raic̆ (2019) for more details about these symbols.

Remark 1.2. For a function $h: \mathbb{R}^{d} \rightarrow \mathbb{R}$ of the form $h(x)=\cos (\xi \cdot x)$ or $h(x)=\sin (\xi \cdot x)$ for some $\xi \in \mathbb{R}^{d}$, where $\cdot$ denotes the Euclidean inner product, we have $M_{r}(h)=|\xi|^{r}$ for every $r \geqslant 1$. Therefore, given a sequence $W(n)$ of random vectors in $\mathbb{R}^{d}$ and another random vector $Y$ in $\mathbb{R}^{d}$, if we have $|\mathbb{E} h(W(n))-\mathbb{E} h(Y)| \rightarrow 0$ as $n \rightarrow \infty$ for any bounded $C^{\infty}$ function $h: \mathbb{R}^{d} \rightarrow \mathbb{R}$ with $M_{r}(h)<\infty$ for every $r \geqslant 1$, then we obtain the point-wise convergence of the characteristic functions of $W(n)$ to that of $Y: \mid \mathbb{E} \exp (\sqrt{-1} \xi \cdot W(n))-$ $\mathbb{E} \exp (\sqrt{-1} \xi \cdot Y) \mid \rightarrow 0$ as $n \rightarrow \infty$ for all $\xi \in \mathbb{R}^{d}$. In particular, if $d$ is fixed, then $W(n)$ converge in law to $Y$ as $n \rightarrow \infty$.

Theorem 1.2 (Smooth function bound with improved dimension dependence). Under the assumptions of Theorem 1.1, we have, for second-order differentiable functions $h$ such that $M_{1}(h), M_{3}(h)<\infty$,
$|\mathbb{E} h(W)-\mathbb{E} h(Z)| \leqslant M_{1}(h)\left(\mathbb{E}|R|+\left\|\Sigma^{-1 / 2}\right\|_{o p} \sqrt{\frac{2}{\pi}} \mathbb{E}\|E\|_{H . S .}\right)+\frac{\left\|\Sigma^{-1 / 2}\right\|_{o p}}{12 \sqrt{2 \pi}} M_{3}(h) \mathbb{E}\left[\left|\Lambda^{-1} D \| D\right|^{3}\right]$.
Remark 1.3. By a simple modification of the proof of Theorem 1.2, we can obtain an alternative bound

$$
\begin{aligned}
|\mathbb{E} h(W)-\mathbb{E} h(Z)| \leqslant & \sup _{0 \leqslant t \leqslant 1}\left\{\mathbb{E}\left[|\nabla h(\sqrt{t} W+\sqrt{1-t} Z)|^{2}\right]\right\}^{1 / 2}\left(\sqrt{\mathbb{E}|R|^{2}}+\left\|\Sigma^{-1 / 2}\right\|_{o p} \sqrt{\mathbb{E}\|E\|_{H . S .}^{2}}\right) \\
& +\frac{\left\|\Sigma^{-1 / 2}\right\|_{o p}}{12 \sqrt{2 \pi}} M_{3}(h) \mathbb{E}\left[\left|\Lambda^{-1} D \| D\right|^{3}\right]
\end{aligned}
$$

which is useful in the case where $|\nabla h(x)|$ is not uniformly bounded.

Remark 1.4. Comparing with smooth function bounds in the literature, e.g., Chatterjee and Meckes (2008, Theorem 2.3) and Reinert and Röllin (2009, Theorem 2.1), the bound in Theorem 1.2 has improved dependence on dimension. This can be easily checked by examining the case of sums of independent random vectors above. In fact, it is crucial to use the bound in Theorem 1.2 to obtain the optimal convergence rate for the application to Wishart matrices in Section 2.1.

Remark 1.5 (Singular covariance matrix). When $\Sigma$ is not invertible, we get the following alternative bound for any thrice differentiable function $h: \mathbb{R}^{d} \rightarrow \mathbb{R}$ with $\mathbb{E}|h(W)|+$ $\mathbb{E}|h(Z)|<\infty$ :

$$
\begin{equation*}
|\mathbb{E} h(W)-\mathbb{E} h(Z)| \leqslant M_{1}(h) \mathbb{E}|R|+\frac{\sqrt{d}}{2} M_{2}(h) \mathbb{E}\|E\|_{H . S .}+\frac{M_{4}(h)}{64} \mathbb{E}\left[\left|\Lambda^{-1} D \| D\right|^{3}\right] \tag{1.3}
\end{equation*}
$$

This should be compared to the following bound from Döbler and Peccati (2017, Theorem 3.1) (see also Meckes (2009, Theorem 3)): For any twice differentiable function $h: \mathbb{R}^{d} \rightarrow \mathbb{R}$ with $\mathbb{E}|h(W)|+\mathbb{E}|h(Z)|<\infty$,

$$
\begin{equation*}
|\mathbb{E} h(W)-\mathbb{E} h(Z)| \leqslant M_{1}(h) \mathbb{E}|R|+\frac{\sqrt{d}}{2} M_{2}(h) \mathbb{E}\|E\|_{H . S .}+\frac{M_{3}(h)}{18} \mathbb{E}\left[\left|\Lambda^{-1} D \| D\right|^{2}\right] \tag{1.4}
\end{equation*}
$$

While our bound requires $h$ to be more smooth, the quantity $\mathbb{E}\left[\left|\Lambda^{-1} D \| D\right|^{3}\right]$ is typically of a smaller order than $\mathbb{E}\left[\left|\Lambda^{-1} D \| D\right|^{2}\right]$. To see the effect of this difference, let us consider the typical case of sums of independent random vectors as above. Then, (1.3) and (1.4) respectively reduce to

$$
|\mathbb{E} h(W)-\mathbb{E} h(Z)| \leqslant C_{1}\left(M_{2}(h) \sqrt{\frac{d^{3}}{n}}+M_{4}(h) \frac{d^{2}}{n}\right)
$$

and

$$
|\mathbb{E} h(W)-\mathbb{E} h(Z)| \leqslant C_{2}\left\{M_{2}(h)+M_{3}(h)\right\} \sqrt{\frac{d^{3}}{n}}
$$

where $C_{1}, C_{2}$ are constants depending only on $\max _{i, j} \mathbb{E}\left|X_{i j}\right|^{4}$. Following the proof of Theorem 1.1 but ignoring the integration by parts step therein, we can derive the corresponding Wasserstein bounds from these results via a smoothing argument. Then, the former yields a bound $\sim\left(d^{4} / n\right)^{1 / 4}$, while the latter implies a bound $\sim\left(d^{4} / n\right)^{1 / 4} \vee\left(d^{5} / n\right)^{1 / 6}$, so our bound always provides a better rate.

Our next result is a continuous version of the Wasserstein bound in multivariate normal approximations. The setting was introduced by Döbler, Vidotto and Zheng (2018) and proved to be useful in the study of Gaussian, Poisson and Rademacher functionals. In the special case that $\rho_{j}(W)=0$ in (1.7), the result reduces to those in Chatterjee and Meckes (2008) and Nourdin and Zheng (2019). An application of Theorem 1.3 to Poisson functionals is given in Section 2.3.

Theorem 1.3 (Continuous version of the Wasserstein bound). For every $t>0$, let $\left(W, W_{t}\right)$ be an exchangeable pair of d-dimensional random vectors such that $\mathbb{E}|W|^{4}<\infty$ and

$$
\begin{equation*}
\lim _{t \downarrow 0} \frac{1}{t} \mathbb{E}\left[W_{t}-W \mid \mathcal{G}\right]=-\Lambda(W+R) \quad \text { in } L^{1}(\mathbb{P}) \tag{1.5}
\end{equation*}
$$

for some invertible $d \times d$ (non-random) matrix $\Lambda$, $d$-dimensional random vector $R$, and $\sigma$-algebra $\mathcal{G}$ containing $\sigma(W)$. Suppose also that there is a $d \times d$ positive definite symmetric matrix $\Sigma$ and ad $\times d$ random matrix $S$ satisfying

$$
\begin{equation*}
\lim _{t \downarrow 0} \frac{1}{t} \mathbb{E}\left[\left(W_{t}-W\right)\left(W_{t}-W\right)^{\top} \mid \mathcal{G}\right]=2 \Lambda \Sigma+S \quad \text { in } L^{1}\left(\Omega,\|\cdot\|_{H . S .}\right) \tag{1.6}
\end{equation*}
$$

Moreover, suppose that, for every $j \in\{1, \ldots, d\}$, there is a constant $\rho_{j}(W)$ satisfying

$$
\begin{equation*}
\limsup _{t \downarrow 0} \frac{1}{t} \mathbb{E}\left(\left(W_{t}\right)_{j}-W_{j}\right)^{4} \leqslant \rho_{j}(W) \tag{1.7}
\end{equation*}
$$

Then we have

$$
\begin{aligned}
d_{\mathcal{W}}(W, Z) \leqslant \mathbb{E}|R|+ & \frac{\left\|\Sigma^{-1 / 2}\right\|_{o p}}{\sqrt{2 \pi}} \mathbb{E}\left\|\Lambda^{-1} S\right\|_{H . S .} \\
& +\left\|\Sigma^{-1 / 2}\right\|_{o p}^{3 / 2}\left(\frac{\pi}{8}\right)^{1 / 4}\left(\mathbb{E}|W|^{2} \vee \operatorname{tr}(\Sigma)\right)^{1 / 4} \sqrt{d} \sqrt{\left\|\Lambda^{-1}\right\|_{o p} \sum_{j=1}^{d} \rho_{i}(W)}
\end{aligned}
$$

where $Z \sim N(0, \Sigma)$.

## 2 APPLICATIONS

In this section, we present three applications of our main results. Their proofs are deferred to Section 3.2. We begin with multivariate normal approximations to Wishart matrices.

### 2.1 Wishart matrices

Let $X=\left\{X_{i k}: 1 \leqslant i \leqslant n, 1 \leqslant k \leqslant d\right\}$ be a matrix with i.i.d. entries such that $\mathbb{E} X_{11}=$ $0, \mathbb{E} X_{11}^{2}=1$ and $\mathbb{E} X_{11}^{4}<\infty$. For $1 \leqslant i<j \leqslant n$, let

$$
W_{i j}=\frac{1}{\sqrt{d}} \sum_{k=1}^{d} X_{i k} X_{j k}
$$

be the upper diagonal entries of the Wishart matrix $\frac{1}{\sqrt{d}} X X^{\top}$. We are interested in approximating $W=\left\{W_{i j}: 1 \leqslant i<j \leqslant n\right\}$, regarded as an $\binom{n}{2}$-vector, by a standard Gaussian vector $Z$ when both $n$ and $d$ grow to infinity.

In the case where $X_{11}$ follows the standard Gaussian distribution, Jiang and Li (2015) and Bubeck et al. (2016) proved that the total variation distance between $W$ and $Z$ tends to zero if $d \gg n^{3}$ and tends to one if $d \ll n^{3}$ (see also Rácz and Richev (2019)). Bubeck and Ganguly (2018) generalized the result to the case where $X_{11}$ follows a log-concave
distribution. Nourdin and Zheng (2018) considered row-wise i.i.d. Gaussian matrices $X$ where each row is a Gaussian vector with a general covariance matrix and Mikulincer (2020) considered column-wise i.i.d. matrices $X$ where each column follows a log-concave measure on $\mathbb{R}^{n}$. Nourdin and Zheng (2018) and Mikulincer (2020) proved convergence of $W$ to $Z$ in the Wasserstein- 1 and Wasserstein-2 distances respectively in the asymptotic region $d \gg n^{3}$. They also considered Gaussian approximations for Wishart tensors.

In Bubeck and Ganguly (2018) and Mikulincer (2020), it was pointed out that a standard application of Stein's method, e.g. by Chatterjee and Meckes (2008), only provides an error bound in the Gaussian approximation for $W$ for smooth test functions that vanishes when $d \gg n^{6}$ (in fact, $d \gg n^{4}$ using the exchangeable pair in the proof of Theorem 2.1 below). We use Theorem 1.2 to obtain the optimal convergence rate $\sqrt{n^{3} / d}$ for the i.i.d. case for smooth test functions. Except for the existence of the fourth moment of $X_{11}$, we do not impose any other distributional assumptions. We also note that the proof works for the non-identically distributed case (cf. (3.16) and (3.17)) and for Wishart tensors (cf. Remark (2.1). In the Appendix, we use a modified version of Theorem 1.1 to obtain the optimal convergence rate $\sqrt{n^{3} / d}$ for the Wasserstein distance assuming in addition $X_{11}$ has finite sixth moment.

Theorem 2.1. Let $X=\left\{X_{i k}: 1 \leqslant i \leqslant n, 1 \leqslant k \leqslant d\right\}$ be a matrix with i.i.d. entries such that $\mathbb{E} X_{11}=0, \mathbb{E} X_{11}^{2}=1$, and $\mathbb{E} X_{11}^{4}<\infty$. Regard $W=\left\{W_{i j}: 1 \leqslant i<j \leqslant n\right\}$ as an $\binom{n}{2}$-vector where

$$
W_{i j}=\frac{1}{\sqrt{d}} \sum_{k=1}^{d} X_{i k} X_{j k} .
$$

Let $Z$ be a standard $\binom{n}{2}$-dimensional Gaussian vector. Then we have, for second-order differentiable functions $h$ such that $M_{1}(h), M_{3}(h)<\infty$,

$$
\begin{align*}
|\mathbb{E} h(W)-\mathbb{E} h(Z)| \leqslant & M_{1}(h) \sqrt{\frac{n^{2}}{2 \pi d}\left[\mathbb{E} X_{11}^{4}+\left(\mathbb{E} X_{11}^{4}\right)^{2}\right]+\frac{n^{3}}{8 \pi d}\left[3+\mathbb{E} X_{11}^{4}\right]} \\
& +M_{3}(h) \frac{n^{3}}{12 d \sqrt{2 \pi}}\left(E X_{11}^{4}+3\right)\left(\frac{E X_{11}^{4}}{n}+1\right) . \tag{2.1}
\end{align*}
$$

Remark 2.1. Let $p \geqslant 2$ be an integer. Under the same assumptions as in Theorem 2.1, let

$$
W_{i_{1} \ldots i_{p}}=\frac{1}{\sqrt{d}} \sum_{k=1}^{d} X_{i_{1} k} \ldots X_{i_{p} k}
$$

be entries of the Wishart tensor. Regard $W=\left\{W_{i_{1} \ldots i_{p}}: 1 \leqslant i_{1}<\cdots<i_{p} \leqslant n\right\}$ as an $\binom{n}{p}$-vector. Let $Z$ be a standard $\binom{n}{p}$-dimensional Gaussian vector. Following the proof of Theorem 2.1, we can easily obtain (details omitted)

$$
|\mathbb{E} h(W)-\mathbb{E} h(Z)| \leqslant C_{p}\left\{M_{1}(h) \sqrt{\frac{n^{2 p-1}}{d}}+M_{3}(h) \frac{n^{2 p-1}}{d}\right\},
$$

where $C_{p}$ is a constant only depending on $p$ and $\mathbb{E} X_{11}^{4}$. This recovers the range $d \gg n^{2 p-1}$ for asymptotic normality in Nourdin and Zheng (2018) and Mikulincer (2020) under only moment assumptions.

Optimality of the convergence rate. By using the alternative bound in Re$\operatorname{mark}$ 1.3, we can replace $\sqrt{\frac{2}{\pi}} M_{1}(h)$ in (2.1) by $\sup _{0 \leqslant t \leqslant 1}\left\{\mathbb{E}\left[|\nabla h(\sqrt{t} W+\sqrt{1-t} Z)|^{2}\right]\right\}^{1 / 2}$. The resulting bound can be shown to be optimal by considering $h(x)=n^{-3 / 2} \sum_{1 \leqslant i<j<k \leqslant n} x_{i j} x_{j k} x_{i k}$. In this case, we have $\mathbb{E}\left[|\nabla h(\sqrt{t} W+\sqrt{1-t} Z)|^{2}\right] \leqslant C \sqrt{\mathbb{E} X_{11}^{4}+n / d}$ and $M_{3}(h) \leqslant C$ for some universal constant $C$, while $\mathbb{E} h(W)=\frac{1}{\sqrt{n^{3} d}}\binom{n}{3} \sim \sqrt{n^{3} / d}$ and $\mathbb{E} h(Z)=0$.
Remark 2.2. We can naturally regard $\binom{n}{2}$-random vectors $W$ and $Z$ as random elements of the infinite-dimensional Hilbert space $\ell^{2}(\mathbb{N})$. Then, we may discuss the closeness between their respective laws $P_{n, d}$ and $Q_{n}$ induced on the space $\ell^{2}(\mathbb{N})$. However, we need some care because the sequence $\left\{Q_{n}\right\}_{n=1}^{\infty}$ is not tight in this case. In such a situation, Davydov and Rotar (2009) argue that it is reasonable to define the concept of weak convergence in the following way: We say $P_{n, d}-Q_{n} \rightarrow 0$ weakly as $n, d \rightarrow \infty$ if $\int f d\left(P_{n, d}-Q_{n}\right) \rightarrow 0$ for all bounded and uniformly continuous functions $f: \ell^{2}(\mathbb{N}) \rightarrow \mathbb{R}$. Using Theorem 3 in Davydov and Rotar (2009), we can easily verify that $P_{n, d}-Q_{n} \rightarrow 0$ weakly as $n, d \rightarrow \infty$ when $d_{\mathcal{W}}(W, Z) \rightarrow 0$. Applying Theorem 1.1 instead of Theorem 1.2 in the proof of Theorem 2.1, we obtain $d_{\mathcal{W}}(W, Z)=O\left(\sqrt{n^{4} / d}\right)$; hence, $P_{n, d}-Q_{n} \rightarrow 0$ weakly as $n, d \rightarrow \infty$ if $n^{4} / d \rightarrow 0$. In the Appendix, we prove $d_{\mathcal{W}}(W, Z)=O\left(\sqrt{n^{3} / d} \vee\left(n^{3} / d\right)^{2 / 3}\right)$ as long as $\mathbb{E} X_{11}^{6}<\infty$, so we recover the optimal condition $n^{3} / d \rightarrow 0$ for the weak convergence in the above sense under the finiteness of the sixth moment.

### 2.2 Degenerate $\boldsymbol{U}$-statistics

For a positive integer $n$, we write $[n]:=\{1, \ldots, n\}$. For each $i \in[n]$, let $X_{i}$ be a random variable taking values in a measurable space $\left(E_{i}, \mathcal{E}_{i}\right)$. Assume $X_{1}, \ldots, X_{n}$ are independent. We set $\mathcal{F}_{J}:=\sigma\left(X_{j}, j \in J\right)$ for every $J \subset[n]$. Also, we denote by $|J|$ the number of elements in $J$.

Let $U \in L^{1}(\mathbb{P})$ be $\mathcal{F}_{[n]}$-measurable. It is known that $U$ admits the Hoeffding decomposition of the form

$$
\begin{equation*}
U=\sum_{J \subset[n]} U^{J} \tag{2.2}
\end{equation*}
$$

where $U^{J} \in L^{1}(\mathbb{P})$ is $\mathcal{F}_{J}$-measurable and satisfies

$$
\begin{equation*}
\mathbb{E}\left[U^{J} \mid \mathcal{F}_{K}\right]=0 \tag{2.3}
\end{equation*}
$$

whenever $J \not \subset K \subset[n]$. Such a decomposition is almost surely unique and given by

$$
U^{J}=\sum_{L \subset J}(-1)^{|J|-|L|} \mathbb{E}\left[U \mid \mathcal{F}_{L}\right], \quad J \subset[n]
$$

See Section 1.2 of Döbler and Peccati (2017) and references therein for more details. Let $p \in[n]$. We say that $U$ is a degenerate $U$-statistic of order $p$ if $U^{J}=0$ whenever $J \subset[n]$ is such that $|J| \neq p$. In the celebrated work de Jong (1990), de Jong showed that a sequence $U(n) \in L^{4}(\mathbb{P})$ of degenerate $U$-statistics of fixed order $p$ with mean 0 and variance 1 converges in law to the standard normal distribution if

$$
\mathbb{E} U(n)^{4} \rightarrow 3 \quad \text { and } \quad \varrho(U(n)):=\max _{1 \leqslant i \leqslant n} \sum_{J \subset[n]: i \in J} \operatorname{Var}\left[U(n)^{J}\right] \rightarrow 0
$$

Recently, Döbler and Peccati (2017) have established a quantitative version of the above result in the Wasserstein distance via exchangeable pairs. They have also obtained a multi-dimensional extension of de Jong's CLT together with error bounds for smooth test functions. Here, we complement their results by deriving a multi-dimensional Wasserstein bound of de Jong type using Theorem 1.1.

Let $W$ be an $\mathcal{F}_{[n]}$-measurable random vector in $\mathbb{R}^{d}$. We assume that, for each $j \in[n]$, $W_{j}$ is a degenerate $U$-statistic of order $p_{j}$. Without loss of generality, we may assume $p_{1} \leqslant \cdots \leqslant p_{d}$. For every $j \in[d]$, we assume $W_{j} \in L^{4}(\mathbb{P})$ with mean 0 and variance 1 . In addition, we set

$$
\varrho_{n, j}^{2}:=\varrho\left(W_{j}\right)=\max _{1 \leqslant i \leqslant n} \sum_{J \subset[n]: i \in J} \operatorname{Var}\left(W_{j}^{J}\right) .
$$

Theorem 2.2. Under the setting described above, assume $\Sigma:=\operatorname{Cov}(W)$ is invertible. Let $Z \sim N(0, \Sigma)$. Then we have

$$
\begin{align*}
d_{\mathcal{W}}(W, Z) \leqslant & \left\|\Sigma^{-1 / 2}\right\|_{o p} \sqrt{\frac{2 p_{d}^{2}}{\pi p_{1}^{2}}\left(\mathbb{E}|W|^{4}-\mathbb{E}|Z|^{4}\right)+C_{\boldsymbol{p}} d \sum_{j=1}^{d} \varrho_{n, j}^{2}} \\
& +\left\|\Sigma^{-1 / 2}\right\|_{o p}^{3 / 2}\left(\frac{\pi}{8}\right)^{1 / 4} d^{3 / 4}\left(\frac{p_{d}}{p_{1}}\right)^{3 / 8} \sqrt{\sum_{j=1}^{d}\left(8\left(\mathbb{E}\left[W_{j}^{4}\right]-3\right)+K_{j} \varrho_{n, j}^{2}\right)} \tag{2.4}
\end{align*}
$$

where $C_{\boldsymbol{p}}>0$ is a constant depending only on $p_{1}, \ldots, p_{d}$ and $K_{j}>0$ is a constant depending only on $p_{j}$.

When $d=1$, Theorem 2.2 recovers Theorem 1.3 in Döbler and Peccati (2017) with a possibly different constant. Also, note that

$$
\left.|\mathbb{E}| W\right|^{4}-\mathbb{E}|Z|^{4}\left|\leqslant \sum_{j=1}^{d}\right| \mathbb{E} W_{j}^{4}-3\left|+\sum_{j \neq k}\right| \mathbb{E} W_{j}^{2} W_{k}^{2}-\mathbb{E} Z_{j}^{2} Z_{k}^{2} \mid
$$

Therefore, Theorem $\sqrt{2.2}$ mav be seen as a quantitative version of Theorem 1.7 in Döbler and Peccati (2017) in terms of Wasserstein bound in the case of invertible $\Sigma$.

Homogeneous sums. A prominent example of degenerate $U$-statistics is a multilinear homogeneous sum. Suppose that $X_{1}, \ldots, X_{n}$ are real-valued random variables with mean 0 and variance 1 . For every $j \in[d]$, we assume $W_{j}$ is of the form

$$
W_{j}=\sum_{i_{1}, \ldots, i_{p_{j}}=1}^{n} f_{j}\left(i_{1}, \ldots, i_{p_{j}}\right) X_{i_{1}} \cdots X_{i_{p_{j}}}
$$

where $f_{j}:[n]^{p_{j}} \rightarrow \mathbb{R}$ is a symmetric function vanishing on diagonals (i.e. $f_{j}\left(i_{1}, \ldots, i_{p_{j}}\right)=$ 0 unless $i_{1}, \ldots, i_{p_{j}}$ are mutually different). Without loss of generality, we may assume $p_{1} \leqslant \cdots \leqslant p_{d}$. Assume also that $W_{j}$ is normalized so that

$$
\operatorname{Var}\left(W_{j}\right)=p_{j}!\sum_{i_{1}, \ldots, i_{p_{j}}=1}^{n} f_{j}\left(i_{1}, \ldots, i_{p_{j}}\right)^{2}=1
$$

For each $i \in[n]$, we define the $i$-th influence function of $f_{j}$ by

$$
\operatorname{Inf}_{i}\left(f_{j}\right):=\sum_{i_{2}, \ldots, i_{p_{j}}=1}^{n} f_{j}\left(i, i_{2}, \ldots, i_{p_{j}}\right)^{2} .
$$

We set $\mathcal{M}\left(f_{j}\right):=\max _{1 \leqslant i \leqslant n} \operatorname{Inf}_{i}\left(f_{j}\right)$.
Corollary 2.1. Under the setting described above, assume $\Sigma:=\operatorname{Cov}(W)$ is invertible. Let $Z \sim N(0, \Sigma)$. Then we have

$$
\begin{align*}
d_{\mathcal{W}}(W, Z) & \leqslant\left\|\Sigma^{-1 / 2}\right\|_{o p} \sqrt{\frac{2 p_{d}^{2}}{\pi p_{1}^{2}} \sum_{\substack{j, k=1 \\
j \leqslant k}}^{d} \Delta_{j, k}+C_{\boldsymbol{p}}^{\prime} d \sum_{j=1}^{d} M^{p_{j}} \mathcal{M}\left(f_{j}\right)} \\
& +\left\|\Sigma^{-1 / 2}\right\|_{o p}^{3 / 2}\left(\frac{\pi}{8}\right)^{1 / 4} d^{3 / 4}\left(\frac{p_{d}}{p_{1}}\right)^{3 / 8} \sqrt{\sum_{j=1}^{d}\left(8\left(\mathbb{E}\left[W_{j}^{4}\right]-3\right)+K_{j}^{\prime} \mathcal{M}\left(f_{j}\right)\right)}, \tag{2.5}
\end{align*}
$$

where $M:=\max _{1 \leqslant i \leqslant n}\left(\mathbb{E} X_{i}^{4}\right), C_{p}^{\prime}>0$ is a constant depending only on $p_{1}, \ldots, p_{d}, K_{j}^{\prime}>0$ is a constant depending only on $p_{j}$, and

$$
\begin{aligned}
& \Delta_{j, k}:=1_{\left\{p_{j}<p_{k}\right\}} C_{j} M^{p_{j} / 2} \sqrt{\left(\mathbb{E} W_{k}^{4}-3\right)+C_{k} M^{p_{k}} \mathcal{M}\left(f_{k}\right)} \\
& \quad+1_{\left\{p_{j}=p_{k}\right\}}\left(2\left(\mathbb{E} W_{j}^{4}-3\right)+C_{j} M^{p_{j}} \mathcal{M}\left(f_{j}\right)\right)
\end{aligned}
$$

with $C_{j}>0$ a constant depending only on $p_{j}$ for each $j \in[d]$.
Remark 2.3. It is worth mentioning that, unlike the bound (2.4) for general degenerate $U$-statistics, the bound (2.5) does not contain any joint moments like $\mathbb{E} W_{j}^{2} W_{k}^{2}$ with $j \neq k$. In particular, $W$ converges in law to $N(0, \Sigma)$ if

$$
\begin{equation*}
\max _{1 \leqslant j \leqslant d}\left|\mathbb{E} W_{j}^{4}-3\right| \rightarrow 0 \quad \text { and } \quad \max _{1 \leqslant j \leqslant d} \mathcal{M}\left(f_{j}\right) \rightarrow 0, \tag{2.6}
\end{equation*}
$$

provided $\operatorname{Cov}(W) \rightarrow \Sigma$ and $M=O(1)$. This fact is not new and follows from Lemma 4.3 and Theorem 7.2 in Nourdin, Peccati and Reinert (2010) for example. It is interesting to observe that (2.6) seemingly concerns only the coordinate-wise information of $W$. This type of phenomenon was first discovered in Peccati and Tudor (2005) when $X_{i}$ are Gaussian, where even the second convergence in (2.6) is dropped. In fact, it is known that the second convergence is implied by the first one in (2.6) for several classes of distributions of $X_{i}$. Nourdin, Peccati, Poly and Simone (2016) use this fact to prove the joint asymptotic normality of $W$ is implied by the marginal asymptotic normality; see Theorem 4.1 ibidem.

Optimality of the bound. The dependence of the bound (2.5) on the quantities in (2.6) is generally optimal. To see this, let us assume that $d=1, p_{1}=2$ and $X_{i}$ are
standard Gaussian. Also, assume that $n / 3$ is integer and the matrix $A:=\left(f_{1}(i, j)\right)_{1 \leqslant i, j \leqslant d}$ is given by

$$
A=\operatorname{diag}(\underbrace{B, \ldots, B}_{n / 3}), \quad \text { where } B:=\frac{1}{2 \sqrt{n}}\left(\begin{array}{lll}
0 & 1 & 1 \\
1 & 0 & 1 \\
1 & 1 & 0
\end{array}\right) .
$$

In this case, we have

$$
\mathbb{E} W^{2}=\frac{2 n}{3} \operatorname{tr}\left(B^{2}\right)=1, \quad \mathbb{E} W^{3}=\frac{8 n}{3} \operatorname{tr}\left(B^{3}\right)=\frac{2}{\sqrt{n}}
$$

and

$$
\mathbb{E} W^{4}-3=\frac{48 n}{3} \operatorname{tr}\left(B^{4}\right)=\frac{12}{n} .
$$

Moreover, since $W$ belongs to the second Wiener chaos of an isonormal Gaussian process over $\mathbb{R}^{n}$, we infer from the proof of Nourdin and Peccati (2015, Theorem 1.2)

$$
|\mathbb{E} \sin (W)-\mathbb{E} \sin (Z)| \geqslant \frac{1}{2 \sqrt{e}} \frac{2}{\sqrt{n}}-C_{1}\left(\frac{12}{n}\right)^{1 / 4} \max \left\{\frac{2}{\sqrt{n}}, \frac{12}{n}\right\},
$$

where $C_{1}>0$ is a universal constant. Therefore, there is a constant $c>0$ such that $d_{\mathcal{W}}(W, Z) \geqslant c / \sqrt{n}$ for sufficiently large $n$. Since $\mathcal{M}\left(f_{1}\right)=1 /(2 n)$, the bound (2.5) is sharp in terms of $\mathbb{E} W^{4}-3$ and $\mathcal{M}\left(f_{1}\right)$.

Remark 2.4. When $p_{j}<p_{k}$ for some $j, k \in[d]$, the bound (2.5) depends on the fourth roots of the quantities in (2.6) rather than their square roots. This is a typical phenomenon in the literature of fourth moment theorems: see Remark 1.9(a) in Döbler, Vidotto and Zheng (2018) for instance.

Remark 2.5. Nourdin, Peccati and Reinert (2010) have obtained error bounds for multivariate normal approximation of $W$ in their Theorem 7.2 in terms of smooth function distances $|\mathbb{E} h(W)-\mathbb{E} h(Z)|$ with bounded $\left\|h^{\prime \prime}\right\|_{\infty}:=\max _{1 \leqslant i, j \leqslant d} \sup _{x \in \mathbb{R}^{d}}\left|\partial_{i j} h(x)\right|$ and $\left\|h^{\prime \prime \prime}\right\|_{\infty}:=\max _{1 \leqslant i, j, k \leqslant d} \sup _{x \in \mathbb{R}^{d}}\left|\partial_{i j k} h(x)\right|$. In view of Lemma 2.1 and Remark 2.3 in Koike (2019), their bound has the same dependence on the quantities in (2.6) as in (2.5). However, while it is possible to obtain a Wasserstein bound from their bound by a smoothing argument, this generally leads to suboptimal dependence on the quantities in (2.6) (see e.g. the proof of Nourdin. Peccati and Reinert (2010, Proposition 5.4)). Thanks to Theorem 1.1, we are able to strengthen the bound in the Wasserstein distance.

### 2.3 Poisson functionals

In this subsection we apply Theorem 1.3 to derive a Wasserstein bound for the fourth moment theorem on the Poisson space in the multi-dimensional setting, which strengthens an earlier result obtained by Döbler. Vidotto and Zheng (2018) in the Wasserstein distance. We refer to Section 1.3 of Döbler, Vidotto and Zheng (2018) and references therein for unexplained concepts appearing below.

Theorem 2.3. Let $(\mathcal{Z}, \mathscr{Z}, \mu)$ be a $\sigma$-finite measure spac $\downarrow^{1}$ and let $\eta$ be a Poisson random measure on $(\mathcal{Z}, \mathscr{Z})$ with control $\mu$. Also, let $1 \leqslant q_{1} \leqslant \cdots \leqslant q_{d}$ be integers and $W$ be a $d$-dimensional random vector such that $\mathbb{E} W_{j}^{4}<\infty$ and $W_{j}$ belongs to the $q_{j}$-th Poisson Wiener chaos associated with $\eta$ for all $j=1, \ldots, d$. Assume $\Sigma:=\operatorname{Cov}(W)$ is invertible. Then we have

$$
\begin{align*}
d_{\mathcal{W}}(W, Z) \leqslant\left\|\Sigma^{-1 / 2}\right\|_{o p} & \frac{q_{d}}{q_{1}} \sqrt{\mathbb{E}\left[|W|^{4}-|Z|^{4}\right]} \\
& +\left\|\Sigma^{-1 / 2}\right\|_{o p}^{3 / 2} \sqrt{\frac{8 q_{d}}{q_{1}}} \operatorname{tr}(\Sigma)^{1 / 4} \sqrt{d} \sqrt{\sum_{j=1}^{d}\left(\mathbb{E} W_{j}^{4}-3\left(\mathbb{E} W_{j}^{2}\right)^{2}\right)}, \tag{2.7}
\end{align*}
$$

where $Z \sim N(0, \Sigma)$. Moreover, if $q_{1}=\cdots=q_{d}$, we have

$$
\begin{equation*}
d_{\mathcal{W}}(W, Z) \leqslant 2 \sqrt{2}\left(\left\|\Sigma^{-1 / 2}\right\|_{o p}+\left\|\Sigma^{-1 / 2}\right\|_{o p}^{3 / 2} \operatorname{tr}(\Sigma)^{1 / 4}\right) \sqrt{d} \sqrt{\sum_{j=1}^{d}\left(\mathbb{E} W_{j}^{4}-3\left(\mathbb{E} W_{j}^{2}\right)^{2}\right)} . \tag{2.8}
\end{equation*}
$$

Remark 2.6. In the same setting as in Theorem [2.3, Döbler. Vidotto and Zheng (2018) have essentially obtained the following bound: For any $C^{2}$ function $g: \mathbb{R}^{d} \rightarrow \mathbb{R}$,

$$
\begin{aligned}
|\mathbb{E}[g(W)]-\mathbb{E}[g(Z)]| \leqslant & \frac{\left(2 q_{d}-1\right) M_{1}(g)\left\|\Sigma^{-1 / 2}\right\|_{o p}}{\sqrt{2 \pi} q_{1}} \sqrt{\mathbb{E}\left[|W|^{4}-\mathbb{E}|Z|^{4}\right]} \\
& +\frac{\sqrt{2 \pi} q_{d} M_{2}(g)\left\|\Sigma^{-1 / 2}\right\|_{o p}}{6 q_{1}} \sqrt{d \operatorname{tr}(\Sigma)} \sqrt{\sum_{j=1}^{d}\left(\mathbb{E} W_{j}^{4}-3\left(\mathbb{E} W_{j}^{2}\right)^{2}\right)} .
\end{aligned}
$$

We note that there should be an additional factor of $\sqrt{d}$ in their Eq.(3.4). 2 Compared to this estimate, the second term of our bound (2.7) improves the dimension dependence from $d$ to $d^{3 / 4}$ when $\Sigma=I_{d}$. In addition, our bound does not require the test function $g$ to satisfy $M_{2}(g)<\infty$.

Remark 2.7. Using the exchangeable pairs coupling constructed in Zheng (2019), it will also be possible to derive a multi-dimensional "fourth-moment-influence" type Wasserstein bound in the Rademacher setting via Theorem 1.3. We omit the details.

As a simple illustration, we consider normal approximation of multivariate compound Poisson distributions. Let $X_{1}, X_{2}, \ldots$ be i.i.d. isotropic random vectors in $\mathbb{R}^{d}$ with finite fourth moments and $N=\left\{N_{t}\right\}_{t \geqslant 0}$ be a Poisson process with intensity $\lambda>0$ and independent of $\left\{X_{i}\right\}_{i=1}^{\infty}$. We take $W:=\lambda^{-1 / 2} \sum_{i=1}^{N_{1}} X_{i}$, which may be seen as an analog of (scaled) sums of i.i.d. random vectors. Since the coordinates of $W$ belong to the first

[^0]Poisson Wiener chaos associated with the jump measure of $N$, we can apply Theorem [2.3 and obtain

$$
d_{\mathcal{W}}(W, Z) \leqslant \frac{3 \sqrt{2} d^{3 / 4}}{\sqrt{\lambda}} \sqrt{\sum_{j=1}^{d} \mathbb{E} X_{1 j}^{4}} \leqslant 3 \sqrt{2} \sqrt{\max _{1 \leqslant j \leqslant d} \mathbb{E} X_{1 j}^{4}} \sqrt{\frac{d^{5 / 2}}{\lambda}},
$$

where $X_{1 j}$ denotes the $j$-th component of $X_{1}$. We observe that the bound depends on the dimension $d$ and "sample size" $\lambda$ in an analogous way to the case of sums of i.i.d. random vectors (cf. Section (1).

## 3 PROOFS

### 3.1 Proofs of main results

In this subsection, we prove our main results stated in Section 1. To prove Theorems 1.1 and [1.2, we need the following lemma, which contains our key idea of exploiting the symmetry of exchangeable pairs (cf. (3.4)).

Lemma 3.1. Under the assumptions of Theorem 1.1, we have

|\mathbb{E}[\mathscr{S} f(W)]| \leqslant M_{1}(f) \mathbb{E}|R|+\sup _{w}\|\operatorname{Hess} f(w)\|_{H . S .} \mathbb{E}\|E\|_{H . S .}+\frac{M_{4}(f)}{16} \mathbb{E}\left[\left|\Lambda^{-1} D \| D\right|^{3}\right] \tag{3.1}
\end{equation*}
$$

for any third-order differentiable function $f: \mathbb{R}^{p} \rightarrow \mathbb{R}$ with $M_{1}(f), \sup _{w}\|\operatorname{Hess} f(w)\|_{H . S}, M_{4}(f)<$ $\infty$, where

$$
\mathscr{S} f(w):=\langle\Sigma, \operatorname{Hess} f(w)\rangle_{H . S .}-w \cdot \nabla f(w), \quad w \in \mathbb{R}^{d} .
$$

Proof of Lemma 3.1, By exchangeability, Taylor's expansion and assumptions (1.1) and (1.2), we have

$$
\begin{align*}
0 & =\frac{1}{2} \mathbb{E}\left[\Lambda^{-1} D \cdot\left(\nabla f\left(W^{\prime}\right)+\nabla f(W)\right)\right] \\
& =\mathbb{E}\left[\frac{1}{2} \Lambda^{-1} D \cdot\left(\nabla f\left(W^{\prime}\right)-\nabla f(W)\right)+\Lambda^{-1} D \cdot \nabla f(W)\right] \\
& =\mathbb{E}\left[\frac{1}{2} \sum_{j, k=1}^{d}\left(\Lambda^{-1} D\right)_{j} D_{k} \partial_{j k} f(W)+\Xi+\Lambda^{-1} D \cdot \nabla f(W)\right]  \tag{3.2}\\
& =\mathbb{E}\left[\langle\Sigma, \operatorname{Hess} f(w)\rangle_{H . S .}+\langle E, \operatorname{Hess} f(W)\rangle_{H . S .}+\Xi-(W+R) \cdot \nabla f(W)\right],
\end{align*}
$$

where

$$
\Xi=\frac{1}{2} \sum_{j, k, l=1}^{d}\left(\Lambda^{-1} D\right)_{j} D_{k} D_{l} U \partial_{j k l} f(W+(1-U) D)
$$

and $U$ is a uniform random variable on $[0,1]$ independent of everything else. Hence

$$
\begin{equation*}
\mid \mathbb{E}[\mathscr{S} f(W)\rangle]\left|\leqslant M_{1}(f) \mathbb{E}\right| R\left|+\sup _{w}\|\operatorname{Hess} f(w)\|_{H . S .} \mathbb{E}\|E\|_{H . S .}+|\mathbb{E}[\Xi]| .\right. \tag{3.3}
\end{equation*}
$$

To estimate $|\mathbb{E}[\Xi]|$, we rewrite it as follows. By exchangeability we have

$$
\begin{aligned}
& \mathbb{E}\left[\left(\Lambda^{-1} D\right)_{j} D_{k} D_{l} U \partial_{j k l} f(W+(1-U) D)\right] \\
& =-\mathbb{E}\left[\left(\Lambda^{-1} D\right)_{j} D_{k} D_{l} U \partial_{j k l} f\left(W^{\prime}-(1-U) D\right)\right] \\
& =-\mathbb{E}\left[\left(\Lambda^{-1} D\right)_{j} D_{k} D_{l} U \partial_{j k l} f(W+U D)\right] .
\end{aligned}
$$

Hence we obtain

$$
\begin{equation*}
\mathbb{E}[\Xi]=\frac{1}{4} \sum_{j, k, l=1}^{d} \mathbb{E}\left[\left(\Lambda^{-1} D\right)_{j} D_{k} D_{l} U\left\{\partial_{j k l} f(W+(1-U) D)-\partial_{j k l} f(W+U D)\right\}\right] \tag{3.4}
\end{equation*}
$$

Thus we conclude

$$
|\mathbb{E}[\Xi]| \leqslant \frac{M_{4}(f)}{4} \mathbb{E}\left[\left|\Lambda^{-1} D \| D\right|^{3}\right] \mathbb{E}[U|1-2 U|]=\frac{M_{4}(f)}{16} \mathbb{E}\left[\left|\Lambda^{-1} D \| D\right|^{3}\right] .
$$

Combining this estimate with (3.3), we obtain the desired result.
Next, we prove our first main result, Theorem 1.1, Because the test function is not smooth enough, it is a common strategy in Stein's method to smooth the test function first, then quantify the error introduced by such smoothing, finally balance the smoothing error with the smooth test function bound (cf. (3.11) to obtain the final result. There are many smoothing lemmas available in the Stein's method literature, we choose the one by Raič (2019) (cf. (3.9)) to use some readily available results.

Proof of Theorem 1.1. Take a Lipschitz function $h: \mathbb{R}^{d} \rightarrow \mathbb{R}$ arbitrarily. For every $\alpha \in$ $(0, \pi / 2)$, we define the function $\tilde{h}_{\alpha}: \mathbb{R}^{d} \rightarrow \mathbb{R}$ by

$$
\tilde{h}_{\alpha}(w)=\int_{\mathbb{R}^{d}} h\left(w \cos \alpha+\Sigma^{1 / 2} z \sin \alpha\right) \phi_{d}(z) d z, \quad w \in \mathbb{R}^{d}
$$

where $\phi_{d}$ is the $d$-dimensional standard normal density. It is easy to check that $\tilde{h}_{\alpha}$ is infinitely differentiable and

$$
\begin{align*}
\partial_{j_{1}, \ldots, j_{r}} \tilde{h}_{\alpha}(w)=(-1)^{r} \frac{\cos ^{r} \alpha}{\sin ^{r} \alpha} & \int_{\mathbb{R}^{d}} h\left(w \cos \alpha+\Sigma^{1 / 2} z \sin \alpha\right) \\
& \times \sum_{i_{1}, \ldots, i_{r}=1}^{d}\left(\Sigma^{-1 / 2}\right)_{i_{1}, j_{1}} \cdots\left(\Sigma^{-1 / 2}\right)_{i_{r}, j_{r}} \partial_{i_{1}, \ldots, i_{r}} \phi_{d}(z) d z \tag{3.5}
\end{align*}
$$

See also the proof of Raic̆ (2019, Lemma 4.6) for an analogous discussion. Therefore, noting the inequality after Eq.(4.9) of Raic̆ (2019) as well as Raic̆ (2019, Proposition 5.8), we obtain

M_{r+1}\left(\tilde{h}_{\alpha}\right) \leqslant c_{r} \frac{\cos ^{r+1} \alpha}{\sin ^{r} \alpha} M_{1}(h)\left\|\Sigma^{-1 / 2}\right\|_{o p}^{r} \tag{3.6}
\end{equation*}
$$

for any nonnegative integer $r$, where $c_{r}:=\int_{-\infty}^{\infty}\left|\phi_{1}^{(r)}(z)\right| d z$. In particular, we have by Eq.(4.10) of Raic̆ (2019)

$$
\begin{equation*}
c_{0}=1 \quad \text { and } \quad c_{3}=\frac{2+8 e^{-3 / 2}}{\sqrt{2 \pi}}<\frac{4}{\sqrt{2 \pi}} . \tag{3.7}
\end{equation*}
$$

Meanwhile, an analogous argument to the proof of Meckes (2009, Lemma 2, Point 4) yields

$$
\begin{equation*}
\sup _{w}\left\|\operatorname{Hess} \tilde{h}_{\alpha}(w)\right\|_{H . S} \leqslant \sqrt{\frac{2}{\pi}} \frac{\cos ^{2} \alpha}{\sin \alpha} M_{1}(h)\left\|\Sigma^{-1 / 2}\right\|_{o p} \tag{3.8}
\end{equation*}
$$

Combining (3.6)-(3.8) with Lemma 3.1, we obtain
$\left|\mathbb{E} \mathscr{S} \tilde{h}_{\alpha}(W)\right| \leqslant M_{1}(h)\left\{\mathbb{E}|R| \cos \alpha+\left\|\Sigma^{-1 / 2}\right\|_{o p} \sqrt{\frac{2}{\pi}} \frac{\cos ^{2} \alpha}{\sin \alpha} \mathbb{E}\|E\|_{H . S .}+\frac{\left\|\Sigma^{-1 / 2}\right\|_{o p}^{3}}{4 \sqrt{2 \pi}} \frac{\cos ^{4} \alpha}{\sin ^{3} \alpha} \mathbb{E}\left[\left|\Lambda^{-1} D \| D\right|^{3}\right]\right\}$.
Now, we obtain $\frac{d}{d \alpha} \tilde{h}_{\alpha}(w)=\mathscr{S} \tilde{h}_{\alpha}(w) \tan \alpha$ by differentiation under the integral sign and Gaussian integration by parts. We also have

$$
\left|\mathbb{E} h(W)-\mathbb{E} \tilde{h}_{\varepsilon}(W)\right| \leqslant M_{1}(h) \sqrt{(1-\cos \varepsilon)^{2} \mathbb{E}|W|^{2}+\mathbb{E}|Z|^{2} \sin ^{2} \varepsilon} \leqslant 2 A M_{1}(h) \sin \frac{\varepsilon}{2}
$$

for any $\varepsilon \in[0, \pi / 2]$, where $A:=\sqrt{\mathbb{E}|W|^{2} \vee \operatorname{tr}(\Sigma)}$. Consequently, we obtain (cf. Raic̈ (2019, Eq.(4.14) and (4.23)))

$$
\begin{equation*}
|\mathbb{E} h(W)-\mathbb{E} h(Z)| \leqslant \int_{\varepsilon}^{\pi / 2}\left|\mathbb{E}\left[\mathscr{S} \tilde{h}_{\alpha}(W)\right]\right| \tan \alpha d \alpha+2 A M_{1}(h) \sin \frac{\varepsilon}{2} . \tag{3.9}
\end{equation*}
$$

Therefore, if $\mathbb{E}\left[\left|\Lambda^{-1} D \| D\right|^{3}\right]=0$, by letting $\varepsilon=0$ we obtain

$$
|\mathbb{E} h(W)-\mathbb{E} h(Z)| \leqslant M_{1}(h)\left(\mathbb{E}|R|+\left\|\Sigma^{-1 / 2}\right\|_{o p} \sqrt{\frac{2}{\pi}} \mathbb{E}\|E\|_{H . S S}\right) .
$$

So we complete the proof. Meanwhile, if $\mathbb{E}\left[\left|\Lambda^{-1} D \| D\right|^{3}\right]>0$, assuming $\varepsilon>0$, we obtain

$$
\begin{aligned}
& \int_{\varepsilon}^{\pi / 2}\left|\mathbb{E}\left[\mathscr{S} \tilde{h}_{\alpha}(W)\right]\right| \tan \alpha d \alpha \\
& \leqslant M_{1}(h) \int_{\varepsilon}^{\pi / 2}\left(\mathbb{E}|R| \sin \alpha+\left\|\Sigma^{-1 / 2}\right\|_{o p} \sqrt{\frac{2}{\pi}} \mathbb{E}\|E\|_{\text {H.S. }} \cos \alpha+\frac{\left\|\Sigma^{-1 / 2}\right\|_{o p}^{3}}{4 \sqrt{2 \pi}} \frac{\cos ^{3} \alpha}{\sin ^{2} \alpha} \mathbb{E}\left[\left|\Lambda^{-1} D \| D\right|^{3}\right]\right) d \alpha \\
& \leqslant M_{1}(h)\left(\mathbb{E}|R|+\left\|\Sigma^{-1 / 2}\right\|_{o p} \sqrt{\frac{2}{\pi}} \mathbb{E}\|E\|_{\text {H.S. }}+\frac{\left\|\Sigma^{-1 / 2}\right\|_{o p}^{3}}{4 \sqrt{2 \pi}} \frac{1}{\sin \varepsilon} \mathbb{E}\left[\left|\Lambda^{-1} D \| D\right|^{3}\right]\right) .
\end{aligned}
$$

Set $\varepsilon:=\frac{1}{2}\left(\frac{\pi}{8}\right)^{1 / 4} \sqrt{\left\|\Sigma^{-1 / 2}\right\|_{o p}^{3} \mathbb{E}\left[\left|\Lambda^{-1} D \| D\right|^{3}\right] / A}$. If $\varepsilon>\pi / 2$, we have $2 \varepsilon A>2 A$. Since we always have $d_{\mathcal{W}}(W, Z) \leqslant \mathbb{E}|W-Z| \leqslant 2 A$, the desired bound is trivial in this case. Otherwise, we may apply the above estimate with this $\varepsilon$ and obtain

|\mathbb{E} h(W)-\mathbb{E} h(Z)| \leqslant M_{1}(h)\left(\mathbb{E}|R|+\left\|\Sigma^{-1 / 2}\right\|_{o p} \sqrt{\frac{2}{\pi}} \mathbb{E}\|E\|_{H . S .}+2 \varepsilon A\right)
$$

where we used Jordan's inequality $2 / \pi<\sin \varepsilon / \varepsilon \leqslant 1$. This is the desired bound.

Next, we prove Theorem 1.2, which is a consequence of Lemma 3.1 and properties of the solution to the Stein equation (3.11).

Proof of Theorem 1.2. Let

f(x):=f_{h}(x)=\int_{0}^{1} \frac{1}{2 t}[\mathbb{E} h(\sqrt{t} x+\sqrt{1-t} Z)-\mathbb{E} h(Z)] d t \tag{3.10}

be the solution to the Stein equation (cf. Lemma 1, Point 3 of Meckes (2009))

$$
\begin{equation*}
-\mathscr{S} f(x)=h(x)-\mathbb{E} h(Z) . \tag{3.11}
\end{equation*}
$$

It is easy to check that (cf. Lemma 2, Point 1 of Meckes (2009))

$$
\begin{equation*}
M_{1}(f) \leqslant M_{1}(h) \tag{3.12}
\end{equation*}
$$

It is also known that (cf. Lemma 2, Point 4 of Meckes (2009))

$$
\begin{equation*}
\sup _{x}\|\operatorname{Hess} f(x)\|_{H . S .} \leqslant \sqrt{\frac{2}{\pi}} M_{1}(h)\left\|\Sigma^{-1 / 2}\right\|_{o p} \tag{3.13}
\end{equation*}
$$

Moreover, we have by Proposition 2.1 of Gaunt (2016)

$$
\begin{equation*}
M_{4}(f) \leqslant \frac{4}{3 \sqrt{2 \pi}} M_{3}(h)\left\|\Sigma^{-1 / 2}\right\|_{o p} \tag{3.14}
\end{equation*}
$$

Theorem 1.2 follows from (3.12)-(3.14) and Lemma 3.1 .
Proof of (1.3). Define the function $f$ by (3.10) again. We have by Lemma 2, Point 1 of Meckes (2009)

$$
M_{1}(f) \leqslant M_{1}(h) \quad \text { and } \quad M_{4}(f) \leqslant \frac{1}{4} M_{4}(h) .
$$

Also, we have by Lemma 2, Point 2 of Meckes (2009)

$$
\sup _{x}\|\operatorname{Hess} f(x)\|_{H . S .} \leqslant \frac{1}{2} \sup _{x}\|\operatorname{Hess} h(x)\|_{H . S .} \leqslant \frac{\sqrt{d}}{2} M_{2}(h)
$$

where the last inequality follows because $M_{2}(h)=\sup _{x}\|\operatorname{Hessh}(x)\|_{o p}$. (1.3) follows from the above bounds and Lemma 3.1.

Finally, we prove Theorem 1.3 following the same strategy of the proof of Theorem 1.1.
Proof of Theorem 1.3. We need to establish a counterpart of Lemma 3.1 in the present setting, which can be shown in line with the proof of Proposition 3.5 in Döbler, Vidotto and Zheng (2018) as follows. Let $f: \mathbb{R}^{d} \rightarrow \mathbb{R}$ be a $C^{4}$ function with bounded partial derivatives. Then, similarly to the derivation of (3.2), we obtain for every $t>0$

0=\mathbb{E}\left[\frac{1}{2}\left\langle\Lambda^{-1} D_{t} D_{t}^{\top}, \operatorname{Hess} f(W)\right\rangle_{H . S .}+\Xi_{t}+\left(\Lambda^{-1} D_{t}\right) \cdot \nabla f(W)\right],
$$

where $D_{t}=W_{t}-W$ and

$$
\Xi_{t}=\frac{1}{2} \sum_{j, k, l=1}^{d}\left(\Lambda^{-1} D_{t}\right)_{j}\left(D_{t}\right)_{k}\left(D_{t}\right)_{l} U \partial_{j k l} f\left(W+(1-U) D_{t}\right)
$$

with $U$ being a uniform random variable on $[0,1]$ independent of everything else. By the same argument as in the derivation of (3.4), we deduce

$$
\mathbb{E}\left[\Xi_{t}\right]=\frac{1}{4} \sum_{j, k, l=1}^{d} \mathbb{E}\left[\left(\Lambda^{-1} D_{t}\right)_{j}\left(D_{t}\right)_{k}\left(D_{t}\right)_{l} U\left\{\partial_{j k l} f\left(W+(1-U) D_{t}\right)-\partial_{j k l} f\left(W+U D_{t}\right)\right\}\right]
$$

Thus we obtain

$$
\begin{aligned}
\left|\mathbb{E}\left[\Xi_{t}\right]\right| & \leqslant \frac{M_{4}(f)}{16} \mathbb{E}\left[\left|\Lambda^{-1} D_{t} \| D_{t}\right|^{3}\right] \leqslant \frac{M_{4}(f)}{16}\left\|\Lambda^{-1}\right\|_{o p} \mathbb{E}\left[\left|D_{t}\right|^{4}\right] \\
& \leqslant \frac{M_{4}(f)}{16}\left\|\Lambda^{-1}\right\|_{o p} \cdot d \sum_{j=1}^{d} \mathbb{E}\left(\left(W_{t}\right)_{j}-W_{j}\right)^{4}
\end{aligned}
$$

Hence, (1.7) yields

$$
\limsup _{t \downarrow 0} \frac{1}{t}\left|\mathbb{E}\left[\Xi_{t}\right]\right| \leqslant \frac{M_{4}(f)}{16} d\left\|\Lambda^{-1}\right\|_{o p} \sum_{j=1}^{d} \rho_{i}(W)
$$

Meanwhile, we obtain from (1.5)-(1.6)

$$
\begin{aligned}
-\lim _{t \downarrow 0} \frac{1}{t} \mathbb{E}\left[\Xi_{t}\right] & =\mathbb{E}\left[\frac{1}{2}\left\langle 2 \Sigma+\Lambda^{-1} S, \operatorname{Hess} f(W)\right\rangle_{H . S .}-(W+R) \cdot \nabla f(W)\right] \\
& =\mathbb{E} \mathscr{S} f(W)+\frac{1}{2} \mathbb{E}\left[\left\langle\Lambda^{-1} S, \operatorname{Hess} f(W)\right\rangle_{H . S .}-R \cdot \nabla f(W)\right]
\end{aligned}
$$

Consequently, we conclude

$$
\begin{align*}
&|\mathbb{E} \mathscr{S} f(W)| \leqslant M_{1}(f) \mathbb{E}|R|+\frac{1}{2} \sup _{w}\|\operatorname{Hess} f(w)\|_{H . S .} \mathbb{E}\left\|\Lambda^{-1} S\right\|_{H . S .} \\
&+\frac{M_{4}(f)}{16} d\left\|\Lambda^{-1}\right\|_{o p} \sum_{j=1}^{d} \rho_{i}(W) \tag{3.15}
\end{align*}
$$

Now, the remainder of the proof is completely parallel to that of Theorem 1.1 with using (3.15) instead of Lemma 3.1 (note that the function $\tilde{h}_{\alpha}$ in the proof of Theorem 1.1 has bounded partial derivatives as long as $\alpha>0$, thanks to (3.6)).

### 3.2 Proof of applications

In this subsection, we prove the results stated in Section 2. Theorem 2.1 follows from Theorem 1.2 and a new construction of exchangeable pairs for Wishart matrices.

Proof of Theorem 2.1. We first construct an exchangeable pair satisfying the linearity condition in (1.1). Let $X^{*}=\left\{X_{i k}^{*}: 1 \leqslant i \leqslant n, 1 \leqslant k \leqslant d\right\}$ be an independent copy of $X$. Let $I \sim \operatorname{Unif}[n]$ and $K \sim \operatorname{Unif}[d]$ be independent uniform random indices that are independent of $X$ and $X^{*}$. Let $X^{\prime}=\left\{X_{i k}^{\prime}: 1 \leqslant i \leqslant n, 1 \leqslant k \leqslant d\right\}$ where

$$
X_{i k}^{\prime}= \begin{cases}X_{i k}^{*}, & \text { if } i=I, k=K \\ X_{i k}, & \text { otherwise }\end{cases}
$$

Let

$$
W_{i j}^{\prime}=\frac{1}{\sqrt{d}} \sum_{k=1}^{d} X_{i k}^{\prime} X_{j k}^{\prime}
$$

and regard $W^{\prime}=\left\{W_{i j}^{\prime}: 1 \leqslant i<j \leqslant n\right\}$ as an $\binom{n}{2}$-vector. By construction, $\mathcal{L}\left(X, X^{\prime}\right)=$ $\mathcal{L}\left(X^{\prime}, X\right) ;$ Hence, $\mathcal{L}\left(W, W^{\prime}\right)=\mathcal{L}\left(W^{\prime}, W\right)$. For $1 \leqslant i<j \leqslant n$, we have

$$
\begin{aligned}
& \mathbb{E}\left(W_{i j}^{\prime}-W_{i j} \mid X\right) \\
= & \mathbb{E}\left[\left(W_{i j}^{\prime}-W_{i j}\right) 1(i=I)+\left(W_{i j}^{\prime}-W_{i j}\right) 1(j=I) \mid X\right] \\
= & \mathbb{E}\left[\left.\frac{1}{\sqrt{d}}\left(X_{i K}^{*}-X_{i K}\right) X_{j K} 1(i=I)+\frac{1}{\sqrt{d}} X_{i K}\left(X_{j K}^{*}-X_{j K}\right) 1(j=I) \right\rvert\, X\right] \\
= & \frac{1}{n d} \sum_{k=1}^{d} \mathbb{E}\left[\left.\frac{1}{\sqrt{d}}\left(X_{i k}^{*}-X_{i k}\right) X_{j k}+\frac{1}{\sqrt{d}} X_{i k}\left(X_{j k}^{*}-X_{j k}\right) \right\rvert\, X\right] \\
= & -\frac{2}{n d} W_{i j} .
\end{aligned}
$$

Therefore,

$$
\mathbb{E}\left(W^{\prime}-W \mid X\right)=-\frac{2}{n d} W

and for $i<j, l<m$ such that $\{i, j\} \cap\{l, m\}=\emptyset$,

& \leqslant \sqrt{\frac{n^{2}}{4 d}\left[\mathbb{E} X_{11}^{4}+\left(\mathbb{E} X_{11}^{4}\right)^{2}\right]+\frac{n^{3}}{16 d}\left[3+\mathbb{E} X_{11}^{4}\right] .} \tag{3.16}

= & \frac{n^{3}}{d}\left(\mathbb{E} X_{11}^{4}+3\right)\left(\frac{\mathbb{E} X_{11}^{4}}{n}+1\right) .

Proof of Theorem [2.2. We apply Theorem 1.1 with the help of the results in Döbler and Peccati (2017). Following Döbler and Peccati (2017), we construct an exchangeable pair $\left(W, W^{\prime}\right)$ satisfying condition (1.1) as follows. Let $X^{*}=\left\{X_{1}^{*}, \ldots, X_{n}^{*}\right\}$ be an independent copy of $X:=\left\{X_{1}, \ldots, X_{n}\right\}$. Also, let $I \sim \operatorname{Unif}[n]$ be an index independent of $X$ and $X^{*}$. Define $X^{\prime}=\left\{X_{1}^{\prime}, \ldots, X_{n}^{\prime}\right\}$ by

Moreover, we have by Lemma 3.2 of Döbler and Peccati (2017)

& +4 p_{j}^{2}\left(\operatorname{Cov}\left(W_{j}^{2}, W_{k}^{2}\right)-2 \Sigma_{j k}^{2}+p_{j} \min \left\{\varrho_{n, k}^{2}, \varrho_{n, j}^{2}\right\}+p_{j} \varrho_{n, k} \varrho_{n, j}+C_{j, k} \max \left\{\varrho_{n, j}^{2}, \varrho_{n, k}^{2}\right\}\right) 1_{\left\{p_{j}=p_{k}\right\}},
\end{aligned}

where $C_{j, k}>0$ is a constant depending only on $p_{j}, p_{k}$. Since $\Sigma_{j k}=0$ if $p_{j}<p_{k}$ (cf. (2.3)), we deduce

\left.|\mathbb{E}| W\right|^{4}-\mathbb{E}|\tilde{W}|^{4}\left|\leqslant \sum_{j, k=1}^{d}\right| \mathbb{E} W_{j}^{2} W_{k}^{2}-\mathbb{E} \tilde{W}_{j}^{2} \tilde{W}_{k}^{2} \mid \leqslant d \sum_{j=1}^{d} C_{j} M^{p_{j}} \mathcal{M}\left(f_{j}\right) \tag{3.24}
\end{equation*}
$$

Using Eq.(4.2) of Nourdin and Rosiński (2014), we obtain

$$
\begin{equation*}
\mathbb{E}|\tilde{W}|^{4}-\mathbb{E}|Z|^{4}=\sum_{j, k=1}^{d}\left(\mathbb{E} \tilde{W}_{j}^{2} \tilde{W}_{k}^{2}-\Sigma_{j j} \Sigma_{k k}-2 \Sigma_{j k}^{2}\right)=\sum_{j, k=1}^{d}\left(\operatorname{Cov}\left(\tilde{W}_{j}^{2}, \tilde{W}_{k}^{2}\right)-2 \Sigma_{j k}^{2}\right) . \tag{3.25}
\end{equation*}
$$

We have by Eq. (5.17) of Koike (2019)

$$
\begin{align*}
& \left|\operatorname{Cov}\left(\tilde{W}_{j}^{2}, \tilde{W}_{k}^{2}\right)-2 \Sigma_{j k}^{2}\right| \leqslant 1_{\left\{p_{j} \neq p_{k}\right\}} \sqrt{\mathbb{E} \tilde{W}_{j \wedge k}^{4}} \sqrt{\mathbb{E} \tilde{W}_{j \vee k}^{4}-3} \\
& \quad+1_{\left\{p_{j}=p_{k}\right\}}\left\{2 \sqrt{\mathbb{E} \tilde{W}_{j}^{4}-3} \sqrt{\mathbb{E} \tilde{W}_{k}^{4}-3}+\left(2^{-p_{j}} \bar{v}_{n}^{p_{j}}-1\right) \sqrt{\mathcal{M}\left(f_{j}\right) \mathcal{M}\left(f_{k}\right)}\right\}, \tag{3.26}
\end{align*}
$$

where $\bar{v}_{n}:=\max _{1 \leqslant i \leqslant n}\left(2+s_{i}^{2} / 2\right)$. From (3.22) we obtain

$$
\begin{equation*}
2^{-p_{j}} \bar{v}_{n}^{p_{j}} \leqslant C_{j}\left(1+\max _{1 \leqslant i \leqslant n} s_{i}^{2 p_{j}}\right) \leqslant C_{j} M^{p_{j}} \tag{3.27}
\end{equation*}
$$

Also, we have by Lemma 4.2 of Nourdin, Peccati and Reinert (2010) and (3.23)

$$
\begin{equation*}
\mathbb{E} \tilde{W}_{j}^{4} \leqslant C_{j} M^{p_{j}}\left(\mathbb{E} \tilde{W}_{j}^{2}\right)^{2}=C_{j} M^{p_{j}} . \tag{3.28}
\end{equation*}
$$

Moreover, Lemma 3.2 yields

$$
\begin{equation*}
\mathbb{E} \tilde{W}_{j}^{4} \leqslant \mathbb{E} W_{j}^{4}+C_{j} M^{p_{j}} \mathcal{M}\left(f_{j}\right) \tag{3.29}
\end{equation*}
$$

Inserting (3.26) -(3.29) into (3.25) and using the AM-GM inequality, we obtain

\begin{aligned}
\left.|\mathbb{E}| \tilde{W}\right|^{4}-\mathbb{E}|Z|^{4} \mid \leqslant \sum_{j, k=1}^{d} 1_{\left\{p_{j}<p_{k}\right\}} C_{j} M^{p_{j} / 2} & \sqrt{\left(\mathbb{E} W_{k}^{4}-3\right)+C_{k} M^{p_{k}} \mathcal{M}\left(f_{k}\right)} \\
& +2 \sum_{j, k=1}^{d} 1_{\left\{p_{j}=p_{k}\right\}}\left(\left(\mathbb{E} W_{j}^{4}-3\right)+C_{j} M^{p_{j}} \mathcal{M}\left(f_{j}\right)\right) .
\end{aligned}
$$

Combining this estimate with (3.24), we obtain (3.21).
Finally, we apply the continuous version of the Wasserstein bound in Theorem 1.3 to obtain Theorem 2.3.

Proof of Theorem 2.3. From the proof of Theorem 1.7 in Döbler. Vidotto and Zheng (2018), there is a family of $d$-dimensional random vectors $\left(W_{t}\right)_{t>0}$ satisfying the assumptions of Theorem 1.3 with $\Lambda=\operatorname{diag}\left(q_{1}, \ldots, q_{d}\right), R=0, \rho_{j}(W)=2\left(4 q_{j}-3\right)\left(\mathbb{E} W_{j}^{4}-3\left(\mathbb{E} W_{j}^{2}\right)^{2}\right)$ and some $d \times d$ random matrix $S$. Moreover, from Eas.(4.2)-(4.3) in Döbler, Vidotto and Zheng (2018), this matrix $S$ satisfies

\mathbb{E}\|S\|_{H . S} \leqslant\left(2 q_{d}-1\right) \sqrt{\mathbb{E}\left[|W|^{4}-|Z|^{4}\right]} .
$$

Consequently, we obtain

d_{\mathcal{W}}(W, Z) \leqslant & \left\|\Sigma^{-1 / 2}\right\|_{o p} \frac{2 q_{d}-1}{q_{1} \sqrt{2 \pi}} \sqrt{\mathbb{E}\left[|W|^{4}-|Z|^{4}\right]} \\
& +\left\|\Sigma^{-1 / 2}\right\|_{o p}^{3 / 2}\left(\frac{\pi}{8}\right)^{1 / 4} \operatorname{tr}(\Sigma)^{1 / 4} \sqrt{d} \sqrt{\frac{2}{q_{1}} \sum_{j=1}^{d}\left(4 q_{j}-3\right)\left(\mathbb{E} W_{j}^{4}-3\left(\mathbb{E} W_{j}^{2}\right)^{2}\right)} .
\end{aligned}
$$

Since $\sqrt{2 \pi} \geqslant 2$ and $\max _{j} q_{j}=q_{d}$, we obtain (2.7). Finally, if $q_{1}=\cdots=q_{d}$, Lemma 4.1 in Döbler. Vidotto and Zheng (2018) yields

\sqrt{\mathbb{E}\left[|W|^{4}-|Z|^{4}\right]} \leqslant \sqrt{2} \sum_{j=1}^{d} \sqrt{\mathbb{E} W_{j}^{4}-3\left(\mathbb{E} W_{j}^{2}\right)^{2}} \leqslant \sqrt{2 d \sum_{j=1}^{d}\left(\mathbb{E} W_{j}^{4}-3\left(\mathbb{E} W_{j}^{2}\right)^{2}\right)} .
$$

Hence (2.8) holds true.

## A APPENDIX: OPTIMAL WASSERSTEIN BOUND FOR WISHART MATRICES

For multivariate normal approximation of Wishart matrices, a direct application of Theorem 1.1 yields a sub-optimal Wasserstein bound (cf. Remark [2.2). However, we can modify the proof of Theorem 1.1 to further exploit the independence structure in Wishart matrices and obtain the optimal Wasserstein bound assuming finite sixth moments. More precisely, we obtain:

Theorem A.1. Under the conditions of Theorem [2.1, if we assume in addition that $\mathbb{E} X_{11}^{6}<\infty$, then

$$
d_{\mathcal{W}}(W, Z) \leqslant C \sqrt{\frac{n^{3}}{d}} \vee\left(\frac{n^{3}}{d}\right)^{2 / 3},
$$

where $C$ is a constant only depending on $\mathbb{E} X_{11}^{6}$.
Below, we first give the modified version of Theorem 1.1 (cf. Theorem A.2) using truncation, we then use it to prove Theorem A.1. In the remainder of this appendix, we use $C$ to denote positive constants, which may depend on $\mathbb{E} X_{11}^{6}$ and may be different in different expressions.

## A. 1 A modified Wasserstein bound

We use the idea of truncation from Bonis (2020) to modify the proof of Theorem 1.1 as follows. We assume that

as in the case for Wishart matrices. Recall that in (3.9), we need to bound

where for a 1-Lipschitz function $h$,

\tilde{h}_{\alpha}(w)=\int_{\mathbb{R}^{d}} h(w \cos \alpha+z \sin \alpha) \phi_{d}(z) d z .
$$

We begin by applying a truncation to (3.2) with $f=\tilde{h}_{\alpha}$ as follows. Note that $\tilde{h}_{\alpha}$ is infinitely differentiable for $\alpha \in(0, \pi / 2)$. We have

& =\mathbb{E}\left[\frac{1}{2} \lambda^{-1} D \cdot\left(\nabla \tilde{h}_{\alpha}\left(W^{\prime}\right)-\nabla \tilde{h}_{\alpha}(W)\right) 1_{\{|D| \leqslant \tan \alpha\}}+\lambda^{-1} D \cdot \nabla \tilde{h}_{\alpha}(W) 1_{\{|D| \leqslant \tan \alpha\}}\right] \\
& =\mathbb{E}\left[\left\langle\frac{D D^{\top}}{2 \lambda}, \operatorname{Hess} \tilde{h}_{\alpha}(W)\right\rangle_{\text {H.S. }}+\Xi_{\alpha}-W \cdot \nabla \tilde{h}_{\alpha}(W)-\lambda^{-1} D \cdot \nabla \tilde{h}_{\alpha}(W) 1_{\{|D|>\tan \alpha\}}\right] \\
& =\mathbb{E}\left[\Delta \tilde{h}_{\alpha}(W)+\left\langle E, \operatorname{Hess} \tilde{h}_{\alpha}(W)\right\rangle_{\text {H.S. }}-\left\langle\frac{D D^{\top}}{2 \lambda}, \operatorname{Hess} \tilde{h}_{\alpha}(W)\right\rangle_{\text {H.S. }} 1_{\{|D|>\tan \alpha\}}\right.
\end{aligned}
$$

$$
\left.+\Xi_{\alpha}-W \cdot \nabla \tilde{h}_{\alpha}(W)-\lambda^{-1} D \cdot \nabla \tilde{h}_{\alpha}(W) 1_{\{|D|>\tan \alpha\}}\right]
$$

where

$$
\Xi_{\alpha}=\frac{1}{2 \lambda} \sum_{j, k, l=1}^{d} D_{j} D_{k} D_{l} U \partial_{j k l} \tilde{h}_{\alpha}(W+(1-U) D) 1_{\{|D| \leqslant \tan \alpha\}} .
$$

This implies

$$
\begin{align*}
\left|\mathbb{E} \mathscr{S} \tilde{h}_{\alpha}(W)\right| \leqslant & \left|\mathbb{E} \lambda^{-1} D \cdot \nabla \tilde{h}_{\alpha}(W) 1_{\{|D|>\tan \alpha\}}\right|+\left|\mathbb{E}\left\langle E, \operatorname{Hess} \tilde{h}_{\alpha}(W)\right\rangle_{H . S .}\right| \\
& +\left|\mathbb{E}\left\langle\frac{D D^{\top}}{2 \lambda}, \operatorname{Hess} \tilde{h}_{\alpha}(W)\right\rangle_{\text {H.S. }} 1_{\{|D|>\tan \alpha\}}\right|+\left|\mathbb{E} \Xi_{\alpha}\right|  \tag{A.1}\\
= & R_{1 \alpha}+R_{2 \alpha}+R_{3 \alpha}+R_{4 \alpha} .
\end{align*}
$$

We bound the four terms one by one as follows.
Because $|\nabla h(w)| \leqslant 1$, we have

R_{1 \alpha} \leqslant \lambda^{-1} \mathbb{E}\left|\mathbb{E}\left[D 1_{\{|D|>\tan \alpha\}} \mid \mathcal{G}\right]\right| .
$$

From (3.8), we have

R_{2 \alpha} \leqslant \frac{C}{\tan \alpha} \mathbb{E}\|E\|_{H . S .} .
$$

For $R_{3 \alpha}$, again using (3.8), we have

R_{3 \alpha} \leqslant \frac{C}{\lambda \tan \alpha} \mathbb{E}\left\|\mathbb{E}\left[D D^{\top} 1_{\{|D|>\tan \alpha\}} \mid \mathcal{G}\right]\right\|_{H . S .} .
$$

We will use the following lemma which will be proved at the end of this subsection.
Lemma A.1. Let $Y=\left(Y_{i j}\right)_{1 \leqslant i, j \leqslant d}$ be a $d \times d$ positive semidefinite symmetric random matrix. Let $F$ and $G$ be two random variables such that $|F| \leqslant G$. Suppose that $\mathbb{E}\left|Y_{i j} F\right|<$ $\infty$ for all $i, j=1, \ldots, d$. Let $\mathcal{G}$ be an arbitrary $\sigma$-field. Then we have

\|\mathbb{E}[Y F \mid \mathcal{G}]\|_{H . S .} \leqslant\|\mathbb{E}[Y G \mid \mathcal{G}]\|_{H . S .}
$$

From Lemma A. 1 ,

R_{3 \alpha} \leqslant \frac{C}{\lambda \tan ^{3} \alpha} \mathbb{E}\left\|\mathbb{E}\left[D D^{\top}|D|^{2} \mid \mathcal{G}\right]\right\|_{H . S .}
$$

For $R_{4 \alpha}$, following the symmetry argument as in (3.4), we have

$$
R_{4 \alpha}=\left|\frac{1}{4 \lambda} \mathbb{E}\left\langle U D_{\alpha}^{\otimes 3}, \nabla^{3} \tilde{h}_{\alpha}\left(W+(1-U) D_{\alpha}\right)-\nabla^{3} \tilde{h}_{\alpha}\left(W+U D_{\alpha}\right)\right\rangle\right|
$$

where $D_{\alpha}:=D 1_{\{|D| \leqslant \tan \alpha\}}$. By Taylor's expansion (cf. Lemma 1 of Bonis (2020) and its proof),

$$
\begin{aligned}
& \mathbb{E}\left\langle U D_{\alpha}^{\otimes 3}, \nabla^{3} \tilde{h}_{\alpha}\left(W+(1-U) D_{\alpha}\right)-\nabla^{3} \tilde{h}_{\alpha}\left(W+U D_{\alpha}\right)\right\rangle \\
= & \sum_{k=4}^{\infty} \frac{1}{(k-3)!} \mathbb{E}\left\langle U\left((1-U)^{k-3}-U^{k-3}\right) D_{\alpha}^{\otimes k}, \nabla^{k} \tilde{h}_{\alpha}(W)\right\rangle .
\end{aligned}
$$

This implies, by the Cauchy-Schwarz inequality,

$$
\begin{aligned}
R_{4 \alpha} \leqslant & \frac{\cos \alpha}{4 \lambda} \mathbb{E} \sqrt{\sum_{k=4}^{\infty} \frac{(\tan \alpha)^{2 k-2}}{\cos ^{2} \alpha(k-1)!}\left|\nabla^{k} \tilde{h}_{\alpha}(W)\right|^{2}} \\
& \times \sqrt{\sum_{k=4}^{\infty} \frac{(k-1)!}{((k-3)!)^{2}(\tan \alpha)^{2 k-2}}\left|\mathbb{E}\left[D_{\alpha}^{\otimes k} \mid \mathcal{G}\right]\right|^{2}},
\end{aligned}
$$

where $|\cdot|$ denotes the Euclidean norm by regarding the tensor as a $d^{k}$-vector. For every $w \in \mathbb{R}^{d}$, we have by a similar argument to the proof of Eq.(17) in Bonis (2020),

$$
\sum_{k=4}^{\infty} \frac{(\tan \alpha)^{2 k-2}}{\cos ^{2} \alpha(k-1)!}\left|\nabla^{k} \tilde{h}_{\alpha}(W)\right|^{2} \leqslant M_{1}(h) \leqslant 1 .
$$

We will use the following lemma which will be proved at the end of this subsection.
Lemma A.2. Let $Y$ be a random vector in $\mathbb{R}^{d}$ such that $\mathbb{E}|Y|^{k}<\infty$ for some integer $k \geqslant 2$. Let $\mathcal{G}$ be an arbitrary $\sigma$-field. Then

\left|\mathbb{E}\left[Y^{\otimes k} \mid \mathcal{G}\right]\right| \leqslant\left\|\mathbb{E}\left[Y Y^{\top}|Y|^{k-2} \mid \mathcal{G}\right]\right\|_{\text {H.S. }}
$$

From Lemma A. 2 and Lemma A. 1 and using $\left|D_{\alpha}\right| \leqslant \tan \alpha$, we obtain for $k \geqslant 4$

$$
\begin{aligned}
&\left|\mathbb{E}\left[D_{\alpha}^{\otimes k} \mid \mathcal{G}\right]\right|^{2} \leqslant \mid \mathbb{E}\left[D_{\alpha} D_{\alpha}^{\top} \|\left. D_{\alpha}\right|^{k-2} \mid \mathcal{G}\right] \|_{\text {H.S. }}^{2} \\
& \leqslant(\tan \alpha)^{2 k-8}\left\|\mathbb{E}\left[D_{\alpha} D_{\alpha}^{\top}\left|D_{\alpha}\right|^{2} \mid \mathcal{G}\right]\right\|_{\text {H.S. }}^{2} \leqslant(\tan \alpha)^{2 k-8}\left\|\mathbb{E}\left[D D^{\top}|D|^{2} \mid \mathcal{G}\right]\right\|_{\text {H.S. }}^{2} .
\end{aligned}
$$

We infer that

$$
\begin{aligned}
& \sum_{k=4}^{\infty} \frac{(k-1)!}{((k-3)!)^{2}(\tan \alpha)^{2 k-2}}\left|\mathbb{E}\left[D_{\alpha}^{\otimes k} \mid \mathcal{G}\right]\right|^{2} \\
\leqslant & \left(\sum_{k=4}^{\infty} \frac{(k-1)!}{((k-3)!)^{2}}\right) \frac{1}{\tan ^{6} \alpha}\left\|\mathbb{E}\left[D D^{\top}|D|^{2} \mid \mathcal{G}\right]\right\|_{H . S .}^{2} \\
\leqslant & \frac{C}{\tan ^{6} \alpha}\left\|\mathbb{E}\left[D D^{\top}|D|^{2} \mid \mathcal{G}\right]\right\|_{\text {H.S. }}^{2},
\end{aligned}
$$

and hence

$$
R_{4 \alpha} \leqslant \frac{C}{\lambda \tan ^{3} \alpha} \mathbb{E}\left\|\mathbb{E}\left[D D^{\top}|D|^{2} \mid \mathcal{G}\right]\right\|_{H . S .} .
$$

Combining the bounds for $R_{1 \alpha}-R_{4 \alpha}$, we have, from (3.9) and (A.1),

$$
\begin{aligned}
d_{\mathcal{W}}(W, Z) \leqslant & \int_{\varepsilon}^{\pi / 2}\left|\mathbb{E}\left[\mathscr{S} \tilde{h}_{\alpha}(W)\right]\right| \tan \alpha d \alpha+2 \sqrt{d} \sin \frac{\varepsilon}{2} \\
\leqslant & \lambda^{-1} \int_{\varepsilon}^{\pi / 2} \mathbb{E}\left|\mathbb{E}\left[D 1_{|D|>\tan \alpha} \mid \mathcal{G}\right]\right| \tan \alpha d \alpha+C \mathbb{E}\|E\|_{H . S .} \\
& +C \lambda^{-1} \int_{\varepsilon}^{\pi / 2} \frac{1}{\tan ^{2} \alpha} \mathbb{E}\left\|\mathbb{E}\left[D D^{\top}|D|^{2} \mid \mathcal{G}\right]\right\|_{H . S .} d \alpha+2 \sqrt{d} \sin \frac{\varepsilon}{2}
\end{aligned}
$$

Optimizing $\varepsilon$, we obtain:

Theorem A.2. Under the conditions of Theorem 1.1, if we assume in addition that

$$
\Sigma=I_{d}, \quad \Lambda=\lambda I_{d}, \quad R=0,
$$

then

$$
\begin{aligned}
d_{\mathcal{W}}(W, Z) \leqslant & \lambda^{-1} \int_{0}^{\pi / 2} \mathbb{E}\left|\mathbb{E}\left[D 1_{|D|>\tan \alpha} \mid \mathcal{G}\right]\right| \tan \alpha d \alpha+C \mathbb{E}\|E\|_{\text {H.S. }} \\
& +C d^{1 / 4} \sqrt{\lambda^{-1} \mathbb{E} \mid\left\|\mathbb{E}\left[D D^{\top}|D|^{2} \mid \mathcal{G}\right]\right\|_{H . S .}}
\end{aligned}
$$

Remark A.1. The assumptions $\Sigma=I_{d}$ and $R=0$ are not essential and can be easily relaxed. The assumption $\Lambda=\lambda I_{d}$ is crucial to be able to apply Lemmas A.1 and A.2. Although Theorem A.2 is in a slightly more complicated form than Theorem 1.1, it is in terms of conditional expectations $\mathbb{E}[\cdot \mid \mathcal{G}]$, which enables us to exploit further the independence structure in Wishart matrices. We note, however, Theorem A. 2 is not strictly better than Theorem 1.1 even under these additional assumptions and does not improve the rate (e.g., for sums of independent random vectors) in general.

Proof of Lemma A.1. Given a $d \times d$ symmetric matrix $A$, we write the ordered eigenvalues of $A$ as $\lambda_{1}(A) \leqslant \cdots \leqslant \lambda_{d}(A)$. For any $u \in \mathbb{R}^{d}$, we have

$$
u^{\top}(\mathbb{E}[Y G \mid \mathcal{G}]-\mathbb{E}[Y F \mid \mathcal{G}]) u=\mathbb{E}\left[u^{\top} Y u \cdot(G-F) \mid \mathcal{G}\right] \geqslant 0 .
$$

Therefore, $\mathbb{E}[Y G \mid \mathcal{G}]-\mathbb{E}[Y F \mid \mathcal{G}]$ is positive semidefinite. Similarly, we can prove $\mathbb{E}[Y G \mid \mathcal{G}]-$ $(-\mathbb{E}[Y F \mid \mathcal{G}])$ is positive semidefinite. Thus, we have $\left|\lambda_{j}(\mathbb{E}[Y F \mid \mathcal{G}])\right| \leqslant \lambda_{j}(\mathbb{E}[Y G \mid \mathcal{G}])$ for all $j$ by Corollary 7.7.4 of Hohn and Johnson (2013). Hence we conclude

$$
\|\mathbb{E}[Y F \mid \mathcal{G}]\|_{H . S .}^{2}=\sum_{j=1}^{d} \lambda_{j}(\mathbb{E}[Y F \mid \mathcal{G}])^{2} \leqslant \sum_{j=1}^{d} \lambda_{j}(\mathbb{E}[Y G \mid \mathcal{G}])^{2}=\|\mathbb{E}[Y G \mid \mathcal{G}]\|_{H . S .}^{2}
$$

This completes the proof.
Proof of Lemma A.2. Taking the regular conditional probability distribution of $Y$ given $\mathcal{G}$ instead of the original probability measure, it suffices to consider the unconditional case. Let $Y^{\prime}$ be an independent copy of $Y$. Then

\mathbb{E}\left(Y \cdot Y^{\prime}\right)^{k} & =\sum_{j_{1}, \ldots, j_{k}=1}^{d} \mathbb{E}\left[Y_{j_{1}} Y_{j_{1}}^{\prime} \cdots Y_{j_{k}} Y_{j_{k}}^{\prime}\right]=\sum_{j_{1}, \ldots, j_{k}=1}^{d} \mathbb{E}\left[Y_{j_{1}} \cdots Y_{j_{k}}\right] \mathbb{E}\left[Y_{j_{1}}^{\prime} \cdots Y_{j_{k}}^{\prime}\right] \\
& =\sum_{j_{1}, \ldots, j_{k}=1}^{d} \mathbb{E}\left[Y_{j_{1}} \cdots Y_{j_{k}}\right]^{2}=\left|\mathbb{E}\left[Y^{\otimes k}\right]\right|^{2} .
\end{aligned}
$$

Hence, we have by the Cauchy-Schwarz inequality

$$
\left|\mathbb{E} Y^{\otimes k}\right|^{2} \leqslant \mathbb{E}\left(Y \cdot Y^{\prime}\right)^{2}|Y|^{k-2}\left|Y^{\prime}\right|^{k-2}=\sum_{i, j=1}^{d} \mathbb{E}\left[Y_{i} Y_{i}^{\prime} Y_{j} Y_{j}^{\prime}|Y|^{k-2}\left|Y^{\prime}\right|^{k-2}\right]
$$

$$
\begin{aligned}
& =\sum_{i, j=1}^{d} \mathbb{E}\left[Y_{i} Y_{j}|Y|^{k-2}\right] \mathbb{E}\left[Y_{i}^{\prime} Y_{j}^{\prime}\left|Y^{\prime}\right|^{k-2}\right]=\sum_{i, j=1}^{d} \mathbb{E}\left[Y_{i} Y_{j}|Y|^{k-2}\right]^{2} \\
& =\left\|\mathbb{E}\left[Y Y^{\top}|Y|^{k-2}\right]\right\|_{\text {H.S. }}^{2} .
\end{aligned}
$$

This completes the proof.

## A. 2 Proof of Theorem A. 1

Now we apply Theorem A. 2 to multivariate normal approximation of Wishart matrices. Recall the basic notation from Sections 2.1 and 3.2. Note that now $d$ denotes the number of columns of the i.i.d. matrix $X=\left\{X_{i k}: 1 \leqslant i \leqslant n, 1 \leqslant k \leqslant d\right\}$ and the dimension is $\binom{n}{2}$.

In (3.16), we have proved that

$$
\mathbb{E}\|E\|_{H . S .} \leqslant C \sqrt{\frac{n^{3}}{d}}
$$

We now first bound

$$
\lambda^{-1} \int_{0}^{\pi / 2} \mathbb{E}\left|\mathbb{E}\left[D 1_{|D|>\tan \alpha} \mid \mathcal{G}\right]\right| \tan \alpha d \alpha
$$

Denote $D^{i k}$ to be the difference $W^{\prime}-W$ given the random indices in the construction of exchangeable paris at the beginning of proof of Theorem [2.1 as $I=i, K=k$ for some $1 \leqslant i \leqslant n$ and $1 \leqslant k \leqslant d$. Then $D^{i k}$ is regarded as an $\binom{n}{2}$-vector ( $D_{l m}^{i k}: 1 \leqslant l<m \leqslant n$ ) and

$$
\begin{equation*}
D_{l m}^{i k}=\frac{1}{\sqrt{d}}\left[\delta_{i l}\left(X_{i k}^{*}-X_{i k}\right) X_{m k}+\delta_{i m}\left(X_{i k}^{*}-X_{i k}\right) X_{l k}\right] \tag{A.2}
\end{equation*}
$$

Note that

$$
\mathbb{E}\left[D 1_{\{|D|>\tan \alpha\}} \mid \mathcal{G}\right]=\frac{1}{n d} \sum_{i=1}^{n} \sum_{k=1}^{d} \mathbb{E}\left[D^{i k} 1_{\mid D^{i k \mid>\tan \alpha}} \mid \mathcal{G}\right]
$$

and each conditional expectation has mean 0 by exchangeability. Also, from its expression above, $D_{l m}^{i k}$ are independent across different $k$ 's. Therefore,

$$
\begin{align*}
& \lambda^{-1} \mathbb{E}\left|\mathbb{E}\left[D 1_{|D|>\tan \alpha} \mid \mathcal{G}\right]\right| \\
\leqslant & \frac{1}{2} \sqrt{\sum_{1 \leqslant l<m \leqslant n} \sum_{k=1}^{d} \operatorname{Var}\left(\sum_{i=1}^{n} D_{l m}^{i k} 1_{\left\{\left|D^{i k}>\tan \alpha\right|\right\}}\right)}  \tag{A.3}\\
= & \frac{1}{2} \sqrt{\sum_{1 \leqslant l<m \leqslant n} \sum_{k=1}^{d} \operatorname{Var}\left(D_{l m}^{l k} 1_{\left\{\left|D^{l k}>\tan \alpha\right|\right\}}+D_{l m}^{m k} 1_{\left\{\left|D^{m k}>\tan \alpha\right|\right\}}\right)},
\end{align*}
$$

where the last equality is from the fact that $D_{l m}^{i k}$ is non-zero only if $i=l$ or $m$. Now,

$$
\begin{aligned}
& \frac{1}{2} \sqrt{\sum_{1 \leqslant l<m \leqslant n} \sum_{k=1}^{d} \operatorname{Var}\left(D_{l m}^{l k} 1_{\left\{\left|D^{l k}>\tan \alpha\right|\right\}}\right)} \\
\leqslant & \frac{1}{2 \tan \alpha} \sqrt{\sum_{1 \leqslant l<m \leqslant n} \sum_{k=1}^{d} \mathbb{E}\left[\left(D_{l m}^{l k}\right)^{2}\left|D^{l k}\right|^{2}\right]} \\
= & \frac{1}{2 \tan \alpha} \sqrt{\sum_{1 \leqslant l<m \leqslant n} \sum_{k=1}^{d} \mathbb{E}\left[\left(D_{l m}^{l k}\right)^{2}\left(\sum_{u: u<l}\left(D_{u l}^{l k}\right)^{2}+\sum_{v: v>l}\left(D_{l v}^{l k}\right)^{2}\right)\right]} \\
\leqslant & \frac{C}{\tan \alpha} \sqrt{n^{2} d \frac{1}{d^{2}} n}=\frac{C}{\tan \alpha} \sqrt{\frac{n^{3}}{d} .}
\end{aligned}
$$

Together with the same bound for the variance of the second term in (A.3), we obtain

$$
\lambda^{-1} \int_{0}^{\pi / 2} \mathbb{E}\left|\mathbb{E}\left[D 1_{|D|>\tan \alpha} \mid \mathcal{G}\right]\right| \tan \alpha d \alpha \leqslant C \sqrt{\frac{n^{3}}{d}}
$$

Next, we bound

$$
\binom{n}{2}^{1 / 4} \sqrt{\lambda^{-1} \mathbb{E}\left\|\mathbb{E}\left[D D^{\top}|D|^{2} \mid \mathcal{G}\right]\right\|_{H . S .}}
$$

which is further bounded by

$$
\begin{equation*}
\binom{n}{2}^{1 / 4}\left(\left\|\lambda^{-1} \mathbb{E}\left[D D^{\top}|D|^{2}\right]\right\|_{H . S .}^{1 / 2}+\sqrt{\lambda^{-1} \mathbb{E}\left\|\mathbb{E}\left[D D^{\top}|D|^{2} \mid \mathcal{G}\right]-\mathbb{E}\left[D D^{\top}|D|^{2}\right]\right\|_{H . S .}}\right) \tag{A.4}
\end{equation*}
$$

For the first term in (A.4), we have

$$
\begin{aligned}
& \left\|\lambda^{-1} \mathbb{E}\left[D D^{\top}|D|^{2}\right]\right\|_{H . S .}^{2}=\sum_{\substack{1 \leqslant l<m \leqslant n \\
1 \leqslant u<v \leqslant n}}\left(\lambda^{-1} \sum_{1 \leqslant p<q \leqslant n} \mathbb{E}\left[D_{l m} D_{u v} D_{p q}^{2}\right]\right)^{2} \\
= & \frac{1}{4} \sum_{\substack{1 \leqslant l<m \leqslant n \\
1 \leqslant u<v \leqslant n}}\left(\sum_{i=1}^{n} \sum_{k=1}^{d} \sum_{1 \leqslant p<q \leqslant n} \mathbb{E}\left[D_{l m}^{i k} D_{u v}^{i k}\left(D_{p q}^{i k}\right)^{2}\right]\right)^{2} .
\end{aligned}
$$

From ( $(\boxed{\text { A.2 }})$, for the expectation to be non-zero, we must have $(l, m)=(u, v), i=l$ or $m$, and $p$ or $q=i$. Hence,

$$
\binom{n}{2}^{1 / 4}\left(\left\|\lambda^{-1} \mathbb{E}\left[D D^{\top}|D|^{2}\right]\right\|_{H . S .}^{2}\right)^{1 / 4} \leqslant C\binom{n}{2}^{1 / 4}\left(n^{2}\left(d n \frac{1}{d^{2}}\right)^{2}\right)^{1 / 4} \leqslant C \sqrt{\frac{n^{3}}{d}}
$$

For the second term in (A.4), note that

$$
\begin{equation*}
\lambda^{-1} \mathbb{E}\left\|\mathbb{E}\left[D D^{\top}|D|^{2} \mid \mathcal{G}\right]-\mathbb{E}\left[D D^{\top}|D|^{2}\right]\right\|_{H . S .}=\frac{1}{2} \mathbb{E}\left\|\sum_{k=1}^{d} \sum_{i=1}^{n} Y^{i k}\right\|_{H . S} \tag{A.5}
\end{equation*}
$$

where

$$
Y^{i k}:=\mathbb{E}\left[D^{i k}\left(D^{i k}\right)^{\top}\left|D^{i k}\right|^{2} \mid \mathcal{G}\right]-\mathbb{E}\left[D^{i k}\left(D^{i k}\right)^{\top}\left|D^{i k}\right|^{2}\right] .
$$

Since $Y^{i k}$ are independent across different $k$ 's, we have by the symmetrization inequality (cf. Lemma 6.3 in Ledoux and Talagrand (1991))

$$
\mathbb{E}\left\|\sum_{k=1}^{d} \sum_{i=1}^{n} Y^{i k}\right\|_{H . S .} \leqslant 2 \mathbb{E}\left\|\sum_{k=1}^{d} \varepsilon_{k} \sum_{i=1}^{n} Y^{i k}\right\|_{H . S .}
$$

where $\epsilon=\left\{\epsilon_{1}, \ldots, \epsilon_{d}\right\}$ is a sequence of independent Rademacher variables independent of everything else. Then, we obtain by Jensen's inequality

$$
\begin{aligned}
\mathbb{E}\left\|\sum_{k=1}^{d} \sum_{i=1}^{n} Y^{i k}\right\|_{H . S .} & \leqslant 2 \mathbb{E} \sqrt{\mathbb{E}\left[\left\|\sum_{k=1}^{d} \varepsilon_{k} \sum_{i=1}^{n} Y^{i k}\right\|_{H . S .}^{2} \mid X\right]}=2 \mathbb{E} \sqrt{\sum_{k=1}^{d}\left\|\sum_{i=1}^{n} Y^{i k}\right\|_{H . S .}^{2}} \\
& \leqslant 2\left(\mathbb{E}\left[\left(\sum_{k=1}^{d}\left\|\sum_{i=1}^{n} Y^{i k}\right\|_{H . S}^{2}\right)^{3 / 4}\right]\right)^{2 / 3} \\
& =2\left(\mathbb{E}\left[\left(\sum_{k=1}^{d} \sum_{\substack{1 \leqslant l<m \leqslant n \\
1 \leqslant u<v \leqslant n}}\left(\sum_{i=1}^{n} Y_{l m, u v}^{i k}\right)^{2}\right)^{3 / 4}\right]\right)^{2 / 3}
\end{aligned}
$$

where

$$
Y_{l m, u v}^{i k}:=\mathbb{E}\left[D_{l m}^{i k} D_{u v}^{i k}\left|D^{i k}\right|^{2} \mid \mathcal{G}\right]-\mathbb{E}\left[D_{l m}^{i k} D_{u v}^{i k}\left|D^{i k}\right|^{2}\right]
$$

Using the elementary inequality $\left(\sum_{j} x_{j}\right)^{3 / 4} \leqslant \sum_{j} x_{j}^{3 / 4}$ for $x_{j} \geqslant 0$, we conclude

$$
\mathbb{E}\left\|\sum_{k=1}^{d} \sum_{i=1}^{n} Y^{i k}\right\|_{H . S .} \leqslant 2\left(\sum_{k=1}^{d} \sum_{\substack{1 \leqslant \lll \ll n \\ 1 \leqslant u<v \leqslant n}} \mathbb{E}\left[\left|\sum_{i=1}^{n} Y_{l m, u v}^{i k}\right|^{3 / 2}\right]\right)^{2 / 3}
$$

Now, note that from the expression (A.2), for $D_{l m}^{i k} D_{u v}^{i k}$ to be non-zero, $\{l, m\}$ and $\{u, v\}$ must have at least one element in common and $i$ must be such a common element. There are $\sim n^{3}$ such combinations. For a typical term with some $k=1, \ldots, d$,

$$
\begin{aligned}
\mathbb{E}\left[\left|Y_{l m, l v}^{l k}\right|^{3 / 2}\right] & \leqslant C \mathbb{E}\left[\left.\left.\left|D_{l m}^{l k} D_{l v}^{l k}\right| D^{l k}\right|^{2}\right|^{3 / 2}\right] \\
& =C \mathbb{E}\left[\left|\sum_{q: q>l} D_{l m}^{l k} D_{l v}^{l k}\left(D_{l q}^{l k}\right)^{2}+\sum_{p: p<l} D_{l m}^{l k} D_{l v}^{l k}\left(D_{p l}^{l k}\right)^{2}\right|^{3 / 2}\right] \\
& =C \mathbb{E}\left[\left|\frac{1}{d^{2}} \sum_{q: q \neq l}\left(X_{l k}^{*}-X_{l k}\right)^{4} X_{m k} X_{v k} X_{q k}^{2}\right|^{3 / 2}\right]
\end{aligned}
$$

Since $l \neq m$ and $l \neq v$, we obtain

$$
\begin{aligned}
\mathbb{E}\left[\left|Y_{l m, l v}^{l k}\right|^{3 / 2}\right] & \leqslant \frac{C}{d^{3}} \mathbb{E}\left[\left(X_{l k}^{*}-X_{l k}\right)^{6}\right] \mathbb{E}\left[\left|X_{m k} X_{v k} \sum_{q: q \neq l} X_{q k}^{2}\right|^{3 / 2}\right] \\
& \leqslant \frac{C}{d^{3}} \mathbb{E}\left[X_{l k}^{6}\right]^{3 / 2} \sqrt{\mathbb{E}\left[\left(\sum_{q: q \neq l} X_{q k}^{2}\right)^{3}\right]} \leqslant \frac{C}{d^{3}} n^{3 / 2}
\end{aligned}
$$

assuming the existence of finite sixth moment. Hence we conclude

$$
\binom{n}{2}^{1 / 4} \sqrt{\mathbb{E}\left\|\sum_{k=1}^{d} \sum_{i=1}^{n} Y^{i k}\right\|_{\text {H.S. }}} \leqslant C n^{1 / 2}\left(d n^{3} \frac{n^{3 / 2}}{d^{3}}\right)^{1 / 3}=C \frac{n^{2}}{d^{2 / 3}}=C\left(\frac{n^{3}}{d}\right)^{2 / 3} .
$$

Therefore, the second term in (A.4) is bounded by $C\left(n^{3} / d\right)^{2 / 3}$ due to (A.5). Theorem A. 1 is proved by combining the above bounds.
